FLATNESS IS A CRITERION FOR SELECTION OF MAXIMIZING MEASURES

RENAUD LEPLAIDEUR

ABSTRACT. For a full shift with $Np+1$ symbols and for a non-positive potential, locally proportional to the distance to one of N disjoint full shifts with p symbols, we prove that the equilibrium state converges as the temperature goes to 0.

The main result is that the limit is a convex combination of the two ergodic measures with maximal entropy among maximizing measures and whose supports are the two shifts where the potential is the flattest.

In particular, this is a hint to solve the open problem of selection, and this indicates that flatness is probably a/the criterion for selection as it was conjectured by A.O. Lopes.

As a by product we get convergence of the eigenfunction at the log-scale to a unique calibrated subaction.

1. INTRODUCTION

1.1. Background. In this paper we deal with the problem of ergodic optimization and, more precisely with the study of ground states. Ergodic optimization is a relatively new branch of ergodic theory and is very active since the 2000's. For a given dynamical system (X, T) , the goal is to study existence and properties of the invariant probabilities which maximize a given potential $\phi : X \rightarrow \mathbb{R}$. We refer the reader to [15] for a survey about ergodic optimization.

Ground states are particular maximizing measures which can be reached by freezing the system as limit of equilibrium states. Namely, for $\beta > 0$, which in statistical mechanics represents the inverse of the temperature, we consider the/an equilibrium state associated to $\beta\phi$, that is a T -invariant probability whose free energy

$$h_\nu(T) + \beta \int \phi d\nu,$$

is maximal (where h_ν is the Kolmogorov entropy of the measure ν). Then, considering an equilibrium state μ_β , it is easy to check (see [12]) that any accumulation point for μ_β as β goes¹ to $+\infty$ is a maximizing measure for ϕ .

The first main question is to know if μ_β converges. It is known (see [8]) that for an uniformly hyperbolic dynamical systems, generically in the \mathcal{C}^0 -topology, ϕ has a unique maximizing measure. Therefore, convergence of μ_β obviously holds in that case.

¹ β is the inverse of the temperature, thus $\beta \rightarrow +\infty$ means $Temp \rightarrow 0$, which means we freeze the system.

Nevertheless, generic results do not concern all the possibilities, and it is very easy to build examples, which at least for the mathematical point of view are meaningful, and for which the set of ergodic maximizing measures is as wild as wanted.

For these situations, the question of convergence is of course fully relevant. Cases of convergence or non-convergence are known (see [9, 16, 11, 10]), but the general theory is far away of being solved. In particular, no criterion which guaranties convergence (except the uniqueness of the maximizing measure or the locally constant case) is known, say *e.g.* for the Lipschitz continuous case.

The second main question, and that is the one we want to focus on here, is the problem of the selection. Assuming that ϕ has several ergodic maximizing measures and that μ_β converges, what is the limit. In other words, is there a way to predict the limit from the potential, or equivalently, what makes the equilibrium state select one locus instead of another one ?

Inspired by a similar study for the Lagrangian Mechanics ([2]), it was conjectured by A.O. Lopes that flatness of the potential would be a criterion for selection and that the equilibrium state always selects the locus where the potential is the flattest. In [3] it is actually proved that the conjecture is not entirely correct. Authors consider in the full 3-shift a negative potential except on the two fixed points 0^∞ and 1^∞ , where it vanishes but is sharper in 1^∞ than in 0^∞ . Then, they prove that the equilibrium state actually converges, but not necessarily to the Dirac measure at 0^∞ .

The first part of the conjecture is however not (yet) invalidated and the question to know if flatness is a criterion for selection is still relevant.

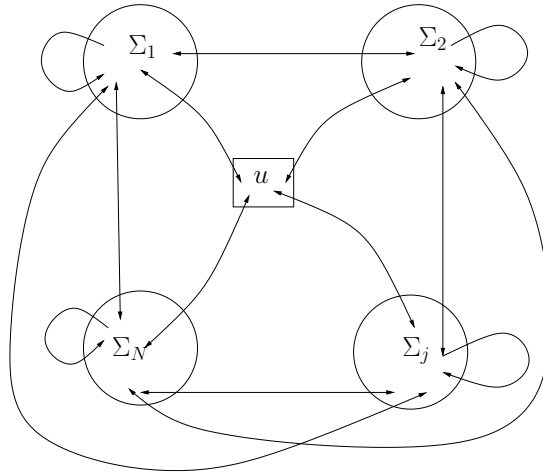


FIGURE 1. Our system

Here, we make a step in the direction of proving that flatness is indeed a criterion for selection. Precise statements are given in the next subsection. We consider in the full shift with $Np + 1$ symbols a potential, negative everywhere except on N Bernoulli subshifts² with p symbols. Figure 1 illustrates the dynamics.

²Note that these Bernoulli shifts are empty interior compact sets.

Then, flatness is ordered on these N Bernoulli subshifts : the potential is flatter on the first one than on the second one, then, it is flatter on the second one than on the third one, and then so on (see below for complete settings).

Any of these Bernoulli shifts has a unique measure of maximal entropy, and the set of ground states is contained in the convex hull of these N -measures. We show here that the equilibrium state converges and selects a convex combination of the two ergodic measures with supports in the two flattest Bernoulli subshifts.

We emphasize that this result is absolutely not in contradiction with [3]. Indeed, in [3] it is proved that the equilibrium state converges to a convex combination of the Dirac measures at 0^∞ and 1^∞ , which are obviously the two flattest loci !

1.2. Settings.

1.2.1. *The set Σ .* We consider the full-shift Σ with $Np + 1$ symbols, with N and p two positive integers. We also consider $Np + 1$ positive real numbers, $0 < \alpha_1 < \alpha_2 \leq \dots \leq \alpha_p$, $0 < \alpha_{p+1} < \alpha_{p+2} \leq \dots \leq \alpha_{2p}$, \dots , $0 < \alpha_{(N-1)p+1} < \alpha_{(N-1)p+2} \leq \dots \leq \alpha_{Np}$ and α . We assume

$$\alpha_1 < \alpha_{p+1} < \alpha_{2p+1} \leq \alpha_{(N-1)p+1}.$$

We set $\Sigma_1 := \{1, \dots, p\}^{\mathbb{N}}$, $\Sigma_2 := \{p + 1, \dots, 2p\}^{\mathbb{N}}$, \dots , $\Sigma_N := \{(N - 1)p + 1, \dots, Np\}^{\mathbb{N}}$.

For simplicity the last letter $Np + 1$ is denoted by u . The letter $(j - 1)p + i$ will be denoted by u_{ij} .

The set of letters defining Σ_j is $\mathcal{A}_j := \{u_{ij}, 1 \leq i \leq p\}$. Hence, $\Sigma_j = \mathcal{A}_j^{\mathbb{N}}$, and a word admissible for Σ_j is a word (finite or infinite) in letters u_{ij} . The length of a word is the number of digit (or letter) it contains. The length of the word w is denoted by $|w|$.

If $w = w_0 w_1 \dots w_n$ and $w' = w'_0, w'_1, \dots, w'_n$ are two finite words, we define the concatenated word $ww' = w_0 w_1 \dots w_n w'_0, w'_1, \dots, w'_n$. This is easily extended to the case $|w'| = +\infty$. If m is a finite-length admissible word for Σ_j , $[m*]$ denotes the set of points starting with the same $|m|$ letters than m and whose next letter is not in \mathcal{A}_j .

The distance in Σ is defined (as usually) by

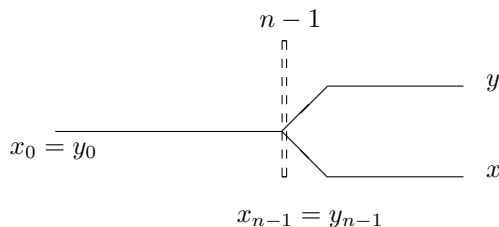


FIGURE 2. The sequence x and y coincide for digits 0 up to $n - 1$ and then split.

$$d(x, y) = \theta^{\min\{j, x_i \neq y_i\}},$$

where θ is a fixed real number in $(0, 1)$. This distance is sometimes graphically represented as in Figure 2.

We emphasize here, that contrarily to [3] we have not chosen $\theta = \frac{1}{2}$ in view to get the most general result as possible. Indeed, in [3] it was not clear if some results were independent or not of θ 's value. Moreover, this also means that we are considering all Hölder continuous functions, and not only the Lipschitz ones, because in Σ , a Hölder continuous function can be considered as a Lipschitz continuous, up to a change of θ 's value.

1.2.2. *The potential, the Transfer operator and the Gibbs measures.* The potential A is defined by

$$A(x) = \begin{cases} -\alpha_j d(x, \Sigma_i), & \text{if } x \in [u_{ij}] \\ A(x) = -\alpha, & \text{if } x \in [u]. \end{cases}$$

The potential is negative on Σ but on each Σ_j where it is constant to 0.

The transfer operator, also called the Ruelle-Perron-Frobenius operator, is defined by

$$\mathcal{L}_\beta(\varphi)(x) := \sum_{j=1}^k \sum_{i=1}^p e^{A(u_{ij}x)} \varphi(u_{ij}x) + e^{A(ux)} \varphi(ux).$$

It acts on continuous functions φ . We refer the reader to Bowen's book [7] for detailed theory of transfer operator, Gibbs measures and equilibrium states for Lipschitz potentials.

The eigenfunction is H_β and the eigenmeasure is ν_β . They satisfy:

$$\mathcal{L}_\beta(H_\beta) = e^{\mathcal{P}(\beta)} H_\beta, \quad \mathcal{L}_\beta^*(\nu_\beta) = e^{\mathcal{P}(\beta)} \nu_\beta.$$

The eigenmeasure and the eigenfunction are uniquely determined if we required the assumption that ν_β is a probability measure and $\int H_\beta d\nu_\beta = 1$.

The Gibbs state μ_β is defined by $d\mu_\beta := H_\beta d\nu_\beta$. The measure μ_β is also the equilibrium state for the potential $\beta.A$: it satisfies

$$\max_{\mu \text{ } \sigma\text{-inv}} \left\{ h_\mu(\sigma) + \beta \int A d\mu \right\} = h_{\mu_\beta}(\sigma) + \beta \int A d\mu_\beta$$

and this maximum is $\mathcal{P}(\beta)$ and is called the *pressure* of $\beta.A$. $e^{\mathcal{P}(\beta)}$ is also the spectral radius of \mathcal{L}_β . It is a single dominating eigenvalue.

1.3. **Results.** In each Σ_j we get a measure of maximal entropy $\mu_{top,j}$. As each Σ_j is a subshift of finite type, $\mu_{top,j}$ is again of the form

$$d\mu_{top,j} = H_{top,j} d\nu_{top,j},$$

where $H_{top,j}$ and $\nu_{top,j}$ are respectively the eigenfunction and the eigen-probability associated to the transfer operator in Σ_j for the potential constant to 0.

Note that, as β goes to $+\infty$, μ_β has only N possible ergodic accumulation points, which are the measures of maximal entropy in each Σ_j , $\mu_{top,j}$.

Our results are

Theorem 1 *The eigenmeasure ν_β converges to the eigenmeasure $\nu_{top,1}$ for the weak* topology as β goes to $+\infty$.*

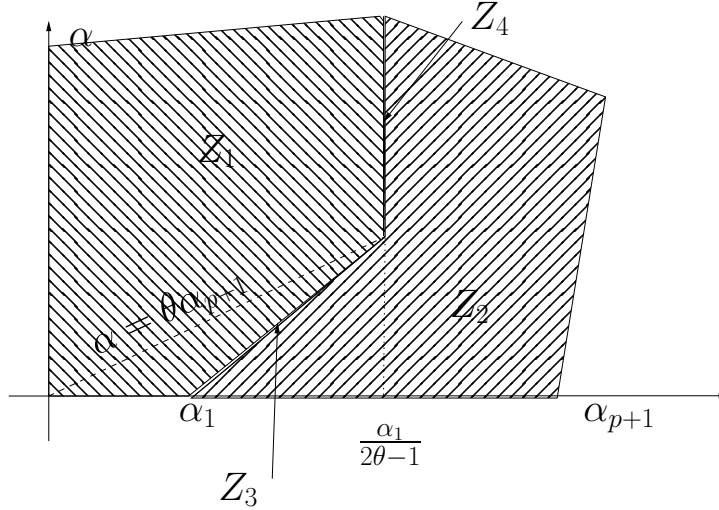


FIGURE 3. Ratio between $\mu_{top,1}$ and $\mu_{top,2}$

Theorem 2 *The Gibbs measure μ_β converges to a convex combination of $\mu_{top,1}$ and $\mu_{top,2}$ for the weak* topology as β goes to $+\infty$. This combination depends in which zone $Z_1 \cup Z_2 \cup Z_3 \cup Z_4$ (see Figure 3) the parameters are:*

- (1) *For parameters in Z_1 , μ_β converges to $\frac{1}{1+p^2}(\mu_{top,1} + p^2\mu_{top,2})$.*
- (2) *For parameters in Z_2 , μ_β converges to $\mu_{top,1}$.*
- (3) *For parameters in $Z_3 \cup Z_4$ μ_β converges to $\frac{1}{1+\rho_i^2}(\mu_{top,1} + \rho_i^2\mu_{top,2})$ for some $\rho_i > 0$ locally constant in $Z_3 \setminus Z_4$, $Z_4 \setminus Z_3$ and $Z_3 \cap Z_4$ (see Equalities (27) page 29, (29) page 30 and (30) page 30).*

Zone Z_3 corresponds to $0 < \alpha \leq \alpha_{p+1}\theta$ and $\alpha = \frac{\theta}{1-\theta} \frac{\alpha_{p+1}-\alpha_1}{2}$. Zone Z_4 corresponds to $\alpha_{p+1} = \frac{\alpha_1}{2\theta-1}$ and $\alpha \geq \alpha_{p+1}\theta$. We emphasize that Z_4 exists if and only if $\theta > \frac{1}{2}$.

As a by product of Theorem 1 and Theorem 2 we get the exact convergence for the eigenfunction to a unique subaction (see Section 2 for definition):

Corollary 3 *The calibrated subactions are all equal up to an additive constant. Moreover, the eigenfunction H_β converges at the log-scale to a single calibrated subaction :*

$$V := \lim_{\beta \rightarrow +\infty} \frac{1}{\beta} \log(H_\beta).$$

The question of convergence and uniqueness of a subaction seems to be important for the theory of ergodic optimization. It appeared very recently in [4]. We point out that

convergence of the eigenfunction to a subaction is related to the study of a Large Deviation Principle for the convergence of μ_β (see *e.g.* [5] and [17]). Nevertheless, in these two papers, Lopes *et al.* always assume the uniqueness of the maximizing measure, which yields the uniqueness of the calibrated subaction (up to a constant). Here we prove convergence to a unique subaction without the assumption of the uniqueness of the maximizing measure. It is thus allowed to hope that we could get a more direct proof of a Large Deviation Principle, without using the very indirect machinery of dual shift (see [5]).

1.4. Further improvements: discussion on hypothesis. The present work is part of a work in progress. The situation described here is far away from the most general case and our goal is to prove the next conjecture.

In [14], Garibaldi *et al.* introduce the set of non-wandering points with respect to a Hölder continuous potential A , $\Omega(A)$. This set contains the union of the supports of all optimizing measures (here we consider maximizing measures, there they consider minimizing measures).

The set $\Omega(A)$ is invariant and compact. Under the assumption that it can be decomposed in finitely many irreducible pieces, it is shown that calibrated subactions are constant on these irreducible pieces and their global value is given by these local values and the Peierls barrier (see Section 2 below).

We believe that, under the same hypothesis, it is possible to determine which irreducible component have measure at temperature zero:

Conjecture. *For $A : \Sigma \rightarrow \mathbb{R}$ Hölder continuous, if $\Omega(A)$ has finitely many irreducible components, $\Omega(A)_1 \dots \Omega(A)_N$, then, $\mu_\beta(\Omega(A)_i)$ goes to 0 if $\Omega(A)_i$ is not one of the two flattest loci for A .*

We emphasize that this conjecture does not mean that there is convergence “into” the components. It may be (as in [10]) that an irreducible component has several maximizing measures and that there is no selection between these measures.

This conjecture is for the moment far of being proved, in particular because several notions are not yet completely clear. In particular the notion of flatness has to be specified. Moreover, the components are not necessarily subshifts of finite type, which is an obstacle to study their (for instance) measures of maximal entropy.

The work presented here, is for a specific form of potential for which flatness is easily defined. The dynamics into the irreducible components and also the global dynamics are easy. We believe that the main issue here is to identify flatness as a criterion for selection.

The next step would be to release assumptions on the dynamics; in particular we would like that these components are not full shift and that the global dynamics is not a full shift. It is also highly probable that the conjecture should be adapted after we have solve this case. Distortion into the dynamics could perhaps favor other components.

The last step would be to get the result for general (or as general as possible) potential.

Nevertheless, and even if the present work is presented as a work in progress and an intermediate step before a more general statement, we want to moderate the specificity of the potential we consider here. For a uniformly hyperbolic system (X, T) and for any Hölder function ϕ , there exists two Hölder continuous ψ_1 and ψ_2 such that $\phi = \psi_1 + m(\phi) + \psi_2 \circ T - \psi_2$, where $m(\phi) = \max \left\{ \int \phi d\mu \right\}$ and ψ_1 is non-negative and vanishes only on the Aubry set. This means that, up to consider a cohomologous function, the assumption on the sign of A is free. Now, if we would consider a very regular potential (say at least \mathcal{C}^1) on a geometrical dynamical systems, the fact that ψ_1 vanishes on the Aubry set means that close to that Aubry set, $\psi_1(x)$ is proportional to the distance between x and the Aubry set (with coefficient related to the derivative of ψ_1). Consequently, the potential A we consider here is a kind of discrete version for the symbolic case of a \mathcal{C}^1 potential on a Manifold.

1.5. Plan of the paper and acknowledgment. In Section 2 we prove that the pressure behaves like $\log p + g(\beta)e^{-\gamma\beta}$ for some specific γ and some sub-exponential function g . The real number γ is obtained as an eigenvalue for the Max-Plus algebra (see Proposition 5).

In Section 3, we define and study an auxiliary function F ; This function gives the asymptotic both for the eigenmeasure and for the Gibbs measure.

In Section 4 we prove Theorem 1 and in Section 5 we prove Theorem 2. As a by-product we give an asymptotic for the function $g(\beta)$ (in the Pressure).

In the last section, Section 6 we prove Corollary 3.

2. PEIERLS BARRIER AND AN EXPRESSION FOR THE PRESSURE

The main goal of this section is Proposition 5 where we prove that $\mathcal{P}(\beta)$ converges exponentially fast to $\log p$. The exponential speed is obtained as an eigenvalue for a matrix in Max-Plus algebra.

2.1. The eigenfunction and the Peierls barrier.

Lemma 1. *The eigenfunction H_β is constant on the cylinder $[u]$. It is also constant on cylinders of the form $[m*]$, where m is an admissible word for some Σ_j . Furthermore, if m' is another admissible word for the same Σ_j with the same length than m , then H_β coincide on both cylinders $[m*]$ and $[m'*]$.*

Proof. The eigenfunction H_β is defined by

$$H_\beta := \lim_{n \rightarrow \infty} \frac{1}{n} \sum_{k=0}^{n-1} e^{-k\mathcal{P}(\beta)} \mathcal{L}_\beta(\mathbf{1}).$$

For x and x' in $[m*] \cup [m'*$], if wx is a preimage for x then wx' is a preimage for x' and $A(wx) = A(wx')$.

The same argument works on $[u]$. □

This Lemma allows us to set

$$(1) \quad \tau_j := \sum_{l \neq j} \sum_i e^{-\alpha(l-1)p+i\theta\beta} H_\beta(u_{il}*) + e^{-\alpha} H_\beta(u).$$

Thus, for x in $\sqcup_i [u_{ij}]$ we get

$$e^{\mathcal{P}(\beta)} H_\beta(x) = \sum_{i=1}^p e^{\beta A(u_{ij}x)} H_\beta(u_{ij}x) + \tau_j.$$

Lemma 2. *The function H_β is constant on each Σ_j : for any x in Σ_j , $H_\beta(x) = \frac{\tau_j}{e^{\mathcal{P}(\beta)} - p}$.*

Proof. The function H_β is continuous on the compact Σ_j . It thus attains its minimum and its maximum. Let \underline{x}_j and \bar{x}_j be two points in Σ_j where H_β is respectively minimal and maximal.

The transfer operator yields:

$$e^{\mathcal{P}(\beta)} H_\beta(\underline{x}_j) = \left(\sum_{i=1}^p H_\beta(u_{ij}\underline{x}_j) \right) + \tau_j.$$

By definition, for each i , $H_\beta(u_{ij}\underline{x}_j) \geq H_\beta(\underline{x}_j)$. This yields

$$(2) \quad (e^{\mathcal{P}(\beta)} - p) H_\beta(\underline{x}_j) \geq \tau_j.$$

Similarly we will get $\tau_j \geq (e^{\mathcal{P}(\beta)} - p) H_\beta(\bar{x}_j)$. As the potential is Lipschitz continuous, the pressure function $\mathcal{P}(\beta)$ is analytic and decreasing (A is non-positive). Then $\mathcal{P}(\beta) > \log p$. This shows $H_\beta(\underline{x}_j) = H_\beta(\bar{x}_j)$.

Let x be any point in Σ_j . Equality $\mathcal{L}_\beta(H_\beta) = e^{\mathcal{P}(\beta)} H_\beta$ yields

$$e^{\mathcal{P}(\beta)} H_\beta(x) = \sum_{i \in \mathcal{A}_j} e^{\beta \cdot A(ix)} H_\beta(ix) + \tau_j.$$

For $i \in \mathcal{A}_j$, $A(ix) = 0$, and as H_β is constant on Σ_j we get

$$(e^{\mathcal{P}(\beta)} - p) H_\beta(x) = \tau_j.$$

□

The family of functions $\{\frac{1}{\beta} \log H_\beta\}_{\beta \in \mathbb{R}^+}$ is uniformly bounded and equi-continuous; any accumulation point V for $\frac{1}{\beta} \log H_\beta$ as β goes to $+\infty$ (and for the C^0 -norm) is a *calibrated subaction*, see [12].

In the following, we consider a calibrated subaction V obtained as an accumulation point for $\frac{1}{\beta} \log H_\beta$. Note that the convergence is uniform (on Σ) along the chosen subsequence for β . For simplicity we shall however write $V = \lim_{\beta \rightarrow +\infty} \frac{1}{\beta} \log H_\beta$.

A direct consequence of Lemma 2 is that the subaction V is constant on each Σ_j . Actually, it is proved in [13] that this holds for the more general case and, moreover, that any calibrated subaction satisfies

$$(3) \quad V(x) = \max_j \{V(x_j) + h(x_j, x)\},$$

where $h(\cdot, \cdot)$ is the *Peierls barrier* and x_j is any point in Σ_j . It is thus important to compute what is the Peierls barrier here.

Lemma 3. *Let x_j be any point in Σ_j . The Peierls barrier satisfies $h(x_j, x) = -\alpha_{(j-1)p+1} \frac{\theta}{1-\theta} d(x, \Sigma_j)$.*

For simplicity we shall set $h_j(x)$ for $h(x_j, x)$.

Proof. Let x be in Σ . Recall that $h_j(x)$ is defined by

$$\limsup_{\varepsilon \rightarrow 0} \sup_n \left\{ \sum_{l=0}^{n-1} A(\sigma^l(z)) : \sigma^n(z) = x, d(x_j, z) < \varepsilon \right\}.$$

As we consider the limit as ε goes to 0, we can assume that $\varepsilon < \theta$. Now, to compute $h_j(x)$, we are looking for a preimage of x , which starts by some letter admissible for Σ_j (because $\varepsilon < \theta$) and which maximizes the Birkhoff sum of the potential “until x ”. As the potential is negative, this can be done if and only if one takes a preimage of x of the form mx , with m a Σ_j admissible word. Moreover, we always have to chose the letter u_{1j} to get the maximal $-\alpha_{(j-1)p+i}$ possible.

In other word we claim that for every $n \geq 1$ for every $l \geq 0$ and for every word m of length $n+l$,

$$S_n(A) \underbrace{(u_{1j} \dots u_{1j} x)}_{n \text{ times}} \geq S_{n+l}(A)(mx).$$

Let assume $d(x, \Sigma_j) = \theta^a$, *i.e.*, the maximal admissible word for Σ_j of the form $x_0 x_1 x_2 \dots$ has length a . This yields

$$h_j(x) = \lim_{n \rightarrow \infty} S_n(A) \underbrace{(u_{1j} \dots u_{1j} x)}_{n \text{ times}} = -\alpha_{(j-1)p+1} \sum_{n=1}^{+\infty} \theta^{n+a} = -\alpha_{(j-1)p+1} \frac{\theta}{1-\theta} \theta^a = -\alpha_{(j-1)p+1} \frac{\theta}{1-\theta} d(x, \Sigma_j).$$

□

Then, Lemma 3 and Equality (3) yield

$$(4) \quad V(x) = \max_j \left(V(\bar{x}_j) - \alpha_{(j-1)p+1} \frac{\theta}{1-\theta} d(x, \Sigma_j) \right).$$

Lemma 4. *For every j ,*

$$\lim_{\beta \rightarrow +\infty} \frac{1}{\beta} \log \left(e^{-\alpha_{(j-1)p+1}\theta\beta} H_\beta(u_{1j}^*) + \dots + e^{-\alpha_{jp}\theta\beta} H_\beta(u_{pj}^*) \right) = V(u_{1j}^*) - \alpha_{(j-1)p+1}\theta.$$

Proof. By Lemma 1, the eigenfunction H_β is constant on rings $[m*]$ with $m \in \mathcal{A}_j^{|m|}$, hence $V(u_{1j*}) = \dots = V(u_{pj*})$. Now, inequalities $\alpha_{(j-1)p+1} < \alpha_{(j-1)p+2} \leq \alpha_{(j-1)p+i}$ show that $e^{-\alpha_{(j-1)p+1}\theta\beta} H_\beta(u_{1j*})$ is exponentially bigger than all the other terms as β goes to $+\infty$. \square

2.2. Exponential speed of convergence of the pressure : Max-Plus formalism.

Here we use the Max-Plus formalism. We refer the reader to [6] (in particular chapter 3) for basic notions on this theory. Some of the results we shall use here are not direct consequence of [6] (even if the proofs can easily be adapted) but can be found in [1].

Proposition 5. *Let*

$$\gamma = \min \left\{ \min(\alpha_{p+1}\theta, \alpha) + \alpha_1 \frac{\theta}{1-\theta}, \frac{(\alpha_1 + \alpha_{p+1})}{2} \frac{\theta}{1-\theta} \right\}.$$

Then, there exists a positive sub-exponential function g such that $\mathcal{P}(\beta) := \log p + g(\beta)e^{-\gamma\beta}$.

Proof. We have seen (Lemma 2) that H_β is constant on the sets Σ_j . This shows that $V := \lim_{\beta \rightarrow +\infty} \frac{1}{\beta} \log H_\beta$ is also constant of the Σ_j . For simplicity we set $u_{ij}^\infty := u_{ij}u_{ij}u_{ij} \dots$. This is a point in Σ_j . Now we have

$$(5) \quad (e^{\mathcal{P}(\beta)} - p)H_\beta(u_{ij}^\infty) = \sum_{l \neq j} \sum_i e^{-\alpha_{(l-1)p+i}\theta\beta} H_\beta(u_{1l*}) + e^{-\alpha} H_\beta(u).$$

Note that the results we get concerning the subaction V are actually true for any calibrated subaction. We point out that we can first chose some subsequence of β such that $\frac{1}{\beta} \log(\mathcal{P}(\beta) - \log p)$ converges, and then take a new subsequence from the previous one to ensure that $\frac{1}{\beta} \log(H_\beta)$ also converges.

We thus consider $V := \lim_{\beta \rightarrow +\infty} \frac{1}{\beta} \log H_\beta$ and $-\gamma := \lim_{\beta \rightarrow +\infty} \frac{1}{\beta} \log(\mathcal{P}(\beta) - \log p)$. At that moment we do not claim that γ has the exact value set in the Proposition. It is only an accumulation point for $\frac{1}{\beta} \log(\mathcal{P}(\beta) - \log p)$. The convergence of $\frac{1}{\beta} \log(\mathcal{P}(\beta) - \log p)$ will follow from the uniqueness of the value for γ .

Then (5) and Lemma 4 yield for every j ,

$$(6) \quad -\gamma - V(u_{ij}^\infty) = \max \left(\max_{l \neq j} (V(u_{1l}) - \alpha_{(l-1)p+1}\theta), V(u) - \alpha \right).$$

Consider the k rows and $k+1$ columns matrix

$$M_1 := \begin{pmatrix} -\infty & -\alpha_{p+1}\theta & -\alpha_{2p+1}\theta & \dots & -\alpha_{(N-1)p+1}\theta & -\alpha \\ -\alpha_1\theta & -\infty & -\alpha_{2p+1}\theta & & & -\alpha \\ \vdots & & & & & \vdots \\ -\alpha_1\theta & \dots & & & -\infty & -\alpha \end{pmatrix}.$$

Then, using the Max-Plus formalism we get

$$(7) \quad \begin{pmatrix} V(u_{11}^\infty) - \gamma \\ V(u_{12}^\infty) - \gamma \\ \vdots \\ V(u_{1N}^\infty) - \gamma \end{pmatrix} = M_1 \begin{pmatrix} V(u_{11}^*) \\ V(u_{12}^*) \\ \vdots \\ V(u_{1N}^*) \\ V(u) \end{pmatrix}.$$

Now, consider the $k + 1$ rows and k columns matrix

$$M_2 := \begin{pmatrix} -\alpha_1 \frac{\theta^2}{1-\theta} & -\alpha_{p+1} \frac{\theta}{1-\theta} & & -\alpha_{(N-1)p+1} \frac{\theta}{1-\theta} \\ -\alpha_1 \frac{\theta}{1-\theta} & -\alpha_{p+1} \frac{\theta^2}{1-\theta} & & \\ \vdots & & \ddots & \vdots \\ -\alpha_1 \frac{\theta}{1-\theta} & -\alpha_{p+1} \frac{\theta}{1-\theta} & \dots & -\alpha_{(N-1)p+1} \frac{\theta}{1-\theta} \end{pmatrix}.$$

Then (4) can be written as

$$(8) \quad \begin{pmatrix} V(u_{11}^*) \\ V(u_{12}^*) \\ \vdots \\ V(u_{1N}^*) \\ V(u) \end{pmatrix} = M_2 \begin{pmatrix} V(u_{11}^\infty) \\ V(u_{12}^\infty) \\ \vdots \\ V(u_{1N}^\infty) \end{pmatrix}.$$

□

Combining (7) and (8), we get that $-\gamma$ is an eigenvalue for the matrix $M_1 M_2$ (for the

Max-Plus algebra) and $\begin{pmatrix} V(u_{11}^\infty) \\ V(u_{12}^\infty) \\ \vdots \\ V(u_{1N}^\infty) \end{pmatrix}$ is an eigenvector.

Let us compute the matrix $M = M_1 M_2$. Let us consider the row l for M_1 and the column j for M_2 . Assume $j \neq l$.

We have to compute the maximum between the sum of the n^{th} term of the row and the n^{th} term of the column. All the terms in the column are equal to $-\alpha_{(j-1)p+1} \frac{\theta}{1-\theta}$ except the j^{th} which is $-\alpha_{(j-1)p+1} \frac{\theta}{1-\theta} \cdot \theta$. This term is added to $-\alpha_{(j-1)p+1} \theta$ (the j^{th} term of the column), and this addition gives $-\alpha_{(j-1)p+1} \frac{\theta}{1-\theta}$. Therefore, this term is the maximum (any other term is that one plus something negative).

Assume now that $j = l$. Then, the j^{th} term of the column is added to $-\infty$, hence disappears. Now, we just have to compute the maximum of all the terms respectively equal to a negative term minus $\alpha_{(j-1)p+1} \frac{\theta}{1-\theta}$. This means that we just have to take the maximal term in the row and to subtract $\alpha_{(j-1)p+1} \frac{\theta}{1-\theta}$.

Finally, the coefficient m_{ij} of M is

$$m_{ij} = \begin{cases} \max(-\alpha_{p+1}\theta, -\alpha) - \alpha_1 \frac{\theta}{1-\theta} & \text{if } i = 1 = j, \\ \max(-\alpha_1\theta, -\alpha) - \alpha_{(j-1)p+1} \frac{\theta}{1-\theta} & \text{if } i = j \neq 1, \\ -\alpha_{(j-1)p+1} \frac{\theta}{1-\theta} & \text{if } i \neq j. \end{cases}$$

To compute the eigenvalue for this matrix, we have to find the “basic loop” with biggest mean value.

A basic loop is a word in $1, \dots, k$ where no letter appear several times. Then we compute the mean value of the costs of the transition $i \rightarrow j$ given by the coefficient m_{ij} of the matrix for the letters of the basic loop.

• Inequalities $\alpha_1 < \alpha_{p+1} < \alpha_{jp+1}$ yields that any basic loop of length greater than 2 gives a lower contribution than the length 2-loop $1 \rightarrow 2 \rightarrow 1$. This contribution is

$$-\frac{\alpha_1 + \alpha_{p+1}}{2} \frac{\theta}{1-\theta}.$$

• We claim that every basic loop of length 1 gives a smaller contribution than the first one. The claim is easy if $\alpha < \alpha_1\theta$. In that case we have

$$\max(-\alpha_{p+1}\theta, -\alpha) - \alpha_1 \frac{\theta}{1-\theta} \geq -\alpha - \alpha_1 \frac{\theta}{1-\theta} > -\alpha - \alpha_{jp+1} \frac{\theta}{1-\theta} = \max(-\alpha_1\theta, -\alpha) - \alpha_{jp+1} \frac{\theta}{1-\theta}.$$

If $\alpha_{p+1}\theta \leq \alpha$ the claim is also true:

$$\begin{aligned} -\alpha_{p+1}\theta - \alpha_1 \frac{\theta}{1-\theta} &> -\alpha_1\theta - \alpha_{jp+1} \frac{\theta}{1-\theta} \\ \Updownarrow \theta\alpha_1 &< \alpha_{jp+1} + (\theta - 1)\alpha_{p+1}, \end{aligned}$$

and this last inequality holds because

$$\alpha_{jp+1} + (\theta - 1)\alpha_{p+1} = \theta\alpha_{p+1} + (\alpha_{jp+1} - \alpha_{p+1}) \geq \theta\alpha_{p+1} > \theta\alpha_1.$$

And finally, if $\alpha_1\theta \leq \alpha \leq \alpha_{p+1}\theta$, $\theta\alpha_1 - \alpha$ is non-positive and $\theta\alpha_{jp} - \alpha$ is non-negative, and we let the reader check that this yields

$$-\alpha - \alpha_1 \frac{\theta}{1-\theta} \geq -\alpha_1\theta - \alpha_{jp} \frac{\theta}{1-\theta}.$$

This shows

$$-\gamma = \max(\max(-\alpha_{p+1}\theta, -\alpha) - \alpha_1 \frac{\theta}{1-\theta}, -\frac{\alpha_1 + \alpha_{p+1}}{2} \frac{\theta}{1-\theta}).$$

In particular, $\frac{1}{\beta} \log(\mathcal{P}(\beta) - \log p)$ has a unique accumulation point, hence converges. Then, there exists a sub-exponential function $g(\beta)$ such that

$$(9) \quad \mathcal{P}(\beta) = \log p + g(\beta)e^{-\gamma \cdot \beta}.$$

The pressure is convex and analytic (the potential is Lipschitz continuous) and always bigger than $\log p$. It is decreasing because its derivative is $\int A d\mu_\beta$ and μ_β gives positive weight to any open set and A is negative except on the empty interior sets Σ_j . This proves that $g(\beta)$ is positive.

Remark 1. We emphasize $\gamma > \alpha_1 \frac{\theta}{1-\theta}$.

2.3. Value for γ in function of the parameters. In this subsection we want to state an exact expression for γ depending on the values for the parameters. We have seen

$$\gamma = \min\left(\frac{\alpha_1 + \alpha_{p+1}}{2} \frac{\theta}{1 - \theta}, \alpha_1 \frac{\theta}{1 - \theta} + \alpha, \alpha_1 \frac{\theta}{1 - \theta} + \alpha_{p+1}\theta\right).$$

Now, $\alpha_1 \frac{\theta}{1 - \theta} + \alpha_{p+1}\theta < \frac{\alpha_1 + \alpha_{p+1}}{2} \frac{\theta}{1 - \theta}$ if and only if $\alpha_{p+1} > \frac{\alpha_1}{2\theta - 1}$ (which is possible only for $\theta > \frac{1}{2}$). Obviously, $\alpha_1 \frac{\theta}{1 - \theta} + \alpha < \alpha_1 \frac{\theta}{1 - \theta} + \alpha_{p+1}\theta$ means $\alpha < \alpha_{p+1}\theta$.

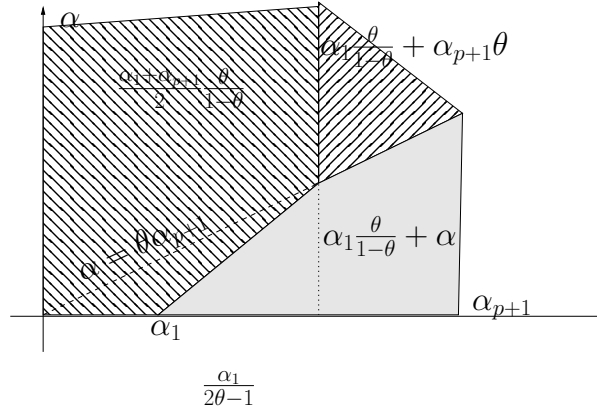


FIGURE 4. Values for γ

Finally, $\alpha_1 \frac{\theta}{1-\theta} + \alpha < \frac{\alpha_1 + \alpha_{p+1}}{2} \frac{\theta}{1-\theta}$ means $\alpha < \frac{\alpha_{p+1} - \alpha_1}{2} \frac{\theta}{1-\theta}$. Note that for $\alpha_{p+1} = \frac{\alpha_1}{2\theta - 1}$,

$$\frac{\alpha_{p+1} - \alpha_1}{2} \frac{\theta}{1-\theta} = \alpha_1 \frac{\theta}{2\theta - 1} = \theta \alpha_{p+1}.$$

3. AUXILIARY FUNCTION F

Lemma 6. *Let $0 < \xi_1 < \xi_2 \leq \dots \leq \xi_p$ be p positive real numbers ($p \geq 2$). Let us set*

- $\eta_i := \xi_i - \xi_1$, for $i \geq 2$,
- $r := \frac{-\log p}{\log \theta} (> 0)$,
- $I(\eta_2, \eta_3, \dots, \eta_p) := \int_0^1 \log \left(1 + \frac{\sum_{i=2}^p e^{-\eta_i x} - 1}{p} \right) \frac{dx}{x} + \int_1^{+\infty} \frac{\sum_{i=2}^p \eta_i e^{-\eta_i x}}{1 + \sum_{i=2}^p e^{-\eta_i x}} \log x \, dx$.

Then, if n goes first to $+\infty$ and then β goes to $+\infty$,

$$\prod_{j=1}^n \left(e^{-\xi_1 \theta^j \beta} + e^{-\xi_2 \theta^j \beta} + \dots + e^{-\xi_p \theta^j \beta} \right) = \frac{p^n}{\beta^r} e^{-\xi_1 \frac{\theta}{1-\theta} \beta (1-\theta^n) - \frac{I(\eta_2, \dots, \eta_p)}{\log \theta} + O(\beta \theta^n) + o_\infty(\beta)},$$

where $O(\beta \theta^n)$ is bounded in absolute value by a term of the form $C \sum_{i=2}^p \eta_i \beta \theta^n$ for some universal constant C and $o_\infty(\beta)$ is bounded in absolute value by a term of the form $C' \sum_i \eta_i e^{-\frac{\eta_2 \beta \theta}{2}}$ for some universal constant C' .

Proof. First we write

$$(10) \quad \prod_{j=1}^n \left(e^{-\xi_1 \theta^j \beta} + e^{-\xi_2 \theta^j \beta} + \dots + e^{-\xi_p \theta^j \beta} \right) = e^{-\xi_1 \beta \theta \frac{1-\theta^n}{1-\theta}} \prod_{j=1}^n \left(1 + e^{-\eta_2 \theta^j \beta} + \dots + e^{-\eta_p \theta^j \beta} \right),$$

and

$$\begin{aligned} \log \prod_{j=1}^n \left(1 + e^{-\eta_2 \theta^j \beta} + \dots + e^{-\eta_p \theta^j \beta} \right) &= \sum_{j=1}^n \log \left(1 + e^{-\eta_2 \theta^j \beta} + \dots + e^{-\eta_p \theta^j \beta} \right) \\ &= n \log p + \sum_{j=1}^n \log \left(1 + \frac{\sum_{i=2}^p e^{-\eta_i \theta^j \beta} - 1}{p} \right). \end{aligned}$$

Note that $\eta_i \theta^j$ decreases in j . Thus we can compare this later sum with an integral

$$\begin{aligned} \int_0^n \log \left(1 + \frac{\sum_{i=2}^p e^{-\eta_i \theta^x \beta} - 1}{p} \right) dx &\leq \sum_{j=1}^n \log \left(1 + \frac{\sum_{i=2}^p e^{-\eta_i \theta^j \beta} - 1}{p} \right) \\ &\leq \int_1^{n+1} \log \left(1 + \frac{\sum_{i=2}^p e^{-\eta_i \theta^x \beta} - 1}{p} \right) dx. \end{aligned}$$

Let I_n and J_n respectively denote the integral from left hand side and the right hand side. First, we focus the study on I_n .

In order to study I_n , let us set $u = \beta\theta^x$. Then we have

$$I_n = \frac{1}{\log \theta} \int_{\beta}^{\beta\theta^n} \log \left(1 + \frac{\sum_{i=2}^p e^{-\eta_i u} - 1}{p} \right) \frac{du}{u},$$

and we split this last integral in two pieces $\int_1^{\beta\theta^n}$ and \int_{β}^1 .

We remind that n is supposed to go first to $+\infty$ and then β goes to $+\infty$. Hence, $\beta\theta^n$ is close to 0. For u close to 0, $\log \left(1 + \frac{\sum_{i=2}^p e^{-\eta_i u} - 1}{p} \right)$ is non-positive and bigger than a term of the form $-C \sum_{i=2}^p \eta_i u$ for some universal constant C . This shows that the integral

$$\int_1^0 \log \left(1 + \frac{\sum_{i=2}^p e^{-\eta_i u} - 1}{p} \right) \frac{du}{u},$$

converges (the function has a limit as u goes to 0) and

$$(11) \quad \int_1^{\beta\theta^n} \log \left(1 + \frac{\sum_{i=2}^p e^{-\eta_i u} - 1}{p} \right) \frac{du}{u} = \int_1^0 \log \left(1 + \frac{\sum_{i=2}^p e^{-\eta_i u} - 1}{p} \right) \frac{du}{u} + O(\beta\theta^n),$$

where $|O(\beta\theta^n)| \leq C \sum_{i=2}^p \beta\theta^n$.

For the other part we get:

$$\begin{aligned} \int_{\beta}^1 \log \left(1 + \frac{\sum_{i=2}^p e^{-\eta_i u} - 1}{p} \right) \frac{du}{u} &= \left[\log \left(1 + \frac{\sum_{i=2}^p \eta_i e^{-\eta_i u} - 1}{p} \right) \log u \right]_{\beta}^1 + \int_{\beta}^1 \frac{\sum_{i=2}^p e^{-\eta_i u}}{1 + \sum_{i=2}^p e^{-\eta_i u}} \log u \, du \\ &= -\log \left(1 + \frac{\sum_{i=2}^p \eta_i e^{-\eta_i \beta} - 1}{p} \right) \log \beta + \int_{\beta}^1 \frac{\sum_{i=2}^p e^{-\eta_i u}}{1 + \sum_{i=2}^p e^{-\eta_i u}} \log u \, du \\ &= \log p \log \beta - \log \left(1 + \sum_{i=2}^p \eta_i e^{-\eta_i \beta} \right) \log \beta + \\ &\quad \int_{+\infty}^1 \frac{\sum_{i=2}^p e^{-\eta_i u}}{1 + \sum_{i=2}^p e^{-\eta_i u}} \log u \, du + \int_{\beta}^{+\infty} \frac{\sum_{i=2}^p e^{-\eta_i u}}{1 + \sum_{i=2}^p e^{-\eta_i u}} \log u \, du. \end{aligned}$$

Now, both terms $\left| \log \left(1 + \sum_{i=2}^p \eta_i e^{-\eta_i \beta} \right) \log \beta \right|$ and $\left| \int_{\beta}^{+\infty} \frac{\sum_{i=2}^p e^{-\eta_i u}}{1 + \sum_{i=2}^p e^{-\eta_i u}} \log u \, du \right|$ are bounded from above by some $C' \sum_i \eta_i e^{-\frac{\eta_2}{2} \beta}$.

The computation for J_n is similar except that borders have to be exchanged. Namely $\beta\theta^n$ in $\int_1^{\beta\theta^n}$ has to be replaced by $\beta\theta^{n+1}$ which improves the estimate, and β in \int_{β}^1 has to be replaced by $\int_{\beta\theta}^1$. This produce an upper bound of the form $O(e^{-\frac{\eta_2}{2} \theta \beta})$ instead of $O(e^{-\frac{\eta_2}{2} \beta})$.

This concludes the proof of the lemma. \square

Definition 1. We define the auxiliary function $F(Z, z_1, \dots, z_p)$ by

$$F(Z, z_1, \dots, z_p) := \sum_{n=1}^{+\infty} \left(e^{-nZ} \prod_{j=1}^n (e^{-z_1 \theta^j} + \dots + e^{-z_p \theta^j}) \right).$$

For an integer K , $F_K()$ denotes the truncated sum to K :

$$F_K(Z, z_1, \dots, z_p) := \sum_{n=1}^K \left(e^{-nZ} \prod_{j=1}^n (e^{-z_1 \theta^j} + \dots + e^{-z_p \theta^j}) \right).$$

Proposition 7. Let $0 < \xi_1 < \xi_2 \leq \dots \leq \xi_p$ be p positive real numbers ($p \geq 2$). We re-employ notations from Lemma 6.

Then, as β goes to $+\infty$

$$\text{if } \gamma > \xi_1 \frac{\theta}{1-\theta}, \text{ then } F(\mathcal{P}(\beta), \xi_1 \beta, \dots, \xi_p \beta) = \frac{1}{\beta^r g(\beta)} e^{(\gamma - \xi_1 \frac{\theta}{1-\theta})\beta - \frac{I(\eta_2, \dots, \eta_p)}{\log \theta} + o_\infty(\beta)},$$

$$\text{if } \gamma < \xi_1 \frac{\theta}{1-\theta}, \text{ then } F(\mathcal{P}(\beta), \xi_1 \beta, \dots, \xi_p \beta) = O(e^{-\xi_1 \theta \beta} \vee \frac{1}{\beta^r g(\beta)} e^{(\gamma - \xi_1 \frac{\theta}{1-\theta})\beta}),$$

where $o_\infty(\beta)$ goes to 0 as β goes to $+\infty$.

Proof. Let ε_0 be a positive real number such that $\log \varepsilon_0 < -2$. We set

$$(12) \quad n(\beta) := \frac{\log \varepsilon_0}{\log \theta} \log \beta.$$

Note that $n(\beta)$ goes to $+\infty$ as β goes to $+\infty$. Furthermore, $\theta^{n(\beta)} < \frac{1}{\beta^2}$ and $n\beta\theta^n$ goes to 0 if $n \geq n(\beta)$ and β goes to $+\infty$.

The proof has three steps. The function F is defined as a sum over n , for $n \geq 1$. In the first part, we give bounds for a fixed β , and for the sum for $n \geq n(\beta)$. This quantity is a trivial bound from below for the global sum.

In the second step we prove that the sum for $n \leq n(\beta) - 1$ goes to 0 as β goes to $+\infty$. This allows to conclude the proof for the case $\gamma > \xi_1 \frac{\theta}{1-\theta}$.

In the last step, we use the computations of the second step to conclude the proof for the case $\gamma < \xi_1 \frac{\theta}{1-\theta}$.

First step. Remember that $\mathcal{P}(\beta) = \log p + g(\beta)e^{-\gamma \cdot \beta}$, where $g(\beta)$ is a positive and sub-exponential function in β . Then Lemma 6 yields for $n \geq n(\beta)$,

$$\begin{aligned} & \frac{1}{\beta^r} \exp \left(-ng(\beta)e^{-\gamma \cdot \beta} - \xi_1 \frac{\theta}{1-\theta} \beta(1-\theta^n) - \frac{I(\eta_2, \dots, \eta_p)}{\log \theta} + O(\beta\theta^n) + o_\infty(\beta) \right) \\ &= e^{-n\mathcal{P}(\beta)} \prod_{j=1}^n \left(e^{-\xi_1 \theta^j \beta} + e^{-\xi_2 \theta^j \beta} + \dots + e^{-\xi_p \theta^j \beta} \right). \end{aligned}$$

As we only consider $n \geq n(\beta)$ and β goes to $+\infty$, we can replace $O(\beta\theta^n)$ and θ^n by $o_\infty(\beta)$. Doing the sum over n , only the terms $e^{-ng(\beta)e^{-\gamma\cdot\beta}}$ have to be summed. We thus get

$$(13) \quad \begin{aligned} & \frac{1}{\beta^r} \exp\left(-\xi_1 \frac{\theta}{1-\theta} \beta - \frac{I(\eta_2, \dots, \eta_p)}{\log \theta} + o_\infty(\beta)\right) \sum_{n \geq n(\beta)} e^{-ng(\beta)e^{-\gamma\cdot\beta}} \\ &= \sum_{n \geq n(\beta)} e^{-n\mathcal{P}(\beta)} \prod_{j=1}^n \left(e^{-\xi_1 \theta^j \beta} + e^{-\xi_2 \theta^j \beta} + \dots + e^{-\xi_p \theta^j \beta}\right). \end{aligned}$$

Now, $\sum_{n \geq n(\beta)} e^{-n(\beta)g(\beta)e^{-\gamma\cdot\beta}} = \frac{e^{-n(\beta)g(\beta)e^{-\gamma\cdot\beta}}}{1 - e^{-g(\beta)e^{-\gamma\cdot\beta}}}$. Both $g(\beta)$ and $n(\beta)$ are sub-exponential in β , hence the numerator goes to 1 as β goes to $+\infty$. The denominator behaves like $g(\beta)e^{-\gamma\cdot\beta}$. Then, (13) yields

$$(14) \quad \frac{1}{\beta^r g(\beta)} e^{(\gamma - \xi_1 \frac{\theta}{1-\theta})\beta - \frac{I(\eta_2, \dots, \eta_p)}{\log \theta} + o_\infty(\beta)} = \sum_{n \geq n(\beta)} e^{-n\mathcal{P}(\beta)} \prod_{j=1}^n \left(e^{-\xi_1 \theta^j \beta} + e^{-\xi_2 \theta^j \beta} + \dots + e^{-\xi_p \theta^j \beta}\right).$$

Second step. All the ξ_j are bigger than ξ_1 . We thus trivially get

$$e^{-n\mathcal{P}(\beta)} \prod_{j=1}^n \left(e^{-\xi_1 \theta^j \beta} + \dots + e^{-\xi_p \theta^j \beta}\right) \leq e^{-\xi_1 \frac{\theta}{1-\theta} \beta} e^{-ng(\beta)e^{-\gamma\cdot\beta} + \xi_1 \frac{\theta}{1-\theta} \beta \theta^n}.$$

For the rest of the proof, we set $D := g(\beta)e^{-\gamma\cdot\beta}$ and $E := \xi_1 \frac{\theta}{1-\theta} \beta$. The sequence $-nD + E\theta^n$ decreases in n , and we can (again) compare the sum with the integral.

We get

$$F_{n(\beta)-1}(\mathcal{P}(\beta), \xi_1 \beta, \dots, \xi_p \beta) \leq e^{-E} \sum_{n=1}^{n(\beta)-1} e^{-nD + E\theta^n} \leq e^{-E} \int_0^{n(\beta)} e^{-xD + E\theta^x} dx.$$

Now we get

$$\begin{aligned} \int_0^{n(\beta)} e^{-xD + E\theta^x} dx &= \frac{1}{\log \theta} \int_1^{\theta^{n(\beta)}} \frac{e^{-\frac{D \log u}{\log \theta} + Eu}}{u} du \\ &= \frac{1}{\log \theta} \int_1^{\theta^{n(\beta)}} u^{-1 - \frac{D}{\log \theta}} e^{Eu} du \\ &= \frac{1}{\log \theta} \sum_{k=0}^{+\infty} \frac{E^k}{k!} \int_1^{\theta^{n(\beta)}} u^{k-1 - \frac{D}{\log \theta}} du \\ &= \frac{1}{\log \theta} \sum_{k=0}^{+\infty} \frac{E^k}{k!} \frac{1}{k - \frac{D}{\log \theta}} \left[\theta^{n(\beta)(k - \frac{D}{\log \theta})} - 1 \right]. \\ &= \frac{1}{D} \left(1 - \theta^{-n(\beta) \frac{D}{\log \theta}} \right) + \frac{1}{\log \theta} \sum_{k=1}^{+\infty} \frac{E^k}{k!} \frac{1}{k - \frac{D}{\log \theta}} \left[\theta^{n(\beta)(k - \frac{D}{\log \theta})} - 1 \right]. \end{aligned}$$

As we shall consider β close to $+\infty$ we can assume that β is big enough such that $\theta^{n(\beta)} < \frac{1}{2}$. Then we have

$$\frac{1}{\log \theta} \int_1^{\theta^{n(\beta)}} \frac{e^{-\frac{D \log u}{\log \theta} + Eu}}{u} du = \frac{1}{\log \theta} \int_1^{\frac{1}{2}} \frac{e^{-\frac{D \log u}{\log \theta} + Eu}}{u} du + \frac{1}{\log \theta} \int_{\frac{1}{2}}^{\theta^{n(\beta)}} \frac{e^{-\frac{D \log u}{\log \theta} + Eu}}{u} du.$$

Let us first study the last integral.

$$\begin{aligned} 0 \leq \frac{1}{\log \theta} \int_{\frac{1}{2}}^{\theta^{n(\beta)}} \frac{e^{-\frac{D \log u}{\log \theta} + Eu}}{u} du &\leq \frac{1}{\log \theta} \int_{\frac{1}{2}}^{\theta^{n(\beta)}} u^{-1 - \frac{D}{\log \theta}} e^{\frac{E}{2}} du \\ &\leq e^{\frac{E}{2}} \frac{1}{D} \left[\left(\frac{1}{2} \right)^{-\frac{D}{\log \theta}} - \theta^{-n(\beta) \frac{D}{\log \theta}} \right]. \end{aligned}$$

Remember that $D = g(\beta)e^{-\gamma\beta}$ and $n(\beta) = \frac{\log \varepsilon_0}{\log \theta} \log \beta$. Hence, D and $n(\beta)D$ go to 0 as β goes to $+\infty$. Then

$$\begin{aligned} \frac{1}{D} \left[\left(\frac{1}{2} \right)^{-\frac{D}{\log \theta}} - \theta^{-n(\beta) \frac{D}{\log \theta}} \right] &= \frac{1}{D} \left[\left(\frac{1}{2} \right)^{-\frac{D}{\log \theta}} - 1 \right] + \frac{1}{D} \left[1 - \theta^{-n(\beta) \frac{D}{\log \theta}} \right] \\ &= \frac{\log 2}{\log \theta} + n(\beta) + o(D). \end{aligned}$$

Let us now study $\frac{1}{\log \theta} \int_1^{\frac{1}{2}} \frac{e^{-\frac{D \log u}{\log \theta} + Eu}}{u} du$.

$$\begin{aligned} 0 \leq \frac{1}{\log \theta} \int_1^{\frac{1}{2}} \frac{e^{-\frac{D \log u}{\log \theta} + Eu}}{u} du &= \frac{1}{\log \theta} \int_1^{\frac{1}{2}} u^{-1 - \frac{D}{\log \theta}} e^{Eu} du \\ &\leq \frac{2^{1 + \frac{D}{\log \theta}}}{E |\log \theta|} \left[e^E - e^{\frac{E}{2}} \right]. \end{aligned}$$

Remember that $E = \xi_1 \frac{\theta}{1-\theta} \beta$. Therefore we finally get

$$(15) \quad F_{n(\beta)-1}(\mathcal{P}(\beta), \xi_1 \beta, \dots, \xi_p \beta) \leq n(\beta) e^{-\frac{\xi_1}{2} \frac{\theta}{1-\theta} \beta} + \frac{\kappa}{\xi_1 \beta},$$

for some universal constant³ $\kappa > 0$.

The term in the right hand side in (15) goes to 0 as β goes to $+\infty$. In particular, (14) and (15) show that the result holds if $\gamma > \xi_1 \frac{\theta}{1-\theta}$ because the sum for $n \leq n(\beta)$ is negligible with respect to the sum for $n > n(\beta)$.

Third step. We assume $\gamma < \xi_1 \frac{\theta}{1-\theta}$. Let K be sufficiently big such that $\xi_1 \frac{\theta}{1-\theta} \theta^K < \gamma$. Then, note that we get

$$(16) \quad \begin{aligned} F(\mathcal{P}(\beta), \xi_1 \beta, \dots, \xi_p \beta) &= F_K(\mathcal{P}(\beta), \xi_1 \beta, \dots, \xi_p \beta) + \\ &e^{-K\mathcal{P}(\beta)} \prod_{j=1}^K \left(e^{-\xi_1 \theta^j \beta} + \dots + e^{-\xi_p \theta^j \beta} \right) F(\mathcal{P}(\beta), \xi_1 \theta^K \beta, \dots, \xi_p \theta^K \beta). \end{aligned}$$

³We emphasize that κ can be assumed to be smaller than 4 if β is chosen sufficiently big.

Again we have

$$\prod_{j=1}^K \left(e^{-\xi_1 \theta^j \beta} + \dots + e^{-\xi_p \theta^j \beta} \right) = e^{-\xi_1 \frac{\theta}{1-\theta} \beta + \xi_1 \theta^K \frac{\theta}{1-\theta} \beta} \prod_{j=1}^K \left(1 + e^{-\eta_2 \theta^j \beta} + \dots + e^{-\eta_p \theta^j \beta} \right).$$

This last term $\prod_{j=1}^K \left(1 + e^{-\eta_2 \theta^j \beta} + \dots + e^{-\eta_p \theta^j \beta} \right)$ goes to 1 as β goes to $+\infty$. The term $e^{-K\mathcal{P}(\beta)}$ goes to the constant p^K , and $F(\mathcal{P}(\beta), \xi_1 \theta^K \beta, \dots, \xi_p \theta^K \beta)$ behaves (at the exponential scale) like $O(e^{(\gamma - \xi_1 \theta^K \frac{\theta}{1-\theta}) \beta})$. This proves that the second term in the right hand side of (16) behaves like $O(e^{(\gamma - \xi_1 \frac{\theta}{1-\theta}) \beta})$.

Now, the finite sum $F_K(\mathcal{P}(\beta), \xi_1 \beta, \dots, \xi_p \beta) = e^{-\mathcal{P}(\beta) - \xi_1 \theta \beta} +$ terms which are exponentially small with respect to $e^{-\xi_1 \theta \beta}$ if β goes to $+\infty$. Hence, this finite sum behaves like the biggest term, namely like $O(e^{-\xi_1 \theta \beta})$. This concludes the proof of the lemma. \square

4. PROOF OF THEOREM 1: CONVERGENCE FOR THE EIGENMEASURE ν_β

4.1. **Selection for ν_β .** We set $O_j := \sqcup_i [u_{ij}]$. This is the set of points whose first digit is one of the u_{ij} 's of the alphabet \mathcal{A}_j .

Proposition 8. *For every j ,*

$$\nu_\beta(O_j) = \frac{F(\mathcal{P}(\beta), \alpha_{(j-1)p+1} \beta, \dots, \alpha_{jp} \beta) e^{-\mathcal{P}(\beta)}}{1 + F(\mathcal{P}(\beta), \alpha_{(j-1)p+1} \beta, \dots, \alpha_{jp} \beta) e^{-\mathcal{P}(\beta)}}.$$

Proof. Let m be an admissible word for Σ_j with length n . Let $k \notin \mathcal{A}_j$. Then,

$$(17) \quad \nu_\beta([mk]) = e^{-n\mathcal{P}(\beta) - \sum_{j=0}^{n-1} \alpha_{m_j} \theta^{n-j}} \nu_\beta([k]).$$

This yields

$$\begin{aligned} \nu_\beta(O_j) &= \sum_{k \notin \mathcal{A}_j} \sum_{n=1}^{+\infty} \sum_{m, |m|=n} e^{-n\mathcal{P}(\beta) - \sum_{j=0}^{n-1} \alpha_{m_j} \theta^{n-j}} \nu_\beta([k]) \\ &= \sum_{n=1}^{+\infty} \left(e^{-n\mathcal{P}(\beta)} \prod_{j=1}^n \left(e^{-\alpha_1 \beta \theta^j} + \dots + e^{-\alpha_p \beta \theta^j} \right) \right) e^{-\mathcal{P}(\beta)} (1 - \nu_\beta(O_j)) \\ &= F(\mathcal{P}(\beta), \alpha_1 \beta, \dots, \alpha_p \beta) e^{-\mathcal{P}(\beta)} (1 - \nu_\beta(\sqcup_{i=1}^p [i])) \end{aligned}$$

Therefore we get

$$\nu_\beta(O_j) = \frac{F(\mathcal{P}(\beta), \alpha_1 \beta, \dots, \alpha_p \beta) e^{-\mathcal{P}(\beta)}}{1 + F(\mathcal{P}(\beta), \alpha_1 \beta, \dots, \alpha_p \beta) e^{-\mathcal{P}(\beta)}}.$$

\square

We also have an explicit value for $\nu_\beta([u])$: we write

$$[u] = [uu] \bigsqcup_{i=1}^{kp} [u i],$$

and use conformity to get

$$(18) \quad \nu_\beta([u]) = e^{-\mathcal{P}(\beta) - \alpha\beta}.$$

In particular this quantity goes to 0 as β goes to $+\infty$. This shows that only the N subshifts Σ_j can have positive measure as β goes to $+\infty$.

Now, Propositions 5 and 7 show that $F(\mathcal{P}(\beta), \alpha_1\beta, \dots, \alpha_p\beta)$ behaves like $e^{(\gamma - \alpha_1 \frac{\theta}{1-\theta})\beta}$ as β goes to $+\infty$, and this quantity diverges to $+\infty$. It also shows that for every $j > 1$, $F(\mathcal{P}(\beta), \alpha_{(j-1)p+1}, \dots, \alpha_{jp})$ goes exponentially fast to 0.

This shows that $\nu_\beta(O_1)$ goes to 1. The speed of the convergence is given by $\frac{1}{1 + F(\mathcal{P}(\beta), \alpha_1\beta, \dots, \alpha_p\beta)}$ which goes exponentially fast to 0.

As a by-product, we also immediately get from (17) that for any Σ_1 -admissible word m with $|m| = n$ and for any $k \notin \mathcal{A}_1$,

$$\nu_\beta([mk]) = e^{-n\mathcal{P}(\beta) - \sum_{j=0}^{n-1} \alpha_{m_j} \theta^{n-j}} \nu_\beta([k]) \rightarrow_{\beta \rightarrow +\infty} 0,$$

as $\nu_\beta([k])$ goes to 0 if β goes to $+\infty$. Hence we get

Proposition 9. *Any accumulation point of ν_β is a probability measure with support in Σ_1 .*

4.2. Convergence for ν_β . The measure of maximal entropy $\mu_{top,1}$ is the product of the eigenfunction and the eigenmeasure both associated to the transfer operator for (Σ_1, σ) and the constant potential zero. Hence, the eigenmeasure $\nu_{top,1}$ is characterized by the fact that every Σ_1 -admissible words with a fixed length n have the same measure $\frac{1}{p^n}$.

We have already seen above that any accumulation point for ν_β is a measure, say ν_∞ , such that $\nu_\infty(O_1) = 0$. Our strategy to prove that ν_β converges to $\nu_{top,1}$ is now to prove that for any two Σ_1 -admissible words m and \hat{m} with the same length, $\frac{\nu_\beta([m])}{\nu_\beta([\hat{m}])}$ goes to 1 as β goes to $+\infty$.

Let us thus consider two Σ_1 -admissible words m and \hat{m} with length n . In the following, m' is a word (possibly the empty word) admissible for Σ_1 . We get

$$\begin{aligned} \nu_\beta([m]) &= \sum_{m'} \nu_\beta(mm'*) \\ &= \sum_{k=0}^{+\infty} e^{-n\mathcal{P}(\beta)} e^{S(m)\beta\theta^k} e^{-k\mathcal{P}(\beta)} \prod_{j=1}^k (e^{-\alpha_1\theta^j\beta} + \dots + e^{-\alpha_p\theta^j\beta})(1 - \nu_\beta(O_1)) \\ &\quad \text{where } S(m) := - \sum_{l=0}^{n-1} \alpha_{m_l} \theta^{n-l} \\ &= e^{-n\mathcal{P}(\beta)} \left(e^{S(m)\beta} + \sum_{k=1}^{+\infty} e^{S(m)\beta\theta^k} e^{-k\mathcal{P}(\beta)} \prod_{j=1}^k (e^{-\alpha_1\theta^j\beta} + \dots + e^{-\alpha_p\theta^j\beta}) \right) (1 - \nu_\beta(O_1)). \end{aligned} \tag{19}$$

The series in the right hand side of this last equality is almost the same than the one defining $F(\mathcal{P}(\beta), \alpha_1\beta, \dots, \alpha_p\beta)$ up to the extra term $e^{S(m)\beta\theta^k}$.

Replacing m by \widehat{m} we get a similar formula for $\nu_\beta([\widehat{m}])$.

The quantities $S(m)$ and $S(\widehat{m})$ are negative, hence $e^{S(\widehat{m})\beta\theta^k}$ is lower than 1 for $\widehat{m} = m, \widehat{m}$. Now, remember the definition of $n(\beta) = \frac{\log \varepsilon_0}{\log \theta} \log \beta$ (see p. 16). Step 2 of the proof of Proposition 7 shows that $F_{n(\beta)}(\mathcal{P}(\beta), \alpha_1\beta, \dots, \alpha_p\beta)$ goes to 0 as β goes to $+\infty$, whereas

Step 1 of the proof of Proposition 7 shows that the tail $\sum_{k \geq n(\beta)+1} e^{-k\mathcal{P}(\beta)} \prod_{j=1}^k (e^{-\alpha_1\theta^j\beta} + \dots + e^{-\alpha_p\theta^j\beta})$ diverges (exponentially fast) to $+\infty$. Note that for $k \geq n(\beta)$, $\beta\theta^k \leq \frac{1}{\beta}$. Therefore we get

$$\frac{\nu_\beta([m])}{\nu_\beta([\widehat{m}])} \leq \frac{1 + F_{n(\beta)}(\mathcal{P}(\beta), \alpha_1\beta, \dots, \alpha_p\beta) + \sum_{k > n(\beta)} e^{-k\mathcal{P}(\beta)} \prod_{j=1}^k (e^{-\alpha_1\theta^j\beta} + \dots + e^{-\alpha_p\theta^j\beta})}{e^{\frac{S(\widehat{m})}{\beta}} \sum_{k > n(\beta)} e^{-k\mathcal{P}(\beta)} \prod_{j=1}^k (e^{-\alpha_1\theta^j\beta} + \dots + e^{-\alpha_p\theta^j\beta})}.$$

Doing β goes to $+\infty$ in this last inequality we get $\limsup_{\beta \rightarrow +\infty} \frac{\nu_\beta([m])}{\nu_\beta([\widehat{m}])} \leq 1$. Exchanging m

and \widehat{m} we also get $\limsup_{\beta \rightarrow +\infty} \frac{\nu_\beta([\widehat{m}])}{\nu_\beta([m])} \leq 1$, which means

$$\lim_{\beta \rightarrow +\infty} \frac{\nu_\beta([m])}{\nu_\beta([\widehat{m}])} = 1.$$

In other words, any accumulation point for ν_β is a probability measure with support in Σ_1 which gives the same weight to all the cylinders of same length. There exists only one such measure, it is $\nu_{top,1}$. This finishes the proof of Theorem 1.

5. PROOF OF THEOREM 2: CONVERGENCE AND SELECTION FOR μ_β

5.1. **An expression for $\mu_\beta(O_j)$.** We recall that $n(\beta)$ was defined (see Equation 12) by

$$n(\beta) := \frac{\log \varepsilon_0}{\log \theta} \log \beta.$$

Its main properties are that $n(\beta)$ goes to $+\infty$ as β goes to $+\infty$ and $n(\beta) \cdot \beta \cdot \theta^\beta$ goes to 0.

We recall that for every j and for every Σ_j -admissible word m with finite length we have

$$(20) \quad H_\beta(m) = e^{-\mathcal{P}(\beta)} \sum_{i=1}^p e^{\beta \cdot A(u_{ij}m)} H_\beta(u_{ij}m) + e^{-\mathcal{P}(\beta)} \tau_j.$$

The main result in this subsection is the following proposition, which gives an expression for $\mu_\beta(O_j)$. We employ notations from Lemma 6 and Proposition 7; we remind $r = -\frac{\log p}{\log \theta}$ and that $I(\eta_2, \dots, \eta_p)$ was defined there.

Proposition 10. *For every j , let us set $\eta_{ij} := \alpha_{(j-1)p+i} - \alpha_{(j-1)p+1}$. Then*

$$\mu_\beta(O_j) = e^{-\mathcal{P}(\beta)} \cdot \tau_j (1 - \nu_\beta(O_j)) \left[\frac{1}{\alpha_{(j-1)p+1}} O\left(\frac{n(\beta)}{\beta}\right) + \frac{n(\beta)(1 + o_\infty(\beta))}{\beta^r (g(\beta))^2} e^{(2\gamma - \alpha_{(j-1)p+1} \frac{\theta}{1-\theta})\beta} e^{-\frac{I(\eta_2, \dots, \eta_{pj})}{\log \theta}} \right],$$

where $o_\infty(\beta)$ goes to 0 as β goes to $+\infty$.

As $n(\beta)$ is proportional to $\log \beta$, the term $O\left(\frac{n(\beta)}{\beta}\right)$ goes to 0 as β goes to $+\infty$. The importance of the formula is that, either $2\gamma > \alpha_{(j-1)p+1} \frac{\theta}{1-\theta}$ and the second term goes to $+\infty$, or the possible convergence occurs at the sub exponential scale.

In particular, it will show that only the components with $\alpha_{(j-1)p+1}$ sufficiently small can have weight as β goes to $+\infty$.

In view to prove Proposition 10, let us first start with some technical lemmas.

Lemma 11. *For every $j \neq j'$, $\tau_j(1 + F(\mathcal{P}(\beta), \alpha_{p(j-1)}\beta, \dots, \alpha_{jp}\beta)) = \tau_{j'}(1 + F(\mathcal{P}(\beta), \alpha_{p(j'-1)}\beta, \dots, \alpha_{j'p}\beta))$.*

Proof. For a By Lemma 1 H_β is constant on rings. Setting $u_{1j}^n = \underbrace{u_{1j} \dots u_{1j}}_{n \text{ times}}$ we get

$$(21) \quad H_\beta(u_{1j}^n) = e^{-\mathcal{P}(\beta)} H_\beta(u_{1j}^{n+1}) \left(e^{-\alpha_{(j-1)p+1}\beta\theta^{n+1}} + \dots + e^{-\alpha_{jp}\beta\theta^{n+1}} \right) + e^{-\mathcal{P}(\beta)} \tau_j.$$

We set $\rho(j, n+1, \beta) := e^{-\alpha_{(j-1)p+1}\beta\theta^{n+1}} + \dots + e^{-\alpha_{jp}\beta\theta^{n+1}}$. Note that

$$F(\mathcal{P}(\beta), \alpha_{p(j-1)+1}\beta, \dots, \alpha_{jp}\beta) := \sum_{k=1}^{+\infty} e^{-k\mathcal{P}(\beta)} \prod_{i=1}^k \rho(j, i, \beta),$$

and remember $F_l(\mathcal{P}(\beta), \alpha_{p(j-1)+1}\beta, \dots, \alpha_{jp}\beta) := \sum_{k=1}^l e^{-k\mathcal{P}(\beta)} \prod_{i=1}^k \rho(j, i, \beta)$ Then, multiply-

ing both sides of Equation (21) by $e^{-\mathcal{P}(\beta)} \rho(j, n, \beta)$ and adding $e^{-\mathcal{P}(\beta)} \tau_j$ we get

$$H_\beta(u_{1j}^{n-1}) = e^{-2\mathcal{P}(\beta)} \rho(j, n, \beta) \rho(j, n+1, \beta) H_\beta(u_{1j}^{n+1}) + e^{-\mathcal{P}(\beta)} \tau_j (1 + e^{-\mathcal{P}(\beta)} \rho(j, n, \beta)).$$

We get, by induction, a relation between $H_\beta(u_{1j}^n)$, n and $H_\beta(u_{1j})$. Now, remember $H_\beta(u) = e^{-\mathcal{P}(\beta)} \rho(j, 1, \beta) + e^{-\mathcal{P}(\beta)} \tau_j$, and we finally get

(22)

$$H_\beta(u) = H_\beta(u_{1j}^n) \left[e^{-n\mathcal{P}(\beta)} \prod_{i=1}^{n-1} \rho(j, i, \beta) \right] + e^{-\mathcal{P}(\beta)} \tau_j (1 + F_n(\mathcal{P}(\beta), \alpha_{p(j-1)}\beta, \dots, \alpha_{jp}\beta)).$$

Now, let n goes to $+\infty$ in (22). The term $H_\beta(u_{1j}^n)$ converges to $\frac{\tau_j}{e^{\mathcal{P}(\beta)} - p}$ (see Lemma

2) and the term $e^{-n\mathcal{P}(\beta)} \prod_{i=1}^{n-1} \rho(j, i, \beta)$ is the general term of a converging series, thus goes

to 0. Then we get

$$H_\beta(u) = e^{-\mathcal{P}(\beta)} \tau_j (1 + F(\mathcal{P}(\beta), \alpha_{p(j-1)}\beta, \dots, \alpha_{jp}\beta)).$$

This holds for any j . \square

Lemma 12. *For any j and for any integer n ,*

$$H_\beta(u_{1j}^n) = e^{-\mathcal{P}(\beta)} \tau_j (1 + F(\mathcal{P}(\beta), \alpha_{p(j-1)}\beta\theta^n, \dots, \alpha_{jp}\beta\theta^n)).$$

Proof. Equation (21) also yields

$$H_\beta(u_{1j}^n) = e^{-2\mathcal{P}(\beta)} \rho(j, n+1, \beta) \rho(j, n+2, \beta) H_\beta(u_{1j}^{n+2}) + e^{-\mathcal{P}(\beta)} \tau_j (1 + e^{-\mathcal{P}(\beta)} \rho(j, n+1, \beta)).$$

By induction we get

$$\begin{aligned} H_\beta(u_{1j}^n) &= \left[e^{-i\mathcal{P}(\beta)} \prod_{l=1}^i \rho(j, n+l, \beta) \right] H_\beta(u_{1j}^{n+i}) + e^{-\mathcal{P}(\beta)} \tau_j \left(1 + \sum_{l=1}^i e^{-\mathcal{P}(\beta)} \prod_{r=1}^l \rho(j, n+r, \beta) \right) \\ &= \left[e^{-i\mathcal{P}(\beta)} \prod_{l=1}^i \rho(j, n+l, \beta) \right] H_\beta(u_{1j}^{n+i}) + e^{-\mathcal{P}(\beta)} \tau_j (1 + F_i(\mathcal{P}(\beta), \alpha_{p(j-1)}\beta\theta^n, \dots, \alpha_{jp}\beta\theta^n)). \end{aligned}$$

As above, as i goes to $+\infty$, $H_\beta(u_{1j}^{n+i})$ converges to $\frac{\tau_j}{e^{\mathcal{P}(\beta)} - p}$ (see Lemma 2) and the term

$e^{-i\mathcal{P}(\beta)} \prod_{l=1}^i \rho(j, l, \beta)$ is the general term of a converging series, thus goes to 0. \square

$$\mathbf{Lemma 13.} \quad \mu(O_j) = e^{-\mathcal{P}(\beta)} \tau_j \sum_{l=1}^{+\infty} l e^{-l\mathcal{P}(\beta)} \prod_{i=1}^l \left(e^{-\alpha_{(j-1)p+1}\theta^i\beta} + \dots + e^{-\alpha_{jp}\theta^i\beta} \right) (1 - \nu_\beta(O_j)).$$

Proof. We pick some j . In the following m is a generic Σ_j -admissible word with finite length.

$$\begin{aligned} \sum_{m, |m|=l} \mu_\beta[m] &= \sum_{m, |m|=l} H_\beta(m) \nu_\beta(m) \\ &= \sum_{m, |m|=l} H_\beta(m) e^{-l\mathcal{P}(\beta)} \prod_{i=1}^l \left(e^{-\alpha_{(j-1)p+1}\theta^i\beta} + \dots + e^{-\alpha_{jp}\theta^i\beta} \right) (1 - \nu_\beta(O_j)). \\ (23) \quad &= H_\beta(u_{1j}^l) e^{-l\mathcal{P}(\beta)} \prod_{i=1}^l \left(e^{-\alpha_{(j-1)p+1}\beta\theta^i} + \dots + e^{-\alpha_{jp}\beta\theta^i} \right) (1 - \nu_\beta(O_j)), \end{aligned}$$

Equality (23) and Lemma 12 yield

$$\begin{aligned} \sum_{m, |m|=l} \mu_\beta[m] &= H_\beta(u_{1j}^l) e^{-l\mathcal{P}(\beta)} \prod_{i=1}^l \left(e^{-\alpha_{(j-1)p+1}\beta\theta^i} + \dots + e^{-\alpha_{jp}\beta\theta^i} \right) (1 - \nu_\beta(O_j)) \\ &= e^{-\mathcal{P}(\beta)} \tau_j (F(\mathcal{P}(\beta), \alpha_{(j-1)p+1}\beta, \dots, \alpha_{jp}\beta) - F_{l-1}(\mathcal{P}(\beta), \alpha_{(j-1)p+1}\beta, \dots, \alpha_{jp}\beta)) (1 - \nu_\beta(O_j)) \end{aligned}$$

Now, it is an usual exercise that the sum of the tail of a series of positive terms u_n is equal to $\sum_n n u_n$. \square

Proof of Proposition 10. We split the sum in the formula of Lemma 13 in two pieces, the one for $l < n(\beta)$ and the one for $l \geq n(\beta)$.

For the part for $l < n(\beta)$, we use Inequality (15), and

$$\sum_{l=1}^{n(\beta)-1} l e^{-l\mathcal{P}(\beta)} \prod_{i=1}^l \left(e^{-\alpha_{(j-1)p+1}\theta^i\beta} + \dots + e^{-\alpha_{jp}\theta^i\beta} \right) \leq n(\beta) F_{n(\beta)-1}(\mathcal{P}(\beta), \alpha_{(j-1)p+1}\beta, \dots, \alpha_{jp}\beta).$$

For the sum for $l \geq n(\beta)$, we use Equality (13). We have to “update” it and replace $e^{-ng(\beta)e^{-\gamma\beta}}$ by $n e^{-ng(\beta)e^{-\gamma\beta}}$. In other words, we are computing the formal power series $\sum_{n \geq n(\beta)} n x^n$ with $x = e^{-g(\beta)e^{-\gamma\beta}}$. It is the derivative of the power series $\sum_{n \geq n(\beta)} x^n$. Hence we get

$$\sum_{n \geq n(\beta)} n x^n = n(\beta) \frac{x^{n(\beta)-1}}{(1-x)^2} \left(1 + x \left(1 - \frac{1}{n(\beta)} \right) \right).$$

Again, $e^{-n(\beta)g(\beta)e^{-\gamma\beta}}$ goes to 1 as β goes to $+\infty$ and $1 - e^{-g(\beta)e^{-\gamma\beta}}$ behaves like $g(\beta)e^{-\gamma\beta}$. \square

5.2. Selection. For simplicity we set⁴ $F_j := F(\mathcal{P}(\beta), \alpha_{(j-1)p+1}\beta, \dots, \alpha_{jp}\beta)$, $\eta_{ij} := \eta_{(j-1)p+i-1}$ and $I_j := \frac{1}{\log \theta} I(\eta_{2j}, \dots, \eta_{pj})$. We remind that $o_\infty(\beta)$ means a function going to 0 as β goes to $+\infty$.

5.2.1. The case $\gamma < \frac{\alpha_1 + \alpha_{p+1}}{2} \frac{\theta}{1-\theta}$. This corresponds to zone Z_2 (see Figure 3). We emphasize that, if j is such that $2\gamma < \alpha_{(j-1)p+1} \frac{\theta}{1-\theta}$, then Propositions 10 and 7 show that $\mu_\beta(O_j)$ behaves like $\tau_j o_\infty(\beta)$.

Lemma 14. *Under the assumption $2\gamma \leq \alpha_{(j-1)p+1} \frac{\theta}{1-\theta}$, $\mu_\beta(O_j)$ goes to 0 exponentially fast as β goes to $+\infty$.*

Proof. Let us assume that j is such that $2\gamma < \alpha_{(j-1)p+1} \frac{\theta}{1-\theta}$.

⁴these are different from the truncated sums defined above.

$$\begin{aligned}
\frac{\mu_\beta(O_1)}{\mu_\beta(O_j)} &= \frac{\tau_1}{(1+F_1)\tau_j} \widehat{\kappa}(\beta) \frac{1}{\beta^r(g(\beta))^2} e^{(2\gamma-\alpha_1\frac{\theta}{1-\theta})\beta} e^{-I_1} \frac{1}{o_\infty(\beta)} \\
&= \frac{1+F_j}{(1+F_1)^2} \widehat{\kappa}(\beta) \frac{1}{\beta^r(g(\beta))^2} e^{(2\gamma-\alpha_1\frac{\theta}{1-\theta})\beta} e^{-I_1} \frac{1}{o_\infty(\beta)} \\
&\quad (\text{by Lemma 11}) \\
&= \phi(\beta) \frac{e^{(2\gamma-\alpha_1\frac{\theta}{1-\theta})\beta}}{o_\infty(\beta) e^{2(\gamma-\alpha_1\frac{\theta}{1-\theta})\beta}} \\
&\quad \text{by Prop. 7 and for some sub exponential function } \phi \\
(24) \quad &= \phi(\beta) \frac{e^{\alpha_1\frac{\theta}{1-\theta}\beta}}{o_\infty(\beta)}.
\end{aligned}$$

This shows that $\mu_\beta(O_1)$ is exponentially bigger (in β) than $\mu_\beta(O_j)$, and thus $\mu_\beta(O_j)$ goes exponentially fast to 0.

The same holds if we only assume $2\gamma \leq \alpha_{(j-1)p+1}\frac{\theta}{1-\theta}$, because for the equality case, we have just to replace the term $o_\infty(\beta)$ by some sub exponential quantity (which does not necessarily goes to 0). However, this does not eliminate the exponential ratio in the computation. □

Remark 2. Furthermore, this shows that $\mu_\beta(O_2)$ can have a positive accumulation point only if $2\gamma > \alpha_{p+1}\frac{\theta}{1-\theta}$. ■

Lemma 15. Assume $2\gamma > \alpha_{p+1}\frac{\theta}{1-\theta}$. Then, for every $j > 2$, $\lim_{\beta \rightarrow +\infty} \mu_\beta(O_j) = 0$.

Proof. We copy the previous computation with O_2 instead of O_1 . Note that F_2 goes to 0 as β goes to $+\infty$. We first assume $2\gamma \leq \alpha_{(j-1)p+1}\frac{\theta}{1-\theta}$

Then we have

$$\frac{\mu_\beta(O_2)}{\mu_\beta(O_j)} = \frac{\tau_2}{\tau_j} \frac{1+F_j}{1+F_2} \frac{\widehat{\kappa}(\beta) e^{(2\gamma-\alpha_{p+1}\frac{\theta}{1-\theta})\beta}}{o_\infty(\beta)},$$

where $o_\infty(\beta)$ may be replaced by a sub exponential function (if $2\gamma = \alpha_{(j-1)p+1}\frac{\theta}{1-\theta}$). Note that $\frac{\tau_2}{\tau_j} \rightarrow 1$ and $\frac{1+F_j}{1+F_2} \rightarrow 1$ as $\beta \rightarrow +\infty$. Then, $\mu_\beta(O_j)$ is exponentially smaller than $\mu_\beta(O_2) \leq 1$.

If $2\gamma > \alpha_{(j-1)p+1}\frac{\theta}{1-\theta}$, then $\frac{\mu_\beta(O_2)}{\mu_\beta(O_j)}$ is— up to a sub-exponential multiplicative ratio— equal to $\frac{e^{(2\gamma-\alpha_{p+1}\frac{\theta}{1-\theta})\beta}}{e^{(2\gamma-\alpha_{(j-1)p+1}\frac{\theta}{1-\theta})\beta}} = e^{(\alpha_{(j-1)p+1}-\alpha_{p+1})\frac{\theta}{1-\theta}\beta}$. Now, we remind

$$\alpha_{p+1} < \alpha_{(j-1)p+1}.$$

□

Lemma 16. *If $\gamma < \frac{\alpha_1 + \alpha_{p+1}}{2} \frac{\theta}{1-\theta}$, then $\lim_{\beta \rightarrow +\infty} \mu_\beta(O_1) = 1$.*

Proof. The result holds if $2\gamma \leq \alpha_{p+1} \frac{\theta}{1-\theta}$. Let us thus assume $2\gamma > \alpha_{p+1} \frac{\theta}{1-\theta}$. Then Equation (24) is still valid, provide that we replace $o_\infty(\beta)$ by $e^{-I_2} e^{(2\gamma - \alpha_{p+1} \frac{\theta}{1-\theta})\beta}$ (following Proposition 10). Hence we get

$$\frac{\mu_\beta(O_1)}{\mu_\beta(O_2)} = \phi(\beta) e^{((\alpha_1 + \alpha_{p+1}) \frac{\theta}{1-\theta} - 2\gamma)\beta},$$

for some sub-exponential function $\phi(\beta)$. Our assumption in the Lemma means that this last quantity diverges exponentially fast to $+\infty$ as β goes to $+\infty$, which means that $\mu_\beta(O_1)$ is exponentially bigger than $\mu_\beta(O_2)$ as β goes to $+\infty$. Hence, $\mu_\beta(O_2)$ goes to 0. Lemma 15 shows that $\mu_\beta(O_j)$ goes to 0 for every $j \neq 1$, thus $\mu_\beta(O_1)$ goes to 1. \square

5.2.2. *The case $\gamma = \frac{\alpha_1 + \alpha_{p+1}}{2} \frac{\theta}{1-\theta} < \min(\alpha_1 \frac{\theta}{1-\theta} + \alpha, \alpha_1 \frac{\theta}{1-\theta} + \alpha_{p+1}\theta)$.* This corresponds to zone Z_1 (see Figure 3). We emphasize that in that case,

$$2\gamma > \alpha_{p+1} \frac{\theta}{1-\theta}$$

always holds. Therefore only O_1 and O_2 can have weight for $\beta \rightarrow +\infty$. Moreover, $\gamma = \frac{\alpha_1 + \alpha_{p+1}}{2} \frac{\theta}{1-\theta}$ implies

$$\frac{\alpha_1 + \alpha_{p+1}}{2} \frac{\theta}{1-\theta} < \alpha_1 \frac{\theta}{1-\theta} + \alpha_{p+1}\theta,$$

which yields

$$\gamma - \alpha_{p+1} \frac{\theta}{1-\theta} = \frac{\alpha_1 - \alpha_{p+1}}{2} \frac{\theta}{1-\theta} > -\alpha_{p+1}\theta.$$

Then, Proposition 7 shows

$$(25) \quad F_2 = \frac{1}{\beta^r g(\beta)} e^{-I_2} e^{(\gamma - \alpha_{p+1} \frac{\theta}{1-\theta})\beta} (1 + o_\infty(\beta)).$$

It also shows that for every $j > 2$, F_j is of order $\max(e^{-\alpha(j-1)p+1\beta}, e^{(\gamma - \alpha(j-1)p+1) \frac{\theta}{1-\theta}\beta})$. It is thus exponentially smaller than F_2 .

Lemma 17. *Under these hypothesis, $\lim_{\beta \rightarrow +\infty} F_1 F_2 = p^2$ and $g(\beta) = \frac{1}{p\beta^r} e^{-\frac{I_1 + I_2}{2}} (1 + o_\infty(\beta))$.*

Proof. Equation (17) can be rewritten under the form:

$$\nu_\beta(O_j) = e^{-\mathcal{P}(\beta)} \sum_{i \neq j} F_i \nu_\beta(O_i) + e^{-\mathcal{P}(\beta)} \nu_\beta([u]).$$

This yields a linear system

$$\begin{pmatrix} 1 & -e^{-\mathcal{P}(\beta)} F_1 & \dots & -e^{-\mathcal{P}(\beta)} F_1 \\ -e^{-\mathcal{P}(\beta)} F_2 & 1 & & -e^{-\mathcal{P}(\beta)} F_2 \\ \vdots & & \ddots & \vdots \\ -e^{-\mathcal{P}(\beta)} F_N & \dots & -e^{-\mathcal{P}(\beta)} F_N & 1 \end{pmatrix} \begin{pmatrix} \nu_\beta(O_1) \\ \nu_\beta(O_2) \\ \vdots \\ \nu_\beta(O_N) \end{pmatrix} = \begin{pmatrix} e^{-\mathcal{P}(\beta)} \nu_\beta([u]) F_1 \\ e^{-\mathcal{P}(\beta)} \nu_\beta([u]) F_2 \\ \vdots \\ e^{-\mathcal{P}(\beta)} \nu_\beta([u]) F_N \end{pmatrix}.$$

We remind that F_j goes to 0 as β goes to $+\infty$ for $j \geq 2$, and F_1 goes to $+\infty$.

We compute the dominating term of the determinant of the $N \times N$ matrix in the left hand side of the last equality. Developing this determinant with respect to the first row, we left it to the reader to check that the determinant is of the form

$$\det(\beta) = 1 - e^{-2\mathcal{P}(\beta)} F_1 \left(\sum_{i=2}^N F_i \right) (1 + o_\infty(\beta)).$$

Now we compute the cofactors for the terms of the first column. Again, we left it to the reader to check that the cofactor of the term in position $i, 1$ is of the form

$$\delta_{1,1} = 1 + o_\infty(\beta), \quad \delta_{i,1} = -e^{-\mathcal{P}(\beta)} F_1 (1 + o_\infty(\beta)).$$

Now, remind Equality (18) $\nu_\beta([u]) = e^{-\mathcal{P}(\beta) - \alpha\beta}$.

Therefore, Equality (25) and the property $F_j \ll F_2$ (for $j > 2$) yield

$$(26) \quad \nu_\beta(O_1) = \frac{F_1 e^{-2\mathcal{P}(\beta) - \alpha(1 + o_\infty(\beta))}}{1 - e^{-2\mathcal{P}(\beta)} F_1 F_2 (1 + o_\infty(\beta))}.$$

We remind that with our values of the parameter, $\gamma = \frac{\alpha_1 + \alpha_{p+1}}{2} \frac{\theta}{1 - \theta} < \alpha_1 \frac{\theta}{1 - \theta} + \alpha$.

Now, F_1 behaves (at the exponential scale) like $e^{(\gamma - \alpha_1 \frac{\theta}{1 - \theta})\beta} < \alpha\beta$. This shows that the numerator in (26) goes to 0 as β goes to $+\infty$. Therefore the denominator also goes to 0 and the first part of the Lemma is proved as $\lim_{\beta \rightarrow +\infty} \mathcal{P}(\beta) = p$.

Let us now replace F_1 and F_2 by their values. Following Proposition 7 and (25) we get

$$\begin{aligned} F_1 F_2 &= e^{-I_1 - I_2} \frac{1}{(\beta^r g(\beta))^2} e^{(2\gamma - (\alpha_1 + \alpha_{p+1}) \frac{\theta}{1 - \theta})\beta} (1 + o_\infty(\beta)) \\ &= e^{-I_1 - I_2} \frac{1}{(\beta^r g(\beta))^2} (1 + o_\infty(\beta)). \end{aligned}$$

As $F_1 F_2$ goes to p^2 , we get $g(\beta) = \frac{1}{p\beta^r} e^{-\frac{I_1 + I_2}{2}} (1 + o_\infty(\beta))$. □

We can now finish the proof of Theorem 2— item (1). We remind that we get

$$\mu_\beta(O_1) = e^{-\mathcal{P}(\beta)} \frac{\tau_1}{1 + F_1} \frac{n(\beta)}{\beta^r (g(\beta))^2} e^{-I_1} e^{(2\gamma - \alpha_1 \frac{\theta}{1 - \theta})\beta},$$

and

$$\mu_\beta(O_2) = e^{-\mathcal{P}(\beta)} \frac{\tau_2}{1 + F_2} \frac{n(\beta)}{\beta^r (g(\beta))^2} e^{-I_2} e^{(2\gamma - \alpha_{p+1} \frac{\theta}{1 - \theta})\beta}.$$

We also remind

- $\tau_1(1 + F_1) = \tau_2(1 + F_2)$ (Lemma 11)
- $F_2 \rightarrow_{\beta \rightarrow +\infty} 0$ and $F_1 \rightarrow_{\beta \rightarrow +\infty} +\infty$,
- $g(\beta) = \frac{1}{p\beta^r} e^{-\frac{I_1 + I_2}{2}} (1 + o_\infty(\beta))$ (Lemma 17),
- $\gamma = \frac{\alpha_1 + \alpha_{p+1}}{2} \frac{\theta}{1 - \theta}$.

Then we get

$$\begin{aligned}
\frac{\mu_\beta(O_1)}{\mu_\beta(O_2)} &= \frac{\tau_1}{(1+F_1)^2} \frac{1+F_1}{\tau_2} (1+F_2) e^{I_2-I_1} e^{(\alpha_{p+1}-\alpha_1) \frac{\theta}{1-\theta} \beta} (1+o_\infty(\beta)) \\
&= \frac{e^{I_2-I_1}}{(1+F_1)^2} e^{(\alpha_{p+1}-\alpha_1) \frac{\theta}{1-\theta} \beta} (1+o_\infty(\beta)) \\
&= e^{I_2-I_1} e^{2I_1} (\beta^r g(\beta))^2 e^{(\alpha_{p+1}-\alpha_1) \frac{\theta}{1-\theta} \beta} e^{2(\alpha_1 \frac{\theta}{1-\theta} - \gamma) \beta} (1+o_\infty(\beta)) \\
&= \frac{1}{p^2} (1+o_\infty(\beta)).
\end{aligned}$$

5.2.3. *The case* $\gamma = \frac{\alpha_1 + \alpha_{p+1}}{2} \frac{\theta}{1-\theta} = \alpha_1 \frac{\theta}{1-\theta} + \alpha < \alpha_1 \frac{\theta}{1-\theta} + \alpha_{p+1} \theta$. This corresponds to zone $Z_3 \setminus Z_4$ (see Figure 3). The situation is very similar than the previous one. We rewrite Equality (26):

$$\nu_\beta(O_1) = \frac{F_1 e^{-2\mathcal{P}(\beta) - \alpha} (1+o_\infty(\beta))}{1 - e^{-2\mathcal{P}(\beta)} F_1 F_2 (1+o_\infty(\beta))}.$$

Again we claim that we get $F_1 F_2 = e^{-I_1 - I_2} \frac{1}{(\beta^r g(\beta))^2} (1+o_\infty(\beta))$.

Nevertheless, and contrarily to the previous case, the numerator is equal to

$$e^{-2\mathcal{P}(\beta) - \alpha} F_1 = e^{-I_1} \frac{1}{\beta^r g(\beta)}.$$

Let L be any accumulation for $\frac{1}{\beta^r g(\beta)}$. Then we get

$$1 = \frac{e^{-I_1} L}{p^2 - e^{-I_1 - I_2} L^2}.$$

Note that $L \geq 0$, then solving the equation we get only one non-negative solution. Hence

$$\lim_{\beta \rightarrow +\infty} \frac{1}{\beta^r g(\beta)} = \frac{\sqrt{4p^2 e^{I_1 - I_2} - 1}}{2} e^{I_2}.$$

Now, copying what is done above we get

$$\begin{aligned}
\frac{\mu_\beta(O_1)}{\mu_\beta(O_2)} &= \frac{\tau_1}{(1+F_1)^2} \frac{1+F_1}{\tau_2} (1+F_2) e^{I_2-I_1} e^{(\alpha_{p+1}-\alpha_1) \frac{\theta}{1-\theta} \beta} (1+o_\infty(\beta)) \\
&= \frac{e^{I_2-I_1}}{(1+F_1)^2} e^{(\alpha_{p+1}-\alpha_1) \frac{\theta}{1-\theta} \beta} (1+o_\infty(\beta)) \\
&= e^{I_2-I_1} e^{2I_1} (\beta^r g(\beta))^2 e^{(\alpha_{p+1}-\alpha_1) \frac{\theta}{1-\theta} \beta} e^{2(\alpha_1 \frac{\theta}{1-\theta} - \gamma) \beta} (1+o_\infty(\beta)) \\
&= \frac{4e^{I_1 - I_2}}{\left(\sqrt{4p^2 e^{I_1 - I_2} + 1} - 1\right)^2} (1+o_\infty(\beta)).
\end{aligned}$$

We set

$$(27) \quad \rho_3^2 := \frac{4e^{I_1 - I_2}}{\left(\sqrt{4p^2 e^{I_1 - I_2} + 1} - 1\right)^2}.$$

5.2.4. *The case* $\gamma = \frac{\alpha_1 + \alpha_{p+1}}{2} \frac{\theta}{1 - \theta} = \alpha_1 \frac{\theta}{1 - \theta} + \alpha_{p+1} \theta < \alpha_1 \frac{\theta}{1 - \theta} + \alpha$. This corresponds to zone $Z_4 \setminus Z_3$ (see Figure 3).

Lemma 18. *The quantity F_2 is exponentially bigger than every F_j for $j > 2$.*

Proof. We remind that $\alpha_{p+1} = \frac{\alpha_1}{2\theta - 1}$. Then, Proposition 7 shows that F_2 behaves, at the exponential scale, like $\max(e^{-\alpha_{p+1}\theta\beta}, e^{(\gamma - \alpha_{p+1}\frac{\theta}{1-\theta})\beta})$ and these two quantities are equal.

Now, for $j > 2$, F_j is lower than $e^{-\alpha(j-1)p+1\theta}$, thus exponentially smaller than F_2 . \square

Again, we rewrite Equality (26). Lemma 18 shows that $F_2 + F_3 + \dots$ is again of the form $F_2(1 + o_\infty(\beta))$:

$$\nu_\beta(O_1) = \frac{F_1 e^{-2\mathcal{P}(\beta) - \alpha(1 + o_\infty(\beta))}}{1 - e^{-2\mathcal{P}(\beta)} F_1 F_2 (1 + o_\infty(\beta))}.$$

Lemma 19. *The quantity $F_1 F_2$ goes to p^2 as β goes to $+\infty$ and $\beta^r g(\beta)$ converges as β goes to $+\infty$. The limit is denoted by L .*

Proof. Remember that F_1 behaves like $e^{(\gamma - \alpha_1 \frac{\theta}{1-\theta})\beta} = e^{\alpha_{p+1} \frac{\theta}{1-\theta} \beta}$, and our assumption yields that the numerator in the last expression for $\nu_\beta(O_1)$ goes exponentially fast to 0. Hence, the denominator also goes to 0 and (again) $F_1 F_2$ goes to p^2 .

Let L be any accumulation point for $\beta^r g(\beta)$ (in $\overline{\mathbb{R}_+}$). Proposition 7 shows that F_1 behaves like $e^{-I_1} \frac{1}{L} e^{(\gamma - \alpha_1 \frac{\theta}{1-\theta})\beta} (1 + o_\infty(\beta))$ and F_2 behaves like $\max(1, e^{-I_2} \frac{1}{L}) e^{(\gamma - \alpha_{p+1} \frac{\theta}{1-\theta})\beta} (1 + o_\infty(\beta))$.

This yields equality $F_1 F_2 = e^{-I_1} \frac{1}{L} \cdot \max(1, e^{-I_2} \frac{1}{L}) (1 + o_\infty(\beta))$. and doing $\beta \rightarrow +\infty$ we get

$$(28) \quad p^2 = e^{-I_1} \frac{1}{L} \cdot \max(1, e^{-I_2} \frac{1}{L}).$$

Now, the function $x \mapsto e^{-I_1} x \max(1, e^{-I_2} x)$ is increasing. Thus there exists a unique x such that its value is p^2 . This proves that $\beta^r g(\beta)$ has unique accumulation point, thus converges. \square

Now, copying what is done above we get

$$\begin{aligned}
\frac{\mu_\beta(O_1)}{\mu_\beta(O_2)} &= \frac{\tau_1}{(1+F_1)^2} \frac{1+F_1}{\tau_2} (1+F_2) e^{I_2-I_1} e^{(\alpha_{p+1}-\alpha_1)\frac{\theta}{1-\theta}\beta} (1+o_\infty(\beta)) \\
&= \frac{e^{I_2-I_1}}{(1+F_1)^2} e^{(\alpha_{p+1}-\alpha_1)\frac{\theta}{1-\theta}\beta} (1+o_\infty(\beta)) \\
&= e^{I_2-I_1} e^{2I_1} (\beta^r g(\beta))^2 e^{(\alpha_{p+1}-\alpha_1)\frac{\theta}{1-\theta}\beta} e^{2(\alpha_1\frac{\theta}{1-\theta}-\gamma)\beta} (1+o_\infty(\beta)) \\
&= e^{I_1+I_2} L^2 (1+o_\infty(\beta)).
\end{aligned}$$

We set

$$(29) \quad \rho_4^2 := e^{I_1+I_2} L^2.$$

5.2.5. *The case* $\gamma = \frac{\alpha_1 + \alpha_{p+1}}{2} \frac{\theta}{1-\theta} = \alpha_1 \frac{\theta}{1-\theta} + \alpha = \alpha_1 \frac{\theta}{1-\theta} + \alpha_{p+1}\theta$. This corresponds to zone $Z_3 \cap Z_4$ (see Figure 3).

The situation is very similar than the previous one. Lemma 18 still holds as we just used inequalities $\alpha_{p+1} < \alpha_{(j-1)p+1}$ for $j > 2$. Hence, $F_1 F_2 = e^{-I_1-I_2} \frac{1}{(\beta^r g(\beta))^2} (1+o_\infty(\beta))$.

The main difference with the previous case is that writing Equality (26):

$$\nu_\beta(O_1) = \frac{F_1 e^{-2\mathcal{P}(\beta)-\alpha} (1+o_\infty(\beta))}{1 - e^{-2\mathcal{P}(\beta)} F_1 F_2 (1+o_\infty(\beta))},$$

the numerator does not necessarily goes to 0. Namely it behaves like⁵ $e^{-I_1} \frac{1}{\beta^r g(\beta)}$.

Nevertheless, Lemma 19 still holds. Indeed, Equality (28) has just to be replaced by

$$1 = \frac{e^{-I_1} \frac{1}{L}}{p^2 - e^{-I_1} \frac{1}{L} \max(1, e^{-I_2} \frac{1}{L})}.$$

Again, the function $x \mapsto e^{-I_1} x (1 + \max(1, e^{-I_2} x))$ is increasing and there is a unique value for which the function is equal to p^2 .

Now, copying what is done above we get

$$\begin{aligned}
\frac{\mu_\beta(O_1)}{\mu_\beta(O_2)} &= \frac{\tau_1}{(1+F_1)^2} \frac{1+F_1}{\tau_2} (1+F_2) e^{I_2-I_1} e^{(\alpha_{p+1}-\alpha_1)\frac{\theta}{1-\theta}\beta} (1+o_\infty(\beta)) \\
&= \frac{e^{I_2-I_1}}{(1+F_1)^2} e^{(\alpha_{p+1}-\alpha_1)\frac{\theta}{1-\theta}\beta} (1+o_\infty(\beta)) \\
&= e^{I_2-I_1} e^{2I_1} (\beta^r g(\beta))^2 e^{(\alpha_{p+1}-\alpha_1)\frac{\theta}{1-\theta}\beta} e^{2(\alpha_1\frac{\theta}{1-\theta}-\gamma)\beta} (1+o_\infty(\beta)) \\
&= e^{I_2+I_1} L^2 (1+o_\infty(\beta)).
\end{aligned}$$

We set

$$(30) \quad \rho_{3 \cap 4}^2 := e^{I_1+I_2} L^2.$$

⁵note that $\gamma = \alpha_1 \frac{\theta}{1-\theta} + \alpha$ and F_1 behaves like $e^{-I_1} \frac{1}{\beta^r g(\beta)} e^{(\gamma-\alpha_1\frac{\theta}{1-\theta})\beta}$.

This concludes the proof of Theorem 2.

6. CONVERGENCE TO THE SUBACTION- PROOF OF COROLLARY 3

In the proof of Proposition 5 we showed that only two basic loops can have a maximal weight (which value is γ). These two loops are $1 \rightarrow 1$ or $1 \rightarrow 2 \rightarrow 1$. Following the Max-Plus formalism (see [6]), in both cases there is a unique *maximal strongly connected subgraph* (m.s.c.s. in abridge way) which is either $1 \rightarrow 1$ or $1 \rightarrow 2 \rightarrow 1$.

Now, Theorem 3.101 in [6] shows that, in both cases, there is a unique eigenvector for M , up to an additive constant (added to all the coordinates), which is given by the first column of the associated matrix $M^+ := e \oplus M \oplus M^2 \dots$ (where \oplus is the sum for the Max-plus formalism, and M^n is computed for the product of the Max-Plus formalisms).

In other word, there is a unique calibrated subaction up to an additive constant. Consequently, a subaction is entirely determined by its value on one of any Σ_j 's.

Now, we have:

Lemma 20. *For every x in S_1 , $\lim_{\beta \rightarrow +\infty} \frac{1}{\beta} \log H_\beta(x) = 0$.*

Proof. The proof is done by contradiction. Assume that $\delta \neq 0$ is an accumulation point for $\frac{1}{\beta} \log H_\beta(x)$ (for x in Σ_1). Let consider any accumulation point V such that $V(x) = \delta$ (this is always possible up to consider a subsequence of β 's).

Then, V is Hölder continuous (all the $\frac{1}{\beta} \log H_\beta$ are equip-continuous with a upper bounded Hölder norm), and $|V| > \frac{\delta}{2}$ on some neighborhood of x . Let us consider some cylinder C in Σ_1 , such that for every $x' \in C$, $|V(x') - V(x)| < \frac{\delta}{2}$.

By Theorem 2, $\mu_\beta(C')$ converges to a positive value as β goes to $+\infty$ (each cylinder in Σ_1 has positive $\mu_{top,1}$ -measure). Similarly, by Theorem 1, $\nu_\beta(C')$ converges to a positive value as β goes to $+\infty$. Now,

$$d\mu_\beta = H_\beta d\nu_\beta,$$

which yields that $\mu_\beta(C')$ is of order $\nu_\beta(C')e^{\beta\frac{\delta}{2}}$ as β goes to $+\infty$. Convergence of $\nu_\beta(C')$ and $\mu_\beta(C')$ and $\delta \neq 0$ yield a contradiction. \square

Lemma 20 shows that any accumulation point for $\frac{1}{\beta} \log H_\beta$ is the unique subaction whose value is 0 on Σ_1 , thus it converges.
