# Topological aspects of generalized Harper operators

#### Abstract

A generalized version of the TKNN-equations computing Hall conductances for generalized Dirac-like Harper operators is derived. Geometrically these equations relate Chern numbers of suitable (dual) bundles naturally associated to spectral projections of the operators.

## GENERALIZED HARPER OPERATORS

The integer quantum Hall effect (IQHE) reveals a variety of surprising and attractive physical features, and has been the subject of several investigations (see [17, 13] and references therein). In fact, a complete spectral analysis of the Schrödinger operator for a single particle moving in a plane in a periodic potential and subject to an uniform orthogonal magnetic field of strength $B$ (magnetic Bloch electron) is extremely difficult. Thus the need for simpler effective models which hopefully capture (some of) the main physical features in suitable physical regimes.

In the limit of a strong magnetic field, $B \gg 1$, the IQHE is well described by an effective Harper operator (cf. [23, 2, 15, 12]). For this model the quantization (in units of $\left.e^{2} / h\right)$ of the Hall conductance has a geometric meaning being related to Chern numbers of suitable naturally bundles associated to spectral projections of the operator. A family of Diophantine equations, the TKNN-equations of [22], provides a recipe for computing such integers. The aim of the present paper is to derive a generalized version of the TKNN-equations yielding the Hall conductances for more general Dirac-like Harper operators. Interest in such generalizations comes also from these Dirac-like operators appearing naturally in important physical models, notably models for the graphene.

With $\theta=1 / B$, the effective Harper operator is

$$
\begin{equation*}
\left(H_{1,0}^{\theta} \psi\right)(x)=\psi(x-\theta)+\psi(x+\theta)+2 \cos (2 \pi x) \psi(x), \tag{1}
\end{equation*}
$$

acting on the Hilbert space $\mathscr{H}_{1}=L^{2}(\mathbb{R})$. That this operator is the simplest representative of a large family of generalized Harper operators, sharing similar mathematical properties, is our starting point. On the Hilbert space $\mathscr{H}_{1}$ consider the unitary operators

\begin{equation*}
\left(T_{1} \psi\right)(x)=\mathrm{e}^{\mathrm{i} 2 \pi x} \psi(x), \quad\left(T_{2}^{\theta} \psi\right)(x)=\psi(x-\theta) \tag{2}
\end{equation*}
$$

with $\theta \in \mathbb{R}$. They are readily seen to obey the relation

$$
\begin{equation*}
T_{1} T_{2}^{\theta}=\mathrm{e}^{\mathrm{i} 2 \pi \theta} T_{2}^{\theta} T_{1}, \tag{3}
\end{equation*}
$$

yielding for the Harper operator the expression $H_{1,0}^{\theta}=T_{1}+\left(T_{1}\right)^{\dagger}+T_{2}^{\theta}+\left(T_{2}^{\theta}\right)^{\dagger}$.
For any positive integer $q=1,2, \ldots$, on the vector space $\mathbb{C}^{q}$ consider two unitary $q \times q$ matrices $\mathbb{U}_{q}$ and $\mathbb{V}_{q}$ defined as follows. Let $\left\{e_{0}, \ldots, e_{q-1}\right\}$ be the canonical basis of $\mathbb{C}^{q}$, then $\mathbb{U}_{q}$ is a diagonal matrix and $\mathbb{V}_{q}$ is a shift matrix acting as

$$
\mathbb{U}_{q}: e_{j} \mapsto \mathrm{e}^{\mathrm{i} 2 \pi \frac{j}{q}} e_{j}, \quad \text { and } \quad \mathbb{V}_{q}: e_{j} \mapsto e_{[j+1]_{q}},
$$

where $[\cdot]_{q}$ stays for modulo $q$. They obey

$$
\mathbb{U}_{q} \mathbb{V}_{q}=\mathrm{e}^{\mathrm{i} 2 \pi \frac{1}{q}} \mathbb{V}_{q} \mathbb{U}_{q} \quad \text { and } \quad\left(\mathbb{U}_{\mathrm{q}}\right)^{\mathrm{q}}=\mathbb{I}_{\mathrm{q}}=\left(\mathbb{V}_{\mathrm{q}}\right)^{\mathrm{q}}
$$

Then, on the Hilbert space $\mathscr{H}_{q}=L^{2}(\mathbb{R}) \otimes \mathbb{C}^{q}$ one defines a pair of unitary operators:

$$
\begin{equation*}
U_{q}=T_{1} \otimes \mathbb{U}_{q}, \quad V_{q, r}^{\theta}=T_{2}^{\varepsilon} \otimes\left(\mathbb{V}_{q}\right)^{r} \tag{4}
\end{equation*}
$$

with $\varepsilon(\theta, q, r)=\theta-\frac{r}{q}$ and $T_{1}$ and $T_{2}^{\varepsilon}$ given by (2). The integer $r \in\{0, \pm 1, \ldots, \pm(q-1)\}$ is chosen coprime with respect to $q$. As for the case before (when $q=1, r=0$ ), the operators (4) also obey the relation (3):

$$
U_{q} V_{q, r}^{\theta}=\mathrm{e}^{\mathrm{i} 2 \pi \theta} V_{q, r}^{\theta} U_{q}
$$

Following the definition (1) we can introduce the generalized ( $q, r$ )-Harper operator

$$
\begin{equation*}
H_{q, r}^{\theta}=U_{q}+\left(U_{q}\right)^{\dagger}+V_{q, r}^{\theta}+\left(V_{q, r}^{\theta}\right)^{\dagger} . \tag{5}
\end{equation*}
$$

More generally one considers the collection $\mathscr{A}_{q, r}^{\theta}$ of bounded operators on the Hilbert space $\mathscr{H}_{q}$ generated by the unitaries $U_{q}$ and $V_{q, r}^{\theta}$. Technically $\mathscr{A}_{q, r}^{\theta}$ is a $C^{*}$-algebra, i.e. an involutive algebra closed with respect to the operator norm, and it is named the (ir)rational rotation algebra or the noncommutative torus algebra $[19,8]$.

By writing the operator in (1) as $H_{1,0}^{\theta}=D_{\theta}+C$ with

$$
\begin{equation*}
\left(D_{\theta} \psi\right)(x)=\psi(x-\theta)+\psi(x+\theta), \quad(C \psi)(x)=2 \cos (2 \pi x) \psi(x) \tag{6}
\end{equation*}
$$

in particular, the generalized $(2,1)$-Harper operator $H_{2,1}^{\theta}$ is just

$$
H_{2,1}^{\theta}=\left(\begin{array}{cc}
C & D_{\theta-\frac{1}{2}}  \tag{7}\\
D_{\theta-\frac{1}{2}} & -C
\end{array}\right)
$$

acting on $\mathscr{H}_{2}=L^{2}(\mathbb{R}) \otimes \mathbb{C}^{2}$. This operator provides an interesting effective model for the IQHE on graphene [3,14, 21]. Moreover, Dirac-like operators like $H_{2,1}^{\theta}$ can be used to describe effective models for electrons interacting with the periodic structure of a crystal through a periodic (internal) magnetic field and subjected to the action of an external strong magnetic field [9, 12].

## BLOCH-FLOQUET TRANSFORM

For rational deformation parameter, $\theta=M / N$ ( $M$ and $N$ taken to be coprime here and after), any family of operators $\mathscr{A}_{q, r}^{\theta}$ can be decomposed in a continuous way according to a generalized version of the Bloch theorem. More explicitly we have the following.

Proposition A. Let $\theta=M / N$. For any (admissible) pair $(q, r)$ the bounded operator algebra $\mathscr{A}_{q, r}^{\theta}$ on $\mathscr{H}_{q}$ admits a bundle representation $\Pi_{q, r}$ over the ordinary two-torus $\mathbb{T}^{2}$. That is to say, there is a Hermitian vector bundle $E_{N, q} \rightarrow \mathbb{T}^{2}$ together with a unitary transform $\mathscr{F}_{q, r}: \mathscr{H}_{q} \rightarrow L^{2}\left(E_{N, q}\right)$ such that

$$
\begin{equation*}
\Pi_{q, r}\left(\mathscr{A}_{q, r}^{\theta}\right)=\mathscr{F}_{q, r} \mathscr{A}_{q, r}^{\theta} \mathscr{F}_{q, r}^{-1} \subset \Gamma\left(\operatorname{End}\left(E_{N, q}\right)\right) . \tag{8}
\end{equation*}
$$

The vector bundle $E_{N, q}$ has rank $N$ and (first) Chern number $C_{1}\left(E_{N, q}\right)=q$.
Here $L^{2}\left(E_{N, q}\right)$ denotes the Hilbert space of square integrable sections of the vector bundle $E_{N, q}$ and $\Gamma\left(\operatorname{End}\left(E_{N, q}\right)\right)$ denotes the collection of continuous sections of the endomorphism bundle $\operatorname{End}\left(E_{N, q}\right) \rightarrow \mathbb{T}^{2}$, i.e. the vector bundle with fibers $\operatorname{End}\left(\mathbb{C}^{q}\right)$ associated with the vector bundle $E_{N, q}$. The unitary map $\mathscr{F}_{q, r}$ implementing the bundle representation of $\mathscr{A}_{q, r}^{\theta}$ is called (generalized) Bloch-Floquet transform [9, 11]. For the details of the proof of Prop. A, that we briefly sketch, we refer to [10] (see also [20]). Denote with $\alpha \in \mathbb{Z},|\alpha|<q$ the unique solution of $\beta q-\alpha r=1$ (due to $q$ and $r$ being coprime) and be $M_{0}=q M-r N$. Then, a simple check shows that the unitary operators

A_{q, r}^{\theta}=\left(T_{1}\right)^{\frac{1}{\varepsilon \varepsilon}} \otimes\left(\mathbb{U}_{q}\right)^{\alpha}, \quad B_{q, r}^{\theta}=T_{2}^{\frac{M_{0}}{q}} \otimes\left(\mathbb{V}_{q}\right)^{r N}
$$

commute, $\left[A_{q, r}^{\theta}, B_{q, r}^{\theta}\right]=0$, while commuting with any element in $\mathscr{A}_{q, r}^{\theta}$. They generate a (indeed maximally) commutative sub-algebra of the commutant of $\mathscr{A}_{q, r}^{\theta}$, and in particular, of symmetries for the operator (5). Were $N$ a multiple of $q$ this commutative subalgebra would reduce to a direct sum of $q$ copies of a commutative algebra on $L^{2}(\mathbb{R})$. Thus to avoid this degeneracy, we take $q$ and $N$ to be coprime as well. This entails there exist two integers $d_{r}$ and $n_{r}$ such that $q d_{r}+N n_{r}=1$, a fact we shall exploit momentarily. Moreover, the commutative algebra generated by $A_{q, r}^{\theta}$ and $B_{q, r}^{\theta}$ is isomorphic to the algebra of continuos functions over the ordinary 2 -torus $\mathbb{T}^{2}$.

A generalized simultaneous eigenvectors of $A_{q, r}^{\theta}$ and $B_{q, r}^{\theta}$ is a $\Xi_{k} \in S^{\prime}(\mathbb{R}) \otimes \mathbb{C}^{q}\left(S^{\prime}(\mathbb{R})\right.$ is the space of tempered distributions) such that

$$
A_{q, r}^{\theta} \Xi_{k}=\mathrm{e}^{\mathrm{i} 2 \pi k_{1}} \Xi_{k}, \quad B_{q, r}^{\theta} \Xi_{k}=\mathrm{e}^{\mathrm{i} 2 \pi k_{2}} \Xi_{k} .
$$

For any $k=\left(k_{1}, k_{2}\right) \in[0,1]^{2} \simeq \mathbb{T}^{2}$, the generalized eigenvectors make up a $N$ dimensional space, a basis of which being given by a fundamental family of distribution $\Upsilon^{(j)}(k)=\left(\zeta_{0}^{(j)}(k), \ldots, \zeta_{q-1}^{(j)}(k)\right) \in S^{\prime}(\mathbb{R}) \otimes \mathbb{C}^{q}$, for indices $j=0, \ldots, N-1$, with elements $\zeta_{\ell}^{(j)}(k), \ell=0, \ldots, q-1$, defined by

$$
\begin{equation*}
\zeta_{\ell}^{(j)}(k)=\sqrt{\frac{\left|M_{0}\right|}{N}} \sum_{m \in \mathbb{Z}} \mathrm{e}^{-\mathrm{i} 2 \pi k_{1}\left(\tau_{\ell}+m q\right)} \delta\left[\cdot-\frac{M_{0}}{N}\left(k_{2}+j\right)-m M_{0}-\tau_{\ell} \frac{M_{0}}{q}\right] . \tag{9}
\end{equation*}
$$

Here the permutation $\tau: \ell \mapsto \tau_{\ell}$ of the set $\{0, \ldots, q-1\}$ is defined by $\ell=\left[\tau_{\ell} r N\right]_{q}$ and, as usual, the Dirac delta function $\delta\left(\cdot-x_{0}\right)$ acts on functions $f: \mathbb{R} \rightarrow \mathbb{C}$ as the evaluation at the point $x_{0}$, i.e. $\left\langle\boldsymbol{\delta}\left(\cdot-x_{0}\right) ; f\right\rangle=f\left(x_{0}\right)$.

We let $\mathscr{H}_{q, r}(k) \subset S^{\prime}(\mathbb{R}) \otimes \mathbb{C}^{q}$ denote the $N$-dimensional vector space spanned by the distributions $\Upsilon^{(0)}(k), \ldots, \Upsilon^{(N-1)}(k)$. The total space of the vector bundle $E_{N, q}$ is just the disjoint union of the spaces $\mathscr{H}_{q, r}(k)$ glued together with transitionf functions coming from pseudo-periodic conditions satisfied by the $\Upsilon^{(j)}$ 's. Indeed, from (9) one deduces that $\Upsilon^{(j)}\left(k_{1}+1, k_{2}\right)=\Upsilon^{(j)}\left(k_{1}, k_{2}\right)$ while $\Upsilon^{(j)}\left(k_{1}, k_{2}+1\right)=\Upsilon^{(j+1)}\left(k_{1}, k_{2}\right)$ for $j=0, \ldots, N-2$ and $\Upsilon^{(N-1)}\left(k_{1}, k_{2}+1\right)=\mathrm{e}^{\mathrm{i} 2 \pi q} \Upsilon^{(0)}\left(k_{1}, k_{2}\right)$. Also, there is an identification

$$
\mathscr{F}_{q, r}: \mathscr{H}_{q} \rightarrow L^{2}\left(E_{N, q}\right) \simeq \int_{\mathbb{T}^{2}}^{\oplus} \mathscr{H}_{q, r}(k) \mathrm{d} z(k)
$$

which is very reminiscent of the usual direct integral decomposition of the Bloch theory. We stress that Prop. A does not only states that any $H \in \mathscr{A}_{q, r}^{\theta}$ can be decomposed as a direct integral operator $H=\int_{\mathbb{T}^{2}}^{\oplus} h(k) \mathrm{d} z(k)$ with $h(k)$ an $N \times N$ matrix acting on $\mathscr{H}_{q, r}(k)$, but also that such a decomposition is continuous with respect to the topology of the vector bundle $E_{N, q}$, thus amounting to a bundle representation. For $H \in \mathscr{A}_{q, r}^{\theta}$, we denote $\widetilde{H}=\Pi_{q, r}(H)$. For the generators, when acting on the basis $\left\{\Upsilon^{(j)}(k)\right\}$ one finds

$$
\begin{equation*}
\widetilde{U}_{q}\left(k_{1}, k_{2}\right)=\mathrm{e}^{\mathrm{i} 2 \pi \frac{M_{0}}{N} k_{2}}\left(\mathbb{U}_{N}\right)^{q M}, \quad \widetilde{V}_{q, r}^{\theta}\left(k_{1}, k_{2}\right)=\mathrm{e}^{\mathrm{i} 2 \pi n_{r} k_{1}}\left(\mathbb{V}_{N ; k_{1}}\right)^{d_{r}} . \tag{10}
\end{equation*}
$$

Here $\mathbb{U}_{N}$ is the diagonal matrix $\mathbb{U}_{N}: e_{j} \mapsto \mathrm{e}^{\mathrm{i} 2 \pi \frac{j}{N}} e_{j} ; \mathbb{V}_{N ; k_{1}}$ is the twisted shift matrix sending $e_{j}$ to $e_{j+1}$ for $j=0, \ldots, N-2$ while $e_{N-1}$ to $\mathrm{e}^{\mathrm{i} 2 \pi q k_{1}} e_{0}$. The matrices in (10) commute up to $\mathrm{e}^{\mathrm{i} 2 \pi \frac{M}{N} q d_{r}}=\mathrm{e}^{\mathrm{i} 2 \pi \frac{M}{N}}$ being $q d_{r}=1-n_{r} N$ as before, $\widetilde{U}_{q} \widetilde{V}_{q, r}^{\theta}=\mathrm{e}^{\mathrm{i} 2 \pi \frac{M}{N}} \widetilde{V}_{q, r}^{\theta} \widetilde{U}_{q}$, thus providing a representation of $\mathscr{A}_{q, r}^{\theta}$. Moreover, their pseudo-periodic conditions

$$
\widetilde{U}_{q}\left(k_{1}+1, k_{2}+1\right)=\mathrm{e}^{\mathrm{i} 2 \pi \frac{M}{N}} \widetilde{U}_{q}\left(k_{1}, k_{2}\right), \quad \widetilde{V}_{q, r}^{\theta}\left(k_{1}+1, k_{2}+1\right)=\widetilde{V}_{q, r}^{\theta}\left(k_{1}, k_{2}\right),
$$

match those of the basis $\left\{\Upsilon^{(j)}(k)\right\}$ thus making $\Pi_{q, r}$ a representation of $\mathscr{A}_{q, r}^{\theta}$ as bundle endomorphisms, as expressed in (8).

The bundle $E_{N, q}$ comes equipped with the Berry connection

$$
\begin{equation*}
\omega_{i, j}(k)=\left\langle\Upsilon^{i}(k) \mid \mathrm{d} \Upsilon^{j}(k)\right\rangle, \quad i, j=0, \ldots, N-1, \tag{11}
\end{equation*}
$$

Its curvature $K=\mathrm{d} \omega$ is constant, $K(k)=\left(\frac{2 \pi q}{\mathrm{i} N} \mathbb{I}_{N}\right) \mathrm{d} k_{1} \wedge \mathrm{~d} k_{2}$ (up to an exact form) and when integrated it results in the first Chern number of the bundle being

$$
C_{1}\left(E_{N, q}\right)=\frac{\mathrm{i}}{2 \pi} \int_{\mathbb{T}^{2}} \operatorname{Tr}_{N}(K)=q
$$

## GENERALIZED TKNN-EQUATIONS

For a rational $\theta=M / N$, the spectrum of $H_{q, r}^{\theta}$ in (5) has $N+1$ energy bands if $N$ is odd or $N$ energy bands if $N$ is even $[16,6,10]$. These include the inf-gap (from $-\infty$ to the minimum of the spectrum) and the sup-gap (from the maximum of the spectrum to $+\infty$ ).

To each gap $g$ one associates a spectral projection $P_{g}$ with the convention that $P_{0}=0$ for the inf-gap $g=0$ and $P_{\max }=\mathbb{I}$ for the sup-gap $g=N_{\max }$ with $N_{\max }=N-1$ or $N_{\max }=N$ according to whether $N$ is odd or even. As usual, the projection $P_{g}$ is defined via the Riesz formula for the operator $H_{q, r}^{\theta}$,

$$
\begin{equation*}
P_{g}=\frac{1}{\mathrm{i} 2 \pi} \oint_{\Lambda}\left(\lambda \mathrm{I}-H_{q, r}^{\theta}\right)^{-1} \mathrm{~d} \lambda \tag{12}
\end{equation*}
$$

The closed rectifiable path $\Lambda \subset \mathbb{C}$ encloses the spectral subset $I_{g}=\left[\varepsilon_{0}, \varepsilon_{g}\right] \cap \sigma\left(H_{q, r}^{\theta}\right)$ (intersecting the real axis in $\varepsilon_{0}$ and $\varepsilon_{g}$ ) with the real numbers $\varepsilon_{0}, \varepsilon_{g} \in \mathbb{R} \backslash \sigma\left(H_{q, r}^{\theta}\right)$ being such that $-\infty<\varepsilon_{0}<\min \sigma\left(\mathrm{H}_{\mathrm{q}, \mathrm{r}}^{\theta}\right)$ and $\varepsilon_{g}$ in the gap $g$.

The Hall conductance associated with the energy spectrum up to the gap $g$ is related to the projection $P_{g}$ via the Kubo formula (linear response theory). Its value is an integer number $t_{g}$; it is by now well known that $t_{g}$ is to be thought of as the Chern number of a bundle determined by the projection $P_{g}[22,4,1]$.

Any such a spectral projection $P_{g}$ yields a projection $\Pi_{q, r}\left(P_{g}\right) \in \Gamma\left(\operatorname{End}\left(E_{N, q}\right)\right)$, via the representation $\Pi_{q, r}$ in (8), and thus a vector subbundle $L_{q, r}\left(P_{g}\right) \subset E_{N, q}$. The related (first) Chern number $C_{1}\left(L_{q, r}\left(P_{g}\right)\right)$ measures the degree of non triviality of the bundle $L_{q, r}\left(P_{g}\right)$. The geometric interpretation of the Hall conductance is none other than the equality $t_{g}=C_{1}\left(L_{q, r}\left(P_{g}\right)\right)$. On the other hand, the Chern number $C_{1}\left(L_{q, r}\left(P_{g}\right)\right)$ obeys a Diophantine equation which then provides a TKNN-type equation for the conductance $t_{g}$. We have the following.

Proposition B. For any projection P in the algebra $\mathscr{A}_{q, r}^{\theta}$ there exists a "dual" vector bundle $L_{\mathrm{ref}}(P) \rightarrow \mathrm{T}^{2}$ s.t. the following duality between Chern numbers holds:

\begin{equation*}
C_{1}\left(L_{q, r}(P)\right)=q\left[\frac{1}{N} \operatorname{Rk}\left(L_{\mathrm{ref}}(P)\right)+\left(\frac{M}{N}-\frac{r}{q}\right) C_{1}\left(L_{\mathrm{ref}}(P)\right)\right] . \tag{13}
\end{equation*}
$$

Before we sketch the proof of this result we turn to its interpretation in terms of conductances of the generalized Harper operators in (5). As mentioned, if $P_{g}$ is its spectral projection up to the gap $g$, the associated Hall conductance $t_{g}$ is the number $C_{1}\left(L_{q, r}\left(P_{g}\right)\right)$. For the dual number we have $C_{1}\left(L_{\text {ref }}\left(P_{g}\right)\right)=-s_{g}$, with $s_{g}$ identified with the Hall conductance of the energy spectrum up to the gap $g$ but in the opposite limit of a weak magnetic field ( $B \ll 1$ ) [22, 1, 9]. Writing $d_{g}=\operatorname{Rk}\left(L_{\text {ref }}\left(P_{g}\right)\right)$, relation (13) translates to the generalized TKNN-equations

$$
\begin{equation*}
N t_{g}+(q M-r N) s_{g}=q d_{g}, \quad g=0, \ldots, N_{\max } . \tag{14}
\end{equation*}
$$

When $q=1$ and $r=0$, the above reduces to

$$
\begin{equation*}
N t_{g}+M s_{g}=d_{g}, \quad g=0, \ldots, N_{\max } \tag{15}
\end{equation*}
$$

which is the original TKNN-equation derived in [22] for the Harper operator (1). In its spirit then, the integer $d_{g}$ in the right-hand side coincides with the labeling of the gap when $N$ is odd, i.e. $d_{g}=g$ for $N$ odd. When $N$ is even $d_{g}=g$ if $0 \leqslant g \leqslant N / 2-1$ and $d_{g}=g+1$ if $N / 2 \leqslant g \leqslant N_{\max }=N-1$. We remark that the bound

$$
\begin{equation*}
2\left|s_{g}\right|<N \tag{16}
\end{equation*}
$$

(already present in [22]) still holds, owing to the bound $2\left|C_{1}\left(L_{\text {ref }}\left(P_{g}\right)\right)\right|<N$ for the spectral projections into the gaps of the Hofstadter operator [6].

Now, the subbundle $L_{q, r}(P) \subset E_{N, q}$ determined by the projection valued section $\Pi_{q, r}(P)=P(\cdot)$, for a projection $P \in \mathscr{A}_{q, r}^{\theta}$, will have as fiber over $k \in \mathbb{T}^{2}$ the space

$$
\begin{equation*}
\left.L_{q, r}(P)\right|_{k}=\operatorname{Range}(P(k)) \subset \mathscr{H}_{q, r}(k) . \tag{17}
\end{equation*}
$$

We need a dual bundle representation, $\Pi_{q, r}^{\mathrm{ref}}$ of $\mathscr{A}_{q, r}^{\theta}$, s.t.

$$
\begin{equation*}
P\left(k_{1}, N k_{2}\right)=P^{\mathrm{ref}}\left(k_{1}, M_{0} k_{2}\right), \tag{18}
\end{equation*}
$$

and $P^{\mathrm{ref}}(\cdot)=\Pi_{q, r}^{\mathrm{ref}}(P)$. We are lead to the representation

$$
\begin{equation*}
U_{q}^{\mathrm{ref}}(k)=\mathrm{e}^{\mathrm{i} 2 \pi k_{2}}\left(\mathbb{U}_{N}\right)^{q M}, \quad V_{q, r}^{\mathrm{ref}}(k)=V_{q, r}^{\theta}(k)=\mathrm{e}^{\mathrm{i} 2 \pi n_{r} k_{1}}\left(\mathbb{V}_{N ; k_{1}}\right)^{d_{r}} . \tag{19}
\end{equation*}
$$

which obey $U_{q}^{\mathrm{ref}}(\cdot) V_{q, r}^{\mathrm{ref}}(\cdot)=\mathrm{e}^{\mathrm{i} 2 \pi \frac{M}{N}} V_{q, r}^{\mathrm{ref}}(\cdot) U_{q}^{\mathrm{ref}}(\cdot)$. As elements in $C\left(\mathbb{T}^{2}\right) \otimes \operatorname{Mat}_{\mathrm{N}}(\mathbb{C}) \simeq$ $\mathrm{C}\left(\mathbb{T}^{2} ; \operatorname{Mat}_{\mathrm{N}}(\mathbb{C})\right)$ they yield a representation of $\mathscr{A}_{q, r}^{\theta}$ as endomorphisms of the the trivial bundle $\mathbb{T}^{2} \times \mathbb{C}^{N} \rightarrow \mathbb{T}^{2}$. Then, any projection $P$ in $\mathscr{A}_{q, r}^{\theta}$ is mapped to a projection-valued section $P^{\mathrm{ref}}(\cdot)=\Pi_{q, r}^{\mathrm{ref}}(p)$ which defines a vector subbundle $L_{\mathrm{ref}}(p) \rightarrow \mathbb{T}^{2}$ of the trivial vector bundle $\mathbb{T}^{2} \times \mathbb{C}^{N}$. It will have as fiber over $k \in \mathbb{T}^{2}$ the space

$$
\begin{equation*}
\left.L_{\mathrm{ref}}(P)\right|_{k}=\operatorname{Range}\left(P^{\mathrm{ref}}(k)\right) \subset \mathbb{C}^{N} \tag{20}
\end{equation*}
$$

Then, equation (18) say that the vector bundle $L_{q, r}(P)$ "winded" around $N$ times in the second direction is (locally) isomorphic to the vector bundle $L_{\mathrm{ref}}(P)$ "winded" around $M_{0}$ times in the same direction. There is however an extra twist, due to the bundle $E_{N, q}$, of which $L_{q, r}(P)$ is a subbundle, being not trivial. Indeed, an analysis of the transition functions lead to the bundle isomorphism

$$
\begin{equation*}
\varphi_{(1, N)}^{*} L_{q, r}(P) \simeq \varphi_{\left(1, M_{0}\right)}^{*} L_{\mathrm{ref}}(P) \otimes \operatorname{det}\left(E_{N, q}\right) . \tag{21}
\end{equation*}
$$

Here $\operatorname{det}\left(E_{N, q}\right) \rightarrow \mathbb{T}^{2}$ is the determinant line bundle and the extra operation $\varphi_{(1, N)}^{*}$ (the pullback) stays for the extra winding by $N$ (for the bundle $L_{q, r}(P)$ ) and the same for $\varphi_{\left(1, M_{0}\right)}^{*}$ (for the bundle $L_{\mathrm{ref}}(P)$ ). Formula (13) is the relation among corresponding first Chern numbers. Using the fact that $C_{1}\left(\varphi_{(1, N)}^{*} L_{q, r}(P)\right)=N C_{1}\left(L_{q, r}(P)\right)$ and $C_{1}\left(\varphi_{\left(1, M_{0}\right)}^{*} L_{\mathrm{ref}}(P)\right)=M_{0} C_{1}\left(L_{\mathrm{ref}}(P)\right)$, as well as the identity $C_{1}\left(\operatorname{det}\left(E_{N, q}\right)\right)=C_{1}\left(E_{N, q}\right)=$ $q$, the relation (13) follows from (21) by standard arguments.

## THE IRRATIONAL CASE

On the algebra $\mathscr{A}_{q, r}^{\theta}$ there is a faithful trace defined by

$$
\tau\left(\left(U_{q}\right)^{n}\left(V_{q, r}^{\theta}\right)^{m}\right)=\delta_{n, 0} \delta_{m, 0}
$$

on monomials, and extended by linearity. Derivations $\partial_{j}: \mathscr{A}_{q, r}^{\theta} \rightarrow \mathscr{A}_{q, r}^{\theta}$, for $j=1,2$, defined on monomials by

$$
\partial_{1}\left(\left(U_{q}\right)^{n}\left(V_{q, r}^{\theta}\right)^{m}\right)=\mathrm{i} 2 \pi n\left(U_{q}\right)^{n}\left(V_{q, r}^{\theta}\right)^{m}, \quad \partial_{2}\left(\left(U_{q}\right)^{n}\left(V_{q, r}^{\theta}\right)^{m}\right)=\mathrm{i} 2 \pi m\left(U_{q}\right)^{n}\left(V_{q, r}^{\theta}\right)^{m},
$$

are extended by linearity and Leibniz rule. Lastly, we need the first Connes-Chern number which, for a projection $P \in \mathscr{A}_{q, r}^{\theta}$ (in the domain of the derivations) computes the integer (an index of a Fredholm operator)

$$
\epsilon_{1}(P)=\frac{1}{\mathrm{i} 2 \pi} \tau\left(P\left(\partial_{1}(P) \partial_{2}(P)-\partial_{2}(P) \partial_{1}(P)\right)\right) .
$$

Let $H_{q, r}^{\theta} \in \mathscr{A}_{q, r}^{\theta}$ be the Hofstadter operator (5) with associated spectral projection $P_{g}^{\theta}$ for the gap $g$ as in (12). For $\theta \in I \subset \mathbb{R}$, the functional expression of $H_{q, r}^{\theta} \in \mathscr{A}_{q, r}^{\theta}$ is fixed and $H_{q, r}^{\theta}$ depends on the parameter $\theta$ only through the fundamental commutation relation which defines $\mathscr{A}_{q, r}^{\theta}$. Now, if the gap $g$ is open for all $\theta \in I$ (with $I$ sufficiently small), the functions $\theta \mapsto \epsilon_{1}\left(P_{g}^{\theta}\right)$ is constant in the interval $I$ [5]. On the other hand, from the structure of the group $K_{0}\left(\mathscr{A}_{q, r}^{\theta}\right)$, one deduces [18, 7] that

$$
\begin{equation*}
\tau\left(P_{g}^{\theta}\right)=m P_{g}^{\theta}-\theta \epsilon_{1}\left(P_{g}^{\theta}\right) \tag{22}
\end{equation*}
$$

with the integer $m(\cdot) \in \mathbb{Z}$ uniquely determined by the condition $0 \leqslant \tau(\cdot) \leqslant 1$. From (22), the integer $m(\cdot)$ is constant for $\theta \in I$. Hence, formula

$$
\begin{equation*}
C_{q, r}\left(P_{g}\right)=q\left[m\left(P_{g}\right)-\frac{r}{q} \epsilon_{1}\left(P_{g}\right)\right]=q\left[\tau\left(P_{g}\right)+\left(\theta-\frac{r}{q}\right) \epsilon_{1}\left(P_{g}\right)\right] \in \mathbb{Z} \tag{23}
\end{equation*}
$$

is well defined and extends (13) for irrational values $\theta \in I$ (for which the gap $g$ remains open). Indeed, for a rational $\theta=M / N$ one has natural identifications $\operatorname{Rk}\left(\mathrm{L}_{\mathrm{ref}}(\mathrm{P})\right)=\tau(\mathrm{P})$ and $C_{1}\left(L_{\mathrm{ref}}(P)\right)=C_{1}(p)[10]$ and for the rational torus, formula (23) is the same as (13).

We think of (23) as relating conductances for the Harper operator $H_{q, r}^{\theta}$ in (5), thus generalizing (14) to

$$
\begin{equation*}
t_{g}+(q \theta-r) s_{g}=q d_{g} \tag{24}
\end{equation*}
$$

with $P_{g}$ once again the spectral projections of the Harper operator $H_{q, r}^{\theta}$, and now identifying $t_{g}=C_{q, r}\left(P_{g}\right)$ and $s_{g}=-\epsilon_{1}\left(P_{g}\right)$ as before, whereas $d_{g}=\tau\left(P_{g}\right)$.
