Vector Addition Systems Reachability Problem (A Simpler Solution)*

Abstract. The reachability problem for Vector Addition Systems (VASs) is a central problem of net theory. The general problem is known to be decidable by algorithms based on the classical Kosaraju-Lambert-Mayr-Sacerdote-Tenney decomposition (KLMTS decomposition). Recently from this decomposition, we deduced that a final configuration is not reachable from an initial one if and only if there exists a Presburger inductive invariant that contains the initial configuration but not the final one. Since we can decide if a Preburger formula denotes an inductive invariant, we deduce from this result that there exist checkable certificates of non-reachability in the Presburger arithmetic. In particular, there exists a simple algorithm for deciding the general VAS reachability problem based on two semialgorithms. A first one that tries to prove the reachability by enumerating finite sequences of actions and a second one that tries to prove the non-reachability by enumerating Presburger formulas. In another recent paper we provided the first proof of the VAS reachability problem that is not based on the KLMST decomposition. The proof is based on the notion of production relations that directly proves the existence of Presburger inductive invariants. In this paper we propose new intermediate results that dramatically simplify this last proof.

1 Introduction

Vector Addition Systems (VASs) or equivalently Petri Nets are one of the most popular formal methods for the representation and the analysis of parallel processes [2]. Their reachability problem is central since many computational problems (even outside the realm of parallel processes) reduce to the reachability problem. Sacerdote and Tenney provided in [13] a partial proof of decidability of this problem. The proof was completed in 1981 by Mayr [11] and simplified by Kosaraju [7] from [13,11]. Ten years later [8], Lambert provided a further simplified version based on [7]. This last proof still remains difficult and the upper-bound complexity of the corresponding algorithm is just known to be non-primitive recursive. Nowadays, the exact complexity of the reachability problem for VASs is still an open-question. Even the existence of an elementary upper-bound complexity is open. In fact, the known general reachability algorithms are exclusively based on the Kosaraju-Lambert-Mayr-Sacerdote-Tenney (KLMST) decomposition.

Recently [9] we proved thanks to the KLMST decomposition that Parikh images of languages accepted by VASs are semi-pseudo-linear, a class that extends the Presburger sets. An application of this result was provided; we proved that a final configuration is

not reachable from an initial one if and only if there exists a forward inductive invariant definable in the Presburger arithmetic that contains the initial configuration but not the final one. Since we can decide if a Presburger formula denotes a forward inductive invariant, we deduce that there exist checkable certificates of non-reachability in the Presburger arithmetic. In particular, there exists a simple algorithm for deciding the general VAS reachability problem based on two semi-algorithms. A first one that tries to prove the reachability by enumerating finite sequences of actions and a second one that tries to prove the non-reachability by enumerating Presburger formulas.

In [10] we provided a new proof of the decidability of the reachability problem that does not introduce the KLMST decomposition. The proof is based on *transformer relations* and it proves that reachability sets are *almost semilinear*, a class of sets inspired by the class of semilinear sets [3] that extend the class of Presburger sets. Since the class of almost semilinear sets is strictly included in the class of semi-pseudo linear sets, this result is more precise than the one presented in [9]. This proof is based on a characterization of the conic sets definable in FO ($\mathbb{Q}, +, \leq$) thanks to topological closures with vectors spaces. Unfortunately even though this characterization is simple, its proof is rather complex. In this paper we provide a more succinct and direct proof that transformer relations are definable in FO ($\mathbb{Q}, +, \leq$). As a direct consequence topological properties on conic sets are no longer used in this new version.

Outline of the paper: Section 2 recalls the definition of *almost semilinear sets*, a class of sets inspired by the decomposition of Presburger sets into semilinear sets. Section 3 introduces definitions related to *vector addition systems*. Section 4 introduces a well-order over the runs of vector addition systems. This well-order is central in the proof and it was first introduced by Petr Jančar in another context[5]. Based on the definition of this well-order we introduce in Section 5 the notion of transformer relations and we prove that conic relations generated by transformer relations are definable in FO ($\mathbb{Q}, +, \leq$). Thanks to this result and the well-order introduced in the previous section we show in Section 6 that reachability sets of vector addition systems are almost semilinear. In Section 7 we introduce a dimension function for subsets of integer vectors. In Section 8 the almost semilinear sets are proved to be approximable by Presburger sets in a precise way based on the dimension function previously introduced. Thanks to this approximation and since reachability sets are almost semilinear we finally prove in Section 9 that the vector addition system reachability problem can be decided by inductive invariants definable in the Presburger arithmetic.

2 Almost Semilinear Sets

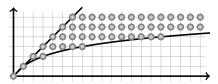
In this section we introduce the class of *almost semilinear sets*, a class of sets inspired by the geometrical characterization of the *Presburger sets* by *semilinear sets*.

We denote by $\mathbb{Z}, \mathbb{N}, \mathbb{N}_{>0}, \mathbb{Q}, \mathbb{Q}_{>0}, \mathbb{Q}_{>0}$ the set of *integers*, *natural numbers*, *positive integers*, *rational numbers*, *non negative rational numbers*, and *positive rational numbers*. Vectors and sets of vectors are denoted in bold face. The *i*th component of a vector $v \in \mathbb{Q}^d$ is denoted by v(i). Given two sets $V_1, V_2 \subseteq \mathbb{Q}^d$ we denote by $V_1 + V_2$ the set $\{v_1 + v_2 \mid (v_1, v_2) \in V_1 \times V_2\}$, and we denote by $V_1 - V_2$

the set $\{v_1 - v_2 \mid (v_1, v_2) \in V_1 \times V_2\}$. Given $T \subseteq \mathbb{Q}$ and $V \subseteq \mathbb{Q}^d$ we let $TV = \{tv \mid (t, v) \in T \times V\}$. We also denote by $v_1 + V_2$ and $V_1 + v_2$ the sets $\{v_1\} + V_2$ and $V_1 + \{v_2\}$, and we denote by tV and Tv the sets $\{t\}V$ and $T\{v\}$.

A periodic set is a subset $P \subseteq \mathbb{Z}^d$ such that $0 \in P$ and $P + P \subseteq P$. A conic set is a subset $C \subseteq \mathbb{Q}^d$ such that $0 \in C$, $C + C \subseteq C$ and $\mathbb{Q}_{\geq 0}C \subseteq C$. A periodic set P is said to be *finitely generated* if there exist vectors $p_1, \ldots, p_k \in P$ such that P = $\mathbb{N}p_1 + \cdots + \mathbb{N}p_k$. A periodic set P is said to be *asymptotically definable* if the conic set $\mathbb{Q}_{\geq 0}P$ is definable in FO ($\mathbb{Q}, +, \leq$). Observe that finitely generated periodic sets are asymptotically definable since the conic set $\mathbb{Q}_{\geq 0}P$ generated by $P = \mathbb{N}p_1 + \cdots + \mathbb{N}p_k$ is equal to $\mathbb{Q}_{\geq 0}p_1 + \cdots + \mathbb{Q}_{\geq 0}p_k$.

Example 2.1. The periodic set $P = \{p \in \mathbb{N}^2 \mid p(2) \leq p(1) \leq 2^{p(2)} - 1\}$ is depicted on the right. Observe that $\mathbb{Q}_{\geq 0}P$ is the conic set $\{\mathbf{0}\} \cup \{\mathbf{c} \in \mathbb{Q}_{\geq 0}^2 \mid \mathbf{c}(2) \leq \mathbf{c}(1)\}$ which is definable in FO $(\mathbb{Q}, +, \leq)$.



A *Presburger set* is a set $Z \subseteq \mathbb{Z}^d$ definable in FO ($\mathbb{Z}, +, \leq$). Recall that $Z \subseteq \mathbb{Z}^d$ is a Presburger set iff it is *semilinear*, i.e. a finite union of *linear sets* b + P where $b \in \mathbb{Z}^d$ and $P \subseteq \mathbb{Z}^d$ is a finitely generated periodic set [3]. The class of *almost semilinear sets* [10] is obtained from the definition of semilinear sets by weakening the finiteness condition on the considered periodic sets. More formally, an *almost semilinear set* is a finite union of sets of the form b + P where $b \in \mathbb{Z}^d$ and $P \subseteq \mathbb{Z}^d$ is an asymptotically definable periodic set.

3 Vector Addition Systems

A Vector Addition System (VAS) is given by a finite subset $\mathbf{A} \subseteq \mathbb{Z}^d$. A vector $\mathbf{a} \in \mathbf{A}$ is called an *action*. A configuration is a vector $\mathbf{c} \in \mathbb{N}^d$. A run ρ is a non-empty word $\rho = \mathbf{c}_0 \dots \mathbf{c}_k$ of configurations such that the difference $\mathbf{a}_j = \mathbf{c}_j - \mathbf{c}_{j-1}$ is in \mathbf{A} for every $j \in \{1, \dots, k\}$. In that case we say that ρ is *labeled* by $w = \mathbf{a}_1 \dots \mathbf{a}_k$, the configurations \mathbf{c}_0 and \mathbf{c}_k are respectively called the *source* and the *target* and they are denoted by $\operatorname{src}(\rho)$ and $\operatorname{tgt}(\rho)$. The *direction* of a run ρ is the pair $(\operatorname{src}(\rho), \operatorname{tgt}(\rho))$, denoted by $\operatorname{dir}(\rho)$. Given a word $w \in \mathbf{A}^*$, we introduce the binary relation $\stackrel{w}{\to}$ over the set of configurations by $\mathbf{x} \stackrel{w}{\to} \mathbf{y}$ if there exists a run ρ from \mathbf{x} to \mathbf{y} labeled by w. Observe that in this case ρ is unique. The *displacement* of a word $w = \mathbf{a}_1 \dots \mathbf{a}_k$ of actions $\mathbf{a}_j \in \mathbf{A}$ is the vector $\Delta(w) = \sum_{j=1}^k \mathbf{a}_j$. Note that $\mathbf{x} \stackrel{w}{\to} \mathbf{y}$ implies $\mathbf{x} + \Delta(w) = \mathbf{y}$ but the converse is not true in general. The *reachability relation* is the relation $\stackrel{*}{\to}$ over \mathbb{N}^d defined by $\mathbf{x} \stackrel{*}{\to} \mathbf{y}$ if there exists a run from \mathbf{x} to \mathbf{y} .

The set of configurations forward reachable from a configuration $x \in \mathbb{N}^d$ is the set $\{c \in \mathbb{N}^d \mid x \xrightarrow{*} c\}$ denoted by $\text{post}^*(x)$. Symmetrically the set of configurations backward reachable from a configuration $y \in \mathbb{N}^d$ is the set $\{c \in \mathbb{N}^d \mid c \xrightarrow{*} y\}$ denoted by $\text{pre}^*(y)$. These definitions are extended over sets of configurations $X, Y \subseteq \mathbb{N}^d$ by

 $post^*(X) = \bigcup_{x \in X} post^*(x)$ and $pre^*(Y) = \bigcup_{y \in Y} post^*(y)$. A set $X \subseteq \mathbb{N}^d$ is said to be a *forward inductive invariant* if $X = post^*(X)$. Symmetrically a set $Y \subseteq \mathbb{N}^d$ is said to be a *backward inductive invariant* if $Y = pre^*(Y)$.

In this paper we prove that for every $x, y \in \mathbb{N}^d$ such that there does not exist a run from x to y, then there exists a pair (X, Y) of disjoint Presburger sets $X, Y \subseteq \mathbb{N}^d$ such that X is a forward inductive invariant that contains x and Y is a backward inductive invariant that contains y. This result will provide directly the following theorem.

Theorem 3.1. The reachability problem for vector addition systems is decidable.

Proof. Let $x, y \in \mathbb{N}^d$ be two configurations. Let us consider an algorithm that enumerates in parallel the runs ρ and the pairs (X, Y) of disjoint Presburger sets $X, Y \subseteq$ $set N^d$ thanks to formulas in the Presburger arithmetic FO ($\mathbb{Z}, +, \leq$). If the algorithm encounters a run from x to y then it returns "reachable" and if X is a forward inductive invariant that contains x and Y is a backward inductive invariant that contains ythen it returns "unreachable". This last condition can be effectively decided as follows. Note that a set $X \subseteq \mathbb{N}^d$ is a forward inductive invariant iff the set $\mathbb{N}^d \cap (X + A) \setminus X$ denoted by \tilde{X} is empty, and a set $Y \subseteq \mathbb{N}^d$ is a backward inductive invariant iff the set $\mathbb{N}^d \cap (Y - A) \setminus Y$ denoted by \tilde{Y} is empty. Moreover, from Presburger formulas denoting X and Y we compute in linear time formulas denoting the sets \hat{X} and \hat{Y} . Hence deciding that X is a forward inductive invariant that contains x and Y is a backward inductive invariant that contains y reduces to the satisfiability of formulas in the Presburger arithmetic. Since this logic is decidable, we deduce a way for implementing the last condition of our algorithm. Note that this algorithm is correct. Moreover, it terminates thanks to the main result proved in this paper.

Remark 3.2. The set $post^*(x)$ is a forward inductive invariant that contains x and $pre^*(y)$ is a backward inductive invariant that contains y. Moreover, if there does not exist a run from x to y then these two reachability sets are disjoint. However in general reachability sets are not definable in the Presburger arithmetic [4].

4 Well-Order Over The Runs

We introduce the relation \trianglelefteq over the runs defined by $\rho \trianglelefteq \rho'$ if ρ is a run of the form $\rho = c_0 \dots c_k$ where $c_j \in \mathbb{N}^d$ and if there exists a sequence $(v_j)_{0 \le j \le k+1}$ of vectors $v_j \in \mathbb{N}^d$ such that ρ' is a run of the form $\rho' = \rho_0 \dots \rho_k$ where ρ_j is a run from $c_j + v_j$ to $c_j + v_{j+1}$. A very similar relation was first introduced by Petr Jančar in [5]. Let us recall that a *well-order* over a set S is an order \sqsubseteq over S such that for every sequence $(s_j)_{j\in\mathbb{N}}$ of elements $s_j \in S$ there exists j < k such that $s_j \sqsubseteq s_k$.

Lemma 4.1. *The relation* \leq *is a well-order over the runs.*

Proof. A proof of this lemma with different notations can be obtained from Section 6 of [5] with a simple reduction. For sake of completeness, we prefer to give a direct proof of this important result. To do so, we introduce a well-order \leq over the runs based on the *Higman's Lemma* and we show that \leq and \leq are equal. We first associate to a run $\rho = c_0 \dots c_k$ the word $\alpha(\rho) = (a_1, c_1) \dots (a_k, c_k)$ over the set $S = \mathbf{A} \times \mathbb{N}^d$ where

 $a_j = c_j - c_{j-1}$. The set S is ordered by the relation \sqsubseteq defined by $(a_1, c_1) \sqsubseteq (a_2, c_2)$ if $a_1 = a_2$ and $c_1 \le c_2$. Dickson's lemma shows that \sqsubseteq is a well-order. The set of words S^* is well-ordered thanks to the Higman's lemma by the relation \sqsubseteq^* defined by $s_1 \dots s_k \sqsubseteq^* w$ if w is a word in $S^* s'_1 S^* \dots s'_k S^*$ with $s_j \sqsubseteq s'_j$ for every $j \in \{1, \dots, k\}$. The well-order \preceq over the runs is defined by $\rho \preceq \rho'$ if dir $(\rho) \le \operatorname{dir}(\rho')$ and $\alpha(\rho) \sqsubseteq^* \alpha(\rho')$. Now, let us prove that \preceq and \trianglelefteq are equal. We consider a run $\rho = c_0 \dots c_k$ with $c_j \in \mathbb{N}^d$ and we introduce the action $a_j = c_j - c_{j-1}$ for each $j \in \{1, \dots, k\}$.

Assume first that $\rho \leq \rho'$ for some run ρ' . Since $\alpha(\rho) = (a_1, c_1) \dots (a_k, c_k)$ and $\alpha(\rho) \equiv^* \alpha(\rho')$ we deduce a decomposition of $\alpha(\rho')$ into the following word where $c'_j \geq c_j$ for every $j \in \{1, \dots, k\}$ and $w_0, \dots, w_k \in S^*$:

$$\alpha(\rho') = w_0(\boldsymbol{a}_1, \boldsymbol{c}_1') w_1 \dots (\boldsymbol{a}_k, \boldsymbol{c}_k') w_k$$

In particular ρ' can be decomposed in $\rho' = \rho_0 \dots \rho_k$ where ρ_0 is a run from $\operatorname{src}(\rho')$ to $c'_1 - a_1$, ρ_j is a run from c'_j to $c'_{j+1} - a_{j+1}$ for every $j \in \{1, \dots, k-1\}$, and ρ_k is a run from c'_k to $\operatorname{tgt}(\rho')$. Let us introduce the sequence $(v_j)_{0 \leq j \leq k+1}$ of vectors defined by $v_0 = \operatorname{src}(\rho') - \operatorname{src}(\rho)$, $v_j = c'_j - c_j$ for every $j \in \{1, \dots, k\}$ and $v_{k+1} = \operatorname{tgt}(\rho') - \operatorname{tgt}(\rho)$. Note that $v_j \in \mathbb{N}^d$ for every $j \in \{0, \dots, k+1\}$. Observe that for every $j \in \{1, \dots, k-1\}$ we have $c'_{j+1} - a_j = c_{j+1} - a_j + v_{j+1} = c_j + v_{j+1}$. Hence ρ_j is a run from $c_j + v_j$ to $c_j + v_{j+1}$ for every $j \in \{0, \dots, k\}$. Therefore $\rho \leq \rho'$.

Conversely, let us assume that $\rho \leq \rho'$ for some run ρ' . We introduce a sequence $(v_j)_{0 \leq j \leq k+1}$ of vectors in \mathbb{N}^d such that $\rho' = \rho_0 \dots \rho_k$ where ρ_j is a run from $c_j + v_j$ to $c_j + v_{j+1}$. We deduce the following equality where $a'_j = \operatorname{src}(\rho_j) - \operatorname{tgt}(\rho_{j-1})$:

$$\alpha(\rho') = \alpha(\rho_0)(\boldsymbol{a}_1', \boldsymbol{c}_1 + \boldsymbol{v}_1)\alpha(\rho_1)\dots(\boldsymbol{a}_k', \boldsymbol{c}_k + \boldsymbol{v}_k)\alpha(\rho_k)$$

Observe that $a'_j = (c_j + v_j) - (c_{j-1} + v_j) = a_j$. We deduce that $\alpha(\rho) \sqsubseteq^* \alpha(\rho')$. Moreover, since $\operatorname{dir}(\rho) \leq \operatorname{dir}(\rho')$ we get $\rho \preceq \rho'$.

5 Transformer Relations

Based on the definition of \trianglelefteq , we introduce the *transformer relation with capacity* $c \in \mathbb{N}^d$ as the binary relation $\stackrel{c}{\frown}$ over \mathbb{N}^d defined by $x \stackrel{c}{\frown} y$ if there exists a run from c + x to c + y. We also associate to every run $\rho = c_0 \dots c_k$ with $c_j \in \mathbb{N}^d$ the *transformer relation along the run* ρ denoted by $\stackrel{\rho}{\frown}$ and defined as the following composition:

$$\stackrel{\rho}{\curvearrowright} = \stackrel{\boldsymbol{c}_0}{\curvearrowleft} \circ \cdots \circ \stackrel{\boldsymbol{c}_k}{\curvearrowleft}$$

In this section transformer relations are shown to be *asymptotically definable periodic*. Thanks to the following Lemma 5.1, it is sufficient to prove that $\stackrel{c}{\frown}$ is in this class for every capacity $c \in \mathbb{N}^d$.

Lemma 5.1. Asymptotically definable periodic relations are stable by composition.

Proof. Assume that $R, S \subseteq \mathbb{Z}^d \times \mathbb{Z}^d$ are two periodic relations and observe that $(\mathbf{0}, \mathbf{0}) \in R \circ S$. Let us consider two pairs $(\mathbf{x}_1, \mathbf{z}_1)$ and $(\mathbf{x}_2, \mathbf{z}_2)$ in $R \circ S$. For each $k \in \{1, 2\}$,

there exists $y_k \in \mathbb{Z}^d$ such that $(x_k, y_k) \in R$ and $(y_k, z_k) \in S$. As R and S are periodic we get $(x, y) \in R$ and $(y, z) \in S$ where $x = x_1 + x_2$, $y = y_1 + y_2$ and $z = z_1 + z_2$. Thus $(x, z) \in R \circ S$ and we have proved that $R \circ S$ is periodic. Now just observe that $\mathbb{Q}_{\geq 0}(R \circ S) = (\mathbb{Q}_{\geq 0}R) \circ (\mathbb{Q}_{\geq 0}S)$. Hence if R and S are asymptotically definable then $R \circ S$ is also asymptotically definable.

Lemma 5.2. The transformer relation $\stackrel{c}{\frown}$ is periodic.

Proof. Assume that $c + x_1 \xrightarrow{w_1} c + y_1$ and $c + x_2 \xrightarrow{w_2} c + y_2$ for words $w_1, w_2 \in A^*$ and vectors $x_1, y_1, x_2, y_2 \in \mathbb{N}^d$. By monotony $c + x_1 + x_2 \xrightarrow{w_1w_2} c + y_1 + y_2$. \Box

In the remainder of this section, we show that $\mathbb{Q}_{\geq 0} \stackrel{c}{\curvearrowleft}$ is definable in FO $(\mathbb{Q}, +, \leq)$. We introduce the set Γ_c of triples $\gamma = (x, c, y)$ such that $x \stackrel{c}{\backsim} y$ and the set $\Gamma = \bigcup_{c \in \mathbb{N}^d} \Gamma_c$. Given a triple $\gamma \in \Gamma$, the vectors x, c, y implicitly denote the components of γ . We introduce the set Ω_{γ} of runs ρ such that $\operatorname{dir}(\rho) \in (c, c) + \mathbb{N}(x, y)$ and the set Q_{γ} of configurations $q \in \mathbb{N}^d$ such that there exists a run $\rho \in \Omega_{\gamma}$ in which q occurs. We denote by I_{γ} the set of indexes $i \in \{1, \ldots, d\}$ such that $\{q(i) \mid q \in Q_{\gamma}\}$ is finite.

Example 5.3. Let us consider the VAS $\boldsymbol{A} = \{\boldsymbol{a}, \boldsymbol{b}\}$ where $\boldsymbol{a} = (1, 1, -1)$ and $\boldsymbol{b} = (-1, 0, 1)$ and let $\gamma = (\boldsymbol{x}, \boldsymbol{c}, \boldsymbol{y})$ where $\boldsymbol{x} = (0, 0, 0), \boldsymbol{c} = (1, 0, 1)$ and $\boldsymbol{y} = (0, 1, 0)$. Observe that $\Omega_{\gamma} = \{\boldsymbol{c} + n\boldsymbol{x} \xrightarrow{w_1...w_n} \boldsymbol{c} + n\boldsymbol{y} \mid n \in \mathbb{N} \ w_j \in \{\boldsymbol{a}\boldsymbol{b}, \boldsymbol{b}\boldsymbol{a}\}\}, \boldsymbol{Q}_{\gamma} = (\{2\} \times \mathbb{N}_{>0} \times \{0\}) \cup (\{1\} \times \mathbb{N} \times \{1\}) \cup (\{0\} \times \mathbb{N} \times \{2\}), \text{ and } I_{\gamma} = \{1, 3\}.$

In section 5.1 we show that for every configuration $q \in Q_{\gamma}$, there exist configurations $q' \in Q_{\gamma}$ that coincide with q on components indexed by I_{γ} and such that q'is as large as expected on all the other components. Based on a projection of the unbounded components of vectors in Q_{γ} , i.e. the components not indexed by I_{γ} , we show in Section 5.3 that a finite graph G_{γ} called *production graph* can be canonically associated to every triple γ . We also prove that the class $\{G_{\gamma} \mid \gamma \in \Gamma_{c}\}$ is finite. Finally in Section 5.2 we introduce a binary relation $R_{\gamma} \subseteq \mathbb{Q}_{\geq 0} \stackrel{c}{\sim}$ definable in FO $(\mathbb{Q}, +, \leq)$ associated to the production graphs G_{γ} and such that $(x, y) \in R_{\gamma}$. By observing that $\mathbb{Q}_{\geq 0} \stackrel{c}{\sim} = \bigcup_{\gamma \in \Gamma_{c}} R_{\gamma}$ and the class $\{R_{\gamma} \mid \gamma \in \Gamma_{c}\}$ is finite we deduce that the periodic relation $\stackrel{c}{\sim}$ is asymptotically definable.

5.1 Intraproductions

An *intraproduction* for γ is a vector $h \in \mathbb{N}^d$ such that there exists $n \in \mathbb{N}$ satisfying $nx \stackrel{c}{\frown} h \stackrel{c}{\frown} ny$. We denote by H_{γ} the set of intraproductions for γ . This set is periodic since $\stackrel{c}{\frown} is$ periodic. In particular for every $h \in H_{\gamma}$ we have $\mathbb{N}h \subseteq H_{\gamma}$ and the following lemma shows that $Q_{\gamma} + \mathbb{N}h \subseteq Q_{\gamma}$. Hence, the components of every vector $q \in Q_{\gamma}$ indexed by i such that h(i) > 0 can be increased to arbitrary large values by adding a large number of times the vector h. In order to increase simultaneously all the components not indexed by I_{γ} we are interested by intraproductions h such that h(i) > 0 for every $i \notin I_{\gamma}$. Note that components indexed by I_{γ} are necessarily zero since for every intraproduction h, from $c + \mathbb{N}h \subseteq Q_{\gamma}$ we get h(i) = 0 for every $i \in I_{\gamma}$.

Lemma 5.4. We have $Q_{\gamma} + H_{\gamma} \subseteq Q_{\gamma}$.

Proof. Let $q \in Q_{\gamma}$ and $h \in H_{\gamma}$. As $q \in Q_{\gamma}$, there exist $n \in \mathbb{N}$ and words $u, v \in A^*$ such that $c + nx \xrightarrow{u} q \xrightarrow{v} c + ny$. Since $h \in H_{\gamma}$ there exist $n' \in \mathbb{N}$ and words $u', v' \in A^*$ such that $c + n'x \xrightarrow{u'} c + h \xrightarrow{v'} c + n'y$. Let m = n + n'. By monotony, we have $c + mx \xrightarrow{u'u} q + h \xrightarrow{vv'} c + my$. Hence $q + h \in Q_{\gamma}$.

Lemma 5.5. For every $q \leq q'$ in Q_{γ} there exists $h \in H_{\gamma}$ such that $q' \leq q + h$.

Proof. As $q, q' \in Q_{\gamma}$ there exists $m, m' \in \mathbb{N}$ and $u, v, u', v' \in A^*$ such that:

 $\boldsymbol{c} + m\boldsymbol{x} \xrightarrow{\boldsymbol{u}} \boldsymbol{q} \xrightarrow{\boldsymbol{v}} \boldsymbol{c} + m\boldsymbol{y}$ and $\boldsymbol{c} + m'\boldsymbol{x} \xrightarrow{\boldsymbol{u}'} \boldsymbol{q}' \xrightarrow{\boldsymbol{v}'} \boldsymbol{c} + m'\boldsymbol{y}$

Let us introduce v = q' - q, h = v + m(x + y), and n = m + m'. By monotony:

Since q' + mx = q + v + mx and q + v + my = q' + my, we have proved that $c + nx \xrightarrow{u'v} c + h \xrightarrow{uv'} c + ny$. Hence $h \in H_{\gamma}$. Observe that $q + h = q' + m(x+y) \ge q'$. We are done.

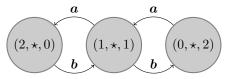
Lemma 5.6. There exist $h \in H_{\gamma}$ such that $I_{\gamma} = \{i \mid h(i) = 0\}$.

Proof. Let $i \notin I_{\gamma}$. There exists a sequence $(q_j)_{j \in \mathbb{N}}$ of configurations $q_j \in Q_{\gamma}$ such that $(q_j(i))_{j \in \mathbb{N}}$ is strictly increasing. Since (\mathbb{N}^d, \leq) is well-ordered there exists j < k such that $q_j \leq q_k$. Lemma 5.5 shows that there exists an intraproduction h_i for γ such that $q_k \leq q_j + h_i$. In particular $h_i(i) > 0$ since $q_j(i) < q_k(i)$. As the set of intraproductions H_{γ} is periodic we deduce that $h = \sum_{i \notin I} h_i$ is an intraproduction for γ . By construction we have h(i) > 0 for every $i \notin I_{\gamma}$. Since $h \in H_{\gamma}$ we deduce that h(i) = 0 for every $i \in I_{\gamma}$. Therefore $I_{\gamma} = \{i \mid h(i) = 0\}$.

5.2 Production Graphs

Finite graphs G_{γ} , called *production graphs* can be associated to every triple γ as follows. The set of *states* is obtained from Q_{γ} by projecting away the unbounded components. More formally, we introduce the projection function $\pi_{\gamma} : Q_{\gamma} \to \mathbb{N}^{I_{\gamma}}$ defined by $\pi_{\gamma}(q)(i) = q(i)$ for every $q \in Q_{\gamma}$ and for every $i \in I_{\gamma}$. We consider the finite set of *states* $S_{\gamma} = \pi_{\gamma}(Q_{\gamma})$ and the set T_{γ} of *transitions* $(\pi_{\gamma}(q), q' - q, \pi_{\gamma}(q'))$ where qq' is a factor of a run in Ω_{γ} . Since $T_{\gamma} \subseteq S_{\gamma} \times A \times S_{\gamma}$ we deduce that T_{γ} is finite. We introduce the finite graph $G_{\gamma} = (S_{\gamma}, T_{\gamma})$, called the *production graph* of γ . Since $c \in Q_{\gamma}$ we deduce that $\pi_{\gamma}(c)$ is a state of G_{γ} . This state is denoted by s_{γ} .

Example 5.7. Let us come back to Example 5.3. The graph G_{γ} is depicted on the right where \star denotes a projected component. Note that $s_{\gamma} = (1, \star, 1)$.



Corollary 5.8. We have $\pi_{\gamma}(\operatorname{src}(\rho)) = s_{\gamma} = \pi_{\gamma}(\operatorname{tgt}(\rho))$ for every run $\rho \in \Omega_{\gamma}$.

Proof. Since $\rho \in \Omega_{\gamma}$ there exists $n \in \mathbb{N}$ such that ρ is a run from $\boldsymbol{c} + n\boldsymbol{x}$ to $\boldsymbol{c} + n\boldsymbol{y}$. In particular $n\boldsymbol{x}$ and $n\boldsymbol{y}$ are two intraproductions for γ . We get $n\boldsymbol{x}(i) = 0 = n\boldsymbol{y}(i)$ for every $i \in I_{\gamma}$. Hence $\pi_{\gamma}(\operatorname{src}(\rho)) = \pi_{\gamma}(\boldsymbol{c}) = \pi_{\gamma}(\operatorname{tgt}(\rho))$.

A path in G_{γ} is a word $p = (s_0, a_1, s_1) \dots (s_{k-1}, a_k, s_k)$ of transitions (s_{j-1}, a_j, s_j) in T_{γ} . Such a path is called a path from s_0 to s_k labeled by $w = a_1 \dots a_k$. When $s_0 = s_k$ the path is called a cycle. The previous corollary shows that for every run $\rho = c_0 \dots c_k$ in Ω_{γ} the following word θ_{ρ} is a cycle on s_{γ} in G_{γ} labeled by w:

$$\theta_{\rho} = (\pi_{\gamma}(\boldsymbol{c}_0), \boldsymbol{a}_1, \pi_{\gamma}(\boldsymbol{c}_1)) \dots (\pi_{\gamma}(\boldsymbol{c}_{k-1}), \boldsymbol{a}_k, \pi_{\gamma}(\boldsymbol{c}_k))$$

Corollary 5.9. The graph G_{γ} is strongly connected.

Proof. Let $s \in S_{\gamma}$. There exists $q \in Q_{\gamma}$ that occurs in a run $\rho \in \Omega_{\gamma}$ such that $s = \pi_{\gamma}(q)$. Hence there exist $u, v \in A^*$ such that $\operatorname{src}(\rho) \xrightarrow{u} q \xrightarrow{v} \operatorname{tgt}(\rho)$. Note that θ_{ρ} is the concatenation of a path from s_{γ} to s and a path from s to s_{γ} labeled by u, v. \Box

Corollary 5.10. *States in* S_{γ} *are incomparable.*

Proof. Let us consider $s \leq s'$ in S_{γ} . There exists $q, q' \in Q_{\gamma}$ such that $s = \pi_{\gamma}(q)$ and $s' = \pi_{\gamma}(q')$. Lemma 5.6 shows that there exists an intraproduction $h' \in H_{\gamma}$ such that $I_{\gamma} = \{i \mid h'(i) = 0\}$. By replacing h' by a vector in $\mathbb{N}_{>0}h'$ we can assume without loss of generality that $q(i) \leq q'(i) + h'(i)$ for every $i \notin I_{\gamma}$. As $q(i) = s(i) \leq s'(i) = q'(i) = q'(i) + h'(i)$ for every $i \in I_{\gamma}$ we deduce that $q \leq q' + h'$. Lemma 5.4 shows that $q' + h' \in Q_{\gamma}$. Lemma 5.5 shows that there exists an intraproduction $h \in H_{\gamma}$ such that $q' + h' \leq q + h$. As $h \in H_{\gamma}$ we deduce that h(i) = 0 for every $i \in I_{\gamma}$. In particular $q'(i) \leq q(i)$ for every $i \in I_{\gamma}$. Hence $s' \leq s$ and we get s = s'.

Corollary 5.11. The class $\{G_{\gamma} \mid \gamma \in \Gamma_{c}\}$ is finite.

Proof. Given $I \subseteq \{1, \ldots, d\}$ we introduce the state $s_{c,I} \in \mathbb{N}^I$ defined by $s_{c,I}(i) = c(i)$ for every $i \in I$. We also introduce the set $\Gamma_{c,I}$ of triples $\gamma \in \Gamma_c$ such that $I_{\gamma} = I$. Assume by contradiction that $S_{c,I} = \bigcup_{\gamma \in \Gamma_{c,I}} S_{\gamma}$ is infinite. For every $s \in S_{c,I}$ there exists $\gamma \in \Gamma_{c,I}$ such that $s \in S_{\gamma}$. Hence there exists a path p_s in G_{γ} from $s_{c,I}$ to s. Since the states in S_{γ} are incomparable, we can assume that the states occurring in p_s are incomparable. By inserting the paths p_s in a tree rooted by $s_{c,I}$ with transitions labeled by actions in A we deduce an infinite tree such that each node has a finite number of children (at most |A|). The Koenig's lemma shows that this tree has an infinite branch. Since (\mathbb{N}^I, \leq) is well-ordered, there exists two comparable distinct nodes in this branch. There exists $s \in S_{c,I}$ such that these two comparable states occurs in p_s . We get a contradiction. Thus $S_{c,I}$ is finite. We deduce the corollary.

5.3 Kirchhoff's Functions

We associate to the production graph G_{γ} a binary relation R_{γ} included in $\mathbb{Q}_{\geq 0} \stackrel{\sim}{\sim}$ and such that $(x, y) \in R_{\gamma}$. This relation is based on the *Kirchhoff's functions*.

A Kirchhoff's function for γ is a function $f : T_{\gamma} \to \mathbb{Q}_{>0}$ labeling transitions of the production graph G_{γ} by some positive rational numbers satisfying the following equality for every $s \in S_{\gamma}$:

$$\sum_{t \in T_{\gamma} \cap (\{s\} \times \mathbf{A} \times S_{\gamma})} f(t) = \sum_{t \in T_{\gamma} \cap (S_{\gamma} \times \mathbf{A} \times \{s\})} f(t)$$

A cycle θ in G_{γ} is said to be *total* for γ if every transition in T_{γ} occurs in θ . The *Parikh image* of a path is the function $f: T_{\gamma} \to \mathbb{N}$ where f(t) denotes the number of occurrences of t in the path. The *Euler's lemma* shows that a function $f: T_{\gamma} \to \mathbb{N}_{>0}$ is a Kirchhoff' function for γ if and only if f is the Parikh image of a total cycle for γ .

The displacement of a function $f: T_{\gamma} \to \mathbb{Q}$ is the sum $\sum_{t \in T_{\gamma}} f(t)\Delta(t)$ where $\Delta(t) = a$ if a is the label of the transition t. This vector is denoted by $\Delta(f)$. Let us observe that if f is the Parikh's image of a path in G_{γ} labeled by a word w then $\Delta(f) = \Delta(w)$. Intuitively the displacement of w only depends on the number of times transitions in T_{γ} occur in the path.

We introduce the relation R_{γ} of pairs $(\boldsymbol{u}, \boldsymbol{v}) \in \mathbb{Q}_{\geq 0}^d \times \mathbb{Q}_{\geq 0}^d$ satisfying $\boldsymbol{u}(i) > 0$ iff $\boldsymbol{x}(i) > 0, \boldsymbol{v}(i) > 0$ iff $\boldsymbol{y}(i) > 0$, and such that there exists a Kirchhoff's function f for γ such that $\boldsymbol{v} - \boldsymbol{u} = \Delta(f)$. Observe that R_{γ} is definable in FO $(\mathbb{Q}, +, \leq)$.

Example 5.12. Let us come back to Examples 5.3 and 5.7. The relation R_{γ} is equal to $\{((0,0,0),(0,n,0)) \mid n \in \mathbb{Q}_{>0}\}.$

Lemma 5.13. We have $(\boldsymbol{x}, \boldsymbol{y}) \in R_{\gamma}$.

Proof. Assume that $T_{\gamma} = \{t_1, \ldots, t_k\}$. By definition of T_{γ} , for every $j \in \{1, \ldots, k\}$, there exists a run ρ_j such that t_j occurs in the cycle θ_{ρ_j} . Let w_j be the label of ρ_j and $n_j \in \mathbb{N}$ such that $\operatorname{dir}(\rho_j) \in (\boldsymbol{c}, \boldsymbol{c}) + n_j(\boldsymbol{x}, \boldsymbol{y})$. As $\boldsymbol{x} \stackrel{\boldsymbol{c}}{\sim} \boldsymbol{y}$ there exists a run ρ from $\boldsymbol{c} + \boldsymbol{x}$ to $\boldsymbol{c} + \boldsymbol{y}$ labeled by a word w. The cycle θ_ρ shows that w is the label of a cycle on s_{γ} . Let us consider $n = 1 + \sum_{j=1}^k n_j$ and $\sigma = ww_1 \ldots w_k$. Observe that σ is the label of a total cycle on s_{γ} . Hence the Parikh's image of this total cycle provides a Kirchhoff's function f for γ such that $\Delta(\sigma) = \Delta(f)$. Observe that $\Delta(\sigma) = n(\boldsymbol{y} - \boldsymbol{x})$. Hence $\boldsymbol{y} - \boldsymbol{x} = \Delta(\frac{1}{n}f)$ and we have proved that $(\boldsymbol{x}, \boldsymbol{y}) \in R_{\gamma}$.

Lemma 5.14. We have $R_{\gamma} \subseteq \mathbb{Q}_{\geq 0} \curvearrowright^{c}$.

Proof. Lemma 5.6 shows that there exists $\mathbf{h}' \in \mathbf{H}_{\gamma}$ such that $I_{\gamma} = \{i \mid \mathbf{h}'(i) = 0\}$. From $\mathbf{h}' \in \mathbf{H}_{\gamma}$ we have a run ρ of the form $\mathbf{c} + n\mathbf{x} \xrightarrow{w_1} \mathbf{c} + \mathbf{h}' \xrightarrow{w_2} \mathbf{c} + n\mathbf{y}$ for some $n \in \mathbb{N}$ and $w_1, w_2 \in \mathbf{A}^*$. The cycle θ_{ρ} shows that there exist cycles θ_1, θ_2 on s_{γ} labeled by w_1, w_2 . We denote by f_1 and f_2 the Parikh images of these two cycles. Let $(\mathbf{u}, \mathbf{v}) \in R_{\gamma}$. By replacing (\mathbf{u}, \mathbf{v}) by a pair in $\mathbb{N}_{>0}(\mathbf{u}, \mathbf{v})$ we can assume without loss of generality that $\mathbf{u}' = \mathbf{u} - n\mathbf{x}$ and $\mathbf{v}' = \mathbf{v} - n\mathbf{y}$ are both in \mathbb{N}^d , and there exists a Kirchhoff's function f such that $f(t) \in \mathbb{N}_{>0}$ and $f(t) > f_1(t) + f_2(t)$ for every $t \in T_{\gamma}$, and such that $\mathbf{v} - \mathbf{u} = \Delta(f)$. Since $g = f - (f_1 + f_2)$ is a Kirchhoff's function satisfying $g(t) \in \mathbb{N}_{>0}$ for every $t \in T_{\gamma}$, the Euler's Lemma shows that g is the Parikh's

image of a total cycle θ in G_{γ} on s_{γ} . Let σ be the label of this cycle and observe that $\Delta(\sigma) = \Delta(g) = \Delta(f) - (\Delta(f_1) + \Delta(f_2)) = \mathbf{v} - \mathbf{u} - ((\mathbf{h}' - n\mathbf{x}) + (n\mathbf{y} - \mathbf{h}')) = \mathbf{v}' - \mathbf{u}'$. Since $\mathbf{c} + n\mathbf{x} \xrightarrow{w_1} \mathbf{c} + \mathbf{h}' \xrightarrow{w_2} \mathbf{c} + n\mathbf{y}$ and $n\mathbf{x} \leq \mathbf{u}, n\mathbf{y} \leq \mathbf{v}$ we deduce by monotony that for every $k \in \mathbb{N}$ we have:

$$c + ku \xrightarrow{w_1^k} c + k(h' + u') \qquad c + k(h' + v') \xrightarrow{w_2^k} c + kv$$

Since θ is a cycle in G_{γ} on s_{γ} labeled by σ and $I_{\gamma} = \{i \mid h'(i) = 0\}$, there exists a run from c + kh' labeled by σ for some $k \in \mathbb{N}_{>0}$ large enough. Let us consider $j \in \{0, \ldots, k\}$ and let us introduce $z_j = (k - j)u' + jv'$. Note that $z_j \in \mathbb{N}^d$. By monotony there exists a run from $c + kh' + z_j$ labeled by σ . Since $\Delta(\sigma) = v' - u'$, we get $z_j + \Delta(\sigma) = z_{j+1}$. We deduce that $c + kh' + z_j \xrightarrow{\sigma} c + kh' + z_{j+1}$. Therefore:

$$\boldsymbol{c} + k(\boldsymbol{h}' + \boldsymbol{u}') \xrightarrow{\sigma^k} \boldsymbol{c} + k(\boldsymbol{h}' + \boldsymbol{v}')$$

We have proved the lemma by observing that $c + ku \xrightarrow{w_1^k \sigma^k w_2^k} c + kv$.

Corollary 5.15. Transformer relations are asymptotically definable periodic relations.

Proof. Lemma 5.13 and Lemma 5.14 show that $\mathbb{Q}_{\geq 0} \curvearrowright = \bigcup_{\gamma \in \Gamma_{\mathbf{c}}} R_{\gamma}$. Since the class $\{G_{\gamma} \mid \gamma \in \Gamma_{\mathbf{c}}\}$ is finite we deduce that the class $\{R_{\gamma} \mid \gamma \in \Gamma_{\mathbf{c}}\}$ is finite. Recall that relations R_{γ} are definable in FO $(\mathbb{Q}, +, \leq)$.

6 Reachability Relations Are Almost Semilinear

In this section the intersection of the reachability relation $\xrightarrow{*}$ with any Presburger relation $R \subseteq \mathbb{N}^d \times \mathbb{N}^d$ is proved to be almost semilinear. As a direct corollary we will deduce that post* $(X) \cap Y$ and pre* $(Y) \cap X$ are almost semilinear for every Presburger sets $X, Y \subseteq \mathbb{N}^d$. Since Presburger relations are finite unions of linear relations, we can assume that R = r + P where $r \in \mathbb{N}^d \times \mathbb{N}^d$ and $P \subseteq \mathbb{N}^d \times \mathbb{N}^d$ is a finitely generated periodic relation. We introduce the set Ω of runs ρ such that dir $(\rho) \in R$ equipped with the order \sqsubseteq defined by $\rho \sqsubseteq \rho'$ if dir $(\rho') \in \text{dir}(\rho) + P$ and $\rho \trianglelefteq \rho'$. Since P is finitely generated, the Dickson's lemma shows that \sqsubseteq is a well-order.

Lemma 6.1. The intersection of $\xrightarrow{*}$ with R is equal to:

$$\bigcup_{\rho \in \min_{\square}(\Omega)} \operatorname{dir}(\rho) + (\stackrel{\rho}{\curvearrowleft} \cap P)$$

Proof. Let us first prove that $\operatorname{dir}(\rho) + (\stackrel{\rho}{\frown} \cap P)$ is included in $\stackrel{*}{\to} \cap R$ for every run $\rho \in \Omega$. Assume that $\rho = \mathbf{c}_0 \dots \mathbf{c}_k$ with $\mathbf{c}_j \in \mathbb{N}^d$ and let $(\boldsymbol{m}, \boldsymbol{n}) \in P$ such that $\boldsymbol{m} \stackrel{\rho}{\frown} \boldsymbol{n}$. As $\rho \in \Omega$ we deduce that $(\mathbf{c}_0, \mathbf{c}_k) \in R$. As $\boldsymbol{m} \stackrel{\rho}{\frown} \boldsymbol{n}$ there exists a sequence $(\boldsymbol{v}_j)_{0 \leq j \leq k+1}$ of vectors $\boldsymbol{v}_j \in \mathbb{N}^d$ such that $\boldsymbol{v}_0 = \boldsymbol{m}, \boldsymbol{v}_{k+1} = \boldsymbol{n}$ and such that $\boldsymbol{v}_j \stackrel{\boldsymbol{c}_j}{\frown} \boldsymbol{v}_{j+1}$ for every $j \in \{0, \dots, k\}$. In particular there exists a run from $\boldsymbol{c}_j + \boldsymbol{v}_j$ to $\boldsymbol{c}_j + \boldsymbol{v}_{j+1}$ labeled by a

word $w_j \in A^*$. Now just observe that we have a run from $c_0 + v_0$ to $c_k + v_{k+1}$ labeled by $w_0 a_1 w_1 \dots a_k w_k$ where $a_j = c_j - c_{j-1}$. Since $(c_0, c_k) \in r + P$ and $(m, n) \in P$ we deduce that $(c_0 + m, c_k + n) \in r + P + P \subseteq R$. Hence $\operatorname{dir}(\rho) + (m, n)$ is in $\stackrel{*}{\to} \cap R$.

Now, let us prove that for every $(\boldsymbol{x}, \boldsymbol{y}) \in R$ such that $\boldsymbol{x} \xrightarrow{*} \boldsymbol{y}$ there exists $\rho \in \min_{\sqsubseteq}(\Omega)$ such that $(\boldsymbol{x}, \boldsymbol{y}) \in \operatorname{dir}(\rho) + (\stackrel{\rho}{\curvearrowleft} \cap P)$. There exists a run $\rho' \in \Omega$ such that $\operatorname{dir}(\rho') = (\boldsymbol{x}, \boldsymbol{y})$. Since \sqsubseteq is a well-order, there exists a run $\rho \in \min_{\sqsubseteq}(\Omega)$ such that $\rho \sqsubseteq \rho'$. By definition of \sqsubseteq we deduce that $\operatorname{dir}(\rho') \in \operatorname{dir}(\rho) + (\stackrel{\rho}{\curvearrowleft} \cap P)$. \Box

Since $\stackrel{\rho}{\sim} \cap P$ is an asymptotically definable periodic relation, from the previous lemma we deduce that the intersection of the reachability relation $\stackrel{*}{\rightarrow}$ with every Presburger relation is almost semilinear. We deduce the following corollary.

Corollary 6.2. The sets $post^*(X) \cap Y$ and $pre^*(Y) \cap X$ are almost semilinear for every Presburger sets $X, Y \subseteq \mathbb{N}^d$.

Proof. Let us consider the Presburger relation $R = \mathbf{X} \times \mathbf{Y}$ and observe that $\text{post}^*(\mathbf{X}) \cap \mathbf{Y} = f(\stackrel{*}{\to} \cap R)$ and $\text{pre}^*(\mathbf{Y}) \cap \mathbf{X} = g(\stackrel{*}{\to} \cap R)$ where $f, g : \mathbb{Q}^d \times \mathbb{Q}^d \to \mathbb{Q}^d$ and defined by $f(\mathbf{x}, \mathbf{y}) = \mathbf{y}$ and $g(\mathbf{x}, \mathbf{y}) = \mathbf{x}$. Now just observe that for every $r \in \mathbb{N}^d \times \mathbb{N}^d$, for every asymptotically definable periodic relation $P \subseteq \mathbb{N}^d \times \mathbb{N}^d$, and for every $h \in \{f, g\}$ we have h(r + P) = h(r) + h(P). Moreover h(P) is a periodic set and the conic set $\mathbb{Q}_{>0}h(P)$ is equal to $h(\mathbb{Q}_{>0}P)$ which is definable in FO $(\mathbb{Q}, +, \leq)$.

7 Dimension

In this section we introduce a dimension function for the subsets of \mathbb{Z}^d and we characterize the dimension of periodic sets.

A vector space is a set $V \subseteq \mathbb{Q}^d$ such that $0 \in V$, $V + V \subseteq V$ and such that $\mathbb{Q}V \subseteq V$. Let $X \subseteq \mathbb{Q}^d$. The following set V is a vector space called the vector space generated by X.

$$oldsymbol{V} = \left\{ \sum_{j=1}^k \lambda_j oldsymbol{x}_j \mid k \in \mathbb{N} ext{ and } (\lambda_j, oldsymbol{x}_j) \in \mathbb{Q} imes oldsymbol{X}
ight\}$$

This vector space is the minimal for the inclusion among the vector spaces that contain X. Let us recall that every vector space V is generated by a finite set. The *rank* rank(V) of a vector space V is the minimal natural number $m \in \mathbb{N}$ such that there exists a finite set X with m vectors that generates V. Let us recall that rank(V) $\leq d$ for every vector space $V \subseteq \mathbb{Q}^d$ and rank(V) \leq rank(W) for every pair of vector spaces $V \subseteq W$. Moreover, if V is strictly included in W then rank(V) < rank(W).

Example 7.1. Vector spaces V included in \mathbb{Q}^2 satisfy rank(V) $\in \{0, 1, 2\}$. Moreover these vectors spaces can be classified as follow : rank(V) = 0 if and only if $V = \{0\}$, rank(V) = 1 if and only if $V = \mathbb{Q}v$ with $v \in \mathbb{Q}^2 \setminus \{0\}$, and rank(V) = 2 if and only if $V = \mathbb{Q}^2$.

The dimension of a set $X \subseteq \mathbb{Z}^d$ is the minimal integer $m \in \{-1, \ldots, d\}$ such that $X \subseteq \bigcup_{j=1}^k b_j + V_j$ where $b_j \in \mathbb{Z}^d$ and $V_j \subseteq \mathbb{Q}^d$ is a vector space satisfying rank $(V_j) \leq m$ for every j. We denote by dim(X) the dimension of X. Observe that dim $(v + X) = \dim(X)$ for every $X \subseteq \mathbb{Z}^d$ and for every $v \in \mathbb{Z}^d$. Moreover we have dim(X) = -1 if and only if X is empty. Note that dim $(X \cup Y) = \max{\dim(X), \dim(Y)}$ for every subsets $X, Y \subseteq \mathbb{Z}^d$.

Lemma 7.2. Let $P \subseteq \mathbb{Z}^d$ be a periodic set included in $\bigcup_{j=1}^k \mathbf{b}_j + \mathbf{V}_j$ where $k \in \mathbb{N}_{>0}$, $\mathbf{b}_j \in \mathbb{Z}^d$ and $\mathbf{V}_j \subseteq \mathbb{Q}^d$ is a vector space. There exists $j \in \{1, \ldots, k\}$ such that $P \subseteq \mathbf{V}_j$ and $\mathbf{b}_j \in \mathbf{V}_j$.

Proof. Let us first prove by induction over $k \in \mathbb{N}_{>0}$ that for every periodic set $P \subseteq \mathbb{Z}^d$ included in $\bigcup_{j=1}^k V_j$ where $V_j \subseteq \mathbb{Q}^d$ is a vector space, there exists $j \in \{1, \ldots, k\}$ such that $P \subseteq V_j$. The rank k = 1 is immediate. Assume the rank k proved and let us prove the rank k + 1. Let P be a periodic set included in $\bigcup_{j=1}^{k+1} V_j$ where $V_j \subseteq \mathbb{Q}^d$ is a vector space. If $P \subseteq V_{k+1}$ the induction is proved. So we can assume that there exists $p \in P \setminus V_{k+1}$. Let $x \in P$. Since $p + nx \in P$ for every $n \in \mathbb{N}$, the pigeonhole principle shows that there exist $j \in \{1, \ldots, k+1\}$ and n < n' such that np + xand n'p + x are both in V_j . In particular the difference of this two vectors is in V_j . Since this difference is (n' - n)p and $p \notin V_{k+1}$ we get $j \in \{1, \ldots, k\}$. Observe that n(n'p + x) - n'(np + x) is the difference of two vectors in V_j . Thus this vector is in V_j and we deduce that $x \in V_j$. We have shown that $P \subseteq \bigcup_{j=1}^k V_j$. By induction there exists $j \in \{1, \ldots, k\}$ such that $P \subseteq V_j$. We have proved the induction.

Finally, assume that $P \subseteq \mathbb{Z}^d$ is a periodic set included in $\bigcup_{j=1}^k b_j + V_j$ where $k \in \mathbb{N}_{>0}$, $b_j \in \mathbb{Z}^d$ and $V_j \subseteq \mathbb{Q}^d$ is a vector space. Let J be the set of $j \in \{1, \ldots, k\}$ such that $b_j \in V_j$ and let us prove that $P \subseteq \bigcup_{j \in J} V_j$. Let $p \in P$. Since $np \in P$ for every $n \in \mathbb{N}$, there exist $j \in \{1, \ldots, k\}$ and n < n' such that np and n'p are both in $b_j + V_j$. The difference of these two vectors shows that (n' - n)p is in V_j . From $b_j \in np - V_j \subseteq V_j$ we deduce that $j \in J$. Thus $P \subseteq \bigcup_{j \in J} V_j$. As $0 \in P$ we deduce that $J \neq \emptyset$ and from the previous paragraph, there exists $j \in J$ such that $P \subseteq V_j$. \Box

Lemma 7.3. We have $\dim(\mathbf{P}) = \operatorname{rank}(\mathbf{V})$ for every periodic set \mathbf{P} where \mathbf{V} is the vector space generated by \mathbf{P} .

Proof. Since $P \subseteq V$ we deduce that $\dim(P) \leq \operatorname{rank}(V)$. For the converse inequality, there exist $k \in \mathbb{N}$, $(b_j)_{1 \leq j \leq k}$ a sequence of vectors $b_j \in \mathbb{Z}^d$ and a sequence $(V_j)_{1 \leq j \leq k}$ of vector spaces $V_j \subseteq \mathbb{Q}^d$ such that $P \subseteq \bigcup_{j=1}^k b_j + V_j$ and such that $\operatorname{rank}(V_j) \leq \dim(P)$ for every j. Since P is non empty we deduce that $k \in \mathbb{N}_{>0}$. Lemma 7.2 proves that there exists $j \in \{1, \ldots, k\}$ such that $P \subseteq V_j$ and $b_j \in V_j$. By minimality of the vector space generated by P we get $V \subseteq V_j$. Hence $\operatorname{rank}(V) \leq \operatorname{rank}(V_j)$. From $\operatorname{rank}(V_j) \leq \dim(P)$ we get $\operatorname{rank}(V) \leq \dim(P)$.

8 Linearizations

A *linearization* of an almost semilinear set X is a set $\bigcup_{j=1}^{k} b_j + (P_j - P_j) \cap \mathbb{Q}_{\geq 0} P_j$ where $b_j \in \mathbb{Z}^d$ and $P_j \subseteq \mathbb{Z}^d$ is an asymptotically definable periodic set such that X =

 $\bigcup_{j=1}^{k} b_j + P_j$. Let us recall that every *subgroup* of $(\mathbb{Z}^d, +)$ is finitely generated[14]. Moreover, since FO $(\mathbb{Q}, +, \leq, 0)$ admits a quantifier elimination algorithm, we deduce that linearizations are definable in the Presburger arithmetic. In this section we show that if $X, Y \subseteq \mathbb{Z}^d$ are two non-empty almost semilinear sets with an empty intersection then every linearizations S, T of X, Y satisfy:

$$\dim(\boldsymbol{S} \cap \boldsymbol{T}) < \dim(\boldsymbol{X} \cup \boldsymbol{Y})$$

Lemma 8.1. Assume that $\mathbf{b} + \mathbf{M} \subseteq (\mathbf{P} - \mathbf{P}) \cap \mathbb{Q}_{\geq 0}\mathbf{P}$ where $\mathbf{b} \in \mathbb{Z}^d$ and $\mathbf{M}, \mathbf{P} \subseteq \mathbb{Z}^d$ are two periodic sets. Let \mathbf{a} be a vector of the form $\mathbf{m}_1 + \cdots + \mathbf{m}_k$ where $(\mathbf{m}_j)_{1 \leq j \leq k}$ is a sequence of vectors $\mathbf{m}_j \in \mathbf{M}$ that generates a vector space that contains \mathbf{P} . There exists $k \in \mathbb{N}_{>0}$ such that $\mathbf{b} + k\mathbb{N}_{>0}\mathbf{a} \subseteq \mathbf{P}$.

Proof. Since $b \in P - P$ there exists $p_+, p_- \in P$ such that $b = p_+ - p_-$. As the sequence $(m_j)_{1 \leq j \leq k}$ generates a vector space that contains P, we get $p_+ \in \sum_{j=1}^k \mathbb{Q}m_j$. Hence there exists $z \in \mathbb{N}_{>0}$ such that $-zp_+ \in \sum_{j=1}^k \mathbb{Z}m_j$. By definition of a, there exists $n \in \mathbb{N}_{>0}$ such that $-zp_+ + na \in \sum_{j=1}^k \mathbb{N}m_j$. Hence $b - zp_+ + na \in b + \sum_{j=1}^k \mathbb{N}m_j$. Since this set is included in $\mathbb{Q}_{\geq 0}P$ and $(z-1)p_+ \in P$ we deduce that $(b-zp_++na)+(z-1)p_+$ is in $\mathbb{Q}_{\geq 0}P$. Note that this vector is equal to $-p_-+na$ since $b = p_+ - p_-$. Hence, there exists $s \in \mathbb{N}_{>0}$ such that $s(-p_- + na) \in P$. Let k = sn and observe that $-p_- + ka = s(-p_- + na) + (s-1)p_-$. Hence $-p_- + ka \in P$. Since $b + ka = (-p_- + ka) + p_+$ and $ka = (-p_- + ka) + p_-$ we deduce that b + ka and ka are both in P. In particular $b + k\mathbb{N}_{>0}a \subseteq P$.

Corollary 8.2. Let $X, Y \subseteq \mathbb{Z}^d$ be two non-empty almost semilinear sets with an empty intersection. For every linearizations S, T of X, Y we have:

$$\dim(\boldsymbol{S} \cap \boldsymbol{T}) < \dim(\boldsymbol{X} \cup \boldsymbol{Y})$$

Proof. We can assume that X = u + P, Y = v + Q where $u, v \in \mathbb{Z}^d$ and $P, Q \subseteq$ \mathbb{Z}^d are two asymptotically definable periodic sets such that $X \cap Y = \emptyset$ and we can assume that S = u + P' where $P' = (P - P) \cap \mathbb{Q}_{\geq 0}P$ and T = v + Q' where $Q' = (Q - Q) \cap \mathbb{Q}_{\geq 0}Q$. Let U and V be the vector spaces generated by P and Q. Lemma 7.3 shows that $\dim(\mathbf{X}) = \operatorname{rank}(\mathbf{U})$ and $\dim(\mathbf{Y}) = \operatorname{rank}(\mathbf{V})$. Note that $\mathbf{S} \cap \mathbf{T}$ is a Presburger set and in particular a finite union of linear sets. If this set is empty the corollary is proved. Otherwise there exists $b \in \mathbb{Z}^d$ and a finitely generated periodic set $M \subseteq \mathbb{Z}^d$ such that $b + M \subseteq S \cap T$ and such that $\dim(S \cap T) = \dim(b + M)$. Let W be the vector space generated by M. Observe that $b + M \subseteq (u + U) \cap (v + V)$. Hence for every $m \in M$ since b + m - u and b + 2m - u are both in U the difference is also in U. Hence $m \in U$. We deduce that $M \subseteq U$ and symmetrically $M \subseteq V$. As M is included in the vector space $U \cap V$, by minimality of W, we get $W \subseteq U \cap V$. Assume by contradiction that W = U and W = V. Since M is finitely generated, there exists a sequence $(m_j)_{1 \le j \le k}$ of vectors $m_j \in M$ such that $M = \mathbb{N}m_1 + \cdots + \mathbb{N}m_k$. Let $a = m_1 + \cdots + m_k$. From $b - u + M \subseteq (P - P) \cap \mathbb{Q}_{\geq 0}P$ and Lemma 8.1 we deduce that there exists $k \in \mathbb{N}_{>0}$ such that $b - u + k\mathbb{N}_{>0}a \subseteq P$. From $b - v + M \subseteq (Q - Q) \cap \mathbb{Q}_{\geq 0}Q$ and Lemma 8.1 we deduce that there exists

 $k' \in \mathbb{N}_{>0}$ such that $b - v + k' \mathbb{N}_{>0} a \subseteq Q$. In particular $b + kk'a \in (u + P) \cap (v + Q)$ and we get a contradiction since this intersection is empty. Thus $W \neq U$ or $W \neq V$. Since $W \subseteq U \cap V$ we deduce that W is strictly included in U or in V. Hence $\operatorname{rank}(W) < \max\{\operatorname{rank}(U), \operatorname{rank}(V)\} = \dim(X \cup Y)$. From Lemma 7.3 we get $\dim(M) = \operatorname{rank}(W)$ and since $\dim(M) = \dim(S \cap T)$ the corollary is proved. \Box

9 Presburger Invariants

We introduce the notion of *separators*. A *separator* is a pair (X, Y) of Presburger sets $X, Y \subseteq \mathbb{N}^d$ such that there does not exist a run from a configuration in X to a configuration in Y. In particular $X \cap Y = \emptyset$. The Presburger set $D = \mathbb{N}^d \setminus (X \cup Y)$ is called the *domain* of (X, Y). We observe that a separator (X, Y) with an empty domain is a partition of \mathbb{N}^d such that X is a Presburger forward inductive invariant and Y is a Presburger backward inductive invariant.

Lemma 9.1. Let (X_0, Y_0) be a separator with a non-empty domain D_0 . There exists a separator (X, Y) with a domain D such that $X_0 \subseteq X$, $Y_0 \subseteq Y$ and dim $(D) < \dim(D_0)$.

Proof. As X_0 , D_0 are Presburger sets, Corollary 6.2 shows that $H = \text{post}^*(X_0) \cap D_0$ is an almost semilinear set. We introduce a linearization S of this set. Since $\text{post}^*(X_0) \cap D_0 \subseteq S$, we deduce that the set $Y = Y_0 \cup (D_0 \setminus S)$ is such that $\text{post}^*(X_0) \cap Y = \emptyset$. Hence (X_0, Y) is a separator. Symmetrically, as D_0, Y are Presburger sets, Corollary 6.2 shows that $K = \text{pre}^*(Y) \cap D_0$ is an almost semilinear set. We introduce a linearization T of this set. Since $\text{pre}^*(Y) \cap D_0 \subseteq T$, we deduce that the set $X = X_0 \cup (D_0 \setminus T)$ is such that $\text{pre}^*(Y) \cap X = \emptyset$. Hence (X, Y) is a separator.

Let us introduce the domain D of (X, Y) and observe that $D = D_0 \cap S \cap T$. If H or K is empty then S or T is empty and in particular D is empty and the lemma is proved. So we can assume that H and K are non empty. Since $H \subseteq \text{post}^*(X_0) \subseteq$ $\text{post}^*(X)$ and $K \subseteq \text{pre}^*(Y)$ and (X, Y) is a separator, we deduce that $H \cap K = \emptyset$. Moreover as $H, K \subseteq D_0$ we deduce that $\dim(H \cup K) \leq \dim(D_0)$. As S and T are linearizations of the non-empty almost semilinear sets H, K and $H \cap K = \emptyset$, Corollary 8.2 shows that $\dim(S \cap T) < \dim(H \cup K)$. Therefore $\dim(D) < \dim(D_0)$.

We deduce the main theorem of this paper.

Theorem 9.2. For every $x, y \in \mathbb{N}^d$ such that there does not exist a run from x to y, then there exists a pair (X, Y) of disjoint Presburger sets $X, Y \subseteq \mathbb{N}^d$ such that X is a forward inductive invariant that contains x and Y is a backward inductive invariant that contains y.

Proof. Observe that $(\{x\}, \{y\})$ is a separator. Thanks to Lemma 9.1 with an immediate induction over the dimension of the domains we deduce that there exists a separator (X, Y) with an empty domain such that $x \in X$ and $y \in Y$.

10 Conclusion

The reachability problem for vector addition systems can be solved with a simple algorithm based on inductive invariants definable in the Presburger arithmetic. This algorithm does not require the classical KLMST decomposition. Note however that the complexity of this algorithm is still open. In fact, the complexity depends on the minimal length of a run from x to y when such a run exists, or the minimal length of a Presburger formula denoting a forward inductive invariant X such that $x \in X$ and $y \notin X$ when such a formula exists. We left as an open question the problem of computing lower and upper bounds for these lengths. Note that the VAS exhibiting a large (Ackermann size) but finite reachability set given in [12] does not directly provide an Ackermann lower-bound for these sizes since Presburger forward invariants can over-approximate reachability sets. Note that the existence of a primitive recursive upper bound of complexity for the reachability problem is still open since the Zakaria Bouziane's paper[1] introducing such a bound was proved to be incorrect by Petr Jančar[6].
