# Noisy low-rank matrix completion with general sampling distribution

#### Abstract

In the present paper we consider the problem of matrix completion with noise for general sampling schemes. Unlike previous works, in our construction we do not need to know or to evaluate the sampling distribution or the variance of the noise. We propose new nuclear-norm penalized estimators, one of them of the "square-root" type. We prove that, up to a logarithmic factor, our estimators achieve optimal rates with respect to the estimation error.


## 1 Introduction

This paper considers the problem of matrix recovery from a small set of noisy observations. Suppose that we observe a small set of entries of a matrix. The problem of inferring the many missing entries from this set of observations is the matrix completion problem. A usual assumption that allows to succeed such a completion is to suppose that the unknown matrix has low rank or has approximately low rank.

The problem of matrix completion comes up in many areas including collaborative filtering, multi-class learning in data analysis, system identification in control, global positioning from partial distance information and computer vision, to mention some of them. For instance, in computer vision, this problem arises as many pixels may be missing in digital images. In collaborative filtering, one wants to make automatic predictions about the preferences of a user by collecting information from many users. So, we have a data matrix where rows are users and columns are items. For each user, we have a partial list of his preferences. We would like to predict the missing rates in order to be able to recommend items that may interest each user.

The noiseless setting was first studied by Candès and Recht [6] using nuclear norm minimization. A tighter analysis of the same convex relaxation was carried out in [7]. For a simpler approach see [21] and [10]. An alternative line of work was developed by Keshavan et al in [12]. A more common situation in applications corresponds to the noisy setting in which the few available entries are corrupted by noise. This problem has been extensively studied recently.

The most popular methods relies on nuclear norm minimization. (see, e.g., $[5,11,22,20,17,18,9,13])$. One can also use rank penalization as it was done by Bunea et al [4] and Klopp [14]. Typically, in the matrix completion problem, the sampling scheme is supposed to be uniform. However, in practice, the observed entries are not guaranteed to follow the uniform scheme and its distribution is not known exactly.

In the present paper we consider nuclear norm penalized estimators and study the corresponding estimation error in Frobenuis norm. We consider both cases when the variance of the noise is known or not. In our construction we do not need to know or to estimate the sampling distribution. Our results are valid for more general sampling schemes than the uniform one: we only assume that the sampling distribution satisfies some mild "regularity" conditions (see Assumptions 1 and 2).

Let $A_{0} \in \mathbb{R}^{m_{1} \times m_{2}}$ be the unknown matrix. Our main results, Theorem 10 and 7 , show the following bound on the normalized Frobenius error of the estimators $\hat{A}$ that we propose in this paper: with high probability

\frac{\left\|\hat{A}-A_{0}\right\|_{2}^{2}}{m_{1} m_{2}} \lesssim \frac{\log \left(m_{1}+m_{2}\right) \max \left(m_{1}, m_{2}\right) \operatorname{rank}\left(A_{0}\right)}{n}
$$

the symbol $\lesssim$ means that the inequality holds up to a multiplicative numerical constant. This theorem guarantees, that the prediction error of our estimator is small whenever $n \gtrsim \log \left(m_{1}+m_{2}\right) \max \left(m_{1}, m_{2}\right) \operatorname{rank}\left(A_{0}\right)$. This quantifies the sample size necessary for successful matrix completion. Note that, when $\operatorname{rank}\left(A_{0}\right)$ is small, this is considerably smaller then $m_{1} m_{2}$, the total number of entries. For large $m_{1}, m_{2}$ and small $r$, this is also quite close to the degree of freedom of a rank $r$ matrix, which is $\left(m_{1}+m_{2}\right) r-r^{2}$.

An important feature of our estimator is that its construction requires only an upper bound on the maximum absolute value of the entries of $A_{0}$. This condition is very mild. A bound on the maximum of the elements is often known in applications. For instance, if the entries of $A_{0}$ are some user's ratings it corresponds to the maximal rating. Previously, the estimators proposed by Koltchinskii et al. [18] and by Klopp [14] also require a bound on the maximum of the elements of the unknown matrix but their constructions use the uniform sampling and additionally require the knowledge of an upper bound on the variance of the noise. Other works on the matrix completion require more involved conditions on the unknown matrix. For more details see Section 3.

More general sampling schemes were previously considered in [19, 20, 8]. In [19], Lounici considers a different estimator and measures the prediction error in the spectral norm. In $[20,8]$ the authors consider penalization using weighted trace-norm, which was first introduced by Srebro et al [23]. For this construction one needs to know the actual sampling distribution or to estimate the empirical frequencies. The weighted trace-norm, used in [20, 8], corrects a specific situation where the standard trace-norm fails. This situation corresponds to a non-uniform distribution where the row/column marginal distribution is such that some columns or rows are sampled with very high probability (for a more
thorough discussion see $[23,8]$ ). Unlike $[20,8]$, we use the standard trace-norm penalization and our assumption on the sampling distribution (Assumption 1) guarantees that no row or column is sampled with very high probability.

Most of the existing methods of matrix completion rely on the knowledge or a pre-estimation of the standard deviation of the noise. The matrix completion problem with unknown variance of the noise was previously considered in [13] using a different estimator which requires uniform sampling. Note also that in [13] the bound on the prediction error is obtained under some additional condition on the rank and the "spikiness ratio" of the matrix. The construction of the present paper is valid for more general sampling distributions and does not require such an extra condition.

The remainder of this paper is organized as follows. In Section 2 we introduce our model and the assumptions on the sampling scheme. For the reader's convenience, we also collect notation which we use throughout the paper. In Section 3 we consider matrix completion in the case of known variance of the noise. We define our estimator and prove Theorem 3 which gives a general bound on its Frobenius error conditionally on bounds for the stochastic terms. Theorem 7, provides bounds on the Frobenius error of our estimator in closed form. Therefore we use bounds on the stochastic terms that we derive in Section 5. To obtain such bounds, we use a non-commutative extension of the classical Bernstein inequality. Such inequalities were first obtained in a pioneering work of Ahlswede et al [1] and Tropp [24]. We use an extension of these ideas to the case of the sub-exponential tails due to Koltchinskii [15].

In Section 4 we consider the case when the variance of the noise is unknown. Our construction uses the idea of "square-root" estimators, first introduced by Belloni et al [2] in the case of the square-root Lasso estimator. Theorem 10, shows that our estimator has the same performances as previously considered estimators which require the knowledge of the standard deviation of the noise and of the sampling distribution.

## 2 Preliminaries

### 2.1 Model and sampling scheme

Let $A_{0} \in \mathbb{R}^{m_{1} \times m_{2}}$ be an unknown matrix, and consider the observations $\left(X_{i}, Y_{i}\right)$ satisfying the trace regression model

\begin{equation*}
Y_{i}=\operatorname{tr}\left(X_{i}^{T} A_{0}\right)+\sigma \xi_{i}, i=1, \ldots, n \tag{1}
\end{equation*}
$$

The noise variables $\xi_{i}$ are independent, with $\mathbb{E}\left(\xi_{i}\right)=0$ and $\mathbb{E}\left(\xi_{i}^{2}\right)=1 ; X_{i}$ are random matrices with dimension $m_{1} \times m_{2}$ and $\operatorname{tr}(A)$ denotes the trace of the matrix $A$. Assume that the design matrices $X_{i}$ are i.i.d copies of a random matrix $X$ having distribution $\Pi$ on the set

\begin{equation*}
\mathcal{X}=\left\{e_{j}\left(m_{1}\right) e_{k}^{T}\left(m_{2}\right), 1 \leq j \leq m_{1}, 1 \leq k \leq m_{2}\right\} \tag{2}
\end{equation*}
$$

where $e_{l}(m)$ are the canonical basis vectors in $\mathbb{R}^{m}$. Then, the problem of estimating $A_{0}$ coincides with the problem of matrix completion with random sampling distribution $\Pi$.

One of the particular settings of this problem is the Uniform Sampling at Random (USR) matrix completion which corresponds to the uniform distribution $\Pi$. We consider a more general weighted sampling model. More precisely, let $\pi_{j k}=\mathbb{P}\left(X=e_{j}\left(m_{1}\right) e_{k}^{T}\left(m_{2}\right)\right)$ be the probability to observe the $(j, k)$-th entry. Let us denote by $C_{k}=\sum_{j=1}^{m_{1}} \pi_{j k}$ the probability to observe an element from the $k$-th column and by $R_{j}=\sum_{k=1}^{m_{2}} \pi_{j k}$ the probability to observe an element from the $j$-th row. Observe that $\max _{i, j}\left(C_{i}, R_{j}\right) \geq 1 / \min \left(m_{1}, m_{2}\right)$.

As it was shown in [23], the trace-norm penalization fails in the specific situation when the row/column marginal distribution is such that some columns or rows are sampled with very high probability (for more details see $[23,8]$ ). To avoid such a situation we need the following assumption on the sampling distribution:

Assumption 1. There exists a positive constant $L \geq 1$ such that

\max _{i, j}\left(C_{i}, R_{j}\right) \leq L / \min \left(m_{1}, m_{2}\right)
$$

In order to get bounds in the Frobenius norm, we suppose that each element is sampled with positive probability:

Assumption 2. There exists a positive constant $\mu \geq 1$ such that

$$
\pi_{j k} \geq\left(\mu m_{1} m_{2}\right)^{-1}
$$

In the case of uniform distribution $L=\mu=1$. Let us set $\|A\|_{L_{2}(\Pi)}^{2}=$ $\mathbb{E}\left(\langle A, X\rangle^{2}\right)$. Assumption 2 implies that

\begin{equation*}
\|A\|_{L_{2}(\Pi)}^{2} \geq\left(m_{1} m_{2} \mu\right)^{-1}\|A\|_{2}^{2} \tag{3}
\end{equation*}
$$

### 2.2 Notation

We provide a brief summary of the notation used throughout this paper. Let $A, B$ be matrices in $\mathbb{R}^{m_{1} \times m_{2}}$.

- We define the scalar product $\langle A, B\rangle=\operatorname{tr}\left(A^{T} B\right)$.
- For $0<q \leq \infty$ the Schatten-q (quasi-)norm of the matrix $A$ is defined by

$$
\|A\|_{q}=\left(\sum_{j=1}^{\min \left(m_{1}, m_{2}\right)} \sigma_{j}(A)^{q}\right)^{1 / q} \text { for } 0<q<\infty \text { and }\|A\|=\sigma_{1}(A)
$$

where $\left(\sigma_{j}(A)\right)_{j}$ are the singular values of $A$ ordered decreasingly.

- $\|A\|_{\infty}=\max _{i, j}\left|a_{i j}\right|$ where $A=\left(a_{i j}\right)$.
- $P_{S}$ is the projector on the linear vector subspace $S$.
- $S^{\perp}$ is the orthogonal complement of $S$.
- Let $u_{j}(A)$ and $v_{j}(A)$ denote respectively the left and right orthonormal singular vectors of $A, S_{1}(A)$ is the linear span of $\left\{u_{j}(A)\right\}, S_{2}(A)$ is the linear span of $\left\{v_{j}(A)\right\}$.
- Let $\mathbf{P}_{A}^{\perp}(B)=P_{S_{1}^{\perp}(A)} B P_{S_{2}^{\perp}(A)}$ and $\mathbf{P}_{A}(B)=B-\mathbf{P}_{A}^{\perp}(B)$.
- Let $\pi_{i, j}=\mathbb{P}\left(X=e_{i}\left(m_{1}\right) e_{j}^{T}\left(m_{2}\right)\right)$ be the probability to observe the $(i, j)$ th element.
- For $j=1 \ldots m_{2}, C_{j}=\sum_{i=1}^{m_{1}} \pi_{i j}$ and for $i=1 \ldots m_{1}, R_{i}=\sum_{j=1}^{m_{2}} \pi_{i j}$.
- $R=\operatorname{diag}\left(R_{1}, \ldots, R_{m_{1}}\right)$ and $C=\operatorname{diag}\left(C_{1}, \ldots, C_{m_{2}}\right)$.
- Let $M=\max \left(m_{1}, m_{2}\right), m=\min \left(m_{1}, m_{2}\right)$ and $d=m_{1}+m_{2}$.
- $\|A\|_{L_{2}(\Pi)}^{2}=\mathbb{E}\left(\langle A, X\rangle^{2}\right)$.
- Let $\left\{\epsilon_{i}\right\}_{i=1}^{n}$ be an i.i.d. Rademacher sequence and we define

$$
\begin{equation*}
\Sigma_{R}=\frac{1}{n} \sum_{i=1}^{n} \epsilon_{i} X_{i} \quad \text { and } \quad \Sigma=\frac{\sigma}{n} \sum_{i=1}^{n} \xi_{i} X_{i} \tag{4}
\end{equation*}
$$

- Define the observation operator $\mathcal{O}: \mathbb{R}^{m_{1} \times m_{2}} \rightarrow \mathbb{R}^{n}$ as $(\mathcal{O}(A))_{i}=\left\langle X_{i}, A\right\rangle$.
- $Q(A)=\sqrt{\frac{1}{n} \sum_{i=1}^{n}\left(Y_{i}-\left\langle X_{i}, A\right\rangle\right)^{2}}$.


## 3 Matrix completion with known variance of the noise

In this section we consider the matrix completion problem when the variance of the noise is known. We define the following estimator of $A_{0}$ :

$$
\begin{equation*}
\hat{A}=\underset{\|A\|_{\infty} \leq \mathrm{a}}{\arg \min }\left\{\frac{1}{n} \sum_{i=1}^{n}\left(Y_{i}-\left\langle X_{i}, A\right\rangle\right)^{2}+\lambda\|A\|_{1}\right\}, \tag{5}
\end{equation*}
$$

where $\lambda>0$ is a regularization parameter and $\mathbf{a}$ is an upper bound on $\left\|A_{0}\right\|_{\infty}$.
The following theorem gives a general upper bound on the prediction error of estimator $\hat{A}$. Its proof is given in Appendix A. The stochastic terms $\|\Sigma\|$ and $\left\|\Sigma_{R}\right\|$ play a key role in what follows.

Theorem 3. Let $X_{i}$ be i.i.d. with distribution $\Pi$ on $\mathcal{X}$ which satisfies Assumption 2 and 1 and $\lambda>3\|\Sigma\|$. Assume that $\left\|A_{0}\right\|_{\infty} \leq \mathbf{a}$ for some constant a. Then, there exist numerical constants $\left(c_{1}, c_{2}\right)$ such that
$\frac{\left\|\hat{A}-A_{0}\right\|_{2}^{2}}{m_{1} m_{2}} \leq \max \left\{c_{1} \mu^{2} m_{1} m_{2} \operatorname{rank}\left(A_{0}\right)\left(\lambda^{2}+\mathbf{a}^{2}\left(\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)\right)^{2}\right), c_{2} \mathbf{a}^{2} \mu \sqrt{\frac{\log (d)}{n}}\right\}$.
with probability at least $1-\frac{2}{d}$, where $d=m_{1}+m_{2}$.
In order to get a bound in a closed form we need to obtain suitable upper bounds on $\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)$ and, with probability close to 1 , on $\|\Sigma\|$. We will obtain such bounds in the case of sub-exponential noise i.e. under the following assumption:

## Assumption 4.

$$
\max _{i=1, \ldots, n} \mathbb{E} \exp \left(\left|\xi_{i}\right| / K\right)<\infty
$$

Let $K>0$ be a constant such that $\max _{i=1, \ldots, n} \mathbb{E} \exp \left(\left|\xi_{i}\right| / K\right) \leq e$. The following two lemmas give bounds on $\|\Sigma\|$ and $\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)$. We prove them in Section 5 using the non-commutative Bernstein inequality.

Lemma 5. Let $X_{i}$ be i.i.d. with distribution $\Pi$ on $\mathcal{X}$ which satisfies Assumption 1 and 2. Assume that $\left(\zeta_{i}\right)_{i=1}^{n}$ are independent with $\mathbb{E}\left(\zeta_{i}\right)=0, \mathbb{E}\left(\zeta_{i}^{2}\right)=1$ and satisfy Assumption 4. Then, there exists an absolute constant $C^{*}>0$ that depends only on $K$ and such that, for all $t>0$ with probability at least $1-e^{-t}$ we have

$$
\begin{equation*}
\left\|\frac{1}{n} \sum_{i=1}^{n} \zeta_{i} X_{i}\right\| \leq C^{*} \max \left\{\sqrt{\frac{L(t+\log (d))}{m n}}, \frac{\log (m)(t+\log (d))}{n}\right\} \tag{6}
\end{equation*}
$$

where $d=m_{1}+m_{2}$.
Lemma 6. Let $X_{i}$ be i.i.d. with distribution $\Pi$ on $\mathcal{X}$ which satisfies Assumption 1 and 2. Assume that $\left(\zeta_{i}\right)_{i=1}^{n}$ are independent with $\mathbb{E}\left(\zeta_{i}\right)=0, \mathbb{E}\left(\zeta_{i}^{2}\right)=1$ and satisfy Assumption 4. Then, for $n \geq m \log ^{3}(d) / L$, there exists an absolute constant $C^{*}>0$ such that

$$
\mathbb{E}\left\|\frac{1}{n} \sum_{i=1}^{n} \zeta_{i} X_{i}\right\| \leq C^{*} \sqrt{\frac{2 e L \log (d)}{n m}}
$$

where $d=m_{1}+m_{2}$.
An optimal choice of the parameter $t$ in these lemmas is $t=\log (d)$. Larger $t$ leads to a slower rate of convergence and a smaller $t$ does not improve the rate but makes the concentration probability smaller. With this choice of $t$ the second
terms in the maximum in (6) is negligible for $n>n^{*}$ where $n^{*}=2 \log ^{2}(d) m / L$. Then, we can choose

$$
\begin{equation*}
\lambda=3 C^{*} \sigma \sqrt{\frac{2 L \log (d)}{m n}} . \tag{7}
\end{equation*}
$$

where $C^{*}$ is an absolute numerical constant which depends only on $K$. If $\xi_{i}$ are $N(0,1)$, then we can take $C^{*}=6.5$ (see Lemma 4 in [13]). With this choice of $\lambda$ we obtain the following Theorem.

Theorem 7. Let $X_{i}$ be i.i.d. with distribution $\Pi$ on $\mathcal{X}$ which satisfies Assumption 2 and 1. Assume that $\left\|A_{0}\right\|_{\infty} \leq \mathbf{a}$ for some constant $\mathbf{a}$ and that Assumption 4 holds. Consider the regularization parameter $\lambda$ satisfying (7). Then, there exist numerical constant $c^{\prime}$ such that

$$
\begin{equation*}
\frac{\left\|\hat{A}-A_{0}\right\|_{2}^{2}}{m_{1} m_{2}} \leq c^{\prime} \max \left\{\max \left(\sigma^{2}, \mathbf{a}^{2}\right) \mu^{2} L \frac{\log (d) \operatorname{rank}\left(A_{0}\right) M}{n}, \mathbf{a}^{2} \mu \sqrt{\frac{\log (d)}{n}}\right\} \tag{8}
\end{equation*}
$$

with probability greater than $1-3 / d$.
An important feature of our estimator is that its construction requires only an upper bound on the maximum absolute value of the entries of $A_{0}$ (and an upper bound on the variance of the noise). This condition is very mild. Let us compare it with the conditions used in previous work on the noisy matrix completion. Except [13], the previous estimators require the prior knowledge of an upper bound on the standard deviation of the noise. In addition, in [11], a prior information on the rank of the unknown matrix as well as a matrix incoherence assumption ( which is stated in terms of the singular vectors of $A_{0}$ ) are required. In [20] a prior information on the "spikiness ratio" $\alpha_{s p}=$ $\frac{\sqrt{m_{1} m_{2}}\left\|A_{0}\right\|_{\infty}}{\left\|A_{0}\right\|_{2}}$ of $A_{0}$ is needed. In $[18,14,13]$, similarly to our construction, a prior bound on $\left\|A_{0}\right\|_{\infty}$ is required. An important difference is that, in these papers, the upper bound is used in the choice of the regularization parameter $\lambda$. This implies the dependence on a of the convex functional which is minimized in order to obtain $\hat{A}$. A too large bound may jeopardize exactness of the estimation. In our construction, a determines the ball over which we are minimizing our convex functional, which itself is independent of $\mathbf{a}$.

## 4 Matrix completion with unknown variance of the noise

In this section we propose a new estimator for the matrix completion problem in the case when the variance of the noise $\sigma$ is unknown. Our construction is inspired by the square-root Lasso estimator proposed in [2]. We define the following estimator of $A_{0}$ :

$$
\begin{equation*}
\hat{A}_{S Q}=\underset{\|A\|_{\infty} \leq \mathbf{a}}{\arg \min }\left\{\sqrt{\frac{1}{n} \sum_{i=1}^{n}\left(Y_{i}-\left\langle X_{i}, A\right\rangle\right)^{2}}+\lambda\|A\|_{1}\right\} \tag{9}
\end{equation*}
$$

where $\lambda>0$ is a regularization parameter and $\mathbf{a}$ is an upper bound on $\left\|A_{0}\right\|_{\infty}$. Note that the first term of this estimator is the square root of the data-dependent term of the estimator that we considered in Section 3. This is similar to the principle used to define the square-root Lasso estimator for the usual vector regression model.

Let us set $\rho=\frac{1}{16 \mu m_{1} m_{2} \operatorname{rank}\left(A_{0}\right)}$. The following theorem gives a general upper bound on the prediction error of the estimator $\hat{A}_{S Q}$. Its proof is given in Appendix D.

Theorem 8. Let $X_{i}$ be i.i.d. with distribution $\Pi$ on $\mathcal{X}$ which satisfies Assumption 2 and 1 and $\sqrt{\rho} \geq \lambda \geq 3\|\Sigma\| / Q\left(A_{0}\right)$. Then, there exist numerical constants $\left(c_{1}^{\prime}, c_{2}\right)$ such that

$$
\begin{aligned}
& \frac{\left\|\hat{A}_{S Q}-A_{0}\right\|_{2}^{2}}{m_{1} m_{2}} \leq \max \left\{c_{1}^{\prime} \mu^{2} m_{1} m_{2} \operatorname{rank}\left(A_{0}\right)\left(Q^{2}\left(A_{0}\right) \lambda^{2}+\mathbf{a}^{2}\left(\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)\right)^{2}\right),\right. \\
& \left.c_{2} \mathbf{a}^{2} \mu \sqrt{\frac{\log (d)}{n}}\right\} .
\end{aligned}
$$

with probability at least $1-\frac{2}{d}$.
In order to get a bound on the prediction risk in a closed form we use the bounds on $\|\Sigma\|$ and $\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)$ given by Lemmas 5 and 6 taking $t=\log (d)$. It remains to bound $Q\left(A_{0}\right)=\sigma \sqrt{\frac{1}{n} \sum_{i=1}^{n} \xi_{i}^{2}}$. We consider the case of sub-Gaussian noise:

Assumption 9. There exists a constant $K$ such that

$$
\mathbb{E}\left[\exp \left(t \xi_{i}\right)\right] \leq \exp \left(t^{2} / 2 K\right)
$$

for all $t>0$.
Note that condition $\mathbb{E} \xi_{i}^{2}=1$ implies that $K \leq 1$. Under Assumption 9, $\xi_{i}^{2}$ are sub-exponential random variables. Then, the Bernstein inequality for subexponential random variables implies that, there exists a numerical constant $c_{3}$ such that, with probability at least $1-2 \exp \left\{-c_{3} n\right\}$, one has

\begin{equation*}
3 \sigma / 2 \geq Q\left(A_{0}\right) \geq \sigma / 2 \tag{10}
\end{equation*}
$$

Using Lemma 5 and the right-hand side of (10), for $n \geq 2 \log ^{2}(d) m / L$, we can take

\lambda=6 C^{*} \sqrt{\frac{2 L \log (d)}{m n}} \tag{11}
\end{equation*}
$$

Note that $\lambda$ does not depend on $\sigma$ and satisfies the two conditions required in Theorem 8. We have that

\lambda \geq 3\|\Sigma\| / Q\left(A_{0}\right) \tag{12}
\end{equation*}
$$

with probability greater then $1-1 / d-2 \exp \left\{-c_{3} n\right\}$ and

$$
\begin{equation*}
\lambda^{2} \leq \frac{1}{16 \mu m_{1} m_{2} \operatorname{rank}\left(A_{0}\right)} \tag{13}
\end{equation*}
$$

for $n$ large enough, more precisely, for $n$ such that

$$
\begin{equation*}
n \geq c_{4} \mu L M \operatorname{rank}\left(A_{0}\right) \log (d) \tag{14}
\end{equation*}
$$

where $c_{4}=576\left(C^{*}\right)^{2}$. We obtain the following theorem.
Theorem 10. Let $X_{i}$ be i.i.d. with distribution $\Pi$ on $\mathcal{X}$ which satisfies Assumption 1 and 2. Assume that $\left\|A_{0}\right\| \leq \mathbf{a}$ for some constant $\mathbf{a}$ and that Assumption 9 holds. Consider regularization parameter $\lambda$ satisfying (11) and $n$ satisfying (14). Then, there exist numerical constants $\left(c^{\prime \prime}, c_{3}\right)$ such that,

$$
\begin{equation*}
\frac{\left\|\hat{A}_{S Q}-A_{0}\right\|_{2}^{2}}{m_{1} m_{2}} \leq c^{\prime \prime} \max \left\{\max \left(\sigma^{2}, \mathbf{a}^{2}\right) \mu^{2} L \frac{\log (d) \operatorname{rank}\left(A_{0}\right) M}{n}, \mathbf{a}^{2} \mu \sqrt{\frac{\log (d)}{n}}\right\} \tag{15}
\end{equation*}
$$

with probability greater than $1-3 / d-2 \exp \left\{-c_{3} n\right\}$.
Note that condition (14) is not restrictive: indeed the sampling sizes $n$ satisfying condition (14) are of the same order of magnitude as those for which the normalized Frobenius error of our estimator is small. Thus, Theorem 10 shows, that $\hat{A}_{S Q}$ has the same prediction performances as previously proposed estimators which rely on the knowledge of the standard deviation of the noise and of the sampling distribution.

## 5 Bounds on the stochastic errors

In this section we will obtain the upper bounds for the stochastic errors $\left\|\Sigma_{R}\right\|$ and $\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)$ defined in (4). In order to obtain such bounds we use the matrix version of Bernstein's inequality. The following proposition is obtained by an extension of Theorem 4 in [15] to rectangular matrices via self-adjoint dilation (cf., for example 2.6 in [24]) . Let $Z_{1}, \ldots, Z_{n}$ be independent random matrices with dimensions $m_{1} \times m_{2}$. Define

$$
\sigma_{Z}=\max \left\{\left\|\frac{1}{n} \sum_{i=1}^{n} \mathbb{E}\left(Z_{i} Z_{i}^{T}\right)\right\|^{1 / 2},\left\|\frac{1}{n} \sum_{i=1}^{n} \mathbb{E}\left(Z_{i}^{T} Z_{i}\right)\right\|^{1 / 2}\right\}
$$

and

$$
U_{i}=\inf \left\{K>0: \mathbb{E} \exp \left(\left\|Z_{i}\right\| / K\right) \leq e\right\}
$$

Proposition 11. Let $Z_{1}, \ldots, Z_{n}$ be independent random matrices with dimensions $m_{1} \times m_{2}$ that satisfy $\mathbb{E}\left(Z_{i}\right)=0$. Suppose that $U_{i}<U$ for some constant
$U$ and all $i=1, \ldots, n$. Then, there exists an absolute constant $c^{*}$, such that, for all $t>0$, with probability at least $1-e^{-t}$ we have

$$
\left\|\frac{1}{n} \sum_{i=1}^{n} Z_{i}\right\| \leq c^{*} \max \left\{\sigma_{Z} \sqrt{\frac{t+\log (d)}{n}}, U\left(\log \frac{U}{\sigma_{Z}}\right) \frac{t+\log (d)}{n}\right\}
$$

where $d=m_{1}+m_{2}$.

### 5.1 Proof of Lemma 5

We apply Proposition 11 to $Z_{i}=\zeta_{i} X_{i}$. We first estimate $\sigma_{Z}$ and $U$. Note that $Z_{i}$ is a zero-mean random matrix which satisfies

$$
\left\|Z_{i}\right\| \leq\left|\zeta_{i}\right|
$$

Then, Assumption 4 implies that there exists a constant $K$ such that $U_{i} \leq K$ for all $i=1, \ldots, n$. We compute

\mathbb{E}\left(Z_{i} Z_{i}^{T}\right)=R \quad \text { and } \quad \mathbb{E}\left(Z_{i}^{T} Z_{i}\right)=C
$$

where $C$ (resp. $R$ ) is the diagonal matrix with $C_{k}$ (resp. $R_{j}$ ) on the diagonal. This and the fact that $X_{i}$ are i.i.d. implies that

$$
\sigma_{Z}^{2}=\max _{i, j}\left(C_{i}, R_{j}\right) \leq L / m
$$

Note that $\max _{i, j}\left(C_{i}, R_{j}\right) \geq 1 / m$ which implies that $\log \left(K / \sigma_{Z}\right) \leq \log (K m)$ and the statement of Lemma 5 follows.

### 5.2 Proof of Lemma 6

The proof follows the lines of the proof of Lemma 7 in [14]. For sake of completeness we give it here. Set $t^{*}=\frac{L n}{m \log ^{2}(m)}-\log (d) . t^{*}$ is the value of $t$ such that the two terms in (6) are equal. Note that Lemma 5 implies that

\begin{equation*}
\mathbb{P}\left(\left\|\frac{1}{n} \sum_{i=1}^{n} \zeta_{i} X_{i}\right\|>t\right) \leq d \exp \left\{-t^{2} n m /\left(\left(C^{*}\right)^{2} L\right)\right\} \quad \text { for } \quad t \leq t^{*} \tag{16}
\end{equation*}
$$

and

$$
\begin{equation*}
\mathbb{P}\left(\left\|\frac{1}{n} \sum_{i=1}^{n} \zeta_{i} X_{i}\right\|>t\right) \leq d \exp \left\{-t n /\left(C^{*} \log (m)\right)\right\} \quad \text { for } \quad t \geq t^{*} \tag{17}
\end{equation*}
$$

We set $\nu_{1}=n m /\left(\left(C^{*}\right)^{2} L\right), \nu_{2}=n /\left(C^{*} \log (m)\right)$. By Hölder's inequality we get

$$
\mathbb{E}\left\|\frac{1}{n} \sum_{i=1}^{n} \zeta_{i} X_{i}\right\| \leq\left(\mathbb{E}\left\|\frac{1}{n} \sum_{i=1}^{n} \zeta_{i} X_{i}\right\|^{2 \log (d)}\right)^{1 /(2 \log (d))}
$$

The inequalities (16) and (17) imply that

$$
\begin{align*}
& \left(\mathbb{E}\left\|\frac{1}{n} \sum_{i=1}^{n} \zeta_{i} X_{i}\right\|^{2 \log (d)}\right)^{1 / 2 \log (d)}=\left(\int_{0}^{+\infty} \mathbb{P}\left(\left\|\frac{1}{n} \sum_{i=1}^{n} \zeta_{i} X_{i}\right\|>t^{1 /(2 \log (d))}\right) \mathrm{d} t\right)^{1 / 2 \log (d)} \\
& \leq\left(d \int_{0}^{+\infty} \exp \left\{-t^{1 / \log (d)} \nu_{1}\right\} \mathrm{d} t+d \int_{0}^{+\infty} \exp \left\{-t^{1 /(2 \log (d)} \nu_{2}\right\} \mathrm{d} t\right)^{1 / 2 \log (d)} \\
& \quad \leq \sqrt{e}\left(\log (d) \nu_{1}^{-\log (d)} \Gamma(\log (d))+2 \log (d) \nu_{2}^{-2 \log (d)} \Gamma(2 \log (d))\right)^{1 /(2 \log (d))} \tag{18}
\end{align*}
$$

The Gamma-function satisfies the following bound:

$$
\begin{equation*}
\text { for } \quad x \geq 2, \quad \Gamma(x) \leq\left(\frac{x}{2}\right)^{x-1} \tag{19}
\end{equation*}
$$

(see e.g. [14] ). Plugging this into (18) we compute

\begin{aligned}
\mathbb{E}\left\|\frac{1}{n} \sum_{i=1}^{n} \zeta_{i} X_{i}\right\| & \leq \sqrt{e}\left((\log (d))^{\log (d)} \nu_{1}^{-\log (d)} 2^{1-\log (d)}\right. \\
& \left.+2(\log (d))^{2 \log (d)} \nu_{2}^{-2 \log (d)}\right)^{1 /(2 \log (d))}
\end{aligned}
$$

Observe that $n>n^{*}$ implies $\nu_{1} \log (d) \leq \nu_{2}^{2}$ and we obtain

$$
\begin{equation*}
\mathbb{E}\left\|\frac{1}{n} \sum_{i=1}^{n} \zeta_{i} X_{i}\right\| \leq \sqrt{\frac{2 e \log (d)}{\nu_{1}}} \tag{20}
\end{equation*}
$$

We conclude the proof by plugging $\nu_{1}=n m /\left(\left(C^{*}\right)^{2} L\right)$ into (20).

## A Proof of Theorem 3

It follows from the definition of the estimator $\hat{A}$ that

which, using (1), implies

\frac{1}{n} \sum_{i=1}^{n}\left(\left\langle X_{i}, A_{0}\right\rangle+\sigma \xi_{i}-\left\langle X_{i}, \hat{A}\right\rangle\right)^{2}+\lambda\|\hat{A}\|_{1} \leq \frac{\sigma^{2}}{n} \sum_{i=1}^{n} \xi_{i}^{2}+\lambda\left\|A_{0}\right\|_{1}
$$

Hence,

$$
\frac{1}{n} \sum_{i=1}^{n}\left\langle X_{i}, A_{0}-\hat{A}\right\rangle^{2}+2\left\langle\Sigma, A_{0}-\hat{A}\right\rangle+\lambda\|\hat{A}\|_{1} \leq \lambda\left\|A_{0}\right\|_{1}
$$

where $\Sigma=\frac{\sigma}{n} \sum_{i=1}^{n} \xi_{i} X_{i}$. Then, by the duality between the nuclear and the operator norms, we obtain

$$
\begin{equation*}
\frac{1}{n}\left\|\mathcal{O}\left(A_{0}-\hat{A}\right)\right\|_{2}^{2}+\lambda\|\hat{A}\|_{1} \leq 2\|\Sigma\|\left\|A_{0}-\hat{A}\right\|_{1}+\lambda\left\|A_{0}\right\|_{1} . \tag{21}
\end{equation*}
$$

Note that from (38) we get

\begin{equation*}
\left\|A_{0}\right\|_{1}-\|\hat{A}\|_{1} \leq\left\|\mathbf{P}_{A_{0}}\left(A_{0}-\hat{A}\right)\right\|_{1}-\left\|\mathbf{P}_{A_{0}}^{\perp}\left(A_{0}-\hat{A}\right)\right\|_{1} . \tag{22}
\end{equation*}
$$

This, the triangle inequality and $\lambda \geq 3\|\Sigma\|$ lead to

\begin{align*}
\frac{1}{n}\left\|\mathcal{O}\left(A_{0}-\hat{A}\right)\right\|_{2}^{2} & \leq 2\|\Sigma\|\left\|\mathbf{P}_{A_{0}}\left(A_{0}-\hat{A}\right)\right\|_{1}+\lambda\left\|\mathbf{P}_{A_{0}}\left(A_{0}-\hat{A}\right)\right\|_{1}  \tag{23}\\
& \leq \frac{5}{3} \lambda\left\|\mathbf{P}_{A_{0}}\left(A_{0}-\hat{A}\right)\right\|_{1}
\end{align*}
$$

Since $\mathbf{P}_{A}(B)=P_{S_{1}^{\perp}(A)} B P_{S_{2}(A)}+P_{S_{1}(A)} B$ and $\operatorname{rank}\left(P_{S_{i}(A)} B\right) \leq \operatorname{rank}(A)$ we have that $\operatorname{rank}\left(\mathbf{P}_{A}(B)\right) \leq 2 \operatorname{rank}(A)$. From (23) we compute

$$
\begin{equation*}
\frac{1}{n}\left\|\mathcal{O}\left(A_{0}-\hat{A}\right)\right\|_{2}^{2} \leq \frac{5}{3} \lambda \sqrt{2 \operatorname{rank}\left(A_{0}\right)}\left\|\hat{A}-A_{0}\right\|_{2} . \tag{24}
\end{equation*}
$$

For a $0<r \leq m$ we consider the following constrain set
$\mathcal{C}(r)=\left\{A \in \mathbb{R}^{m_{1} \times m_{2}}:\|A\|_{\infty}=1,\|A\|_{L_{2}(\Pi)}^{2} \geq \sqrt{\frac{64 \log (d)}{\log (6 / 5) n}},\|A\|_{1} \leq \sqrt{r}\|A\|_{2}\right\}$.
Note that the condition $\|A\|_{1} \leq \sqrt{r}\|A\|_{2}$ is satisfied if $\operatorname{rank}(A) \leq r$.
The following lemma shows that for matrices $A \in \mathcal{C}(r)$ the observation operator $\mathcal{O}$ satisfies some approximative restricted isometry. Its proof is given in Appendix B.

Lemma 12. Let $X_{i}$ be i.i.d. with distribution $\Pi$ on $\mathcal{X}$ which satisfies Assumption 2 and 1. Then, for all $A \in \mathcal{C}(r)$

$$
\frac{1}{n}\|\mathcal{O}(\mathcal{A})\|_{2}^{2} \geq \frac{1}{2}\|A\|_{L_{2}(\Pi)}^{2}-44 \mu r m_{1} m_{2}\left(\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)\right)^{2}
$$

with probability at least $1-\frac{2}{d}$.
We need the following auxiliary lemma which is proven in Appendix E.
Lemma 13. If $\lambda>3\|\Sigma\|$

$$
\left\|\mathbf{P}_{A_{0}}^{\perp}\left(\hat{A}-A_{0}\right)\right\|_{1} \leq 5\left\|\mathbf{P}_{A_{0}}\left(\hat{A}-A_{0}\right)\right\|_{1}
$$

Lemma 13 implies that

$$
\left\|\hat{A}-A_{0}\right\|_{1} \leq 6\left\|\mathbf{P}_{A_{0}}\left(\hat{A}-A_{0}\right)\right\|_{1} \leq \sqrt{72 \operatorname{rank}\left(A_{0}\right)}\left\|\hat{A}-A_{0}\right\|_{2} .
$$

Set $a=\left\|\hat{A}-A_{0}\right\|_{\infty}$. By definition of $\hat{A}$ we have that $a \leq 2 \mathbf{a}$. We now consider two cases, depending on whether the matrix $\frac{1}{a}\left(\hat{A}-A_{0}\right)$ belongs to the set $\mathcal{C}\left(72 \operatorname{rank}\left(A_{0}\right)\right)$ or not.

Case 1: Suppose first that $\left\|\hat{A}-A_{0}\right\|_{L_{2}(\Pi)}^{2}<a^{2} \sqrt{\frac{64 \log (d)}{\log (6 / 5) n}}$, then (3) implies that

$$
\begin{equation*}
\frac{\left\|\hat{A}-A_{0}\right\|_{2}^{2}}{m_{1} m_{2}} \leq 4 \mathbf{a}^{2} \mu \sqrt{\frac{64 \log (d)}{\log (6 / 5) n}} \tag{26}
\end{equation*}
$$

and we get the statement of the Theorem 3 in this case.
Case 2: It remains to consider the case $\left\|\hat{A}-A_{0}\right\|_{L_{2}(\Pi)}^{2} \geq a^{2} \sqrt{\frac{64 \log (d)}{\log (6 / 5) n}}$. Lemma 13 implies that $\frac{1}{a}\left(\hat{A}-A_{0}\right) \in \mathcal{C}\left(72 \operatorname{rank}\left(A_{0}\right)\right)$ and we can apply Lemma 12. From Lemma 12 and (24) we obtain that with probability at least $1-\frac{2}{d}$ one has

\frac{1}{2}\left\|\hat{A}-A_{0}\right\|_{L_{2}(\Pi)}^{2} \leq & \frac{5}{3} \lambda \sqrt{2 \operatorname{rank}\left(A_{0}\right)}\left\|\hat{A}-A_{0}\right\|_{2}+3168 \mu a^{2} \operatorname{rank}\left(A_{0}\right) m_{1} m_{2}\left(\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)\right)^{2} \\
\leq & 6 \lambda^{2} \mu m_{1} m_{2} \operatorname{rank}\left(A_{0}\right)+\frac{1}{4}\left(m_{1} m_{2} \mu\right)^{-1}\left\|\hat{A}-A_{0}\right\|_{2}^{2} \\
& +3168 \mu a^{2} \operatorname{rank}\left(A_{0}\right) m_{1} m_{2}\left(\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)\right)^{2}
\end{aligned}
$$

Now (3) and $a \leq 2 \mathbf{a}$ imply that, there exist numerical constants $c_{1}$ such that

$$
\left\|\hat{A}-A_{0}\right\|_{2}^{2} \leq c_{1}\left(\mu m_{1} m_{2}\right)^{2} \operatorname{rank}\left(A_{0}\right)\left(\lambda^{2}+\mathbf{a}^{2}\left(\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)\right)^{2}\right)
$$

which, together with (26), leads to the statement of the Theorem 3.

## B Proof of Lemma 12

The main lines of this proof are close to those of the proof of Theorem 1 in [20]. Set $\mathcal{E}=44 \mu r m_{1} m_{2}\left(\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)\right)^{2}$. We will show that the probability of the following "bad" event is small

\mathcal{B}=\left\{\exists A \in \mathcal{C}(r) \text { such that }\left|\frac{1}{n}\|\mathcal{O}(A)\|_{2}^{2}-\|A\|_{L_{2}(\Pi)}^{2}\right|>\frac{1}{2}\|A\|_{L_{2}(\Pi)}^{2}+\mathcal{E}\right\} .
$$

Note that $\mathcal{B}$ contains the complement of the event that we are interested in.

In order to estimate the probability of $\mathcal{B}$ we use a standard peeling argument.
Let $\nu=\sqrt{\frac{64 \log (d)}{\log (6 / 5) n}}$ and $\alpha=\frac{6}{5}$. For $l \in \mathbb{N}$ set

S_{l}=\left\{A \in \mathcal{C}(r): \alpha^{l-1} \nu \leq\|A\|_{L_{2}(\Pi)}^{2} \leq \alpha^{l} \nu\right\}
$$

If the event $\mathcal{B}$ holds for some matrix $A \in \mathcal{C}(r)$, then $A$ belongs to some $S_{l}$ and

$$
\begin{align*}
\left|\frac{1}{n}\|\mathcal{O}(A)\|_{2}^{2}-\|A\|_{L_{2}(\Pi)}^{2}\right| & >\frac{1}{2}\|A\|_{L_{2}(\Pi)}^{2}+\mathcal{E} \\
& >\frac{1}{2} \alpha^{l-1} \nu+\mathcal{E}  \tag{27}\\
& =\frac{5}{12} \alpha^{l} \nu+\mathcal{E}
\end{align*}
$$

For each $T>\nu$ consider the following set of matrices

$$
\mathcal{C}(r, T)=\left\{A \in \mathcal{C}(r):\|A\|_{L_{2}(\Pi)}^{2} \leq T\right\}
$$

and the following event

$$
\mathcal{B}_{l}=\left\{\exists A \in \mathcal{C}\left(r, \alpha^{l} \nu\right):\left|\frac{1}{n}\|\mathcal{O}(A)\|_{2}^{2}-\|A\|_{L_{2}(\Pi)}^{2}\right|>\frac{5}{12} \alpha^{l} \nu+\mathcal{E}\right\}
$$

Note that $A \in S_{l}$ implies that $A \in \mathcal{C}\left(r, \alpha^{l} \nu\right)$. Then (27) implies that $\mathcal{B}_{l}$ holds and we get $\mathcal{B} \subset \cup \mathcal{B}_{l}$. Thus, it is enough to estimate the probability of the simpler event $\mathcal{B}_{l}$ and then apply the union bound. Such an estimation is given by the following lemma. Its proof is given in Appendix C. Let

Z_{T}=\sup _{A \in \mathcal{C}(r, T)}\left|\frac{1}{n}\|\mathcal{O}(A)\|_{2}^{2}-\|A\|_{L_{2}(\Pi)}^{2}\right|
$$

Lemma 14. Let $X_{i}$ be i.i.d. with distribution $\Pi$ on $\mathcal{X}$ which satisfies Assumption 2 and 1. Then,

$$
\mathbb{P}\left(Z_{T}>\frac{5}{12} T+44 \mu r m_{1} m_{2}\left(\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)\right)^{2}\right) \leq \exp \left(-c_{5} n T^{2}\right)
$$

where $c_{5}=\frac{1}{128}$.
Lemma 14 implies that $\mathbb{P}\left(\mathcal{B}_{l}\right) \leq \exp \left(-c_{5} n \alpha^{2 l} \nu^{2}\right)$. Using the union bound we obtain

$$
\begin{aligned}
\mathbb{P}(\mathcal{B}) & \leq \sum_{l=1}^{\infty} \mathbb{P}\left(\mathcal{B}_{l}\right) \\
& \leq \sum_{l=1}^{\infty} \exp \left(-c_{5} n \alpha^{2 l} \nu^{2}\right) \\
& \leq \sum_{l=1}^{\infty} \exp \left(-\left(2 c_{5} n \log (\alpha) \nu^{2}\right) l\right)
\end{aligned}
$$

where we used $e^{x} \geq x$. We finally compute for $\nu=\sqrt{\frac{64 \log (d)}{\log (6 / 5) n}}$

$$
\mathbb{P}(\mathcal{B}) \leq \frac{\exp \left(-2 c_{5} n \log (\alpha) \nu^{2}\right)}{1-\exp \left(-2 c_{5} n \log (\alpha) \nu^{2}\right)}=\frac{\exp (-\log (d))}{1-\exp (-\log (d))}
$$

This completes the proof of Lemma 12.

## C Proof of Lemma 14

Our approach is standard: first we show that $Z_{T}$ concentrates around its expectation and then we upper bound the expectation.

By definition, $Z_{T}=\sup _{A \in \mathcal{C}(r, T)}\left|\frac{1}{n} \sum_{i=1}^{n}\left\langle X_{i}, A\right\rangle^{2}-\mathbb{E}\left(\langle X, A\rangle^{2}\right)\right|$. Massart's concentration inequality (see e.g. [3, Theorem 14.2]) implies that

\mathbb{P}\left(Z_{T} \geq \mathbb{E}\left(Z_{T}\right)+\frac{1}{9}\left(\frac{5}{12} T\right)\right) \leq \exp \left(-c_{5} n T^{2}\right) \tag{28}
\end{equation*}
$$

where $c_{5}=\frac{1}{128}$. Next we bound the expectation $\mathbb{E}\left(Z_{T}\right)$. Using a standard symmetrization argument (see e.g. [16, Theorem 2.1]) we obtain

$$
\begin{aligned}
\mathbb{E}\left(Z_{T}\right) & =\mathbb{E}\left(\sup _{A \in \mathcal{C}(r, T)}\left|\frac{1}{n} \sum_{i=1}^{n}\left\langle X_{i}, A\right\rangle^{2}-\mathbb{E}\left(\langle X, A\rangle^{2}\right)\right|\right) \\
& \leq 2 \mathbb{E}\left(\sup _{A \in \mathcal{C}(r, T)}\left|\frac{1}{n} \sum_{i=1}^{n} \epsilon_{i}\left\langle X_{i}, A\right\rangle^{2}\right|\right)
\end{aligned}
$$

where $\left\{\epsilon_{i}\right\}_{i=1}^{n}$ is an i.i.d. Rademacher sequence. The assumption $\|A\|_{\infty}=1$ implies $\left|\left\langle X_{i}, A\right\rangle\right| \leq 1$. Then, the contraction inequality (see e.g. [16]) yields

$$
\mathbb{E}\left(Z_{T}\right) \leq 8 \mathbb{E}\left(\sup _{A \in \mathcal{C}(r, T)}\left|\frac{1}{n} \sum_{i=1}^{n} \epsilon_{i}\left\langle X_{i}, A\right\rangle\right|\right)=8 \mathbb{E}\left(\sup _{A \in \mathcal{C}(r, T)}\left|\left\langle\Sigma_{R}, A\right\rangle\right|\right)
$$

where $\Sigma_{R}=\frac{1}{n} \sum_{i=1}^{n} \epsilon_{i} X_{i}$. For $A \in \mathcal{C}(r, T)$ we have that

$$
\begin{aligned}
\|A\|_{1} & \leq \sqrt{r}\|A\|_{2} \\
& \leq \sqrt{\mu r m_{1} m_{2}}\|A\|_{L_{2}(\Pi)} \\
& \leq \sqrt{\mu m_{1} m_{2} r T}
\end{aligned}
$$

where we have used (3). Then, by the duality between nuclear and operator norms, we compute

$$
\mathbb{E}\left(Z_{T}\right) \leq 8 \mathbb{E}\left(\sup _{\|A\|_{1} \leq \sqrt{\mu m_{1} m_{2} r T}}\left|\left\langle\Sigma_{R}, A\right\rangle\right|\right) \leq 8 \sqrt{\mu m_{1} m_{2} r T} \mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)
$$

Finally, using
$\frac{1}{9}\left(\frac{5}{12} T\right)+8 \sqrt{\mu m_{1} m_{2} r T} \mathbb{E}\left(\left\|\Sigma_{R}\right\|\right) \leq\left(\frac{1}{9}+\frac{8}{9}\right) \frac{5}{12} T+44 \mu r m_{1} m_{2}\left(\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)\right)^{2}$
and the concentration bound (28) we obtain that

$$
\mathbb{P}\left(Z_{T}>\frac{5}{12} T+44 \mu r m_{1} m_{2}\left(\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)\right)^{2}\right) \leq \exp \left(-c_{5} n T^{2}\right)
$$

with $c_{5}=\frac{1}{128}$ as stated.

## D Proof of Theorem 8

Let us set $\Delta=A_{0}-\hat{A}_{S Q}$. We have that

$$
\begin{aligned}
Q^{2}\left(\hat{A}_{S Q}\right)-Q^{2}\left(A_{0}\right) & =\frac{1}{n}\|\mathcal{O}(\Delta)\|_{2}^{2}+2\left\langle\frac{\sigma}{n} \sum_{i=1}^{n} \xi_{i} X_{i}, \Delta\right\rangle \\
& =\frac{1}{n}\|\mathcal{O}(\Delta)\|_{2}^{2}+2\langle\Sigma, \Delta\rangle
\end{aligned}
$$

where $\Sigma=\frac{\sigma}{n} \sum_{i=1}^{n} \xi_{i} X_{i}$. This implies

$$
\begin{equation*}
\frac{1}{n}\|\mathcal{O}(\Delta)\|_{2}^{2}=-2\langle\Sigma, \Delta\rangle+\left(Q\left(\hat{A}_{S Q}\right)-Q\left(A_{0}\right)\right)\left(Q\left(\hat{A}_{S Q}\right)+Q\left(A_{0}\right)\right) \tag{29}
\end{equation*}
$$

We need the following auxiliary lemma which is proven in the appendix F .
Lemma 15. If $\lambda>3\|\Sigma\| / Q\left(A_{0}\right)$, then

$$
\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1} \leq 2\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}
$$

where $\Delta=\hat{A}_{S Q}-A_{0}$.
Note that from (38) we get

$$
\begin{equation*}
\left\|A_{0}\right\|_{1}-\left\|\hat{A}_{S Q}\right\|_{1} \leq\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}-\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1} \tag{30}
\end{equation*}
$$

The definition of $\hat{A}_{S Q}$ and (30) imply that

$$
\begin{align*}
Q\left(A_{0}\right)+Q\left(\hat{A}_{S Q}\right) & \leq 2 Q\left(A_{0}\right)+\lambda\left(\left\|A_{0}\right\|_{1}-\left\|\hat{A}_{S Q}\right\|_{1}\right)  \tag{31}\\
& \leq 2 Q\left(A_{0}\right)+\lambda\left(\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}-\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1}\right)
\end{align*}
$$

and

$$
\begin{align*}
Q\left(\hat{A}_{S Q}\right)-Q\left(A_{0}\right) & \leq \lambda\left(\left\|A_{0}\right\|_{1}-\left\|\hat{A}_{S Q}\right\|_{1}\right) \\
& \leq \lambda\left(\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}-\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1}\right)  \tag{32}\\
& \leq \lambda\left(2\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}-\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1}\right)
\end{align*}
$$

Lemma 15 implies that $2\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}-\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1} \geq 0$. From (31) and (32) we compute

$$
\begin{align*}
& \left(Q\left(\hat{A}_{S Q}\right)-Q\left(A_{0}\right)\right)\left(Q\left(\hat{A}_{S Q}\right)+Q\left(A_{0}\right)\right) \leq \\
& \lambda\left(2\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}-\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1}\right)\left(2 Q\left(A_{0}\right)+\lambda\left(\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}-\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1}\right)\right)= \\
& \quad 4 \lambda Q\left(A_{0}\right)\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}-2 \lambda Q\left(A_{0}\right)\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1} \\
& \quad+2 \lambda^{2}\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}^{2}+\lambda^{2}\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1}^{2}-3 \lambda^{2}\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1} . \tag{33}
\end{align*}
$$

Lemma 15 implies that $\lambda^{2}\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1}^{2}-3 \lambda^{2}\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1} \leq 0$ and we obtain from (33)

$$
\begin{align*}
&\left(Q\left(\hat{A}_{S Q}\right)-Q\left(A_{0}\right)\right)\left(Q\left(\hat{A}_{S Q}\right)+Q\left(A_{0}\right)\right) \leq 4 \lambda Q\left(A_{0}\right)\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1} \\
&-2 \lambda Q\left(A_{0}\right)\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1}+2 \lambda^{2}\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}^{2} \tag{34}
\end{align*}
$$

Plugging (34) into (29) we get

$$
\begin{aligned}
\frac{1}{n}\|\mathcal{O}(\Delta)\|_{2}^{2} \leq & -2\langle\Sigma, \Delta\rangle+4 \lambda Q\left(A_{0}\right)\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1} \\
& -2 \lambda Q\left(A_{0}\right)\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1}+2 \lambda^{2}\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}^{2}
\end{aligned}
$$

Then, by the duality between the nuclear and the operator norms, we obtain

$$
\begin{gathered}
\frac{1}{n}\|\mathcal{O}(\Delta)\|_{2}^{2} \leq 2\|\Sigma\|\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}+2\|\Sigma\|\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1} \\
+4 \lambda Q\left(A_{0}\right)\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}-2 \lambda Q\left(A_{0}\right)\left\|\mathbf{P}_{A_{0}}^{\perp}(\Delta)\right\|_{1} \\
+2 \lambda^{2}\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}^{2}
\end{gathered}
$$

Using $\lambda Q\left(A_{0}\right) \geq 3\|\Sigma\|$ we compute

$$
\frac{1}{n}\|\mathcal{O}(\Delta)\|_{2}^{2} \leq \frac{14}{3} \lambda Q\left(A_{0}\right)\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}+2 \lambda^{2}\left\|\mathbf{P}_{A_{0}}(\Delta)\right\|_{1}^{2}
$$

which leads to

$$
\frac{1}{n}\|\mathcal{O}(\Delta)\|_{2}^{2} \leq \frac{14}{3} \lambda Q\left(A_{0}\right) \sqrt{2 \operatorname{rank}\left(A_{0}\right)}\|\Delta\|_{2}+4 \lambda^{2} \operatorname{rank}\left(A_{0}\right)\|\Delta\|_{2}^{2}
$$

The condition $4 \mu m_{1} m_{2} \lambda^{2} \operatorname{rank}\left(A_{0}\right) \leq 1 / 4$ implies that

$$
\begin{equation*}
\frac{1}{n}\|\mathcal{O}(\Delta)\|_{2}^{2} \leq \frac{14}{3} \lambda Q\left(A_{0}\right) \sqrt{2 \operatorname{rank}\left(A_{0}\right)}\|\Delta\|_{2}+\frac{\|\Delta\|_{2}^{2}}{4 \mu m_{1} m_{2}} \tag{35}
\end{equation*}
$$

Set $a=\left\|\hat{A}_{S Q}-A_{0}\right\|_{\infty}$. By the definition of $\hat{A}_{S Q}$ we have that $a \leq 2 \mathbf{a}$. We now consider two cases, depending on whether the matrix $\frac{1}{a}\left(\hat{A}_{S Q}-A_{0}\right)$ belongs or not to the set $\mathcal{C}\left(18 \operatorname{rank}\left(A_{0}\right)\right)$.

Case 1: Suppose first that $\left\|\hat{A}_{S Q}-A_{0}\right\|_{L_{2}(\Pi)}^{2}<a^{2} \sqrt{\frac{64 \log (d)}{\log (6 / 5) n}}$, then (3) implies that

$$
\begin{equation*}
\frac{\left\|\hat{A}_{S Q}-A_{0}\right\|_{2}^{2}}{m_{1} m_{2}} \leq 4 \mathbf{a}^{2} \mu \sqrt{\frac{64 \log (d)}{\log (6 / 5) n}} \tag{36}
\end{equation*}
$$

and we get the statement of of the Theorem 8 in this case.
Case 2: It remains to consider the case $\left\|\hat{A}_{S Q}-A_{0}\right\|_{L_{2}(\Pi)}^{2} \geq a^{2} \sqrt{\frac{64 \log (d)}{\log (6 / 5) n}}$. Lemma 15 implies that $\frac{1}{a}\left(\hat{A}_{S Q}-A_{0}\right) \in \mathcal{C}\left(18 \operatorname{rank}\left(A_{0}\right)\right)$ and we can apply Lemma 12. From Lemma 12, (3) and (35) we obtain that, with probability at least $1-\frac{2}{d}$ one has

$$
\begin{aligned}
& \frac{\|\Delta\|_{2}^{2}}{2 \mu m_{1} m_{2}} \leq \frac{14}{3} \lambda Q\left(A_{0}\right) \sqrt{2 \operatorname{rank}\left(A_{0}\right)}\|\Delta\|_{2}+\frac{\|\Delta\|_{2}^{2}}{4 \mu m_{1} m_{2}} \\
&+792 a^{2} \mu m_{1} m_{2} \operatorname{rank}\left(A_{0}\right)\left(\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)\right)^{2} .
\end{aligned}
$$

A simple calculation yields

$$
\begin{aligned}
& \left(\frac{\|\Delta\|_{2}}{2 \sqrt{\mu m_{1} m_{2}}}-\frac{14}{3} \lambda Q\left(A_{0}\right) \sqrt{2 \operatorname{rank}\left(A_{0}\right) \mu m_{1} m_{2}}\right)^{2} \leq \\
& \quad\left(\frac{14}{3} \lambda Q\left(A_{0}\right) \sqrt{2 \operatorname{rank}\left(A_{0}\right) \mu m_{1} m_{2}}\right)^{2}+792 a^{2} \mu m_{1} m_{2} \operatorname{rank}\left(A_{0}\right)\left(\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)\right)^{2}
\end{aligned}
$$

and
$\frac{\|\Delta\|_{2}}{2 \sqrt{\mu m_{1} m_{2}}} \leq \frac{28}{3} \lambda Q\left(A_{0}\right) \sqrt{2 \operatorname{rank}\left(A_{0}\right) \mu m_{1} m_{2}}+\sqrt{792 a^{2} \mu m_{1} m_{2} \operatorname{rank}\left(A_{0}\right)\left(\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)\right)^{2}}$.
This and $a \leq 2$ a imply that, there exist numerical constant $c_{1}^{\prime}$ such that

$$
\frac{\left\|\hat{A}_{S Q}-A_{0}\right\|_{2}^{2}}{m_{1} m_{2}} \leq c_{1}^{\prime} \mu^{2} m_{1} m_{2}\left(Q^{2}\left(A_{0}\right) \lambda^{2} \operatorname{rank}\left(A_{0}\right)+\mathbf{a}^{2} \operatorname{rank}\left(A_{0}\right)\left(\mathbb{E}\left(\left\|\Sigma_{R}\right\|\right)\right)^{2}\right),
$$

which, together with (36), leads to the statement of the Theorem 8.

## E Proof of Lemma 13

By definition of $P_{A_{0}}^{\perp}$, for any matrix $B$ the singular vectors of $P_{A_{0}}^{\perp}(B)$ are orthogonal to the space spanned by the singular vectors of $A_{0}$. This implies that

$$
\begin{align*}
& \left\|A_{0}+\mathbf{P}_{A_{0}}^{\perp}\left(\hat{A}-A_{0}\right)\right\|_{1}=\left\|A_{0}\right\|_{1}+\left\|\mathbf{P}_{A_{0}}^{\perp}\left(\hat{A}-A_{0}\right)\right\|_{1} . \text { Then } \\
& \|\hat{A}\|_{1}
\end{align*}=\left\|A_{0}+\hat{A}-A_{0}\right\|_{1} .
$$

By the convexity of $Q^{2}(A)$ and using $\lambda \geq 3 \Delta$ we have

$$
\begin{aligned}
Q^{2}(\hat{A})-Q^{2}\left(A_{0}\right) & \geq-\frac{2}{n} \sum_{i=1}^{n}\left(Y_{i}-\left\langle X_{i}, A_{0}\right\rangle\right)\left\langle X_{i}, \hat{A}-A_{0}\right\rangle \\
& =-2\left\langle\Sigma, \hat{A}-A_{0}\right\rangle \\
& \geq-2\|\Sigma\|\left\|\hat{A}-A_{0}\right\|_{1} \\
& \geq-\frac{2}{3} \lambda\left\|\hat{A}-A_{0}\right\|_{1} .
\end{aligned}
$$

Using the definition of $\hat{A}$, we compute

$$
\begin{aligned}
\lambda\|\hat{A}\|_{1}-\lambda\left\|A_{0}\right\|_{1} & \leq Q^{2}\left(A_{0}\right)-Q^{2}(\hat{A}) \\
& \leq \frac{2}{3} \lambda\left\|\hat{A}-A_{0}\right\|_{1} .
\end{aligned}
$$

This implies that

$$
\left\|\mathbf{P}_{A_{0}}^{\perp}\left(\hat{A}-A_{0}\right)\right\|_{1} \leq 5\left\|\mathbf{P}_{A_{0}}\left(\hat{A}-A_{0}\right)\right\|_{1}
$$

as stated.

## F Proof of Lemma 15

By the convexity of $Q(A)$ we have

$$
\begin{aligned}
Q\left(\hat{A}_{S Q}\right)-Q\left(A_{0}\right) & \geq \frac{-\frac{1}{n} \sum_{i=1}^{n}\left(Y_{i}-\left\langle X_{i}, A_{0}\right\rangle\right)\left\langle X_{i}, \hat{A}_{S Q}-A_{0}\right\rangle}{Q\left(A_{0}\right)} \\
& =\frac{-\left\langle\Sigma, \hat{A}_{S Q}-A_{0}\right\rangle}{Q\left(A_{0}\right)} \\
& \geq-\frac{\|\Sigma\|}{Q\left(A_{0}\right)}\left\|\hat{A}_{S Q}-A_{0}\right\|_{1} \\
& \geq-\frac{1}{3} \lambda\left\|\hat{A}_{S Q}-A_{0}\right\|_{1} .
\end{aligned}
$$

Using the definition of $\hat{A}_{S Q}$, we compute

$$
\begin{aligned}
\lambda\left\|\hat{A}_{S Q}\right\|_{1}-\lambda\left\|A_{0}\right\|_{1} & \leq Q\left(A_{0}\right)-Q\left(\hat{A}_{S Q}\right) \\
& \leq \frac{1}{3} \lambda\left\|\hat{A}_{S Q}-A_{0}\right\|_{1}
\end{aligned}
$$

Then (38) and the triangle inequality imply

$$
\left\|\mathbf{P}_{A_{0}}^{\perp}\left(\hat{A}-A_{0}\right)\right\|_{1}-\left\|\mathbf{P}_{A_{0}}\left(\hat{A}-A_{0}\right)\right\|_{1} \leq \frac{1}{3}\left(\left\|\mathbf{P}_{A_{0}}^{\perp}\left(\hat{A}-A_{0}\right)\right\|_{1}+\left\|\mathbf{P}_{A_{0}}\left(\hat{A}-A_{0}\right)\right\|_{1}\right)
$$

and the statement of Lemma 15 follows.
