ON L^r ESTIMATES FOR SOLUTIONS OF THE $\bar{\partial}$ EQUATION WITH COMPACT SUPPORT.

ABSTRACT. By a theorem of Andreotti and Grauert if ω is a (p,q) current, q < n, in a Stein manifold Ω , $\bar{\partial}$ closed and with compact support, then there is a solution u to $\bar{\partial}u = \omega$ still with compact support in Ω . The main result of this work is to show that if moreover $\omega \in L^r(m)$, where m is a suitable Lebesgue measure on the Stein manifold, then we have a solution u with compact support and, for 1 < r < 2(n+1), in $L^s(m)$, $\frac{1}{s} = \frac{1}{r} - \frac{1}{2(n+1)}$; because s > r, we have a gain of regularity. We prove it by estimates in L^r spaces with weights.

1. Introduction.

Let ω be a $\bar{\partial}$ closed (p,q) form in \mathbb{C}^n with compact support $K:=\operatorname{Supp}\omega$ and such that $\omega\in L^r(\mathbb{C}^n)$. Setting K in a ball $\mathbb{B}:=B(0,R)$ with R big enough, we know, by a theorem of Ovrelid [11], that we have a (p,q-1) form $u\in L^r(\mathbb{B})$ such that $\bar{\partial}u=\omega$. On the other hand we also know, at least when q< n, that there is a current v with compact support such that $\bar{\partial}v=\omega$, by a theorem of Andreotti-Grauert [5]. So a natural question is: may we have a solution u of $\bar{\partial}u=\omega$ with compact support and in $L^r(\mathbb{C}^n)$?

In the sequel a domain in a Stein manifold will always means a be a relatively compact open connected set with C^{∞} smooth boundary. We shall denote by s.p.c. a strictly pseudo convex domain.

There is a work by H. Skoda [13] who proved such a result. Let Ω be a s.p.c. domain in \mathbb{C}^n then in [13], Proposition 1 p. 292 and proposition 2 p. 293, H. Skoda proved that if f is a (p,q) form with measure coefficients, q < n, $\bar{\partial}$ closed and with compact support in Ω , then there is a solution U to the equation $\bar{\partial}U = f$ such that $||U||_{L^r(\Omega)} \leq C(\Omega,r)||f||_r$, for any r such that $1 < r < \frac{2n+2}{2n-1}$ and U has zero boundary values in the sense of Stokes formula.

This means that essentially U has compact support hence H. Skoda got the answer for Ω strictly pseudo-convex and $1 < r < \frac{2n+2}{2n-1}$.

We answered this question by the affirmative for any $r \in [1, \infty]$ in a joined work with S. Mongodi [4] linearly by the "method of coronas". This method works only in \mathbb{C}^n and asks for extra L^r conditions on derivatives of coefficients of ω , when q < n.

The aim of this work is to extend this result to Stein manifolds and get rid of the extra L^r conditions. For it we use a completely different approach inspired by the Serre duality [12]. Because Hahn Banach theorem is used, these results are no longer linear nor constructive as in [4] but they are completely explicit.

On any complex manifold X we define first the "Lebesgue measure" as in Hörmander's book [8] section 5.2, with a hermitian metric locally equivalent to the usual one on any analytic coordinates patch. Associated to this metric there is a volume form dm and we take it for the Lebesgue measure on X.

Let Ω be a domain in a complex manifold X. We shall define $L^r(\Omega)$ to be the set of functions f defined on Ω such that

$$\left\|f\right\|_{L^{r}(\Omega)}^{r}:=\int_{\Omega}\left|f(z)\right|^{r}dm(z)<\infty,$$

with m the Lebesgue measure on X. The same way we denote $L^r_{(p,q)}(\Omega)$ the set of (p,q) currents ω with coefficients in $L^r(\Omega)$. The set of currents in $L^r_{(p,q)}(\Omega)$ with compact support will be denoted by $L^{r,c}_{(p,q)}(\Omega).$

Theorem 1.1. Let Ω be a Stein manifold. Let ω be a (p,q) current with compact support in $L^r_{(p,q)}(\Omega)$, such that $\bar{\partial}\omega = 0$ if $1 \leq q < n$ and $\forall h \in \mathcal{H}_p(\Omega)$, $\langle \omega, h \rangle = 0$ if q = n.

Then, for $1 \leq r < 2(n+1)$, there is a (p,q-1) current u in $L^{s,c}(\Omega)$ such that $\bar{\partial}u = \omega$ with $\frac{1}{s} = \frac{1}{r} - \frac{1}{2(n+1)}$

For r=2(n+1) and any $s<\infty$, there is a (p,q-1) current u in $L^{s,c}(\Omega)$ such that $\bar{\partial}u=\omega$. For r > 2(n+1), there is a (p, q-1) current u in $L^{\infty,c}(\Omega)$ such that $\bar{\partial}u = \omega$.

Moreover if the support of ω is contained in a s.p.c. domain $D \subset \Omega$, then the support of u is also contained in D.

The definition of (r, s) regular domain shall be given later on, but Stein manifolds are such domains. We note r' the conjugate exponent of r, i.e. $\frac{1}{r} + \frac{1}{r'} = 1$. We shall also get a better control on the support of a solution.

Theorem 1.2. Let Ω be a (s', r') regular domain in a Stein manifold X. Then for any (p, q) form ω with compact support in $L^r(\Omega)$, $\partial \omega = 0$, if q < n, and $\omega \perp \mathcal{H}_p(\Omega)$ if q = n, with support in $\Omega \setminus C$ where C is a (s,s) regular domain, there is a $u \in L^s(\Omega)$ with compact support, such that $\bar{\partial}u = \omega$ and with support in $\Omega \setminus \overline{U}$, where U is any open set relatively compact in C, provided that $q \geq 2$.

One may observe that $\Omega \setminus C$ is not Stein in general even if Ω is, so this result is actually an improvement over the previous theorem.

There is also a result of this kind for q = 1, see section 2.3.

The idea is to solve $\partial u = \omega$ in a space $L^r(\Omega)$ with a weight η "big" outside of a relatively compact domain D containing the support of ω ; this way we shall have a "small" solution u outside of D. Then, using a sequence of such weights going to infinity outside of D, we shall have a u zero outside of D.

I am indebted to G. Tomassini who started my interest in this subject. I want to thank C. Laurent who made me realise that I can use a weaker condition than my previous r regularity one to get these results, with exactly the same proofs.

2. Solution of the $\bar{\partial}$ equation with compact support.

2.1. Domain (r, s) regular.

Definition 2.1. Let X be a complex manifold and Ω a domain in X; let $r \in [1, \infty]$, we shall say that Ω is (r,s), $s \geq r$, regular if for any compact set $K \in \Omega$ there are 3 open sets $\Omega_1, \Omega_2, \Omega_3$ such that $K \subseteq \Omega_3 \subset \Omega_2 \subset \Omega_1 \subset \Omega_0 := \Omega$ and 3 constants C_1, C_2, C_3 such that :

$$\forall j = 0, 1, 2, \ \forall \omega \in L_{p,q+j}^{r}(\Omega_{j}), \ \bar{\partial}\omega = 0, \ \exists u \in L_{p,q+j-1}^{s}(\Omega_{j+1}), \ \bar{\partial}u = \omega \ in \ \Omega_{j+1}$$

$$and \ \|u\|_{L^{s}(\Omega_{j+1})} \leq C_{j+1} \|\omega\|_{L^{r}(\Omega_{j})}.$$

I.e. regularity means that we have a 3 steps chain of resolution.

As we shall see the interesting case for us is when Ω_1 is as small as possible still such that $K \subseteq \Omega_3 \subset \Omega_2 \subset \Omega_1$.

Examples of (2, 2) regular domains are the relatively compact pseudo-convex domains in Stein manifold by Hörmander [8].

Examples of (r,r) regular domains in \mathbb{C}^n are the s.p.c. domains by Ovrelid [11]; the polydiscs in \mathbb{C}^n by Charpentier [6], finite transverse intersections of strictly pseudo-convex bounded domains in \mathbb{C}^n by Menini [10].

In fact if Ω is a s.p.c. domain in \mathbb{C}^n we have a better result : Ω is (r,s) regular with $\frac{1}{s} = \frac{1}{r} - \frac{1}{2(n+1)}$ by a more precise result we proved in [2]:

Theorem 2.2. Let Ω be a s.p.c. domain of \mathbb{C}^n , then for 1 < r < 2n + 2 we have

 be a s.p.c. about of \mathcal{C} , then for $1 < r < 2n + \forall \omega \in L^r_{(p,q)}(\Omega), \ \bar{\partial}\omega = 0, \ \exists u \in L^s_{(p,q-1)}(\Omega) :: \bar{\partial}u = \omega$ with $\frac{1}{s} = \frac{1}{r} - \frac{1}{2(n+1)}$.

For $r = 1$, we have

For
$$r = 1$$
, we have

$$\forall \omega \in L^1_{(p,q)}(\Omega), \ \bar{\partial} \omega = 0, \ \exists u \in L^{s,\infty}_{(p,q-1)}(\Omega) :: \bar{\partial} u = \omega.$$

For
$$r > 2n + 2$$
 we have
$$\forall \omega \in L^{2n+2}_{(p,q)}(\Omega), \ \partial \omega = 0, \ \exists u \in L^{2n+2}_{(p,q-1)}(\Omega) :: \partial u = \omega.$$
For $r > 2n + 2$ we have

For
$$r > 2n + 2$$
 we have $\forall \omega \in L^{2n+2}_{(p,q)}(\Omega), \ \bar{\partial}\omega = 0, \ \exists u \in \Lambda^{\beta}_{(p,0)}(\Omega) :: \bar{\partial}u = \omega,$

where Λ^{β} are the Lipschitz functions with $2\beta = 1 - \frac{2(n+1)}{r}$.

For domains in a Stein manifold X we can solve the $\bar{\partial}$ equation in s.p.c. domains with $L^r - L^r$ estimates for (0, 1) forms by use of N. Kerzman kernels [9] and the metric above.

We can solve the ∂ equation in strictly pseudo-convex domains with smooth boundary in X with $L^r - L^r$ estimates for all (p,q) currents by J-P. Demailly and C. Laurent ones [7], Remarque 4, page 596) but here the manifold has to be equiped with a metric with null curvature.

In fact we proved [3] an analogous result as the one in [7], with $L^r - L^s$ estimates with s: $\frac{1}{s} = \frac{1}{r} - \frac{1}{2(n+1)} \ge \frac{1}{2}$, i.e. $s \le 2$, and without any restriction on the metric. Let $\mathcal{H}_p(\Omega)$ be the set of all (p, 0) $\bar{\partial}$ closed forms in Ω .

Theorem 2.3. Let Ω be a s.p.c. domain in the Stein manifold X.

Let s such that $\frac{1}{s} = \frac{1}{r} - \frac{1}{2(n+1)}$; if $\omega \in L_{p,q}^r(\Omega)$ with $\bar{\partial}\omega = 0$ then for $s \leq 2$, there is $u \in L_{p,q-1}^s(\Omega)$ such that $\bar{\partial}u = \omega$.

When $2 < s < \infty$ we have :

- for p=0, q=1 we still have a function $u \in L^s(\Omega)$ such that $\bar{\partial} u = \omega$.
- For q = n, $\omega \in L^r_{p,n}(\Omega)$ with $\omega \perp \mathcal{H}_p(\Omega)$ we still have a $u \in L^s_{(p,n-1)}(\Omega)$ such that $\bar{\partial}u = \omega$.
- If X can be equipped with a hermitian metric with null curvature in the sens of Demailly-Laurent [7], we still have a $u \in L^s_{(p,q-1)}(\Omega)$ such that $\bar{\partial}u = \omega$.
- Finally if ω has compact support in Ω , $\omega \in L_{p,q}^{r,c}(\Omega)$, with $\bar{\partial}\omega = 0$ if q < n and $\omega \perp \mathcal{H}_p(\Omega)$ if $q=n, \ we \ still \ have \ a \ u \in L^s_{(p,q-1)}(\Omega) \ such \ that \ \bar{\partial} u=\omega.$

In any cases, there is a constant C > 0 such that $||u||_s \le C||\omega||_r$.

Lemma 2.4. A Stein manifold Ω is (r,s) regular with $\frac{1}{s} = \frac{1}{r} - \frac{1}{2(n+1)}$ provided that $s \leq 2$, i.e. for $1 \le r \le \frac{2(n+1)}{n+2}$.

Proof.

By theorem 5.1.6 of Hörmander [8] there exists a \mathcal{C}^{∞} strictly plurisubharmonic exhausting function φ for Ω . Call $E \subset \Omega$ the set of critical points of φ , then by the Morse-Sard lemma we have that the Lebesgue measure of $\varphi(E) \subset \mathbb{R}$ is zero. Hence we can find a sequence $c_k \in \mathbb{R} \backslash \varphi(E), c_k \to \infty$, such that

$$D_k := \{ z \in \Omega :: \varphi(z) < c_k \}$$

make an exhaustive sequence of open relatively compact sets in Ω , $\partial \varphi \neq 0$ on ∂D_k , hence D_k is

strictly pseudo-convex with \mathcal{C}^{∞} smooth boundary, and finally $D_k \nearrow \Omega$. Let $\omega \in L^r_{p,q}(\Omega)$, $\bar{\partial}\omega = 0$ then by theorem 2.3, if $\frac{1}{s} = \frac{1}{r} - \frac{1}{2(n+1)} \ge \frac{1}{2}$, we can solve $\bar{\partial}u = \omega$

in D_k with $u \in L^s_{p,q-1}(D_k)$ and

 $||u||_{L^s(D_k)} \le C_k ||\omega||_{L^r(D_k)} \le C_k ||\omega||_{L^r(\Omega)}.$ Hence if K is a compact set in Ω , there is a D_k such that $K \in D_k$ and we can take $\Omega_1 = \Omega_2 = 0$ $\Omega_3 = D_k$.

Hence the (r, s) regularity of Ω , provided $s \leq 2$.

Remark 2.5. If the current $\omega \in L_{p,q}^{r,c}(\Omega)$, $\bar{\partial}\omega = 0$, i.e. ω has compact support, then we can solve $\bar{\partial}u = \omega$ in D_k with $u \in L^s_{p,q-1}(D_k)$ and no restriction on s by theorem 2.3. This will suffice to get our main theorem.

Lemma 2.6. A pseudo convex domain Ω in \mathbb{C}^n is (r,s) regular for $1 \leq r < 2(n+1)$ with $\frac{1}{s} = \frac{1}{s}$ $\frac{1}{r} - \frac{1}{2(n+1)}$. If r = 2(n+1), Ω is (r,s) regular for any $s < \infty$ and if r > 2(n+1), Ω is (r,∞)

Proof.

This is exactly the same proof but we use theorem 2.2 which is valid without the restriction $s \leq 2$.

2.2. The main result.

Let r', s' be the conjugate exponent of r, s respectively. Let Ω be a $(s', r'), r' \geq s'$, regular domain in the complex manifold X, and ω be a (p,q) form in $L^{r,c}(\Omega)$, $r \geq 1$, Supp $\omega \in \Omega$. Let $\Omega_1 \subset \Omega$ be a sub domain in Ω with Supp $\omega \in \Omega_1 \subset \Omega$ given by the regularity of Ω .

Set the weight $\eta = \eta_{\epsilon} := \mathbb{1}_{\Omega_1}(z) + \epsilon \mathbb{1}_{\Omega \setminus \Omega_1}(z)$ for a fixed $\epsilon > 0$. We shall define $L^r(\Omega, \eta)$ to be the set of functions f defined on Ω such that

$$||f||_{L^{r}(\Omega, \eta)}^{r} := \int_{\Omega} |f(z)|^{r} \eta(z) dm(z) < \infty,$$

 $\|f\|_{L^{r}(\Omega, \eta)}^{r} := \int_{\Omega} |f(z)|^{r} \eta(z) dm(z) < \infty,$ with the weight $\eta(z) > 0$. The same way we denote $L_{(p,q)}^{r}(\Omega, \eta)$ the set of (p,q) currents ω with coefficients in $L^r(\Omega, \eta)$.

Suppose that ω is such that $\bar{\partial}\omega = 0$ if $1 \leq q < n$ and for any open $U \in \Omega$, Supp $\omega \in U$ we have $\forall h \in \mathcal{H}_p(U), \ \langle \omega, \ h \rangle = 0 \text{ if } q = n. \text{ We shall use the lemma :}$

Lemma 2.7. For Ω , ω , η as above, the function $\mathcal{L} = \mathcal{L}_{\omega}$, defined on (n-p, n-q+1) form $\alpha \in L^{s'}(\Omega, \eta), \ \bar{\partial} \ closed \ in \ \Omega, \ as \ follows :$

 $\mathcal{L}(\alpha) := (-1)^{p+q-1} \langle \omega, \varphi \rangle$, where $\varphi \in L^{r'}(\Omega_1)$ is such that $\bar{\partial} \varphi = \alpha$ in Ω_1 is well defined and linear.

Proof.

Because $\epsilon > 0$ we have $\alpha \in L^{s'}(\Omega, \eta) \Rightarrow \alpha \in L^{s'}(\Omega)$ and such a φ exists by the (s', r') regularity of Ω , so there is a Ω_1 :: Supp $\omega \in \Omega_1 \subset \Omega$ such that $\varphi \in L^{r'}(\Omega_1)$ with $\bar{\partial} \varphi = \alpha$ in Ω_1 . Let us see that \mathcal{L} is well defined.

Suppose first that q < n.

In order for \mathcal{L} to be well defined we need

$$\forall \varphi, \psi \in L_{(n-p,n-q)}^{r'}(\Omega_1), \ \bar{\partial}\varphi = \bar{\partial}\psi \Rightarrow \langle \omega, \varphi \rangle = \langle \omega, \psi \rangle.$$

This is meaningful because $\omega \in L^{r,c}(\Omega)$, r > 1, Supp $\omega \in \Omega_1$.

Then we have $\bar{\partial}(\varphi - \psi) = 0$ hence, because Ω is (s', r') regular, there is a Ω_2 such that Supp $\omega \in$ $\Omega_2 \subset \Omega_1$ and we can solve $\bar{\partial}$ in $L^{r'}(\Omega_2)$, i.e. $\varphi - \psi \in L^{r'}_{(n-p,n-q)}(\Omega_1) \subset L^{s'}_{(n-p,n-q)}(\Omega_1)$ because $s' \leq r'$. Hence

$$\exists \gamma \in L_{(n-p,n-q-1)}^{r'}(\Omega_2) :: \bar{\partial}\gamma = (\varphi - \psi).$$

 $\exists \gamma \in L_{(n-p,n-q-1)}^{r'}(\Omega_2) :: \bar{\partial}\gamma = (\varphi - \psi).$ So $\langle \omega, \varphi - \psi \rangle = \langle \omega, \bar{\partial}\gamma \rangle = (-1)^{p+q-1} \langle \bar{\partial}\omega, \gamma \rangle = 0$ because ω being compactly supported in Ω_2 there is no boundary term.

Hence \mathcal{L} is well defined in that case.

Suppose now that q = n.

Of course $\bar{\partial}\omega = 0$ and we have that φ , ψ are (p, 0) forms hence $\bar{\partial}(\varphi - \psi) = 0$ means that $h := \varphi - \psi$ is a $\bar{\partial}$ closed (p, 0) form hence $h \in \mathcal{H}_p(\Omega_1)$. Taking $U = \Omega_1$ in the hypothesis, $\omega \perp \mathcal{H}_p(U)$ gives $\langle \omega, h \rangle = 0$, and \mathcal{L} is also well defined in that case.

We remark that no compactness is required for ω in this case.

It remains to see that \mathcal{L} is linear, so let $\alpha = \alpha_1 + \alpha_2$, with $\alpha_j \in L^{s'}(\Omega, \eta)$, $\bar{\partial}\alpha_j = 0$, j = 1, 2; we have $\alpha = \bar{\partial}\varphi$, $\alpha_1 = \bar{\partial}\varphi_1$ and $\alpha_2 = \bar{\partial}\varphi_2$, with φ , φ_1 , φ_2 in $L^{r'}(\Omega_1)$ so, because $\bar{\partial}(\varphi - \varphi_1 - \varphi_2) = 0$, we have

if q < n:

$$\varphi = \varphi_1 + \varphi_2 + \bar{\partial}\psi$$
, with ψ in $L^{r'}(\Omega_2)$, as before because $s' \leq r'$;

SO

$$\mathcal{L}(\alpha) = (-1)^{p+q-1} \langle \omega, \varphi \rangle = (-1)^{p+q-1} \langle \omega, \varphi_1 + \varphi_2 + \bar{\partial} \psi \rangle =$$

$$= \mathcal{L}(\alpha_1) + \mathcal{L}(\alpha_2) + (-1)^{p+q-1} \langle \omega, \bar{\partial} \psi \rangle,$$

but $\langle \omega, \bar{\partial}\psi \rangle = \langle \bar{\partial}\omega, \psi \rangle = 0$, because Supp $\omega \in \Omega_2$ implies there is no boundary term. Hence $\mathcal{L}(\alpha) = \mathcal{L}(\alpha_1) + \mathcal{L}(\alpha_2)$.

If q = n:

because $\bar{\partial}(\varphi - \varphi_1 - \varphi_2) = 0$, we have $h := \varphi - \varphi_1 - \varphi_2 \in \mathcal{H}_p(\Omega_1)$ and the hypothesis $\omega \perp \mathcal{H}_p(\Omega_1)$ gives $\langle \omega, h \rangle = 0$, so

$$\mathcal{L}(\alpha) = (-1)^{p+q-1} \langle \omega, \varphi \rangle = (-1)^{p+q-1} \langle \omega, \varphi_1 + \varphi_2 + h \rangle = \mathcal{L}(\alpha_1) + \mathcal{L}(\alpha_2) + (-1)^{p+q-1} \langle \omega, h \rangle,$$
hence $\mathcal{L}(\alpha) = \mathcal{L}(\alpha_1) + \mathcal{L}(\alpha_2).$

We notice again that ω with compact support is not needed in that case.

Hence in any case $\mathcal{L}(\alpha) = \mathcal{L}(\alpha_1) + \mathcal{L}(\alpha_2)$. The same for $\alpha = \lambda \alpha_1$ and the linearity.

Remark 2.8. If Ω is Stein, we can take the domains Ω_1 to be s.p.c. hence also Stein. So because $K := \operatorname{Supp} \omega \subset \Omega_1 \subset \Omega$, then the $A(\Omega_1)$ convex hull of K, \hat{K}_{Ω_1} is still in Ω_1 and any $\bar{\partial}$ closed (p,0) current in Ω_1 can be uniformly approximated on K_{Ω_1} by $\bar{\partial}$ closed (p,0) current in Ω by the theorem 3.2 we shall prove in the appendix.

Therefore for q = n instead of asking $\omega \perp \mathcal{H}_p(\Omega_1)$ we need just $\omega \perp \mathcal{H}_p(\Omega)$.

Lemma 2.9. Still with the same hypotheses as above there is a (p, q-1) current u such that $\forall \alpha \in L_{(n-p,n-q+1)}^{s'}(\Omega,\eta), \ \langle u,\alpha \rangle = \mathcal{L}(\alpha) = (-1)^{p+q-1} \langle \omega,\varphi \rangle,$

and

$$\sup_{\alpha \in L^{s'}(\Omega, \eta_{\epsilon}), \|\alpha\|_{L^{s'}(\Omega, \eta_{\epsilon})} \le 1} |\langle u, \alpha \rangle| \le C \|\omega\|_{L^{r}(\Omega)},$$
constant C is independent of $\epsilon > 0$

where the constant C is independent of $\epsilon > 0$.

By lemma 2.7 we have that \mathcal{L} is a linear form on (n-p, n-q+1) currents $\alpha \in L^{s'}(\Omega, \eta)$, $\bar{\partial}$ closed

We also have that $\alpha \in L^{s'}(\Omega_1)$, $\bar{\partial}\alpha = 0$ in Ω_1 , hence still with the (s', r') regularity of Ω , we have $\exists \psi \in L_{(n-p,n-q)}^{r'}(\Omega_2) :: \bar{\partial} \psi = \alpha, \ \|\psi\|_{L^{r'}(\Omega_2)} \le C_2 \|\alpha\|_{L^{s'}(\Omega_1)}.$

• If q < n, we have $\bar{\partial}(\varphi - \psi) = \alpha - \alpha = 0$ on Ω_2 and, by the (s', r') regularity of Ω , there is a $\Omega_3 \subset \Omega_2$ such that Supp $\omega \subset \Omega_3 \subset \Omega_2$ and a $\gamma \in L_{(n-p,n-q-1)}^{r'}(\Omega_3)$, $\bar{\partial}\gamma = \varphi - \psi$ in Ω_3 , always because $s' \leq r'$. So we get

$$\langle \omega, \varphi - \psi \rangle = \langle \omega, \bar{\partial} \gamma \rangle = (-1)^{p+q-1} \langle \bar{\partial} \omega, \gamma \rangle = 0,$$

because Supp $\omega \subset \Omega_3$ and there is no boundary term. Hence

$$\mathcal{L}(\alpha) = \langle \omega, \varphi \rangle = \langle \omega, \psi \rangle.$$

• If q = n, we still have $\bar{\partial}(\varphi - \psi) = \alpha - \alpha = 0$ on Ω_2 , hence $\varphi - \psi \in \mathcal{H}_p(\Omega_2)$; this time we choose $U = \Omega_2$ and the assumption gives $\langle \omega, \varphi - \psi \rangle = 0$ hence again $\mathcal{L}(\alpha) = \langle \omega, \varphi \rangle = \langle \omega, \psi \rangle$.

In any cases, by Hölder inequalities

$$|\mathcal{L}(\alpha)| \le \|\omega\|_{L^{r}(\Omega_{1})} \|\psi\|_{L^{r'}(\Omega_{2})} = \|\omega\|_{L^{r}(\Omega)} \|\psi\|_{L^{r'}(\Omega_{2})},$$

because ω is compactly supported in $\Omega_1 \subset \Omega$.

By the (s', r') regularity of Ω there is a constant C_2 such that

$$\|\psi\|_{L^{r'}(\Omega_2)} \le C_2 \|\alpha\|_{L^{s'}(\Omega_1)}.$$

Of course we have

$$\|\alpha\|_{L^{s'}(\Omega_1)} \le \|\alpha\|_{L^{s'}(\Omega, \eta)}$$

$$\begin{split} \|\alpha\|_{L^{s'}(\Omega_1)} &\leq \|\alpha\|_{L^{s'}(\Omega,\ \eta)} \\ \text{because } \eta &= 1 \text{ on } \Omega_1,\ \eta > 0 \text{ on } \Omega, \text{ hence} \end{split}$$

$$|\mathcal{L}(\alpha)| \le C_2 \|\omega\|_{L^r(\Omega)} \|\alpha\|_{L^{s'}(\Omega, \eta)}.$$

So we have that the norm of \mathcal{L} is bounded on the subspace of $\bar{\partial}$ closed forms in $L^{s'}(\Omega, \eta_{\epsilon})$ by $C\|\omega\|_{L^r(\Omega)}$ which is independent of ϵ .

We apply the Hahn-Banach theorem to extend \mathcal{L} with the same norm to all (n-p, n-q+1)forms in $L^{s'}(\Omega, \eta)$. As in Serre duality theorem ([12], p. 20) this is one of the main ingredient in the proof.

This means, by the definition of currents, that there is a (p, q-1) current u which represents the extended form \mathcal{L} , i.e.

$$\forall \alpha \in L_{(n-p,n-q+1)}^{s'}(\Omega,\eta), \quad \langle u,\alpha \rangle = \mathcal{L}(\alpha) = (-1)^{p+q-1} \langle \omega,\varphi \rangle,$$

and such that

$$\sup_{\alpha \in L^{s'}(\Omega, \eta), \ \|\alpha\|_{L^{s'}(\Omega, \eta)} \le 1} \ |\langle u, \alpha \rangle| \le C \|\omega\|_{L^r(\Omega)}.$$

Theorem 2.10. Let Ω be a Stein manifold. Let ω be a (p,q) current in $L^{r,c}(\Omega)$, r>2 such that $\partial \omega = 0 \text{ if } 1 \leq q < n \text{ and } \forall h \in \mathcal{H}_p(\Omega), \ \langle \omega, h \rangle = 0 \text{ if } q = n.$

Then, for 2 < r < 2(n+1), there is a (p,q-1) current u in $L^{s,c}(\Omega)$ such that $\bar{\partial}u = \omega$ with $\frac{1}{s} = \frac{1}{r} - \frac{1}{2(n+1)}$.

For r=2(n+1) and any $s<\infty$, there is a (p,q-1) current u in $L^{s,c}(\Omega)$ such that $\bar{\partial}u=\omega$. For r>2(n+1), there is a (p,q-1) current u in $L^{\infty,c}(\Omega)$ such that $\bar{\partial}u=\omega$.

Moreover if the support of ω is contained in a s.p.c. domain $D \subset \Omega$, then the support of u is also contained in D.

Proof.

First we notice that $\frac{1}{s} = \frac{1}{r} - \frac{1}{2(n+1)} \Rightarrow \frac{1}{r'} = \frac{1}{s'} - \frac{1}{2(n+1)}$ where s', r' are the conjugate exponent of s, r respectively.

Because theorem 2.3 gives that a strictly pseudo convex D in Ω Stein is (s', r') regular if $r' \leq 2$, we have by lemma 2.9 with the weight $\eta = \eta_{\epsilon}$ and choosing $\Omega_1 = D$, a current u such that

$$\forall \alpha \in L_{(n-p,n-q+1)}^{s'}(\Omega,\eta), \ \langle u,\alpha \rangle = \mathcal{L}(\alpha)$$

and

$$\sup_{\alpha \in L^{s'}(\Omega, \eta), \|\alpha\|_{L^{s'}(\Omega, \eta)} \le 1} |\langle u, \alpha \rangle| \le C \|\omega\|_{L^r(\Omega)}.$$

By lemma 3.1, which will be proved in the appendix, this implies

$$||u||_{L^s(\Omega,\eta^{1-s})} \le C||\omega||_{L^r(\Omega)}.$$

In particular $||u||_{L^{s}(\Omega)} \leq C||\omega||_{L^{r}(\Omega)}$ because with $\epsilon < 1$ and s > 1, we have $\eta^{1-s} \geq 1$.

So apply this to $\varphi \in \mathcal{D}_{(n-p,n-q)}(\Omega)$, a test form, and set $\alpha = \bar{\partial}\varphi$, then $\alpha \in L^{s'}(\Omega, \eta)$ and $\varphi \in L^{r'}(\Omega, \eta)$, and we get

$$\langle u, \alpha \rangle = \mathcal{L}(\alpha) = (-1)^{p+q-1} \langle \omega, \varphi \rangle.$$

But, because φ has compact support,

$$\langle \dot{\bar{\partial}}u, \varphi \rangle = \langle u, \bar{\partial}\varphi \rangle = (-1)^{p+q-1} \langle \omega, \varphi \rangle$$

and this means precisely that $\bar{\partial}u = \omega$ in the distributions sense.

Now for $\epsilon > 0$ with $\eta_{\epsilon}(z) := \mathbb{1}_{\Omega_1}(z) + \epsilon \mathbb{1}_{\Omega \setminus \Omega_1}(z)$, let $u_{\epsilon} \in L^s(\Omega, \eta_{\epsilon}^{1-s})$ be the previous solution, then

$$||u_{\epsilon}||_{L^{s}(\Omega)}^{s} \leq \int_{\Omega} |u_{\epsilon}|^{s} \eta^{1-s} dm \leq C^{s} ||\omega||_{L^{r}(\Omega)}^{s}.$$

Replacing n by its value we get

$$\int_{\Omega_1} |u_{\epsilon}|^s dm + \int_{\Omega \setminus \Omega_1} |u_{\epsilon}|^s \epsilon^{1-s} dm \le C^s \|\omega\|_{L^r(\Omega)}^s \Rightarrow \int_{\Omega \setminus \Omega_1} |u_{\epsilon}|^s \epsilon^{1-s} dm \le C^s \|\omega\|_{L^r(\Omega)}^s$$

hence

$$\int_{\Omega \setminus \Omega_1} |u_{\epsilon}|^s dm \le C^s \epsilon^{s-1} \|\omega\|_{L^r(\Omega)}^s.$$

Because C and the norm of ω are independent of ϵ , we have that $\|u_{\epsilon}\|_{L^{s}(\Omega)}$ is uniformly bounded and $s > 1 \Rightarrow L^{s}(\Omega)$ is a dual, hence there is a sub-sequence $\{u_{\epsilon_{k}}\}_{k \in \mathbb{N}}$ of $\{u_{\epsilon}\}$ which converges weakly, when $\epsilon_{k} \to 0$, to a (p, q - 1) form u in $L^{s}(\Omega)$, still with $\|u\|_{L^{s}(\Omega)} \leq C\|\omega\|_{L^{r}(\Omega)}$.

To see that this form u is 0 a.e. on $\Omega \setminus D$ let us take a component $u_{I,J}$ of it; it is the weak limit of the sequence of functions $\{u_{\epsilon_k,I,J}\}$ which means, with the notations $v := u_{I,J}, \ v_k := u_{\epsilon_k,I,J}$

$$\forall f \in L^{s'}(\Omega), \ \int_{\Omega} v f dm = \lim_{k \to \infty} \int_{\Omega} v_k f dm.$$

As usual take $f := \frac{\overline{v}}{|v|} \mathbb{1}_E$ where $E := \{|v| > 0\} \cap (\Omega \backslash D)$ then we get

$$\int_{\Omega} vfdm = \int_{E} |v| \, dm = \lim_{k \to \infty} \int_{\Omega} v_k fdm = \lim_{k \to \infty} \int_{E} \frac{v_k \overline{v}}{|v|} dm.$$
 Now we have by Hölder

$$\left| \int_{E} \frac{v_{k} \overline{v}}{|v|} dm \right| \leq \|v_{k}\|_{L^{s}(E)} \|\mathbf{1}_{E}\|_{L^{s'}(E)}.$$

But

$$||v_k||_{L^s(E)}^s \le \int_{\Omega \setminus D} |u_{\epsilon_k}|^s dm \le (\epsilon_k)^{s-1} ||\omega||_{L^r(\Omega)}^s \to 0, \ k \to \infty.$$

Hence

$$\left| \int_{E} |v| \, dm \right| \leq C^{s} \|\mathbb{1}_{E}\|_{L^{s'}(E)} (\epsilon_{k})^{s-1} \|\omega\|_{L^{r}(\Omega)}^{s} \to 0$$

which implies m(E) = 0 because on E, |v| > 0

This being true for all components of u, we get that the form u is 0 a.e. on $\Omega \setminus D$ i.e. Supp $u \subset D$. So we get

bo we get
$$\forall \varphi \in \mathcal{D}_{n-p,n-q}(\Omega), \ (-1)^{p+q-1} \langle \omega, \ \varphi \rangle = \langle u_{\epsilon}, \ \bar{\partial} \varphi \rangle \rightarrow \langle u, \ \bar{\partial} \varphi \rangle \Rightarrow \langle u, \ \bar{\partial} \varphi \rangle = (-1)^{p+q-1} \langle \omega, \ \varphi \rangle$$
 hence $\bar{\partial} u = \omega$ as distributions. \blacksquare

Remark 2.11. The condition of orthogonality to $\mathcal{H}_p(V)$ in the case q=n is necessary: suppose there is a (p, n-1) current u such that $\partial u = \omega$ and u with compact support in an open set $V \subset \Omega$, then if $h \in \mathcal{H}_p(V)$, we have

$$h \in \mathcal{H}_p(V), \ \langle \omega, h \rangle = \langle \bar{\partial} u, h \rangle = (-1)^{n+p} \langle u, \bar{\partial} h \rangle = 0,$$

because, u being compactly supported, there is no boundary term and

$$\langle \bar{\partial}u, h \rangle = (-1)^{n+p} \langle u, \bar{\partial}h \rangle.$$

This condition was already seen by H. Skoda [13], Proposition 1, p. 292 and also for extension of CR functions, see [1] and the references therein.

Now we suppose that ω is a (p,q) current in $L^{r,c}(\Omega)$, $r\leq 2$ such that $\bar{\partial}\omega=0$, we shall prove the same theorem as above.

Theorem 2.12. Let Ω be a Stein manifold. Let ω be a (p,q) current in $L^{r,c}(\Omega)$, $r \leq 2$ such that $\bar{\partial}\omega = 0 \text{ if } 1 \leq q < n \text{ and } \forall h \in \mathcal{H}_p(\Omega), \ \langle \omega, h \rangle = 0 \text{ if } q = n.$

Then there is a (p, q-1) current u in $L^{s,c}(\Omega)$ such that $\bar{\partial}u = \omega$ with $\frac{1}{s} = \frac{1}{r} - \frac{1}{2(n+1)}$.

Moreover if the support of ω is contained in a s.p.c. $D \subset \Omega$, then the support of u is also contained in D.

Proof.

We shall use a form of the "raising steps method" we introduced and used in [3].

Let D be a s.p.c. domain in Ω containing Supp ω and $\chi_1 \in \mathcal{C}_c^{\infty}(D)$ such that $\chi_1 = 1$ on Supp ω . By theorem 2.3 there is a $u_1 \in L_{(p,q-1)}^{s_1}(\Omega)$ such that $\bar{\partial}u_1 = \omega$, with $\frac{1}{s_1} = \frac{1}{r} - \frac{1}{2(n+1)}$.

Let $v_1 := \chi_1 u_1$ then

$$\bar{\partial}v_1 = \bar{\partial}\chi_1 \wedge u_1 + \chi_1\omega = \bar{\partial}\chi_1 \wedge u_1 + \omega,$$

because $\chi_1 = 1$ on Supp ω . So set $\omega_1 := \bar{\partial}\chi_1 \wedge u_1$ then $\omega_1 \in L^{s_1}_{(p,q)}(\Omega)$ and we have

$$\bar{\partial}v_1 = \omega + \omega_1 \Rightarrow \bar{\partial}\omega_1 = \bar{\partial}^2v_1 - \bar{\partial}\omega = 0.$$

If q = n, then

$$\forall h \in \mathcal{H}_p(\Omega), \ \langle \bar{\partial}(\chi_1 u_1), h \rangle = 0,$$

because $\chi_1 u_1$ has compact support, so

$$\forall h \in \mathcal{H}_p(\Omega), \ 0 = \langle \bar{\partial} v_1, h \rangle = \langle \omega, \ h \rangle + \langle \omega_1, h \rangle = \langle \omega_1, \ h \rangle$$

because $\langle \omega, h \rangle = 0$ hence we have $\langle \omega_1, h \rangle = 0$. Of course we have also Supp $\omega_1 \subset D$.

Again with theorem 2.3 there is a $u_2 \in L^{s_2}_{(p,q-1)}(\Omega)$ such that $\bar{\partial}u_2 = \omega_1$, with $\frac{1}{s_2} = \frac{1}{s_1} - \frac{1}{2(n+1)} = \frac{1}{2(n+1)}$

$$\frac{1}{r} - \frac{2}{2(n+1)}$$
. Take $\chi_2 \in \mathcal{C}_c^{\infty}(D)$ such that $\chi_2 = 1$ on Supp ω_1 and set $v_2 := \chi_2 u_2$.

We have:

$$\bar{\partial}v_2 = \chi_2\omega_1 + \bar{\partial}\chi_2 \wedge u_2 = \omega_1 + \omega_2$$
, with $\omega_2 := \bar{\partial}\chi_2 \wedge u_2$ and $\omega_2 \in L^{s_2}_{(p,q)}(\Omega)$.

Then we get

$$\bar{\partial}(v_1 - v_2) = \omega + \omega_1 - (\omega_1 + \omega_2) = \omega - \omega_2$$

hence

$$\bar{\partial}\omega_2 = \bar{\partial}\omega - \bar{\partial}^2(v_1 - v_2) = 0.$$

If q = n, we have

$$\forall h \in \mathcal{H}_p(\Omega), \ 0 = \langle \bar{\partial} v_2, h \rangle = \langle \omega_1, \ h \rangle + \langle \omega_2, h \rangle = \langle \omega_2, \ h \rangle,$$

because $\langle \omega_1, h \rangle = 0$, hence $\langle \omega_2, h \rangle = 0$. And again Supp $\omega_2 \subset D$. Now if $\frac{1}{s_2} = \frac{1}{r} - \frac{2}{2(n+1)} < \frac{1}{2} \Rightarrow s_2 > 2$ then we can apply theorem 2.10 to have a current

 $u_3 \in L^{s_3,c}_{(p,q-1)}(\Omega)$ with $\overleftarrow{\partial} u_3 = \omega_2$ and Supp $u_3 \subset D$. Then we set

$$U := v_1 - v_2 + u_3$$
;

the form U has compact support in D, $U \in L^{s_1}_{(p,q-1)}(\Omega)$ and

$$\bar{\partial}U = \omega + \omega_1 - (\omega_1 + \omega_2) + \omega_2 = \omega.$$

If $s_2 \le 2$ we continue the process by induction and after a finite number, say N, of steps we have $s_N = \frac{1}{r} - \frac{N}{2(n+1)} < \frac{1}{2} \Rightarrow s_N > 2$

$$s_N = \frac{1}{r} - \frac{N}{2(n+1)} < \frac{1}{2} \Rightarrow s_N > 2$$

and by induction

$$\bar{\partial}\omega_{N-1}=0$$
 and if $q=n, \ \forall h\in\mathcal{H}_p(\Omega), \ \langle\omega_{N-1}, \ h\rangle=0$; Supp $\omega_{N-1}\subset D$.

 $\bar{\partial}\omega_{N-1}=0$ and if $q=n, \ \forall h\in\mathcal{H}_p(\Omega), \ \langle\omega_{N-1}, \ h\rangle=0$; Supp $\omega_{N-1}\subset D.$ So by theorem 2.10 we have a current $u_N\in L^{s_N,c}_{(p,q-1)}(\Omega)$ with $\bar{\partial}u_N=\omega_{N-1}$ and supported in D.Setting

$$U := \sum_{j=1}^{N-1} (-1)^{j+1} v_j + (-1)^{N+1} u_N,$$

we have $U \in L^{s_1}_{(p,q-1)}(\Omega)$, U has compact support in $D \subset \Omega$ and $\bar{\partial}U = \omega$.

2.3. Finer control of the support.

Here we shall get a better control on the support of a solution.

Theorem 2.13. Let Ω be a (s', r') regular domain in a Stein manifold X. Then for any (p, q) form ω in $L^{r,c}(\Omega,dm)$, $\bar{\partial}\omega=0$, if q< n, and $\omega\perp\mathcal{H}_p(\Omega)$ if q=n, with support in $\Omega\setminus C$ where C is a (s,s) regular domain, there is a $u \in L^{s,c}(\Omega,dm)$ such that $\bar{\partial}u = \omega$ and with support in $\Omega\setminus \bar{U}$, where U is any open set relatively compact in C, provided that $q \geq 2$.

Proof.

Let ω be a (p,q) form with compact support in $\Omega \setminus C$ then $\exists v \in L_{p,q-1}^s(\Omega), \ \bar{\partial}v = \omega$, with compact support in Ω , by theorem 2.10.

Because ω has its support outside C we have $\omega = 0$ in C; this means that $\partial v = 0$ in C. Because C is (s, s) regular and $q \geq 2$, we have

$$\exists C' \subset C, \ \overline{C'} \supset \overline{U}, \ \exists h \in L^s_{p,q-2}(C') \ s.t. \ \bar{\partial} h = v \ \text{in} \ C'.$$

Let χ be a smooth function such that $\chi = 1$ in U and $\chi = 0$ near $\partial C'$; then set

$$u := v - \bar{\partial}(\chi h).$$

We have that $u = v - \chi \bar{\partial} h - \bar{\partial} \chi \wedge h = v - \chi v - \bar{\partial} \chi \wedge h$ hence u is in L^s ; moreover u = 0 in \bar{U} because $\chi = 1$ in U hence $\bar{\partial}\chi = 0$ there. Finally $\bar{\partial}u = \bar{\partial}v - \bar{\partial}^2(\chi h) = \omega$ and we are done.

If Ω and C are, for instance, pseudo-convex in \mathbb{C}^n then $\Omega \setminus C$ is no longer pseudo-convex in general, so this theorem improves actually the control of the support.

Remark 2.14. If the correcting function h is given by kernels, then it is linear in ω ; if the primitive solution v is also linear in ω , then the solution u is linear too. This is the case in \mathbb{C}^n if we can use the solution given in [4].

This theorem cannot be true for q=1 as shown by the following example: Take a holomorphic function φ in the open unit ball B(0,1) in \mathbb{C}^n such that it extends to no open ball of center 0 and radius > 1. For instance $\varphi(z) := \exp\left(-\frac{z_1+1}{z_1-1}\right)$. Take R < 1, then φ is $\mathcal{C}^{\infty}(\bar{B}(0,R))$ hence by a theorem of Whitney φ extends \mathcal{C}^{∞} to \mathbb{C}^n ; call φ_R this extension. Let $\chi \in \mathcal{C}_c^{\infty}(B(0,2))$ such that $\chi = 1$ in the ball B(0,3/2) and consider the (0,1) form $\omega := \bar{\partial}(\chi \varphi_R)$. Then Supp $\omega \subset B(0,2)\backslash B(0,R)$, ω is $\bar{\partial}$ closed and is \mathcal{C}^{∞} hence in $L^r_{0,1}(B(0,2))$. Moreover B(0,R)is strictly pseudo-convex hence (r', r') regular, but there is no function u such that $\bar{\partial}u = \omega$ and u zero near the origin because any solution u will be C.R. on $\partial B(0,R)$ and by Hartog's phenomenon will extend holomorphically to B(0,R), hence cannot be identically null near 0.

Nevertheless in the case q=1, we have :

Theorem 2.15. Let Ω be a (r', r') regular domain in a Stein manifold X.

Then for any (p,1) form ω in $L^{r,c}(\Omega,dm)$, $\bar{\partial}\omega=0$, with support in $\Omega_1\backslash C$ where Ω_1 is a (r',r')regular domain in Ω and C is a domain such that $C \subset \Omega$ and $C \setminus \Omega_1 \neq \emptyset$; there is a $u \in L^{r,c}(\Omega, dm)$ such that $\partial u = \omega$ and with support in $\Omega \backslash C$.

Proof.

We have that ω is solvable in L^r by a $u \in L^r_{p,0}(\Omega_1)$ with compact support in Ω_1 , by theorem 2.10. Then $\bar{\partial}u=0$ in C hence u is locally holomorphic in C. Because $C\backslash\Omega_1\neq\emptyset$, there is an open set in $C\backslash\Omega_1\subset\Omega\backslash\Omega_1$ read in a coordinates patch, where u is 0 and holomorphic, hence u is identically 0 in C, C being connected.

Remark 2.16. If there is a $u \in L_{p,0}^{r,c}(\Omega_1)$ which is 0 in C then we have $\forall h \in L_{n-p,n-1}^{r'}(C) :: \operatorname{Supp} \bar{\partial} h \subset C, \ 0 = \langle u, \bar{\partial} h \rangle = \langle \omega, h \rangle,$

$$\forall h \in L_{n-p,n-1}^{r'}(C) :: \operatorname{Supp} \bar{\partial} h \subset C, \ 0 = \langle u, \bar{\partial} h \rangle = \langle \omega, h \rangle,$$

hence the necessary condition:

$$\forall h \in L_{n-p,n-1}^{r'}(C) :: \operatorname{Supp} \bar{\partial} h \subset C, \ \langle \omega, h \rangle = 0.$$

3. Appendix.

3.1. Duality.

Let \mathcal{I}_p be the set of multi-indices of length p in (1,...,n). We shall use the measure defined on $\Gamma := \Omega \times \mathcal{I}_p \times \mathcal{I}_q$ the following way:

$$d\mu(z,k,l) = d\mu_{\eta,p,q}(z,k,l) := \eta(z)dm(z) \otimes \sum_{|I|=p,\ |J|=q} \delta_I(k) \otimes \delta_J(l),$$

where $\delta_I(k) = 1$ if the multi-index k is equal to I and $\delta_I(k) = 0$ if not. This means, if f(z, I, J) is a function defined on Γ , that

$$\int f(z,k,l)d\mu_{\eta,p,q}(z,k,l):=\sum_{|I|=p,\ |J|=q}\int_{\Omega}f(z,I,J)\eta(z)dm(z).$$
 If I is a multi-index of length p , let I^c be the unique multi-index, ordered increasingly, such

that $I \cup I^c = (1, 2, ..., n)$; then I^c is of length n - p.

To
$$t = \sum_{|I|=p, |J|=q} t_{I,J}(z) dz^I \wedge d\bar{z}^J$$
 a (p,q) form, we associate the function on Γ :
$$T(z,I,J) := (-1)^{s(I,J)} t_{I,J}(z),$$

where

$$s(I,J) = 0$$
 if $dz^I \wedge d\bar{z}^J \wedge dz^{I^c} \wedge d\bar{z}^{J^c} = dz_1 \wedge \cdots \wedge dz_n \wedge d\bar{z}_1 \wedge \cdots \wedge d\bar{z}_n$ as a (n,n) form

and

$$s(I, J) = 1$$
 if not.

s(I,J)=1 if not. If $\varphi=\sum_{|I|=p,\ |J|=q} \varphi_{I^c,J^c}(z)dz^I\wedge d\bar{z}^J$ is of complementary bi-degree, associate in the same manner

$$\Phi^*(z, I, J) := \varphi_{I^c, J^c}(z)$$
. This is still a function on Γ .

Now we have, for $1 < r < \infty$, if T(z, I, J) is a function in Ω with $L^r(\Omega)$ coefficients and with $\mu = \mu_{\eta,p,q},$

$$||T||_{L^{r}(d\mu)}^{r} := \int |T(z, I, J)|^{r} d\mu_{\eta, p, q}(x, I, J) = \sum_{|I| = p, |J| = q} ||T(\cdot, I, J)||_{L^{r}(\Omega, \eta)}^{r}.$$

For $1 \le r < \infty$ the dual of $L^r(\mu)$ is $L^{r'}(\mu)$ where r' is the conjugate of r, $\frac{1}{r} + \frac{1}{r'} = 1$, and the norm is defined analogously with r' replacing r.

We also know that, for p, q fixed,

(3.1)
$$||T||_{L^{r}(\mu)} = \sup_{\Phi \in L^{r'}(\mu)} \frac{\left| \int T\Phi d\mu \right|}{\|\Phi\|_{L^{r'}(\mu)}}.$$

For a (p, q) form $t = \sum_{|J|=p, |K|=q} t_{J,K} dz^J \wedge d\bar{z}^K$, and a weight $\eta > 0$ we define its norm by :

(3.2)
$$||t||_{L^{r}(\Omega,\eta)}^{r} := \sum_{|J|=n, |K|=q} ||t_{J,K}||_{L^{r}(\Omega,\eta)}^{r} = ||T||_{L^{r}(\mu)}^{r}.$$

Now we can state

Lemma 3.1. Let $\eta > 0$ be a weight. If u is a (p,q) current defined on (n-p,n-q) forms in $L^{r'}(\Omega,\eta)$ and such that

$$\forall \alpha \in L_{(n-p,n-q)}^{r'}(\Omega,\eta), \ |\langle u, \alpha \rangle| \leq C \|\alpha\|_{L^{r'}(\Omega,\eta)},$$
then $\|u\|_{L^{r}(\Omega,\eta^{1-r})} \leq C.$

Proof.

Let us take the measure $\mu = \mu_{\eta,p,q}$ as above. Let Φ^* be the function on Γ associated to α and T the one associated to u. We have, by definition of the measure μ applied to the function

$$\begin{split} f(z,I,J) &:= T(z,I,J) \eta^{-1} \Phi^*(z,I,J), \\ &\int T \eta^{-1} \Phi^* d\mu = \int f(z,\ k,\ l) d\mu(z,k,l) := \sum_{|I|=p,\ |J|=q} \int_{\Omega} f(z,\ I,\ J) \eta(z) dm(z) = \\ &= \sum_{|I|=p,\ |J|=q} \int_{\Omega} T(z,I,J) \eta^{-1}(z) \Phi^*(z,I,J) \eta(z) dm(z) = \langle u,\ \alpha \rangle, \end{split}$$

by definition of T and Φ^* .

Hence we have, by (3.1)

$$||T\eta^{-1}||_{L^{r}(\mu)} = \sup_{\Psi \in L^{r'}(\mu)} \frac{|\langle u, \alpha \rangle|}{||\Psi||_{L^{r'}(\mu)}}.$$

But $||T\eta^{-1}||_{L^r(\mu)} = ||u\eta^{-1}||_{L^r(\Omega, \eta)}$ by (3.2), and

$$\|f\eta^{-1}\|_{L^r(\Omega,\eta)}^r = \int_{\Omega} |f\eta^{-1}|^r \eta dm = \int_{\Omega} |f|^r \eta^{1-r} dm = \|f\|_{L^r(\Omega,\eta^{1-r})},$$

so we get

$$||u||_{L^r(\Omega,\eta^{1-r})} = \sup_{\Psi \in L^{r'}(\mu)} \frac{|\langle u, \alpha \rangle|}{||\Psi||_{L^{r'}(\mu)}},$$

which implies the lemma because, still by (3.1), we can take $\Psi = \Phi^*$ and $\|\Psi\|_{L^{r'}(\mu)} = \|\alpha\|_{L^{r'}(\Omega,\eta)}$.

It may seem strange that we have such an estimate when the dual of $L^{r'}(\Omega, \eta)$ is $L^{r}(\Omega, \eta)$, but the reason is, of course, that in the duality forms-currents there is no weights.

3.2. Approximation.

We shall copy Hörmander in his proof of the approximation of $\bar{\partial}$ closed (0,0) forms to get the corresponding results for $\bar{\partial}$ closed (p,0) forms. Denote $\mathcal{H}_p(V)$ the set of (p,0) $\bar{\partial}$ closed forms in the open set V.

Theorem 3.2. Let Ω be a complex manifold and φ a strictly plurisubharmonic function in Ω such that

$$K_c := \{ z \in \Omega :: \varphi(z) \le c \} \subseteq \Omega$$

for every real number c. Every (p,0) form which is $\bar{\partial}$ closed in a neighbourhood of K_0 can then be approximated uniformly on K_0 by forms in $\mathcal{H}_p(\Omega)$.

Proof.

By the Hahn Banach theorem it suffices to prove that if $v \in L^2_{(p,0)}(K_0)$ and if

$$\langle u, v \rangle_{L^2_{(p,0)}(\Omega)} = 0$$

for all $u \in \mathcal{H}_p(\Omega)$ then (3.3) is true for every u in $\mathcal{H}_p(V)$ where V is a neighbourhood of K_0 eventually depending on u.

Set $\psi := \chi(\varphi)$ and extend the definition of v by setting v = 0 outside K_0 . Then (3.3) implies that ve^{ψ} is orthogonal to the null space N_T of the operator $T = \bar{\partial}$ operating from $L^2_{(p,0)}(\Omega, e^{-\psi})$ to $L^2_{(p,1)}(\Omega, e^{-\psi})$ because

$$u \in \mathcal{H}_p(\Omega) \Rightarrow \bar{\partial}u = 0$$

and then $u \in \mathcal{C}^{\infty}(\Omega)$ because in each coordinates path u has its coefficients holomorphic, hence is in the domain of T.

So we have, by inequality (5.2.14) on page 125 of [8], that, because Sf = 0,

$$\exists f \in L_{p,1}^2(\Omega, e^{-\psi}) :: T^* f = v e^{\psi} \text{ and } \|f\|_{\psi} \le \|e^{\psi}\|_{\psi}.$$

Using a partition of unity $\{\gamma_l\}_{l\in\mathbb{N}}$ we can suppose that $f_l := \gamma_l f$ has its support in a coordinates path with a \mathcal{C}^{∞} orthonormal basis $\omega_1, ..., \omega_n$ for forms of type (1,0).

So by (5.2.3) p. 122 of [8], we have, with
$$\delta_j w := e^{\psi} \frac{\partial (w e^{-\psi})}{\partial \omega_i}$$
,

$$e^{\psi}v = T^*f = \sum_{l} T^*f_l,$$

so, setting $v_l := e^{-\psi} T^* f_l$, we get

$$v = \sum_{l \in \mathbb{N}} v_l.$$

 $v = \sum_{l \in \mathbb{N}} v_l.$ Now in the coordinates path U_l we have

$$T^* f_l = (-1)^{p-1} \sum_{I,|I|=p}^{r} \sum_{j=1}^{n} \delta_j f_{I,j} \omega^I + \dots = Bf + \dots$$

where the dots indicate terms where no $f_{I,j}$ is differentiated and which do not involve ψ , hence

$$|T^*f_l - Bf_l| \le C |f_l|.$$

Now on we erase the subscript l on f to clarify the notations.

Setting $g_{I,j} := e^{-\psi} \delta_j f_{I,j}$, we get

$$v_l = (-1)^{p-1} \sum_{I,|I|=p}^{r} \sum_{j=1}^{n} g_{I,j} \omega^I + \cdots$$

and

$$\int |T^*f|^2 e^{-\psi} \ge \int |Bf|^2 e^{-\psi} - C \int |f|^2 e^{-\psi}$$

So

$$\int \sum_{I,|I|=p,j=1,\dots,n} |g_{I,j}|^2 e^{\psi} \le \int |v_l|^2 e^{\psi} + C \int |f_l|^2 e^{-\psi}.$$

So back to Ω and summing over l, we

$$\int |g|^2 e^{\psi} \le \int |v|^2 e^{\psi} + C \int |f|^2 e^{-\psi}.$$

But $\int |f|^2 e^{-\psi} \le \int |ve^{\psi}|^2 e^{-\psi} = \int |v|^2 e^{\psi}$, hence $\int |g|^2 e^{\psi} \le (C+1) \int |v|^2 e^{\psi}.$

Now recall that v=0 outside K_0 then we can choose a sequence χ_{ν} of convex functions so that $\chi_{\nu}(t)$ is independent of ν if $t \leq 0$ but $\chi_{\nu} \nearrow \infty$ when $\nu \to \infty$ if t > 0 and choose $\psi = \chi_{\nu}(\varphi)$ where $K_c := \{ z \in \Omega :: \varphi(z) \le c \} \subseteq \Omega.$

Then we have a sequence g^{ν} such that

$$\int |g^{\nu}|^2 e^{\chi_{\nu}(\varphi)} \le (C+1) \int |v|^2 e^{\chi_{\nu}(\varphi)} = (C+1) \int |v|^2 e^{\chi_{1}(\varphi)} = Cste,$$

because the right hand side is an integration only on K_0 and there $\varphi \leq 0 \Rightarrow \chi_{\nu}(\varphi) = \chi_1(\varphi)$. So

(3.5)
$$\int |g^{\nu}|^2 e^{\chi_{\nu}(\varphi)} dV \le Cste,$$

and because $\chi_{\nu} \geq \chi_1$, we have a subsequence of the sequence g^{ν} which converges weakly in the Hilbert space $L^2_{(p,1)}(\Omega,e^{\chi_1(\varphi)})$ to a limit g.

By (3.5) we obtain that g=0 where $\varphi>0$ and $T^*f=e^{\chi_1(\varphi)}v$, which means

 $T^*f - g = 0$ outside K_0

and, using (3.4),

$$|T^*f - g| \le C |f| \mathbb{1}_{K_0}.$$

We get by Cauchy-Schwarz inequality

$$\forall u \in \mathcal{C}^{\infty}_{(p,0)}(\Omega), \left| \int_{\Omega} \langle T^*f, u \rangle e^{-\psi} - \int_{\Omega} \langle g, u \rangle e^{-\psi} \right| \leq C \|f\|_{K_0} \|_{\psi} \|u\|_{K_0} \|_{\psi}.$$

Suppose now that $u \in \mathcal{C}_{(p,0)}^{\infty}$ is such that $\bar{\partial}u = 0$ in a neighbourhood V of K_0 and take a \mathcal{C}^{∞} function $\gamma :: \gamma = 0$ on K_0 and $\gamma = 1$ on V^c . Then $\gamma u \in \mathcal{C}_{(p,0)}^{\infty}(\Omega)$ and $\gamma u \equiv 0$ on K_0 , so

$$\left| \int_{\Omega} \langle T^*f, \gamma u \rangle e^{-\psi} - \int_{\Omega} \langle g, \gamma u \rangle e^{-\psi} \right| \leq C \|f \mathbb{1}_{K_0}\|_{\psi} \|u \mathbb{1}_{K_0}\|_{\psi} = 0,$$
 and, because g is supported by K_0 ,

$$\int_{\Omega} \langle g, \gamma u \rangle e^{-\psi} = 0,$$

$$0 = \int_{\Omega} \langle T^* f, \gamma u \rangle e^{-\psi} = \int_{\Omega} \langle f, \bar{\partial}(\gamma u) \rangle e^{-\psi}.$$

But $\bar{\partial}(\gamma u) = \bar{\partial}\gamma \wedge u + \gamma \bar{\partial}u = \bar{\partial}\gamma \wedge u$, hence, because $\bar{\partial}\gamma = 0$ in K_0 ,

(3.6)
$$\int_{\Omega} \langle f, \bar{\partial}(\gamma u) \rangle e^{-\psi} = \int_{\Omega \setminus K_0} \langle f, \bar{\partial}\gamma \wedge u \rangle e^{-\psi} = 0.$$

Now set $\tilde{u} := (1 - \gamma)u$; we have that \tilde{u} is an extension of u outside K_0 , i.e. $\forall z \in K_0$, $\tilde{u}(z) = u(z)$ and we have

$$\int_{K_0} \langle v, u \rangle = \int_{\Omega} \langle v, \tilde{u} \rangle = (-1)^{p-1} \int_{\Omega} \langle T^* f, \tilde{u} \rangle e^{-\psi} = (-1)^{p-1} \int_{\Omega} \langle f, \bar{\partial} \tilde{u} \rangle e^{-\psi}$$

because $ve^{\psi} = T^*f$, hence

$$\int_{K_0}^{\infty} \langle v, u \rangle = (-1)^{p-1} \int_{K_0} \langle f, \bar{\partial} \tilde{u} \rangle e^{-\psi} + (-1)^{p-1} \int_{\Omega \backslash K_0} \langle f, \bar{\partial} \tilde{u} \rangle e^{-\psi}.$$

But $\bar{\partial}\tilde{u} = \bar{\partial}(1-\gamma) \wedge u = -\bar{\partial}\gamma \wedge u$ hence using (3.6) we get

$$\int_{\Omega \backslash K_0} \langle f, \bar{\partial} \tilde{u} \rangle e^{-\psi} = 0$$

hence finally

$$\int_{K_0} \langle v, u \rangle = (-1)^{p-1} \int_{K_0} \langle f, \bar{\partial} \tilde{u} \rangle e^{-\psi} = 0$$

 $\int_{K_0} \langle v, u \rangle = (-1)^{p-1} \int_{K_0} \langle f, \bar{\partial} \tilde{u} \rangle e^{-\psi} = 0$ because again $\bar{\partial} \tilde{u} = \bar{\partial} (1 - \gamma) \wedge u = -\bar{\partial} \gamma \wedge u = 0$ on K_0 . So we prove that for any $u \in \mathcal{C}^{\infty}_{(p,0)}(\Omega)$:: $\bar{\partial} u = 0$ in a neighbourhood of K_0 , we have that $\int_{\mathcal{V}} \langle v, u \rangle = 0$ which proves the theorem.
