# Consistency of the posterior distribution and MLE for piecewise linear regression

#### Abstract

We prove the weak consistency of the posterior distribution and that of the Bayes estimator for a two-phase piecewise linear regression mdoel where the break-point is unknown. The non-differentiability of the likelihood of the model with regard to the break-point parameter induces technical difficulties that we overcome by creating a regularised version of the problem at hand. We first recover the strong consistency of the quantities of interest for the regularised version, using results about the MLE, and we then prove that the regularised version and the original version of the problem share the same asymptotic properties. keywords : consistency ; asymptotic distribution ; posterior distribution ; MLE ; piecewise regression.


## 1 Introduction

We consider a continuous segmented regression model with 2 phases, one of them (the rightmost) being zero. Let $u$ be the unknown breakpoint and $\gamma$ be the unknown regression coefficient of the non-zero phase. The observations $X_{1: n}=\left(X_{1}, \ldots, X_{n}\right)$ depend on an exogenous variable that we denote $t_{1: n}=\left(t_{1}, \ldots, t_{n}\right)$ via the model given for $i=1, \ldots, n$ by

X_{i}=\mu\left(\eta, t_{i}\right)+\xi_{i}:=\gamma(t-u) \mathbb{1}_{[t,+\infty[ }(u)+\xi_{i}, \tag{1.1}
\end{equation*}

where $\left(\xi_{i}\right)_{i \in \mathbb{N}}$ is a sequence of independent and identically distributed (i.i.d.) random variables with a common centered Gaussian distribution of unknown variance $\sigma^{2}, \mathcal{N}\left(0, \sigma^{2}\right)$.

Such a model is for instance used in practice to estimate and predict the heating part of the electricity demand in France. See Bruhns et al. (2005) for the definition of the complete model and Launay et al. (2011) for a Bayesian approach. In this particular case, $u$ corresponds to the heating threshold above which the temperatures $t_{1: n}$ do not have any effect over the electricity load, and $\gamma$ corresponds to the heating gradient i.e. the strength of the described heating effect.

The work presented in this paper is most notably inspired by the results developed in Ghosh et al. (2006) and Feder (1975).

Feder proved the weak consistency of the least squares estimator in segmented regression problems with a known finite number of phases under the hypotheses of his Theorem 3.10 and some additional assumptions disseminated throughout his paper, amongst which we find that the empirical cumulative distribution functions of the temperatures at the $n$-th step $t_{n 1}, \ldots, t_{n n}$ are required to converge to a cumulative distribution function, say $F_{n}$ converges to $F$, which is of course to be compared to our own Assumption (A1). Feder also derived the asymptotic distribution of the least squares estimator under the same set of assumptions. Unfortunately there are a few typographical errors in his paper (most notably resulting in the disappearance of $\sigma_{0}^{2}$ from the asymptotic variance matrix in his main theorems), and he also did not include $\widehat{\sigma}_{n}^{2}$ in his study of the asymptotic distribution.

In his unpublished technical report, Sylwester introduced the very interesting concept of a pseudo-problem, which inspired Feder's work. ${ }^{1}$

The asymptotic behaviour of the posterior distribution is a central question that has already been raised in the past. For example, Ghosh et al. worked out the limit of the posterior distribution in a general and regular enough i.i.d. setup. In particular they manage to derive the asymptotic normality of the posterior distribution under third-order differentiability conditions. There are also a number of works dealing with some kind of non-regularity, like these of Sareen (2003) which consider data the support of which depends on the parameters to be estimated, or those of Ibragimov and Has'minskii (1981) which offer the limiting behaviour of the likelihood ratio for a wide range of i.i.d. models whose likelihood may present different types of singularity. Unfortunately, the heating part model presented here does not fall into any of these already studied categories.

In this paper, we show that the results of Ghosh et al. can be extended to a non-i.i.d. twophase regression model. We do so by using the original idea first found in Sylwester (1965) : we introduce a new, regularised version of the problem (called pseudo-problem), that is easier to work with, and for which we recover the results of Ghosh et al.. We then extend these results to the (full) problem by showing that the estimates for the problem and the pseudo-problem have the same asymptotic behaviour.

From this point on, we shall denote the parameters $\theta=\left(\gamma, u, \sigma^{2}\right)=\left(\eta, \sigma^{2}\right)$ and $\theta_{0}$ will denote the true value of $\theta$. We may also occasionally refer to the intercept of the model as $\beta=-\gamma u$. The log-likelihood of the $n$ first observations $X_{1: n}$ of the model will be denoted

where $l_{i}\left(X_{i} \mid \theta\right)$ designates the log-likelihood of the $i$-th observation $X_{i}$, i.e.

\end{equation*}

Notice that we do not mention explicitly the link between the likelihood $l$ and the sequence of temperatures $\left(t_{n}\right)_{n \in \mathbb{N}}$ in these notations, so as to keep them as minimal as possible. The least square estimator $\widehat{\theta}_{n}$ of $\theta$ being also the maximum likelihood estimator of the model, we refer to it as the MLE.

Throughout the rest of this paper we work under the following assumptions
Assumption (A1). The sequence of temperatures (exogenous variable) $\left(t_{n}\right)_{n \in \mathbb{N}}$ belongs to a compact set $[\underline{u}, \bar{u}]$ and the sequence of the empirical cumulative distribution functions $\left(F_{n}\right)_{n \in \mathbb{N}}$ of $\left(t_{1}, \ldots, t_{n}\right)$, defined by

F_{n}(u)=\frac{1}{n} \sum_{i=1}^{n} \mathbb{1}_{\left[t_{i},+\infty[ \right.}(u)
$$

converges to a function $F$ where $F$ is a cumulative distribution function itself, which is continuously differentiable over $[\underline{u}, \bar{u}]$.

Remark 1. Due to a counterpart to Dini's Theorem (see Theorem 5.1 taken from Polya and Szegö, 2004, (p81)), $F_{n}$ converges to $F$ uniformly over $[\underline{u}, \bar{u}]$.

Remark 2. Let $h$ be a continuous, bounded function on $[\underline{u}, \bar{u}]$. As an immediate consequence

[^0]of this assumption, for any interval $I \subset[\underline{u}, \bar{u}]$, we have, as $n \rightarrow+\infty$

the convergence holding true by definition of the convergence of probability measures (see Billingsley, 1999, pages $14-16)$. In particular, for $I=[\underline{u}, \bar{u}]$ and $I=]-\infty, u]$ we get, as $n \rightarrow+\infty$

Remark 3. It is a general enough assumption which encompasses both the common cases of i.i.d. continuous random variables and periodic (non-random) variables under a continous (e.g. Gaussian) noise.

Assumption (A2). $\quad \theta_{0} \in \Theta$, where the parameter space $\Theta$ is defined (for identifiability) as

Assumption (A3). $f=F^{\prime}$ does not vanish (i.e. is positive) on $] \underline{u}, \bar{u}[$.
Assumption (A4). There exists $K \subset \Theta$ a compact subset of the parameter space $\Theta$ such that $\widehat{\theta}_{n} \in K$ for any $n$ large enough.

The paper is organised as follows. In Section 2, we present the Bayesian consistency (the proofs involved there rely on the asymptotic distribution of the MLE) and introduce the concept of pseudo-problem. In Section 3, we prove that the MLE for the full problem is strongly consistent. In Section 4 we derive the asymptotic distribution of the MLE using the results of Section 3: to do so, we first derive the asymptotic distribution of the MLE for the pseudo-problem and then show that the MLEs for the pseudo-problem and the problem share the same asymptotic distribution. Most of the technical results and their proofs are found in the appendix at the end of this paper.

Notations. Whenever mentionned, the O and o notations will be used to designate a.s. O and a.s. o respectively, unless there are indexed with $\mathbb{P}$ as in $O_{\mathbb{P}}$ and $o_{\mathbb{P}}$, in which case they will designate O and o in probability respectively.

## 2 Bayesian consistency

In this Section, we show that the posterior distribution of $\theta$ given $\left(X_{1}, \ldots, X_{n}\right)$ asymptotically favours any neighbourhood of $\theta_{0}$ as long as the prior distribution itself charges a (possibly different) neighbourhood of $\theta_{0}$ (see Theorem 2.1). We then present the central result of this paper (see Theorem 2.2), whose proof we discuss in this Section.

### 2.1 Consistency and asymptotic normality of the posterior distribution

Theorem 2.1. Let $\pi(\cdot)$ be a prior distribution on $\theta$, continuous and positive on a neighbourhood of $\theta_{0}$ and let $U$ be a neighbourhood of $\theta_{0}$, then under Assumptions (A1)-(A4), as $n \rightarrow+\infty$,

Proof of Theorem 2.1. The proof is very similar to the one given in Ghosh and Ramamoorthi (2003) for a model with i.i.d. observations. It mainly relies on the key result contained in Proposition 5.11.

Denote

and let $\delta>0$ (to be adjusted later) small enough so that $B\left(\theta_{0}, \delta\right) \subset U$. It will suffice to show that

\int_{U} \pi\left(\theta \mid X_{1: n}\right) \mathrm{d} \theta=\frac{1}{1+\frac{\int_{U^{c}} \pi(\theta) \exp \left[l_{1: n}\left(X_{1: n} \mid \theta\right)-l_{1: n}\left(X_{1: n} \mid \theta_{0}\right)\right] \mathrm{d} \theta}{\int_{U} \pi(\theta) \exp \left[l_{1: n}\left(X_{1: n} \mid \theta\right)-l_{1: n}\left(X_{1: n} \mid \theta_{0}\right)\right] \mathrm{d} \theta}}
$$

and

\begin{aligned}
0 & \leqslant \frac{\int_{U^{c}} \pi(\theta) \exp \left[l_{1: n}\left(X_{1: n} \mid \theta\right)-l_{1: n}\left(X_{1: n} \mid \theta_{0}\right)\right] \mathrm{d} \theta}{\int_{U} \pi(\theta) \exp \left[l_{1: n}\left(X_{1: n} \mid \theta\right)-l_{1: n}\left(X_{1: n} \mid \theta_{0}\right)\right] \mathrm{d} \theta} \\
& \leqslant \frac{\int_{B^{c}\left(\theta_{0}, \delta\right)} \pi(\theta) \exp \left[l_{1: n}\left(X_{1: n} \mid \theta\right)-l_{1: n}\left(X_{1: n} \mid \theta_{0}\right)\right] \mathrm{d} \theta}{\int_{B\left(\theta_{0}, \delta\right)} \pi(\theta) \exp \left[l_{1: n}\left(X_{1: n} \mid \theta\right)-l_{1: n}\left(X_{1: n} \mid \theta_{0}\right)\right] \mathrm{d} \theta} .

To prove (2.2) we adequately majorate its numerator and minorate its denominator.
Majoration. From Proposition 5.11 with $\rho_{n}=1$, for any given $\epsilon>0$, we can choose $\delta>0$ small enough so that a.s. for any $n$ large enough

Minoration. Define $\theta_{n} \in \overline{B\left(\theta_{0}, \delta\right)}$ such that

It is possible to define such a $\theta_{n}$ because $\overline{B\left(\theta_{0}, \delta\right)}$ is a compact subset of $\Theta$ for $\delta>0$ small enough and $l_{1: n}\left(X_{1: n} \mid \cdot\right)$ is continuous as a function of $\theta$. Let now

Recalling the definition of the log-likehood given in (1.2) and replacing $X_{i}$ by its expression given in (1.1) we find via straightforward algebra

where $R_{n} \xrightarrow{\text { a.s. }} 0$ because of the Law of Large Numbers and Lemma 5.6. Thanks to Lemma 5.3 we thus find that there exists $C \in \mathbb{R}_{+}^{*}$ such that

Thanks to (2.7) and the definition of $\theta_{n}$, we can now write that

\inf _{\theta \in B\left(\theta_{0}, \delta\right)} \frac{2}{n}\left[l_{1: n}\left(X_{1: n} \mid \theta\right)-l_{1: n}\left(X_{1: n} \mid \theta_{0}\right)\right] & \geqslant-\frac{1}{\sigma_{n}^{2}}\left(\kappa+C\left\|\theta_{n}-\theta_{0}\right\|^{2}-R_{n}\right) \\
& \geqslant-\frac{1}{\sigma_{n}^{2}}\left(\kappa+C \delta^{2}-R_{n}\right) .
\end{aligned}
$$

Since for any $n$ large enough

& \geqslant-\frac{3\left(\kappa+C \delta^{2}\right)}{2\left(\sigma_{0}^{2}-\delta\right)} \geqslant-\frac{1}{2} \epsilon
\end{aligned}
$$

We just proved that for any $\epsilon>0$, we have a.s. for any $n$ large enough

Let now $\epsilon>0$ and $\delta>0$ small enough so that a.s. for any $n$ large enough (2.3) and (2.9) both hold. We have a.s. for any $n$ large enough

$$

which ends the proof.
Let $\theta \in \Theta$, we first define $I(\theta)$, the asymptotic Fisher Information matrix $I($ theta $)$ of the model, as the symmetric matrix given by

It is obviously positive and definite since all its principal minor determinants are positive. The proof of the fact that it is indeed the limiting matrix of the Fisher Information matrix of the model is deferred to Lemma 5.10.

Theorem 2.2. Let $\pi(\cdot)$ be a prior distribution on $\theta$, continuous and positive at $\theta_{0}$, and let $k_{0} \in \mathbb{N}$ such that

where $I(\theta)$ is defined in (2.10).
The key ideas behind the proof of Theorem 2.2 are discussed in the next subsection 2.2.

### 2.2 Pseudo-problem

The major challenge in proving Theorem 2.2 is that the typical arguments usually used to derive the asymptotic behaviour of the posterior distribution (see Ghosh et al., 2006, for example) do not directly apply here. The proof provided by Ghosh et al. requires a Taylor expansion of the likelihood of the model up to the third order at the MLE, and the likelihood of the model we consider here at the $n$-th step is very obviously not continuously differentiable w.r.t. $u$ in each observed temperature $t_{i}, i=1, \ldots, n$. Note that the problem only grows worse as the number of observations increases.

To overcome this difficulty we follow the original idea first introduced in Sylwester (1965), and later used again in Feder (1975) : we introduce a pseudo-problem for which we are able to recover the classical results and show that the differences between the estimates for the problem and the pseudo-problem are, in a sense, negligeable. The pseudo-problem is obtained by deleting all the observations within intervals $D_{n}$ of respective sizes $d_{n}$ centred around $u_{0}$. The intervals $D_{n}$ are defined as

\left.D_{n}=\right] u_{0}-\frac{d_{n}}{2}, u_{0}+\frac{d_{n}}{2}[

and their sizes $d_{n}$ are chosen such that as $n \rightarrow+\infty$

\end{equation*}

This new problem is called pseudo-problem because the value of $u_{0}$ is unknown and we therefore cannot in practice delete these observations. Note that the actual choice of the sequence $\left(d_{n}\right)_{n \in \mathbb{N}}$ does not influence the rest of the results in any way, as long as it satisfies to conditions (2.13). It thus does not matter at all whether one chooses (for instance) $d_{n}=n^{-\frac{1}{4}}$ or $d_{n}=\log ^{-1} n$.

Let us denote $n^{* *}$ the number of observations deleted from the original problem, and $n^{*}=$ $n-n^{* *}$ the sample size of the pseudo-problem. Generally speaking, quantities annotated with a single asterisk * will refer to the pseudo-problem. $l_{1: n}^{*}\left(X_{1: n} \mid \theta\right)$ will thus designate the likelihood of the pseudo-problem i.e. (reindexing observations whenever necessary)

On one hand, from an asymptotic point of view, the removal of those $n^{* *}$ observations should not have any kind of impact on the distribution theory. The intuitive idea is that deleting $n^{* *}$ observations takes away only a fraction $n^{* *} / n$ of the information which asymptotically approaches zero as will be shown below. The first condition (2.13) seems only a natural requirement if we ever hope to prove that the MLE for the problem and the pseudo-problem behave asymptotically in a similar manner (we will show they do in Theorem 4.2, see equation (4.2)).

On the other hand, assuming the MLE is consistent (we will show it is, in Theorem 3.4) and assuming that the sizes $d_{n}$ are carefully chosen so that the sequence $\left(\widehat{u}_{n}\right)_{n \in \mathbb{N}}$ falls into the designed sequence of intervals $\left(D_{n}\right)_{n \in \mathbb{N}}$ (see Proposition 4.1, whose proof the second condition (2.13) is tailored for), these regions will provide open neighbourhoods of the MLE over which the likelihood of the pseudo-problem will be differentiable. The pseudo-problem can therefore be
thought of as a locally regularised version of the problem (locally because we are only interested in the differentiability of the likelihood over a neighbourhood of the MLE). We should thus be able to retrieve the usual results for the pseudo-problem with a bit of work. It will be shown that this is indeed the case (see Theorem 2.3).

If the sequence $\left(d_{n}\right)_{n \in \mathbb{N}}$ satisfies to conditions (2.13), then as $n \rightarrow+\infty$,

where $u_{n} \in D_{n}$, so that in the end, since $u_{n} \rightarrow u_{0}$ and $f$ is continuous and positive at $u_{0}$, we have a.s.

### 2.3 Asymptotic posterior distribution (for the pseudo-problem)

We now recover the asymptotic normality of the posterior distribution for the pseudo problem.
Theorem 2.3. Let $\pi(\cdot)$ be a prior distribution on $\theta$, continuous and positive at $\theta_{0}$, and let $k_{0} \in \mathbb{N}$ such that

Proof of Theorem 2.3. This proof is inspired by that of Theorem 4.2 in Ghosh et al. (2006) which deals with the case where the observations $X_{1}, \ldots, X_{n}$ are independent and identically distributed and where the (univariate) log-likelihood is differentiable in a fixed small neighbourhood of $\theta_{0}$. Because the posterior distribution of $\theta$ in the pseudo-problem, $\pi_{n}^{*}\left(\cdot \mid X_{1: n}\right)$, can be written as

& -\pi\left(\theta_{0}\right) e^{-\frac{1}{2} t^{\prime} I\left(\theta_{0}\right) t} \tag{2.18}
\end{align*}

to prove (2.16) it suffices to show that for any $0 \leqslant k \leqslant k_{0}$,

also goes to zero a.s.
Let $0<\delta$ to be chosen later, and let $0 \leqslant k \leqslant k_{0}$. To show (2.19), we break $\mathbb{R}^{3}$ into two regions

This way, $\theta \mapsto l_{1: n}^{*}\left(X_{1: n} \mid \theta\right)$ is guaranteed to be infinitely continuously differentiable over $B\left(\theta_{0},\left(\delta+\delta_{0}\right) d_{n}\right) \subset B\left(\theta_{0}, d_{n}\right)$.

Now expanding the log-likelihood in a Taylor series for any $n$ large enough, and taking advantage of the fact that $l_{1: n}^{*}\left(X_{1: n} \mid \widehat{\theta}_{n}^{*}\right)=0$, we define $B_{1: n}^{*}(\cdot)$ the symmetric matrix defined for $u \in D_{n}$ by

& \frac{\partial^{2} l_{1: n}^{*}\left(X_{1: n} \mid \theta\right)}{\partial u \partial u} & \frac{\partial^{2} l_{1: n}^{*}\left(X_{1: n} \mid \theta\right)}{\partial u \partial \sigma^{2}} \\
& & \frac{\partial^{2} l_{1: n}^{*}\left(X_{1: n} \mid \theta\right)}{\partial \sigma^{2} \partial \sigma^{2}}
\end{array}\right] .
$$

and write that

& +R_{3, n}(\theta) \tag{2.24}
\end{align*}

Therefore, for $n$ large enough, $\|t\|^{k}\left|g_{n}(t)\right|$ is dominated by an integrable function on the set $T_{2}(\delta)$ and (2.20) holds for $i=2$ which completes the proof.

### 2.4 Proof of Theorem 2.2

We now give a short proof of Theorem 2.2. As we previously announced, it relies heavily upon its counterpart for the pseudo-problem, i.e. Theorem 2.3.

Proof of Theorem 2.2. Recalling the definition of $t^{*}$ and $\widetilde{\pi}_{n}^{*}\left(\cdot \mid X_{1: n}\right)$ given in (2.15) that mimic the definition of $t$ and $\widetilde{\pi}_{n}\left(\cdot \mid X_{1: n}\right)$ given in (2.11), we first observe that

& \left.=\left.\int_{\mathbb{R}^{3}}\|t\|^{k}\left|\widetilde{\pi}_{n}^{*}\left(t-\alpha_{n} \mid X_{1: n}\right)-(2 \pi)^{-\frac{3}{2}}\right| I\left(\theta_{0}\right)\right|^{\frac{1}{2}} e^{-\frac{1}{2} t^{\prime} I\left(\theta_{0}\right) t} \right\rvert\, \mathrm{d} t \\
& \left.=\left.\int_{\mathbb{R}^{3}}\left\|t+\alpha_{n}\right\|^{k}\left|\widetilde{\pi}_{n}^{*}\left(t \mid X_{1: n}\right)-(2 \pi)^{-\frac{3}{2}}\right| I\left(\theta_{0}\right)\right|^{\frac{1}{2}} e^{-\frac{1}{2}\left(t+\alpha_{n}\right)^{\prime} I\left(\theta_{0}\right)\left(t+\alpha_{n}\right)} \right\rvert\, \mathrm{d} t \\
& \leqslant \\
& \left.\left.\quad \int_{\mathbb{R}^{3}}\left\|t+\alpha_{n}\right\|^{k}\left|\widetilde{\pi}_{n}^{*}\left(t \mid X_{1: n}\right)-(2 \pi)^{-\frac{3}{2}}\right| I\left(\theta_{0}\right)\right|^{\frac{1}{2}} e^{-\frac{1}{2} t^{\prime} I\left(\theta_{0}\right) t} \right\rvert\, \mathrm{d} t \\
& \quad \quad+(2 \pi)^{-\frac{3}{2}}\left|I\left(\theta_{0}\right)\right|^{\frac{1}{2}} \int_{\mathbb{R}^{3}}\left\|t+\alpha_{n}\right\|^{k}\left|e^{-\frac{1}{2}\left(t+\alpha_{n}\right)^{\prime} I\left(\theta_{0}\right)\left(t+\alpha_{n}\right)}-e^{-\frac{1}{2} t^{\prime} I\left(\theta_{0}\right) t}\right| \mathrm{d} t
\end{aligned}
$$

Theorem 2.3 ensures that the first integral on the right hand side of this last inequality goes to zero in probability. It therefore suffices to show that the second integral goes to zero in probability to end the proof, i.e. that as $n \rightarrow+\infty$

But the proof of (2.30) is straightforward knowing that $\alpha_{n} \xrightarrow{\mathbb{P}} 0$ (see (4.2)) and using dominated convergence.

As an immediate consequence of Theorem 2.2 we want to mention the weak consistency of the Bayes estimator.
Corollary 2.4. Let $\pi(\cdot)$ a prior distribution on $\theta$, continuous and positive at $\theta_{0}$, such that

the last convergence being a direct consequence of Theorem 2.2 with $k_{0}=1$.
Observe that, under conditions (2.13), the same arguments naturally apply to the pseudoproblem and lead to a strong consistency (a.s. convergence) of its associated Bayes estimator due to Theorem 2.3, thus recovering the results of Ghosh et al. (2006) for the regularised version of the problem.

## 3 Strong consistency of the MLE

In this Section we prove the strong consistency of the MLE over any compact set including the true parameter (see Theorem 3.1). It is a prerequisite for a more accurate version of the strong consistency (see Theorem 3.4) which lies at the heart of the proof of Theorem 2.3.

Theorem 3.1. Under Assumptions (A1)-(A4), we have a.s., as $n \rightarrow+\infty$,

Proof of Theorem 3.1. Recall that $K$ is a compact subset of $\Theta$, such that $\hat{\theta}_{n} \in K$ for any $n$ large enough. We denote

\leqslant & -b_{n}(\theta)+\frac{\sigma_{0}^{2}-\sigma^{2}}{\sigma^{2} \sigma_{0}^{2}}\left(\frac{1}{n} \sum_{i=1}^{n} \xi_{i}^{2}-\sigma_{0}^{2}\right) \\
& -\frac{2}{\sigma^{2}} \frac{1}{n} \sum_{i=1}^{n}\left[\mu\left(\eta_{0}, t_{i}\right)-\mu\left(\eta, t_{i}\right)\right] \xi_{i} .
\end{aligned}
$$

For any $\theta^{\prime} \in \Theta$ and $r>0$, let $B\left(\theta^{\prime}, r\right)=\left\{\theta, ;\left\|\theta^{\prime}-\theta\right\|_{1}<r\right\}$. It is now obvious that

& \leqslant \sup _{\theta \in B\left(\theta^{\prime}, r\right)}\left\{-b_{n}(\theta)\right\}+\sup _{\theta \in B\left(\theta^{\prime}, r\right)}\left|\frac{\sigma_{0}^{2}-\sigma^{2}}{\sigma^{2} \sigma_{0}^{2}}\right| \cdot\left|\frac{1}{n} \sum_{i=1}^{n} \xi_{i}^{2}-\sigma_{0}^{2}\right| \\
& \quad+\sup _{\theta \in B\left(\theta^{\prime}, r\right)}\left\{\frac{2}{\sigma^{2}}\right\} \cdot \sup _{\theta \in B\left(\theta^{\prime}, r\right)}\left\{\left|\frac{1}{n} \sum_{i=1}^{n}\left[\mu\left(\eta_{0}, t_{i}\right)-\mu\left(\eta, t_{i}\right)\right] \xi_{i}\right|\right\} . \tag{3.1}
\end{align*}
$$

Lemma 5.6 now ensures that

and $\sigma^{2}$ being bounded away from 0 ensures the boundedness of $\sup _{\theta \in B\left(\theta^{\prime}, r\right)}\left\{\frac{2}{\sigma^{2}}\right\}$ which implies

\sup _{\theta \in B\left(\theta^{\prime}, r\right)}\left\{\frac{2}{\sigma^{2}}\right\} \cdot \sup _{\theta \in B\left(\theta^{\prime}, r\right)}\left\{\left|\frac{1}{n} \sum_{i=1}^{n}\left[\mu\left(\eta_{0}, t_{i}\right)-\mu\left(\eta, t_{i}\right)\right] \xi_{i}\right|\right\} \xrightarrow{a . s .} 0

Since $\sigma^{2}$ is bounded away from 0 , taking advantage of the Strong Law of Large Numbers, we also obtain

\end{aligned}

thanks to the finiteness of $m(\delta)$, and finally into

Let us now sum up what we have obtained so far. We proved that

Finally, denote $\mu^{*}$ the orthogonal projection of $X$ onto $\mathcal{G}^{+}$and $\widehat{\mu}$ the closest point to $X$ in $\mathcal{G}^{+}$ satisfying the continuity assumption of the model, i.e.

\left\|\mu^{*}-\mu_{0}\right\|^{2}-2\left\langle\mu^{*}-\mu_{0}, \widehat{\mu}-\mu_{0}\right\rangle+\left\|\widehat{\mu}-\mu_{0}\right\|^{2} \leqslant\left\|\mu^{*}-\mu_{0}\right\|^{2} .

& \leqslant(\max (|\underline{u}|,|\bar{u}|)+1) \cdot\left|\sum_{i=1}^{N_{n}}\right| \beta_{0}+\gamma_{0} t_{i}\left|-\sum_{i=1}^{N_{0, n}}\right| \beta_{0}+\gamma_{0} t_{i}| | \\
& \leqslant(\max (|\underline{u}|,|\bar{u}|)+1) \cdot\|\zeta\|_{1} \\
& \leqslant(\max (|\underline{u}|,|\bar{u}|)+1) \cdot\|\zeta\| \cdot n^{\frac{1}{2}}\left|N_{n}-N_{0, n}\right|^{\frac{1}{2}} \\
& \leqslant(\max (|\underline{u}|,|\bar{u}|)+1) \cdot\|\zeta\| \cdot n^{\frac{1}{2}}\left|\frac{1}{n} \sum_{i=1}^{n} \mathbb{1}_{\left[t_{i},+\infty[ \right.}\left[\widehat{u}_{n}\right)-\frac{1}{n} \sum_{i=1}^{n} \mathbb{1}_{\left[t_{i},+\infty[ \right.}\left(u_{0}\right)\right|^{\frac{1}{2}},

i.e. we have a.s. for any $\phi \in[0,2 \pi]$

&+\frac{1}{n} \sum_{i=1}^{n} t_{i}^{2} \mathbb{1}_{\left[t_{i},+\infty[ \right.}\left(\widehat{u}_{n}\right) \sin ^{2} \phi \\
& \xrightarrow{\text { a.s. }} \cos ^{2} \phi \int_{\underline{u}}^{u_{0}} f(t) \mathrm{d} t+\cos \phi \sin \phi \int_{\underline{u}}^{u_{0}} 2 t f(t) \mathrm{d} t+\sin ^{2} \phi \int_{\underline{u}}^{u_{0}} t^{2} f(t) \mathrm{d} t

\sup _{i \in \mathbb{N}}\left|\nu_{i}\left(\widehat{\eta}_{n}\right)\right|= & \sup _{i \in \mathbb{N}}\left|\gamma_{0}\left(t_{i}-u_{0}\right) \mathbb{1}_{\left[t_{i},+\infty[ \right.}\left(u_{0}\right)-\widehat{\gamma}_{n}\left(t_{i}-\widehat{u}_{n}\right) \mathbb{1}_{\left[t_{i},+\infty[ \right.}\left(\widehat{u}_{n}\right)\right| \\
\leqslant & \left|\gamma_{0}-\widehat{\gamma}_{n}\right| \cdot \sup _{i \in \mathbb{N}}\left|\left(t_{i}-u_{0}\right) \mathbb{1}_{\left[t_{i},+\infty[ \right.}\left(u_{0}\right)\right| \\
& +\left|\widehat{\gamma}_{n}\right| \cdot \sup _{i \in \mathbb{N}}\left|\left(t_{i}-u_{0}\right) \mathbb{1}_{\left[t_{i},+\infty[ \right.}\left(u_{0}\right)-\left(t_{i}-\widehat{u}_{n}\right) \mathbb{1}_{\left[t_{i},+\infty[ \right.}\left(\widehat{u}_{n}\right)\right| \\
= & \mathrm{O}\left(\gamma_{0}-\widehat{\gamma}_{n}\right)+\left|\widehat{\gamma}_{n}\right| \mathrm{O}\left(u_{0}-\widehat{u}_{n}\right), \tag{3.25}
\end{align*}
$$

using straightforward dominations and Lemma 5.2, so that in the end, thanks to the previous results we have a.s.

$$
\begin{equation*}
\sup _{i \in \mathbb{N}}\left|\nu_{i}\left(\widehat{\eta}_{n}\right)\right|=\mathrm{O}\left(n^{-\frac{1}{2}} \log n\right) \tag{3.26}
\end{equation*}
$$

It is thus easy to see that a.s.

$$
\begin{equation*}
\frac{1}{n} \sum_{i=1}^{n} \nu_{i}^{2}\left(\widehat{\eta}_{n}\right)=\mathrm{O}\left(n^{-1} \log ^{2} n\right)=\mathrm{O}\left(n^{-\frac{1}{2}} \log n\right) \tag{3.27}
\end{equation*}
$$

and also that, via Corollary 5.7, a.s.

$$
\begin{equation*}
\frac{2}{n} \sum_{i=1}^{n} \nu_{i}\left(\widehat{\eta}_{n}\right) \xi_{i}=\frac{2}{n}\left(\sum_{i=1}^{n} \nu_{i}^{2}\left(\widehat{\eta}_{n}\right)\right)^{\frac{1}{2}} \cdot \mathrm{O}(\log n)=\mathrm{O}\left(n^{-\frac{1}{2}} \log n\right) \tag{3.28}
\end{equation*}
$$

From the Law of the Iterated Logarithm (see Breiman, 1992, Chapter 13, page 291) we have a.s.

$$
\begin{equation*}
\frac{1}{n} \sum_{i=1}^{n}\left(\xi_{i}^{2}-\sigma_{0}^{2}\right)=\mathrm{O}\left(n^{-\frac{1}{2}}(\log \log n)^{\frac{1}{2}}\right)=\mathrm{O}\left(n^{-\frac{1}{2}} \log n\right) \tag{3.29}
\end{equation*}
$$

and the desired result follows from (3.27), (3.28) and (3.29) put together into (3.23).

## 4 Asymptotic distribution of the MLE

In this Section we derive the asymptotic distribution of the MLE for the pseudo-problem (see Proposition 4.1) and then show that the MLE of pseudo-problem and that of the problem share the same asymptotic distribution (see Theorem 4.2).

Proposition 4.1. Under Assumptions (A1)-(A4) and conditions (2.13), as $n \rightarrow+\infty$

$$
n^{\frac{1}{2}}\left(\widehat{\theta}_{n}^{*}-\theta_{0}\right) \xrightarrow{d} \mathcal{N}\left(0, I\left(\theta_{0}\right)^{-1}\right),
$$

where the asymptotic Fisher Information Matrix $I(\cdot)$ is defined in (2.10).
Proof of Theorem 4.1. The proof we present here is divided into two steps : the first step consists in showing that the likelihood of the pseudo-problem is a.s. differentiable in a neighbourhood of the associated MLE for $N$ large enough, while the second step makes use of a Taylor expansion of the likelihood of the pseudo-problem around the true parameter.

Step 1. We first prove that a.s.

$$
\exists N \in \mathbb{N}, \forall n>N, \widehat{u}_{n}^{*} \in D_{n}
$$

Let us notice that anything proven for the problem remains valid for the pseudo-problem. Because $n^{*} \sim n$, we have a.s., thanks to Theorem 3.4 and conditions (2.13), as $n \rightarrow+\infty$

$$
\begin{aligned}
n^{\frac{1}{2}}\left(\log ^{-1} n\right) \cdot\left(\widehat{u}_{n}^{*}-u_{0}\right) & =\mathrm{O}(1) \\
n^{\frac{1}{2}}\left(\log ^{-1} n\right) \cdot d_{n} & \rightarrow+\infty
\end{aligned}
$$

and thus deduce from the ratio of these two quantities that

$$
\frac{\widehat{u}_{n}^{*}-u_{0}}{d_{n}} \xrightarrow{\text { a.s. }} 0,
$$

and this directly implies the desired result.
Step 2. Let $A_{1: n}^{*}(\cdot)$ be the column vector defined for $u \in D_{n}$ by

$$
\begin{equation*}
A_{1: n}^{*}(\theta)=\left(\left.\frac{\partial l_{1: n}^{*}\left(X_{1: n} \mid \theta\right)}{\partial \gamma}\right|_{\theta},\left.\frac{\partial l_{1: n}^{*}\left(X_{1: n} \mid \theta\right)}{\partial u}\right|_{\theta},\left.\frac{\partial l_{1: n}^{*}\left(X_{1: n} \mid \theta\right)}{\partial \sigma^{2}}\right|_{\theta}\right) \tag{4.1}
\end{equation*}
$$

Step 1 allows us to expand a.s. $A_{1: n}^{*}\left(\widehat{\theta}_{n}^{*}\right)$ around $\theta_{0}$ using a Taylor-Lagrange approximation

$$
0=A_{1: n}^{*}\left(\widehat{\theta}_{n}^{*}\right)=A_{1: n}^{*}\left(\theta_{0}\right)-B_{1: n}^{*}\left(\widetilde{\theta}_{n}\right)\left(\widehat{\theta}_{n}^{*}-\theta_{0}\right)
$$

where $\widetilde{\theta}_{n}$ is a point between $\widehat{\theta}_{n}^{*}$ and $\theta_{0}$ (see (2.23) for the definitions of $B_{1: n}^{*}$ ), and rewrite it as a.s.

$$
\frac{1}{n^{*}} B_{1: n}^{*}\left(\widetilde{\theta}_{n}\right) \cdot n^{* \frac{1}{2}}\left(\widehat{\theta}_{n}^{*}-\theta_{0}\right)=n^{*-\frac{1}{2}} A_{1: n}^{*}\left(\theta_{0}\right)
$$

Since $\widehat{\theta}_{n}^{*} \rightarrow \theta_{0}$, we also have $\widetilde{\theta}_{n} \rightarrow \theta_{0}$ and using both Lemmas 5.9 and 5.10 we immediately find that as $n \rightarrow+\infty$

$$
I\left(\theta_{0}\right) \cdot n^{* \frac{1}{2}}\left(\widehat{\theta}_{n}^{*}-\theta_{0}\right) \xrightarrow{d} \mathcal{N}\left(0, I\left(\theta_{0}\right)\right)
$$

which means, remembering both that $n^{*} \sim n$ and that $I\left(\theta_{0}\right)$ is positive definite and thus invertible that as $n \rightarrow+\infty$

$$
n^{\frac{1}{2}}\left(\widehat{\theta}_{n}^{*}-\theta_{0}\right) \xrightarrow{d} \mathcal{N}\left(0, I\left(\theta_{0}\right)^{-1}\right) .
$$

Theorem 4.2. Under Assumptions (A1)-(A4) and conditions (2.13), as $n \rightarrow+\infty$,

$$
n^{\frac{1}{2}}\left(\widehat{\theta}_{n}-\theta_{0}\right) \xrightarrow{d} \mathcal{N}\left(0, I\left(\theta_{0}\right)^{-1}\right),
$$

where the asymptotic Fisher Information Matrix $I(\cdot)$ is defined in (2.10).
Proof of Theorem 4.2. It is a direct consequence of Proposition 4.1 if we manage to show that as $n \rightarrow+\infty$

$$
\begin{equation*}
\widehat{\theta}_{n}-\widehat{\theta}_{n}^{*}=\mathrm{o}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right) \tag{4.2}
\end{equation*}
$$

To show (4.2), we apply Lemmas 4.12 and 4.16 from Feder (1975). Note that Feder's Lemma's 4.12's results still holds true even though the rate of convergence $d_{n}$ he uses may differ from ours : it suffices to formally replace $(\log \log n)^{\frac{1}{2}}$ by $(\log n)$ all throughout his paper and the proofs he provides go through without any other change. We thus get

\begin{aligned}
& \widehat{\gamma}_{n}-\widehat{\gamma}_{n}^{*}=\mathrm{o}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right), \\
& \widehat{u}_{n}-\widehat{u}_{n}^{*}=\mathrm{o}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right) .
\end{aligned}
$$

It now remains to prove that

$$
\widehat{\sigma}_{n}^{2}-\widehat{\sigma}_{n}^{2 *}=\mathrm{o}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right)
$$

which will be done by capturing $\widehat{\sigma}_{n}^{2}$ and $\widehat{\sigma}_{n}^{2 *}$ asymptotic behaviours.
Since we already proved in Proposition 4.1 that

$$
\begin{aligned}
& \widehat{\gamma}_{n}^{*}-\gamma_{0}=\mathrm{O}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right), \\
& \widehat{u}_{n}^{*}-u_{0}=\mathrm{O}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right),
\end{aligned}
$$

we can easily deduce, adding up the previous pairs of relationships, that

\begin{align*}
& \widehat{\gamma}_{n}-\gamma_{0}=\mathrm{O}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right)  \tag{4.3}\\
& \widehat{u}_{n}-u_{0}=\mathrm{O}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right) \tag{4.4}
\end{align*}
$$

Recall now the decomposition (3.23), namely

\widehat{\sigma}_{n}^{2}=\frac{1}{n} \sum_{i=1}^{n} \nu_{i}^{2}\left(\widehat{\eta}_{n}\right)+\frac{2}{n} \sum_{i=1}^{n} \nu_{i}\left(\widehat{\eta}_{n}\right) \xi_{i}+\frac{1}{n} \sum_{i=1}^{n} \xi_{i}^{2}
$$

where the coefficients $\nu_{i}(\eta)$ are defined in (3.24). Using (3.25) again together with (4.3) and (4.4) we are able to write

\begin{equation*}
\sup _{i \in \mathbb{N}}\left|\nu_{i}\left(\widehat{\eta}_{n}\right)\right|=\mathrm{O}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right) \tag{4.5}
\end{equation*}
$$

It is hence easy to see that

\frac{1}{n} \sum_{i=1}^{n} \nu_{i}^{2}\left(\widehat{\eta}_{n}\right)=\mathrm{O}_{\mathbb{P}}\left(n^{-1}\right)=\mathrm{o}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right)
$$

and also that

$$
\frac{2}{n} \sum_{i=1}^{n} \nu_{i}\left(\widehat{\eta}_{n}\right) \xi_{i}=\frac{2}{n}\left(\sum_{i=1}^{n} \nu_{i}^{2}\left(\widehat{\eta}_{n}\right)\right)^{\frac{1}{2}} \cdot \mathrm{O}_{\mathbb{P}}(1)=\mathrm{o}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right)
$$

which once both substituted into (3.23) yield

$$
\widehat{\sigma}_{n}^{2}=\frac{1}{n} \sum_{i=1}^{n} \xi_{i}^{2}+\mathrm{oP}\left(n^{-\frac{1}{2}}\right)
$$

What was done above with the problem and $\widehat{\sigma}_{n}^{2}$ can be done with the pseudo-problem and $\widehat{\sigma}_{n}^{2 *}$ without any kind of modification so that

$$
\widehat{\sigma}_{n}^{2 *}=\frac{1}{n^{*}} \sum_{i=1}^{n^{*}} \xi_{i}^{2}+\mathrm{o}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right)
$$

We observe that

$$
\begin{aligned}
\widehat{\sigma}_{n}^{2}-\widehat{\sigma}_{n}^{2 *} & =\frac{1}{n} \sum_{i=1}^{n} \xi_{i}^{2}-\frac{1}{n^{*}} \sum_{i=1}^{n^{*}} \xi_{i}^{2}+\mathrm{o} \mathbb{P}\left(n^{-\frac{1}{2}}\right) \\
& =\left[\frac{1}{n}-\frac{1}{n^{*}}\right] \cdot \sum_{i=1}^{n^{*}} \xi_{i}^{2}+\frac{1}{n} \cdot \sum_{i=n^{*}+1}^{n} \xi_{i}^{2}+\mathrm{o}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right) \\
& =\frac{n^{*}-n}{n} \cdot\left(\frac{1}{n^{*}} \sum_{i=1}^{n^{*}} \xi_{i}^{2}\right)+\frac{n-n^{*}}{n} \cdot\left(\frac{1}{n-n^{*}} \sum_{i=n^{*}+1}^{n} \xi_{i}^{2}\right)+\mathrm{o}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right) \\
& =\frac{n^{*}-n}{n} \cdot\left(\sigma_{0}^{2}+\mathrm{O}_{\mathbb{P}}\left(n^{*-\frac{1}{2}}\right)\right)+\frac{n-n^{*}}{n} \cdot\left(\sigma_{0}^{2}+\mathrm{O}_{\mathbb{P}}\left(\left(n-n^{*}\right)^{-\frac{1}{2}}\right)\right)+\mathrm{o}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right)
\end{aligned}
$$

using the Central Limit Theorem, and in the end we get

$$
\begin{aligned}
\widehat{\sigma}_{n}^{2}-\widehat{\sigma}_{n}^{2 *} & =\frac{n^{*}-n}{n} \cdot \mathrm{O}_{\mathbb{P}}\left(n^{*-\frac{1}{2}}\right)+\frac{n-n^{*}}{n} \cdot \mathrm{O}_{\mathbb{P}}\left(\left(n-n^{*}\right)^{-\frac{1}{2}}\right)+\mathrm{o}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right) \\
& =\mathrm{o}(1) \cdot \mathrm{O}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right)+n^{-\frac{1}{2}} \cdot \mathrm{O}_{\mathbb{P}}\left(\left(\frac{n-n^{*}}{n}\right)^{\frac{1}{2}}\right)+\mathrm{o}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right) \\
& =\mathrm{o}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right)+n^{-\frac{1}{2}} \cdot \mathrm{O}_{\mathbb{P}}(\mathrm{o}(1))+\mathrm{o}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right)=\mathrm{o}_{\mathbb{P}}\left(n^{-\frac{1}{2}}\right) .
\end{aligned}
$$

## 5 Appendix

Theorem 5.1 (Polya's Theorem). Let $\left(g_{n}\right)_{n \in \mathbb{N}}$ be a sequence of non-decreasing (or non-increasing) functions defined over $I=[a, b] \subset \mathbb{R}$. If $g_{n}$ converges to $g$ simply and $g$ is continuous then

\sup _{x \in I}\left|g_{n}(x)-g(x)\right| \xrightarrow[n \rightarrow+\infty]{ } 0
$$

Proof of Lemma 5.1. Assume the functions $g_{n}$ are non-decreasing over $I$ (if not, consider their opposites $\left.-g_{n}\right) . \quad g$ is continuous over $I$ and thus bounded since $I$ is compact. $g$ is also nondecreasing over $I$ as the limit of a sequence of non-decreasing functions. Let $\epsilon>0$ and $k>\frac{g(b)-g(a)}{\epsilon}$ such that

\exists a=a_{0}<\ldots<a_{k}=b \in I^{k+1}, \forall i=0, \ldots, k-1, g\left(a_{i+1}\right)-g\left(a_{i}\right)<\epsilon
$$

Now let $x \in I$ and let $i \in \mathbb{N}$ such that $a_{i} \leqslant x \leqslant a_{i+1}$. Since $g_{n}$ and $g$ are non-decreasing, we find that

& g_{n}(x)-g(x) \leqslant g_{n}\left(a_{i+1}\right)-g\left(a_{i}\right) \leqslant g_{n}\left(a_{i+1}\right)-g\left(a_{i+1}\right)+\epsilon, \\
& g_{n}(x)-g(x) \geqslant g_{n}\left(a_{i}\right)-g\left(a_{i+1}\right) \geqslant g_{n}\left(a_{i}\right)-g\left(a_{i}\right)-\epsilon
\end{aligned}
$$

The pointwise convergence of $g_{n}$ to $g$ and the finiteness of $k$ together ensure that

$$
\exists N_{0} \in \mathbb{N}, \forall n \geqslant N_{0}, \forall i=0, \ldots, k,\left|g_{n}\left(a_{i}\right)-g\left(a_{i}\right)\right|<\epsilon,
$$

which implies with both of the inequations mentionned above that

\exists N_{0} \in \mathbb{N}, \forall n \geqslant N_{0}, \forall x \in I,\left|g_{n}(x)-g(x)\right|<\epsilon
$$

Lemma 5.2. Let $k \in \mathbb{N}^{*}$, there exists a constant $C \in \mathbb{R}_{+}^{*}$ such that for any $\left(u, u^{\prime}\right) \in[\underline{u}, \bar{u}]^{2}$

$$
\begin{equation*}
\sup _{t \in[\underline{u}, \bar{u}]}\left|\left(t-u^{\prime}\right)^{k} \mathbb{1}_{[t,+\infty[ }\left(u^{\prime}\right)-(t-u)^{k} \mathbb{1}_{[t,+\infty[ }(u)\right|=C\left|u-u^{\prime}\right| \tag{5.1}
\end{equation*}
$$

Proof of Lemma 5.2. For any $\left(u, u^{\prime}\right) \in[\underline{u}, \bar{u}]^{2}$ we have

$$
\begin{align*}
\sup _{t \in[\underline{u}, \bar{u}]} \mid\left(t-u^{\prime}\right)^{k} \mathbb{1}_{[t,+\infty}\left[\left(u^{\prime}\right)-(t-u)^{k} \mathbb{1}_{[t,+\infty[ }(u) \mid \leqslant\right. & \sup _{t \in[\underline{u}, \bar{u}]}\left\{\left|\left(t-u^{\prime}\right)^{k}-(t-u)^{k}\right| \mathbb{1}_{[t,+\infty[ }\left(u^{\prime}\right)\right\} \\
& +\sup _{t \in[\underline{u}, \bar{u}]}\left\{|t-u|^{k}\left|\mathbb{1}_{[t,+\infty[ }\left(u^{\prime}\right)-\mathbb{1}_{[t,+\infty[ }(u)\right|\right\} . \tag{5.2}
\end{align*}
$$

The mean value theorem guarantees that there exists $v$ between $u$ and $u^{\prime}$ such that

\left(t-u^{\prime}\right)^{k}-(t-u)^{k}=-k(t-v)^{k-1}\left(u^{\prime}-u\right)
$$

We thus have

\begin{align*}
\sup _{t \in[\underline{u}, \bar{u}]}\left\{\left|\left(t-u^{\prime}\right)^{k}-(t-u)^{k}\right| \mathbb{1}_{[t,+\infty[ }\left(u^{\prime}\right)\right\} & \leqslant \sup _{t \in[\underline{u}, \bar{u}]}\left|\left(t-u^{\prime}\right)^{k}-(t-u)^{k}\right| \\
& \leqslant k|\bar{u}-\underline{u}|^{k-1}\left|u-u^{\prime}\right| \tag{5.3}
\end{align*}
$$

Because $|t-u| \leqslant\left|u^{\prime}-u\right|$ whenever $\left|\mathbb{1}_{[t,+\infty[ }\left(u^{\prime}\right)-\mathbb{1}_{[t,+\infty[ }(u)\right| \neq 0$, we also find that

\sup _{t \in[\underline{u}, \bar{u}]}\left\{|t-u|^{k}\left|\mathbb{1}_{[t,+\infty}\left[u^{\prime}\right)-\mathbb{1}_{[t,+\infty[ }(u)\right|\right\} \leqslant\left|u-u^{\prime}\right|^{k} \leqslant\left|u-u^{\prime}\right||\bar{u}-\underline{u}|^{k-1} . \tag{5.4}
\end{equation*}
$$

And now (5.1) is a simple consequence of (5.2), (5.3) and (5.4).
Lemma 5.3. For any $\eta^{\prime} \in \mathbb{R} \times[\underline{u}, \bar{u}]$, there exists $C \in \mathbb{R}_{+}^{*}$ such that for any $\eta \in \mathbb{R} \times[\underline{u}, \bar{u}]$

\sup _{t \in[\underline{u}, \bar{u}]}\left|\mu(\eta, t)-\mu\left(\eta^{\prime}, t\right)\right| \leqslant C\left\|\eta-\eta^{\prime}\right\| . \tag{5.5}

Proof of Lemma 5.3. We have indeed

\sup _{t \in[\underline{u}, \bar{u}]}\left|\mu(\eta, t)-\mu\left(\eta^{\prime}, t\right)\right|= & \sup _{t \in[\underline{u}, \bar{u}]}\left|\gamma(t-u) \mathbb{1}_{[t,+\infty[ }(u)-\gamma^{\prime}\left(t-u^{\prime}\right) \mathbb{1}_{[t,+\infty[ }\left(u^{\prime}\right)\right| \\
\leqslant \leqslant & \sup _{t \in[\underline{u}, \bar{u}]}\left|\left[\gamma-\gamma^{\prime}\right](t-u) \mathbb{1}_{[t,+\infty[ }(u)\right| \\
& +\sup _{t \in[\underline{u}, \bar{u}]}\left|\gamma^{\prime}\left[(t-u) \mathbb{1}_{[t,+\infty[ }(u)-\left(t-u^{\prime}\right) \mathbb{1}_{[t,+\infty[ }\left(u^{\prime}\right)\right]\right| \\
\leqslant & \left|\gamma-\gamma^{\prime}\right| \cdot \sup _{t \in[\underline{u}, \bar{u}]}|t-u| \\
& +\left|\gamma^{\prime}\right| \cdot \sup _{t \in[\underline{u}, \bar{u}]}\left|(t-u) \mathbb{1}_{[t,+\infty[ }(u)-\left(t-u^{\prime}\right) \mathbb{1}_{[t,+\infty[ }\left(u^{\prime}\right)\right| \\
\leqslant & \left|\gamma-\gamma^{\prime}\right| \cdot|\bar{u}-\underline{u}|+\left|\gamma^{\prime}\right| \cdot \sup _{t \in[\underline{u}, \bar{u}]}\left|(t-u) \mathbb{1}_{[t,+\infty[ }(u)-\left(t-u^{\prime}\right) \mathbb{1}_{[t,+\infty[ }\left(u^{\prime}\right)\right| .
\end{aligned}
$$

And now (5.5) is a simple consequence of Lemma 5.2.

\end{aligned}

Proof of Lemma 5.4. It suffices to prove the following claim

and then use the triangle inequality. To see that the claim holds, it suffices, thanks to Lemma 5.3, to exhibit a finite and tight enough grid of $A$ such that any point in $A$ lies close enough to a point of the grid. The existence of such a grid is obviously guaranteed since $A \subset \mathbb{R}^{2}$ is bounded.
Lemma 5.5. Recall the definition of $b_{n}$ given in (2.4). Let

& b_{n}(\theta) \rightarrow b(\theta), \text { as } n \rightarrow+\infty \tag{5.10}

Proof of Lemma 5.5. We will prove each claim separately.
Proof of (5.7). That $b_{n}(\theta) \geqslant 0$ is trivial since the first term in (2.4) is non-negative (having $x-1-\log x \geqslant 0$ with equality only if $x=1$ ), and the second term in (2.4) is obviously non-negative too.

Proof of (5.8). That $b(\theta) \geqslant 0$ is again easy enough to prove, both terms in (5.6) being trivially non-negative. If $\theta \neq \theta_{0}$ then either $\sigma^{2} \neq \sigma_{0}^{2}$ which implies the first term is positive, or $\mu\left(\eta_{0}, \cdot\right) \neq$ $\mu(\eta, \cdot)$ which implies the second term is positive (since $f$ is assumed positive on $[\underline{u}, \bar{u}]$ ). Hence if $\theta \neq \theta_{0}$ then $b(\theta)>0$. That $\theta=\theta_{0}$ implies $b(\theta)=0$ is of course straightforward.

Proof of (5.9). We first observe that

& \leqslant \frac{1}{n} \sum_{i=1}^{n}\left|2 \mu\left(\eta_{0}, t_{i}\right)-\mu\left(\eta^{\prime}, t_{i}\right)-\mu\left(\eta, t_{i}\right)\right| \cdot\left|\mu\left(\eta, t_{i}\right)-\mu\left(\eta^{\prime}, t_{i}\right)\right| \\
& \leqslant\left(\sup _{t \in[\underline{u}, \bar{u}]}\left|\mu\left(\eta_{0}, t\right)-\mu(\eta, t)\right|+\sup _{t \in[\underline{u}, \bar{u}]}\left|\mu\left(\eta^{\prime}, t\right)-\mu(\eta, t)\right|\right) \cdot \sup _{t \in[\underline{u}, \bar{u}]}\left|\mu\left(\eta^{\prime}, t\right)-\mu(\eta, t)\right| \tag{5.11}

As $\theta^{\prime} \rightarrow \theta$, the convergence of the first term of $b_{n}$ to the first term of $b$ is obviously uniform in $n$ since this part of $b_{n}$ does not involve $n$ at all. As $\theta^{\prime} \rightarrow \theta$, via Lemma 5.3, we also obtain

\end{aligned}
$$

Lemma 5.6. Let $A \subset \mathbb{R} \times[\underline{u}, \bar{u}]$ be a bounded set, and let $\eta_{0} \in A$, then under Assumptions (A1)-(A4),

Proof of Lemma 5.6. Let $\epsilon>0, \eta \in A$, and apply Lemma 5.4 to get the corresponding $m(\epsilon) \in \mathbb{N}$, $\left\{\eta_{1}, \ldots, \eta_{m(\epsilon)}\right\} \subset A, j, j^{\prime} \in\{1, \ldots, m(\epsilon)\}$. We can write with the triangle inequality

\leqslant & \sup _{\left(j, j^{\prime}\right) \in\{1, \ldots, m(\epsilon)\}}\left\{\frac{1}{n} \sum_{i=1}^{n}\left[\mu\left(\eta_{j}, t_{i}\right)-\mu\left(\eta_{j^{\prime}}, t_{i}\right)\right] \xi_{i}\right\}+\epsilon \cdot \frac{1}{n} \sum_{i=1}^{n}\left|\xi_{i}\right| .
\end{aligned}
$$

Hence

& \sup _{\eta \in A}\left\{\frac{1}{n} \sum_{i=1}^{n}\left[\mu\left(\eta_{0}, t_{i}\right)-\mu\left(\eta, t_{i}\right)\right] \xi_{i}\right\} \leqslant \sup _{\left(j, j^{\prime}\right) \in\{1, \ldots, m(\epsilon)\}}\left\{\frac{1}{n} \sum_{i=1}^{n}\left[\mu\left(\eta_{j}, t_{i}\right)-\mu\left(\eta_{j^{\prime}}, t_{i}\right)\right] \xi_{i}\right\} \\
& +\epsilon \cdot \frac{1}{n} \sum_{i=1}^{n}\left|\xi_{i}\right| \tag{5.12}
\end{align*}
$$

Let us now recall Kolmogorov's criterion, a proof of which is available in Section 17 of Loève (1991) on pages $250-251$. This criterion guarantees that for any sequence $\left(Y_{i}\right)_{i \in \mathbb{N}}$ of independent random variables and any numerical sequence $\left(b_{i}\right)_{i \in \mathbb{N}}$ such that

for the coefficients $\left[\mu\left(\eta_{j}, t_{i}\right)-\mu\left(\eta_{j^{\prime}}, t_{i}\right)\right]$ are obviously bounded, and it suffices to pick $Y_{i}=$ $\left[\mu\left(\eta_{j}, t_{i}\right)-\mu\left(\eta_{j^{\prime}}, t_{i}\right)\right] \xi_{i}$ and $b_{i}=i$. Having only a finite number of couples $\left(j, j^{\prime}\right) \in\{1, \ldots, m(\epsilon)\}^{2}$ to consider allows us to write

By (5.13), the first term on the right hand side of (5.12) converges almost surely to zero. The Strong Law of Large Numbers ensures that the second term on the right hand side of (5.12) converges almost surely to $\epsilon \cdot\left(2 \pi^{-1} \sigma^{2}\right)^{\frac{1}{2}}$, and the result follows, since all the work done above for $\left(\xi_{n}\right)_{n \in \mathbb{N}}$ can be done again for $\left(-\xi_{n}\right)_{n \in \mathbb{N}}$.

Lemma 5.7. Let $\left(Z_{i}\right)_{i \in \mathbb{N}}$ be a sequence of independent identically distributed random variables such that for all $i \in \mathbb{N}$, either $Z_{i} \sim \mathcal{N}\left(0, \sigma^{2}\right)$ with $\sigma^{2}>0$, or $Z_{i} \sim \chi^{2}(k)$ with $k>0$. Then a.s., as $n \rightarrow+\infty$

Proof of Lemma 5.7. Denote $Y_{n}=Z_{n}$ when the random variables are Gaussian, and $Y_{n}=Z_{n} / 5$ when the random variables considered are chi-squared (so that $\mathbb{E} e^{2 Y_{1}}$ and $\mathbb{E} e^{-2 Y_{1}}$ are both finite). We will show that a.s. $Y_{n}=\mathrm{O}(\log n)$.

For any $\epsilon>0$, from Markov's inequality we get :

Let $V_{1}$ and $V_{2}$ two non-empty open intervals of $] \underline{u}, u_{0}\left[\right.$ such that their closures $\overline{V_{1}}$ and $\overline{V_{2}}$ are do not overlap. We have

&\left.\sum_{i=1}^{n}\left[\mu\left(\eta_{0}, t_{i}\right)-\mu\left(\eta, t_{i}\right)\right]^{2} \mathbb{1}_{V_{2}}\left(t_{i}\right)\right) .
\end{aligned}
$$

Using the same arguments we used to prove (3.21), we find that there exists $C \in \mathbb{R}_{+}^{*}$ such that (remembering the definition of the intercept $\beta$ of the model)

& n^{-1} \sum_{i=1}^{n}\left[\mu\left(\eta_{0}, t_{i}\right)-\mu\left(\eta, t_{i}\right)\right]^{2} \geqslant \min \left(n^{-1} \sum_{i=1}^{n} \mathbb{1}_{V_{1}}\left(t_{i}\right), n^{-1} \sum_{i=1}^{n} \mathbb{1}_{V_{2}}\left(t_{i}\right)\right) \cdot C\left|\beta-\beta_{0}\right|^{2},
\end{aligned}
$$

and since for $j=1,2$ we have

& \leqslant\left|\gamma_{0}^{-1}\right|\left\{\left|\beta_{0}-\beta\right|+\left|\gamma^{-1} \beta\right|\left|\gamma-\gamma_{0}\right|\right\} \\
& \leqslant\left|\gamma_{0}^{-1}\right|\left(\left|\beta_{0}-\beta\right|+|u|\left|\gamma-\gamma_{0}\right|\right) \\
& \leqslant\left|\gamma_{0}^{-1}\right|(1+\max (|\underline{u}|,|\bar{u}|)) \cdot \max \left(\left|\beta_{0}-\beta\right|,\left|\gamma-\gamma_{0}\right|\right)
\end{aligned}
$$

From here, since $u \in[\underline{u}, \bar{u}]$ is bounded, it is straightforward that there exists $C \in \mathbb{R}_{+}^{*}$ such that for any $n$ large enough

Lemma 5.9. Recall the definition of $A_{1: n}^{*}$ given in (4.1). Under Assumptions (A1)-(A4) and conditions (2.13), as $n \rightarrow+\infty$

= & \alpha_{1} \cdot \frac{1}{\sigma_{0}^{2}} \sum_{i=1}^{n^{*}}\left[\left(t_{i}-u_{0}\right) \mathbb{1}_{\left[t_{i},+\infty[ \right.}\left(u_{0}\right) \cdot \xi_{i}\right]-\alpha_{2} \cdot \frac{\gamma_{0}}{\sigma_{0}^{2}} \sum_{i=1}^{n^{*}}\left[\mathbb{1}_{\left[t_{i},+\infty[ \right.}\left(u_{0}\right) \cdot \xi_{i}\right] \\
& +\alpha_{3} \cdot \frac{1}{2 \sigma_{0}^{2}} \sum_{i=1}^{n^{*}}\left[\frac{1}{\sigma_{0}^{2}} \cdot \xi_{i}^{2}-1\right] \\
= & \sigma_{0}^{-2} \sum_{i=1}^{n^{*}} Z_{i}
\end{aligned}
$$

where we denote, for $i=1, \ldots, n^{*}$

\end{equation*}

Since for $i=1, \ldots, n^{*} \mathbb{E}\left[\xi_{i}\right]=0$ and $\mathbb{E}\left[\xi_{i}^{2}\right]=\sigma^{2}$, we deduce that $\mathbb{E}\left[Z_{i}\right]=0$, and hence that $\mathbb{E}\left[\left\langle\alpha, A_{1: n}^{*}\left(\theta_{0}\right)\right\rangle\right]=0$.

i_{n}\left(\theta_{n}\right) \leqslant \frac{1}{\sigma_{n}^{2}} \frac{\left\|\theta_{n}-\theta_{0}\right\|}{\rho_{n}}\left(\frac{R_{n}}{\rho_{n}}-c \frac{\left\|\theta_{n}-\theta_{0}\right\|}{\rho_{n}}\right) \rho_{n}^{2}
$$

Recalling that

$$
\begin{aligned}
\left\|\theta_{n}-\theta_{0}\right\| & \geqslant \delta \rho_{n} \\
R_{n} & =\mathrm{o}\left(\rho_{n}\right), \\
\sigma_{n}^{2} & \rightarrow \sigma_{\infty}^{2}>0
\end{aligned}
$$

we obtain for any $n$ large enough,

i_{n}\left(\theta_{n}\right) \leqslant \frac{1}{\sigma_{n}^{2}} \frac{\left\|\theta_{n}-\theta_{0}\right\|}{\rho_{n}}\left(-c \frac{\delta}{2}\right) \rho_{n}^{2} \leqslant-\frac{c \delta^{2}}{2 \sigma_{n}^{2}} \rho_{n}^{2} \leqslant-\frac{c \delta^{2}}{3 \sigma_{\infty}^{2}} \rho_{n}^{2}
$$

Hence (5.33) holds in this situation too : it suffices to take $\epsilon=\frac{c \delta^{2}}{3 \sigma_{\infty}^{2}}$.
We just proved that (5.33) holds in both cases considered.
Step 6. (5.23) is a consequence of (5.28) and (5.33).

Lemma 5.12. Let $0<\delta<1$ then under Assumptions (A1)-(A4) and conditions (2.13), a.s. there exists a constant $C \in R_{+}^{*}$ such that for any $n$ large enough and for any $1 \leqslant i_{1}, i_{2}, i_{3} \leqslant 3$

Proof of Lemma 5.12. Let $0<\delta<1$. We will prove (5.34) stands true for any $1 \leqslant i_{1}, i_{2}, i_{3} \leqslant 3$. First notice that for $n$ large enough, $\theta \mapsto l_{1: n}^{*}\left(X_{1: n} \mid \theta\right)$ is indeed infinitely continuously differentiable over $B\left(\theta_{0}, \delta d_{n}\right)$ by definition of the pseudo-problem. Any $\theta$ subsequently considered within this proof is assumed to belong to $B\left(\theta_{0}, \delta d_{n}\right)$. Any convergence subsequently mentionned within this proof is uniform in $\theta$ for $\theta \in B\left(\theta_{0}, \delta d_{n}\right)$ for any $n$ large enough thanks to Theorem 5.1 and Lemma 5.6.

And this limit is bounded by $\frac{1}{\sigma^{8}}\left[3 \sigma_{0}^{2}+\sigma^{2}+\left(|\gamma|+\left|\gamma_{0}\right|\right)^{2}(\bar{u}-\underline{u})^{2}\right]$.
(5.34) is thus a direct consequence of both the uniform convergences mentionned above and the trivial majoration of all the limits involved by a fixed constant $C$ for any $n$ large enough.
