# Analyses of Heated Concrete Spalling due to Restrained Thermal Dilation: Application to the "Chunnel" Fire

**Abstract:** Two spalling mechanisms are generally quoted in the literature. The first one is due to pore pressure buildup. The second one, which is analyzed in this paper, is generated by restrained thermal dilation. We seek to model the channel tunnel fire by a thermochemoplastic constitutive model. A simplified analytical approach allows us to express mechanical variables as stresses and strains near the heated surface (the concrete wall). This study leads to introducing a "plastification" temperature and to deduce a plastification depth that can be useful for determining the spalling localization. A comparison between different cases (with and without chemical softening or decohesion) shows that thermal spalling is due to chemical decohesion (strength degradation) and not to chemical softening (rigidity reduction)

#### Introduction

The material and structural behavior of concrete at high temperature is well described in the literature (Anderberg 1997; Bazant 1997). The channel tunnel fire revealed, however, the lack of understanding of the mechanisms that lead to concrete member spalling, which beside logistic questions concerning safety, generates economic losses at the reparation moment.

This study seeks to evaluate the effects of thermal softening E and thermal decohesion  $f_c$  (due to dehydration) upon the compressive stresses generated by the restrained thermal dilation. In a first step, the principle of the dehydration effects on the concrete mechanical properties is presented. Next, equations for the thermoelastoplastic model (Ulm et al. 1999b) are given. Then, a model application for the "Chunnel" fire is present, based on an analytical approach using some simplifications that are justified and validated later on by the numerical complete model (without approximations). The simplified mechanical model obtained is very advantageous since its properties are related to a purely thermal problem. Finally, the ability of the simplified model to forecast the spalling formation is discussed while examining the combination of the two main phenomena: thermal softening and thermal decohesion.

#### Chemoplastic Model

In this model, two chemical dehydration effects are considered.

### Chemical Softening

Young's modulus of degradation is due to the decomposition of the cement connections. It can be supposed that rigidity is proportional to the remaining mass of hydrates. The proportionality has been found to constitute an intrinsic material property of concrete. Thus, the dehydration degree  $\xi = m_h/m_{h0}$ =relative ratio of rigidity after heating

$$E = \xi E_0 \tag{1}$$

This dehydration degree describes a chemical reaction that has a chemical kinetic with a characteristic time  $\tau_{\xi}$  and an asymptotic limit  $\xi_{eq}(T)$  (Fasseu 1997), leading to

$$\dot{\xi} = -\frac{1}{\tau_{\mathcal{E}}} \left[ \xi - \xi_{\text{eq}}(T) \right] \tag{2}$$

# Chemical Decohesion

The dehydration also has an influence on the elastic limit strength that is again supposed to be proportional to the dehydration degree. Thus, the isotropic elastic limit criterion of William—Warnke (William and Warnke 1975) takes into account this chemical decohesion as follows:

$$f(\sigma, \xi) = \tau + \delta(\Theta)(\sigma - \rho_0 \xi)$$
 (3)

where the three invariants are  $\tau = \sqrt{1/2s : s}$ ,  $\sigma = (1/3) \operatorname{tr}(\sigma)$ , and  $\cos(\Theta) = (2\sigma_1^{\operatorname{pr}} - \sigma_2^{\operatorname{pr}} - \sigma_3^{\operatorname{pr}})/\sqrt{12}\tau$ ; and where  $s = \operatorname{stress}$  deviator;  $\rho_0 = \operatorname{cohesion}$  pressure before dehydration; and  $\delta(\Theta) = \operatorname{friction}$  angle, which depends on Lode angle  $\Theta$ , defined above as follows:

$$\delta(\theta) = \frac{u+v}{w}$$

where

$$u = 2\delta_c(\delta_c^2 - \delta_t^2)\cos(\theta)$$

$$v = \delta_c(2\delta_t - \delta_c)\sqrt{4(\delta_c^2 - \delta_t^2)\cos^2(\theta) + 5\delta_t - 4\delta_c\delta_t}$$

$$w = 4(\delta_c^2 - \delta_t^2)\cos^2(\theta) + (\delta_c - 2\delta_t)^2$$

Finally, the friction coefficients  $\delta_c$  and  $\delta_t$  and the cohesion pressure  $\rho_0$  are related to the standard properties (ultimate compressive strength  $f_c$ , ultimate tensile strength  $f_t$ , and ultimate bicompressive strength  $f_{bc}$ ) by

$$f_c = \frac{3\delta_c}{\sqrt{3} - \delta_c} \rho_0; \quad f_t = \frac{3\delta_t}{\sqrt{3} + \delta_t} \rho_0; \quad f_{bc} = \frac{3\delta_t}{\sqrt{3} - 2\delta_t} \rho_0$$

# Comparison between Thermal and Chemical Characteristic Times

Neglecting both elastic deformation latent heat and energy dissipation, the heat balance equation reads (in an unidirectional case with Fourier's law)

$$C\dot{T} - \kappa \nabla_x^2 T = 0 \tag{4}$$

where C and  $\kappa=$ volumic heat capacity and conductivity of concrete. The characteristic time of heat conduction [described in Eq. (4)] is then related to the characteristic length L by  $\tau_T=(\kappa L^2)/C$ .

The characteristic time  $\tau_{\xi}$  of dehydration [described in Eq. (2)] can be roughly estimated by considering the microdiffusion between the micropores and the capillary pores, which occurs faster when temperature is higher [because of the activation Arrhenius term  $\exp(E_a/RT)$ ] and then  $\tau_{\xi}(T) \! \leq \! \tau_{\xi}(T_0) \! \approx \! 30$  s.

Neglecting  $\tau_{\xi}$  with respect to  $\tau_{T}$  is possible when  $L \gg \sqrt{\tau_{\xi}(T_{0})\kappa/C} \approx 5$  mm, which is always verified. Then, it can be supposed that  $\tau_{\xi} \ll \tau_{T}$ .

Thus, the denydration degree  $\xi$  given in Eq. (2) can be supposed equal to its asymptotic value [ $\xi = \xi_{\rm eq}(T)$  at each time]. Thus, and according to Eq. (1), Young's modulus  $E(\xi)$  reads E(T).

# Thermoelastoplastic Deformation

The total strain is the sum of elastic, plastic, and thermal strains

$$\varepsilon^{\text{tot}} = \varepsilon^{\text{th}} + \varepsilon^{\text{el}} + \varepsilon^{\text{pl}} \tag{5}$$

## Thermal Strain

The thermal dilation is characterized by a thermal strain tensor  $\alpha$ . It is assumed in the following that the medium is isotropic so that  $\alpha = \alpha 1$  and then

$$d\varepsilon^{\text{th}} = \alpha dT 1 \tag{6}$$

# Elastic Strain

The elastic strain tensor is related to the stress tensor via the four-order elastic stiffness tensor  $\hat{C}$  as follows:

$$d\sigma = \hat{C}d\varepsilon^{e}$$

where  $\hat{C} = \xi \hat{C}_0$  is assumed to depend on the dehydration degree. This assumption is a generalized form of the result in Eq. (1).

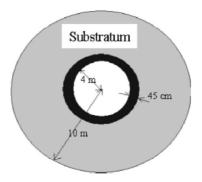


Fig. 1. Geometry of the channel tunnel

In the isotropic case, the elastic stiffness tensor of the last equation reads

$$\hat{C} = K(T)1 \otimes 1 + 2G(T)\left(\hat{I} - \frac{1}{3}1 \otimes 1\right)$$

and then

$$d\sigma = \left[ K(T) - \frac{2}{3}G(T) \right] \operatorname{tr}(d\varepsilon^{\text{el}}) + 2G(T)d\varepsilon^{\text{el}}$$
 (7)

where  $K(T) = [E(T)/3(1-2\nu)] = \text{bulk}$  modulus and  $G(T) = [E(T)/2(1+\nu)] = \text{shear}$  modulus, assuming that the Poisson's ratio is constant.

# Plastic Strain and Flow Rule

We suppose that the plasticity rule is associated. The plastic flow is, therefore, given by the relation

$$d\varepsilon^{\rm pl} = d\lambda \frac{df}{d\sigma} \tag{8}$$

where  $d\lambda$ =plastic multiplier, which is null only when the evolution is purely elastic  $(f<0 \text{ or } \dot{f}<0)$  and positive when there is a plastic flow  $(f=\dot{f}=0)$ .

# "Chunnel" Fire

In this section, the thermochemomechanical behavior of the cylindrical channel tunnel heated during a fire (Ulm et al. 1999a) will be studied.

# Geometry

Fig. 1 presents the geometry of the channel tunnel. Due to the axisymmetric geometry, the geometric problem variable reduces to the radius r from the tunnel center. The substratum external radius is large enough so that the boundary conditions on extrados do not influence the thermal and mechanical fields on intrados (concrete wall).

This axisymmetric geometry allows us to write the following helpful relations:

$$\varepsilon_{r\theta} = \varepsilon_{rz} = \varepsilon_{\theta z} = \varepsilon_{zz} = 0$$
 (9)

$$\varepsilon_{rr} = \frac{\partial u_r}{\partial r}, \quad \varepsilon_{\theta\theta} = \frac{u_r}{r}$$
 (10)

and then

$$\varepsilon_{rr} = r \frac{\partial \varepsilon_{\theta\theta}}{\partial r} + \varepsilon_{\theta\theta} \tag{11}$$

The balance equation  $div(\sigma)=0$  simply reads in this case

$$\sigma_{\theta\theta} = r \frac{\partial \sigma_{rr}}{\partial r} + \sigma_{rr} \tag{12}$$

The heat conduction equation reads

$$C\frac{\partial T}{\partial t} - \frac{1}{r}\kappa \frac{\partial}{\partial r} \left( r\frac{\partial T}{\partial r} \right) = 0$$
 (13)

#### Material Properties

The tunnel concrete wall is modeled in thermochemoplasticity and the chalk substratum is treated in thermoelasticity. The material properties of the different constituents are given in Table 1.

# Boundary Conditions

For this unidimensional model, two boundary conditions are needed to be fixed at  $r\!=\!r_{\rm int}$  and  $r\!=\!r_{\rm ext}$ .

- Convection at intrados:  $q = -\lambda(\partial T/\partial r) = h \left[T T_{\text{imp}}(t)\right]$  at  $r = r_{\text{int}}$ , where  $T_{\text{imp}}(t) = T_0 + 1,280 \left[1 0.325 \exp(-0.167t) 0.675 \exp(-2.5t)\right] = \text{temperature increase given by the } Highway Capacity Manual curve (typical for tunnels) and where <math>t = \text{time in minutes}$ ;
- Adiabatic exchange at extrados: q=0 at r=r<sub>ext</sub>;
- Intrados free of any radial stress:  $\sigma_{rr}$ =0 at r= $r_{int}$ ;
- Restrained radial displacement on extrados: u<sub>r</sub>=0 at r=r<sub>ext</sub> [ε<sub>θθ</sub>=0 according to Eq. (10)].

# Thermoelastic Phase

This phase is characterized by  $d \varepsilon^{\rm pl} = 0$ , so that Eq. (7) reads, using Eq. (5)

$$d\sigma = \hat{C}d\varepsilon^{el} = \hat{C}(d\varepsilon - d\varepsilon^{th})$$

In our cylindrical case, it reads according to Eqs. (6) and (9)

$$d\sigma_{rr} = \left(\frac{4G}{3} + K\right)d\varepsilon_{rr} + \left(K - \frac{2G}{3}\right)d\varepsilon_{\theta\theta} - 3K\alpha dT$$

$$d\sigma_{\theta\theta} = \left(\frac{4G}{3} + K\right)d\varepsilon_{\theta\theta} + \left(K - \frac{2G}{3}\right)d\varepsilon_{rr} - 3K\alpha dT$$

$$d\sigma_{zz} = \left(K - \frac{2G}{3}\right)(d\varepsilon_{rr} + d\varepsilon_{\theta\theta}) - 3K\alpha dT$$

We are especially interested in studying concrete layer behavior. Thus, a dimensionless radius—thickness ratio  $\rho = (r-R_0)/e$  is introduced where  $R_0$  and e=internal radius and the thickness of the concrete wall. This dimensionless number allows us to neglect  $\varepsilon_{\theta\theta}$  with respect to  $\varepsilon_{rr}$  and  $\sigma_{rr}$  with respect to  $\sigma_{\theta\theta}$ . Indeed, according to Eq. (11),  $|\varepsilon_{\theta\theta}/\varepsilon_{rr}| = |\varepsilon_{\theta\theta}/[\varepsilon_{\theta\theta} + (R_0/e + \rho)\partial\varepsilon_{\theta\theta}/\partial\rho]| \ll 1$  because  $R_0/e \gg 1$ .

In the same way, and according to Eq. (12),  $|\sigma_{rn}/\sigma_{\theta\theta}| = |\sigma_{rr}/[\sigma_{rr} + (R_0/e + \rho)\partial\sigma_{rr}/\partial\rho]| \ll 1$ .

Then, in the following, it can be supposed that

$$\sigma_{rr} \approx 0$$
 and  $\varepsilon_{\theta\theta} \approx 0$  (14)

This approximation is foreseeable because when  $R_0/e \gg 1$ , the problem tends locally toward a Cartesian geometry (in which  $\sigma_{xx}$ =0 and  $\varepsilon_{yy}$ =0).

As a consequence of approximation (14), the radial strain variation can be expressed analytically as

$$d\varepsilon_{rr} = \frac{9K}{4G + 3K}\alpha dT = \frac{1 + \nu}{1 - \nu}\alpha dT$$

and then axial and orthoradial stress variations read

$$d\sigma_{zz} \approx d\sigma_{\theta\theta} \approx -\frac{18GK}{4G + 3K}\alpha dT = -\frac{E_0}{1 - \nu}\alpha \xi_{eq}(T)dT$$

The two last differential equations can be integrated on temperature

$$\varepsilon_{rr} = \frac{1+\nu}{1-\nu} \alpha (T-T_0) \tag{15}$$

$$\sigma_{zz} \approx \sigma_{\theta\theta} \approx -\frac{E_0}{1-\nu} \alpha \int_{T_z}^{T} \xi_{eq}(T) dT$$
 (16)

However, the last equalities (15) and (16) are valid if there is no plastic flow:

- $f(\sigma, \xi) < 0$ : elastic domain;
- f=0 and df<0: elastic unloading.

In the following, the conditions to reach the plastic criterion are studied. In our case, the stress tensor can be replaced by a vector

$$(\sigma_{rr}, \sigma_{\theta\theta}, \sigma_{zz}) = (0, \sigma_{zz}, \sigma_{zz})$$

Then, the invariants of William-Warnke criterion (3) are

$$\tau = -\frac{\sigma_{zz}}{\sqrt{3}}, \quad \sigma = \frac{2\sigma_{zz}}{3}$$

and

$$cos(\Theta) = 1 \Rightarrow \delta(\Theta) = \delta(0) = \delta_t$$

Then

$$df = -\frac{1}{3}(\sqrt{3} - 2\delta_t)d\sigma_{zz} - \delta_t\rho_0 d\xi$$

$$= \left[ (\sqrt{3} - 2\delta_t) \frac{E_0}{3(1 - \nu)} \alpha \xi_{eq}(T) - \delta_t\rho_0 \frac{\partial \xi_{eq}}{\partial T} \right] dT \ge 0$$

which means that there is no elastic unloading when temperature increases. Thus, the only case in the elastic phase is when the loading stays in the elastic domain (f < 0), which is verified when

$$|\sigma_{zz}| = -\sigma_{zz} \le \frac{3\rho_0 \delta_t}{-2\delta_t + \sqrt{3}} \xi_{eq}(T)$$
 (17)

The last result is foreseeable because  $[3\rho_0\delta_t/(-2\delta_t + \sqrt{3})]\xi_{eq}(T)$  =  $f_{bc}\xi_{eq}(T)$ , which is the bicompressive elastic limit after dehydration. The stresses are, indeed, bicompressive since they are concentrated in the plane  $(\theta, z)$ .

The combination of equality (16) and inequality (17) on  $\sigma_{zz}$  allows us to deduce a critical temperature of plastification  $T_{\rm pl}$  at which a plastic flow starts.  $T_{\rm pl}$  verifies

$$\frac{E_0}{1 - \nu} \alpha \int_{T_0}^{T_{\text{pl}}} \xi_{\text{eq}}(T) dT \approx f_{\text{bc}} \xi_{\text{eq}}(T_{\text{pl}})$$
 (18)

 $\xi_{\rm eq}$  varies linearly on temperature (for T<773 K) following the function

$$\xi_{\text{eq}}(T) = 1 - \frac{0.83}{500}(T - T_0)$$

For this curve of dehydration, the resolution of Eq. (18) gives the "plastification" temperature  $T_{\rm pl} \approx 440~{\rm K}$  and then the dehydration degree  $\xi_{\rm pl} = \xi_{\rm eq}(T_{\rm pl}) \approx 0.75$ .

#### Plastic Phase

Now, it is supposed that plastification temperature  $T_{\rm pl}$  is exceeded. There is a plastic flow and according to Eq. (8)

$$d\varepsilon_{rr}^{\rm pl} = d\lambda \frac{\partial f}{\partial \sigma_{\rm ex}}, \quad d\varepsilon_{\theta\theta}^{\rm pl} = d\lambda \frac{\partial f}{\partial \sigma_{\theta\theta}}, \quad \text{and} \quad d\varepsilon_{zz}^{\rm pl} = d\lambda \frac{\partial f}{\partial \sigma_{\rm ex}}$$

where using flow rule (3), for  $(i=r,\theta,z)$ 

$$\frac{\partial f}{\partial \sigma_{ii}} = \frac{s_{ii}}{2\tau} + (\sigma - \rho_0 \xi) P_i + \frac{1}{3} \delta(\Theta)$$

with

$$P_{i} = -\frac{d\delta}{d\Theta} \frac{1}{2\sqrt{12}\tau^{3}} \left[ (2\sigma_{1}^{pr} - \sigma_{2}^{pr} - \sigma_{3}^{pr}) s_{ii} + a_{i}\tau^{2} \right]$$

where  $\sigma_1^{pr}$ ,  $\sigma_3^{pr}$  and  $\sigma_3^{pr}$ =principal stresses; and  $a_i$ =-4 if  $\sigma_{ii}$ = $\sigma_1^{pr}$  and  $a_i$ =2 otherwise.

Approximation (14) is used again:  $\varepsilon_{\theta\theta} \approx 0$  and  $\sigma_{rr} \approx 0$ , and so  $\sigma_{\theta\theta} \approx \sigma_{rr}$ .

Knowing that  $\sigma_{\theta\theta} \approx \sigma_{zz} < 0 \approx \sigma_{rr}$ , it can be concluded that  $\sigma_{rr} = \sigma_1^{pr}$  and then  $a_r = -4$  and  $a_{\theta} = a_z = 2$ . Finally

$$\frac{\partial f}{\partial \sigma_{rr}} = \frac{1}{\sqrt{3}} + \frac{\delta_t}{3} = 0.835$$

and

$$\frac{\partial f}{\partial \sigma_{zz}} = \frac{\partial f}{\partial \sigma_{\theta\theta}} = -\frac{1}{2\sqrt{3}} + \frac{\delta_t}{3} = -0.0304$$

A first conclusion is

$$d\varepsilon_{AA}^{pl} = d\varepsilon_{zz}^{pl}$$
 (19)

and

$$d\varepsilon_{rr}^{\text{pl}} = -\frac{\frac{1}{\sqrt{3}} + \frac{\delta_t}{3}}{-\frac{1}{2\sqrt{3}} + \frac{\delta_t}{3}} d\varepsilon_{\theta\theta}^{\text{pl}} = -27.47 d\varepsilon_{\theta\theta}^{\text{pl}}$$
(20)

It is clear then that the most important plastic strain is done in the radial direction.

In our cylindrical case, thermoelastic state equation (7), taking into account plastic strain rate, reads

$$\begin{split} d\sigma_{rr} &= \left(\frac{4G}{3} + K\right) (d\varepsilon_{rr} - d\varepsilon_{rr}^{\text{pl}}) + \left(K - \frac{2G}{3}\right) (d\varepsilon_{\theta\theta} - d\varepsilon_{\theta\theta}^{\text{pl}}) \\ &- \left(K - \frac{2G}{3}\right) d\varepsilon_{zz}^{\text{pl}} - 3K\alpha dT \end{split}$$

$$\begin{split} d\sigma_{\theta\theta} = & \left(\frac{4G}{3} + K\right) (d\varepsilon_{\theta\theta} - d\varepsilon_{\theta\theta}^{\text{pl}}) + \left(K - \frac{2G}{3}\right) (d\varepsilon_{rr} - d\varepsilon_{rr}^{\text{pl}}) \\ & - \left(K - \frac{2G}{3}\right) d\varepsilon_{zz}^{\text{pl}} - 3K\alpha dT \end{split}$$

$$d\sigma_{zz} = -\left(\frac{4G}{3} + K\right)d\varepsilon_{zz}^{\text{pl}} + \left(K - \frac{2G}{3}\right)(d\varepsilon_{rr} - d\varepsilon_{rr}^{\text{pl}} + d\varepsilon_{\theta\theta} - d\varepsilon_{\theta\theta}^{\text{pl}})$$

$$= 3K\alpha dT$$

Still using approximations (14),  $\varepsilon_{\theta\theta} \approx 0$ ,  $\sigma_{rr} \approx 0$  leading then to  $\sigma_{\theta\theta} \approx \sigma_{zz}$  and  $\varepsilon_{\theta\theta}^{pl} \approx \varepsilon_{zz}^{pl}$  allows us to establish the following relation:

$$d\sigma_{zz} = -\frac{18GK}{4G + 3K} (d\varepsilon_{\theta\theta}^{pl} + \alpha dT)$$
 (21)

Because the plastification temperature  $T_{\rm pl}$  is exceeded, it can be affirmed according to Eq. (17) that at each time (in the plasticized zone)

$$\sigma_{zz} = \frac{3\rho_0 \delta_t}{2\delta_t - \sqrt{3}} \xi_{eq}(T) = -f_{bc} \xi_{eq}(T)$$
 (22)

It can be deduced now from Eqs. (19), (21), and (22) that

$$d\varepsilon_{\theta\theta}^{\text{pl}} = d\varepsilon_{zz}^{\text{pl}} = \frac{4G + 3K}{18GK} f_{\text{bc}} d\xi_{\text{eq}} - \alpha dT = \frac{(1 - \nu) f_{\text{bc}}}{E_0} \frac{d\xi_{\text{eq}}}{\xi_{\text{eq}}} - \alpha dT$$
(23)

and then

$$\begin{split} d\varepsilon_{rr}^{\text{el}} &= d\varepsilon_{rr} - d\varepsilon_{rr}^{\text{pl}} = \frac{1}{4G + 3K} [(6K - 4G)d\varepsilon_{\theta\theta}^{\text{pl}} + 9K\alpha dT] \\ &= \frac{2\nu f_{\text{bc}}}{E_0} \frac{d\xi_{\text{eq}}}{\xi_{\text{eq}}} + \alpha dT \end{split} \tag{24}$$

The first differential equality (23) can be integrated between the plastification temperature  $T_{\rm pl}\left[\varepsilon_{\theta\theta}^{\rm pl}(T_{\rm pl}) = \varepsilon_{zz}^{\rm pl}(T_{\rm pl}) = 0\right]$  and the actual temperature T

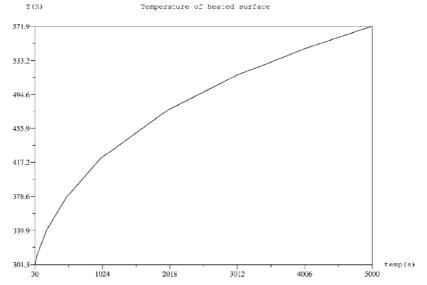


Fig. 2. Temperature of the heated surface (intrados)  $T_{\rm pl}$  is reached after  $1 \times 10^3$  s

$$\varepsilon_{\theta\theta}^{\text{pl}} = \varepsilon_{zz}^{\text{pl}} = \frac{(1 - \nu)f_{\text{bc}}}{E_0} \log\left(\frac{\xi_{\text{eq}}(T)}{\xi_{\text{pl}}}\right) - \alpha(T - T_{\text{pl}})$$
 (25)

The radial plastic strain (which is more important than the orthoradial or axial plastic strain) can be then expressed from Eq. (19)

$$\varepsilon_{rr}^{\text{pl}} = -\frac{\frac{1}{\sqrt{3}} + \frac{\delta_{t}}{3}}{-\frac{1}{2\sqrt{3}} + \frac{\delta_{t}}{3}} \varepsilon_{\theta\theta}^{\text{pl}} \\
= -\frac{\frac{1}{\sqrt{3}} + \frac{\delta_{t}}{3}}{-\frac{1}{2\sqrt{3}} + \frac{\delta_{t}}{3}} \left[ \frac{(1 - \nu)f_{\text{bc}}}{E_{0}} \log \left( \frac{\xi_{\text{eq}}(T)}{\xi_{\text{pl}}} \right) - \alpha (T - T_{\text{pl}}) \right] \tag{26}$$

The integration of the second differential equation (24) between  $T_{\rm pl}$  and T needs to know the elastic radial strain when the plastification temperature  $T_{\rm pl}$  is reached. The value  $\varepsilon_{rr}^{\rm el}(T_{\rm pl})$  is the value of  $\varepsilon_{rr}^{\rm el}$  when plasticity is just beginning and is, therefore, given by the expression of elastic phase (15)

$$\varepsilon_{rr}^{\rm el}(T_{\rm pl}) = \varepsilon_{rr}(T_{\rm pl}) = \frac{1+\nu}{1-\nu}\alpha(T_{\rm pl}-T_0)$$

and then

$$\varepsilon_{rr}^{\text{el}} = \frac{1 + \nu}{1 - \nu} \alpha (T_{\text{pl}} - T_0) + \frac{2\nu f_{\text{bc}}}{E_0} \log \left( \frac{\xi_{\text{eq}}(T)}{\xi_{\text{eq}}(T_{\text{pl}})} \right) + \alpha (T - T_{\text{pl}})$$
(27)

Finally, the total radial strain  $\varepsilon_{rr} = \varepsilon_{rr}^{\rm el} + \varepsilon_{rr}^{\rm pl}$  can be deduced from Eqs. (26) and (27). The elastic orthoradial and axial strains can also be expressed

$$\varepsilon_{\theta\theta}^{el} = \varepsilon_{zz}^{el} = -\varepsilon_{\theta\theta}^{pl} = -\varepsilon_{zz}^{pl}$$

from Eq. (25).

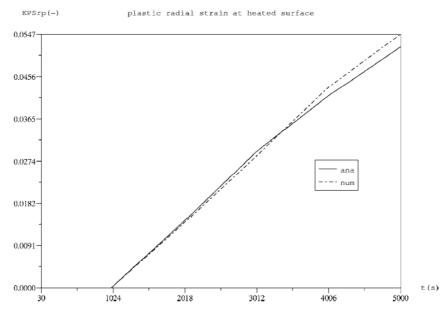


Fig. 3. Plastic radial strain at heated surface: existence of two phases; the plastic phase starts when  $T_{\rm pl}$  is reached (Fig. 2)

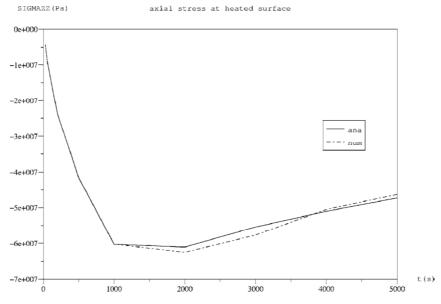
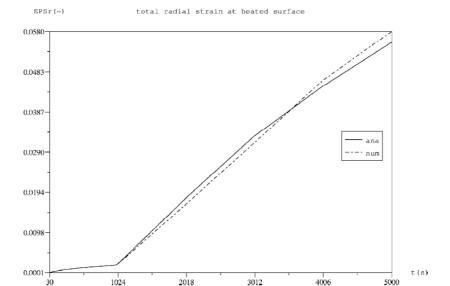


Fig. 4. Compressive axial stress at heated surface: variation changes when  $T=T_{\rm pl}$

- In Fig. 2 is presented the temperature of a heated surface. It can be noticed that the plastification temperature is reached after 1×10<sup>3</sup> s. At the same moment, the radial plastic flow starts (Fig. 3) and the variation of the axial compressive stress changes (Fig. 4). Fig. 5 also shows that the slope of the total radial strain changes due to the plastic flow.
- It can also be noticed in Figs. 3–5 that there is good agreement between the analytical curves [simplified approach using approximation (14)] and the numerical ones (complete model without any approximation). The approximations introduced before  $(\sigma_{rr} \approx 0 \text{ and } \epsilon_{\theta\theta} \approx 0)$  are then validated.

# **Explanation of Thermomechanical Spalling**

In the following, the results of the previous section are used to explain under which conditions thermomechanical spalling can

# General Case Taking Account of Decohesion and Softening

Layers of concrete having a temperature greater than  $T_{\rm pl}$  are in a plastification process. The remaining layers are still in an elastic phase. Let us note the  $r_{\rm pl}$  radius where  $T=T_{\rm pl}$ . For  $r>r_{\rm pl}$ , it is the elastic domain:  $T< T_{\rm pl}$ . From Eq. (16), the axial stress can be expressed

$$\sigma_{zz} = -[E_0/(1-\nu)]\alpha \int_{T_0}^{T} \xi_{eq}(T)dT$$

and then

$$\frac{\partial \sigma_{zz}}{\partial r} = \frac{\partial \sigma_{zz}}{\partial T} \frac{\partial T}{\partial r} = -\frac{E_0}{1 - \nu} \alpha \xi_{eq}(T) \frac{\partial T}{\partial r} > 0$$

$$\frac{\partial \sigma_{zz}}{\partial r} = \frac{\partial \sigma_{zz}}{\partial T} \frac{\partial T}{\partial r} = -f_{bc} \frac{\partial \xi_{eq}}{\partial T} \frac{\partial T}{\partial r} < 0$$

For  $r\!<\!r_{\rm pl}$ , it is the plastic domain:  $T\!>\!T_{\rm pl}$ . From Eq. (22),  $\sigma_{zz}\!=\!-\xi_{\rm eq}(T)f_{\rm bc}$  and then

It has been just proven that  $\sigma_{zz}$  (and also  $\sigma_{\theta\theta}$ ) changes of variation at  $r=r_{\rm pl}$ . There is a plug of axial and orthoradial stresses at

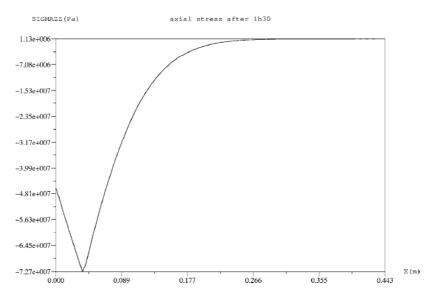


Fig. 6. Axial stress after 1 h 30 min of heating: existence of a stress "plug" and a change of slope at the surface  $r=r_{\rm pl}$ , which may explain failure at this surface

 $r=r_{\rm pl}$  (Fig. 6) and this change of slope may explain spalling by failure in the plane  $(\theta, z)$ .

Thus, the problem of mechanical spalling is brought back to study the propagation of the plasticized zone by the mean of  $r_{\rm pl}$ , where the temperature reaches  $T_{\rm pl}$ . Forecasting the spalling can be, therefore, reduced to a purely thermal problem.

What follows is a study of the different parts of the constitutive model to examine which term is necessary to forecast the

· During the elastic phase, the expression of radial strain is still  $\varepsilon_{rr} = [(1+\nu)/(1-\nu)]\alpha(T-T_0)$ . However, expression (16) of axial stress reads

$$\sigma_{zz} \approx \sigma_{\theta\theta} \approx -\frac{E_0}{1-\nu} \alpha (T-T_0)$$

Eq. (18) for determining the plastic temperature changes into

$$\frac{E_0}{1-\nu}\alpha(T_{\rm pl}-T_0) \approx f_{\rm bc}\xi_{\rm eq}(T_{\rm pl})$$

• During the plastic phase,  $\sigma_{zz} = -f_{bc}\xi_{eq}(T)$  is still valid but the different strains change into

$$\varepsilon_{\theta\theta}^{\text{pl}} = \varepsilon_{zz}^{\text{pl}} = \frac{(1 - \nu)f_{\text{bc}}}{E_0} \left[ \xi_{\text{eq}}(T) - \xi_{\text{pl}} \right] - \alpha (T - T_{\text{pl}})$$

$$\varepsilon_{rr}^{\text{pl}} = -\frac{\frac{1}{\sqrt{3}} + \frac{\delta_t}{3}}{-\frac{1}{2\sqrt{3}} + \frac{\delta_t}{3}} \varepsilon_{\theta\theta}^{\text{pl}}$$

$$\varepsilon_{rr}^{\text{el}} = \frac{1+\nu}{1-\nu} \alpha (T_{\text{pl}} - T_0) + \frac{2\nu f_{\text{bc}}}{E_0} [\xi_{\text{eq}}(T) - \xi_{\text{pl}}] + \alpha (T - T_{\text{pl}})$$

In this case, the spalling explanation is always valid, because  $\partial \sigma_{zz}/\partial r$  is still positive for  $r\!<\!r_{\rm pl}$  according to Eq. (22) and negative when  $r > r_{\rm pl}$  according to Eq. (28).

It can be noticed that the plastification temperature is lower in this case ( $T_{\rm pl} \approx 425$  K instead of 440 K). This means that the plastification radius  $r_{\rm pl}$  is higher.

## Neglecting Thermal Decohesion

In this section, plasticity criterion (3) is independent of the dehydration degree  $\xi[f(\sigma)]$  instead of  $f(\sigma,\xi)$ ; the strength diminution caused by dehydration is neglected.

For the elastic phase, the expressions of strains and stresses are unchanged. However, the plastification temperature changes and is given while solving

$$\frac{E_0}{1 - \nu} \alpha \int_{T_0}^{T_{\text{pl}}} \xi_{\text{eq}}(T) dT \approx f_{\text{bc}}$$

During the plastic phase, the axial stress is constant

$$\sigma_{zz} = -f_{bc} \tag{29}$$

Then, the different strains change into

$$\varepsilon_{\theta\theta}^{\text{pl}} = \varepsilon_{zz}^{\text{pl}} = -\alpha (T - T_{\text{pl}})$$

$$\varepsilon_{rr}^{\rm pl} = -\frac{\frac{1}{\sqrt{3}} + \frac{\delta_t}{3}}{-\frac{1}{2\sqrt{3}} + \frac{\delta_t}{3}} \varepsilon_{\theta\theta}^{\rm pl} = \frac{\frac{1}{\sqrt{3}} + \frac{\delta_t}{3}}{-\frac{1}{2\sqrt{3}} + \frac{\delta_t}{3}} \alpha (T - T_{\rm pl})$$

$$\varepsilon_{rr}^{el} = \frac{1 + \nu}{1 - \nu} \alpha (T_{pl} - T_0) + \alpha (T - T_{pl})$$

The spalling explanation is not valid in this case because  $\partial \sigma_{zz}/\partial r$ is null for  $r < r_{\rm pl}$  according to Eq. (29). There is no plug of axial and orthoradial stresses able to explain a failure in the plane

 $(\theta,z)$ . It means that taking into account the thermal decohesion is necessary to be able to forecast the spalling.

## Neglecting Both Thermal Decohesion and Softening

Neglecting both thermal decohesion and softening means that the chemomechanical couplings are neglected  $[f(\underline{\sigma}), E(T) = E_0]$ . The stress expressions are obtained directly from the last case [by simply replacing  $\xi_{eq}(T)$  by 1]. The plastic temperature changes

$$\frac{E_0}{1-\nu}\alpha(T_{\rm pl}-T)\approx f_{\rm bc}$$

Like the last case, the compressive stress is constant in the plasticized zone near the heated surface. The spalling cannot be explained in this case. There is rather a crushing failure mode at the surface.

#### Conclusion

In this paper, the approximative expressions of compressive stresses and strains (elastic, plastic, and total) have been established in both elastic and plastic phases. The existence of a plastification temperature has also been obtained. Then, the spalling phenomenon is related to a "peak" appearing on the stresses at a certain depth  $r_{\rm pl}$  where the plastification temperature is attained. The existence of this peak was studied in different cases (with or without thermal softening and decohesion) to conclude that it is the thermal decohesion which is necessary to forecast the thermal spalling. The plastification temperature, obtained just while treating a simple problem of thermal conduction, is useful in identifying the plasticized zone where a spalling process is probable.
