Controllability of the bilinear Schrödinger equation with several controls and application to a 3D molecule*

Ugo Boscain¹, Marco Caponigro², and Mario Sigalotti³

Abstract— We show the approximate rotational controllability of a polar linear molecule by means of three nonresonant linear polarized laser fields. The result is based on a general approximate controllability result for the bilinear Schrödinger equation, with wavefunction varying in the unit sphere of an infinite-dimensional Hilbert space and with several control potentials, under the assumption that the internal Hamiltonian has discrete spectrum.

I. INTRODUCTION

Rotational molecular dynamics is one of the most important examples of quantum systems with an infinite-dimensional Hilbert space and a discrete spectrum. Molecular orientation and alignment are well-established topics in the quantum control of molecular dynamics both from the experimental and theoretical points of view (see [19], [20] and references therein). For linear molecules driven by linearly polarized laser fields in gas phase, alignment means an increased probability direction along the polarization axis whereas orientation requires in addition the same (or opposite) direction as the polarization vector. Such controls have a variety of applications extending from chemical reaction dynamics to surface processing, catalysis and nanoscale design. A large amount of numerical simulations have been done in this domain but the mathematical part is not yet fully understood. From this perspective, the controllability problem is a necessary step towards comprehension.

We focus in this paper on the control by laser fields of the rotation of a rigid linear molecule in \mathbb{R}^3 . This control problem corresponds to the control of the Schrödinger equation on the unit sphere S^2 . We show that the system driven by three fields along the three axes is approximately controllable for arbitrarily small controls. This means, in particular, that there exist control strategies which bring the initial state arbitrarily close to states maximizing the molecular orientation [21].

A. The model

We consider a polar linear molecule in its ground vibronic state subject to three nonresonant (with respect to the vibronic frequencies) linearly polarized laser fields. The control is given by the electric fields $E = (u_1, u_2, u_3)$ depending on time and constant in space. We neglect in this model the polarizability tensor term which corresponds to the field-induced dipole moment. This approximation is correct if the intensity of the laser field is sufficiently weak. Despite its simplicity, this equation reproduces very well the experimental data on the rotational dynamics of rigid molecules (see [20]).

Up to normalization of physical constants (in particular, in units such that $\hbar = 1$), the dynamics is ruled by the equation

$$i \frac{\partial \psi(\theta, \varphi, t)}{\partial t} = -\Delta \psi(\theta, \varphi, t) + (u_1(t) \sin \theta \cos \varphi + u_2(t) \sin \theta \sin \varphi + u_3(t) \cos \theta) \psi(\theta, \varphi, t) \quad (1)$$

where θ, φ are the spherical coordinates, which are related to the Euclidean coordinates by the identities

$$x = \sin \theta \cos \varphi, \quad y = \sin \theta \sin \varphi, \quad z = \cos \theta,$$

while Δ is the Laplace–Beltrami operator on the sphere (called in this context the *angular momentum operator*), i.e.,

$$\Delta = \frac{1}{\sin \theta} \frac{\partial}{\partial \theta} \left(\sin \theta \frac{\partial}{\partial \theta} \right) + \frac{1}{\sin^2 \theta} \frac{\partial^2}{\partial \varphi^2}.$$

The wavefunction $\psi(\cdot, \cdot, t)$ evolves in the unit sphere \mathcal{S} of $\mathcal{H} = L^2(\mathbb{S}^2, \mathbb{C})$.

B. The main results

In the following we denote by $\psi(T; \psi_0, u)$ the solution at time T of equation (1), corresponding to control u and with initial condition $\psi(0; \psi_0, u) = \psi_0$, belonging to \mathcal{S} .

Our main result says that (1) is approximately controllable with arbitrarily small controls.

Theorem 1.1: For every ψ^0, ψ^1 belonging to \mathcal{S} and every $\varepsilon, \delta_1, \delta_2, \delta_3 > 0$, there exist $T > 0$ and $u \in L^\infty([0, T], [0, \delta_1] \times [0, \delta_2] \times [0, \delta_3])$ such that $\|\psi^1 - \psi(T; \psi^0, u)\| < \varepsilon$.

The proof of the result is based on arguments inspired by those developed in [11], [7]. There are two main difficulties preventing us to apply those results to the case under consideration: firstly, we deal here with several control parameters, while those general results were specifically conceived for the single-input case. Notice that, because of symmetry obstructions, equation (1) is not controllable with only one

of the three controls u_1, u_2, u_3 . Secondly, the general theory developed in [11], [7] is based on nonresonance conditions on the spectrum of the drift Schrödinger operator (the *internal Hamiltonian*). The Laplace–Beltrami operator on S^2 , however, has a severely degenerate spectrum. It is known, indeed, that the ℓ -th eigenvalue $-i\ell(\ell + 1)$ has multiplicity $2\ell + 1$. In [11] we proposed a perturbation technique in order to overcome resonance relations in the spectrum of the drift. This technique was applied in [8] to the case of the orientation of a molecule confined in a plane driven by one control. The planar case is already technically challenging and a generalization to the case of three controls in the space will hardly provide an apophantic proof of the approximate controllability result. We therefore provide a general multi-input result which can be applied to the control problem defined in (1), up to the computation of certain Lie algebras associated with its Galerkin approximations.

The structure of the paper is the following: in the next section we present the general multi-input abstract framework and we recall some previously known controllability and non-controllability results. In Section III we prove our main sufficient condition for approximate controllability. Finally, in Section IV we prove that the abstract result applies to system (1).

II. ABSTRACT FRAMEWORK

Definition 2.1: Let \mathcal{H} be an infinite-dimensional Hilbert space with scalar product $\langle \cdot, \cdot \rangle$ and A, B_1, \dots, B_p be (possibly unbounded) linear operators on \mathcal{H} , with domains $D(A), D(B_1), \dots, D(B_p)$. Let U be a subset of \mathbb{R}^p . Let us introduce the controlled equation

$$\frac{d\psi}{dt}(t) = (A + u_1(t)B_1 + \dots + u_p(t)B_p)\psi(t), u(t) \in U \subset \mathbb{R}^p. \quad (2)$$

We say that $(A, B_1, \dots, B_p, U, \Phi)$ satisfies (\mathfrak{A}) if the following assumptions are verified:

- (\mathfrak{A}1) $\Phi = (\phi_k)_{k \in \mathbb{N}}$ is an Hilbert basis of \mathcal{H} made of eigenvectors of A associated with the family of eigenvalues $(i\lambda_k)_{k \in \mathbb{N}}$;
- (\mathfrak{A}2) $\phi_k \in D(B_j)$ for every $k \in \mathbb{N}, j = 1, \dots, p$;
- (\mathfrak{A}3) $A + u_1 B_1 + \dots + u_p B_p : \text{span}\{\phi_k \mid k \in \mathbb{N}\} \rightarrow \mathcal{H}$ is essentially skew-adjoint for every $u \in U$;
- (\mathfrak{A}4) if $j \neq k$ and $\lambda_j = \lambda_k$ then $\langle \phi_j, B_l \phi_k \rangle = 0$ for every $l = 1, \dots, p$.

If $(A, B_1, \dots, B_p, U, \Phi)$ satisfies (\mathfrak{A}) then, for every $(u_1, \dots, u_p) \in \mathbb{R}^p$, $A + u_1 B_1 + \dots + u_p B_p$ generates a unitary group $e^{t(A + u_1 B_1 + \dots + u_p B_p)}$. It is therefore possible to define the propagator Υ_T^u at time T of system (1) associated with a p -uple of piecewise constant controls $u(t) = (u_1(t), \dots, u_p(t))$ by concatenation. If, moreover, the potentials B_1, \dots, B_p are bounded operators then the definition can be extended by continuity to every L^∞ control law.

Definition 2.2: Let (A, B, U, Φ) satisfy (\mathfrak{A}) . We say that (2) is *approximately controllable* if for every ψ_0, ψ_1 in the unit sphere of \mathcal{H} and every $\varepsilon > 0$ there exist a piecewise

constant control function $u : [0, T] \rightarrow U$ such that $\|\psi_1 - \Upsilon_T^u(\psi_0)\| < \varepsilon$.

Definition 2.3: Let (A, B, U, Φ) satisfy (\mathfrak{A}) . We say that (2) is *approximately simultaneously controllable* if for every r in \mathbb{N} , ψ_1, \dots, ψ_r in \mathcal{H} , $\hat{\Upsilon}$ in $\mathbf{U}(\mathcal{H})$, and $\varepsilon > 0$ there exists a piecewise constant control $u : [0, T] \rightarrow U$ such that

$$\left\| \hat{\Upsilon} \psi_k - \Upsilon_T^u \psi_k \right\| < \varepsilon, \quad k = 1, \dots, r.$$

A. Short review of controllability results

The controllability of system (2) is a well-established topic when the state space \mathcal{H} is finite-dimensional (see for instance [12] and reference therein), thanks to general controllability methods for left-invariant control systems on compact Lie groups ([10], [14]).

When \mathcal{H} is infinite-dimensional, it is known that the bilinear Schrödinger equation is not controllable (see [2], [22]). Hence, one has to look for weaker controllability properties as, for instance, approximate controllability or controllability between eigenstates of the Schrödinger operator (which are the most relevant physical states). In certain cases where the dimension of the domain where the controlled PDE is defined is equal to one a description of the reachable set has been provided [3], [4], [5]. For dimension larger than one or for more general situations, the exact description of the reachable set appears to be more difficult and at the moment only approximate controllability results are available. Most of them are for the single-input case (see, in particular, [6], [7], [11], [15], [16], [18], [17]), except for some approximate controllability result for specific systems ([13]) and some general approximate controllability result between eigenfunctions based on adiabatic methods [9].

B. Notation

Set $b_{jk}^{(l)} = \langle \phi_j, B_l \phi_k \rangle$, $l = 1, \dots, p$. For every n in \mathbb{N} , define the orthogonal projection

$$\pi_n : \mathcal{H} \ni \psi \mapsto \sum_{j \leq n} \langle \phi_j, \psi \rangle \phi_j \in \mathcal{H}.$$

Given a linear operator Q on \mathcal{H} we identify the linear operator $\pi_n Q \pi_n$ preserving $\text{span}\{\phi_1, \dots, \phi_n\}$ with its $n \times n$ complex matrix representation with respect to the basis (ϕ_1, \dots, ϕ_n) .

III. MAIN ABSTRACT CONTROLLABILITY RESULT IN THE MULTI-INPUT CASE

Let us introduce the set Σ_N of spectral gaps associated with the N -dimensional Galerkin approximation as

$$\Sigma_N = \{|\lambda_j - \lambda_k| \mid j, k = 1, \dots, N, \lambda_j \neq \lambda_k\}.$$

For every $\sigma \in \Sigma_N$, let

$$B_\sigma^{(N)}(v_1, \dots, v_p)_{j,k} = (v_1 B_1^{(N)} + \dots + v_p B_p^{(N)})_{j,k} \delta_{\sigma, |\lambda_j - \lambda_k|}.$$

The $N \times N$ matrix $B_\sigma^{(N)}(v_1, \dots, v_p)$ corresponds to the choice of the controls v_1, \dots, v_p and to the “activation” of the spectral gap σ . Define

$$\mathcal{M}_N = \{B_\sigma^{(N)}(v_1, \dots, v_p) \mid \sigma \in \Sigma_N, v_1, \dots, v_p \in [0, 1]\}$$

and

$$\mathcal{M}_0^n = \left\{ A^{(n)} - \frac{\text{tr}(A^{(n)})}{n} I_n \right\} \cup \left\{ M \in \mathfrak{su}(n) \mid \forall N \geq n \exists Q \in \mathcal{M}_N \text{ s.t. } Q = \begin{pmatrix} M & 0 \\ 0 & * \end{pmatrix} \right\}.$$

The set \mathcal{M}_0^n represents ‘‘compatible dynamics’’ for the n -dimensional Galerkin approximation (*compatible*, that is, with higher dimensional Galerkin approximations).

Theorem 3.1 (Abstract multi-input controllability result):

Let $U = [0, \delta]^p$ for some $\delta > 0$. If for every $n_0 \in \mathbb{N}$ there exist $n > n_0$ such that

$$\text{Lie}\mathcal{M}_0^n = \mathfrak{su}(n), \quad (3)$$

then the system

$$\dot{x} = (A + u_1 B_1 + \dots + u_p B_p)x, \quad u \in U,$$

is approximately simultaneously controllable.

A. Preliminaries

The following technical result, which we shall use in the proof of Theorem 3.1, has been proved in [7].

Lemma 3.2: Let κ be a positive integer and $\gamma_1, \dots, \gamma_\kappa \in \mathbb{R} \setminus \{0\}$ be such that $|\gamma_1| \neq |\gamma_j|$ for $j = 2, \dots, \kappa$. Let

$$\varphi(t) = (e^{it\gamma_1}, \dots, e^{it\gamma_\kappa}).$$

Then, for every $\tau_0 \in \mathbb{R}$, we have

$$\overline{\text{conv}\varphi([\tau_0, \infty))} \supseteq \nu \mathbb{S}^1 \times \{(0, \dots, 0)\},$$

where $\nu = \prod_{k=2}^{\infty} \cos\left(\frac{\pi}{2k}\right) > 0$. Moreover, for every $R > 0$ and $\xi \in \mathbb{S}^1$ there exists a sequence $(t_k)_{k \in \mathbb{N}}$ such that $t_{k+1} - t_k > R$ and

$$\lim_{h \rightarrow \infty} \frac{1}{h} \sum_{k=1}^h \varphi(t_k) = (\nu\xi, 0, \dots, 0).$$

B. Time reparametrization

For every piecewise constant function $z(t) = \sum_{k=1}^K z_k \chi_{[s_{k-1}, s_k)}(t)$ such that $z_k > 0$, for every $k = 1, \dots, K$, and $v_j(t) = \sum_{k=1}^K v_k^{(j)} \chi_{[s_{k-1}, s_k)}(t)$ with $j = 1, \dots, p$, we consider the system

$$\frac{d\psi}{dt}(t) = (z(t)A + v_1(t)B_1 + \dots + v_p(t)B_p)\psi(t). \quad (4)$$

System (4) can be seen as a time-reparametrisation of system (2). Let $\psi(t)$ be the solution of (2) with initial condition $\psi_0 \in \mathcal{H}$ associated with the piecewise constant control $u(\cdot)$ with components $u_j(\cdot) = \sum_{k=1}^K u_k^{(j)} \chi_{[t_{k-1}, t_k)}(\cdot)$, $j = 1, \dots, p$. If $s_k = \frac{t_k - t_{k-1}}{z_k} + s_{k-1}$, $s_0 = 0$, $v_k^{(j)} = u_k^{(j)} z_k$ for every $k = 1, \dots, K$, $j = 1, \dots, p$, then the solution $\tilde{\psi}(t)$ of (4) with the initial condition $\psi_0 \in \mathcal{H}$ associated with the controls $z(t), v_1(t), \dots, v_p(t)$ satisfies

$$\tilde{\psi} \left(\int_0^t \sum_{k=1}^K \frac{1}{z_k} \chi_{[t_{k-1}, t_k)}(s) ds \right) = \psi(t).$$

Controllability issues for system (2) and (4) are equivalent. Indeed, consider piecewise constant controls $z : [0, T_v] \rightarrow [1/\delta, \infty)$, $z(t) = \sum_{k=1}^K z_k \chi_{[s_{k-1}, s_k)}(t)$ and $v_j : [0, T_v] \rightarrow [0, 1]$, $v_j(t) = \sum_{k=1}^K v_k^{(j)} \chi_{[s_{k-1}, s_k)}(t)$ with $j = 1, \dots, p$, achieving controllability (steering system (4) from ψ_j to $\hat{\Upsilon}\psi_j$, $j = 1, \dots, r$ in a time T_v). Then the controls $u_j(t) = \sum_{k=1}^K u_k^{(j)} \chi_{[t_{k-1}, t_k)}(t)$, $j = 1, \dots, p$ defined by $u_k^{(j)} = v_k^{(j)} / z_k$ and $t_0 = 0, t_k = (s_k - s_{k-1})z_k + t_{k-1}$, steer system (2) from ψ_j to $\hat{\Upsilon}\psi_j$, $j = 1, \dots, r$ in a time T_u .

C. Interaction framework

Let $\omega(t) = \int_0^t z(s)ds$, and $w_j(t) = \int_0^t v_j(s)ds$ for $j = 1, \dots, p$. Let $\psi(t)$ be the solution of (4) with initial condition $\psi_0 \in \mathcal{H}$ associated with the controls $z(t), v_1(t), \dots, v_p(t)$ and set

$$y(t) = e^{-\omega(t)A}\psi(t).$$

For $\omega, v_1, \dots, v_p \in \mathbb{R}$ set $\Theta(\omega, v_1, \dots, v_p) = e^{-\omega A}(v_1 B_1 + \dots + v_p B_p)e^{\omega A}$, then $y(t)$ satisfies

$$\dot{y}(t) = \Theta(\omega(t), v_1(t), \dots, v_p(t))y(t). \quad (5)$$

Note that

$$\begin{aligned} \Theta(\omega, v_1, \dots, v_p)_{jk} &= \langle \phi_k, \Theta(\omega, v_1, \dots, v_p)\phi_j \rangle \\ &= e^{i(\lambda_k - \lambda_j)\omega} \left(v_1 b_{jk}^{(1)} + \dots + v_p b_{jk}^{(p)} \right). \end{aligned}$$

Notice that $|y(t)| = |\psi(t)|$, for every $t \in [0, T_v]$ and for every $(p+1)$ -uple of piecewise constant controls $z : [0, T_v] \rightarrow [1/\delta, +\infty)$, $v_1, \dots, v_p : [0, T_v] \rightarrow [0, 1]$.

D. Galerkin approximation

Definition 3.3: Let $N \in \mathbb{N}$. The Galerkin approximation of (5) of order N is the system in \mathcal{H}

$$\dot{x} = \Theta^{(N)}(\omega, v_1, \dots, v_p)x \quad (6)$$

where $\Theta^{(N)}(\omega, v_1, \dots, v_p) = \pi_N \Theta(\omega, v_1, \dots, v_p) \pi_N = (\Theta(\omega, v_1, \dots, v_p)_{jk})_{j,k=1}^N$.

E. First step: choice of the order of the Galerkin approximation

In order to prove approximate simultaneous controllability, we should take r in \mathbb{N} , ψ_1, \dots, ψ_r in \mathcal{H} , $\hat{\Upsilon}$ in $\mathbf{U}(\mathcal{H})$, and $\varepsilon > 0$ and prove the existence of a piecewise constant control $u : [0, T] \rightarrow U$ such that

$$\left\| \hat{\Upsilon}\psi_k - \Upsilon_T^u \psi_k \right\| < \varepsilon, \quad k = 1, \dots, r.$$

Notice that for n_0 large enough there exists $U \in SU(n_0)$ such that

$$|\langle \phi_j, \hat{\Upsilon}\psi_k \rangle - \langle \pi_{n_0} \phi_j, U \pi_{n_0} \psi_k \rangle| < \varepsilon$$

for every $1 \leq k \leq r$ and $j \in \mathbb{N}$. This simple fact suggest to prove approximate simultaneous controllability by studying the controllability of (6) in the Lie group $SU(n_0)$.

F. Second step: control in $SU(n)$

Let $n \geq n_0$ satisfy hypothesis (3). It follows from standard controllability results on compact Lie groups (see [14]) that for every $U \in SU(n)$ there exists a path $M : [0, T_v] \rightarrow \mathcal{M}_0^n$ such that

$$\overrightarrow{\exp} \int_0^{T_v} M(s) ds = U,$$

where the chronological notation $\overrightarrow{\exp} \int_0^t V_s ds$ is used for the flow from time 0 to t of the time-varying equation $\dot{q} = V_s(q)$ (see [1]). More precisely, there exists a finite partition in intervals $(I_k)_k$ of $[0, T_v]$ such that for every $t \in I_k$ either there exist $v_1, \dots, v_p \in [0, 1]$ and $\sigma \in \Sigma_N$ such that

$$M(t) = \pi_n B_\sigma^{(N)}(v_1, \dots, v_p) \pi_n,$$

or

$$M(t) = A^{(n)} - \frac{\text{tr}(A^{(n)})}{n} I_n.$$

In particular,

$$M(t)_{j,k} = 0, \quad \text{for every } t \in [0, T_v], j \leq n, k > n. \quad (7)$$

G. Third step: control of \mathcal{M}_N

Lemma 3.4: For every $N \in \mathbb{N}$, $\delta > 0$, and for every piecewise constant $v_1, \dots, v_p : [0, T_v] \rightarrow [0, 1]$ and $\sigma : [0, T_v] \rightarrow \Sigma_N$ there exists a sequence $(z_h(\cdot))_{h \in \mathbb{N}}$ of piecewise constant functions from $[0, T_v]$ to $[1/\delta, \infty)$, such that

$$\left\| \int_0^t \Theta^{(N)}(z_h(s), v_1, \dots, v_p) ds - \int_0^t B_{\sigma(s)}^{(N)}(v_1(s), \dots, v_p(s)) ds \right\| \rightarrow 0$$

uniformly with respect to $t \in [0, T_v]$ as h tends to infinity.

In other words, every piecewise constant path in \mathcal{M}_N can be approximately tracked by system (6).

Proof. Fix $N \in \mathbb{N}$. We are going to construct the control z_h by applying recursively Lemma 3.2. Consider an interval $[t_k, t_{k+1})$ in which $v_j(t)$, $j = 1, \dots, p$, and $\sigma(t)$ are constantly equal to $v_j \in [0, 1]$, $j = 1, \dots, p$, and $\sigma \in \Sigma_N$ respectively. Apply Lemma 3.2 with $\gamma_1 = \sigma$, $\{\gamma_2, \dots, \gamma_\kappa\} = \Sigma_N \setminus \{\sigma\}$, $R = T$ and $\tau_0 = \tau_0(k)$ to be fixed later depending on k . Then, for every $\eta > 0$, there exist $h = h(k) > 1/\eta$ and a sequence $(w_\alpha^k)_{\alpha=1}^h$ such that $w_1^k \geq t_0$, $w_\alpha^k - w_{\alpha-1}^k > R$, and such that

$$\left| \frac{1}{h} \sum_{\alpha=1}^h e^{i(\lambda_l - \lambda_m) w_\alpha^k} - \nu \frac{(v_1 \overline{B}_1^{(N)} + \dots + v_p \overline{B}_p^{(N)})_{l,m}}{(v_1 B_1^{(N)} + \dots + v_p B_p^{(N)})_{l,m}} \delta_{\sigma, |\lambda_l - \lambda_m|} \right| < \eta,$$

Set $\tau_\alpha^k = t_k + (t_{k+1} - t_k)\alpha/h$, $\alpha = 0, \dots, h$, and define the piecewise constant function

$$\omega_h(t) = \sum_{k \geq 0} \sum_{\alpha=1}^{h(k)} w_\alpha^k \chi_{[\tau_{\alpha-1}^k, \tau_\alpha^k)}(t). \quad (8)$$

Note that by choosing $\tau_0(k) = w_{h(k-1)}^{k-1} + R$ for $k \geq 1$ and $\tau_0(0) = R$ we have that $\omega_h(t)$ is non-decreasing.

Following the smoothing procedure of [7, Proposition 5.5] one can construct the desired sequence of control z_h . The idea is to approximate $\omega_h(t)$ by suitable piecewise linear functions with slope greater than $1/\delta$. Then z_h can be constructed from the derivatives of these functions. \square

As a consequence of last proposition by [1, Lemma 8.2] we have that

$$\left\| \overrightarrow{\exp} \int_0^t \Theta^{(N)}(z_h(s), v_1(s), \dots, v_p(s)) ds - \overrightarrow{\exp} \int_0^t B_{\sigma(s)}^{(N)}(v_1(s), \dots, v_p(s)) ds \right\| \rightarrow 0$$

uniformly with respect to $t \in [0, T_v]$ as h tends to infinity.

H. Fourth step: control of the infinite-dimensional system

Next proposition states that, roughly speaking, we can pass to the limit as N tends to infinity without losing the controllability property proved for the finite-dimensional case. Its proof can be found in [7, Proposition 5.6]. It is based on the particular form (7) of the operators involved, since the fact that the operator has several zero elements guarantees that the difference between the dynamics of the infinite-dimensional system and the dynamics of the Galerkin approximations is small.

Proposition 3.5: For every $\varepsilon > 0$, for every $\delta > 0$, and for every trajectory $U \in SU(n)$ there exist piecewise constant controls $u_j : [0, T_u] \rightarrow [0, \delta]$, $j = 1, \dots, p$ such that the associated propagator Υ^u of (2) satisfies

$$|\langle \pi_n \phi_j, U \pi_n \phi \rangle - \langle \phi_j, \Upsilon_{T_u}^u \phi \rangle| < \varepsilon$$

for every $\phi \in \text{span}\{\phi_1, \dots, \phi_n\}$ with $\|\phi\| = 1$ and for every j in \mathbb{N} .

We recall now a controllability result for the phases (see [7, Proposition 6.1 and Remark 6.3]). This property, stated in the proposition below, together with the controllability up to phases proved in the previous section, is sufficient to conclude the proof of Theorem 3.1.

Proposition 3.6: Assume that, for every $\hat{\Upsilon} \in \mathbf{U}(\mathcal{H})$, m in \mathbb{N} , $\delta > 0$, and $\varepsilon > 0$, there exist $T_u > 0$ and piecewise constant controls $u_j : [0, T_u] \rightarrow [0, \delta]$, $j = 1, \dots, p$ such that the associated propagator Υ^u of equation (2) satisfies

$$|\langle \phi_j, \hat{\Upsilon} \phi \rangle - \langle \phi_j, \Upsilon_{T_u}^u \phi \rangle| < \varepsilon,$$

for every $j \in \mathbb{N}$ and $\phi \in \text{span}\{\phi_1, \dots, \phi_m\}$ with $\|\phi\| = 1$. Then (2) is simultaneously approximately controllable.

IV. 3D MOLECULE

Let us go back to the system presented in the introduction for the orientation of a linear molecule,

$$i\hbar \dot{\psi} = -\Delta \psi + (u_1 \cos \theta + u_2 \cos \varphi \sin \theta + u_3 \sin \varphi \sin \theta) \psi, \quad (9)$$

where $\psi(t) \in \mathcal{H} = L^2(\mathbb{S}^2, \mathbb{C})$.

A basis of eigenvectors of the Laplace–Beltrami operator Δ is given by the spherical harmonics $Y_\ell^m(\theta, \varphi)$, which satisfy

$$\Delta Y_\ell^m(\theta, \varphi) = -\ell(\ell+1)Y_\ell^m(\theta, \varphi).$$

We are first going to prove that for every $\ell \in \mathbb{N}$ the system projected on the $(4\ell+4)$ -dimensional linear space

$$\mathcal{L} := \text{span}\{Y_\ell^{-\ell}, \dots, Y_\ell^\ell, Y_{\ell+1}^{-\ell-1}, \dots, Y_{\ell+1}^{\ell+1}\}$$

is controllable. More precisely, chosen a reordering $(\phi_k)_{k \in \mathbb{N}}$ of the spherical harmonics in such a way that

$$\{\phi_k \mid k = 1, \dots, 4\ell+4\} = \{Y_\ell^{-\ell}, \dots, Y_\ell^\ell, Y_{\ell+1}^{-\ell-1}, \dots, Y_{\ell+1}^{\ell+1}\},$$

we are going to prove that

$$\text{Lie}\mathcal{M}_0^{4\ell+4} = \mathfrak{su}(4\ell+4).$$

A. Matrix representations

Denote by J_ℓ the set of integer pairs $\{(j, k) \mid j = \ell, \ell+1, k = -j, \dots, j\}$. Consider an ordering $\omega : \{1, \dots, 4\ell+4\} \rightarrow J_\ell$. Let $e_{j,k}$ be the $(4\ell+4)$ -square matrix whose entries are all zero, but the one at line j and column k which is equal to 1. Define

$$E_{j,k} = e_{j,k} - e_{k,j}, \quad F_{j,k} = ie_{j,k} + ie_{k,j}, \quad D_{j,k} = ie_{j,j} - ie_{k,k}.$$

By a slight abuse of language, also set $e_{\omega(j), \omega(k)} = e_{j,k}$. The analogous identification can be used to define $E_{\omega(j), \omega(k)}, F_{\omega(j), \omega(k)}, D_{\omega(j), \omega(k)}$.

Thanks to this notation we can conveniently represent the matrices corresponding to the controlled vector field (projected on \mathcal{L}). A computation shows that the control potential in the z direction, $-i \cos \theta$, projected on \mathcal{L} , has a matrix representation with respect to the chosen basis

$$B_3 = \sum_{m=-\ell}^{\ell} p_{\ell,m} F_{(\ell,m), (\ell+1,m)}$$

with

$$p_{\ell,m} = -\sqrt{\frac{(\ell+1)^2 - m^2}{(2\ell+1)(2\ell+3)}}.$$

Similarly, we associate with the control potentials in the x and y directions, $-i \cos \varphi \sin \theta$ and $-i \sin \varphi \sin \theta$ respectively, the matrix representations

$$B_1 = \sum_{m=-\ell}^{\ell} (-q_{\ell,m} F_{(\ell,m), (\ell+1,m-1)} + q_{\ell,-m} F_{(\ell,m), (\ell+1,m+1)})$$

$$B_2 = \sum_{m=-\ell}^{\ell} (q_{\ell,m} E_{(\ell,m), (\ell+1,m-1)} + q_{\ell,-m} E_{(\ell,m), (\ell+1,m+1)}),$$

where

$$q_{\ell,m} = \sqrt{\frac{(\ell-m+2)(\ell-m+1)}{4(2\ell+1)(2\ell+3)}}.$$

The matrix representation of the Schrödinger operator $i\Delta$ is the diagonal matrix

$$\tilde{A} = \sum_{(j,k) \in J_\ell} \tilde{\alpha}_{(j,k)} e_{(j,k), (j,k)}$$

where

$$\tilde{\alpha}_{(j,k)} = -ij(j+1), \quad \text{for } (j,k) \in J_\ell.$$

Now consider $A = \tilde{A} - \frac{\text{tr}(\tilde{A})}{4(\ell+1)}I$, in such a way that $\text{tr}(A) = 0$. Hence, $A = \sum_{(j,k) \in J_\ell} \alpha_{(j,k)} e_{(j,k), (j,k)}$ where

$$\alpha_{(\ell,k)} = i \frac{2\ell+3}{2}, \quad \text{for } k = -\ell, \dots, \ell,$$

and

$$\alpha_{(\ell,k)} = -i \frac{2\ell+1}{2}, \quad \text{for } k = -\ell-1, \dots, \ell+1.$$

B. Useful bracket relations

From the identity

$$[e_{j,k}, e_{n,m}] = \delta_{kn} e_{j,m} - \delta_{jm} e_{n,k} \quad (10)$$

we get the relations $[E_{j,k}, E_{k,n}] = E_{j,n}$, $[F_{j,k}, F_{k,n}] = -E_{j,n}$, and $[E_{j,k}, F_{k,n}] = F_{j,n}$ and

$$[E_{j,k}, F_{j,k}] = 2D_{j,k}. \quad (11)$$

The relations above can be interpreted following a ‘‘triangle rule’’: the bracket between an operator coupling the states Y_ℓ^m and Y_k^n and an operator coupling the states Y_ℓ^m and $Y_{k'}^{n'}$ couples the states Y_k^n and $Y_{k'}^{n'}$. On the other hand, the bracket is zero if two operators couple no common states.

Moreover,

$$[A, E_{(\ell,k), (\ell+1,h)}] = 2(\ell+1)F_{(\ell,k), (\ell+1,h)}, \quad (12a)$$

$$[A, F_{(\ell,k), (\ell+1,h)}] = -2(\ell+1)E_{(\ell,k), (\ell+1,h)}. \quad (12b)$$

From (10) we find also that

$$[E_{(\ell,m), (\ell+1,m)}, E_{(\ell,m'), (\ell+1,m'-1)}] \neq 0$$

if and only if $m' = m$ or $m' = m+1$, with

$$[E_{(\ell,m), (\ell+1,m)}, E_{(\ell,m), (\ell+1,m-1)}] = E_{(\ell+1,m-1), (\ell+1,m)}$$

and

$$[E_{(\ell,m), (\ell+1,m)}, E_{(\ell,m+1), (\ell+1,m)}] = E_{(\ell,m), (\ell,m+1)}.$$

C. Controllability result

We prove the following result, which allows us to apply the abstract controllability criterium obtained in the previous section. We obtain then Theorem 1.1 as a corollary of Theorem 3.1. Notice that the conclusions of Theorem 3.1 allow us to claim more than the required approximately controllability, since simultaneous controllability is obtained as well.

Proposition 4.1: The Lie algebra L generated by A, B_1, B_2, B_3 is the whole algebra $\mathfrak{su}(4\ell+4)$.

Thanks to the matrix relations obtained in Section IV-B, the proof of the proposition can be easily reduced to the proof of the following lemma.

Lemma 4.2: The Lie algebra L contains the elementary matrices

$$E_{(\ell,k), (\ell+1,k+j)} \quad \text{for } k = -\ell, \dots, \ell, \quad j = -1, 0, 1.$$

Proof of Lemma 4.2. First, we want to prove that

$$\{E_{(\ell,-j),(\ell+1,-j)} + E_{(\ell,j),(\ell+1,j)} \mid j = 0, \dots, \ell\} \subset L. \quad (13)$$

We use the fact that

$$\text{ad}_{B_3}^{2j+1} A = (-1)^j (\ell + 1) 2^{2j+1} \sum_{m=-\ell}^{\ell} p_{\ell,m}^{2j+1} E_{(\ell,m),(\ell+1,m)}.$$

Indeed, for $j = 0$

$$\begin{aligned} [B_3, A] &= \sum_{\ell=-m}^m p_{\ell,m} [F_{(\ell,m),(\ell+1,m)}, A] \\ &= 2(\ell + 1) \sum_{\ell=-m}^m p_{\ell,m} E_{(\ell,m),(\ell+1,m)}, \end{aligned}$$

and, by induction, for $j \geq 1$,

$$\begin{aligned} \text{ad}_{B_3}^{2j+1} A &= [B_3, [B_3, \text{ad}_{B_3}^{2j-1} A]] \\ &= (-1)^{j-1} (\ell + 1) 2^{2j-1} \\ &\quad \sum_{m=-\ell}^{\ell} p_{\ell,m}^{2j-1} [B_3, [B_3, E_{(\ell,m),(\ell+1,m)}]] \\ &= (-1)^{j-1} (\ell + 1) 2^{2j-1} \sum_{m=-\ell}^{\ell} p_{\ell,m}^{2j-1} \\ &\quad [B_3, [\sum_{h=-\ell}^{\ell} p_{\ell,h} F_{(\ell,h),(\ell+1,h)}, E_{(\ell,m),(\ell+1,m)}]] \\ &= (-1)^{j-1} (\ell + 1) 2^{2j-1} \\ &\quad \sum_{m=-\ell}^{\ell} p_{\ell,m}^{2j-1} [B_3, -2p_{\ell,m} D_{(\ell,m),(\ell+1,m)}] \\ &= (-1)^j (\ell + 1) 2^{2j} \\ &\quad \sum_{m=-\ell}^{\ell} p_{\ell,m}^{2j} [\sum_{h=-\ell}^{\ell} p_{\ell,h} F_{(\ell,h),(\ell+1,h)}, D_{(\ell,m),(\ell+1,m)}] \\ &= (-1)^j (\ell + 1) 2^{2j+1} \sum_{m=-\ell}^{\ell} p_{\ell,m}^{2j+1} E_{(\ell,m),(\ell+1,m)}. \end{aligned}$$

Then (13) follows from the fact that $p_{\ell,m} \neq p_{\ell,n}$ for every $n \neq m, -m$.

Now note that

$$B_2 - [A, B_1]/(2(\ell + 1)) = 2 \sum_{m=-\ell}^{\ell} q_{\ell,-m} E_{(\ell,m),(\ell+1,m+1)}$$

and

$$B_2 + [A, B_1]/(2(\ell + 1)) = 2 \sum_{m=-\ell}^{\ell} q_{\ell,m} E_{(\ell,m),(\ell+1,m-1)}.$$

Moreover

$$\begin{aligned} &[[\sum_{m=-\ell}^{\ell} q_{\ell,m} E_{(\ell,m),(\ell+1,m-1)}, E_{(\ell,0),(\ell+1,0)}], E_{(\ell,0),(\ell+1,0)}] = \\ &= -q_{\ell,1} [E_{(\ell,0),(\ell,1)}, E_{(\ell,0),(\ell+1,0)}] \\ &\quad - q_{\ell,0} [E_{(\ell+1,-1),(\ell+1,0)}, E_{(\ell,0),(\ell+1,0)}] \\ &= q_{\ell,1} E_{(\ell,1),(\ell+1,0)} + q_{\ell,0} E_{(\ell,0),(\ell+1,-1)}. \end{aligned}$$

and, for $0 < k \leq \ell$,

$$\begin{aligned} &[[\sum_{j=k}^{\ell} q_{\ell,-j} E_{(\ell,-\ell),(\ell+1,-\ell-1)} + \\ &\quad \dots + q_{\ell,-k+1} E_{(\ell,-k+1),(\ell+1,-k)} + q_{\ell,k} E_{(\ell,k),(\ell+1,k-1)} + \\ &\quad \dots + q_{\ell,\ell} E_{(\ell,\ell),(\ell+1,\ell-1)}, E_{(\ell,-k),(\ell+1,-k)} + \\ &\quad E_{(\ell,k),(\ell+1,k)}], E_{(\ell,-k),(\ell+1,-k)} + E_{(\ell,k),(\ell+1,k)}] \\ &= -q_{\ell,-k+1} [E_{(\ell,-k),(\ell,-k+1)}, E_{(\ell,-k),(\ell+1,-k)}] \\ &\quad - q_{\ell,k} [E_{(\ell+1,k-1),(\ell+1,k)}, E_{(\ell,k),(\ell+1,k)}] \\ &= q_{\ell,-k+1} E_{(\ell,-k+1),(\ell+1,-k)} + q_{\ell,k} E_{(\ell,k),(\ell+1,k-1)}. \end{aligned}$$

Then we get $E_{(\ell,-\ell),(\ell+1,-\ell-1)}$, $E_{(\ell,-\ell+1),(\ell+1,-\ell)} + E_{(\ell,\ell),(\ell+1,\ell-1)}$, \dots , $E_{(\ell,0),(\ell+1,-1)} + E_{(\ell,1),(\ell+1,0)} \in L$. Similarly we can prove that the Lie algebra L contains $E_{(\ell,\ell),(\ell+1,\ell+1)}$.

Now, since $E_{(\ell,m),(\ell+1,m-1)} \in L$ and using the relation

$$\begin{aligned} &\text{ad}_{E_{(\ell,m),(\ell+1,m-1)}}^2 E_{(\ell,m),(\ell+1,m)} + E_{(\ell,-m),(\ell+1,-m)} = \\ &[E_{(\ell+1,m-1),(\ell+1,m)}, E_{(\ell,m),(\ell+1,m-1)}] = -E_{(\ell,m),(\ell+1,m)} \end{aligned}$$

we obtain that $E_{(\ell,m),(\ell+1,m)}$ and $E_{(\ell,-m),(\ell+1,-m)}$ belong to L for every $m = -\ell, \dots, -1$

Similarly, $E_{(\ell,m),(\ell+1,m)} \in L$ implies that $E_{(\ell,m+1),(\ell+1,m)}$ and $E_{(\ell,-m),(\ell+1,-m-1)}$ belong to L for every $m = -\ell, \dots, -1$ \square
