# DISPERSIVE LIMIT FROM THE KAWAHARA TO THE KDV EQUATION 

LUC MOLINET AND YUZHAO WANG


#### Abstract

We investigate the limit behavior of the solutions to the Kawahara equation $$
u_{t}+u_{3 x}+\varepsilon u_{5 x}+u u_{x}=0 \quad, \varepsilon>0
$$ as $\varepsilon \rightarrow 0$. In this equation, the terms $u_{3 x}$ and $\varepsilon u_{5 x}$ do compete together and do cancel each other at frequencies of order $1 / \sqrt{\varepsilon}$. This prohibits the use of a standard dispersive approach for this problem. Nervertheless, by combining different dispersive approaches according to the range of spaces frequencies, we succeed in proving that the solutions to this equation converges in $C\left([0, T] ; H^{1}(\mathbb{R})\right)$ towards the solutions of the KdV equation for any fixed $T>0$.


## 1. Introduction and main results

1.1. Introduction. In this paper we are interested in the limit behavior of the solutions to the Kawahara equation

u_{t}+u_{3 x}+\varepsilon u_{5 x}+u u_{x}=0, \quad(t, x) \in \mathbb{R}^{2}, \varepsilon>0
$$

as the positive coefficient $\varepsilon \rightarrow 0$.
Our goal is to prove that they converge in a strong sense towards the solutions of the KdV equation

This study can be seen as a peculiar case of the following class of limit behavior problems :

\partial_{t} u+\partial_{x}\left(L_{1}-\varepsilon L_{2}\right) u+N_{1}(u)+\varepsilon N_{2}(u)=0 \tag{1.2}
\end{equation*}

where $u: \mathbb{R} \rightarrow \mathbb{R}, L_{1}$ and $L_{2}$ are speudo-differential operators with Fourier symbols $|\xi|^{\alpha_{1}}$ and $|\xi|^{\alpha_{2}}$ with $0<\alpha_{1}<\alpha_{2}$ and $N_{1}$ and $N_{2}$ are polynomial functions that depends on $u$, its derivatives and possibly on the image of $u$ by some speudodifferential operator (as for instance the Hilbert transform) . Note that the dispersive limits from the Benjamin equation or some higher-order BO equations derived in [3] towards the Benjamin-Ono equation enter this class.

In this class of limit behavior problems, the main difficulty comes from the fact that the dispersive terms $\partial_{x} L_{1} u$ and $\varepsilon \partial_{x} L_{2} u$ do compete together. As one can easily check, the derivatives of the associated phase function $\phi(\xi)=\xi|\xi|^{\alpha_{1}}\left(1-\varepsilon|\xi|^{\alpha_{2}-\alpha_{1}}\right)$ does vanish at frequencies of order $\varepsilon^{-\frac{1}{\alpha_{2}-\alpha_{1}}}$. This will make classical dispersive estimates as Strichartz estimates, global Kato smoothing effect or maximal in time

[^0]estimate, not uniform in $\varepsilon$. Therefore it is not clear to get even boundedness uniformly in $\varepsilon$ of the solutions to (1.2) by classical dispersive resolution methods.

On the other hand, by using only energy estimates that do not take into account the dispersive terms, we can see immediately that the solutions to $\left(K_{\varepsilon}\right)$ will stay bounded in $H^{s}(\mathbb{R})$, uniformly in $\varepsilon$, providing we work in Sobolev spaces $H^{s}(\mathbb{R})$ with index $s>3 / 2$. Moreover, using for instance Bona-Smith argument, we could prove the convergence of the solution of $\left(K_{\varepsilon}\right)$ to the ones of (1.1) in $C\left([0, T] ; H^{s}(\mathbb{R})\right)$ with $T=T\left(\|u(0)\|_{H^{s}}\right.$ and $s>3 / 2$. However this approach is far to be satisfactory since it does not use at all the dispersive effects. Moreover, the KdV and Kawahara equations are known to be well-posed in low indices Sobolev spaces (see for instance [1], [8], [6] ) and one can ask wether such convergence result does hold in those spaces. In this work we make a first step in this direction by proving that this convergence result holds in $H^{s}(\mathbb{R})$ with $s \geq 1$. Note that $H^{1}(\mathbb{R})$ is a natural space for this problem since it is the energy space for the KdV equation. Our main idea is to combine different dispersive method according to the area of frequencies we consider. More precisely, we will use a Bourgain's approach (cf. [1], [4]) outside the area $D_{\varepsilon}$ where the first derivative of the phase function $\phi^{\prime}$ does vanish whereas we will use Koch-Tzvetkov approach (cf. [10]) in $D_{\varepsilon}$. Indeed, noticing that $\phi^{\prime \prime}$ does not vanish in this area, the Strichartz estimate are valid uniformly in $\varepsilon$ on $D_{\varepsilon}$ so that we can apply Koch-Tzvetkov approach. On the other hand, outside $D_{\varepsilon}$ one can easily see that one has a strong resonance relation at least for the worst interactions, namely the high-low interactions. Indeed, assuming that $\left|\xi_{1}\right| \gg\left|\xi_{2}\right|$, by the mean-value theroem, it holds
$\left|\phi_{\varepsilon}\left(\xi_{1}+\xi_{2}\right)-\phi_{\varepsilon}\left(\xi_{1}\right)-\phi_{\varepsilon}\left(\xi_{2}\right)\right| \sim\left|\phi_{\varepsilon}^{\prime}\left(\xi_{1}\right) \xi_{2}-\phi_{\varepsilon}\left(\xi_{2}\right)\right| \sim\left|\phi_{\varepsilon}^{\prime}\left(\xi_{1}\right) \xi_{2}\right| \sim\left|\xi^{2}\left(3-5 \varepsilon \xi^{2}\right) \xi_{2}\right| \gtrsim \xi^{2}\left|\xi_{2}\right|$,
where $\xi=\xi_{1}+\xi_{2}$ is the output frequency and $\phi_{\varepsilon}(\xi)=\xi^{3}-\varepsilon \xi^{5}$ is the phase function associated with the $\left(K_{\varepsilon}\right)$. It is worth noticing that this resonance relation is similar to the one of the KdV equation that reads $\left(\xi_{1}+\xi_{2}\right)^{3}-\left(\xi_{1}\right)^{3}-\left(\xi_{2}\right)^{3}=3 \xi \xi_{1} \xi_{2}$. To rely on this strong resonance relation even when one of the input frequency belongs to $D_{\varepsilon}$ we will make use of the fact that any $H^{1}$-solution to $\left(K_{\varepsilon}\right)$ must belong to some Bourgain's space with time regularity one.

### 1.2. Main results.

Theorem 1.1. Let $s \geq 1, \varphi \in H^{s}(\mathbb{R}), T>0$ and $\left\{\varepsilon_{n}\right\}_{n \in \mathbb{N}}$ be a decreasing sequence of real numbers converging to 0 . The sequence $u_{n} \in C\left(\mathbb{R} ; H^{s}(\mathbb{R})\right)$ of solutions to $\left(K_{\varepsilon}\right)$ emanating from $\varphi$ satisfies

u_{n} \rightarrow u \text { in } C\left([0, T] ; H^{s}(\mathbb{R})\right) \tag{1.3}
\end{equation*}

where $u \in C\left(\mathbb{R} ; H^{s}(\mathbb{R})\right)$ is the unique solution to the $K d V$ equation (1.1) emanating from $\varphi$.

Theorem 1 is actually a direct consequence of the fact that the Cauchy problem associated with $\left(K_{\varepsilon}\right)$ is well-posed in $H^{s}(\mathbb{R}), s \geq 1$, uniformly in $\left.\varepsilon \in\right] 0,1[$ in the following sense

Theorem 1.2. Let $s \geq 1$ and $\varphi \in H^{s}(\mathbb{R})$. There exists $\left.T=T\left(\|\varphi\|_{H^{1}}\right) \in\right] 0,1[$ and $C>0$ such that for any $\varepsilon \in] 0,1\left[\right.$ the solution $u_{\varepsilon} \in C\left(\mathbb{R} ; H^{1}(\mathbb{R})\right)$ to $\left(K_{\varepsilon}\right)$ satisfies

Moreover, for any $R>0$, the family of solution-maps $\left.S_{K_{\varepsilon}}: \varphi \mapsto u_{\varepsilon}, \varepsilon \in\right] 0,1[$, from $B(0, R)_{H^{s}}$ into $C\left([0, T(R)] ; H^{s}(\mathbb{R})\right)$ is equi-continuous, i.e. for any sequence $\left\{\varphi_{n}\right\} \subset B(0, R)_{H^{s}}$ converging to $\varphi$ in $H^{s}(\mathbb{R})$ it holds

1.3. Notation. For any positive numbers $a$ and $b$, the notation $a \lesssim b$ means that there exists a positive constant $c$ such that $a \leq c b$. We also denote $a \sim b$ when $a \lesssim b$ and $b \lesssim a$. Moreover, if $\alpha \in \mathbb{R}, \alpha_{+}$, respectively $\alpha_{-}$, will denote a number slightly greater, respectively lesser, than $\alpha$.

For $u=u(x, t) \in \mathcal{S}\left(\mathbb{R}^{2}\right), \mathcal{F} u=\widehat{u}$ will denote its space-time Fourier transform, whereas $\mathcal{F}_{x} u=(u)^{\wedge x}$, respectively $\mathcal{F}_{t} u=(u)^{\wedge t}$, will denote its Fourier transform in space, respectively in time. For $s \in \mathbb{R}$, we define the Bessel and Riesz potentials $J_{x}^{s}$ and $D_{x}^{s}$, by

We will need a Littlewood-Paley analysis. Let $\psi \in C_{0}^{\infty}(\mathbb{R})$ be an even function such that $\psi \geq 0, \operatorname{supp} \psi \subset[-3 / 2,3 / 2], \psi \equiv 1$ on $[-5 / 4,5 / 4]$. We set $\eta_{0}:=\psi$ and for all $k \in \mathbb{N}^{*}, \eta_{2^{k}}(\xi):=\psi\left(2^{-k} \xi\right)-\psi\left(2^{-k+1} \xi\right), \eta_{\leq 2^{k}}:=\psi\left(2^{-k}.\right)=\sum_{j=0}^{k} \eta_{2^{j}}$ and $\eta_{\geq 2^{k}}:=1-\psi\left(2^{k-1}\right.$. $)=1-\eta_{\leq 2^{k-1}}$. The Fourier multiplicator operators by $\eta_{2^{j}}, \eta_{\leq 2^{j}}$ and $\eta_{\geq 2^{j}}$ will be denoted respectively by $P_{2^{j}}, P_{\leq 2^{j}}$ and $P_{\geq 2^{j}}$, i.e. for any $u \in L^{\overline{2}}(\mathbb{R})$

Note that, to simplify the notations, any summations over capitalized variables such as $N$ are presumed to be dyadic with $N \geq 1$, i.e., these variables range over numbers of the form $2^{k}, k \in \mathbb{Z}_{+} . P_{+}$and $P_{-}$will denote the projection on respectively the positive and the negative Fourier frequencies.

Finally, we denote by $U_{\varepsilon}(t):=e^{-t\left(\partial_{x}^{3}+\varepsilon \partial_{x}^{5}\right)}$ the free evolution associated with the linear part of $\left(K_{\varepsilon}\right)$.
1.4. Function spaces. For $1 \leq p \leq \infty, L^{p}(\mathbb{R})$ is the usual Lebesgue space with the norm $\|\cdot\|_{L^{p}}$, and for $s \in \mathbb{R}$, the real-valued Sobolev spaces $H^{s}(\mathbb{R})$ denote the spaces of all real-valued functions with the usual norms

If $f=f(x, t)$ is a function defined for $x \in \mathbb{R}$ and $t$ in the time interval $[0, T]$, with $T>0$, if $B$ is one of the spaces defined above, $1 \leq p \leq \infty$ and $1 \leq q \leq \infty$, we will define the mixed space-time spaces $L_{T}^{p} B_{x}, L_{t}^{p} B_{x}, L_{x}^{q} L_{T}^{p}$ by the norms

For $s, b \in \mathbb{R}$, we introduce the Bourgain spaces $X_{\epsilon}^{s, b}$ related to the linear part of $\left(K_{\varepsilon}\right)$ as the completion of the Schwartz space $\mathcal{S}\left(\mathbb{R}^{2}\right)$ under the norm

where $\langle x\rangle:=1+|x|$. We will also use a dyadic version of those spaces introduced in [11] in the context of wave maps. For $s, b \in \mathbb{R}, 1 \leq q \leq \infty, X_{\epsilon}^{s, b, q}$ will denote the completion of the Schwartz space $\mathcal{S}\left(\mathbb{R}^{2}\right)$ under the norm

Moreover, we define a localized (in time) version of these spaces. Let $T>0$ be a positive time and $Y=X_{\epsilon}^{s, b}$ or $Y=X_{\epsilon}^{s, b, q}$. Then, if $\left.v: \mathbb{R} \times\right] 0, T[\rightarrow \mathbb{R}$, we have that

## 2. Uniform estimates far from the stationary point of the phase FUNCTION

As we explained in the introduction, it is crucial that the first and the second derivatives of the phase function $\phi_{\varepsilon}(\xi)=\xi^{3}-\varepsilon \xi^{5}$ do not cancel exactly at the same point. Indeed, $\phi_{\varepsilon}^{\prime}(\xi)=0 \Leftrightarrow|\xi|=\sqrt{\frac{3}{5 \varepsilon}}$ while , $\phi_{\varepsilon}^{\prime \prime}(\xi)=0 \Leftrightarrow|\xi|=\sqrt{\frac{3}{10 \varepsilon}}$. Consequently, we introduce the following smooth Fourier projectors

\widehat{P_{A_{\varepsilon}} f}=\left[1-\eta_{0}\left[20 \sqrt{\varepsilon}\left(|\xi|-\sqrt{\frac{3}{5 \varepsilon}}\right)\right]\right] \widehat{f}

and

\widehat{P_{B_{\varepsilon}} f}=\left[1-\eta_{0}\left[20 \sqrt{\varepsilon}\left(|\xi|-\sqrt{\frac{3}{10 \varepsilon}}\right)\right]\right] \widehat{f}

Clearly, $\widehat{P_{A_{\varepsilon}} f}$ cancels in a region of order $\varepsilon^{-1 / 2}$ around $\sqrt{\frac{3}{5 \varepsilon}}$ whereas $\widehat{P_{B_{\varepsilon}} f}$ cancels in a region of order $\varepsilon^{-1 / 2}$ around $\sqrt{\frac{3}{10 \varepsilon}}$. We are now in position to state the main proposition of this section :
Proposition 2.1. Let $s \geq 1,0<T<1$ and $u_{i, \varepsilon} \in C\left([0, T] ; H^{s}(\mathbb{R})\right)$, $i=1,2$, be two solutions to $\left(K_{\varepsilon}\right)$ with $0<\varepsilon \ll 1$ and initial data $\varphi_{i}$. Then it holds

\left\|P_{A_{\varepsilon}} u_{i, \varepsilon}\right\|_{X_{\varepsilon, T}^{s, 1 / 2,1}} \lesssim\left\|\varphi_{i}\right\|_{H^{s}}+T^{1 / 4}\left\|u_{i, \varepsilon}\right\|_{Y_{\varepsilon, T}^{s}}\left\|u_{i, \varepsilon}\right\|_{Y_{\varepsilon, T}^{1}}\left(1+\left\|u_{i, \varepsilon}\right\|_{Y_{\varepsilon, T}^{1}}\right) \tag{2.1}
\end{equation*}

and, setting $w=u_{1, \varepsilon}-u_{2, \varepsilon}$,

We will make a frequent use of the following linear estimates
Lemma 2.1. Let $\varphi \in S(\mathbb{R})$ and $T \in] 0,1]$ then $\forall 0<\varepsilon \ll 1$,

where $\mathcal{F}_{x}\left(P_{\mathrm{CA}_{\varepsilon}} \varphi\right)=\left(1-\eta_{A_{\varepsilon}}\right) \mathcal{F}_{x} \varphi$ and the implicit constants are independent of $\varepsilon>0$.

Proof. First, (2.4) follows from the classical proof of the local Kato smoothing effect, by using that $\left|\phi_{\varepsilon}^{\prime}(\xi)\right| \gtrsim|\xi|^{2}$ on the Fourier support of $P_{A_{\varepsilon}}$.

To prove (2.5), we first notice that the Fourier support of $P_{B_{\varepsilon}}$ does not intersect the region $\left\{\xi \in \mathbb{R},|\xi| \in\left[\sqrt{\frac{1}{4 \varepsilon}}, \sqrt{\frac{7}{20 \varepsilon}}\right]\right\}$. By the $T T^{*}$ argument it suffices to prove that

By classical arguments, (1.3) will be proven if we show

Setting $\theta:=\xi|t|^{1 / 3}$ this is equivalent to prove

We set $\Phi(\theta)=\Phi_{t, \varepsilon}(\theta):=\theta^{3}-\frac{\varepsilon}{|t|^{2 / 3}} \theta^{5}$ and notice that

\Phi^{\prime}(\theta):=3 \theta^{2}-\frac{5 \varepsilon}{|t|^{2 / 3}} \theta^{4} \text { and } \Phi^{\prime \prime}(\theta)=2 \theta\left(3-\frac{10 \varepsilon}{|t|^{2 / 3}} \theta^{2}\right)
$$

(2.8) is obvious when restricted on $|\theta| \leq 100$. Now, it is worth noticing that

whenever $\theta \in\left\{|z| \geq 100 /|z| \notin\left[\sqrt{\frac{|t|^{2 / 3}}{4 \varepsilon}}, \sqrt{\frac{7|t|^{2 / 3}}{20 \varepsilon}}\right]\right\}$. Therefore, in the region $|\theta| \in$ $\left[\sqrt{\frac{|t|^{2 / 3}}{10 \varepsilon}}, \sqrt{\frac{2|t|^{2 / 3}}{\varepsilon}}\right],(2.8)$ follows from Van der Corput lemma since $\left|\Phi^{\prime \prime}(\theta)\right| \gtrsim 1+\frac{|t|^{1 / 3}}{\sqrt{\varepsilon}}$ and $|\theta|^{1 / 2} \sim \frac{|t|^{1 / 6}}{\varepsilon^{1 / 4}}$. It thus remains to consider the region $|\theta| \notin\left[\sqrt{\frac{|t|^{2 / 3}}{10 \varepsilon}}, \sqrt{\frac{2|t|^{2 / 3}}{\varepsilon}}\right]$. We notice that, in this region, it holds

and divide this region into two subregions.

- The subregion $\left|\Phi^{\prime}(\theta)-X\right| \leq|X| / 2$. Then $\left|\Phi^{\prime}(\theta)\right| \sim|X|$. Assuming we are in the region $100<|\theta| \leq \sqrt{\frac{|t|^{2 / 3}}{10 \varepsilon}}$, we have $\left|\Phi^{\prime}(\theta)\right| \sim|\theta|^{2}$ and thus $|\theta| \sim \sqrt{|X|}$. Then (2.8) follows from Van der Corput lemma since $\left|\Phi^{\prime \prime}(\theta)\right| \gtrsim|\theta| \sim \sqrt{|X|}$. On the other hand, assuming that $|\theta| \geq \sqrt{\frac{2|t|^{2 / 3}}{\varepsilon}} \geq 100$ then $\left|\Phi^{\prime}(\theta)\right| \sim \varepsilon|\theta|^{4}|t|^{-2 / 3}$ and thus $|\theta| \sim \varepsilon^{-1 / 4}|X|^{1 / 4}|t|^{1 / 6}$. (2.8) follows again from Van der Corput lemma since $\left|\Phi^{\prime \prime}(\theta)\right| \gtrsim|\theta| \sim \varepsilon^{-1 / 4}|X|^{1 / 4}|t|^{1 / 6}$.
- The subregion $\left|\Phi^{\prime}(\theta)-X\right|>|X| / 2$. Then $\left|\Phi^{\prime}(\theta)-X\right| \sim\left|\Phi^{\prime}(\theta)\right|$ and (2.8) is obtained by integrating by parts and using (2.9). This completes the proof of (2.5).

Finally, to show (2.6) we notice that it suffices to prove that for $|x| \geq 10^{4}$,

To prove Proposition 2.1 we will have to put the whole solution $u_{\varepsilon}$ of $\left(K_{\varepsilon}\right)$ and not only $P_{A_{\varepsilon}} u_{\varepsilon}$ in some Bourgain's space with regularity 1 in time. This will be done in the next lemma by noticing that any solution to ( $K_{\varepsilon}$ ) that belongs to $C\left([0, T] ; H^{1}(\mathbb{R})\right)$ automatically belongs to $X_{\varepsilon, T}^{0,1}$.
Lemma 2.2. Let $s \geq 1, T \in] 0,1\left[\right.$ and $u \in C\left([0, T] ; H^{s}(\mathbb{R})\right)$ be a solution to ( $K_{\varepsilon}$ ). Then,

Proof. First, we consider $v(t)=U_{\varepsilon}(-t) u(t)$ on the time interval $\left.] 0, T\right]$ and extend $v$ on $]-2,2\left[\right.$ by setting $\partial_{t} v=0$ on $[-2,2] \backslash[0, T]$. Then, it is pretty clear that

Now, we define $\tilde{u}(x, t)=\eta(t) U(t) v(t)$. Obviously, $\tilde{u}$ is an extension of $u$ outside ] $-T, T[$ and it holds
$\|\tilde{u}\|_{X_{\varepsilon}^{s-1,1}} \lesssim\left\|\partial_{t} v\right\|_{L^{2}(]-2,2\left[; H_{x}^{s-1}\right)}+\|v\|_{L^{2}(]-2,2\left[; H_{x}^{s-1}\right)} \lesssim\left\|\partial_{t} v\right\|_{L_{T}^{2} H_{x}^{s-1}}+\|v\|_{L_{T}^{\infty} H_{x}^{s-1}}$.
Therefore (2.10) follows from the identity

together with the facts that $u$ is a solution to $\left(K_{\varepsilon}\right)$ and that

Now, according to the Duhamel formula and to classical linear estimates in Bourgain's spaces (cf. [1], [4]), Proposition 2.1 is a direct consequence of the following bilinear estimate

\end{equation*}

where the functions $u_{i}$ are supported in time in ] $-T, T$ [ with $0<T \leq 1$. To prove this bilinear estimate we first note that by symmetry it suffices to consider $\partial_{x} \Lambda(u, v)$ where $\Lambda(\cdot, \cdot)$ is defined by

We start by noticing that the case of ouput frequencies of order less or equal to one is harmless. Indeed, it is easy to check that for any couple $u_{i}, i=1,2$, of smooth functions supported in time in $]-T, T[$ with $0<T \leq 1$ it holds

Let us continue by deriving an estimate for the interactions of high frequencies with frequencies of order less or equal to 1 .

& \lesssim T^{\frac{1}{2}-}\left\|u_{1}\right\|_{X^{0,1}}^{2}\left\|P_{A_{\varepsilon}} u_{2}\right\|_{X^{1,1 / 2,1}}^{2} .

- $\left|\sigma_{2}\right| \geq 2^{-5}\left|\xi \xi_{1}\left(\xi-\xi_{1}\right)\right|$. This case can be treated exactly in the same way by exchanging the role of $u_{1}$ and $u_{2}$.
- $|\sigma| \geq 2^{-5}\left|\xi \xi_{1}\left(\xi-\xi_{1}\right)\right|$ and $\max \left(\left|\sigma_{1}\right|, \sigma_{2} \mid\right) \leq 2^{-5}\left|\xi \xi_{1}\left(\xi-\xi_{1}\right)\right|$.

Then we separate two subregions.

1. $\left|\xi_{1}\right| \geq 2^{-7}|\xi|$. Then $\left|\xi_{1}\right| \gtrsim\left|\xi_{\max }\right|$ and taking $\delta>0$ close enough to 0 we get

2.2.2 The subregion $\left|\xi_{1}\right| \wedge\left|\xi_{2}\right|>\sqrt{\frac{17}{80 \varepsilon}}$. In this subregion we claim that (2.19) holds. Indeed, on one hand, if $\xi_{1} \xi_{2} \geq 0$ then $\xi^{2}-\xi_{1} \xi_{2} \leq$ $\xi^{2} \leq \frac{2}{5 \varepsilon}$ and thus $\Gamma\left(\xi, \xi_{1}\right) \geq 1$. On the other hand, if $\xi_{1} \xi_{2} \leq$ 0 then, since $|\xi| \geq \sqrt{\frac{17}{80 \varepsilon}}$, we must have $\left|\xi_{1}\right| \vee\left|\xi_{2}\right| \geq 2 \sqrt{\frac{17}{80 \varepsilon}}$. Therefore, $\xi^{2}-\xi_{1} \xi_{2} \geq 3 \frac{17}{80 \varepsilon}$ and thus $\Gamma\left(\xi, \xi_{1}\right) \geq \frac{3}{16}$ which ensures that (2.19) holds and completes the proof of (2.12).

## 3. Uniform estimate close to the stationary point of the phase FUNCTION

As announced in the introduction, close the the stationary point of the phase function we will apply the approach developed by Koch and Tzvetkov in [10]. Note that, in [9], Kenig and Koenig improved this approach by adding the use of the nonlinear local Kato smoothing effect. However, this improvement can not be used here since this smoothing effect is not uniform in $\varepsilon$ close to the stationary point.

Proposition 3.1. Let $s \geq 1$ and $u_{\varepsilon} \in C\left([0, T] ; H^{s}(\mathbb{R})\right), i=1,2$, be a solution to $\left(K_{\varepsilon}\right)$ with initial data $\varphi$. Then it holds

First we establish an estimate, uniform in $\varepsilon$, on the solution to the associated non homogenous linear problem.

\left\|P_{\mathrm{C} A_{\varepsilon}} u\right\|_{L_{T}^{\infty} H_{x}^{s}}^{2} & \lesssim\left\|P_{\mathrm{C} A_{\varepsilon}} u_{0}\right\|_{H^{s}}^{2}+C\|u\|_{L_{T}^{\infty} H_{x}^{s}}^{2}\left(T^{1 / 4}\left\|P_{B_{\varepsilon}} P_{A_{\varepsilon}} u_{x}\right\|_{L_{T}^{4} L_{x}^{\infty}}+\left\|P_{\mathrm{C} A_{\varepsilon}} u_{x}\right\|_{L_{T}^{1} L_{x}^{\infty}}\right) \\
& \lesssim\left\|P_{\mathrm{C} A_{\varepsilon}} u_{0}\right\|_{H^{s}}^{2}+C\left(\varepsilon^{1 / 2}+T^{1 / 4}\right)\|u\|_{L_{T}^{\infty} H_{x}^{s}}^{2}\left(\|u\|_{Y_{\varepsilon, T}^{1}}+\|u\|_{Y_{\varepsilon, T}^{1}}^{2}\right),
\end{aligned}
$$

which completes the proof of (3.1).

## 4. Proof of Theorem 1.2

4.1. Uniform bound on the solutions. Let $u \in C^{\infty}\left(\mathbb{R} ; H^{\infty}(\mathbb{R})\right)$ be a solution of $\left(K_{\varepsilon}\right)$. Combining Propositions 2.1 and 3.1 we infer that for any $s \geq 1$ and $\left.T \in\right] 0,1[$,

\|u\|_{Y_{\varepsilon, T}^{s}}^{2} \leq C\|\varphi\|_{H^{s}}^{2}+C\left(\sqrt{\varepsilon}+T^{1 / 4}\right)\|u\|_{Y_{\varepsilon, T}^{s}}^{2}\|u\|_{Y_{\varepsilon, T}^{1}}\left(1+\|u\|_{Y_{\varepsilon, T}^{1}}^{3}\right)
$$

for some constant $C>0$. Since $u$ is smooth, $T \mapsto\|u\|_{Y_{\varepsilon, T}^{s}}$ is continuous and $\limsup _{T}\|u\|_{Y_{\varepsilon, T}^{s}} \lesssim\|\varphi\|_{H^{s}}$. Therefore a classical continuity argument ensures that for any $\delta>0$ there exists $\alpha>0$ such that

and $\|u\|_{Y_{\varepsilon, T}^{s}} \lesssim\|\varphi\|_{H^{s}}$ provided

By continuity with respect to initial data (for any fixed $\varepsilon>0$ ) it follows that for any fixed initial data $\varphi \in H^{s}(\mathbb{R}), s \geq 1$, the emanating solution $u \in C\left(\mathbb{R} ; H^{s}(\mathbb{R})\right)$ of $\left(K_{\varepsilon}\right)$, with

0<\varepsilon \leq \varepsilon_{0}\left(\|\varphi\|_{H^{1}}\right):=\frac{\alpha^{2}}{4}\left(\|\varphi\|_{H^{1}}+\|\varphi\|_{H^{1}}^{4}\right)^{-2} \tag{4.3}
\end{equation*}
$$

satisfies

\begin{equation*}
\|u\|_{Y_{\varepsilon, T}^{s}} \lesssim\|\varphi\|_{H^{s}} \tag{4.4}
\end{equation*}
$$

with $T=T\left(\|\varphi\|_{H^{1}}\right) \sim\left(\|\varphi\|_{H^{1}}+\|\varphi\|_{H^{1}}^{4}\right)^{-4}$.
Finally, the result for $\varepsilon \in\left[\varepsilon_{0}\left(\|\varphi\|_{H^{1}}\right), 1\right]$ follows from a dilation argument. Indeed, it is easy to check that $u$ is a solution of $\left(K_{\varepsilon}\right)$ with initial data $\varphi$ if and only if $u_{\lambda}=u_{\lambda}(t, x)=\lambda^{-2} u\left(\lambda^{-3} t, \lambda^{-1} x\right)$ is a solution of $\left(K_{\lambda^{2} \varepsilon}\right)$ with initial data $\varphi_{\lambda}=$ $\lambda^{-2} \varphi\left(\lambda^{-1} x\right)$. Hence, taking $\lambda=\varepsilon^{-1 / 2} \geq 1$ we observe that $u_{\lambda}$ satisfies $\left(K_{1}\right)$. By classical well-posedness result for ( $K_{1}$ ) (see for instance [6]), there exists a non increasing function $R: \mathbb{R}_{+}^{*} \rightarrow \mathbb{R}_{+}^{*}$ such that

Coming back to $u$, noticing that $\left\|\varphi_{\lambda}\right\|_{H^{1}} \lesssim \lambda^{-3 / 2}\|\varphi\|_{H^{1}}$ and that $1 \leq \lambda=\varepsilon^{-1 / 2} \lesssim$ $\left(\|\varphi\|_{H^{1}}+\|\varphi\|_{H^{1}}^{2}\right)$ we deduce that

\|u\|_{L_{T}^{\infty} H^{s}} \lesssim\|\varphi\|_{H^{s}} \text { with } T=T\left(\|\varphi\|_{H^{1}}\right),
$$

which completes the proof of (1.4).
4.2. Proof the equi-continuity result. Now to prove the equi-continuity result we will make use of Bona-Smith argument [2]. To simplify the expository we will only consider the most difficult case that is the case $s=1$. We thus want to prove that, be given a sequence $\left\{\varphi_{k}\right\} \subset H^{1}(\mathbb{R})$ converging towards $\varphi$ in $H^{1}(\mathbb{R})$, the emanating solutions $u_{\varepsilon, k}:=S_{K_{\varepsilon}}\left(\varphi_{k}\right)$ satisfy

\lim _{k \rightarrow \infty} \sup _{0<\varepsilon<1}\left\|u_{\varepsilon, k}-u_{\varepsilon}\right\|_{L_{T}^{\infty} H^{1}}=0 \tag{4.5}

where $u_{\varepsilon}:=S_{K_{\varepsilon}}(\varphi)$ and $T=T\left(\|\varphi\|_{H^{1}}\right)$. We first notice that we can restrict ourself to consider $\varepsilon$ satisfying (4.3) since the same dilation argument as above yields directly the result otherwise.

The first step consists in repeating the arguments of Sections $2 \& 3$ to get a $L^{2}$-Lipschitz bound, uniform in $\varepsilon$, for $H^{1}$-solution. This is the aim of the following proposition which proof is postponed in the appendix.

Proposition 4.1. Let $0<\varepsilon<1, T>0$ and $v \in Y_{\varepsilon, T}^{1}$ satisfying

Then any solution $w \in C\left([0, T] ; H^{1}(\mathbb{R})\right)$ to

satisfies

\|w\|_{L_{T}^{\infty} L_{x}^{2}} \lesssim\|w(0)\|_{L_{x}^{2}} \tag{4.9}
\end{equation*}
$$

where the implicit constant is independent of $\varepsilon$.
Now, for any $\varphi \in H^{1}(\mathbb{R})$ and any dyadic integer $N$ we set $\varphi^{N}:=P_{\leq N} \varphi$. By straightforward calculations in Fourier space, for any $\varphi \in H^{1}(\mathbb{R})$, any $N \geq 1$ and any $r \geq 0$,

Setting $u_{\varepsilon}^{N}:=S_{K_{\varepsilon}}\left(\varphi^{N}\right)$ and $u_{\varepsilon, k}^{N}:=S_{K_{\varepsilon}}\left(\varphi_{k}^{N}\right)$, (4.1) ensures that there exists $T_{0}=$ $\left.T_{0}\left(\|\varphi\|_{H^{1}}\right) \in\right] 0,1\left[\right.$ such that for $k$ large enough and $z:=u_{\varepsilon}, u_{\varepsilon}^{N}, u_{\varepsilon, k}$ or $u_{\varepsilon, k}^{N}$,

\left(\sqrt{\varepsilon}+T_{0}^{1 / 4}\right)\left(\|z\|_{Y_{\varepsilon, T_{0}}^{1}}+\|z\|_{Y_{\varepsilon, T_{0}}^{1}}^{4}\right) \ll 1 \tag{4.11}
\end{equation*}
$$

and, according to (4.4), (2.5) and (3.7),

\|z\|_{Y_{\varepsilon, T_{0}}^{1}} \leq 2\|\varphi\|_{H^{1}} \quad \text { and } \quad\left\|P_{B_{\varepsilon}} \partial_{x} z\right\|_{L_{T_{0}}^{1} L_{x}^{\infty}} \lesssim\left(\sqrt{\varepsilon}+T_{0}^{1 / 4}\right)\left(\|z\|_{Y_{\varepsilon, T_{0}}^{1}}+\|z\|_{Y_{\varepsilon, T_{0}}^{1}}^{2}\right) . \tag{4.12}
\end{equation*}
$$

Moreover,

\begin{equation*}
\left\|u_{\varepsilon}^{N}\right\|_{Y_{\varepsilon, T_{0}}^{s}}+\left\|u_{\varepsilon, k}^{N}\right\|_{Y_{\varepsilon, T_{0}}^{s}} \lesssim\left\|\varphi^{N}\right\|_{H^{s}} \lesssim N^{s-1}\|\varphi\|_{H^{1}} \tag{4.13}
\end{equation*}
$$

provided $s \geq 1$. By the triangle inequality, it holds
(4.14) $\left\|u_{\varepsilon}-u_{\varepsilon, k}\right\|_{L_{T}^{\infty} H_{x}^{1}} \leq\left\|u_{\varepsilon}-u_{\varepsilon}^{N}\right\|_{L_{T}^{\infty} H_{x}^{1}}+\left\|u_{\varepsilon}^{N}-u_{\varepsilon, k}^{N}\right\|_{L_{T}^{\infty} H_{x}^{1}}+\left\|u_{\varepsilon, k}^{N}-u_{\varepsilon, k}\right\|_{L_{T}^{\infty} H_{x}^{1}}$.

We start by estimating the first term of the right-hand side fo (4.14). Setting $w_{\varepsilon}:=u_{\varepsilon}-u_{\varepsilon}^{N}$, we observe that $w_{\varepsilon}$ satisfies

\end{equation*}

Therefore, combining Proposition 4.1, (4.11)-(4.12) and (4.10) we get that

According to (2.2) we also have

\left\|P_{A_{\varepsilon}} w_{\varepsilon}\right\|_{X_{\varepsilon, T_{0}}^{1,1 / 2,1}} \leq C\left\|\varphi-\varphi^{N}\right\|_{H_{x}^{1}}+\frac{1}{2}\left\|w_{\varepsilon}\right\|_{Y_{\varepsilon, T_{0}}^{1}} \tag{4.17}
\end{equation*}
$$

Now to estimate $P_{\text {CA }}$ we rewrite the equation satisfying by $w_{\varepsilon}$ in the following less symmetric way :

Applying the operator $P_{\text {CA }}$ on the above equation and taking the $H^{1}$-scalar product with $P_{C_{A_{\varepsilon}}} w_{\varepsilon}$ we get

\frac{d}{d t}\left\|P_{\mathrm{C} A_{\varepsilon}} w_{\varepsilon}(t)\right\|_{H_{x}^{1}}^{2}= & \int_{\mathbb{R}} J_{x}^{1} P_{\mathrm{C} A_{\varepsilon}} \partial_{x}\left(w_{\varepsilon}^{2}\right) J_{x}^{1} P_{\mathrm{C} A_{\varepsilon}} w_{\varepsilon}+2 \int_{\mathbb{R}} J_{x}^{1} P_{\mathrm{C} A_{\varepsilon}}\left(u_{\varepsilon}^{N} \partial_{x} w_{\varepsilon}\right) J_{x}^{1} P_{\mathrm{C} A_{\varepsilon}} w_{\varepsilon} \\
& +2 \int_{\mathbb{R}} J_{x}^{1} P_{\mathrm{C} A_{\varepsilon}}\left(w_{\varepsilon} \partial_{x} u_{\varepsilon}^{N}\right) J_{x}^{1} P_{\mathrm{C} A_{\varepsilon}} w_{\varepsilon} \tag{4.18}
\end{align*}
$$

The contribution of the first term of the above right-hand side can be estimated in exactly the same way as in the proof of Lemma 3.2 by $\left\|P_{B_{\varepsilon}} \partial_{x} w_{\varepsilon}\right\|_{L_{x}^{\infty}}\left\|w_{\varepsilon}\right\|_{H_{x}^{1}}^{2}$. The second term can be estimated also in the same way by

The difficulty comes from the third term. To estimate its contribution we first decompose $w_{\varepsilon}$ and $u_{\varepsilon}^{N}$ to rewrite it as

2 \int_{\mathbb{R}} J_{x}^{1} P_{\mathrm{C} A_{\varepsilon}}\left(P_{\mathrm{C} B_{\varepsilon}} w_{\varepsilon} P_{\mathrm{C} B_{\varepsilon}} \partial_{x} u_{\varepsilon}^{N}+P_{\mathrm{C} B_{\varepsilon}} w_{\varepsilon} P_{B_{\varepsilon}} \partial_{x} u_{\varepsilon}^{N}+P_{B_{\varepsilon}} w_{\varepsilon} P_{\mathrm{C} B_{\varepsilon}} \partial_{x} u_{\varepsilon}^{N}\right) J_{x}^{1} P_{\mathrm{C} A_{\varepsilon}} w_{\varepsilon} \\
+2 \int_{\mathbb{R}} J_{x}^{1} P_{\mathrm{C} A_{\varepsilon}}\left(P_{B_{\varepsilon}} w_{\varepsilon} P_{B_{\varepsilon}} \partial_{x} u_{\varepsilon}^{N}\right) J_{x}^{1} P_{\mathrm{C} A_{\varepsilon}} w_{\varepsilon}=I_{1}+I_{2}
\end{gathered}
$$

According to the frequency projections, in the same way as proof of Lemma 3.2, all the functions in $I_{1}$ are supported in frequencies of order $\varepsilon^{-1 / 2}$, which leads to

Finally we control the contribution of $I_{2}$ by

I_{2} \lesssim\left\|P_{\mathrm{CA}_{\varepsilon}} \partial_{x} w_{\varepsilon}\right\|_{L_{x}^{\infty}}\left(\left\|w_{\varepsilon}\right\|_{H^{1}}\left\|u_{\varepsilon}^{N}\right\|_{H_{x}^{1}}+\left\|w_{\varepsilon}\right\|_{L^{2}}\left\|u_{\varepsilon}^{N}\right\|_{H^{2}}\right)
$$

Note that the difficulty to control $I_{2}$ comes from the fact that we can not avoid to put a $H^{2}$-norm on $u_{\varepsilon}^{N}$. But the idea of Bona-Smith is to compensate the growth with $N$ of this $H^{2}$-norm by the decay with $N$ of the $L^{2}$-norm of $w_{\varepsilon}$. Actually, integrating (4.18) in time, with the above estimates together with (4.16) and (4.12)(4.13) in hand, we get

&+\left\|P_{B_{\varepsilon}} \partial_{x} w_{\varepsilon}\right\|_{L_{T_{0}}^{1} L_{x}^{\infty}}\left(\left\|w_{\varepsilon}\right\|_{L_{T_{0}}^{\infty} H_{x}^{1}}\left\|u_{\varepsilon}^{N}\right\|_{L_{T_{0}}^{\infty} H_{x}^{1}}+\left\|w_{\varepsilon}\right\|_{L_{T_{0}}^{\infty} L_{x}^{2}}\left\|u_{\varepsilon}^{N}\right\|_{L_{T_{0}}^{\infty} H_{x}^{2}}\right) \\
& \leq \gamma_{1}(N)+\frac{1}{8}\left\|w_{\varepsilon}\right\|_{L_{T_{0}}^{\infty} H_{x}^{1}}^{2}+2\|\varphi\|_{H_{x}^{1}}\left\|P_{B_{\varepsilon}} \partial_{x} w_{\varepsilon}\right\|_{L_{T_{0}}^{1} L_{x}^{\infty}}\left\|w_{\varepsilon}\right\|_{L_{T_{0}}^{\infty} H_{x}^{1}} \\
&(4.19) \quad+o\left(N^{-1}\right) N \tag{4.19}
\end{align*}
$$

where $\gamma_{1}(N) \rightarrow 0$ as $N \rightarrow \infty$. On the other hand, applying Lemma 3.1 on the $x$-derivative of (4.15) we get

Therefore, gathering (4.19), (4.20) and (4.17) with (4.11) in hand, we obtain

To estimate the contribution of the third term of the right-hand side of (4.14) we proceed exactly in the same way as for the first one, by replacing $u_{\varepsilon}$ by $u_{\varepsilon, k}$ and $u_{\varepsilon}^{N}$ by $u_{\varepsilon, k}^{N}$. We then obtain

Finally, the contribution of the second term of the right-hand side of (4.14) is also obtain in the same way by replacing $u_{\varepsilon}$ by $u_{\varepsilon, k}^{N}$ (actually, contrary to the preceding contributions, here both terms $u_{\varepsilon, k}^{N}$ and $u_{\varepsilon}^{N}$ can play a symmetric role ). However, for this term, Proposition 4.1 only ensures that

Therefore, setting $w_{\varepsilon}=u_{\varepsilon}^{N}-u_{\varepsilon, k}^{N}$, one has to replace $o\left(N^{-1}\right) N$ by $\left\|\varphi-\varphi_{k}\right\|_{L_{x}^{2}} N$ in the right-hand side member of (4.19) when estimating $\left\|P_{C A_{\varepsilon}}\left(u_{\varepsilon}^{N}-u_{\varepsilon, k}^{N}\right)\right\|_{L_{T_{0}}^{\infty} H_{x}^{1}}$. We thus obtain

$$
\left\|u_{\varepsilon}^{N}-u_{\varepsilon, k}^{N}\right\|_{L_{T_{0}}^{\infty} H_{x}^{1}} \lesssim\left\|\varphi-\varphi_{k}\right\|_{H_{x}^{1}}+N\left\|\varphi-\varphi_{k}\right\|_{L_{x}^{2}}
$$

Gathering the above estimates, (4.14) leads to

\lim _{k \rightarrow+\infty} \sup _{0<\varepsilon<\varepsilon_{0}\left(\|\varphi\|_{H^{1}}\right)}\left\|u_{\varepsilon}-u_{\varepsilon, k}\right\|_{L_{T_{0}}^{\infty} H_{x}^{1}}=0
$$

which completes the proof of Theorem 1.2.
4.3. Proof of Theorem 1.1. We follow general arguments (see for instance [5]). Let us denote by $S_{K_{\varepsilon}}$ and $S_{K d V}$ the nonlinear group associated with respectively $\left(K_{\varepsilon}\right)$ and $\operatorname{KdV}$. Let $\varphi \in H_{x}^{s}(\mathbb{R}), s \geq 1$ and let $T=T\left(\|\varphi\|_{H_{x}^{1}}\right)>0$ be given by Theorem 1.1. For any $N>0$ we can rewrite $S_{K_{\varepsilon}}(\varphi)-S_{K d V}(\varphi)$ as

S_{K_{\varepsilon}}(\varphi)-S_{K d V}(\varphi)= & \left(S_{K_{\varepsilon}}(\varphi)-S_{K_{\varepsilon}}\left(P_{\leq N} \varphi\right)\right)+\left(S_{K_{\varepsilon}}\left(P_{\leq N} \varphi\right)-S_{K d V}\left(P_{\leq N} \varphi\right)\right) \\
& +\left(S_{K d V}\left(P_{\leq N} \varphi\right)-S_{K d V}(\varphi)\right)=I_{\varepsilon, N}+J_{\varepsilon, N}+K_{N}
\end{aligned}
$$

By continuity with respect to initial data in $H^{s}(\mathbb{R})$ of the solution map associated with the KdV equation, we have $\lim _{N \rightarrow \infty}\left\|K_{N}\right\|_{L^{\infty}\left(0, T ; H_{x}^{s}\right)}=0$. On the other hand, (1.5) ensures that

$$
\lim _{N \rightarrow \infty} \sup _{\varepsilon \in] 0,1[ }\left\|I_{\varepsilon, N}\right\|_{L^{\infty}\left(0, T ; H_{x}^{s}\right)}=0
$$

It thus remains to check that for any fixed $N>0, \lim _{\varepsilon \rightarrow 0}\left\|J_{\varepsilon, N}\right\|_{L^{\infty}\left(0, T ; H_{x}^{s}\right)}=0$. Since $P_{\leq N} \varphi \in H^{\infty}(\mathbb{R})$, it is worth noticing that $S_{K_{\varepsilon}}\left(P_{\leq N} \varphi\right)$ and $S_{K d V}\left(P_{\leq N} \varphi\right)$ belong to $C^{\infty}\left(\mathbb{R} ; H^{\infty}(\mathbb{R})\right)$. Moreover, according to Theorem 1.2 and the well-posedness theory of the KdV equation (see for instance [1]), for all $\theta \in \mathbb{R}$ and $\varepsilon \in] 0,1[$,

\left\|S_{K_{\varepsilon}}\left(P_{\leq N} \varphi\right)\right\|_{L_{T}^{\infty} H_{x}^{\theta}}+\left\|S_{K d V}\left(P_{\leq N} \varphi\right)\right\|_{L_{T}^{\infty} H_{x}^{\theta}} \leq C\left(N, \theta,\|\varphi\|_{L_{x}^{2}}\right)
$$

Now, setting $v_{\varepsilon}:=S_{K_{\varepsilon}}\left(P_{\leq N} \varphi\right)$ and $v:=S_{K d V}\left(P_{\leq N} \varphi\right)$, we observe that $w_{\varepsilon}:=$ $v_{\varepsilon}-v$ satisfies

\partial_{t} w_{\varepsilon}+\partial_{x}^{3} w_{\varepsilon}+\varepsilon \partial_{x}^{5} w_{\varepsilon}=-\frac{1}{2} \partial_{x}\left(w_{\varepsilon}\left(v+v_{\varepsilon}\right)\right)-\varepsilon v_{5 x}
$$

with initial data $w_{\varepsilon}(0)=0$. Taking the $H^{s}$-scalar product of this last equation with $w_{\varepsilon}$ and integrating by parts we get

$$
\frac{d}{d t}\left\|w_{\varepsilon}\right\|_{H_{x}^{s}} \lesssim\left(1+\left\|\partial_{x}\left(v+v_{\varepsilon}\right)\right\|_{L_{x}^{\infty}}\right)\left\|w_{\varepsilon}\right\|_{H_{x}^{s}}^{2}+\left\|\left[J^{s},\left(v+v_{\varepsilon}\right)\right] \partial_{x} w_{\varepsilon}\right\|_{L^{2}}\left\|w_{\varepsilon}\right\|_{H_{x}^{s}}+\varepsilon^{2}\left\|v_{5 x}\right\|_{H_{x}^{s}}^{2}
$$

Making use of the following commutator estimate (see for instance [12]), that holds for $s>1 / 2$,

$$
\begin{equation*}
\left\|\left[J_{x}^{s}, f\right] g\right\|_{L_{x}^{2}} \lesssim\left\|f_{x}\right\|_{H_{x}^{s}}\|g\|_{H_{x}^{s-1}} \tag{4.21}
\end{equation*}
$$

we easily get

$$
\frac{d}{d t}\left\|w_{\varepsilon}(t)\right\|_{H_{x}^{s}}^{2} \lesssim C\left(N, s+1,\|\varphi\|_{L_{x}^{2}}\right)\left\|w_{\varepsilon}(t)\right\|_{H_{x}^{s}}^{2}+\varepsilon^{2} C\left(N, 5+s,\|\varphi\|_{L_{x}^{2}}\right)^{2}
$$

Integrating this differential inequality on $[0, T]$, this ensures that $\lim _{\varepsilon \rightarrow 0}\left\|w_{\varepsilon}\right\|_{L^{\infty}\left(0, T ; H^{s}\right)}=$ 0 and completes the proof of Theorem 1.1 with $T=T\left(\|\varphi\|_{H^{1}}\right)$. Finally, recalling that the energy conservation of the KdV equation ensures that for any $\varphi \in H^{1}(\mathbb{R})$ it holds,

\sup _{t \in \mathbb{R}}\left\|S_{K d V}(\varphi)(t)\right\|_{H_{x}^{1}} \lesssim\|\varphi\|_{H_{x}^{1}}+\|\varphi\|_{L_{x}^{2}}^{5}

we obtain the same convergence result on any time interval $\left[0, T_{0}\right]$ with $T_{0}>$ $T\left(\|\varphi\|_{H_{x}^{1}}\right)$ by reiterating the convergence result about $T_{0} / T\left(\|\varphi\|_{H_{x}^{1}}+\|\varphi\|_{L_{x}^{2}}^{5}\right)$ times.

## 5. appendix: Proof of Proposition 4.1

We follow very closely Sections 2 and 3 . The first step consists in establishing the following estimate on $P_{A_{\varepsilon}} w$.
Proposition 5.1. Let $0<T<1$ and $w \in C\left([0, T] ; H^{1}(\mathbb{R})\right)$ be a solution to (4.8) with $0<\varepsilon \ll 1$ and initial data $\varphi$. Then it holds

& \lesssim T^{1 / 2}\left(\left\|v_{x}\right\|_{L_{t}^{\infty} L_{x}^{2}}\left\|P_{\leq 8} w\right\|_{L_{t x}^{\infty}}+\|v\|_{L_{t x}^{\infty}}\|w\|_{L_{t}^{\infty} L_{x}^{2}}\right) \\
& \lesssim T^{1 / 2}\|v\|_{L_{t}^{\infty} H_{x}^{1}}\|w\|_{L_{t}^{\infty} L_{x}^{2}} . \tag{5.3}
\end{align*}
$$

Now to control $\left\|P_{A_{\varepsilon}} \partial_{x}\left(w P_{\leq 8} v\right)\right\|_{X^{0,-1 / 2,1}}$ we notice that in the same way as in (5.3) we have

& \lesssim\left\|\partial_{x} P_{A_{\varepsilon}} \Lambda\left(P_{\leq 8} \mathcal{F}_{x t}^{-1}(|\widehat{v}|), \partial_{x}^{-1} P_{\geq 16} \mathcal{F}_{x t}^{-1}(|\widehat{w}|)\right)\right\|_{X_{\varepsilon}^{1,-1 / 2,1}} \\
& \lesssim\|v\|_{X_{\varepsilon}^{0,1}}\left(T^{1 / 4}\left(\left\|P_{A_{\varepsilon}} w\right\|_{X_{\varepsilon}^{0,1 / 2,1}}+\|w\|_{X_{\varepsilon}^{-1,1}}\right)+\|w\|_{L_{t x}^{2}}\right)
\end{aligned}
$$

To continue we need the following variant of Lemma 2.4.
Lemma 5.1. Let $v$ and $w$ be two smooth functions supported in time in ] - T, T[ with $0<T \leq 1$. Then, in the region where the strong resonance relation (2.19) holds, we have

Proof. We notice that the norms in the right-hand side of (2.4) only see the size of the modulus of the Fourier transforms. We can thus assume that all our functions have non-negative Fourier transforms. We set $I:=\left\|\partial_{x} P_{A_{\varepsilon}} P_{\geq 8}\left(P_{\geq 8} v P_{\geq 8} w\right)\right\|_{X_{\varepsilon}^{0,-1 / 2,1}}$ and separate different subregions .

- $\left|\sigma_{1}\right| \geq 2^{-5}\left|\xi \xi_{1}\left(\xi-\xi_{1}\right)\right|$. Then, by (2.5) of Lemma 2.1 and duality, we get

& \lesssim T^{\frac{1}{4}-}\|v\|_{X_{\varepsilon}^{0,1}}\left\|P_{\geq 8} D_{x}^{-1} w\right\|_{L_{t}^{\infty} L_{x}^{2+}} \\
& \lesssim T^{\frac{1}{4}-}\|v\|_{X_{\varepsilon}^{0,1}}\|w\|_{X_{\varepsilon}^{-3 / 4,3 / 4}} \\
& \lesssim T^{\frac{1}{4}-}\|v\|_{X_{\varepsilon}^{0,1}}\left(\|w\|_{X_{\varepsilon}^{-1,1}}+\|w\|_{L_{t x}^{2}}\right) .
\end{aligned}
$$

- $|\sigma| \geq 2^{-5}\left|\xi \xi_{1}\left(\xi-\xi_{1}\right)\right|$ and $\max \left(\left|\sigma_{1}\right|, \sigma_{2} \mid\right) \leq 2^{-5}\left|\xi \xi_{1}\left(\xi-\xi_{1}\right)\right|$.

Then we separate two subregions.

& \lesssim\|v\|_{X_{E}^{1 / 4,3 / 4}\|w\|_{L_{x x}^{2}}} \\
& \lesssim\left(\|v\|_{X_{e}^{0,1}}^{0,}+\left\|\partial_{x} v\right\|_{L_{t x}^{2}}\right)\|w\|_{L_{t x}^{2}}
\end{aligned}

2. $\left|\xi_{1}\right| \wedge\left|\xi_{2}\right|<2^{-7}|\xi|$. Then, we use that (2.21) holds on the support of $\eta_{A_{\varepsilon}}$. In the subregion $\left|\xi_{1}\right| \wedge\left|\xi_{2}\right|=\left|\xi_{1}\right|$ we write

& \lesssim \sum_{N \geq 4}\left(\sum_{4 \leq N_{1} \leq 2^{-5} N}\left\|P_{N_{1}} D_{x}^{-1 / 2} v\right\|_{L_{t x}^{\infty}}\left\|\chi_{\{|\xi| \sim N\}} \widehat{w}\right\|_{L_{\tau, \xi}^{2}}\right)^{2} \\
& \lesssim \sum_{N \geq 4}\left\|\chi_{\{|\xi| \sim N\}} \widehat{w}\right\|_{L_{\tau, \xi}^{2}}^{2}\left(\sum_{4 \leq N_{1} \leq 2^{-5} N} N_{1}^{-1 / 4}\left\|P_{N_{1}} D_{x}^{1 / 4} v\right\|_{L_{t}^{\infty} L_{x}^{2}}\right)^{2} \\
& \lesssim\|v\|_{X^{1 / 4,3 / 4}}^{2}\|w\|_{L_{t x}^{2}}^{2} \\
& \lesssim\left(\|v\|_{X^{0,1}}+\left\|\partial_{x} v\right\|_{L_{t x}^{2}}\right)^{2}\|w\|_{L_{t x}^{2}}^{2} .
\end{aligned}

Finally, in the subregion $\left|\xi_{1}\right| \wedge\left|\xi_{2}\right|=\left|\xi_{2}\right|$ we write

I^{2} & \lesssim \sum_{N \geq 4}\left(\sum_{4 \leq N_{2} \leq 2^{-5} N}\left\|\eta_{N}(\xi) \eta_{A_{\varepsilon}}(\xi)|\xi| \chi_{\left\{|\sigma| \sim \max \left(N_{2} N^{2}, \varepsilon N^{4} N_{2}\right)\right\}} \mathcal{F}_{x}\left(\left(v P_{N_{2}} w\right)\right)\right\|_{X_{\varepsilon}^{0,-1 / 2,1}}\right)^{2} \\
& \lesssim \sum_{N \geq 4}\left(\sum_{4 \leq N_{2} \leq 2^{-5} N}\left\|P_{N_{1}} D_{x}^{-3 / 2} w\right\|_{L_{t x}^{\infty}}\left\|\chi_{\{|\xi| \sim N\}} \xi \widehat{v}\right\|_{L_{\tau, \xi}^{2}}\right)^{2} \\
& \lesssim \sum_{N \geq 4}\left\|\chi_{\{|\xi| \sim N\}} \xi \widehat{v}\right\|_{L_{\tau, \xi}^{2}}^{2}\left(\sum_{4 \leq N_{2} \leq 2^{-5} N} N_{2}^{-1 / 4}\left\|P_{N_{2}} D_{x}^{-3 / 4} w\right\|_{L_{t}^{\infty} L_{x}^{2}}\right)^{2} \\
& \lesssim\|w\|_{X_{\varepsilon}^{-3 / 4,3 / 4}}^{2}\left\|\partial_{x} v\right\|_{L_{t x}^{2}}^{2} \\
& \lesssim\left(\|w\|_{X_{\varepsilon}^{-1,1}}+\|w\|_{L_{t x}^{2}}^{2}\right)^{2}\left\|\partial_{x} v\right\|_{L_{t x}^{2}}^{2} .
\end{aligned}

Now we are in position to prove the main bilinear estimates :

where $J_{\varepsilon}$ is defined in (2.22). We consider different contributions to $I$.

and it is easy to check that $\Gamma\left(\xi, \xi_{1}\right) \geq 2^{-5}$ as soon as $|\xi| \notin J_{\varepsilon}$. According to (2.13) this ensures that (2.19) holds.
2. $N_{1} \wedge N_{2} \geq 2^{-10}\left(N_{1} \vee N_{2}\right)$. Then $N_{1} \sim N_{2} \gtrsim N$.
2.1. The subregion $|\xi| \notin\left[\sqrt{\frac{17}{80 \varepsilon}}, \sqrt{\frac{2}{5 \varepsilon}}\right]$. In this region, by (2.5) of Lemma 2.1 and duality, we get

& \lesssim T^{\frac{3}{4}-}\|v\|_{L_{t}^{\infty} H^{1}}\|w\|_{L_{t}^{\infty} L_{x}^{2}} .

2.2.1 The subregion $\left|\xi_{1}\right| \wedge\left|\xi_{2}\right| \leq \sqrt{\frac{17}{80 \varepsilon}}$. Since both cases can be treated in the same way, we assume $\left|\xi_{1}\right| \wedge\left|\xi_{2}\right|=\left|\xi_{1}\right|$. Then, according to (2.5) and the support of $\eta_{A_{\varepsilon}}$ and $\eta_{B_{\varepsilon}}$, we get

$$
\begin{aligned}
I & \lesssim \sum_{N_{1} \wedge N_{2} \geq 8, N_{1} \sim N_{2}} T^{\frac{1}{2}-}\left\|\partial_{x}\left(P_{B_{\varepsilon}} P_{A_{\varepsilon}} P_{N_{1}} v P_{N_{2}} w\right)\right\|_{L_{t x}^{2}} \\
& \lesssim T^{\frac{1}{2}-} \sum_{N_{1} \wedge N_{2} \geq 8, N_{1} \sim N_{2}}\left\|P_{B_{\varepsilon}} P_{A_{\varepsilon}} \partial_{x} P_{N_{1}} v\right\|_{L_{t}^{4} L_{x}^{\infty}}\left\|P_{N_{2}} w\right\|_{L_{t}^{\infty} L_{x}^{2}} \\
& \lesssim T^{\frac{1}{2}-} \sum_{N_{1} \wedge N_{2} \geq 8, N_{1} \sim N_{2}} N_{1}^{-1 / 4}\left\|P_{A_{\varepsilon}} P_{N_{1}} v\right\|_{X_{\varepsilon}^{1,1 / 2,1}}\left\|P_{N_{2}} w\right\|_{L_{t}^{\infty} L_{x}^{2}} \\
& \lesssim T^{\frac{1}{2}-}\left\|P_{A_{\varepsilon}} v\right\|_{X_{\varepsilon}^{1,1 / 2,1}}\|w\|_{L_{t}^{\infty} L_{x}^{2}} .
\end{aligned}
$$

2.2.2 The subregion $\left|\xi_{1}\right| \wedge\left|\xi_{2}\right|>\sqrt{\frac{17}{80 \varepsilon}}$. Then as in the proof of (2.12) in Section 3 we observe that (2.19) holds.

To complete the proof of Proposition 5.1 we notice that, similarly to Lemma 2.2, one can easily prove that any solution $w \in C\left([0, T] ; L^{2}(\mathbb{R})\right)$ with $0<T<1$ of (4.8) satisfies

$$
\begin{equation*}
\|w\|_{X_{\varepsilon, T}^{-1,1}} \lesssim\|w\|_{L_{T}^{\infty} H_{x}^{-1}}+\|v\|_{L_{T}^{\infty} H_{x}^{1}}\|w\|_{L_{T}^{\infty} L_{x}^{2}} \tag{5.7}
\end{equation*}
$$

Finally, with (5.6) and (5.7) in hand, Proposition 5.1 follows from the classical linear estimates in Bourgain's spaces.

Now the second step consists in proving the following estimate :
Proposition 5.2. Let $0<\varepsilon<1, w \in C\left([0, T] ; H^{1}(\mathbb{R})\right)$ a solution to (4.8) with initial data $\varphi$ and $v \in Y_{\varepsilon, T}^{1}$. Then it holds

$$
\begin{equation*}
\left\|P_{\mathrm{C} A_{\varepsilon}} w\right\|_{L_{T}^{\infty} L_{x}^{2}}^{2} \lesssim\left\|P_{\mathrm{C} A_{\varepsilon}} \varphi\right\|_{L^{2}}^{2}+\left(\varepsilon^{1 / 2}+T^{1 / 4}\right)\|w\|_{Y_{\varepsilon, T}^{0}}^{2}\left(\|v\|_{Y_{\varepsilon, T}^{1}}+\|v\|_{Y_{\varepsilon, T}^{1}}^{2}\right) \tag{5.8}
\end{equation*}
$$

where the implicit constant is independent of $\varepsilon$.

Proof. Applying the operator $P_{\mathrm{C}_{\varepsilon}}$ on (4.8) and taking the $L_{x}^{2}$-scalar product with $P_{C_{A_{\varepsilon}}} w$ we get

$$
\begin{aligned}
\frac{d}{d t}\left\|P_{\mathrm{C} A_{\varepsilon}} w(t)\right\|_{L_{x}^{2}}^{2} & =\int_{\mathbb{R}} P_{\mathrm{C} A_{\varepsilon}} \partial_{x}(v w) P_{\mathrm{C} A_{\varepsilon}} w \\
& =\int_{\mathbb{R}} P_{\mathrm{C} A_{\varepsilon}} \partial_{x}\left(w P_{B_{\varepsilon}} v\right) P_{\mathrm{C} A_{\varepsilon}} w+\int_{\mathbb{R}} P_{\mathrm{C} A_{\varepsilon}} \partial_{x}\left(w P_{\mathrm{C} B_{\varepsilon}} v\right) P_{\mathrm{C} A_{\varepsilon}} w \\
& =I_{1}+I_{2}
\end{aligned}
$$

Using the following commutator estimate (see for instance [10])

$$
\left\|\left[P_{\mathrm{C} A_{\varepsilon}} \partial_{x}, f\right] g\right\|_{L_{x}^{2}} \lesssim\left\|\partial_{x} f\right\|_{L_{x}^{\infty}}\|g\|_{L_{x}^{2}}
$$

and integrating by parts, we get

$$
\begin{aligned}
I_{1} & =\int_{\mathbb{R}} P_{B_{\varepsilon}} v P_{\mathrm{C} A_{\varepsilon}} w_{x} P_{\mathrm{C} A_{\varepsilon}} w+\int_{\mathbb{R}}\left(\left[P_{\mathrm{C}_{\varepsilon}} \partial_{x}, P_{B_{\varepsilon}} v\right] w\right) P_{\mathrm{CA}_{\varepsilon}} w \\
& \lesssim\left\|\partial_{x} P_{B_{\varepsilon}} v\right\|_{L^{\infty}}\|w\|_{L_{x}^{2}}^{2} .
\end{aligned}
$$

By the frequency projections, we easily control $I_{2}$ by

$$
\begin{aligned}
I_{2} & \lesssim \varepsilon^{-1 / 2}\left\|P_{\mathrm{C} A_{\varepsilon}}\left(w P_{\mathrm{C}_{E_{\varepsilon}}} v\right)\right\|_{L_{x}^{1}}\left\|P_{\mathrm{C} A_{\varepsilon}} w\right\|_{L_{x}^{\infty}} \\
& \lesssim\left\|P_{\mathrm{C} A_{\varepsilon}} w\right\|_{L_{x}^{\infty}}\|w\|_{L_{x}^{2}}\|v\|_{H_{x}^{1}} .
\end{aligned}
$$

Gathering the above estimates we infer that

$$
\frac{d}{d t}\left\|P_{\mathrm{C} A_{\varepsilon}} w(t)\right\|_{L_{x}^{2}}^{2} \lesssim\left(\left(\|w(t)\|_{L_{x}^{2}}+\left\|P_{\mathrm{C} A_{\varepsilon}} w(t)\right\|_{L_{x}^{\infty}}\right)\left(\left\|\partial_{x} P_{B_{\varepsilon}} v(t)\right\|_{L_{x}^{\infty}}+\|v(t)\|_{H^{1}}\right)\right)\|w(t)\|_{L_{x}^{2}} .
$$

On the other hand, applying Lemma 3.1 on (4.8) we get

$$
\left\|P_{\mathrm{C} A_{\varepsilon}} w\right\|_{L_{T}^{1} L_{x}^{\infty}} \lesssim\left(\varepsilon^{1 / 2}+T\right)\left\|P_{\mathrm{C} A_{\varepsilon}} w\right\|_{L_{T}^{\infty} L_{x}^{2}}+T\|v\|_{L_{T}^{\infty} H_{x}^{1}}\|w\|_{L_{T}^{\infty} L_{x}^{2}}
$$

Therefore, integrating in time the next to the last inequality with (4.7) in hand, leads to (5.8)

Combining Propositions 5.1 and 5.2 we infer that

$$
\|w\|_{Y_{\varepsilon, T}^{0}}^{2} \leq C\|\varphi\|_{L^{2}}^{2}+C\left(\sqrt{\varepsilon}+T^{\frac{1}{4}}\right)\|w\|_{Y_{\varepsilon, T}^{0}}^{2}\|v\|_{Y_{\varepsilon, T}^{1}}\left(1+\|v\|_{Y_{\varepsilon, T}^{1}}^{3}\right) .
$$

which yieds the desired result according to (4.6)
