## Characterization of Glycol Ether Emissions from a Water-based Paint: Chamber Tests and Field Experiments

Summary: In order to document glycol ether emissions from a water-based paint, emission test chamber and field experiments were conducted. VOC identified in paint emissions were mainly propylene glycol, 1-(2-butoxy-l-methylethoxy)-2-propanol and 2-(2-butoxyethoxy)-ethanol. VOC emissions were high during and just after painting (e.g. propylene glycol concentrations > 10 mg. $T^1$ ). Indoor concentrations were modelled using a simple sink model to document the influence of the air exchange rate: the higher the AER, the lower the indoor concentrations. High ventilation of the painted room or a delay before re-entering into a freshly painted room appear as simple but efficient recommendations for limiting exposure to water-based paints emissions.

#### 1 Introduction

The purpose of this paper is to present the characterization of glycol ether emissions from a water-based paint as documented from test chamber methods and from a realistic field experiment and to study the influence of ventilation conditions on indoor concentrations.

#### 2 Methods

Two layers of the selected paint were applied with a 24 hours interval on pre painted gypsum boards installed on the walls of a 32 m³ test room of the CSTB experimental house (MARIA). Ventilation conditions were controlled by mechanical extraction during the experiment (air exchange rate =1.0 h¹). The field experiment was simulated in an emission test chamber (COMPAQ). VOC were sampled on Tenax TA and analysed by TD/GC/MS/FID.

#### 3 Results




Fig. 1: Propylene glycol concentrations (µg.m<sup>-3</sup>) measured in the experimental house (MARIA) and in the emission test chamber (CLIMPAQ).




Fig. 2: Measured and modeled indoor DPGBE concentrations ( $\mu g.m^{-3}$ ) depending on the AER ( $h^{-1}$ ).

Main identified VOC emitted by the tested paint were propylene glycol, a mix of isomers of 1-(2-butoxy-1methylethoxy)-2-propanol (DPGBE) butoxyethoxy)-ethanol (DEGBE). Indoor concentrations were high during and ~ 8 hours after application of the paint: e.g. propylene glycol concentrations > 10 mg.m"<sup>3</sup> (TWA WEEL, AIHA). Then, indoor concentrations sharply decreased during the first days after paint application. We observed a good agreement between results obtained under realistic conditions from the field experiment and from the emission test chamber, after 10 days especially (Figure 1). concentrations were modelled using a simple sink model [1]. For the three main identified VOC, we obtained a good agreement between modelled and measured

concentrations (see the example of DPGBE on Figure 2). Three different air exchange rates (AER) were simulated using this model (5.0, 1.0 and 0.2 h<sup>-1</sup>): the higher the AER, the lower the indoor concentrations.
