# ON THE COMMUTING VARIETY OF A REDUCTIVE LIE ALGEBRA. 

JEAN-YVES CHARBONNEL


#### Abstract

The commuting variety of a reductive Lie algebra $\mathfrak{g}$ is the underlying variety of a well defined subscheme of $\mathfrak{g} \times \mathfrak{g}$. In this note, it is proved that this scheme has rational singularities. In particular, its ideal of definition is a prime ideal.

## 1. Introduction.

In this note, the base field $\mathbb{k}$ is algebraically closed of characteristic $0, \mathfrak{g}$ is a reductive Lie algebra of finite dimension, $\ell$ is its rank, and $G$ is its adjoint group.
1.1. Notations. - For $V$ a module over a $\mathbb{k}$-algebra, its symmetric and exterior algebras are denoted by $\mathrm{S}(V)$ and $\bigwedge(V)$ respectively. If $E$ is a subset of $V$, the submodule of $V$ generated by $E$ is denoted by $\operatorname{span}(E)$. When $V$ is a vector space over $\mathbb{k}$, the grassmanian of all $d$-dimensional subspaces of $V$ is denoted by $\operatorname{Gr}_{d}(V)$.

- All topological terms refer to the Zariski topology. If $Y$ is a subset of a topological space $X$, let denote by $\bar{Y}$ the closure of $Y$ in $X$. For $Y$ an open subset of the algebraic variety $X, Y$ is called a big open subset if the codimension of $X \backslash Y$ in $X$ is bigger than 2. For $Y$ a closed subset of an algebraic variety $X$, its dimension is the biggest dimension of its irreducible components and its codimension in $X$ is the smallest codimension in $X$ of its irreducible components. For $X$ an algebraic variety, $\mathbb{k}[X]$ is the algebra of regular functions on $X$.
- All the complexes considered in this note are graded complexes over $\mathbb{Z}$ of vector spaces and their differentials are homogeneous of degree -1 and they are denoted by d. As usual, the gradation of the complex is denoted by $C$.

[^0]- The dimension of the Borel subalgebras of $\mathfrak{g}$ is denoted by $\mathrm{b}_{\mathfrak{g}}$. Let set $n:=\mathrm{b}_{\mathfrak{g}}-\ell$ so that $\operatorname{dim} \mathfrak{g}=$ $2 \mathrm{~b}_{\mathfrak{g}}-\ell_{\mathfrak{g}}=2 n+\ell$.
- The dual $\mathfrak{g}^{*}$ of $\mathfrak{g}$ identifies with $\mathfrak{g}$ by a given non degenerate, invariant, symmetric bilinear form $\langle.,$. on $\mathfrak{g} \times \mathfrak{g}$ extending the Killing form of $[\mathfrak{g}, \mathfrak{g}]$.
- For $x \in \mathfrak{g}$, let denote by $\mathfrak{g}^{x}$ the centralizer of $x$ in $\mathfrak{g}$. The set of regular elements of $\mathfrak{g}$ is

$$
\mathfrak{g}_{\mathrm{reg}}:=\left\{x \in \mathfrak{g} \mid \operatorname{dim} \mathfrak{g}^{x}=\ell\right\}
$$

The subset $\mathfrak{g}_{\text {reg }}$ of $\mathfrak{g}$ is a $G$-invariant open subset of $\mathfrak{g}$. According to [V72], $\mathfrak{g} \backslash \mathfrak{g}_{\text {reg }}$ is equidimensional of codimension 3.

- Let denote by $S(\mathfrak{g})^{\mathfrak{g}}$ the algebra of $\mathfrak{g}$-invariant elements of $\mathrm{S}(\mathfrak{g})$. Let $p_{1}, \ldots, p_{\ell}$ be homogeneous generators of $\mathrm{S}(\mathfrak{g})^{\mathfrak{g}}$ of degree $d_{1}, \ldots, d_{\ell}$ respectively. Let choose the polynomials $p_{1}, \ldots, p_{\ell}$ so that $d_{1} \leq \cdots \leq d_{\ell}$. For $i=1, \ldots, d_{\ell}$ and $(x, y) \in \mathfrak{g} \times \mathfrak{g}$, let consider a shift of $p_{i}$ in direction $y: p_{i}(x+t y)$ with $t \in \mathbb{k}$. Expanding $p_{i}(x+t y)$ as a polynomial in $t$, one obtains

$$
\begin{equation*}
p_{i}(x+t y)=\sum_{m=0}^{d_{i}} p_{i}^{(m)}(x, y) t^{m} ; \quad \forall(t, x, y) \in \mathbb{k} \times \mathfrak{g} \times \mathfrak{g} \tag{1}
\end{equation*}
$$

where $y \mapsto(m!) p_{i}^{(m)}(x, y)$ is the derivate at $x$ of $p_{i}$ at the order $m$ in the direction $y$. The elements $p_{i}^{(m)}$ defined by (1) are invariant elements of $S(\mathfrak{g}) \otimes_{\mathbb{k}} S(\mathfrak{g})$ under the diagonal action of $G$ in $\mathfrak{g} \times \mathfrak{g}$. Let remark that $p_{i}^{(0)}(x, y)=p_{i}(x)$ while $p_{i}^{\left(d_{i}\right)}(x, y)=p_{i}(y)$ for all $(x, y) \in \mathfrak{g} \times \mathfrak{g}$.

Remark 1.1. The family $\mathcal{P}_{x}:=\left\{p_{i}^{(m)}(x,.) ; 1 \leq i \leq \ell, 1 \leq m \leq d_{i}\right\}$ for $x \in \mathfrak{g}$, is a Poisson-commutative family of $\mathrm{S}(\mathfrak{g})$ by Mishchenko-Fomenko [MF78]. One says that the family $\mathcal{P}_{x}$ is constructed by the argument shift method.

- Let $i \in\{1, \ldots, \ell\}$ be. For $x$ in $\mathfrak{g}$, let denote by $\varepsilon_{i}(x)$ the element of $\mathfrak{g}$ given by

$$
\left\langle\varepsilon_{i}(x), y\right\rangle=\left.\frac{\mathrm{d}}{\mathrm{~d} t} p_{i}(x+t y)\right|_{t=0}
$$

for all $y$ in $\mathfrak{g}$. Thereby, $\varepsilon_{i}$ is an invariant element of $S(\mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}$ under the canonical action of $G$. According to [Ko63, Theorem 9], for $x$ in $\mathfrak{g}$, $x$ is in $\mathfrak{g}_{\text {reg }}$ if and only if $\varepsilon_{1}(x), \ldots, \varepsilon_{\ell}(x)$ are linearly independent. In this case, $\varepsilon_{1}(x), \ldots, \varepsilon_{\ell}(x)$ is a basis of $\mathrm{g}^{x}$.

Let denote by $\varepsilon_{i}^{(m)}$, for $0 \leq m \leq d_{i}-1$, the elements of $S(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathbb{k}} \mathfrak{g}$ defined by the equality:

$$
\begin{equation*}
\varepsilon_{i}(x+t y)=\sum_{m=0}^{d_{i}-1} \varepsilon_{i}^{(m)}(x, y) t^{m}, \quad \forall(t, x, y) \in \mathbb{k} \times \mathfrak{g} \times \mathfrak{g} \tag{2}
\end{equation*}
$$

and let set:

$$
V_{x, y}:=\operatorname{span}\left(\left\{\varepsilon_{i}^{(0)}(x, y), \ldots, \varepsilon_{i}^{\left(d_{i}-1\right)}(x, y), i=1, \ldots, \ell\right\}\right)
$$

for $(x, y)$ in $\mathfrak{g} \times \mathfrak{g}$. According to [Bol91, Corollary 2], $V_{x, y}$ has dimension $\mathrm{b}_{\mathfrak{g}}$ if and only if $P_{x, y} \backslash\{0\}$ is contained in $\mathfrak{g}_{\text {reg }}$.
1.2. Main result and main idea. Since $\mathfrak{g}$ identifies with its dual, $S(\mathfrak{g})$ is the algebra of polynomial functions on $\mathfrak{g}$. The commuting variety $\mathcal{C}(\mathfrak{g})$ of $\mathfrak{g}$ is the subvariety of elements $(x, y)$ of $\mathfrak{g} \times \mathfrak{g}$ such that $[x, y]=0$. Let $I_{\mathfrak{g}}$ be the ideal of $\mathbf{S}(\mathfrak{g} \times \mathfrak{g})$ generated by the functions $(x, y) \mapsto\langle v,[x, y]\rangle$ with $v$ in $\mathfrak{g}$. Then $\mathcal{C}(\mathfrak{g})$ is the underlying subvariety of the subscheme of $\mathfrak{g} \times \mathfrak{g}$ defined by $I_{\mathfrak{g}}$. It is a well known and long standing open question whether or not this scheme is reduced. The main result of this note is the following theorem:

Theorem 1.2. The subscheme of $\mathfrak{g} \times \mathfrak{g}$ defined by $I_{\mathfrak{g}}$ has rational singularities. Furthermore, $I_{\mathfrak{g}}$ is a prime ideal of $\mathrm{S}(\mathfrak{g} \times \mathfrak{g})$.

According to a result of R. W. Richardson [Ri79], $\mathcal{C}(g)$ is irreducible. So the last assertion of the theorem is a consequence of the first one. In [Di79], J. Dixmier gave a partial answer to this question. In fact, he proved that $I_{\mathfrak{g}}$ and its radical have the same part in degree 1 . The main tool of our proof uses the main argument of the Dixmier's proof: for a finitely generated module $M$ over $S(\mathfrak{g} \times \mathfrak{g}), M=0$ if the codimension of its support is at least $l+2$ with $l$ the projective dimension of $M$ (see Appendix A).

Let introduce the characteristic submodule of $\mathfrak{g}$, denoted by $\mathrm{B}_{\mathfrak{g}}$. By definition, $\mathrm{B}_{\mathfrak{g}}$ is a submodule of $S(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}$ and an element $\varphi$ of $S(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}$ is in $B_{\mathfrak{g}}$ if and only if for all $(x, y)$ in $\mathfrak{g} \times \mathfrak{g}, \varphi(x, y)$ is in the sum of subspaces $\mathfrak{g}^{a x+b y}$ with $(a, b)$ in $\mathbb{k}^{2} \backslash\{0\}$. This is a free module of rank $\mathrm{b}_{\mathfrak{g}}$. Moreover, for all $\varphi$ in $\mathrm{B}_{\mathfrak{g}}$ and for all $(x, y)$ in $\mathfrak{g} \times \mathfrak{g},\langle\varphi(x, y),[x, y]\rangle=0$. The first step of the proof of Theorem 1.2 is the following proposition:

Proposition 1.3. For i positive integer, the module $\bigwedge^{i}(\mathfrak{g}) \wedge \bigwedge^{\mathrm{b}_{\mathfrak{g}}}\left(\mathrm{B}_{\mathfrak{g}}\right)$ has projective dimension at most $i$.
The second step of the proof of Theorem 1.2 is the following theorem:
Theorem 1.4. The ideal $I_{\mathfrak{g}}$ is radical and its projective dimension is $2 n-1$.
Then Theorem 1.2 follows easily from this theorem and [CZa12, Theorem 1.10].

## 2. Characteristic module.

For $(x, y)$ in $\mathfrak{g} \times \mathfrak{g}$, let set:

$$
V_{x, y}^{\prime}=\sum_{(a, b) \in \mathbb{R}^{2} \backslash\{0\}} \mathfrak{g}^{a x+b y}
$$

By definition, the characteristic module $\mathrm{B}_{\mathfrak{g}}$ of $\mathfrak{g}$ is the submodule of elements $\varphi$ of $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}$ such that $\varphi(x, y)$ is in $V_{x, y}^{\prime}$ for all $(x, y)$ in $\mathfrak{g} \times \mathfrak{g}$. In this section, some properties of $\mathrm{B}_{\mathfrak{g}}$ are given.
2.1. Let recall that $\Omega_{\mathfrak{g}}$ is the subset of elements $(x, y)$ of $\mathfrak{g} \times \mathfrak{g}$ such that $P_{x, y} \backslash\{0\}$ is contained in $\mathfrak{g}_{\text {reg }}$. According to [CMo08, Corollary 10], $\Omega_{\mathfrak{g}}$ is a big open subset of $\mathfrak{g} \times \mathfrak{g}$.

Proposition 2.1. Let $(x, y)$ be in $\mathfrak{g} \times \mathfrak{g}$.
(i) Let suppose that $P_{x, y} \cap \mathfrak{g}_{\text {reg }}$ is not empty. Then for all open subset $O$ of $\mathbb{k}^{2}$ such that ax + by is in $\mathfrak{g}_{\text {reg }}$ for all $(a, b)$ in $O, V_{x, y}$ is the sum of the $\mathfrak{g}^{a x+b y}$ 's, $(a, b)$ is in $O$.
(ii) The spaces $\left[x, V_{x, y}\right]$ and $\left[y, V_{x, y}\right]$ are equal.
(iii) For all $(x, y)$ in $\mathfrak{g} \times \mathfrak{g}$ such that $P_{x, y} \cap \mathfrak{g}_{\mathrm{reg}}$ is not empty, $\left[x, V_{x, y}\right]$ is orthogonal to $V_{x, y}$. Furthermore, $(x, y)$ is in $\Omega_{\mathfrak{g}}$ if and only if $\left[x, V_{x, y}\right]$ is the orthogonal complement of $V_{x, y}$ in $\mathfrak{g}$.
(iv) The space $V_{x, y}$ is contained in $V_{x, y}^{\prime}$. Moreover, $V_{x, y}=V_{x, y}^{\prime}$ if $(x, y)$ is in $\Omega_{\mathfrak{g}}$.
(v) The element $(x, y)$ of $\mathfrak{g} \times \mathfrak{g}$ is in $\Omega_{\mathfrak{g}}$ if and only if $V_{x, y}$ has dimension $\mathrm{b}_{\mathfrak{g}}$.
(vi) For $g$ in $G$, for $i=1, \ldots, \ell$ and for $m=0, \ldots, d_{i}-1, \varepsilon_{i}^{(m)}$ is a $G$-equivariant map.

Proof. (i), (ii), (iii) are a result of A. V. Bolsinov [Bol91].
(iv) According to [Ko63, Theorem 9], for all $z$ in $\mathfrak{g}$ and for $i=1, \ldots, \ell, \varepsilon_{i}(z)$ is in $\mathfrak{g}^{z}$. Hence for all $t$ in $\mathbb{k}, \varepsilon_{i}(x+t y)$ is in $V_{x, y}^{\prime}$. So $\varepsilon_{i}^{(m)}(x, y)$ is in $V_{x, y}^{\prime}$ for all $m$, whence $V_{x, y} \subset V_{x, y}^{\prime}$.

Let suppose that $(x, y)$ is in $\Omega_{\mathfrak{g}}$. According to [Ko63, Theorem 9], for all $(a, b)$ in $\mathbb{k}^{2} \backslash\{0\}, \varepsilon_{1}(a x+$ $b y), \ldots, \varepsilon_{\ell}(a x+b y)$ is a basis of $\mathfrak{g}^{a x+b y}$. Hence $\mathfrak{g}^{a x+b y}$ is contained in $V_{x, y}$, whence the assertion.
(v) is a consequence of (iv) and a result of A. V. Bolsinov [Bol91].
(vi) Let $i$ be in $\{1, \ldots, \ell\}$. Since $p_{i}$ is $G$-invariant, $\varepsilon_{i}$ is a $G$-equivariant map. As a result, its 2polarizations $\varepsilon_{i}^{(0)}, \ldots, \varepsilon_{i}^{\left(d_{i}-1\right)}$ are $G$-equivariant for the diagonal action of $G$ in $\mathfrak{g} \times \mathfrak{g}$.

Theorem 2.2. (i) The module $\mathrm{B}_{\mathfrak{g}}$ is a free module of rank $\mathrm{b}_{\mathfrak{g}}$ whose a basis is the sequence $\varepsilon_{i}^{(0)}, \ldots, \varepsilon_{i}^{\left(d_{i}-1\right)}$, $i=1, \ldots, \ell$.
(ii) For $\varphi$ in $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}$, $\varphi$ is in $\mathrm{B}_{\mathfrak{g}}$ if and only if $p \varphi \in \mathrm{~B}_{\mathfrak{g}}$ for some $p$ in $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \backslash\{0\}$.
(iii) For all $\varphi$ in $\mathrm{B}_{\mathfrak{g}}$ and for all $(x, y)$ in $\mathfrak{g} \times \mathfrak{g}, \varphi(x, y)$ is orthogonal to $[x, y]$.

Proof. (i) and (ii) According to Proposition 2.1,(iv), $\varepsilon_{i}^{(m)}$ is in $\mathrm{B}_{\mathfrak{g}}$ for all (i,m). Moreover, according to Proposition 2.1,(v), these elements are linearly independent over $S(\mathfrak{g} \times \mathfrak{g})$ since the sum of the degrees $d_{1}, \ldots, d_{\ell}$ equal $\mathrm{b}_{\mathfrak{g}}$ by [Bou02, Ch. V, $\S 5$, Proposition 3]. Let $\varphi$ be an element of $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}$ such that $p \varphi$ is in $\mathrm{B}_{\mathfrak{g}}$ for some $p$ in $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \backslash\{0\}$. Since $\Omega_{\mathfrak{g}}$ is a big open subset of $\mathfrak{g} \times \mathfrak{g}$, for all $(x, y)$ in a dense open subset of $\Omega_{\mathfrak{g}}, \varphi(x, y)$ is in $V_{x, y}$ by Proposition 2.1,(iv). According to Proposition 2.1,(v), the map

$$
\Omega_{\mathfrak{g}} \longrightarrow \mathrm{Gr}_{\mathrm{b}_{\mathfrak{g}}}(\mathfrak{g}) \quad(x, y) \longmapsto V_{x, y}
$$

is regular. So, $\varphi(x, y)$ is in $V_{x, y}$ for all $(x, y)$ in $\Omega_{\mathfrak{g}}$ and for some regular functions $a_{i, m}, i=1, \ldots, \ell$, $m=0, \ldots, d_{i}-1$ on $\Omega_{\mathrm{g}}$,

$$
\varphi(x, y)=\sum_{i=1}^{\ell} \sum_{m=0}^{d_{i}-1} a_{i, m}(x, y) \varepsilon_{i}^{(m)}(x, y)
$$

for all $(x, y)$ in $\Omega_{\mathfrak{g}}$. Since $\Omega_{\mathfrak{g}}$ is a big open subset of $\mathfrak{g} \times \mathfrak{g}$ and since $\mathfrak{g} \times \mathfrak{g}$ is normal, the $a_{i, m}$ 's have a regular extension to $\mathfrak{g} \times \mathfrak{g}$. Hence $\varphi$ is a linear combination of the $\varepsilon_{i}^{(m)}$,s with coefficients in $S(\mathfrak{g} \times \mathfrak{g})$. As a result, the sequence $\varepsilon_{i}^{(m)}, i=1, \ldots, \ell, m=0, \ldots, d_{i}-1$ is a basis of the module $\mathrm{B}_{\mathfrak{g}}$ and $\mathrm{B}_{\mathfrak{g}}$ is the subset of elements $\varphi$ of $S(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathbb{k}} \mathfrak{g}$ such that $p \varphi \in \mathrm{~B}_{\mathfrak{g}}$ for some $p$ in $S(\mathfrak{g} \times \mathfrak{g}) \backslash\{0\}$.
(iii) Let $\varphi$ be in $\mathrm{B}_{\mathfrak{g}}$. According to (i) and Proposition 2.1,(iii) and (iv), for all $(x, y)$ in $\Omega_{\mathfrak{g}},[x, \varphi(x, y)]$ is orthogonal to $V_{x, y}$. Then, since $y$ is in $V_{x, y},[x, \varphi(x, y)]$ is orthogonal to $y$ and $\langle\varphi(x, y),[x, y]\rangle=0$, whence the assertion.
2.2. Let also denote by $\langle.,$.$\rangle the natural extension of \langle.,$.$\rangle to the module S(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}$.

Proposition 2.3. Let $\mathrm{C}_{\mathfrak{g}}$ be the orthogonal complement of $\mathrm{B}_{\mathfrak{g}}$ in $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}$.
(i) For $\varphi$ in $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}$, $\varphi$ is in $\mathrm{C}_{\mathfrak{g}}$ if and only if $\varphi(x, y)$ is in $\left[x, V_{x, y}\right]$ for all $(x, y)$ in a nonempty open subset of $\mathfrak{g} \times \mathfrak{g}$.
(ii) The module $\mathrm{C}_{\mathfrak{g}}$ is free of rank $\mathrm{b}_{\mathfrak{g}}-\ell$. Furthermore, the sequence of maps

$$
(x, y) \mapsto\left[x, \varepsilon_{i}^{(1)}(x, y)\right], \ldots,(x, y) \mapsto\left[x, \varepsilon_{i}^{\left(d_{i}-1\right)}(x, y)\right], i=1, \ldots, \ell
$$

is a basis of $\mathrm{C}_{\mathrm{g}}$.
(iii) The orthogonal complement of $\mathrm{C}_{\mathfrak{g}}$ in $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}$ equals $\mathrm{B}_{\mathfrak{g}}$.

Proof. (i) Let $\varphi$ be in $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathbb{k}} \mathfrak{g}$. If $\varphi$ is in $\mathrm{C}_{\mathfrak{g}}$, then $\varphi(x, y)$ is orthogonal to $V_{x, y}$ for all $(x, y)$ in $\Omega_{\mathfrak{g}}$. Then, according to Proposition 2.1,(iii), $\varphi(x, y)$ is in $\left[x, V_{x, y}\right]$ for all $(x, y)$ in $\Omega_{\mathfrak{g}}$. Conversely, let suppose that $\varphi(x, y)$ is in $\left[x, V_{x, y}\right]$ for all $(x, y)$ in a nonempty open subset $V$ of $\mathfrak{g} \times \mathfrak{g}$. By Proposition 2.1,(iii) again, for all $(x, y)$ in $V \cap \Omega_{\mathrm{g}}, \varphi(x, y)$ is orthogonal to the $\varepsilon_{i}^{(m)}(x, y)$ 's, $i=1, \ldots, \ell, m=0, \ldots, d_{i}-1$, whence the assertion by Theorem 2.1.
(ii) Let C be the submodule of $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathbb{k}} \mathfrak{g}$ generated by the maps

$$
(x, y) \mapsto\left[x, \varepsilon_{i}(1)(x, y)\right], \ldots,(x, y) \mapsto\left[x, \varepsilon_{i}^{\left(d_{i}-1\right)}(x, y)\right], i=1, \ldots, \ell
$$

According to (i), C is a submodule of $\mathrm{C}_{\mathrm{g}}$. This module is free of rank $\mathrm{b}_{\mathfrak{g}}-\ell$ since $\left[x, V_{x, y}\right]$ has dimension $\mathrm{b}_{\mathfrak{g}}-\ell$ for all ( $x, y$ ) in $\Omega_{\mathfrak{g}}$ by Proposition 2.1, (iii). According to (i), for $\varphi$ in $\mathrm{C}_{\mathfrak{g}}$, for all $(x, y)$ in $\Omega_{\mathfrak{g}}$,

$$
\varphi(x, y)=\sum_{i=1}^{\ell} \sum_{m=1}^{d_{i}-1} a_{i, m}(x, y)\left[x, \varepsilon_{i}^{(m)}(x, y)\right]
$$

with the $a_{i, m}$ 's regular on $\Omega_{\mathfrak{g}}$ and uniquely defined by this equality. Since $\Omega_{\mathfrak{g}}$ is a big open subset of $\mathfrak{g} \times \mathfrak{g}$ and since $\mathfrak{g} \times \mathfrak{g}$ is normal, the $a_{i, m}$ 's have a regular extension to $\mathfrak{g} \times \mathfrak{g}$. As a result, $\varphi$ is in C, whence the assertion.
(iii) Let $\varphi$ be in the orthogonal complement of $\mathrm{C}_{\mathfrak{g}}$ in $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathbb{k}} \mathfrak{g}$. According to (ii), for all $(x, y)$ in $\Omega_{\mathfrak{g}}, \varphi(x, y)$ is orthogonal to [ $x, V_{x, y}$ ]. Hence by Proposition 2.1,(iii), $\varphi(x, y)$ is in $V_{x, y}$ for all $(x, y)$ in $\Omega_{\mathrm{g}}$. So, by Theorem 2.1, $\varphi$ is in $\mathrm{B}_{\mathfrak{g}}$, whence the assertion.

Let denote by $\mathcal{B}$ and $\mathcal{C}$ the localizations of $\mathrm{B}_{\mathfrak{g}}$ and $\mathrm{C}_{\mathfrak{g}}$ on $\mathfrak{g} \times \mathfrak{g}$ respectively. For $(x, y)$ in $\mathfrak{g} \times \mathfrak{g}$, let $C_{x, y}$ be the image of $\mathrm{C}_{\mathfrak{g}}$ by the evaluation map at $(x, y)$.

Lemma 2.4. There exists an affine open cover $\mathcal{O}$ of $\Omega_{\mathfrak{g}}$ verifying the following condition: for all $O$ in $\mathcal{O}$, there exist some subspaces $E$ and $F$ of $\mathfrak{g}$, depending on $O$, such that

$$
\mathfrak{g}=E \oplus V_{x, y}=F \oplus C_{x, y}
$$

for all $(x, y)$ in $O$. Moreover, for all $(x, y)$ in $O$, the orthogonal complement of $V_{x, y}$ in $\mathfrak{g}$ equals $C_{x, y}$.
Proof. According to Proposition 2.1,(iii) and (v), for all $(x, y)$ in $\Omega_{\mathfrak{g}}, V_{x, y}$ and $C_{x, y}$ have dimension $\mathrm{b}_{\mathfrak{g}}$ and $\mathrm{b}_{\mathfrak{g}}-\ell$ respectively so that the maps

$$
\Omega_{\mathfrak{g}} \longrightarrow \operatorname{Gr}_{\mathrm{b}_{\mathfrak{g}}}(\mathfrak{g}) \quad(x, y) \longmapsto V_{x, y} \quad \Omega_{\mathfrak{g}} \longrightarrow \operatorname{Gr}_{\mathrm{b}_{\mathfrak{g}}-\ell}(\mathfrak{g}) \quad(x, y) \longmapsto C_{x, y}
$$

are regular, whence the assertion.

## 3. Torsion and projective dimension.

Let $E$ and $E^{\#}$ be the quotients of $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}$ by $\mathrm{B}_{\mathfrak{g}}$ and $\mathrm{C}_{\mathfrak{g}}$ respectively. For $i$ positive integer, let denote by $E_{i}$ the quotient of $\bigwedge^{i}(E)$ by its torsion module.
3.1. Let $\mathrm{B}_{\mathrm{g}}^{*}$ and $\mathrm{C}_{\mathrm{g}}^{*}$ be the duals of $\mathrm{B}_{\mathfrak{g}}$ and $\mathrm{C}_{\mathrm{g}}$.

Lemma 3.1. (i) The $\mathrm{S}(\mathrm{g} \times \mathfrak{g})$-modules $E$ and $E^{\#}$ have projective dimension at most 1 .
(ii) The $\mathrm{S}(\mathrm{g} \times \mathrm{g})$-modules $E$ and $E^{\#}$ are torsion free.
(iii) The modules $\mathrm{C}_{\mathfrak{g}}$ and $\mathrm{B}_{\mathfrak{g}}$ are the duals of $E$ and $E^{\#}$ respectively.
(iv) The canonical morphisms from $E$ to $\mathrm{C}_{\mathrm{g}}^{*}$ is an embedding.

Proof. (i) By definition, the short seqences of $\mathrm{S}(\mathrm{g} \times \mathfrak{g})$-modules,

$$
\begin{gathered}
0 \longrightarrow \mathrm{~B}_{\mathfrak{g}} \longrightarrow \mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g} \longrightarrow E \longrightarrow 0 \\
0 \longrightarrow \mathrm{C}_{\mathfrak{g}} \longrightarrow \mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\underline{k}} \mathfrak{g} \longrightarrow E^{\#} \longrightarrow 0
\end{gathered}
$$

are exact. Hence $E$ and $E^{\#}$ have projective dimension at most 1 since $\mathrm{B}_{\mathfrak{g}}$ and $\mathrm{C}_{\mathfrak{g}}$ are free modules by Theorem 2.2 and Proposition 2.3,(ii).
(ii) The module $E$ is torsion free by Theorem 2.2,(ii). By definition, for $\varphi$ in $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}, \varphi$ is in $\mathrm{C}_{\mathfrak{g}}$ if $p \varphi$ is in $\mathrm{C}_{\mathfrak{g}}$ for some $p$ in $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \backslash\{0\}$, whence $E^{\#}$ is torsion free.
(iii) According to the exact sequences of (i), the dual of $E$ is the orthogonal complement of $\mathrm{B}_{\mathfrak{g}}$ in $S(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}$ and the dual of $E^{\#}$ is the orthogonal complement of $C_{\mathfrak{g}}$ in $S(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}$, whence the assertion since $C_{g}$ is the orthogonal complement of $B_{g}$ in $S(g \times g) \otimes_{\mathfrak{k}} \mathfrak{g}$ by definition and since $B_{g}$ is the orthogonal complement of $\mathrm{C}_{\mathfrak{g}}$ in $\mathrm{S}(\mathrm{g} \times \mathfrak{g}) \otimes_{\underline{k}} \mathfrak{g}$ by Proposition 2.3,(iii).
(iv) Let $\bar{\omega}$ be in the kernel of the canonical morphism from $E$ to $\mathrm{C}_{\mathrm{g}}^{*}$. Let $\omega$ be a representative of $\bar{\omega}$ in $S(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}$. According to Proposition 2.3,(iii), $B_{\mathfrak{g}}$ is the orthogonal complement of $C_{\mathfrak{g}}$ in $S(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}$ so that $\omega$ is in $\mathrm{B}_{\mathfrak{g}}$, whence the assertion.

Let $\iota$ be the morphism

$$
\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\underline{k}} \mathfrak{g} \longrightarrow \mathrm{C}_{\mathfrak{g}}^{*} \quad v \longmapsto(\mu \mapsto\langle v, \mu\rangle)
$$

Lemma 3.2. The submodule $\iota\left(\mathrm{S}(\mathrm{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}\right)$ of $\mathrm{C}_{\mathfrak{g}}^{*}$ has projective dimension at most 1 .
Proof. According to Proposition 2.3,(iii), $\mathrm{B}_{\mathfrak{g}}$ is the kernel of $\iota$, whence the assertion since $\mathrm{B}_{\mathfrak{g}}$ is a free module by Theorem 2.2.

Let set

$$
\varepsilon=\wedge_{i=1}^{\ell} \varepsilon_{i}^{(0)} \wedge \cdots \wedge \varepsilon_{i}^{\left(d_{i}-1\right)}
$$

and for $i$ positive integer, let denote by $\theta_{i}$ the morphism

$$
\mathrm{S}(\mathrm{~g} \times \mathfrak{g}) \otimes_{\underline{k}} \wedge^{i}(\mathrm{~g}) \longrightarrow \wedge^{i}(\mathfrak{g}) \wedge \wedge^{\mathrm{b}_{\mathfrak{g}}}\left(\mathrm{B}_{\mathfrak{g}}\right) \quad \varphi \longmapsto \varphi \wedge \varepsilon
$$

Proposition 3.3. Let $i$ be a positive integer.
(i) The morphism $\theta_{i}$ defines through the quotient an isomorphism from $E_{i}$ onto $\bigwedge^{i}(\mathfrak{g}) \wedge \bigwedge^{\mathrm{b}_{\mathrm{g}}}\left(\mathrm{B}_{\mathrm{g}}\right)$.
(ii) The short sequence of $\mathrm{S}(\mathrm{g} \times \mathfrak{g})$-modules

$$
0 \longrightarrow \mathrm{~B}_{\mathfrak{g}} \otimes_{\mathrm{S}(\mathrm{~g} \times \mathfrak{g})} E_{i} \longrightarrow \mathfrak{g} \otimes_{\mathbb{K}} E_{i} \longrightarrow E \otimes_{\mathrm{S}(\mathrm{~g} \times \mathfrak{g})} E_{i} \longrightarrow 0
$$

is exact.

Proof. (i) For $j$ positive integer, let denote by $\pi_{j}$ the canonical map from $S(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathbb{k}} \bigwedge^{j}(\mathfrak{g})$ to $\bigwedge^{j}(E)$. Let $\omega$ be in the kernel of $\pi_{i}$. Let $O$ be an element of the affine open cover of $\Omega_{\mathfrak{g}}$ of Lemma 2.4 and let $W$ be a subspace of $\mathfrak{g}$ such that

$$
\mathfrak{g}=W \oplus V_{x, y}
$$

for all $(x, y)$ in $O$ so that $\pi_{1}$ induces an isomorphism

$$
\mathbb{k}[O] \otimes_{\mathbb{k}} W \longrightarrow \mathbb{k}[O] \otimes_{\mathbb{k}} E
$$

Moreover, $\mathrm{B}_{\mathfrak{g}}$ is the kernel of $\pi_{1}$. Then, from the equality

$$
\mathbb{k}[O] \otimes_{\mathbb{k}} \bigwedge^{i}(\mathfrak{g})=\bigoplus_{j=0}^{i} \bigwedge^{j}(W) \wedge \mathbb{k}[O] \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} \bigwedge^{i-j}\left(\mathrm{~B}_{\mathfrak{g}}\right)
$$

it results that the restriction of $\omega$ to $O$ is in $\mathbb{k}[O] \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} \wedge^{i-1}(\mathfrak{g}) \wedge \mathrm{B}_{\mathfrak{g}}$. Hence the restriction of $\omega \wedge \varepsilon$ to $O$ equals 0 and $\omega$ is in the kernel of $\theta_{i}$ since $\bigwedge^{i}(\mathfrak{g}) \wedge \bigwedge^{\mathrm{b}_{\mathfrak{g}}}\left(\mathrm{B}_{\mathfrak{g}}\right)$ has no torsion as a submodule of a free module. As a result, $\theta_{i}$ defines through the quotient a morphism from $\bigwedge^{i}(E)$ to $\bigwedge^{i}(\mathfrak{g}) \wedge \bigwedge^{\mathrm{b}_{\mathfrak{g}}}\left(\mathrm{B}_{\mathfrak{g}}\right)$. Let denote it by $\vartheta_{i}^{\prime}$. Since $\bigwedge^{i}(\mathfrak{g}) \wedge \bigwedge^{\mathrm{b}_{\mathfrak{g}}}\left(\mathrm{B}_{\mathfrak{g}}\right)$ is torsion free, the torsion submodule of $\bigwedge^{i}(E)$ is contained in the kernel of $\vartheta_{i}^{\prime}$. Hence $\vartheta_{i}^{\prime}$ defines through the quotient a morphism from $E_{i}$ to $\bigwedge^{i}(\mathfrak{g}) \wedge \bigwedge^{\mathrm{b}_{\mathfrak{g}}}\left(\mathrm{B}_{\mathfrak{g}}\right)$. Denoting it by $\vartheta_{i}, \vartheta_{i}^{\prime}$ and $\vartheta_{i}$ are surjective since $\theta_{i}$ is too.

Let $\bar{\omega}$ be in the kernel of $\vartheta_{i}^{\prime}$ and let $\omega$ be a representative of $\bar{\omega}$ in $S(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \wedge^{i}(\mathfrak{g})$. Then $\omega \wedge \varepsilon=0$ so that the restriction of $\omega$ to the above open subset $O$ is in $\mathbb{k}[O] \otimes_{S(\mathfrak{g} \times \mathfrak{g})} \bigwedge^{i-1}(\mathfrak{g}) \wedge \mathrm{B}_{\mathfrak{g}}$. As a result, the restriction of $\bar{\omega}$ to $O$ equals 0 . So, $\bar{\omega}$ is in the torsion submodule of $\bigwedge^{i}(E)$, whence the assertion.
(ii) By definition, the sequence

$$
0 \longrightarrow \mathrm{~B}_{\mathfrak{g}} \longrightarrow \mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathbb{k}} \mathfrak{g} \longrightarrow E \longrightarrow 0
$$

is exact. Then the sequence

$$
\operatorname{Tor}_{1}^{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}\left(E, E_{i}\right) \longrightarrow \mathrm{B}_{\mathfrak{g}} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} E_{i} \longrightarrow \mathfrak{g} \otimes_{\mathbb{k}} E_{i} \longrightarrow E \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} E_{i} \longrightarrow 0
$$

is exact. By definition, $E_{i}$ is torsion free. As a result, $\mathrm{B}_{\mathfrak{g}} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} E_{i}$ is torsion free since $\mathrm{B}_{\mathfrak{g}}$ is a free module. Then, since $\operatorname{Tor}_{1}^{S(\mathfrak{g} \times \mathfrak{g})}\left(E, E_{i}\right)$ is a torsion module, its image in $\mathrm{B}_{\mathfrak{g}} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} E_{i}$ equals 0 , whence the assertion.
3.2. For $i$ positive integer, $\langle.,$.$\rangle has a canonical extension to S(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathbb{k}} \bigwedge^{i}(\mathfrak{g})$ denoted again by $\langle.,$.$\rangle .$

Lemma 3.4. Let $i$ be a positive integer. Let $T_{i}$ be the torsion module of $E \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} E_{i}$ and let $T_{i}^{\prime}$ be its inverse image by the canonical morphism $\mathfrak{g} \otimes_{\mathbb{k}} E_{i} \rightarrow E \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} E_{i}$.
(i) The canonical morphism from $\bigwedge^{i}(E)$ to $\bigwedge^{i}\left(\mathrm{C}_{\mathfrak{g}}^{*}\right)$ defines through the quotient an embedding of $E_{i}$ into $\wedge^{i}\left(\mathrm{C}_{\mathfrak{g}}^{*}\right)$.
(ii) The module of $T_{i}^{\prime}$ is the intersection of $\mathfrak{g} \otimes_{\mathfrak{k}} E_{i}$ and $\mathrm{B}_{\mathfrak{g}} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} \bigwedge^{i}\left(\mathrm{C}_{\mathfrak{g}}^{*}\right)$.
(iii) The module $T_{i}^{\prime}$ is isomorphic to $\operatorname{Hom}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}\left(E^{\#}, E_{i}\right)$.

Proof. (i) According to Lemma 3.1,(iii), there is a canonical morphism from $\bigwedge^{i}(E)$ to $\bigwedge^{i}\left(\mathrm{C}_{\mathfrak{g}}^{*}\right)$. Let $\bar{\omega}$ be in its kernel and let $\omega$ be a representative of $\bar{\omega}$ in $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \bigwedge^{i}(\mathfrak{g})$. Then $\omega$ is orthogonal to $\bigwedge^{i}\left(\mathrm{C}_{\mathfrak{g}}\right)$ with respect to $\langle.,$.$\rangle . So for O$ as in Lemma 2.4, the restriction of $\omega$ to $O$ is in $\mathbb{k}[O] \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} \bigwedge^{i-1}(\mathfrak{g}) \wedge \mathrm{B}_{\mathfrak{g}}$.

Hence the restriction of $\bar{\omega}$ to $O$ equals 0 . In other words, $\bar{\omega}$ is in the torsion module of $\bigwedge^{i}(E)$, whence the assertion since $\bigwedge^{i}\left(\mathrm{C}_{\mathrm{g}}^{*}\right)$ is a free module.
(ii) Since $\bigwedge^{i}\left(\mathrm{C}_{\mathfrak{g}}^{*}\right)$ is a free module, by Proposition 3.3,(ii), there is a morphism of short exact sequences


Moreover, the tow first vertical arrows are embeddings. Hence $T_{i}^{\prime}$ is the intersection of $\mathfrak{g} \otimes_{\mathbb{k}} E_{i}$ and $\mathrm{B}_{\mathfrak{g}} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} \wedge^{i}\left(\mathrm{C}_{\mathfrak{g}}^{*}\right)$.
(iii) According to the identification of $\mathfrak{g}$ with its dual, $\mathfrak{g} \otimes_{\mathbb{k}} E_{i}=\operatorname{Hom}_{\mathbb{k}}\left(\mathfrak{g}, E_{i}\right)$. Moreover, according to the short exact sequence of $S(\mathfrak{g} \times \mathfrak{g})$-modules

$$
0 \longrightarrow \mathrm{C}_{\mathfrak{g}} \longrightarrow \mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathbb{k}} \mathfrak{g} \longrightarrow E^{\#} \longrightarrow 0
$$

the sequence of $S(\mathfrak{g} \times \mathfrak{g})$-modules

$$
0 \longrightarrow \operatorname{Hom}_{\mathbf{S}(\mathfrak{g} \times \mathfrak{g})}\left(E^{\#}, E_{i}\right) \longrightarrow \operatorname{Hom}_{\mathbb{k}}\left(\mathfrak{g}, E_{i}\right) \longrightarrow \operatorname{Hom}_{\mathbf{S}(\mathfrak{g} \times \mathfrak{g})}\left(\mathrm{C}_{\mathfrak{g}}, E_{i}\right) \longrightarrow \operatorname{Ext}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}^{1}\left(E^{\#}, E_{i}\right)
$$

is exact. For $\varphi$ in $\operatorname{Hom}_{\mathbb{K}}\left(\mathfrak{g}, E_{i}\right), \varphi$ is in the kernel of the third arrow if and only if $\mathrm{C}_{\mathfrak{g}}$ is contained in the kernel of $\varphi$ or equivalently $\varphi$ is in $\mathrm{B}_{\mathfrak{g}} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} \bigwedge^{i}\left(\mathrm{C}_{\mathfrak{g}}^{*}\right)$, whence the assertion by (ii).

The following corollary results from Lemma 3.4.
Corollary 3.5. Let $i$ be a positive integer and let $\overline{E_{i}}$ be the quotient of $E \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} E_{i}$ by its torsion module. Then the short sequence of $\mathrm{S}(\mathfrak{g} \times \mathfrak{g})$-modules

$$
0 \longrightarrow \operatorname{Hom}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}\left(E^{\#}, E_{i}\right) \longrightarrow \mathfrak{g} \otimes_{\mathfrak{k}} E_{i} \longrightarrow \overline{E_{i}} \longrightarrow 0
$$

is exact.
3.3. For $i$ positive integer, let $d_{i}$ and $d_{i}^{\prime}$ be the projective dimensions of $E_{i}$ and $\operatorname{Hom}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}\left(E^{\#}, E_{i}\right)$.

Lemma 3.6. Let $i$ be a positive integer and let $d_{i}^{\prime \prime}$ be the projective dimension of $\operatorname{Ext}_{\mathrm{S}(\mathrm{g} \times \mathfrak{g})}^{1}\left(E^{\#}, E_{i}\right)$.
(i) The integer $d_{i}^{\prime}$ is at most $\sup \left\{d_{i}^{\prime \prime}-2, d_{i}\right\}$.
(ii) For $P$ a projective module over $\mathrm{S}(\mathfrak{g} \times \mathfrak{g})$, $\operatorname{Ext}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}^{1}\left(E^{\#}, P\right)$ is canonically isomorphic to $\mathrm{A}_{\mathfrak{g}} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} P$ with $\mathrm{A}_{\mathfrak{g}}$ the quotient of $\mathrm{C}_{\mathfrak{g}}^{*}$ by $\iota\left(\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \mathfrak{g}\right)$.
(iii) The integer $d_{i}^{\prime \prime}$ is at most $d_{i}+2$.

Proof. (i) From the short exact

$$
0 \longrightarrow \mathrm{C}_{\mathfrak{g}} \longrightarrow \mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathbb{k}} \mathfrak{g} \longrightarrow E^{\#} \longrightarrow 0
$$

one deduces the exact sequence

$$
0 \longrightarrow \operatorname{Hom}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}\left(E^{\#}, E_{i}\right) \longrightarrow \operatorname{Hom}_{\mathbb{k}}\left(\mathfrak{g}, E_{i}\right) \longrightarrow \operatorname{Hom}_{\mathbf{S}(\mathfrak{g} \times \mathfrak{g})}\left(\mathrm{C}_{\mathfrak{g}}, E_{i}\right) \longrightarrow \operatorname{Ext}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}^{1}\left(E^{\#}, E_{i}\right) \longrightarrow 0
$$

whence the two short exact sequences

0 \longrightarrow \operatorname{Hom}_{S(\mathfrak{g} \times \mathfrak{g})}\left(E^{\#}, E_{i}\right) \longrightarrow \operatorname{Hom}_{\mathbb{k}}\left(\mathfrak{g}, E_{i}\right) \longrightarrow Z \longrightarrow 0

0 \longrightarrow Z \longrightarrow \operatorname{Hom}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}\left(\mathrm{C}_{\mathfrak{g}}, E_{i}\right) \longrightarrow \operatorname{Ext}_{\mathrm{S}(\mathrm{~g} \times \mathfrak{g})}^{1}\left(E^{\#}, E_{i}\right) \longrightarrow 0
$$

with $Z$ the image of the arrow

\operatorname{Hom}_{\mathbb{k}}\left(\mathfrak{g}, E_{i}\right) \longrightarrow \operatorname{Hom}_{\mathfrak{( g} \times \mathfrak{g})}\left(\mathrm{C}_{\mathfrak{g}}, E_{i}\right)

Denoting by $d$ the projective dimension of $Z$, one deduces the inequalities

d_{i}^{\prime} \leq \sup \left\{d-1, d_{i}\right\} \quad d \leq \sup \left\{d_{i}^{\prime \prime}-1, d_{i}\right\}
$$

since $\mathrm{C}_{\mathrm{g}}$ is a free module, whence the assertion.
(ii) From the short exact sequence

0 \longrightarrow \mathrm{C}_{\mathfrak{g}} \longrightarrow \mathrm{S}(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathbb{k}} \mathfrak{g} \longrightarrow E^{\#} \longrightarrow 0
$$

one deduces the exact sequence

$$
0 \longrightarrow \operatorname{Hom}_{\mathbf{S}(\mathfrak{g} \times \mathfrak{g})}\left(E^{\#}, P\right) \longrightarrow \operatorname{Hom}_{\mathbb{k}}(\mathfrak{g}, P) \longrightarrow \operatorname{Hom}_{\mathbf{S}(\mathfrak{g} \times \mathfrak{g})}\left(\mathrm{C}_{\mathfrak{g}}, P\right) \longrightarrow \operatorname{Ext}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}^{1}\left(E^{\#}, P\right) \longrightarrow 0
$$

Since $\mathrm{C}_{\mathfrak{g}}$ is a free module, $\operatorname{Hom}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}\left(\mathrm{C}_{\mathfrak{g}}, P\right)$ is canonically isomorphic to $\mathrm{C}_{\mathfrak{g}}^{*} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} P$ and there is a commutative diagram

whenever the vertical arrows are isomorphisms, whence the assertion since $P$ is projective.
(iii) Let

$$
0 \longrightarrow P_{d_{i}} \longrightarrow \cdots \longrightarrow P_{0} \longrightarrow E_{i} \longrightarrow 0
$$

be a projective resolution of $E_{i}$. For $j$ nonnegative integer, let $Z_{j}$ be the space of cycles of this complex. Since $E^{\#}$ has projective dimension at most 1 , for all module $M$ over $S(\mathfrak{g} \times \mathfrak{g})$, Ext ${ }_{S(\mathfrak{g} \times \mathfrak{g})}^{j}\left(E^{\#}, M\right)=0$ for all integer at least 2 , whence the exact sequences

\operatorname{Ext}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}^{1}\left(E^{\#}, Z_{0}\right) \longrightarrow \operatorname{Ext}_{\mathrm{S}(\mathrm{~g} \times \mathfrak{g})}^{1}\left(E^{\#}, P_{0}\right) \longrightarrow \operatorname{Ext}_{\mathrm{S}(\mathrm{~g} \times \mathfrak{g})}^{1}\left(E^{\#}, E_{i}\right) \longrightarrow 0 \\
\operatorname{Ext}_{\mathrm{S}(\mathrm{~g} \times \mathfrak{g})}^{1}\left(E^{\#}, Z_{j}\right) \longrightarrow \operatorname{Ext}_{\mathrm{S}(\mathrm{~g} \times \mathfrak{g})}^{1}\left(E^{\#}, P_{j}\right) \longrightarrow \operatorname{Ext}_{\mathrm{S}(\mathrm{~g} \times \mathfrak{g})}^{1}\left(E^{\#}, Z_{j-1}\right) \longrightarrow 0
\end{aligned}
$$

for all positive integer $j$ and whence the long exact sequence

$$
0 \longrightarrow \operatorname{Ext}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}^{1}\left(E^{\#}, P_{d_{i}}\right) \longrightarrow \cdots \longrightarrow \operatorname{Ext}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}^{1}\left(E^{\#}, P_{0}\right) \longrightarrow \operatorname{Ext}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}^{1}\left(E^{\#}, E_{i}\right) \longrightarrow 0
$$

Then by (ii), there is an exact sequence

0 \longrightarrow \mathrm{~A}_{\mathfrak{g}} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} P_{d_{i}} \longrightarrow \cdots \longrightarrow \mathrm{~A}_{\mathfrak{g}} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} P_{0} \longrightarrow \operatorname{Ext}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}^{1}\left(E^{\#}, E_{i}\right) \longrightarrow 0
$$

According to Lemma 3.2, $\mathrm{A}_{\mathfrak{g}}$ has projective dimension at most 2. Hence $d_{i}^{\prime \prime}$ is at most $d_{i}+2$.
The following corollary results from Lemma 3.6,(i) and (iii) and Corollary 3.5.
Corollary 3.7. Let i be a positive integer. Then $\overline{E_{i}}$ has projective dimension at most $d_{i}+1$.
3.4. For $i$ a positive integer and for $M$ a $S(\mathfrak{g} \times \mathfrak{g})$-module, let consider on $M^{\otimes i}$ the canonical action of the symmetric group $\Im_{i}$. For $\sigma$ in $\Im_{i}$, let denote by $\epsilon(\sigma)$ its signature. Let $M_{\text {sign }}^{\otimes i}$ be the submodule of elements $a$ of $M^{\otimes i}$ such that $\sigma \cdot a=\epsilon(\sigma) a$ for all $\sigma$ in $\mathfrak{S}_{i}$ and let $\delta_{i}$ be the endomorphism of $M^{\otimes i}$,

a \longmapsto \delta_{i}(a)=\frac{1}{i!} \sum_{\sigma \in \mathbb{G}_{i}} \epsilon(\sigma) \sigma \cdot a
$$

Then $\delta_{i}$ is a projection of $M^{\otimes i}$ onto $M_{\text {sign }}^{\otimes i}$.
For $L$ submodule of $\mathrm{C}_{\mathfrak{g}}^{*}$, let denote by $L_{i}$ the image of $L^{\otimes i}$ by the canonical map from $L^{\otimes i}$ to $\left(\mathrm{C}_{\mathfrak{g}}^{*}\right)^{\otimes i}$ and let set $L_{i, \text { sign }}:=L_{i} \cap\left(\mathrm{C}_{\mathfrak{g}}^{*}\right)_{\text {sign }}^{\otimes i}$. Let $\overline{\bigwedge^{i}(L)}$ be the quotient of $\bigwedge^{i}(L)$ by its torsion module. For $i \geq 2$, let identify $\mathfrak{S}_{i-1}$ with the stabilizer of $i$ in $\mathfrak{S}_{i}$ and let denote by $L_{i-1, \text { sign,1 }}$ the submodule of elements $a$ of $L_{i}$ such that $\sigma \cdot a=\epsilon(\sigma) a$ for all $\sigma$ in $\mathfrak{S}_{i-1}$.

Lemma 3.8. Let $i$ be a positive integer and let $L$ be a submodule of $\mathrm{C}_{\mathrm{g}}^{*}$.
(i) The module $L_{i}$ is the quotient of $L^{\otimes i}$ by its torsion module.
(ii) The module $L_{i, \mathrm{sign}}$ is isomorphic to $\widehat{\bigwedge^{i}(L)}$.
(iii) For $i \geq 2$, the module $L_{i, \text { sign }}$ is a direct factor of $L_{i-1, \text { sign, } 1}$.
(iv) For $i \geq 2$, the module $L_{i-1, \mathrm{sign}, 1}$ is isomorphic to the quotient of $\overline{\bigwedge^{i-1}(L)} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} L$ by its torsion module.

Proof. (i) Let $L_{1}$ and $L_{2}$ be submodules of a free module $F$ over $\mathrm{S}(\mathfrak{g} \times \mathfrak{g})$. From the short exact sequence

0 \longrightarrow L_{2} \longrightarrow F \longrightarrow F / L_{2} \longrightarrow 0
$$

one deduces the exact sequence

\operatorname{Tor}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}^{1}\left(L_{1}, L_{2}\right) \longrightarrow L_{1} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} L_{2} \longrightarrow L_{1} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} F \longrightarrow L_{1} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}\left(F / L_{2}\right) \longrightarrow 0
$$

Since $F$ is free, $L_{1} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} F$ is torsion free. Hence the kernel of the second arrow is the torsion module of $L_{1} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} L_{2}$ since $\operatorname{Tor}_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})}^{1}\left(L_{1}, L_{2}\right)$ is a torsion module, whence the assertion by induction on $i$.
(ii) There is a commutative diagram

so that $L_{i, \text { sign }}$ is the image of $L_{\text {sign }}^{\otimes i}$ by the canonical morphism $L^{\otimes i} \longrightarrow\left(\mathrm{C}_{\mathfrak{g}}^{*}\right)^{\otimes i}$, whence a commutative diagram


According to (i), the kernel of the left down arrow is the torsion module of $L_{\text {sign }}^{\otimes i}$ so that the kernel of the right down arrow is the torsion module of $\bigwedge^{i}(L)$ since the horizontal arrows are isomorphisms. Moreover, the image of $L_{i, \text { sign }}$ in $\bigwedge^{i}\left(\mathrm{C}_{\mathfrak{g}}^{*}\right)$ is the image of $\bigwedge^{i}(L)$. Hence $\overline{\bigwedge^{i}(L)}$ is isomorphic to $L_{i, \text { sign }}$.
(iii) Let denote by $Q_{i}$ the kernel of the endomorphism $\delta_{i}$ of $\left(\mathrm{C}_{\mathfrak{g}}^{*}\right)^{\otimes i}$. Since $\delta_{i}$ is a projection onto $\left(\mathrm{C}_{\mathfrak{g}}^{*}\right)_{\text {sign }}^{\otimes i}$ such that $\delta_{i}\left(L_{i}\right)$ is contained in $L_{i, \text { sign }}$,

whence

L_{i-1, \mathrm{sign}, 1}=L_{i, \mathrm{sgn}} \oplus Q_{i} \cap L_{i-1, \mathrm{sign}, 1}
$$

since $L_{i, \text { sign }}$ is a submodule of $L_{i-1, \text { sign,1 }}$.
(iv) Let $L_{i}^{\prime}$ be the image of $L_{i-1, \text { sign, } 1}$ by the canonical morphism $\left(\mathrm{C}_{\mathrm{g}}^{*}\right)^{\otimes i} \rightarrow \bigwedge^{i-1}\left(\mathrm{C}_{\mathfrak{g}}^{*}\right) \otimes_{\mathrm{S}(\mathrm{g} \times \mathfrak{g})} \mathrm{C}_{\mathfrak{g}}^{*}$. Then $L_{i}^{\prime}$ is contained in $\bigwedge^{i-1}\left(\mathrm{C}_{\mathfrak{g}}^{*}\right) \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} L$ since $\bigwedge^{i-1}\left(\mathrm{C}_{\mathfrak{g}}^{*}\right) \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} L$ is a submodule of $\bigwedge^{i-1}\left(\mathrm{C}_{\mathfrak{g}}^{*}\right) \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} \mathrm{C}_{\mathfrak{g}}^{*}$. Moreover, the morphism $L_{i-1, \text { sign, } 1} \rightarrow L_{i}^{\prime}$ is an isomorphism since the morphism

is too. From (ii), it results the commutative diagram

with the right down arrow surjective. According to (i), the kernel of the left down arrow is the torsion module of $L_{\text {sign }}^{\otimes(i-1)} \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} L$. Hence the kernel of the right down arrow is the torsion module of $\overline{\bigwedge^{i-1}(L) \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} L} L$, whence the assertion.

Proposition 3.9. Let $i$ be a positive integer. Then $E_{i}$ and $\bigwedge^{i}(\mathfrak{g}) \wedge \bigwedge^{b_{\mathfrak{g}}}\left(\mathrm{B}_{\mathfrak{g}}\right)$ have projective dimension at most $i$.

Proof. According to Proposition 3.3,(i), the modules $E_{i}$ and $\bigwedge^{i}(\mathfrak{g}) \wedge \bigwedge^{\mathrm{b}_{\mathfrak{g}}}\left(\mathrm{B}_{\mathfrak{g}}\right)$ are isomorphic. Let prove by induction on $i$ that $E_{i}$ has projective dimension at most $i$. By Lemma 3.1,(i), it is true for $i=1$. Let suppose that it is true for $i-1$. According to Corollary 3.7, $\overline{E_{i}}$ has projective dimension at most $i$. Then by Lemma 3.8, for $L=E, E_{i}$ has projective dimension at most $i$ since $E$ is a submodule of $\mathrm{C}_{\mathfrak{g}}^{*}$ by Lemma 3.1,(iv) and since $E_{i}=\overline{\bigwedge^{i}(E)}$ by Lemma 3.4,(i).

## 4. Main results

Let $I_{\mathfrak{g}}$ be the ideal of $\mathrm{S}(\mathfrak{g} \times \mathfrak{g})$ generated by the functions $(x, y) \mapsto\langle v,[x, y]\rangle$ with $v$ in $\mathfrak{g}$. The nullvariety of $I_{\mathfrak{g}}$ in $\mathfrak{g} \times \mathfrak{g}$ is $\mathcal{C}(\mathfrak{g})$.

Lemma 4.1. Let $J_{\mathfrak{g}}$ be the radical of $I_{\mathfrak{g}}$. Then the support of $J_{\mathfrak{g}} / I_{\mathfrak{g}}$ in $\mathfrak{g} \times \mathfrak{g}$ is strictly contained in $\mathcal{C}(\mathfrak{g})$.

Proof. Since $\mathcal{C}(\mathfrak{g})$ is the nullvariety of $I_{\mathfrak{g}}$ in $\mathfrak{g} \times \mathfrak{g}$. The support of $J_{\mathfrak{g}} / I_{\mathfrak{g}}$ is contained in $\mathcal{C}(\mathfrak{g})$. Let $x_{0}$ be a regular element of $\mathfrak{g}$ and let $V$ be a complement of $\mathfrak{g}^{x_{0}}$ in $\mathfrak{g}$. Since the map

$$
\mathfrak{g}_{\text {reg }} \longrightarrow \operatorname{Gr}_{\ell}(\mathfrak{g}) \quad x \longmapsto \mathfrak{g}^{x}
$$

is regular, for some open subset $O^{\prime}$ of $\mathfrak{g}_{\text {reg }}$, containing $x_{0}$,

$$
\mathfrak{g}=V \oplus \mathfrak{g}^{x}
$$

for all $x$ in $O^{\prime}$. Let $F$ be a complement of $\left[x_{0}, V\right]$ in $\mathfrak{g}$. Then the map

$$
O^{\prime} \longrightarrow \operatorname{Gr}_{2 n}(\mathfrak{g}) \quad x \mapsto[x, V]
$$

is regular and for some affine open subset $O$ of $O^{\prime}$, containing $x_{0}$,

$$
\mathfrak{g}=F \oplus[x, V]
$$

for all $x$ in $O$. Let set:

I_{O}:=\mathbb{k}[O \times \mathfrak{g}] \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} I_{\mathfrak{g}} \quad J_{O}:=\mathbb{k}[O \times \mathfrak{g}] \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} J_{\mathfrak{g}}
$$

and let prove $I_{O}=J_{O}$. It will result that $\left\{x_{0}\right\} \times \mathfrak{g}^{x_{0}}$ is not contained in the support of $J_{\mathfrak{g}} / I_{\mathfrak{g}}$.
According to the identification of $\mathfrak{g}$ with its dual,

$$
\mathbb{k}[O \times \mathfrak{g}]=\mathbb{k}[O] \otimes_{\mathbb{k}} \mathrm{S}(\mathfrak{g})
$$

Let denote by $v_{1}, \ldots, v_{2 n}$ and $f_{1}, \ldots, f_{\ell}$ some basis of $V$ and $F$ respectively. For $(i, j)$ in $\mathbb{N}^{2 n} \times \mathbb{N}^{\ell}$, let $v_{i, j}$ be the element of $\mathbb{k}[O] \otimes_{\mathbb{k}} \mathrm{S}(\mathfrak{g})$,

$$
x \longmapsto v_{i, j}(x):=\left[x, v_{1}\right]^{i_{1}} \cdots\left[x, v_{2 n}\right]^{i_{2 n}} f_{1}^{j_{1}} \cdots f_{\ell}^{j_{\ell}}
$$

so that $v_{i, j},(i, j) \in \mathbb{N}^{2 n} \times \mathbb{N}^{\ell}$ is a basis of the $\mathbb{k}[O]$-module $\mathbb{k}[O] \otimes_{\mathbb{k}} S(\mathfrak{g})$. In particular, $v_{i, j}$ is in $I_{O}$ if

$$
|i|:=i_{1}+\cdots+i_{2 n}>0
$$

Let $\varphi$ be in $J_{O}$. For all $x$ in $O, \varphi(x)$ is in the ideal of definition of $\mathfrak{g}^{x}$ in $\mathfrak{g}$. Since $[x, \mathfrak{g}]$ is the orthogonal complement of $\mathfrak{g}^{x}$ in $\mathfrak{g}, \varphi(x)$ is in the ideal of $\mathrm{S}(\mathfrak{g})$ generated by $[x, V]$ for all $x$ in $O$. Hence $\varphi$ is a linear combination with coefficients in $\mathbb{k}[O]$ of the $v_{i, j}$ 's with $|i|>0$. As a result, $J_{O}$ is contained in $I_{O}$, whence the lemma.

Let d be the $\mathrm{S}(\mathfrak{g} \times \mathfrak{g})$-derivation of the algebra $S(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathbb{k}} \wedge(\mathfrak{g})$ such that $\mathrm{d} v$ is the function $(x, y) \mapsto$ $\langle v,[x, y]\rangle$ on $\mathfrak{g} \times \mathfrak{g}$ for all $v$ in $\mathfrak{g}$. According to Theorem 2.2,(iii), $\Lambda(\mathfrak{g}) \wedge \wedge^{\mathrm{b}_{\mathfrak{g}}}\left(\mathrm{B}_{\mathfrak{g}}\right)$ is a subcomplex of the complex so defined. The gradation on $\Lambda(\mathfrak{g})$ induces a gradation on $S(\mathfrak{g} \times \mathfrak{g}) \otimes_{\mathfrak{k}} \wedge(\mathfrak{g})$ so that $\Lambda(\mathfrak{g}) \wedge \wedge^{b_{\mathfrak{g}}}\left(B_{\mathfrak{g}}\right)$ is a graded complex denoted by $C_{\bullet}(\mathrm{g})$.

Lemma 4.2. The support of the homology of $C \bullet(\mathfrak{g})$ is contained in $\mathcal{C}(\mathfrak{g})$.
Proof. Let $\left(x_{0}, y_{0}\right)$ be in $\mathfrak{g} \times \mathfrak{g} \backslash \mathcal{C}(\mathfrak{g})$ and let $v$ be in $\mathfrak{g}$ such that $\left\langle v,\left[x_{0}, y_{0}\right]\right\rangle \neq 0$. For some affine open subset $O$ of $\mathfrak{g} \times \mathfrak{g}$, containing $\left(x_{0}, y_{0}\right),\langle v,[x, y]\rangle \neq 0$ for all $(x, y)$ in $O$. Then $\mathrm{d} v$ is an invertible element of $\mathbb{k}[O]$. For $c$ a cycle of $\mathbb{k}[O] \otimes_{\mathrm{S}(\mathfrak{g} \times \mathfrak{g})} C \bullet(\mathfrak{g})$,

$$
\mathrm{d}(v \wedge c)=(\mathrm{d} v) c
$$

so that $c$ is a boundary of $C_{\bullet}(\mathfrak{g})$.

Theorem 4.3. (i) The complex $C_{\bullet}(\mathfrak{g})$ has no homology in degree bigger than $\mathrm{b}_{\mathfrak{g}}$.
(ii) The ideal $I_{\mathfrak{g}}$ has projective dimension $2 n-1$.
(iii) The algebra $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) / I_{\mathfrak{g}}$ is Cohen-Macaulay.
(iv) The ideal $I_{\mathfrak{g}}$ is prime.
(v) The projective dimension of the module $\bigwedge^{n}(\mathfrak{g}) \wedge \bigwedge^{\mathrm{b}_{\mathfrak{g}}}\left(\mathrm{B}_{\mathfrak{g}}\right)$ equals $n$.

Proof. (i) Let $Z$ be the space of cycles of degree $\mathrm{b}_{\mathfrak{g}}+1$ of $C_{\bullet}(\mathfrak{g})$. Let set:

$$
\begin{gathered}
C_{i}:=\left\{\begin{array}{ccc}
C_{\mathrm{b}_{\mathfrak{g}}+1+i}(\mathrm{~g}) & \text { if } & i=1, \ldots, n-1 \\
Z & \text { if } & i=0
\end{array}\right. \\
C_{\bullet}:=C_{0} \oplus \cdots \oplus C_{n-1}
\end{gathered}
$$

Then $C_{\bullet}$ is a subcomplex of $C_{\bullet}(\mathfrak{g})$ whose gradation is deduced from the gradation of $C_{\bullet}(\mathfrak{g})$ by translation by $b_{g}+1$. According to Lemma 4.2, the support of its homology is contained in $\mathcal{C}_{g}$. In particular, its codimension in $\mathfrak{g} \times \mathfrak{g}$ is

$$
4 n+2 \ell-(2 n+2 \ell)=2 n=n+n-1+1
$$

According to Proposition 3.9, for $i=1, \ldots, n-1, C_{i}$ has projective dimension at most $i$. Hence, by Corollary A.3, $C_{\bullet}$ is acyclic and $Z$ has projective dimension at most $2 n-2$, whence the assertion.
(ii) and (iii) By definition, the short sequence

$$
0 \longrightarrow Z \longrightarrow \mathfrak{g} \wedge \wedge^{\mathrm{b}_{\mathfrak{g}}}\left(\mathrm{B}_{\mathfrak{g}}\right) \longrightarrow I_{\mathfrak{g}} \longrightarrow 0
$$

is exact. Moreover, by Proposition 3.9, $\mathfrak{g} \wedge \bigwedge^{b_{\mathfrak{g}}}\left(\mathrm{B}_{\mathfrak{g}}\right)$ has projective dimension at most 1. Then, by (i), $I_{\mathfrak{g}}$ has projective dimension at most $2 n-1$. As a result the $S(\mathfrak{g} \times \mathfrak{g})$-module $S(\mathfrak{g} \times \mathfrak{g}) / I_{\mathfrak{g}}$ has projective dimension at most $2 n$. Then by Auslander-Buchsbaum's theorem [Bou98, $\S 3, \mathrm{n}^{\circ} 3$, Théorème 1 ], the depth of the $\operatorname{graded} \mathrm{S}(\mathfrak{g} \times \mathfrak{g})$-module $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) / I_{\mathfrak{g}}$ is bigger than

$$
4 b_{\mathfrak{g}}-2 \ell-2 n=2 b_{\mathfrak{g}}
$$

so that, according to [Bou98, $\S 1, \mathrm{n}^{\circ} 3$, Proposition 4], the depth of the graded algebra $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) / I_{\mathfrak{g}}$ is at least $2 \mathrm{~b}_{\mathfrak{g}}$. In otherwords, $\mathrm{S}(\mathfrak{g} \times \mathfrak{g}) / I_{\mathfrak{g}}$ is Cohen-Macaulay since it has dimension $2 \mathrm{~b}_{\mathfrak{g}}$. Moreover, since the graded algebra $S(\mathfrak{g} \times \mathfrak{g}) / I_{\mathfrak{g}}$ has depth $2 \mathrm{~b}_{\mathfrak{g}}$, the graded $\mathrm{S}(\mathfrak{g} \times \mathfrak{g})$-module $S(\mathfrak{g} \times \mathfrak{g}) / I_{\mathfrak{g}}$ has depth $2 \mathrm{~b}_{\mathfrak{g}}$ and projective dimension $2 n$. Hence $I_{\mathfrak{g}}$ has projective dimension $2 n-1$.
(iii) According to Lemma 4.1, the support in $\mathfrak{g} \times \mathfrak{g}$ of the module $J_{\mathfrak{g}} / I_{\mathfrak{g}}$ is strictly contained in $\mathcal{C}(\mathfrak{g})$. So its codimension in $\mathfrak{g} \times \mathfrak{g}$ is at least $2 n+1$ since $\mathcal{C}(\mathfrak{g})$ is irreducible. Then by (ii) and Proposition A.2,(ii), $I_{\mathfrak{g}}=J_{\mathfrak{g}}$, whence the assertion since $\mathcal{C}(\mathfrak{g})$ is irreducible by [Ri79].
(iv) By (i), $I_{\mathfrak{g}}$ has projective dimension $2 n-1$. Hence, according to Proposition 3.9,(iii) and according to (ii) and Corollary A. $3, \wedge^{n}(\mathfrak{g}) \wedge \bigwedge^{\mathrm{b}_{\mathfrak{g}}}\left(\mathrm{B}_{\mathfrak{g}}\right)$ has projective dimension $n$.

Corollary 4.4. The subscheme of $\mathfrak{g} \times \mathfrak{g}$ defined by $I_{\mathfrak{g}}$ has rational singularities.
Proof. According to Theorem 4.3,(iii), the subscheme of $\mathfrak{g} \times \mathfrak{g}$ defined by $I_{g}$ is Cohen-Macaulay. According to [Po08, Theorem 1], it is smooth in codimension 1. So by Serre's normality criterion [Bou98, §1, $n^{\circ} 10$, Théorème 4], it is normal. Then, by [CZa12, Theorem 1.10], it has rational singularities.

## Appendix A. Projective dimension and cohomology.

Let recall in this section classical results. Let $X$ be a Cohen-Macaulay irreducible affine algebraic variety and let $S$ be a closed subset of codimension $p$ of $X$. Let $P$. be a complex of finitely generated projective $\mathbb{k}[X]$-modules whose lenght $l$ is finite and let $\varepsilon$ be an augmentation morphism of $P$. whose image is $R$, whence an augmented complex of $\mathbb{k}[X]$-modules,

$$
0 \longrightarrow P_{l} \longrightarrow P_{l-1} \longrightarrow \cdots \longrightarrow P_{0} \xrightarrow{\varepsilon} R \longrightarrow 0
$$

Let denote by $\mathcal{P}_{\bullet}, \mathcal{R}, \mathcal{K}_{0}$ the localizations on $X$ of $P_{\bullet}, R$, the kernel of $\varepsilon$ respectively and let denote by $\mathcal{K}_{i}$ the kernel of the morphism $\mathcal{P}_{i} \longrightarrow \mathcal{P}_{i-1}$ for $i$ positive integer.

Lemma A.1. Let suppose that $S$ contains the support of the homology of the augmented complex $P_{\bullet}$.
(i) For all positive integer $i<p-1$ and for all projective $\mathcal{O}_{X}$-module $\mathcal{P}, \mathrm{H}^{i}(X \backslash S, \mathcal{P})$ equals zero.
(ii) For all nonnegative integer $j \leq l$ and for all positive integer $i<p-j$, the cohomology group $\mathrm{H}^{i}\left(X \backslash S, \mathcal{K}_{l-j}\right)$ equals zero.
Proof. (i) Let $i<p-1$ be a positive integer. Since the functor $\mathrm{H}^{i}(X \backslash S, \bullet)$ commutes with the direct sum, it suffices to prove $\mathrm{H}^{i}\left(X \backslash S, \mathcal{O}_{X}\right)=0$. Since $S$ is a closed subset of $X$, one has the relative cohomology long exact sequence

$$
\cdots \longrightarrow \mathrm{H}_{S}^{i}\left(X, \mathcal{O}_{X}\right) \longrightarrow \mathrm{H}^{i}\left(X, \mathcal{O}_{X}\right) \longrightarrow \mathrm{H}^{i}\left(X \backslash S, \mathcal{O}_{X}\right) \longrightarrow \mathrm{H}_{S}^{i+1}\left(X, \mathcal{O}_{X}\right) \longrightarrow \cdots
$$

Since $X$ is affine, $\mathrm{H}^{i}\left(X, \mathcal{O}_{X}\right)$ equals zero and $\mathrm{H}^{i}\left(X \backslash S, \mathcal{O}_{X}\right)$ is isomorphic to $H_{S}^{i+1}\left(X, \mathcal{O}_{X}\right)$. Since $X$ is CohenMacaulay, the codimension $p$ of $S$ in $X$ equals the depth of its ideal of definition in $\mathbb{K}[X]$ [MA86, Ch. 6, Theorem 17.4]. Hence $\mathrm{H}_{S}^{i+1}\left(X, \mathcal{O}_{X}\right)$ and $\mathrm{H}^{i}\left(X \backslash S, \mathcal{O}_{X}\right)$ equal zero since $i+1<p$.
(ii) Let $j$ be a nonnegative integer. Since $S$ contains the support of the homology of the complex $P_{\bullet}$, for all nonnegative integer $j$, one has the short exact sequence of $\mathcal{O}_{X \backslash S}$-modules

$$
\left.\left.\left.0 \longrightarrow \mathcal{K}_{j+1}\right|_{X \backslash S} \longrightarrow \mathcal{P}_{j+1}\right|_{X \backslash S} \longrightarrow \mathcal{K}_{j}\right|_{X \backslash S} \longrightarrow 0
$$

whence the long exact sequence of cohomology

$$
\cdots \longrightarrow \mathrm{H}^{i}\left(X \backslash S, \mathcal{P}_{j+1}\right) \longrightarrow \mathrm{H}^{i}\left(X \backslash S, \mathcal{K}_{j}\right) \longrightarrow \mathrm{H}^{i+1}\left(X \backslash S, \mathcal{K}_{j+1}\right) \longrightarrow \mathrm{H}^{i+1}\left(X \backslash S, \mathcal{P}_{j+1}\right) \longrightarrow \cdots .
$$

Then, by (i), for $i<p-2$ positive integer, the cohomology groups $\mathrm{H}^{i}\left(X \backslash S, \mathcal{K}_{j}\right)$ and $\mathrm{H}^{i+1}\left(X \backslash S, \mathcal{K}_{j+1}\right)$ are isomorphic since $P_{j+1}$ is a projective module. Since $\mathcal{P}_{i}=0$ for $i>l, \mathcal{K}_{l-1}$ and $\mathcal{P}_{l}$ have isomorphic restrictions to $X \backslash S$. In particular, by (i), for $i<p-1$ positive integer, $\mathrm{H}^{i}\left(X \backslash S, \mathcal{K}_{l-1}\right)$ equal zero. Then, by induction on $j$, for $i<p-j$ positive integer, $\mathrm{H}^{i}\left(X \backslash S, \mathcal{K}_{l-j}\right)$ equals zero.

Proposition A.2. Let $R^{\prime}$ be a $\mathbb{k}[X]$-module containing $R$. Let suppose that the following conditions are verified:
(1) $p$ is at least $l+2$,
(2) $X$ is normal,
(3) $S$ contains the support of the homology of the augmented complex $P_{\text {. }}$.
(i) The complex $P_{\bullet}$ is a projective resolution of $R$ of length $l$.
(ii) Let suppose that $R^{\prime}$ is torsion free and let suppose that $S$ contains the support in $X$ of $R^{\prime} / R$. Then $R^{\prime}=R$.

Proof. (i) Let $j$ be a positive integer. One has to prove that $\mathrm{H}^{0}\left(X, \mathcal{K}_{j}\right)$ is the image of $P_{j+1}$. By Condition (3), the short sequence of $\mathcal{O}_{X \backslash S}$-modules

$$
\left.\left.\left.0 \longrightarrow \mathcal{K}_{j+1}\right|_{X \backslash S} \longrightarrow \mathcal{P}_{j+1}\right|_{X \backslash S} \longrightarrow \mathcal{K}_{j}\right|_{X \backslash S} \longrightarrow 0
$$

is exact, whence the cohomology long exact sequence

$$
0 \longrightarrow \mathrm{H}^{0}\left(X \backslash S, \mathcal{K}_{j+1}\right) \longrightarrow \mathrm{H}^{0}\left(X \backslash S, \mathcal{P}_{j+1}\right) \longrightarrow \mathrm{H}^{0}\left(X \backslash S, \mathcal{K}_{j}\right) \longrightarrow \mathrm{H}^{1}\left(X \backslash S, \mathcal{K}_{j+1}\right) \longrightarrow \cdots
$$

By Lemma A.1,(ii), $\mathrm{H}^{1}\left(X \backslash S, \mathcal{K}_{j+1}\right)$ equals 0 since $1<p-l+j+1$, whence the short exact sequence

$$
0 \longrightarrow \mathrm{H}^{0}\left(X \backslash S, \mathcal{K}_{j+1}\right) \longrightarrow \mathrm{H}^{0}\left(X \backslash S, \mathcal{P}_{j+1}\right) \longrightarrow \mathrm{H}^{0}\left(X \backslash S, \mathcal{K}_{j}\right) \longrightarrow 0
$$

Since the codimension of $S$ in $X$ is bigger than 2 and since $X$ is irreducible, $X \backslash S$ is dense in $X$. Moreover, the restriction from $X$ to $X \backslash S$ is an isomorphism from $P_{j+1}$ to $\mathrm{H}^{0}\left(X \backslash S, \mathcal{P}_{j+1}\right)$ since $X$ is normal. Let $\varphi$ be in $\mathrm{H}^{0}\left(X, \mathcal{K}_{j}\right)$. Then there exists an element $\psi$ of $P_{j+1}$ whose image $\psi^{\prime}$ in $\mathrm{H}^{0}\left(X, \mathcal{K}_{j}\right)$ has the same restriction to $X \backslash S$ as $\varphi$. Since $P_{j}$ is a projective module and since $X$ is irreducible, $P_{j}$ is torsion free. Then $\varphi=\psi^{\prime}$ since $\varphi-\psi^{\prime}$ is a torsion element of $P_{j}$, whence the assertion.
(ii) Let $\mathcal{R}^{\prime}$ be the localization of $R^{\prime}$ on $X$. Arguing as in (i), since $S$ contains the contains the support of $R^{\prime} / R$ and since $1<p-l$, the short sequence

$$
0 \longrightarrow \mathrm{H}^{0}\left(X \backslash S, \mathcal{K}_{0}\right) \longrightarrow \mathrm{H}^{0}\left(X \backslash S, \mathcal{P}_{0}\right) \longrightarrow \mathrm{H}^{0}\left(X \backslash S, \mathcal{R}^{\prime}\right) \longrightarrow 0
$$

is exact. Moreover, the restriction from $X$ to $X \backslash S$ is an isomorphism from $P_{0}$ to $\mathrm{H}^{0}\left(X / S, \mathcal{P}_{0}\right)$ is surjective since $X$ is normal. Let $\varphi$ be in $R^{\prime}$. Then for some $\psi$ in $P_{0}, \varphi-\varepsilon(\psi)$ is a torsion element of $R^{\prime}$. So $\varphi=\varepsilon(\psi)$ since $R^{\prime}$ is torsion free, whence the assertion.

Corollary A.3. Let $\mathcal{C}$. be a homology complex of finite type of $\mathbb{k}[X]$-modules whose length $l$ is finite and positive. For $j=0, \ldots, l$, let denote by $Z_{j}$ the space of cycles of degree $j$ of $C_{0}$. Let suppose that the following conditions are verified:
(1) $S$ contains the support of the homology of the complex $C_{\bullet}$,
(2) for all $i, C_{i}$ is a submodule of a free module,
(3) for $i=1, \ldots, l, C_{i}$ has projective dimension at most $d$,
(4) $X$ is normal and $l+d \leq p-1$.

Then $C_{\bullet}$ is acyclic and for $j=0, \ldots, l, Z_{j}$ has projective dimension at most $l+d-j-1$.
Proof. Let prove by induction on $l-j$ that the complex

$$
0 \longrightarrow C_{l} \longrightarrow \cdots \longrightarrow C_{j+1} \longrightarrow Z_{j} \longrightarrow 0
$$

is acyclic and that $Z_{j}$ has projective dimension at most $l+d-j-1$. For $j=l, Z_{j}$ equals zero since $C_{l}$ is torsion free by Condition (2) and since $Z_{l}$ a submodule of $C_{l}$, supported by $S$ by Condition (1). Let suppose $j \leq l-1$ and let suppose the statement true for $j+1$. By Condition (2), $C_{j+1}$ has a projective resolution $P_{\bullet}$ whose length is at most $d$ and whose terms are finitely generated. By induction hypothesis, $Z_{j+1}$ has a projective resolution $Q$. whose length is at most $l+d-j-2$ and whose terms are finitely generated, whence an augmented complex $R_{\bullet}$ of projective modules whose length is $l+d-j-1$,

$$
0 \longrightarrow Q_{l+d-j-2} \oplus P_{l+d-j-1} \longrightarrow \cdots \longrightarrow Q_{0} \oplus P_{1} \longrightarrow P_{0} \longrightarrow Z_{j} \longrightarrow 0
$$

Denoting by d the differentials of $Q_{\bullet}$ and $P_{\bullet}$, the restriction to $Q_{i} \oplus P_{i+1}$ of the differential of $R_{\boldsymbol{\bullet}}$ is the map

$$
(x, y) \mapsto\left(\mathrm{d} x, \mathrm{~d} y+(-1)^{i} \delta(x)\right)
$$

with $\delta$ the map which results from the injection of $Z_{j+1}$ into $C_{j+1}$. Since $P_{\bullet}$ and $Q_{\bullet}$ are projective resolutions, the complex $R_{\bullet}$ is a complex of projective modules having no homology in positive degree. Hence the support of the homology of the augmented complex $R_{\boldsymbol{\bullet}}$ is contained in $S$ by Condition (1). Then, by Proposition A. 2 and Conditions (3) and (4), $R_{\mathbf{\bullet}}$ is a projective resolution of $Z_{j}$ of length is $l+d-j-1$ since $Z_{j}$ is a submodule of a free module by Condition (2), whence the corollary.
