# ANY COMPACT SET SUPPORTS A LOT OF MULTIFRACTAL MEASURES 

FRÉDÉRIC BAYART


#### Abstract

We prove that, in the Baire category sense, a typical measure supported by a compact set admits a linear lower singularity spectrum. We investigate the same question for the upper singularity spectrum and for other forms of genericity.


## 1. Introduction

Let $K$ be a compact subset of $\mathbb{R}^{d}$ and let $\mu \in \mathcal{P}(K)$, the set of Borel probability measures on $K$. The lower and upper local dimension of $\mu$ at $x$ are defined by

$$
\begin{aligned}
& \underline{\operatorname{dim}}_{\mathrm{loc}}(\mu ; x)=\liminf _{r \rightarrow 0} \frac{\log \mu(B(x, r))}{\log r} \\
& \overline{\operatorname{dim}}_{\mathrm{loc}}(\mu ; x)=\limsup _{r \rightarrow 0} \frac{\log \mu(B(x, r))}{\log r}
\end{aligned}
$$

When these two dimensions coincide, we say that $\mu$ admits a local dimension at $x$ and we denote this common value $\operatorname{dim}_{\mathrm{loc}}(\mu ; x)$.
The study of pointwise dimension maps and their relationship to Hausdorff dimension goes back to Bilingsley ([Bil60], [Bil61]). Setting

$$
\begin{aligned}
& \mathcal{E}_{-}(\mu ; \alpha)=\left\{x \in K ; \operatorname{dim}_{\mathrm{loc}}(\mu ; x) \leq \alpha\right\} \\
& \mathcal{E}^{+}(\mu ; \alpha)=\left\{x \in K ; \operatorname{dim}_{\mathrm{loc}}(\mu ; x) \leq \alpha\right\},
\end{aligned}
$$

it is well known that

$$
\begin{array}{ll}
\operatorname{dim}_{\mathcal{H}}\left(\mathcal{E}_{-}(\mu ; \alpha)\right) \leq \alpha & \text { for any } \alpha \in\left[0, \operatorname{dim}_{\mathcal{H}}(K)\right] \\
\operatorname{dim}_{\mathcal{P}}\left(\mathcal{E}^{+}(\mu ; \alpha)\right) \leq \alpha & \text { for any } \alpha \in\left[0, \operatorname{dim}_{\mathcal{P}}(K)\right]
\end{array}
$$

where $\operatorname{dim}_{\mathcal{H}}(E)\left(\right.$ resp. $\left.\operatorname{dim}_{\mathcal{P}}(E)\right)$ denotes the Hausdorff (resp. the packing) dimension of $E$. By appropriated versions of the Frostman lemma, these inequalities are optimal (we refer to the classical books [Fa197, Mat95] for the usual definitions and results which are involved in this paper).
To understand better the measure $\mu$, we can go a little bit further by doing a multifractal analysis of this measure. We then introduce the level sets of the local dimension maps by setting

$$
\begin{aligned}
E_{-}(\mu ; \alpha) & =\left\{x \in K ; \operatorname{dim}_{\mathrm{loc}}(\mu ; x)=\alpha\right\} \\
E^{+}(\mu ; \alpha) & =\left\{x \in K ; \overline{\operatorname{dim}}_{\mathrm{loc}}(\mu ; x)=\alpha\right\} \\
E(\mu ; \alpha) & =\left\{x \in K ; \operatorname{dim}_{\mathrm{loc}}(\mu ; x)=\alpha\right\} .
\end{aligned}
$$

These sets describe the distribution of the singularities of the measure $\mu$ and thus contain crucial informations on the geometrical properties of $\mu$. The maps $\alpha \mapsto \operatorname{dim}_{\mathcal{H}}\left(E_{-}(\mu ; \alpha)\right)$

[^0]and $\alpha \mapsto \operatorname{dim}_{\mathcal{P}}\left(E^{+}(\mu ; \alpha)\right)$ are called the lower and the upper singularity spectrum of $\mu$. A measure for which $\operatorname{dim}_{\mathcal{H}}\left(E_{-}(\mu ; \alpha)\right)$ or $\operatorname{dim}_{\mathcal{P}}\left(E^{+}(\mu ; \alpha)\right)$ is nonzero for several values of $\alpha$ is called multifractal.
In this paper, we are looking for measures having the worst possible behaviour: for any $\alpha \in\left[0, \operatorname{dim}_{\mathcal{H}}(K)\right], \operatorname{dim}_{\mathcal{H}}\left(E_{-}(\mu ; \alpha)\right)=\alpha$ or, for any $\alpha \in\left[0, \operatorname{dim}_{\mathcal{P}}(K)\right], \operatorname{dim}_{\mathcal{P}}\left(E^{+}(\mu ; \alpha)\right)=$ $\alpha$. We ask whether this can be achieved in any compact set $K$ and whether this is a typical property of probability measures on $K$ ? By a property true for a typical measure of $\mathcal{P}(K)$, we mean a property which is satisfied by a dense $G_{\delta}$ set of elements of $\mathcal{P}(K)$. Throughout this paper, $\mathcal{P}(K)$ is endowed with the weak topology.
In this direction, a recent nice achievement was obtained by Z. Buczolich and S. Seuret; they show in $[\mathrm{BS} 10]$ that this is true if $K=[0,1]^{d}$.

Theorem (Buczolich-Seuret). A typical measure $\mu \in \mathcal{P}\left([0,1]^{d}\right)$ satisfies, for any $\alpha \in$ $[0, d], \operatorname{dim}_{\mathcal{H}}\left(E_{-}(\mu ; \alpha)\right)=\alpha$.
Our first main result in this paper is the generalization of this last theorem to an arbitrary compact subset of $\mathbb{R}^{d}$.

Theorem 1.1. Let $K$ be a compact subset of $\mathbb{R}^{d}$. A typical measure $\mu \in \mathcal{P}(K)$ satisfies, for any $\alpha \in\left[0, \operatorname{dim}_{\mathcal{H}}(K)\right)$, $\operatorname{dim}_{\mathcal{H}}\left(E_{-}(\mu ; \alpha)\right)=\alpha$. If $\mathcal{H}^{\alpha}(K)>0$, this is also true for $\alpha=\operatorname{dim}_{\mathcal{H}}(K)$.

We turn now to the upper local dimension. In that case, the situation breaks down dramatically: for a typical measure $\mu \in \mathcal{P}(K)$, the sets $\mathcal{E}^{+}(\mu ; \alpha)$ are empty provided $\alpha$ is sufficiently small. This depends on the local upper box dimension of $K$. For $E$ a subset of $\mathbb{R}^{d}$, we denote by $\overline{\operatorname{dim}}_{B}(E)$ the upper-box dimension of $E$. The local upper box dimension of a compact subset $K$ of $\mathbb{R}^{d}$ is defined by

$$
\overline{\operatorname{dim}}_{B, \operatorname{loc}}(K)=\inf _{\substack{x \in K \\ \rho>0}} \overline{\operatorname{dim}}_{B}(K \cap B(x, \rho))
$$

Theorem 1.2. Let $K$ be a compact subset of $\mathbb{R}^{d}$. A typical measure $\mu \in \mathcal{P}(K)$ satisfies: for any $x \in K, \overline{\operatorname{dim}}_{\mathrm{loc}}(\mu ; x) \geq \overline{\operatorname{dim}}_{B, \operatorname{loc}}(K)$.

This theorem has to be compared with a result of H. Haase. In [Haa92], it is shown that if $x$ is a non-isolated point of $K$, then a typical measure $\mu \in \mathcal{P}(K)$ satisfies $\overline{\operatorname{dim}}_{\text {loc }}(\mu ; x)=+\infty$. Our Theorem 1.2 is a kind of uniform version of Haase's result.
A Baire Category theorem shows that $\overline{\operatorname{dim}}_{B, \text { loc }}(K) \leq \operatorname{dim}_{\mathcal{P}}(K)$ (see [MP10, Lemma 10.18]). The most interesting case of Theorem 1.2 happens when we have equality. This holds for many compact sets, like Ahlfors regular compact sets. Following G. David and S. Semmes [DS97], a compact set $K \subset \mathbb{R}^{d}$ is called Ahlfors regular if there are positive constants $s, c_{1}, c_{2}, r_{0}>0$ such that $\operatorname{dim}_{\mathcal{H}}(K)=s$ and

$$
c_{1} r^{s} \leq \mathcal{H}^{s}(K \cap B(x, r)) \leq c_{2} r^{s}
$$

for all $x \in K$ and all $0<r<r_{0}$, where $\mathcal{H}^{s}$ denotes the $s$-dimensional Hausdorff measure. Many natural sets are Ahlfors regular (see [DS97]). For instance this is the case of selfsimilar compact sets satisfying the open set condition. Ahlfors regularity easily implies that the local upper box dimension is equal to the packing dimension. Thus we get the following corollary.
Corollary 1.3. Let $K$ be a compact subset of $\mathbb{R}^{d}$ which is Ahlfors regular. Then a typical measure $\mu \in \mathcal{P}(K)$ satisfies: for any $x \in K$, $\overline{\operatorname{dim}}_{\text {loc }}(\mu ; x) \geq \operatorname{dim}_{\mathcal{P}}(K)$.

Since $\overline{\operatorname{dim}}_{\text {loc }}(\mu ; x) \leq \operatorname{dim}_{\mathcal{P}}(K)$ for $\mu$-almost all $x \in K$ (and all $\mu \in \mathcal{P}(K)$ ), this corollary yields in turn:

Corollary 1.4. Let $K$ be a compact subset of $\mathbb{R}^{d}$ which is Ahlfors regular. Then a typical measure $\mu \in \mathcal{P}(K)$ satisfies: for $\mu$-almost all $x \in K$, $\overline{\operatorname{dim}}_{\text {loc }}(\mu ; x)=\operatorname{dim}_{\mathcal{P}}(K)$.

In particular, if $K$ is Ahlfors regular, then a typical measure in $\mathcal{P}(K)$ is monofractal from the upper local dimension point of view.

Of course, one may ask a weaker property: the existence of at least one measure with linear upper singularity spectrum. This can be done provided our compact set has a family of subsets with prescribed packing dimension. When the packing and the Hausdorff dimension of these sets coincide, we can go even further and exhibit a measure with a linear singularity spectrum.

Theorem 1.5. Let $K$ be a compact subset of $\mathbb{R}^{d}$ and assume that there exists an increasing family of compact subsets $\left(E_{\alpha}\right)_{0<\alpha<\operatorname{dim}_{\mathcal{P}}(K)}$ of $K$ such that, for any $\alpha \in\left(0, \operatorname{dim}_{\mathcal{P}}(K)\right)$,

$$
\operatorname{dim}_{\mathcal{P}}\left(E_{\alpha}\right)=\alpha \text { and } \mathcal{P}^{\alpha}\left(E_{\alpha}\right)>0
$$

Then there exists $\mu \in \mathcal{P}(K)$ such that, for any $\alpha \in\left(0, \operatorname{dim}_{\mathcal{P}}(K)\right)$,

$$
\operatorname{dim}_{\mathcal{P}}\left(E^{+}(\mu ; \alpha)\right)=\alpha
$$

Moreover, if we can choose the family $\left(E_{\alpha}\right)$ so that, for any $\alpha \in\left(0, \operatorname{dim}_{\mathcal{P}}(K)\right)$,

$$
\operatorname{dim}_{\mathcal{P}}\left(E_{\alpha}\right)=\alpha \text { and } \mathcal{H}^{\alpha}\left(E_{\alpha}\right)>0
$$

then there exists $\mu \in \mathcal{P}(K)$ such that, for any $\alpha \in\left(0, \operatorname{dim}_{\mathcal{P}}(K)\right)$,

$$
\operatorname{dim}_{\mathcal{H}}(E(\mu ; \alpha))=\operatorname{dim}_{\mathcal{P}}(E(\mu ; \alpha))=\alpha
$$

The assumptions of this last theorem are satisfied by many regular compact sets, like self-similar compact sets satisfying the Open Set Condition.

Corollary 1.6. Let $K$ be a self-similar compact subset of $\mathbb{R}^{d}$ and assume that $K$ satisfies the Open Set Condition. Let $s=\operatorname{dim}_{\mathcal{H}}(K)=\operatorname{dim}_{\mathcal{P}}(K)$. Then there exists $\mu \in \mathcal{P}(K)$ such that, for any $\alpha \in(0, s)$,

$$
\operatorname{dim}_{\mathcal{H}}(E(\mu ; \alpha))=\operatorname{dim}_{\mathcal{P}}(E(\mu ; \alpha))=\alpha
$$

Of course, the same questions may be investigated for other forms of genericity. The notion of prevalence has been proved to be relevant in multifractal analysis. The results that we get for this notion are rather different: genericity of multifractal measures in the prevalence sense is easier to obtain. For instance, we shall prove the following result.

Theorem 1.7. Let $K$ be a self-similar compact subset of $\mathbb{R}^{d}$ satisfying the Open Set Condition. Then a prevalent measure $\mu \in \mathcal{P}(K)$ satisfies, for any $\alpha \in\left[0, \operatorname{dim}_{\mathcal{H}}(K)\right)$,

$$
\operatorname{dim}_{\mathcal{H}}(E(\mu ; \alpha))=\operatorname{dim}_{\mathcal{P}}(E(\mu ; \alpha))=\alpha
$$

The paper is organized as follows. In Sections 2 and 3, we collect some preliminary results. Section 4 is devoted to the study of the lower singularity spectrum whereas Section 5 investigated the upper singularity spectrum. Finally in Section 6, we apply our previous results to the multifractal formalism and to the notion of prevalence.

## 2. Preliminaries

2.1. The topology on $\mathcal{P}(K)$. Throughout this paper, $\mathcal{P}(K)$ will be endowed with the weak topology. It is well known (see for instance [Par67]) that this topology is completely metrizable by the Fortet-Mourier distance defined as follows. Let $\operatorname{Lip}(K)$ denote the family of Lipschitz functions $f: K \rightarrow \mathbb{R}$, with $|f| \leq 1$ and $\operatorname{Lip}(f) \leq 1$, where $\operatorname{Lip}(f)$ denotes the Lipschitz constant of $f$. The metric $L$ is defined by

$$
L(\mu, \nu)=\sup _{f \in \operatorname{Lip}(K)}\left|\int f d \mu-\int f d \nu\right|
$$

for any $\mu, \nu \in \mathcal{P}(K)$. We endow $\mathcal{P}(K)$ with the metric $L$. In particular, for $\mu \in \mathcal{P}(K)$ and $\delta>0, B_{L}(\mu, \delta)=\{\nu \in \mathcal{P}(K) ; L(\mu, \nu)<\delta\}$ will stand for the ball with center at $\mu$ and radius equal to $\delta$. Since $K$ is separable, the set of probability measures with finite support $\mathcal{F}(K)$ is dense in $\mathcal{P}(K)$.
We shall use several times the following lemma. Its proof can be found e.g. in [Bay12].
Lemma 2.1. For any $\alpha \in(0,1)$, for any $\beta>0$, there exists $\eta>0$ such that, for any $E a$ Borel subset of $K$, for any $\mu, \nu \in \mathcal{P}(K)$,

$$
L(\mu, \nu)<\eta \Longrightarrow \mu(E) \leq \nu(E(\alpha))+\beta
$$

where $E(\alpha)=\{x \in K ; \operatorname{dist}(x, E)<\alpha\}$.
2.2. Net measures. To produce sets with prescribed Hausdorff dimension, it is convenient to use $s$-dimensional net measures $\mathcal{M}^{s}$. Let $\mathcal{N}$ be the collection of all $d$-dimensional half-open binary cubes, specifically sets of the form

$$
\left[2^{-k} m_{1}, 2^{-k}\left(m_{1}+1\right)\right) \times \cdots \times\left[2^{-k} m_{d}, 2^{-k}\left(m_{d}+1\right)\right)
$$

where $k$ is a nonnegative integer and $m_{1}, \ldots, m_{d}$ are integers. If $E \subset \mathbb{R}^{d}$ and $\delta>0$, define

$$
\mathcal{M}_{\delta}^{s}(E)=\inf \sum_{i}\left|B_{i}\right|^{s}
$$

where the infimum is over all countable $\delta$-covers of $E$ by sets $\left\{B_{i}\right\}$ of $\mathcal{N}$ (we can always assume that the $B_{i}$ are disjoint). $\mathcal{M}_{\delta}^{s}$ is an outer measure on $\mathbb{R}^{d}$ and we let

$$
\mathcal{M}^{s}(E)=\sup _{\delta>0} \mathcal{M}_{\delta}^{s}(E)
$$

$\mathcal{M}^{s}$ and $\mathcal{H}^{s}$ are comparable measures. Precisely, there exists $B_{d}>0$ such that, for every $E \subset \mathbb{R}^{d}$ and any $\delta \in(0,1)$,

$$
\mathcal{H}_{\delta}^{s}(E) \leq \mathcal{M}_{\delta}^{s}(E) \leq B_{d} \mathcal{H}_{\delta}^{s}(E)
$$

We shall need the following very easy lemma:
Lemma 2.2. Let $0<\alpha \leq \beta$, let $E \subset \mathbb{R}^{d}$ and let $\delta>0$. Then

$$
\mathcal{M}_{\delta}^{\alpha}(E) \geq\left(\mathcal{M}_{\delta}^{\beta}(E)\right)^{\beta / \alpha}
$$

Proof. Let $\left(B_{i}\right)$ be a covering of $E$ by elements of $\mathcal{N}$ with diameters not exceeding $\delta$. Then

$$
\mathcal{M}_{\delta}^{\beta}(E) \leq \sum_{i}\left|B_{i}\right|^{\beta} \leq\left(\sum_{i}\left|B_{i}\right|^{\alpha}\right)^{\alpha / \beta}
$$

since $\|\cdot\|_{\beta / \alpha} \leq\|\cdot\|_{1}$. Taking the infimum over such coverings, we immediately get the result.

## 3. Sets with prescribed dimension

3.1. Sets with prescribed Hausdorff dimension. To prove Theorem 1.1, we need to produce a family $\left(E_{\alpha}\right)$ of subsets of $K$ with $\operatorname{dim}_{\mathcal{H}}\left(E_{\alpha}\right)=\alpha$. For technical reasons, we will require that this family of sets is increasing, and that $\mathcal{H}^{\alpha}\left(E_{\alpha}\right)>0$. On $[0,1]^{d}$, this can be done using ubiquity arguments (for instance we can take the sets of real numbers $\beta$ approximable by dyadics for $\beta$ describing $(1,+\infty)$ ). This was the starting point of [BS10]. In our general context, the ubiquity argument will be replaced by the following theorem.

Theorem 3.1. Let $K$ be a compact subset of $\mathbb{R}^{d}$ and let $s=\operatorname{dim}_{\mathcal{H}}(K)$. There exists a family $\left(E_{\alpha}\right)_{\alpha \in(0, s)}$ of compact subsets of $E$ satisfying

- $\forall \alpha \in(0, s), 0<\mathcal{H}^{\alpha}\left(E_{\alpha}\right)<+\infty$;
- $\forall 0<\alpha \leq \beta<s, E_{\alpha} \subset E_{\beta}$.

That for any $\alpha \in(0, s)$ there exists a compact subset $E_{\alpha} \subset E$ with $0<\mathcal{H}^{\alpha}\left(E_{\alpha}\right)<+\infty$ is known since Besicovitch. Inspecting and modifying carefully the construction, we will ensure the second condition.
For $a \in \mathbb{R}$, let $V_{a}$ be the affine subspace $\left\{x \in \mathbb{R}^{d} ; x_{1}=a\right\}$. We denote by $\Gamma(K)$ the interval of the real numbers $\alpha$ less than $s$ and satisfying

$$
\begin{equation*}
\mathcal{H}^{\alpha}\left(K \cap V_{a}\right)=0 \text { for any } a \in \mathbb{R} . \tag{1}
\end{equation*}
$$

We shall first prove Theorem 3.1 with the restriction $\alpha \in \Gamma(K)$. This assumption is needed for the following lemma.
Lemma 3.2. Suppose that (1) holds. Then for any compact set $L \subset K$, for any $k>0$, the map $g: u \mapsto \mathcal{M}_{2^{-k}}^{\alpha}\left(L \cap\left\{x \in \mathbb{R}^{d} ; x_{1} \leq u\right\}\right)$ is continuous.
Proof. Fix $u_{0} \in \mathbb{R}, \varepsilon>0$ and observe that $\mathcal{M}_{2-k}^{\alpha}\left(L \cap V_{u_{0}}\right)=0$. Thus we may find a finite covering $\left(C_{i}\right)$ of $L \cap\left\{x_{1}=u_{0}\right\}$ by dyadic cubes of size less than $2^{-k}$ satisfying

$$
\sum_{i}\left|C_{i}\right|^{\alpha}<\varepsilon
$$

These dyadic cubes also cover $L \cap\left\{u_{0}-\eta_{1}<x<u_{0}\right\}$ for some $\eta_{1}>0$. This yields easily, for any $u \in\left[u_{0}-\eta_{1}, u_{0}\right), g\left(u_{0}\right)-\varepsilon \leq g(u) \leq g\left(u_{0}\right)$. On the other hand, let $\left(B_{i}\right)$ be a covering of $L \cap\left\{x_{1} \leq u_{0}\right\}$ by dyadic cubes of size less than $2^{-k}$ satisfying

$$
\sum_{i}\left|B_{i}\right|^{\alpha}<g\left(u_{0}\right)+\varepsilon .
$$

These cubes also cover $L \cap\left\{x \leq u_{0}+\eta_{2}\right\}$ for some $\eta_{2}>0$, so that $g\left(u_{0}\right) \leq g(u) \leq g\left(u_{0}\right)+\varepsilon$ provided $u \in\left[u_{0}, u_{0}+\eta_{2}\right]$.

We need to introduce the following notation. For a dyadic cube $I=\prod_{j}\left[a_{j}, a_{j}+2^{-k}\right)$ of size $2^{-k}$ and for $u \geq 0$, we shall denote by

$$
I_{\mid u}=I \cap\left(\left[a_{1}, a_{1}+u\right] \times \prod_{j=2}^{d}\left[a_{j}, a_{j}+2^{-k}\right)\right)=I \cap\left\{x \in \mathbb{R}^{d} ; x_{1} \leq a_{1}+u\right\} .
$$

$I_{\mid u}$ should be thought as the beginning of $I$. Observe that $I_{\mid 0}$ is a face of the cube and that $I_{\mid 2^{-k}}=I$. Observe also that, if $J$ is a dyadic cube contained in $I$, then either $J \cap I_{\mid u}$ is empty or $J \cap I_{u}$ is equal to some $J_{\mid v}$.

We now prove Theorem 3.1 with $\alpha$ belonging only to $\Gamma(K)$. We first observe that, for any $\alpha \in \Gamma(K), \mathcal{M}_{1}^{\alpha}(E) \in(0,+\infty)$. We shall build by induction on $k \geq 0$ compact sets $E_{\alpha}^{k}$, $\alpha \in \Gamma(K)$, satisfying the following properties:
(A) For any $\alpha, \beta \in \Gamma(K)$ with $\alpha \leq \beta, E_{\alpha}^{k} \subset E_{\beta}^{k}$;
(B) For any dyadic cube $I$ of size $2^{-(k-1)}$, for any $\alpha \in \Gamma(K)$, either one may find $u \geq 0$ such that $E_{\alpha}^{k} \cap I=K \cap I_{\mid u}$ or $E_{\alpha}^{k} \cap I=\varnothing$;
(C) For any $\alpha \in \Gamma(K), E_{\alpha}^{k+1} \subset E_{\alpha}^{k}$;
(D) For any dyadic cube $I$ of size $2^{-(k-1)}$, for any $\alpha \in \Gamma(K)$,

$$
\mathcal{M}_{2^{-k}}^{\alpha}\left(E_{\alpha}^{k} \cap I\right)=\mathcal{M}_{2^{-(k-1)}}^{\alpha}\left(E_{\alpha}^{k-1} \cap I\right) \leq 2^{-\alpha(k-1)} .
$$

Properties (A) and (B) are those which are new. Property (B) implies that the same result holds automatically for any dyadic cube $J$ contained in $I$.
We initialize the construction by setting $E_{\alpha}^{0}=K$, for any $\alpha \in \Gamma(K)$. Suppose that the sets $E_{\alpha}^{k}$ have been constructed and let us show how to construct $E_{\alpha}^{k+1}$. Let $\alpha \in \Gamma(K)$. We define $E_{\alpha}^{k+1}$ by specifying its intersection with a dyadic cube of size $2^{-k}$. Let $I$ be such a cube and let us consider the two following cases:

- if $\mathcal{M}_{2^{-(k+1)}}^{\alpha}\left(E_{\alpha}^{k} \cap I\right) \leq 2^{-\alpha k}$, then we set $E_{\alpha}^{k+1} \cap I=E_{\alpha}^{k} \cap I$. In that case, properties (B) and (D) are easily satisfied. For (D), we shall observe that $\mathcal{M}_{2^{-k}}^{\alpha}\left(E_{\alpha}^{k} \cap I\right)=$ $\mathcal{M}_{2^{-(k+1)}}^{\alpha}\left(E_{k}^{\alpha} \cap I\right)$ because using a dyadic cube of size $2^{-k}$ gives an estimate at least as large as $2^{\alpha k}$.
- if $\mathcal{M}_{2^{-(k+1)}}^{\alpha}\left(E_{\alpha}^{k} \cap I\right)>2^{-\alpha k}$, then we use the assumption $\alpha \in \Gamma(K)$. It implies that $\mathcal{M}_{2^{-(k+1)}}^{\alpha}\left(E_{\alpha}^{k} \cap I_{\mid 0}\right)=0$ and that the map $u \mapsto \mathcal{M}_{2^{-(k+1)}}^{\alpha}\left(E_{\alpha}^{k} \cap I_{\mid u}\right)$ is continuous. Thus there exists a biggest posive real number $u$ such that $\mathcal{M}_{2^{-(k+1)}}^{\alpha}\left(E_{\alpha}^{k} \cap I_{\mid u}\right)=2^{\alpha k}$. We set $E_{\alpha}^{k+1} \cap I=E_{\alpha}^{k} \cap I_{\mid u}$. Again, (B) and (D) are satisfied since $\mathcal{M}_{2^{-k}}^{\alpha}\left(E_{\alpha}^{k} \cap I\right)=$ $2^{\alpha k}$.
From the construction, $(\mathbf{C})$ is clear. It remains to prove (A). Let $\alpha, \beta \in \Gamma(K)$ with $\alpha \leq \beta$ and let $I$ be a dyadic cube of size $2^{-k}$. On the one hand, if $E_{\beta}^{k+1} \cap I=E_{\beta}^{k} \cap I$, then the induction hypothesis ensures that $E_{\alpha}^{k+1} \cap I \subset E_{\beta}^{k+1} \cap I$. On the other hand, suppose that $E_{\beta}^{k+1} \cap I$ is not equal to $E_{\beta}^{k} \cap I$. We may assume that $E_{\alpha}^{k+1} \cap I \neq \varnothing$ (otherwise there is nothing to prove). Then we write

$$
E_{\beta}^{k+1} \cap I=K \cap I_{\mid u}, E_{\alpha}^{k+1} \cap I=K \cap I_{\mid v},
$$

where $u$ is the biggest real number with that property. Suppose that $v>u$. Then, by maximality of $u$ and by Lemma 2.2 ,

$$
\mathcal{M}_{2^{-(k+1)}}^{\alpha}\left(E_{\alpha}^{k+1} \cap I\right) \geq\left(\mathcal{M}_{2^{-(k+1)}}^{\beta}\left(K \cap I_{\mid v}\right)\right)^{\alpha / \beta}>2^{\alpha k}
$$

a contradiction with (D). Hence, $E_{\alpha}^{k+1} \subset E_{\beta}^{k+1}$ for every dyadic cube of size $2^{-k}$, showing (A).

We finally set $E_{\alpha}=\bigcap_{k} E_{\alpha}^{k}$. That $0<\mathcal{H}^{\alpha}\left(E_{\alpha}\right)<+\infty$ can be obtained exactly as in [Fal85]. That $E_{\alpha} \subset E_{\beta}$ for any $\alpha \leq \beta, \alpha, \beta \in \Gamma(K)$ follows directly from (A).
We now prove the full statement of Theorem 3.1 and we proceed by induction on $d$. The case $d=1$ has already been handled since (1) is always true for any $\alpha>0$. To prove the statement for any value of $d$, let $t=\inf \Gamma(K)(t=s$ provided $\Gamma(K)$ is empty, this can
happen if $s \leq d-1)$. We first assume that $t \in \Gamma(K)$. We already know that there exists a sequence $\left(F_{\alpha}\right)_{\alpha \in[t, s)}$ with $\mathcal{H}^{\alpha}\left(F_{\alpha}\right) \in(0,+\infty)$ and $F_{\alpha} \subset F_{\beta}$ provided $\alpha \leq \beta$.
Let now $\left(\alpha_{k}\right)_{k \geq 1}$ be a sequence in ( $0, t$ ) increasing to $t$ and let $a_{k} \in \mathbb{R}$ be such that $\mathcal{H}^{\alpha_{k}}\left(K \cap V_{a_{k}}\right)>0$ for any $k \geq 1$. We may assume that $\left(a_{k}\right)$ converges to some $a \in \mathbb{R}$ and we set $\alpha_{0}=0, E_{0}=\varnothing$. The induction hypothesis applied to $K \cap V_{a_{k}}$, which is contained in $\mathbb{R}^{d-1}$, gives us for every $k \geq 1$ an increasing sequence $\left(F_{\alpha}^{k}\right)_{0<\alpha \leq \alpha_{k}}$ of compact subsets of $K \cap V_{a_{k}}$ satisfying $\mathcal{H}^{\alpha}\left(F_{\alpha}^{k}\right) \in(0,+\infty)$ (we may include $\alpha=\alpha_{k}$ by looking first at a compact subset $K_{k}$ of $K \cap V_{a_{k}}$ with $\left.\mathcal{H}^{\alpha_{k}}\left(K_{k}\right) \in(0,+\infty)\right)$.
We define the sets $E_{\alpha}$, for $0<\alpha<t$, in the following way. Each such $\alpha$ belongs to an unique interval ( $\alpha_{k-1}, \alpha_{k}$ ], and we set (inductively) $E_{\alpha}=F_{\alpha}^{k} \cup E_{\alpha_{k-1}}$. It is worth noting that

$$
E_{\alpha} \subset K \cap\left(\bigcup_{k} V_{a_{k}} \cup V_{a}\right)=: W,
$$

which is a compact subset of $K$. The sets $F_{\alpha}$, for $\alpha \geq t$, do not necessarily contain $E_{\beta}$, for $\beta<t$. This leads us to set, for $\alpha \geq t, E_{\alpha}=F_{\alpha} \cup W$. This does not affect their $\alpha$-dimensional Hausdorff measure, since

$$
\mathcal{H}^{t}(W) \leq \sum_{k} \mathcal{H}^{t}\left(K \cap V_{a_{k}}\right)+\mathcal{H}^{t}\left(K \cap V_{a}\right)=0 .
$$

We finally assume that $t \notin \Gamma(K)$, so that $\mathcal{H}^{t}\left(K \cap V_{a}\right)>0$ for some $a \in \mathbb{R}$. We apply the induction hypothesis to $K \cap V_{a}$ to obtain an increasing family $\left(E_{\alpha}\right)_{0<\alpha \leq t}$ of compact sets satisfying $0<\mathcal{H}^{\alpha}\left(E_{\alpha}\right)<+\infty$ for any $\alpha \in(0, t]$. We also know how to construct a similar family $\left(F_{\alpha}\right)_{t<\alpha<s}$. We just modify slightly this last family by setting $E_{\alpha}=F_{\alpha} \cup E_{t}$ for $t>s$. It satisfies all the requirements of Theorem 3.1.
Remark 3.3. The proof of Theorem 3.1 is really specific to the net structure. We do not know whether a similar result does exist on general metric spaces.
3.2. Sets with prescribed packing dimension. Let $K$ be a compact set with packing dimension $s$. A result of H. Joyce and D. Preiss ([JP95]) ensures that, for any $\alpha \in(0, s)$, there exists $E_{\alpha} \subset K$ compact with $0<\mathcal{P}^{\alpha}\left(E_{\alpha}\right)<+\infty$. We would like to find an increasing family $\left(E_{\alpha}\right)_{0<\alpha<s}$. We do not know whether this is possible in full generality. However, let us show how to construct such a family in the context of self-similar compact sets.
We recall that a compact subset $K$ of $\mathbb{R}^{d}$ is called self-similar if there are finitely many contractive similarity maps $S_{1}, \ldots, S_{m}: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ such that $K=\bigcup_{i} S_{i}(K)$. We denote by $r_{1}, \ldots, r_{m}$ the ratios of these maps. $K$ is said to satisfy the Open Set Condition if there is an open, non-empty and bounded subset $\mathcal{O}$ of $\mathbb{R}^{d}$ such that $S_{i}(\mathcal{O}) \subset \mathcal{O}$ for all $i$ and $S_{i}(\mathcal{O}) \cap S_{j}(\mathcal{O})=\varnothing$ for all $i \neq j$.
Proposition 3.4. Let $K$ be a self-similar compact subset of $\mathbb{R}^{d}$ satisfying the Open Set Condition. Let $s=\operatorname{dim}_{\mathcal{P}}(K)=\operatorname{dim}_{\mathcal{H}}(K)$. There exists a family $\left(E_{\alpha}\right)_{0<\alpha<s}$ of compact subsets of $\mathbb{R}^{d}$ satisfying

$$
\forall \alpha \in(0, s), \mathcal{H}^{\alpha}\left(E_{\alpha}\right)>0 \text { and } \operatorname{dim}_{\mathcal{P}}\left(E_{\alpha}\right) \leq \alpha .
$$

Proof. We shall use two results regarding Besicovitch subsets of self-similar compact sets. We need to introduce notations. Let $\Sigma=\{1, \ldots, m\}^{\mathbb{N}}$ be the symbolic space and let $\Sigma^{*}=\bigcup_{n}\{1, \ldots, m\}^{n}$ be the family of all finite lists with entries in $\{1, \ldots, m\}$. For $\mathbf{i} \in \Sigma$ and a positive integer $n$, let $\mathbf{i} \mid n$ denote the truncation of $\mathbf{i}$ to the $n$-th place. Finally, for $\mathbf{i}=i_{1} \ldots i_{n} \in \Sigma^{*}$, we write $S_{\mathbf{i}}=S_{i_{1}} \circ \cdots \circ S_{i_{n}}$ and $K_{\mathbf{i}}=S_{\mathbf{i}} K$. We define a map $\pi: \Sigma \rightarrow K$ by $\{\pi(\mathbf{i})\}=\bigcap_{n} K_{\mathbf{i} \mid n}$.

We then define $m$ maps $\Pi_{i}: \Sigma^{*} \rightarrow \mathbb{R}$ by

$$
\Pi_{i}(\mathbf{i})=\frac{\left|\left\{1 \leq j \leq n ; i_{j}=i\right\}\right|}{n}
$$

namely $\Pi_{i}(\mathbf{i})$ gives the frequency of the digit $i$ in $\mathbf{i}$. Let $\Pi=\left(\Pi_{1}, \ldots, \Pi_{m}\right)$ be the vector of the frequencies of the digits. For $\mathbf{i} \in \Sigma$, let $A(\mathbf{i})$ denote the set of accumulation points of $\Pi(\mathbf{i} \mid n) . A(\mathbf{i})$ is contained in $\Delta$, the simplex of the probability vectors in $\mathbb{R}^{m}$, namely $\Delta=\left\{\mathbf{p}=\left(p_{1}, \ldots, p_{m}\right) \in \mathbb{R}^{m} ; p_{j} \geq 0\right.$ and $\left.\sum_{j} p_{j}=1\right\}$.
One can control the dimension of $\Pi(\mathbf{i})$ such that $A(\mathbf{i})$ belongs to a fixed subset of $\Delta$. This involves the notion of entropy. Define $\Lambda: \Delta \rightarrow \mathbb{R}$ by

$$
\Lambda(\mathbf{p})=\frac{\sum_{j} p_{j} \log p_{j}}{\sum_{j} p_{j} \log r_{j}}
$$

In particular, since $s$ satisfies $r_{1}^{s}+\cdots+r_{m}^{s}=1$,

$$
\Lambda\left(r_{1}^{s}, \ldots, r_{m}^{s}\right)=s
$$

For $C$ a subset of $\Delta$, we define

$$
K(C)=\pi(\{\mathbf{i} \in \Sigma ; A(\mathbf{i}) \subset C\}) \subset K
$$

The first result that we need is due to J-H. Ma, Z-Y. Wen and J. Wu in [MWW02].

$$
\text { For any } \mathbf{p} \in \Delta, \mathbf{p} \neq\left(r_{1}^{s}, \ldots, r_{m}^{s}\right), \mathcal{H}^{\Lambda(\mathbf{p})}\left(K\left(\left\{p_{1}, \ldots, p_{m}\right\}\right)\right)>0
$$

The second result that we need is due to L. Olsen and S. Winter in [OW03].

$$
\text { For any compact and convex set } C \subset \Delta, \operatorname{dim}_{\mathcal{P}}(K(C))=\sup _{\mathbf{p} \in C} \Lambda(\mathbf{p})
$$

For any $\lambda \in[0,1]$, we define

$$
\begin{aligned}
C(\lambda) & =\left\{\mathbf{p} \in \Delta ; 0 \leq p_{j} \leq \lambda r_{j}^{s} \text { for any } j=1, \ldots, m-1\right\} \\
f(\lambda) & =\max _{\mathbf{p} \in C(\lambda)} \Lambda(\mathbf{p})
\end{aligned}
$$

$f$ is continuous, nondecreasing and satisfies $f(0)=0, f(1)=s$. For any $\alpha \in(0, s)$, we define $g(\alpha)=\sup \{\lambda \in[0,1] ; f(\lambda)=\alpha\} . g$ is a right-inverse of $f$ and it is increasing. Finally, let us set $E_{\alpha}=K(C(g(\alpha)))$. The family $\left(E_{\alpha}\right)_{0<\alpha<s}$ is increasing and $\operatorname{dim}_{\mathcal{P}}\left(E_{\alpha}\right)=$ $f \circ g(\alpha)=\alpha$. Moreover, let $\mathbf{p}^{\alpha} \in C(g(\alpha))$ be such that $\Lambda\left(\mathbf{p}^{\alpha}\right)=\alpha$. Then

$$
\mathcal{H}^{\alpha}(K(C(g(\alpha)))) \geq \mathcal{H}^{\alpha}\left(K\left(\left\{p_{1}^{\alpha}, \ldots, p_{m}^{\alpha}\right\}\right)\right)>0
$$

## 4. Multifractal measures - the Hausdorff case

4.1. At a fixed level. To construct multifractal measures on $K$, we begin by fixing some compact subset $E$ of $K$ and by building plenty measures $\mu \in \mathcal{P}(K)$ so that $E \subset \mathcal{E}_{-}(\mu ; \alpha)$ with $\operatorname{dim}_{\mathcal{H}} E=\alpha$. This is reminiscent from Lemma 3.5 of [Cut95] but our result is more precise (and the method of proof is different). Without loss of generality, we may assume that $K$ is infinite.

Proposition 4.1. Let $E$ be a compact subset of $K$ and let $\alpha>0$. Assume that $\mathcal{H}^{\alpha}(E)<$ $+\infty$. Then there exists a dense $G_{\delta}$-subset $\mathcal{R}_{E}$ in $\mathcal{P}(K)$ such that, for any $\mu \in \mathcal{R}_{E}$, $E \subset \mathcal{E}_{-}(\mu ; \alpha)$.

Proof. We first assume that $\mathcal{H}^{\alpha}(E)=0$. Then for any $n \geq 1$, we can find a set $\mathcal{B}_{n}$ of balls with diameters less than $2^{-n}$, covering $E$, and such that

$$
\sum_{B \in \mathcal{B}_{n}}|B|^{\alpha} \leq 2^{-(n+1)}
$$

We may assume that $\mathcal{B}_{n}$ is finite and let $\rho_{n}$ be the minimum of the diameters of the balls in $\mathcal{B}_{n}$. We set $\mathcal{C}_{n}=\bigcup_{B \in \mathcal{B}_{n}} B$.
Let $\left(\omega_{n}\right)$ be an increasing sequence of positive real numbers going to $+\infty$ and such that

$$
\sum_{n \geq 1} \omega_{n} \sum_{B \in \mathcal{B}_{n}}|B|^{\alpha}=1
$$

We set

$$
\mu_{0}=\sum_{n \geq 1} \omega_{n} \sum_{B \in \mathcal{B}_{n}}|B|^{\alpha} \delta_{x_{B}}
$$

where $x_{B}$ denotes the center of the ball $B$. Let now $\nu \in \mathcal{F}(K)$ and let $N$ be the number of elements in the support of $\nu$. We define

$$
\mu_{\nu}=\left(1-\frac{1}{N}\right) \nu+\frac{1}{N} \mu_{0}
$$

Since $K$ is infinite, $\left\{\mu_{\nu}\right\}_{\nu \in \mathcal{F}(K)}$ is dense in $\mathcal{P}(K)$. Let now $l \geq 1$ and let $n \geq l$. For any $y \in \mathcal{C}_{n}$, we may find a ball $B \in \mathcal{B}_{n}$ with radius $r \in\left[\rho_{n}, 2^{-n}\right]$ so that $y \in B$, namely $x_{B} \in B(y, r)$. Thus

$$
\begin{aligned}
\mu_{\nu}(B(y, r)) & \geq \frac{1}{N} \mu_{0}(B(y, r)) \\
& \geq \frac{\omega_{n}}{N} r^{\alpha} \\
& \geq 4^{\alpha} r^{\alpha}
\end{aligned}
$$

provided $n$ is large enough. We shall denote this integer by $n_{\nu, l}$. By Lemma 2.1, one can find $\eta_{\nu, l}>0$ such that any $\mu \in \mathcal{P}(K)$ with $L\left(\mu, \mu_{\nu}\right)<\eta_{\nu, l}$ satisfies, for any $y \in \mathcal{C}_{n_{\nu, l}}$ and for the associated $r>0$,

$$
\mu(B(y, 2 r)) \geq \mu_{\nu}(B(y, r))-2^{\alpha} \rho_{n_{\nu, l}} \geq 2^{\alpha} r^{\alpha}
$$

We finally consider the dense $G_{\delta}$-set

$$
\mathcal{R}_{E}=\bigcap_{l \geq 1} \bigcup_{\mu_{\nu} \in \mathcal{F}(K)} B_{L}\left(\nu, \eta_{\nu, l}\right)
$$

Pick $\mu \in \mathcal{R}_{E}$. For any $l \geq 1$, there exists $\nu \in \mathcal{F}(K)$ such that $\mu \in B_{L}\left(\mu_{\nu}, \eta_{\nu, l}\right)$. Any $y \in E$ belongs to $\mathcal{C}_{n_{\nu, l}}$ so that there exists $0<r \leq 2^{-n_{\nu, l}} \leq 2^{-l}$ with

$$
\mu(B(y, 2 r)) \geq 2^{\alpha} r^{\alpha}
$$

This means that $E \subset \mathcal{E}_{-}(\mu ; \alpha)$.
Suppose now that we have the weaker assumption $\mathcal{H}^{\alpha}(E)<+\infty$. For any $\beta>\alpha, \mathcal{H}^{\beta}(E)=$ 0 and the first part tells us that we can find a residual subset $\mathcal{R}_{\beta} \subset \mathcal{P}(K)$ such that, for any $\mu \in \mathcal{R}_{\beta}, \mathcal{E}_{-}(\mu ; \beta) \supset E$. Let $\left(\beta_{k}\right)$ be a decreasing sequence of positive real numbers going to $\alpha$ and let $\mathcal{R}=\bigcap_{k} \mathcal{R}_{\beta_{k}}$. $\mathcal{R}$ keeps being a residual subset of $\mathcal{P}(K)$ and, taking the limit, $\mathcal{E}_{-}(\mu ; \alpha) \supset E$.
4.2. Multifractal measures. We now prove Theorem 1.1. We start with $K$ a compact subset of $\mathbb{R}^{d}$ with $\operatorname{dim}_{\mathcal{H}}(K)=s$. Let $\left(E_{\alpha}\right)_{0<\alpha<s}$ be the family of sets given by Theorem 3.1. We also pick $\left(\alpha_{k}\right)$ a dense sequence in $(0, s)$. For each $k$, Proposition 4.1 gives us a residual subset $\mathcal{R}_{k}$ such that

$$
\mu \in \mathcal{R}_{k} \Longrightarrow E_{\alpha_{k}} \subset \mathcal{E}_{-}\left(\mu ; \alpha_{k}\right)
$$

We set $\mathcal{R}=\bigcap_{k} \mathcal{R}_{k}$ and we claim that $\mathcal{R}$ is the residual subset we are looking for. Indeed, let $\mu \in \mathcal{R}$ and let $\alpha \in(0, s)$. We consider a subsequence $\left(\alpha_{\varphi(k)}\right)$ decreasing to $\alpha$. Since, for any $k$,

$$
E_{\alpha} \subset E_{\alpha_{\varphi(k)}} \subset \mathcal{E}_{-}\left(\mu ; \alpha_{\varphi(k)}\right)
$$

we get by taking the limit $E_{\alpha} \subset \mathcal{E}_{-}(\mu ; \alpha)$. We then split $E_{\alpha}$ into two parts:

$$
\begin{aligned}
& E_{\alpha}^{1}=\left\{x \in E_{\alpha} ; \underline{\operatorname{dim}}_{\mathrm{loc}}(\mu ; x)=\alpha\right\} \\
& E_{\alpha}^{2}=\left\{x \in E_{\alpha} ; \underline{\operatorname{dim}}_{\mathrm{loc}}(\mu ; x)<\alpha\right\}
\end{aligned}
$$

The crucial point is $\mathcal{H}^{\alpha}\left(E_{\alpha}^{2}\right)=0$. Indeed, $E_{\alpha}^{2}$ is contained in a countable union of sets $\mathcal{E}_{-}(\mu ; \beta), \beta<\alpha$, and these sets satisfy $\mathcal{H}^{\alpha}\left(\mathcal{E}_{-}(\mu ; \beta)\right)=0$. On the contrary, $\mathcal{H}^{\alpha}\left(E_{\alpha}\right)>0$. We then conclude that $\mathcal{H}^{\alpha}\left(E_{\alpha}^{1}\right)>0$ and $E_{\alpha}^{1} \subset E_{-}(\mu ; \alpha)$. Hence, this last set has Hausdorff dimension equal to $\alpha$.
When $\mathcal{H}^{s}(K)>0$, we can include $\alpha=\operatorname{dim}_{\mathcal{H}}(K)$ in the statement. Indeed, we can always assume that $0<\mathcal{H}^{s}(K)<+\infty$ and then we set $E_{s}=K$. The rest of the proof is unchanged.

## 5. Multifractal measures - the packing case

5.1. Obstructions to residuality of multifractal measures. In this subsection, we prove Theorem 1.2. We first observe that it is enough to prove that, for any $s \in$ $\left(0, \overline{\operatorname{dim}}_{B, \text { loc }}(K)\right)$, a typical measure $\mu \in \mathcal{P}(K)$ satisfies $\overline{\operatorname{dim}}_{\mathrm{loc}}(\mu ; x) \geq s$ for any $x \in K$. Taking a sequence $\left(s_{k}\right)$ increasing to $\overline{\operatorname{dim}}_{B, \mathrm{loc}}(K)$ and the countable intersection of residual sets, we will find the desired statement. Thus, let us fix $s \in\left(0, \overline{\operatorname{dim}}_{B, \operatorname{loc}}(K)\right)$ and let $m>l \geq 1$. We define

$$
\mathcal{U}_{l, m}=\left\{\mu \in \mathcal{P}(K) ; \forall x \in K, \exists r \in(1 / m, 1 / l) \text { s.t. } \mu(B(x, r))<r^{s}\right\} .
$$

It is easy to check that any $\mu$ in $\bigcap_{l \geq 1} \bigcup_{m>l} \mathcal{U}_{l, m}$ satisfies $\overline{\operatorname{dim}}_{\text {loc }}(\mu ; x) \geq s$ for any $x \in K$. Hence, we just need to prove the two following facts.

Fact 1: Each $\mathcal{U}_{l, m}$ is open.
Fact 2: For any $l \geq 1, \bigcup_{m>l} \mathcal{U}_{l, m}$ is dense.
To prove Fact 1, we pick $\mu \in \mathcal{U}_{l, m}$. Then, for any $x \in K$, we may find $r_{x} \in(1 / m, 1 / l)$ such that $\mu\left(B\left(x, r_{x}\right)\right)<r_{x}^{s}$. Let $\varepsilon_{x} \in(0,1)$ be small enough so that

$$
\left\{\begin{aligned}
\left(1-2 \varepsilon_{x}\right) r_{x} & >1 / m \\
\mu\left(B\left(x, r_{x}\right)\right) & <\left(1-3 \varepsilon_{x}\right)^{s} r_{x}^{s}
\end{aligned}\right.
$$

We set $\eta_{x}=\varepsilon_{x} r_{x}$. For any $y \in B\left(x, \eta_{x}\right)$, the ball $B\left(y,\left(1-\varepsilon_{x}\right) r_{x}\right)$ is contained in $B\left(x, r_{x}\right)$ so that $\mu\left(B\left(y,\left(1-\varepsilon_{x}\right) r_{x}\right)\right)<\left(1-3 \varepsilon_{x}\right) r_{x}^{s}$. The compact set $K$ may be covered by a finite number of balls $B\left(x_{i}, \eta_{i}\right), i=1, \ldots, m$. Let $\eta>0$ be given by Lemma 2.1 with $\alpha=\inf _{i} \varepsilon_{i} r_{i}$ and $\beta=\inf _{i}\left(\left(1-2 \varepsilon_{i}\right)^{s} r_{i}^{s}-\left(1-3 \varepsilon_{i}\right)^{s} r_{i}^{s}\right)$. Let $\nu \in \mathcal{P}(K)$ with $L(\mu, \nu)<\eta$ and let $y \in K$. Then $y$ belongs to some $B\left(x_{i}, \eta_{i}\right)$ and

$$
\nu\left(B\left(y,\left(1-2 \varepsilon_{i}\right) r_{i}\right)\right) \leq \mu\left(B\left(y,\left(1-\varepsilon_{i}\right) r_{i}\right)+\beta \leq\left(1-2 \varepsilon_{i}\right)^{s} r_{i}^{s}\right.
$$

This shows that $\nu$ belongs to $\mathcal{U}_{l, m}$ and that $\mathcal{U}_{l, m}$ is open.
Let us now prove Fact 2. Let $l \geq 1, \mu=\sum_{i=1}^{n} p_{i} \delta_{x_{i}} \in \mathcal{F}(K)$ and $\eta>0$. We need to find $\nu \in \bigcup_{m>l} \mathcal{U}_{l, m}$ and $L(\mu, \nu)<\eta$. Let $\rho>0$ satisfying

$$
\rho<4 \min \left(\left\|x_{i}-x_{j}\right\| ; i \neq j\right) \text { and } \rho<\eta .
$$

For each $i \in\{1, \ldots, n\}, \overline{\operatorname{dim}}_{B}\left(K \cap B\left(x_{i}, \rho\right)\right)>s$. This implies that we may find $N_{i}$ as large as we want and points $x_{i, 1}, \ldots, x_{i, N_{i}}$ in $K \cap B\left(x_{i}, \rho\right)$ which are the centers of disjoint balls of radius $4 N_{i}^{-s}$. We assume that the integers $N_{i}$ are sufficiently large so that the balls $B\left(x_{i}, \rho+4 N_{i}^{-s}\right)$ are pairwise disjoint and we also assume that $2 \sup _{i} N_{i}^{-s}<1 / l$. We set

$$
\mu_{i}=\frac{1}{N_{i}} \sum_{j=1}^{N_{i}} \delta_{x_{i, j}} \text { and } \nu=\sum_{i=1}^{n} p_{i} \mu_{i} .
$$

We claim that $\nu$ belongs to $\bigcup_{m>l} \mathcal{U}_{l, m} \cap B_{L}(\mu, \eta)$. Indeed, for any $f \in \operatorname{Lip}(K)$,

$$
\left|\int f d \mu-\int f d \nu\right| \leq \sum_{i} p_{i} \int\left|f-f\left(x_{i}\right)\right| d \mu_{i} \leq \rho<\eta
$$

On the other hand, let $m>l$ be such that $\frac{1}{m}<\inf _{i} N_{i}^{-s}$ and let $x \in K$.

- either $x$ belongs to some $B\left(x_{i}, \rho+2 N_{i}^{-s}\right)$. We set $r=2 N_{i}^{-s} \in(1 / m, 1 / l)$. At most one point $x_{i, j}, j=1, \ldots, N_{i}$, may belong to $B(x, r)$ since $\left\|x_{i, j}-x_{i, l}\right\|>2 r$ for $j \neq l$. Hence,

$$
\nu(B(x, r)) \leq \frac{1}{N_{i}}<r^{s} .
$$

- or $x$ does not belong to any $B\left(x_{i}, \rho+2 N_{i}^{-s}\right)$. In that case, we let $r=2 \inf _{i} N_{i}^{-s}$ and we observe that

$$
\nu(B(x, r))=0<r^{s} .
$$

This yields $\nu \in \mathcal{U}_{l, m}$. Hence $\bigcup_{m>l} \mathcal{U}_{l, m}$ is dense in $\mathcal{P}(K)$, which achieves the proof of Theorem 1.2.
5.2. Existence of one multifractal measure. We now investigate the existence of at least one measure with linear upper singularity spectrum. Our starting point is an analogue of Proposition 4.1.
Lemma 5.1. Let $E$ be a compact subset of $K$ and let $\alpha>0$. Assume that $\mathcal{P}^{\alpha}(E)<+\infty$. Then there exists $\mu \in \mathcal{P}(K)$ such that $E \subset \mathcal{E}^{+}(\mu ; \alpha)$.
Proof. Let $\left(\alpha_{k}\right)$ be a sequence decreasing to $\alpha$, so that $\operatorname{dim}_{\mathcal{P}}(E)<\alpha_{k}$. A result of C. Tricot ([Tri82]) ensures that there exists $\mu_{k} \in \mathcal{P}(K)$ such that, for any $x \in E, \overline{\operatorname{dim}}_{\text {loc }}(\mu ; x) \leq \alpha_{k}$. We now define $\mu=\sum_{k} 2^{-k} \mu_{k}$ and we observe that, for any $x \in E$ and any $k \geq 1$,

$$
\overline{\operatorname{dim}}_{\mathrm{loc}}(\mu ; x) \leq \overline{\operatorname{dim}}_{\mathrm{loc}}\left(\mu_{k} ; x\right) \leq \alpha_{k} .
$$

Taking the limit, we get $E \subset \mathcal{E}^{+}(\mu ; \alpha)$.
Proof of Theorem 1.5. We start with an increasing family of sets $\left(E_{\alpha}\right), 0<\alpha<\operatorname{dim}_{\mathcal{P}}(K)$, with $\operatorname{dim}_{\mathcal{P}}(K)=\alpha$ and $\mathcal{P}^{\alpha}\left(E_{\alpha}\right)>0$. Let $\left(\alpha_{k}\right)$ be a sequence dense in $\left(0, \operatorname{dim}_{\mathcal{P}}(K)\right)$ and let $\mu_{k}$ be given by Lemma 5.1 for $\alpha=\alpha_{k}$ and $E=E_{\alpha_{k}}$. We set $\mu=\sum_{k} 2^{-k} \mu_{k}$ and we claim that $\operatorname{dim}_{\mathcal{P}}\left(\mathcal{E}^{+}(\mu ; \alpha)\right)=\alpha$ for any $\alpha \in\left(0, \operatorname{dim}_{\mathcal{P}}(K)\right)$.

Indeed, let us fix $\alpha \in\left(0, \operatorname{dim}_{\mathcal{P}}(K)\right)$ and let $\left(\alpha_{\phi(k)}\right)$ be a subsequence of $\left(\alpha_{k}\right)$ decreasing to $\alpha$. Since $E \subset \bigcap_{k} E_{\alpha_{\phi(k)}}$ and since

$$
\overline{\operatorname{dim}}_{\mathrm{loc}}(\mu ; x) \leq \overline{\operatorname{dim}}_{\mathrm{loc}}\left(\mu_{\phi(k)} ; x\right) \leq \alpha_{\phi(k)}
$$

for any $x \in E_{\alpha_{\phi(k)}}$, one gets $E_{\alpha} \subset \mathcal{E}^{+}(\mu ; \alpha)$. We then argue like in the proof of Theorem 1.1, splitting $E_{\alpha}$ into two parts:

$$
\begin{aligned}
& E_{\alpha}^{1}=\left\{x \in E_{\alpha} ; \overline{\operatorname{dim}}_{\mathrm{loc}}(\mu ; x)=\alpha\right\} \\
& E_{\alpha}^{2}=\left\{x \in E_{\alpha} ; \overline{\operatorname{dim}}_{\mathrm{loc}}(\mu ; x)<\alpha\right\} .
\end{aligned}
$$

Since $\mathcal{P}^{\alpha}\left(E_{\alpha}^{2}\right)=0$ and $\mathcal{P}^{\alpha}\left(E_{\alpha}\right)>0$, one gets $\mathcal{P}^{\alpha}\left(E_{\alpha}^{1}\right)>0$, exactly what is needed to conclude.

Assume now that our sequence of sets $\left(E_{\alpha}\right)$ satisfies not only $\mathcal{P}^{\alpha}\left(E_{\alpha}\right)>0$, but also $\mathcal{H}^{\alpha}\left(E_{\alpha}\right)>0$. In that case, we split $E_{\alpha}$ into

$$
\begin{aligned}
& F_{\alpha}^{1}=\left\{x \in E_{\alpha} ; \underline{\operatorname{dim}}_{\mathrm{loc}}(\mu ; x) \geq \alpha\right\} \\
& F_{\alpha}^{2}=\left\{x \in E_{\alpha} ; \underline{\operatorname{dim}}_{\mathrm{loc}}(\mu ; x)<\alpha\right\} .
\end{aligned}
$$

Then $\mathcal{H}^{\alpha}\left(F_{\alpha}^{1}\right)>0$ and $\operatorname{dim}_{\mathcal{P}}\left(F_{\alpha}^{1}\right) \leq \operatorname{dim}_{\mathcal{P}}\left(E_{\alpha}\right) \leq \alpha$, showing that $\operatorname{dim}_{\mathcal{H}}\left(F_{\alpha}^{1}\right)=\operatorname{dim}_{\mathcal{P}}\left(F_{\alpha}^{1}\right)=$ $\alpha$. Moreover any $x \in F_{\alpha}^{1}$ satisfies

$$
\alpha \leq \underline{\operatorname{dim}}_{\mathrm{loc}}(\mu ; x) \leq \overline{\operatorname{dim}}_{\mathrm{loc}}(\mu ; x) \leq \alpha
$$

which yields the second part of Theorem 1.5.

## 6. Applications

6.1. Multifractal formalism. Let $\mu \in \mathcal{P}(K)$. The lower $L^{q}$-spectrum of $\mu$ is defined by

$$
\underline{D}_{\mu}(q)=\liminf _{r \rightarrow 0} \frac{\log \int_{K}(\mu(B(x, r)))^{q-1} d \mu(x)}{\log r} .
$$

It is well-known (see [BMP92, Ols95]) that the Legendre transform of $\mu$ is an upper bound for the multifractal spectrum of $\mu$ : for any $\alpha \geq 0$,

$$
\operatorname{dim}_{\mathcal{H}}\left(E_{-}(\mu ; \alpha)\right) \leq\left(\underline{D}_{\mu}\right)^{*}(\alpha)=: \inf _{q \in \mathbb{R}}\left(q \alpha-\underline{D}_{\mu}(q)\right) .
$$

For many specific measures (like self-similar measures), this upper bound turns out to be an equality. We say that the measure satisfies the multifractal formalism at $\alpha$ if the previous equality holds for $\alpha$. The validity of the multifractal formalism is a very important issue in Physics: when it is known to be satisfied, we can estimate the singularity spectrum of real datas through the singularity spectrum.

We now show that, in any compact subset of $\mathbb{R}^{d}$, a typical measure satisfies the multifractal formalism.

Theorem 6.1. Let $K$ be a compact subset of $\mathbb{R}^{d}$. A typical measure $\mu \in \mathcal{P}(K)$ satisfies

$$
\operatorname{dim}_{\mathcal{H}}\left(E_{-}(\mu ; \alpha)\right)=\left(\underline{D}_{\mu}\right)^{*}(\alpha) \quad \text { for any } \alpha \in\left[0, \operatorname{dim}_{\mathcal{H}}(K)\right) .
$$

Proof. By [Bay12] and [Ols05], we know that a typical measure $\mu \in \mathcal{P}(K)$ satisfies

$$
\underline{D}_{\mu}(q)= \begin{cases}0 & \text { if } q \geq 1 \\ -s(1-q) & \text { if } q \in[0,1) \\ -\infty & \text { if } q<0,\end{cases}
$$

where $s$ is the upper-box dimension of $K$. Then it is easy to check that, for any $\alpha \in[0, s]$, $\left(\underline{D}_{\mu}\right)^{*}(\alpha)=\alpha$. We conclude by comparing this with the statement of Theorem 1.1 (recall that $\left.\operatorname{dim}_{\mathcal{H}}(K) \leq s\right)$.
6.2. Prevalence. In this paper, we are mainly concerned with genericity in the sense of Baire theorem. We can also consider other notions of genericity. In particular, genericity in the sense of prevalence has been proved to be relevant in multifractal analysis (see for instance [FJ06], [Ols10b], [Ols10a] or [BH11]). Prevalence is an infinite-dimensional version of "almost-everywhere". It has been defined by Anderson and Zame [AZ01] in the context of convex subsets of vector spaces (see also [OY05]).
Let $X$ be a topological vector space and let $C \subset X$ be a convex subset of $X$ which is completely metrizable in the relative topology induced from $X$. Fix a Borel set $E \subset C$ and $c \in C$. We say that $E$ is shy in $C$ at $c$ if, for any $\eta>0$ and any neighbourhood $U$ of 0 , there is a Borel probability measure $\Lambda$ on $X$ such that
(1) $\operatorname{supp}(\Lambda)$ is compact and $\operatorname{supp}(\Lambda) \subset U+c$;
(2) $\operatorname{supp}(\Lambda) \subset \eta C+(1-\eta) c$;
(3) for all $x \in E$, we have $\Lambda(x+E)=0$.

A Borel subset of $C$ is said prevalent if its complement (in $C$ ) is shy in $C$ at some point $c \in C$.

The behaviour of the multifractal spectrum for a prevalent measure was first studied by Olsen in [Ols10a]. He shows that, for any $\alpha>0$, a prevalent measure $\mu \in \mathcal{P}(K)$ satisfies

$$
\begin{aligned}
\operatorname{dim}_{\mathcal{H}}\left(\mathcal{E}_{-}(\mu ; \alpha)\right) & =\sup _{\nu \in \mathcal{P}(K)} \operatorname{dim}_{\mathcal{H}}\left(\mathcal{E}_{-}(\nu ; \alpha)\right) \\
\operatorname{dim}_{\mathcal{P}}\left(\mathcal{E}^{+}(\mu ; \alpha)\right) & =\sup _{\nu \in \mathcal{P}(K)} \operatorname{dim}_{\mathcal{P}}\left(\mathcal{E}_{+}(\nu ; \alpha)\right) .
\end{aligned}
$$

When $K$ is a self-similar compact set satisfying the Open Set Condition, he concludes that for any $\alpha \in\left[0, \operatorname{dim}_{\mathcal{H}}(K)\right]$, a prevalent measure $\mu \in \mathcal{P}(K)$ satisfies $\operatorname{dim}_{\mathcal{H}}\left(\mathcal{E}_{-}(\mu ; \alpha)\right)=$ $\operatorname{dim}_{\mathcal{P}}\left(\mathcal{E}^{+}(\mu ; \alpha)\right)=\alpha$.
An application of Proposition 4.1 shows that the assumption " $K$ is a self-similar compact set satisfying the Open Set Condition" is not needed to obtain this conclusion in the Hausdorff case. We can go much further, replacing $\mathcal{E}_{-}(\mu ; \alpha)$ by $E_{-}(\mu ; \alpha)$ and obtaining that a prevalent measure works for any $\alpha$.
Theorem 6.2. Let $K$ be a compact subset of $\mathbb{R}^{d}$. Then a prevalent measure $\mu \in \mathcal{P}(K)$ satisfies, for any $\alpha \in\left[0, \operatorname{dim}_{\mathcal{H}}(K)\right)$,

$$
\operatorname{dim}_{\mathcal{H}}\left(E_{-}(\mu ; \alpha)\right)=\alpha .
$$

If $K$ is a self-similar compact set satisfying the Open Set Condition, then a prevalent measure $\mu \in \mathcal{P}(K)$ satisfies, for any $\alpha \in\left[0, \operatorname{dim}_{\mathcal{H}}(K)\right)$,

$$
\operatorname{dim}_{\mathcal{H}}(E(\mu ; \alpha))=\operatorname{dim}_{\mathcal{P}}(E(\mu ; \alpha))=\alpha .
$$

Proof. We shall see that the existence of one measure with a linear multifractal spectrum implies that a prevalent measure shares the same property. We just prove the first statement, the second one being completely similar. We fix $a \in K$ and let

$$
M=\left\{\mu \in \mathcal{P}(K) ; \exists \alpha \in\left(0, \operatorname{dim}_{\mathcal{H}}(K)\right), \operatorname{dim}_{\mathcal{H}}\left(E_{-}(\mu ; \alpha)\right)<\alpha\right\}
$$

We show that $M$ is a shy in $\mathcal{P}(K)$ at $\delta_{a}$. Namely, given $\eta>0$ and $U$ a neighbourhood of 0 in $\mathcal{M}(K)$, we have to construct a Borel probability measure $\Lambda$ on $\mathcal{M}(K)$ satisfying the following conditions:
(1) $\operatorname{supp}(\Lambda)$ is compact and $\operatorname{supp}(\Lambda) \subset U+\delta_{a}$;
(2) $\operatorname{supp}(\Lambda) \subset \eta \mathcal{P}(K)+(1-\eta) \delta_{a}$;
(3) for all $\mu \in \mathcal{M}(K), \Lambda(\mu+M)=0$.

Let $\Theta$ be a multifractal probability measure on $K$ given by Theorem 1.1. Moreover, we ask that for any $\alpha \in\left(0, \operatorname{dim}_{\mathcal{H}}(K)\right), \mathcal{H}^{\alpha}(E(\Theta ; \alpha))>0$ (see the proof of this theorem). Let $\rho>0$ be very small and let $T:[0, \rho] \rightarrow \mathcal{P}(K)$ be defined by

$$
T(t)=t \Theta+(1-t) \delta_{a} .
$$

The probability measure $\Lambda$ on $\mathcal{M}(K)$ is defined by

$$
\Lambda=\frac{1}{\rho} \mathcal{L} \circ T^{-1}
$$

where $\mathcal{L}$ is the 1 -dimensional Lebesgue measure on $\mathbb{R}$. Provided $\rho$ is sufficiently small, (1) and (2) are clearly satisfied. We now show (3) and even a much stronger property: for any $\mu \in \mathcal{M}(K)$, there exists at most one $t \in[0, \rho]$ such that $T(t) \in \mu+M$. Suppose that the contrary holds, and let $t<s, \nu_{1}, \nu_{2} \in M$ be such that

$$
\mu+\nu_{1}=t \Theta+(1-t) \delta_{a}, \quad \mu+\nu_{2}=s \Theta+(1-s) \delta_{a} .
$$

Substracting these equalities, we find

$$
(s-t) \Theta=\nu_{2}-\nu_{1}+(s-t) \delta_{a} \leq \nu_{2}+(s-t) \delta_{a} .
$$

This implies that, for any $x \in K \backslash\{a\}$,

$$
\underline{\operatorname{dim}}_{\mathrm{loc}}\left(\nu_{2} ; x\right) \geq \underline{\operatorname{dim}}_{\mathrm{loc}}(\Theta ; x) .
$$

Thus, for any $\alpha \in\left(0, \operatorname{dim}_{\mathcal{H}}(K)\right)$,

$$
E_{-}(\Theta: \alpha) \subset \mathcal{E}_{-}\left(\nu_{2} ; \alpha\right) \cup\{a\} .
$$

This in turn yields

$$
\mathcal{H}^{\alpha}\left(\mathcal{E}_{-}\left(\nu_{2} ; \alpha\right)\right)>0 .
$$

We argue like in the proof of Theorem 1.1 to conclude that $\mathcal{H}^{\alpha}\left(E_{-}\left(\nu_{2} ; \alpha\right)\right)>0$ for any $\alpha \in\left(0, \operatorname{dim}_{\mathcal{H}}(K)\right)$, a contradiction with $\nu_{2} \in M$.
