Weighted Radon transforms and first order differential systems on the plane

Abstract

We consider weighted Radon transforms on the plane, where weights are given as finite Fourier series in angle variable. By means of additive Riemann-Hilbert problem techniques, we reduce inversion of these transforms to solving first order differential systems on $\mathbb{R}^2 = \mathbb{C}$ with a decay condition at infinity. As a corollary, we obtain new injectivity and inversion results for weighted Radon transforms on the plane.

1. Introduction

We consider the weighted ray transforms P_W defined by the formula

$$
P_W f(s, \theta) = \int_{\mathbb{R}} W(s\theta^\perp + t\theta, \theta) f(s\theta^\perp + t\theta) dt, \quad s \in \mathbb{R}, \ \theta = (\theta_1, \theta_2) \in \mathbb{S}^1,
$$
 (1.1)

where $\theta^{\perp} = (-\theta_2, \theta_1), W_{\infty} = W(x, \theta)$ is the weight, $f = f(x)$ is a test function, $x \in \mathbb{R}^2$, \mathbb{S}^1 is the unit circle in \mathbb{R}^2 . Up to change of variables, P_W is known also as the weighted Radon transform on the plane.

In this work one can always assume that

$$
W \in C(\mathbb{R}^2 \times \mathbb{S}^1) \cap L^{\infty}(\mathbb{R}^2 \times \mathbb{S}^1). \tag{1.2}
$$

Additional assumptions on W will be formulated in the framework of context. In particular, in important particular cases W is real-valued and strictly positive:

$$
W = \bar{W}, \quad W \ge c > 0. \tag{1.3}
$$

We recall that in definition (1.1) the product $\mathbb{R} \times \mathbb{S}^1$ is interpreted as the set of all oriented straight lines in \mathbb{R}^2 . More precisely, if $\gamma = (s, \theta) \in \mathbb{R} \times \mathbb{S}^1$, then $\gamma = \{x \in \mathbb{R}^2 :$ $x = s\theta^{\perp} + t\theta$, $t \in \mathbb{R}$ (modulo orientation) and θ gives the orientation of γ .

If $W \equiv 1$, then P_W is known as classical ray (or Radon) transform on the plane. This transform arises, in partcular, in X-ray transmission tomography. If

W(x,\theta) = \exp(-Da(x,\theta)), \quad Da(x,\theta) = \int_{0}^{+\infty} a(x+t\theta)dt,
$$
\n(1.4)

where a is a complex-valued sufficiently regular function on \mathbb{R}^2 with sufficient decay at infinity, then P_W is known as the attenuated ray (or Radon) transform on the plane.

This transform (at least, with $a \geq 0$) arises, in particular, in single-photon emission computed tomography (SPECT). Transforms P_W with some other weights W also arises in applications. For more information in this connection see, for example, [Na], [Ku], [MP], [Ba2].

Exact and simultaneously explicit inversion formulas for the classical and attenuated Radon transforms on the plane were given for the first time in [Ra] and [No1], respectively. For some other weights W , exact and simultaneously explicit inversion formulas were given in [TM], [BS], [G], [No2].

For general P_W , under assumptions (1.2), (1.3), explicit and simultaneously exact (modulo $Ker P_W$) inversion formulas seem to be impossible. Nevertheless, due to [BQ], P_W is injective on $C_0(\mathbb{R}^2)$ (where C_0 denotes continuous functions with compact support), i.e. $Ker P_W = 0$ in $C_0(\mathbb{R}^2)$, for real analytic W satisfying (1.3).

Besides, $[Bo1]$ gives an example of infinitely smooth W satisfying (1.2) , (1.3) and such that $Ker P_W \neq 0$ in $C_0^{\infty}(\mathbb{R}^2)$ (where C_0^{∞} denotes infinitely smooth functions with compact support).

For more information concerning known uniqueness and non-uniqueness results for weighted Radon transforms on the plane see [Q], [Fi], [Ku], [BQ], [Bo1], [Bo2], [No1], [No2] and references therein.

In the present work we develop (exact and approximate) reconstruction methods of $f \in C_0(\mathbb{R}^2)$ from $P_W f$ with known W satisfying (1.2) and, for example, (1.3). Our studies are based on: (1) the Riemann-Hilbert problem approach of [FN], [No1], [Ba1]; (2) generalized analytic function theory, see [V]; (3) approximate inversion approach of [Ch], [No2]. Some of our results can be considered also as a development of [Ku]. Actually, we consider weights of the form

W(x, \theta(\varphi)) = \sum_{n=-N}^{N} e^{in\varphi} w_n(x),

where $w_n \in C(\mathbb{R}^2) \cap L^{\infty}(\mathbb{R}^2)$ and, for example, $|w_0| > c_0 > 0$. Such weights approximate, in particular, W satisfying (1.2) , (1.3) .

Due to the formula (see [No2])

$$
\frac{1}{2}(P_W f(s,\theta) + P_W f(-s,-\theta)) = P_{W_{sym}} f(s,\theta), \quad (s,\theta) \in \mathbb{R} \times \mathbb{S}^1,
$$

\n

W_{sym}(x,\theta) = \frac{1}{2}(W(x,\theta) + W(x,-\theta)), \quad x \in \mathbb{R}^2, \quad \theta \in \mathbb{S}^1,

inversion of P_W can be reduced to inversion of $P_{W_{sym}}$. Therefore, in the present work we consider mainly the case when

$$
W(x,\theta) = W(x,-\theta), \quad x \in \mathbb{R}^2, \quad \theta \in \mathbb{S}^1
$$
\n(1.8a)

and, as a corollary,

$$
w_n \equiv 0 \quad \text{on } \quad \mathbb{R}^2 \quad \text{if } n \text{ is odd} \tag{1.8b}
$$

for W of (1.6) .

In Theorem 3.1 of Section 3 we reduce inversion of P_W under assumptions (1.6), (1.8) to solving a system of first order differential equations on \mathbb{R}^2 with a decay condition at infinity. In the simplest non-trivial case this system is reduced to the inhomogeneous Beltrami type equation of Remark 3.2 of Section 3.

One of possibilities to obtain a linear integral equation for finding f from $P_W f$ and W proceeding from Theorem 3.1 is realized in Theorem 3.2 of Section 3. In addition, the linear integral equation of Theorem 3.2 is uniquely solvable by the method of successive approximations, under some smallness condition on the function set

 $\{\frac{w_{2k}}{w_0}: |2k| \leq N, k \neq 0\}$. It is interesting to note that for the case when $w_0 \equiv 1$ the linear integral equation of Theorem 3.2, actually, coincides with related equation of [Ku], obtained in a completely different way.

In turn, proceeding from Theorem 3.2 we obtain, in particular, that if W satisfies (1.2) , (1.3) and can be written as

\n

x \in \mathbb{R}^2, \quad \theta(\varphi) = (\cos \varphi, \sin \varphi), \quad \varphi \in [-\pi, \pi],

then $f \in C_0(\mathbb{R}^2)$ is uniquely and efficiently determined by $P_W f$ and W; see Theorem 3.3 of Section 3 for details.

At least on the theoretical level, our exact inversion method for P_W , under assumptions $(1.2), (1.3), (1.9),$ and formula (1.7) give new approximate inversion method for P_W under general assumptions (1.2), (1.3). For $w_{-2} \equiv 0$, $w_2 \equiv 0$ this approximate inversion is reduced to the Chang approximate inversion formula; see, for example, [Ch], [No2], [GN] in connection with Chang's formula.

In studies of the present work we proceed from Proposition 2.1 of Section 2. Due to this proposition we consider inversion of P_W as, roughly speaking, some additive Riemann-Hilbert problem. The main results of the present work on inversion of P_W are presented in details in Section 3.

2. Weighted ray equation

Assuming that W satisfies (1.2) and $f \in C_0(\mathbb{R}^2)$, we consider the equation

\theta \partial_x \psi(x,\theta) = W(x,\theta)f(x), \quad x = (x_1, x_2) \in \mathbb{R}^2, \quad \theta = (\theta_1, \theta_2) \in \mathbb{S}^1,

where θ is spectral parameter, $\partial_x = (\partial/\partial x_1, \partial/\partial x_2), \ \ \theta \partial_x = \sum_{j=1}^2 \theta_j \partial/\partial x_j.$

For any $\theta \in \mathbb{S}^1$ we consider the continuous solution $\psi^+(\cdot, \theta)$ of (2.1), specified by

\lim_{t \to -\infty} \psi^+(x + t\theta, \theta) = 0, \quad x \in \mathbb{R}^2.

The following formula holds:

\psi^+(x,\theta) = \int_{-\infty}^0 W(x+t\theta,\theta)f(x+t\theta)dt, \ x \in \mathbb{R}^2, \ \theta \in \mathbb{S}^1.

In addition,

where $P_W f$ is defined by (1.1), θ^{\perp} is the same that in (1.1).

We say that equation (2.1) is the weighted ray equation on the plane and that $P_W f$ is "scattering" data for this equation.

Assuming that W satisfies (1.6) and $f \in C_0(\mathbb{R}^2)$ we consider also equation (2.1) with complexified spectral parameter:

For any $\theta \in \Sigma \backslash \mathbb{S}^1$ we consider the continuous solution $\psi(\cdot, \theta)$ of (2.5) specified by

The following formula holds:

\psi(x,\theta) = \int_{\mathbb{R}^2} G(x-y,\theta)W(y,\theta)f(y)dy, \quad x \in \mathbb{R}^2, \ \theta \in \Sigma \backslash \mathbb{S}^1,

W is defined by (1.6) with $e^{in\varphi}$ replaced by $(\theta_1 + i\theta_2)^n$.

\theta \partial_x G(x, \theta) = \delta(x), \quad x \in \mathbb{R}^2, \quad \theta \in \Sigma \backslash \mathbb{S}^1. \tag{2.10}

For detail properties of $G(x, \theta)$ we refer to [No1].

Consider

z = x_1 + ix_2, \quad \bar{z} = x_1 - ix_2, \ x = (x_1, x_2) \in \mathbb{R}^2.

Consider the following parametrization of Σ by $\lambda \in \mathbb{C}\backslash 0$:

\lambda(\theta) = \theta_1 + i\theta_2 \text{ for } \theta = (\theta_1, \theta_2) \in \Sigma,

In the variable λ the circle $\mathbb{S}^1 = \Sigma \cap \mathbb{R}^2$ takes the form

Let $\psi(z, \lambda)$, $G(z, \lambda)$ denote ψ and G of (2.8), (2.9) written in the variables z , λ of (2.11), (2.12). Let $W(z, \lambda)$, $f(z)$ denote related W and f written in the same way. We recall that

$$
G(z,\lambda) = \frac{sgn(|\lambda|-1)}{\pi(\lambda \bar{z} - z/\lambda)}, \quad z \in \mathbb{C}, \ \lambda \in \mathbb{C} \setminus (\mathbb{T} \cup 0), \tag{2.14}

see [No1], [Ba1] for detail properties of G. Note also that, under assumptions (1.6) , (1.8) , W can be written as

$$
W(z,\lambda) = \sum_{l=-m}^{m} \lambda^{2l} w_{2l}(z), \quad \lambda \in \mathbb{C} \backslash 0, \ z \in \mathbb{C}, \tag{2.15}
$$

where $w_{2l} \in C(\mathbb{C}) \cap L^{\infty}(\mathbb{C}), m = [N/2]$ (i.e. m is the integer part of $N/2$). In addition, we have the following proposition:

Proposition 2.1. Let ψ be the function of (2.8), where W satisfies (1.6), (1.8), $[N/2] = m$, and $f \in C_0(\mathbb{R}^2)$. Then for each $z \in \mathbb{C}$ the function $\psi = \psi(z, \lambda)$ has the following properties in λ (in variables z, λ of (2.11), (2.12)):

where $x(z)=(x_1(z), x_2(z)), \theta(\lambda)=(\theta_1(\lambda), \theta_2(\lambda))$ are given according to (2.11), (2.12), $\theta^{\perp} = (-\theta_2, \theta_1)$ for $\theta = (\theta_1, \theta_2)$.

Proposition 2.1 follows from considerations given in [No1], [Ba1]. In particulier, for $[N/2] = m = 0$ Proposition 2.1 is a particular case of results of [No1] (and goes back to $[FN]$.

Properties (2.16)-(2.21) of ψ permit to study inversion of P_W by means of additive Riemann-Hilbert problem techniques.

3. Inversion of P_W

One can see that

Therefore, under assumptions (1.2), (3.3), inversion of P_W is reduced to the case when $w_0 \equiv 1$ on \mathbb{R}^2 .

We recall that (3.5) is known as the Chang approximate inversion formula for P_W under assumptions (1.2) , (3.3) . In addition, under assumptions (1.2) , (3.3) , due to Theorem 1 of [No2], we have that

However, property (3.7) is fulfilled for W of the form (1.6) if and only if

Below in this section we are focused on inversion of P_W under assumptions (1.2), (1.8), (3.3) for the case when (3.8) is not necessary fulfilled. In addition, we assume that W is written in the form (2.15) , where $m \geq 1$.

Consider the $2m \times 2m$ operator matrices A and B such that

where F_0 is the function of (3.5), $\tilde{w}_{\pm 2l}$ are defined by (3.12), u_{2l-1} , u_{-2l+1}^+ are the function of (2.17) , (2.18) , $l = 1, \ldots, m$.

Let χ_D denote the characteristic function of a domain D in \mathbb{C} , i.e.

where A, B, q, v, χ_D are defined by (3.9), (3.10), (3.13), (3.14), (3.15) and v' is defined by (3.16) in terms of v. In addition,

where F_0/w_0 is the function of (3.5) and v_m , v_{m+1} are the components of v.

We consider (3.17), (3.18) as a system of first order differential equations for $v = (v_1, \ldots, v_{2m})$ on $\mathbb C$ with a decay condition at infinity. One can see that : A is independent of W and F_0 , B is explicitely given in terms of W and is independent of F_0 , q is explicitely given in terms of W and F_0 . In addition, f can be found via (3.19) as soon as F_0/w_0 , v_m , v_{m+1} are known.

Theorem 3.1 is proved in Section 4.

w_0 f + \sum_{l=1}^{m} ((-\bar{\Pi})^l w_{2l} + (-\Pi)^l w_{-2l}) f = F_0.
$$
\n(6.3)

Using (5.4a), (6.3) one can see, in particular, that under our assumptions,

$$
F_0 \in L^p(\mathbb{C}) \quad \text{for each} \quad p > 1. \tag{6.4}
$$

Equation (3.29) follows from formula (6.3), the definitions of F and \tilde{w}_{2l} and formula (4.26). In addition, using (4.29) we obtain that

$$
\|\sum_{l=1}^{m} ((-\bar{\Pi})^{l} \tilde{w}_{2l} + (-\Pi)^{l} \tilde{w}_{-2l}) \chi_D\|_{L^2(\mathbb{C}) \to L^2(\mathbb{C})} \le
$$

$$
\sum_{l=1}^{m} (\sup_{z \in D} |\tilde{w}_{2l}(z)| + \sup_{z \in D} |\tilde{w}_{-2l}(z)|).
$$
 (6.5)

Inequality (6.5) completes the proof of Theorem 3.2.
