Pipeline tracking for fully-actuated autonomous underwater vehicle using visual servo control

Abstract—This paper describes a nonlinear image-based visual servo control algorithm for the pipeline tracking problem of a fully-actuated underwater vehicle. The dynamic model of a generic autonomous underwater vehicle (AUV), incorporating all significant forces and torques is developed and a generic velocity control strategy is proposed. The desired velocities in the plane orthogonal to the direction of the pipeline along with the yaw velocity are derived from the image sequence using bi-normalised Plücker coordinates of the pipeline borders. The desired velocity along the pipeline is specified by the operator and finally the desired velocities in pitch and roll angles are set to zero. The asymptotic stability of the visual servo control strategy is proved and simulation testing is carried out to show performance of the control approach.

I. INTRODUCTION

The application of Autonomous Underwater Vehicles (AUVs) has improved the accessibility of scientific and industrial data in several domains. From the initial goals of data gathering in vast open spaces, the missions of these vehicles are now expected to be executed in close proximity of a complex sea bottom or submarine structures, given that it can create revolutionary applications of AUVs in subsea inspection and maintenance. The shift from simple inertial navigation to sensor-referenced and model-based control is prompting the development of new techniques. Proven robustness and steady performance in the face of often noisy data is a requirement for assuring safe operation of these vehicles, often very expensive.

The main challenging problem when dealing with AUV is inherently linked to the nonlinear dynamics of the system and highly coupled in 6 d.o.f. The interaction with a dense medium (water) has measurable effects due to friction and dynamic surface pressure, bringing in the terms of added mass and damping. There are several formulations of the dynamics of an underwater vehicle taking all these effects into consideration, notably by Fossen [1], Bailey *et al.* [2] and Leonard [3], each of them with different merits and certain considerations. The latter reference, based on the change of momentum expression, provides good insight into the energy of the system.

There is a vast array of designs and control system architectures for AUVs, well summarised by Yuh in [4]. Typically, AUVs carry inertial sensors to estimate accelerations. The estimation, inherently burdened by drift error, is improved

by exploiting the measurements of a magnetic compass along with a Doppler Velocity Log (DVL) which measures linear velocities w.r.t the surrounding medium. An underwater vehicle usually uses a sonar (scanning, multi-beam or side-scan) or a video camera to sense its environment. Although far from Global Positioning System (GPS) in performance, there exist systems which allows positioning with respect to some locally fixed beacons. Most vehicles share a couple of types of common physical dynamics and similar tasks. The control problem thus remains a universal and shared core for most of the academic centers researching AUVs.

Results in non-linear control of AUV systems have been achieved using a host of different techniques. Amongst the approaches which exploit the nonlinearities are techniques of direct Lyapunov control [5], sliding mode control [6], adaptive control (LQ [7], $H-\infty$ [8]), optimal control [9] and a host of linearizing methods. Moreover, some developments with respect to the sensor-based navigation, centered mostly around sonar-based tracking and simultaneous localisation and mapping (SLAM) have been recently proposed [10]. Notable examples of work where the sensor input is used for structure-referenced navigation are [11] and [12], while [13] and [14] focus on the task of pipeline tracking, with little regards to the nonlinearity of the control problem.

While almost all techniques developed previously are based on the reconstruction of the relative position of the vehicle in its environment, this paper focuses on an image-based visual servoing (IBVS). The advantage of IBVS schemes over position-based visual servoing (PBVS) relies on the fact that the relative position of the robot with respect to its environment is not required and only 2D image features are needed. Hence, IBVS techniques are usually more suitable for real-time algorithms since they exploit geometrical properties of the imaging systems and their relations to the environment/robot. The image features considered are the bi-normalised Plücker coordinates [15] of the pipeline borders. The control design is split into two parts: an inner-loop controller to stabilise the velocities of the vehicle around a desired set point and an outer-loop to derive the velocity desired set point from image features.

The paper is organized as follows: Section II presents the developed dynamical system modelling an AUV. Section III describes the chosen control problem along with the visual features considered. Section IV derives the inner-loop controller and analyses the stability of the system. Section V describe the velocity desired set point from image features. Section V-B analyses the stability of the full system. Section

VI applies the control strategy to a realistic model of an underwater vehicle and exhibits some simulation results. The final section provides a short conclusion and an indication of future works.

II. SYSTEM MODELING

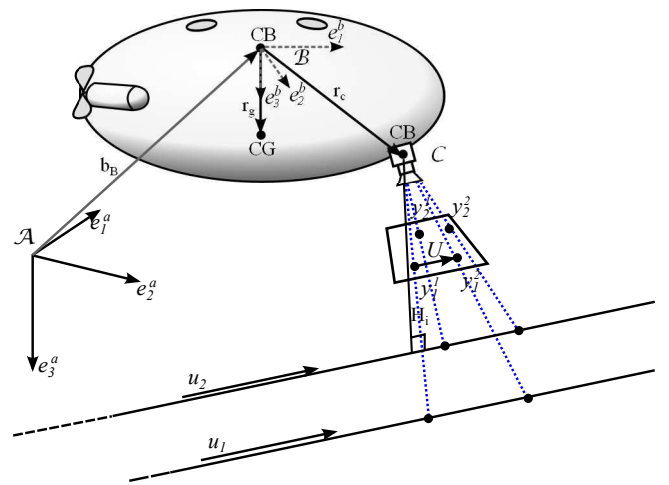


Fig. 1. Reference frames relationships

The following conventions of the reference frames are used: $\mathcal{A} = \{e_1^a, e_2^a, e_3^a\}$ is the inertial reference frame and $\mathcal{B} = \{e_1^b, e_2^b, e_3^b\}$ represents the body-fixed frame. The position of the body-fixed frame in \mathcal{A} is the center of buoyancy (CB) and denoted $b_B \in \mathcal{A}$. The center of gravity (CG) is denoted $b_G \in \mathcal{A}$ and $r_G \in \mathcal{B}$ (see Fig. 1). The orientation of \mathcal{B} with respect to \mathcal{A} is denoted $R \in SO(3)$, $\mathcal{B} \mapsto \mathcal{A}$, an element of the special orthogonal group. The remaining state variables of the system are the velocities: linear V and angular Ω , both expressed in \mathcal{B} . Another important reference frame is bound to the camera: $\mathcal{C} = \{e_1^c, e_2^c, e_3^c\}$ which is displaced from the origin of \mathcal{B} by a vector r_C , keeping its base vectors parallel to those of \mathcal{B} . Let $\{e_1, e_2, e_3\}$ denote the canonical basis of \mathbb{R}^3 . Define:

$$\nu = \begin{bmatrix} V \\ \Omega \end{bmatrix} = [u \ v \ w \ p \ q \ r]^T = \begin{bmatrix} \text{surge} \\ \text{sway} \\ \text{heave} \\ \text{roll} \\ \text{pitch} \\ \text{yaw} \end{bmatrix}$$

Commonly used parameters of a rigid body are the total mass m and the moment of inertia tensor I_0 .

When characterised at an arbitrary point, for instance CB ($CB \neq CG$), the kinetic energy of the system is given by¹:

$$E_{RB} = \frac{1}{2} \nu^T \begin{bmatrix} mI_{3 \times 3} & -mr_{G \times} \\ mr_{G \times} & I_0 \end{bmatrix} \nu = \frac{1}{2} \nu^T M_{RB} \nu$$

where r_G is the position of the center of gravity (CG) in the body-fixed frame with the origin at CB .

According to Kirchhoff and Lamb theory [16], the kinetic energy of the liquid surrounding the body is given by [3]:

$$E_A = \frac{1}{2} \nu^T M_A \nu = \frac{1}{2} \nu^T \begin{bmatrix} M_A^{11} & M_A^{12} \\ M_A^{21} & M_A^{22} \end{bmatrix} \nu$$

where M_A is known as the added mass matrix. Consequently, the total of the kinetic energy of the body in its medium is:

$$E_T = E_{RB} + E_A = \frac{1}{2} \nu^T M_T \nu \quad (1)$$

$$\text{where } M_T = \begin{bmatrix} M & M_T^{12} \\ M_T^{21} & I \end{bmatrix} = \begin{bmatrix} mI_{3 \times 3} + M_A^{11} & -mr_{G \times} + M_A^{12} \\ mr_{G \times} + M_A^{21} & I_0 + M_A^{22} \end{bmatrix}$$

All vehicles with three mutually perpendicular axes of symmetry (em i.e. ellipsoid, box-shaped, ...) approximately have a diagonal form for the added mass matrix M_A . In practice, the diagonal terms of M_A are often significantly larger than the other terms, and therefore the matrix M_A can be approximated by a diagonal matrix [1]. Consequently, $M_T^{21} = -M_T^{12} = D := mr_{G \times}$.

Recalling the total kinetic energy of the body-liquid system (1), one can derive the translational (P) and rotational momentums (Π) as follows [3]:

$$P = \frac{\partial E_T}{\partial V} = MV + D^T \Omega$$

$$\Pi = \frac{\partial E_T}{\partial \Omega} = I\Omega + DV$$

¹The notation $\vec{v}_\times = \begin{bmatrix} 0 & -v_3 & v_2 \\ v_3 & 0 & -v_1 \\ -v_2 & v_1 & 0 \end{bmatrix}$ is used to abbreviate the skew-symmetric matrix multiplicative representation of vector product.

According to [3] and [17], the dynamics of the system can be expressed as follows:

$$\dot{R} = R\Omega_\times \quad (2)$$

$$\dot{b}_B = RV \quad (3)$$

$$\dot{P} = P \times \Omega + (mg - F_B)R^T e_3 + F_D + F_C \quad (4)$$

$$\dot{\Pi} = \Pi \times \Omega + P \times V + mgr_G \times R^T e_3 + T_D + T_C \quad (5)$$

The two first lines represent the kinematics of the system while the other two lines describe the dynamics of the vehicle. The term $(mg - F_B)R^T e_3$ is the contribution of both gravitational and buoyancy forces. The cross term $mgr_G \times R^T e_3$ expresses the gravitational moment with respect to the center of buoyancy. In any submerged vehicle the center of mass lies under the center of buoyancy, it is straightforward to verify that gravitational moment can be expressed as $mgle_3 \times R^T e_3$, where l is the distance between CB and CG, along the body-reference direction e_3^b . This cross term plays an important role in the stabilization of the roll and pitch angles of the vehicle. The expansion of $P \times V$ in Eq. (5), shows that the term $(MV) \times V$ should not be ignored due to the added mass of the AUVs [3]. The terms F_D and T_D represent the damping terms due to fluid pressure and viscous drag. For underwater vehicles maneuvering at low speed, the damping is given by [1, p.74]:

$$[F_D \ T_D]^T = -B(\nu)\nu, \text{ with } B(\nu) = B_l + B_n(\nu) \quad (6)$$

where B_l is a constant diagonal positive matrix and B_n represents a nonlinear damping matrix here modeled as $B_n = \text{diag}(d_u|u|, d_v|v|, d_w|w|, d_p|p|, d_q|q|, d_r|r|)$ with $d_{(\cdot)} > 0$. We assume hereafter and w.l.o.g that:

$$F_D(V) = -B_V(V)V, \quad T_D(\Omega) = -B_\Omega(\Omega)\Omega \quad (7)$$

where B_V and B_Ω are two diagonal positive matrices. Finally, $F_C, T_C \in \mathbb{R}^3$ represent the control inputs of the system.

III. VISUAL SERVO CONTROL PROBLEM

This section describes the control problem considered to perform autonomous pipeline tracking for fully-actuated

AUV using visual servo control. The visual features considered are the images of the pipeline borders assumed to be parallel in the horizontal plane of the inertial frame. The unit direction vector of the pipeline is denoted $\mathbf{u} \in \mathcal{A}$ in the inertial frame and $U = R^T \mathbf{u} \in \mathcal{C}$ in the camera frame. We assume the image features remain in the camera field of view throughout the motion, a reasonable assumption given the nature of the manoeuvre considered.

A position-like and yaw related orientation error terms are derived from the visual features. The first one is based on the bi-normalised Plücker coordinates of the observed parallel lines and is used to align the camera at a desired height with respect to the pipeline. The second is based on the alignment of the forward velocity with the pipeline direction. Given that the observed lines are known to be parallel, their Plücker coordinates $(h_i, U) \in \mathcal{C}$, $i = \{1, 2\}$ can be measured directly from the image features [17]:

$$h_i = \frac{y_i^1 \times y_i^2}{|y_i^1 \times y_i^2|} = \frac{y_i^1 \times U}{|y_i^1 \times U|} = \frac{y_i^2 \times U}{|y_i^2 \times U|}; U = \pm \frac{h_1 \times h_2}{|h_1 \times h_2|} \quad (8)$$

where y_i^1 and $y_i^2 \in \mathcal{C}$ are two specific points on the line $i = \{1, 2\}$. The direction of the pipeline $U \in \mathcal{C}$ is specified up to a sign that should be fixed by the operator. The proposed visual servo scheme is based on centroid vectors designed from the image features (8) as follows:

$$q = h_1 + h_2$$

The visual position error with respect to the set of the linear features can then be defined as:

$$\delta_1 = q - q^* \quad (9)$$

where q^* is the value of the q vector for a reference configuration of the features. It is considered as constant in \mathcal{A} . Therefore, the dynamics of q^* is equivalent to the dynamics of U : $\dot{q}^* = -\Omega \times q^*$. To regulate the velocity of the vehicle in the direction of the pipeline, a reference velocity α is specified. The yaw related-orientation error can be defined by specifying e_1^b as the ‘‘reference forward direction’’ for the vehicle. Let define U_2 as the second component of U , one can define the yaw related orientation error by $U_2 e_3$.

Finally, it is worth noting that the external torque due to gravity and buoyancy in a bottom-heavy vehicle (CG is below CB) ensures a pendulum-like movement around the gravitational direction e_3^a . Moreover, if the damping is included, the system loses rotational kinetic energy and naturally comes back to equilibrium set point, ensuring that $R^T e_3$ converges to e_3 and the first two components of Ω ($\Omega_1 = p, \Omega_2 = q$) converge to zero as long as the external torque due to gravity and buoyancy is not compensated.

According to [17], the time derivative of δ_1 defined by Eq. (9) can be expressed as follows:

$$\dot{\delta}_1 = -\Omega \times \delta_1 - Q(V_C \times U), \quad (10)$$

where V_C is the velocity of the camera expressed in the body-fixed frame \mathcal{B} and is given by

$$V_C = V - \Omega \times r_C \quad (11)$$

The matrix Q is symmetric positive definite matrix and is defined by

$$Q := \sum_{i=1}^2 \frac{1}{|H_i|} \pi_{h_i}$$

with $|H_i|$ the norm of the closest point on line i ($i = \{1, 2\}$) and $\pi_x = (I_3 - xx^T)$ is a projection onto the tangent space of the sphere S^2 of a point $x \in S^2$. Given that the term $|H_i|$ is unknown it follows that Q is also unknown. In practice, one can use different clues like depth gauge readings or camera autofocus information to estimate the upper-bound and lower-bound of its eigenvalues that will be exploited in the control design. It is of interest to study the structural properties of Eq. (10). The time derivative of the storage function $\frac{1}{2} |\delta_1|^2$ is:

$$\frac{1}{2} \frac{d}{dt} |\delta_1|^2 = -\delta_1^T Q (V_C \times U).$$

Since the matrix $Q > 0$, choosing $V_C \times U = \delta_1$ acts to decrease $|\delta_1|^2$. Analogously, in order to stabilize U about e_1 , consider the following storage positive function

$$\mathcal{L}_y = k_y (1 - U^T e_1), \quad k_y > 0, \quad (12)$$

whose time-derivative satisfies

$$\dot{\mathcal{L}}_y = k_y (\Omega \times U)^T e_1 = k_y \Omega^T (U \times e_1) \quad (13)$$

To give the control insight, assume that the first two components of Ω are equal to zero and choose $\Omega_3 = r$ as

$$\Omega_3 = k_U U_2, \quad k_U > 0,$$

One can ensure that \mathcal{L}_y is decreasing

$$\dot{\mathcal{L}}_y = -k_y k_U U_2^2.$$

Since V_c and Ω_3 cannot be chosen as control input, the approach taken in this paper is split into two parts. The first part termed inner-loop controller allows stabilization the velocities to a desired set point and the second one, termed outer-loop controller, is specifically designed from image feature to define the desired set point.

IV. INNER-LOOP CONTROL DESIGN

Since the external torque due to gravity and buoyancy ensures a pendulum-like movement around e_3^a , we consider here the objective of stabilizing the velocities (V, Ω) at the reference (V_r, Ω_r) with $\Omega_r = \Omega_{3r} e_3$, defined by the outer-loop controller. Let us define the velocity error variables

$$\tilde{V} := V - V_r, \quad \tilde{\Omega} := \Omega - \Omega_r. \quad (14)$$

Then, the control objective is equivalent to the stabilization of $(\tilde{V}, \tilde{\Omega})$ to zero. Using Eqs. (4), (5), and (14), and the fact that $D\Omega_r = D\dot{\Omega}_r = 0$, the velocity error system can be written as

$$\begin{cases} M\dot{\tilde{V}} - D\dot{\tilde{\Omega}} = (MV - D\Omega) \times \tilde{\Omega} + (M\tilde{V} - D\tilde{\Omega}) \times \Omega_r \\ \quad + F_r + (mg - F_B) R^T e_3 + F_D(V) + F_C \\ I\dot{\tilde{\Omega}} + D\dot{\tilde{V}} = (I\Omega + DV) \times \tilde{\Omega} + (MV - D\Omega) \times \tilde{V} \\ \quad + (I\tilde{\Omega} + D\tilde{V}) \times \Omega_r + (M\tilde{V} - D\tilde{\Omega}) \times V_r \\ \quad + mgle_3 \times R^T e_3 + T_r + T_D(\Omega) + T_C \end{cases} \quad (15)$$

with the new variables

$$F_r := -M\dot{V}_r + (MV_r) \times \Omega_r$$

$$T_r := -I\dot{\Omega}_r - D\dot{V}_r + (I\Omega_r + DV_r) \times \Omega_r + (MV_r) \times V_r$$

For control design purposes, let us introduce some definitions of saturation functions

$$\sigma_\chi(x) := \min(|x|, \chi) \text{sign}(x), \forall x \in \mathbb{R} \quad (16)$$

$$\text{sat}_\Delta(x) := [\sigma_{\chi_1}(x_1), \sigma_{\chi_2}(x_2), \sigma_{\chi_3}(x_3)]^T, \forall x \in \mathbb{R}^3 \quad (17)$$

with a constant positive vector $\Delta = [\chi_1, \chi_2, \chi_3]$. The first control result of this paper is stated next.

Proposition 1 *Let $K_V, K_\Omega, \Delta_V, \Delta_\Omega$ denote some positive diagonal matrices and apply the control law*

$$\begin{cases} F_C = -\text{sat}_{\Delta_V}(K_V \tilde{V}) - (M\tilde{V})_\times \Omega_r + M(\tilde{\Omega} \times V_r) \\ \quad - F_r - (mg - F_B)R^T e_3 - F_D(V_r) \\ T_C = -\text{sat}_{\Delta_\Omega}(K_\Omega \tilde{\Omega}) - (I\tilde{\Omega})_\times \Omega_r + (D\tilde{\Omega}) \times V_r \\ \quad - T_r - T_D(\Omega_r) \end{cases} \quad (18)$$

to the error system (15). Assume that V_r, Ω_r and their time-derivative are bounded. Then

- 1) The error state $(\tilde{V}, \tilde{\Omega}, R^T e_3)$ converges to $(0, 0, \pm e_3)$ for all initial conditions.
- 2) The equilibrium $(\tilde{V}, \tilde{\Omega}, R^T e_3) = (0, 0, e_3)$ is locally exponentially stable and the equilibrium $(\tilde{V}, \tilde{\Omega}, R^T e_3) = (0, 0, -e_3)$ is unstable.

Proof: Consider the following Lyapunov candidate function

$$\begin{aligned} \mathcal{L}_{vel} &= \frac{1}{2} \tilde{W}^T M_T \tilde{W} + mgl(1 - e_3^T R^T e_3) \\ &= \frac{1}{2} \tilde{V}^T M \tilde{V} + \frac{1}{2} \tilde{\Omega}^T I \tilde{\Omega} - \tilde{V}^T D \tilde{\Omega} + mgl(1 - e_3^T R^T e_3) \end{aligned} \quad (19)$$

with the positive-definite matrix M_T defined in Eq. (1). The time-derivative of \mathcal{L}_{vel} satisfies

$$\begin{aligned} \dot{\mathcal{L}}_{vel} &= \tilde{V}^T (M\dot{\tilde{V}} - D\dot{\tilde{\Omega}}) + \tilde{\Omega}^T (I\dot{\tilde{\Omega}} + D\dot{\tilde{V}}) - mgl\Omega^T e_3 \times R^T e_3 \\ &= \tilde{V}^T (M\dot{\tilde{V}} - D\dot{\tilde{\Omega}}) + \tilde{\Omega}^T (I\dot{\tilde{\Omega}} + D\dot{\tilde{V}}) - mgl\tilde{\Omega}^T e_3 \times R^T e_3 \end{aligned}$$

Then, using system (15) and the properties $D\Omega_r = 0$ and $D(a \times b) = (Da) \times b - (Db) \times a, \forall a, b \in \mathbb{R}^3$, one has:

$$\tilde{V}^T (MV - D\Omega) \times \tilde{\Omega} + \tilde{\Omega}^T (MV - D\Omega) \times \tilde{V} = 0,$$

and the control law (18) one deduces

$$\begin{aligned} \dot{\mathcal{L}}_{vel} &= \tilde{V}^T (F_C + F_r + (mg - F_B)R^T e_3 + F_D(V) \\ &\quad + (M\tilde{V} - D\tilde{\Omega}) \times \Omega_r) \\ &\quad + \tilde{\Omega}^T (T_C + T_r + T_D(\Omega) \\ &\quad + (I\tilde{\Omega} + D\tilde{V}) \times \Omega_r + (M\tilde{V} - D\tilde{\Omega}) \times V_r) \\ &= \tilde{V}^T (F_C + F_r + (mg - F_B)R^T e_3 + F_D(V) \\ &\quad + (M\tilde{V} - D\tilde{\Omega}) \times \Omega_r - M(\tilde{\Omega} \times V_r) + D(\tilde{\Omega} \times \Omega_r)) \\ &\quad + \tilde{\Omega}^T (T_C + T_r + T_D(\Omega) + (I\tilde{\Omega}) \times \Omega_r - (D\tilde{\Omega}) \times V_r) \\ &= -\tilde{V}^T \text{sat}_{\Delta_V}(K_V \tilde{V}) - \tilde{\Omega}^T \text{sat}_{\Delta_\Omega}(K_\Omega \tilde{\Omega}) \\ &\quad + \tilde{V}^T (F_D(\tilde{V} + V_r) - F_D(V_r)) + \tilde{\Omega}^T (T_D(\tilde{\Omega} + \Omega_r) - T_D(\Omega_r)) \\ &\leq -\tilde{V}^T \text{sat}_{\Delta_V}(K_V \tilde{V}) - \tilde{\Omega}^T \text{sat}_{\Delta_\Omega}(K_\Omega \tilde{\Omega}) \end{aligned}$$

where the last inequality is obtained using the following property: $x(|x+y|(x+y) - |y|y) \geq 0, \forall x, y \in \mathbb{R}$. Since $\dot{\mathcal{L}}_{vel}$ is negative semi-definite, the velocity errors \tilde{V} and $\tilde{\Omega}$ and, thus, the control variables F_N and T_N are bounded. From here, one easily verifies the uniform continuity of $\dot{\mathcal{L}}_{vel}$ via the boundedness of $\dot{\mathcal{L}}_{vel}$. By application of Barbalat's lemma,

one deduces the convergence of $\dot{\mathcal{L}}_{vel}$ and, thus, \tilde{V} and $\tilde{\Omega}$ to zero. Then, by application of Barbalat's lemma again one deduces the convergence of \tilde{V} and $\tilde{\Omega}$ to zero. Finally, from the last equation in (15) one deduces the convergence of $e_3 \times R^T e_3$ to zero which implies that $R^T e_3$ converges to either e_3 or $-e_3$. The proof of local exponential stability of the equilibrium $(\tilde{V}, \tilde{\Omega}, R^T e_3) = (0, 0, e_3)$ and the proof of instability of the equilibrium $(\tilde{V}, \tilde{\Omega}, R^T e_3) = (0, 0, -e_3)$ are based on the linearized systems which are not difficult but are omitted here due to space limitation. ■

Note that in the calculation of $\dot{\mathcal{L}}_{vel}$, we have developed a string of mathematical manipulations so as to obtain the control law (18) in a simple form which does not contain many terms depending on \tilde{V} . The main reason is that in practice the measurement of the vehicle's translational velocity is more difficult to obtain and is less precise than that of the angular velocity. Note also that the saturation terms in the control law (18) are useful to account for the constraints of the actuators.

Remark 1 *The knowledge about the time-derivative of the reference velocities V_r and Ω_r are prerequisite to compute the feedback control F_C and T_C . In the next section, we will show how this fact influences the visual servoing control design.*

V. OUTER-LOOP CONTROLLER: VISUAL SERVO CONTROL DESIGN

The control design is based directly on the quantities estimated by the visual sensor. The control objective consists in stabilizing the visual error term δ_1 about zero, the vector U about e_1 , and $V^T U$ about a the reference value α .

In view of Eqs. (10), (4), and (5), the system of interest has a cascaded structure. This may lead one to define the reference velocities V_r and Ω_r of the inner-loop as functions of δ_1 and U respectively to stabilize (V, Ω) about (V_r, Ω_r) . This strategy requires the explicit knowledge of the time-derivative of V_r which in turn implies that the time-derivative of δ_1 must be known. Since the matrix Q is unknown in (10), we introduce a new variable δ_2 satisfying the following dynamics:

$$\dot{\delta}_2 = -\Omega \times \delta_2 - k_1 \delta_2 + k_2 \delta_1, \delta_2(0) = \delta_1(0), k_{1,2} > 0 \quad (20)$$

Note that δ_2 and its time-derivative $\dot{\delta}_2$ are known. Analogously to δ_1 (9), δ_2 is also orthogonal to U .

Lemma 2 *The vector δ_2 , solution to system (20), is orthogonal to U for all time t .*

Proof: The time-derivative of the following Lyapunov candidate function $\mathcal{V} := 1/2(\delta_2^T U)^2$ satisfies

$$\begin{aligned} \dot{\mathcal{V}} &= (\delta_2^T U)(-\dot{\delta}_2^T (\Omega \times U) + U^T (-\Omega \times \delta_2 - k_1 \delta_2 + k_2 \delta_1)) \\ &= -k_1 (\delta_2^T U)^2 = -2k_1 \mathcal{V} \end{aligned}$$

Thus, \mathcal{V} is non-increasing and remains null for all time since $\mathcal{V}(0) = 0$. This concludes the proof. ■

A. Definitions of reference velocities

The next step consists in defining the reference velocities V_r and Ω_r . The following definitions of V_r and Ω_r essentially follow the insights given in [17] with few modifications.

Define the reference translational velocity for the camera V_{Cr} as

$$V_{Cr} = k_\delta U \times \delta_2 + \alpha U, \quad (21)$$

with k_δ some positive gain. Intuitively, if $V_C \equiv V_{Cr}$ and $\Omega \equiv 0$ one has $V^T U \equiv \alpha$. This justifies the term αU in the definition (21) of V_{Cr} . Using Lemma 2 and Eq. (21) one verifies that

$$V_{Cr} \times U := -k_\delta (U \times)^2 \delta_2 = -k_\delta \delta_2$$

The reference angular velocity Ω_r is defined based on the heading control objective. In order to stabilize U about e_1 , recall the time derivative (13) of the storage function (12) and choose:

$$\Omega_r := k_U U_2 e_3, \quad k_U > 0, \quad (22)$$

one obtains

$$\dot{\mathcal{L}}_y = k_y \tilde{\Omega}^T (U \times e_1) - k_y k_U U_2^2. \quad (23)$$

Finally, in view of Eq. (11) we define the reference translational velocity V_r as

$$V_r := V_{Cr} + \Omega_r \times r_C. \quad (24)$$

Note that $\dot{\delta}_2$ and \dot{U} are known, hence \dot{V}_r and $\dot{\Omega}_r$ are also known².

B. Stability analysis

Since the reference velocities are specified, i.e. Eqs. (24), (22), (21), one can apply the control law (18) proposed in Section IV in order to stabilize (V, Ω) about (V_r, Ω_r) . Using the fact that $\tilde{V}, \tilde{\Omega}$ converge to zero and from (12) and (23) it is straightforward to verify that U_2 converges to zero. Since $R^T e_3$ converges to e_3 along with $U_2 = 0$ one can verify that U converges to e_1 . It remains to show the convergence of δ_1 and δ_2 to zero. Recalling Eqs. (10) and (20), one verifies that:

$$\begin{cases} \dot{\delta}_1 = -k_\delta Q \delta_2 + \epsilon_{\delta_1} \\ \dot{\delta}_2 = k_2 \delta_1 - k_1 \delta_2 + \epsilon_{\delta_2} \end{cases} \quad (25)$$

with $\epsilon_{\delta_1} := -\Omega \times \delta_1 - Q((\tilde{V} + \tilde{\Omega} \times r_C) \times U)$, $\epsilon_{\delta_2} := -\Omega \times \delta_2$. The terms ϵ_{δ_1} and ϵ_{δ_2} converge to zero when $\tilde{V}, \tilde{\Omega}$, and U_2 converge to zero. Therefore, they can be treated as singular perturbations of system (25). As a consequence, by application of singular perturbation theory, in order to prove that δ_1 and δ_2 converge to zero, it suffices to prove the exponential stability of the equilibrium $(\delta_1, \delta_2) = (0, 0)$ of the zero dynamics of system (25), corresponding to $\epsilon_{\delta_1} \equiv \epsilon_{\delta_2} \equiv 0$. This zero dynamics is a linear time-varying (LTV) system

$$\frac{d}{dt} \begin{bmatrix} \delta_1 \\ \delta_2 \end{bmatrix} = \underbrace{\begin{bmatrix} 0 & -k_\delta Q \\ k_2 I_{3 \times 3} & -k_1 I_{3 \times 3} \end{bmatrix}}_{\mathbf{A}(t)} \begin{bmatrix} \delta_1 \\ \delta_2 \end{bmatrix}. \quad (26)$$

²Due to the space limitation their expressions are not given in the paper.

Lemma 3 Consider the LTV system (26). If Q is uniformly bounded and positive definite, and if

$$\frac{k_1^2}{k_2 k_\delta} > \min \left(\lambda_{\max}, \frac{(\lambda_{\max} - \lambda_{\min})^2}{4 \lambda_{\min}} \right) \quad (27)$$

where λ_{\max} and λ_{\min} are the upper-bound and lower-bound of the eigenvalues of Q , then the equilibrium $(\delta_1, \delta_2) = (0, 0)$ is exponentially stable.

Proof: Introduce positive constants p_1 and p_2 satisfying

$$p_1 p_2 > 1, \quad (28)$$

which serve to build a matrix $\mathbf{P} := \begin{bmatrix} p_1 I_{3 \times 3} & -I_{3 \times 3} \\ -I_{3 \times 3} & p_2 I_{3 \times 3} \end{bmatrix}$ (constant, symmetric, positive definite) and matrix $\mathbf{W}(t) := \mathbf{A}(t)^T \mathbf{P} + \mathbf{P} \mathbf{A}(t)$ with $\mathbf{A}(t)$ defined in (26).

To prove the exponential stability of the LTV system (26), it suffices to show the existence of p_1 and p_2 such that

$$\exists \varepsilon > 0, \forall t, \mathbf{W}(t) \leq -\varepsilon I_{6 \times 6} \quad (29)$$

Note that condition (28) is necessary for \mathbf{P} to be positive definite. One verifies that

$$\mathbf{W} = \begin{bmatrix} -2k_2 I_{3 \times 3} & -p_1 k_\delta Q + (k_1 + k_2 p_2) I_{3 \times 3} \\ -p_1 k_\delta Q + (k_1 + k_2 p_2) I_{3 \times 3} & 2k_\delta Q - 2p_2 k_1 I_{3 \times 3} \end{bmatrix}$$

For all $X = [x_1 \ x_2]^T$ with $x_1, x_2 \in \mathbb{R}^3$, one has

$$\begin{aligned} \frac{1}{2} X^T \mathbf{W} X &= -k_2 |x_1|^2 - x_2^T (p_2 k_1 - k_\delta Q) x_2 \\ &\quad + (k_1 + p_2 k_2) x_1^T x_2 - p_1 k_\delta x_1^T Q x_2 \end{aligned} \quad (30)$$

Let $\lambda_1, \lambda_2, \lambda_3 (> 0)$ denote the eigenvalues of Q . One has $\lambda_{\min} \leq \lambda_i \leq \lambda_{\max}$. Since Q is symmetric, there exists a matrix $R_Q \in SO(3)$ such that $Q = R_Q^T \Lambda_Q R_Q$, with $\Lambda_Q = \text{diag}(\lambda_1, \lambda_2, \lambda_3)$. Denoting $\bar{x}_i = R_Q x_i$ with $i = 1, 2$, one deduces from Eq. (30) that

$$\begin{aligned} \frac{1}{2} X^T \mathbf{W} X &= - \sum_{i=1}^3 (k_2 \bar{x}_{1,i}^2 + (p_2 k_1 - k_\delta \lambda_i) \bar{x}_{2,i}^2 \\ &\quad - (k_1 + p_2 k_2 - p_1 k_\delta \lambda_i) \bar{x}_{1,i} \bar{x}_{2,i}) \end{aligned} \quad (31)$$

We have to prove that there exists some positive constant ε such that $X^T \mathbf{W} X \leq -\varepsilon |X|^2$. From here, the proof proceeds by considering two possible cases. \triangleright *Case 1* : Consider

the case where $\lambda_{\max} \leq \frac{(\lambda_{\max} - \lambda_{\min})^2}{4 \lambda_{\min}}$. Eq. (27) implies the existence of a constant $c_\lambda > 0$ such that

$$\frac{k_1^2}{k_2 k_\delta} = \lambda_{\max} + c_\lambda. \quad (32)$$

From Eq. (31), using Cauchy-Schwartz inequality one ensures that $\mathbf{W} \leq -\varepsilon I_{6 \times 6}$ if for all $i \in \{1, 2, 3\}$

$$\begin{aligned} (k_1 + p_2 k_2 - p_1 k_\delta \lambda_i)^2 &\leq 4 \left(k_2 - \frac{\varepsilon}{2} \right) \left(p_2 k_1 - k_\delta \lambda_i - \frac{\varepsilon}{2} \right) \\ \Leftrightarrow F_i(p_1) &:= (k_\delta^2 \lambda_i^2) p_1^2 - 2k_\delta \lambda_i (k_1 + p_2 k_2) p_1 \\ &\quad + (k_1 + p_2 k_2)^2 - 4 \left(k_2 - \frac{\varepsilon}{2} \right) \left(p_2 k_1 - k_\delta \lambda_i - \frac{\varepsilon}{2} \right) \leq 0 \end{aligned} \quad (33)$$

Choose $p_2 = k_1/k_2$ and $0 < \varepsilon < \min(2k_2, 2k_\delta c_\lambda)$. Then, it is easy to verify from this choice and Eq. (32) that the determinant of $F_i(p_1)$ is positive. Thus, inequality (33) is satisfied for all $i \in \{1, 2, 3\}$ if

$$\begin{cases} \max_{\lambda_i} p_1^-(\lambda_i) \leq p_1 \leq \min_{\lambda_i} p_1^+(\lambda_i) \\ p_1^\pm(\lambda_i) := \frac{2k_1}{k_\delta \lambda_i} \pm \frac{\sqrt{4(k_2 - \varepsilon/2)(k_1^2/k_2 - k_\delta \lambda_i - \varepsilon/2)}}{k_\delta \lambda_i} \end{cases} \quad (34)$$

It is straightforward to verify that

$$\begin{cases} \lim_{\varepsilon \rightarrow 0} \left(\min_{\lambda_i} p_1^+(\lambda_i) \right) \geq \frac{2k_2}{k_1 - \sqrt{k_1^2 - k_2 k_\delta \lambda_{\max}}} > \frac{k_2}{k_1} = \frac{1}{p_2} \\ \lim_{\varepsilon \rightarrow 0} \left(\max_{\lambda_i} p_1^-(\lambda_i) \right) \leq \frac{2k_2}{k_1 + \sqrt{k_1^2 - k_2 k_\delta \lambda_{\max}}} \end{cases}$$

Thus, by continuity there exists some positive threshold $\bar{\varepsilon}_1$ close enough to zero and smaller than $\min(2k_2, 2k_\delta c_\lambda)$ such that for all $\varepsilon < \bar{\varepsilon}_1$ one has

$$\min_{\lambda_i} p_1^+(\lambda_i) > \max \left(\max_{\lambda_i} p_1^-(\lambda_i), \frac{1}{p_2} \right),$$

which implies the existence of some constant $p_1 > 0$ such that (28) and (34) are satisfied. This concludes the proof.

▷ *Case 2* : Consider the case where $\lambda_{\max} > \frac{(\lambda_{\max} - \lambda_{\min})^2}{4\lambda_{\min}}$. Assume that one can choose some p_1 and p_2 such that

$$p_2 k_1 > k_\delta \lambda_{\max} \quad (35)$$

$$k_1 + p_2 k_2 \geq p_1 k_\delta \frac{\lambda_{\max} + \lambda_{\min}}{2} \quad (36)$$

Then, from Eq. (31) and the fact that $|x_i| = |\bar{x}_i|$, with $i = 1, 2$, one deduces

$$\begin{aligned} \frac{1}{2} X^T \mathbf{W} X &\leq -k_2 |x_1|^2 - (p_2 k_1 - k_\delta \lambda_{\max}) |x_2|^2 \\ &\quad + (k_1 + p_2 k_2 - p_1 k_\delta \lambda_{\min}) |x_1| |x_2| \end{aligned}$$

From here, using Cauchy-Schwartz inequality one ensures that $\mathbf{W} \leq -\varepsilon I_{6 \times 6}$ if

$$\begin{aligned} (k_1 + p_2 k_2 - p_1 k_\delta \lambda_{\min})^2 &\leq 4 \left(k_2 - \frac{\varepsilon}{2} \right) \left(p_2 k_1 - k_\delta \lambda_{\max} - \frac{\varepsilon}{2} \right) \\ \Leftrightarrow (k_\delta^2 \lambda_{\min}^2) p_1^2 - 2k_\delta \lambda_{\min} (k_1 + p_2 k_2) p_1 \\ &\quad + (k_1 + p_2 k_2)^2 - 4 \left(k_2 - \frac{\varepsilon}{2} \right) \left(p_2 k_1 - k_\delta \lambda_{\max} - \frac{\varepsilon}{2} \right) \leq 0 \quad (37) \end{aligned}$$

There exists a positive constant ε close enough to zero such that (37) is satisfied if we have the following strict inequality

$$\begin{aligned} G_1(p_1) := (k_\delta^2 \lambda_{\min}^2) p_1^2 - 2k_\delta \lambda_{\min} (k_1 + p_2 k_2) p_1 \\ + (k_1 + p_2 k_2)^2 - 4k_2 (p_2 k_1 - k_\delta \lambda_{\max}) < 0 \quad (38) \end{aligned}$$

It is easy to verify from Eq. (35) that the determinant of $G_1(p_1)$ is positive. Thus, inequality (38) is satisfied if

$$\begin{cases} p_1^- \leq p_1 \leq p_1^+ \\ p_1^\pm := \frac{k_1 + p_2 k_2}{k_\delta \lambda_{\min}} \pm \frac{\sqrt{4k_2 (p_2 k_1 - k_\delta \lambda_{\max})}}{k_\delta \lambda_{\min}} \end{cases} \quad (39)$$

Combining Eqs. (28) and (36) one obtains

$$\frac{1}{p_2} < p_1 \leq \frac{2(k_1 + p_2 k_2)}{k_\delta (\lambda_{\max} + \lambda_{\min})} \quad (40)$$

One easily verifies from Eq. (35) that

$$\frac{1}{p_2} < \frac{k_1}{k_\delta \lambda_{\max}} < \frac{2(k_1 + p_2 k_2)}{k_\delta (\lambda_{\max} + \lambda_{\min})} < p_1^+$$

Thus, the existence of some $p_1 > 0$, such that Eqs. (39) and (40) are satisfied, is ensured if

$$\begin{aligned} \frac{2(k_1 + p_2 k_2)}{k_\delta (\lambda_{\max} + \lambda_{\min})} &> p_1^- \\ \Leftrightarrow (k_1 + p_2 k_2)^2 \left(\frac{\lambda_{\max} - \lambda_{\min}}{\lambda_{\max} + \lambda_{\min}} \right)^2 &< 4k_2 (p_2 k_1 - k_\delta \lambda_{\max}) \\ \Leftrightarrow G_2(p_2) := \left(\frac{\lambda_{\max} - \lambda_{\min}}{\lambda_{\max} + \lambda_{\min}} \right)^2 k_2^2 p_2^2 \\ &\quad - 2k_1 k_2 \left(2 - \left(\frac{\lambda_{\max} - \lambda_{\min}}{\lambda_{\max} + \lambda_{\min}} \right)^2 \right) p_2 \\ &\quad + k_1^2 \left(\frac{\lambda_{\max} - \lambda_{\min}}{\lambda_{\max} + \lambda_{\min}} \right)^2 + 4k_2 k_\delta \lambda_{\max} < 0 \end{aligned}$$

The determinant of $G_2(p_2)$ is ensured to be positive from the condition (27). This in turn ensures the existence of some $p_2 > 0$ such that $G_2(p_2) < 0$. We have proved the existence of some positive constants p_1 and p_2 satisfying conditions (28), (35), and (36) such that inequality (29) holds for some positive constant ε . This concludes the proof. ■

VI. SIMULATION RESULTS

The controller has been implemented and tested together with the dynamics of a realistic AUV. The simulated vehicle belongs to the family of fully-actuated underwater vehicles which possess full control over all components of the control forces and torques. The physical parameters of the vehicle are shown in Table 1. Two border lines of the tracked pipe stay in a horizontal plane (with $Z=0$) in the inertial frame. The direction of the lines \mathbf{u} is parallel to the X -axis of the inertial frame (i.e., $\mathbf{u} = e_1$), where their Y -coord are $y_{L1} = 1m$ and $y_{L2} = 3m$. The initial position of the vehicle has been chosen as $b_B(0) = [0, -5, 7]^T$, 5 m aside and 7 m above the tracked pipe. The initial orientation of the vehicle is 75° rotated from vector \mathbf{u} . The initial roll and pitch angles of the vehicle are null. The reference values, the control gains and parameters are given in lower part of Table 2.

In order to show the robustness of the method to model errors, a different set of parameters are used in the controller, reflecting usually approximative knowledge of the real AUV dynamics. They are given in the upper part of Table 2

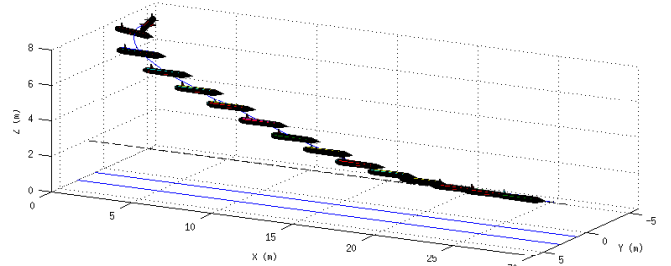


Fig. 3. Perspective view of the simulation

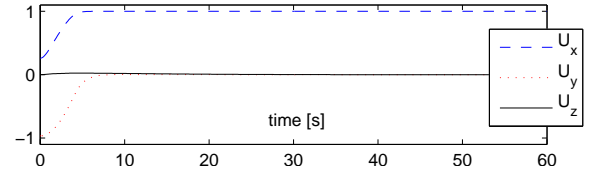


Fig. 4. Components of vector U

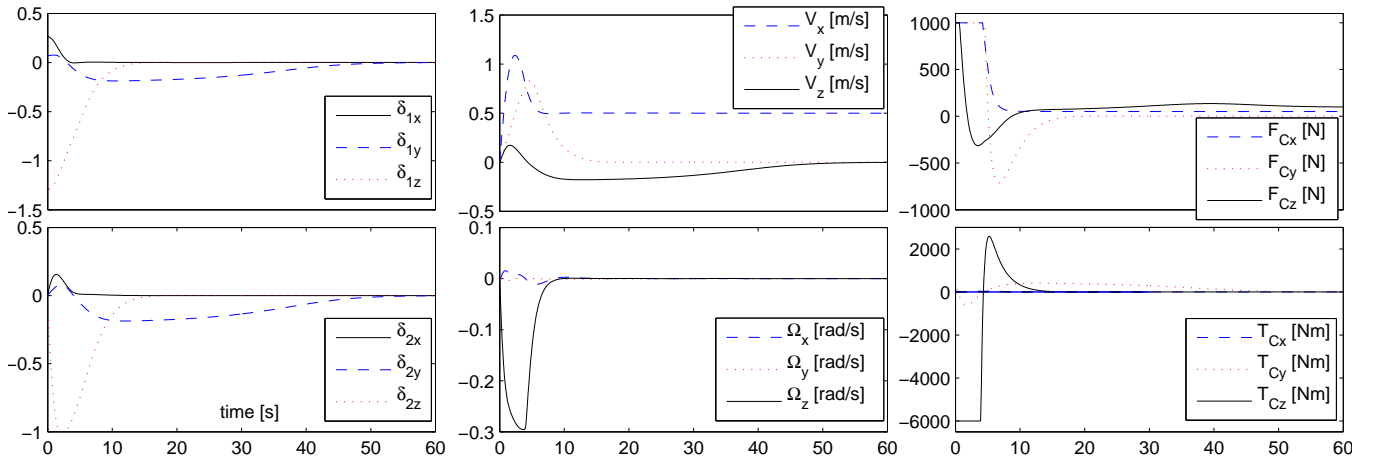


Fig. 2. Numerical results of the simulation. 1st column: error variables of δ_1 and δ_2 ; 2nd column: body-referenced velocities V and Ω ; 3rd column: control forces and torques

The simulation results reported in Fig. 2 show the stabilization of the visual error δ_1 to zero, as well as the regulation of the orientation the desired values. The forwarding velocity converges rapidly to the given value $\alpha = 0.5m/s$. The

vehicle does not experience large pitch and roll angular velocities during the transient period, while only the yaw angular velocity has a visible transient before reaching zero.

The control saturation occurred during a short period and did not significantly affect the overall performance of the controller. The values of Δ_V and Δ_Ω reflect a realistic thrust that real-life propellers could have, with a visible handicap in the pitch regulation - which is the case on several existing AUVs, where pitch is regulated by a separate system, eg. underwater gliders [18]. Thus, the saturation variables can prevent the controller from setting the actuator output to unrealistic or dangerous levels.

VII. CONCLUSIONS

In this paper we developed a nonlinear visual servo control for tracking linear pipelines by fully-actuated underwater vehicle. More precisely, the controller directly uses the image features as feedback information without explicit of the relative pose of the vehicle with respect to the environment. The stability of the closed-loop system is proved and the control algorithm has been tested within a realistic simulation framework. Certain properties of the real-world vehicles which are not part of the generalized approach taken in the theoretical section can be exploited for further refining of the control scheme. Notably, typical AUV hull often resembles a torpedo shape which implies that one of the principal dimensions is significantly bigger than the others. Associated streamlining also causes that one of the coefficients both of the added mass (M_A) and the form drag (B) are of a different order of magnitude than the others. This can be exploited to further enhance the mathematical expression of the controller. The implementation of this scheme on a real system is now envisaged.
