# Description of the minimizers of least squares regularized with $\ell_0$ -norm. Uniqueness of the global minimizer

Abstract. We have an  $M \times N$  real-valued arbitrary matrix A (e. g. a dictionary) with M < N and data d describing the sought-after object with the help of A. This work provides an in-depth analysis of the (local and global) minimizers of an objective function  $\mathcal{F}_d$  combining a quadratic data-fidelity term and an  $\ell_0$  penalty applied to each entry of the sought after solution, weighted by a regularization parameter  $\beta > 0$ . For several decades, this objective focuses a ceaseless effort to conceive algorithms approaching a good minimizer. Our theoretical contributions, summarized below, shed new light on the existing algorithms and can help the conception of innovative numerical schemes.

To solve the normal equation associated with any M-row submatrix of A is equivalent to compute a local minimizer  $\hat{u}$  of  $\mathcal{F}_d$ . (Local) minimizers  $\hat{u}$  of  $\mathcal{F}_d$  are strict if and only if the submatrix, composed of those columns of A whose indexes form the support of  $\hat{u}$ , has full column rank. An outcome is that strict local minimizers of  $\mathcal{F}_d$  are easily computed without knowing the value of  $\beta$ . Each strict local minimizer is linear in data. The global minimizers of  $\mathcal{F}_d$  are always strict. They are studied in more details under the (standard) assumption that  $\operatorname{rank}(A) = M < N$ . The global minimizers with M-length support are seen to be impractical. Given d, critical values  $\beta_K$  for any  $K \leq M - 1$  are exhibited such that if  $\beta > \beta_K$ , all global minimizers of  $\mathcal{F}_d$  are K-sparse.

An assumption on A is adopted and proven to be generically true. Then for generically all data d, the objective  $\mathcal{F}_d$  has a unique global minimizer and the latter is K-sparse for K  $\leq M - 1$ .

Instructive small-size  $(5 \times 10)$  numerical illustrations confirm the main theoretical results.

Key words: global minimizers, local minimizers,  $\ell_0$  regularization, nonconvex nonsmooth minimization problems, perturbation analysis, quadratic programming, solution analysis, sparse recovery, strict minimizers, under-determined linear systems, uniqueness of the solution, variational methods.

#### 1 Introduction

Let A be an arbitrary matrix (e. g. a dictionary) such that

 $A \in \mathbb{R}^{\mathsf{M} \times \mathsf{N}}$  for  $\mathsf{M} < \mathsf{N}$ ,

where the positive integers M and N are fixed. Given a data vector  $d \in \mathbb{R}^{M}$ , we consider an objective function  $\mathcal{F}_{d} : \mathbb{R}^{N} \to \mathbb{R}$  of the form

$$\mathcal{F}_{d}(u) = \|Au - d\|_{2}^{2} + \beta \|u\|_{0}, \quad \beta > 0, \qquad (1)$$
$$\|u\|_{0} = \#\sigma(u),$$

where  $u \in \mathbb{R}^{\mathsf{N}}$  contains the coefficients describing the sought-after object,  $\beta$  is a regularization parameter,  $\sharp$  stands for cardinality and  $\sigma(u)$  is the support of u (i. e. the set of all  $i \in \{1, \dots, \mathsf{N}\}$ for which the *i*th entry of u meets  $u[i] \neq 0$ ). By an abuse of language, the penalty in (1) is called the  $\ell_0$ -norm. Define  $\phi : \mathbb{R} \to \mathbb{R}$  by

$$\phi(t) \stackrel{\text{def}}{=} \begin{cases} 0 & \text{if } t = 0 , \\ 1 & \text{if } t \neq 0 . \end{cases}$$
(2)

Then  $||u||_0 = \sum_{i=1}^{\mathsf{N}} \phi(u[i]) = \sum_{i \in \sigma(u)} \phi(u[i])$ , so  $\mathcal{F}_d$  in (1) equivalently reads

$$\mathcal{F}_{d}(u) = \|Au - d\|_{2}^{2} + \beta \sum_{i=1}^{N} \phi(u[i])$$
(3)

$$= ||Au - d||_{2}^{2} + \beta \sum_{i \in \sigma(u)} \phi(u[i]) .$$
(4)

We focus on all (local and global) minimizers  $\hat{u}$  of an objective  $\mathcal{F}_d$  of the form (1):

$$\hat{u} \in \mathbb{R}^{\mathsf{N}}$$
 such that  $\mathcal{F}_d(\hat{u}) = \min_{u \in \mathcal{O}} \mathcal{F}_d(u)$ , (5)

where  $\mathcal{O}$  is an open neighborhood of  $\hat{u}$ . We note that finding the global minimizer of  $\mathcal{F}_d$  must be an *NP-hard* computational problem [9, 37].

The function  $\phi$  in (2) served as a regularizer for a long time. In the context of Markov random fields it was used by Geman and Geman in 1984 [17] and Besag in 1986 [3] as a prior in MAP energies to restore labeled images. The MAP objective reads

$$\mathcal{F}_{d}(u) = \|Au - d\|_{2}^{2} + \beta \sum_{k} \phi(D_{k}u) , \qquad (6)$$

where  $D_k$  is a finite differences operator and  $\phi$  is given by (2). This label-designed form is known as the Potts prior model, or as the multi-level logistic model [4, 22]. Various stochastic and deterministic algorithms were considered to minimize (6). Leclerc [21] proposed in 1989 a deterministic continuation method to restore piecewise constant images. Robini and Magnin [32] introduced the stochastic continuation approach and successfully used it to reconstruct 3D tomographic images. They refined the method and the theory in [33]. Very recently, Robini and Reissman [34] gave theoretical results relating the probability for global convergence and the computation speed.

The problem stated in (1) and (5)—to (locally) minimize  $\mathcal{F}_d$ —arises when sparse solutions are desired. Typical application fields are signal and image processing, morphologic component analysis, compression, dictionary building, inverse problems, compressive sensing, machine learning, model selection, classification, subset selection, among others. The original hardthresholding method proposed by Donoho and Johnstone [12] amounts to<sup>1</sup> minimize  $\mathcal{F}_d$  where d contains the coefficients of a signal or an image expanded in a wavelet basis (M = N). When M < N various (usually strong) restrictions on  $||u||_0$  (often  $||u||_0$  is replaced by a less irregular function) and on A (e.g. RIP-like criteria, conditions on ||A||, etc.) are needed to conceive

numerical schemes approximating a minimizer of  $\mathcal{F}_d$ , to establish local convergence and derive the asymptotic of the obtained solution. In statistics the problem was widely considered for subset selection and numerous algorithms were designed, with limited theoretical production, as explained in the book of Miller [28]. More recently, Haupt and Nowak [19] investigate the statistical performances of the global minimizer of  $\mathcal{F}_d$  and propose an iterative bound-optimization procedure. Fan and Li [14] discuss a variable splitting and penalty decomposition minimization technique for (1), along with other approximations of the  $\ell_0$ -norm. Liu and Wu [23] mix the  $\ell_0$ and the  $\ell_1$  penalties, establish some asymptotic properties of the new estimator and use mixed integer programming aimed at global minimization. For model selection, Lv and Fan [25] approximate the  $\ell_0$  penalty using functions that are concave on  $\mathbb{R}_+$  and prove a non asymptotic nearly oracle property of the resultant estimator. Thiao et al. [36] reformulate the problem so that an approximate solution can be found using difference of convex functions programming. Blumensath and Davies [6] propose an iterative thresholding scheme to approximate a solution and prove convergence to a local minimizer of  $\mathcal{F}_d$ . Lu and Zhang [24] suggest a penalty decomposition method to minimize  $\mathcal{F}_d$ . Fornasier and Ward [15] propose an iterative thresholding algorithm for finding local minimizers of  $\mathcal{F}_d$  where  $\ell_0$  is replaced by a reasonable sparsity-promoting relaxation given by  $\phi(t) = \min\{t, 1\}$ ; convergence to a local minimizer is established. In a recent report, Chouzenoux et al. [8], a mixed  $\ell_2 - \ell_0$  regularization is considered: a slightly smoothed version of the objective is analyzed and optimization using a majorize-minimize subspace approach is shown to converge to a local minimizer in a finite number of iterations. Since the submission of our paper, image reconstruction methods were designed where  $\ell_0$  regularization is applied to the coefficients of the expansion of the sought-after image in a wavelet frame [40, 11]: the provided numerical results outperform  $\ell_1$  regularization for a reasonable computational cost achieved using penalty decomposition techniques. In a general study on the convergence of descent methods for nonconvex objectives, Attouch et al. [1] apply an inexact forward-backward splitting scheme to find a critical point of  $\mathcal{F}_d$ . Several other references can be evoked, e.g. [29, 16].

Even though overlooked for several decades, the objective  $\mathcal{F}_d$  was essentially considered from a numerical standpoint. The motivation naturally comes from the promising applications and the intrinsic difficulty to minimize  $\mathcal{F}_d$ .

The goal of this work is to analyze the (local and global) minimizers  $\hat{u}$  of objectives  $\mathcal{F}_d$  of the form (1). We provide detailed results on the minimization problem. The uniqueness of the global minimizer of  $\mathcal{F}_d$  is examined as well.

We do not propose an algorithm. However, our theoretical results raise salient cross-questions to the existing algorithms and can help the conception of innovative numerical schemes.

The minimization of  $\mathcal{F}_d$  in (1) might seem close to its constraint variants:

given 
$$\varepsilon \ge 0$$
, minimize  $||u||_0$  subject to  $||Au - d||^2 \le \varepsilon$ ,  
given  $K \in \mathbb{I}_M$ , minimize  $||Au - d||^2$  subject to  $||u||_0 \le K$ . (7)

The latter problems are abundantly studied in the context of sparse recovery in different fields. An excellent account is given in [7], see also the book [26]. For recent achievements, we refer to [38]. It is worth emphasizing that in general, there is no equivalence between the problems stated in (7) and the minimization of  $\mathcal{F}_d$  in (1) because all these problems are nonconvex.

#### 1.1 Main notations and definitions

We remind that if  $\hat{u}$  is a (local) minimizer of  $\mathcal{F}_d$ , the value  $\mathcal{F}_d(\hat{u})$  is a (local) minimum<sup>2</sup> of  $\mathcal{F}_d$ reached at (possibly numerous) points  $\hat{u}$ . Saying that a (local) minimizer  $\hat{u}$  is strict means that there is a neighborhood  $\mathcal{O} \subset \mathbb{R}^N$ , containing  $\hat{u}$ , such that  $\mathcal{F}_d(\hat{u}) < \mathcal{F}_d(v)$  for any  $v \in \mathcal{O} \setminus \{\hat{u}\}$ . So  $\hat{u}$  is an isolated minimizer.

Let K be any positive integer. The expression  $\{u \in \mathbb{R}^{\mathsf{K}} : u \text{ satisfying property } \mathfrak{P}\}$ designates the subset of  $\mathbb{R}^{\mathsf{K}}$  formed from all elements u that meet  $\mathfrak{P}$ . The identity operator on  $\mathbb{R}^{\mathsf{K}}$  is denoted by  $I_{\mathsf{K}}$ . The entries of a vector  $u \in \mathbb{R}^{\mathsf{K}}$  read u[i], for any i. The ith vector of the canonical basis<sup>3</sup> of  $\mathbb{R}^{\mathsf{K}}$  is denoted by  $e_i \in \mathbb{R}^{\mathsf{K}}$ . Given  $u \in \mathbb{R}^{\mathsf{K}}$  and  $\rho > 0$ , the open ball at u of radius  $\rho$  with respect to the  $\ell_p$ -norm for  $1 \leq p \leq \infty$  reads

$$\mathbf{B}_p(u,\rho) \stackrel{\text{def}}{=} \{ v \in \mathbb{R}^{\mathsf{K}} : \|v - u\|_p < \rho \} .$$

To simplify the notations, the  $\ell_2$ -norm is systematically denoted by

 $\|\cdot\| \stackrel{\mathrm{def}}{=} \|\cdot\|_2 \ .$ 

We denote by  $\mathbb{I}_{\mathsf{K}}$  the totally and strictly ordered index set

$$\mathbb{I}_{\mathsf{K}} \stackrel{\text{def}}{=} \left(\{1, \cdots, \mathsf{K}\}, <\right) \,. \tag{8}$$

where the symbol "<" stands for the natural order of the positive integers. Accordingly,

any subset  $\omega \subseteq \mathbb{I}_{N}$  inherits the property of being totally and strictly ordered.

We shall often consider the index set  $\mathbb{I}_N$ . The complement of  $\omega \subseteq \mathbb{I}_N$  in  $\mathbb{I}_N$  is denoted by

$$\omega^c = \mathbb{I}_{\mathsf{N}} \setminus \omega \subseteq \mathbb{I}_{\mathsf{N}} \ .$$

**Definition 1** For any  $u \in \mathbb{R}^N$ , the support  $\sigma(u)$  of u is defined to be the strictly increasing injective map from  $\mathbb{I}_N$  to  $\mathbb{I}_N$ , where  $\mathbb{I}_N$  is defined according to (8), given by

$$\sigma(u) = \left\{ i \in \mathbb{I}_{\mathsf{N}} : u[i] \neq 0 \right\} \subseteq \mathbb{I}_{\mathsf{N}} .$$

If u = 0, clearly  $\sigma(u) = \emptyset$ .

The *i*th column in a matrix  $A \in \mathbb{R}^{M \times N}$  is denoted by  $a_i$ . It is systematically assumed that

$$a_i \neq 0$$
,  $\forall i \in \mathbb{I}_N$ .

For a matrix  $A \in \mathbb{R}^{M \times N}$  and a vector  $u \in \mathbb{R}^N$ , with any  $\omega \subseteq \mathbb{I}_N$ , we associate the submatrix  $A_\omega$  and the subvector  $u_\omega$  given by

$$A_{\omega} \stackrel{\text{def}}{=} \left( a_{\omega[1]}, \cdots, a_{\omega[\sharp \omega]} \right) \in \mathbb{R}^{\mathsf{M} \times \sharp \omega} , \qquad (9)$$

$$u_{\omega} \stackrel{\text{def}}{=} \left( u[\omega[1]], \cdots, u[\omega[\sharp\omega]] \right) \in \mathbb{R}^{\sharp\omega} , \qquad (10)$$

respectively, as well as the zero padding operator  $Z_{\omega}$  :  $\mathbb{R}^{\sharp \omega} \to \mathbb{R}^{\mathsf{N}}$  that inverts (10):

$$u = Z_{\omega} (u_{\omega}) \quad u[i] = \begin{cases} 0 & \text{if } i \notin \omega ,\\ u_{\omega}[k] & \text{for the unique } k \text{ such that } \omega[k] = i. \end{cases}$$
(11)

Thus for  $\omega = \emptyset$  one finds  $u_{\emptyset} = \emptyset$  and  $u = Z_{\emptyset}(u_{\emptyset}) = 0 \in \mathbb{R}^{\mathsf{N}}$ .

Using Definition 1 and the notations in (9)-(10), for any  $u \in \mathbb{R}^{N} \setminus \{0\}$  we have

$$\omega \in \mathbb{I}_{\mathsf{N}} \text{ and } \omega \supseteq \sigma(u) \quad \Rightarrow \quad Au = A_{\omega} u_{\omega} .$$
 (12)

So as to simplify the presentation, we adopt the following definitions  $^4$ :

(a) 
$$A_{\varnothing} = [] \in \mathbb{R}^{\mathsf{M} \times 0}$$
,  
(b)  $\operatorname{rank}(A_{\varnothing}) = 0$ .
(13)

In order to avoid possible ambiguities<sup>5</sup>, we set

$$A_{\omega}^T \stackrel{\text{def}}{=} (A_{\omega})^T \; ,$$

where the superscript "T" stands for transposed. If  $A_{\omega}$  is invertible, similarly  $A_{\omega}^{-1} \stackrel{\text{def}}{=} (A_{\omega})^{-1}$ .

In the course of this work, we shall recurrently refer to the following quadratic constrained optimization problem:

Given  $d \in \mathbb{R}^M$ , for a totally and strictly ordered subset  $\omega \subseteq \mathbb{I}_N$ , problem ( $\mathcal{P}_\omega$ ) reads:

$$(\mathcal{P}_{\omega}) \qquad \left\{ \begin{array}{l} \min_{u \in \mathbb{R}^{\mathsf{N}}} \|Au - d\|^{2} ,\\ \text{subject to} \quad u[i] = 0, \quad \forall i \in \omega^{c} . \end{array} \right.$$
(14)

The definition below will be used to evaluate the extent of some subsets and assumptions.

**Definition 2** Let  $\mathcal{S} \subset \mathbb{R}^{\mathsf{K}}$  be a subset.

- (i) It is said that S is negligible in  $\mathbb{R}^{\mathsf{K}}$  if there exists  $\mathcal{Z} \subset \mathbb{R}^{\mathsf{K}}$  which is closed in  $\mathbb{R}^{\mathsf{K}}$ , its Lebesgue measure in  $\mathbb{R}^{\mathsf{K}}$  is  $\mathbb{L}^{\mathsf{K}}(\mathcal{Z}) = 0$  and  $S \subseteq \mathcal{Z}$ .
- (ii) If a property holds true for all  $v \in \mathbb{R}^{\mathsf{K}} \setminus \mathcal{S}$ , where  $\mathcal{S}$  is negligible in  $\mathbb{R}^{\mathsf{K}}$  in the sense of (i), we say that this property is generic on  $\mathbb{R}^{\mathsf{K}}$ .

The elements of a negligible subset  $S \subset \mathbb{R}^{\mathsf{K}}$  are highly exceptional<sup>6</sup> in  $\mathbb{R}^{\mathsf{K}}$ .

Indeed, the subset  $\mathbb{R}^{\mathsf{K}} \setminus \mathcal{S}$  contains an *open and dense* subset of  $\mathbb{R}^{\mathsf{K}}$ . The chance that a truly random  $v \in \mathbb{R}^{\mathsf{K}}$ —i. e. a v following a non singular probability distribution on  $\mathbb{R}^{\mathsf{K}}$ —comes across such an  $\mathcal{S}$  can be ignored in practice.

#### 1.2 Content of the paper

The main result in section 2 tells us that finding a solution of  $(\mathcal{P}_{\omega})$  for  $\omega \subset \mathbb{I}_{N}$  is equivalent to computing a (local) minimizer of  $\mathcal{F}_{d}$ . In section 3 we prove that the (local) minimizers  $\hat{u}$  of  $\mathcal{F}_{d}$  are strict if and only if the submatrix  $A_{\sigma(\hat{u})}$  has full column rank. The strict minimizers of  $\mathcal{F}_{d}$  are shown to be linear in data d. The importance of the (M - 1)-sparse strict minimizers is emphasized. The global minimizers of  $\mathcal{F}_{d}$  are studied in section 4. They are shown to be strict for any d and for any  $\beta > 0$ . More details are provided under the standard assumption that rank(A) = M < N. Given  $d \in \mathbb{R}^{M}$ , critical values  $\beta_{\mathsf{K}}$  for  $\mathsf{K} \in \mathbb{I}_{\mathsf{M}-1}$  are exhibited such that all global minimizers of  $\mathcal{F}_{d}$  are  $\mathsf{K}$ -sparse<sup>7</sup> if  $\beta > \beta_{\mathsf{K}}$ .

In section 5, a gentle assumption on A is shown to be generic for all  $M \times N$  real matrices. Under this assumption, for generically all data  $d \in \mathbb{R}^M$ , the objective  $\mathcal{F}_d$  for  $\beta > \beta_K$ ,  $K \in \mathbb{I}_{M-1}$ , has a unique global minimizer and the latter is K-sparse.

Small size (A is  $5 \times 10$ ) numerical tests in section 6 illustrate the main theoretical results.

## 2 All minimizers of $\mathcal{F}_d$

#### 2.1 Preliminary results

First, we give some basic facts on problem  $(\mathcal{P}_{\omega})$  as defined in (14) needed for later use. If  $\omega = \emptyset$ , then  $\omega^c = \mathbb{R}^N$ , so the unique solution of  $(\mathcal{P}_{\omega})$  is  $\hat{u} = 0$ . For an arbitrary  $\omega \subset \mathbb{I}_N$  meeting  $\sharp \omega \ge 1$ ,  $(\mathcal{P}_{\omega})$  amounts to minimize a quadratic term with respect to only  $\sharp \omega$  components of u, the remaining entries being null. The latter quadratic problem  $(\mathcal{Q}_{\omega})$  reads

$$(\mathcal{Q}_{\omega}) \qquad \qquad \min_{v \in \mathbb{R}^{\sharp \, \omega}} \left\| A_{\omega} v - d \right\|^2, \quad \sharp \, \omega \ge 1 \ .$$

$$\tag{15}$$

Using the zero-padding operator  $Z_{\omega}$  in (11), we have

$$\left[ \hat{u}_{\omega} \in \mathbb{R}^{\sharp \omega} \text{ solves } (\mathcal{Q}_{\omega}) \text{ and } \hat{u} = Z_{\omega} (\hat{u}_{\omega}) \right] \quad \Leftrightarrow \quad \left[ \hat{u} \in \mathbb{R}^{\mathsf{N}} \text{ solves } (\mathcal{P}_{\omega}), \quad \sharp \omega \ge 1 \right]$$

The optimality conditions for  $(\mathcal{Q}_{\omega})$ , combined with the definition in (13)(a), give rise to the following equivalence which holds true for any  $\omega \subseteq \mathbb{I}_{N}$ :

$$\left[ \hat{u} \in \mathbb{R}^{\mathsf{N}} \text{ solves } (\mathcal{P}_{\omega}) \right] \Leftrightarrow \left[ \hat{u}_{\omega} \in \mathbb{R}^{\sharp \omega} \text{ solves } A_{\omega}^{T} A_{\omega} v = A_{\omega}^{T} d \text{ and } \hat{u} = Z_{\omega} (\hat{u}_{\omega}) \right].$$
(16)

Note that  $A_{\omega}^T A_{\omega} v = A_{\omega}^T d$  in (16) is the normal equation associated to  $A_{\omega} v = d$ .

For  $\omega \subseteq \mathbb{I}_{\mathsf{N}}$ , let  $\mathsf{K}_{\omega}$  denote the vector subspace

$$\mathbf{K}_{\omega} \stackrel{\text{def}}{=} \left\{ v \in \mathbb{R}^{\mathsf{N}} : v[i] = 0, \ \forall \ i \in \omega^c \right\} .$$
(17)

This notation enables problem  $(\mathcal{P}_{\omega})$  in (14) to be rewritten as

$$\min_{u \in \mathcal{K}_{\omega}} \|Au - d\|^2 . \tag{18}$$

The technical lemma below will be used in the sequel. We emphasize that its statement is independent of the vector  $\hat{u} \in \mathbb{R}^{N} \setminus \{0\}$ .

<sup>&</sup>lt;sup>7</sup>As usual, a vector u is said to be K-sparse if  $||u||_0 \leq K$ .

**Lemma 1** Let  $d \in \mathbb{R}^{\mathsf{M}}$ ,  $\beta > 0$  and  $\hat{u} \in \mathbb{R}^{\mathsf{N}} \setminus \{0\}$  be arbitrary. For  $\hat{\sigma} \stackrel{\text{def}}{=} \sigma(\hat{u})$ , set

$$\rho \stackrel{\text{def}}{=} \min\left\{ \min_{i \in \hat{\sigma}} \left| \hat{u}[i] \right|, \frac{\beta}{2\left( \|A^T(A\hat{u} - d)\|_1 + 1 \right)} \right\}.$$
(19)

Then  $\rho > 0$ .

(i) For  $\phi$  as defined in (2), we have

$$v \in \mathcal{B}_{\infty}(0,\rho) \quad \Rightarrow \quad \sum_{i \in \mathbb{I}_{\mathsf{N}}} \phi\big(\,\hat{u}[i] + v[i]\,\big) = \sum_{i \in \hat{\sigma}} \phi\,(\hat{u}[i]) + \sum_{i \in \hat{\sigma}^c} \phi\,(v[i]) \;\;;$$

(ii) For  $K_{\hat{\sigma}}$  defined according to (17),  $\mathcal{F}_d$  satisfies

$$v \in \mathcal{B}_{\infty}(0,\rho) \cap \left(\mathbb{R}^{\mathsf{N}} \setminus \mathcal{K}_{\hat{\sigma}}\right) \quad \Rightarrow \quad \mathcal{F}_{d}(\hat{u}+v) \geq \mathcal{F}_{d}(\hat{u})$$

where the inequality is strict when  $\hat{\sigma}^c \neq \emptyset$ .

The proof is outlined in Appendix 8.1, p. 26.

#### 2.2 The (local) minimizers of $\mathcal{F}_d$ solve quadratic problems

It is worth emphasizing that no special assumptions on the matrix A are adopted.

We begin with an easy but warning result.

**Lemma 2** For any  $d \in \mathbb{R}^{\mathsf{M}}$  and  $\forall \beta > 0$ ,  $\mathcal{F}_d$  has a strict (local) minimum at  $\hat{u} = 0 \in \mathbb{R}^{\mathsf{N}}$ . **Proof.** Using that  $\mathcal{F}_d(0) = ||d||^2 \ge 0$ , we have

$$\mathcal{F}_{d}(v) = \|Av - d\|^{2} + \beta \|v\|_{0} = \mathcal{F}_{d}(0) + \mathcal{R}_{d}(v) , \qquad (20)$$

where 
$$\mathcal{R}_d(v) = ||Av||^2 - 2\langle v, A^T d \rangle + \beta ||v||_0$$
. (21)

Noticing that  $\beta \|v\|_0 \ge \beta > 0$  for  $v \ne 0$  leads to

$$v \in \mathcal{B}_2\left(0, \frac{\beta}{2\|A^Td\| + 1}\right) \setminus \{0\} \quad \Rightarrow \quad \mathcal{R}_d(v) \ge -2\|v\| \|A^Td\| + \beta > 0 \ .$$

Inserting the latter implication into (20) entails the statement.

For any  $\beta > 0$  and  $d \in \mathbb{R}^{M}$ , the sparsest strict local minimizer of  $\mathcal{F}_{d}$  reads  $\hat{u} = 0$ . Initialization with zero of a suboptimal algorithm should generally be a bad choice.

Indeed, experiments have shown that such an initialization can be harmful, see e. g. [28, 6].

The next proposition states a (might be intuitive) result that is often evoked in this work.

**Proposition 1** Let  $d \in \mathbb{R}^{M}$ . Given an  $\omega \subseteq \mathbb{I}_{N}$ , let  $\hat{u}$  solve problem ( $\mathcal{P}_{\omega}$ ) as formulated in (14). Then for any  $\beta > 0$ , the objective  $\mathcal{F}_{d}$  in (1) reaches a (local) minimum at  $\hat{u}$  and

$$\sigma(\hat{u}) \subseteq \omega , \qquad (22)$$

where  $\sigma(\hat{u})$  reads according to Definition 1.

**Proof.** Let  $\hat{u}$  solve problem  $(\mathcal{P}_{\omega})$  and  $\beta > 0$ . The constraint in  $(\mathcal{P}_{\omega})$  entails (22).

Consider that  $\hat{u} \neq 0$  in which case for  $\hat{\sigma} \stackrel{\text{def}}{=} \sigma(\hat{u})$  we have  $1 \leq \sharp \hat{\sigma} \leq \sharp \omega$ . Using the equivalent formulation of  $(\mathcal{P}_{\omega})$  given in (17)-(18), p. 6, yields

$$v \in \mathbf{K}_{\omega} \quad \Rightarrow \quad \|A(\hat{u}+v) - d\|^2 \ge \|A\hat{u} - d\|^2 .$$
 (23)

The inclusion in (22) is equivalent to  $\omega^c \subseteq \hat{\sigma}^c$ . Let  $K_{\hat{\sigma}}$  read according to (17) as well. Then

$$\hat{u} \in \mathbf{K}_{\hat{\sigma}} \subseteq \mathbf{K}_{\omega}.$$

Combining the latter relation with (23) entails that

$$v \in \mathbf{K}_{\hat{\sigma}} \quad \Rightarrow \quad \|A(\hat{u}+v) - d\|^2 \ge \|A\hat{u} - d\|^2 \ . \tag{24}$$

Let  $\rho$  read as in (19), Lemma 1. Noticing that by (2) and (17)

$$v \in \mathbf{K}_{\hat{\sigma}} \Rightarrow \phi(v[i]) = 0, \quad \forall \ i \in \hat{\sigma}^c$$
, (25)

the following inequality chain is derived:

$$\begin{aligned} v \in \mathcal{B}_{\infty}(0,\rho) \cap \mathcal{K}_{\hat{\sigma}} &\Rightarrow \mathcal{F}_{d}(\hat{u}+v) = \|A(\hat{u}+v) - d\|^{2} + \beta \sum_{i \in \mathbb{I}_{\mathsf{N}}} \phi\left(\hat{u}[i] + v[i]\right) \\ \left[ \text{by Lemma 1(i)} \right] &= \|A(\hat{u}+v) - d\|^{2} + \beta \sum_{i \in \hat{\sigma}} \phi\left(\hat{u}[i]\right) + \beta \sum_{i \in \hat{\sigma}^{c}} \phi\left(v[i]\right) \\ \left[ \text{by (25)} \right] &= \|A(\hat{u}+v) - d\|^{2} + \beta \sum_{i \in \hat{\sigma}} \phi\left(\hat{u}[i]\right) \\ \left[ \text{by (24)} \right] &\geqslant \|A\hat{u} - d\|^{2} + \beta \sum_{i \in \hat{\sigma}} \phi\left(\hat{u}[i]\right) \\ \left[ \text{by (4), p. 2} \right] &= \mathcal{F}_{d}(\hat{u}) . \end{aligned}$$

Combining the latter implication with Lemma 1(ii), p. 7, shows that

$$\mathcal{F}_d(\hat{u}+v) \ge \mathcal{F}_d(\hat{u}), \quad \forall v \in \mathcal{B}_\infty(0,\rho) .$$

If  $\hat{u} = 0$ , this is a (local) minimizer of  $\mathcal{F}_d$  by Lemma 2.

Many authors mention that initialization is paramount for the success of approximate algorithms minimizing  $\mathcal{F}_d$ . In view of Proposition 1, if one already has a well elaborated initialization, it could be enough to solve the relevant problem ( $\mathcal{P}_{\omega}$ ).

The statement reciprocal to Proposition 1 is obvious but it helps our analysis.

**Lemma 3** For  $d \in \mathbb{R}^{\mathsf{M}}$  and  $\beta > 0$ , let  $\mathcal{F}_d$  have a (local) minimum at  $\hat{u}$ . Then  $\hat{u}$  solves  $(\mathcal{P}_{\hat{\sigma}})$  for  $\hat{\sigma} \stackrel{\text{def}}{=} \sigma(\hat{u})$ .

**Proof.** Let  $\hat{u}$  be a (local) minimizer of  $\mathcal{F}_d$ . Denote  $\hat{\sigma} \stackrel{\text{def}}{=} \sigma(\hat{u})$ . Then  $\hat{u}$  solves the problem:

$$\min_{u \in \mathbb{R}^{\mathsf{N}}} \left\{ \|Au - d\|^2 + \beta \, \sharp \, \hat{\sigma} \right\} \text{ subject to } u[i] = 0, \, \forall \, i \in \hat{\sigma}^c.$$

Since  $\sharp \hat{\sigma}$  is a constant,  $\hat{u}$  solves  $(\mathcal{P}_{\hat{\sigma}})$ .

By Proposition 1 and Lemma 3, to solve  $(\mathcal{P}_{\omega})$  for some  $\omega \subseteq \mathbb{I}_{N}$  and then to apply the zero padding operator  $Z_{\omega}$  in (11) is *equivalent* to find a (local) minimizer of  $\mathcal{F}_{d}$ .

This equivalence underlies most of the theory developed in this work.

**Corollary 1** For  $d \in \mathbb{R}^{\mathsf{M}}$  and  $\beta > 0$ , let  $\hat{u}$  be a (local) minimizer of  $\mathcal{F}_d$ . Set  $\hat{\sigma} \stackrel{\text{def}}{=} \sigma(\hat{u})$ . Then

$$\hat{u} = Z_{\hat{\sigma}}(\hat{u}_{\hat{\sigma}})$$
 where  $\hat{u}_{\hat{\sigma}}$  satisfies  $A_{\hat{\sigma}}^T A_{\hat{\sigma}} \hat{u}_{\hat{\sigma}} = A_{\hat{\sigma}}^T d$ . (26)

Conversely, if  $\hat{u} \in \mathbb{R}^{\mathsf{N}}$  meets (26) for  $\hat{\sigma} = \sigma(\hat{u})$ , then  $\hat{u}$  is a (local) minimizer of  $\mathcal{F}_d$ .

**Proof.** By Lemma 3,  $\hat{u}$  solves  $(\mathcal{P}_{\hat{\sigma}})$ . The equation in (26) follows directly from (16) on p. 6. The last claim is a straightforward consequence of (16) and Proposition 1.

Equation (26) shows that a (local) minimizer  $\hat{u}$  of  $\mathcal{F}_d$  follows a pseudo-hard thresholding scheme<sup>8</sup>: the nonzero part  $\hat{u}_{\hat{\sigma}}$  of  $\hat{u}$  is the least squares solution with respect to the submatrix  $A_{\hat{\sigma}}$  and the whole data vector d is involved in its computation. Unlike the hard thresholding scheme in [12], unsignificant or purely noisy data entries can hardly be discarded from  $\hat{u}$  and they risk to pollute its nonzero part  $\hat{u}_{\hat{\sigma}}$ . Noisy data d should degrade  $\hat{u}_{\hat{\sigma}}$  and this effect is stronger if  $A_{\hat{\sigma}}^T A_{\hat{\sigma}}$  is ill-conditioned [10]. The quality of the outcome critically depends on the selected (local) minimizer and on the pertinence of A. See also Remark 1 on p. 12.

It may be interesting to evoke another consequence of Proposition 1:

Given  $d \in \mathbb{R}^{\mathsf{M}}$ , for any  $\omega \subseteq \mathbb{I}_{\mathsf{N}}$ ,  $\mathcal{F}_d$  has a (local) minimizer  $\hat{u}$  such that  $\sigma(\hat{u}) \subseteq \omega$ .

# 3 The strict minimizers of $\mathcal{F}_d$

We remind, yet again, that no special assumptions on  $A \in \mathbb{R}^{M \times N}$  are adopted.

Strict minimizers of an objective function enable unambiguous solutions of inverse problems. We focus on the strict minimizers of  $\mathcal{F}_d$ . The definition below is practical to characterize them.

**Definition 3** Given a matrix  $A \in \mathbb{R}^{M \times N}$ , for any  $r \in \mathbb{I}_M$  we define  $\Omega_r$  as the subset of all r-length supports<sup>9</sup> that correspond to full column rank  $M \times r$  submatrices of A, *i. e.* 

$$\Omega_r = \left\{ \omega \subset \mathbb{I}_{\mathsf{N}} : \quad \sharp \, \omega = r = \operatorname{rank} \left( A_\omega \right) \right\}.$$

Set  $\Omega_0 = \emptyset$  and define as well

$$\Omega \stackrel{\text{def}}{=} \bigcup_{r=0}^{\mathsf{M}-1} \Omega_r \quad \text{and} \quad \Omega_{\max} \stackrel{\text{def}}{=} \Omega \cup \Omega_{\mathsf{M}} \ .$$

Definition 3 entails that for any  $r \in \mathbb{I}_{\mathsf{M}}$ ,

$$\operatorname{rank}(A) = r \ge 1 \quad \Leftrightarrow \quad \Omega_r \neq \emptyset \text{ and } \Omega_t = \emptyset, \ \forall t \ge r+1.$$

<sup>&</sup>lt;sup>8</sup>In a Bayesian setting, the quadratic data fidelity term in  $\mathcal{F}_d$  models data corrupted with Gaussian i.i.d. noise. <sup>9</sup>Remind that any  $\omega$  in  $\Omega_r$  is totally and strictly ordered.

#### 3.1 How to recognize a strict minimizer of $\mathcal{F}_d$ ?

The theorem below gives an exhaustive answer to this question.

**Theorem 1** Given  $d \in \mathbb{R}^{\mathsf{M}}$  and  $\beta > 0$ , let  $\hat{u}$  be a (local) minimizer of  $\mathcal{F}_d$ . Define

 $\hat{\sigma} \stackrel{\mathrm{def}}{=} \sigma(\hat{u})$  .

The following statements are equivalent:

- (i) The (local) minimum that  $\mathcal{F}_d$  has at  $\hat{u}$  is strict;
- (*ii*)  $|\operatorname{rank}(A_{\hat{\sigma}}) = \sharp \hat{\sigma}|;$

(*iii*) 
$$\hat{\sigma} \in \Omega_{\max}$$
.

If  $\hat{u}$  is a strict (local) minimizer of  $\mathcal{F}_d$ , then it reads

$$\hat{u} = Z_{\hat{\sigma}} \left( \hat{u}_{\hat{\sigma}} \right) \quad for \quad \hat{u}_{\hat{\sigma}} = \left( A_{\hat{\sigma}}^T A_{\hat{\sigma}} \right)^{-1} A_{\hat{\sigma}}^T d \tag{27}$$

and satisfies  $\sharp \hat{\sigma} = \|\hat{u}\|_0 \leqslant \mathsf{M}$ .

**Proof.** It is prompt to remember that by the rank-nullity theorem [18, 27] we have

$$\dim \ker (A_{\hat{\sigma}}) = \# \hat{\sigma} - \operatorname{rank} (A_{\hat{\sigma}}) .$$
<sup>(28)</sup>

Proof of  $(i) \Rightarrow (ii)$ . Let  $\hat{u} \neq 0$  be a strict (local) minimizer of  $\mathcal{F}_d$ . Assume that (ii) fails. Using (28) the latter means that

$$\dim \ker \left( A_{\hat{\sigma}} \right) \ge 1 \ . \tag{29}$$

By Lemma 3,  $\hat{u}$  solves ( $\mathcal{P}_{\hat{\sigma}}$ ). Let  $\rho$  read as in (19) and  $K_{\hat{\sigma}}$  be defined according to (17), p. 6. Noticing that

$$v \in \mathbf{K}_{\hat{\sigma}}, \quad \hat{\sigma} \neq \emptyset \quad \Rightarrow \quad Av = A_{\hat{\sigma}} v_{\hat{\sigma}} ,$$

$$(30)$$

Lemma 1(i) shows that

.

$$\begin{cases} v \in \mathcal{B}_{\infty}(0,\rho) \cap \mathcal{K}_{\hat{\sigma}} ,\\ v_{\hat{\sigma}} \in \ker(A_{\hat{\sigma}}) \end{cases} \Rightarrow \mathcal{F}_{d}(\hat{u}+v) = \|A_{\hat{\sigma}}(\hat{u}_{\hat{\sigma}}+v_{\hat{\sigma}})-d\|^{2} + \beta \sum_{i \in \hat{\sigma}} \phi\left(\hat{u}[i]+v[i]\right) \\ \left[ \text{by Lemma 1(i)} \right] = \|A_{\hat{\sigma}}\hat{u}_{\hat{\sigma}}-d\|^{2} + \beta \sum_{i \in \hat{\sigma}} \phi\left(\hat{u}[i]\right) + \beta \sum_{i \in \hat{\sigma}^{c}} \phi\left(v[i]\right) \\ \left[ \text{by (25), p. 8} \right] = \|A_{\hat{\sigma}}\hat{u}_{\hat{\sigma}}-d\|^{2} + \beta \sum_{i \in \hat{\sigma}} \phi\left(\hat{u}[i]\right) \\ \left[ \text{by (4), p. 2} \right] = \mathcal{F}_{d}(\hat{u}) , \end{cases}$$

i. e. that  $\hat{u}$  is not a strict minimizer, which contradicts (i). Hence the assumption in (29) is false. Using (28), (ii) holds true.

If  $\hat{u} = 0$ , then  $\hat{\sigma} = \emptyset$ , hence  $A_{\hat{\sigma}} \in \mathbb{R}^{\mathsf{M} \times 0}$  and rank  $(A_{\hat{\sigma}}) = 0 = \sharp \hat{\sigma}$  after (13).

Proof of  $(ii) \Rightarrow (i)$ . Let  $\hat{u}$  be a minimizer of  $\mathcal{F}_d$  that meets (ii). To have  $\sharp \hat{\sigma} = 0$  is equivalent to  $\hat{u} = 0$ . By Lemma 2,  $\hat{u}$  is a strict minimizer. Focus on  $\sharp \hat{\sigma} \ge 1$ . Since rank  $(A_{\hat{\sigma}}) = \sharp \hat{\sigma} \le \mathsf{M}$  and problem  $(\mathcal{Q}_{\omega})$  in (15), p. 6, is strictly convex for  $\omega = \hat{\sigma}$ , its unique solution  $\hat{u}_{\hat{\sigma}}$  satisfies

$$v \in \mathbb{R}^{\sharp \hat{\sigma}} \setminus \{0\} \quad \Rightarrow \quad \|A_{\hat{\sigma}} \left(\hat{u}_{\hat{\sigma}} + v\right) - d\|^2 > \|A_{\hat{\sigma}} \hat{u}_{\hat{\sigma}} - d\|^2$$

Using (30), p. 10, the latter is equivalent to

$$v \in \mathcal{K}_{\hat{\sigma}} \setminus \{0\} \quad \Rightarrow \quad \|A(\hat{u}+v) - d\|^2 = \|A_{\hat{\sigma}}(\hat{u}_{\hat{\sigma}} + v_{\hat{\sigma}}) - d\|^2 > \|A_{\hat{\sigma}}\hat{u}_{\hat{\sigma}} - d\|^2 = \|A\hat{u} - d\|^2 .$$
(31)

Lemma 1(i), along with (25), p. 8, yields

v

$$\in \mathcal{B}_{\infty}(0,\rho) \cap \mathcal{K}_{\hat{\sigma}} \setminus \{0\} \quad \Rightarrow \quad \mathcal{F}_{d}(\hat{u}+v) = \|A(u+v) - d\|^{2} + \beta \sum_{i \in \hat{\sigma}} \phi\left(\hat{u}[i]\right)$$

$$\left[ \text{by } (31) \right] \qquad > \quad \|A\hat{u} - d\|^{2} + \beta \sum_{i \in \hat{\sigma}} \phi\left(\hat{u}[i]\right)$$

$$= \quad \mathcal{F}_{d}(\hat{u}) \ .$$

Since  $\sharp \hat{\sigma} \leq \mathsf{M} \leq \mathsf{N} - 1$ , we have  $\hat{\sigma}^c \neq \emptyset$ . So Lemma 1(ii) tells us that

$$v \in \mathcal{B}_{\infty}(0,\rho) \setminus \mathcal{K}_{\hat{\sigma}} \Rightarrow \mathcal{F}_d(\hat{u}+v) > \mathcal{F}_d(\hat{u}) .$$

Combining the last two implications proves (i).

**Proof of**  $(ii) \Leftrightarrow (iii)$ . Comparing (iii) with Definitions 1 (p. 4) and 3 shows the statement.

**Proof of equation** (27). It follows from (26) in Corollary 1 (p. 9) where<sup>10</sup>  $A_{\hat{\sigma}}^T A_{\hat{\sigma}}$  is invertible.  $\Box$ 

Theorem 1 provides a simple rule enabling to verify if a numerical scheme has reached or not a strict (local) minimizer of  $\mathcal{F}_d$ .

The notations  $\Omega_r$ ,  $\Omega$  and  $\Omega_{\text{max}}$  are frequently used in this paper. Their interpretation is obvious in the light of Theorem 1.

For any  $d \in \mathbb{R}^{M}$  and  $\forall \beta > 0$ , the set  $\Omega_{\max}$  is composed of the supports of all possible strict (local) minimizers of  $\mathcal{F}_{d}$ , while  $\Omega$  is the subset of those ones that are (M - 1)-sparse.

An easy and useful corollary is presented next.

**Corollary 2** Let  $d \in \mathbb{R}^{\mathsf{M}}$ . Given an arbitrary  $\omega \in \Omega_{\max}$ , let  $\hat{u}$  solve  $(\mathcal{P}_{\omega})$ . Then

(i)  $\hat{u}$  reads

$$\hat{u} = Z_{\omega} \left( \hat{u}_{\omega} \right) \quad where \quad \hat{u}_{\omega} = \left( A_{\omega}^T A_{\omega} \right)^{-1} A_{\omega}^T d , \qquad (32)$$

and meets  $\hat{\sigma} \stackrel{\text{def}}{=} \sigma(\hat{u}) \subseteq \omega$  and  $\hat{\sigma} \in \Omega_{\max}$ ;

(ii) for any  $\beta > 0$ ,  $\hat{u}$  is a strict (local) minimizer of  $\mathcal{F}_d$ ;

<sup>&</sup>lt;sup>10</sup>For  $\hat{\sigma} = \emptyset$ , (11) and (13)(a) show that (27) yields  $\hat{u} = 0$ .

#### (iii) $\hat{u}$ solves $(\mathcal{P}_{\hat{\sigma}})$ .

**Proof.** Using (16) (see p. 6),  $\hat{u}$  meets (*i*) since  $A_{\omega}^T A_{\omega}$  is invertible and  $\sigma(\hat{u}) \subseteq \omega$  by the constraint in  $(\mathcal{P}_{\omega})$ . If  $\hat{\sigma} = \emptyset$ , (*ii*) follows from Lemma 2. For  $\sharp \hat{\sigma} \ge 1$ ,  $A_{\hat{\sigma}}$  is an  $\mathsf{M} \times \sharp \hat{\sigma}$  submatrix of  $A_{\omega}$ . Since rank  $(A_{\omega}) = \sharp \omega$ , we have rank  $(A_{\hat{\sigma}}) = \sharp \hat{\sigma}$  and so  $\hat{\sigma} \in \Omega_{\max}$ . By Proposition 1  $\hat{u}$  is a (local) minimizer of  $\mathcal{F}_d$  and Theorem 1 leads to (*ii*). Lemma 3 and Corollary 2(*ii*) yield (*iii*).  $\Box$ 

The following consequence of Corollary 2 might be striking:

One can easily compute a strict (local) minimizer  $\hat{u}$  of  $\mathcal{F}_d$  without knowing the value of the regularization parameter  $\beta$ . Just data d and an  $\omega \in \Omega_{\max}$  are needed.

Clearly, the support  $\sigma(\hat{u})$  of a nonstrict local minimizer  $\bar{u}$  of  $\mathcal{F}_d$  contains some sub-supports yielding strict (local) minimizers of. It is easy to see that among them, there is  $\hat{\sigma} \subsetneqq \sigma(\bar{u})$  such that the corresponding  $\hat{u}$  given by (27) strictly decreases the value of  $\mathcal{F}_d$ , i.e.  $\mathcal{F}_d(\hat{u}) < \mathcal{F}_d(\bar{u})$ .

#### **3.2** Every strict (local) minimizer of $\mathcal{F}_d$ is linear in d

Here we explore the behavior of the strict (local) minimizers of  $\mathcal{F}_d$  with respect to variations of d. An interesting sequel of Theorem 1 is presented below.

**Corollary 3** For  $d \in \mathbb{R}^{\mathsf{M}}$  and  $\beta > 0$ , let  $\hat{u}$  be a (local) minimizer of  $\mathcal{F}_d$  satisfying  $\hat{\sigma} \stackrel{\text{def}}{=} \sigma(\hat{u}) \in \Omega$ . Define  $\mathbb{N}_{\varnothing} = \mathbb{R}^{\mathsf{M}}$  and for  $\hat{\sigma} \neq \varnothing$ ,

$$\mathbf{N}_{\hat{\sigma}} \stackrel{\mathrm{def}}{=} \ker \left( A_{\hat{\sigma}}^T \right) \subset \mathbb{R}^{\mathsf{M}}$$

We have dim  $N_{\hat{\sigma}} = \mathsf{M} - \sharp \hat{\sigma} \ge 1$  and

 $d' \in \mathbf{N}_{\hat{\sigma}} \quad \Rightarrow \quad \mathcal{F}_{d+d'} \text{ has a strict (local) minimum at } \hat{u} \text{ .}$ 

**Proof.** Since  $\hat{\sigma} \in \Omega$ , the minimizer  $\hat{u}$  is strict by Theorem 1. If  $\hat{u} = 0$ , the claim follows from Lemma 2. Let  $\hat{\sigma} \neq \emptyset$ . By  $d' \in \ker(A_{\hat{\sigma}}^T)$  we find  $A_{\hat{\sigma}}^T(d+d') = A_{\hat{\sigma}}^Td$  for any  $d' \in N_{\hat{\sigma}}$ . Inserting this into (27) in Theorem 1 yields the result.

All data living in the vector subspace  $N_{\hat{\sigma}} \supseteq \{0\}$  yield the same strict (local) minimizer  $\hat{u}$ .

**Remark 1** If data contain some noise n, it can be decomposed in a unique way as  $n = n_{N_{\hat{\sigma}}} + n_{N_{\hat{\sigma}}^{\perp}}$ where  $n_{N_{\hat{\sigma}}} \in N_{\hat{\sigma}}$  and  $n_{N_{\hat{\tau}}^{\perp}} \in N_{\hat{\sigma}}^{\perp}$ . By Corollary 3, the component  $n_{N_{\hat{\sigma}}}$  will be removed.

We shall use the definition given below.

**Definition 4** Let  $\mathcal{O} \subseteq \mathbb{R}^{\mathsf{M}}$  be an open domain. We say that  $\mathcal{U} : \mathcal{O} \to \mathbb{R}^{\mathsf{N}}$  is a local minimizer function for the family of objectives  $\mathfrak{F}_{\mathcal{O}} \stackrel{\text{def}}{=} \{\mathcal{F}_d : d \in \mathcal{O}\}$  if for any  $d \in \mathcal{O}$ , the function  $\mathcal{F}_d$  reaches a strict (local) minimum at  $\mathcal{U}(d)$ .

Corollary 2 shows that for any  $d \in \mathbb{R}^M$ , each strict (local) minimizer of  $\mathcal{F}_d$  is entirely described by an  $\omega \in \Omega_{\max}$  via equation (32) in the same corollary.

Consequently, a local minimizer function  $\mathcal{U}$  is associated with every  $\omega \in \Omega_{\max}$ .

**Lemma 4** For some arbitrarily fixed  $\omega \in \Omega_{\max}$  and  $\beta > 0$ , the family of functions  $\mathfrak{F}_{\mathbb{R}^M}$  has a linear (local) minimizer function  $\mathcal{U} : \mathbb{R}^M \to \mathbb{R}^N$  that reads

$$\forall d \in \mathbb{R}^{\mathsf{M}}, \quad \mathcal{U}(d) = Z_{\omega} \left( U_{\omega} d \right) \quad where \quad U_{\omega} = \left( A_{\omega}^{T} A_{\omega} \right)^{-1} A_{\omega}^{T} \in \mathbb{R}^{\sharp \, \omega \times \mathsf{M}} .$$
(33)

**Proof.** Clearly, the function  $\mathcal{U}$  in (33) is linear in d. From Corollary 2 (p. 11), for any  $\beta > 0$  and for any  $d \in \mathbb{R}^{\mathsf{M}}$ ,  $\mathcal{F}_d$  has a strict (local) minimum at  $\hat{u} = \mathcal{U}(d)$ . Hence  $\mathcal{U}$  fits Definition 4.  $\Box$ 

Even if  $\mathcal{F}_d$  has many strict (local) minimizers, each one of them is linear in d.

Next we exhibit a *negligible* subset of  $\mathbb{R}^{\mathsf{M}}$ , associated with a nonempty  $\omega \in \Omega_{\max}$ , whose elements are data d leading to  $\|\mathcal{U}(d)\|_0 < \sharp \omega$ .

**Lemma 5** For any  $\omega \in \Omega_{\max}$ , define the subset  $D_{\omega} \subset \mathbb{R}^{\mathsf{M}}$  by

$$\mathbf{D}_{\omega} \stackrel{\text{def}}{=} \bigcup_{i=1}^{\sharp \omega} \left\{ g \in \mathbb{R}^{\mathsf{M}} : \left\langle e_{i}, \left( A_{\omega}^{T} A_{\omega} \right)^{-1} A_{\omega}^{T} g \right\rangle = 0 \right\}.$$
(34)

Then  $D_{\omega}$  is closed in  $\mathbb{R}^{\mathsf{M}}$  and  $\mathbb{L}^{\mathsf{M}}(D_{\omega}) = 0$ .

**Proof.** If  $\omega = \emptyset$  then  $D_{\omega} = \emptyset$ , hence the claim. Let  $\sharp \omega \ge 1$ . For some  $i \in \mathbb{I}_{\sharp \omega}$ , set

$$D \stackrel{\text{def}}{=} \left\{ g \in \mathbb{R}^{\mathsf{M}} : \left\langle e_i, \left( A_{\omega}^T A_{\omega} \right)^{-1} A_{\omega}^T g \right\rangle = 0 \right\}$$
$$= \left\{ g \in \mathbb{R}^{\mathsf{M}} : \left\langle A_{\omega} \left( A_{\omega}^T A_{\omega} \right)^{-1} e_i, g \right\rangle = 0 \right\} .$$

Since rank  $\left(A_{\omega}\left(A_{\omega}^{T}A_{\omega}\right)^{-1}\right) = \sharp \omega$ , then ker  $\left(A_{\omega}\left(A_{\omega}^{T}A_{\omega}\right)^{-1}\right) = \{0\}$ . Therefore  $A_{\omega}\left(A_{\omega}^{T}A_{\omega}\right)^{-1}e_{i} \neq 0$ . Hence D is a vector subspace of  $\mathbb{R}^{\mathsf{M}}$  of dimension  $\mathsf{M} - 1$  and so  $\mathbb{L}^{\mathsf{M}}(\mathsf{D}) = 0$ . The conclusion follows from the fact that  $\mathsf{D}_{\omega}$  in (34) is the union of  $\sharp \omega$  subsets like D (see e. g. [35, 13]).  $\Box$ 

**Proposition 2** For some arbitrarily fixed  $\omega \in \Omega_{\max}$  and  $\beta > 0$ , let  $\mathcal{U} : \mathbb{R}^{\mathsf{M}} \to \mathbb{R}^{\mathsf{N}}$  be the relevant (local) minimizer function for  $\mathfrak{F}_{\mathbb{R}^{\mathsf{M}}}$  as given in (33) (Lemma 4). Let  $D_{\omega}$  read as in (34). Then

- (i) the set  $\mathbb{R}^{\mathsf{M}} \setminus \mathsf{D}_{\omega}$  contains an open and dense subset of  $\mathbb{R}^{\mathsf{M}}$ ;
- (ii) the function  $d \mapsto \mathcal{F}_d(\mathcal{U}(d))$  is  $\mathcal{C}^{\infty}$  on  $\mathbb{R}^{\mathsf{M}} \setminus D_{\omega}$  and

$$d \in \mathbb{R}^{\mathsf{M}} \setminus \mathcal{D}_{\omega} \quad \Rightarrow \quad \sigma(\mathcal{U}(d)) = \omega \; .$$

**Proof.** Statement (i) is a straightforward consequence of Lemma 5.

If  $\omega = \emptyset$ , then  $\mathcal{U}(d) = 0$ ,  $\forall d \in \mathbb{R}^{\mathsf{M}}$ , so (*ii*) is trivially satisfied. Consider that  $\sharp \omega \ge 1$ . For any  $i \in \mathbb{I}_{\sharp \omega}$ , the  $\omega[i]$ th component of  $\mathcal{U}(d)$  reads (see Lemma 4)

$$\mathcal{U}_{\omega[i]}(d) = \left\langle e_i \,, \left( A_{\omega}^T A_{\omega} \right)^{-1} A_{\omega}^T \, d \right\rangle \;.$$

The definition of  $D_{\omega}$  shows that

$$d \in \mathbb{R}^{\mathsf{M}} \setminus \mathcal{D}_{\omega} \text{ and } i \in \mathbb{I}_{\sharp \omega} \Rightarrow \mathcal{U}_{\omega[i]}(d) \neq 0$$
,

whereas  $\mathcal{U}_i(d) = 0$  for all  $i \in \omega^c$ . Consequently,

$$\omega \in \Omega_{\max}$$
 and  $d \in \mathbb{R}^{\mathsf{M}} \setminus \mathcal{D}_{\omega} \Rightarrow \sigma(\mathcal{U}(d)) = \omega$ .

Then

 $\omega \in \Omega_{\max} \text{ and } d \in \mathbb{R}^{\mathsf{M}} \setminus \mathcal{D}_{\omega} \implies \mathcal{F}_{d}(\mathcal{U}(d)) = \left\| A\mathcal{U}(d) - d \right\|^{2} + \beta \, \sharp \, \omega \, .$ The map  $d \mapsto \left\| A\mathcal{U}(d) - d \right\|^{2}$  is  $\mathcal{C}^{\infty}$  on  $\mathbb{R}^{\mathsf{M}}$ —see (33)—hence (*ii*).

Generically, a local minimizer function produces solutions sharing the same support.

The application  $d \mapsto \mathcal{F}_d(\mathcal{U}(d))$  is discontinuous on the *negligible* subset  $D_\omega$  where the support of  $\mathcal{U}(d)$  is shrunk.

#### 3.3 Strict minimizers with an M-length support

**Proposition 3** Let rank(A) = M,  $\beta > 0$  and

$$U_{\mathsf{M}} \stackrel{\text{def}}{=} \left\{ \hat{u} \in \mathbb{R}^{\mathsf{N}} : \hat{u} \text{ is a strict (local) minimizer of } \mathcal{F}_{d} \text{ meeting } \|\hat{u}\|_{0} = \mathsf{M} \right\} \,.$$

Put

$$\mathbf{Q}_{\mathsf{M}} \stackrel{\text{def}}{=} \bigcup_{\omega \in \Omega_{\mathsf{M}}} \bigcup_{i \in \mathbb{I}_{\mathsf{M}}} \left\{ g \in \mathbb{R}^{\mathsf{M}} : \left\langle e_{i}, A_{\omega}^{-1} g \right\rangle = 0 \right\} .$$
(35)

Then  $\mathbb{R}^{\mathsf{M}} \setminus \mathrm{Q}_{\mathsf{M}}$  contains an open and dense subset of  $\mathbb{R}^{\mathsf{M}}$  and

$$d \in \mathbb{R}^{\mathsf{M}} \setminus \mathcal{Q}_{\mathsf{M}} \quad \Rightarrow \quad \sharp \mathcal{U}_{\mathsf{M}} = \sharp \Omega_{\mathsf{M}} \quad \text{and} \quad \mathcal{F}_{d}(\hat{u}) = \beta \mathsf{M}, \ \forall \ \hat{u} \in \mathcal{U}_{\mathsf{M}}$$

**Proof**. Note that

$$Q_{\mathsf{M}} = \bigcup_{\omega \in \Omega_{\mathsf{M}}} D_{\omega} ,$$

where  $D_{\omega}$  is given in (34). Proposition 2(*i*) entails that  $\mathbb{R}^{\mathsf{M}} \setminus Q_{\mathsf{M}}$  contains an open and dense subset of  $\mathbb{R}^{\mathsf{M}}$ . Since rank(A) =  $\mathsf{M}$ , we have  $\sharp \Omega_{\mathsf{M}} \ge 1$ . By Proposition 2(*ii*)

 $d \in \mathbb{R}^{\mathsf{M}} \setminus Q_{\mathsf{M}}$  and  $\omega \in \Omega_{\mathsf{M}} \Rightarrow \mathcal{F}_d$  has a strict (local) minimizer  $\hat{u}$  obeying  $\sigma(\hat{u}) = \omega$ . Hence  $\hat{u} \in U_{\mathsf{M}}$  and  $\hat{u}_{\omega} = A_{\omega}^{-1}d$ , so  $||A\hat{u} - d||^2 = 0$  and  $\mathcal{F}_d(\hat{u}) = \beta \mathsf{M}$ .

Hence  $u \in O_M$  and  $u_\omega = A_\omega \ u$ , so ||Au - u|| = 0 and  $\mathcal{F}_d(u) = \beta M$ . If  $\#O_M = 1$  the proof is done. Let  $\#O_M > 2$ . If  $d \in \mathbb{R}^M \setminus O_M$  and  $\pi \in \mathbb{R}$ 

If  $\sharp \Omega_{\mathsf{M}} = 1$ , the proof is done. Let  $\sharp \Omega_{\mathsf{M}} \ge 2$ . If  $d \in \mathbb{R}^{\mathsf{M}} \setminus Q_{\mathsf{M}}$  and  $\varpi \in \Omega_{\mathsf{M}} \setminus \{\omega\}$ , then  $\mathcal{F}_d$  has a strict (local) minimizer  $\hat{u}'$  meeting  $\sigma(\hat{u}') = \varpi$ , hence  $\hat{u}' \neq \hat{u}, \, \hat{u}' \in U_{\mathsf{M}}$  and  $\mathcal{F}_d(\hat{u}') = \beta \mathsf{M}$ .  $\Box$ 

For any  $\beta > 0$ ,  $\mathcal{F}_d$  generically has  $\sharp \Omega_M$  strict minimizers  $\hat{u}$  obeying  $\|\hat{u}\|_0 = M$  and  $\mathcal{F}_d(\hat{u}) = \beta M$ . This disables us to discriminate between all these strict minimizers.

Hence the interest in minimizers with supports living in  $\Omega$ , i. e. strict (M - 1)-sparse minimizers of  $\mathcal{F}_d$ .

# 4 On the global minimizers of $\mathcal{F}_d$

The statement below gives a necessary condition for a global minimizer of  $\mathcal{F}_d$ . It follows directly from [30, Proposition 3.4] where<sup>11</sup> the regularization term is  $||Du||_0$  for a full row rank matrix D. For  $\mathcal{F}_d$  in (1) with  $||a_i||_2 = 1$ ,  $\forall i \in \mathbb{I}_N$ , a simpler condition was derived later on in [37, Theorem 12], using different tools. For completeness, the proof for a general A is outlined in Appendix 8.2 on p. 27.

**Proposition 4** For  $d \in \mathbb{R}^{M}$  and  $\beta > 0$ , let  $\mathcal{F}_{d}$  have a global minimum at  $\hat{u}$ . Then<sup>12</sup>

$$i \in \sigma(\hat{u}) \quad \Rightarrow \quad \left| \hat{u}[i] \right| \ge \frac{\sqrt{\beta}}{\|a_i\|}$$
 (36)

Observe that the lower bound on  $\{ | \hat{u}[i] | : i \in \sigma(\hat{u}) \}$  given in (36) is independent of d. This means that in general, (36) provides a pessimistic bound.

The proof of the proposition shows that (36) is met also by all (local) minimizers of  $\mathcal{F}_d$  satisfying

$$\mathcal{F}_d(\hat{u}) \leqslant \mathcal{F}_d(\hat{u} + \rho e_i), \quad \forall \ \rho \in \mathbb{R}, \ \forall \ i \in \mathbb{I}_N$$
.

#### 4.1 The global minimizers of $\mathcal{F}_d$ are strict

**Remark 2** Let  $d \in \mathbb{R}^{\mathsf{M}}$  and  $\beta > ||d||^2$ . Then  $\mathcal{F}_d$  has a strict global minimum at  $\hat{u} = 0$ . Indeed,  $v \neq 0 \Rightarrow ||v||_0 \ge 1 \Rightarrow \mathcal{F}_d(0) = ||d||^2 < \beta \le ||Av - d||^2 + \beta ||v||_0$ .

For least-squares regularized with a more regular  $\phi$ , one usually gets  $\hat{u} = 0$  asymptotically as  $\beta \to +\infty$  but  $\hat{u} \neq 0$  for finite values of  $\beta$ . The latter does not hold for  $\mathcal{F}_d$  (Remark 2).

Some theoretical results on the global minimizers of  $\mathcal{F}_d$  were obtained by the past [30, 19, 37, 6]. May be their existence seemed "offered" and the question has never been examined.

**Theorem 2** Let  $d \in \mathbb{R}^{\mathsf{M}}$  and  $\beta > 0$ . Then

(i) the set of all global minimizers of  $\mathcal{F}_d$ 

$$\hat{U} \stackrel{\text{def}}{=} \left\{ \hat{u} \in \mathbb{R}^{\mathsf{N}} : \hat{u} = \min_{u \in \mathbb{R}^{N}} \mathcal{F}_{d}(u) \right\}$$

is nonempty;

(ii) every  $\hat{u} \in \hat{U}$  is a strict minimizer of  $\mathcal{F}_d$ , i. e.

$$\sigma(\hat{u}) \in \Omega_{\max} ,$$

hence  $\|\hat{u}\|_0 \leq \mathsf{M}$ .

The proof of the theorem is outlined in Appendix 8.3, p. 29.

One can note that if rank(A) = M, any global minimizer  $\hat{u}$  of  $\mathcal{F}_d$  obeys

 $\mathcal{F}_d(\hat{u}) \leqslant \beta \mathsf{M}$ .

According to Theorem 2, the global minimizers of  $\mathcal{F}_d$  are strict and their number is finite: this is a nice property that fails for many convex nonsmooth optimization problems.

#### 4.2 Can we get K-sparse global minimizers for $K \leq M - 1$ ?

In order to simplify the presentation, in what follows we consider that

 $\operatorname{rank}(A) = \mathsf{M} < \mathsf{N}$  .

Since  $\mathcal{F}_d$  has a large number (typically equal to  $\sharp \Omega_M$ ) of strict minimizers with  $\|\hat{u}\|_0 = M$ yielding the same value  $\mathcal{F}_d(\hat{u}) = \beta M$  (see Proposition 3 on p. 14 and the comments next to it), it is important to get sure that the global minimizers of  $\mathcal{F}_d$  are (M - 1)-sparse.

We introduce a notation which is used in the rest of this article. For any  $K \in \mathbb{I}_{M-1}$ , put

$$\overline{\Omega}_{\mathsf{K}} \stackrel{\text{def}}{=} \bigcup_{r=0}^{\mathsf{K}} \Omega_r , \qquad (37)$$

where  $\Omega_r$  read according to Definition 3 (p. 9). Theorem 1 gives a clear meaning of the sets<sup>13</sup>  $\overline{\Omega}_{\mathsf{K}}$ .

For any  $d \in \mathbb{R}^{\mathsf{M}}$  and any  $\beta > 0$ , for any fixed  $\mathsf{K} \in \mathbb{I}_{\mathsf{M}-1}$ , the set  $\overline{\Omega}_{\mathsf{K}}$  is composed of the supports of all possible K-sparse strict (local) minimizers of  $\mathcal{F}_d$ .

The next propositions checks the existence of  $\beta > 0$  ensuring that all the global minimizers of  $\mathcal{F}_d$  are K-sparse, for some  $K \in \mathbb{I}_{M-1}$ .

**Proposition 5** Let  $d \in \mathbb{R}^{M}$ . For any  $\mathsf{K} \in \mathbb{I}_{\mathsf{M}-1}$ , there exists  $\beta_{\mathsf{K}} \ge 0$  such that if  $\beta > \beta_{\mathsf{K}}$ , then each global minimizer  $\hat{u}$  of  $\mathcal{F}_d$  meets

$$\|\hat{u}\|_0 \leqslant \mathsf{K} \quad \text{and} \quad \sigma(\hat{u}) \in \overline{\Omega}_{\mathsf{K}}$$
 (38)

One can choose  $\beta_{\mathsf{K}} = \|A\widetilde{u} - d\|^2$  where  $\widetilde{u}$  solves ( $\mathcal{P}_{\omega}$ ) for some  $\omega \in \Omega_{\mathsf{K}}$ .

The proof is given in Appendix 8.4 (p. 30). The value of  $\beta_{\mathsf{K}}$  in the statement is easy to compute but it is not sharp<sup>14</sup>.

## 5 Uniqueness of the global minimizer of $\mathcal{F}_d$

The presentation is simplified using the notation introduced next.

Given a matrix  $A \in \mathbb{R}^{M \times N}$ , with any  $\omega \in \Omega$  (see Definition 3), we associate the M × M matrix  $\Pi_{\omega}$  that yields the orthogonal projection<sup>15</sup> onto the subspace spanned by the columns of  $A_{\omega}$ :

$$\Pi_{\omega} \stackrel{\text{def}}{=} A_{\omega} \left( A_{\omega}^{T} A_{\omega} \right)^{-1} A_{\omega}^{T} .$$
(39)

$$\beta_{\mathsf{K}} = \min_{\omega \in \Omega_{\mathsf{K}}} \left\{ \|A\widetilde{u} - d\|^2 : \widetilde{u} \text{ solve } (\mathcal{P}_{\omega}) \text{ for } \omega \in \Omega_{\mathsf{K}} \right\} .$$

<sup>15</sup>If  $\omega = \emptyset$ , we have  $A_{\omega} \in \mathbb{R}^{M \times 0}$  and so  $\Pi_{\hat{\sigma}}$  is an  $M \times M$  null matrix.

<sup>&</sup>lt;sup>13</sup>Clearly,  $\overline{\Omega}_{M-1} = \Omega$ .

<sup>&</sup>lt;sup>14</sup>For  $\beta \gtrsim \beta_{\mathsf{K}}$  the global minimizers of  $\mathcal{F}_d$  might be k-sparse for  $k \ll \mathsf{K}$ . A sharp  $\beta_{\mathsf{K}}$  can be obtained as

Checking if a global minimizer  $\hat{u}$  of  $\mathcal{F}_d$  is unique requires to compare its value  $\mathcal{F}_d(\hat{u})$  with the values  $\mathcal{F}_d(\bar{u})$  of the concurrent strict minimizers  $\bar{u}$ . Let  $\hat{u}$  be an  $(\mathsf{M}-1)$ -sparse strict (local) minimizer of  $\mathcal{F}_d$ . Then  $\hat{\sigma} \stackrel{\text{def}}{=} \sigma(\hat{u}) \in \Omega$ . Using (27) in Theorem 1 (p. 10) and (39) shows that

$$\mathcal{F}_{d}(\hat{u}) = \|A_{\hat{\sigma}}\hat{u}_{\hat{\sigma}} - d\|^{2} + \beta \sharp \hat{\sigma}$$

$$= \|A_{\hat{\sigma}} \left(A_{\hat{\sigma}}^{T}A_{\hat{\sigma}}\right)^{-1} A_{\hat{\sigma}}^{T}d - d\|^{2} + \beta \sharp \hat{\sigma}$$

$$= \|(\mathbb{I}_{\mathsf{M}} - \Pi_{\hat{\sigma}})d\|^{2} + \beta \sharp \hat{\sigma}$$

$$= d^{T} \left(I_{\mathsf{M}} - \Pi_{\hat{\sigma}}\right)d + \beta \sharp \hat{\sigma} .$$
(40)

Let  $\bar{u}$  be another  $(\mathsf{M}-1)$ -sparse strict minimizer of  $\mathcal{F}_d$ ,  $\bar{u} \neq \hat{u}$ , and set  $\bar{\sigma} \stackrel{\text{def}}{=} \sigma(\bar{u})$ . Then

$$\mathcal{F}_d(\hat{u}) - \mathcal{F}_d(\bar{u}) = d^T \left( \Pi_{\bar{\sigma}} - \Pi_{\hat{\sigma}} \right) d + \beta (\sharp \hat{\sigma} - \sharp \bar{\sigma}) .$$

If both  $\hat{u}$  and  $\bar{u}$  are global minimizers of  $\mathcal{F}_d$ , the equality given above yields

$$\mathcal{F}_d(\hat{u}) = \mathcal{F}_d(\bar{u}) \quad \Leftrightarrow \quad d^T \left( \Pi_{\bar{\sigma}} - \Pi_{\hat{\sigma}} \right) d = -\beta (\sharp \hat{\sigma} - \sharp \bar{\sigma}) . \tag{41}$$

Equation (41) reveals that the uniqueness of the global minimizer of  $\mathcal{F}_d$  cannot be guaranteed without suitable assumptions on A and on d.

#### 5.1 A generically true assumption on A

We adopt an assumption on the matrix A in  $\mathcal{F}_d$  in order to restrict the cases when (41) takes place for some supports  $\hat{\sigma} \neq \bar{\sigma}$  meeting  $\sharp \hat{\sigma} = \sharp \bar{\sigma}$ .

**H1** The matrix  $A \in \mathbb{R}^{M \times N}$  is such that for some given  $K \in \mathbb{I}_{M-1}$ ,

$$r \in \mathbb{I}_{\mathsf{K}} \text{ and } (\omega, \varpi) \in (\Omega_r \times \Omega_r), \quad \omega \neq \varpi \quad \Rightarrow \quad \Pi_\omega \neq \Pi_\varpi .$$
 (42)

Assumption H1 means that the angle (or the gap) between the equidimensional subspaces Range  $(A_{\omega})$  and Range  $(A_{\varpi})$  must be nonzero [27]. For instance, if  $(i, j) \in \mathbb{I}_{N} \times \mathbb{I}_{N}$  meet  $i \neq j$ , H1 implies that  $a_i \neq \kappa a_j$  for any  $\kappa \in \mathbb{R} \setminus \{0\}$  since  $\prod_{\{i\}} = a_i a_i^T / ||a_i||^2$ .

Checking if H1 holds for a given matrix A requires a combinatorial search over all possible couples  $(\varpi, \omega) \in (\Omega_r \times \Omega_r)$  meeting  $\varpi \neq \omega, \forall r \in \mathbb{I}_K$ . This is hard to do. Instead, we wish to know whether or not H1 is a practical limitation. Using some auxiliary claims, we shall show that H1 fails to hold only for a negligible subset of matrices in the space of all  $M \times N$  real matrices.

**Lemma 6** Given  $r \in \mathbb{I}_{M-1}$  and  $\varpi \in \Omega_r$ , define the following set of submatrices of A:

$$\mathcal{H}_{\varpi} = \left\{ A_{\omega} : \omega \in \Omega_r \text{ and } \Pi_{\omega} = \Pi_{\varpi} \right\}$$

Then  $\mathcal{H}_{\varpi}$  belongs to an  $(r \times r)$ -dimensional subspace of the space of all  $\mathsf{M} \times r$  matrices.

**Proof.** Using that  $\varpi \in \Omega_r$  and  $\omega \in \Omega_r$ , we have<sup>16</sup>

$$\Pi_{\omega} = \Pi_{\varpi} \quad \Leftrightarrow \quad A_{\omega} = \Pi_{\varpi} A_{\omega} \quad . \tag{43}$$

<sup>16</sup>Using (39) (p. 16), as well as the fact that  $A_{\omega} = \prod_{\omega} A_{\omega}, \forall \omega \in \Omega$ , one easily derives that

$$\Pi_{\omega} = \Pi_{\varpi} \quad \Leftrightarrow \left\{ \begin{array}{c} A_{\omega} \left( A_{\omega}^{T} A_{\omega} \right)^{-1} A_{\omega}^{T} = \Pi_{\varpi} \\ A_{\varpi} \left( A_{\varpi}^{T} A_{\varpi} \right)^{-1} A_{\omega}^{T} = \Pi_{\omega} \end{array} \right. \Rightarrow \left\{ \begin{array}{c} A_{\omega} = \Pi_{\varpi} A_{\omega} \\ A_{\varpi} = \Pi_{\omega} A_{\omega} \end{array} \right. \Rightarrow \left\{ \begin{array}{c} \Pi_{\omega} = \Pi_{\varpi} \Pi_{\omega} \\ \Pi_{\varpi} = \Pi_{\omega} \Pi_{\omega} \end{array} \right. \Rightarrow \Pi_{\omega} = \Pi_{\omega}.$$

Therefore  $\mathcal{H}_{\varpi}$  equivalently reads

$$\mathcal{H}_{\varpi} = \left\{ A_{\omega} : \omega \in \Omega_r \text{ and } A_{\omega} = \Pi_{\varpi} A_{\omega} \right\}.$$
(44)

Let  $A_{\omega} \in \mathcal{H}_{\omega}$ . Denote the columns of  $A_{\omega}$  by  $\tilde{a}_i$  for  $i \in \mathbb{I}_r$ . Then (44) yields

$$\Pi_{\varpi}\tilde{a}_i = \tilde{a}_i, \quad \forall i \in \mathbb{I}_r \quad \Rightarrow \quad \tilde{a}_i \in \operatorname{Range}\left(A_{\varpi}\right), \quad \forall i \in \mathbb{I}_r \ .$$

Hence all  $\tilde{a}_i, i \in \mathbb{I}_r$ , live in the *r*-dimensional vector subspace Range  $(A_{\varpi})$ . All the columns of each matrix  $A_{\omega} \in \mathcal{H}_{\varpi}$  belong to Range  $(A_{\varpi})$  as well. It follows that  $\mathcal{H}_{\varpi}$  belongs to a (closed) subspace of dimension  $r \times r$  in the space of all  $\mathsf{M} \times r$  matrices, where  $r \leq \mathsf{M} - 1$ .

More precisions on the submatrices of A living in  $\mathcal{H}_{\varpi}$  are given next.

**Remark 3** The negligible subset  $\mathcal{H}_{\varpi}$  in Lemma 6 is formed from all the submatrices of A that are column equivalent to  $A_{\varpi}$  (see [27, p. 171]), that is

$$A_{\omega} \in \mathcal{H}_{\varpi} \quad \Leftrightarrow \quad \exists P \in \mathbb{R}^{r \times r} \quad meeting \quad \operatorname{rank}(P) = r \quad \operatorname{and} \quad A_{\omega} = A_{\varpi}P \;.$$
 (45)

Observe that P has  $r^2$  unknowns that must satisfy Mr equations and that P must be invertible. Indeed, it should be quite exceptional that such a matrix P does exist.

The latter remark can help to discern structured dictionaries that meet or not H1.

Let us mention a possibly constructive point. If A is such that for a couple  $(\omega, \varpi) \in \Omega_r \times \Omega_r$ ,  $\omega \neq \varpi, r \in \mathbb{I}_{\mathsf{M}-1}$ , we have  $\Pi_{\varpi} = \Pi_{\omega}$ , the non-equality required in H1 can be reached by choosing an  $i \in \omega \setminus (\omega \cap \varpi)$  and replacing the *i*th column  $a_i$  of A by  $\tilde{a}_i$  given by

$$\tilde{a}_i = a_i + v \quad \text{for} \quad v \in \ker\left(A_{\varpi}^T\right) \setminus \{0\}$$

Indeed, using that  $\ker(\Pi_{\varpi}) = \ker(A_{\varpi}^T)$ , one obtains

$$\Pi_{\varpi}\tilde{a}_i = \Pi_{\varpi}(a_i + v) = \Pi_{\varpi}a_i = a_i \neq \tilde{a}_i .$$

By (43), the new matrix (with  $\tilde{a}_i$  in place of  $a_i$ ) meets  $\Pi_{\varpi} \neq \Pi_{\omega}$ .

Next we inspect the set of all matrices A failing assumption H1.

**Lemma 7** Consider the set  $\mathcal{H}$  formed from  $M \times N$  real matrices described next:

$$\mathcal{H} \stackrel{\text{def}}{=} \left\{ A \in \mathbb{R}^{\mathsf{M} \times \mathsf{N}} : \exists r \in \mathbb{I}_{\mathsf{M}-1}, \ \exists (\varpi, \omega) \in \Omega_r \times \Omega_r, \ \varpi \neq \omega \text{ and } \Pi_{\varpi} = \Pi_{\omega} \right\} .$$

Then  $\mathcal{H}$  belongs to a finite union vector subspaces in  $\mathbb{R}^{M \times N}$  whose Lebesgue measure in the latter space is null.

**Proof.** Let  $A \in \mathcal{H}$ . Then there exists at least one integer  $r \in \mathbb{I}_{\mathsf{M}-1}$  and at least one pair  $(\varpi, \omega) \in \Omega_r \times \Omega_r$  such that  $\varpi \neq \omega$  and  $\Pi_{\varpi} = \Pi_{\omega}$ . Using Lemma 6, A contains (at least) one  $\mathsf{M} \times r$  submatrix  $A_{\varpi}$  belonging to an  $r \times r$  vector subspace in the space of all  $\mathsf{M} \times r$  real matrices. Identifying A with an  $\mathsf{MN}$ -length vector, its entries are included in a vector subspace of  $\mathbb{R}^{\mathsf{MN}}$  of dimension no larger than  $\mathsf{MN} - 1$ . The claim of the lemma is straightforward.  $\Box$ 

We can now pleasantly clarify assumption H1.

**Theorem 3** Given an arbitrary  $K \in \mathbb{I}_{M-1}$ , consider the set of  $M \times N$  real matrices below

$$\mathcal{A}_{\mathsf{K}} \stackrel{\text{def}}{=} \left\{ A \in \mathbb{R}^{\mathsf{M} \times \mathsf{N}} : A \text{ satisfies } H1 \text{ for } \mathsf{K} \right\} \,.$$

Then  $\mathcal{A}_{\mathsf{K}}$  contains an open and dense subset in the space of all  $\mathsf{M} \times \mathsf{N}$  real-valued matrices.

**Proof.** The complement of  $\mathcal{A}_{K}$  in the space of all  $M \times N$  real matrices reads

$$\mathcal{A}_{\mathsf{K}}^{c} = \left\{ A \in \mathbb{R}^{\mathsf{M} \times \mathsf{N}} : \text{ H1 fails for } A \text{ and } \mathsf{K} \right\}$$

It is clear that  $\mathcal{A}_{K}^{c} \subset \mathcal{H}$ , where  $\mathcal{H}$  is described in Lemma 7. By the same lemma,  $\mathcal{A}_{K}^{c}$  is included in a closed subset of vector subspaces in  $\mathbb{R}^{M \times N}$  whose Lebesgue measure in the latter space is null. Consequently,  $\mathcal{A}_{K}$  fits the statement.

For any  $K \in \mathbb{I}_{M-1}$ , H1 is a *generic* property of all  $M \times N$  real matrices meeting M < N.

We can note that

$$\mathcal{A}_{\mathsf{K}+1} \subseteq \mathcal{A}_{\mathsf{K}}, \quad \forall \; \mathsf{K} \in \mathbb{I}_{\mathsf{M}-2} \; .$$

One can hence presume that H1 is weakened as K decreases. This issue is illustrated in section 6.

#### 5.2 A generically true assumption on d

A preliminary result, proven in Appendix 8.5 (p. 31), is stated next.

**Lemma 8** Let  $(\omega, \varpi) \in \overline{\Omega}_{\mathsf{K}} \times \overline{\Omega}_{\mathsf{K}}$  for  $\omega \neq \varpi$  and H1 hold for  $\mathsf{K} \in \mathbb{I}_{\mathsf{M}-1}$ . Given  $\kappa \in \mathbb{R}$ , define

$$\mathbf{T}_{\kappa} \stackrel{\text{def}}{=} \{ g \in \mathbb{R}^{\mathsf{M}} : g^{T} (\Pi_{\omega} - \Pi_{\varpi}) g = \kappa \} .$$

Then  $T_{\kappa}$  is a closed subset of  $\mathbb{R}^{\mathsf{M}}$  and  $\mathbb{L}^{\mathsf{M}}(T_{\kappa}) = 0$ .

More precisely, it is shown that  $T_{\kappa}$  are elliptical hyperboloid or conical (for  $\kappa = 0$ ) surfaces of dimension  $\leq M - 1$ . The proof of the lemma includes Lemma 9 devoted to the eigenvalues of a difference of projection matrices, stated and proven on p. 32.

We exhibit a negligible subset of data in  $\mathbb{R}^{\mathsf{M}}$  that can still satisfy the equality in (41), p. 17.

**Proposition 6** For  $\beta > 0$  and  $K \in \mathbb{I}_{M-1}$ , put

$$\Sigma_{\mathsf{K}} \stackrel{\text{def}}{=} \bigcup_{n=-\mathsf{K}}^{\mathsf{K}} \bigcup_{\omega \in \overline{\Omega}_{\mathsf{K}}} \bigcup_{\varpi \in \overline{\Omega}_{\mathsf{K}}} \left\{ g \in \mathbb{R}^{\mathsf{M}} : \omega \neq \varpi \text{ and } g^{T} \Big( \Pi_{\omega} - \Pi_{\varpi} \Big) g = n\beta \right\} , \qquad (46)$$

where  $\overline{\Omega}_{\mathsf{K}}$  is given in (37), p. 16. Let H1 hold for  $\mathsf{K}$ . Then  $\Sigma_{\mathsf{K}}$  is closed in  $\mathbb{R}^{\mathsf{M}}$  and  $\mathbb{L}^{\mathsf{M}}(\Sigma_{\mathsf{K}}) = 0$ .

**Proof.** For some  $n \in \{-\mathsf{K}, \dots, \mathsf{K}\}$  and  $(\omega, \varpi) \in (\overline{\Omega}_{\mathsf{K}} \times \overline{\Omega}_{\mathsf{K}})$  meeting  $\omega \neq \varpi$ , put

$$\Sigma \stackrel{\text{def}}{=} \left\{ g \in \mathbb{R}^{\mathsf{M}} : g^T \Big( \Pi_{\omega} - \Pi_{\overline{\omega}} \Big) g = n\beta \right\} \;.$$

If  $\sharp \omega \neq \sharp \varpi$ , then rank $(\Pi_{\omega} - \Pi_{\varpi}) \ge 1$ . If  $\sharp \omega = \sharp \varpi$ , H1 guarantees that rank $(\Pi_{\omega} - \Pi_{\varpi}) \ge 1$ , yet again. The number  $n\beta \in \mathbb{R}$  is given. According to Lemma 8,  $\Sigma$  is a closed subset of  $\mathbb{R}^{\mathsf{M}}$  and  $\mathbb{L}^{\mathsf{M}}(\Sigma) = 0$ . The conclusion follows from the fact that  $\Sigma_{\mathsf{K}}$  is a finite union of subsets like  $\Sigma$ .  $\Box$ 

We assume thereafter that if H1 holds for some  $K \in \mathbb{I}_{M-1}$ , data d satisfy

$$d \in \{g \in \mathbb{R}^{\mathsf{M}} : g \notin \Sigma_{\mathsf{K}}\} = \mathbb{R}^{\mathsf{M}} \setminus \Sigma_{\mathsf{K}}$$

#### 5.3 The unique global minimizer of $\mathcal{F}_d$ is K-sparse for $K \leq (M-1)$

We are looking for guarantees that  $\mathcal{F}_d$  has a unique global minimizer  $\hat{u}$  obeying

 $\|\hat{u}\|_0 \leq \mathsf{K}$  for some fixed  $\mathsf{K} \in \mathbb{I}_{\mathsf{M}-1}$ .

This is the aim of the next theorem.

**Theorem 4** Given  $K \in \mathbb{I}_{M-1}$ , let H1 hold for K,  $\beta > \beta_K$  where  $\beta_K$  meets Proposition 5 (p. 16) and  $\Sigma_K \subset \mathbb{R}^M$  read as in (46). Consider that

$$d \in \mathbb{R}^{\mathsf{M}} \setminus \Sigma_{\mathsf{K}}$$
.

Then

- (i) data d belong to an open and dense subset of  $\mathbb{R}^{\mathsf{M}}$ ;
- (ii)  $\mathcal{F}_d$  has a unique global minimizer  $\hat{u}$  satisfying  $\|\hat{u}\|_0 \leq \mathsf{K}$ .

**Proof.** The set  $\Sigma_{\mathsf{K}}$  being *negligible* in  $\mathbb{R}^{\mathsf{M}}$  (Proposition 6) entails (*ii*).

Since  $\beta > \beta_{\mathsf{K}}$ , all global minimizers of  $\mathcal{F}_d$  have their support in  $\overline{\Omega}_{\mathsf{K}}$  (Proposition 5). Using that data meet  $d \in \mathbb{R}^{\mathsf{M}} \setminus \Sigma_{\mathsf{K}}$ , the definition of  $\Sigma_{\mathsf{K}}$  in (46) shows that

$$-\mathsf{K} \leqslant n \leqslant \mathsf{K} \text{ and } (\omega, \varpi) \in (\overline{\Omega}_{\mathsf{K}} \times \overline{\Omega}_{\mathsf{K}}), \ \omega \neq \varpi \quad \Rightarrow \quad d^{T} \Big( \Pi_{\omega} - \Pi_{\varpi} \Big) d \neq n\beta .$$
(47)

The proof is conducted by contradiction. Let  $\hat{u}$  and  $\bar{u} \neq \hat{u}$  be two global minimizers of  $\mathcal{F}_d$ . Then

$$\hat{\sigma} \stackrel{\text{def}}{=} \sigma(\hat{u}) \in \overline{\Omega}_{\mathsf{K}} \quad \text{and} \quad \bar{\sigma} \stackrel{\text{def}}{=} \sigma(\bar{u}) \in \overline{\Omega}_{\mathsf{K}} ,$$

and  $\hat{\sigma} \neq \bar{\sigma}$ . By  $\mathcal{F}_d(\hat{u}) = \mathcal{F}_d(\bar{u})$ , equation (41) (p. 17) reads

$$d^{T} \left( \Pi_{\hat{\sigma}} - \Pi_{\bar{\sigma}} \right) d = -\beta \left( \sharp \hat{\sigma} - \sharp \bar{\sigma} \right) .$$
(48)

An enumeration of all possible values of  $\sharp \hat{\sigma} - \sharp \bar{\sigma}$  shows that

$$\beta (\sharp \hat{\sigma} - \sharp \bar{\sigma}) = n\beta \quad \text{for some} \quad n \in \{-\mathsf{K}, \cdots, \mathsf{K}\} \;.$$

Inserting this equation into (48) shows that

$$d^T (\Pi_{\hat{\sigma}} - \Pi_{\bar{\sigma}}) d = n\beta$$
 for some  $n \in \{-\mathsf{K}, \cdots, \mathsf{K}\}$ .

The last result contradicts (47), hence it violates the assumptions H1 and that  $d \in \mathbb{R}^{\mathsf{M}} \setminus \Sigma_{\mathsf{K}}$ . Consequently,  $\mathcal{F}_d$  cannot have two global minimizers. Since  $\mathcal{F}_d$  has always global minimizers (Theorem 2(*i*), p. 15), it follows that  $\mathcal{F}_d$  has a unique global minimizer.  $\Box$ 

For  $\beta > \beta_{K}$ , the objective  $\mathcal{F}_{d}$  in (1) has a unique K-sparse global minimizer where  $K \leq M - 1$ . For all  $K \in \mathbb{I}_{M-1}$ , the claim holds true in a generic sense.

The proof of Theorem 4 shows a wider result: if H1 holds for some  $\mathsf{K} \in \mathbb{I}_{\mathsf{M}-1}$ ,  $\beta > \beta_{\mathsf{K}}$  and  $d \notin \Sigma_{\mathsf{K}}$ , any two distinct K-sparse strict (local) minimizers  $\hat{u}$  and  $\bar{u}$  of  $\mathcal{F}_d$  satisfy  $\mathcal{F}_d(\hat{u}) \neq \mathcal{F}_d(\bar{u})$ .

#### 6 Numerical illustrations

#### 6.1 On assumption H1

Assumption H1 (p. 17) requires that  $\Pi_{\omega} \neq \Pi_{\varpi}$  when  $(\omega, \varpi) \in \Omega_r \times \Omega_r$ ,  $\omega \neq \varpi$  for all  $r \leq \mathsf{K} \in \mathbb{I}_{\mathsf{M}-1}$ . From a practical viewpoint, the magnitude of  $(\Pi_{\omega} - \Pi_{\varpi})$  should be discernible. One way to assess the viability of H1 for a matrix A and  $\mathsf{K} \in \mathbb{I}_{\mathsf{M}-1}$  is to calculate

where 
$$\mu_r(A) \stackrel{\text{def}}{=} \min_{\substack{r \in \mathbb{I}_{\mathsf{K}} \\ (\omega, \varpi) \in \Omega_r \times \Omega_r \\ \omega \neq \varpi}} \mu_r(A) = \min_{\substack{r \in \Omega_r \times \Omega_r \\ \omega \neq \varpi}} \|\Pi_\omega - \Pi_\varpi\|_2, \quad \forall r \in \mathbb{I}_{\mathsf{K}}.$$

$$(49)$$

In fact,  $\|\Pi_{\omega} - \Pi_{\varpi}\|_2 = \sin(\theta)$  where  $\theta \in [0, \pi/2]$  is the maximum angle between Range  $(A_{\omega})$ and Range  $(A_{\varpi})$ , see [27, p. 456]. The latter subspaces have the same dimension and  $\Pi_{\omega} \neq \Pi_{\varpi}$ when  $(\omega, \varpi) \in \Omega_r \times \Omega_r$ ,  $\omega \neq \varpi$  and  $r \in \mathbb{I}_{\mathsf{K}}$ , hence  $\theta \in (0, \pi/2]$ . Consequently,

H1 holds for  $\mathsf{K} \in \mathbb{I}_{\mathsf{M}-1} \Rightarrow \mu_r(A) \in (0,1], \forall r \in \mathbb{I}_{\mathsf{K}} \Rightarrow \xi_{\mathsf{K}}(A) \in (0,1]$ .

According to (49), we have  $\xi_{\mathsf{K}} \ge \xi_{\mathsf{K}+1}$ ,  $\forall \mathsf{K} \in \mathbb{I}_{\mathsf{M}-2}$ . Our guess that assumption H1 is lightened when  $\mathsf{K}$  decreases (see the comments following Theorem 3 on p. 19) means that

$$\xi_1(A) > \dots > \xi_{\mathsf{M}-1}(A)$$
 (50)

We provide numerical tests on two subsets of real-valued random matrices for M = 5 and N = 10, denoted by  $\mathcal{A}_{20}^N$  and  $\mathcal{A}_{1000}^U$ . The values of  $\xi_{\mathsf{K}}(\cdot)$ ,  $\mathsf{K} \in \mathbb{I}_{\mathsf{M}-1} = \mathbb{I}_4$ , for every matrix in  $\mathcal{A}_{20}^N$  and in  $\mathcal{A}_{1000}^U$ , were calculated using exhaustive combinatorial search. All tested matrices satisfy assumption H1, which confirms Theorem 3 (p. 19) and its consequences. In order to evaluate the extent of H1, we computed the worst and the best values of  $\xi_{\mathsf{K}}(\cdot)$  over these sets:

$$\begin{cases} \xi_{\mathsf{K}}^{\text{worst}} = \min_{A \in \mathcal{A}} \xi_{\mathsf{K}}(A) , \\ & \forall \mathsf{K} \in \mathbb{I}_{\mathsf{M}-1} , \quad \mathcal{A} \in \left\{ \mathcal{A}_{20}^{N}, \, \mathcal{A}_{1000}^{U} \right\} . \\ \xi_{\mathsf{K}}^{\text{best}} = \max_{A \in \mathcal{A}} \xi_{\mathsf{K}}(A) , \end{cases}$$
(51)




Figure 1: *x*-axis: the list of the 20 random matrices in  $\mathcal{A}_{20}^N$ . (a) *y*-axis: the value  $\xi_{\mathsf{K}}(A^n)$  according to (49),  $\forall \mathsf{K} \in \mathbb{I}_{\mathsf{M}-1}$  and  $\forall n \in \mathbb{I}_{20}$ . The plot in (b) is a zoom of (a) along the *y*-axis.

Set  $\mathcal{A}_{20}^N$ . This set was formed from 20 matrices  $A^n$ ,  $n \in \mathbb{I}_{20}$  of size  $5 \times 10$ . The components of each matrix  $A^n$  were independent and uniformly drawn from the standard normal distribution with mean zero and variance one. The values of  $\xi_{\mathsf{K}}(\cdot)$  are depicted in Fig. 1. We have<sup>17</sup>  $\xi_1(A^{10}) = \xi_2(A^{10})$  and  $\xi_1(A^{17}) = \xi_2(A^{17})$ . In all other cases (50) is satisfied. Fig. 1 clearly shows that in general  $\xi_{\mathsf{K}}(\cdot)$  increases substantially as  $\mathsf{K}$  decreases (from  $\mathsf{M} - 1$  to 1).

The worst and the best values of  $\xi_{\mathsf{K}}(\cdot)$  over the whole set  $\mathcal{A}_{20}^N$  are displayed in Table 1.

Set  $\mathcal{A}_{1000}^U$ . The set  $\mathcal{A}_{1000}^U$  was composed of one thousand  $5 \times 10$  matrices  $A^n$ ,  $n \in \mathbb{I}_{1000}$ . The entries of each matrix  $A^n$  were independent and uniformly sampled on [-1, 1]. The obtained values for  $\xi_{\mathsf{K}}^{worst}$  and  $\xi_{\mathsf{K}}^{best}$ , calculated according to (51), are shown in Table 2. For  $\mathsf{K} \in \mathbb{I}_3$ , the

best values of  $\xi_{\mathsf{K}}(\cdot)$  were obtained for the same matrix,  $A^{964}$ . Note that  $\xi_4(A^{964}) = 0.0425 \gg \xi_4^{worst}$ . The worst values in Table 2 are smaller than those in Table 1 while the best values in Table 2 are larger than those in Table 1; one credible reason is that  $\mathcal{A}_{1000}^U$  is much larger than  $\mathcal{A}_{20}^N$ .

Overall, equation (50) is satisfied on  $\mathcal{A}_{1000}^U$ —the percentages in Table 3 are pretty small.

Table 3 and Figure 1 agree with our guess that H1 is more viable for smaller values of K.

Based on the magnitudes for  $\xi_{K}^{best}$  in Tables 1 and 2, one can expect that there are some classes of matrices (random or not) that fit H1 for larger values of  $\xi_{K}(\cdot)$ .

#### 6.2 On the global minimizers of $\mathcal{F}_d$

Here we summarize the outcome of a series of experiments corresponding to several matrices  $A \in \mathbb{R}^{M \times N}$  where M = 5 and N = 10, satisfying H1 for K = M-1, different original vectors  $\ddot{u} \in \mathbb{R}^{N}$  and data samples  $d = A\ddot{u} + \text{noise}$ , for various values of  $\beta > 0$ . In each experiment, we computed the complete list of all different strict (local) minimizers of  $\mathcal{F}_d$ , say  $(\hat{u}^i)_{i=1}^n$ . Then the sequence of values  $(\mathcal{F}_d(\hat{u}^i))_{i=1}^n$  was sorted in increasing order,  $\mathcal{F}_d(\hat{u}^{i_1}) \leq \mathcal{F}_d(\hat{u}^{i_2}) \leq \cdots \leq \mathcal{F}_d(\hat{u}^{i_n})$ . A global minimizer  $\hat{u}^{i_1}$  is unique provided that  $\mathcal{F}_d(\hat{u}^{i_1}) < \mathcal{F}_d(\hat{u}^{i_2})$ . In order to discard numerical errors, we also checked if  $|\mathcal{F}_d(\hat{u}^{i_1}) - \mathcal{F}_d(\hat{u}^{i_2})|$  is well detectable.

In all experiments we carried out, the following facts were observed:

- The global minimizer of *F<sub>d</sub>* was unique—manifestly data *d* did never belong to the negligible subset Σ<sub>K</sub> in Proposition 6 (p. 19). This confirms Theorem 4 (p. 20).
- The global minimizers of  $\mathcal{F}_d$  remained unchanged under large variations of  $\beta$ .
- The necessary condition for a global minimizer in Proposition 4 was met.

Next we present in detail two of these experiments where  $\mathcal{F}_d$  is defined using

Only integers appear in (52) for better readability. We have rank(A) = M = 5. An exhaustive combinatorial test shows that the arbitrary matrix A in (52) satisfies H1 for K = M - 1. The values of  $\xi_{\mathsf{K}}(A)$  are seen in Table 4. One notes that  $\mu_2(A) > \mu_1(A)$ , hence  $\xi_1(A) = \xi_2(A)$ .

A way to rate the quality of the solution provided by a global minimizer  $\hat{u}$  of  $\mathcal{F}_d$  is to compute the mean square error (MSE) of the retained non-zero values  $\hat{u}_{\sigma(\hat{u})}$  with respect to  $\ddot{u}_{\sigma(\hat{u})}$ . So

$$MSE(\ddot{u}_{\hat{\sigma}}, \hat{u}_{\hat{\sigma}}) = \frac{1}{\sharp \hat{\sigma}} \sum_{i \in \hat{\sigma}} \left( \hat{u}[i] - \ddot{u}[i] \right)^2 \quad \text{where} \quad \hat{\sigma} \stackrel{\text{def}}{=} \sigma(\hat{u}) .$$
(53)

The rationale is that one expects that the global minimizer  $\hat{u}$  of  $\mathcal{F}_d$  obeys  $\hat{\sigma} \subseteq \sigma(\ddot{u})$  where  $\ddot{u}$  is the original in (52) and that the vanished entries of  $\hat{u}$  correspond to the leas entries of  $\ddot{u}$ .

The experiments described hereafter correspond to two data samples relevant to (52) without and with noise—and to several values of  $\beta > 0$ .

Noise-free data. The noise-free data in (52) read:

$$d = A\ddot{u} = (97, 130, 101, 85, 123)^T.$$
(54)

For different values of  $\beta$ , the global minimizer  $\hat{u}$  is given in Table 5. Since  $\sigma(\ddot{u}) \in \Omega$  and data are noise-free,  $\mathcal{F}_d$  does not have global minimizers with  $\|\hat{u}\|_0 = 5$ . Actually, applying Proposition 5(i) for  $\tilde{u} = \ddot{u}$  yields  $\beta_{\mathsf{M}-1} = 0$ , hence for any  $\beta > 0$  all global minimizers of  $\mathcal{F}_d$  have a support in  $\Omega = \overline{\Omega}_{\mathsf{M}-1}$  (see Definition 3 on p. 9 and (37) on p. 16). The global minimizer  $\hat{u}$  for  $\beta = 1$  meets  $\hat{u} = \ddot{u}$ . For  $\beta = 100$ , the global minimizer  $\hat{u}$  obeys  $\hat{\sigma} \stackrel{\text{def}}{=} \sigma(\hat{u}) = \{3, 5, 10\} \subsetneqq \sigma(\ddot{u})$  and  $\|\hat{u}\|_0 = 3$  the least nonzero entry of the original  $\ddot{u}$  is canceled, which is reasonable. The global minimizers corresponding to  $\beta \ge 300$  are meaningless. We could not find any value of  $\beta$  giving better 2sparse global minimizers. Reminding that data are noise-free, this confirms the discussion next to Corollary 1 (p. 9): the global minimizer of  $\mathcal{F}_d$  realize an only pseudo-hard thresholding. For  $\beta \ge 7 \cdot 10^4 > \|d\|^2$ , the global minimizer of  $\mathcal{F}_d$  is  $\hat{u} = 0$  which confirms Remark 2 (p. 15).

Noisy data. Now we consider *noisy data* in (52) for

$$n = \begin{pmatrix} 4, & -1, & 2, & -3, & 5 \end{pmatrix}^T$$
 (55)

This arbitrary noise yields a signal-to-noise ratio<sup>18</sup> (SNR) equal to 14.07 dB. If  $\beta \leq 0.04$ ,  $\mathcal{F}_d$  has 252 different strict global minimizers  $\hat{u}$  obeying  $\|\hat{u}\|_0 = \mathsf{M}$  and  $\mathcal{F}_d(\hat{u}) = \beta \mathsf{M}$  (remind Proposition 3 on p. 14). For  $\beta \geq 0.05$ , the global minimizer  $\hat{u}$  of  $\mathcal{F}_d$  is unique and meets  $\sigma(\hat{u}) \in \Omega$ . For several values of  $\beta \geq 0.05$ , it is given in Table 6. For  $\beta = 1$ , the global minimizer is meaningless. We

could not find any value of  $\beta$  yielding a better global minimizer with a 4-length support. For

the other values of  $\beta$ , the global minimizer  $\hat{u}$  meets  $\hat{\sigma} \stackrel{\text{def}}{=} \sigma(\hat{u}) \subsetneqq \sigma(\ddot{u})$  and its vanished entries correspond to the least entries in the original  $\ddot{u}$ . For  $\beta = 100$ , the global minimizer seems to furnish a good approximation to  $\ddot{u}$ . Observe that the last entry of the global minimizer  $\hat{u}[10]$ , corresponding to the largest magnitude in  $\ddot{u}$ , freely increases when  $\beta$  increases from  $10^2$  to  $10^4$ . We tested a tight sequence of intermediate values of  $\beta$  without finding better results. Yet again,  $\beta \ge 7 \cdot 10^4 > ||d||^2$  leads to a unique null global minimizer (see Remark 2).




Figure 2: All **638** strict (local) minima of  $\mathcal{F}_d$  in (52) for  $\beta = 100$  and data d corrupted with the arbitrary noise in (55). The x-axis lists all strict (local) minimizers  $\{\hat{u}\}$  of  $\mathcal{F}_d$  sorted according to their  $\ell_0$ -norm  $\|\hat{u}\|_0$  in increasing order. (a) The y-axis shows the value  $\mathcal{F}_d(\hat{u})$  of these minimizers marked with a star. The value of  $\mathcal{F}_d$  for  $\hat{u} = 0$  is not shown because it is too large ( $\mathcal{F}_d(0) = 60559 = \|d\|^2$ ). (b) A zoom of (a) along the y-axis. It clearly shows that  $\mathcal{F}_d$  has a well recognizable unique global minimizer.

Figure 2 shows the value  $\mathcal{F}_d(\hat{u})$  of all the strict local minimizers of  $\mathcal{F}_d$  for  $\beta = 100$ . On the zoom in Figure 2(b) it is well seen that the global minimizer is unique (remember Theorem 4). It meets  $\|\hat{u}\|_0 = 3$  and  $\mathcal{F}_d(\hat{u}) = 301.94$ . One observes that  $\mathcal{F}_d$  has  $252 = \#\Omega_M$  different strict local minimizers  $\hat{u}$  meeting  $\|\hat{u}\|_0 = 5 = M$  and  $\mathcal{F}_d(\hat{u}) = 500 = \beta M$ . This confirms Proposition 3 (p. 14)—obviously d does not belong to the negligible subset  $Q_M$  described in (35).

#### 7 Conclusions and perspectives

We provided a detailed analysis of the (local and global) minimizers of a regularized objective  $\mathcal{F}_d$  composed of an  $\ell_2$  data fidelity term and an  $\ell_0$  penalty weighted by a parameter  $\beta > 0$ , as given in (1), p. 1. We exhibited easy necessary and sufficient conditions ensuring that a (local) minimizer  $\hat{u}$  of  $\mathcal{F}_d$  is strict (Theorem 1). The global minimizers of  $\mathcal{F}_d$  (whose existence was proven in were shown to be strict as well (Theorem 2). Under mild conditions,  $\mathcal{F}_d$  was shown to have a unique global minimizer (Theorem 4). Other interesting results were listed in the Abstract. Below we evoke some perspectives and open questions raised by this work.

• The relationship between the value of the regularization parameter  $\beta$  and the sparsity of the global minimizers of  $\mathcal{F}_d$  (Proposition 5, p. 16) can be improved.

- The generic linearity in data d of each strict (local) minimizer of  $\mathcal{F}_d$  (subsection 3.2, p. 12) should be exploited to better characterize the global minimizers of  $\mathcal{F}_d$ .
- Is there a simple way to check if assumption H1 (p. 17) is satisfied by a given matrix  $A \in \mathbb{R}^{M \times N}$  when M < N are large? Remark 3 and in particular equation (45), p. 18, could help to discard some non-random matrices. Conversely, one can ask if there is a systematic way to construct matrices A that satisfy H1.

An alternative would be to exhibit families of matrices that satisfy H1 for generically large values of  $\xi_{\mathsf{K}}(\cdot)$ , where the latter quantifiers are defined in equation (49) (p. 21).

- A proper adaptation of the results to matrices A and data d with complex entries should not present inherent difficulties.
- The theory developed here can be extended to MAP energies of the form evoked in (6), p. 2. This is important for the imaging applications mentioned there.
- Based on the comments next to Corollary 1 and the numerical tests in subsection 6.2, one has right of asking for conditions ensuring that the global minimizers of  $\mathcal{F}_d$  perform a honorable work. Given the high quality of the numerical results provided in [32, 33], the question deserves attention.

There exist numerous algorithms aimed at approximating a (local) minimizer of  $\mathcal{F}_d$ . As a by-product of our research, we got simple rules to verify whether or not an algorithm could find

- a (local) minimizer  $\hat{u}$  of  $\mathcal{F}_d$ —by checking if  $\hat{u}$  satisfies (26) in Corollary 1 (p. 9);
- and if this local minimizer is strict—by testing if the submatrix whose columns are indexed by the support of  $\hat{u}$  (i. e.  $A_{\hat{\sigma}}$ ) has full column rank (Theorem 1, p. 10).

Some properties of the minimizers of  $\mathcal{F}_d$  given in this work can be inserted in numerical schemes in order to quickly escape from shallow local minimizers.

Many existing numerical methods involve a studious choice of the regularization parameter  $\beta$  and some of them are proven to converge to a local minimizer of  $\mathcal{F}_d$ . We have seen that finding a (strict or nonstrict) local minimizer of  $\mathcal{F}_d$  is independent of the value of  $\beta$  (Corollary 1, p. 9 and Corollary 2, p. 11). There is a theoretical gap that needs clarification. Other successful algorithms are not guaranteed to converge to a local minimizer of  $\mathcal{F}_d$ . Whenever algorithms do a good job, the choice of  $\beta$ , the assumptions on A and on  $\|\hat{u}\|_0$ , the iterative scheme and its initialization obviously provide a tool for selecting a meaningful solution by minimizing  $\mathcal{F}_d$ .

The connection between the existing algorithms and the description of the minimizers exposed in this article deserves a deep exploration.

What conditions ensure that an algorithm minimizing  $\mathcal{F}_d$  yields meaningful solutions?

One can expect that such a research gives rise to innovative and more efficient algorithms enabling to compute relevant solutions by minimizing the tricky objective  $\mathcal{F}_d$ .

### 8 Appendix

#### 8.1 Proof of Lemma 1, p. 7

Since  $\hat{u} \neq 0$ , the definition of  $\hat{\sigma}$  shows that  $\min_{i \in \hat{\sigma}} |\hat{u}[i]| > 0$ . Then  $\rho$  in (19) meets  $\rho > 0$ .

Proof of (i). Since  $\sharp \hat{\sigma} \ge 1$ , we have

$$i \in \hat{\sigma} , \quad v \in \mathcal{B}_{\infty}(0, \rho) \quad \Rightarrow \quad \max_{i \in \hat{\sigma}} |v[i]| < \rho$$

$$\Rightarrow \quad \max_{i \in \hat{\sigma}} |v[i]| < \min_{i \in \hat{\sigma}} |\hat{u}[i]|$$

$$\Rightarrow \quad |\hat{u}[i] + v[i]| \ge |\hat{u}[i]| - |v[i]|$$

$$\geq \min_{i \in \hat{\sigma}} |\hat{u}[i]| - \max_{i \in \hat{\sigma}} |v[i]| \ge \rho - \max_{i \in \hat{\sigma}} |v[i]| > 0$$

$$\Rightarrow \quad \hat{u}[i] + v[i] \ne 0$$

$$\Rightarrow \quad \phi(\hat{u}[i] + v[i]) = \phi(\hat{u}[i]) = 1 . \quad (56)$$

If  $\hat{\sigma}^c = \emptyset$  the result is proven. Let  $\hat{\sigma}^c \neq \emptyset$ . Then  $\hat{u}[i] = 0 = \phi(\hat{u}[i]), \forall i \in \hat{\sigma}^c$ . Statement (i) is obtained by inserting the latter and (56) into

$$\sum_{i \in \mathbb{I}_{\mathsf{N}}} \phi\big(\hat{u}[i] + v[i]\big) = \sum_{i \in \hat{\sigma}} \phi\big(\hat{u}[i] + v[i]\big) + \sum_{i \in \hat{\sigma}^c} \phi\big(\hat{u}[i] + v[i]\big) .$$

Proof of (ii). Using that  $||A(\hat{u}+v) - d||^2 = ||A\hat{u} - d||^2 + ||Av||^2 + 2\langle Av, A\hat{u} - d \rangle$ , one obtains

$$v \in B_{\infty}(0,\rho) \setminus K_{\hat{\sigma}} \Rightarrow \mathcal{F}_{d}(\hat{u}+v) = \|A\hat{u}-d\|^{2} + \|Av\|^{2} + 2\langle Av, A\hat{u}-d\rangle$$

$$\begin{bmatrix} by \text{ Lemma 1}(i) \end{bmatrix} +\beta \sum_{i \in \hat{\sigma}} \phi(v[i]) +\beta \sum_{i \in \hat{\sigma}^{c}} \phi(v[i])$$

$$\begin{bmatrix} using (4), p. 2 \end{bmatrix} = \mathcal{F}_{d}(\hat{u}) + \|Av\|^{2} + 2\langle Av, A\hat{u}-d\rangle +\beta \sum_{i \in \hat{\sigma}^{c}} \phi(v[i])$$

$$\geqslant \mathcal{F}_{d}(\hat{u}) - |2\langle v, A^{T}(A\hat{u}-d)\rangle| +\beta \sharp \hat{\sigma}^{c}$$

If  $\sharp \hat{\sigma}^c = 0$  then  $K_{\hat{\sigma}} = \mathbb{R}^N$ , so  $v \in \mathbb{R}^0$  and  $\|v\|_{\infty} = 0$ , hence the inequality.

Let  $\sharp \hat{\sigma}^c \ge 1$ . The definition of  $\rho$  in (19) shows that

$$\begin{split} v \in \mathcal{B}_{\infty}(0,\rho) \setminus \mathcal{K}_{\hat{\sigma}} &\Rightarrow - \|v\|_{\infty} > -\rho \geqslant -\frac{\beta}{2\Big(\|A^{T}(A\hat{u}-d)\|_{1}+1\Big)} \\ &\Rightarrow -2\|v\|_{\infty} \|A^{T}(A\hat{u}-d)\|_{1} + \beta \,\sharp \,\hat{\sigma}^{c} > -\frac{2\beta \|A^{T}(A\hat{u}-d)\|_{1}}{2\Big(\|A^{T}(A\hat{u}-d)\|_{1}+1\Big)} + \beta \,\sharp \,\hat{\sigma}^{c} > 0 \end{split}$$

Introducing the last inequality into (57) shows that for  $\sharp \hat{\sigma}^c \ge 1$ , the inequality in (*ii*) is strict.

#### 8.2 Proof of Proposition 4, p. 15

If  $\hat{u} = 0$ , the statement is obvious. We focus on  $\hat{u} \neq 0$ . For an arbitrary  $i \in \mathbb{I}_{N}$ , define

$$\hat{u}^{(i)} \stackrel{\text{def}}{=} \left( \hat{u}[1], \cdots, \hat{u}[i-1], 0, \, \hat{u}[i+1], \cdots, \hat{u}[\mathsf{N}] \right) \in \mathbb{R}^{\mathsf{N}} .$$

We shell use the equivalent formulation of  $\mathcal{F}_d$  given in (3). Clearly<sup>19</sup>,

$$\mathcal{F}_{d}(\hat{u}) = \mathcal{F}_{d}(\hat{u}^{(i)} + e_{i}\hat{u}[i]) = \|A\hat{u}^{(i)} + a_{i}\hat{u}[i] - d\|^{2} + \beta \sum_{j \in \mathbb{I}_{N}} \phi\left(\hat{u}^{(i)}[j]\right) + \phi\left(\hat{u}[i]\right) \ .$$

<sup>19</sup>Using the definition of  $\hat{u}^{(i)}$ , we have  $\hat{u}^{(i)} = A_{(\mathbb{I}_{\mathbb{N}} \setminus \{i\})} \hat{u}_{(\mathbb{I}_{\mathbb{N}} \setminus \{i\})}$ , hence  $A\hat{u}^{(i)}$  is independent of  $\hat{u}[i]$ .

Consider  $f_i : \mathbb{R} \to \mathbb{R}$  as given below

$$f_i(t) \stackrel{\text{def}}{=} \mathcal{F}_d\left(\hat{u}^{(i)} + e_i t\right).$$
(58)

Since  $\hat{u}$  is a global minimizer of  $\mathcal{F}_d$ , for any  $i \in \mathbb{I}_N$ , we have

$$\begin{aligned} f_i\left(\hat{u}[i]\right) &= \mathcal{F}_d\left(\hat{u}^{(i)} + e_i\hat{u}[i]\right) \\ &\leqslant \mathcal{F}_d\left(\hat{u}^{(i)} + e_i\,t\right) = f_i(t), \ \forall \ t \in \mathbb{R} \ . \end{aligned}$$

Equivalently, for any  $i \in \mathbb{I}_N$ ,  $f_i(\hat{u}[i])$  is the global minimum of  $f_i(t)$  on  $\mathbb{R}$ . Below we will determine the global minimizer(s)  $\hat{t} = \hat{u}[i]$  of  $f_i$  as given in (58), i. e.

$$\hat{t} = \hat{u}[i] = \arg\min_{t \in \mathbb{R}} f_i(t) \; .$$

Let us focus on an arbitrary  $i \in \mathbb{I}_{N}$ . In detail, the function  $f_i$  reads

$$f_{i}(t) = \|A\hat{u}^{(i)} + a_{i}t - d\|^{2} + \beta \sum_{j \in \mathbb{I}_{N}} \phi\left(\hat{u}^{(i)}[j]\right) + \beta \phi(t)$$

$$= \|A\hat{u}^{(i)} - d\|^{2} + \|a_{i}\|^{2}t^{2} + 2t\langle a_{i}, A\hat{u}^{(i)} - d \rangle + \beta \sum_{j \in \mathbb{I}_{N}} \phi\left(\hat{u}^{(i)}[j]\right) + \beta \phi(t)$$

$$= \|a_{i}\|^{2}t^{2} + 2t\langle a_{i}, A\hat{u}^{(i)} - d \rangle + \beta \phi(t) + C_{i}, \qquad (59)$$

where

$$C_{i} = \|A\hat{u}^{(i)} - d\|^{2} + \beta \sum_{j \in \mathbb{I}_{N}} \phi\left(\hat{u}^{(i)}[j]\right) .$$

Note that  $C_i$  does not depend on t. The function  $f_i$  has two local minimizers denoted by  $\hat{t}_0$  and  $\hat{t}_1$ . The first one is

$$\hat{t}_0 = 0 \quad \Rightarrow \quad f_i(\hat{t}_0) = C_i$$
 (60)

The other one,  $\hat{t}_1 \neq 0$ , corresponds to  $\phi(t) = 1$ . From (59),  $\hat{t}_1$  solves

$$2||a_i||^2 t + 2\langle a_i, A\hat{u}^{(i)} - d \rangle = 0$$

Hence

$$\hat{t}_1 = -\frac{\langle a_i, A\hat{u}^{(i)} - d \rangle}{\|a_i\|^2} \quad \Rightarrow \quad f_i(\hat{t}_1) = -\frac{\langle a_i, A\hat{u}^{(i)} - d \rangle^2}{\|a_i\|^2} + \beta + C_i .$$
(61)

Next we check if  $\hat{t}_0$  or  $\hat{t}_1$  is a global minimizer of  $f_i$ . From (60) and (61) we get

$$f_i(\hat{t}_0) - f_i(\hat{t}_1) = \frac{\langle a_i, A\hat{u}^{(i)} - d \rangle^2}{\|a_i\|^2} - \beta$$
.

Furthermore,

$$\begin{aligned} f_i(\hat{t}_0) &< f_i(\hat{t}_1) \quad \Rightarrow \quad \hat{u}[i] = \hat{t}_0 = 0 , \\ f_i(\hat{t}_1) &< f_i(\hat{t}_0) \quad \Rightarrow \quad \hat{u}[i] = \hat{t}_1 = -\frac{\langle a_i, A\hat{u}^{(i)} - d \rangle}{\|a_i\|^2} , \\ f_i(\hat{t}_0) &= f_i(\hat{t}_1) \quad \Rightarrow \quad \hat{t}_0 \text{ and } \hat{t}_1 \text{ are global minimizers of } f_i. \end{aligned}$$

$$(62)$$

In particular, we have

$$f_{i}(\hat{t}_{1}) \leq f_{i}(\hat{t}_{0}) \quad \Leftrightarrow \quad \langle a_{i}, A\hat{u}^{(i)} - d \rangle^{2} \geq \beta \|a_{i}\|^{2}$$

$$\left[ \text{by (62)} \right] \quad \Rightarrow \quad |\hat{u}[i]| = \frac{|\langle a_{i}, A\hat{u}^{(i)} - d \rangle|}{\|a_{i}\|^{2}}$$

$$\left[ \text{by (63)} \right] \quad \geqslant \frac{\sqrt{\beta} \|a_{i}\|}{\|a_{i}\|^{2}} = \frac{\sqrt{\beta}}{\|a_{i}\|} .$$

$$(63)$$

It is clear that the conclusion holds true for any  $i \in \mathbb{I}_{N}$ .

#### 8.3 Proof of Theorem 2, p. 15

**Proof of** (*i*). Given  $v \in \mathbb{R}^{N}$ , the asymptotic function  $(\mathcal{F}_{d})_{\infty}(v)$  of  $\mathcal{F}_{d}$  reads [2, p. 49]

$$\left(\mathcal{F}_d\right)_{\infty}(v) = \liminf_{v' \to v, t \to \infty} \frac{\mathcal{F}_d(tv')}{t} = \begin{cases} 0 & \text{if } v \in \ker(A) ,\\ +\infty & \text{if } v \notin \ker(A) . \end{cases}$$
(64)

Hence  $\ker (\mathcal{F}_d)_{\infty} = \ker(A)$  and

$$(\mathcal{F}_d)_{\infty}(v) \ge 0, \quad \forall v \in \mathbb{R}^{\mathsf{N}} \setminus \{0\}$$
 (65)

Let  $\{v_k\}$  be any sequence belonging to the set  $S_{\mathcal{F}_d} \subset \mathbb{R}^{\mathsf{N}}$  given below:

$$S_{\mathcal{F}_d} = \left\{ \{v_k\} : \|v_k\| \to \infty , \ \mathcal{F}_d(v_k) \text{ bounded above and } \frac{v_k}{\|v_k\|} \to v \in \ker(A) \right\} .$$

For k large enough,  $v_k \in \ker(A)$  since otherwise the quadratic term in  $\mathcal{F}_d(v_k)$  cannot be bounded above. For such a k, we have  $\mathcal{F}_d(v_k) = ||d||^2 + \beta ||v_k||_0$ . Let

$$z_k \stackrel{\text{def}}{=} \frac{v_k}{\|v_k\|}$$
 and  $\rho_k = \|v_k\|$ .

Then  $\lim_{k \to \infty} z_k = v$  and<sup>20</sup>

$$\mathcal{F}_d(v_k - \rho_k z_k) = \|\rho_k A z_k + d\|^2 + \beta \|v_k - \rho_k z_k\|_0 = \|d\|^2 < \mathcal{F}_d(v_k) .$$
(66)

All conditions in [2, Theorem 3.4.1] are satisfied<sup>21</sup> which ensures that  $\hat{U}$  is nonempty.

**Proof of** (*ii*). Let  $\hat{u}$  be a global minimizer of  $\mathcal{F}_d$ . Set  $\hat{\sigma} = \sigma(\hat{u})$ .

If  $\hat{u} = 0$ , (i) follows from Lemma 2 (p. 7). Let  $\hat{u} \neq 0$  be a nonstrict minimizer of  $\mathcal{F}_d$ . Then Theorem 1(ii) (p. 10), fails to hold, hence

$$\dim \ker \left( A_{\hat{\sigma}} \right) \ge 1 \ . \tag{67}$$

Choose  $v_{\hat{\sigma}} \in \ker(A_{\hat{\sigma}}) \setminus \{0\}$  and set  $v = Z_{\hat{\sigma}}(v_{\hat{\sigma}})$ . Select an  $i \in \hat{\sigma}$  satisfying  $v[i] \neq 0$ . Define  $\tilde{u}$  by

$$\widetilde{u} \stackrel{\text{def}}{=} \widehat{u} - \widehat{u}[i] \frac{v}{v[i]} .$$
(68)

<sup>&</sup>lt;sup>20</sup>The inequality in (66) is strict because  $||v_k|| \to \infty$  implies  $||v_k||_0 \ge 1$ .

<sup>&</sup>lt;sup>21</sup>More precisely, its asked that  $\mathcal{F}_d$  is lower semi-continuous and proper, that (65) holds true and that for every sequence  $\{v_k\} \in S_{\mathcal{F}_d}$ , there exist  $\{z_k\}$  and  $0 < \rho_k \leq ||v_k||$  such that for k large enough  $\mathcal{F}_d(v_k - \rho_k z_k) \leq \mathcal{F}_d(v_k)$  and  $\|\lim_{k\to\infty} z_k - v\| < 1$ , see [2, p. 97].

We have  $\widetilde{u}[i]=0$  and  $\hat{u}[i]\neq 0$  . Set  $\widetilde{\sigma}\stackrel{\rm def}{=}\sigma\left(\widetilde{u}\right).$  Then

$$\widetilde{\sigma} \subsetneqq \widehat{\sigma} \quad \text{hence} \quad \# \widetilde{\sigma} \leqslant \# \widehat{\sigma} - 1 .$$
 (69)

Using that  $v_{\hat{\sigma}} \frac{\hat{u}[i]}{v[i]} \in \ker(A_{\hat{\sigma}})$ , jointly with the expression for  $\tilde{u}$  in (68), shows that

$$A\hat{u} = A_{\hat{\sigma}}\hat{u}_{\hat{\sigma}} = A_{\hat{\sigma}}\left(\hat{u}_{\hat{\sigma}} - v_{\hat{\sigma}}\frac{\hat{u}[i]}{v[i]}\right) = A_{\hat{\sigma}}\widetilde{u}_{\hat{\sigma}} = A_{\widetilde{\sigma}}\widetilde{u}_{\widetilde{\sigma}} = A\widetilde{u}$$

In the latter expression, we also used the relation (12) on p. 5. Then

$$\mathcal{F}_{d}(\widetilde{u}) = \|A\widetilde{u} - d\|^{2} + \beta \sharp \widetilde{\sigma}$$
  
$$\leqslant \quad \mathcal{F}_{d}(\widehat{u}) - \beta = \|A\widehat{u} - d\|^{2} + \beta (\sharp \widehat{\sigma} - 1) .$$

It follows that  $\hat{u}$  is not a global minimizer, hence (67) is false. Therefore rank  $(A_{\hat{\sigma}}) = \sharp \hat{\sigma}$  and  $\hat{u}$  is a strict minimizer of  $\mathcal{F}_d$  (Theorem 1).

#### 8.4 Proof of Proposition 5, p. 16

Given  $K \in \mathbb{I}_{M-1}$ , set

$$U_{\mathsf{K}+1} \stackrel{\text{def}}{=} \bigcup_{\omega \subset \mathbb{I}_{\mathsf{N}}} \{ \bar{u} : \bar{u} \text{ solves } (\mathcal{P}_{\omega}) \text{ and } \|\bar{u}\|_{0} \ge \mathsf{K}+1 \} .$$

$$(70)$$

- Let  $U_{K+1} \neq \emptyset$ . By Proposition 1 (p. 7), for any  $\beta > 0$ ,  $\mathcal{F}_d$  has a (local) minimum at each  $\bar{u} \in U_{K+1}$ . Thus
  - $\bar{u}$  is a (local) minimizer of  $\mathcal{F}_d$  and  $\|\bar{u}\|_0 \ge \mathsf{K} + 1 \quad \Leftrightarrow \quad \bar{u} \in \mathsf{U}_{\mathsf{K}+1}$ . (71)

Then for any  $\beta > 0$ 

$$\mathcal{F}_d(\bar{u}) \ge \beta(\mathsf{K}+1), \quad \forall \ \bar{u} \in U_{\mathsf{K}+1}$$
 (72)

Let  $\widetilde{u}$  be defined by:

 $\widetilde{u}$  solves  $(\mathcal{P}_{\omega})$  for some  $\omega \in \Omega_{\mathsf{K}}$ .

Then

$$\|\widetilde{u}\|_0 \leqslant \mathsf{K} \quad . \tag{73}$$

Set  $\beta$  and  $\beta_{\mathsf{K}}$  according to

$$\beta > \beta_{\mathsf{K}} \stackrel{\text{def}}{=} \|A\widetilde{u} - d\|^2 .$$
(74)

For such a  $\beta$  we have

$$\mathcal{F}_{d}(\widetilde{u}) = \|A\widetilde{u} - d\|^{2} + \beta\|\widetilde{u}\|_{0}$$
  
[by (73) and (74)] <  $\beta + \beta \mathsf{K} = \beta(\mathsf{K} + 1)$   
[by (72)]  $\leqslant \mathcal{F}_{d}(\overline{u}), \quad \forall \, \overline{u} \in \mathsf{U}_{\mathsf{K}+1}$ .

Let  $\hat{u}$  be a global minimizer of  $\mathcal{F}_d$ . Then

$$\mathcal{F}_d(\hat{u}) \leqslant \mathcal{F}_d(\tilde{u}) < \mathcal{F}_d(\bar{u}), \quad \forall \ \bar{u} \in \mathcal{U}_{\mathsf{K}+1} \ .$$

Using (70)-(71), we find

 $\|\hat{u}\|_0 \leqslant \mathsf{K}$ .

•  $U_{K+1} = \emptyset$  entails that<sup>22</sup>

$$\bar{u}$$
 solves  $(\mathcal{P}_{\omega})$  for  $\omega \subset \mathbb{I}_{\mathsf{N}}, \quad \sharp \omega \ge \mathsf{K} + 1 \quad \Rightarrow \quad \|\bar{u}\|_{0} \leqslant \mathsf{K}$ . (75)

Let  $\hat{u}$  be a global minimizer of  $\mathcal{F}_d$ . By (75) we have

$$\|\hat{u}\|_0 \leqslant \mathsf{K}$$
.

According to Theorem 2(ii) (p. 15), any global minimizer of  $\mathcal{F}_d$  is strict, hence  $\sigma(\hat{u}) \in \overline{\Omega}_{\mathsf{K}}$ .

#### 8.5 Proof of Lemma 8, p. 19

The set  $T_{\kappa}$  is closed in  $\mathbb{R}^{\mathsf{M}}$  in all cases. Since  $\Pi_{\omega}$  and  $\Pi_{\varpi}$  are orthogonal projectors, we have<sup>23</sup>

$$(\Pi_{\omega} - \Pi_{\varpi})^T (\Pi_{\omega} - \Pi_{\varpi}) = (\Pi_{\omega} - \Pi_{\varpi}) (\Pi_{\omega} - \Pi_{\varpi})^T .$$

Hence  $(\Pi_{\omega} - \Pi_{\varpi})$  is a normal (unitarily diagonalizable) matrix, i.e. there exist a unitary matrix  $V \in \mathbb{R}^{M \times M}$  and an  $M \times M$  diagonal matrix such that [27, 20]

$$\Pi_{\omega} - \Pi_{\varpi} = V \operatorname{diag}(\lambda_1, \cdots, \lambda_{\mathsf{M}}) V^T , \qquad (76)$$

where  $\lambda_i, \forall i \in \mathbb{I}_M$  are the eigenvalues of  $(\Pi_{\omega} - \Pi_{\varpi})$ . From H1,  $\operatorname{diag}(\lambda_1, \cdots, \lambda_M) \neq 0$ . Set

$$p \stackrel{\text{def}}{=} \operatorname{rank} \left( \Pi_{\omega} - \Pi_{\varpi} \right) \ . \tag{77}$$

We remind that the eigenvalues of a projection matrix  $\Pi_{\omega}$  for  $\omega \in \Omega$  belong to  $\{0, 1\}$ . Clearly

$$\varpi = \varnothing \quad \Rightarrow \quad \mathbf{T}_{\kappa} = \left\{ g \in \mathbb{R}^{\mathsf{M}} : g = Vx \text{ and } \sum_{i \in \mathbb{I}_p} x[i]^2 = \kappa \right\} .$$

For  $\kappa > 0$ ,  $T_{\kappa}$  is isomorphic to a spherical surface and for  $\kappa = 0$  to a vector subspace, hence  $\dim (T_{\kappa}) = \mathsf{M} - p \leq \mathsf{M} - 1$ . For k < 0,  $T_{\kappa} = \emptyset$ . If  $\omega = \emptyset$ ,  $T_{\kappa}$  is negligible in  $\mathbb{R}^{\mathsf{M}}$  as well.

In what follows, consider that  $\sharp \omega \ge 1$  and  $\sharp \varpi \ge 1$ . Observe that

$$\lambda = 1 \quad \text{and} \quad (\Pi_{\omega} - \Pi_{\varpi}) v = \lambda v \neq 0 \quad \Leftrightarrow \quad v \in \ker \Pi_{\varpi} \text{ and} \quad \Pi_{\omega} v = v \neq 0 ,$$

$$\lambda = -1 \quad \text{and} \quad (\Pi_{\omega} - \Pi_{\varpi}) v = \lambda v \neq 0 \quad \Leftrightarrow \quad v \in \ker \Pi_{\omega} \text{ and} \quad \Pi_{\varpi} v = v \neq 0 .$$
(78)

Indeed, we have

$$(\Pi_{\omega} - \Pi_{\varpi}) v = v \qquad \Rightarrow \quad v^T \Pi_{\omega} v - v^T \Pi_{\varpi} v = \|v\|^2 > 0 .$$
<sup>(79)</sup>

Since  $\Pi_{\omega}$  and  $\Pi_{\varpi}$  are also semipositive definite matrices, we have

$$0 \leqslant v^T \Pi_{\omega} v \leqslant \|v\|^2 \quad \text{and} \quad v^T \Pi_{\varpi} v \geqslant 0$$

The equality on the right side of (79) cannot be reached unless  $v^T \Pi_{\varpi} v = \|\Pi_{\varpi} v\| = 0$ , hence  $v \in \ker(\Pi_{\varpi})$  and  $\Pi_{\omega} v = v$ . The reciprocal is direct. The second equivalence is proven likewise.

<sup>&</sup>lt;sup>22</sup>Let  $A \in \mathbb{R}^{4 \times 5}$  read  $A = (e_1, e_2, e_3, e_4, e_1)$  and  $d = e_1 \in \mathbb{R}^4$ . For  $\mathsf{K} = \mathsf{M} - 1 = 3$  one can check that  $\mathsf{U}_{\mathsf{K}+1} = \emptyset$ . <sup>23</sup>Here one uses the basic facts that  $\Pi_{\omega} = \Pi_{\omega}^T = \Pi_{\omega} \Pi_{\omega}, \forall \omega \in \Omega$ .

From (78) it follows that

$$\lambda$$
 is an eigenvalue of  $(\Pi_{\omega} - \Pi_{\varpi}) \Rightarrow |\lambda| \leq 1$ . (80)

It is worthwhile to note also that (78) and (80) entail

 $\lambda \neq 0, \ |\lambda| < 1$  is an eigenvalue of  $(\Pi_{\omega} - \Pi_{\varpi}) \Leftrightarrow v_{(\lambda)} \notin (\ker(\Pi_{\varpi}) \cup \ker(\Pi_{\omega}))$ , (81)

where  $v_{(\lambda)}$  denotes the eigenvector of  $(\Pi_{\omega} - \Pi_{\varpi})$  relevant to  $\lambda$ .

We shall use a claim on the difference of projection matrices. An alike claim was given in [31, Lemma 5] in the case when  $\#\omega = \#\varpi = k$  and any 2k columns of A are linearly independent. In the proof in [31, p. 4676, 2<sup>nd</sup> column], the cases  $|\lambda| = 1$  are omitted. We extend the statement to our more general setting and complete the proof.

**Lemma 9** Let  $(\omega, \varpi) \in \overline{\Omega}_{M-1} \times \overline{\Omega}_{M-1}$ ,  $\emptyset \neq \omega \neq \varpi \neq \emptyset$  and H1 holds for M - 1. Then there exists an integer  $0 \leq r \leq p/2$  such that  $(\Pi_{\omega} - \Pi_{\varpi})$  has 2r eigenvalues satisfying

 $\lambda \neq 0$  is an eigenvalue of  $(\Pi_{\omega} - \Pi_{\varpi}) \Leftrightarrow -\lambda$  is an eigenvalue of  $(\Pi_{\omega} - \Pi_{\varpi})$ , (82)

and p-2r eigenvalues equal either to  $\lambda = 1$  or to  $\lambda = -1$ . Remind that p is given in (77).

(i) If  $\sharp \omega = \sharp \varpi$  then p = 2r and all nonzero eigenvalues of  $(\Pi_{\omega} - \Pi_{\varpi})$  satisfy (82).

**Proof.** The proof consists of three parts.

(1). Let  $\lambda \neq 0$ ,  $|\lambda| < 1$  be an eigenvalue of  $(\Pi_{\omega} - \Pi_{\varpi})$ , i. e.

$$(\Pi_{\omega} - \Pi_{\varpi}) v_{(\lambda)} = \lambda v_{(\lambda)} , \qquad (83)$$

where  $v_{(\lambda)} \notin (\ker(\Pi_{\varpi}) \cup \ker(\Pi_{\omega}))$  according to (81). Consider the vector<sup>24</sup>

$$v_{(-\lambda)} = v_{(\lambda)} - (\Pi_{\omega} + \Pi_{\varpi}) v_{(\lambda)} .$$
(84)

Note<sup>25</sup> that  $v_{(-\lambda)} \neq 0$ . Using that (83) is equivalent to

$$\Pi_{\omega} v_{(\lambda)} = (\Pi_{\varpi} + \lambda I_{\mathsf{M}}) v_{(\lambda)} \quad \Leftrightarrow \quad \Pi_{\varpi} v_{(\lambda)} = (\Pi_{\omega} - \lambda I_{\mathsf{M}}) v_{(\lambda)} ,$$

one derives

$$(\Pi_{\omega} - \Pi_{\overline{\omega}}) v_{(-\lambda)} = (\Pi_{\omega} - \Pi_{\overline{\omega}}) v_{(\lambda)} - (\Pi_{\omega} + \Pi_{\omega}\Pi_{\overline{\omega}} - \Pi_{\overline{\omega}}\Pi_{\omega} - \Pi_{\overline{\omega}}) v_{(\lambda)}$$

$$= -\Pi_{\omega}\Pi_{\overline{\omega}} v_{(\lambda)} + \Pi_{\overline{\omega}}\Pi_{\omega} v_{(\lambda)}$$

$$= -\Pi_{\omega} (\Pi_{\omega} - \lambda I_{\mathsf{M}}) v_{(\lambda)} + \Pi_{\overline{\omega}} (\Pi_{\overline{\omega}} + \lambda I_{\mathsf{M}}) v_{(\lambda)}$$

$$= -(\Pi_{\omega} - \Pi_{\overline{\omega}}) v_{(\lambda)} + \lambda (\Pi_{\omega} + \Pi_{\overline{\omega}}) v_{(\lambda)}$$

$$= -\lambda (v_{(\lambda)} - (\Pi_{\omega} + \Pi_{\overline{\omega}}) v_{(\lambda)})$$

$$= -\lambda v_{(-\lambda)} . \qquad (85)$$

Hence  $-\lambda$  is an eigenvalue of  $(\Pi_{\omega} - \Pi_{\varpi})$ . From (81),  $v_{(-\lambda)} \notin (\ker(\Pi_{\varpi}) \cup \ker(\Pi_{\omega}))$ .

By (81), the eigenvectors (83) and (84) yield all eigenvalues of  $(\Pi_{\omega} - \Pi_{\varpi})$  meeting  $0 < |\lambda| < 1$ . Let  $2r' \ge 0$  denote their cardinality<sup>26</sup>. If 2r' = p, the lemma is proven.

(2). If p > 2r', then by (80), there are p - 2r' eigenvalues living in  $\{-1, +1\}$ . Therefore  $(\Pi_{\omega} - \Pi_{\varpi})$  has 2r, for  $r \ge r' \ge 0$ , eigenvalues<sup>27</sup> satisfying (82) and  $p - 2r \ge 0$  eigenvalues equal either to +1 or to -1.

(3). Consider that p > 2r' and that  $\#\omega = \#\varpi$ . More details are needed to complete claim (i). According to (80) and (81),  $(\Pi_{\omega} - \Pi_{\varpi})$  has p - 2r' eigenvalues with  $|\lambda| = 1$  corresponding

to eigenvectors in  $(\ker(\Pi_{\varpi}) \cup \ker(\Pi_{\omega}))$  meeting the equivalences in (78). From the latter,

$$\lambda = 1 \quad \text{and} \quad (\Pi_{\omega} - \Pi_{\varpi}) v = \lambda v \neq 0 \quad \Leftrightarrow \quad v \in \ker(\Pi_{\varpi}) \cap \operatorname{range}(\Pi_{\omega}) ,$$

$$\lambda = -1 \quad \text{and} \quad (\Pi_{\omega} - \Pi_{\varpi}) v = \lambda v \neq 0 \quad \Leftrightarrow \quad v \in \ker(\Pi_{\omega}) \cap \operatorname{range}(\Pi_{\varpi}) .$$
(86)

where we notice that  $v \in \operatorname{range}(\Pi_{\omega})$  is equivalent to  $\Pi_{\omega}v = v$ , that

$$(\ker (\Pi_{\varpi}) \cap \operatorname{range} (\Pi_{\omega})) \subset \operatorname{range} (\Pi_{\omega} - \Pi_{\varpi})$$

as well as that  $(\ker(\Pi_{\omega}) \cap \operatorname{range}(\Pi_{\varpi})) \subset \operatorname{range}(\Pi_{\omega} - \Pi_{\varpi})$ . Define

$$H_{\varpi} = \ker (\Pi_{\varpi}) \cap \operatorname{range} (\Pi_{\omega}) , \qquad (87)$$

$$H_{\omega} = \ker (\Pi_{\omega}) \cap \operatorname{range} (\Pi_{\varpi}) .$$
(88)

The first claim in [5, Lemma 4.1.] tells us that

$$\ker\left(\Pi_{\varpi}\right) = P_{\varpi} \oplus Q_{\varpi} ,$$

where

$$P_{\varpi} = \ker (\Pi_{\varpi}) \cap \left( \ker (\Pi_{\varpi}) \cap \left( \ker (\Pi_{\omega}) \right)^{\perp} \right)^{\perp}$$
$$Q_{\varpi} = \ker (\Pi_{\varpi}) \cap \left( \ker (\Pi_{\omega}) \right)^{\perp}.$$

Using De Morgan's law and the fact that range  $(\Pi_{\omega}) = (\ker(\Pi_{\omega}))^{\perp}, \forall \omega \in \Omega$ , yield

$$P_{\varpi} = \ker (\Pi_{\varpi}) \cap \left( \operatorname{range} (\Pi_{\varpi}) + \ker (\Pi_{\omega}) \right) = \ker (\Pi_{\varpi}) \cap \ker (\Pi_{\omega}) ,$$
  
$$Q_{\varpi} = \ker (\Pi_{\varpi}) \cap \operatorname{range} (\Pi_{\omega}) = H_{\varpi} .$$

Therefore

$$\ker (\Pi_{\varpi}) = \left(\ker (\Pi_{\varpi}) \cap \ker (\Pi_{\omega})\right) \oplus H_{\varpi} .$$
(89)

 $\overline{e^{26}} \text{We can have } r' = 0. \text{ For instance, let } A_{\omega} = (e_3, e_4) \in \mathbb{R}^{4 \times 2} \text{ and } A_{\varpi} = (e_1, e_2) \in \mathbb{R}^{4 \times 2}. \text{ Then } \Pi_{\omega} = (0, 0, e_3, e_4) \in \mathbb{R}^{4 \times 4} \text{ and } \Pi_{\varpi} = (e_1, e_2, 0, 0) \in \mathbb{R}^{4 \times 4}, \text{ so}$ 

$$\Pi_{\omega} - \Pi_{\varpi} = (-e_1, -e_2, e_3, e_4)$$

The eigenvectors of  $\Pi_{\omega} - \Pi_{\varpi}$  are  $e_i \in \mathbb{R}^4$ ,  $1 \leq i \leq 4$  and the eigenvalues  $\lambda_1 = \lambda_2 = -1$  and  $\lambda_3 = \lambda_4 = 1$ . We have

$$\Pi_{\omega}v_1 = \Pi_{\omega}v_2 = 0 \quad \text{and} \quad \Pi_{\varpi}v_3 = \Pi_{\varpi}v_4 = 0 \ .$$

<sup>27</sup>We can have r = 0. Let  $a_1 \in \mathbb{R}^{\mathsf{M}} \setminus \{0\}$  and  $a_2 \in \mathbb{R}^{\mathsf{M}} \setminus \{0\}$  meet  $a_1 \neq c a_2, \forall c \in \mathbb{R}$ . Let  $A_{\omega} = (a_1, a_2)$  and  $A_{\varpi} = (a_1)$ . Then rank  $(\Pi_{\omega} - \Pi_{\varpi}) = 1$  and  $\ker(\Pi_{\omega}) \subsetneq \ker(\Pi_{\varpi})$ . For a  $v \in \ker(\Pi_{\varpi}) \setminus \ker(\Pi_{\omega})$  the unique eigenvalue of  $(\Pi_{\omega} - \Pi_{\varpi})$  is +1, see (78).

In an symmetric way

$$\ker (\Pi_{\omega}) = P_{\omega} \oplus Q_{\omega} ,$$

$$P_{\omega} = \ker (\Pi_{\omega}) \cap \left( \ker (\Pi_{\omega}) \cap \left( \ker (\Pi_{\varpi}) \right)^{\perp} \right)^{\perp} = \ker (\Pi_{\omega}) \cap \ker (\Pi_{\varpi}) ,$$

$$Q_{\omega} = \ker (\Pi_{\omega}) \cap \left( \ker (\Pi_{\varpi}) \right)^{\perp} = H_{\omega} ,$$

 $\mathbf{SO}$ 

$$\ker (\Pi_{\omega}) = \left(\ker (\Pi_{\omega}) \cap \ker (\Pi_{\varpi})\right) \oplus H_{\omega} .$$
(90)

Since  $\sharp \omega = \sharp \varpi$  and  $\omega \neq \varpi$  are elements of  $\Omega$  it is obvious that

$$\dim \left( \ker \left( \Pi_{\omega} \right) \right) = \dim \left( \ker \left( \Pi_{\varpi} \right) \right) \,. \tag{91}$$

Comparing (89) and (90), combined with (91) and the fact that 2r' < p shows that

$$\dim (H_{\varpi}) = \dim (H_{\varpi}) \stackrel{\text{def}}{=} k \ge 1.$$
(92)

Using (86) we have

$$v \in H_{\varpi} \quad \Leftrightarrow \quad (\Pi_{\omega} - \Pi_{\varpi}) \, v = \lambda v \neq 0 \quad \text{for} \quad \lambda = +1 ,$$

$$\tag{93}$$

$$v \in H_{\omega} \quad \Leftrightarrow \quad (\Pi_{\omega} - \Pi_{\varpi}) v = \lambda v \neq 0 \quad \text{for} \quad \lambda = -1 .$$
 (94)

Combining (93) and (94), along with (92) shows that  $(\Pi_{\omega} - \Pi_{\omega})$  has simultaneously

- k linearly independent eigenvectors in  $H_{\omega}$  corresponding to an eigenvalue equal to +1,
- k linearly independent eigenvectors in  $H_{\varpi}$  corresponding to an eigenvalue equal to -1.

Therefore<sup>28</sup> rank  $(\Pi_{\omega} - \Pi_{\varpi}) = 2(r' + k) = 2r$  and all eigenvalues of  $(\Pi_{\omega} - \Pi_{\varpi})$  meet (82).  $\Box$ 

Using Lemma 9, without loss of generality, assume that

$$\mathbb{I}_r = \{ i \in \mathbb{I}_{\mathsf{M}-1} : \lambda_i > 0 \text{ and } \lambda_{i+r} = -\lambda_i, \ \forall \ i \in \mathbb{I}_r \} .$$

$$(95)$$

Using (76) and (95), the subset  $T_{\kappa}$  in (46) on p. 19 equivalently reads

$$T_{\kappa} = \{g \in \mathbb{R}^{\mathsf{M}} : g = Vx \text{ and } x^{T} \operatorname{diag}(\lambda_{1}, \cdots, \lambda_{\mathsf{M}})x = \kappa\}$$
$$= \{g \in \mathbb{R}^{\mathsf{M}} : g = Vx \text{ and } \sum_{i \in \mathbb{I}_{r}} \lambda_{i} \left(x[i]^{2} - x[i+r]^{2}\right) \pm \sum_{i=2r+1}^{p} x[i]^{2} = \kappa\}, \quad (96)$$

where  $\lambda_i > 0$  for all  $i \in \mathbb{I}_r$ . Consider the subset

$$\Theta_{\kappa} \stackrel{\text{def}}{=} \left\{ x \in \mathbb{R}^{\mathsf{M}} : \sum_{i \in \mathbb{I}_r} \lambda_i \left( x[i]^2 - x[i+r]^2 \right) \pm \sum_{i=2r+1}^p x[i]^2 = \kappa \right\} .$$
(97)

<sup>28</sup>A direct examination of range  $(\Pi_{\omega} - \Pi_{\overline{\omega}})$  shows also that that rank  $(\Pi_{\omega} - \Pi_{\overline{\omega}})$  is an even number.

For any  $\kappa \neq 0$ ,  $\Theta_{\kappa} = \left(x \mapsto \sum_{i \in \mathbb{I}_r} \lambda_i \left(x[i]^2 - x[i+r]^2\right) \pm \sum_{i=2r+1}^p x[i]^2\right)^{-1}(\kappa)$  is a non-degenerate elliptical hyperboloid surface of dimension (p-1). For<sup>29</sup>  $\kappa = 0$ , we have

$$\Theta_0 = \left\{ x \in \mathbb{R}^{\mathsf{M}} : \sum_{i \in \mathbb{I}_r} \lambda_i \left( x[i]^2 - x[i+r]^2 \right) = 0 \right\}$$
$$= \bigcup_{c \in \mathbb{R}} \left\{ x \in \mathbb{R}^{\mathsf{M}} : \sum_{i \in \mathbb{I}_r} \lambda_i x[i]^2 = c \text{ and } \sum_{i \in \mathbb{I}_r} \lambda_i x[i+r]^2 = c \right\}.$$

Clearly,  $\Theta_0$  is a double conical surface (symmetric about zero with elliptic sections) whose dimension is (2r-1). For for any  $\kappa \in \mathbb{R}$ ,  $\Theta_{\kappa}$  is a simple surface of dimension  $\leq M-1$  meeting  $\mathbb{L}^{M}(\Theta_{\kappa}) = 0$ . Since V in (96) is unitary,  $T_{\kappa}$  meets the claim.
