# SPINORIAL REPRESENTATION OF SUBMANIFOLDS IN METRIC LIE GROUPS

#### Abstract

In this paper we give a spinorial representation of submanifolds of any dimension and codimension into Lie groups equipped with left invariant metrics.


Keywords: Spin geometry, metric Lie groups, isometric immersions, Weierstrass representation.

## 1. Introduction

## 2. Preliminaries

2.1. Notation. Let $G$ be a Lie group, endowed with a left invariant metric $\langle.,$.$\rangle ,$ and $\mathcal{G}$ its Lie algebra: $\mathcal{G}$ is the space of the left invariant vector fields on $G$, equipped with the Lie bracket [., .] and is identified to the linear space tangent to $G$ at the identity. The left multiplication induces a bundle isomorphism

$$
\begin{equation*}
T G \simeq G \times \mathcal{G} \tag{1}
\end{equation*}
$$

which preserves the fibre metrics. We note that a vector field $X \in \Gamma(T G)$ is left invariant if, by (1), $X: G \rightarrow \mathcal{G}$ is a constant map. We consider $\nabla^{G}$ the Levi-Civita connection of $(G,\langle.,\rangle$.$) and the linear map$

such that, for all $X, Y \in \mathcal{G}$

\nabla_{X}^{G} Y=\Gamma(X)(Y) \tag{2}
\end{equation*}
$$

By the Koszul formula, $\Gamma$ is determined by the metric as follows: for all $X, Y, Z \in \mathcal{G}$,

$$
\begin{equation*}
\langle\Gamma(X)(Y), Z\rangle=\frac{1}{2}\langle[X, Y], Z\rangle+\frac{1}{2}\langle[Z, X], Y\rangle-\frac{1}{2}\langle[Y, Z], X\rangle \tag{3}
\end{equation*}
$$

Since $\nabla^{G}$ is without torsion, we have, for all $X, Y \in \mathcal{G}$,

$$
\begin{equation*}
\Gamma(X)(Y)-\Gamma(Y)(X)=[X, Y] \tag{4}
\end{equation*}
$$

We note that the curvature of $\nabla^{G}$ is given by

$$
\begin{equation*}
R^{G}(X, Y)=[\Gamma(X), \Gamma(Y)]-\Gamma([X, Y]) \quad \in \Lambda^{2} \mathcal{G} \tag{5}
\end{equation*}
$$

for all $X, Y \in \mathcal{G}$. In the formula the first brackets stand for the commutator of the endomorphisms.
2.2. The spinor bundle of $G$. Let us denote by $C l(\mathcal{G})$ the Clifford algebra of $\mathcal{G}$ with its scalar product, and let us consider the representation

$$
\begin{aligned}
\rho: \quad \operatorname{Spin}(\mathcal{G}) & \rightarrow G L(C l(\mathcal{G})) \\
a & \mapsto \xi \mapsto a \xi
\end{aligned}
$$

This representation is not irreducible in general: it is a sum of irreducible representations [11]. By (1) the principal bundle $Q_{G}$ of the positively oriented and orthonormal frames of $G$ is also trivial

$$
Q_{G} \simeq G \times S O(\mathcal{G})
$$

and we may consider the trivial spin structure

$$
\tilde{Q}_{G}:=G \times \operatorname{Spin}(\mathcal{G})
$$

and the corresponding spinor bundle

$$
\Sigma:=\tilde{Q}_{G} \times_{\rho} C l(G) \simeq G \times C l(\mathcal{G})
$$

A spinor field $\varphi \in \Gamma(\Sigma)$ is said to be left invariant if it is constant as a map $G \rightarrow C l(\mathcal{G})$. The covariant derivative of a left invariant spinor field is

$$
\begin{equation*}
\nabla_{X}^{G} \varphi=\frac{1}{2} \Gamma(X) \cdot \varphi \tag{6}
\end{equation*}
$$

where $\Gamma(X) \in \Lambda^{2} \mathcal{G} \subset C l(\mathcal{G})$ and the dot "." stands for the Clifford product.
2.3. The spin representation of $\operatorname{Spin}(p) \times \operatorname{Spin}(q)$. Let us assume that $p+q=n$, and fix an orthonormal basis $e_{1}^{o}, e_{2}^{o}, \ldots, e_{n}^{o}$ of $\mathcal{G}$; this gives a splitting $\mathcal{G}=\mathbb{R}^{p} \oplus \mathbb{R}^{q}$ (the first factor corresponds to the first $p$ vectors, and the second factor to the last $q$ vectors of the basis) and a natural map

$$
\operatorname{Spin}(p) \times \operatorname{Spin}(q) \rightarrow \operatorname{Spin}(\mathcal{G})
$$

associated to the isomorphism

$$
C l(\mathcal{G})=C l_{p} \hat{\otimes} C l_{q} .
$$

We thus also have a representation, still denoted by $\rho$,
rep $\operatorname{spin} p$ spin $q$

\rho: \quad \operatorname{Spin}(p) \times \operatorname{Spin}(q) & \rightarrow G L(C l(\mathcal{G}))  \tag{7}\\
a & \mapsto \xi \mapsto a \xi .
\end{align*}
$$

2.4. The twisted spinor bundle. We consider $M$ a $p$-dimensional Riemannian manifold, $E \rightarrow M$ a bundle of $\operatorname{rank} q$, with a fibre metric and a compatible connection. We assume that $E$ and $T M$ are oriented and spin, with given spin structures

$$
\tilde{Q}_{M} \xrightarrow{2: 1} Q_{M} \quad \text { and } \quad \tilde{Q}_{E} \xrightarrow{2: 1} Q_{E}
$$

where $Q_{M}$ and $Q_{E}$ are the bundles of positively oriented orthonormal frames of $T M$ and $E$, and we set

$$
\tilde{Q}:=\tilde{Q}_{M} \times_{M} \tilde{Q}_{E}
$$

this is a $\operatorname{Spin}(p) \times \operatorname{Spin}(q)$ principal bundle. We define

$$
\Sigma:=\tilde{Q} \times{ }_{\rho} C l(\mathcal{G})
$$

and

$$
U \Sigma:=\tilde{Q} \times{ }_{\rho} \operatorname{Spin}(\mathcal{G}) \quad \subset \Sigma
$$

where $\rho$ is the representation (7). The vector bundle $\Sigma$ is equipped with the covariant derivative $\nabla$ naturally associated to the spinorial connections on $\tilde{Q}_{M}$ and $\tilde{Q}_{E}$. Let us denote by $\tau: C l(\mathcal{G}) \rightarrow C l(\mathcal{G})$ the anti-automorphism of $C l(\mathcal{G})$ such that

$$
\tau\left(x_{1} \cdot x_{2} \cdots x_{k}\right)=x_{k} \cdots x_{2} \cdot x_{1}
$$

for all $x_{1}, x_{2}, \ldots, x_{k} \in \mathcal{G}$, and set

$$
\begin{align*}
\langle\langle., .\rangle\rangle: \quad C l(\mathcal{G}) \times C l(\mathcal{G}) & \rightarrow C l(\mathcal{G})  \tag{8}\\
\left(\xi, \xi^{\prime}\right) & \mapsto \tau\left(\xi^{\prime}\right) \xi
\end{align*}
$$

This map is $\operatorname{Spin}(\mathcal{G})$-invariant: for all $\xi, \xi^{\prime} \in C l(\mathcal{G})$ and $g \in \operatorname{Spin}(\mathcal{G})$ we have

$$
\left\langle\left\langle g \xi, g \xi^{\prime}\right\rangle\right\rangle=\tau\left(g \xi^{\prime}\right) g \xi=\tau\left(\xi^{\prime}\right) \tau(g) g \xi=\tau\left(\xi^{\prime}\right) \xi=\left\langle\left\langle\xi, \xi^{\prime}\right\rangle\right\rangle
$$

since $\operatorname{Spin}(\mathcal{G}) \subset\left\{g \in C l^{0}(\mathcal{G}): \tau(g) g=1\right\}$; this map thus induces a $C l(\mathcal{G})$-valued map

$$
\begin{array}{llll}
\langle\langle., .\rangle\rangle: & \Sigma \times \Sigma & \rightarrow C l(\mathcal{G})  \tag{9}\\
& \left(\varphi, \varphi^{\prime}\right) & \mapsto & \left\langle\left\langle[\varphi],\left[\varphi^{\prime}\right]\right\rangle\right\rangle
\end{array}
$$

where $[\varphi]$ and $\left[\varphi^{\prime}\right] \in C l(\mathcal{G})$ represent $\varphi$ and $\varphi^{\prime}$ in some spinorial frame $\tilde{s} \in \tilde{Q}$.
Lemma 2.1. The map $\langle\langle.,\rangle\rangle:. \Sigma \times \Sigma \rightarrow C l(\mathcal{G})$ satisfies the following properties: for all $\varphi, \psi \in \Gamma(\Sigma)$ and $X \in \Gamma(T M)$,
scalar product property1

$$
\begin{equation*}
\langle\langle\varphi, \psi\rangle\rangle=\tau\langle\langle\psi, \varphi\rangle\rangle \tag{10}
\end{equation*}
$$

and

$$
\begin{equation*}
\langle\langle X \cdot \varphi, \psi\rangle\rangle=\langle\langle\varphi, X \cdot \psi\rangle\rangle . \tag{11}
\end{equation*}
$$

Proof. We have

$$
\langle\langle\varphi, \psi\rangle\rangle=\tau[\psi][\varphi]=\tau(\tau[\varphi][\psi])=\tau\langle\langle\psi, \varphi\rangle\rangle
$$

and

$$
\langle\langle X \cdot \varphi, \psi\rangle\rangle=\tau[\psi][X][\varphi]=\tau([X][\psi])[\varphi]=\langle\langle\varphi, X \cdot \psi\rangle\rangle
$$

where $[\varphi],[\psi]$ and $[X] \in C l(\mathcal{G})$ represent $\varphi, \psi$ and $X$ in some given frame $\tilde{s} \in \tilde{Q}$.
Lemma 2.2. The connection $\nabla$ is compatible with the product $\langle\langle.,\rangle$.$\rangle :$

$$
\partial_{X}\left\langle\left\langle\varphi, \varphi^{\prime}\right\rangle\right\rangle=\left\langle\left\langle\nabla_{X} \varphi, \varphi^{\prime}\right\rangle\right\rangle+\left\langle\left\langle\varphi, \nabla_{X} \varphi^{\prime}\right\rangle\right\rangle
$$

for all $\varphi, \varphi^{\prime} \in \Gamma(\Sigma)$ and $X \in \Gamma(T M)$.
Proof. If $\varphi=[\tilde{s},[\varphi]]$ is a section of $\Sigma=\tilde{Q} \times{ }_{\rho} C l(\mathcal{G})$, we have

$$
\nabla_{X} \varphi=\left[\tilde{s}, \partial_{X}[\varphi]+\rho_{*}\left(\tilde{s}^{*} \alpha(X)\right)([\varphi])\right], \quad \forall X \in T M
$$

where $\rho$ is the representation (7) and $\alpha$ is the connection form on $\tilde{Q}$; the term $\rho_{*}\left(\tilde{s}^{*} \alpha(X)\right)$ is an endomorphism of $C l(\mathcal{G})$ given by the multiplication on the left by an element belonging to $\Lambda^{2} \mathcal{G} \subset C l(\mathcal{G})$, still denoted by $\rho_{*}\left(\tilde{s}^{*} \alpha(X)\right)$. Such an element satisfies

$$
\tau\left(\rho_{*}\left(\tilde{s}^{*} \alpha(X)\right)\right)=-\rho_{*}\left(\tilde{s}^{*} \alpha(X)\right)
$$

and we have

$$
\begin{aligned}
\left\langle\left\langle\nabla_{X} \varphi, \varphi^{\prime}\right\rangle\right\rangle+\left\langle\left\langle\varphi, \nabla_{X} \varphi^{\prime}\right\rangle\right\rangle= & \tau\left\{\left[\varphi^{\prime}\right]\right\}\left(\partial_{X}[\varphi]+\rho_{*}\left(\tilde{s}^{*} \alpha(X)\right)[\varphi]\right) \\
& +\tau\left\{\partial_{X}\left[\varphi^{\prime}\right]+\rho_{*}\left(\tilde{s}^{*} \alpha(X)\right)\left[\varphi^{\prime}\right]\right\}[\varphi] \\
= & \tau\left\{\left[\varphi^{\prime}\right]\right\} \partial_{X}[\varphi]+\tau\left\{\partial_{X}\left[\varphi^{\prime}\right]\right\}[\varphi] \\
= & \partial_{X}\left\langle\left\langle\varphi, \varphi^{\prime}\right\rangle\right\rangle .
\end{aligned}
$$

We finally note that there is a natural action of $\operatorname{Spin}(\mathcal{G})$ on $U \Sigma$, by right multiplication: for $\varphi=[\tilde{s},[\varphi]] \in U \Sigma=\tilde{Q} \times{ }_{\rho} \operatorname{Spin}(\mathcal{G})$ and $a \in \operatorname{Spin}(\mathcal{G})$ we set

$$
\begin{equation*}
\varphi \cdot a:=[\tilde{s},[\varphi] \cdot a] \in U \Sigma \tag{12}
\end{equation*}
$$

2.5. The spin geometry of a submanifold of $G$. We keep the notation of the previous section, assuming moreover here that $M$ is a submanifold of a Lie group $G$ and that $E \rightarrow M$ is its normal bundle. If we consider spin structures on $T M$ and on $E$ whose sum is the trivial spin structure of $T M \oplus E$ [13], we have

$$
\Sigma=\tilde{Q} \times{ }_{\rho} C l(\mathcal{G}) \simeq M \times C l(\mathcal{G})
$$

where the last bundle is the spinor bundle of $G$ restricted to $M$. Two connections are thus defined on $\Sigma$, the connection $\nabla$ and the connection $\nabla^{G}$; they satisfy the following Gauss formula:

$$
\begin{equation*}
\nabla_{X}^{G} \varphi=\nabla_{X} \varphi+\frac{1}{2} \sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right) \cdot \varphi \tag{13}
\end{equation*}
$$

for all $\varphi \in \Gamma(\Sigma)$ and all $X \in \Gamma(T M)$, where $B: T M \times T M \rightarrow E$ is the second fundamental form of $M$ into $G$. We refer to [1] for the proof (in a slightly different context). Since the covariant derivative of a left invariant spinor field is given by (6), the restriction to $M$ of such a spinor field satisfies

\nabla_{X} \varphi=-\frac{1}{2} \sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right) \cdot \varphi+\frac{1}{2} \Gamma(X) \cdot \varphi \tag{14}
\end{equation*}
$$

for all $X \in T M$.

## 3. Main result

We consider $M$ a $p$-dimensional Riemannian manifold, $E \rightarrow M$ a bundle of rank $q$, with a fibre metric and a compatible connection. We assume that $E$ and $T M$ are oriented and spin, with given spin structures. We suppose that a bilinear and symmetric map $B: T M \times T M \rightarrow E$ is given, and we moreover do the following two assumptions:
(1) There exists a bundle isomorphism

$$
\begin{equation*}
f: T M \oplus E \rightarrow M \times \mathcal{G} \tag{15}
\end{equation*}
$$

which preserves the metrics; this mapping permits to define a bundle map
def Gamma TM+E

$$
\begin{equation*}
\Gamma: T M \oplus E \rightarrow \Lambda^{2}(T M \oplus E) \tag{16}
\end{equation*}
$$

such that, for all $X, Y \in \Gamma(T M \oplus E)$,

$$
f(\Gamma(X)(Y))=\Gamma(f(X))(f(Y))
$$

(on the right hand side $\Gamma$ is the map defined on $\mathcal{G}$ by (2)), together with the following notion: a section $Z \in \Gamma(T M \oplus E)$ will be said to be left invariant if $f(Z): M \rightarrow \mathcal{G}$ is a constant map.

(2) The covariant derivative of a left invariant section $Z \in \Gamma(T M \oplus E)$ is given by

$$
\begin{equation*}
\nabla_{X} Z=\Gamma(X)(Z)-B\left(X, Z^{T}\right)+B^{*}\left(X, Z^{N}\right) \tag{18}
\end{equation*}
$$

where $Z=Z^{T}+Z^{N}$ in $T M \oplus E$ and $B^{*}: T M \times E \rightarrow T M$ is the bilinear map such that for all $X, Y \in \Gamma(T M)$ and $N \in \Gamma(E)$

$$
\langle B(X, Y), N\rangle=\left\langle Y, B^{*}(X, N)\right\rangle
$$

Remark 1. These two assumptions are equivalent to the assumptions made in $[10,15]$ : they are necessary to write down the equations of Gauss, Codazzi and Ricci in a general metric Lie group, and to obtain a fundamental theorem for immersions in that context; see Section 4.

Remark 2. Sometimes it is convenient to write these assumptions in some local frames. For sake of simplicity, we assume that $E$ is a trivial line bundle, oriented by a unit section $\nu$. Let $\left(e_{1}^{o}, e_{2}^{o}, \ldots, e_{n}^{o}\right)$ be an orthonormal basis of $\mathcal{G}$ and $\Gamma_{i j}^{k} \in \mathbb{R}$, $1 \leq i, j, k \leq n$, be such that

$$
\Gamma\left(e_{i}^{o}\right)\left(e_{j}^{o}\right)=\sum_{k=1}^{n} \Gamma_{i j}^{k} e_{k}^{o}
$$

We set, for $i=1, \ldots, n, \underline{e}_{i} \in \Gamma(T M \oplus E)$ such that $f\left(\underline{e}_{i}\right)=e_{i}^{o}$, and $f_{i} \in C^{\infty}(M)$, $T_{i} \in \Gamma(T M)$ such that $\underline{e}_{i}=T_{i}+f_{i} \nu$. Since $f$ preserves the metrics, the vectors $\underline{e}_{1}, \underline{e}_{2}, \ldots, \underline{e}_{n}$ are orthonormal, and we have

$$
\begin{equation*}
\left\langle T_{i}, T_{j}\right\rangle+f_{i} f_{j}=\delta_{i j} \tag{19}
\end{equation*}
$$

for all $i, j=1, \ldots, n$. The assumption (18) then reads as follows: for all $X \in T M$, $j=1, \ldots, n$,

$$
\begin{equation*}

\begin{align*}
\nabla_{X} T_{j} & =\sum_{i, k} \Gamma_{i j}^{k}\left\langle X, T_{i}\right\rangle T_{k}+f_{j} S(X) \\
d f_{j}(X) & =\sum_{i, k} \Gamma_{i j}^{k} f_{k}\left\langle X, T_{i}\right\rangle-h\left(X, T_{j}\right) \tag{21}
\end{align*}

where $S(X)=B^{*}(X, \nu)$ and $h(X, Y)=\langle B(X, Y), \nu\rangle$. Conversely, if vector fields $T_{i} \in \Gamma(T M)$ and functions $f_{i} \in C^{\infty}(M), 1 \leq i \leq n$, are given such that (19), (20) and (21) hold, we may define a bundle isomorphism $f: T M \oplus E \rightarrow M \times \mathcal{G}$ preserving the metrics and such that (18) holds: setting $\underline{e}_{i}=T_{i}+f_{i} \nu$, we define $f$ such that $f\left(\underline{e}_{i}\right)=e_{i}^{o}, i=1, \ldots, n$.

We keep the notation of Section 2 and state the main result of the paper:

## thm main result

Theorem 1. We moreover assume that $M$ is simply connected. The following statements are equivalent:
(1) There exists a section $\varphi \in \Gamma(U \Sigma)$ such that

\nabla_{X} \varphi=-\frac{1}{2} \sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right) \cdot \varphi+\frac{1}{2} \Gamma(X) \cdot \varphi \tag{22}
\end{equation*}
$$

for all $X \in T M$.
(2) There exists an isometric immersion $F: M \rightarrow G$ with normal bundle $E$ and second fundamental form $B$.

More precisely, if $\varphi$ is a solution of (22), replacing $\varphi$ by $\varphi \cdot$ a for some $a \in \operatorname{Spin}(\mathcal{G})$ if necessary, the formula $F=\int \xi$ where $\xi$ is the $\mathcal{G}$-valued 1-form defined by

$$
\begin{equation*}
\xi(X):=\langle\langle X \cdot \varphi, \varphi\rangle\rangle \tag{23}
\end{equation*}
$$

for all $X \in T M$, defines an isometric immersion with normal bundle $E$ and second fundamental form B. Here $\int$ stands for the Darboux integral, i.e. $F=\int \xi: M \rightarrow G$ is such that $F^{*} \omega_{G}=\xi$, where $\omega_{G} \in \Omega^{1}(G, \mathcal{G})$ is the Maurer-Cartan form of $G$. Reciprocally, an isometric immersion $M \rightarrow G$ with normal bundle $E$ and second fundamental form $B$ may be written in that form.

The formula $F=\int \xi$ where $\xi$ is defined by (23) may be regarded as a generalized Weierstrass representation formula.

This theorem generalizes the main result of [4] to a Lie group equipped with a left invariant metric.

Remark 3. If $\varphi$ is a solution of (22) and a belongs to $\operatorname{Spin}(\mathcal{G}), \varphi^{\prime}:=\varphi \cdot a$ is also a solution of (22) (see (12) for the definition of $\varphi \cdot a$ ). Moreover the associated 1 -forms $\xi_{\varphi}$ and $\xi_{\varphi^{\prime}}$ are linked by

$$
\begin{equation*}
\xi_{\varphi^{\prime}}=\tau(a) \xi_{\varphi} a=A d\left(a^{-1}\right) \circ \xi_{\varphi} \tag{24}
\end{equation*}
$$

Let us recall that a 1-form $\xi \in \Omega^{1}(M, \mathcal{G})$ is Darboux integrable if and only if it satisfies the structure equation $d \xi+[\xi, \xi]=0$ ( $M$ is simply connected). The theorem thus says that if $\varphi$ is a solution of (22), it is possible to find an other solution $\varphi^{\prime}$ of this equation such that $\xi_{\varphi^{\prime}}$ is Darboux integrable and $F=\int \xi_{\varphi^{\prime}}$ is an immersion with normal bundle $E$ and second fundamental form $B$. The proof of $(1) \Rightarrow(2)$ in the theorem will in fact follow these lines. See also Remark 5 below.

Remark 4. We note that (22) implies the Dirac equation

$$
D \varphi=(\vec{H}+\gamma) \cdot \varphi
$$

where the Dirac operator $D$ is defined by

$$
D \varphi=\sum_{j=1}^{p} e_{j} \cdot \nabla_{e_{j}} \varphi
$$

and

$$
\vec{H}=\frac{1}{2} \sum_{j=1}^{p} B\left(e_{j}, e_{j}\right) \in E \quad \text { and } \quad \gamma=\frac{1}{2} \sum_{j=i}^{p} e_{j} \cdot \Gamma\left(e_{j}\right) \in C l(T M \oplus E) .
$$

We now prove the theorem: $(1) \Rightarrow(2)$ will be a consequence of Propositions 3.1 and 3.3 below, and $(2) \Rightarrow(1)$ will be proved at the end of the section.
lem xi closed Proposition 3.1. Assume that $\varphi \in \Gamma(U \Sigma)$ is a solution of (22) and define $\xi$ by (23). Then
(1) $\xi$ takes its values in $\mathcal{G} \subset C l(\mathcal{G})$;
(2) there exists $T \in S O(\mathcal{G})$ such that $\xi=T \circ f$;
(3) replacing $\varphi$ by $\varphi \cdot a$ where $a \in \operatorname{Spin}(\mathcal{G})$ is such that $\operatorname{Ad}(a)=T$, we have $\xi=f$, and $\xi$ satisfies the structure equation

$$
\begin{equation*}
d \xi+[\xi, \xi]=0 \tag{25}
\end{equation*}
$$

Proof. 1- By the very definition of $\xi$, we have

$$
\xi(X)=\tau[\varphi][X][\varphi]
$$

for all $X \in T M$, where $[X]$ and $[\varphi]$ represent $X$ and $\varphi$ in a given frame $\tilde{s}$ of $\tilde{Q}$. Since $[X]$ belongs to $\mathcal{G} \subset C l(\mathcal{G})$ and $[\varphi]$ is an element of $\operatorname{Spin}(\mathcal{G}), \xi(X)$ belongs to $\mathcal{G}$.
2- This amounts to show that for every left invariant section $Z \in \Gamma(T M \oplus E)$, the $\operatorname{map} \xi(Z): M \rightarrow \mathcal{G}$ is constant. Indeed, assuming that this property holds, if $\left(e_{1}^{o}, \ldots, e_{n}^{o}\right)$ is a fixed orthonormal basis of $\mathcal{G}$ and denoting by $\underline{e}_{1}, \ldots, \underline{e}_{n}$ the left invariant sections of $T M \oplus E$ such that $f\left(\underline{e}_{i}\right)=e_{i}^{o}, i=1, \ldots, n$, we have, for all section $Z=\sum_{i} Z_{i} \underline{e}_{i} \in \Gamma(T M \oplus E)$,

$$
\xi(Z)=\sum_{i=1}^{n} Z_{i} \xi\left(\underline{e}_{i}\right)
$$

where $\left(\xi\left(\underline{e}_{1}\right), \ldots, \xi\left(\underline{e}_{n}\right)\right)$ is a constant orthonormal basis of $\mathcal{G}$. Considering the orthogonal transformation $T: \mathcal{G} \rightarrow \mathcal{G}$ such that $T\left(e_{i}^{o}\right)=\xi\left(\underline{e}_{i}\right), i=1, \ldots, n$, we get

$$
\xi(Z)=\sum_{i=1}^{n} Z_{i} T\left(e_{i}^{o}\right)=T\left(\sum_{i=1}^{n} Z_{i} e_{i}^{o}\right)=T(f(Z))
$$

i.e. $\xi=T \circ f$. We thus assume that $Z \in \Gamma(T M \oplus E)$ is left invariant, and compute, for $X \in T M$,

$$
\begin{aligned}
\partial_{X} \xi(Z)= & \left\langle\left\langle\nabla_{X} Z \cdot \varphi, \varphi\right\rangle\right\rangle+(i d+\tau)\left\langle\left\langle Z \cdot \varphi, \nabla_{X} \varphi\right\rangle\right\rangle \\
= & \left\langle\left\langle\left\{\Gamma(X)(Z)-B\left(X, Z^{T}\right)+B^{*}\left(X, Z^{N}\right)\right\} \cdot \varphi, \varphi\right\rangle\right\rangle \\
& +\frac{1}{2}(i d+\tau)\left\langle\left\langle Z \cdot \varphi,\left(-\sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right)+\Gamma(X)\right) \cdot \varphi\right\rangle\right\rangle .
\end{aligned}
$$

This expression is zero, as a consequence of the following formulas:
lemma proof xi=f
proof xi=f id 1
proof xi=f id 2

Lemma 3.2. For all $X \in T M$ and $Z \in T M \oplus E$,

$$
\begin{equation*}
\langle\langle\Gamma(X)(Z) \cdot \varphi, \varphi\rangle\rangle=-\frac{1}{2}(i d+\tau)\langle\langle Z \cdot \varphi, \Gamma(X) \cdot \varphi\rangle\rangle \tag{26}
\end{equation*}
$$

and

$$
\begin{equation*}
\left\langle\left\langle\left\{B\left(X, Z^{T}\right)-B^{*}\left(X, Z^{N}\right)\right\} \cdot \varphi, \varphi\right\rangle\right\rangle=-\frac{1}{2}(i d+\tau)\left\langle\left\langle Z \cdot \varphi, \sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right) \cdot \varphi\right\rangle\right\rangle . \tag{27}
\end{equation*}
$$

Proof. We first prove (26): we have

$$
\begin{aligned}
\frac{1}{2}(i d+\tau)\langle\langle Z \cdot \varphi, \Gamma(X) \cdot \varphi\rangle\rangle & =-\langle\langle\varphi,[\Gamma(X), Z] \cdot \varphi\rangle\rangle \\
& =-\langle\langle\Gamma(X)(Z) \cdot \varphi, \varphi\rangle\rangle
\end{aligned}
$$

since $\tau_{\mid \mathcal{G}}=i d, \tau_{\mid \Lambda^{2} \mathcal{G}}=-i d$ and by Lemma A.1. The proof of (27) is similar:

$$
\begin{aligned}
\frac{1}{2}(i d+\tau)\left\langle\left\langle Z \cdot \varphi, \sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right) \cdot \varphi\right\rangle\right\rangle & =-\left\langle\left\langle\varphi,\left[\sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right), Z\right] \cdot \varphi\right\rangle\right\rangle \\
& =-\left\langle\left\langle\left\{B\left(X, Z^{T}\right)-B^{*}\left(X, Z^{N}\right)\right\} \cdot \varphi, \varphi\right\rangle\right\rangle
\end{aligned}
$$

by Lemma A.3.

3- For all $a \in \operatorname{Spin}(\mathcal{G})$ and $X \in T M$, we have

$$
\begin{aligned}
\langle\langle X \cdot(\varphi \cdot a), \varphi \cdot a\rangle\rangle & =\tau([\varphi] a)[X][\varphi] a \\
& =\tau(a)\langle\langle X \cdot \varphi, \varphi\rangle\rangle a \\
& =\operatorname{Ad}\left(a^{-1}\right)(\xi(X)) \\
& =\operatorname{Ad}\left(a^{-1}\right)(T \circ f(X))
\end{aligned}
$$

thus, replacing $\varphi$ by $\varphi \cdot a$ where $a \in \operatorname{Spin}(\mathcal{G})$ is such that $A d(a)=T$ we get $\xi=f$. We compute, for $X, Y \in \Gamma(T M)$ such that $\nabla X=\nabla Y=0$ at $x_{0}$,

\begin{aligned}
\partial_{X} \xi(Y) & =\left\langle\left\langle Y \cdot \nabla_{X} \varphi, \varphi\right\rangle\right\rangle+\left\langle\left\langle Y \cdot \varphi, \nabla_{X} \varphi\right\rangle\right\rangle \\
& =(i d+\tau)\left\langle\left\langle Y \cdot \varphi, \nabla_{X} \varphi\right\rangle\right\rangle \\
& =(i d+\tau)\left\langle\left\langle\varphi,-\frac{1}{2} \sum_{j=1}^{p} Y \cdot e_{j} \cdot B\left(X, e_{j}\right) \cdot \varphi+\frac{1}{2} Y \cdot \Gamma(X) \cdot \varphi\right\rangle\right\rangle
\end{aligned}
$$

and

$$
d \xi(X, Y)=\partial_{X} \xi(Y)-\partial_{Y} \xi(X)
$$

$$
\begin{equation*}
=(i d+\tau)\langle\langle\varphi, \mathcal{C} \cdot \varphi\rangle\rangle+\frac{1}{2}(i d+\tau)\langle\langle\varphi,\{Y \cdot \Gamma(X)-X \cdot \Gamma(Y)\} \cdot \varphi\rangle\rangle \tag{28}
\end{equation*}
$$

with

$$
\mathcal{C}:=-\frac{1}{2} \sum_{j=1}^{p}\left\{Y \cdot e_{j} \cdot B\left(X, e_{j}\right)-X \cdot e_{j} \cdot B\left(Y, e_{j}\right)\right\}
$$

Now, for $X=\sum_{1 \leq k \leq p} x_{k} e_{k}$ and $Y=\sum_{1 \leq k \leq p} y_{k} e_{k}$,

$$
\sum_{j=1}^{p} X \cdot e_{j} \cdot B\left(Y, e_{j}\right)=-B(Y, X)+\sum_{j=1}^{p} \sum_{k \neq j} x_{k} e_{k} \cdot e_{j} \cdot B\left(Y, e_{j}\right)
$$

and

$$
\sum_{j=1}^{p} Y \cdot e_{j} \cdot B\left(X, e_{j}\right)=-B(X, Y)+\sum_{j=1}^{p} \sum_{k \neq j} y_{k} e_{k} \cdot e_{j} \cdot B\left(X, e_{j}\right)
$$

which yields the formula

$$
\mathcal{C}=-\frac{1}{2} \sum_{j=1}^{p} \sum_{k \neq j} e_{k} \cdot e_{j} \cdot\left(y_{k} B\left(X, e_{j}\right)-x_{k} B\left(Y, e_{j}\right)\right)
$$

Since a Clifford product of three pairwise orthogonal vectors is changed to its opposite by $\tau$, we deduce that $\tau[\mathcal{C}]=-[\mathcal{C}]$; this implies

$$
\tau\langle\langle\varphi, \mathcal{C} \cdot \varphi\rangle\rangle=\tau(\tau[\varphi] \tau[\mathcal{C}][\varphi])=-\tau[\varphi] \tau[\mathcal{C}][\varphi]=-\langle\langle\varphi, \mathcal{C} \cdot \varphi\rangle\rangle
$$

Thus the first term in (28) is zero and

$$
\begin{aligned}
d \xi(X, Y) & =\frac{1}{2}(i d+\tau)\langle\langle\varphi,\{Y \cdot \Gamma(X)-X \cdot \Gamma(Y)\} \cdot \varphi\rangle\rangle \\
& =\frac{1}{2}\langle\langle\varphi,\{Y \cdot \Gamma(X)-\Gamma(X) \cdot Y+X \cdot \Gamma(Y)-\Gamma(Y) \cdot X\} \cdot \varphi\rangle\rangle
\end{aligned}
$$

since $\tau_{\mid \mathcal{G}}=i d$ and $\tau_{\mid \Lambda^{2} \mathcal{G}}=-i d$. We finally notice that

$$
\frac{1}{2}\{Y \cdot \Gamma(X)-\Gamma(X) \cdot Y+X \cdot \Gamma(Y)-\Gamma(Y) \cdot X\}=-\Gamma(X)(Y)+\Gamma(Y)(X)
$$

(Lemma A.1), which yields

$$
\begin{aligned}
d \xi(X, Y) & =-\xi(\Gamma(X)(Y)-\Gamma(Y)(X)) \\
& =-[\xi(X), \xi(Y)]
\end{aligned}
$$

since $\xi=f, \Gamma$ satisfies (17), and by (4).
We keep the notation of Proposition 3.1, and moreover assume that $M$ is simply connected; we consider

$$
F: M \rightarrow G
$$

such that $F^{*} \omega_{G}=\xi$ (assuming that $\varphi$ is chosen in such a way that $\xi$ satisfies the structure equation (25)). The next proposition follows from the properties of the Clifford product:
lem F isometry Proposition 3.3. 1. The map $F: M \rightarrow G$ is an isometry.
2. The map

$$
\left.\begin{array}{rl}
\Phi_{E}: & \rightarrow M \times \mathcal{G} \\
X \in E_{m} & \mapsto
\end{array}\right)(F(m), \xi(X)) .
$$

is an isometry between $E$ and the normal bundle of $F(M)$ into $G$, preserving connections and second fundamental forms. Here, for $X \in E, \xi(X)$ still stands for the quantity $\langle\langle X \cdot \varphi, \varphi\rangle\rangle$.

Proof. For $X, Y \in \Gamma(T M \oplus E)$, we have

$$
\begin{aligned}
\langle\xi(X), \xi(Y)\rangle & =-\frac{1}{2}(\xi(X) \xi(Y)+\xi(Y) \xi(X)) \\
& =-\frac{1}{2}(\tau[\varphi][X][\varphi] \tau[\varphi][Y][\varphi]+\tau[\varphi][Y][\varphi] \tau[\varphi][X][\varphi]) \\
& =-\frac{1}{2} \tau[\varphi]([X][Y]+[Y][X])[\varphi] \\
& =\langle X, Y\rangle
\end{aligned}
$$

since $[X][Y]+[Y][X]=-2\langle[X],[Y]\rangle=-2\langle X, Y\rangle$. This implies that $F$ is an isometry, and that $\Phi_{E}$ is a bundle map between $E$ and the normal bundle of $F(M)$ into $G$ which preserves the metrics of the fibres. Let us denote by $B_{F}$ and $\nabla^{\prime F}$ the second fundamental form and the normal connection of the immersion $F$; the aim is now to prove that

$$
\begin{equation*}
\xi(B(X, Y))=B_{F}(\xi(X), \xi(Y)) \quad \text { and } \quad \xi\left(\nabla_{X}^{\prime} N\right)=\nabla_{\xi(X)}^{\prime F} \xi(N) \tag{29}
\end{equation*}
$$

for $X, Y \in \Gamma(T M)$ and $N \in \Gamma(E)$. First,

$$
B_{F}(\xi(X), \xi(Y))=\left(\nabla_{\xi(X)}^{G} \xi(Y)\right)^{N}=\left\{\partial_{X} \xi(Y)+\Gamma(\xi(X))(\xi(Y))\right\}^{N}
$$

where the superscript $N$ means that we consider the component of the vector which is normal to the immersion. We fix a point $x_{0} \in M$, assume that $\nabla Y=0$ at $x_{0}$, and compute:

$$
\begin{aligned}
\partial_{X} \xi(Y) & =\left\langle\left\langle Y \cdot \nabla_{X} \varphi, \varphi\right\rangle\right\rangle+\left\langle\left\langle Y \cdot \varphi, \nabla_{X} \varphi\right\rangle\right\rangle \\
& =(i d+\tau)\left\langle\left\langle\varphi, Y \cdot \nabla_{X} \varphi\right\rangle\right\rangle \\
& =\frac{1}{2}(i d+\tau)\left\langle\left\langle\varphi, Y \cdot\left\{-\sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right)+\Gamma(X)\right\} \cdot \varphi\right\rangle\right\rangle .
\end{aligned}
$$

We showed in the proof of Proposition 3.1 that

$$
Y \cdot \sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right)=-B(X, Y)+\mathcal{D}
$$

where $\mathcal{D}$ is a term which satisfies $\tau \mathcal{D}=-\mathcal{D}$. Since moreover $\tau[B(X, Y)]=[B(X, Y)]$ and $\tau[Y \cdot \Gamma(X)]=-[\Gamma(X) \cdot Y]$, we get

\begin{aligned}
\partial_{X} \xi(Y) & =\xi(B(X, Y))^{N}+\left\langle\left\langle\varphi, \frac{1}{2}(Y \cdot \Gamma(X)-\Gamma(X) \cdot Y) \cdot \varphi\right\rangle\right\rangle^{N} \\
& =\xi(B(X, Y))-\langle\langle\varphi, \Gamma(X)(Y) \cdot \varphi\rangle\rangle^{N}
\end{aligned}
$$

since $\xi(B(X, Y))$ is normal to the immersion and by Lemma A.1. This implies that

$$
\begin{aligned}
B_{F}(\xi(X), \xi(Y)) & =\xi(B(X, Y))-\langle\langle\varphi, \Gamma(X)(Y) \cdot \varphi\rangle\rangle^{N}+\Gamma(\xi(X))(\xi(Y))^{N} \\
& =\xi(B(X, Y))
\end{aligned}
$$

since

$$
\begin{aligned}
\langle\langle\varphi, \Gamma(X)(Y) \cdot \varphi\rangle\rangle & =\langle\langle\Gamma(X)(Y) \cdot \varphi, \varphi\rangle\rangle \quad(\text { since } \tau[\Gamma(X)(Y)]=[\Gamma(X)(Y)] \in \mathcal{G}) \\
& =\xi(\Gamma(X)(Y)) \\
& =f(\Gamma(X)(Y)) \\
& =\Gamma(f(X))(f(Y)) \quad \text { (by definition of } \Gamma \text { on } T M \oplus E \text { ) } \\
& =\Gamma(\xi(X))(\xi(Y)) .
\end{aligned}
$$

We finally show the second identity in (29): we have

$$
\begin{aligned}
\nabla_{\xi(X)}^{\prime F} \xi(N)= & \left(\nabla_{\xi(X)}^{G} \xi(N)\right)^{N} \\
= & \left(\partial_{X} \xi(N)+\Gamma(\xi(X))(\xi(N))\right)^{N} \\
= & \left\langle\left\langle\nabla_{X}^{\prime} N \cdot \varphi, \varphi\right\rangle\right\rangle^{N}+\left\langle\left\langle N \cdot \nabla_{X} \varphi, \varphi\right\rangle\right\rangle^{N}+\left\langle\left\langle N \cdot \varphi, \nabla_{X} \varphi\right\rangle\right\rangle^{N} \\
& +\Gamma(\xi(X))(\xi(N)))^{N}
\end{aligned}
$$

The first term in the right hand side is $\xi\left(\nabla_{X}^{\prime} N\right)$, and we only need to show that

$$
\begin{equation*}
\left.\left\langle\left\langle N \cdot \nabla_{X} \varphi, \varphi\right\rangle\right\rangle^{N}+\left\langle\left\langle N \cdot \varphi, \nabla_{X} \varphi\right\rangle\right\rangle^{N}+\Gamma(\xi(X))(\xi(N))\right)^{N}=0 \tag{30}
\end{equation*}
$$

We have

$$
\begin{aligned}
\left\langle\left\langle N \cdot \nabla_{X} \varphi, \varphi\right\rangle\right\rangle+\left\langle\left\langle N \cdot \varphi, \nabla_{X} \varphi\right\rangle\right\rangle= & (i d+\tau)\left\langle\left\langle N \cdot \nabla_{X} \varphi, \varphi\right\rangle\right\rangle \\
= & \frac{1}{2}(i d+\tau)\left\langle\left\langle\left\{\sum_{j=1}^{p} e_{j} \cdot N \cdot B\left(X, e_{j}\right)+N \cdot \Gamma(X)\right\} \cdot \varphi, \varphi\right\rangle\right\rangle \\
= & \frac{1}{2}(i d+\tau)\left\langle\left\langle\sum_{j=1}^{p} e_{j} \cdot N \cdot B\left(X, e_{j}\right) \cdot \varphi, \varphi\right\rangle\right\rangle \\
& -\langle\langle\Gamma(X)(N) \cdot \varphi, \varphi\rangle\rangle
\end{aligned}
$$

since $\tau[N \cdot \Gamma(X)]=-[\Gamma(X) \cdot N]$ and by Lemma A.1. Taking into account that

$$
\langle\langle\Gamma(X)(N) \cdot \varphi, \varphi\rangle\rangle=\Gamma(\xi(X))(\xi(N))
$$

(see the first part of the proof above), the identity (30) will be proved if we show that the vector

$$
\frac{1}{2}(i d+\tau)\left\langle\left\langle\sum_{j=1}^{p} e_{j} \cdot N \cdot B\left(X, e_{j}\right) \cdot \varphi, \varphi\right\rangle\right\rangle
$$

is tangent to the immersion. We have

$$
\begin{aligned}
\sum_{j=1}^{p} e_{j} \cdot N \cdot B\left(X, e_{j}\right) & =-\sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right) \cdot N-2 \sum_{j=1}^{p} e_{j}\left\langle B\left(X, e_{j}\right), N\right\rangle \\
& =-\sum_{j=1}^{p} B\left(X, e_{j}\right) \cdot N \cdot e_{j}-2 B^{*}(X, N) \\
& =-\tau \sum_{j=1}^{p} e_{j} \cdot N \cdot B\left(X, e_{j}\right)-2 B^{*}(X, N)
\end{aligned}
$$

thus

$$
\frac{1}{2}(i d+\tau)\left\langle\left\langle\sum_{j=1}^{p} e_{j} \cdot N \cdot B\left(X, e_{j}\right) \cdot \varphi, \varphi\right\rangle\right\rangle=-\left\langle\left\langle B^{*}(X, N) \cdot \varphi, \varphi\right\rangle\right\rangle
$$

which is a vector tangent to the immersion since $B^{*}(X, N)$ belongs to $T M$; (30) follows, which finishes the proof.

We finally show the converse statement $(2) \Rightarrow(1)$ : we suppose that $F: M \rightarrow G$ is an isometric immersion with normal bundle $E$ and second fundamental form $B$, we consider the orthonormal frame $s_{o}=1_{S O(\mathcal{G})}$ of $\mathcal{G}$, and the spinor frame $\tilde{s}_{o}=1_{\operatorname{Spin}(\mathcal{G})}$ (recall that $Q_{G}=G \times S O(\mathcal{G})$ and $\tilde{Q}_{G}=G \times \operatorname{Spin}(\mathcal{G})$; see Section $2)$. The spinor field $\varphi=\left[\tilde{s}_{o}, 1_{C l(\mathcal{G})}\right]$ satisfies (22) as a consequence of the Gauss formulas (13)-(14); moreover, its associated 1-form is, for all $X \in T M$,

$$
\xi(X)=\left\langle\left\langle F_{*} X \cdot \varphi, \varphi\right\rangle\right\rangle=\tau[\varphi]\left[F_{*} X\right][\varphi]=\left[F_{*} X\right],
$$

where $\left[F_{*} X\right] \in \mathcal{G}$ represents $F_{*} X$ in $s_{o}$, that is $\left[F_{*} X\right]=\omega_{G}\left(F_{*} X\right)\left(\omega_{G} \in \Omega^{1}(G, \mathcal{G})\right.$ is the Maurer-Cartan form of $G$ ). Thus $\xi=F^{*} \omega_{G}$, that is $F=\int \xi$.

Remark 5. We proved that if $\varphi \in \Gamma(U \Sigma)$ is a solution of (22) such that $\xi_{\varphi}$ satisfies the structure equation (25) then $F=\int \xi_{\varphi}$ is an immersion with normal bundle $E$ and second fundamental form $B$. By (24) it is clear that if $a \in \operatorname{Spin}(\mathcal{G})$ is such that $\operatorname{Ad}\left(a^{-1}\right): \mathcal{G} \rightarrow \mathcal{G} \in S O(\mathcal{G})$ is an automorphism of Lie algebra, then $\xi_{\varphi \cdot a}$ satisfies the structure equation too; in fact, the corresponding immersions $F_{\varphi}=\int \xi_{\varphi}$ and $F_{\varphi \cdot a}=\int \xi_{\varphi \cdot a}$ are linked by the following formula: if $\Phi_{a}: G \rightarrow G$ is the automorphism of $G$ such that $d\left(\Phi_{a}\right)_{e}=A d\left(a^{-1}\right)$, then $\Phi_{a}$ is also an isometry for the left invariant metric, and

$$
\begin{equation*}
F_{\varphi \cdot a}=L_{b} \circ \Phi_{a} \circ F_{\varphi} \tag{31}
\end{equation*}
$$

for some b belonging to $G$. This relies on the following formula: if $\Phi: G \rightarrow G$ is an automorphism, $\omega_{G} \in \Omega^{1}(G, \mathcal{G})$ is the Maurer-Cartan form of $G$ and $F: M \rightarrow G$ is a smooth map, then

$$
(\Phi \circ F)^{*} \omega_{G}=d(\Phi)_{e} \circ\left(F^{*} \omega_{G}\right)
$$

This formula applied to $\Phi=\Phi_{a}$ and $F=F_{\varphi}$ shows that $\Phi_{a} \circ F_{\varphi}$ is a solution of the Darboux equation associated to the form $\xi_{\varphi \cdot a}$; thus, by uniqueness of a solution of the Darboux equation, (31) holds for some b belonging to $G$.

Remark 6. uniqueness of immersions + correspondence between immersions and solutions belonging to a sub-bundle.

## 4. An application: the fundamental theorem for immersions in a METRIC LIE GROUP

We now show that the equations of Gauss, Ricci and Codazzi on $B$ are exactly the integrability conditions of (22). We recall these equations for immersions in the metric Lie group $G$ : if $R^{G}$ denotes the curvature tensor of $(G,\langle.,\rangle$.$) , and if$ $R^{T}$ and $R^{N}$ stand for the curvature tensors of the connections on $T M$ and on $E$ ( $M$ is a submanifold of $G$ and $E$ is its normal bundle), then we have, for all $X, Y, Z \in \Gamma(T M)$ and $N \in \Gamma(E)$,
(1) the Gauss equation

Gauss equation G

## Ricci equation $G$

$$
\left(R^{G}(X, Y) Z\right)^{T}=R^{T}(X, Y) Z-B^{*}(X, B(Y, Z))+B^{*}(Y, B(X, Z))
$$

(2) the Ricci equation

$$
\begin{equation*}
\left(R^{G}(X, Y) N\right)^{N}=R^{N}(X, Y) N-B\left(X, B^{*}(Y, N)\right)+B\left(Y, B^{*}(X, N)\right) \tag{33}
\end{equation*}
$$

(3) the Codazzi equation

Codazzi equation G

$$
\left(R^{G}(X, Y) Z\right)^{N}=\tilde{\nabla}_{X} B(Y, Z)-\tilde{\nabla}_{Y} B(X, Z)
$$

in the last equation, $\tilde{\nabla}$ denotes the natural connection on $T^{*} M \otimes T^{*} M \otimes E$.
These equations make sense if $M$ is an abstract manifold and $E \rightarrow M$ is an abstract bundle as in Section 3, if we assume the existence of the bundle map $f$ in (15), since $f$ permits to define $\Gamma$ on $T M \oplus E$ by (17), and $R^{G}$ may be written in terms of $\Gamma$ only (see (4)-(5)). We prove the following:

Proposition 4.1. We assume that $M$ is simply connected. There exists $\varphi \in \Gamma(U \Sigma)$ solution of (22) if and only if $B: T M \times T M \rightarrow E$ satisfies the Gauss, Ricci and Codazzi equations.

Proof. We first prove that the Gauss, Ricci and Codazzi equations are necessary if we have a non-trivial solution of (22). We assume that $\varphi \in \Gamma(U \Sigma)$ is a solution of (22) and compute the curvature

R(X, Y) \varphi=\nabla_{X} \nabla_{Y} \varphi-\nabla_{Y} \nabla_{X} \varphi-\nabla_{[X, Y]} \varphi
$$

We fix a point $x_{0} \in M$, and assume that $\nabla X=\nabla Y=0$ at $x_{0}$. We have

$$
\begin{aligned}
\nabla_{X} \nabla_{Y} \varphi= & -\frac{1}{2} \sum_{j=1}^{p} e_{j} \cdot\left(\tilde{\nabla}_{X} B\left(Y, e_{j}\right) \cdot \varphi+B\left(Y, e_{j}\right) \cdot \nabla_{X} \varphi\right) \\
& +\frac{1}{2}\left(\nabla_{X} \Gamma(Y) \cdot \varphi+\Gamma(Y) \cdot \nabla_{X} \varphi\right) \\
= & -\frac{1}{2} \sum_{j=1}^{p} e_{j} \cdot \tilde{\nabla}_{X} B\left(Y, e_{j}\right) \cdot \varphi-\frac{1}{4} \sum_{j, k=1}^{p} e_{j} \cdot e_{k} \cdot B\left(Y, e_{j}\right) \cdot B\left(X, e_{k}\right) \\
& -\frac{1}{4} \sum_{j=1}^{p} e_{j} \cdot B\left(Y, e_{j}\right) \cdot \Gamma(X) \cdot \varphi+\frac{1}{2} \nabla_{X} \Gamma(Y) \cdot \varphi-\frac{1}{4} \Gamma(Y) \cdot \sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right) \cdot \varphi \\
& +\frac{1}{4} \Gamma(Y) \cdot \Gamma(X) \cdot \varphi
\end{aligned}
$$

Thus

R function $B$

$$
\begin{align*}
R(X, Y) \varphi= & -\frac{1}{2} \sum_{j=1}^{p} e_{j} \cdot\left(\tilde{\nabla}_{X} B\left(Y, e_{j}\right)-\tilde{\nabla}_{Y} B\left(X, e_{j}\right)\right) \cdot \varphi \\
& +\frac{1}{4} \sum_{j \neq k} e_{j} \cdot e_{k} \cdot\left(B\left(X, e_{j}\right) \cdot B\left(Y, e_{k}\right)-B\left(Y, e_{j}\right) \cdot B\left(X, e_{k}\right)\right) \cdot \varphi  \tag{35}\\
& -\frac{1}{4} \sum_{j=1}^{p}\left(B\left(X, e_{j}\right) \cdot B\left(Y, e_{j}\right)-B\left(Y, e_{j}\right) \cdot B\left(X, e_{j}\right)\right) \cdot \varphi \\
& +\underbrace{\frac{1}{2}\left[\sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right), \Gamma(Y)\right]}_{\mathcal{C}_{1}} \cdot \varphi+\underbrace{-\frac{1}{2}\left[\sum_{j=1}^{p} e_{j} \cdot B\left(Y, e_{j}\right), \Gamma(X)\right] \cdot \varphi}_{\mathcal{C}_{3}} \\
& +\underbrace{\frac{1}{2}\left(\nabla_{X} \Gamma(Y)-\nabla_{Y} \Gamma(X)\right)}_{\mathcal{C}_{4}} \cdot \varphi+\underbrace{-\frac{1}{2}[\Gamma(X), \Gamma(Y)]} \cdot \varphi .
\end{align*}
$$

We computed the second and the third terms in [4]; we only recall the result here:

Lemma 4.2. [4] Let us set

and

\mathcal{B}:=-\frac{1}{4} \sum_{j}\left(B\left(X, e_{j}\right) \cdot B\left(Y, e_{j}\right)-B\left(Y, e_{j}\right) \cdot B\left(X, e_{j}\right)\right)
$$

We have

$$
\mathcal{A}=\frac{1}{2} \sum_{j<k}\left\{\left\langle B^{*}\left(X, B\left(Y, e_{j}\right)\right), e_{k}\right\rangle-\left\langle B^{*}\left(Y, B\left(X, e_{j}\right)\right), e_{k}\right\rangle\right\} e_{j} \cdot e_{k}
$$

and

$$
\mathcal{B}=\frac{1}{2} \sum_{k<l}\left\langle B\left(X, B^{*}\left(Y, n_{k}\right)\right)-B\left(Y, B^{*}\left(X, n_{k}\right)\right), n_{l}\right\rangle n_{k} \cdot n_{l}
$$

We now compute the other terms in (35). We first compute the covariant derivative of $\Gamma$, considering $\Gamma$ as a map

$$
\Gamma: \quad T M \oplus E \rightarrow \operatorname{End}(T M \oplus E) .
$$

Lemma 4.3. If $X, Y \in T M$ and $Z \in T M \oplus E$,

\begin{aligned}
\left(\nabla_{X} \Gamma\right)(Y) Z= & {[\Gamma(X), \Gamma(Y)] Z-B\left(X,(\Gamma(Y) Z)^{T}\right)+B^{*}\left(X,(\Gamma(Y) Z)^{N}\right) } \\
& +\Gamma(Y)\left(B\left(X, Z^{T}\right)\right)-\Gamma(Y)\left(B^{*}\left(X, Z^{N}\right)\right)-\Gamma(\Gamma(X) Y)(Z) \\
& +\Gamma(B(X, Y))(Z) .
\end{aligned}
$$

Here the brackets stand for the commutator of the endomorphisms.
Proof. Since the expression is tensorial, we may assume that $X, Y, Z \in \Gamma(T M \oplus E)$ are left invariant vector fields. By definition,

\nabla_{X} \Gamma(Y) Z=\nabla_{X}(\Gamma(Y) Z)-\Gamma\left(\nabla_{X} Y\right) Z-\Gamma(Y)\left(\nabla_{X} Z\right) \tag{36}

Since $X, Y$ and $Z$ are left invariant vector fields, so are $\Gamma(Y) Z, \nabla_{X} Y$ and $\nabla_{X} Z$, and, by (18),

\nabla_{X}(\Gamma(Y) Z)=\Gamma(X)(\Gamma(Y) Z)-B\left(X,(\Gamma(Y) Z)^{T}\right)+B^{*}\left(X,(\Gamma(Y) Z)^{N}\right) \\
\Gamma(Y)\left(\nabla_{X} Z\right)=\Gamma(Y)(\Gamma(X) Z)-\Gamma(Y) B\left(X, Z^{T}\right)+\Gamma(Y) B^{*}\left(X, Z^{N}\right)
\end{gathered}
$$

and

$$
\Gamma\left(\nabla_{X} Y\right)(Z)=\Gamma(\Gamma(X) Y) Z-\Gamma\left(B\left(X, Y^{T}\right)\right) Z+\Gamma\left(B^{*}\left(X, Y^{N}\right)\right) Z
$$

Plugging these formulas in (36), we get the result.
We now regard $\Gamma$ as a map

$$
\Gamma: \quad T M \oplus E \rightarrow \Lambda^{2}(T M \oplus E) \subset C l(T M \oplus E)
$$

and compute the term $\mathcal{C}_{3}$ in (35).
Lemma 4.4. If $X, Y \in T M$,

\begin{aligned}
\frac{1}{2}\left(\left(\nabla_{X} \Gamma\right)(Y)-\left(\nabla_{Y} \Gamma\right)(X)\right)= & {[\Gamma(X), \Gamma(Y)]-\frac{1}{2} \Gamma([\Gamma(X), Y]-[\Gamma(Y), X]) } \\
& -\frac{1}{2}\left[\sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right), \Gamma(Y)\right]+\frac{1}{2}\left[\sum_{j=1}^{p} e_{j} \cdot B\left(Y, e_{j}\right), \Gamma(X)\right]
\end{aligned}
$$

Here the brackets stand for the commutator in $C l(T M \oplus E)$.
Proof. We first note that the linear maps $Z \mapsto[\Gamma(X), \Gamma(Y)] Z, Z \mapsto \Gamma(\Gamma(X) Y) Z$ and $Z \mapsto \Gamma(B(X, Y)) Z$ appearing in Lemma 4.3 are respectively represented by the bivectors $[\Gamma(X), \Gamma(Y)], \Gamma([\Gamma(X), Y])$ and $\Gamma(B(X, Y))$ (Lemmas A. 1 and A. 2 in the appendix). Moreover, by Lemma A. 4 applied to the linear maps $B(X,):. T M \rightarrow E$ and $\Gamma(Y): T M \oplus E \rightarrow T M \oplus E$, the map
$Z \mapsto-B^{*}\left(X,(\Gamma(Y) Z)^{N}\right)+\Gamma(Y)\left(B^{*}\left(X, Z^{N}\right)\right)+B\left(X,(\Gamma(Y) Z)^{T}\right)-\Gamma(Y)\left(B\left(X, Z^{T}\right)\right)$
is represented by the bivector

$$
\left[\sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right), \Gamma(Y)\right] \in C l(T M \oplus E)
$$

The result follows.
We now deduce the sum of the last four terms in (35):
Lemma 4.5. Let us set, for $X, Y \in T M$,

R^{G}(X, Y)=[\Gamma(X), \Gamma(Y)]-\Gamma([\Gamma(X), Y]-[\Gamma(Y), X]) \in \Lambda^{2}(T M \oplus E)
$$

(note that $R^{G}$ is the curvature tensor of $G$, pulled-back to $T M \oplus E$ by the bundle isomorphism $f$ introduced in (15)). Then

$$
\mathcal{C}_{1}+\mathcal{C}_{2}+\mathcal{C}_{3}+\mathcal{C}_{4}=\frac{1}{2} R^{G}(X, Y)
$$

We thus get the formula

$$
\begin{align*}
R(X, Y) \varphi= & -\frac{1}{2} \sum_{j=1}^{p} e_{j} \cdot\left(\tilde{\nabla}_{X} B\left(Y, e_{j}\right)-\tilde{\nabla}_{Y} B\left(X, e_{j}\right)\right) \cdot \varphi  \tag{37}\\
& +\mathcal{A} \cdot \varphi+\mathcal{B} \cdot \varphi+\frac{1}{2} R^{G}(X, Y) \cdot \varphi
\end{align*}
$$

where $\mathcal{A}$ and $\mathcal{B}$ are computed in Lemma 4.2 and $R^{G}$ may be conveniently written in the form

$$
\begin{aligned}
R^{G}(X, Y)= & \sum_{1 \leq j<k \leq p}\left\langle R^{G}(X, Y)\left(e_{j}\right), e_{k}\right\rangle e_{j} \cdot e_{k} \\
& +\sum_{j=1}^{p} \sum_{r=1}^{q}\left\langle R^{G}(X, Y)\left(e_{j}\right), n_{r}\right\rangle e_{j} \cdot n_{r} \\
& +\sum_{1 \leq l<r \leq q}\left\langle R^{G}(X, Y)\left(n_{r}\right), n_{l}\right\rangle n_{l} \cdot n_{r} .
\end{aligned}
$$

On the other hand, the curvature of the spinorial connection is given by

\begin{align*}
R(X, Y) \varphi= & \frac{1}{2}\left(\sum_{1 \leq j<k \leq p}\left\langle R^{T}(X, Y)\left(e_{j}\right), e_{k}\right\rangle e_{j} \cdot e_{k}\right.  \tag{38}\\
& \left.+\sum_{1 \leq k<l \leq q}\left\langle R^{N}(X, Y)\left(n_{k}\right), n_{l}\right\rangle n_{k} \cdot n_{l}\right) \cdot \varphi
\end{align*}
$$

We now compare the expressions (37) and (38): since in a given frame $\tilde{s}$ belonging to $\tilde{Q}, \varphi$ is represented by an element which is invertible in $C l(\mathcal{G})$ (it is in fact represented by an element belonging to $\operatorname{Spin}(\mathcal{G})$ ), we may identify the coefficients and get

& \left\langle R^{T}(X, Y)(e j), e_{k}\right\rangle=\left\langle B^{*}\left(X, B\left(Y, e_{j}\right)\right), e_{k}\right\rangle-\left\langle B^{*}\left(Y, B\left(X, e_{j}\right)\right), e_{k}\right\rangle+\left\langle R^{G}(X, Y)\left(e_{j}\right), e_{k}\right\rangle \\
& \left\langle R^{N}(X, Y)\left(n_{k}\right), n_{l}\right\rangle=\left\langle B\left(X, B^{*}\left(Y, n_{k}\right)\right), n_{l}\right\rangle-\left\langle B\left(Y, B^{*}\left(X, n_{k}\right)\right), n_{l}\right\rangle+\left\langle R^{G}(X, Y)\left(n_{k}\right), n_{l}\right\rangle
\end{aligned}
$$

and

$$
\left\langle\tilde{\nabla}_{X} B\left(Y, e_{j}\right)-\tilde{\nabla}_{Y} B\left(X, e_{j}\right), n_{r}\right\rangle=\left\langle R^{G}(X, Y)\left(e_{j}\right), n_{r}\right\rangle
$$

for all the indices. These equations are the equations of Gauss, Ricci and Codazzi.
We now prove that the equations of Gauss, Ricci and Codazzi are also sufficient to get a solution of (22). The calculations above show that the connection on $\Sigma$ defined by

$$
\begin{equation*}
\nabla_{X}^{\prime} \varphi:=\nabla_{X} \varphi+\frac{1}{2} \sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right) \cdot \varphi-\frac{1}{2} \Gamma(X) \cdot \varphi \tag{39}
\end{equation*}
$$

for all $\varphi \in \Gamma(\Sigma)$ and $X \in \Gamma(T M)$ is flat if and only if the equations of Gauss, Ricci and Codazzi hold. But if this connection is flat there exists a solution $\varphi \in \Gamma(U \Sigma)$ of (22); this is because $\nabla^{\prime}$ may be also interpreted as a connection on $U \Sigma$ regarded as a principal bundle (of goup $\operatorname{Spin}(\mathcal{G})$, acting on the right): indeed, $\nabla$ defines such
a connection (since it comes from a connection on $\tilde{Q}$ ), and the right hand side term in (39) defines a linear map

$$
\begin{aligned}
T M & \rightarrow \chi_{V}^{i n v}(U \Sigma) \\
X & \mapsto \varphi \mapsto \frac{1}{2} \sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right) \cdot \varphi-\frac{1}{2} \Gamma(X) \cdot \varphi
\end{aligned}
$$

from $T M$ to the vector fields on $U \Sigma$ which are vertical and invariant under the action of the group (these vector fields are of the form $\varphi \mapsto \eta \cdot \varphi, \eta \in \Lambda^{2}(T M \oplus E) \subset$ $C l(T M \oplus E))$. Assuming that the equations of Gauss, Codazzi and Ricci hold, we thus get a solution $\varphi \in \Gamma(U \Sigma)$ of (22).

The considerations above give a spinorial proof of the fundamental theorem of submanifold theory in the metric Lie group $G$ :
Corollary 1. We keep the hypotheses and notation of Section 2, and moreover assume that $M$ is simply connected and that $B: T M \times T M \rightarrow E$ is bilinear, symmetric and satisfies the equations of Gauss, Codazzi and Ricci. Then there is an isometric immersion of $M$ into $G$ with normal bundle $E$ and second fundamental form $B$. The immersion is unique up to a rigid motion in $G$, that is up to a transformation of the form

$$
\begin{align*}
L_{b} \circ \Phi_{a}: \quad G & \rightarrow G  \tag{40}\\
g & \mapsto b \Phi_{a}(g)
\end{align*}
$$

where $a \in \operatorname{Spin}(\mathcal{G})$ is such that $\operatorname{Ad}(a): \mathcal{G} \rightarrow \mathcal{G}$ is an automorphism of Lie algebra, $\Phi_{a}: G \rightarrow G$ is the group automorphism such that $d\left(\Phi_{a}\right)_{e}=A d(a)$, and b belongs to $G$.

Proof. The equations of Gauss, Codazzi and Ricci are the integrability conditions of (22). We thus get a solution $\varphi \in \Gamma(U \Sigma)$ of (22); with such a spinor field at hand, $F=\int \xi$ where $\xi$ is defined in (23) is the immersion. Finally, a solution of (22) is unique up to the right action of an element of $\operatorname{Spin}(\mathcal{G})$; the right multiplication of $\varphi$ by $a \in \operatorname{Spin}(\mathcal{G})$ and the left multiplication by $b \in G$ in the last integration give also an immersion, if $\operatorname{Ad}(a): \mathcal{G} \rightarrow \mathcal{G}$ is moreover an automorphism of Lie algebra. This immersion is obtained form the immersion defined by $\varphi$ by a rigid motion, as described in (40).
Remark 7. In $\mathbb{R}^{n}$, a rigid motion as in (40) is a transformation of the form

$$
\begin{aligned}
\mathbb{R}^{n} & \rightarrow \mathbb{R}^{n} \\
x & \mapsto a x+b
\end{aligned}
$$

with $a \in S O(n)$ and $b \in \mathbb{R}^{n}$.

## 5. Special cases

5.1. Submanifolds in $\mathbb{R}^{n}$. If the metric Lie group is $\mathbb{R}^{n}$ with its natural metric, we recover the main result of [4]. We suppose that $M$ is a $p$-dimensional Riemannian manifold, $E \rightarrow M$ a bundle of rank $q$, with a fibre metric and a compatible connection. We assume that $T M$ and $E$ are oriented and spin with given spin structures, and that $B: T M \times T M \rightarrow E$ is bilinear and symmetric.
Theorem 2. [4] We moreover assume that $M$ is simply connected. The following statements are equivalent:
(1) There exists a section $\varphi \in \Gamma(U \Sigma)$ such that

$$
\begin{equation*}
\nabla_{X} \varphi=-\frac{1}{2} \sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right) \cdot \varphi \tag{41}
\end{equation*}
$$

for all $X \in T M$.
(2) There exists an isometric immersion $F: M \rightarrow \mathbb{R}^{n}$ with normal bundle $E$ and second fundamental form $B$.
Moreover, $F=\int \xi$ where $\xi$ is the $\mathbb{R}^{n}$-valued 1-form defined by

$$
\begin{equation*}
\xi(X):=\langle\langle X \cdot \varphi, \varphi\rangle\rangle \tag{42}
\end{equation*}
$$

for all $X \in T M$.
Proof. We only prove (1) $\Rightarrow(2)$. This will be a consequence of Theorem 1 if we may define a bundle map $f$ as in (15) such that (18) holds. We assume that $\varphi$ is a solution of (41), and set

$$
\begin{aligned}
f: \quad T M \oplus E & \rightarrow M \times \mathbb{R}^{n} \\
Z & \mapsto\langle\langle Z \cdot \varphi, \varphi\rangle\rangle .
\end{aligned}
$$

The map $\Gamma$ defined by (17) is $\Gamma=0$. We now show that (18) is satisfied for every $Z \in \Gamma(T M \oplus E)$ such that $f(Z): M \rightarrow \mathbb{R}^{n}$ is a constant map: for all $X \in T M$, we have $\partial_{X}\{f(Z)\}=0$, which reads

$$
\left\langle\left\langle\nabla_{X} Z \cdot \varphi, \varphi\right\rangle\right\rangle+\left\langle\left\langle Z \cdot \nabla_{X} \varphi, \varphi\right\rangle\right\rangle+\left\langle\left\langle Z \cdot \varphi, \nabla_{X} \varphi\right\rangle\right\rangle=0 .
$$

But, by (41) and (11),

$$
\begin{aligned}
\left\langle\left\langle Z \cdot \nabla_{X} \varphi, \varphi\right\rangle\right\rangle+\left\langle\left\langle Z \cdot \varphi, \nabla_{X} \varphi\right\rangle\right\rangle & =\left\langle\left\langle\left[\sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right), Z\right] \cdot \varphi, \varphi\right\rangle\right\rangle \\
& =\left\langle\left\langle\left\{B\left(X, Z^{T}\right)-B^{*}\left(X, Z^{N}\right)\right\} \cdot \varphi, \varphi\right\rangle\right\rangle
\end{aligned}
$$

where we use Lemma A. 3 in the last step. Thus

$$
\left\langle\left\langle\nabla_{X} Z \cdot \varphi, \varphi\right\rangle\right\rangle=\left\langle\left\langle\left\{-B\left(X, Z^{T}\right)+B^{*}\left(X, Z^{N}\right)\right\} \cdot \varphi, \varphi\right\rangle\right\rangle
$$

and

$$
\nabla_{X} Z=-B\left(X, Z^{T}\right)+B^{*}\left(X, Z^{N}\right)
$$

which is (18) with $\Gamma=0$.
5.2. Submanifolds in $\mathbb{H}^{n}$. Spinor representations of submanifolds in $\mathbb{H}^{n}$ with its natural metric were already given in $[14,3,4]$. We give here an other representation using the group structure of $\mathbb{H}^{n}$, with an arbitrary left invariant metric. Let us set

$$
\mathbb{H}^{n}=\left\{a=\left(a^{\prime}, a_{n}\right) \in \mathbb{R}^{n}: a_{n}>0\right\}
$$

and, for $a \in \mathbb{H}^{n}$, the similarity of $\mathbb{R}^{n-1}$ (by a similarity we mean an homothety composed by a translation)

$$
\begin{aligned}
\varphi_{a}: \quad \mathbb{R}^{n-1} & \rightarrow \mathbb{R}^{n-1} \\
x & \mapsto a_{n} x+a^{\prime}
\end{aligned}
$$

The similarities of $\mathbb{R}^{n-1}$ naturally form a group under composition, and the bijection

a & \mapsto \varphi_{a}
\end{aligned}

induces a group structure on $\mathbb{H}^{n}$ : it is such that

$$
\begin{equation*}
a b=\left(a_{n} b^{\prime}+a^{\prime}, a_{n} b_{n}\right) \tag{43}
\end{equation*}
$$

for all $a, b \in \mathbb{H}^{n}$; the neutral element is $e=(0,1) \in \mathbb{H}^{n}$. Let us denote by $\left(e_{1}^{o}, e_{2}^{o}, \ldots, e_{n}^{o}\right)$ the canonical basis of $T_{e} \mathbb{H}^{n}=\mathbb{R}^{n}$ and keep the same letters to denote the corresponding left invariant vector fields on $\mathbb{H}^{n}$. The Lie bracket may be easily seen to be given by

\left[e_{i}^{o}, e_{j}^{o}\right]=0 \quad \text { and } \quad\left[e_{n}^{o}, e_{i}^{o}\right]=e_{i}^{o}
$$

for $i, j=1, \ldots, n-1$. This may also be written in the form

for all $X, Y \in \mathbb{R}^{n}$, where $l: \mathbb{R}^{n} \rightarrow \mathbb{R}$ is the linear form such that $l\left(e_{i}^{o}\right)=0$ if $i \leq n-1$ and $l\left(e_{n}^{o}\right)=1$. This property implies that every left invariant metric on $\mathbb{H}^{n}$ has constant negative curvature $-|l|^{2}[13,12]$.

We suppose that a left invariant metric $\langle.,$.$\rangle is given on \mathbb{H}^{n}$, and consider the vector $U_{o} \in T_{e} \mathbb{H}^{n}$ such that $l(X)=\left\langle U_{o}, X\right\rangle$ for all $X \in T_{e} \mathbb{H}^{n}$. We have $\left|U_{o}\right|=|l|$, and, by the Koszul formula (3),

\Gamma(X)(Y)=-\left\langle Y, U_{o}\right\rangle X+\langle X, Y\rangle U_{o} \tag{45}
\end{equation*}

for all $X, Y \in T_{e} \mathbb{H}^{n}$.
We keep the hypotheses made at the beginning of Section 5.1. We suppose moreover that $U \in \Gamma(T M \oplus E)$ is given such that $|U|=|l|$ and, for all $X \in T M$,

Remark 8. Equation (46) implies the following:
(1) $U$ is a solution of (18), with the definition (47) of $\Gamma$.
(2) The norm of $U$ is constant, since, by a straightforward computation,

d|U|^{2}(X)=2\left\langle\nabla_{X} U, U\right\rangle=0
$$

for all $X \in T M$. The additional hypothesis $|U|=|l|$ is thus not very restrictive.
We note that it is not necessary to assume the existence of $U$ solution of (46) to get a spinor representation of a submanifold in $\mathbb{H}^{n}$ if $\mathbb{H}^{n}$ is regarded as the set of unit vectors in Minkowski space $\mathbb{R}^{n, 1}[14,3,4]$. Nevertheless, this hypothesis seems necessary if we consider $\mathbb{H}^{n}$ as a group, since the group structure introduces an anisotropy: the vector $e_{n} \in T_{e} \mathbb{H}^{n}$ is indeed a special direction for the group structure.

Let us construct the spinor bundles $\Sigma$ and $U \Sigma$ on $M$ as in Section 2.4 with here $\mathcal{G}=T_{e} \mathbb{H}^{n}$.

Theorem 3. We assume that $M$ is simply connected. The following statements are equivalent:
(1) There exists a spinor field $\varphi \in \Gamma(U \Sigma)$ solution of (22) where $\Gamma$ is defined by (47).
(2) There exists an isometric immersion $M \rightarrow \mathbb{H}^{n}$ with normal bundle $E$ and second fundamental form $B$.

Proof. We assume that $\varphi \in \Gamma(U \Sigma)$ is a solution of (22) where $\Gamma$ is defined by (47), and define $f: T M \oplus E \rightarrow M \times T_{e} \mathbb{H}^{n}$ by

f(Z)=\langle\langle Z \cdot \varphi, \varphi\rangle\rangle

for all $Z \in T M \oplus E$. Let us first observe that if $Z$ is a vector field solution of (18), then $f(Z)$ is constant: we have, for all $X \in T M$,

\partial_{X} f(Z)=\left\langle\left\langle\nabla_{X} Z \cdot \varphi, \varphi\right\rangle\right\rangle+(i d+\tau)\left\langle\left\langle Z \cdot \nabla_{X} \varphi, \varphi\right\rangle\right\rangle ;

this is 0 , by (18), (22) and formulas (26)-(27) in Lemma 3.2. Since $U$ is a solution of (18) (see Remark 8), we deduce that $f(U) \in T_{e} \mathbb{H}^{n}$ is a constant, and, since $|f(U)|=|U|=\left|U_{o}\right|$, replacing $\varphi$ by $\varphi \cdot a$ for some $a \in \operatorname{Spin}\left(T_{e} \mathbb{H}^{n}\right)$ if necessary, we may suppose that $f(U)=U_{o}$. Since $\Gamma$ is defined on $T_{e} \mathbb{H}^{n}$ by (45) and on $T M \oplus E$ by (47), and since $f$ preserves the metrics, it is straightforward to see that $f(\Gamma(X)(Y))=\Gamma(f(X))(f(Y))$ for all $X, Y \in T M \oplus E$. Finally, (18) holds for all $Z \in \Gamma(T M \oplus E)$ such that $f(Z)$ is constant: this is the same argument as in the proof of Theorem 2 in Section 5.1, just adding the term $\Gamma$. The result then follows from Theorem 1.
5.3. Hypersurfaces in a metric Lie group. We assume that $G$ is a simply connected $n$-dimensional metric Lie group, $M$ is a $p$-dimensional Riemannian manifold, $n=p+1$, and $E$ is the trivial line bundle on $M$, oriented by a unit section $\nu \in \Gamma(E)$. We moreover suppose that $M$ is simply connected and that $h: T M \times T M \rightarrow \mathbb{R}$ is a given symmetric bilinear form, and that the hypotheses (1) and (2) of Section 3 with $B=h \nu$ hold. According to Theorem 1, an isometric immersion of $M$ into $G$ with second fundamental form $h$ is equivalent to a section $\varphi$ of $\Gamma(U \Sigma)$ solution of the Killing equation (22). Note that $Q_{E} \simeq M$ and the double covering

(induced by the Clifford map $\mathbb{R}^{p} \rightarrow C l_{p+1}, X \mapsto X \cdot e_{p+1}$ ), we deduce a bundle isomorphism

\tilde{Q}_{M} \times{ }_{\rho} C l_{p} & \rightarrow \tilde{Q} \times{ }_{\rho} C l_{p+1}^{0} \quad \subset \Sigma  \tag{48}\\
\psi & \mapsto \psi^{*} .

It satisfies the following properties: for all $X \in T M$ and $\psi \in \tilde{Q}_{M} \times{ }_{\rho} C l_{p}$,

To write down the Killing equation (22) in the bundle $\tilde{Q}_{M} \times{ }_{\rho} C l_{p}$, we need to decompose the Clifford action of $\Gamma(X)$ into its tangent and its normal parts:

& =\sum_{i=1}^{n}\left\langle X, T_{i}\right\rangle \sum_{k=1}^{n} \Gamma_{i j}^{k} \underline{e}_{k} \\
& =\sum_{1 \leq i, k \leq n} \Gamma_{i j}^{k}\left\langle X, T_{i}\right\rangle\left(T_{k}+f_{k} \nu\right)
\end{aligned}
$$

and thus

\Gamma(X) & =\frac{1}{2} \sum_{j=1}^{n} \underline{e}_{j} \cdot \Gamma(X)\left(\underline{e}_{j}\right) \\
& =\frac{1}{2} \sum_{j=1}^{n}\left(T_{j}+f_{j} \nu\right) \cdot \sum_{1 \leq i, k \leq n} \Gamma_{i j}^{k}\left\langle X, T_{i}\right\rangle\left(T_{k}+f_{k} \nu\right) \\
& =\frac{1}{2} \sum_{1 \leq i, j, k \leq n} \Gamma_{i j}^{k}\left\langle X, T_{i}\right\rangle\left(T_{j}+f_{j} \nu\right) \cdot\left(T_{k}+f_{k} \nu\right)
\end{aligned}
$$

Now

$$
\left(T_{j}+f_{j} \nu\right) \cdot\left(T_{k}+f_{k} \nu\right)=T_{j} \cdot T_{k}+f_{k} T_{j} \cdot \nu-f_{j} T_{k} \cdot \nu-f_{j} f_{k}

and the result follows since $\Gamma_{i j}^{k}=-\Gamma_{i k}^{j}$.
The section $\varphi \in \Gamma(U \Sigma)$ solution of (22) thus identifies to a section $\psi$ of $\tilde{Q}_{M} \times{ }_{\rho} C l_{p}$ solution of

\end{aligned}

for all $X \in T M$, where

\begin{equation*}
\tilde{\Gamma}(X)=\sum_{i}\left\langle X, T_{i}\right\rangle \sum_{j<k} \Gamma_{i j}^{k}\left(\frac{1}{2}\left(T_{j} \cdot{ }_{M} T_{k}-T_{k} \cdot{ }_{M} T_{j}\right)+\left(f_{k} T_{j}-f_{j} T_{k}\right)\right) \tag{51}
\end{equation*}
$$

and $S: T M \rightarrow T M$ is the symmetric operator associated to $h$. We deduce the following result:

Theorem 4. Let $S: T M \rightarrow T M$ be a symmetric operator. The following two statements are equivalent:
(1) there exists an isometric immersion of $M$ into $G$ with shape operator $S$;
(2) there exists a normalized spinor field $\psi \in \Gamma\left(\tilde{Q}_{M} \times{ }_{\rho} C l_{p}\right)$ solution of
equation psi

for all $X \in T M$, where $\tilde{\Gamma}$ is defined in (51).
Here, a spinor field $\psi \in \Gamma\left(\tilde{Q}_{M} \times{ }_{\rho} C l_{p}\right)$ is said to be normalized if it is represented in some frame $\tilde{s} \in \tilde{Q}_{M}$ by an element $[\psi] \in C l_{p} \simeq C l_{p+1}^{0}$ belonging to $\operatorname{Spin}(p+1)$.

We will see below explicit representation formulas in the cases of the dimensions 3 and 4.
5.4. Surfaces in a 3-dimensional metric Lie group. Since $C l_{2} \simeq \Sigma_{2}$ we have

and $\varphi$ is equivalent to a spinor field $\psi \in \Gamma(\Sigma M)$ solution of (52) and such that $|\psi|=1$. Moreover, the explicit representation formula $F=\int \xi$ may be written in terms of $\psi$ : it may be proved by a computation that

\langle\langle X \cdot \varphi, \varphi\rangle\rangle=i 2 \mathcal{R} e\left\langle X \cdot \psi^{+}, \psi^{-}\right\rangle+j\left(\left\langle X \cdot \psi^{+}, \alpha\left(\psi^{+}\right)\right\rangle-\left\langle X \cdot \psi^{-}, \alpha\left(\psi^{-}\right)\right\rangle\right) \tag{53}
\end{equation*}
$$

where the brackets $\langle.,$.$\rangle stand here for the natural hermitian product on \Sigma_{2}$ and $\alpha: \Sigma_{2} \rightarrow \Sigma_{2}$ is the natural quaternionic structure. If $G=\mathbb{R}^{3}$, this is the explicit representation formula given in [6] (see also [3]).

We also note that the expression (51) of $\tilde{\Gamma}$ simplifies if the Lie group is 3dimensional:
lem Gamma dim 3 Lemma 5.2. If $(j, k, l)$ is a permutation of $\{1,2,3\}$ and $\epsilon_{j k l}= \pm 1$ denotes its sign, then, for all $\psi \in \Gamma(\Sigma M)$,

Proof. Keeping the notation introduced above, we note that

& =\epsilon_{j k l}\left(f_{l}-T_{l} \cdot \nu\right) \cdot \omega
\end{aligned}
$$

since $T_{l} \cdot \nu=-\nu \cdot T_{l}, T_{l} \cdot \omega=-\omega \cdot T_{l}$ and $\omega \cdot \nu=\nu \cdot \omega$. Switching the indices $j$ and $k$ we also get

$$

and deduce that

\frac{1}{2}\left(T_{j} \cdot T_{k}-T_{k} \cdot T_{j}\right)+\left(f_{k} T_{j}-f_{j} T_{k}\right) \cdot \nu=\epsilon_{j k l}\left(f_{l}-T_{l} \cdot \nu\right) \cdot \omega
$$

The result is then a consequence of the first property in (49).
5.4.1. The metric Lie group $S^{3}$. A spinor representation of a surface immersed in $S^{3}$ was already given in [14] (see also $[3,4]$ ). We give here a spinor representation relying on the group structure; it appears that it coincides with the result in [14].

We regard the sphere $S^{3}$ as the set of the unit quaternions, with its natural group structure. The Lie algebra of $S^{3}$ identifies to $\mathbb{R}^{3}$, with the bracket $[X, Y]=2 X \times Y$ for all $X, Y \in \mathbb{R}^{3}$ ( $\times$ is the usual cross product). By the Koszul formula (3), for all $X, Y \in \mathbb{R}^{3}$,

\Gamma(X)(Y)=X \times Y
$$

As a bivector, for all $X=X_{1} e_{1}^{o}+X_{2} e_{2}^{o}+X_{3} e_{3}^{o} \in \mathbb{R}^{3}$,

$$
\begin{aligned}
\Gamma(X) & =\frac{1}{2}\left(e_{1}^{o} \cdot \Gamma(X)\left(e_{1}^{o}\right)+e_{2}^{o} \cdot \Gamma(X)\left(e_{2}^{o}\right)+e_{3}^{o} \cdot \Gamma(X)\left(e_{3}^{o}\right)\right) \\
& =X_{1} e_{2}^{o} \cdot e_{3}^{o}+X_{2} e_{3}^{o} \cdot e_{1}^{o}+X_{3} e_{1}^{o} \cdot e_{2}^{o} \\
& =-X \cdot\left(e_{1}^{o} \cdot e_{2}^{o} \cdot e_{3}^{o}\right)
\end{aligned}
$$

Thus, if $\varphi \in \tilde{Q} \times{ }_{\rho} C l_{3}^{0}$ represents an immersion of an oriented surface $M$ in $S^{3}$ and if $\psi \in \Gamma(\Sigma M)$ is such that $\varphi=\psi^{*}$, then, for all $X \in T M$,

\Gamma(X) \cdot \varphi & =-X \cdot\left(e_{1}^{o} \cdot e_{2}^{o} \cdot e_{3}^{o}\right) \cdot \varphi \\
& =-X \cdot \omega \cdot \nu \cdot \varphi \\
& =(X \cdot \nu) \cdot \omega \cdot \varphi \\
& =(X \cdot \omega \cdot \psi)^{*}
\end{aligned}
$$

where $\omega$ is the area form of $M$, and $\nu$ is the vector normal to $M$ in $S^{3}$. Since $\varphi \in \Gamma(U \Sigma)$ is a solution of $(22), \psi \in \Gamma(\Sigma M)$ is a solution of

$$
\nabla_{X} \psi=-\frac{1}{2} S(X) \cdot \psi+\frac{1}{2} X \cdot \omega \cdot \psi

and satisfies $|\psi|=1$. Taking the trace, we get

where $\left(e_{1}, e_{2}\right)$ is a positively oriented and orthonormal basis of $T M$. Now, setting $\bar{\psi}=\psi^{+}-\psi^{-}$and since $\omega \cdot \psi=-i \bar{\psi}$ (recall that $i \omega$ acts as the identity on $\Sigma^{+} M$ and as -identity on $\Sigma^{-} M$ ), we get

which is also the spinor characterization given by Morel in [14].

5.4.2. Surfaces in the 3-dimensional metric Lie groups $E(\kappa, \tau), \tau \neq 0$. We recover here a spinor characterization of immersions in the 3-dimensional homogeneous spaces $E(\kappa, \tau)$; this result was obtained by one of the authors in [16], using a characterization of immersions in these spaces by Daniel [5]. We give here an independent proof, and rather obtain the result of Daniel as a corollary.

The metric Lie group $E(\kappa, \tau), \tau \neq 0$, is defined as follows: its Lie algebra is $\mathcal{G}=\mathbb{R}^{3}$, with the bracket defined on the vectors $e_{1}^{o}, e_{2}^{o}, e_{3}^{o}$ of the canonical basis by

\left[e_{1}^{o}, e_{2}^{o}\right]=2 \tau e_{3}^{o}, \quad\left[e_{2}^{o}, e_{3}^{o}\right]=\sigma e_{1}^{o}, \quad\left[e_{3}^{o}, e_{1}^{o}\right]=\sigma e_{2}^{o}
$$

where $\sigma=\frac{\kappa}{2 \tau}$. The metric on $\mathcal{G}$ is the canonical metric, ie the metric such that the basis $\left(e_{1}^{o}, e_{2}^{o}, e_{3}^{o}\right)$ is orthonormal. The Levi-Civita connection is then given by

for $X, Y \in \mathcal{G}$; see e.g. [5].
Let $S: T M \rightarrow T M$ be a symmetric operator. We assume that a vector field $T \in \Gamma(T M)$ and a function $f \in C^{\infty}(M, \mathbb{R})$ are given such that

(2) There exists an isometric immersion of $M$ into $E(\kappa, \tau)$, with shape operator $S$.

Proof. We consider the trivial line bundle $E=\mathbb{R} \nu$, where $\nu$ is a unit section. The bundle $T M \oplus E$ is of rank 3 , and is assumed to be oriented by the orientation of $T M$ and by $\nu$. We suppose that it is endowed with the natural product metric. Let us denote by $\times$ the natural cross product in the fibers. We set

e_{3}=T+f \nu
$$

and, for all $X, Y \in T M \oplus E$,

$$
\begin{equation*}
\Gamma(X)(Y)=\left\{\tau\left(X-\left\langle X, e_{3}\right\rangle e_{3}\right)+(\sigma-\tau)\left\langle X, e_{3}\right\rangle e_{3}\right\} \times Y \tag{59}
\end{equation*}
$$

Defining $B: T M \times T M \rightarrow E$ and its adjoint $B^{*}: T M \times E \rightarrow T M$ by
(60) $B(X, Y)=\langle S(X), Y\rangle \nu \quad$ and $\quad B^{*}(X, \nu)=S(X)$
for all $X, Y \in T M$, the equations (56) and (57) are equivalent to the single equation

$$
\begin{equation*}
\nabla_{X} e_{3}=\Gamma(X)\left(e_{3}\right)-B\left(X, e_{3}^{T}\right)+B^{*}\left(X, e_{3}^{N}\right) \tag{61}
\end{equation*}
$$

for all $X \in T M$, where $\nabla$ is the sum of the Levi-Civita connection on $T M$ and the trivial connection on $E$. This is (18) for $Z=e_{3}$. We will need the following expression for $\Gamma$ :
lemma Gamma Ek t Lemma 5.3. For all $X \in T M$, the linear map $\Gamma(X): T M \oplus E \rightarrow T M \oplus E$ is represented by the bivector

$$
\Gamma(X)=\{(2 \tau-\sigma)\langle X, T\rangle(T \cdot \nu-f)-\tau X \cdot \nu\} \cdot \omega
$$

Proof. The linear map $\Gamma(X)$ defined by (59) is represented by the bivector

$$
\Gamma(X)=\frac{1}{2}\left(e_{1} \cdot \Gamma(X)\left(e_{1}\right)+e_{2} \cdot \Gamma(X)\left(e_{2}\right)+e_{3} \cdot \Gamma(X)\left(e_{3}\right)\right)
$$

where $e_{1}, e_{2}$ are such that $e_{1}, e_{2}, e_{3}$ is a positively oriented and orthonormal basis of $T M \oplus E$ (see Lemma A.1); thus, a straightforward computation shows that $\Gamma(X)$ is represented by the bivector

$$
\begin{equation*}
\Gamma(X)=-\tau\left(X \times e_{3}\right) \cdot e_{3}+(\sigma-\tau)\left\langle X, e_{3}\right\rangle e_{1} \cdot e_{2} \tag{62}
\end{equation*}
$$

The following formula may be checked by a direct computation: for $X, Y \in T M \oplus E$,

$$
X \times Y=-(X \cdot Y+\langle X, Y\rangle) e_{1} \cdot e_{2} \cdot e_{3}
$$

this gives

$$
\begin{aligned}
\left(X \times e_{3}\right) \cdot e_{3} & =-\left(X \cdot e_{3}+\left\langle X, e_{3}\right\rangle\right) e_{1} \cdot e_{2} \cdot e_{3} \cdot e_{3} \\
& =\left(X-\left\langle X, e_{3}\right\rangle e_{3}\right) e_{1} \cdot e_{2} \cdot e_{3} \\
& =(X-\langle X, T\rangle(T+f \nu)) \cdot \omega \cdot \nu \\
& =(X \cdot \nu-\langle X, T\rangle(T \cdot \nu-f)) \cdot \omega
\end{aligned}
$$

Moreover,

$$
\begin{aligned}
\left\langle X, e_{3}\right\rangle e_{1} \cdot e_{2} & =\langle X, T\rangle\left(-e_{1} \cdot e_{2} \cdot e_{3} \cdot e_{3}\right) \\
& =\langle X, T\rangle(-\omega \cdot \nu \cdot(T+f \nu)) \\
& =-\langle X, T\rangle(T \cdot \nu-f) \cdot \omega
\end{aligned}
$$

Plugging these two formulas in (62) we get the result.
We deduce the following key lemma:
Lemma 5.4. A spinor field $\varphi \in \Gamma(U \Sigma)$ solution of (22) is equivalent to a spinor field $\psi \in \Gamma(\Sigma M)$ solution of (58).

Proof. We use the identification $\psi \in \Gamma(\Sigma M) \mapsto \psi^{*} \in \Gamma(\Sigma)$ described at the beginning of the section; we recall that, for all $X \in T M$,

$$
\begin{equation*}
\left(\nabla_{X} \psi\right)^{*}=\nabla_{X}\left(\psi^{*}\right) \quad \text { and } \quad(X \cdot \psi)^{*}=X \cdot \nu \cdot\left(\psi^{*}\right) \tag{63}
\end{equation*}
$$

Thus, if $\varphi \in \Gamma(U \Sigma)$ is a solution of (22) and if $\psi \in \Gamma(\Sigma M)$ is such that $\psi^{*}=\varphi$, using (63), the formula

$$
\sum_{j=1}^{p} e_{j} \cdot B\left(X, e_{j}\right)=\sum_{j=1}^{p} e_{j} \cdot\left\langle S(X), e_{j}\right\rangle \nu=S(X) \cdot \nu
$$

and Lemma 5.3, we get:

$$
\begin{aligned}
\left(\nabla_{X} \psi\right)^{*} & =\nabla_{X} \varphi \\
& =-\frac{1}{2} S(X) \cdot \nu \cdot \varphi+\frac{1}{2}\{(2 \tau-\sigma)\langle X, T\rangle(T \cdot \nu-f)-\tau X \cdot \nu\} \cdot \omega \cdot \varphi \\
& =\left(-\frac{1}{2} S(X) \cdot \psi+\frac{1}{2}\{(2 \tau-\sigma)\langle X, T\rangle(T-f)-\tau X\} \cdot \omega \cdot \psi\right)^{*}
\end{aligned}
$$

This gives (58). Reciprocally, if $\psi$ is a solution of (58), the spinor field $\varphi=\psi^{*}$ solves (22). This proves the lemma.

Instead of $\psi \in \Gamma(\Sigma M)$ solution of (58) we may thus consider $\varphi \in \Gamma(U \Sigma)$ solution of (22). The theorem will thus be a consequence of Theorem 1 if we can define a bundle isomorphism $f: T M \oplus E \rightarrow M \times \mathcal{G}$ such that (17) and (18) hold. Let us set

$$
f(Z)=\langle\langle Z \cdot \varphi, \varphi\rangle\rangle .
$$

We first observe that $f\left(e_{3}\right)$ is constant: indeed, for all $X \in T M$,

$$
\partial_{X}\left(f\left(e_{3}\right)\right)=\left\langle\left\langle\nabla_{X} e_{3} \cdot \varphi, \varphi\right\rangle\right\rangle+(i d+\tau)\left\langle\left\langle e_{3} \cdot \nabla_{X} \varphi, \varphi\right\rangle\right\rangle=0
$$

in view of (61), (22) and identities (26)-(27) in Lemma 3.2. Moreover, since $f$ preserves the norm of the vectors, $f\left(e_{3}\right)$ is a unit vector. Replacing $\varphi$ by $\varphi \cdot a$ for some $a \in \operatorname{Spin}(\mathcal{G})$ if necessary, we may thus assume that $f\left(e_{3}\right)=e_{3}^{o}$. We now check (17): since the map $f$ is an orientation preserving isometry and using $f\left(e_{3}\right)=e_{3}^{o}$, we have, for all $X, Y \in T M$,

$$
\begin{aligned}
f(\Gamma(X)(Y)) & =f\left(\left\{\tau\left(X-\left\langle X, e_{3}\right\rangle e_{3}\right)+(\sigma-\tau)\left\langle X, e_{3}\right\rangle e_{3}\right\} \times Y\right) \\
& =\left\{\tau\left(f(X)-\left\langle f(X), f\left(e_{3}\right)\right\rangle f\left(e_{3}\right)\right)+(\sigma-\tau)\left\langle f(X), f\left(e_{3}\right)\right\rangle f\left(e_{3}\right)\right\} \times f(Y) \\
& =\left\{\tau\left(f(X)-\left\langle f(X), e_{3}^{o}\right\rangle e_{3}^{o}\right)+(\sigma-\tau)\left\langle f(X), e_{3}^{o}\right\rangle e_{3}^{o}\right\} \times f(Y) \\
& =\Gamma(f(X))(f(Y))
\end{aligned}
$$

Finally, the proof of (18) is very similar to the proof of this identity made in Section 5.1 for $G=\mathbb{R}^{n}$ : we only have to add the term involving $\Gamma$ which appears in the expression (22) of the covariant derivative of $\varphi$; we leave the details to the reader.

Remark 9. We also get an explicit representation formula: the immersion is given by the Darboux integral of $\xi: X \mapsto\langle\langle X \cdot \varphi, \varphi\rangle\rangle$, which may be written in terms of $\psi$ by the formula (53).

We deduce the following result, first obtained by Daniel in [5] using the moving frame method:

Corollary 2. If $S, T, f, \kappa y \tau$ satisfy (55)-(57), the Gauss equation

$$
\begin{equation*}
K=\operatorname{det} S+\tau^{2}+\left(\kappa-4 \tau^{2}\right) f^{2} \tag{64}
\end{equation*}
$$

and the Codazzi equation
Codazzi equation Ek t

$$
\begin{equation*}
\nabla_{X}(S Y)-\nabla_{Y}(S X)-S([X, Y])=\left(\kappa-4 \tau^{2}\right) f(\langle Y, T\rangle X-\langle X, T\rangle Y) \tag{65}
\end{equation*}
$$

then there exists an isometric immersion of $M$ into $E(\kappa, \tau)$ with shape operator $S$. Moreover the immersion is unique up to a global isometry of $E(\kappa, \tau)$ preserving the orientations.

Proof. The equations (64) and (65) are equivalent to the Gauss and Codazzi equations (32) and (34) where $B$ is defined by (60).

5.4.3. The last 3-dimensional riemannian homogeneous space: the metric Lie group $S_{o l}{ }_{3}$. We describe here the special case of a surface in $S_{3} l_{3}$ : this achieves the spinor representation of immersions of surfaces into 3-dimensional riemannian homogeneous spaces [16].

Let us recall that $\mathrm{Sol}_{3}$ is the only metric Lie group whose isometry group is 3-dimensional. It is defined as follows: its Lie algebra is $\mathcal{G}=\mathbb{R}^{3}$, with the bracket defined on the canonical basis $\left(e_{1}^{o}, e_{2}^{o}, e_{3}^{o}\right)$ by

$$
\left[e_{1}^{o}, e_{2}^{o}\right]=0, \quad\left[e_{2}^{o}, e_{3}^{o}\right]=-e_{2}^{o}, \quad\left[e_{3}^{o}, e_{1}^{o}\right]=-e_{1}^{o}
$$

The metric on $\mathcal{G}$ is the canonical metric, i.e., the metric such that the basis $\left(e_{1}^{o}, e_{2}^{o}, e_{3}^{o}\right)$ is orthonormal. By the Koszul formula, the Levi-Civita connection is then such that

$$
\begin{equation*}
\Gamma_{11}^{3}=-\Gamma_{13}^{1}=-1, \quad \Gamma_{22}^{3}=-\Gamma_{23}^{2}=1 \tag{66}
\end{equation*}
$$

and $\Gamma_{i j}^{k}=0$ for the other indices.
Let us consider an oriented riemannian surface $M$, and a symmetric operator $S: T M \rightarrow T M$. We suppose that there exist tangent vectors fields $T_{i} \in \Gamma(T M)$ and functions $f_{i} \in C^{\infty}(M)$ for $1 \leqslant i \leqslant 3$ satisfying

$$
\begin{equation*}
\left\langle T_{i}, T_{j}\right\rangle+f_{i} f_{j}=\delta_{i}^{j} \tag{67}
\end{equation*}
$$

for all $1 \leq i, j \leq 3$, and, for all $X \in T M$,

$$
\begin{align*}
\nabla_{X} T_{i} & =(-1)^{i}\left\langle X, T_{i}\right\rangle T_{3}+f_{i} S(X)  \tag{68}\\
d f_{i}(X) & =(-1)^{i}\left\langle X, T_{i}\right\rangle f_{3}-\left\langle S X, T_{i}\right\rangle
\end{align*}
$$

for $1 \leqslant i \leqslant 2$,

$$
\begin{gather*}
\nabla_{X} T_{3}=\sum_{j=1}^{2}(-1)^{j+1}\left\langle X, T_{j}\right\rangle T_{j}+f_{3} S(X)  \tag{69}\\
d f_{3}(X)=\sum_{j=1}^{2}(-1)^{j+1}\left\langle X, T_{j}\right\rangle f_{j}-\left\langle S(X), T_{3}\right\rangle
\end{gather*}
$$

The equations (68) and (69) are the equations (20) and (21) in Remark 2, with the coefficients $\Gamma_{i j}^{k}$ given by (66). According to (51) together with the simplification in Lemma 5.2, we set

$$
\begin{equation*}
\tilde{\Gamma}(X)=-\left\{\left\langle X, T_{1}\right\rangle\left(T_{2}-f_{2}\right)+\left\langle X, T_{2}\right\rangle\left(T_{1}-f_{1}\right)\right\} \cdot \omega \tag{70}
\end{equation*}
$$

for all $X \in T M$. Theorem 4 then yields the following result:
Theorem 6. If $M$ is simply connected, the following two statements are equivalent:
(1) there exists an isometric immersion of $M$ into $S_{3} l_{3}$ with shape operator $S$;
(2) there exists $\psi \in \Gamma(\Sigma M)$ such that $|\psi|=1$ and

$$
\begin{equation*}
\nabla_{X} \psi=-\frac{1}{2} S(X) \cdot \psi+\frac{1}{2} \tilde{\Gamma}(X) \cdot \psi \tag{71}
\end{equation*}
$$

for all $X \in T M$.
Remark 10. This theorem implies the result of Lodovici [10] concerning isometric immersions in Sol $_{3}$ : by the considerations in Section 4, the equation (71) is solvable if and only if the equations of Gauss and Codazzi hold. Compléter ?

## Appendix A. Skew-symmetric operators and bivectors

We consider $\mathbb{R}^{n}$ endowed with its canonical scalar product. A skew-symmetric operator $u: \mathbb{R}^{n} \rightarrow \mathbb{R}^{n}$ naturally identifies to a bivector $\underline{u} \in \Lambda^{2} \mathbb{R}^{n}$, which may in turn be regarded as belonging to the Clifford algebra $C l_{n}(\mathbb{R})$. We precise here the relations between the Clifford product in $C l_{n}(\mathbb{R})$ and the composition of endomorphisms. If $a$ and $b$ belong to the Clifford algebra $C l_{n}(\mathbb{R})$, we set

$$
[a, b]=\frac{1}{2}(a \cdot b-b \cdot a),
$$

where the dot • is the Clifford product. We denote by $\left(e_{1}, \ldots, e_{n}\right)$ the canonical basis of $\mathbb{R}^{n}$.
lem1 ap1 Lemma A.1. Let $u: \mathbb{R}^{n} \rightarrow \mathbb{R}^{n}$ be a skew-symmetric operator. Then the bivector

$$
\begin{equation*}
\underline{u}=\frac{1}{2} \sum_{j=1}^{n} e_{j} \cdot u\left(e_{j}\right) \quad \in \Lambda^{2} \mathbb{R}^{n} \subset C l_{n}(\mathbb{R}) \tag{72}
\end{equation*}
$$

represents $u$, and, for all $\xi \in \mathbb{R}^{n}$,

$$
[\underline{u}, \xi]=u(\xi)
$$

In the paper, and for sake of simplicity, we will use the same letter $u$ to denote $\underline{u}$. Proof. For $i<j$, we consider the linear map

$$
u: \quad e_{i} \mapsto e_{j}, \quad e_{j} \mapsto-e_{i}, \quad e_{k} \mapsto 0 \quad \text { if } \quad k \neq i, j
$$

it is skew-symmetric and corresponds to the bivector $e_{i} \wedge e_{j} \in \Lambda^{2} \mathbb{R}^{n}$; it is thus naturally represented by $\underline{u}=e_{i} \cdot e_{j}=\frac{1}{2}\left(e_{i} \cdot e_{j}-e_{j} \cdot e_{i}\right)$, which is (72). We then compute, for $k=1, \ldots, n$,

$$
\left[\underline{u}, e_{k}\right]=\frac{1}{2}\left(e_{i} \cdot e_{j} \cdot e_{k}-e_{k} \cdot e_{i} \cdot e_{j}\right)
$$

and easily get

$$
\left[\underline{u}, e_{k}\right]=e_{j} \quad \text { if } \quad k=i, \quad-e_{i} \quad \text { if } \quad k=j, \quad 0 \quad \text { if } \quad k \neq i, j .
$$

The result follows by linearity.
lem2 ap1 Lemma A.2. Let $u: \mathbb{R}^{n} \rightarrow \mathbb{R}^{n}$ and $v: \mathbb{R}^{n} \rightarrow \mathbb{R}^{n}$ be two skew-symmetric operators, represented in $C l_{n}(\mathbb{R})$ by

u=\frac{1}{2} \sum_{j=1}^{n} e_{j} \cdot u\left(e_{j}\right) \quad \text { and } \quad v=\frac{1}{2} \sum_{j=1}^{n} e_{j} \cdot v\left(e_{j}\right)

respectively. Then $[u, v] \in \Lambda^{2} \mathbb{R}^{n} \subset C l_{n}(\mathbb{R})$ represents $u \circ v-v \circ u$.
Proof. For $\xi \in \mathbb{R}^{n}$, the Jacobi equation yields

[[u, v], \xi]=[u,[v, \xi]]-[v,[u, \xi]] .
$$

Thus, using Lemma A. 1 repeatedly, $[u, v]$ represents the map

\begin{aligned}
\xi \mapsto[[u, v], \xi] & =[u,[v, \xi]]-[v,[u, \xi]] \\
& =[u, v(\xi)]-[v, u(\xi)] \\
& =(u \circ v-v \circ u)(\xi),
\end{aligned}
$$

and the result follows.
We now assume that $\mathbb{R}^{n}=\mathbb{R}^{p} \oplus \mathbb{R}^{q}, p+q=n$.
lem3 ap1 Lemma A.3. Let us consider a linear map $u: \mathbb{R}^{p} \rightarrow \mathbb{R}^{q}$ and its adjoint $u^{*}: \mathbb{R}^{q} \rightarrow$ $\mathbb{R}^{p}$. Then the bivector

\underline{u}=\sum_{j=1}^{p} e_{j} \cdot u\left(e_{j}\right) \quad \in \Lambda^{2} \mathbb{R}^{n} \subset C l_{n}(\mathbb{R})
$$

represents

$$
\left(\begin{array}{cc}
0 & -u^{*} \\
u & 0
\end{array}\right): \quad \mathbb{R}^{p} \oplus \mathbb{R}^{q} \rightarrow \mathbb{R}^{p} \oplus \mathbb{R}^{q}
$$

we have
biv u u*

$$
\begin{equation*}
\underline{u}=\frac{1}{2}\left(\sum_{j=1}^{p} e_{j} \cdot u\left(e_{j}\right)+\sum_{j=p+1}^{n} e_{j} \cdot\left(-u^{*}\left(e_{j}\right)\right)\right) \tag{73}
\end{equation*}
$$

and, for all $\xi=\xi_{p}+\xi_{q} \in \mathbb{R}^{n}$,

$$
[\underline{u}, \xi]=u\left(\xi_{p}\right)-u^{*}\left(\xi_{q}\right)
$$

As above, we will simply denote $\underline{u}$ by $u$.
Proof. In view of Lemma A.1, $\underline{u}$ represents the linear map $\xi \mapsto[\underline{u}, \xi]$. We compute, for $\xi \in \mathbb{R}^{p}$,

\begin{aligned}
{[\underline{u}, \xi] } & =\frac{1}{2}\left(\sum_{j=1}^{p} e_{j} \cdot u\left(e_{j}\right) \cdot \xi-\xi \cdot \sum_{j=1}^{p} e_{j} \cdot u\left(e_{j}\right)\right) \\
& =-\frac{1}{2} \sum_{j=1}^{p}\left(e_{j} \cdot \xi+\xi \cdot e_{j}\right) \cdot u\left(e_{j}\right) \\
& =\sum_{j=1}^{p}\left\langle\xi, e_{j}\right\rangle u\left(e_{j}\right) \\
& =u(\xi)
\end{aligned}
$$

and, for $\xi \in \mathbb{R}^{q}$,

$$
\begin{aligned}
{[\underline{u}, \xi] } & =\frac{1}{2}\left(\sum_{j=1}^{p} e_{j} \cdot u\left(e_{j}\right) \cdot \xi-\xi \cdot \sum_{j=1}^{p} e_{j} \cdot u\left(e_{j}\right)\right) \\
& =\frac{1}{2} \sum_{j=1}^{p} e_{j} \cdot\left(u\left(e_{j}\right) \cdot \xi+\xi \cdot u\left(e_{j}\right)\right) \\
& =-\sum_{j=1}^{p} e_{j}\left\langle u\left(e_{j}\right), \xi\right\rangle \\
& =-\sum_{j=1}^{p} e_{j}\left\langle e_{j}, u^{*}(\xi)\right\rangle \\
& =-u^{*}(\xi)
\end{aligned}
$$

Finally,

$$
\begin{aligned}
\underline{u} & =\sum_{j=1}^{p} e_{j} \cdot u\left(e_{j}\right) \\
& =\frac{1}{2}\left(\sum_{j=1}^{p} e_{j} \cdot u\left(e_{j}\right)+\sum_{j=1}^{p}-u\left(e_{j}\right) \cdot e_{j}\right)
\end{aligned}
$$

with

$$
\begin{aligned}
\sum_{j=1}^{p}-u\left(e_{j}\right) \cdot e_{j} & =-\sum_{i=p+1}^{p+q} \sum_{j=1}^{p}\left\langle u\left(e_{j}\right), e_{i}\right\rangle e_{i} \cdot e_{j} \\
& =\sum_{i=p+1}^{p+q} e_{i} \cdot\left(-\sum_{j=1}^{p}\left\langle e_{j}, u^{*}\left(e_{i}\right)\right\rangle e_{j}\right) \\
& =\sum_{i=p+1}^{p+q} e_{i} \cdot\left(-u^{*}\left(e_{i}\right)\right)
\end{aligned}
$$

which gives (73).
lem4 ap1 Lemma A.4. Let us consider two linear maps $u: \mathbb{R}^{p} \rightarrow \mathbb{R}^{q}$ and $v: \mathbb{R}^{n} \rightarrow \mathbb{R}^{n}$, with $v$ skew-symmetric, and the associated bivectors

$$
u=\sum_{j=1}^{p} e_{j} \cdot u\left(e_{j}\right), \quad v=\frac{1}{2} \sum_{j=1}^{n} e_{j} \cdot v\left(e_{j}\right)
$$

Then $[u, v] \in \Lambda^{2} \mathbb{R}^{n}$ represents the map

\xi=\xi_{p}+\xi_{q} \mapsto-u^{*}\left(v(\xi)_{q}\right)+v\left(u^{*}\left(\xi_{q}\right)\right)+u\left(v(\xi)_{p}\right)-v\left(u\left(\xi_{p}\right)\right)
$$

where the sub-indices $p$ and $q$ mean that we take the components of the vectors in $\mathbb{R}^{p}$ and $\mathbb{R}^{q}$ respectively. In view of Lemma A.1, this may also be written in the form

[[u, v], \xi]=-u^{*}\left(v(\xi)_{q}\right)+v\left(u^{*}\left(\xi_{q}\right)\right)+u\left(v(\xi)_{p}\right)-v\left(u\left(\xi_{p}\right)\right)
$$

for all $\xi \in \mathbb{R}^{n}$.
Proof. From Lemmas A. 2 and A.3, the bivector $[u, v] \in \Lambda^{2} \mathbb{R}^{n}$ represents

\left(\begin{array}{cc}
0 & -u^{*} \\
u & 0
\end{array}\right) \circ v-v \circ\left(\begin{array}{cc}
0 & -u^{*} \\
u & 0
\end{array}\right)
$$

that is the map

$$
\begin{aligned}
\xi \mapsto & \left(\begin{array}{cc}
0 & -u^{*} \\
u & 0
\end{array}\right)\binom{v(\xi)_{p}}{v(\xi)_{q}}-v\left(\begin{array}{cc}
0 & -u^{*} \\
u & 0
\end{array}\right)\binom{\xi_{p}}{\xi_{q}} \\
& =\binom{-u^{*}\left(v(\xi)_{q}\right)+v\left(u^{*}\left(\xi_{q}\right)\right)}{u\left(v(\xi)_{p}\right)-v\left(u\left(\xi_{p}\right)\right)},
\end{aligned}
$$

which gives the result.
