A novel technique of particle identification with bolometric detectors

Abstract

We report in this paper the proofs that the pulse shape analysis can be used in some bolometers to identify the nature of the interacting particle. Indeed, while detailed analyses of the signal time development in purely thermal detectors have not produced so far interesting results, similar analyses on bolometers built with scintillating crystals seem to show that it is possible to distinguish between an electron or γ -ray and an α particle interaction. This information can be used to eliminate background events from the recorded data in many rare process studies, especially Neutrinoless Double Beta decay search. Results of pulse shape analysis of signals from a number of bolometers with absorbers of different composition (CaMoO₄, ZnMoO₄, MgMoO₄ and ZnSe) are presented and the pulse shape discrimination capability of such detectors is discussed.

1. Rare event searches

Rare event studies, such as the search for Neutrinoless Dou- 31 ble Beta decay $(\beta\beta(0\nu))$ [1] or the identification of Weakly In- 32 2 teracting Massive Particle (WIMP) interactions with ordinary 33 3 matter [2], are of extreme interest in astroparticle physics, since 34 4 they would imply new physics beyond the Standard Model. In 35 5 both cases, as in all the rare event studies, spurious events are 36 6 a limiting factor to the reachable sensitivity of the experiment. 7 Unfortunately natural radioactive background is often present 8 in the detector itself or in the materials surrounding it, no mat-9 ter how much one can try to reduce it with shieldings, selection 38 10 of materials and complicated purification techniques. In order 39 11 to handle the residual unavoidable background, all the envis- 40 12 aged approaches require both a good energy resolution (which 41 13 always helps in the comprehension of the different structures 42 14 of an energy spectrum) and the capability to identify the nature 43 15 of the projectile that interacted with the detector. Indeed, the 44 16 searched event has always well defined signatures helping to 45 17 distinguish it from background, for instance two electrons with 46 18 a fixed sum energy in the case of the $\beta\beta(0\nu)$. 19

Bolometers [3] are based on the detection of phonons pro- 47 20 duced after an energy release by an interacting particle and can 21 have both an excellent energy resolution and extremely low en-48 22 ergy threshold with respect to conventional detectors. They can 49 23 be fabricated from a wide variety of materials, provided they 50 24 have a low enough heat capacity at low temperatures, which ⁵¹ 25 is the only requirement really unavoidable to build a working 26 bolometer. The latter is a priceless feature for experiments that 27 aim at detectors containing particular atomic or nuclear species 28

to optimize the detection efficiency. If other excitations (such as ionization charge carriers or scintillation photons) are collected in addition to phonons, bolometers have already shown to be able to discriminate nuclear recoils from electron recoils, or α particles from β particles and γ -rays. In this paper we will report on the possibility to obtain similar results just by pulse shape analysis, without the requirement of a double readout for phonons and ionization or scintillation light.

2. Bolometric Technique and Scintillating Bolometers

Bolometers can be essentially sketched as a two-component object: an energy absorber in which the energy deposited by a particle is converted into phonons, and a sensor that converts thermal excitations into a readable signal. The absorber must be coupled to a constant temperature bath by means of a weak thermal conductance.

Denoting by C the heat capacity of the bolometer, the temperature variation induced by an energy release E in the absorber can be written as

$$\Delta T = \frac{E}{C} \tag{1}$$

The accumulated heat flows then to the heat sink through the thermal link and the absorber returns to the base temperature with a time constant $\tau = C/G$, where G is the thermal conductance of the link:

$$\Delta T(t) = \frac{E}{C} e^{-\frac{t}{\tau}} \tag{2}$$

In order to obtain a measurable temperature rise the heat capacity of the absorber must be very small: this is the reason why bolometers need to be operated at cryogenic temperatures (of the order of 10-100 mK).

A real bolometer is somewhat more complicated than the 57 naive description presented above. It is made of different el-58 ements and it is therefore represented by more than one heat 59 capacity and heat conductance. As such, the time development 60 of the thermal pulse is characterized by various time constants. 61 In principle, if the bolometer performs as an ideal calorime-62 ter and if the conversion of the energy into heat deposited by 63 the particle is instantaneous (as assumed in equation 2), then 64 the device is insensitive to the nature of the interacting parti-65 cle. Although this situation is generally very far from reality, it 66 is however true that the small differences are difficult to detect 67 and the goal has been so far achieved only relying on compli-68 cated solutions. Among these are scintillating bolometers. 69

The concept of a scintillating bolometer is very simple: a114 70 bolometer coupled to a light detector [4]. The first must consist¹¹⁵ 71 of a scintillating absorber thermally linked to a phonon sensor₁₁₆ 72 while the latter can be any device able to measure the emitted₁₁₇ 73 photons. The driving idea of this hybrid detector is to combine₁₁₈ 74 the two available informations, the heat and the scintillation₁₁₉ 75 light, to distinguish the nature of the interacting particles, ex-120 76 ploiting the different scintillation yield of β/γ , α and neutrons.₁₂₁ 77 Dark Matter as well as $\beta\beta(0\nu)$ searches can benefit of this capa-122 78 bility of tagging the different particles, and more generally this₁₂₃ 79 technique can be exploited in any research where background₁₂₄ 80 suppression or identification is important. 125 81

Dark matter experiments look for a very rare signal gener-126 82 ally hidden in a huge background. The signal is a nuclear recoil₁₂₇ 83 with an energy of few keV (or less) induced by the scattering₁₂₈ 84 of a WIMP off a target nucleus. Experiments like CDMS [5],129 85 Edelweiss [6] or CRESST [7] clearly show that in such energy₁₃₀ 86 region the background is dominated by β/γ interactions. A sec-131 87 ond source of background are α decays, contributing through₁₃₂ 88 energy degraded α 's and nuclear recoils. The capability to dis-133 89 tinguish a nuclear recoil - candidate for a WIMP interaction -134 90 from α or β/γ clearly allows to improve drastically the experi-135 91 mental sensitivity. 92 136

A similar approach was proposed also for applications in₁₃₇ 93 $\beta\beta(0\nu)$ searches [4]. More recently, such a possibility has been₁₃₈ 94 demonstrated to be viable for a number of candidate nuclei [8].139 95 In this case the major interest is the identification of α interac-140 96 tions. Indeed the other important source of background, namely₁₄₁ 97 γ -rays, is virtually indistinguishable from the $\beta\beta(0\nu)$ signal.₁₄₂ 98 The suggested way to eliminate the problem of γ -rays con-143 99 tribution is to study isotopes with a transition energy above₁₄₄ 100 2615 keV. This corresponds in fact to the highest energy γ -ray₁₄₅ 101 line from natural radioactivity and is due to ²⁰⁸Tl. Above this₁₄₆ 102 energy there are only extremely rare high energy γ 's from ²¹⁴Bi 103 (all the $\beta\beta$ active isotopes with $Q_{\beta\beta} > 2615$ keV are listed in₁₄₇ 104 Tab. 1). Once γ -rays are no more a worrisome source of back-₁₄₈ 105 ground, what is left - on the side of radioactivity- are α emis-106 sions. Indeed α surface contaminations not only can represent 149 107 the dominant background source for $\beta\beta(0\nu)$ searches based on 150 108 high transition energy isotopes, but they are already recognized₁₅₁ 109 as the most relevant background source in the bolometric ex-152 110 periment CUORICINO [9, 10, 11] and as a limiting factor for 153 111 the experiment CUORE [10, 12]. Both the experiments search₁₅₄ 112 for the $\beta\beta(0\nu)$ of ¹³⁰Te whose transition energy is at 2527 keV,¹⁵⁵ 113

therefore in a region where γ background (mainly due to Compton events produced by 2615 keV photons) can be still important.

The α contribution to the background in the $\beta\beta(0\nu)$ region (i.e. at about 3 MeV) is the following. In the natural chains we have various nuclei that decay emitting an α particle with an energy between 4 and 8 MeV, their energy is quite higher than most $\beta\beta(0\nu)$ Q-values. However, if the radioactive nucleus is located at a depth of a few μ m inside a material facing the detector, the α particle looses a fraction of its energy before reaching the detector and its energy spectrum looks as a continuum between 0 and 4-8 MeV [13]. A similar mechanism holds in the case of surface contaminations on the bolometer.

This radioactive source plays a role in almost all detectors but it turns out to be particularly dangerous for fully active detectors, as in the case of bolometers. It can be efficiently identified and removed with active background suppression technique such as that conceived with scintillating bolometers.

The development of a hybrid detector, able to discriminate α particles and optimized for $\beta\beta(0\nu)$ searches, was the main purpose of our studies on scintillating bolometers. We tested several devices, differing mainly in the scintillating crystal material and size, to study their thermal response, light yield and radio purity. The results obtained so far are reported in [14, 15, 16, 17]. On our way, we discovered an extremely interesting feature of some of the tested crystals: the different pulse shape of the thermal signals produced by α 's and by β/γ 's. This feature opens the possibility of realizing a bolometric experiment that can discriminate among different particles, without the need of a light detector coupled to each bolometer. In the case of a huge, multi-detector array, such as CUORE [12] and EURECA [18], the benefits of employing this technique would be impressive:

- more ease during assembly because the single element of the array would be a quite simpler device.
- fewer readout channels, with not only an evident reduction of cost and work, but also a cryogenic benefit (in a cryogenic experiment particular care should be devoted to reduce any thermal link between room temperature and the bolometers working at few mK: the heat load of the readout channels must be taken into account and their reduction is always a good solution).

a significant cost reduction, saving money and work that²⁰⁵
 would be necessary for the light detectors procurement and²⁰⁶
 optimization.

 no need of light collectors, this would simplify the struc-²⁰⁸/₂₀₉ ture of the assembly and it would allow the use of coinci-²¹⁰/₂₁₀ dences between facing crystals to further reduce the back-²¹¹/₂₁₂ ground.

As a final remark, it is worth to be mentioned that these de-²¹³ 163 vices could be used also for the measurement of α emissions $^{^{214}}$ 164 from surfaces, when extremely low counting rates are needed.²¹⁵ 165 Indeed, due to their lack of a dead layer and their high energy²¹⁶ 166 resolution, bolometers have an extraordinary sensitivity to low²¹⁷ 167 range particles like α 's. However, a conventional bolometer²¹⁸ 168 cannot distinguish the nature of the interacting particle. It pro-²¹⁹ 169 vides therefore only a limited diagnostic power (especially for²²⁰ 170 α particles with energies lower than 2615 keV where the β/γ^{221} 171 induced background dominates the detector counting rate). On 222 172 the other hand, a scintillating bolometer has to be surrounded²²³ 173 by a reflector to properly collect the scintillation light (therefore²²⁴ 174 cannot be faced to a sample whose radioactive emission has to $_{225}$ 175 be identified). The devices here discussed overcome these two 176 difficulties. Traditionally the devices used in this field are Si²²⁶ 177 surface barrier detectors. For low counting rates, large area low²²⁷ 178 background detectors are needed. Today Si surface barriers de-228 179 tectors with an active area of about 10 cm², a typical energy²²⁹ 180 resolution of about 25-30 keV FWHM, and counting rates of²³⁰ 181 the order 0.05 count/h/cm² between 3 and 8 MeV are available²³¹ 182 [19]. A bolometer like those here discussed can easily reach a^{232} 183 much larger active area, has a typical energy resolution of 10²³³ 184 keV and a background counting rate in the 3-8 MeV region that²³⁴ 185 can be as low as 0.001 count/h/cm². Thanks to the particle iden-²³⁵ 186 tification technique discussed in this paper, it can distinguish an²³⁶ 187 α emission from a β/γ one¹ and finally can reject the β/γ back-²³⁷ 188 ground extending its measurement field to energies by far lower²³⁸ 189 239 than 3 MeV. 190

In the following section we report the results obtained with the pulse shape analysis on some of the tested crystals.

193 3. Detectors, set-up and data analysis

The results discussed in this paper have been obtained operat-194 ing different scintillating bolometers in an Oxford 200 ³He/⁴He₂₄₇ 195 dilution refrigerator located deep underground, in the National 196 Laboratory of Gran Sasso (L'Aquila, Italy). The rock overbur-197 den (average depth ~3650 m.w.e. [20]) ensures a strong sup-250 198 pression of cosmic rays that in our case is mandatory to be $able_{251}$ 199 to operate the detectors without an overwhelming pile-up. A_{252} 200 detailed description of the experimental setup can be found in 201 [21]. In order to study the pulse shape characteristics of dif-253 202 ferent materials (in particular those of interest for $\beta\beta(0\nu)$), we 203 operated a number of scintillating bolometers differing for size, 255 204

geometry and, of course, the absorbing material. As light detector we have used a second bolometer able to absorb scintillation photons converting their energy into heat. This was realised using as absorber Ge wafers of about 5 g, covered - on the side facing the scintillating crystal - with a 600 Å thick layer of SiO₂ in order to increase the light absorption. In this way they provided measurable thermal signals over an extremely large band of scintillation wavelengths.

Both the scintillating crystal and the Ge wafer were equipped with a Neutron Transmutation Doped Ge thermistor (NTD) [22], glued on the crystal surface and used as a thermometer to measure the heat or light signal produced by particles traversing the scintillating crystal.

A silicon resistance, glued on the crystals, was used to produce a calibrated heat pulse in order to monitor the thermal gain of the bolometer. This is indeed subject to variation upon temperature drifts of the cryostat that can spoil the energy resolution. In most cases this temperature drift could be re-corrected off-line on the basis of the measured thermal gain variation [23, 24].

3.1. Read-out and DAQ

The read-out [25] of the thermistor was performed via a preamplifier stage, a second stage of amplification and an antialiasing filter (a 6 pole roll-off active Bessel filter 120 db/decade [26]) located in a small Faraday cage. The ADC was a NI USB-6225 device (16 bit 40 differential input channels). For each triggered signal the entire waveform (raw-pulse) is sampled, digitized and acquired for the off-line analysis. Since all the relevant parameters (including the amplitude) of the triggered signals are evaluated off-line, a particular care has to be dedicated to the optimization of the signal filtering and digitization. In the case of the scintillating bolometer the large heat capacity of the absorber, coupled to the finite conductance of the crystal-glue-thermistor interface results in quite slow signals, characterised by a rise-time of the order of few ms² and a decay-time of hundreds of ms (determined by the crystal heat capacity and by its thermal conductance toward the heat sink). Consequently the sampling rate typically used for the signal is 1-4 kHz, over a time window of 200-2000 ms. The Bessel filter acts mainly as antialising, to avoid spurious contributions in the sampled signal. Generally it is preferred to fix its cutoff frequency at the lowest value that does not deteriorate the signal to noise ratio (i.e. to obtain the best results in terms of energy resolution). This results to be a frequency of the order of 10 Hz, which is by far lower than what needed for antialiasing purposes. In the studies here presented the Bessel cut-off frequency was fixed at 120 Hz in order to exploit the maximum available information in the signal bandwidth.

3.2. Analysis techniques

Off-line analysis aims at determining the pulse amplitude and energy together with several pulse shape parameters associated

with each raw-pulse waveform recorded by the data acquisition³¹⁰
 system. Starting from these quantities the physical informations³¹¹
 that are relevant for the scientific goals can be extracted.

The first step of the analysis consists in the correct evalua-313 259 tion of the pulse amplitude. Since thermal pulses are super-314 260 imposed to stochastic noise, a simple maximum-minimum al-315 261 gorithm would not give the better achievable resolution. We316 262 therefore use the Optimum Filter (OF) approach [27]. This al-317 263 gorithm has proven to provide the best estimate of the pulse318 264 amplitude and, as a consequence, the best energy resolution.³¹⁹ 265 The basic concept is to build a filter that, when applied to the₃₂₀ 266 raw-pulse, produces - as output - a pulse with the best signal to321 267 noise ratio. The filtered pulse is then used to evaluate the signal₃₂₂ 268 amplitude. It can be proven that in the frequency domain the₃₂₃ 269 OF transfer function H(ω) is given by 324 270

$$H(\omega) = K \frac{S^*(\omega)}{N(\omega)} e^{-j\omega t_M}$$

where $S(\omega)$ is the Fourier transform of the ideal thermal sig-³²⁹ nal (reference pulse in the absence of noise), $N(\omega)$ is the noise₃₃₀ power spectrum, t_M is the delay of the current pulse with respect₃₃₁ to the reference pulse and K is a proper normalising factor usu-³³² ally chosen in order to obtain the correct event energy.

The role of the optimum filter is to weight the frequency com-334 277 ponents of the signal in order to suppress those frequencies that 278 are more affected by noise. It can be seen from eq. 3 that, in $_{335}$ 279 order to build the filter, the shape of the reference pulse $S(\omega)$ 280 and the noise power spectrum N(ω) must be known. S(ω) is₃₃₆ 281 usually estimated by averaging a large number of recorded raw-337 282 pulses, so that the noise associated with each of them averages₃₃₈ 283 to zero. $N(\omega)$ is obtained according to the Wiener-Khintchine₃₃₉ 284 theorem by acquiring many detector baselines in absence of_{340} 285 thermal pulses and averaging the corresponding noise power₃₄₁ 286 spectra. 342 287

Once the pulse amplitude has been evaluated, gain instability₃₄₃ 288 corrections are applied to data. Due to the dependence of the₃₄₄ 289 detector response on the working temperature, the same amount₃₄₅ 290 of released energy can produce thermal pulses of different am-346 291 plitudes. Gain instabilities are corrected monitoring the time347 292 behaviour of thermal pulses of fixed energy, generated every₃₄₈ 293 few minutes across a Si heater resistor attached on the crystal₃₄₉ 294 absorber [23, 24]. Finally the amplitude to energy conversion₃₅₀ 295 (calibration) is determined by measuring the pulse amplitudes₃₅₁ 296 corresponding to fixed calibration lines. In the measurements352 297 here reported the signal of the scintillating bolometer (we will₃₅₃ 298 refer to this signal as to the heat or thermal signal) has been cal-354 299 ibrated on the basis of the full energy peaks visible in the spec-355 300 trum collected when the detector was exposed to an (external to₃₅₆ 301 the cryostat) ²³²Th source. These peaks have a nominal energy₃₅₇ 302 of: 511, 583, 911, 968 and 2615 keV. Below 511 keV and above358 303 2615 keV the energy calibration is extrapolated. However, the359 304 heat response for α particles is slightly different from the β/γ_{360} 305 response in scintillating bolometers [14]. For the molybdates361 306 that are here reported this heat quenching factor is lower than₃₆₂ 307 few percent while for ZnSe it is a little bit higher, about 10 per-363 308 cent for ~6 MeV alpha particles [16]. This miscalibration of₃₆₄ 309

the α band however does not imply an appreciable change in the discrimination confidence level described below.

In the case of the light signal the energy calibration is not needed and we therefore present its value in arbitrary units.

Besides the amplitude, few other characteristic parameters of the pulse are computed by the off-line analysis. Some of them are: τ_{rise} and τ_{decay} , TVL and TVR. The rise-time (τ_{rise}) and the decay-time (τ_{decay}) are determined on the recorded raw-pulse as $(t_{90\%}-t_{10\%})$ and $(t_{30\%}-t_{90\%})$ respectively. TVR (Test Value Right) and TVL (Test Value Left) are computed on the optimally filtered pulse A(t). They are the root mean square differences between the current signal A(t) and the reference pulse after OF filtering $A_0(t) = H(t) \otimes S(t)$. In more detail, the filtered response function $A_0(t)$ is synchronized with the filtered signal A(t), making their maxima to coincide, then the least square differences of the two functions are evaluated on the right (TVR) and left (TVL) side of the maximum on a proper time interval which is usually chosen depending on the shape of the OF signals. Although these two parameters do not have a direct physical meaning, however they are very sensitive (even in noisy conditions) to any difference between the shape of the analyzed pulse and the response function. Consequently, they are used either to reject fake triggered signals (e.g. spikes) or to identify variations in the pulse shape with respect to the reference response function (and this will be our case).

4. Pulse shape signature in the heat pulse

A series of measurements was carried out, in which different scintillating bolometers, each coupled to a light detector (but in one case), were exposed to γ and α sources. This allowed us to study the response of our devices to different radiations. The light signal was used to identify - on the basis of the heat to light ratio - the particle producing the event under study.

As mentioned in section 3.2, for each triggered signal different pulse shape parameters are computed by the off-line analysis, generally to isolate spurious and pile-up events. In the case of scintillating bolometers, looking at the distribution of the pulse shape parameters for the heat signals, we realized that it was possible to distinguish β/γ from α events. This is clearly evident in Fig. 1 where the scatter plot of the amplitudes measured for the light and heat signals (Light vs. Heat) is compared with the scatter plot (obtained for the same events) of the linearized rise-time (see later in the text) vs. amplitude for the heat signal (τ_{rise}^{lin} vs. Heat). In this detector, α and β/γ interactions draw different distributions in both the scatter plots, definitely proving that the shape of the thermal pulse induced by an α particle is different from that of a β/γ interaction.

This behavior can be explained by the dependence of light yield on the nature of the interacting particle. The high ionization density of α particles implies that all the scintillation states along their path are occupied. This saturation effect does not occur or at least is much less for β/γ particles. Therefore, in α interactions a larger fraction of energy flow in the heat channel with respect to β/γ events. This leads not only to a different light and heat yield but also to a different time evolution of both signals. The pulse shape of the thermal signal then can be

explained by the partition of energy in the two channels with 365 different decay constants. In particular, as shown by [28, 29] the scintillation produced in molybdates by α and β/γ particles 367 presents few decay-time constants with different relative inten-368 sities. Also a strong temperature dependence of the averaged 369 decay-time of the light pulses in these same crystals was re-370 ported [30, 31]. For this reason - while at room temperature the 371 averaged decay-time of molybdate or tungstate scintillators is 372 of the order of tens of μ s (thus almost instantaneous in the heat 373 pulse timescale) - at low temperatures it increases to hundreds 374 of μ s and is therefore comparable to the typical rise-time of the 375 heat signal of our scintillating bolometers. 376

In the following sections we analyse the results obtained 377 with different crystals, each being a possible candidate for a 378 $\beta\beta(0\nu)$ experiment. We quote for each crystal the discrimina-379 tion power achieved - in the $\beta\beta(0\nu)$ region - between α and β/γ 380 particles on the basis of the light/heat ratio or simply on the ba-381 sis of the pulse shape of the heat signal. We discuss in more 382 detail the case of CaMoO₄, briefly summarizing the results ob-383 tained for other crystals. 384 398

Recently CaMoO₄ has been intensively studied, for its possi-402 386 ble application as a scintillating bolometer for $\beta\beta(0\nu)$ and Dark⁴⁰³ 387 Matter experiments [8, 34, 35]. This crystal contains two iso-404 388 topes that could undergo $\beta\beta(0\nu)$: ⁴⁸Ca (Q_{\beta\beta}=4.27 MeV) and₄₀₅ 389 ¹⁰⁰Mo ($Q_{\beta\beta}$ =3.03 MeV). Actually, while the large content of₄₀₆ 390 ¹⁰⁰Mo makes this crystal very attractive, the presence of ⁴⁸Ca₄₀₇ 391 is a problem. Indeed, the natural isotopic abundance of ⁴⁸Ca₄₀₈ 392 (a.i.=0.19%) is too low to study the $\beta\beta(0\nu)$ without enrichment, 409 393 which is extremely difficult, and at the same time, it is too₄₁₀ 394 high to study the $\beta\beta(0\nu)$ of ¹⁰⁰Mo, since the background due₄₁₁ 395 to the $\beta\beta(2\nu)$ of ⁴⁸Ca in the $\beta\beta(0\nu)$ region of ¹⁰⁰Mo will limit₄₁₂ 396

the reachable sensitivity for the latter isotope. A possible solution to this problem was suggested by Annenkov et al. [36] who proposed an experiment with CaMoO₄ depleted in ⁴⁸Ca. Despite these possible problems, we discovered that CaMoO₄ is an extremely interesting crystal because of its capability to discriminate β/γ from α , thanks to the different shape of the thermal pulses.

The sample we used was a cylindric CaMoO₄ crystal with a mass of 158 g (h = 40mm, \emptyset = 35mm). The crystal was faced to two α sources. Source A was obtained by implantation of ²²⁴Ra in an Al reflecting stripe. The shallow implantation depth allows to reduce to a minimum the energy released by the α 's in the Al substrate so that monochromatic α lines (those produced in the decay chain of ²²⁴Ra to the stable ²⁰⁸Pb isotope) can be observed in the scintillating bolometer. Besides these α particles - all with energies above 5 MeV - the source emits a

 β with a maximum energy of 5 MeV, due to the decay of ²⁰⁸Tl. 413 Since our main goal was to study the efficiency of α particle 414 rejection in the $\beta\beta(0\nu)$ region (i.e. at about 3 MeV), a second 415 source (B) was also used. This was obtained contaminating an 416 Al stripe with a ²³⁸U liquid solution and later covering the stripe 417 with an alluminated Mylar film (6 μ m thick). Thus the source 418 produced a continuous spectrum of α particles, extending from 419 about 3 MeV down to 0. 420

In Fig. 1 we show the Light vs. Heat scatter plot, collected 421 while the crystal was exposed to an external ²³²Th source. The 422 total live time of this measurement was ~43 h. The FWHM en-423 ergy resolution, on the heat signal, ranges from 2.7 keV at 243 424 keV to 8.7 keV at 2615 keV on β/γ events and is about 10 keV 425 on 5 MeV α 's. The light yield of the crystal, evaluated cali-426 brating the light detector with a 55Fe source, is 1.87 keV/MeV 427 (for more details on the procedure used for the evaluation of the 428 light yield see references [14, 16]). 429

The two separate bands - clearly visible in the Light vs. Heat 430 scatter plot - are ascribed to β/γ 's (upper band) and α 's (lower 431 band). The upper band is dominated by the ²³²Th source γ 's 432 (plus the environmental γ 's). The lower band is due to α 's from 433 source A and from Uranium and Thorium internal contamina-434 tion of the crystal (these are the monochromatic lines above 435 4 MeV) and source B (the continuum counting rate below 4467 436 MeV). Above 8 MeV we observe a group of events ascribed to468 437 $\alpha + \beta$ summed signals due to internal contamination in Bismuth⁴⁶⁹ 438 and Polonium. Indeed, due to the long rise-time of this device470 439 (~5 ms), the beta decay of 214 Bi or 212 Bi (respectively of 238 U⁴⁷¹ 440 and ²³²Th chains) followed immediately by α decay of ²¹⁴Po⁴⁷² 441 $(\tau = 164 \ \mu s)$ and ²¹²Po $(\tau = 298 \ \mu s)$, may lead to a pile up on the⁴⁷⁵ 442 rise-time of the thermal pulses that can hardly be recognized⁴⁷⁴ 443 as a double signal. The two decays produce therefore a single⁴⁷⁵ 444 pulse, with an energy that is the sum of the two. 445

The discrimination between the α and the β/γ populations,⁴⁷⁷ 446 provided by the scintillation signal, can be evaluated by mea-478 447 suring the difference between the average amplitude of the light⁴⁷⁹ 448 signal produced by the two kinds of particles (Light_{β/γ} and⁴⁸⁰ 449 Light_{α}), considering a group of events releasing the same en-⁴⁸¹ 450 ergy in the scintillating crystal. This difference is then com-482 451 pared with the width of the two distributions ($\sigma_{\beta/\gamma}$ and σ_{α}).⁴⁸³ 452 The discrimination confidence level D_{Light} can be then defined⁴⁸⁴ 453 485 as: 454

$$D_{Light} = \frac{Light_{\beta/\gamma} - Light_{\alpha}}{\sqrt{\sigma_{\beta/\gamma}^2 + \sigma_{\alpha}^2}}$$

To evaluate this discrimination power in the $\beta\beta(0\nu)$ region we⁴⁹⁰ 456 selected events belonging to the 2615 keV γ -line full energy⁴⁹¹ 457 peak and compared their light pulse distribution with that of⁴⁹² 458 events of similar energy in the α band (Fig. 2 left panel). D_{light}⁴⁹³ 459 results to be 12.6 sigma. The reason for using events with the⁴⁹⁴ 460 same energy to evaluate D_{light} is in the energy dependence of⁴⁹⁵ 461 the distance (and width) of the α and β/γ bands, that induce an 462 energy dependence of the discrimination confidence level. In₄₉₆ 463 the energy range where both the bands are populated (i.e. be-464 tween 1 and 3 MeV), DLight(E) appears to be linearly decreasing 465 with energy. Its extrapolated value at E=0 being 3 sigma. 497 466

As already anticipated, we discovered that the heat signal shape is enough to discriminate β/γ 's from α 's. This is shown in the right panel of Fig. 1 where we report the (thermal pulse) τ_{rise}^{lin} vs. Heat scatter plot for the same events shown in the left panel. Two separate bands, ascribed to β/γ and α events can be identified. The former with an average rise-time of ~5.8 ms, the latter with ~5.6 ms. In this plot the weak energy (Heat) dependence of τ_{rise} observed for the two populations was corrected by fitting their rise-time distributions with two lines having the same slope. To do this we used β/γ events in the 0.5-2.6 MeV range and α events in the 1.5-7 MeV range. The τ_{rise} is then linearized re-defining it as $\tau_{rise}^{lin} = \tau_{rise} - slope \times E$ with slope=0.0075 ms/MeV.

In order to emphasize the correspondence in the identification of β/γ and α events, signals selected in the Light vs. Heat scatter plot as having an energy between 2 and 4 MeV and belonging to the β/γ or α bands, are reported in different colors. We will refer in the following to these two groups of events as to 2-4 MeV γ 's and 2-4 MeV α 's, although - above the 2615 keV line - the γ group is empty. These two samples will be used to evaluate the difference in shape among β/γ and α signals.

In Fig. 3 we compare two pulses obtained by averaging - separately - signals belonging to the 2615 keV γ -line and signals due to α particles that release a similar energy. The average is here needed to get rid of the noise that can mask the small differences among the pulses. The difference in shape can be appreciated in the bottom panel of Fig. 3.

The discriminating power $D_{RiseTime}$ of the heat pulse shape method can be defined exactly as done for D_{Light} :

$$D_{RiseTime}(E) = \frac{RiseTime_{\beta/\gamma} - RiseTime_{\alpha}}{\sqrt{\sigma_{\beta/\gamma}^2 + \sigma_{\alpha}^2}}$$

where, however, the dependence on energy is here due only to

the variation of the width of the rise-time distributions since 534 498 the difference in rise-time appears to be independent on en-535 499 ergy. The distribution obtained projecting the rise-time of 536 500 2-4 MeV γ 's and 2-4 MeV α 's is shown in Fig. 2 (right₅₃₇ 501 panel). A gaussian fit of the two peaks yields a rise-time of 538 502 (5.788 ± 0.017) ms for γ 's and of (5.649 ± 0.013) ms for α 's.539 503 D_{RiseTime} results equal to 6.5 sigma. As for the D_{Light} case,540 504 we can extrapolate the $D_{RiseTime}$ value also in the energy re-541 505 gion where the α band is poorly populated, simply assuming₅₄₂ 506 that the distance between the two bands remains constant (as 507 we observe) and D_{RiseTime} changes because the width of the two543 508 distributions becomes larger, at low energies, due to noise. The₅₄₄ 509 result is that D_{RiseTime} becomes lower than 2 sigma at 500 keV.₅₄₅ 510 In other words the ~150 μ s difference in rise-time of α and β/γ_{546} 511 events cannot be appreciated when the pulse amplitude is too₅₄₇ 512 low and, therefore, the noise modifies appreciably the signal₅₄₈ 513 shape. Finally, although in this measurement the rise-time is 514 the most efficient shape parameter for α event discrimination,₅₄₉ 515 good discrimination levels were observed also in other para-516 meters such as the decay-time and the TVR. The possibility to⁵⁵⁰ 517 increase the discrimination power by combining the informa-551 518 tion from different shape parameters or the fit on the rise-time⁵⁵² 519 is under study. 520 554

We note that either in the Light vs. Heat scatter plot as in 521 the τ_{rise}^{lin} vs. Heat one we can see some outliers that could in-522 dicate a possible failure of the particle identification technique. 523 However such events can be accounted for if one considers the $_{558}$ 524 following two effects. If a γ -ray interacts both in the light de-525 tector and in the scintillator the light signal that is read-out has $_{560}$ 526 a wrong amplitude since it is not only ascribed to scintillating 527 photons but also to a direct γ interaction in the Ge wafer. The 528 measurement is performed in a high rate condition, therefore 529 we expect to have a number of pile-up events in each of the $_{\rm 564}$ 530 two detectors, this leads to an erroneous evaluation of the pulse 531 amplitude and pulse rise-time. 532

power provided by the use of the scintillation signal is comparable with that provided by the pulse shape analysis. For what concerns the use of this device for the measurements of α particle emissions from an external sample, a $D_{RiseTime}$ better than 2 sigma above 500 keV means that this detector has a good sensitivity even in the region where Si surface barrier detectors start to be dominated by γ background. On the contrary the applicability of this technique to Dark Matter searches cannot be proved directly.

5.1. Other crystals

Other scintillating crystals have shown the possibility to discriminate interacting particles through the thermal pulse shape differences. Among the tested crystals, other molyb-dates (ZnMoO₄, MgMoO₄) and also other crystals such as ZnSe showed a good discrimination power.

5.2. $ZnMoO_4$

We tested a 19.8 g ZnMoO₄ crystal, having the shape of a prism with height of 11mm and a regular hexagonal base, with a diagonal of 25 mm [17]. The FWHM energy resolution, on the heat signal, is 4.2 keV FWHM on β/γ events at 2615 keV, and about 6 keV on the 5.4 MeV α line. The light yield of the crystal is 1.1 keV/MeV. The total live time of this measurement was ~195 h. Also for this analysis we have used the Light vs. Heat scatter plot to select β/γ and α between 2 and 4 MeV, in order to evaluate the discrimination power provided by pulse shape studies.

Unlike for the CaMoO₄ case where the most efficient parameter for the discrimination is the rise-time, this measurement showed a higher discrimination power on the decay-time of the thermal pulse. In order to emphasize the discrimination power, all signals have been fitted with a function obtained as the sum of two exponentials:

To conclude, in the case of $\beta\beta(0\nu)$ decay the discrimination₅₆₆

$$\Delta V(t) = (e^{-t/\tau_1 + A_1} + e^{-t/\tau_2 + A_2}) \tag{6}$$

599 where the au_1 and au_2 parameters are obtained by fitting the decay \int_{600}^{∞} 567 of the thermal signals in the raw-pulse acquired for each event. 568 It was observed that the best discrimination power is obtained 569 by the ratio of the two decay constants (RDC): 570 603

The scatter plot of RDC vs. Heat is reported in the right panel of 572 Fig. 4 (in the left panel the corresponding Light vs. Heat scat-⁶⁰⁸ measurements to better study this promising crystal. 573 ter plot). The discrimination between α and β/γ populations 574 provided by RDC is evaluated linearizing the RDC vs. Heat 575 relationship (fitting the α band in scatter plot of Fig. 4 with a_{609} 576 polynomial as done for the τ_{rise} of CaMoO₄) and then project-577 ing the distribution of RDClin for events in the 2-4 MeV range.610 578 The two peaks (β/γ and α) are then fitted with a gaussian (Fig.₆₁₁ 579 5). The discrimination power D_{RDC} is 6.4 sigma. 612 580 613

5.3. MgMoO₄ 581

This compound contains, as in the two previous cases, the615 582 $\beta\beta$ active isotope ¹⁰⁰Mo which is here present in a larger con-⁶¹⁶ 583 centration (~52% in mass). 617 584

The crystal tested is 32x31x24 mm³ with a weight of 89.1⁶¹⁸ 585 g. The total live time of this measurements was ~22 h. In this⁶¹⁹ 586 run it was not possible to face the crystal to a light detector be-620 587 cause of the assembly structure so we can't use the Light vs.621 588 Heat scatter plot in order to tag α events. The performances of 622 the bolometer were quite poor, most probably this was due to a623 590 problem with the gluing of the NTD thermistor: at the end of624 591 the measurement, when the crystal was back to room tempera-625 592 ture, we discovered that under the thermistor the crystal showed626 593 a crack. This could explain why the signal to noise ratio was so627 594 bad (the energy resolution measured on α lines was ~150 keV₆₂₈ 595 FWHM) and consequently also the resolution in the evaluation 629 596 of the signal shape parameters was limited. Despite these prob-630 597 lems, we were able to observe in the scatter plot of RDC^{lin} vs.631 598

Heat (fig. 6) clear difference between events due to the interaction of α particles and events due to β/γ events.

The discrimination between the two populations provided by the RDC parameter can be evaluated by means of a gaussian fit of the two peaks obtained by projecting selected events after linearization. The resulting discrimination power D_{RDC} is 1.8 sigma.

These preliminary results, even if limited because of the problems reported above, lead us to program new more detailed

5.4. ZnSe

614

 ^{82}Se is a $\beta\beta$ emitter with an isotopic abundance of 9.2% and a Q-value of (2995.5 ± 2.7) keV. It has always been considered a good candidate for $\beta\beta(0\nu)$ studies because of its high transition energy and the favorable nuclear factor of merit. For these reasons in the last years an R&D work was carried out in which we have extensively studied the performances of ZnSe detectors in different conditions. For our studies we have used different ZnSe crystals. Characteristics of measurements done and obtained results are reported in detail in [16]. Here we report the discrimination power on the RDC obtained with the Huge ZnSe crystal (h = 50mm, \emptyset = 40mm, 337g).

In Fig. 7 the Light vs. Heat scatter plot of a measurement of \sim 70 h of live time is shown. In order to have a high number of α counts in the 2-3 MeV region also in these measurements a degraded ²³⁸U source was placed in front of the crystal. An explanation of the Quenching Factor larger than one (i.e. the α band lies above the β/γ band) and other anomalies observed in this crystal can be found in [16].

Also in this case, the RDC^{lin} vs. Heat (fig. 8) showed a difference between events due to the interaction of α particles and events due to β/γ events. The discrimination power D_{RDC} is 2.2 sigma.

632 6. Conclusion

The possibility to discriminate the nature of the particle inter- $\frac{663}{664}$ 633 acting in a bolometric detector, simply on the base of the shape₆₆₅ 634 of the thermal pulse, is now definitely proved and opens new666 635 possibilities for the application of these devices in the field of⁶⁶⁷ 636 rare events searches. In particular, the high rejection capabil-637 ity that could allow to completely rule out the α background in₆₇₀ 638 $\beta\beta(0\nu)$ experiments was demonstrated. Unfortunately, based on⁶⁷¹ 639 the results obtained so far, the applicability of this technique to⁶⁷² 640 Dark Matter searches cannot yet be proved directly. This fea-641 ture was observed in different scintillating crystals (CaMoO_{4,675} 642 ZnMoO₄, MgMoO₄ and ZnSe) and new tests are under prepara-676 643 tion in order to investigate if a similar behavior can be observed677 also in other compounds. A discrimination confidence level 645 of ~6.5 sigma was obtained both for CaMoO₄ and ZnMoO₄₆₈₀ 646 crystals in the 2-4 MeV energy region. Discrimination con-681 647 fidence levels reached with MgMoO₄ (D_{RDC}=1.8 σ) and ZnSe⁶⁸²₆₈₃ 648 $(D_{RDC}=2.2\sigma)$ are not so high but they indicate that even with₆₈₄ 649 these crystals the discrimination based on pulse shape analysises 650 is possible. New techniques aiming at improving the discrimi-686 651 nation power of the pulse shape analysis are being studied. 652 688
