# FRAGMENTED DEFORMATIONS OF PRIMITIVE MULTIPLE CURVES 

JEAN-MARC DRÉZET


#### Abstract

Resume. A primitive multiple curve is a Cohen-Macaulay irreducible projective curve $Y$ that can be locally embedded in a smooth surface, and such that $Y_{\text {red }}$ is smooth.

This paper studies the deformations of $Y$ to curves with smooth irreducible components, when the number of components is maximal (it is then the multiplicity $n$ of $Y$ ).

We are particularly interested in deformations to $n$ disjoint smooth irreducible components, which are called fragmented deformations. We describe them completely. We give also a characterization of primitive multiple curves having a fragmented deformation.

## 1. Introduction

A primitive multiple curve is an algebraic variety $Y$ over $\mathbb{C}$ which is Cohen-Macaulay, such that the induced reduced variety $C=Y_{r e d}$ is a smooth projective irreducible curve, and that every closed point of $Y$ has a neighborhood that can be embedded in a smooth surface. These curves have been defined and studied by C. Bănică and O. Forster in [1]. The simplest examples are infinitesimal neighborhoods of projective smooth curves embedded in a smooth surface (but most primitive multiple curves cannot be globally embedded in smooth surfaces, cf. [2, theorem 7.1).
Let $Y$ be a primitive multiple curve with associated reduced curve $C$, and suppose that $Y \neq C$. Let $\mathcal{I}_{C}$ be the ideal sheaf of $C$ in $Y$. The multiplicity of $Y$ is the smallest integer $n$ such that $\mathcal{I}_{C}^{n}=0$. We have then a filtration

$$
C=C_{1} \subset C_{2} \subset \cdots \subset C_{n}=Y
$$

where $C_{i}$ is the subscheme corresponding to the ideal sheaf $\mathcal{I}_{C}^{i}$ and is a primitive multiple curve of multiplicity $i$. The sheaf $L=\mathcal{I}_{C} / \mathcal{I}_{C}^{2}$ is a line bundle on $C$, called the line bundle on $C$ associated to $Y$.
The deformations of double (i.e. of multiplicity 2) primitive multiple curves (also called ribbons) to smooth projective curves have been studied in [11]. In this paper we are interested in deformations of primitive multiple curves $Y=C_{n}$ of any multiplicity $n \geq 2$ to reduced curves having exactly $n$ components which are smooth ( $n$ is the maximal number of components of deformations of $Y$ ). In this case the number of intersection points of two components is exactly $-\operatorname{deg}(L)$. We give some results in the general case (no assumption on $\operatorname{deg}(L)$ ) and treat more precisely the case $\operatorname{deg}(L)=0$, i.e. deformations of $Y$ to curves having exactly $n$ disjoint irreducible components.
1.1. Motivation - Let $\pi: \mathcal{C} \rightarrow S$ be a flat projective morphism of algebraic varieties, $P$ a closed point of $S$ such that $\pi^{-1}(P) \simeq Y, \mathcal{O}_{\mathcal{C}}(1)$ a very ample line bundle on $\mathcal{C}$ and $P$ a polynomial in one variable with rational coefficients. Let

$$
\tau: \mathcal{M}_{\mathcal{O}_{\mathcal{C}}(1)}(P) \longrightarrow S
$$

be the corresponding relative moduli space of semi-stable sheaves (parametrizing the semistables sheaves on the fibers of $\pi$ with Hilbert polynomial $P$ with respect to the restriction of $\mathcal{O}_{\mathcal{C}}(1)$, cf. [15]).
We suppose first that there exists a closed point $s \in S$ such that $\mathcal{C}_{s}$ is a smooth projective irreducible curve. Then in general $\tau$ is not flat (some other examples on non flat relative moduli spaces are given in [13]). The reason is that the generic structure of torsion free sheaves on $Y$ is more complicated than on smooth curves, and some of these sheaves cannot be deformed to sheaves on the smooth fibers of $\pi$.
A coherent sheaf on a smooth algebraic variety $X$ is locally free on some nonempty open subset of $X$. This is not true on $Y$. But a coherent sheaf $E$ on $Y$ is quasi locally free on some nonempty open subset of $Y$, i.e. on this open subset, $E$ is locally isomorphic to a sheaf of the form $\bigoplus_{1 \leq i \leq n} m_{i} \mathcal{O}_{C_{i}}$, the sequence of non negative integers $\left(m_{1}, \ldots, m_{n}\right)$ being uniquely determined (cf. [3], 6]). It is not hard to see that if $E$ can be extended to a coherent sheaf on $\mathcal{C}$, flat on $S$, then $R(E)=\sum_{i=1} i . m_{i}$ must be a multiple of $n$. For example, it is impossible to deform the stable sheaf $\mathcal{O}_{C_{i}}$ on $Y$ in sheaves on the smooth fibers, if $1 \leq i<n$.
Now suppose that all the fibers $\pi^{-1}(s), s \neq P$, are reduced with exactly $n$ smooth components. I conjecture that (with suitable hypotheses) a torsion free coherent sheaf on $Y$ can be extended to a coherent sheaf on $\mathcal{C}$, flat on $S$, using the fact that we allow coherent sheaves of the reducible fibers $\mathcal{C}_{s}$ that have not the same rank on all the components. This would be a step in the study of the flatness of $\tau$. For example (for suitable $\pi$ ), there exists a coherent sheaf $\mathcal{E}$ on $\mathcal{C}$, flat on $S$, such that $\mathcal{E}_{P}=\mathcal{O}_{C}$, and that for $s \neq P, \mathcal{E}_{s}$ is the structural sheaf of an irreducible component of $\mathcal{C}_{s}$.
Moduli spaces of sheaves on reducible curves have been studied in [16], [17], [18].
1.2. Maximal reducible deformations - Let $(S, P)$ be the germ of a smooth curve. Let $Y$ be a primitive multiple curve of multiplicity $n \geq 2$ and $k>0$ an integer. Let $\pi: \mathcal{C} \rightarrow S$ be a flat morphism, where $\mathcal{C}$ is a reduced algebraic variety, such that

- For every closed point $s \in S$ such that $s \neq P$, the fiber $\mathcal{C}_{s}$ has $k$ irreducible components, which are smooth and transverse, and any three of these components have no common point.
- The fiber $\mathcal{C}_{P}$ is isomorphic to $Y$.

We show that by making a change of variable, i.e. by considering a suitable germ ( $S^{\prime}, P^{\prime}$ ) and a non constant morphism $\tau: S^{\prime} \rightarrow S$, and replacing $\pi$ with $\tau^{*} \mathcal{C} \rightarrow S^{\prime}$, we can suppose that $\mathcal{C}$ has exactly $k$ irreducible components, inducing on every fiber $\mathcal{C}_{s}, s \neq P$ the $k$ irreducible components of $\mathcal{C}_{s}$. In this case $\pi$ is called a reducible deformation of $Y$ of length $k$.
We show that $k \leq n$. We say that $\pi$ (or $\mathcal{C}$ ) is a maximal reducible deformation of $Y$ if $k=n$.
Suppose that $\pi$ is a maximal reducible deformation of $Y$. We show that if $\mathcal{C}^{\prime}$ is the union of $i>0$ irreducible components of $\mathcal{C}$, and $\pi^{\prime}: \mathcal{C}^{\prime} \rightarrow S$ is the restriction of $\pi$, then $\pi^{\prime-1}(P) \simeq C_{i}$, and $\pi^{\prime}$ is a maximal reducible deformation of $C_{i}$. Let $s \in S \backslash\{P\}$. We prove that the irreducible components of $\mathcal{C}_{s}$ have the same genus as $C$. Moreover, if $D_{1}, D_{2}$ are distinct irreducible components of $\mathcal{C}_{s}$, then $D_{1} \cap D_{2}$ consists of $-\operatorname{deg}(L)$ points.
1.3. Fragmented deformations (definition) - Let $Y$ be a primitive multiple curve of multiplicity $n \geq 2$ and $\pi: \mathcal{C} \rightarrow S$ a maximal reducible deformation of $Y$. We call it a fragmented deformation of $Y$ if $\operatorname{deg}(L)=0$, i.e. if for every $s \in S \backslash\{P\}, \mathcal{C}_{s}$ is the disjoint union of $n$ smooth curves. In this case $\mathcal{C}$ has $n$ irreducible components $\mathcal{C}_{1}, \ldots, \mathcal{C}_{n}$ which are smooth surfaces.
The variety $\mathcal{C}$ appears as a particular case of a gluing of $\mathcal{C}_{1}, \ldots, \mathcal{C}_{n}$ along $C$ (cf. 4.1.5). We prove (proposition 4.1.6) that such a gluing $\mathcal{D}$ is a fragmented deformation of a primitive multiple curve if and only if every closed point in $C$ has a neighborhood in $\mathcal{D}$ that can be embedded in a smooth variety of dimension 3 . The simplest gluing is the trivial or initial gluing $\mathcal{A}$. An open subset $U$ of $\mathcal{A}$ (and $\mathcal{C}$ ) is given by open subsets $U_{1}, \ldots, U_{n}$ of $\mathcal{C}_{1}, \ldots, \mathcal{C}_{n}$ respectively, having the same intersection with $C$, and

$$
\mathcal{O}_{\mathcal{A}}(U)=\left\{\left(\alpha_{1}, \ldots, \alpha_{n}\right) \in \mathcal{O}_{\mathcal{C}_{1}}\left(U \cap \mathcal{C}_{1}\right) \times \cdots \times \mathcal{O}_{\mathcal{C}_{n}}\left(U \cap \mathcal{C}_{n}\right) ; \quad \alpha_{1 \mid C}=\cdots=\alpha_{n \mid C}\right\}
$$

and $\mathcal{O}_{\mathcal{C}}(U)$ appears as a subalgebra of $\mathcal{O}_{\mathcal{A}}(U)$, hence we have a canonical morphism $\mathcal{A} \rightarrow \mathcal{C}$.
We can view elements of $\mathcal{O}_{\mathcal{C}}(U)$ as $n$-tuples $\left(\alpha_{1}, \ldots, \alpha_{n}\right)$, with $\alpha_{i} \in \mathcal{O}_{\mathcal{C}_{i}}\left(U \cap \mathcal{C}_{i}\right)$. In particular we can write $\pi=\left(\pi_{1}, \ldots, \pi_{n}\right)$.
1.4. A simple analogy - Consider $n$ copies of $\mathbb{C}$ glued at 0 . Two extreme examples appear: the trivial gluing $\mathcal{A}_{0}$ (the set of coordinate lines in $\mathbb{C}^{n}$ ), and a set $\mathcal{C}_{0}$ of $n$ lines in $\mathbb{C}^{2}$. We can easily construct a bijective morphism $\Psi: \mathcal{A}_{0} \rightarrow \mathcal{C}_{0}$ sending each coordinate line to a line in the plane


But the two schemes are of course not isomorphic: the maximal ideal of 0 in $\mathcal{A}_{0}$ needs $n$ generators, but 2 are enough for the maximal ideal of 0 in $\mathcal{C}_{0}$.
Let $\pi_{\mathcal{C}_{0}}: \mathcal{C}_{0} \rightarrow \mathbb{C}$ be a morphism sending each component linearly onto $\mathbb{C}$, and $\pi_{\mathcal{A}_{0}}=\pi_{\mathcal{C}_{0}} \circ \boldsymbol{\Psi}: \mathcal{A}_{0} \rightarrow \mathbb{C}$. The difference of $\mathcal{A}_{\mathbf{0}}$ and $\mathcal{C}_{0}$ can be also seen by using the fibers of 0 : we have

$$
\pi_{\mathcal{C}_{0}}^{-1}(0) \simeq \operatorname{spec}\left(\mathbb{C}[t] /\left(t^{n}\right)\right) \quad \text { and } \quad \pi_{\mathcal{A}_{0}}^{-1}(0) \simeq \operatorname{spec}\left(\mathbb{C}\left[t_{1}, \ldots, t_{n-1}\right] /\left(t_{1}, \ldots, t_{n-1}\right)^{2}\right)
$$

Let $\mathcal{D}$ be a general gluing of $n$ copies of $\mathbb{C}$ at 0 , such that there exists a morphism $\pi: \mathcal{D} \rightarrow \mathbb{C}$ inducing the identity on each copy of $\mathbb{C}$. It is easy to see that we have $\pi^{-1}(0) \simeq \operatorname{spec}\left(\mathbb{C}[t] /\left(t^{n}\right)\right)$ if and only if some neighborhood of 0 in $\mathcal{D}$ can be embedded in a smooth surface.
1.5. Fragmented deformations (main properties) - Let $\pi: \mathcal{C} \rightarrow S$ be a fragmented deformation of $Y=C_{n}$. Let $I \subset\{1, \ldots, n\}$ be a proper subset, $I^{c}$ its complement, and $\mathcal{C}_{I} \subset \mathcal{C}$ the subscheme union of the $\mathcal{C}_{i}, i \in I$. We prove (theorem 4.3.7) that the ideal sheaf $\mathcal{I}_{\mathcal{C}_{I}}$ of $\mathcal{C}_{I}$ is isomorphic to $\mathcal{O}_{\mathcal{C}_{I^{c}}}$.
In particular, the ideal sheaf $\mathcal{I}_{\mathcal{C}_{i}}$ of $\mathcal{C}_{i}$ is generated by a single regular function on $\mathcal{C}$. We show that we can find such a generator such that for $1 \leq j \leq n, j \neq i$, its $j$-th coordinate can be written as $\alpha_{j} \pi_{j}^{p_{i j}}$, with $p_{i j}>0$ and $\alpha_{j} \in H^{0}\left(\mathcal{O}_{S}\right)$ such that $\alpha_{j}(P) \neq 0$. If $1 \leq j \leq n$ and $j \neq i$, we can then obtain a generator that can be written as

$$
\mathbf{u}_{i j}=\left(u_{1}, \ldots, u_{m}\right)
$$

with

$$
u_{i}=0, \quad u_{m}=\alpha_{i j}^{(m)} \pi_{m}^{p_{i m}} \quad \text { for } m \neq i, \quad \alpha_{i j}^{(j)}=1
$$

The constants $\mathbf{a}_{i j}^{(m)}=\alpha_{i j \mid C}^{(m)} \in \mathbb{C}$ have interesting properties (propositions 4.5.2, 4.4.6). Let $p_{i i}=0$ for $1 \leq i \leq n$. The symmetric matrix $\left(p_{i j}\right)_{1 \leq i, j \leq n}$ is called the spectrum of $\pi$ (or $\mathcal{C}$ ).
It follows also from the fact that $\mathcal{I}_{\mathcal{C}_{i}}=\left(\mathbf{u}_{i j}\right)$ that $Y$ is a simple primitive multiple curve, i.e. the ideal sheaf of $C$ in $Y=C_{n}$ is isomorphic to $\mathcal{O}_{C_{n-1}}$. Conversely, we show in theorem 4.7.1 that if $Y$ is a simple primitive multiple curve, then there exists a fragmented deformation of $Y$.
We give in 4.4 and 4.5 a way to construct fragmented deformations by induction on $n$. This is used later to prove statements on fragmented deformations by induction on $n$.
1.6. $n$-stars and structure of fragmented deformations - An $n$-star of $(S, P)$ is a gluing $\mathcal{S}$ of $n$ copies $S_{1}, \ldots, S_{n}$ of $S$ at $P$, together with a morphism $\tau: \mathcal{S} \rightarrow S$ which is an identity on each $S_{i}$. All the $n$-stars have the same underlying Zariski topological space $S(n)$.
An $n$-star is called oblate if some neighborhood of $P$ can be embedded in a smooth surface. This is the case if and only $\tau^{-1}(0) \simeq \operatorname{spec}(\mathbb{C}[t]) /\left(t^{n}\right)$.
Oblate $n$-stars are analogous to fragmented deformations but simpler. We provide a way to build oblate $n$-stars by induction on $n$.
Let $\pi: \mathcal{C} \rightarrow S$ be a fragmented deformation of $Y=C_{n}$. We associate to it an oblate $n$ star $\mathcal{S}$ of $S$. Let $\mathcal{C}^{\text {top }}$ be the Zariski topological space of $\mathcal{C}$. We have an obvious continuous map $\tilde{\pi}: \mathcal{C}^{\text {top }} \rightarrow S(n)$. For every open subset $U$ of $S(n), \mathcal{O}_{\mathcal{S}}(U)$ is the set of $\left(\alpha_{1}, \ldots, \alpha_{n}\right) \in \mathcal{O}_{\mathcal{C}}\left(\widetilde{\pi}^{-1}(U)\right)$ such that $\alpha_{i} \in \mathcal{O}_{S_{i}}\left(U \cap S_{i}\right)$ for $1 \leq i \leq n$. We obtain also a canonical morphism $\boldsymbol{\Pi}: \mathcal{C} \longrightarrow \mathcal{S}$. We prove (theorem 5.6.2) that $\boldsymbol{\Pi}$ is flat. Hence it is a flat family of smooth curves, with $\Pi^{-1}(P)=C$. The converse is also true, i.e. starting from an oblate $n$-star of $S$ and a flat family of smooth curves parametrized by it, we obtain a fragmented deformation of a multiple primitive curve of multiplicity $n$.
1.7. Fragmented deformations of double curves - Let $Y=C_{2}$ be a primitive double curve, $C$ its associated smooth curve, $\pi: \mathcal{C} \rightarrow S$ a fragmented deformation of $Y$, of spectrum $\left(\begin{array}{ll}0 & p \\ p & 0\end{array}\right)$, and $\mathcal{C}_{1}, \mathcal{C}_{2}$ the irreducible components of $\mathcal{C}$. For $i=1,2, q>0$, let $C_{i}^{q}$ be the infinitesimal neighborhood of order $q$ of $C$ in $\mathcal{C}_{i}$ (defined by the ideal sheaf $\left(\pi_{i}^{q}\right)$ ). It is a primitive multiple curve of multiplicity $q$.
It follows from 4.3.5 that $C_{1}^{p}$ and $C_{2}^{p}$ are isomorphic, and $C_{1}^{p+1}, C_{2}^{p+1}$ are two extensions of $C_{1}^{p}$ in primitive multiple curves of multiplicity $p+1$. According to [4] these extensions are parametrized by an affine space with associated vector space $H^{1}\left(C, T_{C}\right)$ (where $T_{C}$ is the tangent bundle of $C)$. Let $w \in H^{1}\left(C, T_{C}\right)$ be the vector from $C_{1}^{p+1}$ to $C_{2}^{p+1}$.
Similarly, the primitive double curves with associated smooth curve $C$ such that $\mathcal{I}_{C} \simeq \mathcal{O}_{C}$ are parametrized by $\mathbb{P}\left(H^{1}\left(C, T_{C}\right)\right) \cup\{0\}$ (cf. [2], [4]).
We prove in theorem 6.0.5 that the point of $\mathbb{P}\left(H^{1}\left(C, T_{C}\right)\right) \cup\{0\}$ corresponding to $C_{2}$ is $\mathbb{C} w$.
1.8. Notation: Let $X$ be an algebraic variety and $Y \subset X$ a closed subvariety. We will denote by $\mathcal{I}_{Y, X}$ (or $\mathcal{I}_{Y}$ if there is no risk of confusion) the ideal sheaf of $Y$ in $X$.

## 2. Preliminaries

### 2.1. Local embeddings in smooth varieties

2.1.1. Proposition: Let $X$ be an algebraic variety, $x$ a closed point of $X$ and $n$ a positive integer. Then the three following properties are equivalent:
(i) There exist a neighborhood $U$ of $x$ and an embedding $U \subset Z$ in a smooth variety of dimension $n$.
(ii) The $\mathcal{O}_{X, x}$-module $m_{X, x}$ (maximal ideal of $x$ ) can be generated by $n$ elements.
(iii) We have $\operatorname{dim}_{\mathbb{C}}\left(m_{X, x} / m_{X, x}^{2}\right) \leq n$.

Proof. It is obvious that (i) implies (ii), and (ii),(iii) are equivalent according to Nakayama's lemma. It remains to prove that (iii) implies (i).

Suppose that (iii) is true. There exist an integer $N$ and an embedding $X \subset \mathbb{P}_{N}$. Let $\mathcal{I}_{X}$ be the ideal sheaf of $X$ in $\mathbb{P}_{N}$. Let $p$ be the biggest integer such that there exists $f_{1}, \cdots, f_{p} \in \mathcal{I}_{X, x}$ whose images in the $\mathbb{C}$-vector space $m_{\mathbb{P}_{N}, x} / m_{\mathbb{P}_{N}, x}^{2}$ are linearly independent. Then we have

$$
\mathcal{I}_{X, x} \subset\left(f_{1}, \cdots, f_{p}\right)+m_{\mathbb{P}_{N}, x}^{2} .
$$

In fact, let $f \in \mathcal{I}_{X, x}$. Since $p$ is maximal, the image of $f$ in $m_{\mathbb{P}_{N}, x} / m_{\mathbb{P}_{N}, x}^{2}$ is a linear combination of those of $f_{1}, \cdots, f_{n}$. Hence we can write

$$
f=\sum_{i=1}^{p} \lambda_{i} f_{i}+g, \quad \text { with } \quad \lambda_{i} \in \mathbb{C}, g \in m_{\mathbb{P}_{N}, x}^{2}
$$

and our assertion is proved. It follows that we have a surjective morphism

$$
\alpha: \mathcal{O}_{X, x} / m_{X, x}^{2} \longrightarrow \mathcal{O}_{\mathbb{P}_{N}, x} /\left(\left(f_{1}, \cdots, f_{p}\right)+m_{\mathbb{P}_{N}, x}^{2}\right)
$$

We have

$$
\operatorname{dim}_{\mathbb{C}}\left(\mathcal{O}_{X, x} / m_{X, x}^{2}\right) \leq n+1, \quad \operatorname{dim}_{\mathbb{C}}\left(\mathcal{O}_{\mathbb{P}_{N}, x} /\left(\left(f_{1}, \cdots, f_{p}\right)+m_{\mathbb{P}_{N}, x}^{2}\right)\right)=N-p+1
$$

Hence $N-p+1 \leq n+1$, i.e. $\quad p \geq N-n$. We can take for $Z$ a neighborhood of $x$ in the subvariety of $\mathbb{P}_{N}$ defined by $f_{1}, \cdots, f_{N-n}$, which is smooth at $x$.

### 2.2. Flat families of coherent sheaves

Let $(S, P)$ be the germ of a smooth curve and $t \in \mathcal{O}_{S, P}$ a generator of the maximal ideal. Let $\pi: X \rightarrow S$ be a flat morphism. If $\mathcal{E}$ is a coherent sheaf on $X, \mathcal{E}$ is flat on $S$ at $x \in \pi^{-1}(P)$ if and only if the multiplication by $t: \mathcal{E}_{x} \rightarrow \mathcal{E}_{x}$ is injective. In particular the multiplication by $t: \mathcal{O}_{X, x} \rightarrow \mathcal{O}_{X, x}$ is injective.
2.2.1. Lemma: Let $\mathcal{E}$ be a coherent sheaf on $X$ flat on $S$. Then, for every open subset $U$ of $X$, the restriction $\mathcal{E}(U) \rightarrow \mathcal{E}\left(U \backslash \pi^{-1}(P)\right)$ is injective.

Proof. Let $s \in \mathcal{E}(U)$ whose restriction to $U \backslash \pi^{-1}(P)$ vanishes. We must show that $s=0$. By covering $U$ with smaller open subsets we can suppose that $U$ is affine: $U=\operatorname{spec}(A)$. Hence $U \backslash \pi^{-1}(P)=\operatorname{spec}\left(A_{t}\right)$. Let $M=\mathcal{E}(U)$, it is an $A$-module. We have $\mathcal{E}_{\mid U}=\widetilde{M}$ and $\mathcal{E}\left(U \backslash \pi^{-1}(P)\right)=M_{t}$. Hence if the restriction of $s$ to $U \backslash \pi^{-1}(P)$ vanishes, there exists an integer
$n>0$ such that $t^{n} s=0$. Since the multiplication by $t$ is injective (because $\mathcal{E}$ is flat on $S$ ), we have $s=0$.

Let $\mathcal{E}$ be a coherent sheaf on $X$ flat on $S$. Let $\mathcal{F} \subset \mathcal{E}_{\mid X \backslash \pi^{-1}(P)}$ be a subsheaf. For every open subset $U$ of $X$ we denote by $\overline{\mathcal{F}}(U)$ the subset of $\mathcal{F}\left(U \backslash \pi^{-1}(P)\right)$ of elements that can be extended to sections of $\mathcal{E}$ on $U$. If $V \subset U$ is an open subset, the restriction $\mathcal{F}\left(U \backslash \pi^{-1}(P)\right) \rightarrow \mathcal{F}\left(V \backslash \pi^{-1}(P)\right)$ induces a morphism $\overline{\mathcal{F}}(U) \rightarrow \overline{\mathcal{F}}(V)$.
2.2.2. Proposition: $\overline{\mathcal{F}}$ is a subsheaf of $\mathcal{E}$, and $\mathcal{E} / \overline{\mathcal{F}}$ is flat on $S$.

Proof. To prove the first assertion, we must show that if $U$ is an open subset of $X$ and $\left(U_{i}\right)_{i \in I}$ is an open cover of $U$, then
(i) If $s \in \overline{\mathcal{F}}(U)$ is such that for every $i$ we have $s_{\mid U_{i}}=0$, then $s=0$.
(ii) For every $i \in I$ let $s_{i} \in \overline{\mathcal{F}}\left(U_{i}\right)$. Then if for all $i, j$ we have $s_{i \mid U_{i j}}=s_{j \mid U_{i j}}$, then there exists $s \in \overline{\mathcal{F}}(U)$ such that for every $i \in I$ we have $s_{\mid U_{i}}=s_{i}$.

This follows easily from lemma 2.2 .1 .
Now we prove that $\mathcal{E} / \overline{\mathcal{F}}$ is flat on $S$. Let $x \in \pi^{-1}(P)$ and $u \in(\mathcal{E} / \overline{\mathcal{F}})_{x}$ such that $t u=0$. We must show that $u=0$. Let $v \in \mathcal{E}_{x}$ over $u$. Then we have $t v \in \overline{\mathcal{F}}_{x}$. Let $U$ be a neighborhood of $x$ such that $t v$ comes from $w \in \overline{\mathcal{F}}(U)$. This means that $w_{\mid U \backslash \pi^{-1}(P)} \in \mathcal{F}\left(U \backslash \pi^{-1}(P)\right)$. Since $t$ is invertible on $U \backslash \pi^{-1}(P)$ we can write $w=t w^{\prime}$, with $w^{\prime} \in \mathcal{F}\left(U \backslash \pi^{-1}(P)\right)$. We have then $w^{\prime}=v$ on $U \backslash \pi^{-1}(P)$. Hence $v \in \overline{\mathcal{F}}_{x}$ and $u=0$.

### 2.3. Primitive multiple curves

(cf. [1], [2], [3], [4], [6], [7], 8], [10]).
Let $C$ be a smooth connected projective curve. A multiple curve with support $C$ is a CohenMacaulay scheme $Y$ such that $Y_{\text {red }}=C$.
Let $n$ be the smallest integer such that $Y=C^{(n-1)}, C^{(k-1)}$ being the $k$-th infinitesimal neighborhood of $C$, i.e. $\mathcal{I}_{C^{(k-1)}}=\mathcal{I}_{C}^{k}$. We have a filtration $C=C_{1} \subset C_{2} \subset \cdots \subset C_{n}=Y$ where $C_{i}$ is the biggest Cohen-Macaulay subscheme contained in $Y \cap C^{(i-1)}$. We call $n$ the multiplicity of $Y$.
We say that $Y$ is primitive if, for every closed point $x$ of $C$, there exists a smooth surface $S$, containing a neighborhood of $x$ in $Y$ as a locally closed subvariety. In this case, $L=\mathcal{I}_{C} / \mathcal{I}_{C_{2}}$ is a line bundle on $C$ and we have $\mathcal{I}_{C_{j}}=\mathcal{I}_{X}^{j}, \mathcal{I}_{C_{j}} / \mathcal{I}_{C_{j+1}}=L^{j}$ for $1 \leq j<n$. We call $L$ the line bundle on $C$ associated to $Y$. Let $P \in C$. Then there exist elements $y, t$ of $m_{S, P}$ (the maximal ideal of $\mathcal{O}_{S, P}$ ) whose images in $m_{S, P} / m_{S, P}^{2}$ form a basis, and such that for $1 \leq i<n$ we have $\mathcal{I}_{C_{i}, P}=\left(y^{i}\right)$.
The simplest case is when $Y$ is contained in a smooth surface $S$. Suppose that $Y$ has multiplicity $n$. Let $P \in C$ and $f \in \mathcal{O}_{S, P}$ a local equation of $C$. Then we have $\mathcal{I}_{C_{i}, P}=\left(f^{i}\right)$ for $1<j \leq n$, in particular $I_{Y, P}=\left(f^{n}\right)$, and $L=\mathcal{O}_{C}(-C)$.

We will write $\mathcal{O}_{n}=\mathcal{O}_{C_{n}}$ and we will see $\mathcal{O}_{i}$ as a coherent sheaf on $C_{n}$ with schematic support $C_{i}$ if $1 \leq i<n$.
If $\mathcal{E}$ is a coherent sheaf on $Y$ one defines its generalized $\operatorname{rank} R(\mathcal{E})$ and generalized degree $\operatorname{Deg}(\mathcal{E})$ (cf. [6], 3-): take any filtration of $\mathcal{E}$

$$
0=\mathcal{E}_{0} \subset \mathcal{E}_{1} \subset \cdots \subset \mathcal{E}_{n}=\mathcal{E}
$$

by subsheaves such that $\mathcal{E}_{i} / \mathcal{E}_{i-1}$ is concentrated on $C$ for $1 \leq i \leq n$, then

$$
R(\mathcal{E})=\sum_{i=1}^{n} \operatorname{rk}\left(\mathcal{E}_{i} / \mathcal{E}_{i-1}\right) \quad \text { and } \quad \operatorname{Deg}(\mathcal{E})=\sum_{i=1}^{n} \operatorname{deg}\left(\mathcal{E}_{i} / \mathcal{E}_{i-1}\right)
$$

Let $\mathcal{O}_{Y}(1)$ be a very ample line bundle on $Y$. Then the Hilbert polynomial of $\mathcal{E}$ is

$$
P_{\mathcal{E}}(m)=R(\mathcal{E}) \operatorname{deg}\left(\mathcal{O}_{C}(1)\right) m+\operatorname{Deg}(\mathcal{E})+R(\mathcal{E})(1-g)
$$

(where $g$ is the genus of $C$ ).
We deduce from proposition 2.1.1
2.3.1. Proposition: Let $Y$ be a multiple curve with support $C$. Then $Y$ is a primitive multiple curve if and only if $\mathcal{I}_{C} / \mathcal{I}_{C}^{2}$ is zero, or a line bundle on $C$.
2.3.2. Parametrization of double curves - In the case of double curves, D. Bayer and D. Eisenbud have obtained in [2] the following classification: if $Y$ is of multiplicity 2 , we have an exact sequence of vector bundles on $C$

$$
0 \longrightarrow L \longrightarrow \Omega_{Y \mid C} \longrightarrow \omega_{C} \longrightarrow 0
$$

which is split if and only if $Y$ is the trivial curve, i.e. the second infinitesimal neighborhood of $C$, embedded by the zero section in the dual bundle $L^{*}$, seen as a surface. If $Y$ is not trivial, it is completely determined by the line of $\operatorname{Ext}_{\mathcal{O}_{C}}^{1}\left(\omega_{C}, L\right)$ induced by the preceding exact sequence. The non trivial primitive curves of multiplicity 2 and of associated line bundle $L$ are therefore parametrized by the projective space $\mathbb{P}\left(\operatorname{Ext}_{\mathcal{O}_{C}}^{1}\left(\omega_{C}, L\right)\right)$.

### 2.4. Simple primitive multiple curves

Let $C$ be a smooth projective irreducible curve, $n \geq 2$ an integer and $C_{n}$ a primitive multiple curve of multiplicity $n$ and associated reduced curve $C$. Then the ideal sheaf $\mathcal{I}_{C}$ of $C$ in $C_{n}$ is a line bundle on $C_{n-1}$.

We say that $C_{n}$ is simple if $\mathcal{I}_{C} \simeq \mathcal{O}_{n-1}$.

In this case the line bundle on $C$ associated to $C_{n}$ is $\mathcal{O}_{C}$. The following result is proved in [8] (théorème 1.2.1):
2.4.1. Theorem: Suppose that $C_{n}$ is simple. Then there exists a flat family of smooth projective curves $\tau: \mathcal{C} \rightarrow \mathbb{C}$ such that $\tau^{-1}(0) \simeq C$ and that $C_{n}$ is isomorphic to the $n$-th infinitesimal neighborhood of $C$ in $\mathcal{C}$.

## 3. Reducible Reduced deformations of primitive multiples curves

### 3.1. Connected Components

Let $(S, P)$ be the germ of a smooth curve and $t \in \mathcal{O}_{S, P}$ a generator of the maximal ideal. Let $n>0$ be an integer and $Y=C_{n}$ a projective primitive multiple curve of multiplicity $n$.

Let $k>0$ be an integer. Let $\pi: \mathcal{C} \rightarrow S$ be a flat morphism, where $\mathcal{C}$ is a reduced algebraic variety, such that

- For every closed point $s \in S$ such that $s \neq P$, the fiber $\mathcal{C}_{s}$ has $k$ irreducible components, which are smooth and transverse, and any three of these components have no common point.
- The fiber $\mathcal{C}_{P}$ is isomorphic to $C_{n}$.

It is easy to see that the irreducible components of $\mathcal{C}$ are reduced surfaces.
Let $Z$ be the open subset of $\mathcal{C} \backslash \mathcal{C}_{P}$ of points $z$ belonging to only one irreducible component of $\mathcal{C}_{\pi(z)}$. Then the restriction of $\pi: Z \rightarrow S \backslash\{P\}$ is a smooth morphism. For every $s \in S \backslash\{P\}$, let $\mathcal{C}_{s}^{\prime}=\mathcal{C}_{s} \cap Z$. It is the open subset of smooth points of $\mathcal{C}_{s}$.
Let $z \in Z$ and $s=\pi(z)$. There exist a neighborhood (for the Euclidean topology) $U$ of $s$, isomorphic to $\mathbb{C}$, and a neighborhood $V$ of $z$ such that $V \simeq \mathbb{C}^{2}, \pi(V)=U$, the restriction of $\pi: V \rightarrow U$ being the projection $\mathbb{C}^{2} \rightarrow \mathbb{C}$ on the first factor. We deduce easily from that the following facts:

- let $s \in S \backslash\{P\}$ and $C_{1}$ an irreducible component of $\mathcal{C}_{s}$. Let $z_{1}, z_{2} \in C_{1} \cap Z$. Then there exist neighborhoods (in $Z$, for the Euclidean topology) $U_{1}, U_{2}$ of $z_{1}, z_{2}$ respectively, such that if $y_{1} \in U_{1}, y_{2} \in U_{2}$ are such that $\pi\left(y_{1}\right)=\pi\left(y_{2}\right)$, then $y_{1}$ and $y_{2}$ belong to the same irreducible component of $\mathcal{C}_{\pi\left(y_{1}\right)}$.
- for every continuous map $\sigma:[0,1] \rightarrow S \backslash\{P\}$ and every $z \in Z$ such that $\sigma(0)=\pi(z)$ there exists a lifting of $\sigma, \sigma^{\prime}:[0,1] \rightarrow Z$ such that $\sigma^{\prime}(0)=z$. Moreover, if $\sigma^{\prime \prime}:[0,1] \rightarrow Z$ is another lifting of $\sigma$ such that $\sigma^{\prime \prime}(0)=z$, then $\sigma^{\prime}(1)$ and $\sigma^{\prime \prime}(1)$ are in the same irreducible component of $\mathcal{C}_{\sigma(1)}$. More generally, if we only impose that $\sigma^{\prime \prime}(0)$ is in the same irreducible component of $\mathcal{C}_{\sigma(0)}$ as $z$, then $\sigma^{\prime}(1)$ and $\sigma^{\prime \prime}(1)$ are in the same irreducible component of $\mathcal{C}_{\sigma(1)}$.
3.1.1. Lemma: Let $\sigma_{0}, \sigma_{1}:[0,1] \rightarrow S \backslash\{P\}$ be two continuous maps such that $\sigma_{0}(0)=\sigma_{1}(0), s=\sigma_{0}(1)=\sigma_{1}(1)$. Suppose that they are homotopic. Let $\sigma_{0}^{\prime}$, $\sigma_{1}^{\prime}$ be liftings $[0,1] \rightarrow Z$ of $\sigma_{0}$, $\sigma_{1}$ respectively, such that $\sigma_{0}^{\prime}(0)=\sigma_{1}^{\prime}(0)$. Then $\sigma_{0}^{\prime}(1)$ and $\sigma_{1}^{\prime}(1)$ belong to the same irreducible component of $\mathcal{C}_{s}^{\prime}$.

Proof. Let

$$
\Psi:[0,1] \times[0,1] \longrightarrow S \backslash\{P\}
$$

be an homotopy:

$$
\Psi(0, t)=\sigma_{0}(t), \quad \Psi(1, t)=\sigma_{1}(t), \quad \Psi(t, 0)=\sigma_{0}(0), \quad \Psi(t, 1)=\sigma_{0}(1)
$$

for $0 \leq t \leq 1$. For every $u \in[0,1]$ and $\epsilon>0$ let $I_{u, \epsilon}=[u-\epsilon, u+\epsilon] \cap[0,1]$. By using the local structure of $\pi_{\mid Z}$ for the Euclidean topology it is easy to see that for every $u \in[0,1]$, there exists
an $\epsilon>0$ such that the restriction of $\Psi$

$$
I_{u, \epsilon} \times[0,1] \longrightarrow S \backslash\{P\}
$$

can be lifted to a morphism

$$
\Psi^{\prime}: I_{u, \epsilon} \times[0,1] \longrightarrow Z
$$

such that $\Psi^{\prime}(t, 0)=\sigma_{0}^{\prime}(0)$ for every $t \in I_{u, \epsilon}$. It follows that if $I_{u, \epsilon}=\left[a_{u, \epsilon}, b_{u, \epsilon}\right]$, then $\Psi^{\prime}\left(a_{u, \epsilon}, 1\right)$ and $\Psi^{\prime}\left(b_{u, \epsilon}, 1\right)$ are in the same irreducible component of $\mathcal{C}_{\sigma_{0}(1)}^{\prime}$. We have just to cover $[0,1]$ with a finite number of intervals $I_{u, \epsilon}$ to obtain the result.

Let $s \in S \backslash\{P\}, D_{1}, \ldots, D_{k}$ be the irreducible components of $\mathcal{C}_{s}^{\prime}$ and $x_{i} \in D_{i}$ for $1 \leq i \leq k$. Let $\sigma$ be a loop of $S \backslash\{P\}$ with origin $s$, defining a generator of $\pi_{1}(S \backslash\{P\})$. Let $i$ be an integer such that $1 \leq i \leq k$. The liftings $\sigma^{\prime}:[0,1] \rightarrow Z$ of $\sigma$ such that $\sigma^{\prime}(0)=x_{i}$ end up at a component $D_{j}$ which does not depend on $x_{i}$. Hence we can write

$$
j=\alpha_{\mathcal{C}}(i)
$$

3.1.2. Lemma: $\alpha_{\mathcal{C}}$ is a permutation of $\{1, \ldots, k\}$.

Proof. Suppose that $i \neq j$ and $\alpha_{\mathcal{C}}(i)=\alpha_{\mathcal{C}}(j)$. By inverting the paths we find liftings of paths from $D_{\alpha_{\mathcal{C}}(i)}$ to $D_{i}$ and $D_{j}$. This contradicts lemma 3.1.1.

Let $p>0$ be an integer such that $\alpha_{\mathcal{C}}^{p}=I_{\{1, \cdots, k\}}$. Let $t$ be a generator of the maximal ideal of $\mathcal{O}_{S, P}, K$ the field of rational functions on $S$ and $K^{\prime}=K\left(t^{1 / p}\right)$. Let $S^{\prime}$ be the germ of the curve corresponding to $K^{\prime}, \theta: S^{\prime} \rightarrow S$ canonical the morphism and $P^{\prime}$ the unique point of $\theta^{-1}(P)$. Let $\mathcal{D}=\theta^{*}(\mathcal{C})$. We have therefore a cartesian diagram

where $\rho$ is flat, and for every $s^{\prime} \in S^{\prime}, \Theta$ induces an isomorphism $\mathcal{D}_{s^{\prime}} \simeq \mathcal{C}_{\theta\left(s^{\prime}\right)}$. We have

$$
\alpha_{\mathcal{D}}=I_{\{1, \ldots, k\}}
$$

Let $Z^{\prime} \subset \mathcal{D}$ be the complement of the union of $\rho^{-1}\left(P^{\prime}\right)$ and of the singular points of the curves $\mathcal{D}_{s^{\prime}}, s^{\prime} \neq P^{\prime}\left(\right.$ hence $\left.Z^{\prime}=\Theta^{-1}(Z)\right)$.
3.1.3. Proposition: The open subset $Z^{\prime}$ has exactly $k$ irreducible components $Z_{1}^{\prime}, \ldots, Z_{k}^{\prime}$. Let $\overline{Z_{1}^{\prime}}, \ldots, \overline{Z_{k}^{\prime}}$ be their closures in $\mathcal{D}$. Then for every $s^{\prime} \in S^{\prime} \backslash\left\{P^{\prime}\right\}$, the $Z_{i}^{\prime} \cap \mathcal{D}_{s^{\prime}}, 1 \leq i \leq k$, are the irreducible components of $\mathcal{D}_{s^{\prime}}$ minus the intersection points with the other components, and the $\overline{Z_{i}^{\prime}} \cap \mathcal{D}_{s^{\prime}}$ are the irreducible components of $\mathcal{D}_{s^{\prime}}$.
3.1.4. Definition: Let $k>0$ be an integer. A reducible deformation of length $k$ of $C_{n}$ is a flat morphism $\pi: \mathcal{C} \rightarrow S$, where $\mathcal{C}$ is a reduced algebraic variety, such that

- For every closed point $s \in S, s \neq P$, the fiber $\mathcal{C}_{s}$ has $k$ irreducible components, which are smooth and transverse, and any three of these components have no common point.
- The fiber $\mathcal{C}_{P}$ is isomorphic to $C_{n}$.
- We have $\alpha_{\mathcal{C}}=I_{\{1, \ldots, k\}}$.


### 3.2. Maximal Reducible deformations

Let $(S, P)$ be the germ of a smooth curve and $t \in \mathcal{O}_{S, P}$ a generator of the maximal ideal. Let $n>0$ be an integer and $Y=C_{n}$ a projective primitive multiple curve of multiplicity $n$, with underlying smooth curve $C$. We denote by $g$ the genus of $C$ and $L$ the line bundle on $C$ associated to $C_{n}$.
Let $\pi: \mathcal{C} \rightarrow S$ be a reducible deformation of length $k$ of $C_{n}$. Let $Z_{1}, \ldots, Z_{k}$ be the closed subvarieties of $\pi^{-1}(S \backslash\{P\})$ such that for every $s \in S \backslash\{P\}, Z_{1 s}, \ldots, Z_{k s}$ are the irreducible components of $\mathcal{C}_{s}$ (cf. prop. 3.1.3).
For $1 \leq i \leq k$, we denote by $\mathcal{J}_{i}$ the ideal sheaf of $Z_{1} \cup \cdots \cup Z_{i}$ in $\pi^{-1}(S \backslash\{P\})$. This sheaf is flat on $S \backslash\{P\}$, and we have

$$
0=\mathcal{J}_{k} \subset \mathcal{J}_{k-1} \subset \cdots \subset \mathcal{J}_{1} \subset \mathcal{O}_{\pi^{-1}(S \backslash\{P\})}
$$

The quotients $\mathcal{O}_{\pi^{-1}(S \backslash\{P\})} / \mathcal{J}_{1}, \mathcal{J}_{i} / \mathcal{J}_{i+1}, 1 \leq i<k$, are also flat on $S \backslash\{P\}$. We obtain the filtration of sheaves on $\mathcal{C}$

$$
0=\overline{\mathcal{J}_{k}} \subset \overline{\mathcal{J}_{k-1}} \subset \cdots \subset \overline{\mathcal{J}_{1}} \subset \mathcal{O}_{\mathcal{C}}
$$

(cf. 2.2). According to proposition 2.2 .2 the quotients $\mathcal{O}_{\mathcal{C}} / \overline{\mathcal{J}}_{1}$ and $\overline{\mathcal{J}_{i}} / \overline{\mathcal{J}_{i+1}}, 1 \leq i<n$, are flat on $S$. We have $\mathcal{O}_{\pi^{-1}(S \backslash\{P\})} / \mathcal{J}_{1}=\mathcal{O}_{Z_{1}}$. We denote by $\mathbf{X}_{i}$ the closed subvariety of $\mathcal{C}$ corresponding to the ideal sheaf $\overline{\mathcal{J}}_{i}$.
Similarly we consider the ideal sheaf $\mathcal{J}_{i}^{\prime}$ of $Z_{i+1} \cup \cdots \cup Z_{n}$ on $\pi^{-1}(S \backslash\{P\})$, the associated ideal sheaf $\overline{\mathcal{J}_{i}^{\prime}}$ on $\mathcal{C}$ and the corresponding subvariety $\mathbf{X}_{i}^{\prime}$.
3.2.1. Proposition: We have $k \leq n$.

Proof. Let $\mathcal{E}_{0}=\mathcal{O}_{\mathcal{C}} / \overline{\mathcal{J}_{1}}$ and $\mathcal{E}_{i}=\overline{\mathcal{J}_{i}} / \overline{\mathcal{J}_{i+1}}$ for $1 \leq i<n$. The sheaves $\mathcal{E}_{i P}$ are not concentrated on a finite number of points. To see this we use a very ample line bundle $\mathcal{O}(1)$ on $\mathcal{C}$. The Hilbert polynomial of $\mathcal{E}_{i P}$ is the same as that of $\mathcal{E}_{i s}, s \neq P$, hence it is not constant. So we have $R\left(\mathcal{E}_{i}\right) \geq 1\left(R\left(\mathcal{E}_{i}\right)\right.$ is the generalized rank of $\mathcal{E}_{i}$, cf. 2.3), and since

$$
\begin{equation*}
n=R\left(\mathcal{O}_{C_{n}}\right)=\sum_{i=0}^{k} R\left(\mathcal{E}_{i P}\right) \tag{1}
\end{equation*}
$$

we have $k \leq n$.
3.2.2. Definition: We say that $\pi($ or $\mathcal{C})$ is a maximal reducible deformation of $C_{n}$ if $k=n$.
3.2.3. Theorem: Suppose that $\mathcal{C}$ is a maximal reducible deformation of $C_{n}$. Then we have, for $1 \leq i<n$

$$
\overline{\mathcal{J}},^{i}=\mathcal{I}_{C_{i}, C_{n}}
$$

and $\mathbf{X}_{i}$ is a maximal reducible deformation of $C_{i}$.

Proof. Let $\mathcal{O}_{\mathcal{C}}(1)$ be a very ample line bundle on $\mathcal{C}$.
Let $Q$ be a closed point of $C$. Let $z \in \mathcal{O}_{n, Q}$ be an equation of $C$ and $x \in \mathcal{O}_{n, Q}$ over a generator of the maximal ideal of $Q$ in $\mathcal{O}_{C, Q}$. Let $\mathbf{z}, \mathbf{x} \in \mathcal{O}_{\mathcal{C}, Q}$ be over $z, x$ respectively. The maximal ideal of $\mathcal{O}_{n, Q}$ is $(x, z)$. The maximal ideal of $\mathcal{O}_{\mathcal{C}, Q}$ is generated by $\mathbf{z}, \mathbf{x}, t$. It follows from proposition 2.1.1 that there exist a neighborhood $U$ of $Q$ in $\mathcal{C}$ and an embedding $j: U \rightarrow \mathbb{P}_{3}$. We can assume that the restriction of $j$ to $\overline{Z_{1}} \cap U$ is induced by the morphism $\phi: \mathbb{C}[X, Z, T] \rightarrow \mathcal{O}_{\overline{Z_{1}}, Q}$ of $\mathbb{C}$-algebras which associates $x, z, t$ to $X, Z, T$ respectively.
Since $\mathcal{C}$ is reduced, $U$ is an open subset of a reduced hypersurface of $\mathbb{P}_{3}$ having $n$ irreducible components, corresponding to $\overline{Z_{1}}, \ldots, \overline{Z_{n}}$. It is then clear that $\mathbf{X}_{i}$, being the smallest subscheme of $\mathcal{C}$ containing $Z_{1} \backslash C, \ldots, Z_{i} \backslash C$, is the union in $U$ of the first $i$ hypersurface components.
Since $j\left(\overline{Z_{1}}\right)$ is a hypersurface, the kernel of $\phi$ is a principal ideal generated by the equation $F$ of the image of $Z_{1}$.
Recall that $\mathcal{O}_{n}=\mathcal{O}_{C_{n}}=\left(\mathcal{O}_{\mathcal{C}}\right)_{P}$. We have $R\left(\mathcal{O}_{n} / \overline{\mathcal{J}}_{1},{ }_{P}\right)=1$ according to (11). Hence there exists a nonempty open subset $V$ of $C_{n}$ such that $\left(\mathcal{O}_{n} / \overline{\mathcal{J}}_{1}, P\right)_{\mid V}$ is a line bundle on $V \cap C$. It follows that the projection $\mathcal{O}_{n} \rightarrow \mathcal{O}_{C}$ vanishes on $\overline{\mathcal{J}}_{1},{ }_{P \mid V}$. Since $\mathcal{O}_{C}$ is torsion free this projection vanishes everywhere on $\overline{\mathcal{J}_{1}}$, i.e. $\overline{\mathcal{J}_{1}} \subset \mathcal{I}_{C, C_{n}}$, with equality on $V$.
The sheaf $\mathcal{E}_{0}=\mathcal{O}_{\mathcal{C}} / \overline{\mathcal{J}_{1}}$ is the structural sheaf of $\overline{Z_{1}}$, and the projection $\overline{Z_{1}} \rightarrow S$ is a flat morphism. For every $s \in S \backslash\{P\},\left(\overline{Z_{1}}\right)_{s}$ is a smooth curve. The fiber $\left(\overline{Z_{1}}\right)_{P}$ consists of $C$ and a finite number of embedded points. There exist flat families of curves whose general fiber is smooth and the special fiber consists of an integral curve and some embedded points (cf. [12], III, Example 9.8.4). We will show that this cannot happen in our case, i.e. we have $\overline{\mathcal{J}}_{1 P}=\mathcal{I}_{C, C_{n}}$.
Let $\mathbf{m}=(X, Z, T) \subset \mathbb{C}[X, Z, T]$, and $\mathbf{m}_{Z_{1}}$ the maximal ideal of $\mathcal{O}_{\overline{Z_{1}}, Q}$. The ideal of $\left(\overline{Z_{1}}\right)_{P}$ in $\mathcal{O}_{n, Q}$ contains $z^{q}$ and $x^{p} z$ (for suitable minimal integers $p \geq 0, q>0$ ), with $p>0$ if and only if $Q$ is an embedded point. Hence the ideal of $\overline{Z_{1}}$ in $\mathcal{O}_{\mathcal{C}, Q}$ contains elements of type $\mathbf{x}^{p} \mathbf{z}-t \alpha$, $\mathbf{z}^{q}-t \beta$, with $\alpha, \beta \in \mathcal{O}_{\mathcal{C}, Q}$.
Let $\widehat{\mathcal{O}_{\overline{Z_{1}}, Q}}$ be the completion of $\mathcal{O}_{\overline{Z_{1}}, Q}$ with respect to $\mathbf{m}_{Z_{1}}$ and

$$
\widehat{\phi}: \mathbb{C}((X, Z, T)) \longrightarrow \widehat{\mathcal{O}_{\overline{Z_{1}}, Q}}
$$

the morphism deduced from $\phi$. We can also see $\widehat{\widehat{\mathcal{O}_{\overline{Z_{1}}, Q}}}$ as the completion with respect to $(X, Z, T)$ of $\mathcal{O}_{\overline{Z_{1}}, Q}$ seen as a $\mathbb{C}[X, Z, T]$-module. It follows that $\operatorname{ker}(\widehat{\phi})=(F)$ (cf. [9], lemma 7.15). Note that $\widehat{\phi}$ is surjective (this is why we use completions). Let $\boldsymbol{\alpha}, \boldsymbol{\beta} \in \mathbb{C}((X, Y, Z))$ be such that $\widehat{\phi}(\boldsymbol{\alpha})=\alpha, \widehat{\phi}(\boldsymbol{\beta})=\beta$. So we have

$$
X^{p} Z-T \boldsymbol{\alpha}, Z^{q}-T \boldsymbol{\beta} \in \operatorname{ker}(\widehat{\phi})
$$

Hence there exist $A, B \in \mathbb{C}((X, Z, T))$ such that $X^{p} Z-T \boldsymbol{\alpha}=A F, Z^{q}-T \boldsymbol{\beta}=B F$. We can write in an unique way

$$
A=A_{0}+T A_{1}, B=B_{0}+T B_{1}, F=F_{0}+T F_{1}
$$

with $A_{0}, B_{0}, F_{0} \in \mathbb{C}((X, Z))$ and $A_{1}, B_{1}, F_{1} \in \mathbb{C}((X, Z, T))$, and we have

$$
A_{0} F_{0}=X^{p} Z, B_{0} F_{0}=Z^{q}
$$

Since $F$ is not invertible, it follows that $F_{0}$ is of the form $F_{0}=c Z$, with $c \in \mathbb{C}((X, Z, T))$ invertible. So we have $F=c Z+T F_{1}$. It follows that $z \in(t)$ in $\widehat{\mathcal{O}_{\overline{Z_{1}}, Q}}$. This implies that this is also true in $\mathcal{O}_{\overline{Z_{1}}, Q}$ : in fact the assertion in $\widehat{\mathcal{O}_{\overline{Z_{1}}, Q}}$ implies that

$$
z \in \bigcap_{n \geq 0}\left((t)+\mathbf{m}_{Z_{1}}^{n}\right)
$$

in $\mathcal{O}_{\overline{Z_{1}}, Q}$, and the latter is equal to $(t)$ according to [14], vol. II, chap. VIII, theorem 9. Hence $z \in(t)$ in $\mathcal{O}_{\overline{Z_{1}}, Q}$, i.e. $p=0$ and $Q$ is not an embedded point. So there are no embedded points. This implies that $\overline{\mathcal{J}}_{1 P}=\mathcal{I}_{C, C_{n}}$. Similarly, if $I_{j}$ denotes the ideal sheaf of $\overline{Z_{j}}$ for $1 \leq j \leq n$, we have $I_{j, P}=\mathcal{I}_{C, C_{n}}$. Since the restriction of $\pi: \overline{Z_{j}} \rightarrow S$ is flat, the curves $\mathcal{E}_{j, s}, s \neq P$, have the same genus as $C$, and the same Hilbert polynomial with respect to $\mathcal{O}_{\mathcal{C}}(1)$.
Now we show that $\mathbf{X}_{1}^{\prime}$ is a maximal reducible deformation of $C_{n-1}$. We need only to show that $\mathbf{X}_{1, P}^{\prime}=C_{n-1}$. As we have seen, for $2 \leq j \leq n$, a local equation of $\overline{Z_{j}}$ at any point $Q \in C$ induces a generator $u_{j}$ of $\mathcal{I}_{C, C_{n}, Q}$. Hence $u=\prod_{2 \leq j \leq n} u_{j}$ is a generator of $\mathcal{I}_{C_{n-1}, C_{n}, Q}$. But $u=0$ on $\mathbf{X}_{1}^{\prime}$. It follows that $\mathbf{X}_{1, P}^{\prime} \subset C_{n-1}$. But the Hilbert polynomial of $\mathcal{O}_{C_{n-1}}$ is the same as that of the structural sheaves of the fibers of the flat morphism $\mathbf{X}_{1}^{\prime} \rightarrow S$ over $s \neq P$, hence the same as $\mathcal{O}_{\mathbf{X}_{1, P}^{\prime}}$. Hence $\mathbf{X}_{1, P}^{\prime}=C_{n-1}$.
The theorem 3.2 .3 is then easily proved by induction on $n$.
3.2.4. Corollary: Let $s \in S \backslash\{P\}$ and $D_{1}, D_{2}$ be two irreducible components of $\mathcal{C}_{s}$. Then $D_{1}$ is of genus $g$ and $D_{1} \cap D_{2}$ consists of $-\operatorname{deg}(L)$ points.

Proof. According to theorem 3.2.3, there exists a flat family of smooth curves $\mathbf{C}$ parametrized by $S$ such that $\mathbf{C}_{P}=C$ and $\mathbf{C}_{s}=D_{1}$. So the genus of $D_{1}$ is equal to that of $C$.
Let us prove the second assertion. Again according to theorem 3.2.3 we can suppose that $n=2$. We have then $\chi\left(\mathcal{C}_{s}\right)=\chi\left(C_{2}\right)=2 \chi(C)+\operatorname{deg}(L)$. Let $x_{1}, \ldots, x_{N}$ be the intersection points of $D_{1}$ and $D_{2}$. We have an exact sequence

$$
0 \longrightarrow \mathcal{O}_{D_{2}}\left(-x_{1}-\cdots-x_{N}\right) \longrightarrow \mathcal{O}_{\mathcal{C}_{s}} \longrightarrow \mathcal{O}_{D_{1}} \longrightarrow 0
$$

Whence $\quad \chi\left(\mathcal{O}_{\mathcal{C}_{s}}\right)=\chi\left(D_{1}\right)+\chi\left(D_{2}\right)-N=2 \chi\left(\mathcal{O}_{C}\right)-N$ (according to the first assertion). Whence $N=-\operatorname{deg}(L)$.
3.2.5. It follows from the previous results that if $\pi: \mathcal{C} \rightarrow S$ is a maximal reducible deformation of $C_{n}$, then we have
(i) $\operatorname{deg}(L) \leq 0$.
(ii) $\mathcal{C}$ has exactly $n$ irreducible components $\mathcal{C}_{1} \ldots, \mathcal{C}_{n}$.
(iii) For $1 \leq i \leq n$, the restriction of $\pi, \pi_{i}: \mathcal{C}_{i} \rightarrow S$ is a flat morphism, and $\pi_{i}^{-1}(P)=C$.
(iv) For every nonempty subset $I \subset\{1, \ldots, n\}$, let $\mathcal{C}_{I}$ be the union of the $\mathcal{C}_{i}$ such that $i \in I$, and $m$ the number of elements of $I$. Then the restriction of $\pi, \pi_{I}: \mathcal{C}_{I} \rightarrow S$ is a maximal reducible deformation of $C_{m}$.

The following is immediate, and shows that we need only to consider maximal reducible deformations parametrized by a neighborhood of 0 in $\mathbb{C}$ :
3.2.6. Proposition: Let $t \in \mathcal{O}_{S}(P)$ be a generator of the maximal ideal, and $\pi: \mathcal{C} \rightarrow S$ a maximal reducible deformation of $C_{n}$. Let $S^{\prime} \subset S$ be an open neighborhood of $P$ where $t$ is defined and $\mathcal{C}^{\prime}=\pi^{-1}(U), V=t(U)$. Then $\pi^{\prime}=t \circ \pi: \mathcal{C}^{\prime} \rightarrow V$ is a maximal reducible deformation of $C_{n}$.

## 4. Fragmented deformations of primitive multiple curves

The fragmented deformations of primitive multiple curves are particular cases of reducible deformations.
In this chapter $(S, P)$ denotes the germ of a smooth curve. Let $t \in \mathcal{O}_{S, P}$ be a generator of the maximal ideal of $P$. We can suppose that $t$ is defined on the whole of $S$, and that the ideal sheaf of $P$ in $S$ is generated by $t$.

### 4.1. Fragmented deformations and gluing

Let $n>0$ be an integer and $Y=C_{n}$ a projective primitive multiple curve of multiplicity $n$.
4.1.1. Definition: Let $k>0$ be an integer. A general fragmented deformation of length $k$ of $C_{n}$ is a flat morphism $\pi: \mathcal{C} \rightarrow S$ such that for every point $s \neq P$ of $S$, the fiber $\mathcal{C}_{s}$ is a disjoint union of $k$ projective smooth irreducible curves, and such that $\mathcal{C}_{P}$ is isomorphic to $C_{n}$.

We have then $k \leq n$. If $k=n$ we say that $\pi$ (or $\mathcal{C}$ ) is a general maximal fragmented deformation of $C_{n}$. We suppose in the sequel that it is the case.
The line bundle on $C$ associated to $C_{n}$ is $\mathcal{O}_{C}$ (by proposition 3.2.4).
Let $p>0$ be an integer. Let $K$ be the field of rational functions on $S$ and $K^{\prime}=K\left(t^{1 / p}\right)$. Let $S^{\prime}$ be the germ of curve corresponding to $K^{\prime}, \theta: S^{\prime} \rightarrow S$ the canonical morphism and $P^{\prime}$ the unique point of $\theta^{-1}(P)$. Let $\mathcal{D}=\theta^{*}(\mathcal{C})$. So we have a cartesian diagram

where $\rho$ is flat, and for every $s^{\prime} \in S^{\prime}, \Theta$ induces an isomorphism $\mathcal{D}_{s^{\prime}} \simeq \mathcal{C}_{\theta\left(s^{\prime}\right)}$.
4.1.2. Proposition: For a suitable choice of $p, \mathcal{D}$ has exactly $n$ irreducible components $\mathcal{D}_{1}, \ldots, \mathcal{D}_{n}$, and for every point $s \neq P^{\prime}$ of $S^{\prime}, \mathcal{D}_{1 s}, \ldots, \mathcal{D}_{n s}$ are the irreducible components of $\mathcal{D}_{s}$, for $1 \leq i \leq n$ the restriction of $\rho: \mathcal{D}_{i s} \rightarrow S^{\prime}$ is flat, and $\mathcal{D}_{P^{\prime}}=C_{n}$.
(See proposition 3.1.3)
4.1.3. Definition: $A$ fragmented deformation of $C_{n}$ is a general maximal fragmented deformation of length $n$ of $C_{n}$ having $n$ irreducible components.

We suppose in the sequel that $\mathcal{C}$ is a fragmented deformation of $C_{n}$, union of $n$ irreducible components $\mathcal{C}_{1}, \ldots, \mathcal{C}_{n}$.
4.1.4. Proposition: Let $I \subset\{1, \ldots, n\}$ be a nonempty subset having $m$ elements. Let $\mathcal{C}_{I}=\cup_{i \in I} \mathcal{C}_{i}$. Then the restriction of $\pi, \mathcal{C}_{I} \rightarrow S$, is flat, and the fiber $\mathcal{C}_{I P}$ is canonically isomorphic to $C_{m}$.
(See 3.2.5)

In particular there exists a filtration of ideal sheaves

$$
0 \subset \mathcal{I}_{1} \subset \cdots \subset \mathcal{I}_{n-1} \subset \mathcal{O}_{\mathcal{C}}
$$

such that for $1 \leq i<n$ and $s \in S \backslash\{P\}, \mathcal{I}_{i s}$ is the ideal sheaf of $\cup_{j=i}^{n} \mathcal{C}_{j s}$, and that $\mathcal{I}_{i P}$ is that of $C_{n-i}$.
4.1.5. Definition: For $1 \leq i \leq n$, let $\pi_{i}: \mathcal{C}_{i} \rightarrow S$ be a flat family of smooth projective irreducible curves, with a fixed isomorphism $\pi_{i}^{-1}(P) \simeq C$. A gluing of $\mathcal{C}_{1}, \cdots, \mathcal{C}_{n}$ along $C$ is an algebraic variety $\mathcal{D}$ such that

- for $1 \leq i \leq n, \mathcal{C}_{i}$ is isomorphic to a closed subvariety of $\mathcal{D}$, also denoted by $\mathcal{C}_{i}$, and $\mathcal{D}$ is the union of these subvarieties.
- $\coprod_{1 \leq i \leq n}\left(\mathcal{C}_{i} \backslash C\right)$ is an open subset of $\mathcal{D}$.
- There exists a morphism $\pi: \mathcal{D} \rightarrow S$ inducing $\pi_{i}$ on $\mathcal{C}_{i}$, for $1 \leq i \leq n$.
- The subvarieties $C=\pi_{i}^{-1}(P)$ of $\mathcal{C}_{i}$ coincide in $\mathcal{D}$.

For example the previous fragmented deformation $\mathcal{C}$ of $C_{n}$ is a gluing of $\mathcal{C}_{1}, \cdots, \mathcal{C}_{n}$ along $C$.
All the gluings of $\mathcal{C}_{1}, \cdots, \mathcal{C}_{n}$ along $C$ have the same underlying Zariski topological space.
Let $\mathcal{A}$ be the initial gluing of the $\mathcal{C}_{i}$ along $C$. It is an algebraic variety whose points are the same as those of $\mathcal{C}$, i.e.

$$
\left(\coprod_{i=1}^{n} \mathcal{C}_{i}\right) / \sim
$$

where $\sim$ is the equivalence relation: if $x \in \mathcal{C}_{i}$ and $y \in \mathcal{C}_{j}, x \sim y$ if and only if $x=y$, or if $x \in \mathcal{C}_{i P} \simeq C, y \in \mathcal{C}_{j P} \simeq C$ and $x=y$ in $C$. The structural sheaf is defined by: for every open subset $U$ of $\mathcal{A}$

$$
\mathcal{O}_{\mathcal{A}}(U)=\left\{\left(\alpha_{1}, \ldots, \alpha_{n}\right) \in \mathcal{O}_{\mathcal{C}_{1}}\left(U \cap \mathcal{C}_{1}\right) \times \cdots \times \mathcal{O}_{\mathcal{C}_{n}}\left(U \cap \mathcal{C}_{n}\right) ; \alpha_{1 \mid C}=\cdots=\alpha_{n \mid C}\right\} .
$$

For every gluing $\mathcal{D}$ of $\mathcal{C}_{1}, \cdots, \mathcal{C}_{n}$, we have an obvious dominant morphism $\mathcal{A} \rightarrow \mathcal{D}$. If follows that the sheaf of rings $\mathcal{O}_{\mathcal{D}}$ can be seen as a subsheaf of $\mathcal{O}_{\mathcal{A}}$.
The fiber $D=\mathcal{A}_{P}$ is not a primitive multiple curve (if $n>2$ ): if $\mathcal{I}_{C, D}$ denotes the ideal sheaf of $C$ in $D$ we have $\mathcal{I}_{C, D}^{2}=0$, and $\mathcal{I}_{C, D} \simeq \mathcal{O}_{C} \otimes \mathbb{C}^{n-1}$.
4.1.6. Proposition: Let $\mathcal{D}$ be a gluing of $\mathcal{C}_{1}, \cdots, \mathcal{C}_{n}$. Then $\pi^{-1}(P)$ is a primitive multiple curve if and only if for every closed point $x$ of $C$, there exists a neighborhood of $x$ in $\mathcal{D}$ that can be embedded in a smooth variety of dimension 3.

Proof. Suppose that $\pi^{-1}(P)$ is a primitive multiple curve. Then $\mathcal{I}_{C} /\left(\mathcal{I}_{C}^{2}+(\pi)\right)$ is a principal module at $x$ : suppose that the image of $u \in m_{\mathcal{D}, x}$ is a generator. The module $m_{\mathcal{D}, x} / \mathcal{I}_{C}$ is also principal (since it is the maximal ideal of $x$ in $C$ ): suppose that the image of $v \in m_{\mathcal{D}, x}$ is a generator. Then the images of $u, v, \pi$ generate $m_{\mathcal{D}, x} / m_{\mathcal{D}, x}^{2}$, so according to proposition 2.1.1, we can locally embed $\mathcal{D}$ in a smooth variety of dimension 3 .
Conversely, suppose that a neighborhood of $x \in C$ in $\mathcal{D}$ is embedded in a smooth variety $Z$ of dimension 3. The proof of the fact that $\pi^{-1}(P)$ is Cohen-Macaulay is similar to that of theorem 3.2.3. We can suppose that $\pi$ is defined on $Z$. We have $\pi_{\mid \mathcal{C}_{1}}=\pi_{1} \notin m_{\mathcal{C}_{1}, x}^{2}$, so $\pi \notin m_{Z, x}^{2}$. It follows that the surface of $Z$ defined by $\pi$ is smooth at $x$, and that we can locally embed $\pi^{-1}(P)$ in a smooth surface. Hence $\pi^{-1}(P)$ is a primitive multiple curve.

### 4.2. Fragmented deformations of length 2

Let $\pi: \mathcal{C} \rightarrow S$ be a fragmented deformation of $C_{2}$. So $\mathcal{C}$ has two irreducible components $\mathcal{C}_{1}, \mathcal{C}_{2}$. Let $\mathcal{A}$ be the initial gluing of $\mathcal{C}_{1}$ and $\mathcal{C}_{2}$ along $C$. For every open subset $U$ of $\mathcal{C}, U$ is also an open subset of $\mathcal{A}$ and $\mathcal{O}_{\mathcal{C}}(U)$ is a sub-algebra of $\mathcal{O}_{\mathcal{A}}(U)$. For $i=1,2$, let $\pi_{i}: \mathcal{C}_{i} \rightarrow S$ be the restriction of $\pi$. We will also denote $t \circ \pi$ by $\pi$, and $t \circ \pi_{i}$ by $\pi_{i}$. So we have $\pi=\left(\pi_{1}, \pi_{2}\right) \in \mathcal{O}_{\mathcal{C}}(\mathcal{C})$.
Let $\mathcal{I}_{C}$ be the ideal sheaf of $C$ in $\mathcal{C}$. Since $C_{2}=\pi^{-1}(P)$ we have $\mathcal{I}_{C}^{2} \subset\left\langle\left(\pi_{1}, \pi_{2}\right)\right\rangle$.
Let $m>0$ be an integer, $x \in C, \alpha_{1} \in \mathcal{O}_{\mathcal{C}_{1}, x}, \alpha_{2} \in \mathcal{O}_{\mathcal{C}_{2}, x}$. We denote by $\left[\alpha_{1}\right]_{m}$ (resp. [ $\left.\alpha_{2}\right]_{m}$ ) the image of $\alpha_{1}\left(\right.$ resp. $\left.\alpha_{2}\right)$ in $\mathcal{O}_{\mathcal{C}_{1}, x} /\left(\pi_{1}^{m}\right)\left(\operatorname{resp} . \mathcal{O}_{\mathcal{C}_{2}, x} /\left(\pi_{2}^{m}\right)\right)$.
4.2.1. Proposition: 1 - There exists an unique integer $p>0$ such that $\mathcal{I}_{C} /\left\langle\left(\pi_{1}, \pi_{2}\right)\right\rangle$ is generated by the image of $\left(\pi_{1}^{p}, 0\right)$.
$\mathbf{2}$ - The image of $\left(0, \pi_{2}^{p}\right)$ generates $\mathcal{I}_{C} /\left\langle\left(\pi_{1}, \pi_{2}\right)\right\rangle$.
3 - For every $x \in C, \alpha \in \mathcal{O}_{\mathcal{C}_{1}, x}$ and $\beta \in \mathcal{O}_{\mathcal{C}_{2}, x}$, we have $\left(\pi_{1}^{p} \alpha, 0\right) \in \mathcal{O}_{\mathcal{C}, x}$ and $\left(0, \pi_{2}^{p} \beta\right) \in \mathcal{O}_{\mathcal{C}, x}$.
Proof. Let $x \in C$ and $u=\left(\pi_{1} \alpha, \pi_{2} \beta\right)$ whose image is a generator of $\mathcal{I}_{C} /\left\langle\left(\pi_{1}, \pi_{2}\right)\right\rangle$ at $x$ $\left(\mathcal{I}_{C} /\left\langle\left(\pi_{1}, \pi_{2}\right)\right\rangle\right.$ is a locally free sheaf of rank 1 of $\mathcal{O}_{C}$-modules $)$. Let $\beta_{0} \in \mathcal{O}_{\mathcal{C}_{1}, x}$ be such that $\left(\beta_{0}, \beta\right) \in \mathcal{O}_{\mathcal{C}, x}$. Then the image of

$$
u-\left(\pi_{1}, \pi_{2}\right)\left(\beta_{0}, \beta\right)=\left(\pi_{1}\left(\alpha-\beta_{0}\right), 0\right)
$$

is also a generator of $\mathcal{I}_{C} /\left\langle\left(\pi_{1}, \pi_{2}\right)\right\rangle$ at $x$. We can write it $\left(\pi_{1}^{p} \lambda, 0\right)$, where $\lambda$ is not a multiple of $\pi_{1}$.
Now we show that $p$ is the smallest integer $q$ such that $\left(\mathcal{I}_{C} /\left\langle\left(\pi_{1}, \pi_{2}\right)\right\rangle\right)_{x}$ contains the image of an element of the form $\left(\pi_{1}^{q} \mu, 0\right)$, with $\mu$ not divisible by $\pi_{1}$. We can write

$$
\left(\pi_{1}^{q} \mu, 0\right)=\left(u_{1}, u_{2}\right)\left(\pi_{1}^{p} \lambda, 0\right)+\left(v_{1}, v_{2}\right)\left(\pi_{1}, \pi_{2}\right)
$$

with $\left(u_{1}, u_{2}\right),\left(v_{1}, v_{2}\right) \in \mathcal{O}_{\mathcal{C}, x}$. So we have $v_{2}=0$, hence $\left(v_{1}, v_{2}\right) \in \mathcal{I}_{C, x}$. So we can write $\left(v_{1}, v_{2}\right)$ as the sum of a multiple of $\left(\pi_{1}^{p} \lambda, 0\right)$ and a multiple of $\left(\pi_{1}, \pi_{2}\right)$. Finally we obtain $\left(\pi_{1}^{q} \mu, 0\right)$ as

$$
\left(\pi_{1}^{q} \mu, 0\right)=\left(u_{12}, u_{22}\right)\left(\pi_{1}^{p} \lambda, 0\right)+\left(v_{11}, 0\right)\left(\pi_{1}, \pi_{2}\right)^{2}
$$

In the same way we see that $\left(\pi_{1}^{q} \mu, 0\right)$ can be written as

$$
\left(\pi_{1}^{q} \mu, 0\right)=\left(u_{1 p}, u_{2 p}\right)\left(\pi_{1}^{p} \lambda, 0\right)+\left(v_{1 p}, 0\right)\left(\pi_{1}, \pi_{2}\right)^{p},
$$

which implies immediately that $q \geq p$.

It follows that $p$ does not depend on $x$ and that $\mathcal{I}_{C} /\left\langle\left(\pi_{1}, \pi_{2}\right)\right\rangle$ is a subsheaf of $\left\langle\left(\pi_{1}^{p}, 0\right)\right\rangle /\left\langle\left(\pi_{1}^{p+1}, 0\right)\right\rangle \simeq \mathcal{O}_{C}$. Since $\mathcal{I}_{C} /\left\langle\left(\pi_{1}, \pi_{2}\right)\right\rangle$ is of degree 0 by (by corollary 3.2.4) it follows that $\mathcal{I}_{C} /\left\langle\left(\pi_{1}, \pi_{2}\right)\right\rangle \simeq\left\langle\left(\pi_{1}^{p}, 0\right)\right\rangle /\left\langle\left(\pi_{1}^{p+1}, 0\right)\right\rangle$, from which we deduce assertion 1- of proposition 4.2.1. The second assertion comes from the fact that $\left(0, \pi_{2}^{p}\right)=\pi^{p}-\left(\pi_{1}^{p}, 0\right)$.

To prove the third, we use the fact that there exists $\alpha^{\prime} \in \mathcal{O}_{\mathcal{C}_{2}, x}$ such that $\left(\alpha, \alpha^{\prime}\right) \in \mathcal{O}_{\mathcal{C}, x}$ (because $\left.\mathcal{C}_{1} \subset \mathcal{C}\right)$. Hence $\left(\pi_{1}^{p}, 0\right)\left(\alpha, \alpha^{\prime}\right)=\left(\pi_{1}^{p} \alpha, 0\right) \in \mathcal{O}_{\mathcal{C}, x}$. Similarly, we obtain that $\left(0, \pi_{2}^{p} \beta\right) \in \mathcal{O}_{\mathcal{C}, x}$.

According to the proof of proposition 4.2.1, for every $x \in C, p$ is the smallest integer $q$ such that there exists an element of $\mathcal{O}_{\mathcal{C}, x}$ of the form $\left(\pi_{1}^{q} \alpha, 0\right)$ (resp. $\left(0, \pi_{2}^{q} \alpha\right)$ ), with $\alpha \in \mathcal{O}_{\mathcal{C}_{1}, x}$ (resp. $\alpha \in \mathcal{O}_{\mathcal{C}_{2}, x}$ ) not vanishing on $C$.
Let $x \in C$ and $\alpha_{1} \in \mathcal{O}_{\mathcal{C}_{1}, x}$. Since $\mathcal{C}_{1} \subset \mathcal{C}$ there exists $\alpha_{2} \in \mathcal{O}_{\mathcal{C}_{2}, x}$ such that $\left(\alpha_{1}, \alpha_{2}\right) \in \mathcal{O}_{\mathcal{C}, x}$. Let $\alpha_{2}^{\prime} \in \mathcal{O}_{\mathcal{C}_{2}, x}$ such that $\left(\alpha_{1}, \alpha_{2}^{\prime}\right) \in \mathcal{O}_{\mathcal{C}, x}$. We have then $\left(0, \alpha_{2}-\alpha_{2}^{\prime}\right) \in \mathcal{O}_{\mathcal{C}, x}$. So there exists $\alpha \in \mathcal{O}_{\mathcal{C}_{2}, x}$ such that $\alpha_{2}-\alpha_{2}^{\prime}=\pi_{2}^{p} \alpha$. It follows that the image of $\alpha_{2}$ in $\mathcal{O}_{\mathcal{C}_{2}, x} /\left(\pi_{2}^{p}\right)$ is uniquely determined. Hence we have:

### 4.2.2. Proposition: There exists a canonical isomorphism

$$
\Phi: \mathcal{C}_{1}^{(p)} \longrightarrow \mathcal{C}_{2}^{(p)}
$$

between the infinitesimal neighborhoods of order $p$ of $\mathcal{C}_{1}$ and $\mathcal{C}_{2}$ (i.e. $\mathcal{O}_{\mathcal{C}_{i}^{(p)}}=\mathcal{O}_{\mathcal{C}_{i}} /\left(\pi_{i}^{p}\right)$ ), such that for every $x \in C, \alpha_{1} \in \mathcal{O}_{\mathcal{C}_{1}, x}$ and $\alpha_{2} \in \mathcal{O}_{\mathcal{C}_{2}, x}$, we have $\left(\alpha_{1}, \alpha_{2}\right) \in \mathcal{O}_{\mathcal{C}, x}$ if and only if $\Phi_{x}\left(\left[\alpha_{1}\right]_{p}\right)=\left[\alpha_{2}\right]_{p}$. For every $\alpha \in \mathcal{O}_{\mathcal{C}_{1}, x}$ we have $\Phi_{x}(\alpha)_{\mid C}=\alpha_{\mid C}$, and $\Phi_{x}\left(\pi_{1}\right)=\pi_{2}$.

The simplest case is $p=1$. In this case $\Phi: C \rightarrow C$ is the identity and $\mathcal{C}=\mathcal{A}$ (the initial gluing).
4.2.3. Converse - Recall that $\mathcal{A}$ denotes the initial gluing of $\mathcal{C}_{1}, \mathcal{C}_{2}$ (cf. 4.1.5). Let $\Phi: \mathcal{C}_{1}^{(p-1)} \rightarrow \mathcal{C}_{2}^{(p-1)}$ be an isomorphism inducing the identity on $C$ and such that $\Phi\left(\pi_{1}\right)=\pi_{2}$. We define a subsheaf of algebras $\mathcal{U}_{\Phi}$ of $\mathcal{O}_{\mathcal{A}}: \mathcal{U}_{\Phi}=\mathcal{O}_{\mathcal{A}}$ on $\mathcal{A} \backslash C$, and for every point $x$ of $C$

$$
\mathcal{U}_{\Phi, x}=\left\{\left(\alpha_{1}, \alpha_{2}\right) \in \mathcal{O}_{\mathcal{C}_{1}, x} \times \mathcal{O}_{\mathcal{C}_{2}, x} ; \Phi_{x}\left(\left[\alpha_{1}\right]_{p}\right)=\left[\alpha_{2}\right]_{p}\right\}
$$

It is easy to see that $\mathcal{U}_{\Phi}$ is the structural sheaf of an algebraic variety $\mathcal{A}_{\Phi}$, that the inclusion $\mathcal{U}_{\Phi} \subset \mathcal{O}_{\mathcal{A}}$ defines a dominant morphism $\mathcal{A} \rightarrow \mathcal{A}_{\Phi}$ inducing an isomorphism between the underlying topological spaces (for the Zariski topology), and that the composed morphisms $\mathcal{C}_{i} \subset \mathcal{A} \rightarrow \mathcal{A}_{\Phi}, i=1,2$, are immersions. Moreover, the morphism $\pi: \mathcal{A} \rightarrow S$ factorizes through $\mathcal{A}_{\Phi}:$

and $\pi_{\Phi}: \mathcal{A}_{\Phi} \rightarrow S$ is flat.
For $2 \leq i \leq p$, let $\Phi^{(i)}: \mathcal{C}_{1}^{(i)} \rightarrow \mathcal{C}_{2}^{(i)}$ be the isomorphism induced by $\Phi$.
4.2.4. Proposition: $\pi_{\Phi}^{-1}(P)$ is a primitive double curve.

Proof. Let $x$ be a closed point of $C$. We first show that $\mathcal{I}_{C, x}^{2} \subset(\pi)$. Let $u=\left(\pi_{1} \alpha, \pi_{2} \beta\right) \in \mathcal{I}_{C, x}$. Let $\beta^{\prime} \in \mathcal{O}_{\mathcal{C}_{2}, x}$ be such that $\Phi_{x}\left([\alpha]_{p}\right)=\left[\beta^{\prime}\right]_{p}$. We have then $v=\left(\alpha, \beta^{\prime}\right) \in \mathcal{O}_{\mathcal{C}, x}$. We have $u-\pi v=\left(0, \pi_{2}\left(\beta-\beta^{\prime}\right)\right) \in \mathcal{O}_{\mathcal{C}, x}$. Therefore $\left[\pi_{2}\left(\beta-\beta^{\prime}\right)\right]_{p}=\Phi_{x}(0)=0$. Hence $\pi_{2}\left(\beta-\beta^{\prime}\right) \in\left(\pi_{2}^{p}\right)$. We can then write

$$
u=\pi v+\left(0, \pi_{2}^{p} \gamma\right)
$$

Let $u^{\prime} \in \mathcal{I}_{C, x}$, that can be written as $u^{\prime}=\pi v^{\prime}+\left(0, \pi_{2}^{p} \gamma^{\prime}\right)$. We have then

$$
u u^{\prime}=\pi \cdot\left(\pi v v^{\prime}+\left(0, \pi_{2} \gamma^{\prime}\right) v+\left(0, \pi_{2} \gamma\right) v^{\prime}+\left(0, \pi_{2}^{2 p-1} \gamma \gamma^{\prime}\right)\right) \in(\pi) .
$$

It remains to show that $\mathcal{I}_{C, x} /(\pi) \simeq \mathcal{O}_{C, x}$. We have

$$
\begin{aligned}
\mathcal{I}_{C, x} & =\left\{\left(\pi_{1} \alpha, \pi_{2} \beta\right) \in \mathcal{O}_{\mathcal{C}_{1}, x} \times \mathcal{O}_{\mathcal{C}_{2}, x} ; \Phi_{x}\left(\left[\pi_{1} \alpha\right]_{p}\right)=\left[\pi_{2} \beta\right]_{p}\right\} \\
& =\left\{\left(\pi_{1} \alpha, \pi_{2} \beta\right) \in \mathcal{O}_{\mathcal{C}_{1}, x} \times \mathcal{O}_{\mathcal{C}_{2}, x} ; \Phi_{x}^{(p-1)}\left([\alpha]_{p-1}\right)=[\beta]_{p-1}\right\}, \\
(\pi)_{x} & =\left\{\left(\pi_{1} \alpha, \pi_{2} \beta\right) \in \mathcal{O}_{\mathcal{C}_{1}, x} \times \mathcal{O}_{\mathcal{C}_{2}, x} ; \Phi_{x}\left([\alpha]_{p}\right)=[\beta]_{p}\right\} .
\end{aligned}
$$

So if $\left(\pi_{1} \alpha, \pi_{2} \beta\right) \in \mathcal{I}_{C, x}$, we have $w=\Phi_{x}\left([\alpha]_{p}\right)-[\beta]_{p} \in\left(\pi_{2}^{p-1}\right)_{x} /\left(\pi_{2}^{p}\right)_{x} \simeq \mathcal{O}_{C, x}$. Hence we have a morphism of $\mathcal{O}_{\mathcal{C}, x}$-modules

$$
\begin{gathered}
\lambda: \mathcal{I}_{C, x} \longrightarrow \mathcal{O}_{C, x} \\
\left(\pi_{1} \alpha, \pi_{2} \beta\right) \longmapsto \\
\longrightarrow w
\end{gathered}
$$

whose kernel is $(\pi)_{x}$. We have now only to show that $\lambda$ is surjective, which follows from the fact that $\lambda\left(\pi_{1}^{p}, 0\right)=1$.

### 4.3. Spectrum of a fragmented deformation and ideals of sub-deformations

Let $\pi: \mathcal{C} \rightarrow S$ be a fragmented deformation of $C_{n}, \mathcal{C}_{1}, \ldots, \mathcal{C}_{n}$ the irreducible components of $\mathcal{C}$. For $1 \leq i \leq n$, let $\pi_{i}=\pi_{\mid \mathcal{C}_{i}}$. As in 4.2 , we denote also $t \circ \pi_{i}$ by $\pi_{i}$. Let $I=\{i, j\}$ be a subset of $\{1, \ldots, n\}$, with $i \neq j$. Then $\pi: \mathcal{C}_{I} \rightarrow S$ is a fragmented deformation of $C_{2}$. According to 4.2 there exists a unique integer $p>0$ such that $\mathcal{I}_{C, \mathcal{C}_{I}} /(\pi)$ is generated by the image of $\left(\pi_{i}^{p}, 0\right)$ (and also by the image of $\left.\left(0, \pi_{j}^{p}\right)\right)$. Recall that $p$ is the smallest integer $q$ such that $\mathcal{I}_{C, \mathcal{C}_{I}}$ contains a non zero element of the form $\left(\pi_{i}^{q} \lambda, 0\right)$ (or $\left(0, \pi_{j}^{q} \mu\right)$ ), with $\lambda_{\mid C} \neq 0$ (resp. $\left.\mu_{\mid C} \neq 0\right)$. Let

$$
p_{i j}=p_{j i}=p,
$$

and $p_{i i}=0$ for $1 \leq i \leq n$. The symmetric matrix $\left(p_{i j}\right)_{1 \leq i, j \leq n}$ is called the spectrum of $\mathcal{C}$.
4.3.1. Generators of $\left(\mathcal{I}_{C}^{p}+(\pi)\right) /\left(\mathcal{I}_{C}^{p+1}+(\pi)\right)$ - Let $i, j \in\{1, \ldots, n\}$ be such that $i \neq j$. Let $x \in C$. Since $\mathcal{C}_{\{i, j\}} \subset \mathcal{C}$ there exists an element $\mathbf{u}_{i j}=\left(u_{m}\right)_{1 \leq m \leq n}$ of $\mathcal{O}_{\mathcal{C}, x}$ such that $u_{i}=0$ and $u_{j}=\pi_{j}^{p_{i j}}$. According to proposition 4.1.4, the image of $\mathbf{u}_{i j}$ generates $\mathcal{I}_{C} /\left(\mathcal{I}_{C}^{2}+(\pi)\right)$ at $x$.

According to proposition 4.2.1 and the fact that the image of $\mathbf{u}_{i j}$ generates
$\mathcal{I}_{C, \mathcal{C}_{i j}, x} /\left(\mathcal{I}_{C, \mathcal{C}_{i j}, x}^{2}+(\pi)\right)$, for every integer $m$ such that $m \neq i, j$ and that $1 \leq m \leq n, u_{m}$ is of the form $u_{m}=\alpha_{i j}^{(m)} \pi_{m}^{p_{i m}}$, with $\alpha_{i j}^{(m)} \in \mathcal{O}_{\mathcal{C}_{m}, x}$ invertible. Let $\alpha_{i j}^{(i)}=0$ and $\alpha_{i j}^{(j)}=1$.
4.3.2. Proposition: $1-\alpha_{i j \mid C}^{(m)}$ is a non zero constant, uniquely determined and independent of $x$.
$\mathbf{2}$ - Let $\mathbf{a}_{i j}^{(m)}=\alpha_{i j \mid C}^{(m)} \in \mathbb{C}$. Then we have, for all integers $i, j, k, m, q$ such that $1 \leq i, j, k, m, q \leq n, i \neq j, i \neq k$

$$
\mathbf{a}_{i k}^{(m)} \mathbf{a}_{i j}^{(q)}=\mathbf{a}_{i k}^{(q)} \mathbf{a}_{i j}^{(m)}
$$

In particular we have $\mathbf{a}_{i j}^{(m)}=\mathbf{a}_{i k}^{(m)} \mathbf{a}_{i j}^{(k)}$ and $\mathbf{a}_{i j}^{(m)} \mathbf{a}_{i m}^{(j)}=1$.
Proof. Let $\mathbf{u}_{i j}^{\prime}$ have the same properties as $\mathbf{u}_{i j}$. Then $\mathbf{v}=\mathbf{u}_{i j}^{\prime}-\mathbf{u}_{i j} \in \mathcal{I}_{C, x}^{2}+(\pi)$. So the image of $\mathbf{v}$ in $\mathcal{O}_{\mathcal{C}_{i m, x}}$ belongs to $\mathcal{I}_{C, \mathcal{C}_{i m}, x}^{2}+(\pi)$. It follows that the $m$-th component of $\mathbf{v}$ is a multiple of $\pi_{m}^{p_{i m}+1}$. Hence $\alpha_{i j \mid C}^{(m)}$ is uniquely determined. It follows that when $x$ varies the $\alpha_{i j \mid C}^{(m)}$ can be glued together and define a global section of $\mathcal{O}_{C}$, which must be a constant. This proves 1-.
Now we prove 2-. There exists $u \in \mathcal{O}_{\mathcal{C}, x}$ such that the $k$-th component of $u$ is $\alpha_{i j}^{(k)}$, and $u$ is invertible. Then the image of $\left(v_{m}\right)=\frac{\mathbf{u}_{i j}}{u}$ generates $\mathcal{I}_{C} /\left(\mathcal{I}_{C}^{2}+(\pi)\right)$, and $v_{k}=1$. Hence according to 1-, we have $v_{m \mid C}=\mathbf{a}_{i k}^{(m)}$, i.e.

$$
\frac{\mathbf{a}_{i j}^{(m)}}{\mathbf{a}_{i j}^{(k)}}=\mathbf{a}_{i k}^{(m)}
$$

We have the same equality with $q$ instead of $m$, whence 2 - is easily deduced.

Let $p$ be an integer such that $1 \leq p<n$, and $\left(i_{1}, j_{1}\right), \ldots,\left(i_{p}, j_{p}\right) p$ pairs of distinct integers of $\{1, \ldots, n\}$. Then the image of $\prod_{m=1}^{p} \mathbf{u}_{i_{m} j_{m}}$ is a generator of $\left(\mathcal{I}_{C}^{p}+(\pi)\right) /\left(\mathcal{I}_{C}^{p+1}+(\pi)\right)$.
Let $I \subset\{1, \cdots, n\}$ be a nonempty subset, distinct from $\{1, \cdots, n\}$. Let $i \in\{1, \cdots, n\} \backslash I$. Let

$$
\mathbf{u}_{I, i}=\prod_{j \in I} \mathbf{u}_{j i}
$$

Recall that $\mathcal{C}_{I}=\cup_{j \in I} \mathcal{C}_{j} \subset \mathcal{C}$.
4.3.3. Proposition: The ideal sheaf of $\mathcal{C}_{I}$ is generated by $\mathbf{u}_{I, i}$ at $x$.

Proof. According to proposition 4.1.6 there exists an embedding of a neighborhood of $x$ in a smooth variety of dimension 3 . In this variety each $\mathcal{C}_{i}$ is a smooth surface defined by a single equation. The ideal of the union of the $\mathcal{C}_{i}, i \in I$ is the product of these equations.
4.3.4. Proposition: Let $i, j, k$ be distinct integers such that $1 \leq i, j, k \leq n$. Then if $p_{i j}<p_{j k}$, we have $p_{i k}=p_{i j}$.

Proof. We can come down to the case $n=3$ by considering $\mathcal{C}_{\{i, j, k\}}$. We can suppose that $p_{23} \leq p_{12} \leq p_{13}$, and we must show that $p_{23}=p_{12}$. We have

$$
\mathbf{u}_{21}=\left(\pi_{1}^{p_{12}}, 0, \alpha_{21}^{(3)} \pi_{3}^{p_{23}}\right), \quad \mathbf{u}_{31}=\left(\pi_{1}^{p_{13}}, \alpha_{31}^{(2)} \pi_{2}^{p_{23}}, 0\right)
$$

So

$$
\mathbf{u}_{31}-\pi^{p_{13}-p_{12}} \mathbf{u}_{21}=\left(0, \alpha_{31}^{(2)} \pi_{2}^{p_{23}},-\alpha_{21}^{(3)} \pi_{3}^{p_{23}+p_{13}-p_{12}}\right) \in \mathcal{O}_{\mathcal{C}, x} .
$$

Taking the image of this element in $\mathcal{O}_{\mathcal{C}_{12} x}$, we see that $p_{23} \geq p_{12}$, hence $p_{23}=p_{12}$.
4.3.5. Proposition: 1 - Let $i, j$ be distinct integers such that $1 \leq i, j \leq n$. Then we have $\mathcal{I}_{C, x}=\left(\mathbf{u}_{i j}\right)+(\pi)$.
$\mathbf{2}$ - Let $v=\left(v_{m}\right)_{1 \leq m \leq n} \in \mathcal{I}_{C, x}$ such that $v_{i}$ is a multiple of $\pi_{i}^{p}$, with $p>0$. Then we have $v \in\left(\mathbf{u}_{i j}\right)+\left(\pi^{p}\right)$.

Proof. Let $N=1+\max _{1 \leq k \leq n}\left(q_{i}\right)$, where $q_{i}=\sum_{j=1}^{n} p_{i j}$. For every integer $j$ such that $1 \leq j \leq n$ we have $\left(0, \ldots, 0, \pi_{j}^{q_{j}}, 0, \ldots, 0\right) \in \mathcal{O}_{\mathcal{C}}(\mathcal{C})$. Hence $\mathcal{I}_{C}^{N} \subset(\pi)$. We will show by induction on $k$ that $\mathcal{I}_{C, x} \subset\left(\mathbf{u}_{i j}\right)+(\pi)+\mathcal{I}_{C, x}^{k}$. Taking $k=N$ we obtain 1-.
For $k=1$ it is obvious. Suppose that it is true for $k-1 \geq 1$. It is enough to prove that $\mathcal{I}_{C, x}^{k-1} \subset\left(\mathbf{u}_{i j}\right)+(\pi)+\mathcal{I}_{C, x}^{k}$. Let $w_{1}, \ldots, w_{k-1} \in \mathcal{I}_{C, x}$. Since the image of $\mathbf{u}_{i j}$ generates $\mathcal{I}_{C, x} /\left(\mathcal{I}_{C, x}^{2}+(\pi)\right)$, we can write $w_{p}$ as

$$
w_{p}=\lambda_{p} \mathbf{u}_{i j}+\pi \mu_{p}+\nu_{p},
$$

with $\lambda_{p}, \mu_{p} \in \mathcal{O}_{\mathcal{C}, x}$ and $\nu_{p} \in \mathcal{I}_{C, x}^{2}$. So we have

$$
w_{1} \cdots w_{k-1}=\lambda \mathbf{u}_{i j}+\pi \mu+\nu
$$

with $\lambda, \mu \in \mathcal{O}_{\mathcal{C}, x}$ and $\nu \in \mathcal{I}_{C, x}^{2 k-2}$. Since $2 k-2 \geq k$, we have $w_{1} \cdots w_{k-1} \in\left(\mathbf{u}_{i j}\right)+(\pi)+\mathcal{I}_{C, x}^{k}$. This proves $1-$.

We prove 2- by induction on $p$. The case $p=1$ follows 1 -. Suppose that it is true for $p-1 \geq 1$. So we can write $v$ as

$$
v=\lambda \mathbf{u}_{i j}+\pi^{p-1} \mu,
$$

with $\lambda, \mu \in \mathcal{O}_{\mathcal{C}, x}$. We can write $v_{i}$ as $v_{i}=\alpha \pi^{p}$. So we have $\alpha \pi_{i}^{p}=\pi_{i}^{p-1} \mu_{i}$, whence $\mu_{i}=\alpha \pi_{i}$. Hence $\mu \in \mathcal{I}_{C x}$. According to 1- we can write $\mu$ as $\mu=\theta \mathbf{u}_{i j}+\pi \tau$, with $\theta, \tau \in \mathcal{O}_{\mathcal{C}, x}$. So

$$
v=\left(\lambda+\pi^{p-1} \theta\right) \mathbf{u}_{i j}+\pi^{p} \tau
$$

which proves the result for $p$.
4.3.6. The ideal sheaves $\mathcal{I}_{\mathcal{C}_{I}}$ - Recall that $I \subset\{1, \cdots, n\}$ is a nonempty subset, distinct from $\{1, \cdots, n\}$. For every subset $J$ of $\{1, \cdots, n\}$, let $J^{c}=\{1, \cdots, n\} \backslash J$ and $\mathcal{O}_{J}=\mathcal{O}_{\mathcal{C}_{J}}$. It follows from proposition 4.3.3 that $\mathcal{I}_{\mathcal{C}_{I}}$ is a line bundle on $\mathcal{C}_{I^{c}}$.

From now on, we suppose that $S \subset \mathbb{C}$ and $P=0$ (cf. proposition 3.2.6).
4.3.7. Theorem: We have $\mathcal{I}_{\mathcal{C}_{I}} \simeq \mathcal{O}_{I^{c}}$.

Proof. By induction on $n$. If $n=2$ the result follows from proposition 4.2.1 and the fact that $S \subset \mathbb{C}$. Suppose that it is true for $n-1 \geq 2$. We will prove that it is true for $n$ by induction on the number of elements $q$ of $I^{c}$. Suppose first that $q=1$ and let $i$ be the unique element of $I^{c}$. Then according to proposition 4.3.3, $\mathcal{I}_{\mathcal{C}_{I}}$ is generated by $\left(0, \ldots, 0, \pi_{i}^{q_{i}}, 0, \ldots, 0\right)$, so the result is true in this case. Suppose that it is true if $1 \leq q<k<n$, and that $q=k$. Let $K=\{1, \cdots, n-1\}$. We can assume that $I \subset K$.

According to proposition 4.3.3, we have, for every $x \in C, \mathcal{I}_{\mathcal{C}_{I}, x} \simeq \mathcal{O}_{I^{c} x}$. We have $\mathcal{I}_{\mathcal{C}_{K}} \subset \mathcal{I}_{\mathcal{C}_{I}}$, and $\mathcal{I}_{\mathcal{C}_{K}} \simeq \mathcal{O}_{\{n\}}$. We have

$$
\mathcal{I}_{\mathcal{C}_{I}} / \mathcal{I}_{\mathcal{C}_{K}}=\mathcal{I}_{\mathcal{C}_{I}, \mathcal{C}_{K}}
$$

(the ideal sheaf of $\mathcal{C}_{I}$ in $\mathcal{C}_{K}$ ). From the first induction hypothesis we have

$$
\mathcal{I}_{\mathcal{C}_{I}, \mathcal{C}_{K}} \simeq \mathcal{O}_{(I \cup\{n\})^{c}} .
$$

So we have an exact sequence of sheaves

$$
0 \longrightarrow \mathcal{O}_{\{n\}} \longrightarrow \mathcal{I}_{\mathcal{C}_{I}} \longrightarrow \mathcal{O}_{I^{c} \backslash\{n\}} \longrightarrow 0
$$

Now we will compute $\operatorname{Ext}_{\mathcal{O}_{\mathcal{C}}}^{1}\left(\mathcal{O}_{I^{c} \backslash\{n\}}, \mathcal{O}_{\{n\}}\right)$. According to [6], 2.3, we have an exact sequence

$$
0 \longrightarrow \operatorname{Ext}_{\mathcal{O}_{I^{c}}}^{1}\left(\mathcal{O}_{I^{c} \backslash\{n\}}, \mathcal{O}_{\{n\}}\right) \longrightarrow \operatorname{Ext}_{\mathcal{O}_{\mathcal{C}}}^{1}\left(\mathcal{O}_{I^{c} \backslash\{n\}}, \mathcal{O}_{\{n\}}\right) \longrightarrow \operatorname{Hom}\left(\operatorname{Tor}_{\mathcal{O}_{\mathcal{C}}}^{1}\left(\mathcal{O}_{I^{c} \backslash\{n\}}, \mathcal{O}_{I^{c}}\right), \mathcal{O}_{\{n\}}\right)
$$

Since $\operatorname{Tor}_{\mathcal{O}_{\mathcal{C}}}^{1}\left(\mathcal{O}_{I^{c} \backslash\{n\}}, \mathcal{O}_{I^{c}}\right)$ is concentrated on $\mathcal{C}_{I^{c} \backslash\{n\}}$, we have

$$
\operatorname{Hom}\left(\operatorname{Tor}_{\mathcal{O}_{\mathcal{C}}}^{1}\left(\mathcal{O}_{I^{c} \backslash\{n\}}, \mathcal{O}_{I^{c}}\right), \mathcal{O}_{\{n\}}\right)=\{0\}
$$

So we have

$$
\operatorname{Ext}_{\mathcal{O}_{\mathcal{C}}}^{1}\left(\mathcal{O}_{I^{c} \backslash\{n\}}, \mathcal{O}_{\{n\}}\right)=\operatorname{Ext}_{\mathcal{O}_{I^{c}}}^{1}\left(\mathcal{O}_{I^{c} \backslash\{n\}}, \mathcal{O}_{\{n\}}\right)
$$

Let $\mathcal{J}$ denote the ideal sheaf of $\mathcal{C}_{\{n\}}$ in $\mathcal{C}_{I^{c}}$. The ideal sheaf of $\mathcal{C}_{I^{c} \backslash\{n\}}$ is generated by $\mathbf{w}=\left(0, \ldots, 0, \pi_{n}^{m}\right)$, with $m=\sum_{i \in I^{c} \backslash\{n\}} p_{i n}$. So we have an exact sequence of sheaves on $\mathcal{C}_{I^{c}}$

$$
0 \longrightarrow \mathcal{J} \longrightarrow \mathcal{O}_{I^{c}} \xrightarrow{\alpha} \mathcal{O}_{I^{c}} \longrightarrow \mathcal{O}_{I^{c} \backslash\{n\}} \longrightarrow 0,
$$

where $\alpha$ is the multiplication by $w$. By the induction hypothesis there exists a surjective morphism $\mathcal{O}_{I^{c}} \rightarrow \mathcal{J}$, so we get a locally free resolution of $\mathcal{O}_{I^{c} \backslash\{n\}}$

$$
\mathcal{O}_{I^{c}} \longrightarrow \mathcal{O}_{I^{c}} \xrightarrow{\alpha} \mathcal{O}_{I^{c}} \longrightarrow \mathcal{O}_{I^{c} \backslash\{n\}} \longrightarrow 0,
$$

that can be used to compute $\mathcal{E} x t_{\mathcal{O}_{I^{c}}}^{1}\left(\mathcal{O}_{I^{c} \backslash\{n\}}, \mathcal{O}_{\{n\}}\right)$. It follows easily that

$$
\mathcal{E} x t_{\mathcal{O}_{I^{c}}}^{1}\left(\mathcal{O}_{I^{c} \backslash\{n\}}, \mathcal{O}_{\{n\}}\right) \simeq \mathcal{O}_{\{n\}} /\left(\pi_{n}^{m}\right)
$$

We have $\mathcal{H o m}\left(\mathcal{O}_{I^{c} \backslash\{n\}}, \mathcal{O}_{\{n\}}\right)=0$, hence

$$
\begin{aligned}
\operatorname{Ext}_{\mathcal{O}_{I^{c}}}^{1}\left(\mathcal{O}_{I^{c} \backslash\{n\}}, \mathcal{O}_{\{n\}}\right) & \simeq H^{0}\left(\mathcal{E} x t_{\mathcal{O}_{I^{c}}}\left(\mathcal{O}_{I^{c} \backslash\{n\}}, \mathcal{O}_{\{n\}}\right)\right) \\
& \simeq H^{0}\left(\mathcal{O}_{\{n\}} /\left(\pi_{n}^{m}\right)\right) \\
& \simeq H^{0}\left(\mathcal{O}_{S} /\left(\pi_{n}^{m}\right)\right) \\
& \simeq \mathbb{C}\left[\pi_{n}\right] /\left(\pi_{n}^{m}\right) .
\end{aligned}
$$

We will now describe the sheaves $\mathcal{E}$ such that there exists an exact sequence

$$
\begin{equation*}
0 \longrightarrow \mathcal{O}_{\{n\}} \longrightarrow \mathcal{E} \longrightarrow \mathcal{O}_{I^{c} \backslash\{n\}} \longrightarrow 0 \tag{2}
\end{equation*}
$$

Let $\nu \in \mathbb{C}\left[\pi_{n}\right] /\left(\pi_{n}^{m}\right)$ be associated to this exact sequence, and $\bar{\nu} \in H^{0}\left(\mathcal{O}_{S}\right)$ over $\nu$. Let

$$
\begin{aligned}
\tau: \mathcal{O}_{\{n\}} & \longrightarrow \mathcal{O}_{\{n\}} \oplus \mathcal{O}_{I^{c}} \\
u & \longmapsto(\bar{\nu} u, \mathbf{w} u)
\end{aligned}
$$

Then according to the preceding resolution of $\mathcal{O}_{I^{c} \backslash\{n\}}$ and the construction of extensions (cf. [5], 4.2), we have $\mathcal{E} \simeq \operatorname{coker}(\tau)$. It is easy to see that if $\nu=-1$ then $\mathcal{E} \simeq \mathcal{O}_{\mathcal{I}^{c}}$. If $\nu$ is invertible,
then we have also $\mathcal{E} \simeq \mathcal{O}_{\mathcal{I}^{c}}$, because the corresponding extension can be obtained from the one corresponding to $\nu=-1$ by multiplying the left morphism of the exact sequence by $\nu$.
A similar construction can be done for extensions of $\mathcal{O}_{I^{c}, x^{-}}$-modules (for every $x \in C$ )

$$
0 \longrightarrow \mathcal{O}_{\{n\}, x} \longrightarrow V \longrightarrow \mathcal{O}_{I^{c} \backslash\{n\}, x} \longrightarrow 0
$$

These extensions are classified by $\mathcal{O}_{\{n\}, x} /\left(\pi_{n}^{m}\right)$, and $\mathcal{O}_{I^{c}, x}$ corresponds to -1 .
Conversely we consider extensions

$$
0 \longrightarrow \mathcal{O}_{\{n\}, x} \xrightarrow{\lambda} \mathcal{O}_{I^{c}, x} \xrightarrow{\mu} \mathcal{O}_{I^{c} \backslash\{n\}, x} \longrightarrow 0
$$

Using the facts that $\operatorname{Hom}\left(\mathcal{O}_{\{n\}, x}, \mathcal{O}_{I^{c}, x}\right)$ is generated by the multiplication by $\mathbf{w}$ and $\operatorname{Hom}\left(\mathcal{O}_{I^{c}, x}, \mathcal{O}_{I^{c} \backslash\{n\}, x}\right)$ by the restriction morphism, it is easy to see that $\lambda, \mu$ are unique up to multiplication by an invertible element of $\mathcal{O}_{I^{c}, x}$. Hence the elements of $\operatorname{Ext}_{\mathcal{O}_{I^{c}, x}}^{1}\left(\mathcal{O}_{I^{c} \backslash\{n\}, x}, \mathcal{O}_{\{n\}, x}\right)$ corresponding to the preceding extensions are exactly the invertible elements of $\mathcal{O}_{\{n\}, x} /\left(\pi_{n}^{m}\right)$.
It follows that the extensions (2) where $\mathcal{E}$ is locally free correspond to invertible elements of $\mathbb{C}\left[\pi_{n}\right] /\left(\pi_{n}^{m}\right)$, and we have seen that in this case we have $\mathcal{E} \simeq \mathcal{O}_{I^{c}}$. Hence we have $\mathcal{I}_{\mathcal{C}_{I}} \simeq \mathcal{O}_{I^{c}}$ and theorem 4.3.7 is proved.
4.3.8. Corollary: The ideal sheaf of $\mathcal{C}_{I}$ is globally generated by an element $\mathbf{u}_{I}$ such that for every integer $i$ such that $1 \leq i \leq n$ and $i \notin I$, the $i$-th coordinate of $\mathbf{u}_{I}$ belongs to $H^{0}\left(\mathcal{O}_{S}\right)$.

### 4.4. Properties of the fragmented deformations

We use the notations of 4.3.
Let $i$ be an integer such that $1 \leq i \leq n$ and $J_{i}=\{1, \ldots, n\} \backslash\{i\}$. We denote by $\mathcal{B}$ the image of $\mathcal{O}_{\mathcal{C}}$ in $\prod_{1 \leq j \leq n} \mathcal{O}_{\mathcal{C}_{j}} /\left(\pi_{j}^{q_{j}}\right)$; it is a sheaf of $\mathbb{C}$-algebras on $C$. Let $\mathcal{B}_{i}$ be the image of $\mathcal{O}_{\mathcal{C}_{J_{i}}}$ in $\prod_{1 \leq j \leq n, j \neq i} \mathcal{O}_{\mathcal{C}_{j}} /\left(\pi_{j}^{q_{j}}\right)$; it is also a sheaf of $\mathbb{C}$-algebras on $C$. For every point $x$ of $C$ and every $\alpha=\left(\alpha_{m}\right)_{1 \leq m \leq n}$ in $\prod_{1 \leq j \leq n} \mathcal{O}_{\mathcal{C}_{j}, x}$, we denote by $b_{i}(\alpha)$ its image in $\prod_{1 \leq j \leq n, j \neq i} \mathcal{O}_{\mathcal{C}_{j}, x}$ (obtained by forgetting the $i$-th coordinate of $\alpha$ ).
If $p, k$ are positive integers, with $k \leq n, x \in C$ and $\alpha \in \mathcal{O}_{\mathcal{C}_{k}, x}$, let $[\alpha]_{p}$ denote the image of $\alpha$ in $\mathcal{O}_{\mathcal{C}_{k}, x} / \pi_{k}^{p}$.
4.4.1. Proposition: There exists a morphism of sheaves of algebras on $C$

$$
\Phi_{i}: \mathcal{B}_{i} \longrightarrow \mathcal{O}_{\mathcal{C}_{i}} /\left(\pi_{i}^{q_{i}}\right)
$$

such that for every point $x$ of $C$ and all $\left(\alpha_{m}\right)_{1 \leq m \leq n, m \neq i} \in \mathcal{O}_{\mathcal{C}_{J_{i}}, x}, \alpha_{i} \in \mathcal{O}_{\mathcal{C}_{i}, x}$, we have $\alpha=\left(\alpha_{m}\right)_{1 \leq m \leq n} \in \mathcal{O}_{\mathcal{C}, x}$ if and only if $\Phi_{i, x}\left(b_{i}(\alpha)\right)=\left[\alpha_{i}\right]_{q_{i}}$.

Proof. Let $\left(\alpha_{m}\right)_{1 \leq m \leq n, m \neq i} \in \mathcal{O}_{\mathcal{C}_{J_{i}} x}$. Since $\mathcal{C}_{J_{i}} \subset \mathcal{C}$, there exists $\alpha_{i} \in \mathcal{O}_{\mathcal{C}_{i}, x}$ such that $\left(\alpha_{m}\right)_{1 \leq m \leq n} \in \mathcal{O}_{\mathcal{C}, x}$. If $\alpha_{i}^{\prime} \in \mathcal{O}_{\mathcal{C}_{i}} x$ has the same property, we have $\left(0, \ldots, 0, \alpha_{i}-\alpha_{i}^{\prime}, 0, \ldots, 0\right) \in \mathcal{I}_{J_{i} x}$. So according to proposition 4.3.3, we have $\left[\alpha_{i}\right]_{q_{i}}=\left[\alpha_{i}^{\prime}\right]_{q_{i}}$. Hence we have a well defined morphism of algebras $\theta_{x}: \mathcal{O}_{\mathcal{C}_{J_{i}}, x} \rightarrow \mathcal{O}_{\mathcal{C}_{J_{i}}} /\left(\pi_{i}^{q_{i}}\right)$ sending $\left(\alpha_{m}\right)_{1 \leq m \leq n, m \neq i}$ to $\left[\alpha_{i}\right]_{q_{i}}$. If $j \in J_{i}$, we have, according to proposition 4.3.3,
$\theta_{x}\left(0, \ldots, 0, \pi_{j}^{q_{j}}, 0, \ldots, 0\right)=0$. Hence $\theta_{x}$ induces a morphism of algebras $\mathcal{B}_{i, x} \rightarrow \mathcal{O}_{\mathcal{C}_{i}, x} /\left(\pi_{i}^{q_{i}}\right)$.

The morphism $\Phi_{i}$ has the following properties: for every point $x$ of $C$
(i) For every $\alpha=\left(\alpha_{m}\right)_{1 \leq m \leq n, m \neq i} \in \mathcal{B}_{i, x}$, we have $\Phi_{i, x}(\alpha)_{\mid C}=\alpha_{m \mid C}$ for $1 \leq m \leq n, m \neq i$.
(ii) We have $\Phi_{i, x}\left(\left(\pi_{m}\right)_{1 \leq m \leq n, m \neq i}\right)=\pi_{i}$.
(iii) Let $j, k \in\{1, \cdots, n\}$ be such that $i, j, k$ are distinct. Let $\mathbf{v}$ be the image of $\mathbf{u}_{j k}$ in $\mathcal{B}_{i}$. Then there exists $\lambda \in \mathcal{O}_{\mathcal{C}_{i}, x}^{*}$ such that $\Phi_{i, x}(\mathbf{v})=\lambda \pi_{i}^{p_{i j}}$.
(iv) Let $j$ be an integer such that $1 \leq j \leq n$ and $j \neq i$. Let $\mathbf{v}$ be the image of $\mathbf{u}_{i j}$ in $\mathcal{B}_{i, x}$. Then we have $\operatorname{ker}\left(\Phi_{i, x}\right)=(\mathbf{v})$.
4.4.2. Converse - Let $\mathcal{C}^{\prime}$ be a gluing of $\mathcal{C}_{1}, \ldots, \mathcal{C}_{i-1}, \mathcal{C}_{i+1}, \ldots, \mathcal{C}_{n}$ along $C$, which is a fragmented deformation of a primitive multiple curve of multiplicity $n-1$. Let $\left(p_{j k}\right)_{1 \leq j, k \leq n, j, k \neq i}$ be the spectrum of $\mathcal{C}^{\prime}$. Let $p_{i j}, 1 \leq j \leq n, j \neq i$ be positive integers, and $p_{i i}=0$. For $1 \leq j \leq n$, let $q_{j}=\sum_{1 \leq k \leq n} p_{k j}$.
Let $\mathcal{B}_{i}$ be the image of $\mathcal{O}_{\mathcal{C}^{\prime}}$ in $\prod_{1 \leq j \leq n, j \neq i} \mathcal{O}_{\mathcal{C}_{j}} /\left(\pi_{j}^{q_{j}}\right)$ and

$$
\Phi_{i}: \mathcal{B}_{i} \longrightarrow \mathcal{O}_{\mathcal{C}_{i}} /\left(\pi_{i}^{q_{i}}\right)
$$

a morphism of sheaves of algebras on $C$ satisfying properties (i), (ii), (iii) above. Let $\mathcal{A}$ be the subsheaf of algebras of $\mathcal{A}$ defined by: $\mathcal{A}=\mathcal{A}$ on $\mathcal{A}_{\text {top }} \backslash C$, and for every point $x$ of $C$, and every $\alpha=\left(\alpha_{m}\right)_{1 \leq m \leq n} \in \prod_{m=1}^{n} \mathcal{O}_{\mathcal{C}_{m, x}}, \alpha \in \mathcal{A}_{x}$ if and only if $b_{i}(\alpha) \in \mathcal{B}_{i, x}$ and $\Phi_{i, x}\left(b_{i}(\alpha)\right)=\left[\alpha_{i}\right]_{q_{i}}$.
It is easy to see that $\mathcal{A}$ is the structural sheaf of a gluing of $C_{1}, \ldots, C_{n}$ along $C$, which is a fragmented deformation of a primitive multiple curve of multiplicity $n$, and that $\mathcal{C}^{\prime}=\mathcal{A}_{\{1, \ldots, i-1, i+1, \ldots, n\}}$.

We give now some applications of the preceding construction.
4.4.3. Corollary: Let $N$ be an integer such that $N \geq \max _{1 \leq i \leq n}\left(q_{i}\right)$. Let $x \in C$, $\beta \in \mathcal{O}_{\mathcal{C}_{1}, x} \times \cdots \mathcal{O}_{\mathcal{C}_{n}, x}$ and $u \in \mathcal{O}_{\mathcal{C}, x}$ such that $u_{\mid C} \neq 0$. Suppose that $[\beta u]_{N} \in \mathcal{O}_{\mathcal{C}, x} /\left(\pi^{N}\right)$. Then we have $[\beta]_{N} \in \mathcal{O}_{\mathcal{C}, x} /\left(\pi^{N}\right)$.

Proof. By induction on $n$. It is obvious if $n=1$. Suppose that the lemma is true for $n-1$. Let $I=\{1, \ldots, n-1\}$. So we have $\left[\beta_{\mid \mathcal{C}_{1} \times \cdots \mathcal{C}_{n-1}}\right]_{N} \in \mathcal{O}_{\mathcal{C}_{I}, x} /\left(\pi_{1}, \ldots, \pi_{n-1}\right)^{N}$ by the induction hypothesis. Let $\gamma\left(\right.$ resp. $v$ ) be the image of $\beta$ (resp. $u$ ) in $\mathcal{B}_{n}$. To show that $[\beta]_{N} \in \mathcal{O}_{\mathcal{C}, x} /\left(\pi^{N}\right)$ it is enough to verify that

$$
\Phi_{n}(\gamma)=\left[\beta_{n}\right]_{q_{n}} .
$$

We have $\Phi_{n}(\gamma v)=\left[\beta_{n} u_{n}\right]_{q_{n}}$ because $[\beta u]_{N} \in \mathcal{O}_{\mathcal{C}, x} /\left(\pi^{N}\right)$, and $\Phi_{n}(v)=\left[u_{n}\right]_{q_{n}}$ because $u \in \mathcal{O}_{\mathcal{C}, x}$. So we have

$$
\Phi_{n}(\gamma)\left[u_{n}\right]_{q_{n}}=\Phi_{n}(\gamma) \Phi_{n}(v)=\Phi_{n}(\gamma v)=\left[\beta_{n} u_{n}\right]_{q_{n}}=\left[\beta_{n}\right]_{q_{n}}\left[u_{n}\right]_{q_{n}}
$$

Since $u_{\mid C} \neq 0,\left[u_{n}\right]_{q_{n}}$ is not a zero divisor in $\mathcal{O}_{\mathcal{C}_{n}, x} /\left(\pi_{n}^{q_{n}}\right)$, so we have $\Phi_{n}(\gamma)=\left[\beta_{n}\right]_{q_{n}}$.
4.4.4. Corollary: Let $\mathbf{q}=\max _{1 \leq i \leq n}\left(q_{i}\right)$ and $p$ the number of integers $i$ such that $1 \leq i \leq n$ and $q_{i}=\mathbf{q}$. Then we have $p \geq 2$.

Proof. Suppose that $q_{i}=\mathbf{q}$. Then we have $\pi_{i}^{q_{i}-1} \neq 0$ in $\mathcal{O}_{\mathcal{C}_{i}} /\left(\pi_{i}^{q_{i}}\right)$. Since $\pi_{i}=\Phi_{i}\left(\left(\pi_{m}\right)_{1 \leq m \leq n, m \neq i}\right)$, we have $\left(\pi_{m}^{q_{i}-1}\right)_{1 \leq m \leq n, m \neq i} \neq 0$ in $\mathcal{B}_{i}$. So we cannot have $q_{m}<q_{i}$ for all the $m \neq i$.

Let $i$ be an integer such that $1 \leq i \leq n$,

$$
\mathcal{H}=\prod_{1 \leq j \leq n}\left(\pi_{j}^{q_{j}-1}\right) /\left(\pi_{j}^{q_{j}}\right) \simeq \mathcal{O}_{C}^{n} \quad\left(\text { resp. } \quad \mathcal{H}_{i}=\prod_{1 \leq j \leq n, j \neq i}\left(\pi_{j}^{q_{j}-1}\right) /\left(\pi_{j}^{q_{j}}\right) \simeq \mathcal{O}_{C}^{n-1}\right)
$$

It is an ideal sheaf of $\prod_{1 \leq j \leq n} \mathcal{O}_{\mathcal{C}_{j}} /\left(\pi_{j}^{q_{j}}\right)$ (resp. $\left.\prod_{1 \leq j \leq n, j \neq i} \mathcal{O}_{\mathcal{C}_{j}} /\left(\pi_{j}^{q_{j}}\right)\right)$. Let $\mathcal{J}=\mathcal{H} \cap \mathcal{B}$ (resp. $\mathcal{J}_{i}=\mathcal{H}_{i} \cap \mathcal{B}_{i}$ ), which is an ideal sheaf of $\mathcal{B}$ (resp. $\mathcal{B}_{i}$ ).
4.4.5. Proposition: There exists a unique $\lambda(\mathcal{C})=\left(\lambda_{1}, \ldots, \lambda_{n}\right) \in \mathbb{P}_{n}(\mathbb{C})$ such that for every $\mathbf{u}=\left(u_{j}\right)_{1 \leq j \leq n} \in \mathcal{H}$, we have $\mathbf{u} \in \mathcal{J}$ if and only if $\lambda_{1} u_{1}+\cdots \lambda_{n} u_{n}=0$. The $\lambda_{i}$ are all non zero.

Proof. We have $\left(\pi_{m}\right)_{1 \leq m \leq n, m \neq i} \cdot \mathcal{J}_{i}=0$. Hence $\pi_{i} \Phi_{i}\left(\mathcal{J}_{i}\right)=0$ and $\Phi_{i}\left(\mathcal{J}_{i}\right) \subset\left(\pi_{i}^{q_{i}-1}\right) /\left(\pi_{j}^{q_{i}}\right)$. The restriction of $\Phi_{i}, \mathcal{J}_{i} \rightarrow\left(\pi_{i}^{q_{i}-1}\right) /\left(\pi_{j}^{q_{i}}\right)$ is a morphism ( $n-1) \mathcal{O}_{C} \rightarrow \mathcal{O}_{C}$ of vector bundles on $C$. The existence of $\left(\lambda_{1}, \ldots, \lambda_{n}\right)$ follows from that.
If $\lambda_{i}=0$, we have $\left(0, \ldots, 0, \pi_{i}^{q_{i}-1}, 0, \ldots, 0\right) \in \mathcal{O}_{\mathcal{C}}(\mathcal{C})$. This is impossible because according to proposition 4.3.3, $\left(0, \ldots, 0, \pi_{i}^{q_{i}}, 0, \ldots, 0\right)$ generates the ideal sheaf of $\mathcal{C}_{J_{i}}$ in $\mathcal{C}$.

For all distinct integers $i, j$ such that $1 \leq i, j \leq n$, let $I_{i j}=\{1, \ldots, n\} \backslash\{i, j\}$. Then according to proposition 4.3.3, $\mathbf{u}_{I_{i j} i}$ generates the ideal sheaf of $\mathcal{C}_{I_{i j}}$. We have $\mathbf{u}_{I_{i j} i}=\left(b_{k}\right)_{1 \leq k \leq n}$, with $b_{k}=0$ if $k \neq i, j, b_{i}=\pi_{i}^{q_{i}-p_{i j}}$ and

$$
b_{j}=\left(\prod_{1 \leq m \leq n, m \neq i, j} \alpha_{m i}^{(j)}\right) \cdot \pi_{j}^{q_{j}-p_{i j}}
$$

So we have $\pi^{p_{i j}-1} \mathbf{u}_{I_{i j} i} \in \mathcal{J}_{i}$, which gives the equation

$$
\begin{equation*}
\frac{\lambda_{i}}{\lambda_{j}}=-\prod_{1 \leq m \leq n, m \neq i, j} \mathbf{a}_{m i}^{(j)} \tag{3}
\end{equation*}
$$

4.4.6. Proposition: For all distinct integers $i, j, k$ such that $1 \leq i, j, k \leq n$, we have

$$
\mathbf{a}_{k i}^{(j)}=-\mathbf{a}_{i k}^{(j)} \mathbf{a}_{j i}^{(k)}
$$

Proof. We need only to treat the case $n=3$, and we get the preceding formula by writing that $\frac{\lambda_{1}}{\lambda_{3}}=\frac{\lambda_{1}}{\lambda_{2}} \cdot \frac{\lambda_{2}}{\lambda_{3}}$, and by using (3).
4.4.7. Proposition: Let $\left(\alpha_{1} \pi_{1}^{m_{1}}, \ldots, \alpha_{n} \pi_{n}^{m_{n}}\right) \in \mathcal{O}_{\mathcal{C}, x}$, with $\alpha_{1}, \ldots, \alpha_{n}$ invertible. Let $M=m_{1}+\cdots+m_{n}$. then

$$
\left(\frac{1}{\alpha_{1}} \pi_{1}^{M-m_{1}}, \ldots, \frac{1}{\alpha_{n}} \pi_{n}^{M-m_{n}}\right) \in \mathcal{O}_{\mathcal{C}, x}
$$

Proof. By induction on $n$. It is obvious for $n=1$. Suppose that it is true for $n-1 \geq 1$. Let $I=\{1, \ldots, n-1\}$. Then $\left(\alpha_{1} \pi_{1}^{m_{1}}, \ldots, \alpha_{n-1} \pi_{n-1}^{m_{n-1}}\right) \in \mathcal{O}_{\mathcal{C}_{I, x}}$. Hence, by the induction hypothesis, we have

$$
\left(\frac{1}{\alpha_{1}} \pi_{1}^{M-m_{1}-m_{n}}, \ldots, \frac{1}{\alpha_{n-1}} \pi_{n-1}^{M-m_{n-1}-m_{n}}\right) \in \mathcal{O}_{\mathcal{C}_{I, x}} .
$$

So there exists $\gamma \in \mathcal{O}_{\mathcal{C}_{n, x}}$ such that

$$
u=\left(\frac{1}{\alpha_{1}} \pi_{1}^{M-m_{1}-m_{n}}, \ldots, \frac{1}{\alpha_{n-1}} \pi_{n-1}^{M-m_{n-1}-m_{n}}, \gamma\right) \in \mathcal{O}_{\mathcal{C}, x}
$$

Multiplying by $\left(\alpha_{1} \pi_{1}^{m_{1}}, \ldots, \alpha_{n} \pi_{n}^{m_{n}}\right)$ we see that $\left(\pi_{1}^{M-m_{n}}, \ldots, \pi_{n-1}^{M-m_{n}}, \gamma \alpha_{n} \pi_{n}^{m_{n}}\right) \in \mathcal{O}_{\mathcal{C}, x}$. Subtracting $\pi^{M-m_{n}}$, we find that $\left(0, \ldots, 0, \gamma \alpha_{n} \pi_{n}^{m_{n}}-\pi_{n}^{M-m_{n}}\right) \in \mathcal{O}_{\mathcal{C}, x}$. There exists $\alpha \in \mathcal{O}_{\mathcal{C}, x}$ such that the $n$-th coordinate of $\alpha$ is $\alpha_{n}$, and $\alpha$ is invertible. It follows that $v=\left(0, \ldots, 0, \gamma \pi_{n}^{m_{n}}-\frac{1}{\alpha_{n}} \pi_{n}^{M-m_{n}}\right) \in \mathcal{O}_{\mathcal{C}, x}$. Now we have

$$
\pi^{m_{n}} u-v=\left(\frac{1}{\alpha_{1}} \pi_{1}^{M-m_{1}}, \ldots, \frac{1}{\alpha_{n}} \pi_{n}^{M-m_{n}}\right) \in \mathcal{O}_{\mathcal{C}, x}
$$

4.4.8. Corollary: Let $V \subset U$ be open subsets of $\mathcal{C}$, and suppose that $U \cap C \neq \emptyset$. Let $\alpha \in \mathcal{O}_{\mathcal{C}}(V)$ and $\beta \in \mathcal{O}_{\mathcal{A}}(U)$ such that $\beta_{\mid V}=\alpha$. Then $\beta \in \mathcal{O}_{\mathcal{C}}(U)$.
(Recall that $\mathcal{A}$ is the initial gluing of $\mathcal{C}_{1}, \ldots, \mathcal{C}_{n}($ cf. 4.1.5)).
Proof. This can be proved easily by induction on $n$, using proposition 4.4.1.

### 4.5. Construction of fragmented deformations

Consider a fragmented deformation

$$
\pi=\pi^{[n-1]}=\left(\pi_{1}, \ldots, \pi_{n-1}\right): \mathcal{C}^{[n-1]} \longrightarrow S
$$

of $C_{n-1}$, with $n-1$ irreducible components $\mathcal{C}_{1}, \ldots, \mathcal{C}_{n-1}$. Let $\left(p_{i j}^{[n-1]}\right)_{1 \leq i, j<n}$ be its spectrum. For $1 \leq i<n$, let $q_{i}^{[n-1]}=\sum_{1 \leq j<n} p_{i j}^{[n-1]}$. We denote by $\mathcal{I}_{C}^{[n-1]}$ the ideal sheaf of $C$ in $\mathcal{C}^{[n-1]}$. Let $\lambda\left(\mathcal{C}^{[n-1]}\right)=\left(\lambda_{1}, \ldots, \lambda_{n-1}\right)$.
Let $p_{1 n}, \ldots, p_{n-1, n}$ be positive integers, $q_{i}=q_{i}^{[n-1]}+p_{i n}$ for $1 \leq i<n$, and $q_{n}=p_{1 n}+\cdots+p_{n-1, n}$. Let $\mathbf{u} \in H^{0}\left(\mathcal{I}_{C}^{[n-1]}\right)$ whose image generates $\mathcal{I}_{C}^{[n-1]} /\left(\left(\mathcal{I}_{C}^{[n-1]}\right)^{2}+(\pi)\right)$, of the form

$$
\mathbf{u}=\left(\beta_{1} \pi_{1}^{p_{1 n}}, \ldots, \beta_{n-1} \pi_{n-1}^{p_{n-1, n}}\right)
$$

with $\beta_{i} \in H^{0}\left(\mathcal{O}_{S}\right)$ invertible for $1 \leq i<n$.
Let $\mathcal{B}^{[n-1]}$ be the image of $\mathcal{O}_{\mathcal{C}^{[n-1]}}$ in $\mathcal{O}_{\mathcal{C}_{1}} /\left(\pi_{1}^{q_{1}}\right) \times \cdots \times \mathcal{O}_{\mathcal{C}_{n-1}} /\left(\pi_{n-1}^{q_{n-1}}\right)$. We will also denote by $\mathbf{u}$ the image of $\mathbf{u}$ in $\mathcal{B}^{[n-1]}$. Let $\mathcal{Q}=\mathcal{B}^{[n-1]} /(\mathbf{u}), \rho: \mathcal{B}^{[n-1]} \rightarrow \mathcal{Q}$ the projection and $\pi_{n}=\rho(\pi)$.
4.5.1. Proposition: We have $\pi_{n}^{q_{n}}=0$.

Proof. According to proposition 4.4.7 we have for every $x \in C$

$$
v=\left(\frac{1}{\beta_{1}} \pi_{1}^{q_{n}-p_{1 n}}, \ldots, \frac{1}{\beta_{n-1}} \pi_{n}^{q_{n}-p_{n-1, n}}\right) \in \mathcal{O}_{\mathcal{C}^{[n-1]} x}
$$

Hence $\pi^{q_{n}}=v \mathbf{u} \in(\mathbf{u})$ in $\mathcal{O}_{\mathcal{C}^{[n-1]} x}$, and $\pi_{n}^{q_{n}}=0$.
4.5.2. Proposition: 1 - We have $\pi_{n}^{q_{n}-1}=0$ if and only if

$$
\frac{\lambda_{1}}{\beta_{1 \mid C}}+\cdots+\frac{\lambda_{n-1}}{\beta_{n-1 \mid C}}=0
$$

We suppose now that $\frac{\lambda_{1}}{\beta_{1 \mid C}}+\cdots+\frac{\lambda_{n-1}}{\beta_{n-1 \mid C}} \neq 0$. Let $x \in C$. Then
$\mathbf{2}$ - For every $\epsilon \in \mathcal{B}_{x}^{[n-1]}$ such that $\epsilon_{\mid C} \neq 0$, we have $\pi^{q_{n}-1} \epsilon \notin(\mathbf{u})$.
$\mathbf{3}$ - For every $\eta \in \mathcal{B}_{x}^{[n-1]} /(\mathbf{u})$, and every integer $k$ such that $1 \leq k<q_{n}$, we have $\pi_{n}^{k} \eta=0$ if and only if $\eta$ is a multiple of $\pi_{n}^{q_{n}-k}$.
$\mathbf{4}-\mathcal{B}_{x}^{[n-1]} /(\mathbf{u})$ is a flat $\mathbb{C}\left[\pi_{n}\right] /\left(\pi_{n}^{q_{n}}\right)$-module.
Proof. We have $\pi_{n}^{q_{n}-1}=0$ if and only if $\left(\pi_{1}^{q_{n}-1}, \ldots, \pi_{n-1}^{q_{n}-1}\right) \in(\mathbf{u})$ in $\mathcal{B}_{x}^{[n-1]}$. We have, in $\mathcal{O}_{\mathcal{C}_{1 x}} \times \cdots \times \mathcal{O}_{\mathcal{C}_{n-1, x}}$,

$$
\left(\pi_{1}^{q_{n}-1}, \ldots, \pi_{n-1}^{q_{n}-1}\right)=\left(\beta_{1} \pi_{1}^{p_{1 n}}, \ldots, \beta_{n-1, n} \pi_{n-1}^{p_{n-1, n}}\right) \cdot\left(\frac{1}{\beta_{1}} \pi_{1}^{q_{1}^{[n-1]}-1}, \ldots, \frac{1}{\beta_{p}} \pi_{1}^{q_{n-1}^{[n-1]}-1}\right)
$$

and $\pi_{n}^{q_{n}-1}=0$ if and only if there exist $\eta \in \mathcal{O}_{\mathcal{C}^{[n-1]}, x}, a_{i} \in \mathcal{O}_{\mathcal{C}_{i}, x}, 1 \leq i<n$, such that

$$
\left(\pi_{1}^{q_{n}-1}, \ldots, \pi_{n-1}^{q_{n}-1}\right)=\eta \mathbf{u}+\left(a_{1} \pi_{1}^{q_{1}}, \ldots, a_{n-1} \pi_{n-1}^{q_{n-1}}\right) .
$$

This equality is equivalent to

$$
\left(\frac{1}{\beta_{1}} \pi_{1}^{q_{1}^{[n-1]}-1}, \ldots, \frac{1}{\beta_{n-1}} \pi_{1}^{q_{n-1}^{[n-1]}-1}\right)-\eta=\left(\frac{a_{1}}{\beta_{1}} \pi_{1}^{q_{1}^{[n-1]}}, \ldots, \frac{a_{n-1}}{\beta_{n-1}} \pi_{n-1}^{q_{n-1}^{[n-1]}}\right)
$$

Since for $1 \leq i<n$, we have $\left(0, \ldots, 0, \pi_{i}^{q_{i}^{[n-1]}}, 0, \ldots 0\right) \in \mathcal{O}_{\mathcal{C}^{[n-1]}, x}$, we have $\pi_{n}^{q_{n}-1}=0$ if and only if

$$
\left(\frac{1}{\beta_{1}} \pi_{1}^{q_{1}^{[n-1]}-1}, \ldots, \frac{1}{\beta_{n-1}} \pi_{1}^{q_{n-1}^{[n-1]}-1}\right) \in \mathcal{O}_{\mathcal{C}^{[n-1], x}}
$$

So the result of 1 - follows from the definition of $\lambda\left(\mathcal{C}^{[n-1]}\right)$ (cf. prop. 4.4.5), 2- is an easy consequence.
Now we prove 3 -, by induction on $k$. Suppose that it is true for $k=1$, and that $\pi_{n}^{k} \eta=0$, with $2 \leq k<q_{n}$. We have $\pi_{n}^{k-1} \cdot \pi_{n} \eta=0$, so according to the induction hypothesis, $\pi_{n} \eta$ is a multiple of $\pi_{n}^{q_{n}-k+1}: \pi_{n} \eta=\pi_{n}^{q_{n}-k+1} \lambda$. So $\pi_{n}\left(\eta-\pi_{n}^{q_{n}-k} \lambda\right)=0$. Since -3 is true for $k=1$, we can write $\eta-\pi_{n}^{q_{n}-k} \lambda=\pi_{n}^{q_{n}-1} \epsilon$, i.e. $\eta=\pi_{n}^{q_{n}-k}\left(\lambda+\pi_{n}^{k-1} \epsilon\right)$, and 3 - is true for $k$.
Il remains to prove 3 - for $k=1$. Suppose that $\pi_{n} \eta=0$ (with $\eta \neq 0$ ). We can write $\eta$ as $\eta=\pi_{n}^{m} \theta$, where $\theta$ is not a multiple of $\pi_{n}$, and $0 \leq m<q_{n}$. Let $\bar{\theta} \in \mathcal{B}_{x}^{[n-1]}$ be over $\theta$. Since $\mathcal{I}_{C}^{[n-1]}=(\mathbf{u})+(\pi)$ according to proposition 4.3.5. the condition " $\theta$ is not a multiple of $\pi_{n}$ " is equivalent to $\bar{\theta} \notin \mathcal{I}_{C, x}^{[n-1]}$. We have $\pi^{m+1} \bar{\theta} \in(\mathbf{u})$, so according to 2 -, we have $m+1 \geq q_{n}$, which proves 3 - for $k=1$. The last assertion is an easy consequence of 3 -.
4.5.3. Example: Let $N$ be an integer, $s \in H^{0}\left(\mathcal{O}_{S}\right)$ invertible, and $k, l$ integers such that $1 \leq k, l<n, k \neq l$. Suppose that for every integer $i$ such that $1 \leq i<n$ and $i \neq k$ we have $N>p_{i k}^{[n-1]}$ and $N \geq q_{i}^{[n-1]}-q_{k}^{[n-1]}+p_{i k}^{[n-1]}$. We take $\mathbf{u}=\mathbf{u}_{k l}-s \pi^{N}$. We have then $\beta_{i}=\alpha_{k l}^{(i)}$ if $i \neq k$, and $\beta_{k}=-s$. The condition $\frac{\lambda_{1}}{\beta_{1 \mid C}}+\cdots+\frac{\lambda_{n-1}}{\beta_{n-1 \mid C}} \neq 0$ is fulfilled if and only if

$$
\sum_{1 \leq i<n, i \neq k} \frac{\lambda_{i}}{\mathbf{a}_{k l}^{(i)}}-\frac{\lambda_{k}}{s_{\mid C}} \neq 0
$$

4.5.4. Construction of fragmented deformations - Suppose that $\frac{\lambda_{1}}{\beta_{1 \mid C}}+\cdots+\frac{\lambda_{n-1}}{\beta_{n-1 \mid C}} \neq 0$. From proposition 4.5.2, 4-, it is easy to prove that

- There exists a flat morphism of algebraic varieties $\tau: Y \rightarrow \operatorname{spec}\left(\mathbb{C}\left[\pi_{n}\right] /\left(\pi_{n}^{q_{n}}\right)\right)$ with a canonical isomorphism of sheaves of $\mathbb{C}\left[\pi_{n}\right] /\left(\pi_{n}^{q_{n}}\right)$-algebras $\mathcal{O}_{Y} \simeq \mathcal{Q}$, such that $\tau^{-1}(*)=C\left(\right.$ where $*$ is the closed point of $\left.\operatorname{spec}\left(\mathbb{C}\left[\pi_{n}\right] /\left(\pi_{n}^{q_{n}}\right)\right)\right)$.
- There exist a family of smooth curves $\mathcal{C}_{n}$ and a flat morphism $\pi_{n}: \mathcal{C}_{n} \rightarrow S$ extending $\tau$ (recall that $S$ is a germ). Hence $Y$ is the inverse image of the subscheme of $\mathcal{C}_{n}$ corresponding to the ideal sheaf $\left(\pi_{n}^{q_{n}}\right)$. The existence of $\mathcal{C}_{n}$ can be proved using Hilbert schemes of curves in projective spaces. Of course $\mathcal{C}_{n}$ need not be unique.

We obtain a gluing $\mathcal{C}$ of $\mathcal{C}_{1}, \ldots, \mathcal{C}_{n}$ by defining the sheaves of algebras $\mathcal{O}_{\mathcal{C}}$ (on the Zariski topological space corresponding to the initial gluing $\mathcal{A}$ ) as in 4.4.2, using for $\Phi_{n}$ the quotient morphism $\mathcal{B}^{[n-1]} \rightarrow \mathcal{Q}$. It is easy to see that $\pi^{-1}(P)$ is a primitive multiple curve $C_{n}$ of multiplicity $n$ extending $C_{n-1}$, hence $\mathcal{C}$ is a fragmented deformation of $C_{n}$.
4.5.5. Remark: 1 - The multiple curve $C_{n}$ depends on the choice of the family $\mathcal{C}_{n}$ extending the family $Y$ parametrized by $\operatorname{spec}\left(\mathbb{C}\left[\pi_{n}\right] /\left(\pi_{n}^{q_{n}}\right)\right)$.
2 - The multiple curve $C_{n-1}$ is completely defined by $\mathcal{B}^{[n-1]}$, because $\left(\pi_{1}^{q_{1}}\right) \times \cdots\left(\pi_{n-1}^{q_{n-1}}\right) \subset(\pi)$. But it is not enough to know $\mathcal{B}^{[n-1]}$ and $\mathbf{u}$ to define $C_{n}$. In fact we need $\mathcal{O}_{\mathcal{C}_{i}} /\left(\pi_{i}^{q_{i}+1}\right), 1 \leq i \leq n$.

### 4.6. Basic elements

We use the notations of 4.3 and 4.4.
Let $\mathbf{m}=\left(m_{1}, \ldots, m_{n}\right)$ be an $n$-tuple of positive integers, and

$$
\boldsymbol{\Pi}^{\mathrm{m}}=\left(\pi_{1}^{m_{1}}\right) \times \cdots \times\left(\pi_{n}^{m_{n}}\right)
$$

4.6.1. Definition: Let $x \in C$. An element $u$ of $\mathcal{O}_{\mathcal{C}, x}$ is called basic at order $\mathbf{m}$ if there exist polynomials $P_{1}, \ldots, P_{n} \in \mathbb{C}[X]$ such that

$$
u \equiv\left(P_{1}\left(\pi_{1}\right), \ldots, P_{n}\left(\pi_{n}\right)\right) \quad\left(\bmod . \quad \Pi^{\mathbf{m}}\right)
$$

If $u=\left(P_{1}\left(\pi_{1}\right), \ldots, P_{n}\left(\pi_{n}\right)\right)$, we say that $u$ is basic.

Let $\mathbf{q}=\left(q_{1}, \ldots, q_{n}\right)$. Then according to corollary 4.4.8, if $u$ is basic at order $\mathbf{q}$, then for every $y \in C$, we have $\left(P_{1}\left(\pi_{1}\right), \ldots, P_{n}\left(\pi_{n}\right)\right) \in \mathcal{O}_{\mathcal{C}, y}$. So $\left(P_{1}\left(\pi_{1}\right), \ldots, P_{n}\left(\pi_{n}\right)\right)$ is defined on a neighborhood of $C$.
4.6.2. Lemma: Let $u, v, w \in \mathcal{O}_{\mathcal{C}, x}$ such that $w=u v$ and $w \neq 0$. Suppose that $u$ and $w$ are basic at every order. Then $v$ is basic at every order.

Proof. Let $N$ be a positive integer such that $N \gg 0$ and $\mathbf{N}=(N, \ldots, N)$. Suppose that $w \equiv\left(Q_{1}\left(\pi_{1}\right), \ldots, Q_{n}\left(\pi_{n}\right)\right) \quad\left(\bmod . \quad\left(\pi^{N}\right)\right)$, where $Q_{1}, \ldots, Q_{n} \in \mathbb{C}[X]$. Let $\mathbf{m}=\left(m_{1}, \ldots, m_{n}\right)$ be an $n$-tuple of positive integers, and $v=\left(v_{i}\right)_{1 \leq i \leq n}$. Suppose that

$$
u \equiv\left(P_{1}\left(\pi_{1}\right), \ldots, P_{n}\left(\pi_{n}\right)\right) \quad\left(\bmod . \quad \Pi^{\mathbf{N}}\right)
$$

Then we have

$$
Q_{i}\left(\pi_{i}\right) \equiv P_{i}\left(\pi_{i}\right) \cdot v_{i} \quad\left(\bmod . \quad\left(\pi_{i}^{N}\right)\right)
$$

for $1 \leq i \leq n$. We can write $P_{i}(X)$ as $P_{i}(X)=X^{n_{i}} R_{i}(X)$, where $R_{i}(X) \in \mathbb{C}[X]$ is such that $R_{i}(0) \neq 0$. Then $Q_{i}(X)$ is also divisible by $X^{n_{i}}: Q_{i}(X)=X^{n_{i}} S_{i}(X)$, and we have in $\mathcal{O}_{\mathcal{A} x}$ :

$$
S_{i}\left(\pi_{i}\right) \equiv R_{i}\left(\pi_{i}\right) \cdot v_{i} \quad\left(\bmod . \quad\left(\pi_{i}^{N^{\prime}}\right)\right)
$$

for some integer $N^{\prime} \gg 0$. We can write $R_{i}(X)=a_{i} .\left(1-X . T_{i}(X)\right)$, with $a_{i} \in \mathbb{C}^{*}, T_{i} \in \mathbb{C}(X)$. We have then

$$
v_{i} \equiv \frac{S_{i}\left(\pi_{i}\right)}{a_{i}} \sum_{p=1}^{m_{i}-1}\left(\pi_{i} T_{i}\left(\pi_{i}\right)\right)^{p} \quad\left(\bmod . \quad \Pi^{\mathbf{m}}\right)
$$

For $1 \leq i \leq n$, let $\mathbf{u}_{(i)}=\left(\left(u_{(i) j}\right)_{1 \leq j \leq n}\right.$ be a generator of the ideal sheaf $\mathcal{I}_{\mathcal{C}_{i}}$ of $\mathcal{C}_{i}$ in $\mathcal{C}$, such that for $1 \leq j \leq n, u_{(i) j} \in \mathbb{C}\left[\pi_{j}\right]$ (cf. corollary 4.3.8).
4.6.3. Proposition: Let $v \in \mathcal{O}_{\mathcal{C}, x}$. then $v$ is basic at every order if and only if for every $n$-tuple $\mathbf{m}$ of positive integers, there exist an integer $q>0$ and $P_{1}, \ldots, P_{q} \in \mathbb{C}[X]$ such that

$$
v \equiv \sum_{1 \leq j \leq q} P_{j}(\pi) \cdot \mathbf{u}_{(i)}^{j} \quad\left(\bmod . \quad \Pi^{\mathrm{m}}\right)
$$

Proof. We use the notations of the proof of lemma 4.6.2. Suppose that $v=\left(v_{j}\right)_{1 \leq j \leq n}$ is basic at every order. Let $N$ be a positive integer and $\mathbf{N}=(N, \ldots, N)$. We will prove by induction on $q \geq 0$ that we can write $v$ as

$$
\begin{equation*}
v \equiv \sum_{0 \leq j \leq q} P_{j}(\pi) \cdot \mathbf{u}_{(i)}^{j}+\gamma_{q} \mathbf{u}_{(i)}^{q+1} \quad\left(\bmod . \quad \Pi^{\mathbf{N}}\right) \tag{4}
\end{equation*}
$$

with $P_{0}, \ldots, P_{q} \in \mathbb{C}[X]$, and $\gamma_{q} \in \mathcal{O}_{\mathcal{C}, x}$. This proves proposition4.6.3 if $q$ and $N$ are big enough. For $q=0$, we have $v_{i} \equiv P\left(\pi_{i}\right)\left(\bmod \pi_{i}^{N}\right)$, for some $P \in \mathbb{C}[X]$, and we can take $P_{0}=P$. Suppose that the result is true for $q$ and that we have (4). Since $v-\sum_{1 \leq j \leq q} P_{j}(\pi) \cdot \mathbf{u}_{(i)}^{j}$ is basic at any order, using the same method as in the proof of lemma 4.6.2, we see that $\gamma_{q}$ is basic at order $\mathbf{N}^{\prime}$, where $\mathbf{N}^{\prime}=\left(N^{\prime}, \ldots, N^{\prime}\right)$, for some integer $N^{\prime} \gg 0$. As in the case $q=0$ we have

$$
\gamma_{q} \equiv P_{q+1}(\pi)+\mathbf{u}_{(i)} \cdot \gamma_{q+1} \quad\left(\bmod \quad \Pi^{\mathbf{N}^{\prime}}\right)
$$

with $P_{q+1} \in \mathbb{C}[X]$. Hence

$$
v \equiv \sum_{0 \leq j \leq q+1} P_{j}(\pi) \cdot \mathbf{u}_{(i)}^{j}+\gamma_{q+1} \mathbf{u}_{(i)}^{q+2} \quad\left(\bmod . \quad \Pi^{\mathbf{N}}\right)
$$

4.6.4. Proposition: Let $\alpha=\left(\alpha_{1}, \ldots, \alpha_{n}\right) \in \mathcal{O}_{\mathcal{C}, x}$ be such that there exists
$P_{1}, \ldots, P_{n-1} \in \mathbb{C}[X]$ such that, for $1 \leq i \leq n-1$, we have $\alpha_{i} \equiv P_{i}\left(\pi_{i}\right)$ (mod. ( $\left.\pi_{i}^{q_{i}}\right)$ ). Then there exists $P_{n} \in \mathbb{C}[X]$ such that $\alpha_{n} \equiv P_{n}\left(\pi_{n}\right)\left(\bmod .\left(\pi^{q_{n}}\right)\right)$, i.e. $\alpha$ is a basic element of order q.

Proof. By induction on $n$. The case $n=2$ is an easy consequence of proposition 4.2.2. Suppose that $n \geq 3$ and that the result is true for $n-1$.
By subtracting multiples of $\left(0, \ldots, 0, \pi_{i}^{q_{i}}, 0, \ldots, 0\right)$ we may assume that for $1 \leq i \leq n-1, \alpha_{i} \in \mathbb{C}\left[\pi_{i}\right]$. By subtracting a regular function on a neighborhood of $C$ in $\mathcal{C}$, and a multiple of $\left(\pi_{1}^{q_{1}}, 0, \ldots, 0\right)$ we may also assume that $\alpha_{1}=0$. The ideal sheaf of $\mathcal{C}_{1}$ is generated by $\mathbf{u}_{(1)}$. We can then write $\alpha=\beta \mathbf{u}_{(1)}$, with $\beta=\left(\beta_{i}\right)_{1 \leq i \leq n} \in \mathcal{O}_{\mathcal{C}, x}$. We have

$$
\left(\alpha_{2}, \ldots, \alpha_{n-1}\right)=\left(\beta_{2}, \ldots, \beta_{n-1}\right) \cdot\left(u_{(1) 2}, \ldots, u_{(1) n-1}\right)
$$

hence by lemma 4.6.2, $\left(\beta_{2}, \ldots, \beta_{n-1}\right)$ is a basic element at any order. By the induction hypothesis, there exists $Q \in \mathbb{C}[X]$ such that $\beta_{n} \equiv Q\left(\pi_{n}\right)\left(\bmod .\left(\pi_{n}^{q_{n}-p_{1 n}}\right)\right)$. Since $u_{(1) n}$ is a multiple of $\pi_{n}^{p_{1 n}}$ (from the definition of $\left.p_{1 n}\right)$, it follows that $\alpha_{n} \equiv u_{(i) n} Q\left(\pi_{n}\right)\left(\bmod .\left(\pi^{q_{n}}\right)\right)$.

### 4.7. Simple primitive curves and fragmented deformations

Let $C_{n}$ be a primitive multiple curve of multiplicity $n$ and associated smooth curve $C$. Let $\mathcal{I}_{C}$ be the ideal sheaf of $C$ in $C_{n}$. It is obvious from proposition 4.3.5, 1-, that if there exists a fragmented deformation of $C_{n}$, then we have $\mathcal{I}_{C, C_{n}} \simeq \mathcal{O}_{C_{n-1}}$, i.e. $C_{n}$ is simple (cf. 2.4). Conversely we have
4.7.1. Theorem: Let $C_{n}$ be a simple primitive multiple curve of multiplicity $n$. Then there exists a fragmented deformation of $C_{n}$.

Proof. According to theorem 2.4.1, there exists a flat family of smooth projective curves $\tau: \mathcal{C} \rightarrow \mathbb{C}$ such that $\tau^{-1}(0) \simeq C$ and that $C_{n}$ is isomorphic to the $n$-th infinitesimal neighborhood of $C$ in $\mathcal{C}$. Let $\rho_{n}: \mathbb{C} \rightarrow \mathbb{C}$ be the map defined by $\rho_{n}(z)=z^{n}$, and $\theta=\rho_{n} \circ \tau: \mathcal{C} \rightarrow \mathbb{C}$. It is a flat morphism, $\theta^{-1}(0)=C_{n}$, and for every $z \neq 0$ in the image of $\tau, \theta^{-1}(z)$ is a disjoint union of $n$ smooth irreducible curves. We can then apply the process of proposition 3.1.3 to obtain the desired fragmented deformation: it is $\mathcal{C} \times \mathbb{C}$

4.7.2. Remark: let $\left(p_{i j}\right)$ be the spectrum of the fragmented deformation constructed in the proof of theorem 4.7.1. Then it is easy to see that $p_{i j}=1$ for $1 \leq i, j \leq n, i \neq j$. If $x \in C$, then

$$
\begin{aligned}
& \left(\mathcal{C} \times_{\mathbb{C}} \mathbb{C}\right)_{x}=\mathcal{O}_{\mathcal{C}, x} \otimes_{\mathcal{O}_{\mathbb{C}, x}} \mathcal{O}_{\mathbb{C}, x}, \text { and if } t=I_{\mathbb{C}} \in \mathcal{O}_{\mathbb{C}, x}, \text { we have for } 1 \leq k \leq n \\
& \quad\left(\pi_{1}, \ldots, \pi_{k-1}, 0, \pi_{k+1}, \ldots, \pi_{n}\right)=\frac{1}{n-1}\left(1 \otimes t-e^{\frac{2 k i \pi}{n}}(t \otimes 1)\right) .
\end{aligned}
$$

## 5. Stars of a curve

### 5.1. Definitions

Let $S$ be a smooth irreducible curve, and $P \in S$ (we can also take for $(S, P)$ the germ of a smooth curve). Let $n$ be a positive integer.
5.1.1. Definition: An $n$-star (or more simply, a star) of $(S, P)$ is an algebraic variety $\mathcal{S}$ such that
(i) $\mathcal{S}$ is the union of $n$ irreducible components $S_{1}, \ldots, S_{n}$, with fixed isomorphisms $S_{i} \simeq S$, $1 \leq i \leq n$.
(ii) For $1 \leq i<j \leq n$, $S_{i} \cap S_{j}$ has only one closed point, namely $P$.
(iii) There exists a morphism $\pi: \mathcal{S} \rightarrow S$, such that for $1 \leq i \leq n$, the restriction $\pi_{\mid S_{i}}: S_{i} \rightarrow S$ is the isomorphism $S_{i} \simeq S$ of (i).

All the $n$-stars of $(S, P)$ have the same underlying Zariski topological space $S(n)$ and set of closed points. The latter is $\left(\bigcup_{1 \leq i \leq n} \widehat{S}_{i}\right) / \sim$, where $\widehat{S}_{i}$ is the set of closed points of $S_{i}$, and the equivalence relation $\sim$ is defined by: for $x \in \widehat{S}_{i}$ and $y \in \widehat{S}_{j}, x \sim y$ if and only if $i=j$ and $x=y$, or $x=P \in \widehat{S}_{i}$ and $y=P \in \widehat{S}_{j}$. An open subset of $\mathcal{S}$ is defined by open subsets $U_{1}$ of $S_{1}, \ldots$, $U_{n}$ of $S_{n}$, such that for $1 \leq i<j \leq n$, we have $P \in U_{i}$ if and only if $P \in U_{j}$.

The initial star $\mathcal{S}_{0}$ of $(S, P)$ is defined as follows: for every open subset $U$ of $S(n)$, $\mathcal{O}_{\boldsymbol{S}_{0}}(U)$ is the set of $\left(\alpha_{1}, \ldots, \alpha_{n}\right) \in \mathcal{O}_{S_{1}}\left(U \cap S_{1}\right) \times \cdots \mathcal{O}_{S_{n}}\left(U \cap S_{n}\right)$ such that if $P \in U$ then $\alpha_{1}(P)=\cdots=\alpha_{n}(P)$.
For every $n$-star $\mathcal{S}$ of $(S, P)$, there is a unique dominant morphism $\mathcal{S}_{0} \rightarrow \mathcal{S}$ inducing the identity on each component. So $\mathcal{O}_{\mathcal{S}, P}$ is a subring of $\mathcal{O}_{\boldsymbol{\mathcal { S }}_{0}, P}$.
Note that (iii) is equivalent to
(iii)' For every $\alpha \in \mathcal{O}_{S, P}$, we have $(\alpha, \ldots, \alpha) \in \mathcal{O}_{\mathcal{S}, P}$.
5.1.2. Definition: An oblate $n$-star (or more simply, an oblate star) of $(S, P)$ is an $n$-star $\mathcal{S}$ such that some neighborhood of $P$ in $\mathcal{S}$ can be embedded in a smooth surface.
5.1.3. Proposition: An $n$-star $\mathcal{S}$ is oblate if and only if $\pi^{-1}(P) \simeq \operatorname{spec}\left(\mathbb{C}[X] /\left(X^{n}\right)\right)$.
(cf. prop. 4.1.6).
Let $I \subset\{1, \ldots, n\}$ be a nonempty subset. Let $\boldsymbol{\mathcal { S }}^{(I)}=\bigcup_{i \in I} S_{i} \subset \mathcal{S}$. If $\boldsymbol{\mathcal { S }}$ is oblate then $\boldsymbol{\mathcal { S }}^{(I)}$ is oblate too.

### 5.2. Properties of oblate stars

Let $\mathcal{S}$ be an oblate $n$-star of $S$. Recall that $t$ denotes a generator of the maximal ideal of $P$ in $S$. We will denote this generator on $S_{i} \subset \mathcal{S}$ by $t_{i}$. We will also denote by $\pi$ the element $t \circ \pi$ of the maximal ideal of $P$ in $\mathcal{S}$. Let $\mathcal{I}_{P}$ be the ideal sheaf of $P$ in $\mathcal{S}$.
We begin with 2-stars:
5.2.1. Proposition: Suppose that $n=2$. Then

1 - There exists a unique integer $p>0$ such that $\mathcal{I}_{P, P} /(\pi)$ is generated by the image of $\left(t_{1}^{p}, 0\right)$.
2 - The image of $\left(0, t_{2}^{p}\right)$ is also a generator of $\mathcal{I}_{P, P} /(\pi)$.
$\mathbf{3}-\left(0, t_{2}^{p}\right)\left(\right.$ resp. $\left.\left(t_{1}^{p}, 0\right)\right)$ is a generator of the ideal sheaf of $S_{1}\left(\right.$ resp. $\left.S_{2}\right)$ at $P$.
$4-\mathcal{O}_{S^{(2)}, P}$ consists of pairs $(\alpha, \beta) \in \mathcal{O}_{S, P} \times \mathcal{O}_{S, P}$ such that $\alpha-\beta \in\left(t^{p}\right)$.
(cf. prop. 4.2.1 and 4.2.2).

Now suppose that $n \geq 2$. Let $I=\{i, j\} \subset\{1, \ldots, n\}$, with $i \neq j$. Then $S_{i} \cup S_{j} \subset \mathcal{S}$ is a 2-star of $S$. Hence by proposition 5.2.1 there exists a unique integer $p_{i j}>0$ such that $\mathcal{I}_{P, P} /(\pi)$ (on $\left.S_{i} \cup S_{j}\right)$ is generated by the image of $\left(t_{i}^{p_{i j}}, 0\right)$ (and also by the image of $\left(0, t_{j}^{p_{i j}}\right)$ ). Let $p_{i i}=0$. Then the symmetric matrix $\left(p_{i j}\right)_{1 \leq i, j \leq n}$ is called the spectrum of $\mathcal{S}$.
There exists an element $v_{i j}=\left(\nu_{m}\right)_{1 \leq m \leq n}$ such that $\nu_{i}=0$ and $\nu_{j}=t_{j}^{p_{i j}}$. For every integer $m$ such that $1 \leq m \leq n, m \neq i, j$, there exists an invertible element $\beta_{i j}^{(m)} \in \mathcal{O}_{S, P}$ such that $\nu_{m}=\beta_{i j}^{(m)} t_{m}^{p_{i m}}$. Let $\beta_{i j}^{(i)}=0, \beta_{i j}^{(j)}=1$.
5.2.2. Proposition: Let $\mathbf{b}_{i j}^{(m)}=\beta_{i j}^{(m)}(P) \in \mathbb{C}$. Then we have, for all integers $i, j, k, m, q$ such that $1 \leq i, j, k, m, q \leq n, i \neq j, i \neq k$

$$
\mathbf{b}_{i k}^{(m)} \mathbf{b}_{i j}^{(q)}=\mathbf{b}_{i k}^{(q)} \mathbf{b}_{i j}^{(m)}
$$

In particular we have $\mathbf{b}_{i j}^{(m)}=\mathbf{b}_{i k}^{(m)} \mathbf{b}_{i j}^{(k)}$ and $\mathbf{b}_{i j}^{(m)} \mathbf{b}_{i m}^{(j)}=1$.
For all distinct integers $i, j, k$ such that $1 \leq i, j, k \leq n$, we have

$$
\mathbf{b}_{k i}^{(j)}=-\mathbf{b}_{i k}^{(j)} \mathbf{b}_{j i}^{(k)}
$$

(cf. prop. 4.3.2 and 4.4.6).

Let $p$ be an integer such that $1 \leq p<n$, and $\left(i_{1}, j_{1}\right), \ldots,\left(i_{p}, j_{p}\right) p$ pairs of distinct integers of $\{1, \ldots, n\}$. Then the image of $\prod_{m=1}^{p} \mathbf{v}_{i_{m} j_{m}}$ is a generator of $\left(\mathcal{I}_{P, P}^{p}+(\pi)\right) /\left(\mathcal{I}_{P, P}^{p+1}+(\pi)\right)$.
Let $I \subset\{1, \cdots, n\}$ be a nonempty subset, distinct from $\{1, \cdots, n\}$. Let $i \in\{1, \cdots, n\} \backslash I$. Let

$$
\mathbf{v}_{I, i}=\prod_{j \in I} \mathbf{v}_{j i}
$$

5.2.3. Proposition: The ideal sheaf of $\boldsymbol{\mathcal { S }}^{(I)}$ in $\mathcal{S}$ is generated by $\mathbf{v}_{I, i}$ at $P$.
(cf. prop. 4.3.3).

Note that if $I=\{1, \cdots, n\} \backslash\{i\}$ then $\mathbf{v}_{I, i \mid S_{j}}=0$ if $j \neq i$, and $\mathbf{v}_{I, i \mid S_{i}}=t_{i}^{q_{i}}$, with $q_{i}=\sum_{1 \leq j \leq n} p_{i j}$. Let $i$ be an integer such that $1 \leq i \leq n$ and $J_{i}=\{1, \ldots, n\} \backslash\{i\}$. Let $\mathcal{K}_{i}$ be the image of $\mathcal{O}_{\mathcal{S}}$ in $\prod_{1 \leq j \leq n, j \neq i} \mathcal{O}_{S_{j}} /\left(t_{j}^{q_{j}}\right)$. We can view $\mathcal{K}_{i}$ as a $\mathbb{C}$-algebra. For every $\alpha=\left(\alpha_{m}\right) \in \mathcal{O}_{\mathcal{S}, P}$, let $k_{i}(\alpha)$ be the image of $\alpha$ in $\mathcal{K}_{i}$.
5.2.4. Proposition: There exists a morphism of $\mathbb{C}$-algebras

$$
\Psi_{i}: \mathcal{K}_{i} \longrightarrow \mathcal{O}_{S_{i, P}} /\left(t_{i}^{q_{i}}\right)
$$

such that for every $\left(\alpha_{m}\right)_{1 \leq m \leq n, m \neq i} \in \mathcal{O}_{\mathcal{S}^{\left(J_{i}\right)}, P}, \alpha_{i} \in \mathcal{O}_{S_{j, P}}$, we have $\alpha=\left(\alpha_{m}\right)_{1 \leq m \leq n} \in \mathcal{O}_{\mathcal{S}, P}$ if and only if $\Psi_{i}\left(k_{i}(\alpha)\right)=\left[\alpha_{i}\right]_{q_{i}}$.
(cf. prop. 4.4.1).

The morphism $\Psi_{i}$ has the following properties:
(i) For every $\left(\alpha_{m}\right)_{1 \leq m \leq n, m \neq i} \in \mathcal{O}_{\mathcal{S}^{\left(J_{i}\right), P}}$, we have $\Psi_{i}(\alpha)(P)=\alpha_{m}(P)$ for $1 \leq m \leq n, m \neq i$.
(ii) We have $\Psi_{i}\left(\left(t_{m}\right)_{1 \leq m \leq n, m \neq i}\right)=t_{i}$.
(iii) Let $j, k \in\{1, \cdots, n\}$ be such that $i, j, k$ are distinct. Let $\mathbf{w}$ be the image of $\mathbf{v}_{j k}$ in $\mathcal{B}_{i}$. Then there exists $\lambda \in \mathcal{O}_{S_{i, P}}^{*}$ such that $\Psi_{i}(\mathbf{w})=\lambda t_{i}^{p_{i j}}$.
(iv) Let $j$ be an integer such that $1 \leq j \leq n$ and $j \neq i$. Let $\mathbf{w}$ be the image of $\mathbf{v}_{i j}$ in $\mathcal{K}_{i} x$. Then we have $\operatorname{ker}\left(\Psi_{i}\right)=(\mathbf{w})$.
5.2.5. Converse - Let $\mathcal{S}^{[n-1]}$ be a $(n-1)$-star of $S$, with components $S_{1}, \ldots, S_{n-1}$, of spectrum $\left(p_{j k}\right)_{1 \leq j, k \leq n-1}$. Let $p_{n j}=p_{j n}, 1 \leq j<n$ be positive integers, and $p_{n n}=0$. For $1 \leq j \leq n$, let $q_{j}=\sum_{1 \leq k \leq n} p_{k j}$.
Let $S_{n}$ be another copy of $S$. Let $\mathcal{K}_{n}$ be the image of $\mathcal{O}_{\mathcal{S}^{[n-1]}}$ in $\prod_{1 \leq j \leq n-1} \mathcal{O}_{S_{j}} /\left(t_{j}^{q_{j}}\right)$ and

$$
\Psi_{n}: \mathcal{K}_{n} \longrightarrow \mathcal{O}_{S_{n}} /\left(t_{n}^{q_{n}}\right)
$$

a morphism of $\mathbb{C}$-algebras satisfying properties (i), (ii), (iii) above. Let $\mathcal{K}$ be the subsheaf of algebras of $\mathcal{O}_{\mathcal{S}_{0}}$ defined by: $\mathcal{K}=\mathcal{O}_{\mathcal{S}_{0}}$ on $\boldsymbol{\mathcal { S }}_{0} \backslash\{P\}$, and for every $\alpha=\left(\alpha_{m}\right)_{1 \leq m \leq n} \in \mathcal{O}_{\mathcal{S}_{0}, P}$, $\alpha \in \mathcal{K}_{P}$ if and only if $\Psi_{n}\left(\alpha^{\prime}\right)=\left[\alpha_{n}\right]_{q_{n}}$ (where $\alpha^{\prime}$ is the image of $\left(\alpha_{m}\right)_{1 \leq m \leq n-1}$ in $\left.\mathcal{K}_{n}\right)$.
It is easy to see that $\mathcal{K}$ is the structural sheaf of an oblate $n$-star of $S$.

Let $\mathcal{H}=\prod_{1 \leq j \leq n}\left(t_{j}^{q_{j}-1}\right) /\left(t_{j}^{q_{j}}\right) \simeq \mathbb{C}^{n}$ and $\mathcal{K}$ be the image of $\mathcal{O}_{\mathcal{S}}$ in $\prod_{1 \leq j \leq n} \mathcal{O}_{S_{j}} /\left(t_{j}^{q_{j}}\right)$. We can view $\mathcal{K}$ as a $\overline{\mathbb{C}}$-algebra. Let $\mathcal{J}=\mathcal{H} \cap \mathcal{K}$.
5.2.6. Proposition: There exists a unique $\lambda(\mathcal{S})=\left(\lambda_{1}, \ldots, \lambda_{n}\right) \in \mathbb{P}_{n}(\mathbb{C})$ such that for every $\mathbf{u}=\left(u_{j}\right)_{1 \leq j \leq n} \in \mathcal{H}$, we have $\mathbf{u} \in \mathcal{J}$ if and only if $\lambda_{1} u_{1}+\cdots \lambda_{n} u_{n}=0$. The $\lambda_{i}$ are all non zero.
(cf. prop. 4.4.5).

For all distinct integers $i, j$ such that $1 \leq i, j \leq n$, we have

$$
\frac{\lambda_{i}}{\lambda_{j}}=-\prod_{1 \leq m \leq n, m \neq i, j} \mathbf{b}_{m i}^{(j)}
$$

### 5.3. Construction of oblate stars of a curve

Consider an oblate $(n-1)$-star of $S, \mathcal{S}^{[n-1]}$, with $n-1$ irreducible components $S_{1}, \ldots, S_{n-1}$, copies of $S$. Let $\left(p_{i j}^{[n-1]}\right)_{1 \leq i, j<n}$ be its spectrum. For $1 \leq i<n$, let $q_{i}^{[n-1]}=\sum_{1 \leq j<n} p_{i j}^{[n-1]}$. We denote by $\mathcal{I}_{P}^{[n-1]}$ the ideal of $P$ in $\mathcal{O}_{\mathcal{S}^{[n-1]}, P}$. Let $\lambda\left(\mathcal{S}^{[n-1]}\right)=\left(\lambda_{1}, \ldots, \lambda_{n-1}\right)$.
Let $p_{1 n}, \ldots, p_{n-1, n}$ be positive integers, $q_{i}=q_{i}^{[n-1]}+p_{i n}$ for $1 \leq i<n$, and $q_{n}=p_{i 1}+\cdots+p_{n-1, n}$. Let $\mathbf{u} \in \mathcal{I}_{P, P}^{[n-1]}$ whose image generates $\mathcal{I}_{P}^{[n-1]} /\left(\left(\mathcal{I}_{P}^{[n-1]}\right)^{2}+(\pi)\right)$, of the form

$$
\mathbf{u}=\left(\beta_{1} t_{1}^{p_{1 n}}, \ldots, \beta_{n-1} t_{n-1}^{p_{n-1, n}}\right)
$$

with $\beta_{i} \in \mathcal{O}_{S_{i, P}}$ invertible for $1 \leq i<n$.
Let $\mathcal{K}^{[n-1]}$ be the image of $\mathcal{O}_{\mathcal{S}^{[n-1]}}$ in $\mathcal{O}_{S_{1}} /\left(t_{1}^{q_{1}}\right) \times \cdots \times \mathcal{O}_{S_{n-1}} /\left(t_{n-1}^{q_{n-1}}\right)$. We will also denote by $\mathbf{u}$ the image of $\mathbf{u}$ in $\mathcal{K}^{[n-1]}$. Let $\mathcal{Q}=\mathcal{K}^{[n-1]} /(\mathbf{u}), \rho: \mathcal{K}^{[n-1]} \rightarrow \mathcal{Q}$ the projection and $t_{n}=\rho(\pi)$.
5.3.1. Proposition: 1 - We have $t_{n}^{q_{n}}=0$.

2 - We have $t_{n}^{q_{n}-1}=0$ if and only if

$$
\frac{\lambda_{1}}{\beta_{1}(P)}+\cdots+\frac{\lambda_{n-1}}{\beta_{n-1}(P)}=0
$$

We suppose now that $\frac{\lambda_{1}}{\beta_{1}(P)}+\cdots+\frac{\lambda_{n-1}}{\beta_{n-1}(P)} \neq 0$. Then
$\mathbf{3}$ - For every $\epsilon \in \mathcal{K}^{[n-1]}$ such that $\epsilon(P) \neq 0$, we have $t^{q_{n}-1} \epsilon \notin(\mathbf{u})$.
$\mathbf{4}$ - For every $\eta \in \mathcal{K}^{[n-1]} /(\mathbf{u})$, and every integer $k$ such that $1 \leq k<q_{n}$, we have $t_{n}^{k} \eta=0$ if and only if $\eta$ is a multiple of $t_{n}^{q_{n}-k}$.
$5-\mathcal{K}^{[n-1]} /(\mathbf{u})$ is a flat $\mathbb{C}\left[t_{n}\right] /\left(t_{n}^{q_{n}}\right)$-module.
(cf. prop. 4.5.2).
5.3.2. Construction of stars of a curve - Suppose that $\frac{\lambda_{1}}{\beta_{1}(P)}+\cdots+\frac{\lambda_{n-1}}{\beta_{n-1}(P)} \neq 0$. From proposition 5.3.1, 5 -, it is easy to prove, using 5.2.5, that there is a unique oblate $n$-star $\boldsymbol{\mathcal { S }}$ such that $\mathcal{S}^{[n-1]}$ is the union $\bigcup_{1 \leq i \leq n-1} S_{i}$ in $\mathcal{S}$ and $\Psi_{n}$ is the quotient map $\mathcal{K}_{n}=\mathcal{K}^{[n-1]} \rightarrow \mathcal{Q}$.

### 5.4. Morphisms of stars

Recall that if $\mathcal{S}$ is an oblate $n$-star of $S$, then we have a canonical inclusion of sheaves of algebras (on the underlying topological space $S(n)$ of $\boldsymbol{\mathcal { S }}$ ) $\mathcal{O}_{\mathcal{S}} \subset \mathcal{O}_{\mathcal{S}_{0}}$.
Let $\boldsymbol{\mathcal { S }}, \mathcal{S}^{\prime}$ be oblate $n$-stars of $S$, with irreducible components $S_{1}, \ldots, S_{n}$, and $f: \mathcal{S} \rightarrow \boldsymbol{\mathcal { S }}^{\prime}$ a morphism inducing the identity on all the components. Such a morphism exists if and only if $\mathcal{O}_{\mathcal{S}^{\prime}} \subset \mathcal{O}_{\mathcal{S}}$, and in this case $f$ is unique and is induced by the previous inclusion. Let $\left(p_{i j}\right)$ (resp. $\left.\left(p_{i j}^{\prime}\right)\right)$ be the spectrum of $\mathcal{S}$ (resp. $\left.\mathcal{S}^{\prime}\right)$.
5.4.1. Proposition: We have $p_{i j} \leq p_{i j}^{\prime}$ for $1 \leq i, j \leq n$. If $f$ is not the identity morphism then there exist $i, j$ such that $p_{i j}<p_{i j}^{\prime}$.

Proof. Let $I=\{i, j\}$. Then $f$ induces a morphism $\mathcal{S}^{(I)} \rightarrow \mathcal{S}^{(I)}$. So we have $\mathcal{O}_{\mathcal{S}^{\prime(I)}, P} \subset \mathcal{O}_{\mathcal{S}^{(I)}, P}$. From proposition 5.2.1, 4-, it follows that $p_{i j} \leq p_{i j}^{\prime}$.
Suppose now that $p_{i j}^{\prime}=p_{i j}$ for $1 \leq i, j \leq n$. We must prove that $\mathcal{S}=\boldsymbol{\mathcal { S }}^{\prime}$, i.e. that $\mathcal{O}_{\mathcal{S}^{\prime}, P}=\mathcal{O}_{\mathcal{S}, P}$. This is done by induction on $n$. For $n=2$ it is obvious. Suppose that it is true for $n-1$. Let $I=\{1, \ldots, n-1\}$. Then $f$ induces a morphism $f_{n-1}: \boldsymbol{\mathcal { S }}^{(I)} \rightarrow \boldsymbol{\mathcal { S }}^{(I)}$. It follows from the induction hypothesis that $\boldsymbol{\mathcal { S }}^{(I)}=\boldsymbol{\mathcal { S }}^{(I)}$. Since the integers $q_{i}$ are the same for $\boldsymbol{\mathcal { S }}$ and $\boldsymbol{\mathcal { S }}^{\prime}$, the algebras $\mathcal{K}_{n}$ for $\boldsymbol{\mathcal { S }}$ and $\boldsymbol{\mathcal { S }}^{\prime}$ (cf. proposition 5.2.4) are also the same. Now let $\alpha \in \mathcal{O}_{\mathcal{S}, P}$, and let $\beta \in \mathcal{K}_{n}$ be the image of $\alpha$. Let $\alpha^{\prime} \in \mathcal{O}_{\mathcal{S}^{\prime}, P}$ be such that its image in $\mathcal{K}_{n}$ is also $\beta$. Then $\alpha-\alpha^{\prime}$ belongs to the ideal generated by the $\left(0, \ldots, 0, t_{i}^{q_{i}}, 0 \ldots, 0\right), 1 \leq i \leq n$, which is included in $\mathcal{O}_{\mathcal{S}^{\prime}, P}$. Hence $\alpha \in \mathcal{O}_{\mathcal{S}^{\prime}, P}$.
5.4.2. Lemma: Suppose that $f$ is not the identity morphism. Then there exist an ideal $\mathcal{I} \subset \mathcal{O}_{\mathcal{S}^{\prime}, P}$ and $u \in \mathcal{I}, v \in \mathcal{O}_{\mathcal{S}, P}$ such that

$$
u \otimes v \neq 0 \quad \text { in } \quad \mathcal{I} \otimes_{\mathcal{O}_{\mathcal{S}^{\prime}, P}} \mathcal{O}_{\mathcal{S}, P}
$$

and $u v=0$.
Proof. Let $q_{1}=\sum_{i=1}^{n} p_{1 i}, q_{1}^{\prime}=\sum_{i=1}^{n} p_{1 i}^{\prime} . \quad$ According to proposition 5.4.1 we can assume that
$q_{1}<q_{1}^{\prime}$. Let $u$ be a generator of the ideal of $S_{1}$ in $\mathcal{O}_{\mathcal{S}^{\prime} P}$ and $\left.\mathcal{I}=u\right)$. Let $v=\left(t_{1}^{q_{1}}, 0, \ldots, 0\right)$. $q_{1}<q_{1}^{\prime}$. Let $u$ be a generator of the ideal of $S_{1}$ in $\mathcal{O}_{\mathcal{S}^{\prime}, P}$ and $\mathcal{I}=(u)$. Let $v=\left(t_{1}^{q_{1}}, 0, \ldots, 0\right)$. We have $u v=0$. We have to prove that $u \otimes v \neq 0$. We need only to find an $\mathcal{O}_{\mathcal{S}^{\prime}, P}$-module $M$ and a $\mathcal{O}_{\mathcal{S}^{\prime}, P}$-bilinear map

$$
\phi: \mathcal{I} \otimes_{\mathcal{O}_{\mathcal{S}^{\prime}, P}} \mathcal{O}_{\mathcal{S}, P} \longrightarrow M
$$

such that $\phi(u \otimes v) \neq 0$. We take $M=\mathcal{O}_{S_{1}, P} /\left(t_{1}^{q_{1}^{\prime}}\right)$, which is a quotient of $\mathcal{O}_{\mathcal{S}^{\prime}}$. It is easy to verify that

$$
\phi:\left(\left(\lambda_{i}\right)_{1 \leq i \leq n} u,\left(w_{i}\right)_{1 \leq i \leq n}\right) \longmapsto \lambda_{1} w_{1}\left(\bmod t_{1}^{q_{1}^{\prime}}\right)
$$

is well defined, bilinear, and that $\phi(u \otimes v) \neq 0$.
5.4.3. Corollary: Suppose that $f$ is not the identity morphism. Let $Y$ be an algebraic variety and $g: Y \rightarrow S$ a morphism such that $g^{*}: \mathcal{O}_{\mathcal{S}, P} \rightarrow \mathcal{O}_{Y, P}$ is injective. Then $f \circ g: Y \rightarrow S^{\prime}$ is not flat.

Proof. We use the notations of the proof of lemma 5.4.2. We have a commutative diagram

where $\lambda_{S}(\alpha)=u \otimes \alpha, \mu_{S}(u \otimes \alpha)=u \alpha$, and $\lambda_{Y}, \mu_{Y}$ are defined similarly. It follows that $\mu_{Y}\left(u \otimes g^{*} v\right)=0$. We will show that $u \otimes g^{*} v \neq 0$, and this will imply that $f \circ g$ is not flat. Let $w=\left(t_{1}^{q_{1}^{\prime}}, 0, \ldots, 0\right)$. Then we have $\mathcal{I} \simeq \mathcal{O}_{\mathcal{S}^{\prime}, P} /(w)$, and from the exact sequence of $\mathcal{O}_{\mathcal{S}^{\prime}, P^{-m}}$-modules $0 \rightarrow(w) \rightarrow \mathcal{O}_{\mathcal{S}^{\prime}, P} \rightarrow \mathcal{I} \rightarrow 0$ we deduce that $\operatorname{ker}\left(\lambda_{Y}\right)=(w) . \mathcal{O}_{Y, P}$. Suppose that $u \otimes g^{*} v=0$. Then $g^{*} v$ is a multiple of $w: g^{*} v=w . a$, for some $a \in \mathcal{O}_{Y, P}$. But we have $w=g^{*} \pi^{q_{1}^{\prime}-q_{1}} v$. Hence $g^{*} v .\left(1-g^{*} \pi^{q_{1}^{\prime}-q_{1}}\right)=0$. Since $1-g^{*} \pi^{q_{1}^{\prime}-q_{1}}$ is invertible, we have $g^{*} v=0$, which is false since $g^{*}$ is injective. Hence $u \otimes g^{*} v \neq 0$.

### 5.5. Structure of ideals

Let $\mathcal{S}$ be an oblate $n$-star of $S$.

### 5.5.1. Proposition: Let $\mathcal{I} \subset \mathcal{O}_{\mathcal{S}, P}$ be a proper ideal. Then

1 - There exists a positive integer $k$ such that $k \leq n$ and a filtration by ideals

$$
\{0\}=\mathcal{I}_{k+1} \subset \mathcal{I}_{k} \subset \cdots \subset \mathcal{I}_{1}=\mathcal{I}
$$

such that, for $1 \leq i \leq k$ there exists a positive integer $j$ such that $j \leq n$ and an isomorphism $\mathcal{I}_{i} / \mathcal{I}_{i+1} \simeq \mathcal{O}_{S_{j}, P}$ of $\mathcal{O}_{\mathcal{S}, P}$-modules.
2- If $\mathcal{I}_{i} / \mathcal{I}_{i+1} \simeq \mathcal{O}_{S_{j}, P}$, then $\mathcal{I}_{i+1} \subset \mathcal{I}_{S_{j}}$ and $\mathcal{I}_{i} \not \subset \mathcal{I}_{S_{j}}$.
Proof. We prove 1- by induction on $n$. The case $n=1$ is trivial. Suppose that $n>1$ and that the result is true for $n-1$. Let $\mathcal{J}_{1}$ be the ideal sheaf of $S_{1} \subset \mathcal{S}$, and $\mathcal{S}^{\prime}=S_{2} \cup \cdots \cup S_{n-1} \subset \mathcal{S}$. We can view $\mathcal{J}_{1}$ as an ideal of $\mathcal{O}_{\mathcal{S}^{\prime}, P}$. We can suppose that $\mathcal{I} \not \subset \mathcal{O}_{\mathcal{S}^{\prime}, P}$, i.e that some element of $\mathcal{I}$ has a nonzero first coordinate. Let $m$ be the smallest positive integer such that $\mathcal{I}$ contains an element $u$ of the form

$$
u=\left(t^{m}, \alpha_{2}, \ldots, \alpha_{n}\right)
$$

Then every element $v$ of $\mathcal{I}$ can be written as

$$
v=\lambda u+v^{\prime}
$$

with $\lambda \in \mathcal{O}_{\mathcal{S}, P}$ and $v^{\prime} \in \mathcal{J}_{1} \cap \mathcal{I}$, and the first coordinate of $\lambda$ is uniquely determined. It follows that $\mathcal{I} /\left(\mathcal{J}_{1} \cap \mathcal{I}\right) \simeq \mathcal{O}_{S_{1}, P}$. We can apply the recurrence hypothesis to the ideal $\mathcal{J}_{1} \cap \mathcal{I}$ of $\mathcal{O}_{\mathcal{S}^{\prime}, P}$ and get a filtration of it, from which we deduce the filtration of $\mathcal{I}$. This proves 1 - for $n$.

Now we prove 2-. Let $\alpha \in \mathcal{O}_{\mathcal{S}, P} \backslash \mathcal{I}_{S_{j}}$. Let $u \in \mathcal{I}_{i}$ be over a generator of $\mathcal{I}_{i} / \mathcal{I}_{i+1}$. Then the image of $\alpha u$ in $\mathcal{I}_{i} / \mathcal{I}_{i+1}$ is not zero, i.e. $\alpha u \notin \mathcal{I}_{i+1}$. Hence $\alpha \notin \mathcal{I}_{i+1}$, and $\mathcal{I}_{i+1} \subset \mathcal{I}_{S_{j}}$. Let
$v_{i}=\left(0, \ldots, 0, t_{i}^{q_{i}}, 0, \ldots, 0\right) \in \mathcal{O}_{\mathcal{S}, P}$. Then the image of $v_{i} u$ in $\mathcal{I}_{i} / \mathcal{I}_{i+1}$ is not zero, hence $u \notin \mathcal{I}_{S_{j}}$ and $\mathcal{I}_{i} \not \subset \mathcal{I}_{S_{j}}$.

### 5.6. Star associated to a fragmented deformation

We keep the notations of chapter 4. Let $n \geq 2$ be an integer, $\pi: \mathcal{C} \rightarrow S$ a fragmented deformation of $C_{n}$, and $\mathcal{C}_{1}, \ldots, \mathcal{C}_{n}$ the irreducible components of $\mathcal{C}$.
Recall that $S(n)$ is the underlying (Zariski) topological space of any $n$-star of $S$. Let $\mathcal{C}^{\text {top }}$ be the underlying topological space of $\mathcal{C}$. We have an obvious continuous map $\boldsymbol{\pi}: \mathcal{C}^{\text {top }} \rightarrow S(n)$. Let $\mathcal{A}_{n}$ be the sheaf of algebras on $S(n)$ defined by: for every open subset $U$ of $S(n), \mathcal{A}_{n}(U)$ is the algebra of $\left(\alpha_{1}, \ldots, \alpha_{n}\right) \in \mathcal{O}_{\mathcal{C}}\left(\boldsymbol{\pi}^{-1}(U)\right)$ such that $\alpha_{i} \in \mathcal{O}_{S_{i}}\left(U \cap S_{i}\right)$ for $1 \leq i \leq n$.
According to corollary 4.4.8, for every $x \in C, \mathcal{A}_{n, P}$ is the algebra of $\left(\alpha_{1}, \ldots, \alpha_{n}\right) \in \mathcal{O}_{\mathcal{C}, x}$ such that $\alpha_{i} \in \mathcal{O}_{S, P}$ for $1 \leq i \leq n$.

### 5.6.1. Proposition: The sheaf $\mathcal{A}_{n}$ is the structural sheaf of an oblate $n$-star of $S$.

Proof. By induction on $n$. The case $n=1$ is obvious. Suppose that $n>1$ and that the result is true for $n-1$. Let $\mathcal{C}^{\prime}=\mathcal{C}_{1} \cup \cdots \mathcal{C}_{n-1} \subset \mathcal{C}$, and $\mathcal{A}_{n-1}$ the corresponding oblate $(n-1)$-star of $S$. Let

$$
\Phi_{n}: \mathcal{B}_{n} \longrightarrow \mathcal{O}_{\mathcal{C}_{n}} /\left(\pi_{n}^{q_{n}}\right)
$$

be the morphism of proposition 4.4.1. According to proposition 4.6.4, $\Phi_{n}$ induces a morphism

$$
\Psi_{n}: \mathcal{K}_{n} \longrightarrow \mathcal{O}_{S_{n}, P} /\left(t_{n}^{q_{n}}\right)
$$

By the definitions of $\mathcal{A}_{n}$ and $\Phi_{n}$, if $u=\left(\alpha_{1}, \ldots, \alpha_{n}\right) \in \mathcal{O}_{S_{1}, P} \times \cdots \times \mathcal{O}_{S_{1}, P}$, then $u \in \mathcal{A}_{n, P}$ if and only if $\Psi_{n}\left(u^{\prime}\right)=v$, where $u^{\prime}\left(\right.$ resp. $v$ ) is the image of $u$ in $\mathcal{K}_{n}$ (resp. $\left.\mathcal{O}_{S_{n}, P} /\left(t_{n}^{q_{n}}\right)\right)$. The result follows then from 5.2.5.

We denote by $\mathcal{S}(\mathcal{C})$ (or more simply $\mathcal{S}$ ) the oblate $n$-star corresponding to $\mathcal{A}_{n}$, so $\mathcal{O}_{\mathcal{S}(\mathcal{C})}=\mathcal{A}_{n}$. From the definition of $\mathcal{A}_{n}$ we get a canonical morphism

$$
\Pi: \mathcal{C} \longrightarrow \mathcal{S}
$$

such that $\Pi_{\mid \mathcal{C}_{i}}=\pi_{i}: \mathcal{C}_{i} \rightarrow S_{i}$ for $1 \leq i \leq n$.
5.6.2. Theorem: The morphism $\boldsymbol{\Pi}$ is flat.

Proof. We need only to prove that $\Pi$ is flat at any point $x$ of $C$. Let $\mathcal{I} \subset \mathcal{O}_{\mathcal{S}, P}$ be a proper ideal. We have to show that the canonical morphism of $\mathcal{O}_{\mathcal{S}, P}$-modules

$$
\tau=\tau_{\mathcal{I}}: \mathcal{O}_{\mathcal{C}, x} \otimes_{\mathcal{O}_{\mathcal{S}, P}} \mathcal{I} \longrightarrow \mathcal{O}_{\mathcal{C}, x}
$$

is injective. According to proposition 5.5.1 there is a filtration by ideals

$$
\{0\}=\mathcal{I}_{k+1} \subset \mathcal{I}_{k} \subset \cdots \subset \mathcal{I}_{1}=\mathcal{I}
$$

such that, for $1 \leq i \leq k$ there exists a positive integer $j$ such that $j \leq n$ and an isomorphism $\mathcal{I}_{i} / \mathcal{I}_{i+1} \simeq \mathcal{O}_{S_{j}, P}$ of $\mathcal{O}_{\mathcal{S}, P}$-modules. We will prove the injectivity of $\tau$ by induction on $k$.

Recall that for $1 \leq j \leq n, \mathcal{I}_{S_{j}, P}=\mathcal{I}_{S_{j}, \mathcal{S}, P}$ is a principal ideal, generated by an element $u_{j}$ which is also a generator of $\mathcal{I}_{\mathcal{C}_{j}, x}=\mathcal{I}_{\mathcal{C}_{j}, \mathcal{C}, x}$ (cf. corollary 4.3 .8 and proposition 5.2.3), and that the only zero coordinate of $u_{j}$ is the $j$-th.
Suppose that $k=1$, so $\mathcal{I}$ is isomorphic to $\mathcal{O}_{S_{j}, P}$ for some $j$. Let $u$ be a generator of $\mathcal{I}$ and $w \in \mathcal{O}_{\mathcal{C}, x} \otimes_{\mathcal{O}_{\mathcal{S}, P}} \mathcal{I}$, that can be written as $w=v \otimes u, v \in \mathcal{O}_{\mathcal{C}, x}$. Suppose that $\tau(v \otimes u)=v u=0$. Since $\mathcal{I}$ is annihilated by $\mathcal{I}_{S_{j}, P}$, we have $\mathcal{I} \subset\left(\left(0, \ldots, 0, t_{j}^{q_{j}}, 0, \ldots, 0\right)\right)$. Since $v u=0$, the $j$-th component of $v$ is zero, i.e. $v \in \mathcal{I}_{\mathcal{C}_{j}, x}$. Hence $v$ is a multiple of $u_{j}: v=\alpha u_{j}$. We have then

$$
\begin{aligned}
w & =\alpha u_{j} \otimes u \\
& \left.=\alpha \otimes u_{j} u \quad \text { (because } u_{j} \in \mathcal{O}_{\mathcal{S}, P}\right) \\
& \left.=0 \quad \text { (because } u_{j} u=0\right)
\end{aligned}
$$

Hence $\tau$ is injective.
Suppose that the result is true for $k-1 \geq 1$ and that the filtration of $\mathcal{I}$ is of length $k$. According to proposition 5.5.1, 1-, we have $\mathcal{I} / \mathcal{I}_{2} \simeq \mathcal{O}_{S_{j}, P}$ for some $j$. Let $u \in \mathcal{I}$ be such that its image in $\mathcal{I} / \mathcal{I}_{2}$ is a generator, and $w \in \mathcal{O}_{\mathcal{C}, x} \otimes_{\mathcal{O}_{\mathcal{S}, P}} \mathcal{I}$ such that $\tau(w)=0$. We can write $w$ as $w=\alpha \otimes v+\beta \otimes u$, with $\alpha, \beta \in \mathcal{O}_{\mathcal{C}, x}$ and $v \in \mathcal{I}_{2}$. Since $\alpha v+\beta u=0$, we have $\beta u \in \mathcal{O}_{\mathcal{C}, x} \mathcal{I}_{2}$, and $\mathcal{O}_{\mathcal{C}, x} \mathcal{I}_{2} \subset \mathcal{I}_{\mathcal{C}_{j}}$ by proposition 5.5.1, 2-, i.e. the $j$-th coordinate of $\beta u$ is zero. By proposition 5.5.1, 2-, the $j$-th coordinate of $u$ does not vanish, hence the $j$-th coordinate of $\beta$ is zero, i.e. $\beta \in \mathcal{I}_{\mathcal{C}_{j}}$. Hence $\beta$ is a multiple of $u_{j}: \beta=\gamma u_{j}$. We have then

$$
\beta \otimes u=\gamma u_{j} \otimes u=\gamma \otimes u_{j} u
$$

and $u_{j} u \in \mathcal{I}_{2}$ (because its image in $\mathcal{I} / \mathcal{I}_{2}$ vanishes). It follows that $w$ is the image of an element $w^{\prime}$ of $\mathcal{O}_{\mathcal{C}, x} \otimes_{\mathcal{O}_{\mathcal{S}, P}} \mathcal{I}_{2}$. We have $\tau_{\mathcal{I}_{2}}\left(w^{\prime}\right)=0$, hence by the induction hypothesis $w^{\prime}=0$. It follows that we have also $w=0$.
5.6.3. Remark: If $\mathcal{S}^{\prime}$ is an oblate $n$-star of $S$, and if $\Pi^{\prime}: \mathcal{C} \rightarrow \mathcal{S}^{\prime}$ is a flat morphism compatible with the projections to $S$, then we have $\mathcal{S}^{\prime}=\mathcal{S}(\mathcal{C})$ and $\Pi^{\prime}=\Pi$. This is an easy consequence of corollary 5.4.3.
5.6.4. Converse - Let $\pi: \mathcal{S} \rightarrow S$ be an oblate $n$-star of $S$. Let $\Pi: \mathcal{C} \rightarrow \mathcal{S}$ be a flat morphism such that for every closed point $s \in \mathcal{S}, \boldsymbol{\Pi}^{-1}(s)$ is a smooth irreducible projective curve. Let $C=\Pi^{-1}(P)$ and $\tau=\pi \circ \Pi: \mathcal{C} \rightarrow S$. Then $C_{n}=\tau^{-1}(P)$ is a primitive multiple curve of multiplicity $n$ and associated smooth curve $C$, and $\mathcal{C}$ is a fragmented deformation of $C_{n}$. This is an easy consequence of proposition 4.1.6.

## 6. Classification of fragmented deformations of length 2

Let $\pi: \mathcal{C} \rightarrow \mathbb{C}$ be a fragmented deformation of length 2 . The corresponding double curve $C_{2}$ is $\pi^{-1}(0)$. Suppose that the spectrum of $\mathcal{C}$ is $\left(\begin{array}{ll}0 & p \\ p & 0\end{array}\right)$. This means that the infinitesimal neighborhoods of order $p$ of $C$ in $\mathcal{C}_{1}$ and $\mathcal{C}_{2}$ are isomorphic, i.e. we have an isomorphism of sheaves of algebras on $C$

$$
\Phi: \mathcal{O}_{\mathcal{C}_{1}} /\left(\pi_{1}^{p}\right) \longrightarrow \mathcal{O}_{\mathcal{C}_{2}} /\left(\pi_{2}^{p}\right),
$$

and for every point $x$ of $C$, we have

$$
\mathcal{O}_{\mathcal{C}, x}=\left\{\left(\alpha_{1}, \alpha_{2}\right) \in \mathcal{O}_{\mathcal{C}_{1}, x} \times \mathcal{O}_{\mathcal{C}_{2}, x} ; \alpha_{2}\left(\bmod \pi_{2}^{p}\right)=\Phi\left(\alpha_{1}\left(\bmod \pi_{1}^{p}\right)\right)\right\}
$$

Let $C_{i}^{k}$ denote the infinitesimal neighborhood of order $k$ of $C$ in $\mathcal{C}_{i}, i=1,2, k>0$. It is a primitive multiple curve of multiplicity $k$ and associated smooth curve $C$, and we have $C_{1}^{p}=C_{2}^{p}$. Hence $C_{1}^{p+1}$ and $C_{2}^{p+1}$ appear as extensions of $C_{1}^{p}$ in primitive multiple curves of multiplicity $p+1$. According to [4] and [8] these extensions are classified by $H^{1}\left(C, T_{C}\right)\left(T_{C}\right.$ being the tangent sheaf on $C$ ). More precisely, we say that two such extensions $D, D^{\prime}$ are isomorphic if there exists an isomorphism $D \simeq D^{\prime}$ leaving $C_{1}^{p}$ invariant. Then if $\mathcal{H}$ is the set of isomorphism classes of such extensions, a bijection $\lambda: H^{1}\left(C, T_{C}\right) \rightarrow \mathcal{H}$ is defined in [4], such that $\lambda(0)=C_{1}^{p+1}$.
On the other hand, it follows from [2], 4] that the primitive double curves with associated smooth curve $C$ and associated line bundle $\mathcal{O}_{C}$ are classified by $\mathbb{P}\left(H^{1}\left(C, T_{C}\right)\right) \cup\{0\}$.
6.0.5. Theorem: The point of $\mathbb{P}\left(H^{1}\left(C, T_{C}\right)\right) \cup\{0\}$ corresponding to $C_{2}$ is $\mathbb{C} . \lambda^{-1}\left(C_{2}^{p+1}\right)$.

Proof. According to [4, there exists an open covering $\left(U_{i}\right)_{i \in I}$ of $C$ such that for $k=1,2$, the open subset of $C_{k}^{p+1}$ corresponding to $U_{i}$ is isomorphic to $U_{i} \times \operatorname{spec}\left(C[t] /\left(t^{p+1}\right)\right)$. Here $t$ is $\pi_{1}$ on $\mathcal{C}_{1}$ and $\pi_{2}$ on $\mathcal{C}_{2}$. We obtain then cocycles $\left(\theta_{i j}^{(k)}\right)_{i, j \in I}$, where $\theta_{i j}^{(k)}$ is an automorphism of $U_{i j} \times \operatorname{spec}\left(C[t] /\left(t^{p+1}\right)\right)$. We can also suppose that $\omega_{C \mid U_{i}}$ is trivial, for every $i \in I$. Let $d x_{i j}=d x$ be a generator of $\omega_{C}\left(U_{i j}\right)$. Since the ideal sheaf of $C$ in $C_{k}^{p+1}$ is the trivial sheaf on $C_{k}^{p}$, we can write, using the notations of [4], $\theta_{i j}^{(k)}=\phi_{\mu_{i j}^{(k)}, 1}$, with $\mu_{i j}^{(k)} \in \mathcal{O}_{C}\left(U_{i j}\right)[t] /\left(t^{p}\right)$, i.e. for every $\alpha \in \mathcal{O}_{C}\left(U_{i}\right)$, we have, at the level of regular functions

$$
\theta_{i j}^{(k)}(\alpha)=\sum_{m=0}^{p} \frac{1}{m!}\left(\mu_{i j}^{(k)} t\right)^{m} \frac{d^{m} \alpha}{d x^{m}},
$$

and $\quad \theta_{i j}^{(k)}(t)=t$. Since $C_{1}^{p}=C_{2}^{p}$ we can suppose that $\mu_{i j}^{(1)} \equiv \mu_{i j}^{(2)}\left(\bmod t^{p-1}\right)$. Hence $\tau_{i j}=\mu_{i j}^{(2)}-\mu_{i j}^{(1)} \in\left(t^{p-1}\right) /\left(t^{p}\right) \simeq \mathcal{O}_{C}\left(U_{i}\right)$. The family $\left(\tau_{i j}\right)$ is (in some sense) a cocycle representing $\lambda^{-1}\left(C_{2}^{p+1}\right)($ cf. [4], [8]).
We have $\left(\pi_{1}^{p+1}\right)+\left(\pi_{2}^{p+1}\right) \subset(\pi)$ in $\mathcal{O}_{\mathcal{C}}$. Hence $C_{2}=\pi^{-1}(0)$ is contained in the subscheme $Z$ of $\mathcal{C}$ corresponding to the ideal sheaf $\left(\pi_{1}^{p+1}\right)+\left(\pi_{2}^{p+1}\right)$. We have

$$
\begin{aligned}
\mathcal{O}_{Z}\left(U_{i j}\right) & =\left\{\left(\alpha_{1}, \alpha_{2}\right) \in \mathcal{O}_{\mathcal{C}_{1}}\left(U_{i j}\right) /\left(t^{p+1}\right) \times \mathcal{O}_{\mathcal{C}_{2}}\left(U_{i j}\right) /\left(t^{p+1}\right) ; \Phi\left(\alpha_{1} \bmod t^{p}\right)=\alpha_{2} \bmod t^{p}\right\} \\
& =\left\{\left(\alpha_{1}, \alpha_{2}\right) \in \mathcal{O}_{C}\left(U_{i j}\right)[t] /\left(t^{p+1}\right) \times \mathcal{O}_{C}\left(U_{i j}\right)[t] /\left(t^{p+1}\right) ; \alpha_{1} \equiv \alpha_{2} \bmod t^{p}\right\}
\end{aligned}
$$

To obtain $\mathcal{O}_{C_{2}}\left(U_{i j}\right)$, we have just to quotient by $\pi=(t, t)$, and we obtain

$$
\mathcal{O}_{C_{2}}\left(U_{i j}\right)=\mathcal{O}_{Z}\left(U_{i j}\right) /(t, t) \simeq \mathcal{O}_{C}\left(U_{i j}\right)[z] /\left(z^{2}\right)
$$

the last isomorphism being

$$
\left(a_{0}+a_{1} t+\cdots+a_{p-1} t^{p-1}+\alpha t^{p}, a_{0}+a_{1} t+\cdots+a_{p-1} t^{p-1}+\beta t^{p}\right) \mapsto \alpha_{0}+(\beta-\alpha) z .
$$

Now we can make explicit the automorphism of $\mathcal{O}_{C}\left(U_{i j}\right)[z] /\left(z^{2}\right)$ induced by $\theta_{i j}$ (these isomorphisms will define the cocycle corresponding to $C_{2}$ ). It is easy to see that this isomorphism is $\phi_{\tau_{i j}, 1}$, which proves theorem 6.0.5.
