# The Fourier transform of semi-simple coadjoint orbits

#### Abstract

Let $M$ be a closed coadjoint orbit of a real connected semi-simple Lie group $G$, and let $F_{M} \in \mathcal{C}^{-\infty}(\mathfrak{g})^{G}$ be it's Fourier transform. In this paper we compute the restriction of $F_{M}$ to the Lie algebra $\mathfrak{k}$ of a maximal compact subgroup $K$ of $G$. Using a technique of localization in equivariant cohomology developed in [16, 17], we extend previous results by M. Duflo, G. Heckman, M. Vergne and I. Sengupta.

## 1 Coadjoint orbits of semi-simple Lie groups

Let $G$ be a connected, real, semi-simple Lie group with finite center. Let $\mathfrak{g}$ be its Lie algebra, and let $\mathfrak{g}=\mathfrak{k} \oplus \mathfrak{p}$ be a Cartan decomposition of $\mathfrak{g}$. We denote by $K$ (resp. $\theta$ ) the compact connected subgroup of $G$ with Lie algebra $\mathfrak{k}$ (resp. Cartan involution).

Let $M$ be an orbit of the coadjoint representation. It is a regularly embedded submanifold of $\mathfrak{g}^{*}$ which carries a canonical symplectic 2 -form $\Omega$; in particular the manifold $M$ is of even dimension $2 d$. We denote by $d \mathcal{L}:=\frac{\Omega^{d}}{(2 \pi)^{d} d!}$

[^0]the corresponding Liouville volume form on $M$. The action of $G$ on $M$ is Hamiltonian and the corresponding moment $\operatorname{map} \mu_{G}: M \hookrightarrow \mathfrak{g}^{*}$ is the inclusion. Note that

\mu_{G} \text { is proper } \Longleftrightarrow M \text { is closed in } \mathfrak{g}^{*} \tag{1.1}
\end{equation*}

The induced action of $K$ on $M$ is Hamiltonian, and the moment map $\mu_{K}$ : $M \rightarrow \mathfrak{k}^{*}$ is by definition the composition of $\mu_{G}$ with the projection $\mathfrak{g}^{*} \rightarrow \mathfrak{k}^{*}$. For $X \in \mathfrak{g}$, we write $X=X_{1}+X_{2}$ with $X_{1} \in \mathfrak{k}$ and $X_{2} \in \mathfrak{p}$. The Killing form $B$ defines $K$-invariant Euclidean structures on $\mathfrak{k}$ and $\mathfrak{p}$ such that

$$
\begin{equation*}
B(X, X)=-\left\|X_{1}\right\|^{2}+\left\|X_{2}\right\|^{2}, \quad X \in \mathfrak{g} \tag{1.2}
\end{equation*}
$$

is a $G$-invariant quadratic form on $\mathfrak{g}$. Let $\|\cdot\|$ be the $K$-invariant Euclidean norm on $\mathfrak{g}$ defined by the equation $\|X\|^{2}:=-B(X, \theta X)=\left\|X_{1}\right\|^{2}+\left\|X_{2}\right\|^{2}$.

Remark 1.1 The Killing form $B$ provides a $G$-equivariant identification $\mathfrak{g} \cong$ $\mathfrak{g}^{*}$, and also the following $K$-invariant identification $\mathfrak{k} \cong \mathfrak{k}^{*}, \mathfrak{p} \cong \mathfrak{p}^{*}$. Then we will only deal with adjoint orbits $M$ of $G$. In this case the symplectic structure on $M$ is defined by the equation $\Omega_{m}\left(X_{M}, Y_{M}\right)=-B(m,[X, Y])$ for $m \in M$ and $X, Y \in \mathfrak{g}$, and the moment map $\mu_{K}: M \rightarrow \mathfrak{k}$ is the restriction to $M$ of the orthogonal projection $\mathfrak{g} \rightarrow \mathfrak{k}, X \mapsto X_{1}$.

Let $a \in \mathbb{R}$ be the value of $X \mapsto B(X, X)$ on $M$. From the decomposition $\left\|X_{1}\right\|^{2}=\frac{1}{2}\left(\left\|X_{1}\right\|^{2}+\left\|X_{2}\right\|^{2}\right)+\frac{1}{2}\left(\left\|X_{1}\right\|^{2}-\left\|X_{2}\right\|^{2}\right)$ and using (1.2) we see that $\left\|\mu_{K}\right\|^{2}=\frac{1}{2}\left\|\mu_{G}\right\|^{2}-\frac{1}{2} a$ holds on $M$. Hence the relation (1.1) becomes

$$
\begin{equation*}
\mu_{K} \text { is proper } \Longleftrightarrow M \text { is closed in } \mathfrak{g} \tag{1.3}
\end{equation*}
$$

(We just use the fact that: $\mu_{K}$ is proper $\Longleftrightarrow\left\|\mu_{K}\right\|^{2}$ is proper, and the same is true for $\mu_{G}$.)

We denote respectively by $\mathcal{C}_{r d}^{\infty}(\mathfrak{g})$ and $\mathcal{C}_{c p t}^{\infty}(\mathfrak{g})$, the Schwartz space of smooth rapidly decreasing functions on $\mathfrak{g}$, and the space of smooth functions with compact support in $\mathfrak{g}$.

Assumption 1.2 We suppose for the rest of this paper that $M$ is a closed adjoint orbit in $\mathfrak{g}$.

In this case the Liouville volume form $d \mathcal{L}$ defines a tempered positive measure on $\mathfrak{g}$ : for every function $f \in \mathcal{C}_{r d}^{\infty}(\mathfrak{g})$, the integral $\int_{M} f(m) d \mathcal{L}(m)$ converges. Then we can define the Fourier transform of this measure

$$
F_{M}(X)=(\imath)^{d} \int_{M} e^{-\imath B(m, X)} d \mathcal{L}(m), \quad X \in \mathfrak{g}
$$

which is the generalized, tempered, and $G$-invariant function $F_{M} \in \mathcal{C}_{\text {temp }}^{-\infty}(\mathfrak{g})^{G}$ defined by the equation $<F_{M}(X), f(X) d X>_{\mathfrak{g}}:=(\imath)^{d} \int_{M}\left(\int_{\mathfrak{g}} e^{-\imath B(m, X)} f(X) d X\right) d \mathcal{L}(m)$, for every $f \in \mathcal{C}_{r d}^{\infty}(\mathfrak{g})$ (where $d X$ is a Lebesgue measure on $\mathfrak{g}$ ).

The generalized function $F_{M} \in \mathcal{C}_{\text {temp }}^{-\infty}(\mathfrak{g})^{G}$ admits a restriction $\left.F_{M}\right|_{\mathfrak{k}}$ to $\mathfrak{k}$ (see section 1 of [8] for the notion of restriction). Moreover the generalized function $\left.F_{M}\right|_{\mathfrak{k}} \in \mathcal{C}_{\text {temp }}^{-\infty}(\mathfrak{k})^{K}$ is determined by the equation $X \in \mathfrak{k}, F_{M} \mid \mathfrak{k}(X)=$
$(\imath)^{d} \int_{M} e^{\imath\left(\mu_{K}(m), X\right)} d \mathcal{L}(m)$, where $(\cdot, \cdot)$ is the $K$-invariant scalar product on $\mathfrak{k}$ coming from the Killing form (see Proposition 5 of [8]). Using the $K$-equivariant symplectic 2-form $\Omega_{\mathfrak{k}}(X):=\Omega+\left(\mu_{K}, X\right), X \in \mathfrak{k}$, the function $\left.F_{M}\right|_{\mathfrak{k}} \in \mathcal{C}_{\text {temp }}^{-\infty}(\mathfrak{k})^{K}$ can be rewritten in the following way

$$
\left.F_{M}\right|_{\mathfrak{k}}(X)=\int_{M} e^{\imath \Omega_{\mathfrak{k}}(X)}, \quad X \in \mathfrak{k}
$$

In this paper we shall compute the generalized functions $\left.F_{M}\right|_{\mathfrak{k}} \in \mathcal{C}_{\text {temp }}^{-\infty}(\mathfrak{k})^{K}$ for every closed orbits $M \subset \mathfrak{g}$.

This computation has been already carried out in the regular case by J. Sengupta [20] (modulo a constant) and in the elliptic case by Duflo-HeckmanVergne $[7,8]$. Our method, which is closed to those of M. Duflo and M. Vergne in [8], uses the techniques of localization in equivariant cohomology developed in $[16,17]$.

Recall now the Rossmann formula. Suppose that $G$ and $K$ have the same rank, and let $T \subset K$ be a Cartan subgroup of $K$. We denote by $W$ the associated Weyl group. Let $\mathfrak{t}$ be the Lie algebra of $T$ and $\mathfrak{t}_{r}$ be the open subset of regular point: $X \in \mathfrak{t}_{r}$ iff the stabilizer of $X$ in $K$ is equal to the torus $T$.

Definition 1.3 Let $V$ be an oriented Euclidean space provided with an action $\rho: H \rightarrow S O(V)$ of a compact Lie group $H$ that preserves the orientation of $V$. Let $\mathfrak{h}$ be the Lie algebra of $H$ and we still denote by $\rho: \mathfrak{h} \rightarrow \operatorname{so}(V)$ the morphism of Lie algebras. We denote by $\Pi_{V}(X)=\operatorname{det}_{V, o}^{1 / 2}(X), X \in \mathfrak{h}$ the $K$ invariant polynomial square root of the polynomial function $X \mapsto \operatorname{det}_{V}(\rho(X))$ on $\mathfrak{h}$.

Let $H$ be a compact Lie group with Lie algebra $\mathfrak{h}$. For any Lebesgue measure $d X$ on $\mathfrak{h}$, we denote by $\operatorname{vol}(H, d X)$ the volume of $H$ computed with the Haar measure compatible with $d X$.

For $\beta \in \mathfrak{k}$ we denote by $\mathfrak{g}_{\beta}$ (resp. $\mathfrak{k}_{\beta}$ and $\mathfrak{p}_{\beta}$ ) the subspace of $\mathfrak{g}$ (resp. $\mathfrak{k}$ and $\mathfrak{p}$ ) fixed by the adjoint action of $\beta$. Let $K_{\beta}$ be the stabilizer of $\beta$ in $K$ : it is a connected subgroup with Lie algebra $\mathfrak{k}_{\beta}$. The vector spaces $\mathfrak{g} / \mathfrak{g}_{\beta}$ and $\mathfrak{k} / \mathfrak{k}_{\beta}$, considered as the tangent space at $\beta$ of the orbits $G . \beta$ and $K . \beta$, are oriented by the respective symplectic structures. Using the decomposition $\mathfrak{g} / \mathfrak{g}_{\beta}=\mathfrak{k} / \mathfrak{k}_{\beta} \oplus \mathfrak{p} / \mathfrak{p}_{\beta}$, the space $\mathfrak{p} / \mathfrak{p}_{\beta}$ has an induced orientation. The space $\mathfrak{g} / \mathfrak{g}_{\beta}$ (resp. $\mathfrak{k} / \mathfrak{k}_{\beta}$ and $\mathfrak{p} / \mathfrak{p}_{\beta}$ ) carries a natural Euclidean structure and a $K_{\beta}$-action, coming from its identification with the orthogonal complement of $\mathfrak{g}_{\beta}$ (resp. $\mathfrak{k}_{\beta}$ and $\mathfrak{p}_{\beta}$ ) in $\mathfrak{g}$ (resp. $\mathfrak{k}$ and $\mathfrak{p}$ ). Following the Definition 1.3, this data define the $K_{\beta}$-invariant polynomial functions $\Pi_{\mathfrak{g} / \mathfrak{g}_{\beta}} \Pi_{\mathfrak{k} / \mathfrak{k}_{\beta}}$, and $\Pi_{\mathfrak{p} / \mathfrak{p}_{\beta}}$ on $\mathfrak{k}_{\beta}$.

When $\beta$ belongs to $\mathfrak{t}_{r}$ the following proposition is due to Rossmann [18].
Proposition 1.4 Let $\beta \in \mathfrak{t}$ and let $M=G . \beta$ be the associated (closed) adjoint orbit. The function $F_{M}$ is analytic on $G \cdot \mathfrak{t}_{r}$ (hence $F_{M} \mid \mathfrak{k}$ is analytic on K.t.t. ), and for every $X \in \mathfrak{t}_{r}$ we have

$$
F_{M}(X)=(-2 \pi)^{d_{\beta}} \sum_{W / W_{\beta}} \frac{e^{\imath(\beta, w \cdot X)}}{\Pi_{\mathfrak{g} / \mathfrak{g}_{\beta}}(w \cdot X)}
$$

where $\Pi_{\mathfrak{g} / \mathfrak{g}_{\beta}}$ is the $K_{\beta \text {-invariant polynomial defined at the Definition } 1.3 \text {, } d_{\beta}=}^{\text {- }}$ $\frac{1}{2} \operatorname{dim}(M)$, and $W_{\beta}$ is the subgroup of $W$ that stabilizes $\beta$.

Apart from the proof of Rossmann [18], we can find another proofs of this Proposition in [4, 7, 22].

Notations : Let $F \in \mathcal{C}^{-\infty}(V)$ be a generalized function on a vector space $V$. For every test density $f(v) d v$ over $V$, we denote by $<F(v), f(v) d v>_{V} \in \mathbb{C}$ the image (or the integral) of $f(v) d v$ by $F$.

Let's now give a global expression of $\left.F_{M}\right|_{\mathfrak{k}}$. For a function $f \in \mathcal{C}_{r d}^{\infty}(\mathfrak{k})^{K}$ supported in $K . \mathfrak{t}_{r}$ we get from Proposition 1.4

$$
\begin{align*}
<F_{M} \mid \mathfrak{k}(X), f(X) d X>_{\mathfrak{k}} & =\operatorname{cte}<\frac{1}{\Pi_{\mathfrak{g} / \mathfrak{g}_{\beta}}(Y)},\left.e^{\imath(\beta, Y)} f\right|_{\mathfrak{t}}(Y) \Pi_{\mathfrak{k} / \mathfrak{t}}^{2}(Y) d Y>_{\mathfrak{t}} \quad[1] \\
& =\operatorname{cte}<\frac{1}{\Pi_{\mathfrak{p} / \mathfrak{p}_{\beta}}(Y)},\left.e^{\imath(\beta, Y)} f\right|_{\mathfrak{t}}(Y) \Pi_{\mathfrak{k} / \mathfrak{k}_{\beta}}(Y) \Pi_{\mathfrak{k}_{\beta} / \mathfrak{t}}^{2}(Y) d Y>_{\mathfrak{t}}  \tag{2}\\
& =\operatorname{cte}^{\prime}<\frac{1}{\Pi_{\mathfrak{p} / \mathfrak{p}_{\beta}}(Z)},\left.e^{\imath(\beta, Z)} f\right|_{\mathfrak{k}_{\beta}}(Z) \Pi_{\mathfrak{k} / \mathfrak{k}_{\beta}}(Z) d Z>_{\mathfrak{k}_{\beta}}, \quad[3]
\end{align*}
$$

where cte $=\frac{\operatorname{vol}(K, d X)}{\operatorname{vol}(T, d Y)} \frac{(-2 \pi)^{d_{\beta}}}{\left|W_{\beta}\right|}$, and cte' $=(-2 \pi)^{d_{\beta}} \frac{\operatorname{vol}(K, d X)}{\operatorname{vol}\left(K_{\beta}, d Z\right)}$. In the equality [1] we use the Weyl integration formula for $(\mathfrak{k}, \mathfrak{t})$ and the fact that $\left.f\right|_{\mathfrak{t}}$ is $W$ invariant. The equality [2] comes from the equalities $\Pi_{\mathfrak{g} / \mathfrak{g}_{\beta}}=\Pi_{\mathfrak{k} / \mathfrak{k}_{\beta}} \Pi_{\mathfrak{p} / \mathfrak{p}_{\beta}}$ and $\Pi_{\mathfrak{k} / \mathfrak{t}}=\Pi_{\mathfrak{k} / \mathfrak{k}_{\beta}} \Pi_{\mathfrak{k}_{\beta} / \mathfrak{t}}$. In the last equality [3] we use the Weyl integration formula for $\left(\mathfrak{k}_{\beta}, \mathfrak{t}\right)$. Note that $\left.Z \rightarrow e^{\imath(\beta, Z)} f\right|_{\mathfrak{k}_{\beta}}(Z) \Pi_{\mathfrak{k} / \mathfrak{k}_{\beta}}(Z)$ and $Z \rightarrow \Pi_{\mathfrak{p} / \mathfrak{p}_{\beta}}(Z)$ are $K_{\beta^{-}}$ invariant functions on $\mathfrak{k}_{\beta}$.

The $K_{\beta}$-equivariant Euler form of the oriented $K_{\beta}$ vector bundle $\mathfrak{p} / \mathfrak{p}_{\beta} \rightarrow\{0\}$ is equal to $Z \rightarrow \Pi_{\mathfrak{p} / \mathfrak{p}_{\beta}}\left(\frac{1}{-2 \pi} Z\right)$. This equivariant polynomial has a tempered generalized inverse $\operatorname{Eul}_{\beta}^{-1}\left(\mathfrak{p} / \mathfrak{p}_{\beta}\right)$ defined by

$$
\operatorname{Eul}_{\beta}^{-1}\left(\mathfrak{p} / \mathfrak{p}_{\beta}\right)(Z)=\lim _{s \rightarrow 0^{+}} \frac{1}{\Pi_{\mathfrak{p} / \mathfrak{p}_{\beta}}\left(\frac{1}{-2 \pi}(Z+\imath s \beta)\right)}, \quad Z \in \mathfrak{k}_{\beta}
$$

For these notions see section 4 of [16].
Finally we can state the global version of the 'Rossmann formula' that is obtained by Duflo-Vergne in [8] (with a different expression). For every function $f \in \mathcal{C}_{r d}^{\infty}(\mathfrak{k})^{K}$, we have
$<\left.F_{M}\right|_{\mathfrak{k}}(X), f(X) d X>_{\mathfrak{k}}=\operatorname{cte}<\operatorname{Eul}_{\beta}^{-1}\left(\mathfrak{p} / \mathfrak{p}_{\beta}\right)(Z),\left.e^{\imath(\beta, Z)} f\right|_{\mathfrak{k}_{\beta}}(Z) \Pi_{\mathfrak{k} / \mathfrak{k}_{\beta}}(Z) d Z>_{\mathfrak{k}_{\beta}}$,
with cte $=(-2 \pi)^{\operatorname{dim}\left(K / K_{\beta}\right) / 2} \frac{\operatorname{vol}(K, d X)}{\operatorname{vol}\left(K_{\beta}, d Z\right)}$.
The central result of this paper is the following global expression of $\left.F_{M}\right|_{\mathfrak{k}}$ for the case of general closed orbits. We come back in the general case of a real semisimple connected Lie group $G$ with finite center, and we make no assumption related to the ranks of $G$ and $K$. Let $T$ be a Cartan subgroup of $K$ with Lie algebra $\mathfrak{t}$, and let $\mathfrak{t}_{+}$be a Weyl chamber of $\mathfrak{t}$.

Theorem 5.4 Let $M$ be a closed orbit in $\mathfrak{g}$. There exists a unique $\left(\beta_{0}, \beta_{1}\right) \in$ $\mathfrak{t}_{+} \times \mathfrak{p}$ with $\left[\beta_{0}, \beta_{1}\right]=0$ such that $M=G \cdot\left(\beta_{0}+\beta_{1}\right)$. Let $K_{\beta}$ be the stabilizer of $\beta:=\beta_{0}+\beta_{1}$ in $K$, and let $\mathfrak{k}_{\beta}$ be its Lie algebra. The generalized function $\operatorname{Eul}_{\beta_{0}}^{-1}\left(\mathfrak{p} / \mathfrak{p}_{\beta_{0}}\right) \in \mathcal{C}^{-\infty}\left(\mathfrak{k}_{\beta_{0}}\right)^{K_{\beta_{0}}}$ admits a restriction to $\mathfrak{k}_{\beta}$, and for every function $f \in \mathcal{C}_{r d}^{\infty}(\mathfrak{k})^{K}$ we have
$<F_{M}\left|\mathfrak{k}(X), f(X) d X>_{\mathfrak{k}}=\operatorname{cte}<\operatorname{Eul}_{\beta_{0}}^{-1}\left(\mathfrak{p} / \mathfrak{p}_{\beta_{0}}\right)(Z), e^{\imath\left(\beta_{0}, Z\right)} f\right|_{\mathfrak{k}_{\beta}}(Z) \Pi_{\mathfrak{k} / \mathfrak{k}_{\beta_{0}}}(Z) d Z>_{\mathfrak{k}_{\beta}}$,
with cte $=(-2 \pi)^{\operatorname{dim}\left(K / K_{\beta_{0}}\right) / 2}(2 \pi \imath)^{\operatorname{dim}\left(K_{\beta_{0}} / K_{\beta}\right)} \frac{\operatorname{vol}(K, d X)}{\operatorname{vol}\left(K_{\beta}, d Z\right)}$.
Remark 1.5 The result of Theorem 5.4 can be extended in the following way. Let $\alpha(X)$ be a closed $K$-equivariant form on $M$ depending polynomially of $X \in \mathfrak{g}$ (see sub-section 2.1 for the definitions). If $\alpha(X)$ is régulière on $M$ (for the notion of being régulière see pages 20-21 of [8]), then the integral

$$
\int_{M} \alpha(X) e^{\tau \Omega_{\mathfrak{k}}(X)}, \quad X \in \mathfrak{k}
$$

defines a tempered measure on $\mathfrak{k}$, and we have
$<\left(\int_{M} \alpha e^{\imath \Omega_{\mathfrak{k}}}\right)(X), f(X) d X>_{\mathfrak{k}}=\operatorname{cte}<\operatorname{Eul}_{\beta_{0}}^{-1}\left(\mathfrak{p} / \mathfrak{p}_{\beta_{0}}\right)(Z),\left.e^{\imath\left(\beta_{0}, Z\right)} r_{\beta}(\alpha)(Z) f\right|_{\mathfrak{k}_{\beta}}(Z) \Pi_{\mathfrak{k} / \mathfrak{k}_{\beta_{0}}}(Z) d Z>_{\mathfrak{k}_{\beta}}$
for every $f \in \mathcal{C}_{r d}^{\infty}(\mathfrak{k})^{K}$. In this equality $r_{\beta}: \mathcal{A}_{K}^{\infty}(M) \rightarrow \mathcal{A}_{K_{\beta}}^{\infty}(\{\beta\})=\mathcal{C}^{\infty}\left(\mathfrak{k}_{\beta}\right)^{K_{\beta}}$ is the restriction map to the point $\{\beta\} \subset M$.

## 2 Localization of the Fourier transform

We take the same notations as before. Let $M$ be a closed adjoint orbit of $G$ in $\mathfrak{g}$, and consider the Hamiltonian action of the compact subgroup $K$ on $M$. We know from (1.3) that the associated moment map $\mu_{K}: M \rightarrow \mathfrak{k}$ is proper (we make the identification $\mathfrak{k} \cong \mathfrak{k}^{*}$ via the Killing form, see Remark 1.1).

Consider the equivariant symplectic form $\Omega_{\mathfrak{k}}(X):=\Omega+\left(\mu_{\mathfrak{k}}, X\right), X \in \mathfrak{k}$ defined on $M$. By definition of the moment map, the equivariant form $\Omega_{\mathfrak{k}}$ is closed: $\mathcal{D}\left(\Omega_{\mathfrak{k}}\right)(X)=d\left(\mu_{\mathfrak{k}}, X\right)-c\left(X_{M}\right) \Omega=0, X \in \mathfrak{k}$ (see sub-section 2.1 for the notations). And we know from the introduction that the generalized function $\left.F_{M}\right|_{\mathfrak{k}}$ is given by the integral of the closed equivariant form $e^{\imath \Omega_{\mathfrak{k}}} \in \mathcal{A}_{K}^{\infty}(M)$ on $M$. Consider the function $\left\|\mu_{K}\right\|^{2}: M \rightarrow \mathbb{R}$. In this section we show that the integral of $e^{\imath \Omega_{\mathrm{E}}}$ can be localized on the set $\operatorname{Cr}\left(\left\|\mu_{K}\right\|^{2}\right)$ of critical points of the function $\left\|\mu_{K}\right\|^{2}$.

First, we recall the definition and notations we use in the rest of this paper.

### 2.1 Equivariant cohomology-Definitions

Let $M$ be a manifold provided with an action of a compact connected Lie group $K$ with Lie algebra $\mathfrak{k}$. We denote by $\mathcal{A}^{*}(M)$ the algebra of differential forms on $M$ (over $\mathbb{C}$ ), and by $d$ the exterior differentiation. Let $\mathcal{A}_{c p t}^{*}(M)$ be the subalgebra of compactly supported differential forms. If $\xi$ is a vector field on $M$ we denote by $c(\xi): \mathcal{A}^{*}(M) \rightarrow \mathcal{A}^{*-1}(M)$ the contraction by $\xi$. The action of $K$ on $M$ gives a morphism $X \rightarrow X_{M}$ from $\mathfrak{k}$ to the Lie algebra of vector fields on $M$.

We now recall the different de Rham complexes of $K$-equivariant forms on $M$. For more details see [2, 3, 8, 12].

Let $\mathcal{C}^{\infty}\left(\mathfrak{k}, \mathcal{A}^{*}(M)\right)$ be the algebra of forms $\alpha(X)$ on $M$ depending smoothly of $X \in \mathfrak{k}$. We note $\mathcal{A}_{K}^{\infty}(M)$ the sub-algebra of $\mathcal{C}^{\infty}\left(\mathfrak{k}, \mathcal{A}^{*}(M)\right)$ consisting of the $K$-invariant elements: these elements are called the equivariant forms with $\mathcal{C}^{\infty}$ coefficients. Let $\mathcal{A}_{K}^{*}(M) \subset \mathcal{A}_{K}^{\infty}(M)$ be the sub-algebra of equivariant forms $\alpha(X)$ depending polynomially of $X \in \mathfrak{k}$. The differential $\mathcal{D}$ on $\mathcal{A}_{K}^{\infty}(M)$ is given by the equation

$$
\forall \alpha \in \mathcal{A}_{K}^{\infty}(M), \quad(\mathcal{D} \alpha)(X):=\left(d-c\left(X_{M}\right)\right)(\alpha(X)), \quad X \in \mathfrak{k}
$$

We see that $\mathcal{A}_{K}^{*}(M)$ is stable under $\mathcal{D}$, and that $\mathcal{D}^{2}=0$ on $\mathcal{A}_{K}^{\infty}(M)$. The cohomologies associated to $\left(\mathcal{A}_{K}^{*}(M), \mathcal{D}\right)$ and $\left(\mathcal{A}_{K}^{\infty}(M), \mathcal{D}\right)$ are denoted respectively $\mathcal{H}_{K}^{*}(M)$ and $\mathcal{H}_{K}^{\infty}(M)$.

The algebra $\mathcal{A}_{K}^{\infty}(M)$ has a sub-algebra $\mathcal{A}_{K, c p t}^{\infty}(M):=\mathcal{C}^{\infty}\left(\mathfrak{k}, \mathcal{A}_{c p t}^{*}(M)\right)^{K}$, stable under the differential $\mathcal{D}$. The cohomology associated to $\left(\mathcal{A}_{K, c p t}^{\infty}(M), \mathcal{D}\right)$ is called the $K$-equivariant cohomology with compact support and is denoted by $\mathcal{H}_{K, c p t}^{\infty}(M)$.

For our purpose we need equivariant forms with generalized coefficients. For a more precise description see [12].

The space $\mathcal{C}^{-\infty}\left(\mathfrak{k}, \mathcal{A}^{*}(M)\right)$ of generalized functions on $\mathfrak{k}$ with values in the space $\mathcal{A}^{*}(M)$ is, by definition, the space $\operatorname{Hom}\left(m_{c}(\mathfrak{k}), \mathcal{A}^{*}(M)\right)$ of continuous $\mathbb{C}$ linear maps from the space $m_{c}(\mathfrak{k})$ of smooth compactly supported densities on $\mathfrak{k}$ to the space $\mathcal{A}^{*}(M)$, both endowed with the $\mathcal{C}^{\infty}$-topologies. We define

$$
\mathcal{A}_{K}^{-\infty}(M):=\mathcal{C}^{-\infty}\left(\mathfrak{k}, \mathcal{A}^{*}(M)\right)^{K}
$$

as the space of $K$-equivariant $\mathcal{C}^{-\infty}$-maps from $\mathfrak{k}$ to $\mathcal{A}^{*}(M)$. An element of the space $\mathcal{A}_{K}^{-\infty}(M)$ is called an equivariant form with generalized coefficients. The image of $\phi \in m_{c}(\mathfrak{k})$ under $\alpha \in \mathcal{C}^{-\infty}\left(\mathfrak{k}, \mathcal{A}^{*}(M)\right)$ is a differential form on $M$ denoted by $\langle\alpha, \phi\rangle_{\mathfrak{f}}$.

We see that $\mathcal{A}_{K}^{\infty}(M) \subset \mathcal{A}_{K}^{-\infty}(M)$ and we can also extend the differential $\mathcal{D}$ to $\mathcal{A}_{K}^{-\infty}(M)$ [12]. Take a basis $\left\{E^{1}, \cdots, E^{p}\right\}$ of $\mathfrak{k}$, with associated dual basis $\left\{E_{1}, \cdots, E_{p}\right\}$. Let $\left\{X_{1}, \cdots, X_{p}\right\}$ be the corresponding coordinate functions on $\mathfrak{k}$. For every $\gamma \in \mathcal{A}_{K}^{-\infty}(M)$,
$<\mathcal{D}(\gamma), \phi>_{\mathfrak{k}}:=d<\gamma, \phi>_{\mathfrak{k}}-\sum_{k=1}^{p} c\left(E_{M}^{k}\right)<\gamma, X_{k} \phi>_{\mathfrak{k}} \quad$ for every $\quad \phi \in m_{c}(\mathfrak{k})$.

Using the $K$-equivariance condition, we verify that $\mathcal{D}^{2}=0$ on $\mathcal{A}_{K}^{-\infty}(M)$. The cohomology associated to $\left(\mathcal{A}_{K}^{-\infty}(M), \mathcal{D}\right)$ is called the $K$-equivariant cohomology with generalized coefficients and is denoted by $\mathcal{H}_{K}^{-\infty}(M)$. The sub-space $\mathcal{A}_{K, c p t}^{-\infty}(M):=\mathcal{C}^{-\infty}\left(\mathfrak{k}, \mathcal{A}_{c p t}^{*}(M)\right)^{K}$ is stable under the differential $\mathcal{D}$, and we denote by $\mathcal{H}_{K, c p t}^{-\infty}(M)$ the associated cohomology.

Let $H$ be a compact Lie group with Lie algebra $\mathfrak{h}$. For every $f \in \mathcal{C}^{\infty}(\mathfrak{h})$, we denote by $\bar{f}^{H}$ the $H$-invariant function on $\mathfrak{h}$ defined by the equation

$$
\bar{f}^{H}(X):=\int_{K} f(h \cdot X) d h, \quad X \in \mathfrak{h},
$$

where $d h$ is the normalized Haar measure on $H\left(\int_{H} d h=1\right)$. It defines the projection $f \mapsto \bar{f}^{H}, \mathcal{C}^{\infty}(\mathfrak{h}) \rightarrow \mathcal{C}^{\infty}(\mathfrak{h})^{H}$, and the same holds for the subspace $\mathcal{C}_{c p t}^{\infty}(\mathfrak{h})$ and $\mathcal{C}_{r d}^{\infty}(\mathfrak{h})$. Recall that every $H$-invariant generalized function $\phi \in$ $\mathcal{C}^{-\infty}(\mathfrak{h})$ is completely determined by its values on the $H$-invariant densities of $\mathfrak{h}$, and moreover, for every $f \in \mathcal{C}_{c p t}^{\infty}(\mathfrak{h})$ we have

$$
<\phi(X), f(X) d X>_{\mathfrak{h}}=<\phi(X), \bar{f}^{H}(X) d X>_{\mathfrak{h}} .
$$

### 2.2 Critical points of $\left\|\mu_{K}\right\|^{2}$

In this sub-section we prove that the set $\operatorname{Cr}\left(\left\|\mu_{K}\right\|^{2}\right)$ of critical points of the function $\left\|\mu_{K}\right\|^{2}$ is a $K$-orbit in $M$.

For a point $m \in M$ we decompose $m=x_{m}+y_{m}$ with $x_{m}=\mu_{K}(m) \in \mathfrak{k}$ and $y_{m} \in \mathfrak{p}$. By definition of the moment map we have $\frac{1}{2} d\left\|\mu_{K}\right\|_{m}^{2}=\left(d \mu_{K}(m), \mu_{K}(m)\right)=$ $\Omega\left(\left.\left(x_{m}\right)_{M}\right|_{m}, \cdot\right), m \in M$. Then $d\left\|\mu_{K}\right\|_{m}^{2}=0$ iff $\left.\left(x_{m}\right)_{M}\right|_{m}=0$ or equivalently $\left[x_{m}, m\right]=\left[x_{m}, y_{m}\right]=0$. We have shown the following

$$
\begin{equation*}
\operatorname{Cr}\left(\left\|\mu_{K}\right\|^{2}\right)=\left\{m \in M \mid\left[x_{m}, y_{m}\right]=0\right\} . \tag{2.6}
\end{equation*}
$$

Proposition 2.1 The critical points of $\left\|\mu_{K}\right\|^{2}$ form a $K$-orbit in M. In particular the points of $\operatorname{Cr}\left(\left\|\mu_{K}\right\|^{2}\right)$ are the points where $\left\|\mu_{K}\right\|^{2}$ is minimum.

To prove this proposition we consider the length function $\Psi: M \rightarrow \mathbb{R}$, $\Psi(m)=\|m\|^{2}$. We have already seen that $\left\|\mu_{K}\right\|^{2}=\frac{1}{2} \Psi-\frac{a}{2}$ for some $a \in \mathbb{R}$. Then we can work with $\Psi$ instead of $\left\|\mu_{K}\right\|^{2}$.

Proposition (2.1) is a consequence of the next Lemma which is due to P . Slodowy [21].

Lemma 2.2 Let $m \in M$ be a critical point of $\Psi$, and $m^{\prime} \in M$. Then either $\Psi\left(m^{\prime}\right)>\Psi(m)$ or $m^{\prime} \in K . m$.

Proof: Let $g \in G$ such that $m^{\prime}=g . m$. Using the Cartan decomposition $G=K \exp (\mathfrak{p})$ we know that

$$
m^{\prime}=k \exp (X) \cdot m, \quad \text { with } k \in K \text { and } X \in \mathfrak{p} .
$$

We are now going to prove that $\Psi\left(m^{\prime}\right)>\Psi(m)$ or $\exp (X) \cdot m=m$. Consider the following function $\kappa(t)=\Psi(\exp (t X) . m), t \in \mathbb{R}$. The element $X$ belongs to $\mathfrak{p}$, then the endomorphism $\operatorname{ad}(X): \mathfrak{g} \rightarrow \mathfrak{g}, Z \rightarrow[X, Z]$ is auto-adjoint relatively to the scalar product, hence diagonalizable. Let $\mathfrak{g}=\sum_{a} \mathfrak{g}_{a}$ be the decomposition into orthogonal subspaces of $\mathfrak{k}$ where for $a \in \mathbb{R}$,

$$
\mathfrak{g}_{a}=\{Y \in \mathfrak{g} \mid[X, Y]=a Y\} .
$$

If we write $m=\sum_{a} m_{a}$ with $m_{a} \in \mathfrak{g}_{a}$, we have $\kappa(t)=\left\|\sum_{a} e^{a t} m_{a}\right\|^{2}=$ $\sum_{a} e^{2 a t}\left\|m_{a}\right\|^{2}$. This shows that $\kappa^{\prime \prime}(t)=4 \sum_{a \neq 0} a^{2} e^{2 a t}\left\|m_{a}\right\|^{2}$ is a positive function on $\mathbb{R}$, and we have also $\kappa^{\prime}(0)=0$ (because $m$ is a critical point of $\left.\Psi\right)$. The function $\kappa$ is convex and the equality $\kappa^{\prime}(0)=0$ implies that either $\kappa(1)>\kappa(0)$ or $\kappa$ is constant on the interval $[0,1]$. In the first case we get that $\Psi\left(m^{\prime}\right)>\Psi(m)$. The second point imposes that $\kappa^{\prime \prime}(t)=4 \sum_{a \neq 0} a^{2} e^{2 a t}\left\|m_{a}\right\|^{2}=0$ for every $0<t<1$. This means that $m_{a}=0$ for every $a \neq 0$ or equivalently $[X, m]=0$ (hence $\exp (X) \cdot m=m$ ).

This Lemma implies that every critical point of $\Psi$ reaches the minimum of $\Psi$, and that two critical points of $\Psi$ are in the same $K$-orbit. The properness of $\Psi$ implies that $\Psi(M)$ is closed in $\mathbb{R}$, in particular the minimum of $\Psi$ is reached and so $\operatorname{Cr}\left(\left\|\mu_{K}\right\|^{2}\right)=\operatorname{Cr}(\Psi) \neq \emptyset$. The proof of Proposition 2.1 is then completed.

Remark 2.3 One could consider this length function $\Psi$ in the case of a general orbit M. But from the results of P. Slodowy in [21], we know that $\operatorname{Cr}(\Psi)=\emptyset$ when $M$ is not closed.

### 2.3 Localization on $\operatorname{Cr}\left(\left\|\mu_{K}\right\|^{2}\right)$

The $K$-invariant scalar product on $\mathfrak{g}$ defines a $K$-invariant Riemannian metric $(\cdot, \cdot)_{M}$ on the adjoint orbit $M$. Let $\lambda_{K}:=(\mathcal{H}, .)_{M}$ be the $K$-invariant one form on $M$, where $\mathcal{H}$ is the Hamiltonian vector field associated to the function $\frac{1}{2}\left\|\mu_{K}\right\|^{2}$. More precisely, if we note $m=x_{m}+y_{m}$ with $x_{m} \in \mathfrak{k}$ and $y_{m} \in \mathfrak{p}$, we have $\mathcal{H}_{m}=-\left[x_{m}, y_{m}\right] \in \mathbf{T}_{m} M$ for every $m \in M$, and

$$
\begin{equation*}
\left.\lambda_{K}\right|_{m}=-\left(\left[x_{m}, y_{m}\right], \cdot\right)_{M}, \quad m \in M . \tag{2.7}
\end{equation*}
$$

This 1-form was introduced by Witten in [24] to describe a Non-Abelian localization in equivariant cohomology. Now, this idea has been developed by the author in $[16,17]$. In the case of an elliptic orbit $M=G . \beta$, with $\beta \in \mathfrak{k}$, Duflo and Vergne already used the 1 -form $\lambda_{K}$ in [8] (it was denoted by $\theta$, see Proposition 35) to localize the integral defining $\left.F_{M}\right|_{\mathfrak{e}}$ to the submanifold $K . \beta \subset M$. We are going to extend this localization for all closed orbits, using the technique of partition of unity in equivariant cohomology introduced in [16].

We note $\Phi_{\lambda_{K}}: M \rightarrow \mathfrak{k}$ the $K$-equivariant map defined by $\left(\Phi_{\lambda}(m), X\right):=$ $\lambda\left(X_{M}\right)(m), m \in M, X \in \mathfrak{k}$. By definition $X_{M}(m)=-[X, m]$ for every $X \in \mathfrak{k}$ and $\left(\Phi_{\lambda}(m), X\right)=\left(\left[x_{m}, y_{m}\right],[X, m]\right)_{M}=-B\left(\left[x_{m}, y_{m}\right], \theta[X, m]\right)$. When $X \in \mathfrak{k}$, the $\mathfrak{p}$-part of $\theta[X, m]$ is $-\left[X, y_{m}\right]$ and hence $-B\left(\left[x_{m}, y_{m}\right], \theta[X, m]\right)=$
$B\left(\left[x_{m}, y_{m}\right],\left[X, y_{m}\right]\right)=-B\left(\left[\left[x_{m}, y_{m}\right], y_{m}\right], X\right)$. Finally we see that $\Phi_{\lambda_{K}}: M \rightarrow \mathfrak{k}$ is defined by

$$
\Phi_{\lambda_{K}}(m)=\left[\left[x_{m}, y_{m}\right], y_{m}\right] \in \mathfrak{k} \quad \text { for every } m \in M
$$

The equality $\left(\Phi_{\lambda}(m), \mu_{K}\right)(m)=\left\|\left[x_{m}, y_{m}\right]\right\|^{2}$ shows that $\left\{\Phi_{\lambda_{K}}=0\right\}=\{m \in$ $\left.M \mid\left[x_{m}, y_{m}\right]=0\right\}=\operatorname{Cr}\left(\left\|\mu_{K}\right\|^{2}\right)$, and we know from the last sub-section that the set $\operatorname{Cr}\left(\left\|\mu_{K}\right\|^{2}\right)$ is a $K$-orbit.

We work now with the following data. Take a point $\beta \in \operatorname{Cr}\left(\left\|\mu_{K}\right\|^{2}\right)$. Then the manifold $M$ is of the form $M=G . \beta$ with $\beta=\beta_{0}+\beta_{1}, \beta_{0} \in \mathfrak{k}, \beta_{1} \in$ $\mathfrak{p},\left[\beta_{0}, \beta_{1}\right]=0$, and $\left\{\Phi_{\lambda_{K}}=0\right\}=K . \beta$. If we make the choice of a Weyl chamber $\mathfrak{t}^{+}$in $\mathfrak{t}$, we can take $\beta_{0} \in \mathfrak{t}^{+}$.

Lemma 3.1 of [16] tells us that the equivariant form $\mathcal{D} \lambda_{K}(X)=d \lambda_{K}-$ $\left(\Phi_{\lambda_{K}}, X\right)$ is invertible outside the submanifold $K . \beta$ in the space of generalized equivariant forms. For each $K$-invariant differential form $\chi_{\text {ext }}$ on $M$, equal to zero in a neighbourhood of $K . \beta$, we can define $\chi_{e x t}\left(\int_{0}^{\infty} \imath e^{-\imath t} \mathcal{D} \lambda_{K} d t\right) \in$ $\mathcal{A}_{K}^{-\infty}(M)$, and this form satisfies the equality

$$
\chi_{e x t}\left(\int_{0}^{\infty} \imath e^{-\imath t \mathcal{D} \lambda_{K}} d t\right) \mathcal{D} \lambda_{K}=\chi_{e x t}
$$

in $\mathcal{A}_{K}^{-\infty}(M)$.
Let $\chi \in \mathcal{C}^{\infty}(M)^{K}$ be a function with compact support on $M$, and equal to 1 in a neighbourhood of $K . \beta$. Then the differential form $d \chi$ is equal to 0 in a neighbourhood of $K . \beta$, and we can define the equivariant form with compact support on $M$

$$
\begin{equation*}
\mathrm{P}^{K}=\chi+d \chi\left(\int_{0}^{\infty} \imath e^{-\imath t \mathcal{D} \lambda_{K}} d t\right) \lambda_{K} \in \mathcal{A}_{K, c p t}^{-\infty}(M) \tag{2.8}
\end{equation*}
$$

Recall Propositions 3.3 and 3.11 of [16].
Proposition 2.4 The equivariant form $\mathrm{P}^{K}$ is closed, and we have the identity

$$
\begin{equation*}
\mathbf{1}_{M}=\mathrm{P}^{K}+\mathcal{D}(\delta) \tag{2.9}
\end{equation*}
$$

where $\mathbf{1}_{M}$ is the constant function equal to 1 on $M$, and $\delta=(1-\chi)\left(\int_{0}^{\infty} \imath e^{-\imath t} \mathcal{D} \lambda_{K} d t\right) \lambda_{K}$ is a generalized $K$-equivariant form. Moreover the cohomology class of $\mathrm{P}^{K}$ in $\mathcal{H}_{K, c p t}^{-\infty}(M)$ does not depend neither of the choice of the function $\chi$ nor of the choice of the Riemannian metric near K. $\beta$.

We use the phrase "partition of unity" to refer to the equality (2.9), and we will use it to decompose every closed form $\eta \in \mathcal{A}_{K}^{\infty}(M)$ in the following way $\eta=\eta \mathrm{P}^{K}+\mathcal{D}(\eta \delta)$; a sum of an equivariant form $\eta \mathrm{P}^{K}$ supported near $K . \beta$ and an exact equivariant form $\mathcal{D}(\eta \delta)$.

With the compactly supported equivariant form $\mathrm{P}^{K}$ we are going to localize the Fourier transform of $M$. The generalized equivariant form $e^{2 \Omega_{\mathrm{e}}} \mathrm{P}^{K}$ is tempered. For every $f \in \mathcal{C}_{d r}^{\infty}(\mathfrak{k})$, the differential form $<e^{\Omega \Omega_{\mathfrak{k}}(X)} \mathrm{P}^{K}(X), f(X) d X>_{\mathfrak{k}}$ is well defined, with compact support (included in the support of $\chi$ ), and is given

$$
\begin{align*}
& <e^{\imath \Omega_{\mathfrak{k}}(X)} \mathrm{P}^{K}(X), f(X) d X>\left._{\mathfrak{k}}\right|_{m}=\chi(m) e^{\imath \Omega_{m}} \widehat{f}\left(-\mu_{K}(m)\right)+ \\
& \left.d \chi(m) e^{\imath \Omega_{m}}\left(\int_{0}^{\infty} \imath e^{-\left.\imath t d \lambda_{K}\right|_{m}} \widehat{f}\left(-t \Phi_{\lambda_{K}}(m)-\mu_{K}(m)\right) d t\right) \lambda_{K}\right|_{m}, \tag{2.10}
\end{align*}
$$

where $\widehat{f}$ is the Fourier transform of $f$ relatively to $d X$. Note that the map $m \rightarrow \int_{0}^{\infty} \imath e^{-\left.\imath t d \lambda_{K}\right|_{m}} \widehat{f}\left(-t \Phi_{\lambda_{K}}(m)-\mu_{K}(m)\right) d t$ is a well defined differential form on $M \backslash\{K . \beta\}$.

The integral of $e^{2 \Omega_{\mathrm{e}}} \mathrm{P}^{K}$ on $M$ defines a $K$-invariant tempered measure on $\mathfrak{k}$ by the equation

$$
<\left(\int_{M} e^{\imath \Omega_{\mathfrak{l}}} \mathrm{P}^{K}\right)(X), f(X) d X>_{\mathfrak{k}}:=\int_{M}<e^{\imath \Omega_{\mathfrak{k}}(X)} \mathrm{P}^{K}(X), f(X) d X>_{\mathfrak{k}}, \quad f \in \mathcal{C}_{r d}^{\infty}(\mathfrak{k})
$$

Theorem 2.5 We have the following equality of tempered measure on $\mathfrak{k}$

$$
\int_{M} e^{\imath \Omega_{\mathrm{e}}}=\int_{M} e^{\imath \Omega_{\mathrm{e}}} \mathrm{P}^{K} .
$$

Proof: For every tempered measure $\mathfrak{D}$ on $\mathfrak{k}$ we have the following property: if for every function $f \in \mathcal{C}_{c p t}^{\infty}(\mathfrak{k})$ with compact support we have $<\mathfrak{D}(X), \widehat{f}(X) d X>_{\mathfrak{k}}=$ 0 (where $\widehat{f}$ is the Fourier transform of $f$ relatively to $d X$ ), then the measure $\mathfrak{D}$ is identically equal to zero.

Here we take $\mathfrak{D}:=\int_{M} e^{\imath \Omega_{\mathrm{E}}}-\int_{M} e^{\imath \Omega_{\mathrm{e}}} \mathrm{P}^{K}$. Using now the partition of unity (2.9), we see that $<\mathfrak{D}(X), \widehat{f}(X) d X>_{\mathfrak{k}}=\int_{M} A_{f}$ with $A_{f}=<\mathcal{D}\left(e^{\imath \Omega_{\mathfrak{R}}} \delta\right)(X), \widehat{f}(X) d X>_{\mathfrak{k}} \in$ $\mathcal{A}^{*}(M)$. The theorem will be proved after showing that, for every function $f \in \mathcal{C}_{\text {cpt }}^{\infty}(\mathfrak{k})$, there exists a compactly supported differential form $B_{f}$ on $M$ such that $A_{f}-d\left(B_{f}\right) \in \mathcal{A}^{<\operatorname{dim} M}(M)$ : the usual 'Stokes' argument implies that $\int_{M} A_{f}=\int_{M} d\left(B_{f}\right)=0$

By definition of the differential $\mathcal{D}$, we have $A_{f}=<\mathcal{D}\left(e^{\Omega \Omega_{\mathfrak{k}}} \delta\right)(X), \widehat{f}(X) d X>_{\mathfrak{k}}=$ $d\left(<e^{\imath \Omega_{\mathfrak{k}}(X)} \delta(X), \widehat{f}(X) d X>_{\mathfrak{k}}\right)-\sum_{k=1}^{p} c\left(E_{M}^{k}\right)<e^{\imath \Omega_{\mathfrak{k}}(X)} \delta(X), X_{k} \widehat{f}(X) d X>_{\mathfrak{k}}$, and we take $B_{f}:=<e^{\imath \Omega_{\mathfrak{R}}(X)} \delta(X), \widehat{f}(X) d X>_{\mathfrak{k}}$. For every $m \in M$ we have

$$
\begin{equation*}
\left.B_{f}\right|_{m}=\left.(2 \pi)^{\operatorname{dim} K}(1-\chi(m)) e^{\imath \Omega_{m}}\left(\int_{0}^{\infty} \imath e^{-\left.\imath t d \lambda_{K}\right|_{m}} f\left(t \Phi_{\lambda_{K}}(m)+\mu_{K}(m)\right) d t\right) \lambda_{K}\right|_{m}, \tag{2.11}
\end{equation*}
$$

since $\widehat{\hat{f}}(-X)=(2 \pi)^{\operatorname{dim} K^{\prime}} f(X), X \in \mathfrak{k}$. From (2.11), we see that $\left.B_{f}\right|_{m}=0$ if $t \Phi_{\lambda_{K}}(m)+\mu_{K}(m)$ is not in the support of $f$ for every $t>0$. But

$$
\left\|t \Phi_{\lambda_{K}}+\mu_{K}\right\|^{2}=\left\|\mu_{K}\right\|^{2}+t^{2}\left\|\Phi_{\lambda_{K}}\right\|^{2}+2 t\left(\Phi_{\lambda_{K}}, \mu_{K}\right) \geq\left\|\mu_{K}\right\|^{2}
$$

because $\left(\Phi_{\lambda_{K}}, \mu_{K}\right)=\|\mathcal{H}\|_{M}^{2} \geq 0$ on $M$. Let $r>0$ such that the function $f$ is supported in the ball $B(O, r)$ of radius $r$. Using the precedent inequalities we see finally that the differential form $B_{f}$ is supported in $\mu_{K}^{-1}(B(O, r))$, hence is with compact support ( $\mu_{K}$ being proper).

## 3 First reduction: Symplectic induction

In this subsection, we prove an induction formula for the equivariant form $\mathrm{P}^{K}$ similar to the induction we obtain in section 3 of [17]. For this purpose we use the cross section Theorem of Guillemin-Sternberg [10] (see Theorem 6.7), and also a Proposition of Duflo-Vergne [8] about generalized equivariant forms that admit a restriction.

Let $T$ be a maximal torus of $K$ with Lie algebra $\mathfrak{t}$, and let $W:=W(K, T)$ be the Weyl group associated. We make the choice of a Weyl chamber $\mathfrak{t}_{+}$in $\mathfrak{t}$. Recall that a closed adjoint orbit $M$ in $\mathfrak{g}$ is of the form $M=G . \beta$ with $\beta=\beta_{0}+\beta_{1}, \beta_{0} \in \mathfrak{t}_{+}, \beta_{1} \in \mathfrak{p}$ and $\left[\beta_{0}, \beta_{1}\right]=0$, and that the cohomology class of $\mathrm{P}^{K}$ does not depend on the choice of the $K$-invariant Riemannian metric in a neighbourhood of $K . \beta$.

## Symplectic cross-section

Let $\sigma$ be the unique open face of $\mathfrak{t}_{+}$which contains $\beta_{0}$. The stabilizer subgroup $K_{\xi} \subset K$ that does not depend on the choice of $\xi \in \sigma$ is denoted $K_{\sigma}$, and we denote by $\mathfrak{k}_{\sigma}$ its Lie algebra (sometimes we use the different notations $K_{\beta_{0}}$, $\mathfrak{k}_{\beta_{0}}$ ).

Let $U_{\sigma}$ be the $K_{\sigma}$-invariant open subset of $\mathfrak{k}_{\sigma}$ defined by

$$
\begin{equation*}
U_{\sigma}:=K_{\sigma} \cdot\left\{y \in \mathfrak{t}_{+} \mid K_{y} \subset K_{\sigma}\right\}=K_{\sigma} . \bigcup_{\sigma \subset \bar{\tau}} \tau, \tag{3.12}
\end{equation*}
$$

where $\{\sigma \subset \bar{\tau}\}$ is the set of all faces $\tau$ of $\mathfrak{t}_{+}$which contain $\sigma$ in their closure. By construction, $U_{\sigma}$ is a slice for the adjoint action at any $\xi \in \sigma$ (see Definition 3.1 of [13]). This means that the map $K \times U_{\sigma} \rightarrow \mathfrak{k},(g, \xi) \rightarrow g . \xi$, factors through an inclusion $K \times_{K_{\sigma}} U_{\sigma} \hookrightarrow \mathfrak{k}$.

The symplectic cross-section theorem [10] asserts that the pre-image $\mathcal{Y}_{\sigma}=$ $\mu_{K}^{-1}\left(U_{\sigma}\right)$ is a symplectic submanifold provided with an Hamiltonian action of the group $K_{\sigma}$. The restriction $\mu_{K} \mid \mathcal{\nu}_{\sigma}$ is a moment map for the action of $K_{\sigma}$ on $\mathcal{Y}_{\sigma}$ that we denote by $\mu_{\sigma}$. In our case we just need the fact that $\mathfrak{k}_{\sigma} \oplus \mathfrak{p}$ intersects transversally $M$ in a neighbourhood of $K_{\sigma} . \beta \subset \mathcal{Y}_{\sigma} \subset M \cap\left(\mathfrak{k}_{\sigma} \oplus \mathfrak{p}\right)$.

Moreover, the set $K . \mathcal{Y}_{\sigma}$ is a $K$-invariant open neighbourhood of $K . \beta$ in $M$ diffeomorphic to $K \times_{K_{\sigma}} \mathcal{Y}_{\sigma}$. Then, we can compute the equivariant form $\mathrm{P}^{K}$ on the manifold $\mathcal{M}_{\sigma}:=K \times_{K_{\sigma}} \mathcal{Y}_{\sigma}$. We will denote by $\Omega_{\sigma}(Y):=\left.\Omega\right|_{\mathcal{Y}_{\sigma}}+\left(\mu_{\sigma}, Y\right), Y \in$ $\mathfrak{k}_{\sigma}$, the corresponding $K_{\sigma}$-equivariant symplectic form on $\mathcal{Y}_{\sigma}$.

## Induced metric on $\mathcal{M}_{\sigma}$

The quotient $\mathfrak{k} / \mathfrak{k}_{\sigma}$ is identified with the orthogonal complement $\mathfrak{k}_{\sigma}^{\perp}$ of $\mathfrak{k}_{\sigma}$ in $\mathfrak{k}$. We denote respectively by $p r_{\mathfrak{k} / \mathfrak{k}_{\sigma}}$ and $p r_{\mathfrak{k}_{\sigma}}$ the orthogonal projections $\mathfrak{k} \rightarrow \mathfrak{k}_{\sigma}^{\perp}$ and $\mathfrak{k} \rightarrow \mathfrak{k}_{\sigma}$. From now on we fix a $K_{\sigma}$-invariant metric $(\cdot, \cdot)_{\mathcal{y}_{\sigma}}$ on $\mathcal{Y}_{\sigma}$ and we
associate to this metric a natural $K$-invariant Riemannian metric $(\cdot, \cdot)_{\mathcal{M}_{\sigma}}$ on $\mathcal{M}_{\sigma}:=K \times_{K_{\sigma}} \mathcal{Y}_{\sigma}$ which is defined by

$$
\begin{equation*}
\left\|X_{\mathcal{M}_{\sigma}}+v_{m}\right\|_{\mathcal{M}_{\sigma}}^{2}[k, m]:=\left\|p r_{\mathfrak{k} / \mathfrak{k}_{\sigma}}\left(k^{-1} X\right)\right\|_{\mathfrak{k}}^{2}+\left\|\left.p r_{\mathfrak{k}_{\sigma}}\left(k^{-1} X\right)_{\mathcal{Y}_{\sigma}}\right|_{m}+v_{m}\right\|_{\mathcal{Y}_{\sigma}}^{2} \tag{3.13}
\end{equation*}
$$

for $X \in \mathfrak{k}$ and $v_{m} \in \mathbf{T}_{m} M$. Here we use the identification between $\mathbf{T}_{[k, m]} \mathcal{M}_{\sigma}$ and $\left(\mathbf{T}_{g} K \times \mathbf{T}_{m} \mathcal{Y}_{\sigma}\right) / \sim,(\sim$ is the relation of equivalence coming from the $K_{\sigma}$-orbits in $K \times \mathcal{Y}_{\sigma}$ ).

Let $\lambda_{\sigma}:=\left(\mathcal{H}_{\sigma}, \cdot\right)_{\mathcal{Y}_{\sigma}}$ be the $K_{\sigma}$-invariant 1 -form on $\mathcal{Y}_{\sigma}$, where $\mathcal{H}_{\sigma}$ is the Hamiltonian vector field of $\frac{1}{2}\left\|\mu_{\sigma}\right\|^{2}$. A straightforward computation shows that $\operatorname{Cr}\left(\left\|\mu_{\sigma}\right\|^{2}\right)=\operatorname{Cr}\left(\left\|\mu_{K}\right\|^{2}\right) \cap \mathcal{Y}_{\sigma}=K_{\sigma} . \beta$. Let $\tilde{\lambda}_{K}:=(\mathcal{H}, \cdot)_{\mathcal{M}_{\sigma}}$ be the $K$-invariant 1 -form on $\mathcal{M}_{\sigma}$ defined with the induced metric $(\cdot, \cdot)_{\mathcal{M}_{\sigma}}$, where $\mathcal{H}$ is still the Hamiltonian vector field of $\frac{1}{2}\left\|\mu_{K}\right\|^{2}$.

Using the definition of the induced metric $(\cdot, \cdot)_{\mathcal{M}_{\sigma}}$ we see that $i_{\sigma}^{*}\left(\tilde{\lambda}_{K}\right)=\lambda_{\sigma}$, where $i_{\sigma}: \mathcal{Y}_{\sigma} \hookrightarrow \mathcal{M}_{\sigma}$ denotes the $K_{\sigma}$-equivariant inclusion, and we also remark that

$$
\begin{equation*}
\left(\Phi_{\tilde{\lambda}_{K}}([k, m]), X\right)_{\mathfrak{k}}=\left(\Phi_{\lambda_{K_{\sigma}}}(m), p r_{\mathfrak{k}_{\sigma}}\left(k^{-1} X\right)\right)_{\mathfrak{k}}, \quad X \in \mathfrak{k},[k, m] \in \mathcal{M}_{\sigma}, \tag{3.14}
\end{equation*}
$$

where $p r_{\mathfrak{k}_{\sigma}}: \mathfrak{k} \rightarrow \mathfrak{k}_{\sigma}$ is the orthogonal projection. We will use these facts at Proposition 3.4.

Definition 3.1 Let $\chi \in \mathcal{C}_{c p t}^{\infty}\left(\mathcal{M}_{\sigma}\right)^{K}$ be the function coming from a $K_{\sigma}$-invariant function $\chi_{\sigma}$ on $\mathcal{Y}_{\sigma}$, where $\chi_{\sigma}$ is equal to 1 in a neighbourhood of $\operatorname{Cr}\left(\left\|\mu_{\sigma}\right\|^{2}\right)=$ $K_{\sigma} . \beta$. Then the function $\chi$, that is equal to 1 in a neighbourhood of $\operatorname{Cr}\left(\left\|\mu_{K}\right\|^{2}\right)=$ $K \times_{K_{\sigma}}\left(K_{\sigma} . \beta\right)$, defines the $K$-equivariant form

$$
\widetilde{\mathrm{P}}^{K}=\chi+d \chi\left(\int_{0}^{\infty} u e^{-\imath t \mathcal{D} \tilde{\lambda}_{K}} d t\right) \tilde{\lambda}_{K} \in \mathcal{A}_{K, c p t}^{-\infty}\left(\mathcal{M}_{\sigma}\right) .
$$

With the function $\chi_{\sigma}$ we define in the same way the $K_{\sigma}$-equivariant form

$$
\mathrm{P}^{K_{\sigma}}=\chi_{\sigma}+d \chi_{\sigma}\left(\int_{0}^{\infty} \imath e^{-\imath t} \mathcal{D} \lambda_{\sigma} d t\right) \lambda_{\sigma} \in \mathcal{A}_{K_{\sigma}, c p t}^{-\infty}\left(\mathcal{Y}_{\sigma}\right) .
$$

The inclusion $\mathcal{M}_{\sigma} \hookrightarrow M$ of an open subset defines a natural morphism $\mathcal{A}_{c p t}^{*}\left(\mathcal{M}_{\sigma}\right) \rightarrow \mathcal{A}_{c p t}^{*}(M)$ between the differential forms with compact support, and hence a morphism
$j: \mathcal{A}_{K, c p t}^{-\infty}\left(\mathcal{M}_{\sigma}\right) \rightarrow \mathcal{A}_{K, c p t}^{-\infty}(M)$ between the $K$-equivariant forms with compact support. We know from Proposition 2.4, that

$$
\mathrm{P}^{K}=j\left(\widetilde{\mathrm{P}}^{K}\right) \quad \text { in } \quad \mathcal{H}_{K, c p t}^{-\infty}(M) .
$$

Let $\pi: \mathcal{M}_{\sigma} \rightarrow K / K_{\sigma},[k, y] \mapsto[k]$ be the projection map, and denote by $\int_{\text {Fiber }}:=\pi_{*}: \mathcal{A}_{K, c p t}^{-\infty}\left(\mathcal{M}_{\sigma}\right) \rightarrow \mathcal{A}_{K}^{-\infty}\left(K / K_{\sigma}\right)$ the morphism of integration along the fiber of $\pi$. Then we have

$$
\begin{align*}
\left.F_{M}\right|_{\mathfrak{k}} & =\int_{\mathcal{M}_{\sigma}} e^{\imath \Omega_{\mathfrak{e}}} \widetilde{\mathrm{P}}^{K} \\
& =\int_{K / K_{\sigma}}\left(\int_{\text {Fiber }} e^{\imath \Omega_{\mathfrak{e}}} \widetilde{\mathrm{P}}^{K}\right) \tag{3.15}
\end{align*}
$$

In the next paragraph we are going to show that the 'computation' of the closed equivariant form $\int_{\text {Fiber }} e^{\imath \Omega_{\mathrm{e}}} \widetilde{\mathrm{P}}^{K} \in \mathcal{A}_{K}^{-\infty}\left(K / K_{\sigma}\right)$ can be deduced from those of the generalized function
$\int_{\mathcal{Y}_{\sigma}} e^{\imath \Omega_{\mathfrak{R}_{\sigma}}} \mathrm{P}^{K_{\sigma}} \in \mathcal{C}^{-\infty}\left(\mathfrak{k}_{\sigma}\right)^{K_{\sigma}}$.

## Restriction of generalized equivariant forms

The manifold $\mathcal{Y}_{\sigma}$ is oriented by its symplectic form, and $K \times_{K_{\sigma}} \mathcal{Y}_{\sigma}$ is oriented by the symplectic form on $M$. Hence, we get an orientation $o$ for $K / K_{\sigma}$ and we verify that this orientation coincides with those of Definition 1.3. This gives a polynomial square root $Y \rightarrow \Pi_{\mathfrak{k} / \mathfrak{k}_{\sigma}}(Y):=\operatorname{det}_{\mathfrak{k} / \mathfrak{k}_{\sigma}, o}^{1 / 2}(Y), Y \in \mathfrak{k}_{\sigma}$ (we will use also the notation $\Pi_{\mathfrak{k} / \mathfrak{k}_{\beta_{0}}}$ for this polynomial). Note that $\Pi_{\mathfrak{k} / \mathfrak{k}_{\sigma}}$ never vanishes on the open subset $U_{\sigma}$.

We have a natural identification between $\mathcal{A}^{*}\left(K / K_{\sigma}\right)$ and $\mathcal{C}^{\infty}\left(K,\left(\wedge \mathfrak{k}^{*}\right)_{\text {hor } K_{\sigma}}\right)^{K_{\sigma}}$, where $K_{\sigma}$-invariants are taken with respect to the action of $K_{\sigma}$ by right multiplication on $K$ and coadjoint action on $\mathfrak{k}^{*}$. The restriction map to the neutral element $e \in K, \mathcal{A}^{*}\left(K / K_{\sigma}\right) \rightarrow\left(\wedge \mathfrak{k}^{*}\right)_{h o r K_{\sigma}}, \alpha \rightarrow \alpha_{e}$, defines a morphism

$$
\begin{aligned}
\mathcal{A}_{K}^{-\infty}\left(K / K_{\sigma}\right) & \longrightarrow \mathcal{C}^{-\infty}\left(\mathfrak{k},\left(\wedge \mathfrak{k}^{*}\right)_{h o r K_{\sigma}}\right)^{K_{\sigma}} \\
\alpha(X) & \longmapsto \alpha_{e}(X) .
\end{aligned}
$$

Let $E_{1}, \cdots, E_{p}$ be a basis of $\mathfrak{k}^{*}$, and let $\left\{E_{I}=E_{i_{1}} \wedge \cdots \wedge E_{i_{k}}, I=\left[i_{1}<i_{2}<\right.\right.$ $\left.\left.\cdots<i_{k}\right] \subset[1,2, \ldots, p]\right\}$ be the corresponding basis of $\wedge \mathfrak{k}^{*}$. In particular, $E_{\emptyset}=1$ generates $\mathbb{R} \subset \wedge \mathfrak{k}^{*}$. For each $\alpha \in \mathcal{A}_{K}^{-\infty}\left(K / K_{\sigma}\right)$, the form $\alpha_{e}$ can be decomposed relatively to the basis $\left\{E_{I}, I\right\}: \alpha_{e}=\sum_{I}\left(\alpha_{e}\right)_{[I]} E_{I}$ with $\left(\alpha_{e}\right)_{[I]} \in \mathcal{C}^{-\infty}(\mathfrak{k})$.

We say that $\alpha$ admits a restriction to $\mathfrak{k}_{\sigma}$ if the wave front set of each component $\left(\alpha_{e}\right)_{[I]}$ is transverse to $\mathfrak{k}_{\sigma}$ (see [8] for this notion). In this case, each generalized function $\left(\alpha_{e}\right)_{[I]}$ admits a restriction to $\mathfrak{k}_{\sigma}$. We can then define $r_{\mathfrak{k}_{\sigma}} \alpha:=\left.\left(\alpha_{e}\right)_{[\varnothing]}\right|_{\mathfrak{k}_{\sigma}}$ that is a generalized $K_{\sigma}$-invariant function on $\mathfrak{k}_{\sigma}$. This definition extends the usual restriction map $r_{\mathfrak{k}_{\sigma}}: \mathcal{A}_{K}^{\infty}\left(K / K_{\sigma}\right) \rightarrow \mathcal{C}^{\infty}\left(\mathfrak{k}_{\sigma}\right)^{K_{\sigma}}$.

Remark 3.2 There is a basic way to know if $\alpha \in \mathcal{A}_{K}^{-\infty}\left(K / K_{\sigma}\right)$ admits a restriction to $\mathfrak{k}_{\sigma}$. Suppose there exist $\alpha^{a} \in \mathcal{A}_{K}^{\infty}\left(K / K_{\sigma}\right)$, $a>0$, such that
$-\lim _{a \rightarrow \infty} \alpha^{a}=\alpha$, and

- the restriction $\left.\alpha_{e}^{a}\right|_{\mathfrak{k}_{\sigma}} \in \mathcal{C}^{\infty}\left(\mathfrak{k}_{\sigma}, \wedge \mathfrak{k}^{*}\right)$ converges in $\mathcal{C}^{-\infty}\left(\mathfrak{k}_{\sigma}, \wedge \mathfrak{k}^{*}\right)$ when $a \rightarrow$ $\infty$. In particular $r_{\mathfrak{k}_{\sigma}} \alpha^{a} \in \mathcal{C}^{\infty}\left(\mathfrak{k}_{\sigma}\right)^{K_{\sigma}}$ converges in $\mathcal{C}^{-\infty}\left(\mathfrak{k}_{\sigma}\right)^{K_{\sigma}}$ when $a \rightarrow \infty$.

Then the equivariant form $\alpha$ admits a restriction to $\mathfrak{k}_{\sigma}$ and we have ${r_{\mathfrak{k}_{\sigma}} \alpha=}=$ $\lim _{a \rightarrow \infty} r_{\mathfrak{k}_{\sigma}} \alpha^{a}$.

Recall Proposition 31 of [8].
Proposition 3.3 Let $\alpha \in \mathcal{A}_{K}^{-\infty}\left(K / K_{\sigma}\right)$ be a closed equivariant form that admits a restriction to $\mathfrak{k}_{\sigma}$. Then for every $f \in \mathcal{C}_{\text {cpt }}^{\infty}(\mathfrak{k})$, we have

$$
<\left(\int_{K / K_{\sigma}} \alpha\right)(X), f(X) d X>_{\mathfrak{k}}=\operatorname{cte}<r_{\mathfrak{k}_{\sigma}} \alpha(Y),\left.\Pi_{\mathfrak{k} / \mathfrak{k}_{\sigma}}(Y) \bar{f}^{K}\right|_{\mathfrak{k}_{\sigma}}(Y) d Y>_{\mathfrak{k}_{\sigma}}
$$

with cte $=(-2 \pi)^{\operatorname{dim}\left(K / K_{\sigma}\right) / 2} \frac{\operatorname{vol}(K, d X)}{\operatorname{vol}\left(K_{\sigma}, d Y\right)}$.

We can now state the following
Lemma 3.4 The closed $K$-equivariant form $\int_{\text {Fiber }} e^{\imath \Omega_{\varepsilon}} \widetilde{\mathrm{P}}^{K} \in \mathcal{A}_{K}^{-\infty}\left(K / K_{\sigma}\right)$ admits a restriction to $\mathfrak{k}_{\sigma}$ equal to $\int_{\mathcal{Y}_{\sigma}} e^{\imath \Omega_{\mathfrak{k}_{\sigma}}} \mathrm{P}^{K_{\sigma}} \in \mathcal{C}^{-\infty}\left(\mathfrak{k}_{\sigma}\right)^{K_{\sigma}}$.

Proof: Here we are in the situation of Remark 3.2. We know already that $\widetilde{\mathrm{P}}^{K}$ is the limit of the equivariant form $\widetilde{\mathrm{P}}_{a}^{K}:=\chi+d \chi\left(\int_{0}^{a} \imath^{-\imath t \mathcal{D}} \tilde{\lambda}_{K} d t\right) \tilde{\lambda}_{K} \in$ $\mathcal{A}_{K, c p t}^{\infty}\left(\mathcal{M}_{\sigma}\right)$, and so $\alpha:=\int_{\text {Fiber }} e^{\imath \Omega_{\ell}} \widetilde{\mathrm{P}}^{K}$ is the limit of the equivariant forms $\alpha^{a}:=\int_{\text {Fiber }} e^{\imath \Omega_{\mathfrak{e}}} \widetilde{\mathrm{P}}_{a}^{K} \in \mathcal{A}_{K}^{\infty}\left(K / K_{\sigma}\right)$. Consider the maps $\alpha_{e}^{a} \mid \mathfrak{e}_{\sigma} \in \mathcal{C}^{\infty}\left(\mathfrak{k}_{\sigma}, \wedge \mathfrak{k}^{*}\right)^{K_{\sigma}}$. We have

$$
\begin{aligned}
\alpha_{e}^{a} \mid \mathfrak{e}_{\sigma}(Y) & =\int_{\mathcal{Y}_{\sigma}} e^{\imath \Omega_{e}+\imath\left(\mu_{\sigma}, Y\right)} \widetilde{\mathrm{P}}_{a, e}^{K}, \quad \text { with } \\
\widetilde{\mathrm{P}}_{a, e}^{K} & =\chi_{\sigma}+d \chi_{\sigma}\left(\int_{0}^{a} \imath e^{-\imath t d \tilde{\lambda}_{K} \mid e} e^{\imath t\left(\Phi_{\lambda_{\sigma}}, Y\right)} d t\right) \tilde{\lambda}_{K} \mid e,
\end{aligned}
$$

where $\Omega_{e},\left.\tilde{\lambda}_{K}\right|_{e}$ and $\left.d \tilde{\lambda}_{K}\right|_{e}$ are in $\wedge \mathfrak{k}^{*} \otimes \mathcal{A}^{*}\left(\mathcal{Y}_{\sigma}\right)$. In these equalities we have used that $\left(\Phi_{\tilde{\lambda}_{K}} \mid e, Y\right)_{\mathfrak{k}}=\left(\Phi_{\lambda_{\sigma}}, Y\right)_{\mathfrak{k}}$ for every $Y \in \mathfrak{k}_{\sigma}$ (see equation (3.14)). Since $d \chi_{\sigma}$ is equal to 0 in a neighbourhood of $\left\{\Phi_{\lambda_{\sigma}}=0\right\}$, we see that $\left.\alpha_{e}^{a}\right|_{\mathfrak{e}_{\sigma}}$ converge in $\mathcal{C}^{-\infty}\left(\mathfrak{k}_{\sigma}, \wedge \mathfrak{k}^{*}\right)^{K_{\sigma}}$, when $a \rightarrow \infty$.

If $i_{\sigma}: \mathcal{Y}_{\sigma} \hookrightarrow \mathcal{M}_{\sigma}$ denotes the $K_{\sigma}$-equivariant inclusion, we have $i_{\sigma}^{*}\left(\tilde{\lambda}_{K}\right)=$ $\lambda_{\sigma}$, and $i_{\sigma}^{*}(\Omega)=\Omega_{\sigma}$ (see equation (3.14)). Then we see that the functions $r_{\mathfrak{k}_{\sigma}} \alpha^{a}=\int_{\mathcal{Y}_{\sigma}} e^{\imath \Omega_{\mathfrak{k}_{\sigma}}} \mathrm{P}_{a}^{K_{\sigma}}$ with $\mathrm{P}_{a}^{K_{\sigma}}=\chi_{\sigma}+d \chi_{\sigma}\left(\int_{0}^{a} \imath e^{-\imath t \mathcal{D} \lambda_{\sigma}} d t\right) \lambda_{\sigma}$ converge to $\int_{\mathcal{Y}_{\sigma}} e^{2 \Omega_{\mathfrak{l}_{\sigma}}} \mathrm{P}^{K_{\sigma}}$ when $a \rightarrow \infty$. The proof is completed.

Proposition 3.5 We have the following description of the generalized function $F_{M} \mid \mathfrak{k}$. For every function $f \in \mathcal{C}_{r d}^{\infty}(\mathfrak{k})$, we have
$<\left.F_{M}\right|_{\mathfrak{k}}(X), f(X) d X>_{\mathfrak{k}}=\operatorname{cte}<\left(\int_{\mathcal{Y}_{\sigma}} \mathrm{P}^{K_{\sigma}}\right)(Y),\left.e^{\imath\left(\beta_{0}, Y\right)} \Pi_{\mathfrak{k} / \mathfrak{k}_{\sigma}}(Y) \bar{f}^{K}\right|_{\mathfrak{k}_{\sigma}}(Y) d Y>_{\mathfrak{k}_{\sigma}}$,
with cte $=(-2 \pi)^{\operatorname{dim}\left(K / K_{\sigma}\right) / 2} \frac{\operatorname{vol}(K, d X)}{\operatorname{vol}\left(K_{\sigma}, d Y\right)}$.
Proof: Let $\mathcal{U}$ be a $K_{\sigma}$-invariant tubular neighbourhood of $K_{\sigma} . \beta$ in $\mathcal{Y}_{\sigma}$, and denote by $p: \mathcal{U} \rightarrow K_{\sigma} . \beta$ the corresponding fibration. We denote by $i: K_{\sigma} . \beta \hookrightarrow$ $\mathcal{U}$ the 0 -section of this fibration. We need to compute the restriction $i^{*}\left(\Omega_{\mathfrak{k}_{\sigma}}\right)$ of the equivariant form $\Omega_{\mathfrak{R}_{\sigma}}$ on $K_{\sigma} . \beta$. First we note that the inclusion $K_{\sigma} . \beta \hookrightarrow \mathcal{Y}_{\sigma}$ is an isotropic embedding, because $\beta_{0}=\mu_{\sigma}\left(K_{\sigma} . \beta\right)$ is fixed by $K_{\sigma}$ : for every $X, X^{\prime} \in \mathfrak{k}_{\sigma}$, and $m \in K_{\sigma} . \beta$ we have $\left.\Omega_{\sigma}\right|_{m}\left(X_{\mathcal{Y}_{\sigma}}, X_{\mathcal{Y}_{\sigma}}^{\prime}\right)=-\left(\beta_{0},\left[X, X^{\prime}\right]\right)=0$. Then $i^{*}\left(\Omega_{\sigma}\right)=0$ and we have also $i^{*}\left(\mu_{\sigma}\right)=\beta_{0}$. Finally we get $i^{*}\left(\Omega_{\mathfrak{q}_{\sigma}}\right)(Y)=$ $\left(\beta_{0}, Y\right), Y \in \mathfrak{k}_{\sigma}$.

The equivariant form $\mathrm{P}^{K_{\sigma}}$ can be taken with (compact) support in $\mathcal{U}$, and we have

$$
\begin{aligned}
\left(\int_{\mathcal{Y}_{\sigma}} e^{\imath \Omega_{\mathfrak{\ell}_{\sigma}}} \mathrm{P}^{K_{\sigma}}\right)(Y) & =\int_{K_{\sigma} \cdot \beta} i^{*}\left(e^{\imath \Omega_{\mathfrak{R}_{\sigma}}}\right)(Y) p_{*}\left(\mathrm{P}^{K_{\sigma}}\right)(Y) \\
& =e^{\imath\left(\beta_{0}, Y\right)}\left(\int_{\mathcal{Y}_{\sigma}} \mathrm{P}^{K_{\sigma}}\right)(Y) .
\end{aligned}
$$

With this equality, the Proposition is just a consequence of Proposition 3.3, Lemma 3.4, and the equality (3.15).

## 4 Second reduction: Deformation procedure

We are now going to compute the generalized function $\int_{\mathcal{Y}_{\sigma}} \mathrm{P}^{K_{\sigma}}$ by means of a deformation procedure (see Proposition 3.11 of [16] and section 2.3 of [17]).

We first recall briefly the context of our computation. Let $M$ be a semisimple orbit of the adjoint representation of a real semi-simple Lie group $G$. We have shown that $M=G . \beta$ with $\beta=\beta_{0}+\beta_{1}, \beta_{0} \in \mathfrak{k}, \beta_{1} \in \mathfrak{p}$ and $\left[\beta_{0}, \beta_{1}\right]=0$. In the last section we have denote by $\mathfrak{k}_{\sigma}$ the subalgebra of $\mathfrak{k}$ fixed by the adjoint action of $\beta_{0}$. We have also defined a symplectic $K_{\sigma}$-manifold $\mathcal{Y}_{\sigma}$ which is an open neighbourhood of $K_{\sigma} \cdot \beta$ in $M \cap\left(\mathfrak{k}_{\sigma} \oplus \mathfrak{p}\right)$. The action of $K_{\sigma}$ is Hamiltonian and the moment map $\mu_{\sigma}: \mathcal{Y}_{\sigma} \rightarrow \mathfrak{k}_{\sigma}$ is the restriction to $\mathcal{Y}_{\sigma}$ of the orthogonal projection $\mathfrak{g} \rightarrow \mathfrak{k}_{\sigma}$.

The equivariant form $\mathrm{P}^{K_{\sigma}}$ is supported in a (small) neighbourhood of $K_{\sigma} \cdot \beta$ in $\mathcal{Y}_{\sigma}$, and to compute it we just need to describe a $K_{\sigma}$-invariant neighbourhood of $K_{\sigma} . \beta$ in $\mathcal{Y}_{\sigma}$.

We have already remarked that the inclusion $K_{\sigma} . \beta \hookrightarrow \mathcal{Y}_{\sigma}$ is an isotropic embedding. In fact $K_{\sigma} . \beta$ is the 0 -level of the shifted ( $K_{\sigma}$-invariant) moment map $\mu_{\sigma}-\beta_{0}$. Then to describe a $K_{\sigma}$-invariant neighbourhood of $K_{\sigma} . \beta$ in $\mathcal{Y}_{\sigma}$ we can use the normal-form recipe of Marle, Guillemin and Sternberg.

First we can form, following Weinstein (see [11, 23]), the symplectic normal bundle

$$
\begin{equation*}
\mathcal{V}_{\beta_{0}}:=\mathbf{T}\left(K_{\sigma} \cdot \beta\right)^{\perp, \Omega_{\sigma}} / \mathbf{T}\left(K_{\sigma} \cdot \beta\right), \tag{4.16}
\end{equation*}
$$

where the orthogonal ( $\perp, \Omega_{\sigma}$ ) is taken relatively to the symplectic 2 -form $\Omega_{\sigma}$. Let $K_{\beta}$ be the subgroup of $K_{\sigma}$ which stabilizes $\beta$, and let $\mathfrak{k}_{\beta}$ be its Lie algebra ( $K_{\beta}$ is the subgroup of point $k \in K$ such that $k . \beta_{0}=\beta_{0}$ and $k . \beta_{1}=\beta_{1}$ ). We have

$$
\mathcal{V}_{\beta_{0}}=K_{\sigma} \times_{K_{\beta}} V_{\beta_{0}}
$$

where the vector space $V_{\beta_{0}}:=\mathbf{T}_{\beta}\left(K_{\sigma}, \beta\right)^{\perp, \Omega_{\sigma}} / \mathbf{T}_{\beta}\left(K_{\sigma} \cdot \beta\right)$ inherits a symplectic structure and an Hamiltonian action of the group $K_{\beta}$.

Lemma 4.1 The vector space $V_{\beta_{0}}$ is equal to $\left[\mathfrak{p}, \beta_{0}\right] \cong \mathfrak{p} / \mathfrak{p}_{\beta_{0}}$ and is equipped with the natural $K_{\beta}$-action. The moment map $\mu_{\beta}: V_{\beta_{0}} \rightarrow \mathfrak{k}_{\beta}$ associated to this action verifies

$$
\mu_{\beta}(y)=-\frac{1}{2} p{r_{\mathfrak{e}_{\beta}}}\left(\left[y,\left[y, \beta_{0}\right]\right]\right), \quad y \in\left[\mathfrak{p}, \beta_{0}\right]
$$

where $p r_{\mathfrak{k}_{\beta}}: \mathfrak{k}_{\sigma} \rightarrow \mathfrak{k}_{\beta}$ denotes the orthogonal projection. Moreover, $\mu_{\beta}(y)=0$ iff $y=0$.

Proof: The vector space $\mathbf{T}_{\beta} M=[\mathfrak{g}, \beta]$ carries the symplectic form $\Omega_{\beta}$ that is defined by the equation

$$
\begin{equation*}
\Omega_{\beta}([X, \beta],[Y, \beta]):=-B(\beta,[X, Y]), \quad \text { for } X, Y \in \mathfrak{g} \tag{4.17}
\end{equation*}
$$

where $B$ is the Killing form on $\mathfrak{g}$. We see from (4.17) that the symplectic orthogonal $\left[\mathfrak{k}_{\sigma}, \beta_{1}\right]^{\perp, \Omega_{\sigma}}$ of the vector space $\mathbf{T}_{\beta}\left(K_{\sigma} . \beta\right)=\left[\mathfrak{k}_{\sigma}, \beta_{1}\right]$ in $\mathbf{T}_{\beta} M$ is equal to the subspace $B$-orthogonal to $\mathfrak{k}_{\sigma}$. Then we have $V_{\beta_{0}}=\left(\mathfrak{k}_{\sigma}\right)^{\perp, B} \cap \mathbf{T}_{\beta} \mathcal{Y}_{\sigma} /\left[\mathfrak{k}_{\sigma}, \beta_{1}\right]$.

The subspace $[\mathfrak{g}, \beta]$ of $\mathfrak{g}$ is $\theta$-stable because $\operatorname{ker}(\operatorname{ad}(\beta))=\operatorname{ker}(\operatorname{ad}(\theta \beta))=$ $\operatorname{ker}\left(\operatorname{ad}\left(\beta_{0}\right)\right) \cap \operatorname{ker}\left(\operatorname{ad}\left(\beta_{1}\right)\right)$ is $\theta$-stable and $[\mathfrak{g}, \beta]=\operatorname{ker}(\operatorname{ad}(\beta))^{\perp, B}$. Hence we get

$$
\begin{align*}
\mathbf{T}_{\beta} \mathcal{Y}_{\sigma} & =[\mathfrak{g}, \beta] \cap\left(\mathfrak{k}_{\sigma} \oplus \mathfrak{p}\right) \\
& =\underbrace{[\mathfrak{g}, \beta] \cap \mathfrak{k}_{\sigma}}_{\subset \mathfrak{k}} \oplus \underbrace{\oplus \mathfrak{g}, \beta] \cap \mathfrak{p}}_{\subset \mathfrak{p}} . \tag{4.18}
\end{align*}
$$

The $\mathfrak{k}$-part of $\left(\mathfrak{k}_{\sigma}\right)^{\perp, B} \cap \mathbf{T}_{\beta} \mathcal{Y}_{\sigma}$ is reduced to $\{0\}$ because it is included in $\left(\mathfrak{k}_{\sigma}\right)^{\perp, B} \cap$ $\mathfrak{k}_{\sigma}=\{0\}$ (see (4.18)). Hence we have $\left(\mathfrak{k}_{\sigma}\right)^{\perp, B} \cap \mathbf{T}_{\beta} \mathcal{Y}_{\sigma}=[\mathfrak{g}, \beta] \cap \mathfrak{p}=\left[\mathfrak{k}, \beta_{1}\right]+\left[\mathfrak{p}, \beta_{0}\right]$ because $\mathfrak{p}$ is $B$-orthogonal to $\mathfrak{k}_{\sigma}$. Using the decomposition $\mathfrak{k}=\mathfrak{k}_{\sigma} \oplus\left[\mathfrak{k}, \beta_{0}\right]$ we can finally write $\left(\mathfrak{k}_{\sigma}\right)^{\perp, B} \cap \mathbf{T}_{\beta} \mathcal{Y}_{\sigma}=\left[\mathfrak{k}_{\sigma}, \beta_{1}\right] \oplus\left[\mathfrak{p}, \beta_{0}\right]$ (the last sum is direct because the two members are $B$-orthogonal and $B$ is positive definite on $\mathfrak{p}$ ). We proved finally that $V_{\beta_{0}}$ is equal to $\left[\mathfrak{p}, \beta_{0}\right]$. The computation of $\mu_{\beta}$ is left to the reader. For the last point, we remark that $\left(\operatorname{pr}_{\mathfrak{k} \beta}(X), \beta_{0}\right)_{\mathfrak{k}}=\left(X, \beta_{0}\right)_{\mathfrak{k}}$ for every $X \in \mathfrak{k}_{\sigma}$, because $\beta_{0} \in \mathfrak{k}_{\beta}$. It follows that $\left(\mu_{\beta}(y), \beta_{0}\right)_{\mathfrak{k}_{\sigma}}=\frac{1}{2}\left\|\left[y, \beta_{0}\right]\right\|^{2}$ for every $y \in\left[\mathfrak{p}, \beta_{0}\right]$, and this proves the last assertion.

Consider now the following symplectic manifold

$$
\begin{equation*}
\tilde{\mathcal{Y}}_{\sigma}:=\mathcal{V}_{\beta_{0}} \times \mathbf{T}\left(K_{\sigma} / K_{\beta}\right)=K_{\sigma} \times_{K_{\beta}}\left(\mathfrak{k}_{\sigma} / \mathfrak{k}_{\beta} \oplus \mathfrak{p} / \mathfrak{p}_{\beta_{0}}\right) \tag{4.19}
\end{equation*}
$$

where the tangent bundle $\mathbf{T}\left(K_{\sigma} / K_{\beta}\right)$ is here naturally identified with the cotangent bundle $\mathbf{T}^{*}\left(K_{\sigma} / K_{\beta}\right)$ through the $K_{\sigma}$-invariant scalar product on $\mathfrak{k}_{\sigma} / \mathfrak{k}_{\beta}$ coming from the scalar product on $\mathfrak{k}$ (after identification of $\mathfrak{k}_{\sigma} / \mathfrak{k}_{\beta}$ with the orthogonal complement of $\mathfrak{k}_{\beta}$ in $\mathfrak{k}_{\sigma}$ ). The action of $K_{\sigma}$ on $\tilde{\mathcal{Y}}_{\sigma}$ is Hamiltonian and the moment map $\tilde{\mu}_{\sigma}: \tilde{\mathcal{Y}}_{\sigma} \rightarrow \mathfrak{k}_{\sigma}$ is given by the equation

$$
\begin{equation*}
\tilde{\mu}_{\sigma}([k ; x, y])=\beta_{0}+k .\left(x+\mu_{\beta}(y)\right) \quad k \in K_{\sigma}, x \in \mathfrak{k}_{\sigma} / \mathfrak{k}_{\beta}, y \in \mathfrak{p} / \mathfrak{p}_{\beta_{0}} . \tag{4.20}
\end{equation*}
$$

The local normal form Theorem, applied to the moment map $\mu_{\sigma}-\beta_{0}$, (see [19] Proposition 2.5 ) tells us that there exists a $K_{\sigma}$-Hamiltonian isomorphism

$$
\Upsilon: \mathcal{U}_{1} \xrightarrow{\sim} \mathcal{U}_{2},
$$

where $\mathcal{U}_{1}$ is a $K_{\sigma}$-invariant neighbourhood of $K_{\sigma} . \beta$ in $\mathcal{Y}_{\sigma}$, and $\mathcal{U}_{2}$ is a $K_{\sigma^{-}}$ invariant neighbourhood of $K_{\sigma} / K_{\beta}$ in $\tilde{\mathcal{Y}}_{\sigma}$. Furthermore the isomorphism, when restricted to $K_{\sigma} . \beta$, corresponds to the natural isomorphism $K_{\sigma} . \beta \xrightarrow{\sim} K_{\sigma} / K_{\beta}$.

Let $\tilde{\mathcal{H}}_{\sigma}$ be the Hamiltonian vector field on $\tilde{\mathcal{Y}}_{\sigma}$ of $\frac{1}{2}\left\|\tilde{\mu}_{\sigma}\right\|^{2}$. For every $[k ; x, y] \in$ $\tilde{\mathcal{Y}}_{\sigma}$ we have

$$
\begin{align*}
\left.\tilde{\mathcal{H}}_{\sigma}\right|_{[k ; x, y]} & =\left.\left(k \cdot \tilde{\mu}_{\sigma}([1 ; x, y])\right)_{\tilde{\mathcal{H}}_{\sigma}}\right|_{[k ; x, y]} \\
& =\left.\frac{d}{d t}\right|_{t=0}\left[k \cdot e^{-t X} ; x, y\right], \quad \text { with } \quad X=\beta_{0}+x+\mu_{\beta}(y) \\
& =-x_{K_{\sigma}, r}(k)-\left[\beta_{0}, y\right]-\left[\mu_{\beta}(y), x+y\right] . \tag{4.21}
\end{align*}
$$

In the last equality, $x_{K_{\sigma}, r}$ is the vector field generated by the right action of $\left\{e^{t x}, t \in \mathbb{R}\right\}$ on $K_{\sigma}$.

Remark now that the action of $K_{\beta}$ on $V_{\beta_{0}}$ comes from a $K_{\sigma}$-action. Hence the vector bundle $\tilde{\mathcal{Y}}_{\sigma} \rightarrow \mathbf{T}\left(K_{\sigma} / K_{\beta}\right)$ is trivial through the isomorphism

$$
\begin{align*}
\Xi: \tilde{\mathcal{Y}}_{\sigma} & \xrightarrow{\sim} \mathbf{T}\left(K_{\sigma} / K_{\beta}\right) \times V_{\beta_{0}}  \tag{4.22}\\
{[k ; x, y] } & \longmapsto([k, x], k \cdot y) .
\end{align*}
$$

We have a natural $K_{\beta}$-invariant Euclidean structure on $\mathfrak{k}_{\sigma} / \mathfrak{k}_{\beta} \oplus \mathfrak{p} / \mathfrak{p}_{\beta_{0}}$ coming from the Euclidean structure of $\mathfrak{g}$ and we denote by $(\cdot, \cdot)_{\mathbf{T}_{\left(K_{\sigma} / K_{\beta}\right)}}$ the induced $K_{\sigma}$-invariant Riemannian structure on $\mathbf{T}\left(K_{\sigma} / K_{\beta}\right)$ (see equation (3.13)).

Definition 4.2 Let $\theta_{\beta_{0}}$ be the $K_{\sigma}$-invariant 1-form on $V_{\beta_{0}}$ given by $\left.\theta_{\beta_{0}}\right|_{y}=$ $-\left(\left[\beta_{0}, y\right], d y\right)_{\mathfrak{p}}, y \in V_{\beta_{0}}$, and let $\gamma_{\sigma}$ be the $K_{\sigma}$-invariant 1 -form on $\mathbf{T}\left(K_{\sigma} / K_{\beta}\right)$ defined by the equation: $\left.\gamma_{\sigma}\right|_{[k ; x, y]}=-\left(x_{K_{\sigma}, r}(k), \cdot\right)_{\mathbf{T}_{\left(K_{\sigma} / K_{\beta}\right)}}, \quad[k ; x] \in \mathbf{T}\left(K_{\sigma} / K_{\beta}\right)$. We will denote by $\tilde{\lambda}_{\sigma}$ the $K_{\sigma}$-invariant 1-form on $\tilde{\mathcal{Y}}_{\sigma}$ defined below

$$
\tilde{\lambda}_{\sigma}=\Xi^{*}\left(\gamma_{\sigma}+\theta_{\beta_{0}}\right)
$$

We are going to prove that $\tilde{\lambda}_{\sigma}$ and $\lambda_{\sigma}$ define (in cohomology) the same generalized equivariant form in the neighbourhood of $K_{\sigma} / K_{\beta}$ (through the isomorphism $\Upsilon)$. First we compute the function $\left(\Phi_{\tilde{\lambda}_{\sigma}}, \tilde{\mu}_{\sigma}\right)$ near $K_{\sigma} / K_{\beta}$. We have

$$
\begin{align*}
\left(\Phi_{\tilde{\lambda}_{\sigma}}, \tilde{\mu}_{\sigma}\right)([k ; x, y]) & =\gamma_{\sigma}\left(X_{\mathbf{T}\left(K_{\sigma} / K_{\beta}\right)}\right)([k, x])+\theta_{\beta_{0}}\left(X_{V_{\beta_{0}}}\right)(k \cdot y) \quad \text { with } \quad X=\tilde{\mu}_{\sigma}([k ; x, y]) \\
& =\|x\|_{\mathfrak{k}}^{2}+\left(\left[\beta_{0}, k \cdot y\right],\left[\tilde{\mu}_{\sigma}([k ; x, y]), k \cdot y\right]\right)_{\mathfrak{p}} \\
& =\|x\|_{\mathfrak{k}}^{2}+\left\|\left[\beta_{0}, y\right]\right\|_{\mathfrak{p}}^{2}+O\left(\|x, y\|^{3}\right) \tag{4.23}
\end{align*}
$$

In the last equality we just use the fact that $\tilde{\mu}_{\sigma}([k ; x, y])=\beta_{0}+O(\|x, y\|)$, then $\left(\left[\beta_{0}, k . y\right],\left[\beta_{0}+O(\|x, y\|), k . y\right]\right)_{\mathfrak{p}}=\left\|\left[\beta_{0}, k . y\right]\right\|_{\mathfrak{p}}^{2}+O\left(\|x, y\|^{3}\right)$ and the $K_{\sigma}$-invariance of $\beta_{0}$ imposes $\left\|\left[\beta_{0}, k . y\right]\right\|_{\mathfrak{p}}^{2}=\left\|\left[\beta_{0}, y\right]\right\|_{\mathfrak{p}}^{2}$.

From the equality (4.23), we know that there exists a $K_{\sigma}$-invariant neighbourhood $\tilde{\mathcal{V}}$ of the 0 -section in $\tilde{\mathcal{Y}}_{\sigma}$ such that the function $\left(\Phi_{\tilde{\lambda}_{\sigma}}, \tilde{\mu}_{\sigma}\right)$ is strictly positive on $\tilde{\mathcal{V}} \backslash\left\{K_{\sigma} / K_{\beta}\right\}$ (Note that the vector $\left[\beta_{0}, y\right]$ is non-zero for each nonzero vector $\left.y \in \mathfrak{p} / \mathfrak{p}_{\beta_{0}}\right)$. In particular we get $\left\{\Phi_{\tilde{\lambda}_{\sigma}}=0\right\} \cap \tilde{\mathcal{V}}=K_{\sigma} / K_{\beta}$.

Let $\tilde{\chi}_{\sigma} \in \mathcal{C}_{c p t}^{\infty}\left(\tilde{\mathcal{Y}}_{\sigma}\right)$ be a function supported on $\tilde{\mathcal{V}} \cap \mathcal{U}_{2}$, and equal to 1 in a neighbourhood of $K_{\sigma} / K_{\beta}$. With this function we define the equivariant form

$$
\widetilde{\mathrm{P}}^{K_{\sigma}}=\tilde{\chi}_{\sigma}+d \tilde{\chi}_{\sigma}\left(\int_{0}^{\infty} \imath e^{-\imath t \mathcal{D} \tilde{\lambda}_{\sigma}} d t\right) \tilde{\lambda}_{\sigma} \in \mathcal{A}_{K_{\sigma}, c p t}^{-\infty}\left(\tilde{\mathcal{Y}}_{\sigma}\right)
$$

The main point of our deformation procedure is the following

Lemma 4.3 The generalized $K_{\sigma}$-equivariant forms $\mathrm{P}^{K_{\sigma}}$, and $\Upsilon^{*}\left(\widetilde{\mathrm{P}}^{K_{\sigma}}\right)$, define the same cohomology class in $\mathcal{H}_{K_{\sigma}, \text { cpt }}^{-\infty}\left(\mathcal{Y}_{\sigma}\right)$. In particular we have the equality

$$
\int_{\mathcal{Y}_{\sigma}} \mathrm{P}^{K_{\sigma}}=\int_{\tilde{\mathcal{Y}}_{\sigma}} \widetilde{\mathrm{P}}^{K_{\sigma}}
$$

of $K_{\sigma}$-invariant tempered generalized functions on $\mathfrak{k}_{\sigma}$.
Proof: This is a consequence of Proposition 3.11 of [16], with the function $f:=\mu_{\sigma}$ on the manifold $\mathcal{V}:=\Upsilon^{-1}\left(\tilde{\mathcal{V}} \cap \mathcal{U}_{2}\right)$, with the 1 -forms $\lambda_{\sigma}$ and $\Upsilon^{*}\left(\tilde{\lambda}_{\sigma}\right)$. All the point is that the functions $\left(\Phi_{\Upsilon^{*}\left(\tilde{\lambda}_{\sigma}\right)}, \mu_{\sigma}\right)=\left(\Phi_{\tilde{\lambda}_{\sigma}}, \tilde{\mu}_{\sigma}\right) \circ \Upsilon$ and $\left(\Phi_{\lambda_{\sigma}}, \mu_{\sigma}\right)=$ $\left\|\mathcal{H}_{\sigma}\right\|^{2}$ are strictly positive on $\mathcal{V} \backslash\left\{K_{\sigma} . \beta\right\}$. This fact implies that the 1 -forms $\lambda_{\sigma}$ and $\Upsilon^{*}\left(\tilde{\lambda}_{\sigma}\right)$ define the same equivariant forms in cohomology.

Consider now the $K_{\sigma}$-equivariant form $e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}}$ on $\tilde{\mathcal{Y}}_{\sigma}$. First of all we note that the 1 -form $\tilde{\lambda}_{\sigma}$ is linear in the variable $x \in \mathfrak{k}_{\sigma} / \mathfrak{k}_{\beta}$, and quadratic in the variable $y \in \mathfrak{p} / \mathfrak{p}_{\beta_{0}}$. Consider the corresponding map $\Phi_{\tilde{\lambda}_{\sigma}}: \tilde{\mathcal{Y}}_{\sigma} \rightarrow \mathfrak{k}_{\sigma}$. For every $Z \in \mathfrak{k}_{\sigma},[k ;, x, y] \in \tilde{\mathcal{Y}}_{\sigma}$ we have

$$
\begin{aligned}
\left(\Phi_{\tilde{\lambda}_{\sigma}}, Z\right)_{\mathfrak{k}}([k ; x, y]) & =\left(x, p{\left.r_{\mathfrak{k}_{\sigma} / \mathfrak{k}_{\beta}}\left(k^{-1} \cdot Z\right)\right)_{\mathfrak{k}}+\left(\left[\beta_{0}, k \cdot y\right],[Z, k \cdot y]\right)_{\mathfrak{p}}}\right. \\
& =\left(x, k^{-1} \cdot Z\right)_{\mathfrak{k}}+\left(\left[\left[\beta_{0}, k \cdot y\right], k \cdot y\right], Z\right)_{\mathfrak{k}}[1] \\
& =\left(k\left(x+\left[\left[\beta_{0}, y\right], y\right]\right), Z\right)_{\mathfrak{k}} .
\end{aligned}
$$

For the point [1]: we first use the fact that $\left(X, p r_{\mathfrak{E}_{\sigma} / \mathfrak{k}_{\beta}}\left(X^{\prime}\right)\right)_{\mathfrak{k}}=\left(p r_{\mathfrak{k}_{\sigma} / \mathfrak{k}_{\beta}}(X), X^{\prime}\right)_{\mathfrak{k}}$, for $X, X^{\prime} \in \mathfrak{k}_{\sigma}$, and we use also the identity $(a,[X, b])_{\mathfrak{p}}=([a, b], X)_{\mathfrak{k}}$, for $a, b \in \mathfrak{p}$, and $X \in \mathfrak{k}$. The point [2] follows from the $K_{\sigma}$-invariance of $\beta_{0}$. We have found the following expression: $\Phi_{\tilde{\lambda}_{\sigma}}([k ; x, y])=k\left(x+\left[\left[\beta_{0}, y\right], y\right]\right),[k ; x, y] \in \tilde{\mathcal{Y}}_{\sigma}$.

Consider, for every $t>0$, the following $K_{\sigma}$-equivariant contraction

$$
\begin{array}{cccc}
\delta_{t}: & \tilde{\mathcal{Y}}_{\sigma} & \longrightarrow & \tilde{\mathcal{Y}}_{\sigma}  \tag{4.24}\\
& {[k ; x, y]} & \longmapsto & {\left[k, \frac{x}{t}, \frac{y}{\sqrt{t}}\right] .}
\end{array}
$$

We have $t \delta_{t}^{*}\left(\tilde{\lambda}_{\sigma}\right)=\tilde{\lambda}_{\sigma}$ and $t \delta_{t}^{*}\left(\Phi_{\tilde{\lambda}_{\sigma}}\right)=\Phi_{\tilde{\lambda}_{\sigma}}$ for every $t>0$. This gives

$$
\delta_{t}^{*}\left(e^{-\imath t \mathcal{D} \tilde{\lambda}_{\sigma}}\right)=e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}} \quad \text { in } \mathcal{A}_{K_{\sigma}}^{\infty}\left(\tilde{\mathcal{Y}}_{\sigma}\right),
$$

for every $t>0$.
For every $f \in \mathcal{C}_{r d}^{\infty}\left(\mathfrak{k}_{\sigma}\right)$, the differential form $<e^{-\imath \tilde{\mathcal{D}}_{\sigma}(Y)}, f(Y) d Y>_{\mathfrak{k}_{\sigma}}$ is the product of the differential form $e^{-\imath d \tilde{\lambda}_{\sigma}}$ which has a polynomial dependence in the direction of the fibers, with the function $\widehat{f}\left(-\Phi_{\tilde{\lambda}_{\sigma}}\right)$ which is rapidly decreasing along the fibers. The differential form $<e^{-\imath \mathcal{D}} \tilde{\lambda}_{\sigma}(Y), f(Y) d Y>\mathfrak{p}_{\sigma}$ is then integrable on $\tilde{\mathcal{Y}}_{\sigma}$. We denote by $\int_{\tilde{\mathcal{Y}}_{\sigma}} e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}}$ the tempered $K_{\sigma}$-invariant function on $\mathfrak{k}_{\sigma}$ defined by
$<\left(\int_{\tilde{\mathcal{Y}}_{\sigma}} e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}}\right)(Y), f(Y) d Y>_{\mathfrak{k}_{\sigma}}:=\int_{\tilde{\mathcal{H}}_{\sigma}}<e^{-\imath \tilde{\mathcal{\lambda}}_{\sigma}(Y)}, f(Y) d Y>_{\mathfrak{k}_{\sigma}} \quad$ for $\quad f \in \mathcal{C}_{r d}^{\infty}\left(\mathfrak{k}_{\sigma}\right)$.

Proposition 4.4 We have the following equality

$$
\int_{\tilde{\mathcal{H}}_{\sigma}} \widetilde{\mathrm{P}}^{K_{\sigma}}=\int_{\tilde{\mathcal{Y}}_{\sigma}} e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}}
$$

of $K_{\sigma}$-invariant tempered generalized functions on $\mathfrak{k}_{\sigma}$.
Proof: The generalized equivariant form $\widetilde{\mathrm{P}}^{K_{\sigma}}$ is the limit of the smooth equivariant form

$$
\begin{aligned}
\widetilde{\mathrm{P}}_{a}^{K_{\sigma}} & :=\tilde{\chi}_{\sigma}+d \tilde{\chi}_{\sigma}\left(\int_{0}^{a} l e^{-\imath t} \tilde{\mathcal{\lambda}}_{\sigma} d t\right) \tilde{\lambda}_{\sigma} \\
& =\tilde{\chi}_{\sigma} e^{-\imath a \mathcal{D} \tilde{\lambda}_{\sigma}}+\mathcal{D}\left(\tilde{\chi}_{\sigma}\left(\int_{0}^{a} t e^{-\imath t \mathcal{D} \tilde{\lambda}_{\sigma}} d t\right) \tilde{\lambda}_{\sigma}\right),
\end{aligned}
$$

when $a \rightarrow \infty$. Note that the equivariant form $\tilde{\chi}_{\sigma}\left(\int_{0}^{a}{ }^{\imath} e^{-\imath t \mathcal{D}} \tilde{\lambda}_{\sigma} d t\right) \tilde{\lambda}_{\sigma}$ is with compact support on $\tilde{\mathcal{Y}}_{\sigma}$, then after integration on $\tilde{\mathcal{Y}}_{\sigma}$ we get

$$
\int_{\tilde{\mathcal{V}}_{\sigma}} \widetilde{\mathrm{P}}_{a}^{K_{\sigma}}=\int_{\tilde{\mathcal{V}}_{\sigma}} \tilde{\chi}_{\sigma} e^{-\imath a \mathcal{D} \tilde{\lambda}_{\sigma}}=\int_{\tilde{\mathcal{Y}}_{\sigma}} \tilde{\chi}_{\sigma} \circ \delta_{a} e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}}
$$

where we make the change of variable $\delta_{a}$ in the last equality. From this, we see that $\int_{\tilde{\mathcal{Y}}_{\sigma}} \widetilde{\mathrm{P}}^{K_{\sigma}}=\lim _{a \rightarrow \infty} \int_{\tilde{\mathcal{Y}}_{\sigma}} \tilde{\chi}_{\sigma} \circ \delta_{a} e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}}$. The function $\tilde{\chi}_{\sigma}$ is equal to 1 in a neighbourhood of the 0 -section, then $\lim _{a \rightarrow \infty} \tilde{\chi}_{\sigma} \circ \delta_{a}=1$, and we conclude with the 'Lebesgue' convergence argument.

## 5 Computation of $\int_{\tilde{\mathcal{V}}_{\sigma}} e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}}$

Note that the vector field on $\tilde{\mathcal{Y}}_{\sigma}$ generated by $\beta_{0}$ is identically equal to zero on $\mathbf{T}\left(K_{\sigma} / K_{\beta}\right)$ and on $\mathcal{V}_{\beta_{0}}$ we have $\left.\beta_{0} \mathcal{\nu}_{\beta_{0}}\right|_{[k, y]}=-\left[\beta_{0}, y\right]$. With the $K_{\sigma}$-equivariant form

$$
-\imath \mathcal{D} \tilde{\lambda}_{\sigma}\left(X+\imath s \beta_{0}\right)=-\imath \mathcal{D} \tilde{\lambda}_{\sigma}(X)-s\left\|\left[\beta_{0}, y\right]\right\|^{2}
$$

depending of the parameter $s>0$, we can compute the generalized function $\int_{\tilde{\mathcal{J}}_{\sigma}} e^{-\imath \mathcal{D} \lambda_{\sigma}}$ as a limit of the generalized functions $\Lambda_{s}$ on $\mathfrak{k}_{\sigma}$ defined by the equation

$$
\Lambda_{s}(X)=\int_{\tilde{\mathcal{Y}}_{\sigma}} e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}\left(X+\imath s \beta_{0}\right)}, \quad s>0
$$

The integration is well defined because $\left.e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}\left(X+\imath s \beta_{0}\right)}\right|_{[k ; x, y]}=\left.e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}(X)}\right|_{[k ; x, y]} e^{-s\left\|\left[\beta_{0}, y\right]\right\|^{2}}$ and the function $[k ; x, y] \rightarrow e^{-s\left\|\left[\beta_{0}, y\right]\right\|^{2}}$ is bounded on $\tilde{\mathcal{Y}}_{\sigma}$. To compute $\Lambda_{s}$, first we can integrate $e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}\left(X+\imath s \beta_{o}\right)}$ on the fibers of the projection $\pi_{1}: \tilde{\mathcal{Y}}_{\sigma} \rightarrow$ $\mathbf{T}\left(K_{\sigma} / K_{\beta}\right)$. The term $e^{-s\| \| \beta_{0}, y \|^{2}}$ insures that the equivariant form $\left(\pi_{1}\right)_{*}\left(e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}\left(X+\imath s \beta_{o}\right)}\right)$ is smooth, and we have

$$
\left(\pi_{1}\right)_{*}\left(e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}\left(X+\imath s \beta_{0}\right)}\right)=e^{-\imath \mathcal{D} \gamma_{\sigma}(X)}\left(\pi_{1}\right)_{*} \circ \Xi^{*}\left(e^{-\imath \mathcal{D} \theta_{\beta_{0}}\left(X+\imath s \beta_{0}\right)}\right) .
$$

The map $\Xi$ is a trivialization of the bundle $\pi_{1}: \tilde{\mathcal{Y}}_{\sigma} \rightarrow \mathbf{T}\left(K_{\sigma} / K_{\beta}\right)$, then the equivariant form $\left(\pi_{1}\right)_{*} \circ \Xi^{*}\left(e^{-\imath \mathcal{D} \theta_{\beta_{0}}\left(X+\imath s \beta_{0}\right)}\right) \in \mathcal{A}_{K_{\sigma}}^{\infty}\left(\mathbf{T}\left(K_{\sigma} / K_{\beta}\right)\right)$ is equal to the function

$$
\begin{equation*}
\int_{V_{\beta_{0}}} e^{-\imath \mathcal{D} \theta_{\beta_{0}}\left(X+\imath s \beta_{0}\right)}, \quad X \in \mathfrak{k}_{\sigma} . \tag{5.25}
\end{equation*}
$$

The equivariant Euler form $\operatorname{Eul}_{o}\left(\mathfrak{p} / \mathfrak{p}_{\beta_{0}}\right)$ of the oriented $K_{\sigma}$-bundle $V_{\beta_{0}}=\mathfrak{p} / \mathfrak{p}_{\beta_{0}} \rightarrow$ $\{0\}$ is equal to the a $K_{\sigma}$-invariant polynomial $X \in \mathfrak{k}_{\sigma} \rightarrow \Pi_{\mathfrak{p} / \mathfrak{p}_{0}}\left(\frac{-1}{2 \pi} X\right.$ ) (for $\Pi_{\mathfrak{p} / \mathfrak{p}_{\mathcal{p}_{0}}}$ see the Definition 1.3).

The integrals like (5.25) have been studied in section 4 of [16], where we prove in particular that

$$
\begin{equation*}
\int_{V_{\beta_{0}}} e^{-\imath \mathcal{D} \theta_{\beta_{0}}\left(X+\imath s \beta_{0}\right)}=\operatorname{Eul}_{o}\left(\mathfrak{p} / \mathfrak{p}_{\beta_{0}}\right)\left(X+\imath s \beta_{0}\right)^{-1} \tag{5.26}
\end{equation*}
$$

for every $X \in \mathfrak{F}_{\sigma}, s>0$. Hence, we have the following
Lemma 5.1 The generalized function $\int_{\tilde{\mathcal{Y}}_{\sigma}} e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}}$ is the limit of the generalized functions

$$
\Lambda_{s}(X)=\frac{1}{\operatorname{Eul}_{o}\left(\mathfrak{p} / \mathfrak{p}_{\beta_{0}}\right)\left(X+\imath s \beta_{0}\right)} \int_{\mathbf{T}\left(K_{\sigma} / K_{\beta}\right)} e^{-\imath \mathcal{D} \gamma_{\sigma}(X)}, \quad s>0,
$$

when $s \rightarrow 0^{+}$.
Then it remains to compute the generalized function $\int_{\mathbf{T}\left(K_{\sigma} / K_{\beta}\right)} e^{-\imath \mathcal{D} \gamma_{\sigma}(X)}, X \in$ $\mathfrak{k}_{\sigma}$.

Proposition 5.2 Let L be a compact Lie group and H a closed subgroup, with corresponding Lie algebras $\mathfrak{l}$, and $\mathfrak{h}$. We denote by $\lambda_{L / H}$ the (L-invariant) Liouville 1-form on $\mathbf{T}^{*}(L / H)$. For every $f \in \mathcal{C}_{r d}^{\infty}(\mathfrak{r})$ the differential form $<$ $e^{\imath \mathcal{D} \lambda_{L / H}(X)}, f(X) d X>_{\boldsymbol{r}}$ is integrable on $\mathbf{T}^{*}(L / H)$ and

$$
\int_{\mathbf{T}^{*}(L / H)}<e^{\imath \mathcal{D} \lambda_{L / H}(X)}, f(X) d X>_{\mathfrak{l}}=\operatorname{cte}<\mathbf{1}_{\mathfrak{h}}(Y), \bar{f}^{L}(Y) d Y>_{\mathfrak{h}},
$$

with cte $=(2 \imath \pi)^{\operatorname{dim}(L / H)} \frac{\operatorname{vol}(L, d X)}{\operatorname{vol}(H, d Y)}$, and $\mathbf{1}_{\mathfrak{h}}$ is the constant function equal to 1 on $\mathfrak{h}$.

Remark 5.3 A similar computation has been done by Witten in [24] (See equation (2.42)).

Proof: First we parameterize the Liouville 1-form $\lambda_{L / H} \in \mathcal{A}^{1}\left(\mathbf{T}^{*}(L / H)\right)$. Let $\mathfrak{r}$ be a $H$-invariant complement of $\mathfrak{h}$ in $\mathfrak{l}: \mathfrak{l}=\mathfrak{h} \oplus \mathfrak{r}$. Then the dual vector space $\mathfrak{r}^{*}$ is naturally identified with the orthogonal (for the duality) $\mathfrak{h}^{\perp}$ of $\mathfrak{h}$ in $\mathfrak{l}^{*}$. The tangent bundle $\mathbf{T}(L / H)$ (resp. the cotangent bundle $\mathbf{T}^{*}(L / H)$ ) is naturally identified with the bundle $L \times_{H} \mathfrak{r}$ over $L / H$ (resp. the bundle $\left.L \times_{H} \mathfrak{r}^{*}\right)$. Let $E^{i}, i=1, \cdots, \operatorname{dim}(G / H)$ be a basis of $\mathfrak{r}$, and we denote by $E_{i}$ the corresponding dual basis of $\mathfrak{r}^{*}$. For every $X \in \mathfrak{l}$, let $X_{L, r}$ the vector field
on $L$ generated by the right action of $L$ on itself: $\left.X_{L, r}\right|_{l}=\left.\frac{d}{d t}\right|_{t=0} l . e^{t X}, l \in L$. Let $\omega_{i}, i=1, \cdots, \operatorname{dim}(G / H)$ be the (left) $L$-invariant 1 forms on $L$ such that $\omega_{i}\left(X_{L, r}\right)$ is a constant function on $L$ equal to $\left\langle E_{i}, X\right\rangle$ for every $X \in \mathfrak{l}$. The space $\left(\mathcal{A}^{1}(L)^{L} \otimes \mathfrak{r}\right)_{H \text {-basic }}$ is a subspace of the space of (left) $L$-invariant one form on $L \times_{H} \mathfrak{r}^{*}$, where the $H$-invariant are taken with respect to the action of $H$ by right multiplication on $L$, and adjoint action on $\mathfrak{r}$; the $L$-invariant are taken with respect to the action of $L$ by left multiplication on itself. The 1-form $\lambda_{L / H} \in\left(\mathcal{A}^{1}(L)^{L} \otimes \mathfrak{r}\right)_{H \text {-basic }}$ is defined by the equation

$$
\begin{equation*}
\left.\lambda_{L / H}\right|_{[l, \xi]}:=\sum_{i=1}^{\operatorname{dim}(\mathfrak{r})}\left\langle\xi, E^{i}\right\rangle \omega_{i} \mid l, \quad[l, \xi] \in L \times_{H} \mathfrak{r}^{*} . \tag{5.27}
\end{equation*}
$$

A straightforward computation gives $\left.\mathcal{D} \lambda_{L / H}(X)\right|_{[l, \xi]}=\Omega_{L / H}+\langle l . \xi, X\rangle, \quad[l, \xi] \in$ $L \times_{H} \mathfrak{r}^{*}, X \in \mathfrak{l}$, where $\Omega_{L / H}=d \lambda_{L / H}=\sum_{i=1}^{k} d E^{i} \wedge \omega_{i}+E^{i} d \omega_{i}$ is the symplectic two form on $L \times_{H} \mathfrak{r}^{*} \cong \mathbf{T}^{*}(L / H)$. The corresponding Liouville volume form $\frac{\Omega_{L / H}^{k}}{k!}$ is equal to $\Pi_{i=1}^{k} d E^{i} \wedge \omega_{i}$. Then, for every $L$-invariant function $f \in \mathcal{C}_{r d}^{\infty}(\mathfrak{l})$ we have

$$
\begin{align*}
\int_{\mathbf{T}^{*}(L / H)}<e^{\imath D \lambda_{L / H}(X)}, f(X) d X>_{\imath} & =(\imath)^{k} \int_{L \times_{H} \tau^{*}} \frac{\Omega_{L / H}^{k}}{k!} \widehat{f}(-l . \xi) \\
& =(\imath)^{k} \int_{L / H} \Pi_{i} \omega_{i} \int_{\text {Fiber }} \widehat{f}(-l . \xi) \Pi_{i} d E^{i} \tag{2}
\end{align*}
$$

In [1], the function $\widehat{f} \in \mathcal{C}_{r d}^{\infty}\left(\mathfrak{l}^{*}\right)$ is the Fourier transform of $f$ relatively to the measure $d X$, and $k=\operatorname{dim}(L / H)$. In [2], we have decomposed $\Pi_{i=1}^{k} d E^{i} \wedge \omega_{i}$ in $\Pi_{i} \omega_{i} \wedge \Pi_{i} d E^{i}$, and the morphism $\int_{\text {Fiber }}: \mathcal{A}_{r d}^{*}\left(L \times_{H} \mathfrak{r}^{*}\right) \rightarrow \mathcal{A}^{*}(L / H)$ is the morphism of integration along the fiber of $L \times_{H} \mathfrak{r}^{*} \rightarrow L / H$.

The $L$-invariance of $f$ imposes that $[l] \rightarrow \int_{\text {Fiber }} \widehat{f}(-l . \xi) \Pi_{i} d E^{i}$ is constant on $L / H$, and is equal to $\int_{\mathbf{v}^{*}} \widehat{f}(-\xi) d \xi$, where $d \xi$ is the Lebesgue measure on $\mathfrak{r}^{*}$ compatible with $\Pi_{i} d E^{i}$. The double Fourier integral gives

$$
\int_{\mathfrak{r}^{*}} \widehat{f}(-\xi) d \xi=(2 \pi)^{k} \int_{\mathfrak{h}} f(Y) d Y
$$

where $\frac{d X}{d Y}$ is the Lebesgue measure on $\mathfrak{r}$ dual to $d \xi$. Finally, we have proved that

$$
\int_{\mathbf{T}^{*}(L / H)}<e^{\imath \mathcal{D} \lambda_{L / H}(X)}, f(X) d X>_{\mathfrak{l}}=\left.(2 \imath \pi)^{k} \operatorname{vol}\left(L / H, \Pi_{i} \omega_{i}\right) \int_{\mathfrak{h}} f\right|_{\mathfrak{h}}(Y) d Y .
$$

$\operatorname{But} \operatorname{vol}\left(L / H, \Pi_{i} \omega_{i}\right)=\frac{\operatorname{vol}(L, d X)}{\operatorname{vol}(H, d Y)}$, and Proposition is then proved.
We come back now at the previous situation. We verify that the 1-form $-\gamma_{\sigma}$ on $\mathbf{T}\left(K_{\sigma} / K_{\beta}\right)$ corresponds to the Liouville 1-form on $\mathbf{T}^{*}\left(K_{\sigma} / K_{\beta}\right)$, through the identification $\mathbf{T}^{*}\left(K_{\sigma} / K_{\beta}\right) \cong \mathbf{T}\left(K_{\sigma} / K_{\beta}\right)$.

The function defined over $\mathfrak{k}_{\sigma}, X \rightarrow \operatorname{Eul}_{o}\left(\mathfrak{p} / \mathfrak{p}_{\beta_{0}}\right)\left(X+\imath s \beta_{0}\right)^{-1}$, defines, when $s \rightarrow 0^{+}$, a generalized function in $\mathcal{C}^{-\infty}(V)$ on each vector subspace $V \subset \mathfrak{k}_{\sigma}$ that contains $\beta_{0}$. We denote by $\operatorname{Eul}_{\beta_{0}}^{-1}\left(\mathfrak{p} / \mathfrak{p}_{\beta_{0}}\right.$ ) this generalized function (whatever the vector subspace $V$ is).

We can now state the Theorem.
Theorem 5.4 Let $M$ be a closed orbit in $\mathfrak{g}$. There exists a unique $\left(\beta_{0}, \beta_{1}\right) \in$ $\mathfrak{t}_{+} \times \mathfrak{p}$ with $\left[\beta_{0}, \beta_{1}\right]=0$ such that $M=G .\left(\beta_{0}+\beta_{1}\right)$. Let $K_{\beta}$ be the stabilizer of $\beta:=\beta_{0}+\beta_{1}$ in $K$, and let $\mathfrak{k}_{\beta}$ be its Lie algebra. The generalized function $\operatorname{Eul}_{\beta_{0}}^{-1}\left(\mathfrak{p} / \mathfrak{p}_{\beta_{0}}\right) \in \mathcal{C}^{-\infty}\left(\mathfrak{k}_{\beta_{0}}\right)^{K_{\beta_{0}}}$ admits a restriction to $\mathfrak{k}_{\beta}$, and for every function $f \in \mathcal{C}_{r d}^{\infty}(\mathfrak{k})^{K}$ we have
$<\left.F_{M}\right|_{\mathfrak{e}}(X), f(X) d X>_{\mathfrak{k}}=\operatorname{cte}<\operatorname{Eul}_{\beta_{0}}^{-1}\left(\mathfrak{p} / \mathfrak{p}_{\beta_{0}}\right)(Z),\left.e^{\imath\left(\beta_{0}, Z\right)} f\right|_{\mathfrak{k}_{\beta}}(Z) \Pi_{\mathfrak{k} / \mathfrak{k}_{\beta_{0}}}(Z) d Z>_{\mathfrak{k}_{\beta}}$, with cte $=(-2 \pi)^{\operatorname{dim}\left(K / K_{\beta_{0}}\right) / 2}(2 \pi \imath)^{\operatorname{dim}\left(K_{\beta_{0}} / K_{\beta}\right)} \frac{\operatorname{vol}(K, d X)}{\operatorname{vol}\left(K_{\beta}, d Z\right)}$.

Proof: Proposition 5.2 and Lemma 5.1 give

$$
<\Lambda_{s}(X), f(X) d X>_{\mathfrak{k}_{\sigma}}=\operatorname{cte}<\frac{1}{\operatorname{Eul}_{o}\left(\mathfrak{p} / \mathfrak{p}_{\beta_{0}}\right)\left(Y+\imath s \beta_{0}\right)},\left.f\right|_{\mathfrak{k}_{\beta}}(Y) d Y>_{\mathfrak{k}_{\beta}}
$$

for every function $f \in \mathcal{C}_{r d}^{\infty}\left(\mathfrak{k}_{\sigma}\right)$ that is $K_{\sigma}$-invariant, and with cte $=(2 \imath \pi)^{\operatorname{dim}\left(\mathfrak{k}_{\sigma} / \mathfrak{k}_{\beta}\right)} \frac{\operatorname{vol}\left(K_{\sigma}, d X\right)}{\operatorname{vol}\left(K_{\beta}, d Y\right)}$. After taking the limit $s \rightarrow 0^{+}$, we get from Lemma 5.1

$$
<\left(\int_{\tilde{\mathcal{Y}}_{\sigma}} e^{-\imath \mathcal{D} \tilde{\lambda}_{\sigma}}\right)(X), f(X) d X>_{\mathfrak{k}_{\sigma}}=\operatorname{cte}<\operatorname{Eul}_{\beta_{0}}^{-1}\left(\mathfrak{p} / \mathfrak{p}_{\beta_{0}}\right)(Y),\left.f\right|_{\mathfrak{k}_{\beta}}(Y) d Y>_{\mathfrak{k}_{\beta}}
$$

Now Proposition 3.5, Lemma 4.3, and Proposition 4.4 used with this last equality complete the proof.
