# Computing the torsion of the $p$-ramified module 

Frédéric PITOUN and Firmin VARESCON


#### Abstract

We fix a prime number $p$ and $K$ a number field, we denote by $M$ the maximal abelian $p$-extension of $K$ unramified outside $p$. The aim of this paper is to study the $\mathbb{Z}_{p}$-module $\mathfrak{X}=\operatorname{Gal}(M / K)$ and to give a method to effectively compute its structure as a $\mathbb{Z}_{p}$-module. Then we give numerical results, for real quadratic fields, cubic fields and quintic fields, together with interpretations via Cohen-Lenstra's heuristics.


## 1 Introduction

We fix a prime number $p$ and a number field $K$. We denote by $M$ the maximal abelian $p$-extension of $K$ unramified outside $p$. The aim of this paper is to study the $\mathbb{Z}_{p}$-module $\mathfrak{X}=\operatorname{Gal}(M / K)$ and give an algorithm to compute its $\mathbb{Z}_{p}$-structure. This module is described by the following exact sequence from class field theory ([Gra1, p. 294])

\bar{U}_{K} \longrightarrow \prod_{v \mid p} U_{v}^{1} \longrightarrow \mathfrak{X} \longrightarrow \operatorname{Gal}(\mathcal{H} / K) \longrightarrow 1 \tag{1}
\end{equation*}

where $\overline{U_{K}}$ is the pro- $p$-completion of the group of units $U_{K}, U_{v}^{1}$ is the group of principal units at the place $v$ above $p$ of $K$, and $\mathcal{H}$ is the maximal $p$-subextension of the Hilbert class field of $K$. Leopold't conjecture for $K$ and $p$ is equivalent to injectivity of $\bar{U}_{K} \rightarrow \prod_{v \mid p} U_{v}^{1}$. Therefore, from this exact sequence, we deduce that the $\mathbb{Z}_{p}$-rank $r$ of $\mathfrak{X}$ is greater or equal to $r_{2}+1$ and is equal $r_{2}+1$ if and only if $K$ and $p$ satisfy Leopoldt's conjecture. Hence $\mathfrak{X}$ is the direct product of a free part isomorphic to $\mathbb{Z}_{p}^{r}$ and of a torsion part, that we denote by $\mathcal{T}_{p}$. Our algorithm checks if $K$ satify Leopoldt's conjecture at $p$ and then compute the torsion $\mathcal{T}_{p}$.

We propose a method which is based on the fact that the $\mathbb{Z}_{p}$-module $\mathfrak{X}$ is the projective limit of the $p$-parts of the ray class groups modulo $p^{n}, \mathcal{A}_{p^{n}}(K)$. We then study the stabilization of these groups with respect to $n$ and the behaviour of invariants of $\mathcal{A}_{p^{n}}(K)$, as $n$ is increasing. This approach leads us to our algorithm.

Before addressing the technical part of this article, we recall the definition and some basic properties of the ray class groups modulo $p^{n}$. Then, we use our algorithm to compute some cases and propose an heuristic explanation of the statistical data, using the Cohen-Lenstra philosophy ([C-L]).

## 2 Background from class field theory ([Gra1],[Ser])

In this section, we recall the basic notions from class field theory that we will need later. We fix $v$ a place of $K$ above $p$ and $\pi_{v}$ a local uniformiser of $K_{v}$, the completion of $K$ at $v$.

## Definition 2.1.

1. The conductor of an abelian extension of local fields $L_{v} / K_{v}$ is the minimum of integers $c$ such that $U_{v}^{c} \subset N_{L_{v} / K_{v}}\left(L_{v}^{\times}\right)$(we recall that $U_{v}^{c}=$ $1+\left(\pi_{v}^{c}\right)$ and we use the convention $\left.U_{v}^{0}=U_{v}\right)$.
2. The conductor of an abelian extension $L / K$ of a global field is the ideal $\mathfrak{m}=\prod_{v} \mathfrak{p}_{v}^{c_{v}}$, where $v$ runs through all finite places of $K$ and where $c_{v}$ is the conductor of the local extension $L_{v} / K_{v} \cdot([G r a 1, p .126-127]$ Theorem and Definition 4.1 + Lemma 4.2.1).

We start with 2 lemmas.
Lemma 2.2. ([Ser] p. 219). Let $K_{v}$ be the completion of $K$ at the valuation $v$ normalized by $v(p)=1$ and $v\left(\pi_{v}\right)=\frac{1}{e_{v}}$, where $e_{v}$ is the ramification index of the extension $K_{v} / \mathbb{Q}_{p}$. If $m>\frac{e_{v}}{p-1}$, then the application $x \rightarrow x^{p}$ is an isomorphism from $U_{v}^{m}$ to $U_{v}^{m+e_{v}}$.

Lemma 2.3. Let $K_{v} \subset L_{v} \subset M_{v}$ be a tower of extensions of $\mathbb{Q}_{p}$, such that the extension $M_{v} / K_{v}$ is abelian and the extension $M_{v} / L_{v}$ is of degree $p$. We denote respectively by $c_{M, v}$ and $c_{L, v}$ the conductors of the extensions $M_{v} / K_{v}$ and $L_{v} / K_{v}$. If $c_{L, v}>\frac{e_{v}}{p-1}$, then we have

c_{M, v} \leq c_{L, v}+e_{v}
$$

Proof. By definition $c_{L, v}$ is the smallest integer $n$ such that $U_{v}^{n} \subset N_{L_{v} / K_{v}}\left(L_{v}^{\times}\right)$. Local class field theory gives the following diagram


Applying snake lemma we get the exact sequence

$$
1 \longrightarrow N_{M_{v} / K_{v}}\left(M_{v}^{\times}\right) \longrightarrow N_{L_{v} / K_{v}}\left(L_{v}^{\times}\right) \longrightarrow \operatorname{Gal}\left(M_{v} / L_{v}\right)=\mathbb{Z} / p \mathbb{Z} \longrightarrow 1 .
$$

Consequently $N_{M_{v} / K_{v}}\left(M_{v}^{\times}\right)$is a subgroup of index $p$ of $N_{L_{v} / K_{v}}\left(L_{v}^{\times}\right)$. Let $n \in \mathbb{N}, n \geq c_{L, v}+e_{v}$ and $x \in U_{v}^{n}$. We have to show that $x \in N_{M_{v} / K_{v}}\left(M_{v}^{\times}\right)$. By lemma 2.2, $x^{\frac{1}{p}}$ is a well defined element of $\in U_{v}^{n-e_{v}}$. Yet $n-e_{v} \geq c_{L, v}$ therefore $x^{\frac{1}{p}} \in N_{L_{v} / K_{v}}\left(L_{v}^{\times}\right)$. Now, as $N_{M_{v} / K_{v}}\left(M_{v}^{\times}\right)$is of index $p$ in $N_{L_{v} / K_{v}}\left(L_{v}^{\times}\right)$, we deduce that $x \in N_{M_{v} / K_{v}}\left(M_{v}^{\times}\right)$. We have therefore $U_{v}^{n} \subset N_{M_{v} / K_{v}}\left(M_{v}^{\times}\right)$for all integers $n$ such that $n \geq c_{L}+e_{v}$. By definition of the conductor, this proves $c_{M, v} \leq c_{L, v}+e_{v}$.

Definition 2.4. Let $n$ be a positive integer. We denote by

- $H$ the maximal abelian unramified extension of $K$;
- $H_{p^{n}}$ the compositum of all abelian extensions of $K$ whose conductors divide $p^{n}$;
- $\mathcal{H}_{p^{n}}$ the compositum of all abelian p-extensions of $K$ whose conductors divide $p^{n}$;
- $M$ the maximal extension of $K$ which is abelian and unramified outside $p$.

So the Galois groups $\operatorname{Gal}(\mathcal{H} / K)$ and $\operatorname{Gal}\left(\mathcal{H}_{p^{n}} / K\right)$ are respectively isomorphic to the p-parts of $\operatorname{Gal}(H / K)$ and $\operatorname{Gal}\left(H_{p^{n}} / K\right)$.

Proposition 2.5. ([Gra1, p. 47] corollary 5.1.1) We have the following exact sequences,

1 \longrightarrow K^{\times} \prod_{v \nmid p} U_{v} \prod_{v \mid p} U_{v}^{n e_{v}} \longrightarrow \mathcal{I}_{K} \longrightarrow \operatorname{Gal}\left(H_{p^{n}} / K\right) \longrightarrow K^{\times} \prod_{v} U_{v} \longrightarrow \mathcal{I}_{K} \longrightarrow \operatorname{Gal}(H / K) \longrightarrow 1 \\
1 \longrightarrow
\end{gathered}
$$

where $\mathcal{I}_{K}$ is the group of idèles of $K$.
We denote the Galois group $\operatorname{Gal}\left(\mathcal{H}_{p^{n}} / K\right)$ by $\mathcal{A}_{p^{n}}(K)$. It is the $p$-part of the Galois group $\operatorname{Gal}\left(H_{p^{n}} / K\right)$ which, in turn, is isomorphic to the ray class group modulo $p^{n}$ of $K$. By definition, we have a natural inclusion $\mathcal{H}_{p^{n}} \subset \mathcal{H}_{p^{n+1}}$, the union $\bigcup_{n} \mathcal{H}_{p^{n}}$ is equal to $M$ and the projective limit $\lim _{\leftarrow} \mathcal{A}_{p^{n}}(K)$ is canonically isomorphic to $\mathfrak{X}$.

Proposition 2.6. For any integer $n>0$, the Galois groups of the extensions $M$ and $H_{p^{n}}$ of $K$ are related by the following exact sequence

1 \longrightarrow U_{K}^{\left(p^{n}\right)} \longrightarrow \prod_{v \mid p} U_{v}^{n e_{v}} \longrightarrow \operatorname{Gal}(M / K) \longrightarrow \operatorname{Gal}\left(H_{p^{n}} / K\right) \longrightarrow 1
$$

where $U_{K}^{\left(p^{n}\right)}=\left\{u \in U_{K}\right.$ such that $\left.\forall v \mid p, \quad u \in U_{v}^{n e_{v}}\right\}$ and

$$
\bar{U}_{K}^{\left(p^{n}\right)} \longrightarrow \prod_{v \mid p} U_{v}^{n e_{v}} \longrightarrow \mathfrak{X} \longrightarrow \mathcal{A}_{p^{n}}(K) \longrightarrow 1,
$$

where $\bar{U}_{K}^{\left(p^{n}\right)}$ is the pro-p-completion of $U_{K}^{\left(p^{n}\right)}$, i.e ${\underset{\check{m}}{m}}_{\lim _{K}} U_{K}^{\left(p^{n}\right)} / p^{m}$. If Moreover $K$ and $p$ satisfy Leopoldt' conjecture, then $\bar{U}_{K}^{\left(p^{n}\right)} \rightarrow \prod_{v \mid p} U_{v}^{n e_{v}}$ is injective.
Proof. To obtain the second exact sequence, we apply pro- $p$-completion process to the first. Note that injectivity of $\bar{U}_{K}^{\left(p^{n}\right)} \rightarrow \prod_{v \mid p} U_{v}^{n e_{v}}$ is equivalent to Leopoldt's conjecture. Now we prove exactness of the first sequence.
From the definition of the extensions $M$ and $H_{p^{n}}$, we deduce the diagram


It follows immediately from the snake lemma that

$$
\operatorname{ker}\left(\operatorname{Gal}(M / K) \rightarrow \operatorname{Gal}\left(H_{p^{n}} / K\right)\right)=\left(K^{\times} \prod_{v \nmid p} U_{v} \prod_{v \mid p} U_{v}^{n e_{v}}\right) /\left(K^{\times} \prod_{v \nmid p} U_{v} \prod_{v \mid p} 1\right)
$$

Now, we define the application

$$
\theta:\left(K^{\times} \prod_{v \nmid p} U_{v} \prod_{v \mid p} U_{v}^{n e_{v}}\right) \rightarrow\left(\prod_{v \mid p} U_{v}^{n e_{v}}\right) / U_{K}^{\left(p^{n}\right)},
$$

by setting for $k\left(u_{v}\right)_{v} \in K^{\times} \prod_{v \nmid p} U_{v} \prod_{v \mid p} U_{v}^{n e_{v}}, \theta\left(k\left(u_{v}\right)_{v}\right)=\overline{\left(u_{v}\right)_{v \mid p}}$, where $\overline{\left(u_{v}\right)_{v \mid p}}$ is the class of $\left(u_{v}\right)_{v \mid p}$ in $\left(\prod_{v \mid p} U_{v}^{n e_{v}}\right) / U_{K}^{\left(p^{n}\right)}$.

We first check that the application $\theta$ is well defined, i.e. that if $k\left(u_{v}\right)_{v}=$ $k^{\prime}\left(u_{v}^{\prime}\right)_{v}$ in $K^{\times} \prod_{v \nmid p} U_{v} \prod_{v \mid p} U_{v}^{n e_{v}}$, then $\theta\left(k\left(u_{v}\right)_{v}\right)=\theta\left(k^{\prime}\left(u_{v}^{\prime}\right)_{v}\right)$. By definition, for all $v, k\left(u_{v}\right)_{v}=k^{\prime}\left(u_{v}^{\prime}\right)_{v}$ if and only if $i_{v}(k) u_{v}=i_{v}\left(k^{\prime}\right) u_{v}^{\prime}$, where $i_{v}$ is the embedding of $K$ in $K_{v}$. We deduce that for all $v, i_{v}\left(k^{\prime} k^{-1}\right) \in U_{v}$ and that for all $v \mid p, i_{v}\left(k^{\prime} k^{-1}\right) \in U_{v}^{n e_{v}}$. So we get $k^{\prime} k^{-1} \in U_{K}^{\left(p^{n}\right)}$ and $\overline{\left(u_{v}\right)_{v \mid p}}=\overline{\left(u_{v}^{\prime}\right)_{v \mid p}}$.

It is clear that $\left(K^{\times} \prod_{v \nmid p} U_{v} \prod_{v \mid p} 1\right) \subset \operatorname{ker}(\theta)$ and that the application $\theta$ is surjective. We will show that $\left(K^{\times} \prod_{v \nmid p} U_{v} \prod_{v \mid p} 1\right)=\operatorname{ker}(\theta)$. Let $k\left(u_{v}\right) \in \operatorname{ker}(\theta)$, there exists $x \in U_{K}^{\left(p^{n}\right)}$ such that for all $v \mid p, u_{v}=i_{v}(x)$. We consider the element $x\left(u_{v}^{\prime}\right)_{v}$, where $u_{v}^{\prime}=1$ if $v \mid p$ and $u_{v}^{\prime}=i_{v}(x)^{-1} u_{v}$ if $v \nmid p$. We have $\left(u_{v}\right)_{v}=x\left(u_{v}^{\prime}\right)_{v} \Rightarrow k\left(u_{v}\right)_{v}=k x\left(u_{v}^{\prime}\right)_{v}$ and as $k x\left(u_{v}^{\prime}\right)_{v} \in\left(K^{\times} \prod_{v \nmid p} U_{v} \prod_{v \mid p} 1\right)$, we have $\operatorname{ker}(\theta) \subset\left(K^{\times} \prod_{v \nmid p} U_{v} \prod_{v \mid p} 1\right)$ and finally

$$
\left(K^{\times} \prod_{v \nmid p} U_{v} \prod_{v \mid p} U_{v}^{n e_{v}}\right) /\left(K^{\times} \prod_{v \nmid p} U_{v} \prod_{v \mid p} 1\right) \simeq\left(\prod_{v \mid p} U_{v}^{n e_{v}}\right) / U_{K}^{\left(p^{n}\right)} .
$$

The result follows.

## 3 Explicit Computation of $\mathcal{T}_{p}$

In this section, we present our method to check that $K$ verify Leopoldt's conjectue at $p$ and then to compute $\mathcal{T}_{p}$. The main point is that, for $n$ large enough, $\mathcal{A}_{p^{n}}(K)$ determines $\mathfrak{X}$.

### 3.1 Stabilization of $\mathcal{A}_{p^{n}}(K)$

For simplicity we note $Y_{n}=\operatorname{ker}\left(\mathcal{A}_{p^{n+1}}(K) \rightarrow \mathcal{A}_{p^{n}}(K)\right)$. Let $\tilde{K}$ be the compositum of all the $\mathbb{Z}_{p}$-extensions of $K$. We denote by $r$ the $\mathbb{Z}_{p}$-rank de $\mathfrak{X}$, so $r \geq r_{2}+1$.

Proposition 3.1. There exists $n_{0}$ such that $\tilde{K} \cap \mathcal{H}_{p^{n_{0}}} / \tilde{K} \cap \mathcal{H}_{p}$ is ramified at all places above of $p$ and for all $n \geqslant n_{0}, Y_{n}$ surjects on $(\mathbb{Z} / p \mathbb{Z})^{r}$.

Before proving the proposition we need a lemma.

Lemma 3.2. If the extension $\tilde{K} \cap \mathcal{H}_{p^{n}} / \tilde{K} \cap \mathcal{H}_{p}$ is ramified at a place $v$ above $p$, then $c_{n, v}>\frac{e_{v}}{p-1}$, where $c_{n, v}$ is the conductor of the local extension $(\tilde{K} \cap$ $\left.\mathcal{H}_{p^{n}}\right)_{w} / K_{v}$.

Proof of the Lemma 3.2. As $M$ contains the cyclotomic $\mathbb{Z}_{p}$-extension, there exists a $n_{0}$ such that $\tilde{K} \cap \mathcal{H}_{p^{n_{0}}} / \tilde{K} \cap \mathcal{H}_{p}$ is ramified at all places $v$ above of $p$. As $\tilde{K} \cap \mathcal{H}_{p^{n_{0}}} / \tilde{K} \cap \mathcal{H}_{p}$ is ramified at $v$ then, for $n \geq n_{0}, \tilde{K} \cap \mathcal{H}_{p^{n}} / \tilde{K} \cap \mathcal{H}_{p}$ is ramified at $v$, so that there exists $m$ such that $n \geq m \geq 2$ and that $\tilde{K} \cap \mathcal{H}_{p^{m-1}} / \tilde{K} \cap \mathcal{H}_{p}$ is unramified at $v$ and such that $\tilde{K} \cap \mathcal{H}_{p^{m}} / \tilde{K} \cap \mathcal{H}_{p}$ is ramified at $v$. Then, the local conductor $c_{m, v}$ is greater than $(m-1) e_{v}$, yet $m \geq 2$ so $c_{m, v}>(m-1) e_{v} \geqslant e_{v} \geqslant \frac{e_{v}}{p-1}$. As the conductor of the local extension $\tilde{K} \cap \mathcal{H}_{p^{m}} / K$ divides the conductor of $\tilde{K} \cap \mathcal{H}_{p^{n}} / K$, we have $c_{n, v} \geqslant c m, v>\frac{e_{v}}{p-1}$.
Proof of the Proposition 3.1. We consider the following diagram.


We have $\operatorname{Gal}(\tilde{K} / K)=\mathbb{Z}_{p}^{r}$. It is clear that $Y_{n} \rightarrow \operatorname{Gal}\left(\tilde{K} \cap \mathcal{H}_{p^{n+1}} / \tilde{K} \cap\right.$ $\left.\mathcal{H}_{p^{n}}\right)$. Yet $\operatorname{Gal}\left(\tilde{K} / \tilde{K} \cap \mathcal{H}_{p^{n}}\right)$ is a $\mathbb{Z}_{p}$-sub-module of $\operatorname{Gal}(\tilde{K} / K)=\mathbb{Z}_{p}^{r}$ of finite index, therefore it is isomorphic to $\mathbb{Z}_{p}^{r}$. Hence there exists $r$ extensions, say $M_{1}, M_{2}, \cdots, M_{r}$ of $\tilde{K} \cap \mathcal{H}_{p^{n}}$, contained in $\tilde{K}$ such that $\operatorname{Gal}\left(M_{i} / \tilde{K} \cap \mathcal{H}_{p^{n}}\right) \simeq$ $\mathbb{Z} / p \mathbb{Z}$ and $\operatorname{Gal}\left(M_{1} \cdots M_{r} / \tilde{K} \cap \mathcal{H}_{p^{n}}\right) \simeq(\mathbb{Z} / p \mathbb{Z})^{r}$. Yet the conductor of the extension $\tilde{K} \cap \mathcal{H}_{p^{n}} / K$ divides $p^{n}=\prod_{v \mid p} \mathfrak{p}_{v}^{n e_{v}}$. Moreover the hypothesis on $\tilde{K} \cap \mathcal{H}_{p^{n}} / \tilde{K} \cap \mathcal{H}_{p}$ ensures that we can use Lemma 2.3 and consequently the conductor of the extension $M_{i} / K$ divides $\prod_{v \mid p} \mathfrak{p}_{v}^{n e_{v}+e_{v}}=p^{n+1}$, i.e. $M_{i} \subset \mathcal{H}_{p^{n+1}}$ for all $i \in\{1, \cdots, r\}$. Hence the map is surjective.

We deduce immediately the corollary.
Corollary 3.3. We assume that for a naturel number $n$ the extension $\tilde{K} \cap$ $\mathcal{H}_{p^{n}} / \tilde{K} \cap \mathcal{H}_{p}$ is ramified at all places above of $p$, and that the cardinal of $Y_{n}$ is exactly $p^{r_{2}+1}$. Then $Y_{n} \simeq(\mathbb{Z} / p \mathbb{Z})^{r_{2}+1}$ and $K$ verify the Leopoldt's conjecture at p.

From now on, as we can numerically check that $K$ sastify the Leopoldt's conjecture at $p$, we assume it, and we use it to compute $\mathcal{T}_{p}$. Note that if the Leopodt's conjecture is false, then $r>r_{2}+1$ and our algorithm never stops.
Corollary 3.4. We assume that, for some integer $n$ such that the extension $\tilde{K} \cap \mathcal{H}_{p^{n}} / \tilde{K} \cap \mathcal{H}_{p}$ is ramified at all places above of $p$, the cardinal of $Y_{n}$ is exactly $p^{r_{2}+1}$. Then, $Y_{n} \simeq \operatorname{Gal}\left(\tilde{K} \cap \mathcal{H}_{p^{n+1}} / \tilde{K} \cap \mathcal{H}_{p^{n}}\right)$.

It remains to check that if $Y_{n_{0}} \simeq(\mathbb{Z} / p \mathbb{Z})^{r_{2}+1}$ for some $n_{0}$, then $Y_{n} \simeq$ $(\mathbb{Z} / p \mathbb{Z})^{r_{2}+1}$ for all integer $n \geq n_{0}$. For this purpose, we consider the exact sequence defining the $p$-part of the ray class group.

$$
1 \longrightarrow \bar{U}_{K}^{\left(p^{n}\right)} \longrightarrow \prod_{v \mid p} U_{v}^{n e_{v}} \longrightarrow \mathfrak{X} \longrightarrow \mathcal{A}_{p^{n}}(K) \longrightarrow 1,
$$

and we note $\mathcal{Q}_{n}=\prod_{v \mid p} U_{v}^{n e_{v}} / \bar{U}_{K}^{\left(p^{n}\right)}$. We have $\mathcal{Q}_{n}=\operatorname{Gal}\left(M / \mathcal{H}_{p^{n}}\right)$ and consequently $\mathcal{Q}_{n} / \mathcal{Q}_{n+1}=Y_{n} \simeq \operatorname{Gal}\left(\mathcal{H}_{p^{n+1}} / \mathcal{H}_{p^{n}}\right)$.
Proposition 3.5. For $n \geq 2$, raising to the $p^{\text {th }}$ power induces, via the Artin map, a surjection from $Y_{n}$ to $Y_{n+1}$.
Proof. We recall that $\mathcal{Q}_{n}=\prod_{v \mid p} U_{v}^{n e_{v}} / \bar{U}_{K}^{\left(p^{n}\right)}=\operatorname{ker}\left(\mathfrak{X} \rightarrow \mathcal{A}_{p^{n}}(K)\right)$. We have that $n>\frac{1}{p-1}$. Raising to the $p^{t h}$ power realizes an isomorphism of $\prod_{v \mid p} U_{v}^{n e_{v}}$ onto $\prod_{v \mid p} U_{v}^{n e_{v}}+e_{v}$. This isomorphism induces a surjection from $\mathcal{Q}_{n}$ onto $\mathcal{Q}_{n+1}$. We consider finally the diagram


We deduce from the snake lemma that the vertical arrow on the right side is a surjection from $\mathcal{Q}_{n} / \mathcal{Q}_{n+1}$ onto $\mathcal{Q}_{n+1} / \mathcal{Q}_{n+2}$, i.e. from $Y_{n}$ onto $Y_{n+1}$.

Corollary 3.6. We denote $q_{n}=\#\left(Y_{n}\right)$. For all $n \geqslant 2, q_{n} \geqslant q_{n+1}$. Therefore the sequence $\left(q_{n}\right)_{n \geq 1}$ is ultimately constant.

We recall that $Y_{n}$ is $\operatorname{ker}\left(\mathcal{A}_{p^{n+1}}(K) \rightarrow \mathcal{A}_{p^{n}}(K)\right)$.
Theorem 3.7. There exists an integer $n_{0}$ such that $Y_{n_{0}} \simeq(\mathbb{Z} / p \mathbb{Z})^{r_{2}+1}$. Moreover for all integers $n \geq n_{0}$, the modules $\mathcal{Q}_{n}=\operatorname{Gal}\left(M / \mathcal{H}_{p^{n}}\right)$ are $\mathbb{Z}_{p}$-free of rank $r_{2}+1$ and

$$
Y_{n} \simeq(\mathbb{Z} / p \mathbb{Z})^{r_{2}+1}
$$

Proof. The $\mathbb{Z}_{p}$-module $\mathfrak{X}$ is isomorphic to the direct product of its torsion part and of $\mathbb{Z}_{p}^{r_{2}+1}$. An isomorphism being chosen, we can identify $\mathbb{Z}_{p}^{r_{2}+1}$ with a subgroup of $\mathfrak{X}$ and therefore define, via Galois theory, an extension $M^{\prime}$ of $K$ such that $\operatorname{Gal}\left(M^{\prime} / K\right) \simeq \mathcal{T}_{p}$ and $\tilde{K} M^{\prime}=M$.

This extension being unramified outside $p$, there exists an integer $n_{1}$ such that $M^{\prime} \subset \mathcal{H}_{p^{n_{1}}}$ and consequently $\mathcal{H}_{p^{n_{1}}} \tilde{K}=M$. Moreover for all integer $n \geq n_{1}, \operatorname{Gal}\left(M / \mathcal{H}_{p^{n}}\right)$ is a sub-module of finite index of $\operatorname{Gal}\left(M / M^{\prime}\right)=\mathbb{Z}_{p}^{r_{2}+1}$, consequently $\mathcal{Q}_{n}=\operatorname{Gal}\left(M / \mathcal{H}_{p^{n}}\right) \simeq \mathbb{Z}_{p}^{r_{2}+1}$. The $\mathbb{Z}_{p}$-module $\mathcal{Q}_{n}$ is therefore free of rank $r_{2}+1$.
About the other kernel $Y_{n}$ we saw that there exists an integer $n_{2}$ such that $Y_{n}$ maps surjectively onto $(\mathbb{Z} / p \mathbb{Z})^{r_{2}+1}$ for all integer $n \geq n_{2}$ (we can choose $n_{2}$ to be the minimum of all integers $n$ such that for all $p$-places $v$ the conductors of $\left(\tilde{K} \cap \mathcal{H}_{p^{n}}\right)_{w} / K_{v}$ are greater than or equal to $\left.\frac{e}{p-1}\right)$. Finally we note that raising to the $p^{\text {th }}$ power realizes an isomorphism between $U_{v}^{n e_{v}}$ and $U_{v}^{n e_{v}+e_{v}}$, hence the quotient $\mathcal{Q}_{n} / \mathcal{Q}_{n+1}$, which is isomorphic to $Y_{n}$, is killed by $p$. Define $n_{0}=\operatorname{Max}\left(n_{1}, n_{2}\right)$ and fix an integer $n \geq n_{0}$. The kernel $Y_{n}$ is therefore a quotient of $\mathbb{Z}_{p}^{r_{2}+1}$, which maps surjectively onto $(\mathbb{Z} / p \mathbb{Z})^{r_{2}+1}$ and is killed by $p$. Hence we get $Y_{n} \simeq(\mathbb{Z} / p \mathbb{Z})^{r_{2}+1}$.

### 3.2 Computing the invariants of $\mathcal{T}_{p}$

We start by recalling the definition of invariant factors of an abelian group $G$.
Definition 3.8. Let $G$ a finite abelian group, there exists a unique sequence $a_{1}, \cdots, a_{t}$ such that for all $i, a_{i} \mid a_{i+1}$ for $i \in\{1, \cdots, t-1\}$ and $G \simeq \prod_{i=1}^{t} \mathbb{Z} / a_{i} \mathbb{Z}$. These $a_{i}$ are the invariant factors of the group $G$.

In what follows we will note them $\mathcal{F I}(G)=\left[a_{1}, \cdots, a_{t}\right]$. If $G$ is a $p$-group, these invariant factors are all powers of $p$. In practice, we are able to determine the invariant factors of $\mathcal{A}_{p^{n}}(K)$. We will see in this section that the knowledge of invariant factors of $\mathcal{A}_{p^{n}}(K)$, for $n$ large enough, combined with the stabilizing properties of $\mathcal{A}_{p^{n}}(K)$, does determine explicitly the invariant factors of, and thus $\mathcal{T}_{p}$. We recall that for $n$ large enough, $\mathcal{A}_{p^{n}}(K)$ is isomorphic to the direct product of $\operatorname{Gal}\left(\tilde{K} \cap \mathcal{H}_{p^{n}} / K\right)$ and of $\operatorname{Gal}\left(\mathcal{H}_{p^{n}} / \tilde{K} \cap \mathcal{H}_{p^{n}}\right)=\mathcal{T}_{p}$. So we will first explore the structure of $\operatorname{Gal}\left(\tilde{K} \cap \mathcal{H}_{p^{n}} / K\right)$.

Proposition 3.9. Let $n_{0}$ be such that $\tilde{K} \cap \mathcal{H}_{p^{n_{0}}} / \tilde{K} \cap \mathcal{H}_{p}$ is ramified at all places above of $p$ and

$$
Y_{n_{0}} \simeq(\mathbb{Z} / p \mathbb{Z})^{r_{2}+1}
$$

Then for all integer $n \geq n_{0}$, we have

$$
\operatorname{Gal}\left(\tilde{K} / \tilde{K} \cap \mathcal{H}_{p^{n+1}}\right)=p \operatorname{Gal}\left(\tilde{K} / \tilde{K} \cap \mathcal{H}_{p^{n}}\right) .
$$

Proof. By Theorem 3.7, on one hand, $\mathcal{Q}_{n}$ is $\mathbb{Z}_{p}$-free of rank $r_{2}+1$ and on the other hand $Y_{n}=\mathcal{Q}_{n} / \mathcal{Q}_{n+1} \simeq(\mathbb{Z} / p \mathbb{Z})^{r_{2}+1}$. This gives $\mathcal{Q}_{n+1}=p \mathcal{Q}_{n}$. As $\tilde{K} \cap \mathcal{H}_{p^{n_{0}}} / \tilde{K} \cap \mathcal{H}_{p}$ is ramified at all places above of $p$ and $Y_{n_{0}} \simeq(\mathbb{Z} / p \mathbb{Z})^{r_{2}+1}$, we have $\mathcal{T}_{p} \subset \mathcal{A}_{p^{n_{0}}}(K)$, so $\tilde{K} \mathcal{H}_{p^{n_{0}}}=M$. Then, considering the following diagram,

we get the required isomorphism.
Corollary 3.10. Let $n_{0}$ be an integer such that $\tilde{K} \cap \mathcal{H}_{p^{n_{0}}} / \tilde{K} \cap \mathcal{H}_{p}$ is ramified at all places above of $p$ and such that $Y_{n_{0}} \simeq(\mathbb{Z} / p \mathbb{Z})^{r_{2}+1}$. Then for all integers $n \geq n_{0}$, the invariant factors of $\operatorname{Gal}\left(\tilde{K} \cap \mathcal{H}_{p^{n+1}} / K\right)$ are obtained by multiplying by $p$ each invariant factor of $\operatorname{Gal}\left(\tilde{K} \cap \mathcal{H}_{p^{n}} / K\right)$.

From the fact that $\mathfrak{X} \simeq \mathbb{Z}_{p}^{r_{2}+1} \times \mathcal{T}_{p}$, the ray class group, $\operatorname{Gal}\left(\mathcal{H}_{p^{n}} / K\right)$, is isomorphic to the direct product of $\operatorname{Gal}\left(\tilde{K} \cap \mathcal{H}_{p^{n}} / K\right)$ and of $\operatorname{Gal}\left(\mathcal{H}_{p^{n}} / \tilde{K} \cap \mathcal{H}_{p^{n}}\right)$. The invariant factors of $\operatorname{Gal}\left(\mathcal{H}_{p^{n}} / K\right)$ are then simply obtained by concatenating those of the two groups forming the direct product. We now state the result that explicitly determines $\mathcal{T}_{p}$.

Theorem 3.11. Let $n$ such that $Y_{n}=(\mathbb{Z} / p \mathbb{Z})^{r_{2}+1}$ and $\tilde{K} \cap \mathcal{H}_{p^{n}} / \tilde{K} \cap \mathcal{H}_{p}$ is ramified at all places above of $p$. We assume that

$$
\mathcal{F I}\left(\mathcal{A}_{p^{n}}(K)\right)=\left[b_{1}, \cdots, b_{t}, a_{1}, \cdots, a_{r_{2}+1}\right]
$$

with $\left(v_{p}\left(a_{1}\right)\right)>\left(v_{p}\left(b_{t}\right)\right)+1$, and that

$$
\mathcal{F} \mathcal{I}\left(\mathcal{A}_{p^{n+1}}(K)\right)=\left[b_{1}, \cdots, b_{t}, p a_{1}, \cdots, p a_{r_{2}+1}\right] .
$$

Then, we have

$$
\mathcal{F I}\left(\mathcal{T}_{p}\right)=\left[b_{1}, \cdots, b_{t}\right]
$$

Proof. Indeed, as

$$
Y_{n} \simeq(\mathbb{Z} / p \mathbb{Z})^{r_{2}+1}
$$

we have $\mathcal{A}_{p^{i}}(K) \simeq \operatorname{tor}_{\mathbb{Z}_{p}}(\mathfrak{X}) \times \operatorname{Gal}\left(\tilde{K} \cap \mathcal{H}_{p^{i}} / K\right)$ for $i \in\{n, n+1\}$. We saw that the invariant factors of $\operatorname{Gal}\left(\tilde{K} \cap \mathcal{H}_{p^{n+1}} / K\right)$ are exactly equals to $p$ times those of $\operatorname{Gal}\left(\tilde{K} \cap \mathcal{H}_{p^{n}} / K\right)$. Consequently, if $a$ is an invariant factor of $\operatorname{Gal}\left(\tilde{K} \cap \mathcal{H}_{p^{n+1}} / K\right)$, we have necessarily $a=p a_{i}$ or $a=p b_{i}$.
But as $\operatorname{Min}\left(v_{p}\left(a_{i}\right)\right)>\operatorname{Max}\left(v_{p}\left(b_{i}\right)\right)+1$, none of the invariants factors of $\operatorname{Gal}(\tilde{K} \cap$ $\left.\mathcal{H}_{p^{n+1}} / K\right)$ is of the form $p b_{i}$. The invariant factors of $\operatorname{Gal}\left(\tilde{K} \cap \mathcal{H}_{p^{n+1}} / K\right)$ are therefore exactly $p a_{1}, \cdots, p a_{r_{2}+1}$. The result follows from the fact that $\mathcal{A}_{p^{n+1}}(K)$ is isomorphic to the direct product of $\mathcal{T}_{p}$ and of $\operatorname{Gal}\left(\tilde{K} \cap \mathcal{H}_{p^{n+1}} / K\right)$.

## 4 Explicit computation of bounds

More generally if we note $e=\max _{v \mid p}\left\{e_{v}\right\}$ the ramification index of $K / \mathbb{Q}$ and $s$ the $p$-adic valuation of $e$, then we start to check whether $\mathcal{A}_{p^{n}}(K)$ stabilizes from rank $n=2+s$. To show that $n=2+s$ is the proper starting point we consider the diagram,

where $K_{j}$ is the $j^{\text {th }}$-step of the $\mathbb{Z}_{p}$-extension of $K$.
The places above of $p$ are totally ramified in $K_{s+1} / K_{s}$ therefore $\tilde{K} \cap \mathcal{H}_{p^{s}} / \tilde{K} \cap$ $\mathcal{H}_{p}$ is ramified at all places above of $p$ and we start the computation checking whether $\mathcal{A}_{p^{n}}(K)$ stabilizes from $n=s+2$. We first prove that all places above
$p$ are totally ramified in $K_{s+1} / K_{s}$.
Considering the following diagram,

the ramification index of $p$ in $\mathbb{Q}_{s+1} / \mathbb{Q}$ is $p^{s+1}$ while the one in $K / \mathbb{Q}$ is $p^{s} a$ with $p \nmid a$. Therefore the extension $K_{s+1} / K$ is ramified and $K_{s+1} / K_{s}$ is totally ramified at all places above $p$.

Corollary 4.1. Let e be the ramification index of $p$ in $K / \mathbb{Q}$ and $s$ be the $p$-adic valuation of $e$. Let $n \geq 2+s$, we assume that

$$
\mathcal{F I}\left(\mathcal{A}_{p^{n}}(K)\right)=\left[b_{1}, \cdots, b_{t}, a_{1}, \cdots, a_{r_{2}+1}\right]
$$

with $\operatorname{Min}\left(v_{p}\left(a_{i}\right)\right)>\operatorname{Max}\left(v_{p}\left(b_{i}\right)\right)+1$, and moreover that

$$
\mathcal{F} \mathcal{I}\left(\mathcal{A}_{p^{n+1}}(K)\right)=\left[b_{1}, \cdots, b_{t}, p a_{1}, \cdots, p a_{r_{2}+1}\right] .
$$

Then, we have

$$
\mathcal{F I}\left(\mathcal{T}_{p}\right)=\left[b_{1}, \cdots, b_{t}\right]
$$

All the computations are been done using the PARI/GPsystem [PARI-GP].
Example 4.2. We consider the field $K=\mathbb{Q}(\sqrt{-129})$ and $p=3$. We have: $\mathcal{F I}\left(\mathcal{A}_{p^{2}}(K)\right)=[3,3,9], \mathcal{F I}\left(\mathcal{A}_{p^{3}}(K)\right)=[3,9,27]$ and $\mathcal{F I}\left(\mathcal{A}_{p^{4}}(K)\right)=[3,27,81]$. We deduce that $\mathcal{T}_{p}=(\mathbb{Z} / 3 \mathbb{Z})$.

## 5 Numerical results

In the section, we give an explanation of some numerical results that we have computed.

### 5.1 Heuristic approach

We first recall some results on Cohen-Lenstra Heuristics. The main reference on the subject is the seminal paper of Cohen-Lenstra [C-L], see also [Del]. If we assume that the extension $K / \mathbb{Q}$ is Galois with $\Delta=\operatorname{Gal}(K / \mathbb{Q})$, then the module $\mathcal{T}_{p}$ is a $\mathbb{Z}[\Delta]$-module. In this section, we assume that $\Delta$ is cyclic of cardinality $l$, for some prime number $l$. Then $\mathcal{T}_{p}$ is $O_{l}$-module, where $O_{l}$ is the ring of integers of $\mathbb{Q}\left(\zeta_{l}\right)$. In general, we know that all $O_{l}$-module $G$ can be written in a non-canonical way as $\oplus_{i=1}^{q} O_{l} / \mathfrak{a}_{i}$, where the $\mathfrak{a}_{i}$ are ideals of $O_{l}$. Yet the Fitting ideal $\mathfrak{a}=\prod_{i=1}^{q} \mathfrak{a}_{i}$ depends only of the isomorphism class of $G$, considered as a
$O_{l}$-module. This invariant, denoted by $\mathfrak{a}(G)$, can be considered as a generalization of the order of $G$. We also have $N(\mathfrak{a}(G))=\# G$.

To simplify the notation we set.

- $\sum_{G, N}=\sum_{G, N(\mathfrak{a}(G)) \leq N}$, where the sum is over all isomorphism classes of $O_{l}$-module $G$;
- $\sum_{\mathfrak{a}, N}=\sum_{\mathfrak{a}, N(\mathfrak{a}) \leq N} ;$
- $\sum_{\mathfrak{a}^{\prime}, N}=\sum_{\mathfrak{a}^{\prime}, N\left(\mathfrak{a}^{\prime}\right) \leq N \text { and } \mathfrak{a}^{\prime} \wedge p=1} ;$
- $\sum_{O_{l}, N}=\sum_{\mathfrak{p}, N(\mathfrak{p}) \leq N \text { and } \mathfrak{p} \in S_{p}}$, where $S_{p}$ designed the set of all $p$-places of

We consider a function $g$, defined on the set of the isomorphism classes of $O_{l}$-modules (typically $g$ is a characteristic function). We then put

$$
\begin{aligned}
S_{N}(g) & =\sum_{G, N} \frac{g(G)}{\text { \#Auto }} ; \\
S_{N} & =\sum_{G, N}{ }^{\text {\# Auto } O_{l}(G)}
\end{aligned}
$$

Definition 5.1. The average of $g$, if it exists is, the limit when $N \rightarrow \infty$ of the quotient

$$
\frac{S_{N}(g)}{S_{N}}
$$

This average is denoted by $M_{l, 0}(g)$.
As in [C-L], we denote by $w(\mathfrak{a})=\sum_{G, \mathfrak{a}(G)=\mathfrak{a}} \frac{1}{\# \text { Auto }_{l}(G)}$, where $\mathfrak{a}$ is an ideal of $O_{l}$.

Proposition 5.2. ([C-L] p. 40 corollary 3.8) Let $n \in \mathbb{N}$, then

$$
w(\mathfrak{a})=\frac{1}{N_{\mathbb{Q}\left(\zeta_{l}\right)}(\mathfrak{a})}\left(\prod_{\mathfrak{p}^{\alpha}| | \mathfrak{a}} \prod_{k=1}^{\alpha}\left(1-\frac{1}{N_{O_{l}}(\mathfrak{p})^{k}}\right)\right)^{-1}
$$

The notation $\mathfrak{p}^{\alpha} \| \mathfrak{a}$ meaning $\mathfrak{p}^{\alpha} \mid \mathfrak{a}$ and that $\mathfrak{p}^{\alpha+1} \nmid \mathfrak{a}$. Consequently the function $w$, defined on the set of ideals of $O_{l}$, is multiplicative.

Notation. We denote by $\Pi_{p}$ the characteristic function of the set of the isomorphism classes of groups whose $p$-part is non trivial.

Proposition 5.3. ([C-L] p. 47 example 5.10) We note $\mathfrak{p}_{1}, \cdots, \mathfrak{p}_{g}$ the p-places of $O_{l}$, the average of $\Pi_{p}$ exist and we have

$$
M_{l, 0}\left(\Pi_{p}\right)=1-\prod_{i=1}^{g} \prod_{k \geq 1}\left(1-\frac{1}{p^{k f_{i}}}\right),
$$

where the $f_{i}$ designed the degree of the residual extensions $O_{l} / \mathfrak{p}_{i}$ over $\mathbb{F}_{p}$.

Corollary 5.4. If the extension $K$ is a Galois extension, all residual degrees are equals to $f$ and in this case

$$
M_{l, 0}\left(\Pi_{p}\right)=1-\left(\prod_{k \geq 1} 1-\frac{1}{p^{k f}}\right)^{g}
$$

Remark. The real $M_{l, 0}\left(\Pi_{p}\right)$ is called the 0-average. This notion can be generalized to $u$-average. The expression to compute the $u$-average is obtained by replacing $k$ by $k+u$ in the expression of the 0 -average.

### 5.2 Somes numerical results

### 5.2.1 Case of the quadratic fields

We consider all quadratic fields of the type $\mathbb{Q}(\sqrt{d})$ with $d$ square-free and $0<$ $d \leq 10^{9}$. Then, we compute the proportion of fields with non trivial $\mathbb{Z}_{p}$-torsion of $\mathfrak{X}$. We note this proportion $f_{\text {exp }}$. The relative error $\left|f_{\text {exp }}-M_{2,0}\left(\Pi_{p}\right)\right| / M_{2,0}\left(\Pi_{p}\right)$ is denoted by $\delta$.

We consider now the quadratic field of the type $\mathbb{Q}(\sqrt{d})$ with $-10^{9} \leqslant d \leqslant 0$. One uses the 1-average that denoted by $M_{2,1}\left(\Pi_{p}\right)$.

We have also computed these proportions for other fields and we consider the distribution of torsion modules with respect to invariants factors but they will not be given here.

### 5.2.2 Explanation of numerical results

In this section we explain our numerical result. Looking at two tables in §5.2.1 we remark that the proportion $f_{\text {exp }}$ for real quadratic fields seems to be a 0 average and a 1-average for the imaginary quadratic. We remark also that the default $\delta$ for $p=2,3$ increases with the number of fields computed. To explain these phenomena we recall a computation of Gras [Gra2] p. 94-97. Let $k$ be a number field, we denote by $K=k\left(\zeta_{p}\right)$ and $\omega$ the idempotent associated with the action of $\operatorname{Gal}(K / k)$ on $\mu_{p}$.

Theorem 5.5 (Corollaire 1 p. 96 [Gra2]). Let $p$ be a prime, $p \neq 2$. If $\mu_{p} \not \subset k$ then the torsion of $\mathfrak{X}$ is trivial if and only if any prime ideal of $k$ dividing $p$ is totally split in $K / k$ and $\left(C l_{K}\right)^{\omega}$ is trivial where $C l_{K}$ is the p-part of the class group of $K$.

In case of quadratic fields, if $p>3$ then $\mu_{p} \not \subset k$ and the ramification index of $p$ in $\mathbb{Q}\left(\zeta_{p}\right) / \mathbb{Q}$ is $p-1$; then all prime ideal of $k$ dividing $p$ ramifies in $K$, therefore they are not totally split, hence the torsion is trivial if and only if $\left(C l_{K}\right)^{\omega}$ is trivial. So in case $k$ is a real quadratic field the computation of $\mathcal{T}_{p}$ reduces to the computation of a class group of imaginary quadratic field and we use the 0 -average following Cohen-Lenstra Heuristics. In case of imaginary quadratic the remark [Gra2] p.96-97 explains the 1-average. In case $p=3$, if $d \equiv 6 \bmod 9$ then the ideal of $k$ above $p$ is totally split in $K$, so the torsion is non trivial. It
explains why the frequency obtained is greater. If we consider the other average $M_{2}^{\prime}\left(\Pi_{3}\right)=M_{2,0}\left(\Pi_{3}\right) \times \frac{7}{8}+\frac{1}{8} ;$ then we obtain

We now make the computation without the $d \equiv 6 \bmod 9$.

It remains to study the 9 -rank in case where $d \equiv 6 \bmod 9$, and to try and find density formulas for the 9 -rank. Finally the discrepancy in the case $p=2$ is explained by genus theory. Indeed if the discriminant is divided by enough primes then the torsion is not trivial, this explains that the frequency tends to 1.
