# Combinatorics of $\phi$ -deformed stuffle Hopf algebras<sup>1</sup>

#### Abstract

In order to extend the Schützenberger's factorization to general perturbations, the combinatorial aspects of the Hopf algebra of the  $\phi$ -deformed stuffle product is developed systematically in a parallel way with those of the shuffle product and in emphasizing the Lie elements as studied by Ree. In particular, we will give an effective construction of pair of bases in duality.

### 1 Introduction

Let X be an totally ordered alphabet<sup>2</sup>. The free monoid and the set of Lyndon words, over X, are denoted respectively by  $X^*$  and  $\mathcal{L}ynX$ . The neutral element of  $X^*$ , *i.e.* the empty word is denoted by  $1_{X^*}$ . Let  $\mathbb{Q}\langle X\rangle$  be equipped by the concatenation and the shuffle which is defined by

$$\forall w \in X^*, \qquad w \sqcup 1_{X^*} = 1_{X^*} \sqcup w = w,$$
  
$$\forall x, y \in X, \forall u, v \in X^*, \qquad xu \sqcup yv = x(u \sqcup yv) + y(xu \sqcup v), \tag{1}$$

or by their dual co-products,  $\Delta = \Delta_{\text{conc}}$  and  $\Delta = \Delta_{\sqcup \sqcup}$ , defined by, for any  $w \in X^*$  by,

$$\Delta_{\operatorname{conc}}(w) = \sum_{w=uv} u \otimes v$$

$$\Delta_{\sqcup \sqcup}(w) = \sum_{I+J=[1..|w|]} w[I] \otimes w[J]$$
(2)

One gets two Hopf algebras

$$\mathcal{H}_{\sqcup \sqcup} = (\mathbb{Q}\langle X \rangle, \mathsf{conc}, 1_{X^*}, \Delta_{\sqcup \sqcup}, \epsilon, a_{\bullet}) \text{ and}$$

$$\mathcal{H}^{\vee}_{\sqcup \sqcup} = (\mathbb{Q}\langle X \rangle, \sqcup, 1_{X^*}, \Delta_{\mathsf{conc}}, \epsilon, a_{\sqcup \sqcup})$$
(3)

mutually dual with respect to the pairing given by

$$(\forall u, v \in X^*)(\langle u \mid v \rangle = \delta_{u,v}) . \tag{4}$$

and with, for any  $x_{i_1}, \ldots, x_{i_r} \in X$  and  $P \in \mathbb{Q}\langle X \rangle$ ,

$$\epsilon(P) = \langle P \mid 1_{X^*} \rangle,$$

$$a_{\sqcup \sqcup}(w) = a_{\bullet}(w) = (-1)^r x_{i_r} \dots x_{i_1},$$

$$(5)$$

By the theorem of Cartier-Quillen-Milnor and Moore (CQMM in the sequel), the connected, graded positively, co-commutative Hopf algebra  $\mathcal{H}_{\sqcup \sqcup}$  is isomorphic to the enveloping algebra of the Lie algebra of its primitive elements which here is  $\mathcal{L}ie_{\mathbb{Q}}\langle X \rangle$ . Hence, from any basis of the free algebra  $\mathcal{L}ie_{\mathbb{Q}}\langle X \rangle$  one can<sup>3</sup> complete, by the Poincaré-Birkhoff-Witt theorem, a linear basis  $\{b_w\}_{w \in X^*}$  for  $\mathcal{U}(\mathcal{L}ie_{\mathbb{Q}}\langle X \rangle) = \mathbb{Q}\langle X \rangle$  (see below (8) for an example of such a construction), and, when the basis is finely homogeneous, one can construct, by duality, a basis  $\{\check{b}_w\}_{w \in X^*}$  of  $\mathcal{H}_{\sqcup \sqcup}$  (viewed as a  $\mathbb{Q}$ -module) such that :

$$\forall u, v \in X^*, \quad \langle \check{b}_u \mid b_v \rangle = \delta_{u,v} . \tag{6}$$

For  $w = l_1^{i_1} \dots l_k^{i_k}$  with  $l_1, \dots l_k \in \mathcal{L}ynX$ ,  $l_1 > \dots > l_k$ 

$$\check{b}_w = \frac{\check{b}_{l_1}^{\sqcup i_1} \sqcup \ldots \sqcup \check{b}_{l_k}^{\sqcup i_k}}{i_1! \ldots i_k!}.$$
 (7)

For example, Chen, Fox and Lyndon [5] constructed the PBW-Lyndon basis  $\{P_w\}_{w\in X^*}$  for  $\mathcal{U}(\mathcal{L}ie_{\mathbb{Q}}\langle X\rangle)$  as follows

$$\begin{array}{lll} P_x = & x & \text{for } x \in X, \\ P_l = & [P_s, P_r] & \text{for } l \in \mathcal{L}ynX, \text{ standard factorization of } l = (s, r), \\ P_w = & P_{l_1}^{i_1} \dots P_{l_k}^{i_k} & \text{for } w = l_1^{i_1} \dots l_k^{i_k}, \ l_1 > \dots > l_k, l_1 \dots, l_k \in \mathcal{L}ynX. \end{array} \tag{8}$$

Schützenberger and his school constructed, the linear basis  $\{S_w\}_{w\in X^*}$  for  $\mathcal{A} = (\mathbb{Q}\langle X \rangle, \sqcup, 1_{X^*})$  by duality (w.r.t. eq.4) and obtained the transcendence basis of  $\mathcal{A} \{S_l\}_{l \in \mathcal{L}ynX}$  as follows<sup>4</sup>

$$S_l = xS_u, \quad \text{for } l = xu \in \mathcal{L}ynX,$$
 (9)

$$S_{l} = xS_{u}, \quad \text{for } l = xu \in \mathcal{L}ynX,$$

$$S_{w} = \frac{S_{l_{1}}^{\sqcup \sqcup i_{1}} \sqcup \ldots \sqcup S_{l_{k}}^{\sqcup \sqcup i_{k}}}{i_{1}! \ldots i_{k}!} \quad \text{for } w = l_{1}^{i_{1}} \ldots l_{k}^{i_{k}}, l_{1} > \ldots > l_{k}.$$

$$(10)$$

After that, Mélançon and Reutenauer [8] proved that<sup>5</sup>, for any  $w \in X^*$ ,

$$P_w = w + \sum_{v>w,|v|=|w|} c_v v$$
 and  $S_w = w + \sum_{v< w,|v|=|w|} c_v v.$  (11)

On other words, the elements of the bases  $\{S_w\}_{w\in X^*}$  and  $\{P_w\}_{w\in X^*}$  are upper and lower triangular respectively and are multihomogeneous.

Moreover, thanks to the duality of the bases  $\{P_w\}_{w\in X^k}$  and  $\{S_w\}_{w\in X^k}$ , if  $\mathcal{D}_X$ denotes the diagonal series over X one has

$$\mathcal{D}_X = \sum_{w \in X^*} w \otimes w = \sum_{w \in X^*} S_w \otimes P_w = \prod_{l \in \mathcal{L}ynX} \exp(S_l \otimes P_l). \tag{12}$$

## 2 General results on summability and duality

Let  $Y = \{y_i\}_{i \in I}$  be a totally ordered alphabet. The free monoid and the set of Lyndon words, over Y, are denoted respectively by  $Y^*$  and  $\mathcal{L}ynY$ . The neutral of  $Y^*$  (and then of  $A\langle Y\rangle$ ) is denoted by  $1_{Y^*}$ .

### 2.1 Total algebras and duality

### 2.1.1 Series and infinite sums

In the sequel, we will need to construct spaces of functions on different monoids (mainly direct products of free monoids). We set, once for all the general construction of the corresponding convolution algebra.

Let A be a unitary commutative ring and M a monoid. Let us denote  $A^M$  the set<sup>6</sup> of all (graphs of) mappings  $M \to A$ . This set is endowed with its classical structure of module. In order to extend the product defined in A[M] (the algebra of the monoid M), it is essential that, in the sums

$$f * g(m) = \sum_{m \in M} \sum_{uv=m} f(u)g(v)$$
(13)

the inner sum  $\sum_{uv=m} f(u)g(v)$  make sense. For that, we suppose that the monoid M fulfills condition "D" (be of finite decomposition type [3] Ch III.10). Formally, we say that M satisfies condition "D" iff, for all  $m \in M$ , the set

$$\{(u,v) \in M \times M \mid uv = m\} \tag{14}$$

is finite. In this case eq.13 endows  $A^M$  with the structure of a AAU. This algebra is traditionnally called the total algebra of M (see [3] Ch III.10) and has very much to do with the series<sup>7</sup>. It will be, here (with a slight abuse of denotation which does not cause ambiguity) denoted  $A\langle\!\langle M \rangle\!\rangle$ . The pairing

$$A\langle\!\langle M \rangle\!\rangle \otimes A[M] \longrightarrow A$$
 (15)

allows to see every element of the total algebra as a linear form on the module A[M]. On can check easily that, with this pairing, one has  $A\langle\!\langle M \rangle\!\rangle \simeq (A[M])^*$ . One says that a family  $(f_i)_{i \in I}$  of  $A\langle\!\langle M \rangle\!\rangle$  is summable [1] iff, for every  $m \in M$ , the mapping  $i \mapsto \langle f_i \mid m \rangle$  is finitely supported. In this case, the sum  $\sum_{i \in I} f_i$  is exactly the mapping  $m \longmapsto \sum_{i \in I} \langle f_i \mid m \rangle$  so that, one has by definition

$$\langle \sum_{i \in I} f_i \mid m \rangle = \sum_{i \in I} \langle f_i \mid m \rangle . \tag{17}$$

To end with, let us remark that the set  $M_1 \otimes M_2 = \{u \otimes v\}_{(u,v) \in M_1 \times M_2}$  is a (monoidal) basis of  $A[M_1] \otimes A[M_2]$  and  $M_1 \otimes M_2$  is a monoid (in the product algebra  $A[M_1] \otimes A[M_2]$ ) isomorphic to the direct product  $M_1 \times M_2$ .

### 2.1.2 Summable families

In fact,  $A\langle\!\langle M \rangle\!\rangle \simeq (A[M])^* = Hom(A[M],A)$  and the notion of summability developed here can be seen as a particular case of that of a family of endomorphisms  $f_i \in \operatorname{Hom}(V,W)$  for which  $\operatorname{Hom}(V,W)$  appears as a complete space. It is indeed the pointwise convergence for the discrete topology. We will not detail these considerations here.

The definition is similar of that of a summable family of series [1], viewed as a family of linear forms.

**Definition 1.** i) A family  $(f_i)_{i \in I}$  of elements in  $\operatorname{Hom}(V, W)$  is said to be summable iff for all  $x \in V$ , the map  $i \mapsto f_i(x)$  has finite support. As a quantized criterium it reads

$$(\forall x \in V)(\exists F \subset_{finite} I)(\forall i \notin F)(f_i(x) = 0) \tag{18}$$

ii) If the family  $(f_i)_{i\in I} \in \text{Hom}(V,W)^I$  fulfils the condition 18 above its sum is given by

$$\left(\sum_{i \in I} f_i\right)(x) = \sum_{i \in I} f_i(x) \tag{19}$$

It is an easy exercise to show that the mapping  $V \to W$  defined by the equation 19 is in fact in  $\operatorname{Hom}(V,W)$ . Remark that, as the limiting process is defined by linear conditions, if a family  $(f_i)_{i\in I}$  is summable, so is

$$(a_i f_i)_{i \in I} \tag{20}$$

for a set of coefficients  $(a_i)_{i \in I} \in A^I$ .

if a family When  $V = W = \mathcal{B}$  is a bialgebra, this tool will be used in section (2.2) to give an analytic presentation of the theorem of Cartier-Milnor-Moore.

The most interesting feature of this operation is the interversion of sums. Let us state it formally as a proposition the proof of which is left to the reader.

**Proposition 1.** Let  $(f_i)_{i\in I}$  be a family of elements in  $\operatorname{Hom}(V,W)$  and  $(I_j)_{j\in J}$  be a partition of I ([2] ch II §4  $n^o$  7 Def. 6), then TFAE

i)  $(f_i)_{i\in I}$  is summable ii) for all  $j\in J$ ,  $(f_i)_{i\in I_j}$  is summable and the family  $(\sum_{i\in I_j}f_i)_{j\in J}$  is summable. In these conditions, one has

$$\sum_{i \in I} f_i = \sum_{j \in J} (\sum_{i \in I_j} f_i) \tag{21}$$

We derive at once from this the following practical criterium for double sums.

**Proposition 2.** Let  $(f_{\alpha,\beta})_{(\alpha,\beta)\in A\times B}$  be a doubly indexed summable family in Hom(V,W), then, for fixed  $\alpha$  (resp.  $\beta$ ) the "row-families"  $(f_{\alpha,\beta})_{\beta\in B}$  (resp. the "column-families"  $(f_{\alpha,\beta})_{\alpha\in A}$ ) are summable and their sums are summable. Moreover

$$\sum_{(\alpha,\beta)\in A\times B} f_{\alpha,\beta} = \sum_{\alpha\in A} \sum_{\beta\in B} f_{\alpha,\beta} = \sum_{\beta\in B} \sum_{\alpha\in A} f_{\alpha,\beta} . \tag{22}$$

### 2.1.3 Substitutions

Let  $\mathcal{A}$  be a AAU and  $f \in \mathcal{A}$ . For every polynomial  $P \in A\langle X \rangle = A[X]$ , one can compute P(f) by

$$P(f) = \sum_{n>0} \langle P \mid X^n \rangle f^n \tag{23}$$

one checks at once that  $P \mapsto P(f)$  is a morphism<sup>9</sup> of AAU between A[X] and A. Moreover, this morphism is compatible with the substitutions as one checks easily that, for  $Q \in A[X]$ 

$$P(Q)(f) = P(Q(f)) \tag{24}$$

(it suffices to check that  $P \mapsto P(Q)(f)$  and  $P \mapsto P(Q(f))$  are two morphisms which coincide at P = X).

In order to substitute within series, one needs some limiting process. The framework of  $\mathcal{A}=\operatorname{Hom}(V,W)$  and summable families will be here sufficient (see paragraph 2.1.2). We suppose that  $(V,\delta_V,\epsilon_V)$  is a co-AAU and that  $(W,\mu_W,1_W)$  is a AAU. Then  $(\operatorname{Hom}(V,W),*,e)$  is a AAU (with  $e=1_W\circ\epsilon_V$ ). A series  $S\in A[[X]]$  being given, we say that  $f\in\operatorname{iff}$  the family  $(\langle S\mid X^n\rangle f^{*n})_{n\geq 0}$  is summable. It is easy to check that, if  $f\in\operatorname{Dom}(S)\cap\operatorname{Dom}(T)$  and  $\alpha\in A$ , one has

$$(\alpha S)(f) = \alpha S(f) ; (S+T)(f) = S(f) + T(f)$$
(25)

and

$$(TS)(f) = T(f) * S(f) . (26)$$

If  $((f)^n)_{n\geq 0}$  is summable and S(0)=0 then

$$f \in Dom(S) \cap Dom(T(S)) \; ; \; S(f) \in Dom(T)$$
 (27)

and

$$T(S)(f) = T(S(f)) \tag{28}$$

*Proof.* Let us first prove eq.26 . As  $f \in Dom(S) \cap Dom(T)$ , the families  $(\langle S \mid X^n \rangle f^{*n})_{n \geq 0}$  and  $(\langle T \mid X^m \rangle f^{*m})_{n \geq 0}$  are summable, then so is

$$\left(\langle T \mid X^m \rangle f^{*m} * \langle S \mid X^n \rangle f^{*n}\right)_{n,m \ge 0} \tag{29}$$

as, for every  $x \in V$ ,  $\delta(x) = \sum_{i=1}^{N} x_i^{(1)} \otimes x_i^{(2)}$  and for every  $i \in I$ ,

$$supp_{w.r.t.\ n}(\langle T\mid X^m\rangle f^{*m}(x_i^{(1)}))\ ;\ supp_{w.r.t.\ n}(\langle S\mid X^n\rangle f^{*n}(x_i^{(2)}))$$

are finite. Then outside of the cartesian product of the (finite) union of these supports, the product

$$(\langle T \mid X^m \rangle f^{*m} * \langle S \mid X^n \rangle f^{*n})(x) = \mu_W((\langle T \mid X^m \rangle f^{*m} \otimes \langle S \mid X^n \rangle f^{*n})(\delta(x)))$$
(30)

is zero. Hence the summability. Now

$$T(f) * S(f) = \sum_{m=0}^{\infty} (\langle T \mid X^m \rangle f^{*m}) * \sum_{n=0}^{\infty} (\langle S \mid X^n \rangle f^{*n}) =$$

$$\sum_{m=0}^{\infty} \sum_{n=0}^{\infty} (\langle T \mid X^m \rangle \langle S \mid X^n \rangle f^{*n+m}) =$$

$$\sum_{s=0}^{\infty} \left( \sum_{n+m=s}^{\infty} \langle T \mid X^m \rangle \langle S \mid X^n \rangle \right) f^{*s} =$$

$$\sum_{s=0}^{\infty} (\langle TS \mid X^s \rangle) f^{*s} = (TS)(f)$$
(31)

We now prove the statements (27) and (28). If  $((f)^{*n})_{n\geq 0}$  is summable then f belongs to all domains (i.e. is universally substituable). For all  $x\in V$ , it exists  $N_x\in\mathbb{N}$  such that

$$n > N_x \Longrightarrow (f)^{*n}(x) = 0$$
.

Now, for S such that S(0)=0, one has  $S=\sum_{n=1}^{\infty}\langle S\mid X^n\rangle X^n$  and then  $S^k=\sum_{n=k}^{\infty}\langle S^k\mid X^n\rangle X^n$ . Now, in view of eq.26, one has

$$S(f)^{*n}(x) = S^n(f)(x) = \sum_{m=n}^{\infty} \langle S^n \mid X^m \rangle (f)^{*m}(x)$$
 (32)

which is zero for  $n > N_x$ . Hence the summability of  $(S(f)^{*n})_{n \geq 0}$  which implies that  $S(f) \in Dom(T)$ . The family  $(\langle T \mid X^n \rangle \langle S^n \mid X^m \rangle (f)^{*m})_{(n,m) \in \mathbb{N}^2}$  is summable because, if  $x \in V$  and if n or m is greater than  $N_x$  then

$$\langle T \mid X^n \rangle \langle S^n \mid X^m \rangle (f)^{*m}(x) = 0 \tag{33}$$

thus T(S(f)) is the sum

$$T(S(f)) = \sum_{n=0}^{\infty} \langle T \mid X^n \rangle S(f)^{*n} = \sum_{n=0}^{\infty} \langle T \mid X^n \rangle \sum_{m=n}^{\infty} \langle S^n \mid X^m \rangle (f)^{*m} =$$

$$\sum_{n=0}^{\infty} \sum_{m=0}^{\infty} \langle T \mid X^{n} \rangle \langle S^{n} \mid X^{m} \rangle (f)^{*m} = \sum_{m=0}^{\infty} \left( \sum_{n=0}^{\infty} \langle T \mid X^{n} \rangle \langle S^{n} \mid X^{m} \rangle \right) (f)^{*m} = \sum_{m=0}^{\infty} \langle T(S) \mid X^{m} \rangle (f)^{*m} = T(S)(f)$$
(34)

# 2.2 Theorem of Cartier-Quillen-Milnor-Moore (analytic form)

### 2.2.1 General properties of bialgebras

Let A be a unitary commutative ring with all (non-zero) integers invertible (i.e.  $\mathbb{Q} \subset A$ ) and  $(\mathcal{B}, \mu, e_{\mathcal{B}}, \Delta, \epsilon)$  a A-bialgebra. TODO  $Id_+, \Delta_+$ .

In a general bialgebra  $(\mathcal{B}, \mu, e_{\mathcal{B}}, \Delta, \epsilon)$ , one can always consider the Lie algebra of primitive elements  $Prim(\mathcal{B})$  and build the map  $j_{\mathcal{B}} : \mathcal{U}(Prim(\mathcal{B})) \to \mathcal{B}$ . Then,  $\mathcal{A} = j_{\mathcal{B}}(\mathcal{U}(Prim(\mathcal{B})))$  is the subalgebra generated by the primitive elements. It is not difficult to see that  $\mathcal{A}$  is a sub-bialgebra of  $\mathcal{B}$  as, for any list of primitive elements  $L = [g_1, g_2, \cdots g_n]$ , one has

$$\Delta(g_1g_2\cdots g_n) = \Delta(L[\{1,2,..,n\}]) = \sum_{I+J=\{1,2,...,n\}} L[I] \otimes L[J]$$
 (35)

where, for  $I = \{i_1 < i_2 < ... < i_k\} \subset \{1, 2, ..., n\},\$ 

$$L[I] = g_{i_1} g_{i_1} \cdots g_{i_k} \ . \tag{36}$$

From (35) one gets also that  $j_{\mathcal{B}}$  is a morphism of bialgebras. In order to prove that it is always into we need to construct the arrows  $\sigma, \tau$  which are a decomposition of a section of  $j_{\mathcal{B}}$ . Let us remark that, when  $\text{Prim}(\mathcal{B})$  is free as a

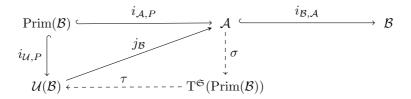


Figure 1: The sub-bialgebra  $\mathcal{A}$  generated by primitive elements.

A-module, the proof of this fact is a consequence of the PBW theorem<sup>10</sup>. But, here, we will construct the section in the general case using projectors which are now classical for the free case but which still can be computed analytically as they lie in  $\mathbb{Q}[[X]]$  and still converge in  $\mathcal{A}$ .

*Proof.* (Injectivity of  $j_{\mathcal{B}}$ , construction of the section  $\tau \circ \sigma$ ). —

Let  $\mathcal{A}$  be the subalgebra of  $\mathcal{B}$  generated by  $\text{Prim}(\mathcal{B})$ , it is straightforward to check that  $\text{Im}(j_{\mathcal{B}}) = \mathcal{A}$ .

Remark that all series  $\sum_{n\geq 0} a_n(I_+)^{*n}$  are summable on  $\mathcal{A}$  (not in general on  $\mathcal{B}$  for example in case of non-trivial group-like elements).

We first prove that

$$\pi_1 = \log_*(I) = \sum_{n \ge 1} \frac{(-1)^{n-1}}{n} (I_+)^{*n}$$
(37)

is a projector  $\mathcal{A} \to \operatorname{Prim}(\mathcal{B})$ . The key point is that  $\Delta_{\mathcal{A}}$  (the restriction of the comultiplication to  $\mathcal{A}$ ) is a morphism of bialgebras <sup>11</sup>  $\mathcal{A} \to \mathcal{A} \otimes \mathcal{A}$ . We begin by to proving that  $\Delta_{\mathcal{A}}$  "commutes" with the convolution. This is a consequence of the following property

**Lemma 1.** i) Let  $f_i \in \text{End}(\mathcal{B}_i)$ , be such that  $\varphi f_1 = f_2 \varphi$ .



Figure 2: Intertwining with a morphism of bialgebras (the functions of  $f_i$  below will be computed with the respective convolution products).

i) Then, if  $P \in A[X]$ , one has

$$\varphi P(f_1) = P(f_2)\varphi . \tag{38}$$

ii) If the series  $\sum_{n\geq 0} (I_{(i)}^+)^{*n}$ , i=1,2 are summable, if  $f_1(1)=0$  and  $S\in A[[X]]$ , then the families  $(\langle S\mid X^n\rangle f_i^{*n})_{n\in\mathbb{N}}$  are summable, we denote  $S(f_i)$  their sums (this definition is coherent with the preceding when S is a polynomial). One has, for the convolution product,

$$\varphi S(f_1) = S(f_2)\varphi . \tag{39}$$

*Proof.* The only delicate part is (ii). First, one remarks that, if  $\varphi$  is a morphism of bialgebras, one has

$$(\varphi \otimes \varphi) \circ \Delta_1^+ = \Delta_2^+ \circ \varphi \tag{40}$$

then, the image by  $\varphi$  of an element of order less than N (i.e. such that  $\Delta_1^{+(N)}(x)=0$ ) is of order less than N. Let now S be an univariate series

 $S = \sum_{k=0}^{\infty} a_k X^k$ . For every element x of order less than N and  $f \in End(\mathcal{B})$  such that  $f(1_{\mathcal{B}}) = 0$ , one has

$$S(f)(x) = \sum_{k=0}^{\infty} a_k f^{*k}(x) = \sum_{k=0}^{\infty} a_k \mu^{(k-1)} f^{\otimes k} \Delta^{(k-1)}(x)$$

$$= \sum_{k=0}^{\infty} a_k \mu^{(k-1)}(f^{\otimes k}) \circ (I_+^{\otimes k}) \Delta^{(k-1)}(x)$$

$$= \sum_{k=0}^{N} a_k \mu^{(k-1)}(f^{\otimes k}) \Delta_+^{(k-1)}(x) . \tag{41}$$

This proves, in view of (i) that  $\varphi \circ S(f_1) = S(f_2) \circ \varphi$ .

We reprove (credits Reutenauer, Patras, Solomon) that  $\pi_1$  is a projector  $\mathcal{B} \to \operatorname{Prim}(\mathcal{B})$  by means of the following lemma.

*Proof.* The only delicate part is (ii). First, one remarks that, if  $\varphi$  is a morphism of bialgebras, one has

$$(\varphi \otimes \varphi) \circ \Delta_1^+ = \Delta_2^+ \circ \varphi \tag{42}$$

then, the image by  $\varphi$  of an element of order less than N (i.e. such that  $\Delta_1^{+(N)}(x)=0$ ) is of order less than N. Let now S be an univariate series  $S=\sum_{k=0}^\infty a_k X^k$ . For every element x of order less than N and  $f\in End(\mathcal{B})$  such that, one has

$$S(f)(x) = \sum_{k=0}^{\infty} a_k f^{*k}(x) = \sum_{k=0}^{\infty} a_k \mu^{(k-1)} f^{\otimes k} \Delta^{(k-1)}(x)$$

$$= \sum_{k=0}^{\infty} a_k \mu^{(k-1)}(f^{\otimes k}) \circ (I_+^{\otimes k}) \Delta^{(k-1)}(x)$$

$$= \sum_{k=0}^{N} a_k \mu^{(k-1)}(f^{\otimes k}) \Delta_+^{(k-1)}(x) . \tag{43}$$

This proves, in view of (i) that  $\varphi \circ S(f_1) = S(f_2) \circ \varphi$ .

Now, in case  $\mathcal{B}$  is cocommutative, the comultiplication  $\Delta$  is a morphism of bialgebras, so one has

$$\Delta \circ log_*(I) = log_*(I \otimes I) \circ \Delta \tag{44}$$

But

$$log_*(I \otimes I) = log_*(I \otimes e) * (e \otimes I)$$

$$= log_*(I \otimes e) + log_*(e \otimes I)$$

$$= log_*(I) \otimes e + e \otimes log_*(I)$$
(45)

Then

$$\Delta(log_*(I)) = (log_*(I) \otimes e + e \otimes log_*(I)) \circ \Delta \tag{46}$$

which implies that  $log_*(I)(\mathcal{B}) \subset Prim(\mathcal{B})$ . To finish to prove that  $\pi_1$  is a projector onto  $Prim(\mathcal{B})$ , one has just to remark that, for  $x \in Prim(\mathcal{B})$  and  $n \ge 2 \; (\mathrm{Id}^+)^{*n}(x) = 0 \; \mathrm{then}$ 

$$log_*(I)(x) = Id^+(x) = x$$
. (47)

Now, we consider

$$I_{\mathcal{A}} = exp_*(log_*(I_{\mathcal{A}})) = \sum_{n \ge 0} \frac{1}{n!} \pi_{1,[\mathcal{A}]}^{*n} .$$
 (48)

where  $\pi_{1,[\mathcal{A}]} = log_*(I_{\mathcal{A}})$ .

Let us prove that the summands form an resolution of unity.

First, one defines  $\mathcal{A}_{[n]}$  as the linear span of the powers  $\{P^n\}_{P\in \mathrm{Prim}(\mathcal{B})}$  or, equivalently of the symmetrized products

$$\frac{1}{n!} \sum_{\sigma \in \mathfrak{S}_n} P_{\sigma(1)} P_{\sigma(2)} \cdots P_{\sigma(n)} . \tag{49}$$

It is obvious that  $\operatorname{Im}(\pi_{1,[\mathcal{A}]}^{*n}) \subset \mathcal{A}_{[n]}$ . We remark that

$$\pi_{1,[\mathcal{A}]}^{*n} = \mu_{\mathcal{B}}^{(n-1)} \pi_{1,[\mathcal{A}]}^{\otimes n} \Delta^{(n-1)} = \mu_{\mathcal{B}}^{(n-1)} \pi_{1,[\mathcal{A}]}^{\otimes n} I_{+}^{\otimes n} \Delta^{(n-1)} = \mu_{\mathcal{B}}^{(n-1)} \pi_{1,[\mathcal{A}]}^{\otimes n} \Delta_{+}^{(n-1)}$$
(50)

as  $\pi_{1,[\mathcal{A}]}I_+ = \pi_{1,[\mathcal{A}]}$ . Now, let  $P \in \text{Prim}(\mathcal{A})$ . We compute  $\pi_{1,[\mathcal{A}]}^{*n}(P^m)$ . Indeed, if m < n, one has

$$\pi_{1,[\mathcal{A}]}^{*n}(P^m) = \mu_{\mathcal{B}}^{n-1} \Delta_{+}^{n-1}(P^m) = 0 . \tag{51}$$

If n = m, one has, from (35)

$$\Delta_{\perp}^{n-1}(P^n) = n! P^{\otimes n} \tag{52}$$

and hence  $\pi_{1,[\mathcal{A}]}^{*n}$  is the identity on  $\mathcal{A}_{[n]}$ . If m > n, the nullity of  $\pi_{1,[\mathcal{A}]}^{*n}(P^m)$  is a consequence of the following lemma.

**Lemma 2.** Let  $\mathcal{B}$  be a bialgebra and P a primitive element of  $\mathcal{B}$ . Then

- i) The series  $log_*(I)$  is summable on each power  $P^m$
- ii)  $log_*(I)(P^m) = 0$  for m > 2

*Proof.* i) As  $\Delta_+^{*N}(P^m)=0$  for N>m, one has  $I_+^{*N}(P^m)=0$  for these values. ii) The morphism of AAU  $\varphi_P:A[X]\to\mathcal{B}$ , defined by

$$\varphi_P(X) = P \tag{53}$$

is, in fact a morphism of bialgebras and one checks easily that One has just to

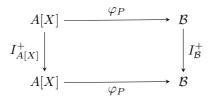

check that  $\pi_{1,[A[X]]}(X^m) = 0$  for m > 2 which is a consequence of the equality

$$\sum_{w \in Y^*} (w \otimes \pi_1(w)) = \log(\sum_{w \in Y^*} w \otimes w)$$
 (54)

because, for Y = X one has

$$\log(\sum_{w \in Y^*} w \otimes w) = \log(\sum_{n \geq 0} X^n \otimes X^n) = \log(\sum_{n \geq 0} \frac{1}{n!} (X \otimes X)^{(\sqcup \sqcup \otimes conc) n}) = \log(\exp(X \otimes X)) = X \otimes X$$
(55)

this proves that  $\pi_{1,[A]}^{*n}(\mathcal{A}_{[m]})=0$  for  $m\neq n$  and hence the summands of the sum

$$I_{\mathcal{A}} = exp_*(log_*(I_{\mathcal{A}})) = \sum_{n>0} \frac{1}{n!} \pi_{1,[\mathcal{A}]}^{*n} .$$
 (56)

are pairwise orthogonal projectors with  $\operatorname{Im}(\pi_{1,[A]}^{*n}) = A_{[n]}$  and then

$$\mathcal{A} = \bigoplus_{n > 0} \mathcal{A}_{[n]} . \tag{57}$$

This decomposition permits to construct  $\sigma$  by

$$\sigma(P^n) = \frac{1}{n!} \Delta_+^{(n-1)}(P^n) \in T_n(\operatorname{Prim}(\mathcal{B}))$$
(58)

and  $\sigma(1_{\mathcal{B}}) = 1_{T(\text{Prim}(\mathcal{B}))}$ . One checks easily that  $j_{\mathcal{B}} \circ \tau \circ \sigma = Id_{\mathcal{A}}$ .

### 2.2.2 The theorem from the point of view of summability

The bialgebra  $\mathcal{B}$  being supposed cocommutative, we discuss the equivalent conditions under which we are in the presence of an enveloping algebra i.e.

$$\mathcal{B} \cong_{A-bialg} \mathcal{U}(Prim(\mathcal{B})) \tag{59}$$

from the point of view of the convergence of the series  $log_*(I)^{12}$ . These conditions are known as the theorem of Cartier-Quillen-Milnor-Moore (CQMM).

**Theorem 1.** [4] Let  $\mathcal{B}$  be a A-cocommutative bialgebra (A is a  $\mathbb{Q}$ -AAU) and  $\mathcal{A}$ , as above, the subalgebra generated by  $\operatorname{Prim}(\mathcal{B})$ . Then, the following conditions are equivalent:

i) B admits an increasing filtration

$$\mathcal{B}_0 = A.1_{\mathcal{B}} \subset \mathcal{B}_1 \subset \cdots \subset \mathcal{B}_n \subset \mathcal{B}_{n+1} \cdots$$

compatible with the structures of algebra (i.e. for all  $p, q \in \mathbb{N}$ , one has  $\mathcal{B}_p \mathcal{B}_q \subset \mathcal{B}_{p+q}$ ) and coalgebra:

$$\forall n \in \mathbb{N}, \quad \Delta(\mathcal{B}_n) \subset \sum_{p+q=n} \mathcal{B}_p \otimes \mathcal{B}_q.$$

- ii)  $((\mathrm{Id}^+)^{*n})_{n\in\mathbb{N}}$  is summable in  $\mathrm{End}(\mathcal{B})$ .
- iii)  $\mathcal{B} = \mathcal{A}$ .

*Proof.* We prove

$$(ii) \Longrightarrow (iii) \Longrightarrow (i) \Longrightarrow (ii)$$
 (61)

$$(ii) \Longrightarrow (iii).$$
 —

The image of  $j_{\mathcal{B}}$  it is the subalgebra generated by the primitive elements. Let us prove that, when  $((\mathrm{Id}^+)^{*n})_{n\in\mathbb{N}}$  is summable, one has  $\mathrm{Im}(j_{\mathcal{B}})=\mathcal{B}$ . The series  $\log(1+X)$  is without constant term so, in virtue of (28) and the summability of  $((\mathrm{Id}^+)^{*n})_{n\in\mathbb{N}}$ , one has

$$exp(log(e+Id^+)) = exp(log(1+X))(Id^+) = 1_{End(B)} + Id^+ = e+Id^+ = I$$
 (62)

Set  $\pi_1 = log(e + \mathrm{Id}^+)$ .

To end this part, let us compute, for  $x \in \mathcal{B}$ 

$$x = exp(\pi_1)(x) = \left(\sum_{n \ge 0} \frac{1}{n!} \pi_1^{*n}\right)(x) = \left(\sum_{n=0}^{N} \frac{1}{n!} \mu^{(n-1)} \pi_1^{\otimes n}\right) \Delta^{(n-1)}(x)$$
 (63)

where N is the first order for which  $\Delta^{+(n-1)}(x) = 0$  (as  $\pi_1 \circ \mathrm{Id}^+ = \pi_1$ ). This proves that  $\mathcal{B}$  is generated by its primitive elements.

$$(iii) \Longrightarrow (i).$$

$$\sum_{n>1} \frac{(-1)^{n-1}}{n} (I^+)^{*n} . {(60)}$$

The family  $(\frac{(-1)^{n-1}}{n}(I^+)^{*n})_{n\geq 0}$  is summable iff  $((I^+)^{*n})_{n\geq 0}$  is (use eq.20 ).

**Remark 1.** i) The equivalence  $(i) \iff (iii)$  is the classical CQMM theorem (see [4]). The equivalence with (ii) could be called the "Convolutional CQMM theorem". The combinatorial aspects of this last one will be the subject of a forthcoming paper [CT, HNM, GHED Nguyen?]

ii) When  $Prim(\mathcal{B})$  is free, we have  $\mathcal{B} \cong_{k-bialg} \mathcal{U}(Prim(\mathcal{B}))$  and  $\mathcal{B}$  is an enveloping algebra.

# 3 Case study : $\phi$ -deformed stuffle

### 3.1 Results for the $\phi$ -deformed stuffle

Let  $Y = \{y_i\}_{i \in I}$  be still a totally ordered alphabet and  $A\langle Y \rangle$  be equipped with the  $\phi$ -deformed stuffle defined by

- i) for any  $w \in Y^*$ ,  $1_{Y^*} \coprod_{\phi} w = w \coprod_{\phi} 1_{Y^*} = w$ ,
- ii) for any  $y_i, y_j \in Y$  and  $u, v \in Y^*$ ,

$$y_i u \coprod_{\phi} y_i v = y_i (y_i u \coprod_{\phi} v) + y_i (u \coprod_{\phi} y_i v) + \phi(y_i, y_i) u \coprod_{\phi} v, \quad (64)$$

where  $\phi$  is an arbitrary mapping

$$\phi: Y \times Y \longrightarrow AY$$
.

### Definition 2. Let

$$\phi: Y \times Y \longrightarrow AY$$

defined by its structure constants

$$(y_i, y_j) \longmapsto \phi(y_i, y_j) = \sum_{k \in I} \gamma_{i,j}^k y_k.$$

**Proposition 3.** The recursion (64) defines a unique mapping

$$\coprod_{\phi}: Y^* \times Y^* \longrightarrow A\langle Y \rangle.$$

*Proof.* Let us denote  $(Y^* \times Y^*)_{\leq n}$  the set of words  $(u, v) \in Y^* \times Y^*$  such that  $|u| + |v| \leq n$ . We construct a sequence of mappings

$$\biguplus_{\phi \leq n} : (Y^* \times Y^*)_{\leq n} \longrightarrow AY.$$

which satisfy the recursion of eq.64 . For n=0, we have only a premiage and  $\coprod_{\phi \leq 0} (1_{Y^*}) = 1_{Y^*} \otimes 1_{Y^*}$ . Suppose  $\coprod_{\phi \leq n}$  constructed and let

 $(u,v) \in (Y^* \times Y^*)_{\leq n+1} \setminus (Y^* \times Y^*)_{\leq n}$ , i.e. |u| + |v| = n+1.

One has three cases:  $u = 1_{Y^*}$ ,  $v = 1_{Y^*}$  and  $(u, v) \in Y^+ \times Y^+$ . For the two first, one uses the initialisation of the recursion thus

$$\coprod_{\phi \leq n+1} (w, 1_{Y^*}) = \coprod_{\phi \leq n+1} (1_{Y^*}, w) = w$$

for the last case, write  $u = y_i u'$ ,  $v = y_i v'$  and use, to get

$$\text{ if } \phi \leq n+1}(y_iu',y_jv') = y_i \text{ if } \phi \leq n}(u',y_jv') + y_j \text{ if } \phi \leq n}(y_iu',v') + y_{i+j} \text{ if } \phi \leq n}(u',v') + y_{i+j} \text{ if } \phi \leq n}(u',v')$$

this proves the existence of the sequence  $(\ \ \ \ \ \phi_{\leq n})_{n\geq 0}$ . Every  $\ \ \ \ \ \phi_{\leq n+1}$  extends the preceding so there is a mapping

which extends all the  $\coprod_{\phi \leq n+1}$  (the graph of which is the union of the graphs of the  $\coprod_{\phi \leq n}$ ). This proves the existence. For unicity, just remark that, if there were two mappings  $\coprod_{\phi}$ ,  $\coprod_{\phi}'$ , the fact that they must fulfill the recursion (64) implies that  $\coprod_{\phi} = \coprod_{\phi}'$ .

We still denote  $\phi$  and  $\bowtie_{\phi}$  the linear extension of  $\phi$  and  $\bowtie_{\phi}$  to  $AY \otimes AY$  and  $A\langle Y \rangle \otimes A\langle Y \rangle$  respectively.

Then  $\coprod_{\phi}$  is a law of algebra (with  $1_{Y^*}$  as unit) on  $A\langle Y \rangle$ .

**Lemma 3.** Let  $\Delta$  be the morphism  $A\langle Y \rangle \to A\langle\!\langle Y^* \otimes Y^* \rangle\!\rangle$  defined on the letters by

$$\Delta(y_s) = y_s \otimes 1 + 1 \otimes y_s + \sum_{n \ m \in I} \gamma_{n,m}^s \, y_n \otimes y_m \tag{65}$$

Then

i) for all  $w \in Y^+$  we have

$$\Delta(w) = w \otimes 1 + 1 \otimes w + \sum_{u,v \in Y^{+}} \langle \Delta(w) \mid u \otimes v \rangle u \otimes v$$
 (66)

ii) for all  $u, v, w \in Y^*$ , one has

$$\langle u \bowtie_{\phi} v \mid w \rangle = \langle u \otimes v \mid \Delta(w) \rangle^{\otimes 2} \tag{67}$$

*Proof.* i) By recurrence on |w|. If  $w = y_s$  is of length one, it is obvious from the definition. If  $w = y_s w'$ , we have, from the fact that  $\Delta$  is a morphism

$$\Delta(w) = \left( y_s \otimes 1 + 1 \otimes w + \sum_{i,j \in I} \gamma_{i,j}^s y_i \otimes y_j \right)$$
$$\left( w' \otimes 1 + 1 \otimes w' + \sum_{u,v \in Y^+} \langle u \otimes v \mid \Delta(w') \rangle \right)$$
(68)

the development of which proves that  $\Delta(w)$  is of the desired form.

ii) Let  $S(u,v) := \sum_{w \in Y^*} \langle u \otimes v \mid \Delta(w) \rangle w$ . It is easy to check (and left to the reader) that, for all  $u \in Y^*$ , S(u,1) = S(1,u) = u. Let us now prove that, for all  $y_i, y_j \in Y$  and  $u, v \in Y^*$ 

$$S(y_i u, y_j v) = y_i S(u, y_j v) + y_j S(y_i u, v) + \phi(y_i, y_j) S(u, v)$$
 (69)

Indeed, remarking that  $\Delta(1) = 1 \otimes 1$ , one has

$$\begin{split} S(y_iu,y_jv) &= \sum_{w \in Y^*} \langle y_iu \otimes y_jv \mid \Delta(w) \rangle w = \sum_{w \in Y^+} \langle y_iu \otimes y_jv \mid \Delta(w) \rangle w \\ &= \sum_{y_s \in Y, \ w' \in Y^*} \langle y_iu \otimes y_jv \mid \Delta(y_sw') \rangle \ y_sw' \\ &= \sum_{y_s \in Y, \ w' \in Y^*} \langle y_iu \otimes y_jv \mid \left(y_s \otimes 1 + 1 \otimes y_s + \sum_{n,m \in I} \gamma_{n,m}^s \ y_n \otimes y_m\right) \Delta(w') \rangle \ y_sw' \\ &= \sum_{y_s \in Y, \ w' \in Y^*} \langle y_iu \otimes y_jv \mid (y_s \otimes 1) \Delta(w') \rangle \ y_sw' \\ &+ \sum_{y_s \in Y, \ w' \in Y^*} \langle y_iu \otimes y_jv \mid (1 \otimes y_s) \Delta(w') \rangle \ y_sw' \\ &+ \sum_{y_s \in Y, \ w' \in Y^*} \langle y_iu \otimes y_jv \mid (\sum_{n,m \in I} \gamma_{n,m}^s \ y_n \otimes y_m) \Delta(w') \rangle \ y_sw' \\ &= \sum_{w' \in Y^*} \langle u \otimes y_jv \mid \Delta(w') \rangle \ y_iw' + \sum_{w' \in Y^*} \langle y_iu \otimes v \mid \Delta(w') \rangle \ y_jw' \\ &+ \sum_{y_s \in Y, \ w' \in Y^*} \langle u \otimes v \mid \gamma_{i,j}^s \Delta(w') \rangle \ y_sw' \\ &= y_i \sum_{w' \in Y^*} \langle u \otimes y_jv \mid \Delta(w') \rangle \ w' + y_j \sum_{w' \in Y^*} \langle y_iu \otimes v \mid \Delta(w') \rangle w' \\ &+ \sum_{y_s \in Y} \gamma_{i,j}^s \ y_s \sum_{w' \in Y^*} \langle u \otimes v \mid \Delta(w') \rangle \ w' \\ &= y_i S(u, y_jv) + y_j S(y_iu, v) + \phi(y_i, y_j) S(u, v) \end{split}$$

then the computation of S shows that, for all  $u, v \in Y^*$ ,  $S(u, v) = u \coprod_{\phi} v$  as S is bilinear, one has  $S = \coprod_{\phi}$ .

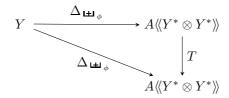

(ii) Likewise, if  $\phi$  is associative, let us define the operators

and, similarly,

which proves the claim.

b) If A is a field of characteristic 0 then  $\mathcal{B}_{\phi}$  is an enveloping bialgebra if and only if the algebra AX admits an increasing filtration  $((AY)_n)_{n\in\mathbb{N}}$  with  $(AY)_0 = \{0\}$  and compatible with both the multiplication and the comultiplication  $\Delta_{\mathbf{H}_{\phi}}$  i.e.

one gets mutually dual Hopf algebras  $\mathcal{H}_{\mathbf{H}_{\phi}} = (\mathbb{Q}\langle Y \rangle, \mathsf{conc}, 1_{Y^*}, \Delta_{\mathbf{H}_{\phi}}, \epsilon, a_{\mathbf{H}_{\phi}})$  and  $\mathcal{H}_{\mathbf{H}_{\phi}}^{\vee} = (\mathbb{Q}\langle Y \rangle, \mathbf{H}_{\phi}, 1_{Y^*}, \Delta_{\mathsf{conc}}, \epsilon, a_{\mathbf{H}_{\phi}}).$ 

**Lemma 4.** Let  $\mathcal{P} = \{P \in \mathbb{Q}\langle Y \rangle \mid \Delta_{\mathbf{H}_{\phi}}P = P \otimes 1 + 1 \otimes P\}$ . Then  $\mathcal{P}$  is stable by the Lie bracket and by linear combinations.

Proof. Since  $\Delta_{\mbox{\ \tiny LL}_{\phi}}y_1=y_1\otimes 1+1\otimes y_1$  then  $\mathcal{P}\neq\emptyset$ . Let  $P,Q\in\mathcal{P}$  and  $p,q\in\mathbb{Q}$ . Firstly, since  $\Delta_{\mbox{\ \tiny LL}_{\phi}}([P,Q])=\Delta_{\mbox{\ \tiny LL}_{\phi}}(PQ-QP)=\Delta_{\mbox{\ \tiny LL}_{\phi}}(PQ)-\Delta_{\mbox{\ \tiny LL}_{\phi}}(QP),$   $\Delta_{\mbox{\ \tiny LL}_{\phi}}(QP)=(\Delta_{\mbox{\ \tiny LL}_{\phi}}Q)(\Delta_{\mbox{\ \tiny LL}_{\phi}}P)$  and  $\Delta_{\mbox{\ \tiny LL}_{\phi}}(PQ)=(\Delta_{\mbox{\ \tiny LL}_{\phi}}P)(\Delta_{\mbox{\ \tiny LL}_{\phi}}Q)$  then one has  $\Delta_{\mbox{\ \tiny LL}_{\phi}}([P,Q])=\Delta_{\mbox{\ \tiny LL}_{\phi}}([P,Q])\otimes 1+1\otimes\Delta_{\mbox{\ \tiny LL}_{\phi}}([P,Q])$  meaning that  $[P,Q]\in\mathcal{P}$  and  $\mathcal{P}$  is stable by the Lie bracket. **Lemma 5.** With the notations of Lemma 4, then  $Y \subset \mathcal{P} \iff \mathcal{L}ie_{\mathbb{Q}}\langle Y \rangle = \mathcal{P}$ .

Proof. Since  $\mathcal{L}ie_{\mathbb{Q}}\langle Y \rangle$  is the smallest algebra containing Y and it is stable by the Lie bracket and by linear combinations then, by Lemma 4,  $\mathcal{P} \subset \mathcal{L}ie_{\mathbb{Q}}\langle Y \rangle$ . If  $\mathcal{P} = \mathcal{L}ie_{\mathbb{Q}}\langle Y \rangle$  then  $Y \subset \mathcal{P}$ . Conversely, if  $Y \subset \mathcal{P} \subset \mathcal{L}ie_{\mathbb{Q}}\langle Y \rangle$  then, by definition,  $\mathcal{L}ie_{\mathbb{Q}}\langle Y \rangle \subset \mathcal{P}$ .

**Proposition 4.** With the notations of Lemma 4, then  $\mathcal{P} \subseteq \mathcal{L}ie_{\mathbb{Q}}\langle Y \rangle$ .

*Proof.* For any  $k \geq 2$  the letter  $y_k$  is a Lie polynomial but, by (??), one has  $\Delta_{\coprod_{\alpha}} y_k \neq y_k \otimes 1 + 1 \otimes y_k$ . Thus, by Lemma 5, it follows the conclusion.

**Lemma 6** (Friedrichs criterium). Let  $S \in \mathbb{Q}\langle\!\langle Y \rangle\!\rangle$  such that  $\langle S \mid 1_{Y^*} \rangle = 1$ . Then, for the co-product  $\Delta_{\coprod_{\phi}}$ ,

i) S is primitive, i.e.  $\Delta_{\square\square\square d}S = S \otimes 1 + 1 \otimes S$ , if and only if,

$$\forall u, v \in Y^+, \qquad \langle S \mid u \perp \omega v \rangle = 0.$$

ii) S is group-like, i.e.  $\Delta_{\coprod_{\phi}} S = S \otimes S$ , if and only if,

$$\forall u, v \in Y^+, \qquad \langle S \mid u \perp \!\!\!\perp_{\phi} v \rangle = \langle S \mid u \rangle \langle S \mid v \rangle.$$

*Proof.* The expected equivalence is due respectively to the following facts

$$\Delta \coprod S = S \otimes 1 + 1 \otimes S - \langle S \mid 1_{Y^*} \otimes 1_{Y^*} \rangle 1 \otimes 1 + \sum_{u,v \in Y^+} \langle S \mid u \coprod_{\phi} v \rangle u \otimes v,$$

$$\Delta \coprod S = \sum_{u,v \in Y^*} \langle S \mid u \coprod {}_\phi v \rangle u \otimes v \quad \text{and} \quad S \otimes S = \sum_{u,v \in Y^*} \langle S \mid u \rangle \langle S \mid v \rangle u \otimes v.$$

**Lemma 7.** Let  $S \in \mathbb{Q}\langle\langle Y \rangle\rangle$  such that  $\langle S \mid 1_{Y^*} \rangle = 1$ . Then, for the co-product  $\Delta_{\coprod_{\phi}}$ , S is group-like if and only if S is primitive.

$$\log(1+S) = \sum_{n>1} \frac{(-1)^{n-1}}{n} S^n \quad \text{and} \quad \exp(S) = \sum_{n>1} \frac{S^n}{n!}.$$

and one has usual formulas  $\log(\exp(S)) = S$  and  $\exp(\log(1+S)) = 1 + S$ .

*Proof.* Since  $\Delta_{\mathbf{H}_{\phi}}$  and the maps  $T \mapsto T \otimes 1$ ,  $T \mapsto 1 \otimes T$  are continous homomorphisms then if  $\log S$  is primitve then  $\Delta_{\mathbf{H}_{\phi}}(\log S) = \log S \otimes 1 + 1 \otimes \log S$  (see Lemma 6(90)) and since  $\log S \otimes 1$  and  $1 \otimes \log S$  commute then we get successily

This means S is group-like. The reciprocal can be obtained in the same way.  $\square$ 

**Lemma 8.** Let  $\{\chi_l\}_{l \in \mathcal{L}ynY}$  be a transcendence basis of  $(\mathbb{Q}\langle Y \rangle, \coprod_{\phi})$  and let  $\{\chi_w\}_{w \in Y^*}$  be the completed basis of  $(\mathbb{Q}\langle Y \rangle, \coprod_{\phi})$  (viewed as a  $\mathbb{Q}$ -module) defined by, for any  $w = l_1 \ldots l_n$  with  $l_1, \ldots, l_n \in \mathcal{L}ynY$  and  $l_1 \geq \ldots \geq l_n$ ,

$$\chi_w = \chi_{l_1} \coprod_{\phi} \dots \coprod_{\phi} \chi_{l_n}$$

in duality with  $\{\xi_w\}_{w\in Y^*}$ :

$$\forall u, v \in Y^*, \quad \langle \chi_u \mid \xi_v \rangle = \delta_{u,v}.$$

Then, for any  $w = l_1 \dots l_n$  with  $l_1, \dots, l_n \in \mathcal{L}ynY$  and  $l_1 \geq \dots \geq l_n$ , one has

$$\langle \chi_w \mid 1_{Y^*} \rangle = \langle \xi_w \mid 1_{Y^*} \rangle = 0 \quad and \quad \langle \chi_w \mid \chi_{l_1} \dots \chi_{l_n} \rangle = \langle \xi_w \mid \chi_{l_1} \dots \chi_{l_n} \rangle = 1.$$

*Proof.* It is immediate by construction and by duality.

**Lemma 9.** With the notations of Lemma 8, if  $w \notin \mathcal{L}ynY$  and if

$$\forall l \in \mathcal{L}ynY, \quad \langle \chi_{l_1} \coprod_{\phi} \dots \coprod_{\phi} \chi_{l_n} \mid \xi_l \rangle = 0$$

then the polynomials  $\{\xi_l\}_{l\in\mathcal{L}ynY}$  are primitive, for the co-product  $\Delta_{\perp \perp \downarrow_{\phi}}$ .

*Proof.* We have

$$\begin{array}{lcl} \Delta_{\ \ \square \hspace{-0.1cm}\square_{\phi}} \xi_{l} & = & \displaystyle \sum_{u \in Y^{+}} \langle u \ \square \hspace{-0.1cm}\square_{\phi} 1_{Y^{*}} \mid \xi_{l} \rangle u \otimes 1 + \displaystyle \sum_{v \in Y^{+}} \langle 1_{Y^{*}} \ \square \hspace{-0.1cm}\square_{\phi} v \mid \xi_{l} \rangle 1 \otimes v \\ & + & \displaystyle \sum_{u,v \in Y^{+}} \langle u \ \square \hspace{-0.1cm}\square_{\phi} v \mid \xi_{l} \rangle u \otimes v + \langle 1_{Y^{*}} \ \square \hspace{-0.1cm}\square_{\phi} 1_{Y^{*}} \mid \xi_{l} \rangle 1 \otimes 1 \\ & = & \displaystyle \xi_{l} \otimes 1 + 1 \otimes \xi_{l}. \end{array}$$

$$\langle S_1 \bowtie_{\phi} \dots \bowtie_{\phi} S_n \mid P_1 \dots P_n \rangle = \sum_{\sigma \in \mathfrak{S}_n} \prod_{i=1}^n \langle S_i \mid P_{\sigma(i)} \rangle.$$

iii) If n < m then, by considering the language  $\mathcal{M}$  over  $\mathcal{A} = \{P_1, \dots, P_m\}$ 

$$\mathcal{M} = \{ w \in \mathcal{A}^* | w = P_{j_1} \dots P_{j_{|w|}}, j_1 < \dots < j_{|w|}, |w| \ge 1 \}$$

and the morphism  $\mu: \mathbb{Q}\langle A \rangle \longrightarrow \mathbb{Q}\langle Y \rangle$ , one has:

$$\langle S_1 \coprod_{\phi} \dots \coprod_{\phi} S_n \mid P_1 \dots P_m \rangle = \sum_{\substack{w_1, \dots, w_m \in \mathcal{M} \\ w_1 \coprod_{\phi} \dots \coprod_{\phi} w_m = P_1 \dots P_m}} \prod_{i=1}^n \langle S_i \mid \mu(w_i) \rangle.$$

*Proof.* On the one hand, since the  $P_i$ 's are primitive then

$$\Delta^{(n-1)}_{\,\,\, \, \, \coprod_{\,\, \phi}}(P_i) \quad = \quad \sum_{p+q=n-1} 1^{\otimes p} \otimes P_i \otimes 1^{\otimes q}.$$

On the other hand, one has  $\Delta^{(n-1)}_{\mathbf{H}_{\phi}}(P_1 \dots P_m) = \Delta^{(n-1)}_{\mathbf{H}_{\phi}}(P_1) \dots \Delta^{(n-1)}_{\mathbf{H}_{\phi}}(P_m)$  and  $\langle S_1 \coprod_{\phi} \dots \coprod_{\phi} S_n \mid P_1 \dots P_m \rangle = \langle S_1 \otimes \dots \otimes S_n \mid \Delta^{(n-1)}_{\mathbf{H}_{\phi}}(P_1 \dots P_m) \rangle$ . Hence,

$$\langle S_1 \, \mathbf{u}_{\phi} \, \dots \, \mathbf{u}_{\phi} S_n \mid P_1 \dots P_m \rangle \quad = \quad \langle \bigotimes_{i=1}^n S_i \mid \prod_{i=1}^m \sum_{p+q=n-1} 1^{\otimes p} \otimes P_i \otimes 1^{\otimes q} \rangle.$$

- i) For n > m, by expanding  $\Delta_{\mathbf{H}_{J}}^{(n-1)}(P_{1}) \dots \Delta_{\mathbf{H}_{J}}^{(n-1)}(P_{m})$ , one obtains a sum of tensors contening at least one factor equal to 1. For j = 1, ..., n, the formal power series  $S_{j}$  is proper and the result follows immediatly.
- ii) For n = m, since

$$\prod_{i=1}^n \Delta_{\frac{1+1}{\sigma}}^{(n-1)}(P_i) \quad = \quad \sum_{\sigma \in \mathfrak{S}_n} \bigotimes_{i=1}^n P_{\sigma(i)} + Q,$$

where Q is sum of tensors contening at least one factor equal to 1 and the  $S_j$ ,'s are proper then  $\langle S_1 \otimes \ldots \otimes S_n \mid Q \rangle = 0$ . Thus, the result follows.

iii) For n < m, since, for j = 1, ..., n, the power series  $S_j$  is proper then the expected result follows by expanding the product

$$\prod_{i=1}^m \Delta^{(n-1)}_{\mbox{\tiny $\mathsf{LHJ}$}_\phi}(P_i) \quad = \quad \prod_{i=1}^m \sum_{p+q=n-1} 1^{\otimes p} \otimes P_i \otimes 1^{\otimes q}..$$

**Definition 3.** Let  $\pi_1$  and  $\check{\pi}_1$  be the mutually adjoint degree-preserving linear endomorphisms of  $\mathbb{Q}\langle Y \rangle$  given by, for any  $w \in Y^+$ ,

$$\begin{array}{lcl} \pi_1(w) & = & w + \sum_{k \geq 2} \frac{(-1)^{k-1}}{k} \sum_{u_1, \dots, u_k \in Y^+} \langle w \mid u_1 \bowtie_{\phi} \dots \bowtie_{\phi} u_k \rangle u_1 \dots u_k, \\ \\ \check{\pi}_1(w) & = & w + \sum_{k \geq 2} \frac{(-1)^{k-1}}{k} \sum_{u_1, \dots, u_k \in Y^+} \langle w \mid u_1 \dots u_k \rangle u_1 \bowtie_{\phi} \dots \bowtie_{\phi} u_k. \end{array}$$

In particular, for any  $y_k \in Y$ , the polynomials  $\pi_1(y_k)$  and  $\check{\pi}_1(y_k)$  are given by

$$\pi_1(y_k) = y_k + \sum_{l \ge 2} \frac{(-1)^{l-1}}{l} \sum_{\substack{j_1, \dots, j_l \ge 1 \\ j_1 + \dots + j_l = k}} y_{j_1} \dots y_{j_l} \quad and \quad \check{\pi}_1(y_k) = y_k.$$

**Proposition 5.** Let  $\mathcal{D}_Y$  be the diagonal series over Y:

$$\mathcal{D}_Y = \sum_{w \in Y^*} w \otimes w.$$

Then

$$i) \log \mathcal{D}_Y = \sum_{w \in Y^+} w \otimes \pi_1(w) = \sum_{w \in Y^+} \check{\pi}_1(w) \otimes w.$$

ii) For any  $w \in Y^*$ , we have

$$w = \sum_{k\geq 0} \frac{1}{k!} \sum_{u_1,\dots,u_k\in Y^*} \langle w \mid u_1 \coprod_{\phi} \dots \coprod_{\phi} u_k \rangle \pi_1(u_1) \dots \pi_1(u_k)$$
$$= \sum_{k\geq 0} \frac{1}{k!} \sum_{u_1,\dots,u_k\in Y^*} \langle w \mid u_1\dots u_k \rangle \check{\pi}_1(u_1) \coprod_{\phi} \dots \coprod_{\phi} \check{\pi}_1(u_k).$$

*Proof.* i) Expanding by different ways the logarithm, it follows the results:

$$\log \mathcal{D}_{Y} = \sum_{k \geq 1} \frac{(-1)^{k-1}}{k} \left( \sum_{w \in Y^{+}} w \otimes w \right)^{k}$$

$$= \sum_{k \geq 1} \frac{(-1)^{k-1}}{k} \sum_{u_{1}, \dots, u_{k} \in Y^{+}} (u_{1} \coprod_{\phi} \dots \coprod_{\phi} u_{k}) \otimes u_{1} \dots u_{k}$$

$$= \sum_{w \in Y^{+}} w \otimes \sum_{k \geq 1} \frac{(-1)^{k-1}}{k} \sum_{u_{1}, \dots, u_{k} \in Y^{+}} \langle w \mid u_{1} \coprod_{\phi} \dots \coprod_{\phi} u_{k} \rangle u_{1} \dots u_{k}.$$

$$\log \mathcal{D}_{Y} = \sum_{w \in Y^{+}} \sum_{k \geq 1} \frac{(-1)^{k-1}}{k} \sum_{u_{1}, \dots, u_{k} \in Y^{+}} \langle w \mid u_{1} \dots u_{k} \rangle u_{1} \coprod_{\phi} \dots \coprod_{\phi} u_{k} \otimes w.$$

ii) Since  $\mathcal{D}_Y = \exp(\log(\mathcal{D}_Y))$  then, by the previous results, one has separately,

$$\begin{split} \mathcal{D}_Y &= \sum_{k \geq 0} \frac{1}{k!} \Biggl( \sum_{w \in Y^+} w \otimes \pi_1(w) \Biggr)^k \\ &= \sum_{k \geq 0} \frac{1}{k!} \sum_{u_1, \dots, u_k \in Y^+} (u_1 \biguplus \phi \dots \biguplus \phi u_k) \otimes (\pi_1(u_1) \dots \pi_1(u_k)) \\ &= \sum_{w \in Y^+} w \otimes \sum_{k \geq 1} \frac{1}{k!} \sum_{u_1, \dots, u_k \in Y^+} \langle w \mid u_1 \biguplus \phi \dots \biguplus \phi u_k \rangle \pi_1(u_1) \dots \pi_1(u_k). \\ \mathcal{D}_Y &= \sum_{k \geq 0} \frac{1}{k!} \sum_{u_1, \dots, u_k \in Y^+} (\check{\pi}_1(u_1) \biguplus \phi \dots \biguplus \phi \check{\pi}_1(u_k)) \otimes (u_1 \dots u_k) \\ &= \sum_{w \in Y^+} \sum_{k \geq 0} \frac{1}{k!} \sum_{u_1, \dots, u_k \in Y^+} \langle w \mid u_1 \dots u_k \rangle \check{\pi}_1(u_1) \biguplus \phi \dots \biguplus \phi \check{\pi}_1(u_k) \otimes w. \end{split}$$

It follows then the expected result.

**Lemma 11.** For any  $w \in Y^+$ , one has  $\Delta_{\coprod_{\phi}} \pi_1(w) = \pi_1(w) \otimes 1 + 1 \otimes \pi_1(w)$ .

*Proof.* Let  $\alpha$  be the alphabet duplication isomorphism defined by

$$\forall \bar{y} \in \bar{Y}, \quad \bar{y} = \alpha(y).$$

Applying the tensor product of algebra isomorphisms  $\alpha \otimes \operatorname{Id}$  to the diagonal series  $\mathcal{D}_Y$ , we obtain, by Lemma 6, a group-like element and then applying the logarithm of this element (or equivalently, applying  $\alpha \otimes \pi_1$  to  $\mathcal{D}_Y$ ) we obtain  $\mathcal{S}$  which is, by Lemma 7, a primitive element :

$$(\alpha \otimes \operatorname{Id})\mathcal{D}_Y = \sum_{w \in Y^*} \alpha(w) \ w \quad \text{and} \quad \mathcal{S} = (\alpha \otimes \pi_1)\mathcal{D}_Y = \sum_{w \in Y^*} \alpha(w) \ \pi_1(w).$$

The two members of the identity  $\Delta_{\mathbf{H}_{\phi}} \mathcal{S} = \mathcal{S} \otimes 1 + 1 \otimes \mathcal{S}$  give respectively

$$\sum_{w \in Y^*} \alpha(w) \ \Delta_{\text{ if }_{\phi}} \pi_1(w) \quad \text{and} \quad \sum_{w \in Y^*} \alpha(w) \ \pi_1(w) \otimes 1 + \sum_{w \in Y^*} \alpha(w) \ 1 \otimes \pi_1(w).$$

Since  $\{w\}_{w\in \bar{Y}^*}$  as a basis for  $\mathbb{Q}\langle \bar{Y}\rangle$  then identifying the coefficients to the previous expressions, we get  $\Delta_{\bowtie_{\phi}}\pi_1(w)=\pi_1(w)\otimes 1+1\otimes \pi_1(w)$  meaning that  $\pi_1(w)$  is primitive.

### 3.2 Pair of bases in duality on $\phi$ -deformed stuffle algebra

**Definition 4.** Let  $\{\Pi_l\}_{l \in \mathcal{L}ynY}$  and  $\{\Pi_w\}_{w \in Y^*}$  be the families of respectively  $\mathcal{L}ie_{\mathbb{Q}}\langle Y \rangle$  and  $\mathcal{U}(\mathcal{L}ie_{\mathbb{Q}}\langle Y \rangle)$  obtained as follows

$$\begin{array}{lcl} \Pi_{y_k} & = & \pi_1(y_k) & \textit{for} & k \geq 1, \\ \Pi_l & = & [\Pi_s, \Pi_r] & \textit{for} & l \in \mathcal{L}ynX, \; \textit{standard factorization of} \; l = (s, r), \\ \Pi_w & = & \Pi_{l_1}^{i_1} \dots \Pi_{l_k}^{i_k} \; \; \textit{for} \; \; w = l_1^{i_1} \dots l_k^{i_k}, l_1 > \dots > l_k, l_1 \dots, l_k \in \mathcal{L}ynY. \end{array}$$

Let  $\{\Sigma_w\}_{w\in Y^*}$  be the family of the quasi-shuffle algebra (viewed as a  $\mathbb{Q}$ -module) obtained by duality with  $\{\Pi_w\}_{w\in Y^*}$ :

$$\forall u, v \in Y^*, \quad \langle \Sigma_v \mid \Pi_u \rangle = \delta_{u,v}.$$

**Proposition 6.** Let  $\bar{\mathcal{P}} = \{P \in \mathbb{Q}\langle \bar{Y} \rangle \mid \Delta_{\coprod_{\phi}} P = P \otimes 1 + 1 \otimes P\}$ , where  $\bar{Y} = \{\pi_1(y_k)\}_{k \geq 1}$ . Then<sup>17</sup>  $\mathcal{L}ie_{\mathbb{Q}}\langle \bar{Y} \rangle = \bar{\mathcal{P}}$ .

*Proof.* By Lemma 11 and by Lemma 5, we get then the expected result.  $\Box$ 

**Proposition 7.** i) For  $l \in \mathcal{L}ynY$ , the polynomial  $\Pi_l$  is upper triangular :

$$\Pi_l = l + \sum_{v>w,(v)=(l)} c_v v.$$

ii) The families  $\{\Pi_w\}_{w\in Y^*}$  and  $\{\Sigma_w\}_{w\in Y^*}$  are upper and lower triangular respectively<sup>18</sup>. On other words, for any  $w\in Y^+$ , by denoting (w) the degree of w with  $(y_k) = \deg(y_k) = k$ , one has

$$\Pi_w = w + \sum_{v > w, (v) = (w)} c_v v \quad and \quad \Sigma_w = w + \sum_{v < w, (v) = (w)} d_v v.$$

*Proof.* i) Let us prove it by induction on the length of l: the result is immediat for  $l \in Y$ . The result is suppose verified for any  $l \in \mathcal{L}ynY \cap Y^k$  and  $0 \le k \le N$ . At N+1, by the standard factorization  $(l_1, l_2)$  of l, one has  $\Pi_l = [\Pi_{l_1}, \Pi_{l_2}]$  and  $l_2l_1 > l_1l_2 = l$ . By induction hypothesis,

$$\begin{split} \Pi_{l_1} &= l_1 + \sum_{v > l_1, (v) = (l_1)} c_v v \quad \text{and} \quad \Pi_{l_2} = l_2 + \sum_{u > l_2, (v) = (l_2)} d_u u, \\ & \Rightarrow \quad \Pi_l = l + \sum_{w > l, (w) = (l)} e_w w, \end{split}$$

getting  $e_w$ 's from  $c_v$ 's and  $d_u$ 's. Actually, the Lie bracket gives

$$\Pi_{l} = [l_{1}, l_{2}] + \sum_{u>l_{2}, (v)=(l_{2})} d_{u}l_{1}u + \sum_{\substack{v>l_{1}, (v)=(l_{2})\\u>l_{2}, (u)=(l_{1})}} c_{v}d_{u}vu 
- \sum_{v>l_{1}, (v)=(l_{1})} c_{v}l_{2}v - \sum_{\substack{v>l_{1}, (v)=(l_{2})\\u>l_{2}, (u)=(l_{1})}} c_{v}d_{u}uv 
= [l_{1}, l_{2}] + \sum_{u>l_{1}l_{2}, (v)=(l_{1}l_{2})} d'_{u}u + \sum_{vu>l_{1}l_{2}, (vu)=(l_{1}l_{2})} c_{v}d_{u}vu 
- \sum_{v>l_{2}l_{1}, (v)=(l_{2}l_{1})} c'_{v}v - \sum_{uv>l_{2}l_{1}, (uv)=(l_{2}l_{1})} c_{v}d_{u}uv$$

<sup>&</sup>lt;sup>17</sup>Any  $P \in \mathbb{Q}\langle \bar{Y} \rangle$  is a Lie polynomial if and only if P is primitive, for  $\Delta \coprod_{\phi}$ .

<sup>&</sup>lt;sup>18</sup>The duality preserves the homogeneous degree and interchanges the triangularity of polynomials (see Note 5 for the same construction of the triangular matrices of coefficients).

$$= [l_1, l_2] + \sum_{u>l,(v)=(l)} d'_u u + \sum_{vu>l,(vu)=(l)} c_v d_u v u - \sum_{v>l_2 l_1>l,(v)=(l)} c'_v v - \sum_{uv>l_2 l_1>l,(uv)=(l)} c_v d_u u v.$$

Hence, the conclusion follows.

ii) Let  $w = l_1 \dots l_k$ , with  $l_1 \ge \dots \ge l_k$  and  $l_1, \dots, l_k \in \mathcal{L}ynY$ . One has

$$\Pi_{l_i} = l_i + \sum_{v > l_i, (v) = (l_i)} c_{i,v} v$$
 and  $\Pi_w = l_1 \dots l_k + \sum_{u > w, (v) = (w)} d_u u$ ,

where the  $d_u$ 's are obtained from the  $c_{i,v}$ 's. Hence, the family  $\{\Pi_w\}_{w\in Y^*}$  is upper triangular and, by duality, the family  $\{\Sigma_w\}_{w\in Y^*}$  is lower triangular.

**Theorem 4.** i) The family  $\{\Pi_l\}_{l \in \mathcal{L}ynY}$  forms a basis of the free Lie algebra.

- ii) The family  $\{\Pi_w\}_{w\in Y^*}$  forms a basis of the free associative algebra  $\mathbb{Q}\langle Y\rangle$ .
- iii) The family  $\{\Sigma_w\}_{w\in Y^*}$  generate freely the quasi-shuffle algebra.
- iv) The family  $\{\Sigma_l\}_{l\in\mathcal{L}ynY}$  forms a transcendence basis of  $(\mathbb{Q}\langle Y\rangle, \bowtie_{\phi})$ .

*Proof.* The family  $\{\Pi_l\}_{l\in\mathcal{L}ynY}$  of primitive upper triangular polynomials is free. By Lemma 4 and then by a theorem of Viennot [9], we get the first result. The second is a direct consequence of the Poincaré-Birkhoff-Witt theorem. By the Cartier-Quillen-Milnor-Moore theorem, we get the third one and the last one is obtained as consequence of the constructions of  $\{\Sigma_l\}_{l\in\mathcal{L}ynY}$  and  $\{\Sigma_w\}_{w\in Y^*}$ .  $\square$ 

**Proposition 8.** Let  $\pi_Y: (\mathbb{Q} \oplus \mathbb{Q} \langle X \rangle x_1, .) \to (\mathbb{Q} \langle Y \rangle, .)$  be the morphism mapping  $x_0^{s_1-1}x_1 \dots x_0^{s_r-1}x_1 \in X^*x_1$  to  $y_{s_1} \dots y_{s_r} \in Y^*$  and let  $\pi_X$  be its inverse. Then

i) The homogeneous polynomials  $\{\pi_Y P_{\pi_X l}\}_{l \in \mathcal{L}ynY}$  are upper triangular and linearly independent<sup>19</sup> and

$$\pi_Y P_{\pi_X l} = \Pi_l + \sum_{v > l, (v) = (l)} p_v v.$$

ii) For any  $w \in Y^*$ , the following homogeneous polynomial

$$\pi_Y P_{\pi_X w} = \Pi_w + \sum_{v>w,(v)=(w)} c_v v$$

is of degree (w) and the family  $\{\pi_Y P_{\pi_X w}\}_{w \in Y^*}$  forms a basis for  $\mathbb{Q}\langle Y \rangle$ .

For example,  $P_{\pi_Y y_2} = [x_0, x_1]$  and  $\Pi_{y_2} = y_2 - \frac{1}{2}y_1^2$  are primitive but  $\pi_Y P_{x_0 x_1} = y_2$  is not.

iii) Let  $\{\Theta_w\}_{w\in Y^*}$  be the family of homogeneous polynomials in duality with the family  $\{\pi_Y P_{\pi_X w}\}_{w\in Y^*}$ :

$$\forall u, v \in Y^*, \quad \langle \pi_Y P_{\pi_X u} \mid \Theta_u \rangle = \delta_{u,v}.$$

Then, the family  $\{\Theta_w\}_{w\in Y^*}$  generate freely the quasi-shuffle algebra and, for any  $w\in Y^*$ ,  $\Theta_w$  is upper triangular of degree (w):

$$\Theta_w = \Sigma_w + \sum_{v < w, (v) = (w)} d_v v.$$

iv) The family  $\{\Theta_l\}_{l\in\mathcal{L}ynY}$  does not form a transcendence basis of  $(\mathbb{Q}\langle Y\rangle, \coprod_{\phi})$ .

*Proof.* i) By (11) (resp. by Proposition 7), for any  $l \in \mathcal{L}ynX$  (resp.  $\mathcal{L}ynY$ ), one has  $\deg(P_l) = |l|$  (resp.  $\deg(\Pi_l) = (l)$ ) and

$$P_l = l + \sum_{v > l, |v| = |l|} a_v v \quad \left(\text{resp.} \quad \Pi_l = l + \sum_{v > l, (v) = (l)} c_v v\right),$$

Hence, for any  $l \in \mathcal{L}ynY$ , we have  $\pi_X l \in \mathcal{L}ynX$  and

$$\begin{split} P_{\pi_X l} &= \pi_X \bigg[ \Pi_l - \sum_{v > l, (v) = (l)} c_v v \bigg] + \sum_{v > \pi_X l, |v| = |l|} a_v v, \\ \Rightarrow &\pi_Y P_{\pi_X l} &= \Pi_l + \sum_{u > l, (u) = (l)} (a'_u - c'_u) u. \end{split}$$

Hence, we get the expected results by putting  $p_u = a'_u - c'_u$ , where the coefficients  $a'_u$ 's (resp.  $c'_u$ 's) are obtained from  $a_v$ 's (resp.  $c_v$ 's) by completing some nul coefficients when it is necessary and by using the fact

$$\forall w_1, w_2 \in Y^* x_1, \quad w_1 > w_2 \quad \Rightarrow \quad \pi_Y w_1 > \pi_Y w_2.$$

By Proposition 7, the polynomials  $\{\Pi_l\}_{l \in \mathcal{L}ynY}$  are upper triangular (see Note 5) and are linearly independent then the  $\{\pi_Y P_{\pi_X l}\}_{l \in \mathcal{L}ynY}$  are also.

ii) As in Proposition 7, let  $w = l_1 \dots l_k$ , with  $l_1 > \dots > l_k, l_1, \dots, l_k \in \mathcal{L}ynY$ . Firstly, one has  $(\pi_X l_1) \dots (\pi_X l_k) = \pi_X w$  and secondly,

$$P_{\pi_X l_i} = \pi_X l_i + \sum_{v>l_i, |v|=|l_i|} c_{i,v} v \quad \text{and} \quad P_{\pi_X w} = \pi_X w + \sum_{u>w, |v|=|w|} d_u u,$$

where the  $d_u$ 's are obtained from the  $c_{i,v}$ 's. Hence, the family  $\{P_{\pi_X w}\}_{w \in Y^*}$  is upper triangular. Using the restriction of  $\pi_Y$ , as being morphism from  $(\mathbb{Q} \oplus \mathbb{Q}\langle X \rangle x_1,...)$  to  $(\mathbb{Q}\langle Y \rangle,...)$ , we get the degree of the upper triangular homogeneous polynomial  $\pi_Y P_{\pi_X w}$  as image of  $\Pi_w$  is (see Proposition 7). The family  $\{\pi_Y P_{\pi_X w}\}_{w \in Y^*}$  forms then a basis for the free algebra  $\mathbb{Q}\langle Y \rangle$ .

- iii) It is a consequence of the Cartier-Quillen-Milnor-Moore theorem.
- iv) If  $\{\Theta_l\}_{l\in\mathcal{L}ynY}$  constitutes a transcendence basis of  $(\mathbb{Q}\langle Y\rangle, \mathbf{\mu}_{\phi})$  then, for any  $l\in\mathcal{L}ynY, \pi_Y P_{\pi_X l}$  is primitive but it is false in general (see Note 19).

Now, let us clarify the basis  $\{\Sigma_w\}_{w\in Y^*}$  and then the transcendence basis  $\{\Sigma_l\}_{l\in\mathcal{L}ynY}$  of the quasi-shuffle algebra  $(\mathbb{Q}\langle Y\rangle, \ \ \ \ \ \ \ \ \ \ \ \ \ )$  as follows

### Proposition 9. We have

- i) For  $w = 1_{Y^*}, \Sigma_w = 1$ .
- ii) For any  $w = l_1^{i_1} \dots l_k^{i_k}$ , with  $l_1, \dots, l_k \in \mathcal{L}ynY$  and  $l_1 > \dots > l_k$ ,

$$\Sigma_w = \frac{\sum_{l_1}^{\mathbf{H}} {}^{\phi l_1} \mathbf{H}_{\phi} \dots \mathbf{H}_{\phi} \sum_{l_k}^{\mathbf{H}} {}^{\phi l_k}}{i_1! \dots i_k!}.$$

iii) For any  $y \in Y, \Sigma_y = \check{\pi}_1(y)$ .

*Proof.* i) Since  $\Pi_{1_{Y^*}} = 1$  then  $\Sigma_{1_{Y^*}} = 1$ .

ii) Let  $u=u_1\ldots u_n=l_1^{i_1}\ldots l_k^{i_k}, v=v_1\ldots v_m=h_1^{j_1}\ldots h_p^{j_p}$  with  $l_1\ldots,l_k,$   $h_1,\ldots,h_p,u_1,\ldots,u_n,v_1,\ldots,v_m\in\mathcal{L}ynY,l_1>\ldots>l_k,h_1>\ldots>h_p,$   $u_1\geq\ldots\geq u_n,v_1\geq\ldots\geq v_m$  and  $i_1+\ldots+i_k=n,j_1+\ldots+j_p=m.$  Hence, if  $m\geq 2$  (resp.  $n\geq 2$ ) then  $v\notin\mathcal{L}ynY$  (resp.  $u\notin\mathcal{L}ynY$ ). Since

$$\langle \Sigma_{u_1} \coprod_{\phi} \dots \coprod_{\phi} \Sigma_{u_n} \mid \prod_{i=1}^n \Pi_{u_i} \rangle = \langle \Sigma_{u_1} \otimes \dots \otimes \Sigma_{u_n} \mid \Delta^{(n-1)}_{\coprod_{\phi}} (\Pi_{v_1} \dots \Pi_{v_m}) \rangle$$

then many cases occur:

- (a) Case n > m. By Lemma 10(90),  $\langle \Sigma_{u_1} \bowtie_{\phi} \dots \bowtie_{\phi} \Sigma_{u_n} \mid \Pi_{v_1} \dots \Pi_{v_m} \rangle = 0$ .
- (b) Case n = m. By Lemma 10(87), one has

$$\begin{split} \langle \Sigma_{u_1} \coprod_{\phi} \dots \coprod_{\phi} \Sigma_{u_n} \mid \prod_{i=1}^n \Pi_{v_i} \rangle & = & \sum_{\sigma \in \Sigma_n} \prod_{i=1}^n \langle \Sigma_{u_i} \mid \Pi_{v_{\sigma(i)}} \rangle \\ & = & \sum_{\sigma \in \Sigma_n} \prod_{i=1}^n \delta_{\Sigma_{u_i}, \Pi_{v_{\sigma(i)}}}. \end{split}$$

Thus, if  $u \neq v$  then  $(u_1, \ldots, u_n) \neq (v_1, \ldots, v_n)$  then the second member is vanishing else, *i.e.* u = v, the second member equals 1 because the factorization by Lyndon words is unique.

(c) Case n < m. By Lemma 10(iii), let us consider the following language over the alphabet  $\mathcal{A} = \{\Pi_{v_1}, \dots, \Pi_{v_m}\}$ :

$$\mathcal{M} = \{ w \in \mathcal{A}^* | w = \Pi_{v_{j_1}} \dots \Pi_{v_{j_{|w|}}}, j_1 < \dots < j_{|w|}, |w| \ge 1 \},$$

and the morphism  $\mu: \mathbb{Q}\langle A \rangle \longrightarrow \mathbb{Q}\langle Y \rangle$ . We get :

$$\langle \Sigma_{u_1} \coprod_{\phi} \dots \coprod_{\phi} \Sigma_{u_n} \mid \prod_{i=1}^n \Pi_{u_i} \rangle = \sum_{\substack{w_1, \dots, w_m \in \mathcal{M} \\ w_1 \coprod_{\phi} \dots \coprod_{\phi} w_m = P_1 \dots P_m}} \prod_{i=1}^n \langle \Sigma_{u_i} \mid \mu(w_i) \rangle = 0.$$

Because in the side, on the one hand, there is at least one  $w_i, |w_i| \geq 2$ , corresponding to  $\mu(w_i) = \Pi_{v_{j_1}} \dots \Pi_{v_{j_{|w_i|}}}$  such that  $v_{j_1} \geq \dots \geq v_{j_{|w_i|}}$  and on the other hand,  $\nu_i := v_{j_1} \dots v_{j_{|w_i|}} \notin \mathcal{L}ynY$  and  $u_i \in \mathcal{L}ynY$ .

By consequent.

$$\langle \Sigma_u \mid \Pi_v \rangle = \langle \frac{\sum_{l_1}^{\mathbf{LL}} \phi^{i_1} \, \mathbf{LL} \, \phi \dots \, \mathbf{LL} \, \phi^{\sum_{l_k}} \phi^{i_k}}{i_1! \dots i_k!} \mid \Pi_{h_1}^{j_1} \dots \Pi_{h_p}^{j_p} \rangle = \delta_{u,v}.$$

iii) For any  $l \in Y$ ,  $\Pi_l = \pi_1(l)$ ,  $\Sigma_l = \check{\pi}_1(l)$  and  $\pi_1, \check{\pi}_1$  are mutually adjoint.

**Proposition 10.** i) For  $w \in Y^+$ , the polynomial  $\Sigma_w$  is proper and homogeneous of degree (w), for  $\deg(y_i) = i$ , and of rational positive coefficients.

ii) 
$$\mathcal{D}_Y = \sum_{w \in Y^*} \Sigma_w \otimes \Pi_w = \prod_{l \in \mathcal{L}ynY} \exp(\Sigma_l \otimes \Pi_l).$$

iii) The family  $\mathcal{L}ynY$  forms a transcendence basis<sup>20</sup> of the quasi-shuffle algebra and the family of proper polynomials of rational positive coefficients defined by, for any  $w = l_1^{i_1} \dots l_k^{i_k}$  with  $l_1 > \dots > l_k$  and  $l_1, \dots, l_k \in \mathcal{L}ynY$ ,

$$\chi_w = \frac{l_1^{\coprod_{\phi} i_1} \coprod_{\phi} \dots \coprod_{\phi} l_k^{\coprod_{\phi} i_k}}{i_1! \dots i_k!}$$

forms a basis of the quasi-shuffle algebra.

iv) Let  $\{\xi_w\}_{w\in Y^*}$  be the basis of the envelopping algebra  $\mathcal{U}(\mathcal{L}ie_{\mathbb{Q}}\langle X\rangle)$  obtained by duality with the basis  $\{\chi_w\}_{w\in Y^*}$ :

$$\forall u, v \in Y^*, \quad \langle \chi_v \mid \xi_u \rangle = \delta_{u,v}.$$

Then the family  $\{\xi_l\}_{l\in\mathcal{L}ynY}$  forms a basis of the free Lie algebra  $\mathcal{L}ie_{\mathbb{Q}}\langle Y\rangle$ .

<sup>&</sup>lt;sup>20</sup>This result is an analogous of a Radford theorem (see [8]). Thus the bases  $\mathcal{L}ynY$  and  $\{\Sigma_l\}_{l\in\mathcal{L}ynY}$  belong to the class of Radford bases, *i.e.* the class of trancensdence bases, of the quasi-shuffle algebra, as well as the bases  $\mathcal{L}ynX$  and  $\{P_l\}_{l\in\mathcal{L}ynX}$  belong to the class of Radford bases of the shuffle algebra.

- *Proof.* i) The proof can be done by induction on the length of w using the fact that the product  $\bowtie_{\phi}$  conserve the property, l'homogenity and rational positivity of the coefficients.
  - ii) Expressing w in the basis  $\{\Sigma_w\}_{w\in Y^*}$  of the quasi-shuffle algebra and then in the basis  $\{\Pi_w\}_{w\in Y^*}$  of the envelopping algebra, we obtain successively

$$\begin{split} \mathcal{D}_Y &= \sum_{w \in Y^*} \left( \sum_{u \in Y^*} \langle \Pi_u \mid w \rangle \Sigma_u \right) \otimes w \\ &= \sum_{u \in Y^*} \Sigma_u \otimes \left( \sum_{w \in Y^*} \langle \Pi_u \mid w \rangle w \right) \\ &= \sum_{u \in Y^*} \Sigma_u \otimes \Pi_u \\ &= \sum_{\substack{l_1 > \dots > l_k \\ i_1, \dots, i_k \geq 1}} \frac{\sum_{l_1}^{\mathbf{H}} \mathcal{A}^{i_1} \mathcal{A} \mathcal{A} \dots \mathcal{A}^{i_k} \mathcal{A}^{\mathbf{H}}^{i_k}}{i_1! \dots i_k!} \otimes \Pi^{i_1}_{l_1} \dots \Pi^{i_k}_{l_k} \\ &= \prod_{l \in \mathcal{L}ynY} \sum_{i \geq 0} \frac{\sum_{l}^{\mathbf{H}} \mathcal{A}^{i}}{i!} \otimes \Pi^{i}_{l} \\ &= \prod_{l \in \mathcal{L}ynY} \exp(\Sigma_l \otimes \Pi_l). \end{split}$$

iii) For  $w=l_1^{i_1}\dots l_k^{i_k}$  with  $l_1,\dots,l_k\in\mathcal{L}ynY$  and  $l_1>\dots>l_k$ , by Proposition 7, the proper polynomial of positive coefficients  $\Sigma_w$  is lower triangular:

$$\Sigma_w = \frac{\sum_{l_1}^{\coprod \phi^{i_1}} \coprod \phi \dots \coprod \phi^{\sum_{l_k}^{\coprod \phi^{i_k}} \phi^{i_k}}}{i_1! \dots i_k!} = w + \sum_{v < w, (v) = (w)} c_v v.$$

In particular, for any  $l_j \in \mathcal{L}ynY$ ,  $\Sigma_{l_j}$  is lower triangular :

$$\Sigma_{l_j} = l_j + \sum_{v < l_j, (v) = (l_j)} c_v v.$$

Hence,  $\Sigma_w = \chi_w + \chi_w'$ , where  $\chi_w'$  is a proper polynomial of  $\mathbb{Q}\langle Y \rangle$  of rational positive coefficients. We deduce then the support of  $\chi_w$  contains words which are less than w and  $\langle \chi_w | w \rangle = 1$ . Thus, the proper polynomial  $\chi_w$  of rational positive coefficients is lower triangular:

$$\chi_w = w + \sum_{v < w, (v) = (w)} c_v v,$$

$$\Rightarrow \forall l \in \mathcal{L}ynY, \quad \chi_l = l + \sum_{v < l, (v) = (l)} c_v v.$$

It follows then expected results.

iv) By duality, for  $w \in Y^*$ , the proper polynomial  $\xi_w$  is upper triangular. In particular, for any  $l \in \mathcal{L}ynY$ , the proper polynomial  $\xi_l$  is upper triangular:

$$\xi_l = l + \sum_{v>l,(v)=(l)} d_v v.$$

Hence, the family  $\{\xi_l\}_{l \in \mathcal{L}ynY}$  is free and its elements verify an analogous of the generalized criterion of Friedrichs:

- for  $w \in \mathcal{L}ynY$ , one has  $\langle \chi_w \mid \xi_l \rangle = \delta_{w,l}$ ,
- for  $w = l_1 \dots l_n \notin \mathcal{L}ynY$  with  $l_1, \dots, l_n \in \mathcal{L}ynY$  and  $l_1 \geq \dots \geq l_n$ , one has  $\langle \chi_{l_1} \coprod_{\phi} \dots \coprod_{\phi} \chi_{l_n} \mid \xi_l \rangle = \langle \chi_w \mid \xi_l \rangle = 0$  (since  $l \in \mathcal{L}ynY$ ).

Moreover, by Lemma 9, the polynomials  $\xi_l$ 's are primitive.. By Lemma 4 and then by a Viennot's theorem [9], we get the expected result.

### 3.3 Particular case: q-deformation of the shuffle product

In the sequel, we focus on the particular case where

$$\forall y_i, y_j \in Y, \qquad \phi(y_i, y_j) = qy_{i+j}.$$

We call a standard sequence of Lyndon words to be a sequence

$$S = (\ell_1, \cdots, \ell_k), k \ge 1 \tag{82}$$

if for all i, either  $\ell_i$  to be a letter or the standard factorization  $\sigma(\ell_i) = (\ell_i', \ell_i'')$  and  $\ell_i'' \geq \ell_{i+1}, \cdots, \ell_n$ . Note that a decreasing sequence of Lyndon words is also a standard sequence. A <u>rise</u> of a sequence S is an index i such that  $\ell_i < \ell_{i+1}$ . A <u>legal rise</u> of sequence  $\overline{S}$  is a rise of i such that  $\ell_{i+1} \geq \ell_{i+2}, \cdots, \ell_k$ ; with the legal rise i, we define

$$\lambda_i(S) = (\ell_1, \dots, \ell_{i-1}, \ell_i \ell_{i+1}, \ell_{i+2}, \dots, \ell_n),$$
 (83)

$$\rho_i(S) = (\ell_1, \dots, \ell_{i-1}, \ell_{i+1}, \ell_i, \ell_{i+2}, \dots, \ell_n)$$
(84)

We denote  $S \Rightarrow T$  if  $T = \lambda_i(S)$  or  $T = \rho_i(S)$  for some legal rise i; and  $S \stackrel{*}{\Rightarrow} T$ , transitive closure of  $\Rightarrow$ .

A <u>derivation tree</u>  $\mathcal{T}(S)$  of S to be a labelled rooted tree with the following properties: if S is decreasing, then  $\mathcal{T}(S)$  is reduced to its root, labelled S; if not,  $\mathcal{T}(S)$  is the tree with root labelled S, with left and right immediate subtree  $\mathcal{T}(S')$  and  $\mathcal{T}(S'')$ , where  $S' = \lambda_i(S)$ ,  $S'' = \rho_i(S)$  for some legal rise i of S; we define  $\Pi(S) = \Pi_{\ell_1} \dots \Pi_{\ell_n}$  (note that,  $\Pi(S) \neq \Pi_{\ell_1 \dots \ell_k}$  because  $\ell_1, \dots, \ell_k$  can be not a decreasing sequence).

Conversely, we call a <u>fall</u> of sequence S is an index i such that  $\ell_1, \dots, \ell_i \in Y, \ell_i > \ell_{i+1}$ . We define

$$\rho_i^{-1}(S) = (\ell_1, \dots, \ell_{i+1}, \ell_i, \dots, \ell_n).$$

We call a <u>landmark</u> of sequence S is an index i such that  $\ell_1, \dots, \ell_{i-1} \in Y, \ell_i \in Y^* \setminus Y$ , and we define

$$\lambda_i^{-1}(S) = (\ell_1, \dots, \ell_{i-1}, \ell'_i, \ell''_i, \ell_{i+1}, \dots, \ell_n),$$

where  $\sigma(\ell_i) = (\ell_i', \ell_i'')$ . We will denote by  $S \Leftarrow T$  if  $T = \rho_i^{-1}(S)$  or  $T = \lambda_i^{-1}(S)$  for some fall or landmark i; and  $S \stackrel{*}{\Leftarrow} T$ , transitive closure of  $\Leftarrow$ . Similarly, we call the conversely derivation tree  $\mathcal{T}^{-1}(S)$  with root labelled S, with left and right immediate subtree  $\mathcal{T}^{-1}(S')$  and  $\mathcal{T}^{-1}(S'')$ , where  $S' = \rho_i^{-1}(S)$  for some fall  $i, S'' = \lambda_i^{-1}(S)$  for some landmark i.

**Lemma 12.** For each standard sequence S,  $\Pi(S)$  is the sum of all  $\Pi(T)$  for T a leaf in a fixed derivation tree of S.

*Proof.* The Lemma is a consequence of the definitions (83), (84) of  $\lambda_i(S)$  and  $\rho_i(S)$ , of that of  $\mathcal{T}(S)$  and  $\Pi(S)$ , and of the identity in  $\mathbb{Q}[q]\langle X \rangle$ :

$$\Pi_{\ell_i} \Pi_{\ell_{i+1}} = [\Pi_{\ell_i}, \Pi_{\ell_{i+1}}] + \Pi_{\ell_{i+1}} \Pi_{\ell_i} = \Pi_{\ell_i \ell_{i+1}} + \Pi_{\ell_{i+1}} \Pi_{\ell_i}.$$

**Example 1.**  $\Pi(y_4, y_2, y_1) = \Pi_{y_4 y_2 y_1} + \Pi_{y_2 y_1} \Pi_{y_4} + \Pi_{y_4 y_1 y_2} + \Pi_{y_2} \Pi_{y_4 y_1} + \Pi_{y_1} \Pi_{y_4 y_2} + \Pi_{y_1} \Pi_{y_2} \Pi_{y_4}$ , we can see the following diagram (note that  $y_4 < y_2 < y_1$ )

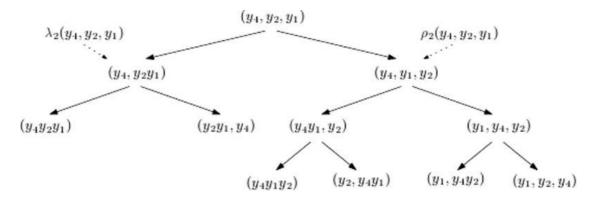


Figure 4: Derivation tree  $\mathcal{T}(y_4, y_2, y_1)$ 

**Proposition 11.** i) For any Lyndon word  $y_{s_1} \dots y_{s_k}$ , we have

$$\Sigma_{y_{s_1}...y_{s_k}} = \sum_{\substack{\{s'_1,\dots,s'_i\} \subset \{s_1,\dots,s_k\}\\ \ell_1 \ge \dots \ge \ell_n \text{ in } \mathcal{L} y n Y\\ (y_{s_1}...y_{s_k}) \stackrel{*}{\Leftarrow} (y_{s'_1},\dots,y_{s'_n},\ell_1,\dots,\ell_n)}} \frac{q^{i-1}}{i!} y_{s'_1+\dots+s'_i} \Sigma_{\ell_1\dots\ell_n}. \tag{85}$$

ii) In special case, if  $y_{s_1} \leq \cdots \leq y_{s_k}$  then

$$\Sigma_{y_{s_1}...y_{s_k}} = \sum_{i=1}^k \frac{q^{i-1}}{i!} y_{s_1+\dots+s_i} \Sigma_{y_{s_{i+1}}...y_{s_k}}.$$
 (86)

*Proof.* (Proposition 11) At first, we remark that the equality (85) is equivalent to saying that for any word u and any letter  $y_s$ ,

$$\langle \Sigma_{y_{s_1} \dots y_{s_k}} | y_s u \rangle = \sum_{\substack{\{s'_1, \dots, s'_i\} \subset \{s_1, \dots, s_k\} \\ \ell_1 \ge \dots \ge \ell_n i n \mathcal{L} y n Y \\ (y_{s_1} \dots y_{s_k}) \stackrel{*}{\Leftarrow} (y_{s'_1} \dots y_{s'_k}, \ell_1, \dots, \ell_n)} \frac{q^{i-1}}{i!} \delta_{s'_1 + \dots + s'_i, s} \langle \Sigma_{\ell_1 \dots \ell_n} | u \rangle. \quad (87)$$

Since the duality, we have

$$u = \sum_{w \in Y^*} \langle \Sigma_w | u \rangle \Pi_w,$$

this and (??) we imply

$$y_s u = \sum_w \langle \Sigma_w | u \rangle y_s \Pi_w \tag{88}$$

$$= \sum_{w} \langle \Sigma_w | u \rangle \left( \sum_{i \ge 1} \frac{q^{i-1}}{i!} \sum_{s_1' + \dots + s_i' = s} \Pi_{y_{s_1'}} \dots \Pi_{y_{s_i'}} \right) \Pi_w$$
 (89)

$$= \sum_{w} \langle \Sigma_{w} | u \rangle \sum_{i \ge 1} \frac{q^{i-1}}{i!} \sum_{s'_{1} + \dots + s'_{i} = s} \Pi_{y_{s'_{1}}} \dots \Pi_{y_{s'_{i}}} \Pi_{w}. \tag{90}$$

For each w fixed, we write w form factorization of Lyndon words  $w = \ell_1 \dots \ell_n, \ell_1 \ge \dots \ge \ell_n$ , then we have  $S := (y_{s_1'}, \dots, y_{s_i'}, \ell_1, \dots, \ell_n)$  is a standard sequence, so we obtain from Lemma 12

$$\Pi(S) = \Pi(y_{s_1'}, \dots, y_{s_i'}, \ell_1, \dots, \ell_n) = \sum_{S \stackrel{*}{\Rightarrow} T} \alpha_T \Pi(T).$$

Consequently

$$\langle \Sigma_{y_1...y_k} | y_s u \rangle = \sum_{w} \langle \Sigma_w | u \rangle \sum_{i \geq 1} \frac{q^{i-1}}{i!} \sum_{s'_1 + \dots + s'_i = s} \langle \Sigma_{y_1...y_k} | \Pi_{y_{s'_1}} \dots \Pi_{y_{s'_i}} \Pi_w \rangle$$

$$= \sum_{\ell_1 \geq \dots \geq \ell_n in \mathcal{L} ynY} \langle \Sigma_{\ell_1...\ell_n} | u \rangle \sum_{i \geq 1} \frac{q^{i-1}}{i!} \sum_{\substack{s'_1 + \dots + s'_i = s \\ (y_{i-1}, \dots, y_{i-1}, \dots, y_{i-1}, \dots, y_{i-1}) \stackrel{\Rightarrow}{\Rightarrow} T}} \alpha_T \langle \Sigma_{y_1...y_k} | \Pi(T) \rangle.$$

Note that, the leaves T's of derivation tree  $\mathcal{T}(S)$  are decreasing sequences of Lyndon words with length  $\geq 2$  except leaves form  $T = (\ell)$ , where  $\ell \in \mathcal{L}ynY$ . Therefore  $\langle \Sigma_{y_1...y_k} | \Pi(T) \rangle \neq 0$  if  $T = (y_{s_1} ... y_{s_k})$ . By maps  $\rho^{-1}$  and  $\lambda^{-1}$ , we construct a conversely derivation tree from the standard sequence of one Lyndon word  $S = (1, \dots, N_s)$ 

 $(y_{s_1} \dots y_{s_k})$ , we take standard sequences form  $(y_{s_1}, \dots, y_{s_i}, \ell_n, \dots, \ell_n), i \geq 1$ ; at that time, for each S of these sequences, we get unique leaf  $T = (y_{s_1} \dots y_{s_k})$  in the derivation tree  $\mathcal{T}(S)$ , it mean  $\alpha_T = 1$ . We thus get (87).

In other words, if  $y_{s_1} \leq \cdots \leq y_{s_k}$  then the standard sequence  $(y_{s_1} \dots y_{s_k})$  may only be a leaf of a derivation tree  $\mathcal{T}(S)$  after applying map  $\lambda_i$  more times, we imply that  $\langle \Sigma_{y_{s_1} \dots y_{s_k}} | \Pi_{y_{s_1'}} \dots \Pi_{y_{s_i'}} \Pi_w \rangle \neq 0$  if and only if  $y_{s_1} \dots y_{s_k} = y_{s_1'} \dots y_{s_i'} \ell_1 \dots \ell_n$ , then  $y_{s_1} = y_{s_1'}, \dots, y_{s_i'} = y_{s_i}$  and  $y_{s_{i+1}} \dots y_{s_k} = \ell_1 \dots \ell_n$ . Hence

$$\langle \Sigma_{y_{s_1} \dots y_{s_k}} | \Pi_{y_{s'_1}} \dots \Pi_{y_{s'_i}} \Pi_w \rangle = \delta_{s_1 + \dots + s_i, s} \delta_{y_{s_{i+1}} \dots y_{s_k}, w},$$

we thus get

$$\begin{split} \langle \Sigma_{y_{s_1} \dots y_{s_k}} | y_s u \rangle &= \sum_w \langle \Sigma_w | u \rangle \sum_{i \ge 1} \frac{q^{i-1}}{i!} \sum_{s_1' + \dots + s_i' = s} \langle \Sigma_{y_{s_1} \dots y_{s_k}} | \Pi_{y_{s_1'}} \dots \Pi_{y_{s_i'}} \Pi_w \rangle \\ &= \frac{q^{i-1}}{i!} \delta_{s_1 + \dots + s_i, s} \langle \Sigma_{y_{s_{i+1}} \dots y_{s_k}} | u \rangle. \end{split}$$
