Forwarding design with prescribed local behavior

Abstract

Among the non-linear control techniques, some Lyapunov design methods (Forwarding / Backstepping) take advantage of the structure of the system (Feedforward-form / Feedback-form) to formulate a continuous control law which stabilizes globally and asymptotically the equilibrium. In addition to stabilization, we focus on the local behaviour of the closed loop system, providing conditions under which we can predetermine the behaviour around the origin for Feedforward systems.

Stabilization, Lyapunov design, Forwarding, First order approximation, Feedforward form.

I. INTRODUCTION

The synthesis of a stabilizing control law for systems described by nonlinear differential equations has been the subject of great interest by the nonlinear control community during the last three decades. Depending on the structure of the model, some techniques are now available to synthesize control laws ensuring global and asymptotic stabilization of the equilibrium point.

For instance, we can refer to the popular backstepping approach (see [1] and the reference therein), or the forwarding approach (see [2], [3], [4], [5]) and some others based on energy considerations (see [6] for a survey of the available approaches).

Although the global asymptotic stability of the equilibrium point can be achieved in some specific cases, it remains difficult to address at the same time, performance issues of a nonlinear system in a closed loop. However, when the first order approximation of the non-linear model is considered, some performance aspects can be addressed by using linear optimal control techniques (using LQ controller for instance).

Hence, it is interesting to raise the question of synthesizing a nonlinear control law which guarantees the global asymptotic stability of the origin while ensuring a prescribed local linear behavior. This type of question has been already discussed in the literature when backstepping design is used to synthesize a nonlinear continuous control law (see [7]).

In the present paper, we consider the same problem in the case of a system whose structure allows forwarding design techniques (see [3], [4]).

The paper is organized as follows. In Section II-A, the problem under consideration is described. Section II-B is devoted to the statement of the main theorem and to its discussion in the case of systems that are obtained after adding some dynamics composed of a stable part and integrations. Section IV gives an illustration of the results on a class of systems composed of a quadratic nonlinear part with a linear subsystem. Finally, Section V gives the conclusion.

II. PROBLEM DESCRIPTION AND GENERAL RESULT

A. Problem description

To present the problem under consideration, we introduce a general controlled nonlinear system described by the following ordinary differential equation:

$$\dot{\chi} = \Phi(\chi, u) , \quad (1)$$

with the state χ in \mathbb{R}^N and $\Phi : \mathbb{R}^N \times \mathbb{R}^m \rightarrow \mathbb{R}^N$ is a C^1 function such that $\Phi(0,0) = 0$ and u is a control input in \mathbb{R}^m . For this system, we can introduce the two matrices describing its first order approximation at the origin which is assumed to be stabilizable:

$$\mathcal{A}_0 := \frac{\partial \Phi}{\partial \chi}(0,0) , \quad \mathcal{G} := \frac{\partial \Phi}{\partial u}(0,0) .$$

For system (1), the problem we intend to solve can be described as follows:

Stabilization with prescribed local behavior: Let the linear state feedback law $u = K_o \chi$

stabilizing the first order approximation of system (1) be given. We are looking for a stabilizing control law $\alpha_o : \mathbb{R}^N \rightarrow \mathbb{R}^m$, differentiable at 0 such that:

- 1) the origin of the system:

$$\dot{\chi} = \Phi(\chi, \alpha_o(\chi)) ,$$

is globally and asymptotically stable.

- 2) The first order approximation of the control law α_o satisfies:

$$\frac{\partial \alpha_o}{\partial \chi}(0) = K_o .$$

A general answer to this problem has been given in [8], requiring the system to be input affine. However, the set of local linear controllers K_o are those which satisfy a specific linear matrix inequality. Adding some structural constraints on the system (1) this problem has been addressed in [7] where the system is in strict feedback form.

In our study, we consider the case in which by decomposing the state as $\chi = [y, x]$ the system (1) can be rewritten in the following Feedforward form.

$$\begin{cases} \dot{y} = Ay + h(x) , \\ \dot{x} = f(x) + g(x)u , \end{cases} \quad (2)$$

with y in \mathbb{R}^{n_y} , x in \mathbb{R}^{n_x} and with $f : \mathbb{R}^{n_x} \rightarrow \mathbb{R}^{n_x}$, $g : \mathbb{R}^{n_x} \rightarrow \mathbb{R}^{n_x \times m}$ and $h : \mathbb{R}^{n_x} \rightarrow \mathbb{R}^{n_y}$ are C^p functions, $p \geq 2$ such that $h(0) = 0$ and $f(0) = 0$ and u is the control input in \mathbb{R}^m .

The stabilization problem for this class of system has been deeply studied in the last two decades employing forwarding techniques (see for instance [2], [3], [4], [5], [9], [10]). Compared to our preliminary result in [11], the novelty comes from the fact that y is not a scalar.

The first order approximation of system (2) is denoted:

$$\begin{cases} \dot{y} = Ay + Hx , \\ \dot{x} = Fx + Gu , \end{cases} \quad (3)$$

with the matrices H , F and G given as

$$F = \frac{\partial f}{\partial x}(0) , \quad H = \frac{\partial h}{\partial x}(0) , \quad G = g(0) . \quad (4)$$

In the following, we make three structural Assumptions on the nonlinear system (2). The first one establishes that the first order approximation is stabilizable.

Assumption 1: The system (3) is stabilizable.

The second assumption we make is also a local property and concerns more specifically the vector field $g(x) = (g_1(x), \dots, g_m(x))$.

Assumption 2: The distribution $\text{Vect}\{g_1(x), \dots, g_m(x)\}$ is involutive and of constant dimension m in a neighborhood of the origin.

In the case where there is only one input (i.e. $m = 1$), this assumption is always satisfied provided $g(0) \neq 0$.

In the spirit of [3], we make the following assumption on the matrix A in the y subsystem.

Assumption 3: There exists a positive definite matrix P in $\mathbb{R}^{n_y \times n_y}$ such that the following equality holds

$$PA + A'P = 0, \quad (5)$$

This Assumption implies that the matrix A has all its eigenvalues with zeros real part and we recover the case in which y is scalar as already studied in our preliminary conference paper [11].

Also, we assume that the stabilization problem with any prescribed local behavior can be solved for the x subsystem in system (2). More precisely, given p in \mathbb{N} we make the following assumption on the functions f and g :

Assumption 4: For all matrix K_x in $\mathbb{R}^{m \times n_x}$ such that the matrix $F + GK_x$ is Hurwitz, there exists a function $\alpha_x : \mathbb{R}^{n_x} \rightarrow \mathbb{R}^m$ of class C^p such that the following two properties are satisfied:

- 1) the origin of the system:

$$\dot{x} = f(x) + g(x)\alpha_x(x). \quad (6)$$

is globally and asymptotically stable;

- 2) the first order approximation of this function satisfies:

$$\frac{\partial \alpha_x}{\partial x}(0) = K_x. \quad (7)$$

B. Main result

We are now ready to state the main result which gives sufficient conditions guaranteeing that the stabilization with prescribed local behavior can be solved for system (2).

Theorem 1 (Adding integration with prescribed local behavior): Assume the System (2) satisfies Assumptions 1, 2, 3 and 4 for a given p in \mathbb{N} . Given a linear controller $K_o = (K_{o,y}, K_{o,x})$

in $(\mathbb{R}^{m \times n_y} \times \mathbb{R}^{m \times n_x})$ such that the matrix:

$$\mathcal{A} = \begin{bmatrix} A & H \\ GK_{o,y} & F + GK_{o,x} \end{bmatrix}, \quad (8)$$

is Hurwitz. Assume moreover that there exists a positive definite matrix \mathcal{P} defined as

$$\mathcal{P} = \begin{bmatrix} P & Q \\ Q' & R \end{bmatrix} \quad (9)$$

which satisfies the weak Lyapunov inequality

$$[\mathcal{P}\mathcal{A} + \mathcal{A}'\mathcal{P}] \leq -c_L \begin{bmatrix} QGG'Q' & 0 \\ 0 & S \end{bmatrix}, \quad (10)$$

and where P is a positive definite matrix in $\mathbb{R}^{n_y \times n_y}$ which satisfies (5) and where S is a $n_x \times n_x$ positive definite matrix and c_L is a positive real number and QG is left invertible. Then there exists a C^{p-1} function $\alpha_o : \mathbb{R}^{n_x+n_y} \rightarrow \mathbb{R}^m$ such that the following properties are satisfied :

1) the function α_o satisfies:

$$\frac{\partial \alpha_o}{\partial y}(0,0) = K_{o,y}, \quad \frac{\partial \alpha_o}{\partial x}(0,0) = K_{o,x}; \quad (11)$$

2) the origin of the system

$$\dot{y} = Ay + h(x), \quad \dot{x} = f(x) + g(x)\alpha_o(x,y), \quad (12)$$

is globally stable¹. Moreover, if any forward bounded solution to the system

$$\dot{y} = Ay, \quad y'QG = 0, \quad (13)$$

defined on $[0 + \infty[$, converges to the origin then the origin is globally asymptotically stable.

C. Discussion on Theorem 1

1) *About Assumption 4* : Assumption 4 is stronger than a stabilizability property since it is assumed that all local behaviors can be recovered for the closed loop system. However, employing the result obtained in [7], yields that Assumption 4 is satisfied in the case in which the x sub-system is in strict feedback form and when the functions f and g are sufficiently smooth. Note also that it is trivially satisfied when this system is a linear controllable system as studied in Section IV.

¹An equilibrium point is said globally stable if it is stable and if all solutions are bounded (see [12, Page 40] for further details).

2) *About the weak linear Lyapunov inequality:*

The right hand side of inequality (10) may not be a full rank matrix. Indeed, this one is of rank $n_x + m$. In order to apply Theorem 1, we need to find \mathcal{P} solution to the weak Lyapunov inequality (10) and (5). Note that in the case there is one input (i.e. $m = 1$), this construction can be reformulated in terms of an equivalent linear matrix inequality. Indeed, we can show the following proposition.

Proposition 1: Let $K_o = [K_{o,y}, K_{o,x}]$ in \mathbb{R}^n be given such that $K_{o,y} \neq 0$. Let P be a positive definite matrix in $\mathbb{R}^{n_y \times n_y}$ which satisfies (5). The matrix \mathcal{P} defined in (9) satisfies (10) with $QG \neq 0$ if and only if it satisfies the following linear matrix inequality

$$\mathcal{P} > 0, \quad [\mathcal{P}\mathcal{A} + \mathcal{A}'\mathcal{P}] \leq -c_L \begin{bmatrix} K'_{o,y}K_{o,y} & 0 \\ 0 & S \end{bmatrix}, \quad S > 0. \quad (14)$$

Proof: Assume (14) is satisfied. Since $K_{o,y} \neq 0$ this implies that $QG \neq 0$. Moreover with (5), $\mathcal{P}\mathcal{A} + \mathcal{A}'\mathcal{P} \leq 0$ implies that $QGK_{o,y} + K'_{o,y}G'Q'$ is a negative semidefinite matrix. For this property to hold, this implies that there exists a positive real number² λ such that $QG = -\lambda K'_{o,y}$. Consequently (10) is satisfied. The proof that (10) implies (14) follows the same lines. ■

In the case in which $n_y = 1$ (this implies that $A = 0$) this assumption can always be satisfied (indeed, this is the usual Lyapunov inequality). However, this is not the case when $n_y > 1$. For instance, if we consider the case of a system whose first order approximation is a linear system of the form

$$\begin{cases} \dot{y}_1 = -y_2 \\ \dot{y}_2 = y_1 + x \\ \dot{x} = u \end{cases} \quad (15)$$

It is shown in Appendix A that for all stabilizing linear controllers in the form $u = k_2 y_2 + k_x x$ where (k_2, k_x) are real numbers (i.e. $K_o = [K_{o,y}, K_{o,x}]$ with $K_{o,y} = [0, k_2]$), it is not possible to find \mathcal{P} such that the weak Lyapunov inequality (10) is satisfied with $QG \neq 0$. Hence, our approach can't be applied for this stabilizing local control law.

²Given two real vectors v_1 and v_2 of the same dimension such that the matrix $v_1 v'_2 + v_2 v'_1$ is negative semidefinite. Note that we have, $(v_1 v'_2 + v_2 v'_1)(|v_2|v_1 + |v_1|v_2) = (|v_2|v_1 + |v_1|v_2)(v'_1 v_2 + |v_1||v_2|)$. Consequently, $(v'_1 v_2 + |v_1||v_2|)$ is an eigenvalue which is strictly positive unless $v'_1 v_2 = -|v_1||v_2|$. Hence the result.

3) *About the result:* As mentioned in the previous comment, when $n_y = 1$, the weak linear Lyapunov inequality is satisfied for all stabilizing linear controller. Consequently when $n_y = 1$, the conclusion of Theorem 1 implies that Assumption 4 is valid for the entire system with stabilizer in C^{p-1} . Hence, with an iterative procedure, higher order systems can be considered. Indeed, let system (1) be with $\chi = (y, z, x)$, with $z = (z_1, \dots, z_{n_z})$ in the form:

$$\begin{cases} \dot{y} = Ay + h(x, z) \\ \dot{z}_1 = h_1(z_2, \dots, z_{n_z}, x) , \\ \vdots \\ \dot{z}_{n_z} = h_{n_z}(x) , \\ \dot{x} = f(x) + g(x)u , \end{cases} \quad (16)$$

with x in \mathbb{R}^{n_x} , z_i in \mathbb{R} and y in \mathbb{R}^{n_y} , $f : \mathbb{R}^{n_x} \rightarrow \mathbb{R}^{n_x}$, $g : \mathbb{R}^{n_x} \rightarrow \mathbb{R}^m$ and $h_i : \mathbb{R}^{n_z-i+n_x} \rightarrow \mathbb{R}$ are C^{i+2} functions, such that $h_i(0, \dots, 0) = 0$ and $f(0) = 0$ and u is the control input in \mathbb{R} . Based on the result obtained from Theorem 1, we can show the following result:

Theorem 2 (Case of higher order systems): Assume the x subsystem of (16) satisfies Assumptions 2 and 4 with $p = n_z + 2$. Assume moreover the first order approximation of this system is stabilizable. For all vector $(K_{o,y}, K_{o,z}, K_{o,x})$ in $(\mathbb{R}^{m \times n_y} \times \mathbb{R}^{m \times n_z} \times \mathbb{R}^{m \times n_x})$ which stabilizes globally and asymptotically the first order approximation of system (16) and such that there exists a matrix \mathcal{P} in the form (9) with Q in $\mathbb{R}^{n_y \times (n_x + n_z)}$ which satisfies (10) with QG left invertible then there exists a C^1 function $\alpha_o : \mathbb{R}^{n_y + n_z + n_x} \rightarrow \mathbb{R}^m$ such that the following properties are satisfied :

1) the function α_o satisfies:

$$\frac{\partial \alpha_o}{\partial y}(0, 0, 0) = K_{o,y} , \quad \frac{\partial \alpha_o}{\partial z}(0, 0, 0) = K_{o,z} , \quad \frac{\partial \alpha_o}{\partial x}(0, 0, 0) = K_{o,x} ;$$

2) the origin of the system (16) in closed loop with $u = \alpha_o(y, z, x)$ is globally stable and if moreover the origin is the only solution to the system (13) then the origin is globally asymptotically stable.

Proof: First, employing Theorem 1 it is shown that the (z_{n_z}, x) -subsystem in system (16) satisfies Assumption 4 with $p = n_z + 1$. Recursively, we apply again Theorem 1 and we obtain the result. ■

In the paper [8], the stabilization with prescribed local behavior has been addressed and studied on an inverted pendulum model. In some specific coordinates, this inverted pendulum model can

be put in forwarding form and a forwarding control law has been introduced in [3]. It is noticed in [8] that, statistically, for all local behavior obtained from a LQ approach, the stabilization with prescribed local behavior could be solved. Consequently, Theorem 1 establishes a theoretical justification on the fact that the approach of [8] applies on the forwarding model of the inverted pendulum.

III. PROOF OF THEOREM 1

The proof of this result is divided into four parts. In the first part, we focus on the linear approximation of the system and we show that the quadratic Lyapunov function associated with the local stabilizer (i.e. \mathcal{P}) can be rewritten in the form of a Lyapunov matrix that would have been obtained by following the forwarding design method of [3]. In the second part of the proof, we construct a candidate Lyapunov function V for the nonlinear model such that its quadratic approximation is the matrix \mathcal{P} . In the third part, from this candidate Lyapunov function we construct a control law which makes non positive the time derivative of the candidate Lyapunov function. By interpolating this control law with the local controller, we finally get our solution to the stabilization with prescribed local behavior. Finally, in the fourth part, we construct a Lyapunov function associated to this control law and show that LaSalle invariance principle may be applied to get asymptotic convergence of the closed loop trajectories toward the origin.

A. Part 1: Forwarding local Lyapunov function

In this part of the proof, we show that the weak Lyapunov matrix \mathcal{P} associated with the matrix \mathcal{A} can be rewritten in the form of a Lyapunov matrix that would have been obtained following the Forwarding design method of [3] or [5].

Indeed, note that the Lyapunov function associated to the matrix \mathcal{P} can be decomposed as follows.

$$\begin{bmatrix} y' & x' \end{bmatrix} \mathcal{P} \begin{bmatrix} y \\ x \end{bmatrix} = x' R_x x + (y - Mx)' P (y - Mx) , \quad (17)$$

where R_x and M are respectively a matrix in $\mathbb{R}^{n_x \times n_x}$ and a vector in \mathbb{R}^{n_x} defined as:

$$R_x = R - Q' P^{-1} Q , \quad M = -P^{-1} Q . \quad (18)$$

If we compare the decomposition in equation (17) and the structure of the Lyapunov function obtained by the forwarding technique of [3] (see [5, equation (3)]), we see that the matrix \mathcal{P}

would be a Lyapunov matrix obtained by a forwarding design technique provided there exists K_x a vector in \mathbb{R}^{n_x} such that the following two requirements are satisfied:

- 1) There exists a matrix K_x in $\mathbb{R}^{m \times n_x}$ which may differ from $K_{o,x}$ and such that the following algebraic equation is satisfied (see [3, equation (132)]):

$$M(F + GK_x) = AM + H . \quad (19)$$

- 2) $u = K_x x$ is a control law for the x -subsystem associated to the Lyapunov matrix R_x . In other words, $F + GK_x$ is a Hurwitz matrix and the following inequalities are satisfied :

$$R_x > 0 , \quad R_x(F + GK_x) + (F + GK_x)'R_x < 0 ; \quad (20)$$

In this part of the proof we show that a vector K_x satisfying (19) and (20) does exist. Indeed, we can decompose $\mathcal{A} = \mathcal{A}_0 + \mathcal{G}K_o$ with³

$$\mathcal{A}_0 = \begin{bmatrix} A & H \\ 0_{n,1} & F \end{bmatrix} , \quad \mathcal{G} = \begin{bmatrix} 0 \\ G \end{bmatrix} .$$

With these notation, we have

$$\mathcal{P}\mathcal{G} = \begin{bmatrix} QG \\ RG \end{bmatrix}$$

and, employing the fact that $PA + A'P = 0$ we get

$$\mathcal{P}\mathcal{A}_0 + \mathcal{A}_0'\mathcal{P} = \begin{bmatrix} 0 & PH + QF + A'Q \\ Q'A + H'P + F'Q' & Q'H + RF + H'Q + F'R \end{bmatrix} .$$

Since we have assumed that QG is left invertible we can introduce the two matrices respectively in $\mathbb{R}^{n_y \times n_x}$ and $\mathbb{R}^{n_y \times n_y}$

$$w_1 = -QG(G'Q'QG)^{-1}G'R , \quad w_2 = QG(G'Q'QG)^{-1}G'Q' - I . \quad (21)$$

Note that we have

$$w_1'QG = -RG , \quad w_2'QG = 0 .$$

Hence, we have for all $n_x \times n_y$ real matrices β ,

$$v'\mathcal{P}\mathcal{G} = 0 , \quad v = \begin{bmatrix} w_1 + w_2\beta \\ I_{n_x} \end{bmatrix} . \quad (22)$$

³the symbol $0_{a,b}$ stands for a $a \times b$ zero matrix.

Note moreover that we have

$$v' \begin{bmatrix} QGG'Q' & 0 \\ 0 & S \end{bmatrix} v = S + RGG'R > 0 .$$

Hence, it implies with (10)

$$v'[\mathcal{P}\mathcal{A} + \mathcal{A}'\mathcal{P}]v < 0 .$$

This yields recalling that $\mathcal{A} = \mathcal{A}_0 + \mathcal{G}K_o$ and with (22)

$$v'[\mathcal{P}\mathcal{A}_0 + \mathcal{A}_0'\mathcal{P}]v < 0 . \quad (23)$$

More precisely, the following inequality is satisfied for all β

$$\begin{aligned} v'[\mathcal{P}\mathcal{A}_0 + \mathcal{A}_0'\mathcal{P}]v &= [\beta'w_2'(PH + QF + A'Q) + (H'P + F'Q' + QA)w_2\beta] \\ &+ [w_1'(PH + QF + A'Q) + (H'P + F'Q' + QA)w_1 + Q'H + RF + H'Q + F'R] < 0 . \end{aligned} \quad (24)$$

The matrix inequality (24) being true for all matrices β , it is for instance true for $\beta = \alpha w_2'(PH + QF + A'Q)$ where α is a positive real number. Hence we get

$$\begin{aligned} \alpha^2 [w_2'(PH + QF + A'Q)(H'P + F'Q' + QA)w_2] \\ + [w_1'(PH + QF + A'Q) + (H'P + F'Q' + QA)w_1 + Q'H + RF + H'Q + F'R] < 0 . \end{aligned}$$

Letting α goes to infinity implies that we have

$$w_2'(PH + QF + A'Q) = 0 . \quad (25)$$

This gives,

$$QG(G'Q'QG)^{-1}G'Q'(PH + QF + A'Q) - PH - QF - A'Q = 0 .$$

Consequently it yields

$$-Q[F + G[-(G'Q'QG)^{-1}G'Q'(PH + QF + A'Q)]] = A'Q + PH . \quad (26)$$

Left multiplying the previous equality by P^{-1} and employing the fact that with (5) we have $P^{-1}A' = -AP^{-1}$ it yields

$$-P^{-1}Q[F + G[-(G'Q'QG)^{-1}G'Q'(PH + QF + A'Q)]] = A[-P^{-1}Q] + H . \quad (27)$$

Hence, we recover equation (19) with $M = -P^{-1}Q$ and

$$K_x = -(G'Q'QG)^{-1}G'Q'(PH + QF + A'Q) . \quad (28)$$

It remains to check if K_x satisfies (20). Note that (24) and (25) imply that

$$w_1'(PH + QF + A'Q) + (H'P + F'Q' + QA)w_1 + Q'H + RF + H'Q + F'R < 0 .$$

Replacing w_1 by its definition given in (21) in the previous inequality yields,

$$R(F + GK_x) + (F + GK_x)'R + Q'H + H'Q < 0 . \quad (29)$$

On another hand, with (27), we have

$$Q'H = -Q'P^{-1}Q[F + GK_x] - Q'AP^{-1}Q .$$

Hence (29) becomes employing again $P^{-1}A' = -AP^{-1}$,

$$S_x := R_x(F + GK_x) + (F + GK_x)'R_x < 0 . \quad (30)$$

Therefore, for the time being, we showed this surprising property.

Lemma 1: Let \mathcal{P} be a matrix in the form (9) solution to the weak Lyapunov inequality (10) and such that its upper left block is a Lyapunov matrix associated to A (i.e. (5) is satisfied). Then this matrix can be decomposed in a forwarding-like manner. In other words, M and R_x defined in (18) satisfy (19) and (20).

From this crucial property, we will be able to get a candidate Lyapunov function for the nonlinear system associated to the local controller.

B. Part 2: Construction of the global CLF

In this part of the proof we construct a global (weak) control Lyapunov function denoted V_g for the nonlinear system (2) and such that its Hessian satisfies⁴ $\mathcal{H}(V_g)(0) = 2\mathcal{P}$. The construction of the candidate Lyapunov function is based on a modified forwarding technique inspired from [3] and employs Assumption 4. First, with Assumption 4, and the local stabilizer K_x given in (28), there exists a C^p function $\alpha_x : \mathbb{R}^n \rightarrow \mathbb{R}^m$ such that the origin of the system (6) is globally and asymptotically stable and the local property (7) is satisfied.

Now, we can apply the following Lemma whose proof is given in Appendix B.

Lemma 2: There exists a C^∞ Lyapunov function $V_x : \mathbb{R}^n \rightarrow \mathbb{R}_+$, proper and positive definite, such that:

⁴The symbol \mathcal{H} denotes the operator which gives the Hessian of a given C^2 function in \mathbb{R}^n .

- V_x is a Lyapunov function associated to the closed loop system (6). In other words, we have:

$$-W_x(x) := \frac{\partial V_x}{\partial x}(x) [f(x) + g(x)\alpha_x(x)] < 0, \forall x \neq 0; \quad (31)$$

- V_x is locally quadratic and its local approximation is R_x defined in (18). We have:

$$\mathcal{H}(V_x)(0) = 2R_x. \quad (32)$$

For the non linear system (2), following the forwarding design described in [13] and [3], we can introduce the function $\mathcal{M} : \mathbb{R}^{n_x} \rightarrow \mathbb{R}^{n_y}$ defined as:

$$\mathcal{M}(x) = \int_{+\infty}^0 \exp(-As) h(X_1(x, s)) ds, \quad (33)$$

where $X_1(x, s)$ is the solution initiated from x and evaluated at time s of the system:

$$\dot{x} = f(x) + g(x)\alpha_x(x).$$

The following Lemma can be obtained from [13, Lemma 6.88]. See also [4, Section 5.2] et [3].

Lemma 3 ([13]): The function \mathcal{M} defined in (33) is zero at the origin, C^p and satisfies the following partial differential equation:

$$\frac{\partial \mathcal{M}}{\partial x}(x) [f(x) + g(x)\alpha_x(x)] = A\mathcal{M}(x) + h(x), \forall x \in \mathbb{R}^n. \quad (34)$$

With V_x obtained from Lemma 2, the function \mathcal{M} given in (33) we consider the C^p candidate Lyapunov function $V_g : \mathbb{R}^{n+1} \rightarrow \mathbb{R}_+$ as:

$$V_g(y, x) = V_x(x) + (y - \mathcal{M}(x))' P (y - \mathcal{M}(x)). \quad (35)$$

This function is proper and positive definite and, according to [3], it is a global weak CLF⁵.

⁵Actually we can replace the function \mathcal{M} by its first order approximation at the origin namely we can replace $\mathcal{M}(x)$ by $\frac{\partial \mathcal{M}}{\partial x}(0)x = Mx$. But then the Lyapunov function in (35) has to be modified in

$$V_g(y, x) = \ell(V_x(x)) + \left[\sqrt{1 + (y - Mx)' P (y - Mx)} - 1 \right] \quad (36)$$

where ℓ is a C^1 class \mathcal{K}^∞ function to be tuned large (enough). For more details, see [3], [13] or [12].

To complete Part 2 of the proof, it remains to show the quadratic approximation of the candidate Lyapunov function is \mathcal{P} . More precisely, it remains to show that $\mathcal{H}(V_g)(0,0) = 2\mathcal{P}$.

Note that

$$\mathcal{H}(V_g)(0,0) = \begin{bmatrix} 2P & -2P \frac{\partial \mathcal{M}}{\partial x}(0) \\ -2 \left(\frac{\partial \mathcal{M}}{\partial x}(0) \right)' P & \mathcal{H}(V_x)(0) + 2 \left(\frac{\partial \mathcal{M}}{\partial x}(0) \right)' \frac{\partial \mathcal{M}}{\partial x}(0) \end{bmatrix}. \quad (37)$$

By evaluating the partial derivative of (34) at the origin where f , α_x and h are zero, we get :

$$\frac{\partial \mathcal{M}}{\partial x}(0)(F + GK_x) - A \frac{\partial \mathcal{M}}{\partial x}(0) = H.$$

The eigenvalues of $(F + GK_x)$ and A being all different, the solution of this algebraic equation is unique and with (19), we get:

$$\frac{\partial \mathcal{M}}{\partial x}(0) = M = -P^{-1}Q.$$

Hence, equality (37) becomes:

$$\mathcal{H}(V_g)(0,0) = 2 \begin{bmatrix} P & Q \\ Q' & R \end{bmatrix} = 2\mathcal{P}. \quad (38)$$

C. Part 3: Construction of the controller

In this part of the proof we construct the global control law denoted α_o solution to stabilization with prescribed local behavior problem. This one is obtained by interpolating K_o and a global control law α_g .

By looking at the time derivative of V_g along the solution of the system (2), we see that a control law ensuring stabilization of the origin of the system (2) and boundedness of the solutions can be obtained simply⁶ as:

$$\alpha_g(y,x) = \alpha_x(x) - \frac{\partial V_x}{\partial x}(x)g(x) + 2(y - \mathcal{M}(x))' P \frac{\partial \mathcal{M}}{\partial x}(x)g(x). \quad (39)$$

Indeed, with (31) this gives along the trajectory of the system (2) :

$$\left. \frac{d}{dt} \overline{V_g(y,x)} \right|_{u=\alpha_g(y,x)} = -W_x(x) - \left(\frac{\partial V_x}{\partial x}(x)Gg(x) - 2(y - \mathcal{M}(x))' P \frac{\partial \mathcal{M}}{\partial x}(x)g(x) \right)^2, \quad (40)$$

⁶Note that to design this control, we need to construct the function \mathcal{M} solution to the PDE (34). Hence, it may be difficult to apply this strategy for general feedforward systems. However, as shown in the following Section, when we consider some specific systems, this control law may be given in closed form. Moreover, when considering the Lyapunov function V_g given in (36) and provided we are able to compute the function ℓ , an explicit solution may be given.

which is non positive. But, unfortunately, the first order approximation of the control law α_g is

$$K_g = \begin{bmatrix} \frac{\partial \alpha_g}{\partial y}(0,0) & \frac{\partial \alpha_g}{\partial x}(0,0) \end{bmatrix} = \begin{bmatrix} K_{g,x} & K_{g,y} \end{bmatrix} ,$$

with

$$K_{g,x} = K_x - 2G'R_x - 2G'M'PM , \quad K_{g,y} = 2G'M'P .$$

And this one is not equal to the given one K_o . Hence the control law $u = \alpha_g(y,x)$ is not a solution to the stabilization with prescribed local behavior.

The idea of the construction is to show that the two controllers $u = \alpha_g(y,x)$ and $u = K_{o,y}y + K_{o,x}x$ makes the time derivative of a same Lyapunov function non positive in a small neighborhood of the origin.

Indeed, we have the following lemma whose proof is given in appendix.

Lemma 4 (Same Lyapunov function for the two controllers α_g and K_o): There exist a positive definite function $V_L : \mathbb{R}^{n_y} \times \mathbb{R}^{n_x} \rightarrow \mathbb{R}_+$ and three positive real numbers R_L , c_g and c_o such that for all (y,x) such that $V_L(y,x) \leq R_L$ we have

$$\left. \overline{\dot{V}_L(y,x)} \right|_{u=\alpha_g(y,x)} \leq -c_g (|x|^2 + |y'PMG|^2) , \quad (41)$$

and,

$$\left. \overline{\dot{V}_L(y,x)} \right|_{u=K_{o,y}y+K_{o,x}x} \leq -c_o [|x|^2 + |y'PMG|^2] . \quad (42)$$

The proof of this Lemma relies on the use of change of coordinates which rectifies the controlled vector field g around the origin. This property relies on Assumption 2.

The two controllers K_o and α_g making non positive the time derivative of the same Lyapunov function and the system being input affine it yields that any convex combination of both controllers will have the same property. Hence, we can interpolate in a neighborhood of the origin this control law with the prescribed one.

$$\alpha_o(y,x) = (1 - \rho(y,x))(K_{o,y}y + K_{o,x}x) + \rho(y,x)\alpha_g(y,x) \quad (43)$$

with ρ any smooth function taking value in $[0,1]$ and such that:

$$\rho(y,x) = \begin{cases} 0 & \text{if } V_L(y,x) \leq \frac{1}{3}R_L , \\ 1 & \text{if } V_L(y,x) \geq \frac{2}{3}R_L . \end{cases}$$

Indeed, in this case we get along the solution of the system (2) and for all (y, x) such that $V_L(y, x) \leq R_L$

$$\left. \overline{\dot{V}_L(y, x)} \right|_{u=\alpha_o(y, x)} = (1 - \rho(y, x)) \left. \overline{\dot{V}_L(y, x)} \right|_{u=K_{o,y}y + K_{o,x}x} + \rho(y, x) \left. \overline{\dot{V}_L(y, x)} \right|_{u=\alpha_g(y, x)} \leq 0 .$$

This is sufficient to conclude that we have stability of the equilibrium. Note however that in order to study its asymptotic behavior and its convergence toward zero we make in the following section an analysis by introducing a Lyapunov function associated to our controller.

D. Part 4: Modification of the global CLF to prove asymptotic stability

In this part, we unite the two functions V_g and V_L in order to obtain a Lyapunov function associated to the controller α_o . Following [14] consider the function V_o defined as

$$V_o(y, x) = \gamma(V_L(y, x))V_L(y, x) + d[1 - \gamma(V_L(y, x))]V_g(y, x)$$

where γ is any smooth and non increasing function such that

$$\gamma(s) = \begin{cases} 0 & \text{if } s \geq R_L , \\ 1 & \text{if } s \leq \frac{2}{3}R_L , \end{cases}$$

and d is a positive real number such that

$$V_L(y, x) \leq dV_g(y, x) , \quad \forall (y, x) : \frac{2}{3}R_L \leq V_L(y, x) \leq R_L .$$

Note that we have with $u = \alpha_o(y, x)$,

$$\begin{aligned} \left. \overline{\dot{V}_o(y, x)} \right|_{u=\alpha_o(y, x)} &= \gamma'(V_L(y, x)) [V_L(y, x) - dV_g(y, x)] \left. \overline{\dot{V}_L(y, x)} \right|_{u=\alpha_o(y, x)} \\ &\quad + \gamma(V_L(y, x)) \left. \overline{\dot{V}_L(y, x)} \right|_{u=\alpha_o(y, x)} + d(1 - \gamma(V_L(y, x))) \left. \overline{\dot{V}_g(y, x)} \right|_{u=\alpha_o(y, x)} . \end{aligned}$$

and different cases may be distinguished:

- 1) If $V_L(y, x) \geq R_L$. In this case, we have $\alpha_o(y, x) = \alpha_g(y, x)$, $\gamma'(V_L(y, x)) = 0$ and $\gamma(V_L(y, x)) = 0$. Consequently, we get,

$$\left. \overline{\dot{V}_o(y, x)} \right|_{u=\alpha_o(y, x)} = -dW_x(x) - d \left(\frac{\partial V_x}{\partial x}(x) Gg(x) - 2(y - \mathcal{M}(x))' P \frac{\partial \mathcal{M}}{\partial x}(x) Gg(x) \right)^2 ,$$

- 2) If $R_L \geq V_L(y, x) \geq \frac{2}{3}R_L$. In this case, we have $\alpha_o(y, x) = \alpha_g(y, x)$. Consequently, we have

$$\left. \overline{\dot{V}_L(y, x)} \right|_{u=\alpha_o(y, x)} \leq 0 \text{ and } \left. \overline{\dot{V}_g(y, x)} \right|_{u=\alpha_o(y, x)} \leq 0 \text{ Moreover we have } V_L(y, x) - dV_g(y, x) \leq 0$$

and $\gamma'(V_L(y, x)) \leq 0$. Hence, with (41) it yields,

$$\begin{aligned} \overline{\dot{V}_o(y, x)} \Big|_{u=\alpha_o(y, x)} &\leq -c_g \gamma(V_L(y, x)) [|x|^2 + |y'PMG|^2] \\ &\quad -d(1 - \gamma(V_L(y, x))) \left[W_x(x) + \left(\frac{\partial V_x}{\partial x}(x) Gg(x) - 2(y - \mathcal{M}(x))' P \frac{\partial \mathcal{M}}{\partial x}(x) Gg(x) \right)^2 \right] \end{aligned}$$

3) If $\frac{2}{3}R_L \geq V_L(y, x)$. We have $\gamma'(V_L(y, x)) = 0$ and $\gamma(V_L(y, x)) = 1$. Hence, it yields,

$$\overline{\dot{V}_o(y, x)} \Big|_{u=\alpha_o(y, x)} = \gamma(V_L(y, x)) \overline{\dot{V}_L(y, x)} \Big|_{u=\alpha_o(y, x)} .$$

On another hand we have,

$$\begin{aligned} \overline{\dot{V}_L(y, x)} \Big|_{u=\alpha_o(y, x)} &= (1 - \rho(y, x)) \overline{\dot{V}_L(y, x)} \Big|_{u=(K_{o,y}y + K_{o,x}x)} + \rho(y, x) \overline{\dot{V}_L(y, x)} \Big|_{u=\alpha_g(y, x)} , \\ &\leq -[c_o(1 - \rho(y, x)) + c_g \rho(y, x)] [|x|^2 + |y'MG|^2] . \end{aligned}$$

Hence, we get global stability and local asymptotic stabilization. Moreover, the control law satisfies the local property requested.

Finally, from LaSalle invariance principle, it follows that, for each trajectory, there exists a real number v such that it converges the trajectories converge to the largest set of points $(y, 0)$, invariant for the system

$$\dot{y} = Ay$$

and satisfying

$$V_o(y, 0) = v \quad , \quad y'PMG = 0 .$$

Recalling that $M = -P^{-1}Q$, we get the result.

IV. ILLUSTRATION ON A PARTICULAR CLASS OF SYSTEMS

In this section, we consider the problem of designing a robust stabilizing control law for a class of disturbed strict feedforward systems with linear x dynamics and a quadratic function h . In other words we consider the case in which the system (2) is in the form

$$\begin{cases} \dot{y} = Ay + h(x) + d_y(y, x)\omega \\ \dot{x} = Fx + Gu + d_x(y, x)\omega \end{cases} , \quad (44)$$

where to simplify the presentation we consider the mono input case (i.e. $m = 1$) and ω is an unknown input which is assumed to be a locally bounded time function taking values in \mathbb{R}^{n_ω} and

d_y and d_x are locally Lipschitz function of appropriate dimension. We assume that the function $h(x)$ is a quadratic function. Hence, this one can be written in the form

$$h(x) = Hx + \begin{bmatrix} x' H_1 x \\ \vdots \\ x' H_{n_y} x \end{bmatrix}, \quad (45)$$

where for all i in $\{1, \dots, n_y\}$, $H'_i = H_i$ is in $\mathbb{R}^{n_x \times n_x}$.

A framework to design a robust control law for this system can be to follow the H_∞ design methodology (see [15]). In this context, we are looking for a control law that satisfies two distinct objectives:

- 1) The first one is to guarantee the asymptotic stability of the origin when the disturbance vanishes.
- 2) The second one is to guarantee a given attenuation level of a quadratic functional of the state and control in the L_2 framework. More precisely, given a positive definite matrix Q in $\mathbb{R}^{(n_x+n_y) \times (n_x+n_y)}$ and a positive real number γ (the attenuation level) we want to find a stabilizing feedback control law $u = \alpha_o(y, x)$ such that the following inequality is satisfied for all t in \mathbb{R}_+ :

$$\int_0^t [(y(s), x(s))' Q (y(s), x(s)) + u(s)^2] ds \leq \gamma^2 \int_0^t |\omega(s)|^2 ds, \quad (46)$$

where $(y(\cdot), x(\cdot))$ denotes the solution of system (44) initialized to the origin.

Solving this problem relies on the construction of a solution to a nonlinear Hamilton Jacobi Bellman equality which can be difficult (or impossible) to solve (see [15]).

However, if we focuss on the linear approximation of system (44), then this problem can be solved locally. The first order approximation of system (44) is a linear system defined as:

$$\begin{cases} \dot{y} = Ay + Hx + D_y \omega \\ \dot{x} = Fx + Gu + D_x \omega \end{cases}, D_y = d_y(0, 0), D_x = d_x(0, 0). \quad (47)$$

In compact form, this linear system can be rewritten as follows.

$$\dot{\chi} = \mathcal{A}_0 \chi + \mathcal{G}u + \mathcal{D}\omega \quad \chi' = [y', x'].$$

In the linear context, the Hamilton Jacobi Bellman equality is an algebraic equation defined as:

$$\mathcal{S} \mathcal{A}_0 + \mathcal{A}_0' \mathcal{S} + \frac{1}{\gamma} \mathcal{S} \mathcal{D} \mathcal{D}' \mathcal{S} - \mathcal{S} \mathcal{G} \mathcal{G}' \mathcal{S} + Q = 0. \quad (48)$$

where the solution \mathcal{S} is a positive definite matrix in $\mathbb{R}^{(n_x+n_y) \times (n_x+n_y)}$, and a robust linear control for system (47) solving the disturbance attenuation problem as defined by inequality (46) for the linear approximation is given as:

$$u = K_o[y, x]' = -\mathcal{G}' \mathcal{S} \chi . \quad (49)$$

However, this control law guarantees only local asymptotic stability of the origin of system (44). We may apply the design methodology given in Theorem 1 to design a global asymptotic stabilizing controller $u = \alpha_o(y, x)$ such that its local behavior is exactly K_o .

We assume that the system (47) is controllable and the matrix A is skew symmetric. This yields that Assumption 1 and 3 are satisfied. Moreover, the x subsystem being linear, it yields that Assumption 2 and 4 are trivially satisfied. In this case, we may apply the procedure of Theorem 1 as described by the following four steps.

- 1) First, we choose a local prescribed behavior K_o by solving the HJB algebraic equation (48) for given tuning parameters Q and γ .
- 2) We solve the linear matrix inequality (14) to find a forwarding like matrix \mathcal{P} (see Theorem 1 equation (10)). Note that this step is not guaranteed to succeed when $n_y > 1$. This gives us a stabilizing controller K_x for the x -subsystem (see equation (28)) and its associated Lyapunov matrix R_x (given in equation (18)).
- 3) Then, using this K_x and R_x , we give an explicit solution \mathcal{M} to the partial differential equation (34). As shown in appendix D, in our particular context this one can simply be expressed as

$$\mathcal{M}(x) = Mx + \begin{bmatrix} x' M_1 x \\ \vdots \\ x' M_{n_y} x \end{bmatrix} , \quad (50)$$

where M is solution to the Sylvester equation

$$M[F + GK_x] - AM = H , \quad (51)$$

and (M_1, \dots, M_{n_y}) are matrices in $\mathbb{R}^{n_x \times n_x}$ obtained by solving the *unsquare* Sylvester

equation⁷:

$$\left[I_{n_y} \otimes [F + GK_x]' - A \otimes I_{n_x} \right] \cdot \begin{bmatrix} M_1 \\ \vdots \\ M_{n_y} \end{bmatrix} + \begin{bmatrix} M_1 \\ \vdots \\ M_{n_y} \end{bmatrix} \cdot [F + GK_x] = \begin{bmatrix} H_1 \\ \vdots \\ H_{n_y} \end{bmatrix}, \quad (52)$$

where the operator \otimes is the Kronecker tensor product.

4) Next we construct the globally stabilizing feedback law defined as

$$\alpha_g(y, x) = (K_x - 2G'R_x)x + 2[y - \mathcal{M}(x)]' P \frac{\partial \mathcal{M}}{\partial x}(x) G. \quad (53)$$

and we modify this, control law to match the local desired behavior. To complete the modified forwarding procedure, we construct a control law $\alpha_o(y, x)$ (see equation (43)) with function $\rho(y, x)$ chosen as :

$$\rho(y, x) = \begin{cases} 0 & \text{if } [y' \ x'] \mathcal{P} \begin{bmatrix} y \\ x \end{bmatrix} \leq \frac{1}{3}R_L, \\ \frac{3}{R_L} [y' \ x'] \mathcal{P} \begin{bmatrix} y \\ x \end{bmatrix} - 1 & \text{if } \frac{1}{3}R_L \leq [y' \ x'] \mathcal{P} \begin{bmatrix} y \\ x \end{bmatrix} \leq \frac{2}{3}R_L, \\ 1 & \text{if } [y' \ x'] \mathcal{P} \begin{bmatrix} y \\ x \end{bmatrix} \geq \frac{2}{3}R_L. \end{cases} \quad (54)$$

where R_L is computed with Lemma 4.

The benchmark example [9, equation (39)] (see also [10]) fits in the class of system considered in this section. More precisely, system (44) is studied in the particular cases in which $n_y = 1$, $n_x = 2$ and the parameters are selected as follows.

$$A = 0, \ H_1 = \begin{bmatrix} 1 & -1 \\ -1 & 1 \end{bmatrix}, \ H = \begin{bmatrix} 1 & 0 \end{bmatrix}, \ F = \begin{bmatrix} 0 & 1 \\ 0 & 0 \end{bmatrix}, \ G = D_x = \begin{bmatrix} 0 \\ 1 \end{bmatrix}, \ D_y = 0. \quad (55)$$

For this system we can follow the procedure to design a global stabilizer with local optimality.

1) We select the tuning parameter of the local optimal controller as:

$$Q = \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & 0 & 10 \end{bmatrix}, \ \gamma \approx 1.00.$$

Solving the associated Riccati equation (see equation (48)) by employing the routine (*care*) of Matlab with the attenuation level $\gamma \approx 1.00$, it yields the local optimal controller

$$K_o \approx \begin{bmatrix} -4.3674 & -26.9105 & -80.7232 \end{bmatrix}.$$

⁷It is shown in appendix D that this Sylvester equation admits a solution.

2) In the case $n_y = 1$, we obtain directly the matrix \mathcal{P} given as

$$\mathcal{P} \approx \begin{bmatrix} 1 & 3 & 4.37 \\ 3 & 14.11 & 29.91 \\ 4.37 & 29.91 & 80.72 \end{bmatrix} .$$

This yields the controller K_x and the matrix R_x given as:

$$K_x \approx \begin{bmatrix} -2.9997 & -4.36 \end{bmatrix} , R_x \approx \begin{bmatrix} -3.39 & -2.18 \\ -2.18 & -3.90 \end{bmatrix} .$$

3) We get the solution to the PDE given in equation (50) with

$$M \approx \begin{bmatrix} -2.11 & -2.16 \end{bmatrix} , M_1 \approx \begin{bmatrix} -5.61 & -2.16 \\ -2.16 & -3.24 \end{bmatrix} .$$

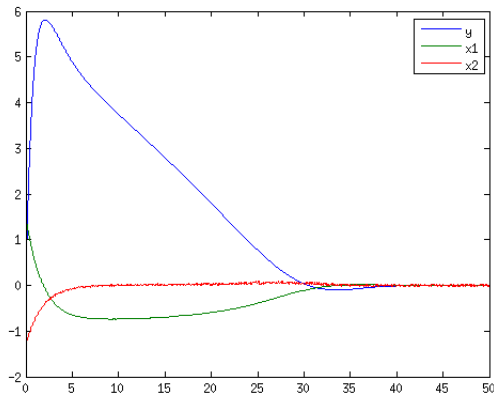
4) By a Matlab computation, it yields the positive real number R_L given as:

$$R_L \approx 5 .$$

In the following figures is considered simulation of this control law when considering ω to be a gaussian white noise with variance 2.

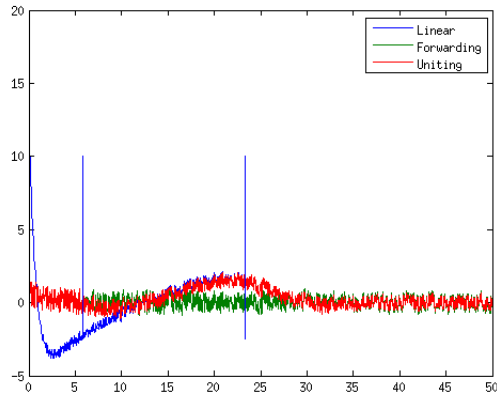
Fig. 1. Example of a closed loop trajectory

In Figure 1 is shown a state trajectory when considering a particular initial condition for the disturbed model.

In Figure 2 is depicted the associated control law. The red one is the locally optimal control. The blue is the evaluation of the optimal local and linear control law along the solution of the

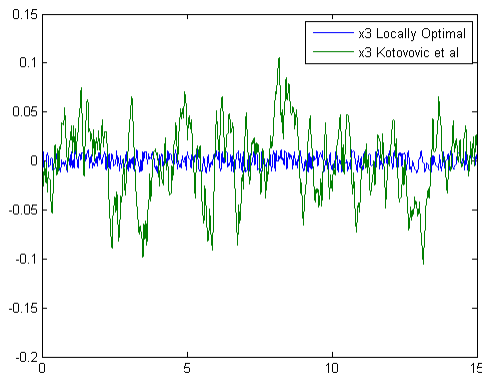
system. Finally the green one is the evaluation of the global forwarding control law. It can be checked that the solution goes from the green toward the red one when the solution gets close to the origin.

The last figure compares the proposed control law which is locally optimal with respect to a given cost and the control law given in [9, equation (39)] when considering solution initiated from the origin.

V. CONCLUSION

We have studied the problem of designing a stabilizing controller which ensures a desired local behavior. We have shown that given a prescribed locally stabilizing control law, provided

there exists a Lyapunov matrix with a specific structure, this stabilizing local behaviors can be reproduced when using the forwarding design technique developed in [3], [4]. This is made possible by modifying the forwarding design adequately. Note that when the y subsystem is of dimension 1, this result establishes that all stabilizing local behaviors can be reproduced. This result gives a theoretical justification of a statistical result given in [8].

APPENDIX

A. On the feasibility of the weak Lyapunov inequality

In this Section, we study the feasibility of the weak Lyapunov inequality (10) when considering systems whose first order approximation is the system (15). Assume a stabilizing local controller $K_o = [0, k_2, k_x]$ is given. Note that, the necessary and sufficient conditions to make $u = k_2 y_2 + k_x x$ a globally and asymptotically stabilizing input are

$$k_2 < 0, \quad k_x < 0. \quad (56)$$

First of all note that $A = \begin{bmatrix} 0 & -1 \\ 1 & 0 \end{bmatrix}$. Let $P = \begin{bmatrix} P_{11} & P_{12} \\ P_{12} & P_{22} \end{bmatrix}$ in $\mathbb{R}^{2 \times 2}$ be a Lyapunov matrix which satisfies (5). Note that

$$PA + A'P = \begin{bmatrix} 2P_{12} & P_{22} - P_{11} \\ P_{22} - P_{11} & -2P_{12} \end{bmatrix} = 0.$$

Hence, this implies that $P_{12} = 0$ and $P_{22} = P_{11}$. In other word, the only Lyapunov matrix which satisfies (5) are those which take the form $P = pI_2$. For a candidate Lyapunov matrix in the form (we have normalized with respect to p):

$$\mathcal{P} \triangleq \begin{pmatrix} 1 & 0 & q_1 \\ 0 & 1 & q_2 \\ q_1 & q_2 & r \end{pmatrix}$$

to, be positive definite, parameters q_1 , q_2 and r must satisfy:

$$r > q_1^2 + q_2^2$$

Assume there exists k_2 and k_x which satisfies (56) and such that there exists q_1 , q_2 and r with q_1 and q_2 not equal to zero such that the weak Lyapunov inequality (10) is satisfied. Inequality

(10) implies that the following matrix is non positive

$$Q \triangleq [\mathcal{A}' \mathcal{P} + \mathcal{P} \mathcal{A}'] = \begin{bmatrix} 0 & k_2 q_1 & q_2 + k_x q_1 \\ * & 2k_2 q_2 & -q_1 + k_2 r + 1 + k_x q_2 \\ * & * & 2q_2 + 2k_x r \end{bmatrix}.$$

It implies that for all (v_1, v_2) in \mathbb{R}^2 , we have

$$[v_1, v_2, 0] Q \begin{bmatrix} v_1 \\ v_2 \\ 0 \end{bmatrix} \leq 0 \Leftrightarrow k_2 q_1 v_2 v_1 - 2k_2 q_2 v_2^2 \leq 0.$$

Hence, this implies that $q_1 = 0$. Moreover for all (v_1, v_3) in \mathbb{R}^2 , we have

$$[v_1, 0, v_3] Q \begin{bmatrix} v_1 \\ 0 \\ v_3 \end{bmatrix} := [v_1, 0, v_3] \begin{bmatrix} 0 & 0 & q_2 \\ * & 2k_2 q_2 & k_2 r + 1 + k_x q_2 \\ * & * & 2q_2 + 2k_x r \end{bmatrix} \begin{bmatrix} v_1 \\ 0 \\ v_3 \end{bmatrix} \leq 0,$$

which means for all (v_1, v_3) in \mathbb{R}^2

$$q_2 v_3 v_1 + (2q_2 + 2k_x r) v_3^2 \leq 0.$$

Hence, $q_1 = q_2 = 0$ which contradicts the assertion.

B. proof of Lemma 2

The proof of this Lemma is based on recent results obtained in [14]. Indeed, the design of the function V_x is obtained from the uniting of a quadratic local control Lyapunov function (denoted V_0) and a global control Lyapunov function (denoted V_∞) obtained employing a converse Lyapunov theorem.

First of all, employing the converse Lyapunov theorem of Kurzweil [16], there exists a C^∞ function $V_\infty : \mathbb{R}^n \rightarrow \mathbb{R}_+$ such that

$$\frac{\partial V_\infty}{\partial x}(x)[f(x) + g(x)\alpha_x(x)] < 0, \quad \forall x \neq 0.$$

On the other hand, with (20), the function $V_0(x) = x'R_x x$ is such that,

$$\frac{\partial V_0}{\partial x}(x)[F + GK_x]x < 0, \quad \forall x \neq 0.$$

Due to the fact that K_x satisfies equation (7) it yields that the matrix $F + GK_x$ is the first order approximation of the x -subsystem in equation (2) with the control law $u = \alpha_x(x)$. Consequently, it implies that there exists a positive real number ε_1 such that

$$\frac{\partial V_0}{\partial x}(x)[f(x) + g(x)\alpha_x(x)] < 0, \quad \forall |x| \leq \varepsilon_1.$$

Employing [14, Theorem 2.1], it yields the existence of a function V_x and a positive real number ε_2 such that

1) for all x in $\mathbb{R}^n \setminus \{0\}$,

$$\frac{\partial V_x}{\partial x}(x)[f(x) + g(x)\alpha_x(x)] < 0.$$

2) for all x in \mathbb{R}^n such that $|x| \leq \varepsilon_2$, we have

$$V_x(x) = V_0(x),$$

and consequently $\mathcal{H}(V_x)(0) = 2R_x$.

This conclude the proof of Lemma 2

C. Proof of Lemma 4

With Assumption 2, there exists a neighborhood of the origin in which the distribution $\text{Vect}\{g_1(x), \dots, g_m(x)\}$ is regular, involutive and of constant dimension m . Employing Frobenius theorem [17, Theorem 1.4.1], we know there exists a neighborhood of the origin $U \subset \mathbb{R}^{n_x}$ and a diffeomorphism $\varphi = (\varphi_1, \dots, \varphi_{n_x}) : U \rightarrow \varphi(U)$ such that

$$\frac{\partial \varphi_i}{\partial x}(x)g_j(x) = 0, \quad m+1 \leq i \leq n_x, \quad 1 \leq j \leq m, \quad \forall x \in U.$$

Let $\psi : U \rightarrow \psi(U)$ be the diffeomorphism defined as $\left(\frac{\partial \varphi}{\partial x}(0)\right)^{-1} \varphi(x)$. Note that we have $\frac{\partial \psi}{\partial x}(0) = I_{n_x}$. Moreover, we have

$$G = g(0) = \left(\frac{\partial \varphi}{\partial x}(0)\right)^{-1} \begin{bmatrix} \frac{\partial \varphi_1}{\partial x}(0)g(0) \\ \vdots \\ \frac{\partial \varphi_m}{\partial x}(0)g(0) \\ 0 \\ \vdots \end{bmatrix}.$$

Hence, we get

$$\frac{\partial \psi}{\partial x}(x)g(x) = Gr(x), \quad \forall x \in U,$$

where

$$r(x) = \begin{bmatrix} \frac{\partial \varphi_1}{\partial x}(0)g(0) \\ \vdots \\ \frac{\partial \varphi_m}{\partial x}(0)g(0) \end{bmatrix}^{-1} \begin{bmatrix} \frac{\partial \varphi_1}{\partial x}(x)g(x) \\ \vdots \\ \frac{\partial \varphi_m}{\partial x}(x)g(x) \end{bmatrix}.$$

If we denote the new coordinates $\tilde{x} = \psi(x)$, the system (2) takes the form

$$\dot{\tilde{x}} = \tilde{f}(\tilde{x}) + G\tilde{r}(\tilde{x})u. \quad (57)$$

where $\tilde{r}(\tilde{x})$ is a matrix in $\mathbb{R}^{m \times m}$ for all \tilde{x} in $\psi(U)$ and $\tilde{r}(0) = I_m$. Note that since $\frac{\partial \psi}{\partial x}(0) = I_{n_x}$, we have $\frac{\partial \tilde{f}}{\partial \tilde{x}}(0) = F$.

Consider now the Lyapunov function

$$V_L(y, x) = \begin{bmatrix} y' & \psi(x)' \end{bmatrix} \mathcal{P} \begin{bmatrix} y \\ \psi(x) \end{bmatrix}.$$

We will show that this Lyapunov function is nonincreasing in a neighborhood of the origin when employing the control law $u = \alpha_g(y, x)$. Note that there exists a and b such that

$$\alpha_g(y, x) = a(\tilde{x}) + b(\tilde{x})y.$$

Note that we have the properties

$$\frac{\partial a}{\partial \tilde{x}}(0) = K_{g,x}, \quad b(0) = K_{g,y}.$$

When $u = \alpha_g(y, x)$ the time derivative of the function $V_L(y, x)$ satisfies along the trajectories of the nonlinear system (2)

$$\left. \frac{d}{dt} V_L(y, x) \right|_{u=\alpha_g(y, x)} = 2 \begin{bmatrix} y' & \tilde{x}' \end{bmatrix} \mathcal{P} \begin{bmatrix} Ay + \tilde{h}(\tilde{x}) \\ \tilde{f}(\tilde{x}) + G\tilde{r}(\tilde{x})\alpha_g(y, x) \end{bmatrix}.$$

This gives

$$\begin{aligned} \left. \frac{d}{dt} V_L(y, x) \right|_{u=\alpha_g(y, x)} = & 2 \begin{bmatrix} y' & \tilde{x}' \end{bmatrix} \mathcal{P} \left(\begin{bmatrix} A & H \\ GK_{g,y} & F + GK_{g,x} \end{bmatrix} \begin{bmatrix} y \\ \tilde{x} \end{bmatrix} \right. \\ & \left. + \begin{bmatrix} \tilde{h}(\tilde{x}) - H\tilde{x} \\ \tilde{f}(\tilde{x}) - F\tilde{x} + G \left[\tilde{r}(\tilde{x})(a(\tilde{x}) + b(\tilde{x})y) - K_g \begin{bmatrix} y \\ \tilde{x} \end{bmatrix} \right] \end{bmatrix} \right) \end{aligned}.$$

Hence we get,

$$\left. \overline{V_L(y, x)} \right|_{u=\alpha_g(y, x)} = \begin{bmatrix} y'QG & \tilde{x}' \end{bmatrix} \mathbb{M} \begin{bmatrix} G'Q'y \\ \tilde{x} \end{bmatrix} + \Delta_1(\tilde{x}) + y'\Delta_2(\tilde{x}) + y'QG\Delta_3(\tilde{x})y \quad (58)$$

where,

$$\mathbb{M} = \begin{bmatrix} -4 & -4(G'M'PM + G'R_x) \\ -4(R_xG + M'PMG) & S_x - 4(G'M'PM + R_xG')(GR_x + M'PMG) \end{bmatrix} < -c_{\mathbb{M}}I_{n_x+1} \quad , \quad (59)$$

where S_x is the negative definite matrix defined in (30) and $c_{\mathbb{M}} = \lambda_{\max}\{\mathbb{M}\}$ is a positive real number,

$$\begin{aligned} \Delta_1(\tilde{x}) &= 2 \begin{bmatrix} 0 & \tilde{x}' \end{bmatrix} \mathcal{P} \begin{bmatrix} \tilde{h}(\tilde{x}) - H\tilde{x} \\ \tilde{f}(\tilde{x}) - F\tilde{x} + G[\tilde{r}(\tilde{x})a(\tilde{x}) - K_{g,x}\tilde{x}] \end{bmatrix} \\ \Delta_2(\tilde{x}) &= 2 \begin{bmatrix} 1 & 0 \end{bmatrix} \mathcal{P} \begin{bmatrix} \tilde{h}(\tilde{x}) - H\tilde{x} \\ \tilde{f}(\tilde{x}) - F\tilde{x} + G[\tilde{r}(\tilde{x})a(\tilde{x}) - K_{g,x}\tilde{x}] \end{bmatrix} + \left(\begin{bmatrix} 0 & \tilde{x}' \end{bmatrix} \mathcal{P} \begin{bmatrix} 0 \\ G[\tilde{r}(\tilde{x})b(\tilde{x}) - K_{g,y}] \end{bmatrix} \right)' \\ \Delta_3(\tilde{x}) &= 2\tilde{r}(\tilde{x})b(\tilde{x}) - K_{g,y} \end{aligned}$$

Moreover, we have,

$$|y'QG\Delta_3(\tilde{x})y| \leq \frac{|y'QG|^2 + |\Delta_3(\tilde{x})|^2}{2} |y| \quad . \quad (60)$$

Hence, (58) becomes,

$$\left. \overline{V_L(y, x)} \right|_{u=\alpha_g(y, x)} \leq -|\tilde{x}|^2 \left(c_{\mathbb{M}} - \frac{\Delta_1(\tilde{x})}{|\tilde{x}|^2} - |y| \frac{|\Delta_2(\tilde{x})| + \frac{1}{2}|\Delta_3(\tilde{x})|^2}{|\tilde{x}|^2} \right) - |G'Q'y|^2 \left(c_{\mathbb{M}} - \frac{1}{2}|y| \right) \quad (61)$$

Note that

$$|\Delta_1(\tilde{x})| = O(|\tilde{x}|^3) \quad , \quad |\Delta_2(\tilde{x})| = O(|\tilde{x}|^2) \quad , \quad |\Delta_3(\tilde{x})| = O(|\tilde{x}|) \quad .$$

Hence, this implies that there exists a positive real number R_g such that when $u = \alpha_g(y, x)$ we get along the solutions of the system (2)

$$\left. \overline{V_L(y, x)} \right|_{u=\alpha_g(y, x)} \leq -\frac{c_{\mathbb{M}}}{2} [|\tilde{x}|^2 + |y'PMG|^2] \quad , \quad \forall (x, y) : V_L(y, x) \leq R_g \quad . \quad (62)$$

With the same analysis, it is possible to find a positive real number R_l such that by taking $u = K_{o,y}y + K_{o,x}x$ we get a positive real number c_o such along the trajectories of the closed loop system we have

$$\left. \overline{V_L(y, x)} \right|_{u=K_{o,y}y+K_{o,x}x} \leq -c_o [|\tilde{x}|^2 + |y'PMG|^2] \quad , \quad \forall (x, y) : V_L(y, x) \leq R_l \quad . \quad (63)$$

Note that since ψ is a diffeomorphism, we get the existence of a positive real number such c_ψ that around the origin $|\tilde{x}| \geq c_\psi|x|$. Hence, we get the result with $R_L = \min\{R_l, R_g\}$.

D. Solving the PDE for the illustrative example

In this section we show that given, a vector $K_x \in \mathbb{R}^{n_x}$ such that $F + GK_x$ is Hurwitz the following partial differential equation

$$\frac{\partial \mathcal{M}}{\partial x}(x)[F + GK_x]x = A\mathcal{M}(x) + h(x), \forall x \in \mathbb{R}^n. \quad (64)$$

can be solved explicitly when the function h is the quadratic function defined in (45).

First of all, note that following (33), the solution $\mathcal{M} : \mathbb{R}^{n_x} \rightarrow \mathbb{R}^{n_y}$ can be expressed as

$$\mathcal{M}(x) = \int_{+\infty}^0 \exp(-As)h\left(\exp\left([F + GK_x]s\right)x\right)ds. \quad (65)$$

The function h being quadratic, this implies that the function \mathcal{M} is also quadratic and may be written in the form (50) with (M, M_1, \dots, M_{n_y}) are matrices in $\mathbb{R}^{n_x \times n_x}$ to be selected. Assume for the time being that there exist solutions to the two Sylvester equations (51) and (52) and let (M, M_1, \dots, M_{n_y}) be these solutions. Note that we have,

$$\frac{\partial \mathcal{M}}{\partial x}(x)[F + GK_x]x = [I_{n_y} \otimes x'] \Psi x + M[F + GK_x]x,$$

where Ψ is the matrix in $\mathbb{R}^{(n_y n_x) \times n_x}$ defined by

$$\Psi = \begin{bmatrix} M_1(F + GK_x) + (F + GK_x)'M_1 \\ \vdots \\ M_{n_y}(F + GK_x) + (F + GK_x)'M_{n_y} \end{bmatrix}.$$

However, employing the fact that $[M_1, \dots, M_{n_y}]'$ is solution to the Sylvester equation (52), we get

$$\Psi = [I_{n_y} \otimes [F + GK_x]'] \begin{bmatrix} M_1 \\ \vdots \\ M_{n_y} \end{bmatrix} + \begin{bmatrix} M_1 \\ \vdots \\ M_{n_y} \end{bmatrix} [F + GK_x] + \begin{bmatrix} H_1 \\ \vdots \\ H_{n_y} \end{bmatrix} = [A \otimes I_{n_x}] \begin{bmatrix} M_1 \\ \vdots \\ M_{n_y} \end{bmatrix} + \begin{bmatrix} H_1 \\ \vdots \\ H_{n_y} \end{bmatrix}.$$

Hence, it implies

$$\frac{\partial \mathcal{M}}{\partial x}(x)[F + GK_x]x = [I_{n_y} \otimes x'] \begin{bmatrix} M_1 \\ \vdots \\ M_{n_y} \end{bmatrix} [A \otimes I_{n_x}] \begin{bmatrix} M_1 \\ \vdots \\ M_{n_y} \end{bmatrix} x + [I_{n_y} \otimes x'] \begin{bmatrix} H_1 \\ \vdots \\ H_{n_y} \end{bmatrix} x + AMx + Hx,$$

where we have used the fact that M satisfies the Sylvester equation (51). Employing the fact that

$$[I_{n_y} \otimes x'] [A \otimes I_{n_x}] \begin{bmatrix} M_1 \\ \vdots \\ M_{n_y} \end{bmatrix} = A \begin{bmatrix} x' M_1 \\ \vdots \\ x' M_{n_y} \end{bmatrix},$$

it yields

$$\frac{\partial \mathcal{M}}{\partial x}(x)[F + GK_x]x = A \begin{bmatrix} x' M_1 \\ \vdots \\ x' M_{n_y} \end{bmatrix} x + [I_{n_y} \otimes x'] \begin{bmatrix} H_1 \\ \vdots \\ H_{n_y} \end{bmatrix} x + AMx + Hx = A\mathcal{M}(x) + h(x).$$

Consequently, if (M, M_1, \dots, M_{n_y}) are matrices in $\mathbb{R}^{n_x \times n_x}$ solution to the Sylvester equations (51) and (52) the function \mathcal{M} defined in (50) is solution to the PDE (64).

It remains to show that the two Sylvester equations (51) and (52) admit a solution. Note that for the first one (i.e. equation (51)), this is trivial since the two matrices $F + GK_x$ and $-A$ have different eigenvalues ($F + GK_x$ is Hurwitz and A is stable).

The same property holds for equation (52). Indeed, with the matrix R_x given in equation (18), we have

$$\begin{aligned} (I_{n_y} \otimes R_x) [I_{n_y} \otimes [F + GK_x] - A' \otimes I_{n_x}] + [I_{n_y} \otimes [F + GK_x]' - A \otimes I_{n_x}] (I_{n_y} \otimes R_x) \\ = I_{n_y} \otimes (R_x[F + GK_x] + [F + GK_x]'R_x) - (I_{n_y} \otimes R_x)(A' \otimes I_{n_x}) - (A \otimes I_{n_x})(I_{n_y} \otimes R_x) \end{aligned}$$

Note that we have,

$$(I_{n_y} \otimes R_x)(A' \otimes I_{n_x}) + (A \otimes I_{n_x})(I_{n_y} \otimes R_x) = A' \otimes R_x + A \otimes R_x = 0$$

since, by assumption, $A' = -A$. Consequently, it implies with (20)

$$\begin{aligned} (I_{n_y} \otimes R_x) [I_{n_y} \otimes [F + GK_x] - A' \otimes I_{n_x}] + [I_{n_y} \otimes [F + GK_x]' - A \otimes I_{n_x}] (I_{n_y} \otimes R_x) \\ = I_{n_y} \otimes (R_x[F + GK_x] + [F + GK_x]'R_x) < 0 \end{aligned}$$

which is a Lyapunov equality with Lyapunov matrix $(I_{n_y} \otimes R_x)$. Hence, it establishes that the matrix $[I_{n_y} \otimes [F + GK_x] - A' \otimes I_{n_x}]$ is Hurwitz and has different eigenvalues with the matrix $-[F + GK_x]$.
