# Stochastic Sensitivity Study for Optimal Credit Allocation

#### Abstract

In this paper we present the detail computations involved in 2]. First we propose a quick presentation of the methodology developed by Bouleau (see [5]). Then, we apply this method to the problem of optimal credit allocation problem.


## 1 Introduction

This introduction is devoted to the presentation of error calculus in the sense of sensitivity with respect to a stochastic perturbation.
We shortly recall Gauss idea for error propagation. All the implied functions are assumed to be smooth enough. Let $(\Omega, \mathcal{F}, \mathbb{P})$ be a probability space. Let $V=F\left(U_{1}, \ldots, U_{n}\right)$ be a real valued function of the $U_{1}, \ldots, U_{n}$ which are supposed to be erroneously measured. The $U_{i}$ are seen as random variables with values very closed to their mean value $\mathbb{E}\left[U_{i}\right]$. The error of measure is given by $\sigma_{i, j}=\mathbb{E}\left[\left(U_{i}-\mathbb{E}\left[U_{i}\right]\right)\left(U_{j}-\mathbb{E}\left[U_{j}\right]\right)\right]$. Here the error is assumed to be small thus using a first order approximation, we obtain:

$$

If we denote by $\sigma_{V}^{2}=\mathbb{E}\left[F\left(U_{1}, \ldots, U_{n}\right)-F\left(\mathbb{E}\left[U_{1}\right], \ldots, \mathbb{E}\left[U_{n}\right]\right)\right]^{2}$,

\left.\left.\sigma_{V}^{2}=\sum_{i, j=1}^{n} \sigma_{i, j} \frac{\partial F}{\partial U_{i}}\left(\mathbb{E}\left[U_{1}\right], \ldots, \mathbb{E}\left[U_{n}\right)\right]\right) \frac{\partial F}{\partial U_{j}}\left(\mathbb{E}\left[U_{1}\right], \ldots, \mathbb{E}\left[U_{n}\right)\right]\right) \tag{1}
\end{equation*}

[^0]We see that the mean square error transmits with a first order differential calculus. Now we try to generalize Gauss equation (11) by considering that the measure of $U_{i}$ is no more the constant value $\mathbb{E}\left[U_{i}\right]$ but a random variable. This random variable is defined on an (independant) copy of $(\Omega, \mathcal{F}, \mathbb{P})$ denoted by $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$. We called it $\widehat{U}_{i}$ : in statistical language it is the estimator of $U_{i}$. Consider another real valued function $G$. We introduce the following random variables defined on the space $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$ :

\operatorname{MSE}\left(F\left(U_{1}, \ldots, U_{n}\right), G\left(U_{1}, \ldots, U_{n}\right)\right) & =\mathbb{E}\left[\left(F\left(U_{1}, \ldots, U_{n}\right)-F\left(\widehat{U_{1}}, \ldots, \widehat{U_{n}}\right)\right)\left(G\left(U_{1}, \ldots, U_{n}\right)-G\left(\widehat{U_{1}}, \ldots, \widehat{U_{n}}\right)\right)\right]
\end{align*}

Let $H \in\{F, G\}$, using a first order approximation we obtain:

\operatorname{MSE}\left(F\left(U_{1}, \ldots, U_{n}\right), G\left(U_{1}, \ldots, U_{n}\right)\right)=\sum_{i, j=1}^{n} \operatorname{MSE}\left(U_{i}, U_{j}\right) \frac{\partial F}{\partial U_{i}}\left(\widehat{U_{1}}, \ldots, \widehat{U_{n}}\right) \frac{\partial G}{\partial U_{i}}\left(\widehat{U_{1}}, \ldots, \widehat{U_{n}}\right) . \tag{5}
\end{gather*}
$$

For the bias we use a second order approximation and we get that:

F\left(U_{1}, \ldots, U_{n}\right)-F\left(\widehat{U_{1}}, \ldots, \widehat{U_{n}}\right)= & \sum_{i=1}^{n}\left(U_{i}-\widehat{U_{i}}\right) \frac{\partial F}{\partial U_{i}}\left(\widehat{U_{1}}, \ldots, \widehat{U_{n}}\right)+ \\
& \frac{1}{2} \sum_{i, j=1}^{n}\left(U_{i}-\widehat{U_{i}}\right)\left(U_{j}-\widehat{U_{j}}\right) \frac{\partial^{2} F}{\partial U_{i} U_{j}}\left(\widehat{U_{1}}, \ldots, \widehat{U_{n}}\right)
\end{aligned}
$$

Thus, one has:
$\operatorname{Bias}\left(F\left(U_{1}, \ldots, U_{n}\right)\right)=\sum_{i=1}^{n} \operatorname{Bias}\left(U_{i}\right) \frac{\partial F}{\partial U_{i}}\left(\widehat{U_{1}}, \ldots, \widehat{U_{n}}\right)+\frac{1}{2} \sum_{i, j=1}^{n} \operatorname{MSE}\left(U_{i}, U_{j}\right) \frac{\partial^{2} F}{\partial U_{i} U_{j}}\left(\widehat{U_{1}}, \ldots, \widehat{U_{n}}\right)$.
The bias follows a second order differential calculus involving the mean square error.
The idea developed by Bouleau is to allow the errors to be random variables. The quadratic error on each $U_{i}$ is given by $\Gamma\left(U_{i}, U_{i}\right)$ (shortly denoted by $\Gamma\left(U_{i}\right)$ ) where $\Gamma$ is a bilinear operator associated to the MSE and the bias by $\mathcal{A}\left(U_{i}\right)$, where $\mathcal{A}$ is a linear operator. This representation would have the nice following property that if the sequence of pairs $\left(Y_{n}, \Gamma\left(Y_{n}\right)\right)$ converges (in a certain sense) it should tends to $(Y, \Gamma(Y))$.

The rest of the paper is organized as follows. In Section 2, we present the mathematical setup for error calculus. Then in Section 3, we present the model for credit spreads, the expression of the $\mathrm{P} \& \mathrm{~L}$, the optimisation program and it solution. Finally, in section 4 we apply the machinery of error calculus to determine the variance and bias of the allocation.

## 2 Error Calculus

We now formalize the intuition exposed in the introduction. The axiomatization of random uncertainty propagation was introduced by Bouleau [4] as follows:

## Definition 1 (Error structure)

An error structure is a term $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}}, \mathbb{D}, \Gamma)$, where

- $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$ is a probability space;
- $\mathbb{D}$ is a dense sub-vector space of $L^{2}(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$ such that for any function $F$ of class $C^{1}$ and globally Lipschitz (afterward denoted $C^{1} \cap$ Lip) and $U \in \mathbb{D}$, one has $F(U) \in \mathbb{D}$.
- $\Gamma$ is a positive symmetric bilinear function from $\mathbb{D} \times \mathbb{D}$ into $L^{1}(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$ satisfying the following functional calculus inspired by (5): for any functions $F$ and $G$ of class $\mathcal{C}^{1} \cap$ Lip and $U, V \in \mathbb{D}^{n}$

- the bilinear form $\mathcal{E}[U, V]=\frac{1}{2} \widetilde{\mathbb{E}}[\Gamma[U, V]]$ is closed, i.e. $\mathbb{D}$ equipped with the norm $|U|_{\mathbb{D}}=\left(\widetilde{\mathbb{E}}\left[U^{2}\right]+\frac{1}{2} \mathcal{E}[U, U]\right)^{1 / 2}$ is complete;
- the constant 1 belongs to $\mathbb{D}$ and $\mathcal{E}[1,1]=0$

An error structure is a probability space equipped with a carré du champ operator $\Gamma$. We generally write $\Gamma[U]$ for $\Gamma[U, U]$. The Hille-Yosida theorem guarantees that there exists a semigroup and a generator $\mathcal{A}$ that are coherent with the Dirichlet form $\mathcal{E}$, see for instance Albeverio [1] and Fukushima et al. [7]. This generator $\mathcal{A}: \mathcal{D} \mathcal{A} \rightarrow L^{2}(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$ is a selfadjoint operator, its domain $\mathcal{D} \mathcal{A}$ is included into $\mathbb{D}$. It is such that for all $U \in \mathcal{D} \mathcal{A}$ and $V \in L^{2}(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$

\mathcal{E}[U, V]=-\widetilde{\mathbb{E}}[\mathcal{A}[U] V] \tag{8}
\end{equation*}
$$

Moreover this operator satisfies, for $F \in \mathcal{C}^{2} \cap \operatorname{Lip}, U \in \mathcal{D} \mathcal{A}, F(U) \in \mathcal{D} \mathcal{A}$ and $\Gamma[U] \in$ $L^{2}(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}}):$

\mathcal{A}[F(U)]=\sum_{i=1}^{n} \frac{\partial F}{\partial U_{i}}(U) \mathcal{A}[U]+\frac{1}{2} \sum_{i, j=1}^{n} \frac{\partial^{2} F}{\partial U_{i} U_{j}}(U) \Gamma[U] \widetilde{\mathbb{P}} \text { a.s.. } \tag{9}
\end{equation*}
$$

This equation is similar to (6). From (8), $\mathcal{A}$ is a closed operator with respect to the norm $\|_{\mathbb{D}}$, in the sense that $\mathcal{D} \mathcal{A}$ equipped with the norm $\|_{\mathbb{D}}$ is complete.

We introduce a basic example to show that the set of error structures is not empty and to give some further intuitions about the different operator introduced above.

## Example 1 (Ornstein-Uhlenbeck error structure)

The Ornstein-Uhlenbeck structure is $(\mathbb{R}, \mathcal{B}(\mathbb{R}), \mu, \mathbb{D}, \Gamma)$, where $\mu$ is unidimensional centered Gaussian law and $\mathbb{D}:=H^{1,2}(\mu)$, i.e. the first Sobolev space associated to $L^{2}(\mathbb{R}, \mathcal{B}(\mathbb{R}), \mu)$. Here we choose a particular semi-group and we compute the associated generator and Dirichlet form. To this end we introduce an auxiliary Ornstein-Hulenbeck process in a probability space $\left(\Omega^{B}, \mathcal{F}^{B}, \mathbb{P}^{B}\right)$ equipped with a Brownian motion $B$ :

d X_{\epsilon}=-\frac{1}{2} X_{\epsilon} d \epsilon+d B_{\epsilon}
$$

We denote by $X_{\epsilon}^{x}$ the solution of the preceding equation starting at some $x$. We then define the semigroup as follows for all $\omega \in \mathbb{R}$ :

where $\mathbb{E}^{B}$ is the expectation with respect to $\mathbb{P}^{B}$. Using Ito lemma, we have for $U \in \mathbf{H}^{2,2}(\mu)$ :

X_{\epsilon}^{x} & =x e^{-\frac{1}{2} \epsilon}+\int_{0}^{\epsilon} e^{-\frac{1}{2}(\epsilon-s)} d B_{s} \\
U\left(X_{\epsilon}^{x}\right) & =U(x)-\frac{1}{2} \int_{0}^{\epsilon} U^{\prime}\left(X_{s}^{x}\right) X_{s}^{x} d s+\frac{1}{2} \int_{0}^{\epsilon} U^{\prime \prime}\left(X_{s}^{x}\right) d s+\int_{0}^{\epsilon} U^{\prime}\left(X_{s}^{x}\right) d B_{s}  \tag{10}\\
<U\left(X^{x}\right)>_{\epsilon} & =\int_{0}^{\epsilon}\left(U^{\prime}\left(X_{s}^{x}\right)\right)^{2} d s \tag{11}
\end{align*}
$$

where $<>_{\epsilon}$ denotes the quadratic variation operator. The generator $\mathcal{A}$ and the Dirichlet form $\mathcal{E}$ associated to the semi-group $P_{\epsilon}$ are given by (see [5] chapter II):

\mathcal{A}[U](\omega) & =\lim _{\epsilon \rightarrow 0} \frac{P_{\epsilon}[U](\omega)-U(\omega)}{\epsilon}=\frac{1}{2} U^{\prime \prime}(\omega)-\frac{1}{2} \omega U^{\prime}(\omega)  \tag{12}\\
\mathcal{E}[U] & =\langle-\mathcal{A}[U], U\rangle_{L^{2}(\mu)}=\frac{1}{2} \int\left(\omega U^{\prime}(\omega)-U^{\prime \prime}(\omega)\right) U(\omega) d \mu(\omega) \\
& =\frac{1}{2} \int\left(U^{\prime}(\omega)\right)^{2} d \mu(\omega) \tag{13}
\end{align*}
$$

where (13) comes from integration by part formula (recall that $\mu$ is a centered gaussian law). As $\mathcal{E}[U]=\frac{1}{2} \widetilde{\mathbb{E}}[\Gamma[U, U]]$, we deduce from (13) that $\Gamma(U)=\left(U^{\prime}\right)^{2}$ for all $U \in \mathbb{D}$. From (12), the related generator is $\mathcal{A}[U]=\frac{1}{2} U^{\prime \prime}-\frac{1}{2} I d \cdot U^{\prime}$, where Id denotes the identity operator. Here the domain $\mathcal{D} \mathcal{A}:=\mathbf{H}^{2,2}(\mu)$, i.e. the second Sobolev space.
In this particular case, (17) and (9) are easy to obtain:

\Gamma[F(U), G(V)](\omega) & =F^{\prime}(U)(\omega) U^{\prime}(\omega) G^{\prime}(V)(\omega) V^{\prime}(\omega)=F^{\prime}(U)(\omega) G^{\prime}(V)(\omega) \Gamma[U, V](\omega) \\
\mathcal{A}[F(U)](\omega) & =\frac{1}{2}\left(F^{\prime \prime}(U)(\omega)\left(U^{\prime}(\omega)\right)^{2}+F^{\prime}(U)(\omega) U^{\prime}(\omega)\right)-\frac{1}{2}\left(\omega F^{\prime}(U)(\omega) U^{\prime}(\omega)\right)= \\
& =F^{\prime}(U)(\omega) \mathcal{A}[U](\omega)+\frac{1}{2} F^{\prime \prime}(U)(\omega) \Gamma[U](\omega)
\end{aligned}
$$

We finish this example with the following remark. In the introduction, we have associated to the statistical notion of bias and mean squared error the operators $\mathcal{A}$ and $\Gamma$ (see (3), (4) and (5)). In this example we can do the other way around: it is easy to show that the $\mathcal{A}$ is associated to a bias and $\Gamma$ is associated to a mean square error in the following sense:

\begin{aligned}
\epsilon \mathcal{A}[U](\omega) & =\mathbb{E}^{B} U\left[X_{\epsilon}^{x}-U(x) \mid x=\omega\right] \\
\epsilon \Gamma[U](\omega) & =\mathbb{E}^{B} U\left[\left(X_{\epsilon}^{x}-U(x)\right)^{2} \mid x=\omega\right]
\end{aligned}
$$

Afterwards, we will omit the explicit dependency on $\omega$.

## Remark 1 (Statistical interpretation)

It is possible to push further the analogy between statists and theory of Dirichlet forms used to compute errors. In [6] it is shown that one can constructed confidence interval for some random variable $U$ using $\mathcal{A}[U]$ and $\Gamma[U]$. This is achieve by choosing an error structure linked to Fisher's information matrix.

The main drawback of the carré du champ operator $\Gamma$ is its bi-linearity, which makes computations awkward to perform. An easy way to overcome this drawback is to introduce a new operator, called the gradient, see Bouleau and Hirsch [3, section II.6. We recall the definition of gradient operator associated to $\Gamma$.

## Proposition 1 (Gradient operator)

From now we assume that the space $\mathbb{D}$ is separable. Let $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}}, \mathbb{D}, \Gamma)$ be an error structure. Let $(\bar{\Omega}, \overline{\mathcal{F}}, \overline{\mathbb{P}})$ be an (independent) copy of $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$ and $\mathcal{H}=L^{2}(\bar{\Omega}, \overline{\mathcal{F}}, \overline{\mathbb{P}})$ be an auxiliary Hilbert space equipped with scalar product $<X, Y>_{\mathcal{H}}=\overline{\mathbb{E}}(X Y)$, where $\overline{\mathbb{E}}$ is the expectation computed under $\overline{\mathbb{P}}$. Let $L^{2}((\bar{\Omega}, \overline{\mathcal{F}}, \overline{\mathbb{P}}), \widetilde{\mathbb{P}})$ or shortly $L^{2}(\widetilde{\mathbb{P}}, \mathcal{H})$ the space of $L^{2}(\bar{\Omega}, \overline{\mathcal{F}}, \overline{\mathbb{P}})$ valued random variables equipped with the scalar product $<A, B>_{L^{2}(\widetilde{\mathbb{P}}, \mathcal{H})}=$ $\widetilde{\mathbb{E}}\left[<A, B>_{\mathcal{H}}\right]=\widetilde{\mathbb{E}} \overline{\mathbb{E}}(A B)$. Then there exists a linear operator, called gradient and denoted by ()$^{\#}: \mathbb{D} \rightarrow L^{2}(\widetilde{\mathbb{P}}, \mathcal{H})$, with the following two properties:

\forall U V \in \mathbb{D}, \Gamma[U, V] & =<U^{\#}, V^{\#}>_{\mathcal{H}}=\overline{\mathbb{E}}\left(U^{\#} V^{\#}\right)  \tag{14}\\
\forall U \in \mathbb{D}^{n}, F \in \mathcal{C}^{1} \cap \operatorname{Lip},\left(F\left(U_{1}, \ldots, U_{n}\right)\right)^{\#} & =\sum_{i=1}^{n}\left(\frac{\partial F}{\partial x_{i}} \circ U\right) U_{i}^{\#} \tag{15}
\end{align*}
$$

The gradient operator is a useful tool when computing $\Gamma$ because it is linear, whereas the carré du champ operator is bilinear.
Let $U \in \mathbb{D}$, by (14) and Definition (item 4) $\widetilde{\mathbb{E}} \overline{\mathbb{E}}\left[U^{\#}\right]=\widetilde{\mathbb{E}} \Gamma[U]=2 \mathcal{E}(U, U)$ and the gradient operator is closed in the sense that $\mathbb{D}$ equipped with the norm $\left\|\|_{\mathbb{D}}\right.$ is complete.
In this paper, we will use frequently the two following straightforward lemmas:

## Lemma 1 (Chain rules for a product of random variables)

Let $U$ and $V \in \mathbb{D}$ then

\Gamma[U V] & =U^{2} \Gamma[V]+V^{2} \Gamma[U]+2 U V \Gamma[U, V] \tag{17}

Moreover, if $U$ and $V \in \mathcal{D} \mathcal{A}$, then

Proof: (16) follows from (15), (17) follows from (7) and (18) follows from (9).

## Lemma 2 (Expectation)

Let $(\Omega, \mathcal{F}, \mathbb{P})$ be a probability space, we will denote $\mathbb{E}$ the conditional expectation w.r.t. $\mathbb{P}$. Let $U \in \mathbb{D} \subset L^{2}(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$ and $V \in \mathcal{D} \mathcal{A}$ then one has

\mathbb{E}\left[U^{\#}\right] & =U^{\#} \\
\mathbb{E}[\mathcal{A}[V]] & =\mathcal{A}[V] .
\end{aligned}

Let $U, V \in \mathbb{D}$ then one has

\mathbb{E}[\Gamma[U, V]]=\Gamma[U, V]
$$

Let $V \in L^{2}(\Omega \times \widetilde{\Omega}, \mathcal{F} \otimes \widetilde{\mathcal{F}}, \mathbb{P} \otimes \widetilde{\mathbb{P}})$ such that $V \in \mathbb{D}$ and $\mathbb{E}[V] \in \mathbb{D}$, one has:

For the forth equation we use the fact that the gradient operator is closed and we can exchange the gradient operator and the integral sign. The proof of this fact proceeds by an approximation of the integral by a sum, then we apply the gradient operator and finally we take the limit using the closeness of the gradient operator, see for instance Bouleau [4] section VI.2. Lemma VI.8. The proof of the last equation is similar.

We observe that the error theory based on Dirichlet forms restricts its analysis to the study of the first two orders of error propagation, i.e. the bias and the variance. This fact is justified
by the lack of information on the parameter uncertainties, generally given by the Fischer information matrix, that is often quite limited. The study of higher orders is a very difficult problem for both mathematical and practical reasons. From the mathematical point of view, it would be necessary to study chain rules of higher orders, involving skewness and kurtosis, and to prove that the related operators are closed in a suitable space. However, the crucial problem remains to have sufficiently accurate estimates for the higher order uncertainties. This statistical obstacle cannot be overcome easily. Therefore, it seems reasonable to restrict the study to the two first orders.

## 3 Financial setup

We consider a continuous time financial model with $K$ credit issuers and one synthetic asset referred to as the benchmark. It represents the global evolution of the credit market. Each credit issuer is characterized by its spread over the risk free rate. The uncertainty is represented by a filtered probability space $\left(\Omega, \mathcal{F}, \mathbb{F}:=\left\{\mathcal{F}_{t}\right\}_{t \geq 0}, \mathbb{P}\right)$ satisfying the usual conditions. First, we define on this space a $\mathbb{F}$-adapted, continuous-time, two-state valued Markov chain, $Y=\left(Y_{t}\right)_{t \geq 0}$. The state space of the Markov chain is equal to $\{g, b\}$.
Let $(W(t))_{t \geq 0}=\left(W_{0}(t), \ldots, W_{K}(t)\right)_{t \geq 0}$ be a standard $(\mathbb{F}, \mathbb{P})$-Brownian motion of dimension $K+1$. Let us define the $K+1$-dimensional stochastic process $(X(t))_{t>0}$, with $X(t):=$ $\left(X_{k}(t)\right)_{0 \leq k \leq K}$. The process $X_{0}$ represents the spread of the benchmark, the drift of which $\mu_{0}$ is assumed to be a measurable function of the Markov chain $Y$ :

We also denote $Z_{k}^{\perp}(t)=\sum_{j=1}^{K} L_{k, j} W_{j}(t)$. It is a standard $(\mathbb{F}, \mathbb{P})$-Brownian motion of dimension 1.
We introduce $\mathbb{G}:=\left\{\mathcal{G}_{t}\right\}_{t \geq 0}$ and $\mathbb{G}^{0}:=\left\{\mathcal{G}_{t}^{0}\right\}_{t \geq 0}$, the right continuous, complete filtrations generated respectively by the following processes:

In [2] the $\epsilon_{k}$ have been in a first time assumed to be constant. Now they are estimated with some uncertainty and we will perform error calculus on them.

We assume that it is possible to invest in the benchmark and on each credit issuer through a debt product - a bond or a CDS - the price of which at time $t \geq 0$ is given by $P^{(k)}\left(t, X_{k}(t)\right)$, $k \in\{0, \ldots, K\}$. Moreover, let us denote by $\operatorname{Cap}(t)$ the deterministic capitalisation factor at time $t$ for the risk free rate.

Assumption 3 The mappings $P^{(k)}(\cdot, \cdot)$ from $\mathbb{R}^{+} \times \mathbb{R}^{+}$to $(0, \infty)$ are, at least, twice continuously differentiable.

We will denote by $\dot{P}_{1}^{(k)}(\cdot, \cdot)$ its first order derivative with respect to the first variable, by $\dot{P}_{2}^{(k)}(\cdot, \cdot)$ its first order derivative with respect to the second variable, and by $\ddot{P}_{2}^{(k)}(\cdot, \cdot)$ its second order derivative with respect to the second variable.

The first one uses the allocation on the assets to outperform the benchmark (benchmarked allocation): this corresponds to the case $\zeta=1$. \delta_{k, i l}^{C o v^{-1}} & :=-\sum_{m}\left(\operatorname{Cov}_{i k}^{-1} \operatorname{Cov}_{m l}^{-1}+\operatorname{Cov}_{i m}^{-1} \operatorname{Cov}_{k l}^{-1}\right) \delta_{k, m}^{C} \\
\alpha_{k, i l}^{C o v^{-1}} & :=-\sum_{m}\left(\operatorname{Cov}_{i k}^{-1} \operatorname{Cov}_{m l}^{-1}+\operatorname{Cov}_{i m}^{-1} \operatorname{Cov}_{k l}^{-1}\right) \alpha_{k, m}^{C} \\
\beta_{k j, i l}^{C C o v^{-1}} & :=-\operatorname{Cov}_{i k}^{-1} \operatorname{Cov}_{j l}^{-1} \beta_{k j}^{C}-\sum_{m}\left(\operatorname{Cov}_{i k}^{-1} \delta_{k, m}^{C} \delta_{j, m l}^{\operatorname{Cov}^{-1}}+\operatorname{Cov}_{i m}^{-1} \delta_{j, m}^{C} \delta_{k, j l}^{C o v^{-1}}\right)
\end{aligned}
$$

Proof: Note that $\operatorname{Cov} \operatorname{Cov}^{-1}=\mathbb{I}$, where $\mathbb{I}$ (the identity matrix) is unaffected by the uncertainty on the coefficients of $\operatorname{Cov}$. Using (16), we find $0=\mathbb{I}^{\#}=\operatorname{Cov}^{\#} \operatorname{Cov}^{-1}+\operatorname{Cov}\left(\operatorname{Cov}^{-1}\right)^{\#}$. Using (28), (33a) follows. (33b) follows from (33a) and (14). From (18), we get that

0=\mathcal{A}[\mathbb{I}]=\mathcal{A}\left[\operatorname{CovCov}^{-1}\right]=\mathcal{A}[\operatorname{Cov}] \operatorname{Cov}^{-1}+\operatorname{Cov}^{\mathcal{A}}\left[\mathrm{Cov}^{-1}\right]+\Gamma\left[\operatorname{Cov}^{2} \mathrm{Cov}^{-1}\right] .

Thus, using (14) we get that

and we conclude using (28), and (33a).
We turn now to study the sensitivity of $z_{i}$, see relations (24), we remark that only the sensitivities of $z_{1}$ to $z_{5}$ need to be computed since $z_{6}$ and $z_{7}$ are linear combination of $z_{1}$ to $z_{5}$.

Proposition 7 (Sensitivity of $z_{i}$ ) For $a=1, \ldots, 5$, we have

Proof: The proof is similar to the proof of Proposition 6 and is based on Propositions 45 , 6 and Lemma (recall also the definitions (24)).

Remark 3 From (24), $z_{6}^{\#}=-\zeta z_{4}^{\#}$ and $\mathcal{A}\left[z_{6}\right]=-\zeta \mathcal{A}\left[z_{4}\right]$ and we set

We are now in position to state the result giving the sensitivity analysis of the optimal allocation $\pi^{*}$.

Theorem 1 (Sensitivity of the optimal strategy) Let $\pi^{*}$ be the solution of Program $(\mathcal{P})$, given by Proposition 3. We get that:

Proof: Again the proof is similar to the previous ones. We apply Propositions 4, 5, 6, 7, Corollary 1, Lemma 1 together with (9) and (14).
Let us provide a corollary the same analysis for the optimal return.

Corollary 2 With the notations of Theorem 1, let $R^{*}$ be the optimal return defined by $R^{*}:=M^{\prime} \pi^{*}$. Then we get that:

\mathcal{A}\left[R^{*}\right]= & \sum_{k}\left(\phi_{k} \pi_{k}^{*}+\sum_{i} \delta_{k, i}^{\pi} M_{i}\right) \mathcal{A}\left[\epsilon_{k}\right]+\sum_{k}\left(\sum_{i} \alpha_{k, i}^{\pi} M_{i}+\frac{1}{2}\left(T \phi_{k}+\psi_{k}\right) \pi_{k}^{*}\right) \Gamma\left[\epsilon_{k}\right] \\
& +\sum_{k, j}\left(\delta_{k, j}^{\pi} \phi_{j}+\sum_{i} \beta_{k j, i}^{\pi} M_{i}\right) \Gamma\left[\epsilon_{k}, \epsilon_{j}\right]
\end{aligned}
