# MATROID BASE POLYTOPE DECOMPOSITION

#### Abstract

Let $P(M)$ be the matroid base polytope of a matroid $M$. A matroid base polytope decomposition of $P(M)$ is a decomposition of the form $P(M)=\bigcup_{i=1}^{t} P\left(M_{i}\right)$ where each $P\left(M_{i}\right)$ is also a matroid base polytope for some matroid $M_{i}$, and for each $1 \leq i \neq j \leq t$, the intersection $P\left(M_{i}\right) \cap P\left(M_{j}\right)$ is a face of both $P\left(M_{i}\right)$ and $P\left(M_{j}\right)$. In this paper, we investigate hyperplane splits, that is, polytope decompositions when $t=2$. We give sufficient conditions for $M$ so $P(M)$ has a hyperplane split and characterize when $P\left(M_{1} \oplus M_{2}\right)$ has a hyperplane split where $M_{1} \oplus M_{2}$ denote the direct sum of matroids $M_{1}$ and $M_{2}$. We also prove that $P(M)$ has not a hyperplane split if $M$ is binary. Finally, we show that $P(M)$ has not a decomposition if its 1 -skeleton is the hypercube.

## 1. Introduction

For general background in matroid theory we refer the reader to [21, 24]. A matroid $M=(E, \mathcal{B})$ of rank $r$ is a finite set $E=\{1, \ldots, n\}$ (called the ground set of $M$ ) together with a nonempty collection $\mathcal{B}=\mathcal{B}(M)$ of $r$-subsets of $E$ (called the bases of $M$ ) satisfying the following basis exchange axiom:
if $B_{1}, B_{2} \in \mathcal{B}$ and $e \in B_{1} \backslash B_{2}$ then there exists $f \in B_{2} \backslash B_{1}$ such that $\left(B_{1}-e\right)+f \in \mathcal{B}$.
The family of independent sets of $M$, denoted by $\mathcal{I}(M)$ consists of all subsets of bases of $M$. For a matroid $M=(E, \mathcal{B})$, let $P(M)$ be the matroid base polytope of $M$ defined as the convex hull of the incidence vectors of bases of $M$, that is,

$$
P(M):=\operatorname{conv}\left\{\sum_{i \in B} e_{i}: B \text { a base of } M\right\}
$$

where $e_{i}$ denotes the $i^{t h}$ standard basis vector in $\mathbb{R}^{n} . P(M)$ is a polytope of dimension at most $n-1$. Notice that $P(M)$ is a face of the independent set polytope $I(M)$ which is obtained as the convex hull of the incidence vectors of the independent sets of $M$. These polytopes were first studied by Edmonds [5, 6].

A matroid base polytope decomposition of $P(M)$ is a decomposition

$$
P(M)=\bigcup_{i=1}^{t} P\left(M_{i}\right)
$$

where each $P\left(M_{i}\right)$ is also a matroid base polytope for some matroid $M_{i}$, and for each $1 \leq i \neq j \leq t$, the intersection $P\left(M_{i}\right) \cap P\left(M_{j}\right)$ is a face of both $P\left(M_{i}\right)$ and $P\left(M_{j}\right)$.
$P(M)$ is said to be decomposable if it has a matroid base polytope decomposition with $t \geq 2$, and indecomposable otherwise. A decomposition is called hyperplane split if $t=2$.

Matroid base polytope decomposition have appeared in many different contexts. For instance, they are treated in the work by Hacking, Keel and Tevelev [10, Section 3.3] in relation with the compactification of the moduli space of hyperplane arrangements (see also [12] and [13, Section 2.6]), in Speyer's work [22, 23] concerning tropical linear spaces, and in Lafforgue's work [15, 16] while studying the compactifications of the fine Schubert cell of the Grassmannian. In particular, Lafforgue's work implies that for a matroid $M$ represented by vectors in $\mathbb{F}^{r}$, if $P(M)$ is indecomposable, then $M$ will be rigid, that is, $M$ will have only finitely many realizations, up to scaling and the action of $G L(r, \mathbb{F})$. Recently, Billera, Jia and Reiner [3] (see also the closely related results due to Luoto [17]), Speyer [22, 23], Derksen [4] and Ardila, Fink and Rincon [1] have showed that different interesting matroids functions (as quasisymmetric functions and Tutte's polynomials) behave like valuations on the the associated matroid base polytope decomposition.

It is therefore of interest to know whether a given matroid base polytope is decomposable or not. Unfortunately, there is not much known about the existence or nonexistence of such decompositions (even for the case $t=2$ ). Kapranov [12, Section 1.3] showed that all decompositions of a (appropriately parametrizied) rank two matroid can be achieved by a sequence of hyperplane splits. In [3], Billera, Jia and Reiner found five rank three matroids on 6 elements for which the corresponding polytope is indecomposable. They also showed that $P(M)$ can be split into three indecomposable pieces where $M$ is the rank three matroid on $\{1, \ldots, 6\}$ having every triple but $\{1,2,3\},\{1,4,5\}$ and $\{3,5,6\}$ as bases. Moreover, they showed that this decomposition cannot be obtained via hyperplane splits. In this paper, we show the existence and nonexistence of hyperplane splits for some infinite classes of matroids. We also give a special family of matroid base polytopes that are indecomposable.

It is known that nonempty faces of matroid base polytope are matroid base polytopes [9, Theorem 2]. So, the common face $P\left(M_{i}\right) \cap P\left(M_{j}\right)$ (whose vertices correspond to elements of $\left.\mathcal{B}\left(M_{i}\right) \cap \mathcal{B}\left(M_{j}\right)\right)$ must also be a matroid base polytope. Thus, in order to investigate the nonexistence of base polytope decomposition, one may consider the following combinatorial
decomposition version. A matroid base decomposition of a matroid $M$ is a decomposition

$$
\mathcal{B}(M)=\bigcup_{i=1}^{t} \mathcal{B}\left(M_{i}\right)
$$

where $\mathcal{B}\left(M_{k}\right), 1 \leq k \leq t$ and $\mathcal{B}\left(M_{i}\right) \cap \mathcal{B}\left(M_{j}\right), 1 \leq i \neq j \leq t$ are collections of bases of matroids.
$M$ is said to be combinatorial decomposable if it has a matroid base decomposition. We say that the decomposition is nontrivial if $\mathcal{B}\left(M_{i}\right) \neq \mathcal{B}(M)$ for all $i$. If $P(M)$ is decomposable then $M$ is clearly combinatorial decomposable. However, a matroid base decomposition do not necessarily induce a matroid base polytope decomposition. For instance, the rank 2 matroid $M^{*}$ where $\mathcal{B}\left(M^{*}\right)=\{\{1,2\},\{1,3\},\{2,3\},\{2,4\},\{3,4\}\}$ has a combinatorial decomposition given by $\mathcal{B}\left(M_{1}\right)=\{\{1,2\},\{2,3\},\{2,4\}\}$ and $\mathcal{B}\left(M_{2}\right)=$ $\{\{1,3\},\{2,3\},\{3,4\}\}$ since $\mathcal{B}\left(M_{1}\right), \mathcal{B}\left(M_{2}\right)$ and $\mathcal{B}\left(M_{1}\right) \cap \mathcal{B}\left(M_{2}\right)=\{2,3\}$ are collections of bases of matroids. However the corresponding polytopes $P\left(M_{1}\right)$ and $P\left(M_{2}\right)$ do not decompose $P\left(M^{*}\right)$, see Figure 1.


Figure 1. $P\left(M^{*}\right), P\left(M_{1}\right)$ and $P\left(M_{2}\right)$
In order to prove the existence of nontrivial hyperplane splits, we always first show the existence of matroid base decompositions and then prove that this induces a hyperplane split since some geometric conditions (see Proposition 1) are satisfied.

In next section, we shall give sufficient conditions for a matroid $M$ so that $P(M)$ has a nontrivial hyperplane split. Our constructive method allows us to show the existence of at least $\left\lfloor\frac{n}{2}\right\rfloor$ different hyperplane splits of $P\left(U_{n, r}\right)$ with $n \geq r+2 \geq 3$ where $U_{n, r}$ denotes the uniform matroid on $n$ elements of rank $r$ (recall that $\mathcal{B}\left(U_{n, r}\right)$ consist of all $r$-subsets of $\{1, \ldots, n\}$ ). In Section 3, we present a complete characterization for matroid $M_{1} \oplus M_{2}$ so $P\left(M_{1} \oplus M_{2}\right)$ has a nontrivial hyperplane split where $M_{1} \oplus M_{2}$ denotes the direct sum
of matroids $M_{1}$ and $M_{2}$. In Section 4, we will show that $P(M)$ has not a nontrivial hyperplane split if $M$ is a binary matroid, that is, if $M$ is representable over $\mathbb{F}^{2}$. We finally prove that if the 1-skeleton of $P(M)$ is the hypercube then $P(M)$ is indecomposable.

## 2. Decomposition

The matroid base graph $G(M)$ of a matroid $M$ is the graph having as its set of vertices the bases of $M$ and there is an edge between two vertices (bases) $B_{1}, B_{2}$ if and only if there exist a pair of elements $e \in B_{1}$ and $f \in B_{2}$ such that $B_{2}=\left(B_{1} \backslash e\right)+f$, that is, the symmetric difference of $B_{1}$ and $B_{2}$, denoted by $\Delta\left(B_{1}, B_{2}\right)$, has cardinality two. It is known [8] that $G(M)$ is the 1-skeleton of $P(M)$ (in other words, the edges of $P(M)$ represent the basis exchange axiom) and that $G(M)$ is connected. We present the following geometric result used throughout the rest of the paper.

Proposition 1. Let $P$ be a d-polytope with set of vertices $X$. Let $H$ be a hyperplane such that $H \cap P \neq \emptyset$ with $H$ not supporting $P$. So, $H$ splits $P$ into polytopes $P_{1}$ and $P_{2}$, that is, $H \cap P=P_{1} \cap P_{2}=F \neq \emptyset$. $H$ also partition $X$ into sets $X_{1}$ and $X_{2}$ with $X_{1} \cap X_{2}=W$. Then, for each edge $[u, v]$ of $P$ we have that $\{u, v\} \subset X_{i}$ with either $i=1$ or 2 if and only if $F=\operatorname{conv}(W)$.

Proof. We notice that $X_{1}, X_{2} \neq \emptyset$ (since $H$ is not supporting). and let $[u, v]$ be an edge of $P$.
(Necessity) We shall proceed by contradiction. Suppose that $\{u, v\} \subset X_{i}$ with $i=1$ or 2 and that $F \neq \operatorname{conv}(W)$. Since $\operatorname{conv}(W) \subset F$ then there exists a vertex $x$ in $F$ such that $x \notin W$ (and thus $x \notin X$ ). So, $x$ is the intersection of $H$ with an edge $[u, v]$ of $P$ with $u \in X_{1} \backslash X_{2}$ and $v \in X_{2} \backslash X_{1}$ which is a contradiction.
(Sufficiency) We shall proceed by contradiction. Suppose that $F=\operatorname{conv}(W)$ and that $u \in X_{1} \backslash X_{2}$ and $v \in X_{2} \backslash X_{1}$. So, $u \in P_{1} \backslash P_{2}$ and $v \in P_{2} \backslash P_{1}$ and therefore $[u, v] \cap F=s$ with $s$ a vertex of $F$ different from $u$ and $v$. Then, $\operatorname{conv}(W)$ does not contain $s$ (since $s$ is not a vertex of $W$ ) and so $F \neq \operatorname{conv}(W)$, which is a contradiction.

We have the following easy consequence of this proposition.
Corollary 1. Let $P, P_{1}$ and $P_{2}$ be the polytopes as in Proposition 1. Then, $F=\operatorname{conv}(W)$ if and only if $P_{i}=\operatorname{conv}\left(X_{i}\right), i=1,2$ (and thus $P=P_{1} \cup P_{2}$ with $P_{1}$ and $P_{2}$ polytopes of the same dimension as $P$ sharing a facet).

Let $M=(E, \mathcal{B})$ be a matroid of rank $r$ and let $A \subseteq E$. We recall that the independent sets of the restriction matroid of $M$ to $A$, denoted by $\left.M\right|_{A}$, are given by $\mathcal{I}\left(\left.M\right|_{A}\right)=\{I \subseteq$ $A: I \in \mathcal{I}(M)\}$.

Let $\left(E_{1}, E_{2}\right)$ be a partition of $E$, that is, $E=E_{1} \cup E_{2}$ and $E_{1} \cap E_{2}=\emptyset$. Let $r_{i}>1$, $i=1,2$ be the rank of $\left.M\right|_{E_{i}}$. We say that $\left(E_{1}, E_{2}\right)$ is a good partition if there exist integers $0<a_{1}<r_{1}$ and $0<a_{2}<r_{2}$ with the following properties:
(P1) $r_{1}+r_{2}=r+a_{1}+a_{2}$ and
(P2) for all $X \in \mathcal{I}\left(\left.M\right|_{E_{1}}\right)$ with $|X| \leq r_{1}-a_{1}$ and all $Y \in \mathcal{I}\left(\left.M\right|_{E_{2}}\right)$ with $|Y| \leq r_{2}-a_{2}$ we have $X \cup Y \in \mathcal{I}(M)$.

Lemma 1. Let $M=(E, \mathcal{B})$ be a matroid of rank $r$ and let $\left(E_{1}, E_{2}\right)$ be a good partition of E. Let

$$
\mathcal{B}\left(M_{1}\right)=\left\{B \in \mathcal{B}(M):\left|B \cap E_{1}\right| \leq r_{1}-a_{1}\right\}
$$

and

$$
\mathcal{B}\left(M_{2}\right)=\left\{B \in \mathcal{B}(M):\left|B \cap E_{2}\right| \leq r_{2}-a_{2}\right\} .
$$

where $r_{i}$ is the rank of matroid $\left.M\right|_{E_{i}}, i=1,2$ and $a_{1}, a_{2}$ are integers satisfying Properties (P1) and (P2). Then, $\mathcal{B}\left(M_{1}\right)$ and $\mathcal{B}\left(M_{2}\right)$ are the collections of bases of matroids $M_{1}$ and $M_{2}$ respectively.

Proof. We shall prove that $\mathcal{B}\left(M_{1}\right)$ is the collection of bases of a matroid (this can be done similarly for $\left.\mathcal{B}\left(M_{2}\right)\right)$. We show that the elements in $\mathcal{B}\left(M_{1}\right)$ satisfy the basis exchange axiom. Let $X, Y \in \mathcal{B}\left(M_{1}\right) \subset \mathcal{B}(M)$ and suppose that $e \in X \backslash Y$. Since $M$ is a matroid then there exists $f \in Y \backslash X$ such that $X-e+f \in \mathcal{B}(M)$. We have two cases.

Case 1) Suppose that either $\left|X \cap E_{1}\right|<r_{1}-a_{1}$ or $e \in E_{1}$. Then, $\left|(X-e+f) \cap E_{1}\right| \leq r_{1}-a_{1}$ and thus $X-e+f \in \mathcal{B}\left(M_{1}\right)$.

Case 2) Suppose that $\left|X \cap E_{1}\right|=r_{1}-a_{1}$ and $e \in E_{2}$. On one hand, we have that $\left|(X-e) \cap E_{2}\right|=r-1-\left(r_{1}-a_{1}\right)=r-r_{1}+a_{1}-1$. On the other hand, we have that $\left|Y \cap E_{1}\right| \leq$ $r_{1}-a_{1}$ and thus $\left|Y \cap E_{2}\right| \geq r-\left(r_{1}-a_{1}\right)$. So, there exists $g \in Y \backslash(X-e)=Y \backslash X$ with $g \in E_{2}$ such that $(X-e+g) \cap E_{2} \in \mathcal{I}\left(\left.M\right|_{E_{2}}\right)$ and also, since $g \notin E_{1}$, then $(X-e+g) \cap E_{1} \in \mathcal{I}\left(\left.M\right|_{E_{1}}\right)$. Moreover, $\left|(X-e+g) \cap E_{1}\right|=r_{1}-a_{1}$ and $\left|(X-e+g) \cap E_{2}\right|=r-r_{1}+a-1=r_{2}-a_{2}$ and thus, by Property (P1), $|X-e+g|=r_{1}+r_{2}-a_{1}-a_{2}=r$. So, by Property (P2), we have $\left((X-e+g) \cap E_{1}\right) \cup\left((X-e+g) \cap E_{2}\right)=X-e+g \in \mathcal{I}(M)$. But since, $|X-e+g|=r$ then $X-e+g \in \mathcal{B}(M)$ and since $\left|(X-e+g) \cap E_{1}\right|=r_{1}-a_{1}$ then $X-e+g \in \mathcal{B}\left(M_{1}\right)$.

Notice that property (P2), needed for the proof of Lemma 1, can be replaced by the following weaker condition.
(P2') for all $B_{1} \in \mathcal{B}\left(M_{1}\right)$ and all $Y \in \mathcal{I}\left(\left.M\right|_{E_{2}}\right)$ with $|Y| \leq r_{2}-a_{2}$ we have $\left(B_{1} \cap E_{1}\right) \cup$ $Y \in \mathcal{I}(M)$ and for all $B_{2} \in \mathcal{B}\left(M_{2}\right)$ and all $Y \in \mathcal{I}\left(\left.M\right|_{E_{1}}\right)$ with $|Y| \leq r_{1}-a_{1}$ we have $\left(B_{2} \cap E_{2}\right) \cup Y \in \mathcal{I}(M)$.
$(\mathrm{P} 2)$ is a stronger condition that ( $\mathrm{P} 2^{\prime}$ ) since

$$
\left\{B_{1} \cap E_{1}: B_{1} \in \mathcal{B}\left(M_{1}\right)\right\} \subset\left\{X:|X| \leq r_{1}-a_{1}, X \in \mathcal{I}\left(\left.M\right|_{E_{1}}\right)\right\}
$$

and

$$
\left\{B_{2} \cap E_{2}: B_{2} \in \mathcal{B}\left(M_{2}\right)\right\} \subset\left\{X:|X| \leq r_{2}-a_{2}, X \in \mathcal{I}\left(\left.M\right|_{E_{2}}\right)\right\}
$$

For instance, let us consider the rank 3 matroid $M$ on $E=\{1, \ldots, 5\}$ where $\mathcal{B}(M)=$ $\{\{1,2,3\},\{1,2,4\},\{1,2,5\},\{1,3,4\},\{1,3,5\},\{1,4,5\}\}$ (an Euclidean representation of $M$ is given by representing element 1 as an isolated point and elements $2,3,4,5$ on a line). We take $E_{1}=\{1,2,3\}, E_{2}=\{4,5\}$ and $a_{1}=1, a_{2}=1$. It can be checked that (P2') holds while (P2) does not.

Theorem 1. Let $M=(E, \mathcal{B})$ be a matroid of rank $r$ and let $\left(E_{1}, E_{2}\right)$ be a good partition of $E$. Let $M_{1}$ and $M_{2}$ be matroids given in Lemma 1. Then, $P(M)=P\left(M_{1}\right) \cup P\left(M_{2}\right)$ is a nontrivial hyperplane split.

Proof. We will first show that $\mathcal{B}\left(M_{1}\right)$ and $\mathcal{B}\left(M_{2}\right)$ give a nontrivial matroid base decomposition of $M$. For this, we show
(i) $\mathcal{B}(M)=\mathcal{B}\left(M_{1}\right) \cup \mathcal{B}\left(M_{2}\right)$,
(ii) $\mathcal{B}\left(M_{1}\right), \mathcal{B}\left(M_{2}\right) \subset \mathcal{B}(M)$,
(iii) $\mathcal{B}\left(M_{1}\right), \mathcal{B}\left(M_{2}\right) \nsubseteq \mathcal{B}\left(M_{1}\right) \cap \mathcal{B}\left(M_{2}\right)$,
(iv) $\mathcal{B}\left(M_{1}\right) \cap \mathcal{B}\left(M_{2}\right) \neq \emptyset$ and
(v) $\mathcal{B}\left(M_{1}\right) \cap \mathcal{B}\left(M_{2}\right)$ is the collection of bases of a matroid.

We then show that this matroid base decomposition induces a nontrivial hyperplane split. For this, we show
(vi) there exists an hyperplane containing the vertices corresponding to $\mathcal{B}\left(M_{1}\right) \cap \mathcal{B}\left(M_{2}\right)$, and not supporting $P(M)$,
(vii) any edge of $P(M)$ is also an edge of either $P\left(M_{1}\right)$ or $P\left(M_{2}\right)$.

So, by Corollary $1, \mathcal{B}\left(M_{1}\right) \cap \mathcal{B}\left(M_{2}\right)$ is the set of vertices of a facet of $P\left(M_{1}\right)$ and $P\left(M_{2}\right)$ and thus $P(M)=P\left(M_{1}\right) \cup P\left(M_{2}\right)$.

We may now prove the above claims.
(i) We claim that $\overline{\mathcal{B}(M)}=\emptyset$. Indeed, let $B \in \overline{\mathcal{B}(M)}=\left\{B \in \mathcal{B}(M):\left|B \cap E_{1}\right|>\right.$ $r_{1}-a_{1}$ and $\left.\left|B \cap E_{2}\right|>r_{2}-a_{2}\right\}$. Since $E_{1} \cap E_{2}=\emptyset$ then $|B|>r_{1}+r_{2}-a_{1}-a_{2}=r$ which is not possible. So, $\mathcal{B}(M)=\mathcal{B}\left(M_{1}\right) \cup \mathcal{B}\left(M_{2}\right)$.
(ii) We show that $\mathcal{B}\left(M_{1}\right) \subset \mathcal{B}(M)$ (it can also be proved that $\mathcal{B}\left(M_{2}\right) \subset \mathcal{B}(M)$ by using similar arguments). Let $B$ be a base of $\left.M\right|_{E_{1}}$ (and so $|B|=r_{1}$ ). We have two cases.

Case 1) If $r_{1}=r$ then $B \in \mathcal{B}(M)$ but $B \notin \mathcal{B}\left(M_{1}\right)$ since $\left|B \cap E_{1}\right|=r>r_{1}-a_{1}$.
Case 2) If $r_{1}<r$ then there exists a base $B^{\prime} \in \mathcal{B}(M)$ with $B \subset B^{\prime}$ since $B \in \mathcal{I}(M)$. Moreover, $\left|B^{\prime} \cap E_{1}\right| \geq r_{1}>r_{1}-a_{1}$ and thus $B^{\prime} \in \mathcal{B}(M)$ but $B^{\prime} \notin \mathcal{B}\left(M_{1}\right)$.
(iii) If $\mathcal{B}\left(M_{1}\right) \subseteq \mathcal{B}\left(M_{1}\right) \cap \mathcal{B}\left(M_{2}\right)$ then $\mathcal{B}\left(M_{1}\right) \subseteq \mathcal{B}\left(M_{2}\right)$ and thus $\mathcal{B}\left(M_{2}\right)=\mathcal{B}\left(M_{1}\right) \cup$ $\mathcal{B}\left(M_{2}\right)=\mathcal{B}(M)$ contradicting (ii).
(iv) Let $X, Y \in \mathcal{B}(M)$ such that $\left|X \cap E_{1}\right|=r_{1}$ and $\left|Y \cap E_{2}\right|=r_{2}$ (we have seen in (ii) that such bases always exist). Since $G(M)$ is connected then there exists a path $X=B_{1}, \ldots, B_{m}=Y$ connecting $X$ and $Y$ where $B_{i} \in \mathcal{B}(M)$ for each $i=1, \ldots, m$. Since $\left|B_{i} \Delta B_{i+1}\right|=2$ then $\left|B_{i} \cap E_{1}\right|=\left|B_{i+1} \cap E_{1}\right|+k$ with either $k=-1,0,+1,$. Moreover, $\left|B_{1} \cap E_{1}\right|=r_{1}$ and $\left|B_{m} \cap E_{1}\right|=r-r_{2}=r_{1}-a_{1}-a_{2}$. So, there must exist an index $k$ such that $\left|B_{k} \cap E_{1}\right|=r_{1}-a_{1}$. Moreover $\left|B_{k} \cap E_{2}\right|=r-r_{1}+a_{1}=r_{2}-a_{2}$. So, $B_{k} \in \mathcal{B}\left(M_{1}\right) \cap \mathcal{B}\left(M_{2}\right)$.
$(v)$ This can be done by using similar arguments as those used in Lemma 1.
(vi) We first notice that if $B \in \mathcal{B}\left(M_{1}\right) \cap \mathcal{B}\left(M_{2}\right)$ then $B \in \mathcal{B}(M)$ (so $|B|=r$ ) and $\left|B \cap E_{1}\right| \leq r_{1}-a_{1},\left|B \cap E_{2}\right| \leq r_{2}-a_{2}=r-r_{1}+a_{1}$. So, if $B \in \mathcal{B}\left(M_{1}\right) \cap \mathcal{B}\left(M_{2}\right)$ then $\left|B \cap E_{1}\right|=r_{1}-a_{1}$ and $\left|B \cap E_{2}\right|=r_{2}-a_{2}$. Let $H$ be the hyperplane defined by

$$
H(\mathbf{x})=\left\{\mathbf{x} \in \mathbb{R}^{n}:\langle\mathbf{e}, \mathbf{x}\rangle=r_{1}-a_{1} \text { where } \mathbf{e}=\sum_{i \in E_{1}} e_{i}\right\}
$$

If $B \in \mathcal{B}\left(M_{1}\right)$ then $\left|B \cap E_{1}\right| \leq r_{1}-a_{1}$ and thus $H\left(x_{B}\right) \leq r_{1}-a_{1}$. If $B \in \mathcal{B}\left(M_{2}\right)$ then $\left|B \cap E_{2}\right| \leq r_{2}-a_{2}$ and so $\left|B \cap E_{1}\right| \geq r-r_{2}+a_{2}=r_{1}-a_{1}$. Then, $H\left(x_{B}\right) \geq r_{1}-a_{1}$. Therefore, $H$ contains only elements in $\mathcal{B}\left(M_{1}\right) \cap \mathcal{B}\left(M_{2}\right)$. Notice that $\operatorname{dim}(P(M) \cap H)=d-1$ where $d=\operatorname{dim}(P(M))$. Indeed, $\operatorname{dim}(P(M) \cap H) \leq d$ and if $\operatorname{dim}(P(M) \cap H) \leq d-2$ then $P(M)$ would be contained in the closed-half space $\bar{H}^{+}$or in $\bar{H}^{-}$which is impossible by (iii). So, the affine space $H^{\prime}$ containing $P(M) \cap H$ is a hyperplane in $\mathbb{R}^{d}$ not supporting $P(M)$.
(vii) Suppose that there exists an edge in $P(M)$ belonging to neither $P\left(M_{1}\right)$ nor $P\left(M_{2}\right)$. So, there exist $B_{1} \in \mathcal{B}\left(M_{1}\right) \backslash \mathcal{B}\left(M_{2}\right)$ and $B_{2} \in \mathcal{B}\left(M_{2}\right) \backslash \mathcal{B}\left(M_{1}\right)$ with $\Delta\left(B_{1}, B_{2}\right)=2$. Then, $\left|B_{1} \cap E_{1}\right|<r_{1}-a_{1}$ and $\left|B_{2} \cap E_{1}\right|>r_{1}-a_{1}$. Combining the latter with the fact that $\Delta\left(B_{1}, B_{2}\right)=2$, then we must have $\left|B_{1} \cap E_{1}\right|=r_{1}-a_{1}$ which is a contradiction.

Remark 1. It is not necessary to have a good partition in the hypothesis of Theorem 1 but only the existence of a partition $\left(E_{1}, E_{2}\right)$ of $E$ satisfying property (P1) and such that the sets $\mathcal{B}\left(M_{1}\right), \mathcal{B}\left(M_{2}\right)$ and $\mathcal{B}\left(M_{1}\right) \cap \mathcal{B}\left(M_{2}\right)$ be collections of bases of matroids. Indeed, this is the case if the partition satisfies either (P2) or (P2').

Example 1: Let us consider $U_{4,2}$ and the good partition $E_{1}=\{1,2\}$ and $E_{2}=\{3,4\}$ (and so $r_{1}=r_{2}=2$ ) with $a_{1}=a_{2}=1$. Then $\mathcal{B}\left(M_{1}\right)=\{\{1,3\},\{1,4\},\{2,3\},\{2,4\},\{3,4\}\}$, $\mathcal{B}\left(M_{2}\right)=\{\{1,2\},\{1,3\},\{1,4\},\{2,3\},\{2,4\}\}$ and $\mathcal{B}\left(M_{1}\right) \cap \mathcal{B}\left(M_{2}\right)=\{\{1,3\},\{1,4\},\{2,3\},\{2,4\}\}$, see Figure 2.


Figure 2. Hyperplane split of $P\left(U_{4,2}\right)$

We remark that there exist matroids with ground set $E$ not having a good partition. For instance, let $M\left(K_{4}\right)$ be the matroid associated to the complete graph on four vertices. We leave this as an exercise to the reader.
It turns out that $P\left(M\left(K_{4}\right)\right)$ has not a nontrivial hyperplane split (this is justified at the end of Section 4).

Let $M=(E, \mathcal{B})$ be a matroid of $\operatorname{rank} r$ and let $X \subset E$ be both a circuit and a hyperplane of $M$ (recall that a hyperplane is a flat, that is $X=c l(X)$, of rank $r-1$ ). It is known [21, Proposition 1.5.13] that $\mathcal{B}\left(M^{\prime}\right)=\mathcal{B}(M) \cup X$ is the collection of bases of a matroid $M^{\prime}$ (called, relaxation of $M$ ).

Corollary 2. Let $M=(E, \mathcal{B})$ be a matroid and let $\left(E_{1}, E_{2}\right)$ be a good partition of $E$. Then, $P\left(M^{\prime}\right)$ has a nontrivial hyperplane split where $M^{\prime}$ is a relaxation of $M$.

Proof. It can be checked that the desired hyperplane split of $P\left(M^{\prime}\right)$ can be obtained by using the same given good partition $\left(E_{1}, E_{2}\right)$ of $E$.

Although $P\left(M\left(K_{4}\right)\right)$ has not a nontrivial hyperplane split, base polytopes of relaxations of $M\left(K_{4}\right)$ may have one.

Example 2: Let $W^{3}$ be the matroid of rank 3 on $E=\{1, \ldots, 6\}$ having as set of bases all 3 -subsets of $E$ except the triples $\{1,2,5\},\{1,4,6\}$ and $\{2,3,6\}$. Notice that $W^{3}$ is a relaxation of $M\left(K_{4}\right)$ (by relaxing circuit $\{3,4,5\}$ ) but it is not graphic. It can be checked
that $E_{1}=\{1,2,6\}$ and $E_{2}=\{3,4,5\}$ (and so $r_{1}=r_{2}=3$ ) with $a_{1}=2$ and $a_{2}=1$ is a good partition.
2.1. Uniform matroids. We say that two hyperplane splits $P\left(M_{1}\right) \cup P\left(M_{2}\right)$ and $P\left(M_{1}^{\prime}\right) \cup$ $P\left(M_{2}^{\prime}\right)$ of $P(M)$ are equivalent if $P\left(M_{i}\right)$ is combinatorial equivalent to $P\left(M_{i}^{\prime}\right)$ for each $i=1,2$ (that is, the corresponding face lattices are isomorphic). They are different otherwise.

Corollary 3. Let $n \geq r+2 \geq 4$ be integers. Let $h\left(U_{n, r}\right)$ be the number of different hyperplane splits of $P\left(U_{n, r}\right)$. Then,

$$
h\left(U_{n, r}\right) \geq\left\lfloor\frac{n}{2}\right\rfloor-1
$$

Proof. For each $k=2, \ldots,\left\lfloor\frac{n}{2}\right\rfloor$, we let $E_{1}(k)=\{1, \ldots, k\}$ and $E_{2}(k)=\{k+1, \ldots, n\}$. So, $\left.M\right|_{E_{1}(k)}$ is isomorphic to $U_{k, \min \{k, r\}}$ and $\left.M\right|_{E_{2}(k)}$ is isomorphic to $U_{n-k, \min \{n-k, r\}}$. Let $r_{1}$ and $r_{2}$ be the ranks of $\left.M\right|_{E_{1}(k)}$ and $\left.M\right|_{E_{2}(k)}$ respectively. Then, an easy analysis shows that

$$
r_{1}+r_{2}=\min \{n, k+r, n-k+r, 2 r\} \geq r+2 .
$$

So, we can find integers $a_{1}, a_{2} \geq 1$ such that $r_{1}+r_{2}=r+a_{1}+a_{2}$ and thus $\left(E_{1}(k), E_{2}(k)\right)$ is a good partition.

Notice that there might be several choices for the values of $a_{1}$ and $a_{2}$ (each of which arises from a good partition). However, it is not clear if these partitions give different hyperplane splits.

Example 3: Let us consider $U_{n, 3}$ with $n \geq 6$. We take the good partition $E_{1}(k)=$ $\{1, \ldots, k\}$ and $E_{2}(k)=\{k+1, \ldots, n\}$ for any $2 \leq k \leq\left\lfloor\frac{n}{2}\right\rfloor$ (and thus $r_{1}=2, r_{2}=3$ ). If we set $a_{2}=1$ and $a_{1}$ such that $r_{1}-a_{1}=1$ then $\mathcal{B}\left(M_{1}\right)=\left\{B \in \mathcal{B}\left(U_{n, 3}\right):\left|B \cap E_{1}\right| \leq 1\right\}$ and $\mathcal{B}\left(M_{2}\right)=\left\{B \in \mathcal{B}\left(U_{n, 3}\right):\left|B \cap E_{2}\right| \leq 2\right\}$.
2.2. Lattice path matroids. Let $\mathcal{A}=\left(A_{j}: j \in J\right)$ be a set system, that is, multiset of subsets of a finite set $E$. A transversal of $\mathcal{A}$ is a set $\left\{x_{j}: j \in J\right\}$ of $|J|$ distinct elements such that $x_{j} \in A_{j}$ for all $j$. A partial transversal of $\mathcal{A}$ is a transversal of a set system of the form ( $A_{k}: k \in K$ ) with $K \subseteq J$. A fundamental result due to Edmonds and Fulkerson [7] states that the partial transversals of a set of system $\mathcal{A}=\left(A_{j}: j \in J\right)$ are the independent sets of a matroid on $E$. We say that $\mathcal{A}$ is a presentation of the transversal matroid. The bases of a transversal matroid are the maximal partial transversals.

A lattice path starts at point $(0,0)$ and uses steps $(1,0)$ and $(0,1)$, called East and North. Let $P=p_{1}, \ldots, p_{r+m}$ and $Q=q_{1}, \ldots, q_{r+m}$ be two lattice paths from $(0,0)$ to $(m, r)$ with $P$ never going above $Q$. Let $\left\{p_{s_{1}}, \ldots, p_{s_{r}}\right\}$ be the set of North steps of $P$ with $s_{1}<\cdots<s_{r}$;
similarly, let $\left\{q_{t_{1}}, \ldots, q_{t_{r}}\right\}$ be the set of North steps of $Q$ with $t_{1}<\cdots<t_{r}$. We clearly have that $t_{i} \leq s_{i}$ for all $1 \leq i \leq r$. Let $M[P, Q]$ be the transversal matroid that has ground set $\{1, \ldots, m+r\}$ and presentation $\left(N_{i}: i \in\{1, \ldots, r\}\right)$ where $N_{i}$ denotes the interval $\left[t_{i}, s_{i}\right]$ of integers. Transversal matroids arising as above are called lattice path matroids. Given a subset $X$ of $\{1, \ldots, m+r\}$, we define the lattice path $P(X)=u_{1}, \ldots, u_{m+r}$ where $u_{i}$ is a North step if $i \in X$, an East step otherwise.

In [2] it was proved that a subset $B$ of $\{1, \ldots, m+r\}$ with $|B|=r$ is a base of $M[P, Q]$ if and only if the associated path $P(B)$ stays in the region bounded by $P$ and $Q$.

Corollary 4. Let $M[P, Q]$ be the transversal matroid on $\{1, \ldots, m+r\}$ and presentation $\left(N_{i}: i \in\{1, \ldots, r\}\right)$ where $N_{i}$ denotes the interval $\left[t_{i}, s_{i}\right]$ of integers. Suppose that there exists integer $x$ such that $t_{j}<x<s_{j}$ and $t_{j+1}<x+1<s_{j+1}$ for some $1 \leq j \leq r-1$. Then, $P(M[P, Q])$ has a nontrivial hyperplane split.

Proof. Let $E_{1}=\{1, \ldots, x\}$ and $E_{2}=\{x+1, \ldots, m+r\}$. Then, $\left.M\right|_{E_{1}}\left(\right.$ resp. $\left.\left.M\right|_{E_{2}}\right)$ is the transversal matroid with representation $\left(N_{i}^{1}: i \in\{1, \ldots, r\}\right.$ ) where $N_{i}^{1}=N_{i} \cap E_{1}$ (resp. with representation $\left(N_{i}^{2}: i \in\{1, \ldots, r\}\right)$ where $\left.N_{i}^{2}=N_{i} \cap E_{2}\right)$. Let $r_{1}$ and $r_{2}$ be the ranks of $\left.M\right|_{E_{1}}$ and $\left.M\right|_{E_{2}}$ respectively. We have that $N_{i}^{1} \neq \emptyset$ for all $i \leq j+1$ (since the smallest element in $N_{i}$ is strictly smaller than $x+1$. Therefore, $r_{1} \geq j+1$. Similarly, we have that $N_{i}^{2} \neq \emptyset$ for all $i \geq r-j+1$ (since the smallest element in $N_{i}$ is larger than $x+1$ ). Therefore, $r_{2} \geq r-j+1$. So, the partition $\left(E_{1}, E_{2}\right)$ satisfies property (P1) by taking integers $a_{1}$ and $a_{2}$ such that $r_{1}-a_{1}=j$ and $r_{2}-a_{2}=r-j$. Moreover, the sets $\mathcal{B}\left(M_{1}\right)=\left\{B \in \mathcal{B}(M):\left|B \cap E_{1}\right| \leq r_{1}-a_{1}\right\}$ and $\mathcal{B}\left(M_{2}\right)=\left\{B \in \mathcal{B}(M):\left|B \cap E_{2}\right| \leq\right.$ $\left.r_{2}-a_{2}\right\}$ are the collections of bases of matroids $M_{1}$ and $M_{2}$ respectively. Indeed, $M_{1}$ is the transversal matroid with representation $\left(\bar{N}_{i}^{1}: i \in\{1, \ldots, r\}\right)$ where $\bar{N}_{i}^{1}=N_{i}$ for each $i=1, \ldots, j$ and $\bar{N}_{i}^{1}=N_{i} \cap E_{2}$ for each $i=j+1, \ldots, r . M_{2}$ is the transversal matroid with representation $\left(\bar{N}_{i}^{2}: i \in\{1, \ldots, r\}\right)$ where $\bar{N}_{i}^{2}=N_{i} \cap E_{1}$ for each $i=1, \ldots, j$ and $\bar{N}_{i}^{1}=N_{i}$ for each $i=j+1, \ldots, r$. Finally, $M_{1} \cap M_{2}$ is the transversal matroid with representation $\left(\bar{N}_{i}: i \in\{1, \ldots, r\}\right)$ where $\bar{N}_{i}=\bar{N}_{i}^{1} \cap \bar{N}_{i}^{2}$ for each $i=1, \ldots, r$. The result follows by Remark 1.

Notice that there might be several choices for the values of $x, j, a_{1}$ and $a_{2}$ (each of which gives rise to a good partition). However, it is not clear if these partitions give different hyperplane splits. Also notice that the partition proposed in the above proof may satisfy neither (P2) nor (P2'). We shall see this, for instance, in the following example.

Example 4: Let $m=3$ and $r=4$. Let $P=p_{1}, \ldots, p_{7}$ be the lattice path where $p_{1}, p_{2}, p_{3}$ are East steps and $p_{4}, p_{5}, p_{6}, p_{7}$ are North steps . Let $Q=q_{1}, \ldots, q_{7}$ be the lattice path where $q_{2}, q_{4}, q_{6}$ are East steps and $q_{1}, q_{3}, q_{5}, q_{7}$ are North steps. Let $M[P, Q]$ be the transversal matroid on $\{1, \ldots, 7\}$ and presentation ( $N_{i}: i \in\{1, \ldots, 4\}$ ) where $N_{1}=[1,2,3,4], N_{2}=[3,4,5], N_{3}=[5,6]$ and $N_{4}=[7]$, see Figure 3.


Figure 3. Lattice paths $P$ and $Q$

Recall that a subset $B$ of $\{1, \ldots, 7\}$ with $|B|=4$ is a base of $M[P, Q]$ if and only if the associated path $P(B)$ stays in the region bounded by $P$ and $Q$.

Let us take $x=3$ and $j=1$, then $E_{1}=\{1,2,3\}$ and $E_{2}=\{4,5,6,7\}$. So, the presentation of $\left.M\right|_{E_{1}}$ (resp. $\left.M\right|_{E_{2}}$ ) is given by $N_{1}^{1}=[1,2,3]$ and $N_{2}^{1}=[3]$ (resp. by $N_{1}^{2}=[4], N_{2}^{2}=[4,5], N_{3}^{2}=[5,6]$ and $\left.N_{4}^{2}=[7]\right)$ and thus, $r_{1}=1$ and $r_{2}=4$. By setting $a_{1}=a_{2}=1$, we obtain that $M_{1}$ is the transversal matroid with representation ( $\bar{N}_{i}^{1}: i \in$ $\{1, \ldots, 4\}$ ) where $\bar{N}_{1}^{1}=[1,2,3,4], \bar{N}_{2}^{1}=[4,5], \bar{N}_{3}^{1}=[5,6]$ and $\bar{N}_{4}^{1}=[7]$. And, $M_{2}$ is the transversal matroid with representation ( $\left.\bar{N}_{i}^{2}: i \in\{1, \ldots, 4\}\right)$ where $\bar{N}_{1}^{2}=[1,2,3], \bar{N}_{2}^{2}=$ $[3,4,5], \bar{N}_{3}^{2}=[5,6]$ and $\bar{N}_{4}^{2}=[7]$. Finally, we have that $M_{1} \cap M_{2}$ is the transversal matroid with representation ( $\bar{N}_{i}: i \in\{1, \ldots, 4\}$ ) where $\bar{N}_{1}=[1,2,3], \bar{N}_{2}=[4,5], \bar{N}_{3}=[5,6]$ and $\bar{N}_{4}=[7]$. These matroids are illustrated in Figure 4.


Figure 4. Transversal matroids (a) $M_{1}$ (b) $M_{2}$ and (c) $M_{1} \cap M_{2}$

So, by Corollary $4, M[P, Q]$ has a nontrivial hyerplane split. We notice that the above partition do not satisfy either (P2) (for instance, $\{3\} \in \mathcal{I}\left(\left.M\right|_{E_{1}}\right),\{4,5,6\} \in \mathcal{I}\left(\left.M\right|_{E_{2}}\right)$ but $\{3,4,5,6\} \notin \mathcal{I}(M[P, Q])$ ) or (P2') (for instance, $B=\{1,4,5,7\} \in \mathcal{B}\left(M_{1}\right), Y=\{4,5,6\} \in$ $\mathcal{I}\left(\left.M\right|_{E_{2}}\right)$ but $\left.\left(B \cap E_{1}\right) \cup Y=\{1,4,5,6\} \notin \mathcal{I}(M[P, Q])\right)$.

Example 5: Let $m \geq r \geq 2$ be integers. Let $P_{1}=p_{1}, \ldots, p_{m+r}$ be the lattice path where $p_{1}, \ldots, p_{m}$ are East steps and $p_{m+1}, \ldots, p_{m+r}$ are North steps. Let $Q_{1}=$ $q_{1}, \ldots, q_{m+r}$ be the lattice path where $q_{1}, \ldots q_{r}$ are North steps and $q_{r+1}, \ldots, q_{r+m}$ are East steps. Let $M_{1}\left[P_{1}, Q_{1}\right]$ be the transversal matroid on $\{1, \ldots, m+r\}$ and presentation $\left(N_{i}: i \in\{1, \ldots, r\}\right)$ where $N_{i}$ denotes the interval $\left[s_{i}=i, m+i=t_{i}\right]$. So, integer $x=2$ is such that $s_{1}<x<t_{1}$ and $s_{2}<x+1<t_{2}$ and thus, by Corollary $4, P\left(M_{1}\right)$ has a nontrivial hyperplane split. Notice that any $r$-subset of $\{1, \ldots, m+r\}$ is a base of $M_{1}$, in other words, $M_{1}$ is isomorphic to $U_{m+r, r}$ (and thus, we found a particular case of Corollary $3)$.

## 3. Direct sum

Let $M_{1}=\left(E_{1}, \mathcal{B}\right)$ and $M_{2}=\left(E_{2}, \mathcal{B}\right)$ be matroids of rank $r_{1}$ and $r_{2}$ respectively where $E_{1} \cap E_{2}=\emptyset$. The direct sum, denoted by $M_{1} \oplus M_{2}$, of matroids $M_{1}$ and $M_{2}$ has as ground set the disjoint union $E\left(M_{1} \oplus M_{2}\right)=E\left(M_{1}\right) \cup E\left(M_{2}\right)$ and as set of bases $\mathcal{B}\left(M_{1} \oplus M_{2}\right)=$ $\left\{B_{1} \cup B_{2} \mid B_{1} \in \mathcal{B}\left(M_{1}\right), B_{2} \in \mathcal{B}\left(M_{2}\right)\right\}$. Further, the rank of $M_{1} \oplus M_{2}$ is $r_{1}+r_{2}$. Our main result in this section is the following.

Theorem 2. Let $M_{1}=\left(E_{1}, \mathcal{B}\right)$ and $M_{2}=\left(E_{2}, \mathcal{B}\right)$ be matroids of rank $r_{1}$ and $r_{2}$ respectively where $E_{1} \cap E_{2}=\emptyset$. Then, $P\left(M_{1} \oplus M_{2}\right)$ has a nontrivial hyperplane split if and only if either $P\left(M_{1}\right)$ or $P\left(M_{2}\right)$ has a nontrivial hyperplane split.

We first prove the following lemma needed for the proof of Theorem 2.
Lemma 2. Let $M_{1}=\left(E_{1}, \mathcal{B}\right)$ and $M_{2}=\left(E_{2}, \mathcal{B}\right)$ be matroids of rank $r_{1}$ and $r_{2}$ respectively where $E_{1} \cap E_{2}=\emptyset$. Then, $A \subset \mathcal{B}\left(M_{1} \oplus M_{2}\right)$ is the collection of bases of a matroid if and only if $A=\left\{X \cup Y: X \in A_{1}, Y \in A_{2}\right\}$ where $A_{i} \subseteq \mathcal{B}\left(M_{i}\right)$ is the collection of bases of $a$ matroid for each $i=1,2$.

Proof. (Sufficiency) We notice that $A=\mathcal{B}\left(M\left(A_{1}\right) \oplus M\left(A_{2}\right)\right)$ where $M\left(A_{i}\right)$ is the matroid given by the collection of bases $A_{i}$ on $E_{i}, i=1,2$. Thus, $A \subset \mathcal{B}\left(M_{1} \oplus M_{2}\right)$ and, by definition of the direct sum, $A$ is indeed the collection of bases of a matroid.
(Necessity) We suppose that $A \subset \mathcal{B}\left(M_{1} \oplus M_{2}\right)$ is the collection of bases of a matroid, say $M(A)$. We set

$$
A_{1}=\left\{B \cap E_{1}: B \in A\right\} \text { and } A_{2}=\left\{B \cap E_{2}: B \in A\right\} .
$$

We first show that $A_{1}$ is the collection of bases of a matroid (it can also be shown that $A_{2}$ is the collection of bases of a matroid by using similar arguments). We thus show that the basis exchange axiom is satisfied. The case when $\left|A_{1}\right|=1$ is clear. Let us suppose that $\left|A_{1}\right| \geq 2$. Let $D_{1}, D_{2} \in A_{1}$. So, there exist $B_{1}, B_{2} \in A$ such that $B_{i} \cap E_{1}=D_{i}$, $i=1,2$. Since $M(A)$ is a matroid if $e \in\left(B_{1} \backslash B_{2}\right) \cap E_{1}=D_{1} \backslash D_{2}$ then there exists
$f \in B_{2} \backslash B_{1}$ such that $B_{1}-e+f \in A$. Since $e \in E_{1}$ then $\left|\left(B_{1}-e\right) \cap E_{2}\right|=r_{2}$ implying that $f \notin E_{2}$ (otherwise, $\left|\left(B_{1}-e+f\right) \cap E_{2}\right|=r_{2}+1$, which is impossible). Thus, $f \in E_{1}$ and so $f \in D_{2} \backslash D_{1}$. Therefore, $\left(B_{1}-e+f\right) \cap E_{1}=D_{1}-e+f \in A_{1}$. We observe that the latter implies the following:

Remark 2. For all $e \in D_{1} \backslash D_{2}$ there exists $f \in D_{2}$ such that if $D_{1} \cup Y \in A$ then $\left(D_{1}-e+f\right) \cup Y \in A$ for any $Y \in \mathcal{B}\left(M_{2}\right)$.

We now show that $A=\left\{X \cup Y: X \in A_{1}, Y \in A_{2}\right\}$. It is clear that $A \subseteq\{X \cup Y$ : $\left.X \in A_{1}, Y \in A_{2}\right\}$. Let $X^{\prime} \in A_{1}$ and $Y^{\prime} \in A_{2}$, we shall show that $X^{\prime} \cup Y^{\prime} \in A$ and so $\left\{X \cup Y: X \in A_{1}, Y \in A_{2}\right\} \subseteq A$. We first observe that for any $X^{\prime} \in A_{1}$ and any $Y^{\prime} \in A_{2}$ there exist $Y^{\prime \prime} \in A_{2}$ and $X^{\prime \prime} \in A_{1}$ such that

$$
X^{\prime} \cup Y^{\prime \prime} \in A \text { and } X^{\prime \prime} \cup Y^{\prime} \in A .
$$

If $X^{\prime}=X^{\prime \prime}$ then we clearly have $X^{\prime} \cup Y^{\prime} \in A$. Let us suppose then that $X^{\prime} \neq X^{\prime \prime}$. By Remark 2, for all $e \in X^{\prime \prime} \backslash X^{\prime}$ there exists $f \in X^{\prime}$ such $\left(X^{\prime \prime}-e+f\right) \cup Y^{\prime} \in A$. We can then construct a path $X^{\prime \prime}=D_{1}, \ldots, D_{m}=X^{\prime}$ connecting $X^{\prime \prime}$ to $X^{\prime}$ such that $D_{i} \cup Y^{\prime} \in A$ for each $i=1, \ldots, m-1$. Since, $D_{1} \cup Y^{\prime}=X^{\prime \prime} \cup Y^{\prime} \in A$ then we may conclude that $D_{m} \cup Y^{\prime}=X^{\prime} \cup Y^{\prime} \in A$.

We may now prove Theorem 2.
Proof of Theorem 2. (Necessity) We suppose that $P\left(M_{1} \oplus M_{2}\right)=P(A) \cup P(C)$ is a nontrivial hyperplane split for some matroids $A$ and $C$. Since $\mathcal{B}(A), \mathcal{B}(C) \subset \mathcal{B}\left(M_{1} \oplus M_{2}\right)$ then, by Lemma 2, we have

$$
\mathcal{B}(A)=\left\{X \cup Y: X \in A_{1}, Y \in A_{2}\right\} \text { and } \mathcal{B}(C)=\left\{X \cup Y: X \in C_{1}, Y \in C_{2}\right\}
$$

where $A_{1}, C_{1} \subseteq \mathcal{B}\left(M_{1}\right)$ and $A_{2}, C_{2} \subseteq \mathcal{B}\left(M_{2}\right)$ are the collection of bases of matroids.
We know that $\mathcal{B}(A) \cup \mathcal{B}(C)=\mathcal{B}\left(M_{1} \oplus M_{2}\right)$. We claim that $A_{2}=C_{2}=\mathcal{B}\left(M_{2}\right)$ and $A_{1}, C_{1} \subset \mathcal{B}\left(M_{1}\right)$ (or, symmetrically, $A_{1}=C_{1}=\mathcal{B}\left(M_{1}\right)$ and $A_{2}, C_{2} \subset \mathcal{B}\left(M_{2}\right)$ ). Indeed, if $A_{1} \neq \mathcal{B}\left(M_{1}\right)$ then there exists $X^{\prime} \in \mathcal{B}\left(M_{1}\right)$ with $X^{\prime} \notin A_{1}$ such that for all $Y \in \mathcal{B}\left(M_{2}\right)$ we have $X^{\prime} \cup Y \in \mathcal{B}(A) \cup \mathcal{B}(C)$. Moreover, since $X^{\prime} \cup Y \notin \mathcal{B}(A)$ then $X^{\prime} \cup Y \in \mathcal{B}(C)$. Therefore, $\left\{X^{\prime} \cup Y: Y \in \mathcal{B}\left(M_{2}\right)\right\} \subseteq \mathcal{B}(C)$ and so $C_{2}=\mathcal{B}\left(M_{2}\right)$ implying that $C_{1} \neq \mathcal{B}\left(M_{1}\right)$ (since $\left.\mathcal{B}(C) \subset \mathcal{B}\left(M_{1} \oplus M_{2}\right)\right)$. Similarly, we may also obtain that $A_{2}=\mathcal{B}\left(M_{2}\right)$. Now, if $A_{1}=\mathcal{B}\left(M_{1}\right)$ then $A_{2} \neq \mathcal{B}\left(M_{2}\right)$ (since $\mathcal{B}(A) \subset \mathcal{B}\left(M_{1} \oplus M_{2}\right)$ ). We obtain, by using similar arguments as above, that $C_{1}=\mathcal{B}\left(M_{1}\right)$ and $C_{2} \neq \mathcal{B}\left(M_{2}\right)$.

So, suppose that $A_{2}=C_{2}=\mathcal{B}\left(M_{2}\right)$ and $A_{1}, C_{1} \subset \mathcal{B}\left(M_{1}\right)$. We have that

$$
\mathcal{B}(A) \cup \mathcal{B}(C)=\mathcal{B}\left(M_{1} \oplus M_{2}\right)=\left\{X \cup Y: X \in A_{1} \cup C_{1}, Y \in \mathcal{B}\left(M_{2}\right)\right\}
$$

and thus, $A_{1} \cup C_{1}=\mathcal{B}\left(M_{1}\right)$. Also,

$$
\mathcal{B}(A) \cap \mathcal{B}(C)=\left\{X \cup Y: X \in A_{1} \cap C_{1}, Y \in \mathcal{B}\left(M_{2}\right)\right\} \subset \mathcal{B}\left(M_{1} \oplus M_{2}\right)
$$

so, since $\mathcal{B}(A) \cap \mathcal{B}(C)$ is a collection of bases of a matroid then, by Lemma $2, A_{1} \cap C_{1}$ is a collection of bases of a matroid. Therefore, $A_{1}$ and $C_{1}$ is a nontrivial matroid base decomposition of $M_{1}$.

We now show that this matroid base decomposition induces a nontrivial hyperplane split. To this end, we first show that there exists a hyperplane containing the elements corresponding to $A_{1} \cap C_{1}$ not supporting $P\left(M_{1}\right)$. Let $H$ be the hyperplane corresponding to the nontrivial hyperplane split $P\left(M_{1} \oplus M_{2}\right)=P(A) \cup P(C)$. Notice that $\operatorname{dim}(H) \leq$ $\left|E_{1}\right|+\left|E_{2}\right|-2$ since $\operatorname{dim}\left(P\left(M_{1} \oplus M_{2}\right)\right) \leq\left|E_{1}\right|+\left|E_{2}\right|$. Without loss of generality, we may suppose that $\operatorname{dim}(H)=\left|E_{1}\right|+\left|E_{2}\right|-2$, otherwise we consider $P\left(M_{1} \oplus M_{2}\right)$ embedded in $\mathbb{R}^{\left|E_{1}\right|+\left|E_{2}\right|}$ and properly extend the equation of $H$. Thus, $H$ can be written as
$H(\mathbf{x})=\left\{\mathbf{x} \in \mathbb{R}^{\left|E_{1}\right|+\left|E_{2}\right|}:\left\langle\mathbf{e}^{1}, \mathbf{x}\right\rangle+\left\langle\mathbf{e}^{2}, \mathbf{x}\right\rangle=p\right.$ where $\mathbf{e}^{i}=\sum_{j \in E_{i}} \alpha_{j}^{i} e_{j}$ with $\alpha_{j}^{i} \in \mathbb{R}$ and $\left.p \in \mathbb{N}\right\}$
where $e_{j}^{i}$ denotes the $j^{\text {th }}$ standard basis vector in $\mathbb{R}^{\left|E_{i}\right|}$ for each $i=1,2$.
$H$ contains the common facet of $P(A)$ and $P(C)$ (that is, the elements in $\mathcal{B}(A) \cap \mathcal{B}(C)$ ). Now, there exists $X^{\prime} \in A_{1} \cap C_{1}$ such that for all $Y \in \mathcal{B}\left(M_{2}\right)$ we have $X^{\prime} \cup Y \in \mathcal{B}(A) \cap \mathcal{B}(C)$ and $\left\langle\mathbf{e}^{1}, \mathbf{x}^{\prime}\right\rangle+\left\langle\mathbf{e}^{2}, \mathbf{y}\right\rangle=p$. So, for all $Y \in \mathcal{B}\left(M_{2}\right)$

$$
\begin{equation*}
\left\langle\mathbf{e}^{2}, \mathbf{y}\right\rangle=p-\left\langle\mathbf{e}^{1}, \mathbf{x}^{\prime}\right\rangle=p-p^{\prime} \tag{1}
\end{equation*}
$$

where $p^{\prime} \in \mathbb{N}$. Now, there exists $Y \in \mathcal{B}\left(M_{2}\right)$ such that $X \cup Y \in \mathcal{B}(A) \cap \mathcal{B}(C)$ for all $X \in A_{1} \cap C_{1}$, so

$$
\left\langle\mathbf{e}^{1}, \mathbf{x}\right\rangle+\left\langle\mathbf{e}^{2}, \mathbf{y}\right\rangle=p
$$

and thus, by (1),

$$
\begin{equation*}
\left\langle\mathbf{e}^{1}, \mathbf{x}\right\rangle=p^{\prime} \tag{2}
\end{equation*}
$$

Since $P(A) \cup P(C)$ is a nontrivial hyperplane split then there exists $B_{1}=X_{1} \cup Y_{1} \in \mathcal{B}(A)$ with $X_{1} \in A_{1}$ and $Y_{2} \in \mathcal{B}\left(M_{2}\right)$ such that $\left\langle\mathbf{e}^{1}, \mathbf{x}\right\rangle+\left\langle\mathbf{e}^{2}, \mathbf{x}^{\prime}\right\rangle>p$. Then, by (2), we have $\left\langle\mathbf{e}^{1}, \mathbf{x}\right\rangle+p-p^{\prime}>p$ and so,

$$
\begin{equation*}
\left\langle\mathbf{e}^{1}, \mathbf{x}\right\rangle>p^{\prime} \tag{3}
\end{equation*}
$$

Similarly, there exists $B_{2}=X_{2} \cup Y_{2} \in \mathcal{B}(C)$ with $X_{1} \in C_{1}$ and $Y_{2} \in \mathcal{B}\left(M_{2}\right)$ such that $\left\langle\mathbf{e}^{1}, \mathbf{x}\right\rangle+\left\langle\mathbf{e}^{2}, \mathbf{x}^{\prime}\right\rangle<p$. Then, by (2), we have $\left\langle\mathbf{e}^{1}, \mathbf{x}\right\rangle+p-p^{\prime}<p$ and so,

$$
\begin{equation*}
\left\langle\mathbf{e}^{1}, \mathbf{x}\right\rangle<p^{\prime} . \tag{4}
\end{equation*}
$$

Therefore, by (2), the hyperplane

$$
H^{\prime}(\mathbf{x})=\left\{\mathbf{x} \in \mathbb{R}^{\left|E_{1}\right|+\left|E_{2}\right|}:\left\langle\mathbf{e}^{1}, \mathbf{x}\right\rangle=p^{\prime} \text { where } \mathbf{e}^{1}=\sum_{j \in E_{1}} \alpha_{j}^{1} e_{j} \text { with } \alpha_{j}^{1} \in \mathbb{R}\right\}
$$

contains the elements corresponding to $A_{1} \cap C_{1}$. Moreover, $H^{\prime}$ does not support $P\left(M_{1}\right)$ by (3) and (4).

We now show that any edge of $P\left(M_{1}\right)$ is also an edge of either $P\left(A_{1}\right)$ or $P\left(C_{1}\right)$. We do this by contradiction, let $B_{A} \in A_{1} \backslash C_{1}$ and $B_{C} \in C_{1} \backslash A_{1}$ with $\Delta\left(B_{A}, B_{C}\right)=2$. There exists $Y \in \mathcal{B}\left(M_{2}\right)$ such that $B_{A} \cup Y \in \mathcal{B}(A) \backslash \mathcal{B}(C)$ and $B_{C} \cup Y \in \mathcal{B}(C) \backslash \mathcal{B}(A)$. Since $\Delta\left(B_{A} \cup Y, B_{C} \cup Y\right)=\Delta\left(B_{A}, B_{C}\right)=2$ then the edge in $P\left(M_{1} \oplus M_{2}\right)$ joining $B_{A} \cup Y$ to $B_{C} \cup Y$ is an edge of neither $P(A)$ nor $P(C)$, which is a contradiction since $P(A) \cup P(C)$ is a nontrivial hyperplane split.

Therefore, by Proposition 1, $A_{1} \cap C_{1}$ are the set of vertices of a common facet of $P\left(A_{1}\right)$ and $P\left(C_{1}\right)$ and, by Corollary 1, $P\left(M_{1}\right)=P\left(A_{1}\right) \cup P\left(C_{1}\right)$.
(Sufficiency) Without loss of generality, we suppose that $P\left(M_{1}\right)=P\left(N_{1}\right) \cup P\left(N_{2}\right)$ is a nontrivial hyperplane split for some matroids $N_{i}, i=1,2$. Let

$$
L_{1}=N_{1} \oplus M_{2}, L_{2}=N_{2} \oplus M_{2} \text { and } L_{1} \cap L_{2}=\left(N_{1} \cap N_{2}\right) \oplus M_{2},
$$

Since $N_{1}, N_{2}$ and $N_{1} \cap N_{2}$ are matroids then $L_{1}$ and $L_{2}$ and $L_{1} \cap L_{2}$ are also matroids where the collection of bases of $L_{1}$ and $L_{2}$ are
$\mathcal{B}\left(L_{1}\right)=\left\{X \cup Y: X \in \mathcal{B}\left(N_{1}\right), Y \in \mathcal{B}\left(M_{2}\right)\right\}$ and $\mathcal{B}\left(L_{2}\right)=\left\{X \cup Y: X \in \mathcal{B}\left(N_{2}\right), Y \in \mathcal{B}\left(M_{2}\right)\right\}$
Moreover, $\mathcal{B}\left(L_{1}\right) \cup \mathcal{B}\left(L_{2}\right)=\mathcal{B}\left(M_{1} \oplus M_{2}\right)\left(\right.$ since $\left.\mathcal{B}\left(N_{1}\right) \cup \mathcal{B}\left(N_{2}\right)=\mathcal{B}\left(M_{1}\right)\right), \mathcal{B}\left(L_{i}\right) \subset$ $\mathcal{B}\left(M_{1} \oplus M_{2}\right)$ (since $\mathcal{B}\left(N_{i}\right) \subset \mathcal{B}\left(M_{1}\right)$ for each $\left.i=1,2\right)$ and $\mathcal{B}\left(L_{1}\right) \cap \mathcal{B}\left(L_{2}\right) \neq \emptyset$ (since $\left.\mathcal{B}\left(N_{1}\right) \cap \mathcal{B}\left(N_{2}\right) \neq \emptyset\right)$. Thus, the matroids given by the collection of bases $\mathcal{B}\left(L_{1}\right)$ and $\mathcal{B}\left(L_{2}\right)$ is a nontrivial matroid base decomposition of $\mathcal{B}\left(M_{1} \oplus M_{2}\right)$.

We now show that this matroid base decomposition induces a nontrivial hyperplane split. To this end, we first show that there exists an hyperplane containing the elements in $\mathcal{B}\left(L_{1}\right) \cap \mathcal{B}\left(L_{2}\right)$ not supporting $P\left(M_{1} \oplus M_{2}\right)$. Let $H$ be the hyperplane in $\mathbb{R}^{d}$ where $d$ is the dimension of $P\left(M_{1}\right)$ containing a common facet of $P\left(N_{1}\right)$ and $P\left(N_{2}\right)$. We suppose that $P\left(N_{1}\right)$ lies in the closed half-space $\bar{H}^{+}$and that $P\left(N_{2}\right)$ lies in the other closed half-space $\bar{H}^{-}\left(H\right.$ exists since $P\left(N_{1}\right) \cup P\left(N_{2}\right)$ is a nontrivial hyperplane split). Moreover, there exist $B_{1} \in \mathcal{B}\left(N_{1}\right)$ and $B_{2} \in \mathcal{B}\left(N_{2}\right)$ such that $B_{1}$ lies in the open half-space $H^{+}$while $B_{2}$ lies in the open half-space $H^{-}$. Let $H_{1}$ be the hyperplane defined by the same equation as $H$ in $\mathbb{R}^{d^{\prime}}$ where $d^{\prime}$ is the dimension of $P\left(M_{1} \oplus M_{2}\right)$ (notice that $\left.d^{\prime}>d\right)$. Then, $H_{1}$
contains the elements in $\mathcal{B}\left(L_{1}\right) \cap \mathcal{B}\left(L_{2}\right)$. Moreover, $H_{1}$ does not support $P\left(M_{1} \oplus M_{2}\right)$ since $B_{1} \cup Y \in \mathcal{B}\left(L_{1}\right)$ lies in open half-space $H_{1}^{+}$and $B_{2} \cup Y \in \mathcal{B}\left(L_{2}\right)$ lies in the open half-space $H_{1}^{-}$for some $Y \in \mathcal{B}\left(M_{2}\right)$.

We now show that any edge of $P\left(M_{1} \oplus M_{2}\right)$ is also and edge of either $P\left(L_{1}\right)$ or $P\left(L_{2}\right)$. We do this by contradiction, let $B_{1} \in \mathcal{B}\left(L_{1}\right) \backslash \mathcal{B}\left(L_{2}\right)$ and $B_{2} \in \mathcal{B}\left(L_{2}\right) \backslash \mathcal{B}\left(L_{1}\right)$ with $\Delta\left(B_{1}, B_{2}\right)=$ 2. Since $B_{1}=X_{1} \cup X_{2}$ with $X_{1} \in \mathcal{B}\left(N_{1}\right), X_{1} \notin \mathcal{B}\left(N_{2}\right)$ and $B_{2}=Y_{1} \cup Y_{2}$ with $Y_{1} \notin$ $\mathcal{B}\left(N_{1}\right), Y_{1} \in \mathcal{B}\left(N_{2}\right)$ then $X_{1} \neq Y_{1}$. So, $X_{2}=Y_{2}\left(\right.$ since $\left.\Delta\left(B_{1}, B_{2}\right)=2\right)$.

Therefore, by Corollary $1, \mathcal{B}\left(L_{1}\right) \cap \mathcal{B}\left(L_{2}\right)$ are the set of vertices of a facet of $P\left(L_{1}\right)$ and $P\left(L_{2}\right)$ and $P\left(M_{1} \oplus M_{2}\right)=P\left(L_{1}\right) \cup P\left(L_{2}\right)$.

It is known [2] that lattice path matroids are closed under direct sums. Let $M\left[P_{1}, Q_{1}\right]$ and $M\left[P_{2}, Q_{2}\right]$ be two lattice path matroids. Then, by Corollary $4, P\left(M\left[P_{1}, Q_{1}\right]\right)$ (or $\left.P\left(M\left[P_{2}, Q_{2}\right]\right)\right)$ has a nontrivial hyperplane split and so, by Theorem 2, $P\left(M\left[P_{1}, Q_{1}\right] \oplus\right.$ $\left.M\left[P_{2}, Q_{2}\right]\right)$ also does.

## 4. Binary matroids

Maurer [18, Theorem 2.1] gave a complete characterization of those graphs that are matroid base graphs. Let $X, Y$ be two vertices and let $\delta(X, Y)$ be the distance between $X$ and $Y$ in $G(M)$. If $\delta(X, Y)=2$ (that is, $X$ and $Y$ are not adjacent but they are joined by a path of length two) then their common neighbor is defined as the set of vertices adjacent to both $X$ and $Y$. Maurer showed that each common neighbor is a square, pyramid or octahedron, see Figure 5.

In [19, Theorem 4.1] Maurer proved that a matroid $M$ is binary if and only if $G(M)$ contains no induced octahedra. Notice that $G\left(U_{4,2}\right)$ is given by an octahedron (see Figure 2) and that induced octahedra in $G(M)$ correspond to minors of $M$ isomorphic to $U_{4,2}$.

Corollary 5. Let $M=(E, \mathcal{B})$ be a binary matroid and let $X, Y \in \mathcal{B}$ with $\delta(X, Y)=2$. Then, there exists a unique couple $U, V \in \mathcal{B}$ such that $X, U, V, Y$ form an empty square in $G(M)$, that is, $X, U, V, Y$ form a cycle of length four without diagonals.

Proof. The existence of an empty square follows from Maurer's characterization. Indeed, for each pair of vertices $X, Y$ with $\delta(X, Y)=2$ we have that their common neighbor is either a square or a pyramid. In both cases we can find the desired empty square. For uniqueness, suppose that there are two empty squares, say $X, U, V, Y$ and $X, U^{\prime}, V^{\prime}, Y$ with $\{U, V\} \neq\left\{U^{\prime}, V^{\prime}\right\}$. If exactly one of $U, V$ is in $\left\{U^{\prime}, V^{\prime}\right\}$, say $V=V^{\prime}$, see Figure 6 (a) (respectively, if none of $U, V$ belongs to $\left\{U^{\prime}, V^{\prime}\right.$ ), see Figure $\left.6(\mathrm{~b})\right)$ then, by the basis exchange axiom $\left\{X, V=V^{\prime}, U, U^{\prime}, Y\right\}$ must induce a pyramid, and thus neither $X, U, V, Y$ nor $X, U^{\prime}, V^{\prime}, Y$ form an empty square (respectively, $\left\{X, V=V^{\prime}, U, U^{\prime}, Y\right\}$ induce an octahedron which is not possible since $M$ is binary).

Lemma 3. Let $M=(E, \mathcal{B})$ be a binary matroid and let $\mathcal{B}_{1} \subset \mathcal{B}$ such that $\mathcal{B}_{1}$ are the set of bases of a matroid, say $M_{1}$. If $X \in \mathcal{B}_{1}$ and the neighborhood of $X$ (that is, the set of vertices in $G(M)$ adjacent to $X$ ) are elements of $\mathcal{B}_{1}$ then $\mathcal{B}_{1}=\mathcal{B}$.

Proof. We first notice that $M_{1}$ is binary. Indeed, since $M$ is binary, we consider the columns of the matrix representation of $M$ corresponding to those elements used in $\mathcal{B}_{1}$. Let $X \in \mathcal{B}_{1}$ and let $\delta_{i}(X)=\{Y \in \mathcal{B}(M) \mid \delta(X, Y)=i\}$. We shall use induction on
i. The cases $i=0,1$ are true by hypothesis. Suppose that $\bigcup_{i=1}^{k} \delta_{i}(X) \subset \mathcal{B}_{1}$ and let $Y \in \delta_{k+1}(X)$. Since $G(M)$ is connected then there exists a path joining $X$ to $Y$ and thus there is $Z \in \delta_{k-1}(X)$ such that $\delta(Z, Y)=2$. By Corollary 5 , there exists a unique couple $U, V \in \mathcal{B}$ such that $Z, U, V, Y$ form an empty square in $G(M)$. So, $\delta(X, U)=\delta(X, V)=k$ implying that $U, V \in \delta_{k}(X)$. Thus, since $\delta_{k}(X) \in \mathcal{B}_{1}$ and $M_{1}$ is binary then, by Corollary 5 , there exists a unique couple $Z^{\prime}, Y^{\prime} \in \mathcal{B}_{1}$ such that $Z^{\prime}, U, V, Y^{\prime}$ form an empty square in $G\left(M_{1}\right)$. Since $Z^{\prime}, U, V, Y^{\prime}$ is also an empty square in $G(M)$ then (by uniqueness) we must have that $Z^{\prime}=Z$ and $Y^{\prime}=Y$. Therefore, $Y \in \mathcal{B}_{1}$.

Theorem 3. Let $M$ be a binary matroid. Then, $P(M)$ has not a nontrivial hyperplane split.

Proof. By contradiction, let us suppose that $P(M)=P\left(M_{1}\right) \cup P\left(M_{2}\right)$ is a nontrivial hyperplane split for some matroids $M_{1}, M_{2}$ (and thus $P\left(M_{1}\right), P\left(M_{2}\right) \neq P(M)$ ). The latter induces the matroid base decomposition of $\mathcal{B}(M)=\mathcal{B}\left(M_{1}\right) \cup \mathcal{B}\left(M_{2}\right)$. By Corollary 1, $P\left(M_{1}\right)$ contains a vertex of $P(M)$ together with all its neighbors. But then, by Lemma $3, M_{1}=M$ which is a contradiction since the hyperplane split is nontrivial.

Corollary 6. Let $M$ be a binary matroid. If $G(M)$ contains a vertex $X$ having exactly d neighbours (that is, with $\left|\delta_{1}(X)\right|=d$ ) where $d=\operatorname{dim}(P(M)$ ) then $P(M)$ is indecomposable.
Proof. By contradiction, let $P(M)=\bigcup_{i=1}^{t} P\left(M_{i}\right), t \geq 2$ be a decomposition. Notice that $d=\operatorname{dim}(P(M))=\operatorname{dim}\left(P\left(M_{i}\right)\right)$ for all $i$. We claim that if vertex $X$ belongs to $P\left(M_{i}\right)$ for some $i$ then $\delta_{1}(X)$ also does. Indeed, any vertex in $P\left(M_{i}\right)$ (and in a general in a $d$-polytope) must have at least $d$ neighbours since $\operatorname{dim}\left(P\left(M_{i}\right)\right)=d$. So if $X$ belongs to $P\left(M_{i}\right)$ then all its $d$ neigbours must also belong to $P\left(M_{i}\right)$. Thus, since $M$ is binary and by using Lemma 3 , we have that $M_{i}=M$ which is a contradiction since $t \geq 2$.

Maurer [20] has proved that the $d$-dimensional hypercube is the base matroid graph of a binary matroid. We have the following immediate consequence.

Corollary 7. Let $P(M)$ be the base matroid polytope having as 1-skeleton the hypercube. Then, $P(M)$ is indecomposable.

Proof. It follows by Corollary 6 since any vertex in the $d$-dimensional hypercube has precisely $d$ neighbours.

The following corollary is an immediate consequence of Theorem 3 since any graphic matroid is binary.

Corollary 8. $P(M)$ has not a nontrivial hyperplane split if $M$ is a graphic matroid.

In particular, the matroid $M\left(K_{4}\right)$ has not a nontrivial hyperplane split.
Note: One of the referees informed us that a complete characterization for the existence of hyperplane splits is given by Kim [14]. However, our necessary conditions (Theorem 1) are easier to satisfy than those given by Kim and allow us to construct families of matroid base polytopes having a hyperplane split (Corollary 2), to give examples without such splits $\left(P\left(M\left(K_{4}\right)\right)\right)$ and to give different hyperplane splits for the same base matroid polytope (Corollary 3). None of the latter is discussed in [14]. Also, our arguments used to prove Theorem 1 are different from those given in [14]. We finally mention that our results in Sections 3 and 4 are not discussed in [14] at all. We were also informed that Hermann and Joswig [11] studied the splits of general polytopes. They rediscovered Kim's characterization in the special case when the matroid base polytope is the entire hypersimplex.
