# A new fully justified asymptotic model for the propagation of internal waves in the Camassa-Holm regime

#### Abstract

This study deals with asymptotic models for the propagation of one-dimensional internal waves at the interface between two layers of immiscible fluids of different densities, under the rigid lid assumption and with a flat bottom. We present a new Green-Naghdi type model in the Camassa-Holm (or medium amplitude) regime. This model is fully justified, in the sense that it is consistent, well-posed, and that its solutions remain close to exact solutions of the full Euler system with corresponding initial data. Moreover, our system allows to fully justify any well-posed and consistent lower order model; and in particular the so-called Constantin-Lannes approximation, which extends the classical Korteweg-de Vries equation in the Camassa-Holm regime.


## 1 Introduction

### 1.1 Presentation of the problem

In the present paper, we study the propagation of internal waves in a two-fluid system, which consists in two layers of immiscible fluids of different densities, under the only influence of gravity. The domain of the two layers is infinite in the horizontal space variable (assumed to be of dimension $d=1$ ) and delimited above by a flat, rigid lid, a below by a flat bottom. Moreover, we assume that the fluids are homogeneous, ideal, incompressible and irrotational. We let the reader refer to [24, and references therein, for a good overview of the ins and outs concerning density-stratified fluids in oceanography, and the relevance of our setup as a model for such system.

The governing equations describing the evolution of the flow under the aforementioned configuration may be reduced to a system of two evolution equations located at the interface between the two layers (following a strategy initiated in the water-wave configuration in 16, 43, and achieved in the bi-fluidic case in $\mid 7$ ), named full Euler system. However, the study of this system is extremely challenging. In particular, the well-posedness of the Cauchy problem has been answered satisfactorily (that is, with a predicted lifespan of solutions consistent with physical observations) only recently; see 31].

Under these circumstances, a great deal of interests has been drawn to asymptotic models, in order to predict accurately the main behavior of the system, provided some parameters describing the domain and nature of the flow are small. Parameters of interests include

where $a$ is the maximal vertical deformation of the interface with respect to its rest position; $\lambda$ is a characteristic horizontal length; $d_{1}$ (resp. $d_{2}$ ) is the depth of the upper (resp. lower) layer; and $\rho_{1}$

[^0](resp. $\rho_{2}$ ) is the density of the upper (resp. lower) layer, $g$ the gravitational acceleration and $\sigma$ the interfacial tension coefficient. Mathematically speaking, $\mu$ and $\epsilon$ measure respectively the amount of dispersion and nonlinearity which will contribute to the evolution of internal waves, and $\mathrm{Bo}^{-1}$ (the Bond number) expresses the ratio of surface tension forces to gravitational forces. It would be quite tedious to make an attempt at acknowledging every work on this aspect, but let us introduce some earlier results directly related to the present paper.

Shallow water ( $\mu \ll 1$ ) asymptotic models for uni-dimensional internal waves have been derived and studied in the pioneer works of [34, 35, 37]. More recently, Choi and Camassa developed models with weakly $(\epsilon=\mathcal{O}(\mu))$ and strongly $(\epsilon \sim 1)$ nonlinear terms, respectively in 11, 12 with horizontal dimension $d=2$. They obtain bi-fluidic extensions of the classical shallow water (or Saint-Venant [17]), Boussinesq 9,10 and Green-Naghdi 22,40 models. Similar systems have been derived in (with the additional assumption of $\gamma \approx 1$ ) and in 15 (using a different approach, i.e. making use of the Hamiltonian structure of the full Euler equations). However, the aforementioned results are limited to the formal level. Let us mention now the work of Bona, Lannes and Saut 7 who, following a strategy initiated in [4,5] in the water-wave setting (one layer of fluid, with free surface), derived a large class of models for different regimes, under the rigid-lid assumption, neglecting surface tension effects and with flat bottom (see also [2] where a topography and surface tension is added to the system, and [18] where the rigid-lid assumption is removed). The same technique has been used to derive Green-Naghdi models 20,21 as well as intermediate long wave $(\epsilon \sim \sqrt{\mu}$ and $\delta \sim \sqrt{\mu})$ systems 42 . The models derived in these papers are systematically justified by a consistency result: roughly speaking, sufficiently smooth solutions of the full Euler system satisfy the equations of the asymptotic model, up to a small remainder.

Yet the consistency is only one of the properties that an asymptotic model shall satisfy, for its validity to be ascertained. Indeed, it leaves two important questions unanswered: for a large class of initial data (typically bounded in suitable Sobolev spaces)

1. (well-posedness) do the full Euler system, as well as the asymptotic model, define a unique solution on a relevant time scale?
2. (convergence) is the difference between these two solutions small over the relevant time scale?

As mentioned earlier, Lannes has recently proved 31 that the Cauchy problem for bi-fluidic full Euler system is well-posed in Sobolev spaces over large time, in the presence of a small amount of surface tension. Thus the full justification of a consistent system of equation as an asymptotic model, in the sense described above, follows from its well-posedness and a stability result; see 29 , Appendix C] for a detailed discussion and state of the art in the water-wave setting.

A striking discrepancy between the water-wave and the bi-fluidic setting is that in the latter, large amplitude internal waves are known to generate Kelvin-Helmholtz instabilities, so that surface tension is necessary in order to regularize the flow. A crucial contribution of 31 consists in asserting that "the Kelvin-Helmholtz instabilities appear above a frequency threshold for which surface tension is relevant, while the main (observable) part of the wave involves low frequencies located below this frequency threshold". It is therefore expected that the surface tension does not play an essential role in the dominant evolution of the flow, especially in the shallow water regime. This intuition is confirmed by the fact that well-posedness and stability results have been proved for the bi-fluidic shallow-water system 23, a class of Boussinesq-type systems 19 as well as intermediate long wave systems [42, without surface tension and under reasonable assumptions on the flow (typically, the shear velocity must be sufficiently small).

However, the original bi-fluidic Green-Naghdi model (or more precisely the linearized system about solutions of constant non-trivial shear velocity) is known to be unconditionally ill-posed in absence of surface tension (33], due to growing modes appearing above a certain frequency threshold. These instabilities are therefore similar to the Kelvin-Helmholtz instabilities of the full Euler system, but are actually wilder; see Section 4.2 for more details. Let us recall that the Green-Naghdi model consists in a higher order extension of the shallow water equation, thus is consistent with precision $\mathcal{O}\left(\mu^{2}\right)$ instead of $\mathcal{O}(\mu)$, and allow strong nonlinearities (whereas Boussinesq models are limited to the long wave regime: $\epsilon=\mathcal{O}(\mu)$ ). As a consequence, and conversely to aforementioned models, it
contains nonlinear dispersive terms in the form of high order, nonlinear differential operators, which are responsible for these instabilities. Various regularized models, that is systems with the same precision as the original Green-Naghdi model in the sense of consistency but improved stability behavior, have been proposed in the literature; see 3,8,14 and references therein. However, these works are restricted to the formal level, and do not provide the complete justification in the sense described above.

In this work, we present a new Green-Naghdi type model in the Camassa-Holm (or medium amplitude) regime, $\epsilon=\mathcal{O}(\sqrt{\mu})$, for the propagation of internal waves. More precisely, the regime of validity of our model is, with fixed $\mu_{\max }, M, \delta_{\min }^{-1}, \delta_{\max }<\infty$ :

0<\mu \leq \mu_{\max }, \quad 0 \leq \epsilon \leq \min (M \sqrt{\mu}, 1), \quad \delta_{\min } \leq \delta \leq \delta_{\max }, \quad 0 \leq \gamma<1
$$

Our model is fully justified: we prove that the full Euler system is consistent with our model, and that our system is well-posed (in the sense of Hadamard) in Sobolev spaces, and stable with respect to perturbations of the equations. These results hold identically without or with (small) surface tension.

In order to obtain these results, we write our system as a quasilinear infinite dimensional first order system, that is a system defined by matrices whose coefficients are differential operators. A similar strategy was used in $[25,32]$ for the Green-Naghdi system in the water wave situation (one layer of fluid), and later on for various Boussinesq systems in 39. The system we obtain is not symmetric, but has a pleasant structure, which allows to decompose it as the sum of a symmetrizable principal part, and a lower order part that is genuinely controlled in the energy space thanks to the assumption of the Camassa-Holm regime and using the extra regularity of the energy space provided by the dispersive terms. At this point, direct well-posedness results are not readily available in the literature, and the conventional technique of a priori estimates in high regularity Sobolev spaces towards the existence of solution and stability of our system has to be precisely conducted. The control of the difference between a solution of the full Euler system and the solution of our model with corresponding initial data is then a direct consequence of the well-posedness, stability and consistency of our model.

Let us emphasize that in addition to its relevance as an asymptotic model, our system offers an important tool for the justification of other models. Indeed, it suffices to check that a given approximate solution solves our system up to a small remainder, to ensure that it is truly close to the solution of our new model, and therefore to the corresponding solution of the full Euler system. Such strategy has been used in particular in $\sqrt{6}$ in order to rigorously justify the historical Korteweg-de Vries equation as a model for the propagation of surface wave in the long wave regime (with a Boussinesq model as the intermediary system); and this result has been extended to the bi-fluidic case in [19]. Higher order models in the Camassa-Holm regime have been introduced and justified in the sense of consistency in [13] in the water-wave case, and in [20 in the bi-fluidic case. We are therefore able to fully justify the latter model, in the sense described above.

We start by introducing in Section 2 the non-dimensionalized full Euler system, describing the evolution of the two-fluid system we consider. In Section 3, we present our new model, and we announce the main results of this paper. This asymptotic model is precisely derived and motivated in Section 4. Sections 5 and 6 contain the necessary ingredients for the proof of our results, which are completed in Section 7. In Section 8, we explain how our system allows us to justify any well-posed and consistent lower order model. Finally the title of Appendix A is self-explanatory.

We conclude this section with an inventory of the notations used throughout the present paper.
Notations In the following, $C_{0}$ denotes any nonnegative constant whose exact expression is of no importance. The notation $a \lesssim b$ means that $a \leq C_{0} b$.
We denote by $C\left(\lambda_{1}, \lambda_{2}, \ldots\right)$ a nonnegative constant depending on the parameters $\lambda_{1}, \lambda_{2}, \ldots$ and whose dependence on the $\lambda_{j}$ is always assumed to be nondecreasing.
We use the condensed notation

## 2 The full Euler system

We recall that the system we study consists in two layers of immiscible, homogeneous, ideal, incompressible fluids only under the influence of gravity (see Figure 1). We restrict ourselves to the two-dimensional case, i.e. the horizontal dimension $d=1$. The derivation of the governing

equations of such a system is not new. We briefly recall it below, and refer to $2,7,20$ for more details.

We assume that the interface is given as the graph of a function $\zeta(t, x)$ which expresses the deviation from its rest position $(x, 0)$ at the spatial coordinate $x$ and at time $t$. The bottom and surface are assumed to be rigid and flat. Therefore, at each time $t \geq 0$, the domains of the upper and lower fluid (denoted, respectively, $\Omega_{1}^{t}$ and $\Omega_{2}^{t}$ ), are given by

We assume that the two domains are strictly connected, that is there exists $h>0$ such that

We denote by $\left(\rho_{1}, \mathbf{v}_{1}\right)$ and $\left(\rho_{2}, \mathbf{v}_{2}\right)$ the mass density and velocity fields of, respectively, the upper and the lower fluid. The two fluids are assumed to be homogeneous and incompressible, so that the mass densities $\rho_{1}, \rho_{2}$ are constant, and the velocity fields $\mathbf{v}_{1}, \mathbf{v}_{2}$ are divergence free. As we assume the flows to be irrotational, one can express the velocity fields as gradients of a potential: $\mathbf{v}_{i}=\nabla \phi_{i}(i=1,2)$, and the velocity potentials satisfy Laplace's equation

The fluids being ideal, they satisfy the Euler equations. Integrating the momentum equation yields the so-called Bernoulli equation, written in terms of the velocity potentials:

where $P$ denotes the pressure inside the fluids.
From the assumption that no fluid particle crosses the surface, the bottom or the interface, one deduces kinematic boundary conditions, and the set of equations is closed by the continuity of the stress tensor at the interface, which reads

where $k(\zeta)=-\partial_{x}\left(\frac{1}{\sqrt{1+\left|\partial_{x} \zeta\right|^{2}}} \partial_{x} \zeta\right)$ denotes the mean curvature of the interface and $\sigma$ the surface (or interfacial) tension coefficient.

Altogether, the governing equations of our problem are given by the following

where $n$ denotes the unit upward normal vector at the interface.
The next step consists in nondimensionalizing the system. Thanks to an appropriate scaling, the two-layer full Euler system (2.1) can be written in dimensionless form. The study of the linearized system (see 31 for example), which can be solved explicitly, leads to a well-adapted rescaling.

Let $a$ be the maximum amplitude of the deformation of the interface. We denote by $\lambda$ a characteristic horizontal length, say the wavelength of the interface. Then the typical velocity of small propagating internal waves (or wave celerity) is given by

Remark 2.1. We use here bo $=\mu \mathrm{Bo}$ instead of the classical Bond number, Bo, which measures the ratio of gravity forces over capillary forces. As we assume later on that bo is bounded from below, this amounts to the assumption $\mathrm{Bo}^{-1}=\mathcal{O}(\mu) .{ }^{2}$

We conclude by remarking that the system can be reduced into two evolution equations coupling Zakharov's canonical variables 16,43, namely (withdrawing the tildes for the sake of readability) the deformation of the free interface from its rest position, $\zeta$, and the trace of the dimensionless upper potential at the interface, $\psi$, defined as follows:

Let $\zeta \in H^{t_{0}+1}(\mathbb{R})$, $t_{0}>1 / 2$, such that there exists $h>0$ with $h_{1} \equiv 1-\epsilon \zeta \geq h>0$ and $h_{2} \equiv \frac{1}{\delta}+\epsilon \zeta \geq h>0$, and let $\psi \in L_{\mathrm{loc}}^{2}(\mathbb{R}), \partial_{x} \psi \in H^{1 / 2}(\mathbb{R})$. Then we define

where $\phi_{1}$ and $\phi_{2}$ are uniquely defined (up to a constant for $\phi_{2}$ ) as the solutions in $H^{2}(\mathbb{R})$ of the Laplace's problems (2.2)-(2.3).

The existence and uniqueness of a solution to $\sqrt{2.2}-(2.3)$, and therefore the well-posedness of the Dirichlet-Neumann operators follow from classical arguments detailed, for example, in 29].

Using the above definition, and after straightforward computations, one can rewrite the nondimensionalized version of (2.1) as a simple system of two coupled evolution equations, namely

We will refer to (2.4) as the full Euler system, and solutions of this system will be referred to as exact solutions of our problem.

## 3 Main results

We now present our new Green-Naghdi type model, that we fully justify as an asymptotic model for the full Euler system $(\sqrt[2.4]{ })$, for a set of dimensionless parameters limited to the so-called CamassaHolm regime, that we describe precisely below.

Let us introduce first the so-called shallow water regime for two layers of comparable depths:

with given $0 \leq \mu_{\max }, \delta_{\min }^{-1}, \delta_{\max }, \mathrm{bo}_{\min }^{-1}<\infty$. The two additional key restrictions for the validity of our model define the Camassa-Holm regime:

where $h_{1} \equiv 1-\epsilon \zeta$ (resp. $h_{2} \equiv \frac{1}{\delta}+\epsilon \zeta$ ) denotes the depth of the upper (resp. lower) fluid, and $\bar{v}$ is the shear mean velocity $3^{3}$ defined by

Our model is fully justified by the following results.
Theorem 3.1 (Consistency). For $\mathfrak{p}=(\mu, \epsilon, \delta, \gamma$, bo $) \in \mathcal{P}_{\mathrm{SW}}$, let $U^{\mathfrak{p}} \equiv\left(\zeta^{\mathfrak{p}}, \psi^{\mathfrak{p}}\right)$ be a family of solutions of the full Euler system (2.4) such that there exists $C_{0}, T>0$ with

For parameters in the Camassa-Holm regime 3.2 , our system is well-posed (in the sense of Hadamard) in the energy space $X^{s}=H^{s}(\mathbb{R}) \times H^{s+1}(\mathbb{R})$, endowed with the norm

Then there exists a maximal time $T_{\max }>0$ such that the system of equations (3.3) admits a unique strong solution $U=(\zeta, v)^{\top} \in$ $C^{0}\left(\left[0, T_{\max }\right) ; X^{s}\right) \cap C^{1}\left(\left[0, T_{\max }\right) ; X^{s-1}\right)$ with the initial value $\left.(\zeta, v)\right|_{t=0}=\left(\zeta_{0}, v_{0}\right)$ and preserving the conditions $(\overline{\mathrm{H} 1}),(\mathrm{H} 2)$ (with different lower bounds) for any $t \in\left[0, T_{\max }\right)$.

Moreover, there exists $T^{-1}, C_{0}, \lambda=C\left(M_{\mathrm{CH}}, h_{01}^{-1}, h_{02}^{-1},\left|U_{0}\right|_{X^{s}}\right)$, independent of $\mathfrak{p} \in \mathcal{P}_{\mathrm{CH}}$, such that $T_{\max } \geq T / \epsilon$ and one has the energy estimate

Let $(\mu, \epsilon, \delta, \gamma$, bo $) \in \mathcal{P}_{\mathrm{CH}}$ and $s \geq s_{0}+1$ with $s_{0}>1 / 2$, and assume $U_{0,1}=$ $\left(\zeta_{0,1}, v_{0,1}\right)^{\top} \in X^{s}$ and $U_{0,2}=\left(\zeta_{0,2}, v_{0,2}\right)^{\top} \in X^{s+1}$ satisfies (H1), H2). Denote $U_{j}$ the solution to (3.3) with $\left.U_{j}\right|_{t=0}=U_{0, j}$. Then there exists $T^{-1}, \lambda, C_{0}=C\left(M_{\mathrm{CH}}, h_{01}^{-1}, h_{02}^{-1},\left|U_{0,1}\right|_{X^{s}},\left|U_{0,2}\right|_{X^{s+1}}\right)$ such that

Finally, the following "convergence result" states that the solutions of our system approach the solutions of the full Euler system, with the accuracy predicted by Theorem 3.1.

Theorem 3.4 (Convergence). Let $\mathfrak{p} \equiv(\mu, \epsilon, \delta, \gamma$, bo $) \in \mathcal{P}_{\mathrm{CH}}$ and $s \geq s_{0}+1$ with $s_{0}>1 / 2$, and $U^{0} \equiv\left(\zeta^{0}, \psi^{0}\right)^{\top} \in H^{s+N}, N$ sufficiently large, satisfy the hypotheses of Theorem 5 in $31{ }^{4}$, as well as H1, (H2). Then there exists $C, T>0$, independent of $\mathfrak{p}$, such that

- There exists a unique solution $U \equiv(\zeta, \psi)^{\top}$ to the full Euler system 2.4, defined on $[0, T]$ and with initial data $\left(\zeta^{0}, \psi^{0}\right)^{\top}$ (provided by Theorem 5 in [31]);
- There exists a unique solution $U_{a} \equiv\left(\zeta_{a}, v_{a}\right)^{\top}$ to our new model (3.3), defined on $[0, T]$ and with initial data $\left(\zeta^{0}, v^{0}\right)^{\top}$ (provided by Theorem 3.2);
- With $\bar{v} \equiv \bar{v}[\zeta, \psi]$, defined as in 3.4, one has

Remark 3.5. The above proposition is valid for time interval $t \in[0, T / \epsilon]$ with $T$ bounded from below, independently of $\mathfrak{p} \in \mathcal{P}_{\mathrm{CH}}$, provided that a stronger criterion is satisfied by the initial data; see criterion (5.5) and Theorem 6 in [31].

Remark 3.6. We would like to emphasize here that, contrarily to the full Euler system, our model is well-posed even in the absence of surface tension (the only modification consists in setting $\mathrm{bo}^{-1}=0$ in the constants $\left.\nu, \kappa_{1}, \kappa_{2}, \varsigma\right)$. Thus the subtle regularizing effect of surface tension highlighted by Lannes in [31] does not play a role in our model. See Section 4.2, below, for a more detailed discussion.

We conclude this section by asserting that our new model allows to fully justify any well-posed asymptotic model, consistent with our model 3.3 in the Camassa-Holm regime.

Proposition 3.7. Consider (S) a system of equations such that

- The Cauchy problem for $(S)$ is well-posed in $X^{r}$, r sufficiently large.
- For $U^{0} \equiv\left(\zeta^{0}, v^{0}\right)^{\top} \in H^{s+N}, N$ sufficiently large, the solutions of ( $S$ ) satisfy our model (3.3), up to a remainder $R$ of size $\mathcal{O}(\iota)$ in $L^{\infty}\left([0, T] ; H^{s} \times H^{s}\right)$.

Then under the assumptions of Theorem 3.4, the difference between the solution of the full Euler system (2.4), $U \equiv(\zeta, \psi)^{\top}$, and the solution of the asymptotic model ( $S$ ) with corresponding initial data, $U_{a} \equiv\left(\zeta_{a}, v_{a}\right)^{\top}$, is estimated as follows:

This procedure of full justification is precisely described in section 8, and applied to the so-called Constantin-Lannes decoupled approximation model.

## 4 Construction of the model

This section is dedicated to the construction of the model we study. The key ingredient for constructing shallow water asymptotic models lies in the expansion of the Dirichlet-to-Neumann operators, with respect to the shallowness parameter, $\mu$; see Proposition 4.1, below. Thanks to such an expansion, one is able to obtain the so-called Green-Naghdi model (for internal waves), displayed in 4.6). This model has been introduced by one of the author in 20], and generalized in 21]. It is justified by a consistency result recalled in Proposition 4.2, roughly speaking, any solution of the full Euler system satisfies the Green-Naghdi asymptotic model up to a small remainder, of size $\mathcal{O}\left(\mu^{2}\right)$.

As we discuss in Section 4.2, the Green-Naghdi system 4.6) develops Kelvin-Helmholtz type instabilities at high frequencies (in absence of surface tension), which advise against any attempt towards the well-posedness of this system. These instabilities persist for the simplified model using the additional assumption of the Camassa-Holm regime, $\epsilon=\mathcal{O}(\sqrt{\mu})$, and withdrawing $\mathcal{O}\left(\mu \epsilon^{2}\right)$ terms. In Section 4.3, we use several additional transformations, similar to the well-known Benjamin-BonaMahony trick, in order to produce an equivalently precise (that is consistent of order $\mathcal{O}\left(\mu^{2}\right)$ in the Camassa-Holm regime) but well-prepared model. This model is system 4.15), and has been introduced previously as (3.3). The justification of this model, in the sense of consistency, is stated in Theorem 4.4. The stronger results (well-posedness, stability, convergence) described in Section 3 are proved in subsequent sections.

### 4.1 The Green-Naghdi model

The following Proposition is given in 20 (see also [21]), extending the result of 7 .
Proposition 4.1 (Expansion of the Dirichlet-Neumann operators). Set $s \geq s_{0}+1 / 2, s_{0}>1 / 2$. Let $\psi \in L_{\text {loc }}^{2}$ be such that $\partial_{x} \psi \in H^{s+11 / 2}(\mathbb{R})$, and $\zeta \in H^{s+9 / 2}(\mathbb{R})$. Let $h_{1}=1-\epsilon \zeta, h_{2}=1 / \delta+\epsilon \zeta$ be such that there exists $h>0$ with $h_{1}, h_{2} \geq h>0$. Then

\left|H^{\mu, \delta} \psi+\frac{h_{1}}{h_{2}} \partial_{x} \psi-\frac{\mu}{3 h_{2}} \partial_{x}\left(h_{2}^{3} \partial_{x}\left(\frac{h_{1}}{h_{2}} \partial_{x} \psi\right)-h_{1}^{3} \partial_{x}^{2} \psi\right)\right|_{H^{s}} & \leq \mu^{2} C_{2}, \tag{4.4}

with $C_{j}=C\left(\frac{1}{h}, \mu_{\max }, \frac{1}{\delta_{\min }}, \delta_{\max },|\zeta|_{H^{s+3 / 2+j}},\left|\partial_{x} \psi\right|_{H^{s+5 / 2+j}}\right)$. The estimates are uniform with respect to the parameters $\epsilon \in[0,1], \mu \in\left[0, \mu_{\max }\right], \delta \in\left(\delta_{\min }, \delta_{\max }\right)$.

Plugging these expansions into the full Euler system (2.4), and withdrawing $\mathcal{O}\left(\mu^{2}\right)$ terms, immediately yields an asymptotic Green-Naghdi model. This model is presented in 20 and justified in the sense of consistency. However, such a Green-Naghdi model is only one of the variety of models which satisfy such a property. In the following, we introduce an equivalent model, using as unknown (instead of $\psi$, the trace of the upper velocity potential at the interface) the shear mean velocity, defined by

where $\bar{u}_{1}, \bar{u}_{2}$ are the mean velocities integrated across the vertical layer in each fluid:

Equivalently (as shown in 20), one has

Such a choice has been used in 11,12 for example, and present at least two benefits. First, the equation describing the evolution of the deformation of the interface is an exact equation, and not a $\mathcal{O}\left(\mu^{2}\right)$ approximation. Indeed, one has immediately from the full Euler system 2.4):

What is more, the system obtained using mean velocities have a nicer behavior with respect to its linear well-posedness, thus one can expect nonlinear well-posedness only for the latter.

Altogether, several technical but straightforward computations yield the following Green-Naghdi model

This model has been derived in 20 and justified in the sense of consistency, as follows.

Remark 4.3. In 20], the author works with $\mathrm{bo}^{-1}=0$. However, it is clear that the results are still valid with the surface tension term, using

where we used Lemma A.4. Of course, one could have simply kept the surface tension term unchanged at this point, as in 21]. The smallness of surface tension, expressed by $\mathrm{bo}^{-1} \leq \mathrm{bo}_{\text {min }}^{-1}$, is useful in the derivation of our new model, in the following subsection.

### 4.2 Kelvin-Helmholtz instabilities

As discussed in the introduction, it is known that the bi-fluidic full Euler system is ill-posed in absence of surface tension, due to the so-called Kelvin-Helmholtz instabilities. In [31], Lannes shows that the Kelvin-Helmholtz instabilities appear only above a frequency threshold, so that the combined regularizing effects of gravity on the low-frequency component of the flow, and (small) surface tension on the high frequency component is sufficient to ensure the well-posedness on a time interval consistent with observations. A very rough and simplistic statement of his result is that the flow is stable provided that (using our notation)

As the Green-Naghdi model is derived in the shallow-water regime, it is expected to predict correctly the low-frequency component which describes the main part of the flow. On the contrary, we cannot expect that the evolution of the high-frequency component of the flow is correctly captured by the Green-Naghdi model. It is therefore interesting to verify whether the Green-Naghdi model is subject to Kelvin-Helmholtz instabilities, as described above.

As a matter of fact, the calculations below suggest that the Green-Naghdi model suffers from stronger instabilities than the full Euler model, in the sense that unstable growing modes appear unless

The phenomenon persists for the simplified model in the Camassa-Holm regime, with a non-physical condition on the depth ratio of the two layers, namely $\delta>1$.

On the contrary, we show that such growing modes our absent from our model (3.3), presented in Section 3 and constructed in Section 4.3 , below. This explains why we are able to show that our model is well-posed even in absence of surface tension.

Our formal discussion in this section is based on the explicit study of linearized systems around the solutions of constant shear: $(\zeta, \bar{v})=(0, \underline{v})$ where $\underline{v}$ is a constant. When plugging the Ansatz $(\zeta, \bar{v})=(0+\varkappa \tilde{\zeta}, \underline{v}+\varkappa \tilde{v})$ in system 4.6) and keeping only terms of size $\mathcal{O}(\varkappa)$, one obtains the following linear system in $(\tilde{\zeta}, \tilde{v})$ :

One obtains (calculations are tedious but straightforward and easily checked with a computer algebra system, thus we omit them) the following dispersion relation when solving for plane waves of the form $\tilde{\zeta}(t, x)=\hat{\zeta}(k, \omega) e^{i(k x-\omega t)}$ and $\tilde{v}=\hat{v}(k, \omega) e^{i(k x-\omega t)}$ :

One sees that if $K_{\mathrm{GN}}<0$, then the system has growing modes at high frequencies, that is negative imaginary part $\Im(\omega(k))<0$ for $|k|$ large. More precisely, if $K_{\mathrm{GN}}<0$, one has for $k$ sufficiently large,

The rate of growth of the unstable modes, namely $-\Im\left(\omega_{ \pm}(k)\right)$, is arbitrarily large in that case, thus one expects the nonlinear system to be strongly ill-posed.

Let us finally note that the criterion $K_{\mathrm{GN}}<0$ roughly states that $\epsilon^{2}$ bo should be sufficiently small. It is therefore similar to the criterion on the full Euler system, but is actually more restricting as $\epsilon<1$.

Recall now that the present work is limited to the so-called Camassa-Holm regime, that is using additional assumption $\epsilon=\mathcal{O}(\sqrt{\mu})$. It is therefore natural to look at the system obtained form the Green-Naghdi system (4.6) when withdrawing all terms of size $\mathcal{O}\left(\mu \epsilon^{2}\right)$. In particular, one can check that the following approximations formally hold:

Following the same method as above for this system yields the new dispersion relation $A_{\mathrm{GN}}(k) \omega^{2}+B_{\mathrm{GN}}(k) \omega+\tilde{C}_{\mathrm{GN}}(k)=0$, where only $\tilde{C}_{\mathrm{GN}}(k)$ has changed:

Thus we see that the strongly unstable modes do not appear if $\delta<1$, that is when the lower layer is thicker then the upper layer.

However, we show in the following that these instabilities never occur in our model, which is equivalent to the previous one in the sense of consistency and in the Camassa-Holm regime. Indeed, when linearizing system (3.3) introduced in Section 3 around the solution of constant shear, one obtains the following dispersion relation:

Notice however that the unstable modes when criterion 4.9) is not satisfied behave much differently from the above unstable modes of Kelvin-Helmholtz type. Indeed the growing modes when $K<0$ arise at low frequency, and the rate of growth satisfies

Thus the rate of growth is uniformly bounded, for all wavenumbers, by $\sqrt{-K \nu \mu^{-1}}$.
This is the reason why the criterion 4.9 does not appear in the results of Section 3 . Indeed, as the energy of the flow is initially bounded, in order to have $K<0$, one needs $\epsilon \gtrsim 1$. Since we are restricted to the Camassa-Holm regime, this yields $\sqrt{\mu} \gtrsim \epsilon \gtrsim 1$, and both the linearized study above and our nonlinear results of Section 3 predict a control of the energy of the solution up to time $T=\mathcal{O}(1)$. Furthermore, we indicate in Remark 6.1 that one could actually work without the Camassa-Holm assumption, $\epsilon=\mathcal{O}(\sqrt{\mu})$, by using another energy which, in order to be a convex entropy of the system, would ask for an additional assumption. This assumption reads

### 4.3 Our new model

In this section, we manipulate the Green-Naghdi system 4.6), systematically withdrawing $\mathcal{O}\left(\mu^{2}, \mu \epsilon^{2}\right)$ terms, in order to recover our model presented in 3.3. The first step is to introduce the following symmetric operator,

=-\mu \frac{\epsilon}{2 \mathrm{bo}} \frac{\delta^{2}-\gamma}{(\delta+\gamma)^{2}} \partial_{x}^{3}\left(|\bar{v}|^{2}\right)-\mu \epsilon \nu \kappa_{2} \partial_{x}\left(\zeta \partial_{x} \partial_{t} \bar{v}\right)+\mu \epsilon \underline{\nu} \kappa_{1} \zeta \partial_{x}^{2} \partial_{t} \bar{v}+\mu \epsilon \kappa_{1} \zeta \frac{\gamma+\delta}{\mathrm{bo}} \partial_{x}^{3} \zeta \\
\quad+\mu \epsilon \frac{\gamma+\delta}{3} \partial_{t}\left((\beta-\alpha) \bar{v} \partial_{x}^{2} \zeta+(\alpha+2 \beta) \partial_{x}\left(\zeta \partial_{x} \bar{v}\right)-\beta \zeta \partial_{x}^{2} \bar{v}\right)+\mathcal{O}\left(\mu^{2}, \mu \epsilon^{2}\right)
\end{aligned}

Use again that 4.6) yields $\partial_{t} \bar{v}=-(\gamma+\delta) \partial_{x} \zeta+\mathcal{O}(\epsilon, \mu)$ and $\partial_{t} \zeta=\frac{-1}{\gamma+\delta} \partial_{x} \bar{v}+\mathcal{O}(\epsilon, \mu)$, one obtains

&-\mu \epsilon \frac{(\gamma+\delta)^{2}}{3}\left((\beta-\alpha)\left(\partial_{x} \zeta\right)\left(\partial_{x}^{2} \zeta\right)+(\alpha+2 \beta) \partial_{x}\left(\zeta \partial_{x}^{2} \zeta\right)-\beta \zeta \partial_{x}^{3} \zeta\right) \\
& \quad-\mu \epsilon \frac{1}{3}\left((\beta-\alpha) \bar{v} \partial_{x}^{3} \bar{v}+(\alpha+2 \beta) \partial_{x}\left(\left(\partial_{x} \bar{v}\right)^{2}\right)-\beta\left(\partial_{x} \bar{v}\right)\left(\partial_{x}^{2} v\right)\right) \\
& \quad-\mu \epsilon \frac{1}{2 \mathrm{bo}} \frac{\delta^{2}-\gamma}{(\delta+\gamma)^{2}} \partial_{x}^{3}\left(|\bar{v}|^{2}\right)+\mathcal{O}\left(\mu^{2}, \mu \epsilon^{2}\right)

It becomes clear, now, that one can adjust $\kappa_{1}, \kappa_{2} \in \mathbb{R}$ so that all terms involving $\zeta$ and its derivatives are withdrawn. More specifically, we set $5^{5}$

However, one of the remaining terms in 4.12, as well as in $\partial_{x}\left(\overline{\mathcal{R}}\left[h_{1}, h_{2}\right] \bar{v}\right)$, involves three derivatives on $\bar{v}$. In order to deal with these terms, we introduce $\mathfrak{T}[\epsilon \zeta]\left(\epsilon \varsigma \bar{v} \partial_{x} \bar{v}\right)$ where, again, $\varsigma \in \mathbb{R}$ is to be determined. More precisely, one has

& =\epsilon \varsigma q_{1}(\epsilon \zeta) \bar{v} \partial_{x} \bar{v}-\mu \epsilon \nu \zeta \partial_{x}\left(q_{2}(\epsilon \zeta) \partial_{x}\left(\bar{v} \partial_{x} \bar{v}\right)\right)+\mu \epsilon q_{1}(\epsilon \zeta) \alpha \partial_{x}\left(\frac{1}{2}\left(\partial_{x} \bar{v}\right)^{2}+\frac{1}{3} \bar{v} \partial_{x}^{2} \bar{v}\right) .
\end{aligned}

Combining 4.12 with 4.13, one can check that if we set

When plugging this estimate in (4.6), and after multiplying the second equation by $q_{1}(\epsilon \zeta)$, we obtain the following system of equations:

\quad+\frac{\epsilon}{2} q_{1}(\epsilon \zeta) \partial_{x}\left(\frac{h_{1}^{2}-\gamma h_{2}^{2}}{\left(h_{1}+\gamma h_{2}\right)^{2}}|\bar{v}|^{2}-\varsigma|\bar{v}|^{2}\right)=-\mu \epsilon \frac{2}{3} \frac{1-\gamma}{(\gamma+\delta)^{2}} \partial_{x}\left(\left(\partial_{x} \bar{v}\right)^{2}\right)
\end{array}\right.

where we recall that

with $q_{i}(X) \equiv 1+\kappa_{i} X(i=1,2)$ and $\nu, \kappa_{1}, \kappa_{2}, \varsigma$ are defined by 4.10, 4.11) and 4.14).
System 4.15) has been introduced in Section 3, and is the system studied in the present work. We reproduce and prove below Theorem 3.1, which asserts the validity of 4.15) as an asymptotic model for the full Euler system in the sense of consistency.

Theorem 4.4. For $(\mu, \epsilon, \delta, \gamma, \mathrm{bo}) \equiv \mathfrak{p} \in \mathcal{P}_{\mathrm{SW}}$, let $U^{\mathfrak{p}} \equiv\left(\zeta^{\mathfrak{p}}, \psi^{\mathfrak{p}}\right)$ be a family of solutions of the full Euler system (2.4) such that such that there exists $C_{0}, T>0$ with

$$

for any $s \geq s_{0}+1 / 2, s_{0}>1 / 2$, and uniformly with respect to $\mathfrak{p} \in \mathcal{P}_{\text {SW }}$. Moreover, assume that there exists $h_{01}>0$ such that

with $C_{1}=C\left(M_{\mathrm{SW}}, h_{01}^{-1}, C_{0}\right)$, uniformly with respect to the parameters $\mathfrak{p} \in \mathcal{P}_{\mathrm{SW}}$.

Proof. Let $U \equiv(\zeta, \psi)$ satisfy the hypotheses of the Proposition (withdrawing the explicit dependence with respect to parameters $\mathfrak{p}$ for the sake of readability). As a consequence of Proposition 4.2, we know that $(\zeta, \bar{v})$ satisfies 4.6 , up to a remainder $R_{0}$, bounded by

$$

with $C_{1}=C\left(M_{\mathrm{SW}}, h_{01}^{-1}, C_{0}\right)$, uniformly with respect to $(\mu, \epsilon, \delta, \gamma, \mathrm{bo}) \in \mathcal{P}_{\mathrm{SW}}$. The proof now consists in checking that all terms neglected in the above calculations can be rigorously estimated in the same way.

The formal expansions can easily be checked. When turning to control the remainder terms in $H^{s}$ norm we make great use of classical product estimates in $H^{s}(\mathbb{R}), s \geq s_{0}+1 / 2$, recalled in Lemma A.1 A technical issue appears when such products involve terms as $\frac{1}{h_{1}}$, since $\frac{1}{h_{1}}$ is controlled in $L^{\infty}$ (thanks to the non-vanishing depth condition), but not in $H^{s}$ (as it does not decay at infinity). We detail in Lemmata A. 3 and A. 4 how such difficulty can be treated.

For the sake of brevity, we do not develop each estimate, but rather provide the precise bound on the various remainder terms. One has

\end{aligned}
$$

with $C(s+3) \equiv C\left(M_{\mathrm{CH}}, h_{01}^{-1},|\zeta|_{H^{s+3}},\left|\partial_{t} \zeta\right|_{H^{s+2}},|\bar{v}|_{H^{s+3}},\left|\partial_{t} \bar{v}\right|_{H^{s+2}}\right)$, and

\left|\partial_{x}\left(\overline{\mathcal{R}}\left[h_{1}, h_{2}\right] \bar{v}\right)-\partial_{x}\left[\alpha\left(\frac{1}{2}\left(\partial_{x} \bar{v}\right)^{2}+\frac{1}{3} \bar{v} \partial_{x}^{2} \bar{v}\right)\right]\right|_{H^{s}} \leq \epsilon C(s+3) .
$$

Then, since $(\zeta, \bar{v})$ satisfies 4.6), up to the remainder $R_{0}$, one has

It follows that (4.13) is valid up to a remainder $R_{1}$, bounded by

The estimate on $\bar{v}$ follows directly from the identity $\partial_{x}\left(\frac{h_{1} h_{2}}{h_{1}+\gamma h_{2}} \bar{v}\right)=-\frac{1}{\mu} G^{\mu, \epsilon} \psi=\partial_{t} \zeta$. The estimate on $\partial_{t} \bar{v}$ can be proved, for example, following [18, Prop. 2.12]. This concludes the proof of Theorem 4.4

## 5 Preliminary results

In this section, we study the operator $\mathfrak{T}[\epsilon \zeta]$, defined in 4.16) and recalled below:

\mathfrak{T}[\epsilon \zeta] V=\left(1+\epsilon \kappa_{1} \zeta\right) V-\mu \nu \partial_{x}\left(\left(1+\epsilon \kappa_{2} \zeta\right) \partial_{x} V\right) \tag{5.1}
\end{equation*}
$$

with $\nu, \kappa_{1}, \kappa_{2}$ are constants. In our setting, $\nu, \kappa_{1}, \kappa_{2}$ depend on the parameters $\gamma, \delta$, bo; but in what follows, we use only that the restrictions of the Camassa-Holm regime ensures that $\nu>0$ is bounded from below (by hypothesis):

$$
\nu \equiv \frac{1+\gamma \delta}{3 \delta(\gamma+\delta)}-\frac{1}{\text { bo }} \geq \nu_{0}>0
$$

and $\nu+\left|\kappa_{1}\right|+\left|\kappa_{2}\right|$ is bounded from above, uniformly with respect to any choice of parameters $\mathfrak{p} \equiv(\mu, \epsilon, \delta, \gamma$, bo $) \in \mathcal{P}_{\mathrm{CH}}($ see 3.2$)$.

When no confusion is possible, we write simply $\mathfrak{T} \equiv \mathfrak{T}[\epsilon \zeta]$. In the following, we seek sufficient conditions to ensure the strong ellipticity of the operator $\mathfrak{T}$ which will yield to the well-posedness and continuity of the inverse $\mathfrak{T}^{-1}$.

As a matter of fact, this condition, namely ( H 2 ) (and similarly the classical non-zero depth condition, (H1) simply consists in assuming that the deformation of the interface is not too large. For fixed $\zeta \in L^{\infty}$, the restriction reduces to an estimate on $\epsilon_{\max }|\zeta|_{L^{\infty}}$, with $\epsilon_{\max }=\min \left(M \sqrt{\mu_{\max }}, 1\right)$, and (H1)- H 2 hold uniformly with respect to $(\mu, \epsilon, \delta, \gamma$, bo $) \in \mathcal{P}_{\mathrm{CH}}$; see Lemma 5.1, below.

Let us shortly detail the argument. Recall the non-zero depth condition

where $h_{1} \equiv 1-\epsilon \zeta$ and $h_{2} \equiv \frac{1}{\delta}+\epsilon \zeta$ are the depth of, respectively, the upper and the lower layer of fluid. It is straightforward to check that, since for all $\mathfrak{p} \in \mathcal{P}_{\mathrm{CH}}$, the following condition

\epsilon_{\max }|\zeta|_{L^{\infty}}<\min \left(1, \frac{1}{\delta_{\max }}\right)
$$

is sufficient to define $h_{01}>0$ such that (H1) is valid, independently of $\mathfrak{p} \in \mathcal{P}_{\mathrm{CH}}$. Briefly, since $\epsilon \leq \epsilon_{\max }$, one has $\inf _{x \in \mathbb{R}} h_{1} \geq 1-\epsilon|\zeta|_{L^{\infty}} \geq 1-\epsilon_{\max }|\zeta|_{L^{\infty}}$ and similarly $\inf _{x \in \mathbb{R}} h_{2} \geq \frac{1}{\delta}-\epsilon|\zeta|_{L^{\infty}} \geq$ $\frac{1}{\delta}-\epsilon_{\max }|\zeta|_{L^{\infty}}$. Note that conversely, for (H1) to be satisfied for any $\mathfrak{p} \in \mathcal{P}_{\mathrm{CH}}$, then one needs

\epsilon_{\max }|\zeta|_{L^{\infty}} \leq \max \left(1, \frac{1}{\delta_{\min }}\right)
$$

Indeed, with $\epsilon=\epsilon_{\max }, \epsilon_{\max } \zeta=1-h_{1} \leq 1-h_{01}$ and $-\epsilon_{\max } \zeta=\frac{1}{\delta}-h_{2} \leq \frac{1}{\delta}-h_{01}$.
In the same way, we introduce the condition

\exists h_{02}>0, \text { such that } \quad \inf _{x \in \mathbb{R}}\left(1+\epsilon \kappa_{2} \zeta\right) \geq h_{02}>0 ; \quad \inf _{x \in \mathbb{R}}\left(1+\epsilon \kappa_{1} \zeta\right) \geq h_{02}>0 \tag{H2}
\end{equation*}
$$

As above, such a condition is a consequence of a smallness assumption on $\epsilon|\zeta|_{L^{\infty}}$.
Lemma 5.1. Let $\zeta \in L^{\infty}$ and $\epsilon_{\max }=\min \left(M \sqrt{\mu_{\max }}, 1\right)$ be such that

\exists h_{0}>0, \text { such that } \quad \max \left(\left|\kappa_{1}\right|,\left|\kappa_{2}\right|, 1, \delta_{\max }\right) \epsilon_{\max }|\zeta|_{L^{\infty}} \leq 1-h_{0}<1

Then there exists $h_{01}, h_{02}>0$ such that (H1)-H2 hold for any $(\mu, \epsilon, \delta, \gamma$, bo $) \in \mathcal{P}_{\mathrm{CH}}$.
In what follows, we will always assume that (H1) and (H2) are satisfied. It is a consequence of our work that such assumption may be imposed only on the initial data, and then is automatically satisfied over the relevant time scale.

Before asserting the strong ellipticity of the operator $\mathfrak{T}$, let us first recall the quantity $|\cdot|_{H_{\mu}^{1}}$, which is defined as

\forall v \in H^{1}(\mathbb{R}), \quad|v|_{H_{\mu}^{1}}^{2}=|v|_{L^{2}}^{2}+\mu\left|\partial_{x} v\right|_{L^{2}}^{2}

and is equivalent to the $H^{1}(\mathbb{R})$-norm but not uniformly with respect to $\mu$. We define by $H_{\mu}^{1}(\mathbb{R})$ the space $H^{1}(\mathbb{R})$ endowed with this norm.

Lemma 5.2. Let $(\mu, \epsilon, \delta, \gamma$, bo $) \in \mathcal{P}_{\mathrm{CH}}$ and $\zeta \in L^{\infty}(\mathbb{R})$ such that (H2) is satisfied. Then the operator

is uniformly continuous and coercive. More precisely, there exists $c_{0}>0$ such that

$$
\begin{align*}
(\mathfrak{T} u, v) & \leq c_{0}|u|_{H_{\mu}^{1}}|v|_{H_{\mu}^{1}}  \tag{5.2}\\
(\mathfrak{T} u, u) & \geq \frac{1}{c_{0}}|u|_{H_{\mu}^{1}}^{2} \tag{5.3}
\end{align*}
$$

with $c_{0}=C\left(M_{\mathrm{CH}}, h_{02}^{-1}, \epsilon|\zeta|_{L^{\infty}}\right)$.
Moreover, the following estimates hold:
(i) Let $s_{0}>\frac{1}{2}$ and $s \geq 0$. If $\zeta \in H^{s_{0}}(\mathbb{R}) \cap H^{s}(\mathbb{R})$ and $u \in H^{s+1}(\mathbb{R})$ and $v \in H^{1}(\mathbb{R})$, then:

$$
\begin{equation*}
\left.\left|\left(\Lambda^{s} \mathfrak{T}[\epsilon \zeta] u, v\right)\right| \leq C_{0}\left(\left(1+\epsilon|\zeta|_{H^{s_{0}}}\right)|u|_{H_{\mu}^{s+1}}+\left.\langle\epsilon| \zeta\right|_{H^{s}}|u|_{H_{\mu}^{s_{0}+1}}\right\rangle_{s>s_{0}}\right)|v|_{H_{\mu}^{1}} \tag{5.4}
\end{equation*}
$$

(ii) Let $s_{0}>\frac{1}{2}$ and $s \geq 0$. If $\zeta \in H^{s_{0}+1} \cap H^{s}(\mathbb{R})$, $u \in H^{s}(\mathbb{R})$ and $v \in H^{1}(\mathbb{R})$, then:

$$
\begin{equation*}
\left.\left|\left(\left[\Lambda^{s}, \mathfrak{T}[\epsilon \zeta]\right] u, v\right)\right| \leq \epsilon C_{0}\left(|\zeta|_{H^{s_{0}+1}}|u|_{H_{\mu}^{s}}+\left.\langle | \zeta\right|_{H^{s}}|u|_{H_{\mu}^{s_{0}+1}}\right\rangle_{s>s_{0}+1}\right)|v|_{H_{\mu}^{1}} \tag{5.5}
\end{equation*}
$$

where $C_{0}=C\left(M_{\mathrm{CH}}, h_{02}^{-1}\right)$.
Proof. Let us define the bilinear form

$$
a(u, v)=(\mathfrak{T} u, v)=\left(\left(1+\epsilon \kappa_{1} \zeta\right) u, v\right)+\nu \mu\left(\left(1+\epsilon \kappa_{2} \zeta\right) \partial_{x} u, \partial_{x} v\right)
$$

where $(\cdot, \cdot)$ denotes the $L^{2}$-based inner product. It is straightforward to check that

$$
|a(u, v)| \leq \sup _{x \in \mathbb{R}}\left|1+\epsilon \kappa_{1} \zeta\right|(u, v)+\mu \nu \sup _{x \in \mathbb{R}}\left|1+\epsilon \kappa_{2} \zeta\right|\left(\partial_{x} u, \partial_{x} v\right)
$$

so that (5.2) is now straightforward, by Cauchy-Schwarz inequality.
The $H_{\mu}^{1}(\mathbb{R})$-coercivity of $a(\cdot, \cdot)$, i.e. (5.3), is a consequence of condition (H2):

\begin{aligned}
a(u, u)=(\mathfrak{T} u, u) & =\int_{\mathbb{R}}\left(1+\epsilon \kappa_{1} \zeta\right)|u|^{2} d x+\nu \mu \int_{\mathbb{R}}\left(1+\epsilon \kappa_{2} \zeta\right)\left|u_{x}\right|^{2} d x \\
& \geq h_{02} \min \left(1, \nu_{0}\right)|u|_{H_{\mu}^{1}}^{2}
\end{aligned}
$$

Let us now prove the higher-order estimates of the Lemma, starting with the product estimates. One has

$$
\left(\Lambda^{s} \mathfrak{T} u, v\right)=\left(\Lambda^{s}\left\{\left(1+\epsilon \kappa_{1} \zeta\right) u\right\}, v\right)+\nu \mu\left(\Lambda^{s}\left\{\left(1+\epsilon \kappa_{2} \zeta\right) \partial_{x} u\right\}, \partial_{x} v\right)
$$

Estimate (5.4) is now a straightforward consequence of Cauchy-Schwarz inequality, and Lemma A.1. As for the commutator estimates, one uses

$$
\left(\left[\Lambda^{s}, \mathfrak{T}\right] u, v\right)=\epsilon \kappa_{1}\left(\left[\Lambda^{s}, \zeta\right] u, v\right)+\nu \mu \epsilon \kappa_{2}\left(\left[\Lambda^{s}, \zeta\right] \partial_{x} u, \partial_{x} v\right)
$$

Estimates (5.5) follow, using again Cauchy-Schwarz inequality, and Lemma A. 2 .
The following lemma offers an important invertibility result on $\mathfrak{T}$.
Lemma 5.3. Let $(\mu, \epsilon, \delta, \gamma$, bo $) \in \mathcal{P}_{\mathrm{CH}}$ and $\zeta \in L^{\infty}(\mathbb{R})$ such that H 2 is satisfied. Then the operator

$$
\mathfrak{T}[\epsilon \zeta]: H^{2}(\mathbb{R}) \longrightarrow L^{2}(\mathbb{R})
$$

is one-to-one and onto. Moreover, one has the following estimates:
(i) $(\mathfrak{T}[\epsilon \zeta])^{-1}: L^{2} \rightarrow H_{\mu}^{1}(\mathbb{R})$ is continuous. More precisely, one has

$$
\left\|\mathfrak{T}^{-1}\right\|_{L^{2}(\mathbb{R}) \rightarrow H_{\mu}^{1}(\mathbb{R})} \leq c_{0}
$$

with $c_{0}=C\left(M_{\mathrm{CH}}, h_{02}^{-1}, \epsilon|\zeta|_{L^{\infty}}\right)$.
(ii) Additionally, if $\zeta \in H^{s_{0}+1}(\mathbb{R})$ with $s_{0}>\frac{1}{2}$, then one has for any $0<s \leq s_{0}+1$,

$$
\left\|\mathfrak{T}^{-1}\right\|_{H^{s}(\mathbb{R}) \rightarrow H_{\mu}^{s+1}(\mathbb{R})} \leq c_{s_{0}+1} .
$$

(iii) If $\zeta \in H^{s}(\mathbb{R})$ with $s \geq s_{0}+1, s_{0}>\frac{1}{2}$, then one has

$$
\left\|\mathfrak{T}^{-1}\right\|_{H^{s}(\mathbb{R}) \rightarrow H_{\mu}^{s+1}(\mathbb{R})} \leq c_{s}
$$

where $c_{\bar{s}}=C\left(M_{\mathrm{CH}}, h_{02}^{-1}, \epsilon|\zeta|_{H^{\bar{s}}}\right)$, thus uniform with respect to $(\mu, \epsilon, \delta, \gamma, \mathrm{bo}) \in \mathcal{P}_{\mathrm{CH}}$.
Proof. To show the invertibility of $\mathfrak{T}$ we use the Lax-Milgram theorem. From the previous Lemma, we know that the bilinear form:

$$
a(u, v)=(\mathfrak{T} u, v)=\left(\left(1+\epsilon \kappa_{1} \zeta\right) u, v\right)+\mu \nu\left(\left(1+\epsilon \kappa_{2} \zeta\right) \partial_{x} u, \partial_{x} v\right)
$$

is continuous and uniformly coercive on $H_{\mu}^{1}(\mathbb{R})$. For any $\mu>0$, the dual of $H_{\mu}^{1}(\mathbb{R})$ is $H^{-1}(\mathbb{R})$, of whom $L^{2}(\mathbb{R})$ is a subspace, and one has $(f, g) \leq|f|_{H_{\mu}^{1}}|g|_{L^{2}}$, independently of $\mu>0$. Therefore, using Lax-Milgram lemma, for all $f \in L^{2}(\mathbb{R})$, there exists a unique $u \in H_{\mu}^{1}(\mathbb{R})$ such that, for all $v \in H_{\mu}^{1}(\mathbb{R})$

$$
a(u, v)=(f, v) ;
$$

equivalently, there is a unique variational solution to the equation

$$
\begin{equation*}
\mathfrak{T} u=f \tag{5.6}
\end{equation*}
$$

We then get from the definition of $\mathfrak{T}$ that

$$
\begin{equation*}
\nu \mu\left(1+\epsilon \kappa_{2} \zeta\right) \partial_{x}^{2} u=\left(1+\epsilon \kappa_{1} \zeta\right) u-\mu \epsilon \nu \kappa_{2}\left(\partial_{x} \zeta\right)\left(\partial_{x} u\right)-f \tag{5.7}
\end{equation*}
$$

Now, using condition (H2), and since $u \in H^{1}(\mathbb{R}), \zeta \in L^{\infty}(\mathbb{R})$ and $f \in L^{2}(\mathbb{R})$, we deduce that $\partial_{x}^{2} u \in L^{2}(\mathbb{R})$, and thus $u \in H^{2}(\mathbb{R})$. We proved $\mathfrak{T}[\epsilon \zeta]: H^{2}(\mathbb{R}) \longrightarrow L^{2}(\mathbb{R})$ is one-to-one and onto.

Let us now turn to the proof of estimates in $(i)-(i i i)$.
We start from the equality $a(u, u)=(f, u)$. Using elliptic inequality (5.3) and Cauchy-Schwarz inequality, one has

$$
\frac{1}{c_{0}}|u|_{H_{\mu}^{1}}^{2} \leq a(u, u)=(f, u) \leq|f|_{L^{2}}|u|_{L^{2}} \leq|f|_{L^{2}}|u|_{H_{\mu}^{1}}
$$

Dividing by $c_{0}^{-1}|u|_{H_{\mu}^{1}}$ yields the estimate in (i).
Let us now assume that $f \in H^{s}(\mathbb{R})$, for $s \geq 0$. We apply $\Lambda^{s}$ to equation 5.6) and we write it under the form:

$$
\mathfrak{T}\left(\Lambda^{s} u\right)=\Lambda^{s} f-\left[\Lambda^{s}, \mathfrak{T}\right] u
$$

Proceeding as above, we use the $L^{2}$ inner product with $\Lambda^{s} u$, and deduce

$$
\begin{align*}
\frac{1}{c_{0}}\left|\Lambda^{s} u\right|_{H_{\mu}^{1}}^{2} & \leq a\left(\Lambda^{s} u, \Lambda^{s} u\right)=\left(\mathfrak{T} \Lambda^{s} u, \Lambda^{s} u\right)=\left(\Lambda^{s} f-\left[\Lambda^{s}, \mathfrak{T}\right] u, \Lambda^{s} u\right) \\
& \leq\left|\Lambda^{s} f\right|_{L^{2}}\left|\Lambda^{s} u\right|_{L^{2}}+\left|\left(\left[\Lambda^{s}, \mathfrak{T}\right] u, \Lambda^{s} u\right)\right| \tag{5.8}
\end{align*}
$$

The result is now a consequence of 5.5 .

- If $0 \leq s \leq s_{0}+1$, one has

$$
\frac{1}{c_{0}}|u|_{H_{\mu}^{s+1}}^{2} \leq|f|_{H^{s}}|u|_{H^{s}}+\epsilon C_{0}|\zeta|_{H^{s_{0}+1}}|u|_{H_{\mu}^{s}}|u|_{H_{\mu}^{s+1}},
$$

thus

$$
|u|_{H_{\mu}^{s+1}} \leq c_{0}\left(|f|_{H^{s}}+\epsilon C_{0}|\zeta|_{H^{s_{0}+1}}|u|_{H_{\mu}^{s}}\right) .
$$

The estimate of (ii) for $0<s \leq 1$ follows, using estimate (i) and $\left|\Lambda^{s-1} u\right|_{H_{\mu}^{1}} \leq|u|_{H_{\mu}^{1}}$. The result for greater values of $s, 1<s \leq s_{0}+1$, follows by continuous induction.

- If $s>s_{0}+1$, then plugging (5.5) into (5.8) yields

$$
\frac{1}{c_{0}}|u|_{H_{\mu}^{s+1}}^{2} \leq|f|_{H^{s}}|u|_{H^{s}}+\epsilon C_{0}\left(|\zeta|_{H^{s_{0}+1}}|u|_{H_{\mu}^{s}}+|\zeta|_{H^{s}}|u|_{H_{\mu}^{s_{0}+1}}\right)|u|_{H_{\mu}^{s+1}}
$$

thus

$$
|u|_{H_{\mu}^{s+1}} \leq c_{0}\left(|f|_{H^{s}}+\epsilon C_{0}\left(|\zeta|_{H^{s_{0}+1}}|u|_{H_{\mu}^{s}}+|\zeta|_{H^{s}}|u|_{H_{\mu}^{s_{0}+1}}\right)\right)
$$

As above, the result follows by continuous induction on $s$.

Finally, let us introduce the following technical estimate, which is used several times in the subsequent sections.

Corollary 5.4. Let $(\mu, \epsilon, \delta, \gamma$, bo $) \in \mathcal{P}_{\mathrm{CH}}$ and $\zeta \in H^{s}(\mathbb{R})$ with $s \geq s_{0}+1, s_{0}>\frac{1}{2}$, such that H2 is satisfied. Assume moreover that $u \in H^{s-1}(\mathbb{R})$ and that $v \in H^{1}(\mathbb{R})$. Then one has

$$
\begin{align*}
\left|\left(\left[\Lambda^{s}, \mathfrak{T}^{-1}[\epsilon \zeta]\right] u, \mathfrak{T}[\epsilon \zeta] v\right)\right| & =\left|\left(\left[\Lambda^{s}, \mathfrak{T}[\epsilon \zeta]\right] \mathfrak{T}^{-1}[\epsilon \zeta] u, v\right)\right| \\
& \leq \epsilon C\left(M_{\mathrm{CH}}, h_{02}^{-1},|\zeta|_{H^{s}}\right)|u|_{H^{s-1}}|v|_{H_{\mu}^{1}} \tag{5.9}
\end{align*}
$$

Proof. The first identity can be obtained through simple calculation: using that $\mathfrak{T}[\epsilon \zeta]$ is symmetric,

$$
\begin{aligned}
\left(\left[\Lambda^{s}, \mathfrak{T}^{-1}[\epsilon \zeta]\right] u, \mathfrak{T}[\epsilon \zeta] v\right) & =\left(\mathfrak{T}[\epsilon \zeta]\left[\Lambda^{s}, \mathfrak{T}^{-1}[\epsilon \zeta]\right] u, v\right) \\
& =\left(\mathfrak{T}[\epsilon \zeta] \Lambda^{s} \mathfrak{T}^{-1}[\epsilon \zeta] u-\Lambda^{s} u, v\right) \\
& =\left(-\left[\Lambda^{s}, \mathfrak{T}[\epsilon \zeta]\right] \mathfrak{T}^{-1}[\epsilon \zeta] u, v\right) .
\end{aligned}
$$

The estimate is now a direct application of (5.5) and Lemma 5.3. From point (ii) and (iii) of Lemma 5.3, one has

$$
\left|\mathfrak{T}^{-1}[\epsilon \zeta] u\right|_{H_{\mu}^{s}} \leq C|u|_{H^{s-1}},
$$

with $C=C\left(M_{\mathrm{CH}}, h_{02}^{-1}, \epsilon|\zeta|_{H^{s-1}}, \epsilon|\zeta|_{H^{s_{0}+1}}\right)$. Now apply commutator estimate (5.5), and one obtains straightforwardly our desired estimate.

## 6 Linear analysis

Let us recall the system 4.15 introduced in section 4.3 .

$$
\left\{\begin{array}{l}
\partial_{t} \zeta+\partial_{x}\left(\frac{h_{1} h_{2}}{h_{1}+\gamma h_{2}} \bar{v}\right)=0  \tag{6.1}\\
\mathfrak{T}[\epsilon \zeta]\left(\partial_{t} \bar{v}+\epsilon \varsigma \bar{v} \partial_{x} \bar{v}\right)+(\gamma+\delta) q_{1}(\epsilon \zeta) \partial_{x} \zeta \\
\quad+\frac{\epsilon}{2} q_{1}(\epsilon \zeta) \partial_{x}\left(\frac{h_{1}^{2}-\gamma h_{2}^{2}}{\left(h_{1}+\gamma h_{2}\right)^{2}}|\bar{v}|^{2}-\varsigma|\bar{v}|^{2}\right)=-\mu \epsilon \frac{2}{3} \frac{1-\gamma}{(\gamma+\delta)^{2}} \partial_{x}\left(\left(\partial_{x} \bar{v}\right)^{2}\right)
\end{array}\right.
$$

with $h_{1}=1-\epsilon \zeta, h_{2}=1 / \delta+\epsilon \zeta q_{i}(X)=1+\kappa_{i} X(i=1,2), \kappa_{i}, \varsigma$ defined in 4.11), 4.14), and

$$
\mathfrak{T}[\epsilon \zeta] V=q_{1}(\epsilon \zeta) V-\mu \nu \partial_{x}\left(q_{2}(\epsilon \zeta) \partial_{x} V\right)
$$

In order to ease the reading, we define the function

$$
f: X \rightarrow \frac{(1-X)\left(\delta^{-1}+X\right)}{1-X+\gamma\left(\delta^{-1}+X\right)}
$$

One can easily check that

$$
f(\epsilon \zeta)=\frac{h_{1} h_{2}}{h_{1}+\gamma h_{2}}, \quad \text { and } \quad f^{\prime}(\epsilon \zeta)=\frac{h_{1}^{2}-\gamma h_{2}^{2}}{\left(h_{1}+\gamma h_{2}\right)^{2}}
$$

Additionally, let us denote

$$
\kappa=\frac{2}{3} \frac{1-\gamma}{(\delta+\gamma)^{2}} \quad \text { and } \quad q_{3}(\epsilon \zeta)=\frac{1}{2}\left(\frac{h_{1}^{2}-\gamma h_{2}^{2}}{\left(h_{1}+\gamma h_{2}\right)^{2}}-\varsigma\right),
$$

so that one can rewrite (here and in the following, we omit the bar on $v$ for the sake of readability)

$$
\left\{\begin{array}{l}
\partial_{t} \zeta+f(\epsilon \zeta) \partial_{x} v+\epsilon \partial_{x} \zeta f^{\prime}(\epsilon \zeta) v=0  \tag{6.2}\\
\mathfrak{T}\left(\partial_{t} v+\frac{\epsilon}{2} \varsigma \partial_{x}\left(v^{2}\right)\right)+(\gamma+\delta) q_{1}(\epsilon \zeta) \partial_{x} \zeta+\epsilon q_{1}(\epsilon \zeta) \partial_{x}\left(q_{3}(\epsilon \zeta) v^{2}\right)+\mu \epsilon \kappa \partial_{x}\left(\left(\partial_{x} v\right)^{2}\right)=0
\end{array}\right.
$$

The equations can be written after applying $\mathfrak{T}^{-1}$ to the second equation in (6.2) as

$$
\begin{equation*}
\partial_{t} U+A_{0}[U] \partial_{x} U+A_{1}[U] \partial_{x} U=0 \tag{6.3}
\end{equation*}
$$

with

$$
A_{0}[U]=\left(\begin{array}{cc}
\epsilon f^{\prime}(\epsilon \zeta) v & f(\epsilon \zeta)  \tag{6.4}\\
\mathfrak{T}^{-1}\left(Q_{0}(\epsilon \zeta) \cdot\right) & \epsilon \mathfrak{T}^{-1}(\mathfrak{Q}[\epsilon \zeta, v] \cdot)
\end{array}\right), \quad A_{1}[U]=\left(\begin{array}{cc}
0 & 0 \\
\epsilon^{2} \mathfrak{T}^{-1}\left(Q_{1}(\epsilon \zeta, v) \cdot\right) & \epsilon \varsigma v
\end{array}\right)
$$

where $Q_{0}(\epsilon \zeta), Q_{1}(\epsilon \zeta, v)$ are defined as

$$
\begin{equation*}
Q_{0}(\epsilon \zeta)=(\gamma+\delta) q_{1}(\epsilon \zeta), \quad Q_{1}(\epsilon \zeta, v)=q_{1}(\epsilon \zeta) q_{3}^{\prime}(\epsilon \zeta) v^{2} \tag{6.5}
\end{equation*}
$$

and the operator $\mathfrak{Q}[\epsilon \zeta, v]$ defined by

$$
\begin{equation*}
\mathfrak{Q}[\epsilon \zeta, v] f \equiv 2 q_{1}(\epsilon \zeta) q_{3}(\epsilon \zeta) v f+\mu \kappa \partial_{x}\left(f \partial_{x} v\right) \tag{6.6}
\end{equation*}
$$

Following the classical theory of hyperbolic systems, the well-posedness of the initial value problem of the above system will rely on a precise study of the properties, and in particular energy estimates, for the linearized system around some reference state $\underline{U}=(\underline{\zeta}, \underline{v})^{\top}$ :

$$
\left\{\begin{array}{l}
\partial_{t} U+A_{0}[\underline{U}] \partial_{x} U+A_{1}[\underline{U}] \partial_{x} U=0  \tag{6.7}\\
U_{\left.\right|_{t=0}}=U_{0}
\end{array}\right.
$$

In the following subsection, we construct the natural energy space for our problem. Energy estimates are then proved in section 6.2. Finally, we state the well-posedness of the linear system (6.7) in section 6.3 .

### 6.1 Energy space

Let us first remark that by construction, one has a pseudo-symmetrizer of the system, given by

S[\underline{U}]=\left(\begin{array}{cc}
\frac{Q_{0}(\epsilon \underline{\zeta})}{f(\epsilon \underline{\zeta})} & 0  \tag{6.8}\\
0 & \mathfrak{T}[\epsilon \underline{\zeta}]
\end{array}\right), \quad S[\underline{U}] A_{0}[\underline{U}]=\left(\begin{array}{cc}
\epsilon \frac{Q_{0}(\epsilon \underline{\zeta})}{f(\epsilon \underline{\zeta})} f^{\prime}(\epsilon \underline{\zeta}) \underline{v} & Q_{0}(\epsilon \underline{\zeta}) \\
Q_{0}(\epsilon \underline{\zeta}) & \epsilon \mathfrak{Q}[\epsilon \underline{\zeta}, \underline{v}]
\end{array}\right)
$$

Notice that $S[\underline{U}]$ is symmetric, as $\mathfrak{T}[\epsilon \underline{\zeta}]$ is symmetric, and one can easily check that $S[\underline{U}] A_{0}[\underline{U}]$ is symmetric as well. On the contrary, the operator

$$
S[\underline{U}] A_{1}[\underline{U}]=\left(\begin{array}{cc}
0 & 0 \\
\epsilon^{2} Q_{1}(\epsilon \underline{\zeta}, \underline{v}) & \epsilon \varsigma \mathfrak{T}[\epsilon \underline{\zeta}](\underline{v} \cdot)
\end{array}\right)
$$

represents the defect of symmetry.
However, $\mathfrak{T}[\epsilon \underline{\zeta}](\underline{v} \cdot)$ has the desired following property:

$$
\begin{align*}
\left(\mathfrak{T}[\epsilon \underline{\zeta}]\left(\underline{v} \partial_{x} V\right), V\right) & =\left(q_{1}(\epsilon \underline{\zeta}) \underline{v} \partial_{x} V-\mu \nu \partial_{x}\left(q_{2}(\epsilon \underline{\zeta}) \partial_{x}\left(\underline{v} \partial_{x} V\right)\right), V\right) \\
& =-\frac{1}{2}\left(\partial_{x}\left(q_{1}(\epsilon \underline{\zeta}) \underline{v}\right) V, V\right)+\mu \nu\left(q_{2}(\epsilon \underline{\zeta}) \partial_{x}\left(\underline{v} \partial_{x} V\right), \partial_{x} V\right) \\
& =-\frac{1}{2}\left(\partial_{x}\left(q_{1}(\epsilon \underline{\zeta}) \underline{v}\right) V, V\right)+\mu \nu\left(q_{2}(\epsilon \underline{\zeta})\left(\partial_{x} \underline{v}\right) \partial_{x} V, \partial_{x} V\right)-\frac{\mu \nu}{2}\left(\partial_{x}\left(q_{2}(\epsilon \underline{\zeta}) \underline{v}\right) \partial_{x} V, \partial_{x} V\right) . \tag{6.9}
\end{align*}
$$

Therefore, the inner product $\left(\mathfrak{T}[\epsilon \underline{\zeta}]\left(\underline{v} \partial_{x} V\right), V\right)$ is controlled by $|V|_{H_{\mu}^{1}}^{2}$, bounded in our energy space, as defined below. In the same way, one can control the contribution of $\epsilon^{2} Q_{1}(\epsilon \underline{\zeta}, \underline{v})$, using the smallness of $\epsilon$ through the assumption of the Camassa-Holm regime $\epsilon=\mathcal{O}(\sqrt{\mu})$.

Remark 6.1. In the analysis below, the only place where the smallness assumption of the CamassaHolm regime, $\epsilon=\mathcal{O}(\sqrt{\mu})$, is used (apart from the simplifications it offers when constructing system (6.1)), stands in the estimation of the contribution of $\epsilon^{2} Q_{1}(\epsilon \underline{\zeta}, \underline{v})$. As a matter of fact, this assumption is actually not required: one could replace $Q_{0}(\epsilon \underline{\zeta})$ by $Q_{0}(\epsilon \underline{\zeta})+\epsilon^{2} Q_{1}(\epsilon \underline{\zeta}, \underline{v})$ in the pseudosymmetrizer $S[\underline{U}]$, thus canceling out the $\epsilon^{2} Q_{1}(\epsilon \underline{\zeta}, \underline{v})$ term. Note however that the energy would then be slightly different than the one defined below, and that for Lemma 6.3 to hold, one needs an additional smallness assumption on $\epsilon \underline{v}$, in order to ensure $Q_{0}(\epsilon \underline{\zeta})+\epsilon^{2} Q_{1}(\epsilon \underline{\zeta}, \underline{v}) \geq h_{03}>0$.

Let us now define our energy space.
Definition 6.2. For given $s \geq 0$ and $\mu, T>0$, we denote by $X^{s}$ the vector space $H^{s}(\mathbb{R}) \times H^{s+1}(\mathbb{R})$ endowed with the norm

& \leq C\left(\epsilon\left|\zeta_{u}\right|_{H^{s}}\right)\left|\zeta_{v}\right|_{H^{s-1}}\left|\zeta_{w}\right|_{L^{2}}
\end{aligned}

where we used Lemma A. 1 and continuous Sobolev embedding for the last inequality.
The second term is estimated using Lemma 5.2, (5.5):

The first term is estimated exactly as above, noticing that both $f\left(\epsilon \zeta_{u}\right)$ and $Q_{0}\left(\epsilon \zeta_{u}\right)$ are bounded from above and below since (H1) and (H2) are satisfied.

The second term is estimated using Corollary 5.4 (5.9). Estimate (6.13) follows, and the Lemma is proved.

### 6.2 Energy estimates

Our aim is to establish a priori energy estimates concerning our linear system. In order to be able to use the linear analysis to both the well-posedness and stability of the nonlinear system, we consider the following modified system

& \equiv A_{1}+A_{2}+A_{3}

The estimates concerning $A_{1}$ and $A_{2}$ are straightforward. Using Cauchy-Schwarz inequality, there exists $C=C\left(\|\underline{U}\|_{L^{\infty}}+\left\|\partial_{x} \underline{U}\right\|_{L^{\infty}}\right)$ such that

= & \left.\epsilon \kappa_{1}\left(v,\left(\partial_{t} \underline{\zeta}\right) v\right)-\mu \epsilon \kappa_{2}\left(\partial_{x} v,\left(\partial_{t} \underline{\zeta}\right) \partial_{x} v\right)\right) \\
& \quad+\epsilon\left(\zeta, \frac{Q_{0}^{\prime}(\epsilon \underline{\zeta}) f(\epsilon \underline{\zeta})-Q_{0}(\epsilon \underline{\zeta}) f^{\prime}(\epsilon \underline{\zeta})}{f(\epsilon \underline{\zeta})^{2}}\left(\partial_{t} \underline{\zeta}\right) \zeta\right)
\end{aligned}

From Cauchy-Schwarz inequality and since $\underline{\zeta}$ satisfies (H1), one deduces

One can now conclude with the proof of the energy estimate. Plug 6.17, 6.18 and 6.19 into 6.16 , invoke Lemma 6.3 and make use of the assumption of the Lemma on $F$. This yields

\frac{1}{2} \frac{d}{d t}\left(E^{0}(U)^{2}\right) \leq \epsilon C_{0} E^{0}(U)^{2}+f(t) E^{0}(U)
$$

where $C_{0} \equiv C\left(\left\|\partial_{t} \underline{\zeta}\right\|_{L^{\infty}([0, T / \epsilon] \times \mathbb{R})},\|\underline{U}\|_{L^{\infty}([0, T / \epsilon] \times \mathbb{R})},\left\|\partial_{x} \underline{U}\right\|_{L^{\infty}([0, T / \epsilon] \times \mathbb{R})}, C_{F}\right)$. Consequently

\frac{d}{d t} E^{0}(U) \leq C_{0} \epsilon E^{0}(U)+f(t)
$$

Making use of the usual trick, we compute for any $\lambda \in \mathbb{R}$,

e^{\epsilon \lambda t} \partial_{t}\left(e^{-\epsilon \lambda t} E^{0}(U)\right)=-\epsilon \lambda E^{0}(U)+\frac{d}{d t} E^{0}(U)
$$

Thanks to the above inequality, one can choose $\lambda=C_{0}$, so that for all $t \in\left[0, \frac{T}{\epsilon}\right]$, one deduces

Integrating this differential inequality yields

This proves the energy estimate 6.15).

Let us now turn to the a priori energy estimate in "large" $X^{s}$ norm.
Lemma 6.6 ( $X^{s}$ energy estimate). Set $(\mu, \epsilon, \delta, \gamma$, bo $) \in \mathcal{P}_{\mathrm{CH}}$, and $s \geq s_{0}+1$, $s_{0}>1 / 2$. Let $U=(\zeta, v)^{\top}$ and $\underline{U}=(\underline{\zeta}, \underline{v})^{\top}$ be such that $U, \underline{U} \in L^{\infty}\left([0, T / \epsilon] ; X^{s}\right), \partial_{t} \underline{\zeta} \in L^{\infty}([0, T / \epsilon] \times \mathbb{R})$ and $\underline{\zeta}$ satisfies $\mathrm{H} 1 \mathrm{H}, \mathrm{H}$ uniformly on $[0, T / \epsilon]$, and such that system 6.14 holds with a right hand side, $F$, with

$$

where $C_{F}$ is a constant and $f$ is an integrable function on $[0, T / \epsilon]$.
Then there exists $\lambda=C\left(\|\underline{U}\|_{X_{T}^{s}}+C_{F}\right)$ such that the following energy estimate holds:

E^{s}(U)(t) \leq e^{\epsilon \lambda t} E^{s}\left(U_{0}\right)+\int_{0}^{t} e^{\epsilon \lambda\left(t-t^{\prime}\right)} f\left(t^{\prime}\right) d t^{\prime} \tag{6.21}
\end{equation*}
$$

The constant $\lambda$ is independent of $(\mu, \epsilon, \delta, \gamma$, bo $) \in \mathcal{P}_{\mathrm{CH}}$, but depends on $M_{\mathrm{CH}}, h_{01}^{-1}, h_{02}^{-1}$.
Remark 6.7. In this Lemma, and in the proof below, the norm $\|\underline{U}\|_{X_{T}^{s}}$ is to be understood as essential sup:

\|U\|_{X_{T}^{s}} \equiv \underset{t \in[0, T / \epsilon]}{\operatorname{ess} \sup }|U(t, \cdot)|_{X^{s}}+\underset{t \in[0, T / \epsilon], x \in \mathbb{R}}{\operatorname{ess} \sup }\left|\partial_{t} \zeta(t, x)\right| .
$$

Proof. Let us multiply the system 6.14 on the right by $\Lambda^{s} S[\underline{U}] \Lambda^{s} U$, and integrate by parts. One obtains

&=\left(\Lambda^{s} F, S[\underline{U}] \Lambda^{s} U\right)
\end{align*}

from which we deduce, using the symmetry property of $S[\underline{U}]$, as well as the definition of $E^{s}(U)$ :

& \frac{1}{2} \frac{d}{d t}\left(E^{s}(U)\right)^{2}=\frac{1}{2}\left(\Lambda^{s} U,\left[\partial_{t}, S[\underline{U}]\right] \Lambda^{s} U\right)-\left(S[\underline{U}] A_{0}[\underline{U}] \partial_{x} \Lambda^{s} U, \Lambda^{s} U\right)  \tag{6.23}\\
& \quad-\left(S[\underline{U}] A_{1}[\underline{U}] \partial_{x} \Lambda^{s} U, \Lambda^{s} U\right)-\left(\left[\Lambda^{s}, A_{0}[\underline{U}]+A_{1}[\underline{U}]\right] \partial_{x} U, S[\underline{U}] \Lambda^{s} U\right) \\
& \\
& +\left(\Lambda^{s} F, S[\underline{U}] \Lambda^{s} U\right)
\end{align*}
$$

We now estimate each of the different components of the r.h.s of the above identity.

- Estimate of $\left(S[\underline{U}] A_{0}[\underline{U}] \partial_{x} \Lambda^{s} U, \Lambda^{s} U\right)$ and $\left(S[\underline{U}] A_{1}[\underline{U}] \partial_{x} \Lambda^{s} U, \Lambda^{s} U\right)$. One can use the $L^{2}$ estimate derived in 6.17), applied to $\Lambda^{s} U$. One deduces

\left|\left(S[\underline{U}] A_{0}[\underline{U}] \partial_{x} \Lambda^{s} U, \Lambda^{s} U\right)\right| \leq \epsilon C\left(\|\underline{U}\|_{L^{\infty}}+\left\|\partial_{x} \underline{U}\right\|_{L^{\infty}}\right)|U|_{X^{s}}^{2} \tag{6.24}
\end{equation*}
$$

Now, thanks to Sobolev embedding, one has for $s>s_{0}+1, s_{0}>1 / 2$

C\left(\|\underline{U}\|_{L^{\infty}}+\left\|\partial_{x} \underline{U}\right\|_{L^{\infty}}\right) \leq C\left(\|\underline{U}\|_{X_{T}^{s}}\right)
$$

so that

\end{equation*}

Similarly, using 6.18, applied to $\Lambda^{s} U$ and continuous Sobolev embedding, one has

\end{equation*}

- Estimate of $\left.\left(\left[\Lambda^{s}, A[\underline{U}]\right] \partial_{x} U, S[\underline{U}]\right] \Lambda^{s} U\right)$, where $A[\underline{U}]=A_{0}[\underline{U}]+A_{1}[\underline{U}]$. Using the definition of $A[\cdot]$ and $S[\cdot]$ in (6.4), (6.8), one has

\begin{aligned}
\left(\left[\Lambda^{s}, A[\underline{U}]\right] \partial_{x} U, S[\underline{U}] \Lambda^{s} U\right)= & \left(\left[\Lambda^{s}, \epsilon f^{\prime}(\epsilon \underline{\zeta}) \underline{v}\right] \partial_{x} \zeta+\left[\Lambda^{s}, f(\epsilon \underline{\zeta})\right] \partial_{x} v, \frac{Q(\epsilon \underline{\zeta}, \underline{v})}{f(\epsilon \underline{\zeta})} \Lambda^{s} \zeta\right) \\
& +\left(\left[\Lambda^{s}, \underline{\mathfrak{T}}^{-1}\left(Q(\epsilon \underline{\zeta}, \underline{v}) \partial_{x} \zeta\right), \underline{\mathfrak{T}} \Lambda^{s} v\right)\right. \\
& +\epsilon\left(\left[\Lambda^{s}, \underline{\mathfrak{T}}^{-1} \mathfrak{Q}[\epsilon \underline{\zeta}, \underline{v}]+\varsigma \underline{v}\right] \partial_{x} v, \underline{\mathfrak{T}} \Lambda^{s} v\right) \\
\equiv & B_{1}+B_{2}+B_{3} .
\end{aligned}
$$

Here and in the following, we denote $\mathfrak{T} \equiv \mathfrak{T}[\epsilon \underline{\zeta}]$ and $Q(\epsilon \underline{\zeta}, \underline{v})=Q_{0}(\epsilon \underline{\zeta})+\epsilon^{2} Q_{1}(\epsilon \underline{\zeta}, \underline{v})$. Let us treat each of these terms separately.

- Control of $B_{1}=\left(\left[\Lambda^{s}, \epsilon f^{\prime}(\epsilon \underline{\zeta}) \underline{v}\right] \partial_{x} \zeta+\left[\Lambda^{s}, f(\epsilon \underline{\zeta})\right] \partial_{x} v, \frac{Q(\epsilon \zeta, \underline{v})}{f(\epsilon \underline{\zeta})} \Lambda^{s} \zeta\right)$.

From Cauchy-Schwarz inequality, one has

\left|B_{1}\right| \leq\left|\left[\Lambda^{s}, \epsilon f^{\prime}(\epsilon \underline{\zeta}) \underline{v}\right] \partial_{x} \zeta+\left[\Lambda^{s}, f(\epsilon \underline{\zeta})\right] \partial_{x} v\right|_{L^{2}}\left|\frac{Q(\epsilon \underline{\zeta}, \underline{v})}{f(\underline{\zeta})} \Lambda^{s} \zeta\right|_{L^{2}}
$$

Since $s \geq s_{0}+1$, we can use the commutator estimate Lemma A. 2 to get

\left|\left[\Lambda^{s}, \epsilon f^{\prime}(\epsilon \underline{\zeta}) \underline{v}\right] \partial_{x} \zeta+\left[\Lambda^{s}, f(\epsilon \underline{\zeta})\right] \partial_{x} v\right|_{L^{2}} & \lesssim\left(\left|\partial_{x}\left(\epsilon f^{\prime}(\epsilon \underline{\zeta})\right)\right|_{H^{s-1}}+\left|\partial_{x}(f(\epsilon \underline{\zeta}))\right|_{H^{s-1}}\right)\left|\partial_{x} U\right|_{H^{s-1}} \\
& \lesssim \epsilon C\left(\|\underline{U}\|_{X_{T}^{s}}\right)|U|_{X^{s}} .
\end{aligned}
$$

where we used, for the last inequality, $\partial_{x}(f(\epsilon \underline{\zeta}))=\epsilon\left(\partial_{x} \underline{\zeta}\right) f^{\prime}(\epsilon \underline{\zeta})$. It follows, using that $\frac{Q(\epsilon \bar{\zeta}, \underline{v})}{f(\underline{\underline{\zeta}})} \in L^{\infty}$ since $\underline{\zeta}$ satisfies (H1):

- Control of $B_{2}=\left(\left[\Lambda^{s}, \underline{\mathfrak{T}}^{-1}(Q(\epsilon \underline{\zeta}, \underline{v}) \cdot)\right] \partial_{x} \zeta, \underline{\mathfrak{T}} \Lambda^{s} v\right)$.

By symmetry of $\mathfrak{T}$, one has

B_{2}=\left(\underline{\mathfrak{T}}\left[\Lambda^{s}, \underline{\mathfrak{T}}^{-1}(Q(\epsilon \underline{\zeta}, \underline{v}) \cdot)\right] \partial_{x} \zeta, \Lambda^{s} v\right)

Now, one can check that, by definition of the commutator,

\mathfrak{T}\left[\Lambda^{s}, \underline{\mathfrak{T}}^{-1}(Q(\epsilon \underline{\zeta}, \underline{v}) \cdot)\right] \partial_{x} \zeta= & \underline{\mathfrak{T}}^{s} \underline{\underline{T}}^{-1} Q(\epsilon \underline{\zeta}, \underline{v}) \partial_{x} \zeta-Q(\epsilon \underline{\zeta}, \underline{v}) \Lambda^{s} \partial_{x} \zeta \\
= & \mathfrak{T}^{s} \underline{\mathfrak{T}}^{-1} Q(\epsilon \underline{\zeta}, \underline{v}) \partial_{x} \zeta-\Lambda^{s} \underline{\mathfrak{T}}^{-1}\left(Q(\epsilon \underline{\zeta}, \underline{v}) \partial_{x} \zeta\right) \\
& +\Lambda^{s}\left(Q(\epsilon \underline{\zeta}, \underline{v}) \partial_{x} \zeta\right)-Q(\epsilon \underline{\zeta}, \underline{v}) \Lambda^{s} \partial_{x} \zeta \\
= & -\left[\Lambda^{s}, \underline{\mathfrak{T}}\right] \underline{\mathfrak{T}}^{-1}\left(Q(\epsilon \underline{\zeta}, \underline{v}) \partial_{x} \zeta\right)+\left[\Lambda^{s}, Q(\epsilon \underline{\zeta}, \underline{v})\right] \partial_{x} \zeta
\end{aligned}
$$

We can now use Corollary 5.4 and deduce

& \leq C\left(|\underline{U}|_{X^{s}}\right)|\zeta|_{H^{s}}|v|_{H_{\mu}^{s+1}}
\end{aligned}
$$

The last inequality is obtained using Lemma A. 1 .
From Lemma A. 2 and the explicit definition of $Q=Q_{0}+\epsilon^{2} Q_{1}$ in 6.5, one has

$$

so that we finally get

- Control of $B_{3}=\epsilon\left(\left[\Lambda^{s}, \underline{\mathfrak{T}}^{-1} \mathfrak{Q}[\epsilon \underline{\zeta}, \underline{v}]+\varsigma \underline{v}\right] \partial_{x} v, \underline{\mathfrak{T}} \Lambda^{s} v\right)$.

Let us first use the definition of $\mathfrak{Q}[\epsilon \underline{\zeta}, \underline{v}]$ 6.5) to expand:

& +\epsilon \varsigma\left(\left[\Lambda^{s}, \underline{v}\right] \partial_{x} v, \underline{\mathfrak{T}} \Lambda^{s} v\right) \\
\equiv & B_{31}+B_{32}+B_{33} .
\end{aligned}
$$

In order to estimate $B_{31}$ and $B_{32}$, one proceeds as for the control of $B_{2}$. One can check

$$
\underline{\mathfrak{T}}\left[\Lambda^{s}, \underline{\mathfrak{T}}^{-1}\left(q_{1}(\epsilon \underline{\zeta}) q_{3}(\epsilon \underline{\zeta}) \underline{v} \cdot\right)\right] \partial_{x} v=-\left[\Lambda^{s}, \underline{\mathfrak{T}}\right] \underline{\mathfrak{T}}^{-1}\left(q_{1}(\epsilon \underline{\zeta}) q_{3}(\epsilon \underline{\zeta}) \underline{v} \partial_{x} v\right)+\left[\Lambda^{s}, q_{1}(\epsilon \underline{\zeta}) q_{3}(\epsilon \underline{\zeta}) \underline{v}\right] \partial_{x} v
$$

As above, using Cauchy-Schwarz inequality, Corollary 5.4 and Lemma A.2, one obtains

In the same way,

$$

Again, using Cauchy-Schwarz inequality, Corollary 5.4 and Lemma A.2, one has

\mu \mid\left(\left[\Lambda^{s}, \underline{\mathfrak{T}} \underline{\mathfrak{T}}^{-1}\left(\partial_{x}\left(\left(\partial_{x} \underline{v}\right)\left(\partial_{x} v\right)\right)\right], \Lambda^{s} v\right) \mid\right. & \leq c_{s} \mu|\underline{\zeta}|_{H^{s}}\left|\partial_{x}\left(\left(\partial_{x} \underline{v}\right)\left(\partial_{x} v\right)\right)\right|_{H^{s-1}}|v|_{H_{\mu}^{s+1}} \\
& \leq c_{s}|\underline{\zeta}|_{H^{s}}|\underline{v}|_{H_{\mu}^{s+1}}|v|_{H_{\mu}^{s+1}}^{2}
\end{aligned}
$$

and

$$
\mu\left|\left(\partial_{x}\left(\left[\Lambda^{s}, \partial_{x} \underline{v}\right] \partial_{x} v\right), \Lambda^{s} v\right)\right|=\mu\left|\left(\left[\Lambda^{s}, \partial_{x} \underline{v}\right] \partial_{x} v, \Lambda^{s} \partial_{x} v\right)\right| \leq c_{s}|\underline{v}|_{H_{\mu}^{s+1}}|v|_{H_{\mu}^{s+1}}^{2}
$$

Thus we proved

Finally, we turn to $B_{33}=\epsilon \varsigma\left(\left[\Lambda^{s}, \underline{v}\right] \partial_{x} v, \mathfrak{T} \Lambda^{s} v\right)$. From Lemma 5.2 one has

$$

Note the identity

$$

so that Lemma A. 2 yields $\sqrt{\mu}\left|\partial_{x}\left(\left[\Lambda^{s}, \underline{v}\right] \partial_{x} v\right)\right|_{L^{2}} \leq|\underline{v}|_{H_{\mu}^{s+1}}|v|_{H_{\mu}^{s+1}}$.
Altogether, we proved

- Estimate of $\frac{1}{2}\left(\Lambda^{s} U,\left[\partial_{t}, S[\underline{U}]\right] \Lambda^{s} U\right)$.

One has

& \left(\Lambda^{s} U,\left[\partial_{t}, S[\underline{U}]\right] \Lambda^{s} U\right) \equiv\left(\Lambda^{s} v,\left[\partial_{t}, \underline{\mathfrak{T}}\right] \Lambda^{s} v\right)+\left(\Lambda^{s} \zeta,\left[\partial_{t}, \frac{Q_{0}(\epsilon \underline{\zeta})}{f(\epsilon \underline{\zeta})}\right] \Lambda^{s} \zeta\right) \\
& =\left(\Lambda^{s} v,\left(\partial_{t} q_{1}(\epsilon \underline{\zeta})\right) \Lambda^{s} v\right)-\mu \nu\left(\Lambda^{s} v, \partial_{x}\left(\left(\partial_{t} q_{2}(\epsilon \underline{\zeta})\right)\left(\partial_{x} \Lambda^{s} v\right)\right)\right) \\

& +\epsilon\left(\Lambda^{s} \zeta, \frac{Q_{0}^{\prime}(\epsilon \underline{\zeta}) f(\epsilon \underline{\zeta})-Q_{0}(\epsilon \underline{\zeta}) f^{\prime}(\epsilon \underline{\zeta})}{f(\epsilon \underline{\zeta})^{2}}\left(\partial_{t} \underline{\zeta}\right) \Lambda^{s} \zeta\right)

Set $\mathfrak{p}=(\mu, \epsilon, \delta, \gamma$, bo $) \in \mathcal{P}_{\mathrm{CH}}$ (see (3.2)) and $s \geq s_{0}+1$ with $s_{0}>1 / 2$, and let $\underline{U}^{\mathfrak{p}}=\left(\underline{\zeta}^{\mathfrak{p}}, \underline{v}^{\mathfrak{p}}\right)^{\top} \in X_{T}^{s}$ (see Definition 6.2) be such that (H1), H2) are satisfied for $t \in[0, T / \epsilon]$, uniformly with respect to $\mathfrak{p} \in \mathcal{P}_{\mathrm{CH}}$. For any $U_{0} \in X^{s}$, there exists a unique solution to (6.7), $U^{\mathfrak{p}} \in C^{0}\left([0, T / \epsilon] ; X^{s}\right) \cap C^{1}\left([0, T / \epsilon] ; X^{s-1}\right) \subset X_{T}^{s}$, and $C_{0}, \lambda_{T}=C\left(\|\underline{U}\|_{X_{T}^{s}}, T, M_{\mathrm{CH}}, h_{01}^{-1}, h_{02}^{-1}\right)$, independent of $\mathfrak{p} \in \mathcal{P}_{\mathrm{CH}}$, such that one has the energy estimates

where we use Lemmata A. 1 and 5.3
The completion of the proof is as follows. In order to construct a solution to (6.7), we use a sequence of Friedrichs mollifiers, defined by $J_{\nu} \equiv\left(1-\nu \partial_{x}^{2}\right)^{-1 / 2}(\nu>0)$, in order to reduce our system to ordinary differential equation systems on $X^{s}$, which are solved uniquely by CauchyLipschitz theorem. Estimates (6.30), 6.31) hold for each $U_{\nu} \in C^{0}\left([0, T / \epsilon] ; X^{s}\right)$, uniformly in $\nu>0$. One deduces that a subsequence converges towards $U \in L^{2}\left([0, T / \epsilon] ; X^{s}\right)$, a (weak) solution of the Cauchy problem (6.7). By regularizing the initial data as well, one can show that the system induces a smoothing effect in time, and that the solution $U \in C^{0}\left([0, T / \epsilon] ; X^{s}\right) \cap C^{1}\left([0, T / \epsilon] ; X^{s-1}\right)$ is actually a strong solution. The uniqueness is a straightforward consequence of 6.30 (with $U_{0} \equiv 0$ ) applied to the difference of two solutions.

## 7 Proof of existence, stability and convergence

In this section we prove the main results of this paper. We start by proving an a priori estimate on the difference of two possible solutions. Existence and uniqueness of the solution of the Cauchy problem for our new Green-Naghdi type system, in the Camassa-Holm regime $\epsilon=O(\sqrt{\mu})$ and over large times, is then deduced from the linear analysis of the previous section and this a priori estimate. The estimate also provides

- the stability of the solution with respect to the initial data, thus the Cauchy problem for our system is well-posed in the sense of Hadamard, in Sobolev spaces; see subsection 7.2 .
- the stability of the solution with respect to a perturbation of the equation, which allows, together with the well-posedness, to fully justify our system (and any other well-posed, consistent model); see section 8 .


### 7.1 One more a priori estimate

In this subsection, we control the difference of two solutions of the nonlinear system, with different initial data and right-hand sides. More precisely, we prove the following result.

Proposition 7.1. Let $(\mu, \epsilon, \delta, \gamma$, bo $) \in \mathcal{P}_{\mathrm{CH}}$ and $s \geq s_{0}+1, s_{0}>1 / 2$, and assume that there exists $U_{i}$ for $i \in\{1,2\}$, such that one has $U_{i}=\left(\zeta_{i}, v_{i}\right)^{\top} \in X_{T}^{s}, U_{2} \in L^{\infty}\left([0, T / \epsilon) ; X^{s+1}\right)$, $\zeta_{1}$ satisfies H 1$], \mathrm{H} 2)$ on $[0, T / \epsilon]$, with $h_{01}, h_{02}>0$, and $U_{i}$ satisfy

Existence and uniqueness of the solution is given by Theorem 7.3 while the stability with respect to the initial data is provided by Theorem 7.4 These results correspond to Theorems 3.2 and 3.3 , as stated in section 3

Theorem 7.3 (Existence and uniqueness). $F^{n} \equiv-S^{-1}\left[U^{n}\right]\left(\Sigma_{0}\left[U^{n}\right]+\Sigma_{1}\left[U^{n}\right]-\Sigma_{0}\left[U^{n-1}\right]-\Sigma_{1}\left[U^{n-1}\right]\right) \partial_{x} U^{n}-S^{-1}\left[U^{n}\right]\left(S\left[U^{n}\right]-S\left[U^{n-1}\right]\right) \partial_{t} U^{n}$.
We wish to use the energy estimate of Lemma 6.5 to the linear system 7.20 . Thus one needs to control accordingly the right hand side $F^{n}$.

More precisely, we want to estimate

Proceeding as in Lemma 7.2, one can easily deduce

Using the uniform control of $U^{n}, \partial_{t} U^{n}$ in 7.19), one deduces

Completion of the proof. Since $U^{n}$ converges in $C^{0}\left(\left[0, T^{\prime} / \epsilon\right] ; X^{0}\right)$ and is uniformly bounded in $X^{s}$, standard interpolation arguments imply that the sequence $U^{n}$ converges in $C^{0}\left(\left[0, T^{\prime} / \epsilon\right] ; X^{s^{\prime}}\right)$, for any $s^{\prime}<s$. Similarly, one proves $\partial_{t} U^{n}$ converges in $C^{0}\left(\left[0, T^{\prime} / \epsilon\right] ; X^{s^{\prime}-1}\right)$. Choosing $s^{\prime}-1>1 / 2$, one may pass to the limit all the terms in system (7.16), and one deduces that the limit $U$ is a solution of system 4.15). Passing to the limit the properties of $U^{n}$, and in particular the energy estimates 77.19 ), one deduces $U \in L^{\infty}\left([0, T / \epsilon] ; X^{s}\right), \partial_{t} U \in L^{\infty}\left([0, T / \epsilon] ; X^{s-1}\right)$, and $U$ satisfies the energy estimate of the Theorem (using Lemma 6.3), and preserves the conditions ( H 11 , (H2) for any $t \in\left[0, \frac{T^{\prime}}{\epsilon}\right]$, independently of $\mathfrak{p} \in \mathcal{P}_{\mathrm{CH}}$.

Finally, as in Proposition 6.8 (with $\underline{U} \equiv U$ ), one can prove that $U$ actually satisfies $U \in$ $C^{0}\left(\left[0, T^{\prime} / \epsilon\right] ; X^{s}\right) \cap C^{1}\left(\left[0, T^{\prime} / \epsilon\right] ; X^{s-1}\right)$. The uniqueness of $U$ follows from the stability result of Proposition 7.1 with $F_{1} \equiv F_{2} \equiv 0$, and one can therefore define a maximal time of existence of the solution, that we denote $T_{\max }$. $T_{\max }$ is bounded from below by $T^{\prime} / \epsilon>0$, and the behavior of the solution as $t \rightarrow T_{\max }$ if $T_{\max }<\infty$ follows from standard continuation arguments.

Theorem 7.4 (Stability). Let $(\mu, \epsilon, \delta, \gamma$, bo $) \in \mathcal{P}_{\mathrm{CH}}$ and $s \geq s_{0}+1$ with $s_{0}>1 / 2$, and assume $U_{0,1}=$ $\left(\zeta_{0,1}, v_{0,1}\right)^{\top} \in X^{s}$ and $U_{0,2}=\left(\zeta_{0,2}, v_{0,2}\right)^{\top} \in X^{s+1}$ satisfies (H1), H2). Denote $U_{j}$ the solution to 4.15 with $\left.U_{j}\right|_{t=0}=U_{0, j}$. Then there exists $T^{-1}, \lambda, C_{0}=C\left(\overline{M_{\mathrm{CH}}}, h_{01}^{-1}, h_{02}^{-1},\left|U_{0,1}\right|_{X^{s}},\left|U_{0,2}\right|_{X^{s+1}}\right)$ such that

Proof. The existence and uniform control of the solution $U_{1}$ (resp. $U_{2}$ ) in $L^{\infty}\left([0, T / \epsilon] ; X^{s}\right)$ (resp. $\left.L^{\infty}\left([0, T / \epsilon] ; X^{s+1}\right)\right)$ is provided by Theorem 7.3. The proposition is then a direct consequence of the a priori estimate of Proposition 7.1 , with $F_{1}=F_{2}=0$, and Lemma 6.3.

## 8 Full justification of asymptotic models

We conclude our work by explaining how the results of the previous sections allow to fully justify our system (and other consistent ones) as asymptotic model for the propagation of internal waves. A model is said to be fully justified (using the terminology of 29$]$ ) if the Cauchy problem for both the full Euler system and the asymptotic model is well-posed for a given class of initial data, and over the relevant time scale; and if the solutions with corresponding initial data remain close. As described in [31, Section 6.3], the full justification of a system (S) follows from:

- (Consistency) One proves that families of solutions to the full Euler system, existing and controlled over the relevant time scale satisfies the system (S) up to a small residual.
- (Existence) One proves that families of solutions to the full Euler system as above do exist. This difficult step is ensured by Theorem 5 (or Theorem 6 for large times) in 31, provided that a stability criterion is satisfied (see details therein).
- (Convergence) One proves that the solutions of the full Euler system, and the ones of the system (S), with corresponding initial data, remain close over the relevant time scale.

The last step supposes that the Cauchy problem for the model is well-posed, and is a consequence of the stability of its solutions with respect to perturbations of the equations, so that the first two steps of the procedure (consistency and existence) yield the conclusion (convergence), and therefore the full justification of the model. Let us refer to Theorem 7 in 31 for the application of such procedure for the full justification of the so-called shallow-water/shallow-water asymptotic model, which corresponds to our system, when withdrawing $\mathcal{O}(\mu)$ terms.

The consistency of our model has been given in Theorem 3.1. The well-posedness of the Cauchy problem is stated in Theorem 3.2, and the stability results is a consequence of Proposition 7.1 . Thus we have all the ingredients for the full justification of our model, stated in Theorem 3.4, and that we recall below.

Theorem 8.1 (Convergence). Let $\mathfrak{p} \equiv\left(\mu, \epsilon, \delta, \gamma\right.$, bo) $\in \mathcal{P}_{\mathrm{CH}}$ (see (3.2)) and $s \geq s_{0}+1$ with $s_{0}>1 / 2$, and let $U^{0} \equiv\left(\zeta^{0}, \psi^{0}\right)^{\top} \in H^{s+N}(\mathbb{R})^{2}, N$ sufficiently large, satisfy the hypotheses of Theorem 5 in [31] as well as (H1), H2). Then there exists $C, T>0$, independent of $\mathfrak{p}$, such that

- There exists a unique solution $U \equiv(\zeta, \psi)^{\top}$ to the full Euler system 2.4, defined on $[0, T]$ and with initial data $\left(\zeta^{0}, \psi^{0}\right)^{\top}$ (provided by Theorem 5 in [31]);
- There exists a unique solution $U_{a} \equiv\left(\zeta_{a}, v_{a}\right)^{\top}$ to our new model 3.3], defined on $[0, T]$ and with initial data $\left(\zeta^{0}, v^{0}\right)^{\top}$ (provided by Theorem 3.2);
- With $\bar{v} \equiv \bar{v}[\zeta, \psi]$, defined as in (3.4), one has for any $t \in[0, T]$,

Proof. As stated above, the existence of $U$ is provided by Theorem 5 in [31, and the existence of $U_{a}$ is given by our Theorem 3.2 (we choose $T$ as the minimum of the existence time of both solutions; it is bounded from below, independently of $\mathfrak{p} \in \mathcal{P}_{\mathrm{CH}}$ ). If $N$ is large enough, then $U \equiv(\zeta, \psi)^{\top}$ satisfies the assumptions of our consistency result, Theorem 3.1, and therefore $(\zeta, \bar{v})^{\top}$ solves (3.3) up to a residual $R=\left(r_{1}, r_{2}\right)^{\top}$, with $|R|_{L^{\infty}\left([0, T] ; H^{s}\right)} \leq C\left(M_{\mathrm{CH}}, h_{01}^{-1},\left|U^{0}\right|_{H^{s+N}}\right)\left(\mu^{2}+\mu \epsilon^{2}\right)$. The result follows from the stability Proposition 7.1, with $F_{1}=\left(r_{1}, \mathfrak{T}[\epsilon \zeta]^{-1} r_{2}\right)^{\top}$ and $F_{2}=0$.

In addition to allowing the complete, full justification of our model, the results of the previous sections allow to rigorously justify any lower order, well-posed and consistent model. We quickly show how to apply the procedure to such models, with the example of the so-called ConstantinLannes decoupled approximation, introduced by one of the authors in 20, and that we recall below.

Definition 8.2 (Constantin-Lannes decoupled approximation model). Let $\zeta^{0}, v^{0}$ be given scalar functions, and set parameters $(\mu, \epsilon, \delta, \gamma, \mathrm{bo}) \in \mathcal{P}_{\mathrm{CH}}$, as defined in (3.2), and $(\lambda, \theta) \in \mathbb{R}^{2}$. The Constantin-Lannes decoupled approximation is then

with parameters defined as follows:

Remark 8.3. The scalar equation (8.1) has been introduced as a model for gravity surface wave (one layer of homogeneous fluid) in [26], and its rigorous justification has been developed in [13]. The justification is to be understood in the following sense: if one chooses carefully the initial data (so as to focus on only one direction of propagation), then the Constantin-Lannes equation provides a good (unidirectional) approximation of the flow. The reason why a bi-directional, decoupled approximation as above has not been developed in the water-wave setting is that lower order scalar equations offer the same accuracy. The specificity of internal waves lies in the existence of a critical ratio $\left(\delta^{2}=\gamma\right)$ for which quadratic nonlinearities vanish, thus calling for higher order decoupled models, especially in the Camassa-Holm regime.

The Cauchy problem for the equation (8.1) has been proved to be locally well-posed in [13, and a property of persistence of spatial decay at infinity has been proved in 20. We state these results below.

Proposition 8.4 (Well-posedness and persistence). Let $u^{0} \in H^{s+1}$, with given $s \geq s_{0}+1, s_{0}>1 / 2$. Let the parameters in 8.2 be such that $\mu, \epsilon, \nu_{t}^{\theta, \lambda}>0$, and define $m>0$ such that

Then there exists $T=C\left(m,\left|u^{0}\right|_{H_{\mu}^{s+1}}\right)$ and a unique $u \in C^{0}\left([0, T / \epsilon) ; H_{\mu}^{s+1}\right) \cap C^{1}\left([0, T / \epsilon) ; H_{\mu}^{s}\right)$ such that $u$ satisfies (8.1) and initial data $\left.u\right|_{t=0}=u^{0}$.

Moreover, $u$ satisfies the following energy estimate for $0 \leq t \leq T / \epsilon$ :

Then there exists $T=C\left(m, n, k, \sum_{j=0}^{n}\left|x^{j} u^{0}\right|_{H_{\mu}^{s+k+1+2(n-j)}}\right)$ such that for $0 \leq t \leq T \times \min (1 / \epsilon, 1 / \mu)$, one has

The decoupled model of Definition 8.2 is consistent with our new model (3.3), in the following way.

Proposition 8.5 (Consistency). Let $\zeta^{0}, v^{0} \in H^{s+6}$ with given $s \geq s_{0}+1$, $s_{0}>1 / 2$. For $(\mu, \epsilon, \delta, \gamma, \mathrm{bo})=\mathfrak{p} \in \mathcal{P}_{\mathrm{CH}}$, we denote $U_{\mathrm{CL}}^{\mathfrak{p}}$ the unique solution of the CL approximation, as defined in Definition 8.2. For some given $M_{s+6}^{\star}>0$, sufficiently large, assume that there exists $T^{\star}>0$ and a family $\left(U_{\mathrm{CL}}^{\mathfrak{p}}\right)_{\mathfrak{p} \in \mathcal{P}_{\mathrm{CH}}}$ such that

Then there exists $U^{c}=U^{c}\left[U_{\mathrm{CL}}^{\mathfrak{p}}\right]$ such that $U \equiv U_{\mathrm{CL}}^{\mathfrak{p}}+U^{c}$ satisfies our Green-Naghdi type system (3.3) up to a remainder $R$ bounded for $t \in\left[0, T^{\star}\right]$ by

Proof. A similar statement concerning the consistency of the Constantin-Lannes decoupled approximation towards the original Green-Naghdi system (4.6) (in the shallow water regime (3.1) and neglecting the surface tension contributions) has been given in [20, Proposition 1.12]. Taking into account the surface tension contribution only requires a slight modification in one of the parameters (one has $\nu_{x}^{\theta, \lambda}=\frac{1-\theta}{6} \frac{1+\gamma \delta}{\delta(\gamma+\delta)}-\lambda$ in 20 ), as shows tedious but straightforward calculations. Finally, using the boundedness of $U_{\mathrm{CL}}^{\mathfrak{p}}$ assumed in the statement, and following the proof of Theorem 3.1 , one easily checks that the corresponding result holds with regards to our system (3.3), in the more stringent Camassa-Holm regime 3.2 .

Remark 8.6. Let us note that Proposition 8.4 ensures that the above result is not empty, but on the contrary is valid for long times (provided that $\nu_{t}^{\theta, \lambda}>0$ and the initial data sufficiently smooth). More precisely, if the initial data $\left(\zeta^{0}, v^{0}\right)=U^{0} \in H^{s+7}, s \geq s_{0}+1, s_{0}>1 / 2$, then for any $\mathfrak{p} \in \mathcal{P}_{\mathrm{CH}}$ and $\lambda, \theta$ such that $\nu_{t}^{\theta, \lambda}>\nu_{0}>0$, then there exists $C_{1}, C_{2}$ independent of $\mathfrak{p}$, such that for $M_{s+6}^{\star} \geq C_{1}$, the decoupled approximate solution satisfies the uniform bound of Proposition 8.5, with $T^{\star} \geq C_{2} / \epsilon$.

Moreover, upon additional condition on the decaying in space of the initial data, there exists $C_{1}, C_{2}$ such that for any $M_{s+6}^{\sharp} \geq C_{1}$, one has $T^{\sharp} \geq C_{2} / \max (\epsilon, \mu)$.

The above properties, thanks to the well-posedness and stability of our Green-Naghdi type system proved in this work, are sufficient to fully justify the solutions of the Constantin-Lannes decoupled approximation as approximate solutions of our model, and therefore as approximate solutions of the full Euler system (2.4.

Proposition 8.7 (Convergence of the decoupled model). Let $\lambda, \theta \in \mathbb{R}$ and $\mathfrak{p} \equiv(\mu, \epsilon, \delta, \gamma$, bo) $\in$ $\mathcal{P}_{\mathrm{CH}}$ be such that (8.3) holds. Let $U^{0} \equiv\left(\zeta^{0}, \psi^{0}\right)^{\top} \in H^{s+N}$, with $N$ sufficiently large, satisfy the hypotheses of Theorem 5 in [31] as well as (H1), (H2). Denote by $U^{\mathfrak{p}} \equiv(\zeta, \psi)^{\top}$ the solution of the full Euler system (2.4) and by $U_{\mathrm{CL}}^{\mathfrak{p}}$ the decoupled approximation defined in Definition 8.2, with
initial data $U^{0}$. Then there exists $C, T>0$, independent of $\mathfrak{p} \in \mathcal{P}_{\mathrm{CH}}$, such that for any $0 \leq t \leq T$, one has

$$
\left\|U_{\mathrm{CL}}^{\mathfrak{p}}-\bar{U}^{\mathfrak{p}}\right\|_{L^{\infty}\left([0, t] ; H^{s}\right)} \leq C\left(\varepsilon_{0} \min \left(t, t^{1 / 2}\right)\left(1+\varepsilon_{0} t\right)\right)
$$

with $\varepsilon_{0} \equiv \max \left(\epsilon\left(\delta^{2}-\gamma\right), \mu\right)$, and $\bar{U}^{\mathfrak{p}} \equiv(\zeta, \bar{v}[\zeta, \psi])^{\top}$ where $\bar{v}[\zeta, \psi]$ is defined as in (3.4).
Moreover, if the initial data is sufficiently localized in space, as in the second part of Proposition 8.5, then one has

$$
\left\|U_{\mathrm{CL}}^{\mathfrak{p}}-\bar{U}^{\mathfrak{p}}\right\|_{L^{\infty}\left([0, t] ; H^{s}\right)} \leq C\left(\varepsilon_{0} \min (t, 1)\left(1+\varepsilon_{0} t\right)\right)
$$

Proof. By Proposition 8.5, we know that for any $U_{\mathrm{CL}}^{\mathfrak{p}}$, there exists $U^{c}=U^{c}\left[U_{\mathrm{CL}}^{\mathfrak{p}}\right]$ such that $U \equiv U_{\mathrm{CL}}^{\mathfrak{p}}+U^{c}$ satisfies the Green-Naghdi type system (3.3), up to a small remainder $R$. Controlling the difference $\left\|U-U_{\mathrm{GN}}{ }^{\mathfrak{p}}\right\|$, where $U_{\mathrm{GN}}{ }^{\mathfrak{p}}$ is the solution of system (3.3) with corresponding initial data, is done exactly as in Theorem 3.4, and we omit the proof. The result is then a straightforward consequence of the triangular inequality, as $\left\|U^{\mathfrak{p}}-U_{\mathrm{GN}}{ }^{\mathfrak{p}}\right\|$ is estimated in Theorem 3.4, and $\left\|U^{c}\left[U_{\mathrm{CL}}^{\mathfrak{p}}\right]\right\|$ in Proposition 8.5

## A Product and commutator estimates in Sobolev spaces.

Let us recall here some product as well as commutator estimates in Sobolev spaces, used throughout the present paper.
Lemma A. 1 (product estimates).
Let $s \geq 0$, one has $\forall f, g \in H^{s}(\mathbb{R}) \bigcap L^{\infty}(\mathbb{R})$, one has

$$
|f g|_{H^{s}} \lesssim|f|_{L^{\infty}}|g|_{H^{s}}+|f|_{H^{s}}|g|_{L^{\infty}}
$$

If $s \geq s_{0}>1 / 2$, one deduces thanks to continuous embedding of Sobolev spaces,

$$
|f g|_{H^{s}} \lesssim|f|_{H^{s}}|g|_{H^{s}} .
$$

More generally, for $s \geq 0$ and $s_{0}>1 / 2$, one has $\forall f \in H^{s}(\mathbb{R}) \bigcap H^{s_{0}}(\mathbb{R}), g \in H^{s}(\mathbb{R})$,

$$
\left.|f g|_{H^{s}} \lesssim|f|_{H^{s_{0}}}|g|_{H^{s}}+\left.\langle | f\right|_{H^{s}}|g|_{H^{s_{0}}}\right\rangle_{s>s_{0}},
$$

Let $F \in C^{\infty}(\mathbb{R})$ such that $F(0)=0$. If $g \in H^{s}(\mathbb{R}) \cap L^{\infty}(\mathbb{R})$ with $s \geq 0$, one has $F(g) \in H^{s}(\mathbb{R})$ and

$$
|F(g)|_{H^{s}} \leq C\left(|g|_{L^{\infty}},|F|_{C^{\infty}}\right)|g|_{H^{s}}
$$

Finally, we will use

$$
|f g|_{H_{\mu}^{s+1}} \leq C|f|_{H_{\mu}^{s+1}}|g|_{H_{\mu}^{s+1}}
$$

The first estimates are classical (see [1,27,30]) , and the last one follows straightforwardly from

$$
|f g|_{H_{\mu}^{s+1}}^{2} \lesssim|f g|_{H^{s}}^{2}+\mu\left|\partial_{x}(f g)\right|_{H^{s}}^{2} \lesssim|f|_{H^{s}}^{2}|g|_{H^{s}}^{2}+\mu\left|g \partial_{x} f\right|_{H^{s}}^{2}+\mu\left|f \partial_{x} g\right|_{H^{s}}^{2}
$$

We know recall commutator estimate, mainly due to the Kato-Ponce [27, and recently improved by Lannes 30 (see Theorems 3 and 6):

Lemma A. 2 (commutator estimates).
For any $s \geq 0$, and $\partial_{x} f, g \in L^{\infty}(\mathbb{R}) \bigcap H^{s-1}(\mathbb{R})$, one has

$$
\left|\left[\Lambda^{s}, f\right] g\right|_{L^{2}} \lesssim\left|\partial_{x} f\right|_{H^{s-1}}|g|_{L^{\infty}}+\left|\partial_{x} f\right|_{L^{\infty}}|g|_{H^{s-1}} .
$$

Thanks to continuous embedding of Sobolev spaces, one has for $s \geq s_{0}+1, s_{0}>\frac{1}{2}$,

$$
\left|\left[\Lambda^{s}, f\right] g\right|_{L^{2}} \lesssim\left|\partial_{x} f\right|_{H^{s-1}}|g|_{H^{s-1}}
$$

More generally, for any $s \geq 0$ and $s_{0}>1 / 2, \partial_{x} f, g \in H^{s_{0}}(\mathbb{R}) \bigcap H^{s-1}(\mathbb{R})$, one has

$$
\left.\left|\left[\Lambda^{s}, f\right] g\right|_{L^{2}} \lesssim\left|\partial_{x} f\right|_{H^{s_{0}}}|g|_{H^{s-1}}+\left.\langle | \partial_{x} f\right|_{H^{s-1}}|g|_{H^{s_{0}}}\right\rangle_{s>s_{0}+1} .
$$

We conclude this section with two corollaries of Lemma A.1, used in particular in the proof of Theorem 4.4.

Lemma A.3. Let $f, \zeta \in L^{\infty} \bigcap H^{\bar{s}}$, with $\bar{s} \geq 0$ and $h_{1}=1-\epsilon \zeta$, with $h_{1}(\epsilon \zeta) \geq h>0$ for any $x \in \mathbb{R}$. Then one has

$$
\left|\frac{1}{h_{1}} f\right|_{H^{\bar{s}}} \leq C\left(h^{-1}, \epsilon|\zeta|_{L^{\infty}}\right)\left(|f|_{H^{\bar{s}}}+\epsilon|\zeta|_{H^{\bar{s}}}|f|_{L^{\infty}}\right)
$$

Proof. We make use of the identity

$$
\frac{1}{h_{1}} f=\frac{1}{1-\epsilon \zeta} f=f+\frac{\epsilon \zeta}{1-\epsilon \zeta} f
$$

Moser's tame estimates (Lemma A.1) yield

$$
\begin{aligned}
\left|\frac{1}{h_{1}} f\right|_{H^{\bar{s}}} & \leq|f|_{H^{\bar{s}}}+\left|\frac{\epsilon \zeta}{1-\epsilon \zeta} f\right|_{H^{\bar{s}}} \\
& \lesssim|f|_{H^{\bar{s}}}+\left|\frac{\epsilon \zeta}{1-\epsilon \zeta}\right|_{L^{\infty}}|f|_{H^{\bar{s}}}+\left|\frac{\epsilon \zeta}{1-\epsilon \zeta}\right|_{H^{\bar{s}}}|f|_{L^{\infty}}
\end{aligned}
$$

The only non-trivial term to estimate is now $\left|\frac{\epsilon \zeta}{1-\epsilon \zeta}\right|_{H^{\bar{s}}}$. Using that $h_{1}=1-\epsilon \zeta \geq h>0$, we introduce a function $F \in C^{\infty}(\mathbb{R})$ such that

$$
F(X)= \begin{cases}\frac{X}{1-X} & \text { if } 1-X \geq h>0 \\ 0 & \text { if } 1-X \leq 0\end{cases}
$$

The function $F$ satisfies the hypotheses of Lemma A.1. and one has

$$
\left|\frac{\epsilon \zeta}{1-\epsilon \zeta}\right|_{H^{\bar{s}}}=|F(\epsilon \zeta)|_{H^{\bar{s}}} \leq C\left(|\epsilon \zeta|_{L^{\infty}}, h^{-1}\right)|\epsilon \zeta|_{H^{\bar{s}}}
$$

The Lemma is now straightforward.
Let us apply this Lemma to the rigorous estimate of specific expansions.
Lemma A.4. Let $f, \zeta \in L^{\infty}\left([0, T) ; H^{\bar{s}}\right)$, with $\bar{s} \geq s_{0}>1 / 2$, be such that one has $h_{1} \equiv 1-\epsilon \zeta \geq h>0$ for any $(t, x) \in[0, T) \times \mathbb{R}$. Then one has

$$
\left|\frac{1}{h_{1}} f-f\right|_{H^{\bar{s}}} \leq \epsilon C\left(h^{-1}, \epsilon|\zeta|_{H^{\bar{s}}}\right)|\zeta|_{H^{\bar{s}}}|f|_{H^{\bar{s}}}
$$

and

$$
\left|\frac{1}{h_{1}} f-(1+\epsilon \zeta) f\right|_{H^{\bar{s}}} \leq \epsilon^{2} C\left(h^{-1}, \epsilon|\zeta|_{H^{\bar{s}}}\right)|\zeta|_{H^{\bar{s}}}^{2}|f|_{H^{\bar{s}}}
$$

Proof. Let us first remark that the formal expansions are straightforward:

$$
\frac{1}{1-X}=1+\mathcal{O}(X) \quad \text { and } \quad \frac{1}{1-X}=1+X+\mathcal{O}\left(X^{2}\right) \quad \text { for } \quad|X|<1
$$

The rigorous estimate is obtained thanks to Lemma A.3, applied to the identities

$$
\frac{1}{h_{1}} f-f=\frac{\epsilon \zeta}{h_{1}} f, \quad \text { and } \quad \frac{1}{h_{1}} f-(1+\epsilon \zeta) f=\frac{\epsilon^{2} \zeta^{2}}{h_{1}} f
$$

Indeed, one has for $s \geq s_{0}>1 / 2$,

$$
\left|\frac{1}{h_{1}} f-f\right|_{H^{\bar{s}}}=\left|\frac{\epsilon \zeta}{h_{1}} f\right|_{H^{\bar{s}}} \lesssim|\epsilon \zeta|_{H^{\bar{s}}}\left|\frac{1}{h_{1}} f\right|_{H^{\bar{s}}} \leq \epsilon C\left(h^{-1}, \epsilon|\zeta|_{H^{\bar{s}}}\right)|f|_{H^{\bar{s}}}
$$

where we used Lemmata A.1 and A.3. The second estimate, concerning $\left|\frac{1}{h_{1}} f-(1+\epsilon \zeta) f\right|_{H^{\bar{s}}}$, is obtained identically.
