### The real primes and the Riemann hypothesis

#### **Abstract**

In this document, we deal with the concept of real prime number together with the Riemann hypothesis to the real numbers. Thus, we highlight the new hypothesis by a calculus of integral.

### The approach

The Rieman hypothesis states the non trivial zeros of the Riemann zeta function

$$\zeta(z) = \sum_{t=1}^{t=\infty} \left(\frac{1}{t^z}\right)$$

lie in the critical line :  $\frac{1}{2} + iy$ . Let us study this hypothesis.

**Definition** A real number is composed if it is equal to  $\pm p_1^{n_1}...p_i^{n_i}$  where  $p_j$  are integer prime numbers and  $n_j$  are rationals. We define other real prime numbers which can not be expressed like this :  $\pi$ , e,  $\ln(2)$ . Thus  $\sqrt[q]{p} = p^{\frac{1}{q}}$  is composed.

Also  $\sqrt[p]{p} + 1$  is prime, with p prime, hence  $\sqrt{p} - 1 = (p-1)(\sqrt{p} + 1)^{-1}$  is composed!

And  $\pi$  and e are primes in stead of  $\pi^{n_0}$  and  $e^{m_0}$  with  $(n_0 - 1)(m_0 - 1) \neq 0$ . We define the GCD of two numbers : If  $p_1$  and  $p_2$  are prime real numbers

$$p_{1} \neq p_{2} \Rightarrow GCD(p_{1}, p_{2}) = 1$$

$$n_{1}n_{2} < 0 \Rightarrow GCD(p_{1}^{n_{1}}, p_{1}^{n_{2}}) = 1$$

$$n_{1}n_{2} > 0 \Rightarrow GCd(p_{1}^{n_{1}}, p_{1}^{n_{2}}) = p_{1}^{min(n_{1}, n_{2})}$$

$$GCD(p_{1}^{n_{1}} p_{2}^{n_{2}} ... p_{i}^{n_{i}}, p_{1}'''_{1} p_{2}'''_{2}' ... p_{j}'''_{j}) = \prod_{i,j} (GCD(p_{i}^{n_{i}}, p_{j}'''_{j}))$$

And if  $x = p_1^{n_1} p_2^{n_2} ... p_i^{n_i}$  and  $y = p_{l_1}^{m_{l_1}} ... p_{l_i}^{m_{l_j}}$  then y divises x if  $1 < l_k < i$  and for  $l_i = j$ ,  $n_j m_{l_i} > 0$ ,  $|m_{l_i}| < |n_j|$ .

Thus  $\frac{3}{2}$  does not divise the prime 3, for example.

Let, now, for t integer, the zeta function of Riemann

$$\zeta(z) = \sum_{t=1}^{t=\infty} \left(\frac{1}{t^z}\right)$$

Euler has proved the following formula

$$\zeta z) = \prod_{p=prime} \left( \frac{1}{1 - p^{-z}} \right)$$

It remains true for p real prime number, but here, for p real

$$\zeta(z) = \prod_{p=prime} \left(\frac{1}{1 - p^{-z}}\right) = \int_{t=1}^{t=\infty} \left(\frac{dt}{t^z}\right)$$

And

$$\zeta(z) = \lim_{t \to \infty} \left( \frac{t^{1-z} - 1}{1 - z} \right)$$

And

$$\lim_{t \to \infty} (t^{1 - \frac{1}{2} - iy}) = \lim_{t \to \infty} (t^{\frac{1}{2} - iy})$$

$$= \lim_{t \to \infty} (t^{\frac{1}{2} + iy}) = a = \frac{1}{2} \lim_{t \to \infty} (t^{\frac{1}{2} - iy} + t^{\frac{1}{2} + iy})$$

$$\Rightarrow \lim_{t \to \infty} (t^{2(\frac{1}{2} + iy)} - 2at^{\frac{1}{2} + iy} + 1) = 0$$

Hence

$$\lim_{t \to \infty} (t^{\frac{1}{2} + iy}) = a = a \pm \sqrt{a^2 - 1} = 1$$

Thus

$$\zeta(\frac{1}{2} + iy) = \lim_{t \to \infty} \left(\frac{t^{\frac{1}{2} - iy} - 1}{\frac{1}{2} - iy}\right) = 0$$

And with  $x \neq 0$ 

$$\zeta(x+iy) = \lim_{t \to \infty} \left(\frac{t^{1-x-iy}-1}{1-x-iy}\right) = 0$$
$$= \lim_{t \to \infty} \left(\frac{t^{\frac{1}{2}-iy+\frac{1}{2}-x}-1}{1-x-iy}\right)$$
$$= \lim_{t \to \infty} \left(\frac{t^{\frac{1}{2}-x}-1}{1-x-iy}\right) = 0 \Rightarrow x = \frac{1}{2}$$

And we see that trivial zeros are z = -2k and non trivial zero lies in  $z = \frac{1}{2} + iy$ .

We have proved the hypothesis for real numbers. The Riemann hypothesis is important because it gives information about the zeros of  $\zeta(z)$  and the distribution of those zeros are related to real primes!

### Conclusion

We did not present it like this, but we have given a proof of the Riemann hypothesis for real numbers.
