# WEAK ERROR EXPANSION OF THE IMPLICIT EULER SCHEME 

OMAR ABOURA

Abstract. In this paper, we extend the Talay Tubaro theorem to the implicit Euler scheme.

## 1. Introduction

Let $(\Omega, \mathcal{F}, P)$ a probability space and $T>0$ a fixed time. $W$ will be a Brownian motion in $\mathbf{R}$ with respect to his own filtration $\mathcal{F}_{t}$. We will consider the following stochastic differential equation

$$
\begin{equation*}
X_{t}=x+\int_{0}^{t} b\left(X_{s}\right) d s+\int_{0}^{t} \sigma\left(X_{s}\right) d W_{s} \tag{1.1}
\end{equation*}
$$

where $x \in \mathbf{R}, b$ and $\sigma$ are real functions defined on $\mathbf{R}$. It is well know that, under Lipschitz conditions on $b$ and $\sigma$, this equation admits a unique strong solution.

For various reasons, including mathematical finance or partial differential equations, the approximation of $E f\left(X_{T}\right)$ is of importance. One way to do this is to use an Euler scheme and to study the speed of convergence. There is a vast literature on this subject and one of the pioneering work is the paper of D. Talay and L. Tubaro [7].

Let $N \in \mathbf{N}^{*}$ and $h:=T / N$. Consider $\left(t_{k}\right)_{0 \leq k \leq N}$ the uniform subdivision of $[0, T]$ defined by $t_{k}:=k h$. In their paper [7] the authors deal with the explicit Euler scheme $\left(\bar{X}_{t_{k}}\right)_{0 \leq k \leq N}$ defined as: $\bar{X}_{t_{0}}=x$ and for $k=0, \ldots, N-1$,

$$
\begin{equation*}
\bar{X}_{t_{k+1}}=\bar{X}_{t_{k}}+b\left(\bar{X}_{t_{k}}\right) h+\sigma\left(\bar{X}_{t_{k}}\right) \Delta W_{k+1} \tag{1.2}
\end{equation*}
$$

where $\Delta W_{k+1}:=W_{t_{k+1}}-W_{t_{k}}$. They study the weak error $E f\left(\bar{X}_{T}\right)-E f\left(X_{T}\right)$.
Here, we will use the implicit Euler scheme defined as follow: $X_{t_{0}}^{N}=x$ and for $k=$ $0, \ldots, N-1$,

$$
\begin{equation*}
X_{t_{k+1}}^{N}=X_{t_{k}}^{N}+b\left(X_{t_{k+1}}^{N}\right) h+\sigma\left(X_{t_{k}}^{N}\right) \Delta W_{k+1} \tag{1.3}
\end{equation*}
$$

Despite the fact that this implicit scheme cannot be implemented in most cases, it has been studied in [5] but, to the best of our knowledge, its weak error expansion has not been given. The main reason of this study is that we believe it would be a step in order to study a weak convergence error for SPDEs. So far in that framework only few cases have been studied in [2]-[4] for the stochastic heat or Schrödinger equation.
Notations. Let $n \in \mathbf{N}$ and $v, w:[0, T] \times \mathbf{R} \rightarrow \mathbf{R}$ be smooth functions. We will denote by $\partial^{n} v(t, x)$ the $n^{t h}$ derivative of $v$ with respect to the space variable $x$, except for the second derivative denoted $\Delta v(t, x)$ as usual. Moreover, by an abuse of notation, for a function $v: \mathbf{R} \rightarrow \mathbf{R}$ and $w:[0, T] \times \mathbf{R} \rightarrow \mathbf{R}$, we will write $(v w)(t, x):=v(x) w(t, x)$.

Given $p \in \mathbf{N}, C_{p}$ will denote a constant that depends on $p, T$ and the coefficients $b$ and $\sigma$, but does not depend on $N$. As usual, $C_{p}$ may change from line to line.

For $h$ small enough, we denote by $S_{h}$ the functions defined on $\mathbf{R}$ by

$$
\begin{equation*}
S_{h}(x):=1 /\left(1-h b^{\prime}(x)\right) . \tag{1.4}
\end{equation*}
$$

It is similar to the map used by Debussche in [3].

## 2. The main Result

Let $u$ the (classical) solution of the following pde, called the Kolmogorov equation:

$$
\left\{\begin{array}{l}
\frac{\partial}{\partial t} u(t, x)+b(x) \partial u(t, x)+\frac{1}{2} \sigma^{2}(x) \Delta u(t, x)=0  \tag{2.1}\\
u(T, x)=f(x)
\end{array}\right.
$$

The properties of $u$ will be given in the next section. Let us mention that for $b$ and $\sigma$ smooth enough, $u$ is smooth too. We define the function $\psi_{i}:[0, T] \times \mathbf{R} \rightarrow \mathbf{R}$, where $i$ stands for implicit, as follows for a smooth enough function $u$ :

$$
\begin{equation*}
\psi_{i}:=\frac{1}{2} b \partial(b \partial u)+\frac{1}{4} \sigma^{2} \Delta(b \partial u)-\frac{1}{2} b^{2} \Delta u+\frac{1}{8} \sigma^{4} \partial^{4} u-\frac{1}{4} b \partial\left(\sigma^{2} \Delta u\right)-\frac{1}{8} \sigma^{2} \Delta\left(\sigma^{2} \Delta u\right) . \tag{2.2}
\end{equation*}
$$

We are now in position to state the main result of this paper.
Theorem 2.1. Let $b, \sigma, f$ be $C^{\infty}$-functions with bounded derivatives.
(i) The implicit Euler scheme (1.3) is of weak order 1, that is, there exists a constant $C$, such that for $h$ small enough $\left|E f\left(X_{T}^{N}\right)-E f\left(X_{T}\right)\right| \leq C h$.
(ii) The weak error can be expanted as

$$
E f\left(X_{T}^{N}\right)-E f\left(X_{T}\right)=h E \int_{0}^{T} \psi_{i}\left(t, X_{t}\right) d t+O\left(h^{2}\right)
$$

We have not given the minimal hypothesis; indeed we want to focus on the ideas and not on the best set of assumptions. The proof of this theorem is quite long; it uses intensively the Kolmogorov equation (2.1), the Itô and Clark-Ocone formulas. It will be proved in the next section. We at first compare our result with that of Talay Tubaro. In their paper [7], the authors introduce the following function

$$
\psi_{e}=\frac{1}{2} b^{2} \Delta u+\frac{1}{2} b \sigma^{2} \partial^{3} u+\frac{1}{8} \sigma^{4} \partial^{4} u+\frac{1}{2} \frac{\partial^{2}}{\partial t^{2}} u+b \frac{\partial}{\partial t} \partial u+\frac{1}{2} \sigma^{2} \frac{\partial}{\partial t} \Delta u
$$

and prove the following result (see [7] page 489).
Theorem 2.2. Let $\left(\bar{X}_{t_{k}}\right)_{k=0, \ldots, N}$ denote the explicit Euler scheme defined by (1.2). Then weak error has the following expansion

$$
E f\left(\bar{X}_{T}\right)-E f\left(X_{T}\right)=h E \int_{0}^{T} \psi_{e}\left(t, X_{t}\right) d t+O\left(h^{2}\right)
$$

Applying $\frac{\partial}{\partial t}, b \partial$ and finally $\frac{1}{2} \sigma^{2} \Delta$ to (2.1) and summing these equations we have

$$
\frac{\partial^{2}}{\partial t^{2}} u+2 b \partial \frac{\partial}{\partial t} u+\sigma^{2} \Delta \frac{\partial}{\partial t} u=-b \partial(b \partial u)-\frac{1}{2} b \partial\left(\sigma^{2} \Delta u\right)-\frac{1}{2} \sigma^{2} \Delta(b \partial u)-\frac{1}{4} \sigma^{2} \Delta\left(\sigma^{2} \Delta u\right)
$$

So we can rewrite the function $\psi_{e}$ as
$\psi_{e}=\frac{1}{2} b^{2} \Delta u+\frac{1}{2} b \sigma^{2} \partial^{3} u+\frac{1}{8} \sigma^{4} \partial^{4} u-\frac{1}{2} b \partial(b \partial u)-\frac{1}{4} b \partial\left(\sigma^{2} \Delta u\right)-\frac{1}{4} \sigma^{2} \Delta(b \partial u)-\frac{1}{8} \sigma^{2} \Delta\left(\sigma^{2} \Delta u\right)$
For $b=0$, we have $\psi_{e}=\psi_{i}=\frac{1}{8} \sigma^{4} \partial^{4} u-\frac{1}{8} \sigma^{2} \Delta\left(\sigma^{2} \Delta u\right)$ as expected since in this case the explicit and the implicit Euler scheme coincide. We can notice that $\psi_{i}=\psi_{e}-b^{2} \Delta u+$ $\frac{1}{2} \sigma^{2} \Delta(b \partial u)+b \partial(b \partial u)-\frac{1}{2} b \sigma^{2} \partial^{3} u$.

## 3. Proof Theorem 2.1

Here is a sketch of the proof: After proving some property of the scheme, we introduce a continuous interpolation of this scheme. Finally, after decomposing the weak error, we study a remainder term.

### 3.1. Some tools.

Proposition 3.1 (Property of $u$ ). Let $\left(X_{s}^{t, x}\right)_{s \in[t, T]}$ denote the stochastic flow, that is the solution of (1.1) starting from $x$ at time $t$ and let $u(t, x)=E f\left(X_{T}^{t, x}\right)$. Then $u$ belongs to $C^{\infty, \infty}([0, T] \times \mathbf{R})$ and satisfies the Kolmogorov equation (2.1). Moreover, for any $n, p \in \mathbf{N}$, there exists constants $C$ and $k$ such that

$$
\left|\frac{\partial^{n}}{\partial t^{n}} \partial^{p} u(t, x)\right| \leq C\left(1+|x|^{k}\right)
$$

See for example [7] page 486 Lemma 2.
Now we recall several results from Malliavin Calculus that will be used in the sequel. For a detailled introduction, we send the reader to D.Nualart's book [6].
Proposition 3.2 (Clark-Ocone formula). Let $t \in[0, T]$ and $F \in L^{2}\left(\mathcal{F}_{t}\right) \cap D^{1,2}$; then we have for all $s \in[0, t]$

$$
F=E\left(F \mid \mathcal{F}_{s}\right)+\int_{s}^{t} E\left(D_{r} F \mid \mathcal{F}_{r}\right) d W_{r}
$$

Lemma 3.3. Let $F, G \in D^{1,2}$.
(i) If $F$ and $D F$ are bounded, then $F G \in D^{1,2}$ and $D(F G)=F D G+G D F$.
(ii) Let $f \in C^{1}$ with a bounded derivative; then $f(F) \in D^{1,2}$ and $D f(F)=f^{\prime}(F) D F$.
(iii) Let $(s, t) \in[0, T]^{2}$ such that $s<t$ and let $F \in D^{1,2} \cap L^{2}\left(\mathcal{F}_{s}\right)$. Then $F\left(W_{t}-W_{s}\right) \in$ $D^{1,2}$ and

$$
D_{r}\left[F\left(W_{t}-W_{s}\right)\right]=D_{r} F\left(W_{t}-W_{s}\right)+F 1_{\{s \leq r \leq t\}}
$$

(iv) $\operatorname{Let}\left\{H_{n}, n \geq 1\right\}$ be a sequence of random variables in $D^{1,2}$ that converges to $H$ in $L^{2}(\Omega)$ and such that $\sup _{n} E\left(\left\|D H_{n}\right\|_{L^{2}(0, T)}^{2}\right)<\infty$. Then $H$ belongs to $D^{1,2}$.

For a proof of (iii), see [6] Lemma 1.3.4. Now we state some technical lemmas that will be useful in the sequel. The following discrete Gronwall lemma is classical.

Lemma 3.4 (Gronwall's lemma). For any nonnegative sequences $\left(a_{k}\right)_{0 \leq k \leq N}$ and $\left(b_{k}\right)_{0 \leq k \leq N}$ satisfying $a_{k+1} \leq(1+C h) a_{k}+b_{k+1}$, with $C>0$. Then we have $a_{k} \leq e^{C\left(T-t_{k}\right)}\left(a_{0}+\sum_{i=1}^{k} b_{i}\right)$.
Lemma 3.5. Let $L>0$; then for $h^{*}$ small enough (more precisely $L h^{*}<1$ ) there exists $\Gamma:=\frac{L}{1-L h^{*}}>0$ such that for all $h \in\left(0, h^{*}\right)$ we have $\frac{1}{1-L h}<1+\Gamma h$.
Proof. Let $h \in\left(0, h^{*}\right)$; then we have $1-L h>1-L h^{*}>0$. Hence $\frac{L}{1-L h}<\frac{L}{1-L h^{*}}=\Gamma$, so that $L h<\Gamma h(1-L h)$, which yields $1+\Gamma h-L h-\Gamma L h^{2}=(1+\Gamma h)(1-L h)>1$. This concludes the proof.
Lemma 3.6 (Generalization of Young's lemma). For an integer $p \geq 1$ and for $\epsilon>0$, we have

$$
(a+b)^{2^{p}} \leq(1+\epsilon)^{2^{p}-1} a^{2^{p}}+\left(1+\frac{1}{\epsilon}\right)^{2^{p}-1} b^{2^{p}}
$$

Proof. We use an induction argument. The inequality is true for $p=1$, that is $(a+b)^{2} \leq$ $(1+\epsilon) a^{2}+\left(1+\frac{1}{\epsilon}\right) b^{2}$. Now, suppose that it is true until $p$ and will prove it for $p+1$; indeed the induction hypothesis yields

$$
\begin{aligned}
(a+b)^{2^{p+1}} & \leq\left|(1+\epsilon)^{2^{p}-1} a^{2^{p}}+\left(1+\frac{1}{\epsilon}\right)^{2^{p}-1} b^{2^{p}}\right|^{2} \\
& \leq(1+\epsilon)\left|(1+\epsilon)^{2^{p}-1}\right|^{2}\left|a^{2^{p}}\right|^{2}+\left(1+\frac{1}{\epsilon}\right)\left|\left(1+\frac{1}{\epsilon}\right)^{2^{p}-1}\right|^{2}\left|b^{2^{p}}\right|^{2} .
\end{aligned}
$$

This concludes the proof.

### 3.2. Property of the implicit Euler scheme.

Lemma 3.7 (Existence of the scheme). For small h, the implicit Euler scheme (1.3) is well defined. Moreover, for all $k=0, \ldots, N$, we have $X_{t_{k}}^{N} \in L^{2}\left(\mathcal{F}_{t_{k}}\right)$.

We will denote by $N_{0}$ the smallest integer such that the scheme is well defined.
Proof. For $k=0$, we have $X_{t_{0}}^{N}=x \in L^{2}\left(\mathcal{F}_{t_{k}}\right)$. Suppose that for all $j=0, \ldots, k$, $X_{t_{j}}^{N}$ is well defined and belongs to $L^{2}\left(\mathcal{F}_{t_{j}}\right)$; we prove this for $j=k+1$. We define $\xi_{k+1}:=X_{t_{k}}^{N}+\sigma\left(X_{t_{k}}^{N}\right) \Delta W_{k+1}$. By independence of $\Delta W_{k+1}$ and $\mathcal{F}_{t_{k}}$ and the linear growth of $\sigma$, we have that $\xi_{k+1} \in L^{2}(\Omega)$. Let $F_{k+1}: L^{2}(\Omega) \rightarrow L^{2}(\Omega)$ be defined by

$$
\begin{equation*}
F_{k+1}(X):=\xi_{k+1}+b(X) h \tag{3.1}
\end{equation*}
$$

for all $X \in L^{2}(\Omega)$. Using the Lipschitz property of $b$ we have $E\left|F_{k+1}(X)-F_{k+1}(Y)\right|^{2} \leq$ $\left|\left\|b^{\prime}\right\|_{\infty} h\right|^{2} E|X-Y|^{2}$. So by the fixed point theorem, if $\left\|b^{\prime}\right\|_{\infty} h<1$ there exist an unique element of $L^{2}(\Omega)$, noted $X_{t_{k+1}}^{N}$, such that $X_{t_{k+1}}^{N}=F_{k+1}\left(X_{t_{k+1}}^{N}\right)$. The measurability of $X_{t_{k+1}}^{N}$ with respect to $\mathcal{F}_{t_{k+1}}$ is obvious.

Lemma 3.8 (Malliavin derivability). Let $h>0$ small enough; then for all $k=0, \ldots, N$, we have $X_{t_{k}}^{N} \in D^{1,2}$. Moreover, for all $t \in\left[t_{k}, t_{k+1}\right)$, we have $D_{t} X_{t_{k+1}}^{N}=S_{h}\left(X_{t_{k+1}}^{N}\right) \sigma\left(X_{t_{k}}^{N}\right)$, where $S_{h}$ is defined by (1.4).

Proof. It is true for $k=0$, since $X_{0}^{N}=x$. Now suppose that for all $j=1, \ldots, k$, $X_{t_{j}}^{N} \in D^{1,2}$ and prove that $X_{t_{k+1}}^{N} \in D^{1,2}$. First, we define the following sequence in $L^{2}(\Omega)$ : $X_{k+1}^{N}(0)=0$ and for $i \geq 0, X_{k+1}^{N}(i+1)=F_{k+1}\left(X_{k+1}^{N}(i)\right)$ where $F_{k+1}$ is defined by (3.1). Using the Lipschitz property of $F_{k+1}$, since $X_{t_{k+1}}^{N}$ is a fixed point of $F_{k+1}$, we have

$$
E\left|X_{t_{k+1}}^{N}-X_{k+1}^{N}(i+1)\right|^{2} \leq\left|\left\|b^{\prime}\right\|_{\infty} h\right|^{2} E\left|X_{t_{k+1}}^{N}-X_{k+1}^{N}(i)\right|^{2} \leq\left(\left|\left\|b^{\prime}\right\|_{\infty} h\right|^{2}\right)^{i+1} E\left|X_{t_{k+1}}^{N}\right|^{2}
$$

So $X_{k+1}^{N}(i)$ converge to $X_{t_{k+1}}^{N}$ in $L^{2}(\Omega)$ if $\left\|b^{\prime}\right\|_{\infty} h<1$. Using the induction hypothesis, the assumptions on $\sigma$ and Lemma 3.3 (ii) and (iii), we deduce that $\xi_{k+1}=X_{t_{k}}^{N}+$ $\sigma\left(X_{t_{k}}^{N}\right) \Delta W_{k+1}$ belongs to $D^{1,2}$. Finally, since $b$ is Lipschitz, we deduce by induction that for all $i \geq 0 X_{k}^{N}(i) \in D^{1,2}$. Moreover we have $D X_{k}^{N}(i+1)=D \xi_{k+1}+h b^{\prime}\left(X_{k}^{N}(i)\right) D X_{k}^{N}(i)$ and $D X_{k+1}^{N}(0)=0$, so that

$$
\left\|D X_{t_{k}}^{N}(i+1)\right\|_{L^{2}(0, T)}^{2} \leq 2\left\|D \xi_{k+1}\right\|_{L^{2}(0, T)}^{2}+2 h^{2}\left\|b^{\prime}\right\|_{\infty}^{2}\left\|D X_{t_{k}}^{N}(i)\right\|_{L^{2}(0, T)}^{2}
$$

An induction argument yields for $i \geq 1$ and $2 h^{2}\left\|b^{\prime}\right\|_{\infty}^{2}<1$,

$$
\left\|D X_{t_{k}}^{N}(i)\right\|_{L^{2}(0, T)}^{2} \leq 2 \frac{\left\|D \xi_{k+1}\right\|_{L^{2}(0, T)}^{2}}{1-2 h^{2}\left\|b^{\prime}\right\|_{\infty}^{2}}
$$

Finally, we have $\sup _{i}\left\|D X_{k}^{N}(i)\right\|<\infty$. Lemma 3.3 (iv) proves that $X_{t_{k+1}}^{N} \in D^{1,2}$. Finally, let $t \in\left[t_{k}, t_{k+1}\right)$; applying the Malliavin derivative $D$ to (1.3) and using Lemma 3.3 we have

$$
D_{t} X_{t_{k+1}}^{N}=h b^{\prime}\left(X_{t_{k+1}}^{N}\right) D_{t} X_{t_{k+1}}^{N}+\sigma\left(X_{t_{k}}^{N}\right)
$$

which concludes the proof.
The following result gives a bound of $p^{t h}$ moments of the implicit scheme.

Lemma 3.9. Fix $p \geq 1$; then for $N_{0}$ large enough, there exists a constant $C(p)>0$ such that

$$
\begin{equation*}
\sup _{N \geq N_{0}} \max _{k=0, \ldots, N} E\left|X_{t_{k}}^{N}\right|^{p} \leq C(p) \tag{3.2}
\end{equation*}
$$

Proof. Holder's inequality shows that it suffices to consider moments which are power of 2 , that is to check $\sup _{N \geq N_{0}} \max _{k=0, \ldots, N} E\left|X_{t_{k}}^{N}\right|^{2^{p}} \leq C_{p}$, for every integer $p \geq 1$. Using the generalized Young Lemma 3.6 the independence between $\Delta W_{k+1}$ and $\mathcal{F}_{t_{k}}$, and the fact that for all $j \in \mathbf{N}, E\left(\Delta W_{k+1}\right)^{2 j+1}=0$, we have for $h \in\left(0, h^{*}\right)$ and some constant $C_{p}$ depending on $h^{*}$

$$
\begin{aligned}
& E\left|X_{t_{k+1}}^{N}\right|^{2^{p}} \leq(1+h)^{2^{p}-1} E\left|X_{t_{k}}^{N}+\sigma\left(X_{t_{k}}^{N}\right) \Delta W_{k+1}\right|^{2^{p}} \\
& \quad+\left(1+\frac{1}{h}\right)^{2^{p}-1} h^{2^{p}} E\left|b\left(X_{t_{k+1}}^{N}\right)\right|^{2^{p}} \\
& \leq\left(1+C_{p} h\right) E\left|X_{t_{k}}^{N}\right|^{2^{p}}+\left(1+C_{p} h\right) \sum_{j=1, \ldots, 2^{p-1}}\binom{2^{p}}{2 j} E\left(\left|X_{t_{k}}^{N}\right|^{2^{p}-2 j}\left|\sigma\left(X_{t_{k}}^{N}\right)\right|^{2 j}\right) E\left|\Delta W_{k+1}\right|^{2 j} \\
& \quad+C_{p} h\left(1+E\left|X_{t_{k+1}}^{N}\right|^{2^{p}}\right)
\end{aligned}
$$

Using the identity $E\left|\Delta W_{k+1}\right|^{2 j}=C(2 j) h^{j}$ and the linear growth of $\sigma$ we deduce for $h<1$

$$
\begin{aligned}
E\left|X_{t_{k+1}}^{N}\right|^{2^{p}} \leq & \left(1+C_{p} h\right) E\left|X_{t_{k}}^{N}\right|^{2^{p}}+C_{p} h+C_{p} h E\left|X_{t_{k+1}}^{N}\right|^{2^{p}} \\
& +\left(1+C_{p} h\right) C_{p} h \sum_{j=1, \ldots, 2^{p-1}} E\left(\left|X_{t_{k}}^{N}\right|^{2^{p}-2 j}\left(1+\left|X_{t_{k}}^{N}\right|^{2 j}\right)\right)
\end{aligned}
$$

Using the inequality: $a^{2^{p+1}-2 j} \leq a^{2^{p+1}}+1$ valid for any $a>0$, we get for some constant $C_{p}>0$ and $h<1$

$$
E\left|X_{t_{k+1}}^{N}\right|^{2^{p}} \leq\left(1+C_{p} h\right) E\left|X_{t_{k}}^{N}\right|^{2^{p}}+C_{p} h+C_{p} h E\left|X_{t_{k+1}}^{N}\right|^{2^{p}}
$$

Provided that $h$ is small enough, the Gronwall Lemma 3.4 and Lemma 3.5 conclude the proof.
3.3. Some martingales and related process: $\beta_{t}^{k, N}, z_{t}^{k, N}, \gamma_{t}^{k, N}$ and $\eta_{t}^{k, N}$. Let $k \in$ $\{0, \ldots, N-1\}$ be fixed; in the sequel, we will use the following processes defined for $t \in\left[t_{k}, t_{k+1}\right]$

& \beta_{t}^{k, N}:=E\left(b\left(X_{t_{k+1}}^{N}\right) \mid \mathcal{F}_{t}\right), \quad z_{t}^{k, N}:=E\left(D_{t} b\left(X_{t_{k+1}}^{N}\right) \mid \mathcal{F}_{t}\right)  \tag{3.3}\\
& \gamma_{t}^{k, N}:=\sigma\left(X_{t_{k}}^{N}\right)+\left(t-t_{k}\right) z_{t}^{k, N}, \quad \eta_{t}^{k, N}:=\sigma\left(X_{t_{k}}^{N}\right) E\left(D_{t}\left(S_{h} b^{\prime}\right)\left(X_{t_{k+1}}^{N}\right) \mid \mathcal{F}_{t}\right)
\end{align*}
$$

The following lemma describes the time evolution of these processes.
Lemma 3.10. For all $k=0, \ldots, N-1$, and for $t \in\left[t_{k}, t_{k+1}\right]$, we have the following relation

d \eta_{t}^{k, N}=\left|\sigma\left(X_{t_{k}}^{N}\right)\right|^{2} E\left(D_{t}\left(S_{h}^{3} b^{\prime \prime}\right)\left(X_{t_{k+1}}^{N}\right) \mid \mathcal{F}_{t}\right) d W_{t}
\end{array}
$$

Proof. Let $k=0, \ldots, N-1$ and let $t \in\left[t_{k}, t_{k+1}\right]$. Lemmas 3.3 (ii), 3.7 and 3.8 and the bounds of $\left\|b^{\prime \prime}\right\|_{\infty}$ imply that $b\left(X_{t_{k+1}}^{N}\right) \in L^{2}\left(\mathcal{F}_{t_{k+1}}\right) \cap D^{1,2}$ and

D_{t} b\left(X_{t_{k+1}}^{N}\right)=b^{\prime}\left(X_{t_{k+1}}^{N}\right) D_{t} X_{t_{k+1}}^{N}=\left(S_{h} b^{\prime}\right)\left(X_{t_{k+1}}^{N}\right) \sigma\left(X_{t_{k}}^{N}\right) . \tag{3.4}
\end{equation*}
$$

So the Clark-Ocone formula in Proposition 3.2 yields $\beta_{t}^{k, N}=b\left(X_{t_{k+1}}^{N}\right)-\int_{t}^{t_{k+1}} z_{s}^{k, N} d W_{s}$ and hence $d \beta_{t}^{k, N}=z_{t}^{k, N} d W_{t}$; where $z_{s}^{k, N}=E\left(D_{s} b\left(X_{t_{k+1}}^{N}\right) \mid \mathcal{F}_{s}\right)$; using (3.4)

z_{s}^{k, N}=\sigma\left(X_{t_{k}}^{N}\right) E\left(\left(S_{h} b^{\prime}\right)\left(X_{t_{k+1}}^{N}\right) \mid \mathcal{F}_{s}\right) . \tag{3.5}
\end{equation*}
$$

So taking conditionnal expectation with respect to $\mathcal{F}_{t}$, we have (3.5). Since $b^{\prime \prime}$ is bounded and $b^{\prime}$ Lipschitz we have that for $h$ small enough, $S_{h} b^{\prime}=\frac{b^{\prime}}{1-h b^{\prime}} \in C_{b}^{1}$. So we can conclude that $\left(S_{h} b^{\prime}\right)\left(X_{t_{k+1}}^{N}\right) \in D^{1,2}$ and using the Clark-Ocone formula we deduce that for $s \in$ $\left[t_{k}, t_{k+1}\right)$,

$$

and hence

d z_{s}^{k, N}=\sigma\left(X_{t_{k}}^{N}\right) E\left(\left.D_{s}\left[\frac{b^{\prime}}{1-h b^{\prime}}\left(X_{t_{k+1}}^{N}\right)\right] \right\rvert\, \mathcal{F}_{s}\right) d W_{s}=\eta_{s}^{k, N} d W_{s} .
$$

The differential of $\gamma_{t}^{k, N}$ is a consequence of the previous result and Itô's formula. Finally, since $S_{h} b^{\prime} \in C_{b}^{1}$ and $\left(S_{h} b^{\prime}\right)^{\prime}=S_{h}^{2} b^{\prime \prime}$, Lemma 3.8 implies that $D_{t}\left(S_{h} b^{\prime}\right)\left(X_{t_{k+1}}^{N}\right)=$ $\sigma\left(X_{t_{k}}^{N}\right)\left(S_{h}^{3} b^{\prime \prime}\right)\left(X_{t_{k+1}}^{N}\right)$ and then

\eta_{t}^{k, N}=\left|\sigma\left(X_{t_{k}}^{N}\right)\right|^{2} E\left(\left(S_{h}^{3} b^{\prime \prime}\right)\left(X_{t_{k+1}}^{N}\right) \mid \mathcal{F}_{t}\right) . \tag{3.6}
\end{equation*}
$$

Applying once more the Clark-Ocone formula in Proposition 3.2, we deduce

Multiplying this by $\left|\sigma\left(X_{t_{k}}^{N}\right)\right|^{2}$ and using (3.6), we conclude the proof.
The next lemma provides uniform moment estimates of the above processes.
Lemma 3.11. Let $p \in \mathbf{N}$; then for $N_{0}$ large enough there exists a constant $C_{p}$ such that for $N \geq N_{0}$,

The identity (3.5), Jensen's inequality, the growth property of $\sigma$ and the upper estimate $b^{\prime} /\left(1-h b^{\prime}\right) \geq C$ for small $h$, Schwarz's inequality and Lemma 3.9 yield

Using the definition of $\gamma_{t}^{k, N}$ in (3.3) and the previous upper estimates we deduce

E\left|\gamma_{t}^{k, N}\right|^{p} \leq C_{p} E\left|\sigma\left(X_{t_{k}}^{N}\right)\right|^{p}+C_{p} h^{p} E\left|z_{t}^{k, N}\right|^{p} \leq C_{p}

Finally (3.6), the Jensen inequality, the growth condition on $\sigma$, the upper bounds of $b^{\prime}$ and $b^{\prime \prime}$, Lemma 3.9 and Schwarz's inequality yield

This concludes the proof.
3.4. Continuous interpolation. As usual we need to introduce a continuous process that interpolates the implicit Euler scheme (1.3). With an abuse of notation, let $\left(X_{t}^{N}\right)_{t \in[0, T]}$ be the process defined as follow: $X_{0}^{N}=x_{0}$ and for $k=0, \ldots, N-1$ and $t_{k} \leq t \leq t_{k+1}$

X_{t}^{N}:=X_{t_{k}}^{N}+E\left(b\left(X_{t_{k+1}}^{N}\right) \mid \mathcal{F}_{t}\right)\left(t-t_{k}\right)+\sigma\left(X_{t_{k}}^{N}\right)\left(W_{t}-W_{t_{k}}\right) . \tag{3.7}
\end{equation*}
$$

This process satisfies the following
Lemma 3.12. The process $\left(X_{t}^{N}\right)_{t \in[0, T]}$ is continuous $\mathcal{F}_{t}$-adapted and is an interpolation of the scheme (1.3). Moreover, for $k \in\{0, \ldots, N-1\}$ and $t \in\left[t_{k}, t_{k+1}\right]$ we have $d X_{t}^{N}=$ $\beta_{t}^{k, N} d t+\gamma_{t}^{k, N} d W_{t}$, where the process $\left(\beta_{t}^{k, N}\right)$ and $\left(\gamma_{t}^{k, N}\right)$ are defined by (3.3).
Remark 3.13. (1) If $b=0$, (3.7) corresponds to the classical interpolation given by Talay Tubaro [7], since the explicit and implicit Euler scheme are the same.
(2) If $b$ is linear, this continuous process differs from that used by Debussche in [3]. Indeed, the finite dimensional analog of the interpolation correponding to the process $d X_{t}=$ $-\beta X_{t} d t+\sigma\left(X_{t}\right) d W_{t}$, is defined by

for $t \in\left[t_{k}, t_{k+1}\right]$ (see [3] page 96 equation (3.2)). In this particular case, our interpolation is given by

X_{t}^{N}=X_{t_{k}}^{N}+\int_{t_{k}}^{t} E\left(-\beta X_{t_{k+1}}^{N} \mid \mathcal{F}_{s}\right) d s+\int_{t_{k}}^{t}\left\{\sigma\left(X_{t_{k}}^{N}\right)+\left(s-t_{k}\right) E\left(-D_{s} \beta X_{t_{k+1}}^{N} \mid \mathcal{F}_{s}\right)\right\} d W_{s} .
$$

Proof of Lemma 3.12. The fact that $\left(X_{t}^{N}\right)$ is an $\left(\mathcal{F}_{t}\right)$-adapted process which interpolates the scheme (1.3) is a consequence of (3.7). The continuity is a consequence of the fact that the map $\left(t \mapsto E\left(X \mid \mathcal{F}_{t}\right)\right)$ has a continuous modification. So, applying Itô's formula and Lemma 3.10, we obtain $d\left(\beta_{t}^{k, N}\left(t-t_{k}\right)\right)=\left(t-t_{k}\right) z_{t}^{k, N} d W_{t}+\beta_{t}^{k, N} d t$, and hence

This concludes the proof.
We next give moment estimates of the interpolation process $X_{t}^{N}$.
Lemma 3.14. Let $p \geq 1$ and $h^{*}>0$ be small enough. There exits a constant $C_{p}>0$ depending on $h^{*}$ such that

Proof. Using Lemma 3.9, Jensen's inequality and the independence of $W_{t}-W_{t_{k}}$ and $X_{t_{k}}^{N}$, we have for $t \in\left[t_{k}, t_{k+1}\right]$ :

& \leq C_{p}+C_{p} h^{p} E\left|b\left(X_{t_{k+1}}^{N}\right)\right|^{p}+E\left|\sigma\left(X_{t_{k}}^{N}\right)\right|^{p} E\left|W_{t}-W_{t_{k}}\right|^{p} .
\end{aligned}
$$

Using the growth condition on $b$ and $\sigma$, moments of the normal law and Lemma 3.9, we deduce the result.

The following is a straightforward consequence of Lemmas 3.11 and 3.14
Corollary 3.15. Let $v:[0, T] \times \mathbf{R} \rightarrow \mathbf{R}$ be a function with polynomial growth, and let $n_{1}, \ldots, n_{6}$ non negative integers. Then there exists a constant $C$ independent of $h^{*}$ such that for $r \in\left[t_{k}, t_{k+1}\right]$ and $h \in\left(0, h^{*}\right)$

E\left(\left|\beta_{r}^{k, N}\right|^{n_{1}}\left|z_{r}^{k, N}\right|^{n_{2}}\left|\gamma_{r}^{k, N}\right|^{n_{3}}\left|\eta_{r}^{k, N}\right|^{n_{4}}\left|r-t_{k}\right|^{n_{5}}\left|v\left(r, X_{r}^{N}\right)\right|^{n_{6}}\right) \leq C .
$$

3.5. Local decomposition. Now we return to the proof of the main theorem. Let $u$ be the solution to the Kolmogorov equation (2.1). Using (2.1), we decompose the weak error into a sum of local errors. Let $\delta_{k}^{N}:=E u\left(t_{k+1}, X_{t_{k+1}}^{N}\right)-E u\left(t_{k}, X_{t_{k}}^{N}\right)$; we deduce

We introduce, for $t_{k} \leq t \leq t_{k+1}$,
$\mathcal{I}_{k}^{N}(t):=E\left[\left(\beta_{t}^{k, N}-b\left(X_{t}^{N}\right)\right) \partial u\left(t, X_{t}^{N}\right)\right], \quad \mathcal{J}_{k}^{N}(t):=E\left[\left(\left|\gamma_{t}^{k, N}\right|^{2}-\sigma^{2}\left(X_{t}^{N}\right)\right) \Delta u\left(t, X_{t}^{N}\right)\right]$.
Since $u \in C^{1,2}$, using Itô's formula, Lemma 3.11 and the Kolmogorov equation (2.1) at the point $\left(t, X_{t}^{N}\right)$, we obtain

& =E \int_{t_{k}}^{t_{k+1}}\left\{\mathcal{I}_{k}^{N}(t)+\frac{1}{2} \mathcal{J}_{k}^{N}(t)\right\} d t . \tag{3.10}
\end{align*}
$$

Now for $k=0, \ldots, N-1$, we introduce the following quantities for $s \in\left[t_{k}, t_{k+1}\right]$ :

& +\frac{1}{2}\left|\gamma_{s}^{k, N}\right|^{2} \Delta(b \partial u)\left(s, X_{s}^{N}\right)-\beta_{s}^{k, N} \frac{\partial}{\partial s} \partial u\left(s, X_{s}^{N}\right) \\
& -\left(\left|\beta_{s}^{k, N}\right|^{2}+z_{s}^{k, N} \gamma_{s}^{k, N}\right) \Delta u\left(s, X_{s}^{N}\right)-\frac{1}{2} \beta_{s}^{k, N}\left|\gamma_{s}^{k, N}\right|^{2} \partial^{3} u\left(s, X_{s}^{N}\right), \\
j_{k}^{N}(s):= & \left|\gamma_{s}^{k, N}\right|^{2} \frac{\partial}{\partial s} \Delta u\left(s, X_{s}^{N}\right)+\beta_{s}^{k, N}\left|\gamma_{s}^{k, N}\right|^{2} \partial^{3} u\left(s, X_{s}^{N}\right)  \tag{3.12}\\
& +\frac{1}{2}\left|\gamma_{s}^{k, N}\right|^{4} \partial^{4} u\left(s, X_{s}^{N}\right)+2 \gamma_{s}^{k, N} z_{s}^{k, N} \Delta u\left(s, X_{s}^{N}\right) \\
& +\left|s-t_{k}\right|^{2}\left|\eta_{s}^{k, N}\right|^{2} \Delta u\left(s, X_{s}^{N}\right)+2\left(s-t_{k}\right)\left|\gamma_{s}^{k, N}\right|^{2} \eta_{s}^{k, N} \partial^{3} u\left(s, X_{s}^{N}\right) \\
& -\frac{\partial}{\partial s}\left(\sigma^{2} \Delta u\right)\left(s, X_{s}^{N}\right)-\beta_{s}^{k, N} \partial\left(\sigma^{2} \Delta u\right)\left(s, X_{s}^{N}\right)-\frac{1}{2}\left|\gamma_{s}^{k, N}\right|^{2} \Delta\left(\sigma^{2} \Delta u\right)\left(s, X_{s}^{N}\right) .
\end{align*}
$$

The next two lemmas explain that, up to some sign, $\mathcal{I}_{k}^{N}$ (resp. $\mathcal{J}_{k}^{N}$ ) can be viewed as an antiderivative of $i_{k}^{N}\left(\right.$ resp. $\left.j_{k}^{N}\right)$.

Lemma 3.16. For all $k=0, \ldots, N-1$, we have $\mathcal{I}_{k}^{N}(t)=E \int_{t}^{t_{k+1}} i_{k}^{N}(s) d s$ for $t \in\left[t_{k}, t_{k+1}\right]$.
Proof. If we denote by $A:=E\left[\beta_{t}^{k, N} \partial u\left(t, X_{t}^{N}\right)\right]-E\left[b\left(X_{t_{k+1}}^{N}\right) \partial u\left(t_{k+1}, X_{t_{k+1}}^{N}\right)\right]$ and by $B:=E\left[b\left(X_{t_{k+1}}^{N}\right) \partial u\left(t_{k+1}, X_{t_{k+1}}^{N}\right)\right]-E\left[b\left(X_{t}^{N}\right) \partial u\left(t, X_{t}^{N}\right)\right]$ we can write $\mathcal{I}_{k}^{N}(t)=A+B$.

Lemma 3.11 enables us to apply Itô's formula: Let $v:[0, T] \times \mathbf{R} \rightarrow \mathbf{R}$ be of class $C^{1,2}$; Itô's formula yields

Using this equation with Lemma 3.10 we have for $v \in C^{1,2}$

d\left[\beta_{r}^{k, N} v\left(r, X_{r}^{N}\right)\right]= & \left\{\beta_{r}^{k, N} \frac{\partial}{\partial r} v+\left|\beta_{r}^{k, N}\right|^{2} \partial v+\frac{1}{2} \beta_{r}^{k, N}\left|\gamma_{r}^{k, N}\right|^{2} \Delta v+z_{r}^{k, N} \gamma_{r}^{k, N} \partial v\right\}\left(r, X_{r}^{N}\right) d r \\
& +\left\{\beta_{r}^{k, N} \gamma_{r}^{k, N} \partial v+z_{r}^{k, N} v\right\}\left(r, X_{r}^{N}\right) d W_{r} \tag{3.14}
\end{align*}
$$

The function $\Delta u$ has polynomial growth; hence corollary 3.15 implies that $E \int_{t}^{t_{k+1}}\left\{\beta_{s}^{k, N} \gamma_{s}^{k, N} \Delta u+z_{s}^{k, N} \partial u\right\}\left(s, X_{s}^{N}\right) d W_{s}=0$. Using equation (3.14) with $v=\partial u$, integrating between $t$ and $t_{k+1}$, using the fact that $\beta_{t_{k+1}}^{k, N}=b\left(X_{t_{k+1}}^{N}\right)$ and taking expectation we obtain

Similarly, Corollary 3.15 implies that $E \int_{t}^{t_{k+1}} \gamma_{s}^{k, N} \partial(b \partial u)\left(s, X_{s}^{N}\right) d W_{s}=0$. Using (3.13) with $v=b \partial u$, integrating between $t$ and $t_{k+1}$ and taking expectation yields

The stochastic integral is centered by Corollary 3.15. This identity combined with (3.15) concludes the proof.

Lemma 3.17. For all $k=0, \ldots, N-1$, we have $\mathcal{J}_{k}^{N}(t)=E \int_{t_{k}}^{t} j_{k}^{N}(s) d s$ for $t \in\left[t_{k}, t_{k+1}\right]$.
Proof. Using (3.3) we clearly deduce that $\mathcal{J}_{k}^{N}(t)=C+D$ where

\frac{1}{2} E\left[\left|\gamma_{s}^{k, N}\right|^{4} \partial^{4} u\left(s, X_{s}^{N}\right)\right]=\frac{1}{2} E\left[\left|\sigma\left(X_{t_{k}}^{N}\right)\right|^{4} \partial^{4} u\left(t_{k}, X_{t_{k}}^{N}\right)\right]+\tilde{R}_{3}(s)
$$

where $\tilde{R}_{3}(s) \leq C h$ by Corollary 3.15 .
3.7.4. The term $\tilde{\phi}_{4}(s)=2 \gamma_{s}^{k, N} z_{s}^{k, N} \Delta u\left(s, X_{s}^{N}\right)$. Using (3.19) with $v=2 \Delta u$ we have $E\left[2 \gamma_{s}^{k, N} z_{s}^{k, N} \Delta u\left(s, X_{s}^{N}\right)\right]=E\left[2 \gamma_{t_{k}}^{k, N} z_{t_{k}} \Delta u\left(t_{k}, X_{t_{k}}^{N}\right)\right]+\tilde{R}_{4}(s)$, and Corollary 3.15 implies $\left|\tilde{R}_{4}(s)\right| \leq C h$.
3.7.5. The term $\tilde{\phi}_{5}(s):=\tilde{R}_{5}(s):=\left|s-t_{k}\right|^{2}\left|\eta_{s}^{k, N}\right|^{2} \Delta u\left(s, X_{s}^{N}\right)+2\left(s-t_{k}\right)\left|\gamma_{s}^{k, N}\right|^{2} \eta_{s}^{k, N} \partial^{3} u\left(s, X_{s}^{N}\right)$.

Using Corollary 3.15, we have $\left|\tilde{R}_{5}(s)\right| \leq C h$.
3.7.6. The term $\tilde{\phi}_{6}(s)=\frac{\partial}{\partial t}\left(\sigma^{2} \Delta u\right)\left(s, X_{s}^{N}\right)$. Using (3.13) with $v=\frac{\partial}{\partial t}\left(\sigma^{2} \Delta u\right)$, integrating between $t_{k}$ and $s$ and taking expectation, we have

$$
-E\left[\frac{\partial}{\partial t}\left(\sigma^{2} \Delta u\right)\left(s, X_{s}^{N}\right)\right]=-E\left[\frac{\partial}{\partial t}\left(\sigma^{2} \Delta u\right)\left(t_{k}, X_{t_{k}}^{N}\right)\right]+\tilde{R}_{6}(s)
$$

with $\left|\tilde{R}_{6}(s)\right| \leq C h$ by Corollary 3.15 .
3.7.7. The term $\tilde{\phi}_{7}(s)=\beta_{s}^{k, N} \partial\left(\sigma^{2} \Delta u\right)\left(s, X_{s}^{N}\right)$. Using (3.14) with $v=\partial\left(\sigma^{2} \Delta u\right)$, integrating between $t_{k}$ and $s$, taking expectation we have

$$
-E\left[\beta_{s}^{k, N} \partial\left(\sigma^{2} \Delta u\right)\left(s, X_{s}^{N}\right)\right]=-E\left[b\left(X_{t_{k}}^{N}\right) \partial\left(\sigma^{2} \Delta u\right)\left(t_{k}, X_{t_{k}}^{N}\right)\right]+\tilde{R}_{7}(s)
$$

with $\left|\tilde{R}_{7}(s)\right| \leq C h$ by Corollary 3.15.
3.7.8. The term $\tilde{\phi}_{8}(s)=\frac{1}{2}\left|\gamma_{s}^{k, N}\right|^{2} \Delta\left(\sigma^{2} \Delta u\right)\left(s, X_{s}^{N}\right)$. Using (3.17) with $v=\frac{1}{2} \Delta\left(\sigma^{2} \Delta u\right)$, integrating between $t_{k}$ and $s$, and finally taking expectation we have

$$
-\frac{1}{2} E\left[\left|\gamma_{s}^{k, N}\right|^{2} \Delta\left(\sigma^{2} \Delta u\right)\left(s, X_{s}^{N}\right)\right]=-\frac{1}{2} E\left[\left|\sigma\left(X_{t_{k}}^{N}\right)\right|^{2} \Delta\left(\sigma^{2} \Delta u\right)\left(t_{k}, X_{t_{k}}^{N}\right)\right]+\tilde{R}_{8}(s)
$$

with $\left|\tilde{R}_{8}(s)\right| \leq C h$ by Corollary 3.15 .
3.8. Proof Theorem 2.1 (i). The identity (3.18) and the upper estimate in section 3.6 and 3.7 imply that

$$
\begin{align*}
E f\left(X_{T}^{N}\right)-E f\left(X_{T}\right) & =\sum_{k=0}^{N-1} E \int_{t_{k}}^{t_{k+1}}\left\{\int_{t}^{t_{k+1}} i_{k}^{N}\left(t_{k+1}\right) d s+\frac{1}{2} \int_{t_{k}}^{t} j_{k}^{N}\left(t_{k}\right) d s\right\} d t+R \\
& =\frac{1}{2} h^{2} \sum_{k=0}^{N-1} E i_{k}^{N}\left(t_{k+1}\right)+\frac{1}{4} h^{2} \sum_{k=0}^{N-1} E j_{k}^{N}\left(t_{k}\right)+R \tag{3.21}
\end{align*}
$$

where

$$
R:=\sum_{k=0}^{N-1} \sum_{j=1}^{7} \int_{t_{k}}^{t_{k+1}} \int_{t}^{t_{k+1}} R_{j}(s) d s d t+\sum_{k=0}^{N-1} \sum_{j=1}^{8} \int_{t_{k}}^{t_{k+1}} \int_{t_{k}}^{t} \tilde{R}_{j}(s) d s d t
$$

Hence $|R| \leq C h^{2}$. Note that $\beta_{t_{k+1}}^{k, N}=b\left(X_{t_{k+1}}^{N}\right)$. Using (3.3) and (3.5) we deduce that $z_{t_{k+1}}^{k, N}=\sigma\left(X_{t_{k}}^{N}\right)\left(S_{h} b^{\prime}\right)\left(X_{t_{k+1}}^{N}\right)$ and $\gamma_{t_{k+1}}^{k, N}=\sigma\left(X_{t_{k}}^{N}\right)\left[1+h\left(S_{h} b^{\prime}\right)\left(X_{t_{k+1}}^{N}\right)\right]=\sigma\left(X_{t_{k}}^{N}\right) S_{h}\left(X_{t_{k+1}}^{N}\right)$.
Therefore, we deduce that

$$
\begin{aligned}
i_{k}^{N}\left(t_{k+1}\right)= & \frac{\partial}{\partial t}(b \partial u)\left(t_{k+1}, X_{t_{k+1}}^{N}\right)+[b \partial(b \partial u)]\left(t_{k+1}, X_{t_{k+1}}^{N}\right)+\frac{1}{2} \sigma^{2}\left(X_{t_{k}}^{N}\right)\left[S_{h}^{2} \Delta(b \partial u)\right]\left(t_{k+1}, X_{t_{k+1}}^{N}\right) \\
& -\left[b \frac{\partial}{\partial t} \partial u\right]\left(t_{k+1}, X_{t_{k+1}}^{N}\right)-\left[b^{2} \Delta u\right]\left(t_{k+1}, X_{t_{k+1}}^{N}\right)-\sigma^{2}\left(X_{t_{k}}^{N}\right)\left[b^{\prime} S_{h}^{2} \Delta u\right]\left(t_{k+1}, X_{t_{k+1}}^{N}\right) \\
& -\frac{1}{2} \sigma^{2}\left(X_{t_{k}}^{N}\right)\left[b S_{h}^{2} \partial^{3} u\right]\left(t_{k+1}, X_{t_{k+1}}^{N}\right) .
\end{aligned}
$$

Similary, $\gamma_{t_{k}}^{k, N}=\sigma\left(X_{t_{k}}^{N}\right)$. So we have

$$
\begin{aligned}
E j_{k}^{N}\left(t_{k}\right)= & E \sigma^{2} \frac{\partial}{\partial t} \Delta u\left(t_{k}, X_{t_{k}}^{N}\right)+E b\left(X_{t_{k+1}}^{N}\right) \sigma^{2} \partial^{3} u\left(t_{k}, X_{t_{k}}^{N}\right)+\frac{1}{2} E \sigma^{4} \partial^{4} u\left(t_{k}, X_{t_{k}}^{N}\right) \\
& +2 E S_{h} b^{\prime}\left(X_{t_{k+1}}^{N}\right) \sigma^{2} \Delta u\left(t_{k}, X_{t_{k}}^{N}\right)-E \frac{\partial}{\partial t}\left(\sigma^{2} \Delta u\right)\left(t_{k}, X_{t_{k}}^{N}\right) \\
& -E b\left(X_{t_{k+1}}^{N}\right) \partial\left(\sigma^{2} \Delta u\right)\left(t_{k}, X_{t_{k}}^{N}\right)-\frac{1}{2} E \sigma^{2} \Delta\left(\sigma^{2} \Delta u\right)\left(t_{k}, X_{t_{k}}^{N}\right)
\end{aligned}
$$

Notice that $b$ and $\sigma$ do not depend upon t ; hence after simplification we have

$$
\begin{align*}
i_{k}^{N}\left(t_{k+1}\right)= & b \partial(b \partial u)\left(t_{k+1}, X_{t_{k+1}}^{N}\right)-b^{2} \Delta u\left(t_{k+1}, X_{t_{k+1}}^{N}\right)+\frac{1}{2} \sigma^{2}\left(X_{t_{k}}^{N}\right)\left(S_{h}^{2} b^{\prime \prime} \partial u\right)\left(t_{k+1}, X_{t_{k+1}}^{N}\right),  \tag{3.22}\\
E j_{k}^{N}\left(t_{k}\right)= & E b\left(X_{t_{k+1}}^{N}\right) \sigma^{2} \partial^{3} u\left(t_{k}, X_{t_{k}}^{N}\right)+\frac{1}{2} E \sigma^{4} \partial^{4} u\left(t_{k}, X_{t_{k}}^{N}\right)-E b\left(X_{t_{k+1}}^{N}\right) \partial\left(\sigma^{2} \Delta u\right)\left(t_{k}, X_{t_{k}}^{N}\right) \\
& -\frac{1}{2} E \sigma^{2} \Delta\left(\sigma^{2} \Delta u\right)\left(t_{k}, X_{t_{k}}^{N}\right)+2 E b^{\prime} S_{h}\left(X_{t_{k+1}}^{N}\right) \sigma^{2} \Delta u\left(t_{k}, X_{t_{k}}^{N}\right) . \tag{3.23}
\end{align*}
$$

Corollary 3.15 implies the existence of a constant $C$, such that for all $k=0, \ldots, N-1$ :

$$
\left|E\left(i_{k}^{N}\left(t_{k+1}\right)+j_{k}^{N}\left(t_{k}\right)\right)\right| \leq C
$$

Using this bound with (3.21) proves the first part of Theorem 2.1.
3.9. Proof Theorem 2.1 (ii). We at first prove the following lemma, which upper estimates the error in the approximation of an integral by a Riemann sum.
Lemma 3.18. Let $v$ and $w$ in $C_{b}^{\infty, \infty}([0, T] \times \mathbf{R})$. Then there exists a constant $C$ independent of $h$ such that

$$
\left|h \sum_{k=0}^{N-1} E v\left(t_{k+1}, X_{t_{k+1}}^{N}\right) w\left(t_{k}, X_{t_{k}}^{N}\right)-E \int_{0}^{T} v w\left(t, X_{t}\right) d t\right| \leq C h
$$

Proof. Using (3.13) multiply by $w\left(t_{k}, X_{t_{k}}^{N}\right)$ and taking expected value, we deduce for $v \in$ $C^{1,2}, E v\left(t_{k+1}, X_{t_{k+1}}^{N}\right) w\left(t_{k}, X_{t_{k}}^{N}\right)=E v w\left(t_{k}, X_{t_{k}}^{N}\right)+A_{k}$, where

$$
A_{k}:=E w\left(t_{k}, X_{t_{k}}^{N}\right) \int_{t_{k}}^{t_{k+1}}\left\{\frac{\partial}{\partial t} v+\beta_{t}^{k, N} \partial v+\frac{1}{2}\left|\gamma_{t}^{k, N}\right|^{2} \Delta v\right\}\left(t, X_{t}^{N}\right) d t
$$

This yields

$$
h \sum_{k=0}^{N-1} E v\left(t_{k+1}, X_{t_{k+1}}^{N}\right) w\left(t_{k}, X_{t_{k}}^{N}\right)-E \int_{0}^{T} v w\left(t, X_{t}\right) d t=\sum_{k=0}^{N-1}\left(h A_{k}+h B_{k}+C_{k}\right)
$$

where

$$
\begin{aligned}
B_{k} & :=E(v w)\left(t_{k}, X_{t_{k}}^{N}\right)-E(v w)\left(t_{k}, X_{t_{k}}\right) \\
C_{k} & :=h E(v w)\left(t_{k}, X_{t_{k}}\right)-E \int_{t_{k}}^{t_{k+1}}(v w)\left(t, X_{t}\right) d t .
\end{aligned}
$$

Using the Cauchy-Schwarz inequality, the fact that $\frac{\partial}{\partial t} v, \partial v$ and $\Delta v$ have polynomial grow so that Corollary 3.15 can be applied, we deduce

$$
\begin{aligned}
\left|A_{k}\right|^{2} & \leq E\left[\left|w\left(t_{k}, X_{t_{k}}^{N}\right)\right|^{2}\right] E\left[\left|\int_{t_{k}}^{t_{k+1}}\left\{\frac{\partial}{\partial t} v+\beta_{t}^{k, N} \partial v+\frac{1}{2}\left|\gamma_{t}^{k, N}\right|^{2} \Delta v\right\}\left(t, X_{t}^{N}\right) d t\right|^{2}\right] \\
& \leq C h E \int_{t_{k}}^{t_{k+1}}\left|\left\{\frac{\partial}{\partial t} v+\beta_{t}^{k, N} \partial v+\frac{1}{2}\left|\gamma_{t}^{k, N}\right|^{2} \Delta v\right\}\left(t, X_{t}^{N}\right)\right|^{2} d t \\
& \leq C h^{2}
\end{aligned}
$$

Hence, $\left|A_{k}\right| \leq C h$ which implies $h \sum_{0 \leq k \leq N-1}\left|A_{k}\right| \leq C h$.
Since $(v w)\left(t_{k},.\right)$ is in $C_{b}^{\infty}$, we use Theorem 2.1 (i), changing $T$ by $t_{k}$, which yields $\left|B_{k}\right| \leq C h$ and then $h \sum_{0 \leq k \leq N-1}\left|B_{k}\right| \leq C h$. Finally, Itô's formula implies

$$
\begin{aligned}
C_{k} & =E \int_{t_{k}}^{t_{k+1}}\left\{(v w)\left(t_{k}, X_{t_{k}}\right)-(v w)\left(t, X_{t}\right)\right\} d t \\
& =-E \int_{t_{k}}^{t_{k+1}} \int_{t_{k}}^{t}\left\{\frac{\partial}{\partial t}(v w)+b \partial(v w)+\frac{1}{2} \sigma^{2} \Delta(v w)\right\}\left(s, X_{s}\right) d s d t
\end{aligned}
$$

Once more the polynomial growth imposed on $v, w$ and their partial derivatives implies that $\left|C_{k}\right| \leq C h^{2}$ and then $\sum_{0 \leq k \leq N-1}\left|C_{k}\right| \leq C h$. This concludes the proof.

Now we introduce the function $\psi_{i h}:[0, T] \times \mathbf{R} \rightarrow \mathbf{R}$ defined by

$$
\begin{align*}
\psi_{i h}(t, x):= & \frac{1}{2} b \partial(b \partial u)(t, x)-\frac{1}{2} b^{2} \Delta u(t, x)+\frac{1}{4} \sigma^{2} S_{h}^{2} b^{\prime \prime} \partial u(t, x)+\frac{1}{4} b \sigma^{2} \partial^{3} u(t, x)  \tag{3.24}\\
& +\frac{1}{8} \sigma^{4} \partial^{4} u(t, x)+\frac{1}{2} b^{\prime} S_{h} \sigma^{2} \Delta u(t, x)-\frac{1}{4} b \partial\left(\sigma^{2} \Delta u\right)(t, x)-\frac{1}{8} \sigma^{2} \Delta\left(\sigma^{2} \Delta u\right)(t, x)
\end{align*}
$$

Using the expression of $i_{k}^{N}$ in (3.22) (resp. $j_{k}^{N}$ in (3.23)) and the previous lemma, we deduce

$$
\begin{equation*}
\left|\frac{1}{2} h \sum_{k=0}^{N-1} E i_{k}^{N}\left(t_{k+1}\right)+\frac{1}{4} h \sum_{k=0}^{N_{1}} E j_{k}^{N}\left(t_{k}\right)-\int_{0}^{T} E \psi_{i h}\left(t, X_{t}\right) d t\right| \leq C h \tag{3.25}
\end{equation*}
$$

Using the definitions of $\psi_{i}$ and $\psi_{i h}$ given in (2.2) and (3.24) respectively, we have

$$
\begin{aligned}
\psi_{i h}(t, x)-\psi_{i}(t, x) & =\frac{1}{4}\left\{\sigma^{2} S_{h}^{2} b^{\prime \prime} \partial u+b \sigma^{2} \partial^{3} u+2 b^{\prime} S_{h} \sigma^{2} \Delta u-\sigma^{2} \Delta(b \partial u)\right\}(t, x) \\
& =\frac{1}{4} \sigma^{2}\left(S_{h}^{2}-1\right) b^{\prime \prime} \partial u(t, x)+\frac{1}{2} b^{\prime}\left(S_{h}-1\right) \sigma^{2} \Delta u(t, x)
\end{aligned}
$$

Since $\left(S_{h}-1\right)(x)=\frac{h b^{\prime}}{1-h b^{\prime}}(x)$ and $\left|S_{h}(x)+1\right| \leq C$ for $h \in\left(0, h^{*}\right)$, we have $\left|\left(S_{h}-1\right)(x)\right|+$ $\left|\left(S_{h}^{2}-1\right)(x)\right| \leq C h$, where as usually $C$ does not depend on $N$ and $h$. This yields

$$
\left|\int_{0}^{T} E\left\{\psi_{i h}\left(t, X_{t}\right)-\psi_{i}\left(t, X_{t}\right)\right\} d t\right| \leq C h
$$

This last equation with (3.21) and (3.25) concludes the proof.
