# $W_{0}^{1,1}$ SOLUTIONS IN SOME BORDERLINE CASES OF ELLIPTIC EQUATIONS WITH DEGENERATE COERCIVITY

#### Abstract

We study a degenerate elliptic equation, proving existence results of distributional solutions in some borderline cases.

## 1. Introduction

The Sobolev space $W_{0}^{1,2}(\Omega)$ is the natural functional framework (see [10], [12]) to find weak solutions of nonlinear elliptic problems of the following type

$$
\left\{\begin{array}{cl}
-\operatorname{div}\left(\frac{a(x) \nabla u}{(1+|u|)^{\theta}}\right)=f, & \text { in } \Omega  \tag{1}\\
u=0, & \text { on } \partial \Omega
\end{array}\right.
$$

where the function $f$ belongs to the dual space of $W_{0}^{1,2}(\Omega), \Omega$ is a bounded, open subset of $\mathbb{R}^{N}$, with $N>2, \theta$ is a real number such that

$$
\begin{equation*}
0 \leq \theta \leq 1 \tag{2}
\end{equation*}
$$

and $a: \Omega \rightarrow \mathbb{R}$ is a measurable function satisfying the following conditions:

$$
\begin{equation*}
\alpha \leq a(x) \leq \beta, \tag{3}
\end{equation*}
$$

[^0]for almost every $x \in \Omega$, where $\alpha$ and $\beta$ are positive constants. The main difficulty to use the general results of [10], [12] is the fact that
$$
A(v)=-\operatorname{div}\left(\frac{a(x) \nabla v}{(1+|v|)^{\theta}}\right)
$$
is not coercive. Papers [7], [4] and [3] deal with the existence and summability of solutions to problem (1) if $f \in L^{m}(\Omega)$, for some $m \geq 1$.

Despite the lack of coercivity of the differential operator $A(v)$ appearing in problem (1), in the papers [7], [4] and [1], the authors prove the following existence results of solutions of problem (1), under assumption (3):
A) a weak solution $u \in W_{0}^{1,2}(\Omega) \cap L^{\infty}(\Omega)$, if $m>\frac{N}{2}$ and (2) holds true;
B) a weak solution $u \in W_{0}^{1,2}(\Omega) \cap L^{m^{* *}(1-\theta)}(\Omega)$, where $m^{* *}=$ $\left(m^{*}\right)^{*}=\frac{m N}{N-2 m}$, if

$$
0<\theta<1, \quad \frac{2 N}{N+2-\theta(N-2)} \leq m<\frac{N}{2}
$$

C) a distributional solution $u$ in $W_{0}^{1, q}(\Omega), q=\frac{N m(1-\theta)}{N-m(1+\theta)}<2$, if

$$
\frac{1}{N-1} \leq \theta<1, \quad \frac{N}{N+1-\theta(N-1)}<m<\frac{2 N}{N+2-\theta(N-2)} .
$$

D) an entropy solution $u \in M^{m^{* *}(1-\theta)}$, with $|\nabla u| \in M^{q}(\Omega)$, for $1 \leq m \leq \max \left\{1, \frac{N}{N+1-\theta(N-1)}\right\}$.
The borderline case $\theta=1$ was studied in [3], proving the existence of a solution $u \in W_{0}^{1,2}(\Omega) \cap L^{p}(\Omega)$ for every $p<\infty$. The case where the source is $\frac{A}{|x|^{2}}$ was analyzed too.

About the different notions of solutions mentioned above, we recall that the notion of entropy solution was introduced in [2]. Let

$$
T_{k}(s)= \begin{cases}s & \text { if }|s| \leq k,  \tag{4}\\ k \frac{s}{|s|} & \text { if }|s|>k .\end{cases}
$$

Then $u$ is an entropy solution to problem (1) if $T_{k}(u) \in W_{0}^{1,2}(\Omega)$ for every $k>0$ and

$$
\int_{\Omega} \frac{a(x) \nabla u}{(1+|u|)^{\theta}} \cdot \nabla T_{k}(u-\varphi) \leq \int_{\Omega} f T_{k}(u-\varphi), \quad \forall \varphi \in W_{0}^{1,2}(\Omega) \cap L^{\infty}(\Omega)
$$

Moreover, we say that $u$ is a distributional solution of (1) if

$$
\begin{equation*}
\int_{\Omega} \frac{a(x) \nabla u}{(1+|u|)^{\theta}} \cdot \nabla \varphi=\int_{\Omega} f \varphi, \quad \forall \varphi \in C_{0}^{\infty}(\Omega) \tag{5}
\end{equation*}
$$

The figure below can help to summarize the previous results, where the name of a given region corresponds to the results that we have just cited.


Our results are the following.
Theorem 1.1. Let $f$ be a function in $L^{m}(\Omega)$. Assume (3) and

$$
\begin{equation*}
m=\frac{N}{N+1-\theta(N-1)}, \quad \frac{1}{N-1}<\theta<1 \tag{6}
\end{equation*}
$$

Then there exists a $W_{0}^{1,1}(\Omega)$ distributional solution to problem (1).
Observe that this case corresponds to the curve between the regions $C$ and $D$ of the figure. Note that $m>1$ if and only if $\theta>\frac{1}{N-1}$.

In the following result too, we will prove the existence of a $W_{0}^{1,1}(\Omega)$ solution.

Theorem 1.2. Let $f$ be a function in $L^{m}(\Omega)$. Assume (3), $f \log (1+$ $|f|) \in L^{1}(\Omega)$ and $\theta=\frac{1}{N-1}$. Then there exists a $W_{0}^{1,1}(\Omega)$ distributional solution of (1).

We end our introduction just mentioning a uniqueness result of solutions to problem (1) can be found in [13].

Moreover, in $[4,5,11,6]$ it was showed that the presence of a lower order term has a regularizing effect on the existence and regularity of the solutions.

To prove our results, we will work by approximation, using the following sequance of problems:

$$
\left\{\begin{array}{cl}
-\operatorname{div}\left(\frac{a(x) \nabla u_{n}}{\left(1+\left|u_{n}\right|\right)^{\theta}}\right)=T_{n}(f), & \text { in } \Omega  \tag{7}\\
u_{n}=0, & \text { on } \partial \Omega
\end{array}\right.
$$

The existence of weak solutions $u_{n} \in W_{0}^{1,2}(\Omega) \cap L^{\infty}(\Omega)$ to problem (7) is due to [7].

## 2. $W_{0}^{1,1}(\Omega)$ solutions

In the sequel $C$ will denote a constant depending on $\alpha, N, \operatorname{meas}(\Omega), \theta$ and the $L^{m}(\Omega)$ norm of the source $f$.

We are going to prove Theorem 1.1, that is, the existence of a solution to problem (1) in the case where $m=\frac{N}{N+1-\theta(N-1)}$ and $\frac{1}{N-1}<\theta<1$. Note that $m>1$ if and only if $\theta>\frac{1}{N-1}$.

Proof. (of Theorem 1.1) We consider $T_{k}\left(u_{n}\right)$ as a test function in (7): then

$$
\begin{equation*}
\int_{\Omega}\left|\nabla T_{k}\left(u_{n}\right)\right|^{2} \leq \frac{(1+k)^{\theta}\|f\|_{L^{1}(\Omega)}}{\alpha} \tag{8}
\end{equation*}
$$

by assumption (3) on $a$.
Choosing $\left[\left(1+\left|u_{n}\right|\right)^{p}-1\right] \operatorname{sign}\left(u_{n}\right)$, for $p=\theta-\frac{1}{N-1}$, as a test function in (7) we have, by Hölder's inequality on the right hand side and assumption (3) on the left one

$$
\begin{equation*}
\alpha p \int_{\Omega}\left(\frac{\left|\nabla u_{n}\right|}{\left(1+\left|u_{n}\right|\right)^{\frac{N}{2(N-1)}}}\right)^{2} \leq \int_{\Omega}|f|\left[\left(1+\left|u_{n}\right|\right)^{p}-1\right] \leq\|f\|_{L^{m}(\Omega)}\left[\int_{\Omega}\left[\left(1+\left|u_{n}\right|\right)^{p}-1\right]^{m^{\prime}}\right]^{\frac{1}{m^{\prime}}} \tag{9}
\end{equation*}
$$

The Sobolev embedding used on the left hand side implies

$$
\left[\int_{\Omega}\left\{\left(1+\left|u_{n}\right|\right)^{\frac{N-2}{2(N-1)}}-1\right\}^{\frac{2 N}{N-2}}\right]^{\frac{2}{2^{*}}} \leq C\left[\int_{\Omega}\left[\left(1+\left|u_{n}\right|\right)^{p}-1\right]^{m^{\prime}}\right]^{\frac{1}{m^{\prime}}}
$$

We observe that $\frac{N-2}{2(N-1)} \frac{2 N}{N-2}=p m^{\prime}$; moreover $\frac{2}{2^{*}}>\frac{1}{m^{\prime}}$, since $m<\frac{N}{2}$. Therefore the above inequality implies that

$$
\begin{equation*}
\int_{\Omega}\left|u_{n}\right|^{\frac{N}{N-1}} \leq C \tag{10}
\end{equation*}
$$

One deduces that

$$
\begin{equation*}
\int_{\Omega} \frac{\left|\nabla u_{n}\right|^{2}}{\left(1+\left|u_{n}\right|\right)^{\frac{N}{N-1}}} \leq C \tag{11}
\end{equation*}
$$

from (10) and (9). Let $v_{n}=\frac{2(N-1)}{N-2}\left(1+\left|u_{n}\right|\right)^{\frac{N-2}{2(N-1)}} \operatorname{sign}\left(u_{n}\right)$. Estimate (11) is equivalent to say that $\left\{v_{n}\right\}$ is a bounded sequence in $W_{0}^{1,2}(\Omega)$; therefore, up to a subsequence, there exists $v \in W_{0}^{1,2}(\Omega)$ such that $v_{n} \rightharpoonup v$ weakly in $W_{0}^{1,2}(\Omega)$ and a.e. in $\Omega$. If we define the function $u=\left(\left[\frac{2(N-1)}{N-2}|v|\right]^{\frac{2(N-1)}{N-2}}-1\right) \operatorname{sign}(v)$, the weak convergence of $\nabla v_{n} \rightharpoonup \nabla v$ means that

$$
\begin{equation*}
\frac{\nabla u_{n}}{\left(1+\left|u_{n}\right|\right)^{\frac{N}{2(N-1)}}} \rightharpoonup \frac{\nabla u}{(1+|u|)^{\frac{N}{2(N-1)}}} \quad \text { weakly in } L^{2}(\Omega) . \tag{12}
\end{equation*}
$$

Moreover, the Sobolev embedding for $v_{n}$ implies that $u_{n} \rightarrow u$ in $L^{s}(\Omega)$, for every $1 \leq s<\frac{N}{N-1}$.

Holdër's inequality with exponent 2 applied to

$$
\int_{\Omega}\left|\nabla u_{n}\right|=\int_{\Omega} \frac{\left|\nabla u_{n}\right|}{\left(1+\left|u_{n}\right|\right)^{\frac{N}{2 N-2}}}\left(1+\left|u_{n}\right|\right)^{\frac{N}{2 N-2}}
$$

gives

$$
\begin{equation*}
\int_{\Omega}\left|\nabla u_{n}\right| \leq C \tag{13}
\end{equation*}
$$

due to (10) and (11). We are now going to estimate $\int_{\left\{k \leq\left|u_{n}\right|\right\}}\left|\nabla u_{n}\right|$. By using $\left[\left(1+\left|u_{n}\right|\right)^{p}-(1+k)^{p}\right]^{+} \operatorname{sign}\left(u_{n}\right)$ as a test function in (7), we have

$$
\int_{\left\{k \leq\left|u_{n}\right|\right\}} \frac{\left|\nabla u_{n}\right|^{2}}{\left(1+\left|u_{n}\right|\right)^{\frac{N}{N-1}}} \leq C\left[\int_{\left\{k \leq\left|u_{n}\right|\right\}}|f|^{m}\right]^{\frac{1}{m}}\left[\int_{\Omega}\left(1+\left|u_{n}\right|\right)^{\frac{N}{N-1}}\right]^{\frac{1}{m^{\prime}}}
$$

which implies, by (10),

$$
\begin{equation*}
\int_{\left\{k \leq\left|u_{n}\right|\right\}} \frac{\left|\nabla u_{n}\right|^{2}}{\left(1+\left|u_{n}\right|\right)^{\frac{N}{N-1}}} \leq C\left[\int_{\left\{k \leq\left|u_{n}\right|\right\}}|f|^{m}\right]^{\frac{1}{m}} \tag{14}
\end{equation*}
$$

Hölder's inequality, estimates (10) and (14) on

$$
\int_{\left\{k \leq\left|u_{n}\right|\right\}}\left|\nabla u_{n}\right|=\int_{\left\{k \leq\left|u_{n}\right|\right\}} \frac{\left|\nabla u_{n}\right|}{\left(1+\left|u_{n}\right|\right)^{\frac{N}{2 N-2}}}\left(1+\left|u_{n}\right|\right)^{\frac{N}{2 N-2}} \leq C\left[\int_{\left\{k \leq\left|u_{n}\right|\right\}}|f|^{m}\right]^{\frac{1}{2 m}}
$$

give

$$
\begin{equation*}
\int_{\left\{k \leq\left|u_{n}\right|\right\}}\left|\nabla u_{n}\right|=\int_{\left\{k \leq\left|u_{n}\right|\right\}} \frac{\left|\nabla u_{n}\right|}{\left(1+\left|u_{n}\right|\right)^{\frac{N}{2 N-2}}}\left(1+\left|u_{n}\right|\right)^{\frac{N}{2 N-2}} \leq C\left[\int_{\left\{k \leq\left|u_{n}\right|\right\}}|f|^{m}\right]^{\frac{1}{2 m}} . \tag{15}
\end{equation*}
$$

Thus, for every measurable subset $E$, due to (8) and (15), we have

$$
\begin{align*}
& \int_{E}\left|\frac{\partial u_{n}}{\partial x_{i}}\right| \leq \int_{E}\left|\nabla u_{n}\right| \leq \int_{E}\left|\nabla T_{k}\left(u_{n}\right)\right|+\int_{\left\{k \leq\left|u_{n}\right|\right\}}\left|\nabla u_{n}\right| \\
& \leq \operatorname{meas}(E)^{\frac{1}{2}}\left[\frac{(1+k)^{\theta}\|f\|_{L^{1}(\Omega)}}{\alpha}\right]^{\frac{1}{2}}+C\left[\int_{\left\{k \leq\left|u_{n}\right|\right\}}|f|^{m}\right]^{\frac{1}{2 m}} \tag{16}
\end{align*}
$$

Now we are going to prove that $u_{n}$ weakly converges to $u$ in $W_{0}^{1,1}(\Omega)$ following [5]. Estimates (16) and (10) imply that the sequence $\left\{\frac{\partial u_{n}}{\partial x_{i}}\right\}$ is equiintegrable. By Dunford-Pettis theorem, and up to subsequences, there exists $Y_{i}$ in $L^{1}(\Omega)$ such that $\frac{\partial u_{n}}{\partial x_{i}}$ weakly converges to $Y_{i}$ in $L^{1}(\Omega)$. Since $\frac{\partial u_{n}}{\partial x_{i}}$ is the distributional partial derivative of $u_{n}$, we have, for every $n$ in $I N$,

$$
\int_{\Omega} \frac{\partial u_{n}}{\partial x_{i}} \varphi=-\int_{\Omega} u_{n} \frac{\partial \varphi}{\partial x_{i}}, \quad \forall \varphi \in C_{0}^{\infty}(\Omega) .
$$

We now pass to the limit in the above identities, using that $\partial_{i} u_{n}$ weakly converges to $Y_{i}$ in $L^{1}(\Omega)$, and that $u_{n}$ strongly converges to $u$ in $L^{1}(\Omega)$ : we obtain

$$
\int_{\Omega} Y_{i} \varphi=-\int_{\Omega} u \frac{\partial \varphi}{\partial x_{i}}, \quad \forall \varphi \in C_{0}^{\infty}(\Omega)
$$

This implies that $Y_{i}=\frac{\partial u}{\partial x_{i}}$, and this result is true for every $i$. Since $Y_{i}$ belongs to $L^{1}(\Omega)$ for every $i, u$ belongs to $W_{0}^{1,1}(\Omega)$.

We are now going to pass to the limit in problems (7). For the limit of the left hand side, it is sufficient to observe that $\frac{\nabla u_{n}}{\left(1+\left|u_{n}\right|\right)^{\frac{N}{2(N-1)}}} \rightharpoonup$ $\frac{\nabla u}{(1+|u|)^{\frac{N}{2(N-1)}}}$ weakly in $L^{2}(\Omega)$ due to (12) and that $|a(x) \nabla \varphi|$ is bounded.

We prove Theorem 1.2, that is, the existence of a $W_{0}^{1,1}(\Omega)$ solution in the case where $\theta=\frac{1}{N-1}$ and $f \log (1+|f|) \in L^{1}(\Omega)$.

Proof. (of Theorem 1.2) Let $k \geq 0$ and take $\left[\log \left(1+\left|u_{n}\right|\right)-\log (1+\right.$ $k)]^{+} \operatorname{sign}\left(u_{n}\right)$, as a test function in problems (7). By assumption (3) on
$a$ one has

$$
\alpha \int_{\left\{k \leq\left|u_{n}\right|\right\}} \frac{\left|\nabla u_{n}\right|^{2}}{\left(1+\left|u_{n}\right|\right)^{\theta+1}} \leq \int_{\left\{k \leq\left|u_{n}\right|\right\}}|f| \log \left(1+\left|u_{n}\right|\right) .
$$

We now use the following inequality on the left hand side:

$$
\begin{equation*}
a \log (1+b) \leq \frac{a}{\rho} \log \left(1+\frac{a}{\rho}\right)+(1+b)^{\rho} \tag{17}
\end{equation*}
$$

where $a, b$ are positive real numbers and $0<\rho<\frac{N-2}{N-1}$. This gives, for any $k \geq 0$

$$
\begin{equation*}
\alpha \int_{\left\{k \leq\left|u_{n}\right|\right\}} \frac{\left|\nabla u_{n}\right|^{2}}{\left(1+\left|u_{n}\right|\right)^{\theta+1}} \leq \int_{\left\{k \leq\left|u_{n}\right|\right\}} \frac{|f|}{\rho} \log \left(1+\frac{|f|}{\rho}\right)+\int_{\left\{k \leq\left|u_{n}\right|\right\}}\left(1+\left|u_{n}\right|\right)^{\rho} \tag{18}
\end{equation*}
$$

In particular, for $k \geq 1$ we have
(19) $\frac{\alpha}{2^{\theta+1}} \int_{\left\{k \leq\left|u_{n}\right|\right\}} \frac{\left|\nabla u_{n}\right|^{2}}{\left|u_{n}\right|^{\theta+1}} \leq \int_{\left\{k \leq\left|u_{n}\right|\right\}} \frac{|f|}{\rho} \log \left(1+\frac{|f|}{\rho}\right)+2^{\rho} \int_{\left\{k \leq\left|u_{n}\right|\right\}}\left|u_{n}\right|^{\rho}$.

Writing the above inequality for $k=1$ and using the Sobolev inequality on the left hand side, one has

$$
\left[\int_{\Omega}\left(\left|u_{n}\right|^{\frac{1-\theta}{2}}-1\right)_{+}^{2^{*}}\right]^{\frac{2}{2^{*}}} \leq C \int_{\left\{1 \leq\left|u_{n}\right|\right\}} \frac{|f|}{\rho} \log \left(1+\frac{|f|}{\rho}\right)+C \int_{\left\{1 \leq\left|u_{n}\right|\right\}}\left|u_{n}\right|^{\rho}
$$

which implies that

$$
\left[\int_{\Omega}\left|u_{n}\right|^{\frac{(1-\theta) 2^{*}}{2}}\right]^{\frac{1}{2^{*}}} \leq C+C \sqrt{\int_{\left\{1 \leq\left|u_{n}\right|\right\}} \frac{|f|}{\rho} \log \left(1+\frac{|f|}{\rho}\right)}+C \sqrt{\int_{\Omega}\left|u_{n}\right|^{\rho}} .
$$

By using Hölder's inequality with exponent $\frac{(1-\theta) 2^{*}}{2 \rho}$ on the last term of the right hand side, we get

$$
\left[\int_{\Omega}\left|u_{n}\right|^{\frac{(1-\theta) 2^{*}}{2}}\right]^{\frac{1}{2^{*}}} \leq C+C \sqrt{\int_{\left\{1 \leq\left|u_{n}\right|\right\}} \frac{|f|}{\rho} \log \left(1+\frac{|f|}{\rho}\right)}+C\left[\int_{\Omega}\left|u_{n}\right|^{\frac{(1-\theta) 2^{*}}{2}}\right]^{\frac{\rho}{(1-\theta) 2^{*}}}
$$

By the choice of $\rho$, this inequality implies that

$$
\begin{equation*}
\int_{\Omega}\left|u_{n}\right|^{\frac{(1-\theta))^{*}}{2}} \leq C \tag{20}
\end{equation*}
$$

Inequalities (20) and (18) written for $k=0$ imply that $\left\{v_{n}\right\}=\left\{\frac{2}{1-\theta}(1+\right.$ $\left.\left.\left|u_{n}\right|\right)^{\frac{1-\theta}{2}} \operatorname{sign}\left(u_{n}\right)\right\}$ is a bounded sequence in $W_{0}^{1,2}(\Omega)$, as in the proof
of Theorem 1.1. Therefore, up to a subsequence there exists $v \in$ $W_{0}^{1,2}(\Omega)$ such that $v_{n} \rightharpoonup v$ weakly in $W_{0}^{1,2}(\Omega)$ and a.e. in $\Omega$. Let $u=\left\{\left[\frac{1-\theta}{2} v\right]^{\frac{2}{1-\theta}}-1\right\} \operatorname{sign}(v)$; the weak convergence of $\nabla v_{n} \rightharpoonup \nabla v$ means that

$$
\begin{equation*}
\frac{\nabla u_{n}}{\left(1+\left|u_{n}\right|\right)^{\frac{\theta+1}{2}}} \rightharpoonup \frac{\nabla u}{(1+|u|)^{\frac{\theta+1}{2}}} \quad \text { weakly in } L^{2}(\Omega) . \tag{21}
\end{equation*}
$$

Moreover, the Sobolev embedding for $v_{n}$ implies that $u_{n} \rightarrow u$ in $L^{s}(\Omega), s<$ $\frac{N}{N-1}$.

By (8) one has

$$
\int_{\Omega}\left|\nabla u_{n}\right|=\int_{\Omega}\left|\nabla T_{1}\left(u_{n}\right)\right|+\int_{\left\{1 \leq\left|u_{n}\right|\right\}}\left|\nabla u_{n}\right| \leq C+\int_{\left\{1 \leq\left|u_{n}\right|\right\}} \frac{\left|\nabla u_{n}\right|}{\left|u_{n}\right|^{\frac{\theta+1}{2}}}\left|u_{n}\right|^{\frac{\theta+1}{2}} .
$$

Hölder's inequality on the right hand side, and estimates (19) written with $k=1$ and (20) imply that the sequence $\left\{u_{n}\right\}$ is bounded in $W_{0}^{1,1}(\Omega)$.

Moreover, due to (19)

$$
\begin{aligned}
& \int_{\left\{k \leq\left|u_{n}\right|\right\}}\left|\nabla u_{n}\right|=\int_{\left\{k \leq\left|u_{n}\right|\right\}} \frac{\left|\nabla u_{n}\right|}{\left|u_{n}\right|^{\frac{\theta+1}{2}}}\left|u_{n}\right|^{\frac{\theta+1}{2}} \leq \\
& \leq C \sqrt{\int_{\left\{k \leq\left|u_{n}\right|\right\}} \frac{|f|}{\rho} \log \left(1+\frac{|f|}{\rho}\right)+\int_{\left\{k \leq\left|u_{n}\right|\right\}}\left|u_{n}\right|^{\rho}} .
\end{aligned}
$$

For every measurable subset $E$, the previous inequality and (8) imply

$$
\begin{gathered}
\int_{E}\left|\frac{\partial u_{n}}{\partial x_{i}}\right| \leq \int_{E}\left|\nabla u_{n}\right| \leq \int_{E}\left|\nabla T_{k}\left(u_{n}\right)\right|+\int_{\left\{k \leq\left|u_{n}\right|\right\}}\left|\nabla u_{n}\right| \\
\leq C \operatorname{meas}(E)^{\frac{1}{2}}(1+k)^{\frac{\theta}{2}}+C \sqrt{\int_{\left\{k \leq\left|u_{n}\right|\right\}} \frac{|f|}{\rho} \log \left(1+\frac{|f|}{\rho}\right)+\int_{\left\{k \leq\left|u_{n}\right|\right\}}\left|u_{n}\right|^{\rho}} .
\end{gathered}
$$

Since $\rho<\frac{(1-\theta) 2^{*}}{2}$, by using Hölder's inequality on the last term and estimate (20), one has

$$
\begin{gathered}
\int_{E}\left|\frac{\partial u_{n}}{\partial x_{i}}\right| \leq C \operatorname{meas}(E)^{\frac{1}{2}}(1+k)^{\frac{\theta}{2}}+ \\
+C \sqrt{\int_{\left\{k \leq\left|u_{n}\right|\right\}} \frac{|f|}{\rho} \log \left(1+\frac{|f|}{\rho}\right)+\operatorname{meas}\left(\left\{\left|u_{n}\right| \geq k\right\}\right)^{1-\frac{2 \rho}{(1-\theta) 2^{*}}}} .
\end{gathered}
$$

One can argue as in the proof of Theorem 1.1 to deduce that $u_{n} \rightarrow u$ weakly in $W_{0}^{1,1}(\Omega)$.

To pass to the limit in problems (7), as in the proof of Theorem 1.1, it is sufficient to observe that $\frac{\nabla u_{n}}{\left(1+\left|u_{n}\right|\right)^{2(N-1)}} \rightharpoonup \frac{\nabla u}{(1+|u|)^{\frac{N}{2(N-1)}}}$ weakly in $L^{2}(\Omega)$, due to (21).
