# A CLT FOR INFORMATION-THEORETIC STATISTICS OF NON-CENTERED GRAM RANDOM MATRICES

Abstract. In this article, we study the fluctuations of the random variable:

$$
\mathcal{I}_{n}(\rho)=\frac{1}{N} \log \operatorname{det}\left(\Sigma_{n} \Sigma_{n}^{*}+\rho I_{N}\right), \quad(\rho>0)
$$

where $\Sigma_{n}=n^{-1 / 2} D_{n}^{1 / 2} X_{n} \tilde{D}_{n}^{1 / 2}+A_{n}$, as the dimensions of the matrices go to infinity at the same pace. Matrices $X_{n}$ and $A_{n}$ are respectively random and deterministic $N \times n$ matrices; matrices $D_{n}$ and $\tilde{D}_{n}$ are deterministic and diagonal, with respective dimensions $N \times N$ and $n \times n$; matrix $X_{n}=\left(X_{i j}\right)$ has centered, independent and identically distributed entries with unit variance, either real or complex.

We prove that when centered and properly rescaled, the random variable $\mathcal{I}_{n}(\rho)$ satisfies a Central Limit Theorem and has a Gaussian limit. The variance of $\mathcal{I}_{n}(\rho)$ depends on the moment $\mathbb{E} X_{i j}^{2}$ of the variables $X_{i j}$ and also on its fourth cumulant $\kappa=\mathbb{E}\left|X_{i j}\right|^{4}-2-$ $\left|\mathbb{E} X_{i j}^{2}\right|^{2}$.

The main motivation comes from the field of wireless communications, where $\mathcal{I}_{n}(\rho)$ represents the mutual information of a multiple antenna radio channel. This article closely follows the companion article "A CLT for Information-theoretic statistics of Gram random matrices with a given variance profile", Ann. Appl. Probab. (2008) by Hachem et al., however the study of the fluctuations associated to non-centered large random matrices raises specific issues, which are addressed here.

## 1. Introduction

The model, the statistics, and the literature. Consider a $N \times n$ random matrix $\Sigma_{n}=$ $\left(\xi_{i j}^{n}\right)$ which writes:

\Sigma_{n}=\frac{1}{\sqrt{n}} D_{n}^{\frac{1}{2}} X_{n} \tilde{D}_{n}^{\frac{1}{2}}+A_{n} \tag{1.1}
\end{equation*}

where $A_{n}=\left(a_{i j}^{n}\right)$ is a deterministic $N \times n$ matrix with uniformily bounded spectral norm, $D_{n}$ and $\tilde{D}_{n}$ are diagonal deterministic matrices with nonnegative entries, with respective dimensions $N \times N$ and $n \times n ; X_{n}=\left(X_{i j}\right)$ is a $N \times n$ matrix with the entries $X_{i j}$ 's being centered, independent and identically distributed (i.i.d.) random variables with unit variance $\mathbb{E}\left|X_{i j}\right|^{2}=1$ and finite $16^{\text {th }}$ moment.

Consider the following linear statistics of the eigenvalues:

\mathcal{I}_{n}(\rho)=\frac{1}{N} \log \operatorname{det}\left(\Sigma_{n} \Sigma_{n}^{*}+\rho I_{N}\right)=\frac{1}{N} \sum_{i=1}^{N} \log \left(\lambda_{i}+\rho\right),
$$

where $I_{N}$ is the $N \times N$ identity matrix, $\rho>0$ is a given parameter and the $\lambda_{i}$ 's are the eigenvalues of matrix $\Sigma_{n} \Sigma_{n}^{*}\left(\Sigma_{n}^{*}\right.$ stands for the Hermitian adjoint of $\left.\Sigma_{n}\right)$. This functional, known as the mutual information for multiple antenna radio channels, is fundamental in wireless communication as it characterizes the performance of a (coherent) communication over a wireless Multiple-Input Multiple-Output (MIMO) channel with gain matrix $\Sigma_{n}$. Channels with non-centered gain matrix $\Sigma_{n}=n^{-1 / 2} D_{n}^{1 / 2} X_{n} \tilde{D}_{n}^{1 / 2}+A_{n}$ are known as Rician channels. The deterministic matrix $A_{n}$ accounts for the so-called line-of-sight component, while $D_{n}$ and $\tilde{D}_{n}$ account for the correlations at the receiving and emitting sides, respectively.

Since the seminal work of Telatar [36], the study of the mutual information $\mathcal{I}_{n}(\rho)$ of a MIMO channel (and other performance indicators) in the regime where the dimensions of the gain matrix grow to infinity at the same pace has turned to be extremely fruitful. However, Rician channels have been comparatively less studied from this point of view, as their analysis is more difficult due to the presence of the deterministic matrix $A_{n}$. First order results can be found in Girko [14, 15; Dozier and Silverstein 10, 11 established convergence results for the spectral measure; and the systematic study of the convergence of $\mathcal{I}_{n}(\rho)$ for a correlated Rician channel has been undertaken by Hachem et al. in 20, 12, etc. The fluctuations of $\mathcal{I}_{n}$ are important as well, for the computation of the outage probability of a MIMO channel for instance. With the help of the replica method, Taricco 34, 35 provided a closed-form expression for the asymptotic variance of $\mathcal{I}_{n}$ for the Rician channel.

The purpose of this article is to establish a Central Limit Theorem (CLT) for $\mathcal{I}_{n}(\rho)$ in the following regime

$$
N, n \rightarrow \infty \quad \text { and } \quad 0<\liminf \frac{N}{n} \leq \lim \sup \frac{N}{n}<\infty
$$

(simply denoted by $N, n \rightarrow \infty$ in the sequel) under mild assumptions for matrices $X_{n}, A_{n}$, $D_{n}$ and $\tilde{D}_{n}$.

The contributions of this article are twofold. From a wireless communication perspective, the fluctuations of $\mathcal{I}_{n}$ are established, regardless of the gaussianity of the entries and the CLT conjectured by Tarrico is fully proved. Also, this article concludes a series of studies devoted to Rician MIMO channels, initiated in 20 where a deterministic equivalent of the mutual information was provided, and continued in [12] where the computation of the ergodic capacity was addressed and an iterative algorithm proposed.

From a mathematical point of view, the study of the fluctuations of $\mathcal{I}_{n}$ is the first attempt (up to our knowledge) to establish a CLT for a linear statistics of the eigenvalues of a Gram non-centered matrix (so-called signal plus noise model in [10, 11]). It complements (but does not supersede) the CLT established in [21] for a centered Gram matrix with a given variance profile. The fact that matrix $\Sigma_{n}$ is non-centered ( $\mathbb{E} \Sigma_{n}=A_{n}$ ) raises specific issues, from a different nature than those addressed in close-by results [1, 4, 21, etc. These issues arise from the presence in the computations of bilinear forms $u_{n}^{*} Q_{n}(z) v_{n}$ where at least one of the vectors $u_{n}$ or $v_{n}$ is deterministic. Often, the deterministic vector is related to the columns of matrix $A_{n}$, and has to be dealt with in such a way that the assumption over the spectral norm of $A_{n}$ is exploited.

Another important contribution of this paper is to establish the CLT regardless of specific assumptions on the real or complex nature of the underlying random variables. It is in particular not assumed that the random variables are gaussian, neither that whenever the random variables $X_{i j}$ are complex, their second moment $\mathbb{E} X_{i j}^{2}$ is zero; nor is assumed that
the random variables are circularl. As we shall see, all these assumptions, if assumed, would have resulted in substantial simplifications. As a reward however, we obtain a variance expression which smoothly depends upon $\mathbb{E} X_{i j}^{2}$ whose value is 1 in the real case, and zero in the complex case where the real and imaginary parts are not correlated.

Interestingly, the mutual information $\mathcal{I}_{n}$ has a strong relationship with the Stieltjes transform $f_{n}(z)=\frac{1}{N} \operatorname{Trace}\left(\Sigma_{n} \Sigma_{n}^{*}-z I_{N}\right)^{-1}$ of $\Sigma_{n} \Sigma_{n}^{*}$ :

\mathcal{I}_{n}(\rho)=\log \rho+\int_{\rho}^{\infty}\left(\frac{1}{w}-f_{n}(-w)\right) d w
$$

Accordingly, the study of the fluctuations of $\mathcal{I}_{n}$ is also an important step toward the study of general linear statistics of $\Sigma_{n} \Sigma_{n}^{*}$ 's eigenvalues which can be expressed via the Stieltjes transform:

$$
\frac{1}{N} \operatorname{Trace} h\left(\Sigma_{n} \Sigma_{n}\right)=\frac{1}{N} \sum_{i=1}^{N} h\left(\lambda_{i}\right)=-\frac{1}{2 \mathbf{i} \pi} \oint_{C} h(z) f_{n}(z) d z
$$

for some well-chosen contour $C$ (see for instance [4]).
Fluctuations for particular linear statistics (and general classes of linear statistics) of large random matrices have been widely studied: CLTs for Wigner matrices can be traced back to Girko [13] (see also [16]). Results for this class of matrices have also been obtained by Khorunzhy et al. [27, Boutet de Monvel and Khorunzhy [6], Johansson [24], Sinai and Sochnikov [32, Soshnikov [33], Cabanal-Duvillard [7], Guionnet [17, Anderson and Zeitouni [1], Mingo and Speicher [29], Chatterjee [8], Lytova and Pastur [28], etc. The case of Gram matrices has been studied in Arharov [2], Jonsson [25], Bai and Silverstein [4], Hachem et al. 21, and also in [28, 29, 8]. Fluctuation results dedicated to wireless communication applications have been developed in the centered case $\left(A_{n}=0\right)$ by Debbah and Müller [9] and Tulino and Verdù 37] (based on Bai and Silverstein [4]), Hachem et al. 19] (for gaussian entries) and [21]. Other fluctuation results either based on the replica method or on saddlepoint analysis have been developed by Moustakas, Sengupta and coauthors [30, 31, and Tarrico 34, 35].

Presentation of the results. We first introduce the fundamental equations needed to express the deterministic approximation of the mutual information and the variance in the CLT.

Fundamental equations, deterministic equivalents. We collect here resuls from [20]. The following system of equations

[^0]admits a unique solution $\left(\delta_{n}, \tilde{\delta}_{n}\right)$ in the class of Stieltjes transforms of nonnegative measures $\mathbb{Z}^{2}$ with support in $\mathbb{R}^{+}$. Matrices $T_{n}(z)$ and $\tilde{T}_{n}(z)$ defined by

are approximations of the resolvent $Q_{n}(z)=\left(\Sigma_{n} \Sigma_{n}^{*}-z I_{N}\right)^{-1}$ and the co-resolvent $\tilde{Q}_{n}(z)=$ $\left(\Sigma_{n}^{*} \Sigma_{n}-z I_{N}\right)^{-1}$ in the sense that $(\xrightarrow{\text { a.s. }}$ stands for the almost sure convergence $)$ :

\frac{1}{N} \operatorname{Tr}\left(Q_{n}(z)-T_{n}(z)\right) \xrightarrow[N, n \rightarrow \infty]{\text { a.s. }} 0

which readily gives a deterministic approximation of the Stieltjes transform $N^{-1} \operatorname{Tr} Q_{n}(z)$ of the spectral measure of $\Sigma_{n} \Sigma_{n}^{*}$ in terms of $T_{n}$ (and similarly for $\tilde{Q}_{n}$ and $\tilde{T}_{n}$ ). Also proved in [22] is the convergence of bilinear forms

\begin{equation*}
u_{n}^{*}\left(Q_{n}(z)-T_{n}(z)\right) v_{n} \xrightarrow[N, n \rightarrow \infty]{\text { a.s. }} 0 \tag{1.4}
\end{equation*}

where $\left(u_{n}\right)$ and $\left(v_{n}\right)$ are sequences of $N \times 1$ deterministic vectors with uniformily bounded euclidian norm, which complements the picture of $T_{n}$ approximating $Q_{n}$.

Matrices $T_{n}=\left(t_{i j} ; 1 \leq i, j \leq N\right)$ and $\tilde{T}_{n}=\left(\tilde{t}_{i j} ; 1 \leq i, j \leq n\right)$ will play a fundamental role in the sequel and enable us to express a deterministic equivalent to $\mathbb{E} \mathcal{I}_{n}(\rho)$. Define $V_{n}(\rho)$ by:

V_{n}(\rho)=\frac{1}{N} \log \operatorname{det}\left(\rho\left(I_{N}+\tilde{\delta}_{n} D_{n}\right) I_{N}+A_{n}\left(I_{n}+\right.\right. & \left.\left.\delta_{n} \tilde{D}_{n}\right)^{-1} A_{n}^{*}\right) \\
& +\frac{1}{N} \log \left(I_{n}+\delta_{n} \tilde{D}_{n}\right)-\frac{\rho n}{N} \delta_{n} \tilde{\delta}_{n} \tag{1.5}
\end{align*}
$$

where $\delta_{n}$ and $\tilde{\delta}_{n}$ are evaluated at $z=-\rho$. Then the difference $\mathbb{E} \mathcal{I}_{n}(\rho)-V_{n}(\rho)$ goes to zero as $N, n \rightarrow \infty$.

In order to study the fluctuations $N\left(\mathcal{I}_{n}(\rho)-V_{n}(\rho)\right)$ and to establish a CLT, we study separately the quantity $N\left(\mathcal{I}_{n}(\rho)-\mathbb{E} \mathcal{I}_{n}(\rho)\right)$ from which the fluctuations arise and the quantity $N\left(\mathbb{E} \mathcal{I}_{n}(\rho)-V_{n}(\rho)\right)$ which yields a bias.

The fluctuations. In every case where the fluctuations of the mutual information have been studied, the variance of $N\left(\mathcal{I}_{n}(\rho)-V_{n}(\rho)\right)$ always proved to take a (somehow unexpected) remarkably simple closed-form expression (see for instance 30, 35, 37, and in a more mathematical flavour [19, 21]). The same phenomenon again occurs for the matrix model $\Sigma_{n}$ under consideration. Drop the subscripts $N, n$ and let

where $\bar{M}$ stands for the (elementwise) conjugate of matrix $M$. Let

where $d_{i}=\left[D_{n}\right]_{i i}, \tilde{d}_{j}=\left[\tilde{D}_{n}\right]_{j j}$, and all the needed quantities are evaluated at $z=-\rho$. The CLT then expresses as:

\frac{N}{\sqrt{\Theta_{n}}}\left(\mathcal{I}_{n}-\mathbb{E} \mathcal{I}_{n}\right) \xrightarrow[N, n \rightarrow \infty]{\mathcal{D}} \mathcal{N}(0,1)
$$

where $\xrightarrow{\mathcal{D}}$ stands for the convergence in distribution. Although complicated at first sight, variance $\Theta_{n}$ encompasses the case of standard real random variables $(\vartheta=1)$, standard complex random variables $(\vartheta=0)$ and all the intermediate cases $0<|\vartheta|<1$. Moreover, $\Theta_{n}$ often takes simpler forms if the variables are gaussian, real, etc. (see for instance Remark (2.2).

The bias. In the case where the entries are complex gaussian and $\kappa=0$, it has already been proved in 12 that $\mathbb{E} \mathcal{I}_{n}(\rho)-V_{n}(\rho)=\mathcal{O}\left(n^{-2}\right)$. In the case where matrices $D_{n}$ and $\tilde{D}_{n}$ are equal to the identity, we establish that there exists a deterministic quantity $\mathcal{B}_{n}(\rho)$ (described in Theorem 2.3) such that:

N\left(\mathbb{E} \mathcal{I}_{n}(\rho)-V_{n}(\rho)\right)-\mathcal{B}_{n}(\rho) \xrightarrow[N, n \rightarrow \infty]{ } 0

Outline of the article. In Section 2, we provide the main assumptions and state the main results of the paper: Definition of the variance $\Theta_{n}$ and asymptotic fluctuations of $N\left(\mathcal{I}_{n}(\rho)-\mathbb{E} \mathcal{I}_{n}(\rho)\right)$ (Theorem 2.2), asymptotic bias of $N\left(\mathbb{E} \mathcal{I}_{n}(\rho)-V_{n}(\rho)\right)$ (Theorem 2.3). Notations, important estimates and classical results are provided in Section 3 Sections 4 , 5 and 6 are devoted to the proof of Theorem 2.2. In Section 4 the general framework of the proof is exposed; in Section 5, the central part of the CLT and of the identification of the variance are established; remaining proofs are provided in Section 6 Finally, proof of Theorem 2.3 (bias) is provided in Section 7

## 2. The Central Limit Theorem for $\mathcal{I}_{n}(\rho)$

2.1. Notations, assumptions and first-order results. The indicator function of the set $\mathcal{A}$ will be denoted by $\mathbf{1}_{\mathcal{A}}(x)$, its cardinality by $\# \mathcal{A}$. If $z \in \mathbb{C}$, then $\bar{z}, \operatorname{Re}(z)$ and $\operatorname{Im}(z)$ respectively stand for its complex conjugate, real and imaginary part; denote by $\mathbf{i}=\sqrt{-1}$. As usual, $\mathbb{R}^{+}=\{x \in \mathbb{R}: x \geq 0\}, \mathbb{C}^{+}=\{z \in \mathbb{C}: \operatorname{Im}(z)>0\}$. Denote by $\xrightarrow{\mathcal{P}}$ the convergence in probability of random variables and by $\xrightarrow{\mathcal{D}}$ the convergence in distribution of probability measures. Denote by $\operatorname{diag}\left(a_{i} ; 1 \leq i \leq k\right)$ the $k \times k$ diagonal matrix whose diagonal entries are the $a_{i}$ 's. Element $(i, j)$ of matrix $M$ will be either denoted $m_{i j}$ or $[M]_{i j}$ depending on the
notational context. if $M$ is a $n \times n$ square matrix, $\operatorname{diag}(M)=\operatorname{diag}\left(m_{i i} ; 1 \leq i \leq n\right)$. Denote by $M^{T}$ the matrix transpose of $M$, by $M^{*}$ its Hermitian adjoint, by $\bar{M}$ the (elementwise) conjugate of matrix $M$, by $\operatorname{Tr}(M)$ its trace and $\operatorname{det}(M)$ its determinant (if $M$ is square). When dealing with vectors, $\|\cdot\|$ will refer to the Euclidean norm, and $\|\cdot\|_{\infty}$, to the max (or $\ell_{\infty}$ ) norm. In the case of matrices, $\|\cdot\|$ will refer to the spectral norm. If $\left(u_{n}\right)$ is a sequence of real numbers, then $u_{n}=\mathcal{O}\left(v_{n}\right)$ stands for $\left|u_{n}\right| \leq K\left|v_{n}\right|$ where constant $K$ does not depend on $n$.

Recall that

denote $D_{n}=\operatorname{diag}\left(d_{i}, 1 \leq i \leq N\right)$ and $\tilde{D}_{n}=\operatorname{diag}\left(\tilde{d}_{j}, 1 \leq j \leq n\right)$. When no confusion can occur, we shall often drop subscripts and superscripts $n$ for readability. Recall also that the asymptotic regime of interest is:

and will be simply denoted by $N, n \rightarrow \infty$ in the sequel. We can assume without loss of generality that there exist nonnegative real numbers $\ell^{-}$and $\ell^{+}$such that:

Assumption A-1. The random variables $\left(X_{i j}^{n} ; 1 \leq i \leq N, 1 \leq j \leq n, n \geq 1\right)$ are complex, independent and identically distributed. They satisfy

Associated to these variables are the quantities:

\vartheta=\mathbb{E}\left(X_{11}\right)^{2} \quad \text { and } \quad \kappa=\mathbb{E}\left|X_{11}\right|^{4}-2-|\vartheta|^{2} .
$$

Remark 2.1. (Gaussian distributions) If $X_{11}$ is a standard complex or real Gaussian random variable, then $\kappa=0$. More precisely, in the complex case, $\operatorname{Re}\left(X_{11}\right)$ and $\operatorname{Im}\left(X_{11}\right)$ are independent real Gaussian random variables, then $\vartheta=\kappa=0$; in the real case, then $\vartheta=1$ while $\kappa=0$.

Assumption A-2. The family of deterministic $N \times n$ complex matrices $\left(A_{n}, n \geq 1\right)$ is uniformily bounded for the spectral norm:

Assumption A-3. The families of real deterministic $N \times N$ and $n \times n$ matrices $\left(D_{n}\right)$ and $\left(\tilde{D}_{n}\right)$ are diagonal with non-negative diagonal elements, and are bounded for the spectral norm as $N, n \rightarrow \infty$ :

Theorem 2.1 (First order results - [20, 12]). Consider the $N \times n$ matrix $\Sigma_{n}$ given by (2.1) and assume that $\mathbf{A}-1, \mathbf{A}-2$ and $\mathbf{A}-3$ hold true. Then, the system (1.2) admits a unique solution $\left(\delta_{n}, \tilde{\delta}_{n}\right)$ in the class of Stieltjes transforms of nonnegative measures.
2.2. The Central Limit Theorem. In this section, we state the CLT then provide the asymptotic bias in some particular cases.

Theorem 2.2 (The CLT). Consider the $N \times n$ matrix $\Sigma_{n}$ given by (2.1) and assume that A-1, A-2 and A-3 hold true. Recall the definitions of $\delta$ and $\tilde{\delta}$ given by (1.2), $T$ and $\tilde{T}$ given by (1.3), $\gamma, \tilde{\gamma}, \underline{\gamma}$ and $\underline{\tilde{\gamma}}$ given by (1.6). Let $\rho>0$. All the considered quantities are evaluated at $z=-\rho$. Define $\Delta_{n}^{-}$and $\underline{\Delta}_{n}$ as

\underline{\Delta}_{n}=\left|1-\vartheta \frac{1}{n} \operatorname{Tr} D^{\frac{1}{2}} \bar{T} \bar{A}(I+\delta \tilde{D})^{-2} \tilde{D} A^{*} T D^{\frac{1}{2}}\right|^{2}-|\vartheta|^{2} \rho^{2} \underline{\gamma} \underline{\tilde{\gamma}} .
$$

Then the real numbers

\Theta_{n}=-\log \Delta_{n}-\log \underline{\Delta}_{n}+\kappa \frac{\rho^{2}}{n^{2}} \sum_{i=1}^{N} d_{i}^{2} t_{i i}^{2} \sum_{j=1}^{n} \tilde{d}_{j}^{2} \tilde{t}_{j j}^{2} \tag{2.3}
\end{equation*}
$$

are well-defined and satisfy:

$$
\begin{equation*}
0<\underset{n}{\liminf } \Theta_{n} \leq \underset{n}{\limsup } \Theta_{n}<\infty \tag{2.4}
\end{equation*}
$$

as $N, n \rightarrow \infty$. Let

\mathcal{I}_{n}(\rho)=\frac{1}{N} \log \operatorname{det}\left(\Sigma_{n} \Sigma_{n}^{*}+\rho I_{N}\right),
$$

then the following convergence holds true:

\frac{N}{\sqrt{\Theta_{n}}}\left(\mathcal{I}_{n}(\rho)-\mathbb{E} \mathcal{I}_{n}(\rho)\right) \xrightarrow[N, n \rightarrow \infty]{\mathcal{D}} \mathcal{N}(0,1) \text {. }
$$

Remark 2.2. (Simpler forms for the variance) We consider here special cases where the variance $\Theta_{n}$ takes a simpler form.
(1) The standard complex Gaussian case. Assume that the $X_{i j}$ 's are standard complex gaussian random variables, i.e. that both the real and imaginary parts of $X_{i j}$ are independent real gaussian random variables, each with variance $1 / 2$. In this case, $\vartheta=\kappa=0$ and $\Theta_{n}$ is equal to the first term of the right hand side (r.h.s.) of (1.7) we in particular recover the variance formula given in (35).
(2) The standard real case. Assume that the $X_{i j}$ 's are standard real random variables, assume also that $A$ has real entries. Then the two first terms of the r.h.s. of (1.7) are equal.
(3) The 'signal plus noise' model. In this case, $D_{n}=I_{N}$ and $\tilde{D}_{n}=I_{n}$, which already yields simplifications in (1.7). In the case where $\vartheta=0$, the variance writes:

As one may easily check, the first term of the variance only depends upon the spectrum of $A A^{*}$. The second term however also depends on the eigenvectors of $A A^{*}$ (see for instance [26]).

The asymptotic bias is described in the following theorem in two important cases.

Theorem 2.3 (The bias). Assume that the setting of Theorem 2.2 holds true. Recall that: $\kappa=\mathbb{E}\left|X_{i j}\right|^{4}-2-\left|\mathbb{E} X_{i j}^{2}\right|^{2}$.
(i) If the random variables $\left(X_{i j}^{n} ; i, j, n\right)$ are moreover complex gaussian with $\operatorname{Re}\left(X_{i j}^{n}\right)$ and $\operatorname{Im}\left(X_{i j}^{n}\right)$ independent, both with distribution $\mathcal{N}(0,1 / 2)$, then:

N\left(\mathbb{E} \mathcal{I}_{n}(\rho)-V_{n}(\rho)\right)=\mathcal{O}\left(\frac{1}{N}\right)
$$

(ii) If $D_{n}=I_{N}$ and $\tilde{D}_{n}=I_{n}$ (signal plus noise model), let the quantities $\delta, \tilde{\delta}, T, \tilde{T}, S$ and $\tilde{S}$ be evaluated at $z=-\omega$ and consider:

\mathcal{B}_{n}(\omega)=\kappa \frac{A(\omega)}{B(\omega)} \tag{2.5}
\end{equation*}
$$

where
$A(\omega)=\omega^{2}(1+\tilde{\delta}) \frac{1}{n} \operatorname{Tr} \tilde{S}^{2} \frac{1}{n} \operatorname{Tr} S T^{2}+\omega^{2}(1+\delta) \frac{1}{n} \operatorname{Tr} S^{2} \frac{1}{n} \operatorname{Tr} \tilde{S} \tilde{T}^{2}-\omega \frac{1}{n} \operatorname{Tr} S^{2} \frac{1}{n} \operatorname{Tr} \tilde{S}^{2}$,
$B(\omega)=1+\omega(1+\delta) \tilde{\gamma}+\omega(1+\tilde{\delta}) \gamma$.

Then,

Proof of Theorem 2.3•(i) can be found in [12, Theorem 2]; proof of Theorem 2.3-(ii) is postponed to Section 7

## 3. Notations and classical Results

3.1. Further notations. Denote by $Y$ the $N \times n$ matrix $n^{-1 / 2} D^{1 / 2} X \tilde{D}^{1 / 2}$; by $\left(\eta_{j}\right),\left(a_{j}\right)$ and $\left(y_{j}\right)$ the columns of matrices $\Sigma, A$ and $Y$. Denote by $\Sigma_{j}, A_{j}, Y_{j}$ and $\tilde{D}_{j}$, the matrices $\Sigma, A, Y$ and $\tilde{D}$ where column $j$ has been removed. The associated resolvent is $Q_{j}(z)=$ $\left(\Sigma_{j} \Sigma_{j}^{*}-z I_{N}\right)^{-1}$. We also denote by $A_{1: j}$ and $\Sigma_{1: j}$ the $N \times j$ matrices $A_{1: j}=\left[a_{1}, \cdots, a_{j}\right]$ and $\Sigma_{1: j}=\left[\eta_{1}, \cdots, \eta_{j}\right]$. Denote by $\mathbb{E}_{j}$ the conditional expectation with respect to the $\sigma$-field $\mathcal{F}_{j}$ generated by the vectors $\left(y_{\ell}, 1 \leq \ell \leq j\right)$. By convention, $\mathbb{E}_{0}=\mathbb{E}$.

We introduce here intermediate quantities of constant use in the rest of the paper. Let $1 \leq j \leq n$, denote by:

e_{j}(z) & =\eta_{j}^{*} Q_{j}(z) \eta_{j}-\left(\frac{\tilde{d}_{j}}{n} \operatorname{Tr} D Q_{j}(z)+a_{j}^{*} Q_{j}(z) a_{j}\right) \\
& =\left(y_{j}^{*} Q_{j}(z) y_{j}-\frac{\tilde{d}_{j}}{n} \operatorname{Tr} D Q_{j}(z)\right)+a_{j}^{*} Q_{j}(z) y_{j}+y_{j}^{*} Q_{j}(z) a_{j}  \tag{3.3}\\
\alpha(z) & =\frac{1}{n} \operatorname{Tr} D \mathbb{E} Q(z), \quad \tilde{\alpha}(z)=\frac{1}{n} \operatorname{Tr} \tilde{D} \mathbb{E} \tilde{Q}(z)  \tag{3.4}\\
C(z) & =\left(-z\left(I_{N}+\tilde{\alpha}(z) D\right)+A\left(I_{n}+\alpha(z) \tilde{D}\right)^{-1} A^{*}\right)^{-1} \tag{3.5}
\end{align*}

Using the well-known characterization of Stieltjes transforms (see for instance [20, Proposition $2.2-(2)]$ ), one can easily prove that $\tilde{b}_{j}$ is the Stieltjes transform of a probability measure. In particular $\left|\tilde{b}_{j}(z)\right| \leq\left(\operatorname{dist}\left(z, \mathbb{R}^{+}\right)\right)^{-1}$ for $z \in \mathbb{C}-\mathbb{R}^{+}$. The same estimate holds true for $\tilde{c}_{j}$.
3.2. Important identities. Recall the following classical identities.

- The inverse of a partitionned matrix (see for instance [23, Section 0.7.3]):

& =Q_{j}(z)+z \tilde{q}_{j j}(z) Q_{j}(z) \eta_{j} \eta_{j}^{*} Q_{j}(z)  \tag{3.9}\\
Q_{j}(z) & =Q(z)+\frac{Q(z) \eta_{j} \eta_{j}^{*} Q(z)}{1-\eta_{j}^{*} Q(z) \eta_{j}}  \tag{3.10}\\
1+\eta_{j}^{*} Q_{j}(z) \eta_{j} & =\frac{1}{1-\eta_{j}^{*} Q(z) \eta_{j}} \tag{3.11}
\end{align*}
$$

Note that:

Identities involving the deterministic equivalents $T$ and $\tilde{T}$. Define the $N \times N$ matrix $\mathcal{T}_{j}$ as

where $\delta$ and $\tilde{\delta}$ are defined in (1.2). Notice that matrix $\mathcal{T}_{j}$ is not obtained in general by solving the analogue of system (1.3) where $A$ is replaced with $A_{j}$. This matrix naturally pops up when expressing the diagonal elements of $\tilde{T}$. Indeed after some algebra (see for instance 18, Appendix B], we obtain:

3.3. Important estimates. We gather in this section matrix estimates which will be of constant use in the sequel.

Let $A$ and $B$ be two square matrices. Then

When $B$ is Hermitian non negative, then a consequence of Von Neumann's trace theorem is

The following lemma gives an estimate for a rank-one perturbation of the resolvent.
Lemma 3.1. The resolvents $Q$ and the perturbed resolvent $Q_{j}$ satisfy:

$$

for any $N \times N$ matrix $A$ with bounded spectral norm.
The following results describe the asymptotic behaviour of quadratic forms based on the resolvent.

Lemma 3.2 (Bai and Silverstein, Lemma 2.7 in [3]). Let $\boldsymbol{x}=\left(x_{1}, \cdots, x_{n}\right)$ be a $n \times 1$ vector where the $x_{i}$ are centered i.i.d. complex random variables with unit variance. Let $M$ be a $n \times n$ deterministic complex matrix. Then for any $p \geq 2$, there exists a constant $K_{p}$ for which

\mathbb{E}\left|\boldsymbol{x}^{*} M \boldsymbol{x}-\operatorname{Tr} M\right|^{p} \leq K_{p}\left(\left(\mathbb{E}\left|x_{1}\right|^{4} \operatorname{Tr} M M^{*}\right)^{p / 2}+\mathbb{E}\left|x_{1}\right|^{2 p} \operatorname{Tr}\left(M M^{*}\right)^{p / 2}\right)
$$

Remark 3.1. There are some important consequences of the previous lemma. Let ( $M_{n}$ ) be a sequence of $n \times n$ deterministic matrices with bounded spectral norm and $\left(\boldsymbol{x}_{n}\right)$ be a sequence of random vectors as in the statement of Lemma 3.2. Then for any $p \geq 2$,

where $e_{j}$ is given by (3.3) (the estimate $\mathbb{E}\left|e_{j}\right|^{p}=\mathcal{O}\left(n^{-p / 2}\right)$ is proved in [18, Appendix B]).
We gather in the following theorem some of the results proved in [22].
Theorem 3.3. Assume that the setting of Theorem 2.2 holds true. Let $\left(u_{n}\right)$ and $\left(v_{n}\right)$ be two sequences of deterministic complex $N \times 1$ vectors bounded in the Euclidian norm:

$$

Then,
(1) For every $z \in \mathbb{C}-\mathbb{R}^{+}$, there exist nonnegative constants $K_{1}(z), K_{2}(z)<\infty$, which do not depend on $N, n$, such that:

\sum_{j=1}^{n} \mathbb{E}\left|u_{n}^{*} Q_{j} a_{j}\right|^{2} \leq K_{1}(z) \quad \text { and } \mathbb{E}\left(\sum_{j=1}^{n} \mathbb{E}_{j}\left|u_{n}^{*} Q_{j} a_{j}\right|^{2}\right)^{2} \leq K_{2}(z)
$$

(2) For every $z \in \mathbb{C}-\mathbb{R}^{+}$and for $p \geq 1$, there exists a nonnegative constant $K(z)<\infty$, which does not depend on $N, n$, such that:

$$
\mathbb{E}\left|u_{n}^{*}(Q(z)-T(z)) v_{n}\right|^{2 p} \leq \frac{K(z)}{n^{p}}
$$

(3) For every $\rho \in \mathbb{R}_{+}^{*}$ and every sequence of deterministic matrices $\left(U_{n}\right)$ with bounded spectral norms, we have:

\left|\frac{1}{n} \operatorname{Tr} U(T(-\rho)-\mathbb{E} Q(-\rho))\right| \leq \frac{K}{n}
$$

(4) For every $z \in \mathbb{C}-\mathbb{R}^{+}$and for $p \geq 1$, there exists a nonnegative constant $K(z)<\infty$, which does not depend on $N$, n, such that:

\begin{equation*}
\mathbb{E}\left|u_{n}^{*}\left(Q_{j}(z)-\mathcal{T}_{j}(z)\right) v_{n}\right|^{2 p} \leq \frac{K(z)}{n^{p}} \tag{3.21}
\end{equation*}
$$

Items (3) and (4) of Theorem 3.3 are not direct consequences of results in [22]; therefore elements of proof are provided in [18, Appendix B].

The following results stem from lemma 3.2 and theorem 3.3 and will be of constant use in the sequel. Recalling (3.1), (3.3), and (3.8), it is clear that $\tilde{q}_{j j}=\tilde{b}_{j}+z \tilde{q}_{j j} \tilde{b}_{j} e_{j}$. Using (3.20) and bounding $\left|q_{j j}\right|$ and $\left|\tilde{b}_{j}\right|$ (see for instance [20]), we have

Of course, the counterpart of Theorem 3.3 for the co-resolvent $\tilde{Q}$ and matrix $\tilde{T}$ holds true. In particular, taking the vectors $u_{n}$ and $v_{n}$ as the $j$ th canonical vector of $\mathbb{C}^{n}$ yields the following estimate:

Lemma 3.4. Assume that the setting of theorem 2.2 holds true. Then, the following quantities satisfy:

& \tilde{\delta}_{\min } \triangleq \frac{\tilde{\boldsymbol{d}}_{\min }}{\rho+\boldsymbol{\ell}^{+} \boldsymbol{d}_{\max } \tilde{\boldsymbol{d}}_{\max }+\boldsymbol{a}_{\max }^{2}} \leq \tilde{\delta}_{n} \leq \tilde{\delta}_{\max } \triangleq \frac{\tilde{\boldsymbol{d}}_{\max }}{\rho} \\
& \frac{\boldsymbol{d}_{\min }^{2}}{\boldsymbol{\ell}^{+}\left(\rho+\boldsymbol{d}_{\max } \tilde{\boldsymbol{d}}_{\max }+\boldsymbol{a}_{\max }^{2}\right)^{2}} \leq \gamma_{n} \leq \frac{\boldsymbol{\ell}^{+} \boldsymbol{d}_{\max }^{2}}{\rho^{2}} \\
& \frac{\tilde{\boldsymbol{d}}_{\min }^{2}}{\left(\rho+\boldsymbol{\ell}^{+} \boldsymbol{d}_{\max } \tilde{\boldsymbol{d}}_{\max }+\boldsymbol{a}_{\max }^{2}\right)^{2}} \leq \tilde{\gamma}_{n} \leq \frac{\tilde{\boldsymbol{d}}_{\max }^{2}}{\rho^{2}} \\
& \frac{\boldsymbol{d}_{\min }^{2}}{\tilde{\ell}^{+}\left(\rho+\boldsymbol{d}_{\max }\right.} \\

3.4. Other important results. The main result we shall rely on to establish the Central Limit theorem is the following CLT for martingales:

Let $\gamma_{1}^{(n)}, \gamma_{2}^{(n)}, \ldots, \gamma_{n}^{(n)}$ be a martingale difference sequence with respect to the increasing filtration $\mathcal{F}_{1}^{(n)}, \ldots, \mathcal{F}_{n}^{(n)}$. Assume that there exists a sequence of real positive numbers $\Upsilon_{n}^{2}$ such that

Remark 3.2. Note that if moreover $\lim _{\inf }^{n} \Upsilon_{n}^{2}>0$, it is sufficient to prove:

We now state a covariance identity (the proof of which is straightforward and therefore omitted) for quadratic forms based on non-centered vectors. This identity explains to some extent the various terms obtained in the variance.

Let $\boldsymbol{x}=\left(x_{1}, \cdots, x_{n}\right)^{T}$ be a $n \times 1$ vector where the $x_{i}$ are centered i.i.d. complex random variables with unit variance. Let $\boldsymbol{y}=n^{-1 / 2} D^{1 / 2} \boldsymbol{x}$ where $D$ is a $n \times n$ diagonal nonnegative deterministic matrix. Let $M=\left(m_{i j}\right)$ and $P=\left(p_{i j}\right)$ be $n \times n$ deterministic complex matrices and let $\boldsymbol{u}$ be a $n \times 1$ deterministic vector.

If $M$ is a $n \times n$ matrix, $\operatorname{vdiag}(M)$ stands for the $n \times 1$ vector $\left[M_{11}, \cdots, M_{n n}\right]^{T}$.
Denote by $\Upsilon(M)$ the random variable:

& \quad+\frac{\mathbb{E}\left[\left|x_{1}\right|^{2} x_{1}\right]}{n^{3 / 2}}\left(\boldsymbol{u}^{*} P D^{3 / 2} \operatorname{vdiag}(M)+\boldsymbol{u}^{*} M D^{3 / 2} \operatorname{vdiag}(P)\right) \\
& \quad+\frac{\mathbb{E}\left[\left|x_{1}\right|^{2} \bar{x}_{1}\right]}{n^{3 / 2}}\left(\operatorname{vdiag}(P)^{T} D^{3 / 2} M \boldsymbol{u}+\operatorname{vdiag}(M)^{T} D^{3 / 2} P \boldsymbol{u}\right) \\
& \quad+\frac{\kappa}{n^{2}} \sum_{i=1}^{n} d_{i i}^{2} m_{i i} p_{i i} \tag{3.26}
\end{align*}
$$

where $\kappa=\mathbb{E}\left|x_{1}\right|^{4}-2-\left|\mathbb{E} x_{1}^{2}\right|^{2}$.
Remark 3.3. Identity (3.26) is the cornerstone for the proof of the CLT; it is the counterpart of Identity (1.15) in [4]. The complexity of Identity (3.26) with respect to [4, Identity (1.15)] lies in 8 extra terms and stems from two elements:
(1) The fact that matrix $\Sigma$ is non-centered.
(2) The fact that the random variables $X_{i j}$ 's are either real and complex with no further assumption (in particular, $\mathbb{E} X_{i j}^{2} \neq 0$ a priori in the complex case).

It is this identity which induces to a large extent all the computations in the present article.

## 4. Proof of Theorem 2.2 (part I)

Decomposition of $\mathcal{I}_{n}-\mathbb{E} \mathcal{I}_{n}$, Cumulant and cross-moments terms in the variance
4.1. Decomposition of $\mathcal{I}_{n}-\mathbb{E} \mathcal{I}_{n}$ as a sum of martingale differences. Denote by

follows verbatim from [21, Section 6.2]. Moreover, it is a matter of bookkeeping to establish the following (cf. [21, Section 6.4]):

Hence, the details are omitted. In view of Theorem3.6 Eq. (3.25), (4.1) and (4.2), the CLT will be established if one proves the following 3 results:
(1) (Lyapounov condition)

It is straightforward (and hence omitted) to verify Lyapounov condition. The convergence toward the variance is the cornerstone of the proof of the CLT: The rest of this section together with much of Section 5 are devoted to establish it. The estimates over the variance $\Theta_{n}$, also central to apply Theorem 3.6, are established in Section 6.2,

Notice that $\mathbb{E}_{j-1}\left(\mathbb{E}_{j} \Gamma_{j}\right)^{2}=\mathbb{E}_{j-1}\left(\mathbb{E}_{j} \rho \tilde{b}_{j} e_{j}\right)^{2}$. We prove hereafter that

& +\frac{4}{n} \sum_{j=1}^{n} \rho^{2} \tilde{d}_{j}^{3 / 2} \tilde{t}_{j j}^{2} \operatorname{Re}\left(\varsigma \frac{a_{j}^{*}\left(\mathbb{E}_{j} Q_{j}\right) D^{3 / 2} \operatorname{vdiag}\left(\mathbb{E}_{j} Q_{j}\right)}{\sqrt{n}}\right) \\
& +\frac{1}{n} \sum_{j=1}^{n} \rho^{2} \tilde{t}_{j j}^{2}\left(\frac{\tilde{d}_{j}^{2}}{n} \operatorname{Tr}\left(\mathbb{E}_{j} Q_{j}\right) D\left(\mathbb{E}_{j} Q_{j}\right) D+2 \tilde{d}_{j} a_{j}^{*}\left(\mathbb{E}_{j} Q_{j}\right) D\left(\mathbb{E}_{j} Q_{j}\right) a_{j}\right) \\
& +\frac{1}{n} \sum_{j=1}^{n} \rho^{2} \tilde{t}_{j j}^{2}\left(|\vartheta|^{2} \frac{\tilde{d}_{j}^{2}}{n} \operatorname{Tr}\left(\mathbb{E}_{j} Q_{j}\right) D\left(\mathbb{E}_{j} \bar{Q}_{j}\right) D+2 \operatorname{Re}\left(\vartheta \tilde{d}_{j} a_{j}^{*}\left(\mathbb{E}_{j} Q_{j}\right) D\left(\mathbb{E}_{j} \bar{Q}_{j}\right) \bar{a}_{j}\right)\right) \\
\triangleq & \sum_{j=1}^{n} \chi_{1 j}+\sum_{j=1}^{n} \chi_{2 j}+\sum_{j=1}^{n} \chi_{3 j}+\sum_{j=1}^{n} \chi_{4 j} .

4.2. Key lemmas for the identification of the variance. The remainder of the proof of Theorem 2.2 is devoted to find deterministic equivalents for the terms $\sum_{j=1}^{n} \chi_{\ell j}$ for $\ell=$ $1,2,3,4$.

\end{aligned}

The term $\left|\varepsilon_{1, j}\right|=n^{-1}\left|\mathbb{E}_{j}\left[\operatorname{Tr} D^{2} \operatorname{diag}\left(\mathbb{E}_{j} Q_{j}\right)\left(Q_{j}-Q\right)\right]\right|$ is of order $\mathcal{O}\left(n^{-1}\right)$ thanks to Lemma 3.1. Moreover, $\mathbb{E}\left|\varepsilon_{2, j}\right|=\mathcal{O}\left(n^{-1 / 2}\right)$ by (3.23). Hence,

& +\frac{K}{n} \sum_{j=1}^{n} \mathbb{E}\left|a_{j}^{*}\left(\mathbb{E}_{j} Q_{j}\right) D^{3 / 2} \frac{\operatorname{vdiag}\left(Q_{j}-Q\right)}{\sqrt{n}}\right| \tag{4.4}

The first term satisfies

As $\left\|n^{-1 / 2} D^{3 / 2} \operatorname{vdiag}(T)\right\|=\left(n^{-1} \sum_{i=1}^{N} d_{i}^{3} t_{i i}^{2}\right)^{1 / 2} \leq K$, Theorem 3.3-(1) can be applied, and the first term in the right handside (r.h.s.) of (4.4) is of order $n^{-1 / 2}$. We now deal with the second term of the r.h.s.

by Lemma 3.1.

The core of the paper is devoted to the proof of Lemma 4.3. This proof is provided in Section ??. The proof of Lemma 4.4 follows the same canvas with minor differences.

## 5. Proof of Theorem 2.2 (part II)

This section is devoted to the proof of Lemma 4.3 We begin with the following lemma which implies that $\sum_{j=1}^{n} \chi_{3 j}$ can be replaced by its expectation.

Lemma 5.1. For any $N \times 1$ vector a with bounded Euclidean norm, we have,

There are structural links between the various quantities $\psi_{j}, \zeta_{k j}, \theta_{k j}$ and $\varphi_{j}$. The idea behind the proof is to establish the equations between these quantities. Solving these equations will yield explicit expressions which will enable to identify $\frac{1}{n} \sum_{j=1}^{n}\left(\rho^{2} \tilde{t}_{j j}^{2} \tilde{d}_{j}^{2} \psi_{j}+2 \rho^{2} \tilde{d}_{j} \tilde{t}_{j j}^{2} \theta_{j j}\right)$ as the deterministic quantity $-\log \Delta_{n}$.

Proof of (5.1) is broken down into four steps. In the first step, we establish an equation between $\zeta_{k j}, \psi_{j}$ and $\varphi_{j}$ (up to $\mathcal{O}\left(n^{-1 / 2}\right)$ ): Eq. (5.7). In the second step, we establish an equation between $\psi_{j}$ and $\varphi_{j}$ : Eq. (5.11). In the third step, we establish an equation between $\zeta_{k j}, \psi_{j}$ and $\theta_{k j}$ : Eq. (5.12). Gathering these results, we obtain a $2 \times 2$ linear system (5.15) whose solutions are $\psi_{j}$ and $\varphi_{j}$. In the fourth step, we solve this system and finally establish (5.1).

## 6. Proof of Theorem 2.2 (part III)

In this section, we complete the proof of Theorem[2.2 Proof of Lemma 4.4 is very close to the proof of Lemma 4.3 we therefore only provide its main landmarks. We finally establish the main estimates over $\left(\Theta_{n}\right)$.
6.1. Elements of proof for Lemma 4.4. Proof of Lemma 4.4 relies on the following counterpart Lemma 3.2

Lemma 6.1. Assume that the setting of Lemma 3.2 holds true; and let $\mathbb{E} x^{2}=\vartheta$. Then for any $p \geq 2$,

By (3.18), $0 \leq \underline{\gamma} \leq \gamma$; furthermore, $|\vartheta| \leq 1,\left|\underline{F}_{j}\right| \leq F_{j}$, and $\left|\underline{G}_{j}\right| \leq G_{j}$. As a result, $\underline{\boldsymbol{\Delta}}_{j} \geq \boldsymbol{\Delta}_{j}$. Hence, by Lemma 5.3, the perturbation remains of order $\mathcal{O}\left(n^{-1 / 2}\right)$ after solving the system. Performing the same derivations as in Step 4 in Section 5 it can be established that $\underline{\boldsymbol{\Delta}}_{n}=\underline{\Delta}_{n}$. We finally end up with:

6.2. Estimates over $\Theta_{n}$. In order to conclude the proof of Theorem [2.2, it remains to prove that $0<\liminf _{n} \Theta_{n} \leq \lim \sup _{n} \Theta_{n}<\infty$.

Consider first the upper bound. By Lemma [3.5] $\sup _{n}\left(-\log \Delta_{n}\right)<\infty$. As $\underline{\Delta}_{n} \geq \Delta_{n}$, $\log \underline{\Delta}_{n}$ is defined and $\sup _{n}\left(-\log \underline{\Delta}_{n}\right)<\infty$. By Lemma 3.4, the cumulant term in the expression of $\Theta_{n}$ is bounded, hence $\lim \sup _{n} \Theta_{n}<\infty$.

We now prove that $\lim \inf \Theta_{n}>0$. To this end, write:

## Appendix A. Proofs of some lemmas

Now $\operatorname{Tr} D T D T \leq \boldsymbol{d}_{\max }^{2} \operatorname{Tr} T^{2}$ by applying twice (3.19), which in turn is lower than $N \boldsymbol{d}_{\max }^{2} \rho^{-2}$, hence the third upper bound, and the fourth which can be proved similarly. Let us now prove the first lower bound.

\sum_{i=1}^{j} \mathbb{E}\left|\tilde{b}_{i} \tilde{q}_{i i} e_{i} a_{i}^{*} M_{i} a_{i}\right|^{2} & \leq K \sum_{i=1}^{j} \mathbb{E} \mathbb{E}^{(i)}\left|e_{i} a_{i}^{*} M_{i} a_{i}\right|^{2} \\
& \leq \frac{K}{n} \sum_{i=1}^{j} \mathbb{E}\left|a_{i}^{*} M_{i} a_{i}\right|^{2} \leq \frac{K}{n} \sum_{i=1}^{j} \mathbb{E}\left|a_{i}^{*} Q_{i} a\right|^{2} \leq \frac{K}{n}
\end{aligned}
$$

where $\mathbb{E}^{(i)}=\mathbb{E}\left[\cdot \mid y_{1}, \ldots, y_{i-1}, y_{i+1}, \ldots, y_{n}\right]$. Moreover,

$$
\sum_{i=1}^{j} \mathbb{E}\left|\tilde{b}_{i} \tilde{q}_{i i} e_{i} y_{i}^{*} M_{i} a_{i}\right|^{2} \leq K \sum_{i=1}^{j}\left(\mathbb{E}\left|e_{i}\right|^{4}\right)^{1 / 2}\left(\mathbb{E}\left|y_{i}^{*} M_{i} a_{i}\right|^{4}\right)^{1 / 2} \leq \frac{K}{n}
$$

and similarly for the terms in $a_{i}^{*} M_{i} y_{i}$ and in $y_{i}^{*} M_{i} y_{i}$. It results that $\mathbb{E}\left|X_{2}\right|^{2}=\mathcal{O}\left(n^{-1}\right)$. We now turn to the term $Z$ of equation (A.3). To control the variance of $Z$, we only need to control the variances of the terms:

Z_{1} & =\sum_{i=1}^{j}\left(\mathbb{E}_{i}-\mathbb{E}_{i-1}\right)\left(\mathbb{E}_{j} \tilde{q}_{i i} a^{*} Q_{i} y_{i} \eta_{i}^{*} Q_{i}\right) D\left(\mathbb{E}_{j} \tilde{q}_{i i} Q_{i} \eta_{i} a_{i}^{*} Q_{i} a\right) \\
Z_{2} & =\sum_{i=1}^{j}\left(\mathbb{E}_{i}-\mathbb{E}_{i-1}\right)\left\|\mathbb{E}_{j}\left(\tilde{q}_{i i} y_{i}^{*} Q_{i} a D^{1 / 2} Q_{i} \eta_{i}\right)\right\|^{2} \\
Z_{3} & =\sum_{i=1}^{j}\left(\mathbb{E}_{i}-\mathbb{E}_{i-1}\right)\left\|\mathbb{E}_{j}\left(\tilde{q}_{i i} a_{i}^{*} Q_{i} a D^{1 / 2} Q_{i} \eta_{i}\right)\right\|^{2}
\end{aligned}
$$

The first term satisfies

$$
\begin{aligned}
\mathbb{E}\left|Z_{1}\right|^{2} & \leq 2 \sum_{i=1}^{j} \mathbb{E}\left|\left(\mathbb{E}_{j} \tilde{q}_{i i} a^{*} Q_{i} y_{i} \eta_{i}^{*} Q_{i}\right) D\left(\mathbb{E}_{j} \tilde{q}_{i i} Q_{i} \eta_{i} a_{i}^{*} Q_{i} a\right)\right|^{2} \\
& \leq 2 \sum_{i=1}^{j} \mathbb{E}\left|\left(\mathbb{E}_{j} a^{*} Q_{i} y_{i} \eta_{i}^{*} Q_{i}\right) D Q_{i} \eta_{i} a_{i}^{*} Q_{i} a\right|^{2} \\
& =2 \sum_{i=1}^{j} \mathbb{E}\left[\left|a_{i}^{*} Q_{i} a\right|^{2} \mathbb{E}^{(i)}\left|\left(\mathbb{E}_{j} a^{*} Q_{i} y_{i} \eta_{i}^{*} Q_{i}\right) D Q_{i} \eta_{i}\right|^{2}\right] \\
& \leq \frac{K}{n} \sum_{i=1}^{j} \mathbb{E}\left|a_{i}^{*} Q_{i} a\right|^{2}=\mathcal{O}\left(n^{-1}\right)
\end{aligned}
$$

where the second inequality comes from $\mathbb{E}\left|\mathbb{E}_{j}(X) \mathbb{E}_{j}(Y)\right|^{2}=\mathbb{E}\left|\mathbb{E}_{j}\left(X \mathbb{E}_{j}(Y)\right)\right|^{2} \leq \mathbb{E}\left|X \mathbb{E}_{j}(Y)\right|^{2}$. The terms $Z_{2}$ and $Z_{3}$ can be handled similarly; details are omitted. The result is $\mathbb{E}|Z|^{2} \leq$ $K / n$.

Hence, $\operatorname{var}\left(a^{*}\left(\mathbb{E}_{j} Q\right)^{2} a\right)=\mathcal{O}\left(n^{-1}\right)$. The estimate $\operatorname{var}\left(\operatorname{Tr}\left(\mathbb{E}_{j} Q\right) D\left(\mathbb{E}_{j} Q\right)\right)=\mathcal{O}(1)$ can be established similarly.
A.5. Proof of Lemma 5.3. The $F_{j}$ increase to $F_{n}=n^{-1} \operatorname{Tr} D^{1 / 2} T A(1+\delta \tilde{D})^{-2} \tilde{D} A^{*} T D^{1 / 2}<$ 1 by lemma 3.5. As $\gamma>0$ and $M_{j}$ and $G_{j}$ are increasing, $\boldsymbol{\Delta}_{j}$ is decreasing. In order to show that $\Delta_{n}=\Delta_{n}$, we only need to show that $M_{n}+G_{n}=\rho^{2} \tilde{\gamma}$. We have

G_{n}=\frac{1}{n} \operatorname{Tr} \tilde{D}(I+\delta \tilde{D})^{-2} A^{*} T A \tilde{D}(I+\delta \tilde{D})^{-2} A^{*} T A-\frac{1}{n} \sum_{k=1}^{n}\left(\frac{\tilde{d}_{k} a_{k}^{*} T a_{k}}{\left(1+\delta \tilde{d}_{k}\right)^{2}}\right)^{2}
$$

Recall from (3.15) and (3.16) that $\left(1+\delta \tilde{d}_{k}\right)^{-2} a_{k}^{*} T a_{k}=\left(1+\delta \tilde{d}_{k}\right)^{-1}-\rho \tilde{t}_{k k}$. Hence

$$
\frac{1}{n} \sum_{k=1}^{n}\left(\frac{\tilde{d}_{k} a_{k}^{*} T a_{k}}{\left(1+\delta \tilde{d}_{k}\right)^{2}}\right)^{2}=\frac{1}{n} \sum_{k=1}^{n} \rho^{2} \tilde{d}_{k}^{2} \tilde{t}_{k k}^{2}-\frac{1}{n} \sum_{k=1}^{n} \frac{\rho \tilde{d}_{k}^{2} \tilde{t}_{k k}}{\left(1+\delta \tilde{d}_{k}\right)}+\frac{1}{n} \sum_{k=1}^{n} \frac{\tilde{d}_{k}^{2} a_{k}^{*} T a_{k}}{\left(1+\delta \tilde{d}_{k}\right)^{3}}
$$

which results in

$$
\begin{aligned}
M_{n}+G_{n}=\frac{\rho}{n} \operatorname{Tr} \tilde{D} \tilde{T} \tilde{D}(I+\delta \tilde{D})^{-1}-\frac{1}{n} & \operatorname{Tr} \tilde{D}^{2}(I+\delta \tilde{D})^{-3} A^{*} T A \\
& +\frac{1}{n} \operatorname{Tr} \tilde{D}(I+\delta \tilde{D})^{-2} A^{*} T A \tilde{D}(I+\delta \tilde{D})^{-2} A^{*} T A
\end{aligned}
$$

Now, one can check with the help of (3.17) that $\rho^{2} \tilde{\gamma}=\rho^{2} n^{-1} \operatorname{Tr} \tilde{D} \tilde{T} \tilde{D} \tilde{T}$ is equal to the r.h.s. of this equation. Lemma 5.3 is proved.

## Appendix B. Additional proofs (Extended version)

In this section, we gather the proofs of many results mentionend without proofs in the short version of the paper.
B.1. Proofs of Eq. (3.15) and Eq. (3.16). Proof of Eq. (3.15) mainly relies on matrix identities (3.6) and (3.7). To lighten the computations, let us introduce the following notations:

A_{1}^{*} \mathcal{I} a_{1} & -z \mathcal{\mathcal { I }}-1+A_{1}^{*} \mathcal{I} A_{1}
\end{array}\right]^{-1}
$$

Hence, according to (3.6):

$$
\begin{aligned}
& \frac{1}{\tilde{t}_{11}}=-z\left(1+\delta \tilde{d}_{1}\right)+a_{1}^{*} \mathcal{I} a_{1}-a_{1}^{*} \mathcal{I} A_{1}\left[-z \tilde{\mathcal{I}}^{-1}+A_{1}^{*} \mathcal{I} A_{1}\right]^{-1} A_{1}^{*} \mathcal{I} a_{1} \\
& \stackrel{(a)}{=}-z\left(1+\delta \tilde{d}_{1}\right)+a_{1}^{*} \mathcal{I} a_{1}-a_{1}^{*} \mathcal{I} A_{1}\left[-\frac{1}{z} \tilde{\mathcal{I}}+\frac{1}{z} \tilde{\mathcal{I}} A_{1}^{*} \mathcal{T}_{1} A_{1} \tilde{\mathcal{I}}\right] A_{1}^{*} \mathcal{I} a_{1} \\
& \stackrel{(b)}{=}-z\left(1+\delta \tilde{d}_{1}\right)+a_{1}^{*} \mathcal{I} a_{1}+\frac{1}{z} a_{1}^{*} \mathcal{I}\left(\mathcal{T}_{1}^{-1}+z \mathcal{I}^{-1}\right) \mathcal{I} a_{1} \\
&-\frac{1}{z} a_{1}^{*} \mathcal{I} A_{1} \tilde{\mathcal{I}} A_{1}^{*}\left[I_{N}+z \mathcal{T}_{1} \mathcal{I}^{-1}\right] \mathcal{I} a_{1} \\
&=-z\left(1+\delta \tilde{d}_{1}\right)-a_{1}^{*} \mathcal{T}_{1} a_{1}
\end{aligned}
$$

where (a) follows from (??), (b) from equalities

$$
\mathcal{T}_{1} A_{1} \tilde{\mathcal{I}} A_{1}^{*}=I_{N}+z \mathcal{T}_{1} \mathcal{I}^{-1} \quad \text { and } \quad A_{1} \tilde{\mathcal{I}} A_{1}^{*}=\mathcal{T}_{1}^{-1}+z \mathcal{I}^{-1}
$$

which follow from the mere definition of $\mathcal{T}_{1}$. Finally, (3.15) is established.
Let us now turn to the proof of (3.16). Notice first that $T$ writes:

T=\left[-z\left(I_{N}+\tilde{\delta} D\right)+A_{1}\left(I_{n-1}+\delta \tilde{D}_{1}\right)^{-1} A_{1}^{*}+\frac{a_{1} a_{1}^{*}}{1+\delta \tilde{d}_{1}}\right]^{-1}

Applying (??) readily yields:

It remains to multiply by $a_{1}^{*}$ (left), $b$ (right) and to use (3.15) to establish (3.16).
B.2. Proof of Inequality (3.20). We provide here some elements to establish that $\mathbb{E}\left|e_{j}\right|^{p}=$ $\mathcal{O}\left(n^{-p / 2}\right)$. Recall the definition (3.3) of $e_{j}$ and write:

The first term of the r.h.s. can be directly estimated with the help of Lemma 3.2. The two remaining terms are similar and can be estimated in the following way:

$$
\begin{aligned}
\mathbb{E}\left|a_{j}^{*} Q_{j} y_{j}\right|^{p} & =\mathbb{E}\left(y_{j}^{*} Q_{j}^{*} a_{j} a_{j}^{*} Q_{j} y_{j}\right)^{p / 2} \\
& \leq 2^{p-1}\left(\mathbb{E}\left|y_{j}^{*} Q_{j}^{*} a_{j} a_{j}^{*} Q_{j} y_{j}-\frac{d_{j}^{2}}{n} \operatorname{Tr} Q_{j}^{*} a_{j} a_{j}^{*} Q_{j}\right|^{p / 2}+\mathbb{E}\left|\frac{1}{n} \operatorname{Tr} Q_{j}^{*} a_{j} a_{j}^{*} Q_{j}\right|^{p / 2}\right)
\end{aligned}
$$

The first term of the r.h.s. can be handled with the help of Lemma 3.2 (notice that $\operatorname{Tr}\left(Q_{j}^{*} a_{j} a_{j}^{*} Q_{j}\right)^{p / 2}$ is of order 1$)$, and the second term is directly of the right order.
B.3. Proofs of Theorem 3.3-(3). The estimate established in [22] is:

$$
\left|\frac{1}{n} \operatorname{Tr} U(T(-\rho)-\mathbb{E} Q(-\rho))\right| \leq \frac{K}{\sqrt{n}}
$$

The speed $\mathcal{O}\left(n^{-1}\right)$ stated in the theorem is higher and therefore does not directly follow from [22. We provide here the needed extra arguments.
