# Polar [3+2] cycloaddition of ketones with electrophilically activated carbonyl ylides. Synthesis of spirocyclic dioxolane indolinones.

The [3+2] cycloaddition reaction between carbonyl ylides generated from epoxides and ketones (ethyl pyruvate, ethyl phenylglyoxylate, isatin, $N$-methylisatin and 5-chloroisatin) to give 10 substituted dioxolanes and spirocyclic dioxolane indolinones was investigated. The effect of microwave irradiation on the outcome of the reaction was studied. The thermal reaction between 2,2-dicyano-3-phenyloxirane and $N$-methylisatin was theoretically studied using DFT methods. This reaction is a domino process that comprises two steps. The first is the thermal ring opening of the epoxide to yield a carbonyl ylide intermediate, whereas the second step is a polar [3+2] 15 cycloaddition to yield the final spiro cycloadducts. The cycloaddition presents a low stereoselectivy and a large regio- and chemoselectivity. Analysis of the electrophilicity values and the Fukui functions at the reagents involved in the cycloaddition step allowed to explain the chemical outcome.

## Introduction

${ }_{20}$ Cycloaddition reactions are one of the most important synthetic processes, with both synthetic and mechanistic interest in organic chemistry. Current understanding of the underlying principles in reactions such as 1,3-dipolar cycloaddition has grown from a fruitful interplay between
25 theory and experiment. ${ }^{1}$ 1,3-Dipolar cycloadditions, whose general concept was introduced by Huisgen and co-workers in 1960 s, ${ }^{2}$ are versatile tools for building five-membered heterocycles. ${ }^{1}$ Carbonyl ylides, generated by thermal electrocyclic ring opening of epoxides, are known to react ${ }_{30}$ with $\pi$-bonds of alkynes, ${ }^{3}$ alkenes, ${ }^{3 a, b, 4}$ imines, ${ }^{5}$ aldehydes ${ }^{6}$ and thioketones, ${ }^{7}$ affording highly substituted dihydrofurans, tetrahydrofurans, oxazolidines, dioxolanes and oxathiolanes, respectively.

Spiro-oxindole system occupies a special place in 35 heterocyclic chemistry because it is the core structure of many pharmacological agents and natural alkaloids. ${ }^{8}$ The dioxolane

[^0]moiety represents another important skeleton present in molecules endowed with biological activities, ${ }^{9}$ notably when substituted by an aryl group at the 2 position, and both an aryl
40 or alkyl group and an ester function at the 4 position. ${ }^{10}$ Due to the importance of these two structural frameworks, synthesis of molecular architectures containing both spiro-oxindole and dioxolane moities could be of biological interest. We focused on spiro[1,3-dioxolane-4,3'-indolin- 2 '-ones], which are very 45 rare, and have only been synthesized by Nair and co-workers using cycloadditions of carbonyl ylides generated from diazo ketones in the presence $\mathrm{Rh}_{2}(\mathrm{OAc})_{4} .{ }^{11}$

To the best of our knowledge, we report here the first cycloadditions between carbonyl ylides, thermically generated ${ }_{50}$ from epoxides, and ketones. The mechanism of these reactions was studied using DFT calculations.

## Results and discussion

## Synthetic Aspects

Reactions were first carried out between 2,2-dicyano-3-(4${ }_{55}$ substituted)phenyloxiranes 1a-c ${ }^{12}$ and ethyl pyruvate (2a) (2 molar equivalent). The conversion to the corresponding ethyl 5,5-dicyano-4-methyl-2-phenyl-1,3-dioxolane-4-carboxylates 3-5 monitored by NMR showed that the reactions carried out in refluxing toluene were complete after $27 \mathrm{~h}(\mathrm{R}=\mathrm{H}), 29 \mathrm{~h}(\mathrm{R}$ $\left.{ }_{60}=\mathrm{Cl}\right)$ and $14 \mathrm{~h}(\mathrm{R}=\mathrm{OMe})($ Table 1, Entries 1-3).

The cis products $\mathbf{3 a - 5 a}$ were isolated from the crude mixture by column chromatography over silica gel in yields ranging from 53 to $56 \%$ and identified by NMR. NOESY, HMBC and HMQC sequences performed on a $\mathrm{CDCl}_{3}$ solution ${ }_{65}$ of the racemic 4a allowed the assignments of all the ${ }^{1} \mathrm{H}$ and ${ }^{13} \mathrm{C}$ NMR signals. In addition, the NOESY experiment clearly showed the relationship between H2 (see Table 1, a) at 6.27 ppm and the methyl group at C 4 at 1.96 ppm . Cis $\mathbf{4 a}$ was then identified unequivocally by X-ray structure analysis. Suitable
colorless crystals were obtained by slowly evaporating a $\mathrm{CDCl}_{3}$ solution of $\mathbf{4 a}$ (Fig. 1). $\dagger$ The trans compounds $\mathbf{3 b} \mathbf{- 5 b}$ were identified using ${ }^{1} \mathrm{H}$ and ${ }^{13} \mathrm{C}$ NMR spectra of enriched fractions.

5 The diastereoisomeric ratios were determined from ${ }^{1} \mathrm{H}$ NMR spectra of the crude mixtures. When $\mathrm{R}=\mathrm{H}$ and OMe , the cis products 3a and 5a, respectively, only slightly predominate over the trans products $\mathbf{3 b}$ and $\mathbf{5 b}$ (respective ratios of $60 / 40$ and $59 / 41$ ). When $\mathrm{R}=\mathrm{Cl}$, the formation of cis ${ }_{10} \mathbf{4 a}$ is slightly more favored over trans $\mathbf{4 b}$ (64/36).

A rising number of articles have advocated the use of microwave technology in organic synthesis. Harsh conditions such as high temperatures and long reaction times often required for cycloaddition reactions could generally be ${ }_{15}$ reduced using this technique. ${ }^{13}$ Syntheses of tetrahydrofurans, dioxolanes and oxazolidines using cycloaddition reactions of alkenes, aldehydes or imines with carbonyl ylides generated from epoxides were recently reported using microwave irradiation. ${ }^{14}$
20 Thus, in order to shorten the reaction times, several experiments were performed at various powers and under different conditions using microwave irradiation. ${ }^{15}$ The best conversions were obtained without solvent (power: 285 W ), with significant reduction of reaction times in comparison to ${ }_{25}$ reaction in toluene at reflux ( $55 \mathrm{~min}(\mathrm{R}=\mathrm{H}$ ) against $27 \mathrm{~h}, 50$ $\min (\mathrm{R}=\mathrm{Cl})$ against 29 h , and $30 \mathrm{~min}(\mathrm{R}=\mathrm{OMe})$ against 14 h). Recourse to classical heating was nevertheless preferred since the formation of the cis products, easier to isolate from the crude mixtures than the trans, was disfavored using 30 microwave heating mode (a:b ratios of 57/43, 59/41 and 41/59 for compounds 3-5, against 60/40, 64/36 and 59/41 in toluene at reflux) (Table 1, Entries 1-3).

For these reasons, reactions between 2,2-dicyano-3-(4substituted) phenyloxiranes $\mathbf{1 a}-\mathbf{c}^{12}$ and ethyl phenylglyoxylate 35 (2b) (1 molar equivalent) were next carried out in refluxing toluene. Replacing ethyl methylglyoxylate by ethyl phenylglyoxylate slightly disfavored the formation of the cis compounds 6a-8a over the trans $\mathbf{6 b}-\mathbf{8 b}$ (a:b ratios of 54/46, 60/40 and 38/62 for compounds 6-8, against 60/40, 64/36 and ${ }_{40} 59 / 41$ for compounds 3-5) (Table 1, Entries 4-6).

Whereas neither cis $\mathbf{6 a}$ nor trans $\mathbf{6 b}$ could be isolated as pure from the diastereoisomeric mixture but only identified using ${ }^{1} \mathrm{H}$ and ${ }^{13} \mathrm{C}$ NMR spectra of enriched fractions, the cis product $7 \mathbf{a}$ and the trans products $\mathbf{7 b}-\mathbf{8 b}$ were isolated from 45 the crude mixture by column chromatography over silica gel followed by crystallization from petrol $/ \mathrm{Et}_{2} \mathrm{O} 4: 1$ in moderate to medium yields. Trans $\mathbf{8 b}$ was identified by NMR 2D experiments. A NOESY sequence performed on a $\mathrm{C}_{6} \mathrm{D}_{6}$ solution revealed the absence of relationship between H 2 (see
${ }_{50}$ Table 1, b) at 6.62 ppm and the unsubstituted phenyl ortho hydrogens H2" and H6" at 7.27 ppm. The structure of trans 7b was elucidated by X-ray analysis of colorless crystals obtained by slowly evaporating a solution in acetone (Fig. 2). $\dagger$

55 In order to reach spirocyclic dioxolane structures, reactions were performed with three different isatins. When carried out between 2,2-dicyano-3-phenyloxiranes $\mathbf{1 a}-\mathbf{c}^{12}$ and isatin (9a) (1 molar equivalent), the reactions were completed in refluxing toluene after reaction times of $32 \mathrm{~h}(\mathrm{R}=\mathrm{H}), 24 \mathrm{~h}(\mathrm{R}$ $\left.{ }_{60}=\mathrm{Cl}\right)$ and $14 \mathrm{~h}(\mathrm{R}=\mathrm{OMe})$ to afford 5,5-dicyano-2-

[^1]phenylspiro[1,3-dioxolane-4,3'-indolin-2'-ones] 10-12 (Table 2, Entries 1-3).

The cis products 10a-12a were isolated from the crude mixture by column chromatography over silica gel in yields 5 ranging from 42 to $66 \%$, and identified by NMR. NOESY, HMBC and HMQC sequences performed on the racemic 12a allowed the assignments of all the ${ }^{1} \mathrm{H}$ and ${ }^{13} \mathrm{C}$ NMR signals. In addition, the proximity between H 2 (see Table 2, a) at 6.41 ppm and $\mathrm{H}^{\prime}$ at 7.52 ppm was shown by conducting the ${ }_{10}$ NOESY experiment in $\mathrm{C}_{6} \mathrm{D}_{6}$. Cis 11a and 12a were then identified unequivocally by their crystal structures. Colorless

crystals suitable for X-ray structure analysis were obtained by slowly evaporating an acetone solution of 11a and a dibutyl 15 ether solution of 12a (Fig. 3). $\dagger$

After identification of the trans compounds 10b-12b using ${ }^{1} \mathrm{H}$ and ${ }^{13} \mathrm{C}$ NMR spectra of enriched fractions, the diastereoisomeric ratios were calculated from the ${ }^{1} \mathrm{H}$ NMR spectra integration of the crude mixtures. When $\mathrm{R}=\mathrm{H}$ and ${ }_{20} \mathrm{OMe}$, the cis products $\mathbf{1 0 a}$ and 12a, respectively, only slightly predominate over the trans products 10b and 12b (respective ratios of $57 / 43$ and 55/45). In contrast, when $\mathrm{R}=\mathrm{Cl}$, the formation of cis 11a is clearly favored over trans 11b (75/25).

If recourse to microwave irradiation could reduce the ${ }_{25}$ reaction times as previously noted, it was again discarded, the formation of the trans products, more difficult to isolate for the crude mixtures than the cis, being similarly favored using this heating mode (Table 2, Entries 1-3).

The reactions carried out between 2,2-dicyano-3${ }_{30}$ phenyloxiranes $\mathbf{1 a}-\mathbf{c}^{12}$ and $N$-methylisatin (9b) ( 0.7 molar equivalent) in refluxing toluene show that the methyl group on isatin helps in favoring the formation of the cis products. Indeed, diastereoisomeric ratios of 73/27, 74/26 and 63/37 were respectively obtained for compounds 13-15 against ${ }_{35} 57 / 43,75 / 25$ and $55 / 45$ for compounds 10-12 (Table 2, Entries 4-6).

The cis products 13a and 14a were isolated from the crude mixture by fractional crystallization from petrol/ $\mathrm{Et}_{2} \mathrm{O} 5: 1$ in satisfying yields. Cis 13a was identified from its ${ }^{1} \mathrm{H}$ and ${ }^{13} \mathrm{C}$ ${ }^{0}$ NMR spectra. After complete assignments of all the ${ }^{1} \mathrm{H}$ and ${ }^{13} \mathrm{C}$ signals using NOESY, HMBC and HMQC sequences performed on 14a, the proximity between H 2 (see Table 2, a, 6.98 ppm ) and $\mathrm{H}^{\prime}$ ( 7.86 ppm ) was evidenced using the NOESY spectrum. The structures of $\mathbf{1 3 a}$ and $\mathbf{1 4 a}$ were 45 confirmed by X-ray analysis of colorless crystals obtained by slowly evaporating an acetone solution (Fig. 4). $\dagger$

Cis 15a could not be purified, but trans $\mathbf{1 5 b}$ was isolated in $30 \%$ yield, and its structure elucidated by X-ray analysis. Single crystals of trans $\mathbf{1 4 b}$ suitable for X-ray diffraction

analysis were collected too (Fig. 5). $\dagger$ The products 15a and 13b were identified using ${ }^{1} \mathrm{H}$ and ${ }^{13} \mathrm{C}$ NMR spectra of enriched fractions.

The presence of a chloro group at the 5-position of isatin 5 does not greatly affect the diastereoisomeric ratios. Indeed, when 5 -chloroisatin (9c) ( 0.7 molar equiv) was similarly involved in the reactions with 2,2-dicyano-3-phenyloxiranes $\mathbf{1 a - c},{ }^{12} \mathbf{a}: \mathbf{b}$ ratios of 59/41, $71 / 29$ and $58 / 42$ were respectively obtained for compounds 16-18, against 57/43, 75/25 and ${ }_{10}$ 55/45 using isatin (9a) (Table 2, Entries 7-9).

C bond to yield the carbonyl ylide intermediate $\mathbf{C Y}$, and ii) a [3+2] cycloaddition reaction between $\mathbf{C Y}$ and the isatin $\mathbf{9 b}$. In order to obtain mechanistic details as well as the stereo-, regio- and chemoselectivity of the formation of the spirocyclic 5 dioxolane indolinones 13a,b (see Schemes 1 and 2), the two steps involved in these domino reactions were studied using DFT calculations at the B3LYP/6-31G* level.

Study of the thermal ring opening of the epoxide $\mathbf{1 a}$.
The first step of this domino reaction is the thermal ring 10 opening of the epoxide 1a through the breaking of the C1-C3 bond of the oxirane to yield the carbonyl ylide intermediate CY. An exhaustive exploration of the reaction path of this step allowed to find a transition structure, TS1, and the
subsequent carbonyl ylide CY (see Scheme 1).
15 In gas phase, the activation energy associated to the breaking of the C1-C3 bond of the epoxide $1 \mathbf{1 a}$ is 26.9 kcal $\mathrm{mol}^{-1}$; the carbonyl ylide $\mathbf{C Y}$ is located $11.7 \mathrm{kcal} \mathrm{mol}^{-1}$ above the epoxide 1a (see Table 3). These highly unfavorable energies are in reasonable agreement with the high 20 temperature required for the reaction (toluene at reflux).

The geometry of TS1 is given in Fig. 7. The length of the C1-C3 breaking bond at TS1 is $2.124 \AA$. Analysis of the atomic movement associated to the unique imaginary frequency of TS1, $112.9 \mathrm{i} \mathrm{cm}^{-1}$, shows that this TS is mainly 25 associated to the C1-C3 breaking bond and to the disrotatory movement of the substituents present at these carbon atoms, as a consequence of the change in the hybridization of C 1 and C 3 carbon atoms from $\mathrm{sp}^{3}$ in $\mathbf{1 a}$ to $\mathrm{sp}^{2}$ in $\mathbf{C Y}$. The carbonyl ylide CY presents a planar rearrangement that allows the ${ }_{30}$ maximum stabilization by charge delocalization at the corresponding zwitterionic structure. The $\mathrm{C} 1-\mathrm{O} 2$ bond length in CY is very short, $1.294 \AA$, as a consequence of the delocalization of the O 2 oxygen lone pair over the C 1 carbon. On the other hand, both C3-CN bond lengths at CY, $1.400 \AA$, 35 are shorter than those at the epoxide 1a, $1.455 \AA$, as a consequence of the delocalization of the negative charge present on C3 towards the two electron-withdrawing CN groups.

The extent of bond formation and bond rupture along the ${ }_{40}$ reaction pathway is provided by the concept of bond order (BO). ${ }^{16}$ At TS1, the BO value of the C1-C3 breaking bond is 0.31. This low value indicates that, at the TS, the breaking bond process is very advanced. This fact is in clear agreement with the endothermic character of the process. ${ }^{17}$ At the 45 carbonyl ylide CY, the C1-O2 BO value, 1.24 , points out its $\pi$ character as a consequence of some delocalization of the O 2 oxygen lone pair over the C 1 carbon. The $\mathrm{C} 1-\mathrm{C}(\mathrm{Ar})$ bond order value, 1.22 , indicates the participation of the $\pi$ aromatic ring in the stabilization of the carbonyl ylide. On the other ${ }_{50}$ hand, the BO value of both $\mathrm{C} 3-\mathrm{C}(\mathrm{CN})$ bonds, 1.17 , points out their $\pi$ character as a consequence of the delocalization of the negative charge developed over the C3 carbon atom over the two electron-withdrawing CN groups.

Study of the [3+2] cycloaddition reaction of the carbonyl ylide ${ }_{55} \boldsymbol{C Y}$ with the isatin $\mathbf{9 b}$.

Due to the existence of two $\mathrm{C}=\mathrm{O}$ reactive centers at the isatin 9b, a carbonyl C5-O4 and an amide carboxyl C7-O6 double bond, and the asymmetry of both reagents, this cycloaddition reaction can yield up to eight isomeric spiro-cycloadducts.

The formation of these cycloadducts can be related to the chemo-, regio- and stereoselectivity of this cycloaddition reaction. The experimental results indicate that these cycloaddition reactions take place with a total 5 chemoselectivity, with the unique participation of the carbonyl C5-O4 double bond, with total regioselectivity, with the unique formation of the regioisomers associated to the C1O4 and C3-C5 bond formation, and with a low stereoselectivity due to the formation of the two possible ${ }_{10}$ stereoisomers. In order to explain the experimental results, the chemo-, regio- and stereoselectivity associated to these cycloadditions were studied. For this purpose we studied: the two stereoselective channels associated to the approach of the carbonyl ylide O 2 oxygen atom to the plane containing the ${ }_{15} \mathrm{C}=\mathrm{O} \pi$ bond, named as $a$ and $b$; those regioisomeric channels associated to the approach of carbonyl ylide CY to the carbonyl C5-O4 double bond of $\mathbf{9 b}$, named as channels rgl and rg2, and finally, the more favorable regioisomeric approach modes of CY to the carboxyl C7-O6 double bond of ${ }_{20} 9 \mathbf{9}$, named as channels chl, allowed us to study the chemoselectivity in these cycloaddition reactions. Therefore, six reactive channels were studied (see Scheme 2). An exhaustive exploration of the potential energy surface of these cycloadditions allowed us to find a series of molecular ${ }_{25}$ complexes (MCs) that open the cycloaddition pathways. In these MCs, the two reagents are separated by $2.8 \AA$. From these MCs we selected the more favorable one, MC. MC is located $-7.1 \mathrm{kcal} \mathrm{mol}^{-1}$ below reagents, $\mathbf{C Y}+\mathbf{9 b}$. Analysis of the stationary points involved in these cycloaddition reactions 30 indicates that they present concerted mechanisms. Hence, six TS, TSrg1a, TSrg1b, TSrg2a, TSrg2b, TSch1a, and TSch1b, and the corresponding spiro-cycloadducts were located and characterized.

The energy results are summarized in Table 3. The most ${ }_{35}$ favorable reactive channels correspond to the formation of the stereoisomeric spiro-cycloadducts 13a and 13b, via TSrg1a and TSrg1b, respectively. From MC, the activation energies associated to the formation of the spiro-cycloadducts 13a and 13b are 5.5 (TSrg1a) and 6.5 (TSrg1b) $\mathrm{kcal} \mathrm{mol}^{-1}$. The low

${ }_{40}$ energy difference between TSrg1a and TSrg1b, $\Delta \Delta \mathrm{E}=1.0$ kcal $\mathrm{mol}^{-1}$, agrees with the low stereoselectivity experimentally observed. Note that major stereoisomer 13a has the cis stereochemistry. TSrg2a and TSrg2b, are located $c a .10 \mathrm{kcal} \mathrm{mol}^{-1}$ above TSrg1a. This large energy difference ${ }_{45}$ prevents the formation of the regioisomeric cycloadducts $\mathbf{1 9 a}$ and 19b, fact that is consistent with the experimental results. Finally, the formation of the spiro-cycloadduct 20a, via TSch1a, is $2.9 \mathrm{kcal} \mathrm{mol}^{-1}$ more unfavorable than the formation of 13a. This energy result is in reasonable ${ }_{50}$ agreement with the chemoselectivity experimentally observed (attack to the carbonyl C5-O4 double bond against the attack to the carboxyl C7-O6 one). The chemoselectivity can be explained by a larger nucleophilic character of the carbonyl O6 oxygen than the carboxyl O6 oxygen (see later). All these 55 cycloaddition reactions are strongly exothermic: between -29 and $-32 \mathrm{kcal} \mathrm{mol}^{-1}$ for the rgl and rg 2 regioisomeric channels and between -19 and $-20 \mathrm{kcal} \mathrm{mol}^{-1}$ for the ch 1 regioisomeric channels.

The geometries of the TSs involved in these cycloadditions ${ }_{60}$ are given in Fig. 8. The lengths of the forming bonds at the TSs are: $1.966 \AA(\mathrm{C} 1-\mathrm{O} 4)$ and $2.425 \AA(\mathrm{C} 3-\mathrm{C} 5)$ at TSrg1a, $2.007 \AA(\mathrm{C} 1-\mathrm{O} 4)$ and $2.614 \AA(\mathrm{C} 3-\mathrm{C} 5)$ at TSrg1b, $2.036 \AA$ (C3-O4) and $2.209 \AA(\mathrm{C} 1-\mathrm{C} 5)$ at TSrg2a, $2.061 \AA$ (C3-O4) and $2.176 \AA(\mathrm{C} 1-\mathrm{C} 5)$ at TSrg2b, $1.913 \AA(\mathrm{C} 1-\mathrm{O} 6)$ and 2.687 © (C3-C7) at TSch1a and $1.801 \AA(\mathrm{C} 1-\mathrm{O} 6)$ and $2.551 \AA$ (C3C7) at TSch1b. Some conclusions can be drawn from these values: i) at all TSs, the length of the O-C forming bond is shorter that the $\mathrm{C}-\mathrm{C}$ one, and ii) the more favorable regioisomeric TSs, rgl, are more asynchronous than the ${ }_{70}$ regioisomeric rg2 ones. Note that the ch1 channels are equivalent to the rgl ones.

The BO values of the forming bonds at these TSs are: 0.34 (C1-O4) and 0.22 (C3-C5) at TSrg1a, 0.31 (C1-O4) and 0.17 (C3-C5) at TSrg1b, 0.32 (C3-O4) and 0.34 (C1-C5) at TSrg2a, 0.31 (C3-O4) and 0.34 (C1-C5) at TSrg2b, 0.37 (C1${ }_{5}$ O6) and 0.12 (C3-C7) at TSch1a, and 0.46 (C1-O6) and 0.16 (C3-C7) at TSch1b. These BO values indicate that both regioisomeric series of TSs present a different behavior. While the TSs associated to the rgl channel, including the chl one, correspond to asynchronous bond-formation processes 10 where the formation of the C-O bond is more advanced than the $\mathrm{C}-\mathrm{C}$ one, the more unfavorable TSs associated to the rg2 channel correspond to synchronous bond-formation processes where the $\mathrm{C}-\mathrm{C}$ bond formation is slightly more advanced than the $\mathrm{C}-\mathrm{O}$ one.
15 The natural population analysis (NPA) allows us to evaluate the charge separation at the TSs, that is the polar character of the cycloaddition. The natural charges at the TSs appear shared between the carbonyl ylide CY, and the isatin $\mathbf{9 b}$. The net charge at the isatin 9 b framework at the TSs are: ${ }_{20} 0.09$ e at TSrg1a, -0.13 e at TSrg1b, -0.26 e at TSrg2a, 0.25 e at TSrg2b, 0.0 e at TSch1a and -0.01 e at TSch1b. These values indicate that at the TSs associated to the attack of the carbonyl C5-O4 double bond there is some charge separation, and that it is larger at the more unfavorable ${ }_{25}$ regioisomeric TSs. At the TSs associated to the attack of the carboxyl C7-O6 double bond, the charge separation is unappreciable.
Thermodynamic analysis of the domino reaction between $1 \mathbf{1}$ and $9 b$.

30 As the two reactions involved in this domino process present different molecularity: the ring-opening process is unimolecular and the cycloaddition reaction is bimolecular, the free energies of the stationary points associated to the stereoisomeric channels $\boldsymbol{a}$ were computed at 383.95 K . ${ }_{35}$ Solvent effects of toluene on the energies were considered at the thermodynamic calculations (see computational methods). The energy results are summarized in Table 3, while a schematic representation of the free energy profiles is depicted in Fig. 9.

40 The activation free energy (considering the solvent effects) associated to the ring-opening process is $23.4 \mathrm{kcal} \mathrm{mol}^{-1}$. Formation of the carbonyl ylide $\mathbf{C Y}$ is an endergonic process in $8.7 \mathrm{kcal} \mathrm{mol}^{-1}$. Two factors are responsible of the decrease of these unfavorable energies respect to the gas-phase results:
${ }_{45}$ i) solvent effects stabilize more efficiently the TS1 and the carbonyl ylide CY than the epoxide 1a as a consequence of the zwitterionic character of the formers, and ii) an increase of the entropy of the system along the ring opening process.

The inclusion of solvent effects and thermal corrections to ${ }_{50}$ the energies and the entropies rises the relative free energies of the stationary points involved in the [3+2] cycloaddition reactions as a consequence of the bimolecular character of the reactions. Now MC is located 10.2 kcal above reagents, CY + 9b. Therefore, in spite of the exothermic character of the 55 formation of MC, its existence on the free energy surface is irrelevant. The free activation energy associated to TSrg1a is $20.0 \mathrm{kcal} \mathrm{mol}^{-1}$ (relative to $\mathbf{C Y}+\mathbf{9 b}$ ). TSrg2a remains 11.7 kcal $\mathrm{mol}^{-1}$ above TSrg1a, so this regioisomeric channel is clearly unfavorable. Although the chemoselectivity, measured ${ }_{60}$ as $\Delta \Delta \mathrm{G}^{\#}$, decreases slightly to $2.8 \mathrm{kcal} \mathrm{mol}^{-1}$, the formation of 13a is exergonic in $-3.9 \mathrm{kcal} \mathrm{mol}^{-1}$ and the formation of $20 \mathbf{a}$ is endergonic in $5.3 \mathrm{kcal} \mathrm{mol}^{-1}$.

Both ring opening and cycloaddition reactions have similar activation energies but, due to the endergonic character of the ${ }_{65}$ formation of CY, TSrg1a is located $6.8 \mathrm{kcal} \mathrm{mol}^{-1}$ above TS1 and, therefore, the cycloaddition reaction becomes the ratedetermining step of this domino process. In addition, the overall process is endergonic in $4.7 \mathrm{kcal} \mathrm{mol}^{-1}$.

## Analysis based in the reactivity indexes.

${ }_{70}$ Recent studies carried out on cycloaddition reactions ${ }^{18}$ have shown that the reactivity indexes ${ }^{19}$ are powerful tools to study the reactivity. In Table 4, the static global properties (electronic chemical potential, $\mu$, chemical hardness, $\eta$, and global electrophilicity, $\omega$ ) of the carbonyl ylides $\mathbf{C Y}(\mathrm{R}=\mathrm{H})$ 75 and $\mathbf{C Y}(\mathrm{R}=\mathrm{OMe})$, and isatins $\mathbf{9 a}, \mathbf{b}$, are presented.

The electronic chemical potential of the carbonyl ylides CY and CY', -0.1693 and -0.1576 au , are close to those of the isatins $9 \mathbf{9}, \mathbf{b},-0.1691$ and -0.1646 au. The presence of electron-releasing substituents, methyl or methoxy, increases
${ }_{80}$ the value of the electronic chemical potential of these molecules. The similar values found in these reagents do not allow to predict clearly the direction of the charge transfer along these polar cycloadditions.

The carbonyl ylides present a very large electrophilicity 85 value, 4.29 (CY) and 3.79 ( $\mathbf{C Y}{ }^{\prime}$ ) eV, being classified as strong electrophiles within the electrophilicity scale. ${ }^{18}$ The inclusion of an electron-releasing methoxy group on the aryl substituent decreases slightly the electrophilicity of the
carbonyl ylide. The electrophilicity value of the isatin $9 \mathbf{a}\left(\mathrm{R}^{1}\right.$ $=\mathrm{R}^{2}=\mathrm{H}$ ) is 2.71 eV , being also classified also as a strong electrophile. Inclusion of an electron-releasing methyl group on the amide nitrogen atom decreases slightly the 5 electrophilicity value of isatin $9 b\left(R^{1}=M e, R^{2}=H\right)$ to 2.66 eV . This decrease with the electron-releasing substitution, which can be related with an increase of the nucleophilicity of this compound, is in agreement with the reduction of the reaction time for isatin $9 \mathbf{b}$ relative to that for isatin $9 \mathbf{a}$.
10 The larger electrophilicity values of the carbonyl ylides $\mathbf{C Y}$ and CY' respect to the isatins $\mathbf{9 a}, \mathbf{b}$ indicate that, along a polar cycloaddition, the carbonyl ylides CY and CY' will behave as electrophiles whereas the isatins $\mathbf{9 a , b}$ will behave as nucleophiles. ${ }^{20}$
15 Analysis of the Fukui functions at the carbonyl ylide CY indicates that the C1 carbon corresponds to the most electrophilic center of this intermediate, while its C3 carbon is the most nucleophilic center. This picture agrees with a heterolytic $\mathrm{C}-\mathrm{C}$ bond breaking along the ring-opening process, 20 where the negative charge on the C3 carbon is delocalized over the two adjacent electron-withdrawing cyano groups, while the positive charge developed on the C 1 carbon is stabilized by the O 2 oxygen and the nearby conjugated phenyl substituent. On the other hand, at the isatin 9b, while the
${ }_{25}$ carbonyl C5 carbon atom is the most electrophilic center, the carbonyl O 4 oxygen atom is the most nucleophilic one. In a polar cycloaddition, the more favorable electronic interaction takes place between the most electrophilic center of the electrophile reagent and the most nucleophilic center of the 30 nucleophile reagent. This favorable electronic interaction controls both the asynchronicity of the bond formation and the regioselectivity of the reaction. Therefore, both the asynchronicity found at the TSs as well as the regioselectivity of the reactions are in agreement with the ${ }_{35}$ electrophile/nucleophile interaction predicted by the analysis of the Fukui functions.

## Conclusions

In conclusion, we have shown that first ethyl 4-phenyl or 4-methyl-2-phenyl-1,3-dioxolane-4-carboxylate and then 2-
40 phenylspiro[1,3-dioxolane-4,3'-indolin-2'-ones] can be easily prepared by a regioselective cycloaddition between ethyl glyoxylates or isatins, and carbonyl ylides, thermically generated from epoxides. It is relevant to mention that trans spiro[1,3-dioxolane-4,3'-indolin-2'-ones] have been 45 synthesized by Nair and co-workers using carbonyl ylides generated from diazo ketones in the presence of $\mathrm{Rh}_{2}(\mathrm{OAc})_{4},{ }^{11}$ whereas our method rather favors the formation of cis products, which are unknown.

The cycloaddition reaction between 2,2-dicyano-3${ }_{50}$ phenyloxirane and $N$-methylisatin to yield spiro-cycloadducts has been theoretically studied using DFT methods at the B3LYP/6-31G* level. The reaction is a domino process that comprises two steps. The first one is the thermal cleavage of the oxirane ring to yield a carbonyl ylide intermediate, 55 whereas the second step is a [3+2] polar cycloaddition initialized by the nucleophilic attack of $N$-methylisatin to the carbonyl ylide to yield final spiro-cycloadducts. Spite of the
large activation energy associated to the oxirane cleavage and the low activation energy associated to the subsequent ${ }_{60}$ nucleophilic attack, thermodynamic calculations in toluene indicate that the cycloaddition reaction is the rate-determining step. The cycloaddition presents a low stereoselectivy and a large regio- and chemoselectivity. The more favorable channels are associated to the nucleophilic attack of the isatin ${ }_{65}$ carbonyl oxygen atom to the phenyl substituted carbon atom of the carbonyl ylide.

Analysis of the reactivity indexes of the reagents indicates that while the large electrophilicity of the carbonyl ylide accounts for the nucleophilic attack of isatin to ylide, analysis 70 of the Fukui functions allows to explain the regio- and chemoselectivity experimentally observed. The more favorable electronic interaction takes place between the carbonyl oxygen atom of isatin, the more nucleophilic center, and the phenyl substituted carbon atom of the carbonyl ylide, 75 the more electrophilic one.

## Experimental

## Syntheses: general methods

Melting points were measured on a Kofler apparatus. NMR spectra were recorded with a Bruker ARX 200P, a Bruker 80 Avance 300P or a Bruker Avance 300 M spectrometer ( ${ }^{1} \mathrm{H}$ at 200 or 300 MHz , and ${ }^{13} \mathrm{C}$ at 50 or 75 MHz ). Assignments of protons and carbons could be made on the basis of bidimensional techniques (NOESY, HMQC and HMBC experiments). Mass spectra (HRMS) were recorded with a ${ }_{85}$ Varian MAT 311 spectrometer, and microanalyses were performed on a Flash EA1112 Thermo Electron. Microwave reactions were performed in open glass containers (Prolabo Synthewave ${ }^{\circledR} 402$ ) with accurate control of power (maximum power: 300 W ) and temperature (infrared detection).
90 Oxiranes were prepared according to described procedures. ${ }^{12}$ Toluene was dried before use. Reactions were performed under dry argon. Petrol refers to petroleum ether (bp $40-60^{\circ} \mathrm{C}$ ).

General procedure 1. A mixture of epoxide ( 3 mmol ) and ${ }_{95}$ ketone (amount given in the product description) in anhydrous toluene ( 30 mL ) was heated at reflux under Ar. The mixture was then evaporated to dryness and purified as specified in the product description.

General procedure 2. A mixture of epoxide ( 3 mmol ) and 100 ketone (amount given in the product description) was heated in a microwave oven (power, temperature and time are given in the product description). The residue was purified as specified in the product description.

Diastereoisomers of ethyl 5,5-dicyano-4-methyl-2-phenyl-1,3${ }_{105}$ dioxolane-4-carboxylate (3). The general procedure 1 (reflux of 27 h ), using 3-phenyloxirane-2,2-dicarbonitrile ( $\mathbf{1 a}, 0.51 \mathrm{~g}$ ) and ethyl pyruvate ( $\mathbf{2 a}, 0.70 \mathrm{~g}, 0.66 \mathrm{~mL}, 6.0 \mathrm{mmol}$ ), gave a $60 / 40$ mixture from which the major diastereoisomer 3a was isolated by column chromatography over silica gel (eluent: petrol/AcOEt $11070: 30)$ in $54 \%(0.46 \mathrm{~g})$ yield as a greenish oil: ${ }^{1} \mathrm{H}$ NMR $\left(\mathrm{CDCl}_{3}\right)$ : $\delta 1.41\left(\mathrm{t}, 3 \mathrm{H}, J=7.1 \mathrm{~Hz}, \mathrm{CH}_{3}\right), 1.97\left(\mathrm{~s}, 3 \mathrm{H}, \mathrm{CH}_{3}\right), 4.37-4.47(\mathrm{~m}$, $\left.2 \mathrm{H}, \mathrm{CH}_{2}\right), 6.29(\mathrm{~s}, 1 \mathrm{H}, \mathrm{H} 2), 7.42-7.57(\mathrm{~m}, 5 \mathrm{H}, \mathrm{Ph}) ;{ }^{13} \mathrm{C}$ NMR

The general procedure $2(285 \mathrm{~W}, 15$ ${ }_{15} \mathrm{~min}$ to reach $180^{\circ} \mathrm{C}$ and 55 min at $180^{\circ} \mathrm{C}$ ), using 3-phenyloxirane-2,2-dicarbonitrile ( $\mathbf{1 a}, 0.51 \mathrm{~g}$ ) and ethyl pyruvate ( $\mathbf{2 a}, 0.46 \mathrm{~g}, 0.44 \mathrm{~mL}, 4.0 \mathrm{mmol}$ ), gave a $57 / 43$ mixture from which the major diastereoisomer 3a was isolated by column chromatography over silica gel (eluent: petrol/AcOEt 70:30) in ${ }_{20} 52 \% ~(0.45 \mathrm{~g})$ yield.

Diastereoisomers of ethyl 2-(4-chlorophenyl)-5,5-dicyano-4-methyl-1,3-dioxolane-4-carboxylate (4). ## Crystallography

Single crystals suitable for X-ray diffraction were grown after slow evaporation (several days at room temperature) of ${ }_{80}$ solutions of $\mathbf{4 a}$ in $\mathrm{CDCl}_{3}$, 12a in dibutyl ether, and 7b, 11a, 13a, 14a, 14b, 15b, 16a, 17a, 17b and 18b in acetone.

The samples were studied with graphite monochromatized $\mathrm{Mo}_{\mathrm{K} \alpha}$ radiation $(\lambda=0.71073 \AA)$. Except for 12a, X-ray diffraction data were collected at $T=100$ (2) K using APEXII ${ }_{85}$ Bruker-AXS diffractometer. The structure was solved by direct methods using the SIR97 program, ${ }^{21}$ and then refined with full-matrix least-square methods based on $\mathrm{F}^{2}$ (SHELX$97)^{22}$ with the aid of the WINGX program. ${ }^{23}$ All nonhydrogen atoms were refined with anisotropic thermal ${ }_{90}$ parameters. H atoms were finally included in their calculated positions. Except N -linked hydrogen that was introduced in the structural model through Fourier difference maps analysis, H atoms were finally included in their calculated positions. Molecular diagrams were generated by ORTEP-3 (version $\left.{ }_{95} 1.08\right) .{ }^{24}$

## Computational methods

DFT calculations were carried out using the B3LYP ${ }^{25}$ 70 exchange-correlation functionals, together with the standard $6-31 G^{*}$ basis set. ${ }^{26}$ This level of theory has been shown suitable to provide enough good performance in the analysis of both geometric and electronic properties in cycloaddition reactions. ${ }^{19 b}$ The optimizations were carried out using the ${ }_{5}$ Berny analytical gradient optimization method. ${ }^{27}$ Free energies were calculated with the standard statistical thermodynamics ${ }^{26}$ at 383.95 K and 1 atm , and were scaled by a factor of 0.96 . Solvent effects, toluene, were considered at the thermodynamic calculations using a self-consistent ${ }_{80}$ reaction field (SCRF) ${ }^{28}$ based on the polarizable continuum model (PCM) of the Tomasi's group. ${ }^{29}$ The electronic structures of stationary points were analyzed by the NBO method. ${ }^{30}$ All calculations were carried out with the Gaussian 03 suite of programs. ${ }^{31}$
${ }_{85}$ The $\omega$ index ${ }^{32}$ is given by the following expression, $\omega=\mu^{2} /(2 \eta)$, in terms of the electronic chemical potential $\mu$ and the chemical hardness $\eta \cdot{ }^{33}$ Both quantities may be approached in terms of the HOMO and LUMO energies as $\mu \approx\left(\varepsilon_{\mathrm{H}}+\varepsilon_{\mathrm{L}}\right) / 2$ and $\eta \approx\left(\varepsilon_{\mathrm{L}}-\varepsilon_{\mathrm{H}}\right) .{ }^{33}$ Fukui functions ${ }^{34}$ condensed to atoms have ${ }^{0}$ been evaluated from single point calculations performed at the ground state of molecules at the same level of theory, using a method described elsewhere. ${ }^{35}$
