# An oriented version of the 1-2-3 Conjecture

#### Abstract

The well-known 1-2-3 Conjecture addressed by Karoński, Łuczak and Thomason asks whether the edges of every undirected graph $G$ with no isolated edge can be assigned weights from $\{1,2,3\}$ so that the sum of incident weights at each vertex yields a proper vertex-colouring of $G$. In this work, we consider a similar problem for oriented graphs. We show that the arcs of every oriented graph $\vec{G}$ can be assigned weights from $\{1,2,3\}$ so that every two adjacent vertices of $\vec{G}$ receive distinct sums of outgoing (or ingoing) weights. This result is tight in the sense that some oriented graphs do not admit such an assignment using the weights from $\{1,2\}$ only. We finally prove that deciding whether two weights are sufficient for a given oriented graph is an NPcomplete problem. These results also hold for a product version of the problem.


Keywords: oriented graph, neighbour-sum-distinguishing arc-weighting, complexity, 1-2-3 Conjecture

## 1 Introduction

Let $G$ be an undirected graph with vertex and edge sets $V(G)$ and $E(G)$, respectively. For every vertex $v$ of $G$, we denote by $N(v)$ the set of vertices neighbouring $v$. A $k$-edge-weighting $w$ of $G$ is an assignment $w: E(G) \rightarrow$ $\{1,2, \ldots, k\}$. From $w$, one naturally deduces a vertex-colouring $\phi_{w}$ of $G$, where $\phi_{w}(v)=\sum_{u \in N(v)} w(v u)$ for every vertex $v$. In other words, the vertex $v$ receives the sum of its incident weights by $w$ as its "colour". If $\phi_{w}$ is proper, i.e. we have $\phi_{w}(u) \neq \phi_{w}(v)$ for every two adjacent vertices $u$ and $v$ of $G$, then we say that $w$ is neighbour-sum-distinguishing (nsd for short).

The study of neighbour-sum-distinguishing edge-weighting of graphs was initiated in 2004, with Karonski, Łuczak and Thomason posing the following conjecture.

1-2-3 Conjecture [8]. Every graph with no isolated edge admits a nsd-3-edge-weighting.

Despite many efforts to tackle it, the 1-2-3 Conjecture is still an open question. The best result towards the 1-2-3 Conjecture at the moment is due to Kalkowski, Karoński and Pfender, who proved that every graph with no isolated edge admits a nsd-5-edge-weighting [7].

Many edge-weighting problems inspired by the 1-2-3 Conjecture have been introduced in the literature. As examples, let us mention the notions of detectable colouring [1] or locally irregular edge-colouring [3] of graphs. We refer the interested reader to [11], where numerous more variants of the original problem are surveyed. Most of these works are devoted to undirected graphs, but one could wonder about an oriented version of the 1-2-3 Conjecture.

We first introduce some terminology related to oriented graphs. Let $\vec{G}$ be an oriented graph, i.e. a loopless directed graph whose every two vertices are joined by at most one arc in either direction, with vertex and arc sets $V(\vec{G})$ and $A(\vec{G})$, respectively. Given a vertex $v$ of $\vec{G}$, we denote by $N^{-}(v)$ (resp. $N^{+}(v)$ ) the set $\{u \in V(\vec{G}): \overrightarrow{u v} \in A(\vec{G})\}$ (resp. $\left.\{u \in V(\vec{G}): \overrightarrow{v u} \in A(\vec{G})\}\right)$. The indegree (resp. outdegree) of $v$, denoted $d^{-}(v)$ (resp. $d^{+}(v)$ ), is $\left|N^{-}(v)\right|$ (resp. $\left.\left|N^{+}(v)\right|\right)$.

To our knowledge, the only link between the 1-2-3 Conjecture and oriented graphs is the following problem. Let $w$ be a $k$-arc-weighting of $\vec{G}$, and let $q_{w}^{-}(v)$ and $q_{w}^{+}(v)$ be $\sum_{u \in N^{-}(v)} w(\overrightarrow{u v})$ and $\sum_{u \in N^{+}(v)} w(\overrightarrow{v u})$, respectively, for every vertex $v$. The functions $q_{w}^{-}$and $q_{w}^{+}$naturally yield a vertexcolouring $q_{w}$ of $\vec{G}$, where $q_{w}(v)=q_{w}^{+}(v)-q_{w}^{-}(v)$ for every vertex $v$ of $\vec{G}$. It was proved in [4] that every oriented graph admits a 2 -arc-weighting $w$ which yields a proper vertex-colouring $q_{w}$. A list version of the same result was also proved independently in [2] and [9] using different methods.

We here investigate another problem. As for the undirected case, a $k$ -arc-weighting $w$ of $\vec{G}$ yields a vertex-colouring $\phi_{w}$ of $\vec{G}$ where $\phi_{w}(v)=$ $\sum_{u \in N(v)+} w(\overrightarrow{v u})$. This time, the "colour" of $v$ by $\phi_{w}$, sometimes called its weighted outdegree ( with respect to $w$ ), is the sum of its outgoing weights ${ }^{1}$. Again, if $\phi_{w}$ has the property to be proper, then we say that $w$ is neighbour-sum-distinguishing (nsd for short).

A quick investigation on small oriented graphs suggests that all oriented graphs should admit a nsd-3-arc-weighting. Besides, there exist oriented graphs, such as the circuit on 3 vertices, which do not admit a nsd-2-arcweighting. We hence investigate the following question.

[^0]Question 1. Does every oriented graph admit a nsd-3-arc-weighting?

Although Question 1 and the 1-2-3 Conjecture are quite similar in essence, the two underlying problems do not seem to share any systematic relationship. The fact that weighting some arc $\overrightarrow{u v}$ only affects the weighted outdegree of $u$ makes Question 1 easier to handle. We hence answer this question in the affirmative in Section 2. We then turn our concern on conditions for some specific classes of oriented graphs to admit a nsd-2-arc-weighting in Section 3. We next prove, in Section 4, that an "easy" characterization of oriented graphs which admit a nsd-2-arc-weighting cannot exist unless $\mathrm{P}=\mathrm{NP}$. For this purpose, we show that the problem of deciding whether an oriented graph admits a nsd-2-arc-weighting is NP-complete. Concluding remarks can be found in Section 5. In particular, we discuss a product version of our weighting problem.

## 2 All oriented graphs admit a nsd-3-arc-weighting

Our main result states that every oriented graph admits a nsd-3-arc-weighting. This relies on the fact that every oriented graph contains a "convenient" vertex, i.e. a vertex which admits a large number of potential weighted outdegrees regarding its number of neighbours. The existence of such a vertex allows the use of an inductive proof scheme. Our proof also yields a polynomial-time algorithm for finding a nsd-3-arc-weighting of every oriented graph.

Theorem 1. Every oriented graph $\vec{G}$ admits a nsd-3-arc-weighting.

Proof. Note that it is enough to consider connected oriented graphs only. The claim is proved by induction on the size of $\vec{G}$, i.e. its number of arcs. The claim is clearly true when $\vec{G}$ has size 1 . Suppose now that the claim is true for every oriented graph with at most $m-1$ arcs, and assume $\vec{G}$ has size $m$.

Note that $\vec{G}$ necessarily has a vertex $v$ such that $d^{+}(v)>0$ and $d^{+}(v) \geq$ $d^{-}(v)$ since otherwise we would have $\sum_{v \in V(\vec{G})} d^{-}(v) \neq \sum_{v \in V(\vec{G})} d^{+}(v)$. A nsd-3-arc-weighting of $\vec{G}$ is then obtained as follows. Start by removing the arcs outgoing from $v$. According to the induction hypothesis, the remaining oriented graph admits a nsd-3-arc-weighting $w$ (if this oriented graph is not connected, then $w$ is an arc-weighting of all the resulting components). Now put back the arcs outgoing from $v$ to $\vec{G}$, and extend $w$ to these arcs in such a way that the weighted outdegree of $v$ is different from the weighted outdegrees of the $d^{-}(v)+d^{+}(v)$ vertices neighbouring $v$. This is possible since there are $2 d^{+}(v)+1$ potential weighted outdegrees for $v$, namely those
from $\left\{d^{+}(v), d^{+}(v)+1, \ldots, 3 d^{+}(v)\right\}$, while the number of forbidden weighted outdegrees is at most $d^{-}(v)+d^{+}(v)<2 d^{+}(v)+1$ by the assumption on $d^{-}(v)$ and $d^{+}(v)$. Because assigning a weight to the arcs outgoing from $v$ does not affect the weighted outdegree by $w$ of any vertex neighbouring $v$, the extension of $w$ to $\vec{G}$ remains neighbour-sum-distinguishing.

## 3 Some families of oriented graphs which admit a nsd-2-arc-weighting

By Theorem 1, we know that every oriented graph admits a nsd-3-arcweighting. Throughout this section, we focus on some oriented graphs which admits a nsd-2-arc-weighting. In particular, we exhibit conditions regarding some common families of oriented graphs.

### 3.1 Acyclic oriented graphs

An oriented graph is acyclic if it does not admit a circuit as an induced subgraph. We show that every such oriented graph admits a nsd-2-arcweighting.

Theorem 2. Every acyclic oriented graph admits a nsd-2-arc-weighting.
Proof. We prove the claim by induction on the order, i.e. the number of vertices, of acyclic oriented graphs. Once again, it is enough to consider connected oriented graphs. As a starting point, note that an oriented graph with only 1 vertex admits a nsd-2-arc-weighting. Suppose now that the claim is true for every acyclic oriented graph with order at most $n-1$ for some $n$, and let $\vec{G}$ be an acyclic oriented graph on $n$ vertices.

It is well-known that every acyclic oriented graph has a vertex with indegree 0 . Let $v$ be such a vertex of $\vec{G}$, and consider the graph $\overrightarrow{G^{\prime}}$ obtained by removing $v$ from $\vec{G}$. Clearly $\overrightarrow{G^{\prime}}$ is acyclic and admits a nsd-2-arc-weighting $w$ according to the induction hypothesis. We now extend $w$ to $\vec{G}$, i.e. we weight the arcs outgoing from $v$ in such a way that $w$ remains neighbour-sum-distinguishing. Note that there are $d^{+}(v)+1$ possible weighted outdegrees for $v$, namely those from $\left\{d^{+}(v), d^{+}(v)+1, \ldots, 2 d^{+}(v)\right\}$, while there are at most $d^{+}(v)$ forbidden weighted outdegrees for $v$, namely the weighted outdegrees by $w$ of the vertices in $N^{+}(v)$. Since weighting the arcs outgoing from $v$ does not alter the weighted outdegree of any vertex neighbouring $v$, we can "choose" an available weighted outdegree for $v$ and weight the arcs outgoing from $v$ consequently. This completes the proof.

### 3.2 Oriented graphs whose underlying graph is $k$-colourable

Given an undirected graph $G$, a $k$-vertex-colouring of $G$ is a partition of $V(G)$ into $k$ parts $V_{1}, \ldots, V_{k}$ such that each $V_{i}$ is an independent set. The least number of parts of a vertex-colouring of $G$ is referred to as the chromatic number of $G$, denoted $\chi(G)$. Assuming $\vec{G}$ is any orientation of $G$, i.e. $\vec{G}$ is obtained by orienting every edge of $G$ in either direction, it should be understood that und $(\vec{G})$ refers to the underlying undirected graph of $\vec{G}$, that is $G$.

As pointed out in some references of the literature (see e.g. [1] or [8]), first partitioning a graph into several independent sets before weighting its edges can be a good method for finding a specific edge-weighting. This is also the case regarding neighbour-sum-distinguishing arc-weighting, as shown in the following result.

Theorem 3. Every oriented graph $\vec{G}$ admits a nsd- $\chi($ und $(\vec{G}))$-arc-weighting.
Proof. Let $k=\chi(\operatorname{und}(\vec{G}))$, and $V_{0}, \ldots, V_{k-1}$ be a $k$-vertex-colouring of $\operatorname{und}(\vec{G})$. Process the vertices of $\vec{G}$ in arbitrary order. If the vertex $v$ belongs to the part $V_{i}$, then weight the arcs outgoing from $v$ with weights from $\{1,2, \ldots, k\}$ in such a way that the weighted outdegree of $v$ is congruent to $i$ modulo $k$. This is possible unless $d^{+}(v)=0$ since, in such a situation, the only possible weighted outdegree for $v$ is 0 . Once the process is achieved, two adjacent vertices $u$ and $v$ cannot have the same weighted outdegrees since otherwise either $u$ and $v$ would both belong to some $V_{i}$, which is impossible since $V_{i}$ is an independent set, or we would have $d^{+}(u)=d^{+}(v)=0$ with $u$ and $v$ being adjacent, which is impossible.

As a corollary of Theorem 3, we get in particular the following result.
Corollary 4. Every oriented graph $\vec{G}$ whose underlying graph is bipartite admits a nsd-2-arc-weighting.

### 3.3 Tournaments

Our strategy for weighting the arcs of any tournament $\vec{T}$ is based on the following lemma, which could be also deduced thanks to a result of Landau (see [10]).

Lemma 5. For every $k \in\{1,2, \ldots,|V(\vec{T})|\}$, let $n_{k} \geq 0$ denote the number of vertices with outdegree at most $k$ of any tournament $\vec{T}$. Then $n_{k} \leq 2 k+1$.

Proof. Let $k$ be fixed, with $1 \leq k \leq|V(\vec{T})|$. Denote by $X \subseteq V(\vec{T})$ the set of the $n_{k}$ vertices of $\vec{T}$ whose outdegree is at most $k$, and by $s$ the sum
of outdegrees of the vertices in $X$. Naturally, we have $s \leq n_{k} k$. We also have $s \geq \frac{n_{k}\left(n_{k}-1\right)}{2}$ since $X$ induces a tournament, and there may be arcs of $\vec{T}$ whose tails lie in $X$, and whose heads do not lie in $X$. We hence get $\frac{n_{k}\left(n_{k}-1\right)}{2} \leq n_{k} k$, which implies that $n_{k} \leq 2 k+1$.

We now give a characterization of tournaments which admit a nsd-2-arcweighting.

Theorem 6. For every $k \in\{1,2, \ldots,|V(\vec{T})|\}$, let $n_{k} \geq 0$ denote the number of vertices with outdegree at most $k$ of any tournament $\vec{T}$. Then $\vec{T}$ admits a $n s d$-2-arc-weighting if and only if $n_{k} \leq k+1$ for every $k \in\{1,2, \ldots,|V(\vec{T})|\}$.

Proof. The proof is based on the following simple weighting scheme for $\vec{T}$. Process the vertices of $\vec{T}$ in increasing order of their outdegrees. For each vertex $v$, weight the arcs outgoing from $v$ in such a way that the weighted outdegree of $v$ gets the smallest possible value which does not appear among the weighted outdegrees of the neighbours of $v$ considered in earlier steps of the process. Assume $k=d^{+}(v)$. Since the weighted outdegree of $v$ can take any value from $\{k, k+1, \ldots, 2 k\}$ and at most $n_{k}-1<k+1$ vertices have been considered in earlier steps of the process, there is necessarily one non-conflicting value which can be chosen as the weighted outdegree of $v$. We then just have to weight the arcs outgoing from $v$ consequently.

The "only if" condition of the statement follows from the fact that if we have $n_{k} \in\{k+2, k+3, \ldots, 2 k+1\}$ for some value of $k$ (the upper bound on $n_{k}$ follows from Lemma 5), then we need to increase the range of possible values as the weighted outdegree of $v$, i.e. to allow the use of a third weight.

### 3.4 Cartesian products of oriented graphs

Let $\vec{G}$ and $\vec{H}$ be two oriented graphs. The Cartesian product of $\vec{G}$ and $\vec{H}$, denoted $\vec{G} \square \vec{H}$, is the oriented graph with vertex set $V(\vec{G}) \times V(\vec{H})$, and whose two vertices $\left(u_{1}, v_{1}\right)$ and $\left(u_{2}, v_{2}\right)$ are joined by an arc from $\left(u_{1}, v_{1}\right)$ towards $\left(u_{2}, v_{2}\right)$ if and only if $u_{1}=u_{2}$ and $\overrightarrow{v_{1} v_{2}} \in E(\vec{H})$, or $\overrightarrow{u_{1} u_{2}} \in E(\vec{G})$ and $v_{1}=v_{2}$.

The Cartesian product of graphs is a classical graph operation which has been studied a lot since its introduction [6]. The reason for focusing on the Cartesian product of oriented graphs is that if $\vec{G}$ and $\vec{H}$ both admit a nsd- $k$ -arc-weighting for some value of $k$, one could expect $\vec{G} \square \vec{H}$ to require more than $k$ weights to obtain a neighbour-sum-distinguishing arc-weighting. In the next result, we show that the existence of a nsd- $k$-arc-weighting of $\vec{G}$ and $\vec{H}$ implies the existence of a nsd- $k$-arc-weighting of $\vec{G} \square \vec{H}$.

Theorem 7. Assume $\vec{G}$ and $\vec{H}$ admit a nsd-k-and nsd- $\ell$-arc-weighting, respectively. Then $\vec{G} \square \vec{H}$ admits a nsd-max $\{k, \ell\}$-arc-weighting.

Proof. Let $w_{\vec{G}}$ and $w_{\vec{H}}$ be nsd- $k$ - and nsd- $\ell$-arc-weighting of $\vec{G}$ and $\vec{H}$, respectively. Let $w$ be a $\max \{k, \ell\}$-arc-weighting of $\vec{G} \square \vec{H}$ defined as follows:

$$
w\left(\overrightarrow{\left(u_{1}, v_{1}\right)\left(u_{2}, v_{2}\right)}\right)= \begin{cases}w_{\vec{H}}\left(\overrightarrow{v_{1} v_{2}}\right) & \text { if } u_{1}=u_{2}, \\ w_{\vec{G}}\left(\overrightarrow{u_{1} u_{2}}\right) & \text { otherwise. }\end{cases}
$$

Assume $\overrightarrow{\left(u_{1}, v_{1}\right)\left(u_{2}, v_{2}\right)}$ is an arc of $\vec{G} \square \vec{H}$. Then we have $\phi_{w}\left(u_{1}, v_{1}\right)=$ $\phi_{w_{\vec{G}}}\left(u_{1}\right)+\phi_{w_{\vec{H}}}\left(v_{1}\right)$ and $\phi_{w}\left(u_{2}, v_{2}\right)=\phi_{w_{\vec{G}}}\left(u_{2}\right)+\phi_{w_{\vec{H}}}\left(v_{2}\right)$. Since $\left(u_{1}, v_{1}\right)$ and ( $u_{2}, v_{2}$ ) are adjacent, we have either $u_{1}=v_{1}$ or $u_{2}=v_{2}$ by construction. Assume $u_{1}=v_{1}$ without loss of generality. Then $\phi_{w_{\vec{G}}}\left(u_{1}\right)=\phi_{w_{\vec{G}}}\left(v_{1}\right)$. Now, because $w_{\vec{H}}$ is neighbour-sum-distinguishing, we have $\phi_{w_{\vec{H}}}\left(u_{2}\right) \neq \phi_{w_{\vec{H}}}\left(v_{2}\right)$. It then follows that $\phi_{w}\left(u_{1}, v_{1}\right) \neq \phi_{w}\left(u_{2}, v_{2}\right)$.

An immediate corollary of Theorem 7 is the following result.
Corollary 8. Assume $\vec{G}$ and $\vec{H}$ both admit a nsd-2-arc-weighting. Then $\vec{G} \square \vec{H}$ admits a nsd-2-arc-weighting.

## 4 Algorithmic complexity

In this section, we focus on the complexity of the following decision problem. NEIGHBOUR-SUM-DISTINGUISHING $k$-ARC-WEIGHTING - $k$-NSDAW
Instance: An oriented graph $\vec{G}$.
Question: Does $\vec{G}$ admits a nsd- $k$-arc-weighting?
An oriented graph $\vec{G}$ admits a nsd-1-arc-weighting if and only if every two adjacent vertices of $\vec{G}$ have distinct outdegrees. Since this property can be checked in polynomial time, the problem 1-nsDAW is in P. Besides, every problem $k$-nsDAW with $k \geq 3$ is also in P since the answer to every of its instances is yes, according to Theorem 1 .

We deal with the complexity of the remaining problem, i.e. 2-NSDAW. We show this problem to be NP-complete in Theorem 11 below, by reduction from 3-sat. For this purpose, we first introduce several gadgets to "force" the propagation of a nsd-2-arc-weighting along an oriented graph.

We first introduce two kinds of forbidding gadgets. A forbidding gadget $\vec{F}$ is composed of one root vertex with outdegree 0 adjacent to forcing vertices. The weighting property of $\vec{F}$ is that its forcing vertices have the same weighted outdegree, say $x_{1}, x_{2}, \ldots, x_{k}$, by every nsd-2-arc-weighting of

$\vec{F}$. Because of this property, note that, after having identified the root of $\vec{F}$ with a vertex $v$ of some graph $\vec{G}$, the vertex $v$ cannot have weighted outdegree $x_{1}, x_{2}, \ldots, x_{k}$ by any nsd-2-arc-weighting of $\vec{G}$ because of the forcing vertices of $\vec{F}$ neighbouring $v$.

First, we define a $(2 k-1,2 k)$-forbidding gadget, denoted $\overrightarrow{F_{2 k-1,2 k}}$, for every integer $k \geq 2$. These gadgets are defined inductively. First, the gadget $\overrightarrow{F_{3,4}}$ is the one depicted in Figure 1. We call $v_{3}$ the root of $\overrightarrow{F_{3,4}}$, while $v_{1}$ and $v_{2}$ are its forcing vertices. Now, for any value of $k \geq 3$ such that the oriented graphs $\overrightarrow{F_{2 k^{\prime}-1,2 k^{\prime}}}$ have been defined for every $k^{\prime}<k$, the oriented graph $\vec{F}=\overrightarrow{F_{2 k-1,2 k}}$ is constructed as follows. Let $v_{1}^{k}, v_{2}^{k}$ and $v_{3}^{k}$ be three distinct vertices joined by $\overrightarrow{v_{1}^{k} v_{3}^{k}}, \overrightarrow{v_{2}^{k} v_{3}^{k}}$ and $\overrightarrow{v_{1}^{k} v_{2}^{k}}$. Now, for every $k^{\prime} \in\{2,3, \ldots, k-1\}$, identify $v_{1}^{k}$ and the root of a copy of $\overrightarrow{F_{2 k^{\prime}-1,2 k^{\prime}}}$. Repeat the same procedure but with $v_{2}^{k}$ instead of $v_{1}^{k}$ and new copies of the forbidding gadgets. Finally add an arc from $v_{1}^{k}$ towards $k-2$ new vertices with outdegree 0 , and similarly from $v_{2}^{k}$ towards $k-1$ new vertices with outdegree 0 . The root of $\vec{F}$ is $v_{3}^{k}$, while its forcing vertices are $v_{1}^{k}$ and $v_{2}^{k}$.

Lemma 9. Let $k \geq 2$ be fixed. In every nsd-2-arc-weighting of $\overrightarrow{F_{2 k-1,2 k}}$, one of the forcing vertices has weighted outdegree $2 k-1$, while the other forcing vertex has weighted outdegree $2 k$.

Proof. We prove the claim by induction on $k$. At each step, let $w$ be a nsd-2-arc-weighting of the considered forbidding gadget. Start with $\vec{F}=\overrightarrow{F_{3,4}}$. Since $u_{1}$ and $u_{2}$ are adjacent and both have outdegree 1, we have $\left\{\phi_{w}\left(u_{1}\right)\right.$, $\left.\phi_{w}\left(u_{2}\right)\right\}=\{1,2\}$. By the same argument, we have $\left\{\phi_{w}\left(u_{4}\right), \phi_{w}\left(u_{5}\right)\right\}=$ $\{1,2\}$. Since $u_{3}$ and $u_{6}$ are adjacent, are both adjacent to vertices with weighted outdegree 2 , and have outdegree 2 , we necessarily have $\left\{\phi_{w}\left(u_{3}\right)\right.$, $\left.\phi_{w}\left(u_{6}\right)\right\}=\{3,4\}$. Because $u_{7}$ is adjacent to $u_{3}$ and $u_{6}$ and has outdegree 2 , we necessarily get $\phi_{w}\left(u_{7}\right)=2$. Repeating the same arguments to the oriented subgraph of $\vec{F}$ induced by the $u_{i}^{\prime}$ 's, we also obtain $\phi_{w}\left(u_{7}^{\prime}\right)=2$. Finally, since $v_{1}$ and $v_{2}$ are adjacent, are both adjacent to a vertex with weighted

outdegree 2, and have outdegree 2, we have $\left\{\phi_{w}\left(v_{1}\right), \phi_{w}\left(v_{2}\right)\right\}=\{3,4\}$ as claimed.
 Let $\vec{F}=\overrightarrow{F_{2 k-1,2 k}}$. Because $v_{1}^{k}$ and $v_{2}^{k}$ have outdegree $k$ by construction, their weighted outdegree by $w$ can only take value from $\{k, k+1, \ldots, 2 k\}$. However, since these two vertices are both identified with the roots of forbidding gadgets $\overrightarrow{F_{3,4}}, \overrightarrow{F_{5,6}}, \ldots, \overrightarrow{F_{2 k-3,2 k-2}}$, their weighted outdegree cannot take value from $\{3,4, \ldots, 2 k-3,2 k-2\}$ according to the induction hypothesis. Therefore, we have $\left\{\phi_{w}\left(v_{1}^{k}\right), \phi_{w}\left(v_{2}^{k}\right)\right\}=\{2 k-1,2 k\}$ since $v_{1}^{k}$ and $v_{2}^{k}$ are adjacent.

We now define a $k$-forbidding gadget, denoted $\overrightarrow{F_{k}}$, for every integer $k \geq 3$. The oriented graph $\overrightarrow{F_{k}}$ originally consists in an arc $\overrightarrow{v_{1}^{k} v_{2}^{k}}$. We call $v_{2}^{k}$ and $v_{1}^{k}$ the root and the forcing vertex of $\vec{F}$, respectively. Next add an arc from $v_{1}^{k}$ towards $k-1$ new vertices with outdegree 0 . The end of the construction depends on the parity of $k$. If $k$ is even, then identify $v_{1}^{k}$ and the root of each of the forbidding gadgets $\overrightarrow{F_{k+1, k+2}}, \overrightarrow{F_{k+3, k+4}}, \ldots, \overrightarrow{F_{2 k-1,2 k}}$. $\xrightarrow{\text { Otherwise, i.e. if } k \text { is odd, then identify } v_{1}^{k} \text { and the roots of } \overrightarrow{F_{k+1}} \text {, and }}$ $\overrightarrow{F_{k+2, k+3}}, \overrightarrow{F_{k+4, k+5}}, \ldots, \overrightarrow{F_{2 k-1,2 k}}$. The gadgets $\overrightarrow{F_{3}}$ and $\overrightarrow{F_{4}}$ are depicted in Figure 2 .
Lemma 10. Let $k \geq 3$ be fixed. In every nsd-2-arc-weighting of $\overrightarrow{F_{k}}$, the forcing vertex has weighted outdegree $k$.

Proof. Let $w$ be a nsd-2-arc-weighting of $\vec{F}=\overrightarrow{F_{k}}$. Assume $k$ is even. Since $v_{1}^{k}$ has outdegree $k$, its weighted outdegree by $w$ can only take value
$\xrightarrow{\text { from }\{k, k+1, \ldots, 2 k\}}$. But, because $v_{1}^{k}$ is the root of forbidding gadgets $\overrightarrow{F_{k+1, k+2}}, \overrightarrow{F_{k+3, k+4}}, \ldots, \overrightarrow{F_{2 k-1,2 k}}$, the vertex $v_{1}^{k}$ is adjacent to vertices with weighted outdegrees $k+1, k+2, \ldots, 2 k$ according to Lemma 9. Hence, the only remaining weighted outdegree for $v_{1}^{k}$ by $w$ is $k$. The claim follows similarly when $k$ is odd, the value $k+1$ being forbidden as the weighted outdegree of $v_{1}^{k}$ because it was identified with the root of a forbidding gadget $\overrightarrow{F_{k+1}}$ with $k+1$ being even.

Thanks to the two kinds of forbidding gadgets introduced above, we can "force" a vertex of some oriented graph to have a specific weighted outdegree by any nsd-2-arc-weighting. Let $v$ be a vertex of some oriented graph $\vec{G}$, and $D \subseteq\left\{d^{+}(v), d^{+}(v)+1, \ldots, 2 d^{+}(v)\right\}$ be a set of "allowed" weighted outdegrees for $v$. We say that $v$ is a $D$-vertex if its weighted outdegree by every nsd-2-arc-weighting of $\vec{G}$ can only take value among $D$.

By "turning $v$ into a D-vertex", we refer to the following operations. Let $k \geq 1$ be fixed, and assume $d^{+}(v) \leq k$. First add arcs from $v$ towards $k-d^{+}(v)$ new vertices with outdegree 0 so that $v$ has outdegree $k$. Then, identify $v$ and the respective root of each of the forbidding gadgets $\vec{F}_{i}$ with $i \in\left\{d^{+}(v), d^{+}(v)+1, \ldots, 2 d^{+}(v)\right\}-D$. Because of the forcing vertices neighbouring $v$, it is easy to check that $v$ is a $D$-vertex.

We are now ready to introduce our hardness reduction.
Theorem 11. The problem 2-NSDAW is NP-complete.
Proof. Given a 2-arc-weighting $w$ of $\vec{G}$, one can first compute the vertexcolouring $\phi_{w}$ of $\vec{G}$ from $w$, and then check whether it is proper. Since this procedure can be achieved in polynomial time, 2-NSDAW is in NP.

We now prove that 2 -NSDAW is NP-hard by reduction from the following classical NP-complete problem [5].

## 3-SAT

Instance: A 3CNF formula $F$ over clauses $C_{1}, \ldots, C_{m}$ and variables $x_{1}, \ldots, x_{n}$. Question: Does $F$ admit a satisfying truth assignment?

Note that we can assume that every possible literal appears in $F$. Indeed, if $\ell_{i}$ does not appear in any clause of $F$, then the 3CNF formula $F \wedge\left(\ell_{i} \vee \ell_{i} \vee \overline{\ell_{i}}\right)$ is satisfiable if and only if $F$ is satisfiable. By repeating this procedure for all literals which do not appear in $F$, we obtain a formula equivalent to $F$ but involving all possible literals over its variables. This procedure is achieved in polynomial time.

We introduce some more terminology regarding an instance of 3-SAT. The $2 n$ literals of $F$ over its $n$ variables are denoted by $\ell_{1}, \ell_{2}, \ldots, \ell_{2 n}$, the ordering being arbitrary. By $n_{i} \geq 1$, we refer to the number of distinct clauses

of $F$ that contain the literal $\ell_{i}$ for every $i \in\{1,2, \ldots, 2 n\}$. By $c_{i} \in\{1,2,3\}$, we denote the number of distinct literals which appear in the clause $C_{i}$ for every $i \in\{1,2, \ldots, m\}$. In the case where $c_{j}=1$, i.e. $C_{j}$ is of the form ( $\ell_{i} \vee \ell_{i} \vee \ell_{i}$ ), note that $\ell_{i}$ is set to true by every satisfying truth assignment of $F$. In such a situation, we say that $\ell_{i}$ is forced to true by $C_{j}$.

Our hardness reduction is described below. From a 3CNF formula $F$, we construct an oriented graph $\overrightarrow{G_{F}}$ such that $F$ is satisfiable if and only if $\overrightarrow{G_{F}}$ admits a nsd-2-arc-weighting $w_{F}$.

Let $t$ and $f$ be two injective mappings from $\left\{x_{1}, x_{2}, \ldots, x_{n}\right\}$ to $\{2 n, 2 n+$ $1, \ldots, 3 n-1\}$ and $\{3 n, 3 n+1, \ldots, 4 n\}$, respectively. Assuming $\ell_{j}=x_{i}$ and $\ell_{j^{\prime}}=\overline{\ell_{j}}$, i.e. $\ell_{j}$ and $\ell_{j^{\prime}}$ are the literals associated with the variable $x_{i}$, we set $t\left(\ell_{j}\right)=f\left(\ell_{j^{\prime}}\right)=t\left(x_{i}\right)$ and $f\left(\ell_{j}\right)=t\left(\ell_{j^{\prime}}\right)=f\left(x_{i}\right)$.

First, for every literal $\ell_{i}$ of $F$, add a vertex $v_{i}$ in $\overrightarrow{G_{F}}$. Now consider every clause $C_{j}$ of $F$. We associate a clause gadget in $\overrightarrow{G_{F}}$ with $C_{j}$, its structure depending on the value of $c_{j}$. Denote by $\ell_{j_{1}}, \ell_{j_{2}}, \ldots, \ell_{j_{c_{j}}}$ the distinct literals of $C_{j}$. Let $\overrightarrow{u_{j_{1}}^{j} v_{j_{1}}}, \overrightarrow{u_{j_{2}}^{j} v_{j_{2}}}, \ldots, \overrightarrow{u_{j_{c_{j}}}^{j} v_{j_{c_{j}}}}$ be $c_{j}$ arcs of $\overrightarrow{G_{F}}$, where $u_{j_{1}}^{j}, u_{j_{2}}^{j}, \ldots, u_{j_{c_{j}}}^{j}$ are new vertices. If $c_{j}=1$, i.e. $\ell_{j_{1}}$ is the only literal of $C_{j}$, then turn $u_{j_{1}}^{j}$ into a $\left\{t\left(\ell_{j_{1}}\right)\right\}$-vertex. Otherwise, i.e. $c_{j} \in\{2,3\}$, turn each vertex $u_{j_{i}}^{j}$ into a $\left\{t\left(\ell_{j_{i}}\right), f\left(\ell_{j_{i}}\right)\right\}$-vertex, add a vertex $z_{j}$ to $\overrightarrow{G_{F}}$, add arcs from $z_{j}$ towards $u_{j_{1}}^{j}, u_{j_{2}}^{j}, \ldots, u_{j_{c_{j}}}^{j}$, and turn $z_{j}$ into a $\left\{f\left(\ell_{j_{1}}\right), f\left(\ell_{j_{2}}\right), \ldots, f\left(\ell_{j_{c_{j}}}\right)\right\}$-vertex. This construction is depicted in Figure 3.

Claim 1. Let $C_{j}=\left(\ell_{j_{1}} \vee \ell_{j_{2}} \vee \ell_{j_{3}}\right)$ be a clause of $F$. Then one of $t\left(\ell_{j_{1}}\right)$, $t\left(\ell_{j_{2}}\right)$ and $t\left(\ell_{j_{3}}\right)$ belongs to $\left\{\phi_{w_{F}}\left(u_{j_{1}}^{j}\right), \phi_{w_{F}}\left(u_{j_{2}}^{j}\right), \phi_{w_{F}}\left(u_{j_{3}}^{j}\right)\right\}$.

Proof. The claim is true when $c_{j}=1$ since $u_{j_{1}}^{j}$ is a $\left\{t\left(\ell_{j_{1}}\right)\right\}$-vertex. When $c_{j} \in\{2,3\}$, note that we cannot have $\phi_{w_{F}}\left(u_{j_{1}}^{j}\right)=f\left(\ell_{j_{1}}\right), \phi_{w_{F}}\left(u_{j_{2}}^{j}\right)=f\left(\ell_{j_{2}}\right)$,

$\ldots, \phi_{w_{F}}\left(u_{j_{c_{j}}}^{j}\right)=f\left(\ell_{j_{c_{j}}}\right)$ since $z_{j}$ is a $\left\{f\left(\ell_{j_{1}}\right), f\left(\ell_{j_{2}}\right), \ldots, f\left(\ell_{{c_{c}}}\right)\right\}$-vertex. On the contrary, note that if there is an $i \in\left\{1,2, \ldots, c_{j}\right\}$ such that $\phi_{w_{F}}\left(u_{j_{i}}^{j}\right)=t\left(\ell_{j_{i}}\right)$, then we can weight the arcs outgoing from $z_{j}$ in such a way that the weighted outdegree of $z_{j}$ by $w_{F}$ is $f\left(\ell_{j_{i}}\right)$.

Let $i \in\{1,2, \ldots, 2 n\}$. Note that, so far, the vertex $v_{i}$ has indegree $n_{i}$. Consider $i^{\prime} \in\{1,2, \ldots, 2 n\}$ such that $\ell_{i^{\prime}}=\overline{\ell_{i}}$. To finish the construction of $\overrightarrow{G_{F}}$, add the arc $\overrightarrow{v_{i^{\prime}} v_{i}}$, and turn $v_{i}$ and $v_{i^{\prime}}$ into $\left\{t\left(\ell_{i}\right), f\left(\ell_{i}\right)\right\}$-vertices. This step of the construction is illustrated in Figure 4.
Claim 2. Let $i \in\{1,2, \ldots, 2 n\}$, and $i_{1}, i_{2}, \ldots, i_{n_{i}}$ be the indexes of the distinct clauses of $F$ that contain $\ell_{i}$. Then $\phi_{w_{F}}\left(u_{i}^{i_{1}}\right)=\phi_{w_{F}}\left(u_{i}^{i_{2}}\right)=\ldots=\phi_{w_{F}}\left(u_{i}^{i_{n_{i}}}\right)$.

Proof. Recall that the $u_{i}^{i_{j}}$,s can only have weighted outdegree $t\left(\ell_{i}\right)$ or $f\left(\ell_{i}\right)$ by $w_{F}$. Now note that if one of the $u_{i}^{i_{j}}$,s has weighted outdegree $t\left(\ell_{i}\right)$ by $w_{F}$ while another such vertex has weighted outdegree $f\left(\ell_{i}\right)$, then $w_{F}$ cannot be extended to the arcs outgoing from $v_{i}$ since $v_{i}$ is a $\left\{t\left(\ell_{i}\right), f\left(\ell_{i}\right)\right\}$-vertex. On the contrary, if all the $u_{i}^{i_{j}}$ s neighbouring $v_{i}$ have the same weighted outdegree, say $t\left(\ell_{i}\right)$, then the arcs outgoing from $v_{i}$ can be weighted in such a way that $\phi_{w_{F}}\left(v_{i}\right)=f\left(\ell_{i}\right)$.

Claim 3. Let $i, i^{\prime} \in\{1,2, \ldots, 2 n\}$ be two integers such that $\ell_{i^{\prime}}=\overline{\ell_{i}}$. Then $\phi_{w_{F}}\left(v_{i}\right) \neq \phi_{w_{F}}\left(v_{i^{\prime}}\right)$.

Proof. The claim follows from the fact that $v_{i}$ and $v_{i^{\prime}}$ are adjacent.

We claim that $F$ has a satisfying truth assignment if and only if $\overrightarrow{G_{F}}$ admits its nsd-2-arc-weighting $w_{F}$. Assume $C_{j}=\left(\ell_{j_{1}} \vee \ell_{j_{2}} \vee \ell_{j_{3}}\right)$ is a clause of $F$, and that having $\phi_{w_{F}}\left(u_{j_{i}}^{j}\right)=t\left(\ell_{j_{i}}\right)$ (resp. $\left.f\left(\ell_{j_{i}}\right)\right)$ simulates the assignment of $\ell_{j_{i}}$ to true (resp. false) in $C_{j}$ by a truth assignment of $F$. Then, by Claim 1, every clause gadget of $\overrightarrow{G_{F}}$ must have a vertex $u_{j_{i}}^{j}$ whose weighted outdegree by $w_{F}$ is $t\left(\ell_{j_{i}}\right)$. This simulates the fact that every clause of $F$ must
have one true literal by a satisfying truth assignment of $F$. Claim 2 depicts the fact that, by a truth assignment of $F$, every literal of $F$ provides the similar truth value to every clause it appears in. Finally, Claim 3 represents the fact that two opposite literals cannot be assigned the same truth value by a truth assignment of $F$. With these arguments, we can deduce a satisfying truth assignment of $F$ from $w_{F}$, and vice-versa.

## 5 Discussion

We can extend the problem investigated in this work to undirected graphs.
Question 2. What is the least $k \in\{1,2,3\}$ such that every undirected graph admits an orientation which admits a nsd-k-arc-weighting?

Recall that an oriented graph admits a nsd-1-arc-weighting if and only if every two of its adjacent vertices have distinct outdegrees. According to a result from [4], the answer to Question 2 is 1 . We give an alternative proof of this statement using our terminology.

Lemma 12. Every undirected graph $G$ admits an orientation in which every two adjacent vertices have distinct outdegrees.

Proof. We prove this result by induction on the order $n$ of $G$. Since the result is true for $n=1$, we assume the claim is true for every $n$ up to $i-1$, and now consider $n=i$. Let $v$ be a vertex whose degree is maximum in $G$. According to the induction hypothesis, the graph $G^{\prime}=G-\{v\}$ admits an orientation $\overrightarrow{G^{\prime}}$ in which every two adjacent vertices have distinct outdegrees. Note that in $\overrightarrow{G^{\prime}}$, the outdegree of every vertex in $N(v)$ is at most $d(v)-1$ since $v$ has maximum degree. Now start from $\overrightarrow{G^{\prime}}$, and let $\vec{G}$ be the orientation of $G$ obtained by orienting all edges incident with $v$ from $v$ towards its neighbours. Since the outdegree of $v$ in $\vec{G}$ then is $d(v)$, and the outdegrees of all vertices neighbouring $v$ are not altered, the orientation still satisfies the claim.

Corollary 13. Every undirected graph admits an orientation which admits a nsd-1-arc-weighting.

As for the undirected case, one can consider a variant of the problem investigated in this work where the weighted outdegree of a vertex is the product of its outgoing weights rather than their sum (see e.g. [12]). Formally, from a $k$-arc-weighting $w$ of some oriented graph $\vec{G}$ one obtains a vertex-colouring $\rho_{w}$ defined as $\rho_{w}(v)=\prod_{u \in N^{+}(v)} w(\overrightarrow{v u})$ for every $v \in V(\vec{G})$.

If $\rho_{w}$ is proper, then we say that $w$ is neighbour-product-distinguishing (npd for short).

Regarding npd-arc-weightings, note that the range of possible weighted outdegrees for a vertex is wider in the product version than in the sum version when the weights from $\{1,2,3\}$ are allowed. Hence, our proof of Theorem 1 is also a proof that every oriented graph admits a npd-3-arcweighting.

Note that there are $k+1$ possible weighted outdegrees for a vertex with outdegree $k$ by a npd-2-arc-weighting of some oriented graph, namely those from $\left\{1,2,4, \ldots, 2^{k}\right\}$. Since there are as many possible weighted outdegrees for a vertex by a nsd-2-arc-weighting and a npd-2-arc-weighting, our results from Section 3 also hold regarding npd-2-arc-weightings.

Finally, we could adapt the reduction scheme from Section 4 to prove that it is NP-complete to decide whether a given oriented graph admits a npd-2-arc-weighting. The forbidding gadgets would be obtain, for instance, as follows. Start from the circuit $\overrightarrow{u_{1} u_{2} u_{3} u_{1}}$ on 3 vertices, and add an arc $\overrightarrow{u_{1} u_{4}}$ where $u_{4}$ is a new vertex. This resulting oriented graph $\overrightarrow{F_{4}}$ is a 4forbidding gadget since it is easy to check that $u_{1}$ would necessarily get weighted outdegree 4 by any npd-2-arc-weighting. The root of $\overrightarrow{F_{4}}$ is $u_{4}$. Now consider another oriented graph $\overrightarrow{F_{1,2}}$ with vertices $v_{1}, v_{2}, v_{3}$ and $v_{4}$ such that $\overrightarrow{v_{1} v_{2}}, \overrightarrow{v_{1} v_{3}}, \overrightarrow{v_{2} v_{3}}$ and $\overrightarrow{v_{2} v_{4}}$ are arcs, and $v_{1}$ and $v_{2}$ are each identified with the root of one copy of $\vec{F}_{4}$. Clearly, since $v_{1}$ and $v_{2}$ are adjacent vertices $\underset{\sim}{\text { with outdegree } 2 \text {, and they are both identified with the root of a gadget }}$ $\vec{F}_{4}$, their weighted outdegree can only be 1 and 2 without loss of generality, and $\overrightarrow{F_{1,2}}$ is thus a (1,2)-forbidding gadget with root $v_{3}$. Now to obtain a $2^{k}$-forbidding gadget $\overrightarrow{F_{2^{k}}}$ assuming that a $2^{k^{\prime}}$-forbidding gadget has been defined for every $k^{\prime}<k$ (with the exception that there is a $(1,2)$-forbidding gadget rather than a 1 -forbidding gadget and a 2 -forbidding gadget), start from the arc $\overrightarrow{w_{1} w_{2}}$, then add arcs from $w_{1}$ towards $k-1$ new vertices so that $w_{1}$ has outdegree $k$, and finally identify $w_{1}$ and the roots of all the forbidding gadgets constructed in previous steps. Clearly, $w_{1}$ can only have weighted outdegree $2^{k}$ by every npd-2-arc-weighting of $\overrightarrow{F_{2^{k}}}$. Thus, $\overrightarrow{F_{2^{k}}}$ is a $2^{k}$-forbidding gadget with root $w_{2}$. With these forbidding gadgets, our reduction scheme can then be directly adapted for the product version of the problem.
