# Fractional elliptic equation with gradient nonlinearity and measure data

#### Abstract

In this paper, we study fractional elliptic equation (E1) $(-\Delta)^{\alpha} u+$ $g(|\nabla u|)=\nu$ in a bounded regular domain $\Omega$ of $\mathbb{R}^{N}(N \geq 2)$, satisfying (E2) $u=0$ in $\Omega^{c}$, where $(-\Delta)^{\alpha}$ denotes the fractional Laplacian with $\alpha \in(0,1), \nu$ is a Radon measure and $g: \mathbb{R} \mapsto \mathbb{R}$ is a continuous function satisfying. We prove the existence of weak solutions for problem (E1)(E2) when $\nu$ is Radon measure and $g$ is subcritical. Furthermore, the asymptotic behaviors and uniqueness of solutions are analyzed when $\nu$ is Dirac measure.

## 1 Introduction

Let $\Omega \subset \mathbb{R}^{N}(N \geq 2)$ be an open bounded $C^{2}$ domain and $g: \mathbb{R}_{+} \mapsto \mathbb{R}_{+}$ be a continuous and nondecreasing function. The purpose of this paper is to study the existence of weak solutions to the semilinear fractional elliptic problem

$$
\begin{align*}
(-\Delta)^{\alpha} u+g(|\nabla u|)=\nu & \text { in } \quad \Omega,  \tag{1.1}\\
u=0 & \text { in } \quad \Omega^{\mathrm{c}},
\end{align*}
$$

where $\alpha \in(1 / 2,1)$ and $\nu \in \mathfrak{M}\left(\Omega, \rho^{\beta}\right)$ with $\beta \in[0,2 \alpha-1]$. Here $\rho(x)=$ $\operatorname{dist}\left(x, \Omega^{c}\right)$ and $\mathfrak{M}\left(\Omega, \rho^{\beta}\right)$ denotes the space of Radon measures in $\Omega$ satisfying

$$
\begin{equation*}
\int_{\Omega} \rho^{\beta} d|\nu|<+\infty \tag{1.2}
\end{equation*}
$$

In particular, we denote that $\mathfrak{M}\left(\Omega, \rho^{0}\right)=\mathfrak{M}^{b}(\Omega)$ is the space of bounded Radon measures. The operator $(-\Delta)^{\alpha}$ is the fractional Laplacian defined as

$$
(-\Delta)^{\alpha} u(x)=\lim _{\epsilon \rightarrow 0^{+}}(-\Delta)_{\epsilon}^{\alpha} u(x),
$$

where for $\epsilon>0$,

$$
\begin{equation*}
(-\Delta)_{\epsilon}^{\alpha} u(x)=-\int_{\mathbb{R}^{N}} \frac{u(z)-u(x)}{|z-x|^{N+2 \alpha}} \chi_{\epsilon}(|x-z|) d z \tag{1.3}
\end{equation*}
$$

and

$$
\chi_{\epsilon}(t)=\left\{\begin{array}{lll}
0, & \text { if } & \mathrm{t} \in[0, \epsilon], \\
1, & \text { if } & \mathrm{t}>\epsilon .
\end{array}\right.
$$

In the pioneering work, Brezis [6] studied the existence and uniqueness of the solution to the semilinear Dirichlet elliptic problem

$$
\begin{align*}
-\Delta u+h(u)=\nu & \text { in } \quad \Omega, \\
u=0 & \text { on } \quad \partial \Omega, \tag{1.4}
\end{align*}
$$

where $\nu$ is a bounded measure in $\Omega$ and the function $h$ is nondecreasing, positive on $(0,+\infty)$ and satisfies that

$$
\int_{1}^{+\infty}(h(s)-h(-s)) s^{-2 \frac{N-1}{N-2}} d s<+\infty .
$$

Also see Benilan and Brezis [1]. Later, Véron [27] improved this result in replacing the Laplacian by more general uniformly elliptic second order differential operator, where $\nu \in \mathfrak{M}\left(\Omega, \rho^{\beta}\right)$ with $\beta \in[0,1]$ and $h$ is a nondecreasing function satisfying that

$$
\int_{1}^{+\infty}(h(s)-h(-s)) s^{-2 \frac{N+\beta-1}{N+\beta-2}} d s<+\infty .
$$

The general semilinear elliptic equations involving measures have been intensively studied, such as the equations involving measures boundary data which was initiated by Gmira and Véron [16] and then this subject has being extended in various ways, see $[4,5,18,19,20,21]$ for details. In a recent work, Phuoc and Véron [23] considered the existence of solutions to problem

$$
\begin{align*}
-\Delta u+h(|\nabla u|)=\nu & \text { in } \quad \Omega \\
u=0 & \text { on } \quad \partial \Omega \tag{1.5}
\end{align*}
$$

where $\nu$ is a positive bounded measure in $\Omega, h$ is a continuous nondecreasing function vanishing at 0 and satisfying that

$$
\int_{1}^{+\infty} h(s) s^{-1-\frac{N}{N-1}} d s<+\infty
$$

During the last years there has also been a renewed and increasing interest in the study of linear and nonlinear intro-differential operators, especially, the fractional Laplacian, motivated by great applications and by important advances on the theory of nonlinear partial differential equations, and we mention the references $[7,10,11,12,9,14,24,26,25]$. Recently, Chen and Véron [12] studied semilinear fractional elliptic equation

$$
\begin{align*}
(-\Delta)^{\alpha} u+h(u)=\nu & \text { in } \quad \Omega \\
u=0 & \text { in } \quad \Omega^{\mathrm{c}} \tag{1.6}
\end{align*}
$$

where $\nu \in \mathfrak{M}\left(\Omega, \rho^{\beta}\right)$ with $\beta \in[0, \alpha]$. They proved the existence and uniqueness of the solution to (1.6) when the function $h$ satisfies that

$$
\int_{1}^{+\infty}(h(s)-h(-s)) s^{-1-k_{\alpha, \beta}} d s<+\infty
$$

where

$$
k_{\alpha, \beta}= \begin{cases}\frac{N}{N-2 \alpha}, & \text { if } \quad \beta \in\left[0, \frac{\mathrm{~N}-2 \alpha}{\mathrm{~N}} \alpha\right]  \tag{1.7}\\ \frac{N+\alpha}{N-2 \alpha+\beta}, & \text { if } \beta \in\left(\frac{\mathrm{N}-2 \alpha}{\mathrm{~N}} \alpha, \alpha\right] .\end{cases}
$$

Motivated by these results and in view of the nonlocal character of the fractional Laplaican we are interested in the existence of weak solutions to fractional equation involving gradient term and measure. Before stating our main theorem we make precise the notion of weak solution used in this article.

Definition 1.1 We say that $u$ is a weak solution of (1.1), if $u \in L^{1}(\Omega)$, $g(|\nabla u|) \in L^{1}\left(\Omega, \rho^{\alpha} d x\right)$ and

$$
\begin{equation*}
\int_{\Omega}\left[u(-\Delta)^{\alpha} \xi+g(|\nabla u|) \xi\right] d x=\int_{\Omega} \xi d \nu, \quad \forall \xi \in \mathbb{X}_{\alpha} \tag{1.8}
\end{equation*}
$$

where $\mathbb{X}_{\alpha} \subset C\left(\mathbb{R}^{N}\right)$ is the space of functions $\xi$ satisfying:
(i) $\operatorname{supp}(\xi) \subset \bar{\Omega}$,
(ii) $(-\Delta)^{\alpha} \xi(x)$ exists for all $x \in \Omega$ and $\left|(-\Delta)^{\alpha} \xi(x)\right| \leq C$ for some $C>0$,
(iii) there exist $\varphi \in L^{1}\left(\Omega, \rho^{\alpha} d x\right)$ and $\epsilon_{0}>0$ such that $\left|(-\Delta)_{\epsilon}^{\alpha} \xi\right| \leq \varphi$ a.e. in $\Omega$, for all $\epsilon \in\left(0, \epsilon_{0}\right]$.

In order to state our main result, we introduce $G_{\alpha}$ the Green kernel of $(-\Delta)^{\alpha}$ in $\Omega$ and $\mathbb{G}_{\alpha}[$.$] the Green operator defined as$

$$
\begin{equation*}
\mathbb{G}_{\alpha}[\nu](x)=\int_{\Omega} G_{\alpha}(x, y) d \nu(y), \quad \forall \nu \in \mathfrak{M}\left(\Omega, \rho^{\alpha}\right) \tag{1.9}
\end{equation*}
$$

In section 2 , we obtain some estimates by the properties of $\mathbb{G}_{\alpha}[\nu]$ which play an important role in the analysis of the existence of weak solutions. Now we state the main result when $g$ is a absorption.

Theorem 1.1 Let $\Omega \subset \mathbb{R}^{N}(N \geq 2)$ be an open bounded $C^{2}$ domain, $\alpha \in$ $(1 / 2,1)$ and $p_{\alpha}^{*}=\frac{N}{N-2 \alpha+1}$. Assume that $g: \mathbb{R}_{+} \rightarrow \mathbb{R}_{+}$is a continuous function satisfying

$$
\begin{equation*}
\int_{1}^{+\infty} g(s) s^{-1-p_{\alpha}^{*}} d s<+\infty \tag{1.10}
\end{equation*}
$$

Then for any nonnegative Radon measure $\nu \in \mathfrak{M}\left(\Omega, \rho^{\beta}\right)$ with $\beta \in[0,2 \alpha-$ 1], problem (1.1) admits a nonnegative weak solution $u_{\nu}$ such that

$$
\begin{equation*}
\mathbb{G}_{\alpha}[\nu]-\mathbb{G}_{\alpha}\left[g\left(\left|\nabla \mathbb{G}_{\alpha}[\nu]\right|\right)\right] \leq u_{\nu} \leq \mathbb{G}_{\alpha}[\nu] . \tag{1.11}
\end{equation*}
$$

Remark 1.1 We note that the critical value $p_{\alpha}^{*}$ is independent of $\beta$.
Remark 1.2 We don't know if weak solution of (1.1) is unique. Because we don't find some inequality which plays the role of Kato's inequality to deal with the gradient term $g(|\nabla u|)$.

Another interest is to consider the solution of (1.1) when $g$ is a source, i.e. $g: \mathbb{R}_{-} \rightarrow \mathbb{R}_{-}$is a continuous function. Then we have following result:

Theorem 1.2 Let $\Omega \subset \mathbb{R}^{N}(N \geq 2)$ be an open bounded $C^{2}$ domain, $\alpha \in$ $(1 / 2,1), \nu \in \mathfrak{M}\left(\Omega, \rho^{\beta}\right)$ with $\beta \in[0,2 \alpha-1]$ and $p_{\alpha}^{*}=\frac{N}{N-2 \alpha+1}$. Assume that $g: \mathbb{R}_{+} \rightarrow \mathbb{R}_{-}$is a continuous function such that there exists $p<p_{\alpha}^{*}$

$$
\begin{equation*}
-g(s) \leq c_{1} s^{p}+\sigma_{0} \quad \text { for } \quad s \geq 0 \tag{1.12}
\end{equation*}
$$

for some $c_{1}>0$ and $\sigma_{0}>0$.
If (i) $p \in\left(1, p_{\alpha}^{*}\right), \sigma_{0}$ and $\|\nu\|_{\mathfrak{M}\left(\Omega, \rho^{\beta}\right)}$ small enough; or $\quad$ (ii) $p=1$, $c_{1}$ small enough; or (iii) $p \in(0,1)$, then problem (1.1) admits a weak solution $u_{\nu}$ such that

$$
\begin{equation*}
\mathbb{G}_{\alpha}[\nu] \leq u_{\nu} \leq \mathbb{G}_{\alpha}[\nu]-\mathbb{G}_{\alpha}\left[g\left(\left|\nabla \mathbb{G}_{\alpha}[\nu]\right|\right)\right] . \tag{1.13}
\end{equation*}
$$

We note that Theorem 1.2 deals with for general Radon measure $\nu$, while $\nu$ is nonnegative when $g$ is an absorption.

The paper is organized as follows. In Section 2, we present some preliminaries to obtain the estimate

$$
\left\|\nabla \mathbb{G}_{\alpha}[\nu]\right\|_{M^{p_{\alpha}^{*}}\left(\Omega, \rho^{\alpha}(x) d x\right)} \leq c_{2}\|\nu\|_{\mathfrak{M}\left(\Omega, \rho^{\beta}\right)}, \quad c_{2}>0
$$

and investigate the related classical solution.
Section 3 is devoted to prove the main theorems. In Section 4, we analyze the asymptotic behaviour of weak solutions to (1.1) when $\nu$ is a Dirac mass and $g$ is a power absorption.

## 2 Preliminary

### 2.1 Marcinkiewicz type estimate

In this subsection, we recall some definition and basic properties of Marcinkiewicz spaces.

Definition 2.1 Let $\Omega \subset \mathbb{R}^{N}$ be an open bounded domain and $\mu$ be a positive Borel measure in $\Omega$. For $\kappa>1, \kappa^{\prime}=\kappa /(\kappa-1)$ and $u \in L_{\text {loc }}^{1}(\Omega, d \mu)$, we set $\|u\|_{M^{\kappa}(\Omega, d \mu)}=\inf \left\{c \in[0, \infty]: \int_{E}|u| d \mu \leq c\left(\int_{E} d \mu\right)^{\frac{1}{\kappa^{\prime}}}, \forall E \subset \Omega\right.$ Borel set $\}$
and

$$
\begin{equation*}
M^{\kappa}(\Omega, d \mu)=\left\{u \in L_{l o c}^{1}(\Omega, d \mu):\|u\|_{M^{\kappa}(\Omega, d \mu)}<\infty\right\} \tag{2.1}
\end{equation*}
$$

$M^{\kappa}(\Omega, d \mu)$ is called the Marcinkiewicz space of exponent $\kappa$ or weak $L^{\kappa}$ space and $\|\cdot\|_{M^{\kappa}(\Omega, d \mu)}$ is a quasi-norm. The following property holds.

Proposition 2.1 [2, 8] Assume $1 \leq q<\kappa<\infty$ and $u \in L_{l o c}^{1}(\Omega, d \mu)$. Then there exists $c_{3}(q, \kappa)>0$ such that

$$
\int_{E}|u|^{q} d \mu \leq c_{3}(q, \kappa)\|u\|_{M^{\kappa}(\Omega, d \mu)}\left(\int_{E} d \mu\right)^{1-q / \kappa}
$$

for any Borel set $E$ of $\Omega$.
Proposition 2.2 Let $\Omega \subset \mathbb{R}^{N}(N \geq 2)$ be an open bounded $C^{2}$ domain and $\nu \in \mathfrak{M}\left(\Omega, \rho^{\beta}\right)$ with $\beta \in[0,2 \alpha-1]$. Then

$$
\begin{equation*}
\left\|\nabla \mathbb{G}_{\alpha}[|\nu|]\right\|_{M^{p_{\alpha}^{*}}\left(\Omega, \rho^{\alpha}(x) d x\right)} \leq c_{2}\|\nu\|_{\mathfrak{M}\left(\Omega, \rho^{\beta}\right)} \tag{2.3}
\end{equation*}
$$

where $\nabla \mathbb{G}_{\alpha}[|\nu|](x)=\int_{\Omega} \nabla_{x} G_{\alpha}(x, y) d|\nu|(y)$ and

$$
\begin{equation*}
p_{\alpha}^{*}=\frac{N}{N-2 \alpha+1} \tag{2.4}
\end{equation*}
$$

Proof. For $\lambda>0$ and $y \in \Omega$, we denote

$$
\omega_{\lambda}(y)=\left\{x \in \Omega \backslash\{y\}:\left|\nabla_{x} G_{\alpha}(x, y)\right| \rho^{\alpha}(x)>\lambda \rho^{\beta}(y)\right\}, \quad m_{\lambda}(y)=\int_{\omega_{\lambda}(y)} d x .
$$

From [10], there exists $c_{4}>0$ such that for any $(x, y) \in \Omega \times \Omega$ with $x \neq y$,

$$
\begin{gather*}
G_{\alpha}(x, y) \leq c_{4} \min \left\{\frac{1}{|x-y|^{N-2 \alpha}}, \frac{\rho^{\alpha}(x)}{|x-y|^{N-\alpha}}, \frac{\rho^{\alpha}(y)}{|x-y|^{N-\alpha}}\right\},  \tag{2.5}\\
G_{\alpha}(x, y) \leq c_{4} \frac{\rho^{\alpha}(y)}{\rho^{\alpha}(x)|x-y|^{N-2 \alpha}}, \tag{2.6}
\end{gather*}
$$

and by Corollary 3.3 in [3], we have

$$
\begin{equation*}
\left|\nabla_{x} G_{\alpha}(x, y)\right| \leq N G_{\alpha}(x, y) \max \left\{\frac{1}{|x-y|}, \frac{1}{\rho(x)}\right\}, \tag{2.7}
\end{equation*}
$$

which implies that for some $c_{5}>0$,

$$
\begin{equation*}
\left|\nabla_{x} G_{\alpha}(x, y)\right| \leq \max \left\{\frac{c_{5} \rho^{\alpha}(y)}{\rho^{\alpha}(x)|x-y|^{N-2 \alpha+1}}, \frac{c_{5} \rho^{\alpha-1-s}(x) \rho^{s}(y)}{|x-y|^{N-\alpha}}\right\} \tag{2.8}
\end{equation*}
$$

where $s \in[0,2 \alpha-1]$ will be chosen later.
Therefore, for $2 \alpha-1-s \geq 0$, we have

$$
\begin{aligned}
\left|\nabla_{x} G_{\alpha}(x, y)\right| \rho^{\alpha}(x) & \leq \max \left\{\frac{c_{5} \rho^{\alpha}(y)}{|x-y|^{N-2 \alpha+1}}, \frac{c_{5} \rho^{2 \alpha-1-s}(x) \rho^{s}(y)}{|x-y|^{N-\alpha}}\right\} \\
& \leq \max \left\{\frac{c_{5} \rho^{\alpha}(y)}{|x-y|^{N-2 \alpha+1}}, \frac{c_{5} \rho^{s}(y)}{|x-y|^{N-\alpha}}\right\} .
\end{aligned}
$$

Since $N-2 \alpha+1>N-\alpha$ and $2 \alpha-1-s \geq 0$, then there exists some $c_{6}>0$ such that
$\omega_{\lambda}(y) \subset\left\{x \in \Omega:|x-y| \leq c_{6} \max \left\{\rho^{\frac{\alpha-\beta}{N-2 \alpha+1}}(y) \lambda^{-\frac{1}{N-2 \alpha+1}}, \rho^{\frac{s-\beta}{N-\alpha}}(y) \lambda^{-\frac{1}{N-\alpha}}\right\}\right\}$.
Choosing $s=\beta \in[0,2 \alpha-1]$ and then for $\lambda>1$,

$$
\begin{equation*}
\omega_{\lambda}(y) \subset\left\{x \in \Omega:|x-y| \leq c_{6} \lambda^{-\frac{1}{N-2 \alpha+1}}\right\} . \tag{2.9}
\end{equation*}
$$

As a consequence,

$$
m_{\lambda}(y) \leq c_{7} \lambda^{-p_{\alpha}^{*}},
$$

where $c_{7}>0$ independent of $y$ and $\lambda$.
For any Borel set $E$ of $\Omega$ and $\lambda>1$, we have

$$
\int_{E}\left|\nabla_{x} G_{\alpha}(x, y)\right| \rho^{\alpha}(x) d x \leq \int_{\omega_{\lambda}(y)}\left|\nabla_{x} G_{\alpha}(x, y)\right| \rho^{\alpha}(x) d x+\lambda \rho^{\beta}(y) \int_{E} d x
$$

and

$$
\begin{aligned}
\int_{\omega_{\lambda}(y)}\left|\nabla_{x} G_{\alpha}(x, y)\right| \rho^{\alpha}(x) d x & =-\int_{\lambda \rho^{\beta}(y)}^{\infty} s d m_{s}(y) \\
& =\lambda \rho^{\beta}(y) m_{\lambda}(y)+\int_{\lambda \rho^{\beta}(y)}^{\infty} m_{s}(y) d s \\
& \leq c_{8} \rho^{\beta}(y) \lambda^{1-p_{\alpha}^{*}},
\end{aligned}
$$

for some $c_{8}>0$. Thus,

$$
\int_{E}\left|\nabla_{x} G_{\alpha}(x, y)\right| \rho^{\alpha}(x) d x \leq \rho^{\beta}(y)\left(c_{8} \lambda^{1-p_{\alpha}^{*}}+\lambda \int_{E} d x\right) .
$$

Choosing $\lambda=\left(\int_{E} d x\right)^{-\frac{1}{p_{\alpha}^{x}}}$, we have

$$
\int_{E}\left|\nabla_{x} G_{\alpha}(x, y)\right| \rho^{\alpha}(x) d x \leq c_{8} \rho^{\beta}(y)\left(\int_{E} d x\right)^{\frac{p_{\alpha}^{*}-1}{p_{\alpha}^{*}}}, \quad \forall y \in \Omega .
$$

Therefore,

$$
\begin{aligned}
& \int_{E}\left|\nabla \mathbb{G}_{\alpha}[|\nu|](x)\right| \rho^{\alpha}(x) d x=\int_{\Omega} \int_{E}\left|\nabla_{x} G_{\alpha}(x, y)\right| \rho^{\alpha}(x) d x d|\nu(y)| \\
& \leq \int_{\Omega} \rho^{\beta}(y) d|\nu(y)| \sup _{x \in K} \rho^{-\beta}(y) \int_{E}\left|\nabla_{x} G_{\alpha}(x, y)\right| \rho^{\alpha}(x) d x \\
& \leq c_{8} \int_{\Omega} \rho^{\beta}(y) d|\nu(y)|\left(\int_{E} d x\right)^{\frac{p_{\alpha}^{*}-1}{p_{\alpha}^{*}}} \\
& \leq c_{8}\|\nu\|_{\mathfrak{M}\left(\Omega, \rho^{\beta}\right)}\left(\int_{E} d x\right)^{\frac{p_{\alpha}^{*}-1}{p_{\alpha}^{*}}}
\end{aligned}
$$

As a consequence,

$$
\left\|\nabla \mathbb{G}_{\alpha}[|\nu|]\right\|_{M^{p_{\alpha}^{*}}\left(\Omega, \rho^{\alpha} d x\right)} \leq c_{8}\|\nu\|_{\mathfrak{M}\left(\Omega, \rho^{\beta}\right)} .
$$

We complete the proof.
The next proposition is a higher order regularity result
Proposition 2.3 [12] Assume that $\nu \in \mathfrak{M}\left(\Omega, \rho^{\beta}\right)$ with $0 \leq \beta \leq \alpha$. Then for $q \in\left(1, \frac{N}{N+\beta-2 \alpha}\right)$ there exists $c_{9}>0$ such that for any $\nu \in L^{1}\left(\Omega, \rho^{\beta} d x\right)$

$$
\begin{equation*}
\left\|\mathbb{G}_{\alpha}[\nu]\right\|_{W^{2 \alpha-\gamma, q}(\Omega)} \leq c_{9}\|\nu\|_{L^{1}\left(\Omega, \rho^{\beta} d x\right)} \tag{2.10}
\end{equation*}
$$

where $q^{\prime}=\frac{q}{q-1}, \gamma=\beta+\frac{N}{q^{\prime}}$ if $\beta>0$ and $\gamma>\frac{N}{q^{\prime}}$ if $\beta=0$.
Proposition 2.4 Assume that $\nu \in \mathfrak{M}\left(\Omega, \rho^{\beta}\right)$ with $0 \leq \beta \leq \alpha$, then the mapping $\nu \mapsto\left|\nabla \mathbb{G}_{\alpha}[\nu]\right|$ is compact from $L^{1}\left(\Omega, \rho^{\beta} d x\right)$ into $L^{q}(\Omega)$ for any $q \in\left[1, \frac{N}{N+\beta+1-2 \alpha}\right)$.

Proof. From the previous proposition we see that $\mathbb{G}_{\alpha}[\nu] \in W^{2 \alpha-\gamma, p}(\Omega)$, where $2 \alpha-\gamma>1$ for $p \in\left(1, \frac{N}{N+\beta-2 \alpha}\right)$. Therefore, $\left|\nabla \mathbb{G}_{\alpha}[\nu]\right| \in W^{2 \alpha-\gamma-1, p}(\Omega)$ and

$$
\left\|\nabla \mathbb{G}_{\alpha}[\nu]\right\|_{W^{2 \alpha-\gamma-1, p}(\Omega)} \leq c_{9}\|\nu\|_{L^{1}\left(\Omega, \rho^{\beta} d x\right)}
$$

By [22, Th 6.5$]$, the embedding of $W^{2 \alpha-\gamma-1, p}(\Omega)$ into $L^{q}(\Omega)$ is compact. We complete the proof.

### 2.2 Classical solution

In order to prove our main theorems, we consider the existence of classical solution to problem

$$
\begin{align*}
(-\Delta)^{\alpha} u+g(|\nabla u|)=f & \text { in } \quad \Omega  \tag{2.11}\\
u=0 & \text { in } \quad \Omega^{\mathrm{c}}
\end{align*}
$$

We denote that $g_{+}=\max \{g, 0\}$ and $g_{-}=\max \{-g, 0\}$.
Theorem 2.1 Suppose that $\Omega$ is an open bounded $C^{2}$ domain of $\mathbb{R}^{N}(N \geq$ 2), $\alpha \in(1 / 2,1)$ and the function $g: \mathbb{R} \rightarrow \mathbb{R}$ is bounded. Assume more that there exists $\theta>0$ such that $g \in C^{\theta}(\mathbb{R})$ and $f \in C^{\theta}(\bar{\Omega})$. Then problem (2.11) admits a unique classical solution $u$ such that

$$
\begin{equation*}
\mathbb{G}_{\alpha}[f]-\mathbb{G}_{\alpha}\left[g_{+}\left(\left|\nabla \mathbb{G}_{\alpha}[f]\right|\right)\right] \leq u \leq \mathbb{G}_{\alpha}[f]+\mathbb{G}_{\alpha}\left[g_{-}\left(\left|\nabla \mathbb{G}_{\alpha}[f]\right|\right)\right] \tag{2.12}
\end{equation*}
$$

and if $f$ is nonnegative, then $u \geq 0$.
Furthermore, the mapping $g \mapsto u$ is decreasing and $f \mapsto u$ is increasing.
To this end, we first introduce following Schauder fixed point theorem.
Theorem 2.2 [15] Assume that $X$ is a Banach space and $T: X \rightarrow X$ is a compact operator such that

$$
T(\mathcal{O}) \subset \mathcal{O}
$$

where $\mathcal{O} \neq \varnothing$ is a closed bounded convex set of $X$. Then there exists fixed point $x \in \mathcal{O}$ of $T$, i.e.

$$
T x=x
$$

Now we are ready to prove Theorem 2.1.
Proof of Theorem 2.1. We divide the proof into several steps.
Step 1. To prove the existence. We define the operator $T$ as

$$
T u=\mathbb{G}_{\alpha}[f-g(|\nabla u|)], \quad u \in W_{0}^{1,1}(\Omega),
$$

where $W_{0}^{1,1}(\Omega)$ is the closure of $\left\{w \in C^{\infty}\left(\mathbb{R}^{N}\right): \operatorname{supp}(w) \subset \bar{\Omega}\right\}$ under the norm of $W^{1,1}(\Omega)$. We claim first that $T$ is compact operator. In fact, for $u \in$ $W_{0}^{1,1}(\Omega)$, we have that $f-g(|\nabla u|) \in L^{1}(\Omega)$ and then by using Proposition
2.4, implies that $T u \in W_{0}^{2 \alpha-\gamma, p}(\Omega)$ where $\gamma=\frac{p-1}{p} N$ and $2 \alpha-\gamma>1$ for $p \in\left(1, \frac{N}{N-2 \alpha}\right)$. Then the embedding $W_{0}^{2 \alpha-\gamma, p}(\Omega) \hookrightarrow W_{0}^{1,1}(\Omega)$ is compact, so $T$ is compact operator. Moreover, using (2.8) with $s=0$, we have that

$$
\begin{align*}
\|T u\|_{W^{1,1}(\Omega)} & \leq\left\|\mathbb{G}_{\alpha}[f]\right\|_{W^{1,1}(\Omega)}+\left\|\mathbb{G}_{\alpha}[g(|\nabla u|)]\right\|_{W^{1,1}(\Omega)} \\
& \leq\left(\|f\|_{L^{\infty}(\Omega)}+\|g(|\nabla u|)\|_{L^{\infty}(\Omega)}\right)\left\|\int_{\Omega} G_{\alpha}(\cdot, y) d y\right\|_{W^{1,1}(\Omega)} \\
& =c_{10}\left(\|f\|_{L^{\infty}(\Omega)}+\|g\|_{L^{\infty}\left(\mathbb{R}_{+}\right)}\right) \tag{2.13}
\end{align*}
$$

where $c_{10}=\left\|\int_{\Omega} G_{\alpha}(\cdot, y) d y\right\|_{W^{1,1}(\Omega)}$.
Let $\mathcal{O}=\left\{u \in W_{0}^{1,1}(\Omega):\|u\|_{W^{1,1}(\Omega)} \leq c_{10}\left(\|f\|_{L^{\infty}(\Omega)}+\|g\|_{L^{\infty}\left(\mathbb{R}_{+}\right)}\right)\right\}$, which is a closed and convex set of $W_{0}^{1,1}(\Omega)$. Combining with (2.13), then

$$
T(\mathcal{O}) \subset \mathcal{O},
$$

and using Theorem 2.2 to obtain a fixed point $u \in \mathbb{Y}$, that is, $T u=u$.
Next we show that $u$ is a classical solution of (2.11). Let open set $O$ satisfy $O \subset \bar{O} \subset \Omega$. By Proposition 2.3 in [24], for any $\sigma \in(0,2 \alpha)$, there exists $c_{11}>0$ such that

$$
\|u\|_{C^{\sigma}(O)} \leq c_{11}\left\{\|g(|\nabla u|)\|_{L^{\infty}(\Omega)}+\|f\|_{L^{\infty}(\Omega)}\right\},
$$

and by choosing $\sigma=\frac{2 \alpha+1}{2} \in(1,2 \alpha)$, then

$$
\|\nabla u\| \|_{C^{\sigma-1}(O)} \leq c_{11}\left\{\|g(|\nabla u|)\|_{L^{\infty}(\Omega)}+\|f\|_{L^{\infty}(\Omega)}\right\}
$$

and then applied Corollary 2.4 in [24], $u$ is $C^{2 \alpha+\epsilon_{0}}$ locally in $\Omega$ for some $\epsilon_{0}>0$. Then $u$ is a classical solution of (2.11). Moreover, from [12], we have

$$
\begin{equation*}
\int_{\Omega}\left[u(-\Delta)^{\alpha} \xi+g(|\nabla u|) \xi\right] d x=\int_{\Omega} \xi f d x, \quad \forall \xi \in \mathbb{X}_{\alpha} \tag{2.14}
\end{equation*}
$$

Step 2. To prove (2.12). Denote by $U_{-}=\mathbb{G}_{\alpha}[f]-\mathbb{G}_{\alpha}\left[g_{+}\left(\left|\nabla \mathbb{G}_{\alpha}[f]\right|\right)\right]$ and $U_{+}=\mathbb{G}_{\alpha}[f]+\mathbb{G}_{\alpha}\left[g_{-}\left(\left|\nabla \mathbb{G}_{\alpha}[f]\right|\right)\right]$. Then $U_{ \pm}=0$ in $\Omega^{c}$ and

$$
(-\Delta)^{\alpha} U_{-}+g_{+}\left(\left|\nabla \mathbb{G}_{\alpha}[f]\right|\right)=f \quad \text { in } \quad \Omega
$$

and

$$
(-\Delta)^{\alpha} U_{+}=f+g_{-}\left(\left|\nabla \mathbb{G}_{\alpha}[f]\right|\right) \quad \text { in } \quad \Omega
$$

We claim that

$$
\begin{equation*}
U_{-} \leq u \leq U_{+} \quad \text { in } \quad \Omega . \tag{2.15}
\end{equation*}
$$

We prove the first inequality of (2.15). If not, there exists $x_{0} \in \Omega$ such that

$$
\left(U_{-}-u\right)\left(x_{0}\right)=\max _{x \in \Omega}\left\{\left(U_{-}-u\right)(x)\right\}>0 .
$$

Then

$$
(-\Delta)^{\alpha}\left(U_{-}-u\right)\left(x_{0}\right)>0 \quad \text { and } \quad \nabla U_{-}\left(x_{0}\right)=\nabla u\left(x_{0}\right) .
$$

This implies that

$$
\begin{equation*}
(-\Delta)^{\alpha}\left(U_{-}-u\right)\left(x_{0}\right)+g_{+}\left(\left|\nabla U\left(x_{0}\right)\right|\right)-g\left(\left|\nabla u\left(x_{0}\right)\right|\right)>0 . \tag{2.16}
\end{equation*}
$$

However, since $u$ is the solutions of (2.11), then we have

$$
(-\Delta)^{\alpha}\left(U_{-}-u\right)\left(x_{0}\right)+g_{+}\left(\left|\nabla U_{-}\left(x_{0}\right)\right|\right)-g\left(\left|\nabla u\left(x_{0}\right)\right|\right)=f\left(x_{0}\right)-f\left(x_{0}\right)=0 .
$$

This is impossible with (2.16). Therefore, (2.12) follows by (2.15). Use the same way to prove the second inequality of (2.15).

In particular, for $f \geq 0$, since the function $\lim _{x \rightarrow \partial \Omega} U(x)=0$, if $u$ is not nonnegative, then there exists $x_{0} \in \Omega$ such that

$$
u\left(x_{0}\right)=\min _{x \in \Omega} u(x)<0,
$$

then we see that $\nabla u\left(x_{0}\right)=0$ and $(-\Delta)^{\alpha} u\left(x_{0}\right)<0$, This contradicts that $u$ is the solution of (2.11).
Step 3. To show that the mapping $g \mapsto u$ is decreasing and $f \mapsto u$ is increasing. We just give the proof of the first argument, the second is similar to prove. Let $g_{1}$ and $g_{2}$ satisfy our hypotheses for $g$ and $g_{1} \leq g_{2}$. Denote $u_{1}$ and $u_{2}$ the solution of (2.11) with $g_{1}$ and $g_{2}$ respectively.

If there exists $x_{0} \in \Omega$ such that

$$
\left(u_{1}-u_{2}\right)\left(x_{0}\right)=\min _{x \in \Omega}\left\{\left(u_{2}-u_{1}\right)(x)\right\}<0 .
$$

Then we have

$$
(-\Delta)^{\alpha}\left(u_{1}-u_{2}\right)\left(x_{0}\right)<0, \quad \nabla u_{1}\left(x_{0}\right)=\nabla u_{2}\left(x_{0}\right) .
$$

This implies that

$$
\begin{equation*}
(-\Delta)^{\alpha}\left(u_{1}-u_{2}\right)\left(x_{0}\right)+g_{1}\left(\left|\nabla u_{1}\left(x_{0}\right)\right|\right)-g_{2}\left(\left|\nabla u_{2}\left(x_{0}\right)\right|\right)<0 . \tag{2.17}
\end{equation*}
$$

However,
$(-\Delta)^{\alpha}\left(u_{1}-u_{2}\right)\left(x_{0}\right)+g_{1}\left(\left|\nabla u_{1}\left(x_{0}\right)\right|\right)-g_{2}\left(\left|\nabla u_{2}\left(x_{0}\right)\right|\right)=f\left(x_{0}\right)-f\left(x_{0}\right)=0$
and the contradiction is obvious. Then $u_{1} \geq u_{2}$.
Finally. The uniqueness follows by the monotonicity in Step 3. The proof is complete.

## 3 Proof of main theorems

### 3.1 The absorption nonlinearity

In this subsection, we prove the existence of weak solution to (1.1) when $g$ is a absorption term, that is, $g(s) \geq 0$ for all $s \geq 0$.
Proof of Theorem 1.1. Existence. We define

$$
C_{\beta}(\bar{\Omega})=\left\{\zeta \in C(\bar{\Omega}): \rho^{-\beta} \zeta \in C(\bar{\Omega})\right\}
$$

endowed with the norm

$$
\|\zeta\|_{C_{\beta}(\bar{\Omega})}=\left\|\rho^{-\beta} \zeta\right\|_{C(\bar{\Omega})} .
$$

We consider a sequence nonnegative functions $\left\{\nu_{n}\right\} \subset C^{1}(\bar{\Omega})$ such that $\nu_{n} \rightarrow$ $\nu$ in the duality sense with $C_{\beta}(\bar{\Omega})$, which means

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \int_{\bar{\Omega}} \zeta \nu_{n} d x=\int_{\bar{\Omega}} \zeta d \nu \tag{3.1}
\end{equation*}
$$

for all $\zeta \in C_{\beta}(\bar{\Omega})$. It follows from the Banach-Steinhaus theorem that $\left\|\nu_{n}\right\|_{\mathfrak{M}(\Omega)}$ is bounded independently of $n$. We denote by $\left\{g_{n}\right\}$ defined on $\mathbb{R}_{+}$a sequence of $C^{\theta}$ and nonnegative functions such that

$$
\begin{equation*}
g_{n} \leq g_{n+1} \leq g, \quad \sup _{s \in \mathbb{R}_{+}} g_{n}(s)=n \quad \text { and } \quad \lim _{n \rightarrow \infty}\left\|g_{n}-g\right\|_{L_{l o c}^{\infty}\left(\mathbb{R}_{+}\right)}=0 \tag{3.2}
\end{equation*}
$$

By Proposition 2.1, there exists a unique nonnegative solution $u_{n}$ of (1.1) with $\nu_{n}$ and $g_{n}$, therefore

$$
\begin{equation*}
\int_{\Omega}\left(u_{n}+g_{n}\left(\left|\nabla u_{n}\right|\right) \eta_{1}\right) d x \leq \int_{\Omega} \nu_{n} \eta_{1} d x \leq C\|\nu\|_{\mathfrak{M}\left(\Omega, \rho^{\beta}\right)} . \tag{3.3}
\end{equation*}
$$

Therefore $\left\|g_{n}\left(\left|\nabla u_{n}\right|\right)\right\|_{\mathfrak{M}\left(\Omega, \rho^{\alpha}\right)}$ is bounded independently of $n$. For $\epsilon>0$, set $\xi_{\epsilon}=\left(\eta_{1}+\epsilon\right)^{\frac{\beta}{\alpha}}-\epsilon^{\frac{\beta}{\alpha}}$, which is concave in the interval $\eta(\bar{\omega})$. By Lemma 2.3 part (ii) in [12], we see that

$$
\begin{aligned}
(-\Delta)^{\alpha} \xi_{\epsilon} & =\frac{\beta}{\alpha}\left(\eta_{1}+\epsilon\right)^{\frac{1}{\alpha}}(-\Delta)^{\alpha} \eta_{1}-\frac{\beta(\beta-\alpha)}{\alpha^{2}}\left(\eta_{1}+\epsilon\right)^{\frac{\beta-2 \alpha}{\alpha}} \int_{\Omega} \frac{\left(\eta_{1}(y)-\eta_{1}(x)\right)^{2}}{|y-x|^{N+2 \alpha}} d y \\
& \geq \frac{\beta}{\alpha}\left(\eta_{1}+\epsilon\right)^{\frac{\beta-\alpha}{\alpha}}
\end{aligned}
$$

and $\xi_{\epsilon} \in \mathbb{X}_{\alpha}$. Since

$$
\int_{\Omega}\left(\left|u_{n}\right|(-\Delta)^{\alpha} \xi_{\epsilon}+g_{n}\left(\left|\nabla u_{n}\right|\right) \xi_{\epsilon}\right) d x \leq \int_{\Omega} \xi_{\epsilon} d\left|\nu_{n}\right|,
$$

we obtain

$$
\int_{\Omega}\left(\frac{\beta}{\alpha}\left|u_{n}\right|\left(\eta_{1}+\epsilon\right)^{\frac{\beta-\alpha}{\alpha}}+g_{n}\left(\left|\nabla u_{n}\right|\right) \xi_{\epsilon}\right) d x \leq \int_{\Omega} \xi_{\epsilon} d\left|\nu_{n}\right| .
$$

If we let $\epsilon \rightarrow 0$, we obtain

$$
\int_{\Omega}\left(\frac{\beta}{\alpha}\left|u_{n}\right| \eta_{1}^{\frac{\beta-\alpha}{\alpha}}+g_{n}\left(\left|\nabla u_{n}\right|\right) \eta_{1}^{\frac{\beta}{\alpha}}\right) d x \leq \int_{\Omega} \eta_{1}^{\frac{\beta}{\alpha}} d\left|\nu_{n}\right| .
$$

By Lemma 2.3 in [12], we derive the estimate

$$
\begin{equation*}
\int_{\Omega}\left(\left|u_{n}\right| \rho^{\beta-\alpha}+g_{n}\left(\left|\nabla u_{n}\right|\right) \rho^{\beta}\right) d x \leq c_{12}\left\|\nu_{n}\right\|_{\mathfrak{M}\left(\Omega, \rho^{\beta}\right)} \leq c_{13}\|\nu\|_{\mathfrak{M}\left(\Omega, \rho^{\beta}\right)} . \tag{3.4}
\end{equation*}
$$

Then $\nu_{n}, g_{n}\left(\left|\nabla u_{n}\right|\right)$ is uniformly bounded in $\mathfrak{M}\left(\Omega, \rho^{\beta}\right)$. Since $u_{n}=\mathbb{G}\left[\nu_{n}-\right.$ $\left.g_{n}\left(\left|\nabla u_{n}\right|\right)\right]$, then

$$
\begin{aligned}
\left\|\left|\nabla u_{n}\right|\right\|_{M^{p_{\alpha}^{*}\left(\Omega, \rho^{\alpha} d x\right)}} & \leq\left\|\nu_{n}\right\|_{\mathfrak{M}\left(\Omega, \rho^{\beta}\right)}+\left\|g_{n}\left(\left|\nabla u_{n}\right|\right)\right\|_{\mathfrak{M}\left(\Omega, \rho^{\beta}\right)} \\
& \leq c_{14}\|\nu\|_{\mathfrak{M}\left(\Omega, \rho^{\beta}\right)} .
\end{aligned}
$$

By Corollary 2.4 the sequence $\left\{u_{n}\right\},\left\{\left|\nabla u_{n}\right|\right\}$ are relatively compact in the $L^{q}(\Omega)$ for $1 \leq q<\frac{N}{N-2 \alpha}$ and $1 \leq q<\frac{N}{N-2 \alpha+1}$, respcetively. Therefore there exist a sub-sequence $\left\{u_{n_{k}}\right\}$ and some $u \in L^{q}(\Omega)$ such that $\left|\nabla u_{n_{k}}\right| \rightarrow$ $|\nabla u|$ in $L^{q}(\Omega)$ and almost every where in $\Omega$. Furthermore $g_{n_{k}}\left(\left|\nabla u_{n_{k}}\right|\right) \rightarrow$ $g(|\nabla u|)$ almost every where in $\Omega$. For $\lambda>0$, we set $S_{\lambda}=\{x \in \Omega$ : $\left.\left|\nabla u_{n_{k}}(x)\right|>\lambda\right\}$ and $\omega(\lambda)=\int_{S_{\lambda}} \rho^{\alpha}(x) d x$. Then for any Borel set $E \subset \Omega$, we have

$$
\begin{aligned}
& \int_{E} g_{n_{k}}\left(\left|\nabla u_{n_{k}}\right|\right)\left|\rho^{\alpha}(x) d x \leq \int_{E} g\left(\left|\nabla u_{n_{k}}\right|\right)\right| \rho^{\alpha}(x) d x \\
& =\int_{E \cap S_{\lambda}^{C}} g\left(\left|\nabla u_{n_{k}}\right|\right) \rho^{\alpha}(x) d x+\int_{E \cap S_{\lambda}} g\left(\left|\nabla u_{n_{k}}\right|\right) \rho^{\alpha}(x) d x \\
& \quad \leq \tilde{g}(\lambda) \int_{E} \rho^{\alpha} d x+\int_{S_{\lambda}} g\left(\left|\nabla u_{n_{k}}\right|\right) \rho^{\alpha}(x) d x \\
& \quad \leq \tilde{g}(\lambda) \int_{E} \rho^{\alpha} d x-\int_{\lambda}^{\infty} g(s) d \omega(s),
\end{aligned}
$$

where $\tilde{g}(s)=\max _{t \in[0, s]}\{g(t)\}$. But

$$
\int_{\lambda}^{\infty} g(s) d \omega(s)=\lim _{T \rightarrow \infty} \int_{\lambda}^{T} g(s) d \omega(s)
$$

Since $\left|\nabla u_{n_{k}}\right| \in M^{p_{\alpha}^{*}}\left(\Omega, \rho^{\alpha} d x\right), \omega(s) \leq c_{15} s^{-p_{\alpha}^{*}}$ and

$$
\begin{aligned}
-\int_{\lambda}^{T} g(s) d \omega(s)=-[g(s) \omega(s)]_{s=\lambda}^{s=T} & +\int_{\lambda}^{T} \omega(s) d g(s) \\
\leq g(\lambda) \omega(\lambda)-g(T) \omega(T) & +c_{15} \int_{\lambda}^{T} s^{-p_{\alpha}^{*}} d g(s) \\
\leq g(\lambda) \omega(\lambda)-g(T) \omega(T)+ & c_{15}\left(T^{-p_{\alpha}^{*}} g(T)-\lambda^{-p_{\alpha}^{*}} g(\lambda)\right) \\
& +\frac{c_{15}}{p_{\alpha}^{*}+1} \int_{\lambda}^{T} s^{-1-p_{\alpha}^{*}} g(s) d s
\end{aligned}
$$

By assumption (1.10) there exists $\{T\} \rightarrow \infty$ such that $T^{-p_{\alpha}^{*}} g(T) \rightarrow 0$ when $n \rightarrow \infty$. Furthermore $g(\lambda) \omega(\lambda) \leq c \lambda^{-p_{\alpha}^{*}} g(\lambda)$, therefore

$$
-\int_{\lambda}^{\infty} g(s) d \omega(s) \leq \frac{c_{15}}{p_{\alpha}^{*}+1} \int_{\lambda}^{\infty} s^{-1-p_{\alpha}^{*}} g(s) d s
$$

Notice that the above quantity on the right-hand side tends to 0 when $\lambda \rightarrow \infty$. The conclusion follows: for any $\epsilon>0$ there exists $\lambda>0$ such that

$$
\frac{c_{15}}{p_{\alpha}^{*}+1} \int_{\lambda}^{\infty} s^{-1-p_{\alpha}^{*}} g(s) d s \leq \frac{\epsilon}{2}
$$

and $\delta>0$ such that

$$
\int_{E} \rho^{\alpha}(x) d x \leq \delta \Longrightarrow g(\lambda) \int_{E} d x \leq \frac{\epsilon}{2}
$$

This proves that $\left\{g_{n_{k}}\left(\left|\nabla u_{n_{k}}\right|\right)\right\}$ is uniformly integrable in $L^{1}\left(\Omega, \rho^{\alpha}(x) d x\right)$. Then $g_{n_{k}}\left(\left|\nabla u_{n_{k}}\right|\right) \rightarrow g(|\nabla u|)$ in $L^{1}\left(\Omega, \rho^{\alpha}(x) d x\right)$ by Vitali convergence theorem. Letting $n_{k} \rightarrow \infty$ in the identity

The purpose of this section is to study the existence of weak solutions to the semilinear fractional elliptic problem with gradient source term $g$ satisfying $g(s) \leq 0$ for $s \geq 0$.

In order to tackle the uniqueness, we have to make use of the properties of classical solution, since Kato's inequality is invalid to obtain uniqueness for gradient nonlinear term. To this end, we start by

\mathbb{G}_{\alpha}\left[\left|\nabla \mathbb{G}_{\alpha}\left[\delta_{0}\right]\right|^{p}\right](x) \leq C_{2}|x|^{2 \alpha-(N-2 \alpha+1) p}, \quad x \in B_{r}(0) \backslash\{0\} . \tag{4.11}
\end{equation*}
$$

On the other side, for $x \in B_{r}(0)$ with $r=\rho(0) / 4$, from [3], we have

$$
\left|\nabla_{x} G(x, 0)\right| \geq \frac{C_{0}}{|x|^{N-2 \alpha+1}}, \quad x \in \Omega
$$

Then for $x \in B_{r}(0) \backslash\{0\}$, we have

$$
\begin{align*}
\mathbb{G}_{\alpha}\left[\left|\nabla \mathbb{G}_{\alpha}\left[\delta_{0}\right]\right|^{p}\right](x) & \geq C \int_{B_{r}(0)} \frac{1}{|y-x|^{N-2 \alpha}} \frac{1}{|y|^{(N-2 \alpha) p}} d y  \tag{4.12}\\
& \geq C|x|^{2 \alpha-(N-2 \alpha) p}
\end{align*}
$$

for some $C>0$. As a consequence, we deduce (4.7) by (4.11) and (2.17).
(ii) In the case of $p=\frac{2 \alpha}{N-2 \alpha+1}$. It is obvious that (4.10) becomes

$$
\mathbb{G}_{\alpha}\left[\left|\nabla \mathbb{G}_{\alpha}\left[\delta_{0}\right]\right|^{p}\right](x) \leq C+\int_{1}^{\frac{r}{|x|}} s^{-1} d s \leq C(1-\ln |x|)
$$

and (4.12) becomes

$$
\mathbb{G}_{\alpha}\left[\left|\nabla \mathbb{G}_{\alpha}\left[\delta_{0}\right]\right|^{p}\right](x) \geq C+\int_{1}^{\frac{D}{|x|}} s^{-1} d s \leq C(1-\ln |x|)
$$

(iii) In the case of $p<\frac{2 \alpha}{N-2 \alpha+1}$. In this case, we only need to prove that $\int_{\Omega} \frac{1}{|y-x|^{N-2 \alpha}|y|^{(N-2 \alpha+1) p}} d y$ is bounded. Indeed, for $x \in B_{r}\left(x_{0}\right)$ with $r=\frac{\min \left\{1, d\left(x_{0}\right)\right\}}{8}$, by Young inequality and the fact of $(N-2 \alpha)(p+1)<N$, we obtain that

$$
\begin{aligned}
& \int_{B_{2 r}(0)} \frac{1}{|y-x|^{N-2 \alpha}|y|^{(N-2 \alpha+1) p}} d y \\
& \leq \int_{B_{2 r}(0)}\left[\frac{1}{|y-x|^{(N-2 \alpha)(p+1)}}+\frac{1}{|y|^{(N-2 \alpha+1)(p+1)}}\right] d y \\
& \leq \int_{B_{4 r}(x)} \frac{1}{|y-x|^{(N-2 \alpha)(p+1)}} d y+\int_{B_{2 r}(0)} \frac{1}{|y|^{(N-2 \alpha+1)(p+1)}} d y \\
& \leq C
\end{aligned}
$$

Then (4.12) becomes

$$
\mathbb{G}_{\alpha}\left[\left|\nabla \mathbb{G}_{\alpha}\left[\delta_{0}\right]\right|^{p}\right](x) \geq C
$$

We complete the proof.
Proof of Theorem 4.1. The existence follows Theorem 1.1 and the solution $u$ satisfies that

$$
\mathbb{G}_{\alpha}\left[\delta_{0}\right]-\mathbb{G}_{\alpha}\left[\left|\nabla \mathbb{G}_{\alpha}\left[\delta_{0}\right]\right|^{p}\right] \leq u \leq \mathbb{G}_{\alpha}\left[\delta_{0}\right]
$$

We deduce the asymptotic behavior of solution $u$ by $\mathbb{G}_{\alpha}\left[\delta_{0}\right]=G_{\alpha}(x, 0)$ and Lemma 4.1.

To prove uniqueness. Let $u$ and $\tilde{u}$ be two solutions of (4.5), then $u$ and $\tilde{u}$ are classical solution of (4.1). For any $\epsilon>0$, let $u_{\epsilon}=(1+\epsilon) u$, we claim that

$$
\begin{equation*}
\tilde{u} \leq u_{\epsilon} . \tag{4.13}
\end{equation*}
$$

In fact, since $\lim _{x \rightarrow 0} \tilde{u}|x|^{N-2 \alpha}=C_{0}$ and $\lim _{x \rightarrow 0} u_{\epsilon}|x|^{N-2 \alpha}=(1+\epsilon) C_{0}$, if not, there exists some point $x_{0} \in \Omega \backslash\{0\}$ such that

$$
\left(\tilde{u}-u_{\epsilon}\right)\left(x_{0}\right)=\max _{x \in \Omega}\left(\tilde{u}-u_{\epsilon}\right)(x)>0
$$

This implies that $(-\Delta)^{\alpha}\left(\tilde{u}-u_{\epsilon}\right)\left(x_{0}\right)<0$ and $\nabla \tilde{u}\left(x_{0}\right)=\nabla u_{\epsilon}\left(x_{0}\right)$. Then on the one hand, we have

$$
\begin{equation*}
(-\Delta)^{\alpha}\left(\tilde{u}-u_{\epsilon}\right)\left(x_{0}\right)+|\nabla \tilde{u}|^{p}\left(x_{0}\right)-\left|\nabla u_{\epsilon}\right|^{p}\left(x_{0}\right)=0 \tag{4.14}
\end{equation*}
$$

On the other hand, $(-\Delta)^{\alpha} \tilde{u}\left(x_{0}\right)+|\nabla \tilde{u}|^{p}\left(x_{0}\right)=0$ and $(-\Delta)^{\alpha} u_{\epsilon}\left(x_{0}\right)=$ $-(1+\epsilon)|\nabla u|^{p}$ and $\left|\nabla u_{\epsilon}\right|^{p}\left(x_{0}\right)=(1+\epsilon)^{p}|\nabla u|^{p}$ and then

$$
(-\Delta)^{\alpha}\left(\tilde{u}-u_{\epsilon}\right)\left(x_{0}\right)+|\nabla \tilde{u}|^{p}\left(x_{0}\right)-\left|\nabla u_{\epsilon}\right|^{p}\left(x_{0}\right)>0,
$$

which is contradiction with (4.14). Take $\epsilon \rightarrow 0$ in (4.13), then we have $\tilde{u} \leq u$. Similarly, $u \leq \tilde{u}$. The proof is complete.
