# A smooth Gaussian-Kronecker diffeomorphism

#### Abstract

We construct a smooth Gaussian-Kronecker diffeomorphism $T$, on $\mathbb{T} \times[0,1]^{\mathbb{N}}$, where $[0,1]^{\mathbb{N}}$ is the Hilbert cube. To obtain this diffeomorphism, we adapt a construction by De La Rue [6], which uses transformations of the planar Brownian motion.


## 1 Introduction

We define Gaussian dynamical systems. We rely on [8]. Let $\gamma$ a finite symmetric measure on the circle $\mathbb{T}$. A dynamical system $(\Omega, \mathcal{A}, \mathbb{P}, U)$ is Gaussian of spectral measure $\gamma$ if there exists a real centred Gaussian process $\left(X_{p}\right)_{p \in \mathbb{Z}}$ satisfying:

1. for any integer $p, X_{p}=X_{0} \circ U^{p}$,
2. $\mathcal{B}\left(X_{p}, p \in \mathbb{Z}\right)=\mathcal{A}$
3. for any integers $p, q, \mathbb{E}\left[X_{p} X_{q}\right]=\int_{0}^{1} e^{2 i \pi(q-p) t} d \gamma(t)$

Giving $\gamma$ determines all the properties of this system. In particular, $U$ is ergodic if and only if $\gamma$ is non-atomic, and in this case, $U$ is even weak mixing (see [5]). The entropy of $U$ is zero or infinite, depending on whether or not $\gamma$ is singular with respect to Lebesgue measure (see [7]).

We recall that $K \subset \mathbb{T}$ is a Kronecker set if any continuous function $f: K \rightarrow \mathbb{T}$ is the uniform limit on $K$ of a sequence of functions $f_{p}: x \mapsto j_{p} x$, where $j_{p}$ is an integer.

In the case where $\gamma$ is non-atomic and concentrated on $K \cup\left(\frac{1}{2}-K\right)$, where $K$ is a Kronecker set of [ $0,1 / 2$ [, we say that the Gaussian dynamical system of spectral measure $\gamma$ is a Gaussian-Kronecker transformation. A Kronecker set always has zero Lebesgue measure, so a Gaussian-Kronecker transformation always has zero entropy.

Gaussian-Kronecker transformations were introduced by Foias and Stratila [10]. They have remarkable properties: they have simple spectrum $L^{p}$, for any $p \geq 1$ (see [5, 14]). Moreover, they satisfy the Weak Closure Theorem [17]: any $\mathbb{P}$-preserving transformation $S$ commuting with $T$ is a weak limit of powers of $T$. We can find a sequence of integers $j_{p}$ such that for any $A \in \mathcal{A}$,

$$
\mathbb{P}\left(S^{-1} A \Delta T^{-j_{p}} A\right) \rightarrow_{p \rightarrow+\infty} 0
$$

Lastly, they satisfy the spectral stability property: any system that is spectrally isomorphic to a Gaussian-Kronecker is actually metrically isomorphic to it.

In [15, 16], Katok raised the problem of the construction of a Gaussian-Kronecker transformation that is smooth. In this paper, we give such construction :

Theorem 1.1. There exists $T \in$ Diff ${ }^{\infty}\left(\mathbb{T} \times[0,1]^{\mathbb{N}}\right.$, Leb $)$ that is Gaussian-Kronecker.
Remark 1.2. Moreover, as in [6], we can get $T$ non-loosely Bernoulli. This gives another example of a smooth non-loosely Bernoulli diffeomorphism, besides the example we constructed in [2]. However, contrary to [2], our construction here does not easily generalize to an uncountable family of pairwise non-Kakutani equivalent diffeomorphisms.

To show this theorem, we provide a smooth version of a transformation constructed by Thierry De La Rue [6]. He constructed a Gaussian-Kronecker and non-loosely Bernoulli transformation using a method of approximation by periodic transformations of the trajectory of the planar Brownian motion.

This adaptation to the smooth case is made using the method of approximation by successive conjugacies, introduced by Anosov and Katok in [1]. More precisely, we generalize our construction of a smooth ergodic diffeomorphism of the annulus $\mathbb{T} \times[0,1]$ that is equal to a rotation $S_{\alpha}$ on the boundary, but that is metrically isomorphic to a rotation $R_{\beta}$ of the circle, such that $\alpha \neq \pm \beta$. In our generalization, we construct a sequence of smooth periodic diffeomorphisms of $\mathbb{T} \times[0,1]^{\mathrm{N}}$, where $[0,1]^{\mathrm{N}}$ is the Hilbert cube, such that each one is metrically isomorphic to an increasingly large family of mutually independent periodic rotations of the circle with different angles. The limit angles of these rotations will provide the Kronecker spectrum of the limit diffeomorphism.

We need to carry the construction on $\mathbb{T} \times[0,1]^{\mathbb{N}}$, instead of $\mathbb{T} \times[0,1]$, because in order to ensure the smooth convergence of the sequence of smooth periodic diffeomorphisms, we need a space of infinite dimensions. This framework is new with respect to known Anosov-Katok constructions.

### 1.1 Definitions

Let $\operatorname{Diff}^{\infty}(M, \mu)$ be the class of smooth diffeomorphisms of $M$ preserving the Lebesgue measure $\mu$. For $B \in \operatorname{Diff}^{\infty}(M, \mu)$ and $j \in \mathbb{N}^{*}$, let $D^{j} B$ be the $j^{t h}$ derivative of $B$ if $j>0$, and the $-j^{\text {th }}$ derivative of $B^{-1}$ if $j<0$. For $x \in M$, let $\left|D^{j} B(x)\right|$ be the norm of $D^{j} B(x)$ at $x$. We denote $\|B\|_{k}=\max _{0<|j| \leq k} \max _{x \in M}\left|D^{j} B(x)\right|$.

A finite measurable partition $\bar{\xi}$ of a measured manifold $(N, v)$ is the equivalence class of a finite set $\xi$ of disjoint measurable subsets of $N$ whose union is $N$, modulo sets of $v$-measure zero. In most of this paper, we do not distinguish a partition $\xi$ with its equivalent class $\bar{\xi}$ modulo sets of $v$-measure zero. In these cases, both are denoted $\xi$. Moreover, all partitions considered in this paper are representatives of a finite measurable partition.

A partition $\xi^{\prime}$ is subordinate to a partition $\xi$ if any element of $\xi$ is a union of elements of $\xi^{\prime}$, modulo sets of $v$-measure zero. In this case, if $\mathcal{B}(\xi)$ denotes the completed algebra generated by $\xi$, then $\mathcal{B}(\xi) \subset \mathcal{B}\left(\xi^{\prime}\right)$. The inclusion map $i: \mathcal{B}(\xi) \rightarrow \mathcal{B}\left(\xi^{\prime}\right)$ will be denoted $\xi \hookrightarrow \xi^{\prime}$. This notation also means that $\xi^{\prime}$ is subordinate to $\xi$. A sequence of partitions $\xi_{n}$ is monotonic if for any $n, \xi_{n} \hookrightarrow \xi_{n+1}$. These definitions and properties are independent of the choice of the representatives $\xi$ and $\xi^{\prime}$ of the equivalence classes $\bar{\xi}$ and $\bar{\xi}^{\prime}$.

A measure-preserving bijective bimeasurable map $T:\left(M_{1}, \mu_{1}, \mathcal{B}_{1}\right) \rightarrow\left(M_{2}, \mu_{2}, \mathcal{B}_{2}\right)$ induces an isomorphism of measure algebras, still denoted $T:\left(\mu_{1}, \mathcal{B}_{1}\right) \rightarrow\left(\mu_{2}, \mathcal{B}_{2}\right)$. If $\xi_{1}, \xi_{2}$ are partitions, and if $\mathcal{B}_{1}=\mathcal{B}\left(\xi_{1}\right)$ and $\mathcal{B}_{2}=\mathcal{B}\left(\xi_{2}\right)$, we denote $T: \xi_{1} \rightarrow \xi_{2}$ this induced isomorphism of measure algebras. If $M_{1}=M_{2}, \mu_{1}=\mu_{2}$ and $\mathcal{B}_{1}=\mathcal{B}_{2}$, then $T$
is a measure-preserving transformation. Its induced isomorphism is an automorphism (see [12, p.43] and [18]).

A metric isomorphism $L$ of measure-preserving transformations $T_{1}:\left(M_{1}, \mu_{1}, \mathcal{B}_{1}\right) \rightarrow$ $\left(M_{1}, \mu_{1}, \mathcal{B}_{1}\right), T_{2}:\left(M_{2}, \mu_{2}, \mathcal{B}_{2}\right) \rightarrow\left(M_{2}, \mu_{2}, \mathcal{B}_{2}\right)$ is a measure-preserving bijective bimeasurable map $L:\left(M_{1}, \mu_{1}, \mathcal{B}_{1}\right) \rightarrow\left(M_{2}, \mu_{2}, \mathcal{B}_{2}\right)$ such that $L T_{1}=T_{2} L$ a.e. For convenience, when the measure is the Lebesgue measure and the algebra is the Borelian algebra, we omit to mention the measures and algebras, and we simply say that $L:\left(M_{1}, T_{1}\right) \rightarrow\left(M_{2}, T_{2}\right)$ is a metric isomorphism.

Let $\bar{\xi}$ be a measurable partition and $\xi$ a representative of this equivalent class modulo sets of $\mu$-measure zero. For $x \in M$, we denote $\xi(x)$ the element of the partition $\xi$ such that $x \in \xi(x)$. A sequences of partitions $\xi_{n}$ of measurable sets generates if there is a set of full measure $F$ such that for any $x \in F$,

$$
\{x\}=F \bigcap_{n \geq 1} \xi_{n}(x)
$$

This property of generation is independent of the choice of the representatives $\xi_{n}$ of the equivalent class $\bar{\xi}_{n}$ and therefore, we will say that the sequence of measurable partitions $\bar{\xi}_{n}$ generates. Let $M / \xi$ denote the equivalent class of the algebra generated by $\xi$, modulo sets of $\mu$-measure zero. $M / \xi$ is independent of the choice of the representative $\xi$ of the equivalent class $\bar{\xi}$. If $T: M_{1} \rightarrow M_{2}$ is a measure-preserving map such that $T\left(\xi_{1}\right)=\xi_{2} \mu$-almost everywhere, we can define a quotient map: $T / \xi_{1}: M / \xi_{1} \rightarrow M / \xi_{2}$.

Let $M=\mathbb{T} \times[0,1]^{\mathbb{N}}$. We consider the periodic flow $S_{t}$ defined by:

S_{t}: \mathbb{T} \times[0,1]^{\mathbb{N}} & \rightarrow \mathbb{T} \times[0,1]^{\mathbb{N}} \\
(s, x) & \mapsto(t+s \quad \bmod 1, x)
\end{aligned}

For $a, b \in \mathbb{T}^{1}$, let $[a, b[$ be the positively oriented circular sector between $a$ and $b$, with $a$ included and $b$ excluded.

For $I \subset \mathbb{T}$ or $[0,1]$, and $i \in \mathbb{N}$, we denote $(I)_{i}=\mathbb{T} \times[0,1] \times \ldots \times[0,1] \times I \times[0,1] \times \ldots .$. , where $I$ is located at the $i^{\text {th }}$ position. $(I \subset \mathbb{T}$ if $i=0, I \subset[0,1]$ if $i \geq 1)$.

For $i \neq i^{\prime}$, we denote $(I)_{i} \times\left(I^{\prime}\right)_{i^{\prime}}=(I)_{i} \cap\left(I^{\prime}\right)_{i^{\prime}}$.
By [11, p. 157], the infinite Cartesian product of the one-dimensional Lebesgue measure defines a probability measure $\mu$ on $M$, still called Lebesgue measure.

A sequence $T_{n}$ of $\mu$-preserving maps weakly converges to $T$ if, for any measurable set $E, \mu\left(T_{n} E \Delta E\right) \rightarrow 0$, where $A \Delta B=(A-B) \cup(B-A)$.
let $E$ be the set of bijections $f$ of $\mathbb{T} \times[0,1]^{\mathbb{N}}$, such that $f\left(\left(x_{i}\right)_{i \in \mathbb{N}}\right)=\left(f_{n}\left(x_{1}, \ldots, x_{n}\right), x_{n+1}, ..\right)$ with $f_{n}$ a smooth diffeomorphism of $\mathbb{T} \times[0,1]^{n}$ for some integer $n$. The smooth distance on finite-dimensional smooth diffeomorphisms extends to $E: d(f, g)=d\left(f_{n}, g_{n}\right)$ (we take $n$ to be the maximum of the integers $n(f)$ and $n(g)$ associated with $f$ and $g$ respectively). The completion of $E$ for $d$ is denoted $\operatorname{Diff}{ }^{\infty}\left(\mathbb{T} \times[0,1]^{\mathbb{N}}\right)$. It corresponds to the set of smooth diffeomorphisms of $\mathbb{T} \times[0,1]^{\mathbb{N}}$, and extends the finite-dimensional notion of smooth diffeomorphisms.

### 1.2 Transformations of the planar Brownian motion

We use the representation of a Gaussian dynamical system as a geometric transformation of the trajectory of the planar Brownian motion, developed in [7]. We denote by $(\Omega, \mathcal{A}, \mathbb{P})$ the canonical space of the planar Brownian motion issued from 0 , on the time interval $[0,1]$ :

1. $\Omega=C_{0}^{0}([0,1], \mathbb{C})$ is the space of continuous maps from $[0,1]$ to $\mathbb{C}$, that cancels in 0 .
2. $\mathbb{P}$ is the Wiener measure on $\Omega$,
3. $\mathcal{A}$ is the Borelian sigma-algebra, completed for $\mathbb{P}$.

For $\omega \in \Omega$, and $0 \leq u \leq 1$, we denote by $B_{u}(\omega)$ the position of the trajectory $\omega$ at time $u$.

If $\sigma$ is a probability measure on $[0,1]$ concentrated in a finite number of points $\alpha_{1}<\ldots<\alpha_{t}$ of respective weights $m_{1}, \ldots, m_{t}$, we define a transformation $U_{\sigma}$ of $\Omega$, preserving $\mathbb{P}$, by the following: for any $k=1, \ldots, t, u_{k}=\sum_{j=1}^{k} m_{j}$, and $u_{0}=0$. We cut the trajectory $\omega$ in $t$ pieces, corresponding to time intervals $\left[u_{k-1}, u_{k}\right], 1 \leq k \leq t$, then we perform a rotation of angle $\alpha_{k}$ on the $k^{t h}$-piece. $U_{\sigma} \omega$ is the trajectory obtained by gluing the rotated pieces. Thus, for $u \in\left[u_{j}, u_{j+1}\right]$,

$$
B_{u} \circ U_{\sigma}=\sum_{k=1}^{j} e^{2 i \pi \alpha_{k}}\left(B_{u_{k}}-B_{u_{k-1}}\right)+e^{2 i \pi \alpha_{j+1}}\left(B_{u}-B_{u_{j}}\right)
$$

Suppose, moreover, that $\alpha_{i}=\frac{p_{n}}{q_{n}} b_{n, i}$, with $p_{n}$ and $b_{n, i}$ integers relatively prime with the integer $q_{n}$. Let $U_{n}=U_{\sigma}$. Let also

$$
c_{n, i, l}=\left\{\omega \in \Omega / \arg \left(B_{u_{i+1}}(\omega)-B_{u_{i}}(\omega)\right) \in\left[\frac{l}{q_{n}}, \frac{l+1}{q_{n}}[ \}\right.\right.
$$

and $\zeta_{n, i}=\left\{c_{n, i, l}, l=0, \ldots, q_{n}-1\right\}$. $\zeta_{n, i}$ is a partition stable by $U_{n}$, and $\left(U_{n \mid \zeta_{n, i},}, \zeta_{n, i}\right)$ is metrically isomorphic to $\left(R \frac{p_{n}}{q_{n}} b_{n, i}, \xi_{n}\right)$, where $R \frac{p_{n}}{q_{n}} n_{n, i}$ is the circle rotation of angle $\frac{p_{n}}{q_{n}} b_{n, i}$, and $\xi_{n}$ is the partition of the circle $\mathbb{T}$ defined by $\xi_{n}=\left\{\left[\frac{l}{q_{n}}, \frac{l+1}{q_{n}}\left[, l=0, \ldots, q_{n}-1\right\}\right.\right.$. This metric isomorphism is the basis of our construction.

Now, if $\sigma$ is a non-atomic probability measure on [0,1], we can define $U_{\sigma}$ as he limit of a sequence of transformations $U_{\sigma_{n}}$, where the measures $\sigma_{n}$ are concentrated on a finite number of points converging sufficiently well towards $\sigma$. For any $u \in[0,1]$, and any $p \in \mathbb{Z}$, we have:

$$
B_{u} \circ U_{\sigma}^{p}=\int_{0}^{u} e^{2 i \pi p \psi(s)} d B_{s}
$$

where $\psi(s)=\inf \{x \in[0,1] / \sigma([0, x]) \geq s\}$.
Moreover, if $\sigma$ is concentrated on $[0,1 / 2]$, then $\left(\Omega, \mathcal{A}, \mathbb{P}, T_{\sigma}\right)$ is a Gaussian dynamical system of spectral measure $\gamma$, where $\gamma$ is the symmetric probability measure on [ $-1 / 2,1 / 2]$, defined by

$$
\gamma(A)=\frac{1}{2}(\sigma(A \cap[0,1 / 2])+\sigma(-A \cap[0,1 / 2]))
$$

The underlying real Gaussian process is given by $X_{0}=\operatorname{Re}\left(B_{1}\right)$ [7].
As a corollary, if $\sigma$ is non-atomic on $[0,1]$, then $U_{\sigma}$ is ergodic (and even weak mixing), and if, moreover, $\sigma$ is singular with respect to Lebesgue measure, then $U_{\sigma}$ has zero entropy.

### 1.3 Basic steps of the proof

The metric isomorphism is obtained as the limit of isomorphisms of finite algebras. We use the lemma [1, p.18]:
Lemma 1.3. Let $M_{1}$ and $M_{2}$ be Lebesgue spaces and let $\xi_{n}^{(i)}(i=1,2)$ be monotonic and generating sequences of finite measurable partitions of $M_{i}$. Let $T_{n}^{(i)}$ be automorphisms of $M_{i}$ such that $T_{n}^{(i)} \xi_{n}^{(i)}=\xi_{n}^{(i)}$ and $T_{n}^{(i)} \rightarrow T^{(i)}$ in the weak topology. Suppose there are metric isomorphisms $L_{n}: M_{1} / \xi_{n}^{(1)} \rightarrow M_{2} / \xi_{n}^{(2)}$ such that

$$
L_{n} T_{n}^{(1)} / \xi_{n}^{(1)}=T_{n}^{(2)} / \xi_{n}^{(2)} L_{n}
$$

and

$$
L_{n+1} \xi_{n}^{(1)}=\xi_{n}^{(2)}
$$

then $\left(M_{1}, T_{1}\right)$ and $\left(M_{2}, T_{2}\right)$ are metrically isomorphic.
Said otherwise, if we have generating sequences of partitions and sequences of automorphisms $T_{n}^{(i)}$ weakly converging towards $T^{(i)}$, and if, for any integer $n$, the following diagram commutes:

then $\left(M_{1}, T_{1}\right)$ and $\left(M_{2}, T_{2}\right)$ are metrically isomorphic.
The proof of theorem 1.1 is in two steps. In the first step (lemma 1.4), we determine sufficient conditions such that there exists sequences of finite partitions and automorphisms satisfying the assumptions of lemma 1.3 with $M_{1}=\Omega, M_{2}=M=\mathbb{T} \times[0,1]^{\mathrm{N}}$, $T_{n}^{(1)}=U_{n}, T_{n}^{(2)}=T_{n}$, where $T_{n}$ is a smooth diffeomorphism, and such that the limit $T$ in the smooth topology of the sequence $T_{n}$ is smooth.

In the second step (lemma 1.5), we construct sequences of integers satisfying the conditions of the first step.
Lemma 1.4. There exists an explicit family of integers $R_{1}(n) \geq n, R_{2}, R_{3}$, such that, if there exist increasing sequences of integers $t_{n}, p_{n}, q_{n}, a_{n, i^{\prime}}, b_{n, i^{\prime}} \in \mathbb{N}^{*}, i^{\prime}=0, \ldots, t_{n}-1$, and sequences $s_{n, i^{\prime}} \in \mathbb{Z}^{*}, i^{\prime}=0, \ldots, t_{n}-1$ such that, for any integer $n$, any $i^{\prime}=0, \ldots, t_{n}-1$,

1. (temporal monotonicity) $t_{n+1}=2^{R_{2}\left(n, q_{n}, t_{n}\right)} t_{n}$.
2. (primality) $a_{n, i^{\prime}} b_{n, i^{\prime}}-s_{n, i^{\prime}} q_{n}=1$.
3. (monotonicity) $q_{n}$ divides $q_{n+1}$.
4. (isomorphism) $q_{n}$ divides $a_{n+1}\left(i / t_{n+1}\right)-a_{n}\left(i^{\prime} / t_{n}\right)$, for $i=i^{\prime} \frac{t_{n+1}}{t_{n}}, \ldots,\left(i^{\prime}+1\right) \frac{t_{n+1}}{t_{n}}-1$.
5. (convergence of the diffeomorphism, generation, Kronecker)

$$
0<\left|\frac{p_{n+1}}{q_{n+1}}-\frac{p_{n}}{q_{n}}\right| \leq 1 / R_{1}\left(n, q_{n}, \prod_{i=0}^{t_{n+1}-1} b_{n+1}\left(i / t_{n+1}\right)\right)
$$

then there exists a smooth ergodic measure-preserving diffeomorphism $T$ of $M$ that is a Gaussian transformation. Moreover, if
6. (Kronecker) the translation of $\mathbb{T}^{t_{n}}$ of vector $\frac{p_{n}}{q_{n}}\left(b_{n}\left(0 / t_{n}\right), \ldots, b_{n}\left(\left(t_{n}-1\right) / t_{n}\right)\right)$ has a fundamental domain of diameter smaller than $1 / n$,

## then $T$ is a Gaussian-Kronecker.

Lemma 1.5. For any $n \geq 1$, there exists increasing sequences of integers
$t_{n}, p_{n}, q_{n}, a_{n, i^{\prime}}, b_{n, i^{\prime}} \in \mathbb{N}^{*}, i^{\prime}=0, \ldots, t_{n}-1$, and sequences $s_{n, i} \in \mathbb{Z}^{*}, i^{\prime}=0, \ldots, t_{n}-1$ satisfying the assumptions of lemma 1.4.

We divide the proof of lemma 1.4 in three main parts. In the first part of the proof, we construct a sequence of monotonic and generating partitions of $\Omega$, called $\zeta_{n}^{\infty}$, which is stabilized by the transformation $U_{n}$. To that end, we use assumptions $1,2,3$. In the second part of the proof, we elaborate sufficient conditions on $B_{n} \in \operatorname{Diff}{ }^{\infty}(M, \mu)$, so that if $T_{n}=B_{n}^{-1} S_{\frac{p n}{q_{n}}} B_{n}$ weakly converges towards an automorphism $T$, then there exists a metric isomorphism between $(\Omega, U, \mathbb{P})$ and $(M, T, \mu)$. To that end, we apply lemma 1.3: we construct a monotonous and generating sequence of partitions $\xi_{n}^{\infty}$ of $M$ and a sequence of isomorphisms $\bar{K}_{n}^{\infty}: \Omega / \zeta_{n}^{\infty} \rightarrow M / \xi_{n}^{\infty}$, such that $\bar{K}_{n}^{\infty} U_{n}=T_{n} \bar{K}_{n}^{\infty}$ and $\bar{K}_{n+1 \zeta_{n}^{\infty}}^{\infty}=\bar{K}_{n}^{\infty}$. In the construction of this isomorphism, assumption 4 is important. Moreover, elements of $\xi_{n}^{\infty}$ must be chosen in a way that ensures the monotonicity of the sequence $\bar{K}_{n}^{\infty}$. This condition of monotonicity induces combinatorial constraints on the elements of the partition $\xi_{n}^{\infty}$.

In the third part of the proof, we construct diffeomorphisms $T_{n}=B_{n}^{-1} S_{\frac{p}{q n}}^{q_{n}} B_{n}$ on $M$ stabilizing $\xi_{n}^{\infty}$, obtained by successive conjugations from the rotation $S \frac{p_{n}}{m}$. In particular, in this part, we use smooth quasi-permutations, introduced in [2].

### 1.4 Construction of suitable sequences of integers: proof of lemma 1.5

We show:
Lemma 1.6. There exist increasing sequences of integers $t_{n}, p_{n}, q_{n}, a_{n}\left(i^{\prime} / t_{n}\right), b_{n}\left(i^{\prime} / t_{n}\right) \in$ $\mathbb{N}^{*}, i^{\prime}=0, \ldots, t_{n}-1$, and sequences $s_{n}\left(i^{\prime} \mid t_{n}\right) \in \mathbb{Z}^{*}, i^{\prime}=0, \ldots, t_{n}-1$ satisfying the assumptions of lemma 1.4.

Proof. We construct these sequences by induction. Let $t_{0}=p_{0}=q_{0}=1, b_{0}\left(0 / t_{0}\right)=$ $s_{0}\left(0 / t_{0}\right)=1, a_{0}\left(0 / t_{0}\right)=2$. Suppose we have defined $t_{k}, p_{k}, q_{k}, a_{k}\left(i^{\prime} / t_{k}\right), b_{k}\left(i^{\prime} / t_{k}\right), s_{k}\left(i^{\prime} / t_{k}\right)$, satisfying the assumptions of lemma 1.4 , up to the rank $k=n$, and let us define $t_{n+1}, p_{n+1}, q_{n+1}, a_{n+1}\left(i / t_{n+1}\right), b_{n+1}\left(i / t_{n+1}\right), s_{n+1}\left(i / t_{n+1}\right)$.

We can define $t_{n+1}=2^{R_{2}\left(n, q_{n}, t_{n}\right)} t_{n}$. Let

To get conditions 5,6 , as in $[1,4]$, we seek $b(n+1)$ of the form:

Therefore, for any $q_{n+1} \geq R_{5}(n, b(n))$ for some $R_{5}(n, b(n))$, and any $p_{n+1}$ such that $\operatorname{gcd}\left(p_{n+1}, q_{n+1}\right)=1$, the translation of $\mathbb{T}^{t_{n+1}}$ of vector $\frac{p_{n+1}}{q_{n+1}} b(n+1)$ has a fundamental domain of diameter smaller than $1 / n$. Hence condition 6 .

Proof. We adapt the proof of $[6, \mathrm{p} .6]$. We must show that for any $f: L \rightarrow \mathbb{T}$ continuous, for any $\epsilon>0$, there exists $k \in \mathbb{Z}$ such that

Since the translation $\frac{p_{n}}{q_{n}} b(n)$ of the $\mathbb{T}^{t_{n}}$-torus has a fundamental domain of diameter smaller than $1 / n$, then there exists $0 \leq k \leq q_{n}-1$ such that

Since $t_{n} \rightarrow+\infty$, then for $n$ sufficiently large, for any $x \in \mathbb{T}$, $\sup _{x \in \mathbb{T}} \sigma_{n}(x) \leq \epsilon$. Therefore, $\sigma$ is non-atomic.n To show that the support of $\sigma$ is included in $L$, let:

Therefore, for any integers $n, m, \frac{p_{n+m}}{q_{n+m}} b_{n+m}\left(i / t_{n+m}\right) \in L_{n}$.
Therefore, $\operatorname{supp}\left(\sigma_{n+m}\right) \subset L_{n}$. Since $L_{n}$ is closed, then $\operatorname{supp}(\sigma) \subset L_{n}$ for any $n$, and so $\operatorname{supp}(\sigma) \subset L$.

## 2 Partitions of $\Omega=C_{0}^{0}([0,1], \mathbb{C})$

The aim of this section is to show the following proposition:
Proposition 2.1. If assumptions of lemma 1.4 hold, there exists measurable partitions $\left(\zeta_{n}^{m}\right)_{n \geq 0, n<m}$ of $\Omega$, such that $\zeta_{n}^{m}$ is stable by $U_{n}$, and such that at $m$ fixed, for $n<m$, $\zeta_{n}^{m} \hookrightarrow \zeta_{n+1}^{m}$. Moreover, there exists an isomorphism $Q_{n}^{m}: \zeta_{n} \rightarrow \zeta_{n}^{m}$ commuting with $U_{n}$.

Moreover, at $n$ fixed, $\zeta_{n}^{m}$ converges as $m \rightarrow+\infty$ towards a partition $\zeta_{n}^{\infty}$, stable by $U_{n}$. Moreover, the sequence $\left(\zeta_{n}^{\infty}\right)_{n \geq 0}$ is monotonous and generates.

A natural partition stabilized by $U_{n}$ is given by $\zeta_{n}=\vee_{i=0}^{t_{n}-1} \zeta_{n, i}$, where:

In order to apply lemma 1.3, we need a monotonous and generating sequence of partitions. In lemma 2.13, we show that $\zeta_{n}$ generates. However, $\zeta_{n}$ is not monotonous, because for any integers $k, i, l, l^{\prime}$,

Therefore, as in [1, 4], we "monotonize" $\zeta_{n}$. This "monotonization" is performed in two steps: in the first step, we construct a partition $\zeta_{n}^{n+1}$ stable by $U_{n}$ and such that $\zeta_{n}^{n+1} \hookrightarrow \zeta_{n+1}$ (lemma 2.2). We also need that the elements of $\zeta_{n}^{n+1}$ have a size independent of $q_{n+1}$, to ensure the smooth convergence of $T_{n}$ towards $T$.

In the second step, we iterate this procedure, so as to obtain a partition $\zeta_{n}^{m}$, such that $\zeta_{n}^{m} \hookrightarrow \zeta_{m}$. At $m$ fixed, for $n<m, \zeta_{n}^{m} \hookrightarrow \zeta_{n+1}^{m}$. We take the limit $m \rightarrow+\infty$. This gives a monotonous partition $\zeta_{n}^{\infty}$ stable by $U_{n}$ (corollary 2.12 ). This procedure is the same as in $[1,4]$. Since $\zeta_{n}$ generates (lemma 2.13), then $\zeta_{n}^{\infty}$ too (corollary 2.15).

To show proposition 2.1, we need some notations and auxiliary transformations. We slightly modify those introduced by De La Rue [8, p. 395].

Let $\theta=\arg B_{1}$, and let $G, D$ transformations of $\Omega$ defined by

Let $\Gamma=G, D$, and for any $n \in \mathbb{N}, \Gamma^{n}$ is the set of words of length $n$ on the alphabet $\Gamma$. Let $\theta_{G}=\theta \circ G, \theta_{D}=\theta \circ D, B_{G}=B_{1} \circ G, B_{D}=B_{1} \circ D$, and having defined the random variables $\theta_{W}$ and $B_{W}$ for $W \in \Gamma^{n}$, we let $\theta_{G W}=\theta_{W} \circ G, \theta_{D W}=\theta_{W} \circ D$, $B_{G W}=B_{W} \circ G, B_{D W}=B_{W} \circ D$. Thus, we obtain families of random variables $\theta_{W}$ and $B_{W}$ defined recursively.

For $n \in \mathbb{N}$, we denote $\mathcal{A}_{n}=\mathcal{B}\left(\theta_{W}, W \in \Gamma^{n}\right)$ and $\mathcal{B}_{n}=\vee_{k=0}^{n} \mathcal{A}_{k}, \mathcal{B}_{\infty}=\vee_{k=0}^{+\infty} \mathcal{A}_{k}$. For $q \in \mathbb{N}^{*}$, let

\mathcal{B}_{W, p}(q)=\vee_{k=0}^{n} \mathcal{A}_{W, k}(q)
\end{gathered}
$$

In particular, we have:

\mathcal{A}_{p+1}(q)=\mathcal{A}_{G, p}(q) \vee \mathcal{A}_{D, p}(q)
$$

The main step in the proof is the following proposition:
Proposition 2.2. If assumptions 1,2 and 3 of lemma 1.4 hold, then for any $n \geq 0$, there exists a measurable partition $\zeta_{n}^{n+1} \hookrightarrow \zeta_{n+1}$ of $\Omega$, stable by $U_{n}$, there exists $Q_{n}^{n+1}: \zeta_{n} \rightarrow$ $\zeta_{n}^{n+1}$ isomorphism such that:

1. For any $c \in \zeta_{n}, \mathbb{P}\left(c \Delta Q_{n}^{n+1} c\right) \leq \frac{1}{2^{n} q_{n}^{l n}}$.
2. $Q_{n}^{n+1} U_{n}=U_{n} Q_{n}^{n+1}$.

Proof of proposition 2.2. First, we need the lemma:
Lemma 2.3. For any $p \geq 0, q>0, \mathbb{P}$-almost surely,

By scaling, $B_{u}^{\prime}$ is another Brownian motion issued from 0, and we have: $B_{1}^{\prime}=\sqrt{2^{|W|}} B_{W}$. Let $\theta^{\prime}=\arg B_{1}^{\prime}$, and for $n \in \mathbb{N}$, we denote $\mathcal{A}_{n}^{\prime}(q)=\mathcal{B}\left(\theta_{W^{\prime}}^{\prime} \in\left[l / q,(l+1) / q\left[, l=0, \ldots, q-1, W^{\prime} \in \Gamma^{n}\right)\right.\right.$ and $\mathcal{B}^{\prime}{ }_{n}(q)=\vee_{k=0}^{n} \mathcal{A}_{k}{ }_{k}(q)$. We have $\mathcal{A}_{W, p}=\mathcal{A}_{p}^{\prime}, \mathcal{B}_{W, p}=\mathcal{B}_{p}{ }_{p}$. Therefore, it suffices to show, $\mathbb{P}$-almost surely:

We show that $\mathbb{E}\left[B_{1} \mid \mathcal{A}_{p}(q)\right]=\mathbb{E}\left[B_{1} \mid \mathcal{B}_{p}(q)\right] \mathbb{P}$-almost surely. Let

We show that for any integer $p \geq 0, u_{p}=0$. Since $=\mathcal{A}_{0}(q)=\mathcal{B}_{0}(q)$, then $u_{0}=0$. It suffices to show that $u_{p+1}=u_{p}$. We follow the method of the proof of relation (15) in [8, p.397]. We have:
$u_{p+1}=\mathbb{E}\left[\left|\mathbb{E}\left[\left.B_{\frac{1}{2}} \right\rvert\, \mathcal{B}_{p+1}(q)\right]-\mathbb{E}\left[\left.B_{\frac{1}{2}} \right\rvert\, \mathcal{A}_{p+1}(q)\right]+\mathbb{E}\left[\left.B_{1}-B_{\frac{1}{2}} \right\rvert\, \mathcal{B}_{p+1}(q)\right]-\mathbb{E}\left[\left.B_{1}-B_{\frac{1}{2}} \right\rvert\, \mathcal{A}_{p+1}(q)\right]\right|^{2}\right]$
$u_{p+1}=\mathbb{E}\left[\frac{1}{2}\left|\mathbb{E}\left[B_{1} \circ G \mid \mathcal{B}_{p+1}(q)\right]-\mathbb{E}\left[B_{1} \circ G \mid \mathcal{A}_{p+1}(q)\right]+\mathbb{E}\left[B_{1} \circ D \mid \mathcal{B}_{p+1}(q)\right]-\mathbb{E}\left[B_{1} \circ D \mid \mathcal{A}_{p+1}(q)\right]\right|^{2}\right]$
For any complex numbers $a, b,|a+b|^{2}=|a|^{2}+b^{2}+a \bar{b}+\bar{a} b$, where $\bar{z}$ denotes the conjugate of the complex number $z$. Therefore,

$$
\begin{aligned}
& u_{p+1}=\frac{1}{2} \mathbb{E}\left[\left|\mathbb{E}\left[B_{1} \circ G \mid \mathcal{B}_{p+1}(q)\right]-\mathbb{E}\left[B_{1} \circ G \mid \mathcal{A}_{p+1}(q)\right]\right|^{2}+\left|\mathbb{E}\left[B_{1} \circ D \mid \mathcal{B}_{p+1}(q)\right]-\mathbb{E}\left[B_{1} \circ D \mid \mathcal{A}_{p+1}(q)\right]\right|^{2}\right] \\
& \left.+\frac{1}{2} \mathbb{E}\left[\left(\mathbb{E}\left[B_{1} \circ G \mid \mathcal{B}_{p+1}(q)\right]-\mathbb{E}\left[B_{1} \circ G \mid \mathcal{A}_{p+1}(q)\right]\right)\left(\overline{\mathbb{E}\left[B_{1} \circ D \mid \mathcal{B}_{p+1}(q)\right]}-\overline{\mathbb{E}\left[B_{1} \circ D \mid \mathcal{A}_{p+1}(q)\right.}\right]\right)\right] \\
& \left.+\frac{1}{2} \mathbb{E}\left[\left(\overline{\mathbb{E}\left[B_{1} \circ G \mid \mathcal{B}_{p+1}(q)\right]}-\overline{\mathbb{E}\left[B_{1} \circ G \mid \mathcal{A}_{p+1}(q)\right.}\right]\right)\left(\mathbb{E}\left[B_{1} \circ D \mid \mathcal{B}_{p+1}(q)\right]-\mathbb{E}\left[B_{1} \circ D \mid \mathcal{A}_{p+1}(q)\right]\right)\right]
\end{aligned}
$$

Now, we apply the claim:
Claim 2.4. Let $X$ a random variable on $(\Omega, \mathcal{A}, \mathbb{P})$, and $\mathcal{G}, \mathcal{H}$ sigma-algebras such that $\mathcal{B}(X, \mathcal{H})$ and $\mathcal{G}$ are independent. We have, a.e.:

Proof. We reproduce the proof of [13]. We need to show that

that is, we need to show that $\mathbb{E}[X \mid \mathcal{H}]$ can serve as the conditional expectation of $X$ given $\mathcal{B}(\mathcal{G} \cup \mathcal{H})$, i.e. show that

- $\mathbb{E}[X \mid \mathcal{H}]$ is $\mathcal{B}(G \cup \mathcal{H})$-measurable,
- $\mathbb{E}[X \mid \mathcal{H}]$ is integrable,
- $\int_{A} \mathbb{E}[X \mid \mathcal{H}] \mathrm{d} \mathbb{P}=\int_{A} X \mathrm{~d} \mathbb{P}$ for all $A \in \mathcal{B}(\mathcal{G} \cup \mathcal{H})$.

The first two are obvious. For the third, let us note that (note that by linearity, we can assume that $X$ is non-negative)

and

are two measures defined on $\mathcal{B}(\mathcal{G} \cup \mathcal{H})$ with equal total mass being $\mathbb{E}[X]$. Hence, it is enough to show that the two measures are identical on some $\cap$-stable generator of $\mathcal{B}(\mathcal{G} \cup \mathcal{H})$. Here, we use that

is indeed a $\cap$-stable generator of $\mathcal{B}(\mathcal{G} \cup \mathcal{H})$. Therefore, it suffices to show that

This is true, because since $\mathcal{G}$ and $\mathcal{H}$ are independent,

By the defining property of conditional expectation, $\mathbb{E}\left[1_{B} \mathbb{E}[X \mid \mathcal{H}]\right]=\mathbb{E}\left[1_{B} X\right]$. Moreover, $1_{B} X \in \mathcal{B}(X, \mathcal{H})$, which is independent of $\mathcal{G}$ by assumption. Therefore,

\mathbb{E}\left[1_{A \cap B} \mathbb{E}[X \mid \mathcal{H}]\right]=\mathbb{E}\left[1_{A}\right] \mathbb{E}\left[1_{B} X\right]=\mathbb{E}\left[1_{A} 1_{B} X\right]=\int_{A \cap B} X \mathrm{dP}
$$

We have that $\mathcal{A}_{p+1}(q)=\mathcal{A}_{G, p}(q) \vee \mathcal{A}_{D, p}(q)$ and $\mathcal{B}_{p+1}(q)=\mathcal{B}_{G, p}(q) \vee \mathcal{B}_{D, p}(q)$. Moreover, the sigma-algebra $\mathcal{B}\left(B_{G}, \mathcal{B}_{G, p}(q)\right)$ is independent of $\mathcal{B}_{D, p}(q)$.

Indeed, $\mathcal{B}\left(B_{G}, \mathcal{B}_{G, p}(q)\right) \subset \mathcal{B}\left(B_{\frac{i+1}{2^{p}}}-B_{\frac{i}{2^{p}}}, i=0, \ldots, 2^{p-1}-1\right)$ and
$\mathcal{B}_{D, p}(q) \subset \mathcal{B}\left(B_{\frac{i+1}{2 p}}-B_{\frac{i}{2 p}}, i=2^{p-1}, \ldots, 2^{p}-1\right)$, and these two sigma-algebras are independent, because the Brownian motion has mutually independent increments. Likewise, $\mathcal{B}\left(B_{D}, \mathcal{B}_{D, p}(q)\right)$ is independent of $\mathcal{B}_{G, p}(q)$. Therefore, by claim 2.4 , we get:

\left.+\left|\mathbb{E}\left[B_{1} \circ D \mid \mathcal{B}_{D, p}(q)\right]-\mathbb{E}\left[B_{1} \circ D \mid \mathcal{A}_{D, p}(q)\right]\right|^{2}\right] \\
\left.+\frac{1}{2} \mathbb{E}\left[\left(\mathbb{E}\left[B_{1} \circ G \mid \mathcal{B}_{G, p}(q)\right]-\mathbb{E}\left[B_{1} \circ G \mid \mathcal{A}_{G, p}(q)\right]\right)\left(\overline{\mathbb{E}\left[B_{1} \circ D \mid \mathcal{B}_{D, p}(q)\right]}-\overline{\mathbb{E}\left[B_{1} \circ D \mid \mathcal{A}_{D, p}(q)\right.}\right]\right)\right] \\
+\frac{1}{2} \mathbb{E}\left[\left(\overline{\mathbb{E}\left[B_{1} \circ G \mid \mathcal{B}_{G, p}(q)\right]}-\overline{\mathbb{E}\left[B_{1} \circ G \mid \mathcal{A}_{G, p}(q)\right.}\right)\left(\mathbb{E}\left[B_{1} \circ D \mid \mathcal{B}_{G, p}(q)\right]-\mathbb{E}\left[B_{1} \circ D \mid \mathcal{A}_{D, p}(q)\right]\right)\right]
\end{gathered}
$$

Since $\mathcal{B}_{G, p}(q)$ and $\mathcal{B}_{D, p}(q)$ are independent, we get:

u_{p+1} & =\frac{1}{2} \mathbb{E}\left[\left|\mathbb{E}\left[B_{1} \circ G \mid \mathcal{B}_{G, p}(q)\right]-\mathbb{E}\left[B_{1} \circ G \mid \mathcal{A}_{G, p}(q)\right]\right|^{2}\right. \\
& \left.+\left|\mathbb{E}\left[B_{1} \circ D \mid \mathcal{B}_{D, p}(q)\right]-\mathbb{E}\left[B_{1} \circ D \mid \mathcal{A}_{D, p}(q)\right]\right|^{2}\right]
\end{aligned}
$$

Since $\mathcal{A}_{G, p}(q)=G^{-1}\left(\mathcal{A}_{p}(q)\right)$ and $\mathcal{B}_{G, p}=G^{-1}\left(\mathcal{B}_{p}(q)\right)$, and since $G$ is measurepreserving, we obtain:

Lemma 2.6. Almost surely, we have:

Theorem 3.2 in [8, p.395] implies that $\left|B_{1}\right|$ is $\bigvee_{k=1}^{+\infty} \mathcal{A}_{k}$-measurable. Therefore, $B_{1}=\left|B_{1}\right| e^{i \arg B_{1}}$ is $\mathcal{B}_{\infty}$-measurable (indeed, [8] introduces $\tilde{\theta}=\arg \left(\frac{B_{\frac{1}{2}}-B_{1}}{B_{\frac{1}{2}}}\right)$ and $\tilde{\mathcal{A}}_{n}=$ $\mathcal{B}\left(\tilde{\theta}_{W}, W \in \Gamma^{n}\right), \tilde{\mathcal{B}}_{n}=\bigvee_{k=0}^{n} \tilde{\mathcal{A}}_{k}$.

Since $\tilde{\theta}=\theta_{D}+\pi-\theta_{G}$, then $\tilde{\theta}$ is $\mathcal{A}_{1}$-measurable, and we have $\tilde{\mathcal{B}}_{n} \subset \bigvee_{k=1}^{n+1} \mathcal{A}_{k}$ ).

Therefore,

$$

Let $\mathcal{B}_{k}^{\prime}=\mathcal{B}_{k}\left(q_{n}^{k}\right)$. By lemma $2.5, \bigvee_{k=0}^{+\infty} \mathcal{B}_{k}^{\prime}=\mathcal{B}_{\infty}$. Moreover, since $q_{n}^{k+1}$ divides $q_{n}^{k}$, then $\mathcal{B}_{k+1}^{\prime} \subset \mathcal{B}_{k}^{\prime}$, and $\mathcal{B}_{k}^{\prime}$ is a filtration. Therefore, $\mathbb{E}\left[B_{1} \mid \mathcal{B}_{k}^{\prime}\right]$ is a closed martingale, and almost surely,

\mathbb{E}\left[B_{1} \mid \mathcal{B}_{k}^{\prime}\right] \rightarrow_{k \rightarrow+\infty} \mathbb{E}\left[B_{1} \mid \mathcal{B}_{\infty}\right]

Since, by lemma 2.3, $\mathbb{E}\left[B_{1} \mid \mathcal{B}_{k}^{\prime}\right]=\mathbb{E}\left[B_{1} \mid \mathcal{A}_{k}\left(q_{n}^{k}\right)\right]$, and since $\mathbb{E}\left[B_{1} \mid \mathcal{B}_{\infty}\right]=B_{1}$, we conclude that, almost surely

Let $Q, \mathcal{N}$ be two measurable partitions. The safe zone of $\mathcal{N}$ with respect to $Q$ is defined by:

=\left\{\omega \in \Omega / \arg \mathbb{E}\left[B_{W} \mid \mathcal{A}_{W, k_{0}}\left(\mathcal{N}_{n}^{n+1}\right)\right] \circ U_{n}^{-1}(\omega) \in\left[\frac{l}{q_{n}}, \frac{l+1}{q_{n}}[ \}\right.\right.
\end{gathered}
$$

$$
=\left\{\omega \in \Omega / \arg \mathbb{E}\left[B_{W} \circ U_{n}^{-1} \mid U_{n}\left(\mathcal{A}_{W, k_{0}}\left(\mathcal{N}_{n}^{n+1}\right)\right)\right](\omega) \in\left[\frac{l}{q_{n}}, \frac{l+1}{q_{n}}[ \}\right.\right.
$$

Moreover, since $R_{\frac{1}{q_{n}}}\left(\mathcal{N}_{n}^{n+1}\right)=\mathcal{N}_{n}^{n+1}$, then $U_{n}\left(\mathcal{A}_{W, k_{0}}\left(\mathcal{N}_{n}^{n+1}\right)\right)=\mathcal{A}_{W, k_{0}}\left(\mathcal{N}_{n}^{n+1}\right)$. On the other hand,

=c_{n}\left(\phi(W), \frac{p_{n} b_{n, \phi(W)}}{q_{n}}+\frac{l}{q_{n}}\right)
\end{gathered}

On the other hand,

Finally, $Q_{n, \phi(W)}^{n+1}$ is measure-preserving: indeed, let $\tilde{U}_{n}$ be the transformation defined like $U_{n}$, but with $p_{n}=b_{n, \phi(W)}=1$ (we use $\tilde{U}_{n}$ instead of $U_{n}$ in order not to use the assumption $\left.\operatorname{gcd}\left(p_{n} b_{n, \phi(W)}, q_{n}\right)=1\right)$. We have:

By independence of the $\zeta_{n, \frac{i}{n_{n}}}^{n+1}$ and by lemma 2.11, $\zeta_{n}^{n+1}$, stable by $U_{n}$, and $Q_{n}^{n+1}$ : $\zeta_{n} \rightarrow \zeta_{n}^{n+1}$ is a measure-preserving isomorphism such that $Q_{n}^{n+1} U_{n}=U_{n} Q_{n}^{n+1}$.

Moreover, since, by estimation (3) and definition (5), we have, for any $i=0, \ldots, t_{n}-$ $1, l=0, \ldots, q_{n}-1$,

Corollary 2.12. If assumptions 1,2 and 3 of lemma 1.4 hold, at $n$ fixed, there exists measurable partitions $\left(\zeta_{n}^{m}\right)_{n \geq 0, n<m}$ of $\Omega$, such that $\zeta_{n}^{m}$ is stable by $U_{n}$, and such that at $m$ fixed, for $n<m, \zeta_{n+1}^{m} \hookrightarrow \zeta_{n}^{m}$. Moreover, at $n$ fixed, $\zeta_{n}^{m}$ converges to a partition $\zeta_{n}^{\infty}$ as $m \rightarrow+\infty$, such that $\zeta_{n}^{\infty}$ is monotonous and stable by $U_{n}$.

Proof. For $m>n$, let

Moreover, $\zeta_{n}^{m}$ is stable by $U_{n}$ : we recall that $b(n)=\left(b_{n}\left(0 / t_{n}\right), \ldots, b_{n}\left(\left(t_{n}-1\right) / t_{n}\right)\right.$. Let $\bar{U}_{n}$ be defined as $U_{n}$, but by taking $p_{n}=1$. Since $b(p+1) / q_{p}=b(p) / q_{p} \bmod \mathbb{Z}$ for any $p \geq n$, and since $q_{n}$ divides $q_{p}$, then $\frac{q_{p}}{q_{n}} b(p) / q_{p}=b(p) / q_{n}=b(n) / q_{n} \bmod \mathbb{Z}$. Since $\bar{U}_{p}$ commutes with $Q_{p}^{p+1}$, then $\bar{U}_{n}=\frac{q_{p}}{q_{n}} \bar{U}_{p}$ also commutes with $Q_{p}^{p+1}$, and therefore, $\bar{U}_{n}$ also commutes with $Q_{n}^{m}=Q_{n}^{n+1} Q_{n+1}^{n+2} \ldots Q_{m-1}^{m}$. Therefore, $U_{n}=\bar{U}_{n}^{p_{n}}$ commutes with $Q_{n}^{m}$, and stabilizes $\zeta_{n}^{m}$.

We show that $\left(\zeta_{n}^{m}\right)_{m \geq n}$ is a Cauchy sequence for the metric on measurable partitions. For any fixed $n, n<m$, we have:

$$

For $c \in \zeta_{n}, Q_{n}^{m}(c) \subset \zeta_{m}$, so we can write:

with $c_{i} \in \zeta_{m}$. By volume conservation of the map $Q_{n}^{m},|I(c)|=q_{m}^{t_{m}} / q_{n}^{t_{n}}$. Therefore, by applying proposition 2.2 ,

\end{aligned}
$$

Therefore,

& \sum_{m \geq n} d\left(\zeta_{n}^{m}, \zeta_{n}^{m+1}\right) \leq \frac{1}{2^{n}} \tag{9}

Therefore, $\left(\zeta_{n}^{m}\right)_{m \geq n}$ is a Cauchy sequence. Let $\zeta_{n}^{\infty}$ its limit. Let $Q_{n}^{\infty}$ the limit of $Q_{n}^{m}$.
Now, we show that $\zeta_{n}^{\infty}$ is monotonous. Let $n \geq 0$ and $\epsilon>0$. Let $m>n$ such that $d\left(\zeta_{n}^{m}, \zeta_{n}^{\infty}\right)<\epsilon / 2$ and $d\left(\zeta_{n+1}^{m}, \zeta_{n+1}^{\infty}\right)<\epsilon / 2$. Let $c_{n}(k) \in \zeta_{n}$, and $c_{n}^{\infty}(k)=Q_{n}^{\infty}\left(c_{n}(k)\right) \in$ $\zeta_{n}^{\infty}$, where $k=\left(\frac{i}{t_{n}}, \frac{l}{q_{n}}\right), i=0, \ldots, t_{n}-1$ and $l=0, \ldots, q_{n}-1$. Let $m \geq n$ such that $\mathbb{P}\left(c_{n}^{m}(k) \Delta c_{n}^{\infty}(k)\right) \leq \epsilon / 2$.

Since $\zeta_{n}^{m} \hookrightarrow \zeta_{n+1}^{m}$, we can write:

Since $d\left(\zeta_{n+1}^{m}, \zeta_{n+1}^{\infty}\right)<\epsilon / 2$, we have:

Since this estimate holds for any $\epsilon>0$, we conclude that:

Lemma 2.13. $\left(\zeta_{n}\right)_{n \geq 0}$ generates.
Proof. We need the lemma:
Lemma 2.14. For any $p \geq 0, k=0, \ldots, 2^{p}-1$, we have, almost surely:

Moreover, $\mathcal{B}\left(\zeta_{n}\right)=\mathcal{A}_{t_{n}^{\prime}}\left(q_{n}\right)$, and by applying claim 2.4, $\mathbb{E}\left[B_{W} \mid \mathcal{A}_{t_{n}^{\prime}}\left(q_{n}\right)\right]=\mathbb{E}\left[B_{W} \mid \mathcal{A}_{W, t_{n}^{\prime}-t_{p}^{\prime}}\left(q_{n}\right)\right]$. Therefore, we get:

Since $B_{\phi(W)}=\sum_{W^{\prime} \in \Gamma^{\prime^{\prime} p} / \phi\left(W^{\prime}\right) \leq \phi(W)} B_{W^{\prime}}$, then we get lemma 2.14.

Let $\omega, \omega^{\prime} \in \Omega$ such that $c_{n}(\omega)=c_{n}\left(\omega^{\prime}\right)$, where $c_{n}(\omega)$ is the element of the partition $\zeta_{n}$ to which $\omega$ belongs. Then almost surely, for any $p \geq 0, k=0, \ldots, 2^{p}-1$, we have:

By taking $n \rightarrow+\infty$, and applying lemma 2.14, we get:

Corollary 2.15. $\left(\zeta_{n}^{\infty}\right)_{n \geq 0}$ generates.
Proof of corollary 2.15. Let $G$ be a measurable set and let $\epsilon>0$. There exists $n_{0} \geq 0$ such that for any $n \geq n_{0}$, there is a $\zeta_{n}$-measurable set $G_{n}$ such that $\mathbb{P}\left(G \Delta G_{n}\right) \leq \epsilon$. Let $I_{n}$ the (finite) set of indices such that

Let

By (9), $\sum_{m \geq n} d\left(\zeta_{n}^{m}, \zeta_{n}^{m+1}\right) \rightarrow_{n \rightarrow+\infty} 0$. Therefore, there is an integer $n_{1}>n_{0}$ such that for any $n \geq n_{1}$ :

& \mathbb{P}\left(Q_{n}^{\infty} G_{n} \Delta G_{n}\right)=\mathbb{P}\left(Q_{n}^{\infty} G_{n} \Delta Q_{n}^{n} G_{n}\right) \leq \sum_{m \geq n} \mathbb{P}\left(Q_{n}^{m+1} G_{n} \Delta Q_{n}^{m} G_{n}\right) \\
= & \sum_{m \geq n} \sum_{i_{n} \in I_{n}} \mathbb{P}\left(Q_{n}^{m+1} c_{n}\left(i_{n}\right) \Delta Q_{n}^{m} c_{n}\left(i_{n}\right)\right) \leq \sum_{m \geq n} \sum_{c \in \zeta_{n}} \mathbb{P}\left(Q_{n}^{m+1} c \Delta Q_{n}^{m} c\right) \leq \epsilon
\end{aligned}
$$

Therefore, for any $n \geq n_{1}, \mu_{h}\left(Q_{n}^{\infty} G_{n} \Delta G\right) \leq 2 \epsilon$. Hence the generation of $\zeta_{n}^{\infty}$.

## 3 The metric isomorphism

This section is similar to [3, section 2], although the framework is more general. Our aim is to elaborate sufficient conditions on $B_{n} \in \operatorname{Diff}^{\infty}(M, \mu)$, so that if $T_{n}=B_{n}^{-1} S_{\frac{p}{q}}^{q_{n}} B_{n}$ weakly converges towards an automorphism $T$, then there exists a metric isomorphism between $(\Omega, U, \operatorname{Pr})$ and $(M, T, \mu)$.

To that end, we use lemma 1.3: we construct a monotonous and generating sequence of partitions $\xi_{n}^{\infty}$ of $M$ and a sequence of isomorphisms $\bar{K}_{n}^{\infty}: \mathbb{T}^{1} / \zeta_{n}^{\infty} \rightarrow M / \xi_{n}^{\infty}$, such that $\bar{K}_{n}^{\infty} U_{n}=T_{n} \bar{K}_{n}^{\infty}$ and $\bar{K}_{n+1 \zeta_{n}^{\infty}}^{\infty}=\bar{K}_{n}^{\infty}$.

For $l=0, \ldots, q_{n}-1$, let

$$

\Delta_{n}\left(0, \frac{l}{q_{n}}\right)=\left[\frac{l}{q_{n}}, \frac{l+1}{q_{n}}[0\right. \\
\eta_{n, 0}=\left\{\Delta_{n}\left(0, \frac{l}{q_{n}}\right), l=0, \ldots, q_{n}-1\right\}
\end{gathered}
$$

For $i=1, \ldots, t_{n}-1, l=0, \ldots, q_{n}-1$, let

\Delta_{n}\left(\frac{i}{t_{n}}, \frac{l}{q_{n}}\right) & =\bigcup_{j=0}^{q_{n}-1}\left(\frac{l}{q_{n}}+\left[\frac{j}{q_{n}}, \frac{j+1}{q_{n}}[)_{0} \times\left[\frac{j}{q_{n}}, \frac{j+1}{q_{n}}[i\right.\right.\right. \\
\eta_{n, \frac{i}{m_{n}}} & =\left\{\Delta_{n}\left(\frac{i}{t_{n}}, \frac{l}{q_{n}}\right), l=0, \ldots, q_{n}-1\right\}
\end{aligned}
$$

For any $i=0, \ldots, t_{n}-1, \eta_{n, \frac{i}{I_{n}}}$ is a partition of $M$ stable by $S_{\frac{p n}{q n}}$. Moreover, the family $\left(\eta_{n, \frac{i}{t_{n}}}\right)_{i=0, \ldots, t_{n}-1}$ is mutually independent. Let $\eta_{n}=\mathrm{V}_{i=0}^{t_{n}-1} \eta_{n, \frac{i}{n_{n}}}$. For $n \geq 1, j=0, \ldots, t_{n-1}$, $k=0, \ldots, t_{n} / t_{n-1}-1$, let

h_{n}\left(\frac{t_{n}}{t_{n-1}} j+k\right)=j+t_{n-1} k
$$

The map $h_{n}:\left\{0, \ldots, t_{n}-1\right\} \rightarrow\left\{0, \ldots, t_{n}-1\right\}$ is bijective. It permutes coordinates $x_{i}, i \geq 1$, and "distributes" them in order to make possible the construction of a diffeomorphism $A_{n+1}$ that simultaneously sends $t_{n}$ independent partitions $\eta_{n, i}$ on $t_{n}$ other independent partitions $\eta_{n, i}^{n+1}$, modulo a set of small measure. See the beginning of section 4.3 for more explanations.

The following lemma gives the isomorphism from which we start:
Lemma 3.1. For $i^{\prime}=0, \ldots, t_{n}-1$, let $a_{n}\left(i^{\prime} / t_{n}\right)$ relatively prime with $q_{n}$, and let

Proof of corollary 3.2. Since each $K_{n, \frac{i}{I_{n}}}$ is surjective, then $K_{n}$ is also surjective. Because of the mutual independence of partitions, $\left|\zeta_{n}\right|=\left|\eta_{n}\right|=q_{n}^{t_{n}}$. Therefore, $K_{n}$ is also injective, and it is an isomorphism.

The following lemma combines corollary 3.2 with the facts that $\zeta_{n} \hookrightarrow \zeta_{n+1}$ and $\eta_{n} \hookrightarrow \eta_{n+1}:$

Proof. We still give a proof, because the similarity with the corresponding lemma in [3] may not be obvious (especially the fact that there are multiple coefficients $b_{n+1}\left(i / t_{n+1}\right)$, and because it allows to introduce some notations and objects that are useful in the next section. Since $\operatorname{gcd}\left(a_{n+1}\left(i / t_{n+1}\right), q_{n+1}\right)=1$, then by corollary $3.2, K_{n+1}$ is an isomorphism. Since $\zeta_{n}^{n+1} \hookrightarrow \zeta_{n+1}$, we can define the isomorphism $K_{n}^{n+1}=K_{n+1 \mid \zeta_{n}^{n+1}}$. Let $\eta_{n}^{n+1}=K_{n}^{n+1}\left(\zeta_{n}\right)$. Proof. The proof is similar to the one found in [4].
For any $n$ fixed, the sequence of partitions $\left(\eta_{n}^{m}\right)_{m \geq n}$ must converge when $m \rightarrow+\infty$, in order to obtain a full sequence of monotonic partitions. Moreover, the possible limit sequence (i.e. a possible $\eta_{n}^{\infty}$ ) must generate. Indeed, these assumptions are required to apply lemma 1.3. However, none of these assumptions are satisfied, in general. Therefore, to obtain these assumptions, we pull back the partition $\eta_{n}^{m}$ by a suitable smooth measure-preserving diffeomorphism $B_{m}$. The following lemma, already proved in [4], gives the conditions that $B_{m}$ must satisfy:

Lemma 3.5. Let $B_{m} \in \operatorname{Diff}^{\infty}(M, \mu)$. Let $A_{m+1}=B_{m+1} B_{m}^{-1}$.

1. If $A_{m+1} S_{\frac{1}{q m}}=S_{\frac{1}{q m}} A_{m+1}$ and if

The sequence $\xi_{n}^{\infty}$ is monotonous and $T_{n}=$ $B_{n}^{-1} S_{\frac{p_{n}}{q_{n}}} B_{n}$ stabilizes each $\xi_{n}^{\infty}$.
2. If, moreover, the sequence $\xi_{n}=B_{n}^{-1}\left(\eta_{n}\right)$ generates, then so does $\xi_{n}^{\infty}$.

By adding to lemma 3.5 the convergence of the sequence $T_{n}$, we obtain the required isomorphism:

Corollary 3.6. If both conditions 1. and 2. of lemma 3.5 hold, and if $T_{n}=B_{n}^{-1} S_{\frac{p_{n}}{q_{n}}} B_{n}$ weakly converges towards an automorphism $T$, then $(\Omega, U, \mathbb{P})$ and $(M, T, \mu)$ are metrically isomorphic.

Proof. The proof is the same as in [4].

## 4 The sequence of conjugacies

In order to construct a suitable smooth approximation $A_{n+1}$ of $C_{n}^{n+1}$, we re-write and approximate the partition $\eta_{n}^{n+1}$, so that the elements of the approximated partition $\eta_{n}^{\prime n+1}$ consist of unions of medium-sized "cubes" (their size is given by a parameter $u_{n+1}$ ) with suitable properties.

These cubes need to be small enough in order to have a good approximation of $\eta_{n}^{n+1}$ by $\eta_{n}^{\prime n+1}$, but they must be large enough to suitably control the norm of $A_{n+1}$. Likewise, elements of $\eta_{n}$ are decomposed into cubes of the same medium-size.

Thus, transforming $\eta_{n}$ into $\eta_{n}^{\prime n+1}$ consists of permuting these cubes. We construct a smooth approximation of this permutation. For the vertical permutation along the $z$ coordinate, we apply a transformation developed in [1], [4], [3], based on fibred rotations of the flow along $z$.

For horizontals permutations, along coordinates $x_{i}, i \geq 1$, we apply and generalize the method of "quasi-permutations" that we introduced in [2]. There is no rotation flow along $x_{i}$, so we displace cubes one by one.

The re-writing and approximation of $\eta_{n}^{n+1}$ has 3 steps: first (lemma 4.1), we rewrite elements of $\eta_{n}^{n+1}$ using the "stacking phenomenon" presented in [3]. A priori, $\Gamma\left(\frac{i}{t_{n+1}}, \frac{j}{q_{n}^{k_{0}}}\right)$ consists of $v$ "slices" of width $1 / q_{n+1}$, with $v=v_{n+1}$ or $\rho_{n+1}$. However, this fact does not ensure the convergence of $T_{n}$, because it only implies that $\left\|B_{n+1}\right\|_{j} \leq$ $F\left(q_{n+1}\right)$ for some fixed function $F$. In order to apply the reasoning above successfully, we need a better estimate. Lemma 4.1 shows that "slices" of $\Gamma\left(\frac{i}{t_{n+1}}, 0\right)$ of width $1 / q_{n+1}$ stack on each other, which gives $b_{n+1}\left(i / t_{n+1}\right)$ connected components to $\Gamma\left(\frac{i}{t_{n+1}}, 0\right)$, each having a width of order $v /\left(q_{n+1} b_{n+1}\left(i / t_{n+1}\right)\right)$. If we only consider slices for $v=v_{n+1}$, this will allow an estimate of the form $\left\|B_{n+1}\right\|_{j} \leq F\left(q_{n}, \max _{i} b_{n+1}\left(i / t_{n+1}\right)\right)$, for some fixed function $F$, which will allow the convergence of $T_{n}$, by taking $b_{n+1}\left(i / t_{n+1}\right)$ small.

Second (lemma 4.4), we approximate $\eta_{n}^{n+1}$ horizontally: along the coordinate $x_{i}$, elements of $\eta_{n}^{n+1}$ are piecewise constant, with a thickness of $1 / q_{n+1}$. This would lead to a too large conjugacy, of order $q_{n+1}$. We make an approximation of thickness $w_{n+1} / q_{n+1}$ in most cases, with $w_{n+1}$ large.

The construction is carried on the infinite-dimensional Hilbert cube, instead of the finite-dimensional annulus, as in previous constructions [1, 9, 4, 3, 2], because the stacking phenomenon only allows to stack together $q_{n+1} / f\left(q_{n}\right)$ elements.

Therefore, if elements of the partition $\eta_{n+1}$ have a length negligible with respect to $1 / q_{n+1}$, we cannot stack them to get a partition with elements of length negligible with respect to $q_{n+1}$, which is a necessary condition for the smooth convergence with our method.

In our case, the volume of an element of the intersection of $t_{n+1}$ mutually independent partitions of size $q_{n+1}$ each has a volume of $1 / q_{n+1}^{t}$. Therefore, in dimension $d$, the maximum of the minimal length of an element of this partition is $1 / q_{n+1}^{t-d}$. Since $t_{n} \rightarrow+\infty$, the dimension of the manifold at the limit must be infinite. For example, in dimension 2 , for $t \geq 1$ integer, let $\eta_{n, t}$ be the partition defined by

The partitions $\eta_{n, t}, t \geq 1$ are mutually independent and stable by $S_{1 / q_{n}}$. However, elements of $\eta_{n, t}$ are $1 / q_{n+1}^{t-1}$-periodic along the horizontal coordinate, so for $t \geq 2$, we cannot move them into elements of $\eta_{n}^{n+1}$ with a diffeomorphism having a norm smaller than $q_{n+1}$.

However, if, for example, we had to consider $t$ pairwise-independent partitions of size $q_{n+1}$, instead of mutually independent partitions, then we would be able to carry the construction on the 2-dimensional annulus.

The broad idea is that the Anosov-Katok method does not allow the manipulation of excessively "complicated" partitions, which have smaller components, because of the constraint of smoothness. To manipulate simpler partitions, we increase the number of dimensions of the partitions. We met the same problem in [2], where we considered two-dimensional partitions, in order to avoid that elements of the partition are intertwined.

### 4.1 Re-writing and approximation of the partition $\eta_{n}^{n+1}$ by $\eta_{n}^{\prime n+1}$

For $i=0, \ldots, t_{n}-1$, let

By our choice of $w_{n+1}$ in (13), we have:

Moreover, $\Delta_{n}^{\prime n+1}\left(\frac{i^{\prime}}{t_{n}}, \frac{l}{q_{n}}\right)$ is a fundamental domain of $S_{1 / q_{n}}$, because $\Delta_{n}^{n+1}\left(\frac{i^{\prime}}{t_{n}}, \frac{l}{q_{n}}\right)$ is a fundamental domain of $S_{1 / q_{n}}$.

By corollary 4.3, $\Delta_{n}^{\prime n+1}\left(\frac{i^{\prime}}{t_{n}}, \frac{l}{q_{n}}\right) \subset \mathcal{B}\left\{C(m), m \in u\left(J_{n+1}\left(i^{\prime}\right)\right)\right\}$. Therefore, for any $m \in$ $u\left(J_{n+1}(0)-\{0\}\right)$, there exists $R^{(m)} \subset \mathcal{B}\left(\mathcal{P}_{0}\right)$ such that $R^{(m)}$ is a fundamental domain of the circle rotation $R_{1 / q_{n}}$ and such that:

This completes the proof of proposition 4.4.

The rest of the paper is dedicated to the construction of the sequence of diffeomorphisms $B_{n}$ satisfying the conditions of lemma 3.5 . First, we introduce definitions and basic properties. Second, we define the diffeomorphism $A_{n+1}$ and we show that it satisfies conditions of lemma 3.5.

### 4.2 Definitions and basic properties

For these definitions, we rely and elaborate on [11, p.155]. Let $J \subset \mathbb{N}$. For any $X \subset M$, we let $X_{J}=\left\{\left(x_{j}\right)_{j \in J} / x \in X\right\}$.

A set $E \subset M$ is a $J$-cylinder if, for any $x, y \in M$ such that for any $j \in J, x_{j}=y_{j}$, we do not have: $(x \in E$ and $y \notin E)$ or $(x \notin E$ and $y \in E)$.

In other words, $E$ is a $J$-cylinder if changing the coordinates of an index not in $J$ of a point $x \in E$ cannot remove $x$ from $E$, nor insert it into $E$. The terminology $\left(z,\left(x_{j}\right)_{j \in J}\right)$-cylinder is synonymous of $\{0, J\}$-cylinder.

For example, $C(m)$ is a $J$-cylinder. $\Delta_{n}\left(0 / t_{n}, l / q_{n}\right)$ is a $z$-cylinder, and for $i \geq 1$, $\Delta_{n}\left(i / t_{n}, l / q_{n}\right)$ is a $\left(z, x_{i}\right)$-cylinder.

For any $A \subset M, A_{0} \times \ldots \times A_{n} \times M_{n+1} \times \ldots$ is a $\{0, \ldots, n\}$-cylinder.
We use the following claims:
Claim 4.5. If $E$ is a $J$-cylinder and $E^{\prime}$ is a $J^{\prime}$-cylinder, then $E \cup E^{\prime}$ and $E \cap E^{\prime}$ are $J \cup J^{\prime}$-cylinders.

For example, $\Delta_{n}\left(i / t_{n}, l / q_{n}\right) \cap \Delta_{n}\left(i^{\prime} / t_{n}, l^{\prime} / q_{n}\right)$ is a $\left(z, x_{i}, x_{i^{\prime}}\right)$-cylinder.
For example, by proposition 4.4, for any $l=0, \ldots, q_{n}-1, \Delta_{n}^{\prime n+1}\left(\frac{0}{t_{n}}, \frac{l}{q_{n}}\right)$ is a $J(0)$ cylinder, and for $i \geq 1, \Delta_{n}^{\prime n+1}\left(\frac{i}{t_{n}}, \frac{l}{q_{n}}\right)$ is a $\{0\} \cup J(i)$-cylinder.

A transformation $F$ of $M$ is a $J$-transformation if for any $x \notin J$, and any $x \in M$, $(F(x))_{j}=x_{j}$. It means that at most, $F$ transforms coordinates in $J$.

Claim 4.6. If $F$ is a $J$-transformation and if $c$ is a $J^{\prime}$-cylinder such that $J \cap J^{\prime}=\emptyset$, then $F(c)=c$.

Proof. First, we show that $F(c) \subset c$. Let $x \in c$ and $y=F(x)$. Since $F$ is a $J$ transformation, then $y_{j}=(F(x))_{j}=x_{j}$ for any $j \in J^{c}$, where $J^{c}$ be the complementary of $J$ in $\mathbb{N}$. Since $J \cap J^{\prime}=\emptyset$ then $J^{\prime} \subset J^{c}$. Therefore, for any $j \in J^{\prime}, y_{j}=x_{j}$. Since $c$ is a $J^{\prime}$-cylinder, then $y \in c$. Therefore, $F(c) \subset c$.

To show that $c \subset F(c)$, we observe that $F^{-1}$ is also a $J$-transformation: if $y_{j}=x_{j}$, then $y_{j}=\left(F^{-1}(y)\right)_{j}$ for any $j \in J^{c}$. Therefore, $F^{-1}(c) \subset c$ and so $c \subset F(c)$.

Let $\left(J^{\prime}\right)^{c}$ be the complementary of $J^{\prime}$ in $\mathbb{N}$. A transformation $F$ is $J^{\prime}$-dependent if there exists $\bar{J} \subset J^{\prime}$ such that $F$ is a $\bar{J}$-transformation, and such that there exists $\tilde{F}: M_{J^{\prime}} \rightarrow M_{\bar{J}}$ such that for any $x \in M, x=\left(x_{j}, x_{j^{\prime}}, x_{j^{\prime \prime}}\right)$ with $x_{j} \in M_{\bar{J}}, x_{j^{\prime}} \in M_{J^{\prime}-\bar{J}}$, $x_{j^{\prime \prime}} \in M_{\left(J^{\prime}\right)^{c}}$, we have:

Proof. First, observe that since $F$ is $J^{\prime}$-dependent, then $F$ is $J \cup J^{\prime}$-dependent. Let $x \in M$. We write $x=\left(x_{j}, x_{j^{\prime}}, x_{j^{\prime \prime}}\right)$ with $x_{j} \in M_{\bar{J}}, x_{j^{\prime}} \in M_{J^{\prime}-\bar{J}}, x_{j^{\prime \prime}} \in M_{\left(J \cup J^{\prime}\right)^{c} \text {. }}$. Since $F$ is $J \cup J^{\prime}$-dependent, then there exists $\tilde{F}: M_{J \cup J^{\prime}} \rightarrow M_{J \cup J^{\prime}}$ such that:

Since $F$ is injective ( $F$ is a transformation), then $z=x$. In particular, $x_{j}=y_{j}$.
If, moreover, $F(x) \in F(c)$, then $x \in c$, because $F$ is bijective. Since $c$ is a $J$-cylinder, then $y \in c$. Therefore, $F(y) \in F(c)$.

Likewise, if $F(x) \notin F(c)$, then $F(y) \notin F(c)$. Therefore, $F(c)$ is a $J \cup J^{\prime}$-cylinder.

### 4.3 Construction of the sequence of conjugacies

In this section, we construct the sequence of diffeomorphisms $A_{n+1}$ of $M$. We write $A_{n+1}=A_{n+1, t_{n}} \circ \ldots \circ A_{n+1,0}$. To simplify notations, we denote $A$ instead of $A_{n+1}$, and for $i=0, \ldots, t_{n}-1$, we denote $A_{i}$ instead of $A_{n+1,0}$, and $J(i)$ instead of $J_{n+1}(i)$. First, we construct $A_{0}$ (lemma 4.9). Second, we construct $A_{i}$, for $i \geq 1$ (lemma 4.11). The
construction of $A_{0}$ is different from the others $A_{i}$ because the partition $\eta_{n, 0}$ is different from the others $\eta_{n, i}$.

The reason why we introduced the permutation of coordinates $h_{n}(i)$ appears here: for example, if we took $h_{n}(i)=i$, then for $i \geq 1$, it would be impossible to apply $A_{i}$ without completely modifying the image of $\eta_{n, 0}$ by $A_{n+1,0}$. If we took $h_{n}(i)$ such that $h_{n+1}\left(\left\{1, \ldots, t_{n}-1\right\}\right) \cap\left\{1, \ldots, t_{n}-1\right\}=\emptyset$, then we cannot obtain generation.

On the other hand, with our choice of $h_{n}(i)$, we can compose the maps $A_{i}$ with no problems, by using the notions and properties introduced in 4.2.

The aim of this subsection is to show the following proposition:
Proposition 4.8. For any $\frac{w_{n+1}^{\prime}}{2 q_{n+1}}>\epsilon>0$, there exists $A: M \rightarrow M$ smooth measurepreserving diffeomorphism such that:

1. $A S_{\frac{1}{q_{n}}}=S_{\frac{1}{q_{n}}} A$.
2. There is a fixed function $R_{1}\left(n, t_{n+1}, b_{n+1}, q_{n}, \epsilon\right) \in \mathbb{N}$ such that

2. There is a fixed function $R_{2}\left(n, t_{n+1}, b_{n+1}, q_{n}, \epsilon_{0}\right) \in \mathbb{N}$ such that

2. There is a fixed function $R_{3}\left(n, t_{n+1}, b_{n+1}, q_{n}, \epsilon_{0}\right) \in \mathbb{N}$ such that

Proof of lemma 4.9. We define $A_{0}$ by $A_{0}=o_{m \in \bar{u}(J(0)-\{0\})} A_{0}(m)$, with $A_{0}(m)$ having disjoint supports. $A_{0}$ has the required properties.

Proof of lemma 4.10. By lemmas 3.3, 3.4 and by remark 3.6 in [3], which elaborates on a construction found in [1] and [4], for any $j \leq u_{n+1}-1, m \in \bar{u}(J(0)-\{0\})$, there exists $\bar{A}_{0}(m) \in \operatorname{Diff}^{\infty}\left(\mathbb{T} \times\left[j w_{n+1} / q_{n+1},(j+1) w_{n+1} / q_{n+1}\right], L e b_{2}\right)$, there exists $\bar{E}_{0}(m) \subset$ $\overline{\mathcal{P}}_{0} \times\left[j w_{n+1} / q_{n+1},(j+1) w_{n+1} / q_{n+1}\right]$ such that

Properties $1,2,3,4$ hold for $A_{0}(m)$, because similar properties hold for $\bar{A}_{0}(m)$, and because $\phi$ is independent of $z$, and bounded in estimation (5).

Property 5 is obtained by construction, the $J(0)$-dependence is due to $\phi$.

For $t_{n}-1 \geq i \geq 1$, the definition of $A_{i}$ is given by:

### 4.4 Generation of $\xi_{n}$ and convergence of the sequence of diffeomorphisms

By combining lemma 3.5 , in order to complete the proof of lemma 1.4 , it remains to show that $\xi_{n}$ generates, that $T_{n}=B_{n}^{-1} S_{\frac{p_{n}}{q_{n}}} B_{n}$ converges in the smooth topology. The limit $T$ of $T_{n}$ is ergodic because it is isomorphic to an ergodic transformation ( De La Rue's transformation is ergodic).

### 4.4.1 Generation of $\xi_{n}$

## Lemma 4.15. $\xi_{n}$ generates.

Proof. Let $p \geq 0$ and for $x, y \in M$, let $d_{p}(x, y)=\max _{0 \leq i \leq p}\left|x_{i}-y_{i}\right|$. For any $V \subset M$, let the $p$-diameter of $V$ be $d_{p}(V)=\sup _{x, y \in V} d_{p}(x, y)$. We use the lemma:

Lemma 4.16. Let $V_{n} \subset M$ be a sequence of subsets such that there exists $r_{n} \rightarrow+\infty$ such that $d_{r_{n}}\left(V_{n}\right) \rightarrow_{n \rightarrow+\infty} 0$. For any $k \geq 0, \cap_{n \geq k} V_{n}$ is at most a singleton.

Proof. Let $k \geq 0$ and $x, y \in \cap_{n \geq k} V_{n}$. Let $M \geq 0$ and $n_{0}$ such that for any $n \geq n_{0}, r_{n} \geq M$. For $n \geq n_{0}$, we have: $d_{M}(x, y) \leq d_{r_{n}}(x, y) \rightarrow 0$. Therefore, $x_{i}=y_{i}$ for $i=0, \ldots, M$ for any $M$ and therefore, $x=y$.

The diffeomorphism $A_{n+1 \mid E_{n+1}}$ acts as a permutation, and in particular, it is an isometry. On the other hand, elements of $\eta_{n+1}$ are of the form $\times_{i=0}^{t_{n+1}-1}\left(\left[j_{i} / q_{n+1},\left(j_{i}+1\right) / q_{n+1}[)_{i}\right.\right.$, for $j_{i}=0, \ldots, q_{n+1}-1$. Therefore, for $q_{n+1} \geq R_{9}\left(n, t_{n+1}, b_{n+1}, q_{n}, \epsilon\right)$, for any $c \in \eta_{n+1}$,

By lemma 4.16, for any integer $k, \bigcap_{n \geq k} V_{n}\left(c_{n}\left(B_{n}(x)\right)\right)$ is at most a singleton. Moreover, $\bigcap_{n \geq k} V_{n}\left(c_{n}\left(B_{n}(x)\right)\right)$ is an increasing sequence of sets for the inclusion. Therefore,

$$
\bigcup_{k \geq 1} \bigcap_{n \geq k} V_{n}\left(c_{n}\left(B_{n}(x)\right)\right)
$$

is at most a singleton, and $G(x) \cap F=\{x\}$. It shows that $\xi_{n}$ generates.

### 4.4.2 Convergence

To complete the proof of lemma 1.4 for $M=[0,1]^{d-1} \times \mathbb{T}$, we need to show the convergence of $T_{n}=B_{n}^{-1} S \frac{p_{n}}{q_{n}} B_{n}$. By the Cauchy criterion, it suffices to show that $\sum_{n \geq 0} d_{n}\left(T_{n+1}, T_{n}\right)$ converges. We combine the estimation of $B_{n+1}$ and the assumption of closeness between $p_{n+1} / q_{n+1}$ and $p_{n} / q_{n}$ of lemma 1.4. We recall the lemma [ 9 , p.1812]:

Lemma 4.17. Let $k \in \mathbb{N}$. There is a constant $C(k, d)$ such that, for any $h \in \operatorname{Diff}(\mathbb{T} \times$ $\left.[0,1]^{d-1}\right), \alpha_{1}, \alpha_{2} \in \mathbb{R}$, we have:

$$
d_{k}\left(h S_{\alpha_{1}} h^{-1}, h S_{\alpha_{2}} h^{-1}\right) \leq C(k, d)\|h\|_{k+1}^{k+1}\left|\alpha_{1}-\alpha_{2}\right|
$$

Since $T_{n}$ and $T_{n+1}$ are $\left(z, x_{1}, \ldots, x_{t_{n+1}}\right)$-transformations and $\left(z, x_{1}, \ldots, x_{t_{n+1}}\right)$-dependent, they can be seen as diffeomorphisms of $\mathbb{T} \times[0,1]^{t_{n+1}-1}$. Moreover, $T_{n}=B_{n}^{-1} S_{\frac{p n}{q n}} B_{n}=$ $B_{n+1}^{-1} S \frac{p_{n}}{q_{n}} B_{n+1}$. Therefore, we obtain, for a fixed sequence $R_{7}\left(n, b_{n+1}, q_{n}, t_{n+1}\right)$ (that depends on $n$ and on the dimension $d$ ):

$$
\begin{aligned}
& d_{n}\left(T_{n+1}, T_{n}\right)=d_{n}\left(B_{n+1}^{-1} S_{\frac{p_{n+1}}{q_{n+1}}} B_{n+1}, B_{n+1}^{-1} S_{\frac{p_{n}}{q_{n}}} B_{n+1}\right) \leq C\left(n+1, t_{n+1}\right)\left\|B_{n+1}\right\|_{n+1}^{n+1}\left|\frac{p_{n+1}}{q_{n+1}}-\frac{p_{n}}{q_{n}}\right| \\
& \leq R_{7}\left(n, b_{n+1}, q_{n}, t_{n+1}\right)\left|\frac{p_{n+1}}{q_{n+1}}-\frac{p_{n}}{q_{n}}\right|
\end{aligned}
$$

For some choice of the sequence $R_{1}\left(n, b_{n+1}, q_{n}, t_{n+1}\right)$ in lemma 1.4, this last estimate guarantees the convergence of $T_{n}$ in the smooth topology.
