# SEMI-CLASSICAL PROPERTIES OF BEREZIN-TOEPLITZ OPERATORS WITH $\mathscr{C}^{k}$ - SYMBOL

#### Abstract

We obtain the semi-classical expansion of the kernels and traces of Toeplitz operators with $\mathscr{C}^{k}$-symbol on a symplectic manifold. We also give a semi-classical estimate of the distance of a Toeplitz operator to the space of self-adjoint and multiplication operators.

## 0. Introduction

The purpose of this paper is to extend some of the semiclassical results about the Berezin-Toeplitz quantization to the case of Toeplitz operators with $\mathscr{C}^{k}$-symbol.

A fundamental problem in mathematical physics is to find relations between classical and quantum mechanics. On one side we have symplectic manifolds and Poisson algebras, on the other Hilbert spaces and selfadjoint operators. The goal is to establish a dictionary between these theories such that given a quantum system depending on a parameter, to obtain a classical system when the parameter approaches a so called semiclassical limit, in such a way that properties of the quantum system are controlled up to first order by the underlying classical system. It is very interesting to go the other way, namely to quantize a classical system, that is, introduce a quantum system whose semiclassical limit is the given classical system.

The aim of the geometric quantization theory of Kostant and Souriau is to relate the classical observables (smooth functions) on a phase space (a symplectic manifold) to the

[^0]quantum observables (bounded linear operators) on the quantum space (holomorphic sections of a line bundle). Berezin-Toeplitz quantization is a particularly efficient version of the geometric quantization theory [1, 2, 6, 10, 12, 13, 22]. Toeplitz operators and more generally Toeplitz structures were introduced in geometric quantization by Berezin [2] and Boutet de Monvel-Guillemin [5]. Using the analysis of Toeplitz structures [5], Bordemann-Meinrenken-Schlichenmaier [3] and Schlichenmaier [20] proved the existence of the asymptotic expansion for the composition of Toeplitz operators in the Kähler case when we twist a trivial bundle $E=\mathbb{C}$.

In $[15,16]$ Ma-Marinescu have extended the Berezin-Toeplitz quantization to symplectic manifolds and orbifolds by using as quantum space the kernel of the Dirac operator acting on powers of the quantum line bundle twisted with an arbitrary vector bundle. In [18] Ma-Marinescu calculated the first coefficients of the kernel expansions of Toeplitz operators and of their composition.

Let us review shortly the results from [15, 16, 17]. We consider a compact symplectic manifold $X$ with symplectic form $\omega$ and a Hermitian line bundle ( $L, h^{L}, \nabla^{L}$ ) whose curvature satisfies the prequantization condition $\frac{\sqrt{-1}}{2 \pi} R^{L}=\omega$. Let $\left(E, h^{E}, \nabla^{E}\right)$ be a Hermitian vector bundle on $X$ with Hermitian connection $\nabla^{E}$. Let $J$ be a $\omega$-compatible almost-complex structure and $g^{T X}$ be a $J$-invariant metric on $T X$. For any $p \in \mathbb{N}$ let $L^{p}:=L^{\otimes p}$ be the $p^{\text {th }}$ tensor power of $L, \Omega^{0, \bullet}\left(X, L^{p} \otimes E\right)$ be the space of smooth antiholomorphic forms with values in $L^{p} \otimes E$ with norm induced by $h^{L}, h^{E}$ and $g^{T X}$, and $P_{p}: \Omega^{0,} \bullet\left(X, L^{p} \otimes E\right) \rightarrow \operatorname{Ker}\left(D_{p}\right)$ be the orthogonal projection on the kernel of the Dirac operator $D_{p}$.

To any $f \in \mathscr{C}^{\infty}(X, \operatorname{End}(E))$ we associate a sequence of linear operators

$$
\begin{equation*}
T_{f, p}: \Omega^{0, \bullet}\left(X, L^{p} \otimes E\right) \rightarrow \Omega^{0, \bullet}\left(X, L^{p} \otimes E\right), \quad T_{f, p}=P_{p} f P_{p} \tag{0.1}
\end{equation*}
$$

where for simplicity we denote by $f$ the operator of multiplication with $f$. For any $f, g \in \mathscr{C}{ }^{\infty}(X, \operatorname{End}(E))$, the product $T_{f, p} T_{g, p}$ has an asymptotic expansion

$$
\begin{equation*}
T_{f, p} T_{g, p}=\sum_{k=0}^{\infty} T_{C_{k}(f, g), p} p^{-k}+\mathscr{O}\left(p^{-\infty}\right) \tag{0.2}
\end{equation*}
$$

in the sense of (3.2), where $C_{k}$ are bidifferential operators of order $\leqslant 2 r$, satisfying $C_{0}(f, g)=f g$ and if $f, g \in \mathscr{C}^{\infty}(X), C_{1}(f, g)-C_{1}(g, f)=\sqrt{-1}\{f, g\}$. Here $\{\cdot, \cdot\}$ is the Poisson bracket on ( $X, 2 \pi \omega$ ) (cf. (2.31)). We deduce from (0.2),

$$
\begin{equation*}
\left[T_{f, p}, T_{g, p}\right]=\frac{\sqrt{-1}}{p} T_{\{f, g\}, p}+\mathcal{O}\left(p^{-2}\right) \tag{0.3}
\end{equation*}
$$

Moreover, the norm of the Toeplitz operators allows to recover the sup-norm of the classical observable $f \in \mathscr{C}^{\infty}(X, \operatorname{End}(E))$ :

$$
\begin{equation*}
\lim _{p \rightarrow \infty}\left\|T_{f, p}\right\|=\|f\|_{\infty}:=\sup _{x \in X}|f(x)| \tag{0.4}
\end{equation*}
$$

and $\|\cdot\|$ is the operator norm. Thus the Poisson algebra $\left(\mathscr{C}^{\infty}(X),\{\cdot, \cdot\}\right)$ is approximated by the operator algebras of Toeplitz operators (for $E=\mathbb{C}$ ) in the norm sense as $p \rightarrow \infty$; the role of the Planck constant is played by $\hbar=1 / p$. This is the so-called semi-classical limit process.

All these papers consider the case of a smooth observable. The assumption that the symbol is $\mathscr{C}^{\infty}$ is quite restrictive and analysts studying Toeplitz operators normally do not require this. While most results on Berezin-Toeplitz quantization are for smooth symbols, some progress has been made towards understanding what is happening with
non-smooth symbols, in particular in work of L. Coburn and co-authors (see e.g., [7, 8]). It was remarked recently by Polterovich [19] that it is interesting to study the BerezinToeplitz quantization also for the case of continuous observables. A specific example of a situation where it would be helpful to know how to quantize non-smooth observables is quantization of the universal Teichmüller space in work of A. Sergeev (see, in particular, [21]). We will extend in this paper the relations (0.2), (0.3), (0.4) for $\mathscr{C}^{k}$-symbols $f, g$. Moreover, we consider the question of how far is a Toeplitz operator from being selfadjoint or a multiplication with a function.

In this paper we shall use the kernel calculus of Toeplitz operators developed in [15, $16,17,18$ ] which lends itself very well to handling less regular symbols.

The plan of the paper is as follows. In Section 1 we recall the Bergman kernel expansion [9, 15]. Section 2 is devoted to the kernel expansion of the Toeplitz operators. In Section 3 , we explain the expansion of a product of Toeplitz operators. In Section 4, we study the asymptotics of the norm of Toeplitz operators. Finally, in Section 5 we consider the semi-classical estimates of the distance of a Toeplitz operator to various spaces (self-adjoint operators, constant multiples of the identity, multiplication operators).

## 1. Quantization of symplectic manifolds

We will briefly describe in this Section the study the Toeplitz operators and BerezinToeplitz quantization for symplectic manifolds. For details we refer the reader to [15, 16] and to the surveys [13, 17]. We recall in Section 1.1 the definition of the spin ${ }^{c}$ Dirac operator and formulate the spectral gap property for prequantum line bundles. In Section 1.2 we state the asymptotic expansion of the Bergman kernel.
1.1. Spectral gap of the spin ${ }^{c}$ Dirac operator. We will first show that in the general symplectic case the kernel of the spin ${ }^{c}$ operator is a good substitute for the space of holomorphic sections used in Kähler quantization.

Let $(X, \omega)$ be a compact symplectic manifold, $\operatorname{dim}_{\mathbb{R}} X=2 n$, with compatible almost complex structure $J: T X \rightarrow T X$. Set $T^{(1,0)} X=\left\{u \in T X \otimes_{\mathbb{R}} \mathbb{C}: J u=\sqrt{-1} u\right\}$. Let $g^{T X}$ be a $J$-compatible Riemannian metric. The Riemannian volume form of $g^{T X}$ is denoted by $d v_{X}$.

We do not assume that $g^{T X}(u, v)=\omega(u, J v)$ for $u, v \in T X$. We relate $g^{T X}$ with $\omega$ by means of the skew-adjoint linear map $J: T X \longrightarrow T X$ which satisfies the relation

$$
\begin{equation*}
\omega(u, v)=g^{T X}(\boldsymbol{J} u, v) \quad \text { for } \quad u, v \in T X \tag{1.1}
\end{equation*}
$$

Then $J$ commutes with $\boldsymbol{J}$, and $J=\boldsymbol{J}\left(-\boldsymbol{J}^{2}\right)^{-\frac{1}{2}}$.
Let $\left(L, h^{L}, \nabla^{L}\right)$ be a Hermitian line bundle on $X$, endowed with a Hermitian metric $h^{L}$ and a Hermitian connection $\nabla^{L}$, whose curvature is $R^{L}=\left(\nabla^{L}\right)^{2}$. We assume that the prequantization condition

$$
\begin{equation*}
\omega=\frac{\sqrt{-1}}{2 \pi} R^{L} \tag{1.2}
\end{equation*}
$$

is fulfilled. Let $\left(E, h^{E}, \nabla^{E}\right)$ be a Hermitian vector bundle on $X$ with Hermitian metric $h^{E}$ and Hermitian connection $\nabla^{E}$. We will be concerned with asymptotics in terms of high tensor powers $L^{p} \otimes E$, when $p \rightarrow \infty$, that is, we consider the semi-classical limit $\hbar=1 / p \rightarrow 0$.

Let us denote by

$$
\begin{equation*}
\boldsymbol{E}:=\Lambda^{\bullet}\left(T^{*(0,1)} X\right) \otimes E \tag{1.3}
\end{equation*}
$$

the bundle of anti-holomorphic forms with values in $E$. The metrics $g^{T X}, h^{L}$ and $h^{E}$ induce an $L^{2}$-scalar product on $\Omega^{0,} \bullet\left(X, L^{p} \otimes E\right)=\mathscr{C}^{\infty}\left(X, L^{p} \otimes \boldsymbol{E}\right)$ by

$$
\begin{equation*}
\left\langle s_{1}, s_{2}\right\rangle=\int_{X}\left\langle s_{1}(x), s_{2}(x)\right\rangle_{L^{p} \otimes E} d v_{X}(x) \tag{1.4}
\end{equation*}
$$

whose completion is denoted $\left(L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right),\|\cdot\|_{L^{2}}\right)$.
Let $\nabla^{\text {det }}$ be the connection on $\operatorname{det}\left(T^{(1,0)} X\right)$ induced by the projection of the Levi-Civita connection $\nabla^{T X}$ on $T^{(1,0)} X$. Let us consider the Clifford connection $\nabla^{\text {Cliff }}$ on $\Lambda^{\bullet}\left(T^{*(0,1)} X\right)$ associated to $\nabla^{T X}$ and to the connection $\nabla^{\text {det }}$ on $\operatorname{det}\left(T^{(1,0)} X\right)$ (see e.g. [15, § 1.3]). The connections $\nabla^{L}, \nabla^{E}$ and $\nabla^{\text {Cliff }}$ induce the connection

$$
\nabla_{p}=\nabla^{\text {Cliff }} \otimes \mathrm{Id}+\mathrm{Id} \otimes \nabla^{L^{p} \otimes E} \quad \text { on } \Lambda^{\bullet}\left(T^{*(0,1)} X\right) \otimes L^{p} \otimes E .
$$

The spin ${ }^{c}$ Dirac operator is defined by

$$
\begin{equation*}
D_{p}=\sum_{j=1}^{2 n} \mathbf{c}\left(e_{j}\right) \nabla_{p, e_{j}}: \Omega^{0, \bullet}\left(X, L^{p} \otimes E\right) \longrightarrow \Omega^{0,}\left(X, L^{p} \otimes E\right) \tag{1.5}
\end{equation*}
$$

where $\left\{e_{j}\right\}_{j=1}^{2 n}$ local orthonormal frame of $T X$ and $\mathbf{c}(v)=\sqrt{2}\left(v_{1,0}^{*} \wedge-i_{v_{0,1}}\right)$ is the Clifford action of $v \in T X$. Here we use the decomposition $v=v_{1,0}+v_{0,1}, v_{1,0} \in T^{(1,0)} X$, $v_{0,1} \in T^{(0,1)} X$ and $v_{1,0}^{*} \in T^{*(0,1)} X$ is the dual of $v_{1,0}$.

Remark 1.1. Let us assume for a moment that $(X, J)$ is a complex manifold (i. e. $J$ is integrable) and the bundles $L, E$ are holomorphic and $\nabla^{L}, \nabla^{E}$ are the Chern connections. If $g^{T X}(u, v)=\omega(u, J v)$ for $u, v \in T X$ (thus ( $X, g^{T X}$ ) is Kähler), then

$$
\begin{equation*}
D_{p}=\sqrt{2}\left(\bar{\partial}+\bar{\partial}^{*}\right), \quad \bar{\partial}=\bar{\partial}^{L^{p} \otimes E} \tag{1.6}
\end{equation*}
$$

so $\operatorname{Ker}\left(D_{p}\right)=H^{0}\left(X, L^{p} \otimes E\right)$ for $p \gg 1$. The following result (Theorem 1.2) shows that for a general symplectic manifold $\operatorname{Ker}\left(D_{p}\right)$ has all semi-classical properties of $H^{0}\left(X, L^{p} \otimes E\right)$.

Note that if $(X, J)$ is a complex manifold but $g^{T X}$ is not necessarily associated to $\omega$ by $g^{T X}(u, v)=\omega(u, J v)$, we can still work with the operator $\widetilde{D}_{p}:=\sqrt{2}\left(\bar{\partial}+\bar{\partial}^{*}\right)$ instead of $D_{p}$ (cf. [15, Theorem 1.5.5]), although $\widetilde{D}_{p}$ is only a modified Dirac operator. Theorem 1.2 and the results which follow remain valid for $\widetilde{D}_{p}$, so that, for $p$ large, the quantum space will be $H^{0}\left(X, L^{p} \otimes E\right)\left(=\operatorname{Ker}\left(\widetilde{D}_{p}\right)\right.$ for $\left.p \gg 1\right)$.

Let us return now to our general situation of a compact symplectic manifold $(X, \omega)$, endowed with a $\omega$-compatible almost complex structure $J$ and $J$-compatible Riemannian metric $g^{T X}$. Let

$$
\begin{equation*}
\mu_{0}=\inf \left\{R_{x}^{L}(u, \bar{u}) /|u|_{g^{T X}}^{2}: u \in T_{x}^{1,0} X \backslash\{0\}, x \in X\right\} . \tag{1.7}
\end{equation*}
$$

By (1.2) we have $\mu_{0}>0$.
Theorem 1.2 ([14, Th. 1.1, 2.5], [15, Th. 1.5.5]). There exists $C>0$ such that for any $p \in \mathbb{N}$ and any $s \in \bigoplus_{k>0} \Omega^{0, k}\left(X, L^{p} \otimes E\right)$, we have

$$
\begin{equation*}
\left\|D_{p} s\right\|_{L^{2}}^{2} \geqslant\left(2 \mu_{0} p-C\right)\|s\|_{L^{2}}^{2} . \tag{1.8}
\end{equation*}
$$

Moreover, the spectrum of $D_{p}^{2}$ verifies

$$
\begin{equation*}
\operatorname{Spec}\left(D_{p}^{2}\right) \subset\{0\} \cup\left[2 \mu_{0} p-C,+\infty[.\right. \tag{1.9}
\end{equation*}
$$

The proof of Theorem 1.2 is based on a direct application of the Lichnerowicz formula for $D_{p}^{2}$.

By the Atiyah-Singer index theorem we have for $p \gg 1$,

$$
\begin{equation*}
\operatorname{dim} \operatorname{Ker}\left(D_{p}\right)=\int_{X} \operatorname{Td}\left(T^{(1,0)} X\right) \operatorname{ch}\left(L^{p} \otimes E\right)=\operatorname{rk}(E) \frac{p^{n}}{n!} \int_{X} \omega^{n}+O\left(p^{n-1}\right) \tag{1.10}
\end{equation*}
$$

where Td is the Todd class and ch is the Chern character. Theorem 1.2 shows the forms in $\operatorname{Ker}\left(D_{p}\right)$ concentrate asymptotically in the $L^{2}$ sense on their zero-degree component and (1.10) shows that $\operatorname{dim} \operatorname{Ker}\left(D_{p}\right)$ is a polynomial in $p$ of degree $n$, as in the holomorphic case.
1.2. Off-diagonal asymptotic expansion of Bergman kernel. We recall that a bounded linear operator $T$ on $L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right)$ is called Carleman operator (see e.g. [11]) if there exists a kernel $T(\cdot, \cdot)$ such that $T(x, \cdot) \in L^{2}\left(X,\left(L^{p} \otimes \boldsymbol{E}\right)_{x} \otimes\left(L^{p} \otimes \boldsymbol{E}\right)^{*}\right)$ and

$$
\begin{equation*}
(T S)(x)=\int_{X} T\left(x, x^{\prime}\right) S\left(x^{\prime}\right) d v_{X}\left(x^{\prime}\right), \quad \text { for all } S \in L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right) \tag{1.11}
\end{equation*}
$$

Let us introduce the orthogonal projection

$$
P_{p}: L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right) \longrightarrow \operatorname{Ker}\left(D_{p}\right),
$$

called the Bergman projection in analogy to the Kähler case. It is a Carleman operator whose integral kernel is called Bergman kernel. Set $d_{p}:=\operatorname{dim} \operatorname{Ker}\left(D_{p}\right)$. Let $\left\{S_{i}^{p}\right\}_{i=1}^{d_{p}}$ be any orthonormal basis of $\operatorname{Ker}\left(D_{p}\right)$ with respect to the inner product (1.4). Then

$$
\begin{equation*}
P_{p}\left(x, x^{\prime}\right)=\sum_{i=1}^{d_{p}} S_{i}^{p}(x) \otimes\left(S_{i}^{p}\left(x^{\prime}\right)\right)^{*} \in\left(L^{p} \otimes \boldsymbol{E}\right)_{x} \otimes\left(L^{p} \otimes \boldsymbol{E}\right)_{x^{\prime}}^{*} \tag{1.12}
\end{equation*}
$$

The Toeplitz operator with symbol $f \in L^{\infty}(X, \operatorname{End}(E))$ is defined by

$$
\begin{equation*}
T_{f, p}: L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right) \rightarrow L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right), \quad T_{f, p}=P_{p} f P_{p} \tag{1.13}
\end{equation*}
$$

where the action of $f$ is the pointwise multiplication by $f$. The map which associates to $f \in L^{\infty}(X, \operatorname{End}(E))$ the family of bounded operators $\left\{T_{f, p}\right\}_{p}$ on $L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right)$ is called the Berezin-Toeplitz quantization. Note that $T_{f, p}$ is a Carleman operator with smooth integral kernel given by

$$
\begin{equation*}
T_{f, p}\left(x, x^{\prime}\right)=\int_{X} P_{p}\left(x, x^{\prime \prime}\right) f\left(x^{\prime \prime}\right) P_{p}\left(x^{\prime \prime}, x^{\prime}\right) d v_{X}\left(x^{\prime \prime}\right) \tag{1.14}
\end{equation*}
$$

The existence of the spectral gap expressed in Theorem 1.2 allows us to localize the behavior of the Bergman kernel and of the kernel of Toeplitz operators.

Let $a^{X}$ be the injectivity radius of ( $X, g^{T X}$ ). We denote by $B(x, \varepsilon)=B^{X}(x, \varepsilon)$ and $B(0, \varepsilon)=B^{T_{x} X}(0, \varepsilon)$ the open balls in $X$ and $T_{x} X$ with center $x$ and radius $\varepsilon$, respectively. Then the exponential map $T_{x} X \ni Z \rightarrow \exp _{x}^{X}(Z) \in X$ is a diffeomorphism from $B^{T_{x} X}(0, \varepsilon)$ onto $B^{X}(x, \varepsilon)$ for $\varepsilon \leqslant a^{X}$. From now on, we identify $B^{T_{x} X}(0, \varepsilon)$ with $B^{X}(x, \varepsilon)$ via the exponential map for $\varepsilon \leqslant a^{X}$. Throughout what follows, $\varepsilon$ runs in the fixed interval ]0, $a^{X} / 4[$.
By [9, Proposition 4.1], we have the far off-diagonal behavior of the Bergman kernel:
Proposition 1.3. For any $\ell, m \in \mathbb{N}$ and $\varepsilon>0$, there exists $C_{\ell, m, \varepsilon}>0$ such that for any $p \geqslant 1, x, x^{\prime} \in X, d\left(x, x^{\prime}\right)>\varepsilon$,

$$
\begin{equation*}
\left|P_{p}\left(x, x^{\prime}\right)\right|_{\mathscr{C}^{m}(X \times X)} \leqslant C_{\ell, m, \varepsilon} p^{-l} \tag{1.15}
\end{equation*}
$$

The $\mathscr{C}^{m}$ norm (1.15) is induced by $\nabla^{L}, \nabla^{E}, h^{L}, h^{E}$ and $g^{T X}$.
Let $\pi: T X \times_{X} T X \rightarrow X$ be the natural projection from the fiberwise product of $T X$ on $X$. Let $\nabla^{\operatorname{End}(\boldsymbol{E})}$ be the connection on $\operatorname{End}\left(\Lambda\left(T^{*(0,1)} X\right) \otimes E\right)$ induced by $\nabla^{\text {Cliff }}$ and $\nabla^{E}$.

Let us elaborate on the identifications we use in the sequel. Let $x_{0} \in X$ be fixed and consider the diffeomorphism $B^{T_{x_{0}} X}(0,4 \varepsilon) \ni Z \mapsto \exp _{x_{0}}^{X}(Z) \in B^{X}\left(x_{0}, 4 \varepsilon\right)$ for $\varepsilon \leqslant a^{X} / 4$. We denote the pull-back of the vector bundles $L, E$ and $L^{p} \otimes \boldsymbol{E}$ via this diffeomorphism by the same symbols.
(i) There exist trivializations of $L, E$ and $L^{p} \otimes \boldsymbol{E}$ over $B^{T_{x_{0}} X}(0,4 \varepsilon)$ given by unit frames which are parallel with respect to $\nabla^{L}, \nabla^{E}$ and $\nabla^{L^{p} \otimes E}$ along the curves $\gamma_{Z}:[0,1] \rightarrow$ $B^{T_{x_{0}} X}(0,4 \varepsilon)$ defined for every $Z \in B^{T_{x_{0}} X}(0,4 \varepsilon)$ by $\gamma_{Z}(u)=\exp _{x_{0}}^{X}(u Z)$.
(ii) With the previous trivializations, $P_{p}\left(x, x^{\prime}\right)$ induces a smooth section

B^{T_{x_{0}} X}(0,4 \varepsilon) \ni Z, Z^{\prime} \mapsto P_{p, x_{0}}\left(Z, Z^{\prime}\right)
$$

of $\pi^{*}(\operatorname{End}(\boldsymbol{E}))$ over $T X \times_{X} T X$, which depends smoothly on $x_{0}$.
(iii) $\nabla^{\operatorname{End}(\boldsymbol{E})}$ induces naturally a $\mathscr{C}^{m}$-norm with respect to the parameter $x_{0} \in X$.
(iv) By (1.1), $\boldsymbol{J}$ is an element of $\operatorname{End}\left(T^{(1,0)} X\right)$. Consequently, we can diagonalize $\boldsymbol{J}_{x_{0}}$, i.e., choose an orthonormal basis $\left\{w_{j}\right\}_{j=1}^{n}$ of $T_{x_{0}}^{(1,0)} X$ such that

form an orthonormal frame of $T_{x_{0}} X$. The diffeomorphism

induces coordinates on $T_{x_{0}} X$, which we use throughout the paper. In these coordinates we have $e_{j}=\partial / \partial Z_{j}$. The complex coordinates $z=\left(z_{1}, \ldots, z_{n}\right)$ on $T_{x_{0}} X$ are given by $z_{j}=Z_{2 j-1}+\sqrt{-1} Z_{2 j}, j=1, \ldots, n$.
(v) If $d v_{T X}$ is the Riemannian volume form on $\left(T_{x_{0}} X, g^{T_{x_{0}} X}\right)$, there exists a smooth positive function $\kappa_{x_{0}}: T_{x_{0}} X \rightarrow \mathbb{R}, Z \mapsto \kappa_{x_{0}}(Z)$ defined by

d v_{X}(Z)=\kappa_{x_{0}}(Z) d v_{T X}(Z), \quad \kappa_{x_{0}}(0)=1 \tag{1.19}

where the subscript $x_{0}$ of $\kappa_{x_{0}}(Z)$ indicates the base point $x_{0} \in X$. By [15, (4.1.101)] we have

(vi) Let $\Theta_{p}: L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right) \longrightarrow L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right)$ be a sequence of continuous linear operators with smooth kernel $\Theta_{p}(\cdot, \cdot)$ with respect to $d v_{X}$ (e.g. $\Theta_{p}=T_{f, p}$ ). In terms of our basic trivialization, $\Theta_{p}(x, y)$ induces a family of smooth sections $Z, Z^{\prime} \mapsto \Theta_{p, x_{0}}\left(Z, Z^{\prime}\right)$ of $\pi^{*} \operatorname{End}(\boldsymbol{E})$ over $\left\{\left(Z, Z^{\prime}\right) \in T X \times_{X} T X:|Z|,\left|Z^{\prime}\right|<\varepsilon\right\}$, which depends smoothly on $x_{0}$.

We denote by $\left|\Theta_{p, x_{0}}\left(Z, Z^{\prime}\right)\right|_{\mathscr{C}^{m}(X)}$ the $\mathscr{C}^{m}$ norm with respect to the parameter $x_{0} \in X$. We say that

\Theta_{p, x_{0}}\left(Z, Z^{\prime}\right)=\mathcal{O}\left(p^{-\infty}\right), \quad p \rightarrow \infty
$$

if for any $\ell, m \in \mathbb{N}$, there exists $C_{\ell, m}>0$ such that $\left|\Theta_{p, x_{0}}\left(Z, Z^{\prime}\right)\right|_{\mathscr{C}^{m}(X)} \leqslant C_{\ell, m} p^{-\ell}$.

We denote by $\operatorname{det}_{\mathbb{C}}$ for the determinant function on the complex bundle $T^{(1,0)} X$ and set $\left|\boldsymbol{J}_{x_{0}}\right|=\left(-\boldsymbol{J}_{x_{0}}^{2}\right)^{1 / 2}$. Note that

& =\frac{1}{(2 \pi)^{n}} \prod_{i=1}^{n} a_{i}\left(x_{0}\right) \exp \left(-\frac{1}{4} \sum_{i} a_{i}\left(x_{0}\right)\left(\left|z_{i}\right|^{2}+\left|z_{i}^{\prime}\right|^{2}-2 z_{i} \bar{z}_{i}^{\prime}\right)\right) \tag{1.22}
\end{align*}

We recall that $\mathscr{P}_{x_{0}}\left(Z, Z^{\prime}\right)$ is actually the kernel of the orthogonal projection $\mathscr{P}_{x_{0}}$ from $L^{2}\left(\mathbb{R}^{2 n}\right)$ onto the Bargmann-Fock space, see [16, §2]. Especially, $\mathscr{P}_{x_{0}}^{2}=\mathscr{P}_{x_{0}}$ so that

Fix $k \in \mathbb{N}$ and $\left.\varepsilon^{\prime} \in\right] 0, a^{X}\left[\right.$. Let $\left\{Q_{r, x_{0}} \in \operatorname{End}(\boldsymbol{E})_{x_{0}}\left[Z, Z^{\prime}\right]: 0 \leqslant r \leqslant k, x_{0} \in X\right\}$ be a family of polynomials in $Z, Z^{\prime}$, which is smooth with respect to the parameter $x_{0} \in X$. We say that

p^{-n} \Theta_{p, x_{0}}\left(Z, Z^{\prime}\right) \cong \sum_{r=0}^{k}\left(Q_{r, x_{0}} \mathscr{P}_{x_{0}}\right)\left(\sqrt{p} Z, \sqrt{p} Z^{\prime}\right) p^{-r / 2}+\mathcal{O}\left(p^{-(k+1) / 2}\right), \tag{1.24}
\end{equation*}
$$

on $\left\{\left(Z, Z^{\prime}\right) \in T X \times_{X} T X:|Z|,\left|Z^{\prime}\right|<\varepsilon^{\prime}\right\}$ if there exist a decomposition

p^{-n} \Theta_{p, x_{0}}\left(Z, Z^{\prime}\right) \kappa_{x_{0}}^{1 / 2}(Z) \kappa_{x_{0}}^{1 / 2}\left(Z^{\prime}\right)-\sum_{r=0}^{k} & \left(Q_{r, x_{0}} \mathscr{P}_{x_{0}}\right)\left(\sqrt{p} Z, \sqrt{p} Z^{\prime}\right) p^{-r / 2}  \tag{1.25}\\
& =R_{p, k, x_{0}}\left(Z, Z^{\prime}\right)+\mathcal{O}\left(p^{-\infty}\right)
\end{align*}
$$

where $R_{p, k, x_{0}}$ satisfies the following estimate on $\left\{\left(Z, Z^{\prime}\right) \in T X \times_{X} T X:|Z|,\left|Z^{\prime}\right|<\varepsilon^{\prime}\right\}$ : for every $m, m^{\prime} \in \mathbb{N}$ there exist $C_{k, m, m^{\prime}}>0, M>0$ such that for all $p \in \mathbb{N}^{*}$

\left\lvert\, \sup _{|\alpha|+\left|\alpha^{\prime}\right| \leqslant m^{\prime}} \frac{\partial^{\alpha+\alpha^{\prime}}}{\partial Z^{\alpha} \partial Z^{\prime \alpha^{\prime}}}\right. & \left.R_{p, k, x_{0}}\left(Z, Z^{\prime}\right)\right|_{\mathscr{C} m}(X)  \tag{1.26}\\
& \leqslant C_{k, m, m^{\prime}} p^{\left(m^{\prime}-k-1\right) / 2}\left(1+\sqrt{p}|Z|+\sqrt{p}\left|Z^{\prime}\right|\right)^{M} e^{-C_{0} \sqrt{p}\left|Z-Z^{\prime}\right|}
\end{align*}
$$

We consider the orthogonal projection:

By [9, Theorem 4.18'] we have the following off diagonal expansion of the Bergman kernel:

Theorem 1.4. Let $\varepsilon \in] 0, a^{X} / 4[$. There exist a smooth family relative to the parameter $x_{0} \in X$

\left\{J_{r, x_{0}}\left(Z, Z^{\prime}\right) \in \operatorname{End}\left(\boldsymbol{E}_{x_{0}}\right)\left[Z, Z^{\prime}\right]: r \in \mathbb{N}, x_{0} \in X\right\}, \quad \operatorname{deg} J_{r, x_{0}} \leqslant 3 r
$$

of polynomials $J_{r, x_{0}}$ having the same parity as $r$, and whose coefficients are polynomials in $R^{T X}, R^{T^{(1,0)} X}, R^{E}$ (and $R^{L}$ ) and their derivatives of order $\leqslant r-1$ (resp. $\leqslant r$ ) such that

p^{-n} P_{p, x_{0}}\left(Z, Z^{\prime}\right) \cong \sum_{r=0}^{k}\left(J_{r, x_{0}} \mathscr{P}_{x_{0}}\right)\left(\sqrt{p} Z, \sqrt{p} Z^{\prime}\right) p^{-\frac{r}{2}}+\mathcal{O}\left(p^{-\frac{k+1}{2}}\right), \tag{1.28}
\end{equation*}
$$

on the set $\left\{\left(Z, Z^{\prime}\right) \in T X \times_{X} T X:|Z|,\left|Z^{\prime}\right|<2 \varepsilon\right\}$. Moreover $J_{0, x_{0}}\left(Z, Z^{\prime}\right)=I_{\mathbb{C} \otimes E}$.
By taking $Z=Z^{\prime}=0$ in (1.28) we obtain the diagonal expansion of the Bergman kernel. Namely, for any $k \in \mathbb{N}, P_{p}(x, x)$ has an expansion in the $\mathscr{C}^{\infty}$-topology

and by Theorem 1.4 and (1.22), we get

Let us remark that if $g^{T X}(u, v)=\omega(u, J v)$ for $u, v \in T X$, then $a_{i}=2 \pi$, so $\boldsymbol{b}_{0}(x)=I_{\mathbb{C} \otimes E}$.

## 2. Expansion of the kernels and traces of Toeplitz operators

For a smooth symbol $f \in \mathscr{C}^{\infty}(X, \operatorname{End}(E))$ we know by [16, Lemma 4.6], [15, Lemma 7.2.4] that the kernel of the associated Toeplitz operator $T_{f, p}$ as in (1.13) has for any $\ell \in \mathbb{N}$ an expansion on the diagonal in the $\mathscr{C}^{\infty}$-topology,

T_{f, p}(x, x)=\sum_{r=0}^{\ell} \boldsymbol{b}_{r, f}(x) p^{n-r}+\mathscr{O}\left(p^{n-\ell-1}\right), \quad \boldsymbol{b}_{r, f} \in \mathscr{C}^{\infty}(X, \operatorname{End}(\boldsymbol{E})) \tag{2.1}
\end{equation*}
$$

where

$$
\begin{equation*}
\boldsymbol{b}_{0, f}(x)=\boldsymbol{b}_{0}(x) f(x) . \tag{2.2}
\end{equation*}
$$

Note as an aside, that the coefficients $\boldsymbol{b}_{r, f}, r=0,1,2$, were calculated in [18, Theorem 0.1], if $(X, \omega)$ is Kähler and the bundles $L, E$ are holomorphic. In [16, Lemma 4.6] we actually established the off-diagonal expansion of the Toeplitz kernel. We wish to study here the asymptotic behavior of the Toeplitz kernel for a less regular symbol $f$. Let us begin with the analogue of [16, Lemma 4.2].

Lemma 2.1. Let $f \in L^{\infty}(X, \operatorname{End}(E))$. For every $\varepsilon>0$ and every $\ell, m \in \mathbb{N}$, there exists $C_{\ell, m, \varepsilon}>0$ such that

where the $\mathscr{C}^{m}$-norm is induced by $\nabla^{L}, \nabla^{E}$ and $h^{L}, h^{E}, g^{T X}$. Moreover, there exists $C>0$ such that for all $p \geqslant 1$ and all $\left(x, x^{\prime}\right) \in X \times X$ with $d\left(x, x^{\prime}\right) \leqslant \varepsilon$,

\begin{equation*}
\left|T_{f, p}\left(x, x^{\prime}\right)\right|_{\mathscr{C}^{m}(X \times X)} \leqslant C p^{n+\frac{m}{2}} e^{-\frac{1}{2} C_{0} \sqrt{p} d\left(x, x^{\prime}\right)}+O\left(p^{-\infty}\right) . \tag{2.4}
\end{equation*}
$$

Proof. Due to (1.14) and (1.15), (2.3) holds if we replace $T_{f, p}$ by $P_{p}$. Moreover, from (1.28), for any $m \in \mathbb{N}$, there exists $C_{m}>0$ such that

These two facts and formula (1.14) imply (2.3). By Theorem 1.4, for $Z, Z^{\prime} \in T_{x_{0}} X$, $|Z|,\left|Z^{\prime}\right|<\varepsilon$ we have

\left|\sup _{|\alpha|+\left|\alpha^{\prime}\right| \leqslant m} \frac{\partial^{\alpha+\alpha^{\prime}}}{\partial Z^{\alpha} \partial Z^{\prime \alpha^{\prime}}} P_{p, x_{0}}\left(Z, Z^{\prime}\right)\right| \leqslant C p^{n+\frac{m}{2}}\left(1+\sqrt{p}|Z|+\sqrt{p}\left|Z^{\prime}\right|\right)^{M} e^{-C_{0} \sqrt{p}\left|Z-Z^{\prime}\right|}+O\left(p^{-\infty}\right) \tag{2.6}
\end{equation*}
$$

Using (1.14) and (2.6) by taking $x_{0}=x$, we get (2.4).
In order to formulate our results for a family of functions (observables) we consider equicontinuous and uniformly bounded families. The results are of course valid for individual functions, too.

Definition 2.2. We denote by $\nabla^{E}$ the connection on $\left(T^{*} X\right)^{\otimes k} \otimes \operatorname{End}(E)$ induced by the Levi-Civita connection $\nabla^{T X}$ and $\nabla^{E}$. Let $\mathscr{A}^{0} \subset \mathscr{C}^{0}(X, \operatorname{End}(E))$ be a subset which is equicontinuous on $X$, and $\mathscr{A}^{1} \subset \mathscr{C}^{1}(X, \operatorname{End}(E))$ be a subset such that $\nabla^{E} \mathscr{A}^{1} \subset$ $\mathscr{C}^{0}(X, \operatorname{End}(E))$ is uniformly bounded. Let $\mathscr{A}^{2} \subset \mathscr{C}^{2}(X, \operatorname{End}(E))$ be a subset such that $\nabla^{E} \mathscr{A}^{2} \subset \mathscr{C}^{0}(X, \operatorname{End}(E))$ is uniformly bounded, and $\nabla^{E} \nabla^{E} \mathscr{A}^{2} \subset \mathscr{C}^{0}(X, \operatorname{End}(E))$ is equicontinuous on $X$. Let $\mathscr{A}_{\infty}^{k}$ be a subset of $\mathscr{A}^{k}$ (for $k=0,1,2$ ) which is uniformly bounded.
Theorem 2.3. Let $(X, \omega)$ be a compact symplectic manifold, $\left(L, h^{L}, \nabla^{L}\right) \rightarrow X$ a prequantization line bundle, $\left(E, h^{E}, \nabla^{E}\right) \rightarrow X$ be an auxiliary vector bundle. We have as $p \rightarrow \infty$
(2.7) $p^{-n} T_{f, p}(x, x)=f(x) \boldsymbol{b}_{0}(x)+o(1)\left(\|f\|_{\mathscr{C}^{0}}+1\right)$, uniformly for $f \in \mathscr{A}^{0}, x \in X$,
(2.8) $p^{-n} T_{f, p}(x, x)=f(x) \boldsymbol{b}_{0}(x)+O\left(p^{-1 / 2}\right)\left(\|f\|_{\mathscr{C}^{0}}+1\right)$, uniformly for $f \in \mathscr{A}^{1}, x \in X$,
(2.9) $p^{-n} T_{f, p}(x, x)=f(x) \boldsymbol{b}_{0}(x)+\boldsymbol{b}_{1, f}(x) p^{-1}+o\left(p^{-1}\right)\left(\|f\|_{\mathscr{C}^{0}}+1\right)$,
uniformly for $f \in \mathscr{A}^{2}, x \in X$.
In particular, the remainders $o(1), O\left(p^{-1 / 2}\right), o\left(p^{-1}\right)$ do not depend on $f$.
Proof. We start by proving (2.7). Recall that we trivialized $L, E$ by a unit frame over $B^{T_{x} X}(0,4 \varepsilon)$ which is parallel with respect to $\nabla^{L}, \nabla^{E}$ along the geodesics starting in $x$. With this trivialization, the section $f \in \operatorname{End}(E)$ induces a section

B^{T_{x} X}(0,4 \varepsilon) \ni Z \mapsto f_{x}(Z) .
$$

We denote by $\left.f(x) \in \operatorname{End}(E)\right|_{U}$ the endomorphism obtained by parallel transport of $f(x) \in \operatorname{End}\left(E_{x}\right)$ into the neighboring fibers $\operatorname{End}\left(E_{x^{\prime}}\right), x^{\prime} \in U=B(0,4 \varepsilon)$.

Let $\delta>0$ be given. Since $\mathscr{A}^{0}$ is uniformly continuous on $X$, there exists $\varepsilon>0$ such that $B(x, \varepsilon) \subset U$ and for all $x^{\prime} \in B(x, \varepsilon)$ we have $\left|f\left(x^{\prime}\right)-f(x)\right| \leqslant \delta$ for any $f \in \mathscr{A}^{0}$.

By (1.14) and (2.3) we have

\end{equation*}

We write now $f\left(x^{\prime}\right)=f(x)+\left(f\left(x^{\prime}\right)-f(x)\right) \in \operatorname{End}\left(E_{x^{\prime}}\right)$ and split accordingly the last integral in a sum of two integrals. From Theorem 1.4, the first one is

& =p^{2 n} \int_{B(x, \varepsilon)} \sum_{i+j=0}^{1}\left(J_{i, x} \mathscr{P}_{x}\right)\left(0, \sqrt{p} Z^{\prime}\right) f(x)\left(J_{j, x} \mathscr{P}_{x}\right)\left(\sqrt{p} Z^{\prime}, 0\right) d Z^{\prime}+O\left(p^{n-1}\right)\|f\|_{\mathscr{C}}
\end{align*}
$$

Note that $J_{0, x_{0}}=I_{\mathbb{C} \otimes E}$ and $J_{1, x_{0}}\left(0, Z^{\prime}\right)$ is a polynomial on $Z^{\prime}$ with odd degree, thus

& =\int_{\mathbb{R}^{2 n}}\left(J_{0, x} \mathscr{P}_{x}\right)\left(0, Z^{\prime}\right) f(x)\left(J_{1, x} \mathscr{P}_{x}\right)\left(Z^{\prime}, 0\right) d Z^{\prime}=0
\end{align*}
$$

From (1.30), (2.11) and (2.12), we get

\int_{B(x, \varepsilon)} & P_{p}\left(x, x^{\prime}\right) f(x) P_{p}\left(x^{\prime}, x\right) d v_{X}\left(x^{\prime}\right)=f(x) \mathscr{P}_{x}(0,0) p^{n}+O\left(p^{n-1}\right)\|f\|_{\mathscr{C}_{0}}  \tag{2.13}\\
& =f(x) \boldsymbol{b}_{0}(x) p^{n}+O\left(p^{n-1}\right)\|f\|_{\mathscr{C}_{0}}
\end{align*}
$$

Note that if $f$ is a function, then we have

& =\delta \int_{B(0, \varepsilon)}\left|P_{p, x}\left(0, Z^{\prime}\right)\right|\left|P_{p, x}\left(Z^{\prime}, 0\right)\right| d v_{X}\left(Z^{\prime}\right)
\end{aligned}
\end{align*}
$$

We use now the off-diagonal expansion from Theorem 1.4. By (1.28) we have

\end{align*}

so in order to estimate the last integral in (2.14), by (1.19), we have to estimate

By using the change of variables $\sqrt{p} Z^{\prime}=Y$ we see that

By Taylor's formula, there exist $C>0, \varepsilon>0$, such that for $|Z| \leqslant \varepsilon, f \in \mathscr{A}^{1}$, we have

Finally, for any $\delta>0$ there exists $\varepsilon>0$, such that for $|Z| \leqslant \varepsilon, f \in \mathscr{A}^{2}$,

Taking into account the proof of the asymptotic expansion (2.1) from [16, Lemma 4.6], we see that (2.9) holds.

Remark 2.4. In the same vein, we show that in the conditions of Theorem 2.3, we have for $f \in \mathscr{C}^{k}(X, \operatorname{End}(E)), k \in \mathbb{N}$, as $p \rightarrow \infty$,

where $\boldsymbol{b}_{r, f}$ are the universal coefficients from (2.1) and

Here $\lfloor a\rfloor$ denotes the integer part of $a \in \mathbb{R}$.
We recall that by $[16,(4.79)]$, $[15,(7.4 .6)]$, for any $f, g \in \mathscr{C}^{\infty}(X, \operatorname{End}(E))$, the kernel of the composition $T_{f, p} \circ T_{g, p}$ has for all $\ell \in \mathbb{N}$ an asymptotic expansion on the diagonal in the $\mathscr{C}^{\infty}$-topology,

The coefficients $\boldsymbol{b}_{r, f, g}, r=0,1,2$, were calculated in [18, Theorem 0.2] in the case of a Kähler manifold $(X, \omega)$ and of holomorphic bundles $L$ and $E$. We give here the analogue of the expansion (2.21) in the case of $\mathscr{C}^{k}$ symbols.

Theorem 2.5. Let $m \in \mathbb{N}$ and $f_{1}, \ldots, f_{m} \in L^{\infty}(X, \operatorname{End}(E))$. Write

& R_{p}(x)=O\left(p^{-1}\right), \text { uniformly on } f_{i} \in \mathscr{A}_{\infty}^{2} \tag{2.25}
\end{align*}

Choose $\varepsilon>0$ such that for $x^{\prime} \in B(x, \varepsilon)$ we have $\left|f_{j}\left(x^{\prime}\right)-f_{j}(x)\right| \leqslant \delta, 1 \leqslant j \leqslant m$, where $f_{j}(x) \in \operatorname{End}\left(\boldsymbol{E}_{x^{\prime}}\right)$ is the parallel transport of $f_{j}(x) \in$
$\operatorname{End}\left(\boldsymbol{E}_{x}\right)$ as in the previous proof. By (1.13) we have $T_{f_{1}, p} \ldots T_{f_{m}, p}=P_{p} f_{1} P_{p} f_{2} \ldots P_{p} f_{m} P_{p}$ hence

& =I+O\left(p^{-\infty}\right)
\end{align*}
$$

where

I=\int_{\substack{\mid Z_{i \mid l} \leqslant \varepsilon \\ 1 \leqslant i \leqslant m}} P_{p, x}\left(0, Z_{1}\right) f_{1, x}\left(Z_{1}\right) P_{p, x}\left(Z_{1}, Z_{2}\right) f_{2, x}\left(Z_{2}\right) \ldots f_{m, x}\left(Z_{m}\right) P_{p, x}\left(Z_{m}, 0\right) \prod_{i=1}^{m} d v_{X}\left(Z_{i}\right)

We write now

&=f_{1}(x) \ldots f_{m}(x)\left(\mathscr{P}_{x}(0,0) p^{n}+O\left(p^{n-1}\right)\right)
\end{align*}

in the above second equation, we use the argument in (2.12), and for $1 \leqslant j \leqslant m$,

& P_{p}\left(Z_{j}, Z_{j+1}\right) f_{j+1, x}\left(Z_{j+1}\right) \ldots f_{m, x}\left(Z_{m}\right) P_{p}\left(Z_{m}, 0\right) \prod_{i=1}^{m} d v_{X}\left(Z_{i}\right)
\end{aligned}

By (1.28), for $\leqslant j \leqslant m$, we have

A_{p}=p^{(m-1) n} \prod_{i=1}^{m-1}\left(1+\sqrt{p}\left|Z_{i}\right|+\sqrt{p}\left|Z_{i+1}\right|\right)^{M} e^{-C_{0} \sqrt{p}\left|Z_{i}-Z_{i+1}\right|}

We plug now the expansion (2.15) for $P_{p}\left(0, Z_{1}\right)$ and $P_{p}\left(Z_{m}, 0\right)$ in (2.28) and estimate the exponential terms appearing there. By (1.7), we have

we pair further $e^{-\frac{C_{3}}{2} \sqrt{p}\left|Z_{3}\right|}$ with $e^{-C_{0} \sqrt{p}\left|Z_{3}-Z_{4}\right|}$ and so on. Finally, we obtain for the lefthand side of (2.28) the estimate

& \leqslant \int_{\substack{\left|Z_{i}\right| \leqslant \varepsilon \\
1 \leqslant i \leqslant m}} e^{-\frac{\pi}{4} p\left|Z_{1}\right|^{2}-C_{2} \sqrt{p}\left|Z_{2}\right| \ldots-C_{m-1} \sqrt{\bar{p}}\left|Z_{m-1}\right|-\frac{\pi}{2} p\left|Z_{m}\right|^{2}} p^{2 n} B_{p} \prod_{i=1}^{m} d Z_{i} \tag{2.29}
\end{align*}
$$

where

B_{p}=p^{(m-1) n}\left(1+\sqrt{p}\left|Z_{1}\right|\right)^{M}\left(1+\sqrt{p}\left|Z_{m}\right|\right)^{M} \prod_{i=1}^{m-1}\left(1+\sqrt{p}\left|Z_{i}\right|+\sqrt{p}\left|Z_{i+1}\right|\right)^{M}
$$

Since the right-hand side integral in (2.29) converges we obtain that $\left|I_{j}\right| \leqslant C^{\prime} \delta p^{n}$, for some $C^{\prime}>0$. This completes the proof of (2.23).

To prove (2.24) and (2.25) we repeat the proof above by estimating $f_{j, x}\left(Z_{j}\right)-f_{j, x}(0)$ with the help of Taylor formulas (2.17) and (2.18). As in the proof of Theorem 2.3 we obtain the remainders $O\left(p^{-1 / 2}\right)$ and $O\left(p^{-1}\right)$, respectively, due to the change of variables $\sqrt{p} Z=Y$.
Remark 2.6. In the same vein, we show that if $f, g \in \mathscr{C}^{k}(X, \operatorname{End}(E)), k \in \mathbb{N}$, we have as $p \rightarrow \infty$,

\end{equation*}

where $\boldsymbol{b}_{r, f, g}$ are the universal coefficients from (2.21) and

R_{k, p}= \begin{cases}o\left(p^{-k / 2}\right), & \text { for } k \text { even } \\ O\left(p^{-k / 2}\right), & \text { for } k \text { odd }\end{cases}
$$

We will now consider traces of Toeplitz operators.
Theorem 2.7. Let $f \in L^{\infty}(X, \operatorname{End}(E))$. Then for any $k \in \mathbb{N}$ we have as $p \rightarrow \infty$,

\end{equation*}

Proof. By (1.29), we infer

Theorem 2.8. Let $f_{1}, \ldots, f_{m} \in L^{\infty}(X, \operatorname{End}(E))$. Write

Then as $p \rightarrow \infty$,

R_{p}= \begin{cases}o(1), & \text { uniformly on } f_{i} \in \mathscr{A}_{\infty}^{0}  \tag{2.34}\\ O\left(p^{-1 / 2}\right), & \text { uniformly on } f_{i} \in \mathscr{A}_{\infty}^{1} \\ O\left(p^{-1}\right), & \text { uniformly on } f_{i} \in \mathscr{A}_{\infty}^{2}\end{cases}
$$

Proof. We have

When $(X, J, \omega)$ is a compact Kähler manifold, $g^{T X}(\cdot, \cdot)=\omega(\cdot, J \cdot), E=\mathbb{C}$ with the trivial metric, and each $f_{i} \in \mathscr{C}^{\infty}(X)$, then (2.33) appears in [3, p. 292], [4, Th. 4.2] with $R_{p}=O\left(p^{-1}\right)$.

## 3. Expansion of a product of Toeplitz operators

We consider in this section the expansion of the composition of two Toeplitz operators at the operator level. We recall first the situation for Toeplitz operators with smooth symbols. A Toeplitz operator is a sequence $\left\{T_{p}\right\}=\left\{T_{p}\right\}_{p \in \mathbb{N}}$ of linear operators $T_{p}: L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right) \longrightarrow L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right)$ with the properties:
(i) For any $p \in \mathbb{N}$, we have $T_{p}=P_{p} T_{p} P_{p}$.
(ii) There exist a sequence $g_{l} \in \mathscr{C}^{\infty}(X, \operatorname{End}(E))$ such that for all $k \geqslant 0$ there exists $C_{k}>0$ such that for all $p \in \mathbb{N}$, we have

$$
\begin{equation*}
\left\|T_{p}-P_{p}\left(\sum_{l=0}^{k} p^{-l} g_{l}\right) P_{p}\right\| \leqslant C_{k} p^{-k-1} \tag{3.1}
\end{equation*}
$$

where $\|\cdot\|$ denotes the operator norm on the space of bounded operators.
We write symbolically

T_{p}=P_{p}\left(\sum_{l=0}^{\infty} p^{-l} g_{l}\right) P_{p}+\mathcal{O}\left(p^{-\infty}\right) \tag{3.2}
\end{equation*}

Let $f, g \in \mathscr{C}^{\infty}(X, \operatorname{End}(E))$. By [16, Theorem 1.1], the product of the Toeplitz operators $T_{f, p}$ and $T_{g, p}$ is a Toeplitz operator, more precisely, it admits the asymptotic expansion in the sense of (3.2):

where $C_{r}$ are bidifferential operators with smooth coefficients of total degree $2 r$ (cf. [16, Lemma 4.6, (4.80)]). We have $C_{0}(f, g)=f g$ and if $f, g \in \mathscr{C}^{\infty}(X)$,

C_{1}(f, g)-C_{1}(g, f)=\sqrt{-1}\{f, g\} \operatorname{Id}_{E} \tag{3.4}
\end{equation*}

In the case of a Kähler manifold $(X, \omega)$, the operators $C_{0}, C_{1}, C_{2}$ were calculated in [18, Theorem 0.1].

We study now the expansion of the product of two Toeplitz operators with $\mathscr{C}^{k}$ symbols.

Theorem 3.1. Let $k \in \mathbb{N}$ and $f, g \in \mathscr{C}^{k}(X, \operatorname{End}(E))$. Then for $m \in\{0, \ldots,\lfloor k / 2\rfloor\}$ we have

T_{f, p} \circ T_{g, p}=\sum_{r=0}^{m} p^{-r} T_{C_{r}(f, g), p}+R_{m, p} \tag{3.5}
\end{equation*}
$$

where $C_{r}(f, g)$ are the universal coefficients from (3.3) and $R_{m, p}$ satisfies the following estimates:

R_{m, p}= \begin{cases}o\left(p^{-k / 2}\right), & \text { for } m=\lfloor k / 2\rfloor  \tag{3.6}\\ O\left(p^{-m-1}\right), & \text { for } m<\lfloor k / 2\rfloor\end{cases}

in the operator norm sense.
In order to prove this theorem we need to develop some machinery from [16] concerning a criterion for a sequence of operators to be a (generalized) Toeplitz operator. For this purpose we refine the condition from (vi) in Section 1.

Let $\Theta_{p}: L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right) \longrightarrow L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right)$ be a sequence of continuous linear operators with smooth kernel $\Theta_{p}(\cdot, \cdot)$ with respect to $d v_{X}$. Fix $k \in \mathbb{N}$ and $\left.\varepsilon^{\prime} \in\right] 0, a^{X}[$. Let

\left\{Q_{r, x_{0}} \in \operatorname{End}(\boldsymbol{E})_{x_{0}}\left[Z, Z^{\prime}\right]: 0 \leqslant r \leqslant k, x_{0} \in X\right\}
$$

be a family of polynomials in $Z, Z^{\prime}$, such that $Q_{r, x_{0}}$ is of class $\mathscr{C}^{k-r}$ with respect to the parameter $x_{0} \in X$. We say that

p^{-n} \Theta_{p, x_{0}}\left(Z, Z^{\prime}\right) \cong \sum_{r=0}^{k}\left(Q_{r, x_{0}} \mathscr{P}_{x_{0}}\right)\left(\sqrt{p} Z, \sqrt{p} Z^{\prime}\right) p^{-r / 2}+\mathcal{O}\left(p^{-\frac{k+1}{2}}\right) \tag{3.7}
\end{equation*}
$$

on $\left\{\left(Z, Z^{\prime}\right) \in T X \times_{X} T X:|Z|,\left|Z^{\prime}\right|<\varepsilon^{\prime}\right\}$ if there exist a decomposition (1.25) and (1.26) holds for $m=m^{\prime}=0$.

We say that

p^{-n} \Theta_{p, x_{0}}\left(Z, Z^{\prime}\right) \cong \sum_{r=0}^{k}\left(Q_{r, x_{0}} \mathscr{P}_{x_{0}}\right)\left(\sqrt{p} Z, \sqrt{p} Z^{\prime}\right) p^{-r / 2}+\boldsymbol{o}\left(p^{-\frac{k}{2}}\right) \tag{3.8}
\end{equation*}
$$

if there exist a decomposition (1.25) where $R_{p, k, x_{0}}$ satisfies the following estimate: for any $\delta>0$, there exists $\varepsilon>0, C_{k}>0, M>0$ such that for all $\left(Z, Z^{\prime}\right) \in T X \times_{X} T X$ with $|Z|,\left|Z^{\prime}\right|<\varepsilon$ and $p \in \mathbb{N}^{*}$,

\left|R_{p, k, x_{0}}\left(Z, Z^{\prime}\right)\right|_{\mathscr{C}^{0}(X)} \leqslant \delta p^{-k / 2}\left(1+\sqrt{p}|Z|+\sqrt{p}\left|Z^{\prime}\right|\right)^{M} e^{-C_{0} \sqrt{p}\left|Z-Z^{\prime}\right|} \tag{3.9}
\end{equation*}

We have the following analogue of [16, Lemma 4.6].
Lemma 3.2. Let $f \in \mathscr{C}^{k}(X, \operatorname{End}(E))$. There exists a family

(a) $Q_{r, x_{0}}(f)$ are polynomials with the same parity as $r$,
(b) $Q_{r, x_{0}}(f)$ is of class $\mathscr{C}^{k-r}$ with respect to the parameter $x_{0} \in X$,
(c) There exists $\varepsilon \in] 0, a^{X} / 4\left[\right.$ such that for any $m \in\{0,1, \ldots, k\}, x_{0} \in X, Z, Z^{\prime} \in T_{x_{0}} X$, $|Z|,\left|Z^{\prime}\right|<\varepsilon / 2$, we have

\begin{equation*}
p^{-n} T_{f, p, x_{0}}\left(Z, Z^{\prime}\right) \cong \sum_{r=0}^{m}\left(Q_{r, x_{0}}(f) \mathscr{P}_{x_{0}}\right)\left(\sqrt{p} Z, \sqrt{p} Z^{\prime}\right) p^{-\frac{r}{2}}+\mathcal{R}_{m, p}, \tag{3.10}
\end{equation*}
$$

where

$$
\mathcal{R}_{m, p}= \begin{cases}\mathcal{O}\left(p^{-\frac{m+1}{2}}\right), & \text { if } m \leqslant k-1, \\ \boldsymbol{o}\left(p^{-\frac{m}{2}}\right), & \text { if } m=k .\end{cases}
$$

in the sense of (3.7) and (3.8). The coefficients $Q_{r, x_{0}}(f)$ are expressed by

Q_{r, x_{0}}(f)=\sum_{r_{1}+r_{2}+|\alpha|=r} \mathscr{K}\left[J_{r_{1}, x_{0}}, \frac{\partial^{\alpha} f_{x_{0}}}{\partial Z^{\alpha}}(0) \frac{Z^{\alpha}}{\alpha!} J_{r_{2}, x_{0}}\right] . \tag{3.11}
\end{equation*}

Especially,

Q_{0, x_{0}}(f)=f\left(x_{0}\right) I_{\mathbb{C} \otimes E} \tag{3.12}
\end{equation*}
$$

Proof. We just have to modify the proof of [16, Lemma 4.6] in what concerns the Taylor formula for $f_{x_{0}}$ :

f_{x_{0}}(Z)=\sum_{|\alpha| \leqslant m} p^{-|\alpha| / 2} \frac{\partial^{\alpha} f_{x_{0}}}{\partial Z^{\alpha}}(0) \frac{(\sqrt{p} Z)^{\alpha}}{\alpha!}+\mathscr{R}_{m, p}(Z) \tag{3.13}
\end{equation*}

where

\mathscr{R}_{m, p}(Z)= \begin{cases}p^{-\frac{m+1}{2}} O\left(|\sqrt{p} Z|^{m+1}\right), & \text { if } m \leqslant k-1 \\ o\left(p^{-\frac{m}{2}}\right) O\left(|\sqrt{p} Z|^{m}\right), & \text { if } m=k\end{cases}

The last line just means that there exists $C>0$ such that for any $\delta>0$, there exists $\varepsilon>0$ such that for all $|Z| \leqslant \varepsilon$ and all $p \in \mathbb{N}$, we have $\left|\mathscr{R}_{m, p}(Z)\right| \leqslant C \delta p^{-\frac{m}{2}}|\sqrt{p} Z|^{m}$.
Lemma 3.3. Let $\mathscr{T}_{p}: L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right) \longrightarrow L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right)$ be a sequence of continuous linear operators with smooth kernel $\mathscr{T}_{p}(\cdot, \cdot)$ with respect to $d v_{X}$. Assume that in the sense of (3.8),

Then there exists $C>0$ such that for every $\delta>0$, there exists $p_{0}$ such that for every $p>p_{0}$ and $s \in L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right)$ we have

We split then the inner integrals into integrals over $B^{X}\left(x, \varepsilon^{\prime}\right)$ and $X \backslash B^{X}\left(x, \varepsilon^{\prime}\right)$ and use the fact that the kernel of $\mathscr{T}_{p}$ has the growth $\mathcal{O}\left(p^{-\infty}\right)$ outside the diagonal. By (3.14), there exists $C^{\prime}>0$ such that for every $\delta>0$, there exists $p_{0}$ such that for every $p>p_{0}$ and $x \in X$,

& =O(1) \delta+O\left(p^{-\infty}\right), \\
\int_{X}\left|\mathscr{T}_{p}(x, y)\right| d v_{X}(y) & \leqslant C \delta
\end{align*}
$$

Combining (3.16) and (3.17) and Fubini's theorem we obtain

& =C \delta \int_{X}\left(\int_{X}\left|\mathscr{T}_{p}(x, y)\right| d v_{X}(x)\right)|s(y)|^{2} d v_{X}(y)  \tag{3.18}\\
& \leqslant(C \delta)^{2} \int_{X}|s(y)|^{2} d v_{X}(y) .
\end{align*}
$$

This proves the first estimate of (3.15). The second one follows by taking the adjoint. The proof of Lemma 3.3 is completed.

Proof of Theorem 3.1. Firstly, it is obvious that $P_{p} T_{f, p} T_{g, p} P_{p}=T_{f, p} T_{g, p}$. Lemmas 2.1 and 3.2 imply that for $Z, Z^{\prime} \in T_{x_{0}} X,|Z|,\left|Z^{\prime}\right|<\varepsilon / 4$ :

+\mathscr{O}\left(p^{-\infty}\right) .
\end{array}
$$

Case $k=0$. By (3.19), we deduce as in the proof of Lemma 3.2, that for $Z, Z^{\prime} \in T_{x_{0}} X$, $|Z|,\left|Z^{\prime}\right|<\varepsilon / 4$, we have

Q_{0, x_{0}}(f, g)=\mathscr{K}\left[Q_{0, x_{0}}(f), Q_{0, x_{0}}(g)\right]=f\left(x_{0}\right) g\left(x_{0}\right) . \tag{3.21}

We conclude by Lemma 3.3 that $T_{f, p} T_{g, p}-T_{f g, p}=o(1)$, as $p \rightarrow \infty$.
Case $k=1$. By (3.19) and the Taylor formula (3.13) for $m=k=1$ we deduce as in the proof of Lemma 3.2 an estimate analogous to (3.20) with $\boldsymbol{o}(1)$ replaced by $\boldsymbol{o}\left(p^{-1 / 2}\right)$, so we obtain $T_{f, p} T_{g, p}-T_{f g, p}=o\left(p^{-1 / 2}\right)$, as $p \rightarrow \infty$.

Case $k \geqslant 2$. We obtain now that for $Z, Z^{\prime} \in T_{x_{0}} X,|Z|,\left|Z^{\prime}\right|<\varepsilon / 4$ and every for every $m \in\{0,1, \ldots, k\}$ we have

p^{-n}\left(T_{f, p} T_{g, p}\right)_{x_{0}}\left(Z, Z^{\prime}\right) \cong \sum_{r=0}^{m}\left(Q_{r, x_{0}}(f, g) \mathscr{P}_{x_{0}}\right)\left(\sqrt{p} Z, \sqrt{p} Z^{\prime}\right) p^{-\frac{r}{2}}+\mathcal{R}_{m, p} \tag{3.22}
\end{equation*}
$$

where

\mathcal{R}_{m, p}= \begin{cases}\mathcal{O}\left(p^{-\frac{m+1}{2}}\right), & \text { if } m \leqslant k-1 \\ \boldsymbol{o}\left(p^{-\frac{m}{2}}\right), & \text { if } m=k\end{cases}
$$

in the sense of (3.7) and (3.8).
Note that for $f, g \in \mathscr{C}^{\infty}(X, \operatorname{End}(E))$, by Lemma 3.2 and (3.3), we know that

As $C_{r}$ are bidifferential operators with smooth coefficients of total degree $2 r$ defined in (3.3), thus for $f, g \in \mathscr{C}^{k}(X, \operatorname{End}(E))$, (3.23) still holds for $l \leqslant k$. Lemma 3.3 and (3.23) implies that Theorem 3.1 holds.

Corollary 3.4. Let $f, g \in \mathscr{C}^{k}(X, \operatorname{End}(E)), k \in \mathbb{N}$. Then as $p \rightarrow \infty$, in the operator norm sense, we have

$$

By (3.4) and (3.25), we get
Corollary 3.5. Let $f, g \in \mathscr{C}^{2}(X)$. Then the commutator of the operators $T_{f, p}, T_{g, p}$ satisfies

where $\{\cdot, \cdot\}$ is the Poisson bracket on $(X, 2 \pi \omega)$ and $R_{p}$ satisfies the estimates from (3.25).
The Poisson bracket $\{\cdot, \cdot\}$ on $(X, 2 \pi \omega)$ is defined as follows. For $f, g \in \mathscr{C}^{2}(X)$, let $\xi_{f}$ be the Hamiltonian vector field generated by $f$, which is defined by $2 \pi i_{\xi_{f}} \omega=d f$. Then $\{f, g\}:=\xi_{f}(d g)$.

## 4. Asymptotics of the norm of Toeplitz operators

For $f \in L^{\infty}(X, \operatorname{End}(E))$ we denote the essential supremum of $f$ by

$$
\|f\|_{\infty}=\operatorname{ess} \sup _{x \in X}|f(x)|_{\operatorname{End}(E)} .
$$

Note that the operator norm $\left\|T_{f, p}\right\|$ of $T_{f, p}$ satisfies

\left\|T_{f, p}\right\| \leqslant\|f\|_{\infty} \tag{4.1}
\end{equation*}
$$

Theorem 4.1. Let $(X, \omega)$ be a compact symplectic manifold and let $\left(L, h^{L}, \nabla^{L}\right) \rightarrow X$ be a prequantum Hermitian line bundle satisfying (1.2). Let $\left(E, h^{E}, \nabla^{E}\right) \rightarrow X$ be a twisting Hermitian vector bundle. Let $f \in L^{\infty}(X, \operatorname{End}(E))$ and assume that there exists $x_{0} \in X$ such that $\|f\|_{\infty}=\left|f\left(x_{0}\right)\right|_{\operatorname{End}(E)}$ and $f$ is continuous in $x_{0}$. Then the norm of $T_{f, p}$ satisfies

$$
\begin{equation*}
\lim _{p \rightarrow \infty}\left\|T_{f, p}\right\|=\|f\|_{\infty} \tag{4.2}
\end{equation*}
$$

Proof. By hypothesis there exist $x_{0} \in X$ and $u_{0} \in E_{x_{0}}$, with $\left|u_{0}\right|_{h^{E}}=1$, such that $\left|f\left(x_{0}\right)\left(u_{0}\right)\right|=\|f\|_{\infty}$. Let us trivialize the bundles $L, E$ in normal coordinates over a neighborhood $U$ of $x_{0}$, and let $e_{L}$ be the unit frame of $L$ which trivialize $L$. In these normal coordinates, we take the parallel transport of $u_{0}$ and obtain a nowhere vanishing section $e_{E}$ of $E$ over $U$. Denote by $\left.f\left(x_{0}\right) \in \operatorname{End}(E)\right|_{U}$ the endomorphism obtained by parallel transport of $f\left(x_{0}\right) \in \operatorname{End}\left(E_{x_{0}}\right)$.

Let $\delta>0$ be fixed. Since $f$ is continuous, there exists $\varepsilon>0$ such that for all $x \in$ $B\left(x_{0}, 2 \varepsilon\right), u \in E_{x}$, with $|u|_{h^{E}}=1$, we have

\begin{equation*}
\left|f(x) u-f\left(x_{0}\right) u\right| \leqslant \delta \tag{4.3}
\end{equation*}
$$

Let

$$
\rho \in \mathscr{C}^{\infty}(X), \operatorname{supp} \rho \subset B\left(x_{0}, \varepsilon\right), \rho=1 \text { on } B\left(x_{0}, \varepsilon / 2\right) .
$$

Define sections

$$
\begin{equation*}
S^{p}=S_{x_{0}, u_{0}}^{p}=2^{-n} p^{\frac{n}{2}} \sqrt{\operatorname{det}\left|J_{x_{0}}\right|} P_{p}\left(\rho e_{L}^{\otimes p} \otimes e_{E}\right) \in \operatorname{Ker}\left(D_{p}\right) . \tag{4.4}
\end{equation*}
$$

Our goal is to prove the following.
Proposition 4.2. There exists $C>0$ (independent of $\delta$ ) such that for $p \gg 1$,

\left\|T_{f, p} S^{p}-\rho f\left(x_{0}\right) S^{p}\right\|_{L^{2}} \leqslant C \delta\left\|S^{p}\right\|_{L^{2}} \tag{4.5}
\end{equation*}
$$

Moreover, for $p \rightarrow \infty$,

\left\|\rho f\left(x_{0}\right) S^{p}\right\|_{L^{2}}=\|f\|_{\infty}+O\left(p^{-\frac{1}{2}}\right) \tag{4.6}
\end{equation*}
$$

We start by showing that $S^{p}$ are peak sections, i. e. satisfies the properties in Lemma 4.3 below. Since $x_{0}$ is fixed let us denote for simplicity $a_{i}=a_{i}\left(x_{0}\right)$ and set

Lemma 4.3. The following expansions hold as $p \rightarrow \infty$,

& +O\left(p^{\frac{n-k-1}{2}} e^{-C_{0} \sqrt{p}|Z|}(1+\sqrt{p}|Z|)^{2 M}\right)+O\left(p^{-\infty}\right), \quad Z \in B(0, \varepsilon / 2)
\end{align*}
$$

for some constants $C_{0}, M>0$ and polynomials $Q_{r}$ with values in $\operatorname{End}\left(\boldsymbol{E}_{x_{0}}\right)$,

$$
\begin{equation*}
S^{p}=O\left(p^{-\infty}\right), \text { uniformly on any compact set } K \text { such that } x_{0} \notin K, \tag{4.8}
\end{equation*}
$$

$$
\begin{equation*}
\left\|S^{p}\right\|_{L^{2}}^{2}=\int_{X}\left|S^{p}\right|^{2} d v_{X}=1+O\left(p^{-1}\right) \tag{4.9}
\end{equation*}
$$

Proof. By (4.4), we have for $x \in X$,

where we have denoted $\widetilde{\kappa}=\rho \kappa_{x_{0}}$. We wish to obtain an expansion of $S^{p}$ in powers of $p$, so we apply Theorem 1.4. By (1.28) (see (1.25)) we have

By (1.20), we write the Taylor expansion of $\varphi\left(Z, Z^{\prime}\right)=\kappa_{x_{0}}^{-\frac{1}{2}}(Z) \kappa_{x_{0}}^{-\frac{1}{2}}\left(Z^{\prime}\right) \widetilde{\kappa}\left(Z^{\prime}\right)$ in the form

& =1+\sum_{1<|\alpha|+|\beta| \leqslant k} p^{-(|\alpha|+|\beta|) / 2} \partial_{Z}^{\alpha} \partial_{Z^{\prime}}^{\beta} \varphi(0,0) \frac{(\sqrt{p} Z)^{\alpha}}{\alpha!} \frac{\left(\sqrt{p} Z^{\prime}\right)^{\beta}}{\beta!}+p^{-(k+1) / 2} O\left(\left|\sqrt{p}\left(Z, Z^{\prime}\right)\right|^{k+1}\right)
\end{align*}
$$

and multiply it with the right-hand side of (4.13). We obtain in this way an expansion in powers of $p^{1 / 2}$ of $P_{p, x_{0}}\left(Z, Z^{\prime}\right) \widetilde{\kappa}\left(Z^{\prime}\right)$ :

for some polynomials $\widetilde{J}_{r, x_{0}} \in \operatorname{End}\left(\boldsymbol{E}_{x_{0}}\right)\left[Z, Z^{\prime}\right], \widetilde{J}_{0, x_{0}}=I_{\mathbb{C} \otimes E}$, and a rest $\widetilde{R}_{p, k}\left(Z, Z^{\prime}\right)$ satisfying appropriate estimates corresponding to (1.26).
We apply now to $P_{p, x_{0}}\left(Z, Z^{\prime}\right)$ the off-diagonal expansion (4.15) and integrate:

The norms $Z \mapsto|Z|$ and $Z \mapsto|Z|_{a}$ are equivalent so by the exponential decay of $\mathscr{P}_{x_{0}}$ we have, as $p \rightarrow \infty$,

& =\left(\operatorname{det}_{\mathbb{C}}\left|\boldsymbol{J}_{x_{0}}\right|\right)^{-1} e^{p|Z|_{a}^{2}} 2^{n} \mathscr{P}_{x_{0}}(\sqrt{2 p} Z, 0) \\
& =2^{n} e^{-p|Z|_{a}^{2}}
\end{aligned}
$$

where the first and third equalities follow from (1.22) and the second from (1.23). We obtain thus

& =\int_{\mathbb{R}^{2 n}} e^{-\sum_{j=1}^{n} \frac{1}{2} p a_{j}\left|Z_{j}\right|^{2}} d Z+O\left(p^{-1}\right)=\prod_{j=1}^{n} \frac{2 \pi}{a_{j}}+O\left(p^{-1}\right) .
\end{align*}
$$

Further

\int_{\mathbb{R}^{2 n}}\left|p^{\frac{n}{2}} e^{-p|Z|_{a}^{2}} Q_{r}(\sqrt{p} Z)\right|^{2} d Z<\infty \tag{4.25}
\end{equation*}

and

\begin{equation*}
\int_{B(0,2 \varepsilon)}\left|p^{\frac{n-k-1}{2}} e^{-C_{0} \sqrt{\bar{p}}|Z|}(1+\sqrt{p}|Z|)^{2 M}\right|^{2} d Z=O\left(p^{-k-1}\right) \tag{4.26}
\end{equation*}

From (4.7)-(4.25) we obtain (4.9). The proof of Lemma 4.3 is completed.

S_{0}^{p} & =\sqrt{\operatorname{det}\left|J_{x_{0}}\right|} p^{\frac{n}{2}} e^{-p|Z|_{a}^{2}} u_{0},  \tag{4.33}\\
I_{2, p}(Z) & =\int_{B(0,2 \varepsilon)} p^{n}\left(J_{0, x_{0}} \mathscr{P}\right)\left(\sqrt{p} Z, \sqrt{p} Z^{\prime}\right) \rho f\left(x_{0}\right)\left(S^{p}-S_{0}^{p}\right)\left(Z^{\prime}\right) d Z^{\prime} .

& +\left(\int_{B(0,2 \varepsilon)}\left|I_{2, p}(Z)\right|^{2} d v_{X}(Z)\right)^{\frac{1}{2}}+\left(\int_{B(0,2 \varepsilon)}\left|\rho f\left(x_{0}\right)\left(S^{p}-S_{0}^{p}\right)(Z)\right|^{2} d v_{X}(Z)\right)^{\frac{1}{2}}  \tag{4.37}\\
& =O\left(p^{-\frac{1}{2}}\right)
\end{align*}
$$

Moreover for $g_{p}$ from (4.31), we get by (4.3) that for $Z \in T_{x_{0}} X,|Z| \leqslant 2 \varepsilon$ we have

& =\left|f\left(x_{0}\right) u_{0}\right|^{2} \int_{B(0, \varepsilon / 2)} p^{n} \operatorname{det}_{\mathbb{C}}\left|J_{x_{0}}\right| e^{-2 p|Z|_{a}^{2}} d Z+O\left(p^{-1}\right) \\
& =\|f\|_{\infty}^{2}+O\left(p^{-1}\right)
\end{align*}
$$

This completes the proof of Proposition 4.2.
Remark 4.7. If we improve the regularity of the section $f$ in Theorem 4.1, the convergence speed in (4.2) improves accordingly (by improving Lemma 4.6):
(a) If $f \in \mathscr{C}^{1}(X, \operatorname{End}(E))$ then there exists $C>0$ such that

\|f\|_{\infty}-\frac{C}{\sqrt{p}} \leqslant\left\|T_{f, p}\right\| \leqslant\|f\|_{\infty}
$$

The estimate does not improve even if $f$ is a function.
(b) Assume that in Theorem 4.1, $(X, J, \omega)$ is Kähler, $\left(L, h^{L}, \nabla^{L}\right) \rightarrow X$ is a prequantum holomorphic Hermitian line bundle (where $\nabla^{L}$ is the Chern connection) satisfying (1.2) and $\left(E, h^{E}, \nabla^{E}\right) \rightarrow X$ is a holomorphic Hermitian vector bundle with the Chern connection $\nabla^{E}$. The Kähler assumption implies that $J_{1}\left(Z, Z^{\prime}\right)=0$ (cf. [15, (4.1.102)]). Using (1.20) and

\int_{\mathbb{C}^{n}} e^{-\pi p \sum_{j=1}^{n} a_{j}\left|Z_{j}\right|^{2}} Z_{j} d Z=0
$$

we deduce that for $f \in \mathscr{C}^{2}(X, \operatorname{End}(E))$ there exists $C>0$ such that

\|f\|_{\infty}-\frac{C}{p} \leqslant\left\|T_{f, p}\right\| \leqslant\|f\|_{\infty} .
$$

For $f \in \mathscr{C}^{1}(X, \operatorname{End}(E))$ we have the same estimate as in (a), which cannot be improved.
Remark 4.8. Theorem 4.1 holds also for large classes of non-compact manifolds, see [15, §7.5], [16, §5], [17, §2.8].

## 5. HOW FAR IS $T_{f, p}$ FROM BEING SELF-ADJOINT OR MULTIPLICATION OPERATOR

In this section we continue to work in the setting of Section 1.1. Let $(X, \omega)$ be a $2 n$-dimensional connected compact symplectic manifold, and $\left(L, h^{L}, \nabla^{L}\right) \rightarrow X$ be a prequantum line bundle satisfying (1.2). We assume in the following that the vector bundle $E$ is trivial of rank one $(E=\mathbb{C})$. To avoid lengthy formulas let us denote

\mathcal{H}_{p}=\operatorname{ker}\left(D_{p}\right) \tag{5.1}
\end{equation*}
$$

Let $\mathscr{C}^{0}(X)$ denote the space of smooth complex-valued functions on $X$. We shall denote by $\mathscr{C}^{0}(X, \mathbb{R})$ the space of smooth real-valued functions on $X$. For $f, g \in \mathscr{C}^{0}(X)$ set

\langle f, g\rangle=\int_{X} f(x) \overline{g(x)} \frac{\omega^{n}}{n!} \tag{5.2}
\end{equation*}

Let $L^{2}(X)$ be the completion of $\mathscr{C}^{0}(X)$ with respect to the norm $\|f\|=\sqrt{\langle f, f\rangle}$ and let $L^{2}(X, \mathbb{R})$ be the subspace of $L^{2}(X)$ that consists of (equivalence classes of) real-valued functions. By a slight abuse of notation, we denote by $\mathbb{C} \subset \mathscr{C}^{0}(X)$ the 1 -dimensional subspace of $\mathscr{C}^{0}(X)$ that consists of constant functions. Note: $L^{2}(X, \mathbb{R})$ and $\mathbb{C}$ are closed subspaces of $L^{2}(X)$. For $f \in L^{2}(X)$ the orthogonal projection of $f$ onto $\mathbb{C}$ (with respect to the inner product $\langle\cdot, \cdot\rangle$ ) is the constant function

$$
\begin{equation*}
f_{X} f \frac{\omega^{n}}{n!}:=\frac{\langle f, 1\rangle}{\langle 1,1\rangle}=\frac{1}{\operatorname{vol}(X)} \int_{X} f \frac{\omega^{n}}{n!} \quad \text { with } \operatorname{vol}(X)=\int_{X} \frac{\omega^{n}}{n!} \tag{5.3}
\end{equation*}
$$

and the orthogonal projection of $f$ onto $L^{2}(X, \mathbb{R})$ (with respect to the inner product $\operatorname{Re}\langle\cdot, \cdot\rangle)$ is $\operatorname{Re}(f)$.

Denote by $(\cdot, \cdot)_{H S}$ the Hilbert-Schmidt inner product on $\operatorname{End}\left(\mathcal{H}_{p}\right)$ : for $A, B \in \operatorname{End}\left(\mathcal{H}_{p}\right)$

$$
(A, B)_{H S}=\operatorname{Tr}\left(A B^{*}\right)
$$

where $B^{*}$ is the adjoint of $B$, and we will use the same notation for Hilbert-Schmidt inner product on $\operatorname{End}\left(L^{2}\left(X, L^{p} \otimes \boldsymbol{E}\right)\right)$. Note that the operator norm does not exceed the Hilbert-Schmidt norm. The inner product on the underlying real vector space $\operatorname{End}_{\mathbb{R}}\left(\mathcal{H}_{p}\right)$ is given by

$$
(A, B)_{\mathbb{R}}=\operatorname{Re} \operatorname{Tr}\left(A B^{*}\right)
$$

Denote by $\operatorname{Herm}\left(\mathcal{H}_{p}\right)$ the subspace of $\operatorname{End}_{\mathbb{R}}\left(\mathcal{H}_{p}\right)$ that consists of self-adjoint (Hermitian) operators. Denote by $\mathbb{C I d}_{\mathcal{H}_{p}}$ the subspace of $\operatorname{End}\left(\mathcal{H}_{p}\right)$ that consists of constant multiples of the identity operator.

We shall use dist $(v, V)$ to denote the distance between an element $v$ of a normed vector space and a closed subspace $V$. For example, for $f \in L^{2}(X)$

$$
\begin{equation*}
\operatorname{dist}(f, \mathbb{C})^{2}=\int_{X}|f|^{2} \frac{\omega^{n}}{n!}-\frac{1}{\operatorname{vol}(X)}\left|\int_{X} f \frac{\omega^{n}}{n!}\right|^{2} \tag{5.4}
\end{equation*}
$$

It is clear that for any $f \in L^{\infty}(X)$ we have

$$
\begin{equation*}
T_{f, p}^{*}=T_{\bar{f}, p}, \tag{5.5}
\end{equation*}
$$

hence for $f \in L^{\infty}(X, \mathbb{R})$ the operator $T_{f, p}$ is self-adjoint. We denote $M_{f}$ the pointwise multiplication by $f$. On the other hand, if $f \in L^{\infty}(X)$ is constant then $T_{f, p}=M_{f}$.

Theorem 5.1, stated below, addresses, informally speaking, the following issues: given $f \in \mathscr{C}^{\infty}(X)$,
(1) how far $f$ is from being real-valued should be related to how far $T_{f, p}$ is from being self-adjoint (in $\operatorname{End}_{\mathbb{R}}\left(\mathcal{H}_{p}\right)$ ),
(2) how far $f$ is from being constant should be related to how far $T_{f, p}$ is from being a constant multiple of the identity operator $\left(\operatorname{in} \operatorname{End}\left(\mathcal{H}_{p}\right)\right)$.
Theorem 5.1. Let $f \in L^{\infty}(X)$. Write

$$
\begin{align*}
p^{-n}\left[\operatorname{dist}\left(T_{f, p}, \operatorname{Herm}\left(\mathcal{H}_{p}\right)\right)\right]^{2} & =\left[\operatorname{dist}\left(f, L^{2}(X, \mathbb{R})\right)\right]^{2}+R_{1, p}, \\
p^{-n}\left[\operatorname{dist}\left(T_{f, p}, \mathbb{C I d}_{\mathcal{H}_{p}}\right)\right]^{2} & =[\operatorname{dist}(f, \mathbb{C})]^{2}+R_{2, p} . \tag{5.6}
\end{align*}
$$

Then $R_{i, p}, i=1,2$, satisfy as $p \rightarrow \infty$

$$
R_{i, p}= \begin{cases}o(1), & \text { uniformly on } f \in \mathscr{A}_{\infty}^{0},  \tag{5.7}\\ O\left(p^{-1 / 2}\right), & \text { uniformly on } f \in \mathscr{A}_{\infty}^{1}, \\ O\left(p^{-1}\right), & \text { uniformly on } f \in \mathscr{A}_{\infty}^{2}\end{cases}
$$

Proof. We consider first the case $i=1$. Let $A \in \operatorname{End}\left(\mathcal{H}_{p}\right)$. The orthogonal projection of $A$ onto $\operatorname{Herm}\left(\mathcal{H}_{p}\right)$ is $\frac{1}{2}\left(A+A^{*}\right)$. We have:

$$
\begin{align*}
{\left[\operatorname{dist}\left(A, \operatorname{Herm}\left(\mathcal{H}_{p}\right)\right)\right]^{2} } & =\left(\frac{1}{2}\left(A-A^{*}\right), \frac{1}{2}\left(A-A^{*}\right)\right)_{\mathbb{R}}=\frac{1}{4} \operatorname{Re} \operatorname{Tr}\left[\left(A-A^{*}\right)\left(A^{*}-A\right)\right]  \tag{5.8}\\
& =\frac{1}{4} \operatorname{Re}\left[-\operatorname{Tr}\left(A^{2}\right)-\operatorname{Tr}\left(\left(A^{*}\right)^{2}\right)+\operatorname{Tr}\left(A A^{*}\right)+\operatorname{Tr}\left(A^{*} A\right)\right]
\end{align*}
$$

We apply the previous formula for $A=T_{f, p}$ by using Theorem 2.8 and (5.5), we get as $p \rightarrow \infty$

$$
\begin{align*}
p^{-n}\left[\operatorname{dist}\left(A, \operatorname{Herm}\left(\mathcal{H}_{p}\right)\right)\right]^{2} & =\frac{1}{4} \operatorname{Re} \int_{X}\left(-f^{2}-\bar{f}^{2}+2 f \bar{f}\right) \frac{\omega^{n}}{n!}+R_{1, p} \\
& =\int_{X}|\operatorname{Im}(f)|^{2} \frac{\omega^{n}}{n!}+R_{1, p}, \tag{5.9}
\end{align*}
$$

where $R_{1, p}$ satisfies (5.7). This proves the assertion of the Theorem for $i=1$, since

$$
\begin{equation*}
\left[\operatorname{dist}\left(f, L^{2}(X, \mathbb{R})\right)\right]^{2}=\int_{X}|f-\operatorname{Re}(f)|^{2} \frac{\omega^{n}}{n!} \tag{5.10}
\end{equation*}
$$

We consider now the case $i=2$. For $A \in \operatorname{End}\left(\mathcal{H}_{p}\right)$ the orthogonal projection of $A$ onto $\mathbb{C I d}_{\mathcal{H}_{p}}$ is $\alpha \operatorname{Id}_{\mathcal{H}_{p}}$, and $\alpha=\frac{1}{\operatorname{dim} \mathcal{H}_{p}} \operatorname{Tr}(A)$. Therefore

$$
\begin{align*}
{\left[\operatorname{dist}\left(A, \mathbb{C I d}_{\mathcal{H}_{p}}\right)\right]^{2} } & =\left(A-\alpha \operatorname{Id}_{\mathcal{H}_{p}}, A-\alpha \operatorname{Id}_{\mathcal{H}_{p}}\right)=\operatorname{Tr}\left[\left(A-\alpha \operatorname{Id}_{\mathcal{H}_{p}}\right)\left(A^{*}-\bar{\alpha} \operatorname{Id}_{\mathcal{H}_{p}}\right)\right] \\
& =\operatorname{Tr}\left(A A^{*}-\alpha A^{*}-\bar{\alpha} A+\alpha \bar{\alpha} \operatorname{Id}_{\mathcal{H}_{p}}\right)  \tag{5.11}\\
& =\operatorname{Tr}\left(A A^{*}\right)-\frac{1}{\operatorname{dim} \mathcal{H}_{p}} \operatorname{Tr}(A) \operatorname{Tr}\left(A^{*}\right),
\end{align*}
$$

since $\operatorname{Tr}\left(\operatorname{Id}_{\mathcal{H}_{p}}\right)=\operatorname{dim} \mathcal{H}_{p}$. Note that by the Atiyah-Singer index formula (1.10), we have

$$
\begin{equation*}
\operatorname{dim} \mathcal{H}_{p}=p^{n} \operatorname{vol}(X)+O\left(p^{n-1}\right) \tag{5.12}
\end{equation*}
$$

We apply formula (5.11) for $A=T_{f, p}$ by using Theorem 2.8, (5.4), (5.5) and (5.12) to get

$$
\begin{align*}
p^{-n}\left[\operatorname{dist}\left(T_{f, p}, \mathbb{C I d}_{\mathcal{H}_{p}}\right)\right]^{2} & =\int_{X}|f|^{2} \frac{\omega^{n}}{n!}-\frac{1}{\operatorname{vol}(X)}\left|\int_{X} f \frac{\omega^{n}}{n!}\right|^{2}+R_{2, p}  \tag{5.13}\\
& =[\operatorname{dist}(f, \mathbb{C})]^{2}+R_{2, p}
\end{align*}
$$

where $R_{2, p}$ satisfies (5.7) as $p \rightarrow \infty$.
It is also intuitively clear that how far $f$ is from being constant (i.e. how far $d f$ is from zero) should be related to how far $T_{f, p}$ is from $M_{f} P_{p}$. This is addressed in the next Proposition. The main point here is to estimate the Hilbert-Schmidt norm of the difference $T_{f, p}-M_{f} P_{p}$ uniformly for $f \in \mathscr{C}^{1}(X)$.
Proposition 5.2. We suppose that $g^{T X}(\cdot, \cdot)=\omega(\cdot, J \cdot)$. Let $\lambda>0$ be the lowest positive eigenvalue of the Laplace operator $\Delta_{g^{T X}}$ acting on functions. Then for any $\varepsilon>0$, there exists $p_{0}>0$ such that for any $p \geqslant p_{0}, f \in \mathscr{C}^{1}(X)$, we have

$$
\begin{equation*}
p^{-n}\left\|T_{f, p}-M_{f} P_{p}\right\|_{H S}^{2} \leqslant \lambda^{-1}(1+\varepsilon)\|d f\|_{L^{2}}^{2} . \tag{5.14}
\end{equation*}
$$

Proof. Denote for simplicity $\Delta=\Delta_{g^{T X}}$. The Hodge decomposition of $f$ has the form $f=f_{1}+f_{2}$, where $f_{1} \in \operatorname{Ker}(\Delta)$ is the harmonic component of $f$ and $f_{2} \in(\operatorname{Ker} \Delta)^{\perp}$. We have $\operatorname{Ker}(\Delta)=\mathbb{C}$ and $f_{1}=f_{X} f d v_{X}$. Moreover,

$$
\begin{equation*}
\left\|f_{2}\right\|_{L^{2}}^{2} \leqslant \lambda^{-1}\left\|d f_{2}\right\|_{L^{2}}^{2}=\lambda^{-1}\|d f\|_{L^{2}}^{2} \tag{5.15}
\end{equation*}
$$

Now

$$
\begin{equation*}
T_{f, p}-M_{f} P_{p}=T_{f_{2}, p}-M_{f_{2}} P_{p} \tag{5.16}
\end{equation*}
$$

As $\operatorname{Tr}\left[T_{f_{2}, p} T_{f_{2}, p}^{*}\right]>0$, we get by using (1.12) and (5.16) that

$$
\begin{align*}
\left\|T_{f, p}-M_{f} P_{p}\right\|_{H S}^{2} & =\operatorname{Tr}\left[T_{f_{2}, p} T_{f_{2}, p}^{*}+f_{2} P_{p} \bar{f}_{2}-T_{f_{2}, p} \bar{f}_{2}-f_{2} P_{p} \bar{f}_{2} P_{p}\right] \\
& =\operatorname{Tr}\left[P_{p} f_{2} \bar{f}_{2} P_{p}-T_{f_{2}, p} T_{f_{2, p}}^{*}\right] \leqslant \operatorname{Tr}\left[P_{p}\left|f_{2}\right|^{2} P_{p}\right]  \tag{5.17}\\
& =\sum_{i=1}^{d_{p}}\left\|f_{2} S_{i}^{P}\right\|_{L^{2}}^{2}=\int_{X}\left|f_{2}(x)\right|^{2} \operatorname{Tr}\left[P_{p}(x, x)\right] d v_{X}(x) .
\end{align*}
$$

By the argument after (1.29), for any $\varepsilon>0$, there exists $p_{0}>0$ such that for $p \geqslant p_{0}$, we have

$$
\begin{equation*}
\int_{X}\left|f_{2}(x)\right|^{2} \operatorname{Tr}\left[P_{p}(x, x)\right] d v_{X}(x) \leqslant(1+\varepsilon) p^{n}\left\|f_{2}\right\|_{L^{2}}^{2} \tag{5.18}
\end{equation*}
$$

By (5.15), (5.17) and (5.18), we get (5.14).
Remark 5.3. The results in this paper hold in particular in the case of the Kähler quantization. Let us assume that that is, if $(X, J)$ is a compact complex manifold and ( $X, g^{T X}$ ) is Kähler (i. e. $J$ is integrable and $g^{T X}(u, v)=\omega(u, J v)$ for $u, v \in T X$ ). Assume moreover that the bundles $L$ and $E$ are holomorphic and $\nabla^{L}, \nabla^{E}$ are the Chern connections. Then by Remark 1.1, the quantum space are the spaces of global holomorphic sections of $L^{p} \otimes E$. We can even dispense of the Kähler condition $g^{T X}(u, v)=\omega(u, J v)$ for $u, v \in T X$, see Remark 1.1.

To illustrate the kind of results we obtain in the Kähler case let us formulate the following special case of of Proposition 5.2.
Proposition 5.4. Assume that $\left(X, J, g^{T X}\right)$ is a compact Kähler manifold and the bundles $L$ and $E$ are holomorphic. Let $\lambda>0$ be the lowest positive eigenvalue of the Kodaira Laplace operator $\bar{\partial}^{*} \bar{\partial}$ acting on functions. Then for any $\varepsilon>0$, there exists $p_{0}>0$ such that for any $p \geqslant p_{0}, f \in \mathscr{C}^{1}(X)$, we have

$$
\begin{equation*}
p^{-n}\left\|T_{f, p}-M_{f} P_{p}\right\|_{H S}^{2} \leqslant \lambda^{-1}(1+\varepsilon)\|\bar{\partial} f\|_{L^{2}}^{2} . \tag{5.19}
\end{equation*}
$$
