# The glassy phase of complex branching Brownian motion

#### Abstract

In this paper, we study complex valued branching Brownian motion in the so-called glassy phase, or also called phase II. In this context, we prove a limit theorem for the complex partition function hence confirming a conjecture formulated by Lacoin and the last two authors in a previous paper on complex Gaussian multiplicative chaos. We will show that the limiting partition function can be expressed as a product of a Gaussian random variable, mainly due to the windings of the phase, and a stable transform of the so called derivative martingale, mainly due to the clustering of the modulus. The proof relies on the fine description of the extremal process available in the branching Brownian motion context.

## 1 Introduction

In a recent article [23], the authors studied complex Gaussian multiplicative chaos, a complex extension of classical Gaussian multiplicative chaos (see [28] for a review on Gaussian multiplicative chaos). More precisely, consider two independent and logarithmically correlated Gaussian fields $X, Y$ on a subdomain $\Omega \subset \mathbb{R}^{d}$

\mathbb{E}[X(x) X(y)]=\mathbb{E}[Y(x) Y(y)] \underset{|y-x| \rightarrow 0}{\sim} \ln \frac{1}{|y-x|}
$$

[^0]We denote $\mathcal{D}(\Omega)$ the space of smooth functions with compact support in $\Omega$ and $\mathcal{D}(\Omega)$ the space of distributions (in the sense of Schwartz). They adressed the problem of finding a proper renormalization as well as the limit of the family of complex random distributions

$$
\begin{equation*}
M_{\varepsilon}^{\gamma, \beta}(\varphi)=\int_{\Omega} e^{\gamma X_{\varepsilon}(x)+i \beta Y_{\varepsilon}(x)} \varphi(x) d x, \quad \varphi \in \mathcal{D}(\Omega) \tag{1.1}
\end{equation*}
$$

where $X_{\varepsilon}, Y_{\varepsilon}$ are appropriate regularizations (say of variance of order $\ln \frac{1}{\varepsilon}$ ) which converge to $X, Y$ and $\gamma, \beta$ are real constants. In this setting, they recovered the phase diagram of figure 1 which was first discovered in the pioneering work [18] in the simpler context of discrete multiplicative cascades, i.e. when $X_{\varepsilon}, Y_{\varepsilon}$ are independent branching random walks on a tree-like structure. More precisely, the authors of [18] computed the free energy of the total mass (or partition function)

\lim _{\varepsilon \rightarrow 0} \frac{1}{\ln \varepsilon} \ln \left|M_{\varepsilon}^{\gamma, \beta}(\Omega)\right|
$$

for a subset $\Omega$ and found phase transitions according to a diagram similar to our figure 1. In particular, they distinguished three phases I, II and III which we have indicated on the figure. The work [23] is a step further in understanding the limit of (1.1). Indeed, the framework of [23] is that of finding a deterministic sequence $c(\varepsilon)$ such that $c(\varepsilon) M_{\varepsilon}^{\gamma, \beta}$ converges to a non trivial limit in the space of distributions (see also the interesting and related works [10, 11]). In a series of works [19, 20, 23, 26], this question was essentially solved for the phases I and III (and their frontiers) but left unanswered in phase II. However, it was conjectured that in phase II, the behaviour of $M_{\varepsilon}^{\gamma, \beta}$ is mainly ruled by two phenomena: the local intensity of this complex measure is dominated by the local maxima of the field $X_{\varepsilon}$ whereas the overall phase resulting from the (strong) windings of the field $Y_{\varepsilon}$ asymptotically behaves like a white noise. This led to the following freezing conjecture corresponding to the so-called glassy phase (the freezing and glassy phase terminology comes from physics, see $[17,21,22]$ for example):

Conjecture 1.1. Let $\beta>0$ and $\gamma>\sqrt{\frac{d}{2}}$ be such that $\beta>\max (\sqrt{2 d}-\gamma, 0)$. Set $\alpha=\sqrt{\frac{d}{2}} \frac{1}{\gamma}$. There exists some constant $\sigma:=\sigma(\gamma, \beta)>0$ such that we get the following convergence in law:
where, conditionally on $N_{M^{\prime}}^{\alpha}, W_{\sigma^{2} N_{M^{\prime}}^{\alpha}}$ is a complex Gaussian random measure with intensity $\sigma^{2} N_{M^{\prime}}^{\alpha}$ and $N_{M^{\prime}}^{\alpha}$ is a $\alpha$-stable random measure with intensity $M^{\prime}$, namely a random distribution whose law is characterized by $\mathbb{E}\left[e^{-q W_{N_{M^{\prime}}}^{\alpha}(A)}\right]=\mathbb{E}\left[e^{-q^{2 \alpha} M^{\prime}(A)}\right]$ for every $q \geqslant 0$ and every bounded Borelian set $A$.

Let us finally mention that a result similar to (1.2) is proved in the real case on the frontier of phase II in the paper [26], i.e. for $\gamma>\sqrt{2 d}$ and $\beta=0$ (see also [7, 8,13 ] for related results). These results in the real case were also studied in the Branching Random Walk context in [9, 12, 25, 29].

The purpose of this work is to prove the analogue of conjecture (1.1) in the context of the simpler but related model, the so-called branching Brownian motion (BBM) where the approximations $X_{\varepsilon}, Y_{\varepsilon}$ are defined by particles which split along a Poisson process and then perform independent Brownian motions: see the next section for precise definitions. Let us mention that, up to some technical adaptations, it should be possible to prove in the BBM context results analogue to [23] and in particular to recover a phase diagram similar to figure 1. Over the past years, there has been impressive progress on the the study of BBM since the seminal works $[14,15,24]$ : this progess has culminated in the works $[2,4,5,6]$. Thanks to these achievements, it is possible to know with high precision the behaviour of the extreme particles of the BBM which dominate phase II. Though our work in the context of BBM relies on the fine results of $[2,4,5,6]$, we believe that it gives insights on the mechanism involved behind the conjectured convergence (1.2): this will be discussed in more detail in the next section.

The paper is organized as follows. In the next section, we define the setup and cite the main result of the paper namely theorem 2.1. We also include a discussion on related models, like the branching random walk or the logarithmically correlated Gaussian fields considered in [26]. Special emphasis will be given to the case of the maximum of the discrete Gaussian Free Field which has received a lot of attention recently $[8,13,16,19,20]$. In the following section, we prove theorem 2.1.

## 2 Setup and main result

### 2.1 Setup and main result

In this paper, we will study the branching Brownian motion (BBM for short). Start with a single particle which performs standard Brownian motion starting from 0 up to an exponential holding time $T$ with parameter $\lambda=1$. At time $T$, the particle splits into two new particles, both of them following a new independent copy of the same process starting from its place of birth. Both new particles thus move according to a standard Brownian motion and split into two after an exponential holding time and so on. We introduce $N(t)$ the associated Poisson point process which counts the number of particles at time $t$ and $\left(\bar{X}_{i}(t)\right)_{1 \leqslant i \leqslant N(t)}$ the (increasingly ordered) positions of the particles.

We then introduce the properly normalized and shifted quantity

$$
X_{i}(t)=\sqrt{2} \bar{X}_{i}(t)+2 t,
$$

in order to have:

$$
\begin{equation*}
\mathbb{E}\left[\sum_{i=1}^{N(t)} e^{-X_{i}(t)}\right]=1, \quad \mathbb{E}\left[\sum_{i=1}^{N(t)} X_{i}(t) e^{-X_{i}(t)}\right]=0, \quad \forall t>0 . \tag{2.1}
\end{equation*}
$$

On the same probability space, we consider particles which split according to the same Poisson point process $N(t)$ but follow Brownian motions that are independent of those involved in the definition of $X$. We consider $\left(\bar{Y}_{i}(t)\right)_{1 \leqslant i \leqslant N(t)}$ the positions of these new particles.

We introduce the random measure

$$
\begin{equation*}
\mathcal{N}_{t}(d X, d Y)=\sum_{i=1}^{N(t)} \delta_{\left(X_{i}(t), Y_{i}(t)\right)} \tag{2.2}
\end{equation*}
$$

We will also consider the measure $\overline{\mathcal{N}}_{x, t}$ which corresponds to the measure $\mathcal{N}_{t}$ conditioned to the event that
all particles $\left(X_{i}(t)\right)_{1 \leqslant i \leqslant N(t)}$ are above $-x$. If $f$ is some continuous function, we denote

$$
<f(X, Y), \mathcal{N}_{t}(d X, d Y)>:=\sum_{i=1}^{N(t)} f\left(X_{i}(t), Y_{i}(t)\right)
$$

and similarly for $\overline{\mathcal{N}}_{x, t}$.
In order to state our results, we introduce the limit of the derivative martingale $M^{\prime}$ given by the following limit (first derived in [27])

$$
M^{\prime}:=\lim _{t \rightarrow \infty} \sum_{i=1}^{N(t)} X_{i}(t) e^{-X_{i}(t)}
$$

Recall the following classical convergence in law of the minimum obtained in [15]

$$
\begin{equation*}
X_{1}(t)-\frac{3}{2} \ln t \underset{t \rightarrow \infty}{\rightarrow} W \tag{2.3}
\end{equation*}
$$

where $W$ is some random variable satisfying $\mathbb{P}(W \leqslant x) \underset{x \rightarrow-\infty}{\sim} c_{\star}|x| e^{x}$ and $c_{\star}$ some constant.
We are interested in studying the variable

$$
\begin{equation*}
t^{\frac{3 \gamma}{2}} \sum_{i=1}^{N(t)} e^{-\gamma X_{i}(t)+\beta \sqrt{2} \bar{Y}_{i}(t)} \tag{2.4}
\end{equation*}
$$

in the so-called phase II, i.e. $\beta>(1-\gamma)_{+}$and $\gamma>\frac{1}{2}$ where for a real $x$ we set $x_{+}=\max (x, 0)$. To state our main result, we recall that a random variable $\mathcal{G}$ is a standard complex Gaussian random variable if $\mathcal{G}=\mathcal{G}_{1}+i \mathcal{G}_{2}$ where $\mathcal{G}_{1}, \mathcal{G}_{2}$ are two independent standard real Gaussian variables. The following theorem is the main result of the paper:
Theorem 2.1. For $(\gamma, \beta)$ in phase $I I$, there is some constant $c(\gamma, \beta)>0$ such that we have the following convergence in law

$$
\begin{equation*}
t^{\frac{3 \gamma}{2}} \sum_{i=1}^{N(t)} e^{-\gamma X_{i}(t)+i \sqrt{2} \beta \bar{Y}_{i}(t)} \underset{t \rightarrow \infty}{\rightarrow} c(\gamma, \beta) N_{\alpha}^{1 / 2} \mathcal{G} \tag{2.5}
\end{equation*}
$$

where $\mathcal{G}$ is a standard complex Gaussian random variable independent from $N_{\alpha}$ which is a $\alpha$-stable random variable with intensity $M^{\prime}$ and $\alpha=\frac{1}{2 \gamma}$. More precisely, the law of $N_{\alpha}$ is characterized by

$$
\mathbb{E}\left[e^{-q N_{\alpha}}\right]=\mathbb{E}\left[e^{-q^{\alpha} M^{\prime}}\right]
$$

for all $q \geqslant 0$.

### 2.2 Heuristic of the proof

In this subsection, we start by giving an insight on the proof of theorem 2.1 which will enable us to discuss other related models: the branching random walk and the discrete GFF. First, introduce the set $N_{\text {loc }}(t)$ of local minima of $X_{i}(t)$ that are close to $\frac{3}{2} \ln t$, i.e. those particles which are at distance of order 1 from $\frac{3}{2} \ln t$ and that are smaller than all the particles sharing with them a common ancestor at distance of order 1. In phase II, the variable 2.4 concentrates on the local minima along with the close neighbours that do not have atypical high values, which constitute the so-called decoration. Therefore, the variable (2.4) is roughly equal for large $t$ to

$$
t^{\frac{3 \gamma}{2}} \sum_{u \in N_{l o c}(t)} \sum_{j \approx u, X_{j}(t) \approx X_{u}(t)} e^{-\gamma X_{j}(t)+i \sqrt{2} \beta \bar{Y}_{j}(t)}
$$

where $x \approx y$ means that $|x-y|$ is of order 1 . Now, one can rewrite the above quantity in the following way

$$
t^{\frac{3 \gamma}{2}} \sum_{u \in N_{l o c}(t)} e^{-\gamma X_{u}(t)}\left(e^{i \sqrt{2} \beta \bar{Y}_{u}(t)} \sum_{j \approx u, X_{j}(t) \approx X_{u}(t)} e^{-\gamma\left(X_{j}(t)-X_{u}(t)\right)+i \sqrt{2} \beta\left(\bar{Y}_{j}(t)-\bar{Y}_{u}(t)\right)}\right)
$$

From the results of $[2,4,5,6]$, the sum $t^{\frac{3 \gamma}{2}} \sum_{u \in N_{l o c}(t)} e^{-\gamma X_{u}(t)}$ converges to $\sum_{u \geqslant 1} e^{-\gamma \Delta_{u}}$ where $\left(\Delta_{u}\right)_{u} \geqslant 1$ is a Poisson point process (PPP) with intensity $c M^{\prime} e^{x} d x$ where $c>0$ is some constant.

Since the local minima are far apart, each $\operatorname{sum}\left(e^{i \sqrt{2} \beta \bar{Y}^{(u)}(t)} \sum_{j \approx u, X_{j}(t) \approx X_{u}(t)} \cdots\right)_{u}$ is asymptotically independent for different values of $u$. From the results of $[2,4,5,6]$, one can also deduce that each term

$$
\left.\sum_{j \approx u, X_{j}(t) \approx X_{u}(t)} e^{-\gamma\left(X_{j}(t)-X_{u}(t)\right)+i \sqrt{2} \beta\left(\bar{Y}_{j}(t)-\bar{Y}_{u}(t)\right.}\right)
$$

converges in law to some non trivial variable $Z^{(u)}$ (which is painful to describe).
Finally, if $\mathcal{N}$ is a standard Gaussian the variable $e^{i \alpha \mathcal{N}}$ converges in law as $\alpha \rightarrow \infty$ to a random variable uniformly distributed on the unit circle. Hence $e^{i \sqrt{2} \beta \bar{Y}_{u}(t)}$ converges in law to a variable $U_{u}$ uniformly distributed on the unit circle and independent from $Y^{(u)}$. Gathering the above considerations, we see that the variable (2.4) converges to

$$
\sum_{u \geqslant 1} e^{-\gamma \Delta_{u}} U_{u} Z^{(u)}
$$

where $\left(U_{u} Z^{(u)}\right)_{u \geqslant 1}$ is an i.i.d. sequence of isotropic random variables. Though we do not have a friendly description of the variable $U_{u} Z^{(u)}$, the scaling property of the Poisson sequence and the isotropy of $U_{u} Z^{(u)}$ yield representation (2.5). In fact, a similar mechanism is behind the freezing phenomenon in the real case $(\gamma>1, \beta=0)$; indeed, in this case, the i.i.d property of the decoration combined to the scaling property of the PPP yield a stable distribution.

### 2.3 Discussion of other models

In the case of the branching random walk, it should be possible to prove analogues of $[2,4,5,6]$ though it certainly requires non trivial technical difficulties to adapt the proofs of $[2,4,5,6]$. Therefore, proving a result similar to theorem 2.1 is clearly within reach (in the lognormal and even the non lattice case).

In the case of the discrete GFF, the situation is a bit more involved and does not just require technical adaptations: this is due to the fact that the correlations do not involve a hierarchical structure. Consider a discrete GFF $X_{\varepsilon}$ on a square grid of size $\varepsilon$ in a fixed bounded domain $D$ with the normalization $\mathbb{E}\left[X_{\varepsilon}(x)^{2}\right]=2 \ln \frac{1}{\varepsilon}+2 \ln C(x, D)+o(1)$ where $C(x, D)$ denotes the conformal radius of a point $x \in D$. Fix $l>0$. We introduce the set $N_{l o c}^{(l)}(\varepsilon):=\left\{x_{1}, \ldots, x_{J_{\varepsilon}^{(l)}}\right\}$ of coordinates of the local maxima of $X_{\varepsilon}$ that are in the interval

$$
\left[2 \ln \frac{1}{\varepsilon}+\frac{3}{2} \ln \ln \frac{1}{\varepsilon}-l, 2 \ln \frac{1}{\varepsilon}+\frac{3}{2} \ln \ln \frac{1}{\varepsilon}+l\right]
$$

In view of the results of $[13,26]$, it is natural to conjecture that the following convergence in law holds for all $k$

$$
\begin{align*}
& \left(\left(x_{u}, X\left(x_{u}\right),\left(X(y)-X\left(x_{u}\right), \frac{y-x_{u}}{\varepsilon}\right)_{\left\{y ;\left|X(y)-X\left(x_{u}\right)\right| \leqslant k \text { and }\left|y-x_{u}\right| \leqslant \varepsilon k\right\}}\right)\right)_{u \leqslant J_{\varepsilon}^{(l)}} \\
& \underset{\varepsilon \rightarrow 0}{\rightarrow}\left(z_{u}, \Delta_{u}, \mu_{u}\left(.1_{|\cdot| \leqslant k}\right), \rho_{u}\left(.1_{|\cdot| \leqslant k}\right)\right)_{u \geqslant 1, \Delta_{u} \in[-l, l]} \tag{2.6}
\end{align*}
$$

where $\left(z_{u}, \Delta_{u}\right)_{u \geqslant 1}$ is a Poisson Point process (PPP) with intensity $c C(x, D)^{2} M^{\prime}(d x) \times e^{-y} d y$ where $M^{\prime}$ is the derivative martingale constructed in [19, 20], $c$ some constant and $\left(\mu_{u}, \rho_{u}\right)_{u} \geqslant 1$ is an i.i.d. sequence of couples of point processes that are independent from the $\left(\Delta_{u}\right)_{u} \geqslant 1$. The law of $\rho_{u}$ should be isotropic. Recall the remarkable result of [13] where the authors prove that $\left(\left(x_{u}, X\left(x_{u}\right)\right)_{u \leqslant J_{\varepsilon}^{(l)} \text { converges to a PPP }}\right.$ with intensity $Z(d x) \times \mathbb{1}_{\{y \in[-l, l]\}} e^{-y} d y$ where $Z(d x)$ should coincide with $c C(x, D)^{2} M^{\prime}(d x)$.

Nonetheless, in order to adapt our result to this context, one still has to reinforce the conjectured convergence (2.6) by adding information on the "decorrelation time" $\varepsilon$ of two points in the point process $\rho$. This is certainly a non trivial issue that requires a fine analysis of the discrete GFF.

## 3 Proof of theorem 2.1

We first recall the following useful lemma, the so-called many-to-one lemma, which states that for all nonnegative function $F$

\begin{equation*}
\mathbb{E}\left[\sum_{i=1}^{N(t)} F\left(\left(X_{i}(s)\right)_{0 \leqslant s \leqslant t}\right)\right]=e^{t} \mathbb{E}\left[F\left(\left(\sqrt{2} B_{s}+2 s\right)_{0 \leqslant s \leqslant t)}\right]\right. \tag{3.1}
\end{equation*}
$$

where $\left(B_{s}\right)_{s} \geqslant 0$ is a standard Brownian motion.

### 3.1 Proof of theorem 2.1

Given the technical lemmas of the next subsection, it is not very difficult to conduct the proof. Let $F$ be some bounded and Lipschitz function from $\mathbb{C}$ to $\mathbb{R}$. We will additionally suppose that $F$ is bounded by 1 and 1-Lipschitz. By lemma 3.5, there exists $C_{k}$ such that $\lim _{k \rightarrow \infty} C_{k}=0$ and

$$
\varlimsup_{t \rightarrow \infty} \mathbb{E}\left[\left|F\left(t^{\frac{3 \gamma}{2}} \sum_{i=1}^{N(t)} e^{-\gamma X_{i}(t)+i \sqrt{2} \beta \bar{Y}_{i}(t)}\right)-F\left(t^{\frac{3 \gamma}{2}} \sum_{i=1}^{N(t)} \mathbb{1}_{\left\{X_{i}(t) \leqslant \frac{3}{2} \ln t+k\right\}} e^{-\gamma X_{i}(t)+i \sqrt{2} \beta \bar{Y}_{i}(t)}\right)\right|\right] \leqslant C_{k}
$$

Following [2], for $l \geqslant 0$, we introduce $\mathcal{H}_{l}(t)$ the set of particles which are the first in their line of descent up to time $t$ to hit $l$. Since $X_{1}(t)$ converges almost surely to infinity as $t$ goes to infinity, $\mathcal{H}_{l}(t)$ is constant for $t$ (random) large enough and equal to a set that we will denote $\mathcal{H}_{l}$. Observe that $\mathcal{H}_{l}$ is finite almost surely.

For each $u \in \mathcal{H}_{l}(t)$, we consider the ordered descendants $\left(X_{i}^{u}(t)\right)_{1 \leqslant i \leqslant N^{u}(t)}$ up to time $t$. Then, we have

$$
\begin{align*}
& \left.t^{\frac{3 \gamma}{2}} \sum_{i=1}^{N(t)} e^{-\gamma X_{i}(t)+i \sqrt{2} \beta \bar{Y}_{i}(t)} \mathbb{1}_{\left\{X_{i}(t)\right.} \leqslant \frac{3}{2} \ln t+k\right\} \\
& =\sum_{u \in \mathcal{H}_{l}(t)} t^{\frac{3 \gamma}{2}} e^{-\gamma X_{1}^{u}(t)+i \sqrt{2} \beta \bar{Y}_{1}^{u}(t)} \sum_{j=1}^{N^{u}(t)} \mathbb{1}_{\left\{X_{j}^{u}(t) \leqslant \frac{3}{2} \ln t+k\right\}} e^{-\gamma\left(X_{j}^{u}(t)-X_{1}^{u}(t)\right)+i \sqrt{2} \beta\left(\bar{Y}_{j}^{u}(t)-\bar{Y}_{1}^{u}(t)\right)}+A_{t, l, k} \tag{3.2}
\end{align*}
$$

where $A_{t, l, k}$ corresponds to the sum on the $i$ which are not descendants of $u \in \mathcal{H}_{l}(t)$. Since $X_{1}(t)$ converges almost surely to infinity as $t$ goes to infinity, the variable $\sup _{k} \geqslant 0 A_{t, l, k}$ converges almost surely to 0 as $t$ goes to infinity. Hence, we just have to study the convergence of $\mathbb{E}\left[F\left(\sum_{u \in \mathcal{H}_{l}(t)} \cdots\right)\right]$ where $\sum_{u \in \mathcal{H}_{l}(t)} \cdots$ is defined in equality 3.2 . We introduce $\tau_{i, j}^{u}(t)$ the splitting times of particles $X_{i}^{u}(t)$ and $X_{j}^{u}(t)$. Now, we have
$\mathbb{E}\left[F\left(\sum_{u \in \mathcal{H}_{l}(t)} t^{\frac{3 \gamma}{2}} e^{-\gamma X_{1}^{u}(t)+i \sqrt{2} \beta \bar{Y}_{1}^{u}(t)} \sum_{j=1}^{N^{u}(t)} \mathbb{1}_{\left\{X_{j}^{u}(t) \leqslant \frac{3}{2} \ln t+k\right\}} e^{-\gamma\left(X_{j}^{u}(t)-X_{1}^{u}(t)\right)+i \sqrt{2} \beta\left(\bar{Y}_{j}^{u}(t)-\bar{Y}_{1}^{u}(t)\right)}\right)\right]$

$$
\begin{equation*}
=\mathbb{E}\left[F\left(\sum_{u \in \mathcal{H}_{l}(t)} t^{\frac{3 \gamma}{2}} e^{-\gamma X_{1}^{u}(t)+i \sqrt{2} \beta \bar{Y}_{1}^{u}(t)} \sum_{j=1, t-\tau_{j, 1}^{u}(t)<b}^{N^{u}(t)} \mathbb{1}_{\left\{X_{j}^{u}(t) \leqslant \frac{3}{2} \ln t+k\right\}} e^{-\gamma\left(X_{j}^{u}(t)-X_{1}^{u}(t)\right)+i \sqrt{2} \beta\left(\bar{Y}_{j}^{u}(t)-\bar{Y}_{1}^{u}(t)\right)}\right)\right] \tag{3.3}
\end{equation*}
$$

$+B_{t, l, k, b}$
where the remainder term $B_{t, l, k, b}$ is such that $\left|B_{t, l, k, b}\right| \leqslant\|F\|_{\infty} \mathbb{P}\left(\mathcal{B}_{t, l, k, b}\right)$ where $\mathcal{B}_{t, l, k, b}$ is defined by

Now for all $k^{\prime} \geqslant k$, we have by lemma 3.6 that
$\mathbb{E}\left[F\left(\sum_{u \in \mathcal{H}_{l}(t)} t^{\frac{3 \gamma}{2}} e^{-\gamma X_{1}^{u}(t)+i \sqrt{2} \beta \bar{Y}_{1}^{u}(t)} \sum_{j=1, t-\tau_{j, 1}^{u}(t)<b}^{N^{u}(t)} \mathbb{1}_{\left\{X_{j}^{u}(t) \leqslant \frac{3}{2} \ln t+k\right\}} e^{-\gamma\left(X_{j}^{u}(t)-X_{1}^{u}(t)\right)+i \sqrt{2} \beta\left(\bar{Y}_{j}^{u}(t)-\bar{Y}_{1}^{u}(t)\right)}\right)\right]=$
$\mathbb{E}\left[F\left(\sum_{u \in \mathcal{H}_{l}(t)} t^{\frac{3 \gamma}{2}} e^{-\gamma X_{1}^{u}(t)+i \sqrt{2} \beta \bar{Y}_{1}^{u}(t)} \mathbb{1}_{\left\{X_{1}^{u}(t) \leqslant \frac{3}{2} \ln t+k\right\}} \sum_{j=1, t-\tau_{j, 1}^{u}(t)<b}^{N^{u}(t)} \mathbb{1}_{\left\{X_{j}^{u}(t) \leqslant \frac{3}{2} \ln t+k^{\prime}\right\}} e^{-\gamma\left(X_{j}^{u}(t)-X_{1}^{u}(t)\right)+i \sqrt{2} \beta\left(\bar{Y}_{j}^{u}(t)-\bar{Y}_{1}^{u}(t)\right)}\right)\right]$
$+C_{t, l, k, k^{\prime}, b}$
where $C_{t, l, k, k^{\prime}, b}$ is such that $\varlimsup_{t \rightarrow \infty}\left|C_{t, l, k, k^{\prime}, b}\right| \leqslant D_{k}$ where $D_{k}$ goes to 0 when $k$ goes to infinity.
Now, in order to describe the limit, we need to introduce some notations. We consider $\mathcal{H}_{l}$ as a subset of $\mathbb{N}$. We introduce an i.i.d. sequence $\left(U_{u}\right)_{u \in \mathbb{N}}$ of random variables uniformly distributed on the unit circle and an i.i.d. sequence $\left(B^{(u)}\right)_{u \in \mathbb{N}}$ of standard Brownian motions. We also consider an i.i.d. sequence $\left(\Gamma^{(u)}\right)_{u \in \mathbb{N}}$ distributed like the backward path $Y$ of $[2]$ and the associated Poisson jumps $\left(\left(\tau_{j}^{(u)}\right)_{j}\right)_{u \in N}$. Finally, given $u$ and conditionally to $\left(\Gamma^{(u)},\left(\tau_{j}^{(u)}\right)_{j}\right)$, we consider an independent sequence of Point processes $\overline{\mathcal{N}}_{\Gamma^{(u)}\left(\tau_{j}^{(i)}\right), \tau_{j}^{(u)}}^{(u, j)}(d X, d Y)$ of distribution that of $\overline{\mathcal{N}}_{x, s}(d X, d Y)$ where $x=\Gamma^{(u)}\left(\tau_{j}^{(u)}\right)$ and $s=\tau_{j}^{(u)}$.

Now, using the convergence results of [2], the $\mathbb{E}_{t, l, k, k^{\prime}, b}[\cdots]$ term in the right hand side of (3.4) satisfies the following convergence

where $\left(W_{u}\right)_{u \in \mathcal{H}_{l}}$ is an i.i.d. sequence distributed like the asymptotic minimum of the (shifted) BBM, i.e. of distribution $W$ in (2.3), and $Z_{W_{u}+l, k^{\prime}}^{(u)}$ is an i.i.d. sequence given by

The point that does not come out of the results of [2] is the appearance of the sequence $\left(U_{u}\right)_{u \in \mathcal{H}_{l}}$ and the sequence $\left(B^{(u)}\left(\tau_{j}^{(u)}\right)_{j}\right)_{u}$. Observe that if $\mathcal{G}$ is a standard Gaussian variable then $e^{i \alpha \mathcal{G}}$ converges in law as $\alpha \rightarrow \infty$ to a random variable uniformly distributed on the unit circle. We extend this elementary result to the following lemma:

Lemma 3.1. Assume that $\left(X^{n}\right)_{n}$ is a sequence of centered $\mathbb{R}^{d}$-valued Gaussian random vectors such that

where $U_{1}, \ldots, U_{d}$ are independent random variables uniformly distributed on the unit circle.
Proof. Let us consider $d$ smooth functions $F_{1}, \ldots F_{d}$ on the unit circle. We can write the Fourier expansion of the product $F_{1} \times F_{d}$

The sum is absolutely converging. We deduce

The relation $\mathbb{E}\left[e^{i<p, X^{n}>}\right]=e^{-\frac{1}{2} \mathbb{E}\left[\left|<p, X^{n}>\right|^{2}\right]}$ and assumption (3.6) imply that each term in the above sum, except for $p=0$, converges towards 0 . The dominated convergence theorem then entails that

The result follows.
Since $l$ is fixed here, conditionally on the Poisson process $N$ and the particles $X_{j}^{u}$, the sequence $\left(\bar{Y}_{1}^{u}(t)\right)_{u}$ satisfies the assumptions of the above lemma as they are Brownian motions, the increments of which become independent after some time $t_{\star}$. Hence, since $\beta>0$, the sequence $\left(e^{i \sqrt{2} \beta \bar{Y}_{1}^{u}(t)}\right)_{u}$ converges in law as $t \rightarrow \infty$ to an i.i.d. sequence of random variables uniformly distributed on the unit circle and independent from all the other variables.

The other point to adress is the appearance of the sequence $\left(B^{(u)}\left(\tau_{j}^{(u)}\right)_{j}\right)_{u}$. Recall the following lemma:
Lemma 3.2. Let $(B(t))_{t} \geqslant 0$ be a standard Brownian motion. For all fixed $0 \leqslant t_{1}<\ldots<t_{d}$ and $a>0$, we have the following convergence in law

\left(e^{i a B(t)}, e^{-i a\left(B(t)-B\left(t-t_{1}\right)\right)}, \cdots, e^{-i a\left(B(t)-B\left(t-t_{d}\right)\right)}\right) \underset{t \rightarrow \infty}{\rightarrow}\left(U, e^{-i a \widetilde{B}\left(t_{1}\right)}, \cdots, e^{-i a \widetilde{B}\left(t_{d}\right)}\right)
$$

where $U$ is uniformly distributed on the circle and $\widetilde{B}$ is a standard Brownian motion independent from $U$.
When $u$ is fixed, each term $\bar{Y}_{j}^{u}(t)-\bar{Y}_{1}^{u}(t)$ is the sum of $-\left(\bar{Y}_{1}^{u}(t)-\bar{Y}_{1}^{u}\left(\tau_{j, 1}^{u}(t)\right)\right)$ and an independent branching part. Hence, conditionally on the Poisson process $N$ and the particles $X_{j}^{u}$, we can apply a straightforward variant of lemma 3.2 in the limit (3.5) since $b$ is fixed before taking the limit $t \rightarrow \infty$.

Now, we wish to take the limit in $k^{\prime}$ in (3.5). By lemma 3.8 and because the set $\mathcal{H}_{l}$ is finite, we have

where $Z^{(u)}$ is an i.i.d. sequence given by (see lemma 3.7)

Z^{(u)}=1+\sum_{j \geqslant 1} e^{-\gamma \Gamma^{(u)}\left(\tau_{j}^{(u)}\right)-i \sqrt{2} \beta B^{(u)}\left(\tau_{j}^{(u)}\right)}<e^{-\gamma X+i \sqrt{2} \beta Y}, \overline{\mathcal{N}}_{\Gamma^{(u)}\left(\tau_{j}^{(u)}\right), \tau_{j}^{(u)}}^{(u, j)}(d X, d Y)>
$$

Now, we wish to take the limit as $l$ goes to infinity. By the results of [2], we get that

\lim _{l \rightarrow \infty} \lim _{k^{\prime} \rightarrow \infty b \rightarrow \infty} \lim _{l \rightarrow \infty} \lim _{t \rightarrow \infty} \mathbb{E}_{t, l, k, k^{\prime}, b}[\cdots]=\mathbb{E}\left[F\left(\sum_{u \geqslant 1} \mathbb{1}_{\left\{\Delta_{u} \leqslant k\right\}} e^{-\gamma \Delta_{u}} U_{u} Z^{(u)}\right)\right]
$$

where $\left(\Delta_{u}\right)_{u \geqslant 1}$ is a Poisson Point Process of intensity $c M^{\prime} e^{x} d x$ where $M^{\prime}$ is the limit of the derivative martingale.

To sum things up, we have proven that

$$
\begin{align*}
& \varlimsup_{l \rightarrow \infty} \varlimsup_{k^{\prime} \rightarrow \infty b \rightarrow \infty} \varlimsup_{l \rightarrow \infty} \varlimsup_{i m}\left|\mathbb{E}\left[F\left(t^{\frac{3 \gamma}{2}} \sum_{i=1}^{N(t)} e^{-\gamma X_{i}(t)+i \sqrt{2} \beta \bar{Y}_{i}(t)}\right)\right]-\mathbb{E}\left[F\left(\sum_{u \geqslant 1} \mathbb{1}_{\left\{\Delta_{u} \leqslant k\right\}} e^{-\gamma \Delta_{u}} U_{u} Z^{(u)}\right)\right]\right| \\
& \leqslant \varlimsup_{l \rightarrow \infty} \varlimsup_{k^{\prime} \rightarrow \infty b \rightarrow \infty} \varlimsup_{\lim _{t \rightarrow \infty}}\left(C_{k}+\mathbb{E}\left[\left|A_{t, l, k}\right| \wedge 1\right]+\left|B_{t, l, k, b}\right|+\left|C_{t, l, k, k^{\prime}, b}\right|\right) \\
& \leqslant C_{k}+D_{k} \tag{3.7}
\end{align*}
$$

In fact, the bounds that we have obtained along the proof hold uniformly with respect to the functions $F$ that are bounded by 1 and 1 -Lipschitz. Let $\mathcal{F}$ denote the space of such functions. We have thus proved

& \leqslant C_{k}+D_{k} \tag{3.8}
\end{align*}
$$

Now, we conclude by using the following trick. Recall that the sequence $\left(t^{\frac{3 \gamma}{2}} \sum_{i=1}^{N(t)} e^{-\gamma X_{i}(t)+i \sqrt{2} \beta \bar{Y}_{i}(t)}\right)_{t}$ is tight. Indeed, by lemma 3.5 , it suffices to show that for all fixed $k$ the sequence

is tight. But this results from the real case $[2,4,5,6]$ and the bound

\left|t^{\frac{3 \gamma}{2}} \sum_{i=1}^{N(t)} \mathbb{1}_{\left\{X_{i}(t) \leqslant \frac{3}{2} \ln t+k\right\}} e^{-\gamma X_{i}(t)+i \sqrt{2} \beta \bar{Y}_{i}(t)}\right| \leqslant\left|\left\{i ; X_{i}(t) \leqslant \frac{3}{2} \ln t+k\right\}\right| e^{-\gamma\left(X_{1}(t)-\frac{3}{2} \ln t\right)}
$$

Since the sequence $\left(t^{\frac{3 \gamma}{2}} \sum_{i=1}^{N(t)} e^{-\gamma X_{i}(t)+i \sqrt{2} \beta \bar{Y}_{i}(t)}\right)_{t}$ is tight, we can find a sequence $\left(t_{j}\right)_{j} \geqslant 1$ going to infinity and such that it converges in law towards a random variable. From this subsequence, we can extract an increasing subsequence $\left(t_{j_{k}}\right)_{j_{k} \geqslant 1}$ such that for all $k$, we have

\begin{aligned}
& \sup _{F \in \mathcal{F}}\left|\mathbb{E}\left[F\left(t_{j_{k}}^{\frac{3 \gamma}{2}} \sum_{i=1}^{N\left(t_{j_{k}}\right)} e^{-\gamma X_{i}\left(t_{j_{k}}\right)+i \sqrt{2} \beta \bar{Y}_{i}\left(t_{j_{k}}\right)}\right)\right]-\mathbb{E}\left[F\left(\sum_{u \geqslant 1} \mathbb{1}_{\left\{\Delta_{u} \leqslant k\right\}} e^{-\gamma \Delta_{u}} U_{u} Z^{(u)}\right)\right]\right| \\
& \leqslant C_{k}+D_{k}+\frac{1}{k^{2}} .
\end{aligned}
$$

Hence, we conclude that $\sum_{u \geqslant 1} \mathbb{1}_{\left\{\Delta_{u} \leqslant k\right\}} e^{-\gamma \Delta_{u}} U_{u} Z^{(u)}$ converges in law as $k$ goes to infinity. We would like to identify this law. Let $x \in \mathbb{R}^{2}$. We denote the scalar product by $<,>$ and $\mathbb{E}_{X}$ expectation with respect to a variable $X$. By isotropy of the uniform law on the unit circle, the random variables $\left(<U_{u} Z^{(u)}, x>\right)_{u}$ have the same laws as $\left(|x|\left|U_{u}^{1}\right|\left|Z^{(u)}\right| \varepsilon_{u}\right)_{u}$ where $U_{u}^{1}$ is the first component of $U_{u}$ and $\left(\varepsilon_{u}\right)_{u}$ is an independent family of i.i.d random variables with law $\mathbb{P}\left(\varepsilon_{u}=1\right)=1-\mathbb{P}\left(\varepsilon_{u}=-1\right)=\frac{1}{2}$. Recalling that $\left(\Delta_{u}\right)_{u}$ is a Poisson point process with intensity $c M^{\prime} e^{z} d z$, we have

$$
\begin{aligned}
\mathbb{E}\left[e^{i \sum_{u} \mathbb{1}_{\left\{\Delta_{u} \leqslant k\right\}} e^{-\gamma \Delta_{u}}<x, U_{u} Z^{(u)}>}\right] & =\mathbb{E}_{M^{\prime}}\left[e^{c M^{\prime} \mathbb{E}_{U, Z}\left[\int_{\{v \leqslant k\}}\left(e^{i e^{-\gamma v}<x, U Z>}-1\right) e^{v} d v\right]}\right] \\
& =\mathbb{E}_{M^{\prime}}\left[e^{c M^{\prime} \mathbb{E}_{U, Z, \varepsilon}\left[\int_{\{v \leqslant k\}}\left(e^{i e^{-\gamma v}|x|\left|U^{1}\right||Z| \varepsilon}-1\right) e^{v} d v\right]}\right] \\
& =\mathbb{E}_{M^{\prime}}\left[e^{c \frac{M^{\prime}}{2} \mathbb{E}_{U, Z}\left[\int_{\{v \leqslant k\}}\left(e^{i e^{-\gamma v}|x|\left|U^{1}\right||Z|}+e^{-i e^{-\gamma v}|x|\left|U^{1}\right||Z|}-2\right) e^{v} d v\right]}\right] \\
& =\mathbb{E}_{M^{\prime}}\left[e^{-c \frac{M^{\prime}}{\gamma}|x|^{1 / \gamma} \mathbb{E}_{U Z}\left[\left|U^{1} Z\right|^{1 / \gamma} \int_{\left\{w \geqslant e^{-\gamma k}|x|\left|U^{1}\right||Z|\right\}}(1-\cos (w)) \frac{d u}{w^{1+\frac{1}{\gamma}}}\right]}\right]
\end{aligned}
$$

Then, by the monotone convergence theorem, we have the following convergence

$$
\lim _{k \rightarrow \infty} \mathbb{E}_{U, Z}\left[\left|U^{1} Z\right|^{1 / \gamma} \int_{\left\{w \geqslant e^{-\gamma k}|x|\left|U^{1} Z\right|\right\}}(1-\cos (w)) \frac{d w}{w^{1+\frac{1}{\gamma}}}\right]=c_{\gamma} \mathbb{E}_{U, Z}\left[\left|U^{1} Z\right|^{1 / \gamma}\right] .
$$

It is important to observe that the expectation $\mathbb{E}_{U, Z}\left[\left|U^{1} Z\right|^{1 / \gamma}\right]$ is necessarily finite, otherwise the family $\sum_{u \geqslant 1} \mathbb{1}_{\left\{\Delta_{u} \leqslant k\right\}} e^{-\gamma \Delta_{u}} U_{u} Z^{(u)}$ could not converge in law as $k \rightarrow \infty$. In conclusion, there exists some constant $c(\gamma, \beta)<\infty$ such that for all $x$

$$
\begin{equation*}
\lim _{k \rightarrow \infty} \mathbb{E}\left[e^{\left.i \sum_{u} \mathbb{1}_{\left\{\Delta_{u}\right.} \leqslant k\right\} e^{-\gamma \Delta_{u}}<x, U_{u} Z^{(u)}>}\right]=\mathbb{E}_{M^{\prime}}\left[e^{-c(\gamma, \beta) M^{\prime}|x|^{1 / \gamma}}\right] \tag{3.9}
\end{equation*}
$$

Now, inequality (3.8) yields that $t^{\frac{3 \gamma}{2}} \sum_{i=1}^{N(t)} e^{-\gamma X_{i}(t)+i \sqrt{2} \beta \bar{Y}_{i}(t)}$ also converges in law as $t$ goes to infinity to the variable whose Fourier transform is defined by the right hand side of (3.9).

### 3.2 Technical lemmas

## Study of the BBM at a fixed time

In this technical subsection, we do not suppose that the particles are ordered and we will identify the interval $[|1, N(t)|]$ with a random tree. In particular, given two particles $i, j$, we will denote $\tau_{i, j}$ their splitting time and set $n_{\tau_{i, j}}$ to be the node of the random tree where the splitting occurs. We start with the following lemma which we will need in the next subsection

Lemma 3.3. Let $\beta>0$ and $\left.\gamma \in] \frac{1}{2}, 1\right]$ such that $\gamma+\beta>1$. Then there exists some constant $C>0$ such that

\sup _{t \geqslant 0} \mathbb{E}\left[\left(\sum_{i, j=1}^{N(t)} e^{-\gamma X_{i}(t)-\gamma X_{j}(t)-2 \beta^{2}\left(t-\tau_{i, j}(t)\right)}\right)^{1 /(2 \gamma)} \mid\right] \leqslant C
$$

Proof. For simplicity, we suppose $t$ is an integer. We have

Each term $\mathbb{E}\left[\left(\sum_{k, k^{\prime}} \mathbb{1}_{\left\{X_{k}^{j}\left(\tau_{j}\right)>\theta\right\}} \mathbb{1}_{\left\{X_{k^{\prime}}^{j}\left(\tau_{j}\right)>\theta\right\}} e^{\left.\left.-\gamma X_{k}^{j}\left(\tau_{j}\right)-\gamma X_{k^{\prime}}^{j}\left(\tau_{j}\right)-2 \beta^{2} \tau_{k, k^{\prime}}^{j, j}\right)^{1 / 2} \mid \Gamma, \tau\right] \text { is bounded by the same }}\right.\right.$ quantity without the indicator function and converges to 0 as $\theta$ goes to infinity. Hence, by the dominated convergence theorem, we have

$$
\sum_{j=1}^{\infty} e^{-\gamma \Gamma\left(\tau_{j}\right)} \mathbb{E}\left[\left(\sum_{k, k^{\prime}} \mathbb{1}_{\left\{X_{k}^{j}\left(\tau_{j}\right)>\theta\right\}} \mathbb{1}_{\left\{X_{k^{\prime}}^{j}\left(\tau_{j}\right)>\theta\right\}} e^{\left.\left.-\gamma X_{k}^{j}\left(\tau_{j}\right)-\gamma X_{k^{\prime}}^{j}\left(\tau_{j}\right)-2 \beta^{2} \tau_{k, k^{\prime}}^{j, j}\right)^{1 / 2} \mid \Gamma, \tau\right]} \underset{\theta \rightarrow \infty}{\rightarrow} 0 .\right.\right.
$$

Therefore, the variable $\mathbb{E}\left[\left|Z^{(\theta)}-Z\right| \mid \Gamma, \tau\right]$ converges almost surely to 0 as $\theta$ goes to infinity. Now, one concludes by using the following inequality for all $\varepsilon>0$

$$
\mathbb{P}\left(\left|Z^{(\theta)}-Z\right| \geqslant \varepsilon\right) \leqslant \mathbb{E}\left[\frac{\mathbb{E}\left[\left|Z^{(\theta)}-Z\right| \mid \Gamma, \tau\right]}{\varepsilon} \wedge 1\right] .
$$
