# Worst-Case Analysis of Weber's GCD Algorithm

#### Abstract

Recently, Ken Weber introduced an algorithm for finding the ( $a, b$ )-pairs satisfying $a u+b v \equiv 0(\bmod k)$, with $0<|a|,|b|<\sqrt{k}$, where $(u, k)$ and $(v, k)$ are coprime. It is based on Sorenson's and Jebelean's " $k$-ary reduction" algorithms. We provide a formula for $N(k)$, the maximal number of iterations in the loop of Weber's GCD algorithm.


Keywords: Integer greatest common divisor (GCD); Complexity analysis; Number theory.

## 1 Introduction

The greatest common divisor (GCD) of integers $a$ and $b$, denoted by $\operatorname{gcd}(a, b)$, is the largest integer that divides both $a$ and $b$.

Recently, Sorenson proposed the "right-shift $k$-ary algorithm" [7]. It is based on the following reduction. Given two positive integers $u>v$ relatively prime to $k$ (i.e., $(u, k)$ and ( $v, k)$ are coprime), two integers $a, b$ can be found that satisfy

$$
\begin{equation*}
a u+b v \equiv(\bmod k) \quad \text { with } \quad 0<|a|,|b|<\sqrt{k} . \tag{1}
\end{equation*}
$$

If we perform the transformation $(u, v) \longmapsto\left(u^{\prime}, v^{\prime}\right)$ (also called " $k$-ary reduction"), where $\left(u^{\prime}, v^{\prime}\right)=(|a u+b v| / k, \min (u, v))$, which replaces $u$ with $u^{\prime}=|a u+b v| / k$, the size of $u$ is reduced by roughly $1 / 2 \log _{2}(k)$ bits. Sorensen suggests table lookup to find sufficiently small $a$ and $b$ satisfying (1). By contrast, Jebelean [2, 3] and Weber [8] both propose an easy algorithm, which finds such small $a$ and $b$ that satisfy (1) with time complexity $O\left(n^{2}\right)$, where $n$ represents the number of bits in

[^0]the two inputs. This latter algorithm we call the "Jebelean-Weber algorithm", or $J W A$ for short.

The present work focuses on the study of $N(k)$, the maximal number of iterations of the loop in $J W A$, in terms of $t=t(k, c)$ as a function of two coprime positive integers $c$ and $k(0<c<k)$. Notice that this exact worst-case analysis of the loop does not provide the greatest lower bound on the complexity of $J W A$ : it does not result in the optimality of the algorithm.

In the next Section 2, an upper bound on $N(k)$ is given, in Section 3, we show how to find explicit values of $N(k)$ for every integer $k>0$. Section 4 is devoted to the determination of all integers $c>0$, which achieve the maximal value of $t(k, c)$ for every given $k>0$; that is the worst-case ocurrences of $J W A$. Section 5 contains concluding remarks.

## 2 An Upper Bound on $N(k)$

Let us recall the $J W A$ as stated in $[5,8]$. The first instruction $c:=x / y \bmod k$ in $J W A$ is not standard. It means that the algorithm finds $c \in[1, k-1]$, such that $c y=x+n k$, for some $n$ (where $x, y, k, c$, and $n$ are all integers).

Notice that the loop invariant is $n^{\prime}\left|d^{\prime \prime}\right|+n^{\prime \prime}\left|d^{\prime}\right|=k$. When $(n, d)$ is the output result of $J W A$, the pairs $(a, b)=(d,-n)$ and $(-d, n)$ meet property (1).

### 2.1 Notation

In $J W A$, the input data are the positive integers $k, u$ and $v$. However, for the purpose of the worst-case complexity analysis, we consider $c=u / v \bmod k$ in place of the pair $(u, v)$. Therefore, the actual input data of $J W A$ are regarded as being $k$ and $c$, such that $0<c<k$, and $\operatorname{gcd}(k, c)=1$.

Throughout, we use the following notation. The sequence ( $n_{i}, d_{i}$ ) denotes the successive pairs produced by $J W A$ when $k$ and $c$ are the input data. Let $t=t(k, c)$ denote the number of iterations of the loop of $J W A ; t$ must satisfy the following inequalities:

$$
\begin{equation*}
n_{t}<\sqrt{k}<n_{t-1} \quad \text { and } \quad 0<n_{t},\left|d_{t}\right|<\sqrt{k} \tag{2}
\end{equation*}
$$

where finite sequence $D=\left(d_{i}\right)$ is defined recursively for $i=-1,0,1, \ldots,(t-2)$ as

$$
\begin{align*}
& d_{i+2}=d_{i}-q_{i+2} d_{i} \text { with } d_{-1}=0 \text { and } d_{0}=1 \\
& q_{i+2}=\left\lfloor n_{i} / n_{i+1}\right\rfloor \quad \text { with } \quad n_{-1}=k \text { and } n_{0}=c \text {. } \tag{3}
\end{align*}
$$

We denote by $Q=\left(q_{i}\right)$ the finite sequence of partial quotients defined in (3). The sequence $D$ is uniquely determined from the choice of $Q$ (i.e., $D=D(Q)$ ), since the initial data $d_{-1}$ and $d_{0}$ are fixed and $D$ is an increasing function of the $q_{i}$ 's in $Q$. Let $\left(F_{n}\right)(n=0,1, \ldots)$ be the Fibonacci sequence, we define $m(k)$ by

$$
m(k)=\max \left\{i \geq 0 \mid F_{i+1} \leq \sqrt{k}\right\} \quad \text { with } i \in \mathbb{N}
$$

For every given integer $k>0$, the maximal number of iterations of the loop of $J W A$ is:

$$
N(k)=\max \{t(k, c) \mid 0<c<k \text { and } \operatorname{gcd}(k, c)=1\} .
$$

### 2.2 Bounding $N(k)$

Lemma 2.1. With the above notation,
(i) $\left|d_{t}\right| \geq F_{t+1}$.
(ii) $N(k) \leq m(k)$.

Proof.
(i) The proof is by induction on $t$.

- Basis: $\left|d_{-1}\right|=0=F_{0},\left|d_{0}\right|=1=F_{1}$, and $\left|d_{1}\right|=q_{1} \geq 1=F_{2}$.
- Induction step: For every $i \geq 0$, suppose $\left|d_{j}\right| \geq F_{j+1}$ for $j=-1,0,1, \ldots$, ( $i-1$ ). Then,

$$
\left|d_{i}\right|=\left|d_{i-2}\right|+q_{i}\left|d_{i-1}\right| \geq\left|d_{i-2}\right|+\left|d_{i-1}\right| \geq F_{i-1}+F_{i}=F_{i+1}
$$

and (i) holds.
(ii) $F_{t+1} \leq\left|d_{t}\right|<\sqrt{k}$. Hence $t=t(c, k) \leq m(k)$, and also $N(k) \leq m(k)$.

Note that the following inequalities also hold

$$
\phi^{m-1}<F_{m+1} l e \sqrt{k}<F_{m+2}<\phi^{m+1}
$$

where $\phi=(1+\sqrt{5}) / 2$ is the golden ratio.
From Lemma 2.1 and the above inequalities, an explicit expression of $m(k)$ is easily derived,

$$
m(k)=\left\lfloor\log _{\phi}(\sqrt{k})\right\rfloor \quad \text { or } \quad m(k)=\left\lceil\log _{\phi}(\sqrt{k})\right\rceil .
$$

Example 2.1. For $k=2^{10}, m(k)=7$ and $t(k, 633)=N(k)=m(k)=7$.
For $k=2^{16}, m(k)=12$ and $t(k, 40,503)=N(k)=m(k)=12$.
In the above examples, $N(k)=m(k)$. However, $N(k)<m(k)$ for some specific values of $k$; e.g. $k=2^{12}$. (See Subsection 3.1, Case 1.)

## 3 Worst-Case Analysis of $\boldsymbol{J} W \boldsymbol{A}$

In this section, we show how to find the largest number of iterations $N(k)$ for every integer $k>0$, and we exhibit all the values of $c$ corresponding to the worst case of $J W A$.

For $p \leq m=m(k)$ and $c>0$ integer, let $I_{p}(k)$ and $J_{p}(k)$ be two sets defined as follows,

$$
\begin{aligned}
& I_{p}(k)=\left\{c \mid\left(F_{p} / F_{p+1}\right) k<c<\left(F_{p+1} / F_{p+2}\right) k\right\} \text { for } p \text { even, } \\
& I_{p}(k)=\left\{c \mid\left(F_{p+1} / F_{p+2}\right) k<c<\left(F_{p} / F_{p+1}\right) k\right\} \text { for } p \text { odd }
\end{aligned}
$$

and

$$
J_{p}(k)=I_{p}(k) \cap ;\{c \mid \operatorname{gcd}(k, c)=1\} .
$$

Proposition 3.1. Let $k>9$ (i.e. $m(k) \geq 3$ ), and let $c$ and $n$ be two positive integers such that $\operatorname{gcd}(k, c)=1$ and $s \leq m(k)=m$. The four following properties hold
(i) $c \in I_{n}(k) \Longrightarrow k / c=[1,1, \ldots, 1, x]$, where $[1,1, \ldots, 1, x]$ denotes a continued fraction having at least $n$ times a " 1 " (including the leftmost 1 ), and $x$ is a sequence of positive integers (see e.g. [1]).
(ii) If $J_{m-1}(k) \neq \emptyset$, then $N(k)=m$ or $m-1$.
(iii) If $J_{m-2}(k) \neq \emptyset$, then $N(k)=m,(m-1)$ or $(m-2)$.
(iv) If $k=2^{s}, N(k)=m,(m-1)$ or $(m-2)$.

Proof.
(i) Let $a_{n} / b_{n}=[1,1, \ldots, 1]=F_{n+1} / F_{n}$ be the $n$-th convergent of the golden ratio $\phi$, containing $n$ times the value " 1 " (see $[1,4]$ for more details). To prove (i), we show that $F_{n+1} / F_{n}$ is the $n$-th convergent of the rational number $k / c$; in other words,

$$
\begin{equation*}
\left|(k / c)-\left(F_{n+1} / F_{n}\right)\right|<1 /\left(F_{n}\right)^{2} . \tag{4}
\end{equation*}
$$

Now, $\left(F_{n+1}\right)^{2}-F_{n} F_{n+2}=(-1)^{n}$ and, since $c \in I_{n}(k)$,

$$
\left|(k / c)-\left(F_{n+1} / F_{n}\right)\right|<\left|\left(F_{n+1}\right)^{2}-F_{n} F_{n+2}\right| /\left(F_{n} F_{n+1}\right)=1 /\left(F_{n} F_{n+1}\right)<1 /\left(F_{n}\right)^{2} .
$$

(ii) First, recall an invariant loop property which is also an Extended Euclidean Algorithm property: for $i=1, \ldots,(t-1)$, where $t=t(k, c)$, we have that

$$
\begin{equation*}
n_{i}\left|d_{i+1}\right|+n_{i+1}\left|d_{i}\right|=k \tag{5}
\end{equation*}
$$

We first prove that $n_{m-2}>\sqrt{k}$. In fact, if we assume that $J_{m-1}(k) \neq \emptyset$, then from (i), there exists an integer $c$ such that $k / c=[1,1, \ldots, 1, x]$ with $(m-1)$ such 1 's. Then, $q_{i}=1$ and $\left|d_{i}\right|=F_{i+1}$ for $i=1, \ldots,(m-1)$.
Now if $n_{m-2}<\sqrt{k}$, then, since $n_{m-1}<n_{m-2}$,

$$
\begin{aligned}
k & =n_{m-2}\left|d_{m-1}\right|+n_{m-1}\left|d_{m-2}\right|=n_{m-2} F_{m}+n_{m-1} F_{m-1} \\
& <\sqrt{k}\left(F_{m}+F_{m-1}\right)=\sqrt{k} F_{m+1},
\end{aligned}
$$

and hence, $\sqrt{k}<F_{m+1}$, which contradicts the definition of $m(k)$, and $n_{m-2}>\sqrt{k}$. If $n_{m-1}<\sqrt{k}$, then $t(k, c)=m-1$ and $N(k) \geq m-1$; else, if $n_{m-1}>\sqrt{k}$, then $N(k)=m$.
(iii) The proof is similar to the previous one. There exists an integer $c$ such that $q_{i}=1$ and $|d i|=F_{i+1}$ for $i=1, \ldots,(m-2)$. So, $n_{m-3}>\sqrt{k}$, and the result follows.
(iv) Let $\Delta_{m-2}$ be the size of the interval $I_{m-2}$. Then,

$$
\begin{aligned}
\Delta_{m-2} & =\left|\left(F_{m-2} / F_{m-1}\right) k-\left(F_{m-1} / F_{m}\right) k\right| \\
& =k\left|F_{m-2} F_{m}-\left(F_{m-1}\right)^{2}\right| /\left(F_{m-1} F_{m}\right)=k /\left(F_{m-1} F_{m}\right) .
\end{aligned}
$$

Since

$$
2 F_{m-1} F_{m}<\left(F_{m-1}+F_{m}\right)^{2}=\left(F_{m+1}\right)^{2} \text { and }\left(F_{m+1}\right)^{2} \leq k, \text { then } \Delta_{m-2}>2
$$

Thus, out of two consecutive values within $I_{m-2}(k)$, at least one integer is odd. Therefore, $J_{m-2}(k) \neq \emptyset$ and we can apply (iii). (Note that this argument is not valid when $k$ is not a power of 2.)

## Remark 3.1.

1. If $J_{m}(k) \neq \emptyset$, then $N(k) \geq m-1$, since $J_{m}(k) \subset J_{m-1}(k) \subset J_{m-2}(k)$.
2. The relation $N(k)=m-2$ holds for several $k$ 's (e.g. for $k=90$ ).
3. For any given integer $k$, there may exists a positive integer $c$ such that $c \notin J_{m}(k)$, whereas $t(k, c)=m$. Such is the case when $k=15,849: m=10$, $I_{m}(k)=\{9,795\}$ and, since $\operatorname{gcd}(k, 9,795) \geq 3, J_{m}(k)=\emptyset$. However, for $c=11,468, t(k, 11,468)=10$.

This last example shows that $J_{m}(k)$ is not made of all integers $c$ such that $t(k, c)=m$, with $\operatorname{gcd}(k, c)=1$. Proposition 3.2 shows how to find all such numbers. For the purpose, two technical lemmas are needed first.

Lemma 3.1. For every $m \geq 3$, the following three implications hold.
(i) $\exists i\left|q_{i}=2 \Longrightarrow F_{m+1}+F_{m-1} \leq\left|d_{m}\right|\right.$.
(ii) $\exists i\left|q_{i} \geq 3 \Longrightarrow\right| d_{m} \mid \geq F_{m+2}>\sqrt{k}$.
(iii) $\exists i, j(i \neq j)\left|q_{i}=q_{j}=2 \Longrightarrow\right| d_{m} \mid \geq F_{m+2}+2 F_{m-3}>\sqrt{k}$.

Proof.
(i) Let $\Delta=\Delta(Q)=\left(\delta_{i}\right)_{i}$ be the sequence defined as: $\delta_{-1}=0, \delta_{0}=1$, and $\delta_{i}=\delta_{i-2}+q_{i} \delta_{i-1}$, for $i=1,2, \ldots, m$ with $Q=(1,2,1, \ldots, 1)$. An easy calculation yields $\delta_{i}=F_{i+1}+F_{i-1}$ for $i=1,2, \ldots, m$.
On the other hand, let $\left(d_{i}\right)_{i}$ be a sequence satisfying (3). We show that $\left|d_{m}\right| \geq$ $\delta_{m}=F_{m+1}+F_{m-1}(m \geq 3)$, and $\Delta$ is thus leading to the smallest possible $\left|d_{m}\right|$ satisfying the assumption in (i), i.e. $\left|d_{m}\right|=F_{m+1}+F_{m-1}(m \geq 3)$. More precisely, If $D=D(Q)$ with $Q=(2,1,1, \ldots, 1)$, then $\left|d_{2}\right|=3,\left|d_{3}\right|=5$, and $\left|d_{m}\right|=F_{m+2}$, whereas $\delta_{2}=3, \delta_{3}=4$ and $\delta_{m}=F_{m+1}+F_{m-1}$. Thus, $\left|d_{m}\right|>\delta_{m}$.

If $D=D(Q)$ with $Q=(1,1, \ldots, 2, \ldots, 1)$ and $q_{p}=2$ for some $p \geq 3$, then $\left|d_{p}\right|=F_{p-1}+2 F_{p}=F_{p+2}$ and $\left|d_{p+1}\right|=F_{p}+F_{p+2}$, whereas $\delta_{p}=F_{p+1}+F_{p-1}$ and $\delta_{p+1}=F_{p+2}+F_{p}$. It is then clear that $\left|d_{i}\right|>\delta_{i}$ for $i \geq p$, and $\left|d_{m}\right| \geq$ $\delta_{m}=F_{m+1}+F_{m-1}$.
(ii) Similarly, let $\Delta=\Delta(Q)$ defined by $Q=(1,3,1, \ldots, 1)$, and let $D$ be a sequence satisfying the assumption. Then $\left|d_{m}\right| \geq \delta_{m}=F_{m+2}(m \geq 3)$.

If $D=D(Q)$ with $Q=(3,1, \ldots, 1)$, then $\left|d_{2}\right|=4,\left|d_{3}\right|=7$, whereas $\delta_{2}=4$ and $\delta_{3}=5$. Clearly, $\left|d_{i}\right|>\delta_{i}$ for $i=3$, and $\left|d_{m}\right|>\delta_{m}>F_{m+2}$.

If $D=D(Q)$ with $Q=(1,1, \ldots, 3, \ldots, 1)$ and $q_{p}=3$ for $p=3$, then $\left|d_{p}\right|=$ $F_{p-1}+3 F_{p}=F_{p+3}+F_{p-2}$, and $\left|d_{p+1}\right|=F_{p+3}+F_{p}+F_{p-2}$, whereas $\delta_{p}=$ $F_{p+2}+F_{p-3}$ and $\delta_{p+1}=F_{p+3}+F_{p-2}$. Therefore, $\left|d_{i}\right| \geq \delta_{i}$ for $i \geq p$, and $\left|d_{m}\right| \geq \delta_{m}=F_{m+2}+F_{m-3}>F_{m+2}$.
(iii) The proof is similar to the previous one with $Q=(1,2,1, \ldots, 1,2,1)$. For such a choice of $Q,\left|d_{m}\right| \geq \delta_{m}=F_{m+2}+2 F_{m-3}$, and the result follows.

Lemma 3.2. For every $m \geq 3$, let $Q=(1,1, \ldots, 1,2,1, \ldots, 1)$, and let $p$ be the index such that $q_{p}=2\left(q_{j}=1\right.$ for $\left.j \neq p, 1 \leq j \leq m\right)$. Then, for $p=1,2, \ldots, m$, $\left|d_{m}\right|$ explicitly expresses as

$$
\left|d_{m}\right|=F_{m-p+1} F_{p+2}+F_{m-p} F_{p} .
$$

Proof. The proof proceeds along the same arguments as for Lemma 3.1.
Proposition 3.2. For every integer $k \geq 9(m \geq 3)$, if $t(k, c)=m$, then
either $c \in J_{m}(k)$,
or $k / c=[1, \ldots, 1,2,1, \ldots, 1, x]$. That is, there exists $i \in\{1, \ldots, m\}$ such that $q_{i}=2$ and for any $j \neq i, j \leq m$ and $q_{j}=1$.

In that case, the inequality $F_{m+1}+F_{m-1}<\sqrt{k}$ holds.
Proof. The proof follows from the inequalities (2) and Lemma 3.1.

### 3.1 Application of Proposition 3.2

The two following cases are examplified in Table 1. Assume $J_{m}(k)=\emptyset$.
Case 1: $N(k) \leq m(k)-1$ holds, for example when $k=2^{6}, 2^{8}$ or $2^{12}$, etc. (the inequality $F_{m+1}+F_{m-1}>\sqrt{k}$ holds).

Case 2: $N(k)=m(k)$. The procedure that determines all possible integers $c$ in the worst case is described in Section 4.

## 4 Worst-Case Occurrences

Assuming that $J_{m}(k)=\emptyset$, we search for the positive integers $c$ such that $t(k, c)=$ $m(k)$.

Step 1. Consider each value of $p(p=1,2, \ldots, m)$, and select the $p$ 's that meet the condition $\left|d_{m}\right|<\sqrt{k}$ (Lemma 3.1 provides all values of $\left|d_{m}\right|$ for each such $m)$. If $t(k, c)$ is still equal to $m$, then there exists a pair $\left(n_{m-1}, n_{m}\right)$ satisfying the Diophantine equation

$$
\begin{equation*}
n_{m-1}\left|d_{m}\right|+n_{m}\left|d_{m-1}\right|=k \tag{6}
\end{equation*}
$$

under the two conditions

$$
\begin{equation*}
\operatorname{gcd}\left(n_{m}, n_{m-1}\right)=1 \quad \text { with } \quad n_{m}<\sqrt{k}<n_{m-1} \tag{7}
\end{equation*}
$$

and

$$
\begin{equation*}
0<n_{m},\left|d_{m}\right|<\sqrt{k} \tag{8}
\end{equation*}
$$

The system of equations (6)-(7)-(8) is denoted by $\left(\Sigma_{Q}\right)$, since it depends on $\left|d_{m}\right|$ and $\left|d_{m-1}\right|$, and thus on $Q$. Further, Eq. (6) is the expression of (5) when $i=$ $m-1$, Eq. (8) expresses the exit test condition of $J W A$ and Eq. (7) ensures that $\operatorname{gcd}(k, c)=\operatorname{gcd}\left(n_{m}, n_{m-1}\right)=1$.
Step 2. Eq. (6) is solved modulo $\left|d_{m-1}\right|$. For $0 \leq a<\left|d_{m-1}\right|$,

$$
n_{m-1} \equiv k /\left|d_{m}\right|\left(\bmod \left|d_{m-1}\right|\right) \equiv a\left(\bmod \left|d_{m-1}\right|\right)
$$

and, from the inequality

$$
\sqrt{k}<n_{m-1}<k /\left|d_{m}\right|
$$

we have $n_{m-1}=a+r\left|d_{m-1}\right|$, where $r$ is a positive integer such that

$$
(\sqrt{k}-a) /\left|d_{m-1}\right|<r<\left(k /\left|d_{m}\right|-a\right) /\left|d_{m-1}\right| .
$$

Therefore, there exists only a finite number of solutions for $n_{m-1}$. Each solution of Eq. (6) (if any) fixes a positive integer $c \equiv n_{m-1} /\left|d_{m-1}\right|(\bmod k)$ such that $t(k, c)=m$, and $N(k)=m$.

Example 4.1. Let $k=15,849$ and $m=10$. By Lemma 3.2 (with $m=10$ and $p=2$ ), Eq. (6) yields $123 n_{m-1}+76 n_{m}=15,849$. Solving modulo 76 gives $n_{m-1}=127$ and $n_{m}=3$. The pair $\left(n_{m-1}, n_{m}\right)$ corresponds to the value $c=11,468$, and $t(k, c)=N(k)=m(k)=10$, while $J_{m}=\emptyset$.

### 4.1 Applications

The following algorithm summarizes the results by computing the values of $N(k)$.

## Remark 4.1.

1. The algorithm terminates, since $N(k) \geq 1$ for every $k \geq 3$. Indeed, the first condition in the repeat loop always holds when $t=1$, since $k-1 \in J_{1}(k)$ ( $k \geq 3$ ).
2. In the algorithm, $\left(\Sigma_{Q}\right)$ corresponds to the system (6)-(7)-(8), where $t$ substitutes for $m$.

The case when $k>1$ is an even power of 2 is of special importance, since it is related to the practical implementation of $J W A$ [8]. Table 1 gives some of the values of $N(k)$, for $k=2^{2 s}(2 \leq s \leq 16)$.

Table 1: Values of $m(k)$ and $N(k)$ for $k=2^{2 s}(2 \leq s \leq 16)$.

## 5 Concluding Remarks

First we must point out that the condition $\operatorname{gcd}(k, c)=1$ is a very strong requirement: it eliminates many integers within $I_{m}(k)$ and many solutions of $\left(\Sigma_{Q}\right)$. This can be seen e.g. when $k=2^{24}$. Then $m(k)=17$, and the choice of $Q=(1,2,1, \ldots, 1)$, (i.e., $\left|d_{m}\right|=3,571,\left|d_{m-1}\right|=2,207$ ) yields $n_{m-1}=4,404$ and $n_{m}=476$, which leads to the solution $c=12,140,108$. We still have $t(k, c)=m(k)=17$ but unfortunately $\operatorname{gcd}(k, c) \neq 1$, and $N(k)=16=m(k)-1$.

Checking whether $J_{m-2}(k)$ is empty is easy. It gives a straightforward answer to the question whether

$$
m(k)-2 \leq N(k) \leq m(k)
$$

or not.
The following problems remain open.

- The example in Table 1 shows that, for $k=2^{2 s}(2 \leq s \leq 16)$, the values of $N(k)$ are either $N(k)=m(k)$ or $N(k)=m(k)-1$. Does the inequality

$$
m(k)-1 \leq N(k)
$$

always hold for $k=2^{2 s}(n \geq 2)$ ?

- $N(k)$ is never less than $m(k)-2$. Are the inequalities

$$
m(k)-2 \leq N(k) \leq m(k)
$$

true for every positive integer $k \geq 9$ ?

- Find the greatest lower bound of $N(k)$ as a function of $m(k)$.
