The motion of a fluid-rigid ball system at the zero limit of the rigid ball radius

Ana Leonor Silvestre, Takéo Takahashi

Abstract

We study the limiting motion of a system of a rigid ball moving in a Navier-Stokes fluid flow in R 3 as the radius of the ball goes to zero. Recently, Dashti and Robinson solved this problem in the 2-D case, in the absence of rotation of the ball [Arch. Rational Mech. Anal. 200 (2011) 285–312]. This restriction was caused by the difficulty in obtaining appropriate uniform bounds on the second order derivatives of the fluid velocity when the rigid body can rotate. In this paper, we show how to obtain the required uniform bounds on the velocity fields in the 3-D case. These estimates then allow to pass to the zero limit of the ball radius and show that the solution of the coupled system converges to the solution of the Navier-Stokes equations describing the motion of only fluid in the whole space. The trajectory of the centre of the ball converges to a fluid particle trajectory, which justifies the use of rigid tracers for finding Lagrangian paths of fluid flow.

1 Introduction

Suppose that, relatively to an inertial reference frame, a homogeneous three-dimensional rigid body, represented by a closed ball $B_r(t) := \{y \in \mathbb{R}^3 : |y - h(t)| \leq r\}$, is moving in a Navier-Stokes liquid which occupies the exterior domain $\Omega_r(t) := \mathbb{R}^3 \setminus B_r(t)$. The function $h = h(t)$ describes the trajectory of the center of mass of the rigid body, which is also allowed to rotate, $\omega = \omega(t)$ being its angular velocity. Denoting by $v = v(t, y)$ the Eulerian velocity of the fluid and $q = q(t, y)$ the corresponding pressure in the same inertial frame, the evolution of the motion of the system body-liquid is described by the initial boundary value problem

In the above system, we have denoted by $n(t) = n(t, y)$ the external unit normal to $\Omega_r(t)$, and by $T(v, q)$ the stress tensor of the liquid, defined by

where ν is the viscosity coefficient of the liquid and where I₃ is the identity matrix of order 3. Finally, m_r and J_r are respectively the mass of the body, and the moment or the matrix of inertia of the body. We have assumed that the density of the ball is constant and we denote it by ρ . Then m_r and J_r have explicit formulas:

Note that J_r is independent of time since the structure is a homogeneous ball.

By means of the changes of variables

system (1)-(7) can be written in a frame attached to the rigid ball:

The advantage of this formulation is that now the fluid domain is known and time-independent $\Omega_r = \{x \in \mathbb{R}^3 : |x| > r\}.$ As concerns the well-posedness of the system (13)-(19), we refer to the works of Galdi and Silvestre [9], Takahashi and Tucsnak [25]. In particular, for all r , for any $(u^0, \ell^0, \omega^0) \in H^1(\Omega_r) \times \mathbb{R}^3 \times \mathbb{R}^3$ such that

the system (13) – (19) admits a unique local strong solution

Note that the maximal time of existence may be finite and may depend on r . In the last years, fluid–structure systems such as system (13) – (19) have been extensively studied. After the pioneer results of Judakov [18], Serre [22], and Weinberger [27], many results have been published in the case of exterior domain (see, for instance, [23, 3, 11, 10, 8]) or in the case of bounded domain (see, for instance, [1, 5, 6, 7, 12, 13, 15]).

As in the work of Dashti and Robinson [4], our aim is to investigate the limit of system (13)- (19) when the radius r of the ball goes to 0. We show that the limiting system is the following Navier–Stokes system in \mathbb{R}^3 :

Dashti and Robinson [4] have solved this problem in \mathbb{R}^2 , in the absence of rotation, considering $\omega = 0$ by imposing an external torque and zero initial angular velocity of the disc. This last restriction has been made because of the difficulty in obtaining L^2 -estimates independent of r for D^2u_r when the particle can rotate, see Lemma 4 of [4]. Such estimates are crucial to pass to the limit of the ball radius in the equations of motion of the fluid and show that the solution of the coupled system converges to the solution of the Navier-Stokes equations describing the motion of only fluid in the whole space.

The study of this type of asymptotic analysis problems is also considered in [16], [17] for the case of a fixed obstacle. In [21], a simplified model of combustion is analyzed with this approach.

In this paper we extend the results of Dashti and Robinson, considering the three-dimensional fluid-ball interaction problem (13)-(19). We show that the required uniform bounds on the velocity fields can be obtained by a careful analysis of a steady Stokes-type problem associated with the problem (13)-(19). Dashti and Robinson derived the estimates for D^2u_r based on the classical exterior steady Stokes problem with a rigid velocity on the boundary. Here, we decompose the solution of the Stokes problem associated with the fluid-structure interaction problem in such a way that the explicit solutions for Stokes flow past a translating ball and around a rotating ball can be used to obtain a precise information about the dependence in r when combined with the Newton's laws-type equations of the modified Stokes problem (see Theorem 3.1).

To state our main result more precisely, we extend the fluid velocities u_r in B_r by the rigid velocities:

This convention is used in all that follows. We also use some classical notation for functional spaces of divergence-free velocities H and V . We define them in Section 2 (see (28), (29)).

Theorem 1.1. Assume $(u_r^0)_{0 \leq r \leq r^*}$ is a bounded sequence of V with

Then there exists T independent of r such that for all r, the strong solution (u_r, ℓ_r, ω_r) of (13)–(19) associated to $(u_r^0, \ell_r^0, \omega_r^0)$ exists on $(0, T)$. Moreover, for all $r_0, R > 0$,

where (u, ℓ) is the solution of (20)–(22), (23) associated to u^0 .

The plan of the paper is the following. In Section 2, we introduce some notation and prove some auxiliary interpolation inequalities. Section 3 is devoted to the analysis of the above mentioned steady Stokes-type problem, where we obtain an uniform estimate in r for the second derivatives of the solution of such a problem in terms of a norm of the associated Stokestype operator. In Section 4, we obtain a number of uniform estimates for the fluid-structure interaction problem (13) – (19) and, finally, in Section 5, we pass to the zero limit of the ball radius to obtain the Navier-Stokes flow $(20)-(22)$. For the reader's convenience, we include in an Appendix (Section A) some calculations for the explicit Stokes solutions that have been used in Section 3.

2 Notation and auxiliary results

For a sufficiently regular vector field $v : \mathbb{R}^3 \to \mathbb{R}^3$, we denote by ∇v the second order tensor field whose components $(\nabla v)_{jk}$ are given by $\frac{\partial v_k}{\partial x_j}$, and by $D(v)$ we denote the symmetric part of ∇v (see (9)). The second order derivatives of v will be indicated by D^2v , more precisely, for each $j \in \{1, 2, 3\}, D^2v_j$ is the Hessian matrix of v_j .

We shall use standard notation for function spaces. So, for instance, $L^s(\mathcal{D})$ and $H^m(\mathcal{D})$ will denote the usual Lebesgue and Sobolev spaces on the domain \mathcal{D} , with norms $\|\cdot\|_{s,\mathcal{D}}$ and $\|\cdot\|_{m,2,\mathcal{D}},$ respectively. Notations like $L^s(\mathcal{D})^3$ (resp. $L^s(\mathcal{D})^{3\times 3}$), $H^m(\mathcal{D})^3$ (resp. $H^m(\mathcal{D})^{3\times 3}$), etc. will be used to denote analogous spaces of vector-valued functions (resp. tensor-valued functions).

We also use the following classical notation

In the next lemma, we establish a useful interpolation inequality in the exterior domain Ω_r , where the embedding constant is independent of r.

Lemma 2.1. Let $u \in H^2(\Omega_r)$. Then the following inequality holds

with a constant C independent of u and r.

Proof. Let $\mathcal{D} \subseteq \mathbb{R}^3$ be an exterior domain. In [2], Crispo and Maremonti proved, in particular, that any function $u \in L^2(\mathcal{D})$ with $D^2u \in L^2(\mathcal{D})^{3 \times 3}$ satisfies

where C is a constant independent of u .

Let $u \in L^2(\Omega_r)$. Then, by a simple change of variables, we find the relation

where $u^r(x) := u(rx)$ $(x \in \Omega_1)$. Analogously, if the second derivatives of u belong to $L^2(\Omega_r)$, we have

We have also the following estimate.

Lemma 2.2. Let $u \in H^2(\Omega_r)$. Then the following inequality holds

with a constant C independent of u and r.

Proof. We proceed as in the proof of Lemma 2.1. More precisely, using [2] again, we know that for an exterior domain $\mathcal{D} \subseteq \mathbb{R}^3$, a function $u \in L^2(\mathcal{D})$ with $D^2u \in L^2(\mathcal{D})^{3 \times 3}$ satisfies

where C is a constant independent of u. Then for $u \in L^2(\Omega_r)$ with $D^2u \in L^2(\Omega_r)^{3\times3}$, we set $u^{r}(x) := u(rx)$ $(x \in \Omega_1)$, and we recall

Hence, applying (31) to u^r and Ω_1 yields the result.

As in Lemma 2 in [4], we can prove a useful result which shows how the trace inequality for the domain Ω_r depends on r in the three-dimensional case.

Lemma 2.3. Let $w \in L^1_{loc}(\overline{\Omega_r})$ be such that $\nabla w \in L^2(\Omega_r)^3$. Then there exist constants w_0 and C such that

where the constant C is independent of w and r. If $w \in L^6(\Omega_r)$ then $w_0 = 0$.

Proof. Let $w \in L^1_{loc}(\overline{\Omega_r})$ be such that $\nabla w \in L^2(\Omega_r)^3$ and set $w^r(y) := w(ry)$ $(y \in \Omega_1)$. It is well known (see [2]) that there exist constants w_0 and C such that

where the constant C is independent of w and r, and $w_0 = 0$ if $w \in L^6(\Omega_r)$. Now

and since

from (32) , we get

Finally, by changing variables again,

Now we recall some function spaces appropriate for studying the system (13)-(19). The spaces

are Hilbert spaces for the inner products of $L^2(\mathbb{R}^3)^3$ and $H^1(\mathbb{R}^3)^3$, respectively. It is well known that, for each $\phi \in \mathcal{H}_r$, there exist $\xi_{\phi} \in \mathbb{R}^3$ and $\omega_{\phi} \in \mathbb{R}^3$ such that

We also define a global density by

and the following inner product of $L^2(\mathbb{R}^3)^3$

The corresponding norm is equivalent to the usual L^2 norm. The notation we choose for this inner product comes from the fact that if $u, v \in \mathcal{H}_r$, then

It is also common (see [8]) to consider the space

and its completion \mathcal{W}_r with respect to the seminorm $||D(v)||_{2,\mathbb{R}^3}$. In what follows, we use several times the following classical relation

for positive constants C independent of v and r .

Finally let us give the following result.

Lemma 2.4. Let $u \in V_r$ be such that $u_{|\Omega_r} \in H^2(\Omega_r)^3$ and $u_{|B_r}(x) = \ell + \omega \times x$. Then

Proof. We follow an idea of [4]. Since the normal to Ω_r is given by $n(x) = -\frac{x}{r}$, we have

3 The Stokes-type problem and the operator A_r

The semigroup approach of [25] for problem (13)-(19) is based on the operator defined by

\n(38)

with \mathbb{P}_r the orthogonal projector in $L^2(\mathbb{R}^3)^3$ onto \mathcal{H}_r (with respect to the inner product $(\cdot, \cdot)_{\mathcal{H}_r}$) and

$$
\mathcal{A}_r u := \begin{cases}\n-\nu \Delta u & \text{in } \Omega_r \\
\frac{2\nu}{m_r} \int_{\partial B_r} D(u) n \, dS + \left[2\nu J_r^{-1} \int_{\partial B_r} y \times D(u) n \, dS\right] \times x & \text{in } B_r.\n\end{cases}
$$
\n(39)

In this section, we analyze the operator A_r . Given $u \in D(A_r)$, there exist $\ell \in \mathbb{R}^3$ and $\omega \in \mathbb{R}^3$ such that

$$
u_{|B_r}(x) = \ell + \omega \times x.
$$

Let $f := A_r u$. Since $f_{\vert \Omega_r} \in L^2(\Omega_r)^3$, there exists (see, for instance, [25]) $p \in L^2_{loc}(\overline{\Omega_r})$ with $\nabla p \in L^2(\Omega_r)^3$ such that

$$
m_r \ell_f = -\int_{\partial B_r} T(u, p) n \, \mathrm{d}S,\tag{44}
$$

$$
J_r \omega_f = -\int_{\partial B_r} x \times T(u, p) n \, dS. \tag{45}
$$

Our aim is to show that

$$
||D^2u||_{2,\Omega_r} \leq C \left[||\nabla u||_{2,\mathbb{R}^3} + (||f_{|\Omega_r}||_{2,\Omega_r}^2 + m_r |\ell_f|^2 + J_r \omega_f \cdot \omega_f)^{\frac{1}{2}} \right]
$$

with C independent of u, f and r. Recall that $m_r = \mathcal{O}(r^3)$ and $J_r = \mathcal{O}(r^5)$. **Theorem 3.1.** There exists a positive constant C independent of r such that

u^{(1)}(x) = 0 \quad \text{for } x \in \partial B_r,\tag{50}
$$

$$
\lim_{|x| \to \infty} u^{(1)}(x) = 0
$$
\n(51)

and

$$
(u^{(2)}(x), p^{(2)}(x)) = \left(\frac{3r}{4}\left[\frac{\ell}{|x|} + \frac{(\ell \cdot x)x}{|x|^3}\right] + \frac{r^3}{4}\left[\frac{\ell}{|x|^3} - 3\frac{(\ell \cdot x)x}{|x|^5}\right], \frac{3\nu r \ell \cdot x}{2}\right) \tag{52}
$$

$$
(u^{(3)}(x), p^{(3)}(x)) = \left(r^3 \frac{\omega \times x}{|x|^3}, 0\right). \tag{53}
$$

Using the results of Section A, we see that $(u^{(2)}, p^{(2)})$ and $(u^{(3)}, p^{(3)})$ satisfy

$$

\n
$$
\int_{\partial B_r} x \times T(u^{(2)}, p^{(2)}) n dS = 0
$$
\n(54)

and

$$
\nabla \cdot T(u^{(3)}, p^{(3)}) = 0, \text{ in } \Omega_r,
$$

\n
$$
\nabla \cdot u^{(3)} = 0, \text{ in } \Omega_r,
$$

\n
$$
u^{(3)}(x) = \omega \times x, x \in \partial B_r,
$$

\n
$$
\lim_{|x| \to \infty} u^{(3)}(x) = 0,
$$

\n
$$
\int_{\partial B_r} T(u^{(3)}, p^{(3)}) n dS = 0,
$$

\n
$$
\int_{\partial B_r} x \times T(u^{(3)}, p^{(3)}) n dS = 8\pi \nu r^3 \omega.
$$
\n(55)

From (52) , (53) and the results of Section A, we deduce the existence of a positive constant C independent of r such that

$$
||D^2u^{(2)}||_{2,\Omega_r} \leqslant C|\ell|r^{-1/2} \tag{56}
$$

$$
||D^2u^{(3)}||_{2,\Omega_r} \leq C|\omega|r^{1/2}.\tag{57}
$$

Writing (44) and (45) in terms of the decomposition (47) of (u, p) yields

$$
6\pi\nu r\ell = -m_r \ell_f - \int_{\partial B_r} T(u^{(1)}, p^{(1)}) n \, dS
$$

$$
8\pi\nu r^3 \omega = -J_r \omega_f - \int_{\partial B_r} x \times T(u^{(1)}, p^{(1)}) n \, dS.
$$

This implies

$$
\ell = -\frac{2r^2}{9\nu}\ell_f - \frac{1}{6\pi\nu r} \int_{\partial B_r} T(u^{(1)}, p^{(1)})n \, dS \tag{58}
$$

$$
\omega = -\frac{r^2}{15\nu}\omega_f - \frac{1}{8\pi\nu r^3} \int_{\partial B_r} x \times T(u^{(1)}, p^{(1)})n \, dS. \tag{59}
$$

By Lemma 1 of [14],

$$
||D^{2}u^{(1)}||_{2,\Omega_{r}} \leq C(||f_{|\Omega_{r}}||_{2,\Omega_{r}} + ||\nabla u^{(1)}||_{2,\Omega_{r}}),
$$
\n(60)

with a constant C independent of r . Moreover, we have

$$
\|\nabla u^{(1)}\|_{2,\Omega_r} \leqslant \|\nabla u\|_{2,\Omega_r} + \|\nabla u^{(2)}\|_{2,\Omega_r} + \|\nabla u^{(3)}\|_{2,\Omega_r} \leqslant \|\nabla u\|_{2,\Omega_r} + C|\ell| r^{1/2} + C|\omega| r^{3/2}
$$

and from (36) and (37) it follows

$$
\|\nabla u^{(1)}\|_{2,\Omega_r} \leqslant C \|\nabla u\|_{2,\mathbb{R}^3}
$$

so that

$$
||D^2u^{(1)}||_{2,\Omega_r} \leqslant C(||f_{|\Omega_r}||_{2,\Omega_r} + ||\nabla u||_{2,\mathbb{R}^3}).
$$
\n(61)

In order to appropriatly bound ℓ and ω from (58) and (59), we begin by showing that the inequality

$$
\left| \int_{\partial B_r} x \times T(u^{(1)}, p^{(1)}) n \, \mathrm{d}S \right| \leqslant C r^{5/2} \| f_{|\Omega_r} \|_{2, \Omega_r},\tag{62}
$$

holds with C independent of r. Indeed, if we consider the functions $H_i(x) := r^3 \frac{e_i \times x}{|x|^3}$, which belong to $L^2(\Omega_r)^3$, and note that for each $i = 1, 2, 3$,

$$
e_i \cdot \int_{\partial B_r} x \times T(u^{(1)}, p^{(1)}) n \, dS = \int_{\partial B_r} e_i \times x \cdot T(u^{(1)}, p^{(1)}) n \, dS = \int_{\partial B_r} H_i \cdot T(u^{(1)}, p^{(1)}) n \, dS,
$$

by Green's formula for the Stokes equations, we have

$$
e_i \cdot \int_{\partial B_r} x \times T(u^{(1)}, p^{(1)}) n \, dS = \int_{\partial B_r} H_i \cdot T(u^{(1)}, p^{(1)}) n \, dS = - \int_{\Omega_r} f \cdot H_i \, dx.
$$

Then (62) follows from the fact that $||H_i||_2 \leq C r^{5/2}$ (see Section A). It remains to show that

\left| \int_{\partial B_r} T(u^{(1)}, p^{(1)}) n \, \mathrm{d}S \right| \leqslant C r^{3/2} (\|f_{|\Omega_r}\|_{2, \Omega_r} + \|\nabla u\|_{2, \Omega_r}),\tag{63}

where, again, C is independent of r . Since

\left| \int_{\partial B_r} T(u^{(1)}, p^{(1)}) n \, dS \right| = \left| \int_{\partial B_r} T(u^{(1)}, p^{(1)} - p_0) n \, dS \right| \leqslant C r(\|\nabla u^{(1)}\|_{2, \partial B_r} + \|p^{(1)} - p_0\|_{2, \partial B_r})
$$

for any $p_0 \in \mathbb{R}$, we can modify the pressure $p^{(1)}$ in such a way that, according to Lemma 2.3,

$$
||p^{(1)} - p_0||_{2, \partial B_r} \leq C r^{1/2} ||\nabla p^{(1)}||_{2, \Omega_r}.
$$

Also by Lemma 2.3,

Now, we only have to note that

Finally, (58) and (59) combined with (63) and (62) yield

|\omega| \leq C r^2 |\omega_f| + C \frac{1}{r^{1/2}} ||f_{|\Omega_r}||_{2,\Omega_r},
$$

for constants C independent of r . Coming back to (56) and (57) with the above estimates for $|\ell|$ and $|\omega|$, we get

$$
||D^2u^{(2)}||_{2,\Omega_r} \leq C r^{3/2} |\ell_f| + C(||f_{|\Omega_r}||_{2,\Omega_r} + ||\nabla u||_{2,\mathbb{R}^3})
$$

$$
||D^2u^{(3)}||_{2,\Omega_r} \leq C r^{5/2} |\omega_f| + C ||f_{|\Omega_r}||_{2,\Omega_r}
$$

which together with (61) and (47) yields

$$
||D^2u||_{2,\Omega_r} \leq C r^{3/2} |\ell_f| + C r^{5/2} |\omega_f| + C ||f_{|\Omega_r}||_{2,\Omega_r} + C ||\nabla u||_{2,\mathbb{R}^3} \leq C (||A_r u||_{\mathcal{H}_r} + ||\nabla u||_{2,\mathbb{R}^3}).
$$

4 Estimates independent of r for the solution of (13) – (19)

Assume that $u_r^0 \in V_r$ for some $r > 0$. Then, writing $u_r^0 = \ell_r^0 + \omega_r^0 \times x$ in B_r , and taking $(u_r^0, \ell_r^0, \omega_r^0)$ for the initial conditions of $(13)-(19)$, we obtain (see, for instance, [25]) the existence and uniqueness of a strong solution

$$
u_r \in H^1(0,T;L^2(\mathbb{R}^3)^3) \cap L^\infty(0,T;H^1(\mathbb{R}^3)^3) \cap L^2(0,T;H^2(\Omega_r)^3).
$$

Here and in what follows, we extend u_r to B_r by $\ell_r + \omega_r \times x$. Let us note that the maximal time of existence T may be finite and may depend on r .

We can write (13)–(17) in an abstract way by using the operator A_r defined by (38)–(39) and the following nonlinear operator:

$$
\mathcal{N}_r(u) = \begin{cases}\n-((u - \ell) \cdot \nabla) u & \text{in } \Omega_r \\
0 & \text{in } B_r\n\end{cases} \quad (u \in \mathcal{V}_r),
$$

and its projection in \mathcal{H}_r

$$
N_r(u) := \mathbb{P}_r \mathcal{N}_r(u).
$$

With this notation, we can write (13) – (17) as

$$
\partial_t u_r + A_r u_r = N_r(u_r). \tag{64}
$$

Theorem 4.1. Assume $(u_r^0)_{0 \le r \le r^*}$ is bounded in $H^1(\mathbb{R}^3)^3$, $u_r^0 \in \mathcal{V}_r$ for all r. Then there exists T independent of r such that

- (i) $(u_r)_{0 \leq r \leq r^*}$ is bounded in $H^1(0,T; L^2(\mathbb{R}^3)^3) \cap L^\infty(0,T; H^1(\mathbb{R}^3)^3) \cap L^2(0,T; H^2(\Omega_r)^3)$,
- (ii) $(\ell_r)_{0 \leq r \leq r^*}$ is bounded in $L^2(0,T)^3$.

Proof. Let us multiply (64) by u_r and integrate over Ω_r . We obtain

$$
\frac{1}{2}\frac{d}{dt}\|u_r\|_{\mathcal{H}_r}^2 + 2\nu\|D(u_r)\|_{2,\Omega_r}^2 = 0\tag{65}
$$

which, combined with (35) yields

$$
\sup_{t \in (0,T)} \|u_r(t)\|_{2, \mathbb{R}^3}^2 + \nu \int_0^T \|\nabla u_r\|_{2, \mathbb{R}^3}^2 \, dt \leqslant C \|u_r^0\|_{2, \mathbb{R}^3}^2. \tag{66}
$$

Now we multiply (64) by A_ru_r and integrate by parts over Ω_r to get

$$
\nu \frac{d}{dt} ||D(u_r)||_{2,\Omega_r}^2 + ||A_r u_r||_{\mathcal{H}_r}^2 = (N_r(u_r), A_r u_r)_{\mathcal{H}_r},
$$
\n(67)

where

$$
(N_r(u_r), A_r u_r)_{\mathcal{H}_r} \leq \|N_r(u_r)\|_{\mathcal{H}_r} \|A_r u_r\|_{\mathcal{H}_r} \leq \|((u_r - \ell_r) \cdot \nabla) u_r\|_{2, \Omega_r} \|A_r u_r\|_{\mathcal{H}_r}.
$$
 (68)

By Hölder's inequality,

$$
||(u_r \cdot \nabla)u_r||_{2,\Omega_r} \le ||u_r||_{\infty,\Omega_r} ||\nabla u_r||_{2,\Omega_r}
$$
\n(69)

and by Lemma 2.4

$$
\| (\ell_r \cdot \nabla) u_r \|_{2, \Omega_r} \leq \| u_r \|_{\infty, \Omega_r} \| \nabla u_r \|_{2, \Omega_r}.
$$
 (70)

Again we use (69), (70) and Lemma 2.1 to get

$$
\begin{aligned} \|\left((u_r - \ell_r) \cdot \nabla \right) u_r \|_{2, \Omega_r} &\leqslant 2 \| u_r \|_{\infty, \Omega_r} \| \nabla u_r \|_{2, \Omega_r} \\ &\leqslant C \| u_r \|_{2, \Omega_r}^{1/4} \| D^2 u_r \|_{2, \Omega_r}^{3/4} \| \nabla u_r \|_{2, \Omega_r} \end{aligned} \tag{71}
$$

with a constant C independent of r. By combining (71) with (67) and (68) , we deduce that

$$
\nu \frac{d}{dt} \|D(u_r)\|_{2,\Omega_r}^2 + \|A_r u_r\|_{\mathcal{H}_r}^2 \leq C \|u_r\|_{2,\Omega_r}^{1/4} \|D^2 u_r\|_{2,\Omega_r}^{3/4} \|\nabla u_r\|_{2,\Omega_r} \|A_r u_r\|_{\mathcal{H}_r}.
$$
 (72)

Now, using Theorem 3.1, and (35) implies

$$
\frac{\nu}{2}\frac{d}{dt}\|\nabla u_r\|_{2,\mathbb{R}^3}^2 + \|A_ru_r\|_{\mathcal{H}_r}^2 \leq C\|u_r\|_{2,\Omega_r}^{1/4}\|\nabla u_r\|_{2,\Omega_r} \|A_ru_r\|_{\mathcal{H}_r}^{7/4} + C\|u_r\|_{2,\Omega_r}^{1/4}\|\nabla u_r\|_{2,\Omega_r}^{7/4} \|A_ru_r\|_{\mathcal{H}_r}
$$

Applying Young's inequality to the above estimate yields

$$
\nu \frac{d}{dt} \|\nabla u_r\|_{2,\mathbb{R}^3}^2 + \|A_r u_r\|_{\mathcal{H}_r}^2 \leqslant C(\|u_r\|_{2,\Omega_r}^2 + 1) \|\nabla u_r\|_{2,\Omega_r}^8 + C\|u_r\|_{2,\Omega_r}^{8/9}
$$

with C independent of r . Using the estimate (66) we get

$$
\nu \frac{d}{dt} \|\nabla u_r\|_{2,\mathbb{R}^3}^2 + \|A_r u_r\|_{\mathcal{H}_r}^2 \leq C(1 + \|u_r^0\|_{2,\mathbb{R}^3}^{8/9} + \|u_r^0\|_{2,\mathbb{R}^3}^2) (\|\nabla u_r\|_{2,\mathbb{R}^3}^2 + 1)^4. \tag{73}
$$

Let $y(t) := 1 + ||\nabla u_r(t)||_{2, \mathbb{R}^3}^2$. Then, from (73) we have

$$
y' \leqslant C y^4
$$

with C independent of r . We conclude that

$$
y(t) \leqslant \frac{y(0)}{\sqrt[3]{1 - 3y(0)^3 C t}}
$$

as long as $t < 1/(3y(0)^3C)$. Let us consider T small enough so that

$$
T < \frac{1}{3C(1 + \|\nabla u_r^0\|_{2, \mathbb{R}^3}^2)^3}.
$$

Since $(u_r^0)_{0 \le r \le r^*}$ is bounded in $H^1(\mathbb{R}^3)^3$, T can be chosen so that it is independent of r. We deduce that for all $t \in [0, T]$,

$$
\|\nabla u_r(t)\|_{2,\mathbb{R}^3}^2 \leqslant C(1 + \|\nabla u_r(0)\|_{2,\mathbb{R}^3}^2) \leqslant \tilde{K}_1
$$

with $\tilde{K_1}$ independent of r. Now from (73),

$$
\int_0^T \|A_r u_r(s)\|_{\mathcal{H}_r}^2 ds \leqslant \tilde{K_2}
$$

with $\tilde{K_2}$ independent of r, which implies with Theorem 3.1

$$
||D^2u_r||_{L^2(0,T;L^2(\Omega_r)^{3\times 3\times 3})}\leqslant \tilde{K_3}
$$

with $\tilde{K_3}$ independent of r. We can find constants $\tilde{K_4}$ and $\tilde{K_5}$ independent of r such that

$$
\|\ell_r\|_{L^2(0,T;\mathbb{R}^3)} \leqslant \tilde{K_4}
$$

and

$$
\|\partial_t u_r\|_{L^2(0,T;L^2(\Omega_r)^3)} \leqslant \tilde{K_5}.
$$

 \Box

.

5 Passage to the zero limit of the ball radius in (13) -(19)

The aim of this section is to prove the main result of the paper.

Applying Theorem 4.1 and using a diagonal process, we deduce that for all $r_0 > 0$,

$$
u_r \rightharpoonup u \quad \text{in} \quad H^1(0, T; L^2(\mathbb{R}^3)^3) \cap L^2(0, T; H^2(\Omega_{r_0})^3) - \text{weak},\tag{74}
$$

$$
u_r \rightharpoonup u
$$
 in $L^{\infty}(0,T; H^1(\mathbb{R}^3)^3)$ – weak^{*}, (75)

$$
\ell_r \rightharpoonup \ell \quad \text{in} \quad L^2(0, T) - \text{weak.} \tag{76}
$$

In particular for any $r_0, u \in L^2(0,T; H^2(\Omega_{r_0})^3)$ and its norm in these spaces is bounded independently of r_0 . Following the proof of [4], we deduce that $u \in L^2(0,T;H^2(\mathbb{R}^3)^3)$. Applying Aubin-Lions-Simon Lemma, and using the fact that $(u_r)_{0 \leq r \leq r^*}$ is bounded in $L^2(0,T;H^1(B_R)^3)$ $H^1(0,T;L^2(B_R)^3)$, we conclude that there exists a subsequence such that

$$
u_r \to u \quad \text{strongly in } L^2(0, T; L^2(B_R)^3). \tag{77}
$$

In order to pass to the limit as $r \to 0$, we write an integral formulation of (13)–(17). Assume $\varphi \in C^1(\mathbb{R}^3)^3$ is divergence free, with compact support in $B_{s,R}$, $R > s > 0$. Then for $r < s$, we multiply (64) by φ to obtain

$$
\int_{\mathbb{R}^3} \rho_r \partial_t u_r \cdot \varphi \, dx + (A_r u_r, \varphi)_{\mathcal{H}_r} = (N_r(u_r), \varphi)_{\mathcal{H}_r} \quad \text{in } (0, T).
$$

By integrating by parts, we deduce from the above equation that

$$
\int_{\mathbb{R}^3} \left(\partial_t u_r - \nu \Delta u_r \right) \cdot \varphi \, dx - \int_{\mathbb{R}^3} \left[\left(u_r - \ell_r \right) \cdot \nabla \right) \varphi \right] \cdot u_r \, dx = 0 \quad \text{in (0, T).} \tag{78}
$$

Using (74)–(76) and (77), we deduce that for all $\varphi \in C^1(\mathbb{R}^3)^3$ divergence free, with compact support in $B_{s,R}$, $R > s > 0$,

$$
\int_{\mathbb{R}^3} \left(\partial_t u - \nu \Delta u + \left((u - \ell) \cdot \nabla \right) u \right) \cdot \varphi \, dx = 0 \quad \text{in } (0, T). \tag{79}
$$

.

We observe that the functions in $C^1(\mathbb{R}^3)^3$ which are divergence free, with compact support in $B_{s,R}, R > s > 0$ are dense in H. To be complete we give below a proof of this result based on [20, pp. 165-166]. Consequently, we deduce that (79) holds for all $\varphi \in L^2(0,T;H)$. In particular, (see, for instance, [26, pp. 14-15]), there exists p with $\nabla p \in L^2(0,T; L^2(\mathbb{R}^3))$ such that

$$
\partial_t u - \nu \Delta u + ((u - \ell) \cdot \nabla) u = -\nabla p \quad \text{in } (0, T) \times \mathbb{R}^3
$$

To recover the initial condition, we apply a classical method: using (74) and (77), we deduce that for any function $\varphi \in C^1([0,T) \times \mathbb{R}^3)^3$ with compact support, we have

$$
\int_{\mathbb{R}^3} u_r(0) \cdot \varphi(0) dx = \int_{(0,T) \times \mathbb{R}^3} u_r \cdot \partial_t \varphi dt dx - \int_{(0,T) \times \mathbb{R}^3} \partial_t u_r \cdot \varphi dt dx \n\to \int_{(0,T) \times \mathbb{R}^3} u \cdot \partial_t \varphi dt dx - \int_{(0,T) \times \mathbb{R}^3} \partial_t u \cdot \varphi dt dx = \int_{\mathbb{R}^3} u(0) \cdot \varphi(0) dx.
$$

Since $u_r^0 \rightharpoonup u^0$ weakly in $L^2(\mathbb{R}^3)^3$, then we deduce that $u(0) = u^0$.

Let us now prove the strong convergence of $(\ell_r)_{0 \leq r \leq r^*}$. Let us consider a decreasing sequence $r_k \to 0$. Then, for $k > m$ and for any $n \in \partial B_1$,

$$
\begin{aligned} |(\ell_{r_k} - \ell_{r_m}) \cdot n| &= |(u_{r_k}(r_k(-n)) - u_{r_m}(r_m(-n))) \cdot n| \\ &\leq |(u_{r_k}(r_m(-n)) - u_{r_m}(r_m(-n))) \cdot n| + |(u_{r_k}(r_k(-n)) - u_{r_k}(r_m(-n))) \cdot n| \\ &\leq |u_{r_k} - u_{r_m}||_{\infty, B_{r_m, 2r_m}} + |r_k - r_m|^{1/2} ||u_{r_k}||_{C^{0,1/2}(\Omega_{r_k})} . \end{aligned} \tag{80}
$$

Let us note that, with an argument similar to the proof of Lemma 2.1, we can prove that for $w \in H^2(\Omega_r)$ the following inequality holds

$$
||w||_{\infty, B_{r, 2r}} \leqslant C||w||_{2, B_{r, 2r}}^{1/4} ||D^2 w||_{2, B_{r, 2r}}^{3/4}
$$

with a constant $C > 0$ independent of w and r.

Combining (80) with the above result, Lemma 2.2 and with Theorem 4.1, we conclude that $\ell_r \to \ell$ in $L^2(0,T)^3$. To obtain the relation between ℓ and u, we consider a similar calculation: for a fixed $e \in \partial B_1$,

$$
|u(t,0) - \ell(t)| \leq |u(t,0) - u(t,re)| + |u(t,re) - \ell_r(t)| + |\ell_r(t) - \ell(t)|.
$$
 (81)

The first term of the right-hand side of (81) can be estimated by $||u||_{C^{0,1/2}(\mathbb{R}^3)}$, the last term has just been treated, and the second term can be handle through the following manipulation: for any $n, e \in \partial B_1$,

$$
|(u(t, re) - \ell_r(t)) \cdot n| = |(u(t, re) - u_r(t, -rn)) \cdot n|
$$

\$\leq |(u(t, re) - u(t, -rn)) \cdot n| + |(u(t, -rn) - u_r(t, -rn)) \cdot n|\$
\$\leq r^{1/2} ||u||_{C^{0,1/2}(\mathbb{R}^3)} + ||u - u_r||_{\infty, B_{r, 2r}},

and we conclude as above.

This concludes the proof of Theorem 1.1.

We give here the proof of the density in H of the subspace of the functions $C^1(\mathbb{R}^3)^3$ which are divergence free, with compact support in $B_{s,R}$, $R > s > 0$. The proof is based on [20, pp. 165-166].

Lemma 5.1. Given $u \in H$ and $\delta > 0$, there exist $0 < s < 1$ and $u^s \in V$ with supp $u^s \subset B_{s,1/s}$ such that

$$
||u - u^s||_{2, \mathbb{R}^3} < \delta.
$$

Proof. Given $u \in H$ and $\delta > 0$, using the density of V in H, there exists $v \in V$ such that

$$
||u-v||_{2,\mathbb{R}^3}<\frac{\delta}{2}.
$$

For $0 < \varepsilon < 1$ and $v \in V$, consider the problem of finding $v_{\varepsilon} \in V$ such that

$$
\Delta v_{\varepsilon} - v_{\varepsilon} - \nabla p_{\varepsilon} = \Delta v - v \text{ in } B_{\varepsilon, 1/\varepsilon},
$$

$$
\nabla \cdot v_{\varepsilon} = 0 \text{ in } B_{\varepsilon, 1/\varepsilon}.
$$
 (82)

This problem has a unique solution $(v_\varepsilon, p_\varepsilon) \in V \times L^2(B_{\varepsilon, 1/\varepsilon})/\mathbb{R}$ such that

$$
||v_{\varepsilon}||_{2,B_{\varepsilon,1/\varepsilon}} + ||\nabla v_{\varepsilon}||_{2,B_{\varepsilon,1/\varepsilon}} \leq ||v||_{V}
$$
\n(83)

Moreover, p_{ε} can be normalized in such a way that

$$
||p_{\varepsilon}||_{2,B_{\varepsilon,1/\varepsilon}} \leqslant C||v||_V \tag{84}
$$

with C independent of ε and v. From (83), extending each v_{ε} by zero outside $B_{\varepsilon,1/\varepsilon}$, we deduce the existence of $\overline{v} \in V$ such that

$$
v_{\varepsilon} \rightharpoonup \overline{v}
$$
 weakly in V , as $\varepsilon \to 0$,

while (84) implies the existence of $p \in L^2(\mathbb{R}^3)$ such that

$$
p_{\varepsilon} \to p
$$
 weakly in $L^2(\mathbb{R}^3)$, as $\varepsilon \to 0$.

The function $\overline{v} - v \in V$ satisfies

$$
\Delta(\overline{v} - v) - (\overline{v} - v) - \nabla p = 0 \text{ in } \mathbb{R}^3,
$$

$$
\nabla \cdot (\overline{v} - v) = 0 \text{ in } \mathbb{R}^3
$$

and therefore $\overline{v} = v$. Actually, since $v_{\varepsilon} \to v$ weakly in V and $||v_{\varepsilon}||_V \le ||v||_V$, it follows that

$$
v_{\varepsilon} \to v
$$
 strongly in V, as $\varepsilon \to 0$.

This results allows us to take $v_s \in V$ with support in $B_{s,1/s}$ such that

$$
||v-v_s||_{2,\mathbb{R}^3}<\frac{\delta}{2}.
$$

A Computations involving the auxiliary Stokes solutions

Stokes derived in 1851 [24] (see also [19]) an explicit solution for tridimensional Stokes flow past a translating sphere. Specifically, the solution to the Stokes problem

$$
\nabla \cdot T(u, p) = 0, \text{ in } \Omega_r,
$$

$$
\nabla \cdot u = 0, \text{ in } \Omega_r,
$$

$$
u(x) = \xi \text{ for } x \in \partial B_r,
$$

$$
\lim_{|x| \to \infty} u(x) = 0
$$

where $\xi \in \mathbb{R}^3$, is given by

$$
u(x) = \frac{3r}{4} \left[\frac{\xi}{|x|} + \frac{(\xi \cdot x)x}{|x|^3} \right] + \frac{r^3}{4} \left[\frac{\xi}{|x|^3} - 3 \frac{(\xi \cdot x)x}{|x|^5} \right]
$$

$$
p(x) = \frac{3\nu r}{2} \frac{\xi \cdot x}{|x|^3} + c
$$

where c is a constant. By direct calculations, we find that the gradient of u is

$$
\nabla u(x) = \frac{3r}{4} \left[\frac{\xi \otimes x - x \otimes \xi}{|x|^3} + \frac{(\xi \cdot x)}{|x|^3} I_3 - \frac{3(\xi \cdot x)}{|x|^5} x \otimes x \right] + \frac{r^3}{4} \left[-3 \frac{(\xi \cdot x)I_3 + \xi \otimes x + x \otimes \xi}{|x|^5} + \frac{15(\xi \cdot x)x \otimes x}{|x|^7} \right]
$$

and its symmetric part is

$$
Du(x) = \frac{3r}{4} \left[\frac{(\xi \cdot x)}{|x|^3} I_3 - \frac{3(\xi \cdot x)}{|x|^5} x \otimes x \right] + \frac{r^3}{4} \left[-3 \frac{(\xi \cdot x) I_3 + \xi \otimes x + x \otimes \xi}{|x|^5} + \frac{15(\xi \cdot x) x \otimes x}{|x|^7} \right]
$$

.

Therefore, since the external unit normal to Ω_r is given by $n(x) = -\frac{x}{r}$ and

$$
(\xi \otimes x)n(x) = -r\xi, \quad (x \otimes \xi)n(x) = (\xi \cdot x)n(x), \quad (x \otimes x)n(x) = r^2n(x) \quad (x \in \partial B_r)
$$

we have

$$
T(u, p)n = \frac{3}{2r}\xi \text{ on } \partial B_r
$$

$$
\int_{\partial B_r} T(u, p) n dS = \frac{3}{2r}\xi \int_{\partial B_r} dS = 6\pi r \xi
$$

$$
\int_{\partial B_r} x \times T(u, p) n dS = -\frac{3}{2r}\xi \times \int_{\partial B_r} x dS = 0.
$$

As concerns the summability properties of u and its derivatives, we have

$$
u \in L^{q}(\Omega_{r})^{3}, \forall q > 3, \text{ with } ||u||_{q,\Omega_{r}} \leq C(q)|\xi|r^{3/q},
$$

\n
$$
\nabla u \in L^{q}(\Omega_{r})^{3\times 3}, \forall q > 3/2, \text{ with } ||\nabla u||_{q,\Omega_{r}} \leq C(q)|\xi|r^{3/q-1}
$$

\n
$$
D^{2}u \in L^{q}(\Omega_{r})^{3\times 3\times 3}, \forall q > 1, \text{ with } ||D^{2}u||_{q,\Omega_{r}} \leq C(q)|\xi|r^{3/q-2}.
$$

In particular, $\|\nabla u\|_{2,\Omega_r} \leqslant C |\xi| r^{1/2}$ and $\|D^2 u\|_{2,\Omega_r} \leqslant C |\xi| r^{-1/2}$.

Now we consider the Stokes flow around a rotating ball. The solution to the Stokes problem

$$
\nabla \cdot T(u, p) = 0, \text{ in } \Omega_r,
$$

\n
$$
\nabla \cdot u = 0, \text{ in } \Omega_r,
$$

\n
$$
u(x) = \omega \times x \text{ for } x \in \partial B_r,
$$

\n
$$
\lim_{|x| \to \infty} u(x) = 0
$$

where $\omega \in \mathbb{R}^3$, is (see [24, 19])

$$
u(x) = r^3 \frac{\omega \times x}{|x|^3}
$$

$$
p(x) = c
$$

where c is a constant. The gradient of u and its symmetric part are given by

$$
\nabla u(x) = \frac{r^3}{|x|^3}W - \frac{3r^3(\omega \times x) \otimes x}{|x|^5} \text{ with } W = \begin{bmatrix} 0 & \omega_3 & -\omega_2 \\ -\omega_3 & 0 & \omega_1 \\ \omega_2 & -\omega_1 & 0 \end{bmatrix}
$$

and

$$
Du(x) = -\frac{3r^3}{2|x|^5}[x \otimes (\omega \times x) + (\omega \times x) \otimes x]
$$

We have

$$
Du(x)n(x) = \frac{3\omega \times x}{2r},
$$

$$
x \times Du(x)n(x) = \frac{3x \times (\omega \times x)}{2r} \quad (x \in \partial B_r)
$$

and then, due to the symmetry of the domain Ω_r ,

$$
\int_{\partial B_r} T(u, p) n \, \mathrm{d}S = 0,
$$

$$
\int_{\partial B_r} x \times T(u, p) n \, dS = 2\nu \int_{\partial B_r} x \times (Du(x)n(x)) \, dS = \frac{3\nu}{r} \int_{\partial B_r} x \times (\omega \times x) \, dS = 8\pi\nu r^3 \omega.
$$

We have $u \in L^q(\Omega_r)^3$ for all $q > 3/2$ and

$$
||u||_{q,\Omega_r}\leqslant C(q)|\omega|r^{1+3/q}.
$$

In particular, u has finite kinetic energy with $||u||_{2,\Omega_r} \leq C|\omega|r^{5/2}$. For the derivatives of u, we have $\overline{3}$ α

$$
\nabla u \in L^{q}(\Omega_{r})^{3\times 3}, \forall q > 1, \text{ with } \|\nabla u\|_{q,\Omega_{r}} \leq C(q)|\omega|r^{3/q},
$$

$$
D^{2}u \in L^{q}(\Omega_{r})^{3\times 3\times 3}, \forall q \in [1, \infty[, \text{ with } \|D^{2}u\|_{q,\Omega_{r}} \leq C(q)|\omega|r^{3/q-1}
$$
