# LARGE DEVIATIONS FOR THE ORNSTEIN-UHLENBECK PROCESS WITH SHIFT 

BERNARD BERCU AND ADRIEN RICHOU


#### Abstract

We investigate the large deviation properties of the maximum likelihood estimators for the Ornstein-Uhlenbeck process with shift. We estimate simultaneously the drift and shift parameters. On the one hand, we establish a large deviation principle for the maximum likelihood estimates of the drift and shift parameters. Surprisingly, we find that the drift estimator shares the same large deviation principle as the one previously established for the Ornstein-Uhlenbeck process without shift. Sharp large deviation principles are also provided. On the other hand, we show that the maximum likelihood estimator of the shift parameter satisfies a large deviation principle with a very unusual implicit rate function.


## 1. INTRODUCTION

Consider the Ornstein-Uhlenbeck process with linear shift $\gamma \in \mathbb{R}$, observed over the time interval $[0, T]$

d X_{t}=\theta X_{t} d t+\gamma d t+d B_{t} \tag{1.1}
\end{equation*}
$$

where the drift parameter $\theta<0$, the initial state $X_{0}=0$ and the driven noise $\left(B_{t}\right)$ is a standard Brownian motion. The maximum likelihood estimates of the unknown parameters $\theta$ and $\gamma$ are given by

\widehat{\theta}_{T}=\frac{T \int_{0}^{T} X_{t} d X_{t}-X_{T} \int_{0}^{T} X_{t} d t}{T \int_{0}^{T} X_{t}^{2} d t-\left(\int_{0}^{T} X_{t} d t\right)^{2}} \tag{1.2}
\end{equation*}
$$

and

$$
\begin{equation*}
\widehat{\gamma}_{T}=\frac{X_{T} \int_{0}^{T} X_{t}^{2} d t-\int_{0}^{T} X_{t} d X_{t} \int_{0}^{T} X_{t} d t}{T \int_{0}^{T} X_{t}^{2} d t-\left(\int_{0}^{T} X_{t} d t\right)^{2}} \tag{1.3}
\end{equation*}
$$

A wide range of literature is available on the asymptotic behavior of $\left(\widehat{\theta}_{T}\right)$ and $\left(\widehat{\gamma}_{T}\right)$. It is well-known [8] that $\widehat{\theta}_{T}$ and $\widehat{\gamma}_{T}$ are both strongly consistent estimators of $\theta$ and $\gamma$ and their joint asymptotic normality is given by

\end{equation*}

where the limiting matrix

$$
L=2\left(\begin{array}{ll}
\theta & \gamma \\
\gamma & \delta
\end{array}\right)
$$

with $\delta=\left(2 \gamma^{2}+\theta\right) / 2 \theta$. Moreover, concentration inequalities for $\left(\widehat{\theta}_{T}\right)$ and $\left(\widehat{\gamma}_{T}\right)$ and moderate deviations were established by Gao and Jiang [5], while Jiang [7] recently obtained the joint law of iterated logarithm as well as Berry-Esseen bounds. In the particular case $\gamma=0$, Florens-Landais and Pham [4] proved the large deviation principle (LDP) for $\left(\widehat{\theta}_{T}\right)$, while sharp large deviation principles (SLDP) were established in [2]. We also refer the reader to [1] for the sharp large deviations in the non-stationary case $\theta \geq 0$ and $\gamma=0$.

Our goal is to extend these investigations by establishing the large deviations properties of the maximum likelihood estimators of the drift and shift parameters $\theta<0$ and $\gamma$ in the situation where $\theta$ and $\gamma$ are estimated simultaneously.

The paper is organized as follows. In Section 2, we propose three keystone lemmas which are at the core of our analysis. An LDP for the couple

\left(\widehat{\theta}_{T}, \widehat{\gamma}_{T}\right)
$$

is given in Section 3. Via the contraction principle, one can realize that $\left(\widehat{\theta}_{T}\right)$ shares the same LDP as the one previously established for the Ornstein-Uhlenbeck process without shift. One can also observe that $\left(\widehat{\gamma}_{T}\right)$ satisfies an LDP with a very unusual implicit rate function. Section 4 is devoted to SLDP for the sequence $\left(\widehat{\theta}_{T}\right)$. All the technical proofs of Sections 2 to 4 are postponed to Appendices A, B, and C.

## 2. Three keystone lemmas.

Denote by $\Lambda_{T}$ the normalized cumulant generating function of the triplet

\left(\frac{X_{T}}{\sqrt{T}}, \frac{1}{T} \int_{0}^{T} X_{t}^{2} d t, \frac{1}{T} \int_{0}^{T} X_{t} d t\right)
$$

defined, for all $(a, b, c) \in \mathbb{R}^{3}$, by

\Lambda_{T}(a, b, c)=\frac{1}{T} \log \mathbb{E}\left[\exp \left(a \sqrt{T} X_{T}+b \int_{0}^{T} X_{t}^{2} d t+c \int_{0}^{T} X_{t} d t\right)\right]
$$

Our first lemma deals with the extended real function $\Lambda$ defined as the pointwise limit of $\Lambda_{T}$.

Lemma 2.1. Let $\mathcal{D}_{\Lambda}$ be the effective domain of $\Lambda$

\mathcal{D}_{\Lambda}=\left\{(a, b, c) \in \mathbb{R}^{3} / b<\theta^{2} / 2\right\}
$$

and set $\varphi(b)=\sqrt{\theta^{2}-2 b}$. Then, for all $(a, b, c) \in \mathcal{D}_{\Lambda}$, we have

$$
\begin{equation*}
\Lambda(a, b, c)=-\frac{1}{2}\left(\theta+\varphi(b)+\gamma^{2}\right)+\frac{1}{2}\left(\frac{a^{2}}{\varphi(b)-\theta}\right)+\frac{1}{2}\left(\frac{c-\theta \gamma}{\varphi(b)}\right)^{2} \tag{2.1}
\end{equation*}
$$

Proof. The proof in given in Appendix A.

A direct calculation shows that the function $\Lambda$ is steep, which means that the norm of its gradient goes to infinity for any sequence in the interior of $\mathcal{D}_{\Lambda}$ converging to a boundary point of $\mathcal{D}_{\Lambda}$. It will allow us in Section 3 to deduce an LDP for the couple $\left(\widehat{\theta}_{T}, \widehat{\gamma}_{T}\right)$. In order to establish the SLDP for the drift parameter $\widehat{\theta}_{T}$, it is necessary to modify our strategy. To be more precise, we shall now focus our attention on the normalized cumulant generating function $\mathcal{L}_{T}$ of the couple

$$
\left(\frac{1}{T} \int_{0}^{T}\left(X_{t}-\bar{X}_{T}\right) d X_{t}, \frac{1}{T} S_{T}\right)
$$

where

$$
S_{T}=\int_{0}^{T}\left(X_{t}-\bar{X}_{T}\right)^{2} d t \quad \text { and } \quad \bar{X}_{T}=\frac{1}{T} \int_{0}^{T} X_{t} d t
$$

which is given, for all $(a, b) \in \mathbb{R}^{2}$, by

$$
\mathcal{L}_{T}(a, b)=\frac{1}{T} \log \mathbb{E}\left[\exp \left(a \int_{0}^{T}\left(X_{t}-\bar{X}_{T}\right) d X_{t}+b S_{T}\right)\right] .
$$

The reason for this is twofold. On the one hand, it is not possible to deduce an $\operatorname{SLDP}$ for $\left(\widehat{\theta}_{T}\right)$ via $\Lambda_{T}$. On the other hand, it immediately follows from (1.2) that

\begin{equation*}
\widehat{\theta}_{T}=\frac{\int_{0}^{T}\left(X_{t}-\bar{X}_{T}\right) d X_{t}}{S_{T}} \tag{2.2}
\end{equation*}
$$

However, one can observe that for all $c \in \mathbb{R}, \mathbb{P}\left(\widehat{\theta}_{T} \geq c\right)=\mathbb{P}\left(\mathcal{Z}_{T}(1,-c) \geq 0\right)$ where, for all $(a, b) \in \mathbb{R}^{2}, \mathcal{Z}_{T}(a, b)$ stands for the random variable

$$
\begin{equation*}
\mathcal{Z}_{T}(a, b)=a \int_{0}^{T}\left(X_{t}-\bar{X}_{T}\right) d X_{t}+b S_{T} \tag{2.3}
\end{equation*}
$$

Our second lemma provides the full asymptotic expansion for $\mathcal{L}_{T}$. Denote by $\mathcal{L}$ the extended real function defined as the pointwise limit of $\mathcal{L}_{T}$.

Lemma 2.2. Let $\mathcal{D}_{\mathcal{L}}$ be the effective domain of $\mathcal{L}$

$$
\mathcal{D}_{\mathcal{L}}=\left\{(a, b) \in \mathbb{R}^{2} / \theta^{2}-2 b>0 \quad \text { and } \quad a+\theta<\sqrt{\theta^{2}-2 b}\right\}
$$

and set $\varphi(b)=\sqrt{\theta^{2}-2 b}, \tau(a, b)=\varphi(b)-(a+\theta)$. Then, for all $(a, b) \in \mathcal{D}_{\mathcal{L}}$ and $T$ large enough, we have

$$
\begin{equation*}
\mathcal{L}_{T}(a, b)=\mathcal{L}(a, b)+\frac{1}{T} \mathcal{H}(a, b)+\frac{1}{T^{2}} \mathcal{R}_{T}(a, b) \tag{2.4}
\end{equation*}
$$

where

$$
\begin{align*}
\mathcal{L}(a, b) & =-\frac{1}{2}\left(a+\theta+\sqrt{\theta^{2}-2 b}\right)  \tag{2.5}\\
\mathcal{H}(a, b) & =-\frac{1}{2} \log \left(\frac{\tau(a, b) \theta^{2}}{2 \varphi^{3}(b)}\right)-\frac{\gamma^{2}\left(a+\theta+\sqrt{\theta^{2}-2 b}\right.}{2 \theta^{2}} \tag{2.6}
\end{align*}
$$

Moreover, the remainder $\mathcal{R}_{T}(a, b)$ may be explicitly calculated as a rational function
of $a, b, T$ and $\exp (-\varphi(b) T)$. In addition, $\mathcal{R}_{T}$ can be extended to the two-dimensional complex plane and it is a bounded analytic function as soon as the real parts of its arguments belong to the interior of $\mathcal{D}_{\mathcal{L}}$.

Proof. The proof in given in Appendix B.
Our third lemma relies on the Karhunen-Loève expansion of the process $\left(X_{T}\right)$. Denote by $\mathcal{F}$ the class of all real-valued continuous functions $f$ such that $f(x)=x^{2} h(x)$ where $h$ is continuous. Moreover, let $g$ be the spectral density of the stationary Ornstein-Uhlenbeck process without shift $\gamma=0$ given, for all $x \in \mathbb{R}$, by

\begin{equation*}
g(x)=\frac{1}{\theta^{2}+x^{2}} \tag{2.7}
\end{equation*}
$$

Lemma 2.3. One can find two sequences of real numbers $\left(\alpha_{k}^{T}\right)$ and $\left(\beta_{k}^{T}\right)$ both in $\ell^{2}(\mathbb{N})$ such that

\begin{equation*}
\mathcal{Z}_{T}(a, b)=\mathbb{E}\left[\mathcal{Z}_{T}(a, b)\right]+\sum_{k=1}^{\infty} \alpha_{k}^{T}\left(\varepsilon_{k}^{2}-1\right)+\beta_{k}^{T} \varepsilon_{k} \tag{2.8}
\end{equation*}
$$

where $\left(\varepsilon_{k}\right)$ are independent standard $\mathcal{N}(0,1)$ random variables. Moreover, for all $(a, b) \in \mathcal{D}_{\mathcal{L}}$, there exist two constants $A>0$ and $B>0$ that do not depend on $T$ such that, for $T$ large enough, $\alpha_{k}^{T} \in[-A, A]$ for all $k \geq 1$ and

$$
\begin{equation*}
\sum_{k=1}^{+\infty}\left(\beta_{k}^{T}\right)^{2}<B \tag{2.9}
\end{equation*}
$$

Consequently, for all $(a, b) \in \mathcal{D}_{\mathcal{L}}$ and $x \in \mathbb{R}$ such that $|x|<1 / 2 A$, and for $T$ large enough, we have
$\mathcal{L}_{T}(x a, x b)=\frac{1}{T} \mathbb{E}\left[\mathcal{Z}_{T}(x a, x b)\right]-\frac{1}{2 T} \sum_{k=1}^{\infty}\left(\log \left(1-2 x \alpha_{k}^{T}\right)+2 x \alpha_{k}^{T}\right)+\frac{1}{2 T} \sum_{k=1}^{\infty} \frac{\left(x \beta_{k}^{T}\right)^{2}}{1-2 x \alpha_{k}^{T}}$.
Finally, if $b \neq 0$, the empirical spectral measure

$$
\begin{equation*}
\nu_{T}=\frac{1}{T} \sum_{k=1}^{\infty} \delta_{\alpha_{k}^{T}} \tag{2.10}
\end{equation*}
$$

satisfies, for any continuous $f \in \mathcal{F}$ with compact support

$$
\begin{equation*}
\lim _{T \rightarrow \infty}\left\langle\nu_{T}, f\right\rangle=\lim _{T \rightarrow \infty} \frac{1}{T} \sum_{k=1}^{\infty} f\left(\alpha_{k}^{T}\right)=\langle\nu, f\rangle=\frac{1}{2 \pi} \int_{\mathbb{R}} f(b g(x)) d x \tag{2.11}
\end{equation*}
$$

Proof. The proof is given in Appendix C.

## 3. Large deviations Results.

Our large deviations results are as follows.
Theorem 3.1. The couple $\left(\widehat{\theta}_{T}, \widehat{\gamma}_{T}\right)$ satisfies an LDP with good rate function

$$
I_{\theta, \gamma}(c, d)=\left\{\begin{array}{cl}
-\frac{(\theta-c)^{2}}{4 c}+\frac{1}{2}\left(\gamma-\frac{d \theta}{c}\right)^{2} & \text { if } c \leq \frac{\theta}{3}  \tag{3.1}\\
(2 c-\theta)+\frac{1}{2}\left(\gamma-\frac{d \theta}{c}\right)^{2} & \text { if } c \geq \frac{\theta}{3} \text { and } c \neq 0 \\
-\theta & \text { if }(c, d)=(0,0) \\
+\infty & \text { if } c=0 \text { and } d \neq 0
\end{array}\right.
$$

A direct application of the contraction principle [3] immediately leads to the two following corollaries.

Corollary 3.2. The sequence $\left(\widehat{\theta}_{T}\right)$ satisfies an LDP with good rate function

$$
I_{\theta}(c)=\left\{\begin{array}{cc}
-\frac{(c-\theta)^{2}}{4 c} & \text { if } \quad c \leq \frac{\theta}{3}  \tag{3.2}\\
2 c-\theta & \text { if } c \geq \frac{\theta}{3}
\end{array}\right.
$$

Corollary 3.3. The sequence $\left(\widehat{\gamma}_{T}\right)$ satisfies an LDP with good rate function

$$
\begin{equation*}
I_{\gamma}(d)=\inf \left\{I_{\theta, \gamma}(c, d) / c \in \mathbb{R}\right\} . \tag{3.3}
\end{equation*}
$$

Proof. The proofs are given is Section 5.
Remark 3.4. On the one hand, one can observe that $\left(\hat{\theta}_{T}\right)$ shares exactly the same LDP as the one previously established by Florens-Landais and Pham [4] for the Ornstein-Uhlenbeck without shift $\gamma=0$. On the other hand, $\left(\widehat{\gamma}_{T}\right)$ satisfies an LDP with a very unusual rate function. Unfortunately, an explicit expression for this rate function is quite complicated. Its very particular form is given in the special cases $(\theta, \gamma)=(-2,2)$ and $(\theta, \gamma)=-(2,1)$ in Figure 1 below.

## 4. Sharp large deviations results.

Our goal is now to improve Corollary 3.2 by a first order SLDP for $\left(\widehat{\theta}_{T}\right)$. Via Lemma 2.2, it is possible to establish SLDP of any order for the sequence $\left(\widehat{\theta}_{T}\right)$. However, for clearness sake, we have chosen to restrict ourself to a first order expansion. We already saw from Lemma 2.2 that the effective domain of the limiting cumulant generating function of the auxiliary random variable $\mathcal{Z}_{T}(a,-c a)$ is given by

$$
\mathcal{D}_{\mathcal{L}}=\left\{a \in \mathbb{R} / \theta^{2}+2 a c>0 \quad \text { and } \quad \sqrt{\theta^{2}+2 a c}>a+\theta\right\} .
$$




Figure 1. Rate functions for the drift parameter.
After some straightforward calculations, it is not hard to see that

In addition, for all $a \in \mathcal{D}_{\mathcal{L}}$, let $\varphi(a)=\sqrt{\theta^{2}+2 a c}$ and denote

$$
\begin{align*}
L(a) & =\mathcal{L}(a,-a c)=-\frac{1}{2}\left(a+\theta+\sqrt{\theta^{2}+2 a c}\right)  \tag{4.1}\\
H(a) & =\mathcal{H}(a,-a c)=-\frac{1}{2} \log \left(\frac{(\varphi(a)-a-\theta) \theta^{2}}{2 \varphi^{3}(a)}\right)-\frac{\gamma^{2}(a+\theta+\varphi(a))}{2 \theta^{2}}
\end{align*}
$$

The function $L$ is not steep as the derivative of $L$ is finite at the boundary of $\mathcal{D}_{\mathcal{L}}$. Moreover, $L^{\prime}(a)=0$ if and only if $a=a_{c}$ with

$$
a_{c}=\frac{c^{2}-\theta^{2}}{2 c}
$$

Finally, one can observe that $a_{c} \in \mathcal{D}_{\mathcal{L}}$ only if $c<\theta / 3$. Our sharp large deviations results are as follows.

Theorem 4.1. Consider the Ornstein-Uhlenbeck process with shift given by (1.1) where the drift parameter $\theta<0$.
a) For all $\theta<c<\theta / 3$, we have for $T$ large enough,

$$
\begin{equation*}
\mathbb{P}\left(\widehat{\theta}_{T} \geq c\right)=\frac{e^{-T I_{\theta}(c)+J(c)}}{a_{c} \sigma_{c} \sqrt{2 \pi T}}(1+o(1)) \tag{4.3}
\end{equation*}
$$

while for $c<\theta$,

$$
\begin{equation*}
\mathbb{P}\left(\widehat{\theta}_{T} \leq c\right)=-\frac{e^{-T I_{\theta}(c)+J(c)}}{a_{c} \sigma_{c} \sqrt{2 \pi T}}(1+o(1)) \tag{4.4}
\end{equation*}
$$

where

$$
\begin{gather*}
a_{c}=\frac{c^{2}-\theta^{2}}{2 c} \quad \text { and } \quad \sigma_{c}^{2}=-\frac{1}{2 c},  \tag{4.5}\\
J(c)=-\frac{1}{2} \log \left(\frac{\theta^{2}(c+\theta)(3 c-\theta)}{4 c^{4}}\right)+\gamma^{2} \frac{(c-\theta)^{2}}{4 c \theta^{2}} . \tag{4.6}
\end{gather*}
$$

b) For all $c>\theta / 3$ with $c \neq 0$, we have for $T$ large enough,

$$
\begin{equation*}
\mathbb{P}\left(\widehat{\theta}_{T} \geq c\right)=\frac{e^{-T I_{\theta}(c)+K(c)}}{a_{c} \sigma_{c} \sqrt{2 \pi T}}(1+o(1)) \tag{4.7}
\end{equation*}
$$

where

$$
\begin{align*}
a_{c} & =2(c-\theta) \quad \text { and } \quad \sigma_{c}^{2}=\frac{c^{2}}{2(2 c-\theta)^{3}} .  \tag{4.8}\\
K(c) & =-\frac{1}{2} \log \left(\frac{\theta^{2}(c-\theta)(3 c-\theta)}{4 c^{2}(2 c-\theta)^{2}}\right)-\frac{\gamma^{2}}{\theta^{2}}(2 c-\theta) . \tag{4.9}
\end{align*}
$$

c) For $c=\theta / 3$, we have for $T$ large enough,

$$
\begin{equation*}
\mathbb{P}\left(\widehat{\theta}_{T} \geq c\right)=\frac{e^{-T I_{\theta}(c)+\gamma^{2} b_{\theta}}}{6 \pi T^{1 / 4}} \frac{\Gamma(1 / 4)}{\sqrt{2} a_{\theta}^{3 / 4} \sigma_{\theta}}(1+o(1)) \tag{4.10}
\end{equation*}
$$

where

$$
\begin{equation*}
a_{\theta}=-\frac{4 \theta}{3}, \quad b_{\theta}=\frac{1}{3 \theta}, \quad \sigma_{\theta}^{2}=-\frac{3}{2 \theta} . \tag{4.11}
\end{equation*}
$$

d) For $c=0$, we have for $T$ large enough,

$$
\begin{equation*}
\mathbb{P}\left(\widehat{\theta}_{T} \geq c\right)=\frac{\sqrt{2} e^{-T I_{\theta}(c)+\frac{\gamma^{2}}{\theta}+2}}{\sqrt{2 \pi T} \sqrt{-\theta}}(1+o(1)) \tag{4.12}
\end{equation*}
$$

## 5. Proofs of the large deviations Results.

First of all, denote

$$
\widehat{V}_{T}=\binom{\hat{\theta}_{T}}{\widehat{\gamma}_{T}} \quad \text { and } \quad \widetilde{V}_{T}=\binom{\widetilde{\theta}_{T}}{\widetilde{\gamma}_{T}}
$$

where

$$
\begin{equation*}
\widetilde{\theta}_{T}=\frac{\int_{0}^{T} X_{t} d X_{t}}{S_{T}} \quad \text { and } \quad \widetilde{\gamma}_{T}=-\widetilde{\theta}_{T} \bar{X}_{T} \tag{5.1}
\end{equation*}
$$

The following lemma shows that the sequences $\left(\widehat{V}_{T}\right)$ and $\left(\widetilde{V}_{T}\right)$ share the same LDP. We refer the reader to [3] for the classical notion of exponential approximation.

Lemma 5.1. The sequences of random vectors $\left(\widehat{V}_{T}\right)$ and $\left(\widetilde{V}_{T}\right)$ are exponentially equivalent, that is to say, for all $\varepsilon>0$,

$$
\begin{equation*}
\lim _{T \rightarrow+\infty} \frac{1}{T} \log \mathbb{P}\left(\left\|\widehat{V}_{T}-\widetilde{V}_{T}\right\|>\varepsilon\right)=-\infty \tag{5.2}
\end{equation*}
$$

In particular, if $\left(\widetilde{V}_{T}\right)$ satisfies an LDP with good rate function $I$, then the same LDP holds for $\left(\widehat{V}_{T}\right)$.

Proof. It is easy to see from the very definition of our estimates given in (1.2), (1.3) and (5.1) that

$$
\widehat{\theta}_{T}-\tilde{\theta}_{T}=\frac{X_{T}}{T}\left(\frac{\bar{X}_{T}}{\Sigma_{T}}\right) \quad \text { and } \quad \widehat{\gamma}_{T}-\widetilde{\gamma}_{T}=\frac{X_{T}}{T}\left(1-\frac{\left(\bar{X}_{T}\right)^{2}}{\Sigma_{T}}\right)
$$

where

$$
\Sigma_{T}=\frac{S_{T}}{T} .
$$

Consequently, for all $\varepsilon>0$,

$$
\begin{equation*}
\mathbb{P}\left(\left\|\widehat{V}_{T}-\widetilde{V}_{T}\right\|>\varepsilon\right) \leq P_{T}^{\varepsilon}+Q_{T}^{\varepsilon} \tag{5.3}
\end{equation*}

where

P_{T}^{\varepsilon}=\mathbb{P}\left(\left|\frac{X_{T}}{T} \frac{\bar{X}_{T}}{\Sigma_{T}}\right| \geq \frac{\varepsilon}{\sqrt{2}}\right), \quad Q_{T}^{\varepsilon}=\mathbb{P}\left(\left|\frac{X_{T}}{T}\left(1-\frac{\left(\bar{X}_{T}\right)^{2}}{\Sigma_{T}}\right)\right| \geq \frac{\varepsilon}{\sqrt{2}}\right)
$$

For all $\eta>0$, we can upper bound the first term $P_{T}^{\varepsilon}$ by

& \leq \mathbb{P}\left(\left|\frac{X_{T}}{T}\right| \geq \frac{\eta}{\sqrt{2}}\right)+\mathbb{P}\left(\left|\bar{X}_{T}\right| \geq \sqrt{\frac{\varepsilon}{\eta}}\right)+\mathbb{P}\left(\Sigma_{T} \leq \sqrt{\frac{\eta}{\varepsilon}}\right)
\end{aligned}
$$

and the second term $Q_{T}^{\varepsilon}$ by

& \leq \mathbb{P}\left(\left|\frac{X_{T}}{T}\right| \geq \frac{\varepsilon}{2 \sqrt{2}}\right)+\mathbb{P}\left(\left|\frac{X_{T}}{T}\right| \geq \frac{\eta}{2 \sqrt{2}}\right)+\mathbb{P}\left(\left|\bar{X}_{T}\right|^{2} \geq \sqrt{\frac{\varepsilon}{\eta}}\right)+\mathbb{P}\left(\Sigma_{T} \leq \sqrt{\frac{\eta}{\varepsilon}}\right) .
\end{aligned}

On the one hand, it is not hard to see that for all $c>0$,

On the other hand, we immediately deduce from Lemma 2.2 together with GärtnerEllis's theorem that the sequence $\left(\Sigma_{T}\right)$ satisfies an LDP with speed $T$ and good rate function

One can observe that if $\eta$ goes to zero, $\zeta$ and $M_{\theta, \gamma}(\varepsilon, \eta)$ tend to infinity, which is exactly what we wanted to prove.

We are now in the position to prove our LDP results. Our strategy is to establish an LDP for the triplet

and then to make use of the contraction principle [3] in order to prove Theorem 3.1 via Lemma 5.1. The limiting cumulant generating function $\Lambda$ of the above triplet was already calculated in Lemma 2.1. It is not difficult to check that the function $\Lambda$ is steep on its effective domain $\mathcal{D}_{\Lambda}$. Consequently, we deduce from Gärtner-Ellis's theorem that the above triplet satisfies an LDP with good rate function $I$ given by the Fenchel-Legendre transform of $\Lambda$,

+\infty & \text { if } \delta^{2} \geq \mu
\end{array}\right.

Hereafter, it follows from the well-known Itô's formula that

where $f$ is the continuous function given, for all $(\lambda, \mu, \delta) \in \mathbb{R}^{3}$ such that $\mu>\delta^{2}$, by

Therefore, we infer from the contraction principle given e.g. by Theorem 4.2.1 of [3], together with Lemma 5.1, that the sequences of random vectors $\left(\widehat{V}_{T}\right)$ and $\left(\widetilde{V}_{T}\right)$ share the same LDP with good rate function

where the infimum over the empty set is equal to $+\infty$. If $c=0$ and $d \neq 0$, we clearly obtain that $I_{(\theta, \gamma)}(0, d)=+\infty$. Otherwise, we find that

when $c<0$, and

Finally, we obtain the rate function given by (3.1) thanks to elementary calculations, which completes the proof of Theorem 3.1.

## 6. Proofs of the sharp large deviations Results.

6.1. Proof of Theorem 4.1, first part. First of all, we shall focus our attention on the SLDP in the easy case $\theta<c<\theta / 3$. Denote by $L_{T}$ the normalized cumulant generating function of the random variable $Z_{T}(a)=\mathcal{Z}_{T}(a,-c a)$. We already saw that $a_{c}$, given by (4.5), belongs to the domain $\mathcal{D}_{\mathcal{L}}$ whenever $c<\theta / 3$. We can split $\mathbb{P}\left(\widehat{\theta}_{T} \geq c\right)$ into two terms, $\mathbb{P}\left(\widehat{\theta}_{T} \geq c\right)=A_{T} B_{T}$ with

where $\mathbb{E}_{T}$ stands for the expectation after the usual change of probability

On the one hand, we can deduce from Lemma 2.2 with $L\left(a_{c}\right)=\mathcal{L}\left(a_{c},-c a_{c}\right), H\left(a_{c}\right)=$ $\mathcal{H}\left(a_{c},-c a_{c}\right)$, and $R_{T}\left(a_{c}\right)=\mathcal{R}_{T}\left(a_{c},-c a_{c}\right)$ that

It remains to establish an asymptotic expansion for $B_{T}$ which can be rewritten as

enough, we obtain from Lemma 2.3 and (6.7) that

& \leq \prod_{k=1}^{\infty}\left(1+\frac{4 u^{2}\left(\alpha_{k}^{T}\right)^{2}}{\sigma_{c}^{2} T\left(1-2 a_{c} \alpha_{k}^{T}\right)^{2}}\right)^{-1 / 2} \tag{6.8}
\end{align*}

For all $\varepsilon>0$ small enough such that $1-2 a_{c} \varepsilon>0$ we denote

It follows from Lemma 2.3 that it exists some constants $\varepsilon>0$ and $\eta>0$, depending only on $\varepsilon$, such that

as $L^{\prime \prime}\left(a_{c}\right)=\sigma_{c}^{2}$, which means that the distribution of $U_{T}$ under $\mathbb{P}_{T}$ converges to the standard $\mathcal{N}(0,1)$ distribution. Finally, it follows from (6.12), (6.13) and the Lebesgue dominated convergence theorem that

Proof of Theorem 4.1, first part. The expansion (4.3) immediately follows from the conjunction of (6.4) and (6.6). The proof of (4.4) follows exactly the same lines, the only notable point to mention being a change of sign in Parseval's formula.
6.2. Proof of Theorem 4.1, second part. We shall now proceed to the proof of the SLDP in the more complex case $c>\theta / 3$ with $c \neq 0$. One can easily check that the function $L$, given by (4.1), is decreasing and reaches its minimum at the right boundary point $a_{c}=2(c-\theta)$ of the domain $\mathcal{D}_{\mathcal{L}}$. Therefore, as in [2] or [1], it is necessary to make use of a slight modification of the usual strategy of change of probability given in (6.3). There exists a unique $a_{T}$, which belongs to the interior of $\mathcal{D}_{\mathcal{L}}$ and converges to its border $a_{c}$, solution of the implicit equation

where $\mathbb{E}_{T}$ stands for the expectation after the time-varying change of probability

\frac{\mathrm{d} \mathbb{P}_{T}}{\mathrm{~d} \mathbb{P}}=\exp \left(Z_{T}\left(a_{T}\right)-T L_{T}\left(a_{T}\right)\right) \tag{6.17}

We deduce from (4.1), (4.2) together with (6.14) that

where $\varphi(a)=\sqrt{\theta^{2}+2 a c}$ and $\tau(a)=\varphi(a)-a-\theta$. Consequently, it follows from straightforward calculations that

Moreover, we can show via Lemma B. 4 and B. 5 that $R_{T}\left(a_{T}\right)$ remains bounded when $T$ goes to infinity. Hence, Lemma 2.2 together with convergences (6.18), (6.19), and (6.20) imply that

\Phi_{T}(u)=\exp \left(T L_{T}\left(a_{T}+\frac{i u}{T}\right)-T L_{T}\left(a_{T}\right)\right) \tag{6.25}
\end{equation*}

Moreover, we obtain from (6.18) and (6.19) that for $T$ large enough and for all $u \in \mathbb{R}$ such that $|u|=o(T)$,

\exp \left(T L\left(a_{T}+\frac{i u}{T}\right)-T L\left(a_{T}\right)\right)=\exp \left(-i b_{c} u-\frac{\sigma_{c}^{2} u^{2}}{2 T}\right)\left(1+O\left(\frac{|u|^{3}}{T^{2}}\right)\right)

where $\sigma_{c}^{2}$ and $b_{c}$ are given by (4.8) and (6.24). Consequently, as soon as $|u|=o\left(T^{2 / 3}\right)$,

It also implies that, for $T$ large enough, $\Phi_{T}$ belongs to $L^{2}(\mathbb{R})$. Hereafter, we deduce from Parseval's formula that $B_{T}$, given by (6.22), can be rewritten as

It shows that the distribution of $U_{T}$ under $\mathbb{P}_{T}$ converges to $\sigma_{\theta} \zeta+d_{\theta}\left(\xi^{2}-1\right)$, where $\zeta$ and $\xi$ are two independent random variables sharing the same $\mathcal{N}(0,1)$ distribution. Finally, we obtain from (6.44) together with (6.47) and the Lebesgue dominated convergence theorem that

and $f_{T}$ is the Gaussian probability density function of $\bar{X}_{T}$. Moreover, as $c_{T}>0$, it is well-known that the conditional distribution of $X_{T}$ given $\bar{X}_{T}=x$ is $\mathcal{N}\left(\nu_{T}, s_{T}^{2}\right)$ with

D_{T} & =\int_{-\alpha}^{\alpha} \frac{1}{z_{T} \sqrt{2 \pi}} \exp \left(-\frac{z_{T}^{2}}{2}\right) \frac{1}{\sqrt{2 \pi c_{T}}} \exp \left(-\frac{\left(x-\mu_{T}\right)^{2}}{2 c_{T}}\right) d x(1+o(1)) .
\end{aligned}

We find from a careful asymptotic expansion inside the integral $C_{T}$ together with the change of variables $y=-\theta(x+\gamma / \theta) \sqrt{T}$ and Lebesgue's dominated convergence theorem, that

& =\frac{1}{2 \varphi^{2} T}\left(e^{\varphi T}-1\right)^{2}

& =\frac{1}{\varphi T^{2}} \int_{0}^{T} \int_{0}^{t} e^{\varphi(s+t)}\left(1-e^{-2 \varphi s}\right) d s d t \\
& =\frac{1}{\varphi^{2} T^{2}} \int_{0}^{T}\left(e^{\varphi t}\left(e^{\varphi t}-1\right)+e^{\varphi t}\left(e^{-\varphi t}-1\right)\right) d t \\
& =\frac{1}{\varphi^{2} T^{2}}\left(\frac{1}{2 \varphi}\left(e^{2 \varphi T}-1\right)-\frac{2}{\varphi}\left(e^{\varphi T}-1\right)+T\right)
\end{aligned}
$$

Denote by $M_{T}(a, b, c)$ the square matrix of order two

M_{T}(a, b, c)=\mathrm{I}_{2}+J \Gamma_{T}(\varphi)=\left(\begin{array}{cc}
1+(\varphi-\theta) a_{T}(\varphi) & (\varphi-\theta) b_{T}(\varphi) \\

where $\mathrm{I}_{2}$ stands for the identity matrix of order two. We clearly have

where $P_{1}$ and $P_{2}$ are rational functions, which achieves the proof of Lemma B.4.

& \quad+b\left(\int_{0}^{T} Y_{t}^{2} d t-\mathbb{E}\left[\int_{0}^{T} Y_{t}^{2} d t\right]\right) .

which clearly implies

$$
\lim _{T \rightarrow \infty} \frac{1}{T} \mathbb{E}\left[X_{T}^{2}\right]=0, \quad \lim _{T \rightarrow \infty} \frac{1}{T} \int_{0}^{T} \mathbb{E}\left[X_{t}^{2}\right] d t=\frac{\gamma^{2}}{\theta^{2}}-\frac{1}{2 \theta}, \quad \lim _{T \rightarrow \infty} \mathbb{E}\left[X_{T} \bar{X}_{T}\right]=0
$$

Then, we find from (C.1) that

$$
\begin{equation*}
\lim _{T \rightarrow \infty} \frac{1}{T} \mathbb{E}\left[\mathcal{Z}_{T}(x a, x b)\right]=-\frac{x}{2}\left(a+\frac{b}{\theta}\right) . \tag{C.7}
\end{equation*}
$$

Finally, we obtain from the decomposition of $\mathcal{L}_{T}(x a, x b)$ together with (C.5), (C.6), and (C.7) that

$$
\begin{align*}
\lim _{T \rightarrow+\infty} \frac{1}{2 T} \sum_{k=1}^{\infty}\left(\log \left(1-2 x \alpha_{k}\right)+2 x \alpha_{k}^{T}\right) & =-\frac{x b}{2 \theta}+\frac{1}{2}\left(\theta+\sqrt{\theta^{2}-2 x b}\right) \\
& =\frac{1}{2 \pi} \int_{\mathbb{R}} f_{x}(b g(y)) d y \tag{C.8}
\end{align*}
$$

where the spectral density $g$ is given by (2.7) and for all $x \in \mathbb{R}$ such that $|x| \leq 1 / 4 A$,

$$
f_{x}(y)=\frac{1}{2}(\log (1-2 x y)+2 x y) .
$$

Hence, it follows from (C.8) together with the elementary Taylor expansion

$$
\log (1-z)+z=-\sum_{p=2}^{\infty} \frac{z^{p}}{p}
$$

and classical complex analysis results that, for any integer $p \geq 2$,

$$
\lim _{T \rightarrow+\infty} \frac{1}{T} \sum_{k=1}^{\infty}\left(\alpha_{k}^{T}\right)^{p}=\frac{1}{2 \pi} \int_{\mathbb{R}}(b g(y))^{p} d y
$$

Therefore, we obtain the weak convergence (2.11) on the class of functions $\mathcal{F}$ from the Stone-Weierstrass theorem, which completes the proof of Lemma 2.3.
