# DEFORMATIONS OF REDUCIBLE REPRESENTATIONS OF KNOT GROUPS INTO $\operatorname{SL}(n, \mathbf{C})$

#### Abstract

Let $K$ be a knot in $S^{3}$ and $X$ its complement. We study deformations of non-abelian, metabelian, reducible representations of the knot group $\pi_{1}(X)$ into $\mathrm{SL}(n, \mathbf{C})$ which are associated to a simple root of the Alexander polynomial. We prove that certain of these metabelian reducible representations are smooth points of the $\mathrm{SL}(n, \mathbf{C})$-representation variety and that they have irreducible deformations.

## 1. Introduction

Let $K$ be a knot in $S^{3}$ and $X=\overline{S^{3} \backslash V(K)}$ its complement, where $V(K)$ is a tubular neighborhood of $K$. Moreover, let $\Gamma_{K}=\pi_{1}(X)$ denote the fundamental group of $X$. The aim of this paper is to study deformations of reducible metabelian representations of $\Gamma_{K}$ into $\operatorname{SL}(n, \mathbf{C})$. The metabelian representations in question where introduced by G. Burde [Bur67] and G. de Rham dR67. Let us recall this result: for each nonzero complex number $\lambda \in \mathbf{C}^{*}$ there exists a diagonal representation $\rho_{\lambda}: \Gamma_{K} \rightarrow \mathrm{SL}(2, \mathbf{C})$ given by

\rho_{\lambda}(\gamma)=\left(\begin{array}{cc}
\lambda^{\varphi(\gamma)} & 0 \\
0 & \lambda^{-\varphi(\gamma)}
\end{array}\right)
$$

Here $\varphi: \pi_{1}(X) \rightarrow \mathbf{Z}$ denotes the canonical surjection which maps the meridian $\mu$ of $K$ to 1 i.e. $\varphi(\gamma)=\operatorname{lk}(\gamma, K)$. Burde and de Rham proved that there exists a metabelian, non-abelian representation

$$
\rho_{\lambda}^{z}: \Gamma \rightarrow \mathrm{SL}(2, \mathbf{C}), \quad \rho_{\lambda}^{z}(\gamma)=\left(\begin{array}{cc}
1 & z(\gamma) \\
0 & 1
\end{array}\right)\left(\begin{array}{cc}
\lambda^{\varphi(\gamma)} & 0 \\
0 & \lambda^{-\varphi(\gamma)}
\end{array}\right)
$$

if and only if $\lambda^{2}$ is a root of the Alexander polynomial $\Delta_{K}(t)$.
The question whether or not the representation $\rho_{\lambda}^{z}$ is a limit of irreducible representations of $\Gamma_{K}$ into $\mathrm{SL}(2, \mathbf{C})$ was studied in HPSP01. Theorem 1.1

[^0]of HPSP01 states that a metabelian non-abelian representation $\rho_{\lambda}^{z}: \Gamma_{K} \rightarrow$ $\mathrm{SL}(2, \mathbf{C})$ is the limit of irreducible representations if $\lambda^{2}$ is a simple root of $\Delta_{K}(t)$. Moreover, in this case the representation $\rho_{\lambda}^{z}$ is a smooth point of the representation variety $R\left(\Gamma_{K}, \mathrm{SL}(2, \mathbf{C})\right)$; it is contained in a unique 4-dimensional component $R_{\lambda} \subset R\left(\Gamma_{K}, \mathrm{SL}(2, \mathbf{C})\right)$.

This article studies the behavior of the representations in question under the composition with the $n$-dimensional, irreducible, rational representation $r_{n}: \mathrm{SL}(2, \mathbf{C}) \rightarrow \mathrm{SL}(n, \mathbf{C})$ (for more details see Section 4.1). It is proved in Proposition 3.1 that generically for an irreducible representation $\rho \in R_{\lambda}$ the representation $\rho_{n}:=r_{n} \circ \rho \in R\left(\Gamma_{K}, \operatorname{SL}(n, \mathbf{C})\right)$ is also irreducible. The main result of this article is the following:

Theorem 1.1. If $\lambda^{2}$ is a simple root of $\Delta_{K}(t)$ and if $\Delta_{K}\left(\lambda^{2 k}\right) \neq 0$ for $2 \leq k \leq$ $n-1$ then the reducible metabelian representation $\rho_{\lambda, n}^{z}:=r_{n} \circ \rho_{\lambda}^{z}$ is a limit of irreducible representations. More precisely, $\rho_{\lambda, n}^{z}$ is a smooth point of $R_{n}\left(\Gamma_{K}\right)$; it is contained in a unique $(n+2)(n-1)$-dimensional component $R_{\lambda, n} \subset R_{n}\left(\Gamma_{K}\right)$.

This theorem is somehow complementary to a result of P. Menal-Ferrer and J. Porti MFP12] where the authors showed that the conclusions of the above theorem hold for hyperbolic knots if $\rho_{\lambda}^{z}$ is replaced by a lift of the holonomy, hol: $\pi_{1}\left(S^{3} \backslash K\right) \rightarrow \mathrm{SL}(2, \mathbf{C})$, of the hyperbolic structure of the complement $S^{3} \backslash K$. Note that Theorem 1.1 and Proposition 3.1 do apply to non-hyperbolic knots. Irreducible metabelian representations and their deformations are studied by Boden and Friedl in BF08, BF11, BF12.

This article is organized as follows: in Section 2 we will introduce notations and recall some facts which are used. In Section 3 we will prove that the representation variety $R\left(\Gamma_{K}, \mathrm{SL}(n, \mathbf{C})\right)$ contains irreducible representation if $\Delta_{K}(t)$ has a simple root (see Proposition 3.1). Moreover we give a streamlined proof of a slightly generalized version of the deformation result used in MFP12 and BAHJ10] (see Proposition 3.3). In order to prove our main result Theorem 1.1 the necessary cohomological calculations and the basic facts about the representation theory of $\mathrm{SL}(2, \mathbf{C})$ are presented in Section 4 Finally, in Section 5 some examples are exhibited.

## 2. Notations and Facts

To shorten notation we write $\operatorname{SL}(n), \mathrm{GL}(n)$ and $\mathfrak{s l}(n)$ instead of $\operatorname{SL}(n, \mathbf{C})$, $\mathrm{GL}(n, \mathbf{C})$ and $\mathfrak{s l}(n, \mathbf{C})$.

Let $\varphi: \pi_{1}(X) \rightarrow \mathbf{Z}$ denote the canonical surjection which maps the meridian $\mu$ of $K$ to 1 i.e. $\varphi(\gamma)=\operatorname{lk}(\gamma, K)$. We associate to a nonzero complex number $\alpha \in \mathbf{C}^{*}$ a homomorphism

$$
\alpha^{\varphi}: \Gamma \rightarrow \mathbf{C}^{*}, \quad \alpha^{\varphi}: \gamma \mapsto \alpha^{\varphi(\gamma)} .
$$

Note that $\alpha^{\varphi}$ maps the meridian $\mu$ of $K$ to $\alpha$. We define $\mathbf{C}_{\alpha}$ to be the $\Gamma$-module $\mathbf{C}$ with the action induced by $\alpha^{\varphi}$, i.e. $\gamma \cdot x=\alpha^{\varphi(\gamma)} x$ for all $\gamma \in \Gamma$ and all $x \in \mathbf{C}$. The trivial $\Gamma$-module $\mathbf{C}_{1}$ is simply denoted $\mathbf{C}$. With this notation it is easy to see that a map

$$
\rho_{\lambda}^{z}: \Gamma \rightarrow \mathrm{SL}(2, \mathbf{C}), \quad \rho_{\lambda}^{z}(\gamma)=\left(\begin{array}{cc}
1 & z(\gamma) \\
0 & 1
\end{array}\right)\left(\begin{array}{cc}
\lambda^{\varphi(\gamma)} & 0 \\
0 & \lambda^{-\varphi(\gamma)}
\end{array}\right)
$$

is a homomorphism if and only if the map $z: \Gamma \rightarrow \mathbf{C}_{\lambda^{2}}$ is a 1-cocycle i.e. $z\left(\gamma_{1} \gamma_{2}\right)=z\left(\gamma_{1}\right)+\lambda^{2 \varphi\left(\gamma_{1}\right)} z\left(\gamma_{2}\right)$. Note also that $\rho_{\lambda}^{z}$ is abelian if $\lambda= \pm 1$. If $\lambda^{2} \neq 1$ then $\rho_{\lambda}^{z}$ is abelian if and only if $z$ is a coboundary i.e. there exists an element $x_{0} \in \mathbf{C}$ such that $z(\gamma)=\left(\lambda^{2 \varphi(\gamma)}-1\right) x_{0}$. The general reference for group cohomology is Brown's book Bro82.

In what follows we are mainly interested in the following situation: let $X$ be the complement of a knot $K \subset S^{3}$ and let $A$ be a $\pi_{1}(X)$-module. The spaces $X$ and $\partial X$ are aspherical and hence the natural homomorphisms $H^{*}\left(\pi_{1}(X) ; A\right) \rightarrow$ $H^{*}(X ; A)$ and $H^{*}\left(\pi_{1}(\partial X) ; A\right) \rightarrow H^{*}(\partial X ; A)$ are isomorphisms. Moreover, the knot complement $X$ has the homotopy type of a 2-dimensional CW-complex which implies that $H^{k}\left(\pi_{1}(X) ; A\right)=0$ and $H_{k}\left(\pi_{1}(X) ; A\right)=0$ for $k \geq 3$. See Whi78 for more details.

The Laurent polynomial ring $\mathbf{C}\left[t^{ \pm 1}\right]$ turns into a $\Gamma_{K}$-module via the action $\gamma p(t)=t^{\varphi(\gamma)} p(t)$ for all $\gamma \in \Gamma_{K}$ and all $p(t) \in \mathbf{C}\left[t^{ \pm 1}\right]$. Recall that there are isomorphism of $\mathbf{C}\left[t^{ \pm 1}\right]$-modules

$$
H_{*}\left(\Gamma_{K} ; \mathbf{C}\left[t^{ \pm 1}\right]\right) \cong H_{*}\left(X ; \mathbf{C}\left[t^{ \pm 1}\right]\right) \cong H_{*}\left(X_{\infty} ; \mathbf{C}\right)
$$

where $X_{\infty}$ denotes the infinite cyclic covering of the knot complement $X$ (see DK01, Chapter 5]). The module $H_{1}\left(\Gamma_{k} ; \mathbf{C}\left[t^{ \pm 1}\right]\right)$ is a finitely generated torsion module it is called the Alexander module of $K$. A generator of its order ideal is called the Alexander polynomial $\Delta_{K}(t) \in \mathbf{C}\left[t^{ \pm 1}\right]$ of $K$. The Alexander polynomial is unique up to multiplication with a unit in $\mathbf{C}\left[t^{ \pm 1}\right]$.

For completeness we will state the next lemma which shows that the cohomology groups $H^{*}\left(\Gamma_{K} ; \mathbf{C}_{\alpha}\right)$ are determined by the Alexander module $H_{1}\left(\Gamma_{K} ; \mathbf{C}\left[t^{ \pm 1}\right]\right)$.

Lemma 2.1. Let $K \subset S^{3}$ be a knot and $\Gamma_{K}$ its group. Let $\alpha \in \mathbf{C}^{*}$ be a nonzero complex number and let $\mathbf{C}_{\alpha}$ denote the $\Gamma_{K}$-module given by the action $\gamma z=\alpha^{\varphi(\gamma)} z$.

If $\alpha=1$ then $\mathbf{C}_{\alpha}=\mathbf{C}$ is a trivial $\Gamma_{K}$-module and $H^{k}\left(\Gamma_{K}, \mathbf{C}\right) \cong \mathbf{C}$ for $k=0,1$ and $H^{k}\left(\Gamma_{K}, \mathbf{C}\right)=0$ for $k \geq 2$. If $\alpha \neq 1$ then $H^{0}\left(\Gamma_{K}, \mathbf{C}_{\alpha}\right)=0$ and
$\operatorname{dim} H^{1}\left(\Gamma_{K}, \mathbf{C}_{\alpha}\right)=\operatorname{dim} H^{2}\left(\Gamma_{K}, \mathbf{C}_{\alpha}\right)$. Moreover, $H^{1}\left(\Gamma_{K}, \mathbf{C}_{\alpha}\right) \neq 0$ if and only if $\Delta_{K}(\alpha)=0$.

Proof. We have $H_{0}\left(X_{\infty} ; \mathbf{C}\right) \cong \mathbf{C} \cong \mathbf{C}\left[t^{ \pm 1}\right] /(t-1)$ and $H_{k}\left(X_{\infty} ; \mathbf{C}\right)=0$ for $k \geq 2$ (see [BZH13, Prop. 8.16]).

First note that for all $\alpha \in \mathbf{C}^{*}$ we have an isomorphism $\mathbf{C}_{\alpha} \cong \mathbf{C}\left[t^{ \pm 1}\right] /(t-\alpha)$. Recall that the Alexander module $H_{1}\left(\Gamma_{K} ; \mathbf{C}\left[t^{ \pm 1}\right]\right)$ is finitely generated torsion module and hence a sum of non-free cyclic modules since $\mathbf{C}\left[t^{ \pm 1}\right]$ is a principal ideal domain. The Alexander polynomial is the order ideal of $H_{1}\left(\Gamma_{K} ; \mathbf{C}\left[t^{ \pm 1}\right]\right)$. The lemma follows from the universal coefficient theorem and the fact that $\Delta_{K}(1) \neq 0$. See $[\mathrm{BA} 00$, Proposition 2.1] for more details.
2.1. Group cohomology and representation varieties. Let now $\Gamma$ be a finitely generated group. The set $R_{n}(\Gamma):=R(\Gamma, \mathrm{SL}(n))$ of homomorphisms of $\Gamma$ in $\mathrm{SL}(n)$ is called the $\mathrm{SL}(n)$-representation variety of $\Gamma$ and has the structure of a (not necessarily irreducible) algebraic set.

Let $\rho: \Gamma \rightarrow \mathrm{SL}(n)$ be a representation. The Lie algebra $\mathfrak{s l}(n)$ turns into a $\Gamma$-module via $\operatorname{Ad} \rho$. This module will be simply denoted by $\mathfrak{s l}(n)_{\rho}$. A cocycle $d \in Z^{1}\left(\Gamma ; \mathfrak{s l}(n)_{\rho}\right)$ is a map $d: \Gamma \rightarrow \mathfrak{s l}(n)$ satisfying

$$
d\left(\gamma_{1} \gamma_{2}\right)=d\left(\gamma_{1}\right)+\rho\left(\gamma_{1}\right) d\left(\gamma_{2}\right) \rho\left(\gamma_{1}\right)^{-1} \quad, \forall \gamma_{1}, \gamma_{2} \in \Gamma
$$

It was observed by André Weil Wei64] that there is a natural inclusion of the Zariski tangent space $T_{\rho}^{Z a r}\left(R_{n}(\Gamma)\right) \hookrightarrow Z^{1}\left(\Gamma ; \mathfrak{s l}(n)_{\rho}\right)$. Informally speaking, given a smooth curve $\rho_{\epsilon}$ of representations through $\rho_{0}=\rho$ one gets a 1-cocycle $d: \Gamma \rightarrow \mathfrak{s l}(n)$ by defining

$$
d(\gamma):=\left.\frac{d \rho_{\epsilon}(\gamma)}{d \epsilon}\right|_{\epsilon=0} \rho(\gamma)^{-1}, \quad \forall \gamma \in \Gamma
$$

It is easy to see that the tangent space to the orbit by conjugation corresponds to the space of 1-coboundaries $B^{1}\left(\Gamma ; \mathfrak{s l}(n)_{\rho}\right)$. Here, $b: \Gamma \rightarrow \mathfrak{s l}(n)$ is a coboundary if there exists $x \in \mathfrak{s l}(n)$ such that $b(\gamma)=\rho(\gamma) x \rho(\gamma)^{-1}-x$. A detailed account can be found in LM85.

Let $\operatorname{dim}_{\rho} R_{n}(\Gamma)$ be the local dimension of $R_{n}(\Gamma)$ at $\rho$ (i.e. the maximal dimension of the irreducible components of $R_{n}(\Gamma)$ containing $\rho$ [Sha77, Ch. II]). So we obtain:

$$
\operatorname{dim}_{\rho} R_{n}(\Gamma) \leq \operatorname{dim} T_{\rho}^{Z a r}\left(R_{n}(\Gamma)\right) \leq \operatorname{dim} Z^{1}\left(\Gamma ; \mathfrak{s l}(n)_{\rho}\right)
$$

and the following lemma follows (for more details see [HPSP01, Lemma 2.6]):
Lemma 2.2. Let $\rho \in R_{n}(\Gamma)$ be given. If $\operatorname{dim}_{\rho} R_{n}(\Gamma)=\operatorname{dim} Z^{1}\left(\Gamma ; \mathfrak{s l}(n)_{\rho}\right)$ then $\rho$ is a smooth point of the representation variety $R_{n}(\Gamma)$ and $\rho$ is contained in a unique component of $R_{n}(\Gamma)$ of dimension $\operatorname{dim} Z^{1}\left(\Gamma ; \mathfrak{s l}(n)_{\rho}\right)$.

## 3. Deforming representations

The aim of the following sections is to prove that the representation $\rho_{\lambda, n}^{z}$ from the introduction is a smooth point of the representation variety. We present a more streamlined and slightly generalized version of the deformation result from HPSP01, HP05, BAHJ10, MFP12] (see Proposition 3.3). For the convenience of the reader we recall the setup.

First we will prove that the representation $\rho_{\lambda, n}^{z} \in R_{n}\left(\Gamma_{K}\right)$ is the limit of irreducible representations if $\lambda^{2}$ is a simple root of of the Alexander polynomial $\Delta_{K}(t)$. In what follows a property of an irreducible algebraic variety $Y$ is said to be true generically if it holds except on a proper Zariski-closed subset of $Y$, in other words, if it holds on a non-empty Zariski-open subset.

Let $K \subset S^{3}$ be a knot, $\lambda^{2} \in \mathbf{C}$ a simple root of $\Delta_{K}(t)$ and $z \in Z^{1}\left(\Gamma_{K}, \mathbf{C}_{\lambda^{2}}\right)$ a cocycle representing a generator of $H^{1}\left(\Gamma_{K}, \mathbf{C}_{\lambda^{2}}\right)$. Following [HPSP01, Thm 1.1] the representation $\rho_{\lambda}^{z} \in R_{2}\left(\Gamma_{K}\right)$ is a smooth point of the representation variety. It is contained in an unique irreducible 4-dimensional component $R_{\lambda} \subset R_{2}\left(\Gamma_{K}\right)$. Note that generically a representation $\rho \in R_{\lambda}$ is irreducible.

Proposition 3.1. Let $K \subset S^{3}$ be a knot, $\lambda^{2} \in \mathbf{C}$ a simple root of $\Delta_{K}(t)$ and let $z \in Z^{1}\left(\Gamma_{K}, \mathbf{C}_{\lambda^{2}}\right)$ be a cocycle representing a generator of $H^{1}\left(\Gamma_{K}, \mathbf{C}_{\lambda^{2}}\right)$.

Then the representation $\rho_{\lambda, n}^{z}=r_{n} \circ \rho_{\lambda}^{z}: \Gamma_{K} \rightarrow B_{n}$ is the limit of irreducible representation in $R_{n}\left(\Gamma_{K}\right)$. More precisely, generically a representation $\rho_{n}=$ $r_{n} \circ \rho, \rho \in R_{\lambda}$ is irreducible.

Proof. It follows from HPSP01, Theorem 1.1] that $\rho_{\lambda}^{z} \in R_{2}\left(\Gamma_{K}\right)$ is the limit of irreducible representations. Moreover, $\rho_{\lambda}^{z} \in R_{2}\left(\Gamma_{K}\right)$ is a smooth point which is contained in a unique 4 -dimensional component $R_{\lambda} \subset R_{2}\left(\Gamma_{K}\right)$.

Let $\Gamma$ be a discrete group and let $\rho: \Gamma \rightarrow \mathrm{SL}(2, \mathbf{C})$ be an irreducible representation. If the image $\rho(\Gamma) \subset \mathrm{SL}(2, \mathbf{C})$ is Zariski-dense then the representation $\rho_{n}:=r_{n} \circ \rho \in R_{n}(\Gamma)$ is irreducible. Hence in order to prove the proposition we show that there is a neighborhood $U=U\left(\rho_{\lambda}^{z}\right) \subset R_{2}\left(\Gamma_{K}\right)$ such that $\rho(\Gamma) \subset \mathrm{SL}(2, \mathbf{C})$ is Zariski-dense for each irreducible $\rho \in U$. Let now $\rho: \Gamma_{K} \rightarrow \mathrm{SL}(2, \mathbf{C})$ be any irreducible representation and let $G \subset \mathrm{SL}(2)$ denote the Zariski-closure of $\rho\left(\Gamma_{K}\right)$. Suppose that $G \neq \mathrm{SL}(2)$. Since $\rho$ is irreducible it follows that $G$ is, up to conjugation, not a subgroup of upper-triangular matrices of SL(2). Then by [Kov86, Sec. 1.4] and Kap57, Theorem 4.12] there are, up to conjugation, only two cases left:

- $G$ is a subgroup of the infinite dihedral group

$$
D_{\infty}=\left\{\left.\left(\begin{array}{cc}
\alpha & 0 \\
0 & \alpha^{-1}
\end{array}\right) \right\rvert\, \alpha \in \mathbf{C}^{*}\right\} \cup\left\{\left.\left(\begin{array}{cc}
0 & \alpha \\
-\alpha^{-1} & 0
\end{array}\right) \right\rvert\, \alpha \in \mathbf{C}^{*}\right\}
$$

- $G$ is one of the groups $A_{4}^{\mathrm{SL}(2)}$ (the tetrahedral group), $S_{4}^{\mathrm{SL}(2)}$ (the octahedral group) or $A_{5}^{\mathrm{SL}(2)}$ (the icosahedral group). These groups are the preimages in $\mathrm{SL}(2)$ of the subgroups $A_{4}, S_{4}, A_{5} \subset \operatorname{PSL}(2, \mathbf{C})$.
In the first case it follows directly from Nag07 that if $\rho$ is an irreducible metabelian representation then the trace of the image of a meridian $\operatorname{tr}(\rho(\mu))=0$ i.e. $\rho(\mu)$ is similar to $\pm\left(\begin{array}{cc}i & 0 \\ 0 & -i\end{array}\right)$. Now, $\operatorname{tr}\left(\rho_{\lambda}^{z}(\mu)\right) \neq 0$ since $\Delta_{K}(-1) \neq 0$ and $\Delta_{K}\left(\lambda^{ \pm 2}\right)=0$. For the second case there are up to conjugation only finitely many irreducible representations of $\Gamma_{K}$ onto the subgroups $A_{4}^{\mathrm{SL}(2)}, S_{4}^{\mathrm{SL}(2)}$ and $A_{5}^{\mathrm{SL}(2)}$. Note that these finitely many orbits are closed and 3-dimensional. Hence the irreducible $\rho \in R_{\lambda}$ such that $r_{n} \circ \rho$ is reducible is contained in a Zariski-closed subset of $R_{\lambda}$. Hence generically $r_{n} \circ \rho$ is irreducible for $\rho \in R_{\lambda}$.

In order to proof that a certain representation $\rho \in R_{n}(\Gamma)$ is a smooth point of the representation variety we will prove that every cocycle $u \in Z^{1}\left(\Gamma_{K} ; \mathfrak{s l}(n)_{\rho}\right)$ is integrable. In order to do this, we use the classical approach, i.e. we first solve the corresponding formal problem and apply then a theorem of Artin Art68.

The formal deformations of a representation $\rho: \Gamma \rightarrow \mathrm{SL}(n)$ are in general determined by an infinite sequence of obstructions (see Gol84, BA00, HPSP01). In what follows we let $C^{1}\left(\Gamma ; \mathfrak{s l}(n)_{\rho}\right):=\left\{c: \Gamma \rightarrow \mathfrak{s l}(n)_{\rho}\right\}$ denote the 1-cochains of $\Gamma$ with coefficients in $\mathfrak{s l}(n)_{\rho}$ (see [Bro82, p.59]).

Let $\rho: \Gamma \rightarrow \mathrm{SL}(n)$ be a representation. A formal deformation of $\rho$ is a homomorphism $\rho_{\infty}: \Gamma \rightarrow \mathrm{SL}(n, \mathbf{C} \llbracket t \rrbracket)$

$$
\rho_{\infty}(\gamma)=\exp \left(\sum_{i=1}^{\infty} t^{i} u_{i}(\gamma)\right) \rho(\gamma), \quad u_{i} \in C^{1}\left(\Gamma ; \mathfrak{s l}(n)_{\rho}\right)
$$

such that $\mathrm{ev}_{0} \circ \rho_{\infty}=\rho$. Here $\mathrm{ev}_{0}: \mathrm{SL}(n, \mathbf{C} \llbracket t \rrbracket) \rightarrow \mathrm{SL}(n)$ is the evaluation homomorphism at $t=0$ and $\mathbf{C} \llbracket t \rrbracket$ denotes the ring of formal power series.

We will say that $\rho_{\infty}$ is a formal deformation up to order $k$ of $\rho$ if $\rho_{\infty}$ is a homomorphism modulo $t^{k+1}$.

An easy calculation gives that $\rho_{\infty}$ is a homomorphism up to first order if and only if $u_{1} \in Z^{1}\left(\Gamma ; \mathfrak{s l}(n)_{\rho}\right)$ is a cocycle. We call a cocycle $u_{1} \in Z^{1}\left(\Gamma ; \mathfrak{s l}(n)_{\rho}\right)$ integrable if there is a formal deformation of $\rho$ with leading term $u_{1}$.

Lemma 3.2. Let $u_{1}, \ldots, u_{k} \in C^{1}\left(\Gamma ; \mathfrak{s l}(n)_{\rho}\right)$ such that

$$
\rho_{k}(\gamma)=\exp \left(\sum_{i=1}^{k} t^{i} u_{i}(\gamma)\right) \rho(\gamma)
$$

is a homomorphism into $\mathrm{SL}(n, \mathbf{C} \llbracket t \rrbracket)$ modulo $t^{k+1}$. Then there exists an obstruction class $\zeta_{k+1}:=\zeta_{k+1}^{\left(u_{1}, \ldots, u_{k}\right)} \in H^{2}\left(\Gamma, \mathfrak{s l}(n)_{\rho}\right)$ with the following properties:
(i) There is a cochain $u_{k+1}: \Gamma \rightarrow \mathfrak{s l}(n)_{\rho}$ such that

$$
\rho_{k+1}(\gamma)=\exp \left(\sum_{i=1}^{k+1} t^{i} u_{i}(\gamma)\right) \rho(\gamma)
$$

is a homomorphism modulo $t^{k+2}$ if and only if $\zeta_{k+1}=0$.
(ii) The obstruction $\zeta_{k+1}$ is natural, i.e. if $f: \Gamma_{1} \rightarrow \Gamma$ is a homomorphism then $f^{*} \rho_{k}:=\rho_{k} \circ f$ is also a homomorphism modulo $t^{k+1}$ and $f^{*}\left(\zeta_{k+1}^{\left(u_{1}, \ldots, u_{k}\right)}\right)=$ $\zeta_{k+1}^{\left(f^{*} u_{1}, \ldots, f^{*} u_{k}\right)} \in H^{2}\left(\Gamma_{1} ; \mathfrak{s l}(n)_{f^{*} \rho}\right)$.

Proof. The proof is completely analogous to the proof of Proposition 3.1 in HPSP01. We replace $\mathrm{SL}(2)$ and $\mathfrak{s l}(2)$ by $\mathrm{SL}(n)$ and $\mathfrak{s l}(n)$ respectively.

The following result streamlines the arguments given in HP05 and BAHJ10:
Proposition 3.3. Let $M$ be a connected, compact, orientable 3-manifold with torus boundary and let $\rho: \pi_{1} M \rightarrow \mathrm{SL}(n)$ be a representation.

If $\operatorname{dim} H^{1}\left(\pi_{1} M ; \mathfrak{s l}(n)_{\rho}\right)=n-1$ then $\rho$ is a smooth point of the $\operatorname{SL}(n)$ representation variety $R_{n}\left(\pi_{1} M\right)$. Moreover, $\rho$ is contained in a unique component of dimension $n^{2}+n-2-\operatorname{dim} H^{0}\left(\pi_{1} M ; \mathfrak{s l}(n)_{\rho}\right)$.

Proof. First we will show that the map $i^{*}: H^{2}\left(\pi_{1} M ; \mathfrak{s l}(n)_{\rho}\right) \rightarrow H^{2}\left(\pi_{1} \partial M ; \mathfrak{s l}(n)_{\rho}\right)$ induced by the inclusion $\partial M \hookrightarrow M$ is injective.

Recall that for any CW-complex $X$ with $\pi_{1}(X) \cong \pi_{1}(M)$ and for any $\pi_{1} M$ module $A$ there are natural morphisms $H^{i}\left(\pi_{1} M ; A\right) \rightarrow H^{i}(X ; A)$ which are isomorphisms for $i=0,1$ and an injection for $i=2$ (see HP05, Lemma 3.3]). Note also that $\partial M \cong S^{1} \times S^{1}$ is aspherical and hence $H^{*}\left(\pi_{1} \partial M ; A\right) \rightarrow H^{*}(\partial M ; A)$ is an isomorphism.

We will make use of a result of Richardson Ric79, Thm. C]. Richardson proved that the representation variety $R_{n}(\mathbf{Z} \oplus \mathbf{Z})$ is an irreducible algebraic variety of dimension $(n+2)(n-1)$. It follows from Poincaré duality and the Euler characteristic that for every $\varrho \in R_{n}(\mathbf{Z} \oplus \mathbf{Z})$

$$
\begin{equation*}
\operatorname{dim} H^{1}\left(\partial M ; \mathfrak{s l}(n)_{\varrho}\right)=2 \operatorname{dim} H^{0}\left(\partial M ; \mathfrak{s l}(n)_{\varrho}\right) \geq 2(n-1) \tag{3.1}
\end{equation*}
$$

Hence $\varrho \in R_{n}(\mathbf{Z} \oplus \mathbf{Z})$ is a smooth point if and only if the dimension of $\mathfrak{s l}(n)_{\varrho}^{\mathbf{Z} \oplus \mathbf{Z}}=$ $H^{0}\left(\mathbf{Z} \oplus \mathbf{Z} ; \mathfrak{s l}(n)_{\varrho}\right)$ is minimal i.e. $\operatorname{dim} H^{0}\left(\mathbf{Z} \oplus \mathbf{Z} ; \mathfrak{s l}(n)_{\varrho}\right)=n-1$ (see also Pop08).

The exact cohomology sequence of the pair $(M, \partial M)$ gives

$$
\begin{aligned}
\rightarrow H^{1}( & \left.M, \partial M ; \mathfrak{s l}(n)_{\rho}\right) \\
& \rightarrow H^{1}\left(M ; \mathfrak{s l}(n)_{\rho}\right) \xrightarrow{\alpha} H^{1}\left(\partial M ; \mathfrak{s l}(n)_{\rho}\right) \xrightarrow{\beta} H^{2}\left(M, \partial M ; \mathfrak{s l}(n)_{\rho}\right) \\
& \rightarrow H^{2}\left(M ; \mathfrak{s l}(n)_{\rho}\right) \xrightarrow{i^{*}} H^{2}\left(\partial M ; \mathfrak{s l}(n)_{\rho}\right) \rightarrow H^{3}\left(M, \partial M ; \mathfrak{s l}(n)_{\rho}\right) \rightarrow 0 .
\end{aligned}
$$

Poincaré-Lefschetz duality implies that $\alpha$ and $\beta$ are dual to each other. Therefore we have

$$
n-1=\operatorname{dim} H^{1}\left(M ; \mathfrak{s l}(n)_{\rho}\right) \geq \operatorname{rk}(\alpha)=\frac{1}{2} \operatorname{dim} H^{1}\left(\partial M ; \mathfrak{s l}(n)_{\rho}\right) \geq n-1
$$

and Equation (3.1) together with Richardson's result imply that $i^{*} \rho=\rho \circ i_{\#} \in$ $R_{n}(\partial M)$ is a smooth point of the representation variety (here $i: \partial M \rightarrow M$ is the inclusion). Note also that $\beta$ is surjective and hence

$$
i^{*}: H^{2}\left(M ; \mathfrak{s l}(n)_{\rho}\right) \rightarrow H^{2}\left(\partial M ; \mathfrak{s l}(n)_{\rho}\right)
$$

is injective. The following commutative diagram shows that $i^{*}: H^{2}\left(\pi_{1} M ; \mathfrak{s l}(n)_{\rho}\right) \rightarrow$ $H^{2}\left(\pi_{1} \partial M ; \mathfrak{s l}(n)_{\rho}\right)$ is injective:


In order to prove that $\rho$ is a smooth point of $R_{n}\left(\pi_{1} M\right)$, we show that all cocycles in $Z^{1}\left(\pi_{1} M, \mathfrak{s l}(n)_{\rho}\right)$ are integrable. In what follows we will prove that all obstructions vanish, by using the fact that the obstructions vanish on the boundary. Let $u_{1}, \ldots, u_{k}: \pi_{1} M \rightarrow \mathfrak{s l}(n)$ be given such that

$$
\rho_{k}(\gamma)=\exp \left(\sum_{i=1}^{k} t^{i} u_{i}(\gamma)\right) \rho(\gamma)
$$

is a homomorphism modulo $t^{k+1}$. Then the restriction $i^{*} \rho_{k}: \pi_{1}(\partial M) \rightarrow \mathrm{SL}(n, \mathbf{C} \llbracket t \rrbracket)$ is also a formal deformation of order $k$. Since $i^{*} \rho$ is a smooth point of the representation variety $R_{n}(\mathbf{Z} \oplus \mathbf{Z})$, the formal implicit function theorem gives that $i^{*} \rho_{k}$ extends to a formal deformation of order $k+1$ (see HPSP01, Lemma 3.7]). Therefore, we have that

$$
0=\zeta_{k+1}^{\left(i^{*} u_{1}, \ldots, i^{*} u_{k}\right)}=i^{*} \zeta_{k+1}^{\left(u_{1}, \ldots, u_{k}\right)}
$$

Now, $i^{*}$ is injective and the obstruction $\zeta_{k+1}^{\left(u_{1}, \ldots, u_{k}\right)}$ vanishes.
Hence all cocycles in $Z^{1}\left(\Gamma, \mathfrak{s l}(n)_{\rho}\right)$ are integrable. By applying Artin's theorem Art68] we obtain from a formal deformation of $\rho$ a convergent deformation (see HPSP01, Lemma 3.3] or BA00, § 4.2]).

Thus $\rho$ is a smooth point of the representation variety $R_{n}\left(\pi_{1} M\right)$. Hence, $\operatorname{dim} H^{1}\left(\pi_{1} M ; \mathfrak{s l}(n)_{\rho}\right)=n-1$ and the exactness of

$$
0 \rightarrow H^{0}\left(\pi_{1} M ; \mathfrak{s l}(n)_{\rho}\right) \rightarrow \mathfrak{s l}(n)_{\rho} \rightarrow B^{1}\left(\pi_{1} M ; \mathfrak{s l}(n)_{\rho}\right) \rightarrow 0
$$

implies

$$
\operatorname{dim} Z^{1}\left(\pi_{1} M ; \mathfrak{s l}(n)_{\rho}\right)=n^{2}+n-2-\operatorname{dim} H^{0}\left(\pi_{1} M ; \mathfrak{s l}(n)_{\rho}\right)
$$

Proposition 3.4. Let $K \subset S^{3}$ be a knot, $\lambda \in \mathbf{C}^{*}$ and $n \geq 3$. Suppose that $\lambda^{2}$ is a simple root of the Alexander polynomial $\Delta_{K}(t)$ and let $\rho_{\lambda}^{z}: \Gamma \rightarrow B_{2}$ be a non-abelian representation as in the introduction.

If $\Delta_{K}\left(\lambda^{2 i}\right) \neq 0$ for $2 \leq i \leq n-1$ then for $\rho_{\lambda, n}^{z}:=r_{n} \circ \rho_{\lambda}^{z}: \Gamma \rightarrow B_{n} \subset \operatorname{SL}(n)$ we have

$$
\operatorname{dim} H^{1}\left(\Gamma_{K} ; \mathfrak{s l}(n)_{\rho_{\lambda, n}^{z}}\right)=(n-1) \text { and } H^{0}\left(\Gamma_{K} ; \mathfrak{s l}(n)_{\rho_{\lambda, n}^{z}}\right)=0
$$

Proof. A proof of the cohomological calculation will be given in Section 4 .
Proof of Theorem 1.1. It follows directly form Propositions 3.3 and 3.4 that $\rho_{\lambda, n}^{z}$ is a smooth point of $R_{n}\left(\Gamma_{K}\right)$ which is contained in a unique component $R_{\lambda, n} \subset$ $R_{n}\left(\Gamma_{K}\right), \operatorname{dim} R_{\lambda, n}=n^{2}+n-2$.

That $\rho_{\lambda, n}^{z}$ is the limit of irreducible representation which are contained in the component $R_{\lambda, n}$ follows from Proposition 3.1,

## 4. COHOMOLOGICAL CALCULATIONS

For the convenience of the reader we recall some facts from the representation theory of SL(2). The general reference for this topic is Springer's LNM Spr77.
4.1. Representation theory of $\mathrm{SL}(2)$. Let $V$ be an $n$-dimensional complex vector space. In what follows we will call a homomorphism $r: \mathrm{SL}(2) \rightarrow \mathrm{GL}(V)$ an $n$-dimensional representation of $\mathrm{SL}(2)$. The vector space $V$ turns into a SL(2)-module. Two $n$-dimensional representations $r: \mathrm{SL}(2) \rightarrow \mathrm{GL}(V)$ and $r^{\prime}: \mathrm{SL}(2) \rightarrow \mathrm{GL}\left(V^{\prime}\right)$ are called equivalent if there is an isomorphism $\phi: V \rightarrow V^{\prime}$ which commutes with the action of $\mathrm{SL}(2)$ i.e. $r^{\prime}(A) \phi=\phi r(A)$ for all $A \in \mathrm{SL}(2)$. It is clear that equivalent representations give rise to isomorphic $\mathrm{SL}(2)$-modules.

We let $\mathrm{SL}(2)$ act as a group of automorphism on the polynomial algebra $R=\mathbf{C}[X, Y]$. If $\left(\begin{array}{ll}a & b \\ c & d\end{array}\right) \in \mathrm{SL}(2)$ then there is a unique automorphism $r\left(\begin{array}{ll}a & b \\ c & d\end{array}\right)$ of $R$ given by

$$
r\left(\begin{array}{ll}
a & b \\
c & d
\end{array}\right)(X)=d X-b Y \quad \text { and } \quad r\left(\begin{array}{ll}
a & b \\
c & d
\end{array}\right)(Y)=-c X+a Y .
$$

We let $R_{n-1} \subset R$ denote the $n$-dimensional subspace of homogeneous polynomials of degree $n-1$. The monomials $e_{l}^{(n-1)}=X^{l-1} Y^{n-l}, 1 \leq l \leq n$, form a basis of $R_{n-1}$ and $r\left(\begin{array}{cc}a & b \\ c & d\end{array}\right)$ leaves $R_{n-1}$ invariant. In what follows we will identify $R_{n-1}$ and $\mathbf{C}^{n}$ by fixing the basis $\left(e_{1}^{(n-1)}, \ldots, e_{n}^{(n-1)}\right)$ of $R_{n-1}$. We obtain an $n$-dimensional representation $r_{n}: \mathrm{SL}(2) \rightarrow \mathrm{GL}\left(R_{n-1}\right) \cong \mathrm{GL}(n)$.

The representation $r_{n}$ is rational i.e. the coefficients of the matrix coordinates of $r_{n}(A)$ are polynomials in the matrix coordinates of $A$. We will make use of the following theorem.

Theorem 4.1. (1) The representation $r_{n}$ is irreducible i.e. there is no $\mathrm{SL}(2)$ stable invariant subspaces $V,\{0\} \subsetneq V \subsetneq R_{n-1}$ and any irreducible rational representation of $\mathrm{SL}(2)$ is equivalent to some $r_{n}$.
(2) For an arbitrary rational representation $r: \mathrm{SL}(2) \rightarrow \mathrm{GL}(V)$ the $\mathrm{SL}(2)-$ module $V$ is isomorphic to a direct sum of $R_{n}$,

$$
V \cong \bigoplus_{d \geq 0} R_{d}^{m(k)}
$$

Proof. For (11) see Lemma 3.1.3 and Proposition 3.2.1 of Spr77].
It is easy to see, and it follows also from the general theory, that $r_{n}$ maps an unipotent matrix $\left(\begin{array}{ll}1 & b \\ 0 & 1\end{array}\right)$ and $\left(\begin{array}{ll}1 & 0 \\ c & 1\end{array}\right)$ onto an unipotent element of $\operatorname{SL}\left(R_{n-1}\right)$. Moreover, an explicit calculations shows that the image of a diagonal matrix is the diagonal matrix $r_{n}\left(\operatorname{diag}\left(a, a^{-1}\right)\right)=\operatorname{diag}\left(a^{n-1}, a^{n-3}, \ldots, a^{-n+3}, a^{-n+1}\right)$. Hence the image of $r_{n}$ is contained in $\operatorname{SL}\left(R_{n-1}\right) \cong \operatorname{SL}(n)$.

Example 1. The representation $r_{1}: \mathrm{SL}(2) \rightarrow \mathrm{SL}(1)=\{1\}$ is the trivial representation. The representation $r_{2}: \mathrm{SL}(2) \rightarrow \mathrm{SL}(2)$ is equivalent to the identity:

$$
r_{2}\left(\begin{array}{ll}
a & b \\
c & d
\end{array}\right)=\left(\begin{array}{cc}
a & -b \\
-c & d
\end{array}\right)=\left(\begin{array}{cc}
i & 0 \\
0 & -i
\end{array}\right)\left(\begin{array}{ll}
a & b \\
c & d
\end{array}\right)\left(\begin{array}{cc}
-i & 0 \\
0 & i
\end{array}\right) .
$$

Moreover, it is easy to see that the adjoint representation $\operatorname{Ad}: \operatorname{SL}(2) \rightarrow \operatorname{Aut}(\mathfrak{s l}(2))$ is equivalent to $r_{3}$.

The Lie algebra $\mathfrak{s l}(n)$ of $\mathrm{SL}(n)$ turns into an $\mathrm{SL}(2)$-module via $\mathrm{Ad} \circ r_{n}$ where $\operatorname{Ad}: \operatorname{SL}(n) \rightarrow \operatorname{Aut}(\mathfrak{s l}(n))$ denotes the adjoint representation. For this action we have the classical formula of Clebsch-Gordan:

$$
\begin{equation*}
\operatorname{Ad} \circ r_{n} \cong \bigoplus_{i=1}^{n-1} r_{2 i+1} \tag{4.1}
\end{equation*}
$$

Let $B_{n} \subset \mathfrak{s l}(n)$ denote the Borel subgroup of upper triangular matrices. The vector space $R_{n-1}$ turns into a $B_{2}$-module via restriction of $r_{n}$ to $B_{2}$. An explicit calculation gives

$$
r_{n}\left(\begin{array}{cc}
\lambda & \lambda^{-1} b  \tag{4.2}\\
0 & \lambda^{-1}
\end{array}\right) \cdot e_{l}^{(n-1)}=\lambda^{n-2 l+1} \sum_{j=0}^{l-1}(-b)^{j}\binom{l-1}{j} e_{l-j}^{(n-1)} .
$$

Hence $r_{n}\left(B_{2}\right)$ is contained in $B_{n} \subset \mathrm{SL}(n)$ and the one-dimensional vector space $\left\langle e_{1}^{(n-1)}\right\rangle$ is $B_{2}$ invariant: $r_{n}\left(\begin{array}{c}\lambda \lambda^{-1} b \\ 0 \\ \lambda^{-1}\end{array}\right) \cdot e_{1}^{(n-1)}=\lambda^{n-1} e_{1}^{(n-1)}$. For a given integer $i \in \mathbf{Z}$ we let $\chi_{i}: B_{2} \rightarrow \mathbf{C}^{*}=\mathrm{GL}(1, \mathbf{C})$ denote the rational character given by

$$
\chi_{i}\left(\begin{array}{cc}
\lambda & \lambda^{-1} b \\
0 & \lambda^{-1}
\end{array}\right)=\lambda^{i} .
$$

Now $\mathbf{C}$ turns into a $B_{2}$-module via $\chi_{i}$ i.e. $\left(\begin{array}{cc}\lambda & \lambda^{-1} b \\ 0 & \lambda^{-1}\end{array}\right) \cdot x=\lambda^{i} x$ for $x \in \mathbf{C}$. We will denote this $B_{2}$-module by $\mathbf{C}_{\chi_{i}}$. It follows that the $B_{2}$-module $\left\langle e_{1}^{(n-1)}\right\rangle \in R_{n-1}$ is isomorphic to $\mathbf{C}_{\chi_{n-1}}$ and we obtain a short exact sequence of $B_{2}$-modules

$$
\begin{equation*}
0 \rightarrow \mathbf{C}_{\chi_{n-1}} \rightarrow R_{n-1} \rightarrow \bar{R}_{n-1} \rightarrow 1 \tag{4.3}
\end{equation*}
$$

where $\bar{R}_{n-1}$ denotes the quotient $R_{n-1} /\left\langle e_{1}^{(n-1)}\right\rangle$. For a given element $x \in R_{n-1}$ we let $\bar{x} \in \bar{R}_{n-1}$ denote the class represented by $x$ i.e. $\bar{x}=x+\left\langle e_{1}^{(n-1)}\right\rangle$.

For abbreviation, we will drop the representation $r_{n}$ from the notation and write for $x \in R_{n-1}$

$$
\left(\begin{array}{cc}
\lambda & \lambda^{-1} b \\
0 & \lambda^{-1}
\end{array}\right) \cdot x \text { instead of } r_{n}\left(\begin{array}{cc}
\lambda & \lambda^{-1} b \\
0 & \lambda^{-1}
\end{array}\right) \cdot x
$$

Lemma 4.2. The linear map $\phi_{n-3}: R_{n-3} \rightarrow \bar{R}_{n-1}$ defined by

$$
\phi_{n-3}\left(e_{l}^{(n-3)}\right)=\frac{1}{l} \bar{e}_{l+1}^{(n-1)}, \quad l=1, \ldots, n-2
$$

is an injective $B_{2}$-module morphism i.e. for all $x \in R_{n-3}$ we have

$$
\left(\begin{array}{cc}
\lambda & \lambda^{-1} b \\
0 & \lambda^{-1}
\end{array}\right) \cdot \phi_{n-3}(x)=\phi_{n-3}\left(\left(\begin{array}{cc}
\lambda & \lambda^{-1} b \\
0 & \lambda^{-1}
\end{array}\right) \cdot x\right)
$$

Proof. The linear map $\phi_{n-3}$ is injective since the vectors $\bar{e}_{l}^{(n-1)}, 2 \leq l \leq n$, form a basis of $\bar{R}_{n-1}$. Now

$$
\left(\begin{array}{cc}
\lambda & \lambda^{-1} b \\
0 & \lambda^{-1}
\end{array}\right) \cdot \phi_{n-3}\left(e_{l}^{(n-3)}\right)=\lambda^{n-2 l-1} \frac{1}{l} \sum_{j=0}^{l}(-b)^{j}\binom{l}{j} \bar{e}_{l-j+1}^{(n-1)}
$$

Since $\binom{l}{j}(l-j)=l\binom{l-1}{j}$ and $\bar{e}_{1}^{(n-1)}=0$ it follows

$$
\begin{aligned}
\left(\begin{array}{cc}
\lambda & \lambda^{-1} b \\
0 & \lambda^{-1}
\end{array}\right) \cdot \phi_{n-3}\left(e_{l}^{(n-3)}\right) & =\lambda^{(n-2)-2 l+1} \sum_{j=0}^{l-1}(-b)^{j}\binom{l-1}{j} \frac{1}{l-j} \bar{e}_{l-j+1}^{(n-1)} \\
& =\phi_{n-3}\left(\left(\begin{array}{cc}
\lambda & \lambda^{-1} b \\
0 & \lambda^{-1}
\end{array}\right) \cdot e_{l}^{(n-3)}\right)
\end{aligned}
$$

Hence $\phi_{n-3}$ is a $B_{2}$-module morphism.
Lemma 4.3. There is a short exact sequence of $B_{2}$-modules

$$
\begin{equation*}
0 \rightarrow R_{n-3} \xrightarrow{\phi_{n-3}} \bar{R}_{n-1} \rightarrow \mathbf{C}_{\chi-n+1} \rightarrow 0 \tag{4.4}
\end{equation*}
$$

Proof. Again the lemma follows from Equation (4.2):

$$
\left(\begin{array}{cc}
\lambda \lambda^{-1} b \\
0 & \lambda^{-1}
\end{array}\right) \cdot e_{n}^{(n-1)} \equiv \lambda^{-n+1} e_{n}^{(n-1)} \bmod \left\langle e_{1}^{(n-1)}, \ldots, e_{n-1}^{(n-1)}\right\rangle
$$

Let us fix a representation $\rho_{\lambda}^{z}: \Gamma \rightarrow B_{2}$. Then $R_{n}$ turns into a $\Gamma$-module and the exact sequences (4.3) and (4.4) are exact sequences of $\Gamma$-modules. Note that $\mathbf{C}_{\chi_{k}} \cong \mathbf{C}_{\lambda^{k}}$ since for all $\gamma \in \Gamma$ and $k \in \mathbf{Z}$ the equation $\chi_{k}\left(\rho_{\lambda}^{z}(\gamma)\right)=\lambda^{k \varphi(\gamma)}$ holds.

Lemma 4.4. Let $\lambda \in \mathbf{C}^{*}, \lambda \neq 1$, and $n>3$ be given. If $\Delta_{K}\left(\lambda^{n-1}\right) \neq 0$ and if $\lambda^{n-1} \neq 1$ then

$$
H^{*}\left(\Gamma_{K} ; R_{n-1}\right) \cong H^{*}\left(\Gamma_{K} ; R_{n-3}\right)
$$

Proof. The long exact cohomology sequences Bro82, III.§6] associated to the short exact sequences (4.3) gives:

$$
H^{k}\left(\Gamma_{K} ; \mathbf{C}_{\lambda^{n-1}}\right) \rightarrow H^{k}\left(\Gamma_{K} ; R_{n-1}\right) \rightarrow H^{k}\left(\Gamma_{K} ; \bar{R}_{n-1}\right) \rightarrow H^{k+1}\left(\Gamma_{K} ; \mathbf{C}_{\lambda^{n-1}}\right)
$$

is exact for $k=0,1,2$. Now $H^{0}\left(\Gamma_{K} ; \mathbf{C}_{\lambda^{n-1}}\right)=0$ since $\lambda^{n-1} \neq 1$ and for $k=1,2$ the group $H^{k}\left(\Gamma_{K} ; \mathbf{C}_{\lambda^{n-1}}\right)=0$ since $\Delta_{K}\left(\lambda^{n-1}\right) \neq 0$ (see Lemma 2.1). Hence

$$
H^{k}\left(\Gamma_{K} ; R_{n-1}\right) \xrightarrow{\cong} H^{k}\left(\Gamma_{K} ; \bar{R}_{n-1}\right) \quad \text { for } k=0,1,2 .
$$

Finally, the short exact Sequence (4.4), Lemma 2.1 and the assumptions $\Delta_{K}\left(\lambda^{n-1}\right) \neq 0$ and if $\lambda^{n-1} \neq 1$ give that

$$
H^{k}\left(\Gamma_{K} ; R_{n-3}\right) \stackrel{\cong}{\leftrightarrows} H^{k}\left(\Gamma_{K} ; \bar{R}_{n-1}\right) \quad \text { for } k=0,1,2 .
$$

are isomorphisms (note that $\Delta_{K}(t)$ is symmetric).
Proposition 4.5. Let $\lambda \in \mathbf{C}^{*}, \Delta_{K}\left(\lambda^{2}\right)=0, n \geq 3$ and $\rho_{\lambda}^{z}: \Gamma \rightarrow B_{2}$ be given as in the introduction. If $\Delta_{K}\left(\lambda^{2 k}\right) \neq 0$ and $\lambda^{2 k} \neq 1$ for $2 \leq k \leq n-1$ then for $\rho_{\lambda, n}^{z}:=r_{n} \circ \rho_{\lambda}^{z}: \Gamma \rightarrow B_{n} \subset \operatorname{SL}(n)$ we have

$$
\operatorname{dim} H^{*}\left(\Gamma_{K} ; \mathfrak{s l}(n)_{\rho_{\lambda, n}^{z}}\right)=(n-1) \operatorname{dim} H^{*}\left(\Gamma_{K} ; R_{2}\right)
$$

Proof. It follows from (4.1) that we have an isomorphism of $\Gamma$-modules:

$$
\mathfrak{s l}(n)_{\rho_{n}} \cong \bigoplus_{k=1}^{n-1} R_{2 k}
$$

Now Lemma 4.4implies that $\operatorname{dim} H^{*}\left(\Gamma, R_{2 k}\right)=\operatorname{dim} H^{*}\left(\Gamma, R_{2}\right)$ since $\Delta_{K}\left(\lambda^{2 k}\right) \neq$ 0 and $\lambda^{2 k} \neq 1$ for $2 \leq k \leq n-1$. Hence the assertion of the proposition follows.

Proof of Proposition 3.4. Let $\lambda \in \mathbf{C}^{*}$ and $n \in \mathbf{Z}, n \geq 3$. Suppose that $\lambda^{2}$ is a simple root of the Alexander polynomial $\Delta_{K}(t)$ and let $\rho_{\lambda}^{z}: \Gamma \rightarrow B_{2}$ be a non-abelian representation as in the introduction.

In order to apply Proposition 4.5 we have to show that $\lambda^{2 k} \neq 1$ for $2 \leq k \leq$ $n-1$. Suppose that there exists $k \in \mathbf{Z}, 2 \leq k \leq n-1$, such that $\lambda^{2 k}=1$. Next note that $\lambda^{-2}=\lambda^{2 k-2}$ is a root of the Alexander polynomial since $\Delta_{K}(t)$ is symmetric. Therefore the assumption of the proposition implies that $k=2$ i.e. $\lambda^{4}=1$ and hence $\lambda^{2}= \pm 1$. On the other hand, $\pm 1$ is not a root of $\Delta_{K}(t)$ since $\Delta_{K}(1)= \pm 1$ and $\Delta_{K}(-1)$ is an odd integer. This gives a contradiction and hence $\lambda^{2 k} \neq 1$ for $2 \leq k \leq n-1$. Therefore, Proposition 4.5 implies that

$$
\operatorname{dim} H^{*}\left(\Gamma_{K} ; \mathfrak{s l}(n)_{\rho_{\lambda, n}^{z}}\right)=(n-1) \operatorname{dim} H^{*}\left(\Gamma_{K} ; R_{2}\right)
$$

Finally, observe that $\mathfrak{s l}(2)_{\rho_{\lambda}^{z}} \cong R_{2}$ (see Example (1) and $\operatorname{dim} H^{1}\left(\Gamma_{K} ; R_{2}\right)=1$ follows from HP05, Corollary 5.4] or [HPSP01, 4.4]. It is easy to see that $H^{0}\left(\Gamma_{K} ; R_{2}\right)=0$ since $\rho_{\lambda}^{z}$ is non-abelian.

## 5. Examples

Let $K \subset S^{3}$ be a knot and $\lambda^{2}$ a simple root of $\Delta_{K}(t)$. Theorem 1.1 implies that if $\Delta_{K}\left(\lambda^{2 k}\right) \neq 0$ for all $k \in \mathbf{Z}, k \neq \pm 1$, then the for all $n \geq 2, n \in$ $\mathbf{Z}$, the representation space $R_{n}\left(\Gamma_{K}\right)$ contains a component $R_{\lambda, n}$ of dimension $n^{2}+n-2$. Moreover, $R_{\lambda, n}$ contains irreducible representations and generically a representation $\rho \in R_{\lambda, n}$ is irreducible (this follows for example from New78, Prop. 3.8]).

Corollary 5.1. Let $K \subset S^{3}$ be a knot with the Alexander polynomial of the figure-eight knot.

Then the representation variety $R_{n}\left(\Gamma_{K}\right)$ contains an $\left(n^{2}+n-2\right)$-dimensional component and the irreducible representations form an Zariski-open subset of this component.

Proof. The Alexander polynomial of the figure-eight knot is $\Delta(t)=t^{2}-3 t+1$ and its roots are $\lambda^{ \pm 2}=3 / 2 \pm \sqrt{5} / 2$ and no power $\lambda^{ \pm 2 k}, k \neq \pm 1$, is a root of $\Delta(t)$.

The situation for the trefoil knot $3_{1}$ is more complicate since the roots of its Alexander polynomial $\Delta_{3_{1}}(t)=t^{2}-t+1$ are the 6 -th roots of unity $\lambda^{ \pm 2}=$ $e^{ \pm i \pi / 3}$. Hence $R_{n}\left(\Gamma_{3_{1}}\right)$ contains an $\left(n^{2}+n-2\right)$-dimensional component $R_{\lambda, n}$ for $n \in\{2,3,4,5\}$ since $e^{ \pm i \pi / 3}$ is a simple root of $\Delta_{3_{1}}(t)$ and since $\Delta_{3_{1}}\left(e^{ \pm i k \pi / 3}\right) \neq 0$ for $k \in\{2,3,4\}$. Let us study the case $n=6$ : the group $\Gamma_{3_{1}}$ is free product with amalgamation

$$
\Gamma_{3_{1}}=\langle S, T \mid S T S=T S T\rangle \cong\left\langle x, y \mid x^{2}=y^{3}\right\rangle \cong\langle x \mid-\rangle *\langle c \mid-\rangle\langle y \mid-\rangle
$$

where $x=S T S, y=T S$, and $c=x^{2}=y^{3}$ generates the center of $\Gamma_{3_{1}}$. Note that a meridian $\mu$ of $3_{1}$ is represented by the Wirtinger generator $\mu=S=x y^{-1}$. Let $\rho: \Gamma_{3_{1}} \rightarrow \mathrm{SL}(n)$ be an irreducible representation. Since $\rho$ is irreducible the generator of the center $x^{2}=c=y^{3}$ has to be mapped into the center

$$
C_{n}:=\left\{\left.\exp \left(2 \pi \frac{k}{n}\right) I_{n} \right\rvert\, 1 \leq k \leq n\right\} \subset \mathrm{SL}(n)
$$

of $\operatorname{SL}(n)$. It follows that if $R \subset R_{n}\left(\Gamma_{3_{1}}\right)$ is an irreducible component of the representation variety then the conjugacy classes represented by the elements $\rho(c), \rho(x), \rho(y)$ in $\operatorname{SL}(n)$ do not vary with $\rho \in R$. Now let $\lambda=e^{i \pi / 6}$ be a primitive 12 -th root of unity. A cohomological non-trivial cocycle $z \in Z^{1}\left(\Gamma_{3_{1}} ; \mathbf{C}_{\lambda^{2}}\right)$ is given by $z(S)=0$ and $z(T)=1$. Therefore the representation $\rho_{\lambda}^{z}: \Gamma_{3_{1}} \rightarrow \mathrm{SL}(2)$ is
given by

$$
\rho_{\lambda}^{z}(S)=\left(\begin{array}{cc}
\lambda & 0 \\
0 & \lambda^{-1}
\end{array}\right) \quad \text { and } \quad \rho_{\lambda}^{z}(T)=\left(\begin{array}{cc}
\lambda & \lambda^{-1} \\
0 & \lambda^{-1}
\end{array}\right) .
$$

Hence

$$
\rho_{\lambda}^{z}(x)=\left(\begin{array}{cc}
i & \lambda^{-1} \\
0 & -i
\end{array}\right), \quad \rho_{\lambda}^{z}(y)=\left(\begin{array}{cc}
\lambda^{2} & \lambda^{-2} \\
0 & \lambda^{-2}
\end{array}\right) \quad \text { and } \quad \rho_{\lambda}^{z}(c)=-I_{2}
$$

Proposition 3.1 implies that $\rho_{\lambda, n}^{z}=r_{n} \circ \rho_{\lambda}^{z}$ is a limit of irreducible representations. Computer supported calculations show that $\operatorname{dim} H^{1}\left(\Gamma_{K} ; R_{10}\right)=3$ and Lemma 4.4 implies that $\operatorname{dim} H^{1}\left(\Gamma_{K} ; R_{2 k}\right)=\operatorname{dim} H^{1}\left(\Gamma_{K} ; R_{2}\right)=1$ for $k \in$ $\{2,3,4\}$. Hence Formula 4.1 implies that

$$
\operatorname{dim} H^{1}\left(\Gamma_{K} ; \mathfrak{s l}(6)\right)=7 \quad \text { i.e. } \quad Z^{1}\left(\Gamma_{K} ; \mathfrak{s l}(6)\right)=42
$$

In order to see that $\rho_{\lambda, n}^{z}$ is contained in a 42-dimensional component of $R_{6}\left(\Gamma_{K}\right)$ we proceed as follows: let $A=\rho_{\lambda, n}^{z}(x)$ and $B=\rho_{\lambda, n}^{z}(y)$ denote the image of $x$ and $y$ respectively. Notice that the matrices $A$ and $B$ are conjugate to $r_{6}\left(\begin{array}{cc}i & 0 \\ 0 & -i\end{array}\right)$ and $r_{6}\left(\begin{array}{cc}\lambda^{2} & 0 \\ 0 & \lambda^{-2}\end{array}\right)$. Hence

$$
A \sim\left(\begin{array}{cccccc}
i & & & & \mathbf{0} & \\
& i & & & & \\
& & i & & & \\
& & & -i & & \\
& & & & -i & \\
& \mathbf{0} & & & & -i
\end{array}\right) \text { and } B \sim\left(\begin{array}{cccccc}
-1 & & & & \mathbf{0} & \\
& -1 & & & & \\
& & \lambda^{2} & & & \\
& & & \lambda^{2} & & \\
& \mathbf{0} & & & \lambda^{-2} & \\
& & & & \lambda^{-2}
\end{array}\right)
$$

Further note that a choice of eigenspaces $E_{A}(i), E_{A}(-i), E_{B}(-1), E_{B}\left(\lambda^{2}\right)$, $E_{B}\left(\lambda^{-2}\right)$ such that $E_{A}(i) \oplus E_{A}(-i) \cong \mathbf{C}^{6}$ and $E_{B}(-1) \oplus E_{B}\left(\lambda^{2}\right) \oplus E_{B}\left(\lambda^{-2}\right) \cong \mathbf{C}^{6}$ determines a representation $\rho: \Gamma_{3_{1}} \rightarrow \mathrm{SL}(6)$ completely.

Let $\operatorname{Gr}(p, n)$ denote the Grassmannian which parametrizes all $p$-dimensional subspaces of $\mathbf{C}^{n}$. Hence the choice of two elements in $\operatorname{Gr}(3,6)$ in generic position determines $A$ and the choice of three elements in $\operatorname{Gr}(2,6)$ in generic position determines $B$. The representation will be irreducible if the eigenspaces of $A$ and $B$ are mutual in general position and reducible if not.

It is well known that $\operatorname{dim} \operatorname{Gr}(p, n)=p(n-p)$ and hence
$\operatorname{dim}(\operatorname{Gr}(3,6) \times \operatorname{Gr}(3,6))=18 \quad$ and $\quad \operatorname{dim}(\operatorname{Gr}(2,6) \times \operatorname{Gr}(2,6) \times \operatorname{Gr}(2,6))=24$.
Therefore, we constructed a 42-dimensional component of representations $C \subset$ $R_{6}\left(\Gamma_{3_{1}}\right)$ which contains $\rho_{\lambda, 6}^{z}=r_{6} \circ \rho_{\lambda}^{z}$ and which contains irreducible representations. Note that $6^{+} 6-2=40<42$. In conclusion we have:

Corollary 5.2. The representation variety $R_{6}\left(\Gamma_{3_{1}}\right)$ contains a 42-dimensional component $C$. The generic representation of $C$ irreducible and $\rho_{\lambda, 6}^{z} \in C \subset$ $R_{6}\left(\Gamma_{3_{1}}\right)$ is a smooth point.

Proof. Computer supported calculations give that $\operatorname{dim} Z^{1}\left(\Gamma_{K}, \mathfrak{s l}(6)\right)=42$. On the other hand, we constructed a 42 -dimensional component $C$ containing $\rho_{\lambda, 6}^{z}$. Now, the assertion follows from Lemma 2.2 ,
