# CONCRETE EXAMPLES OF $\mathscr{H}(b)$ SPACES

#### Abstract

In this paper we give an explicit description of de Branges-Rovnyak spaces $\mathscr{H}(b)$ when $b$ is of the form $q^{r}$, where $q$ is a rational outer function in the closed unit ball of $H^{\infty}$ and $r$ is a positive number.


## 1. Introduction

The purpose of this paper is to explicitly describe the elements of the de Branges-Rovnyak space $\mathscr{H}(b)$ for certain $b \in \mathbf{b}\left(H^{\infty}\right)$. Here $H^{\infty}$ denotes the space of bounded analytic functions on the open unit disk $\mathbb{D}$ normed by $\|f\|_{\infty}:=\sup _{z \in \mathbb{D}}|f(z)|$, and $\mathbf{b}\left(H^{\infty}\right):=\left\{g \in H^{\infty}:\|g\|_{\infty} \leqslant 1\right\}$ is the closed unit ball in $H^{\infty}$ and, for $b \in \mathbf{b}\left(H^{\infty}\right)$, the de Branges-Rovnyak space $\mathscr{H}(b)$ is the reproducing kernel Hilbert space of analytic functions on $\mathbb{D}$ whose kernel is

$$
k_{\lambda}^{b}(z):=\frac{1-\overline{b(\lambda)} b(z)}{1-\bar{\lambda} z}, \quad \lambda, z \in \mathbb{D}
$$

Besides possessing a fascinating internal structure [9], $\mathscr{H}(b)$ spaces play an important role in several aspects of function theory and operator theory, most importantly, in the model theory for many types of contraction operators [3, 4].
Despite the important role $\mathscr{H}(b)$ spaces play in operator theory, the exact contents of $\mathscr{H}(b)$ often remain mysterious. What functions belong to $\mathscr{H}(b)$ ? Certainly the kernel functions $k_{\lambda}^{b}, \lambda \in \mathbb{D}$, do (and have dense linear span). What else?

[^0]In this paper, we give a precise description of the elements of $\mathscr{H}(b)$ for certain relatively simple $b$, namely positive powers of rational outer functions. Our description needs the following set up. If $b \in \mathbf{b}\left(H^{\infty}\right)$ is a non-extreme point of $\mathbf{b}\left(H^{\infty}\right)$, equivalently, $\log (1-|b|) \in L^{1}(\mathbb{T}, m)$ (where $\mathbb{T}:=\{\zeta \in \mathbb{C}:|\zeta|=1\}$ and $m$ Lebesgue measure on $\mathbb{T}$ normalized so that $m(\mathbb{T})=1$ ), then there exists a unique outer function $a \in \mathbf{b}\left(H^{\infty}\right)$, called the Pythagorean mate for $b$, such that $a(0)>0$ and $|a|^{2}+|b|^{2}=1$ almost everywhere on $\mathbb{T}$. The pair $(a, b)$ is said to be a Pythagorean pair.

Our first observation says that in certain situations $\mathscr{H}\left(b^{r}\right)$ does not depend on $r>0$.

## Theorem 1.1.

(1) Suppose $b \in \mathbf{b}\left(H^{\infty}\right)$ is outer. The following are equivalent:
(a) For any $r>0$ we have $\mathscr{H}\left(b^{r}\right)=\mathscr{H}(b)$ as sets.
(b) $\mathscr{H}\left(b^{2}\right)=\mathscr{H}(b)$ as sets.
(c) $b \mathscr{H}(b) \subset \mathscr{H}((b)$.
(2) If $b$ is non-extreme, i.e., $\log (1-|b|) \in L^{1}(\mathbb{T})$, with Pythagorean mate $a$, then conditions (a), (b), and (c) are equivalent to the condition

$$
\begin{equation*}
\inf \{|a(z)|+|b(z)|: z \in \mathbb{D}\}>0 \tag{1.2}
\end{equation*}
$$

(3) If $b$ extreme, i.e., $\log (1-|b|) \notin L^{1}(\mathbb{T})$, then conditions (a), (b), and (c) are equivalent to the condition

$$
\begin{equation*}
b \text { is invertible in } H^{\infty} \text {. } \tag{1.3}
\end{equation*}
$$

Remark 1.4. (1) Since $b$ is outer, it has no zeros on $\mathbb{D}$ and so we can define $b^{r}$ by taking any logarithm of $b$. Note that $b^{r} \in$ $\mathbf{b}\left(H^{\infty}\right)$.
(2) Statement (a) of Theorem 1.1 says that $\mathscr{H}\left(b^{r}\right)=\mathscr{H}(b)$ as sets. Though the norms on $\mathscr{H}\left(b^{r}\right)$ and $\mathscr{H}(b)$ are different, one sees from the closed graph theorem that they are equivalent.
(3) Statement (c) of the theorem says that $b$ is a multiplier of $\mathscr{H}(b)$. We refer the reader to Sarason's book [9] for further information and references about multipliers of $\mathscr{H}(b)$.
(4) By Carleson's corona theorem [6], the condition (1.2) is equivalent to existence of $\phi, \psi \in H^{\infty}$ so that $a \phi+b \psi=1$ on $\mathbb{D}$. Such a pair $(a, b)$ satisfying this condition is called a corona pair.

When $b$ is a rational outer function, or any positive power of a rational function (which is necessarily non-extreme (see Lemma 3.1)), we obtain the following complete description of $\mathscr{H}(b)$ involving the derivatives of the reproducing kernels. Indeed, when $b=q^{r}$, where $q$ is outer and rational and $r>0$, we set

$$
v_{r, \lambda}^{\ell}(z):=\frac{d^{\ell}}{d \bar{\lambda}^{\ell}} k_{\lambda}^{q^{r}}(z)=\frac{d^{\ell}}{d \bar{\lambda}^{\ell}}\left(\frac{1-\overline{q^{r}(\lambda)} q^{r}(z)}{1-\bar{\lambda} z}\right),
$$

for any $z \in \mathbb{D}, \lambda \in \mathbb{D}^{-}$, and $\ell \geqslant 0$. We let $H^{2}$ denote the classical Hardy space [6]. By means of the Féjer-Riesz theorem (see Section 6), one can prove that if $q$ is a rational function then so is its Pythagorean mate $a$. In this case, also notice that for $\zeta \in \mathbb{T}$ we have $|q(\zeta)|=1$ if and only if $a(\zeta)=0$.

Theorem 1.5. Suppose $q \in \mathbf{b}\left(H^{\infty}\right)$ is a rational outer function and $r$ is a positive real number. Then
(1) $\mathscr{H}\left(q^{r}\right)=\mathscr{H}(q)$ as sets.
(2) If $a$ is the Pythagorean mate for $q$ and $a$ has distinct zeros $\zeta_{1}, \ldots, \zeta_{n}$ on $\mathbb{T}$ with corresponding multiplicities $m_{1}, \ldots, m_{n}$, then
(a) the functions $v_{r, j}^{\ell}:=v_{r, \zeta_{j}}^{\ell}$ are well-defined and belong to $\mathscr{H}\left(q^{r}\right)$ for $1 \leqslant j \leqslant n$ and $0 \leqslant \ell \leqslant m_{j}-1$. Moreover, they are orthogonal to

$$
a H^{2}=\left(\prod_{j=1}^{n}\left(z-\zeta_{j}\right)^{m_{j}}\right) H^{2} .
$$

(b) $\mathscr{H}\left(q^{r}\right)$ is equal to

$$
\left(\prod_{j=1}^{n}\left(z-\zeta_{j}\right)^{m_{j}}\right) H^{2} \oplus \bigvee\left\{v_{r, j}^{\ell}: 0 \leqslant \ell \leqslant m_{j}-1,1 \leqslant j \leqslant n\right\},
$$

where the orthogonal decomposition is in terms of the inner product in $\mathscr{H}\left(q^{r}\right)$.

Writing $v_{j}^{\ell}=v_{1, j}^{\ell}$, the theorem above implies that $\mathscr{H}\left(q^{r}\right)$ is equal to

$$
\left(\prod_{j=1}^{n}\left(z-\zeta_{j}\right)^{m_{j}}\right) H^{2}+\bigvee\left\{v_{j}^{\ell}(z): 0 \leqslant \ell \leqslant m_{j}-1,1 \leqslant j \leqslant n\right\},
$$

where the sum is no longer necessarily orthogonal.

It was shown in [2], and rediscovered in [1], that

$$
\begin{equation*}
\mathscr{H}(q)=\left(\prod_{j=1}^{n}\left(z-\zeta_{j}\right)^{m_{j}}\right) H^{2}+\mathscr{P}_{N-1}, \tag{1.6}
\end{equation*}
$$

where $N=\sum_{j=1}^{n} m_{j}, \mathscr{P}_{N-1}$ is the $N$-dimensional vector space of polynomials of degree at most $N-1$, and the sum is an algebraic direct sum (not necessarily an orthogonal one). The novelty of our result is that we can precisely identify the orthogonal complement of $a H^{2}=\left(\prod_{j=1}^{n}\left(z-\zeta_{j}\right)^{m_{j}}\right) H^{2}$ in $\mathscr{H}(q)$ without using (1.6).
In a recent preprint, Lanucha and Nowak [7] examined when an $\mathscr{H}(b)$ space is isomorphic to a Dirichlet type space. Their discussion naturally leads to the situation when $a$ is a polynomial with simple zeros on $\mathbb{T}$ and a similar description of $\mathscr{H}(b)$ for such $a$.

A key ingredient used to show statement (1) of Theorem 1.5, and an added bonus to our result, is that if $a_{r}$ is the Pythagorean mate for $q^{r}$ then the co-analytic Toeplitz operators $T_{\bar{a}}$ and $T_{\overline{a_{r}}}$ on $H^{2}$ have the same range, namely $\mathscr{H}(q)$.

## 2. Preliminaries

There are several equivalent definitions of the de Branges-Rovnyak space $\mathscr{H}(b)$. We can, for instance, define it in the standard way [8] as the reproducing kernel Hilbert space associated with the (positive definite) reproducing kernel

$$
k_{\lambda}^{b}(z):=\frac{1-\overline{b(\lambda)} b(z)}{1-\bar{\lambda} z}, \quad \lambda, z \in \mathbb{D} .
$$

By definition, $f(\lambda)=\left\langle f, k_{\lambda}^{b}\right\rangle_{b}$ for all $f \in \mathscr{H}(b)$ and $\lambda \in \mathbb{D}$, where $\langle\cdot, \cdot\rangle_{b}$ represents the scalar product in $\mathscr{H}(b)$.
The space $\mathscr{H}(b)$ can also be defined as the range space $\left(I-T_{b} T_{\bar{b}}\right)^{1 / 2} H^{2}$ equipped with the norm which makes $\left(I-T_{b} T_{\bar{b}}\right)^{1 / 2}$ a partial isometry. Here $T_{\varphi}$ is the Toeplitz operator on $H^{2}$ with symbol $\varphi \in L^{\infty}(\mathbb{T})$ defined by

$$
T_{\varphi} f=P_{+}(\varphi f), \quad f \in H^{2}
$$

where $P_{+}$is the orthogonal projection of $L^{2}(\mathbb{T})$ onto $H^{2}$. The book [9] is the classic reference for $\mathscr{H}(b)$ spaces.

When $\|b\|_{\infty}<1, \mathscr{H}(b)$ turns out to be a renormed version of $H^{2}$ while if $b$ is an inner function, then $\mathscr{H}(b)$ turns out to be one of the classical and well-studied model spaces $H^{2} \ominus b H^{2}$.

When $b$ is non-extreme and $a$ is its Pythagorean mate, two important (not necessarily closed) vector spaces of functions in $\mathscr{H}(b)$ are

$$
\mathscr{M}(a):=T_{a} H^{2} \quad \text { and } \quad \mathscr{M}(\bar{a}):=T_{\bar{a}} H^{2} .
$$

It follows from the Douglas factorization theorem and the operator inequalities

$$
\begin{equation*}
T_{a} T_{\bar{a}} \leqslant T_{\bar{a}} T_{a} \quad \text { and } \quad T_{\bar{a}} T_{a}=I-T_{\bar{b}} T_{b} \leqslant I-T_{b} T_{\bar{b}} \tag{2.1}
\end{equation*}
$$

that $\mathscr{M}(a) \subset \mathscr{M}(\bar{a}) \subset \mathscr{H}(b)($ see $[9, ~ p .24])$.
For technical reasons, we will make use of the space $\mathscr{H}(\bar{b})$ which, for any $b \in \mathbf{b}\left(H^{\infty}\right)$, is defined similarly as with $\mathscr{H}(b)$ but as the range space $\left(I-T_{\bar{b}} T_{b}\right)^{1 / 2} H^{2}$. The operator inequalities from (2.1) show that $\mathscr{H}(\bar{b})$ is contractively contained in $\mathscr{H}(b)$.

## 3. Corona pairs

This following lemma is well-known but we record it here along with a proof for the sake of completeness and for the discussion of the examples in Section 6.

Lemma 3.1. Suppose $q \in \mathbf{b}\left(H^{\infty}\right)$ is rational and not inner. Then $q$ is non-extreme and, if $a$ is the Pythagorean mate for $q$, then $a$ is also rational.

Proof. Since $q$ is rational then $q=p_{1} / p_{2}$ where $p_{1}$ and $p_{2}$ are analytic polynomials and $p_{2}$ has no zeros on $\mathbb{D}^{-}$. We can, of course, choose $p_{2}$ such that $p_{2}(0)>0$. Since $q \in \mathbf{b}\left(H^{\infty}\right)$, we see that $1-\left|q\left(e^{i \theta}\right)\right|^{2} \geqslant 0$ for all $\theta$ and so $\left|p_{2}\left(e^{i \theta}\right)\right|^{2}-\left|p_{1}\left(e^{i \theta}\right)\right|^{2}$ is a non-negative trigonometric polynomial. Furthermore, $\left|p_{2}\left(e^{i \theta}\right)\right|^{2}-\left|p_{1}\left(e^{i \theta}\right)\right|^{2}$ is not the zero function since we are assuming that $q$ is not an inner function. By the FéjerRiesz theorem, $\left|p_{2}\left(e^{i \theta}\right)\right|^{2}-\left|p_{1}\left(e^{i \theta}\right)\right|^{2}=\left|p\left(e^{i \theta}\right)\right|^{2}$, where $p$ is an analytic polynomial which is zero free in $\mathbb{D}$ and $p(0)>0$.
Let $a=p / p_{2}$. Note that $a$ is rational and zero free in $\mathbb{D}$, hence outer. Moreover, $a(0)>0$.

Furthermore, on $\mathbb{T}$ we have

$$
|a|^{2}=\left|\frac{p}{p_{2}}\right|^{2}=\frac{\left|p_{2}\right|^{2}-\left|p_{1}\right|^{2}}{\left|p_{2}\right|^{2}}=1-\left|\frac{p_{1}}{p_{2}}\right|^{2}=1-|q|^{2}
$$

This means that $(a, q)$ is a Pythagorean pair which, in particular, implies that $q$ is non-extreme.

Lemma 3.2. Suppose $b \in \mathbf{b}\left(H^{\infty}\right)$ is outer and $r$ is a positive real number. Then $b$ and $b^{r}$ are simultaneously non-extreme. Moreover, if $a_{r}$ is the Pythagorean mate for $b^{r}$, the pairs $(a, b)$ and $\left(a_{r}, b^{r}\right)$ are simultaneously corona.

Proof. Since

$$
\begin{equation*}
\frac{1-x^{r}}{1-x} \asymp 1, \quad x \in[0,1) \tag{3.3}
\end{equation*}
$$

we see that $1-|b|^{r} \asymp 1-|b|$ when $b \in \mathbf{b}\left(H^{\infty}\right)$, from which we deduce the first part of the Lemma.

Now observe that

$$
\frac{|a|^{2}}{\left|a_{r}\right|^{2}}=\frac{1-|b|^{2}}{1-\left|b^{2}\right|^{r}} \asymp 1,
$$

and since $a$ and $a_{r}$ are outer, Smirnov's theorem (which says that if the boundary function for the quotient of two outer functions is bounded on $\mathbb{T}$, then $f \in H^{\infty}$ ), shows that $a / a_{r}$ is invertible in $H^{\infty}$. Thus both expressions

$$
\inf _{z \in \mathbb{D}}(|a(z)|+|b(z)|) \quad \text { and } \quad \inf _{z \in \mathbb{D}}\left(\left|a_{r}(z)\right|+\left|b^{r}(z)\right|\right)
$$

are strictly positive (or not) simultaneously. Indeed, if there is a sequence $\left\{z_{n}\right\}_{n \geqslant 1}$ in $\mathbb{D}$ such that one expression goes to 0 then, since both $a\left(z_{n}\right)$ and $b\left(z_{n}\right)$ go to zero, the other expression will go to zero as well.

A special situation where $b$ forms a corona pair with its Pythagorean mate is when $b$ is rational.

Lemma 3.4. Suppose $q \in \mathbf{b}\left(H^{\infty}\right)$ is rational and not inner. If $a$ is the Pythagorean mate for $q$, then $(a, q)$ is a corona pair.

Proof. According to the proof of Lemma 3.1, we know that $a$ is rational, $a=p / p_{2}$, where $p$ and $p_{2}$ are polynomials, $p_{2}$ has no zeros in $\mathbb{D}^{-}$and $p$ is zero free in $\mathbb{D}$. In particular, $a$ is analytic in an open neighborhood of $\mathbb{D}^{-}$and thus has a finite number of zeros on $\mathbb{T}$, say $\left\{\zeta_{1}, \ldots, \zeta_{n}\right\}$. Note that, due to the identity $|a|^{2}+|q|^{2}=1$ on $\mathbb{T}$, the zeros of $a$ (on $\mathbb{T}$ ) must lie where $q$ is unimodular on $\mathbb{T}$.

Let $D_{j}$ be disjoint open disks with center at the zeros $\zeta_{j}$ of $a$ and let

$$
F=\mathbb{D}^{-} \backslash \bigcup_{j=1}^{n} D_{j} .
$$

By making the disks smaller, one can, by using the continuity of $|q|$ on $\mathbb{D}^{-}$, arrange things so that $|q| \geqslant \frac{1}{2}$ on each $D_{j} \cap \mathbb{D}^{-}$.
Notice that $F$ is closed and omits all of the zeros of $a$ in $\mathbb{D}^{-}$and so

$$
\inf _{z \in F}|a(z)|=\delta>0
$$

Thus

$$
\inf _{z \in \mathbb{D}}(|a(z)|+|q(z)|) \geqslant \min \left(\frac{1}{2}, \delta\right)>0
$$

concluding the proof.
The first statement of Theorem 1.1 depends on the following two results. The first is from Sarason's book [9, p. 62].

Proposition 3.5. For $b \in \mathbf{b}\left(H^{\infty}\right)$ and non-extreme, the following are equivalent:
(1) $(a, b)$ is a corona pair;
(2) $\mathscr{H}(b)=\mathscr{M}(\bar{a})$.

The second is the following.
Proposition 3.6. If $a, a_{1} \in H^{\infty}$ are two outer functions such that a/ $a_{1}$ and $a_{1} / a$ belong to $L^{\infty}$, then $\mathscr{M}(\bar{a})=\mathscr{M}\left(\overline{a_{1}}\right)$.

Proof. Again, by Smirnov's theorem, we know that $a / a_{1}$ and $a_{1} / a$ belong to $H^{\infty}$. Thus $T_{a / a_{1}}$, and hence $T_{\overline{a / a_{1}}}$, are invertible operators on $H^{2}$. From here we get

$$
\begin{gathered}
\mathscr{M}(\bar{a})=T_{\bar{a}} H^{2}=T_{\overline{a_{1}}} T_{\overline{a / a_{1}}} H^{2}=T_{\overline{a_{1}}} H^{2}=\mathscr{M}\left(\overline{a_{1}}\right) . \\
\text { 4. } \mathscr{H}\left(b^{r}\right)=\mathscr{H}(b) \mathrm{AS} \mathrm{SETS}
\end{gathered}
$$

We are now ready to prove Theorem 1.1.
Proof of Theorem 1.1. The implication $(a) \Longrightarrow(b)$ is trivial.
To show $(b) \Longrightarrow(c)$ note from $[9, \mathrm{I}-10]$ we have

$$
\mathscr{H}\left(b^{2}\right)=\mathscr{H}(b)+b \mathscr{H}(b) .
$$

But since we are assuming that $\mathscr{H}\left(b^{2}\right)=\mathscr{H}(b)$ is follows that $b \mathscr{H}(b) \subset$ $\mathscr{H}(b)$.

For the implication $(c) \Longrightarrow(1.2)$, we use the fact that $b$ is nonextreme and [9, VIII-1, VIII-7] to see that $b$ being a multiplier of $\mathscr{H}(b)$ is equivalent to $(a, b)$ being a corona pair.

To show that $(1.2) \Longrightarrow(a)$, we proceed as follows. By Lemma 3.2 we know that since $(a, b)$ is a corona pair, then so is $\left(a_{r}, b^{r}\right)$. Thus from Proposition 3.5 we see that $\mathscr{H}(b)=\mathscr{M}(\bar{a})$ and $\mathscr{H}\left(b^{r}\right)=\mathscr{M}\left(\overline{a_{r}}\right)$. As in the proof of Lemma $3.2 a / a_{r}$ and $a_{r} / a$ belong to $H^{\infty}$ so, by Proposition 3.6, we get $\mathscr{M}(\bar{a})=\mathscr{M}\left(\overline{a_{r}}\right)$. Putting this all together we get the desired set equality $\mathscr{H}\left(b^{r}\right)=\mathscr{H}(b)$.
For the implication $(c) \Longrightarrow$ (1.3), we use the fact that $b$ is extreme and [9, VIII-1, VIII-5] to see that $b$ being a multiplier of $\mathscr{H}(b)$ is equivalent to $b$ being an invertible element of $H^{\infty}$.

It remains to show $(1.3) \Longrightarrow(a)$. Assuming that $b$ is invertible in $H^{\infty}$, we use, once again, $[9$, VIII-1] to see that $\mathscr{H}(b)=\mathscr{H}(\bar{b})$. But, since $b$ is invertible in $H^{\infty}$, then so is $b^{r}$ and we thus also have $\mathscr{H}\left(b^{r}\right)=\mathscr{H}\left(\overline{b^{r}}\right)$. Remember that

$$
\frac{1-|b|^{2}}{1-\left|b^{r}\right|^{2}} \asymp 1
$$

and thus there are two constants $c_{1}, c_{2}>0$ such that

$$
c_{1}\left(I-T_{\bar{b}} T_{b}\right) \leqslant I-T_{\overline{b^{r}}} T_{b^{r}} \leqslant c_{2}\left(I-T_{\bar{b}} T_{b}\right) .
$$

The Douglas factorization theorem implies that $\mathscr{H}(\bar{b})=\mathscr{H}\left(\overline{b^{r}}\right)$ which concludes the proof.

Remark 4.1. In Theorem 1.1 we see from the above proofs that one can add the condition $\mathscr{H}(b)=\mathscr{H}(\bar{b})$ to the list of equivalent conditions.

## 5. The contents of $\mathscr{H}(b)$

We now can give the proof of Theorem 1.5. Indeed, statement (1) of the theorem follows from Lemma 3.4 and Theorem 1.1. Let us consider statement (2).
In [5] it was shown, for an outer function $b$, that if $\zeta \in \mathbb{T}$ and

$$
\begin{equation*}
\int_{\mathbb{T}} \frac{|\log | b(w)| |}{|w-\zeta|^{2 n+2}} d m(w)<\infty \tag{5.1}
\end{equation*}
$$

then every function in $\mathscr{H}(b)$, as well as its derivatives up to order $n$, has a finite non-tangential limit at $\zeta$.
Recalling the notation $v_{r, \lambda}^{\ell}$ for the $\ell$-th derivative in the variable $\bar{\lambda}$ of the reproducing kernel in $\mathscr{H}\left(q^{r}\right)$, the results of [5] also show that $v_{r, \zeta}^{\ell} \in \mathscr{H}\left(q^{r}\right), 0 \leqslant \ell \leqslant n$, and

$$
f^{(\ell)}(\zeta)=\left\langle f, v_{r, \zeta}^{\ell}\right\rangle_{q^{r}}, \quad f \in \mathscr{H}\left(q^{r}\right), 0 \leqslant \ell \leqslant n .
$$

Let us check condition (5.1) for our situation. Since $q$ is rational its Pythagorean mate $a$ is also rational and can be written as

$$
\begin{equation*}
a(z)=s(z) \prod_{j=1}^{n}\left(z-\zeta_{j}\right)^{m_{j}} \tag{5.2}
\end{equation*}
$$

where $s$ is a rational function whose poles and zeros lie on the complement of $\mathbb{D}^{-}$. Pick $w=e^{i t}$ near one of the zeros $\zeta_{j}=e^{i \theta_{j}}$ of $a$. Then

$$
\begin{aligned}
|\log | q^{r}\left(e^{i t}\right)| | & \left.\asymp|\log | q\left(e^{i t}\right)\right|^{2}\left|=\left|\log \left(1-\left|a\left(e^{i t}\right)\right|^{2}\right)\right|\right. \\
& \asymp\left|a\left(e^{i t}\right)\right|^{2} \asymp\left|e^{i t}-e^{i \theta_{j}}\right|^{2 m_{j}}
\end{aligned}
$$

This means that for $t$ near $\theta_{j}$ we have

$$
\frac{|\log | q^{r}\left(e^{i t}\right)| |}{\left|e^{i t}-e^{i \theta_{j}}\right|^{2\left(m_{j}-1\right)+2}} \asymp 1
$$

and so, by (5.1), every function in $\mathscr{H}(b)$ as well as its derivatives up the order $m_{j}-1$ admits non-tangential limits at $\zeta_{j}$, and $v_{r, \zeta_{j}}^{\ell} \in \mathscr{H}\left(q^{r}\right)$ for all $0 \leqslant \ell \leqslant m_{j}-1$.

The following interesting observation will be very useful in the proof of our main theorem.

Lemma 5.3. Suppose $a(z)=\prod_{j=1}^{n}\left(z-\zeta_{j}\right)^{m_{j}}$, where $\zeta_{j} \in \mathbb{T}$ and $m_{j}$ is the corresponding multiplicity. If the non-tangential limits if an $f=$ $T_{\bar{a}} g \in \mathscr{M}(\bar{a})$, along with the non-tangential limits of its derivatives up to order $m_{j}-1$, vanish at every point $\zeta_{j}, j=1, \ldots, n$, then

$$
\begin{equation*}
\widehat{g}(0)=\widehat{g}(1)=\cdots=\widehat{g}(N-1)=0 \tag{5.4}
\end{equation*}
$$

where $N=\sum_{j=1}^{n} m_{j}$.
Proof of Lemma. We prove (5.4) as follows. Consider the kernels

$$
k_{\lambda, \ell}(z)=c_{\ell} \frac{z^{\ell}}{(1-\bar{\lambda} z)^{\ell+1}},
$$

where $c_{\ell}$ is adjusted so that these are the reproducing kernels for $\ell$-th derivatives at point $\lambda \in \mathbb{D}$ in the Hardy space $H^{2}$, that is to say,

$$
f^{(\ell)}(\lambda)=\left\langle f, k_{\lambda, \ell}\right\rangle_{H^{2}}=\int_{\mathbb{T}} f(\zeta) \overline{k_{\lambda, \ell}(\zeta)} d m(\zeta), \quad f \in H^{2}
$$

Observe, for $1 \leqslant j \leqslant n$ and $0 \leqslant \ell \leqslant m_{j}-1$, that

$$
\begin{aligned}
a(z) k_{t \zeta_{j}, \ell}(z) & =c_{\ell} \frac{z^{\ell}\left(z-\zeta_{j}\right)^{m_{j}}}{\left(1-t \overline{\zeta_{j}} z\right)^{\ell+1}} \prod_{k \neq j}\left(z-\zeta_{k}\right)^{m_{k}} \\
& =c_{\ell} z^{\ell}\left(z-\zeta_{j}\right)^{m_{j}-(\ell+1)}\left(\frac{z-\zeta_{j}}{1-t \overline{\zeta_{j}} z}\right)^{\ell+1} \prod_{k \neq j}\left(z-\zeta_{k}\right)^{m_{k}}
\end{aligned}
$$

Writing

$$
\frac{z-\zeta_{j}}{1-t \overline{\zeta_{j}} z}=-\zeta_{j}\left(1-\overline{\zeta_{j}} z \frac{1-t}{1-t \overline{\zeta_{i}} z}\right)
$$

we see that $a(z) k_{t \zeta_{j}, \ell}(z)$ is uniformly bounded in $z \in \mathbb{D}$ and $t \in[0,1)$, and moreover

$$
\frac{z-\zeta_{j}}{1-t \overline{\zeta_{j}} z} \rightarrow-\overline{\zeta_{j}}, \quad t \rightarrow 1
$$

for every $z$. Thus, by the dominated convergence theorem,

$$
a k_{t, \ell} \rightarrow c z^{\ell}\left(z-\zeta_{j}\right)^{m_{j}-(\ell+1)} \prod_{k \neq j}\left(z-\zeta_{k}\right)^{m_{k}}
$$

in the norm of $H^{2}$, where $c$ is some non zero constant depending on $\ell$ and $j$.
Choose any function $f=T_{\bar{a}} g \in \mathscr{M}(\bar{a})$ with $\left(T_{\bar{a}} g\right)^{(\ell)}\left(\zeta_{j}\right)=0$ for all $1 \leqslant j \leqslant n, 0 \leqslant \ell \leqslant m_{j}-1$. Recall that $\mathscr{M}(\bar{a}) \subset \mathscr{H}(b)$ and so $f$, as well as all its derivatives up to order $m_{j}-1$, admits non-tangential limits at $\zeta_{j}$ for all $1 \leqslant j \leqslant n$. Then

$$
\begin{aligned}
0 & =\left(T_{\bar{a}} g\right)^{(\ell)}\left(\zeta_{j}\right)=\lim _{t \rightarrow 1^{-}}\left(T_{\bar{a}} g\right)^{(\ell)}\left(t \zeta_{j}\right)=\lim _{t \rightarrow 1^{-}}\left\langle T_{\bar{a}} g, k_{t \zeta_{j}, \ell}\right\rangle_{H^{2}} \\
& =\lim _{t \rightarrow 1^{-}}\left\langle g, a k_{t \zeta_{j}, \ell}\right\rangle_{H^{2}} \\
& =\bar{c}\left\langle g, c z^{\ell}\left(z-\zeta_{j}\right)^{m_{j}-(\ell+1)} \prod_{k \neq j}\left(z-\zeta_{k}\right)^{m_{k}}\right\rangle_{H^{2}} .
\end{aligned}
$$

In order to prove the lemma, it suffices to show that the set

$$
\left\{\varphi_{j, \ell}(z):=z^{\ell}\left(z-\zeta_{j}\right)^{m_{j}-(\ell+1)} \prod_{k \neq j}\left(z-\zeta_{k}\right)^{m_{k}}\right\}
$$

where $j=1, \ldots, n$ and $\ell=0, \ldots, m_{j}-1$, is a basis for the space of polynomials of degree at most $N-1$. Clearly each $\varphi_{j, \ell}$ is a polynomial
of degree $N-1$ and there are $N-1$ functions $\varphi_{j, \ell}$. It remains to show that the elements of this family are linearly independent. Obviously, for fixed $1 \leqslant r \leqslant n$ and $0 \leqslant k \leqslant m_{r}-1$, we have

$$
\varphi_{j, \ell}^{(k)}\left(\zeta_{r}\right)=0, \quad j \neq r, \quad 0 \leqslant k \leqslant m_{r}-1
$$

and

$$
\begin{equation*}
\varphi_{r, \ell}^{(k)}\left(\zeta_{r}\right)=0, \quad 0 \leqslant k \leqslant m_{r}-(\ell+2) \tag{5.5}
\end{equation*}
$$

In particular, if $\sum_{j, \ell} \alpha_{j, \ell} \varphi_{j, \ell}=0$, then, for fixed $r$ and $0 \leqslant k \leqslant m_{r}-1$, $\sum_{j, \ell} \alpha_{j, \ell} \varphi_{j, \ell}^{(k)}\left(\zeta_{r}\right)=0$ which reduces to $\sum_{\ell} \alpha_{r, \ell} \varphi_{r, \ell}^{(k)}\left(\zeta_{r}\right)=0$. Writing $\varphi_{j, \ell}(z)=\left(z-\zeta_{j}\right)^{m_{j}-(\ell+1)} p_{j, \ell}(z)$, where $p_{j, \ell}$ does not vanish at $\zeta_{j}$, Leibniz's formula gives

$$
\begin{aligned}
\varphi_{j, \ell}(z)^{m_{j}-(\ell+1)}(z)=\sum_{k=0}^{m_{j}-(\ell+1)}\binom{m_{j}-(\ell+1)}{k} \\
\times \frac{\left(m_{j}-(\ell+1)\right)!}{\left(m_{j}-(\ell+1)-k\right)!}\left(z-\zeta_{j}\right)^{m_{j}-(\ell+1)-k} p_{j, \ell}^{\left(m_{j}-(\ell+1)-k\right)}(z)
\end{aligned}
$$

Evaluating this expression at $\zeta_{j}$ makes all terms of the sum vanish except for $k=m_{j}-(\ell+1)$, and thus

$$
\varphi_{j, \ell}(z)^{m_{j}-(\ell+1)}\left(\zeta_{j}\right)=\left(m_{j}-(\ell+1)\right)!p_{j, \ell}\left(\zeta_{j}\right) \neq 0
$$

This together with (5.5) generates a triangular system of linear equations with non-zero diagonal entries. Thus $\alpha_{r, \ell}=0,0 \leqslant \ell \leqslant m_{r}-1$.

We are now in a position to prove Theorem 1.5.
Our arguments so far yield

$$
\begin{equation*}
\mathscr{H}\left(q^{r}\right)=\mathscr{M}\left(\overline{a_{r}}\right) \tag{5.6}
\end{equation*}
$$

and

$$
\begin{equation*}
\mathscr{M}\left(\overline{a_{r}}\right)=\mathscr{M}(\bar{a}) \supset \mathscr{M}(a)+\bigvee\left\{v_{r, \zeta_{j}}^{\ell}: 1 \leqslant j \leqslant n, 0 \leqslant \ell \leqslant m_{j}-1\right\} \tag{5.7}
\end{equation*}
$$

First we show that the sum is orthogonal in the $\mathscr{H}\left(q^{r}\right)$ inner product:

$$
v_{r, \zeta_{j}}^{\ell} \perp \mathscr{M}(a), \quad 1 \leqslant j \leqslant n, 0 \leqslant \ell \leqslant m_{j}-1
$$

Indeed, for each $f \in \mathscr{H}\left(q^{r}\right)$ the radial limits $f^{(\ell)}\left(t \zeta_{j}\right)$ exist as $t \rightarrow 1^{-}$. Since

$$
f^{(\ell)}\left(t \zeta_{j}\right)=\left\langle f, v_{r, t \zeta_{j}}^{\ell}\right\rangle_{q^{r}},
$$

we can apply the principle of uniform boundedness to see that $\left\|v_{r, t \zeta_{j}}^{\ell}\right\|_{q^{r}}$ is uniformly bounded as $t \rightarrow 1^{-}$. Since $v_{r, t \zeta_{j}}^{\ell}$ converges pointwise to $v_{r, \zeta_{j}}^{\ell}$ as $t \rightarrow 1^{-}$we see that $v_{r, t \zeta_{j}}^{\ell}$ converges weakly to $v_{r, \zeta_{j}}^{\ell}$. Thus, since $v_{r, t \zeta_{j}}^{\ell}$
reproduces the $\ell$-th derivative of $\mathscr{H}\left(q^{r}\right)$-functions at point $t \zeta_{j}$, for any $g \in H^{2}$, we have

$$
\begin{aligned}
\left\langle a g, v_{r, \zeta_{j}}^{\ell}\right\rangle_{q^{r}} & =\lim _{t \rightarrow 1^{-}}\left\langle a g, v_{r, t \zeta_{j}}^{\ell}\right\rangle_{q^{r}}=\lim _{t \rightarrow 1}(a g)^{(\ell)}\left(t \zeta_{j}\right) \\
& =\lim _{t \rightarrow 1} \sum_{p=0}^{\ell}\binom{\ell}{p} a^{(p)}\left(t \zeta_{j}\right) g^{(\ell-p)}\left(t \zeta_{j}\right)
\end{aligned}
$$

Using the estimate

$$
\left|a^{(p)}\left(t \zeta_{j}\right)\right| \lesssim(1-t)^{m_{j}-p}
$$

along with the following standard $H^{2}$ estimate on the growth of the derivative of an $H^{2}$ function

$$
\left|g^{(\ell-p)}\left(t \zeta_{j}\right)\right| \lesssim \frac{1}{(1-t)^{(\ell-p)+1 / 2}},
$$

we see that

$$
\left|a^{(p)}\left(t \zeta_{j}\right) g^{(\ell-p)}\left(t \zeta_{j}\right)\right| \lesssim(1-t)^{m_{j}-p-((\ell-p)+1 / 2)} .
$$

But since $0 \leqslant \ell \leqslant m_{j}-1$ we see that

$$
m_{j}-p-((\ell-p)+1 / 2)=m_{j}-\ell-\frac{1}{2} \geqslant \frac{1}{2}
$$

and so

$$
\lim _{t \rightarrow 1^{-}}\left|a^{(p)}\left(t \zeta_{j}\right) g^{(\ell-p)}\left(t \zeta_{j}\right)\right|=0
$$

Thus $\left\langle a g, v_{r, \zeta_{j}}^{\ell}\right\rangle_{q^{r}}=0$ and $v_{r, \zeta_{j}}^{\ell} \perp \mathscr{M}(a)$ in $\mathscr{H}\left(q^{r}\right)$, for all $0 \leqslant \ell \leqslant m_{j}-1$.
This upgrades (5.6) and (5.7) to

$$
\begin{equation*}
\mathscr{H}\left(q^{r}\right)=\mathscr{M}(\bar{a}) \supset \mathscr{M}(a) \oplus \bigvee\left\{v_{r, \zeta_{j}}^{\ell}: 1 \leqslant j \leqslant n, 0 \leqslant \ell \leqslant m_{j}-1\right\}, \tag{5.8}
\end{equation*}
$$

and orthogonality is with respect to the norm in $\mathscr{H}\left(q^{r}\right)$.
To show equality in (5.8), our second step is to show that if $f \in \mathscr{M}(\bar{a})$ and $f \perp v_{r, \zeta_{j}}^{\ell}$ for all $1 \leqslant j \leqslant n, 0 \leqslant \ell \leqslant m_{j}-1$, then $f \in \mathscr{M}(a)$. Since $\mathscr{M}(\bar{a})=T_{\bar{a}} H^{2}$ this is equivalent to prove that if $g \in H^{2}$ and

$$
0=\left(T_{\bar{a} g} g\right)^{(\ell)}\left(\zeta_{j}\right)=\lim _{t \rightarrow 1^{-}}\left(T_{\bar{a}} g\right)^{(\ell)}\left(t \zeta_{j}\right)
$$

for all $1 \leqslant j \leqslant n, 0 \leqslant \ell \leqslant m_{j}-1$ then $T_{\bar{a}} g \in \mathscr{M}(a)$. To simplify matters a bit, let us recall the formula for $a$ from (5.2). Since $s$ is a rational function with zeros and poles outside $\mathbb{D}^{-}$then certainly the Toeplitz operators $T_{1 / s}$ and $T_{\overline{1 / s}}$ are invertible, and so $\mathscr{M}(\bar{a})=\mathscr{M}(\overline{a / s})$. We can therefore make the simplifying assumption that

$$
a(z)=\prod_{j=1}^{n}\left(z-\zeta_{j}\right)^{m_{j}}
$$

We will show that

$$
\begin{equation*}
\left(T_{\bar{a}} g\right)^{(\ell)}\left(\zeta_{j}\right)=0,1 \leqslant j \leqslant n, 0 \leqslant \ell \leqslant m-1 \Longrightarrow T_{\bar{a}} g \in a H^{2} \tag{5.9}
\end{equation*}
$$

With $N=\sum_{j=1}^{n} m_{j}$, one can verify the identify

$$
\overline{a(\zeta)}=\bar{\zeta}^{N} a(\zeta) \prod_{j=1}^{n}\left(-\overline{\zeta_{j}}\right)^{m_{j}}, \quad \zeta \in \mathbb{T}
$$

Thus

$$
T_{\bar{a}} g=\prod_{j=1}^{n}\left(-\overline{\zeta_{j}}\right)^{m_{j}} P_{+}\left(a \bar{\zeta}^{N} g\right)
$$

By Lemma 5.3, we have $\widehat{g}(0)=\widehat{g}(1)=\cdots=\widehat{g}(N-1)=0$, which shows that $\bar{\zeta}^{N} g \in H^{2}$ and so

$$
T_{\bar{a}} g=\left(\prod_{j=1}^{n}\left(-\bar{\zeta}_{j}\right)^{m_{j}}\right) P_{+}\left(a \bar{\zeta}^{N} g\right) \in a H^{2}
$$

This completes the proof.

## 6. Examples

Example 6.1. Consider the function

$$
q(z)=\frac{1}{2}(1+z)
$$

and notice that $q$ is outer and $\|q\|_{\infty}=1$. One can easily guess the Pythagorean mate for $q$ to be $a(z)=\frac{1}{2}(1-z)$. The function $a(z)$ has one zero of order 1 at $z=1$ and a computation reveals that

$$
v_{1,1}^{0}(z)=\frac{1-\overline{q(1)} q(z)}{1-z}=\frac{1}{2} .
$$

In this case

$$
\mathscr{H}(q)=(z-1) H^{2} \oplus \mathbb{C} .
$$

Moreover, for any $r>0$ we get $\mathscr{H}\left(q^{r}\right)=\mathscr{H}(q)$ and

$$
\mathscr{H}\left(q^{r}\right)=(z-1) H^{2}+\mathbb{C}=(z-1) H^{2} \oplus \mathbb{C} \frac{1-\left(\frac{1+z}{2}\right)^{r}}{1-z} .
$$

For more general $q$ we need to review the proof of the Féjer-Riesz theorem which says that if

$$
w\left(e^{i \theta}\right)=\sum_{j=-n}^{n} c_{j} e^{i j \theta}
$$

is a non-zero trigonometric polynomial which assumes non-negative values for all $\theta$, then there is an analytic polynomial

$$
p(z)=\sum_{j=0}^{n} a_{j} z^{j}
$$

so that $w\left(e^{i \theta}\right)=\left|p\left(e^{i \theta}\right)\right|^{2}$. Since the proof gives us the algorithm for computing $p$, we give a quick sketch. Indeed, as a function of the complex variable $z$, we see that if

$$
w(z)=\sum_{j=-n}^{n} c_{j} z^{j}
$$

then $\overline{w(1 / \bar{z})}=w(z), z \in \mathbb{T}$. Assuming that $c_{-n} \neq 0$ we see that $s(z)=z^{n} w(z), z \in \mathbb{C}$, is a polynomial of degree $2 n$ and the roots of $s$ occur in the pairs $\alpha, 1 / \bar{\alpha}$ of equal multiplicity. It follows that

$$
w(z)=c \prod_{j=1}^{n}\left(z-\alpha_{j}\right)\left(\frac{1}{z}-\overline{\alpha_{j}}\right)
$$

for some positive constant $c$ and where $\alpha_{1}, \ldots, \alpha_{n}$ satisfy $\left|\alpha_{j}\right| \geqslant 1$ for $1 \leqslant j \leqslant n$. The desired polynomial $p$ is

$$
p(z)=\sqrt{c} \prod_{j=1}^{n}\left(z-\alpha_{j}\right)
$$

Note that $p$ is zero free in $\mathbb{D}$ and we can multiply $p$ by a unimodular constant so that $p(0)>0$.

Recall from the proof of Lemma (3.1) that if $q=p_{1} / p_{2}$ is rational then the Pythagorean mate $a$ for $q$ is given by $a=p / p_{2}$, where $p$ is the analytic polynomial (guaranteed by the Féjer-Riesz theorem) which satisfies $\left|p\left(e^{i \theta}\right)\right|^{2}=w\left(e^{i \theta}\right)=\left|p_{2}\left(e^{i \theta}\right)\right|^{2}-\left|p_{1}\left(e^{i \theta}\right)\right|^{2} \geqslant 0$, and $p$ is chosen to that $a(0)>0$.
Example 6.2. Consider the function

$$
q(z)=\frac{1}{2}(1-z)(1+z)
$$

and note that $q \in \mathbf{b}\left(H^{\infty}\right)$ and is outer. A computation shows that

$$
1-\left|q\left(e^{i t}\right)\right|^{2}=\frac{1}{4} e^{-2 i t}+\frac{1}{4} e^{2 i t}+\frac{1}{2} .
$$

Define

$$
w(z)=\frac{z^{-2}}{4}+\frac{z^{2}}{4}+\frac{1}{2}
$$

and

$$
s(z)=z^{2} w(z)=\frac{z^{4}}{4}+\frac{z^{2}}{2}+\frac{1}{4}=\frac{1}{4}(z-i)^{2}(z+i)^{2} .
$$

Notice how the zeros occur in pairs $i=1 / \bar{i}$ and $-i=1 / \overline{-i}$ as guaranteed by the above proof of the Féjer-Riesz theorem. Thus the Pythagorean mate $a$ for $q$ is of the form $a(z)=c(z-i)(z+i)$ for some $c$ adjusted so that $a(0)>0$ and $1-\left|q\left(e^{i \theta}\right)\right|^{2}=\left|a\left(e^{i \theta}\right)\right|^{2}$. One can check by direct calculation that $c=1 / 2$ works and so $a(z)=\frac{1}{2}(z-i)(z+i)$. Of course the exact value of $c$ is not important for our calculations since we only need to identify the zeros of $a$ along with their multiplicities.

The zeros of $a$ are at $z=i$ and $z=-i$ and each has order one. Thus

$$
\mathscr{H}(q)=(z-i)(z+i) H^{2} \oplus \bigvee\left\{v_{1, i}^{0}, v_{1,-i}^{0}\right\},
$$

where the kernels can be computed directly as

$$
v_{1, i}^{0}(z)=\frac{1}{2 i}(z+i), \quad v_{1,-i}^{0}(z)=\frac{1}{2 i}(z-i) .
$$

Again, as in the previous example, $\mathscr{H}\left(q^{r}\right)=\mathscr{H}(q)$ and so

$$
\mathscr{H}\left(q^{r}\right)=(z-i)(z+i) H^{2}+\bigvee\{z+i, z-i\} .
$$

Example 6.3. Consider the function

$$
q(z)=\frac{1}{4}(z+1)^{2}
$$

and note that $q$ is outer and belongs to $\mathbf{b}\left(H^{\infty}\right)$. Following our FejerRiesz computations as in the previous example, note that

$$
1-\left|q\left(e^{i t}\right)\right|^{2}=-\frac{e^{-i t}}{4}-\frac{e^{i t}}{4}-\frac{1}{16} e^{-2 i t}-\frac{1}{16} e^{2 i t}+\frac{5}{8} .
$$

Define

$$
w(z)=-\frac{z^{2}}{16}-\frac{1}{16 z^{2}}-\frac{z}{4}-\frac{1}{4 z}+\frac{5}{8}
$$

and

$$
\begin{aligned}
s(z) & =z^{2} w(z) \\
& =-\frac{z^{4}}{16}-\frac{z^{3}}{4}+\frac{5 z^{2}}{8}-\frac{z}{4}-\frac{1}{16} \\
& =-\frac{1}{16}(-1+z)^{2}\left(1+6 z+z^{2}\right) .
\end{aligned}
$$

The zeros of $s$ are at
$z=-1, z=-1, z=-3-2 \sqrt{2} \approx-5.82843, z=-3+2 \sqrt{2} \approx-0.171573$.

Notice how these roots occur in the pairs $\alpha, 1 / \bar{\alpha}$. The function $a$ is then $a(z)=c(z-1)(z+3+2 \sqrt{2})$ for some appropriate constant $c$. There is one zero of $a$ at $z=1$ with multiplicity one and so

$$
\mathscr{H}(q)=(z-1) H^{2} \oplus \mathbb{C} v_{1,1}^{0}(z)
$$

The kernel can be computed to be

$$
v_{1,1}^{0}(z)=\frac{z+3}{4}
$$

As in our previous examples, note that

$$
\mathscr{H}\left(q^{r}\right)=(z-1) H^{2}+\mathbb{C}(z+3) .
$$

Observe that the $q$ from this example is the square of the $q$ from Example 6.1 and thus the corresponding spaces should be the same. Indeed, a little algebra will show that

$$
(z-1) H^{2}+\mathbb{C}=(z-1) H^{2}+\mathbb{C}(z+3)
$$

Example 6.4. Reversing the roles of $a$ and $q$ in the preceding example:

$$
a(z)=\frac{1}{4}(z+1)^{2}, \quad q(z)=c(z-1)(z+3+2 \sqrt{2}),
$$

with suitable $c$ so that $\|q\|_{\infty}=1$ (the maximum modulus on $\mathbb{D}^{-}$being attained at -1 , one has $c=(4(1+\sqrt{2}))^{-1}$, and $q(-1)=-1$ corresponding to the normalization $q(0)>0)$, we obtain a function $a$ with double zero, and so

$$
\mathscr{H}(q)=(z+1)^{2} H^{2} \oplus \bigvee\left\{v_{1,-1}^{0}, v_{1,-1}^{1}\right\}
$$

where

$$
v_{1,-1}^{0}(z)=\frac{1-\overline{q(-1)} q(z)}{1-\overline{(-1)} z}=\frac{1+q(z)}{1+z}
$$

Using the facts that $q(-1)=-1, q^{\prime}(z)=c(2+2 \sqrt{2})$, and $q^{\prime}(-1)=$ $-1 / 2$, we obtain

$$
v_{1,-1}^{1}(z)=\frac{\frac{1}{2} q(z)(1+z)+z(1+q(z))}{(1+z)^{2}}=\frac{1}{2} \frac{q(z)(1+3 z)+2 z}{(1+z)^{2}} .
$$

Question 6.5. So far we have computed the exact contents of $\mathscr{H}(b)$ when $b$ outer, rational, and non-extreme. Can one compute the contents of $\mathscr{H}(b)$ when $b$ is outer and extreme. For example if $b$ is the outer function corresponding to the outer function which satisfies $\left|b\left(e^{i \theta}\right)\right|=1$ for $0 \leqslant \theta \leqslant \pi$ and $\left|b\left(e^{i \theta}\right)\right|=\frac{1}{2}$ for $\pi<\theta<2 \pi$, can one describe the functions in $\mathscr{H}(b)$ ?
