### Climatology of tropospheric ozone and water vapour over Chennai: a study based on MOZAIC measurements over India

**ABSTRACT:** Climatology of tropospheric ozone  $(O_3)$  and water vapour  $(H_2O)$  over a metro city of Chennai in southern India has been presented based on the Measurements of OZ one and water vapour by Airbus I n-service AirCraft (MOZAIC) data during 1996–2001. The seasonal trends in mixing ratio of O<sub>3</sub> are discussed in view of annual changes in the transport pattern, rainfall, and its relationship with ambient  $H_2O$ . The vertical distributions of both  $O_3$  and  $H_2O$  show large seasonal variations. The observed high mixing ratios of O<sub>3</sub> in winter and spring months can be attributed to long-range transport of pollutants by the northwesterly winds associated with winter monsoon circulation. The lowest mixing ratio of 15 ppbv of  $O_3$ from July to September coincides with the summer monsoon circulation over Indian subcontinent. The surface level mixing ratio of O<sub>3</sub> was observed to be below 30 ppbv throughout the year. On the other hand, monthly rainfall and vertical distributions of  $H_2O$  show just opposite seasonal variations to that of  $O_3$  mixing ratio. Chennai is a coastal city; therefore, the seasonal change in surface wind flow causes large variability in H<sub>2</sub>O concentrations of 6-30 g/kg in the lower troposphere. More or less similar annual patterns of mixing ratios of O<sub>3</sub> and H<sub>2</sub>O are repeated during different years of 1996–1998, except for some small-scale differences. High level of O<sub>3</sub> mixing ratio, particularly during the early winter months of year 1997, seems unusual as we do not see such trends for other year of measurements over Chennai. The case studies of profiles of O<sub>3</sub>, relative humidity (RH), and temperature in view of long-range transport over Chennai during the different seasons have been also discussed. Significant enhancements in tropospheric O<sub>3</sub> were observed over Chennai due to transport of air from forest fire regions of Indonesia during October 1997.

#### 1. Introduction

Tropospheric ozone (O<sub>3</sub>) plays a key role in the chemistry of the atmosphere, with effects on both the environment and Earth's climate. In the troposphere, photolysis of O<sub>3</sub> initiates the oxidation process through the formation of hydroxyl radicals (OH). Ozone, because of its strong absorption band centred at 9.6  $\mu$ m, also plays an important role in global warming, particularly in the upper troposphere (Forster and Shine, 1997; Gauss *et al.*, 2003). The photochemical reactions are dominated by the cycles of O<sub>3</sub> and water vapour (H<sub>2</sub>O) in the tropical region, which receives intense solar radiation. H<sub>2</sub>O is also a greenhouse gas (Ramanathan *et al.*, 1985; Wigley, 1987).

Tropospheric  $O_3$  levels have increased since preindustrial times (1860), particularly in the Northern Hemisphere (NH) (Oltmans *et al.*, 1998). It is estimated that  $O_3$  has contributed +0.35 W/m<sup>2</sup> to the radiative forcing since 1860, compared with +1.66 W/m<sup>2</sup> from the CO<sub>2</sub> (Forster *et al.*, 2007). Tropical region is a large contributor to the global  $O_3$  budget. Moreover, it plays a key role in controlling the chemistry and climate of the tropical troposphere. Human activities increase  $O_3$  concentration in the troposphere through emissions from fossil fuel combustion and biomass burning (Crutzen *et al.*, 1979; Logan *et al.*, 1981; Crutzen and Andreae, 1985).

The tropical continental boundary layer (CBL) is an important source region for photochemical production of O<sub>3</sub>. In tropics, biomass burning and fossil fuel combustion generate large amount of precursors such as CO, methane (CH<sub>4</sub>), and non-methane hydrocarbons (NMHCs) (Houghton *et al.*, 1996; Kirchhoff, 1996). Therefore, vertical variations of O<sub>3</sub> reflect the heterogeneity of this region, arising from O<sub>3</sub> precursor sources (biomass burning), sinks (photolysis, photochemistry),

and convective processes (Chatfield and Crutzen, 1984; Liu et al., 1987; Davies et al., 1998). Lateral transport from a source in the upper troposphere or perhaps the lower stratosphere, or O<sub>3</sub> and its precursors from a photochemically very active source region have also been observed to play important role in the distributions. An important factor in transport studies is the lifetime of  $O_3$ . Ozone is photodissociated by short-wave solar radiation (<340 nm) into electronically excited O(<sup>1</sup>D) atoms and with  $H_2O$  to form OH radicals. Thus, the lifetime of  $O_3$ is basically determined by the amount of H<sub>2</sub>O and solar radiation. The lifetime of O<sub>3</sub> increases from 2 to 5 days in the moist tropical marine boundary layer (MBL) to approximately 90 days in the free troposphere (Fishman et al., 1991). Thus, once  $O_3$  is lifted from the boundary layer it can be transported far away from its source regions.

Typical vertical distributions of  $O_3$  in the tropics exhibit a minimum at the surface, a maximum at ~6.5 km, another minimum at 11.2 km, and a subsequent increase towards the tropopause (Folkins *et al.*, 2002). The major factors that determine the vertical variation of  $O_3$  are *in situ* production/destruction, deep convective outflow, vertical advection, shallow convection, eddy exchange with the lowermost stratosphere, convective downdrafts, and vertical mixing near the tropical tropopause associated with convective overshooting (Sherwood and Dessler, 2001) and Kelvin waves (Fujiwara *et al.*, 1998).

The detailed characteristics of O<sub>3</sub> in the tropical troposphere remain unresolved because of a lack of comprehensive observations. The number of ozonesonde stations in the northern tropics is limited (Logan, 1999), although Hilo, Kuala Lumpur, Surinam, Benin (Thouret et al., 2009), and Costa Rica have all participated in SHADOZ (Thompson et al., 2003; http://croc.gsfc.nasa.gov/ shadoz). The main objective of this work is to study the tropospheric O<sub>3</sub> profile in view of annual changes in the transport pattern and also its relationship with H<sub>2</sub>O based on the Measurements of OZ one and H<sub>2</sub>O by Airbus Inservice AirCraft (MOZAIC) data over Chennai, India. We have also presented the case studies to investigate the impact of long-range transport in the vertical distributions of O<sub>3</sub> and H<sub>2</sub>O over Chennai.

# 2. Overview of MOZAIC program and measurements over India

The MOZAIC program was initiated in 1993 by European scientists, aircraft manufacturers, and airlines to collect experimental data. Ozone and  $H_2O$  sensors were installed on board five long-range commercial aircrafts (Airbus A340's) of four participating airlines. The MOZAIC project, in operation since August 1994, is a European Union (EU) supported project for the automatic measurements of  $O_3$  and water vapour on board AIRBUS A340 aircraft on scheduled flights. MOZAIC is sponsored by

major European airlines: Air France (one aircraft), Austrian Airlines (one aircraft), Lufthansa (two aircrafts), and Sabena/Air France (one aircraft).

The ozone analyser is a dual-beam ultraviolet (UV) absorption instrument (Thermo-Electron Model 49–103), which has a detection limit of 2 ppbv. Uncertainties in the measurements are estimated to be  $\pm$ (2 pbbv +2%), although actual performance is better (Thouret *et al.*, 1998a, 1998b). The response time of the instrument is 4 s, which translates into a vertical resolution of 30 m. Full details of calibration procedures and mounting in the aircraft are also given by Thouret *et al.* (1998b). Relative humidity (RH) and temperature are measured with a capacitive sensor (Humicap-H) and a platinum resistance sensor (PT100), respectively. The Humicap-capacitor together with the PT100 resistor is mounted at the top of an axis-symmetric body, which is especially designed for installation in an appropriate housing.

MOZAIC data combined with meteorological data are being used to (1) establish a quasi-global climatology of the large-scale distributions of O3 and H2O in the troposphere; (2) establish the vertical and temporal distributions of O<sub>3</sub> and H<sub>2</sub>O at various locations (airports) over the continents; (3) investigate the seasonal and geographical variations in relation to their natural and anthropogenic sources, stratosphere-troposphere exchange (STE), horizontal and vertical air circulation; and (4) to validate chemistry and transport models (Marenco et al., 1998). Measurements taken during both take off and landing of the aircraft have been used as vertical profile data over the airports. To supplement some gaps in MOZAIC database during August or July months, we have used the Indian Metrological Department (IMD) data measured at Trivandrum (as this site also represents similar climatology as over Chennai). The MOZAIC vertical profiles of O<sub>3</sub>, H<sub>2</sub>O and meteorological parameters over the Indian subcontinent consist of measurements at three airports of metropolitan cities, namely Chennai (Madras) (12.99 °N, 80.15 °E), Delhi (28.56 °N, 77.11 °E), and Mumbai (Bombay) (19.09 °N, 72.87 °E). In this study, we have discussed the distributions of O<sub>3</sub> and H<sub>2</sub>O over Chennai.

#### 3. Seasonal transport pattern over Chennai

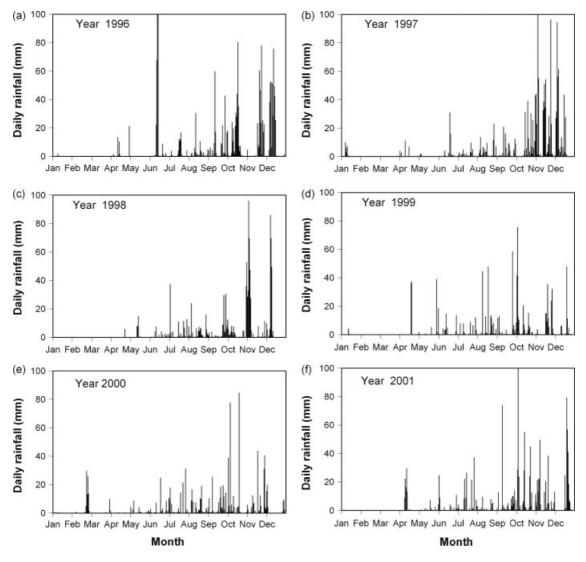


Figure 1. Daily rainfall variations measured at Chennai for different years during 1996–2001 period [data taken from Indian Meteorological Department (IMD)].

Chennai metropolitan area extends over 1180 sq km and has a population of more than 8.5 million. Rapid increase in urbanization with vehicle congestion has increased on the roads of Chennai. As a result of this, gaseous pollutants are continuously increasing in the ambient air of Chennai city (Senthilnathan, 2008). The daily rainfall data measured by the IMD for years 1996–2001 are plotted in Figure 1. Chennai is a coastal city and very often influenced by the transport of maritime air due to land see breeze circulation. The northeast (NE) monsoon period from October to December is the principal rainy season, whereas the southwest (SW) monsoon from June to September is the secondary rainy season for this place.

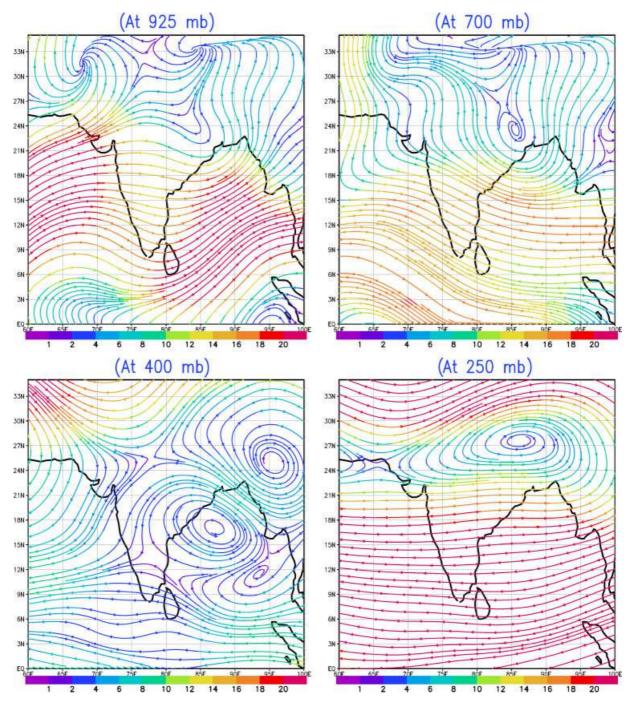


Figure 3. Mean wind fields (NCEP data) at four different pressure levels during summer (July, August, and September) of 1996–2001 period over continental and surrounding marine regions of India. This figure is available in colour online at wileyonlinelibrary.com/journal/joc

In the lower troposphere, the seasonal change in the wind flow pattern over Southeast Asia is mainly associated with the onset and withdrawal of monsoon circulations (Asnani, 1993). The summer monsoon circulation is generally visualized as large-scale convergence of mass and moisture over the Indian subcontinent in the lower levels, while a strong upper level divergence aloft. Surface heating during summer favours enhanced convection over land, which is fuelled by moist inflow at low levels. We have used the National Centre for Environmental Prediction (NCEP) data to derive the wind streamline flow over India and surrounding marine regions. Figure 2 shows the mean wind streamline plots during the winter months of January-March (JFM) at four different pressure levels of 925, 700, 400, and 250 mb during 1996–2001. In the winter season, wind flow at 700 mb is from NE, while in the upper troposphere (see plot at 250 mb) westerly wind flow prevails over Chennai. In the summer monsoon season from July to September (JAS) months, the wind streamlines at 925 mb show the SW flow, while in the upper troposphere the flow is easterly

over Chennai (Figure 3). In the middle troposphere, the wind patterns show large seasonal variations over Chennai.

## 4. Seasonal variations in O<sub>3</sub> over Chennai during 1996–1998

4.1. Monthly mean profiles of  $O_3$  and  $H_2O$  during 1996

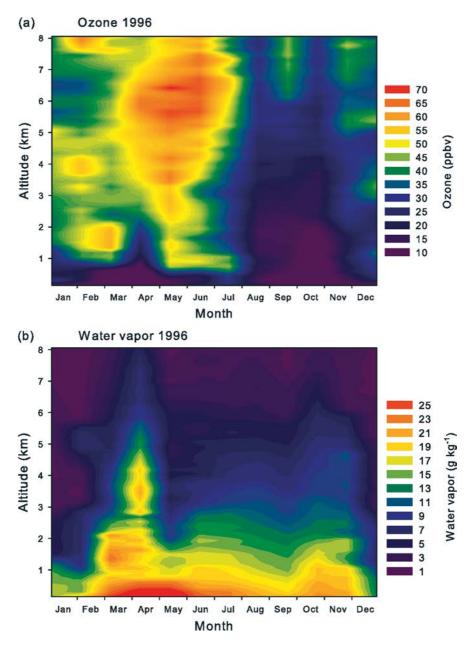


Figure 4. Monthly mean contour plots of (a) ozone and (b) water vapour representing the annual variations over Chennai during 1996. This figure is available in colour online at wileyonlinelibrary.com/journal/joc

We have calculated the monthly mean of MOZAIC profile data to study the seasonal variations of O<sub>3</sub> (ppbv) and H<sub>2</sub>O (g/kg) in the troposphere (0–8 km). Figure 4 shows the vertical distributions over Chennai for year 1996. It can be very clearly seen that profiles of both O<sub>3</sub> and H<sub>2</sub>O show large seasonal variability. The mixing ratio of O<sub>3</sub> near surface is always below 30 ppbv throughout the year. In a good agreement to this result, the mean surface O<sub>3</sub> mixing ratio of ~10–25 ppbv was observed at an urban site of Chennai during year 2006 (Pulikesi *et al.*, 2006). During the winter months, mixing

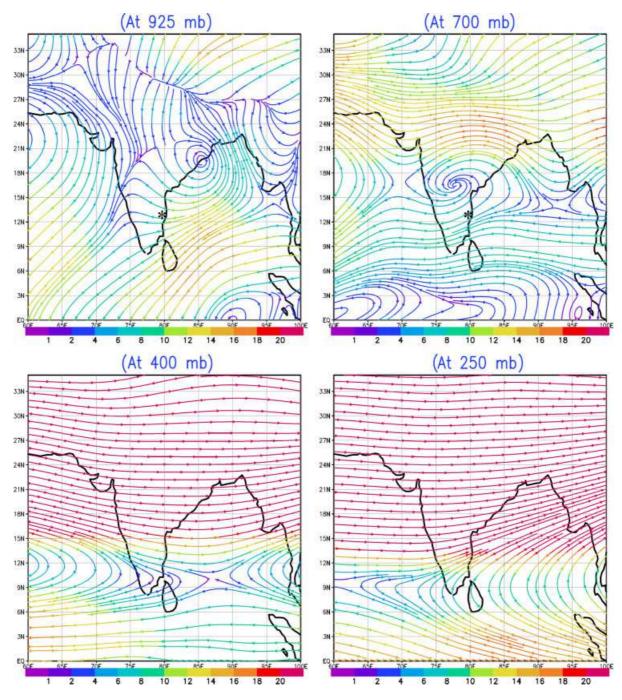


Figure 2. Mean wind fields (NCEP data) at four different pressure levels during winter (January, February, and March) of 1996–2001 period over continental and surrounding marine regions of India (\* symbol shows the location of Chennai). Colour bar represents the magnitude of wind speed. This figure is available in colour online at wileyonlinelibrary.com/journal/joc

ratio of  $O_3$  varies from 40 to 50 ppbv without any significant vertical gradients in the free troposphere, between 1 and 8 km of altitudes. Measurements during April–June months exhibit elevated mixing ratio of 50–70 ppbv in the middle troposphere between 3 and 8 km of altitudes. While consistently low mixing ratios of tropospheric  $O_3$  were observed from August to December months. In this period of summer monsoon circulation, vertical distributions of  $O_3$  show steady increasing trend with height as the mixing ratios were 10–15, 10–20, 20–30 and 30–40 ppbv between the altitudes of 0–2, 2–4, 4–6 and 6–8 km, respectively. On the other hand, the

seasonal variability in  $H_2O$  concentration of 6–30 g/kg was observed in the lower troposphere over Chennai.

Chennai is a metro city of India where anthropogenic emissions of precursors of  $O_3$  are continuous throughout the year. As expected for a typical urban site, the diurnal variations of ozone at Chennai exhibit elevated mixing ratio during daytime with low values at night (Pulikesi *et al.*, 2006). Therefore,  $O_3$  mixing ratios near the surface were always low as the MOZAIC profile measurements were always taken during the night hours. In the spring months (April and May), observed high concentrations of  $O_3$  in the lower and mid-troposphere could be due to

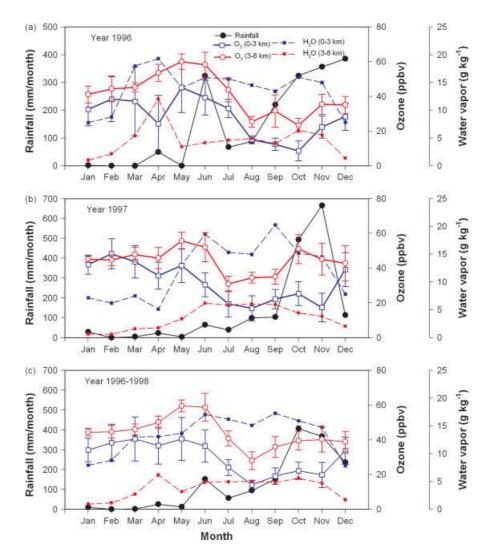


Figure 5. Monthly mean tropospheric (0–3 and 3–8 km of altitudes) ozone, water vapour, and rainfall per month over Chennai for 1996–1998 period (a–c). This figure is available in colour online at wileyonlinelibrary.com/journal/joc

the long-range transport of pollutants from the continental region of Asia (Hastenrath, 1985; Lal *et al.*, 2007). On the other hand, the observed low mean concentration of ~15 ppbv over Chennai is due to advection of cleaner air from the Indian Ocean during June to September. This is the period when frequency and amount of rainfall are highest at Chennai due to the influence of summer monsoon circulation. In a good agreement with this observation, the mixing ratios of O<sub>3</sub> were observed to be in the range of 10–20 ppbv over the southern region of Bay of Bengal during the summer monsoon campaign (Sahu *et al.*, 2006). To investigate how the rainfall might have linked with the seasonality in O<sub>3</sub> distributions, the monthly mean tropospheric mixing ratio of O<sub>3</sub> and rainfall recorded per month over Chennai are plotted in Figure 5. Annual variations of O<sub>3</sub> and rainfall show just opposite trends for year 1996 (Figure 5(a)). The rainfall was lowest from January to June months (year 1996 was an exception), while mixing ratio of O<sub>3</sub> was elevated at 35–60 ppbv during this period of measurements over Chennai. The onset of summer monsoon circulation (cleaner marine air), usually associated with rainfall and convective clouds, coincides with the decline in mixing ratio of O<sub>3</sub> from ~60 to 25 ppbv in upper troposphere

and  $\sim 40$  to 15 ppbv in lower troposphere. Later, from October to December, the rainfall increases over Chennai. However,  $O_3$  is almost constant at  $\sim 20$  ppbv in the lower troposphere and  $\sim 40$  ppbv in the upper troposphere partly due to the transport of polluted air from Indo-Gangetic plain (discussed in case studies). This insensitivity of O<sub>3</sub> mixing ratio to the increasing rainfall over Chennai could be partly due to the balance between the transport of pollutants and photochemical sink of O<sub>3</sub>. During the early winter monsoon circulation, the NE wind flow brings continental pollutants from Asia; however, concentrations of O<sub>3</sub> and other pollutants could be diluted due to intense rainfall and related chemical processes over Chennai. The importance of the processes leading to low mixing ratio of  $O_3$ , whether simple dilution or presence of additional O<sub>3</sub> sink due to high H<sub>2</sub>O,

needs further investigation. The monthly means of tropospheric  $O_3$  and  $H_2O$  over Chennai for measurements during 1996–1998 are shown in Table I.

Space-based observations from Measurements of Pollution in the Troposphere (MOPITT) (Kar *et al.*, 2004), the Microwave Limb Sounder (MLS) (Jiang *et al.*, 2007; Park *et al.*, 2007), the Atmospheric Composition Experiment (ACE) (Park *et al.*, 2008), and the Atmospheric Infrared Sounder (AIRS) (Randel and Park, 2006) also show how deep convection associated with the summer monsoon lofts boundary layer air with low O<sub>3</sub> and high H<sub>2</sub>O from Asia into the upper troposphere (Gettelman *et al.*, 2004). This pattern occurs also over Nairobi, a continental site that is located in a meteorological regime more akin to the Indian Ocean than central or southern Africa (Chatfield *et al.*, 2004, 2007).

4.2. Monthly mean profiles of  $O_3$  and  $H_2O$  during 1997 and 1998

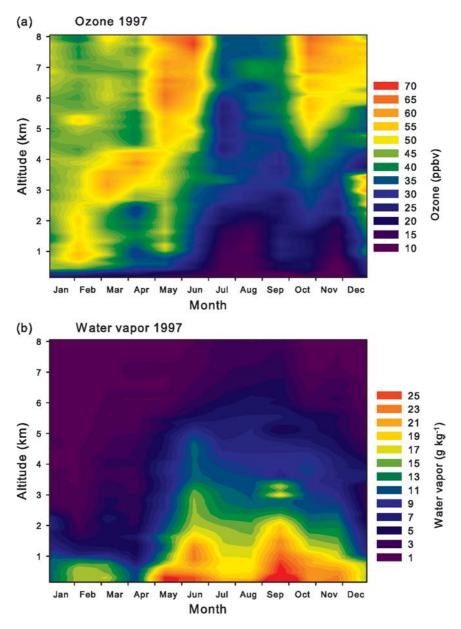


Figure 6. Monthly mean contour plots of (a) ozone and (b) water vapour representing the annual variations over Chennai during 1997. This figure is available in colour online at wileyonlinelibrary.com/journal/joc

Figure 6 shows the seasonal variations of tropospheric  $O_3$  and  $H_2O$  over Chennai for year 1997. Generally,

the seasonal pattern of mixing ratio of  $O_3$  is similar to that observed during 1996. The major factors such as emissions of  $O_3$  precursors from biomass burning sources and pattern of transport controlling the distribution of  $O_3$ in the troposphere may change significantly from year

to year. The main features are same for the years 1996 and 1997; however, some small-scale differences can be noticed in the year-to-year distributions of  $O_3$  over Chennai. The onset of episodes of low  $O_3$  during the summer monsoon starts from June in 1997, while it was from July during 1996. In the upper troposphere (6–8 km altitudes), mixing ratio of  $O_3$  varies between 30–40 and 50–60 ppbv during 1996 and 1997, respectively.

Similar to the observation for year 1996, the annual variations of  $O_3$  and rainfall data also show opposite trends during 1997 (Figure 5(b)). The rainfall was lowest from January to June months, while mixing ratio of  $O_3$  was elevated at 40–55 ppbv during this period of measurements. As has been explained the onset of summer monsoon brings cleaner marine air and rainfall, therefore mixing ratio of  $O_3$  declines from ~45 to 35 ppbv during July–August period. Later, from August

to November, the rainfall data exhibit increasing trend, while mixing ratio of  $O_3$  increases and it becomes  $\sim$ 45 ppbv in October month. The increasing trend in O<sub>3</sub> mixing ratio, particularly during the early winter months of year 1997, seems to be an unusual feature as we do not see such trends for both the years of 1996 and 1998 (Figure 5(a) and (c)). If we see the daily rainfall pattern during the late monsoon and early winter months, from August to mid-October, year 1997 seems to have influenced by spells of dry weather than those in other years of 1996-2001 (Figure 1). Interestingly, for the same period of year 1997 the mixing ratios of O3 in middle and upper troposphere over Chennai were higher than those in 1996 and 1998. The year 1997 corresponds to El Niño events when convective activity becomes low in Indonesia, in this region, extensive forest fire activities were reported due to sparse precipitation (Fujiwara et al.,

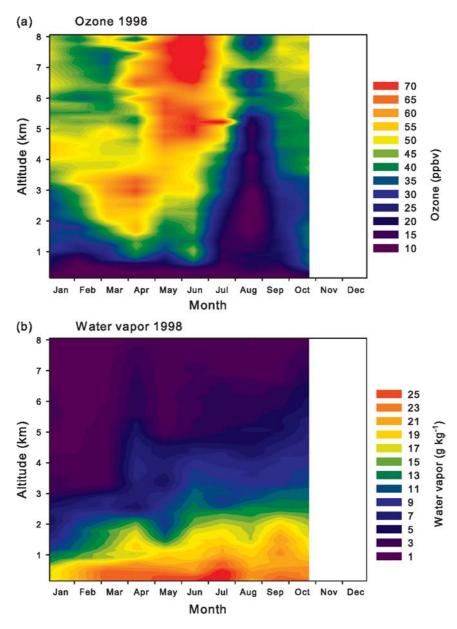


Figure 7. Monthly mean contour plots of (a) ozone and (b) water vapour representing the annual variations over Chennai during 1998. This figure is available in colour online at wileyonlinelibrary.com/journal/joc

1999 and reference therein). Pronounced enhancements of total and tropospheric  $O_3$  were also observed in the other parts of Southeast Asia when extensive forest fires were reported in Indonesia during 1997. The coincidences of the ozone enhancements with the forest fires suggest the photochemical production of tropospheric  $O_3$  due to its precursors emitted from the fires (Fujiwara *et al.*, 1999). Case study discussing the impacts of Indonesian forest fires on the vertical distribution of  $O_3$  over Chennai has been presented in Section 5.

Figure 7 shows the seasonal variations of  $O_3$  and  $H_2O$  over Chennai for year 1998. There were no MOZAIC measurements during November and December months, otherwise the seasonal variability in  $O_3$  during 1998 data is similar to that for year 1996. However, vertical extent of elevated  $O_3$  (values up to 80 ppbv) during spring season of 1998 is higher compared to same period of

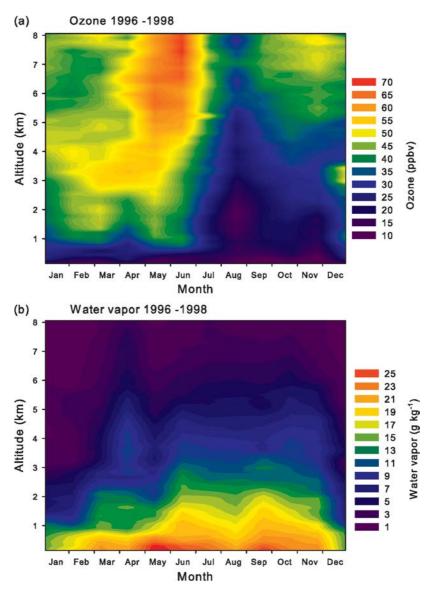


Figure 8. Monthly mean contour plots of (a) ozone and (b) water vapour representing the annual variations over Chennai during 1996–1998. This figure is available in colour online at wileyonlinelibrary.com/journal/joc

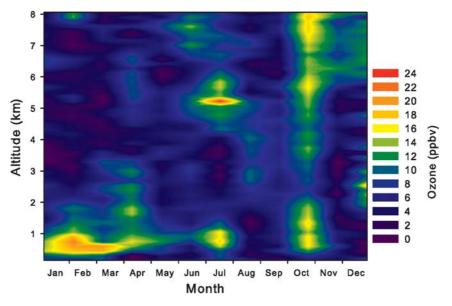


Figure 9. The 1-sigma (standard deviation) variations of monthly O<sub>3</sub> during 1996–1998 over Chennai. This figure is available in colour online at wileyonlinelibrary.com/journal/joc

1996 and 1997. Seasonal variation in H<sub>2</sub>O concentration during 1998 is also similar to 1996 over Chennai. For the period 1996–1998, the composite seasonal variations based on monthly mean vertical profiles of O<sub>3</sub> and H<sub>2</sub>O are shown in Figure 8. The general features observed in the seasonal patterns of both O3 and H2O are similar to those discussed for individual years. The 1-sigma (standard deviation) variation of monthly O<sub>3</sub> mixing ratio is shown in Figure 9. The mixing ratio of O<sub>3</sub> shows some small-scale anomalies in the lower and middle troposphere. The 1-sigma values of  $\sim 20$  ppbv between 0 and 1 km in the winter and spring months are due to exceptionally high values during year 1997. Another anomaly of 15-20 ppbv can be observed in the middle and upper troposphere (>6.0 km) during October. We have investigated all the individual profiles using back trajectories and fire count data to know the causes of this

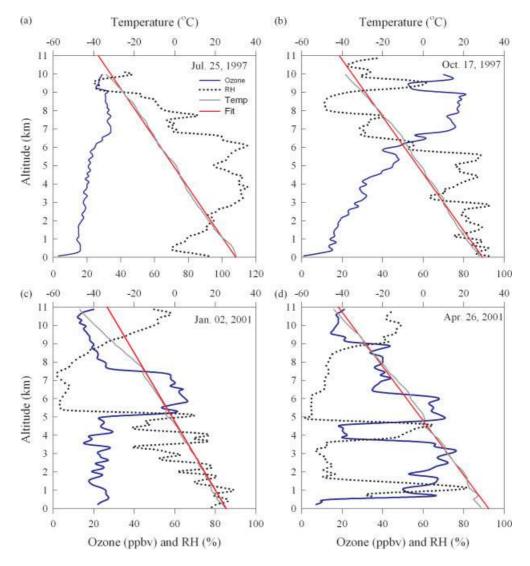


Figure 10. Vertical profiles of ozone, relative humidity, and temperature obtained from MOZAIC measurements over Chennai (a-d). This figure is available in colour online at wileyonlinelibrary.com/journal/joc

anomaly. We found that the long transport of  $O_3$ -rich air from extensive biomass burning regions of Indonesia during year 1997 yielded this feature (case study is presented in Section 5.).

#### 5. Case studies of O<sub>3</sub> profiles over Chennai

At any particular location, there can be large day-to-day variability in the vertical distributions of  $O_3$  and meteorological parameters. The magnitude of variability can change significantly with altitude, sometimes exhibiting marked stratification, with a single or multiple peaks, and other times exhibiting a uniform profile and absence of structures.

Each  $O_3$  profile is a unique response to photochemical and dynamic processes. Therefore, study of profiles in terms of its structure, particularly the magnitude and altitudes of maxima and minima, and vertical gradient should provide the insights about the underlying processes. Traditionally, mean profiles averaged by season or year together with some measure of variability about these means have been analysed (Kirchhoff et al., 1991; Diab et al., 1996; Fortuin and Kelder, 1998; Thouret et al., 1998b; Logan, 1999; Thompson et al., 2003). On the other hand, case studies have been widely used to gain an understanding of the underlying atmospheric processes. Examples of studies focusing on dynamic processes, particularly STE, include Merrill et al. (1996), Cooper et al. (1998), Folkins et al. (1999), Ramdriambelo et al. (1999), Zachariasse et al. (2000), Scott and Cammas (2002), and Kim et al. (2002). Others in which strong photochemical forcing was targeted include Fujiwara et al. (1999) and Longo et al. (1999). The drawback of case study analysis is that, whilst an understanding of process is gained, there is little contribution to our knowledge of the frequency of events or their relative importance in the overall budget of  $O_3$ .

In this study, we first describe the observed features in  $O_3$  along with RH and temperature in the troposphere and then back trajectory analysis will be discussed to explain the features associated with the transport of different air masses. The isentropic 7-day back trajectories were

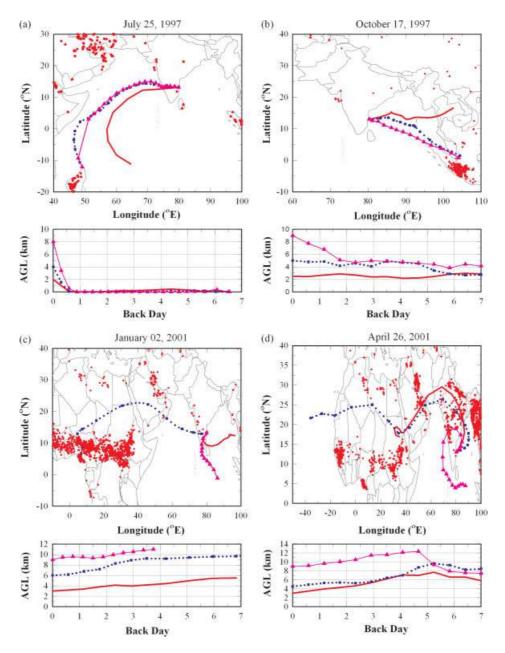


Figure 11. The 7-day back trajectory plots indicating the source and transport history of air masses at different altitudes for four selected dates of observation over Chennai (a–d). The monthly fire count data (filled circle in red) indicate the activities of biomass burning over the different continents. This figure is available in colour online at wileyonlinelibrary.com/journal/joc

calculated using the Hybrid Single-Particle Lagrangian Integrated Trajectories (HYSPLIT) program (Draxler and Hess, 1998). Back trajectories represent the large-scale circulation and may be used to suggest potential source regions, although origin of a specific air parcel cannot be determined exactly. The monthly fire count data from Along Track Scanning Radiometer (ASTR) have also been shown to demonstrate the emissions activities. In the following subsection, we have chosen four different days of MOZAIC observations to represent the typical features in the different seasons over Chennai.

#### 5.1. 25 July 1997

For 25 July 1997, the vertical profiles of  $O_3$ , RH, and temperature over Chennai are shown in Figure 10(a).

This day of MOZAIC measurements have been chosen as a representative for the summer monsoon period. In the lower troposphere (0–5 km), vertical profile of O<sub>3</sub> shows constant but very low values of ~15 ppbv, while RH increased from 80 to 90% near surface to 110% in the free troposphere. The layer of very high RH in the middle troposphere indicates the presence of thick cloud due to deep convection of marine air over Chennai. In the upper troposphere, O<sub>3</sub> increases from 20 to 30 ppbv, while RH profile shows decreasing trend in the upper troposphere.

Such low levels of  $O_3$  in the middle and upper troposphere are frequently observed in the tropical marine air (Fujiwara *et al.*, 2000). For this day of observation, the back trajectory plots calculated at three different altitudes of 2, 4 and 8 km are shown in Figure 11(a). All these trajectories over Chennai were tracked to have originated in the MBL of southern Indian Ocean. Back day analysis of the trajectories suggests that the air masses were confined within the MBL and were convectively uplifted (up to 8 km) just hours before their measurements over Chennai [see lower panel of Figure 11(a)]. Owing to deep convection of marine air, the entire troposphere is well mixed resulting in very low mixing ratios of O<sub>3</sub> and very high RH values over Chennai for this day of observation. In the monsoon season, due to wet or rainy weather, RH is typically associated with low levels of O<sub>3</sub> provided by less intense photochemical production (Lelieveld and Crutzen, 1990). In addition, the chemical loss due to following set of reactions (Parrish et al., 1986) could also play a major role.

Similarly, low values of  $O_3$  mixing ratios over the Indian Ocean have been reported due to lifting of ozonepoor MBL air by convective cells of the Inter Tropical Convergence Zone (ITCZ) (De Laat *et al.*, 1999; Taupin *et al.*, 1999; Chatfield *et al.*, 2004). In support to the observations, the biomass burning activities over Indian subcontinent were also lowest during the July 1997.

#### 5.2. 17 October 1997

For 17 October 1997, vertical profiles of O3, RH, and temperature showing large variability over Chennai are plotted in Figure 10(b). This day of MOZAIC measurements have been chosen as a representative for the transition period from summer to winter monsoon circulations over the Indian subcontinent. The mixing ratio of  $O_3$  is ~10 ppbv near the surface, which increases linearly with height in the lower troposphere (0-5 km), while profile of RH exhibits very high RH of  $\sim 90\%$ . At higher altitudes, mixing ratio of O<sub>3</sub> increases sharply from  $\sim$ 45 ppbv at 5.5 km to  $\sim$ 82 ppbv at 7 km. On the other hand, RH shows just opposite trend as it decreases from 90% at 5.5 km to 30% at 7 km. The peak in O<sub>3</sub> mixing ratio of 82 ppbv coincides with a minimum in RH of 10% between 7 and 8.5 km of altitudes. However, this profile over Chennai appears to be unusual, as we have not noticed such enhancements in  $O_3$  profiles during October and November months of other years.

Figure 11(b) shows back trajectory plots at altitudes 2.5, 5 and 9 km over Chennai for this day of measurements. The back trajectory arriving at 2.5 km of altitude originated over Thailand about 5 days before the observations. Subsequently, the air mass travelled through the MBL (which is a sink of  $O_3$ ) of Bay of Bengal before reaching over Chennai. On the other hand, the sources of back trajectories calculated at 5 and 9 km of altitudes were located in the lower troposphere over Indonesia. It

has been well known that during the October-December months of year 1997, there were extensive forest fire activities over Indonesia as also shown in Figure 11(b). Therefore, transport of O<sub>3</sub> and its precursors from Indonesia could have impacted the measurements over Chennai. The year of 1997 corresponds to El Niño events when convective activity becomes low in Indonesia. In this region, it is likely that pronounced enhancements of tropospheric O<sub>3</sub> associated with extensive forest fires due to sparse precipitation may take place (Fujiwara et al., 1999). Chan et al. (2003) have reported the substantial enhancements in O<sub>3</sub> mixing ratio over many parts of tropical Southeast Asia and the subtropical south China region including Hong Kong in mid-autumn and early winter (October-December) of 1997, when many forest fires occurred in the Indonesian region. Therefore, O<sub>3</sub> enhancements were caused by the large-scale outflows of  $O_3$  and other pollutants from the fire active regions of Indonesia, which were related to the abnormal meteorological conditions associated with the strong El Niño phenomenon. The spread of O<sub>3</sub> plume, extended as far as India, was also detected by satellites observation of the Earth Probe-Total Ozone Mapping Spectrometer (EP/TOMS) during intense fire (August-November 1997) over Indonesia (Thompson et al., 2001). The global importance of emissions from Indonesian peat fires is well established (Herman et al., 1997; Thompson et al., 2001; Cochrane, 2003)

#### 5.3. 02 January 2001

For 02 January 2001 of measurements, the vertical profiles of O<sub>3</sub>, RH, and temperature over Chennai are shown in Figure 10(c). This day of MOZAIC profiles have been chosen to represent the winter season measurements over Chennai. In the lower troposphere (0-5 km), mixing ratio of O<sub>3</sub> fluctuates between 20 and 30 ppbv, while corresponding RH profile shows decreasing trend with fluctuations between 40 and 90%. Interestingly, we can see several small-scale stratified layers in the profiles of both O<sub>3</sub> and RH, which are just opposite in phase. In the middle troposphere, a layer (5-7.5 km) of enhanced O<sub>3</sub>  $(\sim 40 \text{ ppbv})$  was observed when mixing ratio increased from  $\sim 25$  to 65 ppbv. On the other hand, RH profile exhibits just opposite variation and observed to be lowest of  $\sim 10\%$  when O<sub>3</sub> mixing ratio was highest. In the upper troposphere, mixing ratios of  $O_3$  decreases with height while RH increases as their values were  $\sim 20$  ppbv and 60%, respectively at 10 km of altitude. Newell et al. (1999) found that approximately 20% of the troposphere is stratified and that layers are sometimes as thin as a few hundred metres (Thouret et al., 2000).

To investigate the factors causing stratifications in both profiles of  $O_3$  and RH, the back trajectories calculated at the three different altitudes of 3, 6 and 9 km over Chennai are plotted in Figure 11(c). Air parcels arriving at 3 and 9 km of altitudes were originated in the free troposphere over the oceanic regions of Indian Ocean and Bay of Bengal and do not show any influence of continental air mass. In the tropics, maritime free tropospheric air mass is characterized by low O<sub>3</sub> and high RH due to lifting of ozone-poor MBL air by convective cells of the ITCZ (De Laat et al., 1999; Taupin et al., 1999). Further, additional depletion of  $O_3$  in clouds might have also caused the observed low and high RH in their respective profiles (Kley et al., 1996). On the other hand, trajectory arriving at 6 km of altitude shows continental influence as it originated over extensive biomass burning regions of west and central Africa (Ghana and Nigeria). The combination of high O<sub>3</sub> and low RH might be due to convectively lifted CBL air that has subsided over Chennai (Zachariasse et al., 2000). January is the month characterized by the more intense fire activity in west central Africa, where emissions of pollutants including the precursors of  $O_3$  are large (Eva and Lambin, 2000).

A field campaign named *EXP* eriment for *RE* gional Sources and Sinks of Oxidants (EXPRESSO) was designed to investigate the O<sub>3</sub> formation in the tropical troposphere above central Africa and to consider the impact of biomass burning processes on the global atmosphere in the November month 1996 (Marion *et al.*, 2001). During this campaign period, which corresponds to an intense burning activity, the ozone production efficiency (OPE) ranging from 6.3 to 14.8 was estimated in the plumes. Satellite observations have shown high levels of tropospheric O<sub>3</sub> over large areas above the western African continent (Fishman *et al.*, 1990).

#### 5.4. 26 April 2001

Vertical profiles of O<sub>3</sub>, RH, and temperature measured on 26 April 2001 have been shown in Figure 10(d). Typical for the distribution in spring season, profiles of both O<sub>3</sub> and RH show large variations resembling laminar structure over Chennai. The mixing ratio of  $O_3$  is below 10 ppby, while RH varies from 40 to 80% in the boundary layer. Above the boundary layer, the mixing ratio of O<sub>3</sub> increases rapidly to 50-75 ppbv and remain elevated up to 3.5 km of altitude, while reverse to  $O_3$ profile RH value is down to  $\sim 10\%$  in this layer. In the mid-troposphere, between 3.5 and 4.5 km of altitudes,  $O_3$  decreases to 20 ppbv and RH increases to 70% simultaneously. Similar to layer observed just above the boundary layer, mixing ratio of O3 shoots to the elevated values of 60-70 ppbv while RH becomes extremely low (below 5%) between 5 and 7 km of altitudes. A layer with O<sub>3</sub> of about 35 ppbv and RH of 15% was observed between 7 and 9 km of altitudes. In the upper troposphere, mixing ratio of  $O_3$  is ~20 ppbv and RH is relatively high of 40% between 9 and 11 km of altitudes.

We have calculated the back trajectories at various altitudes for this day of measurements; however, trajectories only at 3.0, 4.5 and 8 km of altitudes are shown in Figure 11(d). In previous case study, we have explained that the enhancements in  $O_3$  mixing ratio in the free troposphere over Chennai are mainly due to the long-range transport of fire plumes from Africa. However, in the present case study the observed low mixing ratio of  $O_3$ 

and high RH near the surface is due to strong temperature inversion (Figure 11(d)), hence  $O_3$ -rich free tropospheric air does not enter into the boundary layer. The trajectory at 3 km over Chennai, which corresponds to the elevated  $O_3$  of ~80 ppbv, was originated over the central Africa and passed through Arabian Peninsula and northwest India. April is the end of fire season over central Africa (Eva and Lambin, 2000); however, apart from biomass burning other anthropogenic pollutants could be transported from continents of India and Arabian Peninsula. Diab et al. (2003) have also reported that the forest fire emissions over the central Africa are responsible for the low to mid-tropospheric enhancements in the spring season. Trajectory at 4.5 km originated in the upper troposphere over the Atlantic Ocean and passes through the marine region of Bay of Bengal, resulting in low O<sub>3</sub> and high RH over Chennai. This could have resulted in the dilution of a high O<sub>3</sub> layer as there are two layers with similar levels of O<sub>3</sub> and RH lying just below and above to this layer of lower O<sub>3</sub> mixing ratio. Trajectories arriving in the upper troposphere at 9 km and higher altitudes were originated over the southeast of Indian Ocean and could have transported the O<sub>3</sub>-poor and wet air masses over Chennai. While moderately low O<sub>3</sub> of 35 ppbv and high RH (40%) at 8 km was due to the transport of mixed air from Arabian Sea and continental region of central India. This transport could be due to the presence of easterly jet, which is characterized by O<sub>3</sub>-poor and wet layer at 9–14 km over the tropics (Fujiwara et al., 2003).

#### 6. Conclusions

Climatology of tropospheric ozone and water vapour over a metro city of Chennai in southern India has been presented based on the MOZAIC data during 1996-2001. We have also used the NCEP wind data and HYSPLIT back trajectory calculation to explain the transport and origin of various air masses. Chennai is a coastal city where NE monsoon period from October to December is the principal rainy season, whereas the SW monsoon from June to September is the secondary rainy season. The vertical distributions of both O<sub>3</sub> and H<sub>2</sub>O show large seasonal variations for each year of measurements from 1996 to 1998. In the late winter and spring months, the observed high values of 60-80 ppbv of O<sub>3</sub> mixing ratio in the middle troposphere over Chennai were attributed to the long-range transport of pollutants form continents of Africa and Arabian Peninsula by the northwesterly winds. On the other hand, low  $O_3$  mixing ratios of  $\sim$ 15 ppbv were observed during the JAS months, which coincide with the summer monsoon circulation over Indian subcontinent. On the other hand, monthly rainfall and vertical distributions of H<sub>2</sub>O show just opposite seasonal variations to O3 mixing ratio. The onset of summer monsoon circulation associated with rainfall and convective clouds coincides with the decline in mixing ratio of O<sub>3</sub>. While from August to December, the monthly rainfall data exhibit increasing trend, but O3 was almost

constant, this insensitivity of  $O_3$  mixing ratio was due to the balance between the transport of pollutants and photochemical sink of  $O_3$ . For year 1997, rather elevated but increasing trend in  $O_3$  mixing during the early winter months seems to be an unusual feature as we do not see such trends for both the years of 1996 and 1998 of MOZAIC measurements over Chennai.

We have also selected some MOZAIC measurements for case studies of O<sub>3</sub>, RH and temperature to investigate the impacts of long-range transport and special climatologically events. As a representative for the summer monsoon measurements, the profiles on 25 July 1997 exhibit low  $O_3$  values of  $\sim \! 15$  ppbv and high RH in the troposphere due to the deep convection of marine air over Chennai. The measurements on 17 October 1997 have been chosen as a representative for the transition period from summer to winter monsoon circulations over the Indian subcontinent. This day of O<sub>3</sub> profile exhibits strong enhancements from  $\sim$ 45 ppbv at 5.5 km to  $\sim$ 82 ppbv at 7 km over Chennai due to transport from extensive forest fire region of Indonesia during year 1997, which corresponds to El Niño events. This is for the first time we report the enhancements of O<sub>3</sub> over India caused by the extensive fires over Indonesia. On 02 January 2001, typical for winter monsoon, the vertical profiles of O<sub>3</sub> and RH show several small-scale stratified layers that are just opposite in phase. Typical for the distribution in spring season, profiles on 26 April 2001 show large variations of both O<sub>3</sub> and RH resembling laminar structure over Chennai.
