## Problem of flow data visualization

The visualization of flow matrices is notably difficult because of:


- the variability of origin-destination (OD) lengths;
- the spatial localization of nodes;
- the relative orientation of links;
- the number of nodes (N places) and of links  $(N^2)$ ;
- the direction and value of links;
- the geographical scale;
- etc.



Spaghetti-effect

#### General issues in flow mapping


Thresholded flow map

Several solutions can be applied in order to reduce the *spaghetti-effect*. All of them aims to reduce the complexity of the flow map by selecting graphical features, or by thresholding or aggregating flow values.

### **MAPOD** objective

To geovisualize all the information available in an OD matrix without *a priori* selection of information. To enable the analysis of short distance commuting patterns as well as long distance relationships. To obtain readable and aesthetical maps!

→ Extension of an open-source flow visualization software (JFlowmap)





#### Use of an appropriate colormap

Dark background and double coloration of the features' light

Modification of links geometry

Edge bundled features (visual graphic aggregation)

The (+): A free tool – easy to use - portable & interactive (more a visualization software than a mapping software)

The (-): Memory intensive.

## **MAPOD** approach

**MAPOD** (*Mapping Origin-Destination matrices*) is an innovative interactive application for the geovisualization of local transport demand summarized in the form of an OD matrix.


**MAPOD** deals with the key-problem of visualizing complex spatial networks. It is integrated in JFlowMap (Boyandin, 2010) that enables *edge bundling* and interactive flow geovisualisation.


We have extended JFlowMap in order to include 1) the transformation of geographical spaces into "geographical chord diagrams" preserving the proximities and cardinal orientations of nodes 2) the partitioning of space into functional regions with respect to flow values.



MAPOD won the first price of the french Saint-Dié-des-Vosges International Festival of Geography (FIG'2013) competition on *geovisualization and dynamic cartography*.

#### **Key-concepts**







**Functional regionalization** 

"Geographical" chord diagrams

Inside each region, municipalities are projected onto one of the two concentric circles computed as the basis for "geographical" chord diagrams. The inner circle contains the central cities, whereas the outer circle the ones from the periphery. Vicinities and cardinal directions are preserved as far as possible

Final visualization

The final visualization of "geographical" chord diagram is to be read in conjunction with the edge bundled map on the left column.
