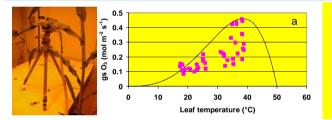
Background: Tropospheric ozone (O₃) is an important gaseous air pollutant with severe phytotoxic effects due to strong oxidizing properties. Current tropospheric O₃ concentrations have become a factor of climate change that mitigates the carbon sink strength of vegetation in a context of increasing atmospheric CO₂. This is particularly acute in spring and summer, as happened during the 2003 summer heat wave.

Indicators: Over the past two decades, prevention of O3 effects on European vegetation has driven the development of policies primarily based on the AOT40 exposure index. Accumulating evidence suggests that the responses of vegetation to ozone are better related to the absorbed dose through stomata than to external concentrations (the absorbed dose being defined as the balance between the O3 taken up and leaf tissue O3-detoxification capacity). However, to date, the detoxification capacity of plants remains an elusive quantity despite the need for detoxification functions (D) to be included in photosynthesis models.

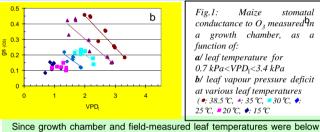


Fig.1: Maize stomatal conductance to O_3 measured ha growth chamber, as a function of: a/ leaf temperature for 0.7 kPa<VPD₁<3.4 kPa b/ leaf vapour pressure deficit at various leaf temperatures (●: 38.5°C. ▲: 35°C. ■ 30°C. ♦: 25 °C, ■ 20 °C, ♦: 15 °C

The responses to O₃ of crops like winter wheat are well documented unlike those of summer crops like maize and sunflower. Here are shown preliminary results about the vulnerability of maize, a typical summer crop, to O₃. To estimate the impact of O₃ on maize photosynthetic parameters, a new model for the determination of stomatal conductance (gs) based on a multiplicative Jarvis-Stewart approach and including an original temperature/VPD₁ function, was designed (Fig. 1). Phytotoxic Ozone Dose (POD) values were derived from this model (POD= ΣO_3 Flux = $\Sigma [O_3]^+$ gs₀).

Step 1: Parameterisation of leaf stomatal conductance vs leaf vapor pressure deficit (VPD_i), leaf temperature (T_i), light, etc... according to Jarvis functions, as determined from growth chamber studies, using a LiCor 6400 (Massad et al. 2007).

A temperature response curve was derived from the experimental data shown on Fig 1a.

gs(O₃) = gs(O₃)opt*[2(T-Tmin)^a(Topt-Tmin)^a-(T-Tmin)^{2a}]/(Topt-Tmin)² a=In2/In[(Tmax-Tmin)/(Topt-Tmin)], gs(O3)opt=0.46 molm-2s-1, where Topt=38.5°C (Tmin and Tmax were arbitrarily set at 0°C and 50°C, respectively), (DO₃/DH₂O=0.663).

gs(O₃) = gs(O₃)_{max}*[1/(1-VPD₀)*,(VPD₁-VPD₀)]*[exp(a*(T-T_{max}))] where leaf VPD₀=4.13 kPa and a=0.09093, R²=0.826, bias=0.053, and $gs(O_3)$ max fitted value=0.618 mol m⁻² s⁻¹.

Step 2: Determination of O₃ impact in three experimental setups (Open Top Chamber, Growth Chamber and field Face system).

Leaf photosynthetic parameters were deduced from A/CO₂ curves established , using a LiCor 6400. A mean O₃ concentration of approximately 80 nmol mol⁻¹ (11.5<AOT40<12.4 ppm h) induced a 50% reduction and a 30% reduction in the maximal PEP carboxylation rate (Vpmax) and the maximal leaf photosynthesis rate (Vcmax), respectively (Table 1).

Table 1- Vpmax, Vcmax and O₃ exposure indices (accumulated exposure over a threshold concentration for ozone of 40 nmol mol⁻¹ (AOT40) and POD₂) for maize leaves located near the ear. In the OTC and field experiments, stomatal conductance (gs) was determined according to a new model. In the growth chamber experiment, gs values were measured.

Concluding remarks: (i) In all three experimental setups, O_q-induced reductions in Vcmax were equivalent. (ii) To include leaf O₃ detoxification capacity in POD values, a 6 nmol m⁻² s⁻¹ threshold was arbitrarily set. However, further field experiments are required to accurately determine maize O₃ scavenging capacities, either as a threshold O₃ flux or as a more complex function. (iii) gsmax is observed at 38.5 °C in maize (at 25°C in maize and wheat, EMEP). Since gs is lower in maize than in wheat for the sameT and [CO₂] values, maize POD values were lower than those generally found in wheat. (iv) As a consequence, field-grown maize yield parameters were not affected in this experiment. POD values could better explain why, in Atlantic central Europe, the yield of winter wheat is reduced by 15% for an 8 mmol mol⁻¹ h AOT40, while little change occurs in maize yield in response to increasing AOT40 values (Mills et al., 2007).
