# $C^{\infty}$ LOCAL SOLUTIONS <br> OF ELLIPTICAL 2-HESSIAN EQUATION IN $\mathbb{R}^{3}$

#### Abstract

In this work, we study the existence of $C^{\infty}$ local solutions to 2-Hessian equation in $\mathbb{R}^{3}$. We consider the case that the right hand side function $f$ possibly vanishes, changes the sign, is positively or negatively defined. We also give the convexities of solutions which are related with the annulation or the sign of right-hand side function $f$. The associated linearized operator are uniformly elliptic.


## 1. Introduction

We are interested by the following $k$-Hessian equation

$$
\begin{equation*}
S_{k}[u]=f(y, u, D u) \tag{1.1}
\end{equation*}
$$

on an open domain $\Omega \subset \mathbb{R}^{n}, 1 \leq k \leq n, f \in C^{\infty}\left(\Omega \times \mathbb{R} \times \mathbb{R}^{n}\right)$. Denote $D u=\left(\partial_{1} u, \ldots, \partial_{n} u\right)$ and $D^{2} u$ is the Hessian matrix $\left(\partial_{i} \partial_{j} u\right)_{1 \leq i, j \leq n}$. the Hessian operators $S_{k}[u]$ is defined as follows:

\begin{equation*}
S_{k}[u]=\sigma_{k}\left(\lambda\left(D^{2} u\right)\right), \quad k=1, \ldots, n \tag{1.2}
\end{equation*}
$$

where $\lambda\left(D^{2} u\right)=\left(\lambda_{1}, \lambda_{2}, \ldots, \lambda_{n}\right), \lambda_{j}$ is the eigenvalue of the Hessian matrix $\left(D^{2} u\right)$, and

$$
\sigma_{k}(\lambda)=\sum_{1 \leq i_{1}<\cdots<i_{k} \leq n} \lambda_{i_{1}} \cdots \lambda_{i_{k}}
$$

is the $k$-th elementary symmetric polynomial. Denoting, for $k, j \in\{1, \cdots, n\}$,

$$
\left.\sigma_{k, j}=\frac{\partial \sigma_{k+1}(\lambda)}{\partial \lambda_{j}}=\sigma_{k} \right\rvert\, \lambda_{j}=0
$$

We also introduce the Gårding cone $\Gamma_{k}$ which is the open symmetric convex cone in $\mathbb{R}^{n}$, with vertex at the origin, given by

$$
\Gamma_{k}=\left\{\left(\lambda_{1}, \ldots, \lambda_{n}\right) \in \mathbb{R}^{n}: \sigma_{j}(\lambda)>0, \forall j=1, \ldots, k\right\} .
$$

When $k=1$, (1.1) is a semi-linear Poisson equation, and it is Monge-Ampère equation for $k=n$.

We say that a function $u \in C^{2}$ is $k$-convex, if

$$
\lambda\left(D^{2} u\right) \in \bar{\Gamma}_{k},
$$

the $n$-convex function is simply called convex function.

[^0]We say that a function $u$ is a local solution of (1.1) near $y_{0} \in \Omega$, if there exists a neighborhood of $y_{0}, V_{y_{0}} \subset \Omega$ such that $u \in C^{2}\left(V_{y_{0}}\right)$ satisfies the equation (1.1) on $V_{y_{0}}$.

In this work, we study the existence of $C^{\infty}$-local solution of the following 2-Hessian equation in $\mathbb{R}^{3}$,

$$
\begin{equation*}
S_{2}[u]=f(y, u, D u), \quad \text { on } \Omega \subset \mathbb{R}^{3}, \tag{1.3}
\end{equation*}
$$

where we also have

$$
S_{2}[u]=u_{11} u_{22}-u_{12}^{2}+u_{22} u_{33}-u_{23}^{2}+u_{11} u_{33}-u_{13}^{2} .
$$

We have proved the following results.
Theorem 1.1. Assume that $f \in C^{\infty}\left(\Omega \times \mathbb{R} \times \mathbb{R}^{3}\right)$, then for any $Z_{0}=\left(y_{0}, z_{0}, p_{0}\right) \in \Omega \times \mathbb{R} \times \mathbb{R}^{3}$, we have that
(1) if $f\left(Z_{0}\right)=0$, then (1.3) admits a 1 -convex $C^{\infty}$ local solution which is not convex;
(2) if $f \geq 0$ near $Z_{0}$, then (1.3) admits a 2-convex $C^{\infty}$ local solution which is not convex. If $f\left(Z_{0}\right)>0$, (1.3) admits a convex $C^{\infty}$ local solution.
(3) if $f\left(Z_{0}\right)<0,(1.3)$ admits a 1 -convex $C^{\infty}$ local solution which is not 2-convex.

Moreover, the equation (1.3) is uniformly elliptic with respect to the above local solutions.
For the local solution, Hong and Zuily [5] obtained the existence of $C^{\infty}$ local solutions to arbitrary dimensional Monge-Ampére equation, in which $f$ is not only nonnegative but also satisfies a variant of Hörmander rank condition. Lin [8] proved the existence of a local $H^{s}$ solution in $\mathbb{R}^{2}$ with $f \geq 0$. We will follow the ideas of [5] and [8, 9], the existence of the local solution can be obtained by a perturbation of polynomial-typed solution for $S_{2}[u]=a$ where $a$ is a constant, so that our solution is in the form

$$
u(y)=\frac{1}{2} \sum_{j=1}^{3} \tau_{j} y_{j}^{2}+\varepsilon^{5} w\left(\varepsilon^{-2} y\right), \quad \tau=\left(\tau_{1}, \tau_{2}, \tau_{3}\right) \in \mathbb{R}^{3}
$$

The significance of theorem 1.1 is our results break away from the framework of Gårding cone. The sign of $f$ is permitted to change in case (1). For the case (2), we say that it is a degenerate 2 -Hessian equation if $f\left(Z_{0}\right)=0$ (see [10]). The non-convex solution in (1) and (2) never occurs for Monge-Ampére equation. There is also many works about the convexity of solution to Hessian equation, see [11] and reference therein. Besides, these results seems to be strange. However, that is because the relationship between the sign of $f$ and the ellipticity of the nonlinear $k$-Hessian equation may not be close.

The rest of this paper is arranged as follow: in Section 2, we will give definitions and some known results. Section 3 is devoted to the proof of Theorem 1.1.

## 2. Preliminaries

In this section, we collect some definitions and known results of $k$-Hessian equations. Firstly some algebraic properties of Gårding cone.

Proposition 2.1 (See [12]). Using the notations introduced in Section 1,
(1) $\sigma_{k}(\lambda)=0$ for $\lambda \in \partial \Gamma_{k}$ and

$$
\Gamma_{n} \subset \ldots \subset \Gamma_{k} \subset \ldots \subset \Gamma_{1} .
$$

(2) Maclaurin's inequalities, for any $\lambda \in \Gamma_{k}, l \leq l \leq k$,

$$
\left[\frac{\sigma_{k}(\lambda)}{\binom{n}{k}}\right]^{1 / k} \leq\left[\frac{\sigma_{l}(\lambda)}{\binom{n}{l}}\right]^{1 / l} .
$$

(3) we also have

$$
\begin{cases}\sigma_{k}(\lambda)=\lambda_{i} \sigma_{k-1 ; i}(\lambda)+\sigma_{k ; i}(\lambda), & \forall \lambda \in \mathbb{R}^{n}, \\ \sum_{i=1}^{n} \sigma_{k, i}(\lambda)=(n-k) \sigma_{k}(\lambda), & \forall \lambda \in \mathbb{R}^{n} .\end{cases}
$$

(4) Assume that $\lambda \in \Gamma_{k}$ is in descending order,

$$
\lambda_{1} \geq \cdots \lambda_{p-1} \geq \lambda_{p}>0 \geq \lambda_{p+1} \geq \cdots \lambda_{n}
$$

then $p \geq k$ and

$$
\begin{equation*}
\sigma_{k-1 ; n}(\lambda) \geq \cdots \geq \sigma_{k-1 ; 1}(\lambda)>0 . \tag{2.1}
\end{equation*}
$$

When $n=3$, we see that $\sigma_{3}(\lambda)>0$ cannot occur for $\lambda \in \partial \Gamma_{2}(\lambda)$, therefore we can express $\partial \Gamma_{2}$ as two parts

$$
\begin{aligned}
& \partial \Gamma_{2}(\lambda)=\mathbf{P}_{1} \cup \mathbf{P}_{2}, \\
& \mathbf{P}_{1}=\left\{\lambda \in \mathbb{R}^{3} ; \sigma_{1}(\lambda) \geq 0, \sigma_{2}(\lambda)=\sigma_{3}(\lambda)=0\right\}, \\
& \mathbf{P}_{2}=\left\{\lambda \in \mathbb{R}^{3} ; \sigma_{1}(\lambda)>0, \sigma_{2}(\lambda)=0, \sigma_{3}(\lambda)<0\right\} .
\end{aligned}
$$

Next, we will recall that what condition can lead to the ellipticity.
As for the framework of ellipticity, we follow the ideas of [6] and [7]. Denote $\operatorname{Sym}(n)$ as the set of symmetric real $n \times n$ matrix. Through the matrix language, we recall the direct condition which leads to the elliptic $k$-Hessian operator. The ellipticity set of the $k$-Hessian operator, $k=1,2, \ldots, n$, is

$$
E_{k}=\left\{S \in \operatorname{Sym}(n): S_{k}(S+t \xi \times \xi)>S_{k}(S)>0,|\xi|=1, t \in \mathbb{R}^{+}\right\}
$$

and the Gårding cones

$$
\Gamma_{k}=\left\{S \in \operatorname{Sym}(n): S_{k}(S+t I d)>S_{k}(S)>0, t \in \mathbb{R}^{+}\right\},
$$

where the definition of $S_{k}(S)$ is given in (1.2). It is easy to show that $E_{k}=\Gamma_{k}$ only for $k=1, n$ and the example in [7] assures that $\Gamma_{k} \subset E_{k}$ and $\operatorname{mess}\left(E_{k} \backslash \Gamma_{k}\right)>0$ when $1<k<n$. Ivochkina, Prokofeva and Yakunina [7] point out that the ellipticity of (1.1) is independent of the sign of $f$.

We now present an algebraic property of

$$
\frac{\partial}{\partial \tau_{i}} \sigma_{2}(\tau)=\sigma_{1, i}(\tau), \quad i=1,2,3
$$

for $\tau=\left(\tau_{1}, \tau_{2}, \tau_{3}\right) \in \mathbf{P}_{2}$.
Lemma 2.2. Assume that $\tau \in \mathbf{P}_{2}, \tau_{1} \geq \tau_{2} \geq \tau_{3}$. Then we have

$$
0<\sigma_{1,1}(\tau) \leq \sigma_{1,2}(\tau) \leq \sigma_{1,3}(\tau)
$$

and

$$
\begin{equation*}
\tau_{3}<0<\tau_{2} \leq \tau_{1} . \tag{2.2}
\end{equation*}
$$

The above result means that for any

$$
\psi=\frac{1}{2} \sum_{i=1}^{3} \tau_{i} y_{i}^{2}, \quad \tau \in \mathbf{P}_{2}
$$

it is a solution of 2-Hessian equation $S_{2}(\psi)=0$, and the linearized operators of $S_{2}[u]$ at $\psi$

$$
\mathcal{L}=\sum_{i=1}^{3} \sigma_{1, i}(\tau) \partial_{i}^{2}
$$

is uniformly elliptic,
Proof. Recall that, for any $\tau \in \mathbb{R}^{3}$,

$$
\sigma_{2}(\tau)=\tau_{1} \tau_{2}+\tau_{2} \tau_{3}+\tau_{1} \tau_{3},
$$

and

$$
\sigma_{1 ; 1}(\tau)=\tau_{2}+\tau_{3}, \quad \sigma_{1 ; 2}(\tau)=\tau_{1}+\tau_{3}, \quad \sigma_{1 ; 3}(\tau)=\tau_{1}+\tau_{2}
$$

Denote $\lambda+\varepsilon=\left(\lambda_{1}+\varepsilon, \lambda_{2}+\varepsilon, \lambda_{3}+\varepsilon\right)$ with $\lambda \in \mathbb{R}^{3}$ and $\varepsilon \in \mathbb{R}$, then we have the formula

$$
\sigma_{2}(\lambda+\varepsilon)=\sum_{j=0}^{2} C(j) \varepsilon^{j} \sigma_{2-j}(\lambda), \quad C(j)=\frac{\binom{3}{2}\binom{2}{j}}{\binom{3-j}{2}}
$$

For $\tau \in \mathbf{P}_{2}$, we have

$$
\sigma_{1}(\tau)>0, \quad \sigma_{2}(\tau)=0
$$

then

$$
\tau+\varepsilon \in \Gamma_{2}, \quad \forall \varepsilon>0
$$

Applying (2.1) to $\tau+\varepsilon$ and letting $\varepsilon \rightarrow 0^{+}$, we get

$$
0 \leq \sigma_{1,1}(\tau) \leq \sigma_{1,2}(\tau) \leq \sigma_{1,3}(\tau)
$$

Since $\tau \in \mathbf{P}_{2}$, we have

$$
\sigma_{2}(\tau)=\tau_{1} \sigma_{1,1}(\tau)+\sigma_{2,1}(\tau)=0
$$

if $\sigma_{1,1}(\tau)=\tau_{2}+\tau_{3}=0$, then,

$$
\sigma_{2,1}(\tau)=\tau_{2} \tau_{3}=0
$$

thus $\sigma_{3}(\tau)=\tau_{1} \tau_{1} \tau_{3}=0$, which contradicts with the assumption $\sigma_{3}(\tau)<0$. Then, We have proven that, for any $\tau \in \mathbf{P}_{2}$,

$$
0<\sigma_{1,1}(\tau) \leq \sigma_{1,2}(\tau) \leq \sigma_{1,2}(\tau)
$$

We prove now (2.2). Since $\sigma_{1}(\tau)>0$, by (4) we have $\tau_{1}>0$. We now claim that $\tau_{1}=$ $\tau_{2}=\tau_{3}$ is impossible. Indeed, if that holds, then $\sigma_{1}(\tau)=3 \tau_{1}>0$ and $\sigma_{2}(\tau)=3 \tau_{1}^{2}>0$, which contradicts with the assumption $\sigma_{2}(\tau)=0$.

Besides, $\sigma_{3}(\tau)<0$ imply that $\tau_{i} \neq 0$ and $\tau_{i}$ can not be positive at the same time. Then property (4) of Proposition 2.1 implies

$$
\tau_{3}<0<\tau_{2} \leq \tau_{1} .
$$

We also have the following elliptic results for $\tau \in \Gamma_{1} \backslash \bar{\Gamma}_{2}$.
Lemma 2.3. For the Gårding cone, we have
(1) For any given $a<0$, there exists $\tau \in \Gamma_{1} \backslash \bar{\Gamma}_{2}$, such that

$$
\sigma_{1}(\tau)>0, \quad \sigma_{2}(\tau)=a
$$

(2) For any given $b>0$, there exists $\tau \in \Gamma_{2} \backslash \bar{\Gamma}_{3}$, such that

$$
\sigma_{1}(\tau)>0, \quad \sigma_{2}(\tau)=b, \quad \sigma_{3}(\tau)<0
$$

(3) For any given $c>0$, there exists $\tau \in \Gamma_{3}$, such that

$$
\sigma_{1}(\tau)>0, \quad \sigma_{2}(\tau)=c, \quad \sigma_{3}(\tau)>0
$$

Moreover, for all above case, we have

$$
\sigma_{1,3}(\tau)>\sigma_{1,2}(\tau)>\sigma_{1,1}(\tau)>0
$$

Proof. We only need to prove the case (1), and to find a $\tau \in \mathbb{R}^{3}$. We can choose $\alpha>0$ and $\beta>0$ such that

$$
(1+\beta) \alpha-1<0 .
$$

Then take $\Theta>0$ satisfying

$$
\Theta^{2}(1+\alpha)[(1+\alpha) \beta-1]=a .
$$

We claim that $\tau$ can be in the following form

$$
\tau=\left(\tau_{1}, \tau_{2}, \tau_{3}\right)=((1+\alpha)(1+\beta) \Theta,(1+\alpha) \Theta,-\Theta)
$$

Indeed, from $1+\beta>1$ and $(1+\alpha) \Theta>0$, we have

$$
\tau_{1}>\tau_{2}>\tau_{3}
$$

$\sigma_{1}(\tau)>0$ and $\sigma_{2}(\tau)=a$. Moreover,

$$
\sigma_{1,3}(\tau)=(1+\alpha)(2+\beta) \Theta>\sigma_{1,2}=(\alpha \beta+\alpha+\beta) \Theta>\sigma_{1,1}(\tau)=\alpha \Theta>0
$$

Proof is done.
For the linearized operators of $k$-Hessian equation, we have the following results, the general version of which can be found in section 2, [2].

Lemma 2.4. The matrix $S_{2}^{i j}(r(w))$ and $\left(r_{i j}(w)\right)$ can be diagonalized simultaneously, that is, for any smooth function $w$, we can find an orthogonal matrix $T(x, \varepsilon)$ satisfying

$$
\left\{\begin{array}{l}
T(x, \varepsilon)\left(S_{2}^{i j}\right)^{t} T(x, \varepsilon)=\operatorname{diag}\left[\frac{\partial \sigma_{2}(\lambda)}{\partial \lambda_{1}}, \frac{\partial \sigma_{2}(\lambda)}{\partial \lambda_{2}}, \frac{\partial \sigma_{2}(\lambda)}{\partial \lambda_{3}}\right] \\
T(x, \varepsilon)\left(r_{i j}\right)^{t} T(x, \varepsilon)=\operatorname{diag}\left[\lambda_{1}(x, \varepsilon), \lambda_{2}(x, \varepsilon), \lambda_{3}(x, \varepsilon)\right]
\end{array}\right.
$$

where ${ }^{t} T(x, \varepsilon)$ is the transpose of $T(x, \varepsilon)$ and $S_{2}^{i j}(r(w))=\partial S_{2} / \partial r_{i j}(r(w))$. Furthermore,

$$
\left.T(x, \varepsilon)\right|_{\varepsilon=0}=I d
$$

where Id is the identity matrix.
Proof. For $T=\left(T_{i j}\right)$, we have

$$
\begin{equation*}
\sum_{i=1}^{3} T_{s i} T_{t i}=\delta_{s}^{t} . \tag{2.3}
\end{equation*}
$$

Now we set $\left(r_{i j}\right)$ can be diagonalized by $T$,

$$
\left(T_{i j}\right)\left(r_{i j}\right)^{t}\left(T_{i j}\right)=\left(\begin{array}{lll}
\lambda_{1} & & \\
& \lambda_{2} & \\
& & \lambda_{3}
\end{array}\right)=\left(\sum_{i, j=1}^{3} T_{s i} T_{t j} r_{i j}\right)_{s t}
$$

Thus, we have, when $s \neq t$

$$
\begin{align*}
& \sum_{i, j=1}^{3} T_{s i} T_{t j} r_{i j}  \tag{2.4}\\
= & T_{s 1} T_{t 1} r_{11}+T_{s 2} T_{t 2} r_{22}+T_{s 3} T_{t 3} r_{33}+2 T_{s 3} T_{t 1} r_{31}+2 T_{s 1} T_{t 2} r_{12}+2 T_{s 3} T_{t 2} r_{32}=0
\end{align*}
$$

Now for

$$
\left(S_{2}^{i j}\left(r_{i j}\right)\right)=\left(\begin{array}{ccc}
r_{22}+r_{33} & -r_{21} & -r_{31} \\
-r_{12} & r_{11}+r_{33} & -r_{31} \\
-r_{13} & -r_{23} & r_{11}+r_{22}
\end{array}\right)
$$

we have

$$
\left(T_{i j}\right)\left(r_{i j}\right)^{t}\left(T_{i j}\right)=\left(\sum_{i, j=1}^{3} T_{s i} T_{t j} S_{2}^{i j}\right)_{s t}
$$

If we could prove that $\sum_{i, j=1}^{3}\left(T_{s i} T_{t j} S_{2}^{i j}\right)_{s t}$ is a diagonal matrix, our proof was done.
Indeed, when $s \neq t$, we have

$$
\begin{align*}
& \sum_{i, j=1}^{3} T_{s i} T_{t j} S_{2}^{i j}  \tag{2.5}\\
= & T_{s 1} T_{t 1}\left(r_{22}+r_{33}\right)+T_{s 2} T_{t 2}\left(r_{11}+r_{33}\right)+T_{s 3} T_{t 3}\left(r_{11}+r_{22}\right) \\
& -2 T_{s 1} T_{t 2} r_{12}-2 T_{s 3} T_{t 1} r_{31}-2 T_{s 3} T_{t 2} r_{32}
\end{align*}
$$

By (2.4) and (2.3), (2.5) can be

$$
\sum_{i, j=1}^{3} T_{s i} T_{t j} S_{2}^{i j}=\sum_{i, j=1}^{3} T_{s i} T_{t j}\left(r_{11}+r_{22}+r_{33}\right)=0
$$

When $\varepsilon=0, S_{2}^{i j}[r(w)]$ and $\left(r_{i j}(w)\right)$ are diagonal, thus, $T$ can be the identity matrix $I d$.
From the view above, when $k=2$ and $f<0$, the corresponding Hessian operator is possible to be uniformly elliptic. In this paper, we will study some uniformly elliptic 2-Hessian equations which have non-positive right-hand functions $f$.

## 3. Existence of $C^{\infty}$ local Solutions for uniformly elliptic case

From now on, we fixed $n=3, k=2$, by a translation $y \longrightarrow y-y_{0}$ and replacing $u$ by $u-u(0)-y \cdot D u(0)$, we can assume $Z_{0}=(0,0,0)$ in Theorem 1.1. We prove now the following results,

Theorem 3.1. Let $f \in C^{\infty}$ and $f\left(Z_{0}\right)=0$ for $Z_{0}=(0,0,0) \in \Omega \times \mathbb{R} \times \mathbb{R}^{3}$. Then (1.3) admits a 1-convex local solution $u \in C^{\infty}$ which is not 3-convex and is of the following form

$$
\begin{equation*}
u(y)=\frac{1}{2} \sum_{i=1}^{3} \tau_{i} y_{i}^{2}+\varepsilon^{5} w\left(\varepsilon^{-2} y\right), \quad \forall\left(\tau_{1}, \tau_{2}, \tau_{3}\right) \in \mathbf{P}_{2} \tag{3.1}
\end{equation*}
$$

in the neighborhood of $y_{0}=0,\|w\|_{C^{4, \alpha}} \leq 1$ and $\varepsilon>0$ very small.

If $f$ is nonnegative near $Z_{0}$, then (1.3) admits a 2-convex local solution $u \in C^{\infty}$ which is not 3-convex. If $f\left(Z_{0}\right)>0$, then (1.3) admits a 3-convex local solution $u \in C^{\infty}$.

Moreover, the equation (1.3) is uniformly elliptic with respect to the solution (3.1).
Remark that, in Theorem 3.1 the function $f$ is permitted to change sign. It is well known that, for Monge-Ampere operator, the type of equation is determined by the sign of $f(y, u, D u)$, it is elliptic if $f>0$, hyperbolic if $f<0$ and degenerate elliptic or hyperbolic if $f$ vanishes; it is of mixed type if $f$ changes sign [4]. So that Theorem 3.1 never occurs in Monge-Ampére case.

Theorem 3.1 is exactly the part (1) and (2) of Theorem 1.1.
Let $\tau=\left(\tau_{1}, \tau_{2}, \tau_{3}\right) \in \mathbf{P}_{2}$, then $\psi(y)=\frac{1}{2} \sum_{i=1}^{3} \tau_{i} y_{i}^{2}$ is a polynomial-type solution of

$$
S_{2}[\psi]=0,
$$

we follow Lin [8] to introduce the following function

We follows now the idea of Hong and Zuily [5] to prove the existence and a priori estimates of solution for linearized operator. In our case, although $L_{G}(w)$ is uniformly elliptic, the existence and a priori Schauder estimates of classical solutions are not directly obtainable, because we do not know whether the coefficient $a$ of $a u$ in (3.3) is non-positive. If we can prove the existence (Lemma 3.3), we can employ Nash-Moser procedure to prove the existence of local solution for (1.3) in Hölder space rather than Sobolev space. One goal is to see how the procedure depends on the condition $\left\|w_{k}\right\|_{C^{4, \alpha}} \leq A$. We shall use the following schema:

It is pointed out on page 107, [3] that, if the operator $L_{G}$ does not satisfy the condition $a \leq 0$, as is well known from simple examples, the Dirichlet problem for $L_{G}(w) \rho=g$ no longer has a solution in general. Notice $a$ in (3.9) has the factor $\varepsilon^{4}$, we will take advantage of smallness of $a$ to obtain the uniqueness and existence of solution for Dirichlet problem (3.9) and then uniformly Schauder estimates of its solution follows.

When we regard $\tilde{f}_{\varepsilon}$ as a function of variable $x$, usually $\|f\|_{C^{3, \alpha}}$ is denoted as $\|f\|_{C^{3, \alpha}\left(B_{1}(0)\right)}$, but it maybe cause confusion because it must be involved in $D^{\alpha} w, 0 \leq|\alpha| \leq 3$ as above. Therefore, here and after, we denote the norm as $\left\|\tilde{f}_{\varepsilon}\right\|_{C^{3}},\left\|\tilde{f}_{\varepsilon}\right\|_{C^{3, \alpha}}$ as above, by dropping $B_{1}(0)$.
Proof. Let the constant $\mu(\tau)=\inf \left\{\frac{\partial \sigma_{2}(\lambda(r(w)))}{\partial \lambda_{i}}:\|w\|_{C^{4, \alpha}\left(B_{1}(0)\right)} \leq A, i=1,2,3,\right\}$. If we choose $\varepsilon_{0}>0$ small (the smallness of $a$ ), then $C_{1}>\frac{1}{2}$ uniformly for $0<\varepsilon<\varepsilon_{0}$. Applying Corollary 3.8 [3] to the solution $\rho$ to Dirichlet problem (3.9), we have

With the existence and uniqueness at hand, we can apply Theorem 6.19 [3] to obtain higher regularity up to boundary for solution to (3.9). Besides this, we have the Schauder estimates (see Problem 6.2, [3])

Firstly, Since the first two derivatives of $w$ have come into the principal coefficients $\frac{\partial S_{2}(r(w))}{\partial r_{i j}}$, then their $C^{2+\alpha}$-norms must be involved in $\|w\|_{C^{4, \alpha}}$, and at last $\|w\|_{C^{4, \alpha}} \leq A$ arise into $C$. Similarly, by virtue of the coefficients $a_{i}$ and $a,\|f\|_{C^{3, \alpha}}$ and $\|w\|_{C^{3, \alpha}} \leq A$ must arise into $C$. Secondly, it depends on uniform ellipticity, that is, on

It follows from standard elliptic theory (see Theorem 6.17, [3] and Remark 2, [1]) and an iteration argument that we obtain.

\mathcal{L}_{u}=\sum_{i, j=1}^{3} \frac{\partial S_{2}\left(u_{i j}\right)}{\partial r_{i j}} \partial_{i j}^{2}-\sum_{i=1}^{3} \frac{\partial f}{\partial p_{i}}(y, u(y), D u(y)) \partial_{i}-\frac{\partial f}{\partial z}(y, u(y), D u(y))
$$

is uniformly elliptic, then $u \in C^{\infty}(\Omega)$.
Proof. Let $v$ be a function on $\Omega$ and denote by $e_{l}, l=1,2,3$ the unit coordinate vector in the $y_{l}$ direction. We define the difference quotient of $v$ at $y$ in the direction $e_{l}$ by

$$
\Delta^{h} v(y)=\Delta_{l}^{h} v(y)=\frac{v\left(y+h e_{l}\right)-v(y)}{h}
$$

Since

$$
\begin{aligned}
& S_{2}\left(u_{i j}\left(y+h e_{l}\right)\right)-S_{2}\left(u_{i j}(y)\right) \\
= & \int_{0}^{1} \frac{d}{d t}\left[S_{2}\left(t u_{i j}\left(y+h e_{l}\right)+(1-t) u_{i j}(y)\right)\right] d t \\
= & \sum_{i, j=1}^{3} \int_{0}^{1} \frac{\partial}{\partial r_{i j}}\left[S_{2}\left(t u_{i j}\left(y+h e_{l}\right)+(1-t) u_{i j}(y)\right)\right] d t\left[u_{i j}\left(y+h e_{l}\right)-u_{i j}(y)\right] \\
\equiv & \sum_{i, j=1}^{3} a_{i j}(y)\left[u_{i j}\left(y+h e_{l}\right)-u_{i j}(y)\right]
\end{aligned}
$$

and Taylor expansion give

$$
\begin{aligned}
& f\left(y+h e_{l}, u\left(y+h e_{l}\right), D u\left(y+h e_{l}\right)\right)-f(y, u(y), D u(y)) \\
= & \sum_{i=1}^{3} b_{i}(y)\left[u_{i}\left(y+h e_{l}\right)-u_{i}(y)\right]+c(y)\left[u\left(y+h e_{l}\right)-u(y)\right]+g(y) h
\end{aligned}
$$

with

$$
\begin{aligned}
b_{i}(y) & =\int_{0}^{1} \frac{\partial f}{\partial p_{i}}\left(t\left(y+h e_{l}\right)+(1-t) y, t u\left(y+h e_{l}\right)+(1-t) u(y), t D u\left(y+h e_{l}\right)+(1-t) D(y)\right) d t \\
c(y) & =\int_{0}^{1} \frac{\partial f}{\partial z}\left(t\left(y+h e_{l}\right)+(1-t) y, t u\left(y+h e_{l}\right)+(1-t) u(y), t D u\left(y+h e_{l}\right)+(1-t) D(y)\right) d t \\
g(y) & =\int_{0}^{1} \frac{\partial f}{\partial y_{l}}\left(t\left(y+h e_{l}\right)+(1-t) y, t u\left(y+h e_{l}\right)+(1-t) u(y), t D u\left(y+h e_{l}\right)+(1-t) D(y)\right) d t
\end{aligned}
$$

Taking the difference quotients of both sides of the equation

$$
S_{2}\left(u_{i j}(y)\right)=f(y, u, D u),
$$

we have

$$
\sum_{i, j=1}^{3} a_{i j}(y) \partial_{i} \partial_{j} \Delta^{h} u(y)-\sum_{i=1}^{3} b_{i}(y) \partial_{i} \Delta^{h} u(y)-c(y) \Delta^{h} u(y)=g(y)
$$

Since $u \in C^{2, \alpha}(\Omega)$, then all the coefficients $a_{i j}, b_{i}, c$ and inhomogeneous term $g$ are in $C^{\alpha}(\Omega)$, from the interior estimates of Corollary 6.3 in [3], we can infer

$$
\Delta^{h} u \in C^{2, \alpha}(\Omega)
$$

Letting $h \rightarrow 0$, we see $\partial_{l} u \in C^{2, \alpha}(\Omega), l=1,2,3$ and

$$
\sum_{i, j=1}^{3} \frac{\partial S_{2}\left(D^{2} u\right)}{\partial r_{i j}} \partial_{i} \partial_{j}\left(\partial_{l} u\right)-\sum_{i=1}^{3} \frac{\partial f}{\partial p_{i}} \partial_{i}\left(\partial_{l} u\right)-\frac{\partial f}{\partial z}\left(\partial_{l} u\right)=\frac{\partial f}{\partial y_{l}}
$$

Repeating the above proof, we obtain $u \in C^{\infty}(\Omega)$.
Using above Lemma 3.3, we can use the procedure (3.6) to construct the sequence $\left\{w_{m}\right\}_{m \in \mathbb{N}}$. Now we study the convergence of $\left\{w_{m}\right\}_{m \in \mathbb{N}}$ and that of $\left\{g_{m}\right\}_{m \in \mathbb{N}}$.

Proposition 3.5. Let $\left\{w_{m}\right\}_{m \in \mathbb{N}}$ and $\left\{g_{m}\right\}_{m \in \mathbb{N}}$ the sequence in (3.6). Suppose that $\left\|w_{j}\right\|_{C^{4, \pi}} \leq A$ for $j=1,2, \ldots, k$. Then we have

$$
\begin{equation*}
\left\|g_{k+1}\right\|_{C^{2, \alpha}} \leq C\left[\left\|g_{k}\right\|_{C^{2, \alpha}}^{2}+\left\|g_{k}\right\|_{C^{2, \alpha}}^{3}\right], \tag{3.13}
\end{equation*}
$$

where $C$ is some positive constant depends only on $\tau, A$ and $\|f\|_{C^{4, \alpha}}$. In particular, $C$ is independent of $k$.

Proof. Applying Taylor's expansion with integral-typed remainder to (3.2), we have

$$
\begin{aligned}
-g_{k+1} & =G\left(w_{k}+\rho_{k}\right)=G\left(w_{k}\right)+L_{G}\left(w_{k}\right) \rho_{k}+Q\left(w_{k}, \rho_{k}\right) \\
& =-g_{k}+L_{G}\left(w_{k}\right) \rho_{k}+Q\left(w_{k}, \rho_{k}\right)=Q\left(w_{k}, \rho_{k}\right)
\end{aligned}
$$

where $Q_{k}$ is the quadratic error of $G$ which consists of $S_{2}$ and $f$.

$$
\begin{aligned}
Q\left(w_{k}, \rho_{k}\right)= & \sum_{i j, s t} \frac{1}{\varepsilon} \int(1-\mu) \frac{\partial^{2} S_{2}\left(w_{k}+\mu \rho_{k}\right)}{\partial w_{i j} \partial w_{s t}} d \mu\left(\rho_{k}\right)_{i j}\left(\rho_{k}\right)_{s t} \\
& +\sum_{i, j} \frac{1}{\varepsilon} \int(1-\mu) \frac{\partial^{2} \tilde{f}_{\varepsilon}\left(w_{k}+\mu \rho_{k}\right)}{\partial w_{i} \partial w_{j}} d \mu\left(\rho_{k}\right)_{i}\left(\rho_{k}\right)_{j} \\
& +\frac{1}{\varepsilon} \sum_{i} \int(1-\mu) \frac{\partial^{2} \tilde{f}_{\varepsilon}\left(w_{k}+\mu \rho_{k}\right)}{\partial w \partial w_{i}} d \mu\left(\rho_{k}\right)_{i}\left(\rho_{k}\right) \\
& +\frac{1}{\varepsilon} \int(1-\mu) \frac{\partial^{2} \tilde{f}_{\varepsilon}\left(w_{k}+\mu \rho_{k}\right)}{\partial w^{2}} d \mu \cdot \rho_{k}^{2} \\
& =I_{1}+I_{2}+I_{3}+I_{4}
\end{aligned}
$$

Since $S_{2}((r(w)))$ is a second-order homogeneous polynomial with variable $r_{i j}(r(w))$ and $\tilde{f}_{\varepsilon}(x, w, D w)$ is independent of $r_{i j}$, we see that

$$
\begin{gathered}
\left|\frac{\partial^{2} S_{2}\left(w_{k}+\mu \rho_{k}\right)}{\partial w_{i j} w_{s t}}\right|=\frac{\partial^{2} S_{2}}{\partial w_{i j} \partial w_{s t}}\left(\delta_{i}^{j} \tau_{i}+\varepsilon\left(w_{k}+\mu \rho_{k}\right)_{i j}\right)=\varepsilon^{2} \quad \text { or } \quad 0, \\
\left|\frac{\partial^{2} \tilde{f}_{\varepsilon}\left(w_{k}+\mu \rho_{k}\right)}{\partial w_{i} \partial w_{j}}\right|=\left|\frac{\partial^{2}\left[f\left(\varepsilon x, \varepsilon^{4} \psi+\varepsilon^{5}\left(w_{k}+\mu \rho_{k}\right), \varepsilon^{3} D \psi+\varepsilon^{3} D\left(w_{k}+\mu \rho_{k}\right)\right)\right]}{\partial w_{i} \partial w_{j}}\right| \leq \varepsilon^{6} \cdot\|f\|_{C^{2}},
\end{gathered}
$$

$$
\begin{aligned}
& \left|\frac{\partial^{2} \tilde{f}_{\varepsilon}\left(w_{k}+\mu \rho_{k}\right)}{\partial w \partial w_{i}}\right|=\left|\frac{\partial^{2}\left[f\left(\varepsilon x, \varepsilon^{4} \psi+\varepsilon^{5}\left(w_{k}+\mu \rho_{k}\right), \varepsilon^{3} D \psi+\varepsilon^{3} D\left(w_{k}+\mu \rho_{k}\right)\right]\right]}{\partial w \partial w_{i}}\right| \leq \varepsilon^{8}\|f\|_{C^{2}}, \\
& \left|\frac{\partial^{2} \tilde{f}\left(w_{k}+\mu \rho_{k}\right)}{\partial w^{2}}\right|=\left|\frac{\partial^{2}\left[f\left(\varepsilon x, \varepsilon^{4} \psi+\varepsilon^{5}\left(w_{k}+\mu \rho_{k}\right), \varepsilon^{3} D \psi+\varepsilon^{3} D\left(w_{k}+\mu \rho_{k}\right)\right)\right]}{\partial w^{2}}\right|=\varepsilon^{10}\|f\|_{c^{2}} .
\end{aligned}
$$

Thus, $I_{i}(1 \leq i \leq 4)$ in $Q_{k}$ are under control by $O(\varepsilon), O\left(\varepsilon^{5}\right), O\left(\varepsilon^{7}\right)$ and $O\left(\varepsilon^{9}\right)$, repectively. Therefore

$$
\left\|I_{1}\right\|_{C_{2, a}} \leq C\left\|\rho_{k}\right\|_{C^{2}}\left\|\rho_{k}\right\|_{C^{4}, a}
$$

and

$$
\begin{aligned}
& \left\|I_{2}\right\| C_{C^{2, \alpha}} \leq C\|f\|_{C^{4, \alpha}}\left(\left\|w_{k}\right\|\left\|_{C^{3, \alpha}}+\right\| \rho_{k} \| C_{C^{3, \alpha}}\right)\left\|\rho_{k}\right\|_{C^{1}}^{2}+\left.C\|f\|_{C^{2}}\left\|\rho_{k}\right\|\right|_{C^{3, \alpha}}\left\|\rho_{k}\right\| \|_{C^{1}} \\
& \leq C\left\|\rho_{k}\right\|\left\|_{C^{3},}\right\| \rho_{k}\left\|_{C^{1}}^{2}+C\right\| \rho_{k}\left\|_{C^{1}}^{2}+C\right\| \rho_{k}\left\|C_{C^{3}, x}\right\| \rho_{k} \| C_{C^{1}}
\end{aligned}
$$

where $C$ depends on $A$ and $\|f\|_{C^{4, \alpha}}$. And $\left\|I_{3}\right\|_{C^{2}, \alpha}$ and $\left\|I_{4}\right\|_{C^{2, \alpha}}$ can be estimated similarly. Accordingly,

$$
\begin{aligned}
&\left\|g_{k+1}\right\| C_{C^{2, \alpha}}=\left\|Q\left(w_{k}, \rho_{k}\right)\right\|_{C^{2, \alpha}} \leq \sum_{i=1}^{4}\left\|I_{i}\right\|_{C^{2, \alpha}} \\
& \quad \leq C\left\|\rho_{k}\right\|\left\|_{C^{2}}\right\| \rho_{k}\| \|_{C^{4, \alpha}}+C\left\|\rho_{k}\right\|\left\|_{C^{3, \alpha}}\right\| \rho_{k}\left\|_{C^{1}}^{2}+\right\| \rho_{k}\left\|_{C^{1}}^{2}+C\right\| \rho_{k}\left\|_{C^{3, \alpha}}\right\| \rho_{k} \|_{C^{1}}
\end{aligned}
$$

where $C$ is independent of $k$ but dependent of $A$ and $\|f\|_{c^{4, \alpha}}$. Thus, by the interpolation inequalities, we have

$$
\left\|g_{k+1}\right\|\left\|_{C^{2, a}} \leq C\right\| \rho_{k}\left\|_{C^{4, \alpha}}^{2}+C\right\| \rho_{k} \|_{C^{4, a}}^{3},
$$

where $C$ is independent of $k$. By Schauder estimates of Lemma 3.3, we have

$$
\left\|\rho_{k}\right\|_{C^{4, a}} \leq C\left\|g_{k}\right\|_{C^{2},} .
$$

Combining the estimates above, we obtain (3.13). Proof is done.
Since $C$ is independent of $k$, more exactly, $A, \tau$ and $\|f\|_{C^{4, \alpha}}$ are independent of $k$. So here and after, we can assume $A=1$.

## Proof of Theorem 3.1. Set

$$
\begin{equation*}
d_{k+1}=C\left\|g_{k+1}\right\|_{C^{2, \alpha}} . \tag{3.14}
\end{equation*}
$$

By (3.13) with letting $C \geq 1$ we have

$$
d_{k+1} \leq d_{k}^{2}+d_{k}^{3}
$$

Take $\tau \in \mathbb{R}^{3}$ as in Lemmas 2.2 and 2.3 such that $\sigma_{2}(\tau)=f(0,0,0)$, we have

$$
\begin{aligned}
g_{0}(x)= & \frac{1}{\varepsilon}\left(\sigma_{2}(\tau)-f\left(\varepsilon^{2} x, \varepsilon^{4} \psi(x), \varepsilon^{2}\left(\tau_{1} x_{1}, \tau_{2} x_{2}, \tau_{3} x_{3}\right)\right)\right) \\
= & \frac{1}{\varepsilon}\left[\sigma_{2}(\tau)-f(0,0,0)\right] \\
& +\varepsilon \int_{0}^{1} x \cdot\left(\partial_{y} f\right)\left(t \varepsilon^{2} x, t \varepsilon^{4} \psi(x), t \varepsilon^{2}\left(\tau_{1} x_{1}, \tau_{2} x_{2}, \tau_{3} x_{3}\right)\right) d t \\
& +\varepsilon^{3} \int_{0}^{1} \psi(x)\left(\partial_{2} f\right)\left(t \varepsilon^{2} x, t \varepsilon^{4} \psi(x), t \varepsilon^{2}\left(\tau_{1} x_{1}, \tau_{2} x_{2}, \tau_{3} x_{3}\right)\right) d t \\
& +\varepsilon \int_{0}^{1}\left(\tau_{1} x_{1}, \tau_{2} x_{2}, \tau_{3} x_{3}\right) \cdot\left(\partial_{p} f\right)\left(t \varepsilon^{2} x, t \varepsilon^{4} \psi(x), t \varepsilon^{2}\left(\tau_{1} x_{1}, \tau_{2} x_{2}, \tau_{3} x_{3}\right)\right) d t,
\end{aligned}
$$

then

$$
\left\|g_{0}\right\|_{C^{2, \alpha}\left(B_{1}(0)\right)} \leq \varepsilon C_{1}\|f\|_{C^{3, \alpha}} .
$$

We can choose $0<\varepsilon \leq \varepsilon_{0}$ so small such that

$$
C\left\|g_{0}\right\|_{C^{2, \alpha}\left(B_{1}(0)\right)} \leq 1 / 4, \quad 0<\varepsilon \leq \varepsilon_{0}
$$

Notice $\varepsilon_{0}$ is independent of $k$. Since $d_{0}=C\left\|g_{0}\right\|_{C^{2, \alpha}}$, we have $d_{1} \leq 2 d_{0}^{2}$ and, by induction,

$$
d_{k+1} \leq 2^{2^{k+1}} d_{0}^{2^{k+1}} \leq(2 C)^{2^{k+1}}\left\|g_{0}\right\|_{C^{2, \alpha}}^{2^{k+1}}
$$

Thus, by (3.14)

$$
\left\|g_{k+1}\right\|_{C^{2, \alpha}} \leq(2 C)^{2^{k+1}-1}\left\|g_{0}\right\|_{C^{2, \alpha}}^{2^{k+1}}
$$

Firstly, we claim that there exists $\varepsilon>0$, depending on $\tau$ and $\|f\|_{C^{3, \alpha}}$ such that

$$
\left\|w_{k}\right\|_{C^{4, \alpha}\left(B_{1}(0)\right)} \leq 1, \quad \forall k \geq 1
$$

Indeed, set $w_{0}=0$, we have by (3.13)

$$
\begin{aligned}
\left\|w_{k+1}\right\|_{C^{4, \alpha}\left(B_{1}(0)\right)} & =\left\|\sum_{i=0}^{k} \rho_{i}\right\|_{C^{4, \alpha}\left(B_{1}(0)\right)} \leq \sum_{i=0}^{k}\left\|\rho_{i}\right\|_{C^{4, \alpha}\left(B_{1}(0)\right)} \\
& \leq \sum_{i=0}^{k} C\left\|g_{i}\right\|_{C^{2, \alpha}\left(B_{1}(0)\right)} \leq \sum_{i=0}^{k}\left(2 C\left\|g_{0}\right\|_{C^{2, \alpha}\left(B_{1}(0)\right)}\right)^{2^{i}}
\end{aligned}
$$

where $C$ is defined in Lemma 3.5. Thus, for any $k$,

$$
\left\|w_{k+1}\right\|_{C^{4, \alpha}\left(B_{1}(0)\right)} \leq \sum_{i=0}^{\infty}\left(C\left\|g_{0}\right\|_{C^{2, \alpha}\left(B_{1}(0)\right)}\right)^{2^{i}} \leq \sum_{i=0}^{\infty} 2^{-2^{i}} \leq 1 .
$$

Then, by Azelà-Ascoli Theorem, we have

$$
w_{k} \rightarrow w \quad \text { in } C^{4}\left(\left(B_{1}(0)\right)\right)
$$

From (3.13), we see that

$$
\left\|g_{k+1}\right\|_{C^{2, \alpha}\left(B_{1}(0)\right)} \leq\left(\frac{1}{2}\right)^{2^{k}} \rightarrow 0
$$

and then $g_{m}=-G\left(w_{m}\right)$ yields

$$
G(w)=\frac{1}{\varepsilon}\left[S_{2}(r(w))-\tilde{f}(x, w, D w)\right]=0, \quad \text { on } B_{1}(0)
$$

which yields that the function

$$
u(y)=\frac{1}{2} \sum_{i=1}^{3} \tau_{i} y_{i}^{2}+\varepsilon^{5} w\left(\varepsilon^{-2} y\right) \in C^{4}\left(B_{\varepsilon^{2}}(0)\right)
$$

is a solution of

$$
S_{2}[u]=f(y, u, D u), \quad \text { on } B_{\varepsilon^{2}}(0)
$$

Now if $f(0,0,0)=0$, we take $\tau \in \mathbf{P}_{2}$, then $\sigma_{1}(\tau)>0, \sigma_{2}(\tau)=0, \sigma_{3}(\tau)<0$, and (3.5) imply,

$$
S_{j}[u]=\sigma_{j}(\lambda)=\sigma_{j}(\tau)+O(\varepsilon), \quad j=1,2,3
$$

it follows that $S_{1}[u]>0, S_{3}[u]<0$ on $B_{\varepsilon^{2}}(0)$ for small $\varepsilon>0$, that is, $u$ is 1 -convex but not convex. Moreover if $S_{2}[u]=f \geq 0$ near $Z_{0}$ and $f\left(Z_{0}\right)=0$, we see that $u$ is 2-convex by definition, but not 3-convex.

If $S_{2}[u]=f>0$ near $Z_{0}$, we take $\tau \in \mathbb{R}^{3}$ given in (2) and (3) of Lemmas 2.3, then we can get the 3-convex or non convex local solutions.

The $C^{\infty}$ regularity of solution is given by Corollary 3.4. We have then proved Theorem 3.1.

We also have the following elliptic results for negative $f$
Theorem 3.6. Let $f \in C^{\infty}, f(0,0,0)<0$. Then (1.3) admits a 1 -convex local solution $u \in C^{\infty}$ in a neighborhood of $y_{0}=0$ which is not 2 -convex, it is of the following form

$$
u(y)=\frac{1}{2} \sum_{i=1}^{3} \tau_{i} y_{i}^{2}+\varepsilon^{5} w\left(\varepsilon^{-2} y\right)
$$

and the equation (1.3) is uniformly elliptic with respect to this solution.
Proof. For $a=f(0,0,0)<0$, take $\tau \in \mathbb{R}^{3}$ as in (1) of Lemma 2.3 such that

$$
\sigma_{1}(\tau)>0, \quad \sigma_{2}(\tau)=f(0,0,0)<0
$$

and

$$
\sigma_{1,3}(\tau)>\sigma_{1,2}(\tau)>\sigma_{1,1}(\tau)>0
$$

Now the proof is exactly same as that of Theorem 3.1 except the estimate of term $g_{0}$, we use Taylor expansion,

$$
\begin{aligned}
g_{0}(x)= & -G(0)=\frac{1}{\varepsilon}\left[S_{2}(r(0))-\tilde{f}(x, 0,0)\right] \\
= & \frac{1}{\varepsilon}\left[\sigma_{2}(\tau)-f\left(\varepsilon^{2} x, \varepsilon^{4} \psi(x), \varepsilon^{2}\left(\tau_{1} x_{1}, \tau_{2} x_{2}, \tau_{3} x_{3}\right)\right)\right] \\
= & \frac{1}{\varepsilon}\left[\sigma_{2}(\tau)-f(0,0,0)\right] \\
& +\varepsilon \int_{0}^{1} x \cdot\left(\partial_{y} f\right)\left(t \varepsilon^{2} x, t \varepsilon^{4} \psi(x), t \varepsilon^{2}\left(\tau_{1} x_{1}, \tau_{2} x_{2}, \tau_{3} x_{3}\right)\right) d t \\
& +\varepsilon^{3} \int_{0}^{1} \psi(x)\left(\partial_{z} f\right)\left(t \varepsilon^{2} x, t \varepsilon^{4} \psi(x), t \varepsilon^{2}\left(\tau_{1} x_{1}, \tau_{2} x_{2}, \tau_{3} x_{3}\right)\right) d t \\
& +\varepsilon \int_{0}^{1}\left(\tau_{1} x_{1}, \tau_{2} x_{2}, \tau_{3} x_{3}\right) \cdot\left(\partial_{p} f\right)\left(t \varepsilon^{2} x, t \varepsilon^{4} \psi(x), t \varepsilon^{2}\left(\tau_{1} x_{1}, \tau_{2} x_{2}, \tau_{3} x_{3}\right)\right) d t
\end{aligned}
$$

then we can end the proof of Theorem 3.6 exactly as that of Theorem 3.1.
