# UNIQUENESS AND LONG TIME ASYMPTOTIC FOR THE PARABOLIC-PARABOLIC KELLER-SEGEL EQUATION

#### Abstract

The present paper deals with the parabolic-parabolic Keller-Segel equation in the plane in the general framework of weak (or "free energy") solutions associated to initial data with finite mass $M<8 \pi$, finite second log-moment and finite entropy. The aim of the paper is twofold: (1) We prove the uniqueness of the "free energy" solution. The proof uses a DiPerna-Lions renormalizing argument which makes possible to get the "optimal regularity" as well as an estimate of the difference of two possible solutions in the critical $L^{4 / 3}$ Lebesgue norm similarly as for the $2 d$ vorticity Navier-Stokes equation. (2) We prove a radially symmetric and polynomial weighted $H^{1} \times H^{2}$ exponential stability of the self-similar profile in the quasi parabolic-elliptic regime. The proof is based on a perturbation argument which takes advantage of the exponential stability of the self-similar profile for the parabolic-elliptic Keller-Segel equation established in [9, 14].

## 1. Introduction

The Patlak-Keller-Segel (PKS) system for chemotaxis describes the collective motion of cells that are attracted by a chemical substance that they are able to emit ([33, 22]). In this paper we are concerned with the parabolic-parabolic PKS model in the plane which takes the form

[^0]and which is complemented with an initial condition
\[

f(0, \cdot)=f_{0} \geq 0 \quad \text { and } \quad u(0, \cdot)=u_{0} \geq 0 \quad \text { in } \quad \mathbb{R}^{2} \tag{1.2}
\end{equation*}

Here $t \geq 0$ is the time variable, $x \in \mathbb{R}^{2}$ is the space variable, $f=f(t, x) \geq 0$ stands for the mass density of cells while $u=u(t, x) \geq 0$ is the chemo-attractant concentration and $\varepsilon>0, \alpha \geq 0$ are constants. We refer to [7] and the references quoted therein for biological motivation and mathematical introduction.

The two fundamental identities associated to the Keller-Segel equation (1.1) are that any solution satisfies, at least formally, the conservation of "mass"

and the "free energy-dissipation of the free energy identity"

where the free energy $\mathcal{F}(t)=\mathcal{F}(f(t), u(t)), \mathcal{F}_{0}=\mathcal{F}\left(f_{0}, u_{0}\right)$ is defined by

and the dissipation of free energy $\mathcal{D}_{\mathcal{F}}(s)=\mathcal{D}_{\mathcal{F}}(f(s), u(s))$ by

\mathcal{D}_{\mathcal{F}}=\mathcal{D}_{\mathcal{F}}(f, u):=\int_{\mathbb{R}^{2}} f|\nabla(\log f)-\nabla u|^{2} d x+\frac{1}{\varepsilon} \int_{\mathbb{R}^{2}}|\Delta u+f-\alpha u|^{2} d x \tag{1.6}
\end{equation*}

Following [7], throughout this paper, we shall assume that the initial data $\left(f_{0}, u_{0}\right)$ satisfy

$$
\begin{cases}f_{0}\left(1+\log \langle x\rangle^{2}\right) \in L^{1}\left(\mathbb{R}^{2}\right) \quad \text { and } \quad f_{0} \log f_{0} \in L^{1}\left(\mathbb{R}^{2}\right)  \tag{1.7}\\ u_{0} \in H^{1}\left(\mathbb{R}^{2}\right) \text { if } \alpha>0 \quad \text { or } \quad u_{0} \in L^{1}\left(\mathbb{R}^{2}\right) \cap \dot{H}^{1}\left(\mathbb{R}^{2}\right) \text { if } \alpha=0 \\ f_{0} u_{0} \in L^{1}\left(\mathbb{R}^{2}\right) & \end{cases}
$$

where here and below we define the weight function $\langle x\rangle:=\left(1+|x|^{2}\right)^{1 / 2}$ and the homogeneous Sobolev space $\dot{H}^{1}\left(\mathbb{R}^{2}\right)$ is defined by $\dot{H}^{1}\left(\mathbb{R}^{2}\right):=\left\{u \in L_{l o c}^{1}\left(\mathbb{R}^{2}\right) ; \nabla u \in L^{2}\left(\mathbb{R}^{2}\right)\right\}$. We also make the important restriction of subcritical mass hypothesis

M:=\left\langle f_{0}\right\rangle \in(0,8 \pi)
$$

because a suitable global existence theory is available in that case (see [7, 29]) and that there exists blow up (not global in time) solution when $M>8 \pi$ (see [19, 31, 30] and the discussion in [29, 1. Introduction]). We also refer to $[4,12]$ where a global existence theory is developed in the possible supercritical case $M>8 \pi$ and the condition that $\varepsilon$ is large enough (which corresponds to a case where the nonlinearity in (1.1) is small).

As in [7], we consider the following definition of weak solution.
Definition 1.1. For any initial datum $\left(f_{0}, u_{0}\right)$ satisfying (1.7) with $M<8 \pi$, we say that the couple $(f, u)$ of nonnegative functions satisfying

& \begin{cases}u \in L^{\infty}\left(0, T ; H^{1}\left(\mathbb{R}^{2}\right)\right) & \text { if } \alpha>0 ; \\
u \in L^{\infty}\left(0, T ; L^{1}\left(\mathbb{R}^{2}\right) \cap \dot{H}^{1}\left(\mathbb{R}^{2}\right)\right) & \text { if } \alpha=0 ;\end{cases}  \tag{1.8}\\
& f u \in L^{\infty}\left(0, T ; L^{1}\left(\mathbb{R}^{2}\right)\right)
\end{align*}
$$

is a global in time weak solution to the Keller-Segel equation associated to the initial condition $\left(f_{0}, u_{0}\right)$ whenever $(f, u)$ satisfies the mass conservation (1.3), the bound

$$
\begin{equation*}
\sup _{[0, T]} \mathcal{F}(t)+\sup _{[0, T]} \int_{\mathbb{R}^{2}} f \log \langle x\rangle^{2} d x+\int_{0}^{T} \mathcal{D}_{\mathcal{F}}(t) d t \leq C_{T} \tag{1.9}
\end{equation*}
$$

as well as the Keller-Segel system of equations (1.1)-(1.2) in the distributional sense, namely

\int_{\mathbb{R}^{2}} f_{0}(x) \varphi(0, x) d x & =\int_{0}^{T} \int_{\mathbb{R}^{2}} f\left\{\left(\nabla_{x}(\log f)-\nabla_{x} u\right) \cdot \nabla_{x} \varphi-\partial_{t} \varphi\right\} d x d t  \tag{1.10}\\
\varepsilon \int_{\mathbb{R}^{2}} u_{0}(x) \psi(0, x) d x & =\int_{0}^{T} \int_{\mathbb{R}^{2}}\left\{u\left(-\Delta \psi+\alpha \psi-\varepsilon \partial_{t} \psi\right)-f(t, x) \psi\right\} d x d t, \tag{1.11}
\end{align*}
$$

for any $T>0$ and $\varphi, \psi \in C_{c}^{2}\left([0, T) \times \mathbb{R}^{2}\right)$.
It is worth emphasizing that thanks to the Cauchy-Schwarz inequality, we have

$$
\int_{\mathbb{R}^{2}} f\left|\nabla_{x}(\log f)-\nabla_{x} u\right| d x \leq M^{1 / 2} \mathcal{D}_{\mathcal{F}}^{1 / 2}
$$

and the RHS of (1.10) is then well defined thanks to (1.3) and (1.9).
This framework is well adapted for a global existence theory in the subcritical mass case.
Theorem 1.2. ([7, Theorem 1]) For any initial datum $\left(f_{0}, u_{0}\right)$ satisfying (1.7) and $M<8 \pi$, there exists at least one global in time weak solution in the sense of Definition 1.1 to the Keller-Segel equation (1.1)-(1.2).

Our first main result establishes that this framework is also well adapted for the well-posedness issue.

Theorem 1.3. For any initial datum $\left(f_{0}, u_{0}\right)$ satisfying (1.7) with $M<8 \pi$, there exists at most one weak solution in the sense of Definition 1.1 to the Keller-Segel equation (1.1)-(1.2). This one is furthermore a classical solution in the sense that

f, u \in C_{b}^{2}\left((0, \infty) \times \mathbb{R}^{2}\right) \tag{1.12}
\end{equation*}
$$

and satisfies the accurate small time estimate

$$
\begin{equation*}
\forall q \in[4 / 3,2), \quad t^{1-\frac{1}{q}}\|f(t)\|_{L^{q}} \rightarrow 0 \quad \text { as } \quad t \rightarrow 0 \tag{1.13}
\end{equation*}
$$

Finally, the free energy-dissipation of the free energy identity (1.4) holds.
Theorem 1.3 improves the uniqueness result proved in [11] in the class of solutions $f \in C([0, T]$; $\left.L_{2}^{1}\left(\mathbb{R}^{2}\right)\right) \cap L^{\infty}\left((0, T) \times \mathbb{R}^{2}\right)$ which can be built under the additional assumption $f_{0} \in L^{\infty}\left(\mathbb{R}^{2}\right)$ (see also [17] where a uniqueness result is established for a related model and the recent works $[15,4,12]$ where the well-posedness is proved in some particular regimes). Our proof follows a strategy introduced in [16] for the 2D viscous vortex model and generalize a similar result obtained in [14] for the parabolic-elliptic model (which corresponds to the case $\varepsilon=0$ ). It is based on a DiPerna-Lions renormalization process (see [13]) which makes possible to get the optimal regularity of solutions for small time (1.13) and then to follow the uniqueness argument introduced by BenArtzi for the 2D viscous vortex model (see [2, 6]). It is worth emphasizing that such an argument is also related to Kato's work on the Navier-Stokes equation (see e.g. [21]).

From now on in this introduction, we definitively restrict ourselves to the case $\alpha=0$ and we focus on the long time asymptotic of the solutions. For that last purpose it is convenient to work with self-similar variables. We introduce the rescaled functions $g$ and $v$ defined by

with $R(t):=(1+t)^{1 / 2}$. For these new unknowns, the rescaled parabolic-parabolic Keller-Segel system reads

& \partial_{t} g=\Delta g+\nabla\left(\frac{1}{2} x g-g \nabla v\right) \quad \text { in } \quad(0, \infty) \times \mathbb{R}^{2},  \tag{1.15}\\
& \varepsilon \partial_{t} v=\Delta v+g+\frac{\varepsilon}{2} x \cdot \nabla v \quad \text { in } \quad(0, \infty) \times \mathbb{R}^{2} \tag{1.16}
\end{align*}
$$

We are interested in self-similar solutions to the Keller-Segel parabolic-parabolic equation (1.1), that is solutions which write as

$$
f(t, x)=\frac{1}{t} G_{\varepsilon}\left(\frac{x}{t^{1 / 2}}\right), \quad u(t, x)=V_{\varepsilon}\left(\frac{x}{t^{1 / 2}}\right)
$$

with

$$
\begin{equation*}
\int_{\mathbb{R}^{2}} f(t, x) d x=\int_{\mathbb{R}^{2}} G_{\varepsilon}(y) d y=M \in(0,8 \pi) \tag{1.17}
\end{equation*}
$$

Such a couple of functions $(f, u)$ is a solution to (1.1) if, and only if, the associated "self-similar profile" $\left(G_{\varepsilon}, V_{\varepsilon}\right)$ satisfies the elliptic system

$$
\begin{align*}
& \Delta G_{\varepsilon}-\nabla\left(G_{\varepsilon} \nabla V_{\varepsilon}-\frac{1}{2} x G_{\varepsilon}\right)=0 \quad \text { in } \quad \mathbb{R}^{2}  \tag{1.18}\\
& \Delta V_{\varepsilon}+\frac{\varepsilon}{2} x \cdot \nabla V_{\varepsilon}+G_{\varepsilon}=0 \quad \text { in } \quad \mathbb{R}^{2}
\end{align*}
$$

and thus corresponds to a stationary solution to the rescaled parabolic-parabolic Keller-Segel system (1.15). It is known that, for any $\varepsilon \in(0,1 / 2)$ and any $M \in(0,8 \pi)$, there exists a unique solution $\left(G_{\varepsilon}, V_{\varepsilon}\right)$ to (1.18) such that the mass of $G_{\varepsilon}$ equals $M$, and which is furthermore radially symmetric and smooth (say $C^{2}\left(\mathbb{R}^{2}\right)$ ), see $[32,3,12]$.

Our second main result concerns the exponential nonlinear stability of the self-similar profile for any given mass $M \in(0,8 \pi)$ under the strong restriction of radial symmetry and closeness to the parabolic-elliptic regime. We define the norm

where the weighted Lebesgue space $L_{k}^{p}\left(\mathbb{R}^{2}\right)$, for $1 \leq p \leq \infty, k \geq 0$, is defined by

L_{k}^{p}\left(\mathbb{R}^{2}\right):=\left\{f \in L_{l o c}^{1}\left(\mathbb{R}^{2}\right) ;\|f\|_{L_{k}^{p}}:=\left\|f\langle x\rangle^{k}\right\|_{L^{p}}<\infty\right\}
$$

and the norm of the higher-order Sobolev spaces $W_{k}^{\ell, p}\left(\mathbb{R}^{2}\right)$ is defined by

\|f\|_{W_{k}^{\ell, p}}^{p}:=\sum_{|\alpha| \leq \ell}\left\|\langle x\rangle^{k} \partial^{\alpha} f\right\|_{L^{p}}^{p}
$$

Theorem 1.4. For any given mass $M \in(0,8 \pi)$, there exist $\varepsilon^{*}>0$ and $\delta^{*}>0$ such that for any $\varepsilon \in\left(0, \varepsilon^{*}\right)$ and any radially symmetric initial datum $\left(g_{0}, v_{0}\right)$ satisfying

$$
\left\|\mid\left(g_{0}, v_{0}\right)-\left(G_{\varepsilon}, V_{\varepsilon}\right)\right\| \leq \delta^{*}, \quad \int_{\mathbb{R}^{2}} g_{0} d x=\int_{\mathbb{R}^{2}} G_{\varepsilon} d x=M
$$

the associated solution $(g, v)$ to (1.15)-(1.16) satisfies

$$
\left\|(g(t), v(t))-\left(G_{\varepsilon}, V_{\varepsilon}\right)\right\| \leq C_{a} e^{a t} \quad \forall a \in(-1 / 2, \infty), \forall t \geq 0
$$

for some constant $C_{a}=C_{a}\left(g_{0}, v_{0}\right)$.
Coming back to the original unknowns $(f, u)$, this theorem asserts that

$$
f(t, x) \sim \frac{1}{t} G_{\varepsilon}\left(\frac{x}{t^{1 / 2}}\right), \quad u(t, x) \sim V_{\varepsilon}\left(\frac{x}{t^{1 / 2}}\right), \quad \text { as } \quad t \rightarrow \infty
$$

That result extends to the parabolic-parabolic Keller-Segel equation similar results known on the parabolic-elliptic Keller-Segel equation, see [14]. To our knowledge, Theorem 1.4 is the first exponential stability result for the system (1.1) even under the two strong restrictions of radial symmetry and quasi parabolic-elliptic regime (we mean $\varepsilon>0$ small). However, we refer again to the recent work [12, Section 4] where some results of convergence (without rate) of some solutions to the associated self-similar profile are established. We also refer to that work for further discussion and additional references. We finally refer to [37] where an exponential convergence to the equilibrium for a somehow similar chemotaxis model is established.

Let us end the introduction by describing the plan of the paper. In Section 2 we present some functional inequalities which will be useful in the sequel of the paper and we establish several
a posteriori bounds satisfied by any weak solution. Section 3 is dedicated to the proof of the uniqueness result stated in Theorem 1.3. In Section 4, we prove the exponential stability of the linearized problem associated to (1.15)-(1.16). Finally, in Section 5, we prove the long-time behaviour result as stated in Theorem 1.4.

## 2. Local in time a priori and a posteriori estimates

2.1. A priori estimates. In this short paragraph, we follow [7] and we explain how to obtain the basic estimates which lead to the notion of weak solution as presented in Definition 1.1. We first observe that the following space logarithmic moment control holds true

\frac{d}{d t} \int_{\mathbb{R}^{2}} f(-\log H) d x & =\int_{\mathbb{R}^{2}} f \nabla(\log f-u) \cdot \nabla(\log H) d x \\
& \leq \frac{\delta}{2} \mathcal{D}_{\mathcal{F}}(f, u)+\frac{1}{2 \delta} \int_{\mathbb{R}^{2}} f|\nabla \log H|^{2} d x
\end{aligned}
$$

where

$$
H(x):=\frac{1}{\pi} \frac{1}{\langle x\rangle^{4}} \quad \text { and then } \quad|\nabla \log H(x)| \leq 4
$$

which together with (1.4) imply that the modified free energy functional

$$
\mathcal{F}_{H}=\mathcal{F}(f, u)-\int_{\mathbb{R}^{2}} f \log H
$$

satisfies

$$
\begin{equation*}
\frac{d}{d t} \mathcal{F}_{H}(t)+\frac{1}{2} \mathcal{D}_{\mathcal{F}}(t) \leq M \tag{2.1}
\end{equation*}
$$

On the one hand, introducing the Laplace kernel $\kappa_{0}(z):=-\frac{1}{2 \pi} \log |z|$ and the Bessel kernel $\kappa_{\alpha}(z):=\frac{1}{4 \pi} \int_{0}^{\infty} t^{-1} \exp \left(-|z|^{2} /(4 t)-\alpha t\right) d t$ for $\alpha>0$, so that $\bar{u}=\bar{u}_{\alpha}:=\kappa_{\alpha} * f$ is a solution to the Laplace type equation

$$
-\Delta \bar{u}=f-\alpha \bar{u} \quad \text { in } \quad \mathbb{R}^{2}
$$

and introducing as well the chemical energy and the modified entropy

$$
F_{\alpha}(f, u):=\frac{1}{2} \int|\nabla u|^{2}+\frac{\alpha}{2} \int u^{2}-\int f u, \quad \mathcal{H}_{H}(f):=\int f \log (f / H)
$$

one can easily show (see e.g. [7, Lemma 2.2]) that

$$
\begin{equation*}
\mathcal{F}_{H}(f, u)=\mathcal{H}_{H}(f)+F_{\alpha}\left(f, \bar{u}_{\alpha}\right)+\frac{1}{2} \int\left|\nabla\left(u-\bar{u}_{\alpha}\right)\right|^{2}+\frac{\alpha}{2} \int\left(u-\bar{u}_{\alpha}\right)^{2} \tag{2.2}
\end{equation*}
$$

and

$$
\begin{equation*}
F_{\alpha}\left(f, \bar{u}_{\alpha}\right)=-\frac{1}{2} \iint_{\mathbb{R}^{2} \times \mathbb{R}^{2}} f(x) f(y) \kappa_{\alpha}(x-y) d x d y \tag{2.3}
\end{equation*}
$$

On the other hand, we know from the classical logarithmic Hardy-Littlewood Sobolev inequality (see e.g. [1, 10]) or its generalization for the Bessel kernel (see [7, Lemma 4.2]) that

& -\int_{\mathbb{R}^{2}} f(x) \log H(x) d x \geq-C_{1}(M)
\end{align*}
$$

where here and below $C_{i}(M)$ denotes a positive constant which only depends on the mass $M$.

Then from (2.2), (2.3) and (2.4) together with the very classical functional inequality (see e.g. [7, Lemma 2.4])

one immediately obtains, for $M<8 \pi$,

\mathcal{F}_{H}(f, u) & \geq\left(1-\frac{M}{8 \pi}\right) \mathcal{H}_{H}(f)+\frac{M}{8 \pi}\left(\mathcal{H}_{H}(f)-\frac{4 \pi}{M} \iint_{\mathbb{R}^{2} \times \mathbb{R}^{2}} f(x) f(y) \kappa_{\alpha}(x-y) d x d y\right) \\

One concludes that under the assumption (1.7) on the initial datum, the identity (1.3) and the inequality (2.1) provide a convenient family of a priori estimates in order to define weak solutions, namely

2.2. Local in time a posteriori estimates. We start by presenting some elementary functional inequalities which will be of main importance in the sequel. The two first estimates are picked up from [16, Lemma 3.2] but are probably classical and the third one is a variant of the Gagliardo-Niremberg-Sobolev inequality.

Remark 2.3. The logarithmic Hardy-Littlewood Sobolev inequality (2.4) in the supercritical case $M \geq 8 \pi$ does not lead to a global estimate as for the subcritical case $M \in(0,8 \pi)$. However, introducing the function $\mathscr{M}:=M H$ of mass $M$ and the modified free energy

This differential inequality provides a local a priori estimate on the modified free energy which can be used in order to prove local existence result for supercritical mass. Because we will prove in Theorem 1.3 that the above resulting bound is suitable in order to get the uniqueness of the solution, we can classically obtain the existence and uniqueness of maximal solutions (in the weak sense of Definition 1.1) $(f, u) \in C\left(\left[0, T^{*}\right) ; \mathcal{D}^{\prime}\left(\mathbb{R}^{2}\right) \times\right.$ $\mathcal{D}^{\prime}\left(\mathbb{R}^{2}\right)$ ) such that

By approximating $\chi \equiv 1$ by the sequence $\left(\chi_{R}\right)$ with $\chi_{R}(x)=\chi(x / R), 0 \leq \chi \in \mathcal{D}\left(\mathbb{R}^{2}\right)$, we see that the last term in (2.21) vanishes and we get (2.16) in the limit $R \rightarrow \infty$ for any renormalizing function $\beta$ with linear growth at infinity.
Step 3. Super-linear estimates. Finally, for any $\beta$ satisfying the growth condition as in the statement of the Lemma, we just approximate $\beta$ by an increasing sequence of smooth renormalizing functions $\beta_{R}$ with linear growth at infinity, and we pass to the limit in (2.16) in order to conclude.

As a first application of the previous lemma we obtain the following estimate.
Lemma 2.6. For any weak solution $(f, u)$ there exists a constant $C:=C\left(M, \mathcal{H}_{0}, \mathcal{F}_{0}, T, p\right)$ such that, for any $0 \leq t_{0}<t_{1} \leq T$, there holds

& +\log K \int_{t_{0}}^{t_{1}} \int_{\mathbb{R}^{2}} \frac{|\nabla f|^{2}}{f} \mathbf{1}_{f>K} \leq \int_{\mathbb{R}^{2}} \beta_{K}\left(f_{t_{0}}\right)+4 \int_{t_{0}}^{t_{1}} \int_{\mathbb{R}^{2}} \gamma_{K}(f)|\Delta u| \tag{2.23}
\end{align*}

On the one hand, for any $\delta>0$, we have

& \leq C^{\prime}\left(M+\mathcal{H}^{+}(f)\right)\left(\int_{\mathbb{R}^{2}} \frac{|\nabla f|^{2}}{f} \widetilde{\log }_{K} f \mathbf{1}_{f \geq e}+I(f)\right) \tag{2.24}
\end{align*}

Coming back to (2.23), Estimate (2.22) follows by taking $\delta>0$ small enough, using Lemma 2.4 and Proposition 2.2, and then letting $K \rightarrow \infty$.

& \quad \leq \int_{\mathbb{R}^{2}} \beta_{K}\left(f_{t_{0}}\right)+\frac{1}{p^{\prime}} \int_{t_{0}}^{t_{1}} \int_{\mathbb{R}^{2}}|\Delta u| f^{p} \mathbf{1}_{f<K}+3 K^{p-1} \int_{t_{0}}^{t_{1}} \int_{\mathbb{R}^{2}}|\Delta u| f \mathbf{1}_{f>K}
\end{align*}

Step 2. For the second term on the right-hand side of (2.26), using the Gagliardo-NirembergSobolev inequality

& \leq C\|\Delta u\|_{L_{x}^{2}}\left(\int_{\mathbb{R}^{2}}(f \wedge K)^{p} \int_{\mathbb{R}^{2}}\left|\nabla(f \wedge K)^{p / 2}\right|^{2}\right)^{1 / 2} \\
& \leq C\|\Delta u\|_{L_{x}^{2}}^{2} \int_{\mathbb{R}^{2}} \beta_{K}(f)+\frac{1}{p p^{\prime}} \int_{\mathbb{R}^{2}}\left|\nabla\left(f^{p / 2}\right)\right|^{2} \mathbf{1}_{f<K}
\end{aligned}
$$

Step 3. Let us define the convex function $\Phi$ by $\Phi(\xi):=\xi^{2}(\widetilde{\log } \xi)^{2}$ for any $\xi \geq 0$, with $\widetilde{\log } \xi:=$ $\mathbf{1}_{\xi \leq e}+\log \xi \mathbf{1}_{\xi>e}$. We observe that $\Phi$ is a $N$-function so that we may associate to $\Phi$ the Orlicz spaces $L_{\Phi}$ (see Appendix A.1). We have already obtained that $\|\Delta u\|_{L_{x}^{2}}^{2} \in L^{1}(0, T)$ in Lemma 2.4 and we claim that we also have

We denote by $\Phi^{*}$ the conjugate function of $\Phi$ and we observe that $\Phi^{*}(\eta) \leq C \eta^{2}(\widetilde{\log } \eta)^{-2}$ for any $\eta>0$ and for some fixed constant $C \in(0, \infty)$ (see Appendix A.3). We introduce the notation $f_{K}:=f \mathbf{1}_{f>K}$ and $A_{K}(f):=\left(\int_{\mathbb{R}^{2}} f \mathbf{1}_{f>K / 2}\right)^{1 / 2}$. Using Young's inequality $\xi \eta \leq \Phi(\xi)+\Phi^{*}(\eta)$, we obtain

& \leq C\left(\int_{\mathbb{R}^{2}} \beta_{K}(f)\right)\left(C(M)\|\Delta u\|_{L_{x}^{2}}^{2}+\|\Phi(|\Delta u|)\|_{L_{x}^{1}}\right) .

For the term $\mathcal{T}_{2,2}$, using that $f_{K}>K$ on $\{f>K\}$, we obtain, for $K>e M^{1 / 2}$,

& \leq C \frac{K^{p-1}\left|A_{K}(f)\right|^{-2}}{\left(\log \frac{K}{M^{1 / 2}}\right)^{2}} \int_{\mathbb{R}^{2}}(f-K / 2)_{+}^{2} \\
& \leq C \frac{K^{p-1}\left|A_{K}(f)\right|^{-2}}{\left(\log \frac{K}{M^{1 / 2}}\right)^{2}}\left(\int_{\mathbb{R}^{2}}|\nabla f| \mathbf{1}_{f \geq K / 2}\right)^{2} \\
& \leq C \frac{K^{p-1}\left|A_{K}(f)\right|^{-2}}{\left(\log \frac{K}{M^{1 / 2}}\right)^{2}}\left(\int_{\mathbb{R}^{2}} f \mathbf{1}_{f \geq K / 2}\right)\left(\int_{\mathbb{R}^{2}} \frac{|\nabla f|^{2}}{f} \mathbf{1}_{f \geq K / 2}\right) \\
& \leq C \frac{K^{p-1}}{\left(\log \frac{K}{\left.M^{1 / 2}\right)^{2}}\right.}\left(\int_{\mathbb{R}^{2}} \frac{|\nabla f|^{2}}{f} \mathbf{1}_{K / 2 \leq f \leq K / 2}+\int_{\mathbb{R}^{2}} \frac{|\nabla f|}{f} \mathbf{1}_{f>K}\right) \\
& \leq C \frac{K^{p-1}}{\left(\log \frac{K}{\left.M^{1 / 2}\right)^{2}}\right.}\left(K^{1-p} \int_{\mathbb{R}^{2}}\left|\nabla\left(f^{p / 2}\right)\right|^{2} \mathbf{1}_{f \leq K}+\int_{\mathbb{R}^{2}} \frac{|\nabla f|}{f} \mathbf{1}_{f>K}\right)
\end{aligned}

where we have used the elementary inequality $f_{K}^{2} \leq C(f-K / 2)_{+}^{2}$ in the second line, Sobolev's inequality in the third line and Cauchy-Schwarz inequality in the fourth line. Hence, for $K$ big enough, we have

Gathering $\mathcal{T}_{1}, \mathcal{T}_{2,1}$ and $\mathcal{T}_{2,2}$, it follows that

Using the fact that $h(t):=\int_{\mathbb{R}^{2}}|\Delta u|^{2}+\Phi(|\Delta u|) \in L^{1}\left(t_{0}, T\right)$ from Lemma 2.4 and Step 3, we can conclude to (2.25) by applying first the Gronwall's lemma and by then passing to the limit $K \rightarrow \infty$.

with $Z \in L^{2}\left(t_{0}, T ; L^{q}\left(\mathbb{R}^{2}\right)\right)$ for all $t_{0} \in(0, T)$ and all $q \in[1,2)$ from (2.31) and (2.32), the same maximal regularity of the heat equation in $L^{q}$-spaces (with the choice $s_{1}=s_{2}=(4 / 3)^{-}$) implies

$$
\nabla f \in L^{p}\left(t_{0}, T ; L^{p}\left(\mathbb{R}^{2}\right)\right), \forall p \in[2,4)
$$

and then $Z \in L^{p}\left(t_{0}, T ; L^{p}\left(\mathbb{R}^{2}\right)\right), \forall p \in[2,4)$. By a bootstrap argument of the regularity property of the heat equation, we easily get

$$
\begin{equation*}
f \in L^{\infty}\left(t_{0}, T ; L^{p}\left(\mathbb{R}^{2}\right)\right), \quad \nabla f \in L^{\infty}\left(t_{0}, T ; L^{p}\left(\mathbb{R}^{2}\right)\right), \quad \partial_{t} f, D^{2} f \in L^{p}\left(\left(t_{0}, T\right) \times \mathbb{R}^{2}\right) \tag{2.33}
\end{equation*}
$$

for all $t_{0} \in(0, T)$ and $p \in(1, \infty)$. The Morrey inequality implies then $f, \nabla f, u, \nabla u \in C^{0, \alpha}\left(\left(t_{0}, T\right) \times\right.$ $\mathbb{R}^{2}$ ) for any $0<\alpha<1$, and any $t_{0}>0$. Finally the classical Holderian regularity result for the heat equation (see Theorem X. 13 stated in [5] and the quoted references) implies first $u \in$ $C^{2, \alpha}\left(\left(t_{0}, T\right) \times \mathbb{R}^{2}\right)$ and next $f \in C^{2, \alpha}\left(\left(t_{0}, T\right) \times \mathbb{R}^{2}\right)$, which concludes the proof.

We prove now the free energy-dissipation of the free energy identity (1.4) in Theorem 1.3.
Proof of the free energy identity in Theorem 1.3. We split the proof into four steps.
Step 1. We claim that the free energy functional $\mathcal{F}$ is lower semi-continuous (lsc) in the sense that for any sequences $\left(f_{n}\right)$ and $\left(u_{n}\right)$ of nonnegative functions such that $\left(f_{n}\right)$ is bounded in $L^{1} \cap$ $L^{1}\left(\log \langle x\rangle^{2}\right)$ with same mass $M<8 \pi,\left(u_{n}\right)$ is bounded in $H^{1}$ if $\alpha>0$ or in $L^{1} \cap \dot{H}^{1}$ if $\alpha=0$, $\left(f_{n} u_{n}\right)$ is bounded in $L^{1},\left(\mathcal{F}\left(f_{n}, u_{n}\right)\right)$ is bounded and $\left(f_{n}, u_{n}\right) \rightharpoonup(f, u)$ in $\mathcal{D}^{\prime}\left(\mathbb{R}^{2}\right) \times \mathcal{D}^{\prime}\left(\mathbb{R}^{2}\right)$, there holds

$$
\begin{equation*}
0 \leq f \in L^{1} \cap L^{1}\left(\log \langle x\rangle^{2}\right) \quad \text { and } \quad \mathcal{F}(f, u) \leq \liminf _{n \rightarrow \infty} \mathcal{F}\left(f_{n}, u_{n}\right) \tag{2.34}
\end{equation*}
$$

Indeed, because of (2.5) and (2.6), we have $\mathcal{H}^{+}\left(f_{n}\right) \leq C$ and we may apply the Dunford-Pettis lemma which implies that $f_{n} \rightharpoonup f$ weakly in $L^{1}\left(\mathbb{R}^{2}\right)$. We then rewrite the free energy functional as

$$
\mathcal{F}\left(f_{n}, u_{n}\right)=\mathcal{H}\left(f_{n}\right)+F_{\alpha}\left(f_{n}, u_{n}\right)
$$

with

$$
\mathcal{H}\left(f_{n}\right):=\int f_{n} \log f_{n} \quad \text { and } \quad F_{\alpha}\left(f_{n}, u_{n}\right):=\frac{1}{2} \int\left|\nabla u_{n}\right|^{2}+\frac{\alpha}{2} \int u_{n}^{2}-\int f_{n} u_{n}
$$

and we consider separately the case $\alpha>0$ and $\alpha=0$.
Step 2: Case $\alpha>0$. We denote $\bar{u}_{n}=\kappa_{\alpha} * f_{n}$ where $\kappa_{\alpha}(z)=\frac{1}{4 \pi} \int_{0}^{\infty} \frac{1}{t} e^{-\frac{|z|^{2}}{4 t}-\alpha t} d t$ is the Bessel kernel. Since $f_{n} \geq 0, f_{n} \in L^{1} \cap L \log L$ and $u_{n} \in H^{1}$, [7, Lemma 2.2] implies that $\bar{u}_{n} \in H^{1}$ and also that the functional $F_{\alpha}\left(f_{n}, u_{n}\right)$ is finite and satisfies

$$
F_{\alpha}\left(f_{n}, u_{n}\right)-F_{\alpha}\left(f_{n}, \bar{u}_{n}\right)=\frac{1}{2}\left\|\nabla\left(u_{n}-\bar{u}_{n}\right)\right\|_{L^{2}}^{2}+\frac{\alpha}{2}\left\|u_{n}-\bar{u}_{n}\right\|_{L^{2}}^{2}
$$

Hence, we can write

$$
\begin{aligned}
\mathcal{F}\left(f_{n}, u_{n}\right) & =\mathcal{H}\left(f_{n}\right)-\frac{1}{2} \iint f_{n}(x) f_{n}(y) \kappa_{\alpha}(x-y)+\frac{1}{2}\left\|\nabla\left(u_{n}-\bar{u}_{n}\right)\right\|_{L^{2}}^{2}+\frac{\alpha}{2}\left\|u_{n}-\bar{u}_{n}\right\|_{L^{2}}^{2} \\
& =: \mathcal{H}\left(f_{n}\right)+\mathcal{V}\left(f_{n}\right)+\mathcal{U}_{1}\left(u_{n}-\bar{u}_{n}\right)+\mathcal{U}_{2}\left(u_{n}-\bar{u}_{n}\right)
\end{aligned}
$$

where the functionals $\mathcal{U}_{1}$ and $\mathcal{U}_{2}$ are defined through the third and fourth term respectively. We clearly have that $\mathcal{U}_{1}+\mathcal{U}_{2}$ is lsc for the weak $H^{1}$ convergence and $\mathcal{H}$ is lsc for the weak $L^{1}$ convergence, so we investigate the functional $\mathcal{V}$. For any $\epsilon \in(0,1)$ we split $\mathcal{V}=\mathcal{V}_{\epsilon}+\mathcal{R}_{\epsilon}$ as

$$
\begin{aligned}
\mathcal{V}_{\epsilon}(g) & :=-\frac{1}{2} \iint g(x) g(y) \kappa_{\alpha}(x-y) \mathbf{1}_{|x-y|>\epsilon} \\
\mathcal{R}_{\epsilon}(g) & :=-\frac{1}{2} \iint g(x) g(y) \kappa_{\alpha}(x-y) \mathbf{1}_{|x-y| \leq \epsilon}
\end{aligned}
$$

The Bessel kernel $\kappa_{\alpha}$ is a positive radial decreasing function with a singularity at the origin: $\kappa_{\alpha}(z)=-\frac{1}{2 \pi} \log |z|+O(1)$ when $|z| \rightarrow 0$. Hence $\mathcal{V}_{\epsilon}$ is continuous for the weak $L^{1}$ convergence and for the rest term we obtain, for any $\epsilon \in(0,1)$ and $\lambda>1$,

$$
\begin{aligned}
\left|\mathcal{R}_{\varepsilon}(g)\right| \leq & C \iint g(x) g(y) \mathbf{1}_{|x-y| \leq \epsilon}+C \iint g(x) g(y)(\log |x-y|)_{-} \mathbf{1}_{|x-y| \leq \epsilon} \\
\leq & C \iint g(x) \mathbf{1}_{g(x) \leq \lambda} g(y) \mathbf{1}_{|x-y| \leq \epsilon}+C \iint g(x) \mathbf{1}_{g(x)>\lambda} g(y) \mathbf{1}_{|x-y| \leq \epsilon} \\
& +C \iint g(x) \mathbf{1}_{g(x) \geq \lambda} g(y)(\log |x-y|)_{-} \mathbf{1}_{|x-y| \leq \epsilon}+C \iint g(x) \mathbf{1}_{g(x)>\lambda} g(y) \log \left(|x-y|^{-1}\right) \mathbf{1}_{|x-y| \leq \epsilon} \\
\leq & C \lambda \int_{y} g(y)\left\{\int_{|z| \leq \epsilon} d z\right\}+C \int_{y} g(y)\left\{\frac{1}{\log \lambda} \int_{x} g(x) \log g(x)\right\} \\
& +C \lambda \int_{y} g(y)\left\{\int_{|z| \leq \epsilon}(\log |z|)_{-} d z\right\}+C \int_{x} g(x) \mathbf{1}_{g(x)>\lambda} \int_{y}\left\{g(y) \log g(y)+|x-y|^{-1}\right\} \mathbf{1}_{|x-y| \leq \epsilon} \\
\leq & C M \lambda \epsilon^{2}+C M \frac{\mathcal{H}(g)}{\log \lambda}+C M \lambda \epsilon^{3 / 2}+C \frac{\mathcal{H}(g)}{\log \lambda}\{\mathcal{H}(g)+\epsilon\},
\end{aligned}
$$

where we have used the convexity inequality $u v \leq u \log u+e^{v}$ for all $u>0, v \in \mathbb{R}$ and the elementary inequality $u \log u \geq-u^{1 / 2}$ for all $u \in(0,1)$. Hence $\sup _{n}\left|\mathcal{R}_{\varepsilon}\left(f_{n}\right)\right| \rightarrow 0$ as $\epsilon \rightarrow 0$ and we deduce that $\mathcal{F}$ is lsc.

Step 3: Case $\alpha=0$. We define $\bar{u}_{n}=\kappa_{0}\left(f_{n}-M H\right)$ where $H(x)=\langle x\rangle^{-4} / \pi$ and $\kappa_{0}(z)=-\frac{1}{2 \pi} \log |z|$ is the Laplace kernel. Since $0 \leq f_{n} \in L^{1} \cap L^{1}\left(\log \langle x\rangle^{2}\right), \mathcal{H}\left(f_{n}\right)$ is finite, $\int(f-M H)=0$ and $u_{n} \in \dot{H}^{1},\left[7\right.$, Lemma 2.2] implies that $\bar{u}_{n} \in \dot{H}^{1}$ and also that the functional $F_{0}\left(f_{n}-M H, u_{n}\right)$ is finite and verifies

$$
F_{0}\left(f_{n}-M H, u_{n}\right)-F_{0}\left(f_{n}-M H, \bar{u}_{n}\right)=\frac{1}{2}\left\|\nabla\left(u_{n}-\bar{u}_{n}\right)\right\|_{L^{2}}^{2}
$$

Now we argue as in the case $\alpha>0$. First we write

$$
\begin{aligned}
\mathcal{F}\left(f_{n}, u_{n}\right)= & \mathcal{H}\left(f_{n}\right)-\frac{1}{2} \iint f_{n}(x) f_{n}(y) \kappa_{0}(x-y)+M \iint f_{n}(x) H(y) \kappa_{0}(x-y) \\
& +\frac{1}{2}\left\|\nabla\left(u_{n}-\bar{u}_{n}\right)\right\|_{L^{2}}^{2}-M \int H u_{n}-\frac{M^{2}}{2} \iint H(x) H(y) \kappa_{0}(x-y) \\
= & : \mathcal{H}\left(f_{n}\right)+\mathcal{V}\left(f_{n}\right)+\mathcal{W}\left(f_{n}\right)+\mathcal{U}_{1}\left(u_{n}-\bar{u}_{n}\right)+\mathcal{U}_{0}\left(u_{n}\right)+\mathcal{Z}(H)
\end{aligned}
$$

The functional $\mathcal{U}_{1}$ is lsc for the weak $\dot{H}^{1}$ convergence and $\mathcal{H}$ is lsc for the weak $L^{1}$ convergence. For $\mathcal{V}$ we just argue as in the preceding case $\alpha>0$. In the same (even simpler) way we obtain that $\mathcal{W}$ is lsc for the weak $L^{1}$ convergence. Finally we conclude that $\mathcal{F}$ is lsc.

Step 4. Now, we easily deduce that the free energy identity (1.4) holds. Indeed, since $(f, u)$ is smooth for positive time, for any fixed $t>0$ and any given sequence $\left(t_{n}\right)$ of positive real numbers which decreases to 0 , we clearly have

$$
\mathcal{F}\left(f\left(t_{n}\right), u\left(t_{n}\right)\right)=\mathcal{F}(t)+\int_{t_{n}}^{t} \mathcal{D}_{\mathcal{F}}(f(s), u(s)) d s
$$

Then, thanks to the Lebesgue convergence theorem, the lsc property of $\mathcal{F}$ and the fact that $f\left(t_{n}\right) \rightharpoonup f_{0}$ and $u\left(t_{n}\right) \rightharpoonup u_{0}$ weakly in $\mathcal{D}^{\prime}\left(\mathbb{R}^{2}\right)$, we deduce from the above free energy identity for positive time that

\begin{aligned}
\mathcal{F}\left(f_{0}, u_{0}\right) & \leq \liminf _{n \rightarrow \infty} \mathcal{F}\left(f\left(t_{n}\right), u\left(t_{n}\right)\right) \\
& \leq \lim _{n \rightarrow \infty}\left\{\mathcal{F}(t)+\int_{t_{n}}^{t} \mathcal{D}_{\mathcal{F}}(f(s), u(s)) d s\right\}=\mathcal{F}(t)+\int_{0}^{t} \mathcal{D}_{\mathcal{F}}(f(s), u(s)) d s
\end{aligned}
$$

Together with the reverse inequality (1.9) we conclude to (1.4).

## 3. Uniqueness - Proof of Theorem 1.3

In this section we prove the uniqueness part of Theorem 1.3. In order to do so, we first prove some estimates in Lemmas 3.1 and 3.2.

Lemma 3.1. Any weak solution $(f, u)$ to the Keller-Segel equation satisfies that for any $p \in(1, \infty)$, $T \in(0, \infty)$ there exists a constant $K=K\left(f_{0}, p, T\right)$ such that

$$
\begin{equation*}
t^{p-1}\|f(t)\|_{L^{p}}^{p} \leq K \quad \forall t \in(0, T) \tag{3.1}
\end{equation*}
$$

Proof of Lemma 3.1. Recall that we already know that $\|f\|_{L^{p}} \in C^{1}(0, T)$ for any $p>1$ and $\|f\|_{L^{p}} \in L^{\infty}\left(t_{0}, T\right)$ for any $0<t_{0}<T$ and any $p \in[1, \infty]$. For for $p>1$, we have

$$
\begin{aligned}
\frac{d}{d t} \int f^{p} & =-4(1-1 / p) \int\left|\nabla\left(f^{p / 2}\right)\right|^{2}+(p-1) \int f^{p+1}-(p-1) \int\left(\partial_{t} u+\alpha u\right) f^{p} \\
& =: T_{1}+T_{2}+T_{3}
\end{aligned}
$$

Using the splitting $f=\min (f, A)+(f-A)_{+}$, for some $A>0$, and denoting $h(u):=\partial_{t} u+\alpha u \in$ $L^{2}\left(0, T ; L^{2}\left(\mathbb{R}^{2}\right)\right)$, we have

$$
\left|T_{3}\right| \leq C \int|h(u)| \min (f, A)^{p}+C \int|h(u)|(f-A)_{+}^{p}=: T_{31}+T_{32}
$$

For the term $T_{31}$, we have

$$
\left|T_{31}\right| \leq C A^{p-1 / 2} \int|h(u)| f^{1 / 2} \leq C A^{p-1 / 2}\left(\|h(u)\|_{L^{2}}^{2}+M\right)
$$

For $T_{32}$, using Gagliardo-Niremberg-Sobolev inequality $\|g\|_{L^{4}\left(\mathbb{R}^{2}\right)}^{4} \leq C\|g\|_{L^{2}\left(\mathbb{R}^{2}\right)}^{2}\|\nabla g\|_{L^{2}\left(\mathbb{R}^{2}\right)}^{2}$ with $g=(f-A)_{+}^{p / 2}$, we have

$$
\begin{aligned}
\left|T_{32}\right| & \leq C \int|h(u)|(f-A)_{+}^{p} \\
& \leq C\|h(c)\|_{L^{2}}\left(\int(f-A)_{+}^{2 p}\right)^{1 / 2} \\
& \leq C\|h(c)\|_{L^{2}}\left(\int(f-A)_{+}^{p}\right)^{1 / 2}\left(\int\left|\nabla(f-A)_{+}^{p / 2}\right|^{2}\right)^{1 / 2} \\
& \leq C_{\delta}\|h(u)\|_{L^{2}}^{2} \int(f-A)_{+}^{p}+\delta \int\left|\nabla\left(f^{p / 2}\right)\right|^{2} \mathbf{1}_{f \geq A}
\end{aligned}
$$

for any $\delta>0$.
For the second term $T_{2}$, we have

$$
\left|T_{2}\right| \leq C \int \min (f, A)^{p+1}+C \int(f-A)_{+}^{p+1}
$$

At the right-hand side, the first term is easily bounded by $C A^{p} M$, and using (2.10), the second one is bounded as follows

$$
\int(f-A)_{+}^{p+1} \leq C\left(\int(f-A)_{+}\right)\left(\int\left|\nabla(f-A)_{+}^{p / 2}\right|^{2}\right) \leq C \frac{\mathcal{H}^{+}(f)}{\log A}\left(\int\left|\nabla\left(f^{p / 2}\right)\right|^{2} \mathbf{1}_{f \geq A}\right)
$$

Gathering all the previous estimates, choosing $\delta>0$ small enough and $A$ large enough, we get

$$
\begin{equation*}
\frac{d}{d t} \int f^{p} \leq-C_{0} \int\left|\nabla\left(f^{p / 2}\right)\right|^{2}+C_{1}\|h(u)\|_{L^{2}}^{2} \int f^{p}+C_{1}\left(M+\|h(u)\|_{L^{2}}^{2}\right) \tag{3.2}
\end{equation*}
$$

Thanks to the following inequalities

$$
\left(\|f\|_{L^{p}}^{p}\right)^{p /(p-1)} \leq C\|f\|_{L^{1}}^{1 /(p-1)}\|f\|_{L^{p+1}}^{p+1} \quad \text { and } \quad\|f\|_{L^{p+1}}^{p+1} \leq C\|f\|_{L^{1}}\left\|\nabla\left(f^{p / 2}\right)\right\|_{L^{2}}^{2}
$$

we obtain from (3.2) the differential inequality

$$
\frac{d}{d t} X(t) \leq-C_{0} X(t)^{\frac{p}{p-1}}+C_{1} H(t) X(t)+C_{2}(1+H(t)), \quad t \in(0, T)
$$

where we denote $X(t):=\|f(t)\|_{L^{p}}^{p}$ and $H(t):=\|h(u)\|_{L^{2}}^{2}(t) \in L^{1}(0, T)$. By standard arguments (see e.g. [7, Proof of Theorem 5.1]) we conclude to (3.1).

We (crucially) improve the preceding estimate by showing
Lemma 3.2. For any $p \in[2, \infty)$, any weak solution $(f, u)$ to the Keller-Segel equation satisfies:

$$
\begin{equation*}
t^{\frac{p-1}{2 p}}\|f(t, .)\|_{L^{2 p /(p+1)}} \rightarrow 0 \quad \text { as } t \rightarrow 0 \tag{3.3}
\end{equation*}
$$

Proof of Lemma 3.2. We prove (3.3) from (3.1) and an interpolation argument. On the one hand, denoting $\widetilde{\log _{+}} f:=2+\log _{+} f$, we use Hölder's inequality in order to get

\begin{aligned}
\int f^{2 p /(p+1)} & =\int f^{p /(p+1)}\left(\widetilde{\log }_{+} f\right)^{p /(p+1)} f^{p /(p+1)}\left(\widetilde{\log }_{+} f\right)^{-p /(p+1)} \\
& \leq\left(\int f \widetilde{\log _{+}} f\right)^{p /(p+1)}\left(\int f^{p} \widetilde{\left.\left(\widetilde{\log _{+}} f\right)^{-p}\right)^{1 /(p+1)}}\right.
\end{aligned}
$$

or in other words

$$
\begin{equation*}
\|f\|_{L^{2 p /(p+1)}} \leq C\left(M, \mathcal{H}_{+}(f)\right)\left(\int f^{p}\left(\widetilde{\log }_{+} f\right)^{-p}\right)^{1 /(2 p)} \tag{3.4}
\end{equation*}
$$

On the other hand, we observe that

$$
\begin{align*}
t^{p-1} \int f^{p}\left(\widetilde{\log _{+}} f\right)^{-p} & \leq t^{p-1} \int_{f \leq R} f^{p}\left(\widetilde{\log _{+}} f\right)^{-p}+t^{p-1} \int_{f \geq R} f^{p}\left(\widetilde{\log _{+}} f\right)^{-p} \\
& \leq t^{p-1} \frac{R^{p-1}}{\left(\widetilde{\left.\log _{+} R\right)^{p}}\right.} \int_{f \leq R} f+\frac{t^{p-1}}{\left(\widetilde{\left.\log _{+} R\right)^{p}}\right.} \int_{f \geq R} f^{p} \\
& \leq t^{p-1} \frac{M R^{p-1}}{\left(\widetilde{\left.\log _{+} R\right)^{p}}\right.}+\frac{K}{\left(\widetilde{\left.\log _{+} R\right)^{p}}\right.} \\
& \leq \frac{M+K}{\left\langle\log t^{-1}\right\rangle^{2}} \rightarrow 0 \tag{3.5}
\end{align*}
$$

where we have used that $s \mapsto s\left(\widetilde{\log }_{+} s\right)^{-2}$ is an increasing function, the mass conservation of the solution of the Keller-Segel equation and the estimate (3.1) in the third line, and we have chosen $R:=t^{-1}$ in the last line. We conclude to (3.3) by gathering (3.4) and (3.5).

We are now able to prove the uniqueness of solutions.
Proof of the uniqueness part in Theorem 1.3. We consider two weak solutions $\left(f_{1}, u_{1}\right)$ and $\left(f_{2}, u_{2}\right)$ to the Keller-Segel equation (1.1) that we write in the mild form

$$
f_{i}(t)=e^{t \Delta} f_{i}(0)-\int_{0}^{t} \nabla e^{(t-s) \Delta}\left(f_{i}(s) \nabla u_{i}(s)\right) d s
$$

and

$$
u_{i}(s)=e^{-\frac{\alpha}{\varepsilon} s} e^{\frac{s}{\varepsilon} \Delta} u_{i}(0)+\frac{1}{\varepsilon} \int_{0}^{s} e^{-\frac{\alpha}{\varepsilon}(s-\sigma)} e^{\frac{(s-\sigma)}{\varepsilon} \Delta} f_{i}(\sigma) d \sigma
$$

from which we also obtain

$$
\nabla u_{i}(s)=e^{-\frac{\alpha}{\varepsilon} s} e^{\frac{s}{\varepsilon} \Delta}\left(\nabla u_{i}(0)\right)+\frac{1}{\varepsilon} \int_{0}^{s} e^{-\frac{\alpha}{\varepsilon}(s-\sigma)}\left(\nabla e^{\frac{(s-\sigma)}{\varepsilon} \Delta}\right) f_{i}(\sigma) d \sigma
$$

When we assume $f_{1}(0)=f_{2}(0)$ and $u_{1}(0)=u_{2}(0)=u_{0}$, the difference $F:=f_{2}-f_{1}$ satisfies

$$
\begin{align*}
F(t)= & -\int_{0}^{t} \nabla e^{(t-s) \Delta}\left\{F(s)\left[e^{-\frac{\alpha}{\varepsilon} s} e^{\frac{s}{\varepsilon} \Delta}\left(\nabla u_{0}\right)\right]\right\} d s \\
& -\int_{0}^{t} \nabla e^{(t-s) \Delta}\left\{F(s)\left[\frac{1}{\varepsilon} \int_{0}^{s} e^{-\frac{\alpha}{\varepsilon}(s-\sigma)} \nabla e^{\frac{(s-\sigma)}{\varepsilon} \Delta} f_{2}(\sigma) d \sigma\right]\right\} d s  \tag{3.6}\\
& -\int_{0}^{t} \nabla e^{(t-s) \Delta}\left\{f_{1}(s)\left[\frac{1}{\varepsilon} \int_{0}^{s} e^{-\frac{\alpha}{\varepsilon}(s-\sigma)} \nabla e^{\frac{(s-\sigma)}{\varepsilon} \Delta} F(\sigma) d \sigma\right]\right\} d s \\
= & I_{1}(t)+I_{2}(t)+I_{3}(t)
\end{align*}
$$

For any $t>0$, we define

$$
Z_{p}^{i}(t):=\sup _{0<s \leq t} s^{\frac{1}{2}-\frac{1}{2 p}}\left\|f_{i}(s)\right\|_{L^{\frac{2 p}{p+1}}}, \quad \Delta(t):=\sup _{0<s \leq t} s^{\frac{1}{4}}\|F(s)\|_{L^{4 / 3}}
$$

We recall the explicit formula for the heat semigroup

e^{t \Delta} g=\gamma(t, \cdot) *_{x} g, \quad \gamma(t, x):=\frac{1}{4 \pi t} \exp \left(-\frac{|x|^{2}}{4 t}\right)
$$

and the following well-known inequalities that will be useful in the sequel

\|K * g\|_{L^{r}} \leq\|K\|_{L^{q}}\|g\|_{L^{p}}, \quad \frac{1}{p}+\frac{1}{q}=\frac{1}{r}+1, \quad 1 \leq p, q, r \leq \infty \tag{3.7}
\end{equation*}

and

\|\gamma(t, \cdot)\|_{L^{q}\left(\mathbb{R}^{2}\right)} \leq C_{q} t^{\frac{1}{q}-1}, \quad\|\nabla \gamma(t, \cdot)\|_{L^{q}\left(\mathbb{R}^{2}\right)} \leq C_{q} t^{\frac{1}{q}-\frac{3}{2}}
$$

We fix $p>2$ and we compute the quantity $t^{\frac{1}{4}}\|\cdot\|_{L^{4 / 3}}$ for each term of (3.6).
For the second term, we compute

t^{\frac{1}{4}}\left\|I_{2}(t)\right\|_{L^{4 / 3}} & \leq C(\alpha, \varepsilon) t^{\frac{1}{4}} \int_{0}^{t}\left\|\nabla e^{(t-s) \Delta}\left\{F(s) \int_{0}^{s} \nabla e^{\frac{(s-\sigma)}{\varepsilon} \Delta} f_{2}(\sigma) d \sigma\right\}\right\|_{L^{4 / 3}} d s \\
& \leq C t^{\frac{1}{4}} \int_{0}^{t}\left\|\nabla e^{(t-s) \Delta}\right\|_{L^{4 / 3}}\left\|F(s) \int_{0}^{s} \nabla e^{\frac{(s-\sigma)}{\varepsilon} \Delta} f_{2}(\sigma) d \sigma\right\|_{L^{1}} d s  \tag{3.8}\\
& \leq C t^{\frac{1}{4}} \int_{0}^{t}(t-s)^{-\frac{3}{4}}\|F(s)\|_{L^{4 / 3}} \int_{0}^{s}\left\|\nabla e^{\frac{(s-\sigma)}{\varepsilon} \Delta} f_{2}(\sigma)\right\|_{L^{4}} d \sigma d s \\
& \leq C t^{\frac{1}{4}} \int_{0}^{t}(t-s)^{-\frac{3}{4}}\|F(s)\|_{L^{4 / 3}} \int_{0}^{s}\left\|\nabla e^{\frac{(s-\sigma)}{\varepsilon} \Delta} f_{2}(\sigma)\right\|_{L^{4}} d \sigma d s,
\end{align*}
$$

where we have used Young's inequality for convolution (3.7) in the second line and Hölder's inequality in the third line. Now we can estimate the integral over $d \sigma$ using again Young's inequality (3.7) with $1 / 4+1=1 / a+(p+1) /(2 p)$, i.e. $1 / a=3 / 4-1 /(2 p)$, by

& \leq C \int_{0}^{s}(s-\sigma)^{\frac{3}{4}-\frac{1}{2 p}-\frac{3}{2}}\left\|f_{2}(\sigma)\right\|_{L^{\frac{2 p}{p+1}}} d \sigma \\
& \leq C Z_{p}^{2}(s) \int_{0}^{s}(s-\sigma)^{-\frac{3}{4}-\frac{1}{2 p}} \sigma^{-\frac{1}{2}+\frac{1}{2 p}} d \sigma \\
& \leq C Z_{p}^{2}(s) s^{-\frac{1}{4}} \int_{0}^{1}(1-y)^{-\frac{3}{4}-\frac{1}{2 p}} y^{-\frac{1}{2}+\frac{1}{2 p}} d y \\
& \leq C Z_{p}^{2}(s) s^{-\frac{1}{4}}
\end{aligned}
$$

since the last integral is bounded thanks to $-\frac{3}{4}-\frac{1}{2 p}>-1$ from $p>2$.
Gathering that last estimate with (3.8), it follows

\begin{align*}
t^{\frac{1}{4}}\left\|I_{2}(t)\right\|_{L^{4 / 3}} & \leq C t^{\frac{1}{4}} \int_{0}^{t}(t-s)^{-\frac{3}{4}} s^{-\frac{1}{4}}\|F(s)\|_{L^{4 / 3}} Z_{p}^{2}(s) d s \\
& \leq C Z_{p}^{2}(t) \Delta(t) \int_{0}^{t}(t-s)^{-\frac{3}{4}} t^{\frac{1}{4}} s^{-\frac{1}{2}} d s  \tag{3.9}\\
& \leq C Z_{p}^{2}(t) \Delta(t) \int_{0}^{1}(1-y)^{-\frac{3}{4}} y^{-\frac{1}{2}} d y \\
& \leq C Z_{p}^{2}(t) \Delta(t)
\end{align*}
$$

For the term $I_{3}$, we have

\begin{align*}
t^{\frac{1}{4}}\left\|I_{3}(t)\right\|_{L^{4 / 3}} & \leq C t^{\frac{1}{4}} \int_{0}^{t}\left\|\nabla e^{(t-s) \Delta}\left\{f_{1}(s) \int_{0}^{s} \nabla e^{\frac{(s-\sigma)}{\varepsilon} \Delta} F(\sigma) d \sigma\right\}\right\|_{L^{4 / 3}} d s \\
& \leq C t^{\frac{1}{4}} \int_{0}^{t}\left\|\nabla e^{(t-s) \Delta}\right\|_{L^{4 / 3}}\left\|f_{1}(s) \int_{0}^{s} \nabla e^{\frac{(s-\sigma)}{\varepsilon} \Delta} F(\sigma) d \sigma\right\|_{L^{1}} d s  \tag{3.10}\\
& \leq C t^{\frac{1}{4}} \int_{0}^{t}(t-s)^{-\frac{3}{4}}\left\|f_{1}(s)\right\|_{L^{\frac{2 p}{p+1}}} \int_{0}^{s}\left\|\nabla e^{\frac{(s-\sigma)}{\varepsilon} \Delta} F(\sigma)\right\|_{L^{\frac{2 p}{p-1}}} d \sigma d s
\end{align*}
$$

We compute the integral over $d \sigma$ in the following way

\int_{0}^{s}\left\|\nabla e^{\frac{(s-\sigma)}{\varepsilon} \Delta} F(\sigma)\right\|_{L^{\frac{2 p}{p-1}}} d \sigma & \leq \int_{0}^{s}\left\|\nabla e^{\frac{(s-\sigma)}{\varepsilon} \Delta}\right\|_{L^{\frac{4 p}{3 p-2}}}\|F(\sigma)\|_{L^{4 / 3}} d \sigma \\
& \leq C \int_{0}^{s}(s-\sigma)^{-\frac{3}{4}-\frac{1}{2 p}}\|F(\sigma)\|_{L^{4 / 3}} d \sigma \\
& \leq C \Delta(s) \int_{0}^{s}(s-\sigma)^{-\frac{3}{4}-\frac{1}{2 p}} \sigma^{-\frac{1}{4}} d \sigma \\
& \leq C \Delta(s) s^{-\frac{1}{2 p}}
\end{aligned}
$$

since the last integral is bounded because $p>2$. Putting together this estimate with (3.10), we obtain

t^{\frac{1}{4}}\left\|I_{3}(t)\right\|_{L^{4 / 3}} & \leq C t^{\frac{1}{4}} \int_{0}^{t}(t-s)^{-\frac{3}{4}}\left\|f_{1}(s)\right\|_{L^{\frac{2 p}{p+1}}} \Delta(s) s^{-\frac{1}{2 p}} d s \\
& \leq C Z_{p}^{1}(t) \Delta(t) \int_{0}^{t}(t-s)^{-\frac{3}{4}} t^{\frac{1}{4}} s^{-\frac{1}{2}}  \tag{3.11}\\
& \leq C Z_{p}^{1}(t) \Delta(t)
\end{align*}
$$

For the term $I_{1}$, we compute

$$
\begin{align*}
t^{\frac{1}{4}}\left\|I_{1}(t)\right\|_{L^{4 / 3}} & \leq C t^{\frac{1}{4}} \int_{0}^{t}\left\|\nabla e^{(t-s) \Delta}\left\{F(s) e^{\frac{s}{\varepsilon} \Delta} \nabla u_{0}\right\}\right\|_{L^{4 / 3}} d s \\
& \leq C t^{\frac{1}{4}} \int_{0}^{t}\left\|\nabla e^{(t-s) \Delta}\right\|_{L^{4 / 3}}\left\|F(s) e^{\frac{s}{\varepsilon} \Delta} \nabla u_{0}\right\|_{L^{1}} d s  \tag{3.12}\\
& \leq C t^{\frac{1}{4}} \int_{0}^{t}(t-s)^{-\frac{3}{4}}\|F(s)\|_{L^{4 / 3}}\left\|e^{\frac{s}{\varepsilon} \Delta} \nabla u_{0}\right\|_{L^{4}} d s
\end{align*}
$$

where we have used Young's and Hölder's inequalities. Let $K>0$ to be chosen later, we estimate

$$
\begin{equation*}
\left\|e^{\frac{s}{\varepsilon} \Delta} \nabla u_{0}\right\|_{L^{4}} \leq\left\|e^{\frac{s}{\varepsilon} \Delta} \nabla u_{0} \mathbf{1}_{\left\{\left|\nabla u_{0}\right| \leq K\right\}}\right\|_{L^{4}}+\left\|e^{\frac{s}{\varepsilon} \Delta} \nabla u_{0} \mathbf{1}_{\left\{\left|\nabla u_{0}\right| \geq K\right\}}\right\|_{L^{4}} \tag{3.13}
\end{equation*}
$$

Using Young's inequality, we have

$$
\left\|e^{\frac{s}{\varepsilon} \Delta} \nabla u_{0} \mathbf{1}_{\left\{\left|\nabla u_{0}\right| \leq K\right\}}\right\|_{L^{4}} \leq\left\|e^{\frac{s}{\varepsilon} \Delta}\right\|_{L^{1}}\left\|\nabla u_{0} \mathbf{1}_{\left\{\left|\nabla u_{0}\right| \leq K\right\}}\right\|_{L^{4}} \leq C K^{\frac{1}{2}}\left\|\nabla u_{0}\right\|_{L^{2}}^{1 / 2}
$$

Using Young's inequality again for the second term in (3.13), we have

\left\|e^{\frac{s}{\varepsilon} \Delta} \nabla u_{0} \mathbf{1}_{\left\{\left|\nabla u_{0}\right| \geq K\right\}}\right\|_{L^{4}} \leq\left\|e^{\frac{s}{\varepsilon} \Delta}\right\|_{L^{4 / 3}}\left\|\nabla u_{0} \mathbf{1}_{\left\{\left|\nabla u_{0}\right| \geq K\right\}}\right\|_{L^{2}} \leq C s^{-\frac{1}{4}} \varphi(K)
$$

where

$$
\varphi(K):=\left\|\nabla u_{0} \mathbf{1}_{\left\{\left|\nabla u_{0}\right| \geq K\right\}}\right\|_{L^{2}} \rightarrow 0 \quad \text { as } \quad K \rightarrow+\infty
$$

by the dominated convergence theorem. Putting together that last estimates in (3.13) and choosing $K=s^{-\frac{1}{4}}$, it follows

\left\|e^{\frac{s}{\varepsilon} \Delta} \nabla u_{0}\right\|_{L^{4}} \leq C s^{-\frac{1}{4}} \alpha(s) \quad \text { with } \quad \alpha(s):=s^{\frac{1}{8}}+\varphi\left(s^{-\frac{1}{4}}\right) \underset{s \rightarrow 0}{ } 0
$$

Coming back to (3.12), we obtain

\begin{align*}
t^{\frac{1}{4}}\left\|I_{1}(t)\right\|_{L^{4 / 3}} & \leq C t^{\frac{1}{4}} \int_{0}^{t}(t-s)^{-\frac{3}{4}}\|F(s)\|_{L^{4 / 3}} s^{-\frac{1}{4}} \epsilon(s) d s \\
& \leq C\left(\sup _{0<s \leq t} \alpha(s)\right) \Delta(t) \int_{0}^{t} t^{\frac{1}{4}}(t-s)^{-\frac{3}{4}} s^{-\frac{1}{2}} d s  \tag{3.14}\\
& \leq C\left(\sup _{0<s \leq t} \alpha(s)\right) \Delta(t) .
\end{align*}
$$

Gathering (3.9), (3.11) and (3.14), we conclude to

$$
\Delta(t) \leq C\left[\sup _{0<s \leq t} \alpha(s)+Z_{p}^{1}(t)+Z_{p}^{2}(t)\right] \Delta(t) \leq \frac{1}{2} \Delta(t)
$$

for $t \in(0, T), T>0$ small enough. That in turn implies $\Delta(t) \equiv 0$ on $[0, T)$. We may then repeat the argument for later times and conclude to the uniqueness of the solution.

## 4. Self-Similar solutions and linear stability

4.1. Convergence of the stationary solutions. First, for a given mass $M \in(0,8 \pi)$ and a given parameter $\varepsilon \in(0,1 / 2)$, we consider the self-similar profile $\left(G_{\varepsilon}, V_{\varepsilon}\right)$ which is the unique solution of the system of elliptic equations (1.17)-(1.18). We also consider the unique positive solution $(G, V)$ to the system of equations corresponding to the limit case $\varepsilon=0$

$$
\begin{align*}
& \Delta G-\nabla\left(G \nabla V-\frac{1}{2} x G\right)=0 \quad \text { in } \quad \mathbb{R}^{2}, \quad \int_{\mathbb{R}^{2}} G d x=M  \tag{4.1}\\
& \Delta V+G=0 \quad \text { in } \quad \mathbb{R}^{2}
\end{align*}
$$

It is worth emphasizing that $(G, V)$ is the unique self-similar profile associated to the parabolicelliptic Keller-Segel equation, see [9, 14].
Lemma 4.1. There exists a constant $C$ such that for any $\varepsilon \in(0,1 / 4]$

$$
\begin{gather*}
0 \leq G_{\varepsilon}(x) \leq C e^{-|x|^{2} / 4}  \tag{4.2}\\
\sup _{x \in \mathbb{R}^{2}}\left(\frac{1}{|x|}+\langle x\rangle\right)\left|\nabla V_{\varepsilon}(x)\right| \leq C \tag{4.3}
\end{gather*}
$$

and

$$
\begin{equation*}
\sup _{x \in \mathbb{R}^{2}}\left|\Delta V_{\varepsilon}(x)\right| \leq C \tag{4.4}
\end{equation*}
$$

Proof of Lemma 4.1. We split the proof into three steps.
Step 1. The estimate (4.2) has been proved in [3]. More precisely it is a consequence of equations (26) and (49) in [3], and

$$
G(0)=b, \quad 0 \leq M(\varepsilon, b) \leq 4 \pi \min (2, b)
$$

Here the parametrization of $G$ is made in function of $\varepsilon$ and $b=G(0)$ instead of $\varepsilon$ and $M$ because this dependence is more tractable. Observe that the estimate above guarantees that the mass is subcritical, i.e. $M(\varepsilon, b) \leq 8 \pi$.

Step 2. Since $V_{\varepsilon}$ and $G_{\varepsilon}$ are radially symmetric functions, the equation on $V_{\varepsilon}$ writes

$$
\begin{equation*}
V_{\varepsilon}^{\prime \prime}+\left(\frac{1}{r}+\frac{1}{2} \varepsilon r\right) V_{\varepsilon}^{\prime}+G_{\varepsilon}=0 \quad \forall r>0 \tag{4.5}
\end{equation*}
$$

where we abuse notation in writing $V_{\varepsilon}(r)=V_{\varepsilon}(x), G_{\varepsilon}(r)=G_{\varepsilon}(|x|), r=|x|$. The function $V_{\varepsilon}$ is smooth and the equation is complemented with the boundary conditions $V_{\varepsilon}^{\prime}(0)=V_{\varepsilon}^{\prime}(\infty)=0$. Defining $w:=\left(r V_{\varepsilon}^{\prime}\right)^{2}$, we find

$$
\frac{w^{\prime}}{2}=-\frac{1}{2} \varepsilon r w-G_{\varepsilon} V_{\varepsilon}^{\prime} r^{2} \leq C \sqrt{w} \frac{r}{\langle r\rangle^{3}}, \quad C:=\sup _{r>0} G_{\varepsilon}\langle r\rangle^{3}
$$

As a consequence

$$
\frac{d}{d r} \sqrt{w} \leq C \frac{r}{\langle r\rangle^{3}}
$$

and then

$$
\sqrt{w} \leq C(1 \wedge r)^{2}
$$

from which the inequality $\sup _{x}\left[\langle x\rangle\left|\nabla V_{\varepsilon}(x)\right|\right] \leq C$ of (4.3) follows.
Step 3. We rewrite (4.5) as

$$
\frac{1}{r}\left(V_{\varepsilon}^{\prime} r\right)^{\prime}=w:=-G_{\varepsilon}-\frac{1}{2} \varepsilon r V_{\varepsilon}^{\prime} \in L^{\infty}
$$

which implies

\left|V_{\varepsilon}^{\prime}(r) r\right|=\left|\int_{0}^{r} s w(s) d s\right| \leq C r^{2}
$$

This completes the estimate (4.3). Coming back to (4.5), we also obtain

\left|V_{\varepsilon}^{\prime \prime}(r)\right| \leq C
$$

which gives (4.4) and ends the proof.
Corollary 4.2. As $\varepsilon \rightarrow 0$, there hold

G_{\varepsilon} \rightarrow G \quad \text { in } W^{2, p} \quad \forall p \in(1, \infty)
$$

and

$$
\nabla V_{\varepsilon} \rightarrow \nabla V \quad \text { in } L_{1}^{\infty}, \quad \Delta V_{\varepsilon} \rightarrow \Delta V \quad \text { a.e. and bounded } L^{\infty}
$$

Proof of Corollary 4.2. Coming back to (1.18) and using Lemma 4.1, for any $p \in(1, \infty)$, we have

$$
L G_{\varepsilon}=\nabla G_{\varepsilon} \cdot \nabla V_{\varepsilon}+G_{\varepsilon} \Delta V_{\varepsilon} \in L^{p}
$$

where $L$ denotes the operator $L G_{\varepsilon}:=\Delta G_{\varepsilon}-\nabla \cdot\left(\frac{1}{2} x G_{\varepsilon}\right)$. By elliptic regularity we obtain that $G_{\varepsilon}$ is uniformly bounded (with respect to $\varepsilon \in(0,1 / 2)$ ) in $W^{2, p}$. Thanks to previous estimates and Lemma 4.1, there exists $(\bar{G}, \bar{V})$ and a subsequence (still denoted as $\left.\left(G_{\varepsilon}, V_{\varepsilon}\right)\right)$ such that $G_{\varepsilon} \rightarrow \bar{G}$, $V_{\varepsilon} \rightarrow \bar{V}$. We may pass to the limit (in the weak sense) in the system of equations, and we find

$$
\bar{V}^{\prime \prime}+\frac{1}{r} \bar{V}^{\prime}+\bar{G}=0, \quad \bar{V}^{\prime}(0)=\bar{V}^{\prime}(\infty)=0
$$

We conclude that $(\bar{G}, \bar{V})$ is a solution to the stationary equation $(4.1)$, so that $(\bar{G}, \bar{V})=(G, V)$.
4.2. Splitting structure for the linearized operator. The evolution equation in self-similar variables writes (see (1.15) and (1.16))

$$
\left\{\begin{array}{l}
\partial_{t} g=\Delta g+\nabla\left(\frac{1}{2} x g-g \nabla v\right)  \tag{4.6}\\
\partial_{t} v=\frac{1}{\varepsilon}(\Delta v+g)+\frac{1}{2} x \cdot \nabla v
\end{array}\right.
$$

and the associated linearized equation around the self-similar profile $\left(G_{\varepsilon}, V_{\varepsilon}\right)$ is given by

$$
\left\{\begin{array}{l}
\partial_{t} f=\Lambda_{1, \varepsilon}(f, u):=\Delta f+\nabla\left(\frac{1}{2} x f-f \nabla V_{\varepsilon}-G_{\varepsilon} \nabla u\right)  \tag{4.7}\\
\partial_{t} u=\Lambda_{2, \varepsilon}(f, u):=\frac{1}{\varepsilon}(\Delta u+f)+\frac{1}{2} x \cdot \nabla u
\end{array}\right.
$$

which we also denote $\partial_{t}(f, u)=\Lambda_{\varepsilon}(f, u)=\left(\Lambda_{1, \varepsilon}(f, u), \Lambda_{2, \varepsilon}(f, u)\right)$. From now on, we restrict ourselves to a radially symmetric setting.

We introduce some classical notation of operator theory. Let $X$ be a Banach space and consider a linear operator $\Lambda: X \rightarrow X$. We denote by $S_{\Lambda}(t)=e^{t \Lambda}$ the semigroup of operators generated by $\Lambda$, by $\Sigma(\Lambda)$ its spectrum and by $\Sigma_{d}(\Lambda)$ its discrete spectrum. Moreover, for two Banach spaces $X, Y$ we denote by $\mathscr{B}(X, Y)$ the space of bounded linear operators from $X$ to $Y$ and by $\|\cdot\|_{\mathscr{B}(X, Y)}$ its norm, with the usual shorthand $\mathscr{B}(X)=\mathscr{B}(X, X)$. We also define the subset $\Delta_{a} \subset \mathbb{C}$ for any $a \in \mathbb{R}$ by

We fix $k>7$ and we introduce the Hilbert space

X:=X_{1} \times X_{2}, \quad X_{1}:=L_{r a d}^{2} \cap L_{k, 0}^{2} \subset L_{k, 1}^{2}, \quad X_{2}=L_{r a d}^{2} \tag{4.9}
\end{equation*}

associated to the norm

$$
\begin{equation*}
\|(f, u)\|_{X}^{2}:=\|f\|_{L_{k}^{2}}^{2}+\|u\|_{L^{2}}^{2} \tag{4.10}
\end{equation*}
$$

Here $L_{\text {rad }}^{2}$ denotes the $L^{2}$ space of radially symmetric functions and $L_{k, j}^{2}, j<k$, the following space

$$
L_{k, j}^{2}:=\left\{g \in L_{k}^{2}\left|\int x^{\alpha} g=0, \forall \alpha \in \mathbb{N}^{2},|\alpha| \leq j\right\}\right.
$$

We now state a property of the spectrum of $\Lambda_{\varepsilon}$ in $X$ that is the main result of this subsection.
Proposition 4.3. There exist $\varepsilon^{*}, r^{*}>0$ such that in $X$

\forall \varepsilon \in\left(0, \varepsilon^{*}\right) \quad \Sigma\left(\Lambda_{\varepsilon}\right) \cap \Delta_{-1 / 3} \subset \Sigma_{d}\left(\Lambda_{\varepsilon}\right) \cap B\left(0, r^{*}\right)
$$

We define the bounded operator $\mathcal{A}=\left(\mathcal{A}_{1}, \mathcal{A}_{2}\right): X \rightarrow X$ by

\mathcal{A}_{1}(f, u):=N \chi_{R}[f]:=N\left(\chi_{R} f-\chi_{1}\left\langle\chi_{R} f\right\rangle\right), \quad \mathcal{A}_{2}(f, u):=0 \tag{4.11}
\end{equation*}
$$

for some constants $N, R>0$ to be chosen later and a smooth non-negative radially symmetric cut-off function $\chi_{R}(x):=\chi(x / R)$ with $\chi \equiv 1$ on $B_{1 / 2}, \operatorname{Supp} \chi \subset B_{2}$ and $\left\langle\chi_{1}\right\rangle=1$. We can split the operator $\Lambda_{\varepsilon}=\mathcal{A}+\mathcal{B}_{\varepsilon}$ and we shall investigate some properties of $\mathcal{A}$ and $\mathcal{B}_{\varepsilon}$ in the next lemmas before proving Proposition 4.3.

Lemma 4.4. In the above splitting, we may choose $N_{*}$ and $R_{*}$ large enough in such a way that for any $N \geq N_{*}, R \geq R_{*}$, the operator $\mathcal{B}_{\varepsilon}$ is a-hypo-dissipative in $X$ for any $a \in(-1 / 2,0)$, in the sense that

for some constant $C_{a}>0$.

Proof of Lemma 4.4. First of all, thanks to Lemma B. 1 and using the notation of Appendix B, we see that in $X$ the norm of $L_{k}^{2} \times L^{2}$ is equivalent to the norm defined by

for any fixed $\eta>0$. We also observe that, thanks to Lemma B.2, we have

thus we fix some $\ell \in(3, k)$ from now on.
We consider the equation

and split the proof into three steps.
Step 1. We write the equation satisfied by $f$ as

\partial_{t} f=\Delta f+\nabla\left(\frac{1}{2} x f-f \nabla V_{\varepsilon}-G_{\varepsilon} \nabla u\right)-N \chi_{R}[f]
$$

Using that $\langle f\rangle=0$ and the notation $\chi_{R}^{c}=1-\chi_{R}$, we compute

\frac{1}{2} \frac{d}{d t} \int f^{2}\langle x\rangle^{2 k}= & \int \Delta f f\langle x\rangle^{2 k}+\frac{1}{2} \int \nabla \cdot(x f) f\langle x\rangle^{2 k}-\int \nabla \cdot\left(f \nabla V_{\varepsilon}\right) f\langle x\rangle^{2 k} \\
& -\int \nabla \cdot\left(G_{\varepsilon} \nabla u\right) f\langle x\rangle^{2 k}-\int N \chi_{R}[f] f\langle x\rangle^{2 k} \\
= & -\int|\nabla f|^{2}\langle x\rangle^{2 k}+\int\left\{\varphi(x)-N \chi_{R}(x)\right\} f^{2}\langle x\rangle^{2 k}  \tag{4.14}\\
& -\int \nabla \cdot\left(G_{\varepsilon} \nabla u\right) f\langle x\rangle^{2 k}-N \int f \chi_{1}\langle x\rangle^{2 k} d x\left\langle\chi_{R}^{c} f\right\rangle
\end{align*}
$$

where

$$
\begin{aligned}
\varphi(x) & =\left(\frac{1}{2} \Delta\langle x\rangle^{2 k}-\frac{1}{2} x \cdot \nabla\langle x\rangle^{2 k}+\frac{1}{4} \nabla \cdot\left(x\langle x\rangle^{2 k}\right)-\frac{1}{2} \nabla \cdot\left(\nabla V_{\varepsilon}\langle x\rangle^{2 k}\right)+\nabla V_{\varepsilon} \cdot \nabla\langle x\rangle^{2 k}\right)\langle x\rangle^{-2 k} \\
& =-\frac{1}{2}(k-1)+k(2 k+1 / 2)\langle x\rangle^{-2}-k(2 k-2)\langle x\rangle^{-4}-\frac{1}{2} \Delta V_{\varepsilon}+k\left(\nabla V_{\varepsilon} \cdot x\right)\langle x\rangle^{-2}
\end{aligned}
$$

We observe that, thanks to Lemma 4.1, we have $\left(\nabla V_{\varepsilon} \cdot x\right)\langle x\rangle^{-2} \rightarrow 0$ as $|x| \rightarrow \infty$. From (1.18), we also have that

-\frac{1}{2} \Delta V_{\varepsilon}=\frac{1}{2} G_{\varepsilon}+\frac{\varepsilon}{4} x \cdot \nabla V_{\varepsilon}

with $G_{\varepsilon} \rightarrow 0$ as $|x| \rightarrow \infty$ from (4.2) and $\left|x \cdot \nabla V_{\varepsilon}\right| \leq C_{V_{\varepsilon}}$ from (4.3). All together, it follows

where $C>0$ is the constant exhibited in (4.3).
For the third term in (4.14), for any $\delta>0$, thanks to Hölder's inequality and using that $G_{\varepsilon}(x) \leq C\langle x\rangle^{-\alpha}$ from (4.2), we get

& \leq \delta\|\nabla f\|_{L^{2}}^{2}+C(\delta)\left\|\nabla\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\left\|\nabla \kappa_{f}\right\|_{L^{2}}^{2}+C\|f\|_{L^{2}}^{2} \\
& \leq \delta\|\nabla f\|_{L^{2}}^{2}+C(\delta)\left\|\nabla\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\|f\|_{L_{\ell}^{2}}^{2}+C\|f\|_{L^{2}}^{2},
\end{aligned}
$$

where we recall that we have fixed some $\ell \in(3, k)$. For the fourth term in (4.14), we have

\begin{aligned}
-N \int f \chi_{1}\langle x\rangle^{2 k} d x\left\langle\chi_{R}^{c} f\right\rangle & \leq N\left\|\chi_{1}\right\|_{L_{2 k-\ell}^{2}}\left\|\chi_{R}^{c}\langle x\rangle^{-\ell}\right\|_{L^{2}}\|f\|_{L_{\ell}^{2}}^{2} \\
& \leq N R^{1-\ell} C_{\ell}\|f\|_{L_{\ell}^{2}}^{2}
\end{aligned}
$$

We conclude this step by gathering the previous estimates to obtain

\frac{1}{2} \frac{d}{d t}\|f\|_{L_{k}^{2}}^{2} \leq & -(1-\delta)\|\nabla f\|_{L_{k}^{2}}^{2}+C(\delta)\left\|\nabla\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2} \\
& +\int\left\{\varphi(x)+\left(C(\delta)+C N R^{1-\ell}\right)\langle x\rangle^{2(\ell-k)}-N \chi_{R}(x)\right\} f^{2}\langle x\rangle^{2 k} \tag{4.16}
\end{align*}
$$

Step 2. From the second equation in (4.7), we have

\begin{gathered}
\frac{1}{2} \frac{d}{d t} \int\left(u-\kappa_{f}\right)^{2}=\int\left(u-\kappa_{f}\right)\left\{\frac{1}{\varepsilon}(\Delta u+f)+\frac{1}{2} x \cdot \nabla\left(u-\kappa_{f}\right)+\frac{1}{2} x \cdot \nabla \kappa_{f}-\partial_{t} \kappa_{f}\right\} \\
=-\frac{1}{\varepsilon} \int\left|\nabla\left(u-\kappa_{f}\right)\right|^{2}-\frac{1}{2} \int\left(u-\kappa_{f}\right)^{2}+\int\left(u-\kappa_{f}\right)\left\{\frac{1}{2} x \cdot \nabla \kappa_{f}-\partial_{t} \kappa_{f}\right\}
\end{gathered}
$$

and we shall estimate the last integral. Since $\partial_{t} \kappa_{f}=\kappa * \partial_{t} f$, we may write

& \int\left(u-\kappa_{f}\right)\left\{\frac{1}{2} x \cdot \nabla \kappa_{f}-\partial_{t} \kappa_{f}\right\}=\frac{1}{2} \int\left(u-\kappa_{f}\right)\left\{x \cdot \nabla \kappa_{f}\right\} \\
& -\int\left(u-\kappa_{f}\right) \kappa *\left\{\Delta f+\frac{1}{2} \nabla(x f)-\nabla\left(f \nabla V_{\varepsilon}\right)-\nabla\left(G_{\varepsilon} \nabla u\right)-N \chi_{R}[f]\right\},
\end{aligned}
$$

and we estimate each of these terms separately. First, we have

\begin{aligned}
I_{1} & :=\frac{1}{2} \int\left(u-\kappa_{f}\right)\left\{x \cdot \nabla \kappa_{f}\right\}=\frac{1}{2} \int\left(u-\kappa_{f}\right)\{x \cdot(\mathcal{K} * f)\} \\
& \leq \delta\left\|\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\|\mathcal{K} * f\|_{L_{1}^{2}}^{2} \\
& \leq \delta\left\|\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\|f\|_{L_{\ell}^{2}}^{2}
\end{aligned}
$$

where we have used Lemma B. 2 in the last line since $f \in X_{1} \subset L_{k, 1}^{2}$. Next, we have

\begin{aligned}
I_{2} & :=-\int\left(u-\kappa_{f}\right) \kappa *\{\Delta f\}=\int\left(u-\kappa_{f}\right) f \\
& \leq \delta\left\|\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\|f\|_{L^{2}}^{2}
\end{aligned}
$$

Arguing as for the term $I_{1}$ and using Lemma B.2, we also have (we denote here $\mathcal{K}=\left(\mathcal{K}_{i}\right)_{i=1,2}$ and use the convention of summation of repeated indices)

$$
\begin{aligned}
I_{3} & :=-\frac{1}{2} \int\left(u-\kappa_{f}\right) \kappa * \nabla(x f)=-\frac{1}{2} \int\left(u-\kappa_{f}\right) \mathcal{K}_{i} *\left(x_{i} f\right) \\
& \leq \delta\left\|\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\|f\|_{L_{\ell}^{2}}^{2}
\end{aligned}
$$

Furthermore, since $f \nabla V_{\varepsilon} \in L_{k, 0}^{2}$, we can apply Lemma B. 2 and use that $\nabla V_{\varepsilon} \in L^{\infty}$ to obtain

\begin{aligned}
I_{4} & :=\int\left(u-\kappa_{f}\right) \kappa * \nabla\left(f \nabla V_{\varepsilon}\right)=\int\left(u-\kappa_{f}\right) \mathcal{K}_{i} *\left(f \partial_{i} V_{\varepsilon}\right) \\
& \leq \delta\left\|\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\left\|f \nabla V_{\varepsilon}\right\|_{L_{\ell}^{2}}^{2} \\
& \leq \delta\left\|\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\|f\|_{L_{\ell}^{2}}^{2} .
\end{aligned}
$$

For the next term, using Lemma B.2, since $G_{\varepsilon} \nabla u \in L_{k, 0}^{2}$, and the bound $G_{\varepsilon} \in L_{k}^{\infty}$, we have

I_{5} & :=\int\left(u-\kappa_{f}\right) \kappa * \nabla\left(G_{\varepsilon} \nabla u\right)=\int\left(u-\kappa_{f}\right) \mathcal{K}_{i} *\left(G_{\varepsilon} \partial_{i} u\right) \\
& \leq \delta\left\|\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\left\|\mathcal{K} *\left(G_{\varepsilon} \nabla u\right)\right\|_{L^{2}}^{2} \\
& \leq \delta\left\|\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\left\|G_{\varepsilon} \nabla u\right\|_{L_{k}^{2}}^{2} \\
& \leq \delta\left\|\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\|\nabla u\|_{L^{2}}^{2} \\
& \leq \delta\left\|\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\left\|\nabla\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\left\|\nabla \kappa_{f}\right\|_{L^{2}}^{2} \\
& \leq \delta\left\|\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\left\|\nabla\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\|f\|_{L_{\ell}^{2}}^{2} .
\end{aligned}
$$

For the last term and thanks to Lemma B.1, we finally have

& \leq \delta\left\|u-\kappa_{f}\right\|_{L^{2}}^{2}+C(\delta) N^{2}\|f\|_{L_{\ell}^{2}}^{2} .
\end{aligned}
$$

Putting together all the estimates of this step, we deduce

\end{equation*}
$$

Step 3. Conclusion. Gathering (4.16) and (4.17), we obtain

\frac{1}{2} \frac{d}{d t}\|(f, u)\|_{X_{*}}^{2} & \leq \int\left\{\varphi(x)+\left[\left(1+\eta N^{2}\right) C(\delta)+\frac{C N}{R^{\ell-1}}\right]\langle x\rangle^{2(\ell-k)}-N \chi_{R}(x)\right\}|f|^{2}\langle x\rangle^{2 k}  \tag{4.18}\\
& -\eta\left(\frac{1}{2}-\delta\right)\left\|u-\kappa_{f}\right\|_{L^{2}}^{2}-(1-\delta)\|\nabla f\|_{L_{k}^{2}}^{2}-\eta\left(\frac{1}{\varepsilon}-C(\delta)\right)\left\|\nabla\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}
\end{align*}
$$

Taking then first $\delta \in(0,1)$ small enough and next $\varepsilon \in(0,1)$ small enough, it follows that for $\eta=N^{-3}$ and $R=N$

& +a \eta\left\|u-\kappa_{f}\right\|_{L^{2}}^{2}+a \eta\left\|\nabla\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}
\end{aligned}
$$

for any $a>-1 / 2$, where $\bar{\varphi}_{N}(x)=\varphi(x)+C\left(1+N^{-1}+N^{2-\ell}\right)\langle x\rangle^{2(\ell-k)}$ has the same asymptotic behaviour as $\varphi(x)$ when $|x| \rightarrow \infty$ and $\bar{\varphi}_{N}$ decreases as $N$ increases. We can choose $N$ large enough such that

which yields that $\mathcal{B}_{\varepsilon}$ is $a$-hypo-dissipative for any $a>-1 / 2$.

endowed with the norm

$$
\begin{equation*}
\|(f, u)\|_{Y}^{2}:=\|(f, u)\|_{X}^{2}+\|\nabla f\|_{L_{k}^{2}}^{2}+\|\nabla u\|_{L^{2}}^{2} \tag{4.20}
\end{equation*}
$$

For the operator $\mathcal{A}$ defined in (4.11), the following result holds true.
Lemma 4.5. There hold $\mathcal{A} \in \mathscr{B}(X)$ and $\mathcal{A} \in \mathscr{B}(Y)$.
Proof of Lemma 4.5. The proof is straightforward so we omit it.
Lemma 4.6. We can choose $N$ and $R$ large enough such that $\mathcal{B}_{\varepsilon}$ is a-hypo-dissipative in $Y$ for any $a \in(-1 / 2,0)$, i.e.

Moreover, we also have

Proof of Lemma 4.6. We introduce the following norm

\|(f, u)\|_{Y_{*}}^{2}:=\|(f, u)\|_{X_{*}}^{2}+\eta_{1}\|\nabla f\|_{L_{k}^{2}}^{2}+\eta_{1}\left\|\nabla\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2} \tag{4.21}
\end{equation*}
$$

which is equivalent to (4.20) for any $\eta_{1}>0$ thanks to Lemma B.2. We recall that, as in Lemma 4.4, we have

$$

We consider now the equation (4.13) and we split the proof of the announced results into three steps.
Step 1. $L^{2}$ differential inequality. For $i=1,2, \partial_{i} u$ verifies

& +\frac{1}{2} \int \partial_{i}\left(u-\kappa_{f}\right) x \cdot \nabla\left\{\partial_{i}\left(u-\kappa_{f}\right)\right\}+\frac{1}{2} \int \partial_{i}\left(u-\kappa_{f}\right) x \cdot \nabla\left\{\partial_{i} \kappa_{f}\right\} \\
& -\int \partial_{i}\left(u-\kappa_{f}\right) \mathcal{K}_{i} *\left(\partial_{t} f\right) \\
= & : T_{1}+T_{2}+T_{3}+T_{4}+T_{5}
\end{aligned}
$$

For the first term, we easily have

For the second term, we have

We also easily see that

T_{4} \leq C\left\|\nabla\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C\left\|D^{2} \kappa_{f}\right\|_{L_{1}^{2}}^{2} \leq C\left\|\nabla\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C\|f\|_{L_{1}^{2}}^{2}
$$

For the last term $T_{5}$, we use the equation satisfied by $f$ and we get

& =: T_{51}+T_{52}+T_{53}+T_{54}+T_{55}

We estimate each term separately. We have

Using that $\nabla V_{\varepsilon} \in L^{\infty}$, we have

\end{aligned}

and arguing as above with $G_{\varepsilon} \in L^{\infty}$, we also obtain

& \leq C\left\|\nabla\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C\|\nabla u\|_{L^{2}}^{2} \\
& \leq C\left\|\nabla\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C\|f\|_{L_{\ell}^{2}}^{2} .

Step 2. $H^{1}$ differential inequality. We write the equation satisfied by $\partial_{i} f$ which is nothing but

and then we can write

& -\int \nabla\left(\partial_{j} G_{\varepsilon} \nabla u\right) \partial_{i} f\langle x\rangle^{2 k}-N \int\left(\partial_{i} \chi_{R}\right) f \partial_{i} f\langle x\rangle^{2 k}+N\left\langle\chi_{R} f\right\rangle \int\left(\partial_{i} \chi_{1}\right) \partial_{i} f\langle x\rangle^{2 k} \\
= & : A_{1}+A_{2}+A_{3}+A_{4}+A_{5}+A_{6}
\end{aligned}
$$

Arguing as in the first step of Lemma 4.4, for any $\delta>0$, we have

\end{aligned}
$$

We next compute

\end{aligned}

using that $\Delta V_{\varepsilon}=-G_{\varepsilon}-(\varepsilon / 2) x \cdot \nabla V_{\varepsilon}$ and Lemma 4.1. We also have

& \leq C(\delta)\left\|\nabla\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+C(\delta)\|f\|_{L_{\ell}^{2}}^{2}+\delta\|\nabla f\|_{L_{k-1 / 2}^{2}}^{2}+\delta\left\|\nabla^{2} f\right\|_{L_{k}^{2}}^{2}
\end{aligned}

\psi^{0}(x):=\varepsilon C(\delta)+N \frac{C}{R} \mathbf{1}_{R / 2 \leq|x| \leq 2 R}+C(\delta)\langle x\rangle^{2(\ell-k)}+C(\delta) N^{2}\langle x\rangle^{-2 k}
$$

and

\psi^{1}(x):=\varphi(x)-\frac{1}{2}+\delta+N \frac{C}{R} \mathbf{1}_{R / 2 \leq|x| \leq 2 R}+\left[C(\delta)+C N R^{1-\ell}\right]\langle x\rangle^{2(\ell-k)}-N \chi_{R}

Step 3. Conclusion. We gather estimates (4.22), (4.23) and (4.18), and we get

& \quad+\eta_{1} \int \psi^{1}(x)|\nabla f|^{2}\langle x\rangle^{2 k}-(1-\delta)\|\nabla f\|_{L_{k}^{2}}^{2}  \tag{4.24}\\
& \quad-\eta\left(\frac{1}{2}-\delta\right)\left\|u-\kappa_{f}\right\|_{L^{2}}^{2}-\eta_{1}(1-\delta)\left\|\nabla^{2} f\right\|_{L_{k}^{2}}^{2} \\
& \quad-\eta\left(\frac{1}{\varepsilon}-C(\delta)-\frac{\eta_{1}}{\eta} C(\delta)\right)\left\|\nabla\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}-\eta_{1}\left(\frac{1}{\varepsilon}-C(\delta)\right)\left\|\nabla^{2}\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}

Now we conclude as in Step 3 of the proof of Lemma 4.4. We choose first $\delta \in(0,1)$ small enough, next $\varepsilon \in(0,1)$ small enough and then $\eta_{1}=\eta=N^{-3}$ and $R=N$ in the above inequality. For any $a>-1 / 2$, we obtain

& +a \eta_{1}\left\|\nabla\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}+a \eta_{1}\left\|\nabla^{2}\left(u-\kappa_{f}\right)\right\|_{L^{2}}^{2}
\end{align*}
$$

where
$\varphi_{N}^{1}(x):=\varphi(x)+C N^{-3}+C N^{-1} \mathbf{1}_{R / 2 \leq|x| \leq 2 R}+\left(C+C N^{-1}+C N^{-3}+C N^{2-\ell}\right)\langle x\rangle^{2(\ell-k)}+C N^{-1}\langle x\rangle^{-2 k}$ and

have the same asymptotic behaviour as $\varphi(x)$ when $|x| \rightarrow \infty$ and are decreasing as a function of $N$. Picking $N$ large enough such that

and we recall that $X=L_{k, 0}^{2} \cap L_{r a d}^{2} \times L_{r a d}^{2}$ and $Y=H_{k}^{1} \cap L_{k, 0}^{2} \cap L_{r a d}^{2} \times H^{1} \cap L_{r a d}^{2}$ (see equations (4.9) and (4.19)). We define a family of interpolation spaces

so that $X^{0}=X, X^{1}=\mathrm{D}\left(\Lambda_{\varepsilon}\right)$ and $X^{1 / 2}=Y$. Thanks to classical interpolation results we have $Y=X^{1 / 2} \subset \mathrm{D}\left(\Lambda_{\varepsilon}^{\eta}\right)$ for any $\eta \in[0,1 / 2)$, see $[23,25,28]$. Now we fix some $\eta \in(0,1 / 2)$ and we have $Y \subset \mathrm{D}\left(\Lambda_{\varepsilon}^{\eta}\right) \subset X$.

Recalling the results from Lemma 4.4, Lemma 4.5, Lemma 4.6 and (4.11) we have, for any $a>-1 / 2$,

& S_{\mathcal{B}_{\varepsilon}}(t): X \rightarrow Y, \quad \text { with } \quad\left\|S_{\mathcal{B}_{\varepsilon}}(t)\right\|_{\mathscr{B}(X, Y)} \leq C t^{-1 / 2} e^{a t},
\end{aligned}
$$

moreover $\mathcal{A} \in \mathscr{B}(X) \cap \mathscr{B}(Y)$ and

First, from the previous estimates, we immediately obtain, for any $a>-1 / 2$,

Moreover, from [18, Lemma 2.17] there exists $n \in \mathbb{N}$ such that

which together with the fact $S_{\mathcal{B}_{\varepsilon}}(t): \mathrm{D}\left(\Lambda_{\varepsilon}^{\eta}\right) \rightarrow \mathrm{D}\left(\Lambda_{\varepsilon}^{\eta}\right)$ with $\left\|S_{\mathcal{B}_{\varepsilon}}(t)\right\|_{\mathscr{B}\left(\mathrm{D}\left(\Lambda_{\varepsilon}^{\eta}\right)\right)} \leq C e^{a t}$ (by interpolation of the same results in $X$ and $Y$ ), yield

\left\|S_{\mathcal{B}_{\varepsilon}} *\left(\mathcal{A} S_{\mathcal{B}_{\varepsilon}}\right)^{(* n)}(t)\right\|_{\mathscr{B}\left(X, \mathrm{D}\left(\Lambda_{\varepsilon}^{\eta}\right)\right)} \leq C e^{a t} \tag{4.28}
\end{equation*}
$$

Gathering that last estimate with (4.27), we can apply [28, Theorem 2.1] which yields, for some $r^{*}>0$,

\Sigma\left(\Lambda_{\varepsilon}\right) \cap \Delta_{a} \subset B\left(0, r^{*}\right) \quad \text { on } \quad X
$$

From the previous estimates together with the fact that $\mathcal{A} \in \mathscr{B}\left(X, L_{k+1}^{2} \times L_{k+1}^{2}\right)$, we also obtain

where $\bar{Y}:=Y \cap\left(L_{k+1}^{2} \times L_{k+1}^{2}\right) \subset X$ with compact embedding. Hence, thanks to (4.27)-(4.28)(4.29), we are able to apply [28, Theorem 3.1] that implies

and that concludes the proof.
4.3. Localization of the spectrum for the linearized operator in a radially symmetric setting. We recall that we consider a radially symmetric setting and we have already defined the space $X$ in (4.9). We establish in this subsection the following localization of the spectrum of $\Lambda_{\varepsilon}$.
Theorem 4.7. There exists $\varepsilon^{*}>0$ such that in $X$ there holds

\Sigma\left(\Lambda_{\varepsilon}\right) \cap \Delta_{-1 / 3}=\emptyset \quad \text { for any } \quad \varepsilon \in\left(0, \varepsilon^{*}\right)
$$

As a consequence, there exists $C$ such that

\left\|S_{\Lambda_{\varepsilon}}(t)\right\|_{\mathscr{B}(X)} \leq C e^{-t / 3} \quad \forall t \geq 0, \forall \varepsilon \in\left(0, \varepsilon^{*}\right)
$$

The difficulty is that $\Lambda_{\varepsilon}$ is not a perturbation of some fixed operator $\Lambda$ and we cannot apply directly the perturbation theory developed in $[27,36]$. However, we are able to identify the limit of $\mathcal{R}_{\Lambda_{\varepsilon}}$ as $\varepsilon \rightarrow 0$ which is enough to conclude.

We introduce the notations

$$
\begin{aligned}
A f & :=\Delta f+\nabla\left(\frac{1}{2} x f-f \nabla V_{\varepsilon}\right), \quad B u:=-\nabla\left(G_{\varepsilon} \nabla u\right) \\
C u & :=\Delta u, \quad D u:=\frac{1}{2} x \cdot \nabla u
\end{aligned}
$$

so that the linearized equation writes

The important point is that at a very formal level, the limit system (as $\varepsilon \rightarrow 0)$ is the linearized parabolic-elliptic system

with $G$ and $V$ defined in (4.1), which simplifies into a single equation

\partial_{t} f=\left(A_{0}+B_{0}(-C)^{-1}\right) f=: \Omega f \tag{4.32}
\end{equation*}
$$

Observe that the last equation is nothing but the linearized equation associated to parabolicelliptic Keller-Segel equation which has been studied in $[8,9,14]$ and for which it has been proved therein that the associated semigroup is exponentially stable in several weighted Lebesgue spaces. In the sequel we explain why the linearized parabolic-parabolic system inherits that exponential stability at least for $\varepsilon>0$ small enough.

We recall the following result which is an immediate consequence of [9, Section 6.1] and [14, Theorem 4.3].

Theorem 4.8. There exists a constant $C$ such that

$$

where $X_{1}=L_{\text {rad }}^{2} \cap L_{k, 0}^{2}$ is defined in (4.9).
In order to formalize the link between the linearized parabolic-parabolic equation and the linearized parabolic-elliptic equation, we write the linearized parabolic-parabolic system (4.30) into the matrix form

For the analysis of the spectrum of $\Lambda_{\varepsilon}$, for any $z \in \mathbb{C}$, we denote

a & b \\
c & d
\end{array}\right)
$$

with

a=A(z)=A-z, \quad b=B, \quad c:=\varepsilon^{-1} I, \quad d:=\varepsilon^{-1} C+D(z), \quad D(z)=D-z
$$

One can readily verify that for $z \in \mathbb{C}$ such that $d=d(z)$ and its Schur's complement

s_{\varepsilon}=s_{\varepsilon}(z):=a-b d^{-1} c=A-B(C+\varepsilon D)^{-1}
$$

are invertible, the resolvent of $\Lambda_{\varepsilon}$ is given by

s_{\varepsilon}^{-1} & -s_{\varepsilon}^{-1} b d^{-1} \\
-d^{-1} c s_{\varepsilon}^{-1} & d^{-1}+d^{-1} c s_{\varepsilon}^{-1} b d^{-1}
\end{array}\right)=:\left(\begin{array}{cc}
\mathcal{R}_{11}^{\Lambda_{\varepsilon}} & \mathcal{R}_{12}^{\Lambda_{\varepsilon}} \\
\mathcal{R}_{21}^{\Lambda_{\varepsilon}} & \mathcal{R}_{2}^{\Lambda_{\varepsilon}}
\end{array}\right)
$$

Then, at least formally, we see that

\mathcal{R}_{\Omega}(z) & 0  \tag{4.33}\\

\end{array}\right)
$$

Indeed, on the one hand, we have

\mathcal{R}_{11}^{\Lambda_{\varepsilon}} & =s_{\varepsilon}^{-1}=\left\{A-z-B\left(\varepsilon^{-1} C+D-z\right)^{-1} \varepsilon^{-1} I\right\}^{-1} \\
& =\left\{A-z-B(C+\varepsilon D-\varepsilon z)^{-1}\right\}^{-1} \underset{\varepsilon \rightarrow 0}{\longrightarrow}\left(A_{0}-B_{0} C^{-1}-z\right)^{-1}=\mathcal{R}_{\Omega}(z)
\end{aligned}
$$

and

$$
\begin{aligned}
\mathcal{R}_{21}^{\Lambda_{\varepsilon}} & =-d^{-1} c s^{-1}=-\left(\varepsilon^{-1} C+D-z\right)^{-1} \varepsilon^{-1} I\left\{A-z-B(C+\varepsilon D-\varepsilon z)^{-1}\right\}^{-1} \\
& =-(C+\varepsilon D-\varepsilon z)^{-1}\left\{A-z-B(C+\varepsilon(D-z))^{-1}\right\}^{-1} \\
& \xrightarrow[\varepsilon \rightarrow 0]{\longrightarrow}-C^{-1}\left(A_{0}-B_{0} C^{-1}-z\right)^{-1}=-C^{-1} \mathcal{R}_{\Omega}(z)
\end{aligned}
$$

In the same way, we have

$$
\mathcal{R}_{12}^{\Lambda_{\varepsilon}}=-s^{-1} b d^{-1}=-\varepsilon\left\{A-z-B(C+\varepsilon D-\varepsilon z)^{-1}\right\}^{-1} B(C+\varepsilon D-\varepsilon z)^{-1}
$$

as well as

$$
\begin{aligned}
& \mathcal{R}_{22}^{\Lambda_{\varepsilon}}=d^{-1}+d^{-1} c s^{-1} b d^{-1} \\
& =\varepsilon(C+\varepsilon D-\varepsilon z)^{-1}+\varepsilon(C+\varepsilon D-\varepsilon z)^{-1}\left\{A-z-B(C+\varepsilon D-\varepsilon z)^{-1}\right\}^{-1} B(C+\varepsilon D-\varepsilon z)^{-1}
\end{aligned}
$$

and then both last terms vanish in the limit $\varepsilon \rightarrow 0$.
In fact, we will not try to prove that convergence (4.33) rigorously holds, but we will just prove the following result. We define, for a given $\rho>0$,

Before proving Proposition 4.9 we establish some estimates on the terms involved in $\mathcal{R}_{\Lambda_{\varepsilon}}$.

is bounded uniformly for $z \in \mathcal{O}_{\rho}$. More precisely, for $f \in L_{k, 0}^{2}$ we write

$$

where we define the coefficients $\lambda_{i} \in \mathbb{R}$ by

and the functions $F_{i}$ by

$$

so that it holds

\int_{0}^{\infty} F_{1}(r)\left(1, r^{2}, r^{4}\right) r d r=(0,1,0), \quad \int_{0}^{\infty} F_{2}(r)\left(1, r^{2}, r^{4}\right) r d r=(0,0,1)
$$

and hence $f_{0} \in L_{k, 5}^{2}$.
We may then solve the equation

so that $\langle r\rangle\left|u_{i}^{\prime}\right| \leq C,|u| \leq C \log (1+\langle r\rangle)$, and $u_{0} \in L_{r a d}^{2} \cap L_{4}^{2}, \nabla u_{0} \in L_{5}^{2}$ is the unique solution to the above Poisson equation as given by Lemma B. 1 and Lemma B.2. As a consequence, $g_{0}:=$ $D(z) u_{0} \in L_{4,1}^{2}$ and $g_{i}:=r u_{i}^{\prime}+z u_{i}$ satisfy the estimates $g_{i} e^{-r / 2} \in L^{\infty}$ for $i=1,2$. Thanks to Lemmas C. 1 and C. 2 and using the notation of Appendix C, we have $v_{i}:=L_{\varepsilon}^{-1} g_{i}$ which satisfy $\left\|v_{0}\right\|_{\dot{H}^{1} \cap \dot{H}^{2}} \leq C\left\|g_{0}\right\|_{L_{4,1}^{2}}$, while for $i=1,2, v_{i}$ satisfy the estimates

\left\|v_{i} e^{-(1+\varepsilon|z|) r}\right\|_{L^{\infty}}+\left\|v_{i}^{\prime} e^{-(1+\varepsilon|z|) r}\right\|_{L^{\infty}} \leq C\left\|g_{i} e^{-r / 2}\right\|_{L^{\infty}} .
$$

Finally, we solve the equation $w_{i}:=B v_{i}$, which means

and the previous estimates together with the bound (4.2) yield $w=w_{0}+w_{1}+w_{2} \in L_{k, 0}^{2} \cap L_{r a d}^{2}=$ $X_{1}$.
Lemma 4.11. With the above notation, for any $\rho>0$, there exists $C_{\rho}$ such that

\sup _{z \in \mathcal{O}_{\rho}}\left\|d^{-1}(z)\right\|_{\mathscr{B}\left(X_{2}\right)} \leq C_{\rho} \tag{4.34}
\end{equation*}
$$

Proof of Lemma 4.11. Consider the equation

\begin{equation*}
d(z) v=\varepsilon^{-1} \Delta v+\frac{1}{2} x \cdot \nabla v-z v=u \tag{4.35}
\end{equation*}
$$

for $z \in \Delta_{a} \cap B(0, \rho)$. Multiplying the equation by $\bar{v}$ and the conjugated equation by $v$, we find

\frac{1}{\varepsilon} \int|\nabla v|^{2}+\left(\frac{1}{2}+\Re e z\right) \int|v|^{2} & =-\frac{1}{2} \int v \bar{u}-\frac{1}{2} \int \bar{v} u  \tag{4.36}\\
& \leq\|u\|_{L^{2}}\|v\|_{L^{2}}
\end{align*}
$$

and then

$$
\left(\frac{1}{2}+\Re e z\right)\|v\|_{L^{2}} \leq\|u\|_{L^{2}}
$$

which is nothing but (4.34).
Lemma 4.12. With the above notations, for any $\rho>0$, there exists $C_{k, a, \rho}>0$ such that

\sup _{z \in \mathcal{O}_{\rho}}\left\|b d^{-1}(z)\right\|_{\mathscr{B}\left(X_{2}, X_{1}\right)} \leq C_{k, a, \rho} \sqrt{\varepsilon} \rightarrow 0 \tag{4.37}
\end{equation*}
$$

Proof of Lemma 4.12. Consider the equation (4.35) again. Coming back to (4.36), we have

Proof of Lemma 4.13. We just have to use appendix B.
Proof of Proposition 4.9. We split the proof into four steps.
Step 1. We prove that

\forall \varepsilon \in\left(0, \varepsilon_{\rho}^{*}\right) \quad \mathcal{R}_{11}^{\Lambda_{\varepsilon}}=s_{\varepsilon}^{-1} \in \mathcal{H}\left(\mathcal{O}_{\rho} ; \mathscr{B}\left(X_{1}\right)\right) \tag{4.41}
\end{equation*}

We write

$s_{0}(z)=A(z)-B C^{-1}, \quad \Omega(z)=\Omega-z=A_{0}(z)-B_{0} C^{-1}, \quad \tilde{s}(z):=B(C+\varepsilon D(z))^{-1}(-D(z)) C^{-1}$.
We remark that

s_{0}(z)-\Omega(z)=s_{0}-\Omega=-\nabla\left(\cdot \nabla\left(V_{\varepsilon}-V\right)\right)-\nabla\left(\left(G_{\varepsilon}-G\right) \nabla\left(\Delta^{-1} \cdot\right)\right)
$$

does not depend on $z$, and thanks to Corollary 4.2, we easily get

Then, arguing as is [36, Lemma 2.16], the operator

$$

satisfies

$$
\left\|\mathcal{T}_{\varepsilon}(z)\right\|_{\mathscr{B}\left(X_{1}\right)} \leq \eta^{\prime}(\varepsilon) \quad \forall z \in \mathcal{O}_{\rho}, \quad \eta^{\prime}(\varepsilon) \rightarrow 0 \quad \text { as } \quad \varepsilon \rightarrow 0
$$

where

$$
\mathcal{R}_{\mathcal{B}_{\varepsilon}}=:\left(\begin{array}{cc}
\mathcal{R}_{11}^{\mathcal{B}_{\varepsilon}} & \mathcal{R}_{12}^{\mathcal{B}_{\varepsilon}} \\
\mathcal{R}_{21}^{\mathcal{B}_{\varepsilon}} & \mathcal{R}_{22}^{\mathcal{B}_{\varepsilon}}
\end{array}\right), \quad \mathcal{A}=:\left(\begin{array}{cc}
\mathcal{A}_{11} & 0 \\
0 & 0
\end{array}\right)
$$

and the integer $n$ is defined in the proof of Proposition 4.3. As a consequence, the operators $I+\mathcal{T}_{\varepsilon}(z)$ and $s_{\varepsilon}(z)$ are invertible for any $z \in \mathcal{O}_{\rho}$, and furthermore

$$
\mathcal{R}_{11}^{\Lambda_{\varepsilon}}(z)=s_{\varepsilon}(z)^{-1}=\mathcal{U}_{\varepsilon}(z)\left(1+\mathcal{T}_{\varepsilon}(z)\right)^{-1}
$$

where

$$
\mathcal{U}_{\varepsilon}(z)=\sum_{j=0}^{n-1}(-1)^{j} \mathcal{R}_{11}^{\mathcal{B}_{\varepsilon}}(z)\left(\mathcal{A}_{11} \mathcal{R}_{11}^{\mathcal{B}_{\varepsilon}}(z)\right)^{j}+(-1)^{n} \mathcal{R}_{\Omega}(z)\left(\mathcal{A}_{11} \mathcal{R}_{11}^{\mathcal{B}_{\varepsilon}}(z)\right)^{n}
$$

We immediately conclude to (4.41), because $\Sigma(\Omega) \cap \Delta_{a}=\emptyset$ on $X_{1}$, and $\left\|R_{\Omega}(z)\right\|_{\mathscr{B}\left(X_{1}\right)} \leq C$ for any $z \in \mathcal{O}_{\rho}$ from Theorem 4.8.
Step 2. We have

$$
\begin{equation*}
\forall \varepsilon \in\left(0, \varepsilon_{\rho}^{*}\right) \quad \mathcal{R}_{12}^{\Lambda_{\varepsilon}}:=-s_{\varepsilon}^{-1} b d^{-1} \in \mathcal{H}\left(\mathcal{O}_{\rho} ; \mathscr{B}\left(X_{2}, X_{1}\right)\right), \tag{4.42}
\end{equation*}
$$

as an immediate consequence of Lemmas 4.10 and 4.12.
Step 3. We also have

$$
\begin{equation*}
\forall \varepsilon \in\left(0, \varepsilon_{\rho}^{*}\right) \quad \mathcal{R}_{21}^{\Lambda_{\varepsilon}}:=-d^{-1} c s_{\varepsilon}^{-1} \in \mathcal{H}\left(\mathcal{O}_{\rho} ; \mathscr{B}\left(X_{1}, X_{2}\right)\right), \tag{4.43}
\end{equation*}
$$

as a consequence of Lemmas 4.10 and 4.13.
Step 4. We finally have

$$
\begin{equation*}
\forall \varepsilon \in\left(0, \varepsilon_{\rho}^{*}\right) \quad \mathcal{R}_{22}^{\Lambda_{\varepsilon}}:=d^{-1}+d^{-1} c s_{\varepsilon}^{-1} b d^{-1} \in \mathcal{H}\left(\mathcal{O}_{\rho} ; \mathscr{B}\left(X_{2}\right)\right) \tag{4.44}
\end{equation*}
$$

as an immediate consequence of Step 1 together with Lemmas 4.12 and 4.13.
Proof of Theorem 4.7. The proof is a consequence of Proposition 4.3, Proposition 4.9 and Theorem 4.8 together with [28, Theorem 2.1].

## 5. Nonlinear exponential stability of self-similar solutions

### 5.1. Linear stability in higher-order norms. Define the space

$$
\begin{equation*}
Z:=Z_{1} \times Z_{2}, \quad Z_{1}:=H_{k}^{1} \cap L_{k, 0}^{2} \cap L_{r a d}^{2}, \quad Z_{2}:=H^{2} \cap L_{r a d}^{2} \tag{5.1}
\end{equation*}
$$

associated to the norm

$$
\begin{equation*}
\|(f, u)\|_{Z}^{2}:=\|(f, u)\|_{Y}^{2}+\left\|\nabla^{2} u\right\|_{L^{2}}^{2} \tag{5.2}
\end{equation*}
$$

We shall prove that the same linear stability estimate in $X$ established in Theorem 4.7 also holds in $Z$, as stated in the following result.
Proposition 5.1. There exists $\varepsilon^{*}>0$ such that there holds in $Z$

$$
\Sigma\left(\Lambda_{\varepsilon}\right) \cap \Delta_{-1 / 3}=\emptyset, \quad \forall \varepsilon \in\left(0, \varepsilon^{*}\right)
$$

As a consequence we have

$$
\left\|S_{\Lambda_{\varepsilon}}(t)\right\|_{\mathscr{B}(Z)} \leq C e^{-t / 3}, \quad \forall t \geq 0, \forall \varepsilon \in\left(0, \varepsilon^{*}\right)
$$

Before proving Proposition 5.1, we state and prove an auxiliary technical result.
Lemma 5.2. (1) $\mathcal{A} \in \mathscr{B}(Z)$.
(2) There exist $N$, $R$ large enough such that the operator $\mathcal{B}_{\varepsilon}$ is a-hypo-dissipative in $Z$, i.e.

\left\|S_{\mathcal{B}_{\varepsilon}}(t)\right\|_{\mathscr{B}(Z)} \leq C e^{a t}, \quad \forall t \geq 0
$$

Moreover, we have the following estimate

Proof. Point (1) is straightforward from (4.11) and we omit the proof. For proving point (2), we consider a solution $(f, u)$ to the equation $\partial_{t}(f, u)=\mathcal{B}_{\varepsilon}(f, u)$. First of all, observe that the norm $\|\cdot\|_{Z}$ is equivalent to

for any $\eta_{2}>0$. We write

& \quad+\eta_{1} \int\left\{\varphi(x)-\frac{1}{2}+\delta+C \frac{N}{R} \mathbf{1}_{R / 2 \leq|x| \leq 2 R}+\left[C(\delta)+C \frac{N}{R^{\ell-1}}\right]\langle x\rangle^{2(\ell-k)}\right. \\
& \left.\quad+C\langle x\rangle^{-2 k}+\frac{\eta_{2}}{\eta_{1}} C\langle x\rangle^{2(1-k)}-N \chi_{R}\right\}|\nabla f|^{2}\langle x\rangle^{2 k} \\

5.3. The nonlinear problem : Proof of theorem 1.4. We focus now on the nonlinear parabolicparabolic Keller-Segel system (1.15)-(1.16) in self-similar variables and we prove Theorem 1.4. Consider a solution $(g, v)$ to (1.15)-(1.16) and define $f:=g-G_{\varepsilon}$ and $u:=v-V_{\varepsilon}$, which satisfy

Lemma 5.3. The solution $\left(f_{t}, u_{t}\right)$ to (5.7) satisfies, at least formally, the following differential inequality

\end{aligned}
$$

For the second (nonlinear) term, we use the linear stability in $Z$ from Proposition 5.1 to obtain

& \leq \eta\|(f, u)\|_{Z}\|Q(f, u)\|_{Z}+C \int_{0}^{\infty} e^{a t}\|(f, u)\|_{Z} e^{a t}\|Q(f, u)\|_{Z} d \tau \\
& \leq C\|(f, u)\|_{Z}\|Q(f, u)\|_{Z}
\end{aligned}

Now, we have to compute

where we have used the embedding $H^{2}\left(\mathbb{R}^{2}\right) \hookrightarrow L^{\infty}\left(\mathbb{R}^{2}\right)$. Moreover, we have

Furthermore, we have

& \leq C\left\|\nabla^{3} u\right\|_{L^{2}}^{2}\|f\|_{H_{k}^{2}}^{2}+C\|f\|_{L_{k}^{2}}\|f\|_{H_{k}^{2}}\|\nabla u\|_{L^{2}}\left\|\nabla^{3} u\right\|_{L^{2}}^{2} \\
& \leq C\|(f, u)\|_{\widetilde{Z}}^{4}
\end{aligned}

where we have used the Gagliardo-Niremberg-Sobolev inequality $\|h\|_{L^{4}\left(\mathbb{R}^{2}\right)}^{2} \leq C\|h\|_{L^{2}\left(\mathbb{R}^{2}\right)}\|\nabla h\|_{L^{2}\left(\mathbb{R}^{2}\right)}$. For the last term, we have

& \leq C\left\|\langle x\rangle^{k} \nabla f\right\|_{L^{4}}^{2}\left\|\nabla^{2} u\right\|_{L^{4}}^{2}+C\|\nabla u\|_{L^{\infty}}^{2}\left\|\nabla^{2} f\right\|_{L_{k}^{2}}^{2} \\
& \leq C\|f\|_{L_{k}^{2}}\|f\|_{H_{k}^{2}}\|\nabla u\|_{L^{2}}\left\|\nabla^{3} u\right\|_{L^{2}}^{2}+C\|u\|_{H^{3}}^{2}\left\|\nabla^{2} f\right\|_{H_{k}^{2}}^{2} \\
& \leq C\|(f, u)\|_{\tilde{Z}}^{4} .
\end{aligned}

Finally, gathering the above estimates, the solution $(f, u)$ of (5.7) verifies

5.3.2. Regularity. We prove that starting close enough to the self-similar profile, the solution to the Keller-Segel equation (1.1) satisfies some strong and uniform in time estimates.
Proposition 5.4. There is $\delta>0$ such that, if $\left\|\left\|\left(f_{0}, u_{0}\right)\right\|_{Z} \leq \delta\right.$, there exists a solution $(f, u) \in$ $C([0, \infty) ; Z)$ to (5.7) (and thus to the Keller-Segel equation (1.1)) that verifies

Proof of Proposition 5.4. At least formally, taking $\delta:=K /(2 C)$ in (5.8), we see that $t \mapsto\|(f, u)(t)\|_{Z}$ is decreasing if $\left\|\left(f_{0}, u_{0}\right)\right\|_{Z} \leq \delta$, and then the a priori estimate (5.9) immediately follows from (5.8). We refer to [18, Theorem 5.3] for a completely rigorous proof based on an iterative scheme.
5.3.3. Sharp exponential convergence to the equilibrium. We now complete the proof of Theorem 1.4 following [18]. Applying Lemma 5.3 to the solution $(f, u)$ constructed above and using the estimate (5.9), we obtain

If $\delta>0$ is small enough so that $-K+C^{\prime} \delta^{2} \leq-K / 2$, this differential inequality implies the exponential decay

Finally, we can recover the optimal decay rate $O\left(e^{a t}\right)$ of the linearized semigroup in Proposition 5.1 by performing a bootstrap argument as in [18, Proof of Theorem 5.3], and that concludes the proof.

## Appendix A. Orlicz space, interpolation and a convex function

We describe here some classical and technical results on Orlicz spaces and interpolation spaces. We then apply these results to the function $\xi \mapsto \xi^{2}(\widetilde{\log } \xi)^{2}$ used during the proof of Lemma 2.7.
A.1. Basic notions. We recall some basic notions of the theory of Orlicz spaces, and we refer to $[24,34]$ for more details. We say that a function $\Phi: \mathbb{R}^{+} \rightarrow \mathbb{R}^{+}$is a $N$-function if it is continuous, convex, $\Phi(t)>0$ for any $t>0$ and satisfies

$$
\lim _{t \rightarrow 0} \frac{\Phi(t)}{t}=0, \quad \lim _{t \rightarrow \infty} \frac{\Phi(t)}{t}=\infty
$$

For such a function $\Phi$, we define the Orlicz space $L_{\Phi}$ by

$$
f \in L_{\Phi} \quad \Leftrightarrow \quad \exists \lambda>0 \text { such that } \int \Phi\left(\frac{f}{\lambda}\right)<\infty
$$

and we endow $L_{\phi}$ with the Luxembourg norm

$$
\|f\|_{L_{\Phi}}:=\inf \left\{\lambda>0: \int \Phi\left(\frac{f}{\lambda}\right) \leq 1\right\}
$$

Moreover, when $\Phi$ satisfies the following $\Delta_{2}$-condition,

$$
\exists c, s>0, \quad \forall t \geq s, \quad \Phi(2 t) \leq c \Phi(t)
$$

we have

$$
\|f\|_{L_{\Phi}}<\infty \quad \Leftrightarrow \quad \forall \lambda>0, \int \Phi\left(\frac{f}{\lambda}\right)<\infty
$$

A.2. Interpolation. We state an interpolation result on Orlicz spaces from [35] (see also [20] and the references therein) which is used in Lemma 2.7.

Theorem A.1. Consider an $N$-function $\Phi$ such that

$$
1 \leq p<\inf _{s>0} \frac{s \Phi^{\prime}(s)}{\Phi(s)} \leq \sup _{s>0} \frac{s \Phi^{\prime}(s)}{\Phi(s)}<q<\infty
$$

Then the Orlicz space $L_{\Phi}$ is an interpolation space between $L^{p}$ and $L^{q}$. In other words, if $U: L^{r} \rightarrow$ $L^{r}$ is bounded for $r=p, q$, then $U: L_{\Phi} \rightarrow L_{\Phi}$ is bounded.
A.3. The function $s \mapsto s^{2}(\widetilde{\log } s)^{2}$. With the notation of the proof of Lemma 2.7, we define $\Phi(s):=s^{2}(\widetilde{\log } s)^{2}$, as well as $\Phi^{*}$ the conjugate function of $\Phi$ by

$$
\Phi^{*}(t)=\sup _{s}\{t s-\Phi(s)\} \quad \forall t \geq 0
$$

We show below that there exists a constant $C>0$ such that

$$
\begin{equation*}
\Phi^{*}(t) \leq C t^{2}(\widetilde{\log } t)^{-2} \tag{A.1}
\end{equation*}
$$

In order to prove such a claim, we first observe that, for any $t>0$, the above supremum is reached at some unique point $s_{t} \in(0, \infty)$, which is implicitly given by the equation $t=\Phi^{\prime}\left(s_{t}\right)$. In particular, $s_{t} \rightarrow \infty$ when $t \rightarrow \infty$ (because $\Phi^{\prime}$ is increasing and bijective from $\mathbb{R}_{+}^{*}$ onto $\mathbb{R}_{+}^{*}$ ) so that there exists $t^{*}>0$ such that $s_{t}>e$ for any $t>t^{*}$. For $t>t^{*}$, we have

$$
4 s_{t}\left(\log s_{t}\right)^{2} \geq t=\Phi^{\prime}\left(s_{t}\right)=2 s_{t}\left(\log s_{t}\right)^{2}+2 s_{t}^{2}\left(\log s_{t}\right)^{2} \geq 2 s_{t}\left(\log s_{t}\right)^{2}
$$

We then compute

$$
\frac{t}{(\log t)^{2}} \geq \frac{2 s_{t}\left(\log s_{t}\right)^{2}}{\left(\log \left[4 s_{t}\left(\log s_{t}\right)^{2}\right]\right)^{2}} \geq \frac{s_{t}}{2}
$$

for $t>t^{* *}, t^{* *}$ large enough. We conclude that

$$
\Phi^{*}(t)=t s_{t}-\Phi\left(s_{t}\right) \leq 2 \frac{t^{2}}{(\log t)^{2}}
$$

for any $t>t^{* *}$. We then easily conclude to (A.1) by observing that $\Phi^{*}(t)=4 t^{2}$ for $t$ small enough.

## Appendix B. Estimates on the solutions to the Poisson equation

In this section, we give some technical (and we believe standard) estimates on the solutions to the Poisson equation in $\mathbb{R}^{2}$ that are useful in the paper. We introduce the notations

$$
\kappa(z)=-\frac{1}{2 \pi} \log |z|, \quad \mathcal{K}(z):=\nabla \kappa(z)=-\frac{1}{2 \pi} \frac{z}{|z|^{2}}
$$

and

$$
\kappa_{f}:=\kappa * f, \quad \mathcal{K}_{f}:=\mathcal{K} * f
$$

so that there holds

$$
\kappa_{f} \in C^{2}\left(\mathbb{R}^{2}\right), \quad\left|\kappa_{f}\right| \leq C(1+\log \langle x\rangle), \quad-\Delta \kappa_{f}=f
$$

Lemma B.1. For any integer $j \geq 1$ and real number $k>j+2$, there exists $C_{k, j}$ such that

$$
\begin{equation*}
\|\kappa * f\|_{L_{j-1}^{2}} \leq C_{k, j}\|f\|_{L_{k}^{2}} \quad \forall f \in L_{k, j}^{2} \tag{B.1}
\end{equation*}
$$

Proof of Lemma B.1. Consider $f \in L_{k, j}^{2}$, so that $\hat{f} \in C_{b}^{j+1}$ and $\partial_{\xi}^{\alpha} \hat{f}(0)=0$ for any $|\alpha| \leq j$ thanks to the moments condition. For a multi-index $\alpha \in \mathbb{N}^{2},|\alpha| \leq j-1$, we may thus write the Taylor expansion

$$
\partial_{\xi}^{\alpha} \hat{f}(\xi)=\int_{0}^{1}(1-s) D_{\xi}^{2} \partial_{\xi}^{\alpha} \hat{f}(s \xi): \xi^{\otimes 2} d s
$$

In Fourier variables the Laplace equation writes $|\xi|^{2} \hat{\kappa}_{f}(\xi)=\hat{f}(\xi)$, and then for a multi-index $\alpha \in \mathbb{N}^{2}$

$$
\int\left|x^{\alpha}\right|^{2}\left|\kappa_{f}\right|^{2}=\int\left|\partial_{\xi}^{\alpha} \hat{\kappa}_{f}\right|^{2}=\int \frac{\left|\partial_{\xi}^{\alpha} \hat{f}\right|^{2}}{|\xi|^{4}}
$$

All together, we have

$$
\begin{aligned}
\int|x|^{2(j-1)}\left|\kappa_{f}\right|^{2} & \leq \int_{B_{1}^{c}} \frac{\left|D^{j-1} \hat{\kappa}_{f}\right|^{2}}{|\xi|^{4}} d \xi+\int_{B_{1}} \sup _{\eta \in B_{1}}\left|D^{j+1} \hat{f}(\eta)\right|^{2} d \xi \\
& \leq\|f\|_{L_{j-1}^{2}}^{2}+C\|f\|_{L_{j+1}^{1}}^{2} \leq C\|f\|_{L_{k}^{2}}^{2}
\end{aligned}
$$

where we have used $\|g\|_{L^{1}} \leq C\|g\|_{L_{r}^{2}}$ for $r>1$ with $g=\langle x\rangle^{j+1} f$ in the last line, which gives $k>j+2$.

Lemma B.2. For any integer $j \geq 0$ and real number $k>j+2$, there exists $C_{k, j}$ such that

$$
\begin{equation*}
\|\mathcal{K} * f\|_{L_{j}^{2}} \leq C_{k, j}\|f\|_{L_{k}^{2}} \quad \forall f \in L_{k, j}^{2} \tag{B.2}
\end{equation*}
$$

Proof of Lemma B.2. The proof is similar to Lemma B.1. In the case $j=0$ for instance, we write in Fourier variables $|\xi|^{2} \hat{\kappa}_{f}(\xi)=\hat{f}(\xi)$, we observe that

$$
\int\left|\nabla \kappa_{f}\right|^{2}=\int|\xi|^{2}\left|\hat{\kappa}_{f}\right|^{2}=\int \frac{|\hat{f}|^{2}}{|\xi|^{2}}
$$

and we use the moments conditions to conclude.

## Appendix C. Estimates on the $c^{-1} d$ operator

With the notations of Section 4.3, we consider the equation

$$
\begin{equation*}
L_{\varepsilon} u:=c^{-1} d u=\Delta u+\frac{\varepsilon}{2} x \cdot \nabla u-\varepsilon z u=f \tag{C.1}
\end{equation*}
$$

with $z \in \Delta_{-1 / 2}$.
Lemma C.1. For any $f \in L_{k, 0}^{2}, k>2, z \in \Delta_{-1 / 2}$, there exists a solution $u \in H^{2}$ to the equation $L_{\varepsilon} u=f$ and there exists a constant $C$ (which does not depend on $\varepsilon>0$ and $z \in \Delta_{-1 / 2} \backslash\{0\}$ ) such that

$$
\|\nabla u\|_{L^{2}}+\|\Delta u\|_{L^{2}} \leq C\|f\|_{L_{k}^{2}}
$$

Proof of Lemma C.1. Multiplying equation (C.1) by $\bar{u}$ and $\Delta \bar{u}$ and its conjugate by $u$ and $\Delta u$, we find

$$
\begin{equation*}
\int|\nabla u|^{2}+\varepsilon\left(\frac{1}{2}+\Re e z\right) \int|u|^{2}=-\frac{1}{2} \int(f \bar{u}+\bar{f} u) \tag{C.2}
\end{equation*}
$$

and

$$
\begin{equation*}
\int|\Delta u|^{2}+(\varepsilon \Re e z) \int|\nabla u|^{2}=\frac{1}{2} \int f \Delta \bar{u}+\frac{1}{2} \int \bar{f} \Delta u . \tag{C.3}
\end{equation*}
$$

Writing

$$
u(x)=u(y)+\int_{0}^{1} \nabla u\left(z_{s}\right)(x-y) d s, \quad z_{s}:=y+s(y-x)
$$

we have

$$
u(x)=\langle u\rangle_{1}+\int_{B(0,1)} \int_{0}^{1} \nabla u\left(z_{s}\right)(x-y) d s d y, \quad\langle u\rangle_{1}:=\int_{B(0,1)} u(y) d y
$$

From the above equation (C.2) and the moment condition, we obtain

$$
\begin{aligned}
\int|\nabla u|^{2} \leq & -\int_{\mathbb{R}^{2}} \int_{B(0,1)} \int_{0}^{1} f(x) \nabla u\left(z_{s}\right) \cdot(x-y) d s d y d x \\
\leq & \frac{1}{2 \alpha} \int_{\mathbb{R}^{2}} \int_{B(0,1)} \int_{0}^{1}|f(x)|^{2}\langle x\rangle^{2 \ell}|x-y|^{2} d s d y d x \\
& +\frac{\alpha}{2} \int_{\mathbb{R}^{2}} \int_{0}^{1 / 2}\left\{\int_{B(0,1)}|\nabla u(s x+(1-s) y)|^{2} d y\right\} d s \frac{d x}{\langle x\rangle^{2 \ell}} \\
& +\frac{\alpha}{2} \int_{B(0,1)} \int_{1 / 2}^{1}\left\{\int_{\mathbb{R}^{2}}|\nabla u(s x+(1-s) y)|^{2} d x\right\} d s d y \\
\leq & \frac{1}{\alpha}\left\{\int_{B(0,1)} d y\right\} \int_{\mathbb{R}^{2}}|f(x)|^{2}\langle x\rangle^{2(\ell+1)} d x \\
& +\frac{\alpha}{2} \int_{\mathbb{R}^{2}} \frac{d x}{\langle x\rangle^{2 \ell}} \int_{0}^{1 / 2} \frac{d s}{(1-s)^{2}} \int_{\mathbb{R}^{2}}|\nabla u(z)|^{2} d z \\
& +\frac{\alpha}{2}\left\{\int_{B(0,1)} d y\right\} \int_{1 / 2}^{1} \frac{d s}{s^{2}} \int_{\mathbb{R}^{2}}|\nabla u(z)|^{2} d z
\end{aligned}
$$

and we deduce that

$$
\int|\nabla u|^{2} \leq C \int_{\mathbb{R}^{2}}|f(x)|^{2}\langle x\rangle^{2 k} d x
$$

by choosing $\ell=k-1$ and $\alpha>0$ small enough. From (C.3), we have

$$
\|\Delta u\|_{L^{2}}^{2} \leq \frac{\varepsilon}{2}\|\nabla u\|_{L^{2}}^{2}+\|f\|_{L^{2}}\|\Delta u\|_{L^{2}}
$$

and we conclude the proof thanks to the above estimate on $\|\nabla u\|_{L^{2}}$ and Young's inequality.

Lemma C.2. There exists a constant $C$ such that for any $\varepsilon \in(0,1)$, any $z \in \Delta_{-1 / 2}$ and any radially symmetric function $f$ the equation

$$
L_{\varepsilon} u=f, \quad u \text { radially symmetric }, \quad u(0)=u^{\prime}(0)=0
$$

has a unique solution which furthermore satisfies

$$
\begin{equation*}
\left\|u e^{-(1+\varepsilon|z|) r}\right\|_{L^{\infty}}+\left\|u^{\prime} e^{-(1+\varepsilon|z|) r}\right\|_{L^{\infty}} \leq C\left\|f e^{-r / 2}\right\|_{L^{\infty}} \tag{C.4}
\end{equation*}
$$

Proof of Lemma C.2. We may write the equation as

$$
\begin{equation*}
u^{\prime \prime}+\left(\frac{1}{r}+\varepsilon r\right) u^{\prime}+\varepsilon z u=f, \quad \forall r>0 \tag{C.5}
\end{equation*}
$$

with the additional boundary conditions $u(0)=u^{\prime}(0)=0$. Defining $U:=|u|^{2}+\left|u^{\prime}\right|^{2}$, we have

$$
\begin{aligned}
U^{\prime} & =u \bar{u}^{\prime}+u^{\prime} \bar{u}+u^{\prime} \bar{u}^{\prime \prime}+u^{\prime \prime} \bar{u}^{\prime} \\
& \leq 2(1+\varepsilon|z|)|u|\left|u^{\prime}\right|-\left(\frac{1}{r}+\varepsilon r\right)\left|u^{\prime}\right|^{2}+2\left|u^{\prime}\right||f| \\
& \leq(2+\varepsilon|z|) U+|f|^{2},
\end{aligned}
$$

from which we immediately get (C.4) thanks to Gronwall's lemma.
