# MEAN CURVATURE BOUNDS AND EIGENVALUES OF ROBIN LAPLACIANS 

KONSTANTIN PANKRASHKIN AND NICOLAS POPOFF

Abstract. We consider the Laplacian with attractive Robin boundary conditions,

$$
Q_{\alpha}^{\Omega} u=-\Delta u, \quad \frac{\partial u}{\partial n}=\alpha u \text { on } \partial \Omega,
$$

in a class of bounded smooth domains $\Omega \in \mathbb{R}^{\nu}$; here $n$ is the outward unit normal and $\alpha>0$ is a constant. We show that for each $j \in \mathbb{N}$ and $\alpha \rightarrow+\infty$, the $j$ th eigenvalue $E_{j}\left(Q_{\alpha}^{\Omega}\right)$ has the asymptotics

$$
E_{j}\left(Q_{\alpha}^{\Omega}\right)=-\alpha^{2}-(\nu-1) H_{\max }(\Omega) \alpha+\mathcal{O}\left(\alpha^{2 / 3}\right)
$$

where $H_{\max }(\Omega)$ is the maximum mean curvature at $\partial \Omega$. The discussion of the reverse Faber-Krahn inequality gives rise to a new geometric problem concerning the minimization of $H_{\max }$. In particular, we show that the ball is the strict minimizer of $H_{\text {max }}$ among the smooth star-shaped domains of a given volume, which leads to the following result: if $B$ is a ball and $\Omega$ is any other star-shaped smooth domain of the same volume, then for any fixed $j \in \mathbb{N}$ we have $E_{j}\left(Q_{\alpha}^{B}\right)>E_{j}\left(Q_{\alpha}^{\Omega}\right)$ for large $\alpha$. An open question concerning a larger class of domains is formulated.

## 1. Introduction

Let $\Omega \subset \mathbb{R}^{\nu}, \nu \geq 2$, be a bounded, connected, $C^{3}$ smooth domain; such domains will be called admissible through the text. For $\alpha \in \mathbb{R}$, denote by $Q_{\alpha}^{\Omega}$ the self-adjoint operator in $L^{2}(\Omega)$ acting as $Q_{\alpha}^{\Omega} u=-\Delta u$ on the functions $u \in H^{2}(\Omega)$ satisfying the Robin boundary conditions

$$
\frac{\partial u}{\partial n}=\alpha u \text { on } S:=\partial \Omega,
$$

where $n$ is the outward pointing unit normal vector at $S$.
More precisely, $Q_{\alpha}^{\Omega}$ is the self-adjoint operator in $L^{2}(\Omega)$ associated with the quadratic form $q_{\alpha}^{\Omega}$ defined on the domain $\mathcal{D}\left(q_{\alpha}^{\Omega}\right)=H^{1}(\Omega)$ by

$$
q_{\alpha}^{\Omega}(u, u)=\int_{\Omega}|\nabla u|^{2} \mathrm{~d} x-\alpha \int_{S}|u|^{2} \mathrm{~d} S,
$$

where $\mathrm{d} S$ stands for the $(\nu-1)$-dimensional Hausdorff measure on $S$. We remark that the boundary $S$ is not necessarily connected.

Throughout the paper, for a lower semibounded self-adjoint operator $Q$ with a compact resolvent we denote by $E_{j}(Q)$ its $j$ th eigenvalue when numbered in non-decreasing order and counted according to the multiplicities. The aim of the paper is to discuss some relations between the geometry of $\Omega$ and the eigenvalues $E_{j}\left(Q_{\alpha}^{\Omega}\right)$ in the asymptotic regime $\alpha \rightarrow+\infty$.

The first order asymptotics of the low lying eigenvalues has been investigated in the previous papers LOS98, LZ04, LP08, DK10] and it was shown
that for any fixed $j \in \mathbb{N}$ one has

$$
E_{j}\left(Q_{\alpha}^{\Omega}\right)=-\alpha^{2}+o\left(\alpha^{2}\right), \quad \alpha \rightarrow+\infty
$$

Some results concerning the convergence of higher eigenvalues were obtained in CCH13. We mention also several works dealing with non-smooth boundaries HePan14, LP08, McC11. Only few works are dedicated to the study of subsequent terms in the asymptotic expansion. In the two-dimensional case $(\nu=2)$ it was shown EMP14, Pan13] that for any fixed $j \in \mathbb{N}$ one has

$$
\begin{equation*}
E_{j}\left(Q_{\alpha}^{\Omega}\right)=-\alpha^{2}-\gamma_{\max } \alpha+\mathcal{O}\left(\alpha^{2 / 3}\right), \quad \alpha \rightarrow+\infty \tag{1}
\end{equation*}
$$

where $\gamma_{\max }$ is the maximum curvature at the boundary. Some results for the principal eigenvalue of balls and spherical shells in arbitrary dimension were obtained in [FK14]. Our first aim is to find an analog of (11) for general domains in higher dimensions, in particular we wonder what is the quantity which plays the role of $\gamma_{\max }$ in dimension $\nu \geq 3$.

Let us introduce the necessary notation. As mentioned above, $s \mapsto n(s)$ is the Gauss map on $S$, i.e. $n(s)$ is the outward pointing unit normal vector at $s \in S$. Denote

$$
L_{s}:=\mathrm{d} n(s): T_{s} S \rightarrow T_{s} S
$$

the shape operator at $s \in S$. Its eigenvalues $\kappa_{1}, \ldots, \kappa_{\nu-1}$ are the so-called principal curvatures at $s$, and the mean curvature $H(s)$ at $s$ is defined by

$$
H(s)=\frac{\kappa_{1}(s)+\cdots+\kappa_{\nu-1}}{\nu-1} \equiv \frac{1}{\nu-1} \operatorname{tr} L_{s}
$$

Due to the assumption $S \in C^{3}$ we have at least $H \in C^{1}(S)$, and we will denote

$$
H_{\max } \equiv H_{\max }(\Omega):=\max _{s \in S} H(s)
$$

Theorem 1. Let $\nu \geq 2$ and $\Omega \subset \mathbb{R}^{\nu}$ be an admissible domain, then for any fixed $j \in \mathbb{N}$ one has the asymptotics

$$
\begin{equation*}
E_{j}\left(Q_{\alpha}^{\Omega}\right)=-\alpha^{2}-(\nu-1) H_{\max }(\Omega) \alpha+\mathcal{O}\left(\alpha^{2 / 3}\right) \text { as } \alpha \rightarrow+\infty . \tag{2}
\end{equation*}
$$

If, additionally, the boundary is $C^{4}$, then the remainder estimate $\mathcal{O}\left(\alpha^{2 / 3}\right)$ can be replaced by $\mathcal{O}\left(\alpha^{1 / 2}\right)$

The proof is given in Section 2 ,
The result of Theorem 1 can be used to discuss some questions related to the so-called reverse Faber-Krahn inequality. It was conjectured in Bar77 that for any $\alpha>0$ among the domains $\Omega$ of the same volume it is the ball which maximizes the first eigenvalue of $Q_{\alpha}^{\Omega}$. In such a setting, the conjecture appears to be false as the very recent counterexample of [FK14] shows: if $B$ is a ball of radius $r>0$ and $\Omega$ is a spherical shell of the same volume, then for large $\alpha$ one has $E_{1}\left(Q_{\alpha}^{B}\right)<E_{1}\left(Q_{\alpha}^{\Omega}\right)$. This result is easily visible with the help of our result: one has $H_{\max }(B)=1 / r$ and $H_{\max }(\Omega)=1 / R$ with $R$ being the outer radius of $\Omega$. Therefore, $H_{\max }(B)<H_{\max }(\Omega)$, which gives the sought inequality. However, some positive results are available for restricted classes of domains and special ranges of $\alpha$. In particular, the conjecture is true for domains which are in a sense close to a ball [Bar77, FNT13] as well as for small $\alpha$ and two-dimensional domains [FK14. (We remark that the
situation for negative $\alpha$ is completely different: the ball minimizes the first eigenvalue for any $\alpha<0$, see Bos86, Dan06, (BG14]).

With the help of Theorem 1 one can easily see that the study of Faber-Krahn-optimal domains for large $\alpha$ leads to the purely geometric question: to minimize $H_{\max }(\Omega)$ in a given class of domains. It seems that such a problem setting is new and may have its own interest. Some aspects of this problem will be discussed in Section 3. In particular, we show the following lower bound, see Subsection 3.3:
Theorem 2. Let $\Omega \subset \mathbb{R}^{\nu}$ be a bounded, star-shaped, $C^{2}$ smooth domain, then

$$
\begin{equation*}
H_{\max }(\Omega) \geq\left(\frac{\operatorname{Vol} B_{\nu}}{\operatorname{Vol} \Omega}\right)^{1 / \nu} \tag{3}
\end{equation*}
$$

where $B_{\nu}$ is the unit ball in $\mathbb{R}^{\nu}$. Moreover, the above lower bound is an equality if and only if $\Omega$ is a ball.

By combining the two theorems we arrive at the following spectral result, which can viewed as an asymptotic version of the reverse Faber-Krahn inequality for star-shaped domains:

Corollary 3. Let $\Omega \subset \mathbb{R}^{\nu}$ be admissible, star-shaped, different from a ball. Let $B$ be a ball in $\mathbb{R}^{\nu}$ with $\operatorname{Vol} B=\operatorname{Vol} \Omega$. For any $j \in \mathbb{N}$ there exists $\alpha_{0}>0$ such that for all $\alpha \geq \alpha_{0}$ there holds the strict inequality

$$
E_{j}\left(Q_{\alpha}^{B}\right)>E_{j}\left(Q_{\alpha}^{\Omega}\right) .
$$

It would be interesting to understand whether Theorem 2 and hence Corollary 3 can be extended to a larger class of domains:
Open question. Let $\Omega \in \mathbb{R}^{\nu}$ be a bounded, $C^{2}$ smooth domain with a connected boundary and let $B$ be a ball of the same volume. Do we have $H_{\text {max }}(\Omega) \geq H_{\text {max }}(B)$ ?

At last we remark that one of our motivations for the present work came from various analogies between the Robin problem and the Neumann magnetic laplacian in two dimensions, in particular, a certain analogue of (1) holds for the magnetic case [BS98, HeMo01. However, a magnetic field has a non-trivial interaction with the boundary in higher dimension HeMo04, and the comparison seems to stop here as our result shows.

## 2. Asymptotics of the eigenvalues

This section is dedicated to the proof of Theorem T. The scheme of the proof is close to that of EMP14, Pan13] and is based on the DirichletNeumann bracketing in suitably chosen tubular neighborhoods of $S$ and on an explicit spectral analysis of some one-dimensional operators. We recall the max-min principle for the eigenvalues of self-adjoint operators, see e.g. Sch12, Sec. 12.1]: if $Q$ is a lower semibounded self-adjoint operator with a compact resolvent in a Hilbert space $\mathcal{H}$ and $q$ is its quadratic form, then for any $j \in \mathbb{N}$ we have

$$
E_{j}(Q)=\max _{\psi_{1}, \ldots, \psi_{j-1} \in \mathcal{H}} \min _{\substack{u \in \mathcal{D}(q), u \neq 0 \\ u \perp \psi_{1}, \ldots, \psi_{j-1}}} \frac{q(u, u)}{\langle u, u\rangle} .
$$

2.1. Dirichlet-Neumann bracketing. For $\delta>0$ denote

$$
\Omega_{\delta}:=\left\{x \in \Omega: \inf _{s \in S}|x-s|<\delta\right\}, \quad \Theta_{\delta}:=\Omega \backslash \overline{\Omega_{\delta}}
$$

Denote by $q_{\alpha}^{\Omega, N, \delta}$ and $q_{\alpha}^{\Omega, D, \delta}$ the quadratic forms defined by the same expression as $q_{\alpha}^{\Omega}$ but acting respectively on the domains

$$
\begin{aligned}
& \mathcal{D}\left(q_{\alpha}^{\Omega, N, \delta}\right)=H^{1}\left(\Omega_{\delta}\right) \cup H^{1}\left(\Theta_{\delta}\right), \quad \mathcal{D}\left(q_{\alpha}^{\Omega, D, \delta}\right)=\widetilde{H}_{0}^{1}\left(\Omega_{\delta}\right) \cup H_{0}^{1}\left(\Theta_{\delta}\right) \\
& \widetilde{H}_{0}^{1}\left(\Omega_{\delta}\right):=\left\{f \in H^{1}\left(\Omega_{\delta}\right): f=0 \text { at } \partial \Omega_{\delta} \backslash S\right\}
\end{aligned}
$$

and denote by $Q_{\alpha}^{\Omega, N, \delta}$ and $Q_{\alpha}^{\Omega, D, \delta}$ the associated self-adjoint operators in $L^{2}(\Omega)$. Due to the inclusions

$$
\mathcal{D}\left(q_{\alpha}^{\Omega, D, \delta}\right) \subset \mathcal{D}\left(q_{\alpha}^{\Omega}\right) \subset \mathcal{D}\left(q_{\alpha}^{\Omega, N, \delta}\right)
$$

and according to the max-min principle, for each $j \in \mathbb{N}$ we have the inequalities

$$
E_{j}\left(Q_{\alpha}^{\Omega, N, \delta}\right) \leq E_{j}\left(Q_{\alpha}^{\Omega}\right) \leq E_{j}\left(Q_{\alpha}^{\Omega, D, \delta}\right)
$$

Furthermore, we have the representations

$$
Q_{\alpha}^{\Omega, N, \delta}=B_{\alpha}^{\Omega, N, \delta} \oplus(-\Delta)_{\Theta_{\delta}}^{N}, \quad Q_{\alpha}^{\Omega, D, \delta}=B_{\alpha}^{\Omega, D, \delta} \oplus(-\Delta)_{\Theta_{\delta}}^{D}
$$

where $B_{\alpha}^{\Omega, N, \delta}$ and $B_{\alpha}^{\Omega, D, \delta}$ are the self-adjoint operators in $L^{2}\left(\Omega_{\delta}\right)$ associated with the respective quadratic forms

$$
\begin{gathered}
b_{\alpha}^{\Omega, \star, \delta}(u, u)=\int_{\Omega_{\delta}}|\nabla u|^{2} d x-\alpha \int_{S}|u|^{2} d S, \quad \star \in\{N, D\} \\
\mathcal{D}\left(b_{\alpha}^{\Omega, N, \delta}\right)=H^{1}\left(\Omega_{\delta}\right), \quad \mathcal{D}\left(b_{\alpha}^{\Omega, D, \delta}\right)=\widetilde{H}_{0}^{1}\left(\Omega_{\delta}\right)
\end{gathered}
$$

and $(-\Delta)_{\Theta_{\delta}}^{N}$ and $(-\Delta)_{\Theta_{\delta}}^{D}$ denote respectively the Neumann and the Dirichlet Laplacian in $\Theta_{\delta}$. As both Neumann and Dirichlet Laplacians are nonnegative, we have the inequalities
(4) $E_{j}\left(B_{\alpha}^{\Omega, N, \delta}\right) \leq E_{j}\left(Q_{\alpha}^{\Omega}\right) \leq E_{j}\left(B_{\alpha}^{\Omega, D, \delta}\right)$ for all $j$ with $E_{j}\left(B_{\alpha}^{\Omega, D, \delta}\right)<0$.

We remark that these inequalities are valid for any value of $\delta$.
2.2. Change of variables. In order to study the eigenvalues of the operators $B_{\alpha}^{\Omega, N, \delta}$ and $B_{\alpha}^{\Omega, D, \delta}$ we proceed first with a change variables in $\Omega_{\delta}$ with small $\delta$. The computations below are very similar to those performed in CEK04 for a different problem.

It is a well-known result of the differential geometry that for $\delta$ sufficiently small the map $\Phi$ defined by

$$
\Sigma:=S \times(0, \delta) \ni(s, t) \mapsto \Phi(s, t)=s-\operatorname{tn}(s) \in \Omega_{\delta}
$$

is a diffeomorphism. The metric $G$ on $\Sigma$ induced by this embedding is

$$
\begin{equation*}
G=g \circ\left(I_{s}-t L_{s}\right)^{2}+\mathrm{d} t^{2} \tag{5}
\end{equation*}
$$

where $I_{s}: T_{s} S \rightarrow T_{s} S$ is the identity map, and $g$ is the metric on $S$ induced by the embedding in $\mathbb{R}^{\nu}$. The associated volume form $\mathrm{d} \Sigma$ on $\Sigma$ is

$$
\mathrm{d} \Sigma=|\operatorname{det} G|^{1 / 2} \mathrm{~d} s \mathrm{~d} t=\varphi(s, t)|\operatorname{det} g|^{1 / 2} \mathrm{~d} s \mathrm{~d} t=\varphi \mathrm{d} S \mathrm{~d} t
$$

where

$$
\mathrm{d} S=|\operatorname{det} g|^{1 / 2} \mathrm{~d} s
$$

is the induced $(\nu-1)$-dimensional volume form on $S$, and the weight $\varphi$ is given by
(6)
$\varphi(s, t):=\left|\operatorname{det}\left(I_{s}-t L_{s}\right)\right|=1-t \operatorname{tr} L_{s}+p(s, t) t^{2} \equiv 1-(\nu-1) H(s) t+p(s, t) t^{2}$,
with $p$ being a polynomial in $t$ with $C^{1}$ coefficients depending on $s$.
Consider the unitary map

$$
U: L^{2}\left(\Omega_{\delta}\right) \rightarrow L^{2}(\Sigma, \mathrm{~d} \Sigma), \quad U f=f \circ \Phi
$$

and the quadratic forms

$$
c_{\alpha}^{\star}(f, f)=b_{\alpha}^{\Omega, \star, \delta}\left(U^{-1} f, U^{-1} f\right) \quad \mathcal{D}\left(c_{\alpha}^{\star}\right)=U \mathcal{D}\left(b_{\alpha}^{\Omega, \star, \delta}\right), \quad \star \in\{N, D\} .
$$

We have then

$$
\begin{aligned}
c_{\alpha}^{N}(u, u) & =\int_{\Sigma} G^{j k} \overline{\partial_{j} u} \partial_{k} u \mathrm{~d} \Sigma_{\alpha}-\alpha \int_{S}|u(s, 0)|^{2} \mathrm{~d} S, \quad \mathcal{D}\left(c_{\alpha}^{N}\right)=H^{1}(\Sigma) \\
c_{\alpha}^{D}(u, u) & =\text { the restriction of } c_{\alpha}^{N} \text { to } \mathcal{D}\left(c_{\alpha}^{D}\right)=\widetilde{H}_{0}^{1}(\Sigma)
\end{aligned}
$$

with

$$
\widetilde{H}_{0}^{1}(\Sigma):=\left\{f \in H^{1}(\Sigma): f(\cdot, \delta)=0\right\}, \quad\left(G^{j k}\right):=G^{-1}
$$

2.3. Estimates of the metrics. We remark that due to (5) we can estimate, with some $0<C_{-}<C_{+}$,

$$
C_{-} g^{-1}+\mathrm{d} t^{2} \leq G^{-1} \leq C_{+} g^{-1}+\mathrm{d} t^{2}, \quad\left(g^{\rho \mu}\right):=g^{-1}
$$

which shows that we have the form inequalities

$$
\begin{equation*}
c_{\alpha}^{-} \leq c_{\alpha}^{N} \quad \text { and } \quad c_{\alpha}^{D} \leq c_{\alpha}^{+} \tag{7}
\end{equation*}
$$

with

$$
\begin{aligned}
c_{\alpha}^{-}(u, u):= & C_{-} \int_{\Sigma} g^{\rho \mu} \overline{\partial_{\rho} u} \partial_{\mu} u \mathrm{~d} \Sigma+\int_{\Sigma}\left|\partial_{t} u\right|^{2} \mathrm{~d} \Sigma-\alpha \int_{S}|u(s, 0)|^{2} \mathrm{~d} S \\
& \mathcal{D}\left(c_{\alpha}^{-}\right)=\mathcal{D}\left(c_{\alpha}^{N}\right)=H^{1}(\Sigma) \\
c_{\alpha}^{+}(u, u):= & C_{+} \int_{\Sigma} g^{\rho \mu} \overline{\partial_{\rho} u} \partial_{\mu} u \mathrm{~d} \Sigma+\int_{\Sigma}\left|\partial_{t} u\right|^{2} \mathrm{~d} \Sigma-\alpha \int_{S}|u(s, 0)|^{2} \mathrm{~d} S, \\
& \mathcal{D}\left(c_{\alpha}^{+}\right)=\mathcal{D}\left(c_{\alpha}^{D}\right)=\widetilde{H}_{0}^{1}(\Sigma) .
\end{aligned}
$$

In particular, if $C_{\alpha}^{-}$and $C_{\alpha}^{+}$are the self-adjoint operators acting in $L^{2}(\Sigma, \mathrm{~d} \Sigma)$ and associated with the forms $c_{\alpha}^{-}$and $c_{\alpha}^{+}$respectively, then it follows from (4) and (7) that

$$
\begin{equation*}
E_{j}\left(C_{\alpha}^{-}\right) \leq E_{j}\left(Q_{\alpha}^{\Omega}\right) \leq E_{j}\left(C_{\alpha}^{+}\right) \text {for all } j \text { with } E_{j}\left(C_{\alpha}^{+}\right)<0 \tag{8}
\end{equation*}
$$

In order to remove the weight $\varphi$ in $\mathrm{d} \Sigma$ we introduce another unitary transform

$$
\begin{gathered}
V: L^{2}(S \times(0, \delta), \mathrm{d} S \mathrm{~d} t) \equiv L^{2}(\Sigma, \mathrm{~d} S \mathrm{~d} t) \rightarrow L^{2}(\Sigma, \mathrm{~d} \Sigma) \\
(V f)(s, t)=\varphi(s, t)^{-1 / 2} f(s, t)
\end{gathered}
$$

and the quadratic forms

$$
d_{\alpha}^{ \pm}(f, f)=c_{\alpha}^{ \pm}(V f, V f), \quad \mathcal{D}\left(d_{\alpha}^{ \pm}\right)=V^{-1} \mathcal{D}\left(c_{\alpha}^{ \pm}\right)
$$

We remark that due to (6) we can choose $\delta$ sufficiently small to have the representation

$$
\begin{equation*}
\varphi(s, t)^{-1 / 2}=1+m(s) t+t^{2} P(s, t), \quad P \in C^{1}(\bar{\Sigma}), \quad \varphi>0 \text { in } \bar{\Sigma} \tag{9}
\end{equation*}
$$

where we denote for the sake of brevity

$$
m(s):=\frac{\nu-1}{2} H(s) .
$$

We can write

\partial_{\mu}(V u)=\varphi^{-1 / 2} \partial_{\mu} u+u \partial_{\mu} \varphi^{-1 / 2}

and
(10) $\int_{\Sigma} g^{\rho \mu} \overline{\partial_{\rho}(V u)} \partial_{\mu}(V u) \mathrm{d} \Sigma=\int_{\Sigma} g^{\rho \mu} \overline{\partial_{\rho}(V u)} \partial_{\mu}(V u) \varphi \mathrm{d} S \mathrm{~d} t$

& \quad=\int_{\Sigma}\left[\varphi^{-1} g^{\rho \mu} \overline{\partial_{\rho} u} \partial_{\mu} u+g^{\rho \mu}\left(\bar{u} \partial_{\rho} \varphi^{-1 / 2}\right) \varphi^{-1 / 2} \partial_{\mu} u\right. \\
& \left.+g^{\rho \mu} \varphi^{-1 / 2} \overline{\partial_{\rho} u}\left(u \partial_{\mu} \varphi^{-1 / 2}\right)+|u|^{2} g^{\rho \mu} \overline{\partial_{\rho} \varphi^{-1 / 2}} \partial_{\mu} \varphi^{-1 / 2}\right] \varphi \mathrm{d} S \mathrm{~d} t
\end{aligned}
$$

As $\left(g^{\rho \mu}\right)$ is positive definite, using the Cauchy-Schwarz inequality we estimate

& \leq \int_{\Sigma}\left(g^{\rho \mu} \overline{\varphi^{-1 / 2} \partial_{\rho} u} \varphi^{-1 / 2} \partial_{\mu} u\right) \varphi \mathrm{d} S \mathrm{~d} t \cdot \int_{\Sigma}|u|^{2}\left(g^{\rho \mu} \overline{\partial_{\rho} \varphi^{-1 / 2}} \partial_{\mu} \varphi^{-1 / 2}\right) \varphi \mathrm{d} S \mathrm{~d} t \\
& =\int_{\Sigma} g^{\rho \mu} \overline{\partial_{\rho} u} \partial_{\mu} u \mathrm{~d} S \mathrm{~d} t \cdot \int_{\Sigma} W|u|^{2} \mathrm{~d} S \mathrm{~d} t, \quad W:=\varphi g^{\rho \mu} \overline{\partial_{\rho} \varphi^{-1 / 2}} \partial_{\mu} \varphi^{-1 / 2} .

\end{aligned}

Denoting

we arrive finally at

& \leq 2 \int_{\Sigma} g^{\rho \mu} \overline{\partial_{\rho} u} \partial_{\mu} u \mathrm{~d} S \mathrm{~d} t+2 C_{0} \int_{\Sigma}|u|^{2} \mathrm{~d} S \mathrm{~d} t
\end{aligned}
$$

On the other hand, as follows from (9),

& \quad-\int_{\Sigma} \partial_{t}\left((m+t R) \varphi^{1 / 2}\right)|u|^{2} \mathrm{~d} S \mathrm{~d} t .
\end{aligned}

& -\beta \int_{S}|u(s, \delta)|^{2} \mathrm{~d} S, \\
\mathcal{D}\left(k_{\alpha}^{-}\right)= & H^{1}(S \times(0, \delta)) .
\end{aligned}

\mathcal{D}\left(k_{\alpha}^{+}\right)= & \widetilde{H}_{0}^{1}(S \times(0, \delta)):=\left\{f \in H^{1}(S \times(0, \delta)): f(\cdot, \delta)=0\right\},

Denote by $K_{\alpha}^{ \pm}$the self-adjoint operators in $L^{2}(S \times(0, \delta), \mathrm{d} S \mathrm{~d} t)$ associated with the respective forms $k_{\alpha}^{ \pm}$then, due to the preceding constructions, for any $j \in \mathbb{N}$ we have the inequalities

2.4. Analysis of the reduced operators and lower bound. Let us analyze the eigenvalues of $K_{\alpha}^{-}$. We remark that it can be represented as

where $L$ is the (positive) Laplace-Beltrami operator on $S$ and acting in $L^{2}(S, \mathrm{~d} S)$ and $T_{\alpha}^{-}$is the self-adjoint operator in $L^{2}(0, \delta)$ associated with the quadratic form
$\tau_{\alpha}^{-}(f, f)=\int_{0}^{\delta}\left|f^{\prime}(t)\right|^{2} \mathrm{~d} t-\left(\alpha+m_{\max }\right)|f(0)|^{2}-\beta|f(\delta)|^{2}, \quad \mathcal{D}\left(\tau_{\alpha}^{-}\right)=H^{1}(0, \delta)$.
Clearly, the eigenvalues of $A_{-} L+B_{-}$do not depend on $\alpha$. On the other hand, the eigenvalues of $T_{\alpha}^{-}$in the limit $\alpha \rightarrow+\infty$ were already analyzed in the previous works, and one has the following result, see e.g. Pan13, Lemma 3] or [EMP14, Lemma 2.5]:

2.5. Construction of quasi-modes and upper bound. It remains to analyze the eigenvalues of $K_{\alpha}^{+}$. Let us show first an additional auxiliary estimate.

Lemma 4. Let $T_{\alpha}^{+}$denote the self-adjoint operator in $L^{2}(0, \delta)$ associated with the quadratic form

& =\frac{1}{2 k}\left|C_{2}(\alpha)\right|^{2}(1+o(1)),
\end{aligned}
$$

from which we infer

Now let us pick a point $s_{0} \in S$ with $m\left(s_{0}\right)=m_{\max }$. Take an arbitrary function $v \in C^{\infty}([0,+\infty))$ which is not identically zero and such that $v^{\prime}(0)=$ 0 and that $v(x)=0$ for $x \geq 1$. Consider the functions

(15) $\theta(\alpha):=\int_{S}\left|v\left(\varepsilon^{-1} d\left(s, s_{0}\right)\right)\right|^{2} \mathrm{~d} S \equiv\left\|u_{\alpha}\right\|^{2}=c_{0} \varepsilon^{\nu-1}+o\left(\varepsilon^{\nu-1}\right), \quad c_{0}>0$,

\int_{S \times(0, \delta)} g^{\rho \mu} \overline{\partial_{\rho} u_{\alpha}} \partial_{\mu} u_{\alpha} \mathrm{d} S \mathrm{~d} t=\mathcal{O}\left(\varepsilon^{\nu-3}\right)

Furthermore,

= & \int_{S \times(0, \delta)}\left|\partial_{t} u_{\alpha}\right|^{2} \mathrm{~d} S \mathrm{~d} t \\
& -\left(\alpha+m_{\max }\right) \int_{S}\left|u_{\alpha}(s, 0)\right|^{2} \mathrm{~d} S+\int_{S}\left(m_{\max }-m(s)\right)\left|u_{\alpha}(s, 0)\right|^{2} \mathrm{~d} S \\
= & \int_{S}\left|v\left(\varepsilon^{-1} d\left(s, s_{0}\right)\right)\right|^{2}\left(\int_{0}^{\delta}\left|\psi_{\alpha}^{\prime}(t)\right|^{2} \mathrm{~d} t-\left(\alpha+m_{\max }\right)\left|\psi_{\alpha}(0)\right|^{2}\right) \mathrm{d} S \\
& +\left|\psi_{\alpha}(0)\right|^{2} \int_{S}\left(m_{\max }-m(s)\right)\left|v\left(\varepsilon^{-1} d\left(s, s_{0}\right)\right)\right|^{2} \mathrm{~d} S \\
= & E_{1}\left(T_{\alpha}^{+}\right) \int_{S}\left|v\left(\varepsilon^{-1} d\left(s, s_{0}\right)\right)\right|^{2} \int_{0}^{\delta}\left|\psi_{\alpha}(t)\right|^{2} \mathrm{~d} t \mathrm{~d} S \\
& +\left|\psi_{\alpha}(0)\right|^{2} \int_{S}\left(m_{\max }-m(s)\right)\left|v\left(\varepsilon^{-1} d\left(s, s_{0}\right)\right)\right|^{2} \mathrm{~d} S \\
= & -\left(\alpha+m_{\max }\right)^{2} \theta(\alpha)+o(\theta(\alpha)) \\
& +\mathcal{O}(\alpha) \int_{S}\left(m_{\max }-m(s)\right)\left|v\left(\varepsilon^{-1} d\left(s, s_{0}\right)\right)\right|^{2} \mathrm{~d} S
\end{aligned}

on the last step we used (13) and (14). As $m \in C^{1}$, one has, for $d\left(s, s_{0}\right)$ sufficiently small,

Finally, using (15),

& =-\left(\alpha+m_{\max }\right)^{2}+\mathcal{O}(1)+\mathcal{O}\left(\varepsilon^{-2}\right)+\mathcal{O}(\alpha \varepsilon) \\
& =-\alpha^{2}-2 m_{\max } \alpha+\mathcal{O}\left(\varepsilon^{-2}+\alpha \varepsilon\right)
\end{aligned}
$$

In order to optimize we take $\varepsilon=\alpha^{-1 / 3}$, which gives

Now let us choose $j$ functions $v_{1}, \ldots, v_{j} \in C^{\infty}([0,+\infty))$ having disjoint supports, non identically zero, and such that $v_{i}^{\prime}(0)=0$ and that $v_{i}(x)=0$ for $x \geq 1$ and any $i=1, \ldots, j$. Set

One easily checks that

and the preceding computations give the estimate

Therefore, by the max-min principle we have

By inserting this estimate into (11) we get the upper bound of (21).
If $S \in C^{4}$, then the remainder estimate can be slightly improved. Namely, in this case we have $m \in C^{2}$. As $s_{0}$ is a local extremum, instead of (16) one can use

This finishes the proof of Theorem 1 ,

## 3. Estimates for the mean curvature

3.1. Mean curvature and comparison of eigenvalues. The result of Theorem 1 provides, at least for large $\alpha$, a geometric point of view at various inequalities involving the Robin eigenvalues.

For example, as shown in GS07], for all $\alpha>0$ one has $E_{1}\left(Q_{\alpha}^{\Omega}\right)<-\alpha^{2}$. For large $\alpha$ this has a simple interpretation in view of Theorem one always has $H_{\max }(\Omega)>0$.

Furthermore, in view of Theorem 1 one has a simple condition allowing one to compare the Robin eigenvalues of two different domains for large $\alpha$ :

Corollary 5. Let $\Omega_{1}$ and $\Omega_{2}$ be two admissible domains in $\mathbb{R}^{\nu}$. Assume that

$$
H_{\max }\left(\Omega_{1}\right)<H_{\max }\left(\Omega_{2}\right)
$$

then for any fixed $j \in \mathbb{N}$ there exists $\alpha_{0}>0$ such that for all $\alpha>\alpha_{0}$ there holds

$$
E\left(Q_{\alpha}^{\Omega_{2}}\right)<E\left(Q_{\alpha}^{\Omega_{1}}\right)
$$

For example, another result obtained in [GS07, Th. 2.4] is as follows: if $\Omega$ satisfies a uniform sphere condition of radius $r$ and $B$ is a ball of radius $r / 2$, then $E\left(Q_{\alpha}^{\Omega}\right) \geq E\left(Q_{\alpha}^{B}\right)$ for all $\alpha>0$. For large $\alpha$ this can be improved as follows:

Proposition 6. Let $\Omega \subset \mathbb{R}^{\nu}$ be an admissible domain satisfying the uniform sphere condition of radius $R>0$ and let $B$ be a ball of radius $r<R$. Then for any $j \in \mathbb{N}$ one can find $\alpha_{0}>0$ such that for $\alpha \geq \alpha_{0}$ there holds $E_{j}\left(Q_{\alpha}^{\Omega}\right)>E_{j}\left(Q_{\alpha}^{B}\right)$.
Proof. The uniform sphere condition of radius $R$ at $s$ implies the inequality $\max _{j} \kappa_{j}(s) \leq 1 / R$, and due to $H(s) \leq \max _{j} \kappa_{j}(s)$ we have $H(s) \leq 1 / R$ and $H_{\max }(\Omega) \leq 1 / R<1 / r=H_{\max }(B)$, and the assertion follows from Corollary 5

In the following subsections we are going to discuss the problem of minimizing $H_{\max }$ among domains of a fixed volume. Corollary 5 shows that this geometric problem is closely related to the reverse Faber-Krahn inequality as discussed in the introduction. We remark that for a given value of $\operatorname{Vol} \Omega$ the value $H_{\max }(\Omega)$ can be made arbitrarily small in the class of admissible domains, as the example of thin spherical shells shows. We are going to show that a positive lower bound still exists in a smaller class in which the ball has the extremal property.
3.2. Local minimizers. We would like to show first that the balls are the only possible local minimizers of the problem. Our argument is based on the so-called Alexandrov theorem Ale62): Let $\Omega \subset \mathbb{R}^{\nu}$ be a bounded, $C^{2}$ smooth, connected domain such that the mean curvature at the boundary is constant, then $\Omega$ is a ball.
Proposition 7. Let $\Omega \subset \mathbb{R}^{\nu}$ be a $C^{k}$ smooth ( $k \geq 2$ ), compact, connected domain, different from a ball. Then for any $\varepsilon>0$ there exists another $C^{k}$ smooth, compact, connected domain $\Omega_{\varepsilon} \subset \mathbb{R}^{\nu}$ with the following properties:

- $\operatorname{Vol} \Omega_{\varepsilon}=\operatorname{Vol} \Omega$,
- the boundary of $\Omega_{\varepsilon}$ is diffeomorphic to that of $\Omega$,
- the Hausdorff distance between $\Omega_{\varepsilon}$ and $\Omega$ is smaller than $\varepsilon$,
- $H_{\max }\left(\Omega_{\varepsilon}\right)<H_{\max }(\Omega)$.

Proof. By Alexandrov's theorem, the mean curvature $H$ on $\partial \Omega$ is nonconstant, so we can find a point $s_{*} \in \partial \Omega$ with $H\left(s_{*}\right)<H_{\max }(\Omega)$. By applying a suitable rotation, without loss of generality we may assume that for $x=\left(x^{\prime}, x_{\nu}\right), x^{\prime}=\left(x_{1}, \ldots, x_{\nu-1}\right)$, close to $s_{*}$ the condition $x \in \Omega$ is equivalent to $x_{\nu}<\varphi\left(x^{\prime}\right)$, where $\varphi$ is a $C^{k}$ function defined in a ball $B \subset$ $\mathbb{R}^{\nu-1}$, and hence the boundary $\partial \Omega$ near $s_{*}$ coincides with the graph of $\varphi$. By the choice of $s_{*}$ and using the continuity of $H$ we may additionally assume that $B$ is chosen in such a way there exists $\delta>0$ such that

$$
\begin{equation*}
H(s) \leq H_{\max }(\Omega)-\delta \text { for any point } s \in S_{B}:=\left\{\left(x^{\prime}, \varphi\left(x^{\prime}\right)\right): x^{\prime} \in B\right\} . \tag{19}
\end{equation*}
$$

Choose any non-negative $\psi \in C_{c}^{\infty}(B)$ which is not identically zero. If $\varepsilon_{0}>0$ is sufficiently small, then for all $\varepsilon \in\left[0, \varepsilon_{0}\right)$, one has the inclusion

$$
\Theta_{\varepsilon}:=\left\{\left(x^{\prime}, x_{\nu}\right): x^{\prime} \in B, \varphi\left(x^{\prime}\right)-\varepsilon \psi\left(x^{\prime}\right)<x_{\nu}<\varphi\left(x^{\prime}\right)\right\} \subset \Omega,
$$

and we set $\widetilde{\Omega}_{\varepsilon}:=\Omega \backslash \overline{\Theta_{\varepsilon}}$. By construction we have, for $\varepsilon \in\left(0, \varepsilon_{0}\right)$,

$$
\begin{equation*}
\operatorname{Vol} \widetilde{\Omega}_{\varepsilon}=\operatorname{Vol} \Omega-\varepsilon \int_{B} \psi\left(x^{\prime}\right) d x^{\prime}<\operatorname{Vol} \Omega \tag{20}
\end{equation*}
$$

and the Hausdorff distance between $\widetilde{\Omega}_{\varepsilon}$ and $\Omega$ is at most $\|\psi\|_{L^{\infty}(B)} \cdot \varepsilon$.
Furthermore,

$$
\partial \widetilde{\Omega}_{\varepsilon}:=\left(\partial \Omega \backslash S_{B}\right) \cup S_{B}^{\varepsilon} \text { with } S_{B}^{\varepsilon}:=\left\{\left(x^{\prime}, \varphi\left(x^{\prime}\right)-\varepsilon \psi\left(x^{\prime}\right)\right): x^{\prime} \in B\right\}
$$

and $S_{B}^{\varepsilon}$ is diffeomorph to $S_{B}$ (as the both are graphs of smooth functions). Furthermore, as $\psi$ has a compact support, $S_{B}^{\varepsilon}$ coincides with $S_{B}$ near the boundary, and, finally, $\partial \widetilde{\Omega}_{\varepsilon}$ is diffeomorph to $\partial \Omega$ for any $\varepsilon \in\left(0, \varepsilon_{0}\right)$.

For $x^{\prime} \in B$, we denote by $H\left(x^{\prime}, \varepsilon\right)$ the mean curvature of $\partial \widetilde{\Omega}_{\varepsilon}$ at the point $\left(x^{\prime}, \varphi\left(x^{\prime}\right)-\varepsilon \psi\left(x^{\prime}\right)\right)$, then $\|H(\cdot, \varepsilon)-H(\cdot, 0)\|_{L^{\infty}(B)}=\mathcal{O}(\varepsilon)$, and in virtue of (19) we can find $\varepsilon_{1} \in\left(0, \varepsilon_{0}\right)$ such that for any $\varepsilon \in\left(0, \varepsilon_{1}\right)$ we have $H\left(x^{\prime}, \varepsilon\right)<H_{\max }(\Omega)$ for all $x^{\prime} \in B$, which gives $H_{\max }\left(\widetilde{\Omega}_{\varepsilon}\right)=H_{\max }(\Omega)$.

Now set

$$
\Omega_{\varepsilon}:=\left(\frac{\operatorname{Vol} \Omega}{\operatorname{Vol} \widetilde{\Omega}_{\varepsilon}}\right)^{1 / \nu} \widetilde{\Omega}_{\varepsilon}
$$

then $\operatorname{Vol} \Omega_{\varepsilon}=\operatorname{Vol} \Omega$, and

$$
H_{\max }\left(\Omega_{\varepsilon}\right)=\left(\frac{\operatorname{Vol} \widetilde{\Omega}_{\varepsilon}}{\operatorname{Vol} \Omega}\right)^{1 / \nu} H_{\max }\left(\widetilde{\Omega}_{\varepsilon}\right) \equiv\left(\frac{\operatorname{Vol} \widetilde{\Omega}_{\varepsilon}}{\operatorname{Vol} \Omega}\right)^{1 / \nu} H_{\max }(\Omega)<H_{\max }(\Omega)
$$

The boundary of $\Omega_{\varepsilon}$ is clearly diffeomorph to that of $\widetilde{\Omega}_{\varepsilon}$ and, consequently, to that of $\Omega$, and using (20) one easily checks that that the Hausdorff distance between $\Omega_{\varepsilon}$ and $\Omega$ is $\mathcal{O}(\varepsilon)$.
3.3. Proof of Theorem 2. We now prove Theorem 2. Without loss of generality we assume that $\Omega$ is star-shaped with respect to the origin. Let us introduce a function $p$ on $S$ by $p(s):=s \cdot n(s)$, where $\cdot$ stands for the scalar product in $\mathbb{R}^{\nu}$. The function $p$ is called sometimes the support function. We will use two integral identities related to $\Omega$. First, due to the divergence theorem we have

$$
\operatorname{Vol} \Omega=\frac{1}{\nu} \int_{S} p \mathrm{~d} S
$$

Furthermore, we have the so-called Minkowski formula

$$
\text { Area } S=\int_{S} p H \mathrm{~d} S
$$

see Hsi54, Theorem 1]; remark that in Hsi54, the mean curvature $M_{1}$ corresponds to $(-H)$ with our notation.

As $\Omega$ is star-shaped, we have $p \geq 0$, and we deduce

$$
\text { Area } S \leq H_{\max }(\Omega) \int_{S} p \mathrm{~d} S=\nu H_{\max }(\Omega) \operatorname{Vol} \Omega
$$

which gives

$$
\begin{equation*}
H_{\max }(\Omega) \geq \frac{1}{\nu} \frac{\operatorname{Area} S}{\operatorname{Vol} \Omega} \tag{21}
\end{equation*}
$$

Due to the classical isoperimetric inequality we have

$$
\begin{equation*}
\text { Area } S \geq \nu\left(\frac{\operatorname{Vol} B_{\nu}}{\operatorname{Vol} \Omega}\right)^{1 / \nu} \operatorname{Vol} \Omega \tag{22}
\end{equation*}
$$

and the equality holds only if $\Omega$ is a ball [BZ88, §2.10]. Substituting (22) into (21) we obtain

$$
\begin{equation*}
H_{\max }(\Omega) \geq\left(\frac{\operatorname{Vol} B_{\nu}}{\operatorname{Vol} \Omega}\right)^{1 / \nu} \tag{23}
\end{equation*}
$$

If one has the equality in (23), then automatically one has the equality in (22), which gives in turn that $\Omega$ is a ball. On the other hand, is $\Omega$ is a ball of radius $r>0$, then $H_{\max }(\Omega)=1 / r$ and $\operatorname{Vol} \Omega=r^{\nu} \operatorname{Vol} B_{\nu}$, and one has the equality in (23).
