# Boundary singularities of solutions of semilinear elliptic equations with critical Hardy potentials

#### Abstract

We study the boundary behaviour of the of (E) $-\Delta u-\frac{\kappa}{d^{2}(x)} u+g(u)=0$, where $0<\kappa<\frac{1}{4}$ and $g$ is a continuous nonndecreasing function in a bounded convex domain of $\mathbb{R}^{N}$. We first construct the Martin kernel associated to the the linear operator $\mathcal{L}_{\kappa}=-\Delta-\frac{\kappa}{d^{2}(x)}$ and give a general condition for solving equation (E) with any Radon measure $\mu$ for boundary data. When $g(u)=|u|^{q-1} u$ we show the existence of a critical exponent $q_{c}=q_{c}(N, \kappa)>1$ : when $0<q<q_{c}$ any measure is eligible for solving (E) with $\mu$ for boundary data; if $q \geq q_{c}$, a necessary and sufficient condition is expressed in terms of the absolute continuity of $\mu$ with respect to some Besov capacity. The same capacity characterizes the removable compact boundary sets. At end any positive solution (F) $-\Delta u-\frac{\kappa}{d^{2}(x)} u+|u|^{q-1} u=0$ with $q>1$ admits a boundary trace which is a positive outer regular Borel measure. When $1<q<q_{c}$ we prove that to any positive outer regular Borel measure we can associate a positive solutions of $(F)$ with this boundary trace.

## 1 Introduction

Let $\Omega$ be a bounded smooth domain in $\mathbb{R}^{N}$ and $d(x)=\operatorname{dist}\left(x, \Omega^{c}\right)$. In this article we study several aspects of the nonlinear boundary value associated to the equation

$$
\begin{equation*}
-\Delta u-\frac{\kappa}{d^{2}(x)} u+|u|^{p-1} u=0 \quad \text { in } \Omega \tag{1.1}
\end{equation*}
$$

where $p>1$. The study of the boundary trace of solutions of (1.1) is a natural framework for a general study of several nonlinear problems where the nonlinearity, the geometric properties of the domain and the coefficient $\kappa$ interact. On this point of view, the case $\kappa=0$ has been thoroughly treated by Marcus and Véron [21], [22], [24], [23], for example and the synthesis presented in [25]. The associated linear Schrödinger operator

$$
\begin{equation*}
u \mapsto \mathcal{L}_{\kappa} u:=-\Delta u-\frac{\kappa}{d^{2}(x)} u \tag{1.2}
\end{equation*}
$$

plays an important role in functional analysis because of the particular singularity of is potential $V(x):=$ $-\frac{\kappa}{d^{2}(x)}$. The case $\kappa<0$ and more generally of nonnegative potential has been studied by Ancona [2] who has shown the existence of a Martin kernel which allows a general representation formula of nonnegative solutions of

\begin{equation*}
\mathcal{L}_{\kappa} u=0 \quad \text { in } \Omega \tag{1.3}
\end{equation*}
$$

This representation turned out to be the key ingredient of the full classification of positive solutions of

$$
\begin{equation*}
-\Delta u+u^{q}=0 \quad \text { in } \Omega \tag{1.4}
\end{equation*}
$$

which was obtained by Marcus [18]. In a more general setting, Véron and Yarur [30] constructed a capacitary theory associated to the linear equation

$$
\begin{equation*}
\mathcal{L}_{V} u:=-\Delta u+V(x) u=0 \quad \text { in } \Omega \tag{1.5}
\end{equation*}
$$

where the potential $V$ is nonnegative and singular near $\partial \Omega$. When $V(x):=-\frac{\kappa}{d^{2}(x)}$ with $\kappa>0, V$ is called a Hardy potential. There is a critical value $\kappa=\frac{1}{4}$. If $\kappa>\frac{1}{4}$, no positive solution of (1.3) exists. When $0<\kappa \leq \frac{1}{4}$, there exist positive solutions and the geometry of the domain plays a fundamental role in the study of the mere linear equation (1.3). We define the constant $c_{\Omega}$ by

$$
\begin{equation*}
c_{\Omega}=\inf _{v \in H_{0}^{1}(\Omega) \backslash\{0\}} \frac{\int_{\Omega}|\nabla v|^{2} d x}{\int_{\Omega} \frac{v^{2}}{d^{2}(x)} d x} \tag{1.6}
\end{equation*}
$$

It is known that $c_{\Omega}$ belongs to $\left(0, \frac{1}{4}\right]$. If $\Omega$ is convex or if the distance function $d$ is super harmonic in the sense of distributions, then $c_{\Omega}=\frac{1}{4}$. Furthermore there holds $c_{\Omega}=\frac{1}{4}$ if and only if problem (1.6) has no minimizer. (see [19]). When $0<\kappa \leq \frac{1}{4}$, which is which is always assumed in the sequel and $-\Delta d \geq 0$ in the sense of distributions, it is possible to define the first eigenvalue $\lambda_{\kappa}$ of the operator $\mathcal{L}_{\kappa}$. If we define the two fundamental exponents $\alpha_{+}$and $\alpha_{-}$by

\alpha_{+}=1+\sqrt{1-4 \kappa} \quad \text { and } \quad \alpha_{-}=1-\sqrt{1-4 \kappa} \tag{1.7}
\end{equation*}
$$

then the first eigenvalue is achieved by an eigenfunction $\phi_{\kappa}$ which satisfies $\phi_{\kappa}(x) \approx d^{\frac{\alpha_{+}}{2}}(x)$ as $d(x) \rightarrow$ 0 . Similarly, the Green kernel $G_{\mathcal{L}_{\kappa}}$ associated to $\mathcal{L}_{\kappa}$ inherits this type of boundary behaviour since there holds

$$
\begin{equation*}
\frac{1}{C_{\kappa}} \min \left\{\frac{1}{|x-y|^{N-2}}, \frac{d^{\frac{\alpha_{+}}{2}}(x) d^{\frac{\alpha_{+}}{2}}(y)}{|x-y|^{N+\alpha_{+}-2}}\right\} \leq G_{\mathcal{L}_{\kappa}}(x, y) \leq C_{\kappa} \min \left\{\frac{1}{|x-y|^{N-2}}, \frac{d^{\frac{\alpha_{+}}{2}}(x) d^{\frac{\alpha_{+}}{2}}(y)}{|x-y|^{N+\alpha_{+}-2}}\right\} \tag{1.8}
\end{equation*}
$$

We show that $\mathcal{L}_{\kappa}$ satisfies the maximum principle in the sense that if $u \in H_{l o c}^{1} \cap C(\Omega)$ is a subsolution i.e. $\mathcal{L}_{\kappa} u \leq 0$ such that

$$
\begin{array}{ll}
\text { (i) } & \limsup _{x \rightarrow y} \frac{u(x)}{d^{\alpha-}(x)} \leq 0  \tag{1.9}\\
\text { (ii) } & \text { if } 0<\kappa<\frac{1}{4} \\
\limsup _{x \rightarrow y} \frac{u(x)}{\sqrt{d(x)}|\ln d(x)|} \leq 0 & \text { if } \kappa=\frac{1}{4}
\end{array}
$$

for all $y \in \partial \Omega$, then $u \leq 0$.
If $\xi \in \partial \Omega$ and $r>0$, we set $\Delta_{r}(\xi)=\partial \Omega \cap B_{r}(\xi)$. We prove that a positive solution of $\mathcal{L}_{\kappa} u=0$ which vanishes on a part of the boundary in the sense that

$$
\begin{array}{lll}
\text { (i) } & \lim _{x \rightarrow y} \frac{u(x)}{d^{\alpha}-(x)}=0 & \forall y \in \Delta_{r}(\xi) \\
\text { if } 0<\kappa<\frac{1}{4}  \tag{1.10}\\
\text { (ii) } & \lim _{x \rightarrow y} \frac{u(x)}{\sqrt{d(x)}|\ln d(x)|}=0 & \forall y \in \Delta_{r}(\xi) \\
\text { if } \kappa=\frac{1}{4}
\end{array}
$$

satisfies

$$
\begin{equation*}
\frac{u(x)}{\phi_{\kappa}(x)} \leq C_{1} \frac{u(y)}{\phi_{\kappa}(y)} \quad \forall x, y \in \Delta_{\frac{r}{2}}(\xi) \tag{1.11}
\end{equation*}
$$

for some $C_{1}=C_{1}(\Omega, \kappa)>0$.
For any $h \in C(\partial \Omega)$ we construct the unique solution $v:=v_{h}$ of the Dirichlet problem

$$
\begin{align*}
\mathcal{L}_{\kappa} v & =0 & & \text { in } \Omega  \tag{1.12}\\
v & =h & & \text { on } \partial \Omega
\end{align*}
$$

Using this construction and estimates (1.9) we show the existence of the $\mathcal{L}_{\kappa}$-measure, which is a Borel measure $\omega^{x}$ with the property that for any $h \in C(\partial \Omega)$, the above function $v_{h}$ satisfies

$$
\begin{equation*}
v_{h}(x)=\int_{\partial \Omega} h(y) d \omega^{x}(y) \tag{1.13}
\end{equation*}
$$

Because of Harnack inequality, the measures $\omega^{x}$ and $\omega^{z}$ are mutually absolutely continuous for $x, z \in \Omega$ and for any $x \in \Omega$ we can define the Radon-Nikodym derivative

$$
\begin{equation*}
K(x, y):=\frac{d \omega^{x}}{d \omega^{x_{0}}}(y) \quad \text { for } \omega^{x_{0}} \text {-almost } y \in \partial \Omega \tag{1.14}
\end{equation*}
$$

There exists $r_{0}:=r_{0}(\Omega)$ such that for any $x \in \Omega$ such that $d(x) \leq r_{0}$, there exists a unique $\xi=\xi_{x} \in \partial \Omega$ such that $d(x)=\left|x-\xi_{x}\right|$. If we denote by $\Omega_{r_{0}}^{\prime}$ the set of $x \in \Omega$ such that $0<d(x)<r_{0}$, the mapping $\Pi$ from $\bar{\Omega}_{r_{0}}^{\prime}$ to $\left[0, r_{0}\right] \times \partial \Omega$ defined by $\Pi(x)=\left(d(x), \xi_{x}\right)$ is a $C^{1}$ diffeomorphism. If $\xi \in \partial \Omega$ and $0 \leq r \leq r_{0}$, we set $x_{r}(\xi)=\Pi^{-1}(r, \xi)$. Let $W$ be defined in $\Omega$ by

$$
W(x)= \begin{cases}d^{\frac{\alpha-}{2}}(x) & \text { if } \kappa<\frac{1}{4}  \tag{1.15}\\ \sqrt{d(x)}|\ln d(x)| & \text { if } \kappa=\frac{1}{4}\end{cases}
$$

we prove that the $\mathcal{L}_{\kappa}$-harmonic measure can be equivalently defined by

$$
\begin{equation*}
\omega^{x}(E)=\inf \left\{\psi: \psi \in C_{+}(\Omega), \mathcal{L}_{\kappa} \text {-superharmonic in } \Omega \text { and s.t. } \liminf _{x \rightarrow E} \frac{\psi(x)}{W(x)} \geq 1\right\} \tag{1.16}
\end{equation*}
$$

for any compact set $E \subset \partial \Omega$ and then extended classically to Borel subsets of $\partial \Omega$.
The $\mathcal{L}_{\kappa}$-harmonic measure is connected to the Green kernel of $\mathcal{L}_{\kappa}$ by the following estimates
Theorem A There exists $C_{3}:=C_{3}(\Omega)>0$ such that for any $r \in\left(0, r_{0}\right]$ and $\xi \in \partial \Omega$, there holds

$$
\begin{align*}
\frac{1}{C_{3}} r^{N+\frac{\alpha_{-}}{2}-2} G_{\mathcal{L}_{\kappa}}\left(x_{r}(\xi), x\right) & \leq \omega^{x}\left(\Delta_{r}(\xi)\right)  \tag{1.17}\\
& \leq C_{3} r^{N+\frac{\alpha_{-}}{2}-2} G_{\mathcal{L}_{\kappa}}\left(x_{r}(\xi), x\right) \quad \forall x \in \Omega \backslash B_{4 r(\xi)}
\end{align*}
$$

if $0<\kappa<\frac{1}{4}$, and

$$
\begin{align*}
\frac{1}{C_{3}} r^{N-2+\frac{1}{2}}|\ln d(x)| G_{\mathcal{L}_{\frac{1}{4}}}\left(x_{r}(\xi), x\right) & \leq \omega^{x}\left(\Delta_{r}(\xi)\right) \\
& \leq C_{3} r^{N-2+\frac{1}{2}}|\ln d(x)| G_{\mathcal{L}_{\frac{1}{4}}}\left(x_{r}(\xi), x\right) \quad \forall x \in \Omega \backslash B_{4 r(\xi)} \tag{1.18}
\end{align*}
$$

As a consequence $\omega^{x}$ has the doubling property. The previous estimates allow to construct a kernel function of $\mathcal{L}_{\kappa}$ in $\Omega$, prove its uniqueness up to an homothety. When normalized, the kernel function denoted by $K_{\mathcal{L}_{\kappa}}$ is the Martin kernel, defined by

$$
\begin{equation*}
K_{\mathcal{L}_{\kappa}}(x, \xi)=\lim _{x \rightarrow \xi} \frac{G_{\mathcal{L}_{\kappa}}(x, y)}{G_{\mathcal{L}_{\kappa}}\left(x, x_{0}\right)} \quad \forall \xi \in \partial \Omega \tag{1.19}
\end{equation*}
$$

for some $x_{0} \in \Omega$. An important property of the Martin kernel is that it allows to represent a positive $\mathcal{L}_{\kappa}$-harmonic function $u$ by mean of a Poisson type formula which endows the form

$$
\begin{equation*}
u(x)=\int_{\partial \Omega} K_{\mathcal{L}_{\kappa}}(x, \xi) d \mu(\xi) \tag{1.20}
\end{equation*}
$$

for some positive Radon measure $\mu$ on $\partial \Omega$. The measure $\mu$ is called the boundary trace of $u$. Furthermore $K_{\mathcal{L}_{\kappa}}$ satisfies the following two-side estimates
Theorem B There exists $C_{3}:=C_{3}(\Omega, \kappa)>0$ such that for any $(x, \xi) \in \Omega \times \partial \Omega$ there holds

$$
\begin{equation*}
\frac{1}{C_{3}} \frac{d^{\frac{\alpha_{+}}{2}}}{|x-\xi|^{N+\alpha_{+}-2}} \leq K_{\mathcal{L}_{\kappa}}(x, \xi) \leq C_{3} \frac{d^{\frac{\alpha_{+}}{2}}}{|x-\xi|^{N+\alpha_{+}-2}} \tag{1.21}
\end{equation*}
$$

Thanks to these estimates we can adapt the approach developed in [13] to prove the existence of weak solutions to the nonlinear boundary value problem

$$
\begin{align*}
&-\Delta u-\frac{\kappa}{d^{2}(x)} u+g(u)=\nu  \tag{1.22}\\
& \text { in } \Omega \\
& u=\mu \\
& \text { in } \partial \Omega
\end{align*}
$$

where $g$ is a continuous nondecreasing function such that $g(0) \geq 0$ and $\nu$ and $\mu$ are Radon measures on $\Omega$ and $\partial \Omega$ respectively. We define the class $\mathbf{X}_{\kappa}(\Omega)$ of test functions by

$$
\begin{equation*}
\mathbf{X}_{\kappa}(\Omega)=\left\{\eta \in L^{2}(\Omega) \text { s.t. } \nabla\left(d^{-\frac{\alpha_{+}}{2}} \eta\right) \in L_{\phi_{k}}^{2}(\Omega) \text { and } \phi_{\kappa}^{-1} \mathcal{L}_{\kappa} \eta \in L^{\infty}(\Omega)\right\} \tag{1.23}
\end{equation*}
$$

and we prove
Theorem C Assume g satisfies

$$
\begin{equation*}
\int_{1}^{\infty}(g(s)+|g(-s)|) s^{-2 \frac{N-1+\frac{\alpha_{+}}{2}}{N-2+\frac{\alpha_{+}}{2}}} d s<\infty \tag{1.24}
\end{equation*}
$$

Then for any Radon measures $\nu$ on $\Omega$ and such that $\int_{\Omega} \phi_{\kappa} d|\mu|<\infty$ and $\mu$ on $\partial \Omega$ there exists a unique $u \in L_{\phi_{k}}^{1}(\Omega)$ such that $g(u) \in L_{\phi_{\kappa}}^{1}(\Omega)$ which satisfies

$$
\begin{equation*}
\int_{\Omega}\left(u \mathcal{L}_{\kappa} \eta+g(u) \eta\right) d x=\int_{\Omega}\left(\eta d \nu+\mathbb{K}_{\mathcal{L}_{\kappa}}[\mu] \mathcal{L}_{\kappa} \eta d x\right) \quad \forall \eta \in \mathbf{X}_{\kappa}(\Omega) \tag{1.25}
\end{equation*}
$$

When $g(r)=|r|^{q-1} r$ the critical value is $q_{c}=\frac{N+\frac{\alpha_{+}}{2}}{N+\frac{\alpha+}{2}-2}$ and (1.24) is satisfied for $0 \leq q<q_{c}$ (the subcritical range). In this range of values of $q$, existence and uniqueness of a solution to

$$
\begin{align*}
&-\Delta u-\frac{\kappa}{d^{2}(x)} u+|u|^{q-1} u=0  \tag{1.26}\\
& \text { in } \Omega \\
& u=\mu \\
& \text { in } \partial \Omega
\end{align*}
$$

has been recently obtained by Marcus and Nguyen [20]. When $q \geq q_{c}$ not all the Radon measures are eligible for solving problem (1.26).

We prove the following result in which statement $C_{2-\frac{2+\alpha_{+}}{2 q^{\prime}}, q^{\prime}}^{\mathbb{R}^{N-1}}$ denotes the Besov capacity associated to the Besov space $B^{2-\frac{2+\alpha+}{2 q^{\prime}}, q^{\prime}}\left(\mathbb{R}^{N-1}\right)$.

Theorem D Assume $q \geq q_{c}$ and $\mu$ is a positive Radon measure on $\partial \Omega$. Then problem (1.26) admits a weak solution if and only if $\mu$ vanishes on Borel sets $E \subset \partial \Omega$ such that $C_{2-\frac{2+\alpha+}{2 q^{\prime}}, q^{\prime}}^{\mathbb{R}^{N-1}}(E)=0$.

Note that a special case of this result is proved in ([20]) when $\mu=\delta_{a}$ for a boundary point and $q \geq q_{c}$. In that case $\delta_{a}$ does not vanish on $\{a\}$ although $C_{2-\frac{2+\alpha_{+}}{2 q^{\prime}}, q^{\prime}}^{\mathbb{R}^{N-1}}(\{a\})=0$.

This capacity plays a fundamental for characterizing the removable compact boundary sets which exist only in the supercritical range $q \geq q_{c}$.

Theorem E Assume $q \geq q_{c}$ and $K \subset \partial \Omega$ is compact. Then any function $u \in C(\bar{\Omega} \backslash K)$ which satisfies

$$
\begin{align*}
-\Delta u-\frac{\kappa}{d^{2}(x)} u+|u|^{q-1} u & =0 & & \text { in } \Omega  \tag{1.27}\\
u & =0 & & \text { in } \partial \Omega \backslash K
\end{align*}
$$

is identically zero if and only if $C_{2-\frac{2+\alpha_{+}}{2 q^{\prime}}, q^{\prime}}^{\mathbb{R}^{N-1}}(K)=0$.
We show that any positive solution $u$ of (1.1) admits a boundary trace, and more precisely we prove that the following dichotomy holds: et

Theorem F Let $u$ be a positive solution of (1.1) in $\Omega$ and $a \in \partial \Omega$. Then
(i) either for any $\epsilon>0$

$$
\begin{equation*}
\lim _{\delta \rightarrow 0} \int_{\Sigma_{\delta} \cap B_{\epsilon}(a)} u d \omega_{\Omega_{\delta}^{\prime}}^{x_{0}}=\infty \tag{1.28}
\end{equation*}
$$

where $\Omega_{\delta}^{\prime}=\{x \in \Omega: d(x)>\delta\}, \Sigma_{\delta}=\partial \Omega_{\delta}^{\prime}$ and $\omega_{\Omega_{\delta}^{\prime}}^{x_{0}}$ is the harmonic measure in $\Omega_{\delta}^{\prime}$,
(ii) or there exists $\epsilon_{0}>0$ and a positive Radon measure $\lambda$ on $\partial \Omega \cap B_{\epsilon_{0}}$ (a) such that for any $Z \in C(\bar{\Omega})$ with support in $\Omega \cup\left(\partial \Omega \cap B_{\epsilon_{0}}(a)\right)$, there holds

$$
\begin{equation*}
\lim _{\delta \rightarrow 0} \int_{\Sigma_{\delta} \cap B_{\epsilon}(a)} Z u d \omega_{\Omega_{\delta}^{\prime}}^{x_{0}}=\int_{\partial \Omega \cap B_{\epsilon}(a)} Z d \lambda \tag{1.29}
\end{equation*}
$$

The set of points $a \in \partial \Omega$ such that (i) (resp. (ii)) holds is closed (resp. relatively open) and denoted by $\mathcal{S}_{u}\left(\operatorname{resp} \mathcal{R}_{u}\right)$. There exists a unique radon measure $\mu_{u}$ on $\mathcal{R}_{u}$ such that, for any $Z \in C(\bar{\Omega})$ with support in $\Omega \cup \mathcal{R}_{u}$ there holds

$$
\begin{equation*}
\lim _{\delta \rightarrow 0} \int_{\Sigma_{\delta}} Z u d \omega_{\Omega_{\delta}^{\prime}}^{x_{0}}=\int_{\mathcal{R}_{u}} Z d \mu_{u} \tag{1.30}
\end{equation*}
$$

The couple $\left(\mathcal{S}_{u}, \mu_{u}\right)$ is called the boundary trace of $u$ and denoted by $\operatorname{Tr}_{\partial \Omega}(u)$. A notion of normalized boundary trace of positive moderate solutions of (1.1), i.e. solutions such that $u \in L^{q}\left(\phi_{\kappa}\right)$, is developed in [20]. They proved the existence of a boundary trace $\mu \approx\left(\{\emptyset\}, \mu_{u}\right)$ and corresponding representation of $u$ via the Martin and Green kernels.

If $1<q<q_{c}$ we denote by $u_{k \delta_{a}}$ positive solution of (1.1) with $\mu=k \delta_{a}$ for some $a \in \partial \Omega$ and $k \geq 0$. There exists $\lim _{k \rightarrow \infty} u_{k \delta_{a}}=u_{\infty, a}$. We prove the following

Theorem $\mathbf{G}$ Assume $1<q<q_{c}$ and $a \in \partial \Omega$. Then If $u$ is a positive solution of (1.1) such that $a \in \mathcal{S}_{u}$, then $u \geq u_{\infty, a}$.

In order to go further in the study of boundary singularities, we construct separable solutions of (1.1) in $\mathbb{R}_{+}^{N}=\left\{x=\left(x^{\prime}, x_{N}\right): x_{N}>0\right\}=\left\{(r, \sigma) \in \mathbb{R}_{+} \times S_{+}^{N-1}\right\}$ which vanish on $\partial \mathbb{R}_{+}^{N} \backslash\{0\}$ under the form $u(r, \sigma)=r^{-\frac{2}{q-1}} \omega(\sigma)$, where $r>0, \sigma \in S_{+}^{N-1}$. They are solutions of

\omega & \text { in } \partial S_{+}^{N-1}
\end{align*}

where $\Delta_{S^{N-1}}$ is the Laplace-Beltrami operator, $\mathbf{e}_{N}$ the unit vector pointing toward the North pole and $\ell_{q, N}$ is a positive constant. We prove that if $1<q<q_{c}$ problem (1.31) admits a unique positive solution $\omega_{\kappa}$ while no such solution exists if $q \geq q_{c}$. To this phenomenon is associated a result of classification of positive solutions of (1.1) in $\Omega$ which vanishes of $\partial \Omega \backslash\{0\}$ (here we assume that $0 \in \partial \Omega$ and that the tangent plane to $\partial \Omega$ at 0 is $\left\{x: x . \mathbf{e}_{N}=0\right\}$, there exists $r_{0}>0$ such that $B_{r_{0}}\left(r_{0} \mathbf{e}_{N}\right) \subset \Omega$, $B_{r_{0}}\left(r_{0} \mathbf{e}_{N}\right) \subset\left\{x: x . \mathbf{e}_{N} \geq 0\right\}$ and $\left.d\left(r_{0} \mathbf{e}_{N}\right)=\left|r_{0} \mathbf{e}_{N}\right|=r_{0}\right)$
Theorem H Assume $1<q<q_{c}$ and let $u \in C(\bar{\Omega} \backslash\{a\}$ be a solution of (1.1) in $\Omega$ which vanishes of $\partial \Omega \backslash\{a\}$. Then
(i) Either $u=u_{\infty, a}$ and

If $1<q<q_{c}$ we prove that to any couple $(F, \mu)$ where $F$ is a closed subset of $\partial \Omega$ and $\mu$ a positive Radon measure on $R=\partial \Omega \backslash F$ we can associate a positive solution $u$ of (1.1) in $\Omega$ with $\operatorname{Tr}_{\partial \Omega}(u)=(F, \mu)$.

## 2 The linear operator $\mathcal{L}_{\kappa}=-\Delta-\frac{\kappa}{d^{2}(x)}$

Throughout this article $c_{j}(\mathrm{j}=1,2, \ldots)$ denote positive constants the value of which may change from one occurrence to another. The notation $\kappa$ is reserved to the value of the coefficient of the Hardy potential

### 2.1 The eigenvalue problem

We recall some known results concerning the eigenvalue problem (see [9], [12]).
1 - Since $\Omega$ is convex, $c_{\Omega}=\frac{1}{4}$ and for any $\kappa \in\left(0, \frac{1}{4}\right]$ there exists

4- Let $H_{0}^{1}\left(\Omega, d^{\alpha}(x) d x\right)$ denote the closure of $C_{0}^{\infty}(\Omega)$ functions under the norm

see [6, Th B]. As a consequence $\mathbf{W}_{\kappa}(\Omega)$ is compactly imbedded into $L^{r}(\Omega)$ for any $r \in\left[1,2^{*}\right)$. 6 - Let $\alpha>0$ and $\Omega \subset \mathbb{R}^{N}$ be a bounded domain. There exists $c^{*}>0$ depending on $\operatorname{diam}(\Omega), \mathrm{N}$ and $\alpha$ such that for any $v \in C_{0}^{\infty}(\Omega)$

The boundary behaviour of the first eigenfunction yield two-side similar estimates of the Green kernel for Schrödinger operators with a general Hardy type potentials [12, Corollary 1.9].

Proposition 2.1. Consider the operator $E:=-\Delta-V$, in $\Omega$ where $V=V_{1}+V_{2}$, with

and that to $\lambda_{1}$ is associated a positive eigenfunction $\phi_{1}$. If, for some $\alpha \geq 1$ and $C_{1}, C_{2}>0$, there holds

then the Green kernel $G_{E}^{\Omega}$ associated to $E$ in $\Omega$ satisfies

Definition 2.2. Let $G \subset \Omega$ and let $H_{c}^{1}(G) \subset H^{1}(G)$ denote the subspace of functions with compact support. A function $h \in W_{\text {loc }}^{1,1}(G)$ is $\mathcal{L}_{\kappa}$-harmonic in $G$ if

A function $\underline{h} \in H_{l o c}^{1}(G) \cap C(G)$ is $\mathcal{L}_{\kappa}$-subharmonic in $G$ if

\int_{G} \nabla \underline{h} . \nabla \psi d x-\kappa \int_{\Omega} \frac{1}{d^{2}(x)} h \psi d x \leq 0 \quad \forall \psi \in H_{c}^{1}(G), \psi \geq 0

We say that $\underline{h}$ is a local $\mathcal{L}_{\kappa}$-subharmonic function if there exists $\delta>0$ such that $\underline{h} \in H_{l o c}^{1}\left(\Omega_{\delta}\right) \cap C\left(\Omega_{\delta}\right)$ is $\mathcal{L}_{\kappa}$-subharmonic in $\Omega_{\delta}$. Similarly, (local) $\mathcal{L}_{\kappa}$-superharmonics $\bar{h}$ are defined with $" \geq "$ in the above inequality.

Note that $\mathcal{L}_{\kappa}$-harmonic functions are $C^{2}$ in $G$ by standard elliptic equations regularity theory. The Phragmen-Lindelöf principle yields the following alternative.
Proposition 2.3. Theorem 2.4 in [3]. Let $\kappa \leq \frac{1}{4}$. If $\underline{h}$ is a local $\mathcal{L}_{\kappa}$-subharmonic function, then the following alternative holds:
(i) either for every local positive $\mathcal{L}_{\kappa}$-superharmonic function $\bar{h}$

The next statement is [3, Theorem 2.9].
Proposition 2.5. Let $\underline{h}$ be a small local $\mathcal{L}_{\kappa}$-subharmonic of $\mathcal{L}_{\kappa}$.
(i) If $\kappa<\frac{1}{4}$ then the following alternative holds:

(ii) If $\kappa=\frac{1}{4}$ then the following alternative holds:

### 2.2 Preliminaries

In this part we study some regularity properties of solutions of linear equations involving $\mathcal{L}_{\kappa}$.
Lemma 2.7. (i) If $\alpha>1$ and $d^{-\frac{\alpha}{2}} u \in H^{1}\left(\Omega, d^{\alpha}(x) d x\right)$, then $u \in H_{0}^{1}(\Omega)$.
(ii) If $\alpha=1$ and $d^{-\frac{1}{2}} u \in H^{1}(\Omega, d(x) d x)$, then $u \in W_{0}^{1, p}(\Omega), \forall p<2$.

Proof. There exists $\beta_{0}>0$ such that $d \in C^{2}\left(\overline{\Omega_{\beta_{0}}}\right)$ and set $u=d^{\frac{\alpha}{2}} v$. In the two cases (i)-(ii), our assumptions imply

(i) Since $v \in H^{1}\left(\Omega, d^{\alpha}(x) d x\right)$, by (2.4) there exists a sequence $v_{n} \in C_{0}^{\infty}(\Omega)$ such that $v_{n} \rightarrow v$ in $H^{1}\left(\Omega, d^{\alpha}(x) d x\right)$. Set $u_{n}=d^{\alpha} v_{n}$. Let $0<\beta \leq \frac{\beta_{0}}{2}$ and $\psi_{\beta}$ be a cut of function such that $\psi_{\beta}=0$ in $\Omega_{\beta}^{\prime}$ and $\psi_{\beta}=1$ in $\Omega_{\frac{\beta}{2}}$. Then $u_{n}=d^{\frac{\alpha}{2}}\left(\psi_{\beta} v_{n}+\left(1-\psi_{\beta}\right) v_{n}\right)$. Thus it is enough to prove that $\widetilde{u}_{n}=d^{\frac{\alpha}{2}} \psi_{\beta} v_{n}$ remains bounded in $H^{1}(\Omega)$ independently of $n$. Set $w_{n}=\psi_{\beta} v_{n}$, then

\int_{\Omega}\left|\nabla \widetilde{u}_{n}\right|^{2} d x=\int_{\Omega_{\beta}}\left|\nabla w_{n}\right|^{2} d x \leq c_{4}\left(\int_{\Omega_{\beta}} d^{\alpha}\left|\nabla w_{n}\right|^{2} d x+\int_{\Omega_{\beta}} d^{\alpha-2} w_{n}^{2} d x\right)
$$

Note that $\alpha-2>-1$. Now

\int_{\Omega_{\beta}} d^{\alpha-2} w_{n}^{2} d x=\frac{1}{\alpha-1} \int_{\Omega_{\beta}} w_{n}^{2} \operatorname{div}\left(d^{\alpha-1} \nabla d\right) d x-\frac{1}{\alpha-1} \int_{\Omega_{\beta}}\left(d^{\alpha-1}(\Delta d) w_{n}^{2} d x\right.
$$

Now since $|\Delta d(x)|<c_{5}, \forall x \in \Omega_{\beta_{0}}$, we have

& \leq c_{6} \int_{\Omega_{\beta}} d^{\alpha}\left|\nabla w_{n}\right|^{2} d x+\delta \int_{\Omega_{\beta}} d^{\alpha-2} w_{n}^{2} d x
\end{aligned}
$$

where $c_{6}=c_{6}(\delta)>0$, and the result follows in this case, if we choose $\delta$ small enough and then we send $n$ at infinity.
(ii) By the same calculations we have

In the following statement we prove regularity up to the boundary for the function $\frac{u}{\phi_{\kappa}}$.
Proposition 2.8. Let $f_{0} \in L^{2}(\Omega)$. Then there exists a unique $u \in H_{l o c}^{1}(\Omega)$ such that $\phi_{\kappa}^{-1} u \in H^{1}\left(\Omega, d^{\alpha+}(x) d x\right)$, satisfying (2.13). Furthermore, if $f_{0} \in L^{q}\left(\Omega, \phi_{\kappa}^{2} d x\right), q>\frac{N+\alpha_{+}}{2}$, then there exists $0<\beta<1$ such that

\sup _{x, y \in \Omega, x \neq y}|x-y|^{-\beta}\left|\frac{u(x)}{\phi_{\kappa}(x)}-\frac{u(y)}{\phi_{\kappa}(y)}\right|<c_{8}| | f_{0} \|_{L^{q}\left(\Omega, \phi_{\kappa}^{2} d x\right)} \tag{2.16}
\end{equation*}
$$

Proof. If there exists a solution $u$, then $\psi=\frac{u}{\phi_{\kappa}}$ satisfies

and we recall that $\phi_{\kappa}(x) \approx d^{\frac{\alpha_{+}}{2}}(x)$. We endow the space $H^{1}\left(\Omega, \phi_{\kappa}^{2} d x\right)$ with the inner product

By a solution $\psi$ of (2.17) we mean that $\psi \in H_{0}^{1}\left(\Omega, \phi_{\kappa}^{2} d x\right)$ satisfies

\langle\nabla \psi, \nabla \zeta\rangle=\int_{\Omega} \nabla \psi \cdot \nabla \zeta \phi_{\kappa}^{2} d x+\lambda_{\kappa} \int_{\Omega} \psi \zeta \phi_{\kappa}^{2} d x=\int_{\Omega} f_{0} \zeta \phi_{\kappa} d x \quad \forall \zeta \in H_{0}^{1}\left(\Omega, \phi_{\kappa}^{2} d x\right) \tag{2.18}

By Riesz's representation theorem we derive the existence and uniqueness of the solution in this space. Since $H^{1}\left(\Omega, \phi_{\kappa}^{2} d x\right)=H_{0}^{1}\left(\Omega, \phi_{\kappa}^{2} d x\right)$ by [12, Th 2.11], any weak solution $u$ of (2.13) such that $\phi_{\kappa}^{-1} u \in$ $H^{1}\left(\Omega, \phi_{\kappa}^{2} d x\right)$ is obtained by the above method.

Finally if $f_{0} \in L^{q}\left(\Omega, \phi_{\kappa}^{2} d x\right)$, where $q>\frac{N+\alpha_{+}}{2}$, thanks to (2.8) we can prove the estimate

where $c_{8}=c_{8}(\Omega, \kappa, q)$. Then we can apply the Moser iteration (see subsection 6.3) to derive the Hölder regularity up to the boundary.

In the next results we make more precise the rate of convergence of a solution of (2.13) to its boundary value.

Proposition 2.9. Assume $\kappa<\frac{1}{4}$. If $f_{0} \in L^{2}(\Omega)$ and $h \in H^{1}(\Omega)$ there exists a unique weak solution $u$ of (2.13) in $\in H_{l o c}^{1}(\Omega)$ and such that $d^{-\frac{\alpha_{+}}{2}}\left(u-d^{\frac{\alpha_{-}}{2}} h\right) \in H^{1}\left(\Omega, d^{\alpha_{+}}(x) d x\right)$. Furthermore, if $f_{0} \in L^{q}\left(\Omega, \phi_{\kappa}^{2} d x\right), q>\frac{n+\alpha}{2}$ and $h \in C^{2}(\bar{\Omega})$, then there exists $0<\beta<1$ such that

uniformly with respect to $y$,

\left\|\frac{u}{d^{\frac{\alpha}{2}-}}\right\|_{L^{\infty}(\Omega)} \leq c_{9}\left(\|h\|_{C^{2}(\bar{\Omega})}+\left\|f_{0}\right\|_{L^{q}\left(\Omega, \phi_{\kappa}^{2} d x\right)}\right)
$$

and

\sup _{x, y \in \Omega, x \neq y}|x-y|^{-\beta}\left|\frac{u(x)}{(d(x))^{\frac{\alpha-}{2}}}-\frac{u(y)}{(d(y))^{\frac{\alpha}{2}}}\right| \leq c_{10}\left(\|h\|_{C^{2}(\bar{\Omega})}+\left\|f_{0}\right\|_{L^{q}\left(\Omega, \phi_{\kappa}^{2} d x\right)}\right) . \tag{2.20}
\end{equation*}

with $c_{9}$ and $c_{10}$ depending on $\Omega, N, q$, and $\kappa$.
Remark. By Lemma 2.7 we already know that $u-d^{\frac{\alpha}{2}} h \in H_{0}^{1}(\Omega)$.
Proof. Let $\beta \leq \beta_{0}$ and $\eta \in C^{2}(\Omega)$ be a function such that $\eta=d^{\frac{\alpha}{2}}(x)$ in $\Omega_{\beta}$ and $\eta(x)>c>0$, if $x \in \Omega_{\beta}^{\prime}$. We set $u=\phi_{\kappa} v+\eta h$. Then $v$ is a weak solution of

\end{equation*}

& \leq \int_{B_{\delta}(\xi) \cap \Omega} h^{2}\left|\nabla\left(w_{s}-w_{s^{\prime}}\right)\right|^{2} d x

Let $u_{i} \in H_{\text {loc }}^{1}(\Omega)$ be two $\mathcal{L}_{\kappa}$-harmonic functions such that $d^{-\frac{\alpha_{+}}{2}}\left(u_{i}-d^{\frac{\alpha_{-}}{2}} h_{i}\right) \in H^{1}\left(\Omega, d^{\alpha_{+}}(x) d x\right)$. Then
If $h_{1} \leq h_{2}$ a.e. in $\Omega$, there holds

If $h_{1}-h_{2} \in H_{0}^{1}(\Omega)$, there holds

Proof. Set $w=\phi_{\kappa}^{-1}\left(u_{1}-u_{2}\right)$, then $w \in H^{1}\left(\Omega, \phi_{\kappa}^{2} d x\right)$ and

(i) If $h_{1} \leq h_{2}$ a.e. in $\Omega$, then

(ii) If $h_{1}-h_{2} \in H_{0}^{1}(\Omega)$, then

We end with existence and uniqueness results for solving the Dirichlet problem associated to $\mathcal{L}_{\kappa}$.

\left\|\frac{u}{\| d^{\frac{1}{2}}\left|\log \frac{d}{D_{0}}\right|}\right\|_{L^{\infty}(\Omega)} \leq c_{24}\|h\|_{C(\partial \Omega)}

where $D_{0}=2 \sup _{x \in \Omega} d(x)$.
Proof. Uniqueness is a consequence of Proposition 2.13. For existence let $m \in \mathbb{N}$ and $h_{n}$ be smooth functions such that $h_{m} \rightarrow h$ in $L^{\infty}(\partial \Omega)$. Then we can find a function $H_{m} \in C^{2}(\bar{\Omega})$ with trace $h_{m}$ on $\partial \Omega$, and $\left\|H_{m}\right\|_{C^{2}(\bar{\Omega})} \leq c\left\|h_{m}\right\|_{L^{\infty}(\partial \Omega)}$, where $c$ depends on $\Omega$. By Lemma 2.10 there exists a unique weak solution $u_{m}$ of $\mathcal{L}_{\frac{1}{4}} u=0$ satisfying

$$
\lim _{x \in \Omega, x \rightarrow \partial \Omega} \frac{u_{m}}{d^{\frac{1}{2}}|\log d|}(x)=h_{m}(y) \quad \text { uniformly for } y \in \partial \Omega
$$

By Proposition 2.10 we have

$$
\left\|\frac{u_{m}-u_{n}}{d^{\frac{1}{2}}\left|\log \frac{d}{D_{0}}\right|}\right\|_{L^{\infty}(\Omega)} \leq c_{16}\left\|h_{m}-h_{n}\right\|_{C(\partial \Omega)}
$$

Thus there exists $u$ such that

$$
\lim _{m \rightarrow \infty}\left\|\frac{u_{m}-u}{d^{\frac{1}{2}}\left|\log \frac{d}{D_{0}}\right|}\right\|_{L^{\infty}(\Omega)}=0
$$

and $u$ is a solution of $L_{\frac{1}{4}} u=0$.
Let $x \in \Omega$, with $d(x)<\frac{1}{2}$ and $y \in \partial \Omega$

$$
\begin{aligned}
\left|\frac{u}{d^{\frac{1}{2}}|\log d|}(x)-h(y)\right| \leq\left|\frac{u}{d^{\frac{1}{2}}|\log d|}(x)-\frac{u_{m}}{d^{\frac{1}{2}}|\log d|}(x)\right| & +\left|\frac{u_{m}}{d^{\frac{1}{2}}|\log d|}(x)-h_{m}(y)\right| \\
& +\left|h(y)-h_{m}(y)\right| .
\end{aligned}
$$

The result follows by letting successively $x \rightarrow y$ and $m \rightarrow \infty$.
Similarly we have
Proposition 2.18. Assume $\kappa<\frac{1}{4}$. Then for any $h \in C(\partial \Omega)$ there exists a unique $\mathcal{L}_{\kappa}$-harmonic function $u \in H_{l o c}^{1}(\Omega)$ satisfying

$$
\lim _{x \in \Omega, x \rightarrow y \in \partial \Omega} \frac{u}{d^{\frac{\alpha}{2}}}(x)=h(y) \quad \text { uniformly for } y \in \partial \Omega
$$

Furthermore there exists a constant $c_{9}=c_{9}(\Omega, \alpha)>0$ such that

\left\|\frac{u}{d^{\alpha_{-}}}\right\|_{L^{\infty}(\Omega)} \leq c_{9}\|h\|_{C(\partial \Omega)}
$$

A useful consequence of [3, Lemma 2.8] and Propositions 2.9 and 2.10 is the following local existence result.
Proposition 2.19. There exists a positive $\mathcal{L}_{\kappa}$-harmonic function $Z_{\kappa} \in C\left(\overline{\Omega_{\beta_{0}}}\right) \cap C^{2}\left(\Omega_{\beta_{0}}\right)$ satisfying

\lim _{d(x) \rightarrow 0} \frac{Z_{\frac{1}{4}}(x)}{\sqrt{d(x)}|\ln d(x)|}=0 \tag{2.32}
\end{equation*}
$$

if $\kappa=\frac{1}{4}$, and

\begin{equation*}
\lim _{d(x) \rightarrow 0} \frac{Z_{\kappa}(x)}{(d(x))^{\frac{\alpha}{2}}}=0 \tag{2.33}
\end{equation*}
$$

if $0<\kappa<\frac{1}{4}$.

## $2.3 \mathcal{L}_{\kappa}$-harmonic measure

Let $x_{0} \in \Omega, h \in C(\partial \Omega)$ and denote $L_{\kappa, x}(h):=v_{h}\left(x_{0}\right)$ where $v_{h}$ is the solution of the Dirichlet problem (see Propositions 2.17 and 2.18)

$$
\begin{align*}
\mathcal{L}_{\kappa} v=0 & \text { in } \Omega \\
v=h & \text { in } \partial \Omega \tag{2.34}
\end{align*}
$$

where $v$ take the boundary data in the sense of Lemmas 2.17 and 2.18. By Lemma's 2.14 and 2.13, the mapping $h \mapsto L_{\kappa, x_{0}}(h)$ is a linear positive functional on $C(\partial \Omega)$. Thus there exists a unique Borel measure on $\partial \Omega$, called $\mathcal{L}_{\kappa}$-harmonic measure in $\Omega$, denoted by $\omega^{x_{0}}$, such that

$$
v_{h}\left(x_{0}\right)=\int_{\partial \Omega} h(y) d \omega^{x_{0}}(y)
$$

Because of Harnack inequality the measures $\omega^{x}$ and $\omega^{x_{0}}, x_{0}, x \in \Omega$ are mutually absolutely continuous. For every fixed $x$ we denote the Radon-Nikodyn derivative by

$$
K_{\mathcal{L}_{\kappa}}(x, y):=\frac{d w^{x}}{d w^{x_{0}}}(y) \quad \text { for } \omega^{x_{0}}-\text { almost all } y \in \partial \Omega
$$

It is wellknown that the following formula is an equivalent definition of the $\mathcal{L}_{\kappa}$-harmonic measure: for any closed set $E \subset \partial \Omega$

$$
\omega^{x_{0}}(E)=\inf \left\{\psi: \psi \in C_{+}(\Omega), \mathcal{L}_{\kappa} \text {-superhamornic in } \Omega \text { s.t. } \liminf _{x \rightarrow E} \frac{\psi(x)}{W(x)} \geq 1\right\}
$$

where

$$
W(x)= \begin{cases}d^{\frac{\alpha_{-}}{2}}(x) & \text { if } \kappa<\frac{1}{4} \\ d^{\frac{1}{2}}(x)|\log d(x)| & \text { if } \kappa=\frac{1}{4}\end{cases}
$$

The extension to open sets is standard. Let $\xi \in \partial \Omega$. We set $\Delta_{r}(\xi)=\partial \Omega \cap B_{r}(\xi)$ and $x_{r}=x_{r}(\xi) \in \Omega$, such that $d\left(x_{r}\right)=\left|x_{r}-\xi\right|=r$. Also $x_{r}(\xi)=\xi-r \mathbf{n}_{\xi}$ where $\mathbf{n}_{\xi}$ is the unit outward normal vector to $\partial \Omega$ at $\xi$. We recall that $\beta_{0}=\beta_{0}(\Omega)>0$ has been defined in Lemma 2.7.
Lemma 2.20. There exists a constant $c_{25}>0$ which depends only on $\Omega$ and a such that if $0<r \leq \beta_{0}$ and $\xi \in \partial \Omega$, there holds

$$
\begin{equation*}
\frac{\omega^{x}\left(\Delta_{r}(\xi)\right)}{W(x)} \geq c_{25} \quad \forall x \in \Omega \cap B_{\frac{r}{2}}(\xi) \tag{2.35}
\end{equation*}
$$

Proof. Let $h \in C(\partial \Omega)$ be a function with compact support in $\Delta_{r}(\xi), 0 \leq h \leq 1$ and $h=1$ on $\overline{\Delta_{\frac{3 r}{4}}(\xi)}$. And let $v_{h}, v_{1}$ the corresponding $\mathcal{L}_{\kappa}$-harmonic functions with $h$ and 1 as boundary data respectively (in the sense of Lemmas 2.17 and 2.18). Then $v_{1}(x) \geq v_{h}(x) \geq 0$ and

$$
\lim _{x \in \Omega, x \rightarrow x_{0}} \frac{v_{1}(x)-v_{h}(x)}{W(x)}=0 \quad \forall x_{0} \in \Omega \cap B_{\frac{3 r}{4}}(\xi)
$$

By Lemmas 2.12 and 2.11, and $\phi_{\kappa} \approx d^{\frac{\alpha}{2}}$, there exists $c_{26}=c_{26}(\Omega)>0$ such that

$$
\frac{v_{1}(x)-v_{h}(x)}{d^{\frac{\alpha}{2}}(x)} \leq c_{26} \frac{v_{1}(y)-v_{h}(y)}{d^{\frac{\alpha_{+}}{2}}(y)}, \quad \forall x, y \in \Omega \cap \overline{B_{\frac{r}{2}}}(\xi)
$$

We consider first the case $\kappa=\frac{1}{4}$. By Proposition 2.10, we have

0 \leq \frac{v_{1}(y)-v_{h}(y)}{d^{\frac{1}{2}}(y)} \leq \frac{v_{1}(y)}{d^{\frac{1}{2}}(y)} \leq c_{24}|\log d(y)|
$$

Thus, combining all above we have that

\frac{v_{1}(x)}{d^{\frac{1}{2}}(x)|\log d(x)|}-c_{2} 7 \frac{|\log d(y)|}{|\log d(x)|} \leq \frac{v_{h}(x)}{d^{\frac{1}{2}}(x)|\log d(x)|}
$$

Now by Lemma 2.10, there exists a $\varepsilon_{0}>0$ such that

$$
\frac{v_{1}(x)}{d^{\frac{1}{2}}(x)|\log d(x)|}>\frac{1}{2} \quad \forall x \in \Omega_{\varepsilon_{0}}
$$

Thus if we choose $y$ such that $d(y)=\frac{r}{4}$, there exists a constant $c_{27}=c_{27}(\Omega)>0$ such that

c_{27} \frac{|\log d(y)|}{|\log d(x)|}=c_{27} \frac{\left|\log \frac{r}{4}\right|}{|\log d(x)|} \leq c_{27} \frac{\left|\log \frac{r}{4}\right|}{\left|\log \frac{r}{D_{0}}\right|} \leq \frac{1}{4} \quad \forall x \in \Omega_{\frac{r}{D_{0}}},
$$

thus

\frac{v_{h}(x)}{d^{\frac{1}{2}}(x)|\log d(x)|} \geq \frac{1}{4} \quad \forall x \in \overline{B_{\frac{r}{2}}}(\xi) \cap \Omega_{\frac{r}{D_{0}}} \tag{2.36}
\end{equation*}
$$

In particular

$$
\begin{equation*}
\frac{v_{h}\left(x_{a^{*} r}(\xi)\right)}{\sqrt{a^{*} r}\left|\log \left(a^{*} r\right)\right|} \geq \frac{1}{4} \tag{2.37}
\end{equation*}
$$

where $a^{*}=\left(\max \left\{2, D_{0}\right\}\right)^{-1}$. If $D_{0} \leq 2$ we obtain the claim. If not, set $k^{*}=\mathbb{E}\left[\frac{D_{0}}{2}\right]+1$ (recall that $\mathbb{E}[x]$ denotes the largest integer less or equal to $x$ ). If $x \in \overline{B_{\frac{r}{2}}}(\xi) \cap \Omega_{\frac{r}{D_{0}}}^{\prime}$ there exists a chain of at most $4 k^{*}$ points $\left\{z_{j}\right\}_{j=0}^{j=j_{0}}$ such that $z_{j} \in \overline{B_{\frac{r}{2}}}(\xi) \cap \Omega, d\left(z_{j}\right) \geq a^{*} r, z_{0}=x_{a^{*} r}(\xi), z_{j_{0}}=x$ and $\left|z_{j}-z_{j+1}\right| \leq \frac{a^{*} r}{4}$. By Harnack inequality (applied $j_{0}$-times)

$$
\begin{equation*}
v_{h}\left(x_{a^{*} r}(\xi)\right) \leq c_{28} v_{h}(x) \tag{2.38}
\end{equation*}
$$

Since

W\left(x_{a^{*} r}(\xi)\right) \geq\left(a^{*}\right)^{\frac{1}{2}} W(x)
$$

we obtain finally

\frac{1}{4} \leq \frac{\omega^{x_{a^{*} r} r}(\xi)}{\sqrt{a^{*} r} \mid \log \left(\Delta_{r}(\xi)\right)} \leq c_{28}\left(\frac{1}{a^{*}}\right)^{\frac{1}{2}} \frac{\omega^{x}\left(\Delta_{r}(\xi)\right)}{W(x)} \quad \forall x \in \Omega \cap B_{\frac{r}{2}}(\xi) \tag{2.39}
\end{equation*}
$$

In the case $\kappa<\frac{1}{4}$, the proof is simpler since no log term appears and we omit it.

The next result is a Carleson type estimate valid for positive $\mathcal{L}_{\kappa}$-harmonic functions.
Lemma 2.21. There exists a constant $c_{29}$ which depends only on $\Omega$ such that for any $\xi \in \partial \Omega$ and $0<r \leq s \leq \beta_{0}$.

\begin{equation*}
\frac{\omega^{x}\left(\Delta_{r}(\xi)\right)}{W(x)} \leq c_{29} \frac{\omega^{x_{s}(\xi)}\left(\Delta_{r}(\xi)\right)}{W\left(x_{s}(\xi)\right)} \quad \forall x \in \Omega \backslash B_{s}(\xi) \tag{2.40}
\end{equation*}
$$

Proof. Let $h \in C(\partial \Omega)$ with compact support in $\left.\Delta_{r}(\xi)\right)$ and $0 \leq h \leq 1$. We denote by $v_{h}, v_{1}$, the solutions of (2.34) with boundary data $h$ and 1 respectively. By Propositions 2.17 and 2.18 there exists a constant $c_{30}>0$ such that for $0<r<\beta_{0}$,

\frac{v_{h}}{W(x)} \leq \frac{\omega^{x}\left(\Delta_{r}(\xi)\right)}{W(x)} \leq \frac{\omega^{x}(\partial \Omega)}{W(x)} \leq c_{30} \quad \forall x \in \Omega \tag{2.41}
\end{equation*}
$$

By Propositions 2.17 and 2.18, there holds

$$
\begin{equation*}
\lim _{d(x) \rightarrow 0} \frac{v_{1}(x)}{W(x)}=1 \tag{2.42}
\end{equation*}
$$

thus we can replace $W$ by $v_{1}$ in (2.40). Since $w_{h}=\frac{v_{h}(x)}{v_{1}(x)}$ is Hölder continuous in $\bar{\Omega}$ and satisfies

$$
\begin{align*}
-\operatorname{div}\left(v_{1}^{2} \nabla w_{h}\right)=0 & \text { in } \Omega \backslash \overline{B_{s}}(\xi) \\
0 \leq w_{h} \leq 1 & \text { in } \Omega \backslash \overline{B_{s}}(\xi)  \tag{2.43}\\
w_{h}=0 & \text { in } \partial \Omega \backslash \overline{B_{s}}(\xi)
\end{align*}
$$

the maximum of $w_{h}$ is achieved on $\Omega \cap \partial B_{s}(\xi)$, therefore it is sufficient to prove the Carleson estimate

$$
\begin{equation*}
w_{h}(x) \leq c_{29} w_{h}\left(x_{s}(\xi)\right) \quad \forall x \in \Omega \cap \partial B_{s}(\xi) \tag{2.44}
\end{equation*}
$$

If $x$ such that $|x-\xi|=s$ is "far" from $\partial \Omega, w_{h}(x)$ is "controled" by $w_{h}\left(x_{s}(\xi)\right)$ thanks to Harnack inequality, while if it is close to $\partial \Omega, w_{h}(x)$ is "controled by the fact that it vanishes on $\partial \Omega \cap \partial B_{s}(\xi)$.

We also note that (2.35) can be written under the form

$$
\begin{equation*}
w_{h}(x) \geq c_{25} \quad \forall x \in \Omega \cap B_{\frac{r}{2}}(\xi) \tag{2.45}
\end{equation*}
$$

Step 1. : $r \leq s \leq 4 r$. By Lemma 2.20, (2.41) and the above inequality we have that

w_{h}\left(x_{\frac{r}{2}}(\xi)\right) \geq \frac{c_{25}}{c_{30}} w_{h}(x) \quad \forall x \in \Omega
$$

Applying Harnack inequality to $w_{h}$ in the balls $B_{\frac{(2+j) r}{4}}\left(x_{\frac{(2+j) r}{4}}(\xi)\right)$ for $j=0, \ldots, j_{0} \leq 14$ we obtain

w_{h}\left(x_{\frac{(2+j) r}{4}}(\xi)\right) \geq c_{31}^{j} w_{h}\left(x_{\frac{r}{2}}(\xi)\right) \quad \text { for } j=1, \ldots, j_{0}
$$

This implies

w_{h}\left(x_{s}(\xi)\right) \geq c_{32} w_{h}(x) \quad \forall x \in \Omega \tag{2.46}
\end{equation*}
$$

Step 2: $\beta_{0} \geq s>4 r$. We apply Propositions $2.11,2.12$ to $w_{h}$ in $B_{\frac{s}{2}}\left(\xi_{1}\right) \cap \Omega$ where $\xi_{1} \in \partial \Omega$ is such that $\left|\xi-\xi_{1}\right|=s$ and we get

w_{h}(x) \leq c_{18} w_{h}\left(x_{\frac{s}{4}}\left(\xi_{1}\right)\right) \quad \forall x \in B_{\frac{s}{4}}\left(\xi_{1}\right) \cap \Omega \tag{2.47}
\end{equation*}
$$

Then we apply six times Harnack inequality to $w_{h}$ between $x_{\frac{s}{4}}\left(\xi_{1}\right)$ and $x_{s}(\xi)$ and obtain

w_{h}\left(x_{\frac{s}{4}}\left(\xi_{1}\right)\right) \leq c_{33} w_{h}\left(x_{s}\left(\xi_{1}\right)\right) \tag{2.48}
\end{equation*}
$$

Combining (2.47) and (2.48) we derive (2.44).
Step 3. For $\epsilon>0$, set $z_{h}=w_{h}-c_{33} w_{h}\left(x_{s}(\xi)\right)-\epsilon$. Then $z_{h}^{+}$has compact support in $\Omega \backslash B_{s}(\xi)$ and thus belongs to $H_{0}^{1}\left(\Omega \backslash B_{s}(\xi)\right)$. Integration by parts in (2.43) leads to

\int_{\Omega \backslash B_{s}(\xi)} v_{1}^{2}\left|\nabla z_{h}^{+}\right|^{2} d x=0 \tag{2.49}
\end{equation*}

Then $z_{h}^{+}=0$ by letting $\epsilon \rightarrow 0$. Combining with (2.46) and $h \uparrow \chi_{\Delta_{r}(\xi)}$ implies (2.40).
Theorem 2.22. There exists a constant $c_{34}$ which depends only on $\Omega$ such that, for any $0<r \leq \beta_{0}$ and $\xi \in \partial \Omega$, there holds

\begin{equation*}
\frac{1}{c_{34}} r^{N-1-\frac{1}{2}}|\log r| G_{\mathcal{L}_{\frac{1}{4}}}\left(x_{r}(\xi), x\right) \leq \omega^{x}\left(\Delta_{r}(\xi)\right) \leq c_{34} r^{N-1-\frac{1}{2}}|\log r| G_{\mathcal{L}_{\frac{1}{4}}}\left(x_{r}(\xi), x\right) \quad \forall x \in \Omega \backslash B_{4 r}(\xi) \tag{2.50}
\end{equation*}
$$

Proof. Let $\eta \in C_{0}^{\infty}\left(B_{2 r}(\xi)\right)$ such that $0 \leq \eta \leq 1$ and $\eta=1$ in $B_{r}(\xi)$. We set

u=\eta(-\ln d) \sqrt{d}:=\eta \psi,
$$

(we assume that $4 r<1$ ), in order to have

\lim _{x \rightarrow x_{0}} \frac{u(x)}{\psi(x)}=\eta \bigsqcup_{\partial \Omega}\left(x_{0}\right)=\zeta\left(x_{0}\right) \quad \forall x_{0} \in \partial \Omega
$$

uniformly with respect to $x_{0}$. Since

-\Delta \psi-\frac{1}{4} \frac{\psi}{d^{2}(x)}=\frac{2+\ln d}{2 \sqrt{d}} \Delta d=-(N-1) \frac{2+\ln d}{2 \sqrt{d}} K
$$

where $K$ is the mean curvature of $\partial \Omega$. Also we have

|\nabla \eta| \leq c_{0} \chi_{\Omega \cap B_{2 r}(\xi)} \frac{1}{r} \quad \text { and } \quad|\Delta \eta(x)| \leq c_{0} \chi_{\Omega \cap B_{2 r}(\xi)} \frac{1}{r^{2}} \leq c_{0} \chi_{\Omega \cap B_{2 r}(\xi)} \frac{1}{r} d^{-1}(x)
$$

then $u$ satisfies

$$
\begin{aligned}
-\Delta u-\frac{1}{4} \frac{u}{d^{2}(x)}=-\psi \Delta \eta+\frac{2+\ln d}{2 \sqrt{d}}(2 \nabla d \cdot \nabla \eta-(N-1) K \eta) & :=f & \text { in } \Omega \\
& u=\zeta & \text { on } \partial \Omega
\end{aligned}
$$

Then $|f| \leq \frac{c_{35}}{r}\left(-\frac{\ln d}{\sqrt{d}}\right) \chi_{\Omega \cap B_{2 r}(\xi)}$ since $\eta$ vanishes outside $B_{2 r}(\xi)$. We have by the representation formula [12]

By Lemma 2.1, we have that for any $x \in \Omega \backslash B_{4 r}(\xi)$ and $y \in B_{2 r}(\xi)$

G_{\mathcal{L}_{\frac{1}{4}}}(x, y) \leq c_{36} G_{\mathcal{L}_{\frac{1}{4}}}\left(x, x_{r}(\xi)\right)
$$

thus

\begin{align*}
\omega^{x}\left(\Delta_{r}(\xi)\right) & \leq \int_{\Omega \cap B_{2 r}(\xi)} G_{\mathcal{L}_{\frac{1}{4}}}(x, y)|f(y)| d y \\
& \leq \frac{c_{37}}{r} G_{\mathcal{L}_{\frac{1}{4}}}\left(x, x_{r}(\xi)\right) \int_{\Omega \cap B_{2 r}(\xi)} \frac{|\ln d(y)|}{\sqrt{d(y)}} d y  \tag{2.52}\\
& \leq c_{38} G_{\mathcal{L}_{\frac{1}{4}}}\left(x, x_{r}(\xi)\right) r^{N-1-\frac{1}{2}}|\ln r|,
\end{align*}
$$

since

\int_{\Omega \cap B_{2 r}(\xi)} \frac{|\ln d(y)|}{\sqrt{d(y)}} d y \leq c_{39} r^{N-1} \int_{0}^{2 r} \frac{|\ln t| d t}{\sqrt{t}} \leq 2 c_{39} r^{N-\frac{1}{2}}|\ln r|
$$

This implies the right-hand side part of (2.50). For the opposite inequality we observe that if $x \in$ $\partial B_{4 r}(\xi) \cap \Omega$, there holds by (2.35)

& \leq c_{40} r^{N-1-\frac{1}{2}}|\log r| \min \left\{\frac{1}{\left|x-x_{r}(\xi)\right|^{N-2}}, \frac{\sqrt{d(x)} \sqrt{d\left(x_{r}(\xi)\right)}}{\left|x-x_{r}(\xi)\right|^{N-1}}\right\} \\
& \leq c_{41} \sqrt{d(x)}|\log r| \\
& \leq c_{42} W(x) \\
& \leq \frac{c_{42}}{c_{25}} \omega^{x \frac{r}{8}(\xi)}\left(\Delta_{r}(\xi)\right)
\end{aligned}
$$

We end the proof by Harnack inequality between $\omega^{x^{r}}(\xi)\left(\Delta_{r}(\xi)\right)$ and $\omega^{x_{4 r}(\xi)}\left(\Delta_{r}(\xi)\right)$ and by Harnack inequality between $\omega^{x}\left(\Delta_{r}(\xi)\right)$ and $\omega^{x_{4 r}(\xi)}\left(\Delta_{r}(\xi)\right)$ on $\partial B_{4 r}(\xi)$ and an argument like in the step 3 in Lemma (2.21).

Replacing, in the last proof, the function $\psi=\sqrt{d}(-\ln d)$ by $\tilde{\psi}=d^{\frac{\alpha}{2}}$, we obtain similarly.y
Theorem 2.23. Assume $\kappa<\frac{1}{4}$. There exists a constant $c_{42}$ which depends only on $\Omega$ and $\kappa$ such that, for any $0<r \leq \beta_{0}$ and $\xi \in \partial \Omega$, there holds

$$
\frac{1}{c_{42}} r^{N-2+\frac{\alpha_{-}}{2}} G_{\mathcal{L}_{\kappa}}\left(x_{r}(\xi), x\right) \leq \omega^{x}\left(\Delta_{r}(\xi)\right) \leq c_{42} r^{N-2+\frac{\alpha-}{2}} G_{\mathcal{L}_{\kappa}}\left(x_{r}(\xi), x\right) \quad \forall x \in \Omega \backslash B_{4 r}(\xi)
$$

As a consequence of Theorems 2.22 and 2.23 and the Harnack inequality, the harmonic measure for $\mathcal{L}_{\kappa}$ possesses the doubling property.
Theorem 2.24. Let $0<\kappa \leq \frac{1}{4}$. There exists a constant $c_{42}$ which depends only on $\Omega, \kappa$ such that for any $0<r \leq \beta_{0}$, there holds

$$
\omega^{x}\left(\Delta_{2 r}(\xi)\right) \leq c_{42} \omega^{x}\left(\Delta_{r}(\xi)\right) \quad \forall x \in \Omega \backslash B_{4 r}(\xi)
$$

Lemma 2.25. Let $0<r \leq \beta_{0}$ and $u$ be a positive $\mathcal{L}_{\kappa}$-harmonic function such that (i) $u \in C\left(\overline{\Omega \backslash B_{r}(\xi)}\right)$,

$$
\begin{equation*}
\lim _{x \rightarrow x_{0}} \frac{u(x)}{W(x)}=0 \quad \forall x_{0} \in \Omega \backslash \overline{B_{r}(\xi)} \tag{ii}
\end{equation*}
$$

uniformy with respect to $x_{0}$.

## Then

$$
c_{42}^{-1} \frac{u\left(x_{r}(\xi)\right)}{W\left(x_{r}(\xi)\right)} w^{x}\left(\Delta_{r}(\xi)\right) \leq u(x) \leq c_{42} \frac{u\left(x_{r}(\xi)\right)}{W\left(x_{r}(\xi)\right)} w^{x}\left(\Delta_{r}(\xi)\right) \quad \forall x \in \Omega \backslash \overline{B_{2 r}(\xi)}
$$

with $c_{42}$ depends only on $\kappa$ and $\Omega$.
Proof. By Propositions 2.11, 2.12 we have that there exists $C$ such that

\frac{1}{C} \frac{u\left(x_{2 r}(\xi)\right)}{w^{x_{2 r}(\xi)}\left(\Delta_{r}(\xi)\right)} \leq \frac{u(x)}{w^{x}\left(\Delta_{r}(\xi)\right)} \leq C \frac{u\left(x_{2 r}(\xi)\right)}{w^{x_{2 r}(\xi)}\left(\Delta_{r}(\xi)\right)}, \quad \forall x \in \Omega \cap \partial B_{2 r}(\xi)
$$

by Harnack inequality between we have that

$$
\frac{1}{C} \frac{u\left(x_{r}(\xi)\right)}{w^{x_{r}(\xi)}\left(\Delta_{r}(\xi)\right)} \leq \frac{u(x)}{w^{x}\left(\Delta_{r}(\xi)\right)} \leq C \frac{u\left(x_{r}(\xi)\right)}{w^{x_{r}(\xi)}\left(\Delta_{r}(\xi)\right)}, \quad \forall x \in \Omega \cap \partial B_{2 r}(\xi)
$$

Also by Harnack inequality we have that

w^{x_{r}(\xi)}\left(\Delta_{r}(\xi)\right) \geq C w^{x_{\frac{r}{2}}(\xi)}\left(\Delta_{r}(\xi)\right)>C_{0} W\left(x_{r}(\xi)\right)
$$

where in the last inequality above we have used Lemma 2.20.
Combining all above we have that

C^{-1} \frac{u\left(x_{r}(\xi)\right)}{W\left(x_{r}(\xi)\right)} w^{x}\left(\Delta_{r}(\xi)\right) \leq u(x) \leq C \frac{u\left(x_{r}(\xi)\right)}{W\left(x_{r}(\xi)\right)} w^{x}\left(\Delta_{r}(\xi)\right), \quad \forall x \in \Omega \cap \partial B_{2 r}(\xi)
$$

The result follows by an argument like in step 3 in Lemma 2.21.

### 2.4 The Poisson kernel of $\mathcal{L}_{\kappa}$

In this section we state some properties of the Poisson kernel associated to $\mathcal{L}_{\kappa}$.
Definition 2.26. Fix $\xi \in \partial \Omega$. A function $K$ defined in $\Omega$ is called a kernel function at $\xi$ with pole at $x_{0} \in \Omega$ if
(i) $K(\cdot, \xi)$ is $\mathcal{L}_{\kappa}$-harmonic in $\Omega$,
(ii) $K(\cdot, \xi) \in C(\bar{\Omega} \backslash\{\xi\})$ and for any $\eta \in \partial \Omega \backslash\{\xi\}$

$$
\lim _{x \rightarrow \eta} \frac{K(x, \xi)}{W(x)}=0
$$

(iii) $K(x, \xi)>0$ for each $x \in \Omega$ and $K\left(x_{0}, \xi\right)=1$.

Proposition 2.27. There exists one and only one kernel function for $\mathcal{L}_{\kappa}$ at $\xi$ with pole at $x_{0}$.
Proof. The proof is the same as the one of Theorem 3.1 in [7].
Set

$$
u_{n}(x)=\frac{w^{x}\left(\Delta_{2^{-n}}(\xi)\right)}{w^{x_{0}}\left(\Delta_{2^{-n}}(\xi)\right)}
$$

Since

$$
u_{n} \geq 0
$$

$\mathcal{L}_{\kappa} u_{n}=0$ in $\Omega$ and $u_{n}\left(x_{0}\right)=1$ the sequence $\left\{u_{n}\right\}$ is locally bounded in $\Omega$. Hence we can find a subsequence, again denoted by $\left\{u_{n}\right\}$, which converges to a function $u$, locally uniformly in $\Omega$.

It is clear that $u \geq 0$ in $\Omega$ and $\mathcal{L}_{\kappa} u=0$ in $\Omega$. Since $u\left(x_{0}\right)=1, u$ is strictly positive in $\Omega$. Now fix $P \in \partial \Omega$ and $P \neq \xi$. Let $n_{0} \in \mathbb{N}$ be such that $P \in \Omega \backslash \overline{B_{2^{n+1}}(\xi)}, \forall n \geq n_{0}$. By Lemma 2.25 if we take $n_{0}$ sufficiently large, we have

$$
u_{n}(x) \leq c_{42} \frac{u_{n}\left(x_{2^{-n_{0}}}(\xi)\right)}{W\left(x_{2^{-n_{0}}}(\xi)\right)} w^{x}\left(\Delta_{2^{-n_{0}}}(\xi)\right) \quad \forall x \in \Omega \backslash \overline{B_{2^{-n_{0}+1}}(\xi)}
$$

which implies

$$
u(x) \leq c_{42} \frac{u\left(x_{2^{-n_{0}}}(\xi)\right)}{W\left(x_{2^{-n_{0}}}(\xi)\right)} w^{x}\left(\Delta_{2^{-n_{0}}}(\xi)\right) \quad \forall x \in \Omega \backslash \overline{B_{2^{-n_{0}+1}}(\xi)}
$$

and so

$$
\lim _{x \rightarrow P} \frac{u(x)}{W(x)}=0
$$

We now turn to the question of uniqueness of the kernel function. To this end we let $f(x)$ and $g(x)$ be any two kernel functions for $\mathcal{L}_{\kappa}$ in $\Omega$ at $\xi$. By Lemma 2.25 and the properties of $f, g$ we have that

$$
\frac{1}{c_{42}^{2}} \frac{f\left(x_{r}(\xi)\right)}{g\left(x_{r}(\xi)\right)} \leq \frac{f(x)}{g(x)} \leq c_{42}^{2} \frac{f\left(x_{r}(\xi)\right)}{g\left(x_{r}(\xi)\right)} \quad \forall x \in \Omega \backslash \overline{B_{2 r}(\xi)}
$$

In particular we can obtain if we set $x=x_{0}$

$$
\frac{f\left(x_{r}(\xi)\right)}{g\left(x_{r}(\xi)\right)} \leq c_{42}^{2}
$$

and we easily conclude that for any two kernel function for $\mathcal{L}_{\kappa}$ at $\xi$

$$
\frac{f(x)}{g(x)} \leq c_{42}^{3}:=c, \quad \forall x \in \Omega
$$

We must have $c \geq 1$. If $c=1$ we are done. If $c>1$ then $f+A(f-g)$ is also a Kernel function for $\mathcal{L}_{\kappa}$ at $\xi$ when $A=\frac{1}{c-1}$. From the above inequality

$$
g \leq c(f+A(f-g))
$$

and therefore

$$
f+A(f-g)+A(f+A(f-g)),
$$

is a kernel function at $\xi$. Proceeding in the above manner and by induction we conclude that for each positive integer $k$ there exists nonnegative numbers $a_{1 k}, \ldots, a_{k k}$ such that

$$
f+\left(k A+\sum_{i=1}^{k} a_{i k}\right)(f-g)
$$

is a kernel function at $\xi$. Hence

$$
f+\left(k A+\sum_{i=1}^{k} a_{i k}\right)(f-g) \leq c^{2} f
$$

The last inequality can only hold for all $k$ when $f(x)=g(x)$ for all $x \in \Omega$.

We recall here that we denote by

$$
K_{\mathcal{L}_{\kappa}}(x, \xi):=\frac{d w^{x}}{d w^{x_{0}}}(\xi) \quad \text { for } \omega^{x_{0}}-\text { almost all } \xi \in \partial \Omega
$$

the kernel function in $\Omega$. Also in view of the proof of Proposition 2.27 and by uniqueness we can write

$$
K_{\mathcal{L}_{\kappa}}(x, \xi)=\lim _{r \rightarrow 0} \frac{w^{x}\left(\Delta_{r}(\xi)\right)}{w^{x_{0}}\left(\Delta_{r}(\xi)\right)} \quad \text { for } \omega^{x_{0}}-\text { almost all } \xi \in \partial \Omega
$$

Proposition 2.28. The kernel function $K_{\mathcal{L}_{\kappa}}(x, \xi)$, is continuous in $\xi$ on the boundary of $\Omega$.
Proof. The proof is the same as the one of Corollary 3.2 in [7]. Suppose that $\xi_{n} \rightarrow \xi$ as $n \rightarrow \infty$. Then the sequence, $K\left(\cdot, \xi_{n}\right)$, of positive solutions of $\mathcal{L}_{\kappa} u=0$ has a subsequence which converges locally uniformly in $\Omega$ to a function which must be a positive solution of $\mathcal{L}_{\kappa} u=0$ in $\Omega$. Outside any fixed neighborhood, $B$, of $\xi, \frac{K_{\mathcal{L}_{\kappa}}\left(x, \xi_{n}\right)}{W(x)}$ converges to zero uniformly in $n$ as $x \rightarrow P \in \partial \Omega \backslash B$. Hence the limit function of the subsequence is the kernel function for $\mathcal{L}_{\kappa}$ at $\xi$. By uniqueness of the kernel function we easily conclude that the entire sequence

$$
K_{\mathcal{L}_{\kappa}}\left(x, \xi_{n}\right) \rightarrow K_{\mathcal{L}_{\kappa}}(x, \xi)
$$

We can now identify the Martin boundary and topology with their classical analogues. We begin by recalling the definitions of the Martin boundary and related concepts.

For $x, y \in \Omega$ let

$$
\mathcal{K}_{\kappa}(x, y):=\frac{G_{\mathcal{L}_{\kappa}}(x, y)}{G_{\mathcal{L}_{\kappa}}\left(x_{0}, y\right)} .
$$

Consider the family of sequences $\left\{y_{k}\right\}_{k \geq 1}$ of points of $\Omega$ without accumulation points in $\Omega$ for which $\mathcal{K}_{\kappa}\left(x, y_{k}\right)$ converges in $\Omega$ to a harmonic function, denoted $\mathcal{K}_{\kappa}\left(x,\left\{y_{k}\right\}\right)$. Two such sequences $y_{k}$ and $y_{k}^{\prime}$ are called equivalent if $\mathcal{K}_{\kappa}\left(x,\left\{y_{k}\right\}\right)=\mathcal{K}_{\kappa}\left(x,\left\{y_{k}^{\prime}\right\}\right)$ and each equivalence class is called an element of the Martin boundary $\Gamma$. If $Y$ is such an equivalence class (i.e., $Y \in \Gamma$ ) then $\mathcal{K}_{\kappa}(x, Y)$ will denote the corresponding harmonic limit function. Thus each $Y \in \Omega \cup \Gamma$ is associated with a unique function $\mathcal{K}_{\kappa}(x, Y)$. The Martin topology on $\Omega \cup \Gamma$ is given by the metric

$$
\rho\left(Y, Y^{\prime}\right)=\int_{A} \frac{\left|\mathcal{K}_{\kappa}(x, Y)-\mathcal{K}_{\kappa}\left(x, Y^{\prime}\right)\right|}{1+\left|\mathcal{K}_{\kappa}(x, Y)-\mathcal{K}_{\kappa}\left(x, Y^{\prime}\right)\right|} d x, \quad Y, Y^{\prime} \in \Omega \cup \Gamma
$$

where $A$ is a small enough neighborhood of $x_{0} . \mathcal{K}_{\kappa}(x, Y)$ is a $\rho$ - continuous function of $Y \in \Omega \cup \Gamma$ for $\operatorname{xin} \Omega$ fixed, $\Omega \cup \Gamma$ is compact and complete with respect to $\rho, \Omega \cup \Gamma$ is the $\rho$-closure of $\Omega$ and the $\rho$-topology is equivalent to the Euclidean topology in $\Omega$. We have the following results.

Proposition 2.29. There is a one-to-one correspondence between the Martin boundary of $\Omega$ and the Euclidean boundary $\partial \Omega$. If $Y \in \Gamma$ corresponds to $\xi \in \partial \Omega$ then $\mathcal{K}_{\kappa}(x, Y)=K_{\mathcal{L}_{\kappa}}(x, \xi)$. The Martin topology on $\Omega \cup \Gamma$ is equivalent to the Euclidean topology on $\Omega \cup \partial \Omega$.

Proof. The proof is same as the one of Theorem 4.2 in [17]. By uniqueness of kernel function we have that

$$
\mathcal{K}_{\kappa}\left(x,\left\{y_{k}\right\}\right)=K_{\mathcal{L}_{\kappa}}(x, \xi),
$$

where $\left\{y_{k}\right\}$ is a sequence in $\Omega$ such that $y_{k} \rightarrow \xi \in \partial \Omega$. It follows that each point of $\Gamma$ may be associated with a point of $\partial \Omega$. Lemma 2.25 clearly shows that $K_{\mathcal{L}_{\kappa}}(\cdot, \xi) \neq K_{\mathcal{L}_{\kappa}}\left(\cdot, \xi^{\prime}\right)$ if $\xi \neq \xi^{\prime}$. Hence, the functions $\mathcal{K}_{\kappa}\left(x, y_{k}\right)$ cannot converge if the sequence $y_{k}$ has more than one accumulation point on $\partial \Omega$ and different points of $\partial \Omega$ must be associated with different points of $\Gamma$. This gives a one-to-one correspondence between $\partial \Omega$ and $\Gamma$ with $\mathcal{K}_{\kappa}(x, Y)=K_{\mathcal{L}_{\kappa}}(x, \xi)$ when $Y \in \Gamma$ corresponds to $\xi \in \partial \Omega$. If $y_{k} \rightarrow \xi$ in the Euclidean topology then $\mathcal{K}_{\kappa}\left(x, Y_{k}\right) \rightarrow \mathcal{K}_{\kappa}(x, Y)$ and, therefore, $Y_{k} \rightarrow Y$ in the $\rho$-topology by Lebesgue's dominated convergence theorem. On the other hand suppose $Y_{k} \rightarrow Y$ in the $\rho$-topology. If $\xi_{k}$ does not converge to $\xi$ in the Euclidean topology there is a subsequence $\xi_{k_{j}}$ such that $\xi_{k_{j}} \rightarrow \xi^{\prime} \neq \xi$ in the Euclidean topology. Then $Y_{k_{j}} \rightarrow Y^{\prime}$ and $Y_{k_{j}} \rightarrow Y$ in the $\rho-$ topology with $Y \neq Y^{\prime}$, which is impossible. Therefore, the Martin $\rho$-topology on $\Omega \cup \Gamma$ is equivalent to the Euclidean topology on $\Omega \cap \partial \Omega$.

By Proposition 2.29 and Proposition 2.1 we have the following result,
Theorem 2.30. Assume $0<\kappa \leq \frac{1}{4}$. There exists a positive constant $c_{43}$ such that

$$
\begin{equation*}
\frac{1}{c_{43}} \frac{d^{\frac{\alpha_{+}}{2}}(y)}{|\xi-y|^{N+\alpha_{+}-2}} \leq K_{\mathcal{L}_{\kappa}}(y, \xi) \leq c_{43} \frac{d^{\frac{\alpha_{+}}{2}}(y)}{|\xi-y|^{N+\alpha_{+}-2}} \tag{2.53}
\end{equation*}
$$

Let us give a Lemma that we will use to prove the representation formula.
Lemma 2.31. Let $\xi \in \partial \Omega, r>0$ be small enough and $u$ be a positive $\mathcal{L}_{\kappa}$-harmonic function in $\Omega$. There exists a super $\mathcal{L}_{\kappa}$-harmonic function $V$ such that

$$
V(x)= \begin{cases}v(x) & \text { in } \Omega \backslash B_{r}(\xi) \\ u(x) & \text { in } \Omega \cap \bar{B}_{r}(\xi)\end{cases}
$$

where $v$ satisfies $\mathcal{L}_{\kappa} v=0$, in $\Omega \backslash B_{r}(\xi), \lim _{x \rightarrow y} v(x)=u(y) \forall y \in \partial B_{r}(\xi) \cap \Omega$ and $\lim _{x \rightarrow y} \frac{v(x)}{W(x)}=$ $0, \forall y \in \partial \Omega \backslash \bar{B}_{r}(\xi)$.

Proof. Since $u$ is $\mathcal{L}_{\kappa}$-harmonic function we have that $u \in C^{2}(\Omega)$. Let $\xi_{0} \in B_{r}(\xi) \cap \Omega$, and $r_{0}$ be such that $B_{r_{0}}\left(\xi_{0}\right) \subset \Omega$. We consider the problem

$$
\begin{aligned}
\mathcal{L}_{\kappa} w & =0, \quad \in \Omega \backslash \bar{B}_{r}(\xi) \\
\lim _{x \rightarrow y} w(x) & =\eta(y) w(y) \forall y \in \partial B_{r}(\xi) \cap \Omega \\
\lim _{x \rightarrow y} \frac{w(x)}{W(x)} & =0, \forall y \in \partial \Omega \backslash \bar{B}_{r}(\xi),
\end{aligned}
$$

where $\eta \in C_{0}^{\infty}\left(B_{\frac{r_{0}}{2}}\left(\xi_{0}\right)\right), 0 \leq \eta \leq 1$. In view of the proof of Propositions 2.9 and 2.10 we can find a positive solution of the above problem $w$. Also we note here that $w \leq u$, and by Harnack inequalities 2.11 and 2.12 , we have that for any $\zeta \in \partial \Omega$

$$
\frac{w(x)}{\phi_{\kappa}(x)} \leq C(\kappa, N, \Omega) \frac{w(y)}{\phi_{\kappa}(y)}, \quad \forall x, y \in B_{\rho}(\zeta)
$$

where $\rho \leq \frac{1}{2} \operatorname{dist}\left(\zeta, \partial B_{r}(\xi)\right)$. Thus we have

$$
\frac{w(x)}{\phi_{\kappa}(x)} \leq C(\kappa, N, \Omega) \frac{u(y)}{\phi_{\kappa}(y)}, \quad \forall x, y \in B_{\rho}(\zeta)
$$

The rest of the proof is standard and we omit it.

We consider a increasing sequence of bounded smooth domains $\left\{\Omega_{n}\right\}$ such that $\overline{\Omega_{n}} \subset \Omega_{n+1}$, $\cup_{n} \Omega_{n}=\Omega$ and $\mathcal{H}^{N-1}\left(\Omega_{n}\right) \rightarrow \mathcal{H}^{N-1}(\Omega)$. Such a sequence is a smooth exhaustion of $\Omega$. For each $n$ the operator $\mathcal{L}_{\kappa}^{\Omega_{n}}$ defined by

$$
\begin{equation*}
\mathcal{L}_{\kappa}^{\Omega_{n}} u=-\Delta u-\frac{\kappa}{d^{2}(x)} u \tag{2.54}
\end{equation*}
$$

is uniformly elliptic and coercive in $H_{0}^{1}\left(\Omega_{n}\right)$ and its first eigenvalue $\lambda_{\kappa}^{\Omega_{n}}$ is larger than $\lambda_{\kappa}$. If $h \in$ $C\left(\partial \Omega_{n}\right)$ the following problem

$$
\begin{align*}
\mathcal{L}_{\kappa}^{\Omega_{n}} v & =0 & & \text { in } \Omega_{n}  \tag{2.55}\\
v & =h & & \text { on } \partial \Omega_{n}
\end{align*}
$$

admits a unique solution which allows to define the $\mathcal{L}_{\kappa}^{\Omega_{n}}$-harmonic measure on $\partial \Omega_{n}$ by

$$
\begin{equation*}
v\left(x_{0}\right)=\int_{\partial \Omega_{n}} h(y) d \omega_{\Omega_{n}}^{x_{0}}(y) \tag{2.56}
\end{equation*}
$$

Thus the Poisson kernel of $\mathcal{L}_{\kappa}^{\Omega_{n}}$ is

$$
\begin{equation*}
K_{\mathcal{L}_{\kappa}^{\Omega_{n}}}(x, y)=\frac{d \omega_{\Omega_{n}}^{x}}{d \omega_{\Omega_{n}}^{x_{0}}}(y) \quad \forall y \in \partial \Omega_{n} \tag{2.57}
\end{equation*}
$$

Proposition 2.32. Assume $0<\kappa \leq \frac{1}{4}$ and let $x_{0} \in \Omega_{1}$. Then for every $Z \in C(\bar{\Omega})$,

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \int_{\partial \Omega_{n}} Z(x) W(x) d \omega_{\Omega_{n}}^{x_{0}}(x)=\int_{\partial \Omega} Z(x) d \omega^{x_{0}}(x) \tag{2.58}
\end{equation*}
$$

Proof. We recall that $d \in C^{2}\left(\bar{\Omega}_{\varepsilon}\right)$ for any $0<\varepsilon \leq \beta_{0}$ and let $n_{0} \in \mathbb{N}$ be such that

$$
\operatorname{dist}\left(\partial \Omega_{n}, \partial \Omega\right)<\frac{\beta_{0}}{2}, \quad \forall n \geq n_{0}
$$

For $n \geq n_{0}$ let $w_{n}$ be the solution of

$$
\begin{align*}
\mathcal{L}_{\kappa}^{\Omega_{n}} w_{n} & =0 & & \text { in } \Omega_{n}  \tag{2.59}\\
w_{n} & =W & & \text { on } \partial \Omega_{n}
\end{align*}
$$

It is straightforward to see that the proof of Propositions 2.17 and 2.18 it is inferred that there exists a positive constant $c_{44}=c_{44}(\Omega, \kappa)$ such that

$$
\left\|w_{n}\right\|_{L^{\infty}\left(\Omega_{n}\right)} \leq c_{44}, \quad \forall n \geq n_{0}
$$

Furthermore

$$
\begin{equation*}
w_{n}\left(x_{0}\right)=\int_{\partial \Omega_{n}} W(x) d \omega_{\Omega_{n}}^{x_{0}}(x)<c_{45} \tag{2.60}
\end{equation*}

We extend $\omega_{\Omega_{n}}^{x_{0}}$ as a Borel measure on $\bar{\Omega}$ by setting $\omega_{\Omega_{n}}^{x_{0}}\left(\bar{\Omega} \backslash \Omega_{n}\right)=0$, and keep the notation $\omega_{\Omega_{n}}^{x_{0}}$ for the extension. Because of (2.60) the sequence $\left\{W \omega_{\Omega_{n}}^{x_{0}}\right\}$ is bounded in the space $\mathfrak{M}_{b}(\bar{\Omega})$ of bounded Borel measures in $\bar{\Omega}$. Thus there exists a subsequence (still denoted by $\left\{W(x) \omega_{\Omega_{n}}^{x_{0}}\right\}$ which converges narrowly to some positive measure, say $\widetilde{\omega}$ which is clearly supported by $\partial \Omega$ and satisfies $\|\widetilde{\omega}\|_{\mathfrak{M}_{b}} \leq c_{45}$ as in (2.60). For every $Z \in C(\bar{\Omega})$ there holds

By Propositions 2.17 and $2.18, \frac{z}{W} \in C(\bar{\Omega})$. Since $\frac{z}{W}\left\lfloor\partial \Omega_{n}\right.$ converges uniformly to $\zeta$, there holds

Theorem 2.33. Let $u$ be a positive $\mathcal{L}_{\kappa}$-harmonic in the domain $\Omega$. Then $u \in L_{\phi_{\kappa}}^{1}(\Omega)$ and there exists a unique Radon measure $\mu$ on $\partial \Omega$ such that

Since $\mu^{x}(F)$ is a positive $\mathcal{L}_{\kappa}$-harmonic function in $\Omega$ the measures $\mu^{x}$ are absolutely continuous with respect to $\mu^{x_{0}}(F)$ by Harnack's inequality. Hence,

We assert that $\frac{d \mu^{x}(F)}{d \mu^{x_{0}}(F)}=K_{\mathcal{L}}(x, y)$ for a.e. $\mu^{x_{0}}(y)$ in $\partial \Omega$. By Besicovitch's theorem,

for a.e. $\mu^{x_{0}}(y)$ in $\partial \Omega$.
By Lemma 2.31 and in view of the proof of Proposition 2.27 we have that $\frac{d \mu^{x}(F)}{d \mu^{x}(F)}$ is a kernel function, and by uniqueness of Kernel functions the proof of assertion follows. Hence

We consider a increasing sequence of bounded smooth domains $\left\{\Omega_{k}\right\}$ such that $\overline{\Omega_{k}} \subset \Omega_{k+1}, \cup \Omega_{k}=\Omega$, $\Omega_{k} \cap G_{k}=\emptyset, \mathcal{H}^{N-1}\left(\Omega_{k}\right) \rightarrow \mathcal{H}^{N-1}(\Omega)$ and

\mathcal{H}^{N-1}\left(\bar{\Omega}_{k} \cap \bar{G}_{k}\right) \rightarrow \mathcal{H}^{N-1}(F) .
$$

Let $w_{\Omega_{k}}^{x_{0}}(y)$ be the $\mathcal{L}_{\kappa}$-harmonic measure in $\partial \Omega_{k}$ (see (2.54)-(2.57)).
Then

& =\int_{\partial \Omega_{k} \cap \partial G_{k}} R_{u}^{\bar{G}_{k}}(y) d w_{\Omega_{k}}^{x_{0}}(y)+\int_{\partial \Omega_{k} \backslash \partial G_{k}} R_{u}^{\bar{G}_{k}}(y) d w_{\Omega_{k}}^{x_{0}}(y) \\
& \geq \int_{\partial \Omega_{k} \cap \partial G_{k}} R_{u}^{\bar{G}_{k}}(y) d w_{\Omega_{k}}^{x_{0}}(y)
\end{aligned}

Now, by Lemma 2.31

& =\int_{\partial \Omega} \int_{\partial \Omega_{k} \cap \partial G_{k}} K_{\mathcal{L}}(y, \xi) d w_{\Omega_{k}}^{x_{0}}(y) d \nu(\xi) \geq \int_{F_{n}} \int_{\partial \Omega_{k} \cap \partial G_{k}} K_{\mathcal{L}}(y, \xi) d w_{\Omega_{k}}^{x_{0}}(y) d \nu(\xi)
\end{aligned}

where $F_{n} \subset F, \cup F_{n}=F$ and $\operatorname{dist}\left(F_{n}, \partial \Omega \backslash F\right)>\frac{1}{n}$.

& =\int_{\partial \Omega} \int_{\partial \Omega_{k} \cap \partial G_{m}} K_{\mathcal{L}}(y, \xi) d w_{\Omega_{k}}^{x_{0}}(y) d \nu(\xi)

and the proof of Theorem follows.

Actually the measure $\mu$ is the boundary trace of $u$. This boundary trace can be achieved in a dynamic way as in [24, Sect 2].

Let $Z \in C^{2}(\bar{\Omega})$ and $\tilde{G} \in C(\Omega)$ which coincides with $G_{\mathcal{L}_{\kappa}}\left(x_{0},.\right)$ in $\Omega_{\delta}$ for some $0<\delta<\beta_{0}$ and some $x_{0} \notin \bar{\Omega}_{\beta_{0}}$. Let $\left\{\Omega_{j}\right\}$ be a smooth exhaustion of $\Omega$ with Green kernel $G_{\mathcal{L}_{\kappa}}^{\Omega_{j}}$ and Poisson kernel $P_{\mathcal{L}_{\kappa}}^{\Omega_{j}}=$ $-\partial_{\mathbf{n}} G_{\mathcal{L}_{\kappa}}^{\Omega_{j}}$. We assume that $j \geq j_{0}$ where $\bar{\Omega}_{\delta}^{\prime} \subset \Omega_{j}$. Set $\zeta_{j}=Z \tilde{G}_{j}$, where the functions $\tilde{G}_{j}$ are $C^{\infty}$ in $\Omega_{j}$, coincide with $G_{\mathcal{L}_{\kappa}}^{\Omega_{j}}\left(x_{0},.\right)$ in $\Omega_{j} \cap \bar{\Omega}_{\delta}$ and satisfy $\tilde{G}_{j} \rightarrow \tilde{G}$ in $C^{2}(\Omega)$-loc and such that $\left|\nabla \tilde{G}_{j} . \nabla Z\right| \leq c_{45}^{\prime} \phi_{\kappa}$.

\int_{\Omega_{j}} v \mathcal{L}_{\kappa} \zeta_{j} d x=-\int_{\partial \Omega_{j}} v \frac{\partial \zeta_{j}}{\partial \mathbf{n}} d S=-\int_{\partial \Omega_{j}} v Z \frac{\partial \tilde{G}_{j}}{\partial \mathbf{n}} d S=\int_{\partial \Omega_{n}} v Z P_{\mathcal{L}_{\kappa}}^{\Omega_{j}}\left(x_{0}, .\right) d S=\int_{\partial \Omega_{j}} v Z d \omega_{\Omega_{j}}^{x_{0}}
$$

By (2.61)

Since $v \in L_{\phi_{\kappa}}^{1}(\Omega)$, the proof follows .
Similarly we can prove
Proposition 2.36. Let $v$ be a positive $\mathcal{L}_{\kappa}$-harmonic function in $\Omega$ with boundary trace $\mu$. Let $0 \leq Z \in$ $C^{2}(\bar{\Omega})$ satisfy

## 3 The nonlinear problem with measures data

### 3.1 The linear boundary value problem with $L^{1}$ data

In the sequel we denote by $\omega=\omega^{x_{0}}$ the $\mathcal{L}_{\kappa}$-harmonic measure in $\Omega$, for some fixed $x_{0} \in \Omega$ and by $\mathfrak{M}_{\phi_{\kappa}}(\Omega)$ be the space of Radon measures $\nu$ in $\Omega$ such that $\phi_{\kappa} d|\nu|$ is a bounded measure. We also denote by $\mathfrak{M}(\partial \Omega)$ the space of Radon measures on $\partial \Omega$ with respective norms $\|\nu\|_{\mathfrak{M}_{\phi_{\kappa}}(\Omega)}$ and $\|\mu\|_{\mathfrak{M}(\partial \Omega)}$. Their respective positive cones are denoted by $\mathfrak{M}_{\phi_{\kappa}}^{+}(\Omega)$ and $\mathfrak{M}^{+}(\partial \Omega)$. By Fubini's theorem and (2.9), for any $\nu \in \mathfrak{M}_{\phi_{\kappa}}(\Omega)$ we can define

In the above inequalities $c_{46}$ and $c_{47}$ are positive constants depending on $\Omega$ and $\kappa$.
For $0<\kappa \leq \frac{1}{4}$, we define the space of test functions $\mathbf{X}(\Omega)$ by

\|u\|_{L_{\phi_{\kappa}}^{1}(\Omega)} \leq c_{46}\|f\|_{L_{\phi_{\kappa}}^{1}(\Omega)}+c_{47}\|h\|_{L^{1}(\partial \Omega, d \omega)} \tag{3.9}
\end{equation*}

Furthermore, for any $\eta \in \mathbf{X}(\Omega), \eta \geq 0$, we have

Step 2: proof of existence. If $f$ and $h$ are bounded, existence follows from Propositions 2.9, 2.10. In the general case let $\left\{\left(f_{n}, h_{n}\right)\right\}$ be a sequence of bounded measurable functions in $\Omega$ and $\partial \Omega$ which converges to $\{(f, h)\}$ in $L_{\phi_{k}}^{1}(\Omega) \times L^{1}(\partial \Omega, d \omega)$. Let $\left\{u_{n}\right\}=\left\{u_{f_{n}, h_{n}}\right\}$ be the sequence weak solutions of (3.6). By estimate (3.9) it is a Cauchy sequence in $L_{\phi_{\kappa}}^{1}(\Omega)$ which converges to $u$. Letting $n \rightarrow \infty$ in identity

In view of the proof of Proposition 2.32 there exists $c_{02}>0$ which depends on $\Omega, N, \kappa,\|h\|_{C^{2}(\bar{\Omega})}$ such that

Thus combining all above and taking the limit in (3.16) we have the proof of (3.10) in the case that $f$ is bounded and $h \in C^{2}(\bar{\Omega})$. We note here that for any $h \in C^{2}(\partial \Omega)$ there exists $H_{m} \in C^{2}(\bar{\Omega})$, such that $\left\|H_{m}\right\|_{C^{2}(\bar{\Omega})} \leq c_{03}\|h\|_{L^{\infty}(\partial \Omega)}$, for some constant $c_{03}$ which depends only on $\Omega$, and $H_{m} \rightarrow h$ in $L^{\infty}(\partial \Omega)$. Thus it is not hard to prove that (2.32) is valid if $f$ is bounded and $h \in C^{2}(\partial \Omega)$. In the general case we consider a sequence $\left(f_{n}, h_{n}\right) \subset L^{\infty}(\Omega) \times C^{2}(\partial \Omega)$ which
converges to $(f, h)$ in $L^{1}(\Omega) \times L^{1}(\partial \Omega, d \omega)$. Since $u_{f_{n}, h_{n}}$ converges to $u_{f, h}$ in $L_{\phi_{\kappa}}^{1}(\Omega)$ we obtain (3.10) from the inequality verified by any $\eta \in \mathbf{X}(\Omega)$

### 3.2 General nonlinearities

Throughout this section $\Omega$ is a smooth bounded domain and $\kappa$ a real number in $\left(0, \frac{1}{4}\right]$. Let $g: \mathbb{R} \mapsto \mathbb{R}$ be a nondecreasing continuous function, vanishing at 0 for simplicity. The problem under consideration is the following

Definition. Let $\nu \in \mathfrak{M}_{\phi_{\kappa}}(\Omega)$ and $\mu \in \mathfrak{M}(\partial \Omega)$. We say that $u$ is a solution of (3.18) if $u \in L_{\phi_{\kappa}}^{1}(\Omega)$, $g(u) \in L_{\phi_{\kappa}}^{1}(\Omega)$ and for any $\eta \in \mathbf{X}(\Omega)$ there holds

Our main existence result for subcritical nonlinearities is the following.

Then for any $(\nu, \mu) \in \mathfrak{M}_{\phi_{k}}(\Omega) \times \in \mathfrak{M}(\partial \Omega)$ problem (3.18) admits a unique solution $u=u_{\nu, \mu}$. Furthermore the mapping $(\nu, \mu) \mapsto u_{\nu, \mu}$ is increasing and stable in the sense that if $\left\{\left(\nu_{n}, \mu_{n}\right)\right\}$ converge to $(\nu, \mu)$ in the weak sense of measures, $\left\{u_{\nu_{n}, \mu_{n}}\right\}$ converges to $u_{\nu, \mu}$ in $L_{\phi_{k}}^{1}(\Omega)$.

The proof is based upon estimates of $\mathbb{M}_{\mathcal{L}_{\kappa}}$ and $\mathbb{K}_{\mathcal{L}_{\kappa}}$ into Marcinkiewicz spaces.
Lemma 3.4. Let $\nu \in \mathfrak{M}_{\phi_{\kappa}}^{+}(\Omega), \mu \in \mathfrak{M}^{+}(\partial \Omega)$ and for $s>0, E_{s}(\nu)=\left\{x \in \Omega: \mathbb{G}_{\mathcal{L}_{\kappa}}[\nu](x)>s\right\}$ and $F_{s}(\mu)=\left\{x \in \Omega: \mathbb{K}_{\mathcal{L}_{k}}[\mu](x)>s\right\}$. $$

Therefore, for any $s_{0}>0$ and any Borel set $G \subset \Omega$

& \leq s_{0} \int_{G} \phi_{\kappa} d x-\int_{s_{0}}^{\infty} s d \mathcal{F}_{s}\left(\delta_{\xi}\right) \\
& \leq s_{0} \int_{G} \phi_{\kappa} d x+c_{50} \int_{s_{0}}^{\infty} s^{-\frac{N+\frac{\alpha_{+}}{2}}{N-2+\frac{\alpha_{+}}{2}}} d s \\
& \leq s_{0} \int_{G} \phi_{\kappa} d x+c_{51} s_{0}^{-\frac{2}{N-2+\frac{\alpha_{+}}{2}}}
\end{aligned}

Next we choose $s_{0}$ so that the two terms in the right part of the last inequality are equal and we get

A simple geometric verification shows that there exists an open domain $\mathcal{O} \subset \overline{\mathcal{O}} \subset \Omega$ such that $y \in \mathcal{O}$, $\operatorname{dist}\left(y, \mathcal{O}^{c}\right)>\lambda_{1} d(y), \mathcal{O} \subset B_{\lambda_{2} d(y)}(y)$ for some $0<\lambda_{1}<\lambda_{2}<1$ independent of $y$ with the following properties

& \leq \int_{\tilde{E}_{s}^{1}\left(\delta_{y}\right)} \phi_{\kappa} d x+\int_{\tilde{E}_{s}^{2}\left(\delta_{y}\right)} \phi_{\kappa} d x \leq c_{53} s^{-\frac{N+\frac{\alpha_{+}}{2}}{N-2+\frac{\alpha_{+}}{2}}}(d(y))^{\frac{\alpha+\left(N+\frac{\alpha_{+}}{2}\right)}{2 N-4+\alpha_{+}}}
\end{aligned}
$$

As in step 1 , for any Borel subset $\Theta \subset \Omega$, we write

& \leq s_{0} \int_{\Theta} \phi_{\kappa} d x-\int_{s_{0}}^{\infty} s d \mathcal{E}_{s}\left(\delta_{y}\right) \\
& \leq s_{0} \int_{\Theta} \phi_{\kappa} d x+c_{53}(d(y))^{\frac{\alpha_{+}\left(N+\frac{\alpha_{+}}{2 N-4+\alpha_{+}}\right.}{2 N}} \int_{s_{0}}^{\infty} s^{-\frac{N+\frac{\alpha_{+}}{2}}{N-2+\frac{\alpha_{+}}{2}}} d s \\
& \leq s_{0} \int_{\Theta} \phi_{\kappa} d x+c_{54}(d(y))^{\frac{\alpha_{+}\left(N+\frac{\alpha_{+}}{2}\right)}{2 N-4+\alpha_{+}}} s_{0}^{-\frac{2}{N-2+\frac{\alpha_{+}}{2}}} \\
& \int_{\Theta} G_{\mathcal{L}_{\kappa}}(x, y) \phi_{\kappa} d x \leq c_{55}(d(y))^{\frac{\alpha_{+}}{2}}\left(\int_{G} \phi_{\kappa} d x\right)^{\frac{2}{N+\frac{\alpha_{+}}{2}}} \leq c_{56} \phi_{\kappa}(y)\left(\int_{G} \phi_{\kappa} d x\right)^{\frac{2}{N+\frac{\alpha_{+}}{2}}} . \tag{3.24}
\end{align*}

If $\sigma$ is not an integer the Besov space $B^{\sigma, p}\left(\mathbb{R}^{d}\right)$ coincides with $W^{\sigma, p}\left(\mathbb{R}^{d}\right)$. When $\sigma$ is an integer we denote $\Delta_{x, y} f=$ $f(x+y)+f(x-y)-2 f(x)$ and

These spaces are fundamental because they are stable under the real interpolation method as it was developed by Lions and Petree. For $\alpha \in \mathbb{R}$ we defined the Bessel kernel of order $\alpha$ by $G_{\alpha}(\xi)=$ $\mathcal{F}^{-1}\left(1+|.|^{2}\right)^{-\frac{\alpha}{2}} \mathcal{F}(\xi)$, where $\mathcal{F}$ is the Fourier transform of moderate distributions in $\mathbb{R}^{d}$. The Bessel space $L_{\alpha, p}\left(\mathbb{R}^{d}\right)$ is defined by

It is known that if $1<p<\infty$ and $\alpha>0, L_{\alpha, p}\left(\mathbb{R}^{d}\right)=W^{\alpha, p}\left(\mathbb{R}^{d}\right)$ if $\alpha \in \mathbb{N}$ and $L_{\alpha, p}\left(\mathbb{R}^{d}\right)=B^{\alpha, p}\left(\mathbb{R}^{d}\right)$ if $\alpha \notin \mathbb{N}$, always with equivalent norms. The Bessel capacity is defined for compact subset $K \subset \mathbb{R}^{d}$ by

Then $\mu \in \mathfrak{M}^{+}(\partial \Omega)$ is a good measure if and only if it is absolutely continuous with respect to the Bessel capacity $C_{2-\frac{2+\alpha_{+}}{2 q^{\prime}}, q^{\prime}}^{\mathbb{R}^{N-1}}$ where $q^{\prime}=\frac{q}{q-1}$, that is

The striking aspect of the proof is that it is based upon potential estimates which have been developed by Marcus and Véron in the study of the supercritical boundary trace problem in polyhedral domains [26]. Before proving this result we need a key potential estimate.

The other term in the right-hand side of (3.56) yields to the same inequality as in (3.55).
Proof of Theorem 3.6: The condition is necessary. Let $K \subset \partial \Omega$ be a compact set and $\eta \in C_{0}^{2}(\partial \Omega)$ such that $0 \leq \eta \leq 1$ and $\eta=1$ on $K$. Then, by (3.46)

Therefore the right-hand side of (3.59) tends to 0 if we substitute $\eta_{n}$ to $\eta$ and thus $\mu(K)=0$ for any $K$ compact with zero capacity and this relation holds for any Borel subset.
Definition. We say that a compact set $K \subset \partial \Omega$ is removable if any positive solution $u \in C(\bar{\Omega} \backslash K)$ of

Theorem 3.10. Assume $0<\kappa \leq \frac{1}{4}$ and $q \geq 1$. A compact set $K \subset \partial \Omega$ is removable if and only if $C_{2-\frac{\mathbb{R}^{N+\alpha_{+}}}{2 q^{\prime}}, q}^{\mathbb{R}^{N-1}}(K)=0$.

Proof. The condition is clearly necessary since, if a compact boundary set $K$ has positive capacity, there exists a capacitary measure $\mu_{k} \in \mathfrak{M}_{+}(\partial \Omega) \cap B^{-2+\frac{2+\alpha_{+}}{2 q^{\prime}}, q}(\partial \Omega)$ with support in $K$ (see e.g. [1]). For such a measure there exists a solution $u_{\mu_{K}}$ of (3.36) with $\mu=\mu_{K}$ by Theorem 3.6. Next we assume that $C_{2-\frac{2+\alpha^{\prime}}{2 q^{\prime}, q}}^{\mathbb{R}^{N-1}}(K)=0$. Then there exists a sequence $\left\{\eta_{n}\right\}$ in $C_{0}^{2}(\partial \Omega)$ satisfying (3.60). In particular, there exists a decreasing sequence $\left\{\mathcal{O}_{n}\right\}$ of relatively open subsets of $\partial \Omega$, containing $K$ such that $\eta_{n}=1$ on $\mathcal{O}_{n}$ and thus $\eta_{n}=1$ on $K_{n}:=\overline{\mathcal{O}}_{n}$. We set $\tilde{\eta}_{n}=1-\eta_{n}$ and $\tilde{\zeta}_{n}=\phi_{\kappa}\left(R\left[\tilde{\eta}_{n}\right]\right)^{2 q^{\prime}}$ where $R$ is defined by (3.51). Then $0 \leq \tilde{\eta}_{n} \leq 1$ and $\tilde{\eta}_{n}=0$ on $K_{n}$. Therefore

Let $\mathcal{O}$ be a relatively open neighborhood of $K$ such that $\overline{\mathcal{O}} \subset \mathcal{O}_{n}$. We set $G_{\mathcal{O}, \beta_{0}}=\left\{x \in \Omega_{\beta_{0}}\right.$ : $\sigma(x) \in \mathcal{O}\}$ and $G_{\mathcal{O}^{c}, \beta_{0}}=\Omega_{\beta_{0}} \backslash G_{\mathcal{O}}$. If $x \in G_{\mathcal{O}}$, dist $\left(x, K_{n}^{c}\right) \geq \tau>0$. Then, by (3.66)-(i) and (3.63), $u^{q} \tilde{\zeta}_{n} \in L^{q}\left(G_{\mathcal{O}}\right)$. Since $u(x)=\circ(W(x))$ in $G_{\mathcal{O}^{c}}$ it follows that $u^{q} \tilde{\zeta}_{n} \in L^{1}\left(\Omega_{\beta_{0}}\right)$ and thus $u^{q} \tilde{\zeta}_{n}$ is integrable in $\Omega$. Similarly, using (N22-1)-(i) and (ii), $u \mathcal{L}_{\kappa} \tilde{\zeta}_{n} \in L^{1}(\Omega)$. Since $\tilde{\zeta}_{n}$ does not vanish in a neighborhood of $K$, we introduce a cut-off function $\theta_{\epsilon} \in C^{2}(\bar{\Omega})$ for $0<\epsilon \leq \frac{\beta_{0}}{2}$, with the following properties,

Since $v$ and $u$ vanish respectively on on $\partial \Omega$ and $\partial \Omega \backslash K$, it follows from Propositions 2.34 and 2.35 that the support of $\tau$ is included in $K$. By Theorem 3.6, $\tau$ vanishes on Borel subsets with zero $C_{2-\frac{2+\alpha+}{2 q^{\prime}}, q^{\prime}}^{\mathbb{R}^{N-1}}$-capacity. Since $C_{2-\frac{2+\alpha_{+}}{2 q^{\prime}}, q^{\prime}}^{\mathbb{R}^{N-1}}(K)=0, \tau=0$. This implies that $u$ is a weak solution of

Remark. Using the fact that $u^{+}$and $u_{-}$are subsolutions of (3.61), it is easy to check that Theorem 3.10 remains valid for any signed solution of (3.61).

Remark. If $1<q<q_{c}$ (see (3.37)) it follows from Sobolev imbedding theorem that only the empty set has zero $C_{2-\frac{\mathbb{R}^{N-1}}{2 q^{\prime}+}, q^{\prime}}^{\mathbb{R}^{\prime}}$-capacity. only the empty set As a consequence of the previous result, if $q \geq q_{c}$ any isolated boundary singularity of a solution of (3.61) is removable.

## 4 Isolated boundary singularities

We denote by $\left\{\mathbf{e}_{1}, \ldots, \mathbf{e}_{N}\right\}$ the canonical basis in $\mathbb{R}^{N}=\left\{x=\left(x^{\prime}, x_{N}\right) \in \mathbb{R}^{N-1} \times \mathbb{R}\right\}$ and by $(r, \sigma)$ the spherical coordinates therein. Then $\mathbb{R}_{+}^{N}=\left\{=\left(x^{\prime}, x_{N}\right):, x^{\prime} \in \mathbb{R}^{N-1}, x_{N}>0\right\}$. We although denote by $S^{N-1}$ and $S_{+}^{N-1}$ the unit sphere and the upper hemisphere of $\mathbb{R}_{+}^{N}$, i.e. $S^{N-1}: \cap \mathbb{R}_{+}^{N}$. In this section we study the behavior near 0 of solutions of

$$
\begin{equation*}
-\Delta u-\frac{\kappa}{d^{2}} u+|u|^{q-1} u=0 \tag{4.1}
\end{equation*}
$$

in a bounded convex domain $\Omega$ of $\mathbb{R}^{N}$ with a smooth boundary containing 0 where $d$ is the distance function to the boundary, $\kappa$ a constant in $\left(0, \frac{1}{4}\right]$ and $q>1$. Although it is not bounded, the model case is $\Omega=\mathbb{R}_{+}^{N}=\left\{=\left(x^{\prime}, x_{N}\right):, x^{\prime} \in \mathbb{R}^{N-1}, x_{N}>0\right\}$ which is represented by $(r, \sigma), r>0, \sigma \in S_{+}^{N-1}$ in spherical coordinates. Then

$$
\begin{equation*}
\mathcal{L}_{\kappa} u=-u_{r r}-\frac{N-1}{r} u_{r}-\frac{1}{r^{2}} \Delta_{S^{N-1}} u-\frac{\kappa}{r^{2}\left(\mathbf{e}_{N} \cdot \sigma\right)^{2}} u+|u|^{q-1} u . \tag{4.2}
\end{equation*}
$$

We also denote by $\nabla^{\prime}$ the covariant gradient on $S^{N-1}$ in the metric of $S^{N-1}$ obtained by the imbedding into $\mathbb{R}^{N}$.

### 4.1 The spherical $\mathcal{L}_{\kappa}$-harmonic problem

It is straightforward to check that the Poisson kernel $K_{\mathcal{L}_{\kappa}}$ of $\mathcal{L}_{\kappa}$ in $\mathbb{R}_{+}^{N}$ has the following expression

K_{\mathcal{L}_{\kappa}}(x, \xi)=c_{N, \kappa} \frac{x_{N}^{\frac{\alpha_{+}}{2}}}{|x-\xi|^{N+\alpha_{+}-2}} \tag{4.3}
\end{equation*}

In spherical coordinates

K_{\mathcal{L}_{\kappa}}(x, 0)=c_{N, \kappa} r^{2-N-\frac{\alpha_{+}}{2}} \psi(\sigma) \quad r>0, \sigma \in S_{+}^{N-1}
$$

where $\psi_{\kappa}(\sigma)=\left.\frac{x_{N}}{|x|}\right|_{S_{+}^{N-1}} ^{\frac{\alpha_{+}}{2}}=\left(\mathbf{e}_{N} \cdot \sigma\right)^{\frac{\alpha_{+}}{2}}$ solves

\begin{align*}
-\Delta_{S^{N-1}} \psi_{\kappa}-\mu_{\kappa} \psi_{\kappa}-\frac{\kappa}{\left(\mathbf{e}_{N} \cdot \sigma\right)^{2}} \psi_{\kappa}=0 & \text { in } S_{+}^{N-1}  \tag{4.4}\\
\psi_{\kappa}=0 & \text { in } \partial S_{+}^{N-1}
\end{align*}
$$

and

$$
\begin{equation*}
\mu_{\kappa}=\frac{\alpha_{+}}{2}\left(N+\frac{\alpha_{+}}{2}-2\right) \tag{4.5}
\end{equation*}
$$

Notice that equation (4.4) admits a unique positive solution with supremum 1. We could have defined the first eigenvalue $\mu_{\kappa}$ of the operator

\mu_{\kappa}=\inf \left\{\frac{\int_{S_{+}^{N-1}}\left(|\nabla w|^{2}-\kappa\left(\mathbf{e}_{N} \cdot \sigma\right)^{-2} w^{2}\right) d S}{\int_{S_{+}^{N-1}} w^{2} d S}: w \in H_{0}^{1}\left(S_{+}^{N-1}\right), w \neq 0\right\} \tag{4.6}
\end{equation*}
$$

By [?] the infimum exists since $\rho(\sigma)=x_{N} L_{S_{+}^{N-1}}=\mathbf{e}_{N} \cdot \sigma$ is the first eigenfunction of $-\Delta_{S^{N-1}}$ in $H_{0}^{1}\left(S_{+}^{N-1}\right)$. The minimizer $\psi_{\kappa}$ belongs to $H_{0}^{1}\left(S_{+}^{N-1}\right)$ only if $1<\kappa<\frac{1}{4}$. Furthermore

$$
\begin{equation*}
\psi_{\kappa} \in \mathbf{Y}\left(S_{+}^{N-1}\right):=\left\{\phi \in H_{l o c}^{1}\left(S^{N-1}\right): \rho^{-\frac{\alpha_{+}}{2}} \phi \in H^{1}\left(S_{+}^{N-1}, \rho^{\alpha_{+}}\right)\right\} \tag{4.7}
\end{equation*}
$$

We can also define $\mu_{k}$ by

\begin{equation*}
\mu_{k}=\inf \left\{\frac{\int_{S_{+}^{N-1}}\left|\nabla^{\prime}\left(\rho^{-\frac{\alpha_{+}}{2}} \omega\right)\right|^{2} \rho^{\alpha_{+}} d S}{\int_{S_{+}^{N-1}} \omega^{2} d S}: \omega \in \mathbf{Y}\left(S_{+}^{N-1}\right) \backslash\{0\}\right\} \tag{4.8}
\end{equation*}
$$

We can use the symmetry of the operator to obtain the second eigenvalue and eigenfunction of $\mathcal{L}_{\kappa}^{\prime}$ on $S_{+}^{N-1}$. We first notice that for $j=1, \ldots, N-1$, the function

is $\mathcal{L}_{\kappa}$-harmonic in $\mathbb{R}_{+}^{N-1}$, positive (resp. negative) on $\left\{x=\left(x_{1}, \ldots, x_{N}: x_{j}>0, x_{N}>0\right\}\right.$ (resp. $\left\{x=\left(x_{1}, \ldots, x_{N}: x_{j}<0, x_{N}>0\right\}\right)$ and vanishes on $\left\{x=\left(x_{1}, \ldots, x_{N}: x_{j}=0, x_{N}=0\right\}\right.$.
Proposition 4.1. For any $j=1, . ., N-1$ the function

\sigma \mapsto \psi_{\kappa, j}(\sigma)=\left(\mathbf{e}_{N} \cdot \sigma\right)^{\frac{\alpha_{+}}{2}} \mathbf{e}_{j} \cdot \sigma
$$

satisfies

\mathcal{L}_{\kappa}^{\prime} \psi_{\kappa, j}=\left(\mu_{\kappa}+N-1+\alpha_{+}\right) \rho_{\kappa, j} \tag{4.10}
\end{equation*}
$$

in $S_{+}^{N-1}$. It is positive (resp. negative) on $S_{+}^{N-1} \cap\left\{x=\left(x_{1}, \ldots, x_{N}\right)=x_{j}>0\right\}$ (resp. $S_{+}^{N-1} \cap\{x=$ $\left.\left.\left(x_{1}, \ldots, x_{N}\right)=x_{j}<0\right\}\right)$ and it vanishes on $\partial S_{+}^{N-1} \cap\left\{x=\left(x_{1}, \ldots, x_{N}\right)=x_{j}=0\right\}$. The real number

$$
\mu_{\kappa, 2}=\mu_{\kappa}+N-1+\alpha_{+}=\left(\frac{\alpha_{+}}{2}+1\right)\left(N+\frac{\alpha_{+}}{2}-1\right)
$$

is the second eigenvalue of $\mathcal{L}_{\kappa}^{\prime}$ in $\mathbf{Y}\left(S_{+}^{N-1}\right)$.
Proof. There holds

\mathcal{L}_{\kappa}^{\prime} \psi_{\kappa, j} & =\mathbf{e}_{j} \cdot \sigma \mathcal{L}_{\kappa} \psi_{\kappa}+\psi_{\kappa} \Delta_{S^{N-1}} \mathbf{e}_{j} \cdot \sigma+2 \nabla^{\prime} \psi_{\kappa} \cdot \nabla^{\prime} \mathbf{e}_{j} \cdot \sigma \\
& =\left(\mu_{\kappa}+N-1\right) \psi_{\kappa, j}-\alpha_{+}\left(\mathbf{e}_{N} \cdot \sigma\right)^{\frac{\alpha_{+}}{2}-1} \nabla^{\prime}\left(\mathbf{e}_{j} \cdot \sigma\right) \cdot \nabla^{\prime}\left(\mathbf{e}_{N} \cdot \sigma\right)
\end{aligned}
$$

Now

\nabla\left(\frac{x_{j}}{r}\right)=\left(\frac{x_{j}}{r}\right)_{r} \frac{x}{r}+\frac{1}{r} \nabla^{\prime}\left(\frac{x_{j}}{r}\right)=\frac{1}{r} \nabla^{\prime}\left(\frac{x_{j}}{r}\right)=\frac{1}{r} \mathbf{e}_{j}-\frac{x_{j}}{r^{3}} x,
$$

thus

$$
\nabla\left(\frac{x_{j}}{r}\right) \cdot \nabla\left(\frac{x_{N}}{r}\right)=-\frac{x_{j} x_{N}}{r^{4}}=\frac{1}{r^{2}} \nabla^{\prime}\left(\frac{x_{j}}{r}\right) \cdot \nabla^{\prime}\left(\frac{x_{N}}{r}\right)=\frac{1}{r^{2}} \nabla^{\prime}\left(\mathbf{e}_{j} \cdot \sigma\right) \cdot \nabla^{\prime}\left(\mathbf{e}_{N} \cdot \sigma\right)
$$

which implies

$$
\nabla^{\prime}\left(\mathbf{e}_{j} \cdot \sigma\right) \cdot \nabla^{\prime}\left(\mathbf{e}_{N} \cdot \sigma\right)=-\frac{x_{j} x_{N}}{r^{2}}=-\left(\mathbf{e}_{j} \cdot \sigma\right)\left(\mathbf{e}_{N} \cdot \sigma\right)
$$

and finally

$$
\begin{equation*}
\mathcal{L}_{\kappa} \psi_{\kappa, j}=\left(\mu_{\kappa}+N-1+\alpha_{+}\right) \psi_{\kappa, j} \tag{4.11}
\end{equation*}
$$

Since $S_{+}^{N-1}=\left\{\left(\sigma^{\prime} \sin \theta, \cos \theta\right): \sigma^{\prime} \in S^{N-2}, \theta \in\left[0, \frac{\pi}{2}\right]\right\}, \mathbf{e}_{N} \cdot \sigma=\cos \theta, \mathbf{e}_{j} \cdot \sigma=\mathbf{e}_{j} \cdot \sigma^{\prime} \sin \theta$ and $d S=(\sin \theta)^{N-2} d S^{\prime} d \theta$ where $d S$ and $d S^{\prime}$ are the volume element of $S^{N-1}$ and $S^{N-2}$ respectively, we derive from the fact that $\sigma^{\prime} \mapsto \mathbf{e}_{j} . \sigma^{\prime}$ is an odd function on $S^{N-2}$,

\int_{S_{+}^{N-1}} \psi_{\kappa, j} \psi_{\kappa} d S & =\int_{S_{+}^{N-1}}\left(\mathbf{e}_{N} \cdot \sigma\right)^{\alpha_{+}} \mathbf{e}_{j} \cdot \sigma d S \\
& =\int_{0}^{\frac{\pi}{2}}\left(\int_{S^{N-2}} \mathbf{e}_{j} \cdot \sigma^{\prime} d S^{\prime}\right)(\cos \theta)^{\alpha_{+}}(\sin \theta)^{N-1} d \theta \\
& =0
\end{aligned}
$$

Hence $\psi_{\kappa, j}$ is an eigenvalue of $\mathcal{L}_{\kappa}^{\prime}$ in $\mathbf{Y}\left(S_{+}^{N-1}\right)$ with two nodal domains and the space the $\psi_{\kappa, j}$ span is ( $\mathrm{N}-1$ )-dimensional and any linear combination of the $\psi_{\kappa, j}$ has exactely two nodal domains since

$$
\sum_{j=1}^{N-1} a_{j} \psi_{\kappa, j}=\left(\mathbf{e}_{N} \cdot \sigma\right)^{\frac{\alpha_{+}}{2}}\left(\sum_{j=1}^{N-1} a_{j} \mathbf{e}_{j}\right) \cdot \sigma
$$

This implies that $\mu_{\kappa, 2}$ is the second eigenvalue.

### 4.2 The nonlinear eigenvalue problem

If we look for separable solutions under the form

u(x)=u(r, \sigma)=r^{\alpha} \omega(\sigma)
$$

then necessarily $\alpha=-\frac{2}{q-1}$ and $\omega$ is a solution of

&-\Delta_{S^{N-1}} \omega-\ell_{q, N} \omega-\frac{\kappa}{\left(\mathbf{e}_{N} \cdot \sigma\right)^{2}} \omega+|\omega|^{q-1} \omega=0  \tag{4.12}\\
& \omega=0 \\
& \text { in } S_{+}^{N-1}  \tag{4.13}\\
& \text { in } \partial S_{+}^{N-1} \\
& \ell_{q, N}=\frac{2}{q-1}\left(\frac{2}{q-1}+2-N\right)
\end{align*}
$$

and (4.6) is transformed accordingly. We denote by

$$
\begin{equation*}
\mathcal{E}_{\kappa}=\left\{\omega \in \mathbf{Y}\left(S_{+}^{N-1}\right) \cap L^{q+1}\left(S_{+}^{N-1}\right) \text { s. t. (4.12) holds }\right\} \tag{4.14}
\end{equation*}
$$

and by $\mathcal{E}_{\kappa}^{+}$the set of the nonnegative ones. We also recall that $q_{c}:=\frac{2 N+\alpha_{+}}{2 N-4+\alpha_{+}}$and we define a second critical value $q_{e}:=\frac{2 N+2+\alpha_{+}}{2 N-2+\alpha_{+}}$.

The following result holds
Theorem 4.2. Assume $0<\kappa \leq \frac{1}{4}$ and $q>1$, then
(i) If $q \geq q_{c}, \mathcal{E}_{\kappa}=\{0\}$.
(ii) If $1<q<q_{c}, \mathcal{E}_{\kappa}^{+}$is contains exactly two elements: 0 and $\omega_{\kappa}$. Furthermore $\omega_{\kappa}$ depends only on the azimuthal angle $\theta$.
(iii) If $q_{e} \leq q<q_{c}, \mathcal{E}_{\kappa}$ contains three elements: $0, \omega_{\kappa}$ and $-\omega_{\kappa}$.

Proof. We recall that $q \geq q_{c} \Longleftrightarrow \ell_{q, N} \leq \mu_{\kappa}$. Then non-existence follows by multiplying by $\omega$ and integrating on $S_{+}^{N-1}$. For existence, we consider the functional

$$

J_{\kappa}(w)=\int_{S_{+}^{N-1}}\left(\left|\nabla^{\prime}(w)\right|^{2}+\left(\mu_{\kappa}-\ell_{q, N}\right) w^{2}+\frac{2}{q+1} \psi_{\kappa}^{q-1}|w|^{q+1}\right) \psi_{\kappa}^{2} d S \tag{4.15}
\end{equation*}
$$

defined in $H^{1}\left(S_{+}^{N-1}, \psi_{\kappa}^{2} d S\right) \cap L^{q+1}\left(S_{+}^{N-1}, \psi_{\kappa}^{q+1} d S\right)$. Since $\mu_{\kappa}-\ell_{q, N}<0$, there exists a nontrivial minimum $w \kappa>0$, which satisfies

-\operatorname{div}\left(\psi_{\kappa}^{2} \nabla^{\prime} w_{\kappa}\right)+\left(\mu_{\kappa}-\ell_{q, N}\right) \psi_{\kappa}^{2} w_{\kappa}+\psi_{\kappa}^{q+1} w_{\kappa}^{q}=0 \tag{4.16}
\end{equation*}
$$

If we set $\omega_{\kappa}=\psi_{\kappa} w_{\kappa}$, then $\omega_{\kappa}$ satisfies

$$
\begin{equation*}
\mathcal{L}_{\kappa}^{\prime} \omega_{\kappa}-\ell_{q, N} \omega_{\kappa}+\omega_{\kappa}^{q}=0 \quad \text { in } S_{+}^{N-1} \tag{4.17}
\end{equation*}
$$

By monotonicity we derive that $\omega_{\kappa} \in L^{p}\left(S_{+}^{N-1}\right)$ for any $1<p<\infty$ and finally, that $\omega_{\kappa}$ satisfies the regularity estimates of Lemma 2.9 and Lemma 2.10. Moreover $\omega_{\kappa}>0$ by the maximum principle.

In the case $q \geq q_{c}$ or equivalently $\mu_{\kappa}-\ell_{q, N} \geq 0$, nonexistence of nontrivial solution is clear from (4.16).

Uniqueness. By Proposition $2.8 \omega_{\kappa}(x) \leq c_{86}(\rho(x))^{\frac{\alpha_{+}}{2}}$ and by standard scaling techniques $\left|\nabla \omega_{\kappa}(x)\right| \leq$ $c_{87}(\rho(x))^{\frac{\alpha_{+}}{2}-1}$. Assume now two different positive solutions of (4.12) $\omega_{\kappa}$ and $\omega_{\kappa}^{\prime}$ exist. Since max $\left\{\omega_{\kappa}, \omega_{\kappa}^{\prime}\right\}$ and $\omega_{\kappa}+\omega_{\kappa}^{\prime}$ are respectively a subsolution and a supersolution and they are ordered, we can assume that $\omega_{\kappa}^{\prime}<\omega_{\kappa}<c \omega_{\kappa}^{\prime}$ for some $c>1$. Let $\epsilon>0$ and $\epsilon^{\prime}=c^{-1} \epsilon$, then $\epsilon \omega_{\kappa}^{\prime} \geq \epsilon^{\prime} \omega_{\kappa}$. Set

\vartheta_{\epsilon}=\frac{\left(\left(\omega_{\kappa}^{\prime}+\epsilon^{\prime}\right)^{2}-\left(\omega_{\kappa}+\epsilon\right)^{2}\right)_{+}}{\omega_{\kappa}+\epsilon}, \vartheta_{\epsilon^{\prime}}=\frac{\left(\left(\omega_{\kappa}^{\prime}+\epsilon^{\prime}\right)^{2}-\left(\omega_{\kappa}+\epsilon\right)^{2}\right)_{+}}{\omega_{\kappa}^{\prime}+\epsilon^{\prime}}
$$

and $S_{\epsilon, \epsilon^{\prime}}=\left\{\sigma \in S_{+}^{N-1}: \omega_{\kappa}^{\prime}+\epsilon^{\prime}>\omega_{\kappa}+\epsilon\right\}$. The assume that $S_{\epsilon, \epsilon^{\prime}} \neq \emptyset$ for any $\epsilon>0$. Then

$$
\int_{S_{\epsilon, \epsilon^{\prime}}}\left(\nabla \omega_{\kappa}^{\prime} \cdot \nabla \vartheta_{\epsilon^{\prime}}-\nabla \omega_{\kappa} \cdot \nabla \vartheta_{\epsilon}-\left(\ell_{q, N}+\frac{\kappa}{\rho^{2}}\right)\left(\omega_{\kappa}^{\prime} \cdot \vartheta_{\epsilon^{\prime}}-\omega_{\kappa} \cdot \vartheta_{\epsilon}\right)+\omega_{\kappa}^{\prime q} \vartheta_{\epsilon^{\prime}}-\omega_{\kappa}^{q} \vartheta_{\epsilon}\right) d S=0
$$

The first integrand on the l.h. side is equal to

$$
\int_{S_{\epsilon, \epsilon^{\prime}}}\left(\left|\nabla \omega_{\kappa}^{\prime}-\frac{\omega_{\kappa}^{\prime}+\epsilon^{\prime}}{\omega_{\kappa}+\epsilon} \nabla \omega_{\kappa}\right|^{2}+\left|\nabla \omega_{\kappa}-\frac{\omega_{\kappa}+\epsilon}{\omega_{\kappa}^{\prime}+\epsilon^{\prime}} \nabla \omega_{\kappa}^{\prime}\right|^{2}\right) d S \geq 0
$$

Since $\epsilon \omega_{\kappa}^{\prime}<\epsilon^{\prime} \omega_{\kappa}$ and $\left(\omega_{\kappa}^{\prime}+\epsilon^{\prime}\right)^{2}>\left(\omega_{\kappa}+\epsilon\right)^{2}$, the second integrand on the 1.h. side is equal to

$$
-\int_{S_{\epsilon, \epsilon^{\prime}}}\left(\ell_{q, N}+\frac{\kappa}{\rho^{2}}\right)\left(\frac{\omega_{\kappa}^{\prime}}{\omega_{\kappa}^{\prime}+\epsilon^{\prime}}-\frac{\omega_{\kappa}}{\omega_{\kappa}+\epsilon}\right)\left(\left(\omega_{\kappa}^{\prime}+\epsilon^{\prime}\right)^{2}-\left(\omega_{\kappa}+\epsilon\right)^{2}\right) d S \geq 0
$$

At end, the last integrand is

$$
\int_{S_{\epsilon, \epsilon^{\prime}}}\left(\frac{\omega_{\kappa}^{\prime q}}{\omega_{\kappa}^{\prime}+\epsilon^{\prime}}-\frac{\omega_{\kappa}^{q}}{\omega_{\kappa}+\epsilon}\right)\left(\left(\omega_{\kappa}^{\prime}+\epsilon^{\prime}\right)^{2}-\left(\omega_{\kappa}+\epsilon\right)^{2}\right) d S
$$

If we let $\epsilon \rightarrow 0$, we derive

\int_{S_{+}^{N-1}}\left(\omega_{\kappa}^{\prime q-1}-\omega_{\kappa}^{q-1}\right)\left(\omega_{\kappa}^{\prime 2}-\omega_{\kappa}^{2}\right)_{+} d S \leq 0

This yields a contradiction. Therefore uniqueness holds.
Case $q_{e} \leq q<q_{c}$. Assume $\omega_{\kappa}$ is a solution. Using the representation of $S_{+}^{N-1}$ already introduced in the proof of Proposition 4.1, with $\sigma=\left(\sigma^{\prime}, \theta\right)$ and

\Delta_{S^{N-1}} \omega_{\kappa}=\frac{1}{(\sin \theta)^{N-2}} \frac{\partial}{\partial \theta}\left((\sin \theta)^{N-2} \frac{\partial \omega_{\kappa}}{\partial \theta}\right)+\frac{1}{\sin ^{2} \theta} \Delta_{S^{N-2}} \omega_{\kappa}
$$

where $\Delta_{S^{N-2}}$ is the Laplace-Beltrami operator on $S^{N-2}$, we set

$$
\bar{\omega}_{\kappa}(\theta)=\frac{1}{\left|S^{N-2}\right|} \int_{S^{N-2}} \omega_{\kappa}\left(\sigma^{\prime}, \theta\right) d S^{\prime}\left(\sigma^{\prime}\right)
$$

Then $\bar{\omega}_{\kappa}$ is independent of $\sigma^{\prime} \in S^{N-2}$ and furthermore

$$
\int_{S_{+}^{N-1}}\left(\omega_{\kappa}-\bar{\omega}_{\kappa}\right) \psi_{\kappa} d S=\int_{0}^{\frac{\pi}{2}}\left(\int_{S^{N-2}}\left(\omega_{\kappa}-\bar{\omega}_{\kappa}\right) d S^{\prime}\right)(\sin \theta)^{N-2}(\cos \theta)^{\frac{\alpha_{+}}{2}} d \theta=0
$$

thus $\bar{\omega}_{\kappa}$ is the projection of $\omega_{\kappa}$ onto the first eigenspace of $\mathcal{L}_{\kappa}$ and

$$
\int_{S_{+}^{N-1}}\left(\omega_{\kappa}-\bar{\omega}_{\kappa}\right) \mathcal{L}_{\kappa}\left(\omega_{\kappa}-\bar{\omega}_{\kappa} d S \geq \mu_{\kappa, 2} \int_{S_{+}^{N-1}}\left(\omega_{\kappa}-\bar{\omega}_{\kappa}\right)^{2} d S\right.
$$

At end, noting that

$$
\int_{S_{+}^{N-2}}\left(\overline{g_{q} \circ \omega_{\kappa}}-g_{q} \circ \bar{\omega}_{\kappa}\right)\left(\omega_{\kappa}-\bar{\omega}_{\kappa}\right) d S^{\prime}=0
$$

with $g_{q} \circ u=|u|^{q-1} u$,

$$
\begin{aligned}
\int_{S_{+}^{N-1}}\left(g_{q} \circ \omega_{\kappa}-\overline{g_{q} \circ \omega_{\kappa}}\right)\left(\omega_{\kappa}-\bar{\omega}_{\kappa}\right) d S & =\int_{0}^{\frac{\pi}{2}} \int_{S_{+}^{N-2}}\left(g_{q} \circ \omega_{\kappa}-\overline{g_{q} \circ \omega_{\kappa}}\right)\left(\omega_{\kappa}-\bar{\omega}_{\kappa}\right) d S^{\prime}(\sin \theta)^{N-2} d \theta \\
& \left.=\int_{0}^{\frac{\pi}{2}} \int_{S_{+}^{N-2}}\left(g_{q} \circ \omega_{\kappa}\right)-g_{q} \circ \bar{\omega}_{\kappa}\right)\left(\omega_{\kappa}-\bar{\omega}_{\kappa}\right) d S^{\prime}(\sin \theta)^{N-2} d \theta \\
& \geq 2^{1-q} \int_{S_{+}^{N-1}}\left|\omega_{\kappa}-\bar{\omega}_{\kappa}\right|^{q+1} d S
\end{aligned}
$$

we derive that $w=\omega_{\kappa}-\bar{\omega}_{\kappa}$, satisfies

$$
\int_{S_{+}^{N-1}}\left(\left(\mu_{\kappa, 2}-\ell_{N, q}\right)\left(\omega_{\kappa}-\bar{\omega}_{\kappa}\right)^{2}+2^{1-q}\left|\omega_{\kappa}-\bar{\omega}_{\kappa}\right|^{q+1}\right) d S, \leq 0
$$

which implies $\omega_{\kappa}=\bar{\omega}_{\kappa}$ and it satisfies

$$
\begin{equation*}
\frac{1}{(\sin \theta)^{N-2}} \frac{d}{d \theta}\left((\sin \theta)^{N-2} \frac{d \omega_{\kappa}}{d \theta}\right)+\left(\ell_{q, N}+\frac{\kappa}{\cos ^{2} \theta}\right) \omega_{\kappa}-g_{q} \circ \omega_{\kappa}=0 \tag{4.18}
\end{equation*}
$$

Since $\mu_{\kappa, 1}<\ell_{q, N} \leq \mu_{\kappa, 2}$, by [4, Th. 4, Corol. 1] this equation admits three solutions, $\omega_{\kappa},-\omega_{\kappa}$ and 0.

Remark. For $\epsilon>0$ small enough the function $\epsilon \psi_{\kappa}$ is a subsolution for problem (4.12). This implies

\omega_{\kappa}(\sigma) \geq \epsilon \psi_{\kappa}(\sigma) \quad \forall \sigma \in S_{+}^{N-1} \tag{4.19}
\end{equation*}
$$

### 4.3 Isolated boundary singularities

Throughout this section we assume that $\Omega \subset \mathbb{R}_{+}^{N}, 0 \in \partial \Omega$ the tangent plane to $\partial \Omega$ at 0 is $\partial \mathbb{R}_{+}^{N}$ and that $1<q<q_{c}$.

Lemma 4.3. There holds

$$
\begin{equation*}
\lim _{|x| \rightarrow 0} \frac{\mathbb{G}_{\mathcal{L}_{\kappa}}\left[\left(K_{\mathcal{L}_{\kappa}}(., 0)\right)^{q}\right](x)}{K_{\mathcal{L}_{\kappa}}(x, 0)}=0 \tag{4.20}
\end{equation*}
$$

Proof. We recall the following estimates (1.8), (2.53)
(i) $\quad G_{\mathcal{L}_{\kappa}}(x, y) \leq c_{3} \min \left\{\frac{1}{|x-y|^{N-2}}, \frac{(d(x))^{\frac{\alpha_{+}}{2}}(d(y))^{\frac{\alpha_{+}}{2}}}{|x-y|^{N+\alpha_{+}-2}}\right\}$
(ii) $\quad c_{3}^{-1} \frac{(d(x))^{\frac{\alpha}{2}}}{|x|^{N+\alpha_{+}-2}} \leq K_{\mathcal{L}_{\kappa}}(x, 0) \leq c_{3} \frac{(d(x))^{\frac{\alpha_{+}}{2}}}{|x|^{N+\alpha_{+}-2}}$.

Then

$$
\begin{aligned}
\frac{\mathbb{G}_{\mathcal{L}_{\kappa}}\left[K_{\mathcal{L}_{\kappa}}^{q}(., 0)\right](x)}{K_{\mathcal{L}_{\kappa}}(x, 0)} & \leq c_{3}^{q+2}|x|^{N+\alpha_{+}-2} \int_{\Omega} \frac{(d(y))^{\frac{(q+1) \alpha_{+}}{2}} d y}{|x-y|^{N+\alpha_{+}-2}|y|^{q\left(N+\alpha_{+}-2\right)}} \\
& \leq c_{3}^{q+2}|x|^{N+\frac{\alpha_{+}}{2}-q\left(N+\frac{\alpha_{+}}{2}-2\right)} \int_{\mathbb{R}^{N}} \frac{d \eta}{\left|e_{x}-\eta\right|^{N+\alpha_{+}-2}|\eta|^{q\left(N+\alpha_{+}-2\right)}}
\end{aligned}
$$

where $e_{x}=|x|^{-1} x$. This last integral is finite and independent of $x$. Since $q<q_{c}$, (4.20) follows.
Corollary 4.4. Let $u_{k \delta_{0}}$ be the unique solution of

$$
\begin{align*}
\mathcal{L}_{\kappa} u+|u|^{q-1} u & =0 & & \text { in } \Omega  \tag{4.21}\\
u & =k \delta_{0} & & \text { in } \partial \Omega .
\end{align*}
$$

Then

$$
\begin{equation*}
\lim _{x \rightarrow 0} \frac{u_{k \delta_{0}}}{K_{\mathcal{L}_{\kappa}}(x)}=k \tag{4.22}
\end{equation*}
$$

Proof. This is a consequence of (4.20) and the inequality

$$
\begin{equation*}
k \mathbb{K}_{\mathcal{L}_{\kappa}}\left[\delta_{0}\right](x)-k^{q} \mathbb{G}\left[\left(\mathbb{K}_{\mathcal{L}_{\kappa}}\left[\delta_{0}\right]\right)^{q}\right](x) \leq u_{k \delta_{0}}(x) \leq k \mathbb{K}_{\mathcal{L}_{\kappa}}\left[\delta_{0}\right](x) \tag{4.23}
\end{equation*}
$$

Proposition 4.5. There exists $u_{\infty, 0}=\lim _{k \rightarrow \infty} u_{k \delta_{0}}$ and there holds

$$
\begin{equation*}
\lim _{\substack{x \rightarrow 0, x \in \Omega \\ x|x|^{-1} \rightarrow \sigma}}|x|^{\frac{2}{q-1}} u_{\infty, 0}(x)=\omega_{\kappa}(\sigma), \tag{4.24}
\end{equation*}
$$

uniformly on compact subsets of $S_{+}^{N-1}$.

Proof. The correspondence $k \mapsto u_{k \delta_{0}}$ is increasing and by the Keller-Osserman estimate, it converges, when $k \rightarrow \infty$ to some smooth function $u_{\infty, 0}$ defined in $\Omega$ where it satisfies (1.1). By Proposition 6.1, for any $0<R<R_{0}, u_{k \delta_{0}}$, and therefore $u_{\infty, 0}$, vanishes on any compact subset of $\partial \Omega \backslash\{0\}$ and furthermore

$$
u_{\infty, 0}(x) \leq \begin{cases}c_{K, \gamma, \kappa}(\operatorname{dist}(x, K))^{\gamma} \quad \forall \gamma \in\left(\frac{\alpha_{-}}{2}, \frac{\alpha_{+}}{2}\right) & \text { if } 0<\kappa<\frac{1}{4} \\ c_{K} \sqrt{\operatorname{dist}(x, K)} \sqrt{\ln \left(\frac{\operatorname{diam}(\Omega)}{\operatorname{dist}(x, K)}\right)} & \text { if } \kappa=\frac{1}{4}\end{cases}
$$

for all compact set $K \subset \partial \Omega \backslash\{0\}$. Combining this estimate with Propositions 6.3 we obtain

$$
\begin{equation*}
u_{\infty, 0}(x) \leq c_{90}(d(x))^{\frac{\alpha_{+}}{2}}|x|^{-\frac{2}{q-1}-\frac{\alpha_{+}}{2}} \quad \forall x \in \Omega \tag{4.25}
\end{equation*}
$$

and

$$
\begin{equation*}
\left|\nabla u_{\infty, 0}(x)\right| \leq c_{90}(d(x))^{\frac{\alpha_{+}}{2}-1}|x|^{-\frac{2}{q-1}-\frac{\alpha_{+}}{2}} \quad \forall x \in \Omega \tag{4.26}
\end{equation*}
$$

Let $\ell_{0}>0$ be small enough such that $\ell \mathbf{e} \in \Omega$ for any $0<\ell<\ell_{0}$, where $\mathbf{e}=(0, \ldots, 0,1)$. Then by (1.8), (2.53) and (4.23) we can easily prove that there exist positive constants $c_{01}$ and $c_{02}$ such that

\ell^{\frac{2}{q-1}} u_{\infty, 0}(\ell \mathbf{e}) \geq c_{01} k \ell^{\frac{2}{q-1}-N-\frac{\alpha_{+}}{2}+2}-c_{02} k^{q} \ell^{2-q\left(N+\frac{\alpha_{+}}{2}-2\right)+\frac{2}{q-1}}, \quad \forall k>0
$$

Now we set $k=\frac{1}{M \ell^{\frac{2}{q-1}-N-\frac{\alpha_{+}}{2}+2}}$, then we have that

$$
\ell^{\frac{2}{q-1}} u_{\infty, 0}(\ell \mathbf{e}) \geq \frac{c_{01}}{M}-\frac{c_{02}}{M^{q}}
$$

Thus if we choose $M$ big enough, we can easily show that there exists $c_{03}>0$ which depends on $\kappa, \Omega, q, N$ such that

$$
\begin{equation*}
\ell^{\frac{2}{q-1}} u_{\infty, 0}(\ell \mathbf{e}) \geq c_{03}>0, \quad \forall 0<\ell<\ell_{0} \tag{4.27}
\end{equation*}
$$

For $\ell>0$, we put $T_{\ell}[v](x)=\ell^{\frac{2}{q-1}} v(\ell x), \Omega_{\ell}=\ell^{-1} \Omega, d_{\ell}(y)=\operatorname{dist}\left(y, \partial \Omega_{\ell}\right)$. If $v$ satisfies (4.1) in $\Omega$ and vanishes on $\partial \Omega \backslash\{0\}, T_{\ell}[v]$ vanishes on $\partial \Omega_{\ell} \backslash\{0\}$ and satisfies

$$
\begin{equation*}
-\Delta T_{\ell}[v]-\frac{\kappa}{d_{\ell}^{2}} T_{\ell}[v]+\left|T_{\ell}[v]\right|^{q-1} T_{\ell}[v]=0 \quad \in \Omega_{\ell} \tag{4.28}
\end{equation*}
$$

In order to avoid ambiguity, we set $u_{k \delta_{0}}=u_{k \delta_{0}}^{\Omega}, v_{k \delta_{0}}=v_{k \delta_{0}}^{\Omega}, u_{\infty, 0}=u_{\infty, 0}^{\Omega}$ and $v_{\infty, 0}=v_{\infty, 0}^{\Omega}$. Since inequalities (4.25) and (4.26) are invariant under the scaling transformation, the standard elliptic equations regularity theory yields the following estimates

$$
\begin{equation*}
u_{\infty, 0}^{\Omega_{\ell}}(y) \leq c_{92}\left(d_{\ell}(y)\right)^{\frac{\alpha_{+}}{2}}|y|^{-\frac{2}{q-1}-\frac{\alpha_{+}}{2}} \quad \forall y \in \Omega_{\ell} \tag{4.29}
\end{equation*}
$$

and

$$
\begin{equation*}
\left|\nabla u_{\infty, 0}^{\Omega_{\ell}}(y)\right| \leq c_{92}\left(d_{\ell}(y)\right)^{\frac{\alpha_{+}}{2}-1}|y|^{-\frac{2}{q-1}-\frac{\alpha_{+}}{2}} \quad \forall y \in \Omega_{\ell} \tag{4.30}
\end{equation*}
$$

valid for any $0<\ell \leq 1$. If we let $k \rightarrow \infty$, we obtain $T_{\ell}\left[u_{\infty, 0}^{\Omega}\right]=u_{\infty, 0}^{\Omega_{\ell}}$ and because of the group property of the transformation $T_{\ell}, T_{\ell^{\prime}}\left[u_{\infty, 0}^{\Omega_{\ell}}\right]=u_{\infty, 0}^{\Omega_{\ell^{\prime} \ell}}$ for any $\ell, \ell^{\prime}>0$. Estimates (4.29) and (4.30) imply that $\left\{u_{\infty, 0}^{\Omega_{\ell}}\right\}$ is relatively compact for the topology of convergence on compact subsets of $\mathbb{R}_{+}^{N}$. Therefore there exists a sequence $\left\{\ell_{n}\right\}$ tending to 0 and a function $U$ such that $\left\{u_{\infty, 0}^{\Omega_{\ell_{n}}}\right\}$ converges to $U$ uniformly on any compact subset of $\mathbb{R}_{+}^{N}$. By (4.27) this function is identically equal to zero. Therefore $U$ is a weak solution of

$$
\begin{equation*}
-\Delta U-\frac{\kappa}{y_{N}^{2}} U+U^{q}=0 \quad \text { in } \mathbb{R}_{+}^{N} \tag{4.31}
\end{equation*}
$$

Furthermore

$$
\begin{equation*}
u_{\infty, 0}^{\mathbb{R}_{+}^{N}}(y) \leq c_{92} y_{N}^{\frac{\alpha_{+}}{2}}|y|^{-\frac{2}{q-1}-\frac{\alpha_{+}}{2}} \quad \forall y \in \mathbb{R}_{+}^{N} \tag{4.32}
\end{equation*}
$$

Since $T_{\ell^{\prime}}\left[u_{\infty, 0}^{\Omega_{\ell_{n}}}\right]=u_{\infty, 0}^{\Omega_{\ell^{\prime} \ell_{n}}}$ we derive $T_{\ell^{\prime}}[U]=U$ for any $\ell^{\prime}>0$, thus $U$ is self similar. Set $\omega\left(\frac{y}{|y|}\right)=$ $U\left(\frac{y}{|y|}\right)$. If we set $\sigma=\frac{y}{|y|}$ then there holds

$$
\begin{equation*}
\omega(\sigma) \leq c_{92} \psi_{\kappa}(\sigma) \quad \forall \sigma \in S_{+}^{N-1} \tag{4.33}
\end{equation*}
$$

Therefore $\omega$ satisfies (4.12) and it coincides with the unique positive element $\omega_{\kappa}$ of $\mathcal{E}_{\kappa}$, since by (4.27) $U(\mathbf{e}) \geq c_{03}>0$. Thus $u_{\infty, 0}^{\Omega_{\ell}}$ converges to $U$ on compact subsets of $\mathbb{R}_{+}^{N}$. In particular (4.24) holds on compact subsets of $S_{+}^{N-1}$.

## 5 The boundary trace of positive solutions

As before we assume that $0<\kappa \leq \frac{1}{4}, q>1$ and $\Omega$ is a bounded smooth domain, convex if $\kappa=\frac{1}{4}$. Although the construction of the boundary trace can be made in a more general framework, we restrict ourselves to the class $\mathcal{U}_{+}(\Omega)$ of positive smooth functions $u$ satisfying

$$
\begin{equation*}
\mathcal{L}_{\kappa} u+|u|^{q-1} u=0 \tag{5.1}
\end{equation*}
$$

in $\Omega$.
Lemma 5.1. Let $f \in L_{\phi_{k}}^{1}(\Omega)$. If $u$ is a nonnegative solution of

$$
\begin{equation*}
\mathcal{L}_{\kappa} u=f \quad \text { in } \Omega \tag{5.2}
\end{equation*}
$$

there exists $\mu \in \mathfrak{M}_{+}(\partial \Omega)$ such that $u$ admits $\mu$ for boundary trace and

$$
\begin{equation*}
u=\mathbb{G}_{\mathcal{L}_{k}}[f]+\mathbb{K}_{\mathcal{L}_{\kappa}}[\mu] . \tag{5.3}
\end{equation*}
$$

Proof. Let $v=\mathbb{G}_{\mathcal{L}_{\kappa}}[f]$, then $u-v$ is $\mathcal{L}_{\kappa}$-harmonic and positive thus the result follows.
Definition Let $G \subset \Omega$ be a domain. A function $u \in L_{l o c}^{q}(G)$ is a supersolution (resp. subsolution) of (5.1) if

$$
\begin{equation*}
\mathcal{L}_{\kappa} u+|u|^{q-1} u \geq 0 \quad\left(\text { resp. } \quad \mathcal{L}_{\kappa} u+|u|^{q-1} u \leq 0\right) \tag{5.4}
\end{equation*}
$$

in the sense of distributions in $G$.
The following comparison principle holds [3, Lemma 3.2]
Proposition 5.2. Let $G \subset \Omega$ be a smooth domain and $\bar{u}, \underline{u}$ a pair of nonnegative supersolution and subsolution respectively in $G$.
(i) If there holds

$$
\begin{equation*}
\limsup _{\operatorname{dist}(x, \partial G) \rightarrow 0}(\bar{u}(x)-\underline{u}(x))<0, \tag{5.5}
\end{equation*}
$$

then $\underline{u}<\bar{u}$ in $G$.
(ii) Assume $\bar{G} \subset \Omega$ and $\bar{u}$ and $\underline{u}$ belong to $H^{1}(G) \cap C(\bar{G})$. If $\underline{u} \leq \bar{u}$ in $\partial G$, then $\underline{u} \leq \bar{u}$ in $G$.

### 5.1 Construction of the boundary trace

We use the notations of [23]
Proposition 5.3. Let $v$ be a non-negative function in $C(\Omega)$.
(i) If $v$ is a subsolution of (5.1), there exists a minimal solution $u_{*}$ dominating $v$, i.e. $v \leq u_{*} \leq U$ for any solution $U \geq v$.
(ii) If $v$ is a supersolution of (5.1), there exists a maximal solution $u^{*}$ dominated by $v$, i.e. $U \leq u^{*} \leq v$ for any solution $U \leq v$.

Proof. (i) Let $\left\{\Omega_{n}\right\}$ be a smooth exhaustion $\Omega$ and for each $n \in \mathbb{N}, u_{n}$ the positive solution of

$$
\begin{align*}
\mathcal{L}_{\kappa} u+|u|^{q-1} u & =0 & & \text { in } \Omega_{n} \\
u & =v & & \text { in } \partial \Omega_{n} . \tag{5.6}
\end{align*}
$$

By the comparison principle $u_{n} \geq v$, which implies $u_{n+1}(x) \geq u_{n}(x) \forall x \in \Omega_{n}$. Since $\left\{u_{n}\right\}$ is uniformly bounded on compact subsets of $\Omega$ and thus in $C^{2}$ by standard regularity arguments that $u_{n} \uparrow$ $u_{*}$ which is a positive solution of (5.1). Furthermore, if $U$ is any solution of (5.1) dominating $v$, it dominates $u_{n}$ in $\Omega_{n}$ and thus $u_{*} \leq U$.
The proof of (ii) is similar: we construct a decreasing sequence $\left\{u_{n}^{\prime}\right\}$ of nonnegative solutions of (5.1) in $\Omega_{n}$ coinciding with $v$ on $\partial \Omega_{n}$ and dominated by $v$. It converges to some $u^{*}$ which satisfies $U \leq u^{*} \leq v$ for any solution $U$ dominated by $v$.

Proposition 5.4. Let $0 \leq u, v \in C(\Omega)$.
(i) If $u$ and $v$ are subsolutions (resp. supersolutions) then $\max (u, v)$ is a subsolution (resp. $\min (u, v)$ is a supersolution).
(ii) If $u$ and $v$ are supersolutions then $u+v$ is a supersolution.
(iii) If $u$ is a subsolution and $v$ is a supersolution then $(u-v)_{+}$is a subsolution.

Proof. The first two statements follow Kato's inequality. The last statement is verified using that

$$
\begin{aligned}
-\Delta(u-v)_{+} \leq \operatorname{sign}_{+}(u-v)(-\Delta(u-v)) & \leq-\operatorname{sign}_{+}(u-v)\left(u^{q}-v^{q}\right)+\kappa \frac{(u-v)_{+}}{d^{2}(x)} \\
& \leq-(u-v)_{+}^{q}+\kappa \frac{(u-v)_{+}}{d^{2}(x)}
\end{aligned}
$$

Notation 5.5. Let $u$, $v$ be nonnegative continuous functions in $\Omega$.
(a) If $u$ is a subsolution, $[u]_{\dagger}$ denotes the smallest solution dominating $u$.
(b) If $u$ is a supersolution, $[u]^{\dagger}$ denotes the largest solution dominated by $u$.
(c) If $u, v$ are subsolutions then $u \vee v:=[\max (u, v)]_{\dagger}$.
(d) If $u, v$ are supersolutions then $u \wedge v:=[\inf (u, v)]^{\dagger}$ and $u \oplus v=[u+v]^{\dagger}$.
(e) If $u$ is a subsolution and $v$ is a supersolution then $u \ominus v:=\left[(u-v)_{+}\right]_{+}$.

The next result based upon local uniform estimates is due to Dynkin [10].
Proposition 5.6. (i) Let $\left\{u_{k}\right\} \subset C(\Omega)$ be a sequence of positive subsolutions (resp. supersolutions) of (5.1). Then $U:=\sup u_{k}$ (resp. $U:=\inf u_{k}$ ) is a subsolution (resp. supersolution).
(ii) Let $\mathcal{T} \subset C(\Omega)$ be a family of positive solutions of (5.1). Suppose that, for every pair $u_{1}, u_{2} \in \mathcal{T}$ there exists $v \in \mathcal{T}$ such that

$$
\max \left(u_{1}, u_{2}\right) \leq v \quad \text { resp. } \min \left(u_{1}, u_{2}\right) \geq v
$$

Then there exists a monotone sequence $\left\{u_{n}\right\} \subset \mathcal{T}$ such that

$$
u_{n} \uparrow \sup \mathcal{T} \quad \text { resp. } u_{n} \downarrow \inf T .
$$

Furthermore $\sup \mathcal{T}($ resp. $\inf \mathcal{T})$ is a solution.
Definition 5.7. Let $F \subset \partial \Omega$ be a closed set. We set

$$
\begin{equation*}
U_{F}:=\sup \left\{u \in \mathcal{U}_{+}(\Omega): \lim _{x \rightarrow \xi} \frac{u(x)}{W(x)}=0, \forall \xi \in \partial \Omega \backslash F\right\} \tag{5.7}
\end{equation*}
$$

and

$$
\begin{equation*}
[u]_{F}=\sup \left\{v \in \mathcal{U}_{+}(\Omega): v \leq u, \lim _{x \rightarrow \xi} \frac{v(x)}{W(x)}=0, \forall \xi \in \partial \Omega \backslash F\right\} \tag{5.8}
\end{equation*}
$$

Notice that $F \mapsto U_{F}$ and $F \mapsto[u]_{F}$ are increasing with respect to the inclusion order relation in $\partial \Omega$, $[u]_{F}=u \wedge U_{F}$. As a consequence of Proposition 6.3, $U_{F}$ satisfies

$$
\begin{equation*}
\lim _{x \rightarrow \xi} \frac{U_{F}(x)}{W(x)}=0, \forall \xi \in \partial \Omega \backslash K \tag{5.9}
\end{equation*}
$$

Proposition 5.8. Let $E, F \subset \partial \Omega$ be closed sets. Then
(i) $U_{E} \wedge U_{F}=U_{E \cap F}$.
(ii) If $F_{n} \subset \partial \Omega$ is a decreasing sequence of closed sets there holds

$$
\lim _{n \rightarrow \infty} U_{F_{n}}=U_{F} \text { where } F=\cap F_{n}
$$

Proof. (i) $U_{E} \wedge U_{F}$ is the largest solution dominated by $\inf \left(U_{E}, U_{F}\right)$ and therefore, by definition, it is the largest solution which vanishes outside $E \cap F$.
(ii) If $V:=\lim U_{F_{n}}$ then $U_{F} \leq V$. But $\operatorname{supp}(V) \subset F_{n}$ for each $n \in \mathbb{N}$ and consequently $V \leq U_{F}$.

For $\beta>0$, we recall that $\Omega_{\beta}, \Sigma_{\beta}$ and the mapping $x \mapsto(d(x), \sigma(x))$ have been defined in the proof of Lemma 3.9. We also set $\Omega_{\beta}^{\prime}=\Omega \backslash \bar{\Omega}_{\beta}$ and, if $Q \subset \partial \Omega, \Sigma_{\beta}(Q)=\left\{x \in \Omega_{\beta}: \sigma(x) \in Q\right\}$.
Proposition 5.9. Let $u \in \mathcal{U}(\Omega)$.
(i) If $A, B \subset \partial \Omega$ are closed sets. Then

$$
\begin{equation*}
\left[[u]_{A}\right]_{B}=\left[[u]_{B}\right]_{A}=[u]_{A \cap B} \tag{5.10}
\end{equation*}
$$

(ii) If $\left\{F_{n}\right\}$ is a decreasing sequence of closed subsets of $\partial \Omega$ and $F=\cap F_{n}$, then

$$
[u]_{F_{n}} \downarrow[u]_{F}
$$

(iii) If $A, B \subset \partial \Omega$ are closed sets. Then

$$
\begin{equation*}
[u]_{A} \leq[u]_{A \cap B}+[u]_{\overline{A \backslash B}} \tag{5.11}
\end{equation*}
$$

Proof. (i) It follows directly from definition that,

$$
\left[[u]_{A}\right]_{B} \leq \inf \left(u, U_{A}, U_{B}\right)
$$

The largest solution dominated by $u$ and vanishing on $A^{c} \cup B^{c}$ is $[u]_{A \cap B}$. Thus

$$
\left[[u]_{A}\right]_{B} \leq[u]_{A \cap B}
$$

On the other hand

$$
[u]_{A \cap B}=\left[[u]_{A \cap B}\right]_{B} \leq\left[[u]_{A}\right]_{B}
$$

this proves (5.10).
(ii) If $F_{n} \downarrow F$, it follows by Proposition 5.8-(ii) that $U_{F_{n}} \rightarrow U_{F}$, thus

[u]_{F} \leq \lim _{n \rightarrow \infty}[u]_{F_{n}}=\lim _{n \rightarrow \infty} u \wedge U_{F_{n}} \leq \lim _{n \rightarrow \infty} \inf \left(u, U_{F_{n}}\right) \leq \inf \left(u, U_{F}\right)
$$

Since $[u]_{F}$ is the largest solution dominated by $\inf \left(u, U_{F}\right),[u]_{F_{n}}$ is the largest solution dominated by $\inf \left(u, U_{F_{n}}\right)$ and $U_{F_{n}} \downarrow U_{F}$ by Proposition 5.8, the function $v=\lim _{n \rightarrow \infty}[u]_{F_{n}}$ is a solution of (5.1) dominated by $\inf \left(u, U_{F}\right)$, thus $v \leq[u]_{F}$ and the proof of (ii) is complete.
(iii) Without loss of generality we assume that $A \cap B \neq \emptyset$. Let $O, O^{\prime} \subset \partial \Omega$ be a relatively open set such that $A \cap B \subset O$ and $\overline{A \cap B^{c}} \subset O^{\prime}$ Set $v=[u]_{A}$ and let $v_{\beta}^{1}$ be the solution of

$$
\begin{aligned}
\mathcal{L}_{\kappa} w+|w|^{q-1} w & =0 & & \text { in } \Omega_{\beta}^{\prime} \\
w & =\chi_{\Sigma_{\beta}(\bar{O})} v & & \text { on } \Sigma_{\beta} .
\end{aligned}
$$

Also we denote by $v_{\beta}^{2}$ and $v_{\beta}^{3}$ the solutions of the above problem with respective boundary data $\chi_{\Sigma\left(\overline{O^{\prime}}\right)} v$ and $\chi_{\Sigma\left(O^{c} \cap O^{\prime c}\right)} v$. Then $v_{\beta}^{i} \leq v\left\lfloor_{\Omega_{\beta}^{\prime}} \leq v_{\beta}^{1}+v_{\beta}^{2}+v_{\beta}^{3}, i=1,2,3\right.$. Let now $\left\{\beta_{j}\right\}$ be a decreasing sequence converging to 0 and such that

$$
v_{\beta_{j}}^{i} \rightarrow v^{i} \leq v \leq v^{1}+v^{2}+v^{3}, i=1,2,3 \text { locally uniformly in } \Omega .
$$

By definition of $v^{i}$ and Proposition 6.1, we have that $v^{1} \leq[v]_{\bar{O}}, v^{2} \leq[v]_{\overline{O^{\prime}}}$ and $v^{3} \leq[v]_{O^{c} \cap O^{\prime c}}$. But by (i) we have

[v]_{O^{c} \cap O^{\prime c}}=\left[[u]_{A}\right]_{O^{c} \cap O^{\prime c}}=[u]_{A \cap O^{c} \cap O^{\prime c}}=0 .
$$

Thus

v \leq[v]_{\bar{O}}+[v]_{\overline{O^{\prime}}}
$$

We can consider decreasing sequences $\left\{O_{n}\right\}$ and $\left\{O_{n}^{\prime}\right\}$ such that $\cap \overline{O_{n}}=A \cap B$ and $\cap \overline{O_{n}^{\prime}}=\overline{A \cap B^{c}}$. By (ii) we obtain

v \leq\left[[u]_{A}\right]_{A \cap B}+\left[[u]_{A}\right]_{\overline{A \cap B^{c}}} \leq[u]_{A \cap B}+[u]_{\overline{A \cap B^{c}}}
$$

which is (iii).
Remark. Since any $u \in \mathcal{U}_{+}(\Omega)$ is dominated by $u_{\partial \Omega}$, it follows from (iii) that for any set $A \subset \partial \Omega$, there holds

u=[u]_{\partial \Omega} \leq[u]_{\bar{A}}+[u]_{\overline{\partial \Omega \backslash \bar{A}}} \leq[u]_{\bar{A}}+[u]_{\overline{\partial \Omega \backslash A}} . \tag{5.12}

Proposition 5.10. Let $u$ be a positive solution of (5.1). If $u \in L_{\phi_{k}}^{q}(\Omega)$ it possesses a boundary trace $\mu \in \mathfrak{M}(\partial \Omega)$, i.e., $u$ is the solution of the boundary value problem (3.36) with this measure $\mu$.

Proof. If $v:=\mathbb{G}_{\mathcal{L}_{\kappa}}\left[u^{q}\right]$ then $v \in L_{\phi_{\kappa}}^{1}(\Omega)$ and $u+v$ is a positive $\mathcal{L}_{\kappa}$-harmonic function. Hence $u+v \in$ $L_{\phi_{\kappa}}^{1}(\Omega)$ and there exists a non-negative measure $\mu \in \mathfrak{M}(\partial \Omega)$ such that $u+v=\mathbb{K}_{\mathcal{L}_{\kappa}}[\mu]$. By Proposition 3.5 this implies the result.

Proposition 5.11. Let $u$ be a positive solution of (5.1) and $\mu \in \mathfrak{M}(\partial \Omega)$. If for an exhaustion $\left\{\Omega_{n}\right\}$ of $\Omega$, we have

\lim _{n \rightarrow \infty} \int_{\partial \Omega_{n}} Z(x) u d \omega_{\Omega_{n}}^{x_{0}}=\int_{\partial \Omega} Z(x) d \mu, \quad \forall Z \in C(\bar{\Omega})
$$

where $\omega_{\Omega_{n}}^{x_{0}}$ is the $\mathcal{L}_{\kappa}$-harmonic measure of $\Omega_{n}$ relative to a point $x_{0} \in \Omega_{1}$, then $u$ and $|u|^{p}$ belong to $L_{\phi_{\kappa}}^{1}(\Omega)$. Furthermore u possesses the boundary trace $\mu \in \mathfrak{M}(\partial \Omega)$, i.e., $u$ is the solution of the boundary value problem (3.36) with this measure $\mu$.

Proof. Let $\mathbb{G}_{\mathcal{L}_{\kappa}}^{n}$ be the green function of $\mathcal{L}_{\kappa}$ in $\Omega_{n}$, then

$$
\mathbb{G}_{\mathcal{L}_{\kappa}}^{n}(x, y) \leq \mathbb{G}_{\mathcal{L}_{\kappa}}^{n+1}(x, y), \quad \forall x, y \in \Omega_{n}
$$

and

$$
\mathbb{G}_{\mathcal{L}_{\kappa}}^{n} \uparrow \mathbb{G}_{\mathcal{L}_{\kappa}}
$$

Since

$$
\int_{\partial \Omega_{n}} u d \omega_{\Omega_{n}}^{x_{0}}=u\left(x_{0}\right)+\int_{\Omega_{n}} \mathbb{G}_{\mathcal{L}_{\kappa}}^{n}\left(x, x_{0}\right)|u(x)|^{q} d x
$$

we derive, as $n \rightarrow \infty$,

$$
\mu(\partial \Omega)=u\left(x_{0}\right)+\int_{\Omega_{n}} \mathbb{G}_{\mathcal{L}_{\kappa}}\left(x, x_{0}\right)|u(x)|^{q} d x
$$

By Proposition 2.1 this implies $|u|^{q} \in L_{\phi_{k}}^{1}(\Omega)$, and the result follows by Proposition 5.10.
Proposition 5.12. If $F \subset \partial \Omega$ is a closed set and $u$ a positive solution of (5.1) with boundary trace $\mu \in \mathfrak{M}(\partial \Omega)$, then $[u]_{F}$ has boundary trace $\mu \chi_{F}$.

Proof. The function $[u]_{F}$ belongs to $\mathcal{U}_{+}(\Omega)$ and is dominated by $u$ which satisfies (5.1), thus $[u]_{F} \in$ $L_{\Phi_{\kappa}}^{q}(\Omega)$ and $[u]_{F}$ admits a boundary trace $\mu_{F} \leq \mu$ by Proposition 5.10. Let $v$ be the solution of (3.36) with boundary data $\mu \chi_{F}$. Let $O \subset \partial \Omega$ relatively open such that $F \subset O$. By 5.12 we have

$$
v \leq[v]_{\bar{O}}+[v]_{\overline{O^{c}}}
$$

Let $A$ be an open set such that $F \subset A \subset \bar{A} \subset O$, and for exhaustion we take $\Omega_{n}=\Omega_{\frac{1}{n}}^{\prime}$ which is smooth for $n$ large enough, and $\partial \Omega_{n}=\Sigma_{\frac{1}{n}}$. Then

$$
\int_{\partial \Omega_{n}}[v]_{\overline{O^{c}}} d \omega_{\Omega_{n}}^{x_{0}}=\int_{\Sigma_{\frac{1}{n}}(A)}[v]_{\overline{O^{c}}} d \omega_{\Omega_{n}}^{x_{0}}+\int_{\partial \Omega_{n} \backslash \Sigma_{\frac{1}{n}}(A)}[v]_{\overline{O^{c}}} d \omega_{\Omega_{n}}^{x_{0}}
$$

But

$$
\int_{\Sigma_{\frac{1}{n}}(A)}[v]_{O^{c}} d \omega_{\Omega_{n}}^{x_{0}} \leq \int_{\Sigma_{\frac{1}{n}}(A)} v d \omega_{\Omega_{n}}^{x_{0}} \rightarrow 0
$$

and

$$
\int_{\partial \Omega_{n} \backslash \Sigma_{\frac{1}{n}}(A)}[v]_{\overline{O^{c}}} d \omega_{\Omega_{n}}^{x_{0}} \leq \int_{\partial \Omega_{n} \backslash \Sigma_{\frac{1}{n}}(A)} U_{\overline{O^{c}}} d \omega_{\Omega_{n}}^{x_{0}} \rightarrow 0
$$

as $n \rightarrow \infty$, thus $[v]_{\overline{O^{c}}}=0$ by Proposition 5.11 and therefore $v \leq[v]_{\bar{O}} \leq[u]_{\bar{O}}$. Since $O$ be an arbitrary open set, take a sequence of open set $\left\{O_{n}\right\}$ such that $F \subset O_{n} \subset \bar{O}_{n} \subset O_{n-1}$ and $\cap O_{n}=F$. Using Proposition 5.9 we derive

and thus $\mu \chi_{F} \leq \mu_{F}$. Conversely, let $Z \in C(\bar{\Omega}), Z \geq 0$,

\int_{\partial \Omega_{n}} Z[u]_{F} d \omega_{\Omega_{n}}^{x_{0}} & =\int_{\partial \Omega_{n} \cap \Sigma_{\frac{1}{n}}(A)} Z[u]_{F} d \omega_{\Omega_{n}}^{x_{0}}+\int_{\partial \Omega_{n} \backslash \Sigma_{\frac{1}{n}}(A)} Z[u]_{F} d \omega_{\Omega_{n}}^{x_{0}} \\
& \leq \int_{\partial \Omega_{n} \cap \Sigma_{\frac{1}{n}}(A)} Z u d \omega_{\Omega_{n}}^{x_{0}}+\int_{\partial \Omega_{n} \backslash \Sigma_{\frac{1}{n}}(A)} Z U_{F} d \omega_{\Omega_{n}}^{x_{0}} \\
& \leq I_{n}+I I_{n}
\end{aligned}
$$

Because of (5.9), $I I_{n} \rightarrow 0$ as $n \rightarrow \infty$, thus

$$
\int_{\partial \Omega} Z d \mu_{F} \leq \int_{\partial \Omega} Z \chi_{F} d \mu \Longrightarrow \mu_{F} \leq \mu \chi_{O}
$$

and the result follow by regularity since $O$ is arbitrary.
The next result shows that the boundary trace has a local character.
Proposition 5.13. Let $u \in \mathcal{U}_{+}(\Omega)$ and $\xi \in \partial \Omega$. We assume that there exists $\rho>0$ such that

\int_{B_{\rho}(\xi) \cap \Omega}(u(x))^{q} \phi_{\kappa}(x) d x<\infty
$$

(i) Then

[u]_{F}^{q} \in L_{\phi_{\kappa}}^{1}(\Omega) \quad \forall F \subset \partial \Omega \cap B_{\rho}(\xi), F \text { closed } .
$$

Thus $[u]_{F}$ possesses a boundary trace $\mu_{F} \in \mathfrak{M}(\partial \Omega)$, and $\operatorname{supp}\left(\mu_{F}\right) \subset F$.
(ii) There exists a nonnegative Radon measure $\mu_{\rho}$ on $B_{\rho}(\xi)$ such that for any closed set $F \subset B_{\rho}(\xi) \cap \partial \Omega$

\mu_{F}=\mu_{\rho} \chi_{F}
$$

and for any exhaustion $\left\{\Omega_{n}\right\}$ of $\Omega$ and any $Z \in C(\bar{\Omega})$ such that $\operatorname{supp}(Z) \cap \partial \Omega \subset \partial \Omega \cap B_{\rho}(\xi)$

\begin{equation*}
\lim _{n \rightarrow \infty} \int_{\partial \Omega_{n}} u(x) Z(x) d \omega_{\Omega_{n}}^{x_{0}}=\int_{\partial \Omega} u(x) Z(x) d \mu_{\rho} \tag{5.13}
\end{equation*}
$$

Proof. (i) Let $F$ be a closed set and $0<\rho^{\prime}<\rho$ be such that

F \subset \partial \Omega \cap B_{\rho^{\prime}}(\xi)
$$

Since $[u]_{F} \leq \inf \left(u, U_{F}\right)$ and $U_{F} \in C(\bar{\Omega} \backslash F)$, we have

\int_{\Omega}[u]_{F}^{q} \phi_{\kappa}(x) d x \leq \int_{B_{\rho}(\xi) \cap \Omega}|u|^{p} \phi_{\kappa}(x) d x+\int_{\Omega \backslash B_{\rho}(\xi)}\left|U_{F}\right|^{p} \phi_{\kappa}(x) d x<\infty
$$

(ii) Let $0<\rho_{1}<\rho_{2}<\rho$, then

$$
[u]_{\bar{B}_{\rho_{2}}(\xi) \cap \partial \Omega} \leq u \leq[u]_{\bar{B}_{\rho_{2}}(\xi) \cap \partial \Omega}+U \frac{\overline{\partial \Omega \backslash \bar{B}_{\rho_{2}}(\xi)}}{} .
$$

The function $[u]_{\bar{B}_{\rho_{2}}(\xi) \cap \partial \Omega}$ which belongs $L_{\phi_{\kappa}}^{q}(\Omega)$ admits a boundary trace $\nu \in \mathfrak{M}(\partial \Omega)$ and

$$
\lim _{n \rightarrow \infty} \int_{\partial \Omega_{n}} U \frac{}{\partial \Omega \backslash \bar{B}_{\rho_{2}}(\xi)} Z(x) d \omega_{\Omega_{n}}^{x_{0}}=0
$$

for any $Z \in C(\bar{\Omega})$ such that $\operatorname{supp}(Z) \cap \partial \Omega \subset \partial \Omega \cap B_{\rho_{1}}(\xi)$. Combined with Proposition 5.12 it follows identity (5.13) and finally statement (ii).

Definition 5.14. The set $\mathcal{R}_{u}$ of boundary points a such that there exists $r>0$ such that (5.13) holds is relatively open. Using a partition of unity there exists a positive Radon measure $\mu_{u}$ on $\mathcal{R}_{u}$ such that

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \int_{\partial \Omega_{n}} u(x) Z(x) d \omega_{\Omega_{n}}^{x_{0}}=\int_{\partial \Omega} u(x) Z d \mu_{u} \tag{5.14}
\end{equation*}
$$

for any $Z \in C(\bar{\Omega})$ such that $\operatorname{supp}(Z) \cap \partial \Omega \subset \mathcal{R}_{u}$. The set $\mathcal{S}_{u}:=\partial \Omega \backslash \mathcal{R}_{u}$ is closed. The couple $\left(\mathcal{S}_{u}, \mu_{u}\right)$ is the boundary trace of $u$, denoted by $\operatorname{Tr}_{\partial \Omega}(u)$. The measure $\mu_{u}$ is the regular part of $\operatorname{Tr}_{\partial \Omega}(u)$, the set $\left(\mathcal{S}_{u}\right)$ is its singular part.

Proposition 5.15. Let $u$ be a positive solution in $\Omega$ and let $\left\{\Omega_{n}\right\}$ be an exhaustion of $\Omega$. If $y \in \mathcal{S}_{u}$ then for every nonnegative $Z \in C(\bar{\Omega})$ such that $Z(y) \neq 0$ we have

$$
\lim _{n \rightarrow \infty} \int_{\partial \Omega_{n}} Z u d \omega_{\Omega_{n}}^{x_{0}}=\infty
$$

Proof. Let $Z \in C(\bar{\Omega}), Z \geq 0$, such that $Z(y) \neq 0$ and

$$
\liminf _{n \rightarrow \infty} \int_{\partial \Omega_{n}} Z u d \omega_{\Omega_{n}}^{x_{0}}<\infty
$$

There exists a subsequence $n_{j}$ such that

$$
\lim _{j \rightarrow \infty} \int_{\partial \Omega_{n_{j}}} Z u d \omega_{\Omega_{n_{j}}}^{x_{0}}=M<\infty
$$

Let $r$ be such that $Z(x)>\frac{Z(y)}{2}, \forall x \in B_{r}(y) \cap \bar{\Omega}$, then for any $r^{\prime}<r$ we have that

$$
\limsup _{j \rightarrow \infty} \int_{\partial \Omega_{n_{j}}}[u]_{B_{{B^{\prime}}^{\prime}}(y) \cap \partial \Omega} d \omega_{\Omega_{n}}^{x_{0}}<\infty
$$

In view of the proposition of 5.11 the last fact implies that $\left|[u]_{\overline{B_{r^{\prime}}(y)}}\right|^{q} \in L_{\phi_{\kappa}}(\Omega)$, which implies that

$$
|u|^{q} \in L_{\phi_{\kappa}}\left(B_{r^{\prime \prime}}(y)\right) \quad \forall r^{\prime \prime}<r^{\prime} .
$$

Which is clearly a contradiction, by Proposition 5.13.
Proposition 5.16. Let $u$ be a positive solution of (5.1) in $\Omega$ with boundary trace $\left(\mathcal{S}_{u}, \mu_{u}\right)$. Then

\int_{\Omega}\left(u \mathcal{L}_{\kappa} \zeta+u^{q} \zeta\right) d x=\int_{\Omega} \mathbb{K}_{\mathcal{L}_{\kappa}}\left[\mu_{u} \chi_{F}\right] \mathcal{L}_{\kappa} \zeta d x
$$

for any $\zeta \in \mathbf{X}(\Omega)$ such that $\operatorname{supp}(\zeta) \cap \partial \Omega \subset F$.
Proof. Consider the function $\zeta \in \mathbf{X}(\Omega)$ such that $\operatorname{supp}(\zeta) \cap \partial \Omega \subset F$. Set $K=\operatorname{supp}(\zeta)$,

O_{\varepsilon}=\left\{x \in \mathbb{R}^{N}: \operatorname{dist}(x, K)<\varepsilon\right\}
$$

and $\varepsilon_{0}>0$ small enough such that

$$
\overline{O_{\varepsilon}} \cap \partial \Omega \subset \mathcal{R}_{u}, \quad \forall 0<\varepsilon<\varepsilon_{0}
$$

Let $\varepsilon<\frac{\varepsilon_{0}}{4}$ and $\eta$ be a cut off function such that $\eta \in C_{0}^{\infty}\left(O_{\varepsilon}\right), 0 \leq \eta \leq 1$ and $\eta \equiv 1$ on $\bar{O}_{\frac{\varepsilon}{2}}$. For $0<\beta \leq \beta_{0}$, let $v_{\beta}$ be the solution of

\begin{aligned}
\mathcal{L}_{\kappa} w+|w|^{q-1} w & =0 & & \text { in } \Omega_{\beta}^{\prime} \\
w & =\eta u & & \text { on } \Sigma_{\beta} .
\end{aligned}

Then there exists a sequence $\left\{\beta_{j}\right\}$ decreasing to 0 such that $v_{\beta_{j}} \rightarrow v$ locally uniformly, and

v \leq[u]_{\partial \Omega \cap \overline{O_{\varepsilon}}}
$$

Thus $v$ has boundary trace $\mu_{0}$ such that

$$
\mu_{0} \leq \mu_{u} \chi_{\partial \Omega \cap \overline{O_{\varepsilon}}}
$$

Let $v_{\beta}^{1}$ and $v_{\beta}^{2}$ be the solutions of

$$
\begin{aligned}
\mathcal{L}_{\kappa} w+|w|^{q-1} w & =0 & & \text { in } \Omega_{\beta}^{\prime} \\
w & =\eta[u]_{\partial \Omega \cap \bar{O}_{2 \varepsilon}} & & \text { on } \Sigma_{\beta}
\end{aligned}
$$

and

$$
\begin{aligned}
\mathcal{L}_{\kappa} w+|w|^{q-1} w & =0 & & \text { in } \Omega_{\beta}^{\prime} \\
w & =\eta U_{\partial \Omega \backslash O_{2 \varepsilon}} & & \text { on } \Sigma_{\beta},
\end{aligned}
$$

respectively. Notice that $u \leq[u]_{\partial \Omega \cap \bar{O}_{2 \varepsilon}}+U_{\partial \Omega \backslash O_{2 \varepsilon}}$ we have that

v_{\beta} \leq v_{\beta}^{1}+v_{\beta}^{2} \leq[u]_{\partial \Omega \cap \bar{O}_{2 \varepsilon}}+v_{\beta}^{2} .
$$

Since $[u]_{\partial \Omega \cap \bar{O}_{2 \varepsilon}}^{q} \in L_{\phi_{\kappa}}^{1}(\Omega)$. By (6.20) we have that

\eta(x) U_{\partial \Omega \backslash O_{2 \varepsilon}}(x) \leq c_{90} d^{\frac{\alpha_{+}}{2}}(x) \quad \forall x \in \Omega
$$

where $c_{90}>0$ depends on $N, q, \kappa$ and dist $\left(\operatorname{supp}(\eta), \partial \Omega \backslash O_{\epsilon}\right)$. Thus $v_{\beta}^{2}(x) \leq c_{90} d^{\frac{\alpha_{+}}{2}}(x)$ and

v_{\beta} \leq[u]_{\partial \Omega \cap \bar{O}_{2 \varepsilon}}+c_{90} d^{\frac{\alpha_{+}}{2}}(x), \quad \forall x \in \Omega_{\beta}^{\prime} . \tag{5.15}
\end{equation*}
$$

Let $w_{\beta}$ be the solution of

\mathcal{L}_{\kappa} w+|w|^{q-1} w & =0 & & \text { in } \Omega_{\beta}^{\prime} \\
w & =\chi_{\Sigma_{\beta}\left(\overline{\partial \Omega \backslash O_{\frac{\varepsilon}{2}}}\right)}[u]_{F} & & \text { on } \Sigma_{\beta} .
\end{aligned}
$$

Then

$$
[u]_{F} \leq v_{\beta}+w_{\beta} \quad \text { in } \Omega_{\beta}^{\prime} .
$$

We have that $w_{\beta_{j}} \rightarrow 0$ locally uniformly in $\Omega$ which implies that

[u]_{F} \leq v
$$

Thus we have

\begin{equation*}
\mu_{u} \chi_{F} \leq \mu_{0} \leq \mu_{u} \chi_{\partial \Omega \cap \overline{O_{\varepsilon}}} \tag{5.16}
\end{equation*}
$$

Set $Z=\eta \zeta_{\beta}$ where $\zeta_{\beta}$ is the solution of

$$
\begin{aligned}
\mathcal{L}_{\kappa} w & =\mathcal{L}_{\kappa} \zeta & & \text { in } \Omega_{\beta}^{\prime} \\
w & =0 & & \text { on } \Sigma_{\beta} .
\end{aligned}
$$

Since $\zeta \in \mathbf{X}(\Omega)$, there exists a constant $c_{91}$ such that $\zeta_{\beta} \leq c_{91} \phi_{\kappa}$ in $\Omega_{\beta}^{\prime}$. Thus there exists a decreasing sequence $\left\{\beta_{j}\right\}$ converging to 0 such that $\zeta_{\beta_{j}} \rightarrow \zeta$ locally uniformly. Now,

\int_{\Omega_{\beta}^{\prime}} u \mathcal{L}_{\kappa} Z d x+\int_{\Omega_{\beta}^{\prime}} u^{q} Z d x & =-\int_{\partial \Omega_{\beta}^{\prime}} \frac{\partial Z}{\partial \mathbf{n}} u d S \\
& =-\int_{\partial \Omega_{\beta}^{\prime}} \frac{\partial \zeta_{\beta}}{\partial \mathbf{n}} \eta u d S . \\
& =\int_{\Omega_{\beta}^{\prime}} v_{\beta} \mathcal{L}_{\kappa} \zeta_{\beta} d x+\int_{\Omega_{\beta}^{\prime}} v_{\beta}^{q} \zeta_{\beta} d x \\
& =\int_{\Omega_{\beta}^{\prime}} v_{\beta} \mathcal{L}_{\kappa} \zeta d x+\int_{\Omega_{\beta}^{\prime}} v_{\beta}^{q} \zeta_{\beta} d x \tag{5.17}
\end{align*}

We note here that in view of the proof of (6.22), we have

where the constant $c_{92}>0$ does not depend on $\beta$. Also by remark ?? and our assumptions we have

The last two inequalities above implies that

\int_{\Omega \cap O_{2 \varepsilon}} u d^{\frac{\alpha_{+}}{2}-1} d x \leq \int_{\Omega \cap O_{2 \varepsilon}} U_{\partial \Omega \backslash O_{3 \varepsilon}} d^{\frac{\alpha_{+}}{2}-1} d x+\int_{\Omega \cap O_{2 \varepsilon}}[u]_{\partial \Omega \cap \bar{O}_{3 \varepsilon}} d^{\frac{\alpha_{+}}{2}-1} d x<\infty .
$$

Combining all above we can choose a decreasing subsequence $\left\{\beta_{j}\right\}$ to the origin such that if we take the limit in (5.17) to obtain

$\operatorname{Be}(5.16)$ we have the desired result if we send $\varepsilon$ to zero.

### 5.2 Subcritical case

We recall that

is the critical exponent for the equation. If $1<q<q_{c}$, we have seen in section 4 that for any $a \in \partial \Omega$ and $k \geq 0$ there exists $u_{k \delta_{a}}$ and $\lim _{k \rightarrow \infty} u_{k \delta_{a}}=u_{\infty, a}$. Furthermore, by Proposition 5.15, $\operatorname{Tr}_{\partial \Omega}\left(u_{\infty, a}\right)=$ ( $\{a\}, 0$ ).

Theorem 5.17. Assume $1<q<q_{c}$ and $a \in \mathcal{S}_{u}$. Then

u(x) \geq u_{\infty, a}(x), \quad \forall x \in \Omega \tag{5.18}
\end{equation*}
$$

For proof of the above uses some ideas of the proof of Theorem 7.1 in [22] and needs several intermediate lemmas.

Lemma 5.18. Assume $1<q<q_{c}$. Let $\left\{\xi^{n}\right\}$ be a sequence of points in $\Omega$ converging to $a \in \partial \Omega$ and let $l \in(0,1)$. We define the sets

Let $h_{n} \in L^{\infty}\left(\Sigma_{n}\right) n=1,2, \ldots$, and suppose that there exist numbers $c$ and $k$ such that

\operatorname{supp}\left(h_{n}\right) \subset V_{n} \quad \text { and } \quad 0 \leq h_{n} \leq c r_{n}^{-N-\frac{\alpha_{+}}{2}+2} \tag{5.20}
\end{equation*}
$$

and

\lim _{n \rightarrow \infty} \int_{\Sigma_{n}} h_{n} \phi d \omega_{\Omega_{n}}^{x_{0}}=k \phi(a), \quad \forall \phi \in C(\bar{\Omega})
$$

Let $w_{n}$ be the solution of the problem

\begin{aligned}
& \mathcal{L}_{\kappa} w_{n}+\left|w_{n}\right|^{q-1} w_{n}=0 \text { in } \Omega_{n} \\
& w_{n}=h_{n} \\
& \text { on } \partial \Sigma_{n} .
\end{aligned}
$$

Then

$$
w_{n} \rightarrow u_{k, a} \quad \text { locally uniformly in } \Omega .
$$

Proof. Let $\eta^{n} \in \partial \Omega$ be such that $d\left(\xi^{n}\right)=\left|\xi^{n}-\eta^{n}\right|$. By Corollary 2.30 we have

\end{equation*}

by the maximum principle,

\end{equation*}

Moreover

\int_{\Omega} \mathbb{K}_{\mathcal{L}_{\kappa}}^{q}(x, y) d^{\frac{\alpha+}{2}}(x) d x \leq c(q, \Omega), \quad \forall 1<q<q_{c}
$$

where $c(q, \Omega)$ is a constant independent of $y$. Since $q$ is subcritical, it follows that the sequences $\left\{\mathbb{K}_{\mathcal{L}_{\kappa}}^{q}\left(\cdot, \eta^{n}\right)\right\}$ and $\left\{\mathbb{K}_{\mathcal{L}_{\kappa}}\left(\cdot, \eta^{n}\right\}\right.$ are uniformly integrable in $L_{\phi_{\kappa}}^{1}(\Omega)$. Let $\bar{w}_{n}$ denotes the extension of $w_{n}$ to $\Omega$ defined by $\bar{w}_{n}=0$ in $\Omega \backslash \Omega_{n}$. In view of (5.21) we conclude that the sequences $\left\{\bar{w}_{n}^{q}\right\}$ and $\left\{\bar{w}_{n}\right\}$ are uniformly integrable in $L_{\phi_{\kappa}}^{1}(\Omega)$, and locally uniformly bounded in $\Omega$ By regularity results for elliptic equations there exists a subsequence of $\left\{\bar{w}_{n}\right\}$, say again $\left\{\bar{w}_{n}\right\}$ that converges locally uniformly in $\Omega$ to a solution $w$ of (5.1). This fact and the uniform integrability mentioned above imply that

w_{n} \rightarrow w \quad \text { in } L_{\phi_{\kappa}}^{q}(\Omega) \cap L_{\phi_{\kappa}}^{1}(\Omega) .

Since $w \in L_{\phi_{\kappa}}^{q}(\Omega)$ by Proposition 5.10 there exists $\mu \in \mathfrak{M}(\Omega)$ such that

Let $\phi_{\kappa, n}$ be the first eigenfunction of $\mathcal{L}_{\kappa}$ in $\Omega_{n}$ normalized by $\phi_{\kappa, n}\left(x_{0}\right)=1$ for some $x_{0} \in \Omega_{1}$. Let $\eta \in \mathbf{X}(\Omega)$ be nonnegative function and let $\eta_{n}$ be the solution of the problem

Then $\eta_{n} \in C^{2}\left(\bar{\Omega}_{n}\right)$ and since $\phi_{\kappa, n} \rightarrow \phi_{\kappa}$,

By the same arguments as above there exists a subsequence of $\left\{v_{n} \chi_{\Omega_{n}}\right\}$, for simplicity $\left\{v_{n} \chi_{\Omega_{n}}\right\}$, converging in $L_{\phi_{\kappa}}^{1}(\Omega)$ to a a nonnegative $\mathcal{L}_{\kappa}$-harmonic function $v$. By (5.21) we have

$$

the results follows if we sent $n$ to $\infty$ in (5.23).
Lemma 5.19. For every $l \in(0,1)$ there exists a constant $c_{l}=c(N, \kappa, q, l)$ such that, for every positive solution $u$ of (5.1) in $\Omega$ and every $x_{0} \in \Omega$,

u(x) \leq c_{l} u(y), \quad \forall x, y \in B_{l r_{0}}\left(x_{0}\right), \quad r_{0}=d\left(x_{0}\right) \tag{5.25}
\end{equation*}

Set $v(y)=u\left(r_{0} y\right)$, and $y_{0}=\frac{x_{0}}{r}$, then $v(y)$ satisfies

-\Delta v-\kappa \frac{v}{\operatorname{dist}^{2}\left(y, \partial \Omega_{y_{0}}\right)}+r_{0}^{2}|v|^{q-1} v=0, \quad \text { in } B_{\frac{1+l}{2}}\left(y_{0}\right)
$$

Now note that

\frac{1}{\operatorname{dist}^{2}\left(y, \partial \Omega_{y_{0}}\right)} \leq \frac{4}{(1-l)^{2}}, \quad \forall y \in B_{\frac{1+l}{2}}\left(y_{0}\right)

r_{0}^{2}|v(y)|^{q-1}=r_{0}^{2}\left|u\left(r_{0} y\right)\right|^{q-1} \leq C(\Omega, \kappa, N) r_{0}^{2} \frac{1}{d^{2}\left(r_{0} y\right)} \leq C(\Omega, \kappa, N) B_{\frac{1+l}{2}}\left(y_{0}\right)
$$

Thus by Harnack inequality there exists a constant $c_{l}>0$ such that

v(z) \leq c_{l} v(y), \quad \forall z, y \in B_{l}\left(y_{0}\right)
$$

and the results follows.
For the proof of the next lemma we need some notations. Let $\beta>0$ and $\xi \in \Sigma_{\beta}=\partial \Omega_{\beta}^{\prime}$. We set $\Delta_{r}^{\beta}(\xi)=\Sigma_{\beta} \cap B_{r}(\xi)$ and, for $0<r<\beta<2 r, x_{r}^{\beta}=x_{r}^{\beta}(\xi) \in \bar{\Omega}_{\beta}$, such that $d\left(x_{r}^{\beta}\right)=\left|x_{r}^{\beta}-\xi\right|=r$. Also we denote by $\omega_{\Omega_{\beta}^{\prime}}^{x}$ the $\mathcal{L}_{\kappa}$-harmonic measure in $\Omega_{\beta}^{\prime}:=\Omega \backslash \bar{\Omega}_{\beta}$ relative to $x$
Lemma 5.20. Let $r_{0}=r_{0}(\Omega)>0$ be small enough and $0<r \leq \frac{r_{0}}{4}$. Then there exists a constant $c_{95}$ which depends only on $\Omega, N$ such that

$$
\begin{equation*}
\omega_{\Omega_{\beta}^{\prime}}^{x}\left(\Delta_{r}(\xi)\right)>c_{95} \quad \forall x \in \Omega \cap B_{\frac{r}{2}}(\xi) \tag{5.26}
\end{equation*}

Proof. Since $x \mapsto \omega_{\Omega_{\beta}^{\prime}}^{x}$ is a positive $\mathcal{L}_{\kappa}$-harmonic in $\Omega_{\beta}^{\prime}$, it is a positive superharmonic function (relative to the Laplacian) in $\Omega_{\beta}^{\prime}$. Thus

Set $x\left(\xi^{n}\right)=x_{\frac{r_{n}}{2}}^{2 r_{n}}\left(\xi^{n}\right)$, with $r_{n}=\frac{d\left(\xi^{n}\right)}{2}$. By (2.9) we have

r_{n}^{N-2} G_{\mathcal{L}_{\frac{1}{4}}}^{n}\left(x, x\left(\xi^{n}\right)\right)<c_{97}, \quad \forall x \in \Omega_{n} \cap \partial B_{r_{n}}\left(\xi^{n}\right)

and by Lemma 5.20 there exists $r_{0}=r_{0}(\Omega)>0$ such that for any $r_{n} \leq \frac{r_{0}}{4}$

r_{n}^{N-2} G_{\mathcal{L}_{\frac{1}{4}}}^{\Omega_{n}}\left(x, x\left(\xi^{n}\right)\right) \leq c_{98} \omega_{\Omega_{n}}^{x}\left(\partial \Omega_{n} \cap B_{r_{n}}\left(\xi^{n}\right)\right), \quad \forall x \in \Omega_{n} \cap \partial B_{r_{n}}\left(\xi^{n}\right)
$$

Since if $|x-y|>\varepsilon>0$ there holds

G_{L_{\frac{1}{4}}}^{\Omega_{n}}(x, y) \approx c_{99}\left(\varepsilon, \Omega_{n}\right) \operatorname{dist}\left(x, \partial \Omega_{n}\right) \operatorname{dist}\left(y, \partial \Omega_{n}\right)

Thus we have by maximum principle and properties of Green function

r_{n}^{N-2} G_{\mathcal{L}_{\frac{1}{4}}}^{\Omega_{n}}\left(x, x\left(\xi^{n}\right)\right) \leq c_{100} \omega_{\Omega_{n}}^{x}\left(\partial \Omega_{n} \cap B_{r_{n}}\left(\xi^{n}\right)\right), \quad \forall x \in \Omega_{n} \backslash B_{r_{n}}\left(\xi^{n}\right) \tag{5.29}
\end{equation*}

By [3, Lemma 2.8] there exists $\beta_{0}=\beta_{0}(\Omega, \varepsilon)>0$ such that the function

h_{1}(x)=d^{\frac{1}{2}}(x)(-\log d(x))\left(1+(-\log d(x))^{-\varepsilon}\right)

is a supersolution in $\Omega_{\beta_{0}}$ and the function

\left.h_{2}(x)=d^{\frac{1}{2}}(x)(-\log d(x))\left(1-(-\log d(x))^{-\varepsilon}\right)\right),
$$

is a subsolution in $\Omega_{\beta_{0}}$. Set

c_{101}=\frac{1-\left(-\log d\left(\xi_{n}\right)\right)^{-\varepsilon}}{1+\left(-\log d\left(\xi_{n}\right)\right)^{-\varepsilon}}
$$

and

$$
H(x)=h_{2}(x)-c_{101} h_{1}(x) .
$$

Let $n_{0} \in \mathbb{N}$ such that $r_{n} \leq \frac{\beta_{0}}{4}, \forall n \geq n_{0}$. then the function $H(x)$ is a nonnegative subsolution in $\Omega_{n} \backslash \Omega_{\beta_{0}}^{\prime}$, and $H(x)=0, \forall x \in \partial \Omega_{n}$. By (5.28) we can choose $n_{1} \in \mathbb{N}$ such that

Let $\beta_{0}>0$ be small enough such that $d_{U} \in C^{2}\left(\bar{U}_{\beta_{0}}\right)$. Let $0<\beta<\beta_{0}$ and $\zeta(x)=d_{U}(x)-\beta$. Then $u$ satisfies

where $c_{106}$ depends on $q, \kappa, \Omega, \beta_{0}$,

Let $w_{n, k}$ be defined as in Lemma 5.18 with $h_{n}$ replaced by $h_{n, k}$. By (5.35) and (5.36), the sequence $\left\{h_{n, k}\right\}_{n=1}^{\infty}$ satisfies (5.20) for every fixed $k>0$. Therefore by Lemma 5.18

By convexity $\tilde{u}$ is a supersolution of (5.1) which is smaller than $u_{\infty, 0}$. Now $\frac{c+1}{2 c} u_{\infty, 0}$ is a subsolution, thus there exists a solution $\underline{u}$ of (5.1) in $\Omega$ which satisfies

Theorem 5.25. . Assume $\mathcal{S} \subset \partial \Omega$ is closed and $\nu$ is a positive Radon measure on $\mathcal{R}=\partial \Omega \backslash \mathcal{S}$. Then there exists a positive solution of (4.1) in $\Omega$ with boundary trace $(\mathcal{S}, \mu)$.

## 6 Appendix I: barriers and a priori estimates

### 6.1 Barriers

Following a localization principle introduced in [22] we the following lemma is at the core of the a priori estimates construction

Proposition 6.1. Let $\Omega \subset \mathbb{R}^{N}$ be a $C^{2}$ domain $0<\kappa \leq \frac{1}{4}$ and $p>1$.Then there exists $R_{0}>0$ such that for any $z \in \partial \Omega$ and $0<R \leq R_{0}$, there exists a super solution $f:=f_{R, z}$ of (4.1) in $\Omega \cap B_{R}(z)$ such that $f \in C\left(\bar{\Omega} \cap B_{R}(z)\right), f(x) \rightarrow \infty$ when $\operatorname{dist}(x, K) \rightarrow 0$, for any compact subset $K \subset \Omega \cap \partial B_{R}(z)$ and which vanishes on $\partial \Omega \cap B_{R}(z)$, and more precisely

c_{\beta, \gamma, \kappa, q}\left(R^{2}-|x-z|^{2}\right)^{-\beta} d^{\gamma}(x) & \forall \gamma \in\left(\frac{\alpha_{-}}{2}, \frac{\alpha_{+}}{2}\right)
\end{array} \begin{array}{ll}
\text { if } 0<\kappa<\frac{1}{4}  \tag{6.1}\\
c_{\beta, \gamma, q}\left(R^{2}-|x-z|^{2}\right)^{-\beta} \sqrt{d(x)} \sqrt{\ln \left(\frac{\operatorname{diam}(\Omega)}{d(x)}\right)} & \text { if } \kappa=\frac{1}{4}
\end{array}\right.
$$

for $\beta \geq \max \left\{\frac{2}{q-1}+\gamma, \frac{N-2}{2}, 1\right\}$.
Proof. We assume $z=0$

\end{gathered}

& \left.-2 \beta d^{2}\left(N R^{2}+(2 \beta+2-N) r^{2}\right)+4 \beta \gamma d\left(R^{2}-r^{2}\right) x \nabla d\right]
\end{align*}

If we fix $\beta \geq \max \left\{\frac{2}{q-1}+\gamma, \frac{N-2}{2}, 1\right\}$, there holds

For $q>1$, there exists $\gamma>0$ and $\epsilon_{0}>0$ such that for any $0 \leq \epsilon \leq \epsilon_{0}$ the function $h_{+} \epsilon=\gamma\left(\phi_{*}-\epsilon\right)^{-\frac{2}{q-1}}$ is a supersolution of 4.1 in $\Omega_{\epsilon, \phi_{*}}:=\left\{x \in \Omega: \phi_{*}(x)>\epsilon\right\}$.

We note here that the constant $0<R_{0}<1$ depends on $C^{2}$ characteristic of $\Omega$.

|u(x)| \leq C d^{-\frac{2}{q-1}}(x) \leq C d^{\frac{\alpha_{+}}{2}}(x)\left(\frac{R_{0}}{2} \operatorname{dist}(x, F)\right)^{-\frac{2}{q-1}-\frac{\alpha_{+}}{2}}
$$

Thus (6.20) holds for every $x \in \Omega_{\frac{R_{0}}{2}}$ such that $\operatorname{dist}(x, F)<\frac{1}{1+R_{0}}$.

Now we assume that $x \in \Omega_{\frac{R_{0}}{2}}$ and

$$
\operatorname{dist}(x, F) \geq \frac{1}{1+R_{0}}
$$

Let $\xi$ be the unique point in $\partial \Omega \backslash F$ such that $|x-\xi|=d(x)$. Similarly with the proof of 6.23 we can prove that

$$
u(x) \leq C d^{\frac{\alpha_{+}}{2}}(x) \leq d^{\frac{\alpha_{+}}{2}}(x) C\left(\left(1+R_{0}\right) \operatorname{dist}(x, F)\right)^{-\frac{2}{q-1}-\frac{\alpha_{+}}{2}}, \quad \forall x \in B_{\frac{R_{0}}{2}}(\xi) \cap \Omega
$$

Now if $x \in \Omega \backslash \Omega_{\frac{R_{0}}{2}}$, the proof of (6.20) follows by (6.19).
(ii) Let $x_{0} \in \Omega^{2}$. Set

$$
\Omega^{x_{0}}=\left\{y \in \mathbb{R}^{n}: d\left(x_{0}\right) y \in \Omega\right\}
$$

and $d_{x_{0}}(y)=\operatorname{dist}\left(y, \partial \Omega^{x_{0}}\right)$. If $x \in B_{\frac{d\left(x_{0}\right)}{2}}\left(x_{0}\right)$ then $y=\frac{x}{d\left(x_{0}\right)}$ belongs to $B_{\frac{1}{2}}\left(y_{0}\right)$, where $y_{0}=\frac{x_{0}}{d\left(x_{0}\right)}$. Also we have that $\frac{1}{2} \leq d_{x_{0}}(y) \leq \frac{3}{2}$ for each $y \in B_{\frac{1}{2}}\left(y_{0}\right)$. Set now $v(y)=u\left(d\left(x_{0}\right) y\right), \forall y \in B_{\frac{1}{2}}\left(y_{0}\right)$. Then $v$ satisfies

$$
-\Delta v-\kappa \frac{u}{\left|d_{x_{0}}(y)\right|^{2}}+d^{2}\left(x_{0}\right)|v|^{q}=0 \quad \text { in } B_{\frac{1}{2}}\left(y_{0}\right)
$$

By standard elliptic estimate we have

$$
\sup _{y \in B_{\frac{1}{4}}\left(y_{0}\right)}|\nabla v| \leq C\left(\sup _{y \in B_{\frac{1}{3}}\left(y_{0}\right)}|v|+\sup _{y \in B_{\frac{1}{3}}\left(y_{0}\right)} d^{2}\left(x_{0}\right)|v|^{q}\right)
$$

Now since $\nabla v(y)=d\left(x_{0}\right) \nabla u\left(d\left(x_{0}\right) y\right)$, by above inequality and (6.20) we have that

$$
\left|\nabla u\left(x_{0}\right)\right| \leq C\left(d^{\frac{\alpha_{+}}{2}-1}\left(x_{0}\right)\left(\operatorname{dist}\left(x_{0}, F\right)\right)^{-\frac{2}{q-1}-\frac{\alpha_{+}}{2}}+d^{\frac{q \alpha_{+}}{2}+1}\left(x_{0}\right)\left(\operatorname{dist}\left(x_{0}, F\right)\right)^{-q\left(\frac{2}{q-1}-\frac{\alpha_{+}}{2}\right)}\right) .
$$

Using $\frac{2 q}{q-1}=\frac{2}{q-1}+2$ and the fact that $x_{0}$ is arbitrary the result follows.
Proposition 6.4. Let $O \subset \partial \Omega$ be a relatively open subset and $F=\bar{O}$. Let $U_{F}$ be defined by (5.7) be the maximal solution of (5.1) which vanishes on $\partial \Omega \backslash F$. Then for any compact set $K \subset O$, there holds

$$
\begin{equation*}
\lim _{\xi \rightarrow x}(d(\xi))^{\frac{2}{q-1}} U_{F}(\xi)=\ell_{\kappa}=\left(\frac{2(q+1)}{(q-1)^{2}}+\kappa\right)^{\frac{1}{q-1}} \quad \text { uniformly with respect to } x \in K \tag{6.25}
\end{equation*}
$$

Proof. Step 1. We claim that for any $\epsilon>0$ there exists $C_{\epsilon}, \tau_{\epsilon}>0$ such that for any $z \in O$ such that $\bar{B}_{2 \tau_{\epsilon}}(z) \subset O$, there holds

$$
\begin{equation*}
u(x) \leq\left(\epsilon+\ell_{\kappa}^{q-1}\right)^{\frac{1}{q-1}} \tau^{-\frac{2}{q-1}}+C_{\epsilon} \quad \forall \tau \in\left(0, \tau_{\epsilon}\right], \forall x \in \Sigma_{\tau}\left(\overline{B_{\tau_{\epsilon}}}(z)\right) \tag{6.26}
\end{equation*}
$$

We recall that $\Sigma_{\tau}\left(\overline{B_{\tau_{\epsilon}}}(z)\right)=\left\{x \in \Omega, x \approx(d(x), \sigma(x)), d(x)=\tau, \sigma(x) \in \bar{B}_{\tau_{\epsilon}}(z)\right\}$. Set $g(x)=\ell d^{-\frac{2}{q-1}}(x)$, then

$$
\begin{equation*}
\mathcal{L}_{\kappa} g+g^{q}=\frac{2(N-1)}{q-1} H_{d} d^{-\frac{q+1}{q-1}}+\left(\ell^{q-1}-\ell_{\kappa}^{q-1}\right) d^{-\frac{2 q}{q-1}} \tag{6.27}
\end{equation*}
$$

where $H_{d}$ is the mean curvature of $\Sigma_{d}$. If $\Omega$ is convex we take $\ell=\ell_{\kappa}$ and $g$ is a supersolution for $d(x) \leq R_{0}$ for some $R_{0}$. In the general case, we take $\ell=\ell(\epsilon)=\left(\epsilon+\ell_{\kappa}^{q-1}\right)^{\frac{1}{q-1}}$, and $g=g_{\epsilon}=\ell(\epsilon) d^{-\frac{2}{q-1}}$ is a supersolution in the set $\Omega_{\tau_{\epsilon}}$ where

$$
\tau_{\epsilon}=\max \left\{\tau: 0<\tau \leq \frac{R_{0}}{2}, \frac{2(N-1)}{q-1}\left\|H_{\tau}\right\|_{L^{\infty}\left(\Sigma_{\tau}\right)}+\epsilon>0\right\}
$$

Then $f_{2 \tau_{\epsilon}, z}+g_{\epsilon}$ is a supersolution of (5.1) in $B_{2 \tau_{\epsilon}}(z) \cap \Omega$ which tends to infinity on $\partial\left(B_{2 \tau_{\epsilon}}(z) \cap \Omega\right)=$ $\partial \Omega \cap B_{2 \tau_{\epsilon}}(z) \cup \Omega \cap \partial B_{2 \tau_{\epsilon}}(z)$. Since we can replace $g_{\epsilon}(x)$ by $g_{\epsilon, \tau}(x)=\ell(d(x)-\tau)^{-\frac{2}{q-1}}$ for $\tau \in\left(0, \rho_{\epsilon}\right)$, any positive solution $u$ of (5.1) in $\Omega$ is bounded from above by $f_{2 \tau_{\epsilon}, z}+g_{\epsilon, \tau}$ and therefore by $f_{2 \tau_{\epsilon}, z}+g_{\epsilon}$. This implies (6.26) with $C_{\epsilon}=\max \left\{f_{2 \tau_{\epsilon}, z}(y):|y-z| \leq \tau_{\epsilon}\right\}$, and it can be made explicit thanks to (6.1).

Step 2. With the same constants as in step 1, we claim that

$$
\begin{equation*}
U_{F}(x) \geq\left(\ell_{\kappa}^{q-1}-\epsilon\right)^{\frac{1}{q-1}} \tau^{-\frac{2}{q-1}}-C_{\epsilon} \quad \forall \tau \in\left(0, \tau_{\epsilon}\right], \forall x \in \Sigma_{\tau}\left(\overline{B_{\tau_{\epsilon}}}(z)\right) \tag{6.28}
\end{equation*}
$$

If in the definition of the function $g$, we take $\ell=\ell(\epsilon)=\left(\ell_{\kappa}^{q-1}-\epsilon\right)^{\frac{1}{q-1}}$, then $g$ is a subsolution in the same set $\Omega_{\tau_{\epsilon}}$. Since $U_{F}+f_{2 \tau_{\epsilon}, z}$ is a supersolution of (5.1) in $B_{2 \tau_{\epsilon}}(z) \cap \Omega$ which tends to infinity on the boundary, it dominates the subsolution $g_{\epsilon,-\tau}=\ell(d(.)+\tau)^{-\frac{2}{q-1}}$ for $\tau \in\left(0, \rho_{\epsilon}\right)$ and thus, as $\tau \rightarrow 0$, $g_{\epsilon}(x) \leq U_{F}(x)+f_{2 \tau_{\epsilon}, z}(x)$. This implies (6.28) with the same constant $C_{\epsilon}$.
Step 3. End of the proof. Since $K \subset O$ is precompact, for any $\epsilon>0$, there exists a finite number of points $z_{j}, j=1, \ldots, k$ such that $K \subset \cup_{j=1}^{k} \overline{B_{\tau_{\epsilon}}}\left(z_{j}\right)$ with $\overline{B_{2 \tau_{\epsilon}}}\left(z_{j}\right) \subset O$. Therefore

$$
\begin{equation*}
\left(\ell_{\kappa}^{q-1}-\epsilon\right)^{\frac{1}{q-1}} \tau^{-\frac{2}{q-1}}-C_{\epsilon} \leq U_{F}(x) \leq\left(\epsilon+\ell_{\kappa}^{q-1}\right)^{\frac{1}{q-1}} \tau^{-\frac{2}{q-1}}+C_{\epsilon} \quad \forall \tau \in\left(0, \tau_{\epsilon}\right], \forall x \in \Sigma_{\tau}(K) \tag{6.29}
\end{equation*}
$$

Since $\epsilon$ is arbitrary, it yields to

$$
\begin{equation*}
\lim _{\tau \rightarrow 0}\left\|\tau^{\frac{2}{q-1}} U_{F}-\ell_{\kappa}\right\|_{L^{\infty}\left(\Sigma_{\tau}(K)\right)}=0 \tag{6.30}
\end{equation*}
$$

which is (6.25).
Corollary 6.5. Let $U_{\partial \Omega}$ be the maximal solution of (5.1) in $\Omega$, then

$$
\begin{equation*}
\lim _{d(x) \rightarrow 0}(d(x))^{\frac{2}{q-1}} U_{\partial \Omega}(x)=\ell_{\kappa} . \tag{6.31}
\end{equation*}
$$

### 6.3 Moser Iteration

In this subsection we always assume that $\Omega$ is a bounded smooth convex domain, $D=2 \sup _{x, y \in \Omega}|x-y|$ and $f_{0} \in L^{q}(\Omega), q>\frac{N+\alpha}{2}$. The main goal of this subsection is to prove Boundary Harnack inequality for positive solutions of the problem

$$
\begin{equation*}
-L_{\phi_{\kappa}} v=-\frac{\operatorname{div}\left(\phi_{\kappa}^{2} \nabla v\right)}{\phi_{\kappa}^{2}}=\frac{f}{\phi_{\kappa}}, \quad \text { in } \Omega \tag{6.32}
\end{equation*}
$$

where $|f(x)| \leq c_{f}\left(\frac{\left|\log \frac{d(x)}{D}\right|}{\phi_{\kappa}}+f_{0}(x)\right), \forall x \in \Omega$, for some positive constant $c_{f}>0$.
In the sequel we will use the following local representation of the boundary of $\Omega$. There exists a finite number $m$ of coordinate systems $\left(y_{i}^{\prime}, y_{n}\right) \in \partial \Omega, y_{i}^{\prime}=\left(y_{i 1}, \ldots, y_{i n-1}\right)$ and the same number $m$ of functions $a_{i}\left(y_{i}^{\prime}\right)$ defined on the closure cubs, $\Delta_{i}:=\left\{x \in \mathbb{R}^{n}:\left|y_{i j}-x_{i}\right| \leq b\right.$, for $j=1, \ldots, n$, and
$i \in\{1, . ., m\}$ so that for each point $x \in \partial \Omega$ there is at least $i$ such that $x=\left(x_{i}^{\prime}, a_{i}\left(x_{i}^{\prime}\right)\right)$. The function $a_{i}$ satisfies the Lipschitz condition on $\bar{\Delta}_{i}$ with constant $A>0$, that is

$$
\left|a_{i}\left(y_{i}^{\prime}\right)-a_{i}\left(z_{i}^{\prime}\right) \leq A\right| y_{i}^{\prime}-z_{i}^{\prime} \mid
$$

for $y_{i}^{\prime}, z_{i}^{\prime} \in \bar{\Delta}_{i}$. Moreover there exists a positive constant $b<1$ such that the set $B_{i}$ is defined for any $i \in\{1, . ., m\}$ by the relation $B_{i}=\left\{\left(y_{i}^{\prime}, y_{i n}\right): y_{i}^{\prime} \in \Delta_{i}, a_{i}\left(y_{i}^{\prime}\right) \leq y_{i n} \leq a_{i}\left(y_{i}^{\prime}\right)+b\right\}$ and $\Gamma_{i}=B_{i} \cap \partial \Omega=\left\{\left(y_{i}^{\prime}, y_{i n}\right): y_{i}^{\prime} \in \Delta_{i}, y_{i n}=a_{i}\left(y_{i}^{\prime}\right)\right\}$. Furthermore, let us observe for any $y \in B_{i}$ where someone can make the following inequality on the distance function

$$
(1+A)^{-1}\left(y_{i n}-a_{i}\left(y_{i}^{\prime}\right)\right) \leq d(y) \leq y_{i n}-a_{i}\left(y_{i}^{\prime}\right)
$$

Finally let $x \in \partial B_{i}$ and $v \in C_{0}^{1}(\Omega)$. Set $x_{i}=y_{i}$ for $i=1, \ldots, n-1$ and $x_{n}=y_{n}+a_{i}\left(y^{\prime}\right)$ then $\nabla_{y^{\prime}} v=\nabla_{x^{\prime}} v+v_{x_{n}} \nabla_{x^{\prime}} a_{i}\left(x^{\prime}\right)$ and $v_{y_{n}}=v_{x_{n}}$, thus

$$
\begin{equation*}
C(A)\left|\nabla_{x} v\right| \leq\left|\nabla_{y} v\right| \leq c(A)\left|\nabla_{x} v\right| . \tag{6.33}
\end{equation*}
$$

Let us now define the "balls" which we will use to prove some Poincaré, weighted Poincaré and Moser inequalities. More precisely we have the following definition
Definition 6.6. Let $\gamma \in(1,2)$.
For any $x \in \Omega$ and for any $0<r<\frac{\min \left\{C_{0}, b\right\}}{2 \gamma}$, we define the ball centered at $x$ and having radius $r$ as follows.
(i) If $d(x) \leq \gamma r$ then

$$
\mathfrak{B}(x, r)=\left\{\left(y_{i}^{\prime}, y_{\text {in }}\right):\left|y_{i}^{\prime}-x_{i}^{\prime}\right| \leq r, d(x)-r \leq y_{\text {in }}-a_{i}\left(y_{i}^{\prime}\right) \leq r+d(x)\right\}
$$

where $i \in\{1, \ldots, m\}$ is uniquely defined by the point $\bar{x} \in \partial \Omega$ such that $|x-\bar{x}|=d(x)$, that is by the projection of the center $x$ onto $\partial \Omega$.
(ii) If $d(x) \geq \gamma r$ then $\mathfrak{B}(x, r)=B(x, r)$ the Euclidean ball centered at $x$.

We also define by

$$
V(x, r)=\int_{\mathfrak{B}(x, r) \cap \Omega} \phi_{\kappa}^{2}(y) d y
$$

the volume of the "ball" centered at $x$ and having radius $r$.
We first recall some known results which the proofs are in [12].
Proposition 6.7. Lemma 2.2-[12]. There exist positive constants $d_{1}$ and $d_{2}$ such that for any $x \in \Omega$ and $0<r<\frac{\min \left\{C_{0}, b\right\}}{2 \gamma}$, we have

$$
d_{1} \max \left\{d^{\alpha}(x), r^{\alpha}\right\} r^{N} \leq V(x, r) \leq d_{2} \max \left\{d^{\alpha}(x), r^{\alpha}\right\} r^{N}
$$

From the previous Lemma someone can easily deduce the doubling property which reads as follows:
Corollary 6.8. Doubling property. Let $N \geq 2, \alpha>0$ and $\Omega$ be a smooth bounded domain. Then there exist positive constants $C(N, \gamma, \Omega, \alpha)$ and $\beta(\Omega, \gamma)$ such that for any $x \in \Omega$ and $0<r<\beta$ we have

$$
V(x, 2 r) \leq C V(x, r)
$$

Proposition 6.9. Local Poincaré inequality (Theorem 2.5-[12]). There exist positive constants $C\left(N, \gamma, \Omega, \alpha_{+}\right)$ and $\beta(\Omega, \gamma)$ such that for any $x_{0} \in \Omega$ and $r<\beta$ we have

$$
\inf _{\xi \in \mathbb{R}} \int_{\mathfrak{B}\left(x_{0}, r\right) \cap \Omega}|\tilde{f}(y)-\xi|^{2} \phi_{\kappa}^{2} d y \leq C r^{2} \int_{\mathfrak{B}\left(x_{0}, r\right) \cap \Omega}|\nabla \tilde{f}(y)|^{2} \phi_{\kappa}^{2} d y, \quad \forall \tilde{f} \in C^{\infty}\left(\mathfrak{B}\left(x_{0}, r\right) \cap \Omega\right)
$$

Proposition 6.10. Local weighted Moser inequality (Theorem 2.6-[12]). There exist positive constants $C_{M}\left(N, \Omega, \alpha_{+}\right)$and $\beta(\Omega)$ such that for any $\nu \geq N+\alpha, x_{0} \in \Omega, r<\beta$ and $f \in C_{0}^{\infty}\left(\mathfrak{B}\left(x_{0}, r\right) \cap \Omega\right)$ we have

$$
\begin{gathered}
\int_{\mathfrak{B}\left(x_{0}, r\right) \cap \Omega}|f(y)|^{2\left(1+\frac{2}{\nu}\right)} \phi_{\kappa}^{2}(y) d y \\
\leq C_{M} r^{2} V(x, r)^{-\frac{2}{\nu}} \int_{\mathfrak{B}\left(x_{0}, r\right) \cap \Omega}|\nabla f(y)|^{2} \phi_{\kappa}^{2}(y) d y\left(\int_{\mathfrak{B}\left(x_{0}, r\right) \cap \Omega}|f(y)|^{2} \phi_{\kappa}^{2}(y) d y\right)^{\frac{2}{\nu}} .
\end{gathered}
$$

Let us now make precise the notion of a weak solution.
Definition 6.11. We will say that $v \in H_{\phi}^{1}(\mathfrak{B}(x, r) \cap \Omega)$ is a weak solution of $L_{\phi_{\kappa}} v=f$ in $\mathfrak{B}(x, r) \cap \Omega$, if for each $\Phi \in C_{0}^{\infty}(\mathfrak{B}(x, r) \cap \Omega)$, we have

$$
\int_{\mathfrak{B}(x, r) \cap \Omega} \nabla v \nabla \Phi d m=\int_{\mathfrak{B}(x, r) \cap \Omega} f \Phi d m
$$

where $d m=\phi_{\kappa}^{2} d x$ and $\sigma>0$.
We denote here by $H_{\phi}^{1}(\mathfrak{B}(x, r) \cap \Omega)$ the space which consists of all functions $u: \mathfrak{B}(x, r) \cap \Omega \rightarrow \mathbb{R}$ such that, $\nabla u$ exists in the weak sense and

$$
\|u\|_{H_{\phi_{\kappa}}^{1}(\mathfrak{B}(x, r) \cap \Omega)}^{2}=\int_{\mathfrak{B}(x, r) \cap \Omega}|\nabla u|^{2} \phi_{\kappa}^{2} d x+\int_{\mathfrak{B}(x, r) \cap \Omega} u^{2} \phi_{\kappa}^{2} d x<\infty
$$

Then we have
Theorem 6.12. Let $v$ be a non-negative solution of $L_{\phi_{\kappa}} v=f$ in $\Omega, T>0$. Then there exists a constant $A>0$ such that the following estimate is valid for all $x, y \in \Omega$.

$$
v(y) \leq A v(x)
$$

In order to prove the Harnack inequality in Theorem 6.12 we use the Moser iteration technique as adapted to degenerate elliptic operators in [14], [15] and [SC2]. In this approach one inserts in the weak form of the equation $L_{\phi_{\kappa}} v=f$ suitable test functions $\Phi$. One of the key ideas is to use test functions $\Phi$ of the form $\eta^{2} v^{q}$, where $v$ is the weak solution of the equation, $\eta$ is a cut off function and $q \in \mathbb{R}$. To this end one has to check that $\eta^{2} v^{q}$ is in the right space of test function. In this direction the following density theorem is crucial, which proof is in [12]-Theorem 2.11.
Theorem 6.13. Let $N \geq 2, \alpha \geq 1$ and $U \subset \mathbb{R}^{n}$ be a smooth bounded domain. Then we have

$$
H_{0}^{1}\left(U, d^{\alpha}(y) d y\right)=H^{1}\left(U, d^{\alpha}(y) d y\right)
$$

Here $H^{1}\left(U, d^{\alpha}(y) d y\right)$ denotes the set

$$
\left\{v=v(y):\|v\|_{H_{1}^{1}}^{2}=\int_{U} d^{\alpha}\left(|\nabla v|^{2}+v^{2}\right) d y<\infty\right\}
$$

We note here the above theorem allows us to take the cut of function $\eta \in C_{0}^{\infty}(\mathfrak{B}(x, r))$ instead of it as a usual taking in $\eta \in C_{0}^{\infty}(\mathfrak{B}(x, r) \cap \Omega)$. Clearly the two function spaces differ only if the "ball" intersects the boundary of $\Omega$.

To explain what are the appropriate modifications of the standard iteration argument by Moser, we now present in detail the first step, which is the $L^{p} ; p \geq 2$ mean value inequality for any positive local subsolution of $L_{\phi_{k}} v \leq f$. Similarly with Definition 6.11, we call a function $v \in H_{\phi}^{1}(\mathfrak{B}(x, r) \cap \Omega)$ subsolution of $L_{\phi_{\kappa}} v \leq f$ in $\mathfrak{B}(x, r) \cap \Omega$, if for each $0 \leq \Phi \in C_{0}^{\infty}(\mathfrak{B}(x, r) \cap \Omega)$ we have

$$
\begin{equation*}
\int_{\mathfrak{B}(x, r) \cap \Omega} \nabla v \nabla \Phi d m d t \leq \int_{\mathfrak{B}(x, r) \cap \Omega} f d m d t \tag{6.34}
\end{equation*}
$$

where $d m=\phi_{\kappa}^{2} d x$.
Theorem 6.14. Let $\gamma \in(1,2)$ and $p \geq 2$. Then there exist positive constants $c_{0}(\Omega)$ and $C\left(\Omega, p, \kappa, c_{0}\right)$ such that for any $x \in \Omega, R<c_{0}$ and for any positive subsolution of $L_{\phi_{\kappa}} v \leq f$ in $\mathfrak{B}(x, r) \cap \Omega$, we have the estimate

$$
\begin{aligned}
\sup _{\mathfrak{B}(x, \sigma R) \cap \Omega}|v|^{p} & \leq \frac{C}{(1-\sigma)^{\nu+2} V(x, R)} \int_{\mathfrak{B}\left(x, \delta^{\prime} R\right) \cap \Omega}|v|^{p} \phi_{\kappa}^{2} d x \\
& +C\left(R^{2} c_{f}+R^{2-\frac{N+\alpha_{+}}{q}}\left(\int_{\mathfrak{B}(x, R) \cap \Omega}\left|f_{0}\right|^{q} \phi_{\kappa}^{2} d x\right)^{\frac{1}{q}}\right)
\end{aligned}
$$

for each $0<\sigma<1$.

\sup _{\mathfrak{B}\left(y_{0}, \frac{R}{2}\right) \cap \Omega^{R}}|v|^{p} \leq \frac{1}{V(x, R)}\left(\int_{\mathfrak{B}\left(y_{0}, 1\right) \cap \Omega^{R}}|v|^{p} \phi_{\kappa}^{2} d x+k\right), \quad \forall p \geq 2,
$$

The estimate in $\mathfrak{B}\left(y_{0}, \sigma R\right) \cap \Omega$ can be obtained by applying the above result to $\mathfrak{B}\left(y_{0},(1-\sigma) R\right) \cap \Omega$ for any $y \in \mathfrak{B}(y, \sigma R) \cap \Omega$.

Using Moser iteration we can prove
Proposition 6.15. Let u be a weak solution of (6.32). Then there exist constant $C=C(\Omega, N, \kappa)$ and $0<\alpha=\alpha(\Omega, N, \kappa)$, such that

$$
\sup _{x, y \in \Omega x \neq y} \frac{|u(x)-u(y)|}{|x-y|^{\alpha}} \leq C\left(c_{f}+\left(\int_{\mathfrak{B}(x, R) \cap \Omega}\left|f_{0}\right|^{q} \phi_{\kappa}^{2} d x\right)^{\frac{1}{q}}\right) .
$$
