

Effects of two types of hyperventilation on standing balance

NTRODUCTION

The present study sought to establish links between hyperventilation and postural stability.

Insofar as hyperventilation can be performed voluntary or by the mean of metabolic changes, we hypothesized by modifying the system of ventilatory control (metabolic vs voluntary) that characteristics of postural perturbations and mechanisms of postural adjustments may also be different.

MATERIALS AND METHODS

* Forceplate data :

- ground reaction forces (Fx, Fy and Fz)
- centre of pressure (COPx and COPy)
- ⇒ characterising postural disturbances

* Ventilatory measurements :

- CO₂ fraction of exhaled gas (Feco₂)
- breathing frequency (BF)
- ⇒ characterising ventilatory perturbations

* Myoelectric activities (EMG):

- Soleus (SO)
- Tibialis anterior (TA)
- ⇒ reflecting postural control

Participants

8 healthy university students



Ventilatory perturbations :

applied randomly with a 5 min-rest period between them

Metabolic Hyperventilation (MH): 5-min of CO₂ rebreathing using Douglas bag

Voluntary Hyperventilation (VH):

3-min imposed by a metronome set at 25-min⁻¹



Postural tests (maintenance of bipedal stance with eyes open) made before and during the ventilatory perturbations

RESULTS AND DISCUSSION

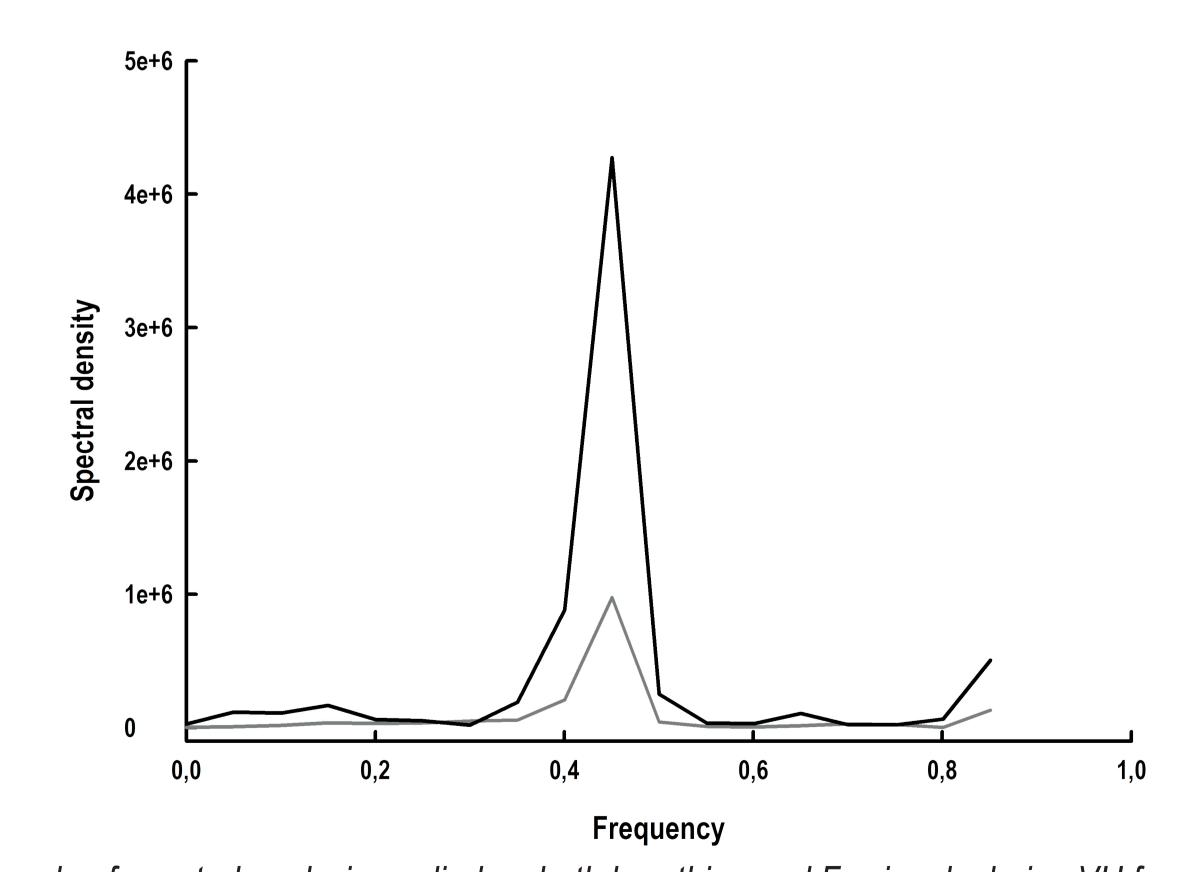
Ventilatory (F_{ECO}_2 , f_R , Δacc) and postural sway (ΔF_2 , ΔF_3 , ΔF_4 , ΔF_5 , ΔF

Characteristics of postural perturbations differ as MH and VH

• Close relationship between breathing and Δ Fz during VH (coh = 0.8 ± 0.14)

Suggests a ventilatory origin of these postural disturbances

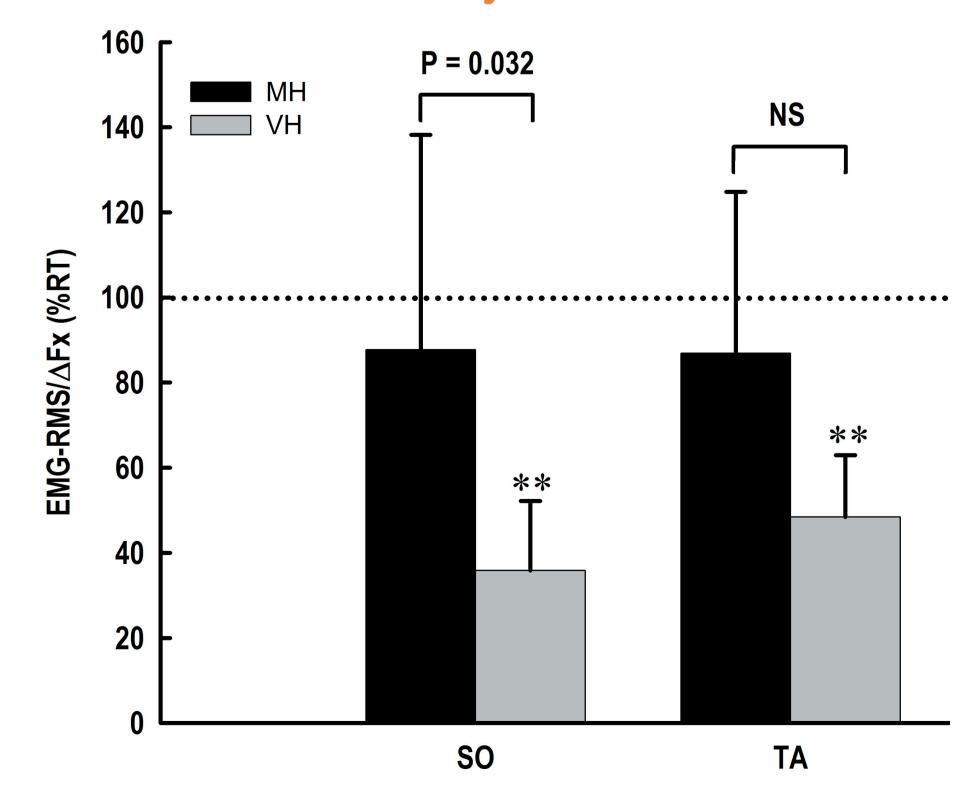


Example of spectral analysis applied on both breathing and Fz signals during VH for one subject.

The frequency distribution of the two signals - ■ for the ventilation and □ for Fzrevealed a synchronization in spectral densities around 0.4 Hz.

- Significant decrease in RMS SO/ Δ Fx and RMS TA/ Δ Fx ratios during VH (P<0.01)
- Significant difference in RMS SO/ Δ Fx ratios between MH and VH (P=0.032)

Hypothesis: leg muscle strategies directly linked to ventilatory control modes?



Soleus and tibialis anterior EMG activities measured in postural tests during MH \blacksquare and VH \blacksquare . EMGs were quantified in terms of the RMS, normalized with respect to $\triangle Fx$ and expressed as percentages of the baseline values obtained in the reference test. **P<0.01

Conclusions

- Our results indicate that characteristics of postural perturbations and mechanisms of postural adjustments markedly differ as the type of hyperventilation (metabolic or voluntary).
- More experiments are needed to better understand how those mechanisms imply some links between ventilatory drive and postural control.
