# Boundary singularities of positive solutions of quasilinear Hamilton-Jacobi equations*

#### Abstract

We study the boundary behaviour of the solutions of (E) $-\Delta_{p} u+|\nabla u|^{q}=0$ in a domain $\Omega \subset \mathbb{R}^{N}$, when $N \geq p>q>p-1$. We show the existence of a critical exponent $q_{*}<p$ such that if $p-1<q<q_{*}$ there exist positive solutions of ( E ) with an isolated singularity on $\partial \Omega$ and that these solutions belong to two different classes of singular solutions. If $q_{*} \leq q<p$ no such solution exists and actually any boundary isolated singularity of a positive solution of $(\mathrm{E})$ is removable. We prove that all the singular positive solutions are classified according the two types of singular solutions that we have constructed.

## 1 Introduction

Let $N \geq p>1, q>p-1$ and $\Omega \subset \mathbb{R}^{N}(N>1)$ be a $C^{2}$ bounded domain such that $0 \in \partial \Omega$. In this article we study the boundary behavior at 0 of nonnegative functions $u \in C^{1}(\Omega) \cap C(\bar{\Omega} \backslash\{0\})$ which satisfy

$$
\begin{equation*}
-\Delta_{p} u+|\nabla u|^{q}=0 \quad \text { in } \Omega \tag{1.1}
\end{equation*}
$$

where $\Delta_{p} u:=\operatorname{div}\left(|\nabla u|^{p-2} \nabla u\right)$. The two main questions we consider are as follows:
Q-1- Existence of positive solutions of (1.1).
Q-2- Description of positive solutions with an isolated boundary singularity at 0 .
When $p=2$ a fairly complete description of positive solutions of

$$
\begin{equation*}
-\Delta u+|\nabla u|^{q}=0 \tag{1.2}
\end{equation*}
$$

in $\Omega$ is provided by Nguyen-Phuoc and Véron [11]. In particular they prove the following series of results in the range of values $1<q<2$.
1- Any signed solution of (1.3) verifies the estimates

$$
\begin{equation*}
|\nabla u(x)| \leq c_{N, q}(d(x))^{-\frac{1}{q-1}} \quad \forall x \in \Omega \tag{1.3}
\end{equation*}
$$

where $d(x)=\operatorname{dist}(x, \partial \Omega)$. As a consequence, if $u \in C(\bar{\Omega} \backslash\{0\})$ is a solution which vanishes on $\partial \Omega \backslash\{0\}$, it satisfies

$$
\begin{equation*}
|u(x)| \leq c_{q, \Omega} d(x)|x|^{-\frac{1}{q-1}} \quad \forall x \in \Omega \tag{1.4}
\end{equation*}
$$

2- If $\frac{N+1}{N} \leq q<2$ any positive solution of (1.3) in $\Omega$ which vanishes on $\partial \Omega \backslash\{0\}$ is identically 0 . An isolated boundary point is a removable singularity for (1.2).
3- If $1<q<\frac{N+1}{N}$ and $k>0$ there exists a unique positive solution $u:=u_{k}$ of (1.2) in $\Omega$ which vanishes on $\partial \Omega \backslash\{0\}$ and satisfies $u(x) \sim c_{N} k P^{\Omega}(x, 0)$ as $x \rightarrow 0$, where $P^{\Omega}$ is the Poisson kernel in $\Omega \times \partial \Omega$.
4- If $1<q<\frac{N+1}{N}$ there exists a unique positive solution $u$ of (1.2) in the half-space $\mathbb{R}_{+}^{N}:=\{x=$ $\left.\left(x^{\prime}, x_{N}\right): x^{\prime} \in \mathbb{R}^{N-1}, x_{N}>0\right\}$ under the form $u(x)=|x|^{-\frac{2-q}{q-1}} \omega\left(|x|^{-1} x\right)$ which vanishes on $\partial \mathbb{R}_{+}^{N} \backslash\{0\}$. The function $\omega$ is the unique positive solution of

$$
\begin{align*}
-\Delta^{\prime} \omega+\left(\left(\frac{2-q}{q-1}\right)^{2} \omega^{2}+\left|\nabla^{\prime} \omega\right|^{2}\right)^{\frac{q}{2}}-\lambda_{N, q} \omega & =0  \tag{1.5}\\
\omega & \text { in } S_{+}^{N-1} \\
& \text { in } \partial S_{+}^{N-1}
\end{align*}
$$

where $S^{N-1}$ is the unit sphere of $\mathbb{R}^{N}, \partial S_{+}^{N-1}=\partial \mathbb{R}_{+}^{N} \cap S^{N-1}, \Delta^{\prime}$ the Laplace-Beltrami operator and $\lambda_{N, q}>0$ an explicit constant.
5- If $1<q<\frac{N+1}{N}$ and $u$ is a positive solution of (1.3) in $\Omega$, which is continuous in $\bar{\Omega} \backslash\{0\}$ and vanishes on $\partial \Omega \backslash\{0\}$ the following dichotomy occurs:
(i) either $u(x) \sim|x|^{-\frac{2-q}{q-1}} \omega\left(|x|^{-1} x\right)$ as $x \rightarrow 0$,
(ii) or $u(x) \sim k c_{N} P^{\Omega}(x, 0)$ as $x \rightarrow 0$ for some $k \geq 0$.

The aim of this article is to extend to the quasilinear case $1<p \leq N$ the above mentioned results. The following pointwise gradient estimate valid for any signed solution $u$ of (1.1) has been proved in [3]: if $0<p-1<q$ there exists a constant $c_{N, p, q}>0$ such that

$$
\begin{equation*}
|\nabla u(x)| \leq c_{N, p, q}(d(x))^{-\frac{1}{q+1-p}} \quad \forall x \in \Omega . \tag{1.6}
\end{equation*}
$$

As a consequence, any solution $u \in C^{1}(\bar{\Omega} \backslash\{0\}$ satisfies

$$
\begin{equation*}
|u(x)| \leq c_{p, q, \Omega} d(x)|x|^{-\frac{1}{q+1-p}} \quad \forall x \in \Omega . \tag{1.7}
\end{equation*}
$$

Concerning boundary singularities, the situation is much more complicated than in the case $p=2$ and the threshold of critical exponent less explicit. We first consider the problem in $\mathbb{R}_{+}^{N}$. Assuming $p-1<q \leq p$, separable solutions of (1.1) in $\mathbb{R}_{+}^{N}$ vanishing on $\partial \mathbb{R}_{+}^{N} \backslash\{0\}$ can be looked for in spherical coordinates $(r, \sigma) \in \mathbb{R}_{+}^{*} \times S^{N-1}$ (we denote $\mathbb{R}_{+}^{*}=(0, \infty)$ ) under the form

$$
\begin{equation*}
u(x)=u(r, \sigma)=r^{-\beta_{q}} \omega(\sigma), \quad r>0, \sigma \in S_{+}^{N-1}:=\left\{S^{N-1} \cap \mathbb{R}_{+}^{N}\right\} . \tag{1.8}
\end{equation*}
$$

Then $\omega$ is solution of the following problem

$$
\begin{align*}
-\operatorname{div}^{\prime}\left(\left(\beta_{q}^{2} \omega^{2}+\left|\nabla^{\prime} \omega\right|^{2}\right)^{\frac{p-2}{2}} \nabla^{\prime} \omega\right)- & \beta_{q} \Lambda_{\beta_{q}}\left(\beta_{q}^{2} \omega^{2}+\left|\nabla^{\prime} \omega\right|^{2}\right)^{\frac{p-2}{2}} \omega \\
+\left(\beta_{q}^{2} \omega^{2}+\left|\nabla^{\prime} \omega\right|^{2}\right)^{\frac{q}{2}} & =0  \tag{1.9}\\
\omega=0 & \text { in } S_{+}^{N-1} \\
\omega=0 & \text { on } \partial S_{+}^{N-1},
\end{align*}
$$

where

$$
\begin{equation*}
\beta_{q}=\frac{p-q}{q+1-p} \text { and } \Lambda_{\beta_{q}}=\beta_{q}(p-1)+p-N, \tag{1.10}
\end{equation*}
$$

and $\nabla^{\prime}$ is the covariant derivative on $S^{N-1}$ identified to the tangential gradient thanks to the canonical isometrical imbedding of $S^{N-1}$ into $\mathbb{R}^{N}$, and $d i v^{\prime}$ the divergence operator acting on vector fields on $S^{N-1}$.

The existence of a positive solution to this problem cannot be separated from the problem of existence of separable p-harmonic functions which are $p$-harmonic in $\mathbb{R}_{+}^{N}$ which vanish on $\partial \mathbb{R}_{+}^{N} \backslash\{0\}$ and have the form $\Psi(x)=\Psi(r, \sigma)=r^{-\beta} \psi(\sigma)$ for some real number $\beta$. Necessarily such a $\psi$ must satisfy

$$
\begin{array}{rlrl}
-d i v^{\prime}\left(\left(\beta^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p-2}{2}} \nabla^{\prime} \psi\right)-\beta \Lambda_{\beta}\left(\beta^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p-2}{2}} \psi & =0 & \text { in } S_{+}^{N-1}  \tag{1.11}\\
\psi & =0 & & \text { on } \partial S_{+}^{N-1},
\end{array}
$$

where $\Lambda_{\beta}=\beta(p-1)+p-N$. We will refer to (1.11) as the spherical $p$-harmonic eigenvalue problem. The study of this problem has been initiated in the 2-dim case by $\operatorname{Krol}[8](\beta<0)$ and Kichenassamy and Véron [9] $(\beta>0)$. In this case $\omega$ satisfies a completely integrable second order differential equation. In the case where $S_{+}^{N-1}$ is replaced by a smooth domain $S \subset S^{N-1}$ with $N \geq 3$, Tolksdorf [14] proved the existence of a unique couple ( $\tilde{\beta}_{s}, \tilde{\psi}_{s}$ ) where $\tilde{\beta}_{s}<0$ and $\tilde{\psi}_{s}$ has constant sign and is defined up to an homothety. Recently Porretta and Véron [12] gave a simpler and more general proof of the existence of two couples ( $\left.\tilde{\beta}_{s}, \tilde{\psi}_{s}\right)$ and $\left(\beta_{* s}, \psi_{* s}\right)$ where $\beta_{* s}>0$ and $\tilde{\psi}_{s}$ and $\psi_{* s}$ are positive solutions of (1.11) with
$\beta=\tilde{\beta}_{s}$ and $\beta=\beta_{* s}$ respectively and are unique up to a multiplication by a real number. When $p=2$ this problem is an eigenvalue problem for the Laplace-Beltrami operator on a subdomain of $\tilde{S}^{N-1}$. If $S=S_{+}^{N-1}, \tilde{\beta}_{s}$ and $\beta_{* s}$ are respectively denoted by $\tilde{\beta}$ and $\beta_{*}$ and accordingly $\tilde{\psi}_{s}$ and $\psi_{* s}$ by $\tilde{\psi}$ and $\psi_{*}$. Since $x \mapsto x_{N}$ is $p$-harmonic, $\tilde{\beta}=-1$. Except in the cases $N=2$ where it is the positive root of some algebraic equation of degree $2, p=2$ where it is $N-1$ and $p=N$ where it is 1 , the value of $\beta_{*}$ is unknown besides the straightforward estimate $\beta_{*} \geq \max \left\{1, \frac{N-p}{p-1}\right\}$. Using the fact that $\psi_{*}$ depends only on the azimuthal variable and satisfies a differential equation, we prove in Appendix II the following new estimate:

Theorem A Let $1<p \leq N$.
(i) If $2 \leq p \leq N$, then $\beta_{*} \leq \frac{N-1}{p-1}$ with equality only if $p=2$ or $N$.
(ii) If $1 \leq p<2$, then $\beta_{*}>\frac{N-1}{p-1}$.

The $p$-harmonic function $\Psi_{*}(x)=\Psi_{*}(r, \sigma)=r^{-\beta_{*}} \psi_{*}(\sigma)$ endows the role of a Poisson kernel. To this exponent $\beta_{*}$ is associated the critical value $q_{*}$ of $q$ defined by $\beta_{*}=\beta_{q}$, or equivalently

$$
\begin{equation*}
q_{*}:=\frac{\beta_{*}(p-1)+p}{\beta_{*}+1}=p-\frac{\beta_{*}}{\beta_{*}+1} \tag{1.12}
\end{equation*}
$$

The following result characterizes strong singularities.
Theorem B Let $0<p-1 \leq N$, then
(i) If $p-1<q<q_{*}$ problem (1.9) admits a unique positive solution $\omega_{*}$.
(ii) If $q_{*} \leq q<p$ problem (1.9) admits no positive solution.

This critical exponent corresponds to the threshold of criticality for boundary isolated singularities.
Theorem C Assume $q_{*} \leq q<p \leq N$. If $u \in C^{1}(\bar{\Omega} \backslash\{0\})$ is a nonnegative solution of (1.1) in $\Omega$ which vanishes on $\partial \Omega \backslash\{0\}$, it is identical zero.

As in the case $p=2$, there exist positive solutions (1.1) in $\Omega$ with weak boundary singularities which are characterized by their blow-up near the singularity. By opposition to the case $p=2$ where existence is obtained by use of a weak formulation of the boundary value problem, combined with uniform integrability of the absorption term thanks to Poisson kernel estimates (see [11]), this approach cannot be performed in the case $p \neq 2$; the obtention of solutions with weak singularities necessitates a very long and delicate construction of subsolutions and supersolutions. Furthermore, when $p \neq N$, the construction is done only if $\Omega$ is locally an hyperplane near 0 .

In the sequel we denote by $B_{R}(a)$ the open ball of center $a$ and radius $R>0$ and $B_{R}=B_{R}(0)$. We also set $B_{R}^{+}(a):=\mathbb{R}_{+}^{N} \cap B_{R}(a), B_{R}^{+}:=\mathbb{R}_{+}^{N} \cap B_{R}, B_{R}^{-}(a):=\mathbb{R}_{-}^{N} \cap B_{R}(a)$ and $B_{R}^{-}:=\mathbb{R}_{-}^{N} \cap B_{R}$, where $\mathbb{R}_{-}^{N}:=\left\{x=\left(x^{\prime}, x_{N}\right): x^{\prime} \in \mathbb{R}^{N-1}, x_{N}<0\right\}$. If $\Omega$ is an open domain and $R>0$, we put $\Omega_{R}=\Omega \cap B_{R}$

Theorem $\mathbf{D}$ Let $\Omega \subset \mathbb{R}_{+}^{N}$ be a bounded domain such that $0 \in \partial \Omega$. Assume there exists $\delta>0$ such that $\Omega_{\delta}=B_{\delta}^{+}$and $0<p-1<q<q_{*}<p \leq N$. Then for any $k>0$ there exists a unique $u:=u_{k} \in C^{1}(\bar{\Omega} \backslash\{0\})$, solution of (1.1) in $\Omega$, vanishing on $\partial \Omega \backslash\{0\}$ and such that

$$
\begin{equation*}
\lim _{\substack{x \rightarrow 0 \\-\rightarrow \sigma \in S_{+}^{N-1}}}|x|^{\beta_{*}} u_{k}(x)=k \psi_{*}(\sigma) \tag{1.13}
\end{equation*}
$$

Furthermore $\lim _{k \rightarrow \infty} u_{k}=u_{\infty}$ and

$$
\begin{equation*}
\lim _{\substack{x \rightarrow 0 \\ \rightarrow \sigma \in S_{+}^{N-1}}}|x|^{\beta_{q}} u_{\infty}(x)=\psi_{*}(\sigma) \tag{1.14}
\end{equation*}
$$

When $p=N$, then $q_{*}=N-\frac{1}{2}$; in such a range of values we use the conformal invariance of $\Delta_{N}$ and prove that the previous result holds if $\Omega$ is any $C^{2}$ domain. Finally, the isolated singularities of positive solutions of (1.1) are completely described by the two types of singular solutions obtained in the previous theorem and we prove:
Theorem $\mathbf{E}$ Let $\Omega$ be a bounded domain such that $0 \in \partial \Omega$. Assume there exists $\delta>0$ such that $\Omega_{\delta}=B_{\delta}^{+}$ and $0<p-1<q<q_{*}<p \leq N$. If $u \in C^{1}(\bar{\Omega} \backslash\{0\})$ is a positive solution of (1.1) in $\Omega$ which vanishes on $\partial \Omega \backslash\{0\}$, then
(i) either there exists $k \geq 0$ such that

$$
\begin{equation*}
\lim _{\substack{x \rightarrow 0 \\|x|} \sigma \in S_{+}^{N-1}}|x|^{\beta_{*}} u(x)=k \psi_{*}(\sigma) \tag{1.15}
\end{equation*}
$$

(ii) or

$$
\begin{equation*}
\lim _{\substack{x \rightarrow 0 \\ \frac{x}{|x|} \rightarrow \sigma \in S_{+}^{N-1}}}|x|^{\beta_{q}} u(x)=\psi_{*}(\sigma) . \tag{1.16}
\end{equation*}
$$

## 2 A priori estimates

### 2.1 The gradient estimates and its applications

We recall the following estimate and its consequences which are proved in [3].
Proposition 2.1. Assume $q>p-1$ and $u$ is a $C^{1}$ solution of (1.1) in a domain $\Omega$. Then

$$
\begin{equation*}
|\nabla u(x)| \leq c_{N, p, q}(d(x))^{-\frac{1}{q+1-p}} \quad \forall x \in \Omega \tag{2.1}
\end{equation*}
$$

The first application is a pointwise upper bound for solutions with isolated singularities.
Corollary 2.2. Assume $q>p-1>0, R^{*}>0$ and $\Omega$ is a domain containing 0 such that $d(0) \geq 2 R^{*}$. Then for any $x \in B_{R^{*}} \backslash\{0\}$, and $0<R \leq R^{*}$, any $u \in C^{1}(\Omega \backslash\{0\})$ solution of (1.1) in $\left.\Omega \backslash\{0\}\right)$ satisfies

$$
\begin{equation*}
\left.|u(x)| \leq\left. c_{N, p, q}| | x\right|^{\frac{q-p}{q+1-p}}-R^{\frac{q-p}{q+1-p}} \right\rvert\,+\max \{|u(z)|:|z|=R\} \tag{2.2}
\end{equation*}
$$

if $p \neq q$, and

$$
\begin{equation*}
|u(x)| \leq c_{N, p}(\ln R-\ln |x|)+\max \{|u(z)|:|z|=R\} \tag{2.3}
\end{equation*}
$$

if $p=q$.

The second application corresponds to solutions with boundary blow-up. For $\delta>0$ small enough we set $\Omega_{\delta}:=\{z \in \Omega: d(z)<\delta\}$.

Corollary 2.3. Assume $q>p-1>0, \Omega$ is a bounded domain with a $C^{2}$ boundary. Then there exists $\delta_{1}>0$ which depends only on $\Omega$ such that any $u \in C^{1}(\Omega)$ solution of (1.1) in $\Omega$ satisfies

$$
\begin{equation*}
|u(x)| \leq c_{N, p, q}\left|(d(x))^{\frac{q-p}{q+1-p}}-\delta_{1}^{\frac{q-p}{q+1-p}}\right|+\max \left\{|u(z)|: d(z)=\delta_{1}\right\} \quad \forall x \in \Omega_{\delta_{1}} \tag{2.4}
\end{equation*}
$$

if $p \neq q$, and

$$
\begin{equation*}
|u(x)| \leq c_{N, p, q}\left(\ln \delta_{1}-\ln d(x)\right)+\max \left\{|u(z)|: d(z)=\delta_{1}\right\} \quad \forall x \in \Omega_{\delta_{1}} \tag{2.5}
\end{equation*}
$$

if $p=q$.
Remark. As a consequence of (2.4) there holds for $p>q>p-1$

$$
\begin{equation*}
u(x) \leq\left(c_{N, p, q}+K \max \left\{|u(z)|: d(z) \geq \delta_{1}\right\}\right)(d(x))^{\frac{q-p}{q+1-p}} \quad \forall x \in \Omega \tag{2.6}
\end{equation*}
$$

where $K=(\operatorname{diam}(\Omega))^{\frac{p-q}{q+1-p}}$, with the standard modification if $p=q$.
As a variant of Corollary 2.3 the following upper estimate of solutions in an exterior domain will be used in the sequel.

Corollary 2.4. Assume $q>p-1>0, R>0$ and $u \in C^{1}\left(B_{R_{0}}^{c}\right)$ is any solution of $(1.1)$ in $B_{R_{0}}^{c}$. Then for any $R>R_{0}$ there holds

$$
\begin{equation*}
|u(x)| \leq c_{N, p, q}\left|\left(|x|-R_{0}\right)^{\frac{q-p}{q+1-p}}-\left(R-R_{0}\right)^{\frac{q-p}{q+1-p}}\right|+\max \{|u(z)|:|z|=R\} \quad \forall x \in B_{R}^{c} \tag{2.7}
\end{equation*}
$$

if $p \neq q$ and

$$
\begin{equation*}
|u(x)| \leq c_{N, p, q}\left(\ln \left(|x|-R_{0}\right)-\ln \left(R-R_{0}\right)\right)+\max \{|u(z)|:|z|=R\} \quad \forall x \in B_{R}^{c} \tag{2.8}
\end{equation*}
$$

if $p=q$.
Proof. The proof is a consequence of the identity

$$
u(x)=u(z)+\int_{0}^{1} \frac{d}{d t} u(t x+(1-t) z) d t=\int_{0}^{1}\langle\nabla u(t x+(1-t) z), x-z\rangle d t
$$

where $z=\frac{R}{|x|} x$. Since by (2.1)

$$
|\nabla u(t x+(1-t) z)| \leq C_{N, p, q}\left(t|x|+(1-t) R-R_{0}\right)^{-\frac{1}{q+1-p}}
$$

(2.7) and (2.8) follow by integration.

### 2.2 Boundary a priori estimates

The next result is the extension to isolated boundary singularities of a previous regularity estimate dealing with singularity in a domain proved in [3, Lemma 3.10].

Lemma 2.5. Assume $p-1<q<p, \Omega$ is a bounded $C^{2}$ domain such that $0 \in \partial \Omega$. Let $u \in C^{1}(\bar{\Omega} \backslash\{0\})$ be a solution of (1.1) in $\Omega$ which vanishes on $\partial \Omega \backslash\{0\}$ and satisfies

|u(x)| \leq \phi(|x|) \quad \forall x \in \Omega, \tag{2.9}
\end{equation*}
$$

where $\phi: \mathbb{R}_{+}^{*} \mapsto \mathbb{R}_{+}$is continuous, nonincreasing and satisfies

\begin{equation*}
\phi(r s) \leq \gamma \phi(r) \phi(s) \quad \text { and } \quad r^{\frac{p-q}{q+1-p}} \phi(r) \leq c \tag{2.10}
\end{equation*}
$$

for some $\gamma, c>0$ and any $r, s>0$. There exist $\alpha \in(0,1)$ and $c_{1}=c_{1}(p, q, \Omega)>0$ such that

$$
\begin{array}{ll}
\text { (i) } \quad|\nabla u(x)| \leq c_{1} \phi(|x|)|x|^{-1} & \forall x \in \Omega, \\
\text { (ii) } & |\nabla u(x)-\nabla u(y)| \leq c_{1} \phi(|x|)|x|^{-1-\alpha}|x-y|^{\alpha} \tag{2.11}
\end{array} \quad \forall x, y \in \Omega,|x| \leq|y| .
$$

## Furthermore

$$
\begin{equation*}
u(x) \leq c_{1} \phi(|x|) \frac{d(x)}{|x|} \quad \forall x \in \Omega \tag{2.12}
\end{equation*}
$$

Proof. For $\ell>0$, we set $\Omega^{\ell}:=\frac{1}{\ell} \Omega$. If $\ell \in(0,1]$ the curvature of $\partial \Omega^{\ell}$ remains uniformly bounded. As in [5, p 622], there exists $0 \leq \delta_{0} \leq 1$ and an involutive diffeomorphism $\psi$ from $\bar{B}_{\delta_{0}} \cap \bar{\Omega}^{\delta_{0}}$ into $\bar{B}_{\delta_{0}} \cap\left(\Omega^{\delta_{0}}\right)^{c}$ which is the identity on $\bar{B}_{\delta_{0}} \cap \partial \Omega^{\delta_{0}}$ and such that $D \psi(\xi)$ is the symmetry with respect to the tangent plane $T_{\xi} \partial \Omega$ for any $\xi \in \partial \Omega \cap \bar{B}_{\delta_{0}}$. We extend any function $v$ defined in $\bar{B}_{\delta_{0}} \cap \bar{\Omega}^{\delta_{0}}$ and vanishing on $\bar{B}_{\delta_{0}} \cap \partial \Omega^{\delta_{0}}$ into a function $\tilde{v}$ defined in $\bar{B}_{\delta_{0}}$ by

\tilde{v}(x)= \begin{cases}v(x) & \text { if } x \in \bar{B}_{\delta_{0}} \cap \bar{\Omega}^{\delta_{0}}  \tag{2.13}\\ -v \circ \psi(x) & \text { if } x \in \bar{B}_{\delta_{0}} \cap\left(\Omega^{\delta_{0}}\right)^{c},\end{cases}
$$

If $v \in C^{1}\left(\bar{B}_{\delta_{0}} \cap \bar{\Omega}^{\delta_{0}}\right)$ is a solution of (1.1) in $B_{\delta_{0}} \cap \Omega^{\delta_{0}}$ which vanishes on $\partial \Omega^{\delta_{0}} \cap \bar{B}_{\delta_{0}}$, $\tilde{v}$ satisfies

$$
\begin{equation*}
-\sum_{j} \frac{\partial}{\partial x_{j}} \tilde{A}_{j}(x, \nabla \tilde{v})+B(x, \nabla \tilde{v})=0 \quad \text { in } B_{\delta_{0}} \tag{2.14}
\end{equation*}
$$

As in [5, (2.37)] the $A_{j}$ and $B$ satisfy the following estimates
(i) $\quad \tilde{A}_{j}(x, 0)=0$
(ii) $\quad \sum_{i, j} \frac{\partial}{\partial \eta_{i}} \tilde{A}_{j}(x, \eta) \xi_{i} \xi_{j} \geq C_{1}|\eta|^{p-1}|\xi|^{2}$
(iii) $\quad \sum_{i, j}\left|\frac{\partial}{\partial \eta_{j}} \tilde{A}_{j}(x, \eta)\right| \leq C_{2}|\eta|^{p-2}$,
and

$$
\begin{equation*}
|B(x, \eta)| \leq C_{3}(1+|\eta|)^{p}, \tag{2.16}
\end{equation*}
$$

where the $C_{j}$ are positive constants. These estimates are the ones needed to apply Tolksdorf's result [15, Th 1,2]. There exists a constant $C$, such that for any ball $\bar{B}_{3 R} \subset \bar{B}_{\delta_{0}}$, there holds

\begin{equation*}
\|\nabla \tilde{v}\|_{L^{\infty}\left(B_{R}\right)} \leq C, \tag{2.17}
\end{equation*}
$$

where $C$ depends on the constants $C_{k}(k=1,2,3), N, p$ and $\|\tilde{v}\|_{L^{\infty}\left(B_{3 R}\right)}$. We define

\begin{equation*}
\Phi_{\ell}[u](y):=u_{\ell}=\frac{1}{\phi(\ell)} u(\ell y) \quad \forall y \in \Omega^{\ell} . \tag{2.18}
\end{equation*}
$$

Then

$$
\begin{equation*}
\left|u_{\ell}(y)\right| \leq \frac{\phi(\ell|y|)}{\phi(\ell)} \leq \gamma \phi(|y|) \quad \forall y \in \Omega^{\ell} \tag{2.19}
\end{equation*}
$$

and

$$
\begin{equation*}
-\Delta_{p} u_{\ell}+\left(\ell^{\beta_{q}} \phi(\ell)\right)^{q+1-p}\left|\nabla u_{\ell}\right|^{q}=0 \quad \text { in } \Omega^{\ell} . \tag{2.20}
\end{equation*}
$$

Using formula (2.13) we extend $u_{\ell}$ into a function $\tilde{u}_{\ell}$ which satisfies

$$
\begin{equation*}
-\sum_{j} \frac{\partial}{\partial y_{j}} \tilde{A}_{j}\left(y, \nabla \tilde{u}_{\ell}\right)+\left(\ell^{\beta_{q}} \phi(\ell)\right)^{q+1-p} B\left(y, \nabla \tilde{u}_{\ell}\right)=0 \quad \text { in } B_{\delta_{0}} . \tag{2.21}
\end{equation*}
$$

For $0<|x|<\delta_{0}$ there exists $\ell \in(0,2)$ such that $\frac{\delta_{0} \ell}{2} \leq|x| \leq \delta_{0} \ell$. Then $y \mapsto \tilde{u}_{\ell}(y)$ with $y=\frac{x}{\ell}$ satisfies (2.21) in $B_{\delta_{0}}$ and $\left|\tilde{u}_{\ell}(y)\right| \leq \gamma_{*} \phi(|y|)$ since $\psi$ is a diffeomorphism and $D \psi(\xi) \in O(N)$ for any $\xi \in \partial \Omega \cap B_{\delta_{0}}$. The function $\tilde{u}_{\ell}$ remains bounded on any ball $B_{3 R}(z) \subset \Gamma:=\left\{y \in \mathbb{R}^{N}: \frac{\delta_{0}}{2}<|y|<\delta_{0}\right\}$, therefore $\left|\nabla \tilde{u}_{\ell}(y)\right| \leq c$ for any $y \in B_{R}(z)$, for some constant $c>0$. This implies

$$
\begin{equation*}
|\nabla u(x)| \leq c \gamma_{*} \delta_{0} \phi\left(\frac{2}{\delta_{0}}\right) \phi(|x|)|x|^{-1} \quad \forall x \in \Omega \cap B_{\delta_{0}}, \tag{2.22}
\end{equation*}
$$

which is (2.11)-(i). Moreover, by standard regularity estimates [10], there exists $\alpha \in(0,1)$ such that $\left|\nabla \tilde{u}_{\ell}(y)-\nabla \tilde{u}_{\ell}\left(y^{\prime}\right)\right| \leq c\left|y-y^{\prime}\right|^{\alpha}$ for all $y$ and $y^{\prime}$ belonging to $B_{R}(z)$. This implies (2.11)-(ii).

Next we prove (2.12). Let $0<\delta_{1} \leq \delta_{0}$ such that at any boundary point $z$ there exist two closed balls of radius $\delta_{1}$ tangent to $\partial \Omega$ at $z$ and which are included in $\Omega \cup\{z\}$ and in $\bar{\Omega}^{c} \cup\{z\}$ respectively ( $\delta_{1}$ corresponds to the maximal radius of the interior and exterior sphere condition). Let $x \in \Omega$ such that $d(x) \leq \delta_{1}$ (this is not a loss of generality) and $z_{x}$ be the projection of $x$ on $\partial \Omega$. We first assume that $x$ does not belong to the cone $\Sigma_{\frac{\pi}{4}}$ with vertex 0 , axis $-\mathbf{n}_{0}$, where $\mathbf{n}_{0}$ is the normal outward unit vector at 0 , and angle $\frac{\pi}{4}$. Consider the path $\zeta$ from $z_{x}$ to $x$ defined by $\zeta(t)=t x+(1-t) z_{x}$ with $0 \leq t \leq 1$. Then

\begin{equation*}
u(x)=\int_{0}^{1} \frac{d}{d t} u \circ \zeta(t) d t=\int_{0}^{1}\left\langle\nabla u \circ \zeta(t), x-z_{x}\right\rangle d t \tag{2.23}
\end{equation*}
$$

Thus, by the Cauchy-Schwarz inequality, using (2.11),

|u(x)| \leq c_{1} d(x) \int_{0}^{1} \frac{\phi(|\zeta(t)|)}{|\zeta(t)|} d t \tag{2.24}
\end{equation*}
$$

Since $x \notin \Sigma_{\frac{\pi}{4}}, \zeta(t) \notin \Sigma_{\frac{\pi}{4}}$ and there exists $c_{2}>0$ depending on $\Omega$ such that $c_{2}^{-1}|x| \leq|\zeta(t)| \leq c_{2}|x|$ for all $0 \leq t \leq 1$. Therefore $\phi(|\zeta(t)|) \leq \phi\left(c_{2}|x|\right) \leq \gamma \phi\left(c_{2}\right) \phi(|x|)$ by (2.10). This implies

$$
\begin{equation*}
|u(x)| \leq \gamma c_{1} c_{2} \phi\left(c_{2}\right) \frac{d(x) \phi(|x|)}{|x|} \tag{2.25}
\end{equation*}
$$

by (2.12) whenever $x \notin \Sigma_{\frac{\pi}{4}}$. When $x \in \Sigma_{\frac{\pi}{4}}$ then $d(x) \leq|x| \leq c_{3} d(x)$ where $c_{3}>0$ depends on the curvature of $\partial \Omega$. Then (2.9) combined with (2.10) implies the claim.

Lemma 2.6. Assume $p-1<q \leq p, \Omega$ is a bounded $C^{2}$ domain such that $0 \in \partial \Omega$ and $R_{0}=\max \{|z|$ : $z \in \Omega\}$. If $u \in C(\bar{\Omega} \backslash\{0\}) \cap C^{1}(\Omega)$ is a positive solution of (1.1) which vanishes on $\partial \Omega \backslash\{0\}$, it satisfies

$$
u(x) \leq \begin{cases}c_{2}\left(|x|^{\frac{q-p}{q+1-p}}-R_{0}^{\frac{q-p}{q+1-p}}\right) & \text { if } q<p  \tag{2.26}\\ (p-1) \ln \left(\frac{R_{0}}{|x|}\right) & \text { if } q=p\end{cases}
$$

for all $x \in \Omega$, where $c_{2}=c_{2}(p, q)>0$.
Proof. For $\epsilon>0$ we denote by $P_{\epsilon}: \mathbb{R} \mapsto \mathbb{R}_{+}$the function defined by

$$
P_{\epsilon}(r)= \begin{cases}0 & \text { if } 0 \leq r \leq \epsilon  \tag{2.27}\\ -\frac{r^{4}}{2 \epsilon^{3}}+\frac{3 r^{3}}{\epsilon^{2}}-\frac{6 r^{2}}{\epsilon}+5 r-\frac{3 \epsilon}{2} & \text { if } \epsilon<r<2 \epsilon \\ r-\frac{3 \epsilon}{2} & \text { if } r \geq 2 \epsilon\end{cases}
$$

and by $u_{\epsilon}$ the extension of $P_{\epsilon}(u)$ by zero outside $\Omega$. There exists $R_{0}$ such that $\Omega \subset B_{R_{0}}$. Since $0 \leq P_{\epsilon}(r) \leq|r|$ and $P_{\epsilon}$ is convex, $u_{\epsilon} \in C\left(\mathbb{R}^{N} \backslash\{0\}\right) \cap W_{l o c}^{1, p}\left(\mathbb{R}^{N} \backslash\{0\}\right)$ and

$$
-\Delta_{p} u_{\epsilon}+\left|\nabla u_{\epsilon}\right|^{q} \leq 0 \quad \text { in } \mathbb{R}^{N} .
$$

Let $R>R_{0}$. If $p-1<q<p$

$$
\begin{equation*}
U_{\epsilon, R}(|x|)=c_{2}\left((|x|-\epsilon)^{\frac{q-p}{q+1-p}}-(R-\epsilon)^{\frac{q-p}{q+1-p}}\right) \quad \text { in } B_{R} \backslash B_{\epsilon}, \tag{2.28}
\end{equation*}
$$

with $c_{2}=(p-q)^{-1}(q+p-1)^{\frac{q-p}{q+1-p}}$. Then $-\Delta_{p} U_{\epsilon, R}+\left|\nabla U_{\epsilon, R}\right|^{q} \geq 0$. Since $u_{\epsilon}$ vanishes on $\partial B_{R}$ and is finite on $\partial B_{\epsilon}$, it follows $u_{\epsilon} \leq U_{\epsilon, R}$. Letting successively $\epsilon \rightarrow 0$ and $R \rightarrow R_{0}$ yields to (2.26). If $q=p$ we take

\begin{equation*}
U_{\epsilon, R}(|x|)=(p-1) \ln \left(\frac{R-\epsilon}{|x|-\epsilon}\right) \quad \text { in } B_{R} \backslash B_{\epsilon}, \tag{2.29}
\end{equation*}
$$

which turns out to be a supersolution of (1.1); the end of the proof is similar.
As a consequence of Lemma 2.5 and Lemma 2.6, we obtain.
Corollary 2.7. Let $p, q \Omega$ and $u$ be as in Lemma 2.6. Then there exists a constant $c_{3}=c_{3}(p, q, \Omega)>0$ such that

|\nabla u(x)| \leq c_{3}|x|^{-\frac{1}{q+1-p}} \quad \forall x \in \Omega \tag{2.30}
\end{equation*}
$$

and

$$
\begin{equation*}
u(x) \leq c_{3} d(x)|x|^{-\frac{1}{q+1-p}} \quad \forall x \in \bar{\Omega} \backslash\{0\} \tag{2.31}
\end{equation*}
$$

Remark. If $\Omega$ is locally flat near 0 , then estimates (2.30) and (2.31) are valid without any sign assumption on $u$. More precisely, if $\partial \Omega \cap B_{\delta_{0}}=T_{0} \partial \Omega \cap B_{\delta_{0}}$ we can perform the reflection of $u$ through the tangent plane $T_{0} \partial \Omega$ to $\partial \Omega$ at 0 and the new function $\tilde{u}$ is a solution of (1.1) in $B_{\delta_{0}} \backslash\{0\}$. By Proposition 2.1, it satisfies

|\nabla \tilde{u}(x)| \leq c_{N, p, q}|x|^{-\frac{1}{q+1-p}} \quad \forall x \in B_{\frac{\delta_{0}}{2}} \backslash\{0\} . \tag{2.32}
\end{equation*}
$$

Integrating this relation as in [3], we derive that for any $x \in B_{\frac{\delta_{0}}{2}} \cap \Omega$, there holds

|u(x)| \leq \begin{cases}c_{N, p, q}\left(|x|^{-\beta_{q}}-\left(\frac{\delta_{0}}{2}\right)^{-\beta_{q}}\right)+\max \left\{|u(z)|:|z|=\frac{\delta_{0}}{2}\right\} & \text { if } p \neq q  \tag{2.33}\\ c_{N, p} \ln \left(\frac{\delta_{0}}{2|x|}\right)+\max \left\{|u(z)|:|z|=\frac{\delta_{0}}{2}\right\} & \text { if } p=q .\end{cases}
$$

In the next result we allow the boundary singular set to be a compact set.
Proposition 2.8. Let $p-1<q<p$ and $\delta_{1}$ as above. There exist $r^{*} \in\left(0, \delta_{1}\right]$ and $c_{4}=c_{4}(N, p, q)>0$ such that for any nonempty compact set $K \subset \partial \Omega, K \neq \partial \Omega$ and any positive solution $u \in C(\bar{\Omega} \backslash K) \cap$ $C^{1}(\Omega)$ of (1.1) which vanishes on $\partial \Omega \backslash K$, there holds

$$
\begin{equation*}
u(x) \leq c_{4} d(x)\left(d_{K}(x)\right)^{-\frac{1}{q+1-p}} \quad \forall x \in \partial \Omega \text { s.t. } d(x) \leq r^{*}, \tag{2.34}
\end{equation*}
$$

where $d_{K}(x)=\operatorname{dist}(x, K)$.
Proof. Step 1: Tangential estimates. Let $x \in \Omega$ such that $d(x) \leq \delta_{1}$. We denote by $\sigma(x)$ the projection of $x$ onto $\partial \Omega$, unique since $d(x) \leq \delta_{1}$. Let $r, r^{\prime}, \tau>0$ such that $\frac{3}{4} r<r^{\prime}<\frac{7}{8} r$ and $0<\tau \leq \frac{r^{\prime}}{2}$ and put $\omega_{\tau, x}=\sigma(x)+\tau \mathbf{n}_{\sigma(x)}$. Since $\partial \Omega$ is $C^{2}$, there exists $0<r^{*} \leq \delta_{1}$ depending on $\Omega$ such that $d_{K}\left(\omega_{\tau, x}\right)>\frac{7}{8} r$ whenever $d(x) \leq r^{*}$. Let $a>0$ and $b>0$ to be specified later on; we define $\tilde{v}(s)=a\left(r^{\prime}-s\right)^{\frac{q-p}{q+1-p}}-b$ and $v(y)=\tilde{v}\left(\left|y-\omega_{\tau, x}\right|\right)$ in $\left[0, r^{\prime}\right)$ and $B_{r^{\prime}}\left(\omega_{\tau, x}\right)$ respectively. Then

$$
\left|\tilde{v}^{\prime}\right|^{p-2}\left(\left|\tilde{v}^{\prime}\right|^{q+2-p}-(p-1) \tilde{v}^{\prime \prime}-\frac{N-1}{s} \tilde{v}^{\prime}\right)=a^{p-1}\left(\frac{p-q}{q+1-p}\right)^{p-1}\left(r^{\prime}-s\right)^{-\frac{q}{q+1-p}} X(s)
$$

where

$$
X(s)=\left(a \frac{p-q}{q+1-p}\right)^{q+1-p}-\frac{p-1}{q+1-p}-\frac{(N-1)\left(r^{\prime}-s\right)}{s} .
$$

For any $\tau \in\left(0, r^{\prime}\right)$ there exists $a>0$ such that

$$
\left(a \frac{p-q}{q+1-p}\right)^{q+1-p} \geq \frac{p-1}{q+1-p}+\frac{(N-1)\left(r^{\prime}-s\right)}{s} \quad \forall \tau \leq s \leq r^{\prime} .
$$

This implies

$$
\begin{equation*}
-\Delta_{p} v+|\nabla v|^{q} \geq 0 \quad \text { in } B_{r^{\prime}}\left(\omega_{\tau, x}\right) \backslash B_{\tau}\left(\omega_{\tau, x}\right) . \tag{2.35}
\end{equation*}
$$

Next we take $b=a\left(r^{\prime}-\tau\right)^{\frac{q-p}{q+1-p}}$, thus $v=0$ on $\partial B_{\tau}\left(\omega_{\tau, x}\right)$. Clearly $B_{\tau}\left(\omega_{\tau, x}\right) \subset \bar{\Omega}^{c}$ since $\tau<\delta_{1}$. Therefore $v \geq 0=u$ on $\partial \Omega \cap B_{r^{\prime}}\left(\omega_{\tau, x}\right)$ and $u \leq v=\infty$ on $\Omega \cap \partial B_{r^{\prime}}\left(\omega_{\tau, x}\right)$. By the comparison principle, $v \geq u$ in $\Omega \cap B_{r^{\prime}}\left(\omega_{\tau, x}\right)$. In particular

$$
u(x) \leq v(x) \leq a\left(r^{\prime}-\tau-d(x)\right)^{\frac{q-p}{q+1-p}}-a\left(r^{\prime}-\tau\right)^{\frac{q-p}{q+1-p}}
$$

We take now $\tau=\frac{r^{\prime}}{2}$ and $d(x) \leq \frac{r}{4}$ and we derive by the mean value theorem

$$
\begin{equation*}
u(x) \leq c_{4}^{\prime} r^{\prime-\frac{1}{q+1-p}} d(x)=c_{4}^{\prime} d(x)\left(d_{K}(x)\right)^{-\frac{1}{q+1-p}}, \tag{2.36}
\end{equation*}
$$

with $c_{4}^{\prime}=c_{4}^{\prime}(p, q)>0$ Letting $r^{\prime} \rightarrow \frac{7}{8} r$, we get (2.12).
Step 2: Global estimates. If $d(x) \geq \frac{1}{4} d_{K}(x)$, there holds

$$
d(x)\left(d_{K}(x)\right)^{-\frac{1}{q+1-p}} \geq 2^{-\frac{2}{q+1-p}}(d(x))^{\frac{q-p}{q+1-p}} .
$$

Combining this inequality with (2.6) and obtain (2.34).
Remark. Under the assumption of Proposition 2.8, it follows from the maximum principle that $u$ is upper bounded in the set $\Omega_{r^{*}}^{\prime}:=\left\{x \in \Omega: d(x)>r^{*}\right\}=\Omega \backslash \bar{\Omega}_{r^{*}}$ by the solution $w$ of

\begin{align*}
-\Delta_{p} w+|\nabla w|^{q} & =0 & & \text { in } \Omega_{r^{*}} \\
w & =c_{4} d(x)\left(d_{K}(x)\right)^{-\frac{1}{q+1-p}} & & \text { in } \partial \Omega_{r^{*}}, \tag{2.37}
\end{align*}
$$

and $w$ itself is bounded by $d^{*}=\max \left\{c d(x)\left(d_{K}(x)\right)^{-\frac{1}{q+1-p}}: d(x)=r^{*}\right\}$.
Next we prove a boundary Harnack inequality. We recall that $\delta_{1}$ has been introduced at Corollary 2.3, and that the interior and exterior sphere conditions hold in the set $\left\{x \in \mathbb{R}^{N}: d(x) \leq \delta_{1}\right\}$.

Theorem 2.9. Let $q>p-1$ and $0 \in \partial \Omega$. Then there exists $c_{5}=c_{5}(N, p, q, \Omega)>0$ such that for any positive solution $u \in C\left(\Omega \cup\left((\partial \Omega \backslash\{0\}) \cap B_{2 \delta_{1}}\right) \cap C^{1}(\Omega)\right.$ of (1.1) in $\Omega$, vanishing on $\left.\partial \Omega \backslash\{0\}\right) \cap B_{2 \delta_{1}}$, there holds

$$
\begin{equation*}
\frac{u(y)}{c_{5} d(y)} \leq \frac{u(x)}{d(x)} \leq c_{5} \frac{u(y)}{d(y)} \tag{2.38}
\end{equation*}
$$

for all $x, y \in B_{\frac{2 \delta_{1}}{3}} \cap \Omega$ such that $\frac{1}{2}|x| \leq|y| \leq 2|x|$.
For proving Theorem 2.9 we need some intermediate lemmas. First we recall the following result from [1].

Lemma 2.10. Assume that $a \in \partial \Omega, 0<r<\delta_{1}$ and $h>1$ is an integer. There exists an integer $N_{0}$, depending only on $\delta_{1}$, such that for any points $x$ and $y$ in $\Omega \cap B_{\frac{3 r}{2}}(a)$ verifying $\min \{d(x), d(y)\} \geq r / 2^{h}$, there exists a connected chain of balls $B_{1}, \ldots, B_{j}$ with $j \leq N_{0}$ h such that

\begin{align*}
& x \in B_{1}, y \in B_{j}, \quad B_{i} \cap B_{i+1} \neq \emptyset \text { for } 1 \leq i \leq j-1 \\
& \text { and } 2 B_{i} \subset B_{2 r}(Q) \cap \Omega \text { for } 1 \leq i \leq j . \tag{2.39}
\end{align*}
$$

The next result is a standard Harnack inequality.
Lemma 2.11. Assume $a \in(\partial \Omega \backslash\{0\}) \cap B_{\frac{2 \delta_{1}}{3}}$ and $0<r \leq|a| / 4$. Let $u \in C(\Omega \cup((\partial \Omega \backslash\{0\}) \cap$ $\left.\left.B_{2 \delta_{1}}\right)\right) \cap C^{1}(\Omega)$ be a positive solution of (1.1) vanishing on $(\partial \Omega \backslash\{0\}) \cap B_{2 \delta_{1}}$. Then there exists $a$ positive constant $c_{6}>1$ depending on $N, p, q$ and $\delta_{1}$ such that

u(x) \leq c_{6}^{h} u(y), \tag{2.40}
\end{equation*}
$$

for every $x, y \in B_{\frac{3 r}{2}}(a) \cap \Omega$ such that $\min \{d(x), d(y)\} \geq r / 2^{h}$ for some $h \in \mathbb{N}$.

Proof. For $\ell>0$, we define $T_{\ell}[u]$ by

and we notice that if $u$ satisfies (1.1) in $\Omega$, then $T_{\ell}[u]$ satisfies the same equation in $\Omega^{\ell}:=\ell^{-1} \Omega$. If we take in particular $\ell=|a|$, we can assume $|a|=1$, thus the curvature of the domain $\Omega^{|a|}$ remains bounded. By Proposition 2.8

where $c_{6}^{\prime}$ depends on $N, q, \delta_{1}$. Then we proceed as in [11], using Lemma 2.10 and internal Harnack inequality as quoted in [16, Corollary 10].

Since the solutions are Hölder continuous, the following statement holds as in [16, Theorem 4.2]:
Lemma 2.12. Let the assumptions on $a$ and $u$ of Lemma 2.11 be fulfilled. If $b \in \partial \Omega \cap B_{r}(a)$ and $0<s \leq 2^{-1} r$, there exist two positive constants $\delta$ and $c_{7}$ depending on $N, p, q$ and $\Omega$ such that

u(x) \leq c_{7} \frac{|x-b|^{\delta}}{s^{\delta}} \max \left\{u(z): z \in B_{r}(b) \cap \Omega\right\} \tag{2.43}
\end{equation*}
$$

for every $x \in B_{s}(b) \cap \Omega$.
As a consequence we derive the following Carleson type estimate.
Lemma 2.13. Assume $a \in(\partial \Omega \backslash\{0\}) \cap B_{\frac{2 \delta_{1}}{3}}$ and $0<r \leq|a| / 8$. Let $u \in C\left(\Omega \cup\left((\partial \Omega \backslash\{0\}) \cap B_{2 \delta_{1}}\right)\right) \cap$ $C^{2}(\Omega)$ be a positive solution of (1.1) vanishing on $(\partial \Omega \backslash\{0\}) \cap B_{2 \delta_{1}}$. Then there exists a constant $c_{8}$ depending only on $N, p$ and $q$ such that

u(x) \leq c_{8} u\left(a-\frac{r}{2} \mathbf{n}_{a}\right) \quad \forall x \in B_{r}(a) \cap \Omega \tag{2.44}
\end{equation*}
$$

Proof. By Lemma 2.11 it is clear that for any integer $h$ and $x \in B_{r}(a) \cap \Omega$ such that $d(x) \geq 2^{-h} r$, there holds

u(x) \leq c_{6}^{h} u\left(a-\frac{r}{2} \mathbf{n}_{a}\right) \tag{2.45}
\end{equation*}
$$

Therefore $u$ satisfies inequality (2.43) as any Hölder continuous function does. The proof that the constant is independent of $r$ and $u$ is more delicate. It is done in [1, Lemma 2.4] for linear equations, but it is based only on Lemma 2.12 and a geometric construction, thus it is also valid in our case.

Lemma 2.14. Assume $a \in(\partial \Omega \backslash\{0\}) \cap B_{\frac{2 \delta_{1}}{3}}$ and $0<r \leq|a| / 8$. Let $u \in C\left(\Omega \cup\left((\partial \Omega \backslash\{0\}) \cap B_{2 \delta_{1}}\right)\right) \cap$ $C^{2}(\Omega)$ be a positive solution of (1.1) vanishing on $(\partial \Omega \backslash\{0\}) \cap B_{2 \delta_{1}}$. Then there exist $\alpha \in(0,1 / 2)$ and $c_{9}>0$ depending on $N, p$ and $q$ such that

\begin{equation*}
\frac{1}{c_{9}} \frac{t}{r} \leq \frac{u\left(b-t \mathbf{n}_{b}\right)}{u\left(a-\frac{r}{2} \mathbf{n}_{a}\right)} \leq c_{9} \frac{t}{r} \tag{2.46}
\end{equation*}
$$

for any $b \in B_{r}(a) \cap \partial \Omega$ and $0 \leq t<\frac{\alpha}{2} r$.

Proof. It is similar to the one of [11, Lemma 3.15].
Proof of Theorem 2.9. Assume $x \in B_{\frac{2 \delta_{1}}{3}} \cap \Omega$ and set $r=\frac{|x|}{8}$.
Step 1: Tangential estimate: we suppose $d(x)<\frac{\alpha}{2} r$. Let $a \in \partial \Omega \backslash\{0\}$ such that $|a|=|x|$ and $x \in B_{r}(a)$. By Lemma 2.14,

\frac{8}{c_{9}} \frac{u\left(a-\frac{r}{2} \mathbf{n}_{a}\right)}{|x|} \leq \frac{u(x)}{d(x)} \leq 8 c_{9} \frac{u\left(a-\frac{r}{2} \mathbf{n}_{a}\right)}{|x|} . \tag{2.47}
\end{equation*}
$$

We can connect $a-\frac{r}{2} \mathbf{n}_{a}$ with $-2 r \mathbf{n}_{0}$ by $m_{1}$ (depending only on $N$ ) connected balls $B_{i}=B_{\frac{r}{4}}\left(x_{i}\right)$ with $x_{i} \in \Omega$ and $d\left(x_{i}\right) \geq \frac{r}{2}$ for every $1 \leq i \leq m_{1}$. It follows from (2.44) that

c_{6}^{-m_{1}} u\left(-2 r \mathbf{n}_{0}\right) \leq u\left(a-\frac{r}{2} \mathbf{n}_{a}\right) \leq c_{6}^{m_{1}} u\left(-2 r \mathbf{n}_{0}\right),
$$

which, together with (2.47) leads to

\end{equation*}
$$

with $c_{10}=8 c_{9} c_{6}^{m_{1}}$.
Step 2: Internal estimate: we suppose $d(x) \geq \frac{\alpha}{2} r$. We can connect $-2 r \mathbf{n}_{0}$ with $x$ by $m_{2}$ (depending only on $N$ ) connected balls $B_{i}^{\prime}=B \frac{\alpha r}{4}\left(x_{i}^{\prime}\right)$ with $x_{i}^{\prime} \in \Omega$ and $d\left(x_{i}^{\prime}\right) \geq \frac{\alpha}{2} r$ for every $1 \leq i \leq m_{2}$. By Harnack and Carleson inequalities (2.40) and (2.44) and since $\frac{\alpha}{4}|x|<d(x) \leq|x|$, we get

\frac{\alpha}{4 c_{6}^{\prime m_{2}}} \frac{u\left(-2 r \mathbf{n}_{0}\right)}{|x|} \leq \frac{u(x)}{d(x)} \leq \frac{4 c_{6}^{\prime m_{2}}}{\alpha} \frac{u\left(-2 r \mathbf{n}_{0}\right)}{|x|} . \tag{2.49}
\end{equation*}

Step 3: End of proof. Suppose $\frac{|x|}{2} \leq s \leq 2|x|$, we can connect $-2 r \mathbf{n}_{Q}$ with $-s \mathbf{n}_{Q}$ by $m_{3}$ (depending only on $N$ ) connected balls $B_{i}^{\prime \prime}=B_{\frac{r}{2}}\left(x_{i}^{\prime \prime}\right)$ with $x_{i}^{\prime \prime} \in \Omega$ and $d\left(x_{i}^{\prime \prime}\right) \geq r$ for every $1 \leq i \leq m_{3}$. This fact, jointly with (2.48) and (2.49), yields to

\frac{1}{c_{11}} \frac{u\left(-s \mathbf{n}_{0}\right)}{|x|} \leq \frac{u(x)}{d(x)} \leq c_{11} \frac{u\left(-s \mathbf{n}_{0}\right)}{|x|} \tag{2.50}

where $c_{11}=c_{11}(N, q, \Omega)$. Finally, if $y \in B_{\frac{2 r_{0}}{3}} \cap \Omega$ satisfies $\frac{|x|}{2} \leq|y| \leq 2|x|$, then by applying twice (2.50) we get (2.38) with $c_{5}=c_{11}^{2}$.

The following inequality is a consequence of Theorem 2.9.
Corollary 2.15. Assume $q>p-1$ and $0 \in \partial \Omega$. Then there exists $c_{12}>0$ depending on $p, q$ and $\Omega$ such that for any positive solutions $u_{1}, u_{2} \in C\left(\Omega \cup\left((\partial \Omega \backslash\{0\}) \cap B_{2 \delta_{1}}\right)\right) \cap C^{1}(\Omega)$ of (1.1) in $\Omega$, vanishing on $(\partial \Omega \backslash\{0\}) \cap B_{2 \delta_{1}}$, there holds

$$
\begin{equation*}
\sup \left\{\frac{u_{1}(y)}{u_{2}(y)}: y \in B_{r} \backslash B_{\frac{r}{2}}\right\} \leq c_{12} \inf \left\{\frac{u_{1}(y)}{u_{2}(y)}: y \in B_{r} \backslash B_{\frac{r}{2}}\right\} . \tag{2.51}
\end{equation*}
$$

## 3 Boundary singularities

### 3.1 Strongly singular solutions

In this section we consider the equation (1.1) in $\mathbb{R}_{+}^{N}$. We denote by $(r, \sigma) \in \mathbb{R}_{+} \times S^{N-1}$ the spherical coordinates in $\mathbb{R}^{N}$ and

S_{+}^{N-1}=\left\{\left(\sin \phi \sigma^{\prime}, \cos \phi\right): \sigma^{\prime} \in S^{N-2}, \phi \in\left[0, \frac{\pi}{2}\right)\right\} .

If $v(x)=r^{-\beta} \omega(\sigma)$ satisfies (1.1) in $\mathbb{R}_{+}^{N}$ and vanishes on $\partial \mathbb{R}_{+}^{N} \backslash\{0\}$, then $\beta=\beta_{q}$ and $\omega$ is a solution of

-d i v^{\prime}\left(\left(\beta_{q}^{2} \omega^{2}+\left|\nabla^{\prime} \omega\right|^{2}\right)^{\frac{p-2}{2}} \nabla^{\prime} \omega\right)- & \beta_{q} \Lambda_{\beta_{q}}\left(\beta_{q}^{2} \omega^{2}+\left|\nabla^{\prime} \omega\right|^{2}\right)^{\frac{p-2}{2}} \omega \\
+\left(\beta_{q}^{2} \omega^{2}+\left|\nabla^{\prime} \omega\right|^{2}\right)^{\frac{q}{2}} & =0  \tag{3.1}\\
\omega=0 & \text { in } S_{+}^{N-1} \\
\omega=0 & \text { on } \partial S_{+}^{N-1} .
\end{align*}
$$

where $\beta_{q}$ and $\Lambda_{\beta_{q}}$ have been defined in (1.10). We denote by $\left(\beta_{*}, \psi^{*}\right) \in \mathbb{R}_{+}^{*} \times C^{2}\left(\bar{S}_{+}^{N-1}\right)$ the unique couple such $\max \psi_{*}=1$ with the property that the function $(r, \sigma) \mapsto r^{-\beta_{*}} \psi^{*}(\sigma)$ is positive, $p$-harmonic in $\mathbb{R}_{+}^{N}$ and vanishes on $\partial \mathbb{R}_{+}^{N} \backslash\{0\}$. Then $\psi_{*}=\psi$ satisfies

\begin{array}{rll}
-d i v^{\prime}\left(\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p-2}{2}} \nabla^{\prime} \psi\right)-\beta_{*} \Lambda_{\beta_{*}}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p-2}{2}} \psi=0 & \text { in } S_{+}^{N-1}  \tag{3.2}\\
\psi=0 & \text { on } \partial S_{+}^{N-1}
\end{array}
$$

Since the function $\psi^{*}$ is unique it depends only on the azimuthal variable $\theta_{N-1}=\cos ^{-1}\left(\frac{x_{N}}{|x|}\right)$ (see Appendix II). Our first result is the following
Theorem 3.1. If $q \geq q_{*}$, or equivalently $\beta_{q} \leq \beta_{*}$, there exists no positive solution to problem (3.1).
Proof. Suppose such a solution $\omega$ exists and put $\theta=\beta_{q} / \beta_{*}$, then $0<\theta \leq 1$. Set $\eta=\psi^{\theta}$, where $\psi$ is a positive solution of (3.2), and define the operator $\mathcal{T}$ by

&+\left(\beta_{q}^{2} \eta^{2}+\left|\nabla^{\prime} \eta\right|^{2}\right)^{\frac{q}{2}} .
\end{align*}
$$

Since $\nabla \eta=\theta \psi^{\theta-1} \nabla \psi$,

\left(\beta_{q}^{2} \eta^{2}+\left|\nabla^{\prime} \eta\right|^{2}\right)^{\frac{p-2}{2}} & =\theta^{p-2} \psi^{(\theta-1)(p-2)}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p-2}{2}}, \\
\left(\beta_{q}^{2} \eta^{2}+\left|\nabla^{\prime} \eta\right|^{2}\right)^{\frac{p-2}{2}} \nabla^{\prime} \eta & =\theta^{p-1} \psi^{(\theta-1)(p-1)}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p-2}{2}} \nabla^{\prime} \psi,
\end{aligned}
$$

therefore

\mathcal{T}(\eta) & =-\theta^{p-1} \psi^{(\theta-1)(p-1)} \operatorname{div}^{\prime}\left(\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p-2}{2}} \nabla^{\prime} \psi\right) \\
& -\theta^{p-1}(\theta-1)(p-1) \psi^{(\theta-1)(p-1)-1}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p-2}{2}}\left|\nabla^{\prime} \psi\right|^{2} \\
& -\beta_{q} \Lambda_{\beta_{q}} \theta^{p-2} \psi^{(\theta-1)(p-1)}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p-2}{2}} \psi+\theta^{q} \psi^{(\theta-1) q}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{q}{2}} .
\end{aligned}

But $\beta_{q} \Lambda_{\beta_{q}} \theta^{p-2}=\beta_{*} \Lambda_{\beta_{q}} \theta^{p-1} \leq \beta_{*} \Lambda_{\beta_{*}} \theta^{p-1}$ since $\beta_{q} \leq \beta_{*}$. Using (3.2), we see that $\mathcal{T}(\eta) \geq 0$. Because Hopf Lemma is valid, there holds $\partial_{\mathbf{n}} \psi<0$ on $\partial S_{+}^{N-1}$. Since $\omega$ is $C^{1}$ in $\overline{S_{+}^{N-1}}$ and $\psi$ is defined up to an homothety, there exists a smallest function $\psi$ such that $\eta \geq \omega$, and the graphs of $\eta$ and $\omega$ over $\overline{S_{+}^{N-1}}$ are tangent, either at some $\alpha \in S_{+}^{N-1}$, or only at a point $\alpha \in \partial S_{+}^{N-1}$. We put $w=\eta-\omega$. Then

where $\Phi(t)=\mathcal{T}\left(\omega_{t}\right)$ with $\omega_{t}=\omega+t w$.
We use local coordinates $\left(\sigma_{1}, \ldots, \sigma_{N-1}\right)$ on $S^{N-1}$ near $\alpha$. We denote by $g=\left(g_{i j}\right)$ the metric tensor on $S^{N-1}$ and by $g^{j k}$ its contravariant components. Then, for any $\varphi \in C^{1}\left(S^{N-1}\right)$,

If $X=\left(X^{1}, \ldots X^{d}\right) \in C^{1}\left(T S^{N-1}\right)$ is a vector field, we lower indices by setting $X^{\ell}=\sum_{i} g^{\ell i} X_{i}$ and define the divergence of $X$ by

d i v_{g}^{\prime} X=\frac{1}{\sqrt{|g|}} \sum_{\ell} \frac{\partial}{\partial \sigma_{\ell}}\left(\sqrt{|g|} X^{\ell}\right)=\frac{1}{\sqrt{|g|}} \sum_{\ell, i} \frac{\partial}{\partial \sigma_{\ell}}\left(\sqrt{|g|} g^{\ell i} X_{i}\right) .

We write $\Phi(t)=\Phi_{1}(t)+\Phi_{2}(t)+\Phi_{3}(t)$ where

$$

where

\begin{gathered}
b=\beta_{q} \Lambda_{\beta_{q}}\left(\beta_{q}^{2} \omega_{t}^{2}+\left|\nabla \omega_{t}\right|^{2}\right)^{\frac{p}{2}-2}\left((p-1) \beta_{q}^{2} \omega_{t}^{2}+\left|\nabla \omega_{t}\right|^{2}\right), \\
a_{j}=(p-2) \beta_{q} \Lambda_{\beta_{q}}\left(\beta_{q}^{2} \omega_{t}^{2}+\left|\nabla \omega_{t}\right|^{2}\right)^{\frac{p}{2}-2} \omega_{t} \sum_{k} g^{j k} \frac{\partial \omega_{t}}{\partial \sigma_{k}}, \\
d=q \beta_{q}^{2}\left(\beta^{2} \omega_{t}^{2}+\left|\nabla \omega_{t}\right|^{2}\right)^{\frac{q}{2}-1} \omega_{t},
\end{gathered}
$$

and

c_{j}=q\left(\beta_{q}^{2} \omega_{t}^{2}+\left|\nabla \omega_{t}\right|^{2}\right)^{\frac{q}{2}-1} \sum_{k} g^{j k} \frac{\partial \omega_{t}}{\partial \sigma_{k}} .

\Phi_{3}(1)-\Phi_{3}(0) & =-(p-2) \operatorname{div}^{\prime}\left(\left(\beta_{q}^{2} \omega_{t}^{2}+\left|\nabla^{\prime} \omega_{t}\right|^{2}\right)^{\frac{p-4}{2}}\left(\beta_{q}^{2} \omega_{t} w+\left\langle\nabla^{\prime} \omega_{t}, \nabla^{\prime} w\right\rangle_{g}\right) \nabla^{\prime} \omega_{t}\right) \\
& -\operatorname{div}^{\prime}\left(\left(\beta_{q}^{2} \omega_{t}^{2}+\left|\nabla^{\prime} \omega_{t}\right|^{2}\right)^{\frac{p-2}{2}} \nabla^{\prime} w\right)
\end{aligned}

Therefore we can write $\Phi(1)-\Phi(0)$ under the form

& \geq\left(\beta_{q}^{2} \omega_{t}^{2}+\left|\nabla^{\prime} \omega_{t}\right|^{2}\right)^{\frac{p-4}{2}} \min \{1, p-1\}\left|\nabla^{\prime} \omega_{t}\right|^{2}|X|^{2}
\end{align*}
$$

and $B$ and $C$ can be computed from the previous expressions. It is important to notice that $\beta_{q}^{2} \omega_{t}^{2}+\left|\nabla^{\prime} \omega_{t}\right|^{2}$ is bounded between two positive constants $m_{1}$ and $m_{2}$ in $\overline{S_{+}^{N-1}}$. Thus the operator $\mathcal{L}$ is uniformly elliptic with bounded coefficients. Since $w$ is nonnegative and either at some point $\alpha, \nabla^{\prime} w(\alpha)=0$ and $w(\alpha)>0$, or at some boundary point $\alpha$ where $w(\alpha)=0$ and $\partial_{\mathbf{n}} w(\alpha)<0$, it follows from the strong maximum principle or Hopf Lemma (see [7]) that $w=0$, contradiction.

Theorem 3.2. Assume $q<q_{*}$ or equivalently $\beta_{q}>\beta_{*}$. There exists a unique positive solution $\omega_{*}$ to problem (3.1).

Proof. Existence. It will follow from [4]. Indeed problem (3.1) can be written under the form

& \mathbf{B}(r, \xi)=\beta_{q} \Lambda_{\beta_{q}}\left(\beta_{q}^{2} r^{2}+|\xi|^{2}\right)^{\frac{p-2}{2}} r-\left(\beta_{q}^{2} r^{2}+|\xi|^{2}\right)^{\frac{q}{2}}
\end{align*}
$$

The operator $\mathbf{A}$ is a Leray-Lions operator which satisfies the assumptions (1.6)-(1.8) of [4, Theorem 2.1], and the term $\mathbf{B}$ satisfies (1.9),(1.10) in the same article. Therefore the existence of a positive solution $\omega \in W_{0}^{1, p}\left(S_{+}^{N-1}\right) \cap L^{\infty}\left(S_{+}^{N-1}\right)$ is ensured whenever we can find a supersolution $\bar{\omega} \in W^{1, p}\left(S_{+}^{N-1}\right) \cap$ $L^{\infty}\left(S_{+}^{N-1}\right)$ and a nontrivial subsolution $\underline{\omega} \in W^{1, p}\left(S_{+}^{N-1}\right)$ of $(3.7)$ such that

\end{equation*}

First we note that $\eta=\eta_{0}$ is a supersolution if the positive constant $\eta_{0}$ is large enough. In order to find a subsolution, we set again $\eta=\psi^{\theta}$ with $\theta=\beta_{q} / \beta_{*}$ and $\psi$ as in (3.2). Now $\theta>1$, thus $\eta \in W_{0}^{1, p}\left(S_{+}^{N-1}\right)$. As above we have

& -\beta_{q} \Lambda_{\beta_{q}} \theta^{p-2} \psi^{(\theta-1)(p-1)}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p-2}{2}} \psi+\theta^{q} \psi^{(\theta-1) q}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{q}{2}}
\end{aligned}
$$

$\operatorname{Now} \beta_{q} \Lambda_{\beta_{q}} \theta^{p-2}=\beta_{*} \Lambda_{\beta_{q}} \theta^{p-1}=\beta_{*}\left(\Lambda_{\beta_{q}}-\Lambda_{\beta_{*}}\right) \theta^{p-1}+\beta_{*} \Lambda_{\beta_{*}} \theta^{p-1}$ and $\Lambda_{\beta_{q}}-\Lambda_{\beta_{*}}=\left(\beta_{q}-\beta_{*}\right)(p-1)=$ $\beta_{*}(p-1)(\theta-1)$, hence

& -\theta^{p-1}(\theta-1)(p-1) \psi^{(\theta-1)(p-1)-1}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p-2}{2}}\left|\nabla^{\prime} \psi\right|^{2} \\
& -\beta_{*}\left(\Lambda_{\beta_{q}}-\Lambda_{\beta_{*}}\right) \theta^{p-1} \psi^{(\theta-1)(p-1)}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p-2}{2}} \psi \\
& -\beta_{*} \Lambda_{\beta_{*}} \theta^{p-1} \psi^{(\theta-1)(p-1)}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p-2}{2}} \psi+\theta^{q} \psi^{(\theta-1) q}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{q}{2}} .
\end{aligned}

Using the equation satisfied by $\psi$ yields to the relation

& -\beta_{*}^{2}(p-1)(\theta-1) \theta^{p-1} \psi^{(\theta-1)(p-1)-1}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p-2}{2}} \psi^{2} \\
& +\theta^{q} \psi^{(\theta-1) q}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{q}{2}} \\
= & -\theta^{p-1}(\theta-1)(p-1) \psi^{(\theta-1)(p-1)-1}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p}{2}} \\
& +\theta^{q} \psi^{(\theta-1) q}\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{q}{2}} .
\end{aligned}
$$

If we replace $\eta:=\eta_{1}=\psi^{\theta}$ by $\eta:=\eta_{m}=(m \psi)^{\theta}$ in the above computation, the inequality $\left.\mathcal{T} \eta_{m}\right) \leq 0$ will be true provided

m^{\theta(q+1-p)} \psi^{(\theta-1)(q+1-p)+1} \leq \theta^{p-1-q}(\theta-1)(p-1)\left(\beta_{*}^{2} \psi^{2}+\left|\nabla^{\prime} \psi\right|^{2}\right)^{\frac{p-q}{2}},

which is satisfied if we choose $m$ small enough so that $(m \psi)^{\theta} \leq \eta_{0}$ and satisfying

Therefore $0<\eta_{m} \leq \eta_{0}$ and standard regularity implies that the solution $\omega$ is $C^{1}$ in $\bar{S}_{+}^{N-1}$. Actually $\omega$ is $C^{\infty}$ since the operator is not degenerate.
Uniqueness. We use the tangency method developed in the proof of Theorem 3.1. Assume $\omega_{1}$ and $\omega_{2}$ are two positive solutions of (3.2), then they are positive in $S_{+}^{N-1}$ and $\partial_{\mathbf{n}} \omega_{i}<0$ on $\partial S_{+}^{N-1}$. Either the $\omega_{i}$ are ordered and $\omega_{1} \leq \omega_{2}$, or their graphs intersect. In any case we can define

\tau=\inf \left\{s>1: s \omega_{1} \geq \omega_{2}\right\} .
$$

We set $\omega^{*}=\tau \omega_{1}$. Then either the graphs of $\omega_{2}$ and $\omega^{*}$ are tangent at some interior point $\alpha$, or they are not tangent in $S_{+}^{N-1}, \partial_{\mathbf{n}} \omega^{*} \leq \partial_{\mathbf{n}} \omega_{2}<0$ on $\partial S_{+}^{N-1}$ and there exists $\alpha \in \partial S_{+}^{N-1}$ such that $\partial_{\mathbf{n}} \omega^{*}(\alpha)=$ $\partial_{\mathbf{n}} \omega_{2}(\alpha)<0$. Furthermore $\mathcal{T}\left(\omega^{*}\right) \geq 0$. If we set $w=\omega^{*}-\omega_{2}$, then, as in Theorem 3.1,

\langle\tilde{A} X, X\rangle_{g} & \left.=\left(\beta_{q}^{2} \omega_{t}^{2}+\left|\nabla^{\prime} \omega_{t}\right|^{2}\right)^{\frac{p-4}{2}}(p-2)\left\langle\nabla^{\prime} \omega_{t}, X\right\rangle_{g}^{2}+\left|\nabla^{\prime} \omega_{t}\right|^{2}|X|^{2}\right) \\
& \geq\left(\beta_{q}^{2} \omega_{t}^{2}+\left|\nabla^{\prime} \omega_{t}\right|^{2}\right)^{\frac{p-4}{2}} \min \{1, p-1\}\left|\nabla^{\prime} \omega_{t}\right|^{2}|X|^{2}, \tag{3.10}
\end{align*}
$$

in which $\omega_{t}=\omega_{2}+t\left(\omega^{*}-\omega_{2}\right)$ and $t \in(0,1)$ is obtained by applying the mean value theorem and $\tilde{B}$ and $\tilde{C}$ are defined accordingly. Since $\tilde{\mathcal{L}}$ is uniformly elliptic and has bounded coefficients, it follows from the strong maximum principle that $w=0$. Thus $\omega^{*}=\tau \omega_{1}=\omega_{2}$ and $\tau=1$ from the equation. This ends the proof.

### 3.2 Removable boundary singularities

The following is the basic result for removability of isolated singularities. It is valid in the general case, but with a local geometric constraint.

Theorem 3.3. Assume $q^{*} \leq q<p \leq N, \Omega$ is a $C^{2}$ bounded domain with $0 \in \partial \Omega$, such that $\Omega \cap B_{\delta}=$ $B_{\delta}^{+}$for some $\delta>0$. If $u \in C^{1}(\bar{\Omega} \backslash\{0\})$ is a nonnegative solution of (1.1) in $\Omega$ which vanishes on $\partial \Omega \backslash\{0\}$, then it is identically 0 .

Proof. Step 1: Assume $\Omega \subset \mathbb{R}_{+}^{N}$. For $\epsilon>0$, we set $\Omega_{\epsilon}^{\prime}=\Omega \cap \overline{B_{\epsilon}^{c}}$ and $H_{\epsilon}=\mathbb{R}_{+}^{N} \cap \overline{B_{\epsilon}^{c}}$. For $k, n \in \mathbb{N}_{*}$, $n \geq \operatorname{diam}(\Omega)$, we denote by $v_{k, n, \epsilon}\left(n \in \mathbb{N}_{*}\right)$ the solution of the problem

v & =k \chi_{\mathbb{R}_{+}^{N} \cap \partial B_{\epsilon}} & & \text { on } \partial\left(H_{\epsilon} \cap B_{n}\right) . \tag{3.11}
\end{align*}
$$

If $k>c_{2} \epsilon^{\frac{q-p}{q+1-p}}$ for a suitable $c_{2}=c_{2}(p, q)>0$ (see Lemma 2.6), then $v_{k, n, \epsilon} \geq u$ in $\Omega_{\epsilon}^{\prime}$. Moreover there holds $v_{k, n, \epsilon} \leq v_{k^{\prime}, n^{\prime}, \epsilon}$ for $n \leq n^{\prime}$ and $k \leq k^{\prime}$. Furthermore the function

U_{\epsilon, n}(x)=c_{2}\left((|x|-\epsilon)^{\frac{q-p}{q+1-p}}-(n-\epsilon)^{\frac{q-p}{q+1-p}}\right)
$$

is a supersolution in $B_{n} \backslash B_{\epsilon}$, and there holds $v_{k, n, \epsilon} \leq U_{\epsilon, n}$. By monotonicity and standard a priori estimate, we obtain that $v_{k, n, \epsilon} \rightarrow v_{\epsilon}$ when $n, k \rightarrow \infty$ and that the function $v=v_{\epsilon}$ is solution of

Furthermore

u(x) \leq v_{\epsilon}(x) \leq c_{2}\left(|x|-\epsilon \epsilon^{\frac{q-p}{q+1-p}} \quad \text { in } \Omega_{\epsilon}^{\prime} .\right. \tag{3.13}
\end{equation*}
$$

The function $v_{\epsilon}$ may not be unique, however it is the minimal solution of the above problem since the $v_{k, n, \epsilon}$ is unique, and monotonicity in $n$ and $k$ holds. Actually, $v_{\epsilon} \leq v_{\epsilon^{\prime}}$ if $0 \leq \epsilon \leq \epsilon^{\prime}$. For $\ell>0$, we recall that the transformation $v \mapsto T_{\ell}[v]$ defined by (2.41) leaves equation (1.1) invariant. As a consequence of the uniqueness of the approximations we have $T_{\ell}\left[v_{k, n, \epsilon}\right]=v_{\ell^{\frac{p-q}{q+1}-p}}^{k, \ell^{-1}}{ }_{n, \ell^{-1} \epsilon^{\prime}}$, which implies

T_{\ell}\left[v_{\epsilon}\right]=v_{\ell^{-1}{ }_{\epsilon}} . \tag{3.14}

Letting $\epsilon \rightarrow 0$, we derive from the monotonicity with respect to $\epsilon$ and standard $C^{1, \alpha}$ estimates, that the following identity holds:

The function $v_{0}$ is a positive and separable solution of $(1.1)$ in $\mathbb{R}_{+}^{N}$ which vanishes on $\partial \Omega \backslash\{0\}$. It follows from Theorem 3.1 that $v_{0}=0$, and so is $u$.
Step 2: The general case. We assume that $\Omega \cap B_{\delta} \subset \mathbb{R}_{+}^{N}$ and we denote by $M$ the maximum of $u$ on $\partial B_{\delta} \cap \Omega$. Then the function $(u-M)_{+}$is a subsolution of $(1.1)$ in $\Omega \cap B_{\delta}$ which vanishes on $\partial \Omega \cap B_{\delta} \backslash\{0\}$. By Step 1, it is dominated by $v_{0}$, which ends the proof.
Remark. The previous result is valid if $u$ is a subsolution with the same regularity. If $u$ is no longer assumed to be nonnegative, only $u^{+}$vanishes. Furthermore, the regularity of the boundary has not been used, but only the fact that $\Omega$ is locally contained into a half space to the boundary of which 0 belongs.
Remark. If no geometric assumption is made on $\partial \Omega$, we can prove that $u(x)=o\left(|x|^{-\beta_{q}}\right)$ near 0 . The next result shows that the removability holds if $q>q_{*}$.

Theorem 3.4. Assume $q^{*}<q<p \leq N$ and $\Omega$ is a $C^{2}$ bounded domain with $0 \in \partial \Omega$. If $u$ is a nonnegative solution of (1.1) in $\Omega$ which belongs to $C^{1}(\bar{\Omega} \backslash\{0\})$ and vanishes on $\partial \Omega \backslash\{0\}$, it is identically 0.

Proof. As it is proved in [12], for any smooth subdomain $S \subset S^{N-1}$, there exists a unique $\beta_{* s}>0$ and $\psi_{s}^{*}>0$, unique up to an homothety, such that $x \mapsto|x|^{-\beta_{* s}} \psi_{s}^{*}\left(|x|^{-1} x\right)$ is $p$ harmonic in the cone $C_{S}=\left\{x \in \mathbb{R}^{N} \backslash\{0\}:|x|^{-1} x \in S\right\}$ and $\psi_{s}^{*}$ satisfies

$$
\begin{array}{rc}
-d i v^{\prime}\left(\left(\beta_{* s}^{2} \psi_{s}^{* 2}+\left|\nabla^{\prime} \psi_{s}^{*}\right|^{2}\right)^{\frac{p-2}{2}} \nabla^{\prime} \psi_{s}^{*}\right)-\beta_{* s} \Lambda_{\beta_{* s}}\left(\beta_{* s}^{2} \psi^{* 2}+\left|\nabla^{\prime} \psi_{s}^{*}\right|^{2}\right)^{\frac{p-2}{2}} \psi_{s}^{*}=0 & \text { in } S \\
\psi_{s}^{*}=0 & \text { on } \partial S \tag{3.16}
\end{array}
$$

Furthermore $S \subset \tilde{S} \subset S^{N-1}$ implies $\beta_{* \tilde{s}} \leq \beta_{* s}$. Using the system of spherical coordinates defined in (6.5) in Appendix II, for $\epsilon>0$ we denote by $S:=S_{\epsilon}$ the spherical shell with vertex the north pole $N$ and latitude angle $\theta_{N-1} \in\left[0, \frac{\pi}{2}+\epsilon\right]$. Because of uniqueness of $\beta_{* s}, \beta_{* s_{\epsilon}} \uparrow \beta_{*}$ as $\epsilon \rightarrow 0$. Therefore, if $q>q_{*}$, or equivalently $\beta_{q}<\beta_{*}$, there exists $\delta, \epsilon>0$ such that $\Omega \cap B_{\delta} \subset C_{S_{\epsilon}} \cap B_{\delta}$ and $\beta_{q}<\beta_{* s_{\epsilon}}$. Since Theorem 3.1 is valid if $S_{+}^{N-1}$ is replaced by $S_{\epsilon}$ and $\beta_{q}<\beta_{* s_{\epsilon}}$ it follows that $u=0$ as in the proof of Theorem 3.3, Steps 1 and 2.

The next result, valid in the case $p=N$, is based upon the conformal invariance of the N -Laplacian. In this case the exponent $\beta_{*}$ corresponding to the first spherical N -harmonic eigenvalue is equal to 1 and the corresponding spherical N -harmonic eigenfunction in $S_{+}^{N-1}$ is $x_{N} /|x|^{2}$.

Theorem 3.5. Assume $N-\frac{1}{2} \leq q<N, \Omega$ is a bounded domain and $0 \in \partial \Omega$ is such that there exists $a$ ball $B \subset \Omega^{c}$ to the boundary of which 0 belongs. If $u$ is a nonnegative solution of

-\Delta_{N} u+|\nabla u|^{q}=0 \quad \text { in } \Omega \tag{3.17}
\end{equation*}
$$

which belongs to $C(\bar{\Omega} \backslash\{0\}) \cap W_{0}^{1, N}\left(\Omega \backslash \bar{B}_{\epsilon}(0)\right)$ for any $\epsilon>0$, it is identically 0 .

Proof. We assume that the inward normal unit vector to $\partial \Omega$ at 0 is $\mathbf{e}_{N}=(0,0, \ldots, 1)$ and that the ball $B=B_{\frac{1}{2}}(a)$ of center $a=-\frac{1}{2} \mathbf{e}_{N}$ and radius $\frac{1}{2}$ touches $\partial \Omega$ at 0 and is exterior to $\Omega$ (this can be assumed up to a rotation and a dilation). This is the consequence of the exterior sphere condition at the point 0 . It is always valid if $\partial \Omega$ is $C^{2}$. We denote by $\mathcal{I}_{\omega}$ the inversion of center $\omega=-\mathbf{e}_{N}$ and power 1, i.e. $\mathcal{I}_{\omega}(x)=\omega+\frac{x-\omega}{|x-\omega|^{2}}$. Under this transformation, the complement of the ball $B_{\frac{1}{2}}(a)$, which contains $\Omega$, is transformed into the half space $\mathbb{R}_{-}^{N}$ which contains the image $\tilde{\Omega}$ of $\Omega$. Since $u$ satisfies (3.17), $\tilde{u}=u \circ \mathcal{I}_{\omega}$ satisfies

$$
\begin{equation*}
-\Delta_{N} \tilde{u}+|x-\omega|^{2(q-N)}|\nabla \tilde{u}|^{q}=0 \quad \text { in } \tilde{\Omega} . \tag{3.18}
\end{equation*}
$$

Furthermore since $0=\mathcal{I}_{\omega}(0)$ and $\mathcal{I}_{\omega}$ is a diffeomorphism, $\tilde{u} \in C(\overline{\tilde{\Omega}} \backslash\{0\}) \cap C^{1}(\tilde{\Omega})$ and it vanishes on $\partial \tilde{\Omega} \backslash\{0\}$. Since $|x-\omega| \leq 1$ and $q<N, \tilde{u}$ is a subsolution for (3.17) in $\tilde{G}$. By Theorem 3.4, $\tilde{u}=0$.

### 3.3 Weakly singular solutions

The main result of this section is the following existence and uniqueness result concerning solutions of (1.1) with a boundary weak singularity. We recall that $\psi_{*}$ is unique positive solution of (1.11) such that $\sup \psi_{*}=1$. Our first result is valid for any $1<p \leq N$ but it needs a geometric constraint on $\Omega$.

Theorem 3.6. Let $p-1<q<q_{*}<p \leq N$ and $\Omega \subset \mathbb{R}_{+}^{N}$ be a bounded $C^{2}$ domain such that $0 \in \partial \Omega$. Assume that there exists $\delta>0$ such that $\Omega_{\delta}:=\Omega \cap B_{\delta}=B_{\delta}^{+}$. Then for any $k>0$ there exists a unique positive solution $u:=u_{k}$ of (1.1) in $\Omega$, which belongs to $C^{1}(\bar{\Omega} \backslash\{0\})$, vanishes on $\partial \Omega \backslash\{0\}$ and satisfies

\lim _{x \rightarrow 0} \frac{u_{k}(x)}{\Psi_{*}(x)}=k \tag{3.19}
\end{equation*}
$$

in the $C^{1}$-topology of $S_{+}^{N-1}$, where

\Psi_{*}(x)=|x|^{-\beta_{*}} \psi_{*}\left(|x|^{-1} x\right) .
$$

The proof of this theorem is long and difficult and requires a certain number of intermediate results.
Lemma 3.7. Let the assumptions on $p, q$ and $\Omega$ of Theorem 3.6 be satisfied. There exists a unique positive $p$-harmonic function $\Phi_{*}$ in $\Omega$, which is continuous in $\bar{\Omega} \backslash\{0\}$, vanishes on $\partial \Omega \backslash\{0\}$ and satisfies

Proof. For $0<\epsilon<\delta$ let $v_{\epsilon}$ be the unique nonnegative $p$-harmonic function in $\Omega \backslash \overline{B_{\epsilon}^{+}}$which is continuous in $\bar{\Omega} \backslash B_{\epsilon}^{+}$, vanishes on $\partial \Omega \backslash B_{\epsilon}$ and achieves the value $\Psi_{*}$ on $\partial B_{\epsilon} \cap \Omega$. Since $\Omega \subset \mathbb{R}_{+}^{N}, v_{\epsilon} \leq \Psi_{*}$ in $\Omega \backslash B_{\epsilon}^{+}$. Hence inequalities $0<\epsilon<\epsilon^{\prime} \leq \delta$ imply $v_{\epsilon} \leq v_{\epsilon^{\prime}}$ in $\Omega \backslash \overline{B_{\epsilon^{\prime}}^{+}}$. Because $\Psi_{*} \leq \delta^{-\beta_{*}}$, there holds

in $\Omega \backslash B_{\delta}^{+}$. Since $v_{\epsilon}$ and $\Psi_{*}$ coincide on $\partial B_{\epsilon}^{+}$and vanish on $\partial \mathbb{R}_{+}^{N} \cap\left(B_{\delta}^{+} \backslash B_{\epsilon}^{+}\right)$, (3.21) holds also in $B_{\delta}^{+} \backslash B_{\epsilon}^{+}$. Because $v_{\epsilon} \geq 0$ there holds

By a standard regularity result $v_{\epsilon}$ converges to a function $\Phi_{*}$ continuous in $\bar{\Omega} \backslash\{0\}$, $p$-harmonic in $\Omega$ such that

in $\Omega$. Therefore (3.20) holds provided $\frac{x}{|x|}$ remains in a compact subset of $S_{+}^{N-1}$. Let us define a function $\tilde{\phi}_{*}$ by $\tilde{\phi}_{*}(x)=|x|^{\beta_{*}} \Phi_{*}(x)$, then $\tilde{\phi}_{*}(r, \sigma) \leq \psi_{*}(\sigma)$ where $r=|x|$ and $\sigma=\frac{x}{|x|} \in S_{+}^{N-1}$. By standard $C^{1, \alpha}$ estimates, $\tilde{\phi}_{*}(r,$.$) is relatively compact in the C\left(\overline{S_{+}^{N-1}}\right)$-topology. Therefore the convergence of $\frac{\Phi_{*}(x)}{\Psi_{*}(x)}$ to 1 when $x$ to 0 holds not only when $\frac{x}{|x|}$ remains in a compact subset of $S_{+}^{N-1}$, but uniformly on $S_{+}^{N-1}$, which implies (3.20). Uniqueness follows classically by (3.20) and the maximum principle.

Lemma 3.8. Let the assumptions on $p, q$ and $\Omega$ of Theorem 3.6 be satisfied. If for some $k>0$ there exists a solution $u_{k}$ of (1.1) in $\Omega$, which belongs to $C^{1}(\bar{\Omega} \backslash\{0\})$, vanishes on $\partial \Omega \backslash\{0\}$ and satisfies (3.19), then for any $k>0$ there exists such a solution.

Proof. We notice that for any $c<1$ (resp $c>1$ ), $c u_{k}$ is a subsolution (resp. supersolution) of (1.1) in $\Omega$. Let $\Phi_{*}$ be as in Lemma 3.7. If $c<1$, the function $c k \Phi_{*}$ is a supersolution of (1.1) which vanishes on $\partial \Omega \backslash\{0\}$. Furthermore

Then there exists a solution $u_{c k}$ of (1.1) in $\Omega$ which satisfies $c u_{k} \leq u_{c k} \leq c k \Phi_{*}$. If $c>1$, we set $u^{*}:=T_{c^{\theta}}\left[u_{k}\right]$, which means $u^{*}(x)=c^{\beta_{q} \theta} u_{k}\left(c^{\theta} x\right)$ with $\theta=\left(\beta_{q}-\beta_{*}\right)^{-1}$. Then $u^{*}$ is a solution of (1.1) in $\Omega^{c^{\theta}}=\frac{1}{c^{\theta}} \Omega$. In particular, $u^{*}$ satisfies the equation in $B_{\frac{\delta}{c^{\theta}}}^{+}(0)$. Since $c^{\theta}>1, B_{\frac{\delta}{c^{\theta}}}^{+}(0) \subset B_{\delta}^{+}(0)$. Put $m=\max \left\{u^{*}: x \in \partial B_{\frac{\delta}{c^{\theta}}}^{+}(0)\right\}$. The function $\left(u^{*}-m\right)_{+}$, extended by 0 outside $B_{\frac{\delta}{c^{\theta}}}^{c^{\circ}}(0)$, is a subsolution of (1.1) in $\Omega$. Furthermore it satisfies

uniformly on any compact subset of $S_{+}^{N-1}$. Therefore there exists a solution $u_{c k}$ of (1.1) in $\Omega$ which satisfies $\left(u^{*}-m\right)_{+} \leq u_{c k} \leq c k \Phi_{*}$, and in particular it vanishes on $\partial \Omega \backslash\{0\}$ and belongs to $C^{1}(\bar{\Omega} \backslash\{0\})$. By [13], $u_{c k}$ is positive in $\Omega$. Thus $u_{c k}$ belongs to $C^{1, \alpha}\left(\overline{B_{\delta}^{+}}(0) \backslash\{0\}\right)$ and satisfies

by (2.11). Therefore the set of functions $\left\{r^{\beta_{*}+1} \nabla u_{c k}(r, .)\right\}_{r>0}$ is uniformly relatively compact in the topology of uniform convergence on $\bar{S}_{+}^{N-1}$. Since it converges to $c k \nabla^{\prime} \psi_{*}$ uniformly on compact subsets of $S_{+}^{N-1}$ as $r \rightarrow 0$, this convergence holds in $C\left(\overline{S_{+}^{N-1}}\right)$. This implies

Under the assumptions of Theorem 3.6 there exists a real number $R_{0}$ such that $0<R_{0} \leq \delta$ and a positive subsolution $\tilde{u}$ of (1.1) in $B_{R_{0}}^{+}$which is Lipschitz continuous in $\overline{B_{R_{0}}^{+}} \backslash\{0\}$, vanishes on $\overline{B_{R_{0}}^{+}} \cap \partial \mathbb{R}_{+}^{N} \backslash\{0\}$, is smaller than $\Psi_{*}$ and satisfies

Proof. The construction of the function $\tilde{u}$. We look for a subsolution under the form $\tilde{u}=\Psi_{*}-w$ for a suitable nonnegative function $w$.
Step 1: reduction of the problem. We use spherical coordinates for a $C^{1}$ function $u: x \mapsto u(x)=$ $u(r, \sigma), r=|x|, \sigma=\frac{x}{|x|}$. Then $\nabla u=u_{r} \mathbf{e}+r^{-1} \nabla^{\prime} u$ where $\mathbf{e}=|x|^{-1} x,|\nabla u|^{2}=u_{r}^{2}+r^{-2}\left|\nabla^{\prime} u\right|^{2}$ and $|\nabla u|^{q}=\left(u_{r}^{2}+r^{-2}\left|\nabla^{\prime} u\right|^{2}\right)^{\frac{q}{2}}$. The function $\hat{\Psi}=-\Psi$ which is $N$-harmonic in $\mathbb{R}_{+}^{N}$ and vanishes on $\partial \mathbb{R}_{+}^{N} \backslash\{0\}$ is transformed by the inversion $\mathcal{I}_{\omega}$ of center $\omega$ and power 1 into the function $\Psi_{\omega}=\hat{\Psi} \circ \mathcal{I}_{\omega}$ which is positive and $N$-harmonic in $B_{\frac{1}{2}}^{c}(a)$ and vanishes on $\partial B_{\frac{1}{2}}(a) \backslash\{0\}$. For $\epsilon>0$ we denote by $\Phi_{\epsilon}$ the solution of

\end{equation*}
$$

which vanishes on $\partial B_{2}^{-} \backslash\{0\}$ and satisfies

$$
\begin{equation*}
\lim _{\substack{x \rightarrow 0 \\ x /|x| \rightarrow \sigma}}|x| w(x)=\sigma \tag{3.64}
\end{equation*}
$$

in the $C^{1}$-topology of $S_{-}^{N-1}$. Its existence follows from Theorem 3.6 and this function is dominated by the N -harmonic function $\Phi_{*}$ corresponding to this domain, obtained in Lemma 3.11. By $\mathcal{I}_{\omega^{\prime}}$, the half-ball $B_{2}^{-}$is transform into the lunule $G=B_{\frac{1}{2}}\left(a^{\prime}\right) \backslash B_{\frac{2}{3}}\left(\frac{4}{3} \omega^{\prime}\right)$ and $\tilde{w}=w \circ \mathcal{I}_{\omega^{\prime}}$ satisfies

-\Delta_{N} \tilde{w}+\left|x-\omega^{\prime}\right|^{2(q-N)}|\nabla \tilde{w}|^{q}=0 \quad \text { in } G \tag{3.65}
\end{equation*}
$$

Since $\left|x-\omega^{\prime}\right| \leq 1$ in $G,-\Delta_{N} \tilde{w}+|\nabla \tilde{w}|^{q} \leq 0$ in $G$. We extend $\tilde{w}$ by 0 in $\Omega \backslash G$ and the resulting function $\tilde{u}$ is a subsolution of (3.17) in $\Omega$ which vanishes on $\partial \Omega \backslash\{0\}$ ), is smaller than the N-harmonic function $\Phi_{*}$ obtained in Lemma 3.11, and satisfies (3.62).

## 4 Classification of boundary singularities

We assume that $\Omega \subset \mathbb{R}^{N}$ is a $C^{2}$ domain and $0 \in \partial \Omega$. Furthermore, in order to avoid extremely technical computations, we shall assume either that $\partial \Omega$ is flat near 0 or $p=N$. We suppose that the tangent plane to $\partial \Omega$ at 0 is $\partial \mathbb{R}_{+}^{N}=\left\{x=\left(x^{\prime}, 0\right)\right\}$ and the normal inward unit vector at 0 is $\mathbf{e}_{N}$, therefore $\mathbf{n}=-\mathbf{e}_{N}$ in the sequel. We denote by $\omega_{s_{+}^{N-1}}$ the unique positive solution of (3.1) in $S_{+}^{N-1}$ and by $U_{s_{+}^{N-1}}$ the corresponding singular solution of (1.1) in $\mathbb{R}_{+}^{N}$ defined by

U_{s_{+}^{N-1}}(x)=|x|^{-\beta_{q}} \omega_{s_{+}^{N-1}}\left(\frac{x}{|x|}\right) \tag{4.66}
\end{equation*}
$$

We recall that $\psi_{*}$ is the unique positive solution of $(3.2)$ with maximum 1 and $\Psi_{*}$ the corresponding $p$-harmonic function

\Psi_{*}(x)=|x|^{-\beta_{*}} \psi_{*}\left(\frac{x}{|x|}\right) . \tag{4.67}
\end{equation*}

### 4.1 The case $1<p<N$

The first statement points out the link between weak and strong singularities.
Proposition 4.1. Under the assumptions of Theorem 3.6 there exists $\lim _{k \rightarrow \infty} u_{k}=u_{\infty}$ which is the unique element of $C(\bar{\Omega} \backslash\{0\}) \cap C^{1}(\Omega)$ which vanishes on $\partial \Omega \backslash\{0\}$, satisfies (1.1) in $\Omega$ and

\lim _{x \rightarrow 0} \frac{u_{\infty}(x)}{U_{s_{+}^{N-1}}(x)}=1 \tag{4.68}
\end{equation*}
$$

Proof. Uniqueness follows from (4.68) and the maximum principle. For existence, since the mapping $k \mapsto u_{k}$ is increasing and $u_{k} \leq U_{s_{+}^{N-1}}$, there exists $\lim _{k \rightarrow \infty} u_{k}:=u_{\infty} \leq U_{s_{+}^{N-1}}$ and $u_{\infty} \in C(\bar{\Omega} \backslash\{0\}) \cap$ $C^{1}(\Omega)$. It vanishes on $\partial B_{\delta}^{+} \backslash\{0\}$ and satisfies (1.1) in $B_{\delta}^{+}$. In order to take into account the domain $B_{\delta}^{+}$ in the notations, we set $u_{k}=u_{k, \delta}$. Since the mapping $\delta \mapsto u_{k, \delta}$ is also increasing and $u_{k, \delta} \leq k \Psi_{*}$, there also exists $\lim _{\delta \rightarrow \infty} u_{k, \delta}:=u_{k, \infty} \leq k \Psi_{*}$ Then, for all $\ell>0$,

and letting $\delta \rightarrow \infty$, we obtain

T_{\ell}\left[u_{\infty, \infty}\right](x)=\ell^{\beta_{q}} u_{\infty, \infty}(\ell x)=u_{\infty, \infty}(x) \tag{4.71}
\end{equation*}

This implies that

u_{\infty, \infty}(r, \sigma)=r^{-\beta_{q}} \omega^{\prime}(\sigma) \tag{4.72}
\end{equation*}
$$

and $\omega^{\prime}$ is a positive solution of problem (3.1). Therefore $\omega^{\prime}=\omega_{s_{+}^{N-1}}$ by Theorem 3.2. If we let $\ell \rightarrow 0$ in (4.69) and take $|x|=1, x=\sigma$, we derive

\lim _{\ell \rightarrow 0} \ell^{\beta_{q}} u_{\infty, \delta}(\ell, \sigma)=\lim _{\ell \rightarrow 0} u_{\infty, \ell^{-1} \delta}(1, \sigma)=u_{\infty, \infty}(1, \sigma)=\omega_{s_{+}^{N-1}}(\sigma) \tag{4.73}
\end{equation*}
$$

This convergence holds in $C^{1}\left(\overline{S_{+}^{N-1}}\right)$ because of Lemma 2.5. This implies (4.68).
The main classification result is as follows.
Theorem 4.2. Assume $1<p<N, p-1<q<q^{*}$ and $\partial \Omega \cap B_{\delta}=\left\{x=\left(x^{\prime}, 0\right):\left|x^{\prime}\right|<\delta\right\}$, for some $\delta>0$. If $u \in C(\bar{\Omega} \backslash\{0\}) \cap C^{1}(\Omega)$ is a positive solution of $(1.1)$ in $\Omega$ which vanishes on $\partial \Omega \backslash\{0\}$, then we have the following alternative:
(i) either there exists $k \geq 0$ such that

(ii) or

Proof. Step 1. Assume

then we claim that (4.74) holds. We first note that if (4.76) holds, there also holds

where $u_{1}$ is the solution of (1.1) obtained in Theorem 3.6 with $k=1$. If $\left\{x_{n}\right\}$ is converging to 0 and such that for some $k>0$

$$

This implies in particular

u(x) \leq c_{5}^{2}\left(k+\epsilon_{n}\right) u_{1}(x) \quad \forall x \text { s.t. }|x|=\left|x_{n}\right|
$$

where $\left\{\epsilon_{n}\right\}$ is converging to $0_{+}$, and by the comparison principle

u(x) \leq K u_{1}(x) \quad \forall x \in \mathbb{R}_{+}^{N} \text { s.t. }\left|x_{n}\right| \leq|x| \leq \frac{\delta}{2}
$$

for some $K>0$ and all $n \in \mathbb{N}_{*}$. Therefore

We can assume that $k \neq 0$, otherwise (4.74) holds with $k=0$ and actually $u$ remains bounded near 0 . As a consequence of the Hopf Lemma and $C^{1}$ regularity, there exists $K>0$ such that

Let $m=\max \{u(x):|x|=\delta\}$. For $0<\tau<\delta$ we denote by $k_{\tau}$ the minimum of the $\kappa>0$ such that $u(x) \leq \kappa \Psi_{*}(x)+m$ for $\tau \leq|x| \leq \delta$. Then $u(x) \leq k_{\tau} \Psi_{*}(x)+m$, and either the graphs of the mappings $u($.$) and k_{\tau} \Psi_{*}()+$.$m are tangent at some x_{\tau} \in B_{\delta}^{+} \backslash \bar{B}_{\tau}^{+}$, or they are tangent on the boundary of the domain, and the only possibility is that they are tangent on $|x|=\tau$. Since

is uniformly elliptic in a neighborhood of $x_{\tau}$ (see [6, Lemma 1.3]). Furthermore $w \leq 0$ and $w\left(x_{\tau}\right)=$ 0 by the strong maximum principle $\nabla u\left(x_{\tau}\right)$ must vanish, which contradicts the fact that $\nabla u\left(x_{\tau}\right)=$ $\nabla w\left(x_{\tau}\right)$ by the tangency condition, and $\nabla w\left(x_{\tau}\right) \neq 0$. Therefore $\left|x_{\tau}\right|=\tau$ and $x_{\tau} \notin \partial \mathbb{R}_{+}^{N}$. If $\tau^{\prime}<\tau$, $k_{\tau} \leq k_{\tau^{\prime}}$, and we set $k=\lim _{\tau \rightarrow 0} k_{\tau}$, which is finite because of (4.79). There exists $\left\{\tau_{n}\right\}$ such that $\sigma_{n}:=\tau^{-1} x_{\tau_{n}} \rightarrow \sigma_{0}$. Furthermore

\begin{equation*}
r^{\beta_{*}} u(r, \sigma) \leq k_{\tau} \psi_{*}(\sigma)+m r^{\beta_{*}} \quad \text { if } \tau \leq r \leq \delta \quad \text { and } \tau^{\beta_{*}} u\left(\tau, \sigma_{\tau}\right)=k_{\tau} \psi_{*}\left(\sigma_{\tau}\right)+m \tau^{\beta_{*}} \tag{4.81}
\end{equation*}
$$

Put

$$
\begin{equation*}
u_{\tau}(x)=\tau^{\beta_{*}} u(\tau x) \tag{4.82}
\end{equation*}
$$

Then

$$
-\Delta_{p} u_{\tau}+\tau^{p-q-\beta_{*}(p+1-q)}\left|\nabla u_{\tau}\right|^{q}=0 \quad \text { in } B_{\frac{\delta}{\tau}}^{+} \backslash\{0\}
$$

and, by (4.79),

$$
0 \leq u_{\tau}(x) \leq K|x|^{-\beta_{*}} \quad \text { in } B_{\frac{\delta}{2 \tau}}^{+} \backslash\{0\}
$$

By Lemma 2.5, the set of functions $\left\{u_{\tau}().\right\}$ is relatively compact in the $C_{l o c}^{1}$ topology of $\overline{\mathbb{R}_{+}^{N}} \backslash\{0\}$. Therefore, as $q<q^{*}$, there exist a sequence $\left\{\tau_{n}^{\prime}\right\} \subset\left\{\tau_{n}\right\}$ converging to 0 , and a positive $p$-harmonic function $v$ in $\mathbb{R}_{+}^{N}$, continuous in $\overline{\mathbb{R}_{+}^{N}} \backslash\{0\}$ and vanishing on $\partial \mathbb{R}_{+}^{N} \backslash\{0\}$, such that $u_{\tau_{n}^{\prime}} \rightarrow v$, and $v$ satisfies (4.79) in $\overline{\mathbb{R}_{+}^{N}} \backslash\{0\}$. By Theorem 5.1 in Appendix I, there exists $k^{*}$ such that $v=k^{*} \Psi_{*}$. In particular,

\lim _{\tau_{n}^{\prime} \rightarrow 0} u_{\tau_{n}^{\prime}}(1, \sigma)=k^{*} \psi_{*}(\sigma) \tag{4.83}
\end{equation*}

in the $C^{1}\left(\overline{S_{+}^{N-1}}\right)$ topology. Combining (4.81), (4.82) and (4.83) we conclude that $k^{*}=k$ and

\lim _{\tau_{n}^{\prime} \rightarrow 0} \tau_{n}^{\prime \beta_{*}} u_{\tau_{n}^{\prime}}(1, \sigma)=k \psi_{*}(\sigma) \tag{4.84}
\end{equation*}

Using Theorem 3.6, it is equivalent to

\lim _{\tau_{n}^{\prime} \rightarrow 0} \frac{u\left(\tau_{n}^{\prime}, \sigma\right)}{u_{k}\left(\tau_{n}^{\prime}, \sigma\right)}=1 \tag{4.85}
\end{equation*}
$$

uniformly on $S_{+}^{N-1}$. For any $\epsilon>0$, there exists $n_{\epsilon}>0$ such that $n \geq n_{\epsilon}$ implies

u_{k-\epsilon}\left(\tau_{n}^{\prime}, \sigma\right) \leq u\left(\tau_{n}^{\prime}, \sigma\right) \leq u_{k+\epsilon}\left(\tau_{n}^{\prime}, \sigma\right)
$$

By comparison principle,

u_{k-\epsilon} \leq u \leq u_{k+\epsilon}+m \quad \text { in } B_{\delta}^{+} \backslash B_{\tau_{n}^{\prime}}^{+} \tag{4.86}
\end{equation*}
$$

and finally

u_{k-\epsilon} \leq u \leq u_{k+\epsilon}+m \quad \text { in } B_{\delta}^{+} \tag{4.87}
\end{equation*}

Since $\epsilon$ is arbitrary and using again Theorem 3.6, it implies

Step 2. Assume

\end{equation*}

where $v_{\epsilon}$ has been defined in (3.12) and $u_{k}$ is given by Theorem 3.6. Letting $\epsilon \rightarrow 0, k \rightarrow \infty$, and using Proposition 4.1, we derive

We have seen in Theorem 3.3 that $v_{0}$ is a separable solution of (1.1) in $\mathbb{R}_{+}^{N}$ which vanishes on $\partial \mathbb{R}_{+}^{N} \backslash\{0\}$, therefore $v_{0}(x)=U_{s_{+}^{N-1}}(x)$. This implies

We conclude using Proposition 4.1.

### 4.2 The case $p=N$

When $p=N$, the assumption that $\partial \Omega$ is an hyperplane near 0 can be removed. The proof of the next results is based upon Theorem 3.10. The following result is the extension to the case $p=N$ of Proposition 4.1.

Proposition 4.3. Under the assumptions of Theorem 3.10 there exists $\lim _{k \rightarrow \infty} u_{k}=u_{\infty}$ which is the unique element of $C(\bar{\Omega} \backslash\{0\}) \cap C^{1}(\Omega)$ which satisfies (3.17) in $\Omega$, vanishes on $\partial \Omega \backslash\{0\}$ and such that

\begin{equation*}
\lim _{x \rightarrow 0} \frac{u_{\infty}(x)}{U_{s_{+}^{N-1}}(x)}=1 \tag{4.93}
\end{equation*}
$$

Proof. We denote by $u_{k}^{\Omega}$ the unique positive solution of (3.17) satisfying (3.57) obtained in Theorem 3.6. Then

T_{\ell}\left[u_{k}^{\Omega}\right]=u_{\ell^{\beta_{q}-\beta_{*}}}^{\Omega^{\ell}} \tag{4.94}
\end{equation*}

because of uniqueness. We denote by $B:=B_{\frac{1}{2}}(a)$ and $B^{\prime}:=B_{\frac{1}{2}}\left(a^{\prime}\right)$ the two balls tangent to $\partial \Omega$ at 0 respectively interior and exterior to $\Omega$ introduced in the proof of Lemma 3.11. Estimate (3.58) implies

the left-hand side inequality holding in $\Omega$ and the right-hand side one in $B$. Therefore

\end{equation*}
$$

the domains of validity of these inequalities being modified accordingly. Using again (3.58) we obtain

for any $0<\ell^{\prime} \leq \ell$ and $\ell^{\prime \beta_{q}-\beta_{*}} k^{\prime} \geq \ell^{\beta_{q}-\beta_{*}} k$. Since $u_{k}^{\Omega} u_{k}^{B}, u_{k}^{B^{\prime c}}$ are increasing with respect to $k$, they converge respectively to $u_{\infty}^{\Omega} u_{\infty}^{B}, u_{\infty}^{B^{\prime C}}$ and there holds for any $\ell>0$

T_{\ell}\left[u_{\infty}^{B^{\prime c}}\right] \leq T_{\ell}\left[u_{\infty}^{\Omega}\right] \leq T_{\ell}\left[u_{\infty}^{B}\right] \tag{4.99}
\end{equation*}

from (4.96) and

$$
\begin{align*}
T_{\ell^{\prime}}\left[u_{\infty}^{B^{\prime c}}\right] & \leq T_{\ell}\left[u_{\infty}^{B^{\prime c}}\right] & \quad \text { in } B^{\prime c \ell^{\prime}}  \tag{i}\\
T_{\ell^{\prime}}\left[u_{\infty}^{B}\right] & \geq T_{\ell}\left[u_{\infty}^{B}\right] & \quad \text { in } B^{\ell} \tag{ii}
\end{align*}
$$

for any $0<\ell^{\prime} \leq \ell$. Notice that, replacing $\ell$ by $\ell \ell^{\prime}$ we can rewrite (4.99) as follows

\end{equation*}

By Lemma 2.5 applied with $\phi(|x|)=|x|^{-\beta_{q}}$ and since there holds $u_{\infty}^{B}(x) \leq c|x|^{-\beta_{q}}$ and $u_{\infty}^{B^{\prime}}(x) \leq$ $c|x|^{-\beta_{q}}$, we derive
(i) $\left|\nabla T_{\ell}\left[u_{\infty}^{B}\right](x)\right| \leq c_{2}|x|^{-\beta_{q}-1}$
$\forall x \in B^{\ell}$
(ii) $\left|\nabla T_{\ell}\left[u_{\infty}^{B}\right](x)-\nabla T_{\ell}\left[u_{\infty}^{B}\right](y)\right| \leq c_{2}|x|^{-\beta_{q}-1-\alpha}|x-y|^{\alpha}$
$\forall x, y \in B^{\ell},|x| \leq|y|$
(iii) $T_{\ell}\left[u_{\infty}^{B}\right](x) \leq c_{2}|x|^{-\beta_{q}-1}\left(\operatorname{dist}\left(x, \partial B^{\ell}\right)\right)^{\alpha}$
$\forall x \in B^{\ell}$,
and
(i) $\left|\nabla T_{\ell}\left[u_{\infty}^{B^{\prime c}}\right](x)\right| \leq c_{2}|x|^{-\beta_{q}-1}$
$\forall x \in B^{\prime c \ell}$
(ii) $\quad\left|\nabla T_{\ell}\left[u_{\infty}^{B^{\prime c}}\right](x)-\nabla T_{\ell}\left[u_{\infty}^{B^{\prime c}}\right](y)\right| \leq c_{2}|x|^{-\beta_{q}-1-\alpha}|x-y|^{\alpha}$
$\forall x, y \in B^{\prime c \ell},|x| \leq|y|$
(iii) $T_{\ell}\left[u_{\infty}^{B^{\prime c}}\right](x) \leq c_{2}|x|^{-\beta_{q}-1}\left(\operatorname{dist}\left(x, \partial B^{\prime c \ell}\right)\right)^{\alpha}$
$\forall x \in B^{\prime c \ell}$.

Thus the sets of functions $\left\{T_{\ell}\left[u_{\infty}^{B}\right]\right\}$ and $\left\{T_{\ell}\left[u_{\infty}^{B^{\prime}}\right]\right\}$ are equicontinuous in the $C^{1}$-loc topology and by uniqueness, the limit in (4.102) below holds in this topology. Hence $U^{B^{\prime c}}$ and $U^{B^{c}}$ are positive solutions of (3.17) in $\mathbb{R}_{+}^{N}$ which vanish on $\partial \mathbb{R}_{+}^{N} \backslash\{0\}$. Furthermore $U^{B^{\prime c}} \leq U^{B^{c}}$ Since for any $\ell, \ell^{\prime}>0$,
$T_{\ell^{\prime}}\left[T_{\ell}\left[u_{\infty}^{B^{\prime c}}\right]\right]=T_{\ell \ell^{\prime}}\left[u_{\infty}^{B^{\prime c}}\right]$, it follows $T_{\ell^{\prime}}\left[U^{B^{\prime c}}\right]=U^{B^{\prime c}}$ and in the same way $T_{\ell^{\prime}}\left[U^{B}\right]=U^{B}$. This means that $U^{B}$ and $U^{B^{\prime c}}$ are self-similar solutions of (3.17) in $\mathbb{R}_{+}^{N}$ and they vanish on $\partial \mathbb{R}_{+}^{N} \backslash\{0\}$. Hence

U^{B}=U^{B^{\prime c}}=U_{S_{+}^{N-1}} \tag{4.105}
\end{equation*}
$$

Applying again Lemma 2.5 to $u_{\infty}^{\Omega}$ with $\phi(|x|)=|x|^{-\beta_{q}}$ we have
(i) $\left|\nabla T_{\ell}\left[u_{\infty}^{\Omega}\right](x)\right| \leq c_{2}|x|^{-\beta_{q}-1}$

\begin{equation*}
\forall x \in \Omega^{\ell} \tag{4.106}
\end{equation*}
$$

(ii) $\left|\nabla T_{\ell}\left[u_{\infty}^{\Omega}\right](x)-\nabla T_{\ell}\left[u_{k}^{\Omega}\right](y)\right| \leq c_{2}|x|^{-\beta_{q}-1-\alpha}|x-y|^{\alpha}$
$\forall x, y \in \Omega^{\ell},|x| \leq|y|$
(iii) $T_{\ell}\left[u_{\infty}^{\Omega}\right](x) \leq c_{2}|x|^{-\beta_{q}-1}\left(\operatorname{dist}\left(x, \partial \Omega^{\ell}\right)\right)^{\alpha}$
$\forall x \in \Omega^{\ell}$.

This implies that the set of functions $\left\{T_{\ell}\left[u_{\infty}^{\Omega}\right]\right\}_{\ell}$ is equicontinuous in the $C^{1}$-loc topology of $\mathbb{R}_{+}^{N}$ and there exists a sequence $\left\{\ell_{n}\right\} \rightarrow 0$ and a function $U$ such that $T_{\ell_{n}}\left[u_{\infty}^{\Omega}\right] \rightarrow U^{\Omega}$ in this topology of $\mathbb{R}_{+}^{N}$, and $U$ is a positive solution of (3.17) in $\mathbb{R}_{+}^{N}$ which vanishes on $\partial \mathbb{R}_{+}^{N} \backslash\{0\}$. From (4.99) and (4.105) there holds $U^{\Omega}=U_{S_{+}^{N-1}}$ and therefore

\begin{equation*}
\lim _{\ell \rightarrow 0} T_{\ell}\left[u_{\infty}^{\Omega}\right]=U_{S_{+}^{N-1}} \tag{4.107}
\end{equation*}
$$

This implies (4.93) and

$$
\begin{equation*}
\lim _{r \rightarrow 0} r^{\beta_{q}} u_{\infty}^{\Omega}(r, \sigma)=\omega_{S_{+}^{N-1}}(\sigma) \tag{4.108}
\end{equation*}
$$

uniformly on compact subsets of $S_{+}^{N-1}$.
Up to minor modifications the proof of the next classification theorem is similar to the one of Theorem 4.2.

Theorem 4.4. Assume $N-1<q<N-\frac{1}{2}$ If $u \in C(\bar{\Omega} \backslash\{0\}) \cap C^{1}(\Omega)$ is a positive solution of $(3.17)$ in $\Omega$ which vanishes on $\partial \Omega \backslash\{0\}$, then we have the following alternative:
(i) either there exists $k \geq 0$ such that (4.74) holds,
(ii) or (4.75) holds.

## 5 Appendix I: Positive $p$-harmonic functions in a half space

In this section we prove the following rigidity result.
Theorem 5.1. Assume $1<p \leq N$ and $u \in C^{1}\left(\mathbb{R}_{+}^{N}\right) \cap C\left(\overline{\mathbb{R}_{+}^{N}} \backslash\{0\}\right)$ is a positive p-harmonic function which vanishes on $\partial \mathbb{R}_{+}^{N} \backslash\{0\}$ and such that $|x|^{\beta_{*}} u(x)$ is bounded. Then there exists $k \geq 0$ such that

$$
\begin{equation*}
u(x)=k \Psi_{*}(x) \quad \forall x \in \mathbb{R}_{+}^{N} \tag{5.1}
\end{equation*}
$$

Proof. Since $|x|^{\beta_{*}} u(x)$ is bounded, $|x|^{\beta_{*}+1} \nabla u(x)$ is also bounded and there exists $m>0$ such that $u(x) \leq m \Psi_{*}(x)$ in $B_{\delta}^{+}$. We denote by $k$ the infimum of the $c>0$ such that $u(x) \leq c \Psi_{*}(x)$. Then

$$
\begin{equation*}
0 \leq u(x) \leq k \Psi_{*}(x) \quad \forall x \in \mathbb{R}_{+}^{N} \backslash\{0\} \tag{5.2}
\end{equation*}
$$

and we assume that $k>0$ otherwise $u=0$. Assume that the graphs over $\mathbb{R}_{+}^{N}$ of the functions $x \mapsto u(x)$ and $x \mapsto k \Psi_{*}(x)$ are tangent at some point $x_{0} \in \mathbb{R}_{+}^{N}$ or $x_{0} \in \partial \mathbb{R}_{+}^{N} \backslash\{0\}$. Since $\nabla \Psi_{*}$ never vanishes in $\overline{\mathbb{R}}_{+}^{N} \backslash\{0\}$ it follows from the strong maximum principle or Hopf Lemma that $u=k \Psi_{*}$. If the two graphs are not tangent in $\overline{\mathbb{R}}_{+}^{N} \backslash\{0\}$, either they are asymptotically tangent at 0 , or at $\infty$.
(i) In the first case there exists two sequences $\left\{k_{n}\right\}$ increasing to $k$ and $\left\{x_{n}\right\} \subset \mathbb{R}_{+}^{N}$ converging to zero such that $\frac{u\left(x_{n}\right)}{\Psi_{*}\left(x_{n}\right)}=k_{n}$. We set $r_{n}=\left|x_{n}\right|$ and $u_{r_{n}}(x)=r_{n}^{\beta_{*}} u\left(r_{n} x\right)$. Then $u_{r_{n}}$ is $p$-harmonic and positive and $0<u_{r_{n}}(x) \leq k|x|^{-\beta_{*}} \psi_{*}\left(\frac{x}{|x|}\right)$; therefore

$$
\begin{equation*}
\left|\nabla u_{r_{n}}(x)\right| \leq C|x|^{-\beta_{*}-1} \text { and }\left|\nabla u_{r_{n}}(x)-\nabla u_{r_{n}}\left(x^{\prime}\right)\right| \leq C|x|^{-\beta_{*}-1-\alpha}\left|x-x^{\prime}\right|^{\alpha} \tag{5.3}
\end{equation*}
$$

for $0<|x| \leq\left|x^{\prime}\right|$ and some constants $C>0$ and $\alpha \in(0,1)$. Up to a subsequence, we can assume that $u_{r_{n}}$ converges to some $U$ in the $C_{\text {loc }}^{1}$ topology of $\overline{\mathbb{R}}_{+}^{N} \backslash\{0\}$ and $\frac{x_{n}}{r_{n}} \rightarrow \xi \in S_{+}^{N-1}$. The function $U$ is $p$-harmonic and positive in $\mathbb{R}_{+}^{N}$ and satisfies $0 \leq U \leq k \Psi_{*}$ in $\mathbb{R}_{+}^{N}$ and $U(\xi)=k \Psi_{*}(\xi)$ if $\xi \in S_{+}^{N-1}$ or $U_{x_{N}}(\xi)=k \Psi_{* x_{N}}(\xi)$ if $\xi \in \partial S_{+}^{N-1}$. It follows from the strong maximum principle or Hopf Lemma that $U=k \Psi_{*}$. Therefore $u_{r_{n}} \rightarrow k \Psi_{*}$ and in particular

$$
\begin{equation*}
\lim _{r_{n} \rightarrow 0} \frac{r_{n}^{\beta_{*}} u\left(r_{n}, \sigma\right)}{\psi_{*}(\sigma)}=k \quad \text { uniformly on } S_{+}^{N-1} . \tag{5.4}
\end{equation*}
$$

For any $\epsilon>0$, there exists $n_{\epsilon} \in \mathbb{N}_{*}$ such that for $n \geq n_{\epsilon},(k-\epsilon) \Psi_{*}(x) \leq u(x) \leq(k+\epsilon) \Psi_{*}(x)$ if $|x|=r_{n}$. This implies $(k-\epsilon) \Psi_{*}(x) \leq u(x) \leq(k+\epsilon) \Psi_{*}$ for $|x| \geq r_{n}$ and therefore in $\mathbb{R}^{N}$. Since $\epsilon$ is arbitrary, we deduce that $u=k \Psi_{*}$.
(ii) if the two graphs are tangent at infinity, there exist two sequences $\left\{k_{n}\right\}$ increasing to $k$ and $\left\{x_{n}\right\}$ such that $r_{n}=\left|x_{n}\right| \rightarrow \infty$ with $u\left(x_{n}\right)=k_{n} \Psi_{*}\left(x_{n}\right)$ and

$$
\begin{equation*}
\lim _{r_{n} \rightarrow \infty} \frac{r_{n}^{\beta_{*} u\left(r_{n}, \sigma\right)}}{\psi_{*}(\sigma)}=k \quad \text { uniformly on } S_{+}^{N-1} \tag{5.5}
\end{equation*}
$$

Therefore we look at the supremum of the $c>0$ such that $u \geq c \Psi_{*}$. If the set of such $c$ is empty, it would mean that

$$
\inf _{x \in \mathbb{R}_{+}^{N}} \frac{u(x)}{\Psi_{*}(x)}=0
$$

Clearly, if this infimum is achieved at some point, the strong maximum principle or Hopf Lemma imply $u \equiv 0$, contradicting (5.5), and this relation prevents also this infimum be achieved at infinity. We are left with the case where there exists a sequence $\left\{z_{n}\right\} \subset \mathbb{R}_{+}^{N}$, converging to 0 , such that

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \frac{u\left(z_{n}\right)}{\Psi_{*}\left(z_{n}\right)}=0 . \tag{5.6}
\end{equation*}
$$

By boundary Harnack inequality [2, th 2.11], there exists $c>0$ such that

$$
\begin{equation*}
c^{-1} \frac{u(z)}{\Psi_{*}(z)} \leq \frac{u\left(z_{n}\right)}{\Psi_{*}\left(z_{n}\right)} \leq c \frac{u(z)}{\Psi_{*}(z)} \quad \forall z \in \mathbb{R}_{+}^{N} \text { s.t. }|z|=\left|z_{n}\right| \tag{5.7}
\end{equation*}
$$

Combining (5.6) and (5.7), we derive that

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \sup _{|z|=\left|z_{n}\right|} \frac{u(z)}{\Psi_{*}(z)}=0 \tag{5.8}
\end{equation*}
$$

Denoting by $\epsilon_{n}$ the supremum in the above relation, we obtain that $u \leq \epsilon_{n} \Psi_{*}$ in $\mathbb{R}_{+}^{N} \backslash B_{\epsilon_{n}}$ and finally $u=0$, contradiction. Thus we are left with the case where there exists $k^{\prime} \in(0, k]$ which is the supremum of the $c>0$ such that $u \geq c \Psi_{*}$. In particular $u \geq k^{\prime} \Psi_{*}$. Remembering that $u \leq k \Psi_{*}$ we get $k=k^{\prime}$, which implies $u=k \Psi_{*}$.

Next we assume that $k^{\prime}<k$. Clearly the graphs of $u$ and $k^{\prime} \Psi_{*}$ cannot be tangent in $\overline{\mathbb{R}}_{+}^{N}$, because of strong maximum principle or Hopf Lemma. They cannot be tangent at infinity because of (5.5). Therefore there exist two sequences $\left\{k_{n}^{\prime}\right\}$ increasing to $k^{\prime}$ and $\left\{x_{n}^{\prime}\right\} \subset \mathbb{R}_{+}^{N}$ converging to 0 such that $\frac{u\left(x_{n}^{\prime}\right)}{\Psi_{*}\left(x_{n}^{\prime}\right)}=k_{n}^{\prime}$. As in case (i) we obtain that

$$
\begin{equation*}
\lim _{r_{n}^{\prime} \rightarrow 0} \frac{r_{n}^{\prime \beta_{*}} u\left(r_{n}^{\prime}, \sigma\right)}{\psi_{*}(\sigma)}=k^{\prime} \quad \text { uniformly on } S_{+}^{N-1} \tag{5.9}
\end{equation*}
$$

where $r_{n}^{\prime}=\left|x_{n}^{\prime}\right|$, and finally derive that $u=k^{\prime} \Psi_{*}$, a contradiction with (5.5). Therefore $k=k^{\prime}$, which ends the proof.
Remark. In the case $p=N$ the result holds under the weaker assumption $\lim _{|x| \rightarrow \infty} u(x)=0$. This is due to the fact that this condition implies by regularity

$$
\lim _{|x| \rightarrow \infty} \frac{u(x)}{\omega_{s_{+}^{N-1}}\left(\frac{x}{|x|}\right)}=0
$$

and therefore

$$
u(x) \leq m \Psi_{*}(x) \quad \forall x \text { s.t. }|x| \geq 1
$$

where $m=\max _{|x|=1} \frac{u(x)}{\omega_{s_{+}^{N-1}}\left(\frac{x}{|x|}\right)}$. Using the inversion $x \mapsto \frac{x}{|x|^{2}}$, we obtain that the estimate $u \leq m \Psi_{*}$ holds $\mathbb{R}^{N}$, and we conclude by Theorem 5.1.

Remark. We conjecture that the rigidity result holds under the mere condition

$$
\begin{equation*}
\lim _{|x| \rightarrow \infty}|x|^{-\tilde{\beta}} u(x)=0 \tag{5.10}
\end{equation*}
$$

were $\tilde{\beta}$ is the (positive) exponent corresponding to the regular spherical $p$-harmonic function under the form

$$
\begin{equation*}
\tilde{\Psi}=|x|^{\tilde{s}} \tilde{\psi}\left(\frac{x}{|x|}\right) \tag{5.11}
\end{equation*}
$$

see [14], [12]. Note that $\tilde{\beta}=1$ when $p=N$.

## 6 Appendix II: Estimates on $\beta_{*}$

When $N=2$ and $1<p \leq 2$, it is proved in [9] that

$$
\begin{equation*}
\beta_{*}=\frac{3-p+2 \sqrt{p^{2}-5 p+7}}{3(p-1)} . \tag{6.1}
\end{equation*}
$$

Up to now no estimate is known when $N>2$ except in the cases $p=2$ where $\beta_{*}=N-1$ and $p=N$ where $\beta_{*}=1$, besides the classical one

$$
\begin{equation*}
\beta_{*}>\frac{N-p}{p-1} \tag{6.2}
\end{equation*}
$$

valid when $p<N$. In this section we prove the following result
Theorem 6.1. Assume $1<p<N$. Then the following estimates hold:

$$
\begin{gather*}
1<p<2 \Longrightarrow \beta_{*}>\frac{N-1}{p-1}  \tag{6.3}\\
2<p<N \Longrightarrow \max \left\{1, \frac{N-p}{p-1}\right\}<\beta_{*}<\frac{N-1}{p-1} \tag{6.4}
\end{gather*}
$$

Remark. It is worth noticing that when $p=2$ or $p=N$, there holds $\beta_{*}=\frac{N-1}{p-1}$.
Proof of Theorem 6.1. We consider the following set of spherical coordinates in $\mathbb{R}_{+}^{N}$ with $x=\left(x_{1}, \ldots, x_{N}\right)$

$$
\begin{align*}
& x_{1}=r \sin \theta_{N-1} \sin \theta_{N-2} \ldots \sin \theta_{2} \sin \theta_{1} \\
& x_{2}=r \sin \theta_{N-1} \sin \theta_{N-2} \ldots \sin \theta_{2} \cos \theta_{1} \\
& \vdots  \tag{6.5}\\
& x_{N-1}=r \sin \theta_{N-1} \cos \theta_{N-2} \\
& x_{N}=r \cos \theta_{N-1}
\end{align*}
$$

with $\theta_{1} \in[0,2 \pi]$ and $\theta_{k} \in[0, \pi]$ for $k=2, \ldots, N-2$ and $\theta_{N-1} \in\left[0, \frac{\pi}{2}\right]$. Under this representation, a solution $\omega$ of (3.2) verifies

$$
\begin{align*}
& -\frac{1}{\sin ^{N-2} \theta_{N-1}}\left[\sin ^{N-2} \theta_{N-1}\left(\beta_{*}^{2} \omega^{2}+\omega_{\theta_{N-1}}^{2}+\frac{1}{\sin ^{2} \theta_{N-1}}\left|\nabla_{\theta^{\prime}} \omega\right|^{2}\right)^{\frac{p-2}{2}} \omega_{\theta_{N-1}}\right]_{\theta_{N-1}} \\
& \left.-\frac{1}{\sin ^{2} \theta_{N-1}} d^{\prime} v_{\theta^{\prime}}^{\prime}\left[\sin ^{N-2} \theta_{N-1}\left(\beta_{*}^{2} \omega^{2}+\omega_{\theta_{N-1}}^{2}+\frac{1}{\sin ^{2} \theta_{N-1}}\left|\nabla_{\theta^{\prime}} \omega\right|^{2}\right)^{\frac{p-2}{2}} \nabla_{\theta^{\prime}} \omega\right]^{\frac{p-2}{2}} \omega\right]  \tag{6.6}\\
& =\beta_{*} \Lambda_{\beta_{*}}\left[\sin ^{N-2} \theta_{N-1}\left(\beta_{*}^{2} \omega^{2}+\omega_{\theta_{N-1}}^{2}+\frac{1}{\sin ^{2} \theta_{N-1}}\left|\nabla_{\theta^{\prime}} \omega\right|^{2}\right)^{2}\right]
\end{align*}
$$

where $\nabla_{\theta^{\prime}}$ and $d i v_{\theta^{\prime}}^{\prime}$ denotes respectively the spherical gradient the divergence in variables $\theta^{\prime}=\left(\theta_{1}, \ldots, \theta_{N-2}\right)$ parametrizing $S^{N-2}$ and $\Lambda_{\beta_{*}}$ is defined in Introduction. If $\omega$ is the unique positive solution of (3.2) (up
to homothety), it depends only on $\theta_{N-1}$ and is $C^{\infty}$. For simplicity we set $\theta_{N-1}=\theta \in\left[0, \frac{\pi}{2}\right]$ and $\omega=\omega(\theta)$ satisfies

\begin{align*}
& -\frac{1}{\sin ^{N-2} \theta}\left[\sin ^{N-2} \theta\left(\beta_{*}^{2} \omega^{2}+\omega_{\theta}^{2}\right)^{\frac{p-2}{2}} \omega_{\theta}\right]_{\theta}=\beta_{*} \Lambda_{\beta_{*}}\left[\sin ^{N-2} \theta\left(\beta_{*}^{2} \omega^{2}+\omega_{\theta}^{2}\right)^{\frac{p-2}{2}} \omega\right] \\
& \text { in }\left(0, \frac{\pi}{2}\right)  \tag{6.7}\\
& \omega\left(\frac{\pi}{2}\right)=0, \omega_{\theta}(0)=0 .
\end{align*}
$$

Step 1: The eigenvalue identity. Equation (6.7) can also be written under the form

$$
\begin{equation*}
-\omega_{\theta \theta}-(N-2) \cot \theta \omega_{\theta}-(p-2) \frac{\beta_{*}^{2} \omega+\omega_{\theta \theta}}{\beta_{*}^{2} \omega^{2}+\omega_{\theta}^{2}} \omega_{\theta}^{2}=\beta_{*} \Lambda_{\beta_{*}} \omega \tag{6.8}
\end{equation*}
$$

By multiplying (6.8) by $\cos \theta \sin ^{N-2} \theta$ and then integrating over $\left(0, \frac{\pi}{2}\right)$ we obtain

-\int_{0}^{\frac{\pi}{2}}\left(\omega_{\theta \theta}+(N-2) \cot \theta \omega_{\theta}\right) \cos \theta \sin ^{N-2} \theta d \theta=(N-1) \int_{0}^{\frac{\pi}{2}} \omega \cos \theta \sin ^{N-2} \theta d \theta

& \quad=(p-1)\left(\beta_{*}-\frac{N-1}{p-1}\right)\left(\beta_{*}+1\right) \int_{0}^{\frac{\pi}{2}} \omega \cos \theta \sin ^{N-2} \theta d \theta
\end{align*}
$$

Step 2: Elliptic coordinates and reduction. Writing $\omega(\theta)=\omega(0)+a \theta^{2}+o\left(\theta^{2}\right), \omega_{\theta}(\theta)=2 a \theta+o(\theta)$ and $\omega_{\theta \theta}(\theta)=2 a+o(1)$, then $-N a=\beta_{*} \Lambda_{\beta_{*}}$. This implies that $\omega$ is decreasing near 0 . It is immediate that it cannot have a local minimum in $\left(0, \frac{\pi}{2}\right)$, therefore it remains decreasing in the whole interval. We parametrize the ellipse

E_{r}=\left\{(x, y): x>0, y<0, x^{2}+\beta^{-2} y^{2}=r^{2}\right\}
$$

by setting

\omega=r \cos \phi \text { and }-\omega_{\theta}=\beta r \sin \phi \text { with } \phi=\phi(\theta) \text { and } r=r(\theta)
$$

The functions $r$ and $\phi$ are $C^{2}$. Hence $r_{\theta} \cos \phi-r \sin \phi \phi_{\theta}=-\beta r \sin \phi$, then $r_{\theta} \cos \phi=\left(\phi_{\theta}-\phi\right) r \sin \phi$ and $r_{\theta}=\left(\phi_{\theta}-\beta\right) r \tan \phi$. Plugging this into (6.8), we derive

$$
\begin{equation*}
-\left((p-1) \frac{r_{\theta}}{r}+\phi_{\theta} \cot \phi+(N-2) \cot \theta\right)+\Lambda_{\beta_{*}} \cot \phi=0 \tag{6.10}
\end{equation*}
$$

and finally

$$
\begin{equation*}
(p-1)\left(\phi_{\theta}-\beta\right) \tan \phi+\left(\phi_{\theta}-\Lambda_{\beta_{*}}\right) \cot \phi=(2-N) \cot \theta \tag{6.11}
\end{equation*}
$$

Step 3: Estimates on $\phi_{\theta}$. We can write (6.11) under the equivalent form

$$
\begin{equation*}
(p-1)\left(\phi_{\theta}-\beta\right) \tan ^{2} \phi+\phi_{\theta}-\Lambda_{\beta_{*}}=(2-N) \frac{\cos \theta}{\cos \phi} \frac{\sin \phi}{\sin \theta} \tag{6.12}
\end{equation*}
$$

Since

$$
\lim _{\theta \rightarrow 0} \frac{\sin \phi}{\sin \theta}=\lim _{\theta \rightarrow 0} \frac{\cos \phi}{\cos \theta} \phi_{\theta}=\phi_{\theta}(0)
$$

we derive $\phi_{\theta}(0)-\Lambda_{\beta_{*}}=(2-N) \phi_{\theta}(0)$ and thus $\phi_{\theta}(0)=\frac{\Lambda_{\beta_{*}}}{N-1}$. Similarly, the expansion of $\phi(\theta)$ near $\theta=\frac{\pi}{2}$ yields to $\phi_{\theta}\left(\frac{\pi}{2}\right)=\beta_{*}$. Since $p<N, \Lambda_{\beta_{*}} /(N-1)<\beta_{*}$. We claim now that

$$
\begin{equation*}
\phi_{\theta}(\theta)<\beta_{*} \quad \forall \theta \in\left(0, \frac{\pi}{2}\right) \tag{6.13}
\end{equation*}
$$

If $\Lambda_{\beta_{*}} \leq \beta_{*}$, then

$$
(2-N) \cot \theta=(p-1)\left(\phi_{\theta}-\beta\right) \tan \phi+\left(\phi_{\theta}-\Lambda_{\beta_{*}}\right) \cot \phi \geq((p-1) \tan \phi+\cot \phi)\left(\phi_{\theta}-\beta\right)
$$

thus (6.13) holds.
Next we assume $\beta_{*}<\Lambda_{\beta_{*}}$. It means $0<(p-2) \beta_{*}-(N-p)$ and thus $p>2$. We claim that

$$
\begin{equation*}
\beta_{*} \leq \frac{N-2}{p-2} \tag{6.14}
\end{equation*}
$$

We proceed by contradiction and assume

$$
\begin{equation*}
\beta_{*}>\frac{N-2}{p-2} \tag{6.15}
\end{equation*}
$$

Then

$$
(p-2)\left(\beta_{*}^{2}-\frac{N-p}{p-2} \beta_{*}-\frac{N-2}{p-2}\right)=(p-2)\left(\beta_{*}+1\right)\left(\beta_{*}-\frac{N-2}{p-2}\right)>0
$$

## Equivalently

$$
\beta_{*}\left(\Lambda_{\beta_{*}}-\beta_{*}\right)>N-2 .
$$

Since

$$
\lim _{\theta \rightarrow \frac{\pi}{2}} \cot \theta \tan \phi=\lim _{\theta \rightarrow \frac{\pi}{2}} \frac{\cos \theta}{\cos \phi}=\lim _{\theta \rightarrow \frac{\pi}{2}} \frac{\sin \theta}{\phi_{\theta} \sin \phi}=\frac{1}{\beta_{*}}
$$

and

$$
\begin{aligned}
(p-1)\left(\phi_{\theta}(\theta)-\beta_{*}\right) \tan ^{2} \phi & =\Lambda_{\beta_{*}}-\phi_{\theta}(\theta)+(2-N) \frac{\cos \theta}{\cos \phi} \frac{\sin \phi}{\sin \theta} \\
& =\frac{1}{\beta_{*}}\left(\beta_{*}\left(\Lambda_{\beta_{*}}-\beta_{*}\right)+2-N\right)+o(1)
\end{aligned}
$$

if follows that (6.15) is equivalent to the fact that there exists $\epsilon>0$ such that $\phi_{\theta}(\theta)>\frac{\pi}{2}$ for any $\theta \in\left[\frac{\pi}{2}-\epsilon, \frac{\pi}{2}\right)$. Since $\phi_{\theta}(0)<\beta_{*}$, there exists $\bar{\theta} \in\left(0, \frac{\pi}{2}\right)$ such that $\phi_{\theta}(\bar{\theta})=\beta$ and $\phi_{\theta \theta}(\bar{\theta}) \geq 0$. We compute $\phi_{\theta \theta}$ and get

$$
\begin{gathered}
(p-1) \phi_{\theta}(\theta)\left(\phi_{\theta}(\theta)-\beta_{*}\right) \sec ^{2} \phi(\theta)+(p-1) \phi_{\theta \theta}(\theta) \tan \phi(\theta)+\phi_{\theta \theta}(\theta) \cot \phi(\theta) \\
-\phi_{\theta}(\theta)\left(\phi_{\theta}(\theta)-\Lambda_{\beta_{*}}\right) \csc ^{2} \phi(\theta)=(N-2) \csc ^{2} \theta
\end{gathered}
$$

Hence, at $\theta=\bar{\theta}$

$$
(p-1) \phi_{\theta \theta}(\bar{\theta})((p-1) \tan \phi(\bar{\theta})+\cot \phi(\bar{\theta}))=\beta_{*}\left(\beta_{*}-\Lambda_{\beta_{*}}\right) \csc ^{2} \phi(\theta)+(N-2) \csc ^{2} \bar{\theta}
$$

From (6.11),

$$
\cot \phi(\bar{\theta})=\frac{N-2}{\Lambda_{\beta_{*}}-\beta_{*}} \cot \bar{\theta}
$$

Therefore

$$
\begin{align*}
(p-1) & \phi_{\theta \theta}(\bar{\theta})((p-1) \tan \phi(\bar{\theta})+\cot \phi(\bar{\theta})) \\
& =\left(1+\left(\frac{N-2}{\Lambda_{\beta_{*}}-\beta_{*}}\right)^{2} \cot ^{2} \bar{\theta}\right) \beta_{*}\left(\beta_{*}-\Lambda_{\beta_{*}}\right)+(N-2)\left(1+\cot ^{2} \bar{\theta}\right) \\
& =\beta_{*}\left(\beta_{*}-\Lambda_{\beta_{*}}\right)+N-2-\left(\frac{(N-2)^{2}}{\Lambda_{\beta_{*}}-\beta_{*}}+2-N\right) \cot ^{2} \bar{\theta}  \tag{6.16}\\
& =-(p-2)\left(\beta_{*}+1\right)\left(\beta_{*}-\frac{N-2}{p-2}\right)-\frac{N-2}{\Lambda_{\beta_{*}}-\beta_{*}}\left(\beta_{*}(N-1)-\Lambda_{\beta_{*}}\right) \cot ^{2} \bar{\theta} \\
& <0
\end{align*}
$$

using (6.15) and the fact that $N>p$. This is a contradiction, thus (6.14) holds and there exists $\epsilon>0$ such that $\phi_{\theta}<\beta_{*}$ in $\left[\frac{\pi}{2}-\epsilon, \frac{\pi}{2}\right)$.

We claim now that $\phi_{\theta}<\beta_{*}$ in $\left[0, \frac{\pi}{2}\right)$. If it is not true, there exist $\theta_{1}<\theta_{2}<\frac{\pi}{2}$ such that $\phi_{\theta}\left(\theta_{1}\right)=$ $\phi_{\theta}\left(\theta_{2}\right)=\beta_{*}, \phi_{\theta \theta}\left(\theta_{1}\right)>0, \phi_{\theta \theta}\left(\theta_{1}\right)<0$, since Cauchy-Lipschitz theorem applies to equation (6.11) in $\left(0, \frac{\pi}{2}\right)$. We put $\phi\left(\theta_{1}\right)=\phi_{1}$ and $\phi\left(\theta_{2}\right)=\phi_{2}$. Using the equation satisfied by $\phi_{\theta \theta}$, we obtain for $i=1,2$,

$$
\begin{align*}
& \left((p-1) \tan \phi_{i}+\cot \phi_{i}\right) \phi_{\theta \theta}\left(\theta_{i}\right) \\
& \quad=(2-p)\left(\beta_{*}+1\right)\left(\beta_{*}-\frac{N-2}{p-2}\right)-\frac{N-2}{\Lambda_{\beta_{*}}-\beta_{*}}\left(\beta_{*}(N-1)-\Lambda_{\beta_{*}}\right) \cot ^{2} \theta_{i} . \tag{6.17}
\end{align*}
$$

Since cot is decreasing in $\left(0, \frac{\pi}{2}\right), \cot ^{2} \theta_{1}>\cot ^{2} \theta_{2}$, hence

$$
0<\left((p-1) \tan \phi_{1}+\cot \phi_{1}\right) \phi_{\theta \theta}\left(\theta_{1}\right)<\left((p-1) \tan \phi_{2}+\cot \phi_{2}\right) \phi_{\theta \theta}\left(\theta_{2}\right)<0
$$

a contradiction. Therefore $\phi_{\theta}<\beta_{*}$ in $\left(0, \frac{\pi}{2}\right)$.
Step 4: End of the proof. Since $r^{2}=\beta_{*}^{2} \omega^{2}+\omega_{\theta}^{2}, r_{\theta}=r\left(\phi_{\theta}-\beta_{*}\right) \tan \phi$, we have

$$
\operatorname{rr}_{\theta}=\left(\beta_{*}^{2} \omega+\omega_{\theta \theta}\right) \omega_{\theta}=r\left(\phi_{\theta}-\beta_{*}\right) \tan \phi
$$

Since $\omega_{\theta}<0$ on $\left(0, \frac{\pi}{2}\right)$, it follows from Step 3 that $\beta_{*}^{2} \omega+\omega_{\theta \theta}>0$ and thus

$$
\int_{0}^{\frac{\pi}{2}} \frac{\beta_{*}^{2} \omega+\omega_{\theta \theta}}{\beta_{*}^{2} \omega^{2}+\omega_{\theta}^{2}} \omega_{\theta}^{2} \omega \cos \theta \sin ^{N-2} \theta d \theta>0
$$

The conclusion follows from (6.9).

Remark. Since $\omega_{\theta}\left(\frac{\pi}{2}\right)=-c^{2}<0$, it follows $\omega(\theta)=-\omega_{\theta}(\theta) \cot \theta+O\left(\frac{\pi}{2}-\theta\right)$ as $\theta \rightarrow \frac{\pi}{2}$, and from the eigenfunction equation (6.8)

$$
\frac{\beta_{*}^{2} \omega+\omega_{\theta \theta}}{\beta_{*}^{2} \omega^{2}+\omega_{\theta}^{2}} \omega_{\theta}^{2}=\left(\beta_{*}^{2} \omega+\omega_{\theta \theta}\right)(1+o(1))
$$

Therefore

$$
-(p-1) \omega_{\theta \theta}=\left(\beta_{*} \Lambda_{\beta_{*}}+(p-2) \beta_{*}^{2}+2-N\right) \omega(1+o(1)) \quad \text { as } \theta \rightarrow \frac{\pi}{2}
$$

and since $\Delta^{\prime} \omega:=\omega_{\theta \theta}+(N-2) \cot \theta \omega_{\theta}$

$$
-\Delta^{\prime} \omega=\frac{\beta_{*}\left(\beta_{*}(2 p-3)+p-N\right)+(p-2)(N-2)}{p-1} \omega(1+o(1)) \quad \text { as } \theta \rightarrow \frac{\pi}{2} .
$$

Because $\omega$ is $C^{\infty}$ we obtain finally

$$
\begin{equation*}
\left|\Delta^{\prime} \omega\right| \leq c \omega \tag{6.18}
\end{equation*}
$$

for some $c>0$.
