SPECTRAL ASSIGNMENT FOR NEUTRAL-TYPE SYSTEMS AND MOMENT PROBLEMS*

Abstract. For a large class of linear neutral-type systems the problem of assigning eigenvalues and eigenvectors is investigated, i.e. finding the system that has the given spectrum and, in some sense, almost all eigenvectors. The solution of this problem enables vector moment problems to be considered using the construction of a neutral-type system. The exact controllability property of the system obtained gives the solution of the vector moment problem.

Key words. Neutral-type systems, eigenvalue and eigenvector assignment, moment problems.

AMS subject classifications. 93C23, 93B60, 44A60

1. Introduction. One of the central problems in control theory is that of spectral assignment. This question has been well investigated for linear finite dimensional systems, see for example [27]. It is important to emphasize that the assignment of eigenvalues is not sufficient in several cases. Sometimes, the assignment of eigenvectors or of the geometric eigenstructure is needed (see for example [11, 23, 26]). This is possible by state or output feedback using the possibility of multivariable control.

For infinite dimensional systems (delay systems, partial derivative equations) the problem is much more complicated. However, for some particular classes of infinite dimensional systems, it is possible to assign a part or whole spectrum, see for example [4, 15, 22, 25]. The main motivation is the stabilizability by feedback. However, the assignment is always related to some controllability conditions. For example, the main result in [25] for the spectrum shifting is based on the exact controllability condition.

Our purpose is to investigate this kind of problem for a large class of linear delay systems of neutral-type, which may be considered in an infinite dimensional framework.

The general properties of systems of neutral-type have been widely investigated, see for example the classic works [2, 6, 9] and references therein.

Our subject of study is the system given by the equation

$$(1.1) \quad \dot{z}(t) = A_{-1}\dot{z}(t-1) + \int_{-1}^0 A_2(\theta)\dot{z}(t+\theta)d\theta + \int_{-1}^0 A_3(\theta)z(t+\theta)d\theta,$$

where $z(t) \in \mathbb{R}^n$ and A_{-1}, A_2, A_3 are $n \times n$ matrices. The elements of matrices $A_2(\cdot)$ and $A_3(\cdot)$ take values in $L_2(-1, 0)$. The neutral-type term $A_{-1}\dot{z}(t-1)$ consists of a simple delay, while the others include multiple discrete and distributed delays.

As shown in [3, 18, 19], this system can be rewritten in the operator form

$$(1.2) \quad \dot{x}(t) = \mathcal{A}x(t), \quad x(t) = \begin{pmatrix} y(t) \\ z_t(\cdot) \end{pmatrix},$$

where $z_t(\theta) = z(t + \theta)$ and the operator $\mathcal{A} : D(\mathcal{A}) \rightarrow M_2 = \mathbb{C}^n \times L_2([-1, 0], \mathbb{C}^n)$, with the domain

$$D(\mathcal{A}) = \left\{ \begin{pmatrix} y \\ \varphi(\cdot) \end{pmatrix} \mid \varphi(\cdot) \in H^1([-1, 0], \mathbb{C}^n), y = \varphi(0) - A_{-1}\varphi(-1) \right\} \subset M_2,$$

is given by the formula

$$\mathcal{A} \begin{pmatrix} y \\ \varphi(\cdot) \end{pmatrix} = \begin{pmatrix} \int_{-1}^0 A_2(\theta) \dot{\varphi}(\theta) d\theta + \int_{-1}^0 A_3(\theta) \varphi(\theta) d\theta \\ \frac{d\varphi}{d\theta}(\cdot) \end{pmatrix},$$

and is the infinitesimal generator of a C_0 -semigroup [3]. This operator is noted $\tilde{\mathcal{A}}$ instead of \mathcal{A} if $A_2(\theta) = A_3(\theta) \equiv 0$. The operator $\tilde{\mathcal{A}}$ is defined in the same domain $D(\mathcal{A})$.

It is well known that the spectral properties of this system are described by the characteristic matrix $\Delta(\lambda)$ given by

$$(1.3) \quad \Delta(\lambda) = \lambda I - \lambda e^{-\lambda} A_{-1} - \int_{-1}^0 \lambda e^{\lambda\theta} A_2(\theta) d\theta - \int_{-1}^0 e^{\lambda\theta} A_3(\theta) d\theta.$$

The eigenvalues are roots of the equation $\det \Delta(\lambda) = 0$. The eigenvectors of the system (more precisely of the functional operator model (1.2) of the system) are expressed through the kernels of the matrix $\Delta(\lambda_i)$, where λ_i are eigenvalues.

It is noteworthy that the eigenvalues and the eigenvectors of the operator \mathcal{A} are quadratically close to those of the operator $\tilde{\mathcal{A}}$ and the latter ones are expressed through the eigenvalues and eigenvectors of the matrix A_{-1} . In this sense, we can say that the behavior of such systems can be described mainly by the algebraic and geometric properties of the spectrum of the matrix A_{-1} , (cf. [18, 19]).

In parallel with the system (1.1), we consider the controlled system

$$(1.4) \quad \dot{z}(t) = A_{-1}z(t-1) + \int_{-1}^0 A_2(\theta) \dot{z}(t+\theta) d\theta + \int_{-1}^0 A_3(\theta) z(t+\theta) d\theta + Bu,$$

or the corresponding operator model

$$\dot{x}(t) = \mathcal{A}x(t) + \mathcal{B}u(t),$$

where $\mathcal{B}u = (Bu, 0)^T$. For this controlled system, the problem of spectrum assignment has been investigated mainly in order to stabilize it by state feedback $u(t) = \mathcal{F}x(t)$, where \mathcal{F} is a linear operator defined in M_2 . Depending on the assumption about the operator \mathcal{F} (bounded, \mathcal{A} -bounded, with domain $D(\mathcal{A})$, or not), and depending on the type of stabilizability needed (strong, exponential, asymptotic, regular), many important results have been obtained by several authors (see [14, 12, 7, 17] and the discussion in [20]).

In particular, when $B = I$, the identity in \mathbb{C}^n , and A_{-1} has a simple spectrum $\{\mu_1, \dots, \mu_n\}$, from the results in [20, 21, 17], it is possible to assign arbitrarily the spectrum of \mathcal{A} in the neighborhood of $\ln \mu_m$, where \ln is the complex logarithm multi-function, by a regular feedback (the neutral term A_{-1} is not modified). This consists, in fact, of the construction of matrices $A_2(\cdot), A_3(\cdot)$ to obtain the spectrum needed.

In this paper, we investigate an inverse problem:

What conditions must a sequence of complex numbers $\{\lambda\}$ and a sequence of vectors $\{v\}$ satisfy in order to be a sequence of roots of the characteristic equation $\det \Delta(\lambda) = 0$ and a sequence of degenerating vectors of the characteristic matrix $\Delta(\lambda)$ of equation (1.1), respectively, for some choice of matrices $A_{-1}, A_2(\theta), A_3(\theta)$?

The first part of the paper is devoted to this problem and is organized as follows.

We show that the assignment of eigenvectors and eigenvalues is equivalent to the existence of a linear operator \mathcal{P}_0 , bounded from $D(\mathcal{A})$ (with the graph norm) to \mathbb{C}^n , defined by

$$\mathcal{P}_0 \begin{pmatrix} y \\ \varphi(\cdot) \end{pmatrix} = \int_{-1}^0 A_2(\theta) \dot{\varphi}(\theta) d\theta + \int_{-1}^0 A_3(\theta) \varphi(\theta) d\theta,$$

such that $\mathcal{A} = \tilde{\mathcal{A}} + \mathcal{B}_0 \mathcal{P}_0$, where $\mathcal{B}_0 = (I, 0)$, has the spectral properties needed (eigenvalues and eigenvectors).

Then, we consider the matrix $F(\lambda) = I + \mathcal{P}_0 R(\tilde{\mathcal{A}}, \lambda) \mathcal{B}_0$. We show that the eigenvalues λ_0 of \mathcal{A} are the zeros of $\det F(\lambda)$ and the kernel of $\Delta(\lambda_0)$ is the kernel of $F(\lambda_0)$.

After that, using the Riesz basis property of eigenvectors of \mathcal{A} , we give a detailed analysis and solution of the *inverse spectral problem*. The main result may be summarized by the following theorem.

THEOREM 1.1. *Let μ_1, \dots, μ_n be distinct non-zero complex scalars and z_1, \dots, z_n a linear independent set in \mathbb{C}^n . For*

$$\tilde{\lambda}_k^m = \ln |\mu_m| + i(\text{Arg } \mu_m + 2\pi k), \quad m = 1, \dots, n, \quad k \in \mathbb{Z},$$

we consider an arbitrary set of distinct complex numbers $\{\lambda_k^m\} \cup \{\lambda_j^0\}_{j=1, \dots, n}$ such that $\sum_k \left| \lambda_k^m - \tilde{\lambda}_k^m \right|^2 < \infty$, $m = 1, \dots, n$ and an arbitrary set of vectors $\{w_k^m\} \cup \{w_j^0\}$ satisfying $\sum_k \|w_k^m - z_m\|^2 < \infty$, $m = 1, \dots, n$. Then, there are matrices $A_{-1}, A_2(\theta), A_3(\theta)$ such that:

- i) The scalars $\{\lambda_k^m, \lambda_j^0\}$ are simple roots of the equation $\det \Delta(\lambda) = 0$;*
- ii) $w_k^{m*} \Delta(\lambda_k^m) = 0$, $m = 1, \dots, n$; $k \in \mathbb{Z}$ and $w_j^{0*} \Delta(\lambda_j^0) = 0$, $j = 1, \dots, n$; except perhaps for a finite number of vectors w_k^m . For this last case, there are vectors \hat{w}_k^m arbitrarily close to the vectors w_k^m : $\hat{w}_k^{m*} \Delta(\lambda_k^m) = 0$.*

This theorem was announced in *Comptes Rendus Mathématique* [24].

As an application of this spectral assignment problem, we consider a vector moment problem via the solution of the exact controllability property for a corresponding neutral-type system (1.4) by an approach developed in [16]. This is the main purpose of the second part of the paper, namely Section 6.

A classic trigonometric moment problem is a set of equations

$$\int_0^T e^{\gamma_i t} v(t) dt = c_i, \quad i \in \mathbb{N},$$

where $\gamma_i \in \mathbb{C}$, the sequence $\{c_i\}$ is given and the function $v \in L_2(0, T)$ is unknown. The goal is to give conditions of solvability for all $\{c_i\} \in \ell_2$ and find a minimal interval of this solvability. Several works are devoted to this important problem. The approach is often based on the study of exponential families, which dates back to the works of Paley and Wiener [13]. Several authors have obtained important results in

this area (see for example [10, 8, 28]). In [1], there are several practical frameworks and useful results for our investigation.

Two of the authors of the present paper showed in [16] that the exact null-controllability problem of the controlled neutral-type system leads to a vector moment problem. This problem may be formulated in some particular cases as

$$(1.5) \quad s_k^m = \int_0^T e^{\lambda_k^m t} (b_{k,m}^1 u_1(t) + \dots + b_{k,m}^r u_r(t)) dt, \quad k \in \mathbb{Z}, m = 1, \dots, n.$$

What is important in this context is the fact that the numbers λ_k^m are the roots of the equation $\det \Delta(\lambda) = 0$ and the coefficients $b_{k,m}^j$ are expressed via the vectors w_k^m , $w_k^{m*} \Delta(\lambda_k^m) = 0$ by the formula $b_{k,m}^j = \langle b_j, w_k^m \rangle$, where $B = (b_1, \dots, b_r)$. Thus, the problem formulated above of spectral (eigenvalues-eigenvectors) assignment defines completely the vector moment corresponding to the problem of exact null-controllability. Roughly speaking, the null-controllability problem can be considered a problem of eigenfrequency extinguishing, where the sequence λ_k^m means the chosen frequencies and coefficients $b_{k,m}^j$ (vectors w_k^m) determine the contribution of the particular control inputs to the extinguishing of the frequency λ_k^m .

For those moment problems (1.5) that are related to the exact controllability property of the controlled neutral-type system, the solvability conditions and the minimal interval of solvability (minimal time of exact controllability) are found.

Here we consider a more general problem:

Starting with an abstract moment problem (1.5), and using the result of the first part, give conditions of the existence of a neutral-type system for which the exact controllability condition is equivalent (almost equivalent in some sense) to the vector moment problem.

This enables the solvability condition and the minimal interval to be given in the general case.

An illustrative example is provided.

2. The state operator as a perturbation. The state operator \mathcal{A} can be considered a perturbation of the operator $\tilde{\mathcal{A}}$, namely

$$\mathcal{A} \begin{pmatrix} y \\ \varphi(\cdot) \end{pmatrix} = \tilde{\mathcal{A}} \begin{pmatrix} y \\ \varphi(\cdot) \end{pmatrix} + \begin{pmatrix} \int_{-1}^0 A_2(\theta) \dot{\varphi}(\theta) d\theta + \int_{-1}^0 A_3(\theta) \varphi(\theta) d\theta \\ 0 \end{pmatrix}.$$

Let $\mathcal{B}_0 : \mathbb{C}^n \rightarrow M_2$ be given by

$$\mathcal{B}_0 y = \begin{pmatrix} y \\ 0 \end{pmatrix},$$

and $\mathcal{P}_0 : D(\mathcal{A}) \rightarrow \mathbb{C}^n$ by

$$(2.1) \quad \mathcal{P}_0 \begin{pmatrix} y \\ \varphi(\cdot) \end{pmatrix} = \int_{-1}^0 A_2(\theta) \dot{\varphi}(\theta) d\theta + \int_{-1}^0 A_3(\theta) \varphi(\theta) d\theta.$$

Then $\mathcal{A} = \tilde{\mathcal{A}} + \mathcal{B}_0 \mathcal{P}_0$. Denote by $X_{\mathcal{A}}$ the set $D(\mathcal{A})$ endowed with the graph norm.

LEMMA 2.1. *The linear bounded operator \mathcal{P}_0 browses the set of all linear bounded operators $\mathcal{L}(X_{\mathcal{A}}, \mathbb{C}^n)$ as $A_2(\cdot), A_3(\cdot)$ run over the set of $n \times n$ matrices with components from $L_2[-1, 0]$.*

Proof. An arbitrary linear operator Q from $\mathcal{L}(X_{\mathcal{A}}, \mathbb{C}^n)$ can be presented as

$$\begin{aligned} Q \begin{pmatrix} y \\ \varphi(\cdot) \end{pmatrix} &= Q_1 y + Q_2 \varphi(\cdot) \\ &= Q_1(\varphi(0) - A_{-1}\varphi(-1)) + \int_{-1}^0 \widehat{A}_2(\theta)\dot{\varphi}(\theta)d\theta + \int_{-1}^0 \widehat{A}_3(\theta)\varphi(\theta)d\theta, \end{aligned}$$

where $\widehat{A}_2(\cdot), \widehat{A}_3(\cdot)$ are $(n \times n)$ -matrices with component from $L_2[-1, 0]$ and Q_1 is a $(n \times n)$ matrix. Let us observe that

$$\begin{aligned} \varphi(-1) &= \int_{-1}^0 \theta\dot{\varphi}(\theta)d\theta + \int_{-1}^0 \varphi(\theta)d\theta, \\ \varphi(0) &= \int_{-1}^0 (\theta + 1)\dot{\varphi}(\theta)d\theta + \int_{-1}^0 \varphi(\theta)d\theta \end{aligned}$$

and denote

$$\begin{aligned} A_2(\theta) &= \widehat{A}_2(\theta) + (\theta + 1)Q_1 - \theta Q_1 A_{-1}, \\ A_3(\theta) &= \widehat{A}_3(\theta) + Q_1 - Q_1 A_{-1}. \end{aligned}$$

Then, with these notations, the operator Q may be written as

$$Q \begin{pmatrix} y \\ \varphi(\cdot) \end{pmatrix} = \int_{-1}^0 A_2(\theta)\dot{\varphi}(\theta)d\theta + \int_{-1}^0 A_3(\theta)\varphi(\theta)d\theta.$$

Hence formula (2.1) describes all the operators from $\mathcal{L}(X_{\mathcal{A}}, \mathbb{C}^n)$. \square

3. An equation for eigenvalues and eigenvectors: the spectral equation.

Consider the operator $\mathcal{A} = \widetilde{\mathcal{A}} + \mathcal{B}_0 \mathcal{P}_0$ and assume that λ_0 is an eigenvalue of \mathcal{A} and x_0 is a corresponding eigenvector, i.e.

$$(3.1) \quad (\widetilde{\mathcal{A}} + \mathcal{B}_0 \mathcal{P}_0)x_0 = \lambda_0 x_0.$$

Let us assume further that λ_0 does not belong to the spectrum of $\widetilde{\mathcal{A}}$ and denote by $R(\widetilde{\mathcal{A}}, \lambda_0) = (\widetilde{\mathcal{A}} - \lambda_0 I)^{-1}$. With this notation, (3.1) reads as

$$(3.2) \quad x_0 + R(\widetilde{\mathcal{A}}, \lambda_0)\mathcal{B}_0 \mathcal{P}_0 x_0 = 0.$$

Let us notice that $v_0 = \mathcal{P}_0 x_0 \neq 0$, because $\lambda_0 \notin \sigma(\widetilde{\mathcal{A}})$. Then applying operator \mathcal{P}_0 to the left-hand side of (3.2) we obtain

$$v_0 + \mathcal{P}_0 R(\widetilde{\mathcal{A}}, \lambda_0)\mathcal{B}_0 v_0 = 0.$$

This equality means that λ_0 is a point of singularity of the matrix-valued function

$$F(\lambda) = I + \mathcal{P}_0 R(\widetilde{\mathcal{A}}, \lambda)\mathcal{B}_0$$

and v_0 is a vector degenerating $F(\lambda_0)$ from the right.

In what follows, the left kernel of the matrix $F(\lambda_0)$ plays a significant role. Let us give a characterization of the vectors of this subspace.

PROPOSITION 3.1. *Let λ_0 not belong to $\sigma(\widetilde{\mathcal{A}})$. Then, the pair (λ_0, w_0) , $w_0 \in \mathbb{C}^n$, $w_0 \neq 0$, satisfies the spectral equation*

$$(3.3) \quad w_0^* F(\lambda_0) = 0.$$

if and only if λ_0 is a root of the characteristic equation $\det \Delta(\lambda) = 0$, where $\Delta(\lambda)$ is given in (1.3) and w_0^* is a row-vector in the left kernel of $\Delta(\lambda_0)$: $w_0^* \Delta(\lambda_0) = 0$.

Proof. In order to describe the vector w_0 , let us first find another form for the matrix $F(\lambda)$. For any $v \in \mathbb{C}^n$ we denote

$$R(\tilde{\mathcal{A}}, \lambda) \mathcal{B}_0 v = \begin{pmatrix} y \\ \varphi(\cdot) \end{pmatrix}, \quad \lambda \notin \sigma(\tilde{\mathcal{A}}),$$

then

$$(\tilde{\mathcal{A}} - \lambda I) \begin{pmatrix} y \\ \varphi(\cdot) \end{pmatrix} = \mathcal{B}_0 v = \begin{pmatrix} v \\ 0 \end{pmatrix}.$$

This gives $v = -\lambda y$ and $\frac{d\varphi(\theta)}{d\theta} - \lambda \varphi(\theta) = 0$. As $\begin{pmatrix} y \\ \varphi(\cdot) \end{pmatrix} \in D(\tilde{\mathcal{A}})$, we obtain $y = \varphi(0) - A_{-1} \varphi(-1)$. Therefore

$$\varphi(\theta) = d e^{\lambda \theta}, \quad d \in \mathbb{C}^n,$$

and

$$v = -\lambda(I - e^{-\lambda} A_{-1})d.$$

Since the matrix $(I - e^{-\lambda} A_{-1})$ is invertible ($\lambda \notin \sigma(\tilde{\mathcal{A}})$), we obtain

$$\varphi(\theta) = -\frac{e^{\lambda \theta}}{\lambda} (I - e^{-\lambda} A_{-1})^{-1} v,$$

and hence

$$R(\tilde{\mathcal{A}}, \lambda) \mathcal{B}_0 v = \begin{pmatrix} y \\ -\frac{e^{\lambda \theta}}{\lambda} (I - e^{-\lambda} A_{-1})^{-1} v \end{pmatrix}.$$

This formula and (2.1) implies

$$v + \mathcal{P}_0 R(\tilde{\mathcal{A}}, \lambda) \mathcal{B}_0 v = v - \left(\int_{-1}^0 e^{\lambda \theta} A_2(\theta) d\theta - \int_{-1}^0 \frac{e^{\lambda \theta}}{\lambda} A_3(\theta) d\theta \right) (I - e^{-\lambda} A_{-1})^{-1} v$$

and hence

$$F(\lambda)v = \Delta(\lambda) \frac{(I - e^{-\lambda} A_{-1})^{-1}}{\lambda} v,$$

Thus, the equality (3.3) for $\lambda_0 \notin \sigma(\tilde{\mathcal{A}})$ is equivalent to $w_0^* \Delta(\lambda_0) = 0$. \square

Proposition 3.1 means that the equation $w^* F(\lambda) = 0$ can be considered an equation whose roots $(\lambda, w) = (\lambda_0, w_0)$ describe all eigenvalues and (right) eigenvectors of the characteristic matrix $\Delta(\lambda)$. It is called the spectral equation.

4. A component-wise representation of the spectral equation. We need a more detailed expression of the spectral equation (3.3).

Let us recall the spectral properties of operators $\tilde{\mathcal{A}}$ and $\tilde{\mathcal{A}}^*$ obtained in [18, 19]. We will assume that the matrix A_{-1} has simple non-zero eigenvalues $\mu_1, \mu_2, \mu_3, \dots, \mu_n$. In this case the spectrum $\sigma(\tilde{\mathcal{A}})$ consists of simple eigenvalues which we denote by

$$\tilde{\lambda}_k^m = \ln |\mu_m| + i(\text{Arg } \mu_m + 2\pi k), \quad m = 1, \dots, n, \quad k \in \mathbb{Z},$$

and of eigenvalue $\tilde{\lambda}_0 = 0$. First, assume $\mu_m \neq 1$, $m = 1, \dots, n$. Then, the eigenvectors corresponding to $\tilde{\lambda}_k^m$ are of the form

$$(4.1) \quad \tilde{\varphi}_k^m = \begin{pmatrix} 0 \\ e^{\tilde{\lambda}_k^m \theta} y_m \end{pmatrix}, \quad k \in \mathbb{Z}, m = 1, \dots, n,$$

where y_1, \dots, y_n are eigenvectors of A_{-1} corresponding to $\mu_1, \mu_2, \dots, \mu_n$. The eigenspace corresponding to $\tilde{\lambda}_0 = 0$ is n dimensional and its basis is

$$(4.2) \quad \tilde{\varphi}_j^0 = \begin{pmatrix} (1 - \mu_j) y_j \\ y_j \end{pmatrix}, \quad j = 1, \dots, n.$$

If some μ_m say μ_1 equals 1, then $\tilde{\lambda}_0^1 = \tilde{\lambda}_0 = 0$. In this case, the eigenspace corresponding to 0 is $(n+1)$ -dimensional and its basis consists of n eigenvectors $\tilde{\varphi}_j^0$, $j = 1, \dots, n$, given by (4.2), and one root-vector

$$\tilde{\varphi}_0^1 = \begin{pmatrix} y_1 \\ \theta y_1 \end{pmatrix}, \quad \tilde{\mathcal{A}} \tilde{\varphi}_0^1 = \tilde{\varphi}_0^1.$$

All the vectors $\tilde{\varphi}_k^m$ given by (4.1), except $\tilde{\varphi}_1^0$, are still eigenvectors of $\tilde{\mathcal{A}}$ and correspond to eigenvalues $\tilde{\lambda}_k^m$. In both cases the family $\Phi = \{\tilde{\varphi}_k^m\} \cup \{\tilde{\varphi}_j^0\}$ forms a Riesz basis in the space M_2 . Denote by $\Psi = \{\tilde{\psi}_k^m\} \cup \{\tilde{\psi}_j^0\}$ the bi-orthogonal basis to Φ . Then

$$(4.3) \quad \tilde{\psi}_k^m = \begin{pmatrix} z_m / \overline{\tilde{\lambda}_k^m} \\ e^{-\overline{\tilde{\lambda}_k^m} \theta} z_m \end{pmatrix}, \quad m = 1, \dots, n, k \in \mathbb{Z} \text{ if } \tilde{\lambda}_0^1 \neq 0, \tilde{\psi}_0^1 = \begin{pmatrix} z_1 \\ 0 \end{pmatrix}, \text{ if } \tilde{\lambda}_0^1 = 0,$$

where $\overline{\tilde{\lambda}}$ is the complex conjugate of $\tilde{\lambda}$. Here z_m are eigenvectors of matrix A_{-1}^* bi-orthogonal to the eigenvectors y_m of A_{-1} , i.e. such that $\langle y_i, z_j \rangle = \delta_{ij}$. It is easy to see that $\tilde{\psi}_k^m$ are eigenvectors of the operator $\tilde{\mathcal{A}}^*$ corresponding to eigenvalues $\overline{\tilde{\lambda}_k^m}$.

In order to obtain a component-wise expression of the spectral equation (3.3), we need to rewrite the matrix $F(\lambda_0)$ in the basis Φ and the vector w_0^* in the basis $\{z_m, m = 1, \dots, n\}$.

In what follows, we shall use the notation

$$\tilde{\beta}_k^m = \begin{cases} \tilde{\lambda}_k^m, & \tilde{\lambda}_k^m \neq 0, \\ 1, & \tilde{\lambda}_k^m = 0, \end{cases} \quad m = 1, \dots, n, k \in \mathbb{Z}.$$

Let us observe that the expression $w_0^* \mathcal{P}_0$ is a linear bounded functional on the space $X_{\mathcal{A}}$, i.e. $w_0^* \mathcal{P}_0 \in \mathcal{L}(X_{\mathcal{A}}, \mathbb{C})$. The representation of w_0^* in the basis z_j is as follows:

$$w_0^* = \sum_j \alpha_j z_j^*.$$

Consider now n functionals $z_j^* \mathcal{P}_0 \in \mathcal{L}(X_{\mathcal{A}}, \mathbb{C})$, $j = 1, \dots, n$. They can be decomposed in the basis Ψ :

$$z_j^* \mathcal{P}_0 = \sum_{k,m} p_{k,m}^j \tilde{\psi}_k^m + \sum_i \tilde{p}_i^j \tilde{\psi}_i^0,$$

where

$$(4.4) \quad \sum_k \left| \frac{p_{k,m}^j}{\tilde{\beta}_k^m} \right|^2 < \infty, \quad m = 1, \dots, n.$$

PROPOSITION 4.1. *The pair (λ_0, w_0) satisfies the spectral equation (3.3) if and only if the following system of n equations is verified:*

$$(4.5) \quad \alpha_m = - \sum_{\substack{k \in \mathbb{Z} \\ j=1, \dots, n}} \alpha_j \left(\frac{p_{k,m}^j}{\tilde{\beta}_k^m} \times \frac{1}{\tilde{\lambda}_k^m - \lambda_0} \right), \quad m = 1, \dots, n,$$

where, for any fixed couple m, j , the needed n -tuple $\{p_{k,m}^j\}$ satisfies (4.4).

Proof. Let us first rewrite the expression $R(\tilde{\mathcal{A}}, \lambda_0)\mathcal{B}_0$. We present \mathcal{B}_0 as a matrix $\mathcal{B}_0 = (\mathbf{b}_1^0, \mathbf{b}_2^0, \dots, \mathbf{b}_n^0)$ with infinite columns \mathbf{b}_i^0 which are vectors from M_2 of the form

$$\mathbf{b}_i^0 = \begin{pmatrix} e_i \\ 0 \end{pmatrix}, \quad i = 1, \dots, n,$$

where e_i is the canonical basis of \mathbb{C}^n . Then

$$\mathbf{b}_i^0 = \sum_{k,m} \langle \mathbf{b}_i^0, \tilde{\psi}_k^m \rangle \tilde{\varphi}_k^m + \sum_j \langle \mathbf{b}_i^0, \tilde{\psi}_j^0 \rangle \tilde{\varphi}_j^0, \quad i = 1, \dots, n,$$

and in the case $\mu_m \neq 1$, $m = 1, \dots, n$, we have

$$R(\tilde{\mathcal{A}}, \lambda_0)\mathbf{b}_i^0 = \sum_{k,m} \frac{1}{\tilde{\lambda}_k^m - \lambda_0} \langle \mathbf{b}_i^0, \tilde{\psi}_k^m \rangle \tilde{\varphi}_k^m - \sum_j \frac{1}{\lambda_0} \langle \mathbf{b}_i^0, \tilde{\psi}_j^0 \rangle \tilde{\varphi}_j^0, \quad i = 1, \dots, n.$$

Taking into account the form of eigenvectors (4.3) we find that for all $m = 1, \dots, n$

$$\left(\langle \mathbf{b}_1^0, \tilde{\psi}_k^m \rangle, \dots, \langle \mathbf{b}_n^0, \tilde{\psi}_k^m \rangle \right) = \frac{1}{\tilde{\lambda}_k^m} (\langle e_1, z_m \rangle, \dots, \langle e_n, z_m \rangle) = z_m^* / \tilde{\lambda}_k^m.$$

Thus, we obtain

$$(4.6) \quad R(\tilde{\mathcal{A}}, \lambda_0)\mathcal{B}_0 = \sum_{k,m} \frac{1}{\tilde{\lambda}_k^m - \lambda_0} \times \frac{1}{\tilde{\lambda}_k^m} \tilde{\varphi}_k^m z_m^* - \sum_j \frac{1}{\lambda_0} \tilde{\varphi}_j^0 \left(\langle \mathbf{b}_1^0, \tilde{\psi}_j^0 \rangle, \dots, \langle \mathbf{b}_n^0, \tilde{\psi}_j^0 \rangle \right),$$

if all the numbers $\tilde{\lambda}_k^m \neq 0$. If $\mu_1 = 1$ and $\tilde{\lambda}_0^1 = 0$, then in the sum (4.6) the term corresponding to $k = 1$, $m = 1$, is replaced by

$$\left(\frac{1}{\tilde{\lambda}_0^1 - \lambda_0} \tilde{\varphi}_0^1 - \frac{1}{(\tilde{\lambda}_0^1 - \lambda_0)^2} \tilde{\varphi}_1^0 \right) z_1^*.$$

In what follows, we shall assume $\tilde{p}_i^j = 0$, $i = 1, \dots, n$. This means that from now on we consider perturbations \mathcal{P}_0 satisfying the condition

$$(4.7) \quad \int_{-1}^0 A_3(\theta) d\theta = 0.$$

Then we have

$$w_0^* \mathcal{P}_0 = \sum_j \alpha_j z_j^* \mathcal{P}_0 = \sum_j \alpha_j \sum_{k,m} p_{k,m}^j \tilde{\psi}_k^m.$$

From this relation and expression (4.6) we obtain the equality

$$\begin{aligned} w_0^* \mathcal{P}_0 \mathcal{R}(\tilde{\mathcal{A}}, \lambda_0) \mathcal{B}_0 &= \sum_m \left\langle \sum_k \frac{1}{\tilde{\beta}_k^m} \times \frac{1}{\tilde{\lambda}_k^m - \lambda_0} \tilde{\varphi}_k^m, \sum_j \alpha_j \sum_{k_0, m_0} \tilde{\beta}_{k_0, m_0}^j \tilde{\psi}_{k_0}^{m_0} \right\rangle z_m^* \\ &= \sum_j \alpha_j \sum_{k_0, m_0} \frac{p_{k_0, m_0}^j}{\tilde{\beta}_{k_0}^{m_0}} \times \frac{1}{\tilde{\lambda}_{k_0}^{m_0} - \lambda_0} z_m^*. \end{aligned}$$

With these notations, equation (3.3) reads

$$0 = w_0^* \left(I + \mathcal{P}_0 \mathcal{R}(\tilde{\mathcal{A}}, \lambda_0) \mathcal{B}_0 \right) = \sum_m \alpha_m z_m^* + \sum_m \left(\sum_{j,k} \alpha_j \frac{p_{k,m}^j}{\tilde{\beta}_k^m} \times \frac{1}{\tilde{\lambda}_k^m - \lambda_0} \right) z_m^*.$$

Thus, the condition for a pair (λ_0, w_0) to satisfy the spectral equation can be rewritten in the form of the following system of n equations:

$$\alpha_m = - \sum_{\substack{k \in \mathbb{Z} \\ j=1, \dots, n}} \alpha_j \left(\frac{p_{k,m}^j}{\tilde{\beta}_k^m} \times \frac{1}{\tilde{\lambda}_k^m - \lambda_0} \right), \quad m = 1, \dots, n,$$

where, for any fixed couple m, j , the needed n -tuple $\{p_{k,m}^j\}$ satisfies (4.4). \square

5. Conditions for the spectral assignment. Now we discuss the following question:

What conditions must a sequence of complex numbers $\{\lambda\}$ and a sequence of vectors $\{v\}$ satisfy in order to be a sequence of roots of the characteristic equation $\det \Delta(\lambda) = 0$ and a sequence of degenerating vectors of the characteristic matrix $\Delta(\lambda)$ of equation (1.1), respectively, for some choice of matrices $A_{-1}, A_2(\theta), A_3(\theta)$?

Let us remember that we assumed earlier that all eigenvalues of matrix A_{-1} are also simple. Starting then from distinct non-zero eigenvalues $\mu_m, j = 1, \dots, n$, we are looking for an operator \mathcal{A} with simple eigenvalues only. These eigenvalues can be numbered as $\{\lambda_k^m\} \cup \{\lambda_j^0\}$, $m, j = 1, \dots, n; k \in \mathbb{Z}$, where (see [19, Theorem 1]) the sequence $\{\lambda_k^m\}$ satisfies

$$(5.1) \quad \sum_{k,m} \left| \lambda_k^m - \tilde{\lambda}_k^m \right|^2 < \infty, \quad \tilde{\lambda}_k^m = \ln |\mu_m| + i(\text{Arg } \mu_m + 2\pi k).$$

Denote by $\{\varphi_k^m\} \cup \{\varphi_j^0\}$, $m, j = 1, \dots, n; k \in \mathbb{Z}$, the corresponding eigenvectors of \mathcal{A} . Then (see [19, Lemma 13, Theorem 15]) these vectors form a Riesz basis in M_2 that is quadratically close to the basis $\{\tilde{\varphi}_k^m\} \cup \{\tilde{\varphi}_j^0\}$ if we assume that the corresponding elements have the same norm. Eigenvector $\{\varphi\}$ has the form

$$\varphi = \begin{pmatrix} v - e^{-\lambda} A_{-1} v \\ e^{\lambda \theta} v \end{pmatrix}$$

with $\Delta(\lambda)v = 0$. Therefore, the fact that the bases $\{\varphi\}$ and $\{\tilde{\varphi}\}$ are quadratically close implies the condition

$$(5.2) \quad \sum_k \|v_k^m - y_m\|^2 < \infty, \quad m = 1, \dots, n,$$

where $\Delta(\lambda_k^m)v_k^m = 0$, $m = 1, \dots, n$; $k \in \mathbb{Z}$, and y_m are eigenvectors of A_{-1} corresponding to μ_m as in (4.1). If we apply the same arguments for the dual system

$$(5.3) \quad \dot{z}(t) = A_{-1}^* \dot{z}(t-1) + \int_{-1}^0 A_2^*(\theta) \dot{z}(t+\theta) d\theta + \int_{-1}^0 A_3^*(\theta) z(t+\theta) d\theta,$$

then we obtain the symmetric condition

$$(5.4) \quad \sum_k \|w_k^m - z_m\|^2 < \infty, \quad m = 1, \dots, n,$$

where $(w_k^m)^* \Delta(\lambda_k^m) = 0$, $m = 1, \dots, n$; $k \in \mathbb{Z}$.

Our further goal is to show that conditions (5.1) and (5.4) or (5.1) and (5.2) are almost sufficient for couples of sequences $\{\lambda\}$ and $\{w\}$ or $\{\lambda\}$ and $\{v\}$ to be spectral ones for the system (1.1).

5.1. An operator form for the spectral equation. Let us consider a sequence of pairwise distinct complex numbers $\{\lambda_{k_0}^{m_0}\}$, $m_0 = 1, \dots, n$; $k_0 \in \mathbb{Z}$, satisfying (5.1). We also assume that the index numbering of $\{\lambda\}$ is such that if $\lambda_{k_0}^{m_0} = \tilde{\lambda}_k^m$ then $m_0 = m$, $k_0 = k$. To begin with, however, we put $\lambda_{k_0}^{m_0} \neq \tilde{\lambda}_k^m$, for all $k, k_0 \in \mathbb{Z}$, $m, m_0 = 1, \dots, n$.

Now let $\{\lambda_{k_0}^{m_0}\}$ be simple eigenvalues of operator $\mathcal{A} = \tilde{\mathcal{A}} + \mathcal{B}_0 \mathcal{P}_0$, where \mathcal{P}_0 is given by (2.1), in which matrix $A_3(\theta)$ satisfies (4.7). Then $\Delta(\lambda_{k_0}^{m_0}) = 0$ and let $\{w_{k_0}^{m_0}\}$ be a sequence of the left degenerating vectors of $\Delta(\lambda_{k_0}^{m_0})$, i.e.

$$(w_{k_0}^{m_0})^* \Delta(\lambda_{k_0}^{m_0}) = 0.$$

We assume that the sequence $w_{k_0}^{m_0}$ satisfies (5.4). For all indices $m_0 = 1, \dots, n$; $k_0 \in \mathbb{Z}$, consider decompositions

$$(w_{k_0}^{m_0})^* = \sum_{j=1}^n \alpha_{j m_0}^{k_0} z_j^*.$$

Then condition (5.4) is equivalent to

$$(5.5) \quad \sum_{k_0} |\alpha_{m m_0}^{k_0}|^2 < \infty, \quad m \neq m_0, \quad \sum_{k_0} |\alpha_{m m}^{k_0} - 1|^2 < \infty, \quad m, m_0 = 1, \dots, n.$$

Let us now rewrite relations (4.5) for $\lambda_0 = \lambda_{k_0}^{m_0}$ and $w_0 = w_{k_0}^{m_0}$.

We consider the space ℓ_2 of infinite sequences (columns) indexed as $\{a_k\}_{k \in \mathbb{Z}}$ with a scalar product defined by $\langle \{a_k\}, \{b_k\} \rangle = \sum_k a_k \overline{b_k}$. From the relation (4.4), we obtain that vectors

$$p_m^j = - \left\{ \begin{array}{c} \overline{p}_{k,m}^j \\ \overline{\beta}_k \end{array} \right\}_{k \in \mathbb{Z}, j, m=1, \dots, n}$$

belong to ℓ_2 . One can also easily see that

$$\left\{ \frac{1}{\widetilde{\lambda}_k^m - \lambda_{k_0}^{m_0}} \right\}_{k \in \mathbb{Z}} \in \ell_2, \quad m, m_0 = 1, \dots, n; k_0 \in \mathbb{Z}.$$

Then, putting $\lambda_0 = \lambda_{k_0}^{m_0}$ and $w_0 = w_{k_0}^{m_0}$ in the equations (4.5), we obtain

$$(5.6) \quad \alpha_{mm_0}^{k_0} = \sum_{j=1}^n \alpha_{jm_0}^{k_0} \left\langle \left\{ \frac{1}{\widetilde{\lambda}_k^m - \lambda_{k_0}^{m_0}} \right\}, p_m^j \right\rangle, \quad m, m_0 = 1, \dots, n; k_0 \in \mathbb{Z}.$$

We would now like to rewrite relation (5.6) in a vector-matrix abstract form. In order to do that, we introduce a more convenient notation. Denote

$$\alpha_{mm_0} = \{ \alpha_{mm_0}^{k_0} \}_{k_0 \in \mathbb{Z}}, \quad m, m_0 = 1, \dots, n.$$

By $S_{mm_0} = \{ s_{k_0 k}^{mm_0} \}_{k, k_0 \in \mathbb{Z}}$, $m, m_0 = 1, \dots, n$, we denote infinite matrices with elements

$$s_{k_0 k}^{mm_0} = \frac{1}{\widetilde{\lambda}_k^m - \lambda_{k_0}^{m_0}},$$

and by A_{jm_0} , $j, m_0 = 1, \dots, n$, infinite diagonal matrices

$$A_{jm_0} = \text{diag} \left\{ \alpha_{jm_0}^{k_0} \right\}_{k_0 \in \mathbb{Z}}.$$

With these notations, relations (5.6) can be rewritten as

$$(5.7) \quad \sum_{j=1}^n A_{jm_0} S_{mm_0} p_m^j = \alpha_{mm_0},$$

$m, m_0 = 1, \dots, n$. Now let us fix the index m and consider n equations (5.7) with this index and $m_0 = 1, 2, \dots, n$. Consider another infinite diagonal matrix

$$\Lambda_m = \text{diag} \left\{ \widetilde{\lambda}_k^m - \lambda_k^m \right\}_{k \in \mathbb{Z}},$$

and multiply both sides of the m -th equality (5.7) (for $m_0 = m$) by this matrix from the left. This gives the following system of equalities

$$(5.8) \quad \begin{cases} \sum_{j=1}^n A_{jm_0} S_{mm_0} p_m^j = \alpha_{mm_0}, & m_0 = 1, \dots, n, m_0 \neq m, \\ \sum_{j=1}^n A_{jm} \Lambda_m S_{mm} p_m^j = \Lambda_m \alpha_{mm}, \end{cases}$$

where we use the fact that diagonal matrices commute: $\Lambda_m A_{jm} = A_{jm} \Lambda_m$. Finally, we introduce block matrix operators

$$D_m = \begin{bmatrix} A_{11} S_{m1} & \dots & A_{m1} S_{m1} & \dots & A_{n1} S_{m1} \\ \vdots & \ddots & \vdots & & \vdots \\ A_{1m} \Lambda_m S_{mm} & \dots & A_{mm} \Lambda_m S_{mm} & \dots & A_{nm} \Lambda_m S_{mm} \\ \vdots & & \vdots & \ddots & \vdots \\ A_{1n} S_{mn} & \dots & A_{mn} S_{mn} & \dots & A_{nn} S_{mn} \end{bmatrix}, \quad m = 1, \dots, n,$$

and present the equations (5.8) in the form

$$D_m \begin{bmatrix} p_m^1 \\ \vdots \\ p_m^m \\ \vdots \\ p_m^n \end{bmatrix} = \begin{bmatrix} \alpha_{m1} \\ \vdots \\ \Lambda_m \alpha_{mm} \\ \vdots \\ \alpha_{mn} \end{bmatrix}.$$

Let us observe that both vectors $(p_m^1, \dots, p_m^n)^T$ and $(\alpha_{m1} \dots \Lambda_m \alpha_{mm} \dots \alpha_{mn})^T$ belong to $\ell_2^n = \underbrace{\ell_2 \times \ell_2 \times \dots \times \ell_2}_{n \text{ times}}$ (see (4.4),(5.5)). Therefore the system (5.8) is solvable if

and only if the vector $(\alpha_{m1}, \dots, \Lambda_m \alpha_{mm}, \dots, \alpha_{mn})^T$ belongs to the image of operator D_m as an operator from ℓ_2^n to ℓ_2^n . In the following, we show that, for all sequences $\{\lambda\}$ satisfying (5.1), and for almost all sequences $\{w\}$ satisfying (5.4), operators $D_m, m = 1, \dots, n$, are bounded and have bounded inverse operators from ℓ_2^n to ℓ_2^n . This means that the spectral assignment problem is solvable.

5.2. Characterization of the spectral assignment. In what follows, we need a proposition, that characterizes a Riesz basis in $L_2(0, 1)$.

PROPOSITION 5.1. *Let $\{\lambda_k\}_{k \in \mathbb{Z}}$ be a sequence such that*

$$\sum_{k \in \mathbb{Z}} |\lambda_k - a + i(b + 2\pi k)|^2 < \infty,$$

for some $a, b \in \mathbb{R}$. Then the family $\{e^{\lambda_k t}, k \in \mathbb{Z}\}$ forms a Riesz basis in $L_2(0, 1)$.

There are several ways to prove this classic result (see [1]). It may be obtained, for example, from the Paley-Wiener theorem [13] and Lemma II.4.11 [1].

Next we prove the following preliminary result.

LEMMA 5.2. *1. For $m \neq m_0$ linear operators $S_{mm_0} : \ell_2 \rightarrow \ell_2$ are bounded and have bounded inverses. 2. The linear operator $\Lambda_m S_{mm} : \ell_2 \rightarrow \ell_2$ is a bounded operator and has a bounded inverse.*

Proof. Let $\{\varphi_k\}, \{\tilde{\varphi}_k\}, k \in \mathbb{Z}$, be two Riesz bases of a Hilbert space H and let R be a bounded operator with a bounded inverse, such that $R\varphi_k = \tilde{\varphi}_k, k \in \mathbb{Z}$.

For $f \in H$, we have

$$f = \sum_j a_j \varphi_j, \quad Rf = \sum_j a_j R\varphi_j.$$

Then

$$R\varphi_j = \tilde{\varphi}_j = \sum_k c_{jk} \varphi_k = \sum_k \langle \tilde{\varphi}_j, \psi_k \rangle \varphi_k, \quad j \in \mathbb{Z},$$

where $\{\psi_k\}_{k \in \mathbb{Z}}$ is the bi-orthogonal with respect to the basis $\{\varphi_k\}_{k \in \mathbb{Z}}$. Hence

$$Rf = \sum_j a_j \sum_k \langle \tilde{\varphi}_j, \psi_k \rangle \varphi_k = \sum_k \sum_j a_j \langle \tilde{\varphi}_j, \psi_k \rangle \varphi_k = \sum_k b_k \varphi_k,$$

where $b_k = \sum_j a_j \langle \tilde{\varphi}_j, \psi_k \rangle$.

This means that the infinite matrix \hat{R} corresponding to R in the basis $\{\varphi_k\}$ is of the form

$$\hat{R} = \{\hat{r}_{kj} = \langle \tilde{\varphi}_j, \psi_k \rangle\}_{\substack{k \in \mathbb{Z} \\ j \in \mathbb{Z}}},$$

where

$$\widehat{R} \begin{bmatrix} \vdots \\ a_{-1} \\ a_0 \\ a_1 \\ \vdots \end{bmatrix} = \begin{bmatrix} \vdots \\ b_{-1} \\ b_0 \\ b_1 \\ \vdots \end{bmatrix}, \quad \{a_j\}, \{b_j\} \in \ell_2.$$

Let now $H = L_2(0, 1)$ and $\{\tilde{\varphi}_k\}_{k \in \mathbb{Z}}$ be a Riesz basis of the form $\tilde{\varphi}_k = e^{\tilde{\lambda}_k^m t}$ for some $m = 1, \dots, n$. Let now $\{\varphi_k\}_{k \in \mathbb{Z}}$ be a Riesz basis that is bi-orthogonal to $\{\psi_k = e^{-\lambda_k^{m_0} t}\}_{k \in \mathbb{Z}}$ for some $m_0 = 1, \dots, n$ (the fact that $\{\psi_k\}_{k \in \mathbb{Z}}$ is a Riesz basis of $L_2(0, 1)$ follows from Proposition 5.1). One has

$$\begin{aligned} \langle \tilde{\varphi}_j, \psi_k \rangle &= \int_{-1}^0 e^{\tilde{\lambda}_j^m t} e^{-\lambda_k^{m_0} t} dt = \frac{1}{\tilde{\lambda}_j^m - \lambda_k^{m_0}} \left(e^{\tilde{\lambda}_j^m - \lambda_k^{m_0}} - 1 \right) \\ &= \frac{1}{\tilde{\lambda}_j^m - \lambda_k^{m_0}} \left(\mu_m e^{-\lambda_k^{m_0}} - 1 \right), \end{aligned}$$

i.e. $\widehat{R} = \{\hat{r}_{kj}\}_{\substack{k \in \mathbb{Z} \\ j \in \mathbb{Z}}}$, where

$$\hat{r}_{kj} = s_{kj} \left(\mu_m e^{-\lambda_k^{m_0}} - 1 \right), \quad k, j \in \mathbb{Z}.$$

Thus

$$\widehat{R} = \mathcal{E}_{mm_0} S_{mm_0},$$

where \mathcal{E}_{mm_0} is the infinite matrix

$$\mathcal{E}_{mm_0} = \begin{bmatrix} \ddots & \dots & \dots & \dots & \dots \\ \vdots & \mu_m e^{-\lambda_{-1}^{m_0}} - 1 & 0 & 0 & \vdots \\ \vdots & 0 & \mu_m e^{-\lambda_0^{m_0}} - 1 & 0 & \vdots \\ \vdots & 0 & 0 & \mu_m e^{-\lambda_1^{m_0}} - 1 & \vdots \\ \dots & \dots & \dots & \dots & \ddots \end{bmatrix}.$$

Hence, we have the following alternative:

1. If $m_0 \neq m$, then the sequence $\left\{ \mu_m e^{-\lambda_k^{m_0}} - 1 \right\}_{k \in \mathbb{Z}}$ is bounded and separated from 0, i.e. $\mathcal{E}_{mm_0} : \ell_2 \rightarrow \ell_2$ is a bounded operator with a bounded inverse. Hence,

$$(5.9) \quad S_{mm_0} = \mathcal{E}_{mm_0}^{-1} \widehat{R}.$$

2. If $m = m_0$, then $\mu_m e^{-\lambda_k^m} \rightarrow 1$, $k \rightarrow \infty$. Moreover,

$$\begin{aligned} \mu_m e^{-\lambda_k^m} - 1 &= e^{\tilde{\lambda}_k^m - \lambda_k^m} - 1 \\ &= \left(1 + \left(\tilde{\lambda}_k^m - \lambda_k^m \right) + \dots + \frac{\left(\tilde{\lambda}_k^m - \lambda_k^m \right)^s}{s!} + \dots \right) - 1 \\ &= \left(\tilde{\lambda}_k^m - \lambda_k^m \right) + o\left(\tilde{\lambda}_k^m - \lambda_k^m \right). \end{aligned}$$

Therefore,

$$\mathcal{E}_{mm} = \Lambda_m Q_m = Q_m \Lambda_m,$$

where $Q_m = \text{diag} \left(1 + O(\tilde{\lambda}_k^m - \lambda_k^m) \right)_{k \in \mathbb{Z}}$ has a bounded inverse, so

$$(5.10) \quad \Lambda_m S_{mm} = Q_m^{-1} \hat{R}.$$

From (5.9) and (5.10), it follows that S_{mm_0} , $m \neq m_0$ and $\Lambda_m S_{mm}$ are bounded and have bounded inverses. \square

REMARK 5.3. *In our previous consideration we assumed implicitly that our sequences $\{\lambda_{k_0}^{m_0}\}_{k_0 \in \mathbb{Z}}$ are different from $\{\tilde{\lambda}_k^m\}_{k \in \mathbb{Z}}$, i.e. $\tilde{\lambda}_k^m \neq \lambda_{k_0}^{m_0}$ for all $k, k_0 \in \mathbb{Z}$, $m, m_0 \in \{1, \dots, n\}$ in particular $\lambda_k^m \neq \tilde{\lambda}_k^m$ for every $k \in \mathbb{Z}$, $m \in \{1, \dots, n\}$.*

Now let us allow $\lambda_k^m = \tilde{\lambda}_k^m$ for some indices $k \in I \subset \mathbb{Z}$. Note that, in this case, the operators S_{mm_0} , $m_0 \neq m$, are still well-defined and the operator $\Lambda_m S_{mm}$ can also be well-defined if we define its components as limits of the corresponding components when $\lambda_k^m \rightarrow \tilde{\lambda}_k^m$, $k \in I$. This means that for $k \in I$ all non-diagonal elements of the k -th line of $\Lambda_m S_{mm}$ equal 0 and the diagonal elements equal 1. Besides, S_{mm_0} for $m_0 \neq m$ and $\Lambda_m S_{mm}$ remain bounded with bounded inverse operators since formulas (5.9) and (5.10) also remain true when $\lambda_k^m = \tilde{\lambda}_k^m$. Finally, if we consider the dependence $\Lambda_m S_{mm}$ of the sequence $\{\lambda_k^m\}_{k \in \mathbb{Z}}$, one can easily prove that

$$\Lambda_m S_{mm} (\{\lambda_k^m\}) \rightarrow \Lambda_m S_{mm} (\{\tilde{\lambda}_k^m\})$$

as

$$\sum_k |\lambda_k^m - \tilde{\lambda}_k^m|^2 \rightarrow 0.$$

In other words, the operators $\Lambda_m S_{mm}$ and consequently their inverse $(\Lambda_m S_{mm})^{-1}$, depend continuously on sequences $\{\lambda_k^m\}_{k \in \mathbb{Z}}$ of the set

$$\left\{ \{\lambda_k^m\} : \sum_k |\lambda_k^m - \tilde{\lambda}_k^m|^2 < \infty \right\}.$$

Now we are ready to prove our main results on the spectral assignment.

THEOREM 5.4. *Let $\mu_1, \mu_2, \dots, \mu_n$ be different non-zero complex numbers and z_1, z_2, \dots, z_n be non-zero n -dimensional linear independent vectors. Denote*

$$\tilde{\lambda}_k^m = \ln |\mu_m| + i(\text{Arg } \mu_m + 2\pi k), \quad m = 1, \dots, n, \quad k \in \mathbb{Z}.$$

Let us consider an arbitrary sequence of different complex numbers $\{\lambda_k^m\}_{k \in \mathbb{Z}, m=1, \dots, n}$ such that

$$\sum_k |\lambda_k^m - \tilde{\lambda}_k^m|^2 < \infty, \quad m = 1, \dots, n.$$

Then there is a small enough $\varepsilon > 0$ such that for any sequence of non-zero vectors $\{d_k^m\}_{k \in \mathbb{Z}, m=1, \dots, n}$ satisfying

$$\sum_k \|d_k^m - z_m\|^2 < \varepsilon, \quad m = 1, \dots, n$$

one can choose matrices $A_{-1}, A_2(\theta), A_3(\theta)$ such that for the system (1.1), with these matrices, the following two conditions hold:

- i) all the numbers $\{\lambda_k^m\}$ are roots of the characteristic equation $\det \Delta(\lambda) = 0$, $k \in \mathbb{Z}$, $m = 1, \dots, n$,
- ii) d_k^m are right degenerating vectors for the matrix $\Delta(\lambda_k^m) : d_k^{m*} \Delta(\lambda_k^m) = 0$, $m = 1, \dots, n$; $k \in \mathbb{Z}$.

Such a choice is unique if we put the following additional condition on the matrix $A_3(\theta)$:

$$(C) \quad \int_{-1}^0 A_3(\theta) d\theta = 0.$$

Proof. First, we denote by A_{-1} the matrix uniquely defined by the relations:

$$z_m^* A_{-1} = \mu_m z_m^*, \quad m = 1, \dots, n,$$

and denote by $\{y_j\}_{j=1, \dots, n}$ the bi-orthogonal basis with respect to $\{z_j\}_{j=1, \dots, n}$ in \mathbb{C}^n . Then the corresponding operator $\tilde{\mathcal{A}}$, generated by the matrix A_{-1} , has eigenvalues $\tilde{\lambda}_k^m$, $m = 1, \dots, n$, $k \in \mathbb{Z}$; $\tilde{\lambda}_0 = 0$ and possesses a Riesz basis of eigenvectors of $\{\tilde{\varphi}_k^m\}_{k \in \mathbb{Z}} \cup \{\tilde{\varphi}_j^0\}_{j=1, \dots, n}$. In the case when all $\mu_m \neq 1$, $m = 1, \dots, n$, the corresponding eigenvectors of $\tilde{\mathcal{A}}$ are

$$(5.11) \quad \begin{cases} \tilde{\varphi}_k^m = \begin{pmatrix} 0 \\ e^{\tilde{\lambda}_k^m \theta} y_m \end{pmatrix}, & \tilde{\mathcal{A}} \tilde{\varphi}_k^m = \tilde{\lambda}_k^m \tilde{\varphi}_k^m, \quad m = 1, \dots, n; \quad k \in \mathbb{Z}, \\ \tilde{\varphi}_j^0 = \begin{pmatrix} y_j - A_{-1} y_j \\ y_j \end{pmatrix}, & \tilde{\mathcal{A}} \tilde{\varphi}_j^0 = 0 \quad j = 1, \dots, n. \end{cases}$$

In the case $\mu_1 = 1$, the vector

$$\varphi_0^1 = \begin{pmatrix} A_{-1} y_1 \\ \theta y_1 \end{pmatrix}, \quad j = 1, \dots, n,$$

is a generalized eigenvector of $\tilde{\mathcal{A}}$ corresponding to $\tilde{\lambda}_0$ and the other $\tilde{\varphi}_k^m$, $\tilde{\varphi}_j^0$ are given by formula (5.11). Let us show that there is a choice of a bounded operator $\mathcal{P}_0 : X_{\tilde{\mathcal{A}}} \rightarrow \mathbb{C}^n$ (or equivalently a choice of matrices $A_2(\theta), A_3(\theta)$) such that

$$(5.12) \quad \lambda_{k_0}^{m_0} \in \sigma(\tilde{\mathcal{A}} + \mathcal{B}_0 \mathcal{P}_0),$$

or equivalently $\det \Delta(\lambda_{k_0}^{m_0}) = 0$, and

$$(5.13) \quad d_{k_0}^{m_0*} \Delta(\lambda_{k_0}^{m_0}) = 0, \quad m = 1, \dots, n; \quad k \in \mathbb{Z}.$$

We represent vectors $d_{k_0}^{m_0}$ in the basis $\{z_j\}_{j=1, \dots, n}$, namely

$$d_{k_0}^{m_0} = \sum_{m=1}^n \alpha_{m m_0}^{k_0} z_m, \quad k_0 \in \mathbb{Z}; \quad m, m_0 = 1, \dots, n.$$

With these notations the condition

$$\sum_{k_0} \|d_{k_0}^m - z_m\|^2 < \infty, \quad m = 1, \dots, n$$

implies

$$\sum_{k_0} |\alpha_{mm_0}^{k_0}|^2 < \infty, \quad m \neq m_0; \quad \sum_{k_0} |\alpha_{mm}^{k_0} - 1|^2 < \infty, \quad m = 1, \dots, n.$$

and these sums tend to zero as

$$(5.14) \quad \sum_{k_0} \|d_{k_0}^m - z_m\|^2 \rightarrow 0.$$

Therefore, under condition (5.14), the operators D_m , $m = 1, \dots, n$ tend to the block-diagonal operators

$$\widehat{D}_m = \begin{bmatrix} S_{m1} & 0 & \dots & 0 & \dots & 0 \\ \vdots & \vdots & \vdots & \vdots & & \vdots \\ 0 & 0 & \dots & \Lambda_m S_{mm} & \dots & 0 \\ \vdots & \vdots & \vdots & \vdots & \vdots & \vdots \\ 0 & 0 & \dots & 0 & \dots & S_{mn} \end{bmatrix}$$

which have a bounded inverse due to Lemma 5.2. This means that for a small enough $\varepsilon > 0$, the inequality $\sum_k \|d_k^m - z_m\|^2 < \varepsilon$ implies that operators D_m , $m = 1, \dots, n$

have bounded inverses. If numbers $\{\lambda_k^m\}$ are different from $\{\widetilde{\lambda}_k^m\}$, this means that there is a bounded operator $\mathcal{P}_0 : X_{\mathcal{A}} \rightarrow \mathbb{C}^n$ for which the relations (5.12) and (5.13) are satisfied. Besides, this operator is unique if we also require the additional assumption: $\mathcal{P}_0 \widetilde{\varphi}_j^0 = 0$, $j = 1, \dots, n$, which is equivalent to condition **(C)** of the Theorem. If we allow coincidences $\lambda_k^m = \widetilde{\lambda}_k^m$ for some indices $\{k, m\} \in \mathbb{I}$, we need to use the continuous dependence of operators D_m on the sequence $\{\lambda_k^m\}$ (see Remark 5.3). We approximate $\{\lambda_k^m\}$ by $\{\lambda_k^m\}$ ($\sum_k |\lambda_k^m - \widetilde{\lambda}_k^m|^2 \rightarrow 0$) such that $\{\lambda_k^m\} \neq \{\widetilde{\lambda}_k^m\}$. Since the conditions (5.12) and (5.13) are satisfied for the operator $\mathcal{P}_0(\{\lambda_k^m\})$ they are also satisfied for $\mathcal{P}_0(\{\widetilde{\lambda}_k^m\})$. This completes the proof. \square

LEMMA 5.5. *Let $\{\lambda_k^m\}$ be a given sequence such that $\sum_k |\lambda_k^m - \widetilde{\lambda}_k^m|^2 < \infty$ and $\{\widehat{\alpha}_{mm_0}^{k_0}\}$ is an arbitrary sequence satisfying*

$$\sum_{k_0} |\widehat{\alpha}_{mm_0}^{k_0}|^2 < \infty, \quad m \neq m_0; \quad \sum_{k_0} |\widehat{\alpha}_{mm}^{k_0} - 1|^2 < \infty.$$

Then for any $\varepsilon > 0$ and $m = 1, \dots, n$ there is a sequence $\{\alpha_{mm_0}^{k_0}\}$ satisfying

$$\sum_{k_0} |\alpha_{mm_0}^{k_0} - \widehat{\alpha}_{mm_0}^{k_0}|^2 < \varepsilon$$

and such that the operator D_m has a bounded inverse.

Proof. First, for a given $\{\lambda_k^m\}$, let us choose $\varepsilon_0 > 0$ such that D_m will be invertible for

$$\sum_{k_0} |\alpha_{mm_0}^{k_0}|^2 < \varepsilon_0, \quad m \neq m_0, \quad \sum_{k_0} |\alpha_{mm}^{k_0} - 1|^2 < \varepsilon_0.$$

Then, one can find a large enough N such that

$$\sum_{|k_0| > N} |\widehat{\alpha}_{mm_0}^{k_0}|^2 < \varepsilon_0, \quad \sum_{|k_0| > N} |\widehat{\alpha}_{mm}^{k_0} - 1|^2 < \varepsilon_0.$$

Next we consider the sequences $\{\alpha_{mm_0}^{k_0}\}$ for which

$$(5.15) \quad \alpha_{mm_0}^{k_0} = \widehat{\alpha}_{mm_0}^{k_0}, \quad |k_0| > N.$$

Our goal is to choose the remaining components $\alpha_{mm_0}^{k_0}$, $|k_0| \leq N$ in order to satisfy the requirement of our lemma. Denote rows of matrix D_m by $(\ell_{k_0}^{m_0})^*$, $m_0 = 1, \dots, n$; $k_0 \in \mathbb{Z}$ and let $q_{k_0}^{m_0}$ be the corresponding components of the vector $q = D_m p$, i.e. $q_{k_0}^{m_0} = (\ell_{k_0}^{m_0})^* p$, $p \in \ell_2^n$, $m_0 = 1, \dots, n$; $k_0 \in \mathbb{Z}$. The space $L = \underbrace{\ell_2 \times \dots \times \ell_2}_{n \text{ times}}$ may

be written as $L = L^1 \oplus L^2$, where

$$L^1 = \{q : q_{k_0}^{m_0} = 0, m_0 = 1, \dots, n, |k_0| > N\},$$

and

$$L^2 = \{q : q_{k_0}^{m_0} = 0, m_0 = 1, \dots, n, |k_0| \leq N\}.$$

Let P be the orthogonal projector on L^2 . Let us observe that the rows $(\ell_{k_0}^{m_0})^*$ for $|k_0| > N$ do not depend on components $\alpha_{mm_0}^{k_0}$, $|k_0| \leq N$ and that, if we put $\alpha_{mm_0}^{k_0} = \delta_{mm_0}$, $|k_0| \leq N$, $m, m_0 = 1, \dots, n$, then the operator $D_m : L \rightarrow L$ has a bounded inverse. This means that, for all sequences $\{\alpha_{mm_0}^{k_0}\}$ satisfying (5.15), we have $P D_m L = L^2$ and the invertibility of D_m occurs if and only if

$$(5.16) \quad D_m L \supset L^1.$$

Let $L^{1'}$ be the subspace

$$\{p \in L : (\ell_{k_0}^{m_0})^* p = 0, |k_0| > N, m_0 = 1, \dots, n\}$$

of dimension $(2N+1)n$. Denote by $\ell_k^{j'}$, $j = 1, \dots, n$; $|k| \leq N$ a basis of $L^{1'}$. With these notations, one can see that (5.16) is equivalent to the invertibility of $(2N+1)n \times (2N+1)n$ matrix

$$M = \left\{ (\ell_{k_0}^{m_0})^* \ell_k^{j'}, |k_0| \leq N, |k| \leq N, m_0 = 1, \dots, n, j = 1, \dots, n \right\}$$

i.e. $\det M \neq 0$. The components of M are linear functions of $\alpha_{mm_0}^{k_0}$, $|k_0| \leq N$. Therefore, the determinant $\det M$ is a polynomial whose coefficients are also linear functions of these scalars. Besides, $\det M$ is not identical to zero because the matrix D_m is invertible if we take $\alpha_{mm_0}^{k_0} = \delta_{mm_0}$, i.e. $\det M \neq 0$. This implies that M is invertible almost everywhere in $\mathbb{C}^{2(N+1)n}$. This fact completes the proof of Lemma 5.5 because we can choose $\alpha_{mm_0}^{k_0}$, $|k_0| \leq N$, in such a way that

$$\sum_{|k_0| \leq N} |\alpha_{mm_0}^{k_0} - \widehat{\alpha}_{mm_0}^{k_0}| < \varepsilon$$

and the operator D_m will be invertible. \square

REMARK 5.6. From the proof of Lemma 5.5, it is easy to see that the sequence $\alpha_{mm_0}^{k_0}$ may differ from $\widehat{\alpha}_{mm_0}^{k_0}$ only for a finite number of components $|k_0| \leq N$.

Due to Lemma 5.5, the formulation of Theorem 5.4 may be generalized in the following way.

THEOREM 5.7. Let the sequence $\{\lambda_k^m\}_{k \in \mathbb{Z}, m=1, \dots, n}$ and vectors $z_m, m = 1, \dots, n$ be chosen according to the assumptions of Theorem 5.4. Then, for any sequence of vectors $\{\widehat{d}_k^m\}_{k \in \mathbb{Z}, m=1, \dots, n}$ satisfying

$$\sum_k \|\widehat{d}_k^m - z_m\|^2 < \infty, \quad m = 1, \dots, n,$$

and for any $\varepsilon > 0$, there is a sequence $\{d_k^m\}_{k \in \mathbb{Z}, m=1, \dots, n}$:

$$\sum_k \|d_k^m - \widehat{d}_k^m\|^2 < \varepsilon$$

such that, for some choice of matrices $A_{-1}, A_2(\theta), A_3(\theta)$, satisfying $\int_{-1}^0 A_3(\theta) d\theta = 0$, the conditions i) and ii) of Theorem 5.4 are verified. Moreover, $\{d_k^m\}$ may be chosen in such a way, that $d_k^m = \widehat{d}_k^m$ for all $|k| > N$ and for some $N \in \mathbb{N}$.

Now we can prove the final result on the spectral assignment.

THEOREM 5.8. Let $\mu_1, \mu_2, \dots, \mu_n$ be different non-zero complex numbers and z_1, z_2, \dots, z_n be non-zero n -dimensional linear independent vectors. Denote

$$\widetilde{\lambda}_k^m = \ln |\mu_m| + i(\text{Arg } \mu_m + 2\pi k), \quad m = 1, \dots, n, \quad k \in \mathbb{Z}.$$

Let us consider an arbitrary sequence of different complex numbers $\{\lambda_k^m\}_{\substack{k \in \mathbb{Z} \\ m=1, \dots, n}}$ such that

$$\sum_k \left| \lambda_k^m - \widetilde{\lambda}_k^m \right|^2 < \infty, \quad m = 1, \dots, n.$$

Let $\{\widehat{d}_k^m\}_{k \in \mathbb{Z}, m=1, \dots, n}$ be quadratically close to the sequences $\{z_m\}_{m=1, \dots, n}$:

$$\sum_k \|\widehat{d}_k^m - z_m\|^2 < \infty, \quad m = 1, \dots, n.$$

In addition, let complex numbers $\lambda_j^0, j = 1, \dots, n$ be different from each other and different from λ_k^m and let $d_j^0, j = 1, \dots, n$ be linear independent vectors.

Then, for any $\varepsilon > 0$, there exists $N > 0$ and a sequence $\{d_k^m\}_{k \in \mathbb{Z}, m=1, \dots, n}$:

$$d_k^m = \widehat{d}_k^m, \quad |k| > N, \quad \sum_{|k| \leq N} \|d_k^m - \widehat{d}_k^m\|^2 < \varepsilon, \quad m = 1, \dots, n$$

such that there are some matrices $A_{-1}, A_2(\theta), A_3(\theta)$ for which the following conditions are satisfied:

- i) The set $\{\lambda_k^m\}_{k \in \mathbb{Z}, m=1, \dots, n} \cup \{\lambda_j^0\}_{j=1, \dots, n}$ is the set of all roots of the characteristic equation $\det \Delta(\lambda) = 0$;
- ii) $d_k^{m*} \Delta(\lambda_k^m) = 0, m = 1, \dots, n, k \in \mathbb{Z}$ and $d_j^{0*} \Delta(\lambda_j^0) = 0$.

Proof. Denote by C a $(n \times n)$ matrix uniquely defined by the equalities:

$$d_j^{0*} C = \lambda_j^0 d_j^{0*}, \quad j = 1, \dots, n,$$

and let us put, for any $k \in \mathbb{Z}$, $m = 1, \dots, n$,

$$\widehat{f}_k^{m*} = \begin{cases} \widehat{d}_k^{m*} (I - \frac{1}{\lambda_k^m} C)^{-1} & \text{if } \lambda_k^m \neq 0, \\ \widehat{d}_k^{m*} C^{-1} & \text{if } \lambda_k^m = 0. \end{cases}$$

It is easy to see that the sequences $\{\widehat{f}_k^m\}$ are also quadratically close to z_m :

$$\sum_k \|\widehat{f}_k^m - z_m\|^2 < \infty.$$

Therefore, due to Theorem 5.7, for any $\varepsilon > 0$, there are matrices A_{-1} , $\widehat{A}_2(\theta)$, $\widehat{A}_3(\theta)$ ($\int_{-1}^0 \widehat{A}_3(\theta) d\theta = 0$), a number $N > 0$ and a sequence of vectors $\{f_k^m\}_{k \in \mathbb{Z}, m=1, \dots, n}$ verifying

$$\sum_k \|f_k^m - \widehat{f}_k^m\|^2 < \frac{\varepsilon}{M^2}, \quad f_k^m = \widehat{f}_k^m, \quad |k| > N,$$

such that

$$f_k^{m*} \widehat{\Delta}(\lambda_k^m) = 0, \quad k \in \mathbb{Z}, \quad m = 1, \dots, n,$$

where $M = \sup\{\|I - \frac{1}{\lambda_k^m} C\|, \lambda_k^m \neq 0; \|C\|\}$ and

$$\widehat{\Delta}(\lambda) = \lambda I - \lambda e^{-\lambda} A_{-1} + \int_{-1}^0 \lambda e^{\lambda\theta} \widehat{A}_2(\theta) d\theta + \int_{-1}^0 e^{\lambda\theta} \widehat{A}_3(\theta) d\theta.$$

We have $\widehat{\Delta}(0) = 0$, and the function $\widehat{\Delta}_1(\lambda) = \frac{1}{\lambda} \widehat{\Delta}(\lambda)$ may be extended to $\lambda = 0$ by the formula

$$\widehat{\Delta}_1(0) = I - A_{-1} + \int_{-1}^0 \widehat{A}_2(\theta) d\theta + \int_{-1}^0 \lim_{\lambda \rightarrow 0} \frac{e^{\lambda\theta} - 1}{\lambda} \widehat{A}_3(\theta) d\theta.$$

Now, let us put

$$\Delta(\lambda) = (I - \frac{1}{\lambda} C) \widehat{\Delta}(\lambda), \quad \lambda \neq 0.$$

At $\lambda = 0$, the function $\Delta(\lambda)$ may be defined as

$$\Delta(0) = -C \widehat{\Delta}_1(0).$$

We can observe that $\Delta(\lambda)$ can be written as

$$\begin{aligned} \Delta(\lambda) &= \lambda I - \lambda e^{-\lambda} A_{-1} + \int_{-1}^0 \lambda e^{\lambda\theta} \widehat{A}_2(\theta) d\theta + \int_{-1}^0 e^{\lambda\theta} \widehat{A}_3(\theta) d\theta \\ &\quad - C + e^{-\lambda} C A_{-1} - \int_{-1}^0 e^{\lambda\theta} C \widehat{A}_2(\theta) d\theta + \int_{-1}^0 e^{\lambda\theta} \int_{-1}^{\theta} C \widehat{A}_3(\tau) d\tau d\theta, \\ &= \lambda I - \lambda e^{-\lambda} A_{-1} + \int_{-1}^0 \lambda e^{\lambda\theta} A_2(\theta) d\theta + \int_{-1}^0 e^{\lambda\theta} A_3(\theta) d\theta, \end{aligned}$$

for $A_2(\theta)$ and $A_3(\theta)$ given by

$$\begin{aligned} A_2(\theta) &= \widehat{A}_2(\theta) - (\theta + 1)C - \theta CA_{-1}, \\ A_3(\theta) &= \widehat{A}_3(\theta) + \int_{-1}^{\theta} C \widehat{A}_3(\tau) d\tau - C - CA_{-1} \end{aligned}$$

It is now easy to see that, with this choice of matrices, the conditions i) and ii) are satisfied. Indeed,

$$\det \Delta(\lambda) = \det\left(I - \frac{1}{\lambda}C\right) \det \widehat{\Delta}(\lambda),$$

and then, the numbers $\{\lambda_k^m\}$ and $\{\lambda_j^0\}$ are roots of the characteristic equation and

$$\begin{aligned} d_k^{m*} \Delta(\lambda_k^m) &= f_k^{m*} \widehat{\Delta}(\lambda_k^m) = 0, & k \in \mathbb{Z}, m = 1, \dots, n, \\ d_j^{0*} \Delta(\lambda_j^0) &= 0, & j = 1, \dots, m. \end{aligned}$$

Finally, for all $m = 1, \dots, n$, we have

$$\sum_k \|d_k^m - \widehat{d}_k^m\|^2 \leq \sum_{k,m} M^2 \|f_k^m - \widehat{f}_k^m\| < \varepsilon.$$

This completes the proof. \square

EXAMPLE 5.9. We consider equations of the form

$$\begin{pmatrix} \dot{z}_1(t) \\ \dot{z}_2(t) \end{pmatrix} = \begin{pmatrix} z_1(t-1) \\ -z_2(t-1) \end{pmatrix} + \int_{-1}^{\theta} \left(A_2(\theta) \begin{pmatrix} z_1(t+\theta) \\ z_2(t+\theta) \end{pmatrix} + A_3(\theta) \begin{pmatrix} z_1(t+\theta) \\ z_2(t+\theta) \end{pmatrix} \right) d\theta,$$

where $A_l(\theta) = (a_{ij}^l)_{i,j=1,2}$, $l = 2, 3$. For this case matrix A_{-1} equals

$$A_{-1} = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix},$$

and then $\mu_1 = 1$, $\mu_2 = -1$. Hence $\tilde{\lambda}_k^1 = 2\pi ki$, $\tilde{\lambda}_k^2 = \pi i + 2\pi ki$, $z_1 = \begin{pmatrix} 1 \\ 0 \end{pmatrix}$, $z_2 = \begin{pmatrix} 0 \\ 1 \end{pmatrix}$. Let us put $\lambda_k^m = \tilde{\lambda}_k^m$, $k \in \mathbb{Z}$, $m = 1, 2$, and let us choose for arbitrary $N \in \mathbb{N}$ the sequence $\{d_k^m\}$, $k \in \mathbb{Z}$, $m = 1, 2$, with $d_k^m = z_m$ for $|k| > N$, $m = 1, 2$, and $d_k^m = z_2$ for $|k| \leq N$, $m = 1, 2$. This sequence is quadratically close to z_m , i.e.

$$\sum_{k \in \mathbb{Z}} \|d_k^m - z_m\|^2 < \infty, \quad m = 1, 2.$$

If we try to find $A_2(\theta)$, $A_3(\theta)$ corresponding to $\{\lambda_k^m\}$, $\{d_k^m\}$, then this leads to the equalities

$$\int_{-1}^0 (\pi + 2\pi k) i e^{(\pi+2\pi k)i\theta} a_{22}^2(\theta) d\theta + \int_{-1}^0 e^{(\pi+2\pi k)i\theta} a_{22}^3(\theta) d\theta = 0, \quad k \in \mathbb{Z},$$

and

$$\int_{-1}^0 2\pi k i e^{2\pi k i \theta} a_{22}^2(\theta) d\theta + \int_{-1}^0 e^{2\pi k i \theta} a_{22}^3(\theta) d\theta = 4\pi k i, \quad |k| \leq N.$$

This in turn can be rewritten as

$$(5.17) \quad \int_{-1}^0 e^{(\pi+2\pi k)i\theta} \left(a_{22}^2(\theta) - \int_0^\theta a_{22}^3(\tau) d\tau \right) d\theta = \frac{iC}{(\pi+2\pi k)}, \quad k \in \mathbb{Z},$$

$$(5.18) \quad \int_{-1}^0 e^{2\pi ki\theta} \left(a_{22}^2(\theta) - \int_0^\theta a_{22}^3(\tau) d\tau \right) d\theta = 2 + \frac{iC}{2\pi k}, \quad |k| \leq N,$$

where $C = \int_{-1}^0 a_{22}^3(\theta) d\theta$. From (5.17) one has

$$a_{22}^2(\theta) - \int_0^\theta a_{22}^3(\tau) d\tau = \sum_{k \in \mathbb{Z}} e^{(-\pi+2\pi k)i\theta} \frac{iC}{(\pi+2\pi k)}$$

which obviously contradicts (5.18). This means that our choice of d_k^m is impossible. However, if we slightly change vectors d_k^m , $|k| \leq N$, as $d_k^m = z_2 + \sqrt{\frac{\varepsilon}{2N+1}} z_1$ for arbitrarily small $\varepsilon > 0$, and put

$$\begin{aligned} a_{11}^3(\theta) &= 2\sqrt{\frac{2N+1}{\varepsilon}} \sum_{k=-N}^N e^{-2\pi ki\theta} \\ &= 2\sqrt{\frac{2N+1}{\varepsilon}} \frac{e^{2(2N+1)\pi i\theta} - 1}{e^{2\pi i\theta} - 1} \cdot e^{-2\pi Ni\theta}, \end{aligned}$$

and

$$a_{21}^3(\theta) = a_{12}^3(\theta) = a_{22}^3(\theta) = 0, \quad a_{js}^2(\theta) = 0, \quad j, s = 1, 2,$$

one can verify that

$$d_k^{m*} \Delta(\lambda_k^m) = 0, \quad k \in \mathbb{Z}, \quad m = 1, 2.$$

Besides,

$$\sum_k \|d_k^m - z_m\|^2 = \varepsilon.$$

Finally, note that $\|a_{11}^3(\cdot)\| \rightarrow \infty$ as $N \rightarrow \infty$ or $\varepsilon \rightarrow 0$. Thus, such a choice of eigenvalues is possible only for a finite number of elements.

6. The moment problem and the controllability. Consider the control neutral-type system given by

$$(6.1) \quad \dot{z}(t) = A_{-1}\dot{z}(t-1) + \int_{-1}^0 A_2(\theta)\dot{z}(t+\theta) d\theta + \int_{-1}^0 A_3(\theta)z(t+\theta) d\theta + Bu(t),$$

where the matrices $A_{-1}, A_2(\cdot), A_3(\cdot)$ are as in (1.1), B is an $n \times r$ -matrix, and $u(t)$ is an r -vector control. In the function space M_2 , this system may be written as

$$(6.2) \quad \frac{d}{dt} \begin{pmatrix} y(t) \\ z_t(\cdot) \end{pmatrix} = \mathcal{A} \begin{pmatrix} y(t) \\ z_t(\cdot) \end{pmatrix} + \mathcal{B}u,$$

where the operator $\mathcal{B} : \mathbb{R}^r \rightarrow M_2$ is defined by $\mathcal{B}u = (Bu, 0)^T$.

As in the preceding sections, we consider the case when all eigenvalues of A_{-1} are simple. Denote these eigenvalues by μ_m , $m = 1, \dots, n$. The operator $\tilde{\mathcal{A}}$, corresponding to the case $A_2(\theta) = A_3(\theta) = 0$, has simple eigenvalues

$$\tilde{\lambda}_k^m = \ln |\mu_m| + i(\text{Arg } \mu_m + 2\pi k), \quad m = 1, \dots, n, k \in \mathbb{Z},$$

with corresponding eigenvectors $\tilde{\varphi}_k^m$. The other eigenvalue of $\tilde{\mathcal{A}}$ is $\tilde{\lambda}^0 = 0$, which corresponds to an n -dimensional subspace generated by the generalized eigenvectors: $\tilde{\varphi}_1^0, \dots, \tilde{\varphi}_n^0$. All eigenvectors $\{\tilde{\varphi}_k^m\} \cup \{\tilde{\varphi}_j^0\}$ constitute a Riesz basis in M_2 .

We assume, as in the preceding sections, that $A_2(\theta)$ and $A_3(\theta)$ are chosen in such a way that all eigenvalues of \mathcal{A} , λ_k^m , $m = 1, \dots, n$, $k \in \mathbb{Z}$, are simple. As noted before, they satisfy the condition [18, 19]:

$$(6.3) \quad \sum_{k,m} \left| \lambda_k^m - \tilde{\lambda}_k^m \right|^2 < \infty,$$

and the corresponding eigenvectors $\{\varphi_k^m\}$ satisfy

$$\sum_{k,m} \|\varphi_k^m - \tilde{\varphi}_k^m\|^2 < \infty.$$

Eigenvectors $\{\varphi_k^m\}$ together with a set of generalized eigenvectors $\{\varphi_j^0, j = 1, \dots, n\}$ form a Riesz basis in M_2 quadratically close to the spectral basis $\{\tilde{\varphi}\}$ of $\tilde{\mathcal{A}}$.

Let $\{\tilde{\psi}\}$ and $\{\psi\}$ be biorthogonal bases for $\{\tilde{\varphi}\}$ and $\{\varphi\}$ respectively. It is known that $\{\tilde{\psi}\}$ and $\{\psi\}$ are spectral bases of adjoint operators $\tilde{\mathcal{A}}^*$ and \mathcal{A}^* ,

$$\tilde{\mathcal{A}}^* \tilde{\psi}_k^m = \tilde{\lambda}_k^m \tilde{\psi}_k^m, \quad \mathcal{A}^* \psi_k^m = \bar{\lambda}_k^m \psi_k^m.$$

These bases are also quadratically close [5]:

$$\sum_{k,m} \left\| \psi_k^m - \tilde{\psi}_k^m \right\|^2 < \infty.$$

Finally, let us note that, as shown in [20], vectors $\tilde{\psi}_k^m$, and ψ_k^m , $k \neq 0$, are of the form

$$(6.4) \quad \tilde{\psi}_k^m = \begin{pmatrix} \frac{1}{k+\frac{1}{2}} z_m \\ * \end{pmatrix}, \quad \psi_k^m = \begin{pmatrix} \frac{1}{k+\frac{1}{2}} d_k^m \\ * \end{pmatrix},$$

where z_m , $m = 1, \dots, n$ are eigenvectors of A_{-1}^* , $A_{-1}^* z_m = \bar{\mu}_m z_m$, and the n -vectors d_k^m are such that $\Delta^*(\bar{\lambda}_k^m) d_k^m = 0$, and

$$(6.5) \quad \sum_{k,m} \|d_k^m - z_m\|^2 < \infty, \quad m = 1, \dots, n.$$

Now, we use the biorthogonal bases $\{\varphi\}$ and $\{\psi\}$ to interpret the steering conditions of the controllability problem of the system (6.1). Let $x \in M_2$. Then

$$x = \sum_{\varphi \in \{\varphi\}} \langle x, \psi \rangle \cdot \varphi.$$

A state $x = \begin{pmatrix} y \\ z(\cdot) \end{pmatrix} \in M_2$ is reachable at time T by a control $u(\cdot) \in L_2(0, T; \mathbb{C}^r)$ if and only if the steering condition

$$(6.6) \quad x = \begin{pmatrix} y \\ z(\cdot) \end{pmatrix} = \int_0^T e^{At} \mathcal{B}u(t) dt.$$

holds. This relation may be expanded using the basis $\{\varphi\}$. A state x is reachable if and only

$$\sum_{\varphi \in \{\varphi\}} \langle x, \psi \rangle \cdot \varphi = \sum_{\varphi \in \{\varphi\}} \int_0^T \langle e^{At} \mathcal{B}u(t), \psi \rangle dt \cdot \varphi,$$

for some $u(\cdot) \in L_2(-1, 0; \mathbb{R}^r)$. Then, the steering condition (6.6) can be substituted by the following system of equalities

$$(6.7) \quad \langle x, \psi \rangle = \int_0^T \langle e^{At} \mathcal{B}u(t), \psi \rangle dt, \quad \psi \in \{\psi\}.$$

Let $\{b_1, \dots, b_r\}$ be columns of B and $\mathbf{b}_i = \begin{pmatrix} b_i \\ 0 \end{pmatrix} \in M_2$, $i = 1, \dots, r$. Then, the right hand side of (6.7) takes the form

$$\int_0^T \langle e^{At} \mathcal{B}u(t), \psi \rangle dt = \sum_{i=1}^r \int_0^T \langle e^{At} \mathbf{b}_i, \psi \rangle u_i(t) dt.$$

Taking into account the fact that $\{\psi\}$ is a spectral basis of \mathcal{A}^* , we can rewrite the main steering conditions, corresponding to the basis $\{\psi_k^m\}$ as

$$(6.8) \quad s_k^m = \left(k + \frac{1}{2}\right) \langle x, \psi_k^m \rangle = \int_0^T e^{\lambda_k^m t} (b_{k,m}^1 u_1(t) + \dots + b_{k,m}^r u_r(t)) dt,$$

$m = 1, \dots, n$, $k \in \mathbb{Z}$, where

$$b_{k,m}^j = \left(k + \frac{1}{2}\right) \langle \mathbf{b}_j, \psi_k^m \rangle = \left\langle \begin{pmatrix} b_j \\ 0 \end{pmatrix}, \begin{pmatrix} d_k^m \\ * \end{pmatrix} \right\rangle.$$

Equations (6.8) pose a vector moment problem with respect to unknown functions $u_j(t)$, $j = 1, \dots, r$. Using (6.4), we observe that

$$\left(k + \frac{1}{2}\right) \langle \mathbf{b}_j, \tilde{\psi}_k^m \rangle = \left\langle \begin{pmatrix} b_j \\ 0 \end{pmatrix}, \begin{pmatrix} z_m \\ * \end{pmatrix} \right\rangle = \langle b_j, z_m \rangle = b_m^j,$$

Thus, this value does not depend on k . Then from (6.5) it follows that the coefficients $b_{k,m}^j$ satisfy the condition

$$(6.9) \quad \sum_{k,m} \left| b_{k,m}^j - b_m^j \right|^2 = \sum_{k,m} |\langle b_j, d_k^m - z_m \rangle|^2 < \infty \quad j = 1, \dots, r.$$

In the scalar case $r = 1$, under the conditions

$$(6.10) \quad b_m^1 = \langle \mathbf{b}_1, \psi_m \rangle \neq 0, \quad m = 1, \dots, n$$

(controllability of the pair (A_{-1}, B)) and

$$(6.11) \quad \langle \mathbf{b}_1, \psi_k^m \rangle \neq 0, \quad m = 1, \dots, n; k \in \mathbb{Z}$$

(approximate controllability of system (6.2)), the solvability of (6.8) can be studied by application of the methods given in [1]. In the vector case, the problem is more complicated. We showed [16] that the minimal interval of solvability of (6.2) is related to the first controllability index $n_1(A_{-1}, B)$ of the system $\dot{x} = A_{-1}x + Bu$ (see [27]).

Our purpose now is to consider the abstract moment problems of the form (6.8) by means of their correspondence to the controllability problems for neutral-type systems (6.1).

We show first that the conditions (6.3) and (6.9), together with some conditions analogous to (6.10) and (6.11), are not only necessary but also almost sufficient for the moment problem (6.8) to be generated by a neutral type system (6.1).

THEOREM 6.1. *Let us consider the moment problem (6.8). Let the following conditions be satisfied:*

- i) $\sum_{k,m} \left| \lambda_k^m - \tilde{\lambda}_k^m \right|^2 < \infty$, where $\tilde{\lambda}_k^m = \ln |\mu_m| + i(\text{Arg } \mu_m + 2\pi k)$,
 $m = 1, \dots, n, k \in \mathbb{Z}$, μ_1, \dots, μ_r are some non-zero different complex numbers;
- ii) $\sum_{j,k,m} \left| b_{k,m}^j - b_m^j \right|^2 < \infty$, where b_m^j and $b_{k,m}^j$ are some real numbers such that

$$\sum_{j=1}^r |b_m^j| > 0, \quad \sum_{j=1}^r |b_{k,m}^j| > 0, \quad m = 1, \dots, n; k \in \mathbb{Z}.$$

Then, for any $\varepsilon > 0$, there is an integer $N > 0$, and sequences of scalars $\{b_{k,m}^j\}$, $m = 1, \dots, n; j = 1, \dots, r$:

$$b_{k,m}^j = b_{k,m}^j, \quad |k| > N, \quad \sum_{|k| \leq N} \left| b_{k,m}^j - b_{k,m}^j \right|^2 < \varepsilon,$$

and matrices A_{-1} , $A_2(\cdot)$, $A_2(\cdot)$, B such that the control system (6.1) with these matrices is exactly controllable and the steering conditions for this system will correspond to the moment problem

$$(6.12) \quad s_k^m = \int_0^T e^{\lambda_k^m t} \left(b_{k,m}^1 u_1(t) + \dots + b_{k,m}^r u_r(t) \right) dt.$$

Proof. Let us introduce the $n \times n$ and $n \times r$ -matrices A_{-1} and B given by

$$A_{-1} = \text{diag}\{\mu_1, \dots, \mu_n\}, \quad B = \{b_m^j\}_{m=1, \dots, n}^{j=1, \dots, r}.$$

The basis of eigenvectors $\{z_m\}$ of the matrix A_{-1}^* is the canonical basis:

$$z_m = e_m = (0, \dots, 1, \dots, 0)^*$$

Due to conditions ii) we have

$$z_m^* B = (b_m^1, \dots, b_m^r) \neq 0.$$

This means that the pair (A_{-1}, B) is controllable.

Now we use Theorem 5.8. Let us choose a sequence of vectors $\{\widehat{d}_k^m\}$ satisfying the conditions

$$(6.13) \quad \langle b_j, \widehat{d}_k^m \rangle = b_{k,m}^j, \quad k \in \mathbb{Z}; \quad m = 1, \dots, n; \quad j = 1, \dots, r$$

and

$$(6.14) \quad \sum_{k \in \mathbb{Z}} \|\widehat{d}_k^m - z_m\|^2 < \infty.$$

From conditions ii) of the theorem, we obtain

$$\inf_{k,m} \sum_{j=1}^r |b_{k,m}^j| = \omega > 0.$$

Therefore we can choose $\varepsilon_0 > 0$ sufficiently small, that

$$(6.15) \quad \sum_{j=1}^r \|\langle b_j, d_k^m \rangle\| \neq 0, \quad k \in \mathbb{Z}; \quad m = 1, \dots, n,$$

as $\|d_k^m - \widehat{d}_k^m\| < \varepsilon_0$.

Applying Theorem 5.8 we observe that, for any $\varepsilon > 0$, there are $N > 0$ and matrices $A_2(\cdot), A_3(\cdot)$ such that the corresponding operator \mathcal{A} will have the eigenvalues $\{\lambda_k^m\}$ with the related eigenvectors d_k^m :

$$d_k^{m*} \Delta(\lambda_k^m) = 0, \quad k \in \mathbb{Z}; \quad m = 1, \dots, n,$$

where

$$d_k^m = \widehat{d}_k^m, \quad |k| > N; \quad \sum_{|k| < N} \|\widehat{d}_k^m - d_k^m\| < \frac{\varepsilon}{M}, \quad M = \max_{j=1, \dots, r} \|b_j\|.$$

Let us now denote

$$b_{k,m}^j = \langle b_j, d_k^m \rangle.$$

Then it is easy to see that

$$\left| b_{k,m}^j - b_{k,m}^j \right| = \left| \langle b_j, \widehat{d}_k^m \rangle \right| < \varepsilon, \quad k \in \mathbb{Z}; \quad m = 1, \dots, n; \quad j = 1, \dots, r.$$

If we assume that $\varepsilon < M\varepsilon_0$, then we obtain from (6.15) that

$$\sum_{j=1}^r \left| b_{k,m}^j \right| > 0, \quad k \in \mathbb{Z}; \quad m = 1, \dots, n; \quad j = 1, \dots, r.$$

The last relation may be formulated as

$$\text{rank}(\Delta(\lambda_k^m), B) = n, \quad k \in \mathbb{Z}; \quad m = 1, \dots, n,$$

which is equivalent to the approximate controllability property of the system (6.1). This condition with the controllability property of the pair (A_{-1}, B) gives [16] the exact controllability of the system (6.1). Thus, the moment problem (6.12) corresponds to the steering conditions of the constructed exactly controllable system (6.1). \square

Let us now analyze the solvability of the moment problem (6.8). Let S_T , $T > 0$ be the linear operator that associates the function $u(\cdot) \in L_2([0, T]; \mathbb{R}^r)$ with the sequence $\{s_k^m\}$:

$$S_T u(\cdot) = \{s_k^m\}$$

Denote by I_T the image of the operator S_T . First we can observe that the Riesz basis property of exponentials $\{e^{\lambda_k^m t}\}$ (see Proposition 5.1) implies $I_T \subset \ell_2$. Moreover S_T is bounded and it is easy to see that

$$I_{T_1} \subset I_{T_2}, \quad \text{if } T_1 < T_2.$$

This makes the following definition natural.

DEFINITION 6.2. 1. *The moment problem is completely solvable if there is $T > 0$ such that $I_T = \ell_2$.* 2. *For a completely solvable moment problem, the interval $[0, T^*]$, where $T^* = \inf\{T : I_T = \ell_2\}$ is called the critical interval of solvability for the moment problem.*

When a moment problem corresponds to the controllability problem of an exactly controllable neutral-type system of the form (6.1), it is known from [16] that the length of the critical interval of solvability can be calculated by the formula

$$T^* = n_1(A_{-1}, B) = \min\{k : \text{rank}(B, A_{-1}B, \dots, A_{-1}^{k-1}B) = n\}.$$

The integer $n_1(A_{-1}, B)$ is the first of a set of controllability indices for the pair (A_{-1}, B) (see for example [27]). Our goal is to prove the same relation for the abstract moment problem (6.8) satisfying the assumptions of Theorem 6.1.

LEMMA 6.3. *Let for some $T_0 > 0$ and $\varepsilon_0 > 0$ the image not increase in the interval $]T_0, T_0 + \varepsilon]$, i.e.*

$$(6.16) \quad I_{T_1} = I_{T_2}, \quad T_0 < I_{T_1} \leq I_{T_2} \leq T_0 + \varepsilon.$$

Then this relation holds for all $T_0 < I_{T_1} \leq I_{T_2} < \infty$.

Proof. For any $\varepsilon > 0$ we introduce the operator $E_\varepsilon : \ell_2 \rightarrow \ell_2$ by

$$E_\varepsilon \{s_k^m\} = \{e^{\lambda_k^m \varepsilon} s_k^m\}.$$

Let us observe that if $\{s_k^m\} = S_T u(\cdot)$, then

$$E_\varepsilon \{s_k^m\} = \left\{ \int_0^T e^{\lambda_k^m (t+\varepsilon)} \sum_{j=1}^r b_{k,m}^j u_j(t) dt \right\} = \left\{ \int_\varepsilon^{T+\varepsilon} e^{\lambda_k^m \tau} \sum_{j=1}^r b_{k,m}^j u_j(\tau - \varepsilon) d\tau \right\},$$

and then $E_\varepsilon S_T u(\cdot) \in I_{T+\varepsilon}$. This relation together with (6.16) brings the inclusions

$$E_\varepsilon I_{T_1} \subset I_{T_1+\varepsilon} = I_{T_0+\varepsilon_0} = I_{T_1}$$

for all $T_0 < T_1 < T_1 + \varepsilon \leq T_0 + \varepsilon$. Then, for any $N \in \mathbb{N}$, we obtain

$$E_{N\varepsilon} I_{T_1} = E_{(N-1)\varepsilon} (E_\varepsilon I_{T_1}) \subset E_{(N-1)\varepsilon} (I_{T_1}) \subset \dots \subset E_\varepsilon (I_{T_1}) \subset I_{T_1}.$$

Hence

$$I_{T_1+N\varepsilon} \subset I_{T_1} \cup E_\varepsilon I_{T_1} \cup \dots \cup E_{N\varepsilon} I_{T_1} \subset I_{T_1},$$

which implies $I_{T_1+N\varepsilon} = I_{T_1}$. If N is chosen such that $T_1 + N\varepsilon \geq T_2$, then

$$I_{T_2} \subset I_{T_1+N\varepsilon} = I_{T_1} \subset I_{T_2}.$$

This proves our Lemma. \square

THEOREM 6.4. *Let the moment problem (6.8) satisfy assumptions i) and ii) of Theorem 6.1. Then this problem is completely solvable and the length of the critical interval of solvability is $T^* = n_1(A_{-1}, B)$, where*

$$A_{-1} = \text{diag}\{\mu_1, \dots, \mu_n\}, \quad B = \{b_m^j\}_{m=1, \dots, n}^{j=1, \dots, r}.$$

Proof. First we note that, by Theorem 6.1, the moment problem (6.8) almost corresponds (up to the substitution of a finite set $\{b_{k,m}^j\}_{|k| \leq N}$ by $\{b_{k,m}^j\}_{|k| \leq N}$) to the steering conditions for some exactly controllable system (6.1) whose minimal time of controllability is $n_1(A_{-1}, B)$. This means, in particular, that for

$$T > T^* = n_1(A_{-1}, B),$$

the images I_T are subspaces of finite co-dimension in the space ℓ_2 . Our goal is to prove that $I_T = \ell_2$, for $T > T^*$. Since $\text{codim} I_T < \infty$ for $T > T^*$, it is sufficient to show that $I_T = \ell_2$ for some $T > 0$.

In parallel with the problem (6.8), let us consider the classic (scalar) moment problem

$$(6.17) \quad s_k^m = \int_0^T e^{\lambda_k^m t} v(t) dt, \quad k \in \mathbb{Z}, m = 1, \dots, n, \quad v(\cdot) \in L_2(0, T).$$

It is well known [1] that the family of exponential $\{e^{\lambda_k^m t}\}$ forms a Riesz basis in $L_2(0, n)$ and hence the problem is completely solvable for $T \geq n$. We want to show that our problem (6.8) is also solvable for this T .

Let us put

$$u_j(t) = \alpha_j v(t), \quad j = 1, \dots, r.$$

For this particular substitution, the relations of our moment problem (6.8) take the form

$$(6.18) \quad s_k^m = \int_0^T e^{\lambda_k^m t} \left(\sum_{j=1}^r \alpha_j b_{k,m}^j \right) v(t) dt.$$

Now, let us remark that the scalars α_j , $j = 1, \dots, r$ can be chosen in such a way that

$$\sum_{j=1}^r \alpha_j b_{k,m}^j \neq 0, \quad k \in \mathbb{Z}, m = 1, \dots, n.$$

Indeed, if not, then the countable family of hyperplanes

$$\Pi_{k,m} = \left\{ (\alpha_1, \dots, \alpha_r) \in \mathbb{R}^r : \sum_{j=1}^r \alpha_j b_{k,m}^j = 0 \right\}, \quad k \in \mathbb{Z}, m = 1, \dots, n$$

covers the whole space \mathbb{R}^r . This contradicts the Baire theorem. Moreover, the assumptions ii) of the theorem (see the formulation of Theorem 6.1) imply that the sequence $\{b_{k,m}^j\}$ is bounded and $\cup_{k,m} \Pi_{k,m}$ is a closed set. From these considerations, we can conclude that there are two constants c_1 and c_2 such that

$$0 < c_1 < \sum_{j=1}^r \alpha_j b_{k,m}^j < c_2.$$

This means that problems (6.17) and (6.18) have the same set of solvability. Then the problem (6.18) is solvable for all $\{s_k^m\} \in \ell_2$ if $T > T^*$. Since I_T includes the set of solvability of (6.18), we obtain that $I_T = \ell_2$ for all $T > T^*$. \square

Finally, we give the following illustrative example.

EXAMPLE 6.5. Consider two vector moment problems:

$$(6.19) \quad \begin{cases} s_k^1 = \int_0^T e^{(i(\pi+2\pi k)+\varepsilon_k^1)t} (11u_1(t) + u_2(t)) dt, \\ s_k^2 = \int_0^T e^{(i2\pi k+\varepsilon_k^2)t} (u_1(t) + u_2(t)) dt, \\ s_k^3 = \int_0^T e^{(\log 2+i2\pi k+\varepsilon_k^3)t} (u_1(t) - u_2(t)) dt, \\ s_k^4 = \int_0^T e^{(\log 3+i2\pi k+\varepsilon_k^4)t} (u_1(t) - u_2(t)) dt, \end{cases}$$

and

$$(6.20) \quad \begin{cases} s_k^1 = \int_0^T e^{(i(\pi+2\pi k)+\varepsilon_k^1)t} (6u_1(t) - u_2(t)) dt, \\ s_k^2 = \int_0^T e^{(i2\pi k+\varepsilon_k^2)t} (4u_1(t) - u_2(t)) dt, \\ s_k^3 = \int_0^T e^{(\log 2+i2\pi k+\varepsilon_k^3)t} (3u_1(t) - u_2(t)) dt, \\ s_k^4 = \int_0^T e^{(\log 3+i2\pi k+\varepsilon_k^4)t} (2u_1(t) - u_2(t)) dt, \end{cases}$$

$k \in \mathbb{Z}$, $\sum_k (\varepsilon_k^j)^2 < \infty$, $j = 1, \dots, 4$. Both moment problems can be reduced to the controllability problem for systems of the form (6.1), where

$$A_{-1} = \begin{pmatrix} 0 & 1 & 0 & 0 \\ 0 & 0 & 1 & 0 \\ 0 & 0 & 0 & 1 \\ 6 & -5 & -5 & 5 \end{pmatrix},$$

$\{\mu_1, \mu_2, \mu_3, \mu_4\} = \{-1, 1, 2, 3\}$, and the corresponding eigenvectors of A_{-1}^* are

$$z_1 = \begin{pmatrix} -6 \\ 11 \\ -6 \\ 1 \end{pmatrix}, \quad z_2 = \begin{pmatrix} 6 \\ 1 \\ -4 \\ 1 \end{pmatrix}, \quad z_3 = \begin{pmatrix} 3 \\ -1 \\ -3 \\ 1 \end{pmatrix}, \quad z_4 = \begin{pmatrix} 2 \\ -1 \\ -2 \\ 1 \end{pmatrix}.$$

The control matrices B_1 and B_2 for both systems (6.19) and (6.20) are

$$B_1 = \begin{pmatrix} 0 & 0 \\ 1 & 0 \\ 0 & 0 \\ 0 & 1 \end{pmatrix}, \quad B_2 = \begin{pmatrix} 0 & 0 \\ 0 & 0 \\ 1 & 0 \\ 0 & 1 \end{pmatrix}$$

for a certain choice of $A_2(\theta)$, $A_3(\theta)$. Since $n_1(A_{-1}, B_1) = 2$ and $n_1(A_{-1}, B_2) = 3$, the moment problem (6.19) is solvable for all $\{s_k^j\} \in \ell_2$ if $T > 2$ and the problem (6.20) is solvable if $T > 3$.

7. Conclusion. We give here some conditions for sets of complex numbers $\{\lambda\}$ and n -vectors $\{d\}$ such that they form a spectral set for a neutral-type system. This is a first step in solving vector moment problems using the exact controllability properties of a neutral-type system related to the given moment problem.
